Extremizers of the J functional with respect to the d_1 metric

Abstract

In previous work, Darvas–George–Smith obtained inequalities between the large scale asymptotic of the J functional with respect to the d_1 metric on the space of toric Kähler metrics/rays. In this work we prove sharpness of these inequalities on all toric Kähler manifolds, and study the extremizing potentials/rays. On general Kähler manifolds we show that existence of radial extremizers is equivalent with the existence of plurisupported currents, as introduced and studied by McCleerey.

1 Introduction and main results

Let (X, ω) be a Kähler manifold of dimension n. We consider the space of Kähler metrics that are cohomologous to ω :

 $\mathcal{H} := \{ \tilde{\omega} \text{ Kähler on } X \text{ and } [\tilde{\omega}]_{dR} = [\omega]_{dR} \}$

By the $\partial\bar{\partial}$ -lemma, for all $\tilde{\omega} \in \mathcal{H}$ there exists $u \in C^{\infty}(X)$, unique up to a constant, such that $\tilde{\omega} = \omega_u := \omega + i\partial\bar{\partial}u$. Consequently, instead of looking at H directly, one can work with the space of Kähler potentials instead:

$$
\mathcal{H}_{\omega} := \{ u \in C^{\infty}(X) \text{ s.t. } \omega + i\partial \bar{\partial} u > 0 \}.
$$

By PSH(X, ω) we denote the space of quasi-plurisubharmonic functions u satisfying ω_u := $\omega+i\partial\overline{\partial}u\geq 0$, in the sense of currents. Clearly, $\mathcal{H}_{\omega}\subset \mathrm{PSH}(X,\omega)$, hence all Kähler potentials are ω -plurisubharmonic (ω -psh). For a comprehensive treatment of ω -psh functions we refer to the recent book [\[GZ16,](#page-19-0) Chapter 8], for a quick introduction see [\[Da19,](#page-19-1) Appendix A.1], [\[Bl13,](#page-19-2) Section 2].

Let $I : \mathcal{H}_{\omega} \to \mathbb{R}$ be the *Monge-Ampère energy*, one of the most basic functionals of Kähler geometry:

$$
I(u) := \frac{1}{(n+1)V} \sum_{j=0}^{n} \int_{X} u \omega^{j} \wedge \omega_{u}^{n-j}, \qquad (1)
$$

where $V = \int_X \omega^n$ is the volume of (X, ω) . For a detailed analysis of the I functional we refer to [\[Bl13,](#page-19-2) page 111] and [\[Da19,](#page-19-1) Section 3.7]. Closely related, the J functional $J: \mathcal{H}_{\omega} \to \mathbb{R}$ is defined as follows:

$$
J(u) = \frac{1}{V} \int_X u\omega^n - I(u).
$$

Using Stokes' theorem one can prove that $J(u) \geq 0$, and in many ways J acts as a norm-like expression on \mathcal{H}_{ω} . This aspect will be revisited in this work.

By definition, the space of Kähler potentials \mathcal{H}_{ω} is a convex open subset of $C^{\infty}(X)$, hence it is a trivial "Fréchet manifold". Motivated by questions in stability, one can introduce on \mathcal{H}_{ω} an L^1 type Finsler metric [\[Da15\]](#page-19-3). If $u \in \mathcal{H}_{\omega}$ and $\xi \in T_u\mathcal{H}_{\omega} \simeq C^{\infty}(X)$, then the L^1 -length of ξ is given by the following expression:

$$
\|\xi\|_u = \frac{1}{V} \int_X |\xi| \omega_u^n. \tag{2}
$$

The analogous L^2 type metric was introduced by Mabuchi [\[Ma87\]](#page-19-4) (independently discovered by Semmes [\[Se92\]](#page-20-0) and Donaldson [\[Do99\]](#page-19-5)). This Riemannian metric was studied in detail by Chen [\[Ch00\]](#page-19-6), and for more historical details we refer to [\[Da19,](#page-19-1) Chapter 3].

To the Finsler metric in [\(2\)](#page-1-0) one associates a path length pseudo-metric $d_1(\cdot, \cdot)$ on \mathcal{H}_{ω} . As proved in [\[Da15\]](#page-19-3), d_1 is actually a metric and $(\mathcal{H}_{\omega}, d_1)$ is a geodesic metric space, whose abstract completion can be identified with (\mathcal{E}^1, d_1) , where $\mathcal{E}^1 \subset \text{PSH}(X, \omega)$ is a space of potentials introduced by Guedj–Zeriahi [\[GZ07\]](#page-19-7), inspired by work of Cegrell [\[Ce98\]](#page-19-8) in the local case.

Extremizing potentials in toric case and convex analysis. By [\[Da15,](#page-19-3) Remark 6.3] it was known that d_1 and J are asymptotically equivalent on \mathcal{H}_{ω} . In [\[DGS21\]](#page-19-9) the authors set out to sharpen the constants in the asymptotic comparison of J and d_1 , and proved the following global inequalities on toric Kähler manifolds:

Theorem 1.1 ([\[DGS21\]](#page-19-9)). Let (X, ω) be a toric Kähler manifold. Then there exists a constant $D > 0$ such that

$$
\frac{2}{n+1} \cdot \left(\frac{n}{n+1}\right)^n J(u) - D \le d_1(0, u) \le 2J(u) + D, \quad u \in \mathcal{H}^T_\omega \cap I^{-1}(0). \tag{3}
$$

In case $X = \mathbb{C}P^n$ and ω is the Fubini-Study metric the constants multiplying $J(u)$ are sharp.

The motivation for obtaining sharpness in [\(3\)](#page-1-1) stems from criteria of existence for canonical Kähler metrics. It is expected that uniform K-stability of (X,ω) is related to energy properness with respect to the d_1 metric [\[BBJ\]](#page-19-10). On the other hand, in concrete situations one can often show energy properness with respect to the J functional, also implying existence of canonical metrics (e.g. [\[SZ20\]](#page-20-1)). Naturally, there is an interest in converting such properness criteria into K-stability criteria, and vice versa, as optimally as possible.

In [\[DGS21,](#page-19-9) page 3] the authors proposed to study the sharpness of the above inequality in case of arbitrary toric Kähler manifolds, not just projective space. This is what we address in this work, and we show that (3) is sharp for any toric Kähler manifold.

As pointed out in [\[DGS21,](#page-19-9) Section 2], using Legendre transforms, the pair of inequalities in [\(3\)](#page-1-1) is equivalent to a pair of integral inequalities involving convex functions of a convex domain, as expressed in [\(4\)](#page-2-0) below. We show that this pair of inequalities is sharp on any convex domain, proving the sharpness of (3) on any toric Kähler manifold:

Theorem 1.2. Let $P \subset \mathbb{R}^n$ be a bounded open convex set. (i)[\[DGS21\]](#page-19-9) for any convex $\phi \in L^1(P)$, satisfying $\int_P \phi = 0$, the following inequality holds:

$$
-\frac{2}{n+1} \cdot \left(\frac{n}{n+1}\right)^n \inf_P \phi \le \frac{1}{\mu(P)} \int_P |\phi| d\mu \le -2 \inf_P \phi,
$$
\n(4)

(ii) there exists a convex function $\phi \in L^1(P)$ such that $\int_P \phi = 0$ and

$$
-\frac{2}{n+1} \cdot \left(\frac{n}{n+1}\right)^n \inf_P \phi = \frac{1}{\mu(P)} \int_P |\phi| d\mu. \tag{5}
$$

Potentials ϕ satisfying [\(5\)](#page-2-1) will be referred to as *extremizers* in this work. When P is the unit simplex (corresponding to projective space), the existence of extremizers was proved in [\[DGS21,](#page-19-9) Proposition 4.2].

Regarding the first inequality in [\(4\)](#page-2-0), we don't just prove the existence of extremizers, but we end up characterizing them explicitly, with this answering another question posed in [\[DGS21,](#page-19-9) page 3] (See Theorem [3.6\)](#page-11-0). What is more, in Section 3.1 we characterize domains P admitting affine extremizers. Such domains P are always very special: they are the intersection of a cone with a half-space.

Regarding the second inequality in [\(4\)](#page-2-0), it is easy to see that it is always sharp, but without any extremizing functions (See Remark [3.2\)](#page-9-0).

Extremizing rays and plurisupported currents. In [\[DGS21\]](#page-19-9) it was conjectured that Theorem [1.1](#page-1-2) holds in case of general Kähler manifolds as well. To provide evidence for this, the authors obtained the radial version of the expected result, as we now recall, along with related terminology from [\[DL20\]](#page-19-11).

Let $\{u_t\} \in \mathcal{R}^1$ be a d_1 -geodesic ray $[0, \infty) \ni t \to u_t \in \mathcal{E}^1$ of (\mathcal{E}^1, d_1) , emanating from $u_0 = 0 \in \mathcal{H}_{\omega}$, and normalized by $I(u_t) = 0, t \geq 0$. Since the J functional is convex along geodesics, one can define its slope along geodesic rays (informally called the radial J functional):

$$
\{u_t\} := \lim_{t \to \infty} \frac{J(u_t)}{t}.
$$
\n⁽⁶⁾

The L^1 speed of a ray $\{u_t\}_t$ is simply the quantity $d_1(0, u_1)$. We have the following inequality between the L^1 speed and the radial J functional:

Theorem 1.3. [\[DGS21\]](#page-19-9) Suppose that (X, ω) is a compact Kähler manifold and $\{u_t\}_t \in \mathcal{R}^1$. Then the following inequality holds:

$$
\frac{2}{n+1} \cdot \left(\frac{n}{n+1}\right)^n J\{u_t\} \le d_1(0, u_1) \le 2J\{u_t\}.\tag{7}
$$

The inequality is sharp in case of $(\mathbb{CP}^n, \omega_{FS})$.

Since rays are constant speed, notice that the middle term in the above inequality could have been replaced by the limit $\lim_{t\to\infty} \frac{d_1(0,u_t)}{t}$ $t_t^{(n, u_t)}$. In particular, [\(7\)](#page-2-2) would instantly follow from the conjectured inequality (3) for general Kähler manifolds.

The sharpness of the second inequality in (7) is not difficult to argue on any Kähler manifold, using examples similar to Remark [3.2.](#page-9-0) As in Theorem $1.2(i)$, we are interested in the sharpness of the first inequality of [\(7\)](#page-2-2) on arbitrary Kähler manifolds, and finding all extremizing rays.

It turns out that this question is tied to the existence of plurisupported potentials in $PSH(X, \omega)$, as introduced and studied in [\[MC21\]](#page-20-2). Recall that $v \in PSH(X, \omega)$ is plurisupported if $\int_X \omega_v \wedge \omega^{n-1} = 0$, i.e., the current ω_v is supported on a pluripolar set.

Theorem 1.4. Suppose that (X, ω) is a compact Kähler manifold. Then there exists $\{u_t\}_t \in$ \mathcal{R}^1 such that $J\{u_t\}/d_1(0, u_1) = \frac{(n+1)^{n+1}}{2n^n}$ if and only if there exists $v \in \text{PSH}(X, \omega)$ plurisupported.

The construction of the extremizings rays $\{u_t\}_t \in \mathcal{R}^1$ in terms of plurisupported currents $v \in \text{PSH}(X,\omega)$ is quite explicit, and is elaborated in Theorem [4.7.](#page-18-0) What is more, it follows from Theorem [4.7](#page-18-0) that all such extremizing rays come from this same construction.

Existence of plurisupported potentials is a deep question related to a number of important conjectures in the field. For details, we refer to [\[MC21\]](#page-20-2). However if (X, ω) is a projective Kähler manifold, then there exists $v \in \text{PSH}(X, \omega)$ such that $\omega_v = [D]$, for some divisor $D \subset X$. It is clear that such v is plurisupported. Hence we get the following corollary:

Corollary 1.5. Suppose that (X, ω) is a projective Kähler manifold. Then there exists ${u_t}_t \in \mathcal{R}^1$ such that $J{u_t}_t/d_1(0, u_1) = \frac{(n+1)^{n+1}}{2n^n}$. In particular, the first inequality of [\(7\)](#page-2-2) is sharp.

After the publication of the paper in Analysis Mathematica, we learned from Kewei Zhang that the constants of Theorem 1.2 and Theorem 1.3 already appeared in the non-Archimedean context in [\[BHJ17,](#page-19-12) Theorem 7.9], without discussing their optimality. Though the results don't overlap, the techniques of the arguments do. It is remarkable how the same philosphy is applicable in the totally different non-Archimedean and toric cases. Both this paper and [\[DGS21\]](#page-19-9) would have been presented differently had we been aware of [\[BHJ17,](#page-19-12) Theorem 7.9].

2 Preliminaries

2.1 Analysis on toric Kähler manifolds

In this short section we point out how the inequalities [\(3\)](#page-1-1) and [\(4\)](#page-2-0) are equivalent. The material here closely follows [\[DGS21,](#page-19-9) Section 3], itself inspired from [\[DG16,](#page-19-13) Section 6] and [\[ZZ08\]](#page-20-3). We say that (X, ω) is a toric Kähler manifold of dimension n if we can embed $(\mathbb{C}^*)^n$ into X so that the complement of $(\mathbb{C}^*)^n$ inside X is a Zariski closed set. Moreover, we ask

that the trivial action of $\mathbb{T}^n := (S^1)^n$ on $(\mathbb{C}^*)^n$ extends to X, and the Kähler form ω is \mathbb{T}^n -invariant.

Using the fact that ω is \mathbb{T}^n -invariant we get that

$$
\omega = i\partial\bar{\partial}(\psi_0 \circ L) \quad \text{on} \quad (\mathbb{C}^*)^n,
$$
\n(8)

where $\psi_0 \in C^{\infty}(\mathbb{R}^n)$ and $L(z_1, z_2, \ldots, z_n) = (\log |z_1|, \log |z_2|, \ldots, \log |z_n|) \in \mathbb{R}^n$. Since $\psi_0 \circ L$ is psh on $(\mathbb{C}^*)^n$, the potential ψ_0 has to be strictly convex on \mathbb{R}^n , and we may choose $\psi_0(0) = 0$.

By \mathcal{H}^T we will denote the metrics $\omega' \in \mathcal{H}$ that are torus invariant, i.e., $(S^1)^n$ acts by isometries on ω' . \mathcal{H}_{ω}^T will denote the corresponding space of toric potentials.

For $u \in \mathcal{H}_{\omega}^T$ we can introduce the following potential

$$
\psi_u := \psi_0 + u \circ E,
$$

where $E(x) = E(x_1, x_2, \ldots, x_n) := (e^{x_1}, e^{x_2}, \ldots, e^{x_n}), x \in \mathbb{R}^n$. The point is that $\omega_u =$ $i\partial\bar{\partial}\psi_u \circ \hat{L}$ on $(\mathbb{C}^*)^n$.

The Legendre transform. Given $\omega_u \in \mathcal{H}_{\omega}^T$, it follows from a result of Atiyah–Guillemin– (see [\[CS08,](#page-19-14) Chapter 27]) that the "moment map" $\nabla \psi_u : \mathbb{R}^n \to \mathbb{R}^n$ is one-to-one and sends \mathbb{R}^n to $P := \text{Im } \nabla \psi_u$, which is a convex bounded polytope, independent of u.

Though we will not use it, by a theorem of Delzant, P satisfies a number of additional properties (simple, i.e., there are n edges meeting at each vertex; rational, i.e., the edges meeting at the vertex p are rational in the sense that each edge is of the form $p + tu_i$, $0 \leq t < \infty$, where $u_i \in \mathbb{Z}^n$; smooth, i.e., these u_1, \ldots, u_n can be chosen to be a basis of \mathbb{Z}^n). What is more, such Delzant polytopes P determine toric Kähler structures (X, ω) uniquely (see [\[Ab00\]](#page-19-15) and [\[CS08,](#page-19-14) Chapter 28]).

Since $\psi_u : \mathbb{R}^n \to \mathbb{R}$ is convex, we can take its Legendre transform and obtain a dual convex function ϕ_u , with possible values equal to $+\infty$:

$$
\phi_u(s) = \psi_u^*(s) := \sup_{x \in \mathbb{R}^n} (\langle s, x \rangle - \psi_u(x)), \ \ s \in \mathbb{R}^n.
$$

Since Im $\nabla \psi_u = P$, it follows that $\phi_u(s)$ is finite if and only if $s \in P$. Also, by the involutive property, for all $x \in \mathbb{R}^n$ we will have

$$
\phi_u^*=\psi_u^{**}=\psi_u,
$$

$$
\phi_u(\nabla \psi_u(x)) = \langle x, \nabla \psi_u(x) \rangle - \psi_u(x)
$$
 and $\nabla \psi_u(x) = s \Leftrightarrow \nabla \phi_u(s) = x$.

Summarizing, the Legendre transform $u \to \psi_u^* = \phi_u$ gives a one-to-one correspondence between elements of \mathcal{H}^T_ω and the class $\mathcal{C}(P)$:

$$
\mathcal{C}(P) := \{ f : P \to \mathbb{R} \text{ is convex and } f - \phi_0 \in C^{\infty}(\overline{P}) \},
$$

where $\phi_0 = \psi_0^*$. In addition, as pointed out in [\[Gu14,](#page-19-16) Proposition 4.5], there is a one-to-one correspondence between $(S^1)^n$ -invariant elements of $PSH(X,\omega) \cap L^{\infty}$ and convex functions $f: P \to \mathbb{R}$ for which $f - \phi_0$ is only bounded on P. In particular, $\phi_0 \in L^{\infty}(P)$.

The L^1 geometry of toric metrics. We briefly describe the L^1 geometry of \mathcal{H}_{ω} restricted to \mathcal{H}_u^T . Let $[0,1] \ni t \to u_t \in \mathcal{H}_\omega^T$ be a smooth curve connecting $u_0, u_1 \in \mathcal{H}_\omega^T$. Taking the Legendre transform of the potentials ψ_{u_t} we obtain

$$
\phi_{u_t}(s) := \sup_{x \in \mathbb{R}^n} \left\{ \langle x, s \rangle - \psi_{u_t}(x) \right\} = \langle x_t, s \rangle - \psi_{u_t}(x_t), \ s \in \mathbb{R}^n,
$$
\n(9)

where $x_t = x_t(s)$ is such that $\nabla \psi_{u_t}(x_t) = s$.

After elementary but tedious calculations (see [\[DGS21,](#page-19-9) Section 3]) we conclude that

$$
\int_{X} |\dot{u}_{t}| \omega_{u_{t}}^{n} = \pi^{n} n! \int_{\mathbb{R}^{n}} |\dot{\psi}_{u_{t}}| MA_{\mathbb{R}}(\psi_{u_{t}}) = \pi^{n} n! \int_{P} |\dot{\phi}_{u_{t}}(s)| d\mu(s), \tag{10}
$$

Hence the Legendre transform sends the L^1 geometry of \mathcal{H}^T_ω to the flat L^1 geometry of convex functions on P. In the particular case when $u_t := t$, we obtain the following useful formula about the Kähler volume:

$$
\int_{X} \omega^{n} = V = \pi^{n} n! \int_{P} d\mu.
$$
\n(11)

Regarding the underlying path length metrics, [\(10\)](#page-5-0) has the following important consequence:

Theorem 2.1. Suppose $u_0, u_1 \in \mathcal{H}_{\omega}^T$. Then

$$
d_1(u_0, u_1) = \frac{1}{\mu(P)} \int_P |\phi_{u_0}(s) - \phi_{u_1}(s)| d\mu(s), \tag{12}
$$

where $\mu(P)$ is the Lebesgue measure of P.

As a consequence of the above theorem, one concludes that the d_1 -completion of \mathcal{H}_{ω}^T can be identified with the space of convex functions on P , that are also integrable on P .

The I and J functionals of toric metrics. In this paragraph we analyze the I and J functionals in terms of the Legendre transform.

The I energy is essentially the Lebesgue integral, after applying the Legendre transform. Indeed, let $[0,1] \ni t \to v_t \in \mathcal{H}_{\omega}^T$ be any smooth curve connecting $v_0 = 0$ and $v_1 = u$. After elementary, but tedious calculations (see [\[DGS21,](#page-19-9) Section 3]), one obtains the following formula:

$$
I(u) = I(u) - I(0) = \frac{-1}{\mu(P)} \int_0^1 \int_P \dot{\phi}_{v_t}(s) d\mu(s) dt = \frac{-1}{\mu(P)} \int_P (\phi_u(s) - \phi_0(s)) d\mu(s).
$$
 (13)

Since $\phi_0 \in L^{\infty}(P)$ [\[Gu14,](#page-19-16) Proposition 4.5], we conclude that there exists $C = C(X, \omega)$ 0 such that

$$
\frac{-1}{\mu(P)} \int_P \phi_u d\mu - C \le I(u) \le \frac{-1}{\mu(P)} \int_P \phi_u d\mu + C, \quad u \in \mathcal{H}_{\omega}^T. \tag{14}
$$

Regarding the J energy, we can express its magnitude using the Legendre transform. This will be sufficient for our analysis (see [\[DGS21,](#page-19-9) Proposition 3.2]):

Proposition 2.2. There exists $C := C(X, \omega) > 0$ such that for all $u \in \mathcal{H}^T_{\omega}$ with $I(u) = 0$ we have

$$
-\inf_{P} \phi_u - C \leq J(u) = \frac{1}{V} \int_X u\omega^n \leq -\inf_{P} \phi_u + C.
$$

Putting together Theorem [2.1,](#page-5-1) [\(14\)](#page-5-2), and Proposition [2.2,](#page-6-0) we obtain the equivalence of the inequalities [\(3\)](#page-1-1) and [\(4\)](#page-2-0), as desired at the beginning of this subsection.

2.2 The Ross–Witt Nyström correspondence

In this subsection we recall the correspondence between geodesic rays and test curves, as established in [\[DX20,](#page-19-17) Section 3.1] and [\[DDL18b,](#page-19-18) Section 4], building on [\[RWN14\]](#page-20-4).

A sublinear subgeodesic ray is a subgeodesic ray $(0, +\infty) \ni t \mapsto u_t \in \text{PSH}(X, \omega)$ (notation ${u_t}_{t>0}$ such that $u_t \to_{L^1} u_0 := 0$ as $t \to 0$, and there exists $C \in \mathbb{R}$ such that $u_t(x) \leq Ct$ for all $t > 0$, $x \in X$.

A *psh geodesic ray* is a sublinear subgeodesic ray that additionally satisfies the following maximality property: for any $0 < a < b$, the subgeodesic $(0, 1) \ni t \mapsto v_t^{a,b}$ $t^{a, b}_t := u_{a(1-t)+bt} \in$ $PSH(X, \omega)$ can be recovered in the following manner:

$$
v_t^{a,b} := \sup_{h \in S} h_t, \quad t \in [0, 1], \tag{15}
$$

where S is the set of subgeodesics $(0, 1) \ni t \to h_t \in \text{PSH}(X, \omega)$ such that

$$
\lim_{t\searrow 0}h_t\leq u_a\,,\quad \lim_{t\nearrow 1}h_t\leq u_b\,.
$$

We note the following properties of the map $v \mapsto \sup_X v$ along rays, established in [\[DX20,](#page-19-17) Lemma 3.1]:

Lemma 2.3. For any psh geodesic ray $\{u_t\}_t$, the map $t \mapsto \sup_X u_t$ is linear. For sublinear subgeodesics, the map $t \mapsto \sup_X u_t$ is convex.

The statement for subgeodesics follows from t-convexity. To argue the statement for psh geodesic rays, one can use [\[Da17,](#page-19-19) Theorem 1] together with approximation by bounded geodesics, and the continuity of $u \mapsto \sup_X u$ in the weak L^1 -topology of $\text{PSH}(X, \omega)$.

A map $\mathbb{R} \ni \tau \mapsto \psi_{\tau} \in \text{PSH}(X, \omega)$ is a psh test curve, denoted $\{\psi_{\tau}\}_{\tau \in \mathbb{R}}$, if (i) $\tau \mapsto \psi_{\tau}(x)$ is concave, decreasing and usc for any $x \in X$.

(ii) $\psi_{\tau} \equiv -\infty$ for all τ big enough, and ψ_{τ} increases a.e. to 0 as $\tau \to -\infty$.

Condition (ii) allows for the introduction of the following constant:

$$
\tau_{\psi}^{+} := \inf \{ \tau \in \mathbb{R} : \psi_{\tau} \equiv -\infty \}.
$$
\n(16)

Remark 2.4. We adopt the following notational convention: psh test curves will always be parametrized by τ , whereas rays will be parametrized by t. Hence $\{\psi_t\}_t$ will always refer to some type of ray, whereas $\{\phi_{\tau}\}_{\tau}$ will refer to some kind of test curve. As recalled below, rays and test curves are dual to each other, so one should think of the parameters t and τ as duals to each other as well.

Given $v \in \text{PSH}(X, \omega)$ we consider the following notion of envelope:

$$
P[v] = \text{usc}\left(\sup\{w \in \text{PSH}(X,\omega), \ w \le 0, \ w \le v + C \text{ for some } C > 0\}\right) \tag{17}
$$

A psh test curve $\{\psi_\tau\}_{\tau}$ can have the following properties:

- (i) $\{\psi_\tau\}_\tau$ is maximal if $P[\psi_\tau] = \psi_\tau, \ \tau \in \mathbb{R}$.
- (ii) $\{\psi_{\tau}\}_{\tau}$ has *finite energy* if

$$
\int_{-\infty}^{\tau_{\psi}^{+}} \left(\int_{X} \omega_{\psi_{\tau}}^{n} - \int_{X} \omega^{n} \right) d\tau > -\infty.
$$
 (18)

(iii) We say $\{\psi_\tau\}_{\tau}$ is *bounded* if $\psi_\tau = 0$ for τ small enough. In this case, we introduce the following constant, complementing [\(16\)](#page-6-1):

$$
\tau_{\psi}^- := \sup \{ \tau \in \mathbb{R} : \psi_\tau \equiv 0 \} . \tag{19}
$$

Above we followed the convention $P[-\infty] = -\infty$, and we note that bounded test curves are clearly of finite energy.

We recall the *Legendre transform*, helping establish the duality between various types of maximal test curves and geodesic rays. Given a convex function $f : [0, +\infty) \to \mathbb{R}$, its Legendre transform is defined as

$$
\hat{f}(\tau) := \inf_{t \ge 0} (f(t) - t\tau) = \inf_{t > 0} (f(t) - t\tau), \quad \tau \in \mathbb{R}.
$$
 (20)

The *(inverse)* Legendre transform of a decreasing concave function $g : \mathbb{R} \to \mathbb{R} \cup \{-\infty\}$ is

$$
\check{g}(t) := \sup_{\tau \in \mathbb{R}} (g(\tau) + t\tau), \quad t \ge 0.
$$
\n(21)

There is a sign difference in our choice of Legendre transform compared to the convex analysis literature, however this choice is more suitable for us.

Given a sublinear subgeodesic ray $\{\phi_t\}_t$ (psh test curve $\{\psi_\tau\}_\tau$), we can associate its (inverse) Legendre transform at $x \in X$ as

$$
\hat{\phi}_{\tau}(x) := \inf_{t>0} (\phi_t(x) - t\tau), \quad \tau \in \mathbb{R},
$$

$$
\check{\psi}_t(x) := \sup_{\tau \in \mathbb{R}} (\psi_\tau(x) + t\tau), \quad t > 0.
$$
\n(22)

The Ross–Witt Nystrom correspondence describes the duality between various types of rays and maximal test curves, proved in [\[DX20,](#page-19-17) Theorem 3.7]:

Theorem 2.5. The Legendre transform $\{\psi_\tau\}_\tau \mapsto \{\check{\psi}_t\}_t$ gives a bijective map with inverse $\{\phi_t\}_t \mapsto \{\hat{\phi}_\tau\}_\tau$ between:

(i) psh test curves and sublinear subgeodesic rays,

(ii) maximal psh test curves and psh geodesic rays,

 $(ii)/RWN14$ maximal bounded test curves and bounded geodesic rays. In this case, we additionally have

$$
\tau_{\psi}^-t\leq \check{\psi}_t\leq \tau_{\psi}^+t\,,\quad t\geq 0\,.
$$

(iv) maximal finite energy test curves and finite energy geodesic rays. In this case, we additionally have

$$
I\{\psi_t\} := \frac{I(\check{\psi}_t)}{t} = \frac{1}{V} \int_{-\infty}^{\tau_{\psi}^+} \left(\int_X \omega_{\psi_\tau}^n - \int_X \omega^n \right) d\tau + \tau_{\psi}^+, t > 0.
$$
 (23)

Here I is the Monge–Ampère functional defined in (1) .

3 Extremizing functions on convex bodies

Let $P \subset \mathbb{R}^n$ be a bounded open convex set. Due to convexity of P we have $\text{int}\overline{P} = P$.

For any $f: P \to \mathbb{R}$ convex, it is well known that the lsc extension of $f: \overline{P} \to (-\infty, \infty]$ is also convex, possibly taking up the value ∞ . Since there will be no chance for confusion. we will not distinguish f from its lsc extension. Since \overline{P} is compact, the infimum of f will be always realized on this bigger set, and this will play a key role in our discussion below.

Before we discuss sharpness and extremizing potentials for Theorem [1.2\(](#page-2-3)i), let us recall the proof of this result from [\[DGS21\]](#page-19-9):

Theorem 3.1. [\[DGS21\]](#page-19-9) Let $P \subset \mathbb{R}^n$ be a bounded open convex set. Then for $\phi \in L^1(P)$ convex and satisfying $\int_P \phi d\mu = 0$, the following inequalities hold:

$$
-\frac{2}{n+1} \cdot \left(\frac{n}{n+1}\right)^n \inf_P \phi \le \frac{1}{\mu(P)} \int_P |\phi| d\mu \le -2 \inf_P \phi,
$$
\n(24)

where the integration is in terms of the Lebesgue measure.

Proof. First we argue the second inequality. Let

$$
P_{-}^{\phi} := \{ x \in P : \phi < 0 \} \quad \text{and} \quad P_{+}^{\phi} := \{ x \in P : \phi \ge 0 \} \tag{25}
$$

Since $\int_P \phi = \int_{P_-^{\phi}} \phi + \int_{P_+^{\phi}} \phi = 0$, we have

$$
\int_P |\phi| = -\int_{P_-^{\phi}} \phi + \int_{P_+^{\phi}} \phi = -2 \int_{P_-^{\phi}} \phi.
$$

Furthermore, $\int_{P_-^{\phi}} \phi \geq \mu(P_-^{\phi})$ $\int_{-}^{\phi} \rho \ln f_{P_{\perp}} \phi \geq \mu(P) \inf_{P} \phi$, and the second estimate follows.

We argue the first estimate. For all $a \in \mathbb{R}$, let

$$
P_a^{\phi} := \{ x \in P : \phi(x) < a \}.
$$

After re-scaling ϕ , we can assume without loss of generality that inf $_P \phi = -1$. We first claim that

$$
\int_{P} |\phi| \ge -\frac{2}{n+1} \mu(P_-^{\phi}).
$$
\n(26)

Let $y \in \overline{P}$ such that $\phi(y) = \inf_{P} \phi = -1$.

By convexity of $\phi : \overline{P} \to (-\infty, \infty]$, if $-1 < a < b$, we have

$$
\frac{b-a}{b+1}y + \frac{a+1}{b+1}P_b^{\phi} \subset P_a^{\phi}, \quad \text{for any } -1 < a < b. \tag{27}
$$

Taking measures of both sides we arrive at

$$
\mu\left(P_b^{\phi}\right) \le \left(\frac{b+1}{a+1}\right)^n \mu\left(P_a^{\phi}\right), \text{ for any } -1 < a < b. \tag{28}
$$

Since $\int_P \phi = \int_{P_+^{\phi}} \phi + \int_{P_-^{\phi}} \phi = 0$, we have $\int_P |\phi| = 2 \int_{P_-^{\phi}} |\phi|$, allowing to bound $\int_P |\phi|$ and proving the claim:

$$
\int_{P} |\phi| = 2 \int_{P_{-}} |\phi| = 2 \int_{-1}^{0} \mu \left(P_{x}^{\phi} \right) dx \ge 2 \int_{-1}^{0} \left(1 + x \right)^{n} \mu \left(P_{-}^{\phi} \right) dx = \frac{2}{n+1} \mu(P_{-}^{\phi}), \tag{29}
$$

where we used that $\int f d\mu = \int_0^{+\infty} \mu \{f \geq t\} dt = \int_0^{+\infty} \mu \{f > t\} dt$ for any non-negative μ -measurable f, estimate [\(28\)](#page-9-1) for $-1 < x < 0$, and $P_0^{\phi} = P_{-}^{\phi}$.

Next we estimate $\int_{P_+} \phi$, applying [\(28\)](#page-9-1) for $-1 < 0 < x$:

$$
\int_{P_{+}^{\phi}} \phi = \int_{0}^{\infty} \mu \left(P \setminus P_{x}^{\phi} \right) dx \ge \int_{0}^{\frac{1}{n}} \mu \left(P \setminus P_{x}^{\phi} \right) dx = \int_{0}^{\frac{1}{n}} \mu \left(P \right) - \mu \left(P_{x}^{\phi} \right) dx \tag{30}
$$

$$
\geq \int_0^{\frac{1}{n}} \mu(P) - (1+x)^n \mu\left(P_-^{\phi}\right) dx
$$
\n
$$
= \frac{1}{n} \mu(P) - \frac{\left(\frac{1}{n} + 1\right)^{n+1}}{n+1} \mu(P_-^{\phi}) + \frac{1}{n+1} \mu(P_-^{\phi})
$$
\n(31)

We then let $A > 0$ such that $\frac{1}{2} \int_P |\phi| = \int_{P_+^{\phi}} |\phi| = \int_{P_-^{\phi}} |\phi| = A \mu(P_-^{\phi})$. Collecting terms, we arrive at

$$
A\mu(P_{-}^{\phi}) = \int_{P_{+}^{\phi}} \phi \ge \frac{1}{n}\mu(P) - \frac{1}{n} \cdot \left(\frac{n+1}{n}\right)^{n} \mu(P_{-}^{\phi}) + \frac{1}{n+1}\mu(P_{-}^{\phi}),
$$

implying

$$
\int_P |\phi| = 2A\mu(P_-^{\phi}) \ge \frac{2A}{nA + \left(\frac{n+1}{n}\right)^n - \frac{n}{n+1}} \mu(P).
$$

The right-hand side is an increasing function of A and by [\(26\)](#page-8-0) we know $A \geq \frac{1}{n+1}$. This means the right hand side is minimized at this value, so

$$
\int_{P} |\phi| \ge \frac{\frac{2}{n+1}}{\left(\frac{n+1}{n}\right)^n} \mu(P) = \frac{2}{(n+1)} \cdot \left(\frac{n}{n+1}\right)^n \mu(P). \tag{32}
$$

 \Box

Remark 3.2. We briefly address the sharpness of the second inequality in (24) . For any $P \subset \mathbb{R}^n$ and $\varepsilon > 0$ one can find $\psi_{\varepsilon} : P \to \mathbb{R}^+$ convex such that $\mu(\{\psi = 0\})/\mu(P) \geq 1 - \varepsilon$ and $\int_X \psi d\mu > 0$. Let $\phi_{\varepsilon} := \psi - \int_P \psi$.

Then $\{\psi = 0\} = \{\phi_{\varepsilon} = \inf_{P} \phi_{\varepsilon}\} \subseteq P_{-}^{\varepsilon} = \{\phi_{\varepsilon} < 0\}$. This implies that

$$
\int_P |\phi_{\varepsilon}| = -\int_{P_-^{\varepsilon}} \phi_{\varepsilon} + \int_{P_+^{\varepsilon}} \phi_{\varepsilon} = -2 \int_{P_-^{\varepsilon}} \phi_{\varepsilon} \ge -2\mu(\{\psi = 0\}) \inf_P \phi_{\varepsilon} \ge -2(1-\varepsilon)\mu(P) \inf_P \phi_{\varepsilon}.
$$

As a result, the last inequality [\(24\)](#page-8-1) is sharp. Moreover, this argument shows that extremizing functions for this equality do not exist.

Finally, we discuss the existence of extremizers for the first inequality of [\(24\)](#page-8-1). To fix notation, we introduce the set of extremizing potentials:

$$
\mathcal{W}(P) := \left\{ \psi : P \to \mathbb{R} \text{ convex}, \int_{P} \psi = 0, \text{ and } -\frac{2}{n+1} \cdot \left(\frac{n}{n+1} \right)^n \inf_{P} \psi = \frac{1}{\mu(P)} \int_{P} |\psi| \cdot \right\}
$$

Notice that $\phi \in \mathcal{W}(P)$ implies that $r\phi \in \mathcal{W}(P)$ for $r > 0$. To deal with this, we will often normalize elements of $\mathcal{W}(P)$ to satisfy inf $_P \phi = -1$. Using the language of the proof of Theorem [3.1](#page-8-2) we notice the following special properties of elements of $W(P)$:

Proposition 3.3. Let $B \subset \mathbb{R}^n$ convex open and bounded and $\phi \in \mathcal{W}(P)$ and $\inf_P \phi = \phi(y)$ -1 , for some $y \in \overline{P}$. Then $\sup_P \phi = \frac{1}{n}$ $\frac{1}{n}$ and

$$
P_a^{\phi} := \{ \phi < a \} = \frac{1 - an}{1 + n} y + \frac{na + n}{1 + n} P, \quad \text{for any} \quad -1 < a < \frac{1}{n}.\tag{33}
$$

Proof. The argument is a careful analysis of the proof of Theorem [3.1](#page-8-2) for $\phi \in \mathcal{W}(P)$ and $\inf_P \phi = -1$. We will also use numerous times that $x \to \mu(P_x^{\phi})$ is continuous due to the Brunn-Minkowski inequality (ϕ is convex).

Since $\phi \in \mathcal{W}(P)$ we need to have $A = \frac{1}{n+1}$, otherwise we have strict inequality in [\(32\)](#page-9-2). For similar reasons, we also need that $\mu(P) = \mu(P_x^{\phi})$ for $x \ge \frac{1}{n}$ $\frac{1}{n}$, otherwise, we have strict inequality in [\(30\)](#page-9-3). This implies that $\sup_P \phi \leq \frac{1}{n}$ $\frac{1}{n}$.

As we have equality in [\(29\)](#page-9-4), we obtain that $\mu(P_x^{\phi}) = (1+x)^n \mu(P_0^{\phi})$ $\binom{p\varphi}{0}$ for $x \in [-1,0]$. Similarly, due to equality in [\(31\)](#page-9-5) we have that $\mu(P_x^{\phi}) = (1+x)^n \mu(P_0^{\phi})$ $\mathbf{0}^{\phi}$ for $x \in [0, \frac{1}{n}]$ $\frac{1}{n}$. Putting these last two facts together, we obtain equality in [\(28\)](#page-9-1):

$$
\mu\big(P_b^{\phi}\big) = \left(\frac{b+1}{a+1}\right)^n \mu\left(P_a^{\phi}\right), \text{ for any } -1 < a \le b < \frac{1}{n}.
$$

Since the measure of the open convex sets on both sides of [\(27\)](#page-9-6) is the same, by Lemma [3.4](#page-10-0) below we conclude that $\frac{b-a}{b+1}y + \frac{a+1}{b+1}P_b^{\phi} = P_a^{\phi}$ for any $-1 < a < b < \frac{1}{n}$. Letting $b \nearrow \frac{1}{n}$, we conclude that $P_a^{\phi} = \frac{1 - an}{1 + n}$ $\frac{1-an}{1+n}y + \frac{na+n}{1+n}$ $\frac{na+n}{1+n}P$, as desired.

Lastly, we see that P_a is strictly increasing as $a \nearrow \frac{1}{n}$, hence $\sup_P \phi = \frac{1}{n}$ $\frac{1}{n}$. \Box

Lemma 3.4. Suppose that $A, B \subset \mathbb{R}^n$, both convex, bounded, open and $B \subset A$. If $\mu(A) =$ $\mu(B)$, then $A = B$.

Proof. Let $x \in A$. Since A is open, there exists $y_0, y_1, \ldots, y_n \in A$ such that x is in the interior of the simplex with vertices y_0, y_1, \ldots, y_n . Since $\mu(A) = \mu(B) < \infty$, B is dense in A. Hence, for all $j \in \{0, \ldots, n\}$ there exists $z_j \in B$ close enough to y_j such that x is in the interior of the simplex with vertices z_0, z_1, \ldots, z_n . Since B is convex, it must contain the interior of the simplex with vertices $z_0, z_1, \ldots, z_n \in B$, hence it also contains x. \Box

After carrying out some calculations, we verify that the reverse of Proposition [3.3](#page-10-1) also holds:

Proposition 3.5. Let $\phi \in L^1(P)$ be convex. Suppose there exists $y \in \overline{P}$ such that $P_a^{\phi} :=$ $\{\phi < a\} = \frac{1-an}{1+n}$ $\frac{1-an}{1+n}y + \frac{na+n}{1+n}$ $\frac{na+n}{1+n}P$ for any $-1 < a < \frac{1}{n}$. Then $\int_P \phi = 0$ and $\phi \in \mathcal{W}(P)$.

Proof. Letting $a \searrow -1$ and $a \nearrow \frac{1}{n}$ in $P_a^{\phi} := {\phi < a} = \frac{1 - an}{1 + n}$ $\frac{1-an}{1+n}y + \frac{na+n}{1+n}$ $\frac{na+n}{1+n}P$ we conclude that $\inf_P \phi = \phi(y) = -1$ and $\sup_P \phi = \frac{1}{n}$ $\frac{1}{n}$. Moreover, after taking measures, we also have that $\mu(P_x^{\phi}) = (1+x)^n \mu(P_0^{\phi})$ p_0^{ϕ} for $x \in \left[-1, \frac{1}{n}\right]$ $\frac{1}{n}$.

Next we verify that $\int_P \phi = 0$. For this we carry out the following side calculations

$$
\int_{P_-^{\phi}} |\phi| = \int_{-1}^0 \mu(P_x^{\phi}) dx = \int_{-1}^0 (1+x)^n \mu(P_0^{\phi}) dx = \frac{1}{n+1} \mu(P_0^{\phi}),
$$

$$
\int_{P_+^{\phi}} \phi = \int_0^{\frac{1}{n}} \mu (P \setminus P_x^{\phi}) dx = \int_0^{\frac{1}{n}} \mu (P) - \mu (P_x^{\phi}) dx = \int_0^{\frac{1}{n}} \mu (P) - (1+x)^n \mu (P_0^{\phi}) dx
$$

= $\frac{1}{n} \mu (P) - \frac{(\frac{1}{n} + 1)^{n+1}}{n+1} \mu (P_0^{\phi}) + \frac{1}{n+1} \mu (P_0^{\phi})$
= $\frac{1}{n} \left(1 + \frac{1}{n} \right)^n \mu (P_0^{\phi}) - \frac{(\frac{1}{n} + 1)^{n+1}}{n+1} \mu (P_0^{\phi}) + \frac{1}{n+1} \mu (P_0^{\phi}) = \frac{1}{n+1} \mu (P_0^{\phi}).$

Comparing the above, we conclude that $\int_P \phi = \int_{P_+} \phi + \int_{P_-} \phi = 0$, as desired.

Finally, using the above facts, we see that each inequality in the proof of Theorem [3.1](#page-8-2) is in fact an equality, ultimately yielding:

$$
-\frac{2}{n+1} \cdot \left(\frac{n}{n+1}\right)^n \inf_P \phi = \frac{1}{\mu(P)} \int_P |\phi| d\mu.
$$

 \Box

With the previous two propositions in hand, we obtain the following characterization of extremizers:

Theorem 3.6. For any $\phi \in \mathcal{W}(P)$ there exists a unique $y_{\phi} \in P$ such that $\inf_{P} \phi = \phi(y_{\phi})$. Moreover, the map $F : \mathcal{W}(P) \cap \{\inf_P \phi = -1\} \to P$ given by $F(\phi) = y_{\phi}$ is a bijective function.

As pointed out to us by the anonymous referee, it is an intriguing question to give a characterization of elements in $W(P)$ in terms of their Legendre transform.

Proof. Let $\phi \in \mathcal{W}(P)$. We can assume without loss of generality that $\inf_{P} \phi = -1$. That $y_{\phi} \in \overline{P}$ is unique, follows from [\(33\)](#page-10-2). This proves that the map $F(\phi) = y_{\phi}$ is well defined. To show that F is injective on $W(P) \cap {\rm inf}_P \phi = -1$, we notice that the identity

 $P_a^{\phi} := \{\phi < a\} = \frac{1 - an}{1 + n}$ $\frac{1-an}{1+n}y_{\phi} + \frac{na+n}{1+n}$ $\frac{na+n}{1+n}P, a \in (-1, \frac{1}{n})$ $\frac{1}{n}$) determines ϕ uniquely.

To argue surjectivity, let $y \in \overline{P}$. We are going to construct an extremizer $\phi_y \in \mathcal{W}(P)$ satisfying $\inf_P \phi_y = -1$ and $F(\phi_y) = y$.

Let $x \in P$. We define $\phi_y(x)$ as follows:

$$
\phi_y(x) = \inf \left\{ r \in \left[-1, \frac{1}{n} \right] \text{ such that } x \in \frac{1 - rn}{1 + n}y + \frac{nr + n}{1 + n}P \right\}
$$

By definition of ϕ_y we have:

$$
P_a^{\phi} := \{\phi_y < a\} = \frac{1 - an}{1 + n}y + \frac{na + n}{1 + n}P, \ a \in \left[-1, \frac{1}{n} \right].\tag{34}
$$

We argue that ϕ_y is convex. Let $x, z \in P$ and suppose that $\phi_y(x) < a$ and $\phi_y(z) < b$. We will argue that $\phi_y(\alpha x + (1 - \alpha)y) \leq \alpha a + (1 - \alpha)b$, $\alpha \in [0, 1]$. This will follow if we can argue that $\alpha\{\phi_y < a\} + (1 - \alpha)\{\phi_y < a\} \subseteq \{\phi_y < \alpha a + (1 - \alpha)b\}$. By [\(34\)](#page-12-0) this is equivalent with:

$$
\alpha \frac{na+n}{1+n}P + (1-\alpha) \frac{nb+n}{1+n}P \subseteq \frac{n(\alpha a + (1-\alpha)b) + n}{1+n}P.
$$

But this inclusion follows from the fact that P is convex.

Lastly, [\(34\)](#page-12-0) and Proposition [3.5](#page-11-1) implies that $\int_P \phi_y = 0$, as well as $\phi_y \in \mathcal{W}(P)$. \Box

3.1 The case of affine extremizers

Given an extremizer $\phi \in \mathcal{W}(P)$, whenever $y_{\phi} \in P$ in Theorem [3.1,](#page-8-2) the graph of ϕ is a cone, with vertex at y_{ϕ} . However when $y_{\phi} \in \partial P$, the shape of the graph of ϕ may change drastically. In particular, as pointed out in the proof of [\[DGS21,](#page-19-9) Proposition 4.2], in some instances such extremizers ϕ are affine functions. In this short subsection, we point out that this can happen only in a very particular instance: when P is the intersection of a convex cone and a half-space.

Let $L \subset \mathbb{R}^n$ open. We say that L is a linear cone if $L + L \subset L$ and $\alpha L \subset L$ for any $\alpha > 0$. We say that $C \subset \mathbb{R}^n$ is a *convex cone* if $C = y + L$ for some $y \in \mathbb{R}^n$ and L linear cone.

We say that $H \subset \mathbb{R}^n$ is an open half-space, if there exist $\chi : \mathbb{R}^n \to \mathbb{R}$ linear so that $H = \{ \chi < c \}$ for some $c \in \mathbb{R}$. If $0 \in H$, we have that $c > 0$, and in this case we can always arrange that $H = \{\chi < 1 + \frac{1}{n}\}.$ This normalization determines $\chi := \chi_H$ uniquely, and we will call χ_H the linear defining function of H.

Theorem 3.7. Let $P \subset \mathbb{R}^n$ be a bounded open convex set. There exists $\phi \in \mathcal{W}(P)$ affine if and only if $P = C \cap H$, where $C = y + L$ is a convex cone and H is a half-space. In the latter case $\psi(x) := \chi_{H-y}(x-y) - 1 \in \mathcal{W}(P)$ is an affine extremizer.

Proof. Suppose that $\phi : P \to \mathbb{R}$ affine and $\phi \in \mathcal{W}(P)$. Let $y \in \overline{P}$ such that $\phi(y) = \inf_P \phi$. After replacing P with $P - y$ and $\phi(x)$ with $\phi(x + y)$ we can assume that $y = 0$. We can also assume that $\inf_{P} \phi = -1$.

In particular, $\psi(x) := \phi(x) + 1, x \in \mathbb{R}^n$ is linear, since ψ is affine and $\psi(0) = 0$. We introduce $H := \{x \in \mathbb{R} : \phi(x) < \frac{1}{n}\}$ $\frac{1}{n}$ } = { $x \in \mathbb{R} : \psi(x) < 1 + \frac{1}{n}$ }.

Let $L := \{rP, r > 0\}$. It is clear that L is a linear cone, since P is convex. We claim that $P = L \cap H$. Since $P = P^{\phi}_{\frac{1}{n}} \subset H$, the easy inclusion is $P \subset L \cap H$. For the reverse

inclusion, let $p \in L \cap H$. Then there exists $q \in P$ and $r > 0$ such that $p = rq$ and $p \in H$. The latter implies that

$$
\psi(p) = \phi(p) + 1 = r\psi(q) = r(\phi(q) + 1) < 1 + \frac{1}{n}.\tag{35}
$$

If $r \in [0, 1]$, then we are done, since $p = rq = 0(1 - r) + rq \in P$ ($0 \in \overline{P}$ and P is open). If, $r > 1$ then by [\(35\)](#page-13-0) we have $\phi(p/r) < \frac{1}{r} - 1 + \frac{1}{nr}$. This implies that $p/r \in P_{\frac{1}{r} - 1 + \frac{1}{nr}}$. Since $\phi \in \mathcal{W}(P)$, by [\(33\)](#page-10-2) we get that

$$
p \in rP_{\frac{1}{r}-1+\frac{1}{nr}} = P.
$$

For the reverse direction, assume that if $P = C \cap H$, where $C = y + L$ is a convex cone and H is half-space. Let χ_{H-y} be the linear defining function of H.

In this case we take $\phi(x) := \chi_{H-y}(x-y) - 1$. We notice that $\phi(y) = -1$, $\sup_P \phi = \frac{1}{n}$ $\frac{1}{n}$. Moreover, since ϕ is affine, we obtain that

$$
P_a^{\phi} := \{ \phi < a \} = \frac{1 - an}{1 + n} y + \frac{na + n}{1 + n} P, \quad -1 < a < \frac{1}{n}.
$$

Proposition [3.5](#page-11-1) now gives and $\int_P \phi = 0$ and $\phi \in \mathcal{W}(P)$.

4 Extremizing rays and plurisupported currents

In proving Theorem [1.4](#page-3-0) we heavily rely on the formalism developed in [\[DL20\]](#page-19-11) regarding the metric space of geodesic rays. For more background and details we refer to this work.

By $\mathcal{E}^1 \subset \text{PSH}(X, \theta)$ we denote the space of finite energy pontentials: $u \in \mathcal{E}^1$ if $\int_X \theta_u^n$ By $\mathcal{E}^1 \subset \text{PSH}(X, \theta)$ we denote the space of finite energy pontentials: $u \in \mathcal{E}^1$ if $\int_X \theta_u^n = \int_X \omega^n$ (where θ_u^n is the non-pluripolar complex Monge–Ampere measure, defined in [\[GZ07,](#page-19-7) Section 1]), moreover $\int_X |u| \theta_u^n < \infty$.

By \mathcal{R}^1 we denote the space of L^1 Mabuchi geodesic rays $[0, \infty) \ni t \to u_t \in \mathcal{E}^1$, normalized by $u_0 = 0$ and $I(u_t) = 0, t \ge 0$.

By [\[BDL1,](#page-19-20) Proposition 5.1] the map $t \to d_1(u_t, v_t)$ is convex for any $\{u_t\}_t, \{v_t\}_t \in \mathcal{R}^1$, where we used the conventions of Remark [2.4.](#page-6-2) In [\[DL20\]](#page-19-11) this was used to define the following metric (see also [\[CC18\]](#page-19-21)):

$$
d_1^c({u_t}_t, {v_t}_t) = \lim_{t \to \infty} \frac{d_1(u_t, v_t)}{t}.
$$

By [\[DL20,](#page-19-11) Theorem 1.3 and 1.4] we know that (\mathcal{R}^1, d_1^c) is complete, moreover the space of normalized bounded geodesic rays \mathcal{R}^{∞} is dense in \mathcal{R}^1 [\[DL20,](#page-19-11) Theorem 1.5].

The radial J functional from (6) can be expressed in very simple terms, slightly extending [\[DGS21,](#page-19-9) Lemma 5.2]:

Lemma 4.1. For $\{u_t\}_t \in \mathcal{R}^1$ we have that $J\{u_t\} = \sup_X \dot{u}_0 = \tau_u^+ = \frac{\sup_X u_t}{l}$ $\frac{dX}{dt}$ for any $l > 0$, where $\dot{u}_0 := \lim_{t \to 0} \frac{u_t}{t}$ $\frac{t_t}{t}$.

Proof. We have that $J(u_t) = \frac{1}{V} \int_X u_t \omega^n - I(u_t) = \frac{1}{V} \int_X u_t \omega^n$. By [\[Da19,](#page-19-1) Lemma 3.45] we obtain that

$$
J\{u_t\} = \lim_{t \to \infty} \frac{J(u_t)}{t} = \lim_{t \to \infty} \frac{\sup_X u_t}{t}.
$$

 \Box

By Lemma [2.3](#page-6-3) $t \to \sup_X u_t$ is linear, hence $J\{u_t\} = \frac{\sup_X u_t}{l} = \tau_u^+$ for any $l > 0$.

Finally, we argue that $J\{u_t\} = \sup_X \dot{u}_0$. For this we have to argue that $\sup_X \dot{u}_0 = \frac{\sup_X u_l}{l}$ l for any $l > 0$. We make use of Theorem [2.5.](#page-7-0) To start, we notice that we can assume that $0 = \tau_u^+ = \sup_X \frac{u_l}{l}$ $\frac{u_l}{l}$, $l > 0$, after replacing u_t with $u_t - \tau_u^+ t$.

Since $u_t := \sup_{\tau \leq 0} (\hat{u}_\tau + t\tau)$, $t \geq 0$, we obtain that $u_t \geq \hat{u}_0$ for any $t \geq 0$. From $\tau_u^+ = 0$ we also obtain that $u_t \leq 0$. Since $\{\hat{u}_\tau\}_\tau$ is maximal, we obtain that $P[\hat{u}_0] = \hat{u}_0$, in particular $\sup_X \hat{u}_0 = 0$. Moreover, since \hat{u}_0 is usc, there exists $x \in X$ such that $\sup_X \hat{u}_0 = u_0(x)$. Since $\hat{u}_0 \leq u_t \leq 0$, we obtain that $u_t(x) = 0$, for all $t > 0$. By t-convexity, we have $\hat{u}_0 \leq 0$. But since $\dot{u}_0(x) = 0$, we conclude that $\sup_X \dot{u}_0 = 0 = \frac{\sup_X u_l}{l}$ for any $l > 0$, finishing the proof. \Box

Lemma 4.2. For $\{u_t\}_t \in \mathcal{R}^1$ we have $d_1(0, u_1) = \int_X |\dot{u}_0| \omega^n$ and $0 = I(u_1) = \int_X \dot{u}_0 \omega^n$.

Proof. That $d_1(0, u_1) = \int_X |u_0| \omega^n$ follows from [\[BDL2,](#page-19-22) Lemma 3.4]. What is more, the argument of [\[BDL2,](#page-19-22) Lemma 3.4] is seen to imply $I(u_1) = \int_X \dot{u}_0 \omega^n$. 口

Given $v \in \text{PSH}(X, \theta)$, we say that v is a *model potential* if $v = P[v]$, where $P[v]$ was defined in [\(17\)](#page-7-1). For more on model potentials we refer to [\[DDL18a\]](#page-19-23).

Lemma 4.3. For any $\{u_t\}_t \in \mathcal{R}^1$ and $b \leq a < \tau_u^+$ we have that

$$
\int_{\{u_0 \ge b\}} \omega^n \le \frac{(\tau_u^+ - b)^n}{(\tau_u^+ - a)^n} \int_{\{u_0 \ge a\}} \omega^n.
$$

Moreover $[-\infty, \tau_u^+] \ni s \to (\int_{\{\dot{u}_0 \geq s\}} \omega^n)^{1/n}$ is concave.

Proof. It follows from Theorem [2.5](#page-7-0) that $\hat{u}_\tau \in \text{PSH}(X, \omega)$ is a model potential. As a result, by [\[DT20,](#page-19-24) Theorem 1] (c.f. [\[DDL18a,](#page-19-23) Theorem 3.8]) we have that $\int_X \omega_{\hat{u}_\tau}^n = \int_{\{\hat{u}_\tau=0\}} \omega^n$. Moreover, due to basic properties of Legendre transforms $\{\dot{u}_0 \geq \tau\} = \{\hat{u}_{\tau} = 0\}$, in particular,

$$
\int_{X} \omega_{\hat{u}_{\tau}}^{n} = \int_{\{\hat{u}_{0} \geq \tau\}} \omega^{n}.
$$
\n(36)

Let now $b \le a \le \tau_u^+$. We recall that $\tau \to \hat{u}_\tau$ is concave and $PSH(X, \omega) \ni v \to (\int_X \omega_v^n)^{\frac{1}{n}}$ is concave as well ([\[DDL21,](#page-19-25) Theorem B]. As a result, using [\[WN17,](#page-20-5) Theorem 1.2] we conclude that $s \to (\int_X \omega_{\hat{u}_s}^n)^{1/n}$ is concave. Together with [\(36\)](#page-14-0) this impies the last statement of the lemma. Using concavity we can write that

$$
\frac{(\tau_u^+ - a)}{(\tau_u^+ - b)} \bigg(\int_X \omega_{\hat{u}_b}^n\bigg)^{\frac{1}{n}} \le \frac{(\tau_u^+ - a)}{(\tau_u^+ - b)} \bigg(\int_X \omega_{\hat{u}_b}^n\bigg)^{\frac{1}{n}} + \frac{(a - b)}{(\tau_u^+ - b)} \bigg(\int_X \omega_{\hat{u}_{\tau_u}^+}^n\bigg)^{\frac{1}{n}} \tag{37}
$$

$$
\leq \left(\int_X \omega^n_{\frac{\left(\tau_u^+-a\right)}{\left(\tau_u^+-b\right)}\hat{u}_b + \frac{\left(a-b\right)}{\left(\tau_u^+-b\right)}\hat{u}_{\tau_u^+}}\right)^{\frac{1}{n}}\tag{38}
$$

$$
\leq \left(\int_X \omega_{\hat{u}_a}^n\right)^{\frac{1}{n}}.\tag{39}
$$

Comparing with [\(36\)](#page-14-0), the result follows.

 \Box

Before we proceed, let us recall the construction for a special type of geodesic ray from [\[Da17\]](#page-19-19), associated to any $v \in \text{PSH}(X, \omega)$ and $a, b \in \mathbb{R}$ with $a < b$.

With [\(22\)](#page-7-2) and Theorem [2.5](#page-7-0) in mind, let $\hat{r}(a, b, v)_{\tau} \in \text{PSH}(X, \omega)$ defined as follows:

$$
\hat{r}(a,b,v)_{\tau} := \begin{cases}\n0, & \tau \leq a; \\
P\left[\frac{\tau-a}{b-a}v\right], & a < \tau < b; \\
\lim_{\tau \nearrow b} P\left[\frac{\tau-a}{b-a}v\right], & \tau = b; \\
-\infty, & \tau > b.\n\end{cases}
$$
\n(40)

By [\[DDL18a,](#page-19-23) Theorem 3.12] we have that $P[r(a, b, v)_\tau] = r(a, b, v)_\tau$, $\tau \in \mathbb{R}$. Hence, by Theorem [2.5\(](#page-7-0)iii) we obtain that $\{\hat{r}(a, b, v)_{\tau}\}_{\tau}$ is a bounded maximal test curve, inducing a geodesic ray $\{r(a, b, v)_t\}_t \in \mathcal{R}^\infty$ that will play a critical role below, in case $v \in \text{PSH}(X, \omega)$ is plurisupported. Indeed, for v plurisupported it is possible to compute the radial Monge-Ampère and J energies of $\{r(a, b, v)_t\}_t$:

Proposition 4.4. For any $v \in \text{PSH}(X, \omega)$ plurisupported we have $I\{r(-1/n, 1, v)_t\} = 0$, moreover

$$
\frac{2}{n+1} \cdot \left(\frac{n}{n+1}\right)^n J\{r(-1/n, 1, v)_t\} = d_1(0, r(-1/n, 1, v)_1).
$$

Proof. We start with computing $I\{r(-1/n, 1, v)_t\}$. Notice that $\tau_r^+ = 1$ and $\tau_r^- = -1/n$.

We will use numerous times that $\int_X \omega_{P[w]}^n = \int_X \omega_w^n$ for all $w \in \text{PSH}(X, \omega)$ ([\[DDL18a,](#page-19-23) Theorem 1.3, Theorem 2.3]). In addition, since v is plurisupported, we have $\int_X \omega_v^k \wedge \omega^{n-k} = 0$ for all $k \in \{1, \ldots, n\}$.

Using the above, formula [\(23\)](#page-8-3) allows to carry out the following calculations:

$$
I\{r(-1/n, 1, v)_t\} = \frac{1}{V} \int_{-\frac{1}{n}}^1 \left(\int_X \omega_{P[\frac{n\tau+1}{n+1}v]}^n - \int_X \omega^n \right) d\tau + 1
$$
\n
$$
= \frac{1}{V} \int_{-\frac{1}{n}}^1 \left(\int_X \omega_{\frac{n\tau+1}{n+1}v}^n - \int_X \omega^n \right) d\tau + 1
$$
\n
$$
= \frac{1}{V} \int_{-\frac{1}{n}}^1 \left(\left(\frac{n - n\tau}{n+1} \right)^n \int_X \omega^n - \int_X \omega^n \right) d\tau + 1
$$
\n
$$
= \frac{n^n}{(n+1)^n} \int_{-\frac{1}{n}}^1 (1 - \tau)^n d\tau - \frac{1}{n} = 0.
$$
\n(41)

Since $J\{r(-1/n, 1, v)_t\} = \tau^+_{r(-1/n, 1, v)} - I\{r(-1/n, 1, v)_t\}$ (Lemma [4.1\)](#page-13-1), and $\tau^+_{r(-1/n, 1, v)} = 1$, we obtain that $J\{r(-1/n, 1, v)_t\} = 1$.

Lastly, we compute $d_1(0, r(-1/n, 1, v)_1) = \frac{1}{V} \int_X |\dot{r}(-1/n, 1, v)_0| \omega^n$.

$$
d_1(0, r(-1/n, 1, v)_1) = \frac{1}{V} \int_X |\dot{r}(-1/n, 1, v)_0| \omega^n
$$

\n
$$
= \frac{2}{V} \int_{\{ \dot{r}(-1/n, 1, v)_0 \ge 0 \}} \dot{r}(-1/n, 1, v)_0 \omega^n
$$

\n
$$
= \frac{2}{V} \int_0^1 \omega^n (\{\dot{r}(-1/n, 1, v)_0 \ge s\}) ds
$$

\n
$$
= \frac{2}{V} \int_0^1 \omega_{\hat{r}_s}^n ds = \frac{2}{V} \int_0^1 \omega_{\frac{n_{s+1}}{n+1}v}^n ds
$$

\n
$$
= \frac{2}{V} \int_0^1 \left(\frac{n - ns}{n + 1}\right)^n \int_X \omega^n ds
$$

\n
$$
= 2 \int_0^1 \left(\frac{n - ns}{n + 1}\right)^n d\tau = \frac{2n^n}{(n + 1)^{n+1}},
$$

where in the second line we have used Lemma [4.2,](#page-14-1) in fourth line we have used [\(36\)](#page-14-0), and in the fifth line we have used that v is plurisupported. □

With the above in hand, we are ready characterize the case of equality in Proposition [4.3:](#page-14-2)

Lemma 4.5. Let $\{u_t\}_t \in \mathcal{R}^{\infty}$. Then

$$
\int_{\{u_0\geq b\}}\omega^n=\frac{(\tau_u^+-b)^n}{(\tau_u^+-a)^n}\int_{\{u_0\geq a\}}\omega^n
$$

for all $\tau_u^- \leq b \leq a < \tau_u^+$ if and only if there exists $v \in \text{PSH}(X, \omega)$ plurisupported such that $u_t = r(\tau_u^-, \tau_u^+, v))_t, t \geq 0.$

Proof. We argue the forward direction only, as this is the only implication that we will use. We leave the simple proof of the reverse direction to the reader.

Let $v = \hat{u}_{\tau_u^+}$. We argue that v is plurisupported and $u_t = r(\tau_u^-, \tau_u^+, v))_t$, $t \geq 0$.

To start we note that all the inequalities [\(37\)](#page-14-3),[\(38\)](#page-14-4) and [\(39\)](#page-14-5) are equalities. Taking $b = \tau_u^$ and $a \in (\tau_u^-, \tau_u^+)$ we arrive at:

$$
\frac{(\tau_u^+ - a)}{(\tau_u^+ - \tau_u^-)} \bigg(\int_X \omega^n\bigg)^{\frac{1}{n}} = \frac{(\tau_u^+ - a)}{(\tau_u^+ - \tau_u^-)} \bigg(\int_X \omega^n\bigg)^{\frac{1}{n}} + \frac{(a - \tau_u^-)}{(\tau_u^+ - \tau_u^-)} \bigg(\int_X \omega_v^n\bigg)^{\frac{1}{n}} \tag{42}
$$

$$
= \left(\int_X \omega^n_{\frac{(a-\tau_u^-)}{(\tau_u^+-\tau_u^-)}v} \right)^{\frac{1}{n}} \tag{43}
$$

$$
= \left(\int_X \omega_{\hat{u}_a}^n\right)^{\frac{1}{n}}.\tag{44}
$$

The equality [\(44\)](#page-16-0) and the fact \hat{u}_a is model (Theorem [2.5\)](#page-7-0) implies that $\hat{u}_a = P \left[\frac{(a - \tau_a)}{(\tau_a^+ - \tau_a^-)} \right]$ $\frac{(a - \tau_u^{-})}{(\tau_u^{+} - \tau_u^{-})}v$ = $\hat{r}(\tau_u^-, \tau_u^+, v))_a$ for $a \in (\tau_u^-, \tau_u^+)$.

From [\(43\)](#page-16-1) we have that

$$
\frac{(\tau_u^+-a)^n}{(\tau_u^+-\tau_u^-)^n}\int_X\omega^n=\int_X\omega^n_{\frac{(a-\tau_u^-)}{(\tau_u^+-\tau_u^-)}v},\ \ a\in[\tau_u^-,\tau_u^+].
$$

The multilinearity of nonpluripolar products now implies that $\int_X \omega_v^k \wedge \omega^{n-k} = 0$ for all $k \in \{1, \ldots, n\}$, hence v is plurisupported. \Box

Before we characterize extremizing rays, let us recall the proof of Theorem [1.3](#page-2-5) from [\[DGS21\]](#page-19-9), sharing striking similarities with the argument of Theorem [3.1:](#page-8-2)

Theorem 4.6. [\[DGS21\]](#page-19-9) Suppose that (X, ω) is a compact Kähler manifold and $\{u_t\}_t \in \mathcal{R}^1$. Then the following inequalities hold:

$$
\frac{2}{n+1} \cdot \left(\frac{n}{n+1}\right)^n J\{u_t\} \le d_1(0, u_1) \le 2J\{u_t\}.
$$
\n(45)

Proof. Due to Lemma [4.1](#page-13-1) and Lemma [4.2,](#page-14-1) it is enough to argue the following estimates:

$$
\frac{2}{n+1} \cdot \left(\frac{n}{n+1}\right)^n \sup_X \dot{u}_0 \le \frac{1}{V} \int_X |\dot{u}_0| \omega^n \le 2 \sup_X \dot{u}_0.
$$

Using re-scaling in time, we can further assume that $\sup_X \dot{u}_0 = 1$, hence it is enough to argue that

$$
\frac{2}{n+1} \cdot \left(\frac{n}{n+1}\right)^n \le \frac{1}{V} \int_X |\dot{u}_0| \omega^n \le 2. \tag{46}
$$

We first argue the easier second estimate. Let $X_ - := \{u_0 < 0\}$ and $X_ + := \{u_0 \geq 0\}$. Since $I(u_1) = \int_X \dot{u}_0 \omega^n$ we have that

$$
\frac{1}{V} \int_X |\dot{u}_0| \omega^n = \frac{2}{V} \int_{X_+} \dot{u}_0 \omega^n \le 2 \sup_X \dot{u}_0.
$$

To address the first estimate, we make the following preliminary calculation:

$$
\int_{X} |\dot{u}_{0}| \omega^{n} = 2 \int_{X^{+}} \dot{u}_{0} \omega^{n} = 2 \int_{0}^{1} \int_{\{\dot{u}_{0}\geq x\}} \omega^{n} dx \geq 2 \int_{0}^{1} (1-x)^{n} \int_{\{\dot{u}_{0}\geq 0\}} \omega^{n} dx
$$
\n
$$
= \frac{2}{n+1} \int_{\{\dot{u}_{0}\geq 0\}} \omega^{n},
$$
\n(47)

where we used that $\int f d\mu = \int_0^{+\infty} \mu \{f \ge t\} dt$ for any non-negative μ -measurable f, and Lemma [4.3](#page-14-2) for the parameters $0 \le x \le \sup_X u_0 = 1$.

To estimate $\int_{X_{-}} |u_0| \omega^n$, we can use a similar technique to the above:

$$
\int_{X_{-}} |u_{0}| \omega^{n} \ge \int_{0}^{\frac{1}{n}} \int_{X \setminus \{u_{0}\ge -x\}} \omega^{n} dx = \int_{0}^{\frac{1}{n}} \left(V - \int_{\{u_{0}\ge -x\}} \omega^{n} \right) dx
$$
\n
$$
\ge \int_{0}^{\frac{1}{n}} \left(V - (1+x)^{n} \int_{\{u_{0}\ge 0\}} \omega^{n} \right) dx
$$
\n
$$
= \frac{V}{n} - \frac{\left(\frac{1}{n} + 1\right)^{n+1}}{n+1} \int_{\{u_{0}\ge 0\}} \omega^{n} + \frac{1}{n+1} \int_{\{u_{0}\ge 0\}} \omega^{n},
$$
\n(48)

where in the second line we used Lemma [4.3](#page-14-2) again, for the parameters $-x \leq 0 \leq \sup_X \dot{u}_0 = 1$.

We now let $A > 0$ such that $\frac{1}{2} \int_X |\dot{u}_0| \omega^n = \int_{X_+} |\dot{u}_0| \omega^n = - \int_{X_-} \dot{u}_0 \omega^n = A \int_{\{\dot{u}_0 \ge 0\}} \omega^n$. This gives

$$
A \int_{\{u_0 \ge 0\}} \omega^n \ge \frac{1}{n} V - \frac{1}{n} \cdot \left(\frac{n+1}{n}\right)^n \int_{\{u_0 \ge 0\}} \omega^n + \frac{1}{n+1} \int_{\{u_0 \ge 0\}} \omega^n,
$$

implying

$$
\int_X |u_0| \omega^n = 2A \int_{\{u_0 \ge 0\}} \omega^n \ge \frac{2A}{nA + \left(\frac{n+1}{n}\right)^n - \frac{n}{n+1}} V.
$$

The right-hand side is an increasing function of A and by [\(47\)](#page-17-0) we know $A \geq \frac{1}{n+1}$. This means the right hand side is minimized at $A = \frac{1}{n+1}$, hence

$$
\int_{X} |\dot{u}_0| \omega^n \ge \frac{\frac{2}{n+1}}{\left(\frac{n+1}{n}\right)^n} V = \frac{2}{(n+1)} \cdot \left(\frac{n}{n+1}\right)^n V,\tag{49}
$$

finishing the proof of [\(46\)](#page-17-1).

Theorem 4.7. Suppose that (X, ω) is a compact Kähler manifold and $\{u_t\}_t \in \mathcal{R}^1$ is such that $\tau_u^+ = 1$ and

$$
\frac{2}{n+1} \cdot \left(\frac{n}{n+1}\right)^n J\{u_t\} = d_1(0, u_1). \tag{50}
$$

 \Box

Then there exists $v \in \text{PSH}(X, \omega)$ plurisupported such that $u_t = r(-\frac{1}{n})$ $(\frac{1}{n}, 1, v)_t, t \geq 0.$ Conversely, for any $w \in \text{PSH}(X, \omega)$ plurisupported, the ray $\{r(-\frac{1}{n})\}$ $\frac{1}{n}, 1, w)_t\}_t$ satisfies [\(50\)](#page-18-1).

We note that the condition $\tau_u^+ = 1$ is a simple normalization, and can be always be achieved after rescaling in time any ray $\{u_t\}_t \in \mathcal{R}^1$. [\(50\)](#page-18-1). Though toric symmetries are not involved, the argument shares similarities with the proof of Proposition [3.3.](#page-10-1)

Proof. Let $\{u_t\}_t \in \mathcal{R}^1$ such that [\(50\)](#page-18-1) holds.

Examining the proof of Theorem [4.6,](#page-17-2) since all x-integrands are continuous (Lemma [4.3\)](#page-14-2), we conclude that all the inequalities between [\(47\)](#page-17-0) and [\(49\)](#page-18-2) are in fact equalities for our ${u_t}_t \in \mathcal{R}^1$. In particular the first line of [\(48\)](#page-17-3) implies that $\dot{u}_0 \geq -\frac{1}{n}$ a.e. on X. This gives $u_t \geq -\frac{t}{n}$ a.e. on X, by t-convexity. Since $u_t \in \text{PSH}(X, \omega)$ we obtain that $u_t \geq -\frac{t}{n}$ globally, hence $\{u_t\}_t \in \mathcal{R}^{\infty}$.

Equality in the second line of [\(48\)](#page-17-3) and [\(47\)](#page-17-0) gives $\int_{\{\dot{u}_0 \ge x\}} \omega^n = (1-x)^n \int_{\{\dot{u}_0 \ge 0\}} \omega^n$ for any $x \in \left[-\frac{1}{n}\right]$ $\frac{1}{n}$, 1). Picking $x = a$, and $x = b$ for $-\frac{1}{n} = \tau_u^- \leq b \leq a < \tau_u^+ = 1$ we arrive at

$$
\int_{\{u_0 \ge b\}} \omega^n = \frac{(1-b)^n}{(1-a)^n} \int_{\{u_0 \ge a\}} \omega^n.
$$

Lemma [4.5](#page-16-2) now implies that there exists $v \in \text{PSH}(X, \omega)$ plurisupported such that $u_t =$ $r(\tau_u^-, \tau_u^+, v))_t$, $t \ge 0$.

For the reverse direction, let $u_t := r(-1/n, 1, w)_t$, $t \geq 0$ for $w \in \text{PSH}(X, \omega)$ plurisupported. Then Proposition [4.4](#page-15-0) implies that [\(50\)](#page-18-1) holds. \Box
