# ENERGY CASCADE FOR THE KLEIN-GORDON LATTICE

## S. PASQUALI $(*)$

ABSTRACT. We study analytically the dynamics of a d-dimensional Klein-Gordon lattice with periodic boundary conditions, for  $d \leq 3$ . We consider initial data supported on one low-frequency Fourier mode. We show that, in the continuous approximation, the resonant normal form of the system is given by a small-dispersion nonlinear Schrödinger (NLS) equation. By exploiting a result about the growth of Sobolev norms for solutions of small-dispersion NLS, we are able to describe an energy cascade phenomenon for the Klein-Gordon lattice, where part of the energy is transferred to modes associated to higher frequencies. Such a phenomenon holds within the time-scale for which we can ensure the validity of the continuous approximation.

# 1. INTRODUCTION

<span id="page-0-0"></span>In this paper we present an analytical study of the dynamics of a d-dimensional  $(d \leq 3)$  Klein-Gordon lattice with periodic boundary conditions, for initial data where only one low-frequency Fourier mode is initially excited. We give a rigorous result concerning the transfer of energy to modes associated to higher frequencies, resulting in an energy cascade phenomenon, according to the terminology used in [\[PB05\]](#page-40-0).

The study of the dynamics of Hamiltonian lattices started with the numerical result by Fermi, Pasta and Ulam (FPU) [\[FPU95\]](#page-40-1), who investigated the dynamics of a one-dimensional chain of particles with nearest neighbour interaction. In the original simulations all the energy was initially given to a single low-frequency Fourier mode, with the aim of measuring the time of relaxation of the system to the 'thermal equilibrium' by looking at the evolution of the Fourier spectrum. According to classical statistical mechanics (more precisely, by the theorem of equipartition of energy), the energy spectrum corresponding to the thermal equilibrium is a plateau. Fermi, Pasta and Ulam expected that the system would

have reached thermal equilibrium within a short time-scale, However, the outcome of their numerical experiment was surprising: indeed, they obtained a Fourier spectrum which was far from being flat, exhibiting a lack of thermalization and a recurrent behaviour of the dynamics.

Both from a physical and a mathematical point of view, the studies on FPU-like systems have a long history: a survey of the vast literature on the subject (until 2006) is discussed in the monograph [\[Gal07\]](#page-40-2). We also mention the numerical study in [\[BP11\]](#page-40-3) about the time-scale for equipartition for two classes of FPU models: in this paper the authors showed that in the regime of small specific energy  $\epsilon \ll 1$ , the lattice first reaches a state very far from energy equipartition (the one observed in the FPU paper), and then it evolves towards equipartition of energy among normal modes on a much longer time-scale.

Unlike the dynamics of one-dimensional Hamiltonian lattices, the dynamics of higher-dimensional Hamiltonian lattices is far less clear; it is expected that different choices of the geometry of the lattice and of the specific energy regime could lead to different results. Moreover, when considering nearly integrable Hamiltonian lattices, the dynamics of "a priori stable" models (namely, when the unperturbed system is integrable, but does not present hyperbolicity) and "a priori unstable" models (when the unperturbed system is integrable and presents hyperbolicity) may be drastically different.

Benettin and collaborators [\[Ben05\]](#page-39-1) [\[BG08\]](#page-39-2) studied numerically a two-dimensional FPU lattice with triangular cells and different boundary conditions in order to estimate the equipartition time-scale. They found out that the equipartition is reached faster than in the one-dimensional case.

Regarding the dynamics of "a priori unstable" models, there are some analytical results concerning Arnold diffusion for lattices of weakly-coupled penduli. In [\[KLS14\]](#page-40-4) [\[Hua17\]](#page-40-5) the authors consider a 1-dimensional lattice of weakly-coupled penduli with periodic boundary conditions, and they prove by variational methods the existence of orbits which display an energy transfer among modes. More recently, in  $[GG23]$  the authors construct orbits for d-dimensional lattices  $(d \geq 1)$  of weakly-coupled penduli which display Arnold diffusion. We also mention [\[BKZ16\]](#page-39-3) [\[GdlLMS20\]](#page-40-7) about Arnold diffusion mechanisms for other classes of Hamiltonian systems.

The relation between the dynamics of Hamiltonian lattices and the dynamics of dispersive PDEs has been first highlighted in [\[ZK65\]](#page-40-8), by comparing the FPU model and the KdV equation (see also [\[SW00\]](#page-40-9) [\[BP06\]](#page-40-10) [\[GPR21\]](#page-40-11) [\[GP22\]](#page-40-12) and references therein, where metastability phenomena for the FPU model are described by approximating its dynamics with the dynamics of the KdV equation). We also mention [\[BCP02\]](#page-39-4), where the authors obtain the NLS equation as a resonant normal form for the FPU model. More recently, metastability phenomena have been proved for two-dimensional rectangular lattices [\[GP21\]](#page-40-13), by approximating their dynamics in some particular specific energy regimes with the dynamics of integrable dispersive PDEs. Regarding instability phenomena, we mention [\[GMPR22\]](#page-40-14), which describes the approach to thermalisation in the FPU model through a system of generalised Burgers equations.

In this paper we study a d-dimensional Klein-Gordon (KG) lattice with  $(2N+1)^d$  sites, with polynomial nonlinearity of degree  $2\ell + 2$  ( $\ell > 1$ ), in the case of periodic boundary conditions, for  $d \leq 3$ . We show the existence of an energy cascade phenomenon, in which part of the energy initially given to only one low-frequency mode is transferred to higher-frequency modes. More precisely, if we denote by  $\mu \ll 1$  the wave-number of the Fourier mode initially excited and we consider small-amplitude solutions for which the specific energy  $\epsilon \sim \mu^{2\alpha}$ , with  $\alpha$  belonging to a suitable interval  $(\alpha_0, \alpha_1) \subset (0, 1/\ell)$ , we obtain that the lattice is approximated by a small-dispersion nonlinear Schrödinger (NLS) equation. We then exploit a result concerning the growth of Sobolev norms for solutions of the small-dispersion NLS equation in order to deduce a rigorous energy cascade result for the KG lattice.

Up to the author's knowledge, this is the first rigorous result concerning instability phenomena for multidimensional "a priori stable" Hamiltonian lattices by continuous approximation arguments.

To prove our result we adopt the following strategy. The first step consists in the approximation of the dynamics of the lattice with the dynamics of a continuous system; this step gives also a natural perturbative order. Next, we perform a normal form canonical transformation and we notice that for  $\frac{1}{2\ell} < \alpha < \frac{1}{\ell}$  the effective dynamics is given by a small-dispersion NLS equation. Next, we exploit a  $\frac{2\ell}{\ell}$  theorem by Kuksin about the growth of Sobolev norms for solutions of the small-dispersion NLS (see

Sec. 3 of [\[Kuk97\]](#page-40-15)) in order to construct approximate solutions of the original discrete lattices, and we estimate the error with repect to a true solution with the corresponding initial datum (see Section 6 of [\[GP21\]](#page-40-13) for a similar argument in the analytic setting). This allows us to estimate the specific energies for the modes of approximate solutions of the original lattice and to prove the energy cascade phenomenon.

The novelties of this work are: a mathematically rigorous proof of an energy cascade phenomenon for a Hamiltonian lattice through a growth of Sobolev norms the dynamics of a dispersive PDE, see Theorem [6.1](#page-22-1) and its proof in Sec. [6;](#page-22-0) the normal form Theorem [3.7,](#page-8-1) which combines the techniques used in [\[FG11\]](#page-40-16) and [\[Fao12\]](#page-40-17) with those used in [\[Bam05\]](#page-39-5) [\[Pas19\]](#page-40-18) (we mention that, unlike the results proved in [\[BP06\]](#page-40-10) [\[GP21\]](#page-40-13), the normal form theorem proved in the present paper holds for sequences in  $\ell_s^1$ -spaces, see also comment iv. later); we also mention the estimates in Sec. [5](#page-15-0) for bounding the error between the approximate solution and the true solution of the lattice, which need a more careful study than the ones appearing in [\[SW00\]](#page-40-9) [\[BP06\]](#page-40-10) for the one-dimensional case (see also Sec. 6 of [\[GP21\]](#page-40-13)).

Some comments are in order:

- i. as mentioned before, the specific energy  $\epsilon$  of the system and the wave-number  $\mu \sim \frac{1}{N}$  of the Fourier mode initially excited are linked through the relation  $\epsilon \sim \mu^{2\alpha}$ , with  $\alpha$  belonging to a suitable interval  $(\alpha_0, \alpha_1) \subset (0, 1/\ell)$ . In particular, this implies that the main result of the paper does not hold in the thermodynamic limit regime (namely, for large  $N$  and for fixed small  $\epsilon$  not depending on  $N$ ), which is the most relevant regime for statistical mechanics;
- ii. the averaging Theorem proved in Sec. [3](#page-5-0) of the paper applies also to the endpoint case  $\alpha = 1/\ell$ , as highlighted by  $(3.49)$  and by Corollary [3.14.](#page-13-1) It would be interesting in this context to use more recent results proved in  $\text{[CKS}^+10\text{[GHP16]}$  $\text{[CKS}^+10\text{[GHP16]}$  $\text{[CKS}^+10\text{[GHP16]}$  $\text{[CKS}^+10\text{[GHP16]}$  $\text{[CKS}^+10\text{[GHP16]}$   $\text{[GG22]}$  $\text{[GG22]}$  $\text{[GG22]}$  about transfer of energy among Fourier modes for the NLS equation on the torus. However, those results hold for solutions with initial data supported on a large number of Fourier modes, and this is a first difference with respect to the initial data considered in the present paper. Moreover, some technical estimates, like the ones proved in Proposition [5.3,](#page-17-1) would require a more careful proof in the endpoint case;
- iii. in the one-dimensional case the dynamics of the KG lattice with different boundary conditions has been studied in [\[BCP09\]](#page-39-6); since the regime investigated in [BCP09] corresponds to  $\ell = 1$  and  $\epsilon \sim \mu^2$  in the notation of the present paper, it does not overlap with the results presented here;
- iv. the mechanism of the energy cascade exhibited in this paper is obtained in four steps. First, we prove a normal form Theorem [3.7](#page-8-1) in  $\ell_s^1$ -spaces, by which we can approximate the continuous approximation [\(3.35\)](#page-11-1) of the Klein-Gordon lattice [\(2.3\)](#page-3-1) with a small-dispersion NLS equation [\(3.52\)](#page-13-2). Next, we use a result of growth of Sobolev norms for solutions of small-dispersion NLS, see Theorem [4.2.](#page-14-1) Then, we estimate the difference between the Fourier modes of the smalldispersion NLS and the normal modes of the lattice, see Proposition [5.3.](#page-17-1) Finally, we prove an energy transfer phenomenon in  $\ell_m^2$ -spaces, with  $m > s$ . We mention that the approach of using a normal form result in  $\ell^1$ -spaces in order to show growth in  $\ell_m^2$ -spaces has been used in recent results about growth of Sobolev norms and instability phenomena for Hamiltonian PDEs where dispersion and nonlinearity are of the same order of magnitude, see [\[CF12\]](#page-40-22) [\[Han14\]](#page-40-23) [\[GHP16\]](#page-40-20);
- v. the result presented in this paper is a first example in which an instability phenomenon for a multidimensional Hamiltonian lattice is described by exploiting an instability result for a nonlinear Hamiltonian PDE. Apart from the results by Kuksin on nonlinear PDEs with small dispersion [\[Kuk95\]](#page-40-24) [\[Kuk96\]](#page-40-25) [\[Kuk97\]](#page-40-15), it would be interesting to apply to multidimensional Hamiltonian lattices more recent results regarding instability phenomena for nonlinear Hamiltonian PDEs, like the ones proved in [\[GG10\]](#page-40-26) [\[GG12\]](#page-40-27) [\[HPTV15\]](#page-40-28) [\[GLPR18\]](#page-40-29) [\[GGMP21\]](#page-40-30) [\[BGGH24\]](#page-39-7).

The paper is organized as follows: in Section [2](#page-3-0) we introduce the mathematical setting of the model and we give an informal statement of the main result. In Section [3.1](#page-5-1) we describe the functional setting for stating in Section [3.2](#page-8-0) an abstract Averaging Theorem; we prove this theorem in Section [3.3.](#page-9-0) In Section [3.4](#page-11-0) we apply the averaging Theorem to the KG lattice, deriving the NLS with small dispersion. In Section [4](#page-14-0) we review a result about the dynamics of the NLS with small dispersion. In Section [5](#page-15-0) we use the normal form equations in order to construct approximate solutions, and we estimate the difference with respect to the true solutions with corresponding initial data. In Section [6](#page-22-0) we state and we prove the main result of the paper. In Appendix [A](#page-26-1) we prove Lemma [3.11,](#page-10-0) while in Appendix [B](#page-35-0) we prove Proposition [5.2.](#page-17-0)

Relevant notation. For the sake of clarity we provide a short explanation of some of the symbols we use in the paper. We denote by N the half length of the side fo the lattice, and by  $N_d := (2N + 1)^d$ the total number of sites in the lattice. With  $\mathbb{Z}_N^d$  we denote  $(\mathbb{Z}/(2N+1))^d = \{(j_1,\ldots,j_d) \in \mathbb{Z}^d : |j_i| \leq$  $N, \forall i = 1, \ldots, d$ . We will denote by  $k = (k_1, \ldots, k_d) \in \mathbb{Z}^d$  the index of the wave-vector.

# 2. Setting and informal statement of the Main Result

<span id="page-3-0"></span>We consider a periodic d-dimensional lattice  $(d = 1, 2, 3)$ , called KG lattice, which combines the nearest-neighbour potential with an on-site one. We write

\mathbb{Z}_N^d := \{ (j_1, \ldots, j_d) : j_1, \ldots, j_d \in \mathbb{Z}, |j_i| \leq N \ \forall i = 1, \ldots, d \};

we also write  $(e_j^{(d)})_{j=1,\ldots,d}$  for the vectors of the canonical basis of  $\mathbb{Z}^d$ . We denote by

$$
(2.2) \t\t N_d := (2N+1)^d
$$

the total numbers of sites in the lattice  $\mathbb{Z}_N^d$ .

The Hamiltonian describing the scalar KG lattice is given by

H_{KG}(Q, P) = \sum_{j \in \mathbb{Z}_N^d} \frac{P_j^2}{2} + \frac{1}{2} \sum_{j \in \mathbb{Z}_N^d} Q_j \left( -\Delta_1 Q \right)_j + \sum_{j \in \mathbb{Z}_N^d} U(Q_j),
$$

The associated equations of motion are

\ddot{Q}_j = (\Delta_1 Q)_j - Q_j - \beta Q_j^{2\ell+1}, \qquad j \in \mathbb{Z}_N^d.

If we take  $\ell = 1$ , we obtain a generalization of the one-dimensional  $\phi^4$  model.

<span id="page-3-7"></span>We also introduce the Fourier coefficients of  $Q$  via the following standard relation,

and similarly for  $P_j$ . We denote by

the energy and the square of the frequency of the mode at site  $k = (k_1, \ldots, k_d) \in \mathbb{Z}_N^d$ . We will restrict to solutions of  $(2.3)$  which have a discrete odd-symmetry, namely to solutions  $Q =$  $(Q_j)_{j\in\mathbb{Z}_N^d}$  such that

and similarly for P.

As is customary in lattices with a large number of degrees of freedom, especially in relation with statistical mechanics, we introduce the *specific wave vector*  $\kappa$  as

\kappa := \kappa(k) = \left(\frac{k_1}{N + \frac{1}{2}}, \dots, \frac{k_d}{N + \frac{1}{2}}\right),

and the specific energy of the specific normal mode  $\kappa = \kappa(k)$  as

The important role of the energy of normal modes can be understood in the following way (see also pag. 155 in Chap. 4 of [\[Gal07\]](#page-40-2) for a more detailed explanation). According to classical equilibrium statistical mechanics, the statistical properties of an Hamiltonian lattice with  $N_d$  sites and Hamiltonian H (such as the KG lattice  $(2.3)$ ) at equilibrium at a given total energy E should be described by the microcanonical measure induced on the energy surface  ${H = E}$  by the Lebesgue measure, or equivalently (if  $N_d$  is sufficiently large) by the canonical or Gibbs measure with a temperature  $T = T(E)$ .

Considering the lattice [\(2.3\)](#page-3-1) at equilibrium and in the harmonic case  $\beta = 0$ , by the Theorem of Equipartition of Energy we have that the expected values of the harmonic energies  $E_k$  at a given total energy E do not depend on k and are all equal to the so-called specific energy  $\epsilon$  of the system, given by

$$
\epsilon := E/N_d.
$$

Moreover, the specific energy of the system and the temperature are related by the formula  $\epsilon = k_BT$ , where  $k_B$  is the Boltzmann constant and T the temperature. The result does not change qualitatively for a slightly anharmonic system (e.g. for  $|\beta| \ll 1$  in [\(2.3\)](#page-3-1)) or for small temperature T (equivalently, due to the formula before, in the case of small specific energy  $\epsilon \ll 1$ ), because anharmonic corrections to the energy equipartition do vanish in the limit of vanishing anharmonic nonlinearity (e.g. in the limit  $\beta \to 0$ for [\(2.3\)](#page-3-1)) or in the limit of vanishing temperature  $T \to 0$  (equivalently, in the limit  $\epsilon \to 0$ ).

By the above discussion it is expected that in the regime of small specific energy the normal modes of the lattice should evolve towards a final state which exhibits equipartition of energy among normal modes. This phenomenon has been observed numerically in  $[PCB^+19]$  $[PCB^+19]$  for the one-dimensional KG lattice (see also the numerical results in the thermodynamic limit regime in [\[BP11\]](#page-40-3) and [\[BG08\]](#page-39-2) for the one-dimensional and two-dimensional FPU lattice, respectively).

In the present paper we study the KG lattice  $(2.3)$  in the regime of small specific energy  $\epsilon \sim \frac{1}{N^{2\alpha}} \ll 1$ , with  $0 < \alpha < \frac{1}{\ell}$  (see Remark [3.12](#page-12-0) below). More precisely, we want to study the behaviour of small amplitude solutions of [\(2.3\)](#page-3-1), with initial data in which only one low-frequency Fourier mode is excited.

We introduce the quantity

which plays the role of the small parameter in our construction: we will use it in the asymptotic expansion of the dispersion relation of the continuous approximation of the lattice in order to derive the approximating PDE in the regime we are considering.

We write  $\kappa_0 := \frac{v_0}{N + \frac{1}{2}} = \mu v_0$ , with  $v_0 := \sum_{j=1}^d e_j^{(d)}$ .

We now present an informal statement of the main result.

<span id="page-4-0"></span>**Theorem 2.1** (informal statement). Consider [\(2.3\)](#page-3-1) with  $\beta > 0$  and  $\ell \ge 1$ .

Then for all sufficiently large  $m \gg 1$  there exist positive  $\lambda_0$  and  $\lambda_1$  such that for any  $\lambda \in (\lambda_0, \lambda_1)$  the following holds true.

There exist an open interval  $\mathcal{I} \subset (0, 1/\ell)$  and  $\delta_0 > 0$  such that for any  $\delta \in (\delta_0, 1)$  and for any  $\alpha \in \mathcal{I}$ we have that for all positive  $\mu \ll 1$ , if the initial datum satisfies

$$
\mathcal{E}_{\kappa_0}(0)=C_0\,\mu^{2\alpha},\ \mathcal{E}_{\kappa}(0)=0,\ \ \forall\kappa\neq\kappa_0,
$$

then there exist  $C_1 > 0$ ,  $K > 0$ , a sufficiently large  $T_m > 0$  and  $c > 0$  such that

\sum_{\kappa \in \mu \mathbb{Z}_N^d : |\kappa| \le \mu^{\delta}} |\kappa|^{2m} \mathcal{E}_{\kappa}(T_m) \ge \frac{c}{8} \mu^{2\alpha - 2(1 - \ell \alpha) \frac{2\lambda}{1 - 2\ell \lambda} + 2m}.
$$

We defer a rigorous statement of our main result, together with its proof, to Section [6.](#page-22-0)

<span id="page-5-2"></span>Remark 2.2. First, we observe that the initial datum in Theorem [2.1](#page-4-0) satisfies

$$
|\kappa_0|^{2m} \mathcal{E}_{\kappa_0}(0) = C_0 |v_0|^{2m} \mu^{2\alpha + 2m}, \ |\kappa|^{2m} \mathcal{E}_{\kappa}(0) = 0, \ \ \forall \kappa \neq \kappa_0,
$$

for all  $m \geq 0$ , so that [\(2.13\)](#page-4-1) gives an analytical description of an energy transfer between lower-frequency and higher-frequency modes for the KG lattice. Such a phenomenon is called energy cascade (see [\[PB05\]](#page-40-0)). in analogy with a similar phenomenon arising in weak turbulence theory.

From the proof of the rigorous Theorem [6.1](#page-22-1) (see Section [6\)](#page-22-0) one can check that  $\lambda_1 < \lambda^*(m)$ , where  $\lambda^*(m)$  admits the following asymptotics (see also Remark [4.3](#page-15-1) below):

$$
\lambda^*(m) = \frac{1}{2\ell} \left( 1 - \frac{B_0}{2\ell m} \right) + \mathcal{O}\left(\frac{1}{m^2}\right), \quad B_0 = d\ell + 5, \quad \text{as} \quad m \to +\infty,
$$

$$
\lim_{m \to \infty} \frac{1}{m} \frac{\lambda^*(m)}{1 - 2\ell \lambda^*(m)} = \frac{1}{B_0}.
$$

**Remark 2.3.** In Theorem [2.2](#page-5-2) we chose  $\kappa_0 = \frac{v_0}{N+\frac{1}{2}}$  for simplicity. With simple modifications (see Remark 3.7 and Sec. 5 of  $[BPO6]$ , the result can be generalized to initial data supported on the mode with specific wave vector  $\kappa(v) = \frac{v}{N+\frac{1}{2}}$ ,  $v \in \mathbb{Z}_N^d \setminus \{0\}$ , and on its higher harmonics, under the assumption that  $|\kappa(v)| \ll 1$ .

As mentioned in comment i. of the introduction, the regimes of specific energy  $\epsilon \sim \mu^{2\alpha}$  described in Theorem [2.1](#page-4-0) are above the regime for which one can prove the existence of metastability phenomena (see Theorem 2.7 in [\[GP21\]](#page-40-13)), and they are also below the so-called thermodynamic limit (since  $\alpha > 0$ ).

We also observe that since in Eq.  $(2.13)$  the quantity  $\kappa$  has an upper bound which depends on  $\mu$ , and since the index m is very large, the energy transfer exhibited in  $(2.13)$  is weaker compared to the energy equipartition observed numerically both for the KG lattice  $[PCB^+19]$  $[PCB^+19]$  and for the FPU lattice  $[BP11]$ [\[BG08\]](#page-39-2).

# 3. Galerkin Averaging

<span id="page-5-0"></span>In this Section we prove an abstract averaging theorem, which we will later apply in order to show that for large N the dynamics of the KG lattice can be approximated by the dynamics of a NLS equation with small dispersion.

The idea of its proof (following [\[Bam05\]](#page-39-5), [\[BP06\]](#page-40-10), [\[FG11\]](#page-40-16), [\[Pas19\]](#page-40-18) and [\[GP21\]](#page-40-13)) is to make a Galerkin cut-off, namely to approximate the original infinite dimensional system by a finite dimensional one, to put in normal form the truncated system, and then to choose the dimension of the truncated system in such a way that the error due to the Galerkin cut-off and the error due to the truncation in the normalization procedure are of the same order of magnitude. The system one gets is composed of a part which is in normal form, and of a remainder.

If we neglect the remainder, we obtain a system whose solutions are approximate solutions of the original system; in Sec. [5](#page-15-0) we will show how to control the error with respect to a true solution of the original system.

This Section is divided into four parts. In the first part we introduce the analytic setting we are working with. In the second part we state the averaging Theorem [3.7.](#page-8-1) In the third part we give a concise proof of the averaging Theorem, deferring the proof of the technical Lemma [3.11](#page-10-0) to Appendix [A.](#page-26-1) In the last part we show an application of the abstract result to study the dynamics of the Klein-Gordon lattice.

# <span id="page-5-1"></span>3.1. Functional Setting.

**Definition 3.1.** Fix a constant  $s \geq 0$ , and let  $\mathcal{N} = \mathbb{Z}^d$  or  $\mathbb{N}^d$ , and  $j = 1, 2$ . We will denote by  $\ell_s^j$  the Banach space of complex sequences  $v = (v_n)_{n \in \mathcal{N}}$  with obvious vector space structure and with norm given  $b<sub>u</sub>$ 

$$
(3.1) \t ||v||_{\ell_s^j} := \left(\sum_{n \in \mathcal{N}} |n|^{js} |v_n|^j\right)^{1/j}, \ |n|^2 := \max(1, n_1^2 + \dots + n_d^2), \ \forall n = (n_1, \dots, n_d).
$$

We will denote by  $\ell^j$  the space  $\ell_0^j$ .

We define the set  $\mathcal{Z} := \mathcal{N} \times \{\pm 1\}$ ; for  $j = (a, \sigma) \in \mathcal{Z}$ , we define  $|j| := |a|$  and we denote  $\overline{j} := (a, -\sigma)$ . We identify  $(\xi, \eta) \in \mathbb{C}^{\mathcal{N}} \times \mathbb{C}^{\mathcal{N}}$  with  $(\zeta_j)_{j \in \mathcal{Z}} \in \mathbb{C}^{\mathcal{Z}}$  through the formula

$$
j = (a, \sigma) \in \mathcal{Z} \implies \begin{cases} \zeta_j = \xi_a & \text{if } \sigma = 1, \\ \zeta_j = \eta_a & \text{if } \sigma = -1. \end{cases}
$$

Now fix  $s \geq 1$ , and consider the scale of Banach spaces  $\mathcal{W}^s := \ell_s^1 \times \ell_s^1 \ni \zeta = (\xi, \eta)$ , endowed with the symplectic form

\Omega_1 := -\mathrm{i} \sum_{a \in \mathcal{N}} \mathrm{d} \xi_a \wedge \mathrm{d} \eta_a,

and the norm

$$
\|\zeta\|_{\mathcal W^s}:=\|\xi\|_{\ell^1_s}+\|\eta\|_{\ell^1_s},\ \ \forall \zeta=(\xi,\eta)\in \mathcal W^s.
$$

If we fix s and  $\mathcal{U}_s \subset \mathcal{W}^s$  open, the Hamiltonian vector field of the Hamiltonian function  $H \in C^1(\mathcal{U}_s, \mathbb{C})$ is given by

and for  $j = (a, \sigma) \in \mathcal{Z}$

\frac{\partial \mathsf{H}}{\partial \zeta_j} := \begin{cases} \frac{\partial \mathsf{H}}{\partial \zeta_a} & \text{if } \sigma = 1, \\ \frac{\partial \mathsf{H}}{\partial \eta_a} & \text{if } \sigma = -1. \end{cases}
$$

If we have  $\mathsf{F}, \mathsf{G} \in C^1(\mathcal{U}_s, \mathbb{C})$  the Poisson bracket  $\{\mathsf{F}, \mathsf{G}\}$  is defined by

$$
\{{\sf F},{\sf G}\}:=\nabla_\zeta{\sf F}^T\;\Omega_1^{-1}\nabla_\zeta{\sf G}\;=\;\mathrm{i}\;\sum_{a\in\mathcal{N}}\frac{\partial{\sf F}}{\partial\xi_a}\frac{\partial{\sf G}}{\partial\eta_a}-\frac{\partial{\sf F}}{\partial\eta_a}\frac{\partial{\sf G}}{\partial\xi_a}.
$$

We denote the open ball of radius R and center 0 in  $\ell_s^1$  by  $B_s(R)$ ; we write  $\mathcal{B}_s(R) := B_s(R) \times B_s(R) \subset \mathcal{W}^s$ . Now, we introduce the Fourier projection operators  $\hat{\pi}_j : \ell_s^1 \to \ell_s^1$

\hat{\pi}_j((v_n)_{n \in \mathbb{Z}^d \setminus \{0\}}) := \begin{cases} v_n & \text{if } j - 1 \le |n| < j \\ 0 & \text{otherwise} \end{cases}, \quad j \ge 1,

the operators  $\pi_j: \mathcal{W}^s \to \mathcal{W}^s$

\pi_j((\zeta_n)_{n \in \mathbb{Z}^d \setminus \{0\}}) := \begin{cases} \zeta_n & \text{if } j-1 \le |n| < j \\ 0 & \text{otherwise} \end{cases}, \quad j \ge 1,

and the operators  $\Pi_M : \mathcal{W}^s \to \mathcal{W}^s$

Last, we define the operator  $\overline{\pi_i} := id - \pi_i$ .

**Lemma 3.2.** The projection operators defined in  $(3.5)$  and  $(3.6)$  satisfy the following properties for any  $\zeta \in \mathcal{W}^s$ :

i. for any  $j > 0$

\zeta = \sum_{j\geq 0} \pi_j \zeta;

ii. for any  $j \geq 0$

If H is real, then we can introduce the coordinate  $(q_a, p_a)$  given by

We now describe the class of nonlinearities we are going to consider. Let  $l \geq 2$ , we consider  $j =$  $(j_1,\ldots,j_l) \in \mathcal{Z}^l$ , and where  $j_i = (a_i,\sigma_i)$ , with  $a_i \in \mathcal{N}$  and  $\sigma_i \in \{\pm 1\}$ , for all  $i \in \{1,\ldots,l\}$ . We define

$$
\overline{\mathbf{j}} := (\overline{j_1}, \ldots, \overline{j_l}), \ \overline{j_i} := (a_i, -\sigma_i), \ \ i = 1, \ldots, l.
$$

We also use the notation  $\zeta_j := \zeta_{j_1} \cdots \zeta_{j_l}$ , and we define the momentum  $\mathcal{M}(j)$  of a multi-index j and the set  $\mathcal{I}_l$  of indices with zero momentum as following,

**Definition 3.5.** We say that a polynomial P of degree k belongs to the class  $\mathcal{P}_k$  if P is real, it has a zero of order at least 2 in  $\zeta = 0$ , and if P contains only monomials of zero momentum, namely it is of the form

$$
P(\zeta) = \sum_{l=2}^{k} \sum_{\mathbf{j} \in \mathcal{I}_l} a_{\mathbf{j}} \zeta_{\mathbf{j}},
$$

where  $a_{\overline{i}} = \overline{a_{i}}$ , and the coefficients are bounded,

\forall \ell = 2, \ldots, k, \ \forall \mathbf{j} = (j_1, \ldots, j_l) \in \mathcal{I}_l, \ |a_{\mathbf{j}}| \leq C.

As an example, polynomials belonging to the class  $\mathcal{P}_k$  are the ones corresponding in Fourier variables to nonlinearities of the form  $\int_{\mathbb{T}^d} p(\psi(y), \phi(y)) dy$ , where  $p \in \mathbb{C}[X, Y]$  is a polynomial of degree k having a zero of order at least 2 at the origin and such that  $p(\psi, \overline{\psi}) \in \mathbb{R}$ .

We define the following norm

We mention the following result (see Proposition III.6 of  $[~~Fao12~~]; see also Proposition 2.8 of  $[FG11]$  $[~~Fao12~~]; see also Proposition 2.8 of  $[FG11]$ ),$$ which exploits the property of zero momentum.

**Proposition 3.6.** Let  $k \geq 2$  and  $s \geq 0$ , then  $\mathcal{P}_k \subset \mathcal{W}_s$ , and for  $P \in \mathcal{P}_k$  we have

 $\cdots X_{\mathsf{F}_{1j}} \in \mathcal{P}_1$  is analytic from  $\mathcal{B}_{s+2j}(R^*)$  to  $\mathcal{W}^s$ , and  $X_{\mathsf{F}_{2j}} \in \mathcal{P}_{k_j-1}$  is analytic from  $\mathcal{B}_s(R^*)$  to  $\mathcal{W}^s$ .

Moreover, there exists a non-increasing sequence of integers  $(j_r)_{r>1}$  with  $j_r \leq k$  for all  $r \geq 1$ such that for any  $r > 1$

The main result of this Section is the following theorem.

**Remark 3.8.** We observe that the terms  $\mathcal{Z}_{11}$  and  $\mathcal{Z}_{21}$  appearing in Theorem [3.7](#page-8-1) come from the terms  $F_{11}$  and  $F_{21}$ , respectively.

Moreover, we point out that the operator  $\delta F - \delta(F_{11} + \delta^{1+\nu}F_{21})$  has order  $\mathcal{O}(\delta^{2+\nu})$ , whereas the remainder in [\(3.19\)](#page-8-5) has order  $\mathcal{O}(\delta^{2(1+\nu)})$ , so it is larger (in terms of order of magnitude in  $\delta$ ) for  $\nu < 0$ ; this loss comes from the normal form procedure performed in the proof of Lemma [A.11.](#page-30-0) The assumption  $\nu > -\frac{1}{2}$  ensures that the remainder of the normal form procedure is smaller than the terms which are in normal form with the unperturbed Hamiltonian  $h_0$ , so that it can be regarded as a lower order correction.

On the other hand, in Sec.  $3.4$  and Sec.  $4$  we will exploit the fact that the Hamiltonian in normal form that we obtain has a very simple structure, and is associated to a semilinear Hamiltonian PDE whose solutions, under suitable assumptions, exhibit growth of their Sobolev norms.

<span id="page-9-0"></span>3.3. Proof of the Averaging Theorem. The proof of Theorem [3.7](#page-8-1) is actually an application of the techniques used in [\[Pas19\]](#page-40-18) and [\[BP06\]](#page-40-10)).

First notice that by assumption (INV) the Hamiltonian vector field of  $h_0$  generates a continuous flow  $\Phi_{\mathsf{h}_0}^{\tau}$  which leaves  $\Pi_M \mathcal{W}^s$  invariant.

Now we set  $H = H_{1,M} + \mathcal{R}_{1,M} + \mathcal{R}_1$ , where

The system described by the Hamiltonian [\(3.24\)](#page-9-1) is the one that we will put in normal form. In the following we will use the notation  $a \leq b$  to mean: there exists a positive constant K independent of M and R (but eventually on s), such that  $a \leq Kb$ . We exploit the following intermediate results:

Inequality [\(3.28\)](#page-9-2) follows from

\sup_{\zeta \in \mathcal{B}_{s+2+\sigma}(R)} \|X_{\mathcal{R}_{1,M}}(\zeta)\|_{\mathcal{W}^s} \n\lesssim \|dX_{\delta F_{11} + \delta^{1+\nu}F_{21}}\|_{L^{\infty}(\mathcal{B}_{s+2}(R), \mathcal{W}^s)} \|\mathrm{id} - \Pi_M\|_{L^{\infty}(\mathcal{B}_{s+2+\sigma}(R), \mathcal{B}_{s+2}(R))} \n\lesssim \delta^{1+\nu} M^{-\sigma},
$$

while estimate  $(3.29)$  is an immediate consequence of (HVF).

Lemma 3.10. For any  $s \geq s_1$

To normalize [\(3.24\)](#page-9-1) we need to prove a reformulation of Theorem 4.4 in [\[Bam99\]](#page-39-8). Here we report a statement of the result adapted to our context which is proved in Appendix [A.](#page-26-1)

Now we conclude with the proof of Theorem [3.7.](#page-8-1)

Proof of Theorem [3.7.](#page-8-1) If we define  $\delta_s := \delta_0$ , where  $\delta_0$  is the quantity appearing in the statement of Lemma [3.11,](#page-10-0) and we choose

<span id="page-11-0"></span>3.4. Application to the KG lattice. We want to study small amplitude solutions of  $(2.6)$ , with initial data in which only one low-frequency Fourier mode is excited.

The first step is to introduce an interpolating function  $Q = Q(t, x)$  such that

- (B1)  $Q(t, j) = Q_j(t)$ , for all  $j \in \mathbb{Z}_N^d$ ;
- (B2) Q is periodic with period  $2N + 1$  and odd in the  $x_j$ -variable, for all  $j = 1, ..., d$ ;
- (B3) Q fulfills

\ddot{Q} = -Q + \Delta_1 Q - \beta Q^{2\ell+1},
$$

where  $\Delta_1$  is the operator defined by

$$

One can check that the operator  $(3.36)$  is equivalent to  $(2.4)$  by using functional calculus.

It is easy to verify that  $(3.35)$  is Hamiltonian with Hamiltonian function

\mathsf{H}_{KG}(Q,P) = \int_{[-\frac{1}{\mu},\frac{1}{\mu}]^d} \left( \frac{P^2}{2} + \frac{Q^2}{2} - \frac{Q \Delta_1 Q}{2} + \beta \frac{Q^{2\ell+2}}{2\ell+2} \right) dx,
$$

where  $P$  is a periodic function and is canonically conjugated to  $Q$ .

Starting from the Hamiltonian [\(3.37\)](#page-12-1), we look for small amplitude solutions of the form

Q(t,x) = \mu^{\alpha} q(t, \mu x), \ \ 0 < \alpha \leq \frac{1}{\ell},

where  $q : \mathbb{R} \times [-1,1]^d \to \mathbb{R}$  is a space-periodic function and  $\mu$  is defined in [\(2.12\)](#page-4-2).

<span id="page-12-0"></span>Remark 3.12. The ansatz [\(3.38\)](#page-12-2) introduces a relation between the number of particles of the lattices (through the quantity  $\mu$ ) and the specific energy, which we denote by  $\epsilon$ . Indeed, we have

where  $p$  is the variable canonically conjugated to  $q$ .

We now exploit the change of coordinates  $(q, p) \mapsto (\psi, \bar{\psi})$  given by

so that the inverse change of coordinates is given by

Observe that the remainder is of higher-order with respect to the leading part of the Hamiltonian, since

**Proposition 3.13.** Assume that the condition  $(3.53)$  holds true. Then the average of  $\mathsf{F}$  in  $(3.48)$  with respect to the flow of  $h(3.48)$  $h(3.48)$  is given by

\langle F \rangle (\xi, \eta) = \sum_{h \in \mathbb{Z}^d} \frac{1}{2} |h|^2 \xi_h \eta_h + \mu^{2(\ell \alpha - 1)} \frac{\beta}{2^{\ell+1} (2\ell+2)} \sum_{\substack{h_1, \dots, h_{2\ell+2} \in \mathbb{Z}^d \\ \sum_{j} (-1)^{j-1} h_j = 0}} \xi_{h_1} \eta_{h_2} \cdots \xi_{h_{2\ell+1}} \eta_{h_{2\ell+2}}.
$$

<span id="page-13-1"></span>Corollary 3.14. Assume that the condition  $(3.49)$  holds true. Then the equations of motion associated to h( $\xi, \eta$ ) +  $\mu^2$   $\langle F \rangle$  ( $\xi, \eta$ ) are given by the following nonlinear Schrödinger equation (NLS),

is satisfied, then Eq. [\(3.52\)](#page-13-2) is a small-dispersion NLS.

**Remark 3.15.** By Corollary [3.14](#page-13-1) and [\(3.47\)](#page-12-4) we obtain that the function  $\psi$  introduced in [\(3.43\)](#page-12-5) satisfies

Observe that if we introduce the second time scale  $\tau = \frac{1}{2} \mu^{2\ell \alpha} t$  and we consider  $\varphi = e^{-i 2 \tau / \mu^{2\ell \alpha}} \psi$ , then the rescaled Hamiltonian  $K_2 = 2\mu^{-2\ell\alpha} K_1$  has associated equations of motions equivalent to

-i \partial_{\tau} \xi_h = -\mu^{2(1-\ell\alpha)} |h|^2 \xi_h + \beta 2^{-(\ell+1)} \begin{pmatrix} 2\ell+2 \\ \ell+1 \end{pmatrix} \sum_{\substack{h_1,\ldots,h_{2\ell+1} \in \mathbb{Z}^d \\ \sum_{j}(-1)^{j-1}h_j = h}} \xi_{h_1} \eta_{h_2} \cdots \eta_{h_{2\ell}} \xi_{h_{2\ell+1}},
$$

## 4. Dynamics of the NLS equation with small dispersion

<span id="page-14-0"></span>In this Section we recall some known facts on the dynamics of the defocusing small-dispersion NLS equation with periodic boundary conditions. The interested reader can find more detailed explanations and proofs in [\[Kuk95\]](#page-40-24) [\[Kuk96\]](#page-40-25) [\[Kuk97\]](#page-40-15).

Consider the defocusing NLS equation

<span id="page-14-2"></span>(4.1) 
$$
-i\varphi_{\tau} = -\varepsilon \Delta_y \varphi + |\varphi|^{2\ell} \varphi, \quad \varphi(0) = \varphi_0, \quad \varepsilon > 0, \quad y \in \mathbb{T}^d := (\mathbb{R}/(2\pi\mathbb{Z}))^d.
$$

Eq. [\(4.1\)](#page-14-2) is a PDE admitting a Hamiltonian structure: indeed, the associated Hamiltonian is given by

(4.2) 
$$
\mathsf{H}_{\text{NLS}}(\varphi,\bar{\varphi}) := \int_{\mathbb{T}^d} \left( \frac{\varepsilon}{2} \left| \nabla \varphi \right|^2 + \frac{1}{2\ell+2} \left| \varphi \right|^{2\ell+2} \right) dy.
$$

We first mention the following result, which states that if the dispersion in  $(4.1)$  is sufficiently small, then there exists a time at which the solution doubles its Sobolev norm (see Theorem 1 of [\[Kuk97\]](#page-40-15) and its rescaled version in Sec. 3 of [\[Kuk97\]](#page-40-15)).

<span id="page-14-3"></span>**Proposition 4.1.** Consider [\(4.1\)](#page-14-2) for  $d \in \{1, 2, 3\}$ , under odd periodic boundary conditions.

Let  $m \geq 3$ , and set  $\nu := 2\ell + 1/m$ . Assume that the initial datum  $\varphi_0$  of [\(4.1\)](#page-14-2) satisfies

$$
\|\varphi_0\|_{L^2} = \varrho > 0, \ \|\varphi_0\|_{H^m} = r > 0.
$$

Then there exists  $\lambda^* = \lambda^*(m) \in (0, 1/\nu)$  such that for all  $\lambda \in (0, \lambda^*)$ , if the condition

<span id="page-14-4"></span>ϱ ≥ K ε<sup>λ</sup> r <sup>1</sup>−2ℓλ (4.3)

holds true, then there exist  $C > 0$  independent from m and  $t_1 > 0$  satisfying

<span id="page-14-6"></span>(4.4) 
$$
t_1 \leq K_1 r^{\nu - 2\ell} \varrho^{-\nu} \leq K_2 \varepsilon^{-\nu \lambda} r^{-2\ell(1 - \nu \lambda)}, \quad K_2 = K_1 K^{-\nu},
$$

such that  $\|\varphi(t_1)\|_{H^m} = 2r$ , and  $\|\varphi(t_1)\|_{H^m} < 2r$  for  $0 \le t < t_1$ .

A consequence of Proposition [4.1](#page-14-3) is the following result, which describes the dynamics of solutions of small-dispersion NLS up to a time scale proportional to the inverse of the dispersion, showing that such solutions display a growth of their Sobolev norm (see Theorem 2 of [\[Kuk97\]](#page-40-15)).

<span id="page-14-1"></span>**Theorem 4.2.** Consider [\(4.1\)](#page-14-2) for  $d \in \{1, 2, 3\}$ , under odd periodic boundary conditions.

Let  $m \geq 3$ , and set  $\nu := 2\ell + 1/m$ . Then there exists  $\lambda^* = \lambda^*(m) \in (0, 1/\nu)$  such that for all  $\lambda \in (0, \lambda^{\star}), \text{ if we define the set }$ 

(4.5) 
$$
\mathcal{A} := \mathcal{A}(m,\ell,\lambda) := \left\{ \varphi \in H^m(\mathbb{T}^d) \, | \, \|\varphi\|_{H^m} > K^{-\frac{1}{1-2\ell\lambda}} \, \varepsilon^{-\frac{\lambda}{1-2\ell\lambda}} \, \|\varphi\|_{L^2}^{\frac{1}{1-2\ell\lambda}} \right\},
$$

the following holds true: if  $\varphi$  is a solution of [\(4.1\)](#page-14-2) such that  $\varphi_0 \notin \mathcal{A}$  and  $\|\varphi_0\|_{H^m} = r$ , then there exists  $T > 0$  satisfying

<span id="page-14-5"></span>(4.6) 
$$
T \leq \frac{1}{1 - 2^{-2\ell(1 - \nu\lambda)}} K^{-\nu} \varepsilon^{-\nu\lambda} r^{-2\ell(1 - \nu\lambda)},
$$

such that  $\varphi(T) \in \mathcal{A}$ .

<span id="page-15-1"></span>**Remark 4.3.** The fact that  $\varphi_0 \notin \mathcal{A}$  can be seen as a condition on the dispersion  $\varepsilon$ , since it is equivalent  $to$

\varepsilon \leq \varepsilon_0 := \left(\frac{\|\varphi_0\|_{L^2}}{K \|\varphi_0\|_{H^m}^{1-2\ell\lambda}}\right)^{1/\lambda},
$$

see also the corresponding condition  $(4.3)$  in Proposition [4.1.](#page-14-3)

Kuksin also proved that for every  $a > 0$  one can choose K such that

(4.9) 
$$
\lim_{m \to \infty} \frac{1}{m} \frac{\lambda^*(m)}{1 - 2\ell \lambda^*(m)} = \frac{1}{B_0},
$$

see Proposition 1 and pag. 346 in  $Kuk97$ .

We point out that the time T in  $(4.6)$  is obtained by looking at the proof of Theorem 2 in [\[Kuk97\]](#page-40-15), which is in turn based on the estimate  $(4.4)$  in Proposition [4.1.](#page-14-3) In the actual statement of the Theorem, the time T is bounded by using that  $\frac{1}{1-2^{-2\ell(1-\nu\lambda)}} \leq C_1 2\ell(1-\nu\lambda)$  and the asymptotics [\(4.8\)](#page-15-2), leading to

<span id="page-15-3"></span>(4.10) 
$$
T \leq C m K^{-\nu} \varepsilon^{-\nu \lambda} r^{-2\ell(1-\nu\lambda)} \leq C m K^{-1/\lambda} \varepsilon^{-1},
$$

where the second estimate in [\(4.10\)](#page-15-3) follows from the fact that if  $\varphi_0 \notin A$ , we have  $r \geq ||\varphi_0||_{L^2} \geq$  $K \varepsilon^{\lambda} r^{1-2\ell\lambda}$ , hence  $r^{2\ell} \geq K^{1/\lambda} \varepsilon$ .

**Remark 4.4.** Kuksin proved also that under the assumptions of Theorem [4.2,](#page-14-1) if moreover  $\|\varphi_0\|_{L^2} = 1$ , then

\lambda^*(m) \leq \frac{1}{2} \frac{m}{1 + 2\ell m},
$$

see Theorem 5 in [\[Kuk97\]](#page-40-15).

<span id="page-15-5"></span>**Remark 4.5.** For our application to the KG lattice we have from  $(3.55)$  that  $\varepsilon = \mu^{2(1-\ell\alpha)}$ , which by  $(4.10)$  it implies that in the original time scale t

$$
t \leq \mathcal{O} \left( \frac{1}{\mu^{2(\nu \lambda + \ell \alpha (1 - \nu \lambda))}} \right) \; \leq \; \mathcal{O} \left( \frac{1}{\mu^2} \right).

#### 5. APPROXIMATION RESULTS

<span id="page-15-0"></span>In this Section we show how to use the normal form equations in order to construct approximate solutions of [\(2.6\)](#page-3-2), and we estimate the difference with respect to the true solutions with corresponding initial data.

Recall that for  $(2.6)$  we defined the energy of normal mode  $E_k$ ,  $k \in \mathbb{Z}_N^d$ , in  $(2.8)$ ; also recall that for any  $k \in \mathbb{Z}_N^d$  we defined the corresponding specific wave vector  $\kappa := \kappa(k)$  in [\(2.10\)](#page-3-5).

In this section, we first point out a relation between the specific energy of normal mode  $\mathcal{E}_\kappa$  =  $2^d E_k/N_d$ , and the Fourier coefficients of the solutions of the normal form equations, see Lemma [5.1](#page-16-0) and Proposition [5.2;](#page-17-0) this procedure has to be done carefully, since all wavevectors of the form  $k +$  $((2N+1)h_1,\ldots,(2N+1)h_d)$   $(h=(h_1,\ldots,h_d)\in\mathbb{Z}^d)$  contribute to the specific energy  $\mathcal{E}_{\kappa}$  of the discrete system. Then we prove that the approximate solutions approximate the specific energy of the true normal mode  $\mathcal{E}_{\kappa}$  up to the time-scale for which the continuous approximation is valid, see Proposition [5.3.](#page-17-1) For simplicity we present in this Section only the main part of the argument, and we defer the proof of Proposition [5.2](#page-17-0) to Appendix [B.](#page-35-0)

The component  $k$  of the Fourier transform of the continuous approximation at time  $t$  will be denoted by  $\hat{Q}(t, k)$  to distinguish it from the k-th component of the Fourier transform of the discrete variable  $\hat{Q}_k(t)$ . Since for the rescaled functions such as q and p this ambiguity does not hold, we prefer the short notation  $\hat{q}_k(\tau)$  and  $\hat{p}_k(\tau)$  for their Fourier transform.

Let  $\beta > 0$  and let I be as in [\(3.40\)](#page-12-6), we define the Fourier coefficients of the function  $q: I \to \mathbb{R}$  by

(5.1) 
$$
\hat{q}_k := \frac{1}{2^{d/2}} \int_I q(y) e^{-i\pi k \cdot y} dy, \quad k \in \mathbb{Z}^d,
$$

and similarly for the Fourier coefficients of the function p.

<span id="page-16-0"></span>Lemma 5.1. Consider the lattice  $(2.3)$  in the regime  $(3.39)$  and with interpolating function  $(3.38)$ . Then for a state corresponding to  $(q, p)$  one has

<span id="page-16-4"></span>
$$
(5.2) \qquad \mathcal{E}_{\kappa} = \frac{\mu^{2\alpha}}{2} \sum_{L \in \mathbb{Z}^d : \mu L \in (2\mathbb{Z})^d} |\hat{p}_{K+L}|^2 + \omega_K^2 |\hat{q}_{K+L}|^2, \ \ \kappa = \mu K, \ \ K = (K_1, \dots, K_d) \in \mathbb{Z}_N^d,
$$

where the  $\omega_K$  are defined as in [\(2.9\)](#page-3-6).

*Proof.* First we introduce a smooth  $(2N+1)^d$ -periodic interpolating function for  $Q_j$ , and we denote it by  $Q$ , and similarly for  $P_j$ . We denote by

(5.3) 
$$
\hat{Q}(j) := \frac{1}{(2N+1)^{d/2}} \int_{\left[ -(N+\frac{1}{2}), (N+\frac{1}{2}) \right]^d} Q(x) e^{-i \frac{2\pi}{2N+1} j \cdot x} dx,
$$

so that by the interpolation property we obtain

$$
Q_j(t) = Q(t,j) = \frac{1}{(2N+1)^{d/2}} \sum_{k \in \mathbb{Z}^d} \hat{Q}(j) e^{-i\frac{2\pi}{2N+1}j \cdot k}
$$
  
= 
$$
\frac{1}{(2N+1)^{d/2}} \sum_{k=(k_1,\ldots,k_d) \in \mathbb{Z}_N^d} e^{-i\frac{2\pi}{2N+1}j \cdot k} \times
$$
  

$$
\times \left[ \sum_{h=(h_1,\ldots,h_d) \in \mathbb{Z}^d} \hat{Q}(k_1 + (2N+1)h_1,\ldots,k_d + (2N+1)h_d) \right],
$$

hence

<span id="page-16-1"></span>(5.4) 
$$
\hat{Q}_k = \sum_{h \in \mathbb{Z}^d} \hat{Q}(k_1 + (2N+1)h_1, \dots, k_d + (2N+1)h_d), \ \ \forall \ k \in \mathbb{Z}_N^d.
$$

The relation between  $\hat{Q}(k)$  and  $\hat{q}_k$  can be deduced from [\(3.38\)](#page-12-2), which gives  $Q(j) = \mu^{\alpha}q(\mu j)$  for all  $j \in \mathbb{Z}_N^d$ . This implies that

$$
\hat{Q}_k = \frac{1}{2^{d/2}} \mu^{d/2} \int_{\left[-\frac{1}{\mu},\frac{1}{\mu}\right]^d} Q(x) e^{-i\pi(\mu k \cdot x)} dx
$$

$$
= \frac{1}{2^{d/2}} \mu^{\alpha + d/2} \int_{\left[-\frac{1}{\mu},\frac{1}{\mu}\right]^d} q(\mu x) e^{-i\pi(\mu k \cdot x)} dx
$$

$$
(5.5)
$$

$$
\stackrel{(3.38)}{=} \frac{1}{2^{d/2}} \mu^{\alpha - d/2} \int_I q(y) e^{-i\pi k \cdot y} dy = \mu^{\alpha - d/2} \hat{q}_k, \quad \forall k \in \mathbb{Z}_N^d,
$$

<span id="page-16-3"></span>and similarly

<span id="page-16-2"></span>(5.6) 
$$
\hat{P}_k = \mu^{\alpha - d/2} \hat{p}_k, \quad \forall \, k \in \mathbb{Z}_N^d.
$$

By using [\(2.11\)](#page-4-3) and [\(5.4\)](#page-16-1)-[\(5.6\)](#page-16-2) we have that for  $\kappa = \mu K$ ,  $K = (K_1, ..., K_d) \in \mathbb{Z}_N^d$ ,

$$
\mathcal{E}_{\kappa} \stackrel{(2.11)}{=} \mu^d \frac{1}{2} \sum_{L \in \mathbb{Z}^d : \mu L \in (2\mathbb{Z})^d} |\hat{P}_{K+L}|^2 + \omega_K^2 |\hat{Q}_{K+L}|^2
$$
  

$$
\stackrel{(5.5)}{=} \mu^d \mu^{2\alpha - d} \frac{1}{2} \sum_{L \in \mathbb{Z}^d : \mu L \in (2\mathbb{Z})^d} |\hat{p}_{K+L}|^2 + \omega_K^2 |\hat{q}_{K+L}|^2,
$$

and this leads to  $(5.2)$ . □

<span id="page-17-0"></span>**Proposition 5.2.** Fix  $s > \frac{d}{2} + 1$  and  $0 < \delta < 1$ .

Consider the normal form system [\(3.56\)](#page-14-7), with  $(\xi, \eta) \in \mathcal{W}^s$ , and denote by  $\mathcal{E}_\kappa$  the specific energy of the normal mode with index  $\kappa$  as defined in [\(2.10\)](#page-3-5)-[\(2.11\)](#page-4-3). Then for any sufficiently small  $\mu > 0$  there exist positive constants  $C, c_1, c_2$  and  $M$  such that

\left|\frac{\mathcal{E}_{\kappa}}{\mu^{2\alpha}} - \frac{\xi_{K} \eta_{K}}{2}\right| \leq C \mu^{c_{1}} \|(\xi, \eta)\|_{\mathcal{W}^{s}}^{2}, \quad c_{1} = c_{1}(\delta),
$$

for  $\kappa = \mu K$ ,  $K = (K_1, \ldots, K_d) \in \mathbb{Z}_N^d$  and  $|K_1| + \cdots + |K_d| \leq M = M(\delta)$ , and

(5.8)  $|\mathcal{E}_{\kappa}| \leq C \,\mu^{c_2} \|(\xi,\eta)\|_{\mathcal{W}^s}^2, \ \ c_2 = c_2(\delta,\alpha,s,d)$ 

for  $\kappa = \mu K$ ,  $K = (K_1, \ldots, K_d) \in \mathbb{Z}_N^d$  and  $|K_1| + \cdots + |K_d| > M$ . More explicitly, we have

<span id="page-17-7"></span>(5.9) 
$$
c_1 = 2\delta, \ \ M = \mu^{-(1-\delta)}, \ \ c_2 = 2\alpha + (1-\delta)(2s-d-2).
$$

The proof of the above Proposition is deferred to Appendix [B.](#page-35-0)

<span id="page-17-1"></span>**Proposition 5.3.** Let us consider [\(2.3\)](#page-3-1) with  $\beta > 0$ .

Let  $m > s + s_0 + \frac{d}{2} \gg 1$ , where  $s_0 > 0$  is the exponent for which Theorem [3.7](#page-8-1) holds true. Let  $\nu, \lambda^* > 0$ be defined as in Theorem [4.2,](#page-14-1) and assume that  $\lambda \in (0, \lambda^*)$ .

Let us assume that the initial datum satisfies [\(6.1\)](#page-22-2) with  $\alpha_0 < \alpha < 1/\ell$ , where

$$
\alpha_0=\alpha_0(m,d,\ell,\lambda)
$$

<span id="page-17-2"></span>
$$
(5.10) \qquad := \frac{1}{\ell} \, \max\left(1 - (1 + \nu\lambda)^{-1} \, \left(1 - \frac{d}{4}\right), \frac{1 - \nu\lambda + [(1 - \nu\lambda)^2 + 8\nu\lambda]^{1/2}}{4}, \frac{d}{4} + \frac{1}{16}, \frac{1}{2}\right),
$$

and denote by  $(Q_j(t), P_j(t))_{j\in\mathbb{Z}_N^d}$  the corresponding solution. Consider the approximate solution  $\zeta_a(t,x)$  $(\tilde{\xi}_a(t,x), \tilde{\eta}_a(t,x))$  with initial datum  $\tilde{\zeta}_{a,0} = (\tilde{\xi}_{a,0}, \tilde{\eta}_{a,0}) \in \mathcal{W}^{s+s_0} \cap (\ell^2_m \times \ell^2_m)$ , and assume that  $\tilde{\zeta}_a \in \mathcal{W}^{s+s_0}$ <br>for all times. Moreover, let  $0 \leq \tilde{\delta} \leq 1$  let  $a_n = a_n(\tilde{\delta}) > 0$  and for all times. Moreover, let  $0 < \delta < 1$ , let  $c_1 = c_1(\delta) > 0$  and  $M = M(\delta) > 0$  be as in Proposition [5.2,](#page-17-0) and assume that  $\frac{1}{16} c_1 \in (0, 2\ell\alpha - \frac{d}{2}).$ 

Then there exist  $T_0$ ,  $\mu_0 = \mu_0(\alpha, \|\tilde{(\xi_{a,0}, \tilde{\eta}_{a,0})\|_{\mathcal{W}^{s+s_0}})$  such that, if  $\mu < \mu_0$ , we have that there exists  $C > 0$  such that

<span id="page-17-3"></span>(5.11) 
$$
\sup_j |Q_j(t) - Q_a(t,j)| + |P_j(t) - P_a(t,j)| \leq C \mu^{\alpha + c_1/16}, \quad \forall |t| \leq \frac{T_0}{\mu^{2(\nu \lambda + \ell \alpha (1 - \nu \lambda))}},
$$

where  $(Q_a, P_a)$  are given by considering  $(\tilde{\xi}_{a,0}, \tilde{\eta}_{a,0})$  and applying  $(3.47)$ ,  $(3.44)$  and  $(3.38)$ . Moreover,

<span id="page-17-4"></span>(5.12) 
$$
\left|\frac{\mathcal{E}_{\kappa}(t)}{\mu^{2\alpha}} - \frac{\widetilde{\xi}_{a,K}(t)\widetilde{\eta}_{a,K}(t)}{2}\right| \leq C \,\mu^{c_1/16}, \quad \forall |t| \leq \frac{T_0}{\mu^{2(\nu\lambda + \ell\alpha(1-\nu\lambda))}}
$$

for  $\kappa = \mu K$ ,  $K = (K_1, \ldots, K_d) \in \mathbb{Z}_N^d$  and  $|K_1| + \ldots + |K_d| \leq M$ . Moreover, there exists  $\varrho := \varrho(\delta, \alpha, s, d)$ such that

<span id="page-17-5"></span>(5.13) 
$$
|\mathcal{E}_{\kappa}(t)| \leq \mu^{2\alpha + \varrho}, \ \forall |t| \leq \frac{T_0}{\mu^{2(\nu\lambda + \ell\alpha(1-\nu\lambda))}},
$$

for  $\kappa = \mu K$ ,  $K = (K_1, ..., K_d) \in \mathbb{Z}_N^d$  and  $|K_1| + ... + |K_d| > M$ .

<span id="page-17-6"></span>**Remark 5.4.** Observe that the assumption  $c_1 < 16 \left(2\ell\alpha - \frac{d}{2}\right)$  is equivalent to  $\delta < 8\left(2\ell\alpha - \frac{d}{2}\right)$ , which is automatically satisfied since  $1 \leq 8(2\ell\alpha_0 - \frac{d}{2})$ ;  $\ell\alpha_0 \geq \frac{d}{4} + \frac{1}{16}$ .

One can check from [\(5.10\)](#page-17-2) that

$$
\frac{1}{2\ell} \le \alpha_0 < \frac{7}{8\ell}, \ \ \forall d \in \{1, 2, 3\}, \ \ \forall \ell \ge 1, \ \ \forall m > 1, \ \ \forall \lambda \in (0, \lambda^*).
$$

Proof. The proof combines the argument in Appendix E of [\[GP21\]](#page-40-13) (see also Appendix C of [\[BP06\]](#page-40-10) for the one-dimensional case) together with the argument in Appendix B of [\[GK15\]](#page-40-32) .

Exploiting the canonical transformation found in Theorem [3.7,](#page-8-1) we also define

(5.14) 
$$
\zeta_a := \mathcal{T}_{\mu^2}(\tilde{\zeta}_a) = \tilde{\zeta}_a + \phi_a(\tilde{\zeta}_a),
$$

where  $\phi_a(\tilde{\zeta}_a) := (\phi_{\xi}(\tilde{\zeta}_a), \phi_{\eta}(\tilde{\zeta}_a))$ ; by  $(3.22)$  we have

<span id="page-18-2"></span>(5.15) 
$$
\sup_{\zeta \in \mathcal{B}_s(R)} \|\phi_a(\zeta)\|_{\mathcal{W}^s} \leq C'_s \mu^{2\ell\alpha} R.
$$

For convenience we define

$$
(5.16) \qquad q_a(\tau, y) := \frac{1}{\sqrt{2}} \left[ e^{i\tau} \tilde{\xi}_a(\tau, y) + e^{-i\tau} \tilde{\eta}_a(\tau, y) \right], \quad p_a(\tau, y) := \frac{1}{\sqrt{2}i} \left[ e^{i\tau} \tilde{\xi}_a(\tau, y) - e^{-i\tau} \tilde{\eta}_a(\tau, y) \right].
$$

We observe that the pair  $(q_a, p_a)$  satisfies

$$
\mu(q_a)_t = \mu p_a + \mu^{2\ell \alpha + 1} \mathcal{R}_q, \quad \mu(p_a)_t = -\mu q_a + \mu \Delta_1 q_a - \mu^{2\ell \alpha + 1} \beta \overline{\pi_0} q_a^{2\ell + 1} + \mu^{4\ell \alpha + 1} \mathcal{R}_p,
$$

where the operator  $\Delta_1$  acts on the variable x,  $\overline{\pi_0}$  is the projector on the space of the functions with zero average, and the remainders are functions of the rescaled variables  $\tau$  and  $y$  which satisfy

$$
\sup_{\mathcal{B}_{s+s_0}(R)} \|(\mathcal{R}_q, \mathcal{R}_p)\|_{\mathcal{W}^s} \leq C,
$$

due to estimate [\(3.21\)](#page-9-4) in Theorem [3.7.](#page-8-1)

We now restrict the space variables to integer values; keeping in mind that  $q_a$  and  $p_a$  are periodic, we restrict to  $j \in \mathbb{Z}_N^d$ . Now let  $Q = (Q_j)_{j \in \mathbb{Z}_N^d}$  a finite sequence, we define the following norms

$$
\|Q\|_k:=\left(\sum_{j\in\mathbb{Z}_N^d}\, |Q_j|^k\,\right)^{1/k},\;\;k=1,2.
$$

Now we consider the discrete model  $(2.3)$ : we rewrite it in the following form,

\n $\dot{P}_j = Q_j + (A_1 - A_2) = 2P_j$ 

<span id="page-18-1"></span>(5.19)  $\dot{P}_j = -Q_j + (\Delta_1 Q)_j - \beta \overline{\pi_0} Q_j^{2\ell+1},$ 

and we want to show that there exist two sequences  $E = (E_j)_{j \in \mathbb{Z}_N^d}$  and  $F = (F_j)_{j \in \mathbb{Z}_N^d}$  such that

$$
Q = \mu^{\alpha} q_a + \mu^{\alpha + \gamma} E, \ P = \mu^{\alpha} p_a + \mu^{\alpha + \gamma} F, \ \ \gamma := c_1/16,
$$

fulfills [\(5.18\)](#page-18-0)-[\(5.19\)](#page-18-1). Therefore, we have that

$$
(5.20) \qquad \dot{E} = F - \mu^{2\ell \alpha - \gamma} \mathcal{R}_q
$$

<span id="page-18-4"></span>(5.21) 
$$
\dot{F} = -E + \Delta_1 E - \beta \pi_0 \mu^{2\ell \alpha} \left( \sum_{k=0}^{2\ell} \mu^{(2\ell - k)\gamma} \binom{2\ell + 1 - k}{k} q_a^k E^{2\ell + 1 - k} \right) - \mu^{4\ell \alpha - \gamma} \mathcal{R}_p,
$$

where we impose initial conditions on  $(E, F)$  such that  $(q_a, p_a)$  has initial conditions corresponding to the ones of the true initial datum,

$$
\mu^{\alpha} q_a(0,\mu j) + \mu^{\alpha+\gamma} E_{0,j} = Q_{0,j}, \ \mu^{\alpha} p_a(0,\mu j) + \mu^{\alpha+\gamma} F_{0,j} = P_{0,j}.
$$

We now define the operator  $\partial_i$ ,  $i = 1, \ldots, d$ , by  $(\partial_i f)_j := f_j - f_{j - e_i^{(d)}}$  for all  $f \in \ell_0^2 \cap \ell_0^1$  such that  $||f||_k < +\infty$ ,  $k = 1, 2$ .

• Claim 1: Let  $\gamma > 0$ , we have

E_0 = \mu^{\alpha} \frac{\psi_a + \bar{\psi}_a - (\tilde{\psi}_a + \tilde{\bar{\psi}}_a)}{\sqrt{2} \mu^{\alpha + \gamma}} = \mu^{-\gamma} \frac{\phi_{\xi} + \phi_{\eta}}{\sqrt{2}},
$$
  

$$
F_0 = \mu^{\alpha} \frac{\psi_a - \bar{\psi}_a - (\tilde{\psi}_a - \tilde{\bar{\psi}}_a)}{\sqrt{2} i \mu^{\alpha + \gamma}} = \mu^{-\gamma} \frac{\phi_{\xi} - \phi_{\eta}}{\sqrt{2} i},
$$

We conclude with some important remarks about the proof of Proposition [5.3.](#page-17-1)

**Remark 5.5.** We stress the fact that  $(5.17)$ , unlike the bound  $(C.7)$  in [\[BP06\]](#page-40-10) and the estimate after Eq.  $(260)-(261)$  in [\[GP21\]](#page-40-13), means that the remainder (which is evaluated on an approximate solution) is bounded in the space  $W^s$ , which is based on  $\ell_s^1$ ; see also the estimate (3.19) in Theorem 4 of [\[GK15\]](#page-40-32), where such bound is used in the context of proving growth of Sobolev norms for the NLS equation.

# 6. Statement and Proof of the Main Result

<span id="page-22-0"></span>Here we state and we prove our main result, Theorem [6.1.](#page-22-1) The main issue in the proof of the theorem is to determine to which extent we can show that the discrete Klein-Gordon lattice [\(2.3\)](#page-3-1) displays an energy cascade phenomenon as its approximating PDE, the small-dispersion NLS [\(3.54\)](#page-13-6).

Now we state our main result.

<span id="page-22-1"></span>**Theorem 6.1.** Consider [\(2.3\)](#page-3-1) with  $\beta > 0$ ,  $\ell \ge 1$ , and let  $\frac{7}{8} \ell^{-1} < \alpha_1 < \left(1 - \frac{1}{2^6}\right) \ell^{-1}$ .

Then there exists  $m_0 \gg 1$  such that for all  $m \geq m_0$  there exist positive  $\lambda_0$  and  $\lambda_1$  such that for any  $\lambda \in (\lambda_0, \lambda_1)$  the following holds true.

There exist  $\alpha_0 > 0$  and  $\delta_0 > 0$  such that for any  $\delta \in (\delta_0, 1)$  and for any  $\alpha \in (\alpha_0, \alpha_1)$  there exists a sufficiently small  $\mu_0 > 0$  such that for all positive  $\mu < \mu_0$ , if the initial datum satisfies

**Remark 6.2.** From the proof of Theorem [6.1](#page-22-1) one can highlight the dependence of the quantities  $m_0$ ,  $\lambda_0$ ,  $\lambda_1, \alpha_0, \delta_0, \mu_0, K, T_m$  and c from the parameters introduced in the statement of the Theorem [6.1.](#page-22-1)

More precisely, we have  $m_0 = m_0(d, \ell, s, s_0) > s + s_0 + \frac{d}{2}$ , where the exponents  $s_0$  and s appear in the statement of Theorem [3.7.](#page-8-1) We also have  $\lambda_0 = \lambda_0(m, d, \ell, \alpha_1), \lambda_1 = \lambda_1(m, d, \ell), \alpha_0 = \alpha_0(m, d, \ell, \lambda),$  $\delta_0 = \delta_0(m, d, \ell, \alpha_1, \lambda), \mu_0 = \mu_0(m, d, \delta, \ell, \alpha, \lambda), K = K(\ell, m, \lambda), T_m = T_m(\mu, \ell, \alpha, \lambda)$  and  $c = c(\ell, \lambda)$ .

**Remark 6.3.** Theorem [6.1,](#page-22-1) and in particular  $(6.3)$ , gives an analytical description of an energy cascade for the KG lattice. As mentioned in comment i. of the introduction, the regimes of specific energy described in Theorem [6.1](#page-22-1) are above the regime for which one can prove the existence of metastability phenomena, but they also are below the so-called thermodynamic limit.

We observe that the fact that  $d \leq 3$  is a consequence both of Theorem [4.2](#page-14-1) about the growth of Sobolev norms for the small-dispersion NLS equation, and of Proposition [5.3](#page-17-1) regarding the approximation of the normal modes of the lattice with the Fourier modes of the PDE.

Remark 6.4. Here we mention where the different quantities mentioned in the statement of Theorem [6.1](#page-22-1) appear in the paper, in order to highlight their role and to give a better explanation of the interplay between the different intermediate results.

The exponent  $m_0$  is defined at the end of the proof of Theorem [6.1.](#page-22-1)

The exponent  $\lambda_0$  is defined at the end of the proof of Theorem [6.1,](#page-22-1) by using the asymptotics [\(4.9\)](#page-15-4), while the exponent  $\lambda_1$  is defined at the beginning of the proof of Theorem [6.1.](#page-22-1)

We observe that the exponent  $\alpha_0$  is defined in the statement of Proposition [5.3,](#page-17-1) see [\(5.10\)](#page-17-2), and is essential in order to ensure that the approximation estimates [\(5.11\)](#page-17-3), [\(5.12\)](#page-17-4) and [\(5.13\)](#page-17-5) hold true. The exponent  $\alpha_1$  is defined due to Remark [5.4](#page-17-6) and is needed in the proof of Theorem [6.1](#page-22-1) in order to ensure that the remainders are smaller than the growth for the small-dispersion NLS stated in Theorem  $\downarrow$ .2. The precise upper bound on  $\alpha_1$  is irrelevant, the important property is that  $\alpha_1$  is bounded away from  $\ell^{-1}$ .

The threshold  $\delta_0 > 0$  is defined at the end of the proof of Theorem [6.1;](#page-22-1) the fact that the threshold is positive implies that in Proposition [5.3](#page-17-1) we prove that the normal modes of the lattice are close to the Fourier modes of the approximating PDE only if the associated frequency is not too high, see [\(5.12\)](#page-17-4).

The time  $T_m$  appearing in [\(6.3\)](#page-22-3) is related to the time for which the growth of Theorem [4.2](#page-14-1) is achieved. Its estimate  $(6.2)$  is a consequance of  $(4.10)$  (which in turn follows from  $(4.8)$ ) and Remark [4.5.](#page-15-5)

*Proof of Theorem [6.1.](#page-22-1)* Let  $m \ge m_0 > s + s_0 + \frac{d}{2}$ , where  $s \gg 1$  and  $s_0 > 0$  is the exponent for which Theorem [3.7](#page-8-1) holds true; we will specify the value of  $m_0$  later. Recalling the notations of Theorem [4.2,](#page-14-1) we define  $\nu(m) := 2\ell + 1/m$ , and we denote  $\lambda_1 := \min(\lambda^*(m), \lambda^*(m+1)).$ 

We consider the lattice  $(2.3)$ , and we consider an initial datum of the form

Moreover, we define an interpolating function for the initial datum  $(Q_0, P_0)$  by

By applying [\(3.38\)](#page-12-2) and Lemma [5.1,](#page-16-0) the initial datum  $(\hat{Q}_{0,k}, \hat{P}_{0,k})_{k \in \mathbb{Z}_N^d}$  of the lattice [\(2.3\)](#page-3-1) corresponds to  $(\hat{q}_{0,J}, \hat{p}_{0,J})_{J \in \mathbb{Z}^d} \in \mathcal{W}^{s+s_0} \cap (\ell_{m+1}^2 \times \ell_{m+1}^2)$ , which, by the change of variable introduced in Remark [3.3,](#page-7-1) takes the form of an initial datum in the Fourier space  $(\tilde{\zeta}_{a,0,L})_{L\in\mathbb{Z}^d} \in \mathcal{W}^{s+s_0} \cap (\ell^2_{m+1} \times \ell^2_{m+1}).$ 

Remark 6.5. Due to the specific form of the initial datum and to the change of variable introduced in Remark [3.3,](#page-7-1) we have that

namely, the solution is normalized, in the language of [\[Kuk97\]](#page-40-15).

By Remark [4.3,](#page-15-1) Theorem [4.2](#page-14-1) and Proposition [4.1](#page-14-3) we have that for all positive  $\lambda < \lambda_1$ , if the dispersion is sufficiently small, namely

$$
\mu \leq \mu_{0,m} := \left[K^{-2/\lambda} \left(\sum_{L \in \mathbb{Z}^d} |L|^{2m} \tilde{\xi}_{a,0,L} \tilde{\eta}_{a,0,L}\right)^{-(1-2\ell\lambda)/\lambda}\right]^{\frac{1}{4(1-\ell\alpha)}},
$$

there exists a (large)  $T_m^* > 0$  satisfying

$$
T_m^* \le C_1 K^{-\nu(m)} m \mu^{-2\ell\alpha - 2\nu(m)\lambda(1-\ell\alpha)} \left(\sum_{L\in\mathbb{Z}^d} |L|^{2m} \tilde{\xi}_{a,0,L} \tilde{\eta}_{a,0,L}\right)^{-\ell(1-\nu(m)\lambda)}
$$

,

such that we have the growth

<span id="page-23-0"></span>(6.5) 
$$
\sum_{L \in \mathbb{Z}^d} |L|^{2m} \widetilde{\xi}_{a,L}(T_m^*) \widetilde{\eta}_{a,L}(T_m^*) = c \mu^{-2(1-\ell\alpha) \frac{2\lambda}{1-2\ell\lambda}},
$$

where  $c = c(\ell, \lambda) := K^{-\frac{2}{1-2\ell\lambda}} > 0$ . Moreover, we can assume that  $T_m^*$  is the *minimal* time at which the growth  $(6.5)$  is attained. Notice that  $(6.5)$  implies

$$
\sum_{L\in\mathbb{Z}^d} |L|^{2(m+1)} \widetilde{\xi}_{a,L}(T_m^*) \widetilde{\eta}_{a,L}(T_m^*) \geq c \,\mu^{-2(1-\ell\alpha)\frac{2\lambda}{1-2\ell\lambda}}.
$$

Similarly, for all positive  $\lambda < \lambda_1$ , if the smallness condition

<span id="page-23-2"></span>(6.6) 
$$
\mu \leq \mu_{0,m+1} := \left[K^{-\frac{2}{\lambda}} \left( \sum_{L \in \mathbb{Z}^d} |L|^{2(m+1)} \tilde{\xi}_{a,0,L} \tilde{\eta}_{a,0,L} \right)^{-\frac{1-2\ell\lambda}{\lambda}} \right]^{\frac{1}{4(1-\ell\alpha)}}
$$

,

holds true, then there exists a positive (large)  $T_{m+1}^* \leq T_m^*$  satisfying

$$
T_{m+1}^{*} \leq C_{1} K^{-\nu(m+1)} (m+1) \mu^{-2\ell\alpha - 2\nu(m+1)\lambda(1-\ell\alpha)} \times \left( \sum_{L \in \mathbb{Z}^{d}} |L|^{2(m+1)} \tilde{\xi}_{a,0,L} \tilde{\eta}_{a,0,L} \right)^{-\ell(1-\nu(m+1)\lambda)}
$$

such that we have the growth

(6.7) 
$$
\sum_{L\in\mathbb{Z}^d} |L|^{2(m+1)} \tilde{\xi}_{a,L}(T^*_{m+1}) \tilde{\eta}_{a,L}(T^*_{m+1}) = c \mu^{-2(1-\ell\alpha)\frac{2\lambda}{1-2\ell\lambda}}.
$$

We now denote

$$
\mu_0^* := \mu_0^*(m) = \min(\mu_{0,m}, \mu_{0,m+1}),
$$

where  $\mu_{0,m}$  and  $\mu_{0,m+1}$  are defined in [\(6.4\)](#page-23-1) and [\(6.6\)](#page-23-2), respectively.

Hence, for all positive  $\mu < \mu_0^*$  and  $\lambda < \lambda_1$ , there exists  $T_m \in [T^*_{m+1}, T^*_m]$  such that the following property holds true: there exists  $\vartheta:=\vartheta(m+1,T_m)\geq 1$  such that

<span id="page-24-2"></span>(6.8) 
$$
\sum_{L\in\mathbb{Z}^d} |L|^{2m} \, \widetilde{\xi}_{a,L}(T_m) \, \widetilde{\eta}_{a,L}(T_m) \geq \frac{3}{4} \, c \, \mu^{-2(1-\ell\alpha) \frac{2\lambda}{1-2\ell\lambda}},
$$

<span id="page-24-1"></span>(6.9) 
$$
\sum_{L\in\mathbb{Z}^d} |L|^{2(m+1)} \tilde{\xi}_{a,L}(T_m) \tilde{\eta}_{a,L}(T_m) = \vartheta c \mu^{-2(1-\ell\alpha)\frac{2\lambda}{1-2\ell\lambda}}.
$$

We now exploit that for all  $M > 0$  and for all  $\sigma > 0$ 

<span id="page-24-0"></span>(6.10) 
$$
\|\mathrm{id} - \Pi_M\|_{\ell^2_{m+\sigma} \times \ell^2_{m+\sigma} \to \ell^2_m \times \ell^2_m} \le (M+1)^{-\sigma}
$$

(see Lemma 3.4 in [\[GP21\]](#page-40-13)).

If we fix  $\delta \in (0,1)$  and we apply  $(6.10)$  to  $(6.9)$  with  $M = \mu^{-(1-\delta)} - 1$  and  $\sigma = 1$ , we obtain

<span id="page-24-3"></span>(6.11) 
$$
\sum_{L \in \mathbb{Z}^d : |L| > \mu^{-(1-\delta)}} |L|^{2m} \widetilde{\xi}_{a,L}(T_m) \widetilde{\eta}_{a,L}(T_m) \leq \mu^{2(1-\delta)} \vartheta c \mu^{-2(1-\ell\alpha)\frac{2\lambda}{1-2\ell\lambda}},
$$

so that by  $(6.8)$  and by  $(6.11)$  we get

<span id="page-24-4"></span>
$$
(6.12) \qquad \sum_{L\in\mathbb{Z}^d:\,|L|\leq\mu^{-(1-\delta)}}|L|^{2m}\,\widetilde{\xi}_{a,L}(T_m)\,\widetilde{\eta}_{a,L}(T_m)\geq\left(\frac{3}{4}-\mu^{2(1-\delta)}\,\vartheta\right)\,c\,\mu^{-2(1-\ell\alpha)\frac{2\lambda}{1-2\ell\lambda}}.
$$

Therefore, there exists  $\mu_0^* := \mu_0^*(m) < \mu_0^*$  such that for all positive  $\mu < \mu_0^*$  satisfying

$$
\mu^{2(1-\delta)} \le \frac{1}{4\,\vartheta}
$$

we have

<span id="page-24-5"></span>(6.13) 
$$
\frac{3}{4} - \mu^{2(1-\delta)} \vartheta \ge \frac{1}{2}.
$$

Therefore, by [\(6.12\)](#page-24-4) and [\(6.13\)](#page-24-5) we can deduce that there exists  $\mu_0^* := \mu_0^*(m, \delta) \leq \mu_0^*$  such that for all positive  $\mu < \mu_0^*$  and  $\lambda < \lambda_1$ , there exists  $T_m \in [T_{m+1}^*, T_m^*]$  such that the following property holds true,

$$
\sum_{L \in \mathbb{Z}^d : |L| \le \mu^{-(1-\delta)}} |L|^{2m} \tilde{\xi}_{a,L}(T_m) \tilde{\eta}_{a,L}(T_m) \ge \frac{1}{2} c \mu^{-2(1-\ell\alpha) \frac{2\lambda}{1-2\ell\lambda}}.
$$

Then by applying Proposition [5.3,](#page-17-1) we have that if  $\lambda \in (0, \lambda_1)$ , then there exists a positive  $\mu_0$  such that, if  $\mu < \mu_0$ , we have that there exists  $C > 0$ 

$$
\sup_{j} |Q_j(t) - Q_a(t,j)| + |P_j(t) - P_a(t,j)| \leq C \mu^{\alpha + c_1/16}, \ \forall |t| \leq T_m,
$$

where  $(Q_a, P_a)$  are given by considering  $(\tilde{\xi}_{a,0}, \tilde{\eta}_{a,0})$  and applying  $(3.47), (3.44)$  $(3.47), (3.44)$  $(3.47), (3.44)$  and  $(3.38)$ ; moreover, by [\(5.12\)](#page-17-4) we have that

$$
\left|\frac{\mathcal{E}_{\kappa}(t)}{\mu^{2\alpha}}-\frac{\widetilde{\xi}_{a,L}(t)\widetilde{\eta}_{a,L}(t)}{2}\right|\leq C\,\mu^{\delta/8}\,,\ \ \forall |t|\leq T_m,
$$

for  $\kappa = \mu L$  and  $|L| \leq \mu^{-(1-\delta)}$  (recall that  $\kappa \in \mu \mathbb{Z}_N^d$ ). By combining  $(6.14)$  and  $(5.12)$  we have that

$$
\frac{c}{4} \mu^{-2(1-\ell\alpha)\frac{2\lambda}{1-2\ell\lambda}} \leq \sum_{L\in\mathbb{Z}^d:|L|\leq \mu^{-(1-\delta)}} |L|^{2m} \frac{\widetilde{\xi}_{a,L}(T_m)\widetilde{\eta}_{a,L}(T_m)}{2}
$$
\n
$$
= \sum_{L\in\mathbb{Z}^d:|L|\leq \mu^{-(1-\delta)}} |L|^{2m} \left[ \frac{\mathcal{E}_{\mu L}(T_m)}{\mu^{2\alpha}} + \frac{\widetilde{\xi}_{a,L}(T_m)\widetilde{\eta}_{a,L}(T_m)}{2} - \frac{\mathcal{E}_{\mu L}(T_m)}{\mu^{2\alpha}} \right],
$$

hence

<span id="page-25-1"></span>
$$
(6.15) \qquad \frac{c}{4} \mu^{-2(1-\ell\alpha)\frac{2\lambda}{1-2\ell\lambda}} \leq \sum_{L\in\mathbb{Z}^d:\kappa=\mu} \sum_{L,|L|\leq \mu^{-(1-\delta)}} |L|^{2m} \frac{\mathcal{E}_{\kappa}(T_m)}{\mu^{2\alpha}}
$$
\n
$$
(6.16) \qquad \qquad + \qquad \sum_{L\text{ is even}} |L|^{2m} \left[\frac{\tilde{\xi}_{a,L}(T_m)\tilde{\eta}_{a,L}(T_m)}{2} - \frac{\mathcal{E}_{\kappa}(T_m)}{\mu^{2\alpha}}\right].
$$

 $L \in \mathbb{Z}^d: \kappa = \mu L, |L| \leq \mu - (1-\delta)$ 

<span id="page-25-0"></span>Now, by  $(5.11)$  and by  $(5.12)$  we have that  $(6.16)$  is bounded by  $\mathcal{O}(\mu^{\delta/8-(1-\delta)(2m+d)})$ . Hence  $(6.16)$  is of lower order compared to the left-hand side term of [\(6.15\)](#page-25-1) if

$$
\left(\frac{1}{8} + 2m + d\right)\delta - (2m + d) > -2(1 - \ell\alpha_1)\frac{2\lambda}{1 - 2\ell\lambda};
$$
\n
$$
\delta > \delta_0 = \delta_0(m, d, \ell, \alpha_1, \lambda) := 1 - \frac{1/8}{2m + d + 1/8} \left[1 + (1 - \ell\alpha_1)\frac{2\lambda}{1 - 2\ell\lambda}\right].
$$

Therefore, by taking  $\delta > \delta_0$  and by recalling the asymptotics [\(4.8\)](#page-15-2) (where we choose  $B_0 = B_0(d, \ell, 1)$ ) and [\(4.9\)](#page-15-4) we can deduce that for all  $c \in (0, 1/(2B_0))$  there exists a sufficiently large  $m_0 = m_0(d, \ell, \text{c}, s, s_0)$ such that for all  $m \geq m_0$ 

$$
\left|m^{-1}\frac{\lambda_1}{1-2\ell\lambda_1}-\frac{1}{B_0}\right|<\mathbf{c}.
$$

Hence there exists  $\lambda_0 = \lambda_0(m, d, \ell, \alpha_1) > 0$  such that for any  $\lambda \in (\lambda_0, \lambda_1)$ , for any  $\delta \in (\delta_0, 1)$  and for any  $\alpha \in (\alpha_0, \alpha_1)$  there exists a sufficiently small  $\mu_0 = \mu_0(m, d, \delta, \ell, \alpha, \lambda) > 0$  such that for all positive  $\mu < \mu_0$ , if the initial datum is of the form  $(6.1)$ , then

\sum_{L \in \mathbb{Z}^d : \kappa = \mu L, |L| \leq \mu^{-(1-\delta)}} |L|^{2m} \frac{\mathcal{E}_{\kappa}(T_m)}{\mu^{2\alpha}} \geq \frac{c}{8} \mu^{-2(1-\ell\alpha)\frac{2\lambda}{1-2\ell\lambda}}.
$$

Finally, from  $(6.17)$  we can deduce  $(6.3)$  by observing that

$$
\sum_{L \in \mathbb{Z}^d: \kappa = \mu} \sum_{L, |L| \leq \mu^{-(1-\delta)}} |L|^{2m} \mathcal{E}_{\kappa}(T_m) = \sum_{L \in \mathbb{Z}^d: \kappa = \mu} \sum_{L, |L| \leq \mu^{-(1-\delta)}} \frac{|\kappa|^{2m}}{\mu^{2m}} \mathcal{E}_{\kappa}(T_m)
$$

$$
= \sum_{\kappa \in \mu} \sum_{\mathbb{Z}_N^d: |\kappa| \leq \mu^{\delta}} \mathcal{E}_{\kappa}(T_m) \frac{|\kappa|^{2m}}{\mu^{2m}},
$$

where the last equality holds true because  $|L| \leq \mu^{-(1-\delta)}$ .

**Remark 6.6.** In order to obtain [\(6.3\)](#page-22-3) it is essential to assume both that  $\frac{1}{\ell} - \alpha_1$  is bounded away from zero and that  $\lambda > \lambda_0$ , otherwise we would obtain that  $1 - \delta_0 = \mathcal{O}(1/m)$  as  $m \to \infty$ .

## Appendix A. Proof of Lemma [3.11](#page-10-0)

<span id="page-26-1"></span>This appendix is devoted to the proof of the Lemma [3.11,](#page-10-0) which is a key step to normalize the system  $(3.24)$ . Its proof is an adaptation of the proof of Theorem 4.4 in  $[Bam99]$  together with some results from Sec. III.3 and Sec.IV.1 of [\[Fao12\]](#page-40-17); it is based on the method of Lie transform, briefly recalled in the following. Throughout this Section, we consider  $s \geq s_1$  to be a fixed quantity.

Given  $k_0 \geq 2$  and an auxiliary function  $\chi \in \mathcal{P}_{k_0}$  analytic on  $\mathcal{W}^s$ , we consider the auxiliary differential equation

$$
\dot{\zeta} = X_{\chi}(\zeta)
$$

and denote by  $\Phi_{\chi}^{t}$  its flow at time t.

**Definition A.1.** The map  $\Phi_{\chi} := \Phi_{\chi}^1$  is called the Lie transform generated by  $\chi$ .

Given  $k_1 \geq 2$  and  $\mathsf{G} \in \mathcal{P}_{k_1}$  analytic on  $\mathcal{W}^s$ , let us consider the differential equation

<span id="page-26-2"></span>
$$
\dot{\zeta} = X_{\mathsf{G}}(\zeta),
$$

where by  $X_{\mathsf{G}}$  we denote the vector field of  $\mathsf{G}$ . Now define

$$
\Phi_\chi^* \mathsf{G}(\tilde{\zeta}) := \mathsf{G} \circ \Phi_\chi(\tilde{\zeta}).
$$

By exploiting the fact that  $\Phi_{\chi}$  is a canonical transformation, we have that in the new variable  $\tilde{\zeta}$  defined by  $\zeta = \Phi_{\chi}(\tilde{\zeta})$  equation [\(A.2\)](#page-26-2) is equivalent to

$$
\dot{\tilde{\zeta}} = X_{\Phi_{\tilde{\chi}}^*\mathsf{G}}(\tilde{\zeta}).
$$

Using the relation

$$
\frac{\mathrm{d}}{\mathrm{d}t} \Phi_{\chi}^* \mathsf{G} = \Phi_{\chi}^* \{ \chi, \mathsf{G} \},
$$

and the Poisson bracket formalism  $\{G_1, G_2\}(\zeta) := dG_1(\zeta)[X_{G_2}(\zeta)]$  we formally get

<span id="page-26-3"></span>(A.5) 
$$
\Phi_X^* \mathsf{G} = \sum_{l=0}^{\infty} \mathsf{G}_l, \ \mathsf{G}_0 := \mathsf{G}, \ \mathsf{G}_l := \frac{1}{l} \{ \chi, \mathsf{G}_{l-1} \}, \ l \geq 1.
$$

In order to estimate the vector field of the terms appearing in [\(A.5\)](#page-26-3), we exploit the following results (see also Proposition III.6 in [\[Fao12\]](#page-40-17)). We recall that we defined the norm  $\|\cdot\|$  in [\(3.10\)](#page-7-2).

<span id="page-26-4"></span>**Lemma A.2.** Let  $k_0, k_1 \geq 2$ ,  $R > 0$ , and assume that  $\chi \in \mathcal{P}_{k_0}$ ,  $\mathsf{G} \in \mathcal{P}_{k_1}$  are analytic on  $\mathcal{B}_s(R)$ , as well as their vector fields. Then we have that  $\{\chi, \mathsf{G}\}\in \mathcal{P}_{k_0+k_1-2}$  is analytic on  $\mathcal{B}_s(R)$ , and

<span id="page-26-5"></span>(A.6) 
$$
\|\{\chi, \mathsf{G}\}\| \leq 2k_0 k_1 \|\chi\| \|\mathsf{G}\|,
$$

<span id="page-26-6"></span>
$$
\sup_{\zeta \in \mathcal{B}_s(R)} \|X_{\{\chi, \mathsf{G}\}}(\zeta)\|_{\mathcal{W}^s} \leq 4(k_0 + k_1 - 2)(k_0 + k_1 - 3)^s k_0 k_1 \| \chi \| \| \mathsf{G} \| R \sup_{\zeta \in \mathcal{B}_s(R)} \max_{n=1, ..., k_0 + k_1 - 4} \| \zeta \|_{\mathcal{W}^s}^n.
$$

*Proof.* First we prove the thesis assuming that  $\chi$  and G are homogeneous polynomials of degrees  $k_0$  and  $k_1$  respectively, with coefficients  $a_j$ ,  $j \in \mathcal{I}_{k_0}$ , and  $b_h$ ,  $h \in \mathcal{I}_{k_1}$ , respectively. Then it follows from definition that  $\{\chi, G\}$  is a monomial of degree  $k_0 + k_1 - 2$  satisfying the zero momentum condition. Moreover, write

$$
\{\chi, {\sf G}\}(\zeta)=\sum_{{\bf j}\in\mathcal{I}_{k_0+k_1-2}}c_{\bf j}\zeta_{\bf j},
$$

where  $c_i$  is a sum of coefficients  $a_r b_s$ , for which there exists  $a \in \mathcal{N}$  and  $\sigma \in {\{\pm 1\}}$  such that

$$
(a,\sigma)\subset \mathbf{r}\in \mathcal{I}_{k_0},\ (a,-\sigma)\subset \mathbf{s}\in \mathcal{I}_{k_1},
$$

and such that if for example  $(a, \sigma) = r_1$  and  $(a, -\sigma) = s_1$ , we necessarily have

$$
(r_2,\ldots,r_{k_0},s_2,\ldots,s_{k_1})=\mathbf{j}.
$$

If  $\chi = \sum_{i=2}^{k_0} \chi_i$  and  $\mathsf{G} = \sum_{j=2}^{k_0} \mathsf{G}_j$ , where  $\chi_i$  and  $\mathsf{G}_j$  are homogeneous polynomials of degree i and j respectively, then we have

$$
\{\chi, \mathsf{G}\} = \sum_{n=2}^{k_0+k_1-2} \sum_{i+j-2=n} \{\chi_i, \mathsf{G}_j\},\
$$

where all the polynomials  $\{\chi_i, \mathsf{G}_j\}$  are homogeneous polynomials of degree  $i + j - 2$ ; hence we can conclude that  $\{\chi, \mathsf{G}\}\in \mathcal{P}_{k_0+k_1-2}$ .

By applying  $(3.14)$  and  $(3.12)$  we can deduce the thesis.

□

**Lemma A.3.** Let  $k_0, k_1 \geq 2$ ,  $R > 0$ , and assume that  $\chi \in \mathcal{P}_{k_0}$  and  $\mathsf{G} \in \mathcal{P}_{k_1}$  are analytic on  $\mathcal{B}_s(R)$ , as well as their vector fields. Let  $l \geq 1$ , and consider  $G_l$  as defined in  $(A.5)$ , then  $G_l \in \mathcal{P}_{l(k_0-2)+k_1}$  is analytic on  $\mathcal{B}_s(R)$  as well as its vector field, and

<span id="page-27-1"></span>(A.8) 
$$
\|G_l\| \le (2e k_0 \|\chi\|)^l k_1 \|G\|,
$$

$$
\sup_{\zeta \in \mathcal{B}_s(R)} \|X_{\mathsf{G}_\ell}(\zeta)\|_{\mathcal{W}^s} \le 2 \left( l(k_0 - 2) + k_1 \right)^l \left( l(k_0 - 2) + k_1 - 1 \right)^s (2e \, k_0 \, \|\chi\|)^l \, k_1 \, \|\mathsf{G}\| \, R \times \times \sup_{\zeta \in \mathcal{B}_s(R)} \max_{n=1,\dots,l(k_0-2)+k_1-2} \|\zeta\|_{\mathcal{W}^s}^n.
$$
\n(A.9)

*Proof.* Fix  $l \geq 1$ . We look for a sequence  $C_m^{(l)}$  such that

$$
\|\mathsf{G}_m\| \le C_m^{(l)}, \ \forall m \le l.
$$

Lemma [A.2](#page-26-4) ensures that the following sequence satisfies this property.

$$
C_0^{(l)} := k_1 ||\mathsf{G}||, \ \ C_m^{(l)} = \frac{2l}{m} C_{m-1}^{(l)} k_0 ||\chi||.
$$

One has

$$
C_l^{(l)} = \frac{1}{l!} (2l k_0 ||\chi||)^l k_1 ||\mathsf{G}||,
$$

and by using the inequality  $l^{l} < l! e^{l}$  one obtains the estimate [\(A.8\)](#page-27-1).

<span id="page-27-0"></span>**Lemma A.4.** Assume that  $G \in \mathcal{P}_{k_1}$  is analytic on  $\mathcal{B}_s(R)$  as well as its vector field, and that  $h_0$  satisfies (PER). Then there exists  $\chi \in \mathcal{P}_{k_1}$  analytic on  $\mathcal{B}_s(R)$  and  $\mathsf{Z} \in \mathcal{P}_{k_1}$  analytic on  $\mathcal{B}_s(R)$  with  $\mathsf{Z}$  in normal form, namely  $\{h_0, Z\} = 0$ , such that

$$
\{ \chi, h_0 \} + G = Z.
$$
 (A.10)

Such  $Z$  and  $\chi$  are given explicitly by

<span id="page-27-4"></span>(A.11) 
$$
Z(\zeta) = \frac{1}{T} \int_0^T G(\Phi_{h_0}^t(\zeta)) dt,
$$

<span id="page-27-3"></span>(A.12) 
$$
\chi(\zeta) = \frac{1}{T} \int_0^T t \left[ Z(\Phi_{h_0}^t(\zeta)) - G(\Phi_{h_0}^t(\zeta)) \right] dt.
$$

Furthermore, we have that the vector fields of  $\chi$  and  $\mathsf{Z}$  are analytic on  $\mathcal{B}_s(R)$ , and satisfy

<span id="page-28-0"></span>
$$
||Z|| \le ||G||, \sup_{\zeta \in \mathcal{B}_s(R)} ||X_Z(\zeta)||_{\mathcal{W}^s} \le \sup_{\zeta \in \mathcal{B}_s(R)} ||X_G(\zeta)||_{\mathcal{W}^s},
$$
  
(A.13)  

$$
||\chi|| \le 2T ||G||, \sup_{\zeta \in \mathcal{B}_s(R)} ||X_x(\zeta)||_{\mathcal{W}^s} \le 2T \sup_{\zeta \in \mathcal{B}_s(R)} ||X_G(\zeta)||_{\mathcal{W}^s}.
$$

*Proof.* We check directly that the solution of  $(A.10)$  is  $(A.12)$ . Indeed,

$$
\begin{split}\n\{\chi, h_{0}\}(\zeta) &= \frac{d}{ds}\Big|_{s=0} \chi(\Phi_{h_{0}}^{s}(\zeta)) \\
&= \frac{1}{T} \int_{0}^{T} t \frac{d}{ds}\Big|_{s=0} \left[\mathbf{Z}(\Phi_{h_{0}}^{t+s}(\zeta)) - \mathbf{G}(\Phi_{h_{0}}^{t+s}(\zeta))\right] dt \\
&= \frac{1}{T} \int_{0}^{T} t \frac{d}{dt} \left[\mathbf{Z}(\Phi_{h_{0}}^{t}(\zeta)) - \mathbf{G}(\Phi_{h_{0}}^{t}(\zeta))\right] dt \\
&= \frac{1}{T} \left[t\mathbf{Z}(\Phi_{h_{0}}^{t}(\zeta)) - t\mathbf{G}(\Phi_{h_{0}}^{t}(\zeta))\right]_{t=0}^{T} - \frac{1}{T} \int_{0}^{T} \left[\mathbf{Z}(\Phi_{h_{0}}^{t}(\zeta)) - \mathbf{G}(\Phi_{h_{0}}^{t}(\zeta))\right] dt \\
&= \mathbf{Z}(\zeta) - \mathbf{G}(\zeta).\n\end{split}
$$

In the last step we used the explicit expression of Z provided in [\(A.11\)](#page-27-4). Finally, the first estimate in  $(A.13)$  follows from the explicit expression of Z in  $(A.11)$  while for the second estimate we write explicitly the vector field  $X_{\chi}$ :

$$
X_{\chi}(\zeta) = \frac{1}{T} \int_0^T t \, D\Phi_{h_0}^{-t}(\Phi_{h_0}^t(\zeta)) \circ X_{Z-G}(\Phi_{h_0}^t(\zeta)) dt.
$$

Hypothesis (PER) guarantees that  $\Phi_{h_0}^t$  as well as its derivatives and the inverses are uniformly bounded as operators from  $\mathcal{W}^s$  into itself. Moreover, for any  $t \in \mathbb{R}$ , the map  $\zeta \mapsto \Phi_{h_0}^t(\zeta)$  is a diffeomorphism of  $\mathcal{B}_s(R)$  into itself. Using the fact that  $\Phi_{h_0}^t$  is an isometry, we have

$$
\sup_{\zeta \in \mathcal{B}_s(R)} \|X_{\chi}(\zeta)\|_{\mathcal{W}^s} \leq T \sup_{\zeta \in \mathcal{B}_s(R)} (\|X_{\mathsf{Z}}(\zeta)\|_{\mathcal{W}^s} + \|X_{\mathsf{G}}(\zeta)\|_{\mathcal{W}^s}) \leq 2T \sup_{\zeta \in \mathcal{B}_s(R)} \|X_{\mathsf{G}}(\zeta)\|_{\mathcal{W}^s}
$$

where in the last step we used the first inequality in  $(A.13)$ .

Now we introduce the following definition regarding Lie derivatives of functions defined on  $\mathcal{W}^s$  (see Definition IV.1-Proposition IV.3 in [\[Fao12\]](#page-40-17)).

<span id="page-28-2"></span>**Definition A.5.** Let  $\mathcal{U}_s \subset \mathcal{W}^s$  open, and let  $H \in C^1(\mathcal{U}_s, \mathbb{C})$  be a Hamiltonian. Now let  $g \in C^{\infty}(\mathcal{W}_s, \mathbb{C})$ , we define the Lie derivative  $\mathcal{L}_{H}[\mathbf{g}]$  in the following way,

Similarly, let  $Y \in C^{\infty}(\mathcal{W}^s, \mathcal{W}^s)$  with  $Y = (Y_j)_{j \in \mathcal{Z}}$ , then we set

(\mathcal{L}_{H}[Y])_j := \{H, Y_j\}, \ \ j \in \mathcal{Z}.
$$

hence the fact that  $X_P(\zeta) \in \mathcal{W}^{s_1}$  for  $\zeta \in \mathcal{W}^{s_1}$  implies that  $\mathcal{L}_P[Y](\zeta) \in \mathcal{W}^{s}$ . The thesis follows by a similar argument on the higher-order derivatives of  $\mathcal{L}_{P}[Y]$ .

Let  $\Phi^t_{\chi}$  be the flow associated to the equation

\zeta_t = X_{\chi}(\zeta), \text{ in } \mathcal{W}^s,

for  $|t| \leq 1$ . Now if  $\zeta(t) \in \mathcal{W}^s$  for all  $s \geq 0$ , we can consider the Taylor expansion around  $t = 0$ .

*Proof.* Here we prove the case  $\mathsf{R}^{(0)} \in \mathcal{P}_{k_1}$ , the case  $\mathsf{R}^{(0)} = 0$  being simpler. The key point of the proof is to look for  $\mathcal{T}_{\delta}^{(0)}$  as the time-one map of the Hamiltonian vector field of an analytic function. Hence, let  $\chi_0 \in \mathcal{P}_2$ , and consider the differential equation

where in the last inequality we used the fact that  $\ell_s^1 \subset \ell_s^2$  (see Proposition III.2 in [\[Fao12\]](#page-40-17)).

In order to estimate  $\mathcal{E}_{\kappa}$  for large values of  $K_j$   $(j = 1, \ldots, d)$ , it is convenient to divide the frequencyspace in different regions and bound the terms supported in each region separately. Indeed, in the multidimensional case the introduction of different regions in the frequency space will help us estimating most of the terms in an efficient way. Let us define

\sum_{\substack{L \in \mathscr{L} \\ |K+L| \neq 0}} (|\hat{p}_{K+L}|^2 + \omega_K^2 |\hat{q}_{K+L}|^2)

\leq \pi^2 \|(\xi, \eta)\|_{\mathcal{W}^s}^2 2 \sum_{\substack{L \in \mathscr{L} \\ |K+L| \neq 0}} |K+L|^{-2s} \left[1 + \mu^2 \sum_{j=1}^d (K_j + L_j)^2\right]
$$
\n
$$
(B.4) \leq 2\pi^2 \|(\xi, \eta)\|_{\mathcal{W}^s}^2 \left[\sum_{\substack{L \in \mathscr{L} \\ |K+L| \neq 0}} |K+L|^{-2s} + \mu^2 \sum_{\substack{L \in \mathscr{L} \\ |K+L| \neq 0}} |K+L|^{-2s} \sum_{j=1}^d (K_j + L_j)^2\right].
$$

$$

+ \sum_{\substack{L = (L_1, ..., L_d) \in \mathscr{L} \\ |K+L| \neq 0 \\ L_1, ..., L_d \neq 0}} |K + L|^{-2s}.

<span id="page-36-0"></span>We now estimate the last sum in [\(B.5\)](#page-36-0); we point out that for  $L_1, \ldots, L_d \neq 0$  we have  $|L| \geq 2d \mu^{-1}$ , hence  $d |K| \leq |L|$ .

Therefore, for any  $s > \frac{d}{2}$  and for  $\kappa = (\mu K_1, \dots, \mu K_d)$  and  $|K_1| + \dots + |K_d| > M$

where for  $d = 2, 3$  the above sum can be bounded by

(Γ is Euler's gamma function), while for  $d = 1$  the above sum can be bounded by

where the above integral is equal to  $\frac{1}{2s-1}|K|$ , and where the sum in the right-hand side of [\(B.7\)](#page-36-1) is bounded by

where the first sum can be bounded as before, while the second sum can be decomposed in the following way,

= 2\pi^{d-1} C_1(s,d) |K|^{-(2s-d-2)},

 $((z, a, b) \mapsto B_z(a, b)$  is the generalized Euler Beta function); for  $d = 1$  the above sum can be bounded by

\sum_{\substack{L=(L_1,\ldots,L_d)\in \mathscr{L}\\ |K+L|\neq 0\\ L_1,\ldots,L_d\neq 0}} L_j^2\, |K+L|^{-2s} + 2|K|^{-2s}\ \int_{2|K|}^{+\infty} R^2\left(\frac{R}{|K|}-1\right)^{-2s}\ \mathrm{d}R \leq C_s\ |K|^{-(2s-3)}.
$$

Similarly, we now estimate the terms

of course the sums vanish for  $d=1,$  while for  $d=2,3$  and for any  $j\in\{1,\ldots,d\}$

which is polinomially small with respect to  $\mu$ .

On the other hand, for  $\kappa = (\mu K_1, \dots, \mu K_d)$  and  $|K_1| + \dots + |K_d| \leq M$  and for any  $s > \frac{d}{2} + 1$  we have

&\leq \mu^{2} \pi^{2} |K|^{2} |\hat{q}_{K}|^{2} + \|(\xi, \eta)\|_{\mathcal{W}^{s}}^{2} \sum_{L=(L_{1},...,L_{d}) \in \mathbb{Z}^{d} \setminus \{0\}} |K+L|^{-2s} (1 + \mu^{2} \pi^{2} |K+L|^{2}) \\
&\leq \pi^{2} \mu^{2\delta} |(\xi, \eta)|_{\mathcal{W}^{0}}^{2} + \|(\xi, \eta)\|_{\mathcal{W}^{s}}^{2} \sum_{L=(L_{1},...,L_{d}) \in \mathbb{Z}^{d} \setminus \{0\}} |K+L|^{-2s} (1 + \mu^{2} \pi^{2} |K+L|^{2}), \\

so that we can deduce the thesis with the constants specified in [\(5.9\)](#page-17-7).
