# AN EIGENVALUE PROBLEM FOR PRESCRIBED CURVATURE EQUATIONS

ABSTRACT. We study an eigenvalue problem for prescribed  $\sigma_k$ -curvature equations of starshaped, k-convex, closed hypersurfaces. We establish the existence of a unique eigenvalue and its associated hypersurface, which is also unique, provided that the given data is even. Moreover, we show that the hypersurface must be strictly convex. A crucial aspect of our proof involves deriving uniform estimates in p for  $L_p$ -type prescribed curvature equations.

#### 1. INTRODUCTION

Let  $\Sigma$  be a smooth, closed hypersurface in  $\mathbb{R}^{n+1}$ . We use  $\nu(X)$  and  $\kappa(X)$  to denote the outward unit normal and principal curvatures of the hypersurface  $\Sigma$  at point X, respectively. This paper concerns the following eigenvalue problem for prescribed curvature equations:

$$\langle X, \nu(X) \rangle^k \sigma_k(\kappa(X)) = \lambda \psi(\nu(X)) \quad \text{for any } X \in \Sigma,$$
 (1.1)

where  $\sigma_k : \mathbb{R}^n \to \mathbb{R}$  represents the elementary symmetric polynomial of degree k and  $\psi$  is a smooth, positive function on  $\mathbb{S}^n$ . The curvature  $\sigma_k(\kappa)$  includes the mean curvature, scalar curvature, and Gauss curvature for cases when k = 1, 2, and n, respectively.

Equation (1.1) is connected to singularity models for an anisotropic flow governed by powers of curvature  $\sigma_k$ , see [4, 12, 13, 24, 31]. Indeed, for  $p \neq 1$ , if X denotes a parametrization of the evolving hypersurfaces  $\Sigma_t$  satisfying

$$\frac{\partial}{\partial t}X = -\operatorname{sign}(1-p)(f(\nu)\sigma_k(\kappa))^{\frac{1}{1-p}}\nu_k$$

then its self-similar solutions fulfill

$$\langle X, \nu(X) \rangle^{p-1} \sigma_k(\kappa(X)) = \lambda / f(\nu(X))$$
(1.2)

for some constant  $\lambda > 0$ . Therefore, (1.1) corresponds to (1.2) with p = k + 1 and the anisotropic function  $f = 1/\psi$ . In particular, for the case of k = 1 and p = 2, equation (1.2) represents a self-similar solution of the (anisotropic) inverse mean curvature flow [10, 12]. Note that (1.2) remains invariant under dilation of the hypersurface if and only if p = k + 1, and the constant  $\lambda$  in (1.2) can be absorbed by scaling when  $p \neq k + 1$ .

In the case of k = n, equation (1.2) becomes the celebrated  $L_p$  Minkowski problem initiated by Lutwak [28], where the admissible solutions are convex. This is a central problem in convex geometry, and there is a vast literature on the  $L_p$  Minkowski problem; see for instance [3, 11, 22, 29, 34] and the references therein. In terms of the support function  $u : \mathbb{S}^n \to \mathbb{R}$

defined by  $u(x) = \langle x, \nu^{-1}(x) \rangle$  for a strictly convex hypersurface  $\Sigma$ , equation (1.2) can be transformed into

$$\det(\nabla^2 u + uI) = \lambda^{-1} u^{p-1} f \quad \text{on } \mathbb{S}^n,$$
(1.3)

where  $\nabla$  denotes the covariant derivative with respect to an orthonormal frame on  $\mathbb{S}^n$  and I is the identity matrix. The existence results for (1.3) can be found in [11] for p > -n - 1 and [22] for p < -n - 1. In particular, Chou and Wang [11] completely resolved the eigenvalue problem in this case (p = n + 1 in (1.3) or k = n in (1.1)) by obtaining a unique pair ( $u, \lambda$ ), where u is the support function of a strictly convex, closed hypersurface that is positive on  $\mathbb{S}^n$ , and  $\lambda > 0$  is the eigenvalue.

On the other hand, when p = 1, equation (1.2) reduces to the well-known prescribed curvature equation. In [14], Guan and Guan demonstrated the existence of a strictly convex, closed hypersurface satisfying (1.2), under the condition that f is even, that is, f(x) = f(-x)for all  $x \in \mathbb{S}^n$ .

We note that an equation analogous to (1.2) arises in the context of curvature measures, which can be expressed as follows:

$$\sigma_k(\kappa(X)) = \frac{\langle X, \nu(X) \rangle}{|X|^{n+1}} f\left(\frac{X}{|X|}\right).$$
(1.4)

Given certain conditions on f, Guan, Lin, and Ma [17] demonstrated the existence of convex solutions to this equation. Moreover, Guan, Li, and Li [15] proved the existence of a unique admissible solution (which is k-convex and star-shaped, see Definition 1.1 below) for a general f. The  $L^p$  dual generalization of this problem, in the measure form of (1.4), has been further investigated in [2, 30].

In this paper we are interested in the eigenvalue problem (1.1) for all  $1 \leq k < n$ , assuming that  $\psi$  is an even function, that is,  $\psi(x) = \psi(-x)$  for all  $x \in \mathbb{S}^n$ . To describe an admissible hypersurface  $\Sigma$  of the eigenvalue problem (1.1), it is necessary to define the notions of a *k*-convex and a star-shaped hypersurface.

**Definition 1.1.** Let  $\Sigma$  be a  $C^2$  regular hypersurface in  $\mathbb{R}^{n+1}$ .

(i) A hypersurface  $\Sigma$  is said to be *k*-convex if its principal curvatures  $\kappa(X) = (\kappa_1(X), \dots, \kappa_n(X))$ lie in  $\Gamma_k$  for all  $X \in \Sigma$ . Here,  $\Gamma_k$  represents the Gårding cone, defined as

$$\Gamma_k = \left\{ \lambda \in \mathbb{R}^n \mid \sigma_i(\lambda) > 0, i = 1, \dots, k \right\}.$$

(ii) A hypersurface  $\Sigma$  is called *star-shaped* if  $\langle X, \nu(X) \rangle > 0$  for all  $X \in \Sigma$ .

We say that a hypersurface  $\Sigma$  is *admissible* if  $\Sigma$  is a k-convex, star-shaped hypersurface. The number  $\lambda$  is referred to as the eigenvalue of (1.1) if there exists an admissible hypersurface  $\Sigma$  that satisfies (1.1) for the given  $\lambda$ . We note that (1.1) is ensured to be elliptic at all admissible hypersurfaces.

We now state the main result of this paper.

**Theorem 1.2.** Let  $1 \leq k < n$ , and let  $\psi$  be a smooth, positive, even function on  $\mathbb{S}^n$ . Then, there exists a unique eigenvalue  $\lambda > 0$  for (1.1). Moreover, the corresponding admissible hypersurface  $\Sigma$  is strictly convex and unique up to dilation.

Remark 1.3. (i) From the uniqueness, it can be deduced that the hypersurface  $\Sigma$  is origin-symmetric.

- (ii) The evenness of  $\psi$  will be used in establishing the existence of an eigenvalue and hypersurface. The uniqueness of the eigenvalue and hypersurface does not require the evenness of  $\psi$ . See the proof of Theorem 1.2 in Section 5.
- (iii) As previously noted, the case when k = n was resolved for general f in [11].

We emphasize that, unlike the Laplace operator which possesses an infinite number of eigenvalues, our problem (1.1) has only one eigenvalue. Furthermore, any origin-symmetric admissible solution to (1.1) must be strictly convex.

The proof of the main theorem relies on a compactness argument by deriving uniform estimates in p for (1.2) with k + 1 . Additionally, in the same range of <math>p, the existence and uniqueness of (1.2) are required, where the existence follows from the work of Guan, Ren, and Wang [20] (see Proposition 2.1 below). We will prove the uniqueness in Proposition 2.2. Combining existence and uniqueness, we summarize the result as follows. Here, f is not necessarily even. An admissible solution to (1.2) is defined in the same manner, imposing conditions that the hypersurface is k-convex and star-shaped.

**Theorem 1.4.** Suppose p > k + 1 with  $1 \le k \le n$ , and let f be a smooth, positive function on  $\mathbb{S}^n$ . Then, there exists a unique admissible solution to (1.2) for any  $\lambda > 0$ . Moreover, the solution must be strictly convex.

We note that the quantity  $\sigma_k(\kappa)$  corresponds to an operator in Hessian quotient equation when expressed as a support function. Indeed, if  $\Sigma$  is strictly convex, then in terms of the support function u of  $\Sigma$ , (1.2) becomes

$$\frac{\det(\nabla^2 u + uI)}{\sigma_{n-k}(\nabla^2 u + uI)} = \frac{fu^{p-1}}{\lambda} \quad \text{on } \mathbb{S}^n,$$
(1.5)

as described in (2.9) below. When k = n, we can see that this equation reduces to the  $L_p$  Minkowski problem (1.3), as mentioned earlier.

Another important equation that includes (1.3) is the equation for the  $L_p$  Christoffel-Minkowski problem, which is formulated as

$$\sigma_k(\nabla^2 u + uI) = \frac{fu^{p-1}}{\lambda} \quad \text{on } \mathbb{S}^n.$$
(1.6)

See Bryan–Ivaki–Scheuer [5], Guan–Lin–Ma [16], Guan–Ma [18], and Guan–Ma–Zhou [19] for the case p = 1; Guan–Xia [21] for  $1 ; Hu–Ma–Shen [23] for <math>p \ge k + 1$ .

When p = k + 1, a key distinction between equations (1.5) and (1.6) is that (1.5) permits cone singularities with the origin as the vertex of the cone for some non-symmetric f (see [12] for instance), whereas (1.6) guarantees that the origin is always located inside  $\Sigma$ , leading to a smooth solution [23].

The fully non-linear equations in the Hessian quotient class have been investigated over a domain in  $\mathbb{R}^n$  by Caffarelli, Nirenberg, and Spruck [6], Krylov [26], Trudinger [35, 36], and Bao, Chen, Guan, and Ji [1]. See also [25] for a crucial application of the Hessian quotient in the convexity estimate of the mean convex mean curvature flow. Recently, Chen and Xu [9] addressed the quotient of mixed Hessians of the form

$$\frac{\sigma_k(\bar{\mu}-\mu_1,\ldots,\bar{\mu}-\mu_n)}{\sigma_l(\bar{\mu}-\mu_1,\ldots,\bar{\mu}-\mu_n)} = \frac{fu^{p-1}}{\lambda} \quad \text{on } \mathbb{S}^n,$$

where  $\mu_1, \ldots, \mu_n$  are the eigenvalues of  $\nabla^2 u + uI$ ,  $\bar{\mu} = \sum_{i=1}^n \mu_i$ ,  $0 \le l < k \le n$ , and  $p \ge k - l + 1$ .

Finally, we conclude the introduction by mentioning the eigenvalue problems associated with the Monge–Ampère equation over a convex domain in  $\mathbb{R}^n$ , which can be found in [27, 33, 37]. These problems may be viewed as the Euclidean counterpart of the eigenvalue problem (1.1) with k = n.

The paper is organized as follows. In Section 2 we collect relevant information, such as properties of  $\sigma_k$ , radial functions for star-shaped hypersurfaces, and support functions in convex geometry. In addition, the proof of Theorem 1.4 is presented. In Section 3, we derive estimates for volume and diameter when p > k + 1. Section 4 dedicated to establishing curvature estimates. Finally, the proof of Theorem 1.2 is provided in Section 5.

## 2. Preliminaries

We refer to [6, 7, 8] for general background on  $\sigma_k(\kappa)$ . Recall that

$$\sigma_k(\kappa) = \sum_{i_1 < i_2 < \dots < i_k} \kappa_{i_1} \cdots \kappa_{i_k}$$

With an abuse of notation, we often denote by  $\sigma_k(A)$  the  $k^{\text{th}}$  elementary symmetric polynomial with respect to the eigenvalues of a symmetric two-tensor A.

The elementary symmetric sum  $\sigma_k$  satisfies the following property, known as the Maclaurin inequality:

$$c_1 \sigma_1 \ge c_2 \sigma_2^{1/2} \ge \dots \ge c_n \sigma_n^{1/n} \tag{2.1}$$

for some dimensional constant  $c_i$ , i = 1, ..., n. It is also well-known that

$$\frac{\partial \sigma_k}{\partial \kappa_i}(\kappa) > 0 \quad \text{for all } \kappa \in \Gamma_k \text{ and } i = 1, \dots, n$$
(2.2)

and

$$\sigma_k(\kappa_1, \dots, \kappa_n) = \frac{\sigma_{n-k}(\kappa_1^{-1}, \dots, \kappa_n^{-1})}{\sigma_n(\kappa_1^{-1}, \dots, \kappa_n^{-1})}.$$
(2.3)

We recall some basic properties of star-shaped hypersurfaces in  $\mathbb{R}^{n+1}$ ; for details, see [32]. For a star-shaped hypersurface, the position vector X can be expressed as  $X = \rho(x)x$  for  $x \in \mathbb{S}^n$  using the radial function  $\rho : \mathbb{S}^n \to \mathbb{R}$ . Then, the induced metric  $g_{ij}$  is given as

$$g_{ij}[\rho] = \rho^2 \delta_{ij} + \nabla_i \rho \nabla_j \rho.$$
(2.4)

The unit outward normal is given by

$$\nu = \frac{\rho x - \nabla \rho}{\sqrt{\rho^2 + |\nabla \rho|^2}},\tag{2.5}$$

and the relation between the radial function  $\rho$  and the support function  $u = \langle X, \nu \rangle$  is

$$u = \frac{\rho^2}{\sqrt{\rho^2 + |\nabla\rho|^2}}.$$
(2.6)

The second fundamental form can be computed as

$$h_{ij}[\rho] = \left(\rho^2 + |\nabla\rho|^2\right)^{-1/2} \left(\rho^2 \delta_{ij} + 2\nabla_i \rho \nabla_j \rho - \rho \nabla_i \nabla_j \rho\right).$$
(2.7)

For a moment, let us consider  $\Sigma$  as a strictly convex, closed hypersurface in  $\mathbb{R}^{n+1}$ . Let  $\nu(x)$  be the unit outer normal vector to  $\Sigma$  at  $x \in \Sigma$ . The Gauss map  $\nu$  is then a diffeomorphism from  $\Sigma$  onto  $\mathbb{S}^n$ . The support function  $u : \mathbb{S}^n \to \mathbb{R}$  of  $\Sigma$  is defined as

$$u(x) = \sup\{\langle x, y \rangle : y \in \Sigma\} = \langle x, \nu^{-1}(x) \rangle, \quad x \in \mathbb{S}^n \subset \mathbb{R}^{n+1}.$$

One can verify that the second fundamental form h is given by the expression

$$h_{ij}[u] = \nabla_i \nabla_j u + u \delta_{ij}.$$

Using this and the Ricci identity, we have

$$\nabla_{l}h_{ij} = \nabla_{l}\nabla_{i}\nabla_{j}u + (\nabla_{l}u)\delta_{ij} = \nabla_{i}\nabla_{l}\nabla_{j}u + \overline{R}_{lijm}\nabla_{m}u + (\nabla_{l}u)\delta_{ij}$$
$$= \nabla_{i}\nabla_{l}\nabla_{j}u + (\delta_{lj}\delta_{im} - \delta_{lm}\delta_{ij})\nabla_{m}u + (\nabla_{l}u)\delta_{ij}$$
$$= \nabla_{i}\nabla_{l}\nabla_{j}u + (\nabla_{i}u)\delta_{lj} = \nabla_{i}h_{lj}$$

and

$$\nabla_k \nabla_l h_{ij} = \nabla_k \nabla_i h_{lj} = \nabla_i \nabla_k h_{lj} + \overline{R}_{kilm} h_{mj} + \overline{R}_{kijm} h_{lm}$$
  
=  $\nabla_i \nabla_j h_{kl} + (\delta_{kl} \delta_{im} - \delta_{km} \delta_{il}) h_{mj} + (\delta_{kj} \delta_{im} - \delta_{km} \delta_{ij}) h_{lm}$   
=  $\nabla_i \nabla_j h_{kl} + \delta_{kl} h_{ij} - h_{kj} \delta_{il} + \delta_{kj} h_{il} - h_{kl} \delta_{ij},$ 

where  $\overline{R}_{ijkl}$  is the Riemannian curvature tensor on the sphere  $\mathbb{S}^n$ . Hence, it follows that

$$\Delta h_{ij} = \nabla_i \nabla_j \operatorname{tr}(h) + nh_{ij} - \operatorname{tr}(h)\delta_{ij}.$$
(2.8)

The eigenvalues of h correspond to the reciprocals of the principal curvatures  $\kappa_i = \kappa_i[u]$  so that

$$\sigma_k(\nabla^2 u + uI) = \sigma_k(\kappa_1[u]^{-1}, \dots, \kappa_n[u]^{-1}).$$

By using (2.3), equation (1.2) can be reformulated as

$$\frac{\det(\nabla^2 u + uI)}{\sigma_{n-k}(\nabla^2 u + uI)} = \frac{fu^{p-1}}{\lambda} \quad \text{on } \mathbb{S}^n.$$
(2.9)

In light of equation (1.3), equation (2.9) migh be referred to as an  $L_p$ -type curvature equation. Since  $\sigma_k^{1/k}$  is concave operator, it is natural to define  $F(A) = (\sigma_n(A)/\sigma_{n-k}(A))^{1/k}$ . We then rewrite (2.9) as

$$F(\nabla^2 u + uI) = (f\lambda^{-1})^{1/k} u^{\frac{p-1}{k}} \quad \text{on } \mathbb{S}^n.$$

We conclude this section by establishing the existence and uniqueness results for (1.2) when k > p + 1. The following two propositions prove Theorem 1.4. As mentioned in the introduction, the existence result is a consequence of Theorem 1.5 in [20].

**Proposition 2.1.** Let p > k + 1, and let f be a smooth positive function on  $\mathbb{S}^n$ . Then there exists a strictly convex hypersurface  $\Sigma$  satisfying (1.2).

*Proof.* It suffices to show the following (i) barrier condition and (ii) convexity property in [20]: (i) there is a constant r > 1 such that

$$\tilde{f}\left(X, \frac{X}{|X|}\right) \le \frac{\sigma_k(1, 1, \dots, 1)}{r^k} \quad \text{for } |X| = r,$$

where  $\tilde{f}(X,\nu) = \frac{\lambda\psi(\nu)}{\langle X,\nu\rangle^{p-1}}$ ; (ii)  $\tilde{f}^{-1/k}(X,\nu)$  is locally convex in X for any fixed  $\nu \in \mathbb{S}^n$ .

The former holds since  $\tilde{f}(X, X/|X|) = \lambda \psi(\nu) r^{1-p}$  and 1-p < -k, and the latter follows from  $\tilde{f}^{-1/k}(X, \nu) = (\lambda \psi(\nu))^{-1/k} \langle X, \nu \rangle^{\frac{p-1}{k}}$  and  $\frac{p-1}{k} > 1$ .

**Proposition 2.2.** Suppose p > k + 1. If  $\Sigma_1$  and  $\Sigma_2$  are two admissible solutions of (1.2), then  $\Sigma_1 = \Sigma_2$ .

*Proof.* Let  $\rho_i$ ,  $u_i$ , and  $\nu_i$  (i = 1, 2) be the radial function, support function, and outward unit normal of  $\Sigma_i$ , respectively. Note that  $\rho_1$  and  $\rho_2$  are positive functions. Suppose that  $v = \log(\rho_1/\rho_2)$  attains its maximum at  $x_0 \in \mathbb{S}^n$ . Then, at  $x_0$ , we have

$$0 = \nabla_j v = \frac{\nabla_j \rho_1}{\rho_1} - \frac{\nabla_j \rho_2}{\rho_2},$$
  

$$0 \ge \nabla_i \nabla_j v = \frac{\nabla_i \nabla_j \rho_1}{\rho_1} - \frac{\nabla_i \rho_1 \nabla_j \rho_1}{\rho_1^2} - \frac{\nabla_i \nabla_j \rho_2}{\rho_2} + \frac{\nabla_i \rho_2 \nabla_j \rho_2}{\rho_2^2}$$
  

$$= \frac{\nabla_i \nabla_j \rho_1}{\rho_1} - \frac{\nabla_i \nabla_j \rho_2}{\rho_2}.$$

Then it follows from (2.4) and (2.7) that

$$\frac{g_{ij}[\rho_1]}{\rho_1^2} = \delta_{ij} + \frac{\nabla_i \rho_1 \nabla_j \rho_1}{\rho_1^2} = \delta_{ij} + \frac{\nabla_i \rho_2 \nabla_j \rho_2}{\rho_2^2} = \frac{g_{ij}[\rho_2]}{\rho_2^2}$$
(2.10)

$$\frac{h_{ij}[\rho_1]}{\rho_1} = \left(1 + |\nabla\rho_1|^2 / \rho_1^2\right)^{-1/2} \left(\delta_{ij} + 2\frac{\nabla_i \rho_1 \nabla_j \rho_1}{\rho_1^2} - \frac{\nabla_i \nabla_j \rho_1}{\rho_1}\right) \ge \frac{h_{ij}[\rho_2]}{\rho_2}.$$
(2.11)

Similarly, by utilizing homogeneity, we can obtain from (2.5) and (2.6) that

$$\nu_1 = \nu_2$$
 and  $\frac{u_1}{\rho_1} = \frac{u_2}{\rho_2}$ . (2.12)

Since the principal curvatures are the eigenvalue of  $h_{ij}$  with respect to  $g_{ij}$ , it follows from (2.10) and (2.11) that

$$\rho_1 \kappa_i[\rho_1] \ge \rho_2 \kappa_i[\rho_2] \quad \text{for all } i = 1, 2, \dots, n.$$

Therefore, we obtain

$$\rho_1^k \sigma_k(\kappa[\rho_1]) \ge \rho_2^k \sigma_k(\kappa[\rho_2]).$$

Using (1.2) and (2.12), we get

$$\lambda u_1^{1-p} = f(\nu_1)\sigma_k(\kappa[\rho_1]) \ge f(\nu_2) \left(\frac{\rho_2}{\rho_1}\right)^k \sigma_k(\kappa[\rho_2]) = \lambda \left(\frac{u_2}{u_1}\right)^k u_2^{1-p}.$$

This implies that  $\rho_1^{k+1-p} \ge \rho_2^{k+1-p}$ . Since p > k+1, we have  $\rho_1 \le \rho_2$  at  $x_0$ . Consequently,  $\max_{\mathbb{S}^n} v \le 1$ . Similarly, we obtain  $\min_{\mathbb{S}^n} v \ge 1$ , which proves that  $v \equiv 1$  and, therefore,  $\rho_1 \equiv \rho_2$ .

## 3. Volume and diameter estimates for p > k + 1

In this section, we provide estimates for volume and diameter, which will be used to extract a sequence after suitable scaling in a subsequent section. According to Theorem 1.4, there exists a unique, strictly convex solution  $u = u_p$  to (1.2) with  $\lambda = 1$  after appropriate dilation, provided p > k + 1.

**Lemma 3.1.** Assume p > k + 1. If u is the solution to equation (1.2) with  $\lambda = 1$ , then for the volume  $V(\Sigma)$  of the region bounded by the associated hypersurface  $\Sigma$ , it holds that

$$\frac{1}{\max_{\mathbb{S}^n} f} \le \left(\frac{V(\Sigma)}{V(B_1)}\right)^{\frac{p-k-1}{n+1}} \le \frac{1}{\min_{\mathbb{S}^n} f}.$$
(3.1)

*Proof.* Let  $\rho$  be the radius of the ball centered at the origin such that  $V(B_{\rho}) = V(\Sigma)$ . We first observe

$$\min_{\mathbb{S}^n} u \le \rho \le \max_{\mathbb{S}^n} u.$$

If u achieves its minimum at  $x_0 \in \mathbb{S}^n$ , then  $\nabla^2 u(x_0) \ge 0$  and consequently,  $h_{ij} = \nabla_i \nabla_j u + u\delta_{ij} \ge u\delta_{ij}$  at  $x_0$ . Since the eigenvalues of  $h_{ij}$  are the principal radii, we deduce  $\kappa_i \le u^{-1}$  and  $\sigma_k(\kappa) \le u^{-k}$  at the point  $x_0$ . It follows from (1.2) that

$$\frac{1}{f(x_0)} = u(x_0)^{p-1} \sigma_k(\kappa)(x_0) \le u(x_0)^{p-k-1} \le \rho^{p-k-1},$$

and hence, the first inequality in (3.1) is derived from

$$V(\Sigma) = V(B_{\rho}) = \rho^{n+1}V(B_1).$$

The second inequality in (3.1) can be obtained through similar arguments, by considering the maximum point of u rather than the minimum point.

The next lemma is valid for a more extensive range of p; however, the range p > k + 1 suffices for proving the main theorem.

**Lemma 3.2.** Let p > 1 - k/n > 0. If u is the solution to (1.2) with  $\lambda = 1$  and  $\Sigma$  is the associated hypersurface, then there exists a constant C that depends only on n, k, p, and  $\min_{\mathbb{S}^n} f$  such that

$$\max_{\mathbb{S}^n} u \le C \left[ V(\Sigma) \right]^{\frac{1}{p_*}},\tag{3.2}$$

where  $p_* = 1 + \frac{(p-1)n}{k} > 0$ . Here, the constant C is finite for all p > 1 - k/n and increases in p

*Remark* 3.3. Due to the monotone increasing property of the constant in equation (3.2), it uniformly holds for  $p \in (k + 1, k + 1 + \epsilon)$ , where  $\epsilon > 0$  is any number.

*Proof.* Suppose that u attains its maximum at  $x_0 \in \mathbb{S}^n$ . Due to the convexity of  $\Sigma$ , the hypersurface  $\Sigma$  encloses the line segment joining  $u(x_0)x_0$  and the origin. Thus we have

$$u(x) \ge \max\{\langle u(x_0)x_0, x\rangle, 0\} = u(x_0)\max\{\langle x_0, x\rangle, 0\}.$$
(3.3)

Applying the Maclaurin inequality (2.1), we deduce that  $c_k \sigma_k^{1/k} \ge c_n \sigma_n^{1/n}$ . This leads to

$$\frac{cu}{K} = \frac{cu}{\sigma_n} \ge \frac{u}{\sigma_k^{n/k}} = u^{1 + \frac{(p-1)n}{k}} f^{\frac{n}{k}} = u^{p_*} f^{\frac{n}{k}}$$

for some dimensional constant c > 0. Hence,

$$c(n+1)V(\Sigma) = c \int_{\mathbb{S}^n} \frac{u}{K} \ge \int_{\mathbb{S}^n} u^{p_*} f^{\frac{n}{k}} \ge \left(\min_{\mathbb{S}^n} f\right)^{\frac{n}{k}} \int_{\mathbb{S}^n} u^{p_*}.$$
(3.4)

Observe that  $p_* = 1 + \frac{(p-1)n}{k} = \frac{pn-(n-k)}{k} > 0$ . From (3.3), we derive

$$\int_{\mathbb{S}^n} u^{p_*} \ge u(x_0)^{p_*} \int_{\langle x_0, x \rangle \ge 0} \langle x_0, x \rangle^{p_*}, \qquad (3.5)$$

where the last integral is invariant under  $x_0$  due to symmetry and is a positive constant that decreases in  $p_*$ . The conclusion then follows from (3.4) and (3.5).

The  $C^1$  estimate is derived from the convexity property.

**Lemma 3.4.** Let u be a smooth, strictly convex solution to (1.1). Then

$$|\nabla u| \leq \max_{\mathbb{S}_n} u$$

*Proof.* Since  $|X|^2 = u^2 + |\nabla u|^2$ , we have

$$|\nabla u| \le \sqrt{u^2 + |\nabla u|^2} = |X| \le \max_{\mathbb{S}^n} |X| = \max_{\mathbb{S}^n} u$$

which completes the proof.

4. Uniform positive lower bound of curvature for 0

The purpose of this section is to establish that the sum of the reciprocals of the principal curvatures remains bounded by the same constant for  $k + 1 , where <math>\varepsilon > 0$  is any number.

**Lemma 4.1.** Suppose that p > k + 1, and let u be the solution of the equation (1.2) with  $\lambda = 1$ . Then

$$\sum_{i=1}^{n} \frac{1}{\kappa_i} \le \frac{2n(p-1)}{k} \|u\|_{L^{\infty}}^{\frac{p-1}{k}} \left\|f^{\frac{1}{k}}\right\|_{C^{1,1}}.$$

*Proof.* Observe that

$$W := \sum_{i=1}^{n} \frac{1}{\kappa_i} = \operatorname{tr}(h) = \Delta u + nu.$$

We will apply the maximum principle to W. By recalling equation (2.8) and taking semipositive definite matrix  $F^{ij} = \frac{\partial F}{\partial h_{ij}}$  to both sides of the equation, we obtain

$$F^{ij}\Delta h_{ij} = F^{ij}\nabla_i\nabla_jW + nF^{ij}h_{ij} - W\sum_{i=1}^n F^{ii}.$$
(4.1)

Here and henceforth, we employ the Einstein summation convention, in which repeated upper and lower indices are automatically summed.

Since F is homogeneous of degree one, we obtain

$$F^{ij}h_{ij} = F = u^{\frac{p-1}{k}}f^{\frac{1}{k}}.$$

It is known [35] (see also [18]) that

$$\sum_{i=1}^{n} \frac{\partial}{\partial h_{ii}} \left( \frac{\sigma_n / \binom{n}{n}}{\sigma_{n-k} / \binom{n}{n-k}} \right)^{1/k} \ge n \quad \text{so} \quad \sum_{i=1}^{n} F^{ii} \ge n \left[ \binom{n}{k} \right]^{-1/k} \ge 1$$

By taking the second derivatives to equation (1.2) and utilizing the concavity of F, we obtain the inequality:

$$\Delta(u^{\frac{p-1}{k}}f^{\frac{1}{k}}) = \Delta F = F^{ij,lm}\nabla_q h_{ij}\nabla^q h_{lm} + F^{ij}\Delta h_{ij} \le F^{ij}\Delta h_{ij}.$$
(4.2)

As p > k + 1, we have  $a := \frac{p-1}{k} > 1$ . Note that  $\Delta u = W - nu \ge -nu$ . Since  $\Delta u^a = cu^{a-1} \Delta u = c(a-1)u^{a-2}|\nabla u|^2 \ge cu^{a-1} \Delta u = -ncu^a$ 

$$\Delta u^a = au^{a-1}\Delta u + a(a-1)u^{a-2}|\nabla u|^2 \ge au^{a-1}\Delta u = -nau^a$$

we obtain through direct computation

$$\Delta(u^a f^{\frac{1}{k}}) = f^{\frac{1}{k}} \Delta u^a + 2\nabla u^a \nabla f^{\frac{1}{k}} + u^a \Delta f^{\frac{1}{k}}$$
$$\geq -2au^{a-1} |\nabla u| |\nabla f^{\frac{1}{k}}| + u^a (\Delta f^{\frac{1}{k}} - naf^{\frac{1}{k}}).$$

Hence, combining with (4.2), we have

$$F^{ij}\Delta h_{ij} \ge -2au^{a-1}|\nabla u||\nabla f^{\frac{1}{k}}| + u^a(\Delta f^{\frac{1}{k}} - naf^{\frac{1}{k}}).$$

Thus, (4.1) can be rewritten as

$$F^{ij} \nabla_i \nabla_j W = F^{ij} \Delta h_{ij} - n F^{ij} h_{ij} + W \sum_{i=1}^n F^{ii} \\ \ge -2au^{a-1} |\nabla u| |\nabla f^{\frac{1}{k}}| + u^a (\Delta f^{\frac{1}{k}} - n(a+1)f^{\frac{1}{k}}) + W.$$

Using Lemma 3.4, we deduce at the maximum point of W,

$$W \le 2au^{a-1} |\nabla u| |\nabla f^{\frac{1}{k}}| - u^a (\Delta f^{\frac{1}{k}} - n(a+1)f^{\frac{1}{k}}) \le 2na ||u||_{L^{\infty}}^a ||f^{\frac{1}{k}}||_{C^{1,1}},$$

which completes our proof.

## 5. Proof of Theorem 1.2

We first prove the existence of a strictly convex solution to (1.1). Suppose 0 < p-k-1 < 1, and let  $u_p$  be the unique positive solution to (1.2) with  $\lambda = 1$ . This is possible due to Theorem 1.4. Let  $\Sigma_p$  be the associated hypersurface whose support function is  $u_p$ . By the uniqueness of  $u_p$  and the evenness of  $\psi$ , we see that  $\Sigma_p$  is origin-symmetric.

Recalling  $p_*$  in Lemma 3.2, we see that

$$\frac{1}{p_*} - \frac{1}{n+1} = \frac{k}{np-n+k} - \frac{1}{n+1} = \frac{n(k+1-p)}{(np-n+k)(n+1)}.$$

By Lemma 3.1 and Lemma 3.2, we have

$$u_p \le C \left[ V(\Sigma_p) \right]^{\frac{1}{p_*}} = C \left[ V(\Sigma_p) \right]^{\frac{1}{n+1}} \left[ V(\Sigma_p)^{\frac{p-k-1}{n+1}} \right]^{-\frac{n}{(np-n+k)}} \le C \left[ V(\Sigma_p) \right]^{\frac{1}{n+1}}.$$
 (5.1)

Here we may assume the constant C is uniform in p since we restrict the upper bound of p.

Define the volume normalized solution as

$$\tilde{u}_p = \frac{u_p}{[V(\Sigma_p)]^{\frac{1}{n+1}}}$$

and denote by  $\Sigma_p$  the associated hypersurface of  $\tilde{u}_p$ . Then  $\tilde{u}_p$  solves

$$\frac{1}{\sigma_k(\kappa)} = [V(\Sigma_p)]^{\frac{p-k-1}{n+1}} u^{p-1} f =: \frac{u^{p-1} f}{\lambda_p} \quad \text{on } \mathbb{S}^n.$$
(5.2)

Moreover, it follows from the definition of  $\tilde{u}_p$ , (5.1), and Lemma 3.1 that

$$V(\tilde{\Sigma}_p) = 1, \quad 0 < \tilde{u}_p \le C, \quad \text{and} \quad 1/C \le \lambda_p \le C.$$
 (5.3)

We can assume that, by considering a subsequence,  $\tilde{u}_p$  and  $\lambda_p$  converge uniformly to a function  $u_0$  and a number  $\lambda_0$ , respectively, as p approaches k + 1 from above. Note that

$$0 \le u_0 \le C$$
 and  $1/C \le \lambda_0 \le C$ .

Furthermore, it follows from the Blaschke selection theorem that  $u_0$  is the support function of some convex hypersurface, say  $\Sigma_0$ . Since  $\Sigma_p$  are origin-symmetric, so is  $\Sigma_0$ . Thus, if  $u_0(x_0) = 0$  at a point  $x_0$ , then we have  $u_0(-x_0) = 0$ , which contradicts to  $V(\Sigma_0) = 1$ . Therefore,  $u_0 > 0$  on  $\mathbb{S}^n$ .

Our purpose is now to show that the pair  $(\Sigma_0, \lambda_0)$  is the desired solution to (1.1), which can be done by using Lemma 4.1. Indeed, let  $\tilde{u}_{p_j}$  be a sequence such that  $\tilde{u}_{p_j} \to u_0$  uniformly. Since  $u_0 > 0$ , we may assume that

$$\tilde{u}_{p_j} \ge \frac{1}{2} \min_{\mathbb{S}^n} u_0 > 0 \quad \text{on } \mathbb{S}^n.$$
(5.4)

Applying Lemma 4.1 to  $u_{p_i}$  and using (5.1), we have

$$\sum_{i=1}^{n} \frac{1}{\tilde{\kappa}_{i}} = \sum_{i=1}^{n} \frac{V(\Sigma_{p})^{-\frac{1}{n+1}}}{\kappa_{i}} \le CV(\Sigma_{p})^{\frac{p-1}{k(n+1)} - \frac{1}{n+1}} = C\lambda_{p}^{-\frac{1}{k}} \le C,$$
(5.5)

where  $\{\tilde{\kappa}_i\}$  are the principal curvatures of  $\tilde{u}_{p_j}$  and the last constant C does not depend on p. Combining (5.2), (5.3), (5.4), and (5.5), we obtain

$$\max_{i} \tilde{\kappa}_{i} \leq \frac{\sigma_{k}(\tilde{\kappa})}{\left(\min_{i} \tilde{\kappa}_{i}\right)^{k-1}} \leq \frac{u^{1-p}}{\lambda_{p} f\left(\min_{i} \tilde{\kappa}_{i}\right)^{k-1}} \leq C.$$

Therefore,  $\tilde{u}_{p_i}$  solves the following uniformly elliptic equation

$$\frac{\det(\nabla^2 u + uI)}{\sigma_{n-k}(\nabla^2 u + uI)} = \frac{u^{p-1}f}{\lambda_p} \quad \text{on } \mathbb{S}^n,$$

and by the standard elliptic theory, we have  $C^{3,\alpha}$  estimates:

$$\left\|\tilde{u}_{p_j}\right\|_{C^{3,\alpha}(\mathbb{S}^n)} \le C.$$

Passing to a subsequence, we finally see that  $u_0$  with  $\lambda_0$  satisfies (1.1).

Lastly, we prove uniqueness. Assume that (1.1) has two distinct k-convex solutions, namely  $(\Sigma_1, \lambda_1)$  and  $(\Sigma_2, \lambda_2)$ . Notice that since (1.1) is scale invariant, any solution multiplied by a constant continues to be a solution. By appropriately scaling  $\Sigma_2$ , we can ensure that  $\Sigma_2$  is enclosed within  $\Sigma_1$  and touches  $\Sigma_1$  at a point  $X_0$ . We then observe that, at the point  $X_0$ ,

$$\frac{\lambda_1 \psi(\nu_{\Sigma_1}(X_0))}{\langle X_0, \nu_{\Sigma_1}(X_0) \rangle^k} = \sigma_k(\kappa[\Sigma_1]) \le \sigma_k(\kappa[\Sigma_2]) = \frac{\lambda_2 \psi(\nu_{\Sigma_2}(X_0))}{\langle X_0, \nu_{\Sigma_2}(X_0) \rangle^k},$$

where we used the monotonicity (2.2) of  $\sigma_k$  with respect to  $\kappa$ . Since  $\nu_{\Sigma_1}(X_0) = \nu_{\Sigma_2}(X_0)$ , we conclude that  $\lambda_1 \leq \lambda_2$ . Changing the role of  $\Sigma_1$  and  $\Sigma_2$ , we also get  $\lambda_2 \leq \lambda_1$ . Therefore,  $\lambda_1 = \lambda_2$ .

Suppose we have two different solutions,  $\Sigma_1$  and  $\Sigma_2$ , of equation (1.1) with the same  $\lambda$ . If  $\Sigma_2$  is not a constant multiple of  $\Sigma_1$ , we can multiply  $\Sigma_2$  by an appropriate constant so that, after rotation if necessary, parts of  $\Sigma_1$  and  $\Sigma_2$  can be represented as graphs of  $U_1$  and  $U_2$ , respectively, over the same domain  $\Omega$  with  $U_1 = U_2$  on  $\partial\Omega$  and  $U_1 > U_2$  in  $\Omega$ .

On the other hand, it is known that  $\sigma_k(\kappa[\Sigma_i]) = G(DU_i, D^2U_i)$  for some elliptic operator if  $\kappa[\Sigma_i] \in \Gamma_k$ , as shown in [7] (see also [8]). Hence, for  $i = 1, 2, U_i$  satisfies

$$G(DU_i, D^2U_i) = \frac{\lambda\psi((DU_i, -1)/\sqrt{1 + |DU_i|^2})}{(x \cdot DU_i(x) - U_i)^k}$$

since  $\nu_{\Sigma_i} = \frac{(DU_i, -1)}{\sqrt{1+|DU_i|^2}}$  and  $X(\Sigma_i) = (x, U_i(x))$ . However, this result contradicts the maximum principle, which completes the proof.
