ROTA-BAXTER OPERATORS ON COCOMMUTATIVE HOPF ALGEBRAS AND HOPF BRACES

Abstract. This paper studies the relationship of Rota-Baxter operators on cocommutative Hopf algebras with Hopf braces and the Yang-Baxter equation, with emphasis on the embedding of cocommutative Hopf braces into Rota-Baxter Hopf algebras. Through Hopf braces, we establish a connection between relative Rota-Baxter operators on cocommutative Hopf algebras and bijective 1-cocycles. Finally, we introduce the notion of symmetric Hopf braces, and establish the relationship between symmetric Hopf braces and Rota-Baxter Hopf algebras.

1. Introduction

Several algebraic structures related to the quantum and classicla Yang-Baxter equations have appeared in recent years.

In 2006, Rump introduced the notion of braces $[26, 27]$ $[26, 27]$ $[26, 27]$ as a generalization of Jacobson radical rings, to study involutive set-theoretical solutions to the Yang-Baxter equation. It also has connections with regular subgroups and left orderable groups [\[3\]](#page-20-1), flat manifolds [\[28\]](#page-21-2), Hopf-Galois extensions $[2]$. In 2014, this notion was reformulated by Cedó, Jespers and Okniński in $[10]$ $[10]$. In 2017, Guarnieri and Vendramin [\[16\]](#page-21-3) defined skew left braces which give non-involutive solutions to the Yang-Baxter equation $[8, 31]$ $[8, 31]$ $[8, 31]$. Here a set *G* with two binary operations \cdot and \circ is called a skew left brace if (G, \cdot) and (G, \circ) are groups and the following identity holds.

a \circ (bc) = (a \circ b)a^{-1}(a \circ c), \quad a, b, c \in G,
$$

where a^{-1} denotes the inverse of *a* in (G, \cdot) .

In 2017, Angiono, Galindo and Vendramin [\[1\]](#page-20-5) introduced Hopf braces and Hopf cobraces. In [\[32\]](#page-21-5), Hopf cobrace is further studied. A Hopf brace is a new algebraic structure related to the Yang-Baxter equation and generalizes Rump's braces.

On the other hand, Rota-Baxter operators on Lie algebras are the operator forms of the classical Yang-Baxter equation, known as the O-operators [\[9,](#page-20-6) [21,](#page-21-6) [29\]](#page-21-7); while Rota-Baxter operators on associative algebras are essential in the renormalization of quantum field theory, made apparent in the framework of Connes and Kreimer [\[13\]](#page-20-7).

With motivation from Factorization Theorem of Semenov-Tian-Shansky for a Lie group that is fundamental in applications to integrable systems $[14, 24, 25]$ $[14, 24, 25]$ $[14, 24, 25]$ $[14, 24, 25]$ $[14, 24, 25]$, the notion of Rota-Baxter groups were recently introduced by Guo, Lang and Sheng in [\[17\]](#page-21-10). A Rota-Baxter group is a group *G* endowed with a map $B: G \to G$ satisfying the identity

B(g)B(h) = B(gB(g)hB(g)^{-1}), \quad g, h \in G.
$$

Subsequently, the study of Rota-Baxter groups has been carried out further in a series of articles [\[5,](#page-20-9) [6,](#page-20-10) [11,](#page-20-11) [12,](#page-20-12) [19\]](#page-21-11). Especially, Bardakov and Gubarev [\[5\]](#page-20-9) proved that every Rota-Baxter group (G, \cdot, B) gives rise to a skew left brace (G, \cdot, \circ_B) , where $x \circ_B y := xB(x)yB(x)^{-1}$ for all $x, y \in G$.
Moreover, they demonstrated that every skew left brace can be embedded into a Rota-Baxter Moreover, they demonstrated that every skew left brace can be embedded into a Rota-Baxter group.

In 2021, Goncharov introduced the notion of a Rota-Baxter operator on a cocommutative Hopf algebra in [\[15\]](#page-21-12). A coalgebra map $B: H \to H$ is called a **Rota-Baxter operator on a cocommu**tative Hopf algebra *H* if

, $x, y \in H$.

It generalizes the Rota-Baxter operators of weight 1 on groups and Lie algebras, in the sense that Rota-Baxter operator of weight 1 on a Lie algebra (resp. on a group) could be uniquely extended to a Rota-Baxter operator on the universal enveloping algebra (resp. on the group algebra). In [\[22\]](#page-21-13), Li, Sheng and Tang generalized this notion to relative Rota-Baxter operators on Hopf algebra and introduced the notion of post-Hopf algebras which generalizes post-Lie algebras and post-groups [\[4\]](#page-20-13). Various interconnections among relative Rota-Baxter Hopf algebras, post-Hopf algebras and Hopf braces have been discovered.

The purpose of present work is to further investigate such connections. The goal is to obtain finer results by specializing to Rota-Baxter operators from relative Rota-Baxter operators. Especially, we address the following embedding question: since a skew brace can be embedded into a Rota-Baxter group [\[5\]](#page-20-9) as noted above, whether a Hopf brace can be embedded into a Rota-Baxter Hopf algebra?

Overall, the paper is organized as follows. In Section [2,](#page-2-0) we give compatibilities of some derived structures from Rota-Baxter operators on cocommutative Hopf algebras, and construct Rota-Baxter operators on cocommutative Hopf algebras via factorizations.

In Section [3,](#page-5-0) we first give a direct connection from Rota-Baxter operators on cocommutative Hopf algebras to cocommutative Hopf braces (Theorem [3.2\)](#page-6-1). Conversely, we show that every cocommutative Hopf brace can be embedded into the induced Hopf brace of a Rota-Baxter Hopf algebra (Theorem [3.7\)](#page-9-0). There is a similar embedding of a cocommutative post-Hopf algebra into a Rota-Baxter Hopf algebra (Corollary [3.11\)](#page-12-0). In addition, we provide new ways to obtain solutions of the Yang-Baxter equation from Rota-Baxter operators on cocommutative Hopf algebras (Proposition [3.13\)](#page-13-1). We finally construct a Hopf brace by a relative Rota-Baxter operator of Hopf algebra and give the connection between relative Rota-Baxter operators on Hopf algebras and bijective 1-cocycles (Proposition [3.19\)](#page-15-1).

In Section [4,](#page-15-0) we introduce the notion of a symmetric Hopf brace and characterize it by identities and H^{op} -module Hopf braces. Here H^{op} denotes the opposite Hopf algebra of a Hopf algebra *H*. Examples of symmetric Hopf braces are provided by Hopf algebras that allows factorizations, and their relationship with Rota-Baxter Hopf algebras is given.

We summarize the relations among the various structures in the following diagram.

Notations. Throughout the paper, let k be a fixed field. Unless otherwise specified, linearity, modules and tensor products are all taken over k. For brevity, we write a comultiplication ∆(*c*) as $c_{(1)} \otimes c_{(2)}$ without the summation sign. All Hopf algebras in this paper are cocommutative.

2. Rota-Baxter operators on cocommutative Hopf algebra and their constructions

In this section, we give some results of Rota-Baxter operators on cocommutative Hopf algebras and use factorizations of Hopf algebras to construct Rota-Baxter operators on Hopf algebras.

2.1. Compatibility of derived Rota-Baxter Hopf algebras.

We first recall two fundamental processes with which a Rota-Baxter operator on a cocommutative Hopf algebra can derive another Rota-Baxter operator.

Lemma 2.1. [\[15\]](#page-21-12) Let *B* be a Rota-Baxter operator on a cocommutative Hopf algebra *H*.

- (a) If $\varphi : H \to H$ is a bialgebra automorphism, then $B^{(\varphi)} := \varphi \circ B \circ \varphi^{-1}$ is also a Rota-Baxter operator of *H* operator of *H*.
- (b) Define $\widetilde{B}: H \to H$ by

Then *B* is also a Rota-Baxter operator on *H*.

Note that every bialgebra homomorphism from a Hopf algebra to another Hopf algebra is actually a Hopf algebra homomorphism. Thus, every bialgebra automorphism from a Hopf algebra to another Hopf algebra is already a Hopf algebra automorphism.

We now show the commutativity of the above two processes of deriving Rota-Baxter operators from a given one.

Lemma 2.2. Let *H* be a cocommutative Hopf algebra, φ a bialgebra automorphism of *H*, and *B* a Rota-Baxter operator on *H*. Then $(\widetilde{B})^{(\varphi)} = B^{(\varphi)}$.

Proof. For all $g \in H$, we have

A new Rota-Baxter Hopf algebra can be induced from a Rota-Baxter cocommutative Hopf algebra via the following procedure which, when repeated, induces a sequence of Rota-Baxter Hopf algebras.

Let (H, B) and (H', B') be Rota-Baxter Hopf algebras. A **homomorphism** $g : (H, B) \to (H', B')$
a Hopf algebra homomorphism such that $g \circ B = B' \circ g$. It is obvious that Rota-Baxter Hopf is a Hopf algebra homomorphism such that $g \circ B = B' \circ g$. It is obvious that Rota-Baxter Hopf algebras and homomorphisms among them form a category, which is denoted by rbHA.

Lemma 2.3. [\[15\]](#page-21-12) Let (*H*, *^B*) be a Rota-Baxter cocommutative Hopf algebra.

Then $H_B := (H, \circ_B, \Delta, T)$ is a cocommutative Hopf algebra, called the **descendent Hopf**
algebra of *H*

(b) Let (*H*, *^B*) be a Rota-Baxter cocommutative Hopf algebra. Then, for *^T* defined in Eq. [\(3\)](#page-3-0), we have

- (c) The operator *B* is also a Rota-Baxter operator on the cocommutative Hopf algebra *HB*.
- (d) The map $B: H_B \to H$ is a homomorphism of Rota-Baxter Hopf algebras.

We next show that the derived Rota-Baxter operators from *B* in Lemma [2.2](#page-2-2) have isomorphic descendent Hopf algebras. We next show that the descendent Hopf algebras induced by *B*, *B* and $B^{(\varphi)}$ are isomorphic.

Lemma 2.4. Let (H, B) be a Rota-Baxter cocommutative Hopf algebra and $\varphi : H \to H$ be a bialgebra automorphism. Then, $H_B \cong H_{\overline{B}} \cong H_{B^{(\varphi)}}$ as Hopf algebras.

Proof. Lemma [2.1](#page-2-3) shows that \overline{B} and $B^{(\varphi)}$ are Rota-Baxter operators on *H*. So, by Lemma [2.3,](#page-3-1) $H_{\overline{B}}$ and $H_{B}(\varphi)$ are Hopf algebras.

Note that the antipode *S* : *H* → *H* is bijective since $S^2 = id$. Moreover, for all *g*, $h \in H$,

S(g \circ_B h) = S(g_{(1)}B(g_{(2)})hS(B(g_{(3)})))
$$

= $B(g_{(1)})S(h)S(B(g_{(2)}))S(g_{(3)})$

= $S(g) \circ_{\widetilde{B}} S(h)$.

So *S* : $H_B \rightarrow H_{\widetilde{B}}$ is an algebra homomorphism.

Since *H* is cocommutative, *S* is a coalgebra map. Then $S : H_B \to H_{\overline{B}}$ is also a bialgebra map. Hence *S* is an isomorphism from the Hopf algebra H_B to the Hopf algebra $H_{\overline{B}}$.

Similarly,

Hence φ is an isomorphism from the Hopf algebra H_B to the Hopf algebra $H_{B(\varphi)}$.

2.2. Rota-Baxter operators from factorizations of cocommutative Hopf algebras.

A common construction of Rota-Baxter operators on associative algebras and Lie algebras is by linear factorizations of these algebras. Such constructions extend to the level of Rota-Baxter operators on groups [\[17\]](#page-21-10). We now construct Rota-Baxter operators on cocommutative Hopf algebras via factorizations of Hopf algebras.

Theorem 2.5. *Let G be a cocommutative Hopf algebra with a factorization G* = *HLM into Hopf subalgebras H*, *L and M, such that HLM is isomorphic to H* [⊗] *^L* [⊗] *M as vector space. Let C be a* Rota-Baxter operator on L, and $\ell h = h\ell$, $mC(\ell) = C(\ell)m$, for all $h \in H, \ell \in L, m \in M$. Define a *linear operator B on G by*

$$

- (a) *B is a Rota-Baxter operator on G.*
- (b) Let \circ_B *be the product defined in Eq.* [\(3\)](#page-3-0) *and L_C* = (*L*, \circ_C) *be the descendent Hopf algebra of the Rota-Baxter Hopf algebra* (*L*, *C*). Then $G_B \cong H \otimes L_C \otimes M^{\text{op}}$ *as Hopf algebras.*

Proof. [\(a\)](#page-4-1) We first check that *B* satisfies the Rota-Baxter equation [\(1\)](#page-1-0). For all $h, h' \in H, \ell, \ell' \in I$

This proves Eq.[\(1\)](#page-1-0). Furthermore, since *C* and *S* are coalgebra homomorphisms, it follows that *B* is also a coalgebra homomorphism. Hence, $B: G \to G$ is a Rota-Baxter operator on *H*. [\(b\)](#page-4-2) Indeed, for all $h, h' \in H, \ell, \ell' \in L, m, m' \in M$, we have

Proposition 2.6. *Let H and K be cocommutative Hopf algebras. Assume that H is a left K-module bialgebra with the module action* \triangleright , and $G = H \# K$ with the smash product
(*h*#k)(*h'*#k') := $h(k_{11} \triangleright h') \# k_{22} k'$, $h, h' \in H, k, k' \in K$

(h\#k)(h'\#k') := h(k_{(1)} \triangleright h')\#k_{(2)}k', \quad h, h' \in H, k, k' \in K.

Let C be a Rota-Baxter operator on K and let K^C be the descendent Hopf algebra.

(a) *The map*

B: G \to G, \quad B(h \# k) = \varepsilon(h)C(k),
$$

is a Rota-Baxter operator.

(b) *We have* $G_B \cong H \# K_C$ *.*

Proof. [\(a\)](#page-5-1) In fact, for any $h, h' \in H, k, k' \in K$, we have

Thus $B(hk)B(h'k') = B((hk)_{(1)}B(hk)_{(2)}h'k'S(B(hk)_{(3)}))$, that is, *B* is a Rota-Baxter operator on *G*.

[\(b\)](#page-5-2) We first show that *H* is a left K_C -module bialgebra with the module action

3. Rota-Baxter operators, Hopf braces, Yang-Baxter equation and 1-cocycles

In this section, we study the relationship of Rota-Baxter operators on cocommutative Hopf algebras with Hopf braces and solutions of the Yang-Baxter equation. We also discuss the relationship between the more general relative Rota-Baxter operators on cocommutative Hopf algebras and Hopf braces. In addition, we establish the connection between relative Rota-Baxter operators on cocommutative Hopf algebras and bijective 1-cocycles.

3.1. Rota-Baxter operators, Hopf braces and Yang-Baxter equation.

Here we show that a Rota-Baxter operator on cocommutative Hopf algebra gives rise to a cocommutative Hopf brace. Conversely, every cocommutative Hopf brace is naturally embedded into to a Rota-Baxter cocommutative Hopf algebra. Further Rota-Baxter operators give solutions of the Yang-Baxter equation.

We first obtain a Hopf brace via a Rota-Baxter operator on a cocommutative Hopf algebra.

Definition 3.1. [\[1\]](#page-20-5) A **Hopf brace** structure over a coalgebra (H, Δ, ε) consists of the following data:

- (a) a Hopf algebra structure $(H, \cdot, 1, \Delta, \varepsilon, S)$ (*H* for short),
- (b) a Hopf algebra structure $(H, \circ, 1_\circ, \Delta, \varepsilon, T)$ (H_\circ for short),
- (c) the compatibility condition

a \circ (bc) = (a_{(1)} \circ b)S(a_{(2)})(a_{(3)} \circ c), a, b, c \in H.
$$

A homomorphism $f : (M, \cdot_M, \circ_M) \to (N, \cdot_N, \circ_N)$ of Hopf braces is a linear map such that $f : M \to N$ and $f : M_{\circ} \to N_{\circ}$ are Hopf algebra homomorphisms (see [\[1\]](#page-20-5)). Let **HB** denote the category of Hopf braces, and let cocHB denote its subcategory of cocommutative Hopf braces.

Theorem 3.2. *Let* (H, \cdot, B) *be a Rota-Baxter cocommutative Hopf algebra, and* $\varphi : H \to H$ *a bialgebra automorphism. Then the following conclusions hold.*

- (a) (H, \cdot, \circ_B) *and* $(H, \cdot^{\text{op}}, \circ_B)$ *are cocommutative Hopf braces.*
(b) $(H, \cdot^{\text{op}}, \circ_B) \cong (H, \circ \circ_C)$ *and* $(H, \circ \circ_B) \cong (H, \circ \circ_C)$ *as Hopf*

from the category of Rota-Baxter Hopf algebras to the category of cocommutative Hopf braces.

Proof. [\(a\)](#page-6-2) By Lemma [2.4,](#page-3-2) (H, \cdot, \circ_B) is a Hopf algebra. For *g*, $h, \ell \in G$, we have

$$
(g_{(1)} \circ_B h)S(g_{(2)})(g_{(3)} \circ_B \ell) = g_{(1)(1)}B(g_{(1)(2)})hS(B(g_{(1)(3)}))S(g_{(2)})g_{(3)(1)}B(g_{(3)(2)})\ell S(B(g_{(3)(3)}))
$$

= $g_{(1)}B(g_{(2)})h\ell S(B(g_{(3)}))$
= $g \circ_B (h\ell).$

Hence (H, \cdot, \circ_B) is a cocommutative Hopf brace.
The assumption that the Hopf algebra $(H \cdot \Lambda)$

The assumption that the Hopf algebra (H, \cdot, Δ, S) is cocommutative implies that $(H, \cdot^{\text{op}}, \Delta, S)$ is ∞ a cocommutative Hopf algebra. Furthermore, for *a* $h, l \in G$, we have also a cocommutative Hopf algebra. Furthermore, for $g, h, l \in G$, we have

Hence (H, \cdot^{op}, \circ_B) is a cocommutative Hopf brace.

[\(b\)](#page-6-3) Since $S(h \cdot {}^{op} g) = S(gh) = S(h)S(g)$, we find that $S : (H, \cdot {}^{op}) \to (H, \cdot)$ is an algebra map. By [\(a\)](#page-6-2) and Lemma [2.4,](#page-3-2) we get $(G, \cdot^{op}, \circ_B) \cong (G, \cdot, \circ_{\overline{B}})$ as Hopf braces.
By (a) we conclude that $(H \cdot \circ_{\overline{B}})$ is a Hopf brace. Further h

By [\(a\)](#page-6-2), we conclude that $(H, \cdot, \circ_{B(\varphi)})$ is a Hopf brace. Further by Lemma [2.4,](#page-3-2) it is easy to see that $(H, \cdot, \circ_B) \cong (H, \cdot, \circ_{B^{(\varphi)}})$ as Hopf braces.

[\(c\)](#page-6-4) By [\(a\)](#page-6-2), (H, \cdot, \circ_B) and $(H', \cdot, \circ_{B'})$ are Hopf braces. We next prove that *f* is a homomorphism of Hopf braces from $(H \cdot \circ_B)$ to $(H' \cdot \circ_B)$ Hopf braces from (H, \cdot, \circ_B) to $(H', \cdot, \circ_{B'})$.
As a matter of fact, because $f : (H, B')$

As a matter of fact, because $f : (H, B) \to (H', B')$ is a homomorphism of Rota-Baxter Hopf
rebra, we have a Hopf algebra homomorphism $f : H \to H'$ such that $f \circ B = B' \circ f$. Moreover algebra, we have a Hopf algebra homomorphism $f : H \to H'$ such that $f \circ B = B' \circ f$. Moreover, for any $h, g \in H$, we obtain

f(h \circ_B g) = f(h_{(1)}B(h_{(2)})gS_H(B(h_{(3)})))
$$

= $f(h_{(1)})f(B(h_{(2)}))f(g)f(S_H(B(h_{(3)})))$

Hence F is a functor. \Box

Corollary 3.3. Let (H, B) be a Rota-Baxter cocommutative Hopf algebra. If Im $B \subset Z(H)$ (the center of *H*), then the Hopf brace (H, \cdot, \circ_B) is the trivial one.

Proof. Indeed, for all $g, h \in H$, $g \circ_B h = g_{(1)}B(g_{(2)})hS(B(g_{(3)})) = gh$. □

We recall some properties of Hopf braces for later use.

Lemma 3.4. [\[1\]](#page-20-5) Let (H, \cdot, \circ) be a cocommutative Hopf brace. Let H_0 denote the Hopf algebra $(H, \circ, 1_\circ, \Delta, \varepsilon, T).$

We next use cocommutative Hopf braces to construct Rota-Baxter Hopf algebras. Let (H, \cdot, \circ) be a cocommutative Hopf brace. Consider the tensor coalgebra *H* ⊗ *H* with multiplication and antipode given by

(x \otimes y) * (z \otimes t) = x_{(1)} \circ z \otimes y(x_{(2)} \to t),
$$

S'(x \otimes y) = T(x_{(1)}) \otimes T(x_{(2)}) \circ (x_{(3)}S(y))

where *S* and *T* are antipodes of the Hopf algebras (*H*, ·) and (*H*, \circ) respectively, and \rightarrow is defined by Eq. (7) .

Consider the sub-Hopf algebras

of *H* ⊗ *H*, noticing that if (H, \cdot, \circ) is a Hopf brace, then $1 = 1 \circ (\text{see}[1])$ $1 = 1 \circ (\text{see}[1])$ $1 = 1 \circ (\text{see}[1])$.
Theorem 3.5. (a) With the notions given above, there is the factor

(a) *With the notions given above, there is the factorization of Hopf algebras* $H \otimes H = G * L$.

(b) *The splitting operator*

is a Rota-Baxter operator and takes the form

B(x \otimes y) = T(x) \circ y \otimes 1, \quad x, y \in H.
$$

(c) *For a homomorphism of cocommutative Hopf braces* $f : (H, \cdot, \circ) \to (H', \cdot, \circ)$ *, the map* $f \otimes f : H \otimes H \to H \otimes H$ is a homomorphism of Rota-Bayter Hopf algebras, vielding a *f* ⊗ *f* : *H* ⊗ *H* → *H* ⊗ *H is a homomorphism of Rota-Baxter Hopf algebras, yielding a functor*

Proof. [\(a\)](#page-7-1) The factorization follows since $x \otimes y = (y_{(1)} \otimes y_{(2)}) * (T(y_{(3)}) \circ x \otimes 1)$ for $x, y \in H$. [\(b\)](#page-7-2) By [\[15,](#page-21-12) Prop. 2], *B* is a Rota-Baxter operator on *H* ⊗ *H*. We verify Eq. [\(11\)](#page-7-3) as follows.

[\(c\)](#page-8-0) We first prove that, for the homomorphism *f* of Hopf braces, the map *f* ⊗ *f* is a homomorphism of Rota-Baxter Hopf algebras from $(H \otimes H, B)$ to $(H' \otimes H', B')$.

In summary, *f* ⊗ *f* is a homomorphism of Rota-Baxter Hopf algebras. Then it is direct to check that *J* a functor. □

Remark 3.6. Let (A, Δ, \circ, T) be a cocommutative Hopf algebra. Assume that (A, A) is a matched pair of cocommutative Hopf algebras $[20]$ with actions \rightarrow and \leftarrow such that

$$
a \circ b = (a_{(1)} \rightarrow b_{(1)}) \circ (a_{(2)} \rightarrow b_{(2)}), \quad a, b \in A.
$$

Then by [\[1,](#page-20-5) Prop. 3.2], we find that (A, \cdot, \circ) is a cocommutative Hopf brace with

a \cdot b = a_{(1)} \circ (T(a_{(2)}) \to b), \quad S(a) = a_{(1)} \to T(a_{(2)}), \quad a, b \in A.
$$

Then by Theorem [3.5,](#page-7-4) there is a Rota-Baxter cocommutative Hopf algebra $(A \otimes A, B)$, where $B(x \otimes y) = T(x) \circ y \otimes 1$, for all $x, y \in A$, and the tensor coalgebra $A \otimes A$ has the multiplication $*$ and antipode *S* ′ defined by

S'(x \otimes y) = T(x_{(1)}) \otimes (T(x_{(2)}) \circ y_{(1)}) \to T(y_{(2)}), \quad x, y, z, t \in A.
$$

Theorem [3.5](#page-7-4) yields the following PBW type theorem.

- Theorem 3.7. (a) *Every cocommutative Hopf brace can be embedded into a Rota-Baxter cocommutative Hopf algebra, regarded as a Hopf brace by Theorem [3.2.](#page-6-1)*
	- (b) *There is a natural transformation* $\mathcal{T}: I \rightarrow FJ$ *, where I is the identity functor on the category* cocHB *of cocommutative Hopf braces, and F and J are defined in Theorem [3.2](#page-6-1) and Theorem [3.5,](#page-7-4) respectively.*

However, the functors F and J do not give an equivalence between the categories cocHB and rbHA, and *H* ⊗ *H* is not an enveloping Rota-Baxter Hopf algebra of the Hopf brace *H*. It would be interesting to obtain an enveloping Rota-Baxter Hopf algebra of a Hopf brace and establish a PBW theorem.

Proof. [\(a\)](#page-9-1) Let (H, \cdot, \circ) be a cocommutative Hopf brace. Then $(H \otimes H, B)$ is a Rota-Baxter cocom-mutative Hopf algebra by Theorem [3.5.](#page-7-4) By Theorem [3.2,](#page-6-1) $(H \otimes H)_B = (H \otimes H, *, \circ_B)$ is a Hopf brace.

Embed *H* into $H \otimes H$ by $\psi : H \to H \otimes H$, $g \mapsto 1 \otimes g$. Then, ψ is an isomorphism of the Hopf braces *H* with Im(ψ), where Im(ψ) is considered as a sub-Hopf brace of $(H \otimes H)_B = (H \otimes H, *, \circ_B)$. In fact, for any $g, h \in H$, we have

\psi(g) * \psi(h) = (1 \otimes g) * (1 \otimes h) = 1 \otimes g(1 \rightarrow h) = 1 \otimes gh = \psi(gh),
$$

\psi(g) \circ_B \psi(h) = \psi(g)_{(1)} * B(\psi(g)_{(2)}) * \psi(h) * S'(B(\psi(g)_{(3)}))

[\(b\)](#page-9-0) Define

$$
\mathcal{T} = \{t_{(H,\cdot,\circ)} = \psi : I((H,\cdot,\circ)) \to FJ((H,\cdot,\circ)) \mid \text{for any Hopf trace } (H,\cdot,\circ)\},
$$

where ψ is defined by [\(a\)](#page-9-1). We next prove that T is a natural transformation.

Indeed, for any Hopf brace homomorphism $f : (H, \cdot, \circ) \to (H', \cdot, \circ)$, and for any $h \in (H, \cdot, \circ)$, we have

$$
FJ(f)\mathfrak{T}_{(H,\cdot,\circ)}(h)=(f\otimes f)(1\otimes h)=f(1)\otimes f(h)=1\otimes f(h),
$$

and

$$
\mathcal{T}_{(H',\cdot,\circ)}I(f)(h) = \mathcal{T}_{(H',\cdot,\circ)}f(h) = 1 \otimes f(h),
$$

that is, $FJ(f)\mathcal{T}_{(H,\cdot,\circ)} = \mathcal{T}_{(H',\cdot,\circ)}I(f)$. Hence $\mathcal{T}: I \to FJ$ is a natural transformation. □

Example 3.8. Let *H* and *K* be cocommutative Hopf algebras, and *H* a left *K*-module bialgebra with the module action \triangleright . Then the smash product of cocommutative Hopf algebras $G = H \# K$ is a cocommutative Hopf brace (see $[1, Example 1.5]$ $[1, Example 1.5]$). Here

(*h*#*k*)(*h* ′ #*k* ′) = *hh*′ #*kk*′ , (*h*#*k*) ◦ (*h* ′ #*k* ′) ⁼ *^h*(*k*(1) [▷] *^h* ′)#*k*(2)*k* ′ , *^S ^H*#*^K*(*h*#*k*) ⁼ *^S ^H*(*h*)#*^S ^K*(*k*), *^T^H*#*^K*(*h*#*k*) ⁼ *^S ^K*(*k*(1)) ▷ *^S ^H*(*h*)#*^S ^K*(*k*(2)), *^h*, *^h* [∈] *^H*, *^k*, *^k* ∈ *K*. ′ ′

In the following, applying Theorem [3.7,](#page-9-0) we construct a Rota-Baxter Hopf algebra containing *G*. To define the operations on $G' := G \otimes G = H \# K \otimes H \# K$: for $h \# k \otimes h' \# k'$, $g \# l \otimes g' \# l' \in G'$, take

$$
(h\#k \otimes h'\#k') * (g\#l \otimes g'\#l') := h(k_{(1)} \triangleright g)\#k_{(2)}l \otimes h'(k_{(3)} \triangleright g')\#k'l',
$$

$$
S'(h\#k \otimes h'\#k') := (S_K(k_{(1)}) \triangleright S_H(h_{(1)})\#S_K(k_{(2)}) \otimes S_K(k_{(3)}) \triangleright S_H(h')\#S_K(k')).
$$

Consider the sub-Hopf algebras

$$
H := \{((h\#k)_{(1)} \otimes (h\#k)_{(2)}) \mid h\#k \in G\}, \quad L := \{((h\#k) \otimes 1\#1) \mid h\#k \in G\}
$$

of *G*'. We obtain the decomposition $G' = H * L$, since

h\#k \otimes h'\#k' = ((h'\#k')_{(1)} \otimes (h'\#k')_{(2)}) * (T((h'\#k')_{(3)}) \circ (h\#k) \otimes 1\#1)

(h'_{(1)}\#k'_{(1)} \otimes h'_{(2)}\#k'_{(2)}) * ((S_K(k'_{(3)}) \circ S_H(h'_{(3)}))(S_K(k'_{(4)}) \circ h)\#S_K(k'_{(5)})k \otimes 1\#1).
$$

Define a Rota-Baxter operator $B: G' \to G'$ by

$$
B((h\#k, h'\#k')) = T(h\#k) \circ (h'\#k') \otimes 1\#1
$$

= $(S_K(k_{(1)}) \circ S_H(h))(S_K(k_{(2)}) \circ h')\#S_K(k_{(3)})k' \otimes 1\#1.$

Hence, $G = H \# K$ embeds into the Rota-Baxter Hopf algebra $(G', *, B)$ by sending $h \# k$ to $1 \# 1 \otimes h \# k$ *h*#*k*.

Remark 3.9. (a) Let (G, B) be a Rota-Baxter group. Then by $[15,$ Theorem 1], we naturally obtain a Rota-Baxter operator *B* on the group algebra $F[G]$. If $f : G \rightarrow G$ is a group isomorphism, then $\varphi : F[G] \to F[G]$ is a bialgebra automorphism, where $\varphi(x) = \sum \alpha_i f(g_i)$, for all $x - \sum \alpha_i g_i \in F(G)$ for all $x = \sum \alpha_i g_i \in F(G)$.
Theorem 3.2 shows the

Theorem [3.2](#page-6-1) shows that $(F[G], \cdot, \circ_B)$, $(F[G], \cdot, \circ_{\overline{B}})$ and $(F[G], \cdot, \circ_{B^{(\varphi)}})$ are cocommutative Hopf braces. Hence, by Theorem [3.7,](#page-9-0) they can be embedded into Rota-Baxter Hopf algebras.

(b) Let *L* be a Lie algebra and *R* be a Rota-Baxter operator of weight 1 on *L*. Then by [\[15,](#page-21-12) Lemmas 2 and 3], the map *R* can be extended to a linear map *B*: $U(L) \rightarrow U(L)$ such that *B* is a Rota-Baxter operator on *U*(*L*), where *U*(*L*) is the universal enveloping algebra of the Lie algebra *L*.

If there is an automorphism *f* on a Lie algebra *L*, then we naturally have a bialgebra automorphism $\psi : U(L) \to U(L)$. Theorem [3.2](#page-6-1) again shows that $(U(L), \cdot, \circ_B), (U(L), \cdot, \circ_{\overline{B}})$ and $(U(L), \cdot, \circ_{R(\psi)})$ are cocommutative Hopf braces. Hence by Theorem [3.7,](#page-9-0) they can be embedded into Rota-Baxter Hopf algebras.

In what follows, we establish a relationship between cocommutative post-Hopf algebras and Rota-Baxter cocommutative Hopf algebras, which goes beyond the one given in [\[22\]](#page-21-13).

Definition 3.10. [\[22\]](#page-21-13) A post-Hopf algebra is a pair (H, \triangleright) , where *H* is a Hopf algebra and $\triangleright: H \otimes H \to H$ is a coalgebra homomorphism satisfying

$$
x \triangleright (yz) = (x_{(1)} \triangleright y)(x_{(2)} \triangleright z),
$$

\n
$$
x \triangleright (y \triangleright z) = (x_{(1)}(x_{(2)} \triangleright y)) \triangleright z, \quad x, y, z \in H,
$$

and the left multiplication $\alpha_{\blacktriangleright}: H \to \text{End}(H)$ defined by

$$
\alpha_{\blacktriangleright, x}(y) = x \blacktriangleright y, \text{ for all } x, y \in H,
$$

is convolutionally invertible in Hom(*H*, End(*H*)), that is, there exists a unique map β_{\triangleright} : *H* \rightarrow $End(H)$ such that ^α▶,*x*(1)β▶,*x*(2) ⁼ ^β▶,*x*(1)α▶,*x*(2) ⁼ ^ε(*x*)id*^H*, *^x* [∈] *^H*.

$$
\alpha_{\blacktriangleright, x_{(1)}} \beta_{\blacktriangleright, x_{(2)}} = \beta_{\blacktriangleright, x_{(1)}} \alpha_{\blacktriangleright, x_{(2)}} = \varepsilon(x) \mathrm{id}_H, \ x \in H.
$$

A homomorphism from a post-Hopf algebra (H, \blacktriangleright) to another post-Hopf algebra $(H', \blacktriangleright')$ is a post-flore homomorphism $g : H \to H'$ satisfying Hopf algebra homomorphism $g : H \to H'$ satisfying

$$
g(x \triangleright y) = g(x) \triangleright' g(y), \ x, y \in H.
$$

 $[22,$ Theorem 2.13] states that a cocommutative post-Hopf algebra $(H, \blacktriangleright, S)$ and its subadjacent Hopf algebra $(H, *_{\blacktriangleright}, S_{\blacktriangleright})$ form a Hopf brace, where the multiplication $*_{\blacktriangleright}$ and the antipode S_{\blacktriangleright} are given by

(12)
$$
x *_{\blacktriangleright} y := x_{(1)}(x_{(2)} \blacktriangleright y), \quad S_{\blacktriangleright}(x) := \beta_{\blacktriangleright, x_{(1)}}(S(x_{(2)})), \quad x, y \in H.
$$

Conversely, any cocommutative Hopf brace (H, \cdot, \circ) gives a post-Hopf algebra (H, \rightarrow) with the multiplication \blacktriangleright defined by

(13)
$$
x \triangleright y = S(x_{(1)})(x_{(2)} \circ y), x, y \in H.
$$

For a post-Hopf algebra (H, \triangleright) and H_{\triangleright} the subadjacent Hopf algebra, by [\[22,](#page-21-13) Prop. 3.2], the identity map $id_H : H \to H_{\blacktriangleright}$ is a relative Rota-Baxter operator. We next apply Theorem [3.2](#page-6-1) to give other avenues to obtain (non-relative) Rota-Baxter operators on Hopf algebras from cocommutative post-Hopf algebras. Applying Theorems [3.2,](#page-6-1) [3.7](#page-9-0) and above relationship between post-Hopf algebras and Hopf braces gives the following correspondences.

Corollary 3.11. (a) Let (H, B) be a Rota-Baxter cocommutative Hopf algebra (H, B) . Let (H, \cdot, \circ_B) be the Hopf brace from Theorem [3.2,](#page-6-1) where

$$
g \circ_B h := g_{(1)} B(g_{(2)}) h S(B(g_{(3)})), \ g, h \in H.
$$

Then, for

$$
x \triangleright y := S(x_{(1)})(x_{(2)} \circ_B y) = B(x_{(1)}) y S(B(x_{(2)})), x, y \in H,
$$

the pair (H, \blacktriangleright) is a post-Hopf algebra.

(b) Let (H, \triangleright, S) be a cocommutative post-Hopf algebra and let (H, \cdot, \cdot) be the corresponding Hopf brace defined in Eq. [\(12\)](#page-11-0). Define an operator

$$
B: H \otimes H \to H \otimes H, \ B(x \otimes y) := S_{\blacktriangleright}(x) *_{\blacktriangleright} y \otimes 1, \ x, y \in H.
$$

Then the pair $(H \otimes H, B)$ is a cocommutative Rota-Baxter Hopf algebra.

(c) Every cocommutative post-Hopf algebra is embedded as the post-Hopf subalgebra of a Rota-Baxter cocommutative Hopf algebra.

Proof. [\(a\)](#page-11-1) This follows from Theorem [3.2](#page-6-1) and above fact that Eq [\(13\)](#page-11-2) defines a post-Hopf algebra. [\(b\)](#page-12-1) This follows from the above fact that (H, \cdot, \cdot) defined by Eq. [\(12\)](#page-11-0) is a Hopf brace together with Theorem [3.7](#page-9-0) that $(H \otimes H, B)$ is a cocommutative Rota-Baxter Hopf algebra.

[\(c\)](#page-12-0) Let *H* be a cocommutative post-Hopf algebra. Then by [\(b\)](#page-12-1), $H \otimes H$ is a cocommutative Rota-Baxter Hopf algebra. Then by [\(a\)](#page-11-1), $(H \otimes H, \blacktriangleright_{H \otimes H})$ is a post-Hopf algebra with
 $(x \otimes y) \blacktriangleright_{H \otimes H} (h \otimes g) = B(x_{(1)} \otimes y_{(1)}) * (h \otimes g) * S'(B(x_{(2)} \otimes y_{(2)}))$, x, y, h, g

$$
(x \otimes y) \blacktriangleright_{H \otimes H} (h \otimes g) = B(x_{(1)} \otimes y_{(1)}) * (h \otimes g) * S'(B(x_{(2)} \otimes y_{(2)})), \quad x, y, h, g \in H,
$$

where $*$ and S' are defined in Theorem [3.7.](#page-9-0)

Embed *H* into $H \otimes H$ by the map

$$
\psi: H \to H \otimes H, \ g \mapsto 1 \otimes g.
$$

Then ψ is an isomorphism from the post-Hopf algebra *G* to Im(ψ), regarded as a post-Hopf subalgebra of $(H \otimes H_{\text{max}})$. This is because for all $g, h \in H$ on the one hand subalgebra of $(H \otimes H, \blacktriangleright_{H \otimes H})$. This is because, for all $g, h \in H$, on the one hand,

$$
\psi(g) \triangleright \psi(h) = (1 \otimes g) \triangleright (1 \otimes h)
$$

\n= $B(1 \otimes g_{(1)}) * (1 \otimes h) * S'(B(1 \otimes g_{(2)}))$
\n= $(g_{(1)} \otimes 1) * (1 \otimes h) * S'(g_{(2)} \otimes 1)$
\n= $(g_{(1)} \otimes S(g_{(2)})(g_{(3)} *_{\blacktriangleright} h)) * (S_{\blacktriangleright}(g_{(2)}) \otimes 1)$
\n= $g_{(1)} *_{\blacktriangleright} S_{\blacktriangleright}(g_{(2)}) \otimes S(g_{(3)})(g_{(4)} *_{\blacktriangleright} h)$
\n= $1 \otimes S(h_{(1)})(h_{(2)} *_{\blacktriangleright} g)$
\n= $1 \otimes S(g_{(1)})g_{(2)}(g_{(3)}) \triangleright h$
\n= $1 \otimes (g \triangleright h)$
\n= $\psi(g \triangleright h)$,

and on the other hand, by Theorem [3.7,](#page-9-0) $\psi(gh) = \psi(g) * \psi(h) = \psi(gh)$.

Definition 3.12. A solution of the **Yang-Baxter equation** on a vector space *V* is a linear bijection $R: V \otimes V \rightarrow V \otimes V$ such that

$$
(R \otimes id)(id \otimes R)(R \otimes id) = (id \otimes R)(R \otimes id)(id \otimes R).
$$

In the following, we obtain solutions of the Yang-Baxter equation via Rota-Baxter operators on cocommutative Hopf algebras.

Let (H, B) be a Rota-Baxter cocommutative Hopf algebra. By Theorem [3.2\(](#page-6-1)[a\)](#page-6-2), (H, \cdot, \circ_B) is a cocommutative Hopf brace. By [\[1,](#page-20-5) Lemma 1.8 and Lemma 2.2], *H* is a left *H^B* module bialgebra via \rightarrow _{*B*}, and *H* is a right *H_B* module coalgebra via \leftarrow _{*B*}, where the actions \rightarrow _{*B*} and \leftarrow _{*B*} are defined by

(14)
$$
h \rightarrow_B k := S(h_{(1)})(h_{(2)} \circ_B k), \ h \rightarrow_B k := T(h_{(1)} \rightarrow k_{(1)}) \circ_B h_{(2)} \circ_B k_{(2)}, \ h, k \in H,
$$

for *T* in Eq. [\(3\)](#page-3-0).

Proposition 3.13. *Let* (*H*, *^B*) *be a Rota-Baxter cocommutative Hopf algebra. Then the linear map*

(15)
$$
c: H \otimes H \to H \otimes H, \quad c(x \otimes y) = x_{(1)} \to_B y_{(1)} \otimes x_{(2)} \leftarrow_B y_{(2)},
$$

is a coalgebra isomorphism and a solution of the Yang-Baxter equation on the vector space H. Furthermore, the actions \rightarrow _{*B} and* \leftarrow _{*B*} *are given in terms of B by*</sub>

(16)
$$
h \rightharpoonup_B k = B(h_{(1)})kS(B(h_{(2)})),
$$

(17) $h \rightharpoonup_B k = S(B(h_{(1)} \rightharpoonup k_{(1)}))S(h_{(2)} \rightharpoonup k_{(2)})h_{(3)}(h_{(4)} \rightharpoonup k_{(3)})B(h_{(5)} \rightharpoonup k_{(4)}), h, k \in H,$

respectively.

Proof. Since (H, B) is a Rota-Baxter cocommutative Hopf algebra, by Theorem [3.2\(](#page-6-1)[a\)](#page-6-2), (H, \cdot, \circ_B) is a Hopf brace. By [\[1,](#page-20-5) Corollary 2.4], the Hopf brace (H, \cdot, \circ_B) gives a solution of the Yang-Baxter equation by Eq. (15) .

Furthermore, Eqs. [\(16\)](#page-13-1) and [\(17\)](#page-13-1) are verified as follows.

$$
h \rightarrow_B k = S(h_{(1)})(h_{(2)} \circ_B k)
$$

= $S(h_{(1)})h_{(2)(1)}B(h_{(2)(2)})kS(B(h_{(2)(3)}))$
= $B(h_{(1)})kS(B(h_{(2)})).$

By [\[15,](#page-21-12) Prop. 5 and Corollary 3] and Lemma [2.3,](#page-3-1) we obtain

$$
h \leftarrow_B k = T(h_{(1)} \rightarrow k_{(1)}) \circ_B h_{(2)} \circ_B k_{(2)}

= T(h_{(1)} \rightarrow k_{(1)}) \circ_B (h_{(2)}B(h_{(3)})k_{(2)}S(B(h_{(4)})))

= T(h_{(1)} \rightarrow k_{(1)})B(T(h_{(2)} \rightarrow k_{(2)}))h_{(3)}B(h_{(4)})k_{(3)}S(B(h_{(5)}))S(B(T(h_{(6)} \rightarrow k_{(4)})))

= S(B(h_{(1)} \rightarrow k_{(1)}))S(h_{(2)} \rightarrow k_{(2)})B(h_{(3)} \rightarrow k_{(3)})
$$

\n

\times B(S(B(h_{(4)} \rightarrow k_{(4)}))S(h_{(5)} \rightarrow k_{(5)})B(h_{(6)} \rightarrow k_{(6)}))
$$

\n
$$
\times h_{(7)}(h_{(8)} \rightarrow k_{(7)})S(B(T(h_{(9)} \rightarrow k_{(8)})))
$$

\n
$$
= S(B(h_{(1)} \rightarrow k_{(1)}))S(h_{(2)} \rightarrow k_{(2)})B(h_{(3)} \rightarrow k_{(3)})B(T(h_{(4)} \rightarrow k_{(4)})))
$$

\n
$$
\times h_{(5)}(h_{(6)} \rightarrow k_{(5)})S(B(T(h_{(7)} \rightarrow k_{(6)})))
$$

\n
$$
= S(B(h_{(1)} \rightarrow k_{(1)}))S(h_{(2)} \rightarrow k_{(2)})h_{(3)}(h_{(4)} \rightarrow k_{(3)})S(B(T((h_{(5)} \rightarrow k_{(4)}))))
$$

\n(applying Lemma 2.3(b) to the underlined part)
\n
$$
= S(B(h_{(1)} \rightarrow k_{(1)}))S(h_{(2)} \rightarrow k_{(2)})h_{(3)}(h_{(4)} \rightarrow k_{(3)})B(T(T((h_{(5)} \rightarrow k_{(4)}))))
$$

\n

= S(B(h_{(1)} \rightarrow k_{(1)}))S(h_{(2)} \rightarrow k_{(2)})h_{(3)}(h_{(4)} \rightarrow k_{(3)})B(h_{(5)} \rightarrow k_{(4)}).
$$

3.2. Relative Rota-Baxter operators on cocommutative Hopf algebras, Hopf braces and bijective 1-cocycles. In this subsection, we construct a Hopf brace from a relative Rota-Baxter operator on Hopf algebra and establish the connection between relative Rota-Baxter operators and bijective 1-cocycles on Hopf algebras.

In [\[22\]](#page-21-13), the authors generalized the notion of Rota-Baxter operators on a Hopf algebra [\[15\]](#page-21-12) to that of relative Rota-Baxter operators, by generalizing the adjoint action to arbitrary actions on bialgebras.

Definition 3.14. [\[22\]](#page-21-13) Let *H* and *K* be Hopf algebras such that *K* is a left *H*-module bialgebra via an action \rightarrow . A coalgebra homomorphism $\tau : K \rightarrow H$ is called a **relative Rota-Baxter operator** with respect to the left *H*-module bialgebra (K, \rightarrow) if

(18)
$$
\tau(a)\tau(b) = \tau(a_{(1)}(\tau(a_{(2)}) \to b)), \quad a, b \in K.
$$

Lemma 3.15. [\[22\]](#page-21-13) Let $\tau : K \to H$ be a relative Rota-Baxter operator with respect to a cocommutative *H*-module bialgebra (K, \rightarrow) . Then $(K, \circ, \Delta, S_{\tau})$ is a Hopf algebra, which is called the descendant Hopf algebra and denoted by K_{τ} , where the antipode S_{τ} and the multiplication \circ is given by

$$
S_{\tau}(k) = S_H(\tau(k_{(1)})) \to S_K(k_{(2)}),
$$

and

$$
k \circ k' = k_{(1)}(\tau(k_{(2)}) \to k'), \ k, k' \in K.
$$

In the following, we will prove that the descendant Hopf algebra also forms a Hopf brace. In fact, The descendant Hopf algebra derived from a relative Rota-Baxter operator generalizes the descendant Hopf algebra obtained through a Rota-Baxter Hopf algebra in Lemma [2.3.](#page-3-1)

Proposition 3.16. Let $\tau : K \to H$ be a relative Rota-Baxter operator with respect to a cocommu*tative H-module bialgebra* (K, \rightarrow) *. Then* (K, K_{τ}, Δ) *is a Hopf brace.*

Conversely, let (H, \cdot, \circ) *be a cocommutative Hopf brace. Then with the action* \rightarrow *defined by Lemma* [3.4,](#page-7-5) the triple $(H, H_\circ, \rightarrow, id_H)$ *is a relative Rota-Baxter Hopf algebra.*

Proof. Indeed, for any $k \in K$, we have

$$
(k_{(1)} \circ k')S(k_{(2)})(k_{(3)} \circ k'') = k_{(1)}(\tau(k_{(2)}) \to k')S(k_{(3)})k_{(4)}(\tau(k_{(5)}) \to k'')
$$

= $k_{(1)}(\tau(k_{(2)}) \to k')(\tau(k_{(3)}) \to k'')$
= $k_{(1)}(\tau(k_{(2)}) \to (k'k''))$
= $k \circ (k'k'').$

For the second claim, taking $\tau = id_H$ in Eq. [\(18\)](#page-13-3) yields Eq. [\(8\)](#page-7-6).

We next recall the notion of bijective 1-cocycles on Hopf algebras as a special case of 1 cocycles, also known as crossed homomorphisms [\[30\]](#page-21-15) and recently identified as relative difference operators [\[18\]](#page-21-16).

Definition 3.17. [\[1\]](#page-20-5) Let *H* and *A* be Hopf algebras, and *A* a left *H*-module algebra via an action \rightarrow . A **bijective 1-cocycle** is a coalgebra isomorphism $\pi : H \rightarrow A$ such that

$$
\pi(hk) = \pi(h_{(1)})(h_{(2)} \to \pi(k)), \quad h, k \in H.
$$

Bijective 1-cocycles can be related to relative Rota-Baxter operators in multiple ways. We first give a direct connection.

Proposition 3.18. *Let H and A be Hopf algebras, and A an H-module bialgebra via an action* \rightarrow *. If* $\tau : A \rightarrow H$ *is a invertible linear map, then* τ *is a relative Rota-Baxter operator if and only if* τ −1 *is a bijective 1-cocycle.*

Proof. If $\tau : A \rightarrow H$ is a relative Rota-Baxter operator with respect to the left *H*-module bialgebra (A, \rightarrow) , we have

$$
\tau(a)\tau(b) = \tau(a_{(1)}(\tau(a_{(2)}) \rightarrow b)),
$$

for all $a, b \in A$. By the bijectivity of τ , there exist $h, k \in H$ such that $\tau^{-1}(h) = a$ and $\tau^{-1}(k) = b$.
Then $hk = \tau(\tau^{-1}(h_{\text{CD}})(h_{\text{CD}} \to \tau^{-1}(k)))$ that is Then $hk = \tau(\tau^{-1}(h_{(1)})(h_{(2)} \to \tau^{-1}(k)))$, that is,

$$
\tau^{-1}(hk) = \tau^{-1}(h_{(1)})(h_{(2)} \rightharpoonup \tau^{-1}(k)).
$$

Moreover, since τ is a coalgebra isomorphism, it is easy to verify that τ^{-1} is a coalgebra isomorphism. Therefore τ^{-1} is a bijective 1-cocycle phism. Therefore, τ^{-1} is a bijective 1-cocycle.

Conversely, if $\tau^{-1}: H \to A$ is a bijective 1-cocycle, then we have

$$
\tau^{-1}(hk) = \tau^{-1}(h_{(1)})(h_{(2)} \rightarrow \tau^{-1}(k)), \ h, h \in H,
$$

and there exist $a, b \in A$ such that $\tau(a) = h$ and $\tau(b) = k$. Hence $\tau^{-1}(\tau(a)\tau(b)) = a_{(1)}(\tau(a_{(2)}) \to b)$
which means that which means that

$$
\tau(a)\tau(b) = \tau(a_{(1)}(\tau(a_{(2)}) \rightarrow b)).
$$

Hence τ is a relative Rota-Baxter operator. \Box

Applying the relationship between Hopf braces and bijective 1-cocycles, we arrive at the next connection between 1-cocycles and relative Rota-Baxter operators on Hopf algebras.

Proposition 3.19. *Let H and K be cocommutative Hopf algebras.*

- (a) *If* π : *H* \rightarrow *K* is a bijective 1-cocycle, then id_K : $K \rightarrow K_{\circ_{\pi}}$ is a relative Rota-Baxter
onerator where \circ is defined by $a \circ f = \pi(\pi^{-1}(a)\pi^{-1}(b))$ for all $a \circ f \in K$ *operator, where* \circ_{π} *is defined by a* \circ_{π} *b* = $\pi(\pi^{-1}(a)\pi^{-1}(b))$ *, for all a, b* ∈ *K. H*, *n* = *H i*s *a relative Rota-Baxter operator with respect to a left H-m*
- (b) *If* τ : *^K* [→] *H is a relative Rota-Baxter operator with respect to a left H-module bialgebra* (K, \rightarrow) *, then id*_K : $K \rightarrow K_{\circ}$ *is a relative Rota-Baxter operator, where* \circ *is defined by* $x \circ y = x_{(1)}(\tau(x_{(2)}) \to y)$, for all $x, y \in K$.

Proof. [\(a\)](#page-15-4) By [\[1,](#page-20-5) Theorem 1.12], if $\pi : H \to K$ is a bijective 1-cocycle, then (K, \cdot, \circ_{π}) is a Hopf brace, with $a \circ_{\pi} b = \pi(\pi^{-1}(a)\pi^{-1}(b))$ for $a, b \in K$. So by Lemma [3.4,](#page-7-5) *K* is a left $K_{\circ_{\pi}}$ -module bialgebra and $a \circ_{\pi} b = a \circ_{\pi}(a \circ_{\pi} \to b)$ for all $a, b \in K$ means that $id_{\pi} : K \to K$ is a relative bialgebra and $a \circ_{\pi} b = a_{(1)}(a_{(2)} \to b)$ for all $a, b \in K$ means that $\mathrm{id}_{K} : K \to K_{\circ_{\pi}}$ is a relative Rota-Baxter operator Rota-Baxter operator.

[\(b\)](#page-15-1) If $\tau : K \to H$ is a relative Rota-Baxter operator with respect to a left *H*-module bialgebra (K, \rightarrow) , then by Proposition [3.16,](#page-14-0) there exists a Hopf brace (K, \cdot, \circ) with $x \circ y = x_{(1)}(\tau(x_{(2)}) \rightarrow y)$ for *x*, *y* \in *K*. So by Definition [3.17](#page-14-2) and Lemma [3.4,](#page-7-5) id_K : $K_{\circ} \rightarrow K$ is a bijective 1-cocycle and its inverse is a relative Rota-Baxter operator.

Corollary 3.20. Let (H, B) be a Rota-Baxter cocommutative Hopf algebra. Then $id_H : H \to H_B$ is a relative Rota-Baxter operator.

Proof. By Theorem [3.2,](#page-6-1) (H, \cdot, \circ_B) is a Hopf brace. So *H* is a left H_B -module bialgebra with the action \rightarrow such that $a \circ_B b = a_{(1)}(a_{(2)} \rightarrow b)$, for $a, b \in H$. Hence, by the above two definitions, the identity map id_H : $H \rightarrow H_B$ is a relative Rota-Baxter operator and id_H : $H_B \rightarrow H$ a bijective 1-cocycle. \Box

Remark 3.21. Let $\pi : H \to A$ be a bijective 1-cocycle. By [\[1,](#page-20-5) Theorem 1.12] and Theorem [3.7,](#page-9-0) we get a Rota-Baxter cocommutative Hopf algebra (*^A* [⊗] *^A*, *^B*), with the Rota-Baxter operator $B(x \otimes y) := \pi(S\pi^{-1}(x)\pi^{-1}(y)) \otimes 1$, for all $x, y \in A$, and tensor coalgebra $A \otimes A$, and the multiplication $*$ and antipode S' defined by ∗ and antipode *S* ′ defined by

$$
(x \otimes y) * (z \otimes t) = \pi(\pi^{-1}(x_{(1)})\pi^{-1}(z)) \otimes y(S(x_{(2)})(\pi(\pi^{-1}(x_{(3)})\pi^{-1}(t))))
$$
\n
$$
S'(x \otimes y) = \pi S \pi^{-1}(x_{(1)}) \otimes \pi(S \pi^{-1}(x_{(2)})\pi^{-1}(x_{(3)}S(y))).
$$

4. Rota-Baxter operators and symmetric Hopf braces

In this section, we introduce the notion of a symmetric Hopf brace which generalizes the symmetric skew brace (See[\[7\]](#page-20-14)), and give their characterizations through Rota-Baxter operators of Hopf algebras.

Definition 4.1. A Hopf brace (H, \cdot, \circ) is called **symmetric** if (H, \circ, \cdot) is also a Hopf brace.

We first characterize symmetric cocommutative Hopf braces by equations.

Proposition 4.2. A cocommutative Hopf brace (H, \cdot, \circ) is symmetric if and only if the action \rightarrow *in Lemma [3.4](#page-7-5) satisfies*

$$
ab_{(1)}(b_{(2)} \rightarrow c) = a_{(1)}b_{(1)}((a_{(2)}b_{(2)}) \rightarrow (T(a_{(3)}) \rightarrow c)), \ a, b, c \in H.
$$

Proof. If a cocommutative Hopf brace (H, \cdot, \circ) is symmetric, then Lemma [3.4](#page-7-5) holds and (H, \circ, \cdot) is a Hopf brace, that is, $a(b \circ c) = (a_{(1)}b) \circ T(a_{(2)}) \circ (a_{(3)}c)$, for all $a, b, c \in H$. Hence

$$
ab_{(1)}(b_{(2)} \rightarrow c) \stackrel{\text{(8)}}{=} a(b \circ c)
$$

\n
$$
= (a_{(1)}b) \circ T(a_{(2)}) \circ (a_{(3)}c)
$$

\n
$$
= (a_{(1)}b_{(1)})((a_{(2)}b_{(2)}) \rightarrow (T(a_{(3)})(T(a_{(4)}) \rightarrow a_{(5)}) (T(a_{(6)}) \rightarrow c)))
$$

\n
$$
\stackrel{\text{(8)}}{=} (a_{(1)}b_{(1)})((a_{(2)}b_{(2)}) \rightarrow ((T(a_{(3)}) \circ a_{(4)}) (T(a_{(5)}) \rightarrow c)))
$$

\n
$$
= a_{(1)}b_{(1)}((a_{(2)}b_{(2)}) \rightarrow (T(a_{(3)}) \rightarrow c)).
$$

Here the underlined part indicates where a simplification occurs.

Conversely, if the action \rightarrow satisfies the given equation, we prove that (H, \circ, \cdot) is also a Hopf brace, that is, for all $a, b, c \in H$,

$$
a(b \circ c) = (a_{(1)}b) \circ T(a_{(2)}) \circ (a_{(3)}c).
$$

Because (H, \cdot, \circ) is a cocommutative Hopf brace, Lemma [3.4](#page-7-5) holds.
Hence, for any *a* $h \in H$

Hence, for any $a, b, c \in H$,
 $a(b \in A)$

$$
a(b \circ c) = ab_{(1)}(b_{(2)} \to c)
$$

= $a_{(1)}b_{(1)}((a_{(2)}b_{(2)}) \to (T(a_{(3)}) \to c))$
= $(a_{(1)}b) \circ T(a_{(2)}) \circ (a_{(3)}c),$

where the last step follows from the proof of necessity above. \Box

We next study symmetric Hopf braces by means of left H^{op} -modules.

Definition 4.3. Let (H, \cdot, \circ) be a Hopf brace. Let H^{op} denote the opposite Hopf algebra of (H, \cdot) .
We call (H, \cdot, \circ) an H^{op} -module Hopf brace if $(H \to)$ is a left H^{op} -module, where the action \to We call (H, \cdot, \circ) an H^{op} **-module Hopf brace** if (H, \rightharpoonup) is a left H^{op} -module, where the action \rightharpoonup is defined by is defined by

(19)
$$
a \to b := S(a_{(1)})(a_{(2)} \circ b), \quad a, b \in H.
$$

Note that the *H*^{op}-module (H, \rightarrow) in Definition [4.3](#page-16-0) is actually a left *H*^{op}-module bialgebra by mma 3.4 Lemma [3.4.](#page-7-5)

Let (H, \cdot, \circ) be an H^{op} -module Hopf brace. By the proof of [\[1,](#page-20-5) Lemma 1.8], for all $a, b, c \in H$,
 \circ have $(a \circ b) \rightarrow c = a \rightarrow (b \rightarrow c)$. That is to say $(H \rightarrow)$ is an H -module. Since $(H \rightarrow)$ is an we have $(a \circ b) \to c = a \to (b \to c)$. That is to say, (H, \to) is an H_{\circ} -module. Since (H, \to) is an *H*^{op}-module, we have $a \rightarrow (b \rightarrow c) = (ba) \rightarrow c$. Therefore,

$$
(a \circ b) \to c = (ba) \to c.
$$

Example 4.4. Let (H, \cdot) be a Hopf algebra. Define an operator \circ on the vector space H by

$$
a \circ b := ba, \quad a, b \in H.
$$

Then (H, \cdot, \circ) is a Hopf brace. Let the action \to on *H* be given in Eq. [\(19\)](#page-16-1). Then for any $a, b \in H$, we have $a \rightarrow b = S(a_{(1)})(a_{(2)} \circ b) = S(a_{(1)})ba_{(2)}$, so that (H, \rightarrow) is a module algebra. Hence every Hopf algebra (H, \cdot) is naturally an H^{op} -module Hopf brace (H, \cdot, \circ) .

Proposition 4.5. *Every cocommutative H*^{op}-module Hopf brace (H, \cdot, \circ) *is symmetric.*

Proof. If *H* is an *H*^{op}-module Hopf brace, then $(ab) \rightarrow c = (b \circ a) \rightarrow c$, for all $a, b, c \in H$.
Hence Hence,

$$
a_{(1)}b_{(1)}((a_{(2)}b_{(2)}) \rightarrow (T(a_{(3)}) \rightarrow c)) = a_{(1)}b_{(1)}((b_{(2)} \circ a_{(2)}) \rightarrow (T(a_{(3)}) \rightarrow c))
$$

\n
$$
= a_{(1)}b_{(1)}(b_{(2)} \rightarrow (a_{(2)} \rightarrow (T(a_{(3)}) \rightarrow c))
$$

\n
$$
= a_{(1)}b_{(1)}(b_{(2)} \rightarrow ((a_{(2)} \circ T(a_{(3)})) \rightarrow c))
$$

\n
$$
= ab_{(1)}(b_{(2)} \rightarrow c).
$$

By Proposition 4.2 , *H* is symmetric. \Box

We give a natural construction of symmetric Hopf braces.

Definition 4.6. A cocommutative Hopf algebra H is said to allow a factorization^{[1](#page-17-1)} if there are nontrivial Hopf subalgebras *A* and *B* of *H* such that $H \cong A \otimes B$ as a tensor product algebra and *H* = *AB* as a Hopf algebra. Then we denote $H = A \otimes B$.

Let $H = A \otimes B$ be a cocommutative Hopf algebra that allows a factorization. Define a operator ◦ on *H* by

$$
(ab) \circ (a'b') := aa'b'b, \quad a, a' \in A, b, b' \in B.
$$

Then, it is not difficult to check that (H, \cdot, \circ) is a Hopf brace. It is easy to see that (H, \circ) is isomorphic to the tensor algebra $A \otimes B^{op}$ where B^{op} is the opposite algebra of B isomorphic to the tensor algebra $A \otimes B^{\text{op}}$, where B^{op} is the opposite algebra of *B*.

Further define an action \rightarrow : $(H, \circ) \otimes H \rightarrow H$ by

$$
x \to y := S(x_{(1)})(x_{(2)} \circ y).
$$

If $x = ab$, $y = a'b'$, where $a, a' \in A$, $b, b' \in B$, then

$$
x \to y = S((ab)_{(1)})((ab)_{(2)} \circ (a'b')) = S(a_{(1)}b_{(1)})(a_{(2)}a'b'b_{(2)}) = \varepsilon(a)S(b_{(1)})y b_{(2)}.
$$

Hence,

$$
(xy) \rightarrow z = \varepsilon(aa')S((bb')_{(1)})z(bb')_{(2)} = \varepsilon(aa')S(b'_{(1)})S(b_{(1)})zb_{(2)}b'_{(2)} = y \rightarrow (x \rightarrow z).
$$

Thus we have the following conclusion.

Proposition 4.7. *For a Hopf algebra H that allows a factorization, the Hopf brace* (*H*, ⋅, ◦) *constructed above is an H*op*-module Hopf brace, hence is symmetric.*

We give another construction of symmetric Hopf braces.

Theorem 4.8. *Let* (H, \cdot, Δ, S) *be a cocommutative Hopf algebra, and* (H, \rightarrow) *an H*^{op}-module *bialgebra such that*

$$
a_{(1)}(a_{(2)} \to b) \to c = (ba) \to c, \quad a, b, c \in H.
$$

Define

 $a \circ b := a_{(1)}(a_{(2)} \to b)$ *and* $T(a) := S(a_{(1)}) \to S(a_{(2)})$

Then (H, \cdot, \circ) *is a symmetric Hopf brace.*

¹This terminology is used to avoid confusion with the factorizable Hopf algebra defined by Reshetikhin and Semenov-Tian-Shansky [\[23\]](#page-21-17).

Proof. We first check that (H, \circ) is an algebra.

This is because, for any $a, b, c \in G$, we have
 $(a \circ b) \circ c = (a_{(1)}(a_{(2)})$

$$
a \circ b) \circ c = (a_{(1)}(a_{(2)} \rightarrow b)) \circ c
$$

= $(a_{(1)}(a_{(2)} \rightarrow b))_{(1)}((a_{(1)}(a_{(2)} \rightarrow b))_{(2)} \rightarrow c)$
= $a_{(1)}(a_{(2)} \rightarrow b_{(1)})((a_{(3)}(a_{(4)} \rightarrow b_{(2)})) \rightarrow c)$
= $a_{(1)}(a_{(2)} \rightarrow b_{(1)})(b_{(2)}a_{(3)} \rightarrow c)$
= $a_{(1)}(a_{(2)} \rightarrow b_{(1)})(a_{(3)} \rightarrow (b_{(2)} \rightarrow c))$
= $a_{(1)}(a_{(2)} \rightarrow (b_{(1)}(b_{(2)} \rightarrow c)))$
= $a_{(1)}(a_{(2)} \rightarrow (b \circ c))$
= $a \circ (b \circ c)$.

Hence (H, \circ) is an algebra with unit 1.

For any $a, b \in H$, we have

$$
\Delta(a \circ b) = \Delta(a_{(1)}(a_{(2)} \to b))
$$

= $a_{(1)(1)}(a_{(2)} \to b)_{(1)} \otimes a_{(1)(2)}(a_{(2)} \to b)_{(2)}$
= $a_{(1)}(a_{(2)} \to b_{(1)}) \otimes a_{(3)}(a_{(4)} \to b_{(2)})$
= $a_{(1)} \circ b_{(1)} \otimes a_{(2)} \circ b_{(2)}$.

and $\varepsilon(a \circ b) = \varepsilon(a_{(1)}(a_{(2)} \to b)) = \varepsilon(a_{(1)})\varepsilon(a_{(2)} \to b) = \varepsilon(a_{(1)})\varepsilon(a_{(2)})\varepsilon(b) = \varepsilon(a)\varepsilon(b).$ Hence (H, \circ, Δ) is a bialgebra.

In what follows, we prove that $a \circ (bc) = (a_{(1)} \circ b)S(a_{(2)})(a_{(3)} \circ c)$, for any $a, b, c \in H$.

$$
(a_{(1)} \circ b)S(a_{(2)})(a_{(3)} \circ c) = a_{(1)}(a_{(2)} \to b)S(a_{(3)})a_{(4)}(a_{(5)} \to c)
$$

= $a_{(1)}(a_{(2)} \to b)(a_{(3)} \to c)$
= $a_{(1)}(a_{(2)} \to (bc))$
= $a \circ (bc)$.

To show that (H, \circ, Δ) is a Hopf algebra with the antipode $T(a) = S(a_{(1)}) \rightarrow S(a_{(2)})$ for $a \in H$. We first prove that

$$
S(a \to b) = a \to S(b).
$$

This is because

$$
S(a \rightarrow b) = S(S(a_{(1)})(a_{(2)} \circ b))
$$

\n
$$
= S(a_{(2)} \circ b)a_{(1)}
$$

\n
$$
= S(a_{(1)} \circ b)a_{(2)}
$$

\n
$$
= S(a_{(1)} \circ b_{(1)})\varepsilon(b_{(2)})a_{(2)}
$$

\n
$$
= S(a_{(1)} \circ b_{(1)})\frac{(a_{(2)} \circ (b_{(2)}S(b_{(3)})))}{(a_{(2)} \circ b_{(2)})S(a_{(3)})(a_{(4)} \circ S(b_{(3)}))}
$$

\n
$$
= \frac{S(a_{(1)} \circ b_{(1)})S(a_{(2)})(a_{(3)} \circ S(b_{(2)}))}{\varepsilon(a_{(1)} \circ b_{(1)})S(a_{(2)})(a_{(3)} \circ S(b_{(2)}))}
$$
 (by antipode property)
\n
$$
= S(a_{(1)})(a_{(2)} \circ S(b))
$$

\n
$$
= a \rightarrow S(b).
$$

Secondly, we prove $T^2 = id$: for any $a \in H$, we have

$$
T^{2}(a) = T(S(a_{(1)}) \rightarrow S(a_{(2)}))
$$

\n
$$
= S(S(a_{(1)}) \rightarrow S(a_{(2)})) \rightarrow S(S(a_{(3)}) \rightarrow S(a_{(4)}))
$$

\n
$$
= (S(a_{(1)}) \rightarrow a_{(2)}) \rightarrow (S(a_{(3)}) \rightarrow a_{(4)})
$$

\n
$$
= (S(a_{(3)})(S(a_{(1)}) \rightarrow a_{(2)})) \rightarrow a_{(4)}
$$

\n
$$
= (S(a_{(2)})(S(a_{(1)}) \rightarrow a_{(3)})) \rightarrow a_{(4)}
$$

\n
$$
= (a_{(2)}S(a_{(1)})) \rightarrow a_{(3)}
$$

\n
$$
= \varepsilon(a_{1})a_{2}
$$

\n
$$
= a.
$$

In the following, we prove that *T* is antipode of (H, \circ, Δ) .
Because *H* is cocommutative for any $a \in H$ we get

Because *H* is cocommutative, for any $a \in H$, we get

$$
\Delta(T(a))=T(a_{(1)})\otimes T(a_{(2)}),
$$

and

$$
a_{(1)} \rightarrow T(a_{(2)}) = a_{(1)} \rightarrow (S(a_{(2)}) \rightarrow S(a_{(3)})) = (S(a_{(2)})a_{(1)}) \rightarrow S(a_{(3)}) = S(a).
$$

Furthermore, we obtain

$$
S(T(a)) = T(a)_{(1)} \rightarrow T(T(a)_{(2)}) = T(a_{(1)}) \rightarrow a_{(2)}.
$$

Hence

$$
T(a_{(1)}) \circ a_{(2)} = T(a_{(1)})(T(a_{(2)}) \to a_{(3)}) = T(a_{(1)})S(T(a_{(2)})) = \varepsilon(a)1,
$$

\n
$$
a_{(1)} \circ T(a_{(2)}) = a_{(1)}(a_{(2)} \to T(a_{(3)})) = a_{(1)}S(a_{(2)}) = \varepsilon(a)1.
$$

Now we have shown that (H, \cdot, \circ) is a Hopf brace, and an H^{op} -module Hopf brace, and therefore wine trice Hopf brace by Proposition 4.5 a symmetric Hopf brace by Proposition 4.5 . \Box

Proposition 4.9. *Let* (H, B) *be a Rota-Baxter cocommutative Hopf algebra. Let* \triangleright *be the adjoint action of H on itself given by* $a \triangleright b := a_{(1)}bS(a_2)$ *.*

(a) *The triple* (H, \cdot, \circ_B) *is a symmetric Hopf brace if and only if*
 $ab_{(1)}(B(b_{(2)}) \triangleright c) = a_{(1)}b_{(1)}((B(a_{(2)}b_{(2)})B(T(a_{(3)}))) \triangleright c$

$$
ab_{(1)}(B(b_{(2)}) \triangleright c) = a_{(1)}b_{(1)}((B(a_{(2)}b_{(2)})B(T(a_{(3)}))) \triangleright c), \quad a, b, c \in H.
$$

(b) (H, \cdot, \circ_B) *is an H^{op}-module Hopf brace if and only if*

$$
B(ba) \rhd c = (B(a)B(b)) \rhd c, \quad a, b, c \in H.
$$

(c) If B is an anti-algebra homomorphism, then (H, \cdot, \circ_B) is a symmetric Hopf brace.

Proof. [\(a\)](#page-19-1) It is obvious that (H, \cdot, \circ_B) is a Hopf brace by Theorem [3.2.](#page-6-1) So for the action \rightarrow in Definition [4.3:](#page-16-0) $a \rightarrow b = S(a_{(1)})(a_{(2)} \circ_B b)$ for $a, b \in H$, we have $a \rightarrow b = B(a) \triangleright b$.

By Proposition [4.2,](#page-16-2) A cocommutative Hopf brace (H, \cdot, \circ) is symmetric if and only if

$$
ab_{(1)}(b_{(2)} \rightarrow c) = a_{(1)}b_{(1)}((a_{(2)}b_{(2)}) \rightarrow (T(a_{(3)}) \rightarrow c)), \ a, b, c \in H.
$$

Note that

$$
a_{(1)}b_{(1)}((a_{(2)}b_{(2)}) \rightarrow (T(a_{(3)}) \rightarrow c)) = a_{(1)}b_{(1)}(B(a_{(2)}b_{(2)}) \triangleright (B(T(a_{(3)})) \triangleright c))
$$

= $a_{(1)}b_{(1)}((B(a_{(2)}b_{(2)})B(T(a_{(3)}))) \triangleright c),$

and

$$
ab_{(1)}(b_{(2)} \rightharpoonup c) = ab_{(1)}(B(b_{(2)}) \rhd c).
$$

Hence (H, \cdot, \circ_B) is a symmetric Hopf brace if and only if

$$
ab_{(1)}(B(b_{(2)}) \triangleright c) = a_{(1)}b_{(1)}((B(a_{(2)}b_{(2)})B(T(a_{(3)}))) \triangleright c).
$$

[\(b\)](#page-19-2) It is easy to see that (H, \cdot, \circ_B) is an H^{op} -module Hopf brace if and only if $(ba) \rightarrow c = a \rightarrow (b \rightarrow c)$ for all *a* $b \in H$ Since $(b \rightharpoonup c)$, for all $a, b, c \in H$. Since

$$
(ba) \rightarrow c = B(ba) \triangleright c, \quad a \rightarrow (b \rightarrow c) = B(a) \triangleright (B(b) \triangleright c) = (B(a)B(b)) \triangleright c,
$$

we see that (H, \cdot, \circ_B) is a H^{op} -module Hopf brace if and only if $B(ba) \rhd c = (B(a)B(b)) \rhd c$ for all $a, b, c \in H$ all $a, b, c \in H$.

[\(c\)](#page-19-3) If *B* is an anti-algebra homomorphism, then $B(yx) = B(x)B(y) = B(x \circ_B y)$ for all $x, y \in H$. So for any $a, b, c \in H$, we obtain the desired equality:

$$
a_{(1)}b_{(1)}((B(a_{(2)}b_{(2)})B(T(a_{(3)}))) \rhd c) = a_{(1)}b_{(1)}((B(b_{(2)} \circ_B a_{(2)})B(T(a_{(3)}))) \rhd c)
$$

= $a_{(1)}b_{(1)}((B((b_{(2)} \circ_B a_{(2)}) \circ_B T(a_{(3)}))) \rhd c)$
= $ab_{(1)}(B(b_{(2)}) \rhd c).$

Then by [\(a\)](#page-19-1), (H, \cdot, \circ_B) is a symmetric Hopf brace.
