# QUOTIENT HOPF ALGEBRAS OF THE FREE BIALGEBRA WITH PBW BASES AND GK-DIMENSIONS

ABSTRACT. Let k be a field. We study the free bialgebra  $\mathcal{T}$  generated by the coalgebra  $C = \lg \oplus kh$ and its quotient bialgebras (or Hopf algebras) over k. We show that the free noncommutative Faà di Bruno bialgebra is a sub-bialgebra of T, and the quotient bialgebra  $\overline{\mathcal{T}} := \mathcal{T}/(E_\alpha | \alpha(g) \geq 2)$  is an Ore extension of the well-known Faà di Bruno bialgebra. The image of the free noncommutative Faà di Bruno bialgebra in the quotient  $\overline{\mathcal{T}}$  gives a more reasonable non-commutative version of the commutative Faà di Bruno bialgebra from the PBW basis point view. If char  $k = p > 0$ , we obtain a chain of quotient Hopf algebras of  $\overline{\mathcal{T}}$ :  $\overline{\mathcal{T}} \twoheadrightarrow \overline{\mathcal{T}}_n(p) \twoheadrightarrow \overline{\mathcal{T}}_n(p) \twoheadrightarrow \overline{\mathcal{T}}_n(p; d_1) \twoheadrightarrow \ldots \twoheadrightarrow \overline{\mathcal{T}}_n(p; d_j, d_{j-1}, \ldots, d_1) \twoheadrightarrow \ldots \twoheadrightarrow$  $\overline{\mathcal{T}}_n(p; d_{p-2}, d_{p-3}, \ldots, d_1)$  with finite GK-dimensions. Furthermore, we study the homological properties and the coradical filtrations of those quotient Hopf algebras.

Keywords: pointed Hopf algebras, shuffle type polynomials, Lyndon-Shirshov basis, Faà di Bruno Hopf algebra, GK-dimension.

#### **INTRODUCTION**

Hopf algebras arise from many different aspects, e.g. groups, dg manifolds, Lie algebras, lattices, graphs, braided spaces etc. One of pure structure constructions of Hopf algebras is to generate a free Hopf algebra (or a bialgebra) by a coalgebra [\[30\]](#page-26-0). Such a free Hopf algebra is usually too big to have nice properties. So we consider its sub-Hopf algebras and quotient Hopf algebras. In this paper, we construct some interesting quotient bialgebras and quotient Hopf algebras of the free bialgebra  $\tau$ generated by the coalgebra  $C := \mathbb{k}g \oplus \mathbb{k}h$  with  $\Delta(g) = g \otimes g$  and  $\Delta(h) = 1 \otimes h + h \otimes g$ . It is clear that the Sweelder algebra  $H_4$  and the Taft algebras  $T_n$  are among them. But they are not the objectives in this paper. In 1977 Radford used the shuffle type polynomials (see [1.9\)](#page-3-0) to construct several interesting quotient Hopf algberas of  $\mathcal T$ , of which some are infinite dimensional [\[23,](#page-25-0) Proposition 4.7] and some are finite dimensional. In [\[16\]](#page-25-1) the authors used the Lyndon-Shirshov basis [\[10,](#page-25-2) [28\]](#page-25-3) to study the shuffle type polynomials, and obtained the non-commutative version of the binomial theorem.

In this paper, we make use of the Lyndon-Shirshov basis and the shuffle polynomials further to study the quotient Hopf algebras of  $\mathcal T$ . We first show that the so-called non-commutative Faà di Bruno bialgebra  $\mathcal{B}_{\text{FdB}}^{\text{nc}}$  is contained in the bialgebra  $\mathcal{T}$ , see Theorem [2.7.](#page-6-0) The free non-commutative Faà di Bruno Hopf algbera was constructed by Brouder–Frabetti–Krattenthaler [\[7\]](#page-25-4) from the noncommutative formal diffeomorphisms, while the (commutative) Faà di Bruno Hopf algebra was introduced in Doubilet  $|12|$  and Joni–Rota  $|17|$  from the set partitions, as an important example of incidence Hopf algebras. By considering the Lyndon words of the form  $\omega_r = g \underbrace{h \cdots h}_{r}$ for  $r \geq 0$  and the Lyndon-

Shirshov basis  $\{E_{\omega_r} | r \geq 0\}$ , we found a quotient bialgebra  $\mathcal T$  of  $\mathcal T$ , which is an Ore-extension of the Faà di Bruno bialgebra  $\mathcal{B}_{FdB}$ , see Theorem [2.19.](#page-10-0) Moreover, an interesting phenomenon occurs in  $\overline{\mathcal{T}}$ : the image  $\pi(\mathcal{B}^{\text{nc}}_{\text{FdB}})$  of the non-commutative Faà di Bruno bialgebra  $\mathcal{B}^{\text{nc}}_{\text{FdB}}$  in the bialgebra  $\overline{\mathcal{T}}$  generated by the Lyndon words  $\{\omega_r\}_{r\geq 0}$  has a PBW basis, which can be obtained by affixing the generators

 $\{\omega_r\}_{r\geq 1}$  to the PBW basis of  $\mathcal{B}_{\text{FdB}}$ . The two bialgebras  $\pi(\mathcal{B}_{\text{FdB}}^{\text{nc}})$  and  $\mathcal{B}_{\text{FdB}}$  intersect trivially and generate a sub-bialgebra  $\mathcal{B}_F$  in  $\overline{\mathcal{T}}$  with a combined PBW basis from those of the two Faà di Bruno bialgebras, see Theorem [2.23.](#page-12-0) Thus, it is more reasonable to view  $\pi(\mathcal{B}_{\text{FdB}}^{\text{nc}})$ , instead of  $\mathcal{B}_{\text{FdB}}^{\text{nc}}$ , as a suitable non-commutative version of the commutative Faà di Bruno bialgebra  $\mathcal{B}_{FdB}$ , see Remark [2.24.](#page-14-0)

In Section [3](#page-14-1) and Section [4,](#page-17-0) we go further to investigate the quotient Hopf algebras of the bialgebra  $\overline{\mathcal{T}}$  which have good homological properties. Let char  $k = p$ ,  $p|n$ ,  $\mathcal{E}_{gh} \neq 0$ ,  $1 \leq j \leq p-2$  and  $d_1 \leq d_2 \leq \ldots \leq d_{p-2}$ . We construct the following chain of quotient Hopf algebras of  $\overline{\mathcal{T}}$ :

$$
\overline{\mathcal{T}} \twoheadrightarrow \overline{\mathcal{T}}_n \twoheadrightarrow \overline{\mathcal{T}}'_n(p) \twoheadrightarrow \overline{\mathcal{T}}_n(p) \twoheadrightarrow \overline{\mathcal{T}}_n(p; d_j, d_{j-1}, \dots, d_1) \twoheadrightarrow \dots \twoheadrightarrow \overline{\mathcal{T}}_n(p; d_{p-2}, d_{p-3}, \dots, d_1).
$$

They have the following properties:

- (a)  $\overline{\mathcal{T}}_n$  has subexponential growth (of infinite GK-dimension), see Lemma [3.3;](#page-14-2)
- $(b)$   $\overline{\mathcal{T}}'$  $n(n)$  is of GK-dimension  $p-1$ , see Lemma [3.6;](#page-15-0)
- (c)  $\overline{\mathcal{T}}_n(p)$  is of GK-dimension  $p-2$ , see Lemma [3.10;](#page-16-0)
- (d)  $\overline{\mathcal{T}}_n(p; d_j, d_{j-1}, \ldots, d_1)$  is of GK-dimension  $p 2 j$ , see Theorem [3.14;](#page-17-1)
- (e) Let  $j = p 2$  in part (d). Then  $\overline{\mathcal{T}}_n(p; d_{p-2}, d_{p-3}, \ldots, d_1)$  is of dimension  $np^{(1+\sum_{i=1}^{p-2} d_i)}$ , see Remark [3.15](#page-17-2) (i).

The Hopf algebras in  $(b)-(e)$  are AS-Gorenstein, see Corollary [4.7.](#page-18-0) Examples of AS-regular algebras can be found in Corollary [4.8.](#page-18-1)

In Section [5,](#page-18-2) we study the coradical filtration and the related structures of the Hopf algebra  $\overline{\mathcal{T}}_{\pm 1}$ , the Faà di Bruno Hopf algebra  $\mathcal{H}_{\text{FdB}}$  and the Hopf algebra  $\overline{\mathcal{T}}_p(p;1,\ldots,1)$ . As a byproduct, we show that  $gr(\overline{\mathcal{T}}_{+1}^{cop}$  $_{\pm 1}^{cop}$ ) with char  $\mathbb{k} = 0$  and  $gr(\overline{\mathcal{T}}_p(p; 1, \ldots, 1)^{cop})$  with char  $\mathbb{k} = p$  both are the bosonizations of the Nichols algebras  $\mathcal{B}(V_{1,2})$ , where the braiding vector space  $V_{1,2}$  appeared in [\[1,](#page-25-7) Chpater 4] and [\[2,](#page-25-8) Section 4].

#### 1. Preliminaries

Let k be a field. For a colagebra C over k, denote by  $\mathbf{G}(C)$  the set of all grouplike elements of C, that is,  $\mathbf{G}(C) := \{ g \in C \mid \Delta(g) = g \otimes g, \epsilon(g) = 1 \},\$ and by  $\mathcal{P}_{g,g'}(C)$  for  $g, g' \in \mathbf{G}(C)$  the set of  $(g, g')$ -shew primitive elements, that is,  $\mathcal{P}_{g,g'}(C) := \{ h \in C \mid \Delta_C(h) = g \otimes h + h \otimes g', \epsilon_C(h) = 0 \}.$  In particular, the elements of  $\mathcal{P}_{1,1}(C)$  are said to be *primitive*. Write  $\mathcal{P}(C) := \bigcup_{g,g'\in\mathbf{G}(C)} \mathcal{P}_{g,g'}(C)$ . The *coradical* corad(C) of C is the sum of all simple subcoalgebras of C. The coalgebra C is said to be *pointed* or connected if  $\text{corad}(C) = \Bbbk \mathbf{G}(C)$  or  $\text{corad}(C) = \Bbbk$ , respectively.

#### 1.1. Lyndon words, Lyndon-Shirhsov basis and shuffle type polynomials.

First we recall some results of Lyndon words and Lyndon-Shirshov basis. We follow the definitions of [\[21\]](#page-25-9). Suppose that  $(X, \preceq)$  is a totally ordered set, and  $\langle X \rangle$  is the free monoid generated by X with the lexicographic order induced by  $\leq$ , see [\[21,](#page-25-9) p.64]. The empty word is denoted by  $1_X$ . In particular, write  $\alpha \prec \beta$  if  $\alpha \preceq \beta$ , but  $\alpha \neq \beta$  for  $\alpha, \beta \in \langle X \rangle$ . If  $\alpha = x_1x_2 \cdots x_n$ ,  $x_i \in X$ , the length of  $\alpha$  is n and is denoted by  $|\alpha|$ . For  $y \in X$ , denote by  $\alpha(y) := \#\{x_i | x_i = y, 1 \le i \le n\}$ .  $\mathbb{k}\langle X \rangle$  is the free associative algebra generated by X.

**Definition 1.1.** [\[21,](#page-25-9) p.64] A word  $\alpha$  in  $\langle X \rangle \setminus \{1\}$  is a *Lyndon word* (or *Lyndon-Shirshov word*) if  $\alpha \in X$ , or  $\alpha = \beta \gamma$  such that  $\alpha \prec \gamma \beta$  for  $\beta, \gamma \in \langle X \rangle \setminus \{1\}$ . The set of all Lyndon words is denoted by L.

**Example 1.2.** Let  $(X, \preceq) = (\{g, h\}, g \prec h)$ . The list of Lyndon words is:

 $\mathcal{L} := \{q, h, gh, ggh, ghh, gghh, ghhh, ggghh, gghgh, gghhh, ghhhh, ghhhh, \ldots\}.$ 

The factorization of a Lyndon word is not unique, see [\[21,](#page-25-9) Propositions 5.1.2, 5.1.3]. So we usually consider its standard factorization. For a composed word  $\alpha = \beta \gamma \in \mathcal{L} \setminus X$ ,  $\beta, \gamma \in \mathcal{L}$ , the pair  $(\beta, \gamma)$  is called the *standard factorizaion* of  $\alpha$  if  $\gamma$  is of maximal length. Denote it by st( $\alpha$ ) or ( $\alpha_L, \alpha_R$ ).

**Lemma 1.3.** [\[21,](#page-25-9) Theorem 5.3.1] Let  $\mathfrak{L}(X)$  be the free Lie algebra over k generated by X. Define a map  $E: \mathcal{L} \longrightarrow \mathfrak{L}(X)$  inductively by  $E(x) = x$  if  $x \in X$  and

$$
E(\alpha) = [E(\beta), E(\gamma)] := E(\beta)E(\gamma) - E(\gamma)E(\beta),
$$

if  $\alpha \in \mathcal{L} \setminus X$  and  $\text{st}(\alpha) = (\beta, \gamma)$ . Then  $\mathfrak{L}(X)$  is a free k-module with  $E(\mathcal{L})$  as a basis, called Lyndon-Shirshov basis. We write  $E_{\alpha}$  for  $E(\alpha)$  for the convenience in the computations.

**Example 1.4.** Let  $(X, \preceq) = (\{g, h\}, g \prec h)$ . Then

$$
E_g = g, \t E_h = h,

Let  $\omega_r := g \underbrace{h \cdots h}_{r}$ for  $r \geq 1$ . Then

$$
E_{\omega_r} = [E_{\omega_{r-1}}, E_h] = [[[g, \underbrace{h], h], \dots, h}_{r}].
$$

<span id="page-2-0"></span>**Remark 1.5.** By [\[21,](#page-25-9) Corollary 5.3.9],  $\mathbb{k}\langle X\rangle$  is a free k-module with a PBW basis  $\{E_{\alpha_1}^{n_{\alpha_1}}E_{\alpha_2}^{n_{\alpha_2}}\cdots E_{\alpha_m}^{n_{\alpha_m}}|$  $\alpha_1 \succ \alpha_2 \succ \ldots \succ \alpha_m$ ,  $\alpha_i \in \mathcal{L}$ ,  $n_{\alpha_i} \geq 0, m \geq 1$ . In order to use the Diamond Lemma [\[6\]](#page-25-10), we define a reduction order  $\prec_{red}$  for the Lyndon-Shirshov basis: for  $\alpha, \beta \in \mathcal{L}$ ,  $E_{\beta} \prec_{red} E_{\alpha}$  if  $\beta \succ \alpha$ .

<span id="page-2-2"></span>**Lemma 1.6.** [\[21,](#page-25-9) Proposition 5.1.4] Let  $\alpha \in \mathcal{L}$  and  $\text{st}(\alpha) = (\alpha_L, \alpha_R)$ . Then for any  $\zeta \in \mathcal{L}$  such that  $\alpha \prec \zeta$ , the pair  $(\alpha, \zeta) = \text{st}(\alpha \zeta)$  if and only if  $\alpha_R \succeq \zeta$ .

The following commutator lemma concerning Lyndon-Shirshov basis is the combination of Lothaire [\[21,](#page-25-9) Lemma 5.5.3], Kharchenko [\[18,](#page-25-11) Lemma 6] and Rosso [\[26,](#page-25-12) Theorem 1].

<span id="page-2-1"></span>**Lemma 1.7.** Let  $(X, \preceq)$  be a totally odered set,  $\mathcal{L}$  be the set of Lyndon words in  $\langle X \rangle$ , and  $\alpha, \beta \in \mathcal{L}$ ,  $\alpha \prec \beta$ , and st( $\alpha$ ) = ( $\alpha_L, \alpha_R$ ) if  $\alpha \in \mathcal{L} \setminus X$ . Then

- (a) If  $\alpha \in X$  or  $\alpha_R \succeq \beta$ , then  $[E_\alpha, E_\beta] = E_{\alpha\beta}$ ;
- (b) If  $\alpha_R \prec \beta$ , then there is a set  $\Gamma \subseteq \mathcal{L}$  such that  $\alpha\beta \in \Gamma$  and

(1) 
$$
[E_{\alpha}, E_{\beta}] = \sum_{\gamma \in \Gamma} k_{\gamma} E_{\gamma},
$$

where  $k_{\alpha\beta} \neq 0$ , for every  $\gamma \in \Gamma$ ,  $\gamma$  satisfies:  $k_{\gamma} \in \mathbb{Z}$ ,  $\alpha\beta \preceq \gamma \prec \beta$  and  $\gamma(x) = \alpha(x) + \gamma(x)$  $\beta(x)$  for all  $x \in X$ .

**Example 1.8.** Let  $(X, \preceq) = (\{g, h\}, g \prec h)$ . Note that  $\text{st}(ggh) = (g, gh)$ ,  $\text{st}(gggh) = (g, ggh)$  and  $ggh \prec gh \prec h$ . Thus

$$
[E_{ggh}, E_h] = [[E_g, E_{gh}], E_h] = [[E_g, E_h], E_{gh}] + [E_g, [E_{gh}, E_h]] = [E_g, E_{ghh}] = E_{gghh},
$$

[E_{gggh}, E_h] = [[E_g, E_{ggh}], E_h] = [[E_g, E_h], E_{ggh}] + [E_g, [E_{ggh}, E_h]]

= -[E_{ggh}, E_{gh}] + [E_g, E_{gghh}] = E_{ggghh} - E_{gghgh},

For more details we refer to [\[16,](#page-25-1) Section 1.2].

<span id="page-3-0"></span>**Definition 1.9.** Let  $X = \{g, h\}$ . Then in  $\mathbb{k}\langle X \rangle$ ,

$$
(g+h)^n = \sum_{i=0}^n \mathcal{SH}_{k,n-k}(h,g),
$$

where  $\mathcal{SH}_{k,n-k}(h,g)$  is the sum of words  $\alpha$  in  $(g+h)^n$  such that  $\alpha(h) = k$  and  $\alpha(g) = n - k$ , that is,  $\mathcal{SH}_{k,n-k}(h,g) = h^k \sqcup g^{n-k}$ , where  $\sqcup$  is the shuffle product (see [\[24\]](#page-25-13)). We call it the  $(k,n-k)$ -shuffle type polynomials.

**Remark 1.10.** (i) By definition,  $\mathcal{SH}_{i,j}(h,g)$  has the recursion (see also [\[23,](#page-25-0) Section 4.2]):

- (2)  $S\mathcal{H}_{i,j}(h,g) = hS\mathcal{H}_{i-1,j}(h,g) + gS\mathcal{H}_{i,j-1}(h,g),$
- <span id="page-3-1"></span>(3)  $S\mathcal{H}_{i,j}(h,g) = S\mathcal{H}_{i-1,j}(h,g)h + S\mathcal{H}_{i,j-1}(h,g)g.$

(ii) From Remark [1.5,](#page-2-0) the shuffle type polynomials can be written as linear combinations of products of the Lyndon-Shirshov basis in the lexicographic order, see [\[16,](#page-25-1) Section 2] for the details.

#### 1.2. Ore extension and GK-dimension.

We follow the definitions of [\[19,](#page-25-14) [22,](#page-25-15) [8\]](#page-25-16).

**Definition 1.11.** [\[22,](#page-25-15) Chapter 1.2.3, p.15] Let S be a ring and R a subring of S. Suppose that

- (a)  $\sigma$  is a endmorphism of R;
- (b)  $\delta$  is a  $\sigma$ -derivation of R, that is, for all  $a, b \in R$ ,

$$
\delta(ab) = \delta(a)\sigma(b) + a\delta(b);
$$

(c)  $x \in S \setminus R$ .

A ring extension  $R \subseteq S$  is called an *Ore extension* of R if  $S = R[x; \sigma, \delta]$  freely generated over R by an element  $x$  subject to the relation:

$$
ax = x\sigma(a) + \delta(a), \qquad \forall a \in R,
$$

such that  $R[x; \sigma, \delta] = \{\sum_i x^i a_i | \{a_i\} \subseteq R \text{ has finite support}\}\.$  In case  $\sigma = id$  and  $\delta \neq 0$ , then  $R[x; id, \delta]$ is written as  $R[x; \delta]$ ; if  $\delta = 0$ , then written as  $R[x; \sigma]$ .

**Definition 1.12.** [\[8,](#page-25-16) Section 2.1] Let H be a Hopf algebra over k and R a Hopf subalgebra of H. H is called a *Hopf Ore extension* (or *HOE*) of R if  $H = R[x; \sigma, \delta], \sigma$  is an automorphism and there exist  $a, b \in R$  and  $v, w \in R \otimes R$  such that

$$
\Delta_H(x) = a \otimes x + x \otimes b + v(x \otimes x) + w.
$$

**Definition 1.13.** [\[19\]](#page-25-14) Let A be a finitely generated algebra over k. Suppose that V is a finite dimensional generating subspace of A, that is,

$$
A = \bigcup_{n \in \mathbb{N}} V_n, \qquad \text{where } V_n = \mathbb{k} + V + V^2 + \ldots + V^n.
$$

Denote by  $d_V(n)$  the function dim<sub>k</sub> $(V_n)$ . The Gelfand-Kirillov dimension (or GK-dimension) of A is defined as

$$
GKdim(A) = \overline{\lim_{n \to \infty}} \log_n(d_V(n)).
$$

If a k-algebra  $B$  is not finitely generated, then we define the GK-dimension of  $B$  as

$$
GKdim(B) = \sup_{A} \{ GKdim(A) \mid A \subseteq B, A \text{ finitely generated } \}.
$$

Note that the GK-dimension of a finitely generated algebra  $A$  is independent of the particular choice of V, see [\[19,](#page-25-14) Lemma 1]. So we usually choose V such that  $1 \in V$ . Then  $V_n = V^n$ .

<span id="page-4-2"></span>**Lemma 1.14.** [\[19,](#page-25-14) Lemma 3.5] Let A be a k-algebra with a derivation  $\delta$  such that each finite dimensional subspace of A is contained in a  $\delta$ -stable finitely generated subalgebra of A. Then GKdim(A[x;  $\delta$ ]) =  $GKdim(A) + 1.$ 

<span id="page-4-3"></span>**Lemma 1.15.** [\[19,](#page-25-14) Lemma 4.3] Let A be a commutative k-algebra with a subalgebra B such that A is finitely generated as a B-module. Then  $GKdim(A) = GKdim(B)$ .

## 2. THE FREE BIALGEBRA  $\mathcal T$  and the quotient bialgebra  $\overline{\mathcal T}$

Let  $(X, \prec) := (\{g, h\}, g \prec h)$  and denote by  $\mathcal L$  the set of the Lyndon words in  $\langle X \rangle$ . We study the free bialgebra  $\mathcal{T} := \mathbb{k}\langle X \rangle$  and a quotient bialgebra  $\overline{\mathcal{T}}$ .

# 2.1. The free bialgebra  $\mathcal T$  and the noncommutative Faà di Bruno bialgebra  $\mathcal B^{\rm nc}_{\rm FdB}$ .

 $\mathcal{T} = \mathbb{k}\langle g, h \rangle$  is a free bialgebra with the counit  $\epsilon(g) = 1$ ,  $\epsilon(h) = 0$  and the coproduct  $\Delta(g) = g \otimes g$  and  $\Delta(h) = 1 \otimes h + h \otimes g.$ 

Let  $\omega_r = g \underbrace{h \cdots h}_{r}$  for  $r \ge 0$ . It is clear that  $\{E_{\alpha} | \alpha(g) = 1\} = \{E_{\omega_r} | r \ge 0\}$ . We now determine the coproduct of  $\overline{E}_{\omega_r}$  in  $\mathcal{T}$ .

**Lemma 2.1.** [\[23,](#page-25-0) 4.3] For  $n > 0$ ,

<span id="page-4-0"></span>(4) 
$$
\Delta_{\mathcal{T}}(h^n) = \sum_{k=0}^n h^k \otimes \mathcal{SH}_{n-k,k}(h,g).
$$

<span id="page-4-1"></span>**Lemma 2.2.** For  $r \geq 2$ , the following coproduct holds in  $\mathcal{T}$ :

$$
\Delta(E_{\omega_r})=g\otimes E_{\omega_r}+\sum_{\omega_r}k_{\alpha,\alpha'}E_{\alpha_1}^{a_1}E_{\alpha_2}^{a_2}\cdots E_{\alpha_m}^{a_m}\otimes E_{\alpha'_1}^{a'_1}E_{\alpha'_2}^{a'_2}\cdots E_{\alpha'_n}^{a'_n}+E_{\omega_r}\otimes g^{r+1},
$$

where  $k_{\alpha,\alpha'} \in \mathbb{Z}$ ,  $\alpha_1 \succ \alpha_2 \succ ... \succ \alpha_m$ ,  $\alpha'_1 \succ \alpha'_2 \succ ... \succ \alpha'_n$ ,  $\alpha_i, \alpha'_j \in \mathcal{L}$ ,  $a_i, a'_j \geq 1$  for  $1 \leq i \leq m$  and  $1 \leq j \leq n$ . More precisely,

- (a) If  $\alpha_1 = h$ , then  $\alpha'_1 \neq h$  and there exists some j such that  $\alpha'_j(g) \geq 2$ ;
- (b) If  $\alpha_1 \neq h$ , then  $|\alpha_1| \geq 2, \alpha_1(g) \geq 1, |\alpha'_1| \geq 2$  and  $\alpha'_1(g) \geq 1$ .

Proof. Note that

$$
\Delta(E_{ghh})=E_g\otimes E_{ghh}+3E_{gh}\otimes E_{gh}E_g+(-E_hE_g+E_{gh})\otimes E_{ggh}+E_{ghh}\otimes E_g^3.
$$

Thus Parts (a) and (b) hold for  $E_{\omega_2}$ . For convenience, we assume  $k_{\alpha,\alpha'} = 1$ . By induction on r,

$$
\Delta(E_{\omega_r+1}) = \Delta([E_{\omega_r}, h])
$$
  
\n
$$
= (g \otimes E_{\omega_r} + \sum_{\omega_r} E_{\alpha_1}^{a_1} E_{\alpha_2}^{a_2} \cdots E_{\alpha_m}^{a_m} \otimes E_{\alpha_1'}^{a_1'} E_{\alpha_2'}^{a_2'} \cdots E_{\alpha_n'}^{a_n'} + E_{\alpha} \otimes g^{r+1})(1 \otimes h + h \otimes g)
$$
  
\n
$$
- (1 \otimes h + h \otimes g)(g \otimes E_{\omega_r} + \sum_{\omega_r} E_{\alpha_1}^{a_1} E_{\alpha_2}^{a_2} \cdots E_{\alpha_m}^{a_m} \otimes E_{\alpha_1'}^{a_1'} E_{\alpha_2'}^{a_2'} \cdots E_{\alpha_n'}^{a_n'} + E_{\omega_r} \otimes g^{r+1})
$$
  
\n
$$
= g \otimes E_{\omega_{r+1}} + E_{gh} \otimes E_{\omega_r} g - hg \otimes E_{g\omega_r} + E_{\omega_r} \otimes \sum_{k=1}^{r+1} {r+1 \choose k} E_{g} \cdots g_h g^{r+1-k}
$$
  
\n
$$
+ E_{\omega_{r+1}} \otimes g^{r+2} + \sum_{\omega_r} F_{\mathbf{L}} \otimes (F_{\mathbf{R}} h - hF_{\mathbf{R}}) + \sum_{\omega_r} F_{\mathbf{L}} h \otimes F_{\mathbf{R}} g - hF_{\mathbf{L}} \otimes gF_{\mathbf{R}},
$$

where  $F_L := E_{\alpha_1}^{a_1} E_{\alpha_2}^{a_2} \cdots E_{\alpha_m}^{a_m}$  and  $F_R := E_{\alpha_1'}^{a_1'} E_{\alpha_2'}^{a_2'} \cdots E_{\alpha_n'}^{a_n'}$ . To show Part (a) and Part (b) hold for  $T_1 := F_L \otimes (F_R h - hF_R)$  and  $T_2 := F_L h \otimes F_R g - hF_L \otimes gF_R$ , we consider two cases of  $F_L \otimes F_R$  in  $\Delta(E_{\omega_{r+1}})$ :

Case 1:  $\alpha_1 = h$  in  $F_L \otimes F_R$ . By induction on  $r + 1$ , there exists some j such that  $\alpha'_j(g) \geq 2$  and  $\alpha'_1 \neq h$ . By Lemma [1.7](#page-2-1) and [\[16,](#page-25-1) Corollary 1.9 (d)], there exists a set  $\Gamma \subseteq \mathcal{L}$  such that  $F_R h =$  $\bar{h}F_{\rm R}+\sum_{\gamma\in\Gamma}k_{\gamma}E_{\alpha_1'}^{a_1'}\cdots E_{\alpha_\ell'}^{a_\ell'}E_{\gamma}E_{\alpha_{\ell+1}'}^{c_{\ell+1}}$  $c_{\ell+1}^{c_{\ell+1}} \cdots E_{\alpha'_n}^{c_n}$ , where for every  $\gamma \in \Gamma$  there exists some  $\ell$  such that  $\alpha'_{\ell} \succeq$  $\gamma \succ \alpha'_{\ell+1}, 0 \leq c_s \leq a_s, \ell+1 \leq s \leq n, \sum_{s=\ell+1}^n (a_s' - c_s) > 0 \text{ and } \gamma(x) = h(x) + \sum_{s=\ell+1}^n (a_s' - c_s) \alpha_s'(x)$ for all  $x \in X$ . Then  $\gamma(g) = \sum_{s=\ell+1}^n (a_s' - c_s) \alpha_s'(g)$ , which means  $\alpha_j'(g) \ge 2$  or  $\gamma(g) \ge 2$ . Thus Part (a) holds for  $T_1$ . Similarly, Part (a) holds for  $T_2$  from Lemma [1.7](#page-2-1) and [\[16,](#page-25-1) Corollary 1.9 (c)-(d)].

Case 2:  $\alpha_1 \neq h$  in  $F_L \otimes F_R$ . The rest is similar to the proof of Case 1.

Now we show that the noncommutative Faà di Bruno bialgebra is a sub-bialgebra of  $\mathcal T$ . Following [\[7,](#page-25-4) Remark 2.1 and [\[13,](#page-25-17) Section 3.2.6], we first recall the Faà di Bruno bialgebra or Hopf algebra, see also [\[12,](#page-25-5) [17\]](#page-25-6) and [\[14,](#page-25-18) Section 2].

**Definition 2.3.** [\[12,](#page-25-5) [17\]](#page-25-6) The Faà di Bruno bialgebra  $\mathcal{B}_{\text{FdB}}$  as an algebra is defined to be the polynomial algebra  $\mathbb{k}[u_1, u_2, \dots, u_n, \dots]$  in infinitely many variables  $\{u_n\}_{n=1}^{\infty}$ , with the counit  $\epsilon(u_n) = \delta_{n,1}$  and the coproduct

$$
\Delta(u_n)=\sum_{k=1}^n u_k\otimes B_{n,k}(u_1,u_2,\ldots,u_n),
$$

where  $B_{n,k}(u_1, u_2, \ldots, u_n)$  is the classical partial Bell polynomial, that is,

<span id="page-5-0"></span>(5) 
$$
B_{n,k}(u_1, u_2, \ldots, u_n) = \sum_{\substack{k_1+k_2+\ldots+k_n=k\\k_1+2k_2+\ldots+nk_n=n}} \frac{n!}{k_1!k_2!\ldots k_n!} \left(\frac{u_1}{1!}\right)^{k_1} \left(\frac{u_2}{2!}\right)^{k_2} \ldots \left(\frac{u_n}{n!}\right)^{k_n}.
$$

The Faà di Bruno Hopf algebra is  $\mathcal{H}_{\text{FdB}} = \mathbb{k}[u_1^{\pm 1}, u_2, \dots, u_n, \dots]$  satisfying the hypothesis of  $\mathcal{B}_{\text{FdB}}$  and  $\Delta(u_1^{-1}) = u_1^{-1} \otimes u_1^{-1}$ , see also [\[17,](#page-25-6) Section IX].

The Bell polynomials mentioned in above definition were introduced by Bell from the set partitions, see  $[4, 5]$  $[4, 5]$ . Now we recall the noncommutative Faà di Bruno bialgebra.

**Definition 2.4.** [\[7,](#page-25-4) Definition 2.4]. The *noncommutative Fa* $\dot{a}$  di Bruno bialgebra is defined on the free algebra  $\mathcal{B}_{\text{FdB}}^{\text{nc}} = \mathbb{k} \langle a_0, a_1, \ldots, a_n, \ldots \rangle$ , with the counit  $\epsilon(a_n) = \delta_{n,0}$  and the coproduct

$$
\Delta(a_n) = \sum_{k=0}^n a_k \otimes \sum_{\substack{i_0 + i_1 + \dots + i_k = n - k, \\ i_0, i_1, \dots, i_k \ge 0}} a_{i_0} a_{i_1} \cdots a_{i_k}.
$$

<span id="page-6-4"></span>**Remark 2.5.**  $\mathcal{B}_{\text{FdB}}$  (resp.  $\mathcal{B}_{\text{FdB}}^{\text{nc}}$ ) is an N-graded bialgebra, with  $\text{deg}(u_n) = n - 1$  for  $n \ge 1$  (resp.  $deg(a_n) = n$  for  $n \ge 0$ ). Thus  $\mathcal{B}_{FdB}^{nc}$  and  $\mathcal{B}_{FdB}^{nc}$  are pointed by [\[25,](#page-25-21) Proposition 4.1.2]. In case char  $k = 0$ , then the abelianization of  $\mathcal{B}_{\text{FdB}}^{\text{nc}}$  is  $\mathcal{B}_{\text{FdB}}$ , that is, there is an isomorphism of bialgebras

$$
f: \mathcal{B}^{\text{nc}}_{\text{FdB}}/[B^{\text{nc}}_{\text{FdB}}, \mathcal{B}^{\text{nc}}_{\text{FdB}}] \to \mathcal{B}_{\text{FdB}}, \qquad a_n \mapsto \frac{u_{n+1}}{(n+1)!}, \qquad n \ge 0,
$$

see [\[7,](#page-25-4) Remark 2.12].

Let L be the subalgebra of  $\mathcal T$  generated by  $\{\omega_n \mid n \geq 0\}.$ 

<span id="page-6-1"></span>**Lemma 2.6.** L is a sub-bialgebra of  $\mathcal{T}$ .

Proof. By Formula [\(4\)](#page-4-0) we have

$$
\Delta(\omega_n) = \sum_{k=0}^n \omega_k \otimes g\mathcal{SH}_{n-k,k}(h,g), \quad n \ge 0.
$$

By Formula [\(3\)](#page-3-1),  $g\mathcal{SH}_{n-k,k}(h,g) \in L$  for all  $0 \leq k \leq n$ . Thus  $\Delta(L) \subseteq L \otimes L$ , as desired

<span id="page-6-0"></span>**Theorem 2.7.** As bialgebras,  $L \cong \mathcal{B}_{\text{FdB}}^{\text{nc}}$ . Thus,  $\mathcal{B}_{\text{FdB}}^{\text{nc}}$  is a sub-bialgebra of  $\mathcal{T}$ .

*Proof.* Note that  $\{\omega_n \mid n \geq 0\}$  is algebraically independent over k. Thus L is a free bialgebra by Lemma [2.6.](#page-6-1) Then, the assignment  $\varphi : \omega_n \mapsto a_n$ ,  $n \geq 0$  gives rise to an isomorphism of algebras  $\varphi$  from L to  $\mathcal{B}^{\text{nc}}_{\text{FdB}}$ . To show that  $\varphi$  is a morphism of coalgebras, it suffices to verify that

<span id="page-6-2"></span>(6) 
$$
g\mathcal{SH}_{n-k,k}(h,g)=\sum_{\substack{i_0+i_1+\ldots+i_k=n-k,\\i_0,i_1,\ldots,i_k\geq 0}}\omega_{i_0}\omega_{i_1}\cdots\omega_{i_k}, \quad 0\leq k\leq n.
$$

It follows from [\[16,](#page-25-1) Theorem 5.9], as desired.  $\square$ 

**Remark 2.8.** We consider a general construction of Hopf algebras containing L (or  $\mathcal{B}_{\text{FdB}}^{\text{nc}}$ ) as subbialgebra, using these Lyndon words  $\{\omega_n | n \geq 0\}$ . Let  $r \geq 1$  and  $\mathcal{T}^{[r]}$  the free algebra generated by  ${g,h}$ . It is clear that  $\mathcal{T}^{[r]}$  is a bialgebra with coproduct and counit:

$$
\Delta(g) = g \otimes g, \qquad \Delta(h) = 1 \otimes h + h \otimes g^r, \qquad \epsilon(g) = 1, \qquad \epsilon(h) = 0.
$$

From the proof of Lemma [2.6](#page-6-1) and Theorem [2.7,](#page-6-0) the subalgebra  $L^{[r]}$  of  $\mathcal{T}^{[r]}$  generated by  $\{\omega_n | n \geq 0\}$ is an N-graded, free, pointed bialgebra, with the degree of  $\omega_n$  defined by n. The coproduct is given by the recursion

$$
\Delta(\omega_n) = (g \otimes g)(1 \otimes h + h \otimes g^r)^n, \quad n \ge 0,
$$

or equivalently, by Formula [\(6\)](#page-6-2),

<span id="page-6-3"></span>(7) 
$$
\Delta(\omega_n) = \sum_{k=0}^n \omega_k \otimes \sum_{\substack{i_0 + \ldots + i_k = n-k, \\ i_0, \ldots, i_k \ge 0}} \omega_{i_0} \omega_0^{r-1} \omega_{i_1} \cdots \omega_{i_s} \omega_0^{r-1} \omega_{i_{s+1}} \cdots \omega_{i_{k-1}} \omega_0^{r-1} \omega_{i_k}, \quad n \ge 0.
$$

It is clear that  $L^{[1]} = L$ . Furthermore, by Formula [\(7\)](#page-6-3), the subalgebra of  $L^{[r]}$  generated by  $\{\omega_0^{r-1}\omega_n\}_{n \geq 0}$ 0} is a free bialgebra. Thus L (or  $\mathcal{B}_{\text{FdB}}^{\text{nc}}$ ) is isomorphic to a sub-bialgebra of  $L^{[r]}$ , with the embedding:

$$
L \hookrightarrow L^{[r]}, \ \omega_n \mapsto \omega_0^{r-1} \omega_n, \quad n \ge 0.
$$

## 2.2. The bialgebra  $\overline{\mathcal{T}}$  and the Faà di Bruno bialgebra  $\mathcal{B}_{\text{FdB}}$ .

Let  $\overline{\mathcal{T}} := \mathcal{T}/\mathcal{I}$ , where  $\mathcal{I}$  is the ideal of  $\mathcal{T}$  generated by  $\{E_{\alpha} | \alpha(g) \geq 2, \alpha \in \mathcal{L}\}\)$ . We show that  $\overline{\mathcal{T}}$  admits a bialgebra structure.

<span id="page-7-0"></span>**Lemma 2.9.** Let  $\mathcal{I}_1$ ,  $\mathcal{I}_2$  be the ideals of  $\mathcal{T}$  generated by  $\{E_{\omega_s}E_{\omega_t} - E_{\omega_t}E_{\omega_s} | 0 \le s < t\}$  and  $\{gE_{\omega_n} - g\}$  $E_{\omega_n} g | n \geq 1$  respectively. Then  $\mathcal{I} = \mathcal{I}_1 = \mathcal{I}_2$ .

*Proof.* Note that  $g = E_{\omega_0}$ . By Lemma [1.7,](#page-2-1) it is easy to see  $\mathcal{I}_2 \subseteq \mathcal{I}_1 \subseteq \mathcal{I}$ .

First we show  $\mathcal{I} \subseteq \mathcal{I}_1$ . Let  $E_\alpha = [E_\beta, E_\gamma] \in \mathcal{I}$  such that  $\text{st}(\alpha) = (\beta, \gamma)$ . If  $\gamma(g) = 0$ , then  $\gamma = h$ . By Lemma [1.6](#page-2-2) we have  $\beta_R \succeq \gamma$ . Hence  $\beta_R = h$ . Similarly, for  $E_{\beta_L}$ , since  $\beta_R(g) = 0$  it follows that  $(\beta_L)_R = h$ . Since  $|\beta|$  is finite,  $\beta = \omega_{|\beta|-1}$  by induction on the terms  $E_{(\beta_L)_L}, \ldots, E_{(\ldots((\beta_L)_L), \ldots)_L}$ . Thus, if  $\alpha(g) = 2$ , then it must have  $\beta(g) = \gamma(g) = 1$ . Hence  $E_{\alpha} \in \mathcal{I}_1$ . If  $\alpha(g) > 2$ , then  $\gamma(g) < \alpha(g)$  because  $\beta(g) \geq 1$ . By induction on  $\alpha(g)$ ,  $E_\gamma \in \mathcal{I}_1$  implies that  $E_\alpha \in \mathcal{I}_1$ . Therefore  $\mathcal{I} = \mathcal{I}_1$ .

Next we show  $\mathcal{I}_1 \subseteq \mathcal{I}_2$ . Let  $[E_{\omega_s}, E_{\omega_t}] \in \mathcal{I}_1$ . If  $s = 1$ , then  $[E_{gh}, E_{\omega_t}] = [[g, E_{\omega_t}], h] - [g, E_{\omega_{t+1}}] \in \mathcal{I}_2$ . If  $s \geq 2$ , then  $[E_{\omega_s}, E_{\omega_t}] = [[E_{\omega_{s-1}}, E_{\omega_t}], h] - [E_{\omega_{s-1}}, E_{\omega_{t+1}}]$ . Thus  $[E_{\omega_s}, E_{\omega_t}] \in \mathcal{I}_2$  by induction on s. Therefore  $\mathcal{I}_1 = \mathcal{I}_2$ .

<span id="page-7-2"></span>**Theorem 2.10.**  $\overline{\mathcal{T}}$  is a pointed bialgebra.

*Proof.* By Lemma [2.9](#page-7-0) and [\[25,](#page-25-21) Corollary 5.1.14], it suffices to show that  $\mathcal{I}_2$  is a coideal. It is clear that  $\epsilon(\mathcal{T}_2) = 0$ . Now we show that  $\Delta_{\mathcal{T}}(\mathcal{I}_2) \in \mathcal{T} \otimes \mathcal{I}_2 + \mathcal{I}_2 \otimes \mathcal{T}$ .

Let  $[g, E_{\omega_{\ell}}] \in \mathcal{I}_2$ . If  $\ell = 1$ , then  $\Delta([g, E_{gh}]) = g^2 \otimes [g, E_{gh}] + [g, E_{gh}] \otimes g^3 \in \mathcal{T} \otimes \mathcal{I}_2 + \mathcal{I}_2 \otimes \mathcal{T}$ . If  $\ell \geq 2$ , then

$$
\Delta([g, E_{\omega_{\ell}}]) = [g \otimes g, g \otimes E_{\omega_{\ell}} + \sum_{\omega_{\ell}} F_{\mathcal{L}} \otimes F_{\mathcal{R}} + E_{\omega_{\ell}} \otimes g^{|\omega_{\ell}|}]
$$
  

$$
= g^2 \otimes E_{g\omega_{\ell}} + E_{g\omega_{\ell}} \otimes g^{|\omega_{\ell}|+1} + \sum_{\omega_{\ell}} (gF_{\mathcal{L}} \otimes gF_{\mathcal{R}} - F_{\mathcal{L}}g \otimes F_{\mathcal{R}}g),
$$

where  $F_L := E_{\alpha_1}^{a_1} E_{\alpha_2}^{a_2} \cdots E_{\alpha_m}^{a_m}$  and  $F_R := E_{\alpha_1'}^{a_1'} E_{\alpha_2'}^{a_2'} \cdots E_{\alpha_n'}^{a_n'}$ . By Lemma [2.2](#page-4-1) and [\[16,](#page-25-1) Corollary 1.9 (c)], we have

$$
gF_{\rm L}\otimes gF_{\rm R}-F_{\rm L}g\otimes F_{\rm R}g\in (F_{\rm L}g+\mathcal{I})\otimes (F_{\rm R}g+\mathcal{I})-F_{\rm L}g\otimes F_{\rm R}g
$$

$$
\subseteq \mathcal{T}\otimes\mathcal{I}+\mathcal{I}\otimes\mathcal{T}=\mathcal{T}\otimes\mathcal{I}_2+\mathcal{I}_2\otimes\mathcal{T}.
$$

Let  $\pi: \mathcal{T} \to \overline{\mathcal{T}}$  be the projection. Now we determine the coproduct of  $\pi(E_{\omega_k})$  in  $\overline{\mathcal{T}}$ . **Corollary 2.11.** The following holds for  $k \geq 0$  in  $\overline{T}$ :

$$
\Delta_{\overline{\mathcal{T}}}(\pi(E_{\omega_k})) = \sum_{r=0}^k \pi(E_{\omega_r}) \otimes \pi(\mathcal{SH}'_{k-r,r+1}),
$$



where  $\mathcal{SH}'_{k-r,r+1}$  is the sum of the terms in  $\mathcal{SH}_{k-r,r+1}$  (Lyndon-Shirshov basis form) of which the leftmost element is not  $E_h$ , and

<span id="page-8-0"></span>
$$
(9) \quad \pi(\mathcal{SH}_{k-r,r+1}') = \sum_{\substack{t_1+t_2+\cdots+(k+1)t_{k+1}=k+1\\t_1+t_2+\cdots+t_{k+1}=r+1}}\frac{(k+1)!}{t_1!t_2!\cdots t_{k+1}!} \left(\frac{\pi(g)}{1!}\right)^{t_1} \left(\frac{\pi(E_{\omega_1})}{2!}\right)^{t_2} \cdots \left(\frac{\pi(E_{\omega_k})}{(k+1)!}\right)^{t_{k+1}}.
$$

*Proof.* From [\[16,](#page-25-1) Corollary 2.2] and [16, Corollary 2.3 (a)],  $\mathcal{SH}'_{m,1} = E_{\omega_m}$  for  $m \geq 0$ . Then  $\Delta(\pi(g)) =$  $\pi(g)\otimes \pi(g)\,=\, \pi(g)\otimes \pi(\mathcal{SH}_{0,1}')\,\,\text{and}\,\, \Delta(\pi(E_{gh}))\,=\, (\pi\otimes \pi)(g\otimes E_{gh} \,+\, E_{gh}\otimes g^2)\,=\, \sum_{r=0}^1 \pi(E_{\omega_r})\otimes$  $\pi(\mathcal{SH}'_{1-r,r+1})$ . By Lemma [2.9](#page-7-0) and the induction on k, we have:

$$
\Delta(\pi(E_{\omega_k})) = \Delta(\pi(E_{\omega_{k-1}}))\Delta(\pi(h)) - \Delta(\pi(h))\Delta(E_{\omega_{k-1}})
$$
  
\n
$$
= \sum_{r=0}^{k-1} \pi(E_{\omega_r}) \otimes (\pi(S\mathcal{H}'_{k-1-r,r+1})\pi(h) - \pi(h)\pi(S\mathcal{H}'_{k-1-r,r+1}))
$$
  
\n
$$
+ \pi(E_{\omega_r})\pi(h) \otimes \pi(S\mathcal{H}'_{k-1-r,r+1})\pi(g) - \pi(h)\pi(E_{\omega_r}) \otimes \pi(g)\pi(S\mathcal{H}'_{k-1-r,r+1})
$$
  
\n
$$
= \pi(g) \otimes \pi([S\mathcal{H}'_{k-1,1}, h]) + \sum_{r=1}^{k-1} \pi(E_{\omega_r}) \otimes \pi([S\mathcal{H}'_{k-1-r,r+1}, h]) +
$$
  
\n
$$
\sum_{r=0}^{k-1} (\pi(h)\pi(E_{\omega_r}) + \pi(E_{\omega_{r+1}})) \otimes \pi(S\mathcal{H}'_{k-1-r,r+1})\pi(g) - \pi(h)\pi(E_{\omega_r}) \otimes \pi(S\mathcal{H}'_{k-1-r,r+1})\pi(g)
$$
  
\n
$$
= \pi(g) \otimes \pi(E_{\omega_k}) + \pi(E_{\omega_k}) \otimes \pi(g)^{k+1} + \sum_{r=1}^{k-1} \pi(E_{\omega_r}) \otimes \pi([S\mathcal{H}'_{k-1-r,r+1}, h] + S\mathcal{H}'_{k-r,r}g)
$$
  
\n
$$
= \sum_{r=0}^{k} \pi(E_{\omega_r}) \otimes \pi(S\mathcal{H}'_{k-r,r+1}),
$$

where  $[\mathcal{SH}_{k-1,1}^{\prime}, h] = E_{\omega_k}$  since  $\mathcal{SH}_{k-1,1}^{\prime} = E_{\omega_{k-1}}$ , and the recursion  $[\mathcal{SH}_{k-1-r,r+1}^{\prime}, h] + \mathcal{SH}_{k-r,r}^{\prime} g =$  $\mathcal{SH}_{k-r,r+1}'$  follows from [\[16,](#page-25-1) Formula (37)]. The formula [\(9\)](#page-8-0) follows from [16, Corollary 2.2] and [16, Corollary 2.3 (a).

#### <span id="page-8-1"></span>Remark 2.12.

- (i)  $\pi(\mathcal{SH}'_{k-r,r+1})$  is the Bell polynomial [\(5\)](#page-5-0). Furthermore,  $\mathcal{SH}'_{k-r,r+1}$  is the dual Bell differential polynomial  $\widehat{B}_{k+1,r+1}^*(E_h, E_g)$  introduced by Schimming–Rida [\[27\]](#page-25-22) for a general noncommutative binomial formula, see [\[16,](#page-25-1) Theorem 4.5 (b)] for the details. Therefore, [\(8\)](#page-7-1) can be derived from the recursion of the dual Bell polynomials. We just give an approach using the shuffle type polynomials.
- (ii) By the recursion of  $\mathcal{SH}'_{k-r,r+1}$  (or  $\widehat{B}^*_{k+1,r+1}$ ), Formula [\(8\)](#page-7-1) has the recursion:

$$
\Delta(\pi(E_{\omega_k})) = (\mathrm{id} \otimes \mathrm{ad}_r \, \pi(h) + \mathrm{ad}_r \, \pi(h) \otimes \pi(g))^k (\pi(g) \otimes \pi(g)), \quad k \geq 0.
$$

To simplify the notation, we will use  $\mathcal{E}_{\omega_k}$  (resp. h, g) in T instead of  $\pi(E_{\omega_k})$  (resp.  $\pi(h), \pi(g)$ ).

Corollary 2.13. Let  $char \mathbb{R} = p > 0$ . Then

<span id="page-8-2"></span>(10) 
$$
\Delta_{\overline{\mathcal{T}}}(h^p) = 1 \otimes h^p + h \otimes \mathcal{E}_{\omega_{p-1}} + h^p \otimes g^p.
$$

*Proof.* It follows from Formula [\(4\)](#page-4-0) and [\[16,](#page-25-1) Corollary 2.3 (c)].

<span id="page-9-2"></span>**Theorem 2.14.**  $\overline{T}$  has subexponential growth (infinite GK-dimension) with a PBW basis

$$
h^{n_2} \mathcal{E}_{\omega_{k_1}}^{n_{\omega_{k_1}}} \cdots \mathcal{E}_{\omega_{k_m}}^{n_{\omega_{k_m}}} | k_1 > \ldots > k_m \ge 0, \ n_{\omega_{k_i}}, n_2 \in \mathbb{N}, \ 1 \le i \le m \}
$$

satisfying the relations:

{

$$
\mathcal{E}_{\omega_s}h=h\mathcal{E}_{\omega_s}+\mathcal{E}_{\omega_{s+1}},\quad \mathcal{E}_{\omega_s}\mathcal{E}_{\omega_t}=\mathcal{E}_{\omega_t}\mathcal{E}_{\omega_s},\quad 0\leq s
$$

Proof. By Lemmma [2.9,](#page-7-0) the relations hold. By [\[29,](#page-25-23) Section 8] (see also [\[19,](#page-25-14) Example 1.3, Section 12.1]),  $\overline{\mathcal{T}}$  has subexponential growth. Applying the Diamond Lemma [\[6\]](#page-25-10) to the order: $\prec_{red}: h \prec_{red}$ ...  $\prec_{red} \mathcal{E}_{\omega_k} \prec_{red} \ldots \prec_{red} \mathcal{E}_{gh} \prec_{red} g$ , we just need to show that the following overlap ambiguities are resolvable: for all  $0 \leq r < s < t$ :

$$
(\mathcal{E}_{\omega_r}\mathcal{E}_{\omega_s})\mathcal{E}_{\omega_t}=\mathcal{E}_{\omega_r}(\mathcal{E}_{\omega_s}\mathcal{E}_{\omega_t}),
$$

<span id="page-9-1"></span>(12) 
$$
(\mathcal{E}_{\omega_r}\mathcal{E}_{\omega_s})h=\mathcal{E}_{\omega_r}(\mathcal{E}_{\omega_s}h).
$$

It is clear that overlap [\(11\)](#page-9-0) is resolvable. By direct computations, the two sides of [\(12\)](#page-9-1) can be reduced to the same expression  $h\mathcal{E}_{\omega_{s}}\mathcal{E}_{\omega_{r}} + \mathcal{E}_{\omega_{s+1}}\mathcal{E}_{\omega_{r}} + \mathcal{E}_{\omega_{s}}\mathcal{E}_{\omega_{r+1}}$ . So it is resolvable.

<span id="page-9-5"></span>**Proposition 2.15.**  $\overline{\mathcal{T}} := \bigoplus_{n=0}^{\infty} \overline{\mathcal{T}}(n)$  is an N-graded pointed bialgebra, where

$$
\overline{\mathcal{T}}(n) := \bigoplus_{\substack{r+k_{m}sm+\ldots+k_1s_1=n\\k_m>\ldots>k_1\geq 0}} h^r \mathcal{E}^{s_m}_{\omega_{k_m}}\cdots \mathcal{E}^{s_1}_{\omega_{k_1}}.
$$

*Proof.* By Theorem [2.10](#page-7-2) it suffices to show that  $\overline{\mathcal{T}}$  is N-graded. Observe that  $q \in \overline{\mathcal{T}}(0)$ ,  $h \in \overline{\mathcal{T}}(1)$ . Then  $\mathcal{E}_{\omega_k} \in \overline{\mathcal{T}}(k)$  for all  $k \geq 0$ . By Theorem [2.14,](#page-9-2)  $\overline{\mathcal{T}}(n)\overline{\mathcal{T}}(m) \subseteq \overline{\mathcal{T}}(n+m)$ . By Corollary [2.11,](#page-7-3)  $\Delta(\overline{\mathcal{T}}(n)) \subseteq \sum_{k=0}^n \overline{\mathcal{T}}(k) \otimes \overline{\mathcal{T}}(n-k)$ , as desired.

Now we show that  $\overline{\mathcal{T}}$  is an Ore extension of the Faà di Bruno bialgebra  $\mathcal{B}_{FdB}$ . Let R be the subalgebra of  $\mathcal T$  generated by  $\{\mathcal{E}_{\omega_n} | n \geq 0\}.$ 

<span id="page-9-3"></span>Lemma 2.16. The following hold:

- (a) R is a commutative sub-bialgebra of  $\overline{\mathcal{T}}$ ;
- (b)  $\overline{\mathcal{T}}$  is an Ore extension of R. Namely,  $\overline{\mathcal{T}} = R[h; \text{ad}_r h],$  where  $\text{ad}_r h(a) := [a, h]$  for  $a \in R$ .

*Proof.* By Formula [\(8\)](#page-7-1) and Theorem [2.14,](#page-9-2) R is a commutative bialgebra and  $\mathcal{E}_{\omega_k} h = h\mathcal{E}_{\omega_k} + [\mathcal{E}_{\omega_k}, h]$ . On the other hand,  $ad_r h$  is a derivation of R and  $\overline{\mathcal{T}}$  is generated by R and h. Therefore,  $\overline{\mathcal{T}}$  =  $R[h; \text{ad}_r h].$ 

<span id="page-9-4"></span>**Lemma 2.17.** Assume that char  $\mathbb{k} = 0$ . Then R is a maximal commutative subalgebra of  $\overline{T}$ , hence a maximal commutative sub-bialgebra of  $\mathcal T$ .

*Proof.* By Lemma [2.16](#page-9-3) (a), R is commutative sub-bialgebra. Suppose that there is a commutative subalgebra D such that  $R \subsetneq D \subsetneq \overline{\mathcal{T}}$ . By Lemma [2.16](#page-9-3) (b),  $d = \sum_{j=0}^{n} h^j r_j \in D$  for some  $r_j \in R$ ,  $0 \leq j \leq n$ , and  $r_n \neq 0$ . Note that there holds in  $\mathcal{T}$ :

<span id="page-9-6"></span>(13) 
$$
[E_{\omega_i}, h^j] = \sum_{k=1}^j {j \choose k} h^{j-k} E_{\omega_{i+k}}, \quad j \ge 1, \ i \ge 0.
$$

Since  $[g, r_0] = 0$  and  $r_n \neq 0$ , it follows that  $[g, d] = [\mathcal{E}_{\omega_0}, d] = \binom{n}{1}$  $\sum_{j=0}^{n} h^{j} s_j \neq 0$ , where  $s_0, \ldots, s_{n-2} \in R$ . However,  $[g, d] = 0$  since D is commutative, a contradiction. Consequently, R is a maximal commutative sub-bialgebra of  $\mathcal T$ .

<span id="page-10-1"></span>**Lemma 2.18.** As bialgebras,  $R ≅ B<sub>FdB</sub>$ .

*Proof.* Note that R and  $\mathcal{B}_{\text{FdB}}$  are commutative. Then there is an algebra isomorphism:

$$
\phi: \mathcal{B}_{\text{FdB}} \mapsto R, \qquad u_{n+1} \mapsto \mathcal{E}_{\omega_n}, \quad n \ge 0.
$$

By Corollary [8](#page-7-1) and Theorem [2.14,](#page-9-2)  $\phi$  is a bialgebra map. Consequently,  $R \cong \mathcal{B}_{\text{FdB}}$  as bialgebras.  $\Box$ 

<span id="page-10-0"></span>**Theorem 2.19.**  $\overline{\mathcal{T}}$  is an Ore extension of the Faà di Bruno bialgebra  $\mathcal{B}_{FdB}$ . If char  $k = 0$ , then  $\mathcal{B}_{FdB}$ is a maximal commutative sub-bialgebra of  $\overline{\mathcal{T}}$ .

*Proof.* It follows directly from Lemmas [2.16,](#page-9-3) [2.17](#page-9-4) and [2.18.](#page-10-1)

### Remark 2.20.

- (i)  $\overline{\mathcal{T}}$  does not admit a Hopf algebra structure. Consider the localization  $\overline{\mathcal{T}}_{\pm 1}$  at g with  $\Delta(\frac{1}{g})$  $\frac{1}{g}\otimes \frac{1}{g}$  $\frac{1}{g}$ , it is clear that  $\mathcal{T}_{\pm 1}$  admits a Hopf algebra structure by [\[30,](#page-26-0) Remark 36], see also [\[17,](#page-25-6) Section IX]. Furthermore,  $\overline{\mathcal{T}}_{\pm 1}$  is a HOE of  $\mathcal{H}_{\text{FdB}}$ .
- (ii) More generally, using the Lyndon-Shirshov basis we can consider a Hopf algebra which contains  $\overline{\mathcal{T}}_{\pm 1}$ . Let  $r \geq 1$  and  $\mathcal{T}_{\pm 1}^{[r]}$  $\pm$ <sup>1</sup><sup>r</sup> be the free algebra generated by  $\{g, g^{-1}, h\}$  over k. It is clear that  $\mathcal{T}^{[r]}_{+1}$  $\pm$ <sup>1</sup><sup>T</sup>] is a bialgebra with the coproduct and counit:

$$
\Delta(g^{\pm 1}) = g^{\pm 1} \otimes g^{\pm 1}, \qquad \Delta(h) = 1 \otimes h + h \otimes g^r, \qquad \epsilon(g^{\pm 1}) = 1, \qquad \epsilon(h) = 0.
$$

By Lemma [2.9](#page-7-0) and the proof of Theorem [2.10,](#page-7-2)

$$
\overline{\mathcal{T}_{\pm 1}^{[r]}} := \mathcal{T}_{\pm 1}^{[r]}/(gg^{-1} - 1, \ g^{-1}g - 1, \ E_{\alpha} | \alpha(g) \ge 2)
$$

is an N-graded pointed Hopf algebra, with a PBW basis

$$
\{\overline{h}^{n_2}\overline{E}_{\omega_{k_1}}^{n_{\omega_{k_1}}}\cdots\overline{E}_{\omega_{k_m}}^{n_{\omega_{k_m}}}g^{n_1}|k_1>\ldots>k_m\geq 1,\ n_1\in\mathbb{Z},\ n_2,n_{\omega_{k_i}}\in\mathbb{N},\ 1\leq i\leq m\}
$$

satisfying the relations:

$$
\overline{g} \ \overline{g}^{-1} = \overline{g}^{-1} \overline{g} = 1, \qquad \overline{E}_{\omega_s} \overline{h} = \overline{h} \ \overline{E}_{\omega_s} + \overline{E_{\omega_{s+1}}}, \qquad \overline{E_{\omega_s}} \ \overline{E_{\omega_t}} = \overline{E_{\omega_t}} \ \overline{E_{\omega_s}},
$$

where  $0 \leq s < t$ . Similar to Remark [2.12](#page-8-1) (ii), the coproduct of  $\mathcal{T}_{+1}^{[r]}$  $\pm 1$  is given by the recursion:

$$
\Delta(\overline{E_{\omega_k}}) = (id \otimes \mathrm{ad}_r \overline{h} + \mathrm{ad}_r \overline{h} \otimes \overline{g}^r)^k (\overline{g} \otimes \overline{g}), \quad k \ge 0.
$$

Evidently,  $\mathcal{T}_{+1}^{[1]}$  $\overline{\mathcal{T}}_{\pm 1}^{[1]} \cong \overline{\mathcal{T}}_{\pm 1}$ . Furthermore,  $\overline{\mathcal{T}}_{\pm 1}$  is isomorphic to a Hopf subalgebra  $\mathcal{T}_{\pm 1}^{[r]}$  $\mathcal{L}_{\pm 1}^{[r]}$ , with the embedding:

$$
\overline{\mathcal{T}}_{\pm 1} \hookrightarrow \overline{\mathcal{T}}_{\pm 1}^{[r]}, \ g \mapsto \overline{g}^r, \ h \mapsto \overline{h}, \quad r \ge 0.
$$

There are some interesting results about  $\mathcal{T}_{+1}^{[r]}$  $\pm 1$ , but we will discuss them elsewhere.

# 2.3. The bialgebra  $\mathcal{B}_F$  and the Faà di Bruno bialgebras  $\mathcal{B}_{\rm FdB},\mathcal{B}^{\rm nc}_{\rm FdB}.$

Recall that  $\varphi : \mathcal{B}_{\text{FdB}}^{\text{nc}} \to L$  is an isomorphism of bialgebras in Theorem [2.7](#page-6-0) and  $\pi : \mathcal{T} \to \overline{\mathcal{T}}$  is the projection. Then we obtain the following bialgebra map.

Corollary 2.21.  $\phi := \pi \circ \iota \circ \varphi^{-1} : \mathcal{B}_{\text{FdB}}^{nc} \to \overline{\mathcal{T}} \ (a_n \mapsto \pi(\omega_n), \ n \geq 0)$  is a bialgebra map, where  $\iota: L \to \mathcal{T}$  is the inclusion.

It is clear that the bialgebra  $\phi(\mathcal{B}_{\text{FdB}}^{\text{nc}}) = \pi \circ \iota(L)$  is N-graded since  $\mathcal{B}_{\text{FdB}}^{\text{nc}}$  is N-graded (see Remark [2.5\)](#page-6-4) and  $\pi$  is an N-graded bialgebra map (see Proposition [2.15\)](#page-9-5). Note that  $\phi(\mathcal{B}_{\text{FdB}}^{\text{nc}})(0) = \Bbbk[\pi(g)]$ . It follows from [\[25,](#page-25-21) Proposition 4.1.2] that  $\phi(\mathcal{B}^{\text{nc}}_{\text{FdB}})$  is pointed. Now we study the N-graded pointed bialgebra  $\phi(\mathcal{B}^{\rm nc}_{\rm FdB})$ . First we give the following relations.

**Lemma 2.22.** The following hold in  $\mathcal{T}$ :

(a) For  $n \geq 0$ ,

<span id="page-11-0"></span>(14) 
$$
\omega_n = \sum_{k=0}^n \binom{n}{k} h^{n-k} E_{\omega_k},
$$

<span id="page-11-3"></span>(15) 
$$
E_{\omega_n} = \sum_{k=0}^n \binom{n}{k} (-1)^k h^k \omega_{n-k}.
$$

(b) For  $m, n \geq 0$ ,

<span id="page-11-4"></span>(16) 
$$
\pi(E_{\omega_m})\pi(\omega_n) = \sum_{k=0}^n \binom{n}{k} \pi(\omega_{n-k})\pi(E_{\omega_{m+k}}),
$$

<span id="page-11-1"></span>(17) 
$$
\omega_{n+1} = \omega_n h = h\omega_n + \sum_{k=0}^n \binom{n}{k} h^{n-k} E_{\omega_{1+k}}.
$$

(c) For  $m, n, r, s \geq 0$ ,

<span id="page-11-5"></span>(18) 
$$
\omega_m \omega_n = \sum_{k=0}^n \binom{n}{k} \omega_{m+n-k} E_{\omega_k},
$$

<span id="page-11-2"></span>(19) 
$$
\omega_r E_{\omega_s} = \sum_{k=0}^s \binom{s}{t} (-1)^t \omega_{r+t} \omega_{s-t}.
$$

*Proof.* Part (a) follows by induction on n. We now show Part (b). Using Formulas  $(14)$  and  $(13)$ , we have

$$
\pi(E_{\omega_m})\pi(\omega_n) = \sum_{k=0}^n {n \choose k} \pi(E_{\omega_m}h^{n-k})\pi(E_{\omega_k})
$$
  
\n
$$
= \sum_{k=0}^n {n \choose k} \sum_{t=0}^{n-k} {n-k \choose t} \pi(h^{n-k-t}E_{\omega_{m+t}})\pi(E_{\omega_k})
$$
  
\n
$$
= \sum_{t=0}^n {n \choose t} \sum_{k=0}^{n-t} {n-t \choose k} \pi(h^{n-t-k})\pi(E_{\omega_k})\pi(E_{\omega_{m+t}})
$$
  
\n
$$
= \sum_{t=0}^n {n \choose t} \pi(\omega_{n-t})\pi(E_{\omega_{m+t}}).
$$

By the definition of  $\omega_n$ , we have  $\omega_n h = \omega_{n+1}$ . It follows from Formula [\(13\)](#page-9-6) that

$$
\omega_n h = hgh^n + E_{\omega_1} h^n
$$

$$
= h\omega_n + \sum_{k=0}^n {n \choose k} h^{n-k} E_{1+k}
$$

Thus Formula [\(17\)](#page-11-1) holds. It remains to show Part (c). Using Formula [\(14\)](#page-11-0), we obtain

$$
\omega_m \omega_n = \sum_{k=0}^n \binom{n}{k} \omega_m h^{n-k} E_{\omega_k}
$$

$$
=\sum_{k=0}^n\binom{n}{k}\omega_{m+n-k}E_{\omega_k}.
$$

Formula [\(19\)](#page-11-2) follows directly from Formula [\(15\)](#page-11-3).

Let  $\tilde{\omega}_n := \pi(\omega_n)$  for  $n \geq 0$ . Denote by  $\mathcal{B}_F$  the subalgebra of  $\overline{\mathcal{T}}$  generated by  $\{\tilde{\omega}_n, \mathcal{E}_{\omega_m} | n, m \geq 0\}$ . Identifying the Faà di Bruno bialgebra  $\mathcal{B}_{\text{FdB}}$  with R in Lemma [2.18,](#page-10-1) we see that  $\mathcal{B}_F$  is a bialgebra containing the bialgebras  $\pi(\mathcal{B}_{\text{FdB}}^{\text{nc}})$  (here we identify  $\mathcal{B}_{\text{FdB}}^{\text{nc}}$  with L) and  $\mathcal{B}_{\text{FdB}}$  as sub-bialgebras.

<span id="page-12-0"></span>**Theorem 2.23.**  $\mathcal{B}_F$  is an N-graded pointed bialgebra with a PBW basis

$$
\{\widetilde{\omega}_{m}^{d} \mathcal{E}_{\omega_{n_1}}^{e_1} \cdots \mathcal{E}_{\omega_{n_j}}^{e_j} | m, j \ge 1, n_1 > \ldots > n_j \ge 0, 0 \le d \le 1, e_1, \ldots, e_j \ge 0\}
$$

such that for  $m, n, r, s \geq 0$ ,

(20) 
$$
\mathcal{E}_{\omega_m}\mathcal{E}_{\omega_n}=\mathcal{E}_{\omega_n}\mathcal{E}_{\omega_m}
$$

(21) 
$$
\mathcal{E}_{\omega_m}\widetilde{\omega}_n = \sum_{k=0}^n \binom{n}{k} \widetilde{\omega}_{n-k} \mathcal{E}_{\omega_{m+k}},
$$

(22) 
$$
\widetilde{\omega}_m \widetilde{\omega}_n = \sum_{k=0}^n {n \choose k} \widetilde{\omega}_{m+n-k} \mathcal{E}_{\omega_k},
$$

(23) 
$$
\widetilde{\omega}_r \mathcal{E}_{\omega_s} = \sum_{k=0}^s \binom{s}{t} (-1)^t \widetilde{\omega}_{r+t} \widetilde{\omega}_{s-t}.
$$

Moreover, as the sub-bialgebra of  $\mathcal{B}_F$ ,  $\pi(\mathcal{B}_{\text{FdB}}^{\text{nc}})$  has a PBW basis:

$$
\{1\} \cup \{\widetilde{\omega}_m \mathcal{E}^{e_1}_{\omega_{n_1}} \cdots \mathcal{E}^{e_j}_{\omega_{n_j}} | m, j \ge 1, n_1 > \ldots > n_j \ge 0, e_1, \ldots, e_j \ge 0\}.
$$

*Proof.* It is clear that  $\mathcal{B}_F$  is an N-graded bialgebra since  $\pi(\mathcal{B}^{\text{nc}}_{\text{FdB}})$  and  $\mathcal{B}_{\text{FdB}}$  are N-graded bialgebras. Observe that  $\mathcal{B}_F(0) = \mathbb{k}[\pi(g)]$ . Thus  $\mathcal{B}_F$  is pointed from [\[25,](#page-25-21) Proposition 4.1.2]. The relations of  $\mathcal{B}_F$ follow from the formulas [\(16\)](#page-11-4), [\(18\)](#page-11-5), [\(19\)](#page-11-2) and Theorem [2.14.](#page-9-2) Now we show that  $\mathcal{B}_F$  has the PBW basis as claimed. Note that  $\pi(g) = \tilde{\omega}_0 = \mathcal{E}_{\omega_0}$ . Applying the Diamond Lemma [\[6\]](#page-25-10) to the order  $\prec_{red}$ :  $\dots \prec_{red} \widetilde{\omega}_n \prec_{red} \dots \prec_{red} \widetilde{\omega}_1 \prec_{red} \dots \prec_{red} \mathcal{E}_{\omega_m} \prec_{red} \dots \prec_{red} \mathcal{E}_{\omega_1} \prec_{red} \mathcal{E}_{\omega_0}$ , we just need to show that the following overlap ambiguities for  $0 \le r < s < t$  are resolvable:

<span id="page-12-1"></span>(24) 
$$
(\mathcal{E}_{\omega_r}\mathcal{E}_{\omega_s})\mathcal{E}_{\omega_t}=\mathcal{E}_{\omega_r}(\mathcal{E}_{\omega_s}\mathcal{E}_{\omega_t}),
$$

(\mathcal{E}_{\omega_r}\mathcal{E}_{\omega_s})\tilde{\omega}_t = \mathcal{E}_{\omega_r}(\mathcal{E}_{\omega_s}\tilde{\omega}_t),
$$

<span id="page-12-3"></span>(26) 
$$
(\mathcal{E}_{\omega_r}\widetilde{\omega}_s)\widetilde{\omega}_t=\mathcal{E}_{\omega_r}(\widetilde{\omega}_s\widetilde{\omega}_t),
$$

<span id="page-12-4"></span>(27) 
$$
(\widetilde{\omega}_r \widetilde{\omega}_s) \widetilde{\omega}_t = \widetilde{\omega}_r (\widetilde{\omega}_s \widetilde{\omega}_t).
$$

It is clear that [\(24\)](#page-12-1) is resolvable. The calculation

$$
\begin{split} (\mathcal{E}_{\omega_r} \mathcal{E}_{\omega_s}) \widetilde{\omega}_t &= \mathcal{E}_{\omega_s} (\mathcal{E}_{\omega_r} \widetilde{\omega}_t) \\ &= \sum_{a=0}^t \binom{t}{a} (\mathcal{E}_{\omega_s} \widetilde{\omega}_{t-a}) \mathcal{E}_{\omega_{r+a}} \\ &= \sum_{a=0}^t \sum_{b=0}^{t-a} \binom{t}{a} \binom{t-a}{b} \widetilde{\omega}_{t-a-b} (\mathcal{E}_{\omega_{s+b}} \mathcal{E}_{\omega_{r+a}}) \\ &= \sum_{a=0}^t \sum_{b=0}^{t-a} \binom{t}{a} \binom{t-a}{b} (\widetilde{\omega}_{t-a-b} \mathcal{E}_{\omega_{r+a}}) \mathcal{E}_{\omega_{s+b}} \end{split}

= \sum_{b=0}^{t} {t \choose b} \left(\sum_{a=0}^{t-b} {t-b \choose a} \widetilde{\omega}_{t-b-a} \mathcal{E}_{\omega_{r+a}} \right) \mathcal{E}_{\omega_{s+b}}

shows that [\(25\)](#page-12-2) is resolvable. For the left side of [\(26\)](#page-12-3) we make the calculation

&= \sum_{a=0}^s \sum_{b=0}^t \binom{s}{a} \binom{t}{b} (\widetilde{\omega}_{s-a}\widetilde{\omega}_{t-b}) \mathcal{E}_{\omega_{r+a+b}} \\
&= \sum_{a=0}^s \sum_{b=0}^t \sum_{c=0}^{t-b} \binom{s}{a} \binom{t}{b} \binom{t-b}{c} \widetilde{\omega}_{s-a+t-b-c}(\mathcal{E}_{\omega_c}\mathcal{E}_{\omega_{r+a+b}}) \\
&= \sum_{a=0}^s \sum_{c=0}^t \sum_{b=0}^{t-c} \binom{s}{a} \binom{t}{c} \binom{t-c}{b} \widetilde{\omega}_{s-a+t-b-c} \mathcal{E}_{\omega_{r+a+b}} \mathcal{E}_{\omega_c} \\
&= \sum_{c=0}^t \binom{t}{c} (\sum_{d=0}^{s+t-c} \sum_{a+b=d} \binom{s}{a} \binom{t-c}{b} \widetilde{\omega}_{s+t-c-d} \mathcal{E}_{\omega_{r+d}}) \mathcal{E}_{\omega_c},\n\end{split}

Using Vandermonde's Identity:  $\binom{m+n}{k} = \sum_{i+j=k} \binom{m}{i} \binom{n}{j}$ , we see that [\(26\)](#page-12-3) amounts to

= \sum_{c=0}^{t} {t \choose c} (\mathcal{E}_{\omega_r} \widetilde{\omega}_{s+t-c}) \mathcal{E}_{\omega_c}

= \mathcal{E}_{\omega_r} (\sum_{c=0}^{t} {t \choose c} \widetilde{\omega}_{s+t-c} \mathcal{E}_{\omega_c})
$$
\n
$$
= \mathcal{E}_{\omega_r} (\mathcal{E}_{\omega_s} \widetilde{\omega}_t).
$$

Thus [\(26\)](#page-12-3) is resolvable. Similarly, [\(27\)](#page-12-4) is resolvable from the following calculation and Vandermonde's Identity:

\begin{split}\n(\widetilde{\omega}_{r}\widetilde{\omega}_{s})\widetilde{\omega}_{t} &= \sum_{a=0}^{s} \binom{s}{a} \widetilde{\omega}_{r+s-a}(\mathcal{E}_{\omega_{a}}\widetilde{\omega}_{t}) \\
&= \sum_{a=0}^{s} \sum_{b=0}^{t} \binom{s}{a} \binom{t}{b} (\widetilde{\omega}_{r+s-a}\widetilde{\omega}_{t-b}) \mathcal{E}_{\omega_{a+b}} \\
&= \sum_{a=0}^{s} \sum_{b=0}^{t} \sum_{c=0}^{t-b} \binom{s}{a} \binom{t}{b} \binom{t-b}{c} \widetilde{\omega}_{r+s+t-a-b-c}(\mathcal{E}_{\omega_{c}}\mathcal{E}_{\omega_{a+b}}) \\
&= \sum_{a=0}^{s} \sum_{c=0}^{t} \sum_{b=0}^{t-c} \binom{s}{a} \binom{t}{c} \binom{t-c}{b} \widetilde{\omega}_{r+s+t-a-b-c} \mathcal{E}_{\omega_{a+b}} \mathcal{E}_{\omega_{c}}\n\end{split}
$$

$$
= \sum_{c=0}^{t} {t \choose c} \left(\sum_{a=0}^{s} \sum_{b=0}^{t-c} {s \choose a} {t-c \choose b} \tilde{\omega}_{r+s+t-c-(a+b)} \mathcal{E}_{\omega_{a+b}}\right) \mathcal{E}_{\omega_{c}}
$$
  
\n
$$
= \sum_{c=0}^{t} {t \choose c} \left(\sum_{d=0}^{s+t-c} {s+t-c \choose d} \tilde{\omega}_{r+s+t-c-d} \mathcal{E}_{\omega_{d}}\right) \mathcal{E}_{\omega_{c}}
$$
  
\n
$$
= \sum_{c=0}^{t} {t \choose c} (\tilde{\omega}_{r} \tilde{\omega}_{s+t-c}) \mathcal{E}_{\omega_{c}}
$$
  
\n
$$
= \tilde{\omega}_{r} (\sum_{c=0}^{t} {t \choose c} \tilde{\omega}_{s+t-c} \mathcal{E}_{\omega_{c}})
$$
  
\n
$$
= \tilde{\omega}_{r} (\tilde{\omega}_{s} \tilde{\omega}_{t}).
$$

Similarly, it is not difficult to show that  $\pi(\mathcal{B}_{\text{FdB}}^{\text{nc}})$  has the basis as claimed.

<span id="page-14-0"></span>**Remark 2.24.** From Theorem [2.23](#page-12-0) we see that  $\{1\} \cup \{\widetilde{\omega}_m \mathcal{E}_{\omega_{n_1}}^{e_1} \cdots \mathcal{E}_{\omega_{n_j}}^{e_j} \mid m, j \geq 1, n_1 > \ldots > n_j \geq j\}$  $[0, e_1, \ldots, e_j \geq 0]$  forms a PBW basis of  $\pi(\mathcal{B}_{\text{FdB}}^{\text{nc}})$ , while  $\{\mathcal{E}_{\omega_{n_1}}^{e_1} \cdots \mathcal{E}_{\omega_{n_j}}^{e_j} \mid m, j \geq 1, n_1 > \ldots > n_j \geq 1\}$ 0,  $e_1, \ldots, e_j \geq 0$  is a PBW basis of  $\mathcal{B}_{FdB}$ . From the form of the two PBW bases, we should view  $\pi(\mathcal{B}^{\rm nc}_{\rm FdB})$ , instead of  $\mathcal{B}^{\rm nc}_{\rm FdB}$ , as the non-commutative version of the commutative Faá di Bruno bialgebra  $B_{\rm FdB}.$ 

## 3. QUOTIENT HOPF ALGEBRAS OF  $\overline{\mathcal{T}}$

<span id="page-14-1"></span>In this section, we construct some quotient bialgebras  $Q$  of  $\overline{\mathcal{T}}$ , which admit Hopf algebra structures. Let  $\pi_Q : \mathcal{T} \to Q$  be the projection. We still use the notation  $\mathcal{E}_{\omega_k}$  (resp. h, g) in Q instead of  $\pi_Q(E_{\omega_k})$ (resp.  $\pi_Q(h)$ ,  $\pi_Q(g)$ ).

<span id="page-14-3"></span>**Lemma 3.1.** [\[25,](#page-25-21) Corollary 7.6.7] Let A be a bialgebra over k generated by  $S \cup \mathcal{P}(A)$ , where  $S \subseteq G(A)$ , and the elements of  $S$  are invertible. Then  $A$  is a pointed Hopf algebra.

### 3.1. The Hopf algebra  $\overline{\mathcal{T}}_n$ .

Let  $\overline{\mathcal{T}}_n$  be the quotient algebra  $\overline{\mathcal{T}}/\mathcal{I}_n$ , where  $\mathcal{I}_n$  is the ideal of  $\overline{\mathcal{T}}$  generated by  $g^n - 1$  for  $n \geq 2$ .

<span id="page-14-5"></span>**Proposition 3.2.**  $\overline{\mathcal{T}}_n$  is an N-graded pointed Hopf algebra.

*Proof.* Since  $\Delta(g^n - 1) = (g^n - 1) \otimes 1 + g^n \otimes (g^n - 1)$ ,  $\mathcal{I}_n$  is a bi-ideal. So  $\overline{\mathcal{I}}_n$  is a quotient bialgebra of  $\overline{\mathcal{T}}$ . By Lemma [3.1,](#page-14-3)  $\overline{\mathcal{T}}$  is a pointed Hopf algebra. Moreover,  $\mathcal{I}_n$  is graded. It follows that  $\overline{\mathcal{T}}_n$  is graded by Propositions [2.15](#page-9-5)

#### <span id="page-14-2"></span>Lemma 3.3.

- (a) If  $\mathcal{E}_{gh} = 0$ , then  $\overline{\mathcal{T}}_n$  is commutative with a PBW basis  $\{h^{n_2}g^{n_1} \mid 0 \leq n_1 \leq n-1, n_2 \in \mathbb{N}\}.$
- (b) If  $\mathcal{E}_{gh} \neq 0$ , char  $k = p > 0$  and  $p|n$ , then  $\overline{\mathcal{T}}_n$  has infinite GK-dimension, with a PBW basis:
- $\{h^{n_2} \mathcal{E}_{\omega_{k_1}}^{n_{\omega_{k_1}}}$  $\omega_{{k_1}}^{n_{\omega_{k_1}}}$   $\mathcal{E}^{n_{\omega_{k_2}}}_{\omega_{k_2}}$  $\sum_{\omega_{k_2}}^{n_{\omega_{k_2}}}\cdots \mathcal{E}_{\omega_{k_m}}^{n_{\omega_{k_m}}} g^{n_1} | k_1 > k_2 > \ldots > k_m \ge 1, 0 \le n_1 \le n-1, n_2, n_{\omega_{k_i}} \in \mathbb{N}, 1 \le i \le m$ . Furthermore,  $S^{2p} = id$ .

*Proof.* Applying the Diamond Lemma [\[6\]](#page-25-10) to the order  $\prec_{red}: h \prec_{red} ... \prec_{red} \mathcal{E}_{\omega_k} \prec_{red} ... \prec_{red} \mathcal{E}_{gh} \prec_{red}$ g, we just needx to verify the overlaps  $(11)$ ,  $(12)$  and the following are resolvable:

$$
(g^{n-1}g)\mathcal{E}_{\omega_s} = g^{n-1}(g\mathcal{E}_{\omega_s}), \quad s \ge 0,
$$

<span id="page-15-1"></span>(29) 
$$
(g^{n-1}g)h = g^{n-1}(gh).
$$

By direct computations, the overlaps [\(11\)](#page-9-0), [\(12\)](#page-9-1) and [\(28\)](#page-14-4) are resolvable and [\(29\)](#page-15-1) amounts to the condition  $\binom{n}{1}$  $n_1^n$ ,  $\mathcal{E}_{gh}g^{n-1} = 0$ , that is,  $n\mathcal{E}_{gh} = 0$ . Thus it leads to two cases:

(i)  $\mathcal{E}_{gh} = 0$ ; (ii)  $\mathcal{E}_{gh} \neq 0$ , char k = p and p|n.

Now we show  $S^{2p} = id$ . Observe that  $S(g) = g^{-1}$ ,  $S(h) = -hg^{-1}$ ,  $S^2(h) = h + \mathcal{E}_{gh}g^{-1}$ ,  $S(\mathcal{E}_{gh}) =$  $-\mathcal{E}_{gh}g^{-3}$  and  $g\mathcal{E}_{gh} = \mathcal{E}_{gh}g$ . Then by induction on n, we obtain

$$
S^{n}(h) = \begin{cases} -hg^{-1} - \frac{n-1}{2} \mathcal{E}_{gh} g^{-2}, & \text{if } n \text{ is odd,} \\ h + \frac{n}{2} \mathcal{E}_{gh} g^{-1}, & \text{if } n \text{ is even.} \end{cases}
$$

Therefore,  $S^{2p} = \text{id}$  by the fact that  $\overline{\mathcal{T}}_n$  is generated by  $\{g, h\}$  as an algebra.

3.2. The Hopf algebras  $\overline{\mathcal{T}}'_i$  $\mathcal{T}_n(p), \ \overline{\mathcal{T}}_n(p) \ \text{and} \ \overline{\mathcal{T}}'_p$  $_{\pm 1}^{\prime }(p).$ 

Now we consider some quotient Hopf algebras with finite GK-dimension.

**Definition 3.4.** Let char  $\mathbb{k} = p$  and suppose that  $\mathcal{E}_{gh} \neq 0$ ,  $p|n$ . Define  $\overline{\mathcal{T}}'_{h}$  $\mathcal{T}_n(p) := \overline{\mathcal{T}}_n/\mathcal{I}'_p$ , where  $\mathcal{I}'_p$  is the ideal generated by  $\mathcal{E}_{\omega_{p-1}}$ .

<span id="page-15-4"></span>Proposition 3.5.  $\overline{\mathcal{T}}'_i$  $f_n(p)$  is an N-graded pointed Hopf algebra.

*Proof.* By Proposition [3.2](#page-14-5) it suffices to show that  $\mathcal{I}'_p$  is a graded coideal. Indeed, using Formulas  $(8), (9)$  $(8), (9)$  $(8), (9)$ , we have

(30) 
$$
\Delta_{\overline{\mathcal{T}}'_n(p)}(\mathcal{E}_{\omega_{p-1}}) = g \otimes \mathcal{E}_{\omega_{p-1}} + \mathcal{E}_{\omega_{p-1}} \otimes g^p.
$$

<span id="page-15-0"></span>Lemma 3.6.  $\overline{\mathcal{T}}'_i$  $f_n(p)$  has GK-dimension  $p-1$ , with a PBW basis

<span id="page-15-3"></span>
$$
\{h^{n_2} \mathcal{E}_{\omega_{p-2}}^{n_{\omega_{p-2}}} \mathcal{E}_{\omega_{p-3}}^{n_{\omega_{p-3}}} \cdots g^{n_1} | 0 \le n_1 \le n-1, n_2, n_{\omega_k} \in \mathbb{N}, 1 \le k \le p-2\}
$$

satsifying the relations:

$$
\begin{aligned} g^n = 1, \qquad \mathcal{E}_{\omega_s} h = h \mathcal{E}_{\omega_s} + \mathcal{E}_{\omega_{s+1}}, \\ \mathcal{E}_{\omega_{p-2}} h = h \mathcal{E}_{\omega_{p-2}}, \qquad \mathcal{E}_{\omega_s} \mathcal{E}_{\omega_t} = \mathcal{E}_{\omega_t} \mathcal{E}_{\omega_s}, \end{aligned}
$$

where  $0 \leq s < t \leq p-2$ .

*Proof.* Consider the order  $\prec_{red}: h \prec_{red} \mathcal{E}_{\omega_{p-2}} \prec_{red} \mathcal{E}_{\omega_{p-3}} \prec_{red} \ldots \prec_{red} g$ , the overlaps [\(11\)](#page-9-0), [\(12\)](#page-9-1), [\(28\)](#page-14-4), [\(29\)](#page-15-1) and the following [\(31\)](#page-15-2) are resolvable in  $\overline{\mathcal{T}}_n(p)$  for all  $0 \leq s \leq p-2$ :

$$
(\mathcal{E}_{\omega_s}h)h^{p-1}=\mathcal{E}_{\omega_s}(h^{p-1}).
$$

Let  $R = \mathbb{E}[g]/(g^n)$ . Since  $\overline{\mathcal{T}}_n(p) = R[\mathcal{E}_{gh}] \dots [\mathcal{E}_{\omega_{p-2}}][h; \operatorname{ad}_r h]$ , the GK-dimension of  $\overline{\mathcal{T}}_n(p)$  is  $p-1$  by Lemma [1.14](#page-4-2) and Lemma [1.15.](#page-4-3)

### <span id="page-15-5"></span>Remark 3.7.

- (i) Let  $R'_n(p)$  be the subalgebra of  $\overline{\mathcal{T}}'_n$  $n(n)$  generated by  $\{\mathcal{E}_{\omega_r} | 0 \leq r \leq p-2\}$ . Then  $\overline{\mathcal{T}}'_n$  $n(p) =$  $R'_n(p)[h; \operatorname{ad}_r h].$
- (ii) From Formula [\(30\)](#page-15-3), Lemma [1.14](#page-4-2) and Lemma [1.15,](#page-4-3)  $\overline{\mathcal{T}}'$ .  $\mathcal{J}_{\pm 1}(p) := \mathcal{T}_{\pm 1}/(\mathcal{E}_{\omega_{p-1}})$  is an N-graded pointed Hopf algebras of GK-dimension p.

**Definition 3.8.** Let char  $\mathbb{k} = p$  and suppose that  $\mathcal{E}_{gh} \neq 0$ ,  $p|n$ . Define  $\overline{\mathcal{T}}_n(p) := \overline{\mathcal{T}}'_n$  $\mathcal{I}_n(p)/\mathcal{I}_p$ , where  $\mathcal{I}_p$ is the ideal of  $\overline{\mathcal{T}}'_{\eta}$  $n(p)$  generated by  $h^p$ .

<span id="page-16-1"></span>**Proposition 3.9.**  $\overline{\mathcal{T}}_n(p)$  is an N-graded pointed Hopf algebra.

*Proof.* It follows from Lemma [3.1](#page-14-3) and the formulas [\(10\)](#page-8-2), [\(30\)](#page-15-3).

<span id="page-16-0"></span>**Lemma 3.10.**  $\overline{\mathcal{T}}_n(p)$  has GK-dimension  $p-2$ , with a PBW basis

 $\{h^{n_2}\mathcal{E}^{n_{\omega_{p-2}}}_{\omega_{p-2}}\mathcal{E}^{n_{\omega_{p-3}}}_{\omega_{p-3}}\cdots g^{n_1}|\ 0\leq n_2\leq p-1,\ 0\leq n_1\leq n-1,\ n_{\omega_{k}}\in\mathbb{N},\ 1\leq k\leq p-2\}$ 

satisfying the relations:

$$
g^{n} = 1, \t h^{p} = 0, \t \t \mathcal{E}_{\omega_{s}} h = h \mathcal{E}_{\omega_{s}} + \mathcal{E}_{\omega_{s+1}},
$$
  

$$
\mathcal{E}_{\omega_{p-2}} h = h \mathcal{E}_{\omega_{p-2}}, \t \mathcal{E}_{\omega_{s}} \mathcal{E}_{\omega_{t}} = \mathcal{E}_{\omega_{t}} \mathcal{E}_{\omega_{s}},
$$

where  $0 \leq s < t \leq p-2$ .

*Proof.* Applying the Diamond Lemma to the order  $\prec_{red}: h \prec_{red} \mathcal{E}_{\omega_{p-2}} \prec_{red} \mathcal{E}_{\omega_{p-3}} \prec_{red} \ldots \prec_{red} g$ , the ambiguities [\(11\)](#page-9-0), [\(12\)](#page-9-1), [\(28\)](#page-14-4), [\(29\)](#page-15-1) and following are resolvable in  $\overline{\mathcal{T}}_n(p)$  for all  $0 \leq s \leq p-2$ :

$$
(hh^{p-1})h = h(h^{p-1}h).
$$

Let  $R = \mathbb{k}[g]/(g^n)$ . Since  $\overline{\mathcal{T}}_n(p) = (R[\mathcal{E}_{gh}] \dots [\mathcal{E}_{\omega_{p-2}}][h; \text{ad}_r h])/(h^p)$ , its GK-dimension is  $p-2$  by Lemma [1.14](#page-4-2) and Lemma [1.15.](#page-4-3)

<span id="page-16-3"></span>**Remark 3.11.** Let  $R_n(p)$  be the subalgebra of  $\mathcal{T}_n(p)$  generated by  $\{\mathcal{E}_{\omega_k} | 0 \leq k \leq p-2\}$ . Then  $\overline{\mathcal{T}}_n(p) = R_n(p)[h; \operatorname{ad}_r h].$ 

Recall that Radford [\[23,](#page-25-0) Proposition 4.7] introduced the pointed Hopf algebra  $\overline{\mathcal{SH}_n} := \mathcal{T}/\mathcal{C}_n$ , where  $\mathcal{C}_n$  is the ideal of  $\mathcal T$  generated by  $\{g^n - 1, \mathcal{SH}_{n-k,k}(h,g) | 0 \leq k \leq n-1\}$ , see also [\[16,](#page-25-1) Section 5.3.2]. We show that the relationship between  $\overline{\mathcal{T}}_n(p)$  and  $\overline{\mathcal{SH}_n}$  is as follows.

**Corollary 3.12.** Let  $n \geq 3$  and  $\mathcal{I}'$  be the ideal of  $\overline{\mathcal{SH}_n}$  generated by  $\{\mathcal{E}_{\alpha} \in \overline{\mathcal{SH}_n} | \alpha(1) \geq 2\}$ .

- (a) If char  $\mathbb{k} = 0$ , then  $\overline{\mathcal{SH}_n}/\mathcal{I}' \cong \mathbb{k}\mathbb{Z}_n$ .
- (b) If char  $\mathbb{k} = p$ , then  $\overline{\mathcal{SH}_p}/\mathcal{I}' \cong \overline{\mathcal{T}}_p(p)$ .

*Proof.* From [\[16,](#page-25-1) Corollary 2.2],  $\mathcal{SH}_{1,n-1} = 0$  implies that  $n((n-1)gh - (n-3)hg) = 0$  in  $\mathcal{SH}_n/\mathcal{I}'$ . Note that  $\mathcal{E}_{qgh} = [g, [g, h]] = 0$ . If char  $k = 0$ , then  $h = 0$  and Part (a) holds. Let K be the ideal of T generated by  $\{E_{\alpha}, g^p - 1, E_{\omega_{p-1}}, h^p | \alpha(g) \ge 2\}$ . If char  $\Bbbk = p$ , then  $\mathcal{I}' + \mathcal{C}_p = \mathcal{K}$  by [\[16,](#page-25-1) Corollary 2.3 (c)]. It is clear that  $\overline{\mathcal{SH}_p}/\mathcal{I}'=\mathcal{T}/\mathcal{C}_p/(\mathcal{I}'+\mathcal{C}_p)/\mathcal{C}_p\cong\mathcal{T}/\mathcal{K}$ . Therefore,  $\overline{\mathcal{SH}_p}/\mathcal{I}'\cong\overline{\mathcal{T}}_p(p)$  from Theorem [2.10,](#page-7-2) Propositions [3.2,](#page-14-5) [3.5,](#page-15-4) [3.9.](#page-16-1)

3.3. The Hopf algebra  $\overline{\mathcal{T}}_n(p; d_i, d_{i-1}, \ldots, d_1)$ .

Let char  $\mathbb{k} = p$  and suppose that  $\mathcal{E}_{gh} \neq 0$ ,  $p|n, 1 \leq j \leq p-2$ ,  $d_j \geq d_{j-1} \geq \ldots \geq d_1 \geq 1$ . Let  $\overline{\mathcal{T}}_n(p; d_j, d_{j-1}, \ldots, d_1) := \overline{\mathcal{T}}_n(p)/\mathcal{I}(d_j, d_{j-1}, \ldots, d_1),$  where  $\mathcal{I}(d_j, d_{j-1}, \ldots, d_1)$  is the ideal of  $\overline{\mathcal{T}}_n(p)$ generated by  $\{\mathcal{E}_{\omega_k}^{p^{d_k}}\}$  $\left|\sum_{\omega_k}^{p^{-\kappa}}\right|1\leq k\leq j\}.$ 

**Proposition 3.13.**  $\overline{\mathcal{T}}_n(p; d_i, d_{i-1}, \ldots, d_1)$  is an N-graded pointed Hopf algebra.

*Proof.* By Lemma [3.1](#page-14-3) it suffices to show that  $\mathcal{I}(d_j, d_{j-1}, \ldots, d_1)$  is a graded coideal. It follows from the formulas  $(8)$  and  $(9)$ .

<span id="page-17-1"></span>**Theorem 3.14.**  $\overline{\mathcal{T}}_n(p; d_i, d_{i-1}, \ldots, d_1)$  has GK-dimension  $(p-2-j)$ , with a PBW basis  $\{h^{n_2} \mathcal{E}^{n_{\omega_{p-2}}}_{\omega_{p-2}} \mathcal{E}^{n_{\omega_{p-3}}}_{\omega_{p-3}} \cdots g^{n_1} | 0 \leq n_2 \leq p-1, 0 \leq n_{\omega_k} \leq p^{d_k}-1, 1 \leq k \leq j,$  $n_{\omega_{11}} \in \mathbb{N}, j < k' \leq p-2, 0 \leq n_1 \leq n-1$ 

and the relations:

$$
g^{n} = 1, \t\mathcal{E}_{\omega_{k}}^{p^{d_{k}}} = 0, \t h^{p} = 0,
$$
  

$$
\mathcal{E}_{\omega_{s}} h = h \mathcal{E}_{\omega_{s}} + \mathcal{E}_{\omega_{s+1}}, \t\mathcal{E}_{\omega_{p-2}} h = h \mathcal{E}_{\omega_{p-2}}, \t\mathcal{E}_{\omega_{s}} \mathcal{E}_{\omega_{t}} = \mathcal{E}_{\omega_{t}} \mathcal{E}_{\omega_{s}},
$$

where  $1 \leq k \leq j$  and  $0 \leq s < t \leq p-2$ .

*Proof.* Following Lemmas [1.14](#page-4-2) and [1.15,](#page-4-3) the GK-dimension of  $\overline{\mathcal{T}}_n(p; d_i, d_{i-1}, \ldots, d_1)$  is  $p - 2 - j$ . Applying the Diamond Lemma to the order  $\prec_{red}: h \prec_{red} \mathcal{E}_{\omega_{p-2}} \prec_{red} \mathcal{E}_{\omega_{p-3}} \prec_{red} \ldots \prec_{red} g$ , we see that the overlaps [\(11\)](#page-9-0), [\(12\)](#page-9-1), [\(28\)](#page-14-4), [\(29\)](#page-15-1), [\(31\)](#page-15-2), [\(32\)](#page-16-2) and the following are resolvable in  $\overline{\mathcal{T}}_n(p; d_i, d_{i-1}, \ldots, d_1)$ for all  $i, k, \ell$  such that  $0 \leq i < k \leq j$  and  $k < \ell \leq p-2$ :

$$
(\mathcal{E}_{\omega_k}\mathcal{E}_{\omega_k})\mathcal{E}_{\omega_k}^{p^{d_k}-1}=\mathcal{E}_{\omega_i}(\mathcal{E}_{\omega_k}\mathcal{E}_{\omega_k}^{p^{d_k}-1}),\\ (\mathcal{E}_{\omega_k}^{p^{d_k}-1}\mathcal{E}_{\omega_k})\mathcal{E}_{\omega_\ell}=\mathcal{E}_{\omega_k}^{p^{d_k}-1}(\mathcal{E}_{\omega_k}\mathcal{E}_{\omega_\ell}),\\ (\mathcal{E}_{\omega_k}^{p^{d_k}-1}\mathcal{E}_{\omega_k})h=\mathcal{E}_{\omega_k}^{p^{d_k}-1}(\mathcal{E}_{\omega_k}h),\\ (\mathcal{E}_{\omega_k}\mathcal{E}_{\omega_k}^{p^{d_k}-1})\mathcal{E}_{\omega_k}=\mathcal{E}_{\omega_k}(\mathcal{E}_{\omega_k}^{p^{d_k}-1}\mathcal{E}_{\omega_k}).
$$

### <span id="page-17-2"></span>Remark 3.15.

- (i) Let  $j = p 2$  in Theorem [3.14.](#page-17-1) Then it derives a class of  $np^{(1+\sum_{i=1}^{p-2}d_i)}$ -dimensional pointed Hopf algebras  $\overline{\mathcal{T}}_n(p; d_{p-2}, d_{p-3}, \ldots, d_1)$  over k of charateristic p.
- <span id="page-17-0"></span>(ii) From Lemmas [3.3,](#page-14-2) [3.6,](#page-15-0) [3.10](#page-16-0) and Theorem [3.14,](#page-17-1) one sees that  $\overline{\mathcal{T}}$  has a chain of quotient Hopf algebras:  $\overline{\mathcal{T}} \twoheadrightarrow \overline{\mathcal{T}}_n \twoheadrightarrow \overline{\mathcal{T}}'_n$  $\overline{\mathcal{T}}_n(p) \rightarrow \overline{\mathcal{T}}_n(p) \rightarrow \ldots \rightarrow \overline{\mathcal{T}}_n(p; d_j, d_{j-1}, \ldots, d_1) \rightarrow \ldots \rightarrow$  $\overline{\mathcal{T}}_n(p; d_{p-2}, d_{p-3}, \ldots, d_1).$

#### 4. Homological properties

In this section, we study some homological properties of those pointed Hopf algebras constructed in Section [3](#page-14-1) with finite GK-dimension. We begin by introducing some basic knowledge, see e.g. [\[22,](#page-25-15) [31,](#page-26-1) [9\]](#page-25-24) for more details.

Let R be a ring. R is called affine if it is finitely generated. If  $R_R$  (respectively  $_RR$ ) is Noetherian, then R is a right Noetherian ring (respectively left Noetherian ring). A ring R is a Noetherian ring if R is left Noetherian and right Noetherian. If there exists some monic polynomial  $f \in \mathbb{Z}\langle x_1, x_2, \ldots \rangle$ such that  $f(r_1, \ldots, r_n) = 0$  for all  $r_i \in R$ . Then R is said to be a polynoimal identity ring (PI ring for short).

<span id="page-17-3"></span>**Lemma 4.1.** [\[22,](#page-25-15) Theorem (iv), p.17] Let  $S = R[x; \sigma, \delta]$ . If  $\sigma$  is an automorphism and R is right (or left) Noetherian, then S is right (repectively left) Noetherian.

<span id="page-17-4"></span>**Lemma 4.2.** [\[22,](#page-25-15) Corollary (iii), p.481] If R is finitely generated as a right module over a commutative subring  $A$ , then  $R$  is a PI ring.

**Definition 4.3.** [\[9,](#page-25-24) Definition 1.2] Let  $(A, \epsilon)$  be an augmented Noetherian algebra. Then A is Artin-Schelter Gorenstein (or AS-Gorenstein for short) if

- (a) injdim<sub>A</sub> $A = d < \infty$ ,
- (b)  $\dim_{\mathbb{k}} \text{Ext}_{A}^{d}(A^{\mathbb{k}}, A A) = 1$  and  $\dim_{\mathbb{k}} \text{Ext}_{A}^{i}(A^{\mathbb{k}}, A A) = 0$  for all  $i \neq d$ ,
- (c) the right A-module versions of (a) and (b) hold.

And if gldim  $A = d$ , then A is called Artin-Schelter regular (or AS-regular).

The following lemma is the combination of [\[31,](#page-26-1) Theorem 0.1] and [\[31,](#page-26-1) Theorem 0.2 (1)], see also [\[20,](#page-25-25) Lemma 2.1].

<span id="page-18-5"></span>Lemma 4.4. [\[31,](#page-26-1) Theorem 0.1, Theorem 0.2] Every affine noetherian PI Hopf algebra is AS-Gorenstein.

We obtain the homological properties of  $\overline{\mathcal{T}}'_i$  $\mathcal{T}_n(p), \mathcal{T}_n(p)$  and  $\mathcal{T}_n(p; d_j, d_{j-1}, \ldots, d_1)$  for  $1 \leq j \leq p-2$ .

<span id="page-18-3"></span>Proposition 4.5.  $\overline{\mathcal{T}}'_i$  $\mathcal{T}_n(p), \ \mathcal{T}_n(p)$  and  $\mathcal{T}_n(p; d_j, d_{j-1}, \ldots, d_1)$  are affine and Noetherian.

Proof.  $\overline{\mathcal{T}}'_1$  $n(n)$  is affine because it is generated by  $\{g, h\}$ . Note that  $R'_n(p) = \mathbb{E}[g, \mathcal{E}_{\omega_1}, \dots, \mathcal{E}_{\omega_{p-2}}]/(g^n)$ in Remark [3.7](#page-15-5) (i) is Noetherian. Thus  $\overline{\mathcal{T}}'_i$  $n'(p) = R'_n(p)[h; \operatorname{ad}_r h]$  is Noetherian by Lemma [4.1.](#page-17-3)  $\overline{\mathcal{T}}_n(p)$ and  $\overline{\mathcal{T}}_n(p; d_j, d_{j-1}, \ldots, d_1)$  are also affine and Noetherian, as quotients of  $\overline{\mathcal{T}}'_n$  $\binom{n}{n}$ .

<span id="page-18-4"></span>Proposition 4.6.  $\overline{\mathcal{T}}'_i$  $\mathcal{T}_n(p), \mathcal{T}_n(p)$  and  $\mathcal{T}_n(p; d_j, d_{j-1}, \ldots, d_1)$  are PI algebras.

*Proof.* By Remark [3.11,](#page-16-3)  $R_n(p)$  is a commutative subalgebra of  $\overline{\mathcal{T}}_n(p)$ . Observe that  $\overline{\mathcal{T}}_n(p)$  is finitely generated as a right  $R_n(p)$ -module because  $h^p = 0$ . Thus  $\overline{\mathcal{T}}_n(p)$  is PI by Lemma [4.2.](#page-17-4) Similarly,  $\overline{\mathcal{T}}_n(p; d_j, d_{j-1}, \ldots, d_1)$  is PI. Note that the subalgebra  $R'$  of  $\overline{\mathcal{T}}'_n$  $\mathcal{E}_n^{\prime}(p)$  generated by  $\{g, \mathcal{E}_{gh}, \ldots, \mathcal{E}_{\omega_{p-2}}, h^p\}$ is commutative and  $\overline{\mathcal{T}}'_{i}$  $n(n)$  is a free right R'-module with a basis  $\{1, h, h^2, \ldots, h^{p-1}\}$ . Therefore, the algebra  $\overline{\mathcal{T}}'_i$  $n(p)$  is PI by Lemma [4.2.](#page-17-4)

<span id="page-18-0"></span>Corollary 4.7.  $\overline{\mathcal{T}}'_1$  $\mathcal{T}_n(p), \, \mathcal{T}_n(p)$  and  $\mathcal{T}_n(p; d_j, d_{j-1}, \ldots, d_1)$  are AS-Gorenstein.

*Proof.* It follows from Proposition [4.5,](#page-18-3) Proposition [4.6](#page-18-4) and Lemma [4.4](#page-18-5)

<span id="page-18-1"></span>The above examples may be not AS-regular, so we consider  $\overline{\mathcal{T}}'$ .  $f_{\pm 1}(p)$  in Remark [3.7](#page-15-5) (ii). Corollary 4.8.  $\overline{\mathcal{T}}'$  $y_{\pm 1}(p)$  is AS-regular.

*Proof.* It is evident that  $\overline{\mathcal{T}}'$ .  $y'_{\pm 1}(p)$  is affine. Since  $\overline{\mathcal{T}}'_\pm$  $\mathcal{L}_{\pm 1}(p) \;=\; \mathbbm{k}[g^{\pm 1}][\mathcal{E}_{gh}]\ldots[\mathcal{E}_{\omega_{p-2}}][h; \text{ad}_r\, h], \;\overline{\mathcal{T}}_{\pm 1}'$  $_{\pm 1}^{'}(p)$ is Noetherian by Lemma [4.1.](#page-17-3) It follows from [\[22,](#page-25-15) Theorem 7.5.3, p.263] that  $\overline{\mathcal{T}}'$  $y'_{\pm 1}(p)$  is of a finite global dimenison. Observe that the subalgebra  $R'$  of  $\overline{\mathcal{T}}'$  $\mathcal{L}_{\pm 1}(p)$  generated by  $\{g^{\pm 1}, \mathcal{E}_{gh}, \ldots, \mathcal{E}_{\omega_{p-2}}, h^p\}$  is commutative and  $\overline{\mathcal{T}}'$  $\mathcal{L}_{\pm 1}(p)$  is a free right R'-module with a basis  $\{1, h, h^2, \ldots, h^{p-1}\}$ . Thus  $\overline{\mathcal{T}}'$ .  $y_{\pm 1}(p)$  is PI by Lemma [4.2.](#page-17-4) Therefore,  $\overline{\mathcal{T}}'$  $\perp_{\pm 1}(p)$  is AS-regular from Lemma [4.4.](#page-18-5)

#### 5. The coradical filtrations and related structures

<span id="page-18-2"></span>In this section, we study the coradical filtration of  $\mathcal{T}_{\pm 1}$ ,  $\mathcal{H}_{\text{FdB}}$  and  $\mathcal{T}_p(p; 1, \ldots, 1)$  $\sum_{p-2}$ ) respectively. If there

is no confusion, we set  $\mathcal{T}_p(p; 1, \ldots, 1) := \mathcal{T}_p(p; 1, \ldots, 1)$  $\sum_{p-2}$ ) for convenience in the sequel.

#### 5.1. Nichols algebras.

Let H be a Hopf algebra with a bijective antipode. Let  ${}^H_H$  $\mathcal{YD}$  be the category of left Yetter-Drinfel'd modules (see [\[25,](#page-25-21) Definition 11.6.2]), whose object  $(M, \cdot, \rho)$  is a left H-module  $(M, \cdot)$  and a left Hcomodule  $(M, \rho)$  (write  $\rho(m) := m_{(-1)} \otimes m_{(0)}$ ), satifying the compatiblity condition:

$$
\rho(h \cdot m) = h_1 m_{(-1)} S_H(h_{(3)}) \otimes h_{(2)} \cdot m_{(0)}, \quad h \in H, \ m \in M.
$$

 ${}^H_H$  $YD$  is a braided monoidal category with the braiding structure: for  $M, N \in {}^H_H$  $YD$ , the braiding

$$
c: M \otimes N \to N \otimes M, \qquad c(m \otimes n) = m_{(-1)} \cdot n \otimes m_{(0)}, \quad m \in M, n \in N.
$$

A Hopf algebra  $B$  in  ${}_{H}^{H}$  $\mathcal{YD}$  is called a braided Hopf algebra (see [\[25,](#page-25-21) p. 370] and [\[3,](#page-25-26) Section 1]), with the coproduct  $\Delta_B$  satisfying:  $\Delta_B(1) = 1 \otimes 1$  and

$$
\Delta_B(bc) = b_{(1)}(b_{(2)(-1)} \cdot c_{(1)}) \otimes b_{(2)(0)}c_{(2)}, \qquad b, c \in B.
$$

For Subections 5.2 and 5.3, we need the following conclusions.

<span id="page-19-0"></span>**Lemma 5.1.** [\[25,](#page-25-21) Theorem 11.7.1] Let A, H be Hopf algebras over k. If there are Hopf algebra maps  $\pi:A\to H$  and  $\jmath:H\to A$  such that  $\pi\circ\jmath=id$ , then there exists a braided Hopf algebra  $(B,\cdot,\rho)\in {}^H_H\mathcal{YD}$ such that

$$
A \cong B \# H,
$$
  
\n
$$
B = A^{co \pi} = \{a \in A | (id \otimes \pi)(\Delta(a)) = a \otimes 1\},
$$
  
\n
$$
\Delta_B = (\Pi \otimes id) \circ \Delta_A | B,
$$
  
\n
$$
x \cdot b = \jmath(x_{(1)}) b \jmath(S(x_{(2)})),
$$
  
\n
$$
\rho(b) = \pi(b_{(1)}) \otimes b_{(2)},
$$

where  $\Pi = id * (\iota \circ S \circ \pi), x \in H$  and  $b \in B$ .

Recall that the *coradical filtration* of a coalgebra C over k is a coalgebra filtration  ${C_n}_{n=0}^{\infty}$  of C such that  $C_0 \subseteq C_1 \subseteq C_2 \dots \subseteq \bigcup_{n=0}^{\infty} C_n$  and  $\Delta(C_n) \subseteq \sum_{\ell=0}^n C_{n-\ell} \otimes C_{\ell}$ , where  $C_0 = \text{cord } C$  and  $C_n := C_{n-1} \wedge C_0 = \Delta^{-1}(C_{n-1} \otimes C + C \otimes C_0)$  for  $n \ge 0$ .

Suppose that  ${H_n}_{n=0}^{\infty}$  is the coradical filtration of a Hopf algebra H over k, which is also an algebra filtration. The graded associated Hopf algebra  $gr(H)$  of H is an N-graded Hopf algebra such that  $gr(H) = \bigoplus_{n=0}^{\infty} H(n)$ ,  $H(n) = H_n/H_{n-1}$ , with the multiplication, the coproduct  $\Delta_{gr(H)}$  and the antipode  $S_{gr(H)}$  respectively defined by: let  $\overline{a} \in H(m), b \in H(n)$ .  $\overline{a}b = ab$  is determined by  $(a + b)$  $H_{m-1}(b+H_{n-1})=ab+H_{m+n-1}, a\in H_m, b\in H_n; S_{gr(H)}(\overline{a})=S_H(a)$  is determined by  $S_{gr(H)}(a+$  $H_{m-1}$ ) =  $S_H(a) + H_{m-1}$ ,  $a \in H_m$ ; and

$$
\Delta_{\text{gr}(H)}(\overline{a}) = \sum_{\ell=0}^{m} (\pi_{n-\ell} \otimes \pi_{\ell}) \circ \Delta_H(a), \qquad \pi_j: H_j \to H(j) = H_j/H_{j-1}, \ h \mapsto \overline{h}, \qquad a \in H_m.
$$

**Definition 5.2.** [\[3,](#page-25-26) Definition 2.1] Let  $V \in H^1 \mathcal{YD}$ . A braided Hopf algebra  $R = \bigoplus_{n=0}^{\infty} R(n) \in H^1 \mathcal{YD}$ is called a *Nichols algebra* if  $R(0) \cong \mathbb{k}$ ,  $R(1) \cong V$ ,  $\mathcal{P}(R) = R(1)$  and R is generated as an algebra by  $R(1).$ 

Note that [\[3,](#page-25-26) Proposition 2.2] shows the existence and the uniqueness of Nichols algebras R: R  $\cong$  $B(V) = T(V)/I(V)$ , where  $I(V)$  is the sum of I such that I is a homogeneous bi-ideal of  $T(V)$ generated by homogeneous elements of degree  $\geq 2$ .

# 5.2. The coradical filtrations of  $\overline{\mathcal{T}}_{\pm 1}$  and  $\mathcal{H}_{\text{FdB}}$ .

We study the coradical filtration of  $\overline{\mathcal{T}}_{\pm 1}$  Set  $y := h$ ,  $x := g$ ,  $x_0 := 1$  and  $x_m := \mathcal{E}_{\omega_m} g^{-1}$  for all  $m \ge 1$ . Observe that  $\Bbbk[x^{\pm 1}] \cong \Bbbk \mathbb{Z}$ . Then we rewrite the defining relations of  $\overline{\mathcal{T}}_{\pm 1}^{cop}$  $_{\pm 1}^{\omega p}$ .

<span id="page-20-0"></span>Lemma 5.3. Let  $z_2 := x_2 - \frac{3}{2}$  $\frac{3}{2}x_1^2$  and  $z_n := x_n - \frac{(n+1)!}{2^n}x_1^n$  for  $n \geq 2$ . Then the relations of  $\overline{\mathcal{T}}_{\pm 1}^{cop}$  are equivalent to

<span id="page-20-2"></span>(33)  $[x, y] = x_1 x,$ 

(34) 
$$
[x_1, y] = \frac{1}{2}x_1^2 + z_2,
$$

(35) 
$$
[z_n, y] = -z_n x_1 - \frac{n(n+1)!}{2^n} z_2 x_1^{n-1} + z_{n+1}, \qquad n \ge 2,
$$

<span id="page-20-3"></span>(36)  $[x, x_1] = 0, \quad [x, z_m] = 0, \quad [x_1, z_n] = 0, \quad [z_n, z_m] = 0, \quad 2 \le n < m.$ 

*Proof.* Rewrite the relations of  $\overline{\mathcal{T}}_{\pm 1}^{cop}$  $_{\pm 1}^{top}$  as follows:

$$
[x, y] = x_1 x, \t [x_n, y] = -x_n x_1 + x_{n+1}, \t [x, x_n] = 0, \t [x_n, x_m] = 0, \t 1 \le n < m.
$$

Then the claim holds by induction on n.

Let  $\mathcal{F}_n^{\pm} := F_n^{\pm} \mathbb{k}[x^{\pm 1}]$  for  $n \geq 0$ , where

$$
F_n^\pm=\bigoplus_{\stackrel{r+(i_m-1)s_m+\ldots+(i_2-1)s_2+s_1\leq n,}{i_m>\ldots>i_2\geq 2}}\Bbbk y^r z_{i_m}^{s_m}\cdots z_{i_2}^{s_2}x_1^{s_1}
$$

For example,

$$
\mathcal{F}_0^{\pm} = \mathbb{k}[x^{\pm 1}],
$$

$$
\mathcal{F}_1^{\pm} = (\mathbb{k}1 \oplus \mathbb{k}y \oplus \mathbb{k}z_2 \oplus \mathbb{k}x_1)\mathbb{k}[x^{\pm 1}],

\mathcal{F}_2^{\pm} = (\mathbb{k}1 \oplus \mathbb{k}y \oplus \mathbb{k}z_2 \oplus \mathbb{k}x_1 \oplus \mathbb{k}z_3 \oplus \mathbb{k}y^2 \oplus \mathbb{k}yz_2 \oplus \mathbb{k}yx_1 \oplus \mathbb{k}z_2^2 \oplus \mathbb{k}z_2x_1 \oplus \mathbb{k}x_1^2)\mathbb{k}[x^{\pm 1}].
$$

<span id="page-20-1"></span>It is clear that  $\mathcal{F}_0^{\pm} \subseteq \mathcal{F}_1^{\pm} \subseteq \ldots \subseteq \mathcal{F}_n^{\pm} \subseteq \ldots \subseteq \overline{\mathcal{T}}_{\pm 1}^{cop}$  $_{\pm 1}^{cop}$ . Following the definition of  $F_n^{\pm}$ , we have: Lemma 5.4. For  $n\geq 0$ ,  $F_n^{\pm}\subseteq \sum_{\substack{s,t$ 

<span id="page-20-4"></span>Lemma 5.5.  $\cup_{n=0}^{\infty}\mathcal{F}_{n}^{\pm}=\overline{\mathcal{T}}_{\pm 1}^{cop}$  $_{\pm 1}^{cop}$ . Furthermore,  $\{\mathcal{F}_n^{\pm}\}_{n=0}^{\infty}$  is a Hopf algebra filtration of  $\overline{\mathcal{T}}_{\pm 1}^{cop}$  $\frac{\mu}{\pm 1}$ .

*Proof.* Note that  $\{y^r z_{i_m}^{s_m}\}$  $\frac{s_m}{i_m} \cdots z_{i_2}^{s_2}$  $i_2^{s_2} x_1^{s_1} x^t | i_m > \ldots > i_2 \ge 2, r, s_m, \ldots, s_1 \ge 0, t \in \mathbb{Z}$  is a PBW basis of  $\overline{\mathcal{T}}^{cop}_{\pm 1}$  $_{\pm 1}^{cop}$ . Thus  $\cup_{n=0}^{\infty} \mathcal{F}_n^{\pm} = \overline{\mathcal{T}}_{\pm 1}^{cop}$  $_{\pm 1}^{cop}$ . It is evident that  $\mathcal{F}_0^{\pm} \mathcal{F}_n^{\pm} \subseteq \mathcal{F}_n^{\pm}$  for all  $n \geq 0$  from Lemma [5.3.](#page-20-0) To show  $\mathcal{F}_m^{\pm} \mathcal{F}_n^{\pm} \subseteq \mathcal{F}_{m+n}^{\pm}$  for all  $m, n \geq 0$ , it suffices to show  $F_m^{\pm} F_n^{\pm} \subseteq F_{m+n}^{\pm}$ . By Lemma [5.3,](#page-20-0) it is easy to show that  $F_1^{\pm} F_n^{\pm} \subseteq F_{n+1}^{\pm}$  for all  $n \geq 0$ . Consequently,  $F_2^{\pm} F_n^{\pm} \subseteq (\sum F_1^{\pm} F_1^{\pm}) F_n^{\pm} \subseteq F_{n+2}^{\pm}$ . By induction on m, we have  $F_m^{\pm}F_n^{\pm} \subseteq (\sum_{s,t \leq m} F_s^{\pm}F_t^{\pm})F_n^{\pm} \subseteq F_{m+n}^{\pm}$ , using Lemma [5.4.](#page-20-1) Thus  $\{\mathcal{F}_n^{\pm}\}_{n=0}^{\infty}$  is an algebra filtration. Now we show  $\Delta(\mathcal{F}_n^{\pm}) \subseteq \sum_{\ell=0} \mathcal{F}_{n-\ell}^{\pm} \otimes \mathcal{F}_{\ell}^{\pm}$ . By induction on n, we obtain that

$$
\Delta(\mathcal{F}_n^{\pm}) \subseteq \Delta(\sum_{\substack{s+t=n\\s,t
$$
\subseteq \sum_{s_1+t_1+s_2+t_2=n} \mathcal{F}_{s_1+t_1}^{\pm} \otimes \mathcal{F}_{s_2+t_2}^{\pm} = \sum_{\ell=0}^n \mathcal{F}_{n-\ell}^{\pm} \otimes \mathcal{F}_{\ell}^{\pm}.
$$
$$

$$
\qquad \qquad \Box
$$

Thus  $\{\mathcal{F}_n^{\pm}\}_{n=0}^{\infty}$  is a coalgebra filtration. To show  $\{\mathcal{F}_n^{\pm}\}_{n=0}^{\infty}$  is a Hopf filtration it remains to show  $S(\mathcal{F}_n^{\pm}) \subseteq \mathcal{F}_n^{\pm}$ . Note that  $\sum_{\ell=0}^n S(\mathcal{F}_{n-\ell}^{\pm})\mathcal{F}_{\ell}^{\pm} = \mathbb{k}1$ . It is clear that  $S(\mathcal{F}_0^{\pm}) \subseteq \mathcal{F}_0^{\pm}$ . For  $n \geq 1$ , by induction on  $n$ , we obtain:

$$
S(\mathcal{F}_n^{\pm})\mathcal{F}_0^{\pm} = \mathbb{k}1 + \sum_{\ell=1}^n S(\mathcal{F}_{n-\ell}^{\pm})\mathcal{F}_{\ell}^{\pm} \subseteq \mathbb{k}1 + \sum_{\ell=1}^n \mathcal{F}_{n-\ell}^{\pm} \mathcal{F}_{\ell}^{\pm} \subseteq \mathcal{F}_n^{\pm}.
$$

<span id="page-21-0"></span>**Lemma 5.6.** Assume char  $\mathbb{k} = 0$ . Then  $\mathcal{F}_1^{\pm}$  is the first term of the coradical filtration of  $\overline{\mathcal{T}}_{\pm 1}^{cop}$  $\frac{\mu}{\pm 1}$ .

*Proof.* By the Taft-Wilson Theorem, it suffices to show that any non-trivial  $(x^N, 1)$ -skew primitive elements of  $\overline{\mathcal{T}}_{+1}^{cop}$  $_{\pm 1}^{cop}$  is contained in  $F_1^{\pm}$  for  $N \geq 0$ . It is clear that  $\mathcal{P}_{x,1}(\overline{\mathcal{T}}_{\pm 1}^{cop})$  $\zeta_{\pm 1}^{cop}$  = k{1 - x, y, x<sub>1</sub>}. Let z be a non-trivial  $(x^N, 1)$ -skew primitive element for  $N \geq 2$ . Since  $z_2 = x_2 - \frac{3}{2}$  $\frac{3}{2}x_{1}^{2}\in\mathcal{P}_{x^{2},1}(\overline{\mathcal{T}}_{\pm 1}^{cop})$  $\binom{top}{\pm 1}$  it is enough to show that  $N = 2$  and  $z = \alpha z_2$  for some  $0 \neq \alpha \in \mathbb{R}$ .

Note that  $\{y^r x_{i_m}^{s_{i_m}}\}$  $\frac{s_{i_m}}{i_m} \cdots x_{i_1}^{s_{i_1}}$  $s_{i_1}^{s_{i_1}} x^s | r, s_{i_m}, \ldots, s_{i_1} \geq 0, s \in \mathbb{Z}, i_m > \ldots > i_1 \geq 1$  is a basis of  $\overline{\mathcal{T}}^{\text{cop}}_{\pm 1}$  $_{\pm 1}^{cop}$ . It follows that

$$
z = \sum_{\substack{r+Ns_N+\ldots+s_1=N\\r,s_N,\ldots,s_1\geq 0}} k_{r,s_N,\ldots,s_1} y^r x_N^{s_N} \cdots x_1^{s_1}.
$$

By Formula [\(4\)](#page-4-0), we have

$$
\Delta(z) = \sum_{\substack{r+N s_N + \ldots + s_1 = N \\ r, s_N, \ldots, s_1 \geq 0}} k_{r, s_N, \ldots, s_1} (y^r \otimes 1 + \sum_{k=1}^{n-1} \mathcal{SH}_{n-k,k}(y, x) \otimes y^k + x^r \otimes y^r)
$$

$$
\cdot (x_N^{s_N} \cdots x_1^{s_1} \otimes 1 + \ldots + x^{N-r} \otimes x_N^{s_N} \cdots x_1^{s_1}).
$$

Thus, if  $r \neq 0$ , then we obtain

$$
\sum_{\substack{r+Ns_N+\ldots+s_1=N\\r,s_N,\ldots,s_1\geq 0}} k_{r,s_N,\ldots,s_1} x^r x_N^{s_N}\cdots x_1^{s_1} = 0.
$$

Thus  $k_{r,s_N,...,s_1} = 0$  for all  $s_N,...,s_1$  and so  $z = \sum_{Ns_N+\ldots+s_1=N} \ell_{s_N,...,s_1} x_N^{s_N} \cdots x_1^{s_1}$ . Let  $N \geq 2$ . We focus on the terms of the forms  $x^{N-1}x \otimes x_1$  and  $x_1x^{N-1} \otimes x_{N-1}$  in  $\Delta(z)$ . They only occur in  $\Delta(\ell_{1,0,...,0}x_N)$  and  $\Delta(\ell_{0,1,0,...,1}x_{N-1}x_1)$ . We make the calculation:

$$
\Delta(x_N) = x_N \otimes 1 + ((N+1)x_{N-1} + {N+1 \choose 2} x_{N-2}x_1 + ... )x \otimes x_1 + ... + {N+1 \choose 2} x_1 x^{N-1} \otimes x_{N-1} + x^N \otimes x_N ,
$$
  

$$
\Delta(x_{N-1}x_1) = x_{N-1}x_1 \otimes 1 + x_{N-1}x \otimes x_1 + ... + x_1x^{N-1} \otimes x_{N-1} + x^N \otimes x_{N-1}x_1.
$$

If  $N = 2$ , then  $z = \alpha z_2$  for some  $0 \neq \alpha \in \mathbb{k}$ . If  $N \geq 3$ , then

$$
\ell_{1,0,\dots,0}(N+1) + \ell_{0,1,0,\dots,1} = 0,
$$
  

$$
\ell_{1,0,\dots,0}\binom{N+1}{2} + \ell_{0,1,0,\dots,1} = 0.
$$

Since char  $\mathbb{k} = 0$ , we have  $\ell_{1,0,\dots,0} = \ell_{0,1,0,\dots,1} = 0$ . Thus  $z = \sum_{(N-2)s_{N-2}+\dots+s_1=N} \ell_{0,0,s_{N-2},\dots,s_1}$  $x_{N-2}^{s_{N-2}}$  $S_{N-2}^{s_{N-2}} \cdots x_1^{s_1}$ . Now, if  $N=3$ , then  $z=\ell_{0,0,3}x_1^3$  is not primitive because char  $\mathbb{k}=0$ . Thus  $\ell_{0,0,3}=0$ . If  $N \geq 4$ , then we focus on the terms of the form  $\log x_{N-2}$  in  $\Delta(z)$ . Observe that they only occur in  $\Delta(\ell_{0,0,1,...,1,0}x_{N-2}x_2)$  and  $\Delta(\ell_{0,0,1,...,0,2}x_{N-2}x_1^2)$ . Then

$$
\ell_{0,0,1,\dots,1,0} x_2 x^{N-2} + \ell_{0,0,1,\dots,0,2} x_1^2 x^{N-2} = 0.
$$

Thus  $\ell_{0,0,1,\dots,1,0} = \ell_{0,0,1,\dots,0,2} = 0$  and  $z = \sum_{(N-3)s_{N-3}+\dots+s_1=N} \ell_{0,0,s_{N-3},\dots,s_1} x_{N-3}^{s_{N-3}}$  $s_{N-3} \cdots x_1^{s_1}$ . Similarly, we obtain inductively  $\ell_{s_N,...,s_1} = 0$  for all  $s_N,...,s_1$  such that  $Ns_N + ... + s_1 = N$ . Thus  $z = 0$  if  $N \geq 3$ . Therefore,  $N = 2$  and  $z = \alpha z_2$  for  $0 \neq \alpha \in \mathbb{k}$ .

Let  $gr_{\mathcal{F}^{\pm}}(\overline{\mathcal{T}}_{\pm 1}^{cop}$  $_{\pm 1}^{cop}$ ) be the graded Hopf algebra associated to the filtration  $\{\mathcal{F}_n^{\pm}\}_{n=0}^{\infty}$ .

<span id="page-22-1"></span>Theorem 5.7.  $\mathrm{gr}_{\mathcal{F}^{\pm}}(\overline{\mathcal{T}}_{\pm 1}^{cop}$  $\sum_{\pm 1}^{cop}$ ) ≅ B $_{\pm}$ #\kZ, where B $_{\pm}$  is a braided Hopf algebra in  $\frac{\text{kZ}}{\text{kZ}}$  $\mathcal{YD}$  determined by

[x_1, z_n] = 0, \qquad [z_n, z_m] = 0, \qquad 2 \le n < m.
$$

(39) 
$$
x \cdot x_1 = x_1, \qquad x \cdot y = y + x_1, \qquad x \cdot z_n = z_n, \qquad n \ge 2
$$

(40) 
$$
\rho(x_1) = x \otimes x_1, \qquad \rho(y) = x \otimes y, \qquad \rho(z_n) = x^n \otimes z_n, \qquad n \ge 2.
$$

If char  $\mathbb{k} = 0$ , then  $B_{\pm}$  is the Nichols algebra of  $V_{1,2} = \mathbb{k} \{y, z_2, x_1\} \in \mathbb{k} \mathbb{Z} \mathcal{Y} \mathcal{D}$ .

*Proof.* Note that  $z_n \in \mathcal{F}_{n-1}^{\pm}$  for  $n \geq 2$ . Then, by Lemma [5.3,](#page-20-0) the relations of  $gr_{\mathcal{F}}(\overline{\mathcal{T}}_{\pm 1}^{cop})$  $\binom{top}{\pm 1}$  are determined by [\(33\)](#page-20-2), [\(37\)](#page-22-0) and [\(36\)](#page-20-3).

Thus  $gr_{\mathcal{F}}(\overline{\mathcal{T}}_{\pm 1}^{cop})$  $\frac{cap}{\pm 1}) \cong B_{\pm} \# \mathbb{K} \mathbb{Z}$  by Lemma [5.1.](#page-19-0) Observe that  $B_{\pm}$  is generated by  $B(1) = V_{1,2}$ . If char  $\mathbb{k} = 0$ , then  $\mathcal{P}(B_{\pm}) = B_{\pm}(1) = V_{1,2}$  by Lemma [5.6.](#page-21-0) Therefore,  $B_{\pm} \cong \mathcal{B}(V_{1,2})$ .

<span id="page-22-3"></span>Corollary 5.8. Assume char  $\Bbbk = 0$ . Then  $\{\mathcal{F}_n^{\pm}\}_{n=0}^{\infty}$  is the coradical filtration of  $\overline{\mathcal{T}}_{\pm 1}^{cop}$  $\sum_{\pm 1}^{cop}$  (and  $\mathcal{T}_{\pm 1}$ ).

*Proof.* Note that the coradical filtration of  $\overline{\mathcal{T}}_{+1}^{cop}$  $\frac{\text{cop}}{\pm 1}$  is also the coradical filtration of  $\mathcal{T}_{\pm 1}$ . Thus the claim follows directly from Theorem [5.7.](#page-22-1)

<span id="page-22-4"></span>**Remark 5.9.** (i) With the notations in Theorem [5.7,](#page-22-1) using the formula of the braiding in  $\frac{k\Z}{k\Z}$  $\mathcal{YD}$ , we have the braided matrix of  $V_{1,2}$  given by

$$
c\left(\begin{array}{cccc} x_1\otimes x_1 & x_1\otimes y & x_1\otimes z_2 \\ y\otimes x_1 & y\otimes y & y\otimes z_2 \\ z_2\otimes x_1 & z_2\otimes y & z_2\otimes z_2 \end{array}\right)=\left(\begin{array}{cccc} x_1\otimes x_1 & (y+x_1)\otimes x_1 & z_2\otimes x_1 \\ x_1\otimes y & (y+x_1)\otimes y & z_2\otimes y \\ x_1\otimes z_2 & (y+2x_1)\otimes z_2 & z_2\otimes z_2 \end{array}\right).
$$

Hence  $\Bbbk\{x_1,y\}$  is of Jordan type (see e.g. [\[11\]](#page-25-27) and [\[1\]](#page-25-7)). The braiding of  $V_{1,2}$  also appeared in [\[1,](#page-25-7) Section 4.1.1] with the ghost equal to  $-4$ . If char  $k = 0$ ,  $\mathcal{B}(V_{1,2}) \cong B_{\pm}$  has infinite GK-dimension and its defining relations are given by relations [\(37\)](#page-22-0) and [\(38\)](#page-22-2).

(ii) Let  $z'_2 := z_2$  and  $z'_{n+1} := [y, z'_n]_c = yz'_n - (y_{(-1)} \cdot z'_n)y_{(0)}$  for  $n \ge 2$ . It is clear that  $z'_{n+1} =$  $yz'_{n} - (x \cdot z'_{n})y = [y, z'_{n}]$ . Set  $z_{0} = z_{1} = 0$ . We can prove that

(41) 
$$
z'_{n} = (-1)^{n} (z_{n} - (n+1)z_{n-1}x_{1} + \frac{n(n+1)}{2}z_{n-2}x_{1}^{2}), \qquad n \ge 2.
$$

In case char  $\mathbb{k} = 0$ , the relations of  $B_{\pm}$  (or  $\mathcal{B}(V_{1,2})$ ) are equivalent to

$$
x_1y = yx_1 + \frac{1}{2}x_1^2, \qquad yz_n' = z_n'y + z_{n+1}', \qquad n \ge 2,
$$
  

$$
x_1z_n' = z_n'x_1, \qquad z_n'z_m' = z_m'z_n', \qquad 2 \le n \le m.
$$

Let  $c_{n,k} \in \mathbb{k}$  for  $1 \leq k \leq n+1$ ,  $c_{n,n} := 1$  and  $c_{n,1} = c_{n,n+1} = 0$ . Then

$$
\Delta(z'_n) = z'_n \otimes 1 + \sum_{k=2}^n c_{n,k} x_1^{n-k} \otimes z'_k,
$$

where  $c_{n,k}$  is determined by the recursion:

$$
c_{n,k} = c_{n-1,k-1} - \frac{n-1+k}{2}c_{n-1,k}, \qquad 2 \le k \le n.
$$

More precisely,

(42) 
$$
c_{n,k} = \left(-\frac{1}{2}\right)^{n-k} {n-2 \choose k-2} (k+2)(k+3)\cdots (n+1), \qquad 2 \le k \le n-1.
$$

**Remark 5.10.** In case char  $\mathbb{k} = p > 0$ ,  $B_{\pm}$  is not a Nichols algebra of  $V_{1,2}$ .

Let  $\mathcal{F}_n^{\text{FdB}} := F_n^{\text{FdB}} \mathbb{k}[x^{\pm 1}]$  for  $n \geq 0$ , where F FdB  $n^{\text{rGB}} =$  $\triangle$ 

$$
F_n^{\text{FdB}} = \bigoplus_{\substack{(i_m-1)s_m+\ldots+(i_2-1)s_2+s_1\leq n,\\i_m>\ldots>i_2\geq 2}} k z_{i_m}^{s_m} \cdots z_{i_2}^{s_2} x_1^{s_1}
$$

For example,

$$
\mathcal{F}_0^{\text{FdB}} = \mathbb{k}[x^{\pm 1}],
$$
  
\n
$$
\mathcal{F}_1^{\text{FdB}} = (\mathbb{k}1 \oplus \mathbb{k}z_2 \oplus \mathbb{k}x_1)\mathbb{k}[x^{\pm 1}],
$$
  
\n
$$
\mathcal{F}_2^{\text{FdB}} = (\mathbb{k}1 \oplus \mathbb{k}z_2 \oplus \mathbb{k}x_1 \oplus \mathbb{k}z_3 \oplus \mathbb{k}z_2^2 \oplus \mathbb{k}z_2x_1 \oplus \mathbb{k}x_1^2)\mathbb{k}[x^{\pm 1}].
$$

It is clear that  $\mathcal{F}_0^{\text{FdB}} \subseteq \mathcal{F}_1^{\text{FdB}} \subseteq \ldots \subseteq \mathcal{F}_n^{\text{FdB}} \subseteq \ldots \subseteq \mathcal{H}_{\text{FdB}}^{cop}.$ 

**Corollary 5.11.** Assume char  $\mathbb{k} = 0$ . Then  $\{\mathcal{F}_n^{\text{FdB}}\}_{n=0}^{\infty}$  is the coradical filtration of  $\mathcal{H}_{\text{FdB}}^{cop}$  (and  $\mathcal{H}_{\text{FdB}}$ ).

*Proof.* Note that  $\mathcal{F}_n^{\text{FdB}} = \mathcal{H}_{\text{FdB}}^{cop} \cap \mathcal{F}_n^{\pm}$  for all  $n \geq 0$ . Thus the claim follows from [\[25,](#page-25-21) Corollary 4.2.2] (a)] and Corollary [5.8.](#page-22-3)  $\Box$ 

# 5.3. The coradical filtration of  $\overline{\mathcal{T}}_p(p;1,\ldots,1)$ .

We study the coradical filtration of  $\overline{\mathcal{T}}_p(p; 1, \ldots, 1)$ . Let  $\pi_{\pm} : \overline{\mathcal{T}}_{\pm 1}^{cop} \to \overline{\mathcal{T}}_p(p; 1, \ldots, 1)^{cop}$  be the projection. If there is no confusion, we still write x for  $\pi_{\pm}(x)$ ,  $\forall x \in \overline{\mathcal{T}}^{\pm}$ .

Let  $\mathcal{F}_n = \pi_{\pm}(\mathcal{F}_n^{\pm})$ . Then  $\mathcal{F}_n := F_n \mathbb{k}[x]/(x^p)$ , where  $F_n =$  $r+(i_{m}-1)s_{m}+...+(i_{2}-1)s_{2}+s_{1}\leq n,$ <br> $i_{m}>\ldots>\overline{i_{2}}\geq2$  $\mathbb{R}y^r z_{i_m}^{s_m} \cdots z_{i_2}^{s_2}$  $\frac{s_2}{i_2}x_1^{s_1}$ 

**Lemma 5.12.** The filtration  $\{\mathcal{F}_n\}_{n=0}^{\infty}$  is a Hopf algebra filtration of  $\overline{\mathcal{T}}_p(p;1,\ldots,1)^{cop}$ .

*Proof.* It is similar to the proof of Lemma [5.5.](#page-20-4)

<span id="page-23-0"></span>**Lemma 5.13.** Assume char  $\mathbb{k} = p > 3$ . Then  $\mathcal{F}_1$  is the first term of the coalgebra filtration of  $\overline{\mathcal{T}}_p(p;1,\ldots,1)^{cop}.$ 

*Proof.* By the Taft-Wilson Theorem, it suffices to show that any non-trivial  $(x^N, 1)$ -skew primitive element is contained in  $F_1$ , where  $0 \leq N < p$ . It is clear that  $\mathcal{P}_{x,1}(\overline{\mathcal{T}}_p(p; 1, \ldots, 1)^{cop}) = \mathbb{k}{1-x, y, x_1}.$ Let  $z \in \mathcal{P}_{x^N,1}(\overline{\mathcal{T}}_p(p;1,\ldots,1)^{cop})$  for  $2 \leq N < p$ . It remains to show that  $z = 0$  if  $3 \leq N \leq p-1$ ; and  $z = \alpha z_2$  for some  $\alpha \neq 0$  if  $N = 2$ . Note that  $\{y^r x_{p-2}^{s_{p-2}}\}$  $_{p-2}^{s_{p-2}}$  …  $x_1^{s_1}x^s$  | 0 ≤ r,  $s_{p-2}, \ldots, s_1, s$  ≤ p - 1} is a basis of  $\mathcal{T}_p(p; 1, 1, \ldots, 1)^{cop}$ . The rest is similar to the proof of Lemma [5.6.](#page-21-0) Let  $gr_{\mathcal{F}}(\overline{\mathcal{T}}_p(p;1,\ldots,1)^{cop})$  be the graded Hopf algebra associated to the filtration  $\{\mathcal{F}_n\}_{n=0}^{\infty}$ .

<span id="page-24-0"></span>**Theorem 5.14.** Assume char k = p > 3. Then  $gr_{\mathcal{F}}(\overline{\mathcal{T}}_p(p; 1, ..., 1)^{cop}) \cong B \# \mathbb{k} \mathbb{Z}_p$ , where B is of dimension  $p^{p-1}$ , determined by

$$
[x_1, y] = \frac{1}{2}x_1^2, \t [z_n, y] = -z_nx_1 - \frac{n(n+1)!}{2^n}z_2x_1^{n-1} + z_{n+1}, \t 2 \le n \le p-2, \t z_{p-1} = 0,
$$
  
\n
$$
[x, x_1] = 0, \t [x, z_n] = 0, \t [z_1, z_n] = 0, \t [z_n, z_m] = 0, \t 2 \le n \le m \le p-2,
$$
  
\n
$$
x_1^p = 0, \t y^p = 0, \t z_n^p = 0, \t 2 \le n \le p-2,
$$
  
\n
$$
x \cdot x_1 = x_1, \t x \cdot y = y + x_1, \t x \cdot z_n = z_n, \t 2 \le n \le p-2,
$$
  
\n
$$
\rho(x_1) = x \otimes x_1, \t \rho(y) = x \otimes y, \t \rho(z_n) = x^n \otimes z_n, \t 2 \le n \le p-2.
$$

Furthermore,  $B \cong \mathcal{B}(V_{1,2})$ , where  $V_{1,2} = \mathbb{k}\{y, z_2, x_1\} \in \frac{\mathbb{k}\mathbb{Z}_p}{\mathbb{k}\mathbb{Z}_p}\mathcal{Y}\mathcal{D}$ .

*Proof.* Similar to the proof of Theorem [5.7,](#page-22-1) we have  $gr_{\mathcal{F}}(\overline{\mathcal{T}}_p(p; 1, \ldots, 1)^{cop}) \cong B \# \mathbb{k}\mathbb{Z}_p$ . It is clear that B is generated by  $B(1) = V_{1,2}$ . By Lemma [5.13,](#page-23-0)  $\mathcal{P}(B) = B(1) = V_{1,2}$ . Therefore,  $B \cong \mathcal{B}(V_{1,2})$ .

**Remark 5.15.** With the notations in Remark [5.9](#page-22-4) (ii), if char  $k = p > 3$ , then the relations of  $\mathcal{B}(V_{1,2})$ are equivalent to

$$
x_1y = yx_1 + \frac{1}{2}x_1^2, \t yz'_n = z'_ny + z'_{n+1}, \t 2 \le n \le p-2,
$$
  
\n
$$
z'_{p-1} = 0, \t x_1z'_n = z'_nx_1, \t z'_nz'_m = z'_mz'_n, \t 2 \le n \le m \le p-2,
$$
  
\n
$$
x_1^p = 0, \t y^p = 0, \t z_n'^p = 0, \t 2 \le n \le p-2.
$$

We mention that this braided Hopf algebra has already appeared in [\[2,](#page-25-8) Proposition 4.10].

Note that when char  $k = 0$ ,  $\mathcal{B}(V_{1,2})$  is of infinite GK-dimension, while  $\mathcal{B}(V_{1,2})$  is finite-dimensional if char  $k = p > 3$ .

Remark 5.16. If char k = 3, then  $\overline{T}_3(3;1) \cong \text{gr}(\overline{T}_3(3;1)) \cong \mathcal{B}(V) \# \mathbb{k} \mathbb{Z}_3$ , where  $V = \mathbb{k}y \oplus \mathbb{k}x_1$  and  $\mathcal{B}(V)$  is determined by

$$
x_1y = yx_1 + \frac{1}{2}x_1^2
$$
,  $x_1^3 = 0$ ,  $y^3 = 0$ .

We mention that  $\overline{T}_3(3;1)$  has appeared in [\[11,](#page-25-27) Corollary 3.14], and its Nichols algebra is of Jordan type (see also [\[11,](#page-25-27) Theorem 3.5] and [\[3,](#page-25-26) Section 3.5]).

**Corollary 5.17.** Assume char  $\mathbb{k} = p > 3$ . Then  $\{\mathcal{F}_n\}_{n=0}^{\infty}$  is the coalgebra filtration of  $\overline{\mathcal{T}}_p(p; 1, \ldots, 1)$ <sup>cop</sup>  $(and \overline{\mathcal{T}}_p(p; 1, \ldots, 1)).$ 

*Proof.* It follows directly from Theorem [5.14.](#page-24-0)
