# PROPERTIES OF FIRST PASSAGE PERCOLATION ABOVE THE (HYPOTHETICAL) CRITICAL DIMENSION

#### Abstract

It is not known (and even physicists disagree) whether first passage percolation (FPP) on $\mathbb{Z}^{d}$ has an upper critical dimension $d_{c}$, such that the fluctuation exponent $\chi=0$ in dimensions $d>d_{c}$. In part to facilitate study of this question, we may nonetheless try to understand properties of FPP in such dimensions should they exist, in particular how they should differ from $d<d_{c}$. We show that at least one of three fundamental properties of FPP known or believed to hold when $\chi>0$ must be false if $\chi=0$. A particular one of the three is most plausible to fail, and we explore the consequences if it is indeed false. These consequences support the idea that when $\chi=0$, passage times are "local" in the sense that the passage time from $x$ to $y$ is primarily determined by the configuration near $x$ and $y$. Such locality is manifested by certain "disc-to-disc" passage times, between discs in parallel hyperplanes, being typically much faster than the fastest mean passage time between points in the two discs.


## 1. Introduction

The study of first passage percolation (FPP) on $\mathbb{Z}^{d}$ suffers from the fact that many of the most fundamental properties presumed to hold, which should be the foundation for many other proofs, have resisted proof. Open problems of this type include:
(1) Do the fluctuation and wandering exponents $\chi, \xi$ exist, and do they take their conjectured (KPZ) values $1 / 3,2 / 3$ for $d=2$ ?
(2) Is there a finite upper critical dimension $d_{c}$, above which the fluctuation exponent $\chi=0$ ?
(3) When edge passage times have an exponential moment, is there an exponential bound on the scale of the standard deviation, for deviations of these passage times?
(4) Does the limit shape have nondegenerate curvature in all directions?

Various authors have dealt with this situation in different ways. One approach is to prove far-fromoptimal (yet still difficult) results, for example that the variance of passage times over distance $n$ is at least of order $\log n$ [13], or that for fixed $k$, for a special class of passage time distributions, the limit shape cannot be a polygon with fewer than $k$ sides [17], both for $d=2$. A second approach, taken in [2], [3], [29], and for non-integrable LPP in [21], is to prove conditional results, assuming certain fundamental unproven properties like (3) and/or (4) above, and showing that more delicate properties follow from them. A third option is to explore interrelations among the fundamental properties, which does not require knowing or assuming which ones are true; this third option, and in part the second option, are our primary approaches in this paper. In particular we show that at least one of three fundamental properties believed to hold in dimensions below $d_{c}$ is false above $d_{c}$. We then move into conditional-result mode, to explore the consequences if the property which

seems the clear candidate to fail above $d_{c}$ indeed does so. This gives some insight into the question, "if $d_{c}$ is finite, how should we expect FPP in dimensions above and below $d_{c}$ to differ?"

The question of a finite $d_{c}$ or not is particularly challenging, as even physicists do not agree. Informally, $\chi$ is the exponent for which the variance of the passage time over distance $n$ grows like $n^{2 \chi}$. Heuristics and simulations suggest that $\chi$ should decrease with dimension; simulations in [30] for a model believed to be in the same (KPZ) universality class as FPP show a decrease from $\chi=.33$ to $\chi=.054$ as $d$ increases from 2 to 7 . In general, some calculations (e.g. renormalization group) seem to predict the existence of a finite upper critical dimension, possibly as low as 3.5 , above which $\chi=0$ ([19], [26]); in contrast, various simulations suggest that $\chi$ may be positive for all $d([4,, 28])$, with those in [24] showing $\chi>0$ all the way to $d=12$, decaying approximately as $1 /(d+1)$. So it is possible that the primary question we are exploring is vacuous $\left(d_{c}=\infty\right)$, but in that case an understanding of the hypothetical nature of FPP above $d_{c}$ could lead to insights as to why such dimensions do not exist.

It is known that on certain large graphs, including for example Galton-Watson trees [16] and the product of a rooted $d$-regular tree and $\mathbb{Z}([9],[10)$, the centered passage time distributions over various distances $n$ form a tight sequence, which of course is stronger than just $\chi=0$. (In the Galton-Watson case this is for point-to-sphere times, not point-to-point.) On other large graphs these distributions yield tight sequences after dividing by $\log n$; examples include the product of an unrooted $d$-regular tree with $\mathbb{Z}[9$. On the Galton-Watson tree the tightness may be attributed to the fact that the point-to-sphere time from the root is mostly determined by edge passage times within a bounded distance of the root. All this makes it somewhat plausible that indeed as the dimension grows, $\mathbb{Z}^{d}$ becomes a large enough graph that it, too, has $\chi=0$, or at least that $\chi \rightarrow 0$ as the dimension grows. It is not clear whether passage times should be tight if $\chi=0$, or whether point-to-point passage times should be determined primarily near the path endpoints as on the Galton-Watson tree; this "local," or "near the endpoints," aspect is what we will attempt to shed preliminary light on, in the present work.

Remark 1.1. There is the question of how this localness can be manifested quantifiably for FPP in $\mathbb{Z}^{d}$, which we approach as follows. Consider two parallel hyperplanes, tangent to a multiple of the limit shape at opposite points $x$ and $-x$. Consider discs $D_{x}$ and $D_{-x}$ in these hyperplanes, centered at $\pm x$, having radius that is small relative to the usual transverse wandering of the geodesic $\Gamma_{-x, x}$. Let $\hat{\sigma}(2 x)$ be the standard deviation of the passage time $T(-x, x)$ from $-x$ to $x$. The small radius of the discs means that for $p, p^{\prime} \in D_{-x}$ and $q, q^{\prime} \in D_{x}$ the geodesics $\Gamma_{p q}$ and $\Gamma_{p^{\prime} q^{\prime}}$ may coincide for most of their length, along all but short sections near their endpoints. If passage times are nonlocal (as expected at least below $d_{c}$ ) then this coinciding means the passage times $T(p, q)$ and $T\left(p^{\prime}, q^{\prime}\right)$ are typically nearly equal, within a small multiple of $\hat{\sigma}(2 x)$. Therefore the disc-to-disc passage time $\min _{p, q} T(p, q)$ is typically close (again, within a small multiple of $\hat{\sigma}(2 x)$ ) to any given point-to-point passage time $T(p, q)$. By contrast, if passage times are local, then $T(p, q)$ and $T\left(p^{\prime}, q^{\prime}\right)$ are primarily determined by the non-coinciding portions of the geodesics, so these two passage times are nearly independent, if $\left|p-p^{\prime}\right|$ and $\left|q-q^{\prime}\right|$ are not too small. There are then many nearly-independent point-to-point passage times $T(p, q)$ between the discs, so at least some point-to-point passage times between $D_{-x}$ and $D_{x}$, and thus also the disc-to-disc passage time, will likely be much faster than the typical (i.e. mean) point-to-point passage time, meaning faster by a large multiple of $\hat{\sigma}(2 x)$. Such a large gap between mean point-to-point and mean disc-to-disc passage times thus manifests localness, and is what we establish, at least conditionally in the sense described above.
1.1. Some definitions. Let $\mathbb{E}^{d}$ denote the set of all edges (i.e. nearest-neighbor pairs) of $\mathbb{Z}^{d}$. The passage times of edges are a collection of nonnegative iid variables $\tau=\left\{\tau_{e}: e \in \mathbb{E}^{d}\right\}$. The passage time of a finite lattice path $\gamma$ (always taken self-avoiding) is

T(\gamma):=\sum_{e \in \gamma} \tau_{e},
$$

and the passage time from $x$ to $y$ is

$$
\begin{equation*}
T(x, y):=\inf \left\{T(\gamma): \gamma \text { is a path from } x \text { to } y \text { in } \mathbb{Z}^{d}\right\} . \tag{1.1}
\end{equation*}
$$

To avoid notational clutter, for general $x, y \in \mathbb{R}^{d}$ we define $T(x, y)$ to be $T(\hat{x}, \hat{y})$, where $\hat{x}, \hat{y}$ are the closest lattice points to $x$ and $y$ respectively, with ties broken by some arbitrary translationinvariant rule. A path $\gamma$ achieving the infimum in (1.1) is called a geodesic from $x$ to $y$. Assuming $\tau_{e}$ is a continuous r.v., a unique geodesic exists a.s. for each $x, y$ [32], and we denote it $\Gamma_{x y}$. From subadditivity, the limit

g(x)=\lim _{n} \frac{E T(0, x)}{n}
$$

exists for all $x \in \mathbb{Z}^{d}$; by considering only $n$ for which $n x \in \mathbb{Z}^{d}$ we may extend this definition to $x \in \mathbb{Q}^{d}$, and then to a norm on $\mathbb{R}^{d}$ by continuity; see [5]. Define also

h(x)=E T(0, x), \quad x \in \mathbb{Z}^{d}
$$

Throughout the paper, $c_{0}, c_{1}, \ldots$ and $\epsilon_{0}, \epsilon_{1}, \ldots$ are constants which depend only on the dimension and the distribution of the passage times $\tau_{e}$, unless otherwise specified.

A function $f \geq 0$ on $\mathbb{Z}^{d}$ is magnitude-based if there exists $f_{\text {mag }}:[1, \infty) \rightarrow[0, \infty)$ and $c_{1}>0$ with

c_{1}^{-1} f_{\text {mag }}(r) \leq f(x) \leq c_{1} f_{\text {mag }}(r) \text { whenever } \frac{r}{2} \leq|x| \leq 2 r . \tag{1.2}
\end{equation*}

Then fixing $r \geq 1$ and $1 \leq \alpha \leq 2$, and taking $x$ with $|x|$ close enough to $r$, we get that $c_{1}^{-1} f_{\text {mag }}(r) \leq$ $f(x) \leq c_{1} f_{\text {mag }}(\alpha r)$ and $c_{1}^{-1} f_{\text {mag }}(\alpha r) \leq f(x) \leq c_{1} f_{\text {mag }}(r)$, so $f_{\text {mag }}$ satisfies

c_{1}^{-2} f_{\text {mag }}(r) \leq f_{\text {mag }}(\alpha r) \leq c_{1}^{2} f_{\text {mag }}(r) \text { for all } r \geq 1,1 \leq \alpha \leq 2 . \tag{1.3}

Therefore there exist $c_{2}, \kappa \geq 1$ such that

For general functions $f:[0, \infty) \rightarrow(0, \infty)$, we say $f$ has growth exponent $\chi \geq 0$ if

\end{equation*}

We say $f$ has regular growth exponent $\chi \geq 0$ if

\lim _{\alpha, r \rightarrow \infty}\left|\frac{\log f(\alpha r)-\log f(r)}{\log (\alpha r)-\log r}-\chi\right|=0 \tag{1.6}
\end{equation*}

and for all $\beta>0$,

\liminf _{r \rightarrow \infty} \inf _{1 \leq \alpha \leq \beta}[\log f(\alpha r)-\log f(r)]>-\infty, \quad \limsup _{r \rightarrow \infty} \sup _{1 \leq \alpha \leq \beta}[\log f(\alpha r)-\log f(r)]<\infty \tag{1.7}
\end{equation*}

We can restate (1.6) and 1.7) as: for every $\epsilon>0$ there exist $\beta, r_{0}, c_{3}$ such that

r \geq r_{0} \Longrightarrow \begin{cases}\alpha^{\chi-\epsilon} \leq \frac{f(\alpha r)}{f(r)} \leq \alpha^{\chi+\epsilon} & \text { if } \alpha \geq \beta  \tag{1.8}\\ c_{3}^{-1} \leq \frac{f(\alpha r)}{f(r)} \leq c_{3} & \text { if } 1 \leq \alpha<\beta\end{cases}
$$

The following is an enhancement of a result in [3]; it is proved in Section 5 .
Lemma 1.2. Suppose $f:[1, \infty) \rightarrow(0, \infty)$ has growth exponent $\chi=0$ and for some $c, \kappa, \delta>0$ satisfies

f(r) \geq \delta, \quad c^{-1} \alpha^{-\kappa} f(r) \leq f(\alpha r) \leq c \alpha^{\kappa} f(r) \text { for all } \alpha, r \geq 1 \tag{1.9}

Then there exists $f_{u p}:[1, \infty) \rightarrow(0, \infty)$ with regular growth exponent $\chi=0$ satisfying
(1.10) $f_{u p} \geq f, \quad \liminf _{r \rightarrow \infty} \frac{f_{u p}(r)}{f(r)}<\infty, \quad f_{u p}$ eventually nondecreasing, $\quad \frac{\log f_{u p}(r)}{\log r}$ nonincreasing.

We call an FPP model standard if the edge passage times are continuous r.v.'s with a finite exponential moment, and $P\left(\tau_{e}=0\right)<p_{c}$, where $p_{c}$ denotes the critical probability of 2-dimensional Bernoulli bond percolation.

Let

$$
\hat{\sigma}(x)=\operatorname{var}(T(0, x))^{1 / 2}, \quad \hat{\Delta}(x)=(|x| \hat{\sigma}(x))^{1 / 2}, \quad D(x)=E T(0, x)-g(x) .
$$

Note $D \geq 0$ by subadditivity of $E T(0, x)$. When $\hat{\sigma}$ is magnitude-based, we call a corresponding $\sigma_{\text {mag }}$ as in (1.2) an approximate standard deviation, respectively; we call a corresponding function from Lemma 1.2 (that is, $f_{u p}$ with $f=\sigma_{\text {mag }}$ ) an upper-regular standard deviation and denote it as $\sigma_{u p}$. From [14] (improving on [1]), for a standard FPP model, if $D$ is magnitude-based then every corresponding $D_{\text {mag }}$ satisfies

D_{\text {mag }}(r) \leq c_{4}(r \log r)^{1 / 2} \text { so } \quad \limsup _{r \rightarrow \infty} \frac{\log D_{\operatorname{mag}}(r)}{\log r} \leq \frac{1}{2} \tag{1.11}
\end{equation*}

Note that $\hat{\sigma}$ is bounded away from 0 , since passage times of edges emanating from 0 have an order- 1 influence on passage times $T(0, x)$, so any approximate standard deviation will be bounded away from 0 as well. Let $\Pi_{x y}^{\infty}$ denote the infinite line through $x$ and $y$ and let $R(x)$ be the maximum transverse wandering from $\Pi_{0 x}^{\infty}$ by the geodesic $\Gamma_{0 x}$, that is,

R(x)=\sup _{u \in \Gamma_{0 x}} d\left(u, \Pi_{0 x}^{\infty}\right)
$$

with $d(\cdot, \cdot)$ denoting Euclidean distance. When $\hat{\sigma}$ is magnitude-based, we define $\Delta_{\text {mag }}(r)=$ $\left(r \sigma_{\text {mag }}(r)\right)^{1 / 2}$ and $\Delta_{u p}(r)=\left(r \sigma_{u p}(r)\right)^{1 / 2}$; then $\Delta_{u p}$ has regular growth exponent $\xi=(1+\chi) / 2$. Let $\mathfrak{B}_{g}(x, r)$ denote the $g$-ball at $x$ of radius $r$; we abbreviate $\mathfrak{B}_{g}(0,1)$ to just $\mathfrak{B}_{g}$. $\mathfrak{B}_{g}$ is known as the limit shape, as, under mild hypotheses [12], it is the a.s. limit of the rescaled "wet region" $t^{-1}\left(\cup\left\{x+\left[-\frac{1}{2}, \frac{1}{2}\right]^{d}: T(0, x) \leq t\right\}\right)$.

For a direction (unit vector) $\theta$ let $y_{\theta}$ be the point of $\partial \mathfrak{B}_{g}$ in direction $\theta$, and let $\mathcal{H}_{\theta}$ be a supporting hyperplane to $\mathfrak{B}_{g}$ at $y_{\theta}$; when uniqueness fails the choice is arbitrary. Then for $r \in \mathbb{R}$ let $H_{\theta, r}$ be the hyperplane parallel to $\mathcal{H}_{\theta}$ through $r y_{\theta}$. At times it will be convenient to express a general $u \in \mathbb{R}^{d}$ in terms of a basis in which the first vector is $y_{\theta}$, and the other $d-1$ form an orthonormal basis for $H_{\theta, 0}$. (The particular choice of orthonormal basis does not matter.) We call these $\theta$-coordinates, and projection along $H_{\theta, 0}$ into $\Pi_{0 \theta}^{\infty}$ is called tangential $\theta$-projection and denoted $\pi_{\theta}$. Projection
along $\Pi_{0 \theta}^{\infty}$ into some $H_{\theta, r}$ is called longitudinal $\theta$-projection. (This is only truly projection when $r=0$, but we use the terminology anyway.) As noted in [2], the angle between $\theta$ and $H_{\theta, 0}$ is always at least $\arcsin 1 / \sqrt{d}$; we call this the $\arcsin$ bound. The distance from a point $x$ to a set $A$ along $H_{\theta, 0}$ is denoted $d_{\theta}(x, A)$.

We say $\theta$ is a direction of sub-curvature if there exists $\epsilon_{0}(\theta)>0$ and a value $c_{5}(\theta)$ such that for $u \in H_{\theta, 1}$ with $\left|u-y_{\theta}\right| \leq \epsilon_{0}(\theta)$ we have

g(u) \leq 1+c_{5}\left|u-y_{\theta}\right|^{2} \tag{1.12}
\end{equation*}

$\theta$ is a direction of curvature if also there exists $c_{6}(\theta)$ such that for all $u$ as above,

\begin{equation*}
g(u) \geq 1+c_{6}\left|u-y_{\theta}\right|^{2} . \tag{1.13}
\end{equation*}
$$

There is then also a $c_{7}(\theta)$ such that for $0<\epsilon \leq \epsilon_{0}(\theta)$ and $u \in H_{\theta, 1}$ with $\left|u-y_{\theta}\right| \geq \epsilon$ we have

g(u) \geq 1+c_{7} \epsilon\left|u-y_{\theta}\right| . \tag{1.14}

Provided directions of curvature exist, we may choose values $\epsilon_{0}^{*}, c_{5}^{*}, c_{6}^{*}, c_{7}^{*}$ for which

\mathcal{U}=\left\{\theta \in S^{d-1}: \theta \text { is a direction of curvature, } \epsilon_{0}(\theta) \geq \epsilon_{0}^{*}, c_{5}(\theta) \leq c_{5}^{*}, c_{6}(\theta) \leq c_{6}^{*}, c_{7}(\theta) \leq c_{7}^{*}\right\} \neq \emptyset
$$

Equivalently, we omit the $*$ in the notation and take $\epsilon_{0}, c_{5}, c_{6}, c_{7}$ as values not depending on $\theta \in \mathcal{U}$. Then, after reducing $\epsilon_{0}$ if necessary, there exists $c_{8}$ such that

\theta \in \mathcal{U},|\alpha-\theta|<\epsilon_{0} \Longrightarrow \text { the angle between } H_{\alpha, 0} \text { and } H_{\theta, 0} \text { is at most } c_{8}|\alpha-\theta| . \tag{1.15}

Convexity of $\mathfrak{B}_{g}$ means the directions of sub-curvature form a set of full (uniform) measure in the unit sphere $S^{d-1}$. By contrast, though it is believed that (outside of cases where the infimum of the support of $\tau_{e}$ has large mass, as in [18]) every $\theta$ is a direction of curvature, there is no $a$ priori reason for the existence of any directions of curvature for $\mathfrak{B}_{g}$; a polyhedron, for example, has none. We say $(\theta, x) \in S^{d-1} \times \mathbb{Z}^{d}$ is directionally good if
(a) $\theta \in \mathcal{U}$,
(b) $d\left(x, \Pi_{0 \theta}^{\infty}\right) \leq d$,
(c) $|x|^{-1 / 4}<\epsilon_{0}$.
and directionally acceptable if (a), (c) hold and
(b') $d\left(x, \Pi_{0 \theta}^{\infty}\right) \leq|x|^{1 / 5}$.
We write $\mathcal{G}$ for the set of all directionally good pairs $(\theta, x), \mathcal{G}_{\mathbb{Z}^{d}}$ for $\{x:(\theta, x) \in \mathcal{G}$ for some $\theta\}, \mathcal{A}$ for the set of all directionally acceptable pairs, and $\mathcal{A}_{\mathbb{Z}^{d}}$ for $\{x:(\theta, x) \in \mathcal{A}$ for some $\theta\}$.

Due to the arcsin bound we always have $\left|x-\pi_{\theta} x\right| \leq c_{9}$ for directionally good $(\theta, x)$ note that $x, \pi_{\theta} x$ lie in the same hyperplane $H_{\theta, g\left(\pi_{\theta} x\right)}$. Of course (c) only requires that $|x|$ be sufficiently large, so for each $\theta \in \mathcal{U}$ there exists $r_{0}(\theta)$ such that

Let $H_{\theta, r}^{+}, H_{\theta, r}^{-}$denote the halfspaces $\cup_{s \geq r} H_{\theta, s}$ and $\cup_{s \leq r} H_{\theta, s}$, respectively, and for $r \leq t$ define the slab $S_{\theta}(r, t)=\cup_{r \leq s \leq t} H_{\theta, s}$. We need to consider slab and disc-to-disc passage times. An infinite $\theta$-cylinder is a set of form $\left\{x \in \mathbb{R}^{d}: d\left(x, \Pi_{0 \theta}^{\infty}\right) \leq r\right\}$ with $\theta$ a unit vector and $r>0$. A bounded $\theta$-cylinder is the intersection of an infinite $\theta$-cylinder with a (not necessarily perpendicular) slab, whenever this intersection is bounded; we will typically simply say "cylinder" to mean "bounded $\theta$-cylinder." We will also have occasion to use cylinders in which $d\left(x, \Pi_{0 \theta}^{\infty}\right)$ is replaced by $d_{\theta}\left(x, \Pi_{0 \theta}^{\infty}\right)$
in the definition; we distinguish these by attaching the adjective skew (e.g. an infinite skew $\theta$ cylinder); note here that $d_{\theta}\left(x, \Pi_{0 \theta}^{\infty}\right)=\left|x-\pi_{\theta} x\right|$. Any bounded $\theta$-cylinder $\mathcal{C}$ determines two end hyperplanes containing its ends, and the associated slab $S(\mathcal{C})$ between them. Given $x \in \mathbb{R}^{d}$ with direction $\phi=x /|x|$, and $s>0$, the natural hyperplanes of $(0, x)$ are the hyperplanes parallel to $\mathcal{H}_{\phi}$ through 0 and $x$, the natural slab of $(0, x)$ is $S_{\text {nat }}(0, x)=S_{\phi}(0, g(x))$ which is the region between the natural hyperplanes, and the natural cylinder of $(0, x)$ of radius $s$ is the bounded $\phi$-cylinder

\left\{u \in \mathbb{R}^{d}: d\left(u, \Pi_{0 x}^{\infty}\right) \leq s\right\} \cap S_{n a t}(0, x),
$$

which has ends in the natural hyperplanes. For $x \neq y$ in $\mathbb{R}^{d}$, the natural cylinder (of radius $s$ ), natural hyperplanes, and natural slab of $(x, y)$ are then defined via translation by $x$ of the corresponding objects defined for $(0, y-x)$, and the cylinder and slab are denoted $\mathcal{C}_{n a t}(x, y, s)$ and $S_{\text {nat }}(x, y)$, respectively. For a bounded $\theta$-cylinder $\mathcal{C}$ each edge which intersects an end hyperplane of $\mathcal{C}$ and has an endpoint in the interior of $S(\mathcal{C})$ is called an end edge of $\mathcal{C}$, and the endpoint not in the interior is called an end vertex. A pair $(u, v)$ of end vertices at opposite ends of $\mathcal{C}$ is called an end pair of $\mathcal{C}$, and the set of all end pairs is denoted $\mathcal{E}(\mathcal{C})$. Similarly, for a slab $S$, pairs $(u, v)$ of sites adjacent to, but not in, the interior of $S$, lying on opposite sides of $S$, are called boundary pairs of $S$, and the set of all boundary pairs is denoted $\mathcal{B}(S)$.

We fix $\epsilon_{1}$ to be specified, and say a slab $S_{\alpha}(\cdot, \cdot)$ is a near-natural slab of $(x, y)$ if $(x, y) \in \mathcal{B}(S)$,

$$
\left|\frac{y-x}{|y-x|}-\alpha\right|<\epsilon_{1},
$$

and $S_{\alpha}(\cdot, \cdot)$ makes an angle less than $\epsilon_{1}$ with $S_{n a t}(x, y)$. The set of all such slabs is denoted $\mathcal{N}(x, y)$. For a fixed $\alpha$, whether $S_{\alpha}(r, s) \in \mathcal{N}(x, y)$ does not depend on $r, s$ so we may write " $S_{\alpha}(\cdot, \cdot) \in \mathcal{N}(x, y)$." Given a direction of curvature $\theta$, there exists $\epsilon_{2}$ such that if both $\alpha$ and $(y-x) /|y-x|$ are within $\epsilon_{2}$ of $\theta$ then $S_{\alpha}(\cdot, \cdot) \in \mathcal{N}(x, y)$.

We now decribe fully some of the properties FPP systems (at least below $d_{c}$ ) are in most cases believed to have, which may be considered "core properties." Unfortunately they are mostly unproven, except in the case of exactly solvable LPP models in $d=2$. There has been considerable work on LPP in which these (or similar) core properties are taken as "black-box inputs" from the algebraic methods, with further proofs then developed by probabilistic methods, for example [7, [6]. These are some of the core properties, with $\sigma_{m a g}$ any approximate standard deviation:
(i) Uniform exponential bound property on scale $\hat{\sigma}(\cdot)$ :

P(|T(x, y)-E T(x, y)| \geq t \hat{\sigma}(y-x)) \leq c_{11} e^{-c_{12} t} \quad \text { for all } x, y \in \mathbb{Z}^{d} \tag{1.17}
\end{equation*}
$$

(ii) Lattice negligibility with a growth exponent: A direction of curvature exists, $\hat{\sigma}$ is magnitudebased, and $\sigma_{\text {mag }}$ has a growth exponent $\chi \geq 0$.
(a) First variant: (ii) holds and $D$ is magnitude-based.
(b) Second variant: (ii) holds and $\sigma_{m a g}$ has a regular growth exponent $\chi \geq 0$.
(iii) Limit shape has nondegenerate boundary curvature (twice differentiable with positive definite Hessian) everywhere.
(iv) Uniform moderate-gap property:

$$
\limsup _{|x| \rightarrow \infty} \frac{E T(0, x)-g(x)}{\hat{\sigma}(x)}<\infty .
$$

(a) Semi-uniform variant:

$$
\liminf _{\substack{|x| \rightarrow \infty \\ x \in \mathcal{G}_{\mathbb{Z}^{d}}}} \frac{E T(0, x)-g(x)}{\hat{\sigma}(x)}<\infty .
$$

(b) Subsequence variant:

$$
\liminf _{|x| \rightarrow \infty} \frac{E T(0, x)-g(x)}{\hat{\sigma}(x)}<\infty
$$

(v) Controlled wandering property:

$$
\begin{equation*}
\lim _{K \rightarrow \infty} \limsup _{\substack{|x| \rightarrow \infty \\ x \in \mathcal{A}_{\mathbb{Z}^{d}}}} P(R(x) \geq K \hat{\Delta}(x))=0 \tag{1.18}
\end{equation*}
$$

(a) Exponentially-controlled variant: for all $x \in \mathcal{A}_{\mathbb{Z}^{d}}$ and all $K \leq c_{13}|x|^{1 / 2}$,

$$
P(R(x) \geq K \hat{\Delta}(x)) \leq c_{14} e^{-c_{15} K^{2}}
$$

Note (iv)(a) is stronger than (iv)(b). The principle underlying (ii) is that as distances become large, effects of the structure of the underlying lattice, other than its dimension, should become small (with an exception when percolation of the minimal edge weight occurs, as in [18]); this should mean every $\theta$ is a direction of curvature, but for our purposes the weaker curvature condition suffices. The parts of (ii) referencing $\hat{\sigma}$ and $\sigma_{\text {mag }}$ essentially say simply that a well-defined $\chi$ exists. The principle underlying (v) that transverse wandering is typically of order $\hat{\Delta}(x)$ in a direction of curvature may be viewed as a more precise version of the exponent relation $\xi=(1+\chi) / 2$, as we now describe.

Remark 1.3. Assuming the uniform moderate-gap property (iv), the exponentially-controlledwandering property ( v )(a) in directions of curvature is closely related to the uniform exponential bound property (i). Informally the reason is as follows. If $R(x) \geq K \hat{\Delta}(x)$, there is a point $u \in \Gamma_{0 x}$ at distance approximately $K \hat{\Delta}(x)$ from the line $\Pi_{0 x}^{\infty}$ through 0 and $x$. Due to curvature, this forces the geodesic to travel an extra distance:

g(u)+g(x-u)-g(x) \geq c_{16} \frac{(K \hat{\Delta}(x))^{2}}{|x|}=c_{16} K^{2} \hat{\sigma}(x) .
$$

For $K$ large relative to the lim sup in (iv) this implies

$$
h(u)+h(x-u)-h(x) \geq \frac{c_{16}}{2} K^{2} \hat{\sigma}(x),
$$

while

$$
T(0, u)+T(u, x)-T(0, x)=0 .
$$

This forces one of the following to occur:

$$
\begin{gathered}
T(0, u)-E T(0, u) \leq-\frac{c_{16}}{8} K^{2} \hat{\sigma}(x), \quad T(u, x)-E T(u, x) \leq-\frac{c_{16}}{8} K^{2} \hat{\sigma}(x), \\
T(0, x)-E T(0, x) \geq \frac{c_{16}}{4} K^{2} \hat{\sigma}(x) .
\end{gathered}
$$

Provided $\hat{\sigma}(u)$ and $\hat{\sigma}(x-u)$ are not of larger order than $\hat{\sigma}(x)$ (true if (ii)(b) holds), the probability for each of these is then bounded in view of (i), yielding (v)(a). This is a heuristic, not a proof,
because we have ignored that the point $u$ is random; what it shows is that (i) and (v)(a) are strongly interrelated. In fact the idea that geodesics wander by order $\hat{\Delta}(x)$, when expressed at the level of exponents, becomes the standard relation $\xi=(1+\chi) / 2$ proved (under the assumption these exponents exist, in a certain sense) by Chatterjee [11].

Since $\hat{\Delta}(x)$ is at least of order $|x|^{1 / 2}$, this heuristic, or just the relation $\xi=(1+\chi) / 2$, suggests that transverse wandering should also always be at least of order $|x|^{1 / 2}$. This means that the natural assumption for the controlled-wandering property is not that $x /|x|$ be precisely a direction of curvature, but rather that $\left|x-\pi_{\theta} x\right|=O\left(|x|^{1 / 2}\right)$ for some direction of curvature $\theta$. We have defined "directionally acceptable" vertices $x$ in keeping with this, replacing the exponent $1 / 2$ with $1 / 5$ as we do not need $1 / 2$ for our proofs. The value $1 / 5$ is chosen to be smaller than the value $1 / 4$ appearing in (c) in the definition of directionally acceptable.

We will consider also a variant of (iv), and a property that connects it to (iv):
(iv') Uniform downward-deviation property: for some $\epsilon_{3}>0$,

\liminf _{|x| \rightarrow \infty} P\left(T(0, x) \leq g(x)-\epsilon_{3} \hat{\sigma}(x)\right)>0 .
$$

(a) Semi-uniform variant:

$$
\liminf _{\substack{|x| \rightarrow \infty \\ x \in \mathcal{I}_{\mathbb{Z}^{d}}}} P\left(T(0, x) \leq g(x)-\epsilon_{3} \hat{\sigma}(x)\right)>0 .
$$

(b) Subsequence variant:

$$
\limsup _{|x| \rightarrow \infty} P\left(T(0, x) \leq g(x)-\epsilon_{3} \hat{\sigma}(x)\right)>0 .
$$

(vi) Unbounded concentration property:

$$
\liminf _{|x| \rightarrow \infty} P(T(0, x)-E T(0, x) \leq-t \hat{\sigma}(x))>0 \quad \text { for all } t>0 .
$$

We see that (iv') implies (iv), by Chebyshev. Conversely, (iv) and (vi) imply (iv'). One expects (iv) is equivalent to (iv'), even without the unbounded concentration property (vi). The unbounded concentration property holds provided $(T(0, x)-E T(0, x)) / \hat{\sigma}(x)$ has a nondegenerate limit distribution for which the support is all of $\mathbb{R}$, as is expected to be true, and is known for integrable LPP in $d=2[22]$. To ensure the support is all of $\mathbb{R}$, it is sufficient that the limit distribution be infinitely divisible.

For a boundary pair $u, v$ of a slab $S$, the slab passage time $T(u, v \mid S)$ is the fastest passage time among all paths from $u$ to $v$ with all vertices in $S \cup\{u, v\}$. The standard deviation of the slab passage time is denoted $\hat{\sigma}(u, v \mid S)$. The disc-to-disc passage time of a cylinder $\mathcal{C}$, denoted $T_{d 2 d}(\mathcal{C})$, is the minimum slab passage time $T(u, v \mid S(\mathcal{C}))$ over all end pairs of $\mathcal{C}$. Its standard deviation is denoted $\hat{\sigma}_{d 2 d}(\mathcal{C})$. Note that disc-to-disc passage time are not restricted to paths staying in the cylinder.

By Proposition 4.4 there is a constant $c_{17}$ such that

$$
\begin{equation*}
E\left[(T(0, x \mid S)-T(0, x))^{2}\right] \leq c_{17} \text { for all } x \in \mathcal{G}_{\mathbb{Z}^{d}} \text { and all } S \in \mathcal{N}(0, x) \tag{1.19}
\end{equation*}
$$

It follows that any approximate standard deviation $\sigma_{\operatorname{mag}}$ also works for slab passage times: after adjusting $c_{1}$,

$$
\begin{equation*}
c_{1}^{-1} \sigma_{m a g}(|x|) \leq \hat{\sigma}(0, x \mid S) \leq c_{1} \sigma_{m a g}(|x|) \text { for all } x \in \mathcal{G}_{\mathbb{Z}^{d}} \text { and all } S \in \mathcal{N}(0, x) \tag{1.20}
\end{equation*}
$$

The last of the properties we consider is the localness (determination near the geodesic endpoints) of passage times discussed in Remark 1.1, which is not expected to hold when $\chi>0$. To describe the property first informally, given a natural cylinder $\mathcal{C}_{\text {nat }}(0, x, \epsilon \hat{\Delta}(x))$ with radius a small multiple of $\hat{\Delta}(x)$, one may compare the typical slab passage time between each end pair $(u, v)$ and the typical fastest of these slab passage times, which is the disc-to-disc passage time. The property of interest is essentially that the typical disc-to-disc passage time for such cylinders is many standard deviations faster than the typical time for each fixed end pair. Since any two end pairs can share the same geodesic path everywhere except near the endpoints, this large passage-time variation across end pairs must be due to some version of localness. We quantify the localness property precisely as follows.
(vii) Local fluctuation property: for every $\epsilon_{+}>0$, for all sufficiently small $\epsilon_{-} \in\left(0, \epsilon_{+}\right)$, letting $\mathcal{C}_{x, \epsilon}=\mathcal{C}_{\text {nat }}(0, x, \epsilon \hat{\Delta}(x))$,

$$
\begin{equation*}
\lim _{r \rightarrow \infty} \sup _{\substack{|x| \geq r \\ x \in x}} \sup _{\epsilon-<\epsilon<\epsilon_{+}} \min _{(u, v) \in \mathcal{E}\left(\mathcal{C}_{x, \epsilon}\right)} \frac{E T\left(u, v \mid S\left(\mathcal{C}_{x, \epsilon}\right)\right)-E T_{d 2 d}\left(\mathcal{C}_{x, \epsilon}\right)}{\hat{\sigma}\left(u, v \mid S\left(\mathcal{C}_{x, \epsilon}\right)\right)}=\infty . \tag{1.21}
\end{equation*}
$$

By contrast, a version of the "nonlocalness" scenario, in which point-to-point and disc-to-disc passage times are not very different, has been confirmed in [2], [20] when $\chi>0$ and (i), (ii) hold, so localness is only a realistic possibility when $\chi=0$.

There are various results providing bounds on $\left|T(u, v)-T\left(u^{\prime}, v^{\prime}\right)\right|$ when $u, v$ are close to $u^{\prime}, v^{\prime}$ respectively, in contexts where we know or expect $\chi>0$; these are proved using the path-sharing described in Remark 1.1. In [20] such bounds are established for $d=2$ assuming versions of (i), (ii), (iii); a similar result for general $d$ is is [2]. Though we will not formally prove that the local fluctuation property fails when $\chi>0$, these bounds point strongly toward the nonlocalness scenario in Remark 1.1.

Our first theorem shows that certain properties expected to hold whenever $\chi>0$ (and conditionally proved in some cases-see below) become inconsistent when $\chi=0$.

Theorem 1.4. For a standard FPP in d dimensions, at least one of the following must be false:
(ii) lattice negligibility, with growth exponent $\chi=0$;
(v) the controlled-wandering property;
(iv')(a) the semi-uniform downward-deviation property.
The state of these properties when $\chi>0$ is as follows.
(ii) is proved with $\chi=1 / 3$ for integrable models of LPP in $d=2$ [22]. As noted before Remark 1.3 , it is a manifestation of the universality principle that at large scales, the underlying lattice should become irrelevant, except for its dimension. Existence of a regular growth exponent is also a manifestation of the kind of regularity that underlies the existence of a scaling limit.
(v) is a finer-detailed manifestation of the same principle that yields the exponent relation $\xi=(1+\chi) / 2$, as noted in Remark 1.3 . The stronger exponentially-controlled variant (v)(a) is known for integrable models of LPP in $d=2$ [8]. (v)(a) is also conditionally
proved on certain "lattice-like" isotropic random graphs in $\mathbb{Z}^{d}$ when $\chi>0$ [3, under unproven assumptions (i) and (ii)(b) (slightly modified.)
(iv')(a) is proved for integrable models of LPP in $d=2$ [22], where it is a consequence of (iv) and the existence of a scaling limit that yields (vi). Its cousin (iv) is conditionally proved for FPP on the same lattice-like random graphs as above in $\mathbb{R}^{d}$ when $\chi>0$, assuming again (i) and a modified (ii)(b).

Of course one would like to know which of (ii), (v), (iv')(a) in Theorem 1.4 actually fails when $\chi=0$, and to that end we have the following. (ii) and (v) seem unlikely candidates to fail, as they are manifestations of non-dimension-dependent principles like universality, the existence of a scaling limit, and the heuristic that underlies $\xi=(1+\chi) / 2$. (iv')(a), on the other hand, does not appear to be a manifestation of any dimension-free general principle, and the conditional proof of its cousin (iv)(a) in [3] makes significant use of $\chi>0$, so it appears the clear candidate to fail when $\chi=0$.

We consider the consequences, if indeed (iv')(a) fails, in the next theorem and corollary, pointing toward the "local" nature of passage time fluctuations. The statement of the theorem is in terms of the related properties (iv)(a)(b), however.

Theorem 1.5. Suppose that for some standard FPP in d dimensions, the following hold:
(ii)(a) lattice negligibility, with growth exponent $\chi=0$,
(v) the controlled-wandering property,
but the subsequential moderate-gap property (iv)(b) fails. Then the local fluctuation property (vii) holds.

If (ii)(b) holds in addition to (ii)(a), then we may replace (iv)(b) with (iv)(a).
As mentioned above, for FPP on the above-mentioned "lattice-like" isotropic random graphs in $\mathbb{R}^{d}$, the uniform moderate-gap property (iv) (so also (iv)(a)(b)) is a consequence of (i) and (ii)(b) when $\chi>0$ [3], so we expect (iv)(b) to potentially fail only when $\chi=0$. So we expect the analog of Theorem 1.5 for $\chi>0$ to be vacuous.

The following is essentially immediate from Theorems 1.4 and 1.5 .
Corollary 1.6. Assume that for some standard FPP in d dimensions, the following hold:
(ii)(a,b) lattice negligibility, with regular growth exponent $\chi=0$,
(v) the controlled-wandering property,
(vi) the unbounded concentration property.

Then the local fluctuation property (vii) holds.
Proof. Under the first two given hypotheses, by Theorem 1.4 (iv')(a) is false. Under (vi) this is equivalent to falsity of (iv)(a). Then Theorem 1.5 (particularly the last sentence) says (vii) holds.

In the corollary, the unbounded concentration property is only needed to bridge the gap from (iv)(a) to (iv')(a), so if one could show (iv)(a) alone implies (iv')(a), then the unbounded concentration property would be unnecessary. The bridging only works because Theorem 1.4 and Theorem 1.5 involve the same semi-uniform variant of (iv)(a) or (iv')(a) when $\sigma_{\text {mag }}$ has regular growth exponent $\chi=0$, that is, when (ii)(b) holds. Without the "regular" aspect, one theorem involves the semi-uniform variant, the other the subsequence variant, and the bridge cannot be made.

## 2. Proof of Theorem 1.4

We will need the following two lemmas, which are proved in Section 5. We will apply the first to $f=\sigma_{u p}$.
Lemma 2.1. Suppose $f:[1, \infty) \rightarrow[1, \infty)$ has regular growth exponent $\chi=0$ with

\delta(r):=\frac{\log f(r)}{\log r} \text { nonincreasing. }
$$

Let $\Psi(r) \rightarrow \infty, \Xi(r) \searrow 0$, and $\eta(r) \searrow 0$ as $r \rightarrow \infty$ with

\eta(r) \geq r^{-1 / 2}, \quad \log \log \frac{1}{\Xi(r)}+\log \frac{1}{\eta(r)} \leq \frac{C}{\delta(r)} \tag{2.1}
\end{equation*}
$$

for some $C>0$. Then

$$
\begin{equation*}
\left(\log \frac{1}{\Xi(\eta(r) r)}\right) f\left(\frac{\eta(r) r}{\log \frac{1}{\Xi(\eta(r) r)}}\right) \gg f(r) \text { as } r \rightarrow \infty . \tag{2.2}
\end{equation*}
$$

We define a linear map $\Phi_{\theta}$, which approximates $g$ in directions near $\theta$ and is constant on hyperplanes $H_{\theta, r}$, by

\Phi_{\theta}(u)= \begin{cases}g\left(\pi_{\theta} u\right) & \text { if } u \in H_{\theta, 0}^{+} \\ -g\left(\pi_{\theta} u\right) & \text { if } u \in H_{\theta, 0}^{-}\end{cases}
$$

For vectors $y$ and angles $\rho$ we use

\Theta_{\rho}(y)=\frac{\left|y-\pi_{\rho} y\right|}{g\left(\pi_{\rho} y\right)}
$$

as a surrogate for the angle between $y /|y|$ and $\rho$; in view of the arcsin bound that angle and $\Theta_{\rho}(y)$ differ by at most a constant factor provided the angle is small.

The second lemma controls backtracking of $\Gamma_{0 x}$, measured in any direction $\theta$ close to $x /|x|$, by a distance $r$ or more.

Lemma 2.2. Consider a standard FPP in d dimensions. Given $K \geq 1$ there exist constants $c_{i}$ as follows. For all sufficiently large $|x|$, all $c_{18}(|x| \log |x|)^{1 / 2} \leq r \leq K|x|$, and all $\theta$ with $S_{\theta}\left(0, \Phi_{\theta}(x)\right) \in$ $\mathcal{N}(0, x)$,

$$
\begin{equation*}
\left.P\left(\Gamma_{0 x} \not \subset S_{\theta}\left(-r, \Phi_{\theta}(x)+r\right)\right)\right) \leq c_{19} e^{-c_{20} r^{2} /|x|} . \tag{2.3}
\end{equation*}
$$

Suppose now $\hat{\sigma}$ is magnitude-based, $\sigma_{\text {mag }}$ has growth exponent $\chi=0$, and (iv')(a), (v) both hold; we will get a contradiction. Let $\sigma_{u p}$ be an upper-regular standard deviation and let $c_{1}$ be as in (1.2) for $f=\hat{\sigma}, f_{\text {mag }}=\sigma_{\text {mag }}$. By (1.10) there exist $c_{21}$ and an unbounded $\Lambda \subset(0, \infty)$ such that

r \in \Lambda \Longrightarrow \sigma_{u p}(r) \leq c_{21} \sigma_{\text {mag }}(r)
$$

Let

$$
\Lambda^{+}=\cup_{r \in \Lambda}\left[\frac{3}{4} r, \frac{3}{2} r\right], \quad \Lambda^{++}=\cup_{r \in \Lambda}\left[\frac{r}{2}, 2 r\right] .
$$

Then by (1.3) and (1.8), for some $c_{22}$,

$$
\begin{align*}
r \in \Lambda^{++} & \Longrightarrow s \in \Lambda \text { for some } s \in\left[\frac{r}{2}, 2 r\right] \\
& \Longrightarrow \sigma_{\text {mag }}(r) \geq \frac{1}{c_{1}^{2}} \sigma_{\text {mag }}(s) \geq \frac{1}{c_{21} c_{1}^{2}} \sigma_{u p}(s) \geq c_{22} \sigma_{\text {up }}(r) . \tag{2.4}
\end{align*}
$$

It follows from Lemma 2.2 that for some $c_{23}, c_{24}$, for $\epsilon_{4}(r)=c_{23}\left(r^{-1} \log r\right)^{1 / 2}, \epsilon_{5}(r)=r^{-c_{24}}$ we have

$$
\begin{gather*}
P\left(\Gamma_{0 v} \not \subset S_{\phi}\left(-\epsilon_{4}(|v|) g\left(\pi_{\phi} v\right),\left(1+\epsilon_{4}(|v|)\right) g\left(\pi_{\phi} v\right)\right)\right) \leq \epsilon_{5}(|v|) \\
\text { for all } v \in \mathbb{Z}^{d} \text { and all } \phi \text { with } S_{\phi}(\cdot, \cdot) \in \mathcal{N}(0, v) . \tag{2.5}
\end{gather*}
$$

By (v), for any function $\Psi(r) \rightarrow \infty$ there exists $\Xi(r) \searrow 0$ for which

$$
\begin{equation*}
P(R(x) \geq \Psi(|x|) \hat{\Delta}(x)) \leq \Xi(|x|) \text { for all } x \in \mathcal{A} \tag{2.6}
\end{equation*}
$$

Our first task is to select particular choices of $\Psi, \Xi$ with other desired properties. We first select $\Xi_{1}(r)$ satisfying

$$
\begin{equation*}
\Xi_{1}(r) \searrow 0, \quad \Xi_{1}(r) \gg \epsilon_{4}\left(\frac{r}{3}\right)^{(d-1) / 6} . \tag{2.7}
\end{equation*}
$$

The last property allows us to next select $\Psi(r)$ satisfying

\begin{equation*}
\Psi(r) \nearrow \infty, \quad \Psi(r) \leq \min \left(\frac{\Xi_{1}(r)^{1 /(d-1)}}{\left(3 \epsilon_{4}(r / 3)\right)^{1 / 6}}, r^{1 / 32}, e^{1 / \delta(r)}\right) \tag{2.8}
\end{equation*}
$$

where, as in Lemma 2.1,

\delta(r)=\frac{\log \sigma_{u p}(r)}{\log r} .
$$

Then using (v) we take $\Xi_{2}, \Xi$ satisfying

\Xi_{2}(r) \searrow 0, \quad \Xi_{2}(r) \geq \sup _{\substack{|x| \geq r \\ x \in \mathcal{A}_{\mathbb{Z}^{d}}}} P(R(x) \geq \Psi(|x|) \hat{\Delta}(x)), \quad \Xi=\max \left(\Xi_{1}, \Xi_{2}, 1 / \Psi, \epsilon_{4}\right), \tag{2.9}
\end{equation*}
$$

so $\Xi(r) \searrow 0$. Finally let

\eta(r)=\left(\frac{\Xi(r)^{1 /(d-1)}}{\Psi(r)}\right)^{8} \tag{2.10}
\end{equation*}
$$

so $\eta(r) \searrow 0$. Then from (2.9),

\begin{equation*}
\log \log \frac{1}{\Xi(r)}+\log \frac{1}{\eta(r)}=\log \log \frac{1}{\Xi(r)}+\frac{8}{d-1} \log \frac{1}{\Xi(r)}+8 \log \Psi(r) \leq 17 \log \Psi(r) \leq \frac{17}{\delta(r)}, \tag{2.11}
\end{equation*}

while from (2.8) and (2.9), since $\Xi \geq \Psi^{-1}$,

Let $\alpha$ be the direction of $\hat{y}^{*}$ and let $\hat{m}=\left\lfloor 2 \eta^{-1 / 4} \hat{n}\right\rfloor$, so (loosely) $\hat{n} \hat{y}^{*} \approx \eta \pi_{\theta} x / 2$ and $\hat{m} \hat{y}^{*} \approx \eta^{3 / 4} \pi_{\theta} x$. We observe that since $1 / \Xi(r) \leq \Psi(r) \leq r^{1 / 32}$ we have using (2.12) that

Note the length of $\mathcal{C}_{i}^{\text {short }}$ is about twice the distance between the points $z_{i}-\hat{n} \hat{y}^{*}, z_{i}+\hat{n} \hat{y}^{*}$ inside it, and the length of $\mathcal{C}_{i}^{\text {long }}$ is about four times the distance between the points $z_{i}+\hat{m} \hat{y}^{*}, z_{i}+\hat{m} \hat{y}^{*}$ inside it. For each $i$ we then get a path of five links from 0 to $x: 0 \rightarrow z_{i}-\hat{m} \hat{y}^{*} \rightarrow z_{i}-\hat{n} \hat{y}^{*} \rightarrow$ $z_{i}+\hat{n} \hat{y}^{*} \rightarrow z_{i}+\hat{m} \hat{y}^{*} \rightarrow x$; see Figure 1. Define corresponding passage times

The first and last link we call outer links, the third one is the central link, and the other two are intermediate links. Note that the central and outer links as given in (2.22) occur in disjoint regions so the passage times of all central links are independent of the passage times of all outer links; this is the reason for inserting the intermediate links between them. We will show that with probability bounded away from 0 , for some $i$, the central link, though short, is fast enough to make the entire 5 -link path "fast."

In dealing with paths from some $y$ to $z$ in a halfspace $H_{\theta, r}^{ \pm}$or slab $S_{\alpha}(q, r)$ (as for example in (2.22) we have in general $y \in H_{s}$ and $z \in H_{t}$ for some $s<t$. In this context we refer to $\rho /(t-s)$

as the relative margin, where $\rho$ is the smaller of the $g$-distances of $y$ and $z$ to the boundary of the halfspace (or slab.) Some approximate relative margins which are relevant here are
in (2.3): $r / \Phi_{\theta}(x)$ (so at least $c_{29}\left(|x|^{-1} \log |x|\right)^{1 / 2}$ )
in (2.5): $\epsilon_{4}(|v|)$

Here in the case of $T_{i}^{++}$and $T_{i}^{--}$we are using 1.15) and 2.20) to conclude that the margin is little affected by the choice between using a $\theta$-based versus $\alpha$-based halfspace in (2.22). From (2.9) and (2.5), together with

\left|x-z_{i}-\hat{m} \hat{y}^{*}\right| \geq\left|\pi_{\theta} x-\pi_{\theta} z_{i}\right|-\left|\pi_{\theta}\left(\hat{m} \hat{y}^{*}\right)\right|-\left|x-\pi_{\theta} x\right|-\left|z_{i}+\hat{m} \hat{y}^{*}-\pi_{\theta}\left(z_{i}+\hat{m} \hat{y}^{*}\right)\right| \geq \frac{\left|\pi_{\theta} x\right|}{3}, \tag{2.34}
\end{equation*}

since the subtracted terms are all much smaller than $|x|$. Note that the relative margin for each outer link is given by the left side of (2.33) divided by the $\Phi_{\theta}(\cdot)$ on the right, so 2.33) says the relative margin is at least $\eta^{3 / 4} / 3$. By 2.8 we have $\eta(r) \geq\left(3 \epsilon_{4}(r / 3)\right)^{4 / 3}$, which with (2.34) gives

& \geq P\left(T_{J}^{--}+T_{J}^{-}+T_{J}^{0}+T_{J}^{+}+T_{J}^{++} \leq g\left(z_{i}-\hat{m} \hat{y}^{*}\right)+2 g\left((\hat{m}-\hat{n}) \hat{y}^{*}\right)\right. \\

But we can always increase $|x|$ (keeping $(\theta, x) \in \mathcal{G}$ ) so that (2.13) holds, and if $K$ is large then (2.45) cannot then be true, as the left side is smaller than the right side. Thus we have a contradiction, which proves Theorem 1.4.

## 3. Proof of Theorem 1.5

Suppose $\hat{\sigma}$ is magnitude-based, $D$ is magnitude-based, and $\sigma_{\text {mag }}$ has growth exponent $\chi=0$. As in the last section, we let $c_{1}$ be as in (1.2) for $f=\hat{\sigma}, f_{\text {mag }}=\sigma_{\text {mag }}$; by increasing $c_{1}$ we may assume (1.2) also holds for $f=D, f_{\text {mag }}=D_{\text {mag }}$. As noted after (1.11), $\hat{\sigma}$ is bounded away from 0 , and hence so is $\sigma_{m a g}$; therefore we may assume $\sigma_{m a g} \geq 1$. This and (1.4) show that (1.9) is valid for $\sigma_{m a g}$, so applying Lemma 1.2 to $f=\sigma_{m a g}$ shows that $\sigma_{u p}$ satisfying (1.10) exists. In the present proof we do not make use of the last two properties in 1.10 for $\sigma_{u p}$; this means that if $\sigma_{\text {mag }}$ has regular growth exponent $\chi=0$, we can take $\sigma_{u p}=\sigma_{\text {mag }}$, which satisfies all the other properties in Lemma 1.2 ,

Let us now give a sketch of the proof. We work again by contradiction: suppose the subsequential moderate gap property (iv)(b) fails, the controlled wandering property (v) holds, and the local fluctuation property (vii) fails. Fixing a large integer $k$, we can find arbitrarily large $x$ for which $D_{\text {mag }}(|x|) / \sigma_{m a g}(|x|)$ is large (at least of order $k^{a}$ for a particular $a$.) We consider paths from 0 to $k x$ inside a natural cylinder $\mathcal{C}^{(k)}$ of radius a large multiple of $\Delta(k|x|)$, where the geodesic is likely to lie, by (v). We subdivide $\mathcal{C}^{(k)}$ into $k$ equal cylinders $Q_{i}$ of length about $|x|$ (see Figure 3) and consider the disc-to-disc passage times $T_{d 2 d}\left(Q_{i}\right)$, which satisfy $T(0, x) \geq \sum_{i=1}^{k} T_{d 2 d}\left(Q_{i}\right)$. By
definition of $D_{\text {mag }}$ there exists $c$ such that $E T(p, q) \geq g(x)+c D_{\text {mag }}(|x|)$ for all end pairs $(p, q)$ of $Q_{i}$, and we want to show that there exists $c^{\prime}<c$ for which $T_{d 2 d}\left(Q_{i}\right)$ is unlikely to be below $g(x)+c^{\prime} D_{\text {mag }}(|x|)$. The cylinder $Q_{i}$ is "too fat" for what we want to do, so we form a collection of a bounded number (order $k^{\rho}$ for some $\rho$ ) of thinner cylinders $\hat{\mathcal{C}}(u, v)$ whose end discs cover the end disks of $Q_{i}$, so that $T_{d 2 d}\left(Q_{i}\right) \geq \min _{u, v} T_{d 2 d}(\hat{\mathcal{C}}(u, v))$. We enlarge each $\hat{\mathcal{C}}(u, v)$ slightly to get a natural cylinder $\hat{\mathcal{C}}_{n a t}(u, v)$; see Figure 4 . In Lemma 3.1 we show that the standard deviation of $T_{d 2 d}\left(\hat{\mathcal{C}}_{\text {nat }}(u, v)\right)$ is at most of order $\left(\sigma_{\text {mag }}(|x|) D_{\text {mag }}(|x|)\right)^{1 / 2}$, which is much smaller than $D_{\text {mag }}(|x|)$. With the help of this standard deviation bound we get the desired upper bound (3.29) on the lower tail of $T_{d 2 d}\left(Q_{i}\right)-\left[g(x)+c^{\prime} D_{\text {mag }}(|x|)\right]$, which after summing over $i$ lets us show that with probability bounded away from 0 we have $T(0, k x) \geq g(k x)+c^{\prime \prime} k D_{\text {mag }}(|x|)$; see (3.31). But this means that for some $\epsilon$ we have $D_{\text {mag }}(k|x|) \geq \epsilon k D_{\text {mag }}(|x|)$, for (at least some) arbitarily large values of $|x|$. One can iterate this to obtain something like $D_{\text {mag }}\left(k^{n}|x|\right) \geq(\epsilon k)^{n} D_{\text {mag }}(|x|)$ for general $n$, showing that $\limsup _{r \rightarrow \infty}\left(\log D_{\text {mag }}(r)\right) / \log r \geq 1$, which contrdicts (1.11).

We turn now to the details of the proof. As mentioned we suppose the uniform moderate gap property (iv)(b) fails, the controlled wandering property (v) holds, and (vii) fails: for some $\epsilon_{+}$, for every $0<\epsilon_{-}<\epsilon_{+}$, there exists $K_{1}=K_{1}\left(\epsilon_{-}, \epsilon_{+}\right)$for which

Recall $\epsilon_{0}$ from the definition of direction of curvature and of $\mathcal{U}$.

Lemma 3.1. Under the hypotheses of Theorem 1.5, there exists $K_{3}$ such that for all $\epsilon<1, M \geq 1$, and all sufficiently large $y \in \mathbb{Z}^{d}$ satisfying both

Note that (3.7) simply says that the $g$-distance between an arbitrary end pair $(a, b)$ is not too much greater than the $g$-distance for the end pair $(0, y)$ which are the centers of the cylinder ends; necessarily $g(b-a) \geq g(y)$. Provided $\epsilon$ is small, since $D_{\text {mag }}^{+} \geq \sigma_{u p}$, 3.7) is satisfied with $M=1$ whenever $y /|y|$ is a direction of curvature, by (1.12). The essential aspect of (3.8) is that if $\sigma_{u p}(r) \ll D_{\text {mag }}(r)$ then the right (and hence also left) side is $\ll D_{\text {mag }}(|y|)$. This means fluctuations of $T_{d 2 d}(\cdot)$ are typically not large enough to overcome a gap of order $D_{\operatorname{mag}}(\cdot)$ for the relevant cylinders; we use this in (3.28) below.

Proof of Lemma 3.1. Fix $0<\epsilon<1$. We consider separately the upward and downward deviations from the mean contributing to $\hat{\sigma}_{d 2 d}\left(\mathcal{C}_{n a t}\left(0, y, \epsilon \Delta_{u p}(|y|)\right)\right)$. To deal with upward deviations, observe first that, writing $\mathcal{F}_{y}$ for $\mathcal{C}_{n a t}\left(0, y, \epsilon \Delta_{u p}(|y|)\right)$, for all $(p, q) \in \mathcal{E}\left(\mathcal{F}_{y}\right)$,

P\left(T_{d 2 d}\left(\mathcal{F}_{y}\right) \geq E T_{d 2 d}\left(\mathcal{F}_{y}\right)+r\right) & \leq P\left(T\left(p, q \mid S\left(\mathcal{F}_{y}\right)\right) \geq E T\left(p, q \mid S\left(\mathcal{F}_{y}\right)\right)-K_{1} c_{1}^{3} \sigma_{\operatorname{mag}}(|y|)+r\right) \\
& \leq P\left(T\left(p, q \mid S\left(\mathcal{F}_{y}\right)\right) \geq E T\left(p, q \mid S\left(\mathcal{F}_{y}\right)\right)+\frac{r}{2}\right) . \tag{3.9}
\end{align*}
$$

Then taking $r=\sqrt{t}$ and integrating this over $t \in\left[4 K_{1}^{2} c_{1}^{6} \sigma_{\text {mag }}(|y|)^{2}, \infty\right)$ yields, using again (1.19) and enlarging $K_{1}$ if necessary in (3.1)

Turning to downward deviations, let

We divide into larger deviations $\left(G^{-} \gg D_{\text {mag }}^{+}(|y|)\right)$ and smaller deviations; fix $C$ to be specified and consider first smaller deviations, meaning $G^{-}<C D_{\text {mag }}^{+}(|y|)$. We have by (3.10)

Turning to larger deviations, meaning $G^{-} \geq r \geq C D_{\text {mag }}^{+}(|y|)$, if $T_{d 2 d}\left(\mathcal{F}_{y}\right) \leq E T_{d 2 d}\left(\mathcal{F}_{y}\right)-r$ then there exists a random $(X, Y) \in \mathcal{E}\left(\mathcal{F}_{y}\right)$ with $T\left(X, Y \mid \mathcal{F}_{y}\right) \leq E T_{d 2 d}\left(\mathcal{F}_{y}\right)-r$; if there are multiple such $(X, Y)$ we assume a particular one has been chosen by some arbitrary algorithm. As in (3.9), letting $\alpha=y /|y|$ and $\mathcal{L}_{u, v}=S_{\alpha}\left(-\Phi_{\alpha}(u), \Phi_{\alpha}(v)\right.$, from (1.2), (1.3), and (1.19) we have for all $(a, b) \in \mathcal{E}\left(\mathcal{F}_{y}\right)$

See Figure 2; as in [8] we now exploit the fact that

which means that a fast value for $T(X, Y)$ for random $(X, Y)$ likely produces a fast value of $T(-y, 2 y)$ which involves nonrandom points. Specifically, since events in disjoint slabs are independent, with (3.13) we have from Chebyshev's inequality, after enlarging $c_{1}$ if necessary,

where we take $C=2\left(c_{47}+3 M\right)$ in our assumption $r \geq C D_{\text {mag }}^{+}(|y|)$ to yield the last inequality. Here we have cheated slightly in applying 3.7 ) to bound $g(a+y)$, because $(-y, a)$ is not necessarily an end pair of $\mathcal{E}\left(\mathcal{C}_{n a t}\left(-y, 0, \epsilon \Delta_{u p}(|y|)\right)\right)$, as $a$ may be slightly on the wrong side of the end hyperplane. But there is a site $z$ within a bounded distance of $a$ on the "correct" side of that hyperplane for which $(-y, z)$ is an end pair. The same holds for bounding $g(2 y-b)$, so the third inequality in (3.15) is valid. Taking $r=\sqrt{t}$ and integrating (3.15) over $t \in\left[C^{2} D_{\text {mag }}^{+}(|y|)^{2}, \infty\right)$ yields that for some $c_{49}$,

with $K_{2}$ (large) to be specified, and cut $k$ equal cylinders from $\mathcal{C}^{(k)}$ (which has axis in direction $\theta$ ):

these are separated by the hyperplanes $H_{\theta, i \Phi_{\theta}(x)}$. See Figure 3. In (3.17) $c_{48}$ is chosen large enough so that no edges intersect both $\mathcal{Q}_{i-1}$ and $\mathcal{Q}_{i}$, which ensures that slab passage times are independent for these two slabs. The geodesic $\Gamma_{0, k x}$ must contain a "slab crossing segment," by which we mean a path crossing $S\left(\mathcal{C}^{(k)}\right)$ with all vertices in $S\left(\mathcal{C}^{(k)}\right)$ except possibly the endpoints; we write $\Gamma_{0, k x}^{s c s}$ for the first such segment. Then

Fix $\epsilon_{6}>0$ (small) to be specified. For each $i \leq k$, we select a finite set $Z_{i}$ of "coarse-grain" points in $\mathcal{C}^{(k)} \cap H_{\theta, g\left(x_{i}\right)}$ satisfying (assuming $k$ large)

and we select a similar set $Z_{i}^{\prime}$ in $\mathcal{C}^{(k)} \cap H_{\theta, g\left(x_{i}^{\prime}\right)}$. Now fix $i \leq k$. Fixing $u \in Z_{i-1}, v \in Z_{i}^{\prime}$, and corresponding direction $\phi=(v-u) /|v-u|$, we have a corresponding cylinder $\hat{\mathcal{C}}(u, v)$ with axis $\Pi_{u v}^{\infty}$, radius $2 \epsilon_{6} \Delta_{u p}(|x|)$, and end hyperplanes $H_{\theta, g\left(x_{i-1}\right)}$ and $H_{\theta, g\left(x_{i}^{\prime}\right)}$. In general $\hat{\mathcal{C}}(u, v)$ is not a natural cylinder, as the end hyperplanes are parallel to $\mathcal{H}_{\theta}$ rather than $\mathcal{H}_{\phi}$. However $\hat{\mathcal{C}}(u, v)$ is contained in a minimal natural cylinder with the same axis and radius, which we denote $\hat{\mathcal{C}}_{\text {nat }}(u, v)$; let $\hat{u}, \hat{v}$ be the points where the axis $\Pi_{u v}^{\infty}$ intersects the ends of $\hat{\mathcal{C}}_{n a t}(u, v)$. See Figure 4 .

The angle between $\phi$ and $\theta$ is at most

From the above angle bound and routine geometry, when $w$ is an end vertex of $\hat{\mathcal{C}}_{n a t}(u, v)$ we have

Observe that

Since $|x| /|\hat{u}-\hat{v}|$ is near 1 for large $|x|$, the ratio on the right is bounded away from 0 and $\infty$, so recalling $\epsilon_{+}$from (3.1) we may choose $\epsilon_{6}$ (in (3.19) and another constant $\epsilon_{7}$ so that the $\epsilon$ in (3.21) always lies in $\left[\epsilon_{7}, \epsilon_{+} \wedge 1\right]$. Writing $\mathcal{D}$ for $\hat{\mathcal{C}}_{\text {nat }}(\hat{u}, \hat{v})$, 3.1) then applies and we have

For each $p, q \in \mathbb{Z}^{d}$ we can specify some path $\gamma_{p q}$ from $p$ to $q$ of length $|q-p|_{1}$. Given $T_{d 2 d}(\hat{\mathcal{C}}(u, v)) \leq t$ for some $t$, there exists a random $(W, Z) \in \mathcal{E}(\hat{\mathcal{C}}(u, v))$ with $T(W, Z) \leq t$, selected by some arbitrary algorithm if there is more than one such pair. Let $w_{\phi}, z_{\phi}$ be the longitudinal $\phi$-projections of $W, Z$, each into the closest end hyperplane of $\mathcal{D}$, and let $(\hat{W}, \hat{Z})$ be an end pair of $\mathcal{D}$ with $\left|w_{\phi}-\hat{W}\right| \leq$
$d,\left|z_{\phi}-\hat{Z}\right| \leq d$. See Figure 5 . Using (3.20) we have

& \quad \geq P\left(\max \left(T\left(\gamma_{W, \hat{W}}\right), T\left(\gamma_{Z, \hat{Z}}\right)\right) \leq 2 c_{54} \epsilon_{6} K_{2} k^{\xi_{1}} E\left(\tau_{e}\right) \sigma_{u p}(|x|) \mid T_{d 2 d}(\hat{\mathcal{C}}(u, v)) \leq t\right) \\
& \quad \geq P\left(T\left(\gamma_{W, \hat{W}}\right) \leq 2 E\left(\tau_{e}\right)\left|\gamma_{W, \hat{W}}\right|, T\left(\gamma_{Z, \hat{Z}}\right) \leq 2 E\left(\tau_{e}\right)\left|\gamma_{Z, \hat{Z}}\right| \mid T_{d 2 d}(\hat{\mathcal{C}}(u, v)) \leq t\right) \\
& \quad \geq \frac{1}{4} . \tag{3.24}

Let $\left(p^{*}, q^{*}\right)$ be the pair in $\mathcal{E}(\mathcal{D})$ achieving the minimum in (3.22). Observe that since $\theta$ is a direction of curvature and $\left|x-\pi_{\theta} x\right| \leq d$, we have

We would like to apply Lemma 3.1 to the cylinder $\mathcal{D}=\hat{\mathcal{C}}_{\text {nat }}(\hat{u}, \hat{v})$ from (3.21), so we need to check the condition (3.7). Let $(a, b) \in \mathcal{E}(\mathcal{D})$; then since $u, v \in \mathcal{Q}_{i}, \mathcal{D}$ is contained in a slightly-fattened $\mathcal{Q}_{i}$, so that

& \geq P\left(T_{d 2 d}(\hat{\mathcal{C}}(u, v)) \leq E T\left(p^{*}, q^{*} \mid S(\mathcal{D})\right)-K_{1} \hat{\sigma}(\hat{u}, \hat{v} \mid S(\mathcal{D}))-4 c_{54} \epsilon_{6} K_{2} k^{\xi_{1}} E\left(\tau_{e}\right) \sigma_{u p}(|x|)\right. \\
&\left.\quad-t c_{60} k^{\xi_{1}}\left(\sigma_{u p}(|\hat{v}-\hat{u}|) D_{m a g}^{+}(|\hat{v}-\hat{u}|)\right)^{1 / 2}\right) \\
& \geq P\left(T_{d 2 d}(\hat{\mathcal{C}}(u, v)) \leq g(x)+c_{56} D_{\text {mag }}(|x|)-5 c_{54} \epsilon_{6} K_{2} k^{\xi_{1}} E\left(\tau_{e}\right) \sigma_{u p}(|x|)\right. \\
&\left.\quad-t c_{60} k^{\xi_{1}}\left(\sigma_{u p}(|\hat{v}-\hat{u}|) D_{\text {mag }}^{+}(|\hat{v}-\hat{u}|)\right)^{1 / 2}\right) \\
& 8  \tag{3.28}\\
&\left.\geq P\left(T_{d 2 d}(\hat{\mathcal{C}}(u, v)) \leq g(x)+\frac{c_{56}}{2} D_{\text {mag }}(|x|)-t c_{60} k^{\xi_{1}}\left(\sigma_{u p}(|\hat{v}-\hat{u}|) D_{\text {mag }}^{+}(|\hat{v}-\hat{u}|)\right)^{1 / 2}\right)\right)
\end{align*}
$$

where the second inequality follows from (3.24), the third from (3.22) and Lemma 3.1 (with $M=$ $c_{59} k^{2 \xi_{1}}$ as above), the fourth from (1.20) and (3.26), and the last from (3.5). For each $(p, q) \in \mathcal{E}\left(\mathcal{Q}_{i}\right)$, one of the cylinders $\hat{\mathcal{C}}(u, v)$ has $(p, q) \in \mathcal{E}(\hat{\mathcal{C}}(u, v))$, with $u \in Z_{i-1}, v \in Z_{i}^{\prime}$. It follows from (1.3), (3.19), and (3.28) that for some $c_{61}$,

& \quad \leq 4\left|Z_{i-1}\right|\left|Z_{i}^{\prime}\right| t^{-2}  \tag{3.29}\\
& (3.29) \\
& \quad \leq 4 c_{50}^{2}\left(\frac{K_{2}}{\epsilon_{6}}\right)^{2(d-1)} k^{2(d-1) \xi_{1}} t^{-2} .
\end{align*}

Equivalently, letting

we have (using $s=t / A_{k}$ )

For technical convenience we replace 2 here with a smaller exponent. Let $Y_{1}^{*}, \ldots, Y_{k}^{*}$ be iid with

so $Y_{1}^{*}$ is stochastically larger than $Y_{1}$. Then $E Y_{1}^{*}=3$, and it is standard that, since the tail exponent for $Y_{1}^{*}$ lies in (1,2),

& \geq g(k x)+\frac{c_{56}}{4} k D_{\text {mag }}^{+}(|x|) . \tag{3.31}
\end{align*}

Thus (see (3.5)) we have shown that if we take $k$ then $x$ large we have

Let $\epsilon_{8}=c_{56} / 4 c_{1}$. Relation (3.32) can be iterated: if we start with $k$ satisfying $k^{1-\xi_{1}} \geq 2 c_{3} / c_{1}^{2} \epsilon_{8}$ and $x$ with $(\theta, x) \in \mathcal{G}$ satisfying $D_{\text {mag }}(|x|) / \sigma_{u p}(|x|) \geq k^{2(d+1) \xi_{2}}$ (as in (3.5), using 3.2) we have

so (3.4) holds for $r=k|x|$. Therefore we can find $x^{\prime}$ with $\left(\theta, x^{\prime}\right) \in \mathcal{G}$ with $\| x^{\prime}|-k| x| |<\sqrt{d}$ such that (3.5) holds for $x^{\prime}$, so by (1.3) and (3.32) we have

Repeating this, since (3.5) holds for $x^{\prime}$, there exists $x^{\prime \prime}$ with $\left(\theta, x^{\prime \prime}\right) \in \mathcal{G}$ and $\left\|x^{\prime \prime}|-k| x^{\prime}\right\|<\sqrt{d}$ such that (3.5) holds for $x^{\prime \prime}$, so (3.34) holds for $x^{\prime}, x^{\prime \prime}$ in place of $x, x^{\prime}$ respectively, so we have (3.35)

## 4. SLAB VS UNRESTRICTED PASSAGE TIMES

For each direction $\psi$, we define discs in each corresponding tangent hyperplane:

\Omega_{\psi, r, \epsilon}=\left\{u \in H_{\psi, r}:\left|u-\pi_{\psi} u\right| \leq \epsilon r\right\} .
$$

Recall that $h(x)=E T(0, x)$. Given $\beta>0$ and a direction of curvature $\theta$, we say another direction $\varphi$ is $\beta$-directionally concordant with $\theta$, and write $\varphi \in D C_{\beta}(\theta)$, if $\varphi \in H_{\theta, 0}^{+}$and $\varphi$ makes an angle of at least $\beta$ with $H_{\theta, 0}$. For such $\varphi$, for $u \in H_{\theta, 1}^{-}$let $\pi_{\varphi, \theta} u$ denote the intersection with $H_{\theta, 1}$ of the line through $u$ in direction $\varphi$. Let $\pi_{\varphi, \theta}^{\partial}$ denote the restriction of $\pi_{\varphi, \theta}$ to $\partial \mathfrak{B}_{g}$, and let

$$
f_{\varphi, \theta}(u)=\left|u-\left(\pi_{\varphi, \theta}^{\partial}\right)^{-1} u\right|
$$

which represents "the distance from $u$ to $\mathfrak{B}_{g}$ in direction $-\varphi$ " and is well-defined for $u$ in some neighborhood of $y_{\theta}$ in $H_{\theta, 1}$.

We first prove that a geodesic $\Gamma_{0 x}$ is very likely to cross a hyperplane, roughly parallel to the natural hyperplanes of $(0, x)$, close to where the line $\Pi_{0 x}^{\infty}$ crosses the hyperplane. We will use the following lemma. Recall $\epsilon_{1}$ from the definition of near-natural slab.

Lemma 4.1. Given $\beta>0$ there exist constants $c_{i}$ as follows. Let $\theta$ be a direction of curvature. There exists a neighborhood $U$ of $y_{\theta}$ in $H_{\theta, 1}$ such that for all $u, v \in U$,

\begin{equation*}
\left|f_{\varphi, \theta}(v)-f_{\varphi, \theta}(u)\right| \leq c_{62}|v-u|\left(\left|u-y_{\theta}\right|+\left|v-y_{\theta}\right|\right) \quad \text { for all } \varphi \in D C_{\beta}(\theta) \text {, } \tag{4.1}
\end{equation*}
$$

and

$$
\begin{equation*}
|g(v)-g(u)| \leq c_{63}|v-u|\left(\left|u-y_{\theta}\right|+\left|v-y_{\theta}\right|\right) \tag{4.2}
\end{equation*}
$$

Proof. We first prove 4.1). We may assume $f_{\varphi, \theta}(v)>f_{\varphi, \theta}(u)$. Take $U$ small enough so $\left(\pi_{\varphi, \theta}^{\partial}\right)^{-1}$, and thus also $f_{\varphi, \theta}$, is well-defined on $U$. Write $\hat{u}$ for $\left(\pi_{\varphi, \theta}^{\partial}\right)^{-1} u, u \in U$. We use the fact that by convexity of $\mathfrak{B}_{g}, \Pi_{\hat{u} \hat{v}}^{\infty}$ intersects the interior $\mathfrak{B}_{g}^{\circ}$ at most in the line segment $[\hat{u}, \hat{v}]$, so letting $p_{\lambda}=\hat{u}+\lambda(\hat{v}-\hat{u})$, for $\lambda \geq 1$ we have $p_{\lambda} \notin \mathfrak{B}_{g}^{\circ}$ and therefore $f_{\varphi, \theta}\left(\pi_{\varphi, \theta}\left(p_{\lambda}\right)\right) \geq\left|p_{\lambda}-\pi_{\varphi, \theta}\left(p_{\lambda}\right)\right|$. See


Figure 6. Diagrams, not to scale, for the proof of (4.1) (upper) and 4.2 (lower). In the upper figure, the lines downward from $p_{\lambda}, \hat{v}$, and $\hat{u}$ are parallel. In the lower figure, the 3 lines in directions $\phi, \alpha, \theta$ all originate at 0 , and the 2 lines downward from $\tilde{u}$ are in directions $\phi$ and $\alpha$.
the upper diagram in Figure 6. It follows using (1.12) and the $\beta$-directionally-concordant property that

\begin{align*}
f_{\varphi, \theta}(u)+\lambda\left(f_{\varphi, \theta}(v)-f_{\varphi, \theta}(u)\right) & =\left|p_{\lambda}-\pi_{\varphi, \theta}\left(p_{\lambda}\right)\right| \\
& \leq f_{\varphi, \theta}\left(\pi_{\varphi, \theta}\left(p_{\lambda}\right)\right) \\
& \leq c_{63}\left|\pi_{\varphi, \theta}\left(p_{\lambda}\right)-y_{\theta}\right|^{2} . \tag{4.3}
\end{align*}
$$

Now we choose

$$
\lambda=\frac{\left|u-y_{\theta}\right|+\left|v-y_{\theta}\right|}{|v-u|},
$$

for which we have

$$
\left|\pi_{\varphi, \theta}\left(p_{\lambda}\right)-u\right|=\lambda|v-u|=\left|u-y_{\theta}\right|+\left|v-y_{\theta}\right|,
$$

and thereby we obtain

$$
\left|\pi_{\varphi, \theta}\left(p_{\lambda}\right)-y_{\theta}\right| \leq\left|\pi_{\varphi, \theta}\left(p_{\lambda}\right)-u\right|+\left|u-y_{\theta}\right|=2\left|u-y_{\theta}\right|+\left|v-y_{\theta}\right| .
$$

With 4.3) (omitting $f_{\varphi, \theta}(u)$ on the left) this shows

\frac{\left|u-y_{\theta}\right|+\left|v-y_{\theta}\right|}{|v-u|}\left(f_{\varphi, \theta}(v)-f_{\varphi, \theta}(u)\right) \leq 4 c_{63}\left(\left|u-y_{\theta}\right|+\left|v-y_{\theta}\right|\right)^{2}, \tag{4.4}
\end{equation*}
$$

which is 4.1.

Turning to 4.2, let $\tilde{u}, \tilde{v}$ denote the points where $\Pi_{0 u}^{\infty}$ and $\Pi_{0 v}^{\infty}$, respectively, intersect $\partial \mathfrak{B}_{g}$, let $\alpha=v /|v|, \psi=u /|u|$, and $u^{\prime}=\pi_{\alpha, \theta} \tilde{u}$. See the lower diagram in Figure 66. We note first that for all angles $\zeta \in H_{\theta, 0}^{+}$,

\frac{\left|\pi_{\zeta, \theta} \tilde{u}-\tilde{u}\right|}{\left|\pi_{\zeta, \theta} \tilde{v}-\tilde{v}\right|}=\frac{g\left(\pi_{\zeta, \theta} \tilde{u}-\tilde{u}\right)}{g\left(\pi_{\zeta, \theta} \tilde{v}-\tilde{v}\right)}, \tag{4.5}
\end{equation*}

since the numerator and denominator involve increments in the same direction $\zeta$. Provided $U$ is small, we have from the $\arcsin$ bound that $\varphi \in D C_{\beta}(\theta)$ for $\beta=\frac{1}{2} \arcsin 1 / \sqrt{d}$, so from (4.1) we have

Since the triangle $\Delta u 0 v$ is just a dilation of $\Delta u \tilde{u} u^{\prime}$ by a factor $|u| /|u-\tilde{u}|$, we have, using (4.5),

\end{align*}
$$

and

$$
\begin{equation*}
\left|u^{\prime}-u\right|=|v-u| \frac{|u-\tilde{u}|}{|u|} \leq|u-v| \leq\left|v-y_{\theta}\right|+\left|u-y_{\theta}\right| \text {. } \tag{4.8}
\end{equation*}
$$

Assuming $U$ is small enough we have $|u-\tilde{u}| /|u|<1 / 2$ so (4.6), 4.7), and 4.8) yield

proving (4.2).
We will need the following exponential concentration result from [14]. The result there is actually stronger, with $(|x| / \log |x|)^{1 / 2}$ in place of $|x|^{1 / 2}$, but the improvement doesn't help us here. Earlier version appeared in [23] (restricted to $t \leq C|x|$ for some $C$ ) and 31] (similarly restricted, but improved to $t^{2}$ in place of $t$ in the exponent.)
Lemma 4.2. 14] For a standard FPP model, there exist constants $c_{i}$ such that for all $x \in \mathbb{Z}^{2}$ and all $t>0$,

Variants of the following have been proved under an assumption (or proven fact, for solvable LPP) of curvature uniform in a neighborhood of $\theta([2],[7],[20)$; here we reduce the assumption to $\theta$ alone being a direction of curvature, which adds significant technicality.
Lemma 4.3. For a standard FPP in d dimensions, for all sufficiently small $\epsilon>0$ there exist $c_{i}, \delta>0$ as follows. Let $\theta \in \mathcal{U}$, let $\psi$ be another unit vector, and let $x \in \mathbb{Z}^{d}$ with

For all $c_{67} \leq t \leq g\left(\pi_{\theta} x\right) / 4$,

P\left(\Gamma_{0 x} \cap\left(H_{\psi, t} \backslash \Omega_{\psi, t, \epsilon}\right) \neq \emptyset\right) \leq c_{68} \exp \left(-c_{69} \epsilon^{2} t^{1 / 48}\right) . \tag{4.12}
\end{equation*}
$$

Proof. For notational convenience we prove (4.12) with $\Omega_{\psi, t, 3 \epsilon}$ in place of $\Omega_{\psi, t, \epsilon}$. Recall $\epsilon_{0}$ from (1.12) (1.15), let $0<\epsilon \leq \epsilon_{0} / 2$, and let $G$ be the event that $\Gamma_{0 x} \cap\left(H_{\psi, t} \backslash \Omega_{\psi, t, 3 \epsilon}\right) \neq \emptyset$. We take $\delta$ in (4.11) small enough so that

u \in H_{\psi, t} \backslash \Omega_{\psi, t, 2 \epsilon} \Longrightarrow\left|u-\pi_{\theta} u\right|>\epsilon t \tag{4.13}
\end{equation*}

Recall that by definition, $x \in H_{\varphi, g\left(\pi_{\varphi} x\right)}$ for all $\varphi$.
We now define an open region $\Lambda=\Lambda(x, \theta, t, \epsilon)$ with the property that when the event $G$ occurs, $\Gamma_{0 x}$ must exit $\Lambda$. We combine the cone and infinite skew $\theta$-cylinder

\mathcal{C}_{\theta, \epsilon}(x)=\left\{u: \Phi_{\theta}(u)>0, \Theta_{\theta}(u)<\epsilon\right\}, \quad \mathcal{D}_{\theta, 2 \epsilon t}=\left\{u:\left|u-\pi_{\theta} u\right|<2 \epsilon t\right\},
$$

to create

$$
\Lambda=\mathcal{C}_{\theta, \epsilon}(x) \cup \mathcal{D}_{\theta, 2 \epsilon t} ;
$$

see Figure 9. Note that the intersection of the boundaries of the cylinder and cone lies in $H_{\theta, 2 t}$, and that by (4.13) we have $H_{\psi, t} \backslash \Omega_{\psi, t, 2 \epsilon} \subset \Lambda^{c}$. For a region $\Xi \subset \mathbb{R}^{d}$ we write $\partial_{\mathbb{Z}^{d}} \Xi$ for the set of all sites in $\Xi^{c}$ adjacent to sites in $\Xi$. On the event $G$ let $x^{(0)}$ be the last point of $\Gamma_{0 x}$ in $\partial_{\mathbb{Z}^{d}} \Lambda$. Observe that

$$
\begin{equation*}
\Theta_{\theta}\left(x^{(0)}\right) \geq \epsilon \text { if } \Phi_{\theta}\left(x^{(0)}\right)>0, \quad \text { and } \quad \Theta_{\theta}(x) \leq c_{70} g(x)^{-1 / 6}, \tag{4.14}
\end{equation*}
$$

the latter coming from 4.11). We consider cases, mainly according to the value of $\Phi_{\theta}\left(x^{(0)}\right)$.
Case 1. No backtracking to $x^{(0)}$, and $\Phi_{\theta}\left(x^{(0)}\right)$ and $t$ are not too large:

$$
\begin{equation*}
\Phi_{\theta}\left(x^{(0)}\right)>0, \quad 0<\Phi_{\theta}\left(x^{(0)}\right) \vee 2 t<\Phi_{\theta}(x)^{4 / 5} . \tag{4.15}
\end{equation*}
$$

Fix $\nu \in\left(\frac{5}{4}, \frac{8}{5}\right)$, let $s_{0}=\Phi_{\theta}\left(x^{(0)}\right) \vee 2 t$, and define

$$
s_{i}=s_{0}^{\nu^{i}}, \quad i \geq 0
$$

Then for $i \geq 1$ let $x^{(i)}$ be the first point of $\Gamma_{x^{(0)} x}$ with $\Phi_{\theta}\left(x^{(i)}\right) \geq s_{i}$ (necessarily in $\Lambda$ ), for $i$ for which such a point exists. The union of the intervals $\left(s_{0}^{(5 / 4)^{2}}, s_{0}^{(8 / 5)^{2}}\right), i \geq 1$ is $\left(s_{0}^{5 / 4}, \infty\right)$, which contains $\Phi_{\theta}(x)$, so we can choose $\nu$ so that $s_{m}=\Phi_{\theta}(x)$ for some $m \geq 1$ (this being the purpose of the allowed range $\nu \in\left(\frac{5}{4}, \frac{8}{5}\right)$.) This means $x^{(i)}$ is defined for $0 \leq i \leq m$, and we now redefine $x^{(m+1)}=x, s_{m+1}=s_{m}$. Observe that we have

$$
\begin{equation*}
\left(\Theta_{\theta}(x) \wedge \epsilon\right) s_{i} \leq\left|x-\pi_{\theta} x\right| \leq 2\left(\Theta_{\theta}(x) \wedge \epsilon\right) s_{i} \text { for all } i \geq 0 \text { and } x \in H_{\theta, \Phi_{\theta}\left(x^{(i)}\right)} \cap\left(\Lambda \cup \partial_{\mathbb{Z}^{d}} \Lambda\right) \tag{4.16}
\end{equation*}
$$

(where we can omit the " $\wedge \epsilon$ " if $i \geq 1$.)
We consider how the "angle" $\Theta_{\theta}$ changes as $\Gamma_{0 x}$ progresses through the points $x^{(0)}, \ldots, x^{(m+1)}=$ $x$. Provided $t$ (hence $s_{0}$ ) is large we have from (4.14) that

$$
s_{0}^{1 / 12} \Theta_{\theta}\left(x^{(0)}\right) \geq 1 \quad \text { and } \quad s_{m+1}^{1 / 12} \Theta_{\theta}\left(x^{(m+1)}\right) \leq c_{71} g(x)^{-1 / 12} .
$$

Therefore there exists an index $1 \leq \ell \leq m+1$ for which $\Theta_{\theta}(\cdot)$ drops sharply from $x_{\ell-1}$ to $x_{\ell}$, in the sense that

$$
\begin{equation*}
s_{\ell-1}^{1 / 12} \Theta_{\theta}\left(x^{(\ell-1)}\right) \geq 1, \quad s_{\ell}^{1 / 12} \Theta_{\theta}\left(x^{(\ell)}\right)<1 \tag{4.17}
\end{equation*}
$$



Figure 7. Diagram for Case 1a. All labeled points except $x^{(\ell-1)}$ are coplanar.

Fixing $\eta>0$, provided $t$ is large we have

$$
\begin{equation*}
\frac{\Theta_{\theta}\left(x^{(\ell)}\right)}{\Theta_{\theta}\left(x^{(\ell-1)}\right)} \leq \frac{s_{\ell-1}^{1 / 12}}{s_{\ell}^{1 / 12}}=s_{\ell-1}^{-(\nu-1) / 12}<\eta . \tag{4.18}
\end{equation*}
$$

We want a lower bound for the "extra distance"

$$
\begin{equation*}
g\left(x^{(\ell-1)}\right)+g\left(x^{(\ell)}-x^{(\ell-1)}\right)-g\left(x^{(\ell)}\right) \tag{4.19}
\end{equation*}
$$

caused by 4.17) and (4.18). We consider two subcases.
Case 1a. $\ell \leq m$. Define the point

$$
y^{(\ell-1)}=H_{\theta, \Phi_{\theta}\left(x^{(\ell-1)}\right)} \cap \Pi_{0 x^{(\ell)}}
$$

so 4.19) can be expressed as

$$
\begin{equation*}
\left[g\left(x^{(\ell-1)}\right)-g\left(y^{(\ell-1)}\right)\right]-\left[g\left(x^{(\ell)}-y^{(\ell-1)}\right)-g\left(x^{(\ell)}-x^{(\ell-1)}\right)\right] . \tag{4.20}
\end{equation*}
$$

Let $z^{(\ell-1)}$ be the longitudinal $\theta$-projection of $x^{(\ell)}$ into $H_{\theta, \Phi_{\theta}\left(x^{(\ell-1)}\right)}$. See Figure 7 . From (1.12), (1.13),

$$
\begin{gather*}
\Theta_{\rho}\left(y^{(\ell-1)}\right)=\Theta_{\rho}\left(x^{(\ell)}\right) \forall \rho \quad \text { (by collinearity with } 0 \text { ), } \\
\Theta_{\theta}(y) \leq \epsilon \Longrightarrow c_{6} \Theta_{\theta}(y)^{2} g\left(\pi_{\theta} y\right) \leq g(y)-g\left(\pi_{\theta} y\right) \leq c_{5} \Theta_{\theta}(y)^{2} g\left(\pi_{\theta} y\right) . \tag{4.21}
\end{gather*}
$$

We first find a lower bound for the first difference in (4.20). We have from (1.12)-(1.14), (4.18), and 4.21) that for some $c_{72}=c_{72}(\theta)$,

$$
\left|g\left(y^{(\ell-1)}\right)-g\left(\pi_{\theta} x^{(\ell-1)}\right)\right| \leq c_{5} \Theta_{\theta}\left(x^{(\ell)}\right)^{2} g\left(\pi_{\theta} x^{(\ell-1)}\right) \leq s_{\ell-1}^{-(\nu-1) / 12} \Theta_{\theta}\left(x^{(\ell)}\right) \Theta_{\theta}\left(x^{(\ell-1)}\right) g\left(\pi_{\theta} x^{(\ell-1)}\right)
$$

$$
\begin{equation*}
g\left(x^{(\ell-1)}\right)-g\left(\pi_{\theta} x^{(\ell-1)}\right) \geq c_{72}\left(\Theta_{\theta}\left(x^{(\ell-1)}\right) \wedge \epsilon\right) \Theta_{\theta}\left(x^{(\ell-1)}\right) g\left(\pi_{\theta} x^{(\ell-1)}\right) \tag{4.22}
\end{equation*}
$$

so

$$
\begin{align*}
g\left(x^{(\ell-1)}\right)-g\left(y^{(\ell-1)}\right) & \geq \frac{c_{72}}{2}\left(\Theta_{\theta}\left(x^{(\ell-1)}\right) \wedge \epsilon\right) \Theta_{\theta}\left(x^{(\ell-1)}\right) g\left(\pi_{\theta} x^{(\ell-1)}\right) \\
& =\frac{c_{72}}{2}\left(\Theta_{\theta}\left(x^{(\ell-1)}\right) \wedge \epsilon\right)\left|x^{(\ell-1)}-\pi_{\theta} x^{(\ell-1)}\right| . \tag{4.23}
\end{align*}
$$

Pursuing next an upper bound for the second difference in 4.20), we want to use Lemma 4.1. From (4.16) we have

$$
\begin{equation*}
\left(\Theta_{\theta}\left(x^{(\ell-1)}\right) \wedge \epsilon\right) s_{\ell-1} \leq\left|x^{(\ell-1)}-\pi_{\theta} x^{(\ell-1)}\right| \leq 2\left(\Theta_{\theta}\left(x^{(\ell-1)}\right) \wedge \epsilon\right) s_{\ell-1} \tag{4.24}
\end{equation*}
$$

and

$$
\begin{equation*}
\left|y^{(\ell-1)}-\pi_{\theta} x^{(\ell-1)}\right| \leq 2 \Theta_{\theta}\left(y^{(\ell-1)}\right) s_{\ell-1}=2 \Theta_{\theta}\left(x^{(\ell)}\right) s_{\ell-1} \tag{4.25}
\end{equation*}
$$

so

$$
\begin{equation*}
\left|y^{(\ell-1)}-x^{(\ell-1)}\right| \leq 4\left|x^{(\ell-1)}-\pi_{\theta} x^{(\ell-1)}\right| . \tag{4.26}
\end{equation*}
$$

Then note that $\pi_{\theta} x^{(\ell-1)}, y^{(\ell-1)}, z^{(\ell-1)}$ are collinear with $y^{(\ell-1)}$ between the other two, so

$$
\begin{equation*}
\left|z^{(\ell-1)}-y^{(\ell-1)}\right| \leq\left|z^{(\ell-1)}-\pi_{\theta} x^{(\ell-1)}\right|=\left|x^{(\ell)}-\pi_{\theta} x^{(\ell)}\right| \leq 2 \Theta_{\theta}\left(x^{(\ell)}\right) s_{\ell} \tag{4.27}
\end{equation*}
$$

which with (4.24) shows that

$$
\begin{equation*}
\left|z^{(\ell-1)}-x^{(\ell-1)}\right| \leq\left|z^{(\ell-1)}-\pi_{\theta} x^{(\ell-1)}\right|+\left|\pi_{\theta} x^{(\ell-1)}-x^{(\ell-1)}\right| \leq 2 \Theta_{\theta}\left(x^{(\ell)}\right) s_{\ell}+2\left(\Theta_{\theta}\left(x^{(\ell-1)}\right) \wedge \epsilon\right) s_{\ell-1} \tag{4.28}
\end{equation*}
$$

Lemma 4.1 together with (4.23), (4.26), 4.27), and 4.28) then show that

$$
\begin{align*}
& g\left(x^{(\ell)}-y^{(\ell-1)}\right)-g\left(x^{(\ell)}-x^{(\ell-1)}\right) \\
& \leq c_{62} \frac{\left|y^{(\ell-1)}-x^{(\ell-1)}\right|\left(\left|z^{(\ell-1)}-x^{(\ell-1)}\right|+\left|z^{(\ell-1)}-y^{(\ell-1)}\right|\right)}{g\left(\pi_{\theta} x^{(\ell)}-\pi_{\theta} x^{(\ell-1)}\right)} \\
& \leq 4 c_{62} \frac{\left|x^{(\ell-1)}-\pi_{\theta} x^{(\ell-1)}\right|\left(2\left[\Theta_{\theta}\left(x^{(\ell-1)}\right) \wedge \epsilon\right] s_{\ell-1}+4 \Theta_{\theta}\left(x^{(\ell)}\right) s_{\ell}\right)}{s_{\ell}} \\
& \leq \frac{1}{2}\left(g\left(x^{(\ell-1)}\right)-g\left(y^{(\ell-1)}\right)\right) . \tag{4.29}
\end{align*}
$$

Hence in view of 4.17), 4.20, and 4.23) the difference in (4.19) satisfies

$$
\begin{align*}
& g\left(x^{(\ell-1)}\right)+g\left(x^{(\ell)}-x^{(\ell-1)}\right)-g\left(x^{(\ell)}\right) \\
& \quad=\left[g\left(x^{(\ell-1)}\right)-g\left(y^{(\ell-1)}\right)\right]-\left[g\left(x^{(\ell)}-y^{(\ell-1)}\right)-g\left(x^{(\ell)}-x^{(\ell-1)}\right)\right] \\
& \quad \geq \frac{1}{2}\left(g\left(x^{(\ell-1)}\right)-g\left(y^{(\ell-1)}\right)\right) \\
& \quad \geq \frac{c_{72}}{4}\left(\Theta_{\theta}\left(x^{(\ell-1)}\right) \wedge \epsilon\right)\left|x^{(\ell-1)}-\pi_{\theta} x^{(\ell-1)}\right| \\
& \quad \geq \frac{c_{72}}{8}\left(\Theta_{\theta}\left(x^{(\ell-1)}\right)^{2} \wedge \epsilon^{2}\right) s_{\ell-1} \\
& \quad \geq \frac{c_{72}}{8} s_{\ell-1}^{5 / 6} \tag{4.30}
\end{align*}
$$

Let $\kappa=5 /(6 \nu)-1 / 2 \in\left(\frac{1}{48}, \frac{1}{6}\right)$, so $s_{\ell-1}^{5 / 6}=s_{\ell}^{\kappa+1 / 2}$. By (1.11, 4.17), and 4.30) we have

$$
\begin{equation*}
h\left(x^{(\ell-1)}\right)+h\left(x^{(\ell)}-x^{(\ell-1)}\right)-h\left(x^{(\ell)}\right) \geq \frac{c_{72}}{8} s_{\ell}^{\kappa+1 / 2}-c_{73}\left(s_{\ell} \log s_{\ell}\right)^{1 / 2} \geq \frac{c_{72}}{16} s_{\ell}^{\kappa+1 / 2}, \tag{4.31}
\end{equation*}
$$

while since $x^{(\ell-1)} \in \Gamma_{0 x^{(\ell)}}$ we have

$$
\begin{equation*}
T\left(0, x^{(\ell-1)}\right)+T\left(x^{(\ell-1)}, x^{(\ell)}\right)-T\left(0, x^{(\ell)}\right)=0 . \tag{4.32}
\end{equation*}
$$

Therefore
$\max \left(\left|T\left(0, x^{(\ell-1)}\right)-h\left(x^{(\ell-1)}\right)\right|,\left|T\left(x^{(\ell-1)}, x^{(\ell)}\right)-h\left(x^{(\ell)}-x^{(\ell-1)}\right)\right|,\left|T\left(0, x^{(\ell)}\right)-h\left(x^{(\ell)}\right)\right|\right) \geq \frac{c_{72}}{48} s_{\ell}^{\kappa+1 / 2}$. Under Case 1 we have $\max \left(g\left(x^{(\ell-1)}\right), g\left(x^{(\ell)}\right)\right) \leq 2 s_{\ell}$. Therefore defining events

$$
G_{i}: \text { there exist } u, v \in \mathfrak{B}_{g}\left(0,2 s_{i}\right) \text { with }|T(u, v)-h(v-u)| \geq \frac{c_{72}}{48} s_{i}^{\kappa+1 / 2}
$$

we see using Lemma 4.2 that

$$
\begin{align*}
P\left(\Gamma_{0 x} \cap\left(H_{\psi, t} \backslash \Omega_{\psi, t, \epsilon}\right) \neq \emptyset \text { and Case 1a holds }\right) & \leq \sum_{i=1}^{m} P\left(G_{i}\right) \\
& \leq \sum_{i=1}^{m}\left|\mathfrak{B}_{g}\left(0,2 s_{i}\right) \cap \mathbb{Z}^{d}\right|^{2} c_{74} e^{-c_{75} s_{i}^{\kappa}} \\
& \leq c_{76} e^{-c_{77} t^{\kappa}} . \tag{4.33}
\end{align*}
$$

Case 1b. $\ell=m+1$. Here $x^{(m)}$ and $x^{(m+1)}=x$ are both in or next to $H_{\theta, g\left(\pi_{\theta} x\right)}$. From 4.17) we have

$$
\left|x^{(m)}-\pi_{\theta} x^{(m)}\right|=\Theta_{\theta}\left(x^{(m)}\right) g\left(\pi_{\theta} x^{(m)}\right) \geq s_{m}^{11 / 12}
$$

while from (1.12) and 4.11),

$$
\begin{equation*}
\left|x-\pi_{\theta} x\right| \leq c_{78} s_{m}^{5 / 6} \quad \text { so } \quad\left|g(x)-g\left(\pi_{\theta} x\right)\right| \leq c_{79} s_{m}^{2 / 3} . \tag{4.34}
\end{equation*}
$$

It then follows from (1.12)-1.14) that $g\left(x^{(m)}\right) \geq g(x)$ so

$$
g\left(x^{(m)}\right)+g\left(x-x^{(m)}\right)-g(x) \geq g\left(x-x^{(m)}\right) \geq c_{80}\left|x-x^{(m)}\right| \geq \frac{c_{80}}{2}\left|x^{(m)}-\pi_{\theta} x^{(m)}\right| \geq \frac{c_{80}}{2} s_{m}^{11 / 12}
$$

and then from (1.11),

$$
h\left(x^{(m)}\right)+h\left(x-x^{(m)}\right)-h(x) \geq \frac{c_{80}}{2} s_{m}^{11 / 12}-c_{62}\left(s_{m} \log s_{m}\right)^{1 / 2} \geq \frac{c_{80}}{4} s_{m}^{11 / 12} .
$$

Defining the event

$$
Q_{m}: \text { there exist } u, v \in \mathfrak{B}_{g}\left(0,2 s_{m}\right) \text { with }|T(u, v)-h(v-u)| \geq \frac{c_{80}}{12} s_{m}^{11 / 12}
$$

it again follows as in 4.32-4.33) that

$$
\begin{aligned}
P\left(\Gamma_{0 x} \cap\left(H_{\psi, t} \backslash \Omega_{\psi, t, \epsilon}\right) \neq \emptyset \text { and Case 1b holds }\right) & \leq P\left(Q_{m}\right) \\
& \leq\left|\mathfrak{B}_{g}\left(0,2 s_{m}\right) \cap \mathbb{Z}^{d}\right|^{2} c_{82} e^{-c_{83} s_{m}^{1 / 3}} \\
& \leq c_{82} e^{-c_{83} s_{m}^{1 / 3} / 2} .
\end{aligned}
$$

Case 2. Backtracking occurs: $\Phi_{\theta}\left(x^{(0)}\right) \leq 0$. This time let $x^{(1)}$ be the first point of $\Gamma_{x^{(0)} x}$ with $\Phi_{\theta}\left(x^{(1)}\right) \geq 2 t$ (necessarily in $\Lambda$ ), define the point

$$
w^{(0)}=\Pi_{x^{(0)}, x^{(1)}} \cap H_{\theta, 0},
$$

and let $u^{(0)}$ be the longitudinal $\theta$-projection of $x^{(1)}$ into $H_{\theta, 0}$. See Figure 8 . In place of 4.20) we express (4.19) as

$$
\begin{equation*}
g\left(x^{(0)}\right)+g\left(w^{(0)}-x^{(0)}\right)-\left[g\left(x^{(1)}\right)-g\left(x^{(1)}-w^{(0)}\right)\right] . \tag{4.36}
\end{equation*}
$$



Figure 8. Diagram for Case 2. The shaded region is the intersection of the hyperplane with $\Lambda$. The geodesic $\Gamma_{0 x}$ follows a path $0 \rightarrow x^{(0)} \rightarrow x^{(1)} \rightarrow x$.

We have

$$
\begin{gather*}
g\left(x^{(0)}\right)>c_{84}\left|x^{(0)}\right| \geq c_{84} \epsilon t, \quad\left|u^{(0)}\right|=\left|x^{(1)}-\pi_{\theta} x^{(1)}\right| \leq 3 \epsilon t, \\
\left|w^{(0)}\right| \leq \max \left(\left|x^{(0)}-\pi_{\theta} x^{(0)}\right|,\left|x^{(1)}-\pi_{\theta} x^{(1)}\right|\right) \leq 3 \epsilon t, \tag{4.37}
\end{gather*}
$$

so

$$
\begin{equation*}
\left|u^{(0)}-w^{(0)}\right| \leq\left|u^{(0)}\right|+\left|w^{(0)}\right| \leq 6 \epsilon t . \tag{4.38}
\end{equation*}
$$

From Lemma 4.1 together with (4.37)-4.38) we then get

$$
\begin{equation*}
\left|g\left(x^{(1)}\right)-g\left(x^{(1)}-w^{(0)}\right)\right| \leq c_{63} \frac{\left|w^{(0)}\right|\left(\left|u^{(0)}\right|+\left|u^{(0)}-w^{(0)}\right|\right)}{\Phi_{\theta}\left(x^{(1)}\right)} \leq \frac{27 c_{63}}{2} \epsilon^{2} t, \tag{4.39}
\end{equation*}
$$

which with 4.36) and (4.37) shows that, provided we take $\epsilon$ small,

$$
\begin{equation*}
g\left(x^{(0)}\right)+g\left(x^{(1)}-x^{(0)}\right)-g\left(x^{(1)}\right) \geq \frac{1}{2} g\left(x^{(0)}\right) . \tag{4.40}
\end{equation*}
$$

In view of 4.37), for some $k \geq 1$ we have $2^{k-1} c_{84} \epsilon t<g\left(x^{(0)}\right) \leq 2^{k-1} c_{84} \epsilon t$ and hence

$$
\max \left(g\left(x^{(0)}\right), g\left(x^{(1)}-x^{(0)}\right), g\left(x^{(1)}\right)\right) \leq c_{85} 2^{k} t,
$$

which with (1.11) and (4.40) shows that

$$
\begin{equation*}
h\left(x^{(0)}\right)+h\left(x^{(1)}-x^{(0)}\right)-h\left(x^{(1)}\right) \geq \frac{1}{2} g\left(x^{(0)}\right)-c_{4}\left(2^{k} t \log \left(2^{k} t\right)\right)^{1 / 2} \geq \frac{1}{4} g\left(x^{(0)}\right) \geq 2^{k} c_{86} \epsilon t . \tag{4.41}
\end{equation*}
$$

We can now follow 4.31)-4.33), defining
$G_{k}^{\prime}:$ there exist $u, v \in \mathfrak{B}_{g}\left(0, c_{85} 2^{k} t\right)$ with $|T(u, v)-h(v-u)| \geq \frac{2^{k} c_{86} \epsilon t}{3}$

so that

$$
\begin{aligned}
P\left(\Gamma_{0 x} \cap\left(H_{\psi, t} \backslash \Omega_{\psi, t, \epsilon}\right) \neq \emptyset \text { and Case } 2 \text { holds }\right) & \leq \sum_{k \geq 1} P\left(G_{k}^{\prime}\right) \\
& \leq \sum_{k \geq 1}\left|\mathfrak{B}_{g}\left(0, c_{85} 2^{k} t\right) \cap \mathbb{Z}^{d}\right|^{2} c_{87} \exp \left(-c_{88} \epsilon\left(2^{k} t\right)^{1 / 2}\right) \\
& \leq c_{89} e^{-c_{90} \epsilon t^{1 / 2}} .
\end{aligned}
$$

Case 3. No backtracking to $x^{(0)}$, and $\Phi_{\theta}\left(x^{(0)}\right)$ or $t$ is large:

$$
\begin{equation*}
\Phi_{\theta}(x)^{4 / 5} \leq \Phi_{\theta}\left(x^{(0)}\right) \vee 2 t \leq \Phi_{\theta}(x) \quad \text { and } \quad \Phi_{\theta}\left(x^{(0)}\right)>0 . \tag{4.43}
\end{equation*}
$$

Define the point

$$
p^{(0)}=\Pi_{0 x} \cap H_{\theta, \Phi_{\theta}\left(x^{(0)}\right)}
$$

and let $q^{(0)}$ be the longitudinal $\theta$-projection of $x$ into $H_{\theta, \Phi_{\theta}\left(x^{(0)}\right)}$. See Figure 9. We want a lower bound for

$$
\begin{equation*}
g\left(x^{(0)}\right)+g\left(x-x^{(0)}\right)-g(x)=\left[g\left(x^{(0)}\right)-g\left(p^{(0)}\right)\right]-\left[g\left(x-p^{(0)}\right)-g\left(x-x^{(0)}\right)\right], \tag{4.44}
\end{equation*}
$$

analogously to 4.20). We first consider the first difference on the right in 4.44). We have

$$
\begin{equation*}
g\left(x^{(0)}\right)-g\left(p^{(0)}\right)=\left[g\left(x^{(0)}\right)-g\left(\pi_{\theta} x^{(0)}\right)\right]-\left[g\left(p^{(0)}\right)-g\left(\pi_{\theta} x^{(0)}\right)\right] \tag{4.45}
\end{equation*}
$$

with, by 1.12 and (4.11),

$$
g\left(p^{(0)}\right)-g\left(\pi_{\theta} x^{(0)}\right) \leq c_{5} \Theta_{\theta}\left(p^{(0)}\right)^{2} \Phi_{\theta}\left(x^{(0)}\right)=c_{5} \Theta_{\theta}(x)^{2} \Phi_{\theta}\left(x^{(0)}\right) \leq c_{91}|x|^{2 / 3}
$$

and, from (1.14) and 4.43),

$$
g\left(x^{(0)}\right)-g\left(\pi_{\theta} x^{(0)}\right) \geq c_{92} \epsilon^{2}\left(\Phi_{\theta}\left(x^{(0)}\right) \vee t\right) \geq c_{93} \epsilon^{2}|x|^{4 / 5}
$$

so

$$
\begin{equation*}
g\left(x^{(0)}\right)-g\left(p^{(0)}\right) \geq \frac{1}{2}\left(g\left(x^{(0)}\right)-g\left(\pi_{\theta} x^{(0)}\right)\right) \geq c_{94} \epsilon^{2}|x|^{4 / 5} . \tag{4.46}
\end{equation*}
$$

Considering next the second difference on the right in (4.44), we have using (1.12)

g\left(x-p^{(0)}\right)-g\left(x-x^{(0)}\right) \leq g\left(x-p^{(0)}\right)-g\left(x-q^{(0)}\right) \leq c_{5} \Theta_{\theta}(x)^{2} \Phi_{\theta}\left(x-x^{(0)}\right) \leq c_{95}|x|^{2 / 3} .
$$

With (4.43), (4.44), and (4.46) this shows that

$$
\begin{equation*}
g\left(x^{(0)}\right)+g\left(x-x^{(0)}\right)-g(x) \geq \frac{c_{94}}{2} \epsilon^{2}|x|^{4 / 5}, \tag{4.47}
\end{equation*}
$$

which with 1.11) yields

$$
\begin{equation*}
h\left(x^{(0)}\right)+h\left(x-x^{(0)}\right)-h(x) \geq \frac{c_{94}}{4} \epsilon^{2}|x|^{4 / 5} . \tag{4.48}
\end{equation*}
$$

As before, following (4.31)-4.33) we obtain

$$
\begin{equation*}
P\left(\Gamma_{0 x} \cap\left(H_{\psi, t} \backslash \Omega_{\psi, t, \epsilon}\right) \neq \emptyset \text { and Case } 3 \text { holds }\right) \leq c_{96} e^{-c_{97} \epsilon^{2}|x|^{3 / 10}} \tag{4.49}
\end{equation*}
$$

Case 4. $\Gamma_{0 x}$ overshoots: $\Phi_{\theta}\left(x^{(0)}\right)>\Phi_{\theta}(x)$. Define the point $v^{(0)}=\Pi_{0 x^{(0)}} \cap H_{\theta, \Phi_{\theta}(x)}$, so that $\Theta_{\theta}\left(v^{(0)}\right)>\epsilon$ and

$$
\begin{equation*}
g\left(x^{(0)}\right)+g\left(x-x^{(0)}\right)-g(x)=\left[g\left(v^{(0)}\right)-g(x)\right]+g\left(x^{(0)}-v^{(0)}\right)+g\left(x-x^{(0)}\right) . \tag{4.50}
\end{equation*}
$$

See Figure 10. We have using (1.14) and (4.11)

$$
\begin{align*}
g\left(v^{(0)}\right)-g(x) & =\left[g\left(v^{(0)}\right)-g\left(\pi_{\theta} x\right)\right]-\left[g(x)-g\left(\pi_{\theta} x\right)\right] \\
& \geq c_{7} \epsilon^{2} \Phi_{\theta}(x)-c_{5} \Theta_{\theta}(x)^{2} \Phi_{\theta}(x) \\
& \geq 0 \tag{4.51}
\end{align*}
$$

and $\left|x-x^{(0)}\right|>c_{99} \epsilon|x|$ so that for some $k \geq 1$,

$$
2^{k-1} c_{99} \epsilon|x|<\left|x-x^{(0)}\right| \leq 2^{k} c_{99} \epsilon|x| .
$$

With (4.50) this shows that

$$
g\left(x^{(0)}\right)+g\left(x-x^{(0)}\right)-g(x) \geq g\left(x-x^{(0)}\right) \geq 2^{k} c_{100}|x|
$$

and hence as with 4.41) and 4.42),

$$
\begin{equation*}
h\left(x^{(0)}\right)+h\left(x-x^{(0)}\right)-h(x) \geq 2^{k-1} c_{100} \epsilon|x| \tag{4.52}
\end{equation*}
$$

and then after summing over $k$,

$$
\begin{equation*}
P\left(\Gamma_{0 x} \cap\left(H_{\psi, t} \backslash \Omega_{\psi, t, \epsilon}\right) \neq \emptyset \text { and Case } 4 \text { holds }\right) \leq c_{101} e^{-\left.c_{102} \epsilon x\right|^{1 / 2}} . \tag{4.53}
\end{equation*}
$$

Since $\kappa>1 / 48$, combining all cases (specifically, 4.33), 4.35), 4.42), 4.49), and 4.53) completes the proof.

Let $\Omega_{\psi, t, \epsilon}\left(\mathbb{Z}^{d}\right)=\left\{x \in H_{\psi, t}^{+} \cap \mathbb{Z}^{d}: x\right.$ is an endpoint of an edge intersecting $\left.\Omega_{\psi, t, \epsilon}\right\}$.
Proposition 4.4. Consider a standard FPP in d dimensions and suppose edge passage times have a finite exponential moment and a direction of curvature $\theta$ exists. There exist constants $c_{i}$ as follows. For every $x$ with $(\theta, x) \in \mathcal{G}$ and every slab $S \in \mathcal{N}(0, x)$,

$$
\begin{equation*}
P(T(0, x \mid S)-T(0, x) \geq t) \leq c_{103} e^{-c_{104} t^{1 / 48}} \quad \text { for all } t>0 \tag{4.54}
\end{equation*}
$$

Proof. Let $\epsilon$ be as in Lemma 4.3; in the definition of near-natural slab take $\epsilon_{1}<\epsilon / 2$. Let $(\theta, x) \in \mathcal{G}$ and fix $S \in \mathcal{N}(0, x)$; this means $S=S_{\psi}\left(0, \Phi_{\psi}(x)\right)$ for some $\psi$ with $\left|\frac{x}{|x|}-\psi\right|<\epsilon_{1}$. Fix $t>0$ large, and $\delta>0$ to be specified. Let $z$ be the closest site in $H_{\psi, \delta t}^{+}$to $\Pi_{0 x}^{\infty} \cap H_{\psi, \delta t}$, and let $z^{\prime}$ be the closest site in $H_{\psi, \Phi_{\psi}(x)-\delta t}^{-}$to $\Pi_{0 x}^{\infty} \cap H_{\psi, \Phi_{\psi}(x)-\delta t}$. Let $W$ be the last vertex of $\Gamma_{0 x}$ in $H_{\psi, t}^{-}$and $W^{\prime}$ the first vertex of $\Gamma_{W x}$ in $H_{\psi, \Phi_{\psi}(x)-t}^{+}$, respectively, so $\Gamma_{W W^{\prime}} \subset S$. See Figure 11. Let $\gamma_{z}$ be a path in $S$ from 0 to $z$ of length $|z|_{1}$, and $\gamma_{z^{\prime}}^{\prime}$ a path in $S$ from $z^{\prime}$ to $x$ of length $\left|x-z^{\prime}\right|$. Note that the primed quantities here are symmetric to the unprimed ones when we interchange 0 and $x$; symmetrically to $\Omega_{\psi, t, \epsilon}$ we define

$$
\Omega_{\psi, t, \epsilon}^{\prime}=\left\{u \in H_{\psi, \Phi_{\psi}(x)-t}:\left|u-\pi_{\psi} u\right| \leq \epsilon t\right\} .
$$

Define the events

$$
\begin{gathered}
F_{\psi, \delta t}(x): \Gamma_{z W} \cup \Gamma_{z^{\prime} W^{\prime}} \not \subset S, \\
G_{t, \epsilon}(x): \Gamma_{0 x} \cap\left(H_{\psi, t} \backslash \Omega_{\psi, t, \epsilon}\right) \neq \emptyset \text { or } \Gamma_{0 x} \cap\left(H_{\psi, \Phi_{\psi}(x)-t} \backslash \Omega_{\psi, t, \epsilon}^{\prime}\right) \neq \emptyset .
\end{gathered}
$$

For configurations in $F_{\psi, \delta t}(x)^{c}$ we have

$$
\begin{gathered}
T(0, x \mid S) \leq T\left(\gamma_{z}\right)+T(z, W)+T\left(W, W^{\prime}\right)+T\left(W^{\prime}, z^{\prime}\right)+T\left(\gamma_{z^{\prime}}^{\prime}\right) \\
T(0, x)=T(0, W)+T\left(W, W^{\prime}\right)+T\left(W^{\prime}, x\right),
\end{gathered}
$$

so

$$
\begin{align*}
& P\left(\{T(0, x \mid S)-T(0, x) \geq t\} \cap F_{\psi, \delta t}(x)^{c}\right) \\
& \quad \leq P\left(T\left(\gamma_{z}\right) \geq \frac{t}{4}\right)+P\left(T(z, W)-T(0, W) \geq \frac{t}{4}\right) \\
& \quad \quad+P\left(T\left(W^{\prime}, z^{\prime}\right)-T\left(W^{\prime}, x\right) \geq \frac{t}{4}\right)+P\left(T\left(\gamma_{z^{\prime}}^{\prime}\right) \geq \frac{t}{4}\right) \\
& \quad \leq 2 P\left(T\left(\gamma_{z}\right) \geq \frac{t}{4}\right)+2 P\left(T\left(\gamma_{z^{\prime}}^{\prime}\right) \geq \frac{t}{4}\right) \\
& =4 P\left(T\left(\gamma_{z}\right) \geq \frac{t}{4}\right) . \tag{4.55}
\end{align*}
$$

Provided we choose $\delta$ small we have

$$
\begin{equation*}
E T\left(\gamma_{z}\right)=|z|_{1} E \tau_{e} \leq \frac{t}{8}, \tag{4.56}
\end{equation*}
$$

so since our FPP is standard, from Lemma 4.2 we get

$$
\begin{equation*}
P\left(T\left(\gamma_{z}\right) \geq \frac{t}{4}\right) \leq c_{105} e^{-c_{106} t} \tag{4.57}
\end{equation*}
$$

Next, from Lemma 4.3,

$$
\begin{align*}
P\left(F_{\psi, \delta t}(x)\right) & \leq P\left(F_{\psi, \delta t}(x) \cap G_{t, \epsilon}(x)^{c}\right)+P\left(G_{t, \epsilon}(x)\right) \\
& \leq P\left(F_{\psi, \delta t}(x) \cap G_{t, \epsilon}(x)^{c}\right)+2 c_{68} e^{-c_{69} \epsilon^{2} t^{1 / 48}} . \tag{4.58}
\end{align*}
$$

Now

$$
\begin{align*}
P\left(F_{\psi, \delta t}(x) \cap G_{t, \epsilon}(x)^{c}\right) & \leq 2 P\left(\Gamma_{z w} \not \subset S \text { for some } w \in \Omega_{\psi, t, \epsilon}\left(\mathbb{Z}^{d}\right)\right) \\
& \leq c_{107}(\epsilon t)^{d-1} \max _{w \in \Omega_{\psi, t, \epsilon}\left(\mathbb{Z}^{d}\right)} P\left(\Gamma_{z w} \not \subset H_{\psi, 0}^{+}\right) . \tag{4.59}
\end{align*}
$$

To bound the last probability, fix $w \in \Omega_{\psi, t, \epsilon}\left(\mathbb{Z}^{d}\right)$ and suppose $\Gamma_{z w} \not \subset H_{\psi, 0}^{+}$. Let $U$ be the first point of $\Gamma_{z w}$ in $H_{\psi, 0}^{-} \cup\left(2 t \mathfrak{B}_{g}\right)^{c}$. We need an upper bound for $g(w-z)$, but we cannot readily obtain this using $\psi$-coordinates (i.e. tangential and longitudinal $\psi$-projections), as $\psi$ need not be a direction of curvature. So instead we must in effect translate to $\theta$-coordinates. Let

$$
p=\Pi_{0 \theta}^{\infty} \cap H_{\psi, \delta t}, \quad q=\Pi_{0 \theta}^{\infty} \cap H_{\psi, t}, \quad v=\Pi_{0 \psi} \cap H_{\psi, t} ;
$$

see Figure 11. Since

$$
|\theta-\psi| \leq\left|\theta-\frac{x}{|x|}\right|+\left|\frac{x}{|x|}-\psi\right| \leq \frac{c_{108}}{|x|}+\epsilon_{1} \leq 2 \epsilon_{1}
$$

we have $|z-p| \leq c_{111} \epsilon_{1} \delta t$. Since $\theta$ is a direction of curvature, the angle between $H_{\theta, 0}$ and $H_{\psi, 0}$ is at most a constant multiple of $|\theta-\psi|$. Combining these we get

$$
\left|p-\pi_{\theta} z\right| \leq c_{109}|z-p||\theta-\psi| \leq c_{110} \epsilon_{1}^{2} \delta t \quad \text { and hence } \quad\left|z-\pi_{\theta} z\right| \leq 2 c_{111} \epsilon_{1} \delta t .
$$

Further, in view of the arcsin bound,

$$
\begin{equation*}
|w-q| \leq|w-v|+|v-q| \leq 2 \epsilon t+c_{112} t|\theta-\psi| \leq c_{114} \epsilon_{1} t \tag{4.60}
\end{equation*}
$$

and

$$
\begin{equation*}
\left|q-\pi_{\theta} w\right| \leq c_{113}|\theta-\psi||w-q| \leq|w-q|, \tag{4.61}
\end{equation*}
$$

so

$$
\begin{equation*}
\left|w-\pi_{\theta} w\right| \leq 2 c_{114} \epsilon_{1} t . \tag{4.62}
\end{equation*}
$$

The only condition we have imposed on $\delta$ is (4.56), so $\delta$ depends only on $E \tau_{e}$. Therefore we may choose $\epsilon_{1}$, in the definition of near-natural slab, to depend on $\delta$. Specifically, since $\theta$ is a direction of curvature, taking $\epsilon_{1}$ small enough we get using (1.12), (4.60), (4.61), and (4.62) that

$$
\begin{align*}
g(w-z) & \leq g(w-p)+g(p-z) \\
& \leq g\left(\pi_{\theta} w-p\right)+c_{5} \frac{\left|w-\pi_{\theta} w\right|^{2}}{\Phi_{\theta}(w-p)}+c_{115} \epsilon_{1} \delta t \\
& \leq g\left(\pi_{\theta} w-q\right)+g(q-v)+g(v-z)+g(z-p)+c_{116} \epsilon_{1} t \\
& \leq g(v-z)+c_{117} \epsilon_{1} t \\
& =(1-\delta) t+c_{117} \epsilon_{1} t \\
& \leq\left(1-\frac{\delta}{2}\right) t . \tag{4.63}
\end{align*}
$$

If $U \in H_{\psi, 0}^{-} \cap 2 t \mathfrak{B}_{g}$ then $g(w-U) \geq t$; otherwise we have $U \notin 2 t \mathfrak{B}_{g}$ so $g(U-z) \geq g(U)-g(z)>t$. Either way we have $g(U-z)+g(w-U) \geq t$ and $U \in \Gamma_{z w} \cap 2 t \mathfrak{B}_{g}$, and we conclude that

$$
T(z, U)+T(U, w)-T(z, w)=0, \quad g(U-z)+g(w-U)-g(w-z) \geq \frac{\delta}{2} t
$$

Then from (1.11,

$$
h(U-z)+h(w-U)-h(w-z) \geq \frac{\delta}{4} t .
$$

It follows that there exist $p, q \in 2 t \mathfrak{B}_{g}$ with $|T(p, q)-h(q-p)| \geq \delta t / 4$, so from 4.59) and Lemma 4.2 ,

$$
\begin{align*}
P\left(F_{\psi, \delta t}(x) \cap G_{t, \epsilon}(x)^{c}\right) & \leq c_{118} \epsilon^{d-1} t^{3 d-1} \max _{p, q \in 2 t \mathfrak{B}_{g}} P\left(|T(p, q)-h(q-p)| \geq \frac{\delta}{4} t\right) \\
& \leq c_{119} e^{-c_{120} \delta^{1 / 2} t^{1 / 2}}, \tag{4.64}
\end{align*}
$$

which combined with (4.55, (4.57), and 4.58) yields

$$
P(T(0, x \mid S)-T(0, x) \geq t) \leq c_{121} e^{-c_{122} t^{1 / 48}}
$$

which completes the proof.

## 5. Proofs of supporting lemmas

Proof of Lemma 1.2. Let

$$
\Upsilon(r)=\log f\left(e^{r}\right), \quad r \geq 0,
$$

so $\Upsilon(r)=o(r)$ as $r \rightarrow \infty$. The first step is to replace $\Upsilon$ with an upper bound which is more regular (piecewise linear with bounded slope.) Let

$$
M_{k}=\sup \{\Upsilon(r): k-1 \leq r \leq k\}, \quad k \geq 2
$$

Define $\Upsilon_{\text {reg }}$ on $[0, \infty)$ by

$$
\Upsilon_{r e g}(1)=M_{1}, \quad \Upsilon_{r e g}(k)=\max \left(M_{k}, M_{k+1}\right), \quad \Upsilon_{r e g}\left(k-\frac{1}{2}\right)=M_{k}, \quad k \geq 2,
$$

with $\Upsilon_{\text {reg }}$ linear on each interval $\left[k-1, k-\frac{1}{2}\right]$ and $\left[k-\frac{1}{2}, k\right]$, so in view of (1.9) we have

$$
\begin{equation*}
\Upsilon_{\text {reg }}-c_{123} \leq \Upsilon \leq \Upsilon_{\text {reg }}, \tag{5.1}
\end{equation*}
$$

and $\Upsilon_{\text {reg }}$ is bounded below. Also from (1.9) (taking $\alpha \leq e^{2}$ ) we have

$$
s \in[r, r+2] \Longrightarrow|\Upsilon(s)-\Upsilon(r)| \leq c_{124}:=2 \kappa+\log c,
$$

so $\left|M_{k+1}-M_{k}\right| \leq c_{124}$ for all $k$, and hence

$$
\begin{equation*}
\left|\Upsilon_{r e g}(s)-\Upsilon_{r e g}(r)\right| \leq 2 c_{124}|s-r| \text { for all } r, s \geq 0 \tag{5.2}
\end{equation*}
$$

We define $\Upsilon_{u p} \geq \Upsilon_{\text {reg }}$ by two cases, then in each case let

$$
f_{u p}(r)=e^{\Upsilon_{u p}(\log r)}, \quad r \geq 1 .
$$

Case 1. $\Upsilon_{\text {reg }}(r)$ is eventually nonpositive as $r \rightarrow \infty$, say $\Upsilon_{r e g}(r) \leq 0$ for all $r \geq r_{0}$. Here we define

$$
\Upsilon_{u p}(r)= \begin{cases}2 c_{124}\left(r_{0}-r\right) & \text { if } 0 \leq r \leq r_{0}, \\ 0 & \text { if } r>r_{0} .\end{cases}
$$

By (5.2) this satisfies $\Upsilon_{u p} \geq \Upsilon_{\text {reg }} \geq \Upsilon$, so $f_{u p} \geq f$, and since $\Upsilon$ is bounded below, the other conditions in (1.10), and the regular growth exponent property, are straightforward.

Case 2. There exist arbitrarily large $r$ with $\Upsilon_{\text {reg }}(r)>0$. By (5.2) $\Upsilon_{\text {reg }}$ is bounded on bounded intervals, and $\Upsilon_{r e g}(r)=o(r)$, so we can define $\Upsilon_{u p}$ to be the concave majorant of $\Upsilon_{r e g} \vee 0$ on $[0, \infty)$, which is nondecreasing. If $\Upsilon_{r e g}$ is bounded on all $[0, \infty)$ then $\Upsilon_{u p}$ is also bounded, and since $f \geq \delta$ it follows that $f_{u p} / f$ is bounded. If instead $\lim \sup _{r \rightarrow \infty} \Upsilon_{\text {reg }}(r)=\infty$ then there exist arbitrarily large $r$ where $\Upsilon_{u p}(r)=\Upsilon_{\text {reg }}(r)$ so it follows from (5.1) that $\lim _{\inf }^{r \rightarrow \infty}{ }_{r} f_{u p}(r) / f(r)<\infty$. Concavity and nonnegativity of $\Upsilon_{u p}$ ensure that $\Upsilon_{u p}(r) / r$ is nonincreasing, or equivalently, $\log f_{u p}(r) / \log r$ is nonincreasing. Thus again all conditions in (1.10) are satisfied. The regular growth exponent property for $f_{u p}$ follows from the fact that $\Upsilon_{u p}^{\prime}$ (which exists a.e.) decreases to 0 .

Proof of Lemma 2.1. Let

$$
s=s(r)=\frac{\eta(r) r}{\log _{\Xi(\eta(r) r)}} .
$$

Taking logs, we see that we wish to show that given $c>0$, for large $r$,

$$
\log \log \frac{1}{\Xi(\eta(r) r)}+\delta(s) \log s \geq \delta(r) \log r+c
$$

or equivalently,

$$
\frac{\log \log \frac{1}{\Xi(\eta(r) r)}-c}{\delta(r) \log s}+\frac{\delta(s)}{\delta(r)} \geq 1+\frac{\log \frac{r}{s}}{\log s}
$$

Since $\delta$ is nonincreasing and $s(r)<r$ for large $r$, we have $\delta(s) / \delta(r) \geq 1$ so it is sufficient to show that for large $r$,

$$
\begin{equation*}
\frac{\log \log \frac{1}{\Xi(\eta(r) r)}-c}{\log \frac{r}{s}} \geq \delta(r) \tag{5.3}
\end{equation*}
$$

We have by (2.1)

$$
\log \frac{r}{s}=\log \log \frac{1}{\Xi(\eta(r) r)}+\log \frac{1}{\eta(r)} \leq \log \log \frac{1}{\Xi(r)}+\log \frac{1}{\eta(r)} \leq \frac{C}{\delta(r)}
$$

and (5.3) follows, since $\eta(r) r \rightarrow \infty$ as $r \rightarrow \infty$.
Proof of Lemma 2.2. In this proof constants $c_{i}$ may depend on $K$. Let $x, \theta, r$ be as in the lemma statement, and let $\alpha=x /|x|$, so (by definition of $\mathcal{N}(\cdot, \cdot))|\theta-\alpha|<\epsilon_{1}$ and $\mathcal{H}_{\theta}$ makes an angle of less than $\epsilon_{1}$ with $\mathcal{H}_{\alpha}$. If $\Gamma_{0 x} \cap H_{\theta,-r}^{-} \neq \emptyset$, let $Z$ be the first vertex of $\Gamma_{0 x} \cap H_{\theta,-r}^{-}$, so $\Phi_{\theta}(Z) \leq-r$. We want a lower bound for the extra distance $g(Z)+g(x-Z)-g(x)$.

## Claim.

$$
\begin{equation*}
g(Z)+g(x-Z)-g(x) \geq \frac{1}{2}(r+g(Z)) \tag{5.4}
\end{equation*}
$$

If $g(Z) \geq 2 g(x)$ then the left side is bounded below by $g(Z)$, which is at least $r$ since $Z \in H_{\theta,-r}$, so (5.4) holds. Thus we may assume $g(Z)<2 g(x)$. Then to prove (5.4), let $V, W$ be the points where $\Pi_{x Z}^{\infty}$ intesects $H_{\alpha, 0}$ and $H_{\theta, 0}$, respectively. See Figure 12 . Since $V \in H_{\alpha, 0}$ we have $g(x-V) \geq g(x)$, and therefore

$$
\begin{equation*}
g(x-Z) \geq g(x-W)+r \geq g(x-V)-g(V-W)+r \geq g(x)-g(V-W)+r \tag{5.5}
\end{equation*}
$$

The arcsin bound provides a minimum angle between $x$ (i.e. $\alpha$ ) and $H_{\alpha, 0}$, and since $g(Z)<2 g(x)$, also then a minimum possible angle, call it $\varphi_{0}$, between $\Pi_{x Z}^{\infty}$ and $H_{\alpha, 0}$. It then follows from basic geometry that, since the angle between $H_{\alpha, 0}$ and $H_{\theta, 0}$ is less than $\epsilon_{1}$, from $\varphi_{0}$ we get $c_{125}$ such that

$$
g(V-W) \leq c_{125} \epsilon_{1} g(W) \leq c_{125} \epsilon_{1}(g(Z)+g(W-Z))=c_{125} \epsilon_{1}\left(g(Z)+\frac{r}{\Phi_{\theta}(x)+r} g(x-Z)\right)
$$

Combining this with 5.5) and using $g(x-Z) \leq g(x)+g(Z)<3 g(x)$ we get

$$
\begin{align*}
g(Z)+g(x-Z)-g(x) & \geq g(Z)-g(V-W)+r \\
& \geq\left(1-c_{125} \epsilon_{1}\right) g(Z)+\left(1-3 c_{125} \epsilon_{1} \frac{g(x)}{\Phi_{\theta}(x)}\right) r . \tag{5.6}
\end{align*}
$$

Now provided $\epsilon_{1}$ is taken small enough (depending only on $g$ ),

$$
\left|x-\pi_{\theta} x\right| \leq c_{126}|\alpha-\theta||x| \leq c_{126} \epsilon_{1}|x| \quad \text { so } \quad \Phi_{\theta}(x)=g\left(\pi_{\theta} x\right) \geq g(x)-g\left(x-\pi_{\theta} x\right) \geq \frac{1}{2} g(x)
$$

which with (5.6) proves the claim (5.4).


Figure 12. Diagram for the proof of Lemma 2.2 Lines and hyperplanes corresponding to direction $\theta$ are black; those for direction $\alpha$ are gray. In the case shown we have $Z \in H_{\alpha, 0}^{+}$, meaning $\Gamma_{0 x}$ backtracks to $Z$ in direction $\theta$ but not in direction $\alpha$. In general $Z$ may lie on either side of $V$.

From (1.2) and (1.11) we have $h(x)-g(x) \leq c_{1} D_{\text {mag }}(|x|) \leq c_{1} c_{4}(|x| \log |x|)^{1 / 2}$ so recalling $r \geq c_{18}(|x| \log |x|)^{1 / 2}$, we have from the claim that provided $c_{18}$ is large,

$$
h(Z)+h(x-Z)-h(x) \geq \frac{1}{2}(r+g(Z))-c_{1} c_{4}(|x| \log |x|)^{1 / 2}>\frac{1}{2} g(Z)
$$

while

$$
T(0, Z)+T(Z, x)-T(0, x)=0,
$$

so one of $h(Z)-T(0, Z), h(x-Z)-T(Z, x), T(0, x)-h(x)$ must exceed $g(Z) / 6$. Since $Z \in H_{\theta,-r}^{-}$ we have $g(Z) \geq r$. Either $g(Z) \leq g(x)$ or there exists $k \geq 1$ for which $2^{k-1} g(x)<g(Z) \leq 2^{k} g(x)$. Decomposing according to the value of $k$ then gives

$$
\begin{aligned}
& P\left(\Gamma_{0 x} \cap H_{\theta,-r}^{-} \neq \emptyset\right) \leq P\left(T(0, x)-h(x) \geq \frac{r}{6}\right) \\
&+P\left(\max (h(z)-T(0, z), h(x-z)-T(z, x)) \geq \frac{r}{6}\right. \\
&\text { for some } \left.z \text { with }|z| \leq c_{127}|x|\right) \\
&+\sum_{k=1}^{\infty} P\left(\max (h(z)-T(0, z), h(x-z)-T(z, x)) \geq \frac{2^{k-1} g(x)}{6}\right. \\
&\text { for some } \left.z \text { with }|z| \leq c_{127} 2^{k}|x|\right) .
\end{aligned}
$$

Using Lemma 4.2 and recalling $r \leq K|x|$, this yields

$$
\begin{align*}
& P\left(\Gamma_{0 x} \cap H_{\theta,-r}^{-} \neq \emptyset\right) \\
& \quad \leq c_{128} \exp \left(-c_{129} \frac{r^{2}}{|x|}\right)+c_{128}|x|^{d} \exp \left(-c_{129}|x|\right)+\sum_{k=1}^{\infty} c_{128}\left(2^{k}|x|\right)^{d} \exp \left(-c_{129} 2^{2 k}|x|\right) \\
& \quad \leq c_{130} e^{-c_{131} r^{2} /|x|}+c_{132} e^{-c_{133}|x|} \\
& \quad \leq c_{134} e^{-c_{135} r^{2} /|x|} . \tag{5.8}
\end{align*}
$$

The same bound for $P\left(\Gamma_{0 x} \cap H_{\theta, \Phi_{\theta}(x)+r}^{+} \neq \emptyset\right)$ is obtained symmetrically.
