# The $q$-Onsager algebra and the quantum torus

#### Abstract

The $q$-Onsager algebra, denoted $O_{q}$, is defined by two generators $W_{0}, W_{1}$ and two relations called the $q$-Dolan-Grady relations. Recently, Terwilliger introduced some elements of $O_{q}$, said to be alternating. These elements are denoted $$
\left\{W_{-k}\right\}_{k=0}^{\infty}, \quad\left\{W_{k+1}\right\}_{k=0}^{\infty}, \quad\left\{G_{k+1}\right\}_{k=0}^{\infty}, \quad\left\{\tilde{G}_{k+1}\right\}_{k=0}^{\infty}
$$

The alternating elements of $O_{q}$ are defined recursively. By construction, they are polynomials in $W_{0}$ and $W_{1}$. It is currently unknown how to express these polynomials in closed form.

In this paper, we consider an algebra $T_{q}$, called the quantum torus. We present a basis for $T_{q}$ and define an algebra homomorphism $p: O_{q} \mapsto T_{q}$. In our main result, we express the $p$-images of the alternating elements of $O_{q}$ in the basis for $T_{q}$. These expressions are in a closed form that we find attractive.

## 1 Introduction

The $q$-Onsager algebra, which we denote $O_{q}$, first appeared in the topic of algebraic graph theory [12, Lemma 5.4]. Applications of $O_{q}$ in algebraic combinatorics appear in many papers, including [10, 11, 13]. The algebra $O_{q}$ has recently been applied to statistical mechanics [1, 3, 5, 7] and quantum groups [6, Section 2.2]. The algebra $O_{q}$ is defined by generators $W_{0}, W_{1}$ and two relations called the $q$-DolanGrady relations.

We mentioned that $O_{q}$ appears in statistical mechanics; let us expand on that. In [5, eqn. 4], Pascal Baseilhac and Kozo Koizumi described an algebra similar to $O_{q}$ while researching operators on boundary integrable systems with hidden
symmetries. Following [16], we denote this algebra by $\mathcal{O}_{q}$. This algebra is defined by generators and relations. The generators are

\left\{\mathcal{W}_{-k}\right\}_{k=0}^{\infty}, \quad\left\{\mathcal{W}_{k+1}\right\}_{k=0}^{\infty}, \quad\left\{\mathcal{G}_{k+1}\right\}_{k=0}^{\infty}, \quad\left\{\tilde{\mathcal{G}}_{k+1}\right\}_{k=0}^{\infty} \tag{1}
\end{equation*}
$$

The relations are given in [7, Definition 3.1], as well as Definition 3.5 below. The name and notation for $\mathcal{O}_{q}$ have evolved over time; it is currently known as the alternating central extension of the $q$-Onsager algebra, as in [15]. The elements displayed in equation (1) are called the alternating generators of $\mathcal{O}_{q}$; see [15] and [16].

Motivated by [5], Paul Terwilliger showed in [15] that there exists an algebra isomorphism from $\mathcal{O}_{q}$ to the tensor product of $O_{q}$ and the polynomial algebra over countably many commuting variables. We denote this isomorphism by $\varphi$, and we denote the variables by $\left\{z_{i}\right\}_{i=1}^{\infty}$. For $i \geq 1$, let $\mathcal{Z}_{i} \in \mathcal{O}_{q}$ denote the $\varphi$-preimage of $1 \otimes z_{i}$. By [16, Definition 11.2], there exists an algebra homomorphism $\gamma: \mathcal{O}_{q} \mapsto O_{q}$ that sends $\mathcal{W}_{0} \mapsto W_{0}, \mathcal{W}_{1} \mapsto W_{1}$, and $\mathcal{Z}_{i} \mapsto 0$ for $i \geq 1$.

The $\gamma$-images of the alternating generators of $\mathcal{O}_{q}$ are called the alternating elements of $O_{q}$. By construction, each alternating element of $O_{q}$ is a polynomial in $W_{0}$ and $W_{1}$. Recursive formulas for these polynomials are known; see [15, Lemma 8.22]. However, closed forms for the polynomials are not currently known.

In this paper, we discuss an algebra $T_{q}$, called the quantum torus [9. The algebra $T_{q}$ is defined by the generators $x, y, x^{-1}, y^{-1}$ and the relations

x x^{-1}=1=x^{-1} x, \quad y y^{-1}=1=y^{-1} y, \quad x y=q^{2} y x .
$$

It is known that the elements $\left\{x^{i} y^{j} \mid i, j \in \mathbb{Z}\right\}$ form a basis for $T_{q}$; see [9, p. 3].
In this paper, we introduce the algebra homomorphism $p: O_{q} \rightarrow T_{q}$ that sends $W_{0} \mapsto x+x^{-1}$ and $W_{1} \mapsto y+y^{-1}$. We consider the $p$-images of the alternating elements of $O_{q}$. Our main objective is to express these $p$-images in closed form in the above basis. To reach our objective, we make use of generating functions. We give two versions of our main result: one expressed using generating functions and one without them. The main results of this paper are Theorem 8.1 and Theorem 9.1 .

The paper is organized as follows. In Sections 3-5, we give definitions and results concerning $\mathcal{O}_{q}, O_{q}$, and $T_{q}$. Section 6 covers generating functions, and in Section 7 we provide notation and formulas. In Section 8 we state and prove our main result in terms of generating functions. In Section 9 we present our main result without using generating functions.

## 2 Notations

In this section, we introduce some notation that will be used throughout the paper.

- Let $K$ be a field of characteristic 0 .
- All algebras in this paper are associative, unital, and over $K$.
- For $u, v$ in any algebra, define $[u, v]=u v-v u$. We call $[u, v]$ the commutator of $u$ and $v$. For nonzero $r \in K$, define $[u, v]_{r}=r u v-r^{-1} v u$. We call $[u, v]_{r}$ the $r$-commutator of $u$ and $v$.
- Fix nonzero $q \in K$.
- Let $\mathbb{N}$ denote the set of natural numbers $\{0,1,2, \ldots\}$. Let $\mathbb{Z}$ denote the set of integers. Let $\mathbb{C}$ denote the set of complex numbers.
- For $n \in \mathbb{N}$, define $[n]_{q}=\frac{q^{n}-q^{-n}}{q-q^{-1}}$. We are using the notation from [14].
- By an automorphism of an algebra $\mathcal{A}$, we mean an algebra isomorphism from $\mathcal{A}$ to itself.
- The opposite algebra of an algebra $\mathcal{A}$, denoted $\mathcal{A}^{o p}$, is the algebra on the vector space $\mathcal{A}$ such that for $a, b \in \mathcal{A}^{o p}$, $a b\left(\right.$ in $\left.\mathcal{A}^{o p}\right)=b a($ in $\mathcal{A})$. Note that if $\mathcal{A}$ is commutative, then $\mathcal{A}=\mathcal{A}^{o p}$.
- By an antiautomorphism of an algebra $\mathcal{A}$, we mean an algebra isomorphism from $\mathcal{A}$ to $\mathcal{A}^{o p}$. In other words, an antiautomorphism of $\mathcal{A}$ is a $K$-linear bijection $\alpha: \mathcal{A} \rightarrow \mathcal{A}$ that reverses the order of multiplication: $\alpha(a b)=$ $\alpha(b) \alpha(a)$ for all $a, b \in \mathcal{A}$.


## 3 The $q$-Onsager algebra

In this section, we consider the $q$-Onsager algebra and its alternating central extension.

Definition 3.1. Let $O_{q}$ denote the algebra defined by generators $W_{0}, W_{1}$ and relations

& {\left[W_{0},\left[W_{0},\left[W_{0}, W_{1}\right]_{q}\right]_{q^{-1}}\right]=-\left(q^{2}-q^{-2}\right)^{2}\left[W_{0}, W_{1}\right]}  \tag{2}\\
& {\left[W_{1},\left[W_{1},\left[W_{1}, W_{0}\right]_{q}\right]_{q^{-1}}\right]=-\left(q^{2}-q^{-2}\right)^{2}\left[W_{1}, W_{0}\right] .} \tag{3}
\end{align*}
$$

We call $O_{q}$ the $q$-Onsager algebra.

Equations (22) and (3) are called the $q$-Dolan-Grady relations. We define an automorphism and an antiautomorphism of $O_{q}$.

Lemma 3.2. (See [16, Lemma 3.3].) There exists an automorphism $\sigma$ of $O_{q}$ that sends

W_{0} \mapsto W_{1}, \quad W_{1} \mapsto W_{0}
$$

Lemma 3.3. (See [16, Lemma 3.4].) There exists an antiautomorphism $\dagger$ of $O_{q}$ that sends

$$
W_{0} \mapsto W_{0}, \quad W_{1} \mapsto W_{1}
$$

Lemma 3.4. With reference to Lemmas 3.2 and 3.3, we have $\sigma \circ \dagger=\dagger \circ \sigma$ in $O_{q}$. That is to say, this diagram commutes:


Proof. Chase $W_{0}$ and $W_{1}$ around the diagram.
We recall the alternating central extension of $O_{q}$.
Definition 3.5. (See [7, Definition 3.1]) Define the algebra $\mathcal{O}_{q}$ by the generators

\left\{\mathcal{W}_{-k}\right\}_{k=0}^{\infty}, \quad\left\{\mathcal{W}_{k+1}\right\}_{k=0}^{\infty}, \quad\left\{\mathcal{G}_{k+1}\right\}_{k=0}^{\infty}, \quad\left\{\tilde{\mathcal{G}}_{k+1}\right\}_{k=0}^{\infty} \tag{4}
\end{equation*}
$$

and the following relations. For $k, \ell \in \mathbb{N}$,

\begin{align*}
& {\left[\mathcal{W}_{0}, \mathcal{W}_{k+1}\right]=\left[\mathcal{W}_{-k}, \mathcal{W}_{1}\right]=\left(\tilde{\mathcal{G}}_{k+1}-\mathcal{G}_{k+1}\right) /\left(q+q^{-1}\right),}  \tag{5}\\
& {\left[\mathcal{W}_{0}, \mathcal{G}_{k+1}\right]_{q}=\left[\tilde{\mathcal{G}}_{k+1}, \mathcal{W}_{0}\right]_{q}=\rho \mathcal{W}_{-k-1}-\rho \mathcal{W}_{k+1},}  \tag{6}\\
& {\left[\mathcal{G}_{k+1}, \mathcal{W}_{1}\right]_{q}=\left[\mathcal{W}_{1}, \tilde{\mathcal{G}}_{k+1}\right]_{q}=\rho \mathcal{W}_{k+2}-\rho \mathcal{W}_{-k},}  \tag{7}\\
& {\left[\mathcal{W}_{-k}, \mathcal{W}_{-\ell}\right]=0,}  \tag{8}\\
& {\left[\mathcal{W}_{k+1}, \mathcal{W}_{\ell+1}\right]=0,}  \tag{9}\\
& {\left[\mathcal{W}_{-k}, \mathcal{W}_{\ell+1}\right]+\left[\mathcal{W}_{k+1}, \mathcal{W}_{-\ell}\right]=0,}  \tag{10}\\
& {\left[\mathcal{W}_{-k}, \mathcal{G}_{\ell+1}\right]+\left[\mathcal{G}_{k+1}, \mathcal{W}_{-\ell}\right]=0,}  \tag{11}\\
& {\left[\mathcal{W}_{-k}, \tilde{\mathcal{G}}_{\ell+1}\right]+\left[\tilde{\mathcal{G}}_{k+1}, \mathcal{W}_{-\ell}\right]=0,}  \tag{12}\\
& {\left[\mathcal{W}_{k+1}, \mathcal{G}_{\ell+1}\right]+\left[\mathcal{G}_{k+1}, \mathcal{W}_{\ell+1}\right]=0,}  \tag{13}\\
& {\left[\mathcal{W}_{k+1}, \tilde{\mathcal{G}}_{\ell+1}\right]+\left[\tilde{\mathcal{G}}_{k+1}, \mathcal{W}_{\ell+1}\right]=0,}  \tag{14}\\
& {\left[\mathcal{G}_{k+1}, \mathcal{G}_{\ell+1}\right]=0,}  \tag{15}\\
& {\left[\tilde{\mathcal{G}}_{k+1}, \tilde{\mathcal{G}}_{\ell+1}\right]=0,}  \tag{16}\\
& {\left[\tilde{\mathcal{G}}_{k+1}, \mathcal{G}_{\ell+1}\right]+\left[\mathcal{G}_{k+1}, \tilde{\mathcal{G}}_{\ell+1}\right]=0 .} \tag{17}
\end{align*}
$$

In these equations, $\rho=-\left(q^{2}-q^{-2}\right)^{2}$.
The algebra $\mathcal{O}_{q}$ is called the alternating central extension of $O_{q}$. The elements in (4) are called the alternating generators of $\mathcal{O}_{q}$.

For notational convenience, we define

$$
\mathcal{G}_{0}=-\left(q-q^{-1}\right)\left(q+q^{-1}\right)^{2}, \quad \tilde{\mathcal{G}}_{0}=-\left(q-q^{-1}\right)\left(q+q^{-1}\right)^{2} .
$$

For the remainder of this section, we explain how $O_{q}$ and $\mathcal{O}_{q}$ are related.

Proposition 3.6. (See [3, Section 3].) In $\mathcal{O}_{q}$, we have

\begin{aligned}
& {\left[\mathcal{W}_{0},\left[\mathcal{W}_{0},\left[\mathcal{W}_{0}, \mathcal{W}_{1}\right]_{q}\right]_{q^{-1}}\right]=-\left(q^{2}-q^{-2}\right)^{2}\left[\mathcal{W}_{0}, \mathcal{W}_{1}\right]} \\
& {\left[\mathcal{W}_{1},\left[\mathcal{W}_{1},\left[\mathcal{W}_{1}, \mathcal{W}_{0}\right]_{q}\right]_{q^{-1}}\right]=-\left(q^{2}-q^{-2}\right)^{2}\left[\mathcal{W}_{1}, \mathcal{W}_{0}\right] .}
\end{aligned}
$$

We have defined an automorphism and an antiautomorphism of $O_{q}$. We define analogous maps for $\mathcal{O}_{q}$.

Lemma 3.7. (See [15, Lemma 3.1].) There exists an automorphism $\sigma$ of $\mathcal{O}_{q}$ that sends

$$
\mathcal{W}_{-k} \mapsto \mathcal{W}_{k+1}, \quad \mathcal{W}_{k+1} \mapsto \mathcal{W}_{-k}, \quad \mathcal{G}_{k+1} \mapsto \tilde{\mathcal{G}}_{k+1}, \quad \tilde{\mathcal{G}}_{k+1} \mapsto \mathcal{G}_{k+1}
$$

for all $k \in \mathbb{N}$.
Lemma 3.8. (See [15, Lemma 3.2].) There exists an antiautomorphism $\dagger$ of $\mathcal{O}_{q}$ that sends

\mathcal{W}_{-k} \mapsto \mathcal{W}_{-k}, \quad \mathcal{W}_{k+1} \mapsto \mathcal{W}_{k+1}, \quad \mathcal{G}_{k+1} \mapsto \tilde{\mathcal{G}}_{k+1}, \quad \tilde{\mathcal{G}}_{k+1} \mapsto \mathcal{G}_{k+1}
$$

for all $k \in \mathbb{N}$.
Lemma 3.9. This diagram commutes:


Proof. Chase the alternating generators of $\mathcal{O}_{q}$ around the diagram.
We bring in some notation. Let $\left\{z_{i}\right\}_{i=1}^{\infty}$ be mutually commuting indeterminates. Let $K\left[z_{1}, z_{2}, \ldots\right]$ denote the algebra of polynomials in $\left\{z_{i}\right\}_{i=1}^{\infty}$ that have coefficients in $K$.

Proposition 3.10. There exists an algebra isomorphism

$$
\phi: O_{q} \otimes K\left[z_{1}, z_{2}, \ldots\right] \mapsto \mathcal{O}_{q}
$$

such that

$$
\phi\left(W_{0} \otimes 1\right)=\mathcal{W}_{0}, \quad \phi\left(W_{1} \otimes 1\right)=\mathcal{W}_{1}
$$

and these diagrams commute:


Proof. The map $\phi$ is the isomorphism defined in [16, Proposition 8.8]. The diagrams commute by [16, Proposition 8.9].
Definition 3.11. For $i \geq 1$, define $\mathcal{Z}_{i}=\phi\left(1 \otimes z_{i}\right)$. For notational convenience, define $\mathcal{Z}_{0}=\left(q+q^{-1}\right)^{2}$.
Lemma 3.12. The elements

$$
\mathcal{W}_{0}, \quad \mathcal{W}_{1}, \quad\left\{\mathcal{Z}_{i}\right\}_{i=1}^{\infty}
$$

generate $\mathcal{O}_{q}$. Moreover, the elements $\left\{\mathcal{Z}_{i}\right\}_{i=1}^{\infty}$ are central in $\mathcal{O}_{q}$.
Proof. By Proposition 3.10 and since $1 \otimes z_{i}$ is central in $O_{q} \otimes K\left[z_{1}, z_{2}, \ldots\right]$ for $i \geq 1$.

Definition 3.13. Define an algebra homomorphism $\epsilon: K\left[z_{1}, z_{2}, \ldots\right] \mapsto K$ that sends $z_{i} \mapsto 0$ for $i \geq 1$.
Definition 3.14. (See [16, Definition 11.2].) Let $\gamma: \mathcal{O}_{q} \mapsto O_{q}$ denote the composition

$$
\gamma: \quad \mathcal{O}_{q} \xrightarrow{\phi^{-1}} O_{q} \otimes K\left[z_{1}, z_{2}, \ldots\right] \xrightarrow{i d \otimes \epsilon} O_{q} \otimes K \xrightarrow{x \otimes 1 \mapsto x} O_{q},
$$

where $\phi$ is from Proposition 3.10.
Note that $\gamma$ is an algebra homomorphism.
Lemma 3.15. The map $\gamma$ sends

$$
\mathcal{W}_{0} \mapsto W_{0}, \quad \mathcal{W}_{1} \mapsto W_{1}, \quad \mathcal{Z}_{i} \mapsto 0, \quad i \geq 1
$$

Proof. Routine consequence of Definition 3.14.
Definition 3.16. (See [16, Definition 11.5].) For $k \in \mathbb{N}$, define
$W_{-k}=\gamma\left(\mathcal{W}_{-k}\right), \quad W_{k+1}=\gamma\left(\mathcal{W}_{k+1}\right), \quad G_{k+1}=\gamma\left(\mathcal{G}_{k+1}\right), \quad \tilde{G}_{k+1}=\gamma\left(\tilde{\mathcal{G}}_{k+1}\right)$.
We call these elements the alternating elements of $O_{q}$. For notational convenience, we define

$$
G_{0}=-\left(q-q^{-1}\right)\left(q+q^{-1}\right)^{2}, \quad \quad \tilde{G}_{0}=-\left(q-q^{-1}\right)\left(q+q^{-1}\right)^{2}
$$

Lemma 3.17. These diagrams commute:


Proof. Chase $\mathcal{W}_{0}, \mathcal{W}_{1}$, and $\mathcal{Z}_{i}$ around each diagram.
Corollary 3.18. Pick $k \in \mathbb{N}$. The automorphism $\sigma$ of $O_{q}$ sends

$$
W_{-k} \mapsto W_{k+1}, \quad W_{k+1} \mapsto W_{-k}, \quad G_{k+1} \mapsto \tilde{G}_{k+1}, \quad \tilde{G}_{k+1} \mapsto G_{k+1}
$$

The antiautomorphism $\dagger$ of $O_{q}$ sends

$$
W_{-k} \mapsto W_{-k}, \quad W_{k+1} \mapsto W_{k+1}, \quad G_{k+1} \mapsto \tilde{G}_{k+1}, \quad \tilde{G}_{k+1} \mapsto G_{k+1}
$$

Proof. Chase $\mathcal{W}_{-k}, \mathcal{W}_{k+1}, \mathcal{G}_{k+1}$, and $\tilde{\mathcal{G}}_{k+1}$ around the diagrams in Lemma3.17.

## 4 The quantum torus

In this section we consider an algebra called the quantum torus, denoted $T_{q}$. We review some properties of $T_{q}$ and display a basis for the vector space $T_{q}$. Then we introduce an algebra homomorphism $p: O_{q} \mapsto T_{q}$ and consider the $p$-images of the alternating elements of $O_{q}$.

Definition 4.1. (See [9].) Define the algebra $T_{q}$ by generators

$$
x, y, x^{-1}, y^{-1}
$$

and relations

$$
\begin{equation*}
x x^{-1}=1=x^{-1} x, \quad y y^{-1}=1=y^{-1} y, \quad x y=q^{2} y x \tag{18}
\end{equation*}
$$

The algebra $T_{q}$ is called the quantum torus.
Lemma 4.2. The following relations hold in $T_{q}$ :

$$
\begin{aligned}
x y & =q^{2} y x, \\
x^{-1} y & =q^{-2} y x^{-1}, \\
x^{-1} y^{-1} & =q^{2} y^{-1} x^{-1}, \\
x y^{-1} & =q^{-2} y^{-1} x .
\end{aligned}
$$

Proof. Routine consequence of the relations in (18).
We display a basis for the vector space $T_{q}$.
Lemma 4.3. (See [9, p. 3].) The vector space $T_{q}$ has a basis consisting of $\left\{x^{a} y^{b} \mid a, b \in\right.$ $\mathbb{Z}\}$.

Definition 4.4. For the algebra $T_{q}$, define

$$
\begin{equation*}
w_{0}=x+x^{-1}, \quad w_{1}=y+y^{-1} \tag{19}
\end{equation*}
$$

We describe how $w_{0}$ and $w_{1}$ are related.
Lemma 4.5. In the algebra $T_{q}$, we have

$$
\begin{align*}
{\left[w_{0},\left[w_{0}, w_{1}\right]_{q}\right]_{q^{-1}} } & =-\left(q^{2}-q^{-2}\right)^{2} w_{1}  \tag{20}\\
{\left[w_{1},\left[w_{1}, w_{0}\right]_{q}\right]_{q^{-1}} } & =-\left(q^{2}-q^{-2}\right)^{2} w_{0} \tag{21}
\end{align*}
$$

Proof. Write (20) and (21) in terms of $x$ and $y$ using (19) and simplify the result using Lemma 4.2.

Remark. A variation of Definition 4.4 and Lemma 4.5 can be found in 4, eqn. (30) and above eqn. (32)].

Corollary 4.6. In the algebra $T_{q}$, we have

\begin{align*}
& {\left[w_{0},\left[w_{0},\left[w_{0}, w_{1}\right]_{q}\right]_{q^{-1}}\right]=-\left(q^{2}-q^{-2}\right)^{2}\left[w_{0}, w_{1}\right]}  \tag{22}\\
& {\left[w_{1},\left[w_{1},\left[w_{1}, w_{0}\right]_{q}\right]_{q^{-1}}\right]=-\left(q^{2}-q^{-2}\right)^{2}\left[w_{1}, w_{0}\right] .} \tag{23}
\end{align*}
$$

Proof. To obtain equation (22), take the commutator of $w_{0}$ with both sides of equation (20). To obtain equation (23), take the commutator of $w_{1}$ with both sides of equation (21).

Proposition 4.7. There exists an algebra homomorphism $p: O_{q} \mapsto T_{q}$ that sends $W_{0} \mapsto w_{0}$ and $W_{1} \mapsto w_{1}$.

Proof. The relations in Corollary 4.6 are the $q$-Dolan-Grady relations.
Definition 4.8. For $k \in \mathbb{N}$, we define the following elements of $T_{q}$ :

$$
\begin{equation*}
w_{-k}=p\left(W_{-k}\right), \quad w_{k+1}=p\left(W_{k+1}\right), \quad g_{k+1}=p\left(G_{k+1}\right), \quad \tilde{g}_{k+1}=p\left(\tilde{G}_{k+1}\right) \tag{24}
\end{equation*}
$$

The elements in (24) are called the alternating elements of $T_{q}$.
For notational convenience, we define

$$
g_{0}=-\left(q-q^{-1}\right)\left(q+q^{-1}\right)^{2}, \quad \quad \tilde{g}_{0}=-\left(q-q^{-1}\right)\left(q+q^{-1}\right)^{2}
$$

Since $O_{q}$ is generated by $W_{0}$ and $W_{1}$, the alternating elements of $O_{q}$ are polynomials in $W_{0}$ and $W_{1}$. However, only recursive formulas for these polynomials are known. The situation is different for $T_{q}$. We will express the alternating elements of $T_{q}$ in the basis for $T_{q}$ given in Lemma 4.3. This will provide attractive closed forms for the alternating elements of $T_{q}$.

## 5 An automorphism and antiautomorphism of $T_{q}$

In this section we define an automorphism and an antiautomorphism of $T_{q}$.
Lemma 5.1. There exists an automorphism $\tau$ of $T_{q}$ that sends

$$
x \mapsto y^{-1}, \quad y \mapsto x, \quad x^{-1} \mapsto y, \quad y^{-1} \mapsto x^{-1}
$$

Proof. Define

$$
x_{\tau}=y^{-1}, \quad y_{\tau}=x, \quad\left(x^{-1}\right)_{\tau}=y, \quad\left(y^{-1}\right)_{\tau}=x^{-1}
$$

One routinely checks that $x_{\tau}, y_{\tau},\left(x^{-1}\right)_{\tau}$, and $\left(y^{-1}\right)_{\tau}$ satisfy the defining relations in (18).

Consequently, there is an algebra homomorphism $\tau: T_{q} \rightarrow T_{q}$ that sends

$$
x \mapsto x_{\tau}, \quad y \mapsto y_{\tau}, \quad x^{-1} \mapsto\left(x^{-1}\right)_{\tau}, \quad y^{-1} \mapsto\left(y^{-1}\right)_{\tau} .
$$

Note that $\tau^{4}$ fixes $x, y, x^{-1}$, and $y^{-1}$. Hence, $\tau^{4}$ is the identity map, so the map $\tau$ is invertible. Thus $\tau$ is an automorphism of $T_{q}$.

Lemma 5.2. There exists an antiautomorphism $\ddagger$ of $T_{q}$ that sends

$$
x \mapsto x^{-1}, \quad y \mapsto y, \quad x^{-1} \mapsto x, \quad y^{-1} \mapsto y^{-1}
$$

Proof. Define

$$
x_{\ddagger}=x^{-1}, \quad y_{\ddagger}=y, \quad\left(x^{-1}\right)_{\ddagger}=x, \quad\left(y^{-1}\right)_{\ddagger}=y^{-1} .
$$

The opposite algebra $T_{q}^{\mathrm{op}}$ is explained in Section 2. By this explanation and (18), the defining relations of $T_{q}^{\mathrm{op}}$ are

$$
x x^{-1}=1=x^{-1} x, \quad y y^{-1}=1=y^{-1} y, \quad y x=q^{2} x y .
$$

These relations are satisfied by $x_{\ddagger}, y_{\ddagger}, x_{\ddagger}^{-1}, y_{\ddagger}^{-1}$.
Therefore, there is an algebra homomorphism $\ddagger: T_{q} \rightarrow T_{q}^{\mathrm{op}}$ that sends

$$
x \mapsto x_{\ddagger}, \quad y \mapsto y_{\ddagger}, \quad x^{-1} \mapsto\left(x^{-1}\right)_{\ddagger}, \quad y^{-1} \mapsto\left(y^{-1}\right)_{\ddagger} .
$$

Note that $\ddagger^{2}$ fixes $x, y, x^{-1}$, and $y^{-1}$, so $\ddagger^{2}$ is the identity map of $T_{q}$. It follows that $\ddagger$ is a bijection and hence an antiautomorphism of $T_{q}$.

Lemma 5.3. These diagrams commute:


Proof. Chase $W_{0}$ and $W_{1}$ around each diagram.

## 6 Some generating functions

Our goal for the paper is to write the alternating elements of $T_{q}$ in the basis from Lemma 4.3. We do so using generating functions. In this section we define these generating functions and discuss their properties.

Definition 6.1. (See [16, Definition 7.1].) For the algebra $\mathcal{O}_{q}$, define the generating functions

$$
\begin{align*}
\mathcal{W}^{-}(t)=\sum_{i=0}^{\infty} \mathcal{W}_{-i} t^{i}, & \mathcal{W}^{+}(t)=\sum_{i=0}^{\infty} \mathcal{W}_{i+1} t^{i}, \\
\mathcal{G}(t)=\sum_{i=0}^{\infty} \mathcal{G}_{i} t^{i}, & \tilde{\mathcal{G}}(t)=\sum_{i=0}^{\infty} \tilde{\mathcal{G}}_{i} t^{i} . \tag{25}
\end{align*}
$$

Definition 6.2. (See [16, Definition 12.1].) For the algebra $O_{q}$, define the generating functions

$$
\begin{align*}
W^{-}(t) & =\sum_{i=0}^{\infty} W_{-i} t^{i}, \\
G(t) & =\sum_{i=0}^{\infty} G_{i} t^{i}, \tag{26}
\end{align*} \quad \tilde{G}(t)=\sum_{i=0}^{\infty} W_{i+1} t^{i}, ~ \tilde{G}_{i} t^{i} .
$$

Definition 6.3. For the algebra $T_{q}$, define the generating functions

$$
\begin{array}{cl}
w^{-}(t)=\sum_{i=0}^{\infty} w_{-i} t^{i}, & w^{+}(t)=\sum_{i=0}^{\infty} w_{i+1} t^{i},  \tag{27}\\
g(t)=\sum_{i=0}^{\infty} g_{i} t^{i}, & \tilde{g}(t)=\sum_{i=0}^{\infty} \tilde{g}_{i} t^{i} .
\end{array}
$$

Recall the algebra homomorphism $\gamma$ from Definition 3.14.
Lemma 6.4. The map $\gamma$ sends the generating functions in (25) to the generating functions in (26) as follows.

$$
\begin{array}{c|llll}
\text { argument in } \mathcal{O}_{q} & \mathcal{W}^{-}(t) & \mathcal{W}^{+}(t) & \mathcal{G}(t) & \tilde{\mathcal{G}}(t) \\
\hline \text { image in } O_{q} & W^{-}(t) & W^{+}(t) & G(t) & \tilde{G}(t)
\end{array}
$$

Proof. By Definition 3.16,
Recall the algebra homomorphism $p$ from Proposition 4.7.
Lemma 6.5. The map $p$ sends the generating functions in (26) to the generating functions in (27) as follows.

$$
\begin{array}{c|cccc}
\text { argument in } O_{q} & W^{-}(t) & W^{+}(t) & G(t) & \tilde{G}(t) \\
\hline \text { image in } T_{q} & w^{-}(t) & w^{+}(t) & g(t) & \tilde{g}(t)
\end{array}
$$

Proof. By Definition 4.8.
Next, we express the relations (5)-(17) in terms of generating functions.
Lemma 6.6. (See [16, Lemma 7.2].) The following relations hold in the algebra
$\mathcal{O}_{q}$.

$$
\begin{align*}
& {\left[\mathcal{W}_{0}, \mathcal{W}^{+}(t)\right]=\left[\mathcal{W}^{-}(t), \mathcal{W}_{1}\right]=t^{-1}(\tilde{\mathcal{G}}(t)-\mathcal{G}(t)) /\left(q+q^{-1}\right),}  \tag{28}\\
& {\left[\mathcal{W}_{0}, \mathcal{G}(t)\right]_{q}=\left[\tilde{\mathcal{G}}(t), \mathcal{W}_{0}\right]_{q}=\rho \mathcal{W}^{-}(t)-\rho t \mathcal{W}^{+}(t),}  \tag{29}\\
& {\left[\mathcal{G}(t), \mathcal{W}_{1}\right]_{q}=\left[\mathcal{W}_{1}, \tilde{\mathcal{G}}(t)\right]_{q}=\rho \mathcal{W}^{+}(t)-\rho t \mathcal{W}^{-}(t),}  \tag{30}\\
& {\left[\mathcal{W}^{-}(s), \mathcal{W}^{-}(t)\right]=0, \quad\left[\mathcal{W}^{+}(s), \mathcal{W}^{+}(t)\right]=0,}  \tag{31}\\
& {\left[\mathcal{W}^{-}(s), \mathcal{W}^{+}(t)\right]+\left[\mathcal{W}^{+}(s), \mathcal{W}^{-}(t)\right]=0,}  \tag{32}\\
& s\left[\mathcal{W}^{-}(s), \mathcal{G}(t)\right]+t\left[\mathcal{G}(s), \mathcal{W}^{-}(t)\right]=0,  \tag{33}\\
& s\left[\mathcal{W}^{-}(s), \tilde{\mathcal{G}}(t)\right]+t\left[\tilde{\mathcal{G}}(s), \mathcal{W}^{-}(t)\right]=0,  \tag{34}\\
& s\left[\mathcal{W}^{+}(s), \mathcal{G}(t)\right]+t\left[\mathcal{G}(s), \mathcal{W}^{+}(t)\right]=0,  \tag{35}\\
& s\left[\mathcal{W}^{+}(s), \tilde{\mathcal{G}}(t)\right]+t\left[\tilde{\mathcal{G}}(s), \mathcal{W}^{+}(t)\right]=0,  \tag{36}\\
& {[\mathcal{G}(s), \mathcal{G}(t)]=0, \quad[\tilde{\mathcal{G}}(s), \tilde{\mathcal{G}}(t)]=0,}  \tag{37}\\
& {[\tilde{\mathcal{G}}(s), \mathcal{G}(t)]+[\mathcal{G}(s), \tilde{\mathcal{G}}(t)]=0 .} \tag{38}
\end{align*}
$$

In these equations, $\rho=-\left(q^{2}-q^{-2}\right)^{2}$. We turn our attention to $O_{q}$.
Lemma 6.7. The following equations hold in the algebra $O_{q}$.

$$
\begin{align*}
& {\left[W_{0}, W^{+}(t)\right]=\left[W^{-}(t), W_{1}\right]=t^{-1}(\tilde{G}(t)-G(t)) /\left(q+q^{-1}\right),}  \tag{39}\\
& {\left[W_{0}, G(t)\right]_{q}=\left[\tilde{G}(t), W_{0}\right]_{q}=\rho W^{-}(t)-\rho t W^{+}(t),}  \tag{40}\\
& {\left[G(t), W_{1}\right]_{q}=\left[W_{1}, \tilde{G}(t)\right]_{q}=\rho W^{+}(t)-\rho t W^{-}(t),}  \tag{41}\\
& {\left[W^{-}(s), W^{-}(t)\right]=0, \quad\left[W^{+}(s), W^{+}(t)\right]=0,}  \tag{42}\\
& {\left[W^{-}(s), W^{+}(t)\right]+\left[W^{+}(s), W^{-}(t)\right]=0,}  \tag{43}\\
& s\left[W^{-}(s), G(t)\right]+t\left[G(s), W^{-}(t)\right]=0,  \tag{44}\\
& s\left[W^{-}(s), \tilde{G}(t)\right]+t\left[\tilde{G}(s), W^{-}(t)\right]=0,  \tag{45}\\
& s\left[W^{+}(s), G(t)\right]+t\left[G(s), W^{+}(t)\right]=0,  \tag{46}\\
& s\left[W^{+}(s), \tilde{G}(t)\right]+t\left[\tilde{G}(s), W^{+}(t)\right]=0,  \tag{47}\\
& {[G(s), G(t)]=0, \quad[\tilde{G}(s), \tilde{G}(t)]=0,}  \tag{48}\\
& {[\tilde{G}(s), G(t)]+[G(s), \tilde{G}(t)]=0 .} \tag{49}
\end{align*}
$$

Proof. Apply the map $\gamma$ to relations (28)-(38).
We now turn our attention to $T_{q}$.

Lemma 6.8. The following equations hold in the algebra $T_{q}$.

$$
\begin{align*}
& {\left[w_{0}, w^{+}(t)\right]=\left[w^{-}(t), w_{1}\right]=t^{-1}(\tilde{g}(t)-g(t)) /\left(q+q^{-1}\right),}  \tag{50}\\
& {\left[w_{0}, g(t)\right]_{q}=\left[\tilde{g}(t), w_{0}\right]_{q}=\rho w^{-}(t)-\rho t w^{+}(t),}  \tag{51}\\
& {\left[g(t), w_{1}\right]_{q}=\left[w_{1}, \tilde{g}(t)\right]_{q}=\rho w^{+}(t)-\rho t w^{-}(t),}  \tag{52}\\
& {\left[w^{-}(s), w^{-}(t)\right]=0, \quad\left[w^{+}(s), w^{+}(t)\right]=0,}  \tag{53}\\
& {\left[w^{-}(s), w^{+}(t)\right]+\left[w^{+}(s), w^{-}(t)\right]=0,}  \tag{54}\\
& s\left[w^{-}(s), g(t)\right]+t\left[g(s), w^{-}(t)\right]=0,  \tag{55}\\
& s\left[w^{-}(s), \tilde{g}(t)\right]+t\left[\tilde{g}(s), w^{-}(t)\right]=0,  \tag{56}\\
& s\left[w^{+}(s), g(t)\right]+t\left[g(s), w^{+}(t)\right]=0,  \tag{57}\\
& s\left[w^{+}(s), \tilde{g}(t)\right]+t\left[\tilde{g}(s), w^{+}(t)\right]=0,  \tag{58}\\
& {[g(s), g(t)]=0, \quad[\tilde{g}(s), \tilde{g}(t)]=0,}  \tag{59}\\
& {[\tilde{g}(s), g(t)]+[g(s), \tilde{g}(t)]=0 .} \tag{60}
\end{align*}
$$

Proof. Apply the map $p$ to relations (39)-(49).

## 7 The generating function $\omega(t)$

In this section, we introduce a function that will become useful later on.
Definition 7.1. Define the generating function

$$
\omega(t)=\sum_{i=0}^{\infty}\binom{2 i}{i}\left(\frac{t}{q+q^{-1}}\right)^{2 i}
$$

Note that $\omega(0)=1$.
Remark: The function $\omega(t)$ is the power series expansion of

$$
\left(1-\frac{4 t^{2}}{\left(q+q^{-1}\right)^{2}}\right)^{-\frac{1}{2}}
$$

However, we will not make use of this fact.
Define

$$
\begin{equation*}
T=\frac{q+q^{-1}}{q t+q^{-1} t^{-1}}, \quad S=\frac{q+q^{-1}}{q t^{-1}+q^{-1} t} . \tag{61}
\end{equation*}
$$

Following [15], we express $T$ and $S$ as power series:

$$
\begin{equation*}
T=\left(q+q^{-1}\right) \sum_{\ell=0}^{\infty}(-1)^{\ell} q^{2 \ell+1} t^{2 \ell+1}, \quad S=\left(q+q^{-1}\right) \sum_{\ell=0}^{\infty}(-1)^{\ell} q^{-(2 \ell+1)} t^{2 \ell+1} \tag{62}
\end{equation*}
$$

Lemma 7.2. The following identities hold:

$$
\begin{equation*}
\omega(T)=\frac{1+q^{2} t^{2}}{1-q^{2} t^{2}}, \quad \omega(S)=\frac{1+q^{-2} t^{2}}{1-q^{-2} t^{2}} \tag{63}
\end{equation*}
$$

Proof. We first verify the equation on the left in (63). From (61) and Definition 7.1, we obtain

$$
\omega(T)=\sum_{i=0}^{\infty}\binom{2 i}{i}\left(\frac{1}{q t+q^{-1} t^{-1}}\right)^{2 i}
$$

Recall a special case of the Newton binomial theorem [8, Theorem 5.5.1], which states that for any integer $a$,

$$
(1+z)^{a}=\sum_{j=0}^{\infty}\binom{a}{j} z^{j},
$$

where we define

$$
\binom{a}{j}=\frac{a(a-1) \cdots(a-j+1)}{j!} .
$$

One readily checks that

$$
\binom{-a}{j}=(-1)^{j}\binom{a+j-1}{j}
$$

We express $\left(1+q^{2} t^{2}\right)^{-1} \omega(T)$ as a power series in $t$. We have

$$
\begin{aligned}
\left(1+q^{2} t^{2}\right)^{-1} \omega(T) & =\sum_{i=0}^{\infty}\binom{2 i}{i} \frac{(q t)^{2 i}}{\left(1+q^{2} t^{2}\right)^{2 i+1}} \\
& =\sum_{i=0}^{\infty}\binom{2 i}{i} q^{2 i} t^{2 i} \sum_{j=0}^{\infty}(-1)^{j}\binom{2 i+j}{j} q^{2 j} t^{2 j} \\
& =\sum_{n=0}^{\infty} \sum_{i=0}^{n}(-1)^{n-i}\binom{2 i}{i} q^{2 n} t^{2 n}\binom{n+i}{n-i} \\
& =\sum_{n=0}^{\infty} c_{n} q^{2 n} t^{2 n}
\end{aligned}
$$

where

$$
\begin{equation*}
c_{n}=\sum_{i=0}^{n}(-1)^{n-i}\binom{2 i}{i}\binom{n+i}{n-i} . \tag{64}
\end{equation*}
$$

We claim that $c_{n}=1$ for all $n \geq 0$. Let $n$ be given and consider the expression

$$
\begin{equation*}
\psi(x)=(1-x)^{-n-1}(1-x)^{n} \tag{65}
\end{equation*}
$$

We will compute the coefficient of $x^{n}$ in two ways. First, notice that

$$
\psi(x)=(1-x)^{-n-1}(1-x)^{n}=(1-x)^{-1}=\sum_{i=0}^{\infty} x^{i}
$$

so the coefficient of $x^{n}$ in $\psi(x)$ is equal to 1 .
Second, we expand (65) using the Newton binomial theorem. We have

$$
\begin{equation*}
\psi(x)=(1-x)^{-n-1}(1-x)^{n}=\sum_{s=0}^{\infty} x^{s} \sum_{i=0}^{s}(-1)^{s+i}\binom{n+i}{i}\binom{n}{s-i} \tag{66}
\end{equation*}
$$

In the double sum on the right of (66), the coefficient of $x^{n}$ is

$$
\begin{equation*}
\sum_{i=0}^{n}(-1)^{n+i}\binom{n+i}{i}\binom{n}{n-i}=\sum_{i=0}^{n}(-1)^{n-i}\binom{2 i}{i}\binom{n+i}{n-i} \tag{67}
\end{equation*}
$$

The right side of (67) matches the right side of (64), and therefore is equal to $c_{n}$. Hence, we have shown that $c_{n}=1$, and the claim is proven. By the claim, we have

$$
\left(1+q^{2} t^{2}\right)^{-1} \omega(T)=\sum_{n=0}^{\infty} q^{2 n} t^{2 n}=\frac{1}{1-q^{2} t^{2}}
$$

We have verified the equation on the left in (63). The equation on the right in (63) is similarly verified.

## 8 The first main result

Recall the generating functions from Definition 6.3. In this section, we express these generating functions in the basis for $T_{q}$ given in Lemma 4.3. We now state our first main result.

Theorem 8.1. In the algebra $T_{q}$,

$$
\begin{align*}
w^{-}(t) & =\omega(t)\left(x+x^{-1}\right),  \tag{68}\\
w^{+}(t) & =\omega(t)\left(y+y^{-1}\right),  \tag{69}\\
g(t) & =\left(q^{2}-q^{-2}\right) \omega(t)\left(t\left(q x^{-1} y+q x y^{-1}\right)-q-q^{-1}\right),  \tag{70}\\
\tilde{g}(t) & =\left(q^{2}-q^{-2}\right) \omega(t)\left(t\left(q^{-1} x y+q^{-1} x^{-1} y^{-1}\right)-q-q^{-1}\right) . \tag{71}
\end{align*}
$$

Theorem 8.1 will be proven at the end of this section.
Definition 8.2. In the algebra $\mathcal{O}_{q}$, define

$$
\mathcal{Z}(t)=\sum_{i=0}^{\infty} \mathcal{Z}_{i}\left(q+q^{-1}\right)^{i} t^{i}
$$

where $\mathcal{Z}_{i}$ is from Definition 3.11.
We present two lemmas about $\mathcal{Z}(t)$. Recall $S, T$ from (61) and the homomorphism $\gamma$ from Definition 3.14.

Lemma 8.3. The map $\gamma$ sends $\mathcal{Z}(t) \mapsto\left(q+q^{-1}\right)^{2}$.

Proof. By Lemma 3.15, $\gamma\left(\mathcal{Z}_{i}\right)=0$ for $i \geq 1$. Recall from Definition 3.11 that $\mathcal{Z}_{0}=\left(q+q^{-1}\right)^{2}$. The result follows.

Lemma 8.4. (See [15, Definition 8.4].) In the algebra $\mathcal{O}_{q}$,

$$
\begin{align*}
\mathcal{Z}(t)= & t^{-1} S T \mathcal{W}^{-}(S) \mathcal{W}^{+}(T)+t S T \mathcal{W}^{+}(S) \mathcal{W}^{-}(T)-q^{2} S T \mathcal{W}^{-}(S) \mathcal{W}^{-}(T) \\
& -q^{-2} S T \mathcal{W}^{+}(S) \mathcal{W}^{+}(T)+\left(q^{2}-q^{-2}\right)^{-2} \mathcal{G}(S) \tilde{\mathcal{G}}(T) \tag{72}
\end{align*}
$$

Proof. Let $\mathcal{Z}^{c}(t)$ denote the expression on the right side of equation (72). We expand $S$ and $T$ using the power series in (62). These expansions each have zero constant term, so $t^{-1} S T$ can be written as a power series in $t$. Hence $\mathcal{Z}^{c}(t)$ is a power series, which we express as

$$
\mathcal{Z}^{c}(t)=\sum_{i=0}^{\infty} \mathcal{Z}_{i}^{c}\left(q+q^{-1}\right)^{i} t^{i}
$$

For $i \geq 1$, the map $\phi$ sends $1 \otimes z_{i} \mapsto \mathcal{Z}_{i}^{c}$ by [15, Lemma 9.3], so $\mathcal{Z}_{i}^{c}=\mathcal{Z}_{i}$. By [15, Lemma 8.18], we have $\mathcal{Z}_{0}^{c}=\left(q+q^{-1}\right)^{2}=\mathcal{Z}_{0}$. By these observations, $\mathcal{Z}^{c}(t)=\mathcal{Z}(t)$ and the result follows.

Corollary 8.5. In the algebra $O_{q}$,

$$
\begin{align*}
\left(q+q^{-1}\right)^{2}= & t^{-1} S T W^{-}(S) W^{+}(T)+t S T W^{+}(S) W^{-}(T)-q^{2} S T W^{-}(S) W^{-}(T)  \tag{73}\\
& -q^{-2} S T W^{+}(S) W^{+}(T)+\left(q^{2}-q^{-2}\right)^{-2} G(S) \tilde{G}(T)
\end{align*}
$$

Proof. Routine consequence of Lemmas 8.3 and 8.4 .
Corollary 8.6. In the algebra $T_{q}$,

$$
\begin{align*}
\left(q+q^{-1}\right)^{2}= & t^{-1} S T w^{-}(S) w^{+}(T)+t S T w^{+}(S) w^{-}(T)-q^{2} S T w^{-}(S) w^{-}(T)  \tag{74}\\
& -q^{-2} S T w^{+}(S) w^{+}(T)+\left(q^{2}-q^{-2}\right)^{-2} g(S) \tilde{g}(T)
\end{align*}
$$

Proof. Apply $p$ to both sides of equation (73).
Proof of Theorem 8.1. By [15, Lemma 8.22], there is a unique set of generating functions in $\mathcal{O}_{q}$,

$$
\begin{equation*}
\mathcal{W}_{c}^{-}(t), \quad \mathcal{W}_{c}^{+}(t), \quad \mathcal{G}_{c}(t), \quad \tilde{\mathcal{G}}_{c}(t) \tag{75}
\end{equation*}
$$

that satisfy equations (28) $-(38)$, equation (72), and the conditions

$$
\begin{equation*}
\mathcal{W}_{c}^{-}(0)=\mathcal{W}_{0}, \quad \mathcal{W}_{c}^{+}(0)=\mathcal{W}_{1} \tag{76}
\end{equation*}
$$

Applying $\rho \circ \gamma$ to (75) and (76), we see that there is a unique set of generating functions in $T_{q}$,

$$
w_{c}^{-}(t), \quad w_{c}^{+}(t), \quad g_{c}(t), \quad \tilde{g}_{c}(t)
$$

that satisfy equations (50)-(60), equation (74), and the conditions

$$
\begin{equation*}
w_{c}^{-}(0)=w_{0}, \quad w_{c}^{+}(0)=w_{1} . \tag{77}
\end{equation*}
$$

We are going to display this unique solution. Going forward, we define

$$
w_{c}^{-}(t), \quad w_{c}^{+}(t), \quad g_{c}(t), \quad \tilde{g}_{c}(t)
$$

to be the right-hand sides of equations (68)-(71), in that order.
Since $\omega(0)=1$, these candidates satisfy (77). Therefore, it suffices to show that these candidates satisfy equations (74) and (50)-(60).

We begin with (74). We claim that in the algebra $T_{q}$,

$$
\begin{align*}
\left(q+q^{-1}\right)^{2}= & t^{-1} S T w_{c}^{-}(S) w_{c}^{+}(T)+t S T w_{c}^{+}(S) w_{c}^{-}(T)-q^{2} S T w_{c}^{-}(S) w_{c}^{-}(T) \\
& -q^{-2} S T w_{c}^{+}(S) w_{c}^{+}(T)+\left(q^{2}-q^{-2}\right)^{-2} g_{c}(S) \tilde{g}_{c}(T) \tag{78}
\end{align*}
$$

To show this, we evaluate equations (68) -(71) using (61) and (63) to obtain the following equations:

$$
\begin{align*}
w_{c}^{-}(S) & =\frac{1+q^{-2} t^{2}}{1-q^{-2} t^{2}}\left(x+x^{-1}\right)  \tag{79}\\
w_{c}^{+}(S) & =\frac{1+q^{-2} t^{2}}{1-q^{-2} t^{2}}\left(y+y^{-1}\right)  \tag{80}\\
w_{c}^{-}(T) & =\frac{1+q^{2} t^{2}}{1-q^{2} t^{2}}\left(x+x^{-1}\right)  \tag{81}\\
w_{c}^{+}(T) & =\frac{1+q^{2} t^{2}}{1-q^{2} t^{2}}\left(y+y^{-1}\right)  \tag{82}\\
g_{c}(S) & =\frac{\left(q+q^{-1}\right)^{2}\left(q-q^{-1}\right)\left(1+q^{-2} t^{2}\right)}{\left(1-q^{-2} t^{2}\right)\left(q t^{-1}+q^{-1} t\right)}\left(q x y^{-1}+q x^{-1} y-q t^{-1}-q^{-1} t\right)  \tag{83}\\
\tilde{g}_{c}(T) & =\frac{\left(q+q^{-1}\right)^{2}\left(q-q^{-1}\right)\left(1+q^{2} t^{2}\right)}{\left(1-q^{2} t^{2}\right)\left(q t+q^{-1} t^{-1}\right)}\left(q^{-1} x y+q^{-1} x^{-1} y^{-1}-q t-q^{-1} t^{-1}\right) . \tag{84}
\end{align*}
$$

To verify (78), we evaluate the expression on its right using equations (79)(84). We have now verified (78), and with it (74). The equations (50)-(60) can be verified in a straightforward manner. The reader is welcome to see Appendix A for more details.

We have now verified that the candidate functions satisfy (50)-(60) and (74), so the proof is complete.

## 9 The second main result

In this section we use the formulas in Theorem 8.1 to express the alternating elements of $T_{q}$ in the basis for $T_{q}$ given in Lemma 4.3,

Throughout this section, $j$ is a natural number. The following is our second main result.

Theorem 9.1. In the table below, we express the alternating elements of $T_{q}$ in the basis for $T_{q}$ from Lemma 4.3. For $k \in \mathbb{N}$,

|  | Case $k=2 j$ | Case $k=2 j+1$ |
| :---: | :---: | :---: |
| $w_{k+1}$ | $\binom{2 j}{j}\left(q+q^{-1}\right)^{-2 j}\left(y+y^{-1}\right)$ | 0 |
| $w_{-k}$ | $\binom{2 j}{j}\left(q+q^{-1}\right)^{-2 j}\left(x+x^{-1}\right)$ | 0 |
| $g_{k}$ | $-\binom{2 j}{j}\left(q-q^{-1}\right)\left(q+q^{-1}\right)^{2-2 j}$ | $\binom{2 j}{j} q\left(q-q^{-1}\right)\left(q+q^{-1}\right)^{1-2 j}\left(x y^{-1}+x^{-1} y\right)$ |
| $\tilde{g}_{k}$ | $-\binom{2 j}{j}\left(q-q^{-1}\right)\left(q+q^{-1}\right)^{2-2 j}$ | $\binom{2 j}{j} q^{-1}\left(q-q^{-1}\right)\left(q+q^{-1}\right)^{1-2 j}\left(x y+x^{-1} y^{-1}\right)$ |

Proof. We begin with $\tilde{g}_{k}$. Expanding $\omega(t)$ in the right side of (71), we have

$$
\begin{equation*}
\tilde{g}(t)=\left(q^{2}-q^{-2}\right)\left(t\left(q^{-1} x y+q^{-1} x^{-1} y^{-1}\right)-\left(q+q^{-1}\right)\right) \sum_{i=0}^{\infty}\binom{2 i}{i} \frac{t^{2 i}}{\left(q+q^{-1}\right)^{2 i}} . \tag{85}
\end{equation*}
$$

We examine the coefficient of $t^{k}$ in (85) and obtain the following equations:

$$
\begin{array}{ll}
\tilde{g}_{k}=-\binom{2 j}{j}\left(q-q^{-1}\right)\left(q+q^{-1}\right)^{2-2 j} & \text { for } k=2 j, \\
\tilde{g}_{k}=\binom{2 j}{j}\left(q-q^{-1}\right)\left(q+q^{-1}\right)^{1-2 j}\left(q^{-1} x y+q^{-1} x^{-1} y^{-1}\right) \text { for } k=2 j+1 . \tag{87}
\end{array}
$$

Expanding $\omega(t)$ in the right side of (70), we have

$$
\begin{equation*}
g(t)=\left(q^{2}-q^{-2}\right)\left(t\left(q x y^{-1}+q x^{-1} y\right)-\left(q+q^{-1}\right)\right) \sum_{i=0}^{\infty}\binom{2 i}{i} \frac{t^{2 i}}{\left(q+q^{-1}\right)^{2 i}} \tag{88}
\end{equation*}
$$

We examine the coefficient of $t^{k}$ in (88) and obtain the following equations:

$$
\begin{array}{ll}
g_{k}=-\binom{2 j}{j}\left(q-q^{-1}\right)\left(q+q^{-1}\right)^{2-2 j} & \text { for } k=2 j, \\
g_{k}=\binom{2 j}{j}\left(q-q^{-1}\right)\left(q+q^{-1}\right)^{1-2 j}\left(q x y^{-1}+q x^{-1} y\right) & \text { for } k=2 j+1 \tag{90}
\end{array}
$$

Expanding $\omega(t)$ in the right side of (69), we have

$$
\begin{equation*}
w^{+}(t)=\left(y+y^{-1}\right) \sum_{i=0}^{\infty}\binom{2 i}{i} \frac{t^{2 i}}{\left(q+q^{-1}\right)^{2 i}} \tag{91}
\end{equation*}
$$

We examine the coefficient of $t^{k}$ in (91) and obtain the following equations:

$$
\begin{array}{ll}
w_{k+1}=\binom{2 j}{j}\left(q+q^{-1}\right)^{-2 j}\left(y+y^{-1}\right) & \text { for } k=2 j \\
w_{k+1}=0 & \text { for } k=2 j+1 \tag{93}
\end{array}
$$

Expanding $\omega(t)$ in the right side of (68), we have

$$
\begin{equation*}
w^{-}(t)=\left(x+x^{-1}\right) \sum_{i=0}^{\infty}\binom{2 i}{i} \frac{t^{2 i}}{\left(q+q^{-1}\right)^{2 i}} \tag{94}
\end{equation*}
$$

We examine the coefficient of $t^{k}$ in (94) and obtain the following equations:

$$
\begin{array}{ll}
w_{-k}=\binom{2 j}{j}\left(q+q^{-1}\right)^{-2 j}\left(x+x^{-1}\right) & \text { for } k=2 j \\
w_{-k}=0 & \text { for } k=2 j+1 .
\end{array}
$$

We end this section with a comment. From the table given in Theorem 9.1, we see that each alternating element of $T_{q}$ is a linear combination of the following nine elements:

$$
1, \quad x, \quad y, \quad x^{-1}, \quad y^{-1}, \quad x y, \quad x y^{-1}, \quad x^{-1} y, \quad x^{-1} y^{-1} .
$$

The above elements are linearly independent. Therefore, the alternating elements of $T_{q}$ are contained in a 9-dimensional subspace of $T_{q}$.

## Appendix A: Details from the proof of Theorem 8.1

This appendix clarifies some details regarding the proof of Theorem 8.1. We seek to show that the generating functions in (68)-(71) satisfy relations (50)-(60).

To simplify our arguments, we use the fact that the automorphism $\tau$ of $T_{q}$ sends

$$
w^{+}(t) \mapsto w^{-}(t), \quad w^{-}(t) \mapsto w^{+}(t), \quad g(t) \mapsto \tilde{g}(t), \quad \tilde{g}(t) \mapsto g(t)
$$

We consider (50)-(60) individually.

- We show that $\left[w_{0}, w^{+}(t)\right]=\left[w^{-}(t), w_{1}\right]$.

By Definition 4.4, we have

$$
\begin{aligned}
{\left[w_{0}, w^{+}(t)\right] } & =\left[w_{0}, \omega(t)\left(y+y^{-1}\right)\right]=\omega(t)\left[x+x^{-1}, y+y^{-1}\right] \\
& =\left[\omega(t)\left(x+x^{-1}\right), w_{1}\right]=\left[w^{-}(t), w_{1}\right] .
\end{aligned}
$$

- We show that $\left[w^{-}(t), w_{1}\right]=\frac{\tilde{g}(t)-g(t)}{t\left(q+q^{-1}\right)}$.

We have

$$
\begin{aligned}
t^{-1} \frac{\tilde{g}(t)-g(t)}{q+q^{-1}} & =t^{-1} \frac{\left(q^{2}-q^{-2}\right) t \omega(t)\left(q^{-1} x y+q^{-1} x^{-1} y^{-1}-q x y^{-1}-q x^{-1} y\right)}{q+q^{-1}} \\
& =\left(q-q^{-1}\right) \omega(t)\left(q^{-1} x y+q^{-1} x^{-1} y^{-1}-q x y^{-1}-q x^{-1} y\right) \\
& =\omega(t)\left[w_{0}, w_{1}\right] \\
& =\left[w^{-}(t), w_{1}\right] .
\end{aligned}
$$

- We show that $\left[w_{0}, g(t)\right]_{q}=\rho w^{-}(t)-\rho t w^{+}(t)$.

We have

$$
\begin{aligned}
{\left[w_{0}, g(t)\right]_{q}=} & q w_{0} g(t)-q^{-1} g(t) w_{0} \\
= & \left(q^{2}-q^{-2}\right) \omega(t)\left(q\left(x+x^{-1}\right)\left(t q x y^{-1}+t q x^{-1} y-q-q^{-1}\right)\right. \\
& \left.-q^{-1}\left(t q x y^{-1}+t q x^{-1} y-q-q^{-1}\right)\left(x+x^{-1}\right)\right) \\
= & \left(q^{2}-q^{-2}\right) \omega(t)\left(\left(t q^{2} y+t q^{2} x^{-2} y+t q^{2} y^{-1}+t q^{2} x^{2} y^{-1}\right.\right. \\
& \left.-q^{2} x-q^{2} x^{-1}-x-x^{-1}\right)-\left(t q^{-2} y+t q^{-2} y^{-1}\right. \\
& \left.\left.+t q^{2} x^{-2} y+t q^{2} x^{2} y^{-1}-x-x^{-1}-q^{-2} x-q^{-2} x^{-1}\right)\right) \\
= & \left(q^{2}-q^{-2}\right) \omega(t)\left(q^{2}-q^{-2}\right)\left(t y+t y^{-1}-x-x^{-1}\right) \\
= & -\left(q^{2}-q^{-2}\right)^{2}\left(w^{-}(t)-t w^{+}(t)\right) \\
= & \rho w^{-}(t)-\rho t w^{+}(t) .
\end{aligned}
$$

- We show that $\left[w_{1}, \tilde{g}(t)\right]_{q}=\rho w^{+}(t)-\rho t w^{-}(t)$.

Apply the $\tau$ automorphism to the above equation.

- We show that $\left[\tilde{g}(t), w_{0}\right]_{q}=\rho w^{-}(t)-\rho t w^{+}(t)$.

We have

$$
\begin{aligned}
{\left[\tilde{g}(t), w_{0}\right]_{q}=} & q \tilde{g}(t) w_{0}-q^{-1} w_{0} \tilde{g}(t) \\
= & \left(q^{2}-q^{-2}\right) \omega(t)\left(q\left(t q^{-1} x y+t q^{-1} x^{-1} y^{-1}-q-q^{-1}\right)\left(x+x^{-1}\right)\right. \\
& \left.-q^{-1}\left(x+x^{-1}\right)\left(t q^{-1} x y+t q^{-1} x^{-1} y^{-1}-q-q^{-1}\right)\right) \\
= & \left(q^{2}-q^{-2}\right) \omega(t)\left(\left(t q^{2} y+t q^{-2} x^{2} y+t q^{2} y^{-1}+t q^{-2} x^{-2} y^{-1}\right.\right. \\
& \left.-q^{2} x-q^{2} x^{-1}-x-x^{-1}\right)-\left(t q^{-2} y+t q^{-2} y^{-1}\right. \\
& \left.\left.+t q^{-2} x^{-2} y^{-1}+t q^{-2} x^{2} y-x-x^{-1}-q^{-2} x-q^{-2} x^{-1}\right)\right) \\
= & \left(q^{2}-q^{-2}\right) \omega(t)\left(q^{2}-q^{-2}\right)\left(t y+t y^{-1}-x-x^{-1}\right) \\
= & -\left(q^{2}-q^{-2}\right)^{2}\left(w^{-}(t)-t w^{+}(t)\right) \\
= & \rho w^{-}(t)-\rho t w^{+}(t) .
\end{aligned}
$$

- We show that $\left[g(t), w_{1}\right]_{q}=\rho w^{+}(t)-\rho t w^{-}(t)$.

Apply the $\tau$ automorphism to the above equation.

- We show that $\left[w^{-}(s), w^{-}(t)\right]=0$.

We have

$$
\left[w^{-}(s), w^{-}(t)\right]=\omega(s) \omega(t)\left[x+x^{-1}, x+x^{-1}\right]=0
$$

- We show that $\left[w^{+}(s), w^{+}(t)\right]=0$.

We have

$$
\left[w^{+}(s), w^{+}(t)\right]=\omega(s) \omega(t)\left[y+y^{-1}, y+y^{-1}\right]=0 .
$$

- We show that $\left[w^{-}(s), w^{+}(t)\right]+\left[w^{+}(s), w^{-}(t)\right]=0$.

We have

$$
\begin{aligned}
{\left[w^{-}(s), w^{+}(t)\right]=\omega(s) \omega(t)\left[x+x^{-1}, y+y^{-1}\right] } & =-\omega(s) \omega(t)\left[y+y^{-1}, x+x^{-1}\right] \\
& =-\left[w^{+}(s), w^{-}(t)\right]
\end{aligned}
$$

- We show that $s\left[w^{-}(s), g(t)\right]+t\left[g(s), w^{-}(t)\right]=0$.

We have

$$
\begin{aligned}
s\left[w^{-}(s), g(t)\right] & =\left(q^{2}-q^{-2}\right) s \omega(s) \omega(t)\left[x+x^{-1}, t\left(q x y^{-1}+q x^{-1} y\right)-q-q^{-1}\right] \\
& =\left(q^{2}-q^{-2}\right) s t \omega(s) \omega(t)\left[x+x^{-1}, q x y^{-1}+q x^{-1} y\right] \\
& =-\left(q^{2}-q^{-2}\right) t \omega(t) \omega(s)\left[s\left(q x y^{-1}+q x^{-1} y\right)-q-q^{-1}, x+x^{-1}\right] \\
& =-t\left[g(s), w^{-}(t)\right] .
\end{aligned}
$$

- We show that $s\left[w^{+}(s), \tilde{g}(t)\right]+t\left[\tilde{g}(s), w^{+}(t)\right]=0$.

Apply $\tau$ to each side of the previous equation.

- We show that $s\left[w^{-}(s), \tilde{g}(t)\right]+t\left[\tilde{g}(s), w^{-}(t)\right]=0$.

We have

$$
\begin{aligned}
s\left[w^{-}(s), \tilde{g}(t)\right] & =\left(q^{2}-q^{-2}\right) s \omega(s) \omega(t)\left[x+x^{-1}, t\left(q^{-1} x y+q^{-1} x^{-1} y^{-1}\right)-q-q^{-1}\right] \\
& =\left(q^{2}-q^{-2}\right) s t \omega(s) \omega(t)\left[x+x^{-1}, q^{-1} x y+q^{-1} x^{-1} y^{-1}\right] \\
& =-\left(q^{2}-q^{-2}\right) t \omega(t) \omega(s)\left[s\left(q^{-1} x y+q^{-1} x^{-1} y^{-1}\right)-q-q^{-1}, x+x^{-1}\right] \\
& =-t\left[\tilde{g}(s), w^{-}(t)\right] .
\end{aligned}
$$

- We show that $s\left[w^{+}(s), g(t)\right]+t\left[g(s), w^{+}(t)\right]=0$. Apply $\tau$ to each side of the previous equation.
- We show that $[g(s), g(t)]=0$.

We have

$$
\begin{aligned}
{[g(s), g(t)]=} & \left(q^{2}-q^{-2}\right)^{2} \omega(s) \omega(t)\left[s\left(q x y^{-1}+q x^{-1} y\right)-q-q^{-1},\right. \\
& \left.t\left(q x y^{-1}+q x^{-1} y\right)-q-q^{-1}\right] \\
= & \left(q^{2}-q^{-2}\right)^{2} s t \omega(s) \omega(t)\left[q x y^{-1}+q x^{-1} y, q x y^{-1}+q x^{-1} y\right] \\
= & 0
\end{aligned}
$$

- We show that $[\tilde{g}(s), \tilde{g}(t)]=0$.

Apply $\tau$ to each side of the previous equation.

- We show that $[\tilde{g}(s), g(t)]+[g(s), \tilde{g}(t)]=0$.

We have

$$
\begin{aligned}
{[\tilde{g}(s), g(t)]=} & \left(q^{2}-q^{-2}\right)^{2} \omega(s) \omega(t)\left[s\left(q^{-1} x y+q^{-1} x^{-1} y^{-1}\right)-q-q^{-1},\right. \\
& \left.t\left(q x y^{-1}+q x^{-1} y\right)-q-q^{-1}\right] \\
= & \left(q^{2}-q^{-2}\right)^{2} s t \omega(s) \omega(t)\left[q^{-1} x y+q^{-1} x^{-1} y^{-1}, q x y^{-1}+q x^{-1} y\right] \\
= & -\left(q^{2}-q^{-2}\right)^{2} \omega(s) \omega(t)\left[s\left(q x y^{-1}+q x^{-1} y\right)-q-q^{-1},\right. \\
& \left.t\left(q^{-1} x y+q^{-1} x^{-1} y^{-1}\right)-q-q^{-1}\right] \\
= & -[g(s), \tilde{g}(t)] .
\end{aligned}
$$

We have now verified the equations (50)-(60), so the argument is complete.
