HARMONIC METRICS AND SEMI-SIMPLENESS

Abstract. Given a flat vector bundle over a compact Riemannian manifold, Corlette [\[Co1](#page-17-0)] and Donaldson [\[Do3\]](#page-17-1) proved that it admits harmonic metrics if and only if it is semi-simple. In this paper, we extend this equivalence to arbitrary vector bundles without any additional hypothesis, the result can be viewed as a Riemannian Hitchin-Kobayashi correspondence. Furthermore, we also prove an equivalence of categories in Sasakian geometry, relating the category of projective flat complex vector bundles to the category of Higgs bundles.

1. INTRODUCTION

A unifying principle in geometric analysis predicts that existences of canonical metrics should be closely related to appropriate algebraic stability conditions on underlying geometric objects, one may refer to the works on Yau-Tian-Donaldson conjecture for extremal metrics in Kähler geometry and Donaldson-Uhlenbeck-Yau characterization (also referred as Hitchin-Kobayashi correspondence or Kobayashi-Hitchin correspondence) for Hermitian-Einstein metrics in holomorphic vector bundles. It is our aim in present paper to investigate the issue on general vector bundles. Unless indicated explicitly otherwise, vector bundles could be real or complex, whose metrics are Riemannian or Hermitian respectively.

Suppose that E is a smooth vector bundle over a compact Riemannian manifold (M, g) and ∇ is a connection on E. We call (E, ∇) semi-simple(also called completely reducible or reductive in the literature) if it splits as a direct sum of simple sub-bundles, where simple(also called irreducible or stable in the literature) means that there exists no nontrivial ∇-invariant sub-bundle. A vector bundle E is said to be semi-simple if (E, ∇) is semi-simple for some ∇ . Naturally there arises a fundamental problem: *Does there exist certain best canonical metrics* on (E, ∇) ? On the other hand, motivated by calculating the Euler characteristic number $\chi(E)$ via the Gauss-Bonnet-Chern formula and its ramifications, one may ask: *How to find* metric compatible connections on E° . For this purpose, we write for a metric K on E,

\nabla = \nabla_K + \psi_K,
$$

where ∇_K is a connection preserving K and ψ_K is a End(E)-valued 1-form. We define

and the point is to minimize $\mathcal{E}_{\nabla}(K)$ when K varies.

The canonical metric concerned in this paper is the critical point of \mathcal{E}_{∇} which means

$$
\nabla_H^* \psi_H = 0,
$$

and we then call H a harmonic metric. Another reason for this candidate lies in the scenario of nonabelian Hodge theory in Kähler geometry [\[Si3](#page-18-0)], in which ∇ is assumed to be flat and the existence of harmonic metrics leads to the existence of Higgs structures. It is remarked that the flatness means any metric H corresponds to an equivariant map

where M is the universal covering space of M and $r = \text{rank}(E)$, Moreover, it is known that H being harmonic iff f_H being harmonic. So in general case, lacking of flatness may block off methods used in equivariant harmonic maps. Detecting harmonic metrics on vector bundles is a nonlinear system generalization of solving Laplace equations and obstructions would appear.

In this paper, we prove(see Theorem [2.1\)](#page-10-0)

Theorem 1.1. Let (E, ∇) be a vector bundle over a compact Riemannian manifold with an arbitrary connection ∇ , then it admits harmonic metrics if and only if it is semi-simple.

Note that Theorem [1.1](#page-1-0) is a Riemannian counterpart of the Hitchin-Kobayashi correspon-dence in Kähler geometry [\[Do1](#page-17-2), [Do2](#page-17-3), [UY](#page-18-1)]. Concerning Theorem [1.1,](#page-1-0) there are a few previous works in the presence of extra assumptions which we should mention. As a postscript to Hitchin's paper [\[Hi\]](#page-17-4) on self-duality equations, borrowing ideas from harmonic maps, Donaldson [\[Do3](#page-17-1)] proved that any vector bundle over a compact Riemannian surface equipped with a semi-simple flat connection must admit harmonic metrics. Deforming a semi-simple flat connection via an evolution equation and utilizing Uhlenbeck compactness [\[Uh\]](#page-18-2), it is Corlette who proved Theorem [1.1](#page-1-0) for flat vector bundles in [\[Co1](#page-17-0)]. Many works are constantly engaged in generalizations and applications on Corlette-Donaldson's tremendous criterion since then, see $\langle \text{CJY}, \text{Co2}, \text{JZ1}, \text{JZ2}, \text{KV}, \text{Li}, \text{Lo}, \text{Lü}, \text{Mo}, \text{PZZ}, \text{Si2}, \text{WZ} \rangle$. Among other things, if (E, ∇) is non-Hermitian Yang-Mills(see [\[KV\]](#page-17-9) for precise definition) instead of flatness and the base space is a compact Kähler manifold, Kaledin-Verbitsky conjectured($[KV, Conjecture 8.7]$ $[KV, Conjecture 8.7]$) that the existence of harmonic metrics is equivalent to a kind of stability condition, see [\[PSZ\]](#page-18-7).

Given an automorphism $\sigma \in Aut(E)$, it acts on a connection ∇ by $\nabla \mapsto \sigma \circ \nabla \circ \sigma^{-1}$ and the space \mathcal{M}_S of isomorphism classes of simple connections is realized as the quotient

(1.5) $\{Simple\ connections\ on\ E\}/\operatorname{Aut}(E).$

We say a connection ∇ irreducible if there is no nontrivial ∇ -invariant endomorphism and the space $\mathcal{M}_{I,K}$ of isomorphism classes of irreducible connections with $\nabla_K^* \psi_K = 0$ is defined by

(1.6) ${Irreducible\ connections\ } \nabla\ on\ E\ with\ \nabla^*_K\psi_K=0\}/\ U(E,K),$

where $U(E, K) \subseteq Aut(E)$ is the sub-group preserving K.

Using Theorem [1.1,](#page-1-0) we have(see Corollary [2.1\)](#page-10-1)

Corollary 1.1. Assume (E, K) is a Hermitian vector bundle over a compact Riemannian manifold, then there is a bijection from \mathcal{M}_S to $\mathcal{M}_{I,K}$.

Next we are concerned with vector bundles which have Sasakian manifolds as base spaces. Recall Sasakian manifolds were first introduced in [\[Sa\]](#page-18-8), which is a subject lying on the intersection of contact, CR, Riemannian and Kähler geometry. A standard model of a compact

Sasakian manifold is the odd dimensional unit sphere S^{2n+1} . With the robust discovery of its relevance in string theory and anti-de Sitter space duality conjecture/conformal field theory in mathematical physics [\[Ma](#page-17-13)], there has been a considerable increase of interests in Sasakian manifolds of late, see [\[BG](#page-17-14), [GMSW,](#page-17-15) [MS](#page-18-9), [MSY](#page-18-10)] and references therein.

An application of Theorem [1.1](#page-1-0) emerges in Sasakian geometry, we prove(see Theorem [3.1\)](#page-16-0)

Theorem 1.2. For a compact Sasakian manifold $(M, T_{1,0}M, \eta)$ of dimension $2n + 1$, there exists an equivalence between the category of rank r semi-simple basic projective flat complex vector bundles over M and the category of rank r poly-stable basic Higgs bundles over M with

where ξ is the characteristic direction and \mathcal{F}_{ξ} is the associated foliation.

The existence of harmonic metrics is employed to produce the functor that from semi-simple basic projective flat complex vector bundles to basic Higgs bundles. Beyond that, it requires to prove the key property $\nabla_H(\psi_H(\xi)) = 0$ for harmonic metric H, known by Biswas-Kasuya [\[BK1\]](#page-16-1) for flat vector bundles via modifying the spinorial proof of [\[Pe,](#page-18-11) Theorem 4.1]. Under the weaker condition $\nabla_{H,\xi} \nabla_H^* \psi_H = 0$, we shall give a simple maximum principle proof without involving special curvature theory of Tanaka-Webster connections on Sasakian manifolds and the commutative formula [\[Pe,](#page-18-11) Corollary 2.1] concerning the Dirac operator, see Lemma [3.2.](#page-12-0) The opposite direction is mainly inspired by [\[Si1\]](#page-18-12) and Baraglia-Hekmati's work [\[BH\]](#page-16-2) on a foliated Hitchin-Kobayashi correspondence, where the notion of stability was addressed.

Our Theorem [1.2](#page-2-0) extends the main result in [\[BK1\]](#page-16-1)(see also [\[BM](#page-17-16)] for the case of quasi-regular Sasakian manifolds) to the nonvanishing Chern classes case. Note these are Sasakian analogues of the Corlette-Donaldson-Hitchin-Simpson correspondence built upon [\[Co1](#page-17-0), [Do3](#page-17-1), [Hi,](#page-17-4) [Si1,](#page-18-12) [Si3\]](#page-18-0), dating back to Narasimhan-Seshadri [\[NS](#page-18-13)], Donadlson [\[Do1](#page-17-2), [Do2](#page-17-3)] and Uhlenbeck-Yau [\[UY\]](#page-18-1). Readers are also refereed to [\[BK2,](#page-17-17) [Ka](#page-17-18), [KM](#page-17-19)] for recent works concerning related topics.

2. Harmonic metrics on vector bundles

2.1. Preliminaries. We assume E is a vector bundle over a compact Riemannian manifold (M, g) and set $A^p(M, E) = \Gamma(\Lambda^p T^* M \otimes E)$, the space of p-forms on M with values in E. Associated to a connection ∇ on E, the exterior differential operator

is defined by requiring $D(\alpha \otimes u) = d\alpha \otimes u + (-1)^p \alpha \wedge \nabla u$ for any $\alpha \in A^p(M)$ and $u \in \Gamma(E)$. Then the curvature is given by $F_{\nabla} = D \circ \nabla \in A^2(M, \text{End}(E))$. For $\omega \in A^p(M, E)$, we have

where $e_1, ..., e_p \in \Gamma(TM)$ and symbols covered by \wedge are omitted. If the tangent bundle TM is equipped with a connection ∇^{TM} , the action of ∇ may be further extended to tensorial combinations of TM and E as well as their duals. Then it also holds

where $T_{\nabla T^M}$ denotes the torsion. For a metric K on E, we have the pointwise inner-product

where $\{e_i\}_{i=1}^{\dim M}$ is an orthogonal unit basis of TM. Henceforth, we will omit the subscript K if there is no ambiguity. The generalized inner-product

is defined by requiring $K(\alpha \otimes u, \beta \otimes v) = (u, v)\alpha \wedge \beta$ for any $\alpha \in A^p(M)$, $\beta \in A^q(M)$ and $u, v \in \Gamma(E)$. In particular, for $\omega, \theta \in A^p(M, E)$ we have $K(\omega, * \theta) = (\omega, \theta)$ dvol_g, where * is the Hodge star operator acting on the form component.

Given above ∇ and K, we define $\psi_K \in A^1(M,\text{End}(E))$ by

where $u, v \in \Gamma(E)$. One can easily check ψ_K is self-adjoint and

is a connection preserving K . The co-differential operator

is determined by D_K , the exterior differential operator of ∇_K ,

where $\omega \in A^{p-1}(M, E), \theta \in A^p(M, E)$. Then it holds

where for notational simplicity, ∇_K also denotes the connection on $\Lambda^p T^*M \otimes E$ which acts on $\Lambda^p T^*M$ by the Levi-Civita connection ∇^g .

For two metrics K and H on E, we denote by $f = K^{-1}H$ the endormorphism given by

By (2.7) and the fact that f is self-adjoint with respect to K and H, we have

Set $f = h^{*K}h$ and $H(\bullet, \bullet) = K(h(\bullet), h(\bullet))$. Consider the gauge action $h(\bullet) = h \circ \bullet \circ h^{-1}$ and write $h(\nabla) = h(\nabla)_K + \psi_{h(\nabla), K}$ for the decomposition of $h(\nabla)$ in term of K, then

Moreover, by [\(2](#page-2-1).2) we also know $h(D_H)$ is the exterior differential operator relative to $h(\nabla)_K$.

2.2. Harmonic metrics. We shall apply the method of continuity to detect harmonic metrics on a simple vector bundle (E, ∇) over a compact Riemannian manifold (M,g) . Let us fix a background metric K and consider the following family of equations:

Pick a metric K_0 and a function u with $\Delta_g u = -2 \text{rank}(E)^{-1} \text{tr} \nabla^*_{K_0} \psi_{K_0}$, where Δ_g denotes the Beltrami-Laplace. Define $\hat{K} = e^u K_0$, $K = \hat{K} \exp(-\nabla_{\hat{K}}^* \psi_{\hat{K}})$, and then by (2.[15\)](#page-4-0), we obtain

Moreover, one easily concludes $f_1 = \exp \nabla_{\hat{K}}^* \psi_{\hat{K}}$ must solve (2.[19\)](#page-5-0) with $\epsilon = 1$.

We denote by I the set of $\epsilon \in [0,1]$ such that (2.[19\)](#page-5-0) is solvable and thus $1 \in J$. For the openness of I, we consider the operator

On the other hand, since $d(u, v) = (\nabla^f u, v) + (u, \delta_K^f v)$ for $u, v \in \Gamma(\text{End}(E))$, we have for any $\phi \in S_K$ (where S_K is the space of self-adjoint sections of $\text{End}(E)$) with $\delta_2 \hat{L}(\epsilon, f_{\epsilon})(\phi) = 0$,

+ \sum_{i=1}^{\dim M} \begin{pmatrix} -\frac{1}{2}\beta_{F}(\frac{\partial}{\partial x^{i}}) \circ \beta_{F}^{*}(\frac{\partial}{\partial x^{i}}) & \frac{1}{2}[\psi_{(F^{\perp})^{*}\otimes F,H}(\frac{\partial}{\partial x^{i}}), \beta_{F}(\frac{\partial}{\partial x^{i}})] \\ -\frac{1}{2}[\psi_{F^{*}\otimes F^{\perp},H}(\frac{\partial}{\partial x^{i}}), \beta_{F}^{*}(\frac{\partial}{\partial x^{i}})] & \frac{1}{2}\beta_{F}^{*}(\frac{\partial}{\partial x^{i}}) \circ \beta_{F}(\frac{\partial}{\partial x^{i}}) \end{array} \right),
$$

By the harmonicity of H , we have

(2.56)
$$
2\nabla_{F,H}^* \psi_{F,H} = \sum_{i=1}^{\dim M} \beta_F(\frac{\partial}{\partial x^i}) \circ \beta_F^*(\frac{\partial}{\partial x^i}).
$$

Taking trace on both sides and integrating over M indicate $\beta_F = 0$, therefore

(2.57)
$$
(E, \nabla, H) = (F, \nabla_F, H) \oplus (F^{\perp}, \nabla_{F^{\perp}}, H)
$$

splits as harmonic bundles. By an induction argument we conclude that (E, ∇) is semi-simple and combing this with Proposition [2.2](#page-9-1) yields

Theorem 2.1. The existence of harmonic metrics and the semi-simpleness are equivalent.

Corollary 2.1. Given a Hermitian vector bundle (E, K) , we have a natural bijection:

$$
(2.58) \t I_K: \mathcal{M}_S \to \mathcal{M}_{I,K}.
$$

Proof. Given a simple connection ∇ with $\nabla f = 0$ for $f \in \Gamma(\text{End}(E))$. Let

(2.59)

g(\lambda) = (\lambda - \lambda_1)^{m_1} \dots (\lambda - \lambda_s)^{m_s}
$$

be the characteristic polynomial of f, where λ_i are the s mutually different eigenvalues of f. It is known that $\text{tr } f^k$ must be constants since $d \text{tr } f^k = \text{tr } \nabla f^k = 0$. In particular, we conclude λ_j , m_j are constants and we decompose E into the eigenspaces of f:

(2.60)
$$
(E, \nabla) = \bigoplus_{i=1}^{s} (E_{\lambda_i}, \nabla |_{E_{\lambda_i}}).
$$

If $s \geq 2$ one finds at least one nontrivial ∇ -invariant sub-bundle, contradicting to the simpleness. Therefore f only has one eigenvalue, saying λ . However the simpleness again implies $\ker(f - \lambda \mathrm{id}_E) = E$, $f = \lambda \mathrm{id}_E$ and hence ∇ is irreducible. Furthermore, there is a connection in the Aut(E)-orbit through ∇ such that K is harmonic. In fact, we pick H, the harmonic metric given in Theorem [2.1](#page-10-0) and it follows for $K^{-1}H = h^{*K}h$,

(2.61)
$$
h(\nabla)_K^* \psi_{h(\nabla),K} = h(\nabla_H^* \psi_H) = 0.
$$

If $K^{-1}H = \tilde{h}^{*K}\tilde{h}$, $\tilde{h}(\nabla)$ is isomorphic to $h(\nabla)$ via $\tilde{h} \circ h^{-1} \in U(E, K)$. Moreover, let H_1 , H_2 be two harmonic metrics and $h_{12} = H_1^{-1}H_2$, we have

(2.62)
$$
\Delta_g \operatorname{tr} h_{12} = (h_{12}^{-1} \delta_{H_1} h_{12}, \delta_{H_1} h_{12})_{H_1} = |h_{12}^{-\frac{1}{2}} \delta_{H_1} h_{12}|_{H_1}^2,
$$

from which and the simpleness we know that h_{12} is a constant mutiple of id_E. Consequently, ∇ uniquely corresponds to an element, saying $I_K(\nabla) = [h(\nabla)] \in \mathcal{M}_{I,K}$. In addition, assuming $I_K(\nabla) = [h_1(\nabla)]$ and $I_K(g(\nabla)) = [h_2(g(\nabla))]$, it is not hard to see

(2.63)
$$
h_2(g(\nabla)) = (h_2 \circ g \circ h_1^{-1})(h_1(\nabla)), h_2 \circ g \circ h_1^{-1} \in U(E, K).
$$

That is, I_K desends to a bijection from \mathcal{M}_S to $\mathcal{M}_{I,K}$, as required.

3. An application in Sasakian geometry

3.1. Sasakian manifolds in pseudo-Hermitian geometry. We start with some basic facts on Sasakian manifolds from the viewpoint of pseudo-Hermitian geometry, more details can be found in [\[BG](#page-17-14), [DT](#page-17-21)]. Let M be a $2n + 1$ -dimensional smooth manifold, a CR structure on M is an integrable rank n complex sub-bundle

(3.1)
$$
T_{1,0}M\subseteq T^{\mathbb{C}}M=TM\otimes\mathbb{C}
$$

satisfying $T_{1,0}M \cap T_{0,1}M = \{0\}$ for $T_{0,1}M = \overline{T_{1,0}M}$. We then call $(M, T_{1,0}M)$ a CR manifold and its maximal complex or Levi, distribution is the real rank $2n$ real sub-bundle

$$
(3.2) \tHM = Re{T1,0M} \oplus T0,1M} \subseteq TM.
$$

It carries a complex structure $J: HM \rightarrow HM$ given by

(3.3)
$$
J(X + \overline{X}) = \sqrt{-1}(X - \overline{X}), \ X \in T_{1,0}M.
$$

Assume M to be orientable, we define

(3.4)
$$
E_x = \{ \omega \in T_x^*M, HM_x \subseteq \ker \omega \} \subseteq T_x^*M,
$$

then E a real line bundle and any globally defined nowhere vanishing section η is called a pseudo-Hermitian structure and the associated Levi form L_n is defined by

(3.5)
$$
L_{\eta}(X,\overline{Y}) = -\sqrt{-1}d\eta(X,\overline{Y}), X, Y \in T_{1,0}M.
$$

An orientable CR manifold $(M, T_{1,0}M)$ is nondegenerate if L_n is nondegenerate for a pseudo-Hermitian structure η and $(M, T_{1,0}M, \eta)$ is called a pseudo-Hermitian manifold. Moreover, $(M, T_{1,0}M, \eta)$ is said to be strictly pseudoconvex CR manifold if L_{η} is positive definite.

For a pseudo-Hermitian manifold $(M, T_{1,0}M, \eta)$, $d\eta$ is nondegenerate on HM and thus there is a unique nonvanishing vector field ξ (referred to as the characteristic direction) such that

$$
\eta(\xi) = 1, \ d\eta(\xi, \bullet) = 0,
$$

and ξ is transverse to the Levi distribution(that is $TM = HM \oplus \mathbb{R}\xi$). Define a bilinear form

$$
(3.7) \tG\eta(X,Y) = d\eta(X,JY), X,Y \in HM,
$$

the integrability of $T_{1,0}M$ implies that G_n is J-invariant and thus symmetric. One may extend G_n to a semi-Riemannian (Riemannian if strictly pseudoconvex CR) metric via

(3.8)
$$
g_{\eta}(X,Y) = G_{\eta}(X,Y), \ g_{\eta}(X,\xi) = 0, \ g_{\eta}(\xi,\xi) = 1, X, Y \in HM,
$$

and we call it the Webster metric.

Proposition 3.1 ([\[Ta,](#page-18-15) [Web\]](#page-18-16), see also [\[DT](#page-17-21)]). For a pseudo-Hermitian manifold $(M, T_{1,0}M, \eta)$, we extend J to an endomorphism of TM by requiring $J\xi = 0$. There exists a unique affine connection ∇^{TM} (called Tanaka-Webster connection) on TM such that

(1) HM is parallel with respect to ∇^{TM} , (2) $\nabla^{TM}g_n = 0$, $\nabla^{TM}J = 0$ and $\nabla^{TM}\xi = 0$, (3) The torsion $T_{\nabla^{TM}}$ is pure: (a) $\tau_{\nabla^{TM}} \circ J + J \circ \tau_{\nabla^{TM}} = 0$, (b) $T_{\nabla^{TM}}(X,Y) = 0$, $T_{\nabla^{TM}}(X,\overline{Y}) = d\eta(X,\overline{Y})\xi$, where $\tau_{\nabla TM} = T_{\nabla TM}(\xi, \bullet)$ (called the pseudo-Hermitian torsion) and $X, Y \in T_{1,0}M$.

As an endomorphism, it is known that

(3.9)
$$
\text{tr } \tau_{\nabla^{TM}} = 0, \ \tau_{\nabla^{TM}}(T_{1,0}M) \subseteq T_{0,1}M.
$$

On the other hand, the relation between the Levi-Civita connection $\nabla^{g_{\eta}}$ and the Tanaka-Webster connection ∇^{TM} is given by(see [\[DT\]](#page-17-21))

(3.10)
$$
\nabla_X^{g_\eta} Y - \nabla_X^{TM} Y = (g_\eta(X, J(Y)) - g_\eta(\tau_{\nabla^{TM}}(X), Y)) \xi + \tau_{\nabla^{TM}}(X)\eta(Y) + \eta(X)J(Y) + \eta(Y)J(X),
$$

for two vector fields X, Y. Define a vector field $U = \text{tr}_{g_{\eta}}(\nabla^{g_{\eta}} - \nabla^{TM})$ and it follows

Lemma 3.1. For a strictly pseudoconvex CR manifold $(M, T_{1,0}M, \eta)$, we have $U = 0$.

Definition 3.1. A strictly pseudoconvex CR manifold $(M, T_{1,0}M, \eta)$ with vanishing pseudo-Hermitian torsion $\tau_{\nabla^{TM}}$ is called a Sasakian manifold.

3.2. A vanishing result. In what follows we always assume $\{e_1 = \xi, e_2, ..., e_{2n+1}\}\$ is a local frame of TM and $\{e^1 = \eta, e^2, ..., e^{2n+1}\}\$ is a local frame of T^*M . For a vector bundle E over M with a connection ∇ and a metric K on E, we shall use ∇_K to denote the connection on $\Lambda^{\bullet}T^{*}M \otimes E$ which acts on $\Lambda^{\bullet}T^{*}M$ by ∇^{TM} and acts on E by ∇_{K} . We take the notation

(3.11)
$$
\nabla_{H,X,Y}^2 \omega = \nabla_{H,X} \nabla_{H,Y} \omega - \nabla_{H,\nabla_X^{TM} Y} \omega,
$$

for two vector fields X, Y and $\omega \in A^{\bullet}(E)$.

A connection ∇ on a complex vector bundle E is called projective flat if the curvature satisfies $\sqrt{-1}F_{\nabla} = \alpha \otimes id_E$ for a 2-form α .

Lemma 3.2. Let (E, ∇) be a projective flat complex vector bundle over a compact Sasakian manifold $(M, T_{1,0}M, \eta)$ and H be a metric on E with $\nabla_{H,\xi} \nabla_H^* \psi_H = 0$, then $\nabla_H(\psi_H(\xi)) = 0$.

Proof. We first note Lemma [3.1](#page-12-1) implies

(3.12)
$$
\nabla_H^* \psi_H = g_{\eta}^{ij} \nabla_{H, e_i} (\psi_H(e_j)) - g_{\eta}^{ij} \psi_H(\nabla_{e_i}^g e_j) = g_{\eta}^{ij} \nabla_{H, e_i} (\psi_H(e_j)) - g_{\eta}^{ij} \psi_H(\nabla_{e_i}^{TM} e_j)
$$

The projective flatness means $D_H \psi_H = 0$, $\sqrt{-1}(F_{\nabla_H} + \psi_H \wedge \psi_H) = \alpha \otimes \mathrm{id}_E$ for $\alpha \in A^2(M)$. Next we deduce the symmetry

(3.13)
$$
\nabla_{H,e_i}(\psi_H(\xi)) = \nabla_{H,e_i}\psi_H(\xi) + \psi_H(\nabla_{e_i}^{TM}\xi)
$$

$$
= \nabla_{H,\xi}\psi_H(e_i) - \psi_H(\tau_{\nabla^{TM}}(e_i)) - D_H\psi_H(\xi,e_i)
$$

$$
= \nabla_{H,\xi}(\psi_H(e_i)),
$$

where we haved used $\nabla^{TM}\xi = 0$ and the vanishing of pseudo-Hermitian torsion. Using these properties again, (3.[12\)](#page-12-2) and (3.[13\)](#page-12-3) repeatedly, we have

tr_{g_{\eta}} \nabla_{H}^{2}(\psi_{H}(\xi)) = g_{\eta}^{ij} \nabla_{H,e_{i}} \nabla_{H,e_{j}}(\psi_{H}(\xi)) - g_{\eta}^{ij} \nabla_{H,\nabla_{e_{i}}^{TM}e_{j}}(\psi_{H}(\xi))
$$

\n
$$
= g_{\eta}^{ij} \nabla_{H,e_{i},\xi}^{2}(\psi_{H}(e_{j})) - g_{\eta}^{ij} \nabla_{H,\nabla_{e_{i}}^{TM}e_{j}}(\psi_{H}(\xi))
$$

\n
$$
= g_{\eta}^{ij} \nabla_{H,\xi,e_{i}}^{2}(\psi_{H}(e_{j})) - g_{\eta}^{ij} \nabla_{H,\nabla_{e_{i}}^{TM}e_{j}}(\psi_{H}(\xi))
$$

\n
$$
+ g_{\eta}^{ij} ([F_{\nabla_{H}}(e_{i},\xi), \psi_{H}(e_{j})] + \nabla_{H,\tau_{\nabla_{H}}(e_{i})}(\psi_{H}(e_{j})))
$$

\n(3.14)

- g_{\eta}^{ij} \nabla_{H,\xi,e_{i}}^{2}(\psi_{H}(e_{j})) - g_{\eta}^{ij} \nabla_{H,\nabla_{e_{i}}^{TM}e_{j}}(\psi_{H}(\xi))

- \frac{1}{2} g_{\eta}^{ij} [[\psi_{H}(e_{i}), \psi_{H}(\xi)], \psi_{H}(e_{j})]
$$

= -\nabla_{H,\xi} \nabla_{H}^{*} \psi_{H} - \frac{1}{2} g_{\eta}^{ij} [[\psi_{H}(e_{i}), \psi_{H}(\xi)], \psi_{H}(e_{j})].
$$

By Lemma [3.1](#page-12-1) and the assumption on H , it follows

$$
\Delta_{g_{\eta}}|\psi_H(\xi)|_H^2 = \text{div}(\nabla^{TM}|\psi_H(\xi)|_H^2)
$$

\n
$$
= 2(\text{tr}_{g_{\eta}} \nabla_H^2(\psi_H(\xi)), \psi_H(\xi))_H + 2|\nabla_H(\psi_H(\xi))|_H^2
$$

\n
$$
= -(g_{\eta}^{ij}[[\psi_H(e_i), \psi_H(\xi)], \psi_H(e_j)], \psi_H(\xi))_H^2 + 2|\nabla_H(\psi_H(\xi))|_H^2
$$

\n
$$
= |[\psi_H(\xi), \psi_H]_H^2 + 2|\nabla_H(\psi_H(\xi))|_H^2,
$$

and we thus conclude $\nabla_H(\psi_H(\xi)) = 0$ by maximum principle.

Under the setting in Lemma [3.2,](#page-12-0) we define $\mathcal{D} = g_{\eta}^{ij} (e^i \wedge \nabla_{H,e_j} - \iota(e_i) \nabla_{H,e_j})$, the Dirac operator on $\Lambda^* T^* M \otimes \text{End}(E)$. By (3.[12\)](#page-12-2) and the projective flatness, we have

(3.16)
$$
\mathcal{D}\psi_H = g_{\eta}^{ij}e^i \wedge \nabla_{H,e_j}\psi_H + \nabla_H^*\psi_H,
$$

and for any $X, Y \in TM$,

(3.17)
$$
(g_{\eta}^{ij}e^i \wedge \nabla_{H,e_j}\psi_H)(X,Y) = \nabla_{H,X}\psi_H(Y) - \nabla_{H,Y}\psi_H(X) = \psi_H(T_{\nabla^{TM}}(X,Y)) + D_H\psi_H(X,Y) = \psi_H(T_{\nabla^{TM}}(X,Y)).
$$

ij

Therefore we have $\mathcal{D}\psi_H = d\eta \otimes \psi_H(\xi) + \nabla_H^* \psi_H$ due to Proposition [3.1](#page-11-0) and the vanishing of pseudo-Hermitian torsion. Furthermore it holds

(3.18)
$$
\mathcal{D}^2 \psi_H = g_{\eta}^{ij} \left(e^i \wedge \nabla_{H,e_j} (d\eta \otimes \psi_H(\xi)) - (\nabla_{H,e_j} (d\eta \otimes \psi_H(\xi)))(e_i) \right) \n= g_{\eta}^{ij} \left(e^i \wedge d\eta \otimes \nabla_{H,e_j} (\psi_H(\xi)) - d\eta(e_i, \bullet) \otimes \nabla_{H,e_j} (\psi_H(\xi)) \right),
$$

where we have used $\nabla^{TM}d\eta = 0$. Thanks to Lemma [3.2,](#page-12-0) we find $\mathcal{D}\psi_H = 0$ since $\mathcal D$ is formal self-adjoint(see [\[Pe](#page-18-11), Proposition 2.1]). Hence, we have the following vanishing result which is essential to construct basic Higgs structures.

Proposition 3.2. Let (E, ∇) be a projective flat complex vector bundle over a compact Sasakian manifold $(M, T_{1,0}M, \eta)$ and H be a metric on E with $\nabla_{H,\xi} \nabla_H^* \psi_H = 0$, then H is exactly harmonic and satisfies $\psi_H(\xi) = 0$.

3.3. Correspondence between projective flat bundles and Higgs bundles. Below we assume the base space is a compact Sasakian manifold $(M, T_{1,0}M, \eta)$ and denote by $A^*_{B_{\mathcal{F}_{\xi}}}(M)$ the space of basic forms, meaning that any $\omega \in A^*_{B_{\mathcal{F}_{\xi}}}(M)$ satisfies $\iota_{\xi}\omega = 0$ and $L_{\xi}\omega = 0$. Since ker $\eta \otimes \mathbb{C} = T_{1,0}M \oplus T_{0,1}M$, we similar have the decomposition

(3.19)
$$
A_{B_{\mathcal{F}_{\xi}}}^{k}(M) \otimes \mathbb{C} = \bigoplus_{p+q=k} A_{B_{\mathcal{F}_{\xi}}}^{p,q}(M),
$$

where $A^{p,q}_{B_{\tau}}$ $\mathcal{B}_{\mathcal{F}_{\xi}}(M)$ is the sub-space of basic forms of type (p,q) . It is easy to see the exterior differential preserves basic forms and hence $d = \partial_{\xi} + \overline{\partial}_{\xi}$ on $A_{B_{\mathcal{F}_{\xi}}}^{k}(M) \otimes \mathbb{C}$, such that

(3.20)
$$
\partial_{\xi}: A^{p,q}_{\mathcal{F}_{\xi}}(M) \to A^{p+1,q}_{\mathcal{F}_{\xi}}(M), \overline{\partial}_{\xi}: A^{p,q}_{\mathcal{F}_{\xi}}(M) \to A^{p,q+1}_{\mathcal{F}_{\xi}}(M).
$$

In the presence of the CR structure $T_{1,0}M$ and the complex structure J, there is a transverse holomorphic structure on $M(\text{with the transverse Kähler structure } d\eta)$ as well as the transverse Hodge theory on the foliated manifold (M, \mathcal{F}_{ξ}) , see [\[To](#page-18-17), Chapter 7] and [\[BK1](#page-16-1), pp.275].

Let E be a complex vector bundle over M , it is called transverse holomorphic if it can be trivialized by an open cover $M = \bigcup_{\alpha} U_{\alpha}$ so that each transition function $f_{\alpha\beta}$ is basic and holomorphic(that is, $\overline{\partial}_{\xi} f_{\alpha\beta} = 0$). We have the canonical Dolbeault operator

(3.21)
$$
\overline{\partial}_E: A^{p,q}_{\mathcal{F}_\xi}(M,E) \to A^{p,q+1}_{\mathcal{F}_\xi}(M,E),
$$

which satisfies $\overline{\partial}_E^2 = 0$ and for $\alpha \in A_{B_{\mathcal{I}}}^{p,q}$ ${}_{B_{\mathcal{F}_{\xi}}}(M), u \in A_{B_{\mathcal{F}_{\xi}}}^{0}(M,E),$

(3.22)
$$
\overline{\partial}_E(\alpha \wedge u) = \overline{\partial}_\xi \alpha \otimes u + (-1)^{p+q} \alpha \wedge \overline{\partial}_E u.
$$

A basic Higgs bundle (E, θ) consists of a transverse holomorphic bundle E and a Higgs field $\theta \in A^{1,0}_{B_{\mathcal{F}}}$ $B_{\mathcal{B}_{\mathcal{F}_{\xi}}}(M,\text{End}(E))$ satisfying $\partial_E \theta = 0$, $\theta \wedge \theta = 0$. Assume further E admits a basic Hermitian metric H , one may take all nontrivial sub-Higgs sheaves to define the notion of poly-stability on (E, θ) in the manner of [\[BH,](#page-16-2) Section 3.3]. We say a connection ∇ on a vector bundle E is basic if the associated D restricts to a homomorphism

(3.23)
$$
D: A^k_{\mathcal{F}_\xi}(M, E) \to A^{k+1}_{\mathcal{F}_\xi}(M, E),
$$

and the pair (E, ∇) is said to be a basic vector bundle. For a basic connection ∇ on E, we may define $c_{k,B_{\mathcal{F}_{\xi}}}(E,\nabla) \in A_{\mathcal{F}_{\xi}}^{2k}(M,E)$ by

(3.24)
$$
\det(I + \frac{\sqrt{-1}}{2\pi} F_{\nabla}) = \sum_{k=0}^{n} c_{k, B_{\mathcal{F}_{\xi}}}(E, \nabla).
$$

For each k, the class $c_{k,B_{\mathcal{F}_{\xi}}}(E,\nabla)$ in $H^*_{B_{\mathcal{F}_{\xi}}}(M)$, the cohomology of complex

(3.25)
$$
(A^*_{B_{\mathcal{F}_{\xi}}}(M), d|_{A^*_{B_{\mathcal{F}_{\xi}}}(M)}),
$$

is independent of the choice of basic connections and we just write $c_{k,B_{\mathcal{F}_{\xi}}}(E)$.

Proposition 3.3. Let $(M, T_{1,0}M, \eta)$ be a compact Sasakian manifold of dimension $2n + 1$ and (E, ∇) be a rank r semi-simple basic projective flat complex vector bundle over M, then it determines a poly-stable basic Higgs bundle (E, θ) over M such that

(3.26)
$$
\int_M \left(c_{2,B_{\mathcal{F}_{\xi}}}(E) - \frac{r-1}{2r} c_{1,B_{\mathcal{F}_{\xi}}}(E) \right) \wedge (d\eta)^{n-2} \wedge \eta = 0.
$$

Proof. We employ Theorem [1.1](#page-1-0) and Proposition [3.2](#page-14-0) to find a harmonic metric H on (E, ∇) satisfying $\psi_H(\xi) = 0$. It follows that ∇_H induces a homomorphism

(3.27)
$$
D_H: A^k_{\mathcal{F}_\xi}(M, E) \to A^{k+1}_{\mathcal{F}_\xi}(M, E).
$$

We decompose $D_H = \partial_{H,\xi} + \overline{\partial}_{H,\xi}$ and $\psi_H = \theta_{H,\xi} + \overline{\theta}_{H,\xi}$ such that

(3.28) \t\t \partial_{H,\xi}: A^{p,q}_{\mathcal{F}_{\xi}}(M,E) \to A^{p+1,q}_{\mathcal{F}_{\xi}}(M,E), \ \overline{\partial}_{H,\xi}: A^{p,q}_{\mathcal{F}_{\xi}}(M,E) \to A^{p,q+1}_{\mathcal{F}_{\xi}}(M,E),
$$

and $\theta_{H,\xi} \in A^{1,0}_{\mathcal{F}_{\xi}}$ $\overline{\mathcal{F}}_{\xi}(M,\mathrm{End}(E)),\ \overline{\theta}_{H,\xi}\in A^{0,1}_{\mathcal{F}_{\xi}}$ $\mathcal{F}_{\xi}^{0,1}(M,\mathrm{End}(E)).$ The projective flatness implies

\partial_{H,\xi}\theta_{H,\xi}=0, \overline{\partial}_{H,\xi}\overline{\theta}_{H,\xi}=0, \ \partial_{H,\xi}\overline{\theta}_{H,\xi}+\overline{\partial}_{H,\xi}\theta_{H,\xi}=0,

(3.30)

\partial_{H,\xi}^2 = -\frac{1}{2} [\theta_{H,\xi}, \theta_{H,\xi}], \overline{\partial}_{H,\xi}^2 = -\frac{1}{2} [\overline{\theta}_{H,\xi}, \overline{\theta}_{H,\xi}],
$$

(3.31)
$$
[\partial_{H,\xi}, \overline{\partial}_{H,\xi}] = -[\theta_{H,\xi}, \overline{\theta}_{H,\xi}] + \frac{\operatorname{tr} F_{\nabla}}{r} \otimes \operatorname{id}_E.
$$

Set $D''_{H,\xi} = \overline{\partial}_{H,\xi} + \theta_{H,\xi}$ and $G_{H,\xi} = D''_{H,\xi} \circ D''_{H,\xi}$, it follows

\begin{split}\n\text{tr}(G_{H,\xi} \wedge G_{H,\xi}) \wedge (d\eta)^{n-2} &= -2 \, \text{tr}(\overline{\theta}_{H,\xi} \wedge \overline{\theta}_{H,\xi} \wedge \theta_{H,\xi} \wedge \theta_{H,\xi}) \wedge (d\eta)^{n-2} \\
&\quad - \, \text{tr}(\overline{\partial}_{H,\xi} \theta_{H,\xi} \wedge \partial_{H,\xi} \overline{\theta}_{H,\xi}) \wedge (d\eta)^{n-2} \\
&= -2 \, \text{tr}(\overline{\theta}_{H,\xi} \wedge \overline{\theta}_{H,\xi} \wedge \theta_{H,\xi} \wedge \theta_{H,\xi}) \wedge (d\eta)^{n-2} \\
&\quad - \overline{\partial} \, \text{tr}(\theta_{H,\xi} \wedge \partial_{H,\xi} \overline{\theta}_{H,\xi}) \wedge (d\eta)^{n-2} \\
&\quad + \, \text{tr}(\theta_{H,\xi} \wedge [[\theta_{H,\xi}, \overline{\theta}_{H,\xi}] - \frac{\text{tr } F_{\nabla}}{r} \otimes \text{id}_{E}, \overline{\theta}_{H,\xi}]) \wedge (d\eta)^{n-2} \\
&= -\overline{\partial} \left(\text{tr}(\theta_{H,\xi} \wedge \partial_{H,\xi} \overline{\theta}_{H,\xi}) \wedge (d\eta)^{n-2} \right).\n\end{split}
$$

The harmonicity of H is equivalent to $\Lambda_{\xi}G_{H,\xi}=0$, meaning $G_{H,\xi}$ is primitive, where Λ_{ξ} is the adjoint of the multiplication of $d\eta$. Thus

$$
\begin{split} \text{tr}(G_{H,\xi} \wedge G_{H,\xi}) \wedge (d\eta)^{n-2} &= 2C_1 \, \text{tr}(G_{H,\xi}^{2,0} \wedge *_\xi G_{H,\xi}^{0,2}) - C_1 \, \text{tr}(G_{H,\xi}^{1,1} \wedge *_\xi G_{H,\xi}^{1,1}) \\ &= 2C_1 \, \text{tr}(G_{H,\xi}^{2,0} \wedge *_\xi (G_{H,\xi}^{2,0})^{*H}) + C_1 \, \text{tr}(G_{H,\xi}^{1,1} \wedge *_\xi (G_{H,\xi}^{1,1})^{*H}) \\ &= C_1 \, \text{tr}\left(G_{H,\xi} \wedge *_\xi G_{H,\xi}^{*H}\right), \end{split}
$$

for a constant C_1 , where $*_\xi$ is the basic Hodge star operator given by $*_\xi \beta = *(\eta \wedge \beta)$ for $\beta \in A_{B_{\mathcal{F}_{\xi}}}^{*}(M)$. Therefore integrating $\text{tr}(G_{H,\xi} \wedge G_{H,\xi}) \wedge (d\eta)^{n-2} \wedge \eta$ over \tilde{M} yields $G_{H,\xi} = 0$,

meaning (E, θ) is a basic Higgs bundle with canonical Dolbeault operator $\partial_{H,\xi}$. In addition, the calculation in [\[Si1](#page-18-12), Proposition 3.4] shows for a constant C_2 ,

$$

= 0,
$$

by the projective flatness. Using the basic metric H , the stability of basic Higgs bundle can be well-defined and one easily concludes the poly-stability, see [\[BH](#page-16-2), Theorem 4.7]. \Box

Proposition 3.4. Let $(M, T_{1,0}M, \eta)$ be a compact Sasakian manifold of dimension $2n+1$ and (E, θ) be a rank r poly-stable basic Higgs bundle satisfying (3.[26\)](#page-15-0) over M, then it determines a semi-simple basic projective flat complex vector bundle (E, ∇) over M.

Proof. The Sasakian analogue of $[Si1, Theorem 1.1]$ shows that there exists a basic Hermitian metric H on (E, θ) such that(see [\[BK1](#page-16-1)])

\Lambda_{\xi} F_{\nabla}^{\perp} = 0, \ \nabla = \nabla_H + \theta + \theta^{*H},
$$

where ∇_H is the canonical basic Chern connection. Now by (3.[34\)](#page-16-3) it follows

0 = \int_M \left(c_{2,B_{\mathcal{F}_{\xi}}}(E) - \frac{r-1}{2r} c_{1,B_{\mathcal{F}_{\xi}}}^2(E) \right) \wedge (d\eta)^{n-2} \wedge \eta

= C_2 \int_M \left(|F_V^{\perp}|_H^2 - |\Lambda_{\xi} F_V^{\perp}|_H^2 \right) d\text{vol}_{g_{\eta}}
$$
\n
$$
= C_2 \int_M |F_V^{\perp}|_H^2 d\text{vol}_{g_{\eta}}.
$$

This means (E, ∇) is a semi-simple basic projective flat complex vector bundle.

Suppsoe that (F, ∇) is a flat vector bundle with a harmonic metric H, over a compact Sasakian manifold $(M, T_{1,0}M, \eta)$. Define $H_{DR,\mathcal{F}_\xi}^0(M, F)$ to be the space of ∇ -parallel elements of $A_{\mathcal{F}_{\xi}}^{0}(M,F)$ and $H_{Dol,\mathcal{F}_{\xi}}^{0}(M,F)$ to be the space of $D_{H}^{0,1}+\psi_{H}^{1,0}$ ^{1,0}-parallel elements of $A^0_{\mathcal{F}_\xi}(M,F)$.

In view of Proposition [3.3,](#page-15-1) Proposition [3.4](#page-16-4) and the natural isomorphism

(3.37)
$$
H_{DR,\mathcal{F}_{\xi}}^{0}(M,F) \cong H_{Dol,\mathcal{F}_{\xi}}^{0}(M,F),
$$

via transverse Kähler identities (just as $[Si3, Lemma 1.2]$), we conclude

Theorem 3.1. For a compact Sasakian manifold $(M, T_{1,0}M, \eta)$ of dimension $2n + 1$, there exists an equivalence between the following two categories:

- Semi-simple basic projective flat complex vector bundles over M.
- Poly-stable basic Higgs bundles satisfying (3.[26\)](#page-15-0) over M.
