# ON CERTAIN NAVIER-STOKES FLOWS ON NON-COMPACT RIEMANNIAN MANIFOLDS

#### Abstract

In this paper, we study the existence, uniqueness and asymptotic behaviour of almost periodic and asymptotically almost periodic mild solutions to the incompressible Navier-Stokes equations on $d$-dimensional non-compact manifold $(\mathcal{M}, g)$ which satisfies bounded conditions on curvature tensors. We use certain exponential dipsersive estimates of the Stokes semigroup to prove Massera-type principles which guarantees the well-posedness of almost periodic and asymptotically almost periodic mild solutions for the inhomogeneous Stokes equations. Then, by using fixed point arguments and Gronwall's inequality we establish the well-posedness and exponential decay for global-in-time of such solutions of NavierStokes equations.

## 1. Introduction

In the present paper we will study the existence and asymptotic behaviour of almost periodic (AP-) and asymptotically almost periodic (AAP-) mild solutions to incompressible Navier-Stokes equations (NSE) for vector fields on the $d$-dimensional non-compact Riemannian manifold $(\mathcal{M}, g)$ with negative Ricci curvature tensor which satisfies Assumption 2.1 below (see Subsection 2.1). In particular, denoting $\Gamma(T \mathcal{M})$ the set of all vector

[^0]fields on $\mathcal{M}$, we consider NSE for a vector-field-valued mapping $u: \mathbb{R}_{+} \times \mathcal{M} \rightarrow \Gamma(T \mathcal{M})$

where $\nabla$ denotes the Levi-Civita connection on $\mathcal{M} ; \pi$ is the pressure; $r(u)$ is Ricci operator (see the definition in the next section); $f$ is external force; and $\vec{\Delta}$ is Bochner Laplace operator.

First, we recall some results about Navier-Stokes equations on Riemannian manifolds. In particular, the non-uniqueness problem of Leray-weak solutions of Navier-Stokes equations was proved by Czubak et al. $[3,4,5]$ on two-dimensional hyperbolic space $\mathbb{H}^{2}$. Then, this non-uniqueness problem was revisited by Khesin and Misiolek [18] in $\mathbb{H}^{d}$ for $d \geqslant 2$ by using harmonic forms. In particular, they proved that the Navier-Stokes equations have non-uniqueness Leray-weak solutions in $\mathbb{H}^{2}$ and have uniqueness Leray-weak solutions in $\mathbb{H}^{d}$ for $d \geqslant 3$. The non-uniqueness problem were extended to study on another three-dimensional non-compact Riemannian manifold by Lichtenfelz [21] by considering Navier-Stokes equations on Anderson's manifold. After that, Pierfelice [27] provided $L^{p}-L^{q}$ - dispersive and smoothing estimates for Stokes semigroups on real hyperbolic and generalized non-compact manifolds with negative Ricci curvatures. Then, the author used these estimates and Kato-iteration method (see [17]) to prove the existence and uniqueness of strong mild solutions for Navier-Stokes equations (see Section 5 in [27]). There are some other works for Navier-Stokes on Riemannian manifolds such as [10, 11, 24, 28, 32] and references therein.

Concerning the existence and asymptotic behaviour of periodic mild solutions, the existence and stability of periodic solutions to Navier-Stokes equations (1.1) on Einstein manifolds with negative curvature tensor were established in [25]. These results have extended to the case of general non-compact Riemannian manifolds satisfying Assumption 2.1 in [26]. For almost periodic and forward asymptotically almost periodic mild solutions, the recent works [30,31] provides the fully results on the existence and exponential stability (and exponential decay) for equation (1.1) in the spaces $L^{p}\left(\Gamma\left(T \mathbb{H}^{d}\right)\right.$ ) for all $p>1$, where $\mathbb{H}^{d}$ is the $d$-dimensional real hyperbolic space.

We would like to notice that, the questions on existence and asymptotic behaviours of forward asymptotically almost periodic solutions of Navier-Stokes equations on flat spaces such as the whole Euclidean space $\mathbb{R}^{n}$ or its unbounded domains remain open sofar. In related work, there is only work done by Farwig and Tanuichi (see [12]) which gives the global uniqueness of the small backward AAP- mild solution in unbounded domains in $\mathbb{R}^{n}$. The main obstacle is that the heat and Stokes semigroups are polynomial stable on $\mathbb{R}^{n}$,
then the solution operator (see Definition in the proof of Theorem 2.7) can not preserve the asymptotically almost periodic properties of input functions. However, the vectorial heat and Stokes semigroups are exponential stable on the framework of non-compact manifolds with negative Ricci curvatures (see [27]). Using this fact, we can prove that the solution operator preserves the asymptotically almost periodic property (see [30, 31] for the case of hyperbolic space).

The purpose of this paper is to extend the results in [30] for some non-compact Riemannian manifolds satisfying Assumption 2.1 below which require some bounded conditions on curvatures (see the end of Subsection 2.1). In this geometric framewrork, we will face the obstacles that the Kodaira-Hodge projection $\mathbb{P}$ does not commute with Stokes semigroup $e^{-t \mathcal{A}}$ and the fact that the almost periodic mild solutions is determined on the full line time-axis (see [20] for the initial notion of this type of mild solution). To overcome these obstacles, we introduce and establish the boundedness of mild solutions of inhomogeneous Stokes equations in the phase spaces $\mathcal{X}$ (for AAP-mild solutions) and $\mathbb{X}$ (for AP-mild solutions) which consist $L^{p}(\Gamma(T \mathcal{M})) \cap L^{2}(\Gamma(T \mathcal{M}))$ for $p>d$ (see Subsection 2.3 and Lemma 3.2 for the definitions of $\mathbb{X}$ and $\mathcal{X})$. Then, by using $L^{p}-L^{q}$ estimates for Stokes semigroup we prove the Massera-type principles which show the existence of APand AAP- mild solutions of inhomogeneous Stokes equations in $\mathcal{X}$ and $\mathbb{X}$, respectively (see Theorem 2.7). Note that, since the curvatures satisfy the bounded and negative conidtions in Assumption 2.1 below, the Stokes semigroup is exponential stable and the solution operator can preserve the asymptotic property as $t$ tends to infinity (see Theorem $2.7 \mathrm{ii})$ ). Combining these results with fixed point argument we establish the existence of such solutions for Navier-Stokes equations (1.1) (see Theorem 2.8). Finally, we provide the exponential decay for AP- and AAP- mild solutions by using Gronwall's inequalities (see Theorem 2.9).

## Notations.

For a given Banach space $X$ we denote the following Banach spaces:

endowed with the norm $\|h\|_{\infty, X}=\|h\|_{C_{b}(\mathbb{R}, X)}:=\sup _{t \in \mathbb{R}}\|h(t)\|_{X}$.
2. Setting of geometric analysis and main results

### 2.1. Non-compact Riemannian manifolds with negative Ricci curvatures.

For $2 \leqslant d \in \mathbb{N}$, we consider a $d$-dimensional non-compact Riemannian manifold $(\mathcal{M}, g)$ whose the Ricci tensor Ric is a negative. We restrict ourselves to the case that the sectional curvature of $(\mathcal{M}, g)$ is negative, so that the smoothing and dispersive estimates obtained by Pierfelice [27] can be applied. We refer the reader to [16, 14] for notions and detail discussions on Riemannian manifolds and related concepts of geometric analysis. For details on Navier-Stokes equations on Riemannian manifolds we refer to [8, 27, 29] and references therein. For the reader's convenience, in what follows, we recall some notions on differential operators on Riemannian manifolds. We denote the Levi-Civita connection by $\nabla$ and the set of all vector fields on $\mathcal{M}$ by $\Gamma(T \mathcal{M})$. For $X \in \Gamma(T \mathcal{M})$ we can extend $\nabla_{X}$ to arbitrary $(p, q)$ tensor by requiring
i) $\nabla_{X}(c(S))=c\left(\nabla_{X} S\right)$ for any contraction $c$,
ii) $\nabla_{X}(S \otimes T)=\nabla_{X} S \otimes T+S \otimes \nabla_{X} T$
where we take the convention that $\nabla_{X} f=X \cdot f$ for a function $f: \mathcal{M} \rightarrow \mathbb{R}$.
In particular, for $S \in \Gamma\left(\otimes^{p}(T \mathcal{M}) \otimes^{q}\left(T^{*} \mathcal{M}\right)\right)$ we get
$\left.\left(\nabla_{X} S\right)\left(X_{1}, \cdots, X_{q}\right)=\nabla_{X}\left(S\left(X_{1}, \cdots, X_{q}\right)\right)-S\left(\nabla_{X} X_{1}, \cdots, X_{q}\right)\right)-\cdots-S\left(X_{1}, \cdots, \nabla_{X} X_{q}\right)$.
Moreover, we define the covariant derivatives $\nabla$ on tensor field $S \in \Gamma\left(\otimes^{p}(T \mathcal{M}) \otimes^{q}\left(T^{*} \mathcal{M}\right)\right)$ by

\nabla S\left(X, X_{1}, \cdots, X_{q}\right)=\left(\nabla_{X} S\right)\left(X_{1}, \cdots, X_{q}\right), \text { hence, } \nabla S \in \Gamma\left(\otimes^{p}(T \mathcal{M}) \otimes^{q+1}\left(T^{*} \mathcal{M}\right)\right.
$$

Next, we recall the "musical isomorphisms" on Riemannian manifolds. For a 1-form $w$, we define the vector field $w^{\sharp}$ by

g\left(w^{\sharp}, Y\right)=w(Y), \forall Y \in \Gamma(T \mathcal{M})
$$

whereas, for a vector field $X$, we define the 1 -form $X^{b}$ by

X^{b}(Y)=g(X, Y), \forall Y \in \Gamma(T \mathcal{M})
$$

The metric on 1 -forms can then be defined by setting

g(w, \eta):=g\left(w^{\sharp}, \eta^{\sharp}\right), \forall w, \eta \in \Gamma\left(T^{*} \mathcal{M}\right) .
$$

The Riemannian gradient of a function is then defined as

$$
\operatorname{grad} p=(d p)^{\sharp} .
$$

More generally, for $(p, q)$-tensor field $T \in \Gamma\left(\otimes^{p}(T \mathcal{M}) \otimes^{q}\left(T^{*} \mathcal{M}\right)\right)$ we have

T^{\sharp} & =C_{1}^{2}\left(g^{-1} \otimes T\right) \in \Gamma\left(\otimes^{p+1}(T \mathcal{M}) \otimes^{q-1}\left(T^{*} \mathcal{M}\right)\right) \\
T^{b} & =C_{2}^{1}(g \otimes T) \in \Gamma\left(\otimes^{p-1}(T \mathcal{M}) \otimes^{q+1}\left(T^{*} \mathcal{M}\right)\right) \\
\operatorname{div} T & =C_{1}^{1} \nabla T \in \Gamma\left(\otimes^{p-1}(T \mathcal{M}) \otimes^{q}\left(T^{*} \mathcal{M}\right)\right)

where $C_{j}^{i}$ stands for the contraction of the $i$ and $j$ indices for tensors.
Next, the Laplace-Beltrami operator $\Delta_{g}$ applying on functions is defined as

\Delta_{g}(f)=\operatorname{div} \operatorname{grad} f=\frac{1}{\sqrt{|g|}} \frac{\partial}{\partial x^{j}}\left(\sqrt{|g|} g^{i j} \frac{\partial f}{\partial x^{i}}\right) \text { for a function } f: \mathcal{M} \rightarrow \mathbb{R}
$$

where $|g|=\operatorname{det} g$.
Furthermore, the vectorial Laplacian $L$ is defined by the stress tensor (see [8, 29]) :

L u=\operatorname{div}\left(\nabla u+\nabla u^{t}\right)^{\sharp} .
$$

Since $\operatorname{div} u=0$ we can express $L$ in the following formula

L u=\vec{\Delta} u+r(u)
$$

where $\vec{\Delta}$ is the Bochner-Laplacian

$$
\vec{\Delta} u=-\nabla^{*} \nabla u=\operatorname{Tr}_{g}\left(\nabla^{2} u\right)
$$

and $r(\cdot)$ is the Ricci operator related to the Ricci curvature tensor by the formula

r(u)=(\operatorname{Ric}(u, \cdot))^{\sharp} \text { for all } u \in \Gamma(T \mathcal{M})
$$

where the Ricci curvature tensor is defined by

$$
\operatorname{Ric}(X, Y)=\sum_{i=1}^{d} g\left(\mathcal{R}\left(X, e_{i}\right) Y, e_{i}\right) \text { for all } X, Y \in \Gamma(T \mathcal{M})
$$

for the standard basis $\left\{e_{i}=\frac{\partial}{\partial x_{i}}\right\}_{i=1}^{d}$ and $\mathcal{R}$ being the curvature tensor on $M$ defined by

\mathcal{R}(X, Y) Z:=-\nabla_{X}\left(\nabla_{Y} Z\right)+\nabla_{Y}\left(\nabla_{X} Z\right)+\nabla_{[X, Y]} Z \text { for all } X, Y, Z \in \Gamma(T \mathcal{M}) .
$$

Moreover, the sectional curvature $\kappa$ is defined as $\kappa(X, Y):=\frac{\mathcal{R}(X, Y, X, Y)}{g(X, X) g(Y, Y)-g(X, Y)^{2}}$ for all $X, Y \in T_{x} \mathcal{M}$.

In the next sections, we will work on Riemannian manifolds which satisfy the below assumption. This assumption was introduced in [27].

Assumption 2.1. Assume that $(\mathcal{M}, g)$ is a smooth, complete, non-compact, simply connected Riemannian manifold satisfying the following properties

& \left(H_{3}\right) \kappa<0, \\
& \left(H_{4}\right) \inf _{x \in \mathcal{M}} r_{x}>0,
\end{aligned}

where $r_{x}$ is the injectivity radius for the exponential map at $x$.
Examples: There are several Riemannian manifolds satisfying the above hypotheses $\left(H_{1}\right)-\left(H_{4}\right)$ such as real hyperbolic manifolds, non-compact Einstein manifolds with negative Ricci curvature tensors ([15, 16]), Damek-Ricci manifolds ([7]) and symmetric manifolds of non-compact types ([9, 15]).

### 2.2. Almost periodic and forward asymptotically almost periodic functions.

Let $X$ be a Banach space, we recall the definitions of almost periodic and forward asymptotically almost periodic functions which have the values in $X$ (for details see [1]).

Definition 2.2. A function $h \in C_{b}(\mathbb{R}, X)$ is called almost periodic function if for each $\epsilon>0$, there exists $l_{\epsilon}>0$ such that every interval of length $l_{\epsilon}$ contains at least a number $T$ with the following property

\sup _{t \in \mathbb{R}}\|h(t+T)-h(t)\|_{X}<\epsilon . \tag{2.1}
\end{equation*}
$$

The set of all almost periodic functions $h: \mathbb{R} \rightarrow X$ is denoted by $A P(\mathbb{R}, X)$ which is also a Banach space endowed with the norm

$$
\|h\|_{A P(\mathbb{R}, X)}=\sup _{t \in \mathbb{R}}\|h(t)\|_{X}
$$

In order to introduce the asymptotically almost periodic functions, we define the space $C_{0}\left(\mathbb{R}_{+}, X\right)$, as the set of all forward asymptotic and continuous functions $\varphi: \mathbb{R}_{+} \rightarrow X$ satisfying

\lim _{t \rightarrow+\infty}\|\varphi(t)\|_{X}=0
$$

Clearly, $C_{0}\left(\mathbb{R}_{+}, X\right)$ is a Banach space endowed with the norm

$$
\|\varphi\|_{C_{0}\left(\mathbb{R}_{+}, X\right)}=\sup _{t \in \mathbb{R}_{+}}\|\varphi(t)\|_{X} .
$$

Definition 2.3. A continuous function $f \in C\left(\mathbb{R}_{+}, X\right)$ is said to be forward asymptotically almost periodic (in the rest we call simply by asymptotically almost periodic) if there exists two functions $h \in A P(\mathbb{R}, X)$ and $\varphi \in C_{0}\left(\mathbb{R}_{+}, X\right)$ such that

$$
\begin{equation*}
f(t)=h(t)+\varphi(t) \tag{2.2}
\end{equation*}
$$

We denote $A A P\left(\mathbb{R}_{+}, X\right)=\left\{f: \mathbb{R}_{+} \rightarrow X \mid f\right.$ is asymptotically almost periodic on $\left.\mathbb{R}_{+}\right\}$. Observe that $A A P\left(\mathbb{R}_{+}, X\right)$ is a Banach space endowed with the norm

$$
\|f\|_{A A P\left(\mathbb{R}_{+}, X\right)}=\|h\|_{A P(\mathbb{R}, X)}+\|\varphi\|_{C_{0}\left(\mathbb{R}_{+}, X\right)}
$$

Note that, a periodic function or an almost periodic function is also asymptotically almost periodic, but the vice versa is not always true. For instance, let $g \in C_{b}(\mathbb{R}, X)$, then $f(t)=\left(\sin t+\sin \sqrt{2} t+\frac{1}{\sqrt{t}}\right) g(t)$ is an asymptotically almost periodic function in $A A P\left(\mathbb{R}_{+}, X\right)$ but is not periodic or almost periodic.

### 2.3. Navier-Stokes equations and state of main results.

We consider the existence, uniqueness and asymptotic behaviour of almost periodic and asymptotically almost periodic mild solutions to the Cauchy problem for the incompressible Navier-Stokes equations (1.1) on $\mathcal{M}$. Using the Kodaira-Hodge operator $\mathbb{P}=I+\operatorname{grad}\left(-\Delta_{g}\right)^{-1}$ div we can get rid of the pressure term $\pi$ and then obtain from (1.1) that (see [27, 29]):

\partial_{t} u-(\vec{\Delta} u+r(u)+G(u))=\mathbb{P}\left[-\nabla_{u} u+f\right]  \tag{2.3}\\
\operatorname{div} u=0 \\
u(0, x)=u_{0}(x) \in \Gamma(T M) \text { for all } x \in \mathcal{M} ; \operatorname{div} u_{0}=0
\end{array}\right.
$$

where $G(u)=2 \operatorname{grad}\left(-\Delta_{g}\right)^{-1} \operatorname{div}(r(u))$ with $\Delta_{g}$ being the Laplace-Beltrami operator. The corresponding inhomogeneous Stokes equation takes the form

$$
\begin{cases}\partial_{t} u & =-\mathcal{A} u+\mathbb{P}\left[-\nabla_{v} v+f\right]  \tag{2.4}\\ u(0, x) & =u_{0}(x) \in \Gamma(T \mathcal{M}) \text { for all } x \in \mathcal{M}\end{cases}
$$

for given vector-field valued mappings $v(t, \cdot)$ and $f(t, \cdot) \in \Gamma(T \mathcal{M})$, where $\mathcal{A} u=-(\vec{\Delta} u+$ $r(u)+G(u))$, and $e^{-t \mathcal{A}}$ is denoted the semigroup associated with the homogeneous Cauchy problem:

$$
\begin{cases}\partial_{t} u & =-\mathcal{A} u  \tag{2.5}\\ u(0, x) & =u_{0}(x) \in \Gamma(T \mathcal{M}) \text { for all } x \in \mathcal{M}\end{cases}
$$

i.e., the unique solution of the above Cauchy problem is given by $u(t)=e^{-t \cdot \mathcal{A}} u_{0}$. Here, traditionally, we denote $u(t)$ for $u(t, \cdot)$.

Remark 2.4. Note that, the operator $\vec{\Delta}+r+G$ does not commute with the KodairaHodge operator $\mathbb{P}=I+\operatorname{grad}\left(-\Delta_{g}\right)^{-1}$ div on the generalized non-compact manifolds with all the conditions $\left(H_{1}\right)-\left(H_{4}\right)$. However, in the case of Einstein manifolds, these operator are commutated (see [27]).

To state our main results we need the following notions of mild solutions:

## Definition 2.5.

(i) By a mild solution on the half line time-axis to system (2.4), we mean a mapping $u: \mathbb{R}_{+} \times \mathcal{M} \rightarrow \Gamma(T \mathcal{M})$ which satisfies the integral equation

\begin{equation*}
u(t)=e^{-t \mathcal{A}} u_{0}+\int_{0}^{t} e^{-(t-\tau) \mathcal{A}} \mathbb{P}\left[-\nabla_{v} v+f\right](\tau) d \tau \text { for } t \geq 0 \tag{2.6}
\end{equation*}
$$

(ii) By a mild solution on the whole line time-axis to the first equation of system (2.4) (we do not consider the initial data), we mean a mapping $u: \mathbb{R} \times \mathcal{M} \rightarrow \Gamma(T \mathcal{M})$ which satisfies the integral equation

$$
\begin{equation*}
u(t)=\int_{-\infty}^{t} e^{-(t-\tau) \mathcal{A}} \mathbb{P}\left[-\nabla_{v} v+f\right](\tau) d \tau \tag{2.7}
\end{equation*}
$$

Since, the Stokes operator $\vec{\Delta}+r+G$ does not commute with the Kodaira-Hodge operator $\mathbb{P}=I+\operatorname{grad}\left(-\Delta_{g}\right)^{-1}$ div on a generalized non-compact manifold, we establish the existence and stability of the asymptotically almost periodic mild solutions of equations (2.3) and (2.4) on the following Banach space

\begin{align*}
& \mathcal{X}:=\left\{u \in C_{b}\left(\mathbb{R}_{+},\left(L^{p} \cap L^{2}\right)(\Gamma(T \mathcal{M}))\right), \nabla u \in C_{b}\left(\mathbb{R}_{+}, L^{\tilde{p}}(\Gamma(T \mathcal{M})) \cap L^{s}(\Gamma(T \mathcal{M}))\right) \mid\right. \\
& \text { The function } t \mapsto\|u(t)\|_{L^{p} \cap L^{2}}+\left[c_{d}(t)\right]^{-\left(\frac{1}{p}-\frac{1}{p}+\frac{1}{d}\right)}\|\nabla u(t)\|_{L^{\tilde{p}}} \\
&\left.+\left[c_{d}(t)\right]^{-\left(\frac{1}{p}-\frac{1}{s}+\frac{1}{d}\right)}\|\nabla u(t)\|_{L^{s}} \text { belongs to } L^{\infty}\left(\mathbb{R}_{+}\right)\right\} \tag{2.8}
\end{align*}

endowed with the norm

whereas $c_{d}(t):=C_{0} \max \left\{t^{-\frac{d}{2}}, 1\right\}$.
Also, we consider the existence and stability of the almost periodic mild solutions of equations (2.3) and (2.4) without initial data condition on the following Banach space

here the notation $\left(L^{p} \cap L^{2}\right)(\Gamma(T \mathcal{M}))$ stands for $L^{p}(\Gamma(T \mathcal{M})) \cap L^{2}(\Gamma(T \mathcal{M}))$ and $\|\cdot\|_{p}:=$ $\|\cdot\|_{L^{p}(\Gamma(T \mathcal{M}))}$. Here we assume that $d<p<s^{\prime}<\tilde{p}<s$ with $\frac{1}{2}=\frac{1}{p}+\frac{1}{\tilde{p}}$, whereas $c_{d}(t):=C_{0} \max \left\{t^{-\frac{d}{2}}, 1\right\}$ and

Remark 2.6. If we consider the Navier-Stokes equations on Einstein manifolds, then the space $\mathcal{X}$ and $\mathbb{X}$ reduce to a simple space $C_{b}\left(\mathbb{R}_{+}, L^{p}(\Gamma(T \mathcal{M}))\right)$ and $C_{b}\left(\mathbb{R}, L^{p}(\Gamma(T \mathcal{M}))\right)$, respectively (see [30]).

We now state our first main result on the existence of mild solutions to Stokes equations (2.4) in the following theorem:

Theorem 2.7. Let $(\mathcal{M}, g)$ be a d-dimensional non-compact manifold with negative Ricci curvature tensor and $p>d$.
(i) Suppose that $v \in \mathbb{X}$ and the external force $f \in C_{b}\left(\mathbb{R}, L^{p}(\Gamma(T \mathcal{M})) \cap L^{2}(\Gamma(T \mathcal{M}))\right)$ are almost periodic functions. Then, problem (2.4) (without the initial data $u_{0}$ ) on the full line time-axis has one and only one almost periodic mild solution $\hat{u} \in \mathbb{X}$ satisfying

\|\hat{u}\|_{\mathbb{X}} \leqslant \widetilde{C}\|f\|_{\infty, L^{p} \cap L^{2}}+\widetilde{M}\|v\|_{\mathbb{X}}^{2}
$$

(ii) Suppose that $v \in \mathcal{X}$ and the external force $f \in C_{b}\left(\mathbb{R}_{+}, L^{p}(\Gamma(T \mathcal{M})) \cap L^{2}(\Gamma(T \mathcal{M}))\right)$ are asymptotic almost periodic functions. Then, problem (2.4) has one and only one asymptotic almost periodic mild solution $\hat{u} \in \mathcal{X}$ satisfying

Analogously to the case of Stokes equations, by a mild solution to equation (2.3) we mean the vector-field-valued map $u: \mathbb{R}_{+} \times \mathcal{M} \rightarrow \Gamma(T \mathcal{M})$ satisfying the integral equation

We then state our second main result on the existence and uniqueness of the periodic mild solution to (2.3) in the following theorem.

Theorem 2.8. Let $(\mathcal{M}, g)$ be a d-dimensional non-compact manifold with the negative Ricci curvature tensor and $p>d$.
(i) Assume that $f \in C_{b}\left(\mathbb{R}, L^{p}(\Gamma(T \mathcal{M})) \cap L^{2}(\Gamma(T \mathcal{M}))\right)$ be almost periodic. Then, if $\|f\|_{\infty, L^{p} \cap L^{2}}$ is sufficiently small, the equation (2.3) (without initial data $u_{0}$ ) has one and only one almost periodic mild solution $\hat{u}$ on a small ball of $\mathbb{X}$.
(ii) Assume that $f \in C_{b}\left(\mathbb{R}_{+}, L^{p}(\Gamma(T \mathcal{M})) \cap L^{2}(\Gamma(T \mathcal{M}))\right)$ be asymptotically almost periodic. Then, if $\|f\|_{\infty, L^{p} \cap L^{2}}$ is sufficiently small, the equation (2.3) has one and only one asymptotically almost periodic mild solution $\hat{u}$ on a small ball of $\mathcal{X}$.

Lastly, our third main result on the exponential stability of the almost periodic and asymptotically almost periodic mild solution is stated as follows:

Theorem 2.9. Assume that the external force $f(t)=0$. Then, the almost periodic (resp. asymptotically almost periodic) mild solution $\hat{u}$ of equation (2.3) is exponentially stable in the sense that for any $t>1$,

here we denote

whereas $\gamma$ is a positive constant satisfying $0<\gamma<\beta$.
We will give the proofs of our main results in Section 3.

## 3. Proofs of the main Results

In this section, we will give the proofs of our three main results stated in Subsection 2.3. We first prove the existence of bounded mild solutions to linear inhomogeneous Stokes equations (2.4) with bounded external forces. To that purpose we need the $L^{p}-L^{q}-$ dispersive and smoothing estimates of the semigroup $e^{-t \mathcal{A}}$. These estimates have been proved for semigroups on noncompact manifolds satisfying $\left(H_{1}\right)-\left(H_{4}\right)$ by Pierfelice in [27, Corollary 4.13 and Theorem 4.15]. We recall these dipsersive and smoothing estimates in the following lemma:

Lemma 3.1. Assuming $\left(H_{1}\right)-\left(H_{4}\right)$, putting $c_{d}(t)=C_{0} \max \left(\frac{1}{t^{d / 2}}, 1\right)$. There exist $\beta \geqslant$ $C_{0}>0$ and some $C>0$ such that the solution of (2.5) satisfies the following dispersive and smoothing estimates
i) For $2 \leqslant p \leqslant r<+\infty$ and for all $u_{0} \in L^{p}(\Gamma(T \mathcal{M})) \cap L^{2}(\Gamma(T \mathcal{M}))$,

ii) For $1<p \leqslant 2 \leqslant r<+\infty$ and for all $u_{0} \in L^{p}(\Gamma(T \mathcal{M}))$,

The following lemma gives us the boundedness (in time) of mild solutions to (2.4) for each bounded external force.

Lemma 3.2. Consider Stokes equation (2.4) on d-dimensional non-compact manifold $(\mathcal{M}, g)$ with negative Ricci curvature tensor and $p>d$.
(i) Let $u_{0} \in L^{p}(\Gamma(T \mathcal{M})) \cap L^{2}(\Gamma(T \mathcal{M}))$ and suppose that $v \in \mathcal{X}$, $f \in C_{b}\left(\mathbb{R}_{+},\left(L^{p} \cap\right.\right.$ $\left.\left.L^{2}\right)(\Gamma(T \mathcal{M}))\right)$. Then, the problem (2.4) has one and only one mild solution $u \in \mathcal{X}$ given by the formula (2.7) with $u(0)=u_{0}$. Furthermore, we have

(ii) Let $v \in \mathbb{X}$ and $\left.f \in C_{b}\left(\mathbb{R}, L^{p}(\Gamma(T \mathcal{M}))\right) \cap L^{2}(\Gamma(T \mathcal{M}))\right)$. Then, the problem (2.4) (without initial data $u_{0}$ ) on the full line time-axis has one and only one mild solution $u \in \mathbb{X}$ given by the formula (2.7). Furthermore, we have

Proof. The proof of Assertion (i) is done in the recent work [26, Lemma 3.2]. Therefore, we prove only Assertion (ii) which consists the boundedness of AAP- mild solution on the full line time-axis. For the sake of convenience, we denote $\|\cdot\|_{p}:=\|\cdot\|_{L^{p}(\Gamma(T \mathcal{M}))}$. Note
that, on Riemannian non-compact manifold with negative curvature tensor we have the $L^{p}$-boundedness of Riesz transform (see [22]), therefore the operator $\mathbb{P}$ is bounded.

Using the first inequality in assertion $i$ ) of Lemma 3.1, one has

\leqslant & \frac{C}{\beta}\|f\|_{\infty, L^{p} \cap L^{2}}+M_{2}\|v\|_{\mathbb{X}}^{2}

Remark 3.3. In above three main theorems, we have proved the existence and exponential decay for AP and AAP-mild solutions for Stokes and Navier-Stokes equations in the phase spaces $\mathbb{X}$ and $\mathcal{X}$, respectively. These spaces consist the main component $C_{b}\left(\mathbb{R}, L^{p}(\Gamma(T \mathcal{M}))\right)($ for $p>d)$. In fact, if we consider the Navier-Stokes equations on the real hyperbolic manifold $\mathbb{H}^{d}$, then the Kodaira-Hodge operator commutates with the vectorial heat semigroup and these phase spaces reduce to $C_{b}\left(\mathbb{R}, L^{p}\left(\Gamma\left(T \mathbb{H}^{d}\right)\right)\right)$. Therefore, the results obtained in this paper are extension of the ones obtained in [30].

& +\int_{0}^{1}\left((t-\tau)^{-\frac{d}{2}\left(\frac{1}{s}+\frac{1}{d}\right)}+1\right) 2 \tau^{-\frac{d}{2}\left(\frac{1}{p}-\frac{1}{s}+\frac{1}{d}\right)} d \tau+\int_{1}^{t} 2 e^{-\beta(t-\tau)} d \tau \\
& \leqslant \frac{2}{\beta}+\frac{2}{\theta_{s^{\prime}}}+t^{\frac{1}{2}-\frac{d}{2 p}} \mathbf{B}\left(\frac{1}{2}-\frac{d}{2 s}, \theta_{s}\right)+\frac{2}{\theta_{s}}+\frac{2}{\beta} \\
& \leqslant \frac{4}{\beta}+\frac{2}{\theta_{s^{\prime}}}+\mathbf{B}\left(\frac{1}{2}-\frac{d}{2 s}, \theta_{s}\right)+\frac{2}{\theta_{s}}:=M_{42 d}
\end{aligned}

Therefore, $G_{42}(t) \lesssim M_{42}:=\max \left\{M_{42 b}, M_{42 c}, M_{42 d}\right\}<+\infty$ for all $t \in \mathbb{R}$.
