# VECTOR-VALUED MAXIMAL INEQUALITIES AND MULTI-PARAMETER OSCILLATION INEQUALITIES FOR THE POLYNOMIAL ERGODIC AVERAGES ALONG MULTI-DIMENSIONAL SUBSETS OF PRIMES

#### Abstract

We prove the uniform $\ell^{2}$-valued maximal inequalities for polynomial ergodic averages and truncated singular operators of Cotlar type modeled over multi-dimensional subsets of primes. In the averages case, we combine this with earlier one-parameter oscillation estimates 20 to prove corresponding multi-parameter oscillation estimates. This provides a fuller quantitative description of the pointwise convergence of the mentioned averages and is a generalization of the polynomial Dunford-Zygmund ergodic theorem attributed to Bourgain 23 .


## 1. Introduction

1.1. Statement of results. Let $(X, \mathcal{B}, \mu)$ be a $\sigma$-finite measure space endowed with a family of invertible commuting and measure preserving transformations $S_{1}, \ldots, S_{d}: X \rightarrow X$. Let $\Omega$ be a bounded convex open subset of $\mathbb{R}^{k}$ such that $B\left(0, c_{\Omega}\right) \subseteq \Omega \subseteq B(0,1)$ for some $c_{\Omega} \in(0,1)$, where $B(0, u)$ is the open Euclidean ball in $\mathbb{R}^{k}$ with radius $u>0$ centered at $0 \in \mathbb{R}^{k}$. For any $t>0$, we set

We consider a polynomial mapping

\end{equation*}

where each $\mathcal{P}_{j}: \mathbb{Z}^{k} \rightarrow \mathbb{Z}$ is a polynomial of $k$ variables with integer coefficients such that $\mathcal{P}_{j}(0)=0$. Let $k^{\prime}, k^{\prime \prime} \in\{0,1, \ldots, k\}$ with $k=k^{\prime}+k^{\prime \prime}$. For $f \in L^{\infty}(X, \mu)$, we define the associated ergodic averages by

where $\pm \mathbb{P}$ denotes the set of positive and negative prime numbers and

\vartheta_{\Omega}(t):=\sum_{(n, p) \in \mathbb{Z}^{k^{\prime} \times( \pm \mathbb{P})^{k^{\prime \prime}}}} \mathbb{1}_{\Omega_{t}}(n, p)\left(\prod_{i=1}^{k^{\prime \prime}} \log \left|p_{i}\right|\right)

is the Chebyshev function. We also consider the Cotlar type ergodic averages given by

where $K: \mathbb{R}^{k} \backslash\{0\} \rightarrow \mathbb{C}$ is a Calderón-Zygmund kernel satisfying the following conditions:
(1) The size condition: For every $x \in \mathbb{R}^{k} \backslash\{0\}$, we have

(3) The Lipschitz continuity condition: For every $x, y \in \mathbb{R}^{k} \backslash\{0\}$ with $2|y| \leq|x|$, we have

For a sequence of functions $\left(f_{\mathfrak{i}}\right)_{i \in \mathbb{N}}$ with each $f_{\mathrm{i}} \in L^{p}(X, \mu)$, we define the $L^{p}\left(X ; \ell^{2}\right)$ norm by

and we say that $\left(f_{\mathrm{i}}\right)_{i \in \mathbb{N}} \in L^{p}\left(X ; \ell^{2}\right)$ if $\left\|f_{\mathrm{i}}\right\|_{L^{p}\left(X ; \ell^{2}\right)}<\infty$.
We can now state the main result of this paper.
Theorem 1. Let $d, k \in \mathbb{N}$ and let $\mathcal{P}$ be a polynomial mapping as in (1.1). Let $k^{\prime}, k^{\prime \prime} \in\{0,1, \ldots, k\}$ with $k^{\prime}+k^{\prime \prime}=k$ and let $\mathcal{M}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}}$ be either $\mathcal{A}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}}$ or $\mathcal{H}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}}$. Then, for any $p \in(1, \infty)$, there is a constant $C_{p, d, k, \operatorname{deg} \mathcal{P}}>0$ such that

for any $\left(f_{i}\right)_{i \in \mathbb{N}} \in L^{p}\left(X ; \ell^{2}\right)$. The constant $C_{p, d, k, \operatorname{deg} \mathcal{P}}$ is independent of the coefficients of the polynomial mapping $\mathcal{P}$.

In the proof of the above theorem, we use methods developed in [25, 29, 40] and very recently in [20, 22, 37]. We follow Bourgain's approach [5] to use the Calderón transference principle [7] which reduces the problem to the integer shift system (see Section (2.4) and then exploit the Hardy-Littlewood circle method to analyze the appropriate Fourier multipliers. The main tools used to handle the estimates for the multiplier operators are: an appropriate generalization of Weyl's inequality (Proposition 10); the IonescuWainger multiplier theorem (see [13, 29] and [39]) combined with the Rademacher-Menshov inequality (see [25]) and standard multiplier approximations (Lemma [12); the Magyar-Stein-Wainger sampling principle [19] and [27. Throughout, we also use the Marcinkiewicz-Zygmund inequality (Proposition (7) to extend scalar inequalities to their vector-valued analogues.

We recall the $\lambda$-jump counting function and the variation and oscillation semi-norms, which give quantitative measures for pointwise convergence. We use the convention that a supremum taken over the empty set is zero. Let $\mathbb{I} \subseteq \mathbb{R}$ with $\# \mathbb{I} \geq 2$ and $f: \mathbb{I} \rightarrow \mathbb{C}$. Given $\lambda>0$,the $\lambda$-jump counting function of $f$ is defined by

Given $r \in[1, \infty)$, the $r$-variation seminorm $V^{r}$ of a $f$ is defined by

Given $r \in[1, \infty), N \in \mathbb{N} \cup\{\infty\}$, and a strictly increasing sequence $I=\left(I_{j}: j \in \mathbb{N}\right) \subseteq \mathbb{I}$, the truncated $r$-oscillation seminorm of $f$ is defined by

Because of their preeminent role in multi-parameter pointwise convergence problems, we also consider multi-parameter analogues of the oscillation seminorms. Let $\mathbb{I} \subseteq \mathbb{R}^{M}$ with $\# \mathbb{I} \geq 2$ and $f: \mathbb{I} \rightarrow \mathbb{C}$. Given
$r \in[1, \infty), N \in \mathbb{N} \cup\{\infty\}$, and a sequence $I=\left(I_{j}: j \in \mathbb{N}\right) \subseteq \mathbb{I}$ that is strictly increasing in every coordinate, the $M$-parameter truncated $r$-oscillation seminorm of $f$ is defined by

where $\mathbb{B}\left[I_{j}\right]:=\left[I_{j 1}, I_{(j+1) 1}\right) \times \ldots \times\left[I_{j M}, I_{(j+1) M}\right)$ is a box determined by the element $I_{j}=\left(I_{j 1}, \ldots, I_{j M}\right)$ of the sequence $I$. Without causing any ambiguity, we may instead take $I \in \mathfrak{S}_{N}(\mathbb{I})$, the family of all sequences of length $N+1$ contained in $\mathbb{I}$ that are strictly increasing in every coordinate. For more information about these quantitative tools in the study of pointwise convergence problems, we refer to [26], see also [5, 17, 22, 23, 27, 36].

We now recall an abstract multi-parameter oscillation result. For a linear operator $T: L^{0}(X) \rightarrow L^{0}(X)$, we denote by $|T|$ the sublinear maximal operator taken in the lattice sense defined by

Proposition 2. [26, Proposition 4.1] Let $(X, \mathcal{B}(X), \mu)$ be a $\sigma$-finite measure space and let $\mathbb{I} \subseteq \mathbb{R}$ be such that $\# \mathbb{I} \geq 2$. Let $k \in \mathbb{N}_{\geq 2}$ and $p, r \in(1, \infty)$ be fixed. Let $\left(T_{t}\right)_{t \in \mathbb{I}_{k}}$ be a family of linear operators of the form

where $\left\{T_{t_{i}}^{i}: i \in[k], t_{i} \in \mathbb{I}\right\}$ is a family of commuting linear operators that are bounded on $L^{p}(X)$. If the set $\mathbb{I}$ is uncountable, then we also assume that $\mathbb{I} \ni t \mapsto T_{t}^{i} f$ is continuous $\mu$-almost everywhere on $X$ for every $f \in L^{0}(X)$ and $i \in[k]$. Further assume that, for every $i \in[k]$, we have

Then we have the following multi-parameter $r$-oscillation estimate:

In the $\mathcal{M}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}}=\mathcal{A}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}}$ case, (1.8) gives us

which corresponds to condition (1.10) in the $r=2$ case. We also recall the variation, jump, and oneparameter oscillation inequalities for $\mathcal{A}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}}$ and $\mathcal{H}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}}$.
Proposition 3. [40, Theorem C] [20, Theorem 1] Let $d, k \geq 1, r \in(2, \infty)$, and let $\mathcal{P}$ be a polynomial mapping as in (1.1). Let $k^{\prime}, k^{\prime \prime} \in\{0,1, \ldots, k\}$ with $k^{\prime}+k^{\prime \prime}=k$ and let $\mathcal{M}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}}$ be either $\mathcal{A}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}}$ or $\mathcal{H}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}}$. Then, for any $p \in(1, \infty)$, there is a constant $C_{p, d, k, \operatorname{deg} \mathcal{P}}>0$ such that

& \sup _{N \in \mathbb{N} I \in \mathcal{S}_{N}\left(\mathbb{R}_{+}\right)}\left\|O_{I, N}^{2}\left(\mathcal{M}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}} f: t>0\right)\right\|_{L^{p}(X, \mu)} \leq C_{p, d, k, \operatorname{deg} \mathcal{P}}\|f\|_{L^{p}(X, \mu)}, \tag{1.14}

for any $f \in L^{p}(X, \mu)$. The constant $C_{p, d, k, \operatorname{deg} \mathcal{P}}$ is independent of the coefficients of the polynomial mapping $\mathcal{P}$.

In particular, (1.14) corresponds to condition (1.9). As such, we have the following applications.

Let $M \in \mathbb{N}$ and let $(X, \mathcal{B}, \mu)$ be a $\sigma$-finite measure space endowed with a family of invertible commuting and measure preserving transformations $S_{1}^{1}, \ldots, S_{d_{1}}^{1}, \ldots, S_{1}^{M}, \ldots, S_{d_{M}}^{M}: X \rightarrow X$. For each $j \in\{1, \ldots, M\}$, let $\Omega^{j}$ be a bounded convex open subset of $\mathbb{R}^{k_{j}}$ such that $B(0, c) \subseteq \Omega^{j} \subseteq B(0,1)$ for some $c \in(0,1)$, let $\mathcal{P}^{j}$ be a polynomial mapping

For $f \in L^{\infty}(X, \mu)$, we define the associated ergodic averages by

Letting $k=k_{1}+\ldots+k_{M}, k^{\prime}=k_{1}^{\prime}+\ldots+k_{M}^{\prime}$, and $k^{\prime \prime}=k_{1}^{\prime \prime}+\ldots+k_{M}^{\prime \prime}$, we let $(n, p) \in \mathbb{Z}^{k^{\prime}} \times( \pm \mathbb{P})^{k^{\prime \prime}}$ denote $\left(n_{1}, p_{1}, \ldots, n_{M}, p_{M}\right) \in \mathbb{Z}_{1}^{k_{1}^{\prime}} \times( \pm \mathbb{P})^{k_{1}^{\prime \prime}} \times \ldots \times \mathbb{Z}^{k_{M}^{\prime}} \times( \pm \mathbb{P})^{k_{M}^{\prime \prime}} \cong \mathbb{Z}^{k^{\prime}} \times( \pm \mathbb{P})^{k^{\prime \prime}}$. Let $p \in(1, \infty)$ and $f \in L^{p}(X, \mu)$. Then we have:
(i) (Mean ergodic theorem) the averages $\mathcal{A}_{t} f$ converge in $L^{p}(X, \mu)$ norm as $\min \left\{t_{1}, \ldots, t_{M}\right\} \rightarrow \infty$;
(ii) (Pointwise ergodic theorem) the averages $\mathcal{A}_{t} f$ converge pointwise $\mu$-almost everywhere on $X$ as $\min \left\{t_{1}, \ldots, t_{M}\right\} \rightarrow \infty$;
(iii) (Maximal ergodic theorem) the following maximal estimate holds, including with $p=\infty$ :

$$
\begin{equation*}
\left\|\sup _{t \in \mathbb{R}_{+}^{M}}\left|\mathcal{A}_{t} f\right|\right\|_{L^{p}(X, \mu)} \lesssim d, k, p, M, \operatorname{deg} \mathcal{P}\|f\|_{L^{p}(X, \mu)} ; \tag{1.15}
\end{equation*}
$$

(iv) (Oscillation ergodic theorem) the following uniform oscillation inequality holds:

$$
\begin{equation*}
\sup _{N \in \mathbb{N}} \sup _{I \in \mathfrak{S}_{N}\left(\mathbb{R}_{+}^{M}\right)}\left\|O_{I, N}^{2}\left(\mathcal{A}_{t} f: t \in \mathbb{R}_{+}^{M}\right)\right\|_{L^{p}(X)} \lesssim d, k, p, M, \operatorname{deg} \mathcal{P}\|f\|_{L^{p}(X)}, \quad f \in L^{p}(X) . \tag{1.16}
\end{equation*}
$$

The implicit constants in (1.15) and (1.16) are independent of the coefficients of the polynomial mapping $\mathcal{P}$.

This generalizes the polynomial Dunford-Zygmund ergodic theorem due to Bourgain as we shall see in section 1.4. We note that (i) follows from the dominated convergence theorem together with (ii) and (iii), and these each follow from (iv). Although Corollary 4 only requires the $\mathcal{M}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}}=\mathcal{A}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}}$ case of Theorem [1, we also prove the $\mathcal{M}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}}=\mathcal{H}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}}$ case for the sake of independent interest and to exhibit a unified approach that illustrates what common features of the operators are needed in the proof.
1.2. Historical background: Classical results and Bourgain. In 1931, Birkhoff [2] and von Neumann [32] proved that the averages

$$
\begin{equation*}
M_{N} f(x):=\frac{1}{N} \sum_{n=1}^{N} f\left(S^{n} x\right) \tag{1.17}
\end{equation*}
$$

converge pointwise $\mu$-almost everywhere on $X$ and in $L^{p}(X, \mu)$ norm respectively for any $f \in L^{p}(X, \mu)$, $p \in[1, \infty)$, as $N \rightarrow \infty$. In 1955, Cotlar [10] established the pointwise $\mu$-almost everywhere convergence on $X$ as $N \rightarrow \infty$ of the ergodic Hilbert transform given by

$$
H_{N} f(x):=\sum_{1 \leq|n| \leq N} \frac{f\left(S^{n} x\right)}{n}
$$

for any $f \in L^{p}(X, \mu)$. In 1968, Calderón [7] made an important observation (now called the Calderón transference principle) that some results in ergodic theory can be easily deduced from known results in harmonic analysis. Namely, the convergence of the Birkhoff averages $M_{N}$ can be deduced from the boundedness of the Hardy-Littlewood maximal function, and the convergence of Cotlar's averages $H_{N}$ follows from the boundedness of the maximal function for the truncated discrete Hilbert transform. As we will see ahead, this observation has had a huge impact in the study of convergence problems in ergodic theory.

We briefly sketch the classical approach of handling the problem of pointwise convergence. It consists of two steps:
(a) Establish $L^{p}$-boundedness for the corresponding maximal function.
(b) Find a dense class of functions in $L^{p}(X, \mu)$ for which the pointwise convergence holds.

In the case of Birkhoff's averages $M_{N}$, the Calderón transference principle allows one to deduce the estimate

$$
\left\|\sup _{N \in \mathbb{N}}\left|M_{N} f\right|\right\|_{L^{p}(X, \mu)} \lesssim_{p}\|f\|_{L^{p}(X, \mu)}
$$

for $p \in(1, \infty]$ from the estimate for the discrete Hardy-Littlewood maximal function (and we have a weak-type estimate for $p=1$ ). In turn, estimates for the discrete Hardy-Littlewood maximal function follow easily from those for the continuous one. This establishes the first step (a). For the second step, one can use the idea of Riesz decomposition [34] to analyze the space $\mathbb{I}_{S} \oplus \mathbb{T}_{S} \subseteq L^{2}(X, \mu)$, where

$$
\mathbb{I}_{S}:=\left\{f \in L^{2}(X, \mu): f \circ S=f\right\} \quad \text { and } \quad \mathbb{T}_{S}:=\left\{h \circ S-h: h \in L^{2}(X, \mu) \cap L^{\infty}(X, \mu)\right\} .
$$

We see that $M_{N} f=f$ for $f \in \mathbb{I}_{S}$ and, for $g=h \circ S-h \in \mathbb{T}_{S}$, we have

$$
M_{N} g(x)=\frac{1}{N}\left(h\left(S^{N+1} x\right)-h(S x)\right)
$$

by telescoping. Consequently, we see that $M_{N} g \rightarrow 0$ as $N \rightarrow \infty$. This establishes $\mu$-almost everywhere pointwise convergence of $M_{N}$ on $\mathbb{I}_{S} \oplus \mathbb{T}_{S}$, which is dense in $L^{2}(X, \mu)$. Since $L^{2}(X, \mu)$ is dense in $L^{p}(X, \mu)$ for every $p \in[1, \infty)$, this establishes (b).

At the beginning of the 1980's, Bellow [1] and independently Furstenberg [12] posed the problem of the pointwise convergence of the averages along squares given by

$$
T_{N} f(x):=\frac{1}{N} \sum_{n=1}^{N} f\left(S^{n^{2}} x\right) .
$$

Despite its similarity to Birkhoff's theorem, the problem of pointwise convergence of the $T_{N}$ averages has a totally different nature from that of its linear counterpart, and the standard approach is insufficient in this case. For the first step, by the Calderón transference principle, it is enough to establish $\ell^{p}$ bounds for the maximal function given by

$$
\begin{equation*}
\sup _{N \in \mathbb{N}} \frac{1}{N} \sum_{n=1}^{N} f\left(x-n^{2}\right), \quad f \in \ell^{p}(\mathbb{Z}) . \tag{1.18}
\end{equation*}
$$

The $\ell^{p}$ estimate for the above maximal function does not follow directly from the continuous counterpart and requires completely new methods. However, a more serious problem arises in connection with the second step. The telescoping idea fails in the case of the averages $T_{N} g$ since the $(n+1)^{2}-n^{2}=2 n+1$ gap sizes are unbounded.

At the end of the 1980's, Bourgain established the pointwise convergence of the averages $T_{N}$ in a series of groundbreaking articles [3, 4, 5. By using the Hardy-Littlewood circle method from analytic number theory, he established $\ell^{p}$-bounds for the maximal function (1.18), which establishes step (a). He then bypassed the problem of finding the requisite dense class of functions by using the oscillation seminorm. Bourgain [5 proved that, for any $\lambda>1$ and any sequence of integers $I=\left(I_{j}: j \in \mathbb{N}\right)$ with $I_{j+1}>2 I_{j}$ for all $j \in \mathbb{N}$, we have

$$
\begin{equation*}
\left\|O_{I, N}^{2}\left(T_{\lambda^{n}} f: n \in \mathbb{N}\right)\right\|_{L^{2}(X, \mu)} \leq C_{I, \lambda}(N)\|f\|_{L^{2}(X, \mu)}, \quad N \in \mathbb{N}, \tag{1.19}
\end{equation*}
$$

for any $f \in L^{2}(X, \mu)$ with $\lim _{N \rightarrow \infty} N^{-1 / 2} C_{I, \lambda}(N)=0$. Inequality (1.19) suffices to establish the pointwise convergence of the averaging operators $T_{N} f$ for any $f \in L^{2}(X, \mu)$ (see [26, Proposition 2.8] for details even in the multi-parameter setting). Indeed, it can be thought of as the weakest possible quantitative form of pointwise convergence since one can derive (1.19) with $C_{I, \lambda}(N)$ at most $N^{1 / 2}$ from the $\ell^{2}$ bound for the maximal function (1.18).

In the same series of papers, by similar methods, Bourgain established the pointwise convergence of the averages along primes

$$
\frac{1}{\left|\mathbb{P}_{N}\right|} \sum_{n=1}^{N} f\left(S^{n} x\right) \mathbb{1}_{\mathbb{P}}(n)
$$

for $f \in L^{p}(X, \mu)$ with $p>\frac{1}{2}(1+\sqrt{3})$. In the same year, Wierdl 41 extended Bourgain's result to $p \in(1, \infty)$.
1.3. Historical background: Developments towards Proposition 3. An intriguing question was the issue of uniformity in the inequality (1.19). Shortly after the groundbreaking work of Bourgain, Lacey [35, Theorem 4.23, p. 95] improved inequality (1.19) showing that, for every $\lambda>1$, there is a constant $C_{\lambda}>0$ such that

$$
\begin{equation*}
\sup _{N \in \mathbb{N}} \sup _{I \in \mathfrak{G}_{N}\left(\mathbb{L}_{\tau}\right)}\left\|O_{I, N}^{2}\left(T_{\lambda^{n}} f: n \in \mathbb{N}\right)\right\|_{L^{2}(X)} \leq C_{\lambda}\|f\|_{L^{2}(X)}, \quad f \in L^{2}(X, \mu) \tag{1.20}
\end{equation*}
$$

where $\mathbb{L}_{\tau}:=\left\{\tau^{n}: n \in \mathbb{N}\right\}$. This result motivated the question about uniform estimates independent of $\lambda>1$ in (1.20). In the case of Birkhoff's averages, this is the Rosenblatt-Wierdl conjecture explicitly formulated in [35, Problem 4.12, p. 80] in the early 1990s.

In 1998, Jones, Kaufman, Rosenblatt, and Wierdl [14 established the uniform oscillation inequality on $L^{p}(X, \mu)$ for the standard Birkhoff averages $M_{N}$. Two years later, Campbell, Jones, Reinhold, and Wierdl [8] established the uniform oscillation inequality for the ergodic Hilbert transform. In 2003, Jones, Rosenblatt, and Wierdl [16] proved uniform oscillation inequalities on $L^{p}(X, \mu)$ with $p \in(1,2]$ for the Birkhoff averages over cubes. However, the case of polynomial averages, even one-dimensional, was open until recent works [22, 37], see [20] for the case of averages over primes.

In 2015, Mirek and Trojan [30, using the ideas of Bourgain and Wierdl, established $\mu$-almost everywhere pointwise convergence of the Cotlar averages along the primes,

$$
\sum_{p \in\left( \pm \mathbb{P}_{N}\right)} \frac{f\left(S^{p}\right)}{p} \log |p| .
$$

They proved that the corresponding maximal function is bounded on $L^{p}(X, \mu)$ with $p>1$ and showed that the analogue of Bourgain's non-uniform oscillation inequality (1.19) holds for those averages.

In the same year, Zorin-Kranich [42] established the pointwise convergence of the averages related to the polynomial mapping given by

$$
\tilde{\mathcal{P}}=\left(n, n^{2}, n^{3}, \ldots, n^{d}\right): \mathbb{Z} \rightarrow \mathbb{Z}^{d}
$$

Namely, he proved that, for any $r>2$ and $\left|\frac{1}{p}-\frac{1}{2}\right|<\frac{1}{2(d+1)}$, we have the following $r$-variational estimate

$$
\left\|V^{r}\left(\mathcal{A}_{N}^{\tilde{\mathcal{P}} 1,0} f: N \in \mathbb{N}\right)\right\|_{L^{p}(X, \mu)} \lesssim_{p, r}\|f\|_{L^{p}(X, \mu)}
$$

As a consequence, the averages $\mathcal{A}_{N}^{\tilde{\mathcal{P}} 1,0} f$ converge $\mu$-almost everywhere for any $f \in L^{p}(X, \mu)$.
In 2016, Mirek and Trojan [31] established the pointwise convergence for the averages (1.2) taken over cubes with $k^{\prime}=k$, that is

$$
A_{N, \text { cube }}^{\mathcal{P}, k, 0} f(x):=\frac{1}{N^{k}} \sum_{y \in[0, N]^{k} \cap \mathbb{Z}^{k}} f\left(S_{1}^{\mathcal{P}_{1}(y)} S_{2}^{\mathcal{P}_{1}(y)} \cdots S_{d}^{\mathcal{P}_{d}(y)} x\right)
$$

There, Mirek and Trojan noted for the first time that the Rademacher-Menshov inequality (2.1) may be used to establish $r$-variational estimates. For $p \in(1, \infty)$ and $r>\max \{p, p /(p-1)\}$, they proved that

$$
\left\|V^{r}\left(A_{N, \text { cube }}^{\mathcal{P}, k, 0} f: N \in \mathbb{N}\right)\right\|_{L^{p}(X, \mu)} \leq C_{p, d, k, \operatorname{deg} \mathcal{P}}\|f\|_{L^{p}(X, \mu)} .
$$

Unfortunately, the methods introduced by Bourgain had limitations. These work perfectly fine in the case of the $L^{2}$ estimates, but, in the case of an $L^{p}$ estimates with $p \neq 2$, there arise difficulties which are hard to overcome concerning the fractions around which major arcs are defined. However, Ionescu and Wainger [13], in their groundbreaking 2005 work about discrete singular Radon operators, introduced a set of fractions for which the circle method can be applied towards $L^{p}$ estimates with $p \neq 2$.

In 2015, Mirek [21] built a discrete counterpart of the Littlewood-Paley theory using the IonescuWainger multiplier theorem and used it to reprove the main result from [13]. In 2017, Mirek, Stein, and Trojan [24, 25] further exploited these ideas together with the Rademacher-Menshov inequality from [31] to obtain an $L^{p}$ estimate for the $r$-variation seminorm for both $\mathcal{A}_{t}^{\mathcal{P}, k, 0}$ and $\mathcal{H}_{t}^{\mathcal{P}, k, 0}$ associated with convex sets in the full range of parameters. Namely, they showed that

$$
\begin{equation*}
\left\|V^{r}\left(\mathcal{M}_{t}^{\mathcal{P}, k, 0} f: t>0\right)\right\|_{L^{p}(X, \mu)} \lesssim d, k, p, r, \operatorname{deg} \mathcal{P}\|f\|_{L^{p}(X, \mu)} \tag{1.21}
\end{equation*}
$$

for $p \in(1, \infty)$ and $r \in(2, \infty)$, where $\mathcal{M}_{t}^{\mathcal{P}, k, 0}$ is either $\mathcal{A}_{t}^{\mathcal{P}, k, 0}$ or $\mathcal{H}_{t}^{\mathcal{P}, k, 0}$.
In 2019, Trojan [40] proved the variation case of Proposition 3, A straightforward consequence is the $\mu$-almost everywhere convergence of the averages $\mathcal{A}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}} f$ and $\mathcal{H}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}} f$.

In 2020, Mirek, Stein, and Zorin-Kranich [29] further refined the methods developed in [24, 25] and proved a uniform $L^{p}$ estimate for the $\lambda$-jump counting function. They proved that

$$
\begin{equation*}
\sup _{\lambda>0}\left\|\lambda N_{\lambda}\left(\mathcal{M}_{t}^{\mathcal{P}, k, 0} f: t>0\right)^{1 / 2}\right\|_{L^{p}(X, \mu)} \leq C_{p, d, k, \operatorname{deg} \mathcal{P}}\|f\|_{L^{p}(X, \mu)} \tag{1.22}
\end{equation*}
$$

for any $p \in(1, \infty)$ and any $f \in L^{p}(X, \mu)$, where $\mathcal{M}_{t}^{\mathcal{P}, k, 0} f$ is either $\mathcal{A}_{t}^{\mathcal{P}, k, 0} f$ or $\mathcal{H}_{t}^{\mathcal{P}, k, 0} f$. There, the operators $\mathcal{H}_{t}^{\mathcal{P}, k, 0}$ are associated with Calderón-Zygmund kernels satisfying the Hölder continuity condition generalizing (1.6): For some $\sigma \in(0,1]$ and for every $x, y \in \mathbb{R}^{k} \backslash\{0\}$ with $2|y| \leq|x|$, we have

$$
\begin{equation*}
|K(x)-K(x+y)| \lesssim|y|^{\sigma}|x|^{-(k+\sigma)} . \tag{1.23}
\end{equation*}
$$

It is worth noting that the inequality (1.22) implies the $r$-variation inequality (1.21).

In 2021, Mirek, Słomian, and Szarek [22] established the oscillation inequality

$$
\begin{equation*}
\sup _{N \in \mathbb{N}} \sup _{I \in \mathfrak{S}_{N}\left(\mathbb{R}_{+}\right)}\left\|O_{I, N}^{2}\left(\mathcal{A}_{t}^{\mathcal{P}, k, 0} f: t>0\right)\right\|_{L^{p}(X, \mu)} \leq C_{p, d, k, \operatorname{deg} \mathcal{P}}\|f\|_{L^{p}(X, \mu)} \tag{1.24}
\end{equation*}
$$

and, Słomian [37] later proved the counterpart of (1.24) in the case of the operators $\mathcal{H}_{t}^{\mathcal{P}, k, 0}$ related to Calderón-Zygmund kernels satisfying (1.23). Lastly, in 2023, Słomian and the author [20] proved the oscillation and jump cases of Proposition 3. This is the most general quantitative version of the one parameter ergodic theorem for both averages $\mathcal{A}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}}$ and $\mathcal{H}_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}}$ (cf. [233, Theorem 1.20]), which concludes the work of many authors over the last decades.
1.4. Historical background: Multi-parameter problems. In 1951, Dunford 11 and independently Zygmund [43] showed that the two-step procedure can be applied in a multi-parameter setting. Even for $S_{1}, \ldots, S_{d}$ not necessarily commuting, the Dunford-Zygmund ergodic theorem states that the averages

$$
A_{M_{1}, \ldots, M_{d} ; S_{1}, \ldots, S_{d}}^{n_{1}, \ldots, n_{d}} f(x):=\frac{1}{M_{1} \cdots M_{d}} \sum_{n_{1}=1}^{M_{1}} \cdots \sum_{n_{d}=1}^{M_{d}} f\left(S_{1}^{n_{1}} \cdots S_{d}^{n_{d}} x\right), \quad x \in X
$$

converge almost everywhere on $X$ and in $L^{p}(X)$ norm as $\min \left\{M_{1}, \ldots, M_{d}\right\} \rightarrow \infty$ for every $f \in L^{p}(X)$, $p \in(1, \infty)$. Using the identity

$$
A_{M_{1}, \ldots, M_{d} ; S_{1}, \ldots, S_{d}}^{n_{1}, \ldots, n_{d}} f=A_{M_{1} ; S_{1}}^{n_{1}} \circ \cdots \circ A_{M_{d} ; S_{d}}^{n_{d}} f,
$$

the $L^{p}(X), p \in(1, \infty]$, bounds for the strong maximal function $\sup _{M \in \mathbb{N}^{d}}\left|A_{M_{1}, \ldots, M_{d} ; S_{1}, \ldots, S_{d}}^{n_{1}, \ldots, n_{d}} f\right|$ follow by applying $d$ times the corresponding $L^{p}(X)$ bounds for $\sup _{M \in \mathbb{N}}\left|A_{M ; S}^{n} f\right|$. This establishes (a), and (b) can be established by a suitable adaptation of the telescoping argument to the multi-parameter setting and an application of the classical Birkhoff ergodic theorem, see [33] for more details. We note that that the operator $f \mapsto \sup _{M \in \mathbb{N}^{d}}\left|A_{M_{1}, \ldots, M_{d} ; S_{1}, \ldots, S_{d}}^{n_{1}, \ldots, n_{d}} f\right|$ is not of weak type $(1,1)$ in general, so the pointwise convergence may fail if $p=1$. A model example is $X=\mathbb{Z}^{d}$ with $S_{j} x=x-e_{j}, 1 \leq j \leq d$, where $e_{j}$ is the $j$ th coordinate vector. It is well known that the weak type $(1,1)$ estimate does not hold for the corresponding strong maximal operator, see [38, Section X.2.3].

After completing [3, 4, 5], Bourgain observed that the Dunford-Zygmund ergodic theorem can be extended to the polynomial setting at the expense of imposing that the measure-preserving transformations commute. Bourgain's result can be formulated as follows.

Proposition 5 (Polynomial Dunford-Zygmund ergodic theorem). [23, Theorem 1.25] Let $M \in \mathbb{N}$, let $(X, \mathcal{B}, \mu)$ be a $\sigma$-finite measure space endowed with a family of invertible commuting and measure preserving transformations $S_{1}, \ldots, S_{M}: X \rightarrow X$, and consider a polynomial mapping

$$
\mathcal{P}=\left(\mathcal{P}_{1}, \ldots, \mathcal{P}_{M}\right): \mathbb{Z}^{M} \rightarrow \mathbb{Z}^{M}
$$

where each $\mathcal{P}_{j}: \mathbb{Z} \rightarrow \mathbb{Z}$ is a polynomial of one variable with integer coefficients such that $\mathcal{P}_{j}(0)=0$. For $f \in L^{\infty}(X, \mu)$ and $t, t_{1}, \ldots, t_{M} \in \mathbb{N}$, we define the associated ergodic averages by

$$
A_{t}^{\mathcal{P}_{j}} f(x):=\frac{1}{t} \sum_{n=1}^{t} f\left(S_{1}^{\mathcal{P}_{j}(n)} x\right), \quad x \in X,
$$

and

$$
A_{t_{1}, \ldots, t_{M}}^{\mathcal{P}_{1}, \ldots, \mathcal{P}_{M}} f(x):=A_{t_{1}}^{\mathcal{P}^{1}} \circ \cdots \circ \mathcal{A}_{t_{M}}^{\mathcal{P}_{M}}, f(x)=\frac{1}{t_{1} \cdots t_{M}} \sum_{n_{1}=1}^{t_{1}} \cdots \sum_{n_{M}=1}^{t_{M}} f\left(S_{1}^{\mathcal{P}_{1}\left(n_{1}\right)} \cdots S_{M}^{\mathcal{P}_{M}\left(n_{M}\right)} x\right), \quad x \in X .
$$

Let $p \in(1, \infty)$ and $f \in L^{p}(X, \mu)$. Then we have:
(i) (Mean ergodic theorem) the averages $A_{t_{1}, \ldots, t_{M}}^{\mathcal{P}_{1}, \ldots, \mathcal{P}_{M}} f$ converge in $L^{p}(X, \mu)$ norm as $\min \left\{t_{1}, \ldots, t_{M}\right\} \rightarrow$ $\infty$;
(ii) (Pointwise ergodic theorem) the averages $A_{t_{1}, \ldots, t_{M}}^{\mathcal{P}_{1}, \ldots, \mathcal{P}_{M}} f$ converge pointwise $\mu$-almost everywhere on $X$ as $\min \left\{t_{1}, \ldots, t_{M}\right\} \rightarrow \infty$;
(iii) (Maximal ergodic theorem) the following maximal estimate holds, including with $p=\infty$ :

$$
\left\|\sup _{t \in \mathbb{N}^{M}}\left|A_{t_{1}, \ldots, t_{M}}^{\mathcal{P}_{1}, \ldots \mathcal{P}_{M}} f\right|\right\|_{L^{p}(X, \mu)} \lesssim_{p, M, \operatorname{deg} \mathcal{P}}\|f\|_{L^{p}(X, \mu)}
$$

(iv) (Oscillation ergodic theorem) the following uniform oscillation inequality holds:

$$
\sup _{N \in \mathbb{N}} \sup _{I \in \mathfrak{S}_{N}\left(\mathbb{R}_{+}^{M}\right)}\left\|O_{I, N}^{2}\left(A_{t_{1}, \ldots, t_{M}}^{\mathcal{P}_{1} \ldots, \mathcal{P}_{M}} f: t \in \mathbb{N}^{M}\right)\right\|_{L^{p}(X)} \lesssim_{p, M, \operatorname{deg} \mathcal{P}}\|f\|_{L^{p}(X)}, \quad f \in L^{p}(X),
$$

with implicit constants independent of the coefficients of the polynomial mapping $\mathcal{P}$.
Proposition 55(i)-(iii) is attributed to Bourgain, though it was never published, see [23] for a proof and additional historical notes, and Proposition [5(iv) with linear polynomials $\mathcal{P}_{1}(t)=\ldots=\mathcal{P}_{M}(t)=t$ was established in [15. Corollary 4 is a significant generalization of Proposition 5 (one may check that the proof is easily adaptable to sums taken over $\mathbb{N}$ instead of $\mathbb{Z}$ ) in that it allows for averages taken over primes and over more general polynomial orbits. Indeed, from the point of view of the permitted polynomial orbits, Corollary 4 is the most one can extend Proposition 5 without having to go beyond averaging operators that can be written as the composition of one-parameter averaging operators. For comparison, proving the analogue of Proposition 5 for averages of the form

\frac{1}{t_{1} \cdots t_{M}} \sum_{n_{1}=1}^{t_{1}} \cdots \sum_{n_{M}=1}^{t_{M}} f\left(S_{1}^{\mathcal{P}_{1}\left(n_{1}, \ldots, n_{M}\right)} \cdots S_{M}^{\mathcal{P}_{M}\left(n_{1}, \ldots, n_{M}\right)} x\right)
$$

is a central open problem in modern ergodic theory that can be seen as a multi-parameter variant of the Bellow and Furstenberg problem (cf. [23, Conjecture 1.29], and see [6] for some recent progress).

## 2. Notation and necessary tools

2.1. Basic notation. We denote $\mathbb{N}:=\{1,2, \ldots\}, \mathbb{N}_{0}:=\{0,1,2, \ldots\}$, and $\mathbb{R}_{+}:=(0, \infty)$. For $d \in \mathbb{N}$, the sets $\mathbb{Z}^{d}, \mathbb{R}^{d}, \mathbb{C}^{d}$, and $\mathbb{T}^{d}=(\mathbb{R} / \mathbb{Z})^{d} \equiv[-1 / 2,1 / 2)^{d}$ have the standard meanings. For each $N \in \mathbb{N}$, we set

\mathbb{N}_{N}:=\{1, \ldots, N\} .
$$

For any $x \in \mathbb{R}$, we set

\lfloor x\rfloor:=\max \{n \in \mathbb{Z}: n \leq x\} .

For $u \in \mathbb{N}$, we define the set

2^{u \mathbb{N}}:=\left\{2^{u n}: n \in \mathbb{N}\right\} .

For two non-negative numbers $A$ and $B$, we write $A \lesssim B$ to indicate that $A \leq C B$ for some $C>0$ that may change from line to line, and we may write $\lesssim \delta$ if the implicit constant depends on $\delta$.

We denote the standard inner product on $\mathbb{R}^{d}$ by $x \cdot \xi$. Moreover, for any $x \in \mathbb{R}^{d}$, we denote the $\ell^{2}$-norm and the maximum norm respectively by

|x|:=|x|_{2}:=\sqrt{x \cdot x} \quad \text { and } \quad|x|_{\infty}:=\max _{1 \leq k \leq d}\left|x_{k}\right| .

For a multi-index $\gamma=\left(\gamma_{1}, \ldots, \gamma_{k}\right) \in \mathbb{N}_{0}^{k}$, we abuse the notation to write $|\gamma|:=\gamma_{1}+\cdots+\gamma_{k}$. No confusion should arise since all multi-indices will be denoted by $\gamma$.

Let $\mathbb{I} \subset \mathbb{R}$ and let $E$ be either of $\mathbb{R}^{d}$ or $\mathbb{Z}^{d}$ with the usual measures and let $\left(f_{i, t}: \mathfrak{i} \in \mathbb{N}\right) \in L^{p}\left(E, \ell^{2}\right)$ for all $t \in \mathbb{I}$. We define

As we shall see, working with this rather than the usual maximal function is just a technical adaptation to be more similar to the variation, jump, and oscillation quantities that have been studied before.
2.2. Rademacher-Menshov inequality. We recall a basic numerical inequality. A variational version of this inequality was proven by Lewko-Lewko [18, Lemma 13], see also [28, Lemma 2.5, p. 534].
Proposition 6. For any $k, m \in \mathbb{N}$ with $k<2^{m}$ and any sequence of complex numbers ( $a_{n}: n \in \mathbb{N}$ ), we have

where each $\left[u_{j}^{i}, u_{j+1}^{i}\right)$ is a dyadic interval contained in $\left[k, 2^{m}\right]$ of the form $\left[j 2^{i},(j+1) 2^{i}\right)$ for some $0 \leq i \leq m$ and $0 \leq j \leq 2^{m-i}-1$.
2.3. Marcinkiewicz-Zygmund inequality. We recall a result extending the Marcinkiewicz-Zygmund inequality to the Hilbert space setting. Let $\left(T_{m}: m \in \mathbb{N}_{0}\right)$ be a family of bounded linear operators, $T_{m}: L^{p}(X) \rightarrow L^{p}(X)$. For each $\omega \in[0,1]$, we define

where $\left(\epsilon_{m}: m \in \mathbb{N}_{0}\right)$ is the sequence of Rademacher functions on $[0,1]$.
Proposition 7. [24, Lemma 2.1] Let $p \in(0, \infty)$. Suppose there is a constant $C_{p}>0$ such that, for all $\omega \in[0,1]$ and $f \in L^{p}(X)$, we have

\end{equation*}

for every sequence of functions $\left(f_{i}\right)_{i \in \mathbb{N}}$ in $L^{p}\left(X ; \ell^{2}\right)$. Moreover, if $T_{m} \equiv 0$ for all $m \in \mathbb{N}$, then (2.2) recovers the Marcinkiewicz-Zygmund inequality

2.4. Reductions: Calderón transference and lifting. By the Calderón transference principle [7], we may restrict attention to the model dynamical system of $\mathbb{Z}^{d}$ equipped with the counting measure and the shift operators $S_{j}: \mathbb{Z}^{d} \rightarrow \mathbb{Z}^{d}$ given by $S_{j}\left(x_{1}, \ldots, x_{d}\right):=\left(x_{1}, \ldots, x_{j}-1, \ldots, x_{d}\right)$. We denote the corresponding averaging operators by

A_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}} f(x)=\frac{1}{\vartheta_{\Omega}(t)} \sum_{\left.(n, p) \in \mathbb{Z}^{k^{\prime} \times( \pm \mathbb{P}}\right)^{k^{\prime \prime}}} f(x-\mathcal{P}(n, p)) \mathbb{1}_{\Omega_{t}}(n, p)\left(\prod_{j=1}^{k^{\prime \prime}} \log \left|p_{j}\right|\right)
$$

and

$$
H_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}} f(x)=\sum_{(n, p) \in \mathbb{Z}^{k^{\prime}} \times( \pm \mathbb{P})^{k^{\prime \prime}}} f(x-\mathcal{P}(n, p)) K(n, p) \mathbb{1}_{\Omega_{t}}(n, p)\left(\prod_{j=1}^{k^{\prime \prime}} \log \left|p_{j}\right|\right) .
$$

Moreover, by a standard lifting argument, it suffices to prove Theorem 1 for a canonical case of the polynomial mapping $\mathcal{P}$. Let $\mathcal{P}$ be a polynomial mapping as in (1.1). We define

where $x^{\gamma}=x_{1}^{\gamma_{1}} x_{2}^{\gamma_{2}} \cdots x_{k}^{\gamma_{k}}$. By invoking the lifting procedure described in 24, Lemma 2.2] (see also 38, Chapter XI]), the following implies Theorem [1].

Let $k \in \mathbb{N}$, let $\Gamma \subset \mathbb{N}^{k} \backslash\{0\}$ be a nonempty finite set, and let $k^{\prime}, k^{\prime \prime} \in\{0,1, \ldots, k\}$ with $k^{\prime}+k^{\prime \prime}=k$. Let $M_{t}^{k^{\prime}, k^{\prime \prime}}$ be either $A_{t}^{\mathcal{Q}, k^{\prime}, k^{\prime \prime}}$ or $H_{t}^{\mathcal{Q}, k^{\prime}, k^{\prime \prime}}$. For any $p \in(1, \infty)$, there is a constant $C_{p, k,|\Gamma|}>0$ such that

\left\|\sup _{t>0} \mid M_{t}^{\mathcal{P}, k^{\prime}, k^{\prime \prime}} f_{\mathrm{i}_{\mathrm{i}}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \leq C_{p, k,|\Gamma|}\left\|f_{\mathrm{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} . \tag{2.5}
\end{equation*}
$$

2.5. Fourier transform and Ionescu-Wainger multiplier theorem. Let $\mathbb{G}=\mathbb{R}^{d}$ or $\mathbb{G}=\mathbb{Z}^{d}$ and let $\mathbb{G}^{*}$ denote the dual group of $\mathbb{G}$. For every $z \in \mathbb{C}$, we set $\boldsymbol{e}(z):=e^{2 \pi i z}$, where $\boldsymbol{i}^{2}=-1$. Let $\mathcal{F}_{\mathbb{G}}$ denote the Fourier transform on $\mathbb{G}$ defined for any $f \in L^{1}(\mathbb{G})$ by

\mathcal{F}_{\mathbb{G}} f(\xi):=\int_{\mathbb{G}} f(x) \boldsymbol{e}(x \cdot \xi) \mathrm{d} \mu(x), \quad \xi \in \mathbb{G}^{*}

where $\mu$ is the usual Haar measure on $\mathbb{G}$. For any bounded function $\mathfrak{m}: \mathbb{G}^{*} \rightarrow \mathbb{C}$, we define the corresponding Fourier multiplier operator by

Here, we assume that $f: \mathbb{G} \rightarrow \mathbb{C}$ is a compactly supported function on $\mathbb{G}$ (and smooth if $\mathbb{G}=\mathbb{R}^{d}$ ) or any other function for which (2.6) makes sense.

An indispensable tool in the proof of Theorem 8 is the vector-valued Ionescu-Wainger multiplier theorem from [29, Section 2] with an improvement by Tao [39].

Theorem 9. For every $\varrho>0$, there exists a family $\left(P_{\leq N}\right)_{N \in \mathbb{N}}$ of subsets of $\mathbb{N}$ such that:
(i) $\mathbb{N}_{N} \subseteq P_{\leq N} \subseteq \mathbb{N}_{\max \left\{N, e^{N^{\varrho}}\right\}}$.
(ii) If $N_{1} \leq N_{2}$, then $P_{\leq N_{1}} \subseteq P_{\leq N_{2}}$.
(iii) If $q \in P_{\leq N}$, then all factors of $q$ also lie in $P_{\leq N}$.
(iv) $\operatorname{lcm}\left(P_{N}\right) \leq 3^{N}$.

Furthermore, for every $p \in(1, \infty)$, there exists $0<C_{p, \varrho,|\Gamma|}<\infty$ such that, for every $N \in \mathbb{N}$, the following holds:

Let $0<\varepsilon_{N} \leq e^{-N^{2} \varrho}$ and let $\mathbf{Q}:=[-1 / 2,1 / 2)^{\Gamma}$ be a unit cube. Let $\mathfrak{m}: \mathbb{R}^{\Gamma} \rightarrow L\left(H_{0}, H_{1}\right)$ be a measurable function supported on $\varepsilon_{N} \mathbf{Q}$ taking values in $L\left(H_{0}, H_{1}\right)$, the space of bounded linear operators between separable Hilbert spaces $H_{0}$ and $H_{1}$. Let $0 \leq \mathbf{A}_{p} \leq \infty$ denote the smallest constant such that

\left\|T_{\mathbb{R}^{\Gamma}}[\mathfrak{m}] f\right\|_{L^{p}\left(\mathbb{R}^{\Gamma} ; H_{1}\right)} \leq \mathbf{A}_{p}\|f\|_{L^{p}\left(\mathbb{R}^{\Gamma} ; H_{0}\right)}
$$

for every function $f \in L^{2}\left(\mathbb{R}^{\Gamma} ; H_{0}\right) \cap L^{p}\left(\mathbb{R}^{\Gamma} ; H_{0}\right)$. Then, the multiplier

\Delta_{N}(\xi):=\sum_{b \in \Sigma_{\leq N}} \mathfrak{m}(\xi-b),
$$

where $\Sigma_{\leq N}$ is defined by

\Sigma_{\leq N}:=\left\{\frac{a}{q} \in \mathbb{Q}^{\Gamma} \cap \mathbb{T}^{\Gamma}: q \in P_{\leq N} \text { and } \operatorname{gcd}(a, q)=1\right\}
$$

satisfies

$$
\begin{equation*}
\left\|T_{\mathbb{Z}^{\Gamma}}\left[\Delta_{N}\right] f\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; H_{1}\right)} \leq C_{p, \varrho,|\Gamma|}(\log N) \mathbf{A}_{p}\|f\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; H_{0}\right)} \tag{2.7}
\end{equation*}
$$

for every $f \in \ell^{p}\left(\mathbb{Z}^{\Gamma} ; H_{0}\right)$, (cf. [39, Theorem 1.4] which removes the factor of $\log N$ in the inequality (2.7) ).
2.6. Exponential sums. In this section, we present some general results concerning the behavior of exponential sums. The following proposition is an enhancement of the variant of Weyl's inequality due to Trojan [40, Theorem 2] that allows us to estimate exponential sums related to a possibly non-differentiable function $\phi$, (cf. [29, Theorem A.1]).

Proposition 10 (Weyl's inequality). [20, Proposition 6] Let $\alpha>0, k \in \mathbb{N}$, and let $\Gamma \subset \mathbb{N}^{k} \backslash\{0\}$ be a nonempty finite set. Let $\Omega^{\prime} \subseteq \Omega \subseteq B(0, N) \subset \mathbb{R}^{k}$ be convex sets and let $\phi: \Omega \cap \mathbb{Z}^{k} \rightarrow \mathbb{C}$. There is $\beta_{\alpha}>0$ such that, for any $\beta>\beta_{\alpha}$, if there is a multi-index $\gamma_{0} \in \Gamma$ with

\left|\xi_{\gamma_{0}}-\frac{a}{q}\right| \leq \frac{1}{q^{2}}
$$

for some coprime integers $a$ and $q$ with $1 \leq a \leq q$ and $(\log N)^{\beta} \leq q \leq N^{\left|\gamma_{0}\right|}(\log N)^{-\beta}$, then

\begin{aligned}
\left|\sum_{(n, p) \in \mathbb{Z}^{k^{\prime}} \times( \pm \mathbb{P})^{k^{\prime \prime}}} e(\xi \cdot \mathcal{Q}(n, p)) \phi(n, p) \mathbb{1}_{\Omega \backslash \Omega^{\prime}}(n, p)\right| \lesssim & N^{k} \log (N)^{-\alpha}\|\phi\|_{L^{\infty}\left(\Omega \backslash \Omega^{\prime}\right)} \\
& +N^{k} \sup _{\substack{|x-y| \leq N(\log N)^{-\alpha} \\
x, y \in \Omega \backslash \Omega^{\prime}}}|\phi(x)-\phi(y)| .
\end{aligned}
$$

The implicit constant is independent of the function $\phi$, the variable $\xi$, the sets $\Omega, \Omega^{\prime}$, and the numbers a, $q$, and $N$.

The next result is a generalization of [40, Proposition 4.1] and [40, Proposition 4.2] in the spirit of [29, Proposition 4.18]. For $q \in \mathbb{N}$ and $a \in \mathbb{N}_{q}^{\Gamma}$ with $\operatorname{gcd}(a, q)=1$, the Gaussian sum related to the polynomial mapping $\mathcal{Q}$ is given by

G(a / q):=\frac{1}{q^{k^{\prime}}} \frac{1}{\varphi(q)^{k^{\prime \prime}}} \sum_{x \in \mathbb{N}_{q}^{k^{\prime}}} \sum_{y \in A_{q}^{k^{\prime \prime}}} e((a / q) \cdot \mathcal{Q}(x, y)), \tag{2.8}
\end{equation*}

where $A_{q}:=\left\{a \in \mathbb{N}_{q}: \operatorname{gdc}(a, q)=1\right\}$ and $\varphi$ is Euler's totient function. There is $\delta>0$ such that

according to 40, Theorem 3].
Proposition 11. [20, Lemma 7] Let $N \in \mathbb{N}$ and let $\Omega \subseteq B(0, N) \subset \mathbb{R}^{k}$ be a convex set or a Boolean combination of finitely many convex sets. Let $\mathcal{K}: \mathbb{R}^{k} \rightarrow \mathbb{C}$ be a continuous function supported in $\Omega$. Then, for each $\beta>0$, there is a constant $c=c_{\beta}>0$ such that, for any $q \in \mathbb{N}$ with $1 \leq q \leq(\log N)^{\beta}, a \in A_{q}$, and $\xi=a / q+\theta \in \mathbb{R}^{\Gamma}$, we have

& \left|\sum_{(n, p) \in \mathbb{Z}^{k^{\prime} \times( \pm \mathbb{P}) k^{\prime \prime}}} e(\xi \cdot \mathcal{Q}(n, p)) \mathcal{K}(n, p)\left(\prod_{i=1}^{k^{\prime \prime}} \log \left|p_{i}\right|\right)-G(a / q) \int_{\Omega} e((\xi-a / q) \cdot \mathcal{Q}(t)) \mathcal{K}(t) \mathrm{d} t\right| \\
& \lesssim\left[N^{k-1}\|\mathcal{K}\|_{L^{\infty}(\Omega)}\left(1+\sum_{\gamma \in \Gamma}\left|\theta_{\gamma}\right| N^{|\gamma|}\right)+N^{k} \sup _{\substack{x, y \in \Omega \\
|x-y| \leq q \sqrt{k}}}|\mathcal{K}(x)-\mathcal{K}(y)|\right] N \exp (-c \sqrt{\log N}) .
\end{aligned}
$$

The implied constant is independent of $N, a, q, \xi$ and the kernel $\mathcal{K}$.
2.7. Multipliers for the averaging operators. For a function $f: \mathbb{Z}^{\Gamma} \rightarrow \mathbb{C}$ with finite support, we have

A_{t}^{\mathcal{Q}, k^{\prime}, k^{\prime \prime}} f(x)=T_{\mathbb{Z}\ulcorner }\left[\mathfrak{m}_{t}\right] f(x) \quad \text { and } \quad H_{t}^{\mathcal{Q}, k^{\prime}, k^{\prime \prime}} f(x)=T_{\mathbb{Z} \Gamma}\left[\mathfrak{n}_{t}\right] f(x)
$$

for the discrete Fourier multipliers

$$
\mathfrak{m}_{t}(\xi):=\frac{1}{\vartheta_{\Omega}(t)} \sum_{(n, p) \in \mathbb{Z}^{k^{\prime} \times( \pm \mathbb{P})^{k^{\prime \prime}}}} e(\xi \cdot \mathcal{Q}(n, p)) \mathbb{1}_{\Omega_{t}}(n, p)\left(\prod_{i=1}^{k^{\prime \prime}} \log \left|p_{i}\right|\right), \quad \xi \in \mathbb{T}^{\Gamma}
$$

and

Their continuous counterparts are given by

\Phi_{t}(\xi):=\frac{1}{\left|\Omega_{t}\right|} \int_{\Omega_{t}} \boldsymbol{e}(\xi \cdot \mathcal{Q}(t)) \mathrm{d} t \quad \text { and } \quad \Psi_{t}(\xi):=\mathrm{p} . \mathrm{v} . \int_{\Omega_{t}} \boldsymbol{e}(\xi \cdot \mathcal{Q}(t)) K(t) \mathrm{d} t
$$

respectively. To present a unified approach, we write $M_{t}^{k^{\prime}, k^{\prime \prime}}, \mathfrak{y}_{t}$, and $\Theta_{t}$ to represent either $A_{t}^{\mathcal{Q}, k^{\prime}, k^{\prime \prime}}, \mathfrak{m}_{t}$, and $\Phi_{t}$ or $H_{t}^{\mathcal{Q}, k^{\prime}, k^{\prime \prime}}, \mathfrak{n}_{t}$, and $\Psi_{t}$ respectively. We now present the key properties of our multiplier operators that will be used in the proof of Theorem 8 . Let $N_{n}:=\left\lfloor 2^{n^{\tau}}\right\rfloor$ for $n \in \mathbb{N}$ and some $\tau \in(0,1]$ adjusted later. Property 1. For each $\alpha>0$, there is $\beta_{\alpha}>0$ such that, for any $\beta>\beta_{\alpha}$ and $n \in \mathbb{N}$, if there is a multi-index $\gamma_{0} \in \Gamma$ with

\left|\xi_{\gamma_{0}}-\frac{a}{q}\right| \leq \frac{1}{q^{2}}
$$

for some coprime integers $a$ and $q$ with $1 \leq a \leq q$ and $\left(\log N_{n}\right)^{\beta} \leq q \leq N_{n}^{\left|\gamma_{0}\right|}\left(\log N_{n}\right)^{-\beta}$, then

$$
\left|\left(\mathfrak{y}_{N_{n}}-\mathfrak{y}_{N_{n-1}}\right)(\xi)\right| \lesssim C\left(\log N_{n}\right)^{-\alpha}
$$

This follows from Proposition 10 with $\phi(x) \equiv\left(\vartheta_{\Omega}\left(N_{n}\right)\right)^{-1}$ for the $\mathfrak{y}_{t}=\mathfrak{m}_{t}$ case and with $\phi(x)=K(x)$ for the $\mathfrak{y}_{t}=\mathfrak{n}_{t}$ case, noting the size condition (1.4) and the continuity condition (1.6).
Property 2. Let $A$ be the $|\Gamma| \times|\Gamma|$ diagonal matrix with

\end{equation*}

For any $t>0$, we set $t^{A} v:=\left(t^{|\gamma|} v_{\gamma}: \gamma \in \Gamma\right)$. Then

\left|\Theta_{N_{n}}(\xi)-\Theta_{N_{n-1}}(\xi)\right| \lesssim \min \left\{\left|N_{n}^{A} \xi\right|_{\infty},\left|N_{n}^{A} \xi\right|_{\infty}^{-1 /|\Gamma|}\right\}, \quad \text { for each } n \in \mathbb{N}
$$

In the $\Theta_{t}=\Phi_{t}$ case, this follows from the mean value theorem and the standard van der Corput lemma. In the $\Theta_{t}=\Psi_{t}$ case, this follows from the cancellation condition (1.5) and [28, Proposition B.2] (see [28, p. 21] for details).

Property 3. For each $\alpha>0, n \in \mathbb{N}$, and $\xi \in \mathbb{T}^{\Gamma}$ satisfying

with $1 \leq q \leq L, a \in A_{q}^{\Gamma}$, and $1 \leq L \leq \exp \left(c \sqrt{\log N_{n}}\right)\left(\log N_{n}\right)^{-\alpha}$, we have

\mathfrak{y}_{N_{n}}(\xi)-\mathfrak{y}_{N_{n-1}}(\xi)=G(a / q)\left(\Theta_{N_{n}}(\xi-a / q)-\Theta_{N_{n-1}}(\xi-a / q)\right)+\mathcal{O}\left(\left(\log N_{n}\right)^{-\alpha}\right)
$$

for some constant $c>0$ which is independent of $n, \xi, a$ and $q$.
In the $\mathfrak{y}_{t}=\mathfrak{m}_{t}, \Theta_{t}=\Phi_{t}$ case, this is [40, Property 6]. In the $\mathfrak{y}_{t}=\mathfrak{n}_{t}, \Theta_{t}=\Psi_{t}$ case, this follows from Property 1 alongside Lemma 11 with $\Omega:=\Omega_{N_{n}} \backslash \Omega_{N_{n-1}}$ and $\mathcal{K}(n, p):=K(n, p) \mathbb{1}_{\Omega}$, noting the size condition (1.4) and the continuity condition (1.6). For details see [40, Lemmas 3 and 5].
2.8. Parameters discussion. Let $p \in(1, \infty)$ be fixed and let $\chi \in(0,1 / 10)$. Fix $\tau$ with $0<\tau<$ $1-\min (2, p)^{-1}$ and let $N_{n}:=\left\lfloor 2^{n^{\tau}}\right\rfloor$ for $n \in \mathbb{N}$. If $p \in(1,2)$, fix $p_{0}$ such that $1<p_{0}<p$. If instead $p \in(2, \infty)$, fix $p_{0}>p$. If $p=2$, the discussion is moot since all the interpolation arguments in the article become unnecessary. We choose $\rho$ with

$$
\rho>\frac{1}{\tau} \frac{p p_{0}-2 p}{2 p_{0}-2 p}
$$

so that interpolation of the estimates

$$
\|T\|_{\ell^{2}} \lesssim n^{-\rho \tau} \quad \text { and } \quad\|T\|_{\ell^{p_{0}}} \lesssim 1
$$

yields

$$
\|T\|_{\ell^{p}} \lesssim n^{-(1+\varepsilon)} \text { for some } \varepsilon>0
$$

Property 1 gives us a corresponding $\beta_{\rho}$. We fix a choice of $\beta>\beta_{\rho}$ and then fix a choice of $u \in \mathbb{N}$ with $u>|\Gamma| \beta$. We also have the value of $\delta$ coming from the Gaussian sum estimate (2.9). With these fixed, we choose the value of $\varrho$ in Theorem 9 to be

## 3. Proof of Theorem 8

By the monotone convergence theorem and standard density arguments, it is enough to prove that

\sup _{t \in \mathbb{I}}\left|M_{t}^{k^{\prime}, k^{\prime \prime}} f_{\mathrm{i}}\right| \leq \sup _{t \in \mathbb{I}}\left|\left(M_{t}^{k^{\prime}, k^{\prime \prime}}-M_{t_{0}}^{k^{\prime}, k^{\prime \prime}}\right) f_{\mathrm{i}}\right|+\left|M_{t_{0}}^{k^{\prime}, k^{\prime \prime}} f_{\mathrm{i}}\right|
$$

so,

\left\|\sup _{t \in \mathbb{I}} \mid M_{t}^{k^{\prime}, k^{\prime \prime}} f_{\mathrm{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \lesssim \mathcal{S}_{\mathbb{Z}^{\Gamma}}^{p}\left(M_{t}^{k^{\prime}, k^{\prime \prime}} f_{\mathrm{i}}: t \in \mathbb{I}\right)+\left\|M_{\inf \mathbb{I}}^{k^{\prime}, k^{\prime \prime}} f_{\mathrm{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)}
$$

Thus, it suffices to show that

\mathcal{S}_{\mathbb{Z}^{\Gamma}}^{p}\left(M_{t}^{k^{\prime}, k^{\prime \prime}} f_{\mathrm{i}}: t \in \mathbb{I}\right) \lesssim\left\|f_{\mathrm{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} .

We start by splitting (cf. [17, Lemma 1.3], [25, Lemma 8.1]) into long and short suprema along the subexponential sequence $N_{n}$. Letting $\mathbb{I}_{n}:=\left[N_{n}, N_{n+1}\right) \cap \mathbb{I}$, we have

$$

3.1. Short suprema. Let $s_{n, 0}<s_{n, 1}<\ldots<s_{s, J(n)}$ be the increasing enumeration of [ $N_{n}, N_{n+1}$ ] $\cap \mathbb{I}$ and let $r=\min (2, p)$. Monotonicity of $\ell^{p}$ norms, Minkowski's inequality, and the triangle inequality give

\left\|\left(\sum_{n \in \mathbb{N}_{0}} \sup _{t \in \mathbb{I}_{n}}\left|\left(M_{t}^{k^{\prime}, k^{\prime \prime}}-M_{\inf }^{k^{\prime}, \mathbb{I}_{n}^{\prime \prime}}\right) f_{\mathrm{i}}\right|^{2}\right)^{1 / 2}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \leq\left(\sum_{n \in \mathbb{N}_{0}}\left(\sum_{j=1}^{J(n)}\left\|\left(M_{s_{n, j}}^{k^{\prime}, k^{\prime \prime}}-M_{s_{n}, j-1}^{k^{\prime}, k^{\prime \prime}}\right) f_{\mathrm{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)}\right)^{r}\right)^{1 / r} \tag{3.1}
\end{equation*}
$$

Since

$$
\left\|\left(M_{s_{n, j}}^{k^{\prime}, k^{\prime \prime}}-M_{s_{n, j-1}}^{k^{\prime}, k^{\prime \prime}}\right) f\right\|_{\ell \ell^{p}\left(\mathbb{Z}^{\Gamma}\right)} \leq\left\|\check{\mathfrak{y}}_{s_{n, j}}-\check{\mathfrak{y}}_{s_{n, j-1}}\right\|_{\ell^{1}\left(\mathbb{Z}^{\Gamma}\right)}\|f\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma}\right)}
$$

by Young's convolution inequality, (2.3) gives

\left\|\left(M_{s_{n, j}}^{k^{\prime}, k^{\prime \prime}}-M_{s_{n, j-1}}^{k^{\prime}, k^{\prime \prime}}\right) f_{\mathrm{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \leq\left\|\check{\mathfrak{y}}_{s_{n, j}}-\check{\mathfrak{y}}_{s_{n, j-1}}\right\|_{\ell^{1}\left(\mathbb{Z}^{\Gamma}\right)}\left\|f_{\mathfrak{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} .
$$

Therefore, we control the right hand side of (3.1) by

\left(\sum_{n \in \mathbb{N}_{0}}\left(\left\|\sum_{j=1}^{J(n)}\left|\check{\mathfrak{y}}_{s_{n, j}}-\check{\mathfrak{y}}_{s_{n, j-1}}\right|\right\|_{\ell^{1}\left(\mathbb{Z}^{\Gamma}\right)}\right)^{r}\right)^{1 / r}\left\|f_{\mathrm{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \lesssim\left(\sum_{n \in \mathbb{N}_{0}}\left(n^{-r(1-\tau)}\right)^{1 / r}\left\|f_{\mathrm{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \lesssim\left\|f_{\mathrm{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} .\right.
$$

The last estimates follow from [20, eq. 4.2] with $f=\delta_{0}$ and the discussion thereafter.
3.2. Long suprema and the circle method. Let $\eta: \mathbb{R}^{\Gamma} \rightarrow[0,1]$ be a smooth function with

where $A$ is the matrix given in (2.10) and Id is the $|\Gamma| \times|\Gamma|$ identity matrix. For dyadic integers $s \in 2^{u \mathbb{N}}$, we define the annuli sets of fractions by

\Sigma_{s}:= \begin{cases}\Sigma_{\leq s} & \text { if } s=2^{u},  \tag{3.2}\\ \Sigma_{\leq s} \backslash \Sigma_{\leq s / 2^{u}} & \text { if } s>2^{u},\end{cases}
$$

where the $\Sigma_{\leq}$. are the sets of Ionescu-Wainger fractions as in Theorem 9 . For $t \geq 2^{u}$, we set $F(t):=$ $\max \left\{s \in 2^{u \mathbb{N}^{-}}: s \leq t\right\}$. We define

\mathcal{S}_{\mathbb{Z}^{\Gamma}}^{p}\left(\sum_{j=1}^{n} T_{\mathbb{Z}^{\Gamma}}\left[\left(\mathfrak{y}_{N_{j}}-\mathfrak{y}_{N_{j-1}}\right) \Xi_{\left.\leq j^{\tau u}\right]}\right] f_{\mathfrak{i}}: n \in \mathbb{N}\right)+\mathcal{S}_{\mathbb{Z}^{\Gamma}}^{p}\left(\sum_{j=1}^{n} T_{\mathbb{Z}^{\Gamma}}\left[\left(\mathfrak{y}_{N_{j}}-\mathfrak{y}_{N_{j-1}}\right)\left(1-\Xi_{\leq j^{\tau u}}\right)\right] f_{\mathfrak{i}}: n \in \mathbb{N}\right) .
$$

These terms correspond to major and minor arcs respectively.
3.3. Minor arcs. Monotonicity of $\ell^{p}$ norms, telescoping, and the triangle inequality give

\mathcal{S}_{\mathbb{Z}^{\Gamma}}^{p}\left(\sum _ { j = 1 } ^ { n } T _ { \mathbb { Z } ^ { \Gamma } } \left[( \mathfrak { y } _ { N _ { j } } - \mathfrak { y } _ { N _ { j - 1 } } ) \left(1-\Xi_{\left.\left.\left.\leq j^{\tau u}\right)\right] f_{\mathfrak{i}}: n \in \mathbb{N}\right) \leq \sum_{n=1}^{\infty}\left\|T_{\mathbb{Z}^{\Gamma}}\left[\left(\mathfrak{y}_{N_{n}}-\mathfrak{y}_{N_{n-1}}\right)\left(1-\Xi_{\leq n^{\tau u}}\right)\right] f_{i}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} . . . . . . . .}\right.\right.\right.
$$

It then suffices to show that

$$
\left\|T_{\mathbb{Z}^{\Gamma}}\left[\left(\mathfrak{y}_{N_{n}}-\mathfrak{y}_{N_{n-1}}\right)\left(1-\Xi_{\leq n^{\tau u}}\right)\right] f_{\mathrm{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \lesssim n^{-(1+\varepsilon)}\left\|f_{\mathrm{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)}
$$

for some $\varepsilon>0$. This follows from

\| T_{\mathbb{Z}^{\Gamma}}\left[( \mathfrak { y } _ { N _ { n } } - \mathfrak { y } _ { N _ { n - 1 } } ) \left(1-\Xi_{\left.\left.\leq n^{\tau u}\right)\right] f}\left\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma}\right)} \lesssim n^{-(1+\varepsilon)}\right\| f \|_{\ell^{p}\left(\mathbb{Z}^{\Gamma}\right)}\right.\right.
$$

by (2.3). This uses Property 1 and follows from the proof of [40, Eqs. (5.8), (5.9)] with only small changes due to our differing scaling in the definition of $\eta_{N}(\xi)$. We omit the details.
3.4. Introduction to major arcs. Using the annuli multipliers (3.3) and the triangle inequality, we bound the major arcs term by

\mathcal{S}_{\mathbb{Z} \Gamma}^{p}\left(\sum_{j=1}^{n} \sum_{\substack{s \in 2^{u \mathbb{N}} \\ s \leq j^{\tau u}}} T_{\mathbb{Z}^{\Gamma}}\left[\left(\mathfrak{y}_{N_{j}}-\mathfrak{y}_{N_{j-1}}\right) \Xi_{j}^{s}\right] f_{\mathfrak{i}}: n \in \mathbb{N}\right) \leq \sum_{s \in 2^{u \mathbb{N}}} \mathcal{S}_{\mathbb{Z}^{\Gamma}}^{p}\left(\sum_{\substack{1 \leq j \leq n \\ j \geq s^{1 /(\tau u)}}} T_{\mathbb{Z}^{\Gamma}}\left[\left(\mathfrak{y}_{N_{j}}-\mathfrak{y}_{N_{j-1}}\right) \Xi_{j}^{s}\right] f_{\mathfrak{i}}: n \geq s^{1 / \tau u}\right)
$$

It then suffices to show for large $s \in 2^{u \mathbb{N}}$ that

\begin{equation*}
\mathcal{S}_{\mathbb{Z}^{\Gamma}}^{p}\left(\sum_{\substack{1 \leq j \leq n \\ j \geq s^{1 /(\tau u)}}} T_{\mathbb{Z}^{\Gamma}}\left[\left(\mathfrak{y}_{N_{j}}-\mathfrak{y}_{N_{j-1}}\right) \Xi_{j}^{s}\right] f_{\mathfrak{i}}: n \geq s^{1 / \tau u}\right) \lesssim s^{-\varepsilon}\left\|f_{\mathfrak{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \tag{3.4}
\end{equation*}
$$

for some $\varepsilon>0$ since $\sum_{s \in 2^{u \mathbb{N}}} s^{-\varepsilon}<\infty$. Let $\kappa_{s}:=s^{2\lfloor\varrho\rfloor}$. By splitting the left hand side of (3.4) at $n \approx 2^{\kappa_{s}}$ into small and large scales, it suffices to prove that

\end{equation*}

and

\begin{equation*}
\mathcal{S}_{\mathbb{Z}^{\Gamma}}^{p}\left(\sum_{\substack{1 \leq j \leq n \\ j \geq 2^{\kappa_{s} / \tau}}} T_{\mathbb{Z}^{\Gamma}}\left[\left(\mathfrak{y}_{N_{j}}-\mathfrak{y}_{N_{j-1}}\right) \Xi_{j}^{s}\right] f_{\mathfrak{i}}: n^{\tau}>2^{\kappa_{s}}\right) \lesssim s^{-\varepsilon}\left\|f_{\mathfrak{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \tag{3.6}
\end{equation*}
$$

For the small scales (3.5), we will use the Rademacher-Menshov inequality (2.1) and Theorem 9 . For the large scales (3.6), we will use the Magyar-Stein-Wainger sampling principle from [19, Proposition 2.1] and its counterpart for the jump inequality from [27, Theorem 1.7]. We first recall an approximation lemma to replace our discrete multipliers with continuous counterparts. Let

\end{equation*}

Lemma 12. [20, Lemma 8] Let $M \in \mathbb{N}, \alpha^{\prime}>0$, and $S_{M}:=\left\lfloor 2^{M^{\tau}-3 M^{\tau \chi}}\right\rfloor$. For $j \in \mathbb{N}$ with $s^{1 /(\tau u)} \leq j$ and $M \leq j \leq 2 M$, we have

\left\|\left(\mathfrak{y}_{N_{j}}-\mathfrak{y}_{N_{j-1}}\right) \Xi_{j}^{s}-\Lambda_{j}^{s} \mathfrak{m}_{S_{M}}\right\|_{\ell \infty\left(\mathbb{T}^{\Gamma}\right)} \lesssim j^{-\alpha^{\prime} \tau} \tag{3.10}
\end{equation*}
$$

3.5. Small scales. Splitting $\left[s^{1 / u}, 2^{\kappa_{s}+1}\right]$ into dyadic intervals and preparing via the triangle inequality to use (3.10), we bound the left hand side of (3.5) by

$$
\begin{array}{r}
\overbrace{\sum_{M \in 2^{\mathbb{N}} \cap\left[s^{1 / u}, 2^{\kappa s}\right]} \mathcal{S}_{\mathbb{Z}^{\Gamma}}^{p}\left(\sum_{\substack{1 \leq j \leq n \\
j \geq s^{1 /(\tau u)}}} T_{\mathbb{Z}^{\Gamma}}\left[\Lambda_{j}^{s} \mathfrak{m}_{S_{M}}\right] f_{\mathfrak{i}}: n^{\tau} \in[M, 2 M]\right)}^{\sum_{M \in 2^{\mathbb{N}} \cap\left[s^{1 / u}, 2^{\kappa s}\right]} \mathcal{S}_{\mathbb{Z}^{\Gamma}}^{p}(\underbrace{}_{\substack{1 \leq j \leq n \\
j \geq s^{1 /(\tau u)}}} T_{\mathbb{Z}^{\Gamma}}\left[\left(\mathfrak{y}_{N_{j}}-\mathfrak{y}_{N_{j-1}}\right) \Xi_{j}^{s}-\Lambda_{j}^{s} \mathfrak{m}_{S_{M}}\right] f_{\mathfrak{i}}: n^{\tau} \in[M, 2 M])}
\end{array} .
$$

For Error Term 1, it will suffice to show that

$$
\left\|T_{\mathbb{Z}^{\Gamma}}\left[\left(\mathfrak{y}_{N_{n}}-\mathfrak{y}_{N_{n-1}}\right) \Xi_{n}^{s}-\Lambda_{n}^{s} \mathfrak{m}_{S_{M}}\right] f_{i}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \lesssim n^{-\left(1+\varepsilon^{\prime}\right)}\left\|f_{i}\right\|_{\ell p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)
$$

for some $\varepsilon^{\prime}>0$ since we would then bound it by

$$
\sum_{n \geq s^{1 /(\tau u)}} n^{-\left(1+\varepsilon^{\prime}\right)}\left\|f_{\mathfrak{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \lesssim s^{-\varepsilon^{\prime} /(\tau u)}\left\|f_{\mathfrak{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \lesssim s^{-\varepsilon}\left\|f_{\mathfrak{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)}
$$

This follows from

$$
\left\|T_{\mathbb{Z}^{\Gamma}}\left[\left(\mathfrak{y}_{N_{n}}-\mathfrak{y}_{N_{n-1}}\right) \Xi_{n}^{s}-\Lambda_{n}^{s} \mathfrak{m}_{S_{M}}\right] f\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma}\right)} \lesssim n^{-\left(1+\varepsilon^{\prime}\right)}\|f\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma}\right)}
$$

by (2.3), and that is [20, Eq. 4.12].
For Main Term 1, we apply the Rademacher-Menshov inequality (2.1) to bound it by

$$
\sum_{M \in 2^{\mathbb{N}} \cap\left[s^{1 / u}, 2^{\kappa s}\right]} \sum_{i=0}^{\log _{2}(2 M)}\left\|\left(\sum_{j}\left|\sum_{k \in I_{i, j}^{M}} T_{\mathbb{Z}^{\Gamma}}\left[\Lambda_{k}^{s} \mathfrak{m}_{S_{M}}\right] f_{\mathfrak{i}}\right|^{2}\right)^{1 / 2}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)}
$$

where $j$ is taken over $j \geq 0$ such that $I_{i, j}^{M}:=\left[j 2^{i},(j+1) 2^{i}\right] \cap\left[M^{1 / \tau},(2 M)^{1 / \tau}\right] \neq \emptyset$. Let $\tilde{\eta}_{N}(\xi):=\eta_{N}(\xi / 2)$. Then $\tilde{\eta}_{N} \eta_{k^{\tau}}=\eta_{k^{\tau}}$ for $k^{\tau} \geq N$ due to the nesting supports. This lets us write

$$
\Lambda_{k}^{s} \mathfrak{m}_{S_{M}}=\Lambda_{k}^{s} \mathfrak{m}_{S_{M}} \sum_{a / q \in \Sigma_{s}} \tilde{\eta}_{M}(\xi-a / q)=: \Lambda_{k}^{s} \mathfrak{m}_{S_{M}} \tilde{\Xi}_{M^{1 / \tau}}^{s}
$$

for $k \in I_{i, j}^{M}$ since then $k \geq M^{1 / \tau}$.
By (2.2), it suffices to get an appropriate estimate for

$$
\left\|\sum_{j} \sum_{k \in I_{i, j}^{M}} \epsilon_{j}(\omega) T_{\mathbb{Z}^{\Gamma}}\left[\Lambda_{k}^{s} \mathfrak{m}_{S_{M}}\right] f\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma}\right)}
$$

for any Rademacher sequence $\epsilon=\left(\epsilon_{j}(\omega)\right)$ with $\epsilon_{j}(\omega) \in\{-1,1\}$ and for every $\omega \in[0,1]$.
We get the appropriate bound on $\ell^{p}\left(\mathbb{Z}^{\Gamma}\right)$ by the Ionescu-Wainger theorem and the bound for the continuous analogue

$$
\left\|\sum_{j} \sum_{k \in I_{i, j}^{M}} \epsilon_{j}(\omega) T_{\mathbb{Z}^{\Gamma}}\left[\left(\Theta_{N_{j}}-\Theta_{N_{j-1}}\right) \eta_{j}^{\tau}\right] g\right\|_{L^{p}\left(\mathbb{R}^{\Gamma}\right)} \lesssim\|g\|_{L^{p}\left(\mathbb{R}^{\Gamma}\right)}
$$

with a bound independent of the Rademacher sequence $\epsilon$, see [38, Chapter XI] or [9]. Therefore,

$$
\begin{equation*}
\left\|\sum_{j} \sum_{k \in I_{i, j}^{M}} \epsilon_{j}(\omega) T_{\mathbb{Z}^{\Gamma}}\left[\Lambda_{k}^{s} \mathfrak{m}_{S_{M}}\right] f\right\|_{\ell^{p_{0}}\left(\mathbb{Z}^{\Gamma}\right)} \lesssim\left\|T_{\mathbb{Z}^{\Gamma}}\left[\mathfrak{m}_{S_{M}}\right] f\right\|_{\ell^{p_{0}}\left(\mathbb{Z}^{\Gamma}\right)} \lesssim\|f\|_{\ell^{p_{0}}\left(\mathbb{Z}^{\Gamma}\right)} \tag{3.11}
\end{equation*}
$$

using the uniform $\ell^{p}$-boundedness of the averaging operators.
We get an improved bound on $\ell^{2}$. To do this, we use that

$$
\left\|\mathfrak{m}_{S_{M}} \tilde{\Xi}_{M^{1 / \tau}}^{s}\right\|_{\ell^{\infty}\left(\mathbb{T}^{\Gamma}\right)} \lesssim s^{-\delta}
$$

for $M \in 2^{\mathbb{N}} \cap\left[s^{1 / u}, 2^{\kappa_{s}}\right]$, see [20, Section 4.5]. Then

$$
\begin{equation*}
\left\|\sum_{j} \sum_{k \in I_{i, j}^{M}} \epsilon_{j}(\omega) T_{\mathbb{Z}^{\Gamma}}\left[\Lambda_{k}^{s} \mathfrak{m}_{S_{M}}\right] f\right\|_{\ell^{2}\left(\mathbb{Z}^{\Gamma}\right)} \lesssim\left\|T_{\mathbb{Z}^{\Gamma}}\left[\mathfrak{m}_{S_{M}} \tilde{\Xi}_{M_{1 / \tau}}^{s}\right] f\right\|_{\ell^{2}\left(\mathbb{Z}^{\Gamma}\right)} \lesssim s^{-\delta}\|f\|_{\ell^{2}\left(\mathbb{Z}^{\Gamma}\right)} \tag{3.12}
\end{equation*}
$$

Interpolation of (3.11) with (3.12) then gives that

$$
\left\|\sum_{j} \sum_{k \in I_{i, j}^{M}} \epsilon_{j}(\omega) T_{\mathbb{Z}^{\Gamma}}\left[\Lambda_{k}^{s} \mathfrak{m}_{S_{M}}\right] f\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma}\right)} \lesssim s^{-8 \varrho}\|f\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma}\right)}
$$

since $8 \varrho \leq \delta /(\rho \tau)$. We then apply (2.2)

$$
\left\|\left(\sum_{j}\left|\sum_{k \in I_{i, j}^{M}} T_{\mathbb{Z}^{\Gamma}}\left[\Lambda_{k}^{s} \mathfrak{m}_{S_{M}}\right] f_{\mathfrak{i}}\right|^{2}\right)^{1 / 2}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \lesssim\left\|f_{\mathfrak{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)}
$$

Thus, we may dominate Main Term 1 by

$$
\sum_{M \in 2^{\mathbb{N}} \cap\left[s^{1 / u}, 2^{\kappa s}\right]} \sum_{i=0}^{\log _{2}(2 M)} s^{-8 \varrho}\left\|f_{\mathfrak{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \lesssim \kappa_{s}^{2} s^{-8 \varrho}\left\|f_{\mathfrak{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \lesssim s^{-4 \varrho}\left\|f_{\mathfrak{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)}
$$

since $\kappa_{s} \leq s^{2 \varrho}$, concluding the proof of (3.5).
3.6. Large scales. We bound the left hand side of (3.6) by

$$
\overbrace{\mathcal{S}_{\mathbb{Z} \Gamma}^{p}\left(\sum_{\substack{1 \leq j \leq n \\ j \geq 2^{\kappa_{s} / \tau}}} T_{\mathbb{Z}^{\Gamma}}\left[v_{j}^{s}\right] f_{\mathfrak{i}}: n^{\tau}>2^{\kappa_{s}}\right)}^{\text {Main }}+\overbrace{\sum_{n \geq 2^{\kappa_{s} / \tau}}\left\|T_{\mathbb{Z}^{\Gamma}}\left[\left(\mathfrak{y}_{N_{n}}-\mathfrak{y}_{N_{n-1}}\right) \Xi_{n}^{s}-v_{n}^{s}\right] f_{\mathfrak{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)}}^{\text {Term 2 }}
$$

For Error Term 2, it will suffice to show that

$$
\left\|T_{\mathbb{Z}^{\Gamma}}\left[\left(\mathfrak{\eta}_{N_{n}}-\mathfrak{y}_{N_{n-1}}\right) \Xi_{n}^{s}-v_{n}^{s}\right] f_{i}\right\|_{e_{p}\left(\mathbb{Z}^{\Gamma} ; 2^{2}\right)} \lesssim e^{(\Gamma \mid+1) s^{e}} n^{-\left(1+\varepsilon^{\prime}\right)}\left\|f_{i}\right\|_{e_{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)}
$$

for some $\varepsilon^{\prime}>0$ since we would then bound it by

$$
e^{(|\Gamma|+1) s^{\varrho}} \sum_{n \geq 2^{\kappa_{s} / \tau}} n^{-\left(1+\varepsilon^{\prime}\right)}\left\|f_{\mathfrak{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \lesssim e^{(|\Gamma|+1) s^{\varrho}} 2^{-s^{2 \varrho} \varepsilon^{\prime} / \tau}\left\|f_{\mathfrak{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \lesssim s^{-\varepsilon}\left\|f_{\mathfrak{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)}
$$

This follows from

$$
\left\|T_{\mathbb{Z}^{\Gamma}}\left[\left(\mathfrak{y}_{N_{n}}-\mathfrak{y}_{N_{n-1}}\right) \Xi_{n}^{s}-v_{n}^{s}\right] f\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma}\right)} \lesssim e^{(|\Gamma|+1) s^{\varrho}} n^{-\left(1+\varepsilon^{\prime}\right)}\|f\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma}\right)}
$$

by (2.3), and that is [20, Eq. 4.15].
For Main Term 2, we define

$$
w^{s}(\xi):=\sum_{a / q \in \Sigma_{s}} G(a / q) \tilde{\eta}_{2^{\kappa_{s}}}(\xi-a / q), \quad \Pi^{s}(\xi):=\sum_{a / q \in \Sigma_{s}} \tilde{\eta}_{2^{\kappa_{s}}}(\xi-a / q)
$$

and

$$
\omega_{n}^{s}(\xi):=\sum_{2^{\kappa_{s} / \tau} \leq j \leq n}\left(\Theta_{N_{j}}-\Theta_{N_{j-1}}\right)(\xi) \eta_{j^{\tau}}(\xi)
$$

Let $Q_{s}:=\operatorname{lcm}\left(q: a / q \in \Sigma_{s}\right)$. By property (iv) from Theorem 9, we have $Q_{s} \leq 3^{s}$. The function $\omega_{n}^{s}$ is supported on $\left[-\frac{1}{4 Q_{s}}, \frac{1}{4 Q_{s}}\right]$ for large $s \in 2^{u \mathbb{N}}$ since, on the support of $\eta_{2^{\kappa_{s}}}$, we have $\left|\xi_{\gamma}\right| \leq 2^{-2^{-\kappa_{s}}+2^{\kappa_{s} \chi}} \leq$ $\left(4 Q_{s}\right)^{-1}$ for all $\gamma \in \Gamma$ and large $s$. We also have

$$
\sum_{2^{\kappa_{s} / \tau} \leq j \leq n} v_{j}^{s}(\xi)=w^{s}(\xi) \sum_{b \in \mathbb{Z}^{\Gamma}} \omega_{n}^{s}\left(\xi-b / Q_{s}\right)
$$

Therefore, it suffices to prove

$$
\begin{equation*}
\mathcal{S}_{\mathbb{Z}^{\Gamma}}^{p}\left(T_{\mathbb{Z}^{\Gamma}}\left[\sum_{b \in \mathbb{Z}^{\Gamma}} \omega_{n}^{s}\left(\cdot-b / Q_{s}\right)\right] f_{\mathfrak{i}}: n^{\tau}>2^{\kappa_{s}}\right) \lesssim\left\|f_{\mathfrak{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \tag{3.13}
\end{equation*}
$$

and

$$
\begin{equation*}
\left\|T_{\mathbb{Z}^{\Gamma}}\left[w^{s}\right] f_{\mathfrak{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \lesssim s^{-\varepsilon}\left\|f_{\mathfrak{i}}\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma} ; \ell^{2}\right)} \tag{3.14}
\end{equation*}
$$

for some $\varepsilon>0$. (3.14) follows from

$$
\left\|T_{\mathbb{Z}^{\Gamma}}\left[w^{s}\right] f\right\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma}\right)} \lesssim s^{-\varepsilon}\|f\|_{\ell^{p}\left(\mathbb{Z}^{\Gamma}\right)}
$$

by (2.3), and that is [20, Eq. 4.17].
By the Magyar-Stein-Wainger sampling principle [19, Proposition 2.1] for the supremum seminorm, (3.13) follows from

$$
\begin{equation*}
\mathcal{S}_{\mathbb{R}^{\Gamma}}^{p}\left(T_{\mathbb{R}^{\Gamma}}\left[\omega_{n}^{s}\right] f_{\mathrm{i}}: n^{\tau}>2^{\kappa_{s}}\right) \lesssim\left\|f_{i}\right\|_{L^{p}\left(\mathbb{R}^{\Gamma} ; \ell^{2}\right)} . \tag{3.15}
\end{equation*}
$$

To prove (3.15), we use that the $\omega_{n}^{s}$ functions are almost telescoping. We define

$$
\Delta_{n}^{s}(\xi):=\sum_{2^{\kappa_{s} / \tau} \leq j \leq n}\left(\Theta_{N_{j}}-\Theta_{N_{j-1}}\right)(\xi)=\left(\Theta_{N_{n}}-\Theta_{N_{2^{\kappa_{s} / \tau-1}}}\right)(\xi) .
$$

Then (3.15) follows from

$$
\begin{equation*}
\mathcal{S}_{\mathbb{R}^{\Gamma}}^{p}\left(T_{\mathbb{R}^{\Gamma}}\left[\Delta_{n}^{s}\right] f_{i}: n^{\tau}>2^{\kappa_{s}}\right) \lesssim\left\|f_{i}\right\|_{L^{p}\left(\mathbb{R}^{\Gamma} ; \ell^{2}\right)} \tag{3.16}
\end{equation*}
$$

since the error term is bounded by

$$
\sum_{n>2^{\kappa s} / \tau}\left\|T_{\mathbb{R}^{\Gamma}}\left[\left(\Theta_{N_{n}}-\Theta_{N_{n-1}}\right)\left(\eta_{n^{\tau}}-1\right)\right] f_{i}\right\|_{L^{p}\left(\mathbb{R}^{\Gamma} ; \ell^{2}\right)} \lesssim\left\|f_{\mathrm{i}}\right\|_{L^{p}\left(\mathbb{R}^{\Gamma} ; \ell^{2}\right)}
$$

This last estimate follows from

$$
\sum_{n>2^{\kappa_{s} / \tau}}\left\|T_{\mathbb{R}^{\Gamma}}\left[\left(\Theta_{N_{n}}-\Theta_{N_{n-1}}\right)\left(\eta_{n^{\tau}}-1\right)\right] f\right\|_{L^{p}\left(\mathbb{R}^{\Gamma}\right)} \lesssim\|f\|_{L^{p}\left(\mathbb{R}^{\Gamma}\right)}
$$

by (2.3), and this follows from Property 2 and interpolation. (3.16) itself follows from

$$
\mathcal{S}_{\mathbb{R}^{\Gamma}}^{p}\left(T_{\mathbb{R}^{\Gamma}}\left[\Theta_{t}\right] f: t>0\right) \lesssim\|f\|_{L^{p}\left(\mathbb{R}^{\Gamma}\right)}
$$

and this follows from [24, Appendix A].
