# VARIOUS TOPOLOGICAL COMPLEXITIES OF SMALL COVERS AND REAL BOTT MANIFOLDS

#### Abstract

In this paper, we compute the LS-category and equivariant LS-category of a small cover and its real moment angle manifold. We calculate a tight lower bound for the topological complexity of many small covers over a product of simplices. Then we compute symmetric topological complexity of several small covers over a product of simplices. We calculate the LS one-category of real Bott manifolds and infinitely many small covers.


## 1. Introduction

The topological complexity of a space is a numerical homotopy invariant introduced by Michael Farber in [Far03], which connects motion planning problems in robotics. Briefly, given a mechanical system $\mathcal{M}$, a motion planning algorithm for $\mathcal{M}$ is a function that associates to any pair of states $(a, b)$ of $\mathcal{M}$ to a continuous motion of the system starting at $a$ and ending at $b$. Interestingly, the topological complexity is a particular case of another homotopy invariant called the 'sectional category' of a map $p: E \rightarrow B$ where $E$ and $B$ are path connected spaces. The sectional category of $p$, denoted by secat $(p)$, is the least integer $k$ such that there is an open cover $\left\{U_{1}, \ldots, U_{k}\right\}$ of $B$, and there is a local section $s_{i}: U_{i} \rightarrow E$ of $p$ for each $i$ satisfying $p \circ s_{i}=i d_{U_{i}}: U_{i} \hookrightarrow B$ where $i d_{U_{i}}$ denotes the inclusion. We remark that the genus of a fibration was introduced by Schwarz Šva58. However, James Jam78 used 'sectional category' instead of 'genus'.

Let $Y$ be the space of all possible configurations of a mechanical system. We assume that $Y$ is a Hausdorff path-connected topological space. Let $P Y$ be the space of all continuous paths $\gamma:[0,1] \rightarrow Y$ in $Y$ equipped with the compact-open topology. Consider the path fibration

\pi: P Y \rightarrow Y \times Y \tag{1.1}
\end{equation*}
$$

defined by $\pi(\gamma)=(\gamma(0), \gamma(1))$. A motion planning algorithm of $Y$ is defined by a section $s: Y \times Y \rightarrow P Y$ of the fibration $\pi$. This section exists if and only if $Y$ is contractible. Interestingly in general, almost all configuration spaces are non-contractible. To compute the complexity of motion-planning algorithm for a non-contractible space $Y$, Farber defined the topological complexity of $Y$ by the sectional category of $\pi$. The survey [Far08] contains several introductory results related to motion planning.

A symmetric version of the topological complexity arises when one restricts the local planners for which the motion from $a$ to $b$ is the reverse of the motion from $b$ to $a$ and the motion from $a$ to $a$ is constant. In notation, consider a map $s: Y \times Y \rightarrow P Y$ (not necessarily continuous) such that $\pi \circ s=I d_{Y \times Y}$ and $s(a, a)(t)=a, s(a, b)(t)=s(b, a)(1-t)$ for all $a, b \in Y$ and $t \in[0,1]$. This motivates the notion of symmetric topological complexity, given by Farber and Grant in FG07. Some developments in symmetric topological complexity can be found in GL09, Gon11, Gra19.

[^0]Consider a continuous partial section $s: U \rightarrow P Y$ of the fibration $\pi$ over an open subset $U \subseteq Y \times Y$. The map $s$ can be described as a homotopy $h: U \times[0,1] \rightarrow Y$ defined by $h(u, t)=s(u)(t)$ for $u \in U, t \in[0,1]$. Let $p_{1}: Y \times Y \rightarrow Y$ and $p_{2}: Y \times Y \rightarrow Y$ denote the projections onto the first and the second factor, respectively. Since $s$ is a section, the homotopy $h$ connects $h(u, 0)=p_{1}(u)$ and $h(u, 1)=p_{2}(u)$. Therefore the open sets $U_{i} \subseteq Y \times Y$, which appear in the definition of topological complexity, can be equivalently characterized by the property that their two projections $U_{i} \rightarrow Y$ on the first and the second factors are homotopic. For an aspherical space $Y$, a connected subspace $U$ of $Y$ which is homotopy equivalent to a cell complex, the set of homotopy classes of maps $U \rightarrow Y$ is in a one-to-one correspondence with the set of conjugacy classes of homomorphisms $\pi_{1}\left(U, u_{0}\right) \rightarrow \pi_{1}\left(Y, y_{0}\right)$. Using this idea, Farber, Grant, Lupton, and Oprea introduced $\mathbf{T C}^{\mathcal{D}}(Y)$, the $\mathcal{D}$-topological complexity for a path-connected topological space, see [FGLO19a]. Here the letter ' $\mathcal{D}$ ' in the notation $\mathbf{T C}^{\mathcal{D}}(Y)$ stands for the 'diagonal'. In FGLO19b], Farber, Grant, Lupton, and Oprea introduced some properties of $\mathcal{D}$-topological complexity. Note that symmetric topological complexity is not homotopy invariant but $\mathcal{D}$-topological complexity is homotopy invariant. Some related results can be found in Dra15.

A small cover of dimension $n$ is an $n$-dimensional closed smooth manifold with a locally standard $\mathbb{Z}_{2}^{n}$-action whose orbit space is a simple polytope. It was introduced in the pioneering paper DJ91 as a generalization of real projective toric varieties. An $n$-dimensional toric variety is an algebraic normal variety that admits an action of $\left(\mathbb{C}^{*}\right)^{n}$ with an open dense orbit. A non-singular complete toric variety is simply called a toric manifold. The real locus of a toric manifold is called a real toric manifold. A real Bott tower is a sequence of smooth complete real toric varieties, see Subsection [2.2. In this paper, we compute lower and upper bounds for the topological complexity, symmetric topological complexity, and LS one-category of a class of small covers and real Bott manifolds.

The paper is organized as follows. In Section 2, we study the definition of small cover over a simple polytope, generalized real Bott manifold, and the relation between them. We modify the cohomology ring of a small cover over a product of simplices $\prod_{j=1}^{m} \Delta^{n_{j}}$ with $\mathbb{Z}_{2}$ coefficients as $\mathbb{Z}_{2}\left[y_{1}, y_{2}, \ldots, y_{m}\right] / I$ where $I$ is given in (2.14). We prove $y_{j}^{n_{j}} \neq 0$ in the cohomology ring $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$ as in (2.13), see Lemma [2.6. We also recall the notion of real moment angle manifolds and complexes.

In Section 3, we recall the definition and some properties of LS-category and equivariant LS-category of a topological space. We compute the LS-category and equivariant LScategory of a small cover. We calculate the LS-category of the real moment angle manifold for $r$-gon and the equivariant LS-category of a real moment angle complex.

In Section [4, we give a tight lower bounds to the topological complexity of a small cover over a product of two simplices. We compute the topological complexity for some classes of real Bott manifolds.
In Section [5, we rewrite the definition and some basic properties of symmetric topological complexity and give bounds for the symmetric topological complexity of several small covers over a product of simplices.

Finally in Section 6, we recall the definition and some basic properties of the LS onecategory and $\mathcal{D}$-topological complexity. We calculate the exact value of LS one-category of a simple polytope when its real moment angle manifold is simply connected and orientable. We calculate LS one-category of a small cover over a product of simplices, and give bounds of $\mathcal{D}$-topological complexity for a small cover over a product of simplices.

## 2. Cohomology rings of small covers, generalized real Bott manifolds, AND REAL MOMENT ANGLE COMPLEXES

In this section, we recall simple polytopes and the constructive definition of a small cover over a simple polytope using [DJ91]. If the polytope is a product of finitely many
simplices, then the small cover is known as a generalized real Bott manifold. We give a presentation of the cohomology ring of a generalized real Bott manifold. Later, we study real moment angle manifolds and complexes.
2.1. Small covers and its cohomology ring. In this subsection, we recall the definition of small cover and its cohomology ring with $\mathbb{Z}_{2}$-coefficients following [DJ91].

A convex polytope is a convex hull of finitely many points in $\mathbb{R}^{n}$ for some $n \in \mathbb{Z}_{\geq 0}$. The face of dimension 0 and $(n-1)$ in a convex polytope of dimension $n$ are called the vertex and the facet of the polytope, respectively. The vertex set and the facet set of a convex polytope $P$ are denoted by $V(P)$ and $\mathcal{F}(P)$, respectively. An $n$-dimensional convex polytope is called simple if at each vertex exactly $n$ many facets intersect. Throughout this paper, we denote an $n$-dimensional simple polytope by $P$.

Definition 2.1. A function $\lambda: \mathcal{F}(P) \rightarrow \mathbb{Z}_{2}^{n}$ is called a characteristic function if the submodule of $\mathbb{Z}_{2}^{n}$ generated by $\left\{\lambda\left(F_{i_{1}}\right), \ldots, \lambda\left(F_{i_{\ell}}\right)\right\}$ is an $\ell$-dimensional direct summand of $\mathbb{Z}_{2}^{n}$ whenever $F_{i_{1}} \cap \cdots \cap F_{i_{\ell}} \neq \emptyset$. The vector $\lambda_{i}:=\lambda\left(F_{i}\right)$ is called the characteristic vector associated with the facet $F_{i}$ for $i=1, \ldots, r$, and the pair $(P, \lambda)$ is called a characteristic pair.

We recall the construction of a small cover from a characteristic pair $(P, \lambda)$. For each point $p \in P$, let $F(p)$ be the unique face of $P$, which contains $p$ in its relative interior. Let $F(p)=F_{i_{1}} \cap \cdots \cap F_{i_{k}}$ for some unique facets $F_{i_{1}}, \ldots, F_{i_{k}}$. Define $G_{F(p)}$ as a subgroup of $\mathbb{Z}_{2}^{n}$ generated by $\lambda\left(F_{i_{1}}\right), \ldots, \lambda\left(F_{i_{k}}\right)$. We define an equivalence relation on $P \times \mathbb{Z}_{2}^{n}$ as follows:

$$
(p, g) \backsim(q, h) \Leftrightarrow p=q, g^{-1} h \in G_{F(p)}
$$

The identification space $M^{n}(P, \lambda):=\left(P \times \mathbb{Z}_{2}^{n}\right) / \sim$ has an $n$-dimensional manifold structure with a natural $\mathbb{Z}_{2}^{n}$-action induced by the group operation on the second factor of $P \times \mathbb{Z}_{2}^{n}$. The projection onto the first factor gives the orbit map

$$
\rho: M^{n}(P, \lambda) \rightarrow P \text { defined by }[p, g]_{\sim} \mapsto p
$$

where $[p, g]_{\sim}$ is the equivalence class of $(p, g)$. The manifold $M^{n}(P, \lambda)$ is called a small cover over $P$ with the characteristic function $\lambda$, see DJ91 for details.

Let $\left\{F_{1}, \ldots, F_{r}\right\}$ be the facets of $P$ and the indeterminates $v_{1}, \ldots, v_{r}$ correspond bijectively to the facets $F_{1}, \ldots, F_{r}$ respectively.

Proposition 2.2. DJ91, Theorem 4.14] Let $\rho: M^{n}(P, \lambda) \rightarrow P$ be a small cover over a simple polytope $P$ with $|\mathcal{F}(P)|=r$. Then

$$
H^{*}\left(M^{n}(P, \lambda), \mathbb{Z}_{2}\right) \cong \mathbb{Z}_{2}\left[v_{1}, \ldots, v_{r}\right] /(\tilde{I}+\tilde{J})
$$

where the ideal $\tilde{I}$ is generated by the monomials $v_{s_{1}} \cdots v_{s_{\ell}}$, if $F_{s_{1}} \cap \cdots \cap F_{s_{\ell}}=\emptyset$, and the ideal $\tilde{J}$ is generated by the $n$ coordinates of the vector $\Lambda_{\tilde{J}}$ where $\Lambda_{\tilde{J}}=\sum_{i=1}^{r} \lambda_{i} v_{i}$.
Example 2.3. The $n$-dimensional real projective space $\mathbb{R} \mathbb{P}^{n}$ is an example of a small cover over the $n$-dimensional simplex $\Delta^{n}$. A finite product of $\mathbb{R} \mathbb{P}^{n}$ 's is also a small cover.
2.2. Generalized real Bott manifolds and its cohomology ring. In this subsection, we study generalized real Bott manifolds and give a nice presentation of its cohomology ring with $\mathbb{Z}_{2}$-coefficients.

A generalized real Bott tower of height $m$ is a sequence

$$
\begin{equation*}
B_{m} \xrightarrow{\pi_{m}} B_{m-1} \xrightarrow{\pi_{m-1}} \cdots \xrightarrow{\pi_{2}} B_{1} \xrightarrow{\pi_{1}} B_{0}=\{\mathrm{pt}\} \tag{2.1}
\end{equation*}
$$

of manifolds $B_{j}=\mathbb{P}\left(\underline{\mathbb{R}} \oplus E_{j}^{(1)} \oplus \cdots \oplus E_{j}^{\left(n_{j}\right)}\right)$, where $\underline{\mathbb{R}}$ is the trivial line bundle over $B_{j-1}$, $E_{j}^{(i)}$ is a real line bundle over $B_{j-1}$ for $i=1, \ldots, n_{j}$, and $j=1, \ldots, m$. Here $\mathbb{P}($.$) denotes$ the projectivization. The space $B_{j}$ is called a $j$-th stage generalized real Bott manifold. In this case, when $n_{j}=1$ for every $j, B_{j}$ is called a real Bott manifold.

Proposition 2.4. KL16, Corollary 4.6] The $j$-th stage generalized real Bott manifold $B_{j}$ of the tower (2.1) is a small cover over $\prod_{i=1}^{j} \Delta^{n_{i}}$ where $\Delta^{n_{i}}$ is the $n_{i}$-simplex.

The converse statement also holds by the following proposition.
Proposition 2.5. DU19, Proposition 2.7] Every small cover over a product of simplices is a generalized real Bott manifold.

Now we discuss the cohomology ring of a small cover over a finite product of simplices. Let

$$
\begin{equation*}
P:=\prod_{j=1}^{m} \Delta^{n_{j}} \tag{2.2}
\end{equation*}
$$

where $\Delta^{n_{j}}$ is a simplex of dimension $n_{j}$. Then, the dimension of $P$ is $n:=\sum_{j=1}^{m} n_{j}$. Let

$$
\begin{equation*}
\mathcal{N}_{s}:=\sum_{j=1}^{s} n_{j} \tag{2.3}
\end{equation*}
$$

for $s=1, \ldots, m$. Thus $\mathcal{N}_{1}=n_{1}$ and $\mathcal{N}_{m}=n$. Let us assume $\mathcal{N}_{0}:=0$.
Let $V\left(\Delta^{n_{j}}\right):=\left\{v_{0}^{j}, \ldots, v_{n_{j}}^{j}\right\}$ be the vertices of $\Delta^{n_{j}}$ for $j=1, \ldots, m$. Then the vertex set of $P$ is given by

\begin{equation*}
V(P):=\left\{v_{\ell_{1} \ell_{2} \ldots \ell_{m}}:=\left(v_{\ell_{1}}^{1}, v_{\ell_{2}}^{2}, \ldots, v_{\ell_{m}}^{m}\right) \mid 0 \leq \ell_{j} \leq n_{j}\right\} \tag{2.4}
\end{equation*}
$$

Let $\mathcal{F}\left(\Delta^{n_{j}}\right):=\left\{F_{0}^{\Delta_{j}}, \ldots, F_{n_{j}}^{\Delta_{j}}\right\}$ be the facets of $\Delta^{n_{j}}$ where the facet $F_{k_{j}}^{\Delta_{j}}$ does not contain the vertex $v_{k_{j}}^{j}$ for $j=1, \ldots, m$. So, the facet set of $P$ is

$$
\begin{equation*}
\mathcal{F}(P):=\left\{F_{k_{j}}^{j} \mid 0 \leq k_{j} \leq n_{j}, j=1, \ldots, m\right\}, \tag{2.5}
\end{equation*}
$$

where $F_{k_{j}}^{j}:=\Delta^{n_{1}} \times \cdots \times \Delta^{n_{j-1}} \times F_{k_{j}}^{\Delta_{j}} \times \Delta^{n_{j+1}} \times \cdots \times \Delta^{n_{m}}$. Observe that the vertex $v_{\ell_{1} \ell_{2} \ldots \ell_{m}}$ is the unique intersection of the $n$-many facets of $\mathcal{F}(P) \backslash\left\{F_{\ell_{j}}^{j} \mid j=1, \ldots, m\right\}$. In particular,

\begin{equation*}
v_{0 \ldots 0}=F_{1}^{1} \cap \cdots \cap F_{n_{1}}^{1} \cap \cdots \cap F_{1}^{m} \cap \cdots \cap F_{n_{m}}^{m} . \tag{2.6}
\end{equation*}
$$

Let

$$
\begin{equation*}
\lambda: \mathcal{F}(P) \rightarrow \mathbb{Z}_{2}^{n} \tag{2.7}
\end{equation*}
$$

be a $\mathbb{Z}_{2}$-characteristic function on $P$ where $P$ is the product of simplices as in (2.2). Then from (2.6), we have $\left\{\lambda\left(F_{1}^{1}\right), \ldots, \lambda\left(F_{n_{1}}^{1}\right), \ldots, \lambda\left(F_{1}^{m}\right), \ldots, \lambda\left(F_{n_{m}}^{m}\right)\right\}$ is a basis of $\mathbb{Z}_{2}^{n}$ over $\mathbb{Z}_{2}$. So, we may assume that these vectors are assigned with the standard basis vectors. Thus,

$$
\lambda\left(F_{1}^{j}\right)=e_{\mathcal{N}_{j-1}+1}, \ldots, \lambda\left(F_{n_{j}}^{j}\right)=\boldsymbol{e}_{\mathcal{N}_{j}}
$$

for $j=1, \ldots, m$. The remaining $m$ facets $\left\{F_{0}^{1}, \ldots, F_{0}^{m}\right\}$ are assigned with the vectors as follows

\lambda\left(F_{0}^{j}\right):=\boldsymbol{\alpha}_{\boldsymbol{j}} \in \mathbb{Z}_{2}^{n} \text { for } j=1, \ldots, m \tag{2.8}
\end{equation*}
$$

so that the above assignment satisfies Definition 2.1. This gives us vector matrices of order $(1 \times m)$ and $(m \times m)$, and a scalar matrix of order $(n \times m)$ as following:

\boldsymbol{\alpha}_{\mathbf{1}} & \boldsymbol{\alpha}_{\mathbf{2}} & \ldots & \boldsymbol{\alpha}_{\boldsymbol{m}}

\boldsymbol{\alpha}_{1}^{\mathbf{1}} & \ldots & \boldsymbol{\alpha}_{\boldsymbol{m}}^{\mathbf{1}} \\
\vdots & \ldots & \vdots \\
\boldsymbol{\alpha}_{1}^{\boldsymbol{m}} & \ldots & \boldsymbol{\alpha}_{\boldsymbol{m}}^{\boldsymbol{m}}
\end{array}\right)_{m \times m}=\left(\begin{array}{ccc}
\alpha_{11}^{1} & \ldots & \alpha_{m 1}^{1} \\
\vdots & \ldots & \vdots \\
\alpha_{1 n_{1}}^{1} & \cdots & \alpha_{m n_{1}}^{1} \\
\vdots & \ldots & \vdots \\
\alpha_{11}^{m} & \cdots & \alpha_{m 1}^{m} \\
\vdots & \cdots & \vdots \\
\alpha_{1 n_{m}}^{m} & \cdots & \alpha_{m n_{m}}^{m}
\end{array}\right)_{n \times m},

where $\boldsymbol{\alpha}_{\boldsymbol{j}} \in \mathbb{Z}_{2}^{n}$ is the $j$-th column vector of $A, \boldsymbol{\alpha}_{\boldsymbol{j}}^{\boldsymbol{k}} \in \mathbb{Z}_{2}^{n_{k}}$ is the $(k, j)$-th entry of the $m \times m$ vector matrix and $\alpha_{j i}^{k} \in \mathbb{Z}_{2}$ is the $\left(\mathcal{N}_{k-1}+i, j\right)$-th entry of the $n \times m$ scalar matrix. Throughout this paper, the vectors $\boldsymbol{e}_{\boldsymbol{i}}$ and $\boldsymbol{\alpha}_{\boldsymbol{j}}$ of $\mathbb{Z}_{2}^{n}$ are considered as the column entries of the matrices for $i=1, \ldots, n$, and $j=1, \ldots, m$.

Now we calculate the cohomology ring of the small cover $M^{n}(P, \lambda)$ when $P$ is a product of simplices as in (2.2) and the characteristic function $\lambda$ on $P$ is given by (2.7). Let us assign the indeterminate $x_{i}$ to the facet $F_{k_{j}}^{j}$ where

$$
i=\left(\sum_{s=1}^{j-1} n_{s}\right)+k_{j}=\mathcal{N}_{j-1}+k_{j}
$$

for $1 \leq k_{j} \leq n_{j}, j=1, \ldots, m$. Therefore $i \in\{1, \ldots, n\}$. We also assign the indeterminate $x_{i}$ to the facet $F_{0}^{j}$ where $i=n+j$ for $j=1, \ldots, m$. Note that $F_{1}^{j} \cap \cdots \cap F_{n_{j}}^{j} \cap F_{0}^{j}=\emptyset$. Then, from Proposition 2.2, we have

H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right) \cong \mathbb{Z}_{2}\left[x_{1}, \ldots, x_{n+m}\right] / \tilde{I}+\tilde{J} \tag{2.9}
\end{equation*}
$$

where the ideals $\tilde{I}$ and $\tilde{J}$ are as follows. The ideal $\tilde{I}$ is given by

$$
\begin{equation*}
\tilde{I}=\left\langle\left\{x_{\mathcal{N}_{j-1}+1} x_{\mathcal{N}_{j-1}+2} \ldots x_{\mathcal{N}_{j}} x_{n+j} \mid j=1, \ldots, m\right\}\right\rangle \tag{2.10}
\end{equation*}
$$

where $\mathcal{N}_{j}$ is defined in (2.3). The ideal $\tilde{J}$ is generated by the coordinates of

\Lambda_{\tilde{J}}=\left(\begin{array}{llll}
\lambda\left(F_{1}\right)^{t} & \lambda\left(F_{2}\right)^{t} & \ldots & \lambda\left(F_{n+m}\right)^{t}
\end{array}\right)_{(n \times(n+m))} \cdot\left(\begin{array}{llll}
x_{1} & x_{2} & \ldots & x_{n+m} \tag{2.11}
\end{array}\right)_{(n+m) \times 1}^{t}
$$

In (2.11); for $i=1, \ldots, n$, we denote $F_{i}=F_{k_{j}}^{j}$ with $i=\mathcal{N}_{j-1}+k_{j}$ for $1 \leq k_{j} \leq n_{j}, j=1, \ldots, m$ and for $i=n+1, \ldots, n+m$, we denote $F_{i}=F_{0}^{j}$ with $i=n+j$ where $j=1, \ldots, m$.

Note that $\Lambda_{\tilde{J}}$ is an $n$ tuple. The $i$-th coordinate of $\Lambda_{\tilde{J}}$ is

x_{i}+\alpha_{1 k_{j}}^{j} x_{n+1}+\alpha_{2 k_{j}}^{j} x_{n+2}+\cdots+\alpha_{m k_{j}}^{j} x_{n+m}
$$

where $i=\mathcal{N}_{j-1}+k_{j} ; k_{j}=1, \ldots, n_{j}$ and $j=1, \ldots, m$. Thus any $x_{i}$ can be written as a $\mathbb{Z}_{2}$-linear combination of $x_{n+1}, \ldots, x_{n+m}$ for $i=1, \ldots, n$. For simplicity, we denote the indeterminate $x_{n+j}$ by $y_{j}$ for $j=1, \ldots, m$. Thus,

x_{i}=\sum_{\ell=1}^{m} \alpha_{\ell k_{j}}^{j} y_{\ell} \text { where } i=\mathcal{N}_{j-1}+k_{j}, k_{j}=1, \ldots, n_{j} \text { and } j=1, \ldots, m \tag{2.12}
\end{equation*}

in $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$. Then the generators of the ideal $\tilde{I}$ in (2.10) can be described in terms of $y_{j}$ 's. Therefore, we have

$$
\begin{gather*}
H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right) \cong \mathbb{Z}_{2}\left[y_{1}, y_{2}, \ldots, y_{m}\right] / I, \text { where }  \tag{2.13}\\
I=\left\langle\left\{\prod_{k_{j}=1}^{n_{j}}\left(\sum_{\ell=1}^{m} \alpha_{\ell k_{j}}^{j} y_{\ell}\right) y_{j} \mid j=1, \ldots, m\right\}\right\rangle \tag{2.14}
\end{gather*}
$$

We have the following observation on the cohomology ring.

Lemma 2.6. Let $M^{n}(P, \lambda)$ be a small cover over a finite product of simplices with the characteristic function $\lambda$ as in (2.7). Then, for $j \in\{1, \ldots, m\}, y_{j}^{n_{j}} \neq 0$ in the cohomology ring $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$ as in (2.13).

Proof. Let $P:=\prod_{j=1}^{m} \Delta^{n_{j}}$ be a product of $m$ simplices. We know the cohomology ring of a small cover over a product of simplices from (2.13). The function $\lambda$ determines the following $m \times m$ vector matrix $A$.

A:=\left(\begin{array}{cccc}
\alpha_{1}^{1} & \alpha_{2}^{1} & \ldots & \alpha_{m}^{1} \\
\alpha_{1}^{2} & \alpha_{2}^{2} & \ldots & \alpha_{m}^{2} \\
\vdots & \vdots & \ldots & \vdots \\
\alpha_{1}^{m} & \alpha_{2}^{m} & \ldots & \alpha_{m}^{m}
\end{array}\right)_{m \times m}
$$

Therefore, by the arguments in [CMS10, Proposition 5.1], $A$ is conjugate to a unipotent lower triangular vector matrix of the following form:

\tilde{A}:=\left(\begin{array}{cccc}
\mathbf{1} & \mathbf{0} & \ldots & \mathbf{0}  \tag{2.15}\\
\boldsymbol{\beta}_{1}^{2} & \mathbf{1} & \ldots & \mathbf{0} \\
\vdots & \vdots & \ldots & \vdots \\
\boldsymbol{\beta}_{\mathbf{1}}^{m} & \boldsymbol{\beta}_{\mathbf{2}}^{m} & \ldots & \mathbf{1}
\end{array}\right)_{m \times m}
$$

where $\boldsymbol{\beta}_{\boldsymbol{j}}^{\boldsymbol{k}}=\left(\beta_{j 1}^{k}, \beta_{j 2}^{k}, \ldots, \beta_{j n_{k}}^{k}\right)^{t} \in \mathbb{Z}_{2}^{n_{k}}$ and $\mathbf{1}=(1, \ldots, 1)^{t} \in \mathbb{Z}_{2}^{n_{k}}$ for $k=1, \ldots, m$. The matrix $\tilde{A}$ is called the Bott matrix. Thus the ideal $\tilde{J}$ is generated by the coordinates of the following matrix.

1 & 0 & \cdots & 0 & 1 & 0 & \cdots & 0 & \cdots & \cdots & 0 & 0 \\
0 & 1 & \cdots & 0 & 1 & 0 & \cdots & 0 & \cdots & \cdots & 0 & 0 \\
\vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots & \ddots & \ddots & \vdots & \vdots \\
0 & 0 & \cdots & 1 & 1 & 0 & \cdots & 0 & \cdots & \cdots & 0 & 0 \\
0 & 0 & \cdots & 0 & \beta_{11}^{2} & 1 & \cdots & 1 & \cdots & \cdots & 0 & 0 \\
\vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots & \ddots & \ddots & \vdots & \vdots \\
0 & 0 & \cdots & 0 & \beta_{1 n_{2}}^{2} & 0 & \cdots & 1 & \cdots & \cdots & 0 & 0 \\
\vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots & \ddots & \ddots & \vdots & \vdots \\
\vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots & \ddots & \ddots & \vdots & \vdots \\
0 & 0 & \cdots & 0 & \beta_{11}^{m} & 0 & \cdots & \beta_{21}^{m} & \cdots & \cdots & 0 & 1 \\
\vdots & \vdots & \ddots & \vdots & \vdots & \vdots & \ddots & \vdots & \ddots & \ddots & \vdots & \vdots \\
0 & 0 & \cdots & 0 & \beta_{1 n_{m}}^{m} & 0 & \cdots & \beta_{2 n_{m}}^{m} & \cdots & \cdots & 1 & 1
\end{array}\right)_{n \times(n+m)} \quad\left(\begin{array}{c}
x_{1} \\
x_{2} \\
\vdots \\
x_{\mathcal{N}_{1}} \\
y_{1} \\
x_{\mathcal{N}_{1}+1} \\
\vdots \\
y_{2} \\
\vdots \\
y_{m}
\end{array}\right)
$$

Let $\alpha_{j}:=x_{\mathcal{N}_{j-1}+1} x_{\mathcal{N}_{j-1}+2} \cdots x_{\mathcal{N}_{j}} y_{j}$ for $j=1, \ldots, m$. Here $\alpha_{j}$ 's are generators of the ideal $I$ in (2.13). From the above matrix multiplication, the first $n_{1}$ elements are $x_{1}+y_{1}=0, x_{2}+y_{1}=0, \ldots$, $x_{\mathcal{N}_{1}}+y_{1}=0$. Therefore we get $x_{1}=x_{2}=\cdots=x_{\mathcal{N}_{1}}=y_{1}$.
So,

$$
\alpha_{1}=x_{1} x_{2} \cdots x_{n_{1}} y_{1}=y_{1}^{n_{1}+1}
$$

We have the following using (2.12).

$$
\begin{aligned}
\alpha_{j} & =x_{\mathcal{N}_{j-1}+1} x_{\mathcal{N}_{j-1}+2} \cdots x_{\mathcal{N}_{j}} y_{j} \\
& =\left(y_{j}+\beta_{11}^{j} y_{1}+\beta_{21}^{j} y_{2}+\cdots+\beta_{(j-1) 1}^{j} y_{j-1}\right)\left(y_{j}+\beta_{12}^{j} y_{1}+\beta_{22}^{j} y_{2}+\right. \\
& \left.\cdots+\beta_{(j-1) 2}^{j} y_{j-1}\right) \cdots\left(y_{j}+\beta_{1 n_{j}}^{j} y_{1}+\beta_{2 n_{j}}^{j} y_{2}+\cdots+\beta_{(j-1) n_{j}}^{j} y_{j-1}\right) y_{j}
\end{aligned}
$$

for $j=2, \ldots, m$. Now the least power of $y_{j}$ in $\alpha_{j}$ is $n_{j}+1$. Our claim is that $y_{j}^{n_{j}} \neq 0$. If not, let $y_{j}^{n_{j}}=0$. Then $y_{j}^{n_{j}} \in I$. But the least power of $y_{j}$ which appears as a term in a polynomial in the ideal $I$ is $y_{j}^{n_{j}+1}$. This is a contradiction. Hence $y_{j}^{n_{j}} \notin I$, i.e., $y_{j}^{n_{j}} \neq 0$ in $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$ for $j=1,2, \ldots, m$.
2.3. Real moment angle manifolds and complexes. We recall the notion of real moment angle complexes. Let $r$ be a positive integer and $K$ be a simplicial complex with vertex set $[r]=\{1, \ldots, r\}$. For each simplex $\sigma \in K$, we define

\left(D^{1}, S^{0}\right)^{\sigma}=\left\{\left(x_{1}, \ldots, x_{r}\right) \in\left(D^{1}\right)^{r} \mid x_{i} \in S^{0} \text { when } i \notin \sigma\right\}
$$

Then the set

$$
\mathbb{R} \mathcal{Z}_{K}:=\bigcup_{\sigma \in K}\left(D^{1}, S^{0}\right)^{\sigma} \subseteq\left(D^{1}\right)^{r}
$$

is called the real moment angle complex of $K$. The space $\mathbb{R} \mathcal{Z}_{K}$ has a natural $\mathbb{Z}_{2}^{r}$-action induced from the $\mathbb{Z}_{2}^{r}$-action on $\left(D^{1}\right)^{r}$.

Let $P$ be a simple polytope with facets $\left\{F_{1}, \ldots, F_{r}\right\}$. Then the set

$$
K_{P}:=\left\{\sigma=\left\{i_{1}, \ldots, i_{k}\right\} \mid F_{i_{1}} \cap \cdots \cap F_{i_{k}} \neq \emptyset\right\}
$$

is a simplicial complex on $\{1, \ldots, r\}$, see [BP02, Chapter 1]. The set $K_{P}$ is called the dual of $P$, and $\mathbb{R} \mathcal{Z}_{K_{P}}$ has a manifold structure. The space $\mathbb{R} \mathcal{Z}_{K_{P}}$ is called the real moment angle manifold for $P$.

Proposition 2.7. Let $M^{n}(P, \lambda)$ be a small cover. Then there is a subgroup $\mathbb{Z}_{\lambda}$ of $\mathbb{Z}_{2}^{r}$ of rank $r-n$ such that $\mathbb{Z}_{\lambda}$ acts on $\mathbb{R} \mathcal{Z}_{K_{P}}$ freely and $\mathbb{R} \mathcal{Z}_{K_{P}} / \mathbb{Z}_{\lambda} \cong M^{n}(P, \lambda)$.

Proof. This is similar to the proof of BP02, Proposition 6.5], and [SZ22, Proposition 2.4].
We note that $\mathbb{R} \mathcal{Z}_{K_{\Delta^{n}}}=\mathbb{S}^{n}$ and $\mathbb{R} \mathcal{Z}_{K_{P_{1} \times P_{2}}}=\mathbb{R} \mathcal{Z}_{K_{P_{1}}} \times \mathbb{R} \mathcal{Z}_{K_{P_{2}}}$. Let $M^{n}(P, \lambda)$ be a small cover over an $n$-dimensional polytope $\prod_{j=1}^{m} \Delta^{n_{j}}$ for $j=1, \ldots, m$. Then, the number of facets of $\prod_{j=1}^{m} \Delta^{n_{j}}$ is $n+m$, and the real moment angle manifold $\mathbb{R} \mathcal{Z}_{K_{P}}$ is $\prod_{j=1}^{m} \mathbb{S}^{n_{j}}$. By Proposition 2.7, $M^{n}(P, \lambda)$ can be realized as the orbit space of the moment angle manifold $\prod_{j=1}^{m} \mathbb{S}^{n_{j}}$ by a free $\mathbb{Z}_{2}^{m}$-action. More precisely, the action of $\mathbb{Z}_{2}^{m}$ on $\prod_{j=1}^{m} \mathbb{S}^{n_{j}}$ is given by

$$
\begin{align*}
& \left(g_{1}, g_{2}, \ldots, g_{m}\right)\left(\left(x_{0}^{1}, \ldots, x_{n_{1}}^{1}\right), \ldots,\left(x_{0}^{m}, \ldots, x_{n_{m}}^{m}\right)\right)  \tag{2.16}\\
& =\left(\left(g_{1} x_{0}^{1},\left(g_{1}^{a_{11}^{1}} \cdots g_{m}^{a_{m 1}^{1}}\right) \cdot x_{1}^{1}, \ldots,\left(g_{1}^{a_{1 n_{1}}^{1}} \cdots g_{m}^{a_{m n_{1}}^{1}}\right) \cdot x_{n_{1}}^{1}\right), \ldots,\right. \\
& \left.\left(g_{m} \cdot x_{0}^{m},\left(g_{11}^{a_{11}^{m}} \cdots g_{m}^{a_{m 1}^{m}}\right) \cdot x_{1}^{m}, \ldots,\left(g_{1}^{a_{1 n m}^{m}} \cdots g_{m}^{a_{m n}^{m}}\right) \cdot x_{n_{m}}^{m}\right)\right)
\end{align*}
$$

where $\left(g_{1}, g_{2}, \ldots, g_{m}\right) \in \mathbb{Z}_{2}^{m}$ and $\left(x_{0}^{j}, \ldots, x_{n_{j}}^{j}\right) \in \mathbb{S}^{n_{j}}$ for $j=1, \ldots, m$, see DU19, Remark 2.3]. This $\mathbb{Z}_{2}^{m}$-action on $\prod_{j=1}^{m} \mathbb{S}^{n_{j}}$ is free and one has $\prod_{j=1}^{m} \mathbb{S}^{n_{j}} / \mathbb{Z}_{2}^{m} \cong M^{n}(P, \lambda)$.

## 3. Equivariant LS-Category of small covers

In this section, we recall some basics of LS-category following CLOT03. Then, we compute the LS-category and the equivariant LS-category of a small cover over a simple polytope. Next, we compute the LS-category of the real moment angle manifold for $r$-gon and the equivariant LS-category of the real moment angle complex.

Let $G$ be a compact topological group acting continuously on a Hausdorff topological space $Y$. In this case, $Y$ is called a $G$-space. A subset $U$ of a $G$-space $Y$ is called $G$-invariant if $G U \subseteq U$. The homotopy $H: U \times I \rightarrow Y$ is called $G$-homotopy if for any $g \in G, y \in U$ and $t \in I$, we have $g H(y, t)=H(g y, t)$. A $G$-invariant open subset $U$ of $Y$ is called $G$-categorical if there exists an equivariant homotopy $H: U \times I \rightarrow Y$ such that $H_{0}$ is the inclusion, and $H_{1}: U \rightarrow Y$ has the image in a single $G$-orbit. In particular, $U$ is called categorical if $G$ is trivial. Here we denote the orbit of an element $y \in Y$ by $\mathcal{O}(y)$.
Definition 3.1. The equivariant LS-category of a $G$-space $Y$, denoted by $\operatorname{cat}_{G}(Y)$, is the least positive number of $G$-categorical invariant open sets required to cover $Y$. If no such covering exists, then $\operatorname{cat}_{G}(Y)=\infty$.

In particular, if $G$ is trivial, then $\operatorname{cat}_{G}(Y)$ is called the LS-category of $Y$, denoted by $\operatorname{cat}(Y)$.

Let $Y$ be a space and $R$ be a commutative ring. The least integer $n$ such that all $(n+1)$-fold cup products vanish in $H^{*}(Y ; R)$ is called the cup-length of $Y$ with coefficients in $R$, denoted by $\operatorname{cl}_{R}(Y)$. If no such $n$ exists, we write $\operatorname{cl}_{R}(Y)=\infty$. The cup-length gives a lower bound for LS-category, as follows:
Proposition 3.2. The cup-length of a topological space $Y$ is less than the LS-category of $Y$, i.e., $\operatorname{cl}_{R}(Y)+1 \leq \operatorname{cat}(Y)$, see [CLOT03, Proposition 1.5].
Proposition 3.3. If $Y$ is a manifold, then $\operatorname{cat}(Y) \leq \operatorname{dim}(Y)+1$, see CLOT03, Theorem 1.7].
Theorem 3.4. Let $M^{n}(P, \lambda)$ be an $n$-dimensional small cover. Then $\operatorname{cat}\left(M^{n}(P, \lambda)\right)=n+1$.
Proof. Since $P$ is a simple polytope, at each vertex, exactly $n$ many facets intersect. Let $v$ be a vertex of $P$, and $v=F_{s_{1}} \cap \cdots \cap F_{s_{n}}$ where $F_{s_{1}}, \ldots, F_{s_{n}}$ are unique $n$ facets of $P$. Let $m_{v}=\rho^{-1}(v)$ and $M_{i}=\rho^{-1}\left(F_{s_{i}}\right)$ for $i=1, \ldots, n$. Here the $\mathbb{Z}_{2}^{n}$-action on $M^{n}(P, \lambda)$ is locally standard. So, $m_{v}$ is a fixed point, and $M_{1}, \ldots, M_{n}$ intersect to $m_{v}$ transversely. Therefore the Poincare dual of $M_{i}$ represents a non-zero cohomology class in $H^{1}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$. So by definition of cup-length, $n \leq \operatorname{cl}_{\mathbb{Z}_{2}}\left(M^{n}(P, \lambda)\right)$. Therefore by Proposition 3.2, $n+1 \leq \operatorname{cat}\left(M^{n}(P, \lambda)\right)$. Also by Proposition 3.3. we have $\operatorname{cat}\left(M^{n}(P, \lambda)\right) \leq \operatorname{dim}\left(M^{n}(P, \lambda)\right)+1=n+1$. Hence $\operatorname{cat}\left(M^{n}(P, \lambda)\right)=n+1$.

We remark that the LS-category of small covers has been studied in ML21. However, it is written in Chinese. So, we write a proof.

We recall a result from BS19, which helps us to calculate the equivariant LS-category of a small cover over a simple polytope.

Proposition 3.5. BS19, Theorem 3.3] Let $Y$ be a $G$ space and $\left\{\left[\mathcal{O}\left(y_{i}\right)\right]\right\}_{i \in \mathcal{A}}$ be the collection of all minimal orbit classes in $Y$. Let

$$
Y_{i}=\bigcup_{\mathcal{O}(y) \in\left[\mathcal{O}\left(y_{i}\right)\right]} \mathcal{O}(y)
$$

Then

$$
\# \mathcal{A} \leq \sum_{i \in \mathcal{A}} \operatorname{cat}_{G}\left(Y_{i}\right) \leq \operatorname{cat}_{G}(Y)
$$

where $\# \mathcal{A}$ is the cardinality of $\mathcal{A}$.
Theorem 3.6. Let $M^{n}(P, \lambda)$ be an $n$-dimensional small cover over a simple polytope $P$ with $k$ vertices. Then $\operatorname{cat}_{\mathbb{Z}_{2}^{n}}\left(M^{n}(P, \lambda)\right)=k$.
Proof. Let $M:=M^{n}(P, \lambda)$. We know that there is a bijection between the fixed point set $M^{\mathbb{Z}_{2}^{n}}$ and $V(P)$. Since the fixed points are isolated and minimal orbits, by Proposition 3.5, we have $\operatorname{cat}_{\mathbb{Z}_{2}^{n}}(M) \geq|V(P)|$. So, it is enough to show that for any $v \in M^{\mathbb{Z}_{2}^{n}}$, there is a $\mathbb{Z}_{2}^{n}$-categorical subset $X_{v}$ of $M$ such that $M=\bigcup_{v \in M^{Z_{2}^{n}}} X_{v}$. Let $\rho: M \rightarrow P$ be the orbit map. Now for $v \in M^{\mathbb{Z}_{2}^{n}}$, let

$$
C_{v}=\bigcup_{\rho(v) \notin F} F, U_{v}=P-C_{v}, \text { and } X_{v}=\rho^{-1}\left(U_{v}\right)
$$

where $F$ is a face of $P$. Here $X_{v}$ is $\mathbb{Z}_{2}^{n}$-invariant subset of $M$. Since $U_{v}$ is a convex subset of $P$, it is contractible to $v$. So there exists a homotopy $h: U_{v} \times I \rightarrow P$ such that $h(x, 0)=x$ and $h(x, 1)=v$ for all $x \in U_{v}$ and preserves the face structure of $U_{v} \times I$. So, for any face $F$ of $U_{v}$, we have $h(x, t) \in F$ for $x \in F, t \in I$. Thus, by Proposition 1.8 of [DJ91], we can say $X_{v} \cong\left(U_{v} \times \mathbb{Z}_{2}^{n}\right) / \sim$. Therefore $h$ induces a homotopy

$$
h \times I d: U_{v} \times I \times \mathbb{Z}_{2}^{n} \rightarrow P \times \mathbb{Z}_{2}^{n}
$$

defined by $\left(x,\left(r^{\prime}, t\right)\right) \mapsto\left(h\left(x, r^{\prime}\right), t\right)$. Since for each face $F$ of $U_{v}$, we have

$$
x \in F \Rightarrow h\left(x, r^{\prime}\right) \in F, \text { for all } r^{\prime} \in I
$$

$h \times I d$ induces a homotopy $H: X_{v} \times I \rightarrow M$ with $\left([x, t], r^{\prime}\right) \mapsto\left[h\left(x, r^{\prime}\right), t\right]$. Since

$$
g H\left([x, t], r^{\prime}\right)=g\left[h\left(x, r^{\prime}\right), t\right]=\left[h\left(x, r^{\prime}\right), g t\right]=H\left([x, g t], r^{\prime}\right)=H\left(g[x, t], r^{\prime}\right)
$$

the map $H$ is a $\mathbb{Z}_{2}^{n}$-homotopy. Also $H(x, 0)=x, H(x, 1)=\rho^{-1}(v)=v$, for all $x \in X_{v}$. Thus $X_{v}$ is $\mathbb{Z}_{2}^{n}$-categorical open invariant subset of $M$. Since $\left\{X_{v} \mid v \in V(P)\right\}$ covers $M$, therefore $\operatorname{cat}_{\mathbb{Z}_{2}^{n}}(M)=|V(P)|=k$.

Proposition 3.7. Let $P$ be an $r$-gon and $\mathbb{R} \mathcal{Z}_{K_{P}}$ be a moment angle manifold. Then $\operatorname{cat}\left(\mathbb{R} \mathcal{Z}_{K_{P}}\right)=3$. Proof. We know the cohomology ring $H^{*}\left(\mathbb{R} \mathcal{Z}_{K_{P}} ; \mathbb{Z}_{2}\right)$ is generated by elements of degree only 0,1 and 2. We can get two elements of degree 1 such that their cup product is non-zero in $H^{*}\left(\mathbb{R} \mathcal{Z}_{K_{P}} ; \mathbb{Z}_{2}\right)$, see [Cai17, Section 3]. Therefore $2 \leq \operatorname{cl}_{\mathbb{Z}_{2}}\left(\mathbb{R} \mathcal{Z}_{K_{P}}\right)$. Then, we have $3 \leq \operatorname{cat}\left(\mathbb{R} \mathcal{Z}_{K_{P}}\right)$. Also $\operatorname{dim}\left(\mathbb{R} \mathcal{Z}_{K_{P}}\right)=\operatorname{dim}(P)=2$. Therefore, $\operatorname{cat}\left(\mathbb{R} \mathcal{Z}_{K_{P}}\right) \leq 3$. Hence $\operatorname{cat}\left(\mathbb{R} \mathcal{Z}_{K_{P}}\right)=3$.
Remark 3.8. Let $K$ be a triangulated $d$-sphere for $d \leq 2$ or a connected sum of joins of such spheres. If $K$ is $k$-Golod over $\mathbb{Z}_{2}$ (i.e., length $k+1$ cup products of positive degree elements in $H^{*}\left(\mathbb{R} \mathcal{Z}_{K} ; \mathbb{Z}_{2}\right)$ vanish $)$, then $k \leq \operatorname{cl}_{\mathbb{Z}_{2}}\left(\mathbb{R} \mathcal{Z}_{K}\right)$. Thus $k+1 \leq \operatorname{cat}\left(\mathbb{R} \mathcal{Z}_{K}\right)$, see BG21, Theorem 4.2].
Theorem 3.9. Let $S$ be the set of all maximal simplices of a simplicial complex $K$ on $[r]$. Then

$$
\operatorname{cat}_{\mathbb{Z}_{2}^{r}}\left(\mathbb{R} \mathcal{Z}_{K}\right)=|S| .
$$

Proof. Note that if $\tau$ is a face of $\sigma$ in $K$, then $\left(D^{1}, S^{0}\right)^{\tau} \subseteq\left(D^{1}, S^{0}\right)^{\sigma}$. So we have

$$
\mathbb{R} \mathcal{Z}_{K}=\bigcup_{\sigma \in S}\left(D^{1}, S^{0}\right)^{\sigma} \subseteq\left(D^{1}\right)^{r}
$$

The topology on $\mathbb{R} \mathcal{Z}_{K}$ is the subspace topology of $\left(D^{1}\right)^{r}$. Also, any simplex of $K$ is a face of a maximal simplex. So the set

$$
\left\{\left(D^{1}, S^{0}\right)^{\sigma} \mid \sigma \in S\right\}
$$

is an open covering for $\mathbb{R} \mathcal{Z}_{K}$. Moreover, $\left(D^{1}, S^{0}\right)^{\sigma}$ is a $\mathbb{Z}_{2}^{r}$-invariant subset which is equivariantly contractible to the orbit $\left(S^{0}\right)^{\sigma}$ in $\mathbb{R} \mathcal{Z}_{K}$ where

$$
\left(S^{0}\right)^{\sigma}=\left\{\left(x_{1}, \ldots, x_{r}\right) \in \mathbb{R} \mathcal{Z}_{K} \mid x_{i}=0 \text { if } i \in \sigma \text { and }\left|x_{i}\right|=1 \text { if } i \notin \sigma\right\}
$$

So we obtain that

$$
\operatorname{cat}_{\mathbb{Z}_{2}^{r}}\left(\mathbb{R} \mathcal{Z}_{K}\right) \leq|S|
$$

Note that the set $\left\{\left(S^{0}\right)^{\sigma} \mid \sigma \in S\right\}$ is the set of all minimal orbits of $\mathbb{R} \mathcal{Z}_{K}$ with respect to $\mathbb{Z}_{2}^{r}$-action. So, by Proposition 3.5, we have

$$
\operatorname{cat}_{\mathbb{Z}_{2}^{r}}\left(\mathbb{R} \mathcal{Z}_{K}\right) \geq|S|
$$

## 4. Topological complexity of small covers

In this section, we recall the definition of topological complexity and zero-divisors-cup-length. Next, we try to give bounds for the topological complexity of a class of small covers over a product of simplices and real Bott manifolds.

Definition 4.1. Let $Y$ be a path-connected space. The topological complexity of the motion planning in $Y$ is the least integer $k$ such that $Y \times Y$ can be covered by $k$ open subsets $U_{1}, \ldots, U_{k}$ on each of which there exists a section $s_{i}: U_{i} \rightarrow P Y$ such that $\pi \circ s_{i}$ is homotopic to the inclusion $i d_{U_{i}}$. If no such integer exists, then we set $\mathbf{T C}(Y)=\infty$.

We note that in the above definition, we consider non-normalized topological complexity. The cup product map

$$
\begin{equation*}
\cup: H^{*}(Y ; R) \otimes H^{*}(Y ; R) \rightarrow H^{*}(Y ; R) \tag{4.1}
\end{equation*}
$$

is an algebra homomorphism whose kernel is called the ideal of zero-divisors of $H^{*}(Y ; R)$. The multiplicative structure on the left in (4.1) is given by the formula $(\alpha \otimes \beta) \cdot(\gamma \otimes \delta)=(-1)^{|\beta| \cdot|\gamma|} \alpha \gamma \otimes \beta \delta$. Here $|\beta|$ and $|\gamma|$ denote the degrees of the cohomology classes $\beta$ and $\gamma$ respectively.

Definition 4.2. The zero-divisors-cup-length of $H^{*}(Y ; R)$, denoted by $\operatorname{zcl}_{R}(Y)$, is the length of the longest nontrivial product in the ideal of the zero-divisors of $H^{*}(Y ; R)$.

The following proposition gives a lower bound and an upper bound for $\mathbf{T C}(Y)$.
Proposition 4.3. Far03, Theorem $4,5,7]$ If $Y$ is a manifold, then we have

$$
\max \left\{\operatorname{cat}(Y), \operatorname{zcl}_{R}(Y)+1\right\} \leq \mathbf{T C}(Y) \leq 2 \operatorname{dim}(Y)+1
$$

Proposition 4.4. Far03, Theorem 11] For any path-connected metric spaces $Y_{1}, \ldots, Y_{m}$, we have $\mathbf{T C}\left(Y_{1} \times \cdots \times Y_{m}\right) \leq \mathbf{T C}\left(Y_{1}\right)+\cdots+\mathbf{T C}\left(Y_{m}\right)-(m-1)$.

Proposition 4.5. Let $M^{n}(P, \lambda)$ be an $n$-dimensional small cover. Then

$$
n+1 \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right) \leq 2 n+1
$$

Proof. The proof follows from Theorem 3.4 and Proposition 4.3 .
Now we calculate the topological complexity of several small covers over a product of two simplices. Consider the set $\mathcal{S}:=\left\{n \in \mathbb{N} \left\lvert\,\binom{ n}{i}\right.\right.$ is even for $\left.0<i<n\right\}$. Let $n \leq 2^{r}-1<2 n$, $n_{j} \leq 2^{r_{j}}-1<2 n_{j}$ for $j=1,2$, and $n=n_{1}+n_{2}$. Note that $\binom{2^{s}}{i}$ is even for $0<i<2^{s}$.
Theorem 4.6. Let $M^{n}(P, \lambda)$ be a small cover other than $\mathbb{R P}^{n_{1}} \times \mathbb{R}^{n_{2}}$ over $P=\Delta^{n_{1}} \times \Delta^{n_{2}}$.
(1) Let $n_{2} \in \mathcal{S}$ with $n_{2}>n_{1}$. Then $2^{r_{1}}+2^{r_{2}}-1 \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right)$.
(2) Let $n_{2} \in \mathcal{S}$ with $n_{2}$ divides $n_{1}$. Then $2^{r} \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right)$.
(3) Let $n_{2} \in \mathcal{S}+1$ with $n_{2}>n_{1}+1$. Then, $2^{r} \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right)$.
(4) Let $n_{2} \in \mathcal{S}+2$ with $n_{2}>n_{1}+2$. Then, $2^{r} \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right)$.

In particular, if $n=2^{s-1}$, then for the cases (2), (3), and (4), we have

$$
2 n \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right) \leq 2 n+1
$$

Proof. In the cohomology ring $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$ described in Proposition 2.2 the ideal $\tilde{I}$ is generated by $\alpha_{1}=x_{1} x_{2} \cdots x_{n_{1}} y_{1}$ and $\alpha_{2}=x_{n_{1}+1} x_{n_{1}+2} \cdots x_{n_{1}+n_{2}} y_{2}$. The ideal $\tilde{J}$ is generated by

$$
x_{1}=x_{2}=\cdots=x_{n_{1}}=y_{1}, \text { and } x_{n_{1}+1}=x_{n_{1}+2}=\cdots=x_{n_{1}+n_{2}}=y_{1}+y_{2}
$$

Therefore $\alpha_{1}=y_{1}^{n_{1}+1}=0$ and $y_{1}^{n_{1}} \neq 0$ in $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$. From (2.6), and the Poincare duality, we have $x_{1} \cdots x_{n_{1}} x_{n_{1}+1} \cdots x_{n_{1}+n_{2}} \neq 0$. So, $y_{1}^{n_{1}}\left(y_{1}+y_{2}\right)^{n_{2}} \neq 0$. Now,

$$
\begin{aligned}
y_{1}^{n_{1}}\left(y_{1}+y_{2}\right)^{n_{2}} & =y_{1}^{n_{1}}\left\{y_{2}^{n_{2}}+y_{1} \cdot f\left(y_{1}, y_{2}\right)\right\}\left(\text { where } f\left(y_{1}, y_{2}\right) \text { is a function of } y_{1} \text { and } y_{2}\right) \\
& =y_{1}^{n_{1}} y_{2}^{n_{2}}+y_{1}^{n_{1}+1} \cdot f\left(y_{1}, y_{2}\right) \\
& =y_{1}^{n_{1}} y_{2}^{n_{2}}\left(\text { as } y_{1}^{n_{1}+1}=0\right)
\end{aligned}
$$

Therefore we get the following:

$$
\begin{equation*}
y_{1}^{n_{1}} y_{2}^{n_{2}} \neq 0 \tag{4.2}
\end{equation*}
$$

Let $\mathfrak{a}_{j}:=1 \otimes y_{j}-y_{j} \otimes 1$ for $j=1,2$. Then $\mathfrak{a}_{j}$ is in the ideal of the zero-divisors of $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$. Let $c=2^{r}-1$, and $c_{j}=2^{r_{j}}-1$ for $j=1,2$.
(1) Let $n_{2} \in \mathcal{S}$ with $n_{2}>n_{1}$. Here,

$$
\begin{aligned}
\alpha_{2} & =\left(y_{1}+y_{2}\right)^{n_{2}} y_{2} \\
& =\left(y_{1}^{n_{2}}+y_{2}^{n_{2}}\right) y_{2}\left(\text { as }\binom{n_{2}}{i} \text { is even for } 0<i<n\right) \\
& =y_{2}^{n_{2}+1}\left(\text { as } y_{1}^{n_{2}}=0, \text { since } n_{2} \geq n_{1}+1 \text { and } y_{1}^{n_{1}+1}=0\right) .
\end{aligned}
$$

Therefore $y_{2}^{n_{2}+1}=0$. Now, for $j=1,2$,

$$
\mathfrak{a}_{j}^{c_{j}}=\left(1 \otimes y_{j}-y_{j} \otimes 1\right)^{c_{j}}=\sum_{k_{j}=0}^{c_{j}}(-1)^{c_{j}-k_{j}}\binom{c_{j}}{k_{j}}\left(y_{j}^{c_{j}-k_{j}} \otimes y_{j}^{k_{j}}\right)
$$

Now, the binomial coefficient $\binom{2^{r_{j}}-1}{i_{j}}$ is odd for all $0 \leq i_{j} \leq c_{j}$ for $j=1,2$. The binomial expansion of $\mathfrak{a}_{j}^{c_{j}}$ contains the term $\left(y_{j}^{c_{j}-n_{j}} \otimes y_{j}^{n_{j}}\right)$ which is non-zero. Now, by (4.2), $y_{1}^{n_{1}} y_{2}^{n_{2}} \neq 0$. So, $\mathfrak{a}_{1}^{c_{1}} \mathfrak{a}_{2}^{c_{2}}$ contains the term $y_{1}^{n_{1}} y_{2}^{n_{2}} \otimes\left(y_{1}^{c_{1}-n_{1}} y_{2}^{c_{2}-n_{2}}\right)$ which is non-zero and there is no other term of this form in the expression of $\mathfrak{a}_{1}^{c_{1}} \mathfrak{a}_{2}^{c_{2}}$.

Hence zero-divisors-cup-length of $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$ is greater than or equal to $c_{1}+c_{2}$. Therefore, by Proposition 4.3, we have, $2^{r_{1}}+2^{r_{2}}-1 \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right)$.
(2) Now, consider the case when $n_{2} \in \mathcal{S}$ with $n_{2}$ divides $n_{1}$. Let $n_{1}=\bar{n} n_{2}$ for some $\bar{n} \in \mathbb{Z}$. Since $\binom{n_{2}}{i}$ is even for $0<i<n_{2}$, so,

$$
\alpha_{2}=\left(y_{1}+y_{2}\right)^{n_{2}} y_{2}=\left(y_{1}^{n_{2}}+y_{2}^{n_{2}}\right) y_{2}=y_{1}^{n_{2}} y_{2}+y_{2}^{n_{2}+1} .
$$

So, $y_{2}^{n_{2}+1}=y_{1}^{n_{2}} y_{2}$ in $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$. Thus,

$$
y_{1}^{n_{1}} y_{2}^{n_{2}}=y_{1}^{\bar{n} n_{2}} y_{2}^{n_{2}}=y_{1}^{\bar{n} n_{2}} y_{2}^{\bar{n}} y_{2}^{n_{2}-\bar{n}}=y_{2}^{\bar{n} n_{2}+\bar{n}} y_{2}^{n_{2}-\bar{n}}=y_{2}^{\bar{n} n_{2}+n_{2}}=y_{2}^{n_{1}+n_{2}}=y_{2}^{n} .
$$

Now, by (4.2), $y_{1}^{n_{1}} y_{2}^{n_{2}} \neq 0$. Thus, $y_{2}^{n} \neq 0$. Now,

$$
\mathfrak{a}_{2}^{c}=\left(1 \otimes y_{2}-y_{2} \otimes 1\right)^{c}=\sum_{k=0}^{c}(-1)^{c-k}\binom{c}{k}\left(y_{2}^{c-k} \otimes y_{2}^{k}\right) .
$$

Therefore, by similar arguments as in (11), we get $2^{r} \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right)$.
(3) Let $n_{2} \in \mathcal{S}+1$ with $n_{2}>n_{1}+1$. Now,

$$
\begin{aligned}
\alpha_{2} & =\left(y_{1}+y_{2}\right)^{n_{2}} y_{2} \\
& =\left(y_{1}+y_{2}\right)^{n_{2}-1}\left(y_{1}+y_{2}\right) y_{2} \\
& =\left(y_{1}^{n_{2}-1}+y_{2}^{n_{2}-1}\right)\left(y_{1}+y_{2}\right) y_{2}\left(\text { as }\binom{n_{2}-1}{i} \text { is even for } 0<i<n_{2}-1\right) \\
& =\left(y_{1}+y_{2}\right) y_{2}^{n_{2}}\left(\text { as } y_{1}^{n_{2}-1}=0, \text { since } n_{2}-1 \geq n_{1}+1 \text { and } y_{1}^{n_{1}+1}=0\right) \\
& =y_{1} y_{2}^{n_{2}}+y_{2}^{n_{2}+1} .
\end{aligned}
$$

So, $y_{2}^{n_{2}+1}=y_{1} y_{2}^{n_{2}}$ in $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$. Thus,

$$
y_{1}^{n_{1}} y_{2}^{n_{2}}=y_{1}^{n_{1}-1}\left(y_{1} y_{2}^{n_{2}}\right)=y_{1}^{n_{1}-1} y_{2}^{n_{2}+1}=\cdots=y_{2}^{n_{1}+n_{2}}=y_{2}^{n} .
$$

Therefore, by similar arguments as in (21), we get $2^{r} \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right)$.
(4) Let $n_{2} \in \mathcal{S}+2$ with $n_{2}>n_{1}+2$. Now,

$$
\begin{aligned}
\alpha_{2} & =\left(y_{1}+y_{2}\right)^{n_{2}} y_{2} \\
& =\left(y_{1}+y_{2}\right)^{n_{2}-2}\left(y_{1}+y_{2}\right)^{2} y_{2} \\
& =\left(y_{1}^{n_{2}-2}+y_{2}^{n_{2}-2}\right)\left(y_{1}^{2}+y_{2}^{2}\right) y_{2}\left(\text { as }\binom{n_{2}-2}{i} \text { is even for } 0<i<n_{2}-2\right) \\
& =\left(y_{1}^{2}+y_{2}^{2}\right) y_{2}^{n_{2}-1}\left(\text { as } y_{1}^{n_{2}-2}=0, \text { since } n_{2}-2 \geq n_{1}+1 \text { and } y_{1}^{n_{1}+1}=0\right) \\
& =y_{1}^{2} y_{2}^{n_{2}-1}+y_{2}^{n_{2}+1} .
\end{aligned}
$$

So, $y_{2}^{n_{2}+1}=y_{1}^{2} y_{2}^{n_{2}-1}$ in $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$. Let $n_{1}$ be even. Then,

$$
y_{1}^{n_{1}} y_{2}^{n_{2}}=y_{1}^{n_{1}-2}\left(y_{1}^{2} y_{2}^{n_{2}-1}\right) y_{2}=y_{1}^{n_{1}-2} y_{2}^{n_{2}+1} y_{2}=\cdots=y_{2}^{n_{1}+n_{2}}=y_{2}^{n} .
$$

Therefore, by similar arguments as in (2), we get $2^{r} \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right)$.
Now, let $n_{1}$ be odd. Then,

$$
y_{1}^{n_{1}} y_{2}^{n_{2}}=y_{1}^{n_{1}-2}\left(y_{1}^{2} y_{2}^{n_{2}-1}\right) y_{2}=y_{1}^{n_{1}-2} y_{2}^{n_{2}+1} y_{2}=\cdots=y_{1} y_{2}^{n_{1}+n_{2}-1}=y_{1} y_{2}^{n-1}
$$

Now, by (4.2), $y_{1}^{n_{1}} y_{2}^{n_{2}} \neq 0$. Therefore $y_{1} y_{2}^{n-1} \neq 0$. So, $y_{2}^{n-1} \neq 0$. We know $n \leq 2^{r}-1<2 n$, i.e., $2^{r}-1 \leq 2 n-1$. If $2^{r}-1=2 n-1$, then $n$ is even. Since $n_{1}$ is odd, so $n_{2}$ is odd, which is not true. Therefore, $2^{r}-1 \leq 2 n-2$. Now,

$$
\mathfrak{a}_{2}^{c}=\left(1 \otimes y_{2}-y_{2} \otimes 1\right)^{c}=\sum_{k=0}^{c}(-1)^{c-k}\binom{c}{k}\left(y_{2}^{c-k} \otimes y_{2}^{k}\right) .
$$

Here, the binomial expansion of $\mathfrak{a}_{2}^{c}$ contains the term $\left(y_{2}^{c-n+1} \otimes y_{2}^{n-1}\right)$ which is non-zero, and there is no other same term in the expression of $\mathfrak{a}_{2}^{c}$. So $\mathfrak{a}_{2}^{c}$ is non-zero. Therefore, by similar arguments as in (2), we get $2^{r} \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right)$.

In particular, if $n=2^{s-1}$ then $n \leq 2^{s}-1<2 n$. Therefore, by (2), (3), and (4) we have $2^{s} \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right)$. Thus $2 n \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right) \leq 2 n+1$ for any $s \geq 1$.

Proposition 4.7. FTY03, Corollary 8.1, 8.2] If $n$ equals 1,3 or 7 , then $\mathbf{T C}\left(\mathbb{R}^{n}\right)=n+1$, and if $n$ is a power of 2 , then $\mathbf{T C}\left(\mathbb{R} \mathbb{P}^{n}\right)=2 n$.
Proposition 4.8. Let the small cover $M^{n}(P, \lambda)$ over the polytope $P=\prod_{j=1}^{m} \Delta^{n_{j}}$ is of the form $\mathbb{R}^{\mathbb{P}^{n_{1}}} \times \cdots \times \mathbb{R}^{\mathbb{P}_{m}}$.
(1) If $n_{j}=2^{s_{j}-1}$ for all $j \in\{1,2, \ldots, m\}$, then $\mathbf{T C}\left(M^{n}(P, \lambda)\right)=2^{s_{1}}+\cdots+2^{s_{m}}-(m-1)$.
(2) If $n_{j}=1,3$ or 7 for all $j \in\{1,2, \ldots, m\}$, then $\mathbf{T C}\left(M^{n}(P, \lambda)\right)=n+1$.

Proof. Here $M^{n}(P, \lambda)=\mathbb{R}^{\mathbb{P}^{n_{1}}} \times \cdots \times \mathbb{R} \mathbb{P}^{n_{m}}$. In the cohomology ring $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$, the ideal $\tilde{I}$ is generated by $\alpha_{j}=x_{\mathcal{N}_{j-1}+1} x_{\mathcal{N}_{j-1}+2} \cdots x_{\mathcal{N}_{j}} y_{j}$ for $j=1, \ldots, m$, and the ideal $\tilde{J}$ is generated by

$$
\begin{equation*}
x_{\mathcal{N}_{j-1}+1}=x_{\mathcal{N}_{j-1}+2}=\cdots=x_{\mathcal{N}_{j}}=y_{j} . \tag{4.3}
\end{equation*}
$$

Therefore, $\alpha_{j}=y_{j}^{n_{j}+1}=0$ in $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$ for $j=1, \ldots, m$. Let

$$
\mathfrak{a}_{j}:=1 \otimes y_{j}-y_{j} \otimes 1
$$

for $j=1, \ldots, m$. Then $\mathfrak{a}_{j}$ belongs to the ideal of the zero-divisors of $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$. Let $c_{j}=2^{s_{j}}-1$ for $j=1, \ldots, m$. Now, by Lemma 2.6, $y_{j}^{n_{j}} \neq 0$. From (2.6), and the Poincare duality, we have

$$
x_{1} \cdots x_{\mathcal{N}_{1}} x_{\mathcal{N}_{1}+1} \cdots x_{\mathcal{N}_{2}} x_{\mathcal{N}_{2}+1} \cdots x_{\mathcal{N}_{m-1}+1} \cdots x_{\mathcal{N}_{m}} \neq 0
$$

Using (4.3), we have, $y_{1}^{n_{1}} \cdots y_{m}^{n_{m}} \neq 0$. Therefore, by similar arguments as in Theorem 4.6(1), we have $\mathfrak{a}_{1}^{c_{1}} \mathfrak{a}_{2}^{c_{2}} \cdots \mathfrak{a}_{m}^{c_{m}} \neq 0$. Thus, $c_{1}+\cdots+c_{m}+1 \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right)$. That is

$$
2^{s_{1}}+\cdots+2^{s_{m}}-(m-1) \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right)
$$

Also, from Proposition 4.4 we have

$$
\begin{equation*}
\mathbf{T C}\left(M^{n}(P, \lambda)\right) \leq \mathbf{T C}\left(\mathbb{R} \mathbb{P}^{n_{1}}\right)+\cdots+\mathbf{T C}\left(\mathbb{R} \mathbb{P}^{n_{m}}\right)-(m-1) \tag{4.4}
\end{equation*}
$$

(1) If $n_{j}=2^{s_{j}-1}$ then $n_{j} \leq 2^{s_{j}}-1<2 n_{j}$. Now by Proposition 4.7, we have $\mathbf{T C}\left(\mathbb{R} \mathbb{P}^{n_{j}}\right)=2^{s_{j}}$. So, the right inequality can be obtained using (4.4). Hence

$$
\mathbf{T C}\left(M^{n}(P, \lambda)\right)=2^{s_{1}}+\cdots+2^{s_{m}}-(m-1)
$$

(2) If $n_{j}=1,3$ or 7 , then there exists some $s_{j}$ which satisfies $n_{j} \leq 2^{s_{j}}-1<2 n_{j}$ and $n_{j}+1=2^{s_{j}}$. So, $2^{s_{1}}+\cdots+2^{s_{m}}=n_{1}+\cdots+n_{m}+m=n+m$. Thus, we have $n+m-(m-1)=n+1 \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right)$. By Proposition4.7, we have $\mathbf{T C}\left(\mathbb{R P}^{n_{j}}\right)=n_{j}+1$. So, the right inequality can be obtained using (4.4). Hence

$$
\mathbf{T C}\left(M^{n}(P, \lambda)\right)=n+1
$$

We remark that if $M^{n}(P, \lambda)$ is not $\mathbb{R}^{P^{n_{1}}} \times \cdots \times \mathbb{R}^{P_{m}}$ then computation of $\mathbf{T C}\left(M^{n}(P, \lambda)\right)$ is a challenging problem.

We recall that the $n$-th stage real Bott manifold is a small cover $M^{n}(P, \lambda)$ over the polytope $P=\prod_{j=1}^{n} \Delta^{n_{j}}$ where $n_{j}=1$ for $j=1, \ldots, n$ and $\lambda$ be as in (2.7). In this case, the elements of the $(n \times n)$ matrix coming from (2.15) are scalars. Note that the diagonal elements of this matrix are 1 follows from the definition of $\lambda$. Since the Bott matrix is unique up to conjugation, different $\beta_{l}^{m \prime} s$ give different real Bott manifolds up to equivariant diffeomorphism. Now we calculate some lower bounds (possibly tight) of the topological complexity of the real Bott manifolds.

Theorem 4.9. For $n \geq 3$, let the elements $\beta_{k}^{k+1}$ in the Bott matrix (2.15) be 1 for $k=1, \ldots, n-1$, and the remaining elements $\beta_{l}^{m}$ be zero for $l=1, \ldots, n-2$, and $m=3, \ldots, n$. If $n \leq 2^{r}-1<2 n$, then the topological complexity of the real Bott manifold $M^{n}(P, \lambda)$ is greater than or equal to $2^{r}$. In particular, if $n=2^{s-1}$, then $2 n \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right) \leq 2 n+1$.
Proof. In the cohomology ring $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$ as in Proposition 2.2, the generators of the ideal $\tilde{I}$ are $\alpha_{j}=x_{j} y_{j}$ for $j=1, \ldots, n$, and the ideal $\tilde{J}$ is generated by the elements $x_{1}+y_{1}$ and $x_{j}+y_{j}+y_{j-1}$ for $j=2, \ldots, n$. Now for $j \in\{2, \ldots, n\}$,

\alpha_{j}=x_{j} y_{j}=\left(y_{j-1}+y_{j}\right) y_{j}=y_{j-1} y_{j}+y_{j}^{2}
$$

Our claim is that $y_{j}^{2} \neq 0$ for $j=2, \ldots, n$. For this, it is enough to show that $y_{j-1} y_{j} \neq 0$ for $j=2, \ldots, n$ as $\alpha_{j}=0$ in $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$. Note that in this case, $P=\prod_{1}^{n} \Delta^{1}$, an $n$-cube. So, the
facets corresponding to the indeterminates $x_{j}$ and $y_{j}$ don't intersect. But the facets corresponding to the indeterminates $y_{j-1}$ and $y_{j}$ intersect to an $(n-2)$-dimensional face. So $y_{j-1} y_{j}$ is non-zero in $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$. Therefore $y_{j}^{2} \neq 0$ for $j=2, \ldots, n$.

Since $P$ is an $n$-dimensional simple polytope, there is a vertex where the facets corresponding to the indeterminates $y_{1}, y_{2}, \ldots, y_{n}$ intersect. In other words, $y_{1} y_{2} \cdots y_{n} \neq 0$, by Poincare duality. From the relation $y_{j-1} y_{j}=y_{j}^{2}$ for $j=2, \ldots, n$, we have $y_{1} y_{2} \cdots y_{n}=y_{n}^{n}$. Therefore, $y_{n}^{n} \neq 0$.

Let $\mathfrak{a}_{n}:=1 \otimes y_{n}-y_{n} \otimes 1$. Then $\mathfrak{a}_{n}$ is in the ideal of the zero-divisors of $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$. Then,

\mathfrak{a}_{n}^{2^{r}-1} & =\left(1 \otimes y_{n}-y_{n} \otimes 1\right)^{2^{r}-1} \\
& =\sum_{k=0}^{2^{r}-1}(-1)^{2^{r}-1-k}\binom{2^{r}-1}{k}\left(1 \otimes y_{n}\right)^{k}\left(y_{n} \otimes 1\right)^{2^{r}-1-k} \\
& =\sum_{k=0}^{2^{r}-1}(-1)^{2^{r}-1-k}\binom{2^{r}-1}{k}\left(y_{n}^{2^{r}-1-k} \otimes y_{n}^{k}\right) .
\end{aligned}
$$

The binomial coefficients $\binom{2^{r}-1}{i}$ are odd for all $0 \leq i \leq 2^{r}-1$. The binomial expansion of $\mathfrak{a}_{n}^{2^{r}-1}$ contains the term $\left(y_{n}^{2^{r}-1-n} \otimes y_{n}^{n}\right)$ which is non-zero and there is no other term of this form in the expression of $\mathfrak{a}_{n}^{2^{r}-1}$. So $\mathfrak{a}_{n}^{2^{r}-1}$ is nonzero. Therefore zero-divisors-cup-length of $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$ is greater than or equal to $2^{r}-1$. Hence, by Proposition 4.3, we have $2^{r} \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right)$.

If $n=2^{s-1}$ then $r$ satisfies $n \leq 2^{s}-1<2 n$. Thus, $2^{s}=2 n \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right) \leq 2 n+1$.
We recall that for $n=3$, the Bott matrix is given by $\left(\begin{array}{ccc}1 & 0 & 0 \\ \beta_{1}^{2} & 1 & 0 \\ \beta_{1}^{3} & \beta_{2}^{3} & 1\end{array}\right)$. We denote the corresponding real Bott manifold $M^{3}(P, \lambda)$ by $M^{3}\left(\beta_{1}^{2}, \beta_{1}^{3}, \beta_{2}^{3}\right)$.
Theorem 4.10. $5 \leq \mathbf{T C}\left(M^{3}(1,0,0)\right), \mathbf{T C}\left(M^{3}(0,1,0)\right), \mathbf{T C}\left(M^{3}(0,0,1)\right), \mathbf{T C}\left(M^{3}(0,1,1)\right) \leq 7$.
Proof. The generators of the ideal $\tilde{I}$ in Proposition 2.2 are $\alpha_{j}=x_{j} y_{j}$ where $j=1,2,3$. Let

\mathfrak{a}_{j}:=1 \otimes y_{j}-y_{j} \otimes 1
$$

for $j=1,2,3$. Then $\mathfrak{a}_{\mathfrak{j}}$ is in the ideal of the zero-divisors of $H^{*}\left(M^{3}\left(\beta_{1}^{2}, \beta_{1}^{3}, \beta_{2}^{3}\right) ; \mathbb{Z}_{2}\right)$. Note that $\mathbf{T C}\left(M^{3}\left(\beta_{1}^{2}, \beta_{1}^{3}, \beta_{2}^{3}\right)\right) \leq 7$ by Proposition 4.5. The manifolds $M^{3}(1,0,0), M^{3}(0,1,0), M^{3}(0,0,1)$, and $M^{3}(0,1,1)$ are diffeomorphic to each other by [Naz11, Theorem 4].

Consider the real Bott manifold $M^{3}(1,0,0)$. Then from Proposition 2.2, the ideal $\tilde{J}$ is generated by the elements $x_{1}+y_{1}, x_{2}+y_{1}+y_{2}$, and $x_{3}+y_{3}$. So, $x_{1}=y_{1}, x_{2}=y_{1}+y_{2}$, and $x_{3}=y_{3}$ in $H^{*}\left(M^{3}(1,0,0) ; \mathbb{Z}_{2}\right)$. Therefore, we have $y_{1}^{2}=y_{3}^{2}=0$, and $y_{2}^{2}=y_{1} y_{2}$. Now,

\mathfrak{a}_{2}^{3} \mathfrak{a}_{3} & =\left(1 \otimes y_{2}^{3}-y_{2} \otimes y_{2}^{2}+y_{2}^{2} \otimes y_{2}-y_{2}^{3} \otimes 1\right)\left(1 \otimes y_{3}-y_{3} \otimes 1\right) \\
& =y_{1} y_{2} \otimes y_{2} y_{3}+y_{2} y_{3} \otimes y_{1} y_{2}-y_{1} y_{2} y_{3} \otimes y_{2}-y_{2} \otimes y_{1} y_{2} y_{3} .
\end{aligned}
$$

So, the product $\mathfrak{a}_{2}^{3} \mathfrak{a}_{3}$ contains an element $y_{1} y_{2} \otimes y_{2} y_{3}$ which is non-zero. Therefore, the zero-divisors-cup-length of $H^{*}\left(\mathbf{T C}\left(M^{3}(1,0,0)\right) ; \mathbb{Z}_{2}\right)$ is greater than or equal to 4 . Hence by Proposition 4.3, we have $5 \leq \mathbf{T C}\left(M^{3}(1,0,0)\right)$.

We remark that $M^{3}(1,1,0)$ is the 3-dimensional Klein Bottle, and [DS23, Theorem 3.1] gives $\mathbf{T C}\left(M^{3}(1,1,0)\right)=6$.

Theorem 4.11. $6 \leq \mathbf{T C}\left(M^{3}(1,0,1)\right), \mathbf{T C}\left(M^{3}(1,1,1)\right) \leq 7$.
Proof. The generators of the ideal $\tilde{I}$ in Proposition 2.2 are $\alpha_{j}=x_{j} y_{j}$ where $j=1,2,3$. Let $\mathfrak{a}_{j}:=1 \otimes y_{j}-y_{j} \otimes 1$ for $j=1,2,3$. Then $\mathfrak{a}_{\mathfrak{j}}$ is in the ideal of the zero-divisors of $H^{*}\left(M^{3}(P, \lambda) ; \mathbb{Z}_{2}\right)$. Note that $\mathbf{T C}\left(M^{3}\left(\beta_{1}^{2}, \beta_{1}^{3}, \beta_{2}^{3}\right)\right) \leq 7$ by Proposition 4.5. The manifolds $M^{3}(1,0,1)$ and $M^{3}(1,1,1)$ are diffeomorphic by [Naz11, Theorem 4].

Consider the real Bott manifold $M^{3}(1,0,1)$. Then from Proposition 2.2 the ideal $\tilde{J}$ is generated by the elements $x_{1}+y_{1}, x_{2}+y_{1}+y_{2}$, and $x_{3}+y_{2}+y_{3}$. So, $x_{1}=y_{1}, x_{2}=y_{1}+y_{2}$, and $x_{3}=y_{2}+y_{3}$
in $H^{*}\left(M^{3}(1,0,1) ; \mathbb{Z}_{2}\right)$. Now,

\begin{aligned}
\mathfrak{a}_{2}^{2} \mathfrak{a}_{3}^{3} & =\left(1 \otimes y_{2}^{2}+y_{2} \otimes 1\right)\left(1 \otimes y_{3}^{3}-y_{3} \otimes y_{3}^{2}+y_{3}^{2} \otimes y_{3}-y_{3}^{3} \otimes 1\right) \\
& =\left(y_{1} y_{2}+y_{2} y_{3}\right) \otimes y_{1} y_{2} y_{3}-y_{1} y_{2} y_{3} \otimes\left(y_{1} y_{2}+y_{2} y_{3}\right)
\end{aligned}
$$

So, the product $\mathfrak{a}_{2}^{2} \mathfrak{a}_{3}^{3}$ contains an element $y_{1} y_{2} \otimes y_{1} y_{2} y_{3}$ which is non-zero. Therefore the zero-divisors-cup-length of $H^{*}\left(M^{3}(1,0,1) ; \mathbb{Z}_{2}\right)$ is greater than or equal to 5 . Hence by Proposition 4.3, we have $6 \leq \mathbf{T C}\left(M^{3}(1,0,1)\right)$.

Now, for $n=4$, the Bott matrix is given by $\left(\begin{array}{cccc}1 & 0 & 0 & 0 \\ \beta_{1}^{2} & 1 & 0 & 0 \\ \beta_{1}^{3} & \beta_{2}^{3} & 1 & 0 \\ \beta_{1}^{4} & \beta_{2}^{4} & \beta_{3}^{4} & 1\end{array}\right)$. In this case, we denote $M^{4}(P, \lambda)$ by $M^{4}\left(\beta_{1}^{2}, \beta_{1}^{3}, \beta_{2}^{3}, \beta_{1}^{4}, \beta_{2}^{4}, \beta_{3}^{4}\right)$.
Theorem 4.12. Let $\beta_{1}^{2}=1$. If at least one of $\left\{\beta_{1}^{3}, \beta_{2}^{3}\right\}$ is 1 , and at least two of $\left\{\beta_{1}^{4}, \beta_{2}^{4}, \beta_{3}^{4}\right\}$ are 1 , then $8 \leq \mathbf{T C}\left(M^{4}\left(1, \beta_{1}^{3}, \beta_{2}^{3}, \beta_{1}^{4}, \beta_{2}^{4}, \beta_{3}^{4}\right)\right) \leq 9$.
Proof. The generators of the ideal $\tilde{I}$ in the cohomology ring $H^{*}\left(M^{4}\left(1, \beta_{1}^{3}, \beta_{2}^{3}, \beta_{1}^{4}, \beta_{2}^{4}, \beta_{3}^{4}\right) ; \mathbb{Z}_{2}\right)$ are $\alpha_{j}=x_{j} y_{j}$ where $j=1,2,3,4$. Let $\mathfrak{a}_{j}:=1 \otimes y_{j}-y_{j} \otimes 1$ for $j=1,2,3,4$. Then $\mathfrak{a}_{\mathfrak{j}}$ is in the ideal of the zero-divisors of $H^{*}\left(M^{4}\left(1, \beta_{1}^{3}, \beta_{2}^{3}, \beta_{1}^{4}, \beta_{2}^{4}, \beta_{3}^{4}\right) ; \mathbb{Z}_{2}\right)$. Note that $\mathbf{T C}\left(M^{4}\left(1, \beta_{1}^{3}, \beta_{2}^{3}, \beta_{1}^{4}, \beta_{2}^{4}, \beta_{3}^{4}\right)\right) \leq 9$ by Proposition 4.5. By Naz11, Theorem 5], it is enough to consider the following manifolds to prove the claim; $M^{4}(1,1,0,1,1,0), M^{4}(1,0,1,1,1,0), M^{4}(1,0,1,0,1,1), M^{4}(1,0,1,1,0,1)$, and $M^{4}(1,1,1,1,1,0)$
(1) Consider the real Bott manifold $M^{4}(1,1,0,1,1,0)$. Then from Proposition [2.2, the ideal $\tilde{J}$ is generated by the elements $x_{1}+y_{1}, x_{2}+y_{1}+y_{2}, x_{3}+y_{1}+y_{3}$, and $x_{4}+y_{1}+y_{2}+y_{4}$. So $x_{1}=y_{1}, x_{2}=y_{1}+y_{2}, x_{3}=y_{1}+y_{3}$, and $x_{4}=y_{1}+y_{2}+y_{4}$ in $H^{*}\left(M^{4}(1,1,0,1,1,0) ; \mathbb{Z}_{2}\right)$. Therefore, we have $y_{1}^{2}=0, y_{2}^{2}=y_{1} y_{2}, y_{3}^{2}=y_{1} y_{3}, y_{4}^{2}=y_{1} y_{4}+y_{2} y_{4}$. Now,
$\mathfrak{a}_{2} \mathfrak{a}_{3}^{3} \mathfrak{a}_{4}^{3}=\left(1 \otimes y_{2}-y_{2} \otimes 1\right)\left(1 \otimes y_{3}^{3}-y_{3} \otimes y_{3}^{2}+y_{3}^{2} \otimes y_{3}-y_{3}^{3} \otimes 1\right)\left(1 \otimes y_{4}^{3}-y_{4} \otimes y_{4}^{2}+y_{4}^{2} \otimes y_{4}-y_{4}^{3} \otimes 1\right)$
$=y_{1} y_{2} y_{3} y_{4} \otimes y_{1} y_{2} y_{3}-y_{1} y_{2} y_{3} \otimes y_{1} y_{2} y_{3} y_{4}+y_{1} y_{2} y_{3} y_{4} \otimes y_{1} y_{3} y_{4}-y_{1} y_{3} y_{4} \otimes y_{1} y_{2} y_{3} y_{4}$.
So, the product $\mathfrak{a}_{2} \mathfrak{a}_{3}^{3} \mathfrak{a}_{4}^{3}$ contains an element $y_{1} y_{2} y_{3} \otimes y_{1} y_{2} y_{3} y_{4}$ which is non-zero. Therefore the zero-divisors-cup-length of $H^{*}\left(M^{4}(1,1,0,1,1,0) ; \mathbb{Z}_{2}\right)$ is greater than or equal to 7 . Hence by Proposition 4.3, we have $8 \leq \mathbf{T C}\left(M^{4}(1,1,0,1,1,0)\right)$.
(2) Consider the real Bott manifold $M^{4}(1,0,1,1,1,0)$. Then from Proposition 2.2, the ideal $\tilde{J}$ is generated by the elements $x_{1}+y_{1}, x_{2}+y_{1}+y_{2}, x_{3}+y_{2}+y_{3}$, and $x_{4}+y_{1}+y_{2}+y_{4}$. So, $x_{1}=y_{1}, x_{2}=y_{1}+y_{2}, x_{3}=y_{2}+y_{3}$, and $x_{4}=y_{1}+y_{2}+y_{4}$ in $H^{*}\left(M^{4}(1,0,1,1,1,0) ; \mathbb{Z}_{2}\right)$. Now,

So, the product $\mathfrak{a}_{2} \mathfrak{a}_{3}^{3} \mathfrak{a}_{4}^{3}$ contains an element $y_{1} y_{2} y_{3} \otimes y_{1} y_{2} y_{3} y_{4}$ which is non-zero. Therefore the zero-divisors-cup-length of $H^{*}\left(M^{4}(1,0,1,1,1,0) ; \mathbb{Z}_{2}\right)$ is greater than or equal to 7 . Hence by Proposition 4.3, we have $8 \leq \mathbf{T C}\left(M^{4}(1,0,1,1,1,0)\right)$.
(3) Consider the real Bott manifold $M^{4}(1,0,1,0,1,1)$. Then from Proposition 2.2, the ideal $\tilde{J}$ is generated by the elements $x_{1}+y_{1}, x_{2}+y_{1}+y_{2}, x_{3}+y_{2}+y_{3}$, and $x_{4}+y_{2}+y_{3}+y_{4}$. So, $x_{1}=y_{1}, x_{2}=y_{1}+y_{2}, x_{3}=y_{2}+y_{3}$, and $x_{4}=y_{2}+y_{3}+y_{4}$ in $H^{*}\left(M^{4}(1,0,1,0,1,1) ; \mathbb{Z}_{2}\right)$. Now,
$\mathfrak{a}_{2} \mathfrak{a}_{3}^{3} \mathfrak{a}_{4}^{3}=\left(1 \otimes y_{2}-y_{2} \otimes 1\right)\left(1 \otimes y_{3}^{3}-y_{3} \otimes y_{3}^{2}+y_{3}^{2} \otimes y_{3}-y_{3}^{3} \otimes 1\right)\left(1 \otimes y_{4}^{3}-y_{4} \otimes y_{4}^{2}\right.$ $\left.+y_{4}^{2} \otimes y_{4}-y_{4}^{3} \otimes 1\right)$

=y_{1} y_{2} y_{3} y_{4} \otimes\left(y_{1} y_{2} y_{3}+y_{2} y_{3} y_{4}+y_{1} y_{2} y_{4}\right)-\left(y_{1} y_{2} y_{3}+y_{2} y_{3} y_{4}+y_{1} y_{2} y_{4}\right) \otimes y_{1} y_{2} y_{3} y_{4}

So, the product $\mathfrak{a}_{2} \mathfrak{a}_{3}^{3} \mathfrak{a}_{4}^{3}$ contains an element $y_{1} y_{2} y_{3} \otimes y_{1} y_{2} y_{3} y_{4}$ which is non-zero. Therefore the zero-divisors-cup-length of $H^{*}\left(M^{4}(1,0,1,0,1,1) ; \mathbb{Z}_{2}\right)$ is greater than or equal to 7 . Hence by Proposition 4.3, we have $8 \leq \mathbf{T C}\left(M^{4}(1,0,1,0,1,1)\right)$.
(4) Consider the real Bott manifold $M^{4}(1,0,1,1,0,1)$. Then from Proposition 2.2, the ideal $\tilde{J}$ is generated by the elements $x_{1}+y_{1}, x_{2}+y_{1}+y_{2}, x_{3}+y_{2}+y_{3}$, and $x_{4}+y_{1}+y_{3}+y_{4}$. So $x_{1}=y_{1}, x_{2}=y_{1}+y_{2}, x_{3}=y_{2}+y_{3}$, and $x_{4}=y_{1}+y_{3}+y_{4}$ in $H^{*}\left(M^{4}(1,0,1,1,0,1) ; \mathbb{Z}_{2}\right)$. Now,

Therefore the zero-divisors-cup-length of $H^{*}\left(M^{4}(1,0,1,1,0,1) ; \mathbb{Z}_{2}\right)$ is greater than or equal to 7 . Hence by Proposition 4.3, we have $8 \leq \mathbf{T C}\left(M^{4}(1,0,1,1,0,1)\right)$.
(5) Consider the real Bott manifold $M^{4}(1,1,1,1,1,0)$. Then from Proposition [2.2 the ideal $\tilde{J}$ is generated by the elements $x_{1}+y_{1}, x_{2}+y_{1}+y_{2}, x_{3}+y_{1}+y_{2}+y_{3}$, and $x_{4}+y_{1}+y_{2}+y_{4}$. So, $x_{1}=y_{1}, x_{2}=y_{1}+y_{2}, x_{3}=y_{1}+y_{2}+y_{3}$, and $x_{4}=y_{1}+y_{2}+y_{4}$ in $H^{*}\left(M^{4}(1,1,1,1,1,0) ; \mathbb{Z}_{2}\right)$. Now,

& =y_{1} y_{2} y_{3} y_{4} \otimes y_{2} y_{3} y_{4}-y_{2} y_{3} y_{4} \otimes y_{1} y_{2} y_{3} y_{4} .
\end{aligned}
$$

So, the product $\mathfrak{a}_{2} \mathfrak{a}_{3}^{3} \mathfrak{a}_{4}^{3}$ contains an element $y_{2} y_{3} y_{4} \otimes y_{1} y_{2} y_{3} y_{4}$ which is non-zero. Therefore the zero-divisors-cup-length of $H^{*}\left(M^{4}(1,1,1,1,1,0) ; \mathbb{Z}_{2}\right)$ is greater than or equal to 7 . Hence by Proposition 4.3, we have $8 \leq \mathbf{T C}\left(M^{4}(1,1,1,1,1,0)\right)$.

## 5. Symmetric topological complexity of small covers

In this section, we recall the definition of symmetric topological complexity. Then we compute this invariant for a class of small covers.

Let $Y$ be a path-connected space. The path fibration $\pi: P Y \rightarrow Y \times Y$ restricts to a fibration

$$
\begin{equation*}
\pi^{\prime}: P^{\prime} Y \rightarrow F(Y ; 2) \tag{5.1}
\end{equation*}
$$

where $F(Y ; 2)=\{(x, y) \in Y \times Y \mid x \neq y\}$ is the space of ordered pairs of distinct points in $Y$, and $P^{\prime} Y$ is the subspace $\{\gamma: I \rightarrow Y \mid \gamma(0) \neq \gamma(1)\} \subseteq P Y$ consisting of paths with distinct endpoints.

The group $\mathbb{Z}_{2}$ acts on $F(Y ; 2)$ by permutation of factors, and acts on $P^{\prime} Y$ by sending a path $\gamma$ to its inverse $\bar{\gamma}$ given by $\bar{\gamma}(t)=\gamma(1-t)$. So, the group $\mathbb{Z}_{2}$ acting on the spaces $P^{\prime} Y$ and $F(Y ; 2)$ freely. Observe that $\pi^{\prime}: P^{\prime} Y \rightarrow F(Y ; 2)$ is an equivariant map of free $\mathbb{Z}_{2}$-spaces. So, it induces a map

$$
\begin{equation*}
\pi^{\prime \prime}: P^{\prime} Y / \mathbb{Z}_{2} \rightarrow B(Y ; 2) \tag{5.2}
\end{equation*}
$$

where $B(Y ; 2)$ denotes the orbit space $F(Y ; 2) / \mathbb{Z}_{2}$ of unordered pairs of distinct points in $Y$. This map is also a fibration.
Definition 5.1. The symmetric topological complexity of $Y$, denoted by $\mathbf{T C}^{S}(Y)$, is defined to be one plus the sectional category of the fibration $\pi^{\prime \prime}$. In other words, $\mathbf{T C}^{S}(Y)=1+\operatorname{secat}\left(\pi^{\prime \prime}\right)$.

We adopt the convention that the sectional category of $p: E \rightarrow B$ vanishes if and only if $E=B=\emptyset$. The space $B(Y ; 2)$ is empty if and only if $Y$ is a single point, and so in this case, $\mathbf{T C}^{S}(Y)=1$. If $Y$ contains more than one point then secat $\left(\pi^{\prime \prime}\right) \geq 1$, and therefore $\mathbf{T C}^{S}(Y) \geq 2$.
Example 5.2. Let $Y$ is a contractible space. Then there exists a continuous map $y \mapsto \gamma_{y} \in P Y$ such that $\gamma_{y}(0)=y$ and $\gamma_{y}(1)=y_{0}$. Then setting $s(a, b)$ to be equal to the concatenation of $\gamma_{a}$ and the inverse path to $\gamma_{b}$ gives a symmetric equivariant section of (5.1). Therefore for any contractible space $Y$ with more than one point, we have $\mathbf{T C}^{S}(Y)=2$. We note that if $Y$ is a path-connected space with $\mathbf{T C}^{S}(Y)=2$, then $Y$ is contractible.

Let $N_{Y}$ be the sub-ring of $H^{*}(Y) \otimes H^{*}(Y)$ spanned by the norm elements (i.e., the elements of the form $x \otimes y+y \otimes x$ with $x \neq y$ ). The following result follows from Corollary 9, Proposition 10, and Theorem 17 in FG07.

Proposition 5.3. Let $Y$ be a closed smooth manifold. Then

$$
\max \left\{\mathbf{T C}(Y), \operatorname{cl}\left(N_{Y}\right)+2\right\} \leq \mathbf{T} \mathbf{C}^{S}(Y) \leq 2 \operatorname{dim} Y+1
$$

Next, we calculate the symmetric topological complexity of the circle.
Corollary 5.4. If $P$ is an 1 -simplex, then $M^{1}(P, \lambda)=\mathbb{R P}^{1}$ and $\mathbf{T C}^{S}\left(\mathbb{R}^{1}\right)=3$.
Proof. Note that the non-zero element $1 \otimes y_{1}+y_{1} \otimes 1$ is the norm element of $H^{*}\left(M^{1}(P, \lambda) ; \mathbb{Z}_{2}\right) \otimes$ $H^{*}\left(M^{1}(P, \lambda) ; \mathbb{Z}_{2}\right)$. So, by Proposition 5.3 we get $3 \leq \mathbf{T C}^{S}\left(M^{1}(P, \lambda)\right)$. The small cover over a 1 -simplex is $\mathbb{R} \mathbb{P}^{1}=\mathbb{S}^{1}$. Therefore, by Proposition 5.3, we get

$$
\mathbf{T C}^{S}\left(M^{1}(P, \lambda)\right) \leq 2 \operatorname{dim}\left(M^{1}(P, \lambda)\right)+1=3
$$

We note that the conclusion of Corollary 5.4 can be obtained from [FG07, Corollary 18].
Remark 5.5. The element $1 \otimes y_{j}+y_{j} \otimes 1$ is same as $1 \otimes y_{j}-y_{j} \otimes 1$ in $N_{M^{n}(P, \lambda)}$. Thus the zero-divisors-cup-length of $M^{n}(P, \lambda)$ is the same as the cup-length of $N_{M^{n}(P, \lambda)}$.
Theorem 5.6. Let $M^{n}(P, \lambda)$ be a small cover other than $\mathbb{R}^{P^{n_{1}}} \times \mathbb{R}^{P^{n_{2}}}$ over $P=\Delta^{n_{1}} \times \Delta^{n_{2}}$.
(1) Let $n_{2} \in \mathcal{S}$ with $n_{2}>n_{1}$. Then $2^{r_{1}}+2^{r_{2}} \leq \mathbf{T C}^{S}\left(M^{n}(P, \lambda)\right)$.
(2) Let $n_{2} \in \mathcal{S}$ with $n_{2}$ divides $n_{1}$. Then $2^{r}+1 \leq \mathbf{T C}^{S}\left(M^{n}(P, \lambda)\right)$.
(3) Let $n_{2} \in \mathcal{S}+1$ with $n_{2}>n_{1}+1$. Then, $2^{r}+1 \leq \mathbf{T C}^{S}\left(M^{n}(P, \lambda)\right)$.
(4) Let $n_{2} \in \mathcal{S}+2$ with $n_{2}>n_{1}+2$. Then, $2^{r}+1 \leq \mathbf{T C}^{S}\left(M^{n}(P, \lambda)\right)$.

In particular, if $n=2^{s-1}$, then for the cases (21), (31), and (4), we have $\mathbf{T C}^{S}\left(M^{n}(P, \lambda)\right)=2 n+1$.
Proof. Let $N_{M^{n}(P, \lambda)}$ denotes the sub-ring of $H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right) \otimes H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$ spanned by the norm elements. Consider the norm elements $\mathfrak{a}_{j}:=1 \otimes y_{j}+y_{j} \otimes 1$ in $N_{M^{n}(P, \lambda)}$ for $j=1,2$. Then the proof follows from Theorem 4.6, Proposition 5.3, and Remark 5.5,

Theorem 5.7. For $n \geq 3$, let the elements $\beta_{k}^{k+1}$ in the Bott matrix (2.15) be 1 for $k=1, \ldots, n-1$, and the remaining elements $\beta_{l}^{m}$ be zero for $l=1, \ldots, n-2$ and $m=3, \ldots, n$. If $n \leq 2^{r}-1<2 n$, then the symmetric topological complexity of the real Bott manifold $M^{n}(P, \lambda)$ is greater than or equal to $2^{r}+1$. In particular, if $n=2^{s-1}$, then $\mathbf{T C}^{S}\left(M^{n}(P, \lambda)\right)=2 n+1$.

Proof. The proof follows from Theorem 4.9, Proposition 5.3, and Remark 5.5.

## Remark 5.8.

(1) From Theorem 4.11, Proposition 5.3, and Remark 5.5, we get,

$$
\mathbf{T C}^{S}\left(M^{3}(1,1,0)\right)=\mathbf{T C}^{S}\left(M^{3}(1,0,1)\right)=\mathbf{T C}^{S}\left(M^{3}(1,1,1)\right)=7
$$

(2) Let $\beta_{1}^{2}=1$. If at least one of $\left\{\beta_{1}^{3}, \beta_{2}^{3}\right\}$ is 1 , and at least two of $\left\{\beta_{1}^{4}, \beta_{2}^{4}, \beta_{3}^{4}\right\}$ are 1 . Then from Theorem 4.12, Proposition 5.3 and Remark 5.5] we get,

$$
\mathbf{T C}^{S}\left(M^{4}\left(1, \beta_{1}^{3}, \beta_{2}^{3}, \beta_{1}^{4}, \beta_{2}^{4}, \beta_{3}^{4}\right)\right)=9
$$

## 6. $\mathcal{D}$-TOPOLOGICAL COMPLEXITY OF SMALL COVERS

In this section, we recall the $\mathcal{D}$-topological complexity and the LS one-category of a space. We compute LS one-category for all real Bott manifolds and for a class of small covers. Then, we give some bounds for the $\mathcal{D}$-topological complexity of small covers.
Definition 6.1. Let $Y$ be a path-connected space with the fundamental group $G=\pi_{1}\left(Y, y_{0}\right)$. The $\mathcal{D}$-topological complexity, denoted by $\mathbf{T C}^{\mathcal{D}}(Y)$, is defined as the minimal number $k$ such that $Y \times Y$ can be covered by $k$ open subsets $U_{1}, \ldots, U_{k}$ with the property that for each $i \in\{1, \ldots, k\}$ and for every choice of the base point $u_{i} \in U_{i}$, the homomorphism $\pi_{1}\left(U_{i}, u_{i}\right) \rightarrow \pi_{1}\left(Y \times Y, u_{i}\right)$ induced by the inclusion $U_{i} \rightarrow Y \times Y$ takes values in a subgroup conjugate to the diagonal $\Delta \subseteq G \times G$.

Note that there is an isomorphism $\pi_{1}\left(Y \times Y, u_{i}\right) \rightarrow \pi_{1}\left(Y \times Y,\left(y_{0}, y_{0}\right)\right) \cong G \times G$ determined uniquely up to conjugation, and the diagonal inclusion $Y \rightarrow Y \times Y$ induces the inclusion $G \rightarrow G \times G$ onto the diagonal $\Delta$.

We recall the Lusternik-Schnirelmann one-category (in short LS one-category) of a space which is denoted by $\operatorname{cat}_{1}(Y)$ for a space $Y$.
Definition 6.2. Let $Y$ be a connected, locally path-connected, and semi-locally simply connected space with the universal cover $p: \widetilde{Y} \rightarrow Y$. Then the LS one-category is the sectional category of the map $p$. That is, $\operatorname{cat}_{1}(Y)=\operatorname{secat}(p)$.

Similar to cat $(Y)$ and $\mathbf{T C}(Y)$ there is a relation between $\operatorname{cat}_{1}(Y)$ and $\mathbf{T C}^{\mathcal{D}}(Y)$.
Proposition 6.3. FGLO19b, Proposition 2.4, Proposition 2.11] If $Y$ is a connected, locally pathconnected, and semi-locally simply connected topological space, then

$$
\operatorname{cat}_{1}(Y) \leq \mathbf{T} \mathbf{C}^{\mathcal{D}}(Y) \leq \min \left\{\mathbf{T C}(Y), \operatorname{cat}_{1}(Y \times Y)\right\}
$$

We recall a result that gives a lower bound for the sectional category of fibrations.
Proposition 6.4. CLOT03, Proposition 9.14] Let $F \rightarrow E \xrightarrow{p} B$ be a fibration. If there exists $y_{1}, \ldots, y_{k} \in H^{*}(B ; R)$ with $p^{*}\left(y_{1}\right)=\cdots=p^{*}\left(y_{k}\right)=0$ and $y_{1} \cup \cdots \cup y_{k} \neq 0$, then $\sec a t(p) \geq k+1$.

The following result gives the computation of LS one-category of infinitely many small covers.
Theorem 6.5. Let $M^{n}(P, \lambda)$ be a small cover over a simple polytope $P$ such that $\mathbb{R} \mathcal{Z}_{K_{P}}$ is simply connected. Then $\operatorname{cat}_{1}\left(M^{n}(P, \lambda)\right)=n+1$.

Proof. Consider the principal $\mathbb{Z}_{2}^{m}$-bundle map $p: \mathbb{R} \mathcal{Z}_{K_{P}} \rightarrow M^{n}(P ; \lambda)$ given by Proposition 2.7. So we get the induced graded ring homomorphism

$$
p^{*}: H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right) \rightarrow H^{*}\left(\mathbb{R} \mathcal{Z}_{K_{P}} ; \mathbb{Z}_{2}\right)
$$

Note that $p^{*}$ carries $H^{j}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$ to $H^{j}\left(\mathbb{R} \mathcal{Z}_{K_{P}} ; \mathbb{Z}_{2}\right)$. Now, for $j=1, H^{1}\left(\mathbb{R} \mathcal{Z}_{K_{P}} ; \mathbb{Z}_{2}\right)=0$ as $\mathbb{R} \mathcal{Z}_{K_{P}}$ is simply connected. Therefore, each $v$ in $H^{1}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$ maps to 0 in $H^{*}\left(\mathbb{R} \mathcal{Z}_{K_{P}} ; \mathbb{Z}_{2}\right)$. Hence $p^{*}(v)=0$ for $v \in H^{1}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right)$. Since $P$ is a simple polytope, at each vertex, exactly $n$ many facets intersect. So the cup product of corresponding $n$ indeterminates is non-zero. Therefore, by Proposition 6.4, secat $(p) \geq n+1$. Since $p$ is the universal cover, so by definition of LS onecategory, $\operatorname{secat}(p)=\operatorname{cat}_{1}\left(M^{n}(P, \lambda)\right)$. Therefore $n+1 \leq \operatorname{cat}_{1}\left(M^{n}(P, \lambda)\right)$.

On the other hand, we know that $\operatorname{cat}_{1}\left(M^{n}(P, \lambda)\right) \leq \operatorname{cat}\left(M^{n}(P, \lambda)\right)$ as discussed in FGLO19b. Since $\operatorname{cat}\left(M^{n}(P, \lambda)\right)=n+1$ (by Theorem 3.4), so $\operatorname{cat}_{1}\left(M^{n}(P, \lambda)\right) \leq n+1$. Hence, we get the result.

Corollary 6.6. Let $M^{n}(P, \lambda)$ be a small cover over $P=\prod_{j=1}^{m} \Delta^{n_{j}}$ such that $n_{j} \geq 2$ for $j=$ $1, \ldots, m$. Then $\operatorname{cat}_{1}\left(M^{n}(P, \lambda)\right)=n+1$.
Proof. The moment angle manifold $\mathbb{R} \mathcal{Z}_{K_{P}}$ for the polytope $P=\prod_{j=1}^{m} \Delta^{n_{j}}$ is $\mathbb{S}^{n_{1}} \times \cdots \times \mathbb{S}^{n_{m}}$. Thus, $\mathbb{R} \mathcal{Z}_{K_{P}}$ is simply connected and orientable for $n_{j} \geq 2$ for $j=1, \ldots, m$. Therefore, by Theorem 6.5. $\operatorname{cat}_{1}\left(M^{n}(P, \lambda)\right)=n+1$.

Theorem 6.7. Let $M^{n}(P, \lambda)$ be a small cover over $P=\prod_{j=1}^{m} \Delta^{n_{j}}$. Then $\operatorname{cat}_{1}\left(M^{n}(P, \lambda)\right)=n+1$.
Proof. Corollary 6.6 gives the proof for all $n_{j} \geq 2$.
Now consider the small cover $M^{n}(P, \lambda)$ over $P=\prod_{j=1}^{m} \Delta^{n_{j}}$ where some $n_{j}=1$. Without loss of generality, we assume that $n_{1}=n_{2}=\cdots=n_{s-1}=1$ and the remaining $n_{j}$ 's are greater than or equal to 2 . Then the map $\bar{p}:\left(\prod_{1}^{s-1} \mathbb{R} \times \prod_{j=s}^{m} \mathbb{S}^{n_{j}}\right) \rightarrow\left(\prod_{1}^{s-1} \mathbb{S}^{1} \times \prod_{j=s}^{m} \mathbb{S}^{n_{j}}\right) / \mathbb{Z}_{2}^{m}=M^{n}(P, \lambda)$ is the universal cover where $\mathbb{R} \rightarrow \mathbb{S}^{1}$ is given by exponential map. This induces a ring homomorphism

$$
\bar{p}^{*}: H^{*}\left(M^{n}(P, \lambda) ; \mathbb{Z}_{2}\right) \rightarrow H^{*}\left(\prod_{1}^{s-1} \mathbb{R} \times \prod_{j=s}^{m} \mathbb{S}^{n_{j}} ; \mathbb{Z}_{2}\right)
$$

We know that the cohomology ring of $M^{n}(P, \lambda)$ is generated by $y_{1}, \ldots, y_{m}$ and $y_{j}^{n_{j}} \neq 0$ for $j=1,2, \ldots, m$. Hence

$$
p^{*}\left(y_{1}\right)=\cdots=p^{*}\left(y_{m}\right)=0 .
$$

Since all $y_{j}^{n_{j}} \neq 0$ for $j=1, \ldots, m$, so

$$
y_{1} \cup \cdots \cup y_{s-1} \cup \underbrace{y_{s} \cup \cdots \cup y_{s}}_{n_{s} \text { times }} \cup \cdots \cup \underbrace{y_{m} \cup \cdots \cup y_{m}}_{n_{m} \text { times }} \neq 0 .
$$

Therefore, by Proposition 6.4. $\operatorname{secat}(\bar{p}) \geq n_{1}+\cdots+n_{m}+1=n+1$. By the definition of LS one-category, $\operatorname{secat}(p)=\operatorname{cat}_{1}\left(M^{n}(P, \lambda)\right)$. Therefore $n+1 \leq \operatorname{cat}_{1}\left(M^{n}(P, \lambda)\right)$. Using Theorem 3.4, $\operatorname{cat}\left(M^{n}(P, \lambda)\right)=n+1$. Thus $\operatorname{cat}_{1}\left(M^{n}(P, \lambda)\right) \leq n+1$. Hence $\operatorname{cat}_{1}\left(M^{n}(P, \lambda)\right)=n+1$.

We give some bounds on $\mathbf{T C}^{\mathcal{D}}\left(M^{n}(P, \lambda)\right)$ in the following.
Theorem 6.8. Let $M^{n}(P, \lambda)$ be a small cover over a product of simplices $P$. Then

$$
n+1 \leq \mathbf{T C}^{\mathcal{D}}\left(M^{n}(P, \lambda)\right) \leq 2 n+1
$$

In particular, if $M^{n}(P, \lambda)=\mathbb{R}^{P^{n_{1}}} \times \cdots \times \mathbb{R}^{n_{m}}$ with $n_{j} \in\{1,3,7\}$, then $\mathbf{T C}^{\mathcal{D}}\left(M^{n}(P, \lambda)\right)=n+1$.
Proof. By Proposition 6.3, we have $\operatorname{cat}_{1}\left(M^{n}(P, \lambda)\right) \leq \mathbf{T C}^{\mathcal{D}}\left(M^{n}(P, \lambda)\right)$. Therefore, by Theorem 6.7. we have $n+1 \leq \mathbf{T C}^{\mathcal{D}}\left(M^{n}(P, \lambda)\right)$. By Proposition 6.3, $\mathbf{T C}^{\mathcal{D}}\left(M^{n}(P, \lambda)\right) \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right)$. So, the upper bound of $\mathbf{T C}^{\mathcal{D}}\left(M^{n}(P, \lambda)\right)$ is $2 n+1$, i.e., $\mathbf{T C}^{\mathcal{D}}\left(M^{n}(P, \lambda)\right) \leq 2 n+1$.

The second part follows from Corollary 4.8 and $\mathbf{T C}^{\mathcal{D}}\left(M^{n}(P, \lambda)\right) \leq \mathbf{T C}\left(M^{n}(P, \lambda)\right)$. In this case $\mathbf{T C}^{\mathcal{D}}\left(M^{n}(P, \lambda)\right) \leq n+1$.
