# Closest Distance between Iterates of Typical Points

#### Abstract

The shortest distance between the first $n$ iterates of a typical point can be quantified with a log rule for some dynamical systems admitting Gibbs measures. We show this in two settings. For topologically mixing Markov shifts with at most countably infinite alphabet admitting a Gibbs measure with respect to a locally Hölder potential, we prove the asymptotic length of the longest common substring for a typical point converges and the limit depends on the Rényi entropy. For interval maps with a Gibbs-Markov structure, we prove a similar rule relating the correlation dimension of Gibbs measures with the shortest distance between two iterates in the orbit generated by a typical point.


Keywords - Symbolic Dynamics, Gibbs-Markov maps, Renyi entropy, correlation dimension, closest distance within orbits

## 1 Introduction

Consider a topological Markov shift $\left(\Sigma_{A}, \sigma, \mathcal{I}\right)$ on a (at most) countably infinite alphabet $\mathcal{I}$ with respect to a transition matrix $A$ equipped with the natural symbolic metric $d$. The first $n$ iterates of a $\underline{x} \in \Sigma_{A}$ under $\sigma$ are the initial $n$ symbols appearing in $\underline{x}$. We are interested in the asymptotic behaviour of the following quantity:

$$
\begin{equation*}
M_{n}(\underline{x})=\max \left\{k: \exists 0 \leq i<j \leq n-1: x_{i}, \ldots, x_{i+k-1}=x_{j}, \ldots, x_{j+k-1}\right\} \tag{1.1}
\end{equation*}
$$

which counts the maximum length of self-repetition. Studying quantities of this type is often referred to as the longest common substring matching problem. One motivation comes from the matching of nucleotide sequences in DNA, and early results were established in the 80s by Arratia and Waterman's work AW85]. They showed that the length of the longest common substring among two i.i.d stochastic sequences $X_{1}, X_{2}, \ldots$ and $Y_{1}, Y_{2}, \ldots$ taking letters in a finite alphabet with uniform distribution,

$$
M_{n}(X, Y):=\sup \left\{k: X_{i+m}=Y_{j+m} \text { for all } m=1 \text { to } k \text { and } 1 \leq i, j \leq n-k\right\}
$$

satisfies an Erdős-Rényi law

$$
\mathbb{P}\left(\lim _{n \rightarrow \infty} \frac{M_{n}}{\log n}=\frac{2}{\log 1 / p}\right)=1
$$

[^0]where $p=\mathbb{P}\left(X_{1}=Y_{1}\right)$ the collision probability, and $-\log \mathbb{P}\left(X_{1}=Y_{1}\right)$ is often called the collision entropy or Rényi entropy.

The result can easily be translated to topological Markov shifts by replacing the stochastic sequences with two points in the shift spaces $\Sigma_{X}$ and $\Sigma_{Y}$ with distribution $\mu_{X}, \mu_{Y}$, and one can verify a similar convergence law holds for $M_{n}(\underline{x}, \underline{y})$ (see DKZ94b and DKZ94a]). In recent works, BLR19] the authors proved as an improvement of the results in DKZ94b], for subshift systems with an invariant probability measure $\mu$ admitting good mixing conditions (more precisely, $\alpha$-mixing with exponential decay or $\psi$-mixing with polynomial decay), the shortest distance between the $n$-orbit of a typical pair of points $\underline{x}, \underline{y}$,

$$
M_{n}(\underline{x}, \underline{y})=\sup \left\{k: x_{i_{1}+j}=y_{i_{2}+j}, j=0, \ldots, k-1, \text { for some } i_{1}, i_{2} \leq n-k\right\}
$$

converges to a Rényi entropy for $\mu \otimes^{2}-\operatorname{almost~every~}(\underline{x}, \underline{y})$ in $\Sigma_{A}^{2}$. Similar almost sure convergences are proved for $k$-point-orbits in [BR21] for all $k \geq 2$.
The analogous problem for $M_{n}(\underline{x})$ is more difficult due to short return phenomenon. For subshifts of finite type, Collet et al in CGR09] applied first and second-moment analysis to the counting random variable $N\left(\underline{x}, n, r_{n}\right)$, which counts the number of matches of subwords of length $r_{n}$ among the first $n$ iterates in $\underline{x}$, there exists a constant $H_{2}$ which is the Rényi entropy of a Gibbs measure $\mu$, such that

$$
\lim _{n \rightarrow+\infty} \mu\left(\left|\frac{M_{n}(\underline{x})}{\log n}-\frac{2}{H_{2}}\right|>\varepsilon\right)=0,
$$

that is, $\frac{M_{n}(\underline{x})}{\log n}$ converges to $\frac{2}{H_{2}}$ in probability for typical $\underline{x}$. Then one may ask if this result can be improved to an almost sure convergence, or if the convergence remains valid when the alphabet is countably infinite. The answer is given by the following theorem.

Theorem 1.1. For a one-sided subshift system $\left(\Sigma_{A}, \sigma, \mu, \mathcal{I}\right)$ admitting a Gibbs measure $\mu$,

$$
\lim _{n \rightarrow+\infty} \frac{M_{n}(\underline{x})}{\log n}=\frac{2}{H_{2}}
$$

for $\mu$-almost every $\underline{x} \in \Sigma_{A}$, where $M_{n}(\underline{x})$ is defined in (1.1).
The existence and uniqueness of the Gibbs measure with respect to locally Hölder potentials for finite $\mathcal{I}$ is well-known (see BR08] for reference). For $\mathcal{I}$ countably infinite, they are charaterised by theorems in Sar99] and Sar03]. Detailed discussion is in subsection 2.2 below.

The counterpart of the longest substring matching problem for dynamical systems ( $T, X, \mu$ ) acting on nonsymbolic metric spaces $(X, d)$ investigates the shortest distance between the two $n$-orbits generated by a typical pair of points. To be precise, we care about the following quantity

$$
m_{n}(x, y):=\min _{0 \leq i, j \leq n-1} d\left(T^{i} x, T^{j} y\right) .
$$

There is a dimension-like object for measures, called correlation dimension (denoted as $D_{2}(\mu)$, Definition 4.1), which plays a similar role to Rényi entropies for symbolic systems. In BLR19] the authors gave an asymptotic relation between $m_{n}(x, y)$ and the correlation dimension $D_{2}(\mu)$ for $\mu \otimes^{2}$-almost every ( $x, y$ ), provided good decay of correlations. Later in BR21], this rule is generalised for a typical collection of $k$ points, $\left(x_{1}, x_{2}, \ldots, x_{k}\right)$, for $k=2,3, \ldots$. Again, we extend the investigation to the one-point case. Adopting techniques from GRS22], we will show that for one-dimensional Gibbs-Markov interval maps, there is a similar asymptotic relation between $m_{n}(x)$ and $D_{2}(\mu)$, where

$$
\begin{equation*}
m_{n}(x):=\min _{0 \leq i<j \leq n-1} d\left(T^{i} x, T^{j} x\right) . \tag{1.2}
\end{equation*}
$$

Theorem 1.2. Let $X$ be a closed interval of $\mathbb{R},(X, T)$ a Gibbs-Markov system and $\mu$ a Gibbs probability measure admitting exponential decay of correlations for $L^{1}$ against $\mathcal{B V}$ observables. Then if its upper correlation dimension $\bar{D}_{2}(\mu)$ is bounded from 0 ,

$$
\liminf _{n \rightarrow \infty} \frac{\log m_{n}(x)}{-\log n} \geq \frac{2}{\bar{D}_{2}}
$$

for $\mu$-almost every $x$ in the repeller $\Lambda$. If $\mu$ is absolutely continuous with respect to the Lebesgue measure, then

$$
\lim _{n \rightarrow \infty} \frac{\log m_{n}(x)}{-\log n}=\frac{2}{D_{2}}
$$

for $\mu$-almost every $x$, and in this case $\underline{D}_{2}(\mu)=\bar{D}_{2}(\mu)=1$.
Remark 1.3. The proof for this setting is more challenging than that for the symbolic setting because the open balls defined by the Euclidean metric and the cylinders generated by the natural partitions disagree. The analysis of short return to balls is crucial for obtaining the upper bound of $\frac{\log m_{n}(x)}{-\log n}$, which is also generally harder than the recurrence analysis of cylinders. The proof for the lower bound relies on the 4 -mixing property of Gibbs measures proved in Lemma 4.16

Remark 1.4. Another difference between the two theorems stated above and theorems proved in BLR19], [BR21] is that in the single point case, obtaining asymptotic upper bounds of $M_{n}(x)$ and $m_{n}(x)$ requires good mixing properties. This should be expected due to the fundamental difference between one-point orbits and orbits generated by multiple independent points, the strengthening of assumptions is to ensure the iterates decorrelate fast enough to behave like an independent sequence after a relatively small number of iterations.

This theorem is applicable to the a range of systems, for example,
Example 1.5 (k-doubling maps). $f:[0,1] \rightarrow[0,1], f(x)=k x(\bmod 1)$ for $k=2,3, \ldots$, and $\mu=$ Leb.
Example 1.6 (Piecewise affine interval maps). Let $\left\{a_{k}\right\}_{k}$ be a monotonic sequence with $a_{1}=1$ and $\lim _{k} a_{k}=0$. Then $f:[0,1] \rightarrow[0,1]$ with

$$
\left.f\right|_{\left[a_{k+1}, a_{k}\right)}=\frac{1}{a_{k}-a_{k+1}}\left(x-a_{k+1}\right)
$$

satisfies the assumptions above.
Example 1.7 (Gauss Map). Define the Gauss map $G:[0,1] \rightarrow[0,1]$ by

$$
G(x)=\left\{\begin{array}{lr}
\frac{1}{x}(\bmod 1) & x \in(0,1] \\
0 & x=0
\end{array}\right.
$$

It is a full-branched map. Let $\mu_{G}$ be the Gauss measure, it is the Gibbs measure for the potential $-\log D F$ with density $\frac{d \mu_{G}}{d L e b}=\frac{1}{(1+x) \log 2}$, then Theorem 1.2 holds for $\left(G, \mu_{G}\right)$.

Example 1.8 (An induced map). Let $F$ be the first return function to $\left[0, \frac{1}{2}\right.$ ) of a Manneville-Pomeau map $f:[0,1] \rightarrow[0,1]:$

$$
f(x)= \begin{cases}x\left(1+2^{a} x^{a}\right) & x \in\left[0, \frac{1}{2}\right) \\ 2 x-1 & x \in\left[\frac{1}{2}, 1\right]\end{cases}
$$

for $a \in(0,1)$. There exists $\mu_{F}$ a Gibbs measure with respect to the potential - $\log D F$ (see LSV99] or HNT12, $\S 13.2]$ )and is absolutely continuous with respect to the Lebesgue measure.

## 2 Preliminaries for Theorem 1.1

We consider the one-sided symbolic dynamics. Let $\mathcal{I}$ be an at most countably infinite alphabet, $A$ a $\mathbb{N} \times \mathbb{N}$ transition matrix of 0,1 entries and

$$
\Sigma_{A}=\left\{\underline{x}=\left(x_{0}, x_{1}, x_{2}, \ldots\right): x_{i} \in \mathcal{I}, A_{x_{i}, x_{i+1}}=1\right\}
$$

be the symbolic space. It is equipped with a metric $d(\cdot, \cdot)=d_{\theta}(\cdot, \cdot)$, for some $\theta \in(0,1)$, and

$$
d(\underline{x}, \underline{y})=\theta^{\underline{x} \wedge \underline{y}}, \quad \underline{x} \wedge \underline{y}:=\min \left\{j \geq 0: x_{j} \neq y_{j}\right\} .
$$

Without loss of generality, we may always assume $\theta=e^{-1}$. The shift space in question is denoted by $\left(\Sigma_{A}, \sigma, d\right)$, where the left shift map $\sigma$

$$
\sigma: \Sigma_{A} \rightarrow \Sigma_{A}, \quad\left(x_{0}, x_{1}, \ldots\right) \mapsto\left(x_{1}, x_{2}, \ldots\right)
$$

When $\mathcal{I}$ is finite the space $\left(\Sigma_{A}, d\right)$ is compact. A measure $\mu$ is $\sigma$-invariant if for all measurable $E \subseteq \Sigma_{A}$

$$
\mu(E)=\mu\left(\sigma^{-1} E\right)
$$

In dynamical systems literature, $\left(\Sigma_{A}, \sigma\right)$ is often referred to as a topological Markov chain.

### 2.1 General Definitions and Lemmas

First, we need the most basic notion of open sets in the symbolic space.
Definition 2.1 (Cylinders). A $k$-cylinder in $\Sigma_{A}$ is a subset set of the form

$$
\left[x_{0}, x_{1}, \ldots, x_{k-1}\right]=\left\{\underline{y} \in \Sigma_{A}: y_{i}=x_{i}, \forall i=0,1, \ldots, k-1\right\} .
$$

The set of all $k$-cylinders is denoted as $\mathcal{C}_{k}$. For any $\underline{x} \in \Sigma_{A}$, let $C_{k}(\underline{x})$ be the $k$-cylinder containing $\underline{x}$, i.e. $C_{k}(\underline{x})=\left[x_{0}, x_{1}, \ldots, x_{k-1}\right]$. Cylinders are generating in the sense that any subset in $\Sigma_{A}$ can be represented by a countable union of cylinders. Also, cylinders are also the open balls defined by the symbolic metric $d$.

Definition 2.2 (Rényi entropy). For each $n \in \mathbb{N}, t>0$, define the quantities

$$
Z_{n}(t)=\sum_{C \in \mathcal{C}_{n}} \mu(C)^{1+t}
$$

The Rényi entropy (with respect to the natural partition given by the alphabet $\mathcal{I}$ ) of the system is given by

$$
\begin{equation*}
H_{2}(\mu)=\lim _{n \rightarrow+\infty} \frac{\log Z_{n}(1)}{-n}, \tag{2.2}
\end{equation*}
$$

whenever this limit exists, and the generalised Rényi entropy function is

$$
\mathcal{R}_{\mu}(t)=\liminf _{n \rightarrow+\infty} \frac{\log Z_{n}(t)}{-t n}
$$

In the information theory context, this entropy is also called collision entropy for Bernoulli systems, as it reflects the probability of two i.i.d. random variables coinciding i.e. $H_{2}=-\log \sum_{i} p_{i}^{2}=-\log \mathbb{P}(X=Y)$.
Rényi entropy does not always exist, especially when the alphabet is not finite. For the finite alphabet case, Haydn and Vaienti proved in HV10, Theorem 1] that $\mathcal{R}_{\mu}(t)$ converges uniformly on compact subsets of $\mathbb{R}^{+}$for all weakly $\psi$-mixing invariant measures, in particular, if $\mu$ is a Gibbs measure, $H_{2}(\mu)=\mathcal{R}_{\mu}(1)=2 P_{\text {top }}(\phi)-P_{\text {top }}(2 \phi)$ where $P_{t o p}$ is the topological pressure. For infinite alphabet Markov chains, Rényi entropy is obtained in GGL11].

Definition 2.3. The system is said to be $\psi$-mixing, if there is some monotone decreasing function $\psi(\cdot): \mathbb{N} \rightarrow$ $[0, \infty)$ such that for all $n, k$, all $E \in \mathcal{C}_{n}$, and all $F \in \mathcal{C}^{*}$, where $\mathcal{C}^{*}=\bigcup_{j=0}^{\infty} \mathcal{C}_{j}$,

$$
\begin{equation*}
\left|\frac{\mu\left(E \cap \sigma^{-n-k} F\right)}{\mu(E) \mu(F)}-1\right| \leq \psi(k) \tag{2.3}
\end{equation*}
$$

A measure is called quasi-Bernoulli if there is some constant $B>1$ such that for any finite words $\mathbf{i}, \mathbf{j} \in \mathcal{C}^{*}$

$$
\mu([\mathbf{i} \mathbf{j}]) \leq B \mu([\mathbf{i}]) \mu([\mathbf{j}]) .
$$

Automatically, $\psi$-mixing entails the quasi-Bernoulli property.
Lemma 2.4. If the probability measure $\mu$ is $\psi$-mixing with $\psi(\cdot)$ summable, there exists constant $\rho \in(0,1)$ such that $\mu(C) \leq \rho^{n}$ for all $C \in \mathcal{C}_{n}$ and all $n$.

The proof is given for finite alphabet case in GS97] which remains valid for countable alphabet case.
Notation 2.5. For two sequences $\left\{a_{k}\right\}_{k},\left\{b_{k}\right\}_{k}$, the following notation is inherited from CGR09, Def 2.9]. Say $a_{k} \approx b_{k}$ if $\log a_{k}-\log b_{k}$ is bounded, or equivalently the ratio $\left|\frac{a_{k}}{b_{k}}\right|$ is uniformly bounded away from 0 and $+\infty$.
Say $a_{k} \preceq b_{k}$ if there is $\left\{c_{k}\right\}_{k}$ such that $a_{k} \leq c_{k}$ for all $k$, and $b_{k} \approx c_{k}$.
Both relations are transitive.
Notation 2.6. The following notation is also used.
(1) For each $\omega \in \mathbb{N}$ and any finite word $\left(x_{0}, x_{1}, \ldots, x_{k-1}\right)$ of length $k \geq 2$, the notation $\left(x_{0}, x_{1}, \ldots, x_{k}\right)^{\omega}$ means the word is repeated $\omega$-times whenever it is allowed.
(2) For any $\underline{x} \in \Sigma$, denote the $k$-word starting from position $m$ by $x_{m}^{k}=\left(x_{m}, x_{m+1}, \ldots, x_{m+k-1}\right)$.
(3) The indicator function of a set $E$ is denoted by $\mathbb{1}_{E}$.
(4) The expectation and variance of a random variable $X$ are denoted respectively by $\mathbb{E}[X]$ and $\operatorname{Var}[X]$.
(5) The cardinality of a set $E$ is denoted by $\# E$.

### 2.2 Thermodynamic Formalism for Gibbs Measures

In [CGR09] the authors considered the substring matching problem for a single point in a Markov subshift system, the relevant measure $\mu$ is Gibbsian with respect to a locally Hölder potential. In this section, we will provide conditions and lemmas which enable us to include certain types of countable Markov subshifts. The majority of references for this section can be found in [Sar99] and [Sar03].

Definition 2.7. A potential $\phi: \Sigma_{A} \rightarrow \mathbb{R}$ is called locally Hölder if there exists $M_{\phi}>0, \zeta \in(0,1)$ such that for all $k \geq 1, \operatorname{var}_{k}(\phi) \leq M_{\phi} \zeta^{k}$ where

$$
\operatorname{var}_{k}(\phi):=\sup \left\{|\phi(\underline{x})-\phi(\underline{y})|: x_{i}=y_{i}, \forall i \leq k-1\right\} .
$$

Definition 2.8. The system $\left(\Sigma_{A}, \sigma\right)$ is topologically mixing if for all $a, b \in \mathcal{I}$, there is $n_{0} \in \mathbb{N}$ such that for all $n>n_{0}$,

$$
[a] \cap \sigma^{-n}[b] \neq \emptyset .
$$

The system has big image and preimage property, if there is a finite subset $S \subseteq \mathcal{I}$ such that for any $a \in \mathcal{I}$, there are $b_{1}, b_{2} \in \mathcal{S}$ such that $\left[b_{1} a b_{2}\right] \neq \emptyset$. This condition is trivially satisfied for all subshifts of finite type.

Definition 2.9. Given a potential $\phi$ on $\Sigma_{A}$, a $\sigma$-invariant measure $\mu$ is said to be $G i b b s$ if there are constants $c_{\phi}>0, P \in \mathbb{R}$ such that for each $m \in \mathbb{N}$,

$$
\begin{equation*}
c_{\phi}^{-1} \leq \frac{\mu\left(C_{m}(\underline{x})\right)}{\exp \left(-m P+S_{m} \phi(\underline{x})\right)} \leq c_{\phi} \tag{2.4}
\end{equation*}
$$

where $S_{m} \phi(\underline{x})=\sum_{i=0}^{m-1} \phi\left(\sigma^{i} \underline{x}\right)$.
Definition 2.10. Let $\phi$ be a locally Hölder potential, the partition functions with respect to $\phi$ are defined by

$$
\begin{equation*}
P_{n}(\phi, a):=\sum_{\substack{\sigma_{n} \underline{x}=\underline{x} \\ x_{0}=a}} e^{S_{n}(\phi)(\underline{x})}, \tag{2.5}
\end{equation*}
$$

for each $a \in \mathcal{I}$, and the Gurevich pressure $P_{G}(\phi)$ :

$$
\begin{equation*}
P_{G}(\phi):=\lim _{n \rightarrow \infty} \frac{1}{n} \log P_{n}(\phi, a) . \tag{2.6}
\end{equation*}
$$

For topologically mixing countable subshifts, $P_{G}(\phi)$ exists and is independent of the symbol $a \in \mathcal{I}$ (Sar99, Theorem 1]).

The existence of Gibbs measure for a countable topological Markov subshift is characterised by the following theorem:

Theorem 2.11. SSar03, Theorem 1], Sar9s, Theorem 8] Let $\phi$ be a locally Hölder potential, $\left(\Sigma_{A}, \sigma, \mathcal{I}\right)$ topologically mixing, then $\phi$ has an invariant Gibbs measure $\mu$ if and only if the system satisfies the big image and preimage property and $P_{G}(\phi)<\infty$. In particular, let $\mathcal{L}_{\phi}$ be the Ruelle-Perron-Frobenius operator associated with $\phi$,

$$
\mathcal{L}_{\phi} f(\underline{x})=\sum_{\sigma \underline{y}=\underline{x}} e^{\phi(\underline{y})} f(\underline{y}),
$$

then $\lambda=e^{P_{G}(\phi)}$ is the eigenvalue of $\mathcal{L}_{\phi}$ and the eigenfunction $h$ is uniformly bounded from 0 and $\infty$, also $P_{G}(\phi)=P$ for $P$ in (2.4).

Remark 2.12. It is shown by Sar99, Theorem 3, Theorem 8] that the Gibbs measure given in Theorem [2.11 is the unique equilibrium state which realises the equality below

$$
P_{G}(\phi):=\sup \left\{h_{\nu}+\int \phi d \nu: \nu \text { is } \sigma \text { invariant and } \int \phi d \nu>-\infty\right\} .
$$

We will need the following lemmas for the proof of Theorem 1.1
Lemma 2.13. For subshifts of finite type or countable shifts satisfying the assumptions of Theorem 2.11, if $\mu$ is the (unique) Gibbs measure with respect to a locally Hölder potential $\phi$, it has exponential rate $\psi$-mixing for cylinders.

Proof. For $\mathcal{I}$ finite, one can verify exponential decay of $\psi$ with BR08, Proposition 1.14].
For countable $\mathcal{I}$, because the corresponding Gibbs measures for two comohologous Hölder potentials coincide, without loss of generality, one can assume $\mathcal{L}_{\phi} 1=1$, which implies $P_{G}(\phi)=0$ and the conformal measure $\nu$ identifies with the Gibbs measure $\mu$ on cylinders.
Firstly, by locally Hölder property of $\phi$, there is $M_{1}>0$ such that

$$
\begin{equation*}
\left|e^{S_{n} \phi(\underline{x})-S_{n} \phi(\underline{y})}-1\right| \leq M_{1} d(\underline{x}, \underline{y}) \tag{2.7}
\end{equation*}
$$

whenever there is $a \in \mathcal{I}$ such that $\underline{x}, \underline{y} \in[a]$
Also, as the invariant density is uniformly bounded from 0 and $+\infty$, there is $M_{2}>0$ such that for each $n$-cylinder $C \in \mathcal{C}_{n}$,

$$
\begin{equation*}
M_{2}^{-1} e^{S_{n} \phi} \leq \mu(C) \leq M_{2} e^{S_{n} \phi} \tag{2.8}
\end{equation*}
$$

Now define the norm for real-valued function $f$ acting on $\Sigma_{A}$,

$$
\|f\|_{L}:=\|f\|_{\infty}+D_{\beta} f
$$

where $\beta$ is the $\sigma$-algebra generated by $\{\sigma[a]: a \in \mathcal{I}\}$ and

$$
D_{\beta}:=\sup _{b \in \beta} \sup _{x, y \in b} \frac{|f(x)-f(y)|}{d(x, y)}
$$

The operator $\mathcal{L}_{\phi}: \operatorname{Lip}_{1, \beta} \rightarrow L$ where the spaces are defined by $\operatorname{Lip}_{1, \beta}:=\left\{f: \Sigma_{A} \rightarrow \mathbb{R}:\|f\|_{1}, D_{\beta} f \leq \infty\right\}$ and $L:=\left\{f: \Sigma_{A} \rightarrow \mathbb{R}:\|f\|_{L}<\infty\right\}$.
Consider $E=\left[e_{0}, e_{1}, \ldots, e_{n-1}\right] \in \mathcal{C}_{n}$ and $F \in \mathcal{C}^{*}$, as $\mathcal{L}_{\phi}^{*} \mu=\mu$,

& \left|\mu\left(E \cap \sigma^{-(n+k)} F\right)-\mu(E) \mu(F)\right|=\left|\int \mathbb{1}_{E} \cdot \mathbb{1}_{F} \circ \sigma^{n+k} d \mu-\int \mathbb{1}_{E} d \mu \int \mathbb{1}_{F} d \mu\right| \\
& \leq\left|\int \mathbb{1}_{F}\left(\left(\mathcal{L}_{\phi}^{n+k} \mathbb{1}_{E}\right)-\int \mathbb{1}_{E} d \mu\right) d \mu\right| \leq \mu(F)\left\|\mathcal{L}_{\phi}^{n+k} \mathbb{1}_{E}-\int \mathbb{1}_{F} d \mu\right\|_{\infty} \\
& \leq \mu(F)\left\|\mathcal{L}_{\phi}^{k}\left(\mathcal{L}_{\phi}^{n} \mathbb{1}_{E}\right)-\int \mathcal{L}_{\phi}^{n} \mathbb{1}_{E} d \mu\right\|_{L}
\end{aligned}
$$

It is a standard fact (see for example [AD07, Theorem 1.6] or Sar99, Theorem 5]) that there are $K_{\phi}>0$ and $\kappa \in(0,1)$ such that

Proof of claim. It is easy to see for each $E \in \mathcal{C}_{n}$ and $\underline{x} \in \Sigma_{A}$, there is (at most) only one $\underline{z} \in E=\left[e_{0}, e_{1}, \ldots, e_{n-1}\right]$ such that $\sigma^{n} \underline{z}=\underline{x}$, i.e.

$$

this gives $\mathcal{L}_{\phi}^{n} \mathbb{1}_{E} \leq \mu(E) M_{1} M_{2}$. and the claim is proved with $M_{3}=M_{2}\left(1+M_{1}\right)$.
The proof of lemma follows from the claim.

Now we will show that for countable topological Markov shifts, Rényi entropy of the Gibbs measure $\mu$ exists and is given by a formula involving the pressure function. The analogous statement for subshift of finite types is mentioned in HV10] and is easy to verify.

Lemma 2.14. Under the assumptions of Theorem 2.11, for $\mu$ the unique Gibbs measure with respect to $\phi$, the Rényi entropy $H_{2}(\mu)$ exists and is given by

Proof. Firstly, $H_{2}$ is clearly non-negative. By (2.4), for $B_{1}:=\sum_{k \geq 1} \operatorname{var}_{k}(\phi)$,

so $-\log Z_{n}(1)$ is almost subadditive, and the limit $\frac{\log Z_{n}(1)}{-n}$ exists, in particular, every subsequence converges to the same limit. Suppose $\underline{x}$ is a periodic point with period $k$, then for all $n$,

Since $S_{n k} \phi(\underline{x})=n S_{k} \phi(\underline{x})$ and both $P_{G}$ and $S_{k} \phi(x) / k$ are finite, we get $\limsup \sup _{n} \frac{\log Z_{n}(1)}{-n}<\infty$.
Combining the BIP property and locally Hölder property with [Sar99, Lemma 4] one can show that

$$

Also for each $C \in \mathcal{C}_{n}$, there is at most one $\underline{x} \in C$ such that $\sigma^{n} \underline{x}=\underline{x}$, thus

& \geq c_{\phi}^{-1} e^{-2 n P_{G}(\phi)} \sum_{\substack{\sigma^{n} \underline{x}=\underline{x} \in C \\
C \in \mathcal{C}_{n}, \bar{C} \subseteq[a]}} \exp \left(2 S_{n} \phi(\underline{x})\right)=c_{\phi}^{-1} e^{-2 n P_{G}(\phi)} P_{n}(2 \phi, a),
\end{aligned}
$$

which implies

$$
\liminf _{n \rightarrow \infty} \frac{1}{n} \log \sum_{C \in \mathcal{C}_{n}} \mu(C)^{2} \geq P_{G}(2 \phi)-2 P_{G}(\phi)
$$

Then putting the inequalities for limsup and liminf together,

H_{2}=\lim _{n \rightarrow+\infty} \frac{\log \sum_{C \in \mathcal{C}_{n}} \mu(C)^{2}}{-n}=2 P_{G}(\phi)-P_{G}(2 \phi)
$$

Remark 2.15. It is also easy to see that $H_{2}(\mu) \leq 2 h_{\nu}$ for all invariant probability measure $\nu$ : for all $\underline{x}$ and all $n \in \mathbb{N}$,

\frac{\log Z_{n}(1)}{-n} \leq \frac{2 \log \nu\left(C_{n}(\underline{x})\right)}{-n}

By the Shannon-McMillan-Breiman Theorem, the left hand side converges to $2 h_{\nu}$ for almost every $\underline{x}$, therefore $\lim \sup _{n} \frac{\log Z_{n}(1)}{-n} \leq h_{\nu}$. So the Rényi entropy is finite whenever the measure-theoretic entropy of $\nu$ is finite.

For simplicity, denote $\alpha=\frac{H_{2}}{2}$. The following lemma is crucial for approximating the values of $Z_{n}(t)$.

Lemma 2.16. For countable Markov shifts satisfying the assumptions of Theorem 2.11, for $\mu$ the invariant Gibbs measure, we have $\alpha>0$ and

The approximation formulae are from CGR09, Lemma 2.13]. They were originally proved for finite alphabets and the proof remains valid if one combines with HV10, Theorem 1 (IV)] which holds whenever the relevant measure admits exponential decay of cylinder measures.

## 3 Proof of Theorem 1.1

We will use dynamical Borel-Cantelli argument to show separately:

### 3.1 Upper Bound (3.1.1)

Proof. Set

As $M_{n}(\underline{x})=r_{n}$ implies the return time of some iterate of $\underline{x}$ under $\sigma$ to some $r_{n}$-cylinder is strictly less than $n$, we need to approximate the size of short return sets in the system in order to apply Borel-Cantelli Lemmas to obtain almost everywhere statements. Hence, as in [HV10] and [GR09], we intend to solve this by considering different cases of overlapping between $r_{n}$-substrings in $\underline{x}$.

## Overlapping Analysis

Let $r_{n}$ be given; if $r_{n}$ is not an integer, we simply take the closest integer since when $n \rightarrow+\infty, r_{n} \rightarrow+\infty$ it will not make any difference in terms of limiting behaviours. Let us define the following auxiliary sets.

In other words, it is the set of points whose return time of $\underline{x}$ to the $r_{n}$-cylinder containing itself is $k$, and

In order to obtain good estimates of $\mu\left(S_{k}\left(r_{n}\right)\right)$, we consider three separate cases according to the range of $k$.
Let

Let $\omega_{k}=\left\lfloor\frac{r_{n}}{k}\right\rfloor$ and $0 \leq \gamma_{k}<k$ so that $r_{n}=k \omega_{k}+\gamma_{k}$. Then if $\underline{x} \in \sigma^{-i} S_{k}\left(r_{n}\right), x_{j}=x_{l}$ if $j=l(\bmod k)$ for all $j, l \in\left[i, i+r_{n}+k-1\right]$, therefore $\sigma^{i} \underline{x}$ has the following form:

that is, a $k$-word $\left(x_{i}, \ldots, x_{i+k-1}\right)$ will be repeated fully for $\omega_{k}+1$ times, followed by a truncated $\gamma_{k}$-word with the same initial symbols. Also, for each $k \leq\left\lfloor r_{n} / 2\right\rfloor$, there is at least one $\ell=\ell_{k} \in\left[\left\lceil r_{n} / 4\right\rceil,\left\lfloor r_{n} / 2\right\rfloor\right]$ such that $\ell$ is a multiple of $k$, meaning that $\underline{x} \in \sigma^{-i} S_{k}\left(r_{n}\right) \subseteq \sigma^{-i} S_{\ell}\left(r_{n}\right)$ where the $\ell$ word is fully repeated $\omega_{\ell_{k}}+1 \leq 5$ times, i.e. we may interpret $\sigma^{i} \underline{x}$ as

where $\rho$ is a given by Lemma 2.4 As $r_{n} \leq \ell_{k} \omega_{\ell_{k}} \leq r_{n}+1, e^{-\alpha \ell_{k} \omega_{k}} \leq e^{-\alpha r_{n}}$, by definition of $r_{n}$,

For each $i \leq n-1$ and $1 \leq k \leq\left\lfloor r_{n} / 2\right\rfloor$, we can omit $\sigma^{-i} S_{k}\left(r_{n}\right)$ if $2 k \leq n-i-1$ to avoid overcounting the redundant terms because $\sigma^{-i} S_{k}\left(r_{n}\right) \subseteq \sigma^{-i} S_{2 k}\left(r_{n}\right)$, hence for $\Sigma_{0}$ we only need to consider points $\underline{x}$ such that $\sigma^{i} \underline{x}$ has short return time and $i \geq n-r_{n}$. As $r_{n}$ is in the scale of $\log n$, we may choose $n$ large such that $r_{n} \leq n^{1 / 2}$ so that by Lemma 2.16

In this case, $\underline{x} \in \sigma^{-i} S_{k}\left(r_{n}\right)$ implies $x_{j}=x_{l}$ if $j=l(\bmod k)$ for all $j, l \in\left[i, i+r_{n}+k-1\right]$, hence $\sigma^{i} \underline{x}$ has the form

that is, the $\left(r_{n}-k\right)$ word starting from $x_{i}$ is repeated three times, separated by two identical $\left(2 k-r_{n}\right)$ words. Hence by Lemma 2.16 and the quasi-Bernoulli property, the following upper bound for $\mu\left(\sigma^{-i} S_{k}\left(r_{n}\right)\right)$ holds:

& =B^{4} \sum_{k=\left\lfloor r_{n} / 2\right\rfloor+1}^{r_{n}}(n-k) e^{-\alpha\left(r_{n}+k\right)} \leq B^{6} e^{-\frac{3}{2} r_{n} \alpha} \sum_{k=\left\lfloor r_{n} / 2\right\rfloor+1}^{r_{n}}(n-k) \preceq r_{n} n e^{-\frac{3}{2} \alpha r_{n}} \\
& \leq \frac{n r_{n}}{(n \log n)^{3 / 2}} \leq \frac{n^{1 / 2} n}{(n \log n)^{3 / 2}} \leq \frac{1}{\log n}, \tag{3.4}
\end{align*}

$\Sigma_{2}:$ return time $r_{n}+1 \leq k \leq n-i-1$
In this case, $k-r_{N} \geq 1$ and $\underline{x} \in \sigma^{-i} S_{k}\left(r_{n}\right)$ implies $x_{i}^{r_{n}}$, the $r_{n}$-word starting from position $i$ of $\underline{x}$, is repeated from the $i+k$ entry without any overlapping with itself, i.e.

therefore

\Sigma_{2} \leq \sum_{k=r_{n}+1}^{n-1}(n-k) \mu\left(S_{k}\left(r_{n}\right)\right) \leq \sum_{k=r_{n}+1}^{n-1}(n-k)\left(1+\psi\left(k-r_{n}\right)\right) Z_{r_{n}}(1)
$$

Given that $(1+\psi(k))$ is monotonically decreasing in $k$,

& \leq(1+\psi(1)) e^{-2 \alpha r_{n}} n^{2} \leq \frac{1+\psi(1)}{(\log n)^{2}} \leq \frac{1+\psi(1)}{\log n} \tag{3.5}
\end{align*}

Then, combining $(3.2)-3.5$, there is some constant $K_{1}>0$ independent of $n$ such that

M_{n_{k}}(\underline{x}) \leq r_{n_{k}}
$$

which implies for all $k$ large enough,

$$
\frac{M_{n_{k}}(\underline{x})}{\log n_{k}} \leq \frac{1}{\alpha-\varepsilon}\left(1+\frac{\log \log n_{k}}{\log n_{k}}\right)
$$

Now taking the limsup of the inequality above, and since $M_{n}(\underline{x})$ is non-decreasing in $n$ for all $\underline{x}$, for each $n$, there is a unique $k$ such that $n_{k} \leq n<n_{k+1}$ with

\end{equation*}

the following inequality holds for all $\varepsilon>0$ small,

\lim _{k \rightarrow+\infty} \frac{\log n_{k+1}}{\log n_{k}}=1, \text { and } \lim _{k \rightarrow+\infty} \frac{\log \log n_{k}}{\log n_{k}}=0 .

Then (3.1.1) is proved by letting $\varepsilon \rightarrow 0$

### 3.2 Lower bound (3.1.2)

Proof. We apply a similar second-moment analysis as in the proof of [CGR09, Theorem 4.1]. Let

\end{equation*}
$$

which counts the number of times that $\underline{x}$ is belongs to some $\sigma^{-i} S_{k}\left(r_{n}\right)$. As $M_{n}(\underline{x})<r_{n}$ implies for all $0 \leq i \leq n-1,1 \leq k \leq n-i-1, \underline{x} \notin \sigma^{-i} S_{k}\left(r_{n}\right)$, and in particular not in the $\sigma^{-i} S_{k}\left(r_{n}\right)$ sets with $k \geq 2 r_{n}$, therefore

\left\{M_{n}(\underline{x})<r_{n}\right\} \subseteq\left\{S_{n}(\underline{x})=0\right\}
$$

and by Paley-Zygmund's inequality PZ32],

\mu\left(\left\{M_{n}(\underline{x})<r_{n}\right\}\right) \leq \mu\left(\left\{\mathcal{S}_{n}(\underline{x})=0\right\}\right) \leq \frac{\operatorname{Var}\left[\mathcal{S}_{n}\right]}{\mathbb{E}\left[\mathcal{S}_{n}^{2}\right]} \leq \frac{\operatorname{Var}\left[\mathcal{S}_{n}\right]}{\mathbb{E}\left[\mathcal{S}_{n}\right]^{2}} . \tag{3.8}
\end{equation*}
$$

By definition of $\sigma^{-i} S_{k}\left(r_{n}\right)$ with $k \geq 2 r_{n}$, this set corresponds to the set of points in which an $r_{n}$-word repeats itself at least once with at least an $r_{n}$ gap, therefore we have the following lower bound using the $\psi$-mixing property,

\mu\left(\left\{C_{r_{n}}\left(\sigma^{i} \underline{x}\right)=C_{r_{n}}\left(\sigma^{i+k} \underline{x}\right)\right\}\right) & =\mu\left(\sigma^{-i} S_{k}\left(r_{n}\right)\right)=\sum_{C \in \mathcal{C}_{r_{n}}} \mu\left(C \cap \sigma^{-k} C\right) \\
& \geq\left(1-\psi\left(k-r_{n}\right)\right) \sum_{C \in \mathcal{C}_{r_{n}}} \mu(C)^{2} \geq\left(1-\psi\left(r_{n}\right)\right) Z_{r_{n}}(1),
\end{aligned}
$$

therefore

$$
\begin{equation*}
\mathbb{E}\left[\mathcal{S}_{n}\right] \geq \frac{1}{2}\left(1-\psi\left(r_{n}\right)\right)\left(n-2 r_{n}\right)^{2} Z_{r_{n}}(1) \tag{3.9}
\end{equation*}
$$

Next, we need to consider

\begin{equation*}
\mathbb{E}\left[\mathcal{S}_{n}^{2}\right]=\sum_{i, j=0}^{n-2 r_{n}-1} \sum_{k=2 r_{n}}^{n-i-1} \sum_{l=2 r_{n}}^{n-j-1} \mu\left(\sigma^{-i} S_{k}\left(r_{n}\right) \cap \sigma^{-j} S_{l}\left(r_{n}\right)\right) . \tag{3.10}
\end{equation*}
$$

Define the index set

F:=\left\{(i, j, k, l) \in \mathbb{N}^{4}: 0 \leq i, j \leq n-2 r_{n}-1,2 r_{n} \leq k \leq n-i-1,2 r_{n} \leq l \leq n-j-1\right\},
$$

then

$$
\mathbb{E}\left[\mathcal{S}_{n}^{2}\right]=\sum_{(i, j, k, l) \in F} \mu\left(\sigma^{-i} S_{k}\left(r_{n}\right) \cap \sigma^{-j} S_{l}\left(r_{n}\right)\right),
$$

and the cardinality of $F$ satisfies

$$
\# F=\left(\sum_{i=2 r_{n}}^{n-2 r_{n}-1} n-i\right)\left(\sum_{j=2 r_{n}}^{n-2 r_{n}-1} n-j\right) \leq \frac{1}{4}\left(n-2 r_{n}\right)^{4} .
$$

Define the counting function by

\theta: F \rightarrow \mathbb{N}, \quad \theta(i, j, k, l)=\sum_{\substack{a \in\{i, i+k\} \\ b \in\{j, j+l\}}} \mathbb{1}_{\left(a-r_{n}, a+r_{n}\right)}(b),
$$

i.e. it counts the occurrences that two indices in $\{i, j, i+k, j+l\}$ are $r_{n}$-close to each other; $\theta>0$ translates to overlapping between some $r_{n}$ words, e.g. $|i-j|<r_{n}$ implies the $r_{n}$ word $x_{i}^{r_{n}}$ overlaps with the $r_{n}$ word $x_{j}^{r_{n}}$, and both $r_{n}$-strings are repeated later.
By our definition of $\mathcal{S}_{n}$, for each quadruple $(i, j, k, l)$, necessarily $k, l \geq 2 r_{n}$ which implies

\theta(i, j, k, l) \leq 2, \quad \forall(i, j, k, l) \in F,
$$

which allows us to split (3.10) again into 3 components,

where $F_{t}=\{(i, j, k, l) \in F: \theta(i, j, k, l)=t\}$.
Clearly,

\# F_{0} \leq \# F \leq \frac{1}{4}\left(n-2 r_{n}\right)^{4} .
$$

For each $(i, j, k, l) \in F_{1}$, if we fix any three indices, for example, if $i, j, k$ are fixed, $j+l$ can be $r_{n}$-close to either $i$ or $i+k$ as it is automatically $2 r_{n}$ - apart from $j$, hence there are at most $4 r_{n}$ choices for the remaining index l. Hence

and similarly if we fix any two of $i, j, k, l$ in $F_{2}$, there are at most $2 r_{n}^{2}$ choices for the remaining two indices, therefore

\# F_{2} \leq 2 r_{n}^{2}\left(n-2 r_{n}\right)^{2}
$$

## Contributions of indices in $F_{0}$ :

We will consider the sum over indices in $F_{0}$ first. Since $(i, j, k, l) \in F_{0}$ implies no overlapping, $\underline{x} \in \sigma^{-i} S_{k}\left(r_{n}\right) \cap$ $\sigma^{-j} S_{l}\left(r_{n}\right)$ implies $x_{i}^{r_{n}}=x_{i+k}^{r_{n}}$ and $x_{j}^{r_{n}}=x_{j+l}^{r_{n}}$ while the symbols in these two $r_{n}$-strings are independent, e.g. when $i+k<j, \underline{x}$ has the following form:

\sigma^{i} \underline{x}=\left(x_{i}^{r_{n}}, \ldots, x_{i+k}^{r_{n}}, x_{i+k+r_{n}}, x_{i+k+r_{n}+1}, \ldots, x_{j}^{r_{n}}, \ldots, x_{j+l}^{r_{n}} \ldots\right)=\left(x_{i}^{r_{n}}, \ldots, x_{i}^{r_{n}}, \ldots, x_{j}^{r_{n}}, \ldots, x_{j}^{r_{n}}, \ldots\right) .

Hence by $\psi$-mixing property

\mu\left(\sigma^{-i} S_{k}\left(r_{n}\right) \cap \sigma^{-j} S_{l}\left(r_{n}\right)\right) \leq\left(1+\psi\left(\gamma_{i j k l}\right)\right)^{3} Z_{r_{n}}(1)^{2}, \tag{3.11}
\end{equation*}
$$

where

$$
\gamma_{i j k l}=\min \left\{|a-b|-r_{n}: a, b \in\{i, j, i+k, j+l\}\right\} .
$$

Let $F_{0}^{\prime} \subseteq F_{0}$ be defined as

F_{0}^{\prime}:=\left\{(i, j, k, l) \in F_{0}: \gamma_{i j k l} \geq r_{n}\right\},
$$

and $F_{0}^{\prime \prime}:=F_{0} \backslash F_{0}^{\prime}$. Notice also that $\#\left(F_{0}^{\prime \prime}\right) \leq 2 r_{n}\left(n-2 r_{n}\right)^{3}$.
Define the notation for any $G \subseteq F$,

\mathbb{E}\left[\mathcal{S}_{n}^{2} \mid G\right]:=\sum_{i, j, k, l \in G} \mu\left(\sigma^{-i} S_{k}\left(r_{n}\right) \cap \sigma^{-j} S_{l}\left(r_{n}\right)\right) .

Then, using (3.11),

\mathbb{E}\left[\mathcal{S}_{n}^{2} \mid F_{0}^{\prime}\right]=\sum_{i, j, k, l \in F_{0}^{\prime}} \mu\left(\sigma^{-i} S_{k}\left(r_{n}\right) \cap \sigma^{-j} S_{l}\left(r_{n}\right)\right) \leq\left(n-2 r_{n}\right)^{4}(1+\psi(g))^{3} Z_{r_{n}}(1)^{2},
$$

By Lemma $2.13 \psi\left(r_{n}\right) \leq r_{n}^{-1}$ for all $n$ large enough, then

$$
\begin{align*}
& \left(1+\psi\left(r_{n}\right)\right)^{3}-\left(1-\psi\left(r_{n}\right)\right)^{2} \leq\left(1+\psi\left(r_{n}\right)\right)^{3}-\left(1-\psi\left(r_{n}\right)\right)^{3} \\
& =2 \psi\left(r_{n}\right)\left(2+2 \psi\left(r_{n}\right)^{2}+1-\psi\left(r_{n}\right)^{2}\right) \leq 2 r_{n}^{-1}\left(3+r_{n}^{-2}\right) \leq 8 r_{n}^{-1} \leq \frac{1}{\log n} \tag{3.12}
\end{align*}
$$

using (3.9) with (3.12), as $\#\left(F_{0}^{\prime}\right) \leq \frac{1}{4}\left(n-2 r_{n}\right)^{4}$, for some constant $K_{2}>0$.

$$
\begin{align*}
\frac{\mathbb{E}\left[\mathcal{S}_{n}^{2} \mid F_{0}^{\prime}\right]-\mathbb{E}\left[\mathcal{S}_{n}\right]^{2}}{\mathbb{E}\left[\mathcal{S}_{n}\right]^{2}} & \leq \frac{\left(n-2 r_{n}\right)^{4} Z_{r_{n}}(1)^{2}\left(\left(1+\psi\left(r_{n}\right)\right)^{3}-\left(1-\psi\left(r_{n}\right)\right)^{2}\right)}{\left(n-2 r_{n}\right)^{4}\left(1-\psi\left(r_{n}\right)\right)^{2} Z_{r_{n}}(1)^{2}} \\
& \leq \frac{\left(1+\psi\left(r_{n}\right)\right)^{3}-\left(1-\psi\left(r_{n}\right)\right)^{3}}{\left(1-\psi\left(r_{n}\right)\right)^{2}} \leq K_{2} \frac{1}{\log n}, \tag{3.13}
\end{align*}
$$

And for the sum over $F_{0}^{\prime \prime}$, the term $1+\psi\left(\gamma_{i j k l}\right)$ in (3.11) is uniformly bounded above by $1+\psi(0)$, and $1-\psi\left(r_{n}\right) \geq \frac{1}{2}$ for all $n$ sufficiently large, therefore

\frac{\mathbb{E}\left[\mathcal{S}_{n}^{2} \mid F_{0}^{\prime \prime}\right]}{\mathbb{E}\left[\mathcal{S}_{n}\right]^{2}} \approx \frac{r_{n}\left(n-2 r_{n}\right)^{3}(1+\psi(0))^{3} Z_{r_{n}}(1)^{2}}{\left(1-\psi\left(r_{n}\right)\right)^{2}\left(n-2 r_{n}\right)^{4} Z_{r_{n}}(1)^{2}} \preceq \frac{r_{n}}{n-2 r_{n}}
$$

hence for some $K_{3}>0$ and all $n$ sufficiently large,

\frac{\mathbb{E}\left[\mathcal{S}_{n}^{2} \mid F_{0}^{\prime \prime}\right]}{\mathbb{E}\left[\mathcal{S}_{n}\right]^{2}} \leq K_{3} \frac{1}{\log n} \tag{3.14}
\end{equation*}
$$

## Contributions of indices in $F_{1}$ :

Next, for $(i, j, k, l) \in F_{1}$, without loss of generality, suppose only $|i-j|=r<r_{n}, i<j$ and $i+k<j+l$. The other cases are treated exactly the same since the order of the $r_{n}$-strings does not have any effects on estimations of the upper bounds for $\mu\left(\sigma^{-i} S_{k}\left(r_{n}\right) \cap \sigma^{-j} S_{l}\left(r_{n}\right)\right)$.
An $\underline{x} \in \sigma^{-i} S_{k}\left(r_{n}\right) \cap \sigma^{-j} S_{l}\left(r_{n}\right)$ means $x_{i+r}=x_{j}, x_{i+r+1}=x_{j+1}, \ldots, x_{i+r_{n}}=x_{j+r}$, so $\sigma^{i} \underline{x}$ has the following form:

\sigma^{i} \underline{x}=\left(x_{i}^{r_{n}-r}, x_{j}^{r_{n}}, \ldots, x_{i}^{r_{n}}, \ldots, x_{j}^{r_{n}}, \ldots\right)=\left(x_{i}^{r}, x_{j}^{r_{n}-r}, x_{j+r_{n}}^{r}, \ldots, x_{i}^{r}, x_{j}^{r_{n}-r}, \ldots, x_{j}^{r_{n}-r}, x_{j+r_{n}}^{r}, \ldots\right) .

then using the quasi-Bernoulli property and Lemma 2.16 for $B>1$ the relevant quasi-Bernoulli constant,

C \in \mathcal{C}_{n_{n}}-r}} \mu(A)^{2} \mu(B)^{2} \mu(C)^{3}=C^{10} Z_{r}(1)^{2} Z_{r_{n}-r}(2) \\
& \preceq B^{10} e^{-4 \alpha r_{n}} e^{-3 \alpha\left(r_{n}-r\right)} \leq B^{10} e^{-3 \alpha r_{n}} .
\end{aligned}
$$

Recall that $r_{n}=\frac{1}{\alpha+\varepsilon}(\log n+\beta \log \log n)$ and

e^{-\alpha r_{n}}=\left(n(\log n)^{\beta}\right)^{-\frac{\alpha}{\alpha+\varepsilon}}=n^{-\frac{\alpha}{\alpha+\varepsilon}}(\log n)^{-\frac{\alpha \beta}{\alpha+\varepsilon}}

hence for all $n$ large enough such that

by (3.9) and (3.15) above, as $\beta<0$,

\frac{\mathbb{E}\left[\mathcal{S}_{n}^{2} \mid F_{1}\right]}{\mathbb{E}\left[\mathcal{S}_{n}\right]^{2}} & \preceq \frac{2 r_{n}\left(n-2 r_{n}\right)^{3} B^{10} e^{-3 \alpha r_{n}}}{\left(n-2 r_{n}\right)^{4}\left(1-\psi\left(r_{n}\right)\right)^{2} Z_{r_{n}}(1)^{2}} \\
& \approx \frac{r_{n} e^{-3 \alpha r_{n}}}{\left(n-2 r_{n}\right) e^{-4 \alpha r_{n}}}=\frac{1}{\alpha+\varepsilon} \frac{\log n+\beta \log \log n}{\left(n-2 r_{n}\right) e^{-\alpha r_{n}}} \\
& \preceq \frac{\log n}{\left(n-2 r_{n}\right) e^{-\alpha r_{n}}}=\frac{(\log n)^{1+\beta \frac{\alpha}{\alpha+\varepsilon}} n^{\frac{\alpha}{\alpha+\varepsilon}}}{n-2 r_{n}} \\
& \leq(\log n)^{\left(1+\beta\left(1-\frac{\varepsilon}{\alpha+\varepsilon}\right)\right)} .
\end{aligned}
$$

For all $0<\varepsilon \leq \alpha$ such that $1-\frac{\varepsilon}{\alpha+\varepsilon} \geq \frac{1}{2}$, one can choose

\beta=-4,
$$

hence

$$
1+\beta\left(1-\frac{\varepsilon}{\alpha+\varepsilon}\right) \leq-1
$$

which is sufficient to conclude that for some constant $K_{4}$,

## Contributions of indices in $F_{2}$ :

Finally for indices in $F_{2}$, it is enough to know that for any $\underline{x} \in \sigma^{-i} S_{k}\left(r_{n}\right) \cap \sigma^{-j} S_{l}\left(r_{n}\right)$ there is some $r_{n}$-word repeated twice, so we can bound the measure of $\sigma^{-i} S_{k}\left(r_{n}\right) \cap \sigma^{-j} S_{l}\left(r_{n}\right)$ for each $(i, j, k, l) \in F_{2}$ by

B^{4} \sum_{C \in \mathcal{C}_{r_{n}}} \mu(C)^{2} \approx B^{4} e^{-2 \alpha r_{n}} .
$$

by Lemma 2.16
Then for $\beta=-4$ and all $n$ verifying (3.15), as $\left(1-\psi\left(r_{n}\right)\right)$ is uniformly bounded from below, by (3.9),

\frac{\mathbb{E}\left[\mathcal{S}_{n}^{2} \mid F_{2}\right]}{\mathbb{E}\left[\mathcal{S}_{n}\right]^{2}} & \approx \frac{2 r_{n}^{2}\left(n-2 r_{n}\right)^{2} B^{4} e^{-2 \alpha r_{n}}}{\left(n-2 r_{n}\right)^{4}\left(1-\psi\left(r_{n}\right)\right)^{2} e^{-4 \alpha r_{n}}} \\
& \approx \frac{r_{n}^{2}}{\left(n-r_{n}\right)^{2} e^{-2 \alpha r_{n}}} \preceq \frac{n^{\frac{2 \alpha}{\alpha+\varepsilon}}}{\left(n-2 r_{n}\right)^{2}}(\log n)^{2+2 \beta \frac{\alpha}{\alpha+\varepsilon}} \\
& \leq(\log n)^{2\left(1+\beta\left(1-\frac{\varepsilon}{\alpha+\varepsilon}\right)\right)} \leq(\log n)^{-2},
\end{aligned}
$$

and it follows that for some constant $K_{5}>0$,

\frac{\mathbb{E}\left[\mathcal{S}_{n}^{2} \mid F_{2}\right]}{\mathbb{E}\left[\mathcal{S}_{n}\right]^{2}} \leq K_{5} \frac{1}{(\log n)^{2}} \tag{3.17}
\end{equation*}
$$

Then, combining (3.8) (3.107) (3.13)-(3.17), there is some constant $K_{6}>0$ such that

\mu\left(\left\{M_{n}<r_{n}\right\}\right) \leq K_{6} \frac{1}{\log n},
$$

hence we can repeat the trick of picking a subsequence $n_{k}=\left\lceil e^{k^{2}}\right\rceil$, and apply Borel-Cantelli Lemma to the sum $\sum_{k=1}^{\infty} \mu\left(\left\{M_{n_{k}}<r_{n_{k}}\right\}\right)<+\infty$, which means for all $k$ large enough,

\frac{M_{n_{k}}(\underline{x})}{\log n_{k}} \geq \frac{1}{\alpha+\varepsilon}\left(1-\frac{4 \log \log n_{k}}{\log n_{k}}\right),
$$

then taking the liminf on both sides and apply the arguments which validate (3.6),

\liminf _{n \rightarrow+\infty} \frac{M_{n}(\underline{x})}{\log n}=\liminf _{n \rightarrow+\infty} \frac{M_{n_{k}}(\underline{x})}{\log n_{k}} \geq \frac{1}{\alpha+\varepsilon},
$$

then (3.1.2) is verified by letting $\varepsilon \rightarrow 0$.

## 4 Gibbs-Markov interval maps.

This section is inspired by [BLR19], GRS22] and HNT12], and we will prove an asymptotic behaviour for $m_{n}(x)$ for $\mu$-almost every $x$, where the dynamics are interval maps with a Gibbs-Markov structure. Let us first define the measure theoretic dimension object.

Definition 4.1. Suppose $T: X \rightarrow X$ is a measurable map with respect on the probability space $(X, \mu)$. Define the upper and lower correlation dimension of $\mu$ by

\begin{aligned}
& \underline{D}_{2}(\mu)=\liminf _{r \rightarrow 0} \frac{\log \int \mu(B(x, r)) d \mu(x)}{\log r}, \\
& \bar{D}_{2}(\mu)=\limsup _{r \rightarrow 0} \frac{\log \int \mu(B(x, r)) d \mu(x)}{\log r}
\end{aligned}
$$

respectively, and simply write $D_{2}(\mu)$ when the two limits coincide.
Clearly, $D_{2}(m)=1$ for $m$ the Lebesgue measure.
Definition 4.2. Say the metric space ( $X, d$ ) satisfies the bounded local complexity condition if there exists $C_{0} \in \mathbb{N}$ such that for each $r>0$, there is $k(r)<\infty$, and $\left\{x_{1}^{r}, x_{2}^{r}, \ldots, x_{k(r)}^{r}\right\} \subseteq X$ such that

$$
X \subseteq \bigcup_{p=1}^{k(r)} B\left(x_{p}^{r}, r\right)
$$

and each $x \in X$ belongs to at most $C_{0}$ elements of $\left\{B\left(x_{p}^{r}, 2 r\right)\right\}_{p=1}^{k(r)}$.
Any compact subset of $\mathbb{R}$ has bounded local complexity: compact implies totally bounded which gives $k(r)<\infty$ for all $r$ and $C_{0}$ can be chosen to be 4 because one can choose an $r$-net such that $d\left(x_{i}^{r}, x_{j}^{r}\right) \geq r$ for $i \neq j \in$ $\{1, \ldots, k(r)\}$.

Definition 4.3. (Piecewise expanding interval map) Let $X$ be a closed interval in $\mathbb{R}, T: X \rightarrow X$ is a piecewise expanding interval map if there is a (at most) countable partition $\mathcal{P}=\left\{I_{1}, I_{2}, \ldots\right\}$ for $T$ such that $T$ is differentiable on each $I_{k}$ and there is a uniform constant $\gamma>0$ such that $\left|D T_{I_{k}}\right|>\gamma$. An $n$-cylinder $\left[x_{0}, x_{1}, \ldots, x_{n-1}\right]$ with respect to the partition $\mathcal{P}$ is given by

$$
\left[x_{0}, x_{1}, \ldots, x_{n-1}\right]=\bigcap_{i=0}^{n-1} T^{-i} P_{x_{i}}
$$

Then a point $x \in X$ has a symbolic representation $\underline{x}=\left(x_{0}, x_{1}, \ldots\right)$ if $x \in \bigcap_{i=0}^{\infty} T^{-i} P_{x_{i}}$. Denote $\mathcal{P}_{n}:=$ $\bigvee_{j=0}^{n-1} T^{-j} \mathcal{P}$.
We require the following conditions on the probability preserving system $(T, \mu)$.

- Say $T: X \rightarrow X$ has exponential decay of correlation for $\mathcal{B} \mathcal{V}$ against $L^{1}$ observables, where $\mathcal{B V}:=\{\varphi \in$ $L^{1}(m): \varphi$ has bounded variation. $\}$, if there is $\beta: \mathbb{N} \rightarrow \mathbb{R}$ with $\beta(n)=C_{1} e^{-c_{1} n}$ for some $C_{1}, c_{1}>0$, and for all $f, g: X \rightarrow \mathbb{R}, f \in \mathcal{B V}$ and $g \in L^{1}$,

\left|\int f \cdot g \circ T^{n} d \mu-\int f d \mu \int g d \mu\right| \leq\|f\|_{\mathcal{B} \mathcal{V}}\|g\|_{1} \beta(n)
$$

where the norm $\|f\|_{\mathcal{B} \mathcal{V}}:=\|f\|_{1}+T V(f)$, and $T V(f)$ stands for the total variation of $f$. In particular, if $f$ is an indicator function of some measurable $A \subseteq X,\|f\|_{\mathcal{B} \mathcal{V}}=2$ and $\|f\|_{1} \leq 1$.

- $T$ has bounded distortion, that is, there is $C_{b d}>0$ such that for all $x, y \in I \in \mathcal{P}_{n}$,

\frac{1}{C_{b d}} \leq \frac{D T^{n}(x)}{D T^{n}(y)} \leq C_{b d}
$$

Definition 4.4. (Gibbs-Markov maps) The map $T: X \rightarrow X$ is said to be Gibbs-Markov if

- $T(P)$ is a union of elements in $\mathcal{P}$ and $\left.T\right|_{P}$ is injective for all $P \in \mathcal{P}$.
- Let $d_{s}$ be the symbolic metric as, $d_{s}(\underline{x}, \underline{y})=e^{-\underline{x} \wedge \underline{y}}$. The map $\left.\log g\right|_{P}$ is Lipschitz with respect to $d_{s}$ for each $P \in \mathcal{P}$, where $g=\frac{d m}{d(m \circ T)}$.
- When the partition does in fact contains infinitely many continuous components, we assume there is $\delta_{0}$ such that $\left|T^{n}(I)\right| \geq \delta_{0}$ for all $I \in \mathcal{P}_{n}$, for all $n \geq 1$. Otherwise, $\delta_{0}$ is a positive constant such that $|I| \geq \delta_{0}$ for all $I \in \mathcal{P}$. This is also known as the big image property.

Remark 4.5. For a Gibbs-Markov map defined above one can check that there is a measure $\mu$ verifying the inequality for $n$-cylinders as (2.4) holds for $T$, and because the system is conjugate to a topological Markov shift satisfying the conditions of Theorem 2.11 the invariant density $h=d \mu / d m$ is bounded from 0 and $+\infty$.

Definition 4.6. The repeller $\Lambda$ of $T$ is defined as the following:

\Lambda:=\left\{x \in I: T^{k}(x) \in \bigcup_{P \in \mathcal{P}} P \text { for all } k \geq 0\right\}
$$

Before the proof our quantitative result for limiting behaviour of $m_{n}$, following the convention in GRS22, define the following quantities,

m_{n}^{\leq}(x):=\min _{\substack{0 \leq i<j<n \\
|i=j| \leq \alpha(n)}} d\left(T^{i} x, T^{j} x\right), \\
m_{n}^{>}(x):=\min _{\substack{0 \leq i<j<n \\
|i=j|>\alpha(n)}} d\left(T^{i} x, T^{j} x\right), \\
m_{n}^{\gg}(x):=\min _{\substack{0 \leq i \leq n / 3 \\
2 n / 3 \leq j<n}} d\left(T^{i} x, T^{j} x\right),
\end{gathered}
$$

Then, Theorem 1.2 can be rephrased as the following.
Theorem 4.7. Let $T: X \rightarrow X$ be a piecewise expanding map as Definition 4.3 with a Gibbs-Markov structure defined in Definition 4.4, and $\mu$ its invariant Gibbs measure admitting exponential decay of correlations for $\mathcal{B V}$ against $L^{1}$ observables, then one has

\limsup _{n \rightarrow \infty} \frac{\log m_{n}^{>}(x)}{-\log n} \leq \frac{2}{\underline{D}_{2}} \tag{4.1.1}
\end{equation*}
$$

If $\mu$ is absolutely continuous to Lebesgue measure $m, \underline{D}_{2}=\bar{D}_{2}=1$, and

$$
\begin{equation*}
\limsup _{n \rightarrow \infty} \frac{\log m_{n}^{\leq}(x)}{-\log n} \leq \frac{2}{D_{2}} \tag{4.1.2}
\end{equation*}
$$

for $\mu$-almost every $x \in \Lambda$. Then as $m_{n}(x)=\min \left\{m_{\frac{5}{n}}^{\leq}, m_{n}^{>}(x)\right\}$,

$$
\limsup _{n \rightarrow+\infty} \frac{\log m_{n}(x)}{-\log n} \leq \frac{2}{D_{2}}=2
$$

Theorem 4.8. For all Gibbs measures $\mu$, for $\mu$-almost every $x \in \Lambda$,

$$
\begin{equation*}
\liminf _{n \rightarrow \infty} \frac{\log m_{n}^{\gg}(x)}{-\log n} \geq \frac{2}{\bar{D}_{2}} \tag{4.2}
\end{equation*}
$$

Since $-\log m_{n} \geq-\log m_{n}^{\gg}$,

$$
\lim _{n \rightarrow \infty} \frac{\log m_{n}(x)}{-\log n} \geq \frac{2}{\bar{D}_{2}}
$$

for $\mu$-almost every $x \in \Lambda$.

Then these two theorems together imply Theorem 1.2 i.e. if $\mu$ is absolutely continuous to the Lebesgue measure $m$,

$$

$\mu$-almost every $x$.
Remark 4.9. The proof of (4.1.1) uses ideas from the proof of GRS22, Proposition 1.10], whereas the proof of (4.1.2) requires estimating the measures of sets of short return points. Along the proof one will see also that (4.1.1) and (4.2) hold for all Gibbs invariant measures with exponential decay of correlations and $D_{2}(\mu)>0$. For Gibbs acip $\mu$, the correlation dimension is well defined in the sense that $\bar{D}_{2}(\mu)=\underline{D}_{2}(\mu)=1$, because the invariant density with respect to Lebesgue measure $m$ is uniformly bounded hence $D_{2}(\mu)=D_{2}(m)$.
The following lemmas are analogous to GRS22, Lemma 3.1, Lemma 3.2], which can be proved by replacing their $\rho_{p}^{(r)}$ functions with indicator functions.

Lemma 4.10. For all $x, y \in X$, let $\mathbb{1}_{p, r}:=\mathbb{1}_{B\left(x_{p}^{r}, 2 r\right)}$, if $X$ has bounded local complexity defined in Definition 4.2,

$$
\mathbb{1}_{B(x, r)}(y) \leq \sum_{p=1}^{k(r)} \mathbb{1}_{p, r}(x) \mathbb{1}_{p, r}(y) \leq C_{0} \mathbb{1}_{B(x, 4 r)}(y)
$$

Lemma 4.11. The following equations hold.

\left\{\begin{array}{l}
\limsup _{r \rightarrow 0} \frac{\log \sum_{p=1}^{k(r)}\left(\int \mathbb{1}_{p, r} d \mu\right)^{2}}{\log r}=\bar{D}_{2}(\mu)  \tag{4.3.1}\\
\liminf _{r \rightarrow 0} \frac{\log \sum_{p=1}^{k(r)}\left(\int \mathbb{1}_{p, r} d \mu\right)^{2}}{\log r}=\underline{D}_{2}(\mu)
\end{array}\right.
$$

which means for any $\varepsilon>0$, there is $r_{0}>0$ such that for all $0<r<r_{0}$,

$$
\begin{equation*}
r^{\bar{D}_{2}+\varepsilon} \leq \sum_{p=1}^{k(r)}\left(\int \mathbb{1}_{p, r} d \mu\right)^{2} \leq r^{\underline{D}_{2}-\varepsilon} \tag{4.3.2}
\end{equation*}
$$

Also, for simplicity, the following definition is introduced.
Definition 4.12. A term is said to be admissible, which is a notion introduced by the authors of GRS22, if it has the form $r^{-k} g(n)$, for some $k \geq 0$ and a function $g$ which decays in $n$ faster than any polynomial of $n$, hence for any $k \in \mathbb{N}$, by 4.3.2 and choosing the scale of $r$ as in (4.4) below we can bound any admissible error by $\mathcal{O}\left(n^{-k}\right)$ for all $n$ large.

Now we can prove 4.1.1).

## Upper Bound

Proof of (4.1.1). Let $\varepsilon, r>0$ be given, in particular, $r$ should be small enough that it verifies (4.3.2). Define the random variable $\mathcal{S}_{n}^{>}$,

By Lemma4.10 $\left\{m_{n}^{>}(x) \leq r\right\} \subseteq\left\{\mathcal{S}_{n}^{>} \geq 1\right\}$. Therefore, by Markov's inequality and decay of correlation,

& \mu\left(x: \mathcal{S}_{n}^{>}(x) \geq 1\right) \leq \mathbb{E}\left[S_{n}^{>}\right]=\sum_{\substack{0 \leq i<j<n \\
j-i>\alpha(n)}} \sum_{p=1}^{k(r)} \int \mathbb{1}_{p, r}\left(T^{i} x\right) \mathbb{1}_{p, r}\left(T^{j} x\right) d \mu(x) \\
& \leq \sum_{\substack{0 \leq i<j<n \\
j-i>\alpha(n)}} \sum_{p=1}^{k(r)}\left(\left(\int \mathbb{1}_{p, r} d \mu\right)^{2}+\beta(\alpha(n))\left\|\mathbb{1}_{p, r}\right\|_{\mathcal{B} \mathcal{V}}\left\|_{\left.\mathbb{1}_{p, r} \|_{1}\right)} \leq \sum_{0 \leq i<j<n} r^{\underline{D}_{2}-\varepsilon}+\sum_{0 \leq i<j<n} \sum_{p=1}^{k(r)}\right\| \mathbb{1}_{p, r}\left\|_{\mathcal{B} \mathcal{V}}\right\| \mathbb{1}_{p, r} \|_{1} \beta(\alpha(n))\right. \\
& \leq n^{2} r^{\underline{D}_{2}-\varepsilon}+C_{1} e^{-c_{1}(\log n)^{2}} n^{2} \sum_{p=1}^{k(r)} 2 \mu\left(B\left(x_{p}, 2 r\right)\right) \\
& \leq n^{2} r^{\underline{D}_{2}-\varepsilon}+2 C_{0} C_{1} e^{-c_{1}(\log n)^{2}} n^{2} .
\end{aligned}
$$

The last inequality follows from the definition of bounded local complexity

$$
\sum_{p=1}^{k(r)} \mu\left(B\left(x_{p}, 2 r\right)\right)=\int \sum_{p=1}^{k(r)} \mathbb{1}_{p, r}(y) d \mu(y) \leq \int C_{0} d \mu(y)
$$

Then as $e^{-c_{1}(\log n)^{2}}$ decays faster than any polynomial of $n$, picking

r=r_{n}=\exp \left(-\frac{2+2 \varepsilon}{\underline{D}_{2}-\varepsilon}(\log n+\log \log n)\right) \leq n^{-\frac{2+2 \varepsilon}{\underline{D}_{2}-\varepsilon}} \tag{4.4}
\end{equation*}
$$

for all $n$ sufficiently large,

$$
n^{2} r_{n}^{D_{2}-\varepsilon}+2 C_{0} C_{1} n^{2} e^{-c_{1}(\log n)^{2}} \leq n^{-2 \varepsilon}+C_{1} e^{-c_{1}(\log n)^{2}} r_{n}^{-C_{2}} .
$$

The second term on the right is admissible by definition, meaning that there is some constant $C_{2}>0$ such that for all $n$ large enough that $n^{-\varepsilon} \leq \frac{1}{\log n}$ :

Therefore, eventually for $\mu$-almost every $x$,

\frac{\log m_{n_{k}}^{>}(x)}{-\log n_{k}} \leq \frac{2+\varepsilon}{\underline{D}_{2}-\varepsilon}\left(1+\frac{\log \log n_{k}}{\log n_{k}}\right) .
$$

Although $m_{n}^{>}$is not monotonically increasing, for each $n \in\left[n_{s}, n_{s+1}\right]$,

$$
\begin{aligned}
& -\log m_{n_{k+1}}^{\prime}(x):=-\log \min _{\substack{0 \leq i<j<n_{k+1} \\
j-i>\alpha\left(n_{k}\right)}} \geq-\log m_{n}^{>}(x) \\
& -\log m_{n_{k}}^{\prime \prime}(x):=-\log \min _{\substack{0 \leq i<j<n_{k} \\
j-i>\alpha\left(n_{k+1}\right)}} \leq-\log m_{n}^{>}(x),
\end{aligned}
$$

and one can show that for $\mu$-almost every $x$, for all $k$ large,

$$
\frac{-\log m_{n_{k}}^{\prime}(x)}{\log n_{k}} \leq \frac{2+\varepsilon}{\underline{D}_{2}-\varepsilon}\left(1+\frac{\log \log n_{k}}{\log n_{k}}\right),
$$

and

$$
\frac{-\log m_{n_{k}}^{\prime \prime}(x)}{\log n_{k}} \leq \frac{2+\varepsilon}{\underline{D}_{2}-\varepsilon}\left(1+\frac{\log \log n_{k}}{\log n_{k}}\right),
$$

then the limit can be passed to the whole tail of $m_{n}^{>}$, and (4.1.1) is proved.
Remark 4.13. Note also that for $|i-j|$ large, the measure of the sets $\left\{x: d\left(T^{i} x, T^{j} x\right)<r\right\}$ scales like $r^{D_{2}}$ which is similar to the behaviour of the sequence matching problem in the symbolic setting, and this matches our intuition because $D_{2}(\mu)$ is analogous to $H_{2}$ in many ways.

To prove (4.1.2), we are dealing with iterates of $x$ which return to an $r$-neighborhood of itself within $\alpha(n)$ units of time, that is, we need to approximate the measure of some short return sets as those $S_{m}(k)$ sets defined in section 3.1 for the symbolic case. But we cannot expect a similar upper bound for short returns as in (3.3) or (3.4). This is because for symbolic structures, an $r_{n}$-cylinder is itself an $r_{n}$ open ball with respect to the symbolic metric, so analysing the returns is equivalent to analysing the repetition of letters in cylinders and one does not need to consider the case that two iterates $\sigma^{i} \underline{x}, \sigma^{j} \underline{x}$ are close to the boundaries of two open balls with a common boundary but they belong to different cylinders.
For interval maps, although the Gibbs-Markov structure prescribes a natural partition hence a way to define cylinders, metric balls and symbolic cylinders are different object so one need to take more caution and include the case that two points belong to different cylinders $U, V \in \mathcal{P}_{n}$ but they accumulate on a common boundary of $U, V$ with distance smaller than the contraction scale of $n$-cylinders.

The measures of the short return sets are approximated by the following lemma for absolutely continuous Gibbs measures

Lemma 4.14. [HNT12, Lemma 3.4] Define the sets

$$
\mathcal{E}_{n}(\epsilon):=\left\{x \in X:\left|x-T^{n} x\right| \leq \epsilon\right\} .
$$

Then for $T$ satisfying Gibbs-Markov property and the invariant Gibbs measure $\mu$ absolutely continuous with respect to the Lebesgue measure $m$ with exponential decay of correlation for $\mathcal{B V}$ against $L^{1}$ observables, there is some constant $C_{3}$ such that for all $n \in \mathbb{N}$ and $\epsilon$ small enough,

\mu\left(\mathcal{E}_{n}(\epsilon)\right) \leq C_{3} \epsilon .
$$

Proof. The original lemma states that $m\left(\mathcal{E}_{n}(\epsilon)\right)=\mathcal{O}(\epsilon)$, and since $m$ is equivalent to $\mu$ on $\Lambda$ with $d \mu / d m$ bounded away from 0 and $+\infty$, there is a uniform constant $C_{\mu}$ such that

C_{\mu}^{-1} m(A) \leq \mu(A) \leq C_{\mu} m(A)
$$

for each measurable $A$, therefore there is some $C_{3}>0$ such that

$$
\mu\left(\mathcal{E}_{n}(\epsilon)\right) \leq C_{3} \epsilon .
$$

Proof of (4.1.2). Define the random variable $\mathcal{S}_{n}^{\leq}$by

\mathcal{S}_{n}^{\leq}(x):=\sum_{i=0}^{n-1} \sum_{k=1}^{\alpha(n) \wedge(n-i-1)} \mathbb{1}_{B\left(T^{i} x, r\right)}\left(T^{i+k} x\right),
$$

where $a \wedge b=\min \{a, b\}$.
As $\left\{x: \mathbb{1}_{B\left(T^{i} x, r\right)}\left(T^{i+k} x\right)=1\right\} \subseteq\left\{x: T^{i} x \in \mathcal{E}_{k}(r)\right\}=T^{-i} \mathcal{E}_{k}(r)$, using the Markov inequality and Lemma 4.14 we obtain the following bound

\mu\left(\mathcal{S}_{n}^{\leq} \geq 1\right) \leq \mathbb{E}_{m}\left[\mathcal{S}_{n}^{\leq}\right] \leq \sum_{i=0}^{n-1} \sum_{k=1}^{\alpha(n) \wedge(n-i-1)} \mu\left(T^{-i} \mathcal{E}_{k}(r)\right) \leq n \alpha(n) C_{3} r
$$

Pick $r=r_{n}$ as in (4.4), for all $n$ large enough such that

$$
\alpha(n)=(\log n)^{2} \leq n^{\frac{\varepsilon}{2-\varepsilon}}, \quad n^{-\frac{\varepsilon}{2-\varepsilon}} \leq \frac{1}{\log n}
$$

As the invariant density $d \mu / d m$ is uniformly bounded, $D_{2}(\mu)=1<2$, one has

$$
\mu\left(x: m_{n}(x) \leq r_{n}\right) \leq C_{3} n^{1+\frac{\varepsilon}{2-\varepsilon}} r \leq n^{\frac{2}{2-\varepsilon}} C_{3} n^{-\frac{2+2 \varepsilon}{\underline{D}_{2}-\varepsilon}} \leq C_{3} n^{-\frac{\varepsilon}{2-2 \varepsilon}} \leq \frac{C_{3}}{\log n} .
$$

Therefore, by picking a subsequence $n_{k}=\left\lceil e^{k^{2}}\right\rceil$, by Borel-Cantelli Lemma, we have that $\mu\left\{x: m_{n_{k}} \leq\right.$ $r_{n_{k}}$ for infinitely many $\left.k\right\}=0$, for $\mu$-almost every $x$, for all $k$ large enough,

$$
m_{n_{k}}^{\leq}(x) \geq r_{n_{k}}
$$

and one can apply the arguments used to validate
eqrefineqn:3.1.1 to obtain (4.1.2) for $\mu$-almost every $x$.
Remark 4.15. The condition that $\mu$ is an acip may be not sharp; if $\tilde{\mu}$ is another Gibbs measure with exponential decay of correlation and satisfying $\tilde{\mu}\left(\mathcal{E}_{k}(\epsilon)\right)=\mathcal{O}(\epsilon)$, then Theorem 4.7 remains valid.

As in the symbolic case the proof for the lower bound of $\frac{\log m_{n}(x)}{-\log n}$ is slightly more complicated and also requires a second-moment computation which exploits the following notion of mixing.

Lemma 4.16. A Gibbs-Markov interval map $(T, \mu)$ has exponential 4 - mixing, that is, for $a<b \leq c$ in $\mathbb{N}$, there are $C_{1}^{\prime}, c_{1}^{\prime}>0$ such that for any $f_{1}, f_{2} \in \mathcal{B V}, g_{1}, g_{2} \in L^{\infty}$, such that

$$
\left|\int f_{1} \cdot f_{2} \circ T^{a} \cdot g_{1} \circ T^{b} \cdot g_{2} \circ T^{c} d \mu-\int f_{1} \cdot g_{1} \circ T^{a} d \mu \int f_{2} \cdot g_{2} \circ T^{c-b} d \mu\right| \leq C_{1}^{\prime} e^{-c_{1}^{\prime}(b-a)}
$$

The constant $C_{1}^{\prime}$ depends on the functions $f_{1}, f_{2}, g_{1}, g_{2}$.
In particular, for any given $r>0,0 \leq p, q \leq k(r)$, $f_{1}=g_{1}=\mathbb{1}_{p, r}, f_{2}=g_{2}=\mathbb{1}_{q, r}$, the constant $C_{1}^{\prime}=$ $C_{1}^{\prime}\left(f_{1}, f_{2}, g_{1}, g_{2}\right)$ does not depend on $r$.

Proof. Consider the transfer operator $\mathcal{L}$ associated with the Hölder potential $\varphi$, that acts on the space of functions of bounded variation of $X, \mathcal{B V}=\mathcal{B} \mathcal{V}(X)$,

$$
\mathcal{L}=\mathcal{L}_{\varphi}: \mathcal{B V} \rightarrow \mathcal{B} \mathcal{V}, \quad \mathcal{L}_{\varphi} f(x)=\sum_{T y=x} e^{\varphi(y)} f(y)
$$

Let $\nu$ be the conformal measure of $\mathcal{L}$ and $h$ the invariant density, $\frac{d \mu}{d \nu}=h$. By the following well-known fact, (see for example Kel84, (3)]) for mixing Gibbs-Markov maps, there are $C_{\mathcal{B} \mathcal{V}}>0, \kappa \in(0,1)$ such that for any $f \in \mathcal{B} \mathcal{V}$,

for all $f \in \mathcal{B} \mathcal{V}$, there is

= & \left|\int \mathcal{L}^{b-a}\left(h f_{1} f_{2} \circ T^{a}\right) g_{1} \circ T^{a} g_{2} \circ T^{c-b+a} d \nu-\int \mathcal{L}^{a}\left(h f_{1}\right) f_{2} d \nu \int h g_{1} \circ T^{a} g_{2} \circ T^{c-b+a} d \nu\right| \\
= & \left|\int\left(\mathcal{L}^{b-a}\left(\mathcal{L}^{a}\left(h f_{1}\right) f_{2}\right)-h \int \mathcal{L}^{a}\left(h f_{1}\right) f_{2} d \nu\right) g_{1} \circ T^{a} g_{2} \circ T^{c-b+a} d \nu\right| \\
\leq & \left\|\mathcal{L}^{b-a}\left(\mathcal{L}^{a}\left(h f_{1}\right) f_{2}\right)-h \int \mathcal{L}^{a}\left(h f_{1}\right) f_{2} d \nu\right\|_{1}\left\|g_{1}\right\|_{\infty}\left\|g_{2}\right\|_{\infty} \\
\leq & C_{\mathcal{B} \mathcal{V}} \cdot \kappa^{b-a}\left\|\mathcal{L}^{a}\left(h f_{1}\right) f_{2}\right\|_{\mathcal{B} \mathcal{V}}\left\|g_{1}\right\|_{\infty}\left\|g_{2}\right\|_{\infty}, \tag{*}
\end{align*}

where the first equality holds by the invariance of $\mu$. As $\mathcal{L}^{a} h f_{1}$ is of bounded variation because $h$ is of bounded variation, and the product of functions in $\mathcal{B V}$ has bounded variation, the first part of the lemma is proved.

As $\min \{j, t\}-\max \{i, s\} \geq \frac{n}{3}$, by Lemma 4.16 and invariance, one obtains the following upper bound for each such quadruple $(i, j, s, t)$ :

\leq \sum_{p, q}\left(R_{p} R_{q}+2 \beta(\alpha(n))\right) \int \mathbb{1}_{p, r}(x) \mathbb{1}_{q, r}\left(T^{s-i} x\right) d \mu(x)+C_{1}^{\prime} e^{-c_{1}^{\prime} \frac{n}{3}} r^{-2 C_{0}^{\prime}},

and this can be bounded by the following up to an admissible error using Cauchy-Schwarz inequality,

& =\frac{6 \alpha(n)\left(\frac{n}{3}\right)^{3} C_{0}\left(\sum_{p} R_{p}^{2}\right)^{\frac{3}{2}}}{n\left(\left(\sum_{p} R_{p}^{2}\right)^{1 / 2}-4 \beta(\alpha(n))\left(\sum_{p} R_{p}^{2}\right)^{-1 / 2}-4 \beta(\alpha(n))^{2}\left(\sum_{p} R_{p}^{2}\right)^{-3 / 2}\right)} \\
& \leq \frac{6 C_{0} \alpha(n)}{n\left(\left(r^{D_{2}+\varepsilon}\right)^{1 / 2}-\mathcal{O}\left(n^{-1}\right)\right)}=\frac{6 C_{0} \alpha(n)}{n\left(\left(n^{-1+2 \varepsilon}-\mathcal{O}\left(n^{-1}\right)\right)\right.} \\
& \leq \frac{C_{5} n^{\varepsilon}}{n \cdot n^{-1+2 \varepsilon}}=\frac{C_{5}}{n^{\varepsilon}} . \tag{4.10}

& \leq \frac{36 C_{0} n^{2 \varepsilon}}{n^{2}\left(r^{\bar{D}}+\varepsilon-\mathcal{O}\left(n^{-2}\right)\right)} \\

The proof of (4.2) is yet complete because $m_{n}^{\gg}$ is not a monotone sequence, but for each $n \in\left[n_{k}, n_{k+1}\right]$,

$$
-\log m_{n}^{\gg}(x) \geq-\log \min _{\substack{0 \leq i \leq n_{k} \\ 2 n_{k+1} / 3 \leq j<n_{k}}} d\left(T^{i} x, T^{j} x\right)=:-\log m_{n_{k}}^{*}(x),
$$

and as for all $k, m_{n_{k+1}}^{\gg}(x) \leq m_{n_{k}}^{*}(x)$, repeating the same proof we have done for $m_{n}^{\gg}$ one can also show that $\lim \inf _{k \rightarrow \infty} \frac{\log m_{n_{k}}^{*}}{\log n_{k}} \geq \frac{2-4 \varepsilon}{\bar{D}_{2}+\varepsilon}$ whence the lower bound will be passed to the entire tail of $-\log m_{n_{k}}^{>}(x)$ and hence $-\log m_{n}(x)$, which implies

$$
\liminf _{n \rightarrow \infty} \frac{\log m_{n}(x)}{-\log n} \geq \frac{2}{\bar{D}_{2}}
$$

for $\mu$-almost every $x$ by sending $\varepsilon \rightarrow 0$.
Remark 4.17. (4.1.1) and (4.2) still hold if decay of correlations is exponential with respect to other Banach function spaces $\mathcal{B}, \mathcal{B}^{\prime}$, for example, both observables are in $\mathcal{B} \mathcal{V}$ or Lip, where Lip:=\{f $\in C(X): f$ is Lipschitz $\}$, as long as $\beta(\alpha(n))\left\|\mathbb{1}_{p, r}\right\|_{\mathcal{B}}\left\|_{\mathbb{1}_{q, r}}\right\|_{\mathcal{B}^{\prime}}$ remains an admissible term. For example, if the system has decay of correlations for Lipschitz observables, one can replace $\mathbb{1}_{p, r}$ functions with $\left\{\rho_{p}^{r}\right\}_{p=1}^{k(r)}$, a set of discretisation functions defined in [GRS22], although it requires more machinery to adjust the proof for (4.2) and Lemma4.16. Also, instead of exponential decay of correlations, the proof remains valid under stretched exponential decay by manipulating the scale of $k$ in $\alpha(n)=(\log n)^{k}$.
