# FINITISTIC SPACES WITH ORBIT SPACE A PRODUCT OF PROJECTIVE SPACES

#### Abstract

Let $G=\mathbb{Z}_{2}$ act freely on a finitistic space $X$. If the $\bmod 2$ cohomology of $X$ is isomorphic to the real projective space $\mathbb{R P}^{2 n+1}$ (resp. complex projective space $\mathbb{C P}^{2 n+1}$ ) then the mod 2 cohomology of orbit spaces of these free actions are $\mathbb{R P}^{1} \times \mathbb{C P}^{n}$ (resp. $\mathbb{R P}^{2} \times \mathbb{H}^{P^{n}}$ ) [7]. In this paper, we have discussed converse of these result. We have showed that if the mod 2 cohomology of the orbit space $X / G$ is $\mathbb{R P}^{1} \times \mathbb{C P}^{n}$ (resp. $\mathbb{R P}^{2} \times \mathbb{H P}^{n}$ ) then the mod 2 cohomology of $X$ is $\mathbb{R P}^{2 n+1}$ or $\mathbb{S}^{1} \times \mathbb{C P}^{n}$ (resp. $\mathbb{C P}^{2 n+1}$ or $\left.\mathbb{S}^{2} \times \mathbb{H} \mathbb{P}^{n}\right)$.

A partial converse of free involutions on the product of projective spaces $\mathbb{R} \mathbb{P}^{n} \times \mathbb{R}^{2 m+1}$ (resp. $\mathbb{C P}^{n} \times \mathbb{C P}^{2 m+1}$ ) are also discussed.


## 1. Introduction

Let $G$ be a compact Lie group acting on a space $X$. An interesting problem is to classify $X$ when $G$ acts freely on $X$ and the orbit space $X / G$ is known. First, J. C. Su [9 worked in this direction. He proved that if $G=\mathbb{Z}_{2}$ or $\mathbb{S}^{1}$, acts freely on a space $X$ and the orbit space $X / G$ is the $\bmod 2$ or integral cohomology projective space $\mathbb{F} \mathbb{P}^{n}, \mathbb{F}=\mathbb{R}$ or $\mathbb{C}$, then the space $X$ is the $\bmod 2$ cohomology $n$-sphere $\mathbb{S}^{n}$ or integral cohomology $(2 n+1)$-sphere $\mathbb{S}^{2 n+1}$. Su also proved that if $G=\mathbb{Z}_{q}, q$ an odd prime, and $X / G=L_{q}^{2 n+1}$ (lens space) then $X$ is the $\bmod q$ cohomology $(2 n+1)$-sphere $\mathbb{S}^{2 n+1}$. It has also been proved that if $G=\mathbb{S}^{3}$ and $X / G=\mathbb{H}^{n}$ (quaternion projective space), then $X$ is either integral cohomology $\mathbb{S}^{4 n+3}$ or $\mathbb{S}^{3} \times \mathbb{H} \mathbb{P}^{n}$ [4]. Harvey [2] proved that for semi-free actions of $G=\mathbb{S}^{1}$ when the orbit space $X / G$ is a simply connected 4 -manifold, then the total space is a simply connected 5 -manifold.

The orbit spaces of free actions of $G=\mathbb{Z}_{2}$ on projective spaces $X=\mathbb{F} \mathbb{P}^{2 n+1}$ and the product of projective spaces $X=\mathbb{F P}^{n} \times \mathbb{F P}^{m}$, where $\mathbb{F}=\mathbb{R}$ or $\mathbb{C}$, have been discussed in [7] [8]. For $G=\mathbb{Z}_{2}$ and $X=\mathbb{R P}^{2 n+1}$ (resp. $\mathbb{C P}^{2 n+1}$ ), it is proved that the mod 2 cohomology of the orbit space $X / G$ is $\mathbb{R P}^{1} \times \mathbb{C P}^{n}\left(\right.$ resp. $\left.\mathbb{R P}^{2} \times \mathbb{H P}^{n}\right)$ [7]. We have discussed converse

[^0]of these results. We have determined the cohomology classification of a finitistic space $X$ if the $\bmod 2$ cohomology of orbit space $X / G$ is $\mathbb{R P}^{1} \times \mathbb{C P}^{n}$ or $\mathbb{R P}^{2} \times \mathbb{H} \mathbb{P}^{n}$. For $G=\mathbb{Z}_{2}$ and $X=\mathbb{R P}^{n} \times \mathbb{R P}^{2 m+1}\left(\right.$ resp. $\left.\mathbb{C P}^{n} \times \mathbb{C P}^{2 m+1}\right)$, one of the possibilities of the $\bmod 2$ cohomology of the orbit space is $\mathbb{R P}^{1} \times \mathbb{R P}^{n} \times \mathbb{C P}^{m}$ (resp. $\mathbb{R P}^{2} \times \mathbb{C P}^{n} \times \mathbb{H} \mathbb{P}^{m}$ ) [8]. In this paper, we have also determined $X$ equipped with a free action of $G$ when the $\bmod 2$ cohomology of the orbit space $X / G$ is $\mathbb{R} \mathbb{P}^{1} \times \mathbb{R P}^{n} \times \mathbb{C P}^{m}$ or $\mathbb{R}^{2} \times \mathbb{C P}^{n} \times \mathbb{H}^{P}$. This gives a partial converse of results proved in [8].

All spaces are assumed to finitistic connected spaces. Recall that a paracompact Hausdorff space $X$ is said to be finitistic if every open cover of $X$ has a finite dimensional open refinement. All compact spaces and all finite dimensional paracompact spaces are finitistic spaces. We have considered Čech cohomology with coefficients in $\mathbb{Z}_{2}$. Throughout the paper, $X \sim_{2} Y$ means $H^{*}\left(X ; \mathbb{Z}_{2}\right) \cong H^{*}\left(Y ; \mathbb{Z}_{2}\right)$. We have proved the following results:

Theorem 1.1. Let $G=\mathbb{Z}_{2}$ act freely on a finitistic connected space $X$ with $X / G \sim_{\mathbb{Z}_{2}}$ $\mathbb{R P}^{1} \times \mathbb{C P}^{n}$. Then either $X \sim_{\mathbb{Z}_{2}} \mathbb{S}^{1} \times \mathbb{C P}^{n}$ or $X \sim_{\mathbb{Z}_{2}} \mathbb{R P}^{2 n+1}$.

Theorem 1.2. Let $G=\mathbb{Z}_{2}$ act freely on a finitistic connected space $X$ with $X / G \sim_{2}$ $\mathbb{R} \mathbb{P}^{2} \times \mathbb{H} \mathbb{P}^{n}$. Then $X \sim_{2} \mathbb{S}^{2} \times \mathbb{H} \mathbb{P}^{n}$ or $X \sim_{2} \mathbb{C P}^{2 n+1}$.

Theorem 1.3. Let $G=\mathbb{Z}_{2}$ act freely on a finitistic connected space $X$ with $X / G \sim_{2}$ $\mathbb{R P}^{1} \times \mathbb{R} \mathbb{P}^{n} \times \mathbb{C P}^{m}$ and $\pi_{1}\left(B_{G}\right)$ act trivially on $H^{*}(X)$. Then the cohomology algebra of $X$ is one of the following:
(i) $\mathbb{Z}_{2}[x, y, z] /\left\langle x^{n+1}, y^{m+1}, z^{2}+\alpha x^{2}+\beta y\right\rangle$, where $\operatorname{deg} x=\operatorname{deg} z=1, \operatorname{deg} y=2$ and $\alpha, \beta \in \mathbb{Z}_{2}$;
(ii) $\mathbb{Z}_{2}[x, y, z] /\left\langle x^{2}, y^{m+1}, z^{2}+\alpha y^{n}\right\rangle$, where $\operatorname{deg} x=1, \operatorname{deg} y=2, \operatorname{deg} z=n, \alpha \in \mathbb{Z}_{2}$ and $\alpha=0$ if $n>m$.

Theorem 1.4. Let $G=\mathbb{Z}_{2}$ act freely on a finitistic connected space $X$ with $X / G \sim_{2}$ $\mathbb{R P}^{2} \times \mathbb{C P}^{n} \times \mathbb{H}^{m}$ and $\pi_{1}\left(B_{G}\right)$ acts trivially on $H^{*}(X)$. Then the cohomology algebra of $X$ is isomorphic to

$$
\mathbb{Z}_{2}[x, y, z] /\left\langle x^{n+1}, y^{m+1}, z^{2}+\alpha x^{2}+\beta y\right\rangle,
$$

where $\operatorname{deg} x=2, \operatorname{deg} y=4, \operatorname{deg} z=2$ and $\alpha, \beta \in \mathbb{Z}_{2}$.

## 2. Preliminaries

In this section, we have recalled some results and definitions which are used to prove our main results.

Let $G$ be a compact Lie group and $G \hookrightarrow E_{G} \rightarrow B_{G}$ be the universal principal $G$ bundle, where $B_{G}$ is the classifying space. Suppose $G$ acts freely on a finitistic space $X$. The associated bundle $X \hookrightarrow\left(X \times E_{G}\right) / G \rightarrow B_{G}$ is a fibre bundle with fibre $X$. Put $X_{G}=\left(X \times E_{G}\right) / G$. Then the bundle $X \hookrightarrow X_{G} \rightarrow B_{G}$ is called the Borel fibration. We consider the Leray-Serre spectral sequence for the Borel fibration. If $\pi_{1}\left(B_{G}\right)$ acts trivially on $H^{*}(X)$, then the system of local coefficients on $B_{G}$ is simple and the $E_{2}$-term of the Leray-Serre spectral sequence corresponding to the Borel fibration is given by

E_{2}^{k, l}=H^{k}\left(B_{G}\right) \otimes H^{l}(X)
$$

This sequence converges to $H^{*}\left(X_{G}\right)$ as an algebra. We recall some results which are needed to prove our results:

Proposition 2.1. Let $X \xrightarrow{i} X_{G} \xrightarrow{\pi} B_{G}$ be the Borel fibration. Suppose that the system of local coefficients on $B_{G}$ is simple, then the edge homomorphisms

H^{k}\left(B_{G}\right) \cong E_{2}^{k, 0} \longrightarrow E_{3}^{k, 0} \longrightarrow \cdots \longrightarrow E_{k}^{k, 0} \longrightarrow E_{k+1}^{k, 0}=E_{\infty}^{k, 0} \subset H^{k}\left(X_{G}\right)
$$

and

$$
H^{l}\left(X_{G}\right) \longrightarrow E_{\infty}^{0, l}=E_{l+2}^{0, l} \subset E_{l+1}^{0, l} \subset \cdots \subset E_{2}^{0, l} \cong H^{l}(X)
$$

are the homomorphisms

$$
\pi_{k}^{*}: H^{k}\left(B_{G}\right) \rightarrow H^{k}\left(X_{G}\right) \text { and } i_{l}^{*}: H^{l}\left(X_{G}\right) \rightarrow H^{l}(X) .
$$

For details about spectral sequences, we refer [5]. Let $G$ act freely on $X$ and $h: X_{G} \rightarrow$ $X / G$ be the map induced by $G$-equivariant projection $X \times E_{G} \rightarrow X$. Then $h$ is a homotopy equivalence [1]. Now, we recall Gysin sequence of sphere bundles.

Proposition 2.2 ([3]). Let $G=\mathbb{Z}_{2}$ act freely on a finitistic space $X$. The Gysin sequence of the sphere bundle $G \hookrightarrow X \xrightarrow{p} X / G$ is:

\cdots \longrightarrow H^{i-1}(X / G) \xrightarrow{\cup} H^{i}(X / G) \xrightarrow{p_{i}^{*}} H^{i}(X) \xrightarrow{\rho_{i}} H^{i}(X / G) \xrightarrow{\cup} H^{i+1}(X / G) \longrightarrow \cdots
$$

which start with

$$
0 \longrightarrow H^{0}(X / G) \xrightarrow{p_{0}^{*}} H^{0}(X) \xrightarrow{\rho_{0}} H^{0}(X / G) \xrightarrow{u} H^{1}(X / G) \xrightarrow{p_{1}^{*}} H^{1}(X) \longrightarrow \cdots
$$

where $\cup: H^{i}(X / G) \rightarrow H^{i+1}(X / G)$ maps $x \rightarrow x e, e \in H^{1}(X / G)$ denotes the image of 1 under the map $\cup: H^{0}(X / G) \rightarrow H^{1}(X / G)$ and $e$ is called the Euler class of the sphere bundle.

Proposition 2.3 ( 6$])$. Let $G=\mathbb{Z}_{2}$ act freely on a finitistic space $X$. Suppose that $H^{j}(X)=0$ for all $j>n$, then $H^{j}(X / G)=0$ for all $j>n$.

## 3. Proof of main Theorems

Proof of Theorem 1.1. As $X / G \sim_{2} \mathbb{R P}^{1} \times \mathbb{C P}^{n}$, we have $H^{*}(X / G)=\mathbb{Z}_{2}[a, b] /\left\langle a^{2}, b^{n+1}\right\rangle$, where $\operatorname{deg} a=1$ and $\operatorname{deg} b=2$. By connectedness of $X$ and the exactness of Gysin sequence of $G$-bundle $G \hookrightarrow X \xrightarrow{p} X / G$, we get $p_{0}^{*}$ is an isomorphism and the Euler class $\cup(1)$ is $a$. This implies that for $0 \leq i<n, p_{2 i+2}^{*}: H^{2 i+2}(X / G) \rightarrow H^{2 i+2}(X), \rho_{2 i+1}:$ $H^{2 i+1}(X) \rightarrow H^{2 i+1}(X / G)$ and $\rho_{2 n+1}: H^{2 n+1}(X) \rightarrow H^{2 n+1}(X / G)$ are isomorphisms. Consequently, $H^{2 i+1}(X) \cong H^{2 n+1}(X) \cong H^{2 i+2}(X) \cong \mathbb{Z}_{2}$ with bases $\left\{u_{2 i+1}\right\},\left\{u_{2 n+1}\right\}$ and $\left\{x^{i+1}\right\}$, respectively, where $x=p_{2}^{*}(b), \rho_{2 i+1}\left(u_{2 i+1}\right)=a b^{i}, \rho_{2 n+1}\left(u_{2 n+1}\right)=a b^{n}$. By Proposition [2.3, $H^{i}(X)=0$ for $i>2 n+1$. Now, we compute the cohomology algebra of $X$. The Leray-Serre spectral sequence associated to the Borel fibration $X \hookrightarrow X_{G} \rightarrow B_{G}$ converges to $H^{*}\left(X_{G}\right)$. It is easy to see that $G$ acts trivially on $H^{*}(X)$. Thus, the $E_{2}$-term $E_{2}^{s, t}$ of the Leray-Serre spectral sequence associated to the Borel fibration $X \xrightarrow{i} X_{G} \xrightarrow{\pi} B_{G}$ is $H^{s}\left(B_{G}\right) \otimes H^{t}(X)$. By the edge homomorphism, we get $d_{r}(1 \otimes x)=0$ for all $r>0$ and $d_{r^{\prime}}\left(1 \otimes u_{1}\right) \neq 0$ for some $r^{\prime}>0$. So, $d_{2}\left(1 \otimes u_{1}\right)=t^{2} \otimes 1$. This gives that $x^{i} u_{1} \neq 0$, and hence $u_{2 i+1}=x^{i} u_{1}$ for all $0 \leq i \leq n$. Clearly, $x^{n+1}=0$. If $u_{1}^{2}=0$ then $X \sim_{2} \mathbb{S}^{1} \times \mathbb{C P}^{n}$. If $u_{1}^{2} \neq 0$ then $X \sim_{2} \mathbb{R}^{2 n+1}$.

Proof of Theorem 1.2. As $X / G \sim_{2} \mathbb{R}^{2} \times \mathbb{H}^{2}$, we have $H^{*}(X / G)=\mathbb{Z}_{2}[a, b] /\left\langle a^{3}, b^{n+1}\right\rangle$, where $\operatorname{deg} a=1$ and $\operatorname{deg} b=4$. It is easy to see that $\cup: H^{0}(X / G) \rightarrow H^{1}(X / G)$ maps 1 to $a$. Since $H^{j}(X / G)=0$ for $j \equiv 3(\bmod 4)$, we get $p_{4 i}^{*}: H^{4 i}(X / G) \rightarrow H^{4 i}(X)$ and $\rho_{4 i+2}$ : $H^{4 i+2}(X) \rightarrow H^{4 i+2}(X / G)$ are isomorphisms for $1 \leq i \leq n$. Consequently, for $1 \leq i \leq n$, we get $H^{4 i}(X) \cong H^{4 i+2}(X) \cong \mathbb{Z}_{2}$ with bases $\left\{x^{i}\right\}$ and $\left\{u_{4 i+2}\right\}$, respectively, where $x=p_{4}^{*}(b)$ and $\rho_{4 i+2}\left(u_{4 i+2}\right)=a^{2} b^{i}$. By the exactness of Gysin sequence, $H^{4 i+3}(X)=H^{4 i+1}(X)=0$ for all $0 \leq i \leq n$. Clearly, $H^{i}(X)=0$ for all $i>4 n+3$. Now, we compute cohomology algebra of $X$. As $\pi_{1}\left(B_{G}\right)$ acts trivially on $H^{*}(X)$, we get $E_{2}^{s, t}=H^{s}\left(B_{G}\right) \otimes H^{t}(X)$. By the edge homomorphism, we get $d_{3}\left(1 \otimes u_{2}\right)=t^{3} \otimes 1$ and $d_{3}(1 \otimes x)=0$. Thus, $x^{i} u_{2} \neq 0$, and hence $u_{4 i+2}=x^{i} u_{2}$ for all $0 \leq i \leq n$. Clearly, $x^{n+1}=0$. If $u_{2}^{2}=0$ then $X \sim_{2} \mathbb{S}^{2} \times \mathbb{H} \mathbb{P}^{n}$. Otherwise, we get $X \sim_{2} \mathbb{C P}^{2 n+1}$.

Proof of Theorem 1.3. It is given that $X / G \sim_{2} \mathbb{R P}^{1} \times \mathbb{R P}^{n} \times \mathbb{C P}^{m}$. So, we get $H^{*}(X / G)=$ $\mathbb{Z}_{2}[a, b, c] /\left\langle a^{n+1}, b^{m+1}, c^{2}\right\rangle$, where $\operatorname{deg} a=\operatorname{deg} c=1$ and $\operatorname{deg} b=2$. As $X$ is connected, $H^{0}(X) \cong \mathbb{Z}_{2}$. First, we consider $1 \leq n<2 m$. By Proposition 2.3, $H^{i}(X)=0$ for all $i>2 m+n+1$. Consider the Gysin sequence of the sphere bundle $G \hookrightarrow X \xrightarrow{p} X / G$ :

\cdots \longrightarrow H^{i-1}(X / G) \xrightarrow{\cup} H^{i}(X / G) \xrightarrow{p_{i}^{*}} H^{i}(X) \xrightarrow{\rho_{i}} H^{i}(X / G) \xrightarrow{\cup} H^{i+1}(X / G) \longrightarrow \cdots
$$

which begins with

$$
0 \longrightarrow H^{0}(X / G) \xrightarrow{p_{0}^{*}} H^{0}(X) \xrightarrow{\rho_{0}} H^{0}(X / G) \xrightarrow{\cup} H^{1}(X / G) \xrightarrow{p_{1}^{*}} H^{1}(X) \longrightarrow \cdots
$$

Clearly, the Euler class of the associated principal $G$-bundle $G \hookrightarrow X \rightarrow X / G$ must be nontrivial. We have considered the following three cases:
Case (1): When $\cup: H^{0}(X / G) \rightarrow H^{1}(X / G)$ maps 1 to $c$.
For $0 \leq i<\frac{n}{2}$, we have $H^{2 i}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(2 i+1$-copies $)$ and $H^{2 i+1}(X / G) \cong$ $\mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(2 i+2$-copies $)$ with bases

$$
\begin{aligned}
& \left\{b^{i}, a b^{i-1} c, a^{2} b^{i-1}, a^{3} b^{i-2} c, \cdots, a^{2 i-1} c, a^{2 i}\right\}, \text { and } \\
& \left\{b^{i} c, a b^{i}, a^{2} b^{i-1} c, a^{3} b^{i-1}, \cdots, a^{2 i} c, a^{2 i+1}\right\},
\end{aligned}
$$

respectively. By the exactness of Gysin sequence, we get ker $p_{2 i}^{*}=\operatorname{im} \rho_{2 i} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}$ ( $i$-copies) with basis $\left\{a^{2 j+1} b^{i-j-1} c \mid 0 \leq j \leq i-1\right\}$, and $\operatorname{ker} p_{2 i+1}^{*}=\operatorname{im} \rho_{2 i+1} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}$ ( $i+1$-copies) with basis $\left\{a^{2 j} b^{i-j} c \mid 0 \leq j \leq i\right\}$. Consequently, im $p_{2 i}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(i+1$ copies) with basis $\left\{x^{2 j} y^{i-j} \mid 0 \leq j \leq i\right\}$, and $\operatorname{im} p_{2 i+1}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}$ ( $i+1$-copies) with basis $\left\{x^{2 j+1} y^{i-j} \mid 0 \leq j \leq i\right\}$, where $p_{1}^{*}(a)=x, p_{2}^{*}(b)=y$. It is easy to see that

$$
0 \rightarrow \operatorname{im} p_{j}^{*} \hookrightarrow H^{j}(X) \xrightarrow{\rho_{j}} \operatorname{im} \rho_{j} \rightarrow 0, j=2 i, 2 i+1
$$

are split exact sequences. This gives that

& H^{2 i}(X) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(2 i+1 \text {-copies }), \text { and } \\
& H^{2 i+1}(X) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(2 i+2 \text {-copies })
\end{aligned}
$$

with bases $\left\{x^{2 j} y^{i-j}, u_{2 i}^{2 l+1} \mid 0 \leq j \leq i, 0 \leq l \leq i-1\right\}$ and $\left\{x^{2 j+1} y^{i-j}, u_{2 i+1}^{2 j} \mid 0 \leq j \leq i\right\}$, respectively, where $\rho_{2 i}\left(u_{2 i}^{2 l+1}\right)=a^{2 l+1} b^{i-l-1} c, 0 \leq l \leq i-1$ and $\rho_{2 i+1}\left(u_{2 i+1}^{2 j}\right)=a^{2 j} b^{i-j} c, 0 \leq$ $j \leq i$.

Firstly, suppose that $n=2 k$ for some $k$. Then for $\frac{n}{2} \leq i \leq m, H^{2 i}(X / G) \cong H^{2 i+1}(X / G) \cong$ $\mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}$ ( $n+1$-copies) with bases

& \left\{b^{i}, a b^{i-1} c, a^{2} b^{i-1}, a^{3} b^{i-2} c, \cdots, a^{n-1} b^{i-k} c, a^{n} b^{i-k}\right\}, \text { and } \\
& \left\{b^{i} c, a b^{i}, a^{2} b^{i-1} c, a^{3} b^{i-1}, \cdots, a^{n-1} b^{i-k+1}, a^{n} b^{i-k} c\right\},
\end{aligned}
$$

respectively. Again, by the exactness of Gysin sequence, $\operatorname{ker} p_{2 i}^{*}=\operatorname{im} \rho_{2 i} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(k$ copies) and $\operatorname{ker} p_{2 i+1}^{*}=\operatorname{im} \rho_{2 i+1} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}\left(k+1\right.$-copies) with bases $\left\{a^{2 j+1} b^{i-j-1} c \mid 0 \leq\right.$ $j \leq k-1\}$ and $\left\{a^{2 j} b^{i-j} c \mid 0 \leq j \leq k\right\}$, respectively. This gives that $\operatorname{im} p_{2 i}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}$ ( $k+1$-copies) and $\operatorname{im} p_{2 i+1}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}$ ( $k$-copies) with bases $\left\{x^{2 j} y^{i-j} \mid 0 \leq j \leq k\right\}$
and $\left\{x^{2 j+1} y^{i-j} \mid 0 \leq j \leq k-1\right\}$, respectively. We observe that $H^{j}(X) \cong \operatorname{im} p_{j}^{*} \oplus \operatorname{im} \rho_{j}, j=$ $2 i, 2 i+1$. So, we get

with bases $\left\{x^{2 j} y^{i-j}, u_{2 i}^{2 l+1} \mid 0 \leq j \leq k, 0 \leq l \leq k-1\right\}$ and $\left\{x^{2 j+1} y^{i-j}, u_{2 i+1}^{2 l} \mid 0 \leq j \leq k-1,0 \leq\right.$ $l \leq k\}$, respectively, where $\rho_{2 i}\left(u_{2 i}^{2 l+1}\right)=a^{2 l+1} b^{i-l-1} c, 0 \leq l \leq k-1$ and $\rho_{2 i+1}\left(u_{2 i+1}^{2 l}\right)=$ $a^{2 l} b^{i-l} c, 0 \leq l \leq k$.

For $m<i \leq m+\frac{n}{2}$, we have $H^{2 i}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(n+2 m-2 i+2$-copies) and $H^{2 i+1}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(n+2 m-2 i+1$-copies) with bases

respectively. Note that $\operatorname{ker} p_{2 i}^{*}=\operatorname{im} \rho_{2 i} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}\left(k+m-i+1\right.$-copies) and $\operatorname{ker} p_{2 i+1}^{*}=$ $\operatorname{im} \rho_{2 i+1} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(k+m-i+1$-copies $)$ with bases $\left\{a^{2 j+1} b^{i-j-1} c \mid i-m-1 \leq j \leq k-1\right\}$ and $\left\{a^{2 j} b^{i-j} c \mid i-m \leq j \leq k\right\}$, respectively. This implies that $\operatorname{im} p_{2 i}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}$ $\left(k+m-i+1\right.$-copies) and im $p_{2 i+1}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}\left(k+m-i\right.$-copies) with bases $\left\{x^{2 j} y^{i-j} \mid i-\right.$ $m \leq j \leq k\}$ and $\left\{x^{2 j+1} y^{i-j} \mid i-m \leq j \leq k-1\right\}$, respectively. So, we get

with bases $\left\{x^{2 j} y^{i-j}, u_{2 i}^{2 l+1} \mid i-m \leq j \leq k, i-m-1 \leq l \leq k-1\right\}$ and $\left\{x^{2 j+1} y^{i-j}, u_{2 i+1}^{2 l} \mid i-m \leq\right.$ $j \leq k-1, i-m \leq l \leq k\}$, respectively, where $\rho_{2 i}\left(u_{2 i}^{2 l+1}\right)=a^{2 l+1} b^{i-l-1} c, i-m-1 \leq l \leq k-1$ and $\rho_{2 i+1}\left(u_{2 i+1}^{2 l}\right)=a^{2 l} b^{i-l} c, i-m \leq l \leq k$.

Now, we compute the cohomology algebra of $X$. Consider the Leray Serre spectral sequence for the Borel fibration $X \stackrel{i}{\hookrightarrow} X_{G} \xrightarrow{\pi} B_{G}$ with $E_{2}^{s, t}=H^{s}\left(B_{G}\right) \otimes H^{t}(X)$. As $p_{j}^{*}=i_{j}^{*} \circ$ $h^{*}$ for all $j \geq 0$, we get $d_{r}(1 \otimes x)=0=d_{r}(1 \otimes y)$ for all $r \geq 0$ and for all $i, j ; d_{r_{i, j}}\left(1 \otimes u_{j}^{i}\right) \neq 0$ for some $r_{i, j}>0$. Put $u_{1}^{0}=z$. So, $H^{1}(X)$ is generated by $\{x, z\}$. Trivially, $d_{2}(1 \otimes z)=t^{2} \otimes 1$ and so $d_{2}(1 \otimes x z) \neq 0$. This implies that $x z=\alpha x^{2}+\beta y+u_{2}^{1}, \alpha, \beta \in \mathbb{Z}_{2}$. So, $H^{2}(X)$ is generated by $\left\{x^{2}, y, x z\right\}$. By induction, we show that for $1 \leq i<\frac{n}{2}, H^{2 i-1}(X)$ and $H^{2 i}(X)$ are generated by $\left\{x y^{i-1}, x^{3} y^{i-2}, \cdots, x^{2 i-3} y, x^{2 i-1}, y^{i-1} z, x^{2} y^{i-2} z, \cdots x^{2 i-4} y z, x^{2 i-2} z\right\}$ and $\left\{y^{i}, x^{2} y^{i-1}, \cdots, x^{2 i-2} y, x^{2 i}, x y^{i-1} z, x^{3} y^{i-2} z, \cdots, x^{2 i-1} z\right\}$, respectively. Now, we prove it for $i+1$. We have $d_{2}\left(1 \otimes y^{i} z\right)=t^{2} \otimes y^{i}, d_{2}\left(1 \otimes x^{2} y^{i-1} z\right)=t^{2} \otimes x^{2} y^{i-1}, \cdots, d_{2}\left(1 \otimes x^{2 i-2} y z\right)=$ $t^{2} \otimes x^{2 i-2} y, d_{2}\left(1 \otimes x^{2 i} z\right)=t^{2} \otimes x^{2 i}$. This gives that $y^{i} z, x^{2} y^{i-1} z, \cdots x^{2 i-2} y z, x^{2 i} z$ are nonzero
elements of $H^{2 i+1}(X)$. Therefore,

As the set $\left\{y^{i}, x^{2} y^{i-1}, \cdots, x^{2 i-2} y, x^{2 i}\right\}$ is linearly independent, the coefficient matrix

Then $u_{2 i+1}^{2 k}$ is generated by $\left\{x y^{i}, x^{3} y^{i-1}, \cdots, x^{2 i-1} y, x^{2 i+1}, y^{i} z, x^{2} y^{i-1} z, \cdots\right.$, $\left.x^{2 i-2} z, x^{2 i} z\right\}$ for all $0 \leq k \leq i$. So, the basis for $H^{2 i+1}(X)$ is $\left\{x y^{i}, x^{3} y^{i-1}, \cdots, x^{2 i-3} y^{2}, x^{2 i-1} y\right.$ , $\left.x^{2 i+1}, y^{i} z, x^{2} y^{i-1} z, \cdots, x^{2 i-2} y z, x^{2 i} z\right\}$. Also, we have $d_{2}\left(1 \otimes x y^{i} z\right)=t^{2} \otimes x y^{i}, d_{2}(1 \otimes$ $\left.x^{3} y^{i-1} z\right)=t^{2} \otimes x^{3} y^{i-1}, d_{2}\left(1 \otimes x^{5} y^{i-2} z\right)=t^{2} \otimes x^{5} y^{i-2}, \cdots, d_{2}\left(1 \otimes x^{2 i+1} z\right)=t^{2} \otimes x^{2 i+1}$. This implies that $x y^{i} z, x^{3} y^{i-1} z, \cdots, x^{2 i+1} z$ are nonzero elements of $H^{2 i+2}(X)$. So, we get

As the set $\left\{x y^{i}, x^{3} y^{i-1}, \cdots, x^{2 i+1}\right\}$ is linearly independent, $u_{2 i+2}^{k}$ is generated by $\left\{y^{i+1}, x^{2} y^{i}\right.$, $\left.\cdots, x^{2 i} y, x y^{i} z, x^{3} y^{i-1} z, \cdots, x^{2 i+1} z\right\}$ for all $k=1,3, \cdots, 2 i+1$. So, our assumption is true for $i+1$. Similarly, for $\frac{n}{2} \leq i \leq m$, bases for $H^{2 i}(X)$ and $H^{2 i+1}(X)$ are $\left\{x^{2 j} y^{i-j}, x^{2 l+1} y^{i-l-1} z\right.$ $\mid 0 \leq j \leq k, 0 \leq l \leq k-1\}$ and $\left\{x^{2 j+1} y^{i-j}, x^{2 l} y^{i-l} z \mid 0 \leq j \leq k-1,0 \leq l \leq k\right\}$, respectively, and for $m<i \leq m+\frac{n}{2}$, bases for $H^{2 i}(X)$ and $H^{2 i+1}(X)$ are $\left\{x^{2 j} y^{i-j}, x^{2 l+1} y^{i-l-1} z \mid i-m \leq\right.$ $j \leq k, i-m-1 \leq l \leq k-1\}$ and $\left\{x^{2 j+1} y^{i-j}, x^{2 l} y^{i-l} z \mid i-m \leq j \leq k-1, i-m \leq l \leq k\right\}$, respectively.

Now, suppose that $n=2 k+1$ for some $k$. For $n \leq 2 i, 2 i+1 \leq 2 m, H^{n-1}(X / G) \cong$ $\mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(2 k+1$-copies $)$ and $H^{2 i}(X / G) \cong H^{2 i+1}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(2 k+2$-copies $)$ with bases

Then we have $\operatorname{ker} p_{n-1}^{*}=\operatorname{im} \rho_{n-1} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(k$-copies $)$, $\operatorname{ker} p_{2 i}^{*}=\operatorname{im} \rho_{2 i} \cong$ $\mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(k+1$-copies $)$ and $\operatorname{ker} p_{2 i+1}^{*}=\operatorname{im} \rho_{2 i+1} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(k+1$-copies $)$ with bases $\left\{a^{2 j+1} b^{k-j-1} c \mid 0 \leq j \leq k-1\right\},\left\{a^{2 j+1} b^{i-j-1} c \mid 0 \leq j \leq k\right\}$ and $\left\{a^{2 j} b^{i-j} c \mid 0 \leq j \leq k\right\}$, respectively. So, $\operatorname{im} p_{n-1}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(k+1$-copies $), \operatorname{im} p_{2 i}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(k+1$ copies) and $\operatorname{im} p_{2 i+1}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(k+1$ copies $)$ with bases $\left\{x^{2 j} y^{k-j} \mid 0 \leq j \leq k\right\}$, $\left\{x^{2 j} y^{i-j} \mid 0 \leq j \leq k\right\}$ and $\left\{x^{2 j+1} y^{i-j} \mid 0 \leq i \leq k\right\}$, respectively. As we have done above, we get

Also, for $2 m<2 i, 2 i+1 \leq 2 m+n+1$, we have $H^{2 i}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(n+2 m-2 i+2$-copies $)$ and $H^{2 i+1}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(n+2 m-2 i+1$-copies) with bases

This implies that $\operatorname{im} p_{2 i}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}$ ( $k+m-i+1$-copies) and $\operatorname{im} p_{2 i+1}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(k+m-i+1$-copies) with bases $\left\{x^{2 j} y^{i-j} \mid i-m \leq j \leq k\right\}$ and $\left\{x^{2 j+1} y^{i-j} \mid i-m \leq j \leq k\right\}$, respectively. & H^{2 i+1}(X) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(n+2 m-2 i+1 \text {-copies })
\end{aligned}
$$

with bases $\left\{x^{2 j} y^{i-j}, u_{2 i}^{2 l+1} \mid i-m \leq j \leq k, i-m-1 \leq l \leq k\right\}$ and $\left\{x^{2 j+1} y^{i-j}, u_{2 i+1}^{2 j} \mid i-m \leq\right.$ $j \leq k\}$, respectively, where $\rho_{2 i}\left(u_{2 i}^{2 l+1}\right)=a^{2 l+1} b^{i-l-1} c, i-m-1 \leq l \leq k$ and $\rho_{2 i+1}\left(u_{2 i+1}^{2 j}\right)=$ $a^{2 j} b^{i-j} c, i-m \leq j \leq k$.

For $1 \leq i<n, H^{i}(X)$ has the same basis as in the case when $n$ is even. Again by induction, for $n \leq 2 i, 2 i+1 \leq 2 m$, bases for $H^{n-1}(X), H^{2 i}(X)$ and $H^{2 i+1}(X)$ are $\left\{x^{2 j} y^{k-j}, x^{2 l+1} y^{k-l-1} z \mid 0 \leq j \leq k, 0 \leq l \leq k-1\right\},\left\{x^{2 j} y^{i-j}, x^{2 l+1} y^{i-l-1} z \mid 0 \leq j, l \leq k\right\}$ and $\left\{x^{2 j+1} y^{i-j}, x^{2 l} y^{i-l} z \mid 0 \leq j, l \leq k\right\}$, respectively, and for $m<i \leq m+\frac{n}{2}$, bases for $H^{2 i}(X)$ and $H^{2 i+1}(X)$ are $\left\{x^{2 j} y^{i-j}, x^{2 l+1} y^{i-l-1} z \mid i-m \leq j \leq k, i-m-1 \leq l \leq k\right\}$ and $\left\{x^{2 j+1} y^{i-j}, x^{2 l} y^{i-l} z \mid i-m \leq j, l \leq k\right\}$, respectively.

As $d_{2}\left(1 \otimes z^{2}\right)=0$, we get $z^{2}=\alpha x^{2}+\beta y$ for some $\alpha, \beta \in \mathbb{Z}_{2}$. Thus the cohomology algebra of $X$ is given by

\mathbb{Z}_{2}[x, y, z] /\left\langle x^{n+1}, y^{m+1}, z^{2}+\alpha x^{2}+\beta y\right\rangle,
$$

where $\operatorname{deg} x=\operatorname{deg} z=1, \operatorname{deg} y=2$ and $\alpha, \beta \in \mathbb{Z}_{2}$. This realizes possibility (i).
Case (2): When $\cup: H^{0}(X / G) \rightarrow H^{1}(X / G)$ maps 1 to $a$.
Clearly, $\rho_{i}: H^{i}(X) \rightarrow H^{i}(X / G)$ is trivial for all $1 \leq i<n$. For $0<2 i, 2 i+1<$ $n$, bases for $\operatorname{ker} p_{2 i}^{*}$ and $\operatorname{ker} p_{2 i+1}^{*}$ are $\left\{a^{2 j+1} b^{i-j-1} c, a^{2 l} b^{i-l} \mid 0 \leq j \leq i-1,1 \leq l \leq i\right\}$
and $\left\{a^{2 j+1} b^{i-j}, a^{2 l} b^{i-l} c \mid 0 \leq j \leq i, 1 \leq l \leq i\right\}$, respectively. This implies that im $p_{2 i}^{*} \cong$ $\operatorname{im} p_{2 i+1}^{*} \cong \mathbb{Z}_{2}$ with bases $\left\{y^{i}\right\}$ and $\left\{x y^{i}\right\}$, respectively, where $p_{1}^{*}(c)=x$ and $p_{2}^{*}(b)=y$. So, $H^{2 i}(X) \cong H^{2 i+1}(X) \cong \mathbb{Z}_{2}$ with bases $\left\{y^{i}\right\}$ and $\left\{x y^{i}\right\}$, respectively.

If $n=2 k$ for some $k$, then for $n \leq 2 i, 2 i+1 \leq 2 m+1$, $\left\{a^{2 j+1} b^{i-j-1} c, a^{2 l} b^{i-l} \mid 0 \leq j \leq\right.$ $k-1,1 \leq l \leq k\}$ and $\left\{a^{2 j+1} b^{i-j}, a^{2 l} b^{i-l} c \mid 0 \leq j \leq k-1,1 \leq l \leq k\right\}$ are bases for ker $p_{2 i}^{*}$ and $\operatorname{ker} p_{2 i+1}^{*}$, respectively. This gives that $\operatorname{im} p_{2 i}^{*} \cong \operatorname{im} p_{2 i+1}^{*} \cong \mathbb{Z}_{2}$ with bases $\left\{y^{i}\right\}$ and $\left\{x y^{i}\right\}$, respectively, and $\operatorname{im} \rho_{2 i} \cong \operatorname{im} \rho_{2 i+1} \cong \mathbb{Z}_{2}$ with bases $\left\{a^{n} b^{i-k}\right\}$ and $\left\{a^{n} b^{i-k} c\right\}$, respectively. Consequently, $H^{2 i}(X) \cong H^{2 i+1}(X) \cong \mathbb{Z}_{2} \oplus \mathbb{Z}_{2}$ with bases $\left\{y^{i}, u_{2 i}^{n}\right\}$ and $\left\{x y^{i}, u_{2 i+1}^{n}\right\}$, respectively, where $\rho_{2 i}\left(u_{2 i}^{n}\right)=a^{n} b^{i-k}$ and $\rho_{2 i+1}\left(u_{2 i+1}^{n}\right)=a^{n} b^{i-k} c$. If $2 m+1<2 i, 2 i+1 \leq$ $2 m+n+1$ then bases for $\operatorname{ker} p_{2 i}^{*}$ and $\operatorname{ker} p_{2 i+1}^{*}$ are $\left\{a^{2 j+1} b^{i-j-1} c, a^{2 l} b^{i-l} \mid i-m-1 \leq j \leq\right.$ $k-1, i-m \leq l \leq k\}$ and $\left\{a^{2 j+1} b^{i-j}, a^{2 l} b^{i-l} c \mid i-m \leq j \leq k-1, i-m \leq l \leq k\right\}$, respectively. This implies that $p_{2 i}^{*}, p_{2 i+1}^{*}$ are trivial and $\operatorname{im} \rho_{2 i} \cong \operatorname{im} \rho_{2 i+1} \cong \mathbb{Z}_{2}$ with bases $\left\{a^{n} b^{i-k}\right\}$ and $\left\{a^{n} b^{i-k} c\right\}$, respectively. Thus, $H^{2 i}(X) \cong H^{2 i+1}(X) \cong \mathbb{Z}_{2}$ with bases $\left\{u_{2 i}^{n}\right\}$ and $\left\{u_{2 i+1}^{n}\right\}$ respectively, where $\rho_{2 i}\left(u_{2 i}^{n}\right)=a^{n} b^{i-k}$ and $\rho_{2 i+1}\left(u_{2 i+1}^{n}\right)=a^{n} b^{i-k} c$. Trivially, $x^{2}=y^{m+1}=0$. Put $u_{2 k}^{n}=z$. Then by the edge homomorphism, $d_{r}(1 \otimes x)=d_{r}(1 \otimes y)=0$ for all $r>0$ and $d_{r^{\prime}}(1 \otimes z) \neq 0$ for some $r^{\prime}>0$. As $X / G \sim_{2} \mathbb{R P}^{1} \times \mathbb{R} \mathbb{P}^{n} \times \mathbb{C P}^{m}, r^{\prime}$ must be $n+1$. Note that for all $0 \leq i \leq m, x y^{i} z$ and $x y^{i}$ are nonzero elements of $H^{n+2 i+1}(X)$ and $H^{n+2 i}(X)$, respectively. Therefore, $x y^{i} z=\alpha x y^{k+m}+\beta u_{n+2 i+1}^{n}$ and $x y^{i}=\alpha^{\prime} y^{k+m}+\beta^{\prime} u_{n+2 i}^{n}$ for some $\alpha, \alpha^{\prime}, \beta, \beta^{\prime} \in \mathbb{Z}_{2}$, where $\beta$ and $\beta^{\prime}$ are nonzero. Note that for $n+2 i>2 m$, we get $\alpha=\alpha^{\prime}=0$.

As $d_{r}\left(1 \otimes z^{2}\right)=0$ for all $r \geq 0$, we get $z^{2}=\alpha y^{n}$ for some $\alpha \in \mathbb{Z}_{2}$ and $\alpha=0$ for $n>m$. Thus, the cohomology algebra of $X$ is given by

\mathbb{Z}_{2}[x, y, z] /\left\langle x^{2}, y^{m+1}, z^{2}+\alpha y^{n}\right\rangle,
$$

where $\operatorname{deg} x=1, \operatorname{deg} y=2, \operatorname{deg} z=n$ and $\alpha=0$ if $n>m$. This realizes possibility (ii).
Now, let $n=2 k+1$ for some $k \geq 0$. For $n \leq 2 i, 2 i+1 \leq 2 m+1$, we get $H^{2 i}(X) \cong$ $\mathbb{Z}_{2} \oplus \mathbb{Z}_{2} \cong H^{2 i+1}(X)$ with bases $\left\{y^{i}, u_{2 i}^{n}\right\}$ and $\left\{x y^{i}, u_{2 i+1}^{n}\right\}$, respectively, where $\rho_{2 i}\left(u_{2 i}^{n}\right)=$ $a^{n} b^{i-k-1} c$ and $\rho_{2 i+1}\left(u_{2 i+1}^{n}\right)=a^{n} b^{i-k}$. Also, for $2 m+1<2 i, 2 i+1 \leq 2 m+n+1$, we have $H^{2 i}(X) \cong \mathbb{Z}_{2} \cong H^{2 i+1}(X)$ with bases $\left\{u_{2 i}^{n}\right\}$ and $\left\{u_{2 i+1}^{n}\right\}$, respectively, where $\rho_{2 i}\left(u_{2 i}^{n}\right)=$ $a^{n} b^{i-k-1} c$ and $\rho_{2 i+1}\left(u_{2 i+1}^{n}\right)=a^{n} b^{i-k}$. It is easy to observe that $X$ has the same cohomology algebra as in the case when $n$ is even.
Case (3): When $\cup: H^{0}(X / G) \rightarrow H^{4}(X / G)$ maps 1 to $a+c$.
Also, in this case $\rho_{i}: H^{i}(X) \rightarrow H^{i}(X / G)$ and $p_{j}^{*}$ are trivial for all $1 \leq i<n$ and $2 m+$ $1<j \leq 2 m+n+1$. Similar calculations show that for $1 \leq i<n, H^{2 i}(X) \cong H^{2 i+1}(X) \cong \mathbb{Z}_{2}$ with bases $\left\{y^{i}\right\}$ and $\left\{x y^{i}\right\}$, respectively, where $x=p_{1}^{*}(a)=p_{1}^{*}(c), y=p_{2}^{*}(b)$. For $n \leq 2 i, 2 i+$
$1 \leq 2 m+1, H^{2 i}(X) \cong H^{2 i+1}(X) \cong \mathbb{Z}_{2} \oplus \mathbb{Z}_{2}$ with bases $\left\{y^{i}, u_{2 i}\right\},\left\{x y^{i}, u_{2 i+1}\right\}$, respectively; and for $2 m+1<2 i, 2 i+1 \leq 2 m+n+1$, we have $H^{2 i}(X) \cong H^{2 i+1}(X) \cong \mathbb{Z}_{2}$ with bases $\left\{u_{2 i}\right\}$, $\left\{u_{2 i+1}\right\}$, respectively, where $\rho_{2 i}\left(u_{2 i}\right)=a^{n-1} b^{i-k} c+a^{n} b^{i-k}$ and $\rho_{2 i+1}\left(u_{2 i+1}\right)=a^{n} b^{i-k} c$ if $n=2 k$; and $\rho_{2 i}\left(u_{2 i}\right)=a^{n} b^{i-k-1} c$ and $\rho_{2 i+1}\left(u_{2 i+1}\right)=a^{n-1} b^{i-k} c+a^{n} b^{i-k}$ if $n=2 k+1$. Consequently, the cohomology algebra of $X$ is given by

\mathbb{Z}_{2}[x, y, z] /\left\langle x^{2}, y^{m+1}, z^{2}+\alpha y^{n}\right\rangle,
$$

where $\operatorname{deg} x=1, \operatorname{deg} y=2, \operatorname{deg} z=n$ and $\alpha=0$ if $n>m$. This realizes possibility (ii).
Similarly, we get the same cohomology algebra for the case when $2 m \leq n$.
Proof of Theorem 1.4. As $X / G \sim_{2} \mathbb{C P}^{n} \times \mathbb{H P}^{m} \times \mathbb{R P}^{2}$, we get $H^{*}(X / G)=\mathbb{Z}_{2}[a, b, c] /\left\langle a^{n+1}\right.$ $\left., b^{m+1}, c^{3}\right\rangle$, where $\operatorname{deg} a=2, \operatorname{deg} b=4$ and $\operatorname{deg} c=1$. Since $X$ is connected, $H^{0}(X) \cong \mathbb{Z}_{2}$. By Proposition 2.3, $H^{i}(X)=0$ for all $i>4 m+2 n+2$. Firsty, assume that $1 \leq n<2 m$. Consider the Gysin sequence of the sphere bundle $G \hookrightarrow X \xrightarrow{p} X / G$ :

$$

By the exactness of Gysin sequence, the Euler class of the associated principal $G$-bundle $G \hookrightarrow X \rightarrow X / G$ must be $c$.

For $0 \leq i<\frac{n}{2}$, we have $H^{4 i}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(2 i+1$-copies $), H^{4 i+1}(X / G) \cong$ $\mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}\left(i+1\right.$-copies), $H^{4 i+2}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}\left(2 i+2\right.$-copies) and $H^{4 i+3}(X / G) \cong$ $\mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(i+1$-copies $)$ with bases

Again, by the exactness of Gysin sequence, we get $\operatorname{ker} p_{4 i}^{*}=\operatorname{im} \rho_{4 i} \cong \mathbb{Z}_{2} \oplus$ $\cdots \oplus \mathbb{Z}_{2}$ ( $i$-copies) with basis $\left\{a^{2 j+1} b^{i-j-1} c^{2} \mid 0 \leq j \leq i-1\right\}$, ker $p_{4 i+1}^{*}=H^{4 i+1}(X / G)$, $\operatorname{ker} p_{4 i+2}^{*}=\operatorname{im} \rho_{4 i+2} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}\left(i+1\right.$-copies) with basis $\left\{a^{2 j} b^{i-j} c^{2} \mid 0 \leq j \leq i\right\}$ and $\operatorname{ker} p_{4 i+3}^{*}=H^{4 i+3}(X / G)$. This implies that $\operatorname{im} p_{4 i}^{*} \cong \operatorname{im} p_{4 i+2}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(i+1$ copies) with bases $\left\{x^{2 j} y^{i-j} \mid 0 \leq j \leq i\right\}$ and $\left\{x^{2 j+1} y^{i-j} \mid 0 \leq j \leq i\right\}$, respectively, where
$p_{2}^{*}(a)=x, p_{4}^{*}(b)=y$. Clearly, $\operatorname{im} p_{4 i+j}^{*}=\operatorname{im} \rho_{4 i+j}=0, j=1,3$. Thus,

with bases $\left\{x^{2 j} y^{i-j}, u_{4 i}^{2 l+1} \mid 0 \leq j \leq i, 0 \leq l \leq i-1\right\}$ and $\left\{x^{2 j+1} y^{i-j}, u_{4 i+2}^{2 j} \mid 0 \leq j \leq i\right\}$, respectively, where $\rho_{4 i}\left(u_{4 i}^{2 l+1}\right)=a^{2 l+1} b^{i-l-1} c^{2}, 0 \leq l \leq i-1$ and $\rho_{4 i+2}\left(u_{4 i+2}^{2 j}\right)=a^{2 j} b^{i-j} c^{2}, 0 \leq$ $j \leq i$.

Let us assume that $n=2 k$ for some $k>0$. In this case, for $2 n \leq 4 i+r \leq 4 m, 0 \leq r \leq 3$, we have $H^{4 i}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(2 k+1$-copies $), H^{4 i+1}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(k+1$ copies $), H^{4 i+2}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(2 k+1$-copies $)$ and $H^{4 i+3}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}$ ( $k$-copies) with bases

Then by the exactness of Gysin sequence, we get $\operatorname{ker} p_{4 i}^{*}=\operatorname{im} \rho_{4 i} \cong \mathbb{Z}_{2} \oplus \cdots \oplus$ $\mathbb{Z}_{2}$ ( $k$-copies) with basis $\left\{a^{2 j+1} b^{i-j-1} c^{2} \mid 0 \leq j \leq k-1\right\}$, $\operatorname{ker} p_{4 i+2}^{*}=\operatorname{im} \rho_{4 i+2} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}$ ( $k+1$-copies) with basis $\left\{a^{2 j} b^{i-j} c^{2} \mid 0 \leq j \leq k\right\}$ and $\operatorname{ker} p_{4 i+j}^{*}=H^{4 i+j}(X / G), j=1,3$. This gives that $\operatorname{im} p_{4 i}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}\left(k+1\right.$-copies) with basis $\left\{x^{2 j} y^{i-j} \mid 0 \leq j \leq k\right\}$ and $\operatorname{im} p_{4 i+2}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}$ ( $k$-copies) with basis $\left\{x^{2 j+1} y^{i-j} \mid 0 \leq j \leq k-1\right\}$. Also, $\operatorname{im} p_{4 i+j}^{*}=\operatorname{im} \rho_{4 i+j}=0, j=1$ and 3 , Therefore,

& \left\{a^{2 i-2 m} b^{m} c^{2}, a^{2 i-2 m+1} b^{m}, a^{2 i-2 m+2} b^{m-1} c^{2}, a^{2 i-2 m+3} b^{m-1}, \cdots, a^{2 k-1} b^{i-k+1}, a^{2 k} b^{i-k} c^{2}\right\}, \text { and } \\
& \left\{a^{2 i-2 m+1} b^{m} c, a^{2 i-2 m+3} b^{m-1} c, \cdots, a^{2 k-3} b^{i-k+2} c, a^{2 k-1} b^{i-k+1} c\right\},
\end{aligned}
$$

respectively. Then by the exactness of Gysin sequence, we get $\operatorname{ker} p_{4 i}^{*}=\operatorname{im} \rho_{4 i} \cong \mathbb{Z}_{2} \oplus \cdots \oplus$ $\mathbb{Z}_{2}(m+k-i+1$-copies $)$ with basis $\left\{a^{2 j+1} b^{i-j-1} c^{2} \mid i-m-1 \leq j \leq k-1\right\}$, $\operatorname{ker} p_{4 i+j}^{*}=$ $H^{4 i+j}(X / G), j=1,3$; and $\operatorname{ker} p_{4 i+2}^{*}=\operatorname{im} \rho_{4 i+2} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(m+k-i+1$-copies) with basis $\left\{a^{2 j} b^{i-j} c^{2} \mid i-m \leq j \leq k\right\}$. This gives that $\operatorname{im} p_{4 i}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(m+k-i+1$ copies) with basis $\left\{x^{2 j} y^{i-j} \mid i-m \leq j \leq k\right\}$, $\operatorname{im} p_{4 i+j}^{*}=\operatorname{im} \rho_{4 i+j}=0, j=1,3$; and $\operatorname{im} p_{4 i+2}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(m+k-i$-copies $)$ with basis $\left\{x^{2 j+1} y^{i-j} \mid i-m \leq j \leq k-1\right\}$. Therefore,

$$
\begin{aligned}
& H^{4 i+1}(X)=H^{4 i+3}(X)=0 \\
& H^{4 i}(X) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(2 m+n-2 i+2 \text {-copies }), \text { and } \\
& H^{4 i+2}(X) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(2 m+n-2 i+1 \text {-copies })
\end{aligned}
$$

with bases $\left\{x^{2 j} y^{i-j}, u_{4 i}^{2 l+1} \mid i-m \leq j \leq k, i-m-1 \leq l \leq k-1\right\}$ and $\left\{x^{2 j+1} y^{i-j}, u_{4 i+2}^{2 l} \mid i-m \leq\right.$ $j \leq k-1, i-m \leq l \leq k\}$, respectively, where $\rho_{4 i}\left(u_{4 i}^{2 l+1}\right)=a^{2 l+1} b^{i-l-1} c^{2}, i-m-1 \leq l \leq$ $k-1$ and $\rho_{4 i+2}\left(u_{4 i+2}^{2 l}\right)=a^{2 l} b^{i-l} c^{2}, i-m \leq l \leq k$.

Next, we compute the cohomology algebra of $X$. Consider the Leray-Serre spectral sequence for the Borel fibration $X \stackrel{i}{\longrightarrow} X_{G} \xrightarrow{\pi} B_{G}$. By the edge homomorphisms, we get $d_{r}(1 \otimes x)=0=d_{r}(1 \otimes y)$ for all $r>0$ and for all $i, j ; d_{r_{i, j}}\left(1 \otimes u_{j}^{i}\right) \neq 0$ for some $r_{i, j}>0$. Put $u_{2}^{0}=z$. So, $H^{2}(X)$ is generated by $\{x, z\}$. Clearly, $d_{3}(1 \otimes z)=t^{3} \otimes 1$ and so $d_{3}(1 \otimes x z)=$ $t^{3} \otimes x \neq 0$. This implies that $x z=\alpha x^{2}+\beta y+u_{4}^{1}, \alpha, \beta \in \mathbb{Z}_{2}$. So, $H^{4}(X)$ is generated by $\left\{x^{2}, y, x z\right\}$. By the induction, as in Theorem 1.3, we get that for $1 \leq 4 i+r<2 n, r=0,2$, $H^{4 i}(X)$ and $H^{4 i+2}(X)$ have bases $\left\{x^{2 j} y^{i-j}, x^{2 l+1} y^{i-l-1} z \mid 0 \leq j \leq i, 0 \leq l \leq i-1\right\}$ and $\left\{x^{2 j+1} y^{i-j}, x^{2 l} y^{i-l} z \mid 0 \leq j, l \leq i\right\}$, respectively. Similarly, for $2 n \leq 4 i+r \leq 4 m, r=0,2$, bases for $H^{4 i}(X)$ and $H^{4 i+2}(X)$ are $\left\{x^{2 j} y^{i-j}, x^{2 l+1} y^{i-l-1} z \mid 0 \leq j \leq k, 0 \leq l \leq k-1\right\}$ and $\left\{x^{2 j+1} y^{i-j}, x^{2 l} y^{i-l} z \mid 0 \leq j \leq k-1,0 \leq l \leq k\right\}$, respectively, and for $4 m<4 i+r \leq$ $4 m+2 n+2, r=0,2$, bases for $H^{4 i}(X)$ and $H^{4 i+2}(X)$ are $\left\{x^{2 j} y^{i-j}, x^{2 l+1} y^{i-l-1} z \mid i-m \leq\right.$ $j \leq k, i-m-1 \leq l \leq k-1\}$ and $\left\{x^{2 j+1} y^{i-j}, x^{2 l} y^{i-l} z \mid i-m \leq j \leq k-1, i-m \leq l \leq k\right\}$, respectively.

Now, we take the case when $n=2 k+1$ for some $k>0$. In this case, for $2 n \leq$ $4 i+r \leq 4 m, 0 \leq r \leq 3$, we have $H^{4 i}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}\left(2 k+2\right.$-copies), $H^{4 i+1}(X / G) \cong$ $\mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(k+1$-copies $), H^{4 i+2}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}\left(2 k+2\right.$-copies) and $H^{4 i+3}(X / G) \cong$ $\mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(k+1$-copies $)$ with bases

$$
\begin{aligned}
& \left\{b^{i}, a b^{i-1} c^{2}, a^{2} b^{i-1}, a^{3} b^{i-2} c^{2}, \cdots, a^{2 k} b^{i-k}, a^{2 k+1} b^{i-k-1} c^{2}\right\}, \\
& \left\{b^{i} c, a^{2} b^{i-1} c, \cdots, a^{2 k-2} b^{i-k+1} c, a^{2 k} b^{i-k} c\right\}, \\
& \left\{b^{i} c^{2}, a b^{i}, a^{2} b^{i-1} c^{2}, a^{3} b^{i-1}, \cdots, a^{2 k} b^{i-k} c^{2}, a^{2 k+1} b^{i-k}\right\}, \text { and } \\
& \left\{a b^{i} c, a^{3} b^{i-1} c, \cdots, a^{2 k-1} b^{i-k+1} c, a^{2 k+1} b^{i-k} c\right\},
\end{aligned}
$$

respectively. Again, by the exactness of Gysin sequence, we get $\operatorname{ker} p_{4 i}^{*}=\operatorname{im} \rho_{4 i} \cong \mathbb{Z}_{2} \oplus \cdots \oplus$ $\mathbb{Z}_{2}$ ( $k+1$-copies) with basis $\left\{a^{2 j+1} b^{i-j-1} c^{2} \mid 0 \leq j \leq k\right\}$, $\operatorname{ker} p_{4 i+2}^{*}=\operatorname{im} \rho_{4 i+2} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}$ ( $k+1$-copies) with basis $\left\{a^{2 j} b^{i-j} c^{2} \mid 0 \leq j \leq k\right\}$ and $\operatorname{ker} p_{4 i+j}^{*}=H^{4 i+j}(X / G), j=1,3$. This gives that $\operatorname{im} p_{4 i}^{*} \cong \operatorname{im} p_{4 i+2}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}\left(k+1\right.$-copies) with bases $\left\{x^{2 j} y^{i-j} \mid 0 \leq j \leq k\right\}$ and $\left\{x^{2 j+1} y^{i-j} \mid 0 \leq j \leq k\right\}$, respectively. Note that $\operatorname{im} p_{4 i+j}^{*}=\operatorname{im} \rho_{4 i+j}=0, j=1$ and 3 . Thus,

$$
\begin{aligned}
& H^{4 i+1}(X)=H^{4 i+3}(X)=0 \\
& H^{4 i}(X) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(n+1 \text {-copies }), \text { and } \\
& H^{4 i+2}(X) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(n+1 \text {-copies })
\end{aligned}
$$

with bases $\left\{x^{2 j} y^{i-j}, u_{4 i}^{2 l+1} \mid 0 \leq j, l \leq k\right\}$ and $\left\{x^{2 j+1} y^{i-j}, u_{4 i+2}^{2 l} \mid 0 \leq j, l \leq k\right\}$, respectively, where $\rho_{4 i}\left(u_{4 i}^{2 l+1}\right)=a^{2 l+1} b^{i-l-1} c^{2}, 0 \leq l \leq k$ and $\rho_{4 i+2}\left(u_{4 i+2}^{2 l}\right)=a^{2 l} b^{i-l} c^{2}, 0 \leq l \leq k$. Now, for $4 m<4 i+r \leq 4 m+2 n+2,0 \leq r \leq 3$; we have $H^{4 i}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(2 m+n-2 i+2$ copies), $H^{4 i+1}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(m+k-i+1$-copies $), H^{4 i+2}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}$ $\left(2 m+n-2 i+1\right.$-copies) and $H^{4 i+3}(X / G) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(m+k-i+1$-copies) with bases $\left\{a^{2 i-2 m-1} b^{m} c^{2}, a^{2 i-2 m} b^{m}, a^{2 i-2 m+1} b^{m-1} c^{2}, a^{2 i-2 m+2} b^{m-1}, \cdots, a^{2 k} b^{i-k}, a^{2 k+1} b^{i-k-1} c^{2}\right\}$, $\left\{a^{2 i-2 m} b^{m} c, a^{2 i-2 m+2} b^{m-1} c, \cdots, a^{2 k-2} b^{i-k+1} c, a^{2 k} b^{i-k} c\right\}$, $\left\{a^{2 i-2 m} b^{m} c^{2}, a^{2 i-2 m+1} b^{m}, a^{2 i-2 m+2} b^{m-1} c^{2}, a^{2 i-2 m+3} b^{m-1}, \cdots, a^{2 k} b^{i-k} c^{2}, a^{2 k+1} b^{i-k}\right\}$, and $\left\{a^{2 i-2 m+1} b^{m} c, a^{2 i-2 m+3} b^{m-1} c, \cdots, a^{2 k-1} b^{i-k+1} c, a^{2 k+1} b^{i-k} c\right\}$,
respectively. Now, $\operatorname{ker} p_{4 i}^{*}=\operatorname{im} \rho_{4 i} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(m+k-i+2$-copies) with basis $\left\{a^{2 j+1} b^{i-j-1} c^{2} \mid i-m-1 \leq j \leq k\right\}$, $\operatorname{ker} p_{4 i+j}^{*}=H^{4 i+j}(X / G), j=1,3$; and $\operatorname{ker} p_{4 i+2}^{*}=$ $\operatorname{im} \rho_{4 i+2} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(m+k-i+1$-copies $)$ with basis $\left\{a^{2 j} b^{i-j} c^{2} \mid i-m \leq j \leq\right.$ $k\}$. Consequently, $\operatorname{im} p_{4 i}^{*} \cong \operatorname{im} p_{4 i+2}^{*} \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(m+k-i+1$-copies) with bases
$\left\{x^{2 j} y^{i-j} \mid i-m \leq j \leq k\right\}$ and $\left\{x^{2 j+1} y^{i-j} \mid i-m \leq j \leq k\right\}$, respectively. Also, im $p_{4 i+j}^{*}=$ $\operatorname{im} \rho_{4 i+j}=0, j=1,3$. Therefore,

$$
\begin{aligned}
& H^{4 i+1}(X)=H^{4 i+3}(X)=0 \\
& H^{4 i}(X) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(2 m+n-2 i+2 \text {-copies }), \text { and } \\
& H^{4 i+2}(X) \cong \mathbb{Z}_{2} \oplus \cdots \oplus \mathbb{Z}_{2}(2 m+n-2 i+1 \text {-copies })
\end{aligned}
$$

with bases $\left\{x^{2 j} y^{i-j}, u_{4 i}^{2 l+1} \mid i-m \leq j \leq k, i-m-1 \leq l \leq k\right\}$ and $\left\{x^{2 j+1} y^{i-j}, u_{4 i+2}^{2 l} \mid i-m \leq\right.$ $j, l \leq k\}$, respectively, where $\rho_{4 i}\left(u_{4 i}^{2 l+1}\right)=a^{2 l+1} b^{i-l-1} c^{2}, i-m-1 \leq l \leq k$ and $\rho_{4 i+2}\left(u_{4 i+2}^{2 l}\right)=$ $a^{2 l} b^{i-l} c^{2}, i-m \leq l \leq k$. Now, we discuss the cohomology algebra of $X$. By the repeated use of induction, for $\frac{n}{2} \leq i \leq m$, bases for $H^{4 i}(X)$ and $H^{4 i+2}(X)$ are $\left\{x^{2 j} y^{i-j}, x^{2 l+1} y^{i-l-1} z \mid 0 \leq\right.$ $j \leq k, 0 \leq l \leq k\}$ and $\left\{x^{2 j+1} y^{i-j}, x^{2 l} y^{i-l} z \mid 0 \leq j \leq k, 0 \leq l \leq k\right\}$, respectively, and for $m<i \leq m+\frac{n}{2}$, bases for $H^{4 i}(X)$ and $H^{4 i+2}(X)$ are $\left\{x^{2 j} y^{i-j}, x^{2 l+1} y^{i-l-1} z \mid i-m \leq j \leq\right.$ $k, i-m-1 \leq l \leq k\}$ and $\left\{x^{2 j+1} y^{i-j}, x^{2 l} y^{i-l} z \mid i-m \leq j \leq k, i-m \leq l \leq k\right\}$, respectively.

Clearly, $x^{n+1}=y^{m+1}=0$. As $d_{2}\left(1 \otimes z^{2}\right)=0, y^{2}=\alpha x^{2}+\beta y$ for some $\alpha, \beta \in \mathbb{Z}_{2}$. Thus, the cohomology algebra of $X$ is

$$
\mathbb{Z}_{2}[x, y, z] /\left\langle x^{n+1}, y^{m+1}, z^{2}+\alpha x^{2}+\beta y\right\rangle,
$$

where $\operatorname{deg} x=2, \operatorname{deg} y=4, \operatorname{deg} z=2$ and $\alpha, \beta \in \mathbb{Z}_{2}$.
Similarly, we get the same cohomology algebra for the case when $n \geq 2 m$.
Now, we realize the possibilities of our main Theorems.
Example 3.1. Consider, the antipodal action of $G=\mathbb{Z}_{2}$ on $\mathbb{S}^{1}$ and trivial action of $G$ on $\mathbb{C P}^{n}$. Then the diagonal action of $G$ on $X=\mathbb{S}^{1} \times \mathbb{C P}^{n}$ is a free action with the orbit space $X / G=\mathbb{R P}^{1} \times \mathbb{C P}^{n}$. Also, the map $\left[x_{0}, x_{1}, \cdots, x_{2 n}, x_{2 n+1}\right] \rightarrow\left[-x_{1}, x_{0} \cdots,-x_{2 n+1}, x_{2 n}\right]$ gives a free action of $G$ on $\mathbb{R P}^{2 n+1}$ with the orbit space $X / G \sim_{2} \mathbb{R P}^{1} \times \mathbb{C P}^{n}[7$. These examples realizes both possibilities of Theorem 1.1.

Example 3.2. Consider, the antipodal action of $G=\mathbb{Z}_{2}$ on $\mathbb{S}^{2}$ and trivial action of $G$ on $\mathbb{H P}^{n}$. Then the diagonal action of $G$ on $X=\mathbb{S}^{2} \times \mathbb{H} \mathbb{P}^{n}$ is a free action with the orbit space $X / G=\mathbb{R P}^{2} \times \mathbb{H}^{n}$. Also, the map $\left[z_{0}, z_{1}, \cdots, z_{n-1}, z_{n}\right] \rightarrow\left[-\overline{z_{1}}, \overline{z_{0}} \cdots,-\overline{z_{n}}, \overline{z_{n-1}}\right]$ gives a free action of $G$ on $\mathbb{C P}^{2 n+1}$ with the orbit space $X / G \sim_{2} \mathbb{R P}^{2} \times \mathbb{H}^{p}$ [7. These examples realizes both possibilities of Theorem 1.2,

Example 3.3. Consider, the antipodal action of $G=\mathbb{Z}_{2}$ on $\mathbb{S}^{1}$ and trivial action on $\mathbb{R P}^{n} \times \mathbb{C P}^{m}$. Then the diagonal action of $G$ on $\mathbb{S}^{1} \times \mathbb{R P}^{n} \times \mathbb{C P}^{m}$ is a free action with
the orbit space $\mathbb{R} \mathbb{P}^{1} \times \mathbb{R} \mathbb{P}^{n} \times \mathbb{C P}^{m}$. This realizes possibility (i) of Theorem 1.3 when $\alpha=\beta=0$. Now, we consider trival action of $G$ on $\mathbb{R P}^{n}$ and free action of $G$ on $\mathbb{R P}^{2 m+1}$ as defined in Example 3.1. Then $G$ acts freely on $X=\mathbb{R} \mathbb{P}^{n} \times \mathbb{R P}^{2 m+1}$ with the orbit space $X / G \sim_{2} \mathbb{R P}^{n} \times \mathbb{R P}^{1} \times \mathbb{C P}^{m}$. This realizes possibility (i) of Theroem 1.3 when $\alpha=0, \beta=1$. Also, if we take antipodal action of $G$ on $\mathbb{S}^{n}$ and trivial action on $\mathbb{R} \mathbb{P}^{1} \times \mathbb{C P}^{m}$ then $G$ acts freely on $\mathbb{S}^{n} \times \mathbb{R P}^{1} \times \mathbb{C P}^{m}$ with the orbit space $\mathbb{R}^{n} \times \mathbb{R P}^{1} \times \mathbb{C P}^{m}$. This realizes possibilty (ii) of Theorem 1.3 when $\alpha=0$.

Example 3.4. Consider, the antipodal action of $G=\mathbb{Z}_{2}$ on $\mathbb{S}^{2}$ and trivial action on $\mathbb{C P}^{n} \times \mathbb{H} \mathbb{P}^{m}$. Then the diagonal action of $G$ on $\mathbb{S}^{2} \times \mathbb{C P}^{n} \times \mathbb{H P}^{m}$ is a free action with the orbit space $\mathbb{R} \mathbb{P}^{2} \times \mathbb{C P}^{n} \times \mathbb{H}^{m}$. This realizes Theorem 1.4 when $\alpha=\beta=0$. Take trival action of $G$ on $\mathbb{C P}^{n}$ and free action of $G$ on $\mathbb{C P}^{2 m+1}$ as defined in Example 3.2. Then $G$ acts freely on $X=\mathbb{C P}^{n} \times \mathbb{C P}^{2 m+1}$ with the orbit space $X / G \sim_{2} \mathbb{C P}^{n} \times \mathbb{R P}^{2} \times \mathbb{H}^{m}$. This realizes Theorem 1.4 when $\alpha=0, \beta=1$.
