# Optimal $L^{2}$ error analysis of a loosely coupled finite element scheme for thin-structure interactions

#### Abstract

Finite element methods and kinematically coupled schemes that decouple the fluid velocity and structure displacement have been extensively studied for incompressible fluidstructure interaction (FSI) over the past decade. While these methods are known to be stable and easy to implement, optimal error analysis has remained challenging. Previous work has primarily relied on the classical elliptic projection technique, which is only suitable for parabolic problems and does not lead to optimal convergence of numerical solutions to the FSI problems in the standard $L^{2}$ norm. In this article, we propose a new stable fully discrete kinematically coupled scheme for incompressible FSI thin-structure model and establish a new approach for the numerical analysis of FSI problems in terms of a newly introduced coupled non-stationary Ritz projection, which allows us to prove the optimalorder convergence of the proposed method in the $L^{2}$ norm. The methodology presented in this article is also applicable to numerous other FSI models and serves as a fundamental tool for advancing research in this field.


Keywords: Fluid-structure interaction, finite element method, kinematically coupled schemes, energy stability, error estimates, coupled non-stationary Ritz projection

## 1 Introduction

There has been increasing interest in studying fluid-structure interaction due to its diverse applications in many areas [16, 24, 32, 38, 41]. Numerical simulations are crucial in this field, and over the past two decades, numerous efforts have been devoted to developing efficient numerical algorithms and analysis methods.

This paper focus on a commonly-used academic model problem, where an incompressible fluid interacts with thin structure described by some lower-dimensional, linearly elastic model (for example, membrane, shell and etc). This thin-structure interaction model is described by the following equations

[^0]and certain inflow and outflow conditions at $\Sigma_{l}$ and $\Sigma_{r}$; see Figure 1. The unknown solutions in (1.1)- $(1.3)$ are fluid velocity $\mathbf{u}$, fluid pressure $p$ and structure displacement $\eta$, and the following notations are used:

An elliptic differential operator on $\Sigma$, such as $\mathcal{L}_{s}=$ $-I+\Delta_{s}$, where $\Delta_{s}$ is the Laplace-Beltrami operator on $\Sigma$.

In general, two strategies can be employed to construct numerical schemes for solving fluidstructure interaction problems. Monolithic algorithms solve a fully coupled system, which can be expensive for complex fluid-structure problems. Various studies have focused on the numerical simulation and analysis of monolithic algorithms, as can be found in [30, 33, 36, 39, 41]. Alternatively, the fluid and structure sub-problems can be solved separately by partitioned type schemes. A strongly-coupled partitioned scheme often requires extra iterations for the sub-problems at each time step to obtain the solution which at convergence coincides with the monolithic one [19,41, while the extra iterations are not needed in loosely coupled partitioned schemes. However, the stability is a key issue for loosely coupled partitioned schemes, which may be hard to be ensured for highly added mass effect problems such as hemodynamics (e.g. [15)). The development and study of stable loosely coupled partitioned schemes have been an active area of research (e.g. [4, $8,20,26,27]$ ).

Among those loosely coupled partitioned schemes, the kinematically coupled scheme is the most popular one due to its modularity, stability, and ease of implementation. The scheme was first studied in [27] for the fluid-structure interaction problems and subsequently by numerous researchers $10,12,13,40,42$. However, the analysis of kinematically coupled schemes has been challenging due to the specific coupling of two distinct physical phenomena. In [21], Fernandez proposed an incremental displacement-correction scheme, which proved to be stable, and the following energy-norm error estimate was established using piecewise polynomials of degree $k$ for both $\mathbf{u}_{h}^{n}$ and $\eta_{h}^{n}$ in (1.4), i.e.,

The above estimate is optimal only for the velocity in the weak $H^{1}$-norm (more precisely, $L^{2}\left(H^{1}\right)$ norm) and not optimal in $L^{2}$-norm. Several different schemes were investigated, and similar error estimates, such as those given in [12,42], were provided. The kinematic coupling has been extended to other applications, such as composite structures and non-Newtonian flow [11, 40, by many researchers. Recently, a fully discrete loosely coupled Robin-Robin scheme for thick structures was proposed in [14], where they showed that the error estimate in the same energy
norm as in $\sqrt{1.4}$ ) is in the order of $O(\sqrt{\tau}+h)$ for $k=1$. Additionally, a splitting scheme was proposed in 22 for the fluid-structure interaction problem with immersed thin-walled structures. The scheme was proved to be unconditionally stable, and a suboptimal $L^{2}$-norm error estimate was presented.

Optimal $L^{2}$-norm error estimates play a crucial role in both theoretical analysis of algorithms and development of novel algorithms for practical applications. However, to our knowledge, such results have not been established due to the lack of properly defined Ritz projections for fluidstructure interaction problems. This is in contrast to the error analysis of finite element methods for parabolic equations, where the Ritz projections have been well defined since the early work of Wheeler [45]. For instance, for the heat equation $\partial_{t} u-\Delta u=f$, the Ritz projection is a finite element function $R_{h} u$ that satisfies the weak formulation:

With this projection $R_{h}$, the error of the finite element solution can be decomposed into two parts:

In the analysis of the second part, the pollution from the approximation of the diffusion term is not involved, thus enabling the establishment of an optimal-order error estimate for $\| R_{h} u-$ $u_{h} \|_{L^{2}(\Omega)}$. The optimal estimate for $\left\|u-u_{h}\right\|_{L^{2}(\Omega)}$ can be derived from the fact that the projection error $\left\|u-R_{h} u\right\|_{L^{2}(\Omega)}$ is also of optimal order. However, formulating and determining optimal $L^{2}$ norm error estimates for a suitably defined Ritz projection in fluid-structure interaction systems remains a challenge. The standard elliptic Ritz projection for the Stokes equations, while widely employed for obtaining error estimates in the energy norm, no longer produces optimal $L^{2}$-norm error estimates for such fluid-structure interaction systems; see $[2,12,21,35,42$.

In this article, we propose a new kinematically coupled scheme which decouples ( $\mathbf{u}, p$ ) and $\eta$ for solving the thin-structure interaction problem, and demonstrate its unconditional stability for long-time computation. More importantly, we establish an optimal $L^{2}$-norm error estimate for the proposed method, i.e.,

by developing a new framework for the numerical analysis of fluid-structure interaction problems in terms of a newly introduced coupled non-stationary Ritz projection, which is defined as a triple of finite element functions ( $R_{h} \mathbf{u}, R_{h} p, R_{h} \eta$ ) satisfying a weak formulation plus a constraint condition $\left.\left(R_{h} \mathbf{u}\right)\right|_{\Sigma}=\partial_{t} R_{h} \eta$ on $\Sigma \times[0, T]$. This is equivalent to solving an evolution equation of $R_{h} \eta$ under some initial condition $R_{h} \eta(0)$. Moreover, the dual problem of the non-stationary Ritz projection, required in the optimal $L^{2}$-norm error estimates for the fluid-structure interaction problem, is a backward initial-boundary value problem

which turns out to be equivalent to a backward evolution equation of $\xi=\sigma(\phi, q) \mathbf{n}$, i.e.,

where $\mathcal{N}: H^{-\frac{1}{2}}(\Sigma)^{d} \rightarrow H^{\frac{1}{2}}(\Sigma)^{d}$ is the Neumann-to-Dirichlet map associated to the Stokes equations. By choosing a well-designed initial value $R_{h} \eta(0)$ and utilizing the regularity properties of the dual problem (1.7), which are shown by analyzing the equivalent formulation in (1.8), we are able to establish optimal $L^{2}$ error estimates for the non-stationary Ritz projection and, subsequently, optimal $L^{2}$-norm error estimates for the finite element solutions of the thin-structure interaction problem.

The rest of this article is organized as follows. In Section 2, we introduce a kinematically coupled scheme and present our main theoretical results on the unconditional stability and optimal $L^{2}$-norm error estimates of the scheme. We focus on a first-order kinematically coupled time-
stepping method and the class of $H^{1}$-conforming inf-sup stable finite element spaces, including the classical Taylor-Hood and MINI elements. In Section 3, we introduce a new non-stationary coupled Ritz projection and present the corresponding projection error estimates (with its proof deferred to Section 4). Then we establish unconditionally stability and optimal $L^{2}$-norm error estimates for the fully discrete finite element solutions by utilizing the error estimates for the non-stationary coupled Ritz projection. Section 4 is devoted to the proof of the error estimates of the non-stationary coupled Ritz projection. We present a well-designed initial value of the projection and the corresponding error estimates based on duality arguments on the thin solid structure. In Section 5, we provide three numerical examples to support the theoretical analysis presented in this article. The first example illustrates the optimal $L^{2}$-norm convergence of the proposed fully discrete kinematically coupled scheme. The second example demonstrates the simulation of certain physical features, which are consistent with previous works. The third example is the 3 D simulation of common cardiac arteries in hemodynamics.

## 2 Notations, assumptions and main results

In this section, we propose a fully discrete stabilized kinematically coupled FEM for the fluidstructure problem (1.1)-(1.3), as well as the main theoretical results of unconditional stability and optimal-order convergence in the $L^{2}$ norm.

### 2.1 Notation and weak formulation

Some standard notations and operators are defined below. For any two function $u, v \in L^{2}(\Omega)$, we denote the inner products and norms of $L^{2}(\Omega)$ and $L^{2}(\Sigma)$ by

We assume that $\Omega \subset \mathbb{R}^{d}(d=2,3)$ is a bounded domain with $\partial \Omega=\Sigma_{l} \cup \Sigma_{r} \cup \Sigma$, where $\Sigma$ denotes the fluid-structure interface, $\Sigma_{l}$ and $\Sigma_{r}$ are two disks (or lines in 2-dimensional case) denoting the inflow and outflow boundary and $\Sigma_{r}=\left\{(x, y, z+L):(x, y, z) \in \Sigma_{l}\right.$ for some $\left.L>0\right\}$.

For the simplicity of analysis, we consider the problem with the periodic boundary condition on $\Sigma_{l}$ and $\Sigma_{r}$, and assume that the extended domains $\Omega_{\infty}$ and $\Sigma_{\infty}$ are smooth, where

The structure is assumed to be a linear thin-solid (e.g., string in two-dimensional model and membrane for three-dimensional model). Nonetheless, the algorithm presented in this paper is also applicable to problems with more general boundary conditions and domains.

We say a function $f$ defined in $\Omega_{\infty}$ is periodic if

The space of periodic smooth functions on $\Omega_{\infty}$ is denoted as $C^{\infty}\left(\Omega_{\infty}\right)$. The periodic Sobolev spaces $H^{s}(\Omega)$ and $H^{s}(\Sigma)$, with $s \geq 0$, are defined as

which are equivalent to the Sobolev spaces by considering $\Omega$ and $\Sigma$ as tori in the $z$ direction. The dual spaces of $H^{s}(\Omega)$ and $H^{s}(\Sigma)$ are denoted by $H^{-s}(\Omega)$ and $H^{-s}(\Sigma)$, respectively.

We define the following function spaces associated to velocity, pressure and thin structure, respectively:

In addition, we denote $\|\mathbf{u}\|_{f}:=\sqrt{(\mathbf{D}(\mathbf{u}), \mathbf{D}(\mathbf{u}))}$ and mention that the following norm equivalence holds (according to Korn's inequality):

where $\|\cdot\|_{X}$ is any norm or semi-norm in space, such as $\|\cdot\|_{f},\|\cdot\|_{s}$ or $\|\cdot\|_{L^{2}(\Sigma)}$. The following conventional notations will be used: $\|\cdot\|_{X}:=\|\cdot\|_{X(\Omega)},\|\cdot\|:=\|\cdot\|_{L^{2}(\Omega)},\|\cdot\|_{\Sigma}:=\|\cdot\|_{L^{2}(\Sigma)}$ and $\|\cdot\|_{H_{f}}:=\|\cdot\|_{f},\|\cdot\|_{H_{s}}:=\|\cdot\|_{s}$.

For smooth solutions of (1.1)-(1.3), one can verify that (via integration by parts) the following equations hold for all test functions $(\mathbf{v}, q, \mathbf{w}) \in \mathbf{X} \times Q \times \mathbf{S}$ with $\left.\mathbf{v}\right|_{\Sigma}=\mathbf{w}$ :

### 2.2 Regularity assumptions

To establish the optimal error estimates for the finite element solutions to the thin-structure interaction problem, we need to use the following regularity results.

- We assume that the domain $\Omega$ is smooth so that the the solution $(\mathbf{u}, p, \eta)$ of the fluidstructure interaction problem (1.1)-1.3) is sufficiently smooth.
- The weak solution $(\omega, \lambda) \in H^{1}(\Omega)^{d} \times L^{2}(\Omega)$ of the Stokes equations

where $\bar{\lambda}:=\frac{1}{|\Omega|} \int_{\Omega} \lambda$ is the mean value of $\lambda$ over $\Omega$. The estimates in (2.7) and (2.8) correspond to the Neumann and Dirichlet boundary conditions, respectively; see [25, Theorem IV.6.1] for a proof of (2.8) in smooth domains, with a similar approach as in 25, Chapter IV] one can prove (2.7). We also refer to [29, Theorem 4.15] for a proof of (2.7) in the case of polygonal domain.

- We assume that operator $\mathcal{L}_{s}$ possesses the following elliptic regularity: The weak solution
$\boldsymbol{\xi} \in H^{1}(\Sigma)^{d}$ of the equation (in the weak formulation)

### 2.3 Assumptions on the finite element spaces

Let $\mathcal{T}_{h}$ denote a quasi-uniform partition on $\Omega$ with $\bar{\Omega}=\bigcup_{K \in \mathcal{T}_{h}} K$. Each $K$ is a curvilinear polyhedron/polygon with $\operatorname{diam}(K) \leq h$. All of the boundary faces on $\Sigma$ consist of a partition $\mathcal{T}_{h}(\Sigma), \Sigma=\bigcup_{D \in \mathcal{T}_{h}(\Sigma)} D$, all of the boundary faces on $\Sigma_{l}$ or $\Sigma_{r}$ consist of a partition of $\Sigma_{l}$ or $\Sigma_{r}$, respectively, and these two partitions coincide after shifting $L$ in $z$-direction. To approximate the weak form $(2.6)$ by finite element method, we assume that there are finite element spaces $\left(\mathbf{X}_{h}^{r}, \mathbf{S}_{h}^{r}, Q_{h}^{r-1}\right)$ on $\mathcal{T}_{h}$ (where $r \geq 1$ ) with the following properties.

- (A1) $\mathbf{X}_{h}^{r} \subseteq \mathbf{X}, \mathbf{S}_{h}^{r} \subseteq \mathbf{S}$ and $\mathbb{R} \subseteq Q_{h}^{r-1} \subseteq Q$, with $\mathbf{S}_{h}^{r}=\left\{\left.\mathbf{v}_{h}\right|_{\Sigma}: \mathbf{v}_{h} \in \mathbf{X}_{h}^{r}\right\}$.
- (A2) For $\mathbf{X}_{h}^{r}$ and $Q_{h}^{r-1}$, the following local inverse estimate holds on each $K \in \mathcal{T}_{h}$ for $0 \leq l \leq k, 1 \leq p, q \leq \infty$ :

\left\|\mathbf{v}_{h}\right\|_{W^{k, p}(K)} \leq C h^{-(k-l)+(d / p-d / q)}\left\|\mathbf{v}_{h}\right\|_{W^{l, q}(K)} \quad \forall \mathbf{v}_{h} \in \mathbf{X}_{h}^{r} \text { or } Q_{h}^{r-1} \tag{2.10}
\end{equation*}

For $\mathbf{S}_{h}^{r}$, the following global inverse estimate holds:

- (A3) There are interpolation/projection operators $I_{h}^{X}: \mathbf{X} \rightarrow \mathbf{X}_{h}^{r}$ and $I_{h}^{Q}: Q \rightarrow Q_{h}^{r-1}$ which have the following local $L^{p}$ approximation properties on each $K \in \mathcal{T}_{h}$, for all $1 \leq$ $p \leq \infty$ :

where $\Delta_{K}$ is the macro element including all the elements which have a common vertex with $K$. And there is an interpolation/projection operator $I_{h}^{S}: \mathbf{S} \rightarrow \mathbf{S}_{h}^{r}$ satisfying $\left.I_{h}^{X} \mathbf{u}\right|_{\Sigma}=$ $I_{h}^{S}\left(\left.\mathbf{u}\right|_{\Sigma}\right)$ for all $\mathbf{u} \in \mathbf{X}$ with $\left.\mathbf{u}\right|_{\Sigma} \in \mathbf{S}$. Moreover, we require the following optimal order error estimate

where $\|\cdot\|_{H_{h}^{k+1}(\Sigma)}$ is the piecewise $H^{k+1}$ _norm associated with partition $\mathcal{T}_{h}(\Sigma)$. We will abuse notation and use $I_{h}$ to denote one of the operators $I_{h}^{X}, I_{h}^{S}$ and $I_{h}^{Q}$ when there is no confusion.

- (A4) Let $\dot{\mathbf{X}}_{h}^{r}:=\left\{\mathbf{v}_{h} \in \mathbf{X}_{h}^{r}:\left.\mathbf{v}_{h}\right|_{\Sigma}=0\right\}$ and $Q_{h, 0}^{r-1}:=\left\{q_{h} \in Q_{h}^{r-1}: q_{h} \in L_{0}^{2}(\Omega)\right\}$. The following inf-sup condition holds:

Remark 2.1. Examples of finite element spaces which satisfy Assumptions (A1)-(A4) include the Taylor-Hood finite element space with $I_{h}^{X}, I_{h}^{Q}$ and $I_{h}^{S}$ being the Scott-Zhang interpolation operators onto $\mathbf{X}_{h}^{r}, Q_{h}^{r-1}$ and $\mathbf{S}_{h}^{r}$ respectively. We refer to [9, Section 4.8] and the references therein for the details on construction and properties of Scott-Zhang interpolation, and refer to [6, Section 8.8] for a proof of (2.14) for the Taylor-Hood finite element spaces. The following properties are consequences of the assumptions on the finite element spaces in (A1)-(A4).

1. From (A2) and (A3) we can derive the following estimate for $\mathbf{v}_{h} \in \mathbf{X}_{h}^{r}$ :

& \leq C\left(\sum_{D \in \mathcal{T}_{h}(\Sigma)} h^{-1}\left\|\mathbf{v}_{h}\right\|_{H^{1}(K)}^{2}\right)^{1 / 2} \leq C h^{-1 / 2}\left\|\mathbf{v}_{h}\right\|_{H^{1}}
\end{aligned}
$$

Therefore, we can obtain the following inverse estimate for the boundary term $\sigma\left(\mathbf{v}_{h}, q_{h}\right) \mathbf{n}$ :

2. From (A3) and (A4) we can see that when $r \geq 2$, the mixed finite element space $\left(\mathbf{X}_{h}^{r}, Q_{h}^{r-1}\right)$ can be realized by the $(r, r-1)$ Taylor-Hood finite element space. When $r=1,\left(\mathbf{X}_{h}^{1}, Q_{h}^{0}\right)$ can be realized by the MINI element space.
3. From inf-sup condition $(2.14)$, we can deduce the following alternative version of inf-sup condition (involving $H^{1}(\Sigma)$-norm in the denominator)

An inf-sup condition similar to 2.16 was proved in [46, Lemma 2], though thick structure problem is considered there. For the reader's convenience, we present a proof of (2.16) in the Appendix C.
4. For each $\mathbf{w}_{h} \in \mathbf{S}_{h}^{r}$, we denote by $E_{h} \mathbf{w}_{h} \in \mathbf{X}_{h}^{r}$ an extension such that $E_{h} \mathbf{w}_{h}:=I_{h}^{X} \mathbf{v}$, where $\mathbf{v} \in H^{1}(\Omega)^{d}$ is the extension of $\mathbf{w}_{h}$ by trace theorem, satisfying $\|\mathbf{v}\|_{H^{1}} \leq C\left\|\mathbf{w}_{h}\right\|_{H^{1 / 2}(\Sigma)}$ and $\left.\mathbf{v}\right|_{\Sigma}=\mathbf{w}_{h}$. Combining 2.12 with 2.11 we see that

& \leq\left\|\boldsymbol{\sigma}\left(\mathbf{u}-I_{h} \mathbf{u}, p-I_{h} p\right) \mathbf{n}\right\|_{\Sigma}+\left\|\sigma\left(I_{h} \mathbf{u}-\mathbf{u}_{h}, I_{h} p-p_{h}\right) \mathbf{n}\right\|_{\Sigma} \\
& \leq C\left(\left\|\mathbf{u}-I_{h} \mathbf{u}\right\|_{W^{1, \infty}}+\left\|p-I_{h} p\right\|_{L^{\infty}}\right)+\left\|\sigma\left(I_{h} \mathbf{u}-\mathbf{u}_{h}, I_{h} p-p_{h}\right) \mathbf{n}\right\|_{\Sigma} \\
& \leq C h^{r}+C h^{-1 / 2}\left(\left\|I_{h} \mathbf{u}-\mathbf{u}_{h}\right\|_{H^{1}}+\left\|I_{h} p-p_{h}\right\|\right) \\
& \leq C h^{r-1 / 2}+C h^{-1 / 2}\left(\left\|\mathbf{u}-\mathbf{u}_{h}\right\|_{H^{1}}+\left\|p-p_{h}\right\|\right) \tag{2.18}
\end{align*}
$$

where we have used 2.12 with $p=\infty$ and 2.15 in the second to last inequality.

### 2.4 A new kinematically coupled scheme and main theoretical results

Let $\left\{t_{n}\right\}_{n=0}^{N}$ be a uniform partition of the time interval $[0, T]$ with stepsize $\tau=T / N$. For a sequence of functions $\left\{\mathbf{u}^{n}\right\}_{n=0}^{N}$ we denote

With the above notations, we present a fully discrete kinematically coupled algorithm below.
Step 1: For given $\mathbf{u}_{h}^{n-1}, p_{h}^{n-1}, \eta_{h}^{n-1}$, find $\mathbf{s}_{h}^{n} \in \mathbf{S}_{h}^{r}$ such that

& \eta_{h}^{n}=\eta_{h}^{n-1}+\tau \mathbf{s}_{h}^{n} .
\end{align*}
$$

Step 2: Then find $\left(\mathbf{u}_{h}^{n}, p_{h}^{n}\right) \in \mathbf{X}_{h}^{r} \times Q_{h}^{r-1}$ satisfying

& +\rho_{s} \epsilon_{s}\left(\frac{\mathbf{u}_{h}^{n}-\mathbf{s}_{h}^{n}}{\tau}, \mathbf{v}_{h}+\frac{\tau}{\rho_{s} \epsilon_{s}} \sigma\left(\mathbf{v}_{h}, q_{h}\right) \cdot \mathbf{n}\right)_{\Sigma} \\
& +\left(\left(\sigma_{h}^{n}-\sigma_{h}^{n-1}\right) \cdot \mathbf{n}, \mathbf{v}_{h}+\frac{\tau(1+\beta)}{\rho_{s} \epsilon_{s}} \sigma\left(\mathbf{v}_{h}, q_{h}\right) \cdot \mathbf{n}\right)_{\Sigma}=0
\end{align*}
$$

for all $\left(\mathbf{v}_{h}, q_{h}\right) \in \mathbf{X}_{h}^{r} \times Q_{h}^{r-1}$, where $\sigma_{h}^{n}=\sigma\left(\mathbf{u}_{h}^{n}, p_{h}^{n}\right)$ and $\beta \geq 0$ denotes a stabilization parameter.
Initial values: Since $\sigma_{h}^{n-1}$ depends on both $\mathbf{u}_{h}^{n-1}$ and $p_{h}^{n-1}$, the numerical scheme in 2.192.20 requires the initial value $\left(\mathbf{u}_{h}^{0}, p_{h}^{0}, \eta_{h}^{0}\right)$ to be given. We simply assume that the initial value $\left(\mathbf{u}_{h}^{0}, p_{h}^{0}, \eta_{h}^{0}\right)$ are given sufficiently accurately, satisfying the following conditions:

where $\left(R_{h} \mathbf{u}^{0}, R_{h} p^{0}, R_{h} \eta^{0}\right)$ satisfies a couple non-stationary Ritz projection defined in Section 3.2 .

Remark 2.2. Kinematically coupled schemes were firstly proposed in $\sqrt[10,]{12}, 27$ with the following time discretization: Find $\left(\mathbf{s}^{n}, \eta^{n}\right)$ such that

\eta^{n}=\eta^{n-1}+\tau \mathbf{s}^{n} & \text { on } \Sigma
\end{array}
$$

and then find $\left(\mathbf{u}^{n}, p^{n}\right)$ satisfying

$$
\begin{array}{ll}
\rho_{f} D_{\tau} \mathbf{u}^{n}+\nabla \cdot \sigma^{n}=0 \quad \text { and } \quad \nabla \cdot \mathbf{u}^{n}=0 & \text { in } \Omega \\
\rho_{s} \epsilon_{s} \frac{\mathbf{u}^{n}-\mathbf{s}^{n}}{\tau}+\left(\sigma^{n}-\sigma^{n-1}\right) \cdot \mathbf{n}=0 & \text { on } \Sigma
\end{array}
$$

The extension to full discretization was considered by several authors [12, 42, while the analysis for full discretization is incomplete and the energy stability is proved only for time-discrete schemes.

Remark 2.3. Our scheme in (2.19)-2.20) is designed with two new ingredients. First, we have added two stabilization terms

\rho_{s} \epsilon_{s}\left(\frac{\mathbf{u}_{h}^{n}-\mathbf{s}_{h}^{n}}{\tau}, \frac{\tau}{\rho_{s} \epsilon_{s}} \sigma\left(\mathbf{v}_{h}, q_{h}\right) \cdot \mathbf{n}\right)_{\Sigma} \quad \text { and } \quad\left(\left(\sigma_{h}^{n}-\sigma_{h}^{n-1}\right) \cdot \mathbf{n}, \frac{\tau(1+\beta)}{\rho_{s} \epsilon_{s}} \sigma\left(\mathbf{v}_{h}, q_{h}\right) \cdot \mathbf{n}\right)_{\Sigma}
$$

which guarantee unconditional energy stability of the scheme in $2.19-2.20$. Otherwise the unconditional energy stability cannot be proved in the fully discrete finite element setting. Second, we have introduced an additional parameter $\beta>0$ to the scheme, and this additional parameter allows us to prove optimal-order convergence in the $L^{2}$ norm (especially optimal order in space). More specifically, this parameter $\beta>0$ leads to the following term in the $E_{1}$ of 2.26 :

$$

which is used to absorb other undesired terms on the right-hand side of the inequalities in our error estimation. Therefore, the optimal-order $L^{2}$ error estimate does benefits from our scheme (with the parameter $\beta>0$ ).
Remark 2.4. For the Taylor-Hood finite element spaces, the conditions in 2.21) on the initial values can be satisfied if one chooses $\mathbf{u}_{h}^{0}$ and $p_{h}^{0}$ to be the Lagrange interpolations of $\mathbf{u}^{0}$ and $p^{0}$, respectively, and chooses $\eta_{h}^{0}=R_{s h} \eta(0)$, where $R_{s h} \eta(0)$ is defined in Section 4 , see Definition 4.4 and estimate 4.16.

The main theoretical results of this article are the following two theorems.

Theorem 2.1. Under the assumptions in Section 2.3 (on the finite element spaces), the finite element system in 2.19-(2.20) is uniquely solvable, and the following inequality holds:

E_{0}\left(\mathbf{u}_{h}^{n}, p_{h}^{n}, \eta_{h}^{n}\right)= & \frac{\rho_{f}}{2}\left\|\mathbf{u}_{h}^{n}\right\|^{2}+\frac{1}{2}\left\|\eta_{h}^{n}\right\|_{s}^{2}+\frac{\tau^{2}(1+\beta)}{2 \rho_{s} \epsilon_{s}}\left\|\sigma_{h}^{n} \cdot \mathbf{n}\right\|_{\Sigma}^{2}+\frac{\rho_{s} \epsilon_{s}}{2}\left\|\mathbf{u}_{h}^{n}\right\|_{\Sigma}^{2},  \tag{2.25}\\
E_{1}\left(\mathbf{u}_{h}^{n}, \mathbf{s}_{h}^{n}, \eta_{h}^{n}\right)= & 2 \mu\left\|\mathbf{u}_{h}^{n}\right\|_{f}^{2}+\frac{\rho_{f}}{2 \tau}\left\|\mathbf{u}_{h}^{n}-\mathbf{u}_{h}^{n-1}\right\|^{2}+\frac{\rho_{s} \epsilon_{s}}{2 \tau}\left\|\mathbf{s}_{h}^{n}-\mathbf{u}_{h}^{n-1}\right\|_{\Sigma}^{2}+\frac{\rho_{s} \epsilon_{s} \beta_{0}}{2 \tau}\left\|\mathbf{s}_{h}^{n}-\mathbf{u}_{h}^{n}\right\|_{\Sigma}^{2} \\
& +\frac{\tau \beta_{0}}{2 \rho_{s} \epsilon_{s}}\left\|\left(\sigma_{h}^{n}-\sigma_{h}^{n-1}\right) \cdot \mathbf{n}\right\|_{\Sigma}^{2}+\frac{\tau}{2}\left\|D_{\tau} \eta_{h}^{n}\right\|_{s}^{2}, \tag{2.26}
\end{align*}

with $\beta_{0}=1-\left(\sqrt{4+\beta^{2}}-\beta\right) / 2$ and $\beta \geq 0$.
Theorem 2.2. For finite elements of degree $r \geq 2$, under the assumptions in Sections 2.22 .2 .3 (on the regularity of solutions and finite element spaces), there exist positive constants $\tau_{0}$ and $h_{0}$ such that, for sufficiently small stepsize and mesh size $\tau \leq \tau_{0}$ and $h \leq h_{0}$, the finite element solutions given by (2.19)-2.20) with initial values satisfying (2.21) and $\beta>0$ has the following error bound:

where $C$ is some positive constant independent of $n, h$ and $\tau$.
The proofs of Theorem [2.1] and Theorem [2.2 are presented in the next section.

## 3 Analysis of the proposed algorithm

This section is devoted to the proof of Theorems 2.1] and 2.2. For the simplicity of notation, we denote by $C$ a generic positive constant, which is independent of $n, h$ and $\tau$ but may depend on the physical parameters $\rho_{s}, \epsilon, \mu, \rho_{f}$ and the exact solution ( $\mathbf{u}, p, \eta$ ). In addition, we denote by $a \lesssim b$ the statement " $|a| \leq b$ ".

### 3.2 A coupled non-stationary Ritz projection

To establish $L^{2}$-norm optimal error estimate as given in Theorem 2.2 , we need to introduce a new coupled Ritz projection. Since the thin fluid-structure model is governed by the Stokes type equation for fluid coupled with a hyperbolic type equation for solid, the coupled projection, which is non-stationary and much more complicated than the standard Ritz projections, plays a key role in proving the optimal-order convergence of finite element solutions to the fluid-structure models.

Definition 3.1 (Coupled non-stationary Ritz projection). Let $(\mathbf{u}, p, \eta) \in \mathbf{X} \times Q \times \mathbf{S}$ be a triple of functions smoothly depending on $t \in[0, T]$ and satisfying the condition $\left.\mathbf{u}\right|_{\Sigma}=\partial_{t} \eta$. In order to guarantee that the coupled non-stationary Ritz projection $R_{h}$ possesses optimalorder approximation properties, we need to define $R_{h} \eta(0)$ in a rather technical way. Therefore, we present error estimates for this coupled non-stationary Ritz projection in Theorem 3.1 and postpone the definition of $R_{h} \eta(0)$ and the proof of Theorem 3.1 to Section 4 .

Theorem 3.1 (Error estimates for the coupled non-stationary Ritz projection). ## 4 The proof of Theorem 3.1

We present the proof of the Theorem 3.1 step-by-step in the next three subsections.

### 4.1 The definition of $R_{h} \eta(0)$ in the coupled Ritz projection

In this subsection, we focus on designing the initial value $R_{h} \eta(0)$ for our coupled non-stationary Ritz projection.

We first present two auxiliary Ritz projections $R_{h}^{S}$ and $R_{h}^{D}$ associated to the structure model and fluid model in Definitions 4.1-4.2, respectively. Next, in terms of these two auxiliary Ritz projections, we define the initial value $R_{h} \eta(0)$ in Definition 4.3 which is only for our theoretical purpose. Finally, an alternative definition of $R_{h} \eta(0)$ for practical computation is given in Definition 4.4.

Definition 4.1 (Structure-Ritz projection $R_{h}^{S}$ ). We define an auxiliary Ritz projection $R_{h}^{S}$ : $\mathbf{S} \rightarrow \mathbf{S}_{h}^{r}$ for the elastic structure problem by

Definition 4.2 (Dirichlet Stokes-Ritz projection $R_{h}^{D}$ ). Let $\hat{\mathbf{X}}:=\left\{\mathbf{u} \in \mathbf{X}:\left.\mathbf{u}\right|_{\Sigma} \in \mathbf{S}\right\}$. We define an auxiliary Dirichlet Stokes-Ritz projection $R_{h}^{D}: \hat{\mathbf{X}} \times Q \rightarrow \mathbf{X}_{h}^{r} \times Q_{h}^{r-1}$ by

& a_{f}\left(\mathbf{u}-R_{h}^{D} \mathbf{u}, \mathbf{v}_{h}\right)-b\left(p-R_{h}^{D} p, \mathbf{v}_{h}\right)+\left(\mathbf{u}-R_{h}^{D} \mathbf{u}, \mathbf{v}_{h}\right)=0 \quad \forall \mathbf{v}_{h} \in \dot{X}_{h}^{r}  \tag{4.3a}\\
& b\left(q_{h}, \mathbf{u}-R_{h}^{D} \mathbf{u}\right)=0 \quad \forall q_{h} \in Q_{h, 0}^{r-1} ; \quad R_{h}^{D} \mathbf{u}=\widetilde{P} R_{h}^{S}\left(\left.\mathbf{u}\right|_{\Sigma}\right) \quad \text { on } \Sigma \tag{4.3b}
\end{align*}
$$

In addition, we choose $R_{h}^{D} p$ to satisfy $R_{h}^{D} p-p \in L_{0}^{2}(\Omega)$. This uniquely determines a solution $\left(R_{h}^{D} u, R_{h}^{D} p\right) \in \mathbf{X}_{h}^{r} \times Q_{h}^{r-1}$, as explained in the following Remark.

Remark 4.1. In order to see the existence and uniqueness of solution ( $R_{h}^{D} u, R_{h}^{D} p$ ) defined by (4.3), we let $\hat{\mathbf{u}}_{h} \in \mathbf{X}_{h}^{r}$ be an extension of $\widetilde{P} R_{h}^{S} \mathbf{u}$ to the bulk domain $\Omega$ and let $\hat{p}_{h}$ be the $L^{2}(\Omega)$ orthogonal projection of $p$ onto $Q_{h}^{r-1}$. Then $\hat{\mathbf{u}}_{h}-R_{h}^{D} \mathbf{u} \in \stackrel{\mathbf{X}}{h}_{r}^{r}$ and $\hat{p}_{h}-R_{h}^{D} p \in Q_{h, 0}^{r-1}$. Replacing
$(\mathbf{u}, p)$ and $\left(R_{h}^{D} \mathbf{u}, R_{h}^{D} p\right)$ by $\left(\mathbf{u}-\hat{\mathbf{u}}_{h}, p-\hat{p}_{h}\right)$ and $\left(R_{h}^{D} \mathbf{u}-\hat{\mathbf{u}}_{h}, R_{h}^{D} p-\hat{p}_{h}\right)$ in 4.3a)-4.3b respectively, we obtain a standard Stokes FE system with a homogeneous Dirichlet boundary condition for $\left(R_{h}^{D} \mathbf{u}-\hat{\mathbf{u}}_{h}, R_{h}^{D} p-\hat{p}_{h}\right)$. The well-posedness directly follows the inf-sup condition (2.14).

Remark 4.2. The projection $\widetilde{P}$ in 4.3 b$)$ is introduced to guarantees that the $b\left(q_{h}, \mathbf{u}-R_{h}^{D} \mathbf{u}\right)=0$ holds not only for $q_{h} \in Q_{h, 0}^{r-1}$ but also for $q_{h} \in Q_{h}^{r-1}$. That is,

Especially, when $\mathbf{u}$ is replaced with $\partial_{t} \mathbf{u}(0)$, we have

Relation (4.5) is needed in estimating the error between $\left(\partial_{t} R_{h} \mathbf{u}(0), \partial_{t} R_{h} p(0)\right)$ and ( $\left.\partial_{t} \mathbf{u}(0), \partial_{t} p(0)\right)$ in Lemma 4.4 below. Furthermore, in Definition 4.3 , we defined $\left(R_{h} \mathbf{u}(0), R_{h} p(0)\right)$ via a Dirichlettype Stokes-Ritz projection with the boundary condition $\left.R_{h} \mathbf{u}(0)\right|_{\Sigma}=\widetilde{P} R_{s h} \mathbf{u}(0)$.

To facilitate further use of $\widetilde{P}$ in the following analysis, here we derive an explicit formula for $\widetilde{P}$. We denote by $\mathbf{n}_{h} \in \mathbf{S}_{h}^{r}$ the $L^{2}(\Sigma)$-orthogonal projection of unit normal vector field $\mathbf{n}$ of $\Sigma$ to $\mathbf{S}_{h}^{r}$, i.e.,

From $\left\|\mathbf{n}-\mathbf{n}_{h}\right\|_{\Sigma} \leq\left\|\mathbf{n}-I_{h} \mathbf{n}\right\|_{\Sigma} \leq C h^{r+1}$ (since $\mathbf{n}$ is smooth on $\Sigma$ ), especially we have $\left\|\mathbf{n}_{h}\right\|_{\Sigma} \sim C$ and

Therefore we obtain the estimate $\left\|R_{h}^{D} \mathbf{u}-\mathbf{u}\right\|_{\Sigma} \leq C h^{r+1}$.
The following lemma on the error estimates of the Dirichlet Stokes-Ritz projection is standard. We refer to [28, Proposition 8, Proposition 9] for the proof of 4.9). The negative norm estimate of pressure in 4.10) requires a further duality argument, which is presented in the proof of Lemma B. 3 in the Appendix B. We omit the details here.

Lemma 4.1. Under the regularity assumptions in Section 2.2, the Dirichlet Stokes-Ritz projection $R_{h}^{D}$ defined in 4.3 satisfies the following estimates:

We define an initial value $R_{h} \eta(0)$ as follows in terms of the Dirichlet Ritz projection $R_{h}^{D}$.
Definition 4.3 (Initial value $\left.R_{h} \eta(0)\right)$. Firstly, assuming that the function $\left(R_{h}^{D} \partial_{t} \mathbf{u}(0), R_{h}^{D} \partial_{t} p(0)\right)$ is known with operator $R_{h}^{D}$ defined by (4.3), we define $R_{s h} \mathbf{u}(0) \in \mathbf{S}_{h}^{r}$ to be the solution of the following weak formulation:

\end{align*}

where $E_{h} \mathbf{w}_{h}$ denotes an extension of $\mathbf{w}_{h}$ to the bulk domain $\Omega$. From the definition of $R_{h}^{D}$ in (4.3) we can conclude that this definition is independent of the specific extension. Therefore, 4.11) still holds when replacing both $\mathbf{w}_{h}$ and $E \mathbf{w}_{h}$ with $\mathbf{v}_{h} \in \mathbf{X}_{h}^{r}$.

Secondly, we denote by $\left(R_{h} \mathbf{u}(0), R_{h} p(0)\right) \in \mathbf{X}_{h}^{r} \times Q_{h}^{r-1}$ a Dirichlet-type Stokes-Ritz projection satisfying

b\left(q_{h}, \mathbf{u}(0)-R_{h} \mathbf{u}(0)\right)=0 & \forall q_{h} \in Q_{h, 0}^{r-1} ; \quad R_{h} \mathbf{u}(0)=\widetilde{P} R_{s h} \mathbf{u}(0) & \text { on } \Sigma \tag{4.12~b}
\end{array}
$$

where we require $p(0)-R_{h} p(0) \in L_{0}^{2}(\Omega)$.
Finally, with the $R_{h} \mathbf{u}(0)$ and $R_{h} p(0)$ defined above, we define $R_{h} \eta(0) \in \mathbf{S}_{h}^{r}$ to be the solution of the following weak formulation on $\Sigma$ :

Again 4.13) also holds when replacing $\mathbf{w}_{h}$ and $E_{h} \mathbf{w}_{h}$ with $\mathbf{v}_{h} \in \mathbf{X}_{h}^{r}$.
In addition, by differentiating (3.3) with respect to time, we have the following evolution equations:

b\left(q_{h}, \partial_{t}\left(\mathbf{u}-R_{h} \mathbf{u}\right)\right)=0 & \forall q_{h} \in Q_{h}^{r-1} \tag{4.14b}
\end{align*}

For the computation with the numerical scheme $2.19-2.20$, we can define the initial value $\eta_{h}^{0}=R_{s h} \eta(0) \in \mathbf{S}_{h}^{r}$ in an alternative way below.

Definition 4.4 (Ritz projection $\left.R_{s h} \eta(0)\right)$. We define $\eta_{h}^{0}=R_{s h} \eta(0) \in \mathbf{S}_{h}^{r}$ as the solution of the following weak formulation:

which does not require knowledge of $\partial_{t} \mathbf{u}(0)$ or $\partial_{t} p(0)$. Again, $E_{h} \mathbf{w}_{h}$ denotes an extension of $\mathbf{w}_{h}$ to the bulk domain $\Omega$, and this definition is independent of the specific extension. Therefore, 4.15 holds for all $\mathbf{v}_{h} \in \mathbf{X}_{h}^{r}$ with $\mathbf{w}_{h}$ and $E_{h} \mathbf{w}_{h}$ replaced by $\mathbf{v}_{h}$ in the equation. For $r \geq 2$, the following result can be proved in the Appendix B :

Secondly, we present estimates for $\mathbf{u}(0)-R_{h} \mathbf{u}(0), \eta(0)-$ $R_{h} \eta(0)$ and $p(0)-R_{h} p(0)$ in Lemma 4.3. Finally, we present estimates for the time derivatives $\partial_{t}\left(\mathbf{u}-R_{h} \mathbf{u}\right)(0)$ and $\partial_{t}\left(p-R_{h} p\right)(0)$ in Lemma 4.4 .

Lemma 4.2. Under the assumptions in Sections 2.2 and 2.3, the following error estimate holds for the $R_{s h} \mathbf{u}(0)$ defined in 4.11):

& -a_{f}\left(\partial_{t} \mathbf{u}(0)-R_{h}^{D} \partial_{t} \mathbf{u}(0), I_{h} \psi\right)+b\left(\partial_{t} p(0)-R_{h}^{D} \partial_{t} p(0), I_{h} \psi\right) \\
& -\left(\partial_{t} \mathbf{u}(0)-R_{h}^{D} \partial_{t} \mathbf{u}(0), I_{h} \psi\right) \quad(\text { relation } 4.11) \text { is used) } \\
\leq & C h^{r+1}\|\psi\|_{H^{2}(\Sigma)}+\left|a_{f}\left(\partial_{t} \mathbf{u}(0)-R_{h}^{D} \partial_{t} \mathbf{u}(0), \psi\right)\right| \\
& +\left|b\left(\partial_{t} p(0)-R_{h}^{D} \partial_{t} p(0), \psi\right)\right|+\left|\left(\partial_{t} \mathbf{u}(0)-R_{h}^{D} \partial_{t} \mathbf{u}(0), \psi\right)\right| .
\end{aligned}
$$

Since

& \left(\mathbf{D}\left(\partial_{t} \mathbf{u}(0)-R_{h}^{D} \partial_{t} \mathbf{u}(0)\right), \mathbf{D} \psi\right) \\
& =-\left(\partial_{t} \mathbf{u}(0)-R_{h}^{D} \partial_{t} \mathbf{u}(0), \nabla \cdot \mathbf{D} \psi\right)+\left(\partial_{t} \mathbf{u}(0)-R_{h}^{D} \partial_{t} \mathbf{u}(0), \mathbf{D} \psi \cdot \mathbf{n}\right)_{\Sigma} \\
& \lesssim C h^{r+1}\|\psi\|_{H^{2}(\Sigma)}
\end{aligned}
$$

where the last inequality uses the estimate $\|\psi\|_{H^{2}(\Omega)} \leq C\|\psi\|_{H^{2}(\Sigma)}$ as well as the estimates of $\left\|\partial_{t} \mathbf{u}(0)-R_{h}^{D} \partial_{t} \mathbf{u}(0)\right\|$ and $\left\|\partial_{t} \mathbf{u}(0)-R_{h}^{D} \partial_{t} \mathbf{u}(0)\right\|_{\Sigma}$ in 4.9 (with $\mathbf{u}(0)$ replaced by $\partial_{t} \mathbf{u}(0)$ therein). Since $\left(R_{h} \mathbf{u}(0), R_{h} p(0)\right)$ is essentially a Dirichlet Ritz projection with a different boundary value, i.e., $\widetilde{P} R_{s h} \mathbf{u}(0)$, the error estimates for $\left\|\mathbf{u}(0)-R_{h} \mathbf{u}(0)\right\|$ and $\left\|p(0)-R_{h} p(0)\right\|$ are the same as those in Lemma 4.1. With the optimal-order estimates of $\left\|\mathbf{u}(0)-R_{h} \mathbf{u}(0)\right\|_{\Sigma},\left\|\mathbf{u}(0)-R_{h} \mathbf{u}(0)\right\|$ and $\left\|p(0)-R_{h} p(0)\right\|$, the estimation of $\left\|\eta(0)-R_{h} \eta(0)\right\|_{\Sigma}$ and $\left\|\eta(0)-R_{h} \eta(0)\right\|_{s}$ would be the same as the proof of Lemma 4.2.

In addition, we present estimates for the time derivatives $\partial_{t}\left(\mathbf{u}-R_{h} \mathbf{u}\right)(0)$ and $\partial_{t}\left(p-R_{h} p\right)(0)$. To this end, we use the following relation:

### 4.3 Error estimates of the coupled Ritz projection for $t>0$

In this subsection, using the results in subsection 4.2 , we mainly present the proof of the $H^{1}$-error estimates 4.39 and $L^{2}$-error estimates results in Theorem 3.1.

We first present $H^{1}$-norm error estimates for the the coupled Ritz projection by employing the auxiliary Ritz projections $R_{h}^{S}$ and $R_{h}^{D}$ defined in 4.1) and 4.3), respectively. From 4.3b we see that

Similarly, by choosing $\mathbf{v}_{h}=\partial_{t}^{2}\left(R_{h} \mathbf{u}-R_{h}^{D} \mathbf{u}\right)$ in (4.38a) and using the same approach as above with the initial value estimates in (4.25), we can obtain the following estimate (the details are omitted):

&+\left\|\partial_{t}^{2}\left(R_{h} \mathbf{u}-\mathbf{u}\right)\right\|_{L^{2} H^{1}}+\left\|\partial_{t}^{2}\left(R_{h} p-p\right)\right\|_{L^{2} L^{2}} \leq C h^{r} . \tag{4.39}
\end{align*}

This establishes the $H^{1}$-norm error estimates for the coupled non-stationary Ritz projection defined in (3.3).

We then present $L^{2}$-norm error estimates for the coupled non-stationary Ritz projection. To this end, we introduce the following dual problem:

with the initial condition $\sigma(\phi, q) \mathbf{n}=0$ at $t=T$. Problem (4.40) can be equivalently written as a backward evolution equation of $\boldsymbol{\xi}=\boldsymbol{\sigma}(\phi, q) \mathbf{n}$, i.e.,

where $\mathcal{N}: H^{-\frac{1}{2}}(\Sigma)^{d} \rightarrow H^{\frac{1}{2}}(\Sigma)^{d}$ is the Neumann-to-Dirichlet map associated to the Stokes equations. The existence, uniqueness and regularity of solutions to 4.40) are presented in the following lemma, for which the proof is given in the Appendix A by utilizing and analyzing (4.41).

Lemma 4.5. Problem 4.40 has a unique solution which satisfies the following estimate:

By choosing $\mathbf{f}=R_{h} \eta-\eta$ and, testing equations 4.40a and 4.40b with $R_{h} \eta-\eta$ and $R_{h} \mathbf{u}-\mathbf{u}$, respectively, and using relation $\partial_{t}\left(R_{h} \eta-\eta\right)=R_{h} \mathbf{u}-\mathbf{u}$ on $\Sigma$, we have

& =\frac{d}{d t}\left(\sigma(\phi, q) \cdot \mathbf{n}, R_{h} \eta-\eta\right)_{\Sigma}+\left\|R_{h} \eta-\eta\right\|_{\Sigma}^{2} .

In view of the definition of the non-stationary Ritz projection in (3.3), we can subtract $I_{h} \phi$ from $\phi$ in the inequality above by generating an additional remainder $b\left(R_{h} p-p, \phi-I_{h} \phi\right)$. This leads to the following result in view of the estimate in 4.34):

Since $\left\|\left(R_{h} \eta-\eta\right)(0)\right\|_{\Sigma} \leq C h^{r+1}$ (see Lemma 4.3), the inequality above leads to the following result:

By using the same approach, choosing $\mathbf{f}=R_{h} \mathbf{u}-\mathbf{u}$ and $\mathbf{f}=\partial_{t}\left(R_{h} \mathbf{u}-\mathbf{u}\right)$ in 4.40a), respectively, the following result can be shown (the details are omitted):

where the term $\|\sigma(\phi, q) \mathbf{n}\|_{L^{2}(\Sigma)}$ is included on the left-hand side because it is actually bounded by $\|\phi\|_{H^{2}}+\|q\|_{H^{1}}$. Then, testing (4.46) with $R_{h} \mathbf{u}-\mathbf{u}$, we have

= & a_{f}\left(\phi-I_{h} \phi, R_{h} \mathbf{u}-\mathbf{u}\right)-b\left(q-I_{h} q, R_{h} \mathbf{u}-\mathbf{u}\right)-\left(\sigma(\phi, q) \mathbf{n}, R_{h} \mathbf{u}-\mathbf{u}\right)_{\Sigma} \\
\quad & \left.+\left(\phi-I_{h} \phi, R_{h} \mathbf{u}-\mathbf{u}\right)-b\left(R_{h} p-p, \phi-I_{h} \phi\right) \quad \text { (as a result of }(3.3) \text { with } \mathbf{v}_{h}=I_{h} \phi, q_{h}=I_{h} q\right) \\
\leq & C h\left(\|\phi\|_{H^{2}}+\|q\|_{H^{1}}\right)\left(\left\|R_{h} \mathbf{u}-\mathbf{u}\right\|_{H^{1}}+\left\|R_{h} p-p\right\|\right) \\
& +\|\boldsymbol{\sigma}(\phi, q) \cdot \mathbf{n}\|_{\Sigma}\left\|R_{h} \mathbf{u}-\mathbf{u}\right\|_{\Sigma} \\
\leq & C h^{r+1}\left\|R_{h} \mathbf{u}-\mathbf{u}\right\|+C\left\|R_{h} \mathbf{u}-\mathbf{u}\right\|\left\|R_{h} \mathbf{u}-\mathbf{u}\right\|_{\Sigma} .
\end{aligned}
$$

The last inequality implies, in combination with (4.45), the following result:

The proof of Theorem 3.1 is complete.

## 5 Numerical examples

In this section, we present numerical tests to support the theoretical analysis in this article and to show the effectivenss of the proposed algorithm. For 2D numerical examples, the operator $\mathcal{L}_{s} \eta=C_{0} \partial_{x x} \eta-C_{1} \eta$ on the interface $\Sigma$ is considered. All computations are performed by the finite element package NGSolve; see (43].

Example 5.1. To test the convergence rate of the algorithm, we consider an artificial example of a two-dimensional thin structure model given in (1.1)-(1.2) with extra sources such that the exact solution is given by

First, we examine a problem involving left/right-side periodic boundary conditions and top/bottom interfaces on the domain $\Omega=[0,2] \times[0,1]$. A uniform triangular partition is em-
ployed, featuring $M+1$ vertices in the $y$-direction and $2 M+1$ vertices in the $x$-direction, where $h=1 / M$. The classical lowest-order Taylor-Hood element is utilized for spatial discretization. To verify the $L^{2}$-norm error estimates, we set all involved parameters to 1 . Our algorithm is applied to solve the system with $M=8,16,32, \tau=h^{3}$, and the terminal time $T=0.1$. The numerical results are presented in Table 1, which shows that the algorithm has third-order accuracy for velocity and displacement in the $L^{2}$-norm, as well as second-order accuracy for pressure in the $L^{2}$-norm and displacement in the energy-norm. These numerical results align with our theoretical analysis.

Next, we test our algorithm for a model with Dirichlet boundary condition on the left and right boundaries, using the same configuration as previously described. Both the lowest-order Taylor-Hood element and the MINI element are employed for spatial discretization. For the Taylor-Hood element and the MINI element, we adopt $\tau=h^{3}$ and $\tau=h^{2}$ in the computation, respectively. The numerical results are displayed in Table 2. As observed in Table 2, the algorithm, when paired with both the Taylor-Hood element and the MINI element, yields numerical results exhibiting optimal convergence orders for $\mathbf{u}$ and $\eta$.

Example 5.2. We consider a benchmark model which was studied by many people $12,13,21$, $23,27,39,42$. All the quantities will be given in the CGS system of units [21]. The model is described by (1.1)-1.2) in $\Omega=(0,5) \times(0,0.5)$ with the physical parameters: fluid density $\rho_{f}=1$, fluid viscosity $\mu=0.035$, solid density $\rho_{s}=1.1$, the thickness of wall $\epsilon_{s}=0.1$, Young's modulus $E=0.75 \times 10^{6}$, Poisson's ratio $\sigma=0.5$ and

$$
C_{0}=\frac{E \epsilon_{s}}{2(1+\sigma)}, \quad C_{1}=\frac{E \epsilon_{s}}{R^{2}\left(1-\sigma^{2}\right)},
$$

where $R=0.5$ is the width of the domain $\Omega$. The boundary conditions on the in/out-flow sides $(x=0, x=5)$ are defined by $\sigma(\mathbf{u}, p) \mathbf{n}=-p_{\text {in/out }} \mathbf{n}$ where

with $p_{\max }=1.3333 \times 10^{4}$ and $t_{\max }=0.003$. The top and bottom sides of $\Omega$ are thin structures, and the fluid is initially at rest. We take a uniform triangular partition with $M+1$ vertices in $y$-direction and $10 M+1$ vertices in $x$-direction $(h=1 / M)$, and solve the system by our
algorithm where the lowest-order Taylor-Hood finite element approximation is used with the spatial mesh size $h=1 / 64(M=64)$, the temporal step size $\tau=h^{3}$ and the parameter $\beta=0.5$. We present the contour of pressure $p$ in Figure 2 at $t=0.003,0.009,0.016,0.026$ (from top to bottom). We can see a forward moving pressure wave(red), which reaches the right-end of the domain and gets reflected. The reflected wave is characterized by the different color(blue) of the pressure, which was also observed in 21, 23, 27].

Example 5.3. Finally, we consider the 3D blood flow simulation in common carotid arteries studied in 42. The blood flow is modeled by the Navier-Stokes equation, while the analysis was presented only for the model with Stokes equation. The weak form of the arterial wall model is:

for any $\mathbf{w} \in \mathbf{S}$, where $\nabla_{s}$ denote the surface gradient on the interface $\Sigma$ and

\mathbf{\Pi}_{s}(\eta)=\frac{E}{1+\sigma^{2}} \frac{\nabla_{s} \eta+\nabla_{s}^{T} \eta}{2}+\frac{E \sigma}{1-\sigma^{2}} \nabla_{s} \cdot \eta \mathbf{I}

for a linearly elastic isotropic structure. The geometrical domain is a straight cylinder of length 4 cm and radius 0.3 cm , see Fugure 3. The hemodynamical parameters used in this model are given in the Table 3 .


Figure 3: The geometrical domain and the prescribed inlet velocity and outlet pressure
For the inlet and outlet boundary conditions, we set

$$

The waveforms of $u_{D}(t)$ and $p_{\text {out }}(t)$ are given in Figure 3. The pulsatile periodic shapes of waveforms are studied in 22,31 .

The fluid mesh used in this example consists of 11745 tetrahedral elements, while the structure mesh consists of 3786 triangles. We used the $P 2-P 1$ finite element approximation for the

velocity and pressure of the fluid, the P2 finite element approximation for the displacement of the structure. For comparison, both classical monolithic scheme and the proposed partitioned scheme are used for solving this example, where the parameter $\beta=0.5$. The initial velocity/pressure is the smooth constant extension of the inlet/outlet boundary data at $t=0$ for both schemes. The terminal time $T=3 \mathrm{~s}$ which corresponds to 3 cardiac cycles. We have observed that the periodic pattern was established after 1 cardiac cycle. The comparison of the radial displacement magnitude of the artery wall obtained by our partitioned scheme and monolithic scheme at the interface point $(2,0.3,0)$ in the whole 3 cardiac cycles is shown in Figure 4 . The axial velocity and pressure at the center point $(2,0,0)$ in the third cardiac cycle are presented in Figure 56.

## 6 Conclusion

We have proposed a new stable fully discrete kinematically coupled scheme which decouples fluid velocity from the structure displacement for solving a thin-structure interaction problem described by (1.1-1.3). To the best of our knowledge, the optimal-order convergence in $L^{2}$ norm of spatially finite element methods for such problems has not been established in the previous works. Our scheme in 2.19 - 2.20 contains two stabilization terms

\rho_{s} \epsilon_{s}\left(\frac{\mathbf{u}_{h}^{n}-\mathbf{s}_{h}^{n}}{\tau}, \frac{\tau}{\rho_{s} \epsilon_{s}} \sigma\left(\mathbf{v}_{h}, q_{h}\right) \cdot \mathbf{n}\right)_{\Sigma} \quad \text { and } \quad\left(\left(\sigma_{h}^{n}-\sigma_{h}^{n-1}\right) \cdot \mathbf{n}, \frac{\tau(1+\beta)}{\rho_{s} \epsilon_{s}} \sigma\left(\mathbf{v}_{h}, q_{h}\right) \cdot \mathbf{n}\right)_{\Sigma}
$$

which guarantee the unconditional stability of the method, and an additional parameter $\beta>0$ which is helpful for us to prove optimal-order convergence in the $L^{2}$ norm for the fully discrete finite element scheme. Moreover, we have developed a new approach for the numerical analysis of such thin-structure interaction problems in terms of a newly introduced coupled non-stationary Ritz projection, with rigorous analysis for its approximation properties through analyzing its dual problem, which turns out to be equivalent to a backward evolution equation on the boundary $\Sigma$, i.e.,

-\mathcal{L}_{s} \mathcal{N} \boldsymbol{\xi}+\mathcal{N} \boldsymbol{\xi}-\partial_{t} \boldsymbol{\xi}=\mathbf{f} \text { on } \Sigma \times[0, T), \text { with initial condition } \boldsymbol{\xi}(T)=0,

in terms of the Neumann-to-Dirichlet map $\mathcal{N}: H^{-\frac{1}{2}}(\Sigma)^{d} \rightarrow H^{\frac{1}{2}}(\Sigma)^{d}$ associated to the Stokes equations. Although we have focused on the analysis for the specific kinematically coupled scheme proposed in this article for a thin-structure interaction problem, the new approach developed in this article, including the non-stationary Ritz projection and its approximation properties, may be extended to many other fully discrete monolithic and partitioned coupled algorithms and to more general fluid-structure interaction models.

## Appendix A: Proof of Lemma 4.5

In this appendix, we prove Lemma 4.5 via the following proposition, where equation (A.1) differs from (4.40) via a change of variable $t \rightarrow T-t$ in time.

Proposition A.1. The initial-boundary value problem

has a unique solution $(\phi, q)$ which satisfies the following regularity estimate:

\end{equation*}

Proof. We divide the proof into three parts. In the first part, we introduce the Neumann-toDirichlet operator and reformulate (A.1) into an evolution equation (A.4) on the boundary $\Sigma$ with the aid of Neumann-to-Dirichlet operator, and then establish some mapping properties of the Neumann-to-Dirichlet operator to be used in the proof of Proposition A.1. In the second part, we establish the existence, uniqueness and regularity of solutions to an equivalent formulation
of (A.1), i.e., equation (A.4 below. Finally, in the third part, we establish regularity estimates for the solutions to A.1).

Part 1. We can define the Neumann-to-Dirichlet operator $\mathcal{N}: H^{-1 / 2}(\Sigma)^{d} \rightarrow H^{1 / 2}(\Sigma)^{d}$ as $\left.\zeta \mapsto\left(\mathcal{N}^{v} \zeta\right)\right|_{\Sigma}$, with $\left(\mathcal{N}^{v} \zeta, \mathcal{N}^{p} \zeta\right)$ being the solution of the following Stokes equation:

b\left(q, \mathcal{N}^{v} \boldsymbol{\zeta}\right) & =0 & & \forall q \in L^{2}(\Omega) \tag{A.3b}
\end{align*}
$$

Therefore,

-\nabla \cdot \sigma\left(\mathcal{N}^{v} \boldsymbol{\zeta}, \mathcal{N}^{p} \boldsymbol{\zeta}\right)+\mathcal{N}^{v} \boldsymbol{\zeta}=0 \text { in } \Omega \quad \text { and } \quad \sigma\left(\mathcal{N}^{v} \boldsymbol{\zeta}, \mathcal{N}^{p} \boldsymbol{\zeta}\right) \mathbf{n}=\boldsymbol{\zeta} \text { on } \Sigma .
$$

Let $\boldsymbol{\xi}=\sigma(\phi, q) \mathbf{n}$. Then it is easy to see that problem A.1) can be equivalently formulated as follows: Find $\boldsymbol{\xi}(t) \in H^{1}(\Sigma)^{d}$ for $t \in[0, T]$ satisfying the following evolution equation:

By choosing $\mathbf{v}=\mathcal{N}^{v} \boldsymbol{\varphi}$ in A.3) and using relation $b\left(\mathcal{N}^{p} \boldsymbol{\zeta}, \mathcal{N}^{v} \boldsymbol{\varphi}\right)=0$ (due to the definition of $\mathcal{N}^{v} \varphi$ ), we obtain

(\zeta, \mathcal{N} \zeta)_{\Sigma}=2 \mu\left\|\mathcal{N}^{v} \zeta\right\|_{f}^{2}+\left\|\mathcal{N}^{v} \zeta\right\|^{2} \sim\left\|\mathcal{N}^{v} \zeta\right\|_{H^{1}}^{2} \sim\|\mathcal{N} \zeta\|_{H^{1 / 2}(\Sigma)}^{2} \quad \forall \zeta \in H^{-1 / 2}(\Sigma)^{d} \tag{A.6}
\end{equation*}
$$

By choosing $k=s$ in the regularity result in 2.7 with $s \geq-1 / 2, s \in \mathbb{R}$ and noting the trace inequality, we can establish the following mapping property of the Neumann-to-Dirichlet operator:

Note that $\mathcal{N} \zeta=0$ if and only if $\zeta=\lambda \mathbf{n}$ for some scalar constant $\lambda \in \mathbb{R}$. This motivates us to define the following subspace of $H^{s}(\Sigma)^{d}$ for $s \in \mathbb{R}$ :

Then we define the Dirichlet-to-Neumann operator $\mathcal{D}: \widetilde{H}^{1 / 2}(\Sigma)^{d} \rightarrow \widetilde{H}^{-1 / 2}(\Sigma)^{d}$ as follows: For $\boldsymbol{\zeta} \in \widetilde{H}^{1 / 2}(\Sigma)^{d}$, let $\left(\mathcal{D}^{v} \boldsymbol{\zeta}, \mathcal{D}^{p} \boldsymbol{\zeta}\right)$ be the weak solution of

\end{align*}
$$

and then define $\mathcal{D} \zeta \in \widetilde{H}^{-1 / 2}(\Sigma)^{d}$ by the following equation

\begin{equation*}
a_{f}\left(\mathcal{D}^{v} \boldsymbol{\zeta}, \mathbf{v}\right)-b\left(\mathcal{D}^{p} \boldsymbol{\zeta}, \mathbf{v}\right)+\left(\mathcal{D}^{v} \boldsymbol{\zeta}, \mathbf{v}\right)=(\mathcal{D} \boldsymbol{\zeta}, \mathbf{v})_{\Sigma} \quad \forall \mathbf{v} \in H^{1}(\Omega)^{d} \tag{A.9}
\end{equation*}
$$

Since the function $\mathcal{D}^{p} \zeta$ in equation A.8) is only determined up to a constant, we can choose this constant in such a way that the function $\mathcal{D} \boldsymbol{\zeta}$ defined by A.9) lies in $\widetilde{H}^{-1 / 2}(\Sigma)^{d}$. Using trace theorem and Bogovoski's map (cf. 18, Corollary 1.5]) there exists $\mathbf{v} \in H^{1}(\Omega)^{d}$ such that $\left.\mathbf{v}\right|_{\Sigma}=\mathbf{n}, \nabla \cdot \mathbf{v}=\frac{\|\mathbf{n}\|_{\Sigma}^{2}}{|\Omega|}$ with $\|\mathbf{v}\|_{H^{1}} \leq C$, testing $A .9$ with such $\mathbf{v}$, noting the assumption that $(\mathcal{D} \boldsymbol{\zeta}, \mathbf{n})_{\Sigma}=0$, we obtain

where $\overline{\mathcal{D}^{p} \boldsymbol{\zeta}}$ is the mean value of $\mathcal{D}^{p} \boldsymbol{\zeta}$ over $\Omega$. Therefore, choosing $k=s$ with $s \geq 1 / 2, s \in \mathbb{R}$ in (2.8) and combining A.10) leads to the following estimates

From the weak form A.9), it follows that

Meanwhile when $s \geq 3 / 2$, by trace inequality we have

Combining A.12, A.13 and A.11 leads to the following estimates of the Neumann value $\mathcal{D} \boldsymbol{\zeta}$
in terms of the Dirichlet value $\zeta$ :

&\|\mathcal{D} \zeta\|_{H^{s-1}(\Sigma)} \leq C\|\zeta\|_{H^{s}(\Sigma)} \quad \forall \zeta \in \widetilde{H}^{s}(\Sigma)^{d} . \quad(\text { whenever } s \geq 3 / 2, s \in \mathbb{R}) \tag{A.14}
\end{align*}
$$

The following complex interpolation of Sobolev spaces hold:

{\left[H^{k}(\Sigma)^{d}, H^{s}(\Sigma)^{d}\right]_{\theta} } & =H^{\theta s+(1-\theta) k}(\Sigma)^{d} \tag{A.15a}
\end{align*} \quad \forall k, s \in \mathbb{R}, \theta \in[0,1] ;

where A.15a follows from [44, Proposition 3.1-3.2 of Chapter 4] and A.15b follows from A.15a because $\widetilde{H}^{s}(\Sigma)^{d}$ is a retract of $H^{s}(\Sigma)^{d}$ for $s \in \mathbb{R}$ via projection $\pi: H^{s}(\Sigma)^{d} \rightarrow \widetilde{H}^{s}(\Sigma)^{d}$, with

\pi(\zeta):=\zeta-\frac{(\zeta, \mathbf{n})_{\Sigma}}{\|\mathbf{n}\|_{\Sigma}^{2}} \mathbf{n} \tag{A.16}
\end{equation*}

Therefore, the following result follows from the complex interpolation between the two estimates in A.14:

If we restrict the domain of $\mathcal{N}$ to $\widetilde{H}^{-1 / 2}(\Sigma)^{d}$, then $\mathcal{N}: \widetilde{H}^{-1 / 2}(\Sigma)^{d} \rightarrow \widetilde{H}^{1 / 2}(\Sigma)^{d}$ and $\mathcal{D}$ : $\widetilde{H}^{1 / 2}(\Sigma)^{d} \rightarrow \widetilde{H}^{-1 / 2}(\Sigma)^{d}$ are inverse maps of each other. This leads to the following norm equivalence:

Similarly, from identity $\mathcal{D N} \boldsymbol{\zeta}=\mathcal{N D} \boldsymbol{\mathcal { D }}=\boldsymbol{\zeta}$ for $\boldsymbol{\zeta} \in \widetilde{H}^{1 / 2}(\Sigma)^{d}$ and the mapping property in A.17) and A.7), we conclude that the maps $\mathcal{N}: \widetilde{H}^{s}(\Sigma)^{d} \rightarrow \widetilde{H}^{s+1}(\Sigma)^{d}$ and $\mathcal{D}: \widetilde{H}^{s+1}(\Sigma)^{d} \rightarrow \widetilde{H}^{s}(\Sigma)^{d}$ are also inverse to each other for all $s \geq-1 / 2, s \in \mathbb{R}$. This implies the following norm equivalence for $s \geq-1 / 2, s \in \mathbb{R}$ :

\|\zeta\|_{H^{s}(\Sigma)} \sim\|\mathcal{N} \zeta\|_{H^{s+1}(\Sigma)} ;\|\zeta\|_{H^{s+1}(\Sigma)} \sim\|\mathcal{D} \zeta\|_{H^{s}(\Sigma)} \quad \forall \zeta \in \widetilde{H}^{-1 / 2}(\Sigma)^{d} \tag{A.18}

To facilitate further use, we summarize the properties of the NtD (Neumann to Dirichlet) operator and DtN (Dirichlet to Neumann) operator in the following lemma:

## Lemma A.1.

1. For $s \geq-1 / 2, s \in \mathbb{R}$, the NtD operator $\mathcal{N}: \widetilde{H}^{s}(\Sigma)^{d} \rightarrow \widetilde{H}^{s+1}(\Sigma)^{d}$ and DtN operator $\mathcal{D}: \widetilde{H}^{s+1}(\Sigma)^{d} \rightarrow \widetilde{H}^{s}(\Sigma)^{d}$ are bounded and inverse to each other.
2. With domain $\operatorname{dom}(\mathcal{D}):=\widetilde{H}^{1}(\Sigma)^{d} \subseteq \widetilde{L}^{2}(\Sigma)^{d}$, the DtN operator $\mathcal{D}$ is a self-adjoint positivedefinite operator on $\widetilde{L}^{2}(\Sigma)^{d}$. The NtD operator $\mathcal{N}: \widetilde{L}^{2}(\Sigma)^{d} \rightarrow \widetilde{L}^{2}(\Sigma)^{d}$ is a compact self-adjoint positive-definite operator on $\widetilde{L}^{2}(\Sigma)^{d}$.
3. The square root operators $\mathcal{D}^{1 / 2}$ and $\mathcal{N}^{1 / 2}$ are well defined. Moreover, for $s \geq-1 / 2, s \in \mathbb{R}$, operators $\mathcal{N}^{1 / 2}: \widetilde{H}^{s}(\Sigma)^{d} \rightarrow \widetilde{H}^{s+1 / 2}(\Sigma)^{d}$ and $\mathcal{D}^{1 / 2}: \widetilde{H}^{s+1 / 2}(\Sigma)^{d} \rightarrow \widetilde{H}^{s}(\Sigma)^{d}$ are bounded and inverse to each other.

Proof. The three statements are proved as follows.

1. The first statement has been proved in A.18).
2. From A.5) and A.6 it follows that $\mathcal{N}$ is self-adjoint positive-definite operator on $\widetilde{L}^{2}(\Sigma)^{d}$. Since $H^{1}(\Sigma)^{d} \rightarrow \widetilde{L}^{2}(\Sigma)^{d}$ is a compact embedding by Rellich-Kondrachov theorem (cf. 44, Proposition 3.4 of Chapter 4]), from mapping property (A.7) of $\mathcal{N}$ it follows that $\mathcal{N}$ is a compact operator. To verify $\mathcal{D}: \operatorname{dom}(\mathcal{D}) \rightarrow \widetilde{L}^{2}(\Sigma)^{d}$ is self-adjoint, it suffices to show that if $\zeta$ satisfies

then $\boldsymbol{\zeta} \in \widetilde{H}^{1}(\Sigma)^{d}$. From A.199, by Riesz representation theorem there exists $\mathbf{g} \in \widetilde{L}^{2}(\Sigma)^{d}$ such that

(\zeta, \mathcal{D} \varphi)_{\Sigma}=(\mathbf{g}, \varphi)_{\Sigma} \quad \forall \varphi \in \widetilde{H}^{1}(\Sigma)^{d} .

Especially, taking $\varphi=\mathcal{N} \xi$, it follows that

Therefore $\boldsymbol{\zeta}=\mathcal{N} \mathbf{g} \in \widetilde{H}^{1}(\Sigma)^{d}$, proof of the second statement is complete.
3. By the spectrum theory of compact self-adjoint operator (cf. [7, Theorem 5.3.16]), $\widetilde{L}^{2}(\Sigma)^{d}$ admits an orthornormal basis of eigenvectors $\left\{\omega_{i}\right\}_{i \in \mathbb{N}}$ of $\mathcal{N}$ and $\mathcal{N}$ has the following expression

\mathcal{N} \zeta=\sum_{i=1}^{\infty}\left(\mathcal{N} \zeta, \omega_{i}\right)_{\Sigma} \omega_{i}=\sum_{i=1}^{\infty} \lambda_{i}\left(\zeta, \omega_{i}\right)_{\Sigma} \omega_{i} \quad \forall \zeta \in \widetilde{H}^{-1 / 2}(\Sigma)^{d},
$$

where $\lambda_{i}>0$ is the eigenvalue associated with $\omega_{i}$. From norm equivalence A.18, we can deduce that for $s \in \mathbb{N}$ there holds

\|\boldsymbol{\zeta}\|_{H^{s}(\Sigma)} \sim\left\|\mathcal{D}^{s} \zeta\right\|_{\Sigma}=\left(\sum_{i=1}^{\infty} \lambda_{i}^{-2 s}\left|\left(\zeta, \omega_{i}\right)_{\Sigma}\right|^{2}\right)^{1 / 2} \quad \forall s \in \mathbb{N} . \tag{A.20}
\end{equation*}

In view of complex interpolation result of weighted $\ell^{2}$-sequence spaces (cf. [5, Theorem 5.5.3]), in fact (A.20 is valid for all $s \geq 0, s \in \mathbb{R}$ by complex interpolation method. Moreover for $-1 / 2 \leq s<0$, using norm equivalence A.18) and A.20) (which is valid for $s \geq 0, s \in \mathbb{R}$ ) we have

\|\zeta\|_{H^{s}(\Sigma)} \sim\|\mathcal{N} \zeta\|_{H^{s+1}(\Sigma)} \sim\left(\sum_{i=1}^{\infty} \lambda_{i}^{-2 s}\left|\left(\zeta, \omega_{i}\right)_{\Sigma}\right|^{2}\right)^{1 / 2} \quad \forall s \in \mathbb{R},-1 / 2 \leq s<0 . \tag{A.21}
\end{equation*}
$$

Combining A.20 and A.21, we arrive at

$$
\begin{equation*}
\|\zeta\|_{H^{s}(\Sigma)} \sim\left(\sum_{i=1}^{\infty} \lambda_{i}^{-2 s}\left|\left(\zeta, \omega_{i}\right)_{\Sigma}\right|^{2}\right)^{1 / 2} \quad \forall s \geq-1 / 2, s \in \mathbb{R} \tag{A.22}
\end{equation*}
$$

We can define square root operators $\mathcal{N}^{1 / 2}$ and $\mathcal{D}^{1 / 2}$ by formula

$$
\begin{array}{ll}
\mathcal{N}^{1 / 2} \zeta:=\sum_{i=1}^{\infty} \lambda_{i}^{1 / 2}\left(\zeta, \omega_{i}\right)_{\Sigma} \omega_{i} & \left.\forall \zeta \in \widetilde{H}^{-1 / 2}(\Sigma)^{d} \quad \text { (this series converges in } \widetilde{L}^{2}(\Sigma)^{d}\right) \\
\mathcal{D}^{1 / 2} \zeta:=\sum_{i=1}^{\infty} \lambda_{i}^{-1 / 2}\left(\zeta, \omega_{i}\right)_{\Sigma} \omega_{i} & \left.\forall \zeta \in \widetilde{L}^{2}(\Sigma)^{d} \quad \text { (this series converges in } \widetilde{H}^{-1 / 2}(\Sigma)^{d}\right),
\end{array}
$$

from the norm equivalence in $(\mathrm{A} .22)$, it is direct to verify that operators $\mathcal{N}^{1 / 2}$ and $\mathcal{D}^{1 / 2}$ are inverse to each other and satisfy the following mapping property for $s \geq-1 / 2, s \in \mathbb{R}$

$$
\begin{equation*}
\|\zeta\|_{H^{s}(\Sigma)} \sim\left\|\mathcal{N}^{1 / 2} \zeta\right\|_{H^{s+1 / 2}(\Sigma)} ;\|\zeta\|_{H^{s+1 / 2}(\Sigma)} \sim\left\|\mathcal{D}^{1 / 2} \zeta\right\|_{H^{s}(\Sigma)} \quad \forall \zeta \in \widetilde{H}^{-1 / 2}(\Sigma)^{d} . \tag{A.23}
\end{equation*}
$$

The proof of third statement is complete.

Part 2. Taking into account of the fact that $\mathcal{N}$ is not injective on $L^{2}(\Sigma)^{d}$, for convenience of our further construction we first take the $L^{2}$-orthogonal projection $\pi: L^{2}(\Sigma)^{d} \rightarrow \widetilde{L}^{2}(\Sigma)^{d}$ defined as in A.16 on the both side of A.4), and obtain the following equation with solution space contained in $\widetilde{L}^{2}(\Sigma)^{d}$ : seek $\widetilde{\boldsymbol{\xi}} \in L^{2} \widetilde{H}^{1}(\Sigma)^{d}$ with $\partial_{t} \widetilde{\boldsymbol{\xi}} \in L^{2} \widetilde{L}^{2}(\Sigma)^{d}$ satisfying

\begin{equation*}
\partial_{t} \widetilde{\xi}+\mathcal{A} \widetilde{\xi}=\widetilde{\mathbf{f}} ; \quad \widetilde{\xi}(0)=0 \tag{A.24}
\end{equation*}
$$

where $\mathcal{A}=\pi\left(I-\mathcal{L}_{s}\right) \mathcal{N}$ and $\widetilde{\mathbf{f}}=\pi \mathbf{f}$. One difficulty in proving existence and regularity of solution to A.24) is that the operator $\mathcal{A}: \widetilde{H}^{1}(\Sigma)^{d} \rightarrow \widetilde{L}^{2}(\Sigma)^{d}$ is not a self-adjoint operator in $\widetilde{L}^{2}(\Sigma)^{d}$. To overcome this difficulty, we consider the following change of variable $\omega=\mathcal{N}^{1 / 2} \widetilde{\xi}$, and reformulate
A.24 into an abstract Cauchy problem on $\omega$ : seek $\omega \in L^{2} \widetilde{H}^{1}(\Sigma)^{d}$ with $\partial_{t} \omega \in L^{2} \widetilde{L}^{2}(\Sigma)^{d}$ satisfying

$$
\begin{equation*}
\partial_{t} \omega+\mathcal{B} \omega=\mathbf{g} ; \quad \omega(0)=0 \tag{A.25}
\end{equation*}
$$

where $\mathcal{B}:=\mathcal{N}^{1 / 2} \pi\left(I-\mathcal{L}_{s}\right) \mathcal{N}^{1 / 2}$ and $\mathbf{g}:=\mathcal{N}^{1 / 2} \widetilde{\mathbf{f}}$. We summarize some useful properties on the operators $\mathcal{A}$ and $\mathcal{B}$ in the following lemma:

## Lemma A.2.

1. There holds norm equivalence for $0 \leq s \leq 1, s \in \mathbb{R}$

\|\mathcal{A} \boldsymbol{\zeta}\|_{H^{s}(\Sigma)} \sim\|\boldsymbol{\zeta}\|_{H^{s+1}(\Sigma)} ; \quad\|\mathcal{B} \boldsymbol{\zeta}\|_{H^{s}(\Sigma)} \sim\|\boldsymbol{\zeta}\|_{H^{s+1}(\Sigma)} \quad \forall \boldsymbol{\zeta} \in \widetilde{H}^{-1 / 2}(\Sigma)^{d} \tag{A.26}
\end{equation*}
$$

2. $\mathcal{B}$ is a self-adjoint positive-definite operator on $\widetilde{L}^{2}(\Sigma)^{d}$ with domain $\operatorname{dom}(\mathcal{B}):=\widetilde{H}^{1}(\Sigma)^{d}$.

Proof. The two statements are proved as follows.

1. In view of the norm equivalence relations in A.18 and A.23, it suffices to show the following norm equivalence for $-1 \leq s \leq 1, s \in \mathbb{R}$

\begin{equation*}
\left\|\pi\left(I-\mathcal{L}_{s}\right) \zeta\right\|_{H^{s}(\Sigma)} \sim\|\zeta\|_{H^{s+2}(\Sigma)} \quad \forall \zeta \in \widetilde{H}^{-1 / 2}(\Sigma)^{d} \tag{А.27}
\end{equation*}
$$

Note that one direction of the norm equivalence in A.27) is given by assumption 2.3. To prove the opposite direction, observe first that

$$

It follows that A.27 is valid for $s=-1$. Next we note that, by definition A.16 of projection $\pi: H^{s}(\Sigma)^{d} \rightarrow \widetilde{H}^{s}(\Sigma)^{d}$,

\left\|\pi\left(I-\mathcal{L}_{s}\right) \boldsymbol{\zeta}-\left(I-\mathcal{L}_{s}\right) \boldsymbol{\zeta}\right\|_{H^{s}(\Sigma)} \leq C\left|\left(\boldsymbol{\zeta},\left(I-\mathcal{L}_{s}\right) \mathbf{n}\right)_{\Sigma}\right| \leq C\|\boldsymbol{\zeta}\|_{H^{1}(\Sigma)} \tag{A.28}
\end{equation*}
$$

For $-1 \leq s \leq 1, s \in \mathbb{R}$, in view of regularity assumption (2.9) and the estimate A.28) above, we have

$$
\begin{aligned}
\|\boldsymbol{\zeta}\|_{H^{s+2}(\Sigma)} & \leq C\left\|\left(I-\mathcal{L}_{s}\right) \boldsymbol{\zeta}\right\|_{H^{s}(\Sigma)} \\
& \leq C\left\|\pi\left(I-\mathcal{L}_{s}\right) \boldsymbol{\zeta}\right\|_{H^{s}(\Sigma)}+C\|\boldsymbol{\zeta}\|_{H^{1}(\Sigma)} \\
& \left.\leq C\left\|\pi\left(I-\mathcal{L}_{s}\right) \boldsymbol{\zeta}\right\|_{H^{s}(\Sigma)} \quad \text { (this is because A.27) is valid for } s=-1\right)
\end{aligned}
$$

Thus A.27) is proved and the first statement follows directly.
2. Since $\mathcal{B}$ is obviously symmetric and positive definite on its domain $\operatorname{dom}(B)=\widetilde{H}^{1}(\Sigma)^{d}$. To prove that $\mathcal{B}$ is self-adjoint, it remains to show that the domain of the dual operator $\mathcal{B}^{\prime}$ defined by

$$
\operatorname{dom}\left(\mathcal{B}^{\prime}\right)=\left\{\mathbf{w} \in \widetilde{L}^{2}(\Sigma)^{d}: \exists \mathbf{g} \in \widetilde{L}^{2}(\Sigma)^{d} \text { such that }(\boldsymbol{\omega}, \mathcal{B} \boldsymbol{\zeta})_{\Sigma}=(\mathbf{g}, \boldsymbol{\zeta})_{\Sigma} \quad \forall \boldsymbol{\zeta} \in \widetilde{H}^{1}(\Sigma)^{d}\right\}
$$

coincides with the domain of $\mathcal{B}$. Therefore, we need to prove that if $\omega \in \widetilde{L}^{2}(\Sigma)^{d}$ satisfies

$$
\begin{equation*}
(\omega, \mathcal{B} \zeta)_{\Sigma}=(\mathbf{g}, \zeta)_{\Sigma} \quad \forall \zeta \in \widetilde{H}^{1}(\Sigma)^{d} \tag{A.29}
\end{equation*}
$$

for some $\mathbf{g} \in \widetilde{L}^{2}(\Sigma)^{d}$, then $\boldsymbol{\omega} \in \widetilde{H}^{1}(\Sigma)^{d}$. To this end, we define $\boldsymbol{\varphi} \in \widetilde{H}^{1}(\Sigma)^{d}$ to be the weak solution of equation

$$
\begin{equation*}
a_{s}(\boldsymbol{\varphi}, \boldsymbol{\zeta})+(\boldsymbol{\varphi}, \boldsymbol{\zeta})_{\Sigma}=\left(\mathcal{D}^{1 / 2} \mathbf{g}, \boldsymbol{\zeta}\right)_{\Sigma} \quad \forall \boldsymbol{\zeta} \in \widetilde{H}^{1}(\Sigma)^{d} \tag{A.30}
\end{equation*}
$$

where the existence and uniqueness of solution to A.30 is due to coercive property: $\|\boldsymbol{\zeta}\|_{s}^{2}+\|\boldsymbol{\zeta}\|_{\Sigma}^{2} \sim\|\boldsymbol{\zeta}\|_{H^{1}(\Sigma)}^{2}, \forall \boldsymbol{\zeta} \in \widetilde{H}^{1}(\Sigma)^{d}$. Equation A.30 means

$$
\pi\left(I-\mathcal{L}_{s}\right) \varphi=\mathcal{D}^{1 / 2} \mathbf{g} \in \widetilde{H}^{-1 / 2}(\Sigma)^{d}
$$

thus by norm equivalence A.27 we have $\varphi \in \widetilde{H}^{3 / 2}(\Sigma)^{d}$. Now we observe

$$
\begin{equation*}
\left(\mathcal{D}^{1 / 2} \varphi, \mathcal{B} \zeta\right)_{\Sigma}=\left(\pi\left(I-\mathcal{L}_{s}\right) \varphi, \mathcal{N}^{1 / 2} \zeta\right)_{\Sigma}=\left(\mathcal{D}^{1 / 2} \mathbf{g}, \mathcal{N}^{1 / 2} \zeta\right)_{\Sigma}=(\mathbf{g}, \zeta)_{\Sigma} \quad \forall \zeta \in \widetilde{H}^{1}(\Sigma)^{d} \tag{A.31}
\end{equation*}
$$

By comparing A.29 with A.31 we obtain $\omega=\mathcal{D}^{1 / 2} \varphi \in \widetilde{H}^{1}(\Sigma)^{d}$. This completes the proof.

Especially, since $\mathcal{B}$ is a self-adjoint positive-definite operator on $\widetilde{L}^{2}(\Sigma)^{d}$ with domain $\operatorname{dom}(\mathcal{B}):=$ $\widetilde{H}^{1}(\Sigma)^{d},-\mathcal{B}$ generates an analytic semigroup $E(t): \widetilde{L}^{2}(\Sigma)^{d} \rightarrow \widetilde{L}^{2}(\Sigma)^{d}$ for $t \geq 0$ (cf. (7, Example 7.4.5]), and the unique solution to A.25 is given by

\omega(t)=\int_{0}^{t} E(t-s) \mathbf{g}(s) d s
$$

Moreover, for self-adjoint semigroup on a Hilbert space, the following $L^{2}$-maximal regularity estimate holds (cf. [7, Theorem 7.6.11]):

$$
\begin{equation*}
\left\|\partial_{t} \omega\right\|_{L^{2} L^{2}(\Sigma)}+\|\mathcal{B} \omega\|_{L^{2} L^{2}(\Sigma)} \leq C\|\mathbf{g}\|_{L^{2} L^{2}(\Sigma)}, \tag{A.32}
\end{equation*}
$$

which can be obtained by testing A.25 with $\partial_{t} \omega$. If the source term $\mathbf{g}$ in A.25 possesses higher spacial regularity, the solution $\omega$ also inherits higher spacial regularity. To see this, assume $\mathbf{g} \in L^{2} \widetilde{H}^{1}(\Sigma)^{d}$, then since

\mathcal{B} \omega(t)=\int_{0}^{t} E(t-s) \mathcal{B} \mathbf{g}(s) d s
$$

is the solution to A.25 with the source term replaced by $\mathcal{B g}$. Thus again by maximal $L^{2}$ regularity estimate, we have

\left\|\mathcal{B} \partial_{t} \boldsymbol{\omega}\right\|_{L^{2} L^{2}(\Sigma)}+\left\|\mathcal{B}^{2} \omega\right\|_{L^{2} L^{2}(\Sigma)} \leq C\|\mathcal{B} \mathbf{g}\|_{L^{2} L^{2}(\Sigma)} . \tag{A.33}
\end{equation*}
$$

By norm equivalence in A.26, it follows that

$$
\begin{equation*}
\left\|\partial_{t} \boldsymbol{\omega}\right\|_{L^{2} H^{1}(\Sigma)}+\|\mathcal{B} \boldsymbol{\omega}\|_{L^{2} H^{1}(\Sigma)} \leq C\|\mathbf{g}\|_{L^{2} H^{1}(\Sigma)} . \tag{A.34}
\end{equation*}
$$

Complex interpolation of A.32 and A.34 gives

$$
\begin{equation*}
\left\|\partial_{t} \boldsymbol{\omega}\right\|_{L^{2} H^{1 / 2}(\Sigma)}+\|\mathcal{B} \omega\|_{L^{2} H^{1 / 2}(\Sigma)} \leq C\|\mathbf{g}\|_{L^{2} H^{1 / 2}(\Sigma)} . \tag{A.35}
\end{equation*}
$$

Now we take $\mathbf{g}=\mathcal{N}^{1 / 2} \widetilde{\mathbf{f}}$, then it is direct to verify that $\widetilde{\boldsymbol{\xi}}:=\mathcal{D}^{1 / 2} \omega$ is the solution to A.24) and satisfies estimate

$$
\begin{equation*}
\left\|\partial_{t} \widetilde{\xi}\right\|_{L^{2} L^{2}(\Sigma)}+\|\widetilde{\boldsymbol{\xi}}\|_{L^{2} H^{1}(\Sigma)} \leq C\|\widetilde{\mathbf{f}}\|_{L^{2} L^{2}(\Sigma)}, \tag{A.36}
\end{equation*}
$$

where we have used norm equivalences in A.26) and A.23). Having obtained the solution $\widetilde{\xi}$ to equation A.24, if we write $\mathbf{f}(t)=\widetilde{\mathbf{f}}(t)+c(t) \mathbf{n}$ then it is direct to verify that $\boldsymbol{\xi}(t)=\widetilde{\boldsymbol{\xi}}(t)+k(t) \mathbf{n}$ is the solution to A.4), where $k(t)$ is given by

$$
\begin{aligned}
& \partial_{t} k=c-r(\widetilde{\boldsymbol{\xi}}) ; \quad k(0)=0 \\
& r(\widetilde{\boldsymbol{\xi}}):=\frac{\left(\left(I-\mathcal{L}_{S}\right) \mathcal{N} \widetilde{\boldsymbol{\xi}}, \mathbf{n}\right)_{\Sigma}}{\|\mathbf{n}\|_{\Sigma}^{2}},
\end{aligned}
$$

it follows that

$$
\begin{equation*}
\left\|\partial_{t} k\right\|_{L^{2}(0, T)} \leq C\left(\|\mathbf{f}\|_{L^{2} L^{2}(\Sigma)}+\|\widetilde{\boldsymbol{\xi}}\|_{L^{2} H^{1}(\Sigma)}\right) \leq C\|\mathbf{f}\|_{L^{2} L^{2}(\Sigma)} . \tag{A.37}
\end{equation*}
$$

Therefore, combining A.37) and A.36 we obtain

$$
\begin{equation*}
\left\|\partial_{t} \boldsymbol{\xi}\right\|_{L^{2} L^{2}(\Sigma)}+\|\boldsymbol{\xi}\|_{L^{2} H^{1}(\Sigma)} \leq C\|\mathbf{f}\|_{L^{2} L^{2}(\Sigma)} \tag{A.38}
\end{equation*}
$$

Part 3. Given the solution $\boldsymbol{\xi}$ to equation (A.4), we define $(\phi, q)=\left(\mathcal{N}^{v} \boldsymbol{\xi}, \mathcal{N}^{p} \boldsymbol{\xi}\right)$. Then $\boldsymbol{\xi}=\boldsymbol{\sigma}(\phi, q) \mathbf{n}$ and $\mathcal{N} \boldsymbol{\xi}=\left.\phi\right|_{\Sigma}$. Therefore, equation (A.4) can be written as
$-\mathcal{L}_{s} \phi+\phi=-\partial_{t} \sigma(\phi, q) \mathbf{n}+\mathbf{f} \quad$ on $\Sigma \times(0, T], \quad$ with initial condition $(\phi, q)(0)=(0,0)$.
Thus $(\phi, q)$ is a solution of equation A.11. Since $\sigma(\phi, q) \mathbf{n}(0)=0$, it follows that

\|\sigma(\phi, q) \mathbf{n}\|_{L^{\infty} L^{2}(\Sigma)} \leq C\left\|\partial_{t} \sigma(\phi, q) \mathbf{n}\right\|_{L^{2} L^{2}(\Sigma)} .

Therefore, $(\phi, q)$ satsifies the following estimate according to A.38) and the inequality above:

\|\sigma(\phi, q) \mathbf{n}\|_{L^{\infty} L^{2}(\Sigma)}+\|\phi\|_{L^{2} H^{2}(\Sigma)} \leq C\|\mathbf{f}\|_{L^{2} L^{2}(\Sigma)} \tag{A.39}
\end{equation*}
$$

Moreover, since $(\phi, q)$ is the solution of the homogeneous Stokes equation (with boundary value $\left.\left.\phi\right|_{\Sigma}=\mathcal{N} \boldsymbol{\xi}\right)$, the following two estimates follow from the regularity results of the Stokes equation
in 2.7-2.8):

\|\phi\|_{H^{2}}+\|\nabla q\| \leq C\left\|\left.\phi\right|_{\Sigma}\right\|_{H^{2}(\Sigma)} ; \quad\|\phi\|_{H^{1}}+\|q\| \leq C\|\sigma(\phi, q) \mathbf{n}\|_{H^{-1 / 2}(\Sigma)} \tag{A.40}
\end{equation*}
$$

Combining the estimates in A.39) and A.40, we obtain the result of Proposition A.1.
Proof of 4.42). Let $\widehat{\phi}=\phi(T-t)$ and $\hat{q}=q(T-t)$, then $\hat{\phi}$ and $\hat{q}$ is a solution of A. 1 in Proposition A.1, with source term $\widehat{\mathbf{f}}(t)=\mathbf{f}(T-t)$, thus we have

\|\phi\|_{L^{2} H^{2}(\Omega)}+\|\phi\|_{L^{2} H^{2}(\Sigma)}+\|q\|_{L^{2} H^{1}(\Omega)}+\|\sigma(\phi, q) \mathbf{n}\|_{L^{\infty} L^{2}(\Sigma)} \leq C\|\mathbf{f}\|_{L^{2} L^{2}(\Sigma)}
$$

The proof of Lemma 4.5 is complete.

## Appendix B: Proof of (4.16)

In this subsection, we assume that $r \geq 2$. Under this assumption, we establish a negative-norm estimate for the Dirichlet Stokes-Ritz projection $R_{h}^{D}$ in the following lemma.

Lemma B.3. For the Dirichlet Stokes-Ritz projection $R_{h}^{D}$ defined in 4.3), the following error estimate holds:

\end{equation*}
$$

Skectch of Proof. From the definition of $R_{h}^{D} \mathbf{u}$ in 4.3) we can see that the following relation holds on the boundary $\Sigma$ :

R_{h}^{S} \mathbf{u}-R_{h}^{D} \mathbf{u}=\frac{\left(R_{h}^{S} \mathbf{u}, \mathbf{n}\right)_{\Sigma}}{\left\|\mathbf{n}_{h}\right\|^{2}} \mathbf{n}_{h}=\frac{\left(R_{h}^{S} \mathbf{u}-\mathbf{u}, \mathbf{n}\right)_{\Sigma}}{\left\|\mathbf{n}_{h}\right\|^{2}} \mathbf{n}_{h}
$$

Since

$$
\frac{\left(R_{h}^{S} \mathbf{u}-\mathbf{u}, \mathbf{n}\right)_{\Sigma}}{\left\|\mathbf{n}_{h}\right\|^{2}} \lesssim C\left\|R_{h}^{S} \mathbf{u}-\mathbf{u}\right\|_{H^{-1}(\Sigma)} \leq C h^{r+2}
$$

it follows that $\left\|\mathbf{u}-R_{h}^{D} \mathbf{u}\right\|_{H^{-1}(\Sigma)} \leq C h^{r+2}$. Then B.1) follows from the same routine of duality argument for the Dirichlet Stokes-Ritz projection.

Next, we note that $\left\|\left(R_{s h} \mathbf{u}-\mathbf{u}\right)(0)\right\|$ also satisfies negative norm estimate below.
Lemma B.4. For the $R_{s h} \mathbf{u}(0)$ defined in 4.11), the following negative-norm estimate holds:

\end{equation*}

The regularity assumption in 2.9 implies that $\|\psi\|_{H^{3}(\Sigma)} \leq\|\varphi\|_{H^{1}(\Sigma)}$. We can extend $\psi$ to be a function (still denoted by $\psi$ ) which is defined in $\Omega$ with periodic boundary condition and satisfies $\|\psi\|_{H^{3}} \leq C\|\psi\|_{H^{3}(\Sigma)}$. Then the following relation can be derived:

& -a_{f}\left(\left(R_{h}^{D} \partial_{t} \mathbf{u}-\partial_{t} \mathbf{u}\right)(0), I_{h} \psi\right)+b\left(\left(R_{h}^{D} \partial_{t} p-\partial_{t} p\right)(0), I_{h} \psi\right) \\
& -\left(\left(R_{h}^{D} \partial_{t} \mathbf{u}-\partial_{t} \mathbf{u}\right)(0), I_{h} \psi\right) \\
\leq & C h^{r+2}\|\psi\|_{H^{3}(\Sigma)}+\left|a_{f}\left(\left(R_{h}^{D} \partial_{t} \mathbf{u}-\partial_{t} \mathbf{u}\right)(0), \psi\right)\right|+\left|b\left(\left(R_{h}^{D} \partial_{t} p \partial_{t}-p\right)(0), \psi\right)\right| \\
& +\left|\left(\left(R_{h}^{D} \partial_{t} \mathbf{u}-\partial_{t} \mathbf{u}\right)(0), \psi\right)\right|
\end{aligned}
$$

Since

\left(\mathbf{D}\left(R_{h}^{D} \partial_{t} \mathbf{u}-\partial_{t} \mathbf{u}\right)(0), \mathbf{D} \psi\right) & =-\left(\left(R_{h}^{D} \partial_{t} \mathbf{u}-\partial_{t} \mathbf{u}\right)(0), \nabla \cdot \mathbf{D} \psi\right)+\left(\left(R_{h}^{D} \partial_{t} \mathbf{u}-\partial_{t} \mathbf{u}\right)(0), \mathbf{n} \cdot \mathbf{D} \psi\right)_{\Sigma} \\
& \lesssim\left(\left\|\left(R_{h}^{D} \partial_{t} \mathbf{u}-\partial_{t} \mathbf{u}\right)(0)\right\|_{H^{-1}(\Omega)}+\left\|\left(R_{h}^{D} \partial_{t} \mathbf{u}-\partial_{t} \mathbf{u}\right)(0)\right\|_{H^{-1}(\Sigma)}\right)\|\psi\|_{H^{3}(\Omega)} \\
& \leq C h^{r+2}\|\varphi\|_{H^{1}(\Sigma)}
\end{aligned}

& \left(\left(R_{h}^{D} \partial_{t} \mathbf{u}-\partial_{t} \mathbf{u}\right)(0), \psi\right) \lesssim\left\|\left(R_{h}^{D} \partial_{t} \mathbf{u}-\partial_{t} \mathbf{u}\right)(0)\right\|_{H^{-1}}\|\psi\|_{H^{1}} \leq C h^{r+2}\|\varphi\|_{H^{1}(\Sigma)}
\end{aligned}

summing up the estimates above yields the result in (B.2). The proof is complete.

& +\left|a_{f}\left(e_{h}^{u}, \psi\right)-b\left(e_{h}^{p}, \psi\right)+\left(e_{h}^{u}, \psi\right)\right| . \tag{B.9}
\end{align*}

Using integrating by parts and negative-norm estimates in Lemma B.5, the following estimates can obtain:

& \geq C_{1}\left\|\widetilde{p}_{h}\right\|^{2}+\epsilon b\left(\widetilde{p}_{h}, \mathbf{v}_{h}^{e}\right)+\epsilon C_{2}\left\|\bar{p}_{h}\right\|^{2} & \text { (here (C.1) and (C.2) are used) } \\
& \geq C_{1}\left\|\widetilde{p}_{h}\right\|^{2}-C \epsilon\left\|\widetilde{p}_{h}\right\|\left\|\bar{p}_{h}\right\|+\epsilon C_{2}\left\|\bar{p}_{h}\right\|^{2} & \text { (the first inequality in (C.2) is used). }
\end{array}
$$

By using Young's inequality, we can reduce the last inequality to the following one:

$$
b\left(p_{h}, \mathbf{v}_{h}\right) \geq C_{1}\left\|\widetilde{p}_{h}\right\|^{2}+\epsilon C_{2}\left\|\bar{p}_{h}\right\|^{2}-\left(\frac{C_{1}}{2}\left\|\widetilde{p}_{h}\right\|^{2}+\frac{C^{2} \epsilon^{2}}{2 C_{1}}\left\|\bar{p}_{h}\right\|^{2}\right)
$$

Then, choosing $\epsilon=\frac{C_{1} C_{2}}{C^{2}}$, we derive that

$$
\begin{equation*}
b\left(p_{h}, \mathbf{v}_{h}\right) \geq \frac{C_{1}}{2}\left\|\widetilde{p}_{h}\right\|^{2}+\frac{C_{1} C_{2}^{2}}{2 C^{2}}\left\|\bar{p}_{h}\right\|^{2} \geq C_{3}\left\|p_{h}\right\|^{2} \quad \text { with } C_{3}:=\min \left\{\frac{C_{1}}{2}, \frac{C_{1} C_{2}^{2}}{2 C^{2}}\right\} \tag{C.3}
\end{equation*}
$$

Since $\mathbf{v}_{h}=\widetilde{\mathbf{v}}_{h}+\epsilon \mathbf{v}_{h}^{e}$ with $\widetilde{\mathbf{v}}_{h}=0$ on $\Sigma$, it follows from the triangle inequality and C.1)-(C.2) that

$$
\begin{align*}
\left\|\mathbf{v}_{h}\right\|_{H^{1}}+\left\|\mathbf{v}_{h}\right\|_{H^{1}(\Sigma)} & \leq\left\|\widetilde{\mathbf{v}}_{h}\right\|_{H^{1}}+\epsilon\left(\left\|\mathbf{v}_{h}^{e}\right\|_{H^{1}}+\left\|\mathbf{v}_{h}^{e}\right\|_{H^{1}(\Sigma)}\right)  \tag{C.4}\\
& \leq\left\|\widetilde{p}_{h}\right\|+\frac{C_{1} C_{2}}{C^{2}}\left\|\bar{p}_{h}\right\| \leq\left(1+\frac{C_{1} C_{2}}{C^{2}}\right)\left\|p_{h}\right\| . \tag{C.5}
\end{align*}
$$

Therefore, (C.3) and (C.4) imply that

$$
\frac{b\left(p_{h}, \mathbf{v}_{h}\right)}{\left\|\mathbf{v}_{h}\right\|_{H^{1}}+\left\|\mathbf{v}_{h}\right\|_{H^{1}(\Sigma)}} \geq \frac{C_{3}\left\|p_{h}\right\|^{2}}{\left(1+\frac{C_{1} C_{2}}{C^{2}}\right)\left\|p_{h}\right\|}=\frac{C_{3}\left\|p_{h}\right\|}{\left(1+\frac{C_{1} C_{2}}{C^{2}}\right)} .
$$

This proves that

$$
\left\|p_{h}\right\| \leq \frac{1}{C_{3}}\left(1+\frac{C_{1} C_{2}}{C^{2}}\right) \frac{b\left(p_{h}, \mathbf{v}_{h}\right)}{\left\|\mathbf{v}_{h}\right\|_{H^{1}}+\left\|\mathbf{v}_{h}\right\|_{H^{1}(\Sigma)}}
$$

and therefore completes the proof of 2.16.
