## The L-system representation and c-entropy

ABSTRACT. Given a symmetric operator  $\dot{A}$  with deficiency indices (1, 1) and its self-adjoint extension  $A$  in a Hilbert space  $H$ , we construct a (unique) L-system with the main operator in  $H$  such that its impedance mapping coincides with the Weyl-Titchmarsh function  $M_{(\dot{A},A)}(z)$  or its linear-fractional transformation  $M_{(\dot{A},A_{\alpha})}(z)$ . Similar L-system constructions are provided for the Weyl-Titchmarsh function  $aM_{(\dot{A},A)}(z)$  with  $a>0$ . We also evaluate c-entropy and the main operator dissipation coefficient for the obtained L-systems.

## 1. Introduction

Recall the concept of an L-system.

Let  $T$  be a non-symmetric, densely defined linear operator in a Hilbert space H such that its resolvent set  $\rho(T)$  is not empty. We also assume that  $Dom(T) \cap$ Dom(T<sup>\*</sup>) is dense and that the restriction  $T|_{\text{Dom}(T) \cap \text{Dom}(T^*)}$  is a closed symmetric operator A with deficiency indices (1, 1). Let  $\mathcal{H}_+ \subset \mathcal{H} \subset \mathcal{H}_-$  be the rigged Hilbert space associated with  $\dot{A}$  (see the next section for details).

By an *L*-*system* we mean the array

(1) 
$$
\Theta = \begin{pmatrix} A & K & 1 \\ \mathcal{H}_+ \subset \mathcal{H} \subset \mathcal{H}_- & \mathbb{C} \end{pmatrix},
$$

where the *state-space operator* A is a bounded linear operator from  $\mathcal{H}_+$  into  $\mathcal{H}_$ such that  $A \subset T \subset A$ ,  $A \subset T^* \subset A^*$ , K is a bounded linear operator from  $\mathbb C$  into  $\mathcal{H}_-$  such that Im  $\mathbb{A} = K K^*$ .

The operator-valued function

$$
W_{\Theta}(z) = I - 2iK^*(\mathbb{A} - zI)^{-1}K, \quad z \in \rho(T),
$$

is called the *transfer function* of the L-system  $\Theta$  and

$$
V_{\Theta}(z) = i[W_{\Theta}(z) + I]^{-1}[W_{\Theta}(z) - I] = K^*(\text{Re}\,\mathbb{A} - zI)^{-1}K, \quad z \in \rho(T) \cap \mathbb{C}_{\pm},
$$

is called the *impedance function* of  $\Theta$  (see Section [2](#page-2-0) for more details).

The main goal of this note can be described as follows. Given a symmetric operator  $\tilde{A}$  with deficiency indices  $(1, 1)$  and its arbitrary (but fixed) self-adjoint extension A in a Hilbert space  $\mathcal{H}$ , let  $M_{(\dot{A},A)}(z)$  denote the Weyl-Titchmarsh function associated with the pair  $(A, A)$ . We construct a unique L-system  $\Theta$  of the form (1), with  $\mathcal{H}_+ \subset \mathcal{H} \subset \mathcal{H}_-$  generated by  $\dot{A}$ , such that the impedance function  $V_{\Theta}(z)$ coincides with  $M_{(\dot{A},A)}(z)$ . Such an L-system we call the "L-system representation" of the function  $M_{(\dot{A},A)}(z)$ . A similar construction is available for representing the function  $M_{(\dot{A},A_{\alpha})}(z)$  associates with the pair  $(\dot{A},A_{\alpha})$  where  $A_{\alpha}$  is an arbitrary selfadjoint extensions of the symmetric operator  $\dot{A}$ . We also obtain several results that provide us with an explicit construction of an L-system such that its impedance mapping coincides with  $aM_{(\dot{A},A)}(z)$  for an arbitrary value of the parameter  $a > 0$ . For such L-systems we establish an explicit connection between the c-entropy and the coefficient of dissipation of the main operator of the system. In particular, we show that the differential of L-system c-entropy, considered as a one-form on the Riemann surface  $\mathfrak{R} = \mathbb{C} \cup {\infty}$  of the parameter a, is an Abelian differential of the third kind with simple poles at  $a = \pm 1$ .

Notice that the main difference in the suggested approach as compared to the standard techniques used in the realization theory for Herglotz-Nevanlinna functions is that the underlying triple  $\mathcal{H}_+ \subset \mathcal{H} \subset \mathcal{H}_-$  in (1) is generated by the symmetric operator  $\dot{A}$  in question. In order to make this distinction clearer, we use the term "L-system representation" instead of the customary "L-system realization" when referring to the corresponding L-systems.

The paper is organized as follows.

Section [2](#page-2-0) contains necessary information on the L-systems theory.

In Section [3](#page-4-0) we give the formal definition and describe basic properties of the Weyl-Titchmarsh functions  $M_{(\dot{A},A)}(z)$  and  $M_{(\dot{A},A_{\alpha})}(z)$ .

Section [4](#page-6-0) provides us with an explicit construction of an L-system associated with a given densely defined closed symmetric operator  $A$  with deficiency indices  $(1, 1)$  and fixed (+)-normalized deficiency vectors  $q_{+}$  and  $q_{-}$ .

Section [5](#page-9-0) contains the main results of the paper, see also Teorems [5](#page-9-0) and [6](#page-10-0). In particular, we present explicit constructions of L-systems  $\Theta_{10}$  and  $\Theta_{\alpha 0}$  (see [\(41\)](#page-9-0) and [\(50](#page-11-0))) whose impedance functions match  $M_{(\dot{A},A)}(z)$  and  $M_{(\dot{A},A_{\alpha})}(z)$ , respectively. Moreover, we show that the L-systems  $\Theta_{10}$  and  $\Theta_{\alpha 0}$  have the same main <span id="page-2-0"></span>dissipative operator whose von Neumann's parameter with respect to the given deficiencyvectors  $g_+$  and  $g_-\$  (see ([11\)](#page-4-0)) is zero. The obtained results are generalized to a more general setting where the Weyl-Titchmarsh functions are replaced by the "re-normalized" functions  $aM_{(\dot{A},A)}(z)$  and  $aM_{(\dot{A},A_{\alpha})}(z)$ , with  $a>0$ , from the generalized Donoghue classes discussed in Section [3](#page-4-0).

In Section [6](#page-14-0) we recall the concept of c-entropy of an L-system introduced in [[4](#page-24-0)]) and relate the entropy to the dissipation coefficient of the main operator of the systems discussed in Section [5,](#page-9-0) see Theorems [13–](#page-15-0)[15.](#page-17-0) In particular, we show that the c-entropy of the systems associated with the Donoghue functions  $aM_{(\dot{A},A)}(z)$ and  $aM_{(\dot{A},A_{\alpha})}(z)$  is infinite if and only if  $a=1$ .

We conclude the paper with providing examples that illustrate main results.

#### 2. Preliminaries

For a pair of Hilbert spaces  $\mathcal{H}_1$  and  $\mathcal{H}_2$ , denote by  $[\mathcal{H}_1, \mathcal{H}_2]$  the set of all bounded linear operators from  $\mathcal{H}_1$  to  $\mathcal{H}_2$ . Let A be a closed, densely defined, symmetric operator in a Hilbert space H with inner product  $(f, g)$ ,  $f, g \in \mathcal{H}$ . Throughout this paper, by a *quasi-self-adjoint extension* of  $\vec{A}$  we mean any non-symmetric operator  $T$  in  $H$  such that

$$
\dot{A}\subset T\subset \dot{A}^*.
$$

Consider the rigged Hilbert space  $\mathcal{H}_+ \subset \mathcal{H} \subset \mathcal{H}_-$  (see [[2](#page-24-0), [7](#page-24-0), [8](#page-24-0)]), where

$$
\mathcal{H}_+ = \mathrm{Dom}(\dot{A}^*)
$$

and

(2) 
$$
(f,g)_+ = (f,g) + (\dot{A}^*f, \dot{A}^*g), \ \ f,g \in \text{Dom}(A^*).
$$

Let R be the Riesz-Berezansky operator R (see [[2](#page-24-0), Section 2.1], [[7](#page-24-0)], [[8](#page-24-0)]) which maps  $\mathcal{H}_-$  onto  $\mathcal{H}_+$  such that

$$
(f,g) = (f, \mathcal{R}g)_+ \quad \forall f \in \mathcal{H}_+, g \in \mathcal{H}_-
$$

with  $\|\mathcal{R}g\|_{+} = \|g\|_{-}$ , so that

(3) 
$$
(f,g) = (f, \mathcal{R}g) = (\mathcal{R}f, g) = (\mathcal{R}f, \mathcal{R}g) +, \qquad (f, g \in \mathcal{H}_-),
$$

$$
(u, v)_+ = (u, \mathcal{R}^{-1}v) = (\mathcal{R}^{-1}u, v) = (\mathcal{R}^{-1}u, \mathcal{R}^{-1}v) -, \qquad (u, v \in \mathcal{H}_+).
$$

Notice that upon identifying the space conjugate to  $\mathcal{H}_{\pm}$  with  $\mathcal{H}_{\mp}$ , we get that  $\mathbb{A} \in [\mathcal{H}_+, \mathcal{H}_-]$  implies  $\mathbb{A}^* \in [\mathcal{H}_+, \mathcal{H}_-]$ .

Recall that [[2](#page-24-0)] an operator  $A \in [\mathcal{H}_+, \mathcal{H}_-]$  is called a self-adjoint bi-extension of a symmetric operator  $\dot{A}$  if  $\dot{A} \subset \mathbb{A}$  and  $\mathbb{A}^* = \mathbb{A}$ .

Next, if A is a self-adjoint bi-extension of  $\dot{A}$ , the restriction  $\hat{A} = \mathbb{A} \upharpoonright \text{Dom}(\hat{A})$  of A on

$$
\text{Dom}(\hat{A}) = \{ f \in \mathcal{H}_+ : \mathbb{A}f \in \mathcal{H} \}
$$

is called a *quasi-kernel* of a self-adjoint bi-extension  $\mathbb{A}$  (see [[2](#page-24-0), Section 2.1], [[21](#page-25-0)]).

A self-adjoint bi-extension  $A$  of a symmetric operator  $\dot{A}$  is called *t-self-adjoint* (see [[2](#page-24-0), Definition 4.3.1]) if its quasi-kernel A is a self-adjoint operator in  $H$ . An operator  $A \in [\mathcal{H}_+, \mathcal{H}_-]$  is called a *quasi-self-adjoint bi-extension* of an operator T if  $\mathbb{A} \supset T \supset \dot{A}$  and  $\mathbb{A}^* \supset T^* \supset \dot{A}$ .

<span id="page-3-0"></span>Also recall that in accordance with the von Neumann Theorem (see [[2](#page-24-0), Theorem 1.3.1]), the domain of an arbitrary self-adjoint extension  $\hat{A}$  of  $\hat{A}$  can be represented as

(4) 
$$
\text{Dom}(\hat{A}) = \text{Dom}(\hat{A}) \oplus (I + U)\mathfrak{N}_i.
$$

Here the operator U, von Neumann's parameter, is both a  $(\cdot)$ -isometric as well as (+)-isometric operator from the deficiency subspace  $\mathfrak{N}_i$  of  $\dot{A}$  into the deficiency subspace  $\mathfrak{N}_{-i}$  where

$$
\mathfrak{N}_{\pm i} = \text{Ker} \, (\dot{A}^* \mp iI).
$$

Throughout this paper, we will be mostly interested in the following type of quasi-self-adjoint bi-extensions. Let T be a quasi-self-adjoint extension of  $\vec{A}$  with nonempty resolvent set  $\rho(T)$ . A quasi-self-adjoint bi-extension A of an operator T is called (see [[2](#page-24-0), Definition 3.3.5]) a (\*)-extension of T if Re  $\mathbb A$  is a t-self-adjoint bi-extension of  $\dot{A}$ .

In what follows we assume that  $A$  has deficiency indices  $(1, 1)$ . In this case it is known [[2](#page-24-0)] that every quasi-self-adjoint extension T of  $\ddot{A}$  admits (\*)-extensions, and the description of all  $(*)$ -extensions via the Riesz-Berezansky operator  $\mathcal R$  can be found in  $[2, Section 4.3]$  $[2, Section 4.3]$  $[2, Section 4.3]$ .

DEFINITION 1.  $[cf. [2, Definition 6.3.4]/An array$  $[cf. [2, Definition 6.3.4]/An array$  $[cf. [2, Definition 6.3.4]/An array$ 

(5) 
$$
\Theta = \begin{pmatrix} A & K & 1 \\ \mathcal{H}_+ \subset \mathcal{H} \subset \mathcal{H}_- & \mathbb{C} \end{pmatrix}
$$

is called an L-system if:

- (1) T is a dissipative  $(\text{Im}(Tf, f) > 0, f \in \text{Dom}(T))$  quasi-self-adjoint extension of a symmetric operator  $\dot{A}$  with deficiency indices  $(1, 1)$ ;
- (2) A is a  $(*)$ -extension of T;
- (3) Im  $\mathbb{A} = KK^*$ , where  $K \in [\mathbb{C}, \mathcal{H}_-]$  and  $K^* \in [\mathcal{H}_+, \mathbb{C}]$ .

The operators  $T$  and  $A$  are called the main and state-space operators respectively of the system  $\Theta$ , and K is the *channel operator*. It is easy to see that the operator A of the system (5) can be chosen in such a way that

$$
\mathop{\rm Im}\nolimits{\mathbb A}=(\cdot,\chi)\chi,\quad \chi\in{\mathcal H}_-
$$

and

$$
Kc = c \cdot \chi \quad c \in \mathbb{C}.
$$

Throughout this paper we will often rely on another important element of an Lsystem, the quasi-kernel A of the Re A, which is the self-adjoint extension A of A defined as

(6) 
$$
\hat{A} = \text{Re } \mathbb{A} \upharpoonright \text{Dom}(\hat{A}), \quad \text{Dom}(\hat{A}) = \{f \in \mathcal{H}_+ : \text{Re } \mathbb{A}f \in \mathcal{H}\}.
$$

The system  $\Theta$  in (5) is called *minimal* if the operator  $\dot{A}$  is a prime operator in  $H$ , i.e., there exists no non-trivial reducing invariant subspace of H on which it induces a self-adjoint operator. Notice that minimal L-systems of the form (5) with one-dimensional input-output space were also discussed in [[3](#page-24-0)].

With any L-system  $\Theta$ , we associate the **transfer** and **impedance function** given by the formulas

(7) 
$$
W_{\Theta}(z) = I - 2iK^*(\mathbb{A} - zI)^{-1}K, \quad z \in \rho(T),
$$

(8) 
$$
V_{\Theta}(z) = K^*(\text{Re}\,\mathbb{A} - zI)^{-1}K, \quad z \in \rho(T),
$$

respectively.

Recall that for Im  $z \neq 0, z \in \rho(T)$  we have

(9)  
\n
$$
V_{\Theta}(z) = i[W_{\Theta}(z) + I]^{-1}[W_{\Theta}(z) - I],
$$
\n
$$
W_{\Theta}(z) = (I + iV_{\Theta}(z))^{-1}(I - iV_{\Theta}(z)).
$$

Moreover, any impedance function  $V_{\Theta}(z)$  admits the integral representation

(10) 
$$
V_{\Theta}(z) = Q + \int_{\mathbb{R}} \left( \frac{1}{\lambda - z} - \frac{\lambda}{1 + \lambda^2} \right) d\sigma,
$$

where Q is a real number and  $\sigma$  is an infinite Borel measure such that

$$
\int_{\mathbb{R}} \frac{d\sigma(\lambda)}{1+\lambda^2} < \infty.
$$

We refer to  $\left[2, 3, 11\right]$  and references therein for the details and also for the the complete description of the class of all Herglotz-Nevanlinna functions that can be realized as impedance functions of an L-system.

# 3. Donoghue classes and L-systems

Suppose that  $\dot{A}$  is a closed prime densely defined symmetric operator with deficiency indices (1, 1) in a Hilbert space  $H$ . Assume also that  $T \neq T^*$  is a maximal dissipative extension of  $\dot{A}$ ,

$$
\operatorname{Im}(Tf, f) \ge 0, \quad f \in \operatorname{Dom}(T).
$$

Since  $\dot{A}$  is symmetric, its dissipative extension T is automatically quasi-self-adjoint  $[2]$  $[2]$  $[2]$ , that is,

$$
\dot{A}\subset T\subset\dot{A}^*,
$$

and hence, (see [[3](#page-24-0)])

(11) 
$$
g_+ - \kappa g_- \in \text{Dom}(T) \quad \text{for some } |\kappa| < 1,
$$

where  $g_{\pm} \in \mathfrak{N}_{\pm i} = \text{Ker}(\dot{A}^* \mp iI)$  and  $||g_{\pm}|| = 1$ . Throughout this paper  $\kappa$  will be referred to as the von Neumann parameter of the operator  $T$  with respect to the basis  ${g_{\pm}}$  in the subspace  $\mathfrak{N}_i$ + $\mathfrak{N}_{-i}$ .

Recall that in this setting the Weyl-Titchmarsh function  $M_{(\dot{A},A)}(z)$  associated with the pair  $(\dot{A}, A)$  is given by

(12) 
$$
M_{(\dot{A},A)}(z) = ((Az+I)(A-zI)^{-1}g_+,g_+), \quad z \in \mathbb{C}_+.
$$

Notice that the function  $M_{(\dot{A},A)}(z)$  is well-defined whenever the normalization condition  $||g_+|| = 1$  holds.

Along with the Weyl-Titchmarsh function  $M_{(\dot{A},A)}(z)$ , introduce the Livisc func*tion* (see [[15](#page-25-0)], [[18](#page-25-0)])

(13) 
$$
s(z) = s_{(\dot{A}, A)}(z) = \frac{z - i}{z + i} \cdot \frac{(g_z, g_-)}{(g_z, g_+)}, \quad z \in \mathbb{C}_+,
$$

provided that

$$
(14) \t\t\t g_{+} - g_{-} \in \text{Dom}(A).
$$

<span id="page-5-0"></span>Here

$$
g_z \in \text{Ker}(\dot{A}^* - zI), \quad z \in \mathbb{C}_+.
$$

Given a triple  $\mathfrak{A} = (\dot{A}, T, A)$ , we call  $\kappa$  the von Neumann parameter of the triple  $\mathfrak{A} = (\dot{A}, T, A)$  provided that the deficiency elements  $g_{\pm}$ ,  $||g_{\pm}|| = 1$  are chosen insuch a way that  $(14)$  $(14)$  and  $(11)$  hold.

In this case, the Weyl-Titchmarsh  $M(z) = M_{(\dot{A},A)}(z)$  and Livšic  $s(z) = s_{(\dot{A},A)}(z)$ functions (see  $[15, 18]$  $[15, 18]$  $[15, 18]$  $[15, 18]$  $[15, 18]$ ) are related as

(15) 
$$
s(z) = \frac{M(z) - i}{M(z) + i}, \quad z \in \mathbb{C}_+,
$$

or, equivalently,

(16) 
$$
M(z) = \frac{1}{i} \cdot \frac{s(z) + 1}{s(z) - 1}, \quad z \in \mathbb{C}_{+}.
$$

We stress that the Weyl-Titchmarsh  $M(z) = M_{(\dot{A},A)}(z)$  is rather sensitive to the choice of a self-adjoint reference extension  $A$  of the symmetric operator  $\dot{A}$ . For instance (see, e.g., [[18](#page-25-0), Appendix E, Lemma E.1]), if

(17) 
$$
g_{+} - e^{2i\alpha} g_{-} \in \text{Dom}(A_{\alpha}), \quad \alpha \in [0, \pi),
$$

then the corresponding transformation law for the Weyl-Titchmarsh functions reads as

(18) 
$$
M(\dot{A}, A_{\alpha}) = \frac{\cos \alpha M(\dot{A}, A) - \sin \alpha}{\cos \alpha + \sin \alpha M(\dot{A}, A)},
$$

while the transformation law for the corresponding Livšic function is simply reduced to the appearance of an additional "innocent" phase factor

$$
s(\dot{A}, A_{\alpha}) = e^{2i\alpha} s(\dot{A}, A).
$$

Let  $\mathfrak{N}$  (see [[6](#page-24-0)]) be the class of all Herglotz-Nevanlinna functions  $M(z)$  that admit the representation

(19) 
$$
M(z) = \int_{\mathbb{R}} \left( \frac{1}{\lambda - z} - \frac{\lambda}{1 + \lambda^2} \right) d\sigma,
$$

where  $\sigma$  is an infinite Borel measure with

$$
\int_{\mathbb{R}} \frac{d\sigma(\lambda)}{1 + \lambda^2} = a < \infty.
$$

Following our earlier developments in  $[3, 6, 16, 17]$  $[3, 6, 16, 17]$  $[3, 6, 16, 17]$  $[3, 6, 16, 17]$  $[3, 6, 16, 17]$  $[3, 6, 16, 17]$  $[3, 6, 16, 17]$  $[3, 6, 16, 17]$  $[3, 6, 16, 17]$ , we split  $\mathfrak{M}$  in to three subclasses

$$
\mathfrak{N} = \mathfrak{M}_{\kappa} \cup \mathfrak{M}_0 \cup \mathfrak{M}_{\kappa}^{-1}
$$

in accordance with whether the norming constant  $a$  has the property that  $a < 1$ ,  $a = 1$  or  $a > 1$ , with

(20) 
$$
\kappa = \begin{cases} \frac{1-a}{1+a}, & a < 1 \\ 0, & a = 1 \\ \frac{a-1}{1+a}, & a > 1 \end{cases}
$$

In particular,  $\mathfrak{M}_0 = \mathfrak{M}_0^{-1} = \mathfrak{M}$  is the **Donoghue class** of all analytic mappings  $M(z)$  from  $\mathbb{C}_+$  into itself that admits the representation (19) and has a property

$$
\int_{\mathbb{R}} \frac{d\sigma(\lambda)}{1+\lambda^2} = 1, \quad \text{equivalently,} \quad M(i) = i.
$$

<span id="page-6-0"></span>It is well known [[9](#page-24-0), [10](#page-24-0), [11](#page-24-0), [15](#page-25-0)] that  $M(z) \in \mathfrak{M}$  if and only if  $M(z)$  can be realized as the Weyl-Titchmarsh function  $M_{(\dot{A},A)}(z)$  associated with the pair  $(A, A)$ . Following [[3,](#page-24-0) [5](#page-24-0)] we refer to the classes  $\mathfrak{M}_{\kappa}$  and  $\mathfrak{M}_{\kappa}^{-1}$  as the **generalized** Donoghue classes.

We say that an L-system  $\Theta$  of the form [\(5](#page-3-0)) is associated with the triple  $(A, T, A)$ if A and T are the symmetric and main operators of  $\Theta$ , respectively, and  $A = \hat{A}$ , where  $\hat{A}$  is the quasi-kernel of Re  $\mathbb{A}$ .

PROPOSITION 2 ([[3,](#page-24-0) [5](#page-24-0)]). Suppose that  $T \neq T^*$  is a maximal dissipative extension of a symmetric operator  $\dot{A}$  with deficiency indices  $(1,1)$  in a Hilbert space  $\mathcal{H}$ . Given k,  $k \in [0,1)$ , assume that the deficiency elements  $g_{\pm} \in \text{Ker}(\dot{A}^* \mp iI)$  are normalized,  $||g_{\pm}|| = 1$ , and chosen in such a way that

(21) 
$$
g_+ - \kappa g_- \in \text{Dom}(T).
$$

Suppose that  $A$  is a self-adjoint extension of  $\dot{A}$ . Assume, in addition, that the Weyl-Titchmarsh function associated with the pair  $(A, A)$  is not an identical constant in  $\mathbb{C}_{+}.$ 

Denote by  $\Theta$  the minimal L-system of the form [\(5](#page-3-0)) associated with the triple  $(A, T, A)$ . Then:

If

$$
(22) \t\t\t g_{+} - g_{-} \in \text{Dom}(A),
$$

then the impedance function  $V_{\Theta}$  of the system belongs to the class  $\mathfrak{M}_{\kappa}$ . If, instead,

(23) 
$$
g_+ + g_- \in \text{Dom}(A),
$$

then  $V_{\Theta}$  belongs to the class  $\mathfrak{M}_{\kappa}^{-1}$ .

The proof of Proposition 2 can be obtained by combining [[3](#page-24-0), Theorem 12] and [[5](#page-24-0), Theorem 5.4].

For the further reference, recall that if the symmetric operator  $\dot{A}$  is prime, then both the Weyl-Titchmarsh function  $M_{(\dot{A},A)}(z)$  and the Livšic function  $s_{(\dot{A},A)}(z)$ are complete unitary invariants of the pair  $(A, A)$  (see [[15,](#page-25-0) [18](#page-25-0)]). In particular, the pairs  $(\dot{A}, A)$  and  $(\dot{B}, B)$  are mutually unitary equivalent if and only if  $M_{(\dot{A}, A)}(z) =$  $M_{(\dot{B},B)}(z)$ , equivalently,  $s_{(\dot{A},A)}(z) = s_{(\dot{B},B)}(z)$ .

## 4. Inclusion of a dissipative operator into an L-system

In this section, following  $[6, 19]$  $[6, 19]$  $[6, 19]$  $[6, 19]$  $[6, 19]$ , we provide an explicit construction of an L-system based upon the following operator theoretic setting.

Assume that  $\dot{A}$  is a densely defined closed symmetric operator with finite deficiency indices (1, 1). Given

$$
(\kappa,U)\in [0,1)\times\mathbb{T},\quad\text{with}\quad \mathbb{T}=\{z\in\mathbb{C}\,\mid\,|z|=1\},
$$

and (+)-normalized deficiency elements  $g_{\pm} \in \mathfrak{N}_{\pm i} = \text{Ker}(\dot{A}^* \mp iI), ||g_{\pm}||_{+} = 1,$ assume that  $T$  is a quasi-selfadjoint extension of  $\dot{A}$  such that

$$
g_+ - \kappa g_- \in \text{Dom}(T).
$$

Also assume that  $A$  is a reference self-adjoint extension of  $\overline{A}$  with

$$
g_+ + Ug_- \in \text{Dom}(A).
$$

Introduce the L-system (see  $[6,$  $[6,$  $[6,$  Appendix A])

<span id="page-7-0"></span>(24) 
$$
\Theta = \begin{pmatrix} A & K & 1 \\ \mathcal{H}_+ \subset \mathcal{H} \subset \mathcal{H}_- & \mathbb{C} \end{pmatrix},
$$

where  $\mathbb A$  is a unique (\*)-extension  $\mathbb A$  of T (see [[2](#page-24-0), Theorem 4.4.6]) and

 $K c = c \cdot \chi, \quad (c \in \mathbb{C}).$ 

In this case, the state-space operator A given by

(25) 
$$
\mathbb{A} = \dot{A}^* + \frac{\sqrt{2}i(\kappa + \bar{U})}{|1 + \kappa U|\sqrt{1 - \kappa^2}} \left(\cdot, \kappa \varphi + \psi\right) \chi,
$$

with

(26) 
$$
\chi = \frac{\kappa^2 + 1 + 2\kappa U}{\sqrt{2}|1 + \kappa U|\sqrt{1 - \kappa^2}}\varphi + \frac{\kappa^2 U + 2\kappa + U}{\sqrt{2}|1 + \kappa U|\sqrt{1 - \kappa^2}}\psi.
$$

Here

(27) 
$$
\varphi = \mathcal{R}^{-1}(g_+), \quad \psi = \mathcal{R}^{-1}(g_-),
$$

with  $R$  the Riesz-Berezansky operator.

REMARK 3. Notice that since by the hypothesis  $||g_{\pm}||_{+} = 1$ , we have

$$
\|\varphi\|_{-}=\|\psi\|_{-}=1.
$$

Indeed, by  $(3)$  $(3)$ ,

$$
\|\varphi\|_{-}^{2} = \|\mathcal{R}\varphi\|_{+}^{2} = \|g_{+}\|_{+}^{2} = 1.
$$

Analogously,

$$
\|\psi\|_{-}^2=1.
$$

Moreover, since obviously

$$
||g_{\pm}||_{+}^{2} = 2||g_{\pm}||^{2},
$$

we also see that the deficiency elements  $g'_{\pm} \in \mathfrak{N}_{\pm i}$  given by

(28) 
$$
g'_{+} = \sqrt{2}\mathcal{R} = \sqrt{2}g_{+}, \qquad g'_{-} = \sqrt{2}\mathcal{R}\psi = \sqrt{2}g_{-}
$$

are  $(\cdot)$ -normalized.

Given all that, it is also worth mentioning that for the reminder of this paper all the results will be formulated in terms of the  $(+)$ -normalized deficiency elements  $g_{\pm}$ .

Observe that the constructed L-system  $\Theta$  of the form (24) is in one-to-one correspondence with a parametric pair  $(\kappa, U) \in [0, 1) \times \mathbb{T}$ .

Also recall that (see  $[6]$  $[6]$  $[6]$ )

(29) 
$$
\operatorname{Im} A = (\cdot, \chi)\chi,
$$

and

(30) 
$$
\operatorname{Re} \mathbb{A} = \dot{A}^* - \frac{i\sqrt{1-\kappa^2}}{\sqrt{2}|1+\kappa U|} (\cdot, \varphi - U\psi)\chi,
$$

where  $\chi$  is given by (26).

If the reference self-adjoint extension A satisfies [\(22](#page-6-0))  $(U = -1)$ , then for the corresponding L-system

(31) 
$$
\Theta_1 = \begin{pmatrix} A_1 & K_1 & 1 \\ \mathcal{H}_+ \subset \mathcal{H} \subset \mathcal{H}_- & \mathbb{C} \end{pmatrix}
$$

<span id="page-8-0"></span>we have

(32) 
$$
\mathbb{A}_1 = \dot{A}^* - \frac{\sqrt{2}i}{\sqrt{1 - \kappa^2}} \left( \cdot, \kappa \varphi + \psi \right) \chi_1,
$$

where

(33) 
$$
\chi_1 = \sqrt{\frac{1-\kappa}{2+2\kappa}} \left( \varphi - \psi \right) = \sqrt{\frac{1-\kappa}{1+\kappa}} \left( \frac{1}{\sqrt{2}} \varphi - \frac{1}{\sqrt{2}} \psi \right).
$$

Also,([29\)](#page-7-0) gives us

(34) 
$$
\operatorname{Im} \mathbb{A}_1 = \left(\frac{1}{2}\right) \frac{1-\kappa}{1+\kappa} (\cdot, \varphi - \psi)(\varphi - \psi) = (\cdot, \chi_1)\chi_1,
$$

and, according to([30\)](#page-7-0),

(35) 
$$
\operatorname{Re} \mathbb{A}_1 = \dot{A}^* - \frac{i}{2} (\cdot, \varphi + \psi)(\varphi - \psi).
$$

If condition [\(23](#page-6-0)) holds, i.e.,  $U = 1$ , the entries of the corresponding L-system

(36) 
$$
\Theta_2 = \begin{pmatrix} A_2 & K_2 & 1 \\ \mathcal{H}_+ \subset \mathcal{H} \subset \mathcal{H}_- & \mathbb{C} \end{pmatrix}
$$

are given by

(37) 
$$
\mathbb{A}_2 = \dot{A}^* + \frac{\sqrt{2}i}{\sqrt{1 - \kappa^2}} \Big( \cdot, \kappa \varphi + \psi \Big) \chi_2,
$$

where

(38) 
$$
\chi_2 = \sqrt{\frac{1+\kappa}{2-2\kappa}} \left( \varphi + \psi \right) = \sqrt{\frac{1+\kappa}{1-\kappa}} \left( \frac{1}{\sqrt{2}} \varphi + \frac{1}{\sqrt{2}} \psi \right).
$$

Also,([29\)](#page-7-0) yields

(39) 
$$
\operatorname{Im} \mathbb{A}_2 = \left(\frac{1}{2}\right) \frac{1+\kappa}{1-\kappa} \left((\cdot, \varphi + \psi)(\varphi + \psi)\right) = (\cdot, \chi_2)\chi_2,
$$

and, according to([30\)](#page-7-0),

(40) 
$$
\operatorname{Re} \mathbb{A}_2 = \dot{A}^* - \frac{i}{2} (\cdot, \varphi - \psi)(\varphi + \psi).
$$

Note that two L-systems  $\Theta_1$  and  $\Theta_2$  in [\(31](#page-7-0)) and (36) are constructed in a way thatthe quasi-kernels  $\hat{A}_1$  of Re  $\mathbb{A}_1$  and  $\hat{A}_2$  of Re  $\mathbb{A}_2$  satisfy the conditions ([22\)](#page-6-0) or ([23\)](#page-6-0), respectively, as it follows from (35) and (40).

Concludingthis section we would like to emphasize that formulas  $(24)$  $(24)$ – $(26)$ allow us to construct an L-system  $\Theta$  that is complectly based on a given triple  $(\dot{A}, T, A)$  and a fixed (+)-normalized deficiency vectors  $g_{\pm}$ . Moreover, in this construction the operators  $\dot{A}$  and  $T$  become the symmetric and main operators of  $\Theta$ , respectively, while the self-adjoint reference extension A of the triple matches  $\hat{A}$ , the quasi-kernel of Re A.

5. Representations of  $M_{(\dot{A},A)}(z)$  and  $M_{(\dot{A},A_\alpha)}(z)$ .

<span id="page-9-0"></span>Throughout this section we assume the following Hypothesis.

HYPOTHESIS 4. Assume that  $\dot{A}$  is a densely defined closed symmetric operator with deficiency indices (1,1) and  $\mathcal{H}_+ \subset \mathcal{H} \subset \mathcal{H}_-$  a rigged Hilbert space generated by  $\dot{A}$ . Suppose that deficiency vectors  $g_+$  and  $g_-$  are  $(+)$ -normalized. Also assume that and set  $\varphi = \mathcal{R}^{-1}(g_+)$  and  $\psi = \mathcal{R}^{-1}(g_-)$ , where  $\mathcal R$  is the Riesz-Berezansky operator.

THEOREM 5. Assume Hypothesis 4. Suppose, in addition, that A is the selfadjoint extensions of A such that

 $g_+ - g_- \in \text{Dom}(A)$ .

Then the Weyl-Titchmarsh functions function  $M_{(\dot{A},A)}(z)$  associated with the pair  $(A, A)$  coincides with the impedance function of a unique L-system of the form

(41) 
$$
\Theta_{10} = \begin{pmatrix} A_{10} & K_{10} & 1 \ \mathcal{H}_+ \subset \mathcal{H} \subset \mathcal{H}_- & \mathbb{C} \end{pmatrix},
$$

where

(42) 
$$
\mathbb{A}_{10} = \dot{A}^* - i(\cdot, \psi)(\varphi - \psi)
$$

and

$$
K_{10}c = c \cdot \chi_{10}, \quad (c \in \mathbb{C})
$$

with

(43) 
$$
\chi_{10} = \frac{1}{\sqrt{2}} (\varphi - \psi).
$$

In this case, the von Neumann parameter  $k$  of the main operator  $T_{10}$  of the system and the von Neumann parameter U of the quasi-kernel  $\hat{A}_{10} = A$  are given by

(44) 
$$
\kappa = 0 \quad and \quad U = -1.
$$

Moreover, if  $\Theta$  is an L-system [\(5](#page-3-0)) with the symmetric operator A such that

$$
V_{\Theta}(z) = M_{(\dot{A},A)}(z), \quad z \in \mathbb{C}_{\pm},
$$

where  $A = \hat{A}$  is the quasi-kernel of Re A, then the von Neumann parameters  $\kappa$  and U of the operators T and  $\hat{A}$  of  $\Theta$  are given by (44).

PROOF. We begin by recalling the definition of the model triple [[15,](#page-25-0) [18](#page-25-0)]. Given a function  $M(z)$  from the Donoghue class  $\mathfrak{M}$  and a  $\kappa \in \mathbb{C}$ ,  $|\kappa| < 1$ , in the Hilbert space $L^2(\mathbb{R}; d\sigma)$ , where is the representing measure for the function  $M(z)$  via ([19\)](#page-5-0), introduce the (self-adjoint) operator  $\beta$  of multiplication by independent variable on

(45) 
$$
\text{Dom}(\mathcal{B}) = \left\{ f \in L^2(\mathbb{R}; d\sigma) \middle| \int_{\mathbb{R}} \lambda^2 |f(\lambda)|^2 d\sigma(\lambda) < \infty \right\}
$$

and denote by  $\dot{\mathcal{B}}$  its symmetric restriction on

(46) 
$$
\text{Dom}(\mathcal{B}) = \left\{ f \in \text{Dom}(\mathcal{B}) \middle| \int_{\mathbb{R}} f(\lambda) d\sigma(\lambda) = 0 \right\}.
$$

<span id="page-10-0"></span>Next, introduce  $T^{\kappa}_{\mathcal{B}}$  $\mathcal{B}_{\mathcal{B}}^{\kappa}$  as the dissipative quasi-self-adjoint extension of the symmetric operator  $\hat{\mathcal{B}}$  on

(47) 
$$
\text{Dom}(T_{\mathcal{B}}^{\kappa}) = \text{Dom}(\mathcal{B}) + \text{lin span}\left\{\frac{1}{\lambda - i} - \kappa \frac{1}{\lambda + i}\right\},\,
$$

Notice that in this case,

(48) 
$$
\text{Dom}(\mathcal{B}) = \text{Dom}(\mathcal{B}) + \text{lin span}\left\{\frac{1}{\lambda - i} - \frac{1}{\lambda + i}\right\}.
$$

We refer to the triple  $(\dot{\mathcal{B}}, T_{\mathcal{B}}^{\kappa}, \mathcal{B})$  as the model triple (see [[15](#page-25-0), [18](#page-25-0)]) in the Hilbert space  $L^2(\mathbb{R}; d\sigma)$ . It was shown in [[15](#page-25-0), Theorems 1.4, 4.1] that if  $\kappa$  is the von Neumann parameter of the dissipative operator  $T_A$  with respect to a basis  $\{g_{\pm}\},$  $||g_+|| = ||g_-||$ , in the deficiency subspaces, that is,

$$
g_+ - \kappa g_- \in \text{Dom}(T),
$$

and

$$
g_+ - g_- \in \text{Dom}(A),
$$

then the triple  $(A, T_A, A)$  is mutually unitarily equivalent to the model triple  $(\mathcal{B}, T_{\mathcal{B}}^{\kappa}, \mathcal{B})$  in the Hilbert space  $L^2(\mathbb{R}; d\mu)$ , where  $\mu(d\lambda)$  is the representing measure for the Weyl-Titchmarsh function  $M_{(\dot{A},A)}(z)$ .

In  $\left[3, \text{ Theorem 7}\right]$  $\left[3, \text{ Theorem 7}\right]$  $\left[3, \text{ Theorem 7}\right]$  we have shown how to construct a model L-system that realizes the function  $M_{(\dot{A},A)}(z)$  with the parameters  $\kappa = 0$  and  $U = -1$ . The model L-system constructed is uniquely based on the model triple  $(\mathcal{B}, T_{\mathcal{B}}^{\kappa}, \mathcal{B})$  of the form $(45)-(47)$  $(45)-(47)$  $(45)-(47)$  with  $\kappa = 0$ . This model triple is unitarily equivalent to the triple  $(A, T_A, A)$  $(A, T_A, A)$  $(A, T_A, A)$  that is included in the L-system  $\Theta_1$  in ([31\)](#page-7-0) if we set  $\kappa = 0$ . Thus, in order to prove the first part of the theorem, all we have to do is set  $\kappa = 0$  for the L-system  $\Theta_1$  in [\(31](#page-7-0)) and then refer to [[15](#page-25-0), Theorems 1.4, 4.1] to conclude that  $M_{(\dot{A},A)}(z)$  coincides with the impedance function of an L-system with the same set of parameters  $\kappa$  and U. We obtain (see [\(34](#page-8-0)) – [\(35\)](#page-8-0)) that

(49) Im 
$$
\mathbb{A}_{10} = (\cdot, \chi_{10})\chi_{10}
$$
, Re  $\mathbb{A}_{10} = \dot{A}^* - \frac{i}{2}(\cdot, \varphi + \psi)(\varphi - \psi)$ ,

and  $\chi_{10}$  is defined by [\(43](#page-9-0)). Then [\(42](#page-9-0)) immediately follows from (49).

Now let us assume that  $\Theta$  is an L-system with the symmetric operator A described in the statement of the theorem such that  $V_{\Theta}(z) = M_{(\dot{A},A)}(z)$ . Then, according to [[15](#page-25-0), Theorems 1.4, 4.1], the underlying triple  $(A, T, \hat{A})$  of  $\Theta$  is unitarily equivalentto the model triple  $(\mathcal{B}, T_{\mathcal{B}}^{\kappa}, \mathcal{B})$  of the form  $(45)-(47)$  $(45)-(47)$  $(45)-(47)$  with  $\kappa = 0$  that is used in the construction of the model L-system realizing  $M_{(\dot{A},A)}(z)$ . Consequently, by unitary invariance, both triples  $(\dot{\mathcal{B}}, T_{\mathcal{B}}^{\kappa}, \mathcal{B})$  and  $(\dot{A}, T, \hat{A})$  have the same set of  $V$  and  $V$  is constrained by the extensive of  $(x, -\beta, \alpha)$  and  $(x, -\beta, \alpha)$  and  $\alpha$  and  $U = -1$ .

More generally, we have the following representations theorem.

THEOREM 6. Assume Hypothesis [4](#page-9-0). Suppose, in addition, that A is the selfadjoint extensions of A such that

$$
g_{+} - e^{2i\alpha} g_{-} \in \text{Dom}(A_{\alpha}).
$$

<span id="page-11-0"></span>Then the Weyl-Titchmarsh function of the pair  $(\dot{A}, A_{\alpha})$ , coincides with the impedance function of a unique L-system of the form

(50) 
$$
\Theta_{\alpha 0} = \begin{pmatrix} A_{\alpha 0} & K_{\alpha 0} & 1 \\ H_+ \subset H \subset H_- & \mathbb{C} \end{pmatrix},
$$

where

(51) 
$$
\mathbb{A}_{\alpha 0} = \dot{A}^* - i(\cdot, \psi)(e^{-2i\alpha}\varphi - \psi)
$$

and

$$
K_{\alpha 0}c = c \cdot \chi_{\alpha 0}, \quad (c \in \mathbb{C})
$$

with

(52) 
$$
\chi_{\alpha 0} = \frac{1}{\sqrt{2}} (\varphi - e^{2i\alpha} \psi).
$$

In this case, the von Neumann parameter k of the main operator  $T_{\alpha 0}$  of the system and the von Neumann parameter U of the quasi-kernel  $\hat{A}_{\alpha 0} = A$  are given by

(53) 
$$
\kappa = 0 \quad and \quad U = -e^{2i\alpha}.
$$

Moreover, if  $\Theta$  is an L-system [\(5](#page-3-0)) with the symmetric operator  $\dot{A}$  such that

$$
V_{\Theta}(z) = M_{(\dot{A},A)}(z), \quad z \in \mathbb{C}_+,
$$

where  $A = \hat{A}$  is the quasi-kernel of Re A, then the von Neumann parameters  $\kappa$  and U of the operators T and  $\hat{A}$  of  $\Theta$  are given by (53).

PROOF. Consider  $g' = (e^{2i\alpha})g_{-}$ . Clearly,  $g'_{-}$  is another (+)-normalized deficiency vector in Ker  $(\dot{A}^* + iI)$  and is such that  $g_+ - g'_- \in \text{Dom}(A_\alpha)$ . Consequently, all the conditions of Theorem [5](#page-9-0) apply to the pair of normalized deficiency vectors  $g_+$  and  $g'_-$  and the Weyl-Titchmarsh function  $M_{(\dot{A},A_\alpha)}(z)$  of the pair  $(\dot{A},A_\alpha)$ . Thus we can construct a realizing  $M_{(\dot{A},A_{\alpha})}(z)$  L-system  $\Theta_{\alpha 0}$  out of L-system  $\Theta_{10}$  in [\(41\)](#page-9-0) simply by replacing  $\psi$  in formulas [\(42](#page-9-0))-[\(43](#page-9-0)) with  $\psi' = \mathcal{R}^{-1}(g'_{-})$ .

Alternatively, we can apply the formulas  $(26)$ – $(24)$  $(24)$  with a new set of parameters. Inparticular, if  $U = -e^{2i\alpha}$  and  $\kappa = 0$  the formulas ([26\)](#page-7-0)–[\(24](#page-7-0)) become

$$
\chi_{0\alpha} = \frac{1}{\sqrt{2}} (\varphi - e^{2i\alpha} \psi),
$$

and

Im 
$$
\mathbb{A}_{0\alpha} = (\cdot, \chi_{0\alpha})\chi_{0\alpha}
$$
, Re  $\mathbb{A}_{0\alpha} = \dot{A}^* - \frac{i}{\sqrt{2}}(\cdot, \varphi + e^{2i\alpha}\psi)\chi_{0\alpha}$ ,

yielding (see also([25\)](#page-7-0))

$$
\begin{split} \mathbb{A}_{0\alpha} &= \text{Re}\,\mathbb{A}_{0\alpha} + i \,\text{Im}\,\mathbb{A}_{0\alpha} = \dot{A}^* - \frac{i}{\sqrt{2}} \left[ (\cdot, \varphi + e^{2i\alpha}\psi) - (\cdot, \varphi - e^{2i\alpha}\psi) \right] \chi_{0\alpha} \\ &= \dot{A}^* - \frac{i}{\sqrt{2}} (\cdot, 2e^{2i\alpha}\psi) \chi_{0\alpha} = \dot{A}^* - \sqrt{2} \, ie^{-2i\alpha} (\cdot, \psi) \chi_{0\alpha} \\ &= \dot{A}^* - \sqrt{2} \, ie^{-2i\alpha} (\cdot, \psi) \frac{1}{\sqrt{2}} (\varphi - e^{2i\alpha}\psi) = \dot{A}^* - i (\cdot, \psi) (e^{-2i\alpha}\varphi - \psi). \end{split}
$$

The above formulas confirm (51) and (52). The corresponding L-system is given by  $(50)$  then.

In order to prove the second part of the theorem statement we simply repeat the argument used in the proof of Theorem [5](#page-9-0) with  $\kappa = 0$  and  $U = -e^{-2i\alpha}$ .  $\Box$ 

<span id="page-12-0"></span>Finally, we address a slightly more general problem of representing the functions  $aM_{(\dot{A},A)}(z)$ , where  $M_{(\dot{A},A)}(z)$  is the Weyl-Titchmarsh function associated with the pair  $(\dot{A}, A)$ , with an arbitrary  $a > 0$ .

Observe that from the definition of the generalized Donoghue classes  $\mathfrak{M}_\kappa$  and  $\mathfrak{M}_{\kappa}^{-1}$ (see ([20](#page-5-0))) it follows that

$$
aM_{(\dot A,A)}(z)\in \mathfrak{M}_\kappa,
$$

with

(54) 
$$
\kappa = \frac{1-a}{1+a},
$$

whenever  $0 < a < 1$  and

$$
aM_{(\dot{A},A)}(z)\in {\mathfrak{M}}_\kappa^{-1},
$$

with

(55) 
$$
\kappa = \frac{a-1}{1+a}.
$$

for  $a > 1$ .

THEOREM 7. Assume Hypothesis [4](#page-9-0). Suppose, in addition, that A is the selfadjoint extensions of  $\dot{A}$  such that

$$
g_+ - g_- \in \text{Dom}(A).
$$

Let  $M_{(\dot{A},A)}(z)$  denote the Weyl-Titchmarsh function of the pair  $(\dot{A}, A)$ .

Then the function  $aM_{(\dot{A},A)}(z)$ ,  $(0 < a < 1)$  coincides with the impedance function of a unique L-system of the form

(56) 
$$
\Theta_{1a} = \begin{pmatrix} A_{1a} & K_{1a} & 1 \ \mathcal{H}_+ \subset \mathcal{H} \subset \mathcal{H}_- & \mathbb{C} \end{pmatrix},
$$

where

(57) 
$$
\mathbb{A}_{1a} = \dot{A}^* - \frac{i}{2} (\cdot, (1-a)\varphi + (1+a)\psi) (\varphi - \psi).
$$

and

$$
K_{1a}c = c \cdot \chi_{1a}, \quad (c \in \mathbb{C})
$$

with

(58) 
$$
\chi_{1a} = \sqrt{\frac{a}{2}} (\varphi - \psi).
$$

In this case, the von Neumann parameter k of the main operator  $T_{1a}$  of the system and the von Neumann parameter U of the quasi-kernel  $\hat{A}_{1a} = A$  are given by

(59) 
$$
\kappa = \frac{1-a}{1+a} \quad and \quad U = -1.
$$

Moreover, if  $\Theta$  is an L-system [\(5](#page-3-0)) with the symmetric operator  $\dot{A}$  such that

$$
V_{\Theta}(z) = a M_{(\dot{A},A)}(z), \quad z \in \mathbb{C}_+,
$$

where  $A = \hat{A}$  is the quasi-kernel of Re A, then the von Neumann parameters  $\kappa$  and U of the operators T and  $\hat{A}$  of  $\Theta$  are given by (59).

<span id="page-13-0"></span>PROOF. We follow the steps of the proof of Theorem [5](#page-9-0) and hence use formulas  $(34)$  $(34)$ –  $(35)$  $(35)$  with parameters  $\kappa$  represented in the form  $(54)$  and  $U = -1$ . We get

(60)  
\n
$$
\operatorname{Im} \mathbb{A}_{1a} = (\cdot, \chi_{1a}) \chi_{1a} = \frac{\sqrt{a}}{\sqrt{2}} (\cdot, \varphi - \psi) \chi_{1a},
$$
\n
$$
\operatorname{Re} \mathbb{A}_{1a} = \dot{A}^* - \frac{i}{2} (\cdot, \varphi + \psi)(\varphi - \psi) = \dot{A}^* - \frac{i}{\sqrt{2a}} (\cdot, \varphi + \psi) \chi_{1a},
$$

and $\chi_{1a}$  is defined by ([58\)](#page-12-0). Then

$$
\begin{split} \mathbb{A}_{1a} &= \text{Re}\,\mathbb{A}_{1a} + i\,\text{Im}\,\mathbb{A}_{1a} = \dot{A}^* - \frac{i}{\sqrt{2a}}\left[ (\cdot, \varphi + \psi) - a(\cdot, \varphi - \psi) \right] \chi_{1a} \\ &= \dot{A}^* - \frac{i}{\sqrt{2a}}\left[ (\cdot, \varphi + \psi) - a(\cdot, \varphi - \psi) \right] \frac{\sqrt{a}}{\sqrt{2}}\left( \varphi - \psi \right) \\ &= \dot{A}^* - \frac{i}{2}\left( \cdot, \varphi - a\varphi + \psi + a\psi \right) \left( \varphi - \psi \right) \\ &= \dot{A}^* - \frac{i}{2}\left( \cdot, (1-a)\varphi + (1+a)\psi \right) \left( \varphi - \psi \right). \end{split}
$$

This confirms [\(57](#page-12-0)).

In order to prove the second part of the theorem statement we simply repeat the argument used in the proof of Theorem [5](#page-9-0) with  $\kappa = \frac{1-a}{1+a}$  and  $U = -1$ .  $\Box$ 

A similar result holds for  $a > 1$ .

THEOREM 8. Assume Hypothesis [4](#page-9-0). Suppose, in addition, that A is the selfadjoint extensions of  $\ddot{A}$  such that

$$
g_+ + g_- \in \text{Dom}(A).
$$

Let  $M_{(\dot{A},A)}(z)$  denote the Weyl-Titchmarsh function of the pair  $(\dot{A}, A)$ .

Then the function  $aM_{(\dot{A},A)}(z)$ ,  $(a>1)$  coincides with the impedance function of a unique L-system of the form

(61) 
$$
\Theta_{1a} = \begin{pmatrix} A_{1a} & K_{1a} & 1 \ \mathcal{H}_+ \subset \mathcal{H} \subset \mathcal{H}_- & \mathbb{C} \end{pmatrix},
$$

where

(62) 
$$
\mathbb{A}_{1a} = \dot{A}^* - \frac{i}{2} (\cdot, (1-a)\varphi - (1+a)\psi)(\varphi + \psi).
$$

and

$$
K_{1a}c = c \cdot \chi_{1a}, \quad (c \in \mathbb{C})
$$

with

(63) 
$$
\chi_{1a} = \sqrt{\frac{a}{2}} (\varphi + \psi).
$$

In this case, the von Neumann parameter k of the main operator  $T_{1a}$  of the system and the von Neumann parameter U of the quasi-kernel  $\hat{A}_{1a} = A$  are given by

(64) 
$$
\kappa = \frac{a-1}{1+a} \quad and \quad U = 1.
$$

Moreover, if  $\Theta$  is an L-system [\(5](#page-3-0)) with the symmetric operator  $\dot{A}$  such that

$$
V_{\Theta}(z) = a M_{(\dot{A},A)}(z), \quad z \in \mathbb{C}_+,
$$

<span id="page-14-0"></span>where  $A = \overline{A}$  is the quasi-kernel of Re A, then the von Neumann parameters  $\kappa$  and U of the operators T and  $\hat{A}$  of  $\Theta$  are given by [\(64\)](#page-13-0).

PROOF. We follow the steps of the proof of Theorem [5](#page-9-0) and hence use formulas  $(39) - (40)$  $(39) - (40)$  $(39) - (40)$  $(39) - (40)$  $(39) - (40)$  with parameters  $\kappa$  represented in the form  $(55)$  and  $U = 1$ . We get

Im 
$$
\mathbb{A}_{1a} = (\cdot, \chi_{1a}) \chi_{1a} = \frac{\sqrt{a}}{\sqrt{2}} (\cdot, \varphi + \psi) \chi_{1a},
$$

Re 
$$
\mathbb{A}_{1a} = \dot{A}^* - \frac{i}{2}(\cdot, \varphi - \psi)(\varphi + \psi) = \dot{A}^* - \frac{i}{\sqrt{2a}}(\cdot, \varphi - \psi)\chi_{1a},
$$

and $\chi_{1a}$  is defined by ([63\)](#page-13-0). Then

$$
\begin{split}\n\mathbb{A}_{1a} &= \text{Re}\,\mathbb{A}_{1a} + i \,\text{Im}\,\mathbb{A}_{1a} = \dot{A}^* - \frac{i}{\sqrt{2a}} \left[ (\cdot, \varphi - \psi) - a(\cdot, \varphi + \psi) \right] \chi_{1a} \\
&= \dot{A}^* - \frac{i}{\sqrt{2a}} \left[ (\cdot, \varphi - \psi) - a(\cdot, \varphi + \psi) \right] \frac{\sqrt{a}}{\sqrt{2}} \left( \varphi + \psi \right) \\
&= \dot{A}^* - \frac{i}{2} \left( \cdot, \varphi - a\varphi - \psi - a\psi \right) \left( \varphi + \psi \right) \\
&= \dot{A}^* - \frac{i}{2} \left( \cdot, (1 - a)\varphi - (1 + a)\psi \right) \left( \varphi + \psi \right).\n\end{split}
$$

This confirms [\(62](#page-13-0)).

(65)

In order to prove the second part of the theorem statement we simply repeat the argument used in the proof of Theorem [5](#page-9-0) with  $\kappa = \frac{a-1}{1+a}$  and  $U = 1$ .

## 6. c-Entropy and dissipation coefficient

We begin with reminding a definition of the c-entropy of an L-system introduced in [[4](#page-24-0)].

DEFINITION 9. Let  $\Theta$  be an L-system of the form [\(5](#page-3-0)). The quantity

(66) 
$$
S = -\ln(|W_{\Theta}(-i)|),
$$

where  $W_{\Theta}(z)$  is the transfer function of  $\Theta$ , is called the **coupling entropy** (or c-entropy) of the L-system  $\Theta$ .

Notice that if, in addition, the point  $z = i$  belongs to  $\rho(T)$ , then we also have that

(67) 
$$
S = \ln(|W_{\Theta}(i)|) = \ln(1/|\kappa|) = -\ln(|\kappa|).
$$

This follows from the known (see [[2](#page-24-0)]) property of the transfer functions for Lsystems that states that  $W_{\Theta}(z)\overline{W_{\Theta}(\bar{z})}=1$  and the fact that  $|W_{\Theta}(i)|=1/|\kappa|$  (see  $\vert 3 \vert$  $\vert 3 \vert$  $\vert 3 \vert$ ).

DEFINITION 10. Let T be the main operator of an L-system  $\Theta$  of the form [\(5](#page-3-0)) and  $\kappa$  be its von Neumman's parameter according to a fixed ( $\cdot$ )-normalized deficiency basis  $g'_{\pm}$  such that  $0 \leq \kappa \leq 1$ . If

(68) 
$$
\tilde{y} = g'_{+} - \kappa g'_{-},
$$

then the quantity  $\mathcal{D} = \text{Im}(T\tilde{y}, \tilde{y})$  is called the **coefficient of dissipation** of the L-system Θ.

Our next immediate goal is to establish the connection between the coefficient of dissipation  $D$  and c-entropy of an L-system  $\Theta$ .

LEMMA 11. Let  $\Theta$  be an L-system of the form [\(5](#page-3-0)).

Then c-entropy  $S$  and the coefficient of dissipation  $D$  of the system are related as

(69)  $\mathcal{D} = 1 - e^{-2S}$ .

PROOF. Let T be the main operator of  $\Theta$ . Since

$$
\tilde{y} = g'_{+} - \kappa g'_{-} \in \text{Dom}(T)
$$

and  $T \subset \dot{A}^*$ , where  $\dot{A}$  is the symmetric operator associated with the system  $\Theta$ , we have

$$
(T\tilde{y}, \tilde{y}) = (T(g'_{+} - \kappa g'_{-}), g'_{+} - \kappa g'_{-}) = i(g'_{+} + \kappa g'_{-}, g'_{+} - \kappa g'_{-})
$$
  
=  $i(||g'_{+}||^{2} - \kappa^{2}||g'_{-}||^{2}) + i\kappa[(g'_{-}, g'_{+}) - (g'_{+}, g'_{-})]$   
=  $i(1 - \kappa^{2}) + i\kappa[(g'_{-}, g'_{+}) - (g'_{-}, g'_{+})].$ 

Here we have taken into account the normalization condition  $||g'_{\pm}|| = 1$ . Note that the second term in the last sum is a real number. Therefore,

(70) 
$$
\mathcal{D} = \text{Im}(T\tilde{y}, \tilde{y}) = 1 - \kappa^2.
$$

Since  $|W_{\Theta}(-i)| = |\kappa|$  (see [[5](#page-24-0)]),

(71) 
$$
S = -\ln(|W_{\Theta}(-i)|) = -\ln(|\kappa|).
$$

Combining (70) and and (71) we obtain the connection between the L-system's c-entropy and its coefficient of dissipation given by (69).

 $\Box$ 

REMARK 12. Note that c-entropy defined by formula (71) is an additive func-tion with respect to the coupling of L-systems (see [[5](#page-24-0)]). That means if L-system  $\Theta$ with c-entropy S is a coupling of two L-systems  $\Theta_1$  and  $\Theta_2$  with c-entropies  $S_1$  and  $\mathcal{S}_2$ , respectively, we have

$$
S=S_1+S_2.
$$

Let  $\mathcal{D}, \mathcal{D}_1$ , and  $\mathcal{D}_2$  be the dissipation coefficients of L-systems  $\Theta, \Theta_1$ , and  $\Theta_2$ . Then Lemma 11 and (69) imply

$$
1 - \mathcal{D} = e^{-2\mathcal{S}} = e^{-2(\mathcal{S}_1 + \mathcal{S}_2)} = e^{-2\mathcal{S}_1} \cdot e^{-2\mathcal{S}_2} = (1 - \mathcal{D}_1)(1 - \mathcal{D}_2).
$$

Thus, the formula

(72) 
$$
\mathcal{D} = 1 - (1 - \mathcal{D}_1)(1 - \mathcal{D}_2) = \mathcal{D}_1 + \mathcal{D}_2 - \mathcal{D}_1 \mathcal{D}_2,
$$

describes the coefficient of dissipation of the L-system coupling.

Now we are going to find c-entropy for the L-systems whose impedances are the functions  $M_{(\dot{A},A)}(z)$  and  $aM_{(\dot{A},A)}(z)$  with  $a>0$ .

THEOREM 13. Let A be a symmetric densely defined closed operator with deficiency indices (1, 1) and (+)-normalized deficiency vectors  $g_+$  and  $g_-$ .

Assume, in addition, that A is a self-adjoint extensions of A such that

$$
g_+ - g_- \in \text{Dom}(A).
$$

Let  $M_{(\dot{A},A)}(z)$  denote the Weyl-Titchmarsh function of the pair  $(\dot{A}, A)$ .

<span id="page-15-0"></span>

<span id="page-16-0"></span>Then the function  $M_{(\dot{A},A)}(z)$  can be represented as the impedance function of an L-system  $\Theta_{10}$  of the form [\(41\)](#page-9-0) with c-entropy S and the coefficient of dissipation of the main operator of the system  $\Theta_{10}$  given by

(73) S = ∞

and

(74) D = 1.

Moreover, if  $\Theta$  is an L-system [\(5](#page-3-0)) with the symmetric operator A such that

$$
V_\Theta(z)=M_{(\dot A,A)}(z),\quad z\in\mathbb C_+,
$$

where  $A = \hat{A}$  is the quasi-kernel of Re A, then  $\Theta$  has infinite c-entropy and the coefficient of dissipation of the main operator is 1.

PROOF. Applying Theorem [5](#page-9-0) yields that one of the defining  $\Theta_{10}$  parameters  $\kappa = 0$  $\kappa = 0$  $\kappa = 0$ . The proof then immediately follows from ([67](#page-14-0)) and [\(70](#page-15-0)).

Clearly, a similar to Theorem [13](#page-15-0) result takes place if the Weyl-Titchmarsh function  $M_{(\dot{A},A)}(z)$  in the statement of the theorem is replaced with  $M_{(\dot{A},A_{\alpha})}(z)$ . In this case one would apply Theorem [6](#page-10-0).

Now we state and prove analogues results for the functions  $aM_{(\dot{A},A)}(z)$  with  $a > 0, a \neq 1.$ 

THEOREM 14. Let A be a symmetric densely defined closed operator with deficiency indices (1, 1) and (+)-normalized deficiency vectors  $g_+$  and  $g_-$ .

Assume, in addition, that A is a self-adjoint extensions of A such that

$$
g_+ - g_- \in \text{Dom}(A).
$$

Let  $M_{(\dot{A},A)}(z)$  denote the Weyl-Titchmarsh function of the pair  $(\dot{A}, A)$ .

Then for any  $a \in (0,1)$ , the function  $aM_{(\dot{A},A)}(z)$  can be represented as the impedance function of an L-system  $\Theta_{1a}$  of the form ([56\)](#page-12-0) with c-entropy S and the coefficient of dissipation of the main operator of the system  $\Theta_{1a}$  given by

(75) 
$$
S = \ln(1 + a) - \ln(1 - a)
$$

and

(76) 
$$
\mathcal{D} = \frac{4a}{(1+a)^2},
$$

respectively.

Moreover, if  $\Theta$  is an L-system [\(5](#page-3-0)) with the symmetric operator A such that

$$
V_\Theta(z)=aM_{(\dot A,A)}(z),\quad z\in\mathbb C_+,
$$

where  $A = \hat{A}$  is the quasi-kernel of Re A, then  $\Theta$  has c-entropy S and the coefficient of dissipation of the main operator  $D$  defined by (75) and (76), respectively.

PROOF. Applying Theorem [7](#page-12-0) yields that one of the defining  $\Theta_{1a}$  parameters  $\kappa = \frac{1-a}{1+a}$  $\kappa = \frac{1-a}{1+a}$  $\kappa = \frac{1-a}{1+a}$ . Substituting this value in ([67\)](#page-14-0) gives us (75). Using ([70\)](#page-15-0) we get

$$
\mathcal{D} = 1 - \kappa^2 = 1 - \frac{(1 - a)^2}{(1 + a)^2} = \frac{4a}{(1 + a)^2},
$$

that confirms (76).  $\Box$ 

A similar result takes place for  $a > 1$ .

<span id="page-17-0"></span>THEOREM 15. Let  $\dot{A}$  be a symmetric densely defined closed operator with deficiency indices (1, 1) and (+)-normalized deficiency vectors  $g_+$  and  $g_-$ .

Assume, in addition, that A is a self-adjoint extensions of A such that

 $g_{+} + g_{-} \in Dom(A).$ 

Let  $M_{(\dot{A},A)}(z)$  denote the Weyl-Titchmarsh function of the pair  $(\dot{A}, A)$ .

Then for any  $a > 1$  the function  $aM_{(\dot{A},A)}(z)$  can be represented as the impedance function of an L-system  $\Theta_{1a}$  of the form [\(61](#page-13-0)) with c-entropy S and the coefficient of dissipation  $\mathcal D$  of the main operator of the system  $\Theta_{1a}$  given by

$$
(77) \qquad \qquad \mathcal{S} = \ln(a+1) - \ln(a-1)
$$

and

(78) 
$$
\mathcal{D} = \frac{4a}{(1+a)^2},
$$

respectfully.

Moreover, if  $\Theta$  is an L-system [\(5](#page-3-0)) with the symmetric operator  $\dot{A}$  such that

$$
V_\Theta(z)=aM_{(\dot A,A)}(z),\quad z\in\mathbb{C}_+,
$$

where  $A = \hat{A}$  is the quasi-kernel of Re A, then  $\Theta$  has c-entropy S and the coefficient of dissipation of the main operator  $D$  given by (77) and ([76\)](#page-16-0), respectively.

PROOF. Applying Theorem [8](#page-13-0) yields that one of the defining  $\Theta_{1a}$  parameters  $\kappa = \frac{a-1}{1+a}$  $\kappa = \frac{a-1}{1+a}$  $\kappa = \frac{a-1}{1+a}$ . Substituting this value in ([67\)](#page-14-0) gives us (77). Using ([70\)](#page-15-0) we get

$$
\mathcal{D} = 1 - \kappa^2 = 1 - \frac{(a-1)^2}{(1+a)^2} = \frac{4a}{(1+a)^2},
$$
 that confirms (78).

Notice that c-entropy  $S(a)$  given by [\(75](#page-16-0)) and (77) admits the representation

$$
\mathcal{S}(a) = \ln \left| \frac{a+1}{a-1} \right|, \quad a \in (0,1) \cup (1,\infty).
$$

It is clearly seen that  $S(a)$  coincides with the boundary values on the positive semiaxis of the real part of the analytic function  $\mathfrak{S}(a)$  in the upper half-plane of the complex parameter a given by

$$
\mathfrak{S}(z) = \ln \frac{a+1}{a-1} = \ln(a+1) - \ln(a-1), \quad a \in \mathbb{C}_+.
$$

Here  $\ln(z)$  denotes the principle branch of the logarithmic function that is real on the positive real-axis. That is,

$$
\mathcal{S}(a) = \text{Re}(\mathfrak{G}(a + i0)), \quad a \in (0, 1) \cap (1, \infty).
$$

The point  $a = 1$  is a branching point of  $\mathfrak{S}(a)$ : c-entropy is infinite in this case (see eq. [\(73](#page-16-0))).

It is interesting to note that the corresponding one-form  $d\mathfrak{S}(a)$  is an Abelian differential of the third kind with simple poles at  $a = \pm 1$  with

$$
Res(d\mathfrak{S})|_{a=\pm 1}=\mp 1
$$

on the Riemann surface  $\mathfrak{R} = \mathbb{C} \cup \{\infty\}.$ 

<span id="page-18-0"></span>Observe that the differential  $d\mathfrak{S}(a)$  is invariant with respect to the involution of the Riemann surface  $\Re$  given by

$$
a \mapsto \frac{1}{a}, \quad a \in \mathfrak{R} = \mathbb{C} \cup \{\infty\}.
$$

In particular,

$$
\mathcal{S}(a) = \mathcal{S}\left(\frac{1}{a}\right), \quad a \in (0,1) \cap (1,\infty).
$$

and hence, by Lemma [11,](#page-15-0)

$$
\mathcal{D}(a) = \mathcal{D}\left(\frac{1}{a}\right), \quad a \in (0, \infty).
$$

One cam also see that directly. Indeed, since

$$
\mathcal{D}(a) = \frac{4a}{(1+a)^2} \quad \text{for all} \quad a \in (0, \infty)
$$

(see [\(74\)](#page-16-0), [\(76](#page-16-0)) and([78\)](#page-17-0)), one computes

$$
\mathcal{D}(a) = \frac{4a}{(1+a)^2} = \frac{\frac{4}{a}}{(1+\frac{1}{a})^2} = \mathcal{D}\left(\frac{1}{a}\right), \quad a \in (0, \infty).
$$

A natural question arises then: can different values  $0 < a_1 < 1$  and  $a_2 > 1$  give the same dissipation coefficient and under what condition? To answer it we set

$$
\mathcal{D}(a_1) = \frac{4a_1}{(1+a_1)^2} = \mathcal{D}(a_2) = \frac{4a_2}{(1+a_2)^2}, \quad 0 < a_1 < 1 < a_2,
$$

to get

$$
a_1(1 + a_2)^2 = a_2(1 + a_1)^2.
$$

Expanding and simplifying the above yields

$$
(a_1 - a_2)(1 - a_1 a_2) = 0, \quad 0 < a_1 < 1 < a_2.
$$

Therefore the only possibility for the dissipation coefficient to stay the same is when  $a_2 = 1/a_1.$

<span id="page-19-0"></span>The results of Section [6](#page-14-0) are summarized in Table [1](#page-18-0) where each row shows a function to be represented as well as the values of c-Entropy and dissipation coefficient of the representing L-system. The last column of Table [1](#page-18-0) references theorems stating the corresponding result.

## 7. Examples

Example 1. In this example we will apply Theorem [5](#page-9-0) to present an L-system that has the impedance function matching a given function  $M_{(\dot{A},A)}(z)$ .

Following  $[1]$  $[1]$  $[1]$  we consider the prime symmetric operator for  $\ell > 0$ 

(79)

$$
\dot{A}x = i\frac{dx}{dt}, \text{ Dom}(\dot{A}) = \left\{x(t) \middle| x(t) - \text{abs. cont.}, x'(t) \in L^2_{[0,\ell]}, x(0) = x(\ell) = 0\right\}.
$$

Its (normalized) deficiency vectors of  $\vec{A}$  are

(80) 
$$
g_{+} = \frac{\sqrt{2}}{\sqrt{e^{2\ell} - 1}} e^{t} \in \mathfrak{N}_{i}, \qquad g_{-} = \frac{\sqrt{2}}{\sqrt{1 - e^{-2\ell}}} e^{-t} \in \mathfrak{N}_{-i}.
$$

If we set  $C = \frac{\sqrt{2}}{\sqrt{e^{2\ell}}}$  $\frac{\sqrt{2}}{e^{2\ell}-1}$ , then (80) can be re-written as

$$
g_{+} = Ce^{t}, \quad g_{-} = Ce^{\ell}e^{-t}.
$$

Let

(81)

$$
Ax = i\frac{dx}{dt}
$$
, Dom(A) =  $\left\{x(t) | x(t) - abs. \text{ cont.}, x'(t) \in L^2_{[0,\ell]}, x(0) = -x(\ell)\right\}$ .

be a self-adjoint extension of  $\dot{A}$ . Clearly,  $g_+(0) - g_-(0) = C - Ce^{\ell}$  and  $g_+(\ell) g_-(\ell) = Ce^{\ell} - C$  $g_-(\ell) = Ce^{\ell} - C$  $g_-(\ell) = Ce^{\ell} - C$  and hence the first part of ([21\)](#page-6-0) is satisfied, i.e.,  $g_+ - g_- \in \text{Dom}(A)$ . Thenthe Livšic function  $s(z)$  in ([13\)](#page-4-0) for the pair  $(\dot{A}, A)$  has the form (see [[1](#page-24-0)])

(82) 
$$
s(z) = \frac{e^{\ell} - e^{-i\ell z}}{1 - e^{\ell} e^{-i\ell z}}.
$$

Applying([16\)](#page-5-0) we get

(83) 
$$
M_{(\dot{A},A)}(z) = i \frac{e^{\ell} + 1}{e^{\ell} - 1} \cdot \frac{e^{-i\ell z} - 1}{e^{-i\ell z} + 1}.
$$

We introduce the operator

(84) 
$$
T_0 x = i \frac{dx}{dt},
$$

$$
Dom(T_0) = \left\{ x(t) \mid x(t) - abs. \text{ cont.}, x'(t) \in L^2_{[0,\ell]}, x(\ell) = e^{\ell} x(0) \right\}.
$$

It turns out that  $T_0$  is a dissipative extension of  $\dot{A}$  parameterized by the von Neumann parameter  $\kappa = 0$ . Indeed, using (80) with [\(11](#page-4-0)) again we obtain

(85) 
$$
x(t) = Ce^{t} - \kappa Ce^{\ell}e^{-t} \in \text{Dom}(T_0), \quad x(\ell) = e^{\ell}x(0),
$$

yielding  $\kappa = 0$ . We are going to use the triple  $(\dot{A}, T_0, A)$  in the construction of an L-system  $\Theta_0$ . By the direct check one gets

(86) 
$$
T_0^*x = i\frac{dx}{dt},
$$

Dom
$$
(T_0^*)
$$
 =  $\left\{ x(t) | x(t) - abs. \text{ cont.}, x'(t) \in L^2_{[0,\ell]}, x(\ell) = e^{-\ell}x(0) \right\}.$ 

<span id="page-20-0"></span>Following [[3](#page-24-0), Example 1] we have

(87) 
$$
\dot{A}^*x = i\frac{dx}{dt}, \text{ Dom}(\dot{A}^*) = \left\{x(t) \middle| x(t) - \text{abs. cont.}, x'(t) \in L^2_{[0,\ell]}\right\}.
$$

Then  $\mathcal{H}_+ = \text{Dom}(\dot{A}^*) = W_2^1$  is the Sobolev space with scalar product

(88) 
$$
(x,y)_+ = \int_0^\ell x(t)\overline{y(t)} dt + \int_0^\ell x'(t)\overline{y'(t)} dt.
$$

Construct rigged Hilbert space  $W_2^1 \subset L^2_{[0,\ell]} \subset (W_2^1)$ .

In order to illustrate the results of Section [5](#page-9-0) we need to  $(+)$ -normalize the deficiency vectors  $g_{\pm}$  from [\(80](#page-19-0)). Using Remark [3](#page-7-0) we obtain a new set

(89) 
$$
g'_{+} = \frac{e^t}{\sqrt{e^{2\ell} - 1}} \in \mathfrak{N}_i, \qquad g'_{-} = \frac{e^{-t}}{\sqrt{1 - e^{-2\ell}}} \in \mathfrak{N}_{-i}.
$$

such that  $||g'_{\pm}||_{+} = 1$ . Now relying on the fact that  $(g'_{+}, \varphi) = (g'_{-}, \psi) = 1$  and  $(g'_{+}, \psi) = (g'_{-}, \varphi) = 0$  we find

(90) 
$$
\varphi = \frac{1}{\sqrt{e^{2\ell}-1}} [e^{\ell} \delta(t-\ell) - \delta(t)] \text{ and } \psi = \frac{1}{\sqrt{e^{2\ell}-1}} [e^{\ell} \delta(t) - \delta(t-\ell)].
$$

Here  $\delta(t)$ ,  $\delta(t-\ell)$  are delta-functions and elements of  $(W_2^1)$ <sub>-</sub> that generate functionals by the formulas  $(x, \delta(t)) = x(0)$  and  $(x, \delta(t-\ell)) = x(\ell)$ . For further convenience we find

(91) 
$$
\varphi - \psi = \sqrt{\frac{e^{\ell} + 1}{e^{\ell} - 1}} \left[ \delta(t - \ell) - \delta(t) \right].
$$

Applying Theorem [5](#page-9-0) and formula [\(42](#page-9-0)) with  $\varphi$  and  $\psi$  from (90), we construct operator

$$
\begin{split} \mathbb{A}_{10}x &= \dot{A}^*x - i(x,\psi)(\varphi - \psi) \\ &= i\frac{dx}{dt} - i\frac{1}{\sqrt{e^{2\ell}-1}}(e^{\ell}x(0) - x(\ell)) \cdot \sqrt{\frac{e^{\ell}+1}{e^{\ell}-1}} \left[ \delta(t-\ell) - \delta(t) \right] \\ &= i\frac{dx}{dt} + i\frac{x(\ell) - e^{\ell}x(0)}{e^{\ell}-1} \left[ \delta(t-\ell) - \delta(t) \right]. \end{split}
$$

Finding also  $\mathbb{A}_{10}^*$  we obtain

(92)  

$$
A_{10}x = i\frac{dx}{dt} + i\frac{x(\ell) - e^{\ell}x(0)}{e^{\ell} - 1} [\delta(t - \ell) - \delta(t)],
$$

$$
A_{10}^{*}x = i\frac{dx}{dt} + i\frac{x(0) - e^{\ell}x(\ell)}{e^{\ell} - 1} [\delta(t - \ell) - \delta(t)],
$$

where  $x(t) \in W_2^1$ . It is easy to see that  $\mathbb{A}_{10} \supset T_0 \supset \dot{A}$ ,  $\mathbb{A}_{10}^* \supset T_0^* \supset \dot{A}$ , and (independently or via [\(49](#page-10-0))) we get

Re 
$$
A_{10}x = i\frac{dx}{dt} - \frac{i}{2}(x(0) + x(\ell)) [\delta(t - \ell) - \delta(t)].
$$

Moreover,  $\text{Re } A_0$  has its quasi-kernel equal to A in [\(81](#page-19-0)). Similarly,

Im 
$$
\mathbb{A}_{10}x = \left(\frac{1}{2}\right) \frac{e^{\ell} + 1}{e^{\ell} - 1} (x(\ell) - x(0)) [\delta(t - \ell) - \delta(t)].
$$

Therefore,

Im 
$$
\mathbb{A}_{10}
$$
 =  $\left(\cdot, \sqrt{\frac{e^{\ell} + 1}{2(e^{\ell} - 1)}} \left[\delta(t - \ell) - \delta(t)\right]\right) \sqrt{\frac{e^{\ell} + 1}{2(e^{\ell} - 1)}} \left[\delta(t - \ell) - \delta(t)\right]$   
 =  $(\cdot, \chi_{10})\chi_{10}$ ,

where (see  $(43)$ )

(93) 
$$
\chi_{10} = \sqrt{\frac{e^{\ell} + 1}{2(e^{\ell} - 1)}} [\delta(t - \ell) - \delta(t)] = \frac{1}{\sqrt{2}} (\varphi - \psi).
$$

Now we can build

$$
\Theta_{10} = \begin{pmatrix} \mathbb{A}_{10} & K_{10} & 1 \\ W_2^1 \subset L^2_{[0,l]} \subset (W_2^1)_{-} & \mathbb{C} \end{pmatrix},
$$

which is a minimal L-system of the form [\(41](#page-9-0)) described in Theorem [5.](#page-9-0) Here  $K_{10}c =$  $c \cdot \chi_{10}$ ,  $(c \in \mathbb{C})$ ,  $K_{10}^* x = (x, \chi_{10})$  and  $x(t) \in W_2^1$ . It was shown in [[3](#page-24-0), Example 2] the transfer function of  $\Theta_{10}$  is

$$
W_{\Theta_{10}}(z) = \frac{e^{\ell}e^{-i\ell z} - 1}{e^{\ell} - e^{-i\ell z}}.
$$

The corresponding impedance function also independently calculated in [[3](#page-24-0), Exam-ple2 (or found by  $(9)$  $(9)$ ) is

$$
V_{\Theta_{10}}(z) = i \frac{e^{\ell} + 1}{e^{\ell} - 1} \cdot \frac{e^{-i\ell z} - 1}{e^{-i\ell z} + 1}
$$

that matches  $M_{(\dot{A},A)}(z)$  from [\(83](#page-19-0)). The c-entropy of the L-system  $\Theta_{10}$  is infinite and the coefficient of dissipation of  $T_0$  in [\(84](#page-19-0)) is  $\mathcal{D} = 1$ .

Example 2. In this example we will apply Theorem [7](#page-12-0) to present an L-system with impedance mapping matching a function  $aM_{(\dot{A},A)}(z)$ ,  $(0 < a < 1)$ . Then we will provide a similar construction illustrating Theorem [8](#page-13-0).

We rely on the main elements of the construction presented in Example 1 but with some changes. Let A and A be still defined by formulas [\(79](#page-19-0))and ([81\)](#page-19-0), respectively and let  $s(z)$  be the Livšic characteristic function  $s(z)$  for the pair  $(A, A)$ given by([82\)](#page-19-0). We introduce the operator

(94) 
$$
Tx = i\frac{dx}{dt}
$$
,  $\text{Dom}(T) = \left\{x(t) \mid x(t) - \text{abs. cont.}, x'(t) \in L^2_{[0,\ell]}, x(0) = 0\right\}$ .

By construction, T is a dissipative extension of  $\dot{A}$  parameterized by the von Neumann parameter  $\kappa$ . To find  $\kappa$  we use [\(80](#page-19-0)) with [\(11](#page-4-0)) to obtain

(95) 
$$
x(t) = Ce^{t} - \kappa Ce^{\ell}e^{-t} \in \text{Dom}(T), \quad x(0) = 0,
$$

yielding

$$
(96) \t\t \t\t \kappa = e^{-\ell}.
$$

Let

(97) 
$$
a = \frac{1 - \kappa}{1 + \kappa} = \frac{1 - e^{-\ell}}{1 + e^{-\ell}} = \frac{e^{\ell} - 1}{e^{\ell} + 1} < 1
$$

<span id="page-21-0"></span>

<span id="page-22-0"></span>and introduce

(98) 
$$
V(z) = aM_{(\dot{A},A)}(z) = \frac{e^{\ell} - 1}{e^{\ell} + 1}M_{(\dot{A},A)}(z),
$$

where  $M_{(\dot{A},A)}(z)$  is given by [\(83](#page-19-0)). Clearly,  $V(z) = aM_{(\dot{A},A)}(z) \in \mathfrak{M}_{\kappa}$  with  $\kappa = e^{-\ell}$ . We are going to utilize Theorem [7](#page-12-0) to construct an L-system  $\Theta_{1a}$  that represents  $V(z)$  as its impedance function.

Following the steps of Example 1 we are going to use the triple  $(A, T, A)$  in the construction of an L-system Θ. First, we note that by the direct check one gets

(99) 
$$
T^*x = i\frac{dx}{dt}
$$
,  $\text{Dom}(T) = \left\{x(t) \middle| x(t) - \text{abs. cont.}, x'(t) \in L^2_{[0,\ell]}, x(\ell) = 0\right\}$ .

Let  $W_2^1 \subset L^2_{[0,\ell]} \subset (W_2^1)$  be the rigged Hilbert space explained in Example 1. Applying Theorem [7](#page-12-0) and formula [\(57](#page-12-0))with  $\varphi$  and  $\psi$  from ([90\)](#page-20-0), we obtain operators

(100) 
$$
\mathbb{A}_{1a}x = i\frac{dx}{dt} + ix(0)[\delta(t) - \delta(t-\ell)], \quad \mathbb{A}_{1a}^*x = i\frac{dx}{dt} + ix(l)[\delta(t) - \delta(t-\ell)],
$$

where  $x(t) \in W_2^1$ . It is easy to see that  $\mathbb{A}_{1a} \supset T \supset \dot{A}$ ,  $\mathbb{A}_{1a}^* \supset T^* \supset \dot{A}$ , and that

Re 
$$
\mathbb{A}_{1a}x = i\frac{dx}{dt} + \frac{i}{2}(x(0) + x(\ell))[\delta(t) - \delta(t - \ell)].
$$

Clearly,Re  $\mathbb A$  has its quasi-kernel equal to  $A$  in ([81\)](#page-19-0). Moreover,

Im 
$$
\mathbb{A}_{1a} = \left( \cdot, \frac{1}{\sqrt{2}} [\delta(t) - \delta(t - \ell)] \right) \frac{1}{\sqrt{2}} [\delta(t) - \delta(t - \ell)] = (\cdot, \chi_{1a}) \chi_{1a},
$$

where  $\chi_{1a} = \frac{1}{\sqrt{2}}$  $\frac{1}{2}[\delta(t)-\delta(t-\ell)]$ . Note that  $\mathbb{A}_{1a}$  represents a (\*)-extension of operator T with one-dimensional imaginary component in  $L^2_{[0,\ell]}$  while the description of all such  $(*)$ -extensions is given in  $[20]$  $[20]$  $[20]$ .

Now we can build

(101) 
$$
\Theta_{1a} = \begin{pmatrix} \mathbb{A}_{1a} & K_{1a} & 1 \\ W_2^1 \subset L^2_{[0,\ell]} \subset (W_2^1)_{-} & \mathbb{C} \end{pmatrix},
$$

that is a minimal L-system with

(102)  
\n
$$
K_{1a}c = c \cdot \chi_{1a} = c \cdot \frac{1}{\sqrt{2}} [\delta(t) - \delta(t - l)], \quad (c \in \mathbb{C}),
$$
\n
$$
K_{1a}^* x = (x, \chi_{1a}) = \left( x, \frac{1}{\sqrt{2}} [\delta(t) - \delta(t - l)] \right) = \frac{1}{\sqrt{2}} [x(0) - x(l)],
$$

and  $x(t) \in W_2^1$ . It was shown in [[3](#page-24-0), Example 1] that the transfer function of  $\Theta_{1a}$  is  $W_{\Theta_{1a}}(z) = e^{-i\ell z}.$ 

The corresponding impedance function is found via([9\)](#page-4-0) and is

$$
V_{\Theta_{1a}}(z) = i \frac{e^{-i\ell z} - 1}{e^{-i\ell z} + 1}
$$

that matches function  $V(z) = aM_{(\dot{A},A)}(z)$  of the form (98). Also, one can confirm by direct substitution that

$$
V_{\Theta_{1a}}(i) = i \frac{e^{\ell} - 1}{e^{\ell} + 1} = ia.
$$

<span id="page-23-0"></span>Usingformulas ([75](#page-16-0)) and [\(76](#page-16-0)) we find that the c-entropy of the L-system  $\Theta_{1a}$  is

$$
S = \ln\left(1 + \frac{e^{\ell} - 1}{e^{\ell} + 1}\right) - \ln\left(1 - \frac{e^{\ell} - 1}{e^{\ell} + 1}\right) = \ln(e^{\ell}) = \ell
$$

and the coefficient of dissipation of  $T$  in [\(94](#page-21-0)) can be found via [\(76\)](#page-16-0) as

$$
\mathcal{D} = \frac{4a}{(1+a)^2} = \frac{4\frac{e^{\ell}-1}{e^{\ell}+1}}{(1+\frac{e^{\ell}-1}{e^{\ell}+1})^2} = \frac{e^{2\ell}-1}{e^{2\ell}} = 1-e^{-2\ell}.
$$

We can quickly modify the developed construction to illustrate Theorem [8](#page-13-0) using the value

$$
\frac{1}{a} = \frac{e^{\ell} + 1}{e^{\ell} - 1} > 1.
$$

Consider the function

(103) 
$$
-V^{-1}(z) = \frac{1}{a} M_{(\dot{A}, A_{\frac{\pi}{2}})}(z) = \frac{e^{\ell} + 1}{e^{\ell} - 1} \cdot i \frac{e^{\ell} - 1}{e^{\ell} + 1} \cdot \frac{e^{-i\ell z} + 1}{e^{-i\ell z} - 1} = i \frac{e^{-i\ell z} + 1}{e^{-i\ell z} - 1},
$$

where  $V(z)$  is still defined by [\(98](#page-22-0)). It is known [[2](#page-24-0)] (see also [[5](#page-24-0)], [[6](#page-24-0)]) that  $-V^{-1}(z)$ can be represented as the impedance function of an L-system  $\Theta_{1\frac{1}{a}}$  that has the same main operator T (of the form  $(94)$ ) as  $\Theta_{1a}$ . Applying Theorem [8](#page-13-0) and formula ([62\)](#page-13-0) with  $\varphi$  and  $\psi$  from [\(90](#page-20-0)), and noting that

(104) 
$$
\varphi + \psi = \sqrt{\frac{e^{\ell} - 1}{e^{\ell} + 1}} \left[ \delta(t - \ell) + \delta(t) \right],
$$

we obtain operators

(105) 
$$
\mathbb{A}_{1\frac{1}{a}}x = i\frac{dx}{dt} + ix(0)[\delta(t) + \delta(t-\ell)], \quad \mathbb{A}_{1\frac{1}{a}}^*x = i\frac{dx}{dt} - ix(l)[\delta(t) + \delta(t-\ell)],
$$

where  $x(t) \in W_2^1$ . It is easy to see that  $\mathbb{A}_{1\frac{1}{a}} \supset T \supset \dot{A}$ ,  $\mathbb{A}_{1\frac{1}{a}}^* \supset T^* \supset \dot{A}$ , and that

Re 
$$
A_{1\frac{1}{a}}x = i\frac{dx}{dt} + \frac{i}{2}(x(0) - x(\ell))[\delta(t) + \delta(t - \ell)],
$$

with the quasi-kernel

$$
A_{\frac{\pi}{2}}x = i\frac{dx}{dt}, \text{ Dom}(A_{\frac{\pi}{2}}) = \left\{x(t) \mid x(t) - \text{abs. cont.}, x'(t) \in L^2_{[0,\ell]}, x(0) = x(\ell)\right\}.
$$

Moreover,

Im 
$$
\mathbb{A}_{1\frac{1}{a}} = \left(\cdot, \frac{1}{\sqrt{2}}[\delta(t) + \delta(t-\ell)]\right) \frac{1}{\sqrt{2}}[\delta(t) + \delta(t-\ell)] = (\cdot, \chi_{1\frac{1}{a}})\chi_{1\frac{1}{a}},
$$

where  $\chi_{1\frac{1}{a}} = \frac{1}{\sqrt{2a}}$  $\frac{1}{2}[\delta(t) + \delta(t-\ell)]$ . Now we can construct

(106) 
$$
\Theta_{1\frac{1}{a}} = \begin{pmatrix} \mathbb{A}_{1\frac{1}{a}} & K_{1\frac{1}{a}} & 1 \\ W_2^1 \subset L^2_{[0,\ell]} \subset (W_2^1)_{-} & \mathbb{C} \end{pmatrix},
$$

<span id="page-24-0"></span>that is a minimal L-system with

(107) 
$$
K_{1\frac{1}{a}}c = c \cdot \chi_{1\frac{1}{a}} = c \cdot \frac{1}{\sqrt{2}} [\delta(t) + \delta(t-l)], \quad (c \in \mathbb{C}),
$$

$$
K_{1\frac{1}{a}}^{*}x = (x, \chi_{1\frac{1}{a}}) = \left(x, \frac{1}{\sqrt{2}} [\delta(t) + \delta(t-l)]\right) = \frac{1}{\sqrt{2}} [x(0) + x(l)],
$$

and  $x(t) \in W_2^1$ . The transfer function of  $\Theta_{1\frac{1}{a}}$  is

$$
W_{\Theta_{1\frac{1}{a}}}(z) = -e^{-i\ell z},
$$

and the corresponding impedance function is found via([9\)](#page-4-0) and is

$$
V_{\Theta_{1\frac{1}{a}}}(z) = i \frac{e^{-i\ell z} + 1}{e^{-i\ell z} - 1}
$$

thatmatches  $-V^{-1}(z) = \frac{1}{a} M_{(\dot{A},A_{\frac{\pi}{2}})}(z)$  from ([103\)](#page-23-0). The c-entropy S of the Lsystem  $\Theta_{1\frac{1}{a}}$  equals to the one of the L-system  $\Theta_{1a}$  since both L-systems share the same main operator, i.e.,  $S = \ell$ . To find the coefficient of dissipation we apply [\(76\)](#page-16-0) independently

$$
\mathcal{D} = \frac{4\frac{1}{a}}{\left(1 + \frac{1}{a}\right)^2} = \frac{4\frac{e^{\ell} + 1}{e^{\ell} - 1}}{\left(1 + \frac{e^{\ell} + 1}{e^{\ell} - 1}\right)^2} = \frac{e^{2\ell} - 1}{e^{2\ell}} = 1 - e^{-2\ell}.
$$

This confirms our observation made in the end of Section [6](#page-14-0) that is  $\mathcal{D}(1/a) = \mathcal{D}(a)$ .

REMARK 16. Note that the symmetric operator A of the form  $(79)$  $(79)$ , that was used in Examples 1 and 2 for the construction of the representing L-systems, is a model operator (according to the Livšic Theorem  $[1, Sect. IX, Theorem 4], [13]$  $[1, Sect. IX, Theorem 4], [13]$  $[1, Sect. IX, Theorem 4], [13]$ ) for any prime symmetric operator with deficiency indices  $(1, 1)$  that admits dissipative extension without the spectrum in the open upper half-plane.
