# Wave breaking in the unidirectional non-local wave model

#### Abstract

In this paper we study wave breaking in the unidirectional non-local wave model describing the motion of a collision-free plasma in a magnetic field. By analyzing the monotonicity and continuity properties of a system of the Riccatitype differential inequalities involving the extremal slopes of flows, we show a new sufficient condition on the initial data to exhibit wave breaking. Moreover, the estimates of life span and wave breaking rate are derived.

Keywords: Unidirectional non-local wave model; Wave breaking; Collision-free plasma

#### 1 Introduction

The motion of a cold plasma in a magnetic field consisting of singly-charged particles can be described by [\[1](#page-9-0), [2](#page-9-1)]

where  $n = n(t, x)$ ,  $u = u(t, x)$  and  $b = b(t, x)$  stand for the ionic density, the ionic velocity and the magnetic field, respectively. System [\(1.1\)](#page-0-0)-[\(1.3\)](#page-0-1) can also be applied to describe the motion of collision-free two-fluid model under the assumptions that the electron inertia, the displacement current and the charge separation are neglected and the Poisson equation [\(1.3\)](#page-0-1) is satisfied initially [\[3,](#page-9-2) [4\]](#page-9-3).

Recently, Alonso-Orán D, Durán A and Granero-Belinchón R [\[23](#page-10-0)] derived a unidirectional asymptotic model describing the motion of a collision-free plasma in a magnetic field given in system  $(1.1)-(1.3)$  $(1.1)-(1.3)$ . The method to derive the unidirectional asymptotic model relies on a multi-scale expansion (see [\[5](#page-9-4)[–10](#page-9-5), [22\]](#page-10-1)) which reduces the full system  $(1.1)-(1.3)$  $(1.1)-(1.3)$  to a cascade of linear equations which can be closed up to some order of precision. More precisely, let

introducing the following formal expansions

$$
N = \sum_{l=0}^{\infty} \varepsilon^{l+1} N^{(l)}, \quad B = \sum_{l=0}^{\infty} \varepsilon^{l+1} B^{(l)}, \quad U = \sum_{l=0}^{\infty} \varepsilon^{l+1} U^{(l)} \tag{1.4}
$$

then under the extra assumption  $U^{(0)} = N^{(0)}$  in [\(1.4\)](#page-1-0) leads to the following bidirectional single non-local wave equation

$$
h_{tt} + \mathcal{L}h = (hh_x + [\mathcal{L}, \mathcal{N}h]h)_x - 2(hh_t)_x.
$$
\n(1.5)

The formal reduction of  $(1.5)$  to the corresponding unidirectional version, cf. [\[11\]](#page-9-6), yields

h_t + \frac{3}{2}hh_x = \frac{1}{2}([\mathcal{L}, \mathcal{N}h]h + \mathcal{N}h + h_x),
$$

where

$$
\mathcal{L} = -\partial_x^2 (1 - \partial_x^2)^{-1}, \quad \mathcal{N} = \partial_x (1 - \partial_x^2)^{-1}
$$

and  $[\mathcal{L}, \cdot]$  denotes the following commutator

Denote by L the operator  $(1 - \partial_x^2)^{-1}$  which acting on functions  $f \in L^2(\mathbb{R})$  has the representation

$$
Lf(x) = G * f(x) = \int_{\mathbb{R}} G(x - y) f(y) dy
$$
,  $G(x) = \frac{1}{2} e^{-|x|}$ ,

a simple computation, for all  $f \in L^2$ , we have

$$
\partial_x^2 Lf(x) = (L - I)f(x),
$$

where I denotes the identity operator. Note that  $-\mathcal{L} = L - 1$ , then Eq.[\(1.6\)](#page-1-2) can be rewritten as

$$
h_t + \frac{3}{2}hh_x = \frac{1}{2}Lh_x + \frac{1}{2}h_x - \frac{1}{2}[L, Lh_x]h.
$$
 (1.7)

 $Eq.(1.7)$  $Eq.(1.7)$  possesses the following conservation properties

\int_{\mathbb{R}} h(t,x)dx = \int_{\mathbb{R}} h_0(x)dx
$$

and

$$
\int_{\mathbb{R}} h^2(t,x)dx = \int_{\mathbb{R}} h_0^2(x)dx.
$$

Note that the unidirectional non-local wave model [\(1.7\)](#page-2-0) is very similar to the celebrated Fornberg-Whitham equation

u_t + \frac{3}{2}uu_x = Lu_x, \t\t(1.8)
$$

which was derived by Whitham [\[12](#page-9-7)] and Fornberg and Whitham [\[13\]](#page-9-8), as a model for shallow water waves describing breaking waves. Recently, some properties of FW equation [\(1.8\)](#page-2-1) such as well-posedness, continuity, traveling waves and blow-up have been studied in [\[14](#page-10-2)[–21\]](#page-10-3). The main difference between the unidirectional non-local wave model and the FW equation is the emergence of the nonlocal commutator-type term in [\(1.7\)](#page-2-0).

In this paper, we study wave breaking in the unidirectional non-local wave model [\(1.7\)](#page-2-0). By analyzing wave breaking conditions on the extremal functions

M(t) := \sup_{x \in \mathbb{R}} [h_x(t, x)],
$$

and

$$

where both  $M(t)$  and  $m(t)$  satisfy the Riccati-type differential inequalities [\(3.6\)](#page-5-0) and [\(3.7\)](#page-5-1), we show a new sufficient condition on the initial data to exhibit wave breaking which extending wave breaking results in Ref.[\[23](#page-10-0)]. Our wave breaking condition (see Theorem [3.1\)](#page-4-0) is that

$$
\inf_{x \in \mathbb{R}} h_{0,x}(x) < \min\left\{ -\frac{1}{6} \left( 1 + \sqrt{1 + 24C_0} \right), -\frac{1}{12} \left( 1 + \sqrt{1 + 24 \left( \sup_{x \in \mathbb{R}} h_{0,x}(x) + 4C_0 \right)} \right) \right\},\tag{1.9}
$$

where  $C_0$  is some positive constant depends on  $||h_0||_{L^2}$ . The wave breaking condition in [\[23](#page-10-0)] is that

$$
\inf_{x \in \mathbb{R}} h_{0,x}(x) \le -C_1,\tag{1.10}
$$

where  $C_1$  is some positive constant depends on  $||h_0||_{L^2}$  and  $||h_0||_{L^{\infty}}$ . Comparing wave breaking condition [\(1.9\)](#page-2-2) and condition [\(1.10\)](#page-3-0), it is clear that the wave breaking condition [\(1.10\)](#page-3-0) in [\[23](#page-10-0)] follows from our wave breaking condition [\(1.9\)](#page-2-2). Moreover, for the first time, we get the estimates of life span and wave breaking rate to the unidirectional non-local wave model [\(1.7\)](#page-2-0).

The remainder of this paper is organized as follows. In Section [2,](#page-3-1) we recall several useful results which are crucial in deriving wave breaking. In Section [3,](#page-4-1) we present a new wave breaking result and wave breaking rate.

#### <span id="page-3-1"></span>2 Preliminaries

In this section, we recall several useful results which are crucial in deriving wave breaking.

First of all, we recall the local well-posedness for Eq.[\(1.7\)](#page-2-0).

<span id="page-3-2"></span>**Lemma 2.1** ([\[23\]](#page-10-0)). Let  $h_0 \in H^s(\mathbb{R})$  with  $s > 3/2$ , then there exists maximal existence time  $T > 0$  and a unique local solution  $h \in C([0, T), H^s(\mathbb{R}))$  of  $(1.7)$ .

The blow-up criteria for Eq.[\(1.7\)](#page-2-0) can be formulated as follows.

**Lemma 2.2** ([\[23\]](#page-10-0)). Let  $h_0 \in H^s(\mathbb{R})$  with  $s > 3/2$ , and let maximal existence time  $T > 0$  be the lifespan associated to the solution h to [\(1.7\)](#page-2-0) with  $h(0, x) = h_0(x)$ . Then  $h(t, x)$  blows up in finite time T if and only if

$$
\int_0^T \|h_x(\tau)\|_{BMO} d\tau = \infty.
$$

Next, the following lemma shows that for the maximal time of existence  $T > 0$ , the solutions remains bounded.

<span id="page-3-3"></span>**Lemma 2.3** ([\[23](#page-10-0)]). Let  $h_0 \in H^s(\mathbb{R})$  with  $s > 3/2$ , and let  $T > 0$  be the maximal time of existence of the unique solution  $h$  of  $(1.7)$  given by Lemma [2.1.](#page-3-2) Then

$$
\sup_{t\in[0,T)}\|h(t)\|_{L^{\infty}(\mathbb{R})}<\infty.
$$

Finally, the following classical lemma is key to construct a system of the Riccatitype differential inequalities involving the extremal slopes of flows.

**Lemma 2.4** ([\[24](#page-10-4)]). Let  $T > 0$  and  $u \in C^1([0, T]; H^2)$ . Then for every  $t \in [0, T)$  there exist at least one point  $\xi(t) \in \mathbb{R}$  with

$$
m(t) := \inf_{x \in \mathbb{R}} [h_x(t, x)] = h_x(t, \xi(t)),
$$

and the function m is almost everywhere differentiable on  $(0, T)$  with

$$
\frac{dm(t)}{dt} = h_{tx}(t, \xi(t)), \ a.e. \ on \ (0, T).
$$

**Remark.** The same statement is valid clearly for the supremum function  $M(t) :=$  $\sup[h_x(t,x)].$  $x\in\mathbb{\bar{R}}$ 

### <span id="page-4-1"></span>3 Wave breaking

In this section, we present a new wave breaking result and wave breaking rate. The main result is as follows.

<span id="page-4-0"></span>**Theorem 3.1.** Let  $h_0 \in H^s(\mathbb{R})$  with  $s > 3/2$ , and the maximal existence time  $T > 0$ be the lifespan associated to the solution h to [\(1.7\)](#page-2-0) with  $h(0, x) = h_0(x)$ . Assume that the initial data  $m_0 = m(0)$  and  $M_0 = M(0)$  satisfy

$$
\inf_{x \in \mathbb{R}} h_{0,x}(x) < \min\left\{ -\frac{1}{6} \left( 1 + \sqrt{1 + 24C_0} \right), -\frac{1}{12} \left( 1 + \sqrt{1 + 24 \left( \sup_{x \in \mathbb{R}} h_{0,x}(x) + 4C_0 \right)} \right) \right\},\tag{3.1}
$$

where  $C_0 = C ||h_0||_{L^2}^2 > 0$ . Then the corresponding solution h breaks down in the finite time T with

$$
0 < T \le t^* = \frac{2\sqrt{3}(3m_0^2 + \frac{1}{2}m_0 - 2C_0)}{3(3m_0^2 + m_0 - 2C_0)\sqrt{3m_0^2 - \frac{1}{2}M_0 + \frac{1}{2}m_0 - 2C_0}}.
$$

Moreover, for some  $x(t) \in \mathbb{R}$ , the blow-up rate is

$$
h_x(t, x(t)) \sim -\frac{2}{3(T-t)} \quad as \quad t \to T. \tag{3.2}
$$

**Remark.** The wave-breaking time  $t^*$  in Theorem [3.1](#page-4-0) could be optimized by more delicate estimate, which can be obtained from replacing  $m^2(t) = -\frac{2}{3}$  $\frac{2}{3}\varphi(t) + \frac{1}{6}(M$  $m$ ) +  $\frac{2}{3}C_0 \geq -\frac{2}{3}\varphi(t)$  by  $m^2(t) \geq -\frac{2}{3}\varphi(t) - \frac{1}{6}m_0 + \frac{2}{3}C_0$ . By investigating the proof in Theorem [3.1,](#page-4-0) we are able to obtain a better estimate of upper bound on wave-breaking time by

$$
t^* = \frac{\sqrt{3}(3m_0^2 + \frac{1}{2}m_0 - 2C_0)}{3\sqrt{2C_0 - \frac{1}{2}m_0}(3m_0^2 + m_0 - 2C_0)} \ln \frac{\sqrt{6m_0^2 - M_0} + \sqrt{4C_0 - m_0}}{\sqrt{6m_0^2 - M_0} - \sqrt{4C_0 - m_0}}.
$$

Proof. Let

$$
M(t) = \sup_{x \in \mathbb{R}} h_x(t, x) = h_x(t, \xi_1(t))
$$

and

<span id="page-5-4"></span>
$$
m(t) = \inf_{x \in \mathbb{R}} h_x(t, x) = h_x(t, \xi_2(t)).
$$

Differentiating  $(1.7)$  with respect to x yields

$$
h_{tx} = -\frac{1}{2}(3h_x^2 + 3hh_{xx} + \partial_x[L, Lh_x]h + L_xh_x - h_{xx}).
$$
\n(3.3)

Note that the Sobolev embedding  $H^{\frac{1}{2}+\epsilon} \hookrightarrow L^{\infty}$  for  $\epsilon > 0$  and L is continuous between  $H<sup>s</sup>(\mathbb{R})$  and  $H<sup>s+2</sup>(\mathbb{R})$  for any  $s \in \mathbb{R}$ , yields

$$
\left| \partial_x [L, L h_x] h \right| \le ||[L, L h_x] h||_{H^{\frac{1}{2} + \epsilon}} \le ||L h_x h||_{H^{-\frac{3}{2} + \epsilon}} + ||(L h)^2||_{H^{\frac{3}{2} + \epsilon}} \le C ||h||_{L^2}^2 \le C ||h_0||_{L^2}^2 := C_0
$$
\n(3.4)

and by observing

$$
L_x h_x = G_x * h_x = -\frac{1}{2} \int_{-\infty}^x e^{y-x} h_x dy + \frac{1}{2} \int_x^{+\infty} e^{x-y} h_x dy.
$$
 (3.5)

Combining [\(3.4\)](#page-5-2) and [\(3.5\)](#page-5-3), from [\(3.3\)](#page-5-4), it's easy to find that, for a.e.  $t \in (0, T)$ 

<span id="page-5-3"></span><span id="page-5-2"></span><span id="page-5-0"></span>
$$
M'(t) \le -\frac{3}{2}M^2 + \frac{1}{4}(M-m) + C_0,\tag{3.6}
$$

<span id="page-5-1"></span>
$$
m'(t) \le -\frac{3}{2}m^2 + \frac{1}{4}(M-m) + C_0.
$$
\n(3.7)

Now, we adapt the method in [\[25](#page-10-5)] in Theorem [3.1](#page-4-0) to prove our result. Note that the condition  $(3.1)$ , together with  $(3.7)$ , we have

$$
m(0) < -\frac{1}{6} \left( 1 + \sqrt{1 + 24C_0} \right)
$$
 and  $m'(0) \le -\frac{3}{2}m^2(0) + \frac{1}{4} (M(0) - m(0)) + C_0 < 0.$ 

We claim that:

$$
m(t) < -\frac{1}{6} \left( 1 + \sqrt{1 + 24C_0} \right)
$$
 for all  $t \in [0, T)$ .

Otherwise, there exists  $t_0 < T$  such that

$$
m(t_0) = -\frac{1}{6} \left( 1 + \sqrt{1 + 24C_0} \right) \text{ and } m(t) < -\frac{1}{6} \left( 1 + \sqrt{1 + 24C_0} \right) \text{ for all } t \in [0, t_0). \tag{3.8}
$$

Let

$$
\varphi(t) = -\frac{3}{2}m^2 + \frac{1}{4}(M - m) + C_0,
$$

then from [\(3.6\)](#page-5-0) and [\(3.7\)](#page-5-1), a simple computation yields that, for a.e.  $t \in [0, t_0)$ 

$$
\varphi'(t) = -3mm' + \frac{1}{4}(M' - m')
$$
  
=  $-\frac{1}{4}(12m + 1)m' + \frac{1}{4}M'$   
 $\le -\frac{1}{4}(12m + 1)\left(-\frac{3}{2}m^2 + \frac{1}{4}(M - m) + C_0\right) + \frac{1}{4}\left(-\frac{3}{2}M^2 + \frac{1}{4}(M - m) + C_0\right)$   
=  $\frac{3}{2}m(3m^2 + m - 2C_0) - \frac{3}{8}(M + m)^2$   
< 0.

Taking into account the fact  $\varphi(0) < 0$ , it follows from the decreasing of  $\varphi(t)$  that

$$
\varphi(t) \le \varphi(0) < 0 \quad \text{for a.e. } t \in [0, t_0).
$$

Thus, we have

$$
m'(t) \le \varphi(t) < 0 \quad \text{for a.e. } t \in [0, t_0),
$$

which means that

$$
m(t_0) \le m(0) < -\frac{1}{6} \left( 1 + \sqrt{1 + 24C_0} \right).
$$

This contradicts with [\(3.8\)](#page-6-0). Consequently, we obtain

$$
m(t) < -\frac{1}{6} \left( 1 + \sqrt{1 + 24C_0} \right), \quad \varphi(t) \le \varphi(0) < 0, \quad \text{ for all } t \in [0, T), \tag{3.9}
$$

and

<span id="page-6-2"></span>
$$
m'(t) < 0
$$
 for a.e.  $t \in [0, T)$ . (3.10)

On the other hand, in view of [\(3.9\)](#page-6-1) and [\(3.10\)](#page-6-2), the definition of  $\varphi(t)$  implies that

$$
m^{2}(t) = -\frac{2}{3}\varphi(t) + \frac{1}{6}(M-m) + \frac{2}{3}C_{0} \ge -\frac{2}{3}\varphi(t) > 0,
$$

which shows us

<span id="page-6-3"></span>
$$
-m(t) \ge \sqrt{-\frac{2}{3}\varphi(t)}.\tag{3.11}
$$

Conclusively, from the above discussion and [\(3.9\)](#page-6-1), for a.e.  $t \in [0, T)$ 

$$
\varphi'(t) \le \frac{3}{2}m(3m^2 + m - 2C_0)
$$
  
\n
$$
\le -\sqrt{6}\frac{3m^2 + m - 2C_0}{3m^2 - \frac{1}{2}M + \frac{1}{2}m - 2C_0}(-\varphi)^{\frac{3}{2}}(t)
$$
  
\n
$$
\le -\sqrt{6}\frac{3m^2 + m - 2C_0}{3m^2 + \frac{1}{2}m - 2C_0}(-\varphi)^{\frac{3}{2}}(t).
$$

A straightforward computation yields

$$
\left(\frac{3m^2 + m - 2C_0}{3m^2 + \frac{1}{2}m - 2C_0}\right)' = \left(\frac{\frac{1}{2}m}{3m^2 + \frac{1}{2}m - 2C_0}\right)'
$$

$$
= \frac{m'(-\frac{3}{2}m^2 - C_0)}{\left(3m^2 + \frac{1}{2}m - 2C_0\right)^2} > 0.
$$

Hence, we have

$$
\varphi'(t) \le -\sqrt{6} \frac{3m_0^2 + m_0 - 2C_0}{3m_0^2 + \frac{1}{2}m_0 - 2C_0} (-\varphi)^{\frac{3}{2}}(t) \quad \text{for a.e. } t \in [0, T).
$$

Denote

$$
\delta = \sqrt{6} \frac{3m_0^2 + m_0 - 2C_0}{3m_0^2 + \frac{1}{2}m_0 - 2C_0}.
$$

Apparently,  $\delta > 0$  and

$$
\left( (-\varphi)^{-\frac{1}{2}}(t) \right)' = \frac{1}{2} (-\varphi)^{-\frac{3}{2}}(t) \varphi'(t) \le -\frac{\delta}{2}.
$$
\n(3.12)

Integrating  $(3.12)$  from 0 to t yields

<span id="page-7-1"></span>
$$
-\varphi(t) \ge \left( (-\varphi)^{-\frac{1}{2}}(0) - \frac{\delta}{2}t \right)^{-2}.
$$
\n(3.13)

Since  $-\varphi(t) > 0$  for any  $t \geq 0$ , then  $\varphi(t)$  and  $m(t)$  break down at the finite time

$$
T \le t^* := \frac{2}{\delta(-\varphi)^{\frac{1}{2}}(0)} = \frac{2\sqrt{3}(3m_0^2 + \frac{1}{2}m_0 - 2C_0)}{3(3m_0^2 + m_0 - 2C_0)\sqrt{3m_0^2 - \frac{1}{2}M_0 + \frac{1}{2}m_0 - 2C_0}}.
$$

In the case of  $T_0 = t^*$ , in view of [\(3.11\)](#page-6-3) and [\(3.13\)](#page-7-1), we have

$$
m(t) \le -\sqrt{-\frac{2}{3}\varphi(t)} \le -\frac{1}{\sqrt{\frac{3}{8}}\delta(t^*-t)},
$$

which implies that  $m(t) \to -\infty$  as  $t \to T$ .

Now, let us give more insight into the wave breaking mechanism to Eq. [\(1.7\)](#page-2-0). Assume that the corresponding solution h breaks in finite time  $T < \infty$  for some  $\xi_2(t) \in \mathbb{R}$ , then from Lemma [2.3,](#page-3-3) we have

$$
m(t) = h_x(t, \xi_2(t)) \to -\infty \quad \text{as } t \nearrow T \quad \text{and} \quad \sup_{t \in [0,T)} |h(t, \xi_2(t))| < \infty. \tag{3.14}
$$

Then it follows from  $(3.3)$  that, for a.e.  $t \in [0, T)$ 

<span id="page-8-0"></span>
$$
m'(t) = -\frac{3}{2}m^2(t) - \frac{1}{2}\partial_x[L, Lh_x]h(t, x(t)) - \frac{1}{2}L_xh_x(t, x(t)).
$$
\n(3.15)

Note that

$$
|L_x h_x| = |Lh - h| \le ||G * h||_{L^{\infty}} + ||h||_{L^{\infty}}
$$
  
\n
$$
\le ||G||_{L^2} ||h||_{L^2} + ||h||_{L^{\infty}}
$$
  
\n
$$
= \frac{1}{2} ||h||_{L^2} + ||h||_{L^{\infty}}
$$
  
\n
$$
= \frac{1}{2} ||h_0||_{L^2} + ||h||_{L^{\infty}}.
$$
\n(3.16)

Combing [\(3.15\)](#page-8-0), [\(3.4\)](#page-5-2) and [\(3.16\)](#page-8-1) leads to

$$
-\frac{C_0}{2} - \frac{1}{4} \|h_0\|_{L^2} - \frac{1}{2} \|h\|_{L^\infty} - \frac{3}{2} m^2(t) \le m'(t) \le -\frac{3}{2} m^2(t) + \frac{1}{2} \|h\|_{L^\infty} + \frac{1}{4} \|h_0\|_{L^2} + \frac{C_0}{2}.
$$
\n(3.17)

For small  $\varepsilon > 0$ , from [\(3.14\)](#page-8-2) we can find  $t_0 \in (0, T)$  such that  $t_0$  is close enough to  $T$  in a such way that

<span id="page-8-3"></span><span id="page-8-1"></span>
$$
\left| \frac{\frac{1}{2} ||h||_{L^{\infty}} + \frac{1}{4} ||h_0||_{L^2} + \frac{C_0}{2}}{m^2(t)} \right| < \varepsilon
$$

on  $(t_0, T)$ . Therefore, on such interval, one can infer from [\(3.17\)](#page-8-3) that, for a.e.  $t \in (t_0, T)$ 

$$
-\frac{3}{2} - \varepsilon \le -\frac{d}{dt}\left(\frac{1}{m}\right) \le -\frac{3}{2} + \varepsilon.
$$

Integrating the above inequalities on  $(t, T)$  with  $t \in (t_0, T)$ , we derive the blow-up rate (3.2) with  $x(t) = \xi_2(t)$ . Thus, the proof of the Theorem 3.1 is complete. [\(3.2\)](#page-4-3) with  $x(t) = \xi_2(t)$ . Thus, the proof of the Theorem [3.1](#page-4-2) is complete.
