# OBSERVABILITY INEQUALITY FROM MEASURABLE SETS AND THE STACKELBERG-NASH GAME PROBLEM FOR DEGENERATE PARABOLIC EQUATIONS

#### Abstract

In this study, we employ the established Carleman estimates and propagation estimates of smallness from measurable sets for real analytic functions, along with the telescoping series method, to establish an observability inequality for the degenerate parabolic equation over measurable subsets in the time-space domain. As a direct application, we formulate a captivating Stackelberg-Nash game problem and provide a proof of the existence of its equilibrium. Additionally, we characterize the set of Stackelberg-Nash equilibria and delve into the analysis of a norm optimal control problem.


## 1. Introduction

Observability inequality is a powerful and significant tool for investigating stability and controllability problems in evolution equations. The degenerate parabolic equation, which is a common class of diffusion equations, can describe numerous physical phenomena, such as laminar flow, large ice blocks, solar radiation-climate interactions, and population genetics (for more detailed descriptions, refer to [13]). As a result, the control problems for such equations have gained considerable attention, with studies on controllability and observability problems for some degenerate parabolic equations in [13] and its extensive references. In [11], the authors derived the observability inequality for a kind of degenerate parabolic problems, where the control acts on an open sets, by Carleman estimates based on the choice of suitable weighted functions and Hardy-type inequalities. In [23], the author considered non-smooth general degenerate parabolic equations in non-divergence form with the control acts on an open sets and with degeneracy and singularity occurring in the interior of the spatial domain, in presence of Dirichlet or Neumann boundary conditions. In particular, they obtained the observability inequality for the associated adjoint problem by Carleman estimates. In [8], the authors considered a parabolic problem with degeneracy in the interior of the spatial domain and Neumann boundary conditions with the control acts on an open sets. In particular, they focused on the well-posedness of the problem and on Carleman estimates for the associated adjoint problem. As a consequence, new observability inequalities were established. For other controllability issues related to degenerate parabolic equations, see $[10,14,17,22]$ and references therein.

It is worth noting that the current researches on observability inequalities for degenerate parabolic equations have primarily focused on control exerted on open sets, with little existing results considering control exerted on measurable sets. The reason for these

[^0]is that in the above works, the main technique used in the arguments, Carleman inequalities, requires to construct suitable Carleman weights: a role for functions which requires smoothness and to have the extreme values in proper regions associated to the control region. The construction of such functions seems to be not possible, when the control region does not an open set. In [29], The authors employed the available Carleman estimates, propagation estimates of smallness from measurable sets for real analytic functions, and the telescoping series method to establish an observability inequality from measurable subsets in the time-space variable for the degenerate parabolic equation with the Grushin operator in certain multidimensional domains. On the contrary, for nondegenerate parabolic equations, there have been extensive findings pertaining to control exerted on measurable sets. The authors in $[3,31]$ establish the observability inequality of the heat equation for the measurable subsets, and show the null controllability with controls restricted over these sets. In [19], the authors found new quantitative estimates on the space-time analyticity of solutions to linear parabolic evolutions with time-independent analytic coefficients and applied them to obtain observability inequalities for its solutions over measurable sets.

The current paper represents an advancement in the study of observability inequality for measurable subsets within the context of degenerate parabolic equations. However, unlike the approach discussed earlier, which relied on Carleman estimates, this paper builds upon the conventional observability inequality established in [11] and [9] for open subsets. Notably, it is currently not feasible to derive an observability inequality for degenerate parabolic equations from measurable subsets using the Carleman estimates method. Nevertheless, we have made an intriguing observation: When the observation domain is sufficiently distant from the singularity, we can derive an observability inequality with a constant term on the right-hand side, expressed as $e^{\frac{C}{T^{k}}}$, where $C$ and $k$ are positive parameters, and the solution is real analytic. By employing a telescoping series argument, we are able to obtain the desired result. This novel approach provides fresh insights into the controllability of degenerate parabolic equations, offering alternative perspectives beyond the sole reliance on Carleman estimates.

As an important application, we consider a game problem for degenerate parabolic equations. Differential games were introduced originally by Isaacs (see [26]). Since then, lots of researchers were attracted to establish and improve the related theory. Meanwhile, the theory was applied to a large number of fields. For a comprehensive survey on the differential game theory, we refer to $[7,18,20,24]$ and the references therein. The famous game problem, Stackelberg-Nash game problem, is an interesting question in the framework of mathematical finance. For instance, it is well known that the price of an European call option is governed by a backward PDE. The independent space variable must be interpreted as the stock price and the time variable is in fact the reverse of time. In this regard, it can be interesting to control the solution of the system with the composed action of several agents, each of them corresponding to a different range of values of the space variable. For further information on the modeling and control of phenomena of this kind, see for instance $[32,36]$. For more Stackelberg-Nash game problems, we refer the reader to the works in [16, 25]. In this paper, based on the Stackelberg-Nash null controllability, see [4-6], we will focus on the characterizations of the set of Stackelberg-Nash equilibria and a norm optimal control problem. To the best of our knowledge, this paper is the first attempt to obtain the existence of the Stackelberg-Nash equilibria by the Kakutani type fixed point theorems for degenerate parabolic equations. Furthermore, we characterize the sets of Stackelberg-Nash equilibria and consider a norm optimal control problem. After that, we can mention [35], which seems the first time to apply the Kakutani type fixed point theorems to the game problems for heat equations.

The remaining sections of this paper are organized as follows. In Section 2, we present the formulation of the main problems and state the key results: Theorem 2.1, Theorem
2.2, Theorem 2.3, and Theorem 2.7. The proof of Theorem 2.1 is provided in Section 3. In Section 4, we delve into the discussion of a forthcoming Stackelberg-Nash game problem (to be formulated later) and provide the proofs for Theorem 2.2 and Theorem 2.3. These findings are instrumental in the subsequent discussion of a norm optimal control problem (to be formulated later) and the proof of Theorem 2.7 in Section 5.

## 2. Problems formulation and main results

In this section, we will outline the principal issues investigated and present the pivotal findings of this manuscript. Firstly, let us introduce necessary notations.

Let $T>0$ be a fixed positive time constant, and $I:=(0,1)$. Throughout this paper, we denote by $\langle\cdot, \cdot\rangle$ the scalar product in $L^{2}(I)$ and denote by $\|\cdot\|$ the norm induced by $\langle\cdot, \cdot\rangle$. We denote by $|\cdot|$ the Lebesgue measure on $\mathbb{R}$.

Let $A$ be an unbounded linear operator on $L^{2}(I)$ :

endowed with the norms

The system, that we consider in this paper, is described by the following degenerate equation:

where initial state $y_{0} \in L^{2}(I), y$ is the state variable. By [11], one can check that for all $y_{0} \in L^{2}(I)$, system (2.2) admit a unique solution $y$ in the space $C\left([0, T] ; L^{2}(I)\right) \cap$ $L^{2}\left(0, T ; H_{\alpha}^{1}(I)\right)$.

The main result of this paper is the following observability inequality for the degenerate parabolic equation (2.2):

Theorem 2.1. Let $T>0, \alpha \in(0,2)$. Let $\mu \in(0,1)$ be defined as

and $D \subset I \times(0, T)$ be a measurable subset with positive measures. Then there exists a constant $C=C(T, I, \alpha, D, \mu) \geq 1$ such that the solution of equation (2.2) satisfies the following observability inequality: for any $y_{0} \in L^{2}(I)$,

As an important application of Theorem 2.1, we consider the following degenerate problem with three controls (one leader and two followers), but very similar considerations
hold for other systems (degenerated cases or non-degenerated cases) with a higher number of controls.

where $A$ defined in (2.1), $\omega, \omega_{1}, \omega_{2}$ are measurable subsets of $(0,1)$ with positive measures. $\omega$ is the main (leader) control domain and $\omega_{1}, \omega_{2}$ are the secondary (followers) control domains. The controls $g, u_{1}, u_{2} \in L^{\infty}\left(0, T ; L^{2}(0,1)\right)$, where $g$ is the main (leader) control and $u_{1}$ and $u_{2}$ are the secondary (followers) controls. Initial state is $y_{0} \in L^{2}(0,1)$. The solution of system (2.5) denote by $y\left(\cdot ; y_{0}, g, u_{1}, u_{2}\right)$.

We define the following admissible sets of controls:

where $M_{0}, M_{1}, M_{2}$ are positive constants. Meanwhile, we introduce the following two functionals: For each $i=1,2$, the functional $J_{i}:\left(L^{\infty}\left(0, T ; L^{2}(0,1)\right)\right)^{2} \rightarrow[0,+\infty)$ is defined by

where $G_{i} \subset(0,1)(i=1,2)$ be measurable subsets such that $\omega_{i} \subset G_{i}$ representing observation domains for the followers and $y_{T}^{i} \in L^{2}(0,1)$ and

The mathematical models for the control problems are:

1. The followers $u_{1}$ and $u_{2}$ assume that the leader $g$ has made a choice and intend to be a Nash equilibrium for the cost functionals $J_{i}\left(u_{1}, u_{2}\right), i=1,2$. Thus, once the leader $g$ has been fixed:
(P1) Does there exist $\left(u_{1}^{*}, u_{2}^{*}\right) \in \mathcal{U}_{1} \times \mathcal{U}_{2}$ with respect to $g$ so that

We call the problem (P1) as a Stackelberg-Nash game problem. It is a noncooperative game problem of the followers. If the answer to the problem ( P 1 ) is yes, we call $\left(u_{1}^{*}, u_{2}^{*}\right)$ a Stackelberg-Nash equilibrium (or an optimal strategy pair, or an optimal control pair) of (P1). We can understand the problem (P1) in the following manner: There are two followers executing their strategies and hoping to achieve their goals $y_{T}^{1}$ and $y_{T}^{2}$, respectively. If the first follower chooses the strategy $u_{1}^{*}$, then the second follower can execute the strategy $u_{2}^{*}$ so that $y\left(T ; y_{0}, g, u_{1}^{*}, u_{2}^{*}\right)$ is closer to $y_{T}^{2}$; Conversely, if the second follower chooses the strategy $u_{2}^{*}$, then the first follower can execute the strategy $u_{1}^{*}$ so that $y\left(T ; y_{0}, g, u_{1}^{*}, u_{2}^{*}\right)$ is closer to $y_{T}^{1}$. Roughly speaking, if one follower is deviating from $\left(u_{1}^{*}, u_{2}^{*}\right)$, then the cost functional of this follower would get larger; and there is no information given if both followers are deviating from the Nash equilibrium $\left(u_{1}^{*}, u_{2}^{*}\right)$. From the knowledge of game theory, in generally, Nash equilibrium is not unique.
2. Once the Stackelberg-Nash equilibrium $\left(u_{1}^{*}, u_{2}^{*}\right)$ has been identified for each leader $g$, denoted by $\left(u_{1}^{*}(g), u_{2}^{*}(g)\right)$, we consider the following norm optimal control problem:
(P2) $\quad N\left(T, y_{0}\right):=\inf _{g \in \mathcal{U}_{0}}\left\{\|g\|_{L^{\infty}\left(0, T ; L^{2}(0,1)\right)}: y\left(T ; y_{0}, g, u_{1}^{*}(g), u_{2}^{*}(g)\right)=0\right\}$.
The first main result of the Stackelberg-Nash game problem (P1) is about the existence of a Stackelberg-Nash equilibrium.

Theorem 2.2. Let $g \in L^{\infty}\left(0, T ; L^{2}(0,1)\right)$ be given. The problem (P1) with respect to the system (2.5) admits a Stackelberg-Nash equilibrium, i.e., there exist at least a pair of $\left(u_{1}^{*}, u_{2}^{*}\right) \in \mathcal{U}_{1} \times \mathcal{U}_{2}$ with respect to $g$ so that (2.8) and (2.9) hold.

The second main result of the Stackelberg-Nash game problem (P1) is the characterizations of the set of Stackelberg-Nash equilibria, which concerned with the following bang-bang property of the Stackelberg-Nash equilibria.

Theorem 2.3. Let $g \in L^{\infty}\left(0, T ; L^{2}(0,1)\right)$ be given and let $\left(u_{1}^{*}, u_{2}^{*}\right) \in \mathcal{U}_{1} \times \mathcal{U}_{2}$ be a Stackelberg-Nash equilibrium of the problem (P1) with respect to $g$. Then either

Remark 2.4. It is noteworthy that in previous studies addressing the Stackelberg-Nash game problem, the scholars have predominantly concentrated on the examination of system controllability, such as exact controllability [4], approximate controllability [16], null controllability [6], and the presence of Stackelberg-Nash equilibrium, while paying no attention to the comprehensive characterization of the set of Stackelberg-Nash equilibrium and their distinctive bang-bang property.

The result of the norm optimal control problem (P2) is concered with the characterization of the leader. To the end, we make some assumptions:
$\left(A_{1}\right) . \omega_{i} \subset \omega \subset(0,1)$ for $i=1,2$.
$\left(A_{2}\right)$. System (2.5) is null controllability, i.e. there exists a control $g \in L^{\infty}\left(0, T ; L^{2}(0,1)\right)$ such that the corresponding solution $y$ of (2.5) satisfies $y\left(T ; y_{0}, g, u_{1}^{*}(g), u_{2}^{*}(g)\right)=$ 0 , in $(0,1)$.

Remark 2.5. The assumption $\left(A_{1}\right)$ is exclusively utilized for the purpose of characterizing the leader $g$, specifically in Theorem 2.7, which will be introduced later. The assumption $\left(A_{2}\right)$ is well-founded, supported by several references, e.g., [4-6] demonstrating the null controllability of system (2.5). Nevertheless, in the present section, our primary emphasis lies in delineating the properties of the leader $g$. Therefore, we have omitted the detailed proof of null controllability of system (2.5), directing interested readers to consult the above references for further exploration.

Let us introduce the following adjoint equation corresponding to (2.2):

where $z\left(\cdot ; z_{T}\right)$ is the solution of system (2.11) with the terminal value $z_{T} \in L^{2}(0,1)$. It is obviously that $X_{T}$ is a linear subspace of $L^{1}\left(0, T ; L^{2}(0,1)\right)$. Define

Lemma 2.6. Suppose $\left(A_{2}\right)$ holds. Let $T>0, y_{0} \in L^{2}(0,1)$. Let Stackelberg-Nash equilibria $\left(u_{1}^{*}(g), u_{2}^{*}(g)\right)$ be given with respect to $g$. Then there exists at least one $g^{*} \in$ $L^{\infty}\left(0, T ; L^{2}(0,1)\right)$ such that $N\left(T, y_{0}\right)=\left\|g^{*}\right\|_{L^{\infty}\left(0, T ; L^{2}(0,1)\right)}$.

The main result of the norm optimal control problem (P2) is stated as follows.
Theorem 2.7. Suppose $\left(A_{1}\right)$ and $\left(A_{2}\right)$ hold. Let $y_{0} \in L^{2}(0,1), T>0$. Let $\left(u_{1}^{*}\left(g^{*}\right), u_{2}^{*}\left(g^{*}\right)\right)$ be given with respect to $g^{*}$ in Lemma 2.6 (i.e., $g^{*}$ is the optimal control for the problem (P2)), and

3. The proof of Theorem 2.1

The equation (2.2) will be referred to as the controlled system in our discussion, where the control in the form of $\chi_{\omega} u$ is applied on the right-hand side of the equation. Here, $u \in L^{2}\left(0, T ; L^{2}(I)\right)$ represents a function, and $\omega$ denotes a subset of $I$.

Let us recall an important result that will be used later, see Section 3.4 in [9].
Lemma 3.1. Let $\alpha \in(0,2)$ and $\omega_{0} \subset I$ be an open subset. Let $\mu \in(0,1)$ be defined in (2.3). Then there exists a positive constant $C=C\left(\alpha, \omega_{0}, I, \mu\right)$ such that the solution of (2.2) satisfies the following observability inequality:

Next, we aim to quantify the real analyticity of the solution $y$ of equation (2.2) on the subdomain that is away from the singularity point zero.

Lemma 3.2. Set $\alpha \in(0,2)$. Let $\omega$ be a subdomain of $I$ with $0 \notin \bar{\omega}$. Then there are positive constants $C=C(\alpha, I, \omega) \geq 1$ and $\rho=\rho(\alpha, I, \omega), 0<\rho \leq 1$, such that when $x \in \omega, \forall 0 \leq s<t, a \in \mathbb{N}$ and $\gamma \in \mathbb{N}$, the solution of equation (2.2) satisfies

Proof. We borrow some ideas from [29]. We only need to prove the situation of $s=0$. Let $\left\{e_{k}\right\}_{k \geq 1}$ and $\left\{w_{k}^{2}\right\}_{k \geq 1}$ be respectively the sets of $L^{2}(I)$-normalized eigenfunctions and eigenvalues for $-\frac{\partial}{\partial x}\left(x^{\alpha} \frac{\partial}{\partial x}\right)$ with zero lateral Dirichlet boundary conditions; i.e.,

here, $0<w_{1} \leq w_{2} \leq \cdots \leq w_{k} \leq \cdots$ and $\lim _{k \rightarrow+\infty} w_{k}=+\infty$. Take $y_{0}=\sum_{k \geq 1} a_{k} e_{k}$ with

\end{equation*}
$$

Moreover, together with (3.3), we have

\begin{cases}\partial_{\tau}^{2}\left(\partial_{t}^{\gamma} y\right)+\frac{\partial}{\partial x}\left(x^{\alpha} \frac{\partial}{\partial x}\left(\partial_{t}^{\gamma} y\right)\right)=0, & \text { in } I \times \mathbb{R}  \tag{3.6}\\ \partial_{t}^{\gamma} y=B C_{\alpha}\left(\partial_{t}^{\gamma} y\right)=0, & \text { on } \partial I \times \mathbb{R}\end{cases}
$$

Because $0 \notin \bar{\omega}$, without loss of generality (otherwise use of a finite covering argument), we can assume that there exists $R \leq \frac{1}{8}, x_{0} \in \omega$ such that

By the last equality of (3.7), it shows the function $x^{\alpha}$ is real analytic and non-degenerate in $D_{2 R}\left(x_{0}, 0\right) \subset I \times \mathbb{R}$. By the real analytic estimates of solutions to linear elliptic equations with real analytic coefficients (cf. for instance, [2], Chapter 3 in [27], and Chapter 5 in [30]), we have that there are constants $C=C(R, \alpha) \geq 1$ and $\rho=\rho(R, \alpha) \in(0,1)$ such that any solutions to equation (3.6) satisfies,

By the orthogonality of $\left\{e_{k}\right\}_{k \geq 1}$ in $L^{2}(I)$, and (3.5), we have

& =\sum_{k \geq 1} a_{k}^{2} w_{k}^{4 \gamma} e^{-w_{k}^{2} t} e^{-w_{k}^{2} t+2 w_{k} \tau} \\
& \leq \max _{k \geq 1}\left\{w_{k}^{4 \gamma} e^{-w_{k}^{2} t}\right\} \max _{k \geq 1}\left\{e^{-w_{k}^{2} t+2 w_{k} \tau}\right\} \sum_{k \geq 1} a_{k}^{2}
\end{aligned}
$$

which, along with (3.9), it implies

\end{equation*}

On one hand, from Stirling's formula, see page 111 in [28], i.e. for a absolute constant $C$, $\gamma^{\gamma} \leq C e^{\gamma}(\gamma)$ !, we have

\end{equation*}

This together with (3.8), it implies

$$

which, along with the first result of (3.7), we have

Hence, the above inequality implies that (3.2) with $s=0$ holds. The proof is completed.

The subsequent two lemmas focus on the propagation of smallness estimates from measurable sets for real analytic functions. This type of observability estimate was initially established in [34] (also refer to [2] and [3] for associated findings). To facilitate subsequent references, one lemma pertains to the one-dimensional scenario, while the other lemma caters to the multidimensional case. For a more streamlined proof, interested readers can refer to Section 3 of [3].

Lemma 3.3. Let $g:[a, a+s] \rightarrow \mathbb{R}$, where $a \in \mathbb{R}$ and $s>0$ be a real analytic function satisfying

where $M>0, \rho \in(0,1]$. Assume that $F \subset[a, a+s]$ is a measurable subset of positive measure. Then there are $C=C(\rho,|F| / s)$ and $\theta=\theta(\rho,|F| / s), 0<\theta<1$, such that

\|g\|_{L^{\infty}(a, a+s)} \leq C M^{1-\theta}\left(\frac{1}{|F|} \int_{F}|g(x)| d x\right)^{\theta} .

Lemma 3.4. Let $\omega$ be a bounded domain in $\mathbb{R}^{n}, n \geq 1$ and $\bar{\omega} \subset \omega$ be a measurable set of positive measure. Let $f$ be an analytic function in $\omega$ satisfying

where $M>0, \rho \in(0,1]$. Then there are $C=C(|\omega|, \rho,|\bar{\omega}|)$ and $\theta=\theta(|\omega|, \rho,|\bar{\omega}|), 0<\theta<1$, such that

\|f\|_{L^{\infty}(\omega)} \leq C M^{1-\theta}\left(\int_{\bar{\omega}}|f(x)| d x\right)^{\theta} .
$$

Next, we shall make use of Lemma 3.1 and Lemma 3.2, as well as Lemma 3.3 and Lemma 3.4, to establish an interpolation inequality from measurable sets for any solution $y$ to equation (2.2). For similar results, we refer the reader to [3] or [29].

Theorem 3.5. Let $0 \leq t_{1}<t_{2}<1, \eta \in(0,1), \mu \in(0,1)$ defined in (2.3), $\alpha \in(0,2)$ and $\sigma>0$. Assume that $E \subset\left(t_{1}, t_{2}\right)$ is a measurable subset with $\left|E \cap\left(t_{1}, t_{2}\right)\right| \geq \eta\left(t_{2}-t_{1}\right)$ such that for all $t \in E$, the measurable subset $D_{t} \subset \omega$ stands that $\left|D_{t}\right| \geq \sigma$. Then, there are constants $C=C(I, \omega, \alpha, \eta, \sigma, \mu) \geq 1$ and $\theta=\theta(I, \omega, \alpha, \eta, \sigma, \mu) \in(0,1)$ such that the solution to equation (2.2) satisfies

\left\|y\left(\cdot, t_{2}\right)\right\| \leq\left(\int_{t_{1}}^{t_{2}} \chi_{E}\|y(\cdot, t)\|_{L^{1}\left(D_{t}\right)} d t\right)^{\theta}\left(e^{\left.C\left(t_{2}-t_{1}\right)^{-\frac{\mu}{1-\mu}}\left\|y\left(\cdot, t_{1}\right)\right\|\right)^{1-\theta} . . . .}\right. \tag{3.12}
\end{equation*}

Proof. Define

One can verify that $|F|>\frac{\eta}{2}\left(t_{2}-t_{1}\right)$. This shows that $F \subset\left[\tau, t_{2}\right]$ is a measurable subset of positive measure.

From Lemma 3.2, we have that there are constants $C=C(I, \omega, \alpha, \eta, \sigma) \geq 1$ and $\theta=\theta(I, \omega, \alpha, \eta, \sigma) \in(0,1)$ such that for all $t \in\left[\tau, t_{2}\right]$ and for all $x \in \omega, a \in \mathbb{N}, \gamma \in \mathbb{N}$,

\left|\partial_{x}^{a} \partial_{t}^{\gamma} y(\cdot, t)\right| \leq \frac{e^{\frac{C}{t_{2}-t_{1}}} a!\gamma!}{\rho^{a}\left(\eta\left(t_{2}-t_{1}\right) / 2\right)^{\gamma}}\left\|y\left(\cdot, t_{1}\right)\right\| . \tag{3.13}
\end{equation*}

Now, for simplicity, we write

$\|y\|_{L^{2}\left(\tau, t_{2} ; L^{2}(\omega)\right)} \leq\|y\|_{L^{\infty}\left(\tau, t_{2} ; L^{\infty}(\omega)\right)}^{\frac{1}{2}}\|y\|_{L^{1}\left(\tau, t_{2} ; L^{1}(\omega)\right)}^{\frac{1}{2}} \leq e^{\frac{C}{t_{2}-t_{1}}}\left\|y\left(\cdot, t_{1}\right)\right\|^{\frac{1}{2}}\|y\|_{L^{1}\left(\tau, t_{2} ; L^{1}(\omega)\right)}^{\frac{1}{2}}$,
which along with (3.17), it holds

\left\|y\left(\cdot, t_{2}\right)\right\| & \leq\|y\|_{L^{1}\left(\tau, t_{2} ; L^{1}(\omega)\right)}^{\frac{1}{2}} e^{C\left(t_{2}-\tau\right)^{-\frac{\mu}{1-\mu}}} e^{\frac{C}{t_{2}-t_{1}}}\left\|y\left(\cdot, t_{1}\right)\right\|^{\frac{1}{2}} \\
& \leq\|y\|_{L^{1}\left(\tau, t_{2} ; L^{1}(\omega)\right)}^{\frac{1}{2}}\left(e^{C\left(t_{2}-t_{1}\right)-\frac{\mu}{1-\mu}}\left\|y\left(\cdot, t_{1}\right)\right\|\right)^{\frac{1}{2}} \tag{3.18}
\end{align*}
$$

It follows by (3.16) that for any $t \in F$,

& \leq C M^{1-\theta}\left(\int_{\omega} \int_{F}|y(x, t)| d t d x\right)^{\theta} \tag{3.19}
\end{align*}

Since the measurable subset $D_{t} \subset \omega$ stands that $\left|D_{t}\right| \geq \sigma$, when $t \in F$, we obtain from Lemma 3.4 (with $n=1$ ) that there are constants $C_{1}=C_{1}(\omega, \rho, \sigma) \geq 1$ and $\theta_{1}=$ $\theta_{1}(\omega, \rho, \sigma) \in(0,1)$ such that

& \leq C C_{1} M^{1-\theta \theta_{1}}\left(\int_{F} \int_{D_{t}}|y(x, t)| d x d t\right)^{\theta \theta_{1}}
\end{align*}
$$

Therefore, by (3.18), it implies

\left\|y\left(\cdot, t_{2}\right)\right\| \leq C C_{1} M^{1-\theta \theta_{1}}\left(\int_{F} \int_{D_{t}}|y(x, t)| d x d t\right)^{\theta \theta_{1}}\left(e^{C\left(t_{2}-t_{1}\right)^{-\frac{\mu}{1-\mu}}}\left\|y\left(\cdot, t_{1}\right)\right\|\right)^{\frac{1}{2}}
$$

Set $\theta^{\prime}=\theta \theta_{1} \in(0,1)$ and by (3.14), we obtain the desired estimate (3.12).
By leveraging Fubini's theorem and the property of Lebesgue density points for measurable subsets, along with the interpolation inequality established in Theorem 3.5, a telescoping series can be constructed with respect to any solution $y$ of (2.2). Subsequently, the desired observability inequality from measurable subsets can be derived directly from this telescoping series (also see [3] and [31]). To begin, we quote the following fact from [31], which pertains to the property of Lebesgue density points and represents an improved version of Lemma 2.1.5 in [21].
Lemma 3.6. Let $E \subset(0, T)$ be a measurable subset of positive measure. Assume that $l \in(0, T)$ be a Lebesgue density point of $E$. Then, for each $q \in(0,1)$, there exists $a$ sequence $\left\{\ell_{n}\right\}_{n \geq 1} \subset[0, T]$, which monotone decreasing converges to $l$, such that for any $n \geq 1$,

\ell_{n+1}-\ell_{n+2}=q\left(\ell_{n}-\ell_{n+1}\right) \tag{3.21}

Now, we are prepared to present the proof of Theorem 2.1 by employing the techniques outlined in Theorem 3.5 and Lemma 3.6, in addition to the telescoping series method.

Proof of Theorem 2.1. Firstly, we can make the assumption, without loss of generality, that $T \in(0,1]$ and that there exists a subdomain $\omega \subset I$ such that $0 \notin \bar{\omega}$. (Alternatively, we can select a new measurable subset $\tilde{D} \subset(I \backslash\{0\}) \times\left(T_{1}, T_{2}\right)$ with $0 \leq T_{1}<T_{2} \leq T$ and $T_{2}-T_{1} \leq 1$.) Next, for a.e. $t \in(0, T)$, we slice the space

From the Fubini theorem, we have

which shows $|E| \geq \frac{|D|}{2|\omega|}$, i.e. $E$ is a measurable subset with positive measures. Moreover, we have

\chi_{E}(t) \chi_{D_{t}}(x) \leq \chi_{D}(x, t) \text {, a.e. }(x, t) \in I \times(0, T) . \tag{3.25}
\end{equation*}

Let $l \in(0, T)$ be a Lebesgue density point of $E$. Then for each $q \in(0,1)$, which is to be fixed later, by Lemma 3.6, there exists a monotone decreasing sequence $\left\{\ell_{n}\right\}_{n \geq 1}$ such that (3.21) and (3.22) hold. Moreover,

\lim _{n \rightarrow+\infty} l_{n}=l . \tag{3.26}
\end{equation*}
$$

We can obtain from Theorem 3.5 that there are positive constants $C=C(I, \omega, \alpha, \eta, \sigma, \mu) \geq$ 1 and $\theta=\theta(I, \omega, \alpha, \eta, \sigma, \mu) \in(0,1)$ such that for all $n \geq 1$,

\left\|y\left(\cdot, l_{n}\right)\right\| \leq\left(\int_{l_{n+1}}^{l_{n}} \chi_{E}\|y(\cdot, t)\|_{L^{1}\left(D_{t}\right)} d t\right)^{\theta}\left(e^{C\left(l_{n}-l_{n+1}\right)^{-\frac{\mu}{1-\mu}}}\left\|y\left(\cdot, l_{n+1}\right)\right\|\right)^{1-\theta} \tag{3.27}
\end{equation*}
$$

Using the Young inequality with $\epsilon$, i.e., $a b \leq \epsilon a^{(1-\theta)^{-1}}+\epsilon^{-\frac{1-\theta}{\theta}} b^{\theta^{-1}}$, the above inequality leads to

\left\|y\left(\cdot, l_{n}\right)\right\| \leq \epsilon\left\|y\left(\cdot, l_{n+1}\right)\right\|+\epsilon^{-\frac{1-\theta}{\theta}} e^{C\left(l_{n}-l_{n+1}\right)^{-\frac{\mu}{1-\mu}}} \int_{l_{n+1}}^{l_{n}} \chi_{E}\|y(\cdot, t)\|_{L^{1}\left(D_{t}\right)} d t \tag{3.28}
\end{equation*}
$$

Multiplying the above inequality by $\epsilon^{\frac{1-\theta}{\theta}} e^{-C\left(\ell_{n}-\ell_{n+1}\right)^{-\frac{\mu}{1-\mu}}}$, we have

\begin{aligned}
& \epsilon^{\frac{1-\theta}{\theta}} e^{-C\left(\ell_{n}-\ell_{n+1}\right)^{-\frac{\mu}{1-\mu}}}\left\|y\left(\cdot, l_{n}\right)\right\|-\epsilon^{\frac{1}{\theta}} e^{-C\left(\ell_{n}-\ell_{n+1}\right)^{-\frac{\mu}{1-\mu}}}\left\|y\left(\cdot, l_{n+1}\right)\right\| \\
\leq & \int_{l_{n+1}}^{l_{n}} \chi_{E}\|y(\cdot, t)\|_{L^{1}\left(D_{t}\right)} d t .
\end{aligned}
$$

Choosing $\epsilon=e^{-\theta\left(\ell_{n}-\ell_{n+1}\right)^{-\frac{\mu}{1-\mu}}}$ in the above inequality, we get

& e^{-(C+1-\theta)\left(\ell_{n}-\ell_{n+1}\right)^{-\frac{\mu}{1-\mu}}}\left\|y\left(\cdot, l_{n}\right)\right\|-e^{-(C+1)\left(\ell_{n}-\ell_{n+1}\right)^{-\frac{\mu}{1-\mu}}}\left\|y\left(\cdot, l_{n+1}\right)\right\| \\
\leq & \int_{l_{n+1}}^{l_{n}} \chi_{E}\|y(\cdot, t)\|_{L^{1}\left(D_{t}\right)} d t .
\end{aligned}
$$

Now, fixing $q=\left(\frac{C+1-\theta}{C+1}\right)^{\frac{1-\mu}{\mu}} \in(0,1)$, it follows from (3.21) and the latter inequality that

\leq & \int_{l_{n+1}}^{l_{n}} \chi_{E}\|y(\cdot, t)\|_{L^{1}\left(D_{t}\right)} d t
\end{aligned}
$$

To summarize the inequalities earlier from $n=1$ to $+\infty$ and noting that (3.26), we conclude that

which along with $(3.25)$ and $\|y(\cdot, T)\| \leq C(T)\left\|y\left(\cdot, l_{1}\right)\right\|$, we obtain the desired estimate (2.4). The proof is completed.

## 4. A Stackelberg-Nash game problem

In this section, we shall discuss the Stackelberg-Nash game problem (P1).
4.1. Existence of Stackelberg-Nash equilibrium. In this subsection, we will prove Theorem 2.2. Its proof needs the Kakutani fixed point theorem quoted from [15].
Lemma 4.1. Let $S$ be a nonempty, compact and convex subset of a locally convex Hausdorff space $X$. Let $\Phi: S \mapsto 2^{S}$ (where $2^{S}$ denotes the set consisting of all subsets of $S$ ) be a set-valued function satisfying:
(i) For each $s \in S, \Phi(s)$ is a nonempty and convex subset;
(ii) Graph $\Phi:=\{(s, z): s \in S$ and $z \in \Phi(s)\}$ is closed.

Then the set of fixed points of $\Phi$ is nonempty and compact, where $s^{*} \in S$ is called to be a fixed point of $\Phi$ if $s^{*} \in \Phi\left(s^{*}\right)$.

Now, we are in a position to prove Theorem 2.2.
Proof of Theorem 2.2. We first introduce three set-valued functions $\Phi_{1}: \mathcal{U}_{1} \mapsto 2^{\mathcal{U}_{2}}, \Phi_{2}$ : $\mathcal{U}_{2} \mapsto 2^{\mathcal{U}_{1}}$ and $\Phi: \mathcal{U}_{1} \times \mathcal{U}_{2} \mapsto 2^{\mathcal{U}_{1} \times \mathcal{U}_{2}}$ as follows:

& \Phi_{1} u_{1}:=\left\{u_{2} \in \mathcal{U}_{2}: J_{2}\left(u_{1}, u_{2}\right) \leq J_{2}\left(u_{1}, v_{2}\right) \text { for all } v_{2} \in \mathcal{U}_{2}\right\}, \quad u_{1} \in \mathcal{U}_{1}  \tag{4.1}\\
& \Phi_{2} u_{2}:=\left\{u_{1} \in \mathcal{U}_{1}: J_{1}\left(u_{1}, u_{2}\right) \leq J_{1}\left(v_{1}, u_{2}\right) \text { for all } v_{1} \in \mathcal{U}_{1}\right\}, \quad u_{2} \in \mathcal{U}_{2} \tag{4.2}
\end{align*}
$$

and

$$
\begin{equation*}
\Phi\left(u_{1}, u_{2}\right):=\left\{\left(\widetilde{u}_{1}, \widetilde{u}_{2}\right): \widetilde{u}_{1} \in \Phi_{2} u_{2} \text { and } \widetilde{u}_{2} \in \Phi_{1} u_{1}\right\}, \quad\left(u_{1}, u_{2}\right) \in \mathcal{U}_{1} \times \mathcal{U}_{2} . \tag{4.3}
\end{equation*}
$$

Then we set

X:=\left(L^{\infty}\left(0, T ; L^{2}(0,1)\right)\right)^{2} \text { and } S:=\mathcal{U}_{1} \times \mathcal{U}_{2} .
$$

It is clear that $X$ is a locally convex Hausdorff space. The rest of the proof will be carried out by the following four steps.

Step 1. Show that $S$ is a nonempty, compact and convex subset of $X$.
This fact can be easily checked. We omit the proof here.
Step 2. $\Phi\left(u_{1}, u_{2}\right)$ is nonempty. We prove that $\Phi\left(u_{1}, u_{2}\right)$ is nonempty for each $\left(u_{1}, u_{2}\right) \in$ $S$.

We arbitrarily fix $\left(u_{1}, u_{2}\right) \in S$. According to (4.1)-(4.3), it suffices to show that $\Phi_{1} u_{1}$ and $\Phi_{2} u_{2}$ are nonempty. For this purpose, we introduce the following auxiliary optimal control problem:

On one hand, since $\left\|v_{2, n}\right\|_{L^{\infty}\left(0, T ; L^{2}(0,1)\right)} \leq M_{2}$, there exists a subsequence of $\left\{v_{2, n}\right\}_{n \geq 1}$, still denoted by itself, and $v_{2,0} \in \mathcal{U}_{2}$, so that

We denote by $\bar{y}_{n}(\cdot):=y\left(\cdot ; y_{0}, g, u_{1}, v_{2, n}\right)-y\left(\cdot ; y_{0}, g, u_{1}, v_{2,0}\right)$. According to (2.5), it is clear that

\begin{cases}\bar{y}_{n, t}(x, t)=A \bar{y}_{n}(x, t)+\chi_{\omega_{2}}\left(v_{2, n}-v_{2,0}\right), & (x, t) \in(0,1) \times(0, T),  \tag{4.7}\\ \bar{y}_{n}(1, t)=B C_{\alpha}\left(\bar{y}_{n}(\cdot, t)\right)=0, & t \in(0, T), \\ \bar{y}_{n}(x, 0)=0, & x \in(0,1) .\end{cases}
$$

Multiplying the first equation of (4.7) by $\bar{y}_{n}$ and integrating over $(0,1)$, one deduces, for all $t \leq T$,

\end{equation*}

From these, we obtain

\sup _{t \in[0, T]}\left\|\bar{y}_{n}(t)\right\|^{2}+\left\|x^{\frac{\alpha}{2}} \bar{y}_{n, x}\right\|_{L^{2}\left(0, T ; L^{2}(0,1)\right)}^{2} \leq C\left\|v_{2, n}-v_{2,0}\right\|_{L^{2}\left(0, T ; L^{2}\left(\omega_{2}\right)\right)}^{2} \tag{4.11}
\end{equation*}
$$

where $C=C(T)$ independent of $n$.
It follows from (4.6) and (4.11) that there exists a subsequence of $\bar{y}_{n}$, still denoted by itself, and $\bar{y} \in C\left([0, T] ; L^{2}(0,1)\right) \cap L^{2}\left(0, T ; H_{\alpha}^{1}(0,1)\right)$ such that

Since the embedding $H_{\alpha}^{1}(0,1) \hookrightarrow L^{2}(0,1)$ is compact, see [33], also see section 6 in [1], it implies that

Passing to the limit for $n \rightarrow \infty$ in (4.7), by (4.6) and (4.12), we have

from which we obtain that $\bar{y}=0$. Hence, on the other hand, we have

Noting that $v_{2,0} \in \mathcal{U}_{2}$, by (4.4), (4.15) and (4.1), we obtain that $v_{2,0} \in \Phi_{1} u_{1}$. This implies that $\Phi_{1} u_{1} \neq \emptyset$. In the same way, we also have that $\Phi_{2} u_{2} \neq \emptyset$.

Step 3. Convex subset $\Phi\left(u_{1}, u_{2}\right)$. We show that $\Phi\left(u_{1}, u_{2}\right)$ is a convex subset of $\mathcal{U}_{1} \times \mathcal{U}_{2}$ for each $\left(u_{1}, u_{2}\right) \in \mathcal{U}_{1} \times \mathcal{U}_{2}$.

We arbitrarily fix $\left(u_{1}, u_{2}\right) \in \mathcal{U}_{1} \times \mathcal{U}_{2}$. According to (4.1)-(4.3), it suffices to prove that $\Phi_{1} u_{1}$ is a convex subset of $\mathcal{U}_{2}$. The convexity of $\Phi_{2} u_{2}$ can be similarly proved. For this purpose, we arbitrarily fix $\widetilde{u}_{2}, \widehat{u}_{2} \in \Phi_{1} u_{1}$. By (4.1), we get that

and

J_{2}\left(u_{1}, \widetilde{u}_{2}\right) \leq J_{2}\left(u_{1}, v_{2}\right) \text { and } J_{2}\left(u_{1}, \widehat{u}_{2}\right) \leq J_{2}\left(u_{1}, v_{2}\right) \text { for each } v_{2} \in \mathcal{U}_{2} \tag{4.17}
\end{equation*}
$$

For any $\lambda \in[0,1]$, by (2.6) and (2.5), we have that

$$
\begin{aligned}
& J_{2}\left(u_{1}, \lambda \widetilde{u}_{2}+(1-\lambda) \widehat{u}_{2}\right)-\left[\lambda J_{2}\left(u_{1}, \widetilde{u}_{2}\right)+(1-\lambda) J_{2}\left(u_{1}, \widehat{u}_{2}\right)\right] \\
= & \left\|y\left(T ; y_{0}, u_{1}, \lambda \widetilde{u}_{2}+(1-\lambda) \widehat{u}_{2}\right)-y_{T}^{2}\right\|_{L^{2}\left(G_{2}\right)}-\lambda\left\|y\left(T ; y_{0}, u_{1}, \widetilde{u}_{2}\right)-y_{T}^{2}\right\|_{L^{2}\left(G_{2}\right)} \\
& -(1-\lambda)\left\|y\left(T ; y_{0}, u_{1}, \widehat{u}_{2}\right)-y_{T}^{2}\right\|_{L^{2}\left(G_{2}\right)} \\
= & \left\|\lambda\left[y\left(T ; y_{0}, u_{1}, \widetilde{u}_{2}\right)-y_{T}^{2}\right]+(1-\lambda)\left[y\left(T ; y_{0}, u_{1}, \widehat{u}_{2}\right)-y_{T}^{2}\right]\right\|_{L^{2}\left(G_{2}\right)} \\
& -\lambda\left\|y\left(T ; y_{0}, u_{1}, \widetilde{u}_{2}\right)-y_{T}^{2}\right\|_{L^{2}\left(G_{2}\right)}-(1-\lambda)\left\|y\left(T ; y_{0}, u_{1}, \widehat{u}_{2}\right)-y_{T}^{2}\right\|_{L^{2}\left(G_{2}\right)} \\
\leq & 0 .
\end{aligned}
$$

This, along with (4.16) and (4.17), yields that

and

which indicate that $\lambda \widetilde{u}_{2}+(1-\lambda) \widehat{u}_{2} \in \Phi_{1} u_{1}$ (see (4.1)). Hence, $\Phi_{1} u_{1}$ is a convex subset of $\mathcal{U}_{2}$.

Step 4. Prove that Graph $\Phi$ is closed.
It suffices to show that if $\left(u_{n, 1}, u_{n, 2}\right) \in \mathcal{U}_{1} \times \mathcal{U}_{2}, \widetilde{u}_{n, 1} \in \Phi_{2} u_{n, 2}, \widetilde{u}_{n, 2} \in \Phi_{1} u_{n, 1}$, $\left(u_{n, 1}, u_{n, 2}\right) \rightarrow\left(u_{1}, u_{2}\right)$ in $X$ and $\left(\widetilde{u}_{n, 1}, \widetilde{u}_{n, 2}\right) \rightarrow\left(\widetilde{u}_{1}, \widetilde{u}_{2}\right)$ in $X$, then

$$
\begin{equation*}
\left(u_{1}, u_{2}\right) \in \mathcal{U}_{1} \times \mathcal{U}_{2}, \widetilde{u}_{1} \in \Phi_{2} u_{2} \text { and } \widetilde{u}_{2} \in \Phi_{1} u_{1} . \tag{4.18}
\end{equation*}
$$

Indeed, on one hand, by (4.1) and (4.2), we can easily check that

\left(u_{1}, u_{2}\right) \in \mathcal{U}_{1} \times \mathcal{U}_{2}, \widetilde{u}_{1} \in \mathcal{U}_{1} \text { and } \widetilde{u}_{2} \in \mathcal{U}_{2} \tag{4.19}
\end{equation*}

On the other hand, according to $\widetilde{u}_{n, 1} \in \Phi_{2} u_{n, 2},(4.2)$ and (2.6), it is obvious that for each $v_{1} \in \mathcal{U}_{1}$,

Since $\left(\widetilde{u}_{n, 1}, u_{n, 2}\right) \rightarrow\left(\widetilde{u}_{1}, u_{2}\right)$ weakly star in $\left(L^{\infty}\left(0, T ; L^{2}(0,1)\right)\right)^{2}$, by similar arguments as those to get (4.14), there exists a subsequence of $\{n\}_{n \geq 1}$, still denoted by itself, so that

& \left(y\left(T ; y_{0}, g, \widetilde{u}_{n, 1}, u_{n, 2}\right), y\left(T ; y_{0}, g, v_{1}, u_{n, 2}\right)\right) \\
& \rightarrow\left(y\left(T ; y_{0}, g, \widetilde{u}_{1}, u_{2}\right), y\left(T ; y_{0}, g, v_{1}, u_{2}\right)\right) \text { strongly in }\left(L^{2}(0,1)\right)^{2}
\end{aligned}
$$

which, implies that

\begin{align*}
& \left(y\left(T ; y_{0}, g, \widetilde{u}_{n, 1}, u_{n, 2}\right), y\left(T ; y_{0}, g, v_{1}, u_{n, 2}\right)\right) \\
& \rightarrow\left(y\left(T ; y_{0}, g, \widetilde{u}_{1}, u_{2}\right), y\left(T ; y_{0}, g, v_{1}, u_{2}\right)\right) \text { strongly in }\left(L^{2}\left(G_{1}\right)\right)^{2} . \tag{4.21}
\end{align*}
$$

Passing to the limit for $n \rightarrow \infty$ in (4.20), by (4.21), we get that for each $v_{1} \in \mathcal{U}_{1}$,

This, together with (2.6), (4.2) and the second conclusion in (4.19), implies that $\widetilde{u}_{1} \in \Phi_{2} u_{2}$. Similarly, $\widetilde{u}_{2} \in \Phi_{1} u_{1}$. Hence, (4.18) follows.

Step 5. Finish the proof.
According to Steps 1-4 and Lemma 4.1, there exists a pair of $\left(u_{1}^{*}, u_{2}^{*}\right) \in \mathcal{U}_{1} \times \mathcal{U}_{2}$ so that $\left(u_{1}^{*}, u_{2}^{*}\right) \in \Phi\left(u_{1}^{*}, u_{2}^{*}\right)$, which, combined with (4.1)-(4.3), indicates that $\left(u_{1}^{*}, u_{2}^{*}\right)$ is a Stackelberg-Nash equilibrium of the problem (P1).

In summary, we end the proof of Theorem 2.2.
4.2. Decomposition and Characterization of Stackelberg-Nash Equilibria. In this subsection, we first give some conclusions that will be used later. By Theorem 2.1, we have the observability inequality for adjoint equation (2.11).

Corollary 4.2. Let $\alpha \in(0,2), \mu \in(0,1)$ and $\omega \times E \subset I \times(0, T)$ be measurable subsets with positive measures. Then there exists a constant $C=C(T, I, \alpha, \omega, E, \mu) \geq 1$ such that the solution of (2.11) satisfies the following observability inequality: for any $z_{T} \in L^{2}(0,1)$,

Let $\omega_{0} \subset G$, where $G$ is a measurable subset of $(0,1)$ and $\zeta\left(\cdot ; \zeta_{0}, g, u\right)$ be the solution to the following system:

$$

with $M>0$. Consider the following problem:

\inf _{u \in \mathcal{U}}\left\|\zeta\left(T ; \zeta_{0}, g, u\right)-\zeta_{T}\right\|_{L^{2}(G)} \tag{4.24}
\end{equation*}
$$

where $\zeta_{T} \in L^{2}(0,1)$ is a given function. Then there exists $u^{*} \in \mathcal{U}$ such that

$$
\left\|\zeta\left(T ; \zeta_{0}, g, u^{*}\right)-\zeta_{T}\right\|_{L^{2}(G)}=\inf _{u \in \mathcal{U}}\left\|\zeta\left(T ; \zeta_{0}, g, u\right)-\zeta_{T}\right\|_{L^{2}(G)} .
$$

Moreover, if $\zeta\left(T ; \zeta_{0}, g, u^{*}\right) \neq \zeta_{T}$, then $u^{*}$ enjoys the following form

u^{*}(t)=M \frac{\chi_{\omega_{0}} z(t)}{\left\|\chi_{\omega_{0}} z(t)\right\|_{L^{2}(G)}}, \text { for a.e. } t \in(0, T) \tag{4.25}

where $z$ is a solution solving the following equation:

\begin{cases}z_{t}(x, t)+A z(x, t)=0, & (x, t) \in(0,1) \times(0, T)  \tag{4.26}\\ z(1, t)=B C_{\alpha}(z(\cdot, t))=0, & t \in(0, T) \\ z(x, T)=\zeta_{T}-\zeta\left(T ; \zeta_{0}, g, u^{*}\right), & x \in(0,1)\end{cases}
$$

Proof. We carry out this proof step by step.
Step 1. We show the existence of the problem (4.24).
Note that $\zeta\left(\cdot ; \zeta_{0}, g, u\right)=\zeta\left(\cdot ; \zeta_{0}, g, 0\right)+\zeta(\cdot ; 0,0, u)$, then the problem (4.24) is equivalent to the following problem:

Since $\left\{u_{n}\right\}_{n \geq 1} \subseteq \mathcal{U}$, there exists a subsequence of $\left\{u_{n}\right\}_{n \geq 1}$, still denoted by itself, and $u^{*} \in L^{\infty}\left(0, \bar{T} ; L^{\overline{2}}(0,1)\right)$ such that

$$

By similar arguments as those to get (4.14), there exists a subsequence of $\{n\}_{n \geq 1}$, still denoted by itself and $\zeta^{*} \in C\left([0, T] ; L^{2}(0,1)\right) \cap L^{2}\left(0, T ; H_{a}^{1}(0,1)\right)$ such that

\zeta\left(\cdot ; 0,0, u_{n}\right) \rightarrow \zeta^{*} \text { weakly in } C\left([0, T] ; L^{2}(0,1)\right) \cap L^{2}\left(0, T ; H_{a}^{1}(0,1)\right) \\
\text { and strongly in } L^{2}(0,1) . \tag{4.28}
\end{gather*}
$$

Passing to the limit for $n \rightarrow \infty$ in (4.28), we obtain that $\zeta^{*}$ is the solution of the following system

\begin{cases}\zeta_{t}^{*}(x, t)=A \zeta^{*}(x, t)+\chi_{\omega_{0}} u^{*}, & (x, t) \in(0,1) \times(0, T) \\ \zeta^{*}(1, t)=B C_{\alpha}\left(\zeta^{*}(\cdot, t)\right)=0, & t \in(0, T) \\ \zeta^{*}(x, 0)=0, & x \in(0,1)\end{cases}

This means that $\zeta^{*}=\zeta\left(\cdot ; 0,0, u^{*}\right)$. Now, letting $n \rightarrow \infty$ in (4.27) we obtain that

Step 2. We characterize the optimal control $u^{*}$.
Denote $\hat{\zeta}_{T}=\zeta_{T}-\zeta\left(T ; \zeta_{0}, g, 0\right)$. Since $u^{*}$ is an optimal control, i.e., for each $u \in \mathcal{U}$ we have

After some calculations, the above inequality holds

which, implies that for all $u \in \mathcal{U}$

\int_{0}^{T}\left\langle\chi \omega_{0} z(t), u^{*}(t)\right\rangle_{L^{2}(G)} d t=\max _{u(\cdot) \in \mathcal{U}} \int_{0}^{T}\left\langle\chi_{\omega_{0}} z(t), u(t)\right\rangle_{L^{2}(G)} d t .
$$

This is equivalent to the following condition:

By the condition $\zeta\left(T ; \zeta_{0}, g, u^{*}\right) \neq \zeta_{T}$ and noting that $\hat{\zeta}_{T}-\zeta\left(T ; 0,0, u^{*}\right)=\zeta_{T}-\zeta\left(T ; \zeta_{0}, g, 0\right)-$ $\zeta\left(T ; 0,0, u^{*}\right)=\zeta_{T}-\zeta\left(T ; \zeta_{0}, g, u^{*}\right)$, it holds $\hat{\zeta}_{T}-\zeta\left(T ; 0,0, u^{*}\right) \neq 0$. This, together with (4.22) in Corollary 4.2, implies

It implies $u_{0} \in \mathcal{U}$. Also, we have
$\left\langle\chi_{\omega_{0}} z(t), u_{0}(t)\right\rangle_{L^{2}(G)}=\left\langle\chi_{\omega_{0}} z(t), M \frac{\chi_{\omega_{0}} z(t)}{\left\|\chi_{\omega_{0}} z(t)\right\|}\right\rangle_{L^{2}(G)}=M\left\|\chi_{\omega_{0}} z(t)\right\|_{L^{2}(G)}$, for a.e. $t \in(0, T)$,
which, along with (4.31) again, it holds

\left\langle\chi_{\omega_{0}} z(t), u^{*}(t)\right\rangle_{L^{2}(G)}=M\left\|\chi_{\omega_{0}} z(t)\right\|_{L^{2}(G)} \text { for a.e. } t \in(0, T) \text {. }

Therefore, we have (4.25). This completes the proof.
Next, we shall obtain that the set of Stackelberg-Nash equilibria breaks down into three disjoint parts.

Let N be the set of Stackelberg-Nash equilibria of problem (P1) with respect to the system (2.5), and let

& N_{1}=\left\{\left(u_{1}^{*}, u_{2}^{*}\right) \in N: y\left(T, y_{0}, g, u_{1}^{*}, u_{2}^{*}\right)=y_{T}^{1}\right\}  \tag{4.32}\\
& N_{2}=\left\{\left(u_{1}^{*}, u_{2}^{*}\right) \in N: y\left(T, y_{0}, g, u_{1}^{*}, u_{2}^{*}\right)=y_{T}^{2}\right\} .
\end{align*}
$$

Clearly, $N_{0}, N_{1}, N_{2}$ are three disjoint subsets of $N$ and $N=N_{0} \cup N_{1} \cup N_{2}$.

\begin{cases}z_{t}(x, t)+A z(x, t)=0, & (x, t) \in(0,1) \times(0, T) \\ z(1, t)=B C_{\alpha}(z(\cdot, t))=0, & t \in(0, T) \\ z(x, T)=y_{T}^{1}-y\left(T, y_{0}, g, u_{1}^{*}, u_{2}^{*}\right), & x \in(0,1)\end{cases}
$$

One can easily check that

\left\|u_{1}^{*}\right\|_{L^{2}\left(G_{1}\right)}=M_{1}, \text { for a.e. } t \in(0, T) .

Case 2: if $y\left(T, y_{0}, g, u_{1}^{*}, u_{2}^{*}\right) \neq y_{T}^{2}$, then

\begin{cases}z_{t}(x, t)+A z(x, t)=0, & (x, t) \in(0,1) \times(0, T) \\ z(1, t)=B C_{\alpha}(z(\cdot, t))=0, & t \in(0, T) \\ z(x, T)=y_{T}^{2}-y\left(T, y_{0}, g, u_{1}^{*}, u_{2}^{*}\right), & x \in(0,1)\end{cases}
$$

One can easily check that

\left\|u_{2}^{*}\right\|_{L^{2}\left(G_{2}\right)}=M_{2}, \text { for a.e. } t \in(0, T)
$$

The proof is completed.

where $z$ is a solution for adjoint equation (4.26) with the terminal condition $z(T)=$ $y_{T}^{2}-y\left(T ; y_{0}, g, u_{1}, u_{2}^{*}\right), u_{1} \in \mathcal{U}_{1}$.

Denote
$A=\left\{\begin{array}{l|l}u_{1} \in \mathcal{U}_{1} & \begin{array}{l}y\left(T, y_{0}, g, u_{1}, u_{2}^{*}\right)=y_{T}^{1}, \\ \left\|y\left(T ; y_{0}, g, u_{1}, u_{2}^{*}\right)-y_{T}^{2}\right\|_{L^{2}\left(G_{2}\right)} \leq\left\|y\left(T ; y_{0}, g, u_{1}, u_{2}\right)-y_{T}^{2}\right\|_{L^{2}\left(G_{2}\right)}, \\ \forall u_{2} \in \mathcal{U}_{2} .\end{array}\end{array}\right\}$,
and

B=\left\{u_{1} \in \mathcal{U}_{1}: y\left(T, y_{0}, g, u_{1}, u_{2}^{*}\right)=y_{T}^{1}\right\} .

Then, $A=B$.
Proof. It is clear that $A \subseteq B$. We only need to show $B \subseteq A$.
Let $u_{1} \in B$. Then there exists an element $u_{2} \in \mathcal{U}_{2}$ such that the following problem holds:

By the same line as the proof of Lemma 4.3, it holds

This implies $u_{1} \in A$. Hence, we have $B \subseteq A$. The proof is completed.

In conclusion, Theorem 2.3 is a direct consequence of (4.32), Proposition 4.4 and Proposition 4.9.

## 5. The norm optimal control problem

In this section, we discuss the norm optimal control problem (P2). At first, we study the existence, i.e., Lemma 2.6. Then the leader control $g$ is characterized in terms of the solution of a variational problem, i.e., Theorem 2.7.

Proof of Lemma 2.6. Let $\left\{g_{n}\right\}_{n \geq 1} \subset \mathcal{U}_{0}$ be a minimizing sequence of problem (P2) corresponding a Stackelberg-Nash equilibrium sequence $\left(u_{1, n}^{*}\left(g_{n}\right), u_{2, n}^{*}\left(g_{n}\right)\right) \in N=N_{0} \cup$ $N_{1} \cup N_{2}, N \subset \mathcal{U}_{1} \times \mathcal{U}_{2}$ such that

Since $\left\{g_{n}\right\}_{n=1}^{\infty} \subset L^{\infty}\left(0, T ; L^{2}(0,1)\right)$ is bounded, then there exists a subsequence, still denoted by itself, and $g^{*} \in L^{\infty}\left(0, T ; L^{2}(0,1)\right)$ such that

Note that $\left\|u_{1}^{*}\left(g_{n}\right)\right\|_{L^{\infty}\left(0, T ; L^{2}(0,1)\right)} \leq M_{1},\left\|u_{2}^{*}\left(g_{n}\right)\right\|_{L^{\infty}\left(0, T ; L^{2}(0,1)\right)} \leq M_{2}$, then there exists a subsequence of $\left\{\left(u_{1}^{*}\left(g_{n}\right), u_{2}^{*}\left(g_{n}\right)\right)\right\}_{n=1}^{\infty} \subset\left(L^{\infty}\left(0, T ; L^{2}(0,1)\right)\right)^{2}$, still denoted by itself, and $\left(u_{1}^{*}, u_{2}^{*}\right) \in\left(L^{\infty}\left(0, T ; L^{2}(0,1)\right)\right)^{2}$, such that

u_{1}^{*}\left(g_{n}\right) \rightarrow u_{1}^{*} \text {, and } u_{2}^{*}\left(g_{n}\right) \rightarrow u_{2}^{*} \text { weakly star in } L^{\infty}\left(0, T ; L^{2}(0,1)\right) . \tag{5.3}

According to $y\left(T ; y_{0}, g_{n}, u_{1}^{*}\left(g_{n}\right), u_{2}^{*}\left(g_{n}\right)\right)=0$, we get $y\left(T ; y_{0}, g^{*}, u_{1}^{*}, u_{2}^{*}\right)=0$ by (5.1) and (5.3). By (5.2), we only need to show $u_{1}^{*}=u_{1}^{*}\left(g^{*}\right), u_{2}^{*}=u_{2}^{*}\left(g^{*}\right)$.

It is obviously that there exists a subsequence of $\left\{\left(u_{1, n}^{*}\left(g_{n}\right), u_{2, n}^{*}\left(g_{n}\right)\right)\right\}_{n=1}^{\infty}$, by extracting a subsequence (the subsequence is also a minimizing sequence of Problem (P2)), still denoted by itself, such that the sequence $\left\{\left(u_{1, n}^{*}\left(g_{n}\right), u_{2, n}^{*}\left(g_{n}\right)\right)\right\}_{n=1}^{\infty}$ is contained in $N_{0}, N_{1}$ or $N_{2}$. This implies the following three cases:

Case 1. If $\left(u_{1, n}^{*}\left(g_{n}\right), u_{2, n}^{*}\left(g_{n}\right)\right) \in N_{0}$, i.e., $y_{T}^{1} \neq 0 \neq y_{T}^{2}$, by Remark 4.5 and $\left(A_{2}\right)$, we have

Case 2. If $\left(u_{1, n}^{*}\left(g_{n}\right), u_{2, n}^{*}\left(g_{n}\right)\right) \in N_{1}$, i.e., $y_{T}^{1}=0$, by Proposition 4.6 and assumption $\left(A_{2}\right)$, we have

where $z_{2}$ is the solution of following system

\begin{cases}z_{2, t}(x, t)+A z_{2}(x, t)=0, & (x, t) \in(0,1) \times(0, T) \\ z_{2}(1, t)=B C_{\alpha}\left(z_{2}(\cdot, t)\right)=0, & t \in(0, T) \\ z_{2}(x, T)=y_{T}^{2}, & x \in(0,1)\end{cases}
$$

By Remark 4.8 and $y\left(T ; y_{0}, g^{*}, u_{1}^{*}, u_{2}^{*}\left(g^{*}\right)\right)=0=y_{T}^{1}$, we have $\left(u_{1}^{*}, u_{2}^{*}\left(g^{*}\right)\right) \in N_{1}$, i.e., $u_{1}^{*}=u_{1}^{*}\left(g^{*}\right)$.

Case 3. If $\left(u_{1, n}^{*}\left(g_{n}\right), u_{2, n}^{*}\left(g_{n}\right)\right) \in N_{2}$, i.e., $y_{T}^{2}=0$, the rest proof is similar to Case 2, then we also have $u_{1}^{*}=u_{1}^{*}\left(g^{*}\right), u_{2}^{*}=u_{2}^{*}\left(g^{*}\right)$.

This completes the proof.
Remark 5.1. From the proof of Lemma 2.6, we see that under the assumption $\left(A_{2}\right)$, if there exists a Stackelberg-Nash equilibrium $\left(u_{1}^{*}(g), u_{2}^{*}(g)\right) \in N$, then $\left(u_{1}^{*}, u_{2}^{*}\right) \in N_{0}$ or $\left(u_{1}^{*}(g), u_{2}^{*}\right) \in N_{1}$ or $\left(u_{1}^{*}, u_{2}^{*}(g)\right) \in N_{2}$.
Remark 5.2. Unfortunately, due to the influences of the functions $u_{1}^{*}\left(g^{*}\right)$ and $u_{2}^{*}\left(g^{*}\right)$ with respect to $g^{*}$, where $g^{*}$ is an optimal control of problem (P2), the confirmation of the bang-bang property of the optimal control $g^{*}$ remains elusive, thereby preventing the attainment of the uniqueness of the norm optimal control of problem (P2).
Lemma 5.3. For any $T \in \mathbb{R}^{+}$, let $Y_{T}$ and $Z_{T}$ be defined as (2.13) and (2.14) respectively. Then

Proof. The proof will be accomplished by following two steps.
Step 1: Show that $Y_{T} \subset Z_{T}$.
Indeed, for any $\psi \in Y_{T}$ and noting the embedding $H_{\alpha}^{1}(0,1) \hookrightarrow L^{2}(0,1)$ is compact and similar to the proof of (4.12) and (4.13), there exists $\left\{z_{T, n}\right\}_{n \geq 1} \subset L^{2}(0,1)$ such that

Choose $\left\{T_{n}\right\}_{n \geq 1}$ with $T_{n} \uparrow T$ and $T_{n} \geq \frac{T}{2}$ for all $n \in \mathbb{N}$. We consider the following three
cases. cases.

Case a). For $T_{1}$, there exists a constant $C_{1}=C\left(C_{O}, T_{2}\right)>0$ such that

\begin{cases}\partial_{t} \hat{z}_{2}(x, t)+A \hat{z}_{2}(x, t)=0, & (x, t) \in(0,1) \times\left(0, T_{3}\right), \\ \hat{z}_{2}(1, t)=B C_{\alpha}\left(\hat{z}_{2}(\cdot, t)\right)=0, & t \in\left(0, T_{3}\right), \\ \hat{z}_{2}\left(T_{3}\right)=\hat{z}_{T, 2}, & x \in(0,1),\end{cases}
$$

and

$$
\chi_{\omega} z_{2 n}=\chi_{\omega} z\left(\cdot ; z_{T, 2 n}\right) \rightarrow \chi_{\omega} \hat{z}_{2} \text { strongly in } L^{1}\left(0, T_{2} ; L^{2}(0,1)\right) \cap C\left(\left[0, T_{2}\right] ; L^{2}(0,1)\right) .
$$

These combine with (5.6), (5.9) and (5.10) imply that

where $\hat{z}_{2}(\cdot)=e^{A\left(T_{2}-\cdot\right)} z_{T, 2}$ and $z_{T, 2}=e^{A\left(T_{3}-T_{2}\right)} \hat{z}_{T, 2}$.
Case c). Similarly to a) and b), for every $k \in \mathbb{N}$, we can find a subsequence $\left\{z_{T, k n}\right\}_{n \geq 1}$ of $\left\{z_{T, k-1, n}\right\}_{n \geq 1}$ such that

- $\hat{z}_{k} \in L^{1}\left(0, T_{k+1} ; L^{2}(0,1)\right) \cap C\left(\left[0, T_{k+1}\right] ; L^{2}(0,1)\right)$,
- $\left.\hat{z}_{k+1}\right|_{\left[0, T_{k}\right]}=\hat{z}_{k}$,
- $\hat{z}_{k}$ satisfies

$$

- $\psi=\chi_{\omega} \hat{z}_{k}$ in $L^{1}\left(0, T_{k} ; L^{2}(0,1)\right)$, where $\hat{z}_{k}(\cdot)=e^{A\left(T_{k}-\cdot\right)} z_{T, k}$ and $z_{T, k}=e^{A\left(T_{k+1}-T_{k}\right)} \hat{z}_{T, k}$.

Finally, define

Step 2: Show that $Z_{T} \subset Y_{T}$.
In fact, by the definition of $Z_{T}$, for any $\xi \in Z_{T}$, there exists $z$ such that

\leq & \left\|z_{T, n}-e^{A\left(T_{k}-T_{l}\right)} z_{T, n}\right\|,
\end{aligned}

where we used (5.11) in the third equality above and the operator $A$ generates a $C_{0}$ semigroup of linear contractions in the last inequality above, see [12]. This implies that $\left\{z_{k}\left(T_{n}\right)\right\}_{k \geq n}$ is a Cauchy sequence in $L^{2}(0,1)$. Furthermore,

& \leq\left\|\chi_{\omega} \tilde{z}(\cdot)-\chi_{\omega} \tilde{z}\left(\cdot-\left(T-T_{k}\right)\right)\right\|_{L^{1}\left(0, T-\frac{\delta(\varepsilon)}{2} ; L^{2}(0,1)\right)}+\left\|\chi_{\omega} \tilde{z}\left(\cdot-\left(T-T_{k}\right)\right)\right\|_{L^{1}\left(T-\frac{\delta(\varepsilon)}{2}, T ; L^{2}(0,1)\right)} \\
& \quad+\left\|\chi_{\omega} \tilde{z}\right\|_{L^{1}\left(T-\frac{\delta(\varepsilon)}{2}, T ; L^{2}(0,1)\right)} \\
& \leq\left\|\tilde{z}(\cdot)-\tilde{z}\left(\cdot-\left(T-T_{k}\right)\right)\right\|_{L^{1}\left(0, T-\frac{\delta(\varepsilon)}{2} ; L^{2}(0,1)\right)}+\left\|\chi_{\omega} \tilde{z}\left(\cdot-\left(T-T_{k}\right)\right)\right\|_{L^{1}\left(T-\frac{\delta(\varepsilon)}{2}, T ; L^{2}(0,1)\right)} \\
&+\left\|\chi_{\omega} \tilde{z}\right\|_{L^{1}\left(T-\frac{\delta(\varepsilon)}{2}, T ; L^{2}(0,1)\right)} \\
& \leq\left(T-\frac{\delta(\varepsilon)}{2}\right) \varepsilon+2 \varepsilon .

\geq & \frac{1}{2}\left\|\chi_{\omega} z\right\|_{L^{1}\left(0, T ; L^{2}(0,1)\right)}^{2}-C\left\|y_{0}\right\|\left\|\chi_{\omega} z\right\|_{L^{1}\left(0, T ; L^{2}(0,1)\right)}-\max \left\{M_{1}, M_{2}\right\}\left\|\chi_{\omega} z\right\|_{L^{1}\left(0, T ; L^{2}(0,1)\right)},
\end{aligned}
$$

where we used observability inequality (4.22) and $\left(A_{1}\right)$, which implies that

& -\frac{1}{2}\left\|\chi_{\omega} z_{*}\right\|_{L^{1}\left(0, T ; L^{2}(0,1)\right)}^{2}-\left\langle y_{0}, z_{*}(0)\right\rangle-\int_{0}^{T} \int_{0}^{1} \sum_{i=1}^{2} \chi_{\omega_{i}} u_{i}^{*}\left(g^{*}\right) z_{*} d x d t \\
= & \frac{1}{2} \int_{0}^{T} \frac{2 h \int_{0}^{1} \chi_{\omega} z_{*}(t) \chi_{\omega} z(t) d x+h^{2} \int_{0}^{1} \chi_{\omega} z(t)^{2} d x}{\left\|\chi_{\omega} z_{*}(t)+h \chi_{\omega} z(t)\right\|+\left\|\chi_{\omega} z_{*}(t)\right\|} d t \\
& \cdot \int_{0}^{T}\left(\left\|\chi_{\omega} z_{*}(t)+h \chi_{\omega} z(t)\right\|+\left\|\chi_{\omega} z_{*}(t)\right\|\right) d t \\
& +h\left\langle y_{0}, z(0)\right\rangle+h \int_{0}^{T} \int_{0}^{1} \sum_{i=1}^{2} \chi_{\omega_{i}} u_{i}^{*}\left(g^{*}\right) z d x d t .
\end{aligned}
$$

\begin{cases}y_{t}(x, t)=A y(x, t)+\chi_{\omega} g^{*}+\chi_{\omega_{1}} u_{1}^{*}\left(g^{*}\right)+\chi_{\omega_{2}} u_{2}^{*}\left(g^{*}\right), & (x, t) \in(0,1) \times(0, T) \\ y(1, t)=B C_{\alpha}(y(\cdot, t))=0, & t \in(0, T) \\ y(x, 0)=y_{0}(x), & x \in(0,1)\end{cases}
$$

and integrating with respect to $x \in(0,1)$ and $t \in(0, T)$, it produces

$$
\begin{equation*}
-\left\langle y(0), z\left(0 ; z_{T, n}\right)\right\rangle-\int_{0}^{T} \int_{0}^{1} \sum_{i=1}^{2} \chi_{\omega_{i}} u_{i}^{*}\left(g^{*}\right) z\left(t ; z_{T, n}\right) d x d t=\int_{0}^{T}\left\langle g^{*}(t), \chi_{\omega} z\left(t ; z_{T, n}\right)\right\rangle d t . \tag{5.26}
\end{equation*}
$$

By the same arguments as the proof of Lemma 5.3, there exists a subsequence of $\left\{z_{T, n}\right\}_{n \geq 1}$, still denoted by itself, such that

$$
\begin{equation*}
z\left(0 ; z_{T, n}\right) \rightarrow z_{*}(0) \text { weakly in } L^{2}(0,1) . \tag{5.27}
\end{equation*}
$$

By (5.24)-(5.27), letting $n \rightarrow \infty$, we obtain that

$$
-\left\langle y(0), z_{*}(0)\right\rangle-\int_{0}^{T} \int_{0}^{1} \sum_{i=1}^{2} \chi_{\omega_{i}} u_{i}^{*}\left(g^{*}\right) z_{*}(t) d x d t=\int_{0}^{T}\left\langle g^{*}(t), \chi_{\omega} z_{*}(t)\right\rangle d t
$$

which, along with (5.19) and (5.21), we have

$$
\begin{equation*}
\|\bar{g}\|_{L^{\infty}\left(0, T ; L^{2}(0,1)\right)}=\left\|\chi_{\omega} z_{*}\right\|_{L^{1}\left(0, T ; L^{2}(0,1)\right)} \leq\left\|g^{*}\right\|_{L^{\infty}\left(0, T ; L^{2}(0,1)\right)} . \tag{5.28}
\end{equation*}
$$

This implies that

$$
\|\bar{g}\|_{L^{\infty}\left(0, T ; L^{2}(0,1)\right)}=\left\|g^{*}\right\|_{L^{\infty}\left(0, T ; L^{2}(0,1)\right)}=N\left(T, y_{0}\right)
$$

Therefore, $\bar{g}$ is also an optimal control of problem (P2). Replacing $g^{*}$ by $\bar{g}$ and together with (5.20), we have

$$
g^{*}(t)=\frac{\chi_{\omega} z_{*}(t)}{\left\|\chi_{\omega} z_{*}(t)\right\|}\left\|\chi_{\omega} z_{*}\right\|_{L^{1}\left(0, T ; L^{2}(0,1)\right)} \text { for a.e. } t \in(0, T)
$$

Case (ii). If (5.23) holds, then multiplying $z$ with $\chi_{\omega} z \in X_{T} \subset Z_{T}$ on both sides of the first equation of the following system

$$
\begin{cases}y_{t}(x, t)=A y(x, t)+\chi_{\omega_{1}} u_{1}^{*}\left(g^{*}\right)+\chi_{\omega_{2}} u_{2}^{*}\left(g^{*}\right), & (x, t) \in(0,1) \times(0, T) \\ y(1, t)=B C_{\alpha}(y(\cdot, t))=0, & t \in(0, T) \\ y(x, 0)=y_{0}(x), & x \in(0,1)\end{cases}
$$

and integrating with respect to $x \in(0,1)$ and $t \in(0, T)$, it produces

$$
\left\langle y\left(T ; y_{0}, 0, u_{1}^{*}\left(g^{*}\right), u_{2}^{*}\left(g^{*}\right)\right), z_{T}\right\rangle-\langle y(0), z(0)\rangle-\int_{0}^{T} \int_{0}^{1} \sum_{i=1}^{2} \chi_{\omega_{i}} u_{i}^{*}\left(g^{*}\right) z d x d t=0
$$

which, along with (5.22), it implies that

$$
y\left(T ; y_{0}, 0, u_{1}^{*}\left(g^{*}\right), u_{2}^{*}\left(g^{*}\right)\right)=0
$$

Similar to the proof of Case $(i)$, we obtain $u_{1}^{*}(0)=u_{1}^{*}\left(g^{*}\right)$ and $u_{2}^{*}(0)=u_{2}^{*}\left(g^{*}\right)$. This shows that

$$
y\left(T ; y_{0}, 0, u_{1}^{*}(0), u_{2}^{*}(0)\right)=0 .
$$

Therefore, by the definition of $N\left(T, y_{0}\right)$, which defined in (2.10), $\bar{g}=0$ is also an optimal control of problem (P2). Replacing $g^{*}$ by $\bar{g}$ and together with (5.23), we have

$$
g^{*}(t)=0 \text { for a.e. } t \in(0, T) .
$$

Step 4. Conclude that $V\left(T, y_{0}\right)=-\frac{1}{2} N\left(T, y_{0}\right)^{2}$.
By Step 3, it shows that Case (I). If

$$
g^{*}(t)=\frac{\chi_{\omega} z_{*}(t)}{\left\|\chi_{\omega} z_{*}(t)\right\|}\left\|\chi_{\omega} z_{*}\right\|_{L^{1}\left(0, T ; L^{2}(0,1)\right)} \text { for a.e. } t \in(0, T)
$$

then

$$
N\left(T, y_{0}\right)=\left\|\chi_{\omega} z_{*}\right\|_{L^{1}\left(0, T ; L^{2}(0,1)\right)}
$$

which, together with (5.19) and (5.16), deduces that

$$
V\left(T, y_{0}\right)=-\frac{1}{2}\left\|\chi_{\omega} z_{*}\right\|_{L^{1}\left(0, T ; L^{2}(0,1)\right)}^{2}=-\frac{1}{2} N\left(T, y_{0}\right)^{2} .
$$

Case (II). If

$$
g^{*}(t)=0, \text { for a.e. } t \in(0, T)
$$

then

$$
V\left(T, y_{0}\right)=N\left(T, y_{0}\right)
$$

From these, we have

$$
V\left(T, y_{0}\right)=-\frac{1}{2} N\left(T, y_{0}\right)^{2} .
$$

The proof is completed.
