

Streamlining Input/Output Logics with Sequent Calculi — Extended Version

Abstract

Input/Output (I/O) logic is a general framework for reasoning about conditional norms and/or causal relations. We streamline Bochman’s causal I/O logics via proof-search-oriented sequent calculi. Our calculi establish a natural syntactic link between the derivability in these logics and in the original I/O logics. As a consequence of our results, we obtain new, simple semantics for all these logics, complexity bounds, embeddings into normal modal logics, and efficient deduction methods. Our work encompasses many scattered results and provides uniform solutions to various unresolved problems.

1 Introduction

Input/Output (I/O) logic is a general framework proposed by (Makinson and van der Torre 2000) to reason about conditional norms. I/O logic is not a single logic but rather a family of logics, each viewed as a “transformation engine”, which converts an input (condition under which the obligation holds) into an output (what is obligatory under these conditions). Many different I/O logics have been defined, e.g., (Makinson and van der Torre 2001; van der Torre and Parent 2013; Parent and van der Torre 2014; Stolpe 2015), and also used as building blocks for causal reasoning (Bochman 2003; Bochman 2004; Bochman and Lifschitz 2015; Bochman 2021), laying down the logical foundations for the causal calculus (McCain and Turner 1997), and for legal reasoning (Ciabattoni, Parent, and Sartor 2021). I/O logics manipulate Input-Output pairs¹ (A, B) , which consists of boolean formulae representing either conditional obligations (in the case of the original I/O logics) or causal relations (A causes B , in the case of their causal counterparts). Different I/O logics are defined by varying the mechanisms of obtaining new pairs from a set of pairs (entailment problem). Each I/O logic is characterized by its own semantics. The original I/O logics use a procedural approach, while their causal counterparts adopt bimodels, which in general consist of pairs of arbitrary deductively-closed sets of formulae. Additionally, each I/O logic is equipped with a proof calculus, consisting of axioms and rules but not suitable for proof search.

This paper deals with the four original I/O logics OUT_1 - OUT_4 in (Makinson and van der Torre 2000) and their causal counterpart OUT_1^\perp - OUT_4^\perp in (Bochman 2004). We introduce proof-search-oriented sequent calculi and use them to bring together scattered results and to provide uniform solutions to various unresolved problems. Indeed (van Berkel and Straßer 2022) characterized many I/O logics through an argumentative approach using sequent-style calculi. Their calculi are not proof search-oriented. First sequent calculi of this kind for some I/O logics, including OUT_1 and OUT_3 , have been proposed in (Lellmann 2021). Their implementation provides an alternative decidability proof, although not optimal (entailment is shown to be in Π_3^P). Moreover, the problem of finding proof-search-oriented calculi for OUT_2 and OUT_4 was left open there. A prover for these two logics was introduced in (Benzmüller et al. 2019). The prover encodes in classical Higher Order Logic their embeddings from (Makinson and van der Torre 2000) into the normal modal logics **K** and **KT**. Finding an embedding of OUT_1 and OUT_3 into normal modal logics was left as an open problem, that (van der Torre and Parent 2013) indicates as difficult, if possible at all. An encoding of various I/O logics into more complicated logics (adaptive modal logics) is in (Straßer, Beirlaen, and Putte 2016). Using their procedural semantics, (Steen 2021) defined goal-directed decision procedures for the original I/O logics, without mentioning the complexity of the task. (Sun and Robaldo 2017) showed that the entailment problem for OUT_1 , OUT_2 , and OUT_4 is co-NP-complete, while for OUT_3 the complexity was determined to lie within the first and second levels of the polynomial hierarchy, without exact resolution.

In this paper we follow a new path that streamlines the considered logics. Inspired by the modal embedding of OUT_2^\perp and OUT_4^\perp in (Bochman 2003), we design well-behaving sequent calculi for Bochman’s causal I/O logics. The normal form of derivations in these calculi allows a simple syntactic link between derivability in the original I/O logics and in their causal versions to be established, making it possible to utilize our calculi for the original I/O logics as well. As a by-product:

- We introduce a simple possible worlds semantics.
- We prove co-NP-completeness and provide efficient automated procedures for the entailment problem; the latter

are obtained via reduction to unsatisfiability of a classical logic formula of polynomial size.

- We provide embeddings into the shallow fragment of the modal logics **K**, **KD** (i.e., standard deontic logic (von Wright 1951)), and their extension with axiom **F**.

These results are uniformly obtained *for all* four original I/O logics and their causal versions.

2 Preliminaries

In the I/O logic framework, conditional norms (or causal relations) are expressed as pairs (B, Y) of propositional boolean formulae. The semantics is operational, rather than truth-functional. The meaning of the deontic/causal concepts in these logics is given in terms of a set of procedures yielding outputs for inputs. The basic mechanism underpinning these procedures is detachment (modus ponens).

On the syntactic side, different I/O logics are obtained by varying the mechanisms of obtaining new input-output pairs from a given set of these pairs. The mechanisms introduced in the original paper (Makinson and van der Torre 2000) are based on the following (axioms and) rules (\models denotes semantic entailment in classical propositional logic):

- (**TOP**) (\top, \top) is derivable from no premises
- (**BOT**) (\perp, \perp) is derivable from no premises
- (**WO**) (A, X) derives (A, Y) whenever $X \models Y$
- (**SI**) (A, X) derives (B, X) whenever $B \models A$
- (**AND**) (A, X_1) and (A, X_2) derive $(A, X_1 \wedge X_2)$
- (**OR**) (A_1, X) and (A_2, X) derive $(A_1 \vee A_2, X)$
- (**CT**) (A, X) and $(A \wedge X, Y)$ derive (A, Y)

Different I/O logics are given by different subsets R of these rules, see Fig. 1. The basic system, called *simple-minded output* OUT_1 , consists of the rules $\{(\text{TOP}), (\text{WO}), (\text{SI}), (\text{AND})\}$. Its extension with (OR) (for reasoning by cases) leads to *basic output* logic OUT_2 , with (CT) (for reusability of outputs as inputs in derivations) to *simple-minded reusable output* logic OUT_3 , and with both (OR) and (CT) to *basic reusable output* logic OUT_4 . Their causal counterpart (Bochman 2004), that we denote by OUT_i^\perp for $i = 1, \dots, 4$, extends the corresponding logics with (BOT).

Definition 1. *Given a set of pairs G and a set R of rules, a derivation in an I/O logic of a pair (B, Y) from G is a tree with (B, Y) at the root, each non-leaf node derivable from its immediate parents by one of the rules in R , and each leaf node is an element of G or an axiom from R .*

We indicate by $G \vdash_{\text{OUT}^*} (B, Y)$ that the pair (B, Y) is derivable in the I/O logic OUT^* from the set of pairs in G (*entailment problem*). We will refer to (B, Y) as the *goal pair*, to the formulae B and Y as the *goal input* and *goal output* respectively, and to the pairs in G as *deriving pairs*.

Remark 1. *A derivation in I/O logic is a sort of natural deduction proof, acting on pairs, rather than formulae. This proof theory is however not helpful to decide whether $G \vdash_{\text{OUT}^*} (B, Y)$ holds, or to prove metalogical results*

(e.g., complexity bounds). The main reason is that derivations have no well-behaved normal forms, and in general are difficult to find. (Lellmann 2021) introduced the first proof-search oriented calculi, which operate effectively only in the absence of (OR) (hence not for OUT_2^\perp and OUT_4^\perp). The calculi use sequents that manipulate pairs expressed using the conditional logic connective \Rightarrow .

3 Sequent Calculi for Causal I/O Logics

We present sequent-style calculi for the causal I/O logic OUT_1^\perp - OUT_4^\perp . Their basic objects are

$$\text{I/O sequents} \quad (A_1, X_1), \dots, (A_n, X_n) \vdash (B, Y)$$

dealing with pairs, as well as

$$\text{Genzen's LK sequents} \quad A_1, \dots, A_n \Rightarrow B_1, \dots, B_m$$

dealing with boolean formulae (meaning that $\{A_1, \dots, A_n\} \models (B_1 \vee \dots \vee B_m)$). Our calculi are defined by extending the sequent calculus LK^2 for classical logic with three rules manipulating I/O sequents: one *elimination rule*—different for each logic—that removes one of the deriving pair while modifying the goal pair, and two *concluding rules* that transform the derivation of the goal pair into an LK derivation of either the goal input or the goal output. The latter rules, which are the same for all the considered logics, are in Fig. 1.

Definition 2. *A derivation in our calculi is a finite labeled tree whose internal nodes are I/O or LK sequents s.t. the label of each node follows from the labels of its children using the calculus rules. We say that an I/O sequent $(A_1, X_1), \dots, (A_n, X_n) \vdash (B, Y)$ is derivable if all the leaves of its derivation are LK axioms.*

A derivation of an I/O sequent consists of two phases. Looking at it bottom up, we first encounter rules dealing with pairs (pair elimination and concluding rules) followed by LK rules. The calculi, in a sense, uphold the ideological principles guiding I/O logics: pairs (i.e., conditional norms) are treated separately from the boolean statements.

It is easy to see that using (IN) and (OUT) we can derive (TOP) and (BOT); their soundness in the weakest causal I/O logic OUT_1^\perp is proven below.

Lemma 1. (IN) and (OUT) are derivable in OUT_1^\perp .

Proof. If $B \Rightarrow$ we have the following derivation in OUT_1^\perp : from (\perp, \perp) and $B \models \perp$ (i.e., $B \Rightarrow$) we get (B, \perp) by (SI); the required pair (B, Y) follows by (WO).

Assume $\Rightarrow Y$. From (\top, \top) and $\Rightarrow Y$ (i.e., $\top \models Y$) by (WO) we get (\top, Y) , from which (B, Y) follows by (SI). \square

Henceforth, when presenting derivations in our calculi, we will omit the LK sub-derivations.

3.1 Basic Production Inference OUT_2^\perp

The calculus SC_2^\perp for the causal³ basic output logic OUT_2^\perp is obtained by adding to the core calculus (consisting of LK with the rules (IN) and (OUT)) the pair elimination rule (E₂) in Fig. 2.

Remark 2. The rule (E₂) is inspired by the embedding in (Bochman 2003) of OUT_2^\perp into the modal logic **K**: $(A_1, X_1), \dots, (A_n, X_n) \vdash_{OUT_2^\perp} (B, Y)$ iff $(*) (A_1 \rightarrow \Box X_1), \dots, (A_n \rightarrow \Box X_n), B \vdash \Box Y$ is derivable in **K**. To provide the rule's intuition we make use of the sequent calculus GK for **K** in (Ono 1998). GK extends LK with the following rule for introducing boxes (or eliminating them, looking at the rule bottom up):

$$\frac{A_1, \dots, A_n \vdash B}{\Box A_1, \dots, \Box A_n \vdash \Box B} (\Box R)$$

To prove the sequent (*) in GK we can apply the LK rule for \rightarrow to one of the implications $(A_i \rightarrow \Box X_i)$ on the left. This creates two premises: (a) $G', B \vdash_K \Box Y, A_i$ and (b) $G', B, \Box X_i \vdash_K \Box Y$ (where G' is the set of all implications on the left-hand side but $(A_i \rightarrow \Box X_i)$). Now (a) $G', B \vdash_K \Box Y, A_i$ is equivalent in **K** to (derivable in GK if and only if so is) the sequent $G', (B \wedge \neg A_i) \vdash_K \Box Y$, that using the embedding again leads to the first premise of (E₂); (b) $G', B, \Box X_i \vdash_K \Box Y$ is equivalent (for suitable G') to $G', B \vdash_K \Box(Y \vee \neg X_i)$, which leads to the second premise of (E₂).

We prove below the soundness and completeness of the calculus SC_2^\perp for OUT_2^\perp . We start by describing a useful characterization of derivability in SC_2^\perp of an I/O sequent $(A_1, X_1), \dots, (A_n, X_n) \vdash (B, Y)$ via derivability of certain sequents in LK.

Notation 1. $\mathcal{P}(X)$ will denote the set of all partitions of the set X , i.e., $\mathcal{P}(X) = \{(I, J) \mid I \cup J = X, I \cap J = \emptyset\}$

Notice that if a concluding rule (IN) or (OUT) can be applied to the conclusion of (E₂), it can also be applied to its premises. This observation implies that if $(A_1, X_1), \dots, (A_n, X_n) \vdash (B, Y)$ is derivable in SC_2^\perp there is a derivation in which the concluding rules are applied only when all deriving pairs are eliminated. We use this I/O normal form of derivations in the proof of the following lemma.

Lemma 2 (Characterization lemma for SC_2^\perp). $(A_1, X_1), \dots, (A_n, X_n) \vdash (B, Y)$ is derivable in SC_2^\perp iff for all partitions $(I, J) \in \mathcal{P}(\{1, \dots, n\})$, either $B \Rightarrow \{A_i\}_{i \in I}$ or $\{X_j\}_{j \in J} \Rightarrow Y$ is derivable in LK.

Proof. By induction on n . Base case: $n = 0$. The only partition is (\emptyset, \emptyset) . From derivability of $B \Rightarrow$ or $\Rightarrow Y$ follows $\vdash (B, Y)$ by either (IN) or (OUT); the converse also holds.

Inductive case: from n to $n + 1$. Let $G = \{(A_1, X_1), \dots, (A_{n+1}, X_{n+1})\}$ and consider only derivations in SC_2^\perp in I/O normal form (so the last applied rule can only be (E₂)). We characterize the condition when there exists a derivation of $G \vdash (B, Y)$ whose last rule applied is (E₂) eliminating a pair (A_k, X_k) , for some $k \in \{1, \dots, n + 1\}$. This application leads to two premises: $G' \vdash (B \wedge \neg A_k, Y)$ and $G' \vdash (B, Y \vee \neg X_k)$, where $G' = G \setminus \{(A_k, X_k)\}$. By the inductive hypothesis, the derivability of these premises is equivalent to the derivability of the following sequents: for each $(I', J') \in \mathcal{P}(\{1, \dots, n + 1\} \setminus \{k\})$:

- (a1) $B \wedge \neg A_k \Rightarrow \{A_i\}_{i \in I'}$ or (a2) $\{X_j\}_{j \in J'} \Rightarrow Y$, and
- (b1) $B \Rightarrow \{A_i\}_{i \in I'}$ or (b2) $\{X_j\}_{j \in J'} \Rightarrow Y \vee \neg X_k$.

(a1) is equivalent in LK to (a1)' $B \Rightarrow \{A_i\}_{i \in I' \cup \{k\}}$, and (b2) to (b2)' $\{X_j\}_{j \in J' \cup \{k\}} \Rightarrow Y$. Hence (a1)', (a2) give the required condition for the partition $(I' \cup \{k\}, J')$, while (b1), (b2)' for the partition $(I', J' \cup \{k\})$. \square

The soundness and completeness proof of SC_2^\perp makes use of the admissibility in the calculus of the structural rules for I/O sequents (weakening, contraction, and cut) in Fig. 3. Recall that a rule is *admissible* if its addition does not change the set of sequents that can be derived.

Lemma 3. The rules (IO-Wk), (IO-Ctr) and (IO-Cut) in Fig. 3 are admissible in SC_2^\perp .

Proof. By Lem. 2 we can reduce the admissibility of these structural rules to the admissibility of weakening, contraction, and cut in LK. Consider the case (IO-Cut). Let $G = \{(D_1, W_1) \dots (D_m, W_m)\}$, $G' = \{(A_1, X_1), \dots, (A_n, X_n)\}$ and $(A_{n+1}, X_{n+1}) = (C, Z)$. Now $G, G' \vdash (B, Y)$ is derivable in SC_2^\perp iff for any $(I_1, J_1) \in \mathcal{P}(\{1, \dots, n\})$ and $(I_2, J_2) \in \mathcal{P}(\{1, \dots, m\})$ either $B \Rightarrow \{A_i\}_{i \in I_1}, \{D_i\}_{i \in I_2}$ or $\{X_j\}_{j \in J_1}, \{W_j\}_{j \in J_2} \Rightarrow Y$ is derivable in LK. It is tedious but easy to see that this holds by applying Lem. 2 to the hypotheses $(C, Z), G \vdash (B, Y)$ and $G' \vdash (C, Z)$, and using the structural rules of LK. (Full proof in Appendix B). \square

Theorem 1 (Soundness and completeness of SC_2^\perp). $G \vdash (B, Y)$ is derivable in SC_2^\perp iff (B, Y) is derivable from the pairs in G in OUT_2^\perp .

Proof. (Completeness) Assume that (B, Y) is derivable in OUT_2^\perp . We prove by induction on the derivation tree that for each pair (A, X) occurring in it, the I/O sequent $G \vdash (A, X)$ is derivable in SC_2^\perp . The case $(A, X) \in G$ is:

For (AND): we derive $(B, X_1), (B, X_2) \vdash (B, X_1 \wedge X_2)$, and apply (IO-Cut) twice followed by many applications of contraction to the resulting derivation as follows

The claim follows by Lem 3. (Full proof in Appendix B).
Soundness See Lem. 1 and Fig. 4 for the rule (E₂). \square

3.2 Causal Production Inference OUT_4^\perp

The calculus SC_4^\perp for the causal version of reusable output logic OUT_4^\perp extends the core calculus (consisting of LK with the rules (IN) and (OUT)) with the pair elimination rule (E₄) in Fig. 2.

Inspired by the normal modal logic embedding of OUT_4^\perp in (Bochman 2003), the shape of the rule (E₄) requires to amend the statement of the characterization lemma. The proof of this lemma is similar to the one for SC_2^\perp (See full proof in Appendix B).

Lemma 4 (Characterization lemma for SC_4^\perp). $(A_1, X_1), \dots, (A_n, X_n) \vdash (B, Y)$ is derivable in SC_4^\perp iff for all $(I, J) \in \mathcal{P}(\{1, \dots, n\})$, either $B, \{X_j\}_{j \in J} \Rightarrow \{A_i\}_{i \in I}$ or $\{X_j\}_{j \in J} \Rightarrow Y$ is derivable in LK .

Theorem 2 (Soundness and completeness of SC_4^\perp). $G \vdash (B, Y)$ is derivable in SC_4^\perp iff the pair (B, Y) is derivable from the pairs in G in OUT_4^\perp .

Proof. (Completeness) To derive (CT) in SC_4^\perp we first derive $(A, X), (A \wedge X, Y) \vdash (A, Y)$, and then apply (IO-Cut) and (IO-Ctr) (Fig. 3). The claim follows by the admissibility of these structural rules in SC_4^\perp , which can be reduced to the admissibility of the structural rules in LK as for SC_2^\perp . (Full proof in Appendix B).

(Soundness) Replace in Fig. 4 the subtree that derives $(B \wedge A, Y \vee \neg X)$ from the pair $(B, Y \vee \neg X)$ by the following derivation, which uses the rule (CT)

3.3 Production Inference OUT_1^\perp and Regular Production Inference OUT_3^\perp

The calculi SC_1^\perp and SC_3^\perp for the causal simple-minded output OUT_1^\perp and simple-minded reusable output OUT_3^\perp consist of LK with (IN) and (OUT) extended with the pair elimination rules (E₁) and (E₃) in Fig. 2, respectively.

Remark 3. Unlike OUT_2^\perp and OUT_4^\perp , there is no modal embedding in the literature to provide guidance for the development of the pair elimination rules for OUT_1^\perp and OUT_3^\perp . These rules are instead designed by appropriately modifying (E₂) and (E₄). Indeed OUT_1^\perp and OUT_3^\perp impose restrictions on OUT_2^\perp and OUT_4^\perp , respectively, by prohibiting the combination of inputs. The rules (E₁) and (E₃) are defined by reflecting this limitation.

Due to the LK premise in their peculiar rules, derivations in SC_1^\perp and SC_3^\perp have a simpler form w.r.t. derivations in SC_2^\perp and SC_4^\perp ; this form could be exploited for the soundness and completeness proof. We proceed instead as for the latter calculi by proving the characterization lemma. This

lemma will be key to solve the open problems about computational bounds and modal embeddings for OUT_1^\perp and OUT_3^\perp . The proof of the lemma for \mathcal{SC}_1^\perp and \mathcal{SC}_3^\perp is less straightforward than for the other logics. The intuition here is that the characterization considers all possible ways to apply the rule (E₃) (or (E₁)), by partitioning the premises $(A_1, X_1), \dots, (A_n, X_n)$ into two disjoint sets (I of remaining deriving pairs and J of eliminated pairs). We will focus on the lemma for \mathcal{SC}_3^\perp , the one for \mathcal{SC}_1^\perp being a simplified case (with a very similar proof). Its proof relies on the following result:

Lemma 5. *If $(A, X), G \vdash (B, Y)$ is derivable in \mathcal{SC}_3^\perp , then so is $G \vdash (B \wedge X, Y \vee \neg X)$.*

Proof. Easy induction on the length of the derivation. We proceed by case distinction on the last applied rule. (Full proof in Appendix B). \square

Lemma 6 (Characterization lemma for \mathcal{SC}_3^\perp). *$(A_1, X_1), \dots, (A_n, X_n) \vdash (B, Y)$ is derivable in \mathcal{SC}_3^\perp iff for all $(I, J) \in \mathcal{P}(\{1, \dots, n\})$, one of the following holds:*

- $B, \{X_j\}_{j \in J} \Rightarrow A_i$ is derivable in LK for some $i \in I$,
- $B, \{X_j\}_{j \in J} \Rightarrow$ is derivable in LK,
- $\{X_j\}_{j \in J} \Rightarrow Y$ is derivable in LK.

Proof. (\Rightarrow): Let $(I, J) \in \mathcal{P}(\{1, \dots, n\})$ be any partition. By (several application of) Lem. 5 to each (A_j, X_j) with $j \in J$, we get that the I/O sequent $(*) \{(A_i, X_i) \mid i \in I\} \vdash (B \wedge \bigwedge_{j \in J} X_j, Y \vee \bigvee_{j \in J} \neg X_j)$ is derivable in \mathcal{SC}_3^\perp . We consider the last rule (r) applied in the derivation of $(*)$. Three cases can arise:

- (r) = (E₃) eliminating the deriving pair (A_k, X_k) with $k \in I$; hence $B \wedge \bigwedge_{j \in J} X_j \Rightarrow A_k$ (and therefore $B, \{X_j\}_{j \in J} \Rightarrow A_k$) is derivable in LK,
- (r) = (IN) then $B, \{X_j\}_{j \in J} \Rightarrow$ is derivable in LK.
- (r) = (OUT) then $\{X_j\}_{j \in J} \Rightarrow Y$ is derivable in LK.

(\Leftarrow): We stepwise construct a derivation in \mathcal{SC}_3^\perp of $(A_1, X_1), \dots, (A_n, X_n) \vdash (B, Y)$. We start with $(I, J) = (\{1, \dots, n\}, \emptyset)$, and we distinguish the three cases from the assumption of the lemma: (1) $B, \{X_j\}_{j \in J} \Rightarrow A_i$ for some $i \in I$, (2) $B, \{X_j\}_{j \in J} \Rightarrow$, and (3) $\{X_j\}_{j \in J} \Rightarrow Y$. If either (2) or (3) holds the derivation follows by applying a concluding rule ($J = \emptyset$). If (1) holds, we apply (E₃) bottom up getting $\{(A_t, X_t)\}_{t \in \{1, \dots, n\} \setminus \{i\}} \vdash (B \wedge X_i, Y \vee \neg X_i)$ as the second premise. We now apply the same reasoning to this latter sequent (considering the partition $(I, J) = (\{1, \dots, n\} \setminus \{i\}, \{i\})$), and keep applying it for the second premise of (E₃), until a concluding rule is applied. This will eventually happen since I loses the index of the eliminated pair at each step. \square

The characterization lemma for \mathcal{SC}_1^\perp has the following formulation (the proof is similar to the proof for \mathcal{SC}_3^\perp).

Lemma 7 (Characterization lemma for \mathcal{SC}_1^\perp). *$(A_1, X_1), \dots, (A_n, X_n) \vdash (B, Y)$ is derivable in \mathcal{SC}_1^\perp iff for all partitions $(I, J) \in \mathcal{P}(\{1, \dots, n\})$, at least one of the following holds:*

- $B \Rightarrow A_i$ is derivable in LK for some $i \in I$,
- $B \Rightarrow$ is derivable in LK,
- $\{X_j\}_{j \in J} \Rightarrow Y$ is derivable in LK.

Theorem 3 (Soundness and completeness of \mathcal{SC}_1^\perp and \mathcal{SC}_3^\perp). *$G \vdash (B, Y)$ is derivable in \mathcal{SC}_1^\perp (\mathcal{SC}_3^\perp) iff (B, Y) is derivable from the pairs in G in OUT_1^\perp (OUT_3).*

Proof. (Completeness) uses the admissibility proof of the structural rules in Fig. 3 The case $(A, X) \vdash (A, X)$ is now handled as follows:

$$\frac{A \Rightarrow A \quad \frac{\Rightarrow X \vee \neg X}{\vdash (A, X \vee \neg X)} \text{ (OUT)}}{(A, X) \vdash (A, X)} \text{ (E}_1\text{)}$$

The derivation of the rule (SI) directly uses the premise $B \Rightarrow A$, instead of the rule (IN). (Full proof in Appendix B).

(Soundness): For \mathcal{SC}_1^\perp , the derivation of (E₁) is obtained by juxtaposing to the subderivation of $(B \wedge A, Y)$ from (A, X) and $(B, Y \vee \neg X)$ in Fig. 4 the following

$$\frac{\vdots}{\frac{(B \wedge A, Y)}{(B, Y)} \text{ (SI)}}$$

noticing that the side condition $B \Rightarrow A$ of the rule (E₁) implies that B and $B \wedge A$ are classically equivalent. The soundness of the rule (E₃) is very similar since the translation of the rule (E₄) from the proof of Theorem 2 also contains a sub-derivation of the pair $(B \wedge A, Y)$ from (A, X) and $(B \wedge X, Y \vee \neg X)$ which uses only the rules of OUT_3 ((WO), (SI), (AND) and (CT)). \square

4 Causal I/O Logics vs. Original I/O Logics

We establish a syntactic correspondence between derivability in the original I/O logics and in their causal version. This correspondence obtained utilizing the sequent calculi \mathcal{SC}_1^\perp - \mathcal{SC}_4^\perp , will enable to use them for OUT_1 - OUT_4 , and to transfer all results arising from the calculi for the causal I/O logics to the original I/O logics.

Note that \mathcal{SC}_1^\perp - \mathcal{SC}_4^\perp rely on the axiom (BOT), which is absent in the original I/O logics. An inspection of the soundness proofs for our calculi shows that (BOT) is solely employed in the translation of the rule (IN) (Lemma 1). Can we simply remove this rule and hence get rid of axiom (BOT)? Yes, but only for \mathcal{SC}_1^\perp and \mathcal{SC}_3^\perp , where, as evidenced by the completeness proof, (IN) is used to derive (BOT) and not utilized elsewhere. Hence, by removing the rule (IN) from \mathcal{SC}_1^\perp and \mathcal{SC}_3^\perp we get sequent calculi for OUT_1 and OUT_3 . These calculi are close to the sequent calculi inspired by conditional logics introduced in (Lellmann 2021). The same does not hold for \mathcal{SC}_2^\perp and \mathcal{SC}_4^\perp , where (IN) is needed, e.g., to derive (SI). Instead of developing ad hoc calculi to handle the original I/O logics, we leverage \mathcal{SC}_1^\perp - \mathcal{SC}_4^\perp using the following result:

Theorem 4. $(A_1, X_1), \dots, (A_n, X_n) \vdash_{OUT_k} (B, Y)$
iff $(A_1, X_1), \dots, (A_n, X_n) \vdash_{OUT_k^\perp} (B, Y)$ and
 $X_1, \dots, X_n \models Y$ in classical logic, for each $k = 1, \dots, 4$.

Proof. (\Rightarrow) Derivability in OUT_k implies derivability in the stronger logic OUT_k^\perp . The additional condition $X_1, \dots, X_n \models Y$ can be proved by an easy induction on the length of the derivation in the original I/O logics: it is enough to check that for every rule if the outputs of all (pairs-)premises follow from $X_1 \wedge \dots \wedge X_n$, then so is the output of the (pair-)conclusion.

(\Leftarrow) Consider our sequent calculi $SC_1^\perp - SC_4^\perp$. The translation constructed in their soundness theorem shows how to map a derivation of the I/O sequent $(A_1, X_1), \dots, (A_n, X_n) \vdash (B, Y)$ in SC_k^\perp into a I/O derivation of (B, Y) from the pairs $\{(A_1, X_1), \dots, (A_n, X_n)\}$ using the rules of the logic OUT_k^\perp . As observed before, (BOT) appears in this transformed derivation only inside sub-derivations of the pairs (B', Y') derived in SC_k^\perp by the rule (IN). We can replace every such sub-derivation with a derivation that does not contain the axiom (BOT) and uses only the rules of the weakest logic OUT_1 . This latter derivation relies on the premise $B' \Rightarrow$ of the rule (IN) (which implies $B' \models \perp$), on the condition $X_1 \wedge \dots \wedge X_n \models Y$ from the statement of the lemma and the fact that $Y \models Y'$ since in all our calculi the goal output in the premises of the elimination rules is the same or weaker than the goal output in the conclusion. The required derivation is the following:

$$\frac{\frac{\frac{(A_1, X_1)}{(\perp, X_1)} \text{ (SI)} \quad \dots \quad \frac{(A_n, X_n)}{(\perp, X_n)} \text{ (SI)}}{(\perp, X_1 \wedge \dots \wedge X_n)} \text{ (AND)} \times (n-1)}{\frac{(\perp, Y')}{(B', Y')} \text{ (SI)}} \text{ (WO)}$$

After the replacement of all indicated sub-derivation of (B', Y') with the ones above, we will get a derivation of (B, Y) that does not use the axiom (BOT) and thus (B, Y) is derivable in the original I/O calculus in (Makinson and van der Torre 2000) for OUT_k . \square

Remark 4. *The constructive proof above heavily relies on the restricted form of the I/O derivations resulting from translating our sequent derivations. If at all possible, finding ways to eliminate the use of the (BOT) axiom in arbitrary I/O derivations within OUT_k^\perp would be a challenging task. The power of structural proof theory lies in its capacity to solely examine well-behaved derivations.*

5 Applications

Our proof-theoretic investigation is used here to establish the following results for the original and the causal I/O logics: uniform possible worlds semantics (Sec. 5.1), co-NP-completeness and automated deduction methods (Sec. 5.2), and new embeddings into normal modal logics (Sec. 5.3).

5.1 Possible Worlds Semantics

We provide possible worlds semantics for both the original and the causal I/O logics. Our semantics is a generalization of the bimodels semantics in (Bochman 2004) for OUT_2^\perp ; it turns out to be simpler than them for the remaining causal logics, and than the procedural semantics for the original I/O logics. As we will see, this semantics facilitates clean and uniform solutions to various unresolved inquiries regarding I/O logics that were only partially addressable.

First, notice that a contrapositive reading of the characterization lemmas leads to countermodels for non-derivable statements in all considered causal I/O logics. These countermodels consist of (a partition and) several boolean interpretations (two for OUT_2^\perp, OUT_4^\perp and their causal versions, and $(n+2)$ for OUT_1^\perp, OUT_3^\perp and their causal versions) that falsify the *LK* sequents from the respective lemma statement. We show below that a suitable generalization of these countermodels provides alternative semantic characterizations for both the original and the causal I/O logics.

A possible worlds semantics for the causal I/O logics was introduced by (Bochman 2004) using *bimodels*. For the simplest case of OUT_2^\perp , bimodel is a pair of worlds (here ‘world’ can be seen as a synonym for boolean interpretation) corresponding to input and output states.

Definition 3. (Bochman 2004) *A pair (A, X) is said to be valid in a bimodel (in, out) if $in \models A$ implies $out \models X$.*

The adequacy of this semantics implies, in particular, that $G \vdash_{OUT_2^\perp} (B, Y)$ if and only if the validity of all pairs from G implies validity of (B, Y) for all bimodels. The notion of bimodels for OUT_1^\perp, OUT_3^\perp and OUT_4^\perp is more complex, with input and output states consisting of arbitrary deductively closed sets of formulae, instead of worlds.

To construct our semantics, we look at the countermodels provided by the characterization lemma from the point of view of the simplest bimodels of OUT_2^\perp . Lemma 2 says indeed that if $(A_1, X_1), \dots, (A_n, X_n) \vdash (B, Y)$ is not derivable in SC_2^\perp there is a partition (I, J) , and two boolean interpretations in and out such that: in falsifies the *LK*-sequent $B \Rightarrow \{A_i\}_{i \in I}$ (meaning that $in \models B$ and $in \not\models A_i$ for all $i \in I$) and out falsifies the *LK*-sequent $\{X_j\}_{j \in J} \Rightarrow Y$ (meaning that $out \models X_j$ for all $j \in J$ and $out \not\models Y$). These two interpretations lead to a bimodel that falsifies $(A_1, X_1), \dots, (A_n, X_n) \vdash (B, Y)$; indeed all pairs (A_i, X_i) for $i \in I$ are valid in (in, out) as $in \not\models A_i$, all pairs (A_j, X_j) for $j \in J$ are valid in (in, out) as $out \models X_j$, but (B, Y) is not valid in (in, out) because $in \models B$ and $out \not\models Y$.

Reasoning in a similar way about the countermodels for OUT_1^\perp given by Lem. 7, we observe there are now multiple input worlds, each falsifying in $B \Rightarrow A_i$ the input A_i (plus one additional input world that arises from the sequent $B \Rightarrow$). This leads to the following generalization of bimodels with multiple input worlds.

Definition 4. *An I/O model is a pair (In, out) where out is the output world, and In is a set of input worlds.*

The definition of validity in an I/O model will be modified to require that the input formula is true in all input worlds,

Table 2: Conditions on I/O models (size of the set In of input worlds) and corresponding notions of validity for I/O models.

rather than just in the unique input world. This update ensures that the existence of a single input world falsifying A is enough to establish the validity of the pair (A, X) . Moreover, the additional ability to reuse outputs as inputs in the logics OUT_3^\perp and OUT_4^\perp can be expressed in these models by the requirement that a triggered output X should hold in the input worlds too. This leads to the following two definitions of validity in I/O models – one for the logics OUT_1^\perp and OUT_2^\perp , the other for OUT_3^\perp and OUT_4^\perp .

Definition 5.

- An I/O pair (A, X) is 1-2-valid in an I/O model (In, out) if $(\forall in \in In. in \models A)$ implies $out \models X$.
- An I/O pair (A, X) is 3-4-valid in an I/O model (In, out) if $(\forall in \in In. in \models A)$ implies $(\forall w \in \{out\} \cup In. w \models X)$.

When clear from the context, henceforth we will use the term *validity* to mean either 1-2-validity (hence referring to the logics $\text{OUT}_1, \text{OUT}_2, \text{OUT}_1^\perp$, and OUT_2^\perp) or 3-4-validity (hence referring to $\text{OUT}_3, \text{OUT}_4, \text{OUT}_3^\perp$, and OUT_4^\perp).

Proposition 1 (Semantics for OUT_k^\perp). $G \vdash_{\text{OUT}_k^\perp} (B, Y)$ iff for all I/O models (satisfying the conditions in Tab. 2) validity of all pairs from G implies validity of (B, Y) .

Proof. The proofs rely on the characterization lemmas for each of the four logics. We detail the proof for OUT_3^\perp , the others being similar. The equivalence is proved by negating both statements.

(\Leftarrow) Suppose $(A_1, X_1), \dots, (A_n, X_n) \vdash (B, Y)$ is not derivable in SC_3^\perp (and hence in OUT_3^\perp). We show the existence of a countermodel. By Lem. 6 there exists a partition (I, J) such that the sequents $\{X_j\}_{j \in J} \Rightarrow Y$, $B, \{X_j\}_{j \in J} \Rightarrow$ and $B, \{X_j\}_{j \in J} \Rightarrow A_i$ for all $i \in I$ are not derivable in LK. By the soundness and completeness of LK w.r.t. the classical truth tables semantics there exist:

- an interpretation out , s.t. $out \models X_j \ \forall j \in J$ and $out \not\models Y$,
- an interpretation in_0 , s.t. $in_0 \models B$ and $in_0 \models X_j \ \forall j \in J$,
- for every $i \in I$ an interpretation in_i , s.t. $in_i \models B$, $in_i \models X_j$ for all $j \in J$ and $in_i \not\models A_i$.

Then the I/O model $M = (\{in_0\} \cup \{in_i \mid i \in I\}, out)$ (which has at least one input world) is a countermodel for the derivability of the I/O sequent $(A_1, X_1), \dots, (A_n, X_n) \vdash (B, Y)$. Indeed, every pair (A_i, X_i) for $i \in I$ is 3-4-valid in M since A_i is not true in the input world in_i ; every pair (A_j, X_j) for $j \in J$ is

3-4-valid in M since X_j is true in all worlds of M ; but the pair (B, Y) is not 3-4-valid since B is true in all input worlds, while Y is not true in the output world out .

(\Rightarrow) Let $M = (In, out)$ (with $In \neq \emptyset$) be a countermodel. I.e. M 3-4-validates all pairs $\{(A_1, X_1), \dots, (A_n, X_n)\}$, but does not 3-4-validate the pair (B, Y) . We prove that the sequent $(A_1, X_1) \dots, (A_n, X_n) \vdash (B, Y)$ is not derivable in OUT_3^\perp . We show the existence of a partition (I, J) , such that none of the LK sequents $\{X_j\}_{j \in J} \Rightarrow Y$, $\{X_j\}_{j \in J} \Rightarrow Y$, and $B, \{X_j\}_{j \in J} \Rightarrow$ is derivable. The claim follows then by Lem. 6. For such partition, we chose J as $\{j : \forall in \in In. in \models A_j\}$, and I as the rest of the indices. Notice that X_j is true in all worlds of M for every $j \in J$ by definition of 3-4-validity of (A_j, X_j) . Also, the fact that (B, Y) is not 3-4-valid in M means that B holds in all input worlds, but there exists a world $w^* \in \{out\} \cup In$, s.t. $w^* \not\models Y$. Then:

- $\{X_j\}_{j \in J} \Rightarrow Y$ is not derivable in LK, because this sequent does not hold in the world w^* .
- $B, \{X_j\}_{j \in J} \Rightarrow$ is not derivable in LK, because this sequent does not hold in any input world of M (and there is at least one by the condition $In \neq \emptyset$).
- For any $i \in I$ there exists an input world in_i , s.t. $in_i \not\models A_i$ (by the choice of I). Hence $B, \{X_j\}_{j \in J} \Rightarrow A_i$ is not derivable in LK, as this sequent does not hold in in_i . \square

Dropping the condition of having at least one input world leads to models for the original I/O logics.

Proposition 2 (Semantics for OUT_k). $G \vdash_{\text{OUT}_k} (B, Y)$ iff for all I/O models (satisfying the conditions in Tab. 2) validity of all pairs from G implies validity of (B, Y) .

Proof. By Th. 4, (B, Y) is derivable from $(A_1, X_1), \dots, (A_n, X_n)$ in OUT_k iff it is derivable in OUT_k^\perp together with the additional condition $X_1, \dots, X_n \models Y$. We prove that this additional condition is equivalent to the fact that every model with zero input worlds that validates all pairs from G also validates (B, Y) . Notice that this will prove the proposition, as the only difference between the proposed semantics for a causal I/O logic and the corresponding original one is that the latter additionally considers models with zero input worlds (see Tab. 2).

For both notions of validity, the validity of a pair (A, X) in (\emptyset, out) is equivalent to $out \models X$. Now, $X_1, \dots, X_n \models Y$ means that every interpretation that satisfies every X_i also satisfies Y , which is equivalent to the fact that every model (\emptyset, out) (with arbitrary interpretation out) that validates every (A_i, X_i) also validates (B, Y) . \square

Remark 5. A natural interpretation for the I/O models in the deontic context regards input world(s) as (different possible instances of) the real world, and the output world as the ideal world, where all triggered obligations are fulfilled.

5.2 Complexity and Automated Deduction

We investigate the computational properties of the four original I/O logics and their causal versions. One corollary of our previous results is co-NP-completeness for all of them. Moreover, we can explicitly reduce the entailment problem

in all these logics to the (un-)satisfiability of one classical propositional formula of polynomial size, a thoroughly studied problem with a huge variety of efficient tools available.

Corollary 1. *The entailment problem is a co-NP-complete problem for all eight considered I/O logics.*

Proof. The characterization lemmas for the logics OUT_1^\perp - OUT_4^\perp imply that the non-derivability of a pair from n pairs can be non-deterministically verified in polynomial time by guessing the non-fulfilling partition (consisting of n bits) and then non-deterministically checking the non-derivability of all sequents (at most $(n+2)$) for this partition; the latter task can be done in linear time. For the original I/O logics, by Th. 4 we also need to verify that the additional condition does not hold (guessing a falsifying boolean assignment). Thus, the entailment problem belongs to co-NP for all considered I/O logics. The co-NP-completeness follows by the fact that any arbitrary propositional formula Y is classically valid iff (\top, Y) can be derived from no pairs in any calculus for the considered logics (notice that the additional condition of Th. 4 also boils down to the classical validity of Y). \square

We provide an explicit reduction the derivability in I/O logics to the classical validity. For OUT_2 and OUT_4 this is already contained in (Makinson and van der Torre 2000). Using the semantics introduced in Sec. 5.1, we obtain this result for Bochmann’s causal I/O logics and their original version in a uniform way.

Prop. 1 shows that the underderivability of $G \vdash (B, Y)$ in the causal I/O logics is equivalent to the existence of an I/O model that validates all pairs in G , but does not validate (B, Y) . For OUT_2^\perp and OUT_4^\perp a countermodel should have exactly one input world, while for OUT_1^\perp and OUT_3^\perp there is always one with at most $(|G| + 1)$ input worlds.

We will encode existence of a countermodel to $G \vdash (B, Y)$ with exactly \mathcal{N}_k input worlds (with $\mathcal{N}_k = 1$ for $k = 2, 4$, and $\mathcal{N}_k = |G| + 1$ for $k = 1, 3$) in classical logic. For the encoding, we assign to the input worlds the numbers from 1 to \mathcal{N}_k , and 0 to the output world. Let \mathcal{V} be the finite set of all propositional variables that occur in the formulae of G or (B, Y) . For every variable $x \in \mathcal{V}$, our encoding will use $(\mathcal{N}_k + 1)$ copies of this variable $\{x^0, \dots, x^{\mathcal{N}_k}\}$ with the intuitive interpretation that x^l is true iff x is true in the world number l . For an arbitrary formula A with variables from \mathcal{V} , let us denote by A^l the copy of A in which every variable $x \in \mathcal{V}$ is replaced by its labeled version x^l . We read the formula A^l as “ A is true in the world number l ”. The exact connection with $G \vdash (B, Y)$ is stated below.

Lemma 8. $(A_1, X_1), \dots, (A_n, X_n) \vdash_{\text{OUT}_k^\perp} (B, Y)$ iff the classical propositional formula $\neg \mathcal{P}_n^k((B, Y)) \wedge \bigwedge_{(A, X) \in G} \mathcal{P}_n^k((A, X))$ is unsatisfiable,

where

- $\mathcal{P}_n^k((A, X)) = \left(\bigwedge_{l=1}^{\mathcal{N}_k} A^l \right) \rightarrow X^0$ for $k = 1, 2$
- $\mathcal{P}_n^k((A, X)) = \left(\bigwedge_{l=1}^{\mathcal{N}_k} A^l \right) \rightarrow \left(\bigwedge_{l=0}^{\mathcal{N}_k} X^l \right)$ for $k = 3, 4$

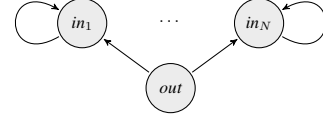


Figure 5: Kripke countermodel construction for I/O model $(\{in_1, \dots, in_N\}, out)$. Arrows represent the accessibility relation.

Proof. We prove the contrapositive version.

(\Rightarrow) Let \mathcal{V}^L the set of all labeled copies of variables in \mathcal{V} ($\mathcal{V}^L = \{x^l \mid x \in \mathcal{V}, l \in \{0, \dots, \mathcal{N}_k\}\}$). Suppose there is a valuation $v: \mathcal{V}^L \rightarrow \{0, 1\}$, that satisfies the formula in the statement (i.e., $v \models \mathcal{P}_n^k((A, X))$ for all $(A, X) \in G$ and $v \not\models \mathcal{P}_n^k((B, Y))$). v can be decomposed into $(\mathcal{N}_k + 1)$ valuations $v_l: \mathcal{V} \rightarrow \{0, 1\}$, one for each label ($v_l(x) = v(x^l)$). It is easy to see that (*): For every formula A with variables in \mathcal{V} , $v \models A^l$ iff $v_l \models A$ (it can be proven by trivial induction). The valuations $\{v_l\}$ can then be turned into an I/O model $M = (\{v_1, \dots, v_{\mathcal{N}_k}\}, v_0)$. Then using the reading of $v \models A^l$ given by (*) we can see that $v \models \mathcal{P}_n^k((A, X))$ (for $k = 1, 2$) iff (A, X) is 1-2-valid in M , and $v \models \mathcal{P}_n^k((A, X))$ (for $k = 3, 4$) iff (A, X) is 3-4-valid in M . Therefore, since v satisfies the formula in the statement, M validates all pairs from G and does not validate (B, Y) , which implies that $G \vdash (B, Y)$ is not derivable in OUT_k^\perp .

(\Leftarrow) Here instead of decomposing a valuation of labeled variables into $(\mathcal{N}_k + 1)$ worlds, we use a countermodel $(\{in_1, \dots, in_{\mathcal{N}_k}\}, out)$ to define a valuation $v: \mathcal{V}^L \rightarrow \{0, 1\}$ of labeled variables (with $v(x^0) = out(x)$ and $v(x^l) = in_l(x)$). The proof proceeds as in the other direction. \square

The result is extended to the original I/O logics via Th. 4.

Lemma 9. $(A_1, X_1), \dots, (A_n, X_n) \vdash_{\text{OUT}_k} (B, Y)$ iff the classical propositional formula $\mathcal{F}_n^k \vee (\neg Y \wedge \bigwedge_{i=1}^n X_i)$ is unsatisfiable, where \mathcal{F}_n^k is the formula encoding derivability of $(A_1, X_1), \dots, (A_n, X_n) \vdash (B, Y)$ in OUT_k^\perp from Lem. 8.

Proof. The disjunct $(\neg Y \wedge (X_1 \wedge \dots \wedge X_n))$ arises from Th. 4 (derivability in OUT_k is equivalent to derivability in OUT_k^\perp and the classical entailment of Y from $\{X_i\}_{i=1}^n$). The claim follows by Lem. 8. \square

5.3 Embeddings into Normal Modal Logics

We provide uniform embeddings into normal modal logics. The embeddings are a corollary of soundness and completeness of I/O logics w.r.t. I/O models.

More precisely we show that $G \vdash (B, Y)$ in I/O logics iff a certain sequent consisting of shallow formulae only (meaning that the formulae do not contain nested modalities) is valid in suitable normal modal logics. To do that we establish a correspondence between pairs and shallow formulae.

The I/O models already use the terminology of Kripke semantics that define normal modal logic. To establish a precise link between the two semantics we need only to define the accessibility relation on worlds. We will treat the set of input worlds In as the set of worlds accessible from the output world out (see Fig. 5). Under this view on input

worlds, 1-2-validity (resp. 3-4-validity) of the pair (A, X) is equivalent to the truth of the modal formula $\Box A \rightarrow X$ (resp. $\Box A \rightarrow X \wedge \Box X$) in the world *out*.

Also, the conditions on the number of input worlds that are used in Prop. 1 and Prop 2 to distinguish different I/O logics can be expressed in normal modal logics by standard Hilbert axioms. Specifically, axiom **D**: $\Box A \rightarrow \Diamond A$ forces Kripke models to have at least one accessible world, while **F**: $\Diamond A \rightarrow \Box A$ forces them to have at most one accessible world. As proved below, the embedding works for the basic modal logic **K** extended with **D** (which results in the well-known standard deontic logic (von Wright 1951) **KD**), with **F**, or both axioms.

Henceforth we abbreviate, e.g., validity in the logics **K** (respectively **K + F**) with $\models_{\mathbf{K}/\mathbf{K}+\mathbf{F}}$.

Theorem 5. (B, Y) is derivable from pairs G in

- OUT_1 and OUT_2 iff $G_{1/2}^\Box \models_{\mathbf{K}/\mathbf{K}+\mathbf{F}} \Box B \rightarrow Y$
- OUT_3 and OUT_4 iff $G_{3/4}^\Box \models_{\mathbf{K}/\mathbf{K}+\mathbf{F}} \Box B \rightarrow Y \wedge \Box Y$
- OUT_1^\perp and OUT_2^\perp iff $G_{1/2}^\Box \models_{\mathbf{KD}/\mathbf{KD}+\mathbf{F}} \Box B \rightarrow Y$
- OUT_3^\perp and OUT_4^\perp iff $G_{3/4}^\Box \models_{\mathbf{KD}/\mathbf{KD}+\mathbf{F}} \Box B \rightarrow Y \wedge \Box Y$

where $G_{1/2}^\Box = \{\Box A_i \rightarrow X_i \mid (A_i, X_i) \in G\}$,

and $G_{3/4}^\Box = \{\Box A_i \rightarrow X_i \wedge \Box X_i \mid (A_i, X_i) \in G\}$.

Proof. We show these equivalences by transforming the I/O countermodels given by Prop. 1 and Prop. 2 into Kripke countermodels for the corresponding modal logic and vice versa. The transformations will be the same for all the considered logics. We detail the case of OUT_3^\perp .

(\Leftarrow) Assume $G_3^\Box \models_{\mathbf{KD}} \Box B \rightarrow Y \wedge \Box Y$ does not hold. Then there should exist a Kripke model M in which every world has at least one world accessible from it, and a world w in M , such that $w \models \Box A \rightarrow X \wedge \Box X$ for every $(A, X) \in G$ and $w \not\models \Box B \rightarrow Y \wedge \Box Y$. Let $N(w)$ be the set of all worlds accessible from w in M . Then the I/O model $(N(w), w)$ will be a countermodel for $G \vdash (B, Y)$; notice indeed that $w \models \Box A \rightarrow X \wedge \Box X$ means exactly 3-4-validity of (A, X) in $(N(w), w)$, so all pairs in G are 3-4-valid in $(N(w), w)$, but (B, Y) is not 3-4-valid, and $|N(w)| \geq 1$. Hence $G \vdash (B, Y)$ is not derivable in OUT_3^\perp .

(\Rightarrow) Assume $G \vdash (B, Y)$ is not derivable in OUT_3^\perp . Then there is some I/O model (In, out) with $|In| \geq 1$, s.t. all pairs from G are 3-4-valid in (In, out) and (B, Y) is not 3-4-valid in (In, out) . Consider the Kripke model M that consists of worlds $In \cup \{out\}$ with accessibility relation defined as shown in Fig. 5 (all input worlds are accessible from the output world and every input world is accessible from itself). M satisfies the frame condition for **KD** as there is at least one accessible world from *out* because of $|In| \geq 1$, and exactly one accessible world for every input world (itself). *out* satisfies the modal formula $A \rightarrow X \wedge \Box X$ (with A and X being propositional formulae) in the Kripke model M iff the I/O pair (A, X) is 3-4-valid in (in, out) . So in M , $out \models A \rightarrow X \wedge \Box X$ for every pair $(A, X) \in G$ and $out \not\models B \rightarrow Y \wedge \Box Y$. Therefore $G_3^\Box \models_{\mathbf{KD}} \Box B \rightarrow Y \wedge \Box Y$ does not hold. \square

Remark 6. Modal embeddings were already known for the causal logics OUT_2^\perp and OUT_4^\perp . The embedding for OUT_2^\perp was translating the pair (A, X) into the **K** formula $A \rightarrow \Box X$. In (Makinson and van der Torre 2000) this embedding was stated for OUT_2 and OUT_4 together with the additional condition $X_1, \dots, X_n \models Y$ (appearing in our Th. 4). Note that moving the modality to inputs allows for a more refined embedding. The validity of the statement $(A \rightarrow \Box X), \dots, (A \rightarrow \Box X) \models (B \rightarrow \Box Y)$ is indeed the same in all four target logics we use (**K**, **KD**, **K + F** and **KD + F**), while the validity of $(\Box A \rightarrow X), \dots, (\Box A \rightarrow X) \models (\Box B \rightarrow Y)$ is different.

6 Conclusions

We have introduced sequent calculi for I/O logics. Our calculi provide a natural syntactic connection between derivability in the four original I/O logic (Makinson and van der Torre 2000) and in their causal version (Bochman 2004). Moreover, the calculi yield natural possible worlds semantics, complexity bounds, embeddings into normal modal logics, as well as efficient deduction methods. It is worth noticing that our methods for the entailment problem offer derivability certificates (i.e., derivations) or counter-models as solutions. The efficient discovery of the latter can be accomplished using SAT solvers, along the line of (Lahav and Zohar 2014). The newly introduced possible worlds semantics might be used to import in I/O logics tools and results from standard modal theory.

Our work encompasses many scattered results and presents uniform solutions to various unresolved problems; among them, it contains first proof-search oriented calculi for OUT_2^\perp and OUT_4^\perp ; it provides a missing⁴ direct formal connection between the semantics of the original and the causal I/O logics; it introduces a uniform embedding into normal modal logics, that also applies to OUT_1 and OUT_3 , despite the absence in these logics of the (OR) rule⁵; moreover, it settles the complexity of the logics OUT_3 and OUT_3^\perp . The latter logic has been used in (Bochman 2018) as the base for actual causality and in (Bochman 2004), together with OUT_4^\perp , to characterize strong equivalence of causal theories w.r.t. two different semantics: general and causal non-monotonic semantics. Strong equivalence is an important notion as theories satisfying it are ‘equivalent forever’, that is, they are interchangeable in any larger causal theory without changing the general/causal non-monotonic semantics. Furthermore

OUT₄ has been used as a base for formalizing legal concepts (Ciabattani, Parent, and Sartor 2021). The automated deduction tools we have provided might be used also in these contexts.

In this paper, we have focused on *monotonic I/O* logics. However, due to their limitations in addressing different aspects of causal reasoning (Bochman 2021) and of normative reasoning, several non-monotonic extensions have been introduced. For example (Makinson and van der Torre 2001; Parent and van der Torre 2014) have proposed non-monotonic extensions that have also been applied to represent and reason about legal knowledge bases, as demonstrated in the work by Robaldo et al. (Robaldo et al. 2020). Our new perspective on the monotonic I/O logics contributes to increase their understanding and can provide a solid foundation for exploring non-monotonic extensions.

A LK sequent calculus

The sequent calculus LK is a deductive system for (first-order) classical logic, introduced by (Gentzen 1934). Its basic objects are sequents, that are derivability assertions of the form

$$A_1, \dots, A_n \Rightarrow B_1, \dots, B_m,$$

where $\{A_1, \dots, A_n\}$ and $\{B_1, \dots, B_m\}$ are multisets of formulae (assumptions, and conclusions, respectively).

Axioms and rules of (the propositional fragment of) LK are as follows (Γ and Δ denote arbitrary multisets of formulae):

$$\begin{array}{c} \frac{}{\Gamma, x \Rightarrow x, \Delta} \text{ (AX)} \quad \frac{}{\Gamma, \perp \Rightarrow \Delta} \text{ (\(\perp\) L)} \quad \frac{}{\Gamma \Rightarrow \top, \Delta} \text{ (\(\top\) R)} \\ \\ \frac{\Gamma, A, B \Rightarrow \Delta}{\Gamma, A \wedge B \Rightarrow \Delta} \text{ (\(\wedge\) L)} \quad \frac{\Gamma \Rightarrow A, \Delta \quad \Gamma \Rightarrow B, \Delta}{\Gamma \Rightarrow A \wedge B, \Delta} \text{ (\(\wedge\) R)} \\ \\ \frac{\Gamma, A \Rightarrow \Delta \quad \Gamma, B \Rightarrow \Delta}{\Gamma, A \vee B \Rightarrow \Delta} \text{ (\(\vee\) L)} \quad \frac{\Gamma \Rightarrow A, B, \Delta}{\Gamma \Rightarrow A \vee B, \Delta} \text{ (\(\vee\) R)} \\ \\ \frac{\Gamma \Rightarrow A, \Delta \quad \Gamma, B \Rightarrow \Delta}{\Gamma, A \rightarrow B \Rightarrow \Delta} \text{ (\(\rightarrow\) L)} \quad \frac{\Gamma, A \Rightarrow B, \Delta}{\Gamma \Rightarrow A \rightarrow B, \Delta} \text{ (\(\rightarrow\) R)} \end{array}$$

Definition 6. A derivation in LK is a finite labelled tree whose internal nodes are labelled with sequents s.t. the label of each non-leaf node follows from the labels of its children using the calculus rules and leafs are axioms of the calculus. We say that a sequent $A_1, \dots, A_n \Rightarrow B_1, \dots, B_m$ is derivable in LK, if there is a derivation in LK with this sequent as the root label.

There are several known equivalent formulation of LK. The version we have presented is the one known as G3p. In this version, the standard structural rules in Fig. 6 are admissible (i.e. addition of these rules to the calculus does not change the set of sequents that can be derived). This makes the resulting derivations particularly well behaved as: (1) they can be constructed by safely applying the calculus rules bottom up, and (2) they satisfy the subformula property: all formulae occurring in a derivation are subformulae of the sequent to be proved.

Theorem 6 (Gentzen). A sequent $A_1, \dots, A_n \Rightarrow B_1, \dots, B_m$ is derivable in LK iff $A_1, \dots, A_n \models B_1 \vee \dots \vee B_m$ in classical logic.

B Detailed Proofs

Lemma 3. *Rules (IO-Wk), (IO-Ctr) and (IO-Cut) are admissible for the calculus SC_2^\perp .*

Proof. We will use the characterization from Lem. 2 to prove the admissibility for all three rules by reducing them to the admissibility of the corresponding rules in LK.

Weakening. Let $G = \{(A_1, X_1), \dots, (A_n, X_n)\}$. Denote $(A_{n+1}, X_{n+1}) = (A, X)$. Suppose $G \vdash (B, Y)$ is derivable. Then for every partition $(I, J) \in \mathcal{P}(\{1, \dots, n\})$,

$$\text{either } B \Rightarrow \{A_i\}_{i \in I} \text{ or } \{X_j\}_{j \in J} \Rightarrow Y \text{ is derivable in LK.}$$

We can weaken the left sequent by adding the formula A_{n+1} on the right:

$$\text{either } B \Rightarrow \{A_i\}_{i \in I}, A_{n+1} \text{ or } \{X_j\}_{j \in J} \Rightarrow Y \text{ is derivable in LK.}$$

Analogously, we can weaken the right sequent by adding the formula X_{n+1} on the left:

$$\text{either } B \Rightarrow \{A_i\}_{i \in I} \text{ or } \{X_j\}_{j \in J}, X_{n+1} \Rightarrow Y \text{ is derivable in LK.}$$

Notice that these two statements give exactly the characterization of derivability of $(A, B), G \vdash (B, Y)$ by Lem. 2 (first one for the partitions that have index $(n+1)$ in I , and second for the partitions that have index $(n+1)$ in J).

Contraction. Let $G = \{(A_1, X_1), \dots, (A_n, X_n)\}$. Suppose $(A, X), (A, X), G \vdash (B, Y)$ is derivable. Let's denote $(A_{n+1}, X_{n+1}) = (A_{n+2}, X_{n+2}) = (A, X)$ to have all pairs indexed for characterisation.

Consider the partitions from $\mathcal{P}(\{1, \dots, n+2\})$ that have the form $(I \cup \{n+1, n+2\}, J)$. For any such partition, we have

$$\text{either } B \Rightarrow \{A_i\}_{i \in I}, A, A \text{ or } \{X_j\}_{j \in J} \Rightarrow Y \text{ is derivable in LK.}$$

After rewriting the first sequent into $B \Rightarrow \{A_i\}_{i \in I}, A$ using the classical contraction this condition turns exactly into the condition of the characterization for $(A, X), G \vdash (B, Y)$ (which has $(n+1)$ pairs on the left) for the partition $(I \cup \{n+1\}, J)$.

Now consider the partitions from $\mathcal{P}(\{1, \dots, n+2\})$ that have the form $(I, J \cup \{n+1, n+2\})$. For any such partition, we have

$$\text{either } B \Rightarrow \{A_i\}_{i \in I} \text{ or } \{X_j\}_{j \in J}, X, X \Rightarrow Y \text{ is derivable in LK.}$$

After rewriting the second sequent into $\{X_j\}_{j \in J}, X \Rightarrow Y$ using classical contraction this condition turns exactly into the condition of the characterization for $(A, X), G \vdash (B, Y)$ for partition $(I, J \cup \{n+1\})$.

Notice that these two cases cover all partitions from $\mathcal{P}(\{1, \dots, n+1\})$, so $(A, X), G \vdash (B, Y)$ is derivable.

Cut. Let $G = \{(D_1, W_1), \dots, (D_m, W_m)\}$ and $G' = \{(A_1, X_1), \dots, (A_n, X_n)\}$ and denote $(A_{n+1}, X_{n+1}) = (C, Z)$. For derivability of $G, G' \vdash (B, Y)$ we need to show that for any partition $(I_1, J_1) \in \mathcal{P}(\{1, \dots, n\})$ and any partition $(I_2, J_2) \in \mathcal{P}(\{1, \dots, m\})$ the following holds:

$$(*) \text{ either } B \Rightarrow \{A_i\}_{i \in I_1}, \{D_i\}_{i \in I_2} \text{ or } \{X_j\}_{j \in J_1}, \{W_j\}_{j \in J_2} \Rightarrow Y \text{ is derivable in LK.}$$

We first use that $(C, Z), G \vdash (B, Y)$ is derivable. First, we use characterization lemma for the partition $(I_1 \cup \{n+1\}, J_1)$ (so from the additional pair (C, Z) , C goes to the inputs):

$$(1) \text{ either } B \Rightarrow \{A_i\}_{i \in I_1}, C \text{ or } \{X_j\}_{j \in J_1} \Rightarrow Y \text{ is derivable in LK.}$$

Second, we use the characterization lemma for the partition $(I_1, J_1 \cup \{n+1\})$ (so from the additional pair (C, Z) , Z goes to the outputs):

$$(2) \text{ either } B \Rightarrow \{A_i\}_{i \in I_1} \text{ or } \{X_j\}_{j \in J_1}, Z \Rightarrow Y \text{ is derivable in LK.}$$

Now we use the derivability of $G' \vdash (C, Z)$. We use the characterization lemma for the partition (I_2, J_2) :

$$(3) \text{ either } C \Rightarrow \{D_i\}_{i \in I_2} \text{ or } \{W_j\}_{j \in J_2} \Rightarrow Z \text{ is derivable in LK.}$$

Now we show that for any possible choice of derivable sequent (left or right) in (1), (2) and (3), we can always derive one of the sequents of (*) (either by weakening or cut in LK):

- If the right sequent of (1) is derivable, then the right sequent of (*) is derivable by weakening in LK.
- If the left sequent of (2) is derivable, then the left sequent of (*) is derivable by weakening in LK.
- If the left sequent of (3) is derivable and the left sequent of (1) is derivable, we can use the LK cut on them and get exactly the left sequent of (*).

- If the right sequent of (3) is derivable and the right sequent of (2) is derivable, we can cut them using the LK cut and get exactly the right sequent of (*).

Thus, we have proved (*) for all possible cases. \square

Theorem 1 (Soundness and completeness of SC_2^\perp). $G \vdash (B, Y)$ is derivable in SC_2^\perp iff the pair (B, Y) is derivable from the pairs in G in OUT_2^\perp .

Proof.

Completeness. Proven constructively by induction on I/O derivation in OUT_2^\perp .

Suppose we have a derivation of (B, Y) from pairs G in OUT_2^\perp . We prove by induction on this derivation that for each occurring pair (A, X) , the derivability statement $G \vdash (A, X)$ is derivable in SC_2^\perp .

For the base case when the pair (A, X) belongs to G' (and so $G = \{(A, X)\} \cup G'$ for some G') we have the following derivation.

For I/O rules with zero premises ((TOP) and (BOT)), we have the following derivations.

For I/O rules with one premise and a side condition of classical entailment (the rules (WO) and (SI)) we take the following derivations that apply cut to the inductive hypothesis. Notice the LK sequents in the derivations marked by the blue color. These sequents are derivable because they are equivalent to the side condition of a considered I/O rule ($X \models Y$ for (WO), and $B \models A$ for (SI)).

For (WO):

For the rules with two premises ((AND) and (OR)) we use the following derivations.

For (AND):

For (OR):

$$\frac{\frac{(A_1 \vee A_2) \wedge \neg A_1 \wedge \neg A_2 \Rightarrow}{\vdash ((A_1 \vee A_2) \wedge \neg A_1 \wedge \neg A_2, Y)} \text{ (IN)} \quad \frac{\Rightarrow Y \vee \neg Y}{\vdash ((A_1 \vee A_2) \wedge \neg A_1, Y \vee \neg Y)} \text{ (OUT)}}{(A_2, Y) \vdash ((A_1 \vee A_2) \wedge \neg A_1, Y)} \text{ (E}_2\text{)} \quad \frac{\Rightarrow Y \vee \neg Y}{(A_2, Y) \vdash (A_1 \vee A_2, Y \vee \neg Y)} \text{ (OUT)} \\ \hline (A_1, Y), (A_2, Y) \vdash (A_1 \vee A_2, Y) \text{ (E}_2\text{)}$$

We afterwards cut these derivations twice with both inductive hypotheses and use contraction to remove duplicate pairs from the result. We show how to do it for (AND) (for (OR) it is exactly the same):

Soundness.

Proven constructively by induction on derivations in SC_2^\perp .

Inductive base: the rules (IN) and (OUT).

If $B \Rightarrow$ (which means $B \models \perp$ in classical logic) we have the following I/O derivation for the required pair (B, Y) in OUT_2^\perp .

The inductive step is the rule (E₂). By inductive hypotheses we have that both pairs $(B \wedge \neg A, Y)$ and $(B, Y \vee \neg X)$ are derivable from pairs G in OUT_2^\perp . We now need to prove that (B, Y) is derivable from the pairs in $G \cup \{(A, X)\}$. We do it with the following I/O derivation of the pair (B, Y) from the pairs (A, X) , $(B \wedge \neg A, Y)$ and $(B, Y \vee \neg X)$ in the logic OUT_2^\perp . If you take it and plug in the derivations of $(B \wedge \neg A, Y)$ and $(B, Y \vee \neg X)$ from G obtained by the inductive hypotheses you will get the required derivation from $G \cup \{(A, X)\}$.

Lemma 4. $(A_1, X_1), \dots, (A_n, X_n) \vdash (B, Y)$ is derivable in SC_4^\perp iff for all partitions $(I, J) \in \mathcal{P}(\{1, \dots, n\})$, either $B, \{X_j\}_{j \in J} \Rightarrow \{A_i\}_{i \in I}$ or $\{X_j\}_{j \in J} \Rightarrow Y$ is derivable in LK.

Proof. Analogous to the proof of Lem. 2. The only difference is that the sequents that we have in the conditions for derivability obtained from the inductive hypothesis applied to premises in the inductive step are different (due to modifications in both pair elimination rule and characterization statement). Specifically, the existence of the derivation that starts with the application of the rule (E₄) that eliminates a pair (A_k, X_k) , is equivalent (by applying inductive hypothesis to the premises) to the derivability of the following sequents for all $(I', J') \in \mathcal{P}(\{1, \dots, n+1\} \setminus \{k\})$:

- (a1) $B \wedge \neg A_k, \{X_j\}_{j \in J'} \Rightarrow \{A_i\}_{i \in I'}$ or (a2) $\{X_j\}_{j \in J'} \Rightarrow Y$
- (b1) $B \wedge X_k, \{X_j\}_{j \in J'} \Rightarrow \{A_i\}_{i \in I'}$ or (b2) $\{X_j\}_{j \in J'} \Rightarrow Y \vee \neg X_k$

But these two modifications complement each other: they both introduce deriving outputs on the left side of the first sequent. Therefore when moving A_k and X_k to the other deriving inputs/outputs, we are also able to move X_k from $B \wedge X_k$ to $\{X_j\}_{j \in J'}$ on the same side. This way we again get two equivalent conditions for every $(I', J') \in \mathcal{P}(\{1, \dots, n+1\} \setminus \{k\})$:

- (a1) $B, \{X_j\}_{j \in J'} \Rightarrow \{A_i\}_{i \in I' \cup \{k\}}$ or (a2) $\{X_j\}_{j \in J'} \Rightarrow Y$
- (b1) $B, \{X_j\}_{j \in J' \cup \{k\}} \Rightarrow \{A_i\}_{i \in I'}$ or (b2) $\{X_j\}_{j \in J' \cup \{k\}} \Rightarrow Y$

Which gives exactly the statement of the lemma. \square

Lemma 10. *If $G \vdash (B, Y)$ is derivable in SC_2^\perp it is also derivable in SC_4^\perp .*

Proof. We prove the more general statement: if $G \vdash (B, Y)$ is derivable in SC_2^\perp then for any B' such that $B' \models B$ in classical logic, $G \vdash (B', Y)$ is also derivable in SC_4^\perp .

The proof proceeds by induction on the derivation of $G \vdash (B, Y)$ in SC_2^\perp .

- If $G \vdash (B, Y)$ is derived by the rule (IN) then $B \Rightarrow$ is derivable in LK, so $B' \Rightarrow$ is also derivable in LK and $G \vdash (B', Y)$ can be derived in OUT_4 by (IN).
- If $G \vdash (B, Y)$ is derived by the rule (OUT) then $\Rightarrow Y$ is derivable in LK, so $G \vdash (B', Y)$ can be derived in SC_4^\perp by (OUT).
- Suppose $G \vdash (B, Y)$ is derived by the rule (E₂) from the premises $G' \vdash (B \wedge \neg A, Y)$ and $G' \vdash (B, Y \vee \neg X)$ for some pair (A, X) such that $G = G' \cup (A, X)$. By the inductive hypotheses $G' \vdash (B' \wedge \neg A, Y)$ and $G' \vdash (B' \wedge X, Y \vee \neg X)$ are derivable in SC_4^\perp (since from $B' \models B$ follows that $B' \wedge \neg A \models B \wedge \neg A$ and $B' \wedge X \models B$ classically). We then can derive $G \vdash (B', Y)$ in SC_4^\perp from these premises by (E₄).

\square

Lemma 11. *The rules (IO-Wk), (IO-Ctr) and (IO-Cut) are admissible in the calculus SC_4^\perp .*

Proof. Analogous to the proof 1 of Lem. 3. By the characterization lemma (Lem. 4) the difference is that the output part $\{X_j\}_{j \in J}$ appear on the left of the first sequent. This does not affect the proof of admissibility of (IO-Wk) and (IO-Ctr) — weakening and contraction from LK can be applied on the left where the additional formulae appear the same way as in other parts to reduce the sequents to the required form.

For (IO-Cut) rule admissibility there is one additional LK cut that may be required in one of the cases. Specifically to prove admissibility of (IO-Cut) following the proof 1 of Lemma 3 we have to prove the following characterization statement for any partition $(I_1, J_1) \in \mathcal{P}(\{1, \dots, n\})$ and partition $(I_2, J_2) \in \mathcal{P}(\{1, \dots, m\})$.

(*) *either $B, \{X_j\}_{j \in J_1}, \{W_j\}_{j \in J_2} \Rightarrow \{A_i\}_{i \in I_1}, \{D_i\}_{i \in I_2}$ or $\{X_j\}_{j \in J_1}, \{W_j\}_{j \in J_2} \Rightarrow Y$ is derivable in LK.*

Again, we first get the following statement by applying characterization lemma to the derivation of $(C, Z), G \vdash (B, Y)$ for the partition $(I_1 \cup \{n+1\}, J_1)$:

(1) *either $B, \{X_j\}_{j \in J_1} \Rightarrow \{A_i\}_{i \in I_1}, C$ or $\{X_j\}_{j \in J_1} \Rightarrow Y$ is derivable in LK.*

Second, we get the following statement by applying the characterization lemma to the derivation of $(C, Z), G \vdash (B, Y)$ for the partition $(I_1, J_1 \cup \{n+1\})$:

(2) *either $B, Z, \{X_j\}_{j \in J_1} \Rightarrow \{A_i\}_{i \in I_1}$ or $Z, \{X_j\}_{j \in J_1} \Rightarrow Y$ is derivable in LK.*

Third, we get the following statement by applying the characterization lemma to the derivation of $G' \vdash (C, Z)$ for the partition (I_2, J_2) :

(3) *either $C, \{W_j\}_{j \in J_2} \Rightarrow \{D_i\}_{i \in I_2}$ or $\{W_j\}_{j \in J_2} \Rightarrow Z$ is derivable in LK.*

Now we show that for any possible choice of derivable sequent (left or right) in (1), (2) and (3), we can always derive one of the sequents of (*) (either by weakening or by cut in LK):

- If the right sequent of (1) is derivable, then the right sequent of (*) is derivable by weakening in LK.
- If the left sequent of (1) is derivable and the left sequent of (3) is derivable, we can cut them using the LK cut and get exactly the left sequent of (*).
- If the right sequent of (3) is derivable and the left sequent of (2) is derivable, we can cut them using the LK cut and weaken the result to get the left sequent of (*).
- If the right sequent of (3) is derivable and the right sequent of (2) is derivable, we can cut them using the LK cut and get exactly the right sequent of (*).

Thus, we have proved (*) for all possible cases. \square

Theorem 2. $G \vdash (B, Y)$ is derivable in SC_4^\perp iff (B, Y) is derivable from the pairs in G in OUT_4^\perp .

Proof. Analogous to the proof 1 of the Th. 1.

Completeness.

We need to check the derivability of all rules of OUT_4^\perp in SC_4^\perp . While this can be done directly, we also can use the derivability of all axioms OUT_2^\perp in SC_2^\perp , that was proven in the proof 1 of Lem. ??, and the additional simple fact that anything derivable in SC_2^\perp is also derivable in SC_4^\perp (lemma 10).

Then the only rule of OUT_4^\perp left to check is the peculiar rule (CT). Its derivation in SC_4^\perp is given below.

Then this derivations of OUT_4^\perp rules are combined using structural rules to build a derivation in SC_4^\perp analogously to the proof 1 of Th. 1. Admissibility of structural rules in SC_4^\perp is given by Lem. 11.

Soundness.

Analogous to the proof 1 of Th. 1. The soundness of the rule (E₄) in SC_4^\perp is given by the following derivation.

Lemma 5. If $(A, X), G \vdash (B, Y)$ is derivable in SC_3^\perp , then $G \vdash (B \wedge X, Y \vee \neg X)$ is also derivable SC_3^\perp .

Proof. By induction on the derivation of $(A, X), G \vdash (B, Y)$ in SC_3^\perp .

- Suppose $(A, X), G \vdash (B, Y)$ is derived by the rule (IN). Then $B \Rightarrow$ is derivable in LK, so $B \wedge X \Rightarrow$ is also derivable in LK and $G \vdash (B \wedge X, Y \vee \neg X)$ can be also derived by the rule (IN).
- Suppose $(A, X), G \vdash (B, Y)$ is derived by the rule (OUT). Then $\Rightarrow Y$ is derivable in LK, so $\Rightarrow Y \vee \neg X$ is also derivable in LK and $G \vdash (B \wedge X, Y \vee \neg X)$ can be also derived by the rule (OUT).
- If $(A, X), G \vdash (B, Y)$ is derived by elimination of the pair (A, X) with the rule (E₃), than there is a derivation of the premise $G \vdash (B \wedge X, Y \vee \neg X)$.
- Suppose $(A, X), G \vdash (B, Y)$ is derived by elimination of some other pair (A', X') with the rule (E₃) ($G = \{(A', X')\} \cup G'$ for some G'). The first premise is then $B \Rightarrow A'$, which infers $B \wedge X \models A'$. The second premise is $(A, X), G' \vdash (B \wedge X', Y \vee \neg X')$ to which we can apply the inductive hypothesis to get a derivation of $G' \vdash (B \wedge X' \wedge X, Y \vee \neg X' \vee \neg X)$. The required sequent can be derived as follows:

Lemma 12. The rules (IO-Wk), (IO-Ctr) and (IO-Cut) are admissible for the calculi SC_1^\perp and SC_3^\perp .

Proof. Analogous to the proof of Lemma 3 for the calculus SC_2^\perp and its analogue for the calculus SC_4^\perp . The difference is that the characterization lemma in the case of SC_1^\perp and SC_3^\perp does not have only two, but $(|I| + 2)$ LK-sequents one of which should be derivable for each partition (I, J) . However the form of these sequents is the same, so the structure of the proof does not change.

For admissibility of weakening and contraction the modification is minimal: instead of applying the LK rules of weakening and contraction to add/duplicate the formula A (for weakened/contracted pair (A, X)) we add/duplicate the whole separate sequent that has A on the right. Since the characterization statement requires at least one of the sequents to be derivable, addition of a new sequent or duplication of the existing sequent results in a statement that is weaker (or equivalent), as needed.

We will now show how LK cuts (and weakenings) should be applied to establish cut admissibility in SC_3^\perp (case of SC_1^\perp is exactly the same, but the sequents are simpler, since they do not have additional outputs on the left).

Using the characterization lemma 6, for arbitrary partitions $(I_1, J_1) \in \mathcal{P}(\{1, \dots, n\})$ and $(I_2, J_2) \in \mathcal{P}(\{1, \dots, m\})$ we need to prove the following characterization statement

(*) *at least one of the following $(|I_1| + |I_2| + 2)$ sequents should be derivable:*

- (*1) $B, \{X_j\}_{j \in J_1}, \{W_j\}_{j \in J_2} \Rightarrow A_i$ for some $i \in I_1$
- (*2) $B, \{X_j\}_{j \in J_1}, \{W_j\}_{j \in J_2} \Rightarrow D_l$ for some $l \in I_2$
- (*3) $B, \{X_j\}_{j \in J_1}, \{W_j\}_{j \in J_2} \Rightarrow$
- (*4) $\{X_j\}_{j \in J_1}, \{W_j\}_{j \in J_2} \Rightarrow Y$

Again, we first apply the characterization lemma to derivability of $(C, Z), G \vdash (B, Y)$ for the partition $(I_1 \cup \{n+1\}, J_1)$ and get the following statement

(a) *at least one of the following $(|I_1| + 3)$ sequents should be derivable:*

- (a1) $B, \{X_j\}_{j \in J_1} \Rightarrow A_i$ for some $i \in I_1$
- (a2) $B, \{X_j\}_{j \in J_1} \Rightarrow C$
- (a3) $B, \{X_j\}_{j \in J_1} \Rightarrow$
- (a4) $\{X_j\}_{j \in J_1} \Rightarrow Y$

Second, we get the following statement by applying the characterization lemma to derivability $(C, Z), G \vdash (B, Y)$ for the partition $(I_1, J_1 \cup \{n+1\})$:

(b) *at least one of the following $(|I_1| + 2)$ sequents should be derivable:*

- (b1) $B, \{X_j\}_{j \in J_1}, Z \Rightarrow A_i$ for some $i \in I_1$
- (b2) $B, \{X_j\}_{j \in J_1}, Z \Rightarrow$
- (b3) $\{X_j\}_{j \in J_1}, Z \Rightarrow Y$

Third, we get the following statement by applying the characterization lemma to derivability $G' \vdash (C, Z)$ for the partition (I_2, J_2) :

(c) *at least one of the following $(|I_2| + 2)$ sequents should be derivable:*

- (c1) $C, \{W_j\}_{j \in J_2} \Rightarrow D_l$ for some $l \in I_2$
- (c2) $C, \{W_j\}_{j \in J_2} \Rightarrow$
- (c3) $\{W_j\}_{j \in J_2} \Rightarrow Z$

Now we show that for any possible choice of derivable sequent in (1), (2) and (3), we can always derive one of the sequents of (*) (either by weakening or cut in LK):

- If one of the sequents in (a1) is derivable, one of sequents (*1) is derivable by weakening.
- If the sequent (a3) is derivable, the sequent (*3) is derivable by weakening.
- If the sequent (a4) is derivable, the sequent (*4) is derivable by weakening.
- If the sequent (a2) and one of the sequents (c1) are derivable we can use the LK cut on them and get one of the sequents (*2).
- If the sequent (a2) and the sequent (c2) are derivable we apply the LK cut to them and get the sequent (*3).
- If the sequent (c3) and one of the sequents (b1) are derivable we use the LK cut and get one of the sequents (*1).
- If the sequent (c3) and the sequent (b2) are derivable we can use the LK cut and get the sequent (*3).
- If the sequent (c3) and the sequent (b3) are derivable using the LK cut we get the sequent (*4).

Thus, we have proved that one of the sequents (*) are derivable for all possible cases. □

Theorem 3. For both $k \in \{1, 3\}$, $G \vdash (B, Y)$ is derivable in SC_k^\perp iff the pair (B, Y) is derivable from the pairs in G in OUT_k^\perp .

Proof. Analogous to the proofs of Theoremes 1 and 2 for the calculi \mathcal{SC}_2^\perp and \mathcal{SC}_4^\perp .

Completeness

We need to check that all I/O rules of OUT_1^\perp (plus adequacy of derivability $(A, X) \vdash (A, X)$) are derivable in \mathcal{SC}_1^\perp and all I/O rules of OUT_3^\perp are derivable in \mathcal{SC}_3^\perp ; combining instances of these rules via (admissible) structural rules is the same as in the proof of completeness of \mathcal{SC}_2^\perp .

Below are derivation of I/O rules of OUT_1^\perp in \mathcal{SC}_1^\perp .

1. Base case $((A, X)$ belongs to G)

5. (SI) (the blue LK-sequent is derivable due to the side condition that $B \models A$ classically)

$$\frac{B \Rightarrow A \quad \frac{\Rightarrow Y \vee \neg Y}{\vdash (B, Y \vee \neg Y)} \text{ (OUT)}}{(A, Y) \vdash (B, Y)} \text{ (E}_1\text{)}$$

6. (AND)

$$\frac{B \Rightarrow B \quad \frac{\Rightarrow (X_1 \wedge X_2) \vee \neg X_1 \vee \neg X_2}{\vdash (B, (X_1 \wedge X_2) \vee \neg X_1 \vee \neg X_2)} \text{ (OUT)}}{(B, X_2) \vdash (B, (X_1 \wedge X_2) \vee \neg X_1)} \text{ (E}_1\text{)}$$

$$\frac{B \Rightarrow B \quad (B, X_2) \vdash (B, (X_1 \wedge X_2) \vee \neg X_1)}{(B, X_1), (B, X_2) \vdash (B, X_1 \wedge X_2)} \text{ (E}_1\text{)}$$

These rules can be derived the same way for \mathcal{SC}_3^\perp , or alternatively analogously to the Lem. 10 we can prove that every sequent derivable in \mathcal{SC}_1^\perp is also derivable in \mathcal{SC}_3^\perp and refer to the derivations in \mathcal{SC}_1^\perp above. The only rule left to prove is the derivability in \mathcal{SC}_3^\perp of the additional axiom (CT) of OUT_3^\perp . The derivation is below.

$$\frac{A \wedge X \Rightarrow A \wedge X \quad \frac{\Rightarrow Y \vee \neg X \vee \neg Y}{\vdash (A \wedge X \wedge Y, Y \vee \neg X \vee \neg Y)} \text{ (OUT)}}{(A \wedge X, Y) \vdash (A \wedge X, Y \vee \neg X)} \text{ (E}_3\text{)}$$

$$\frac{A \Rightarrow A \quad (A \wedge X, Y) \vdash (A \wedge X, Y \vee \neg X)}{(A, X), (A \wedge X, Y) \vdash (A, Y)} \text{ (E}_3\text{)}$$

Then the derivations of the rules are combined using structural rules to build a derivation in \mathcal{SC}_1^\perp (or \mathcal{SC}_3^\perp) analogously to the proof 1 of Th. 1. Admissibility of structural rules in \mathcal{SC}_4^\perp is given by Lem. 12.

Soundness

Analogous to the proof 1 of Th. 1.

To establish soundness of the rule (E₁) in OUT_1^\perp , notice that if first premise $B \Rightarrow A$ is derivable, then $B \models A$ (by soundness and completeness of LK), and therefore $B \models B \wedge A$. Then the following derivation provides the soundness for the rule (E₁) in OUT_1^\perp .
