ON HARADA'S IDENTITY AND SOME OTHER CONSEQUENCES OF BURNSIDE'S VANISHING PROPERTY

Abstract. In this short note, we prove some consequences of Burnside's vanishing property [\[BP23\]](#page-6-0). It is known that Harada's identity concerning the product of all conjugacy classes of a finite group is a consequence of Burnside's vanishing property of characters. We prove a similar formula for any weaklyintegral fusion category. In the second part, we prove some structural results concerning nilpotent and modular fusion categories. As an application we show that any fusion category of dimension $p^2q^2r^2d$ with $p < q < r$ prime numbers and d a square-free integer is weakly-group theoretical.

1. INTRODUCTION

A classical vanishing result of Burnside states that any irreducible non-linear character of a finite group vanishes on at least one element of the group.

Based on this vanishing result, in [\[Har08,](#page-7-0) Theorem 1], K. Harada proved that the product of all conjugacy classes of a finite group form a coset with respect to the commutator subgroup G' .

Theorem 1.1. *(Harada,* [\[Har08\]](#page-7-0)*) For any finite group* G*, the following identity holds:*

$$
\left(\prod_{j=0}^m \frac{C_j}{|\mathcal{C}^j|}\right)^2 = \frac{1}{|G'|} \sum_{\mathcal{C}^j \subseteq G'} C_j
$$

where G′ *is the commutator subgroup of* G*.*

In the above theorem $\{\mathcal{C}^j\}_{j=0}^m$ are all the conjugacy classes of G and $|\mathcal{C}^j|$ is the size of the conjugacy class. The elements $C_j := \sum_{g \in \mathcal{C}^j} g$ are the class sums associated to \mathcal{C}^j .

One of the goals of this short note is to present a similar formula for any weakly-integral fusion category. For weakly-integral fusion categories Burnside's vanishing result was extended in [\[Bur23\]](#page-6-2). Some other consequences of Brauer's vanishing result at the level of fusion categories are also presented.

Let $\mathcal C$ be a weakly-integral fusion category, $\mathcal C^j$ the set of all its conjugacy classes and C_i their associated class sums. Our first main result is the following:

Theorem 1.2. *For any weakly-integral fusion category, with the above notations, one has*

$$
(\prod_{j=0}^{m} \frac{C_j}{\mathrm{FPdim}(\mathcal{C}^j)})^2 = \frac{\mathrm{FPdim}(\mathcal{C}_{\mathrm{pt}})}{\mathrm{FPdim}(\mathcal{C})} \left(\sum_{\mu_j \in J_{\mathcal{C}_{\mathrm{pt}}}} C_j\right)
$$

For the definition of conjugacy classes \mathcal{C}^j and their associated class sums C_j , see Section [2.](#page-2-0) Moreover, the support of the fusion subcategory \mathcal{C}_{pt} is defined in [\[Bur20,](#page-6-3) Subsection 4.2].

In [\[OY23,](#page-7-1) Theorem 4.2] it was shown that any weakly group-theoretical modular tensor category whose dimension is nd with $(n, d) = 1$ is in fact a Deligne product of $\mathcal{C}(\mathbb{Z}_q, d) \boxtimes \mathcal{D}$ of two other modular tensor categories.

Suppose that $\mathcal C$ is a weakly-integral modular category. As usually we suppose that C is of type $(d_1, n_1; d_2, n_2; \ldots d_r, n_r)$ with $d_1=1$. Our second main result of this note is the following:

Theorem 1.3. *Suppose that* C *is a weakly-integral modular tensor category with* $FPdim(\mathcal{C}) = nd$ with $(n, d) = 1$ and d a square-free integer.

Then, with the above notations one has $d|n_i$ *for all* $i \geq 1$ *.*

As an application we prove the following:

Theorem 1.4. Let $\mathcal C$ be an integral modular fusion category of dimension $p^2q^2r^2d$ *with d a square-free number and* $p < q < r$ *three prime numbers. Then any such fusion category is weakly group-theoretical and can be written as a Deligne product* $A \boxtimes B$ *with* $A \simeq C(\mathbb{Z}_q, d)$ *and* B *a weakly group theoretical fusion category of dimension* $p^2q^2r^2$.

Note that the case $d = 1$ of the above result was treated in [\[CP22,](#page-6-4) Prop. 3.8.]. Proposition [4.5](#page-6-5) proves another consequence of Burnside vanishing result for nilpotent fusion categories.

Shortly, this note is organized as follows: In Section [2](#page-2-0) we remind the basics on pivotal fusion categories that are needed through the paper. In Section [3](#page-4-0) we prove Harada's identity for weakly-integral fusion categories. In Section [4](#page-5-0) we prove Theorem [1.3](#page-1-1) and Proposition [4.5](#page-6-5)

2. Preliminaries

Throughout this paper we work over the ground field \mathbb{C} . For the basic theory of fusion categories, we refer the reader to the monograph [\[EGNO15\]](#page-7-2).

Recall that a pivotal structure of a rigid monoidal category $\mathcal C$ is an isomorphism $j : id_{\mathcal{C}} \to$ ()^{**} of monoidal functors. A pivotal monoidal category is a rigid monoidal category endowed with a pivotal structure.

For any fusion category \mathcal{C} , the monoidal center (or the Drinfeld center) of \mathcal{C} is a braided fusion category $\mathcal{Z}(\mathcal{C})$ endowed with a forgetful functor $F : \mathcal{Z}(\mathcal{C}) \to \mathcal{C}$, see [\[EGNO15\]](#page-7-2).

The forgetful functor F also admits a right adjoint functor $R : \mathcal{C} \to \mathcal{Z}(\mathcal{C})$ and $Z := FR : C \to C$ is a Hopf comonad defined as an end. Indeed, following [\[Shi17,](#page-7-3) Section 2.6] one has that

(2.1)
$$
Z(V) \simeq \int_{X \in \mathcal{C}} X \otimes V \otimes X^*
$$

It is known that $A := Z(1)$ has the structure of central commutative algebra in $\mathcal{Z}(\mathcal{C}).$

The vector space $CE(\mathcal{C}) := Hom_{\mathcal{C}}(1, A)$ is called the set of central elements. There is a canonical bijection:

(2.2) CE(
$$
\mathcal{C}
$$
) $\xrightarrow{\psi}$ End(id \mathcal{C}), $\psi(a)_X = \rho_X(a \otimes id_X), X = \mathbf{1} \otimes X \xrightarrow{a \otimes id_X} X \otimes Z(\mathbf{1}) \xrightarrow{\rho_X} X$

The vector space $CF(\mathcal{C}) := Hom_{\mathcal{C}}(A_{\mathcal{C}}, \mathbf{1})$ is called the *space of class functions* of C. To any object $X \in \text{Irr}(\mathcal{C})$ Shimizu has attached an element $\chi_X \in \text{CF}(\mathcal{C})$ called *the character of* X*.*

Recall $R: \mathcal{C} \to \mathcal{Z}(\mathcal{C})$ is a right adjoint to the forgetful functor $F: \mathcal{Z}(\mathcal{C}) \to \mathcal{C}$. As explained in [\[Shi17,](#page-7-3) Theorem 3.8] this adjunction gives an isomorphism of of C-algebras

(2.3)
$$
\text{CF}(\mathcal{C}) \xrightarrow{\cong} \text{End}_{\mathcal{Z}(\mathcal{C})}(R(\mathbf{1})), \ \ \chi \mapsto Z(\chi) \circ \delta_{\mathbf{1}}.
$$

where δ_1 is the comultiplication of the comonad Z associated at 1.

Let $\lambda \in CF(\mathcal{C})$ be a non-zero cointegral of C. The *Fourier transform* of C associated to λ is the linear map

(2.4)
$$
\mathcal{F}_{\lambda}: CE(\mathcal{C}) \to CF(\mathcal{C}) \text{ given by } a \mapsto \lambda \hookrightarrow \mathcal{S}(a)
$$

where $S:CE(\mathcal{C}) \to CE(\mathcal{C})$ is the above antipodal operator. The Fourier transform is a bijective k-linear map whose inverse is given in [\[Shi17,](#page-7-3) Equation 5.17]. Since the monoidal center $\mathcal{Z}(\mathcal{C})$ is also a fusion category we can write $R(1) = \bigoplus_{i=0}^{m} C_i$ as a direct sum of simple objects in $\mathcal{Z}(\mathcal{C})$. Thus $\mathcal{C}^0, \ldots, \mathcal{C}^m$ are the conjugacy classes of C. Since the unit object $\mathbf{1}_{\mathcal{Z}(C)}$ is always a subobject of $R(1)$, we can assume $\mathcal{C}^0 = \mathbf{1}_{\mathcal{Z}(\mathcal{C})}$.

Let $\tilde{F}_0, \tilde{F}_1, \ldots, \tilde{F}_m \in \text{End}_{\mathcal{Z}(\mathcal{C})}(R(1))$ be the canonical projections on each of these conjugacy classes. Let also $F_0, F_1, \ldots F_m$ be also the corresponding primitive idempotents of CF(\mathcal{C}) under the canonical adjunction isomorphism CF(\mathcal{C}) \simeq $\text{End}_{\mathcal{Z}(\mathcal{C})}(R(1))$ from Equation [\(2.2\)](#page-2-1).

We define $C_i := \mathcal{F}_{\lambda}^{-1}(F_i) \in \text{CE}(\mathcal{C})$ to be the *conjugacy class sums* corresponding to the conjugacy class \mathcal{C}^i where $\lambda \in \mathrm{CF}(\mathcal{C})$ is a cointegral such that $\langle \lambda, u \rangle = 1$.

We denote by $\mu_j : CF(\mathcal{C}) \to \mathbb{C}$ the algebra homomorphisms corresponding to the central primitive idempotent F_j .

We adapt the following from [\[BP23,](#page-6-0) Definition 1.4].

Definition 2.1. *A fusion category* C *has* Burnside's vanishing property *(or shortly, is Burnside) if for all* $X_i \in \text{Irr}(\mathcal{C})$ *, the following tow assertions are equivalent:*

- (1) *There is some* $\mu_j \in \mathcal{B}$ *such that* $\mu_j(\chi_{X_i}) = 0$ *,*
- (2) X_i *is not an invertible object.*

By [\[Bur23,](#page-6-2) Theorem 2] any weakly integral fusion category is Burnside.

2.1. Definition of the support $\mathcal{J}_\mathcal{D}$. Let C be a fusion subcategory with a commutative Grothendieck ring. For any fusion subcategory $\mathcal{D} \subseteq \mathcal{C}$, recall the definition of its support form [\[Bur20,](#page-6-3) Subsection 4.2]. It is well known that there is an inclusion of $\mathbb{C}\text{-algebras } \iota : \text{CF}(\mathcal{D}) \hookrightarrow \text{CF}(\mathcal{C})$. Thus there is a subset $\mathcal{J}_{\mathcal{D}} \subseteq \{0, \ldots, m\}$ such that

(2.5)
$$
\lambda_{\mathcal{D}} = \sum_{j \in \mathcal{J}_{\mathcal{D}}} F_j
$$

since $\lambda_{\mathcal{D}}$ is an idempotent element inside CF(C). The set $\mathcal{J}_{\mathcal{D}}$ is called the *support* of the fusion subcategory D.

2.2. The dual hypergroup of $K(\mathcal{C})$. Let C be a fusion category with a commutative Grothendieck group $K(\mathcal{C})$. On the dual space $\widehat{K(\mathcal{C})} := \text{Hom}_{\mathbb{C}}(K(\mathcal{C}), \mathbb{C})$ one defines a multiplicative structure as in [\[Bur21\]](#page-6-6), such as, for all $f, g \in K(\mathcal{C})$ one has:

(2.6)
$$
[f \star g](\frac{\chi_i}{d_i}) := f(\frac{\chi_i}{d_i})g(\frac{\chi_i}{d_i}), \text{ for all } \chi_i \in \text{Irr}(\mathcal{C}).
$$

Then $\widehat{K(\mathcal{C})}$ is not anymore a fusion ring but an abelian normalized hypergroup, see [\[BP23,](#page-6-0) Definition 1.1].

Let (H, \mathcal{B}) be an abelian normalized hypergroup. By the commutativity assumption on $K(\mathcal{C})$, the set of algebra morphisms $\widehat{\text{Irr}(\mathcal{C})} := \{\mu_j\}_{j=0}^m$ forms a basis for the dual $\widetilde{K}(\widetilde{\mathcal{C}})$.,

2.3. The isomorphism α . Note that the dual hypergroup $\widetilde{K}(\widetilde{\mathcal{C}})$ is denoted by $CF(\mathcal{C})$ in [\[Bur21\]](#page-6-6). Theorem 3.4 from the same paper implies that for any pseudounitary fusion category there is a canonical isomorphism of hypergroups

(2.7)
$$
\alpha : \widehat{\mathrm{CF}(\mathcal{C})} \to \mathrm{CE}(\mathcal{C}), \ \mu_j \mapsto \frac{C_j}{\dim(\mathcal{C}^j)}.
$$

3. Proof of Theorem [1.2](#page-1-0)

Proof. Since C is weakly-integral, it is a Burnside category, by $\lbrack \text{Bur23, Theorem} \rbrack$ 2]. Then [\[BP23,](#page-6-0) Corollary 4.5] implies that

(3.1)
$$
\left(\prod_{j=0}^{m} \mu_j\right)^2 = \sum_{\left[X_i\right] \in \text{Irr}(\mathcal{C}_{\text{pt}})} \widehat{E}_i.
$$

where \widehat{E}_i is the primitive central idempotent of $\widehat{K(C)}$ associated to $\chi_i := \chi_{X_i}$. Note that $\alpha(E_i) = E_i$, the primitive idempotent of $CE(\mathcal{C})$ associated to the irreducible character E_i , see [\[Shi17,](#page-7-3) Subsection 6.2]. Applying the isomorphism α to Equation (3.1) one obtains the following identity in CE(C).

$$
(\prod_{j=0}^{m} \frac{C_j}{\mathrm{FPdim}(\mathcal{C}^j)})^2 = \sum_{[X_i] \in \mathrm{Irr}(\mathcal{C}_{\mathrm{pt}})} E_i.
$$

On the other hand one has by [\[Bur20,](#page-6-3) Eq. (4.13) and Eq. (4.15)] one has

$$
\frac{\mathrm{FPdim}(\mathcal{C})}{\mathrm{FPdim}(\mathcal{C}_{\mathrm{pt}})}\left(\sum_{[X_i]\in\mathrm{Irr}(\mathcal{C}_{\mathrm{pt}})}E_i\right) = \sum_{j\in\mathcal{J}_{\mathcal{C}_{\mathrm{pt}}} } C_j
$$

and this implies that

$$
(\prod_{j=0}^{m} \frac{C_j}{\mathrm{FPdim}(\mathcal{C}^j)})^2 = \frac{\dim(\mathcal{C}_{\mathrm{pt}})}{\dim(\mathcal{C})} \Big(\sum_{j \in \mathcal{J}_{\mathcal{C}_{\mathrm{pt}}}} C_j\Big).
$$

The proof of the theorem is finished.

Corollary 3.1. *With the above notations, if the structure constants are integers then one has that*

(3.2)
$$
\frac{\dim(\mathcal{C})}{\dim(\mathcal{C}_{\rm pt})} \Big| \prod_{j=0}^{m} \mathrm{FPdim}(\mathcal{C}^j)
$$

Corollary 3.2. *If* C *is Burnside and modular with integral structure constants then*

(3.3)
$$
\text{FPdim}(\mathcal{C}_{\text{ad}}) = \frac{\text{FPdim}(\mathcal{C})}{\text{FPdim}(\mathcal{C}_{\text{pt}})} \left| \prod_{j=0}^{m} \text{FPdim}(d_j)^2 \right|
$$

Proof. It follows that $\text{FPdim}(\mathcal{C}^j) = d_j^2$ since \mathcal{C} is modular.

For a semisimple Hopf algebra H recall the notion of commutator left coideal subalgebra H' , see [\[Bur12\]](#page-6-7). In this case Harada's identity can be written as:

Corollary 3.3. *For a semisimple Hopf algebra one has*

$$
(\prod_{j=0}^{m} \frac{C_j}{\mathrm{FPdim}(\mathcal{C}^j)})^2 = \Lambda_{H'} = \frac{1}{\dim(H')} \left(\sum_{\{j \mid \mathcal{C}^j \subseteq H'\}} C_j \right)
$$

4. Proof of Theorem [1.3](#page-1-1) and some other applications

Suppose that $\mathcal C$ is a weakly-integral modular category. As usually we suppose that C is of type $(d_1, n_1; d_2, n_2; \ldots d_r, n_r)$ with $d_1=1$. We will use the notation $FPdim(\mathcal{C}) = FPdim(\mathcal{C})_1FPdim(\mathcal{C})_{\geq 2}$ where $FPdim(\mathcal{C})_1$ is the free square part of FPdim(C). Thus FPdim(C)₁ is the unique square free divisor of FPdim(C) such that $g.c.d(\text{FPdim}(\mathcal{C})_1, \text{FPdim}(\mathcal{C})_{\geq 2}) = 1$. Note that $\text{FPdim}(\mathcal{C})_1|n_1$ by [\[BP23,](#page-6-0) Corollary 1.17].

Let Irr(\mathcal{C}) denote the set of isomorphism classes of simple object of \mathcal{C} . For any subset $\mathcal{A} \subseteq \text{Irr}(\mathcal{C})$ we denote $\text{FPdim}(\mathcal{A}) := \sum_{X \in \mathcal{A}} \text{FPdim}(X)^2$.

Remark 4.1. *if* C *is an integral modular category then for any* $d_i > 1$ *one clearly* has $gcd(d_i, \text{FPdim}(\mathcal{C})_1) = 1$ *since* $d_i^2 | \text{FPdim}(\mathcal{C})$ *by* [\[ENO11,](#page-7-4) Theorem 2.11].

4.1. Proof of Theorem [1.3.](#page-1-1) Note that Theorem [1.3](#page-1-1) can be reformulated as

Theorem 4.2. In any modular category C one has $\text{FPdim}(\mathcal{C})_1 | n_i$ for all $i \geq 1$.

Proof. Recall that for any $a > 0$ by $\text{Irr}_a(\mathcal{C})$ is denoted the set of isomorphism classes of simple objects of $\mathcal C$ of dimension a.

Let $G(\mathcal{C})$ be the set of invertible objects of C. Consider the action of $G(\mathcal{C})$ on Irr(C) and note that each set $\text{Irr}_{d_i}(\mathcal{C})$ is a union of orbits of this action. By [\[ENO05,](#page-7-5) Remark 8.17] one has that $|G(\mathcal{C})|$ FPdim(Irr_{di} $(\mathcal{C})) = n_i d_i^2$.

Thus $\text{FPdim}(\mathcal{C})_1 | n_i d_i^2$ and since $(d_i, \text{FPdim}(\mathcal{C})_1) = 1$ for all i with $d_i > 1$ it follows that $\mathrm{FPdim}(\mathcal{C})_1\big|n_i$. В последните поставите на селото на се

Proposition 4.3. The first divisibility $d|n_1$ is true if $(d, \text{FPdim}(V)^2) = 1$ for any *simple* V *as in* [\[OY23\]](#page-7-1)*.*

Proof. By [\[BP23,](#page-6-0) Theorem 1.15] one has that $\mathcal{V}(\mathcal{C}) = \mathcal{V}(\mathcal{C}_{pt}) \cup \mathcal{V}(d_i^2)$. On the other hand note that if $p|d$ since $(p, d_i^2) = 1$ it follows that $p|\text{FPdim}(\mathcal{C}_{pt})$. \Box

Remark 4.4. *Note that by* [\[Nat14,](#page-7-6) Thm 7. 4] *any modular fusion category* C *with* $FPdim(\mathcal{C}) = p^a q^b d$ with d a square free number is WGT. Thus by $[OY23]/Theorem$ $[OY23]/Theorem$ *4.2] these fusion categories decompose as a Deligne product as above.*

4.2. Proof of Theorem [1.4.](#page-1-2) Our proof goes as follows. By [\[OY23,](#page-7-1) Theorem 4.2, it suffices to show that C is weakly group-theoretical. If $d \neq 1$ then by Theorem [1.3](#page-1-1) it follows that $d | n_i$ for all $i > 1$. Thus $n_i = dn'_i$ and Frobenius-Perron dimension of $\mathcal C$ can be written as

$$
(pqr)^2 = \sum_{i=0}^{r} n'_i d_i^2.
$$

Then one can do something similar as in the proof of from [\[ENO11,](#page-7-4) Lemma 9.3] to deduce that C has a symmetric fusion subcategory. If the subcategory \mathcal{C}_{pt} is degenerate, then its Mueger center is a symmetric fusion subcategory. Otherwise $\mathcal{C} \simeq \mathcal{C}_{pt} \boxtimes \mathcal{C}_{ad}$ and one can repeat the argument for \mathcal{C}_{ad} .

4.3. Nilpotent fusion categories. Note that by Theorem 1.11 and Theorem 1.12 of [\[BP23\]](#page-6-0) all nilpotent fusion categories with $K(\mathcal{C})$ commutative are both Burnside and dual Burnside. Moreover they are weakly-integral as iterated extensions of Vec. We also prove the following result for nilpotent fusion categories:

Proposition 4.5. *If* C *is a non-pointed integral nilpotent fusion category with* K(C) *commutative then*

- (1) $FPdim(\mathcal{C}_{ad})$ *has no square free parts.*
- (2) Moreover $\mathrm{FPdim}(\mathcal{C})_1$ $\big[U(\mathcal{C}) \big]$ where $U(\mathcal{C})$ is the universal grading group of *the fusion category* C*.*

Proof. By [\[BP23,](#page-6-0) Theorem 1.15] one has $\mathcal{V}(\mathcal{C}_{ad}) = \cup_{i=0}^{m} \mathcal{V}(d_i)$. For any prime p it follows that if $p | \text{FPdim}(\mathcal{C}_{ad})$ then $p | d_i$. By [\[GN08,](#page-7-7) Corollary 5.3] then $p^2|d_i^2|\text{FPdim}(\mathcal{C}_{ad})$ which shows that $\text{FPdim}(\mathcal{C}_{ad})$ has no square free part. On the other hand, since $\mathrm{FPdim}(\mathcal{C}) = |U(\mathcal{C})|\mathrm{FPdim}(\mathcal{C}_{ad})$ it follows that $\mathrm{FPdim}(\mathcal{C})_1||U(\mathcal{C})|$. \Box
