RANDOMIZED ALGORITHMS FOR LOW-RANK MATRIX APPROXIMATION: DESIGN, ANALYSIS, AND APPLICATIONS*

JOEL A. TROPP[†] AND ROBERT J. WEBBER[†]

Abstract. This survey explores modern approaches for computing low-rank approximations of high-dimensional matrices by means of the randomized SVD, randomized subspace iteration, and randomized block Krylov iteration. The paper compares the procedures via theoretical analyses and numerical studies to highlight how the best choice of algorithm depends on spectral properties of the matrix and the computational resources available.

Despite superior performance for many problems, randomized block Krylov iteration has not been widely adopted in computational science. This paper strengthens the case for this method in three ways. First, it presents new pseudocode that can significantly reduce computational costs. Second, it provides a new analysis that yields simple, precise, and informative error bounds. Last, it showcases applications to challenging scientific problems, including principal component analysis for genetic data and spectral clustering for molecular dynamics data.

 \mathbf{Key} words. Low-rank matrix approximation, randomized numerical linear algebra, Krylov subspace methods

1. Motivation. A core problem in numerical linear algebra is to produce a low-rank, factorized approximation of a high-dimensional input matrix $\mathbf{A} \in \mathbb{R}^{L \times N}$:

$$egin{array}{ccccc} oldsymbol{A} & lpha & oldsymbol{B} & oldsymbol{C} \ L imes N & L imes k & k imes N \end{array}$$

We think of the inner dimension k as much smaller than the outer dimensions L and N. In this case, the factorized approximation BC has fewer degrees of freedom than the input matrix A, so the factorization is easier to store and manipulate. Furthermore, to attain a small error, the approximation must expose structure in the input matrix. Particular examples of "structure" include the range of the input matrix (rank-revealing QR factorization), principal components (truncated singular value decomposition), or salient columns (CUR or interpolative decomposition).

Low-rank approximation serves as a fundamental tool for computational science. Application areas include fluid dynamics [9, 93], uncertainty quantification [21, 29], genetics [44], climate science [108], geophysics [113], astronomical imaging [65], and beyond. Indeed, low-rank approximation is helpful whenever we need to extract dominant patterns in data, remove unwanted noise, or perform compression.




Fig. 1. (Singular value decay profiles). Fast versus slow singular value decay; for details of the matrices, see subsection 2.3.

For high-dimensional matrices, the computational difficulty of low-rank approximation depends on the singular value spectrum of the input matrix; see Figure 1 for a schematic. While we can apply simple algorithms to approximate a matrix with a rapidly decaying spectrum, we need more powerful algorithms to approximate a matrix with a slowly decaying spectrum. This challenge arises in many modern applications. For example, consider this quotation from the genetics literature [22]:

"[I]n large datasets, eigenvalues may be highly significant (reflecting real population structure in the data) but only slightly larger than

background noise eigenvalues..."

In this setting, we require scalable techniques that can filter out the noise components, while accurately approximating the signal components. So what algorithms should we use?

This survey explores a family of powerful methods for low-rank approximation: the randomized singular value decomposition (RSVD), randomized subspace iteration (RSI), and randomized block Krylov iteration (RBKI). We will introduce these techniques in subsections 2.1 and 2.2. They are related because each one collects information about the input matrix using matrix—vector products with random vectors. We will develop a systematic comparison of the three approaches by examining their mathematical structure, providing new implementations, refining the theoretical analyses, and presenting numerical studies.

As compared with classic methods, the randomized algorithms are more scalable, reliable, and robust. Our investigation shows that the simplest method, RSVD, returns accurate approximations for matrices with rapid spectral decay, but we must use the more sophisticated RBKI method for challenging problems. In case storage is the limiting factor, RSI may offer a reasonable compromise. These conclusions will be familiar to experts.

Nevertheless, the RBKI method still has not reached a wide audience in computational science. (For example, see the recent genetics review [104].) Therefore, the second goal of this survey is to establish firm foundations for the RBKI method to speed its adoption. We develop a new formulation of the algorithm that is significantly faster than previous implementations. We prove new theoretical guarantees that demonstrate exactly how RBKI improves over RSVD and RSI. Finally, we show applications to benchmark problems in computational science that confirm the benefits of RBKI in these settings.

Remark 1.1 (Finding structure with randomness). The paper [55] of Halko et al. made a comprehensive case for RSVD and RSI, which led to broader usage of these methods. The goal of this survey is to perform the same mission for RBKI.

2. Randomized matrix approximation: Overview. This section offers an introduction to the randomized algorithms that we study in this paper. It provides a first look at the numerical behavior of these methods, and it presents simple theoretical bounds that allow us to compare their performance.

2.1. Ingredients. In 2009, Halko et al. [55] developed a framework for designing randomized algorithms for low-rank matrix approximation. In this section, we outline the key concepts from their approach.

Consider the problem of approximating a high-dimensional matrix $A \in \mathbb{R}^{L \times N}$. The matrix can be an array of data stored on a computer, or it can be an abstract linear operator defined by its action on test vectors. Regardless, we only access A by performing multiplications $x \mapsto Ax$ and $y \mapsto A^*y$ with input vectors $x \in \mathbb{R}^N$ and $y \in \mathbb{R}^L$. As usual, A^* is the transpose.

The first idea underlying low-rank approximation is that we can find important directions in the range of A by applying the matrix to a random vector. Suppose that A has the singular value decomposition (SVD)

$$oldsymbol{A} = \sum_{i=1}^N \sigma_i oldsymbol{u}_i oldsymbol{v}_i^* \quad ext{with } \sigma_1 \geq \sigma_2 \geq \cdots \geq \sigma_N \geq 0.$$

The "leading" left singular vectors u_i , associated with the largest singular values σ_i , are significant directions in the range. Draw a random vector $\boldsymbol{\omega} \in \mathbb{R}^N$ from the standard normal distribution $\mathcal{N}(\mathbf{0}, \mathbf{I}_N)$. By rotational invariance, we can express $\boldsymbol{\omega}$ in the basis of right singular vectors:

$$\omega = \sum_{i=1}^{N} Z_i v_i$$
 where $Z_i \stackrel{\text{iid}}{\sim} \mathcal{N}(0,1)$.

With probability one, all of the random coefficients Z_i are nonzero, and they are on the same scale because each coefficient has variance one. The matrix–vector product takes the form

$$oldsymbol{A}oldsymbol{\omega} = \sum
olimits_{i=1}^N Z_i \sigma_i \, oldsymbol{u}_i.$$

We see that the image $A\omega$ is strongly correlated with the leading left singular vectors, while it is weakly correlated with the trailing left singular vectors.

Now, observe that repeated multiplication with the input matrix \boldsymbol{A} and its transpose \boldsymbol{A}^* amplify the coefficients associated with large singular values, while attenuating coefficients with small singular values. More precisely,

$$(\boldsymbol{A}\boldsymbol{A}^*)^{q-1}\boldsymbol{A}\boldsymbol{\omega} = \sum_{i=1}^N Z_i \sigma_i^{2q-1} \boldsymbol{u}_i.$$

As we increase the depth $q=1,2,3,\ldots$, the small singular values are suppressed exponentially fast. Therefore, the output vector is more and more likely to be aligned with the leading left singular vectors. In fact, we can achieve this goal even when the depth is a moderate constant, say, $q \leq 5$. There is no need to take a limit.

Next, we double down on this insight by multiplying the input matrix with a block of $k \gg 1$ vectors to find many important directions in the range. To express this operation, we introduce a standard normal matrix $\mathbf{\Omega} = \begin{bmatrix} \boldsymbol{\omega}_1 & \dots & \boldsymbol{\omega}_k \end{bmatrix} \in \mathbb{R}^{N \times k}$ with independent columns. By sequential multiplication, we obtain the matrices

$$A\Omega$$
, $(AA^*)A\Omega$, $(AA^*)^2A\Omega$, ..., $(AA^*)^{q-1}A\Omega$.

As the powers increase, the ranges of these matrices align better with the k leading left singular vectors u_1, \ldots, u_k of the input matrix. We will quantify the extent of the overlap in sections 6 and 7.

Finally, suppose we have constructed a matrix $M \in \mathbb{R}^{L \times k}$ whose range aligns with the leading left singular vectors of the input matrix A. We can build the desired

low-rank approximation of A by compressing A into the range of M. To that end, we orthogonalize the columns of M to obtain a matrix X = orth(M), and we construct the orthogonal projector $\Pi_M = XX^*$ onto the range of M. Then we form the approximation

(2.1)
$$\hat{A} = \Pi_M A = XX^*A = XY^* \quad \text{where } Y = A^*X.$$

Since X has at most k columns, so does the matrix Y. We have produced a factorized rank-k approximation $\hat{A} = XY^*$ of the input matrix A.

At this point, the approximation \hat{A} can be manipulated into alternative forms by standard transformations. For example, we can easily produce an SVD, a QR factorization, or a CUR decomposition. See [55, Sec. 5] for details.

2.2. Approximation formulas and computations. Combining these basic ideas, we obtain several fundamental approaches to low-rank matrix approximation.

In the first approach, called "randomized singular value decomposition" or RSVD, we generate the low-rank approximation

$$\hat{A} = \Pi_{A\Omega} A.$$

This procedure requires a first multiplication with A and a second multiplication with A^* , while storage is limited to two blocks of k vectors. See Algorithm 4.1 for pseudocode.

In the second approach, called "randomized subspace iteration" or \mathtt{RSI} , we generate

$$\hat{\boldsymbol{A}} = \boldsymbol{\Pi}_{(\boldsymbol{A}\boldsymbol{A}^*)^{q-1}\boldsymbol{A}\boldsymbol{\Omega}}\boldsymbol{A}.$$

This procedure requires 2q multiplications, alternating between A and A^* , while storage is limited to two blocks of k vectors. We think about the depth parameter q as a fixed number, rather than treating the algorithm as a limiting process. See Algorithm 4.2 for pseudocode.

The third approach, called "randomized block Krylov iteration" or RBKI, forms the approximation

(RBKI)
$$\hat{A} = \Pi_{[A\Omega \ \cdots \ (AA^*)^{q-1}A\Omega]} A.$$

In this case, we project onto the range of the block matrix $[A\Omega \cdots (AA^*)^{q-1}A\Omega]$. Subsection 4.5 shows how to carry out this construction using 2q multiplications, an improvement of 33% to 50% over previous implementations. The storage cost is higher than the other algorithms, typically 2q blocks of k vectors. As before, the depth parameter q is viewed as a fixed number. See Algorithm 4.4 for pseudocode.

Our primary objective in this work is to address the following question:

What is the most appropriate algorithm for low-rank approximation of a given matrix: RSVD, RSI, or RBKI?

The answer depends on the spectrum of the matrix, the required accuracy, and limitations on computational resources (such as storage).

We focus on the high-dimensional setting in which L or N is large (say, $\geq 10^4$). In this case, the predominant operating cost for each approximation method is the repeated application of \mathbf{A} and \mathbf{A}^* to a block of k vectors. Therefore, we measure the operating cost in terms of the total number m of matrix–matrix multiplications and

the block size k of each multiplication. Our goal is to reduce the parameters m and k as much as possible, while ensuring a robust and accurate low-rank approximation. We accept certain tradeoffs between m and k, but we focus mainly on decreasing the number m of multiplications. Reducing m gives a linear improvement in the runtime because the repeated matrix multiplications are inherently serial.

Remark 2.1 (Matrix multiplication). On modern computers, matrix multiplications with a large block size k are optimized to take advantage of architectural features, including multithreading [94], caching [50, 68], parallelization [21], and single-instruction multiple data processors [106]. By designing multiplication-rich algorithms, we harness the full power of modern computing platforms. This is the main advantage of blocked Krylov methods over Krylov methods with a single starting vector (k = 1).

2.3. Illustrative comparison. In this section, we present an illustrative comparison of RSVD, RSI, and RBKI. Section 5 presents a more comprehensive series of experiments, including real-world applications.

We consider approximating two matrices with dimensions $L = N = 10^4$:

$$A = \text{diag}(1, e^{-.1}, e^{-.2}, \dots, e^{-999.9}), \qquad B = A + Z, \text{ where } Z_{ij} \stackrel{\text{iid}}{\sim} \mathcal{N}(0, .002^2).$$

The first matrix A has exponentially decaying singular values; see the "fast decay" profile in Figure 1. The second matrix B is a noisy version of A that has been perturbed by adding an independent Gaussian random variable to each entry. For a particular realization of the noise, the upper left submatrices are

$$\boldsymbol{A} = \begin{bmatrix} 1.000 & 0.000 & 0.000 & 0.000 \\ 0.000 & 0.905 & 0.000 & 0.000 \\ 0.000 & 0.000 & 0.819 & 0.000 \\ 0.000 & 0.000 & 0.000 & 0.741 \\ & & & & & & \\ \end{bmatrix}, \quad \boldsymbol{B} = \begin{bmatrix} 1.001 & -0.002 & 0.002 & 0.002 & 0.002 \\ 0.000 & 0.907 & -0.003 & -0.001 \\ -0.003 & 0.002 & 0.819 & -0.001 \\ -0.002 & 0.000 & -0.003 & 0.739 \\ & & & & & \\ & & & & & \\ \end{bmatrix}.$$

The matrix entries are similar, up to variations on the scale ± 0.002 . However, the Gaussian noise transforms the structure of the singular values. The matrix \boldsymbol{B} has a long tail of singular values with magnitudes 0.0 to 0.4; see the "slow decay" profile in Figure 1.

First, we exhibit the output of RSVD (Algorithm 4.1) with a block size k = 50 when applied to the original matrix A:

$$(\mathtt{RSVD}) \qquad \qquad \hat{A}_{k=50} = \left[\begin{array}{ccccc} 1.000 & 0.000 & 0.000 & 0.000 \\ 0.000 & 0.905 & 0.000 & 0.000 \\ 0.000 & 0.000 & 0.819 & 0.000 \\ 0.000 & 0.000 & 0.000 & 0.741 \\ & & & & \\ \end{array} \right].$$

The upper left submatrix coincides with A up to three decimal places. RSVD performs ideally for this example, and there is no reason to increase the block size or use a more elaborate approximation.

In contrast, RSVD with a block size k = 50 produces an appalling approximation

of the noisy matrix B, with major discrepancies in the first four rows and columns:

$$(\mathtt{RSVD}) \qquad \qquad \hat{\pmb{B}}_{k=50} = \left[\begin{array}{c|cccc} 0.123 & -0.010 & 0.013 & 0.007 \\ -0.011 & \textbf{0.082} & -0.024 & -0.004 \\ 0.014 & -0.026 & \textbf{0.098} & -0.001 \\ 0.007 & -0.004 & -0.001 & \textbf{0.049} \\ & & & & & & & & & & \\ \end{array} \right].$$

We can improve the approximation quality by using a larger block size k = 1000, but the errors remains large:

The off-diagonal entries are too large in magnitude, and the diagonal entries are too small.

As an alternative to RSVD, we can approximate the noisy matrix \boldsymbol{B} using RSI (Algorithm 4.3) or RBKI (Algorithm 4.5) with a block size k=50. After m=5 multiplications, RSI improves on RSVD, but it still produces an underestimate of the diagonal:

(RSI)
$$\hat{\boldsymbol{B}}_{\mathrm{RSI}} = \begin{bmatrix} 0.993 & -0.002 & 0.001 & -0.002 \\ 0.001 & 0.892 & -0.005 & 0.000 \\ -0.004 & 0.001 & 0.797 & -0.004 \\ -0.005 & -0.001 & -0.005 & 0.684 \end{bmatrix}.$$

In contrast, after m=5 multiplications, RBKI yields the superior approximation

$$\hat{\boldsymbol{B}}_{\mathrm{RBKI}} = \begin{bmatrix} \begin{array}{c|cccc} \mathbf{0.999} & -0.002 & 0.001 & 0.002 \\ 0.000 & \mathbf{0.904} & -0.003 & -0.001 \\ -0.003 & 0.002 & \mathbf{0.816} & -0.001 \\ -0.002 & 0.000 & -0.003 & \mathbf{0.735} \\ & & & & & & & \\ \end{array} \right].$$

In fact, the approximation $\hat{\boldsymbol{B}}_{RBKI}$ agrees with the best rank-50 approximation of \boldsymbol{B} up to three decimal places. The remaining error is a consequence of the low-rank approximation, rather than a deficiency in the RBKI algorithm.

The takeaway from these simple experiments is that it can be difficult to approximate a matrix, such as \boldsymbol{B} , that has been corrupted by noise. For approximation problems with noisy matrices, RBKI typically offers the best combination of speed and accuracy, and it outperforms the other randomized low-rank approximation algorithms.

2.4. Theoretical analysis. In this section, we introduce our main error bounds for randomized low-rank matrix approximation, which help to explain the outcomes of the experiments in subsection 2.3. Detailed derivations and additional bounds can be found in sections 6 and 7.

Return to the setting where $\mathbf{A} \in \mathbb{R}^{L \times N}$ is an arbitrary matrix. We measure the quality of a computed approximation by comparison to an optimal rank-r approximation. For a parameter $r \geq 1$, the minimal rank-r approximation error in the spectral norm is given by the (r+1)st singular value:

$$\min\{\|\boldsymbol{B} - \boldsymbol{A}\| : \operatorname{rank}(\boldsymbol{B}) = r\} = \sigma_{r+1}(\boldsymbol{A}).$$

Here, $\|\cdot\|$ is the spectral norm, and $\sigma_j(\cdot)$ returns the jth largest singular value. Equality holds for any r-truncated SVD of the matrix A.

A randomized low-rank approximation algorithm produces a random approximation \hat{A} of the input matrix A. We evaluate the computed approximation \hat{A} using the mean-squared relative error:

$$\mathbb{E}\left[rac{\|oldsymbol{A}-\hat{oldsymbol{A}}\|^2}{\sigma_{r+1}(oldsymbol{A})^2}
ight].$$

The expectation \mathbb{E} averages over the randomness in the algorithm (which comes from the choice of the random initialization matrix Ω). We often compare an approximation with rank k to a best approximation with rank $r \leq k$, so the relative error could be smaller than one.

Here is the core technical question:

What block size k and number m of matrix multiplications suffice to make the mean-squared relative error small?

Our theoretical analysis elucidates how the parameters k, m and the choice of approximation subspace affect the quality of the approximation. Let us emphasize that the user of the algorithm specifies k and m, while the comparison rank r only appears in the theoretical analysis.

As a first result, we present an error bound for RSVD with k Gaussian vectors. For each block size $k \ge r + 2$, we have the estimate

$$\frac{\mathbb{E}\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|^2}{\sigma_{r+1}(\boldsymbol{A})^2} \leq 1 + \frac{r}{k-r-1} \sum_{i > r} \frac{\sigma_i(\boldsymbol{A})^2}{\sigma_{r+1}(\boldsymbol{A})^2}.$$

As the block size k increases, the polynomial factor r/(k-r-1) decreases. Typical choices for the block size are k=r+2 and k=2r+1. Once k and r are fixed, the bound depends only on the tail singular values $\sigma_{r+1}(A), \sigma_{r+2}(A), \ldots$, regardless of the first r singular values. When the tail singular values decay quickly, the error is proportional to the optimal rank-r error. For example, when the singular values of A decay exponentially fast, the error satisfies $\mathbb{E}||A-\hat{A}||^2 \leq (1+\varepsilon) \cdot \sigma_{r+1}(A)^2$ for $k \approx 1.5r + \text{const} \cdot \log(1+1/\varepsilon)$.

The next result shows that randomized subspace iteration, RSI, is a better alternative for matrices with slowly decaying singular values. Consider the approximation \hat{A} produced by the RSI algorithm with k Gaussian vectors and m matrix multiplications. For each block size $k \geq r + 2$,

$$(\mathtt{RSI}) \qquad \log \left(\frac{\mathbb{E} \|\boldsymbol{A} - \hat{\boldsymbol{A}}\|^2}{\sigma_{r+1}(\boldsymbol{A})^2} \right) \leq \frac{1}{m-1} \log \left(1 + \frac{r}{k-r-1} \sum_{i > r} \frac{\sigma_i(\boldsymbol{A})^2}{\sigma_{r+1}(\boldsymbol{A})^2} \right).$$

The logarithm of the mean-squared relative error decreases in proportion to the number m of multiplications. The logarithm ensures that the error cannot depend

too strongly on the singular value decay. Regardless of the singular value decay, $m = \log(1 + \min\{L, N\})$ multiplications suffice to achieve a constant relative error for k = 2r + 1.

Now, consider the approximation \hat{A} produced by the RBKI algorithm with k Gaussian initialization vectors and m matrix multiplications. For each block size $k \geq r+2$,

$$(\mathtt{RBKI}) \qquad \log \left(\frac{\mathbb{E} \|\boldsymbol{A} - \hat{\boldsymbol{A}}\|^2}{\sigma_{r+1}(\boldsymbol{A})^2} \right) \leq \frac{1}{4(m-2)^2} \bigg[\log \bigg(4 + \frac{4r}{k-r-1} \sum_{i>r} \frac{\sigma_i(\boldsymbol{A})^2}{\sigma_{r+1}(\boldsymbol{A})^2} \bigg) \bigg]^2.$$

This bound shows that RBKI reduces the logarithm of the relative error proportionally to the square m^2 of the number m of multiplications, which suggests that RBKI can provide a far more accurate approximation than RSI. For example, we might require m=100 multiplications to obtain an accurate approximation using RSI but only m=10 multiplications using RBKI.

As stated, these error bounds are new, but they build on prior work. The results for RSVD and RSI are patterned on arguments from Halko et al. [55, Thm. 10.6, Cor. 10.10]. Musco and Musco [73, Thm. 1] obtained a qualitative result for RBKI that identifies the $\mathcal{O}(m^{-2})$ scaling, but our detailed analysis of RBKI does not have a precedent in the literature. For mathematical derivations and a more comprehensive discussion, see sections 6 and 7.

2.5. Positive-semidefinite matrices. A special priority of this survey is to develop methods for approximating *positive-semidefinite* (psd) matrices. Of course, we can approximate a psd matrix using the general-purpose algorithms RSVD, RSI, and RBKI, but this strategy is wasteful. As a more accurate alternative that also preserves the psd property, we can employ algorithms based on Nyström approximation (discussed in subsection 4.6).

We discuss three methods: NysSVD, NysSI, and NysBKI, which are the Nyströmbased extensions of RSVD, RSI, or RBKI. We address the following question:

What is the most appropriate algorithm for low-rank approximation of a given psd matrix: NysSVD, NysSI, or NysBKI?

Our results show that NysSVD is the most efficient algorithm for rapidly decaying singular values, while NysBKI is the most efficient algorithm for slowly decaying singular values. Additionally, our theory and experiments suggest that NysBKI improves on RBKI by a factor of $\sqrt{2}$ multiplications, demonstrating the major potential for speed-ups in the psd setting.

The NysRBKI algorithm is new, as is most of the theory for the Nyström methods. For a real-world application, see the spectral clustering problem in subsection 5.3.

- **2.6. Plan for the paper.** The rest of the paper is organized as follows. Section 3 presents historical background, section 4 introduces pseudocode, section 5 showcases numerical experiments, sections 6 and 7 derive error bounds, and section 8 offers conclusions.
- **2.7.** Notation. For simplicity, we work with real-valued matrices only. There is an analogous theory for complex-valued matrices, although the constants may differ. We use the term *Gaussian* random matrix (or vector) as a shorthand for a matrix with independent Gaussian entries with mean zero and variance one.

We adopt standard notation for various matrix operations. The transpose of a matrix $A \in \mathbb{R}^{L \times N}$ is represented by A^* . The Moore–Penrose pseudoinverse of A is denoted by A^{\dagger} , and the orthogonal projection onto the range space of A is written

as $\Pi_{A} = A(A^*A)^{\dagger}A^*$. The eigenvalues of a symmetric matrix A are ordered from largest to smallest as $\lambda_1(A) \geq \lambda_2(A) \geq \cdots$, as are the singular values $\sigma_1(A) \geq \sigma_2(A) \geq \cdots$ of a general matrix A. The symbol \leq denotes the positive-semidefinite (psd) order on symmetric matrices: $A \leq B$ if and only if B - A is psd.

We measure the size of a matrix $M \in \mathbb{R}^{L \times N}$ using the Schatten *p*-norm [11, Sec. 4.2], defined by

$$\|oldsymbol{M}\|_p = \left(\sum
olimits_{i=1}^N \sigma_i(oldsymbol{M})^p
ight)^{1/p}$$

for $1 \leq p < \infty$ and $\|M\|_{\infty} = \sigma_1(M)$. The most commonly used Schatten p-norms are the trace norm $\|\cdot\|_1 = \|\cdot\|_*$, the Frobenius norm $\|\cdot\|_2 = \|\cdot\|_F$, and the spectral norm $\|\cdot\|_{\infty} = \|\cdot\|_*$, each with its distinctive notation. Schatten p-norms are unitarily invariant, invariant under transposition, and satisfy the matrix inequality $\|AMB\|_p \leq \|A\| \|M\|_p \|B\|$.

In addition to the standard conventions, we introduce the following special definitions. A matrix is said to be rank-r when its rank does not exceed r. We use $\lfloor \mathbf{A} \rfloor_r$ to denote any optimal rank-r approximation of the matrix $\mathbf{A} \in \mathbb{R}^{L \times N}$, derived from an r-truncated singular value decomposition:

$$A = \sum_{i=1}^{N} \sigma_i u_i v_i^*$$
 yields $\lfloor A \rfloor_r = \sum_{i=1}^r \sigma_i u_i v_i^*$.

This low-rank approximation may not be unique, so we employ the notation only in contexts where it leads to an unambiguous statement. We represent the Nyström approximation of a psd matrix $\mathbf{A} \in \mathbb{R}^{N \times N}$ with respect to a test matrix $\mathbf{X} \in \mathbb{R}^{N \times k}$ as $\mathbf{A}\langle \mathbf{X} \rangle = \mathbf{A}\mathbf{X}(\mathbf{X}^*\mathbf{A}\mathbf{X})^{\dagger}\mathbf{X}^*\mathbf{A}$.

- **3. History.** In this section, we provide a concise history of randomized low-rank matrix approximation.
- **3.1. Development of classic iterative methods.** Computational tools for low-rank approximation have their roots in numerical methods for spectral computation. We focus on methods that extract a few eigenvalues and eigenvectors, rather than returning a full spectral decomposition.

In the early 20th century, the power method and variants, such as inverse iteration, emerged as popular techniques for computing a few eigenvalues and eigenvectors of a square matrix (see [97, Sec. 2.1.3]). Around 1950, Lanczos [63] introduced an improvement of the power method for Hermitian matrices that fully exploits Krylov information (matrix powers applied to vectors).

Both the power method and the Lanczos algorithm employ just a single starting vector (i.e., block size k=1), making them inadequate for resolving eigenvalues with multiplicity higher than one. To address this shortcoming, between the 1950s and 1970s, computational mathematicians developed versions of the power method and the Lanczos algorithm that use multiple starting vectors, called "subspace iteration" and "block Krylov iteration" (see [97, Secs. 5.3.4, 6.1.4]).

These classic iterative methods have been extensively discussed in the literature; see Golub and van der Vorst [49] for an historical overview. For modern accounts of the power method and the Lanczos algorithm, refer to the textbooks of Partlett [83] and Saad [91]. Additional analyses of the Lanczos algorithm have been contributed by van der Sluis and van der Vorst (regarding superlinear convergence [105]) and Nemirovsky, Yudin, and Chou (concerning optimality [76, 25]). For analyses of subspace iteration and block Krylov iteration, see Stewart [95] and Li and Zhang [67].

All the traditional iterative methods for calculating the dominant eigenvalues and eigenvectors of a Hermitian matrix can be adapted to calculate the dominant singular values and singular vectors of a general, rectangular matrix $\boldsymbol{A} \in \mathbb{R}^{L \times N}$ by applying them to the Jordan–Wielandt matrix $\begin{bmatrix} 0 & A \\ A^* & 0 \end{bmatrix}$ [47, 48]. When initialized with a random matrix $\boldsymbol{\Omega}$, this approach yields an approximate singular value decomposition $\hat{\boldsymbol{A}} = \boldsymbol{U} \boldsymbol{\Sigma} \boldsymbol{V}^*$ that matches the output of RSI or RBKI (in exact precision arithmetic). However, the iterative approach to singular value decomposition was historically used to calculate a few (say, 1–4) leading singular values and singular vectors [48]. The potential for converting these schemes into algorithms for low-rank approximation apparently went unrecognized in the 20th century.

Early iterative algorithms for eigenvalue or singular vector computations used relatively few starting vectors (say, 3 or 4), which were often generated randomly, e.g., by random Gaussians. The random initialization was viewed as undesirable but necessary to ensure overlap with the dominant singular vectors [79, 27]. To obtain accurate results, the algorithms employed a large number of matrix multiplications (10s or 100s). Numerical analysts emphasized the benefit of these repeated multiplications, since they viewed these computations as limiting processes, rather than finite algorithms [83, Sec. 13.2].

3.2. Recognizing the benefits of random sampling. Dixon (1983) [32] and Kuczyński and Woźniakowski (1992) [61] introduced a fresh perspective by using probability theory to analyze the power method and the Lanczos algorithm. When the starting vector is Gaussian, these authors proved that the iterative algorithms can approximate the largest eigenvalue of a psd matrix after a fixed number of steps that depends logarithmically on the matrix dimension. They also demonstrated that the algorithms succeed even when the maximum eigenvalue is not separated from the remaining eigenvalues. In the papers [32, 61], randomization is seen not as a necessary evil but rather as a helpful tool for guaranteeing robustness.

In the late 1990s and early 2000s, theoretical computer scientists began to investigate randomized low-rank approximation through an approach called column sampling [43, 33, 30, 36]. The simplest column sampling approximation takes the form $\hat{A} = \Pi_C A$, where C is a randomly selected subset of the columns of A [36]. However, it is more typical in this literature to reduce the approximation to a target rank $r \geq 1$, for example, by outputting the r-truncated singular value decomposition $\hat{A} = \lfloor \Pi_C A \rfloor_r$. To sample the columns, many authors use sampling probabilities proportional to the square column norms of A [43, 33], but there are also more elaborate constructions based on adaptive sampling [30] or subspace sampling [36]. The motivating idea behind this work was to discover hidden structure in the target matrix through a judicious use of random sampling. Several analyses [35, 90, 30, 20] prove that column sampling can lead to a more accurate low-rank approximation than traditional deterministic algorithms based on rank-revealing QR [46, 52]. For a more detailed history of column-sampling approaches, see the survey [55, Sec. 2.1.2].

In parallel, researchers began investigating algorithms similar to RSVD and RSI. Papadimitriou et al. (1998) [82, 81] introduced a randomized low-rank approximation $\hat{A} = \Pi_{\lfloor A\Omega \rfloor_r} A$, where $\Omega \in \mathbb{R}^{N \times k}$ is a random orthogonal matrix and $\lfloor A\Omega \rfloor_r$ is a r-truncated singular value decomposition of $A\Omega$. Sarlós (2006) [92] proposed a similar approximation $\hat{A} = \lfloor \Pi_{A\Omega} A \rfloor_r$, where $\Omega \in \mathbb{R}^{N \times k}$ is a subsampled trigonometric transform. Rokhlin et al. (2010) [88] acknowledged the difficulty of approximating a matrix with slowly decaying singular values, and they addressed the problem using a low-rank approximation $\Pi_{\lfloor (AA^*)^{q-1}A\Omega\rfloor_r} A$, where $\Omega \in \mathbb{R}^{N \times k}$ is a Gaussian matrix

and $q \geq 1$ is a depth parameter; see also the well-known 1997 paper of Roweis [89]. These early works argue that a small number of multiplications m with a large block of random vectors (typically, $10 \leq k \leq 1000$) is sufficient to approximate a matrix with rapidly decaying singular values, and they provide preliminary theory to support their argument.

In 2011, Halko, Martinsson, and Tropp [55] developed a framework for designing randomized low-rank approximation algorithms, which leads to the standard versions of RSVD and RSI that treat the the rank-r truncation as an optional last step. Halko et al. also obtained the first precise theoretical analysis for these algorithms that can predict their empirical behavior. They showed that randomized matrix approximation yields provable guarantees after a fixed number of matrix products, even when the input matrix does not have gaps between the singular values. Following the publication of [55], researchers from various fields have applied randomized low-rank approximation to big-data problems in spectral clustering [19], genetics [1, 44], uncertainty quantification [21, 59], and image processing [24, 62, 113], among other areas.

3.3. Proposals for more efficient methods. In the next stage of inquiry, researchers proposed many ways to improve the efficiency of randomized low-rank approximation, going beyond the basic RSVD and RSI algorithms. First, they introduced new approaches for the low-rank approximation of psd matrices based on *Nyström approximation* [55, 66, 101]. For a mathematical description of Nyström approximation, see subsection 4.6 or [69, Sec. 14]. Nyström approximation can be applied with any choice of test vectors, including random Gaussian vectors [101] or random coordinate vectors [111]. The approximation is always psd, and it always yields more accurate results than the simpler approximation based on orthogonal projection (see Lemma 4.2).

In another development, researchers improved the theoretical understanding of structured random matrices $\Omega \in \mathbb{R}^{N \times k}$. Random matrices constructed using sparse sign vectors [17, 28] or subsampled trigonometric transforms [98, 42, 85] can be used for initializing randomized low-rank approximation, while ensuring a high quality of approximation. These structured initialization matrices significantly improve runtimes for algorithms that require just a single matrix multiplication, such as NysSVD (Algorithm 4.6) or one-pass RSVD algorithms [112, 26, 102, 103]. However, when low-rank matrix approximation requires repeatedly multiplying the iterates with \boldsymbol{A} and \boldsymbol{A}^* , as in RSVD or RBKI, the computational benefits of a structured random initialization are limited due to loss of structure after the first multiplication.

Last, one of the most significant advances in low-rank matrix approximation has been the introduction [88, 54] and analysis [73, 109, 34, 99, 100, 6] of randomized block Krylov methods. In 2015, Musco and Musco [73] proved that RBKI can be substantially more accurate than RSI, and their insight has spurred a variety of follow-up works [109, 34, 99, 100, 6]. In spite of this progress, the literature still lacks a crisp treatment of RBKI that parallels the earlier work on RSVD and RBKI. As a consequence, while RBKI is well-known among experts in randomized numerical linear algebra, it remains under-utilized in computational science (for instance, see the recent survey article [104] in genetics). Therefore, our objective in this work is to increase the use of RBKI by providing efficient pseudocode, detailed theory, and numerical experiments that highlight the benefits of this algorithm.

4. Design and implementation. In this section, we explain the goals of randomized low-rank matrix approximation, and we present pseudocode for all of the algorithms we study. Efficient versions of RSVD, RSI, NysSVD and NysSI have already

appeared in [88, 55, 51, 101], but we have developed a faster implementation of RBKI. Our RBKI pseudocode stores and reuses matrix multiplications, leading to computational savings between 33% and 50%. Additionally, to the best of our knowledge, the NysBKI algorithm is a novel contribution to the low-rank matrix approximation literature, and it can provide an additional savings of 30%.

This section is structured as follows: subsections 4.1 and 4.2 identify the goals and consequences of randomized low-rank matrix approximation; subsections 4.3 to 4.5 provide pseudocode for RSVD, RSI, and RBKI; subsection 4.6 discusses Nyström approximation algorithms; and subsection 4.8 discusses modifications to the pseudocode that reduce or eliminate orthogonalization steps.

4.1. Goals of randomized low-rank approximation. The primary purpose of randomized low-rank approximation is to quickly extract structure from a high-dimensional matrix $A \in \mathbb{R}^{L \times N}$. Ideally, a low-rank approximation algorithm should satisfy three main criteria: (1) speed, (2) accuracy, and (3) utility for downstream matrix computations.

The first design criterion is speed. Our goal is to develop multiplication-rich algorithms, which harness the efficiency of matrix multiplications on modern computing platforms. We perform most of the computations in a sequence of matrix multiplications between A or A^* and a block of k vectors. Even with standard matrix multiplication for dense matrices, this approach costs only $\mathcal{O}(kmLN)$ arithmetic operations, so it can be much faster than a traditional (full) singular value decomposition or eigendecomposition, which expends $\mathcal{O}(LN \min\{L,N\})$ operations. See section 5 for examples of computational speed-ups spanning 1 to 3 orders of magnitude.

The second design criterion is accuracy. Our goal is to produce an approximation \hat{A} that is competitive with the best rank-r approximation in spectral norm:

$$\|\mathbf{A} - \hat{\mathbf{A}}\| \approx \|\mathbf{A} - \|\mathbf{A}\|_r\|.$$

We allow the rank of the approximation \hat{A} to be slightly larger than the comparison rank r. Our experiments (section 5) and theory (sections 6 and 7) show how the error from a randomized low-rank approximation achieves the goal (4.1).

The third design criterion is utility for downstream matrix calculations. We focus on algorithms that return a factorized approximation, which can be stored and manipulated efficiently. In the general setting, we seek a singular value decomposition $\hat{A} = U\Sigma V^*$. In the psd setting, we instead seek an eigenvalue decomposition $\hat{A} = U\Lambda U^*$. Consequently, the output of these algorithms identifies the singular values and singular vectors of the approximation \hat{A} , which serve as proxies for the singular values and singular vectors of the input matrix A. Additionally, the factorized output leads to accelerated routines for computing matrix–vector products or solving regularized linear systems.

- **4.2.** Consequences of randomized low-rank approximation. As we have noted, our goal is to produce an approximation that is close to the input matrix in spectral norm, say, $\|A \hat{A}\| \leq \varepsilon$. This type of bound allows us to substitute the approximation in place of the input matrix in many different contexts.
 - 1. Matrix-vector multiplications. We can use the low-rank approximation \hat{A} for matrix-vector products, and the error is controlled as

$$||Av - \hat{A}v|| \le ||A - \hat{A}|||v||.$$

2. Regularized linear systems. If A is psd and we generate a psd Nyström approximation \hat{A} , we can use it to solve a regularized linear system of the form $(A + \mu \mathbf{I})x = y$ with $\mu > 0$; for example, see [31]. By the resolvent identity, the error is controlled as

$$\|(\mathbf{A} + \mu \mathbf{I})^{-1} - (\hat{\mathbf{A}} + \mu \mathbf{I})^{-1}\| = \|(\mathbf{A} + \mu \mathbf{I})^{-1}(\hat{\mathbf{A}} - \mathbf{A})(\hat{\mathbf{A}} + \mu \mathbf{I})^{-1}\|$$

$$\leq \frac{\|\mathbf{A} - \hat{\mathbf{A}}\|}{\mu^2}.$$

Hence, the linear solve is guaranteed to be accurate as long as $\|\mathbf{A} - \hat{\mathbf{A}}\| \ll \mu^2$.

3. Singular values. We can use the low-rank approximation \hat{A} to compute singular values. Weyl's inequality [57, Thm. 4.3.1] guarantees the error is controlled by:

$$|\sigma_i(\mathbf{A}) - \sigma_i(\hat{\mathbf{A}})| \le ||\mathbf{A} - \hat{\mathbf{A}}||$$

for each $1 \le i \le \min\{L, N\}$.

4. Singular vectors. The low-rank approximation \hat{A} can be used to compute singular vectors. Wedin's theorem [110, 96] (also see [80, Thm. 4]) shows that

$$(4.2) \langle \boldsymbol{u}_i(\boldsymbol{A}), \boldsymbol{u}_i(\hat{\boldsymbol{A}}) \rangle^2 + \langle \boldsymbol{v}_i(\boldsymbol{A}), \boldsymbol{v}_i(\hat{\boldsymbol{A}}) \rangle^2 \ge 2 - \frac{8\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|^2}{\delta_i^2(\boldsymbol{A})}.$$

for each $1 \le i < \min\{L, N\}$. Here, $u_i(M)$ denotes the *i*th left singular vector, $v_i(M)$ denotes the *i*th right singular vector, and

$$\delta_i(\boldsymbol{M}) = \min_{j \neq i} |\sigma_j(\boldsymbol{M}) - \sigma_i(\boldsymbol{M})|$$

denotes the *i*th singular gap of a matrix M. As a consequence of (4.2), the *i*th singular vectors of A and \hat{A} are closely aligned, as long as $||A - \hat{A}|| \ll \delta_i(A)$.

In summary, randomized low-rank approximation can be a helpful tool for performing fast, approximate matrix computations.

4.3. RSVD. The simplest approach for randomized low-rank matrix approximation is the *randomized singular value decomposition*, which was introduced in [81, 92] and refined in [55]. RSVD has been applied to thousands of problems in spectral clustering [19], biology [56, 104], uncertainty quantification [21, 59], and image processing [24, 62]. The algorithm is now implemented in scikit-learn using the command "randomized_svd" with parameter "n_iter" set to 0 [84] and in Matlab using the command "svdsketch" with parameter "NumPowerIterations" set to 0 [71].

RSVD generates a low-rank approximation

(RSVD)
$$\hat{A} = \Pi_{A\Omega} A$$
,

where $\Omega \in \mathbb{R}^{N \times k}$ is a random matrix, typically Gaussian, and k is a block size parameter chosen by the user, typically $10 \le k \le 1000$. Algorithm 4.1 provides RSVD pseudocode, which is optimized for efficiency in two ways:

1. The low-rank approximation

$$\Pi_{A\Omega}A = A\Omega(A\Omega)^{\dagger}A$$

is generated without forming the pseudoinverse $(A\Omega)^{\dagger}$. As a cheaper and more stable approach, the columns of $A\Omega$ are orthogonalized to produce a matrix $X \in \mathbb{R}^{L \times k}$ and the low-rank approximation is generated using

$$\Pi_{A\Omega}A = X(X^*A).$$

2. The SVD of $\boldsymbol{X}(\boldsymbol{X}^*\boldsymbol{A})$ is evaluated by first computing the SVD of the wide matrix

$$X^*A = \hat{U}\Sigma V^*$$

and then applying the rotation

$$X(X^*A) = (X\hat{U})\Sigma V^*.$$

These implementation techniques, which are standard [55, Sec. 1.5], lead to the fast and stable pseudocode that is presented in Algorithm 4.1.

Next, we comment on the main user choice when implementing RSVD: choosing the block size k. As a general rule, increasing the block size k increases the cost of RSVD, but it also improves the approximation quality. We provide a quick proof of this fact below:

LEMMA 4.1 (Bigger projection, smaller error). Consider a matrix $\mathbf{A} \in \mathbb{R}^{L \times N}$ and orthogonal projections $\mathbf{P}_1, \mathbf{P}_2 \in \mathbb{R}^{L \times L}$ such that range $(\mathbf{P}_1) \subseteq \text{range}(\mathbf{P}_2)$. Then,

$$||A - P_2 A||_p \le ||A - P_1 A||_p$$

for any Schatten p-norm with $1 \le p \le \infty$.

Proof. Because range(P_1) \subseteq range(P_2), we have $P_1 \preceq P_2$, and the complementary projectors satisfy $I - P_2 \preceq I - P_1$. Since conjugation preserves the psd order,

$$A^*(\mathbf{I} - \mathbf{P}_2)A \leq A^*(\mathbf{I} - \mathbf{P}_1)A.$$

Consequently, for each $1 \le i \le \min\{L, N\}$,

$$\sigma_i(\mathbf{A} - \mathbf{P}_2 \mathbf{A})^2 = \lambda_i(\mathbf{A}^* (\mathbf{I} - \mathbf{P}_2) \mathbf{A})$$

$$\leq \lambda_i(\mathbf{A}^* (\mathbf{I} - \mathbf{P}_1) \mathbf{A}) = \sigma_i(\mathbf{A} - \mathbf{P}_1 \mathbf{A})^2.$$

The inequality is Weyl's monotonicity theorem [57, Thm. 4.3.1]. This statement implies the p-norm inequality (4.3).

Since increasing the block size k improves the approximation quality, the user of RSVD can always raise k to address more difficult problems. As an adaptive strategy, the user can increase k until the Frobenius norm error hits a target precision. That is, $\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|_{\mathrm{F}}^2 = \|\boldsymbol{A}\|_{\mathrm{F}}^2 - \|\hat{\boldsymbol{A}}\|_{\mathrm{F}}^2 < \varepsilon$. This adaptive version of RSVD is currently implemented in the "sydsketch" function for Matlab [71]. The paper [38] proposes a different adaptive strategy for approximating $\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|_{\mathrm{F}}^2$ that remains valid even when \boldsymbol{A} is a linear operator and we evaluate $\boldsymbol{x} \mapsto \boldsymbol{A}\boldsymbol{x}$ and $\boldsymbol{y} \mapsto \boldsymbol{A}^*\boldsymbol{y}$ on the fly for each input vector.

4.4. RSI. The early developers of RSVD acknowledged that the algorithm leads to large random errors when applied to a matrix \boldsymbol{A} with slowly decaying singular values. When targeting a matrix with slow singular value decay, they proposed an alternative strategy called randomized subspace iteration [88, 55]. RSI is based on the randomized low-rank approximation

$$\hat{\pmb{A}} = \pmb{\Pi}_{(\pmb{A}\pmb{A}^*)^{q-1}\pmb{A}\pmb{\Omega}}\pmb{A},$$

where $\Omega \in \mathbb{R}^{N \times k}$ is a random matrix, typically Gaussian, and $q \geq 1$ is a depth parameter. RSI with q=1 is identical to RSVD. Increasing the depth q systematically improves the approximation quality, but the cost grows linearly with q since RSI requires q matrix multiplications with A and q multiplications with A^* . In applications, we typically set q to a modest value, such as $2 \leq q \leq 5$.

We provide simple, stable pseudocode for RSI in Algorithm 4.2. However, note that the pseudocode has the slightly awkward requirement of performing an even number of matrix multiplications (q multiplications with \boldsymbol{A} and q multiplications with \boldsymbol{A}^*). Therefore we ask, "Is there any way to perform RSI with an odd number of multiplications?" Bjarkason [13] (also see earlier work of [88]) answered this question in the affirmative, by replacing the approximation $\hat{\boldsymbol{A}} = \Pi_{(\boldsymbol{A}\boldsymbol{A}^*)^{q-1}\boldsymbol{A}\boldsymbol{\Omega}}\boldsymbol{A}$ with the closely related approximation

$$(4.4) \qquad \hat{A} = A \Pi_{(A^*A)^q \Omega},$$

which requires q+1 matrix-matrix multiplications with \boldsymbol{A} and only q matrix-matrix multiplications with \boldsymbol{A}^* . When multiplications with \boldsymbol{A} are much cheaper than multiplications with \boldsymbol{A}^* , we essentially get the final matrix multiplication for free, and we obtain an improved approximation.

Bjarkason's insight leads to an extended version of RSI that uses either an odd or an even number of matrix multiplications (Algorithm 4.3). To fully optimize the

number of multiplications, we can run Algorithm 4.3 with an adaptive stopping criterion. For example, we can stop the algorithm as soon as the squared Frobenius norm error $\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|_{\mathrm{F}}^2 = \|\boldsymbol{A}\|_{\mathrm{F}}^2 - \|\hat{\boldsymbol{A}}\|_{\mathrm{F}}^2$ falls below a target precision ε .

4.5. RBKI. In light of Lemma 4.1, it is always better to project onto a bigger subspace, and randomized block Krylov iteration projects onto the biggest subspace generated by the sequential matrix products. We define the Krylov subspace $\mathcal{K}_q(\mathbf{A}\mathbf{A}^*; \mathbf{A}\mathbf{\Omega})$ by

$$\mathcal{K}_q(\boldsymbol{A}\boldsymbol{A}^*;\boldsymbol{A}\boldsymbol{\Omega}) = \operatorname{range} \left[\boldsymbol{A}\boldsymbol{\Omega} \quad (\boldsymbol{A}\boldsymbol{A}^*)\boldsymbol{A}\boldsymbol{\Omega} \quad \cdots \quad (\boldsymbol{A}\boldsymbol{A}^*)^{q-1}\boldsymbol{A}\boldsymbol{\Omega} \right]$$

$$= \bigcup_{\deg(\phi) \leq q-1} \operatorname{range} [\phi(\boldsymbol{A}\boldsymbol{A}^*)\boldsymbol{A}\boldsymbol{\Omega}].$$

In this expression, ϕ varies over polynomials with degree q-1. The RBKI method compresses the input matrix to the Krylov subspace:

(RBKI)
$$\hat{A} = \Pi_{\lceil A\Omega \ \cdots \ (AA^*)^{q-1}A\Omega \rceil} A.$$

The Krylov subspace is much larger than the projection space used in RSI, which only contains the range of the final power $(AA^*)^{q-1}A\Omega$. As a consequence, the RBKI approximation has the potential to be much more accurate.

RBKI was first introduced by Rokhlin, Szlam, and Tygert [88]. The paper [54] contains a numerical study in the context of principal component analysis. The first theoretical analysis is due to Musco and Musco [73]. Over the past decade, RBKI has been applied to several problems in genetics [44], meteorology [18], and geophysical imaging [113], leading to reported higher accuracy than RSI. Nonetheless, RBKI has remained under-utilized in applications (as reflected in the computational genetics review [104]).

Algorithm 4.4 presents pseudocode for a simple version of RBKI, while Algorithm 4.5 displays pseudocode for an extended version of RBKI that uses an even or odd number of multiplications. Note that the Gram-Schmidt step (lines 4 and 5)

must be performed twice for numerical stability. In subsequent algorithm displays, we indicate this repetition with the label $(2\times)$ rather than writing out the formula twice

Our RBKI pseudocode is more efficient than existing RBKI implementations [88, 54, 73, 44, 114, 34, 13, 113, 69]. Indeed, the existing procedures all require the following series of multiplications:

- (a) q times: multiply \boldsymbol{A} with a matrix of size $N \times k$;
- (b) q-1 times: multiply A^* with a matrix of size $L \times k$; and
- (c) 1 time: multiply A^* with a block matrix of size $L \times kq$.

In contrast, Algorithm 4.4 uses a reduced set of multiplications:

- (a) q times: multiply **A** with a matrix of size $N \times k$: and
- (b) q times: multiply A^* with a matrix of size $L \times k$.

Our new procedure removes step (c), which involves an expensive multiplication of A^* with a block matrix of size $L \times kq$. We have substituted a single multiplication with a smaller matrix of size $L \times k$.

If we measure computational cost in the simplest way, by counting matrix–vector multiplications, our new pseudocode results in cost savings of 33% to 50%. The savings are 33% when matrix–vector multiplications with \mathbf{A} and \mathbf{A}^* are equally expensive and 50% when matrix–vector multiplications with \mathbf{A} are much more expensive than matrix–vector multiplications with \mathbf{A} (as in some PDE models [13]). Our new pseudocode does not change the asymptotic arithmetic cost of RBKI, which is still $\mathcal{O}(kmLN)$ for dense matrices, yet it makes a noticeable practical difference in applications. There are also potential reductions in communication costs.

Our new pseudocode also enables a clean comparison between RSI and RBKI because the two algorithms now perform matrix multiplications with precisely the same block size k. We will see that RBKI makes better use of the matrix products than RSI, resulting in a far more accurate approximation. Although RBKI performs more arithmetic than RSI outside the matrix products, this arithmetic is rarely the predominant cost of the algorithm.

We do acknowledge that RBKI requires $\mathcal{O}(km(L+N))$ storage whereas RSI only requires $\mathcal{O}(k(L+N))$ storage. In typical applications involving data matrices (see section 5), this is not an issue because storing the low-rank approximation \hat{A} is much cheaper than storing the original matrix A. Overall, we suspect that the RSI method

is preferable to RBKI only in case A is an abstract linear operator and working storage is the limiting factor for the computation.

4.6. Positive-semidefinite matrices. Suppose that $A \in \mathbb{R}^{N \times N}$ is psd and we have generated a matrix $M \in \mathbb{R}^{N \times k}$ whose range is aligned with leading eigenvectors of A. Then, the simplest approximation for A, which is used in RSVD, RSI, and RBKI, are based on compressing the range or co-range of A as follows:

$$\Pi_M A = M(M^*M)^{\dagger} (AM)^*$$
 or $A\Pi_M = (AM)(M^*M)^{\dagger} M^*$.

Since A is psd, we can employ the same data more effectively using the *Nyström approximation* [69, Sec. 14]:

$$A\langle M \rangle := A^{1/2}\Pi_{A^{1/2}M}A^{1/2} = (AM)(M^*(AM))^{\dagger}(AM)^*.$$

The Nyström approximation always improves over the simpler approximations.

LEMMA 4.2 (Nyström helps). Consider a psd matrix $\mathbf{A} \in \mathbb{R}^{N \times N}$ and any matrix $\mathbf{M} \in \mathbb{R}^{N \times k}$. Then

for any Schatten p-norm with $1 \le p \le \infty$.

Proof. Since $\Pi_M A$ and $A\langle M \rangle$ only depend on the range of M, we can assume without loss of generality that M has orthonormal columns and change basis so that $M = \begin{bmatrix} \mathbf{I} \\ \mathbf{0} \end{bmatrix}$. With this transformation, the matrices A, $\Pi_M A$, and $A\langle M \rangle$ can be written in block form:

$$\begin{split} \sigma_{i}(\boldsymbol{A} - \boldsymbol{A}\langle \boldsymbol{M} \rangle)^{2} &= \lambda_{i} \begin{pmatrix} \begin{bmatrix} \mathbf{0} & \mathbf{0} \\ \mathbf{0} & \boldsymbol{A}_{22} - \boldsymbol{A}_{21} \boldsymbol{A}_{11}^{\dagger} \boldsymbol{A}_{12} \end{bmatrix} \end{pmatrix}^{2} \\ &\leq \lambda_{i} \begin{pmatrix} \begin{bmatrix} \mathbf{0} & \mathbf{0} \\ \mathbf{0} & \boldsymbol{A}_{22} \end{bmatrix} \end{pmatrix}^{2} = \lambda_{i} \begin{pmatrix} \begin{bmatrix} \mathbf{0} & \mathbf{0} \\ \mathbf{0} & \boldsymbol{A}_{22}^{2} \end{bmatrix} \end{pmatrix} \\ &\leq \lambda_{i} \begin{pmatrix} \begin{bmatrix} \mathbf{0} & \mathbf{0} \\ \mathbf{0} & \boldsymbol{A}_{22}^{2} + \boldsymbol{A}_{21} \boldsymbol{A}_{12} \end{bmatrix} \end{pmatrix} = \lambda_{i} ((\boldsymbol{A} - \boldsymbol{\Pi}_{\boldsymbol{M}} \boldsymbol{A})(\boldsymbol{A} - \boldsymbol{\Pi}_{\boldsymbol{M}} \boldsymbol{A})^{*}) \\ &= \sigma_{i} (\boldsymbol{A} - \boldsymbol{\Pi}_{\boldsymbol{M}} \boldsymbol{A})^{2} \end{split}$$

for each $1 \le i \le N$, which confirms (4.5).

Next, we show how to incorporate Nyström approximation in three different randomized low-rank approximation algorithms: NysSVD (subsection 4.6.1), NysSI (subsection 4.6.2), and NysBKI (subsection 4.6.3).

4.6.1. NysSVD. In randomized Nyström approximation, we generate a low-rank approximation:

(NysSVD)
$$\hat{m{A}} = m{A} \langle m{\Omega}
angle,$$

where $\Omega \in \mathbb{R}^{N \times k}$ is a random matrix. In this work, Ω is always a Gaussian matrix [101], mimicking the strategy used in RSVD. For parallelism, we call the resulting algorithm NysSVD even though it produces an eigenvalue decomposition.

Algorithm 4.6 presents NysSVD pseudocode, which is optimized for efficiency in the following ways:

1. The low-rank approximation

$$A\langle\Omega\rangle = A\Omega(\Omega^*A\Omega)^\dagger\Omega^*A^*,$$

is generated without ever forming the pseudoinverse $(\Omega^* A \Omega)^{\dagger}$ explicitly. Instead, we compute an upper-triangular Cholesky factor $C \in \mathbb{R}^{k \times k}$ so that $\Omega^*(A\Omega) = C^*C$. The low-rank approximation is generated as

$$m{A}\langle m{\Omega}
angle = (m{A}m{\Omega}m{C}^\dagger)(m{A}m{\Omega}m{C}^\dagger)^*.$$

2. To stabilize the Cholesky decomposition, the Nyström approximation is applied to a shifted operator $A_{\varepsilon} = A + \varepsilon \mathbf{I}$, where the shift parameter $\varepsilon = \varepsilon_{\text{mach}} \text{tr}(\mathbf{A})$ depends on the machine precision. Then, to counteract the shift, the eigenvalues of the approximation \hat{A}_{ε} are all reduced by ε .

These improvements, previously recommended in [66], lead to the fast and robust NysSVD implementation in Algorithm 4.6.

Remark 4.3 (Column Nyström approximation). When evaluating each entry of the input matrix A is expensive, we might prefer to construct a Nyström approximation using individual columns of the input matrix. Equivalently, the test matrix Ω contains (random) coordinate vectors [111]. To find an informative set of columns, we need additional ideas; see the paper [23] and its background references.

4.6.2. NysSI. In randomized subspace iteration with Nyström approximation [55, Alg. 5.5], we approximate a psd matrix $\mathbf{A} \in \mathbb{R}^{N \times N}$ as:

(NysSI)
$$\hat{m{A}} = m{A} \langle m{M}
angle, \quad ext{where} \quad m{M} = m{A}^{m-1} m{\Omega}.$$

This formula corrects an error in the presentation in [69, Sec. 14.5]. NysSI performs better than RSI by one-half of a matrix multiplication, as reflected in our experiments (Figures 4 and 5) and theory (section 7). NysSI pseudocode appears in Algorithm 4.7.

4.6.3. NysBKI. In randomized block Krylov iteration with Nyström approximation, we approximate a psd matrix $A \in \mathbb{R}^{N \times N}$ as

(NysBKI)
$$\hat{m{A}} = m{A} \langle m{M}
angle, \quad ext{where} \quad m{M} = egin{bmatrix} m{\Omega} & m{A} m{\Omega} & m{A}^2 m{\Omega} & \cdots & m{A}^{m-1} m{\Omega} \end{bmatrix}.$$

NysBKI uses the output of every matrix multiplication, not just every second matrix multiplication, to build an enriched approximation space. NysBKI is more efficient than RBKI by roughly a factor of $\sqrt{2}$ matrix multiplications (Figures 4 and 5). To the best of our knowledge, NysBKI has not appeared in the matrix approximation literature before now. NysBKI pseudocode appears in Algorithm 4.8.




Fig. 2. (Accuracy of the singular vectors). Singular vector approximation error for the clean matrix \mathbf{A} (left) and the noisy matrix \mathbf{B} (right), as constructed in subsection 2.3.

4.7. Quality assurance. Here we discuss strategies for controlling the quality of a randomized low-rank approximation \hat{A} . Typically, we observe that a randomized low-rank approximation \hat{A} contains high-accuracy estimates of the leading singular vectors, but lower-quality estimates of the trailing singular vectors. For a numerical example, see Figure 2, where we have applied RBKI with parameters m=5 and k=20 to the clean matrix A and noisy matrix B constructed in subsection 2.3. We plot the error in the ith right singular vector approximation:

$$\|\boldsymbol{\Pi}_{\boldsymbol{v}_i(\boldsymbol{A})} - \boldsymbol{\Pi}_{\boldsymbol{v}_i(\hat{\boldsymbol{A}})}\| \quad \text{or} \quad \|\boldsymbol{\Pi}_{\boldsymbol{v}_i(\boldsymbol{B})} - \boldsymbol{\Pi}_{\boldsymbol{v}_i(\hat{\boldsymbol{B}})}\|,$$

where $v_i(\cdot)$ denotes the *i*th right singular vector of a matrix. The left panel shows that RBKI accurately captures nearly all of the top 100 right singular vectors of \boldsymbol{A} within the 100-dimensional approximation space, with deteriorating quality at the higher indices. The right panel shows that RBKI only captures the leading 10 right singular vectors of \boldsymbol{B} with any accuracy, and the remaining singular vector estimates are pure noise.

To help ensure the quality of the randomized low-rank approximation, the papers [55, 69] recommend applying an r-truncated singular value decomposition to the low-rank approximation, e.g., with a truncation rank r=k-2 or $r=\lfloor k/2 \rfloor$. The truncated singular value decomposition potentially removes some of the least accurate singular vector estimates from consideration. Yet, determining the optimal truncation threshold r is a challenge. In settings of rapid singular value decay, the number of accurate singular vectors could be large (even larger than k, if we are using RBKI). In settings of slow singular value decay, all the singular vectors could be inaccurate. To make matters worse, the estimates associated with clustered singular values are especially poor. In applications, different authors apply different truncation thresholds [1, 44, 16, 41, 40, 64, 14] and even after truncation, there are reports that RSVD and

RSI can produce inaccurate singular value estimates [41, 62, 113, 64, 14, 18]. Clearly, truncation is not a panacea for ensuring accuracy.

In this work, we recommend *not* truncating a randomized low-rank approximation in typical applications. As a rule, truncation hurts the quality of the approximation.

COROLLARY 4.4 (Truncation hurts). Consider a matrix $\mathbf{A} \in \mathbb{R}^{L \times N}$, an orthogonal projection $\mathbf{P} \in \mathbb{R}^{L \times L}$, and an optimal rank-r approximation $[\mathbf{P}\mathbf{A}]_r$. Then,

$$\|oldsymbol{A} - oldsymbol{\lfloor PA
floor}_r\|_p \geq \|oldsymbol{A} - oldsymbol{PA}\|_p$$

for any Schatten p-norm with $1 \le p \le \infty$.

Proof. Observe that $\lfloor PA \rfloor_r = QA$, where Q is the orthogonal projection onto the dominant r left singular vectors of PA, and apply Lemma 4.1.

Truncation is most appropriate if we are storing and repeatedly using the matrix approximation \hat{A} for matrix–vector multiplications or regularized linear systems. Then truncation has the benefit of reducing downstream operating costs. Nonetheless, many researchers prefer not to truncate in applications [24, 87], given the difficulty in determining the proper truncation rank and the loss of accuracy signaled by Corollary 4.4.

As an alternative to truncation, we recommend monitoring convergence and halting the randomized low-rank approximation algorithm when the estimates of interest are sufficiently converged. This approach has long been applied in iterative methods for eigendecomposition [79] and singular value decomposition [10], and we recommend extending it to randomized low-rank approximation as well. For example, as we increase the block size k or number of multiplications m, we can monitor the convergence of the singular value estimates or the angles between the singular vector estimates. As a more rigorous strategy, we can monitor the square residual:

(4.6)
$$r_i^2 = \|\hat{\boldsymbol{u}}_i^* \boldsymbol{A} - \hat{\sigma}_i \hat{\boldsymbol{v}}_i^*\|^2 + \|\boldsymbol{A}\hat{\boldsymbol{v}}_i - \hat{\sigma}_i \hat{\boldsymbol{u}}_i\|^2,$$

associated with the *i*th estimated singular vector triplet $(\hat{\boldsymbol{u}}_i, \hat{\sigma}_i, \hat{\boldsymbol{v}}_i)$. When (4.6) is small, a backward error analysis [53] ensures there is a nearby matrix $\boldsymbol{A} + \boldsymbol{E}$ with exactly the singular vector triplet $(\hat{\boldsymbol{u}}_i, \hat{\sigma}_i, \hat{\boldsymbol{v}}_i)$.

Last, a statistical approach for posterior error evaluation, based on the jackknife, appears in the recent preprint [38]. This technique can be applied to matrix approximations, singular value estimates, and singular subspace estimates. Moreover, the method avoids additional matvecs with the input matrix.

4.8. Additional opportunities for speedups. So far, we have presented simple, stable pseudocode that requires the minimal number of matrix multiplications with A and A^* . However, we have not necessarily optimized the operations involving smaller matrices, and the algorithms use a large number of QR and SVD factorizations. Here we discuss some possibilities for computational speedups by removing or replacing these factorizations. This section is intended for numerical linear algebra experts, and most readers can skip it with impunity.

As the first speedup opportunity, we can remove all the SVD steps in our pseudocode [24]. For example, we can redesign RSVD to return a factorization $\hat{A} = XY^*$, without ever calculating the singular values and vectors. We can make similar adjustments to the pseudocode for other randomized low-rank approximation algorithms. After these changes, the algorithms return the same low-rank approximation (in exact precision arithmetic), but the singular values and singular vectors of \hat{A} are no longer easily accessible as before.

As the second speedup opportunity, we can replace all but the last QR factorization in RSI and NysSI with a cheaper matrix decomposition. Indeed, the sole purpose of the QR factorizations is to prevent the iterates from becoming ill-conditioned, but we can also avoid ill-conditioning using an LU factorization [66] or a randomized QR decomposition [7, 8]. These alternatives use roughly 50% of the arithmetic of the standard pivoted QR factorization.

For RBKI and NysBKI, we can also replace the block orthogonalization steps (such as lines 4–5 in Algorithm 4.4) by a shorter Lanczos-type recurrence [75]:

$$m{X}_i = m{X}_i - \sum_{j=i-2}^{i-1} m{X}_j (m{X}_j^* m{X}_i).$$

This change reduces the cost of the arithmetic so that the dependence on the depth q is linear, rather than quadratic. On the other hand, in finite precision arithmetic it may result in a basis $M = \begin{bmatrix} X_1 & \cdots & X_q \end{bmatrix}$ that is not orthogonal. Accepting this outcome, we still have the property that $A^*M = \begin{bmatrix} Y_1 & \cdots & Y_q \end{bmatrix}$. Provided that M is not too badly conditioned, we can compute a reliable approximation of the form

$$\hat{A} = (M^{\dagger})^* (M^* A).$$

Of course, we must take care with the numerical aspects of the formula.

In all of the algorithms, the final orthogonalization step is the most critical, because it is used to compute the low-rank approximation $\hat{A} = \Pi_M A$ from a nonorthogonal basis matrix M. However, if we are willing to accept some additional error, Nakatsukasa [74, 75] has proposed replacing the approximation $\hat{A} = \Pi_M A = MM^{\dagger}A$ with a cheaper approximation

$$\hat{\boldsymbol{A}} = \boldsymbol{M}(\boldsymbol{S}\boldsymbol{M})^{\dagger}\boldsymbol{S}\boldsymbol{A},$$

where S is a randomized embedding matrix that can be applied quickly to M and A. Nakatsukasa [74] finds the additional error to be small in numerical tests. When we have access to A^*M , we can also consider the similar formula

$$\hat{\boldsymbol{A}} = \boldsymbol{M}((\boldsymbol{S}\boldsymbol{M})^*(\boldsymbol{S}\boldsymbol{M}))^{\dagger}(\boldsymbol{M}^*\boldsymbol{A}).$$

Both approaches require careful implementation to preserve numerical stability, but they work when the basis matrix M is not too badly conditioned.

- **5. Applications.** In this section, we present experiments comparing the low-rank approximation algorithms, and we apply the algorithms to scientific problems that require principal component analysis or kernel spectral clustering.
- **5.1. Comparison of low-rank approximation algorithms.** As a simple, direct comparison, we apply RSVD, RSI, RBKI, and their Nyström-based variants to approximate two psd matrices \boldsymbol{A} and \boldsymbol{B} with singular values

$$\sigma_i(\mathbf{A}) = e^{-i/25}, \qquad \sigma_i(\mathbf{B}) = \max \left\{ e^{-i/25}, \frac{1 - i/10^5}{25} \right\}, \qquad i = 1, 2, \dots, 10^5.$$




Fig. 3. (Fast vs. slow singular value decay). Fast singular value decay of the matrix A versus slow singular value decay of the matrix B, as constructed in subsection 5.1.

Matrix B models a noisy variant of A, with noise affecting the singular values $\sigma_i(B)$ for $i \geq 81$ (see Figure 3). The noise singular values are small, ranging from 0.00 to 0.04 in magnitude, but given the high-dimensionality ($L = N = 10^5$), they threaten to drown out the signal. We construct A and B as diagonal matrices, as the choice of




Fig. 4. (Matrix approximation comparisons). Matrix approximation error for a matrix \mathbf{A} with fast singular value decay (left) and a matrix \mathbf{B} with slow singular value decay (right). Algorithms for general matrices are on top, algorithms for psd matrices are on bottom.

singular vectors does not affect the performance of our algorithms in exact arithmetic (see Lemma 6.3).

Figure 4 evaluates the computational cost and approximation error of several low-rank approximation algorithms. The horizontal axis measures the computational cost using the product of the block size k and the number of multiplications m. We allow




Fig. 5. (Singular vector approximation comparisons). Error in the dominant 75 singular vectors for a matrix \mathbf{A} with fast singular value decay (left) and a matrix \mathbf{B} with slow singular value decay (right). Algorithms for general matrices are on top, algorithms for psd matrices are on bottom.

the block size k to vary for RSVD and NysSVD, but we fix the block size to k=100 for the other algorithms. The vertical axis measures the mean-squared spectral-norm approximation error

$$\left(\mathbb{E} \left\| \hat{\boldsymbol{A}} - \boldsymbol{A} \right\|^2 \right)^{1/2} \quad \text{or} \quad \left(\mathbb{E} \left\| \hat{\boldsymbol{B}} - \boldsymbol{B} \right\|^2 \right)^{1/2}.$$

In experiments, the expectation is approximated empirically over 100 independent Gaussian initializations. Note that we are using absolute (not relative) errors here.

The results in Figure 4 show that various randomized low-rank approximation algorithms, including NysSVD and RSVD, can produce a high-quality approximation of the matrix \boldsymbol{A} with fast singular value decay. Since NysSVD and RSVD use fewer matrix multiplications (m=1 for NysSVD, m=2 for RSVD), these strategies are better at approximating such a matrix. NysSVD is even more efficient than RSVD since it achieves the same approximation accuracy using half as many matrix multiplications.

In contrast, the Krylov methods yield the highest accuracy approximations for the matrix \boldsymbol{B} with slowly decaying singular values. The NysBKI method is the top performer, since it achieves this high approximation accuracy using a factor of $\sqrt{2}$ fewer multiplications than RBKI.

Next, Figure 5 compares the singular vector approximations obtained with sev-




Fig. 6. (Clustering in genetics). Clustering individuals based on the top 5 principal components of the HapMap3 data set.

eral low-rank approximation algorithms. The singular vectors are vital for principal component analysis and kernel spectral clustering, as we will show through examples in subsections 5.2 and 5.3. We evaluate the error in the estimated singular vectors as

$$\left(\mathbb{E}\big\|\boldsymbol{\Pi}_{75}(\hat{\boldsymbol{A}}) - \boldsymbol{\Pi}_{75}(\boldsymbol{A})\big\|^2\right)^{1/2} \quad \text{or} \quad \left(\mathbb{E}\big\|\boldsymbol{\Pi}_{75}(\hat{\boldsymbol{B}}) - \boldsymbol{\Pi}_{75}(\boldsymbol{B})\big\|^2\right)^{1/2},$$

where $\Pi_{75}(\cdot)$ denotes the orthogonal projection onto the dominant 75 right singular vectors. We find that RSVD and NysSVD lead to accurate singular vector approximations for the matrix \boldsymbol{A} with rapid singular value decay (as do the Krylov methods). However, RBKI and NysBKI produce $10\times$ to $300\times$ more accurate singular vector approximations for the matrix \boldsymbol{B} than the other randomized low-rank approximation methods.

5.2. Human genetic diversity data. Randomized low-rank approximation is frequently applied to large matrices containing single-nucleotide polymorphism (SNP) data, encoding the variations in DNA at specific locations in the genome [1, 44]. The results are used to identify the principal components of the SNP data and cluster individuals that share similar genomes.

Here, we apply principal component analysis to the HapMap3 data set [58], one of the earliest data sets measuring human genetic diversity, which we downloaded from [2]. The data is organized into a matrix $\mathbf{A} \in \mathbb{R}^{957 \times 14,079}$ containing counts of SNPs for 957 individuals in 14,079 chromosomal locations. The entries of \mathbf{A} are 0, 1, or 2, corresponding to two copies of each chromosome in humans. To normalize the matrix entries, we apply the transformation

$$\boldsymbol{B}_{ij} = \frac{\boldsymbol{A}_{ij} - \mu_j}{\sqrt{\mu_j/2(1 - \mu_j/2)}}, \text{ where } \mu_j = \frac{1}{957} \sum_{i=1}^{957} \boldsymbol{A}_{ij}.$$

Our goal is to extract the principal components, which are defined as the right singular vectors of \mathbf{B} . Once we have identified the principal components, we can cluster individuals by genetic ancestry as depicted in Figure 6.

HapMap3 is a small data set by today's standards, and we can obtain the principal components using a full singular value decomposition on a laptop. Yet, modern




Fig. 7. (Singular value decay in genetics). Singular value decay for the HapMap3 data.




Fig. 8. (Approximating principal components in genetics). Error in the top i=5 principal components (left) or top i=7 principal components (right) for the HapMap3 data.

genetics data sets may contain millions of individuals and genetic markers, making a full singular value decomposition infeasible [16]. Therefore, we consider a more scalable approach to principal component analysis based on randomized low-rank approximation.

We acknowledge that the randomized approach to principal component analysis has been questioned in the past. In 2013, Chen et al. wrote [22],

"In theory, randomized eigenvector approximations [RSVD] can reduce the running time... (Rokhlin et al., 2009). However, a colleague of ours reports that efforts to apply this approach to genetic data have not yet been successful, as in large datasets, eigenvalues may be highly significant (reflecting real population structure in the data) but only slightly larger than background noise eigenvalues, and thus sometimes missed by randomized methods (N. Patterson, personal communication)."

The authors are concerned that randomized algorithms cannot accurately identify principal components when the singular values are close together. This limitation would present a major obstacle, since genetics data sets are characterized by small singular value gaps, as shown for the HapMap3 data in Figure 7.

Figure 8 compares the accuracy of RSVD, RSI (with k=20), and RBKI (with k=20) when approximating the principal components of the HapMap3 data. The vertical axis evaluates error in the principal components using

$$\left(\mathbb{E}\left\|\mathbf{\Pi}_{i}(\hat{\boldsymbol{B}})-\mathbf{\Pi}_{i}(\boldsymbol{B})\right\|^{2}\right)^{1/2},$$

where $\Pi_i(\cdot)$ represents the orthogonal projection onto the top i right singular vectors and the expectation is measured empirically over 100 independent Gaussian initializations. The top i=5 principal components (left column) are separated by a sizable spectral gap, whereas the top i=7 principal components (right column) are separated by a tiny singular value gap leading to larger errors. The results in Figure 8 confirm that RSVD and RSI struggle to identify the top i=7 principal components in the data. Only RBKI identifies all 7 principal components up to a precision of 0.1.

RBKI also performs well at separating individuals into clusters. With just m=4 multiplications, the algorithm identifies the top i=5 principal components well enough to match the ideal clustering results in Figure 6. In contrast, we would need to perform RSVD with a block size $25 \times larger$ (k=500) to achieve the same clustering accuracy.

These investigations show that RBKI is both fast and accurate when performing principal component analysis with genetics data. RBKI is faster than traditional singular value decomposition, since we can take km to be a small fraction of the number of rows. Moreover RBKI is highly accurate, even when the signal barely rises above the noise.

5.3. Spectral clustering. Kernel spectral clustering is a common tool for analyzing molecular dynamics simulations of proteins [45]. The approach is useful for identifying metastable states (e.g., folded and unfolded states) that the protein occupies for a long time, with rare transitions between states. However in the past, kernel spectral clustering has mainly been limited to data sets with $N \leq 10^4$ data points, because it requires calculating the dominant eigenvectors of an $N \times N$ matrix.

Here, we use randomized low-rank approximation to extend kernel spectral clustering to a larger data set with $N=2.5\times 10^5$ data points. The data is derived from a 250 ns simulation of alanine dipeptide (CH₃-CO-NH-C $_{\alpha}$ HCH₃-CO-NH-CH₃), which we downloaded from [77]. There are 250,000 data points $\boldsymbol{x}^{(i)} \in \mathbb{R}^{30}$, identifying the spatial (x,y,z)-positions of the 10 non-hydrogen atoms. We will perform kernel spectral clustering as follows.

1. Form the psd Gaussian kernel matrix $\boldsymbol{A} \in \mathbb{R}^{N \times N}$ with entries

$$a_{ij} = \exp\left(-\frac{1}{2\sigma^2} \|\boldsymbol{x}^{(i)} - \boldsymbol{x}^{(j)}\|^2\right),$$

where $\sigma > 0$ is a tunable bandwidth.

- 2. Form the diagonal matrix $D \in \mathbb{R}^{N \times N}$ containing the row sums of A.
- 3. Calculate the dominant r eigenvectors $\mathbf{V} = \begin{bmatrix} \mathbf{v}^{(1)} & \cdots & \mathbf{v}^{(r)} \end{bmatrix}$ for the psd matrix $\mathbf{D}^{-1/2} \mathbf{A} \mathbf{D}^{-1/2}$, where r is a tunable parameter.
- 4. Apply the diagonal rescaling $V \leftarrow D^{-1/2}V$, so that V contains right eigenvectors of $D^{-1}A$.
- 5. Apply k-means clustering to the rows of V.




Fig. 9. (Clustering in biochemistry). Clustering results for alanine dipeptide (N=250,000) with a bandwidth $\sigma=.05$.

The results of kernel spectral clustering are shown in Figure 9. As the horizontal and vertical coordinates, we plot the dihedral angle ϕ between C, N, C_{α} , and C and




Fig. 10. (Eigenvalue decay in biochemistry). Eigenvalues of the alanine dipeptide data (subset of N = 25,000 data points) with different bandwidths.

the angle ψ between N, C_{α} , C, and N, which are known to identify the low-energy configurations of alanine dipeptide [78]. Yet when we feed the data into the kernel spectral clustering algorithm, we do not provide access to the dihedral angles, only the (x, y, z)-positions of the 10 backbone atoms. The algorithm discovers the clusters organically.

It is especially challenging to complete the third step of kernel spectral clustering, which requires calculating the dominant eigenvectors of an $N \times N$ psd matrix. For the alanine dipeptide problem, the matrix $\boldsymbol{B} = \boldsymbol{D}^{-1/2} \boldsymbol{A} \boldsymbol{D}^{-1/2}$ requires 222GB storage and is therefore too large to fit in working memory on a 64GB laptop. To produce the results in Figure 9, therefore, we stored the matrix on disk and applied the NysBKI algorithm to approximate the eigenvectors. With m=10 multiplications and a block size k=20, NysBKI runs in 23 minutes and 99.8% of the time is spent loading blocks of the matrix and performing blockwise matrix multiplications.




Fig. 11. (Approximating eigenvectors in biochemistry). Error in the top 3 eigenvectors for the alanine dipeptide data (subset of N=25,000 data points) with a bandwidth $\sigma=.15$ (left), $\sigma=.10$ (center) or $\sigma=.05$ (right).

To provide more insight into the difficulties of kernel spectral clustering, we take a subset of N=25,000 data points (so we can perform a full eigendecomposition as a reference), and we consider the impact of varying the bandwidth σ . When σ is small, the matrix $\mathbf{B} = \mathbf{D}^{-1/2} \mathbf{A} \mathbf{D}^{-1/2}$ becomes more difficult to approximate since there are slowly decaying eigenvalues (Figure 10). Nonetheless, a small bandwidth σ is needed to obtain physically relevant clusters with sharp boundaries between clusters. Figure 11 evaluates the eigenvector approximation error

$$\left(\mathbb{E}\left\|\mathbf{\Pi}_{3}(\hat{\boldsymbol{B}})-\mathbf{\Pi}_{3}(\boldsymbol{B})\right\|^{2}\right)^{1/2}$$

where Π_3 is the orthogonal projection onto the dominant three eigenvectors. The results show that NysSVD and NysSI can produce high-quality approximations when $\sigma = .15$ (left) and to a lesser extent when $\sigma = .10$ (center). However, only NysBKI can produce a high-quality approximation when $\sigma = .05$ (right), which is the physically relevant parameter setting for alanine dipeptide.

In summary, we find that kernel spectral clustering leads to challenging, high-dimensional eigenvalue problems, especially when the bandwidth σ is small. To solve these eigenvalue problems with high accuracy and scalability, we recommend the NysBKI algorithm. NysBKI works robustly across different bandblock sizes and it leads to speedups of 2–3 orders of magnitude over a traditional eigendecomposition.

6. Analysis of RSVD and NysSVD. In this section, we derive error bounds for RSVD (Algorithm 4.1) and NysSVD (Algorithm 4.6), which are the simplest randomized low-rank approximation algorithms. These results provide the foundation for studying the more sophisticated methods (RSI, RBKI, NysSI, NysBKI). Although related results are already well-established [55], we have found opportunities for simplification and improvement.

We compare the RSVD approximation to an optimal rank-r approximation $\lfloor A \rfloor_r$, which arises from an r-truncated singular value decomposition, and we establish the following main result. The proof appears below in subsection 6.3.

Theorem 6.1 (RSVD error). Fix a matrix $\mathbf{A} \in \mathbb{R}^{L \times N}$ and a target rank $r \geq 1$. For any $2 \leq p \leq \infty$ and $u, t \geq 0$, RSVD with $k \geq r$ Gaussian initialization vectors generates a random rank-k approximation $\hat{\mathbf{A}} \in \mathbb{R}^{L \times N}$ that satisfies

$$\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|_p^2 \leq \|\boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_r\|_p^2 + \frac{utr}{k-r+1} \|\boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_r\|_{\mathrm{F}}^2$$

with failure probability at most $e^{-(u-2)/4} + \sqrt{\pi r}(t/e)^{-(k-r+1)/2}$. Additionally, if the block size $k \ge r+2$, then

$$\mathbb{E}\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|_p^2 \leq \|\boldsymbol{A} - \lfloor \boldsymbol{A}\rfloor_r\|_p^2 + \frac{r}{k-r-1}\|\boldsymbol{A} - \lfloor \boldsymbol{A}\rfloor_r\|_{\mathrm{F}}^2.$$

The result for NysSVD is a corollary of the result for RSVD.

COROLLARY 6.2 (NysSVD error). Fix a psd matrix $\mathbf{A} \in \mathbb{R}^{N \times N}$ and a target rank $r \geq 1$. For any $1 \leq p \leq \infty$ and $u,t \geq 0$, NysSVD with $k \geq r$ Gaussian initialization vectors generates a random rank-k approximation $\hat{\mathbf{A}} \in \mathbb{R}^{N \times N}$ that satisfies

$$\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|_p \leq \|\boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_r\|_p + \frac{utr}{k-r+1}\|\boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_r\|_*$$

with failure probability at most $e^{-(u-2)/4} + \sqrt{\pi r}(t/e)^{-(k-r+1)/2}$. Additionally, if the block size $k \ge r+2$, then

$$\mathbb{E}\|\boldsymbol{A}-\hat{\boldsymbol{A}}\|_p \leq \|\boldsymbol{A}-\lfloor\boldsymbol{A}\rfloor_r\|_p + \frac{r}{k-r-1}\|\boldsymbol{A}-\lfloor\boldsymbol{A}\rfloor_r\|_*.$$

The error bounds in Theorem 6.1 and Corollary 6.2 only depend on the singular values $\sigma_i(\mathbf{A})$ for $i \geq r+1$. If the tail singular values are small and rapidly decaying, the theorem immediately establishes the accuracy of the RSVD and NysSVD approximations.

Interpreting these error bounds, we identify two limitations of RSVD and NysSVD. First, when the singular values decay slowly, the terms $\|\boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_r\|_{\mathrm{F}}$ and $\|\boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_r\|_*$ are large, in which case RSVD and NysSVD perform poorly, as confirmed by our experiments in section 5. To target matrices with slow singular value decay, we need more powerful algorithms, such as RBKI and NysBKI.

As another limitation, the expectation bounds are not applicable when k=r or k=r+1, and the probability bounds suggest that large random errors can occur when k-r is small. The requirements on k-r extend to all the randomized low-rank approximation algorithms considered in this survey. This reflects a fundamental problem that the range of k random Gaussian initialization vectors might barely align with the dominant r singular vectors when k-r is small.

RSVD and NysSVD were previously analyzed in [55, 51, 101]. However, by revisiting and reworking the details of these analyses, we obtain a more flexible framework that delivers many new bounds. The probability bounds (RSVD1) and (NysSVD1) are especially novel and informative, since previous analyses [51, 100] separated the cases k=r, k=r+1, and $k\geq r+2$ whereas we provide a unified treatment. Additionally, our analytic approach leads to a broad range of expectation bounds for RSVD and NysSVD, many of them new, to be presented in subsection 6.4.

The new technical idea in this section is to decompose the Schatten *p*-norm error of RSVD in a simple way using *parallel sums* of psd matrices [4]. Parallel sums, which generalize the harmonic mean to the case of psd matrices, are sufficiently tractable that they allow us to produce a wide range of probability and expectation bounds. To our knowledge, parallel sums have not been previously exploited in the randomized matrix approximation literature.

The rest of this section contains a complete and up-to-date analysis of RSVD and NysSVD. Subsection 6.1 presents a reduction to the case of diagonal, psd matrices; subsection 6.2 analyzes the error of RSVD using parallel sums; subsection 6.3 uses random matrix theory to prove our main error bounds; and subsection 6.4 derives additional expectation bounds for RSVD and NysSVD. Afterward, section 7 deploys these results to describe the behavior of RSI, NysSI, RBKI, and NysBKI.

6.1. Diagonal, psd reduction. As the first step in our analysis, we show that the error of many randomized low-rank approximation algorithms depends only on the singular values of the target matrix, regardless of the singular vectors. This reduction is standard.

LEMMA 6.3 (Diagonal, psd reduction). When we apply RSVD, RSI, RBKI, NysSVD, NysSI, or NysBKI to approximate a matrix $A \in \mathbb{R}^{L \times N}$ using a Gaussian initialization

matrix $\Omega \in \mathbb{R}^{N \times k}$, the Schatten p-norm error $\|\mathbf{A} - \hat{\mathbf{A}}\|_p$ has a distribution that only depends on the singular values of \mathbf{A} , regardless of the singular vectors, for any $1 \leq p \leq \infty$.

Proof. Let $U\Sigma V^*$ be a singular value decomposition for A and set $\Omega' = V^*\Omega$. The randomized low-rank approximation \hat{A} can be written:

$$\begin{array}{lll} \text{(RSVD)} & & U\big(\Pi_{\Sigma\Omega'}\Sigma\big)V^*, \\ \text{(RSI, even } m) & & U\big(\Pi_{\Sigma^{m-1}\Omega'}\Sigma\big)V^*, \\ \text{(RSI, odd } m) & & U\big(\Sigma\Pi_{\Sigma^{m-1}\Omega'}\big)V^*, \\ \text{(RBKI, even } m) & & U\big(\Pi_{[\Sigma^{m-1}\Omega' \ \Sigma^{m-3}\Omega' \ \dots \ \Sigma^2\Omega']}\Sigma\big)V^*, \\ \text{(RBKI, odd } m) & & U\big(\Sigma\Pi_{[\Sigma^{m-1}\Omega' \ \Sigma^{m-3}\Omega' \ \dots \ \Sigma^2\Omega']}\big)V^*, \end{array}$$

The Schatten p-norm is unitarily invariant, so the p-norm error only depends on Σ and the matrix $\Omega' = V^*\Omega$, which is a random Gaussian matrix.

Similarly, if $A \in \mathbb{R}^{N \times N}$ is psd, let $U\Sigma U^*$ be an eigenvalue decomposition for A and set $\Omega' = U^*\Omega$. The randomized low-rank approximation \hat{A} can be written:

$$\begin{array}{ll} \text{(NysSVD)} & U\big(\boldsymbol{\Sigma}^{1/2}\boldsymbol{\Pi}_{\boldsymbol{\Sigma}^{1/2}\boldsymbol{\Omega}'}\boldsymbol{\Sigma}^{1/2}\big)\boldsymbol{U}^*, \\ \text{(NysSI)} & U\big(\boldsymbol{\Sigma}^{1/2}\boldsymbol{\Pi}_{\boldsymbol{\Sigma}^{m-1/2}\boldsymbol{\Omega}'}\boldsymbol{\Sigma}^{1/2}\big)\boldsymbol{U}^*, \\ \text{(NysBKI)} & U\big(\boldsymbol{\Sigma}^{1/2}\boldsymbol{\Pi}_{\boldsymbol{\Sigma}^{m-1/2}\boldsymbol{\Omega}'}\boldsymbol{\Sigma}^{m-3/2}\boldsymbol{\Omega}' \dots \boldsymbol{\Sigma}^{1/2}\boldsymbol{\Omega}']\boldsymbol{\Sigma}^{1/2}\big)\boldsymbol{U}^*. \end{array}$$

The same conclusion follows as before: the error only depends on Σ and the Gaussian matrix $\Omega' = U^*\Omega$.

As a consequence of Lemma 6.3 and without loss of generality, the subsequent analysis will assume that we are approximating a matrix $\mathbf{A} \in \mathbb{R}^{N \times N}$ that is diagonal and psd, with nonincreasing diagonal entries.

6.2. Deterministic analysis using parallel sums. In this section, we develop a simple formula for the error of RSVD when approximating a diagonal, psd matrix. We fix the target matrix $\mathbf{A} \in \mathbb{R}^{N \times N}$, we fix the initialization matrix $\mathbf{\Omega} \in \mathbb{R}^{N \times k}$, and we analyze the p-norm error $\|\mathbf{A} - \mathbf{\Pi}_{\mathbf{A}\mathbf{\Omega}}\mathbf{A}\|_p$. For this section, it does not matter whether the test matrix $\mathbf{\Omega}$ is deterministic or random.

Our analysis is based on *parallel sums* of psd matrices. Parallel sums were introduced by Anderson & Duffin [4] to give a mathematical framework for analyzing electric networks of capacitors and resistors. Parallel sums have become a favorite topic in linear algebra textbooks (e.g., [12, Ch. 4]), and they satisfy the following simple and natural properties:

Lemma 6.4 (Parallel sums). For psd matrices A, B with the same dimension, define the parallel sum A : B to be the psd matrix

$$A: B = A - A(A+B)^{\dagger}A.$$

Then the following properties hold:

- 1. The parallel sum is symmetric; that is, A : B = B : A.
- 2. If A and B are strictly positive definite, then $A : B = (A^{-1} + B^{-1})^{-1}$.
- 3. The mapping $B \mapsto A : B$ is monotone and concave with respect to the psd ordering, and it is bounded above as $A : B \leq A$.
- 4. $\|\mathbf{A}:\mathbf{B}\|_p \leq \|\mathbf{A}\|_p : \|\mathbf{B}\|_p$ for any Schatten p-norm with $1 \leq p \leq \infty$.

Proof. Anderson & Duffin [4] established properties (1)–(3) and property (4) in the special cases p=1 and $p=\infty$. Ando extended property (4) to the general case $1 \le p \le \infty$; see [5, eq. 3.13].

Next, we use parallel sums to analyze the RSVD error. Our error decomposition is similar to [55, Theorem 9.1], but parallel sums allow us to highlight the main reasoning and shorten the proof.

PROPOSITION 6.5 (Error decomposition). Fix a diagonal, psd matrix $\mathbf{A} \in \mathbb{R}^{N \times N}$ and a test matrix $\mathbf{\Omega} \in \mathbb{R}^{N \times k}$. Partition the matrices as

$$oldsymbol{A} = egin{bmatrix} oldsymbol{A}_1 & & & & & & oldsymbol{\Omega}_1 \ & & oldsymbol{A}_2 \end{bmatrix}, & oldsymbol{\Omega} = egin{bmatrix} oldsymbol{\Omega}_1 \ oldsymbol{\Omega}_2 \end{bmatrix},$$

so that A_1 is a $r \times r$ matrix and Ω_1 is a $r \times k$ matrix with $r \leq k$. Assume that $\operatorname{rank}(\Omega_1) = r$. Then the orthogonal projection $Q = \Pi_{A\Omega\Omega^{\dagger}}$ satisfies

(6.1)
$$\|\boldsymbol{A} - \boldsymbol{Q}\boldsymbol{A}\|_{n}^{2} \leq \|\boldsymbol{A}_{2}\|_{n}^{2} + \|\boldsymbol{A}_{1}\|_{n}^{2} : \|\boldsymbol{A}_{2}\boldsymbol{\Omega}_{1}\boldsymbol{\Omega}_{1}^{\dagger}\|_{n}^{2}$$

$$\leq \|\boldsymbol{A}_2\|_p^2 + \|\boldsymbol{A}_2\boldsymbol{\Omega}_2\boldsymbol{\Omega}_1^{\dagger}\|_p^2.$$

for any Schatten p-norm with $2 \le p \le \infty$.

Proof. We make the following calculation:

(6.3)
$$\|(\mathbf{I} - \mathbf{Q})\mathbf{A}\|_{p}^{2} = \|(\mathbf{I} - \mathbf{Q})\mathbf{A}^{2}(\mathbf{I} - \mathbf{Q})\|_{p/2}$$

$$(6.4) \leq \left\| (\mathbf{I} - \mathbf{Q}) \begin{bmatrix} \mathbf{0} & \\ & \mathbf{A}_2^2 \end{bmatrix} (\mathbf{I} - \mathbf{Q}) \right\|_{p/2} + \left\| (\mathbf{I} - \mathbf{Q}) \begin{bmatrix} \mathbf{A}_1^2 & \\ & \mathbf{0} \end{bmatrix} (\mathbf{I} - \mathbf{Q}) \right\|_{p/2}$$

$$(6.5) \leq \left\| \begin{bmatrix} \mathbf{0} & \\ & \mathbf{A}_2 \end{bmatrix} \right\|_{n}^{2} + \left\| (\mathbf{I} - \mathbf{Q}) \begin{bmatrix} \mathbf{A}_1 & \\ & \mathbf{0} \end{bmatrix} \right\|_{n}^{2}$$

(6.6)
$$= \|\mathbf{A}_2\|_p^2 + \left\| \begin{bmatrix} \mathbf{A}_1 & \\ & \mathbf{0} \end{bmatrix} (\mathbf{I} - \mathbf{Q}) \begin{bmatrix} \mathbf{A}_1 & \\ & \mathbf{0} \end{bmatrix} \right\|_{p/2}.$$

Equations (6.3), (6.5), and (6.6) use identities $\|\mathbf{M}\|_p^2 = \|\mathbf{M}^*\mathbf{M}\|_{p/2} = \|\mathbf{M}\mathbf{M}^*\|_{p/2}$, while (6.4) follows from the triangle inequality, and (6.5) relies on the property that the orthogonal projector $\mathbf{I} - \mathbf{Q}$ is a p-norm contraction.

Next, the orthogonal projector Q is given explicitly by the formula

(6.7)
$$Q = (A\Omega\Omega_1^{\dagger}) [(A\Omega\Omega_1^{\dagger})^* (A\Omega\Omega_1^{\dagger})]^{\dagger} (A\Omega\Omega_1^{\dagger})^*.$$

By the assumption that rank $[\Omega_1] = r$, we have $\Omega_1 \Omega_1^{\dagger} = \mathbf{I}$. Consequently,

(6.8)
$$A\Omega\Omega_1^{\dagger} = \begin{bmatrix} A_1 \\ A_2\Omega_2\Omega_1^{\dagger} \end{bmatrix} =: \begin{bmatrix} A_1 \\ F \end{bmatrix}.$$

We have introduced the abbreviation $\mathbf{F} = \mathbf{A}_2 \mathbf{\Omega}_1 \mathbf{\Omega}_1^{\dagger}$. A direct calculation involving (6.7) and (6.8) delivers an expression involving the parallel sum:

$$\begin{bmatrix} \boldsymbol{A}_1 & \\ & \boldsymbol{0} \end{bmatrix} (\mathbf{I} - \boldsymbol{Q}) \begin{bmatrix} \boldsymbol{A}_1 & \\ & \boldsymbol{0} \end{bmatrix} = \begin{bmatrix} \boldsymbol{A}_1^2 : (\boldsymbol{F}^* \boldsymbol{F}) & \\ & \boldsymbol{0} \end{bmatrix}.$$

By Lemma 6.4 parts (3) and (4), we obtain the bound

$$\left\| m{A}_1^2 : (m{F}^*m{F})
ight\|_{p/2} \le \left\| m{A}_1^2
ight\|_{p/2} : \left\| m{F}^*m{F}
ight\|_{p/2} = \|m{A}_1\|_p^2 : \|m{F}\|_p^2 \le \|m{F}\|_p^2$$

This statement leads to (6.2) and completes the proof.

The error bounds in Proposition 6.5 are relatively simple and explicit, and they ensure that RSVD gives a high-quality approximation when the quantity $\|\mathbf{A}_2\Omega_2\Omega_1^{\dagger}\|_p^2$ is small. To understand when this quantity is likely to be small, we need additional tools from random matrix theory, to be presented in the next section.

6.3. Calculations using random matrix theory. To complete the proof of our main result, we apply the following error bounds for Gaussian matrices, which are derived in Appendix A.1.

PROPOSITION 6.6 (Gaussian matrix products). Fix a matrix $\mathbf{S} \in \mathbb{R}^{(N-r)\times (N-r)}$ and consider independent Gaussian matrices $\mathbf{G} \in \mathbb{R}^{(N-r)\times k}$ and $\mathbf{H} \in \mathbb{R}^{r\times k}$, where $k \geq r$. Then, for any $u, t \geq 0$,

(6.9)
$$\mathbb{P}\left\{ \|\mathbf{SGH}^{\dagger}\|_{\mathrm{F}}^{2} > \frac{utr}{k-r+1} \|\mathbf{S}\|_{\mathrm{F}}^{2} \right\} \leq e^{-(u-2)/4} + \sqrt{\pi r} \left(\frac{t}{e}\right)^{-(k-r+1)/2}.$$

Additionally, if $k \ge r + 2$,

(6.10)
$$\mathbb{E} \| \mathbf{SGH}^{\dagger} \|_{F}^{2} = \frac{r}{k - r - 1} \| \mathbf{S} \|_{F}^{2}.$$

The expectation bound (6.10) was previously presented in [55, Thm. 10.5]. It follows from the well-known formula for the expectation of an inverse Wishart matrix [86, pg. 119]. The probability bound (6.9) improves on previous results [55, Thm. 10.7]. It is derived using a Lipschitz concentration inequality for Gaussian random fields, together with a new concentration inequality for the trace of an inverse Wishart matrix.

The random matrix theory allow us to complete the proof of our main results, Theorem 6.1 and Corollary 6.2, as follows.

Proof of Theorem 6.1 and Corollary 6.2. Without loss of generality, assume that $\mathbf{A} \in \mathbb{R}^{N \times N}$ is diagonal and psd, with nonincreasing diagonal entries. We partition the Gaussian test matrix $\mathbf{\Omega} = \begin{bmatrix} \mathbf{\Omega}_1 \\ \mathbf{\Omega}_2 \end{bmatrix}$, where $\mathbf{\Omega}_1$ is a $r \times k$ matrix and $\mathbf{\Omega}_2$ is a $(N-r) \times k$ matrix. The two submatrices $\mathbf{\Omega}_1$ and $\mathbf{\Omega}_2$ are independent Gaussian matrices, and $\mathbf{\Omega}_1$ almost surely has rank r.

RSVD produces an approximation $\hat{A} \in \mathbb{R}^{N \times n}$ that satisfies

$$\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|_p^2 = \|(\mathbf{I} - \boldsymbol{\Pi}_{\boldsymbol{A}\boldsymbol{\Omega}})\boldsymbol{A}\|_p^2 \leq \|(\mathbf{I} - \boldsymbol{\Pi}_{\boldsymbol{A}\boldsymbol{\Omega}\boldsymbol{\Omega}_1^\dagger})\boldsymbol{A}\|_p^2$$

because $A\Omega$ has a bigger range than $A\Omega\Omega_1^{\dagger}$; see Lemma 4.1. Next, Proposition 6.5 shows that, almost surely,

$$\|(\mathbf{I} - \mathbf{\Pi}_{\boldsymbol{A}\boldsymbol{\Omega}\boldsymbol{\Omega}_{1}^{\dagger}})\boldsymbol{A}\|_{p}^{2} \leq \|\boldsymbol{A}_{2}\|_{p}^{2} + \|\boldsymbol{A}_{2}\boldsymbol{\Omega}_{2}\boldsymbol{\Omega}_{1}^{\dagger}\|_{p}^{2} \leq \|\boldsymbol{A}_{2}\|_{p}^{2} + \|\boldsymbol{A}_{2}\boldsymbol{\Omega}_{2}\boldsymbol{\Omega}_{1}^{\dagger}\|_{\mathrm{F}}^{2}.$$

Since Ω_1 and Ω_2 are independent Gaussian matrices, the error bounds from Proposition 6.6 deliver the RSVD error bounds (RSVD1) and (RSVD2).

As for the corollary, NysSVD produces an approximation $\hat{\boldsymbol{A}} \in \mathbb{R}^{N \times N}$ that satisfies

$$\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|_p = \|\boldsymbol{A}^{1/2}(\mathbf{I} - \boldsymbol{\Pi}_{\boldsymbol{A}^{1/2}\boldsymbol{\Omega}})\boldsymbol{A}^{1/2}\|_p = \|(\mathbf{I} - \boldsymbol{\Pi}_{\boldsymbol{A}^{1/2}\boldsymbol{\Omega}})\boldsymbol{A}^{1/2}\|_{2p}^2.$$

We recognize $\|(\mathbf{I} - \mathbf{\Pi}_{A^{1/2}\Omega})A^{1/2}\|_{2p}^2$ as the squared error of the RSVD, applied to the matrix $A^{1/2}$. By invoking the RSVD error bounds for $\|(\mathbf{I} - \mathbf{\Pi}_{A^{1/2}\Omega})A^{1/2}\|_{2p}^2$, we confirm the NysSVD error bounds (NysSVD1) and (NysSVD2).

6.4. Additional expectation bounds. The analysis of RSVD using parallel sums of psd matrices leads to a family of expectation bounds with respect to various Schatten p-norms. We give a collection of these bounds in Theorem 6.7, with the proof appearing in Appendix A.2. The bounds underscore the potential for high errors when k-r is small.

Theorem 6.7 (RSVD expectation bounds). Fix a matrix $\mathbf{A} \in \mathbb{R}^{L \times N}$, fix a target rank $r \geq 1$, and a block size $k \geq r$. Then RSVD with a block of k Gaussian starting vectors generates a random approximation $\hat{\mathbf{A}} \in \mathbb{R}^{L \times N}$ that satisfies

$$\frac{\mathbb{E}\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|_{\mathrm{F}}^{2}}{\|\boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_{r}\|_{\mathrm{F}}^{2}} \leq \begin{cases} 1 + \frac{r}{k - r - 1}, & k \geq r + 2; \\ 1 + r \log\left(1 + \frac{\|\lfloor \boldsymbol{A} \rfloor_{r}\|_{\mathrm{F}}^{2}}{\|\boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_{r}\|_{\mathrm{F}}^{2}}\right), & k = r + 1; \\ 1 + r\left(\frac{\pi \|\lfloor \boldsymbol{A} \rfloor_{r}\|_{\mathrm{F}}^{2}}{2\|\boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_{r}\|_{\mathrm{F}}^{2}}\right)^{1/2}, & k = r. \end{cases}$$

Additionally, if the block size $k \geq r + 2$,

$$\mathbb{E}\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|^2 \le \left(1 + \frac{2r}{k - r - 1}\right) \left(\|\boldsymbol{A} - \lfloor \boldsymbol{A}\rfloor_r\|^2 + \frac{e^2}{k - r}\|\boldsymbol{A} - \lfloor \boldsymbol{A}\rfloor_r\|_F^2\right).$$

Last, if the block size $k \ge r + 4$,

$$\left(\mathbb{E}\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|_{4}^{4}\right)^{1/2} \leq \left(1 + \frac{r+1}{k-r-3}\right) \left(\|\boldsymbol{A} - \lfloor \boldsymbol{A}\rfloor_{r}\|_{4}^{2} + \frac{1}{\sqrt{k-r}}\|\boldsymbol{A} - \lfloor \boldsymbol{A}\rfloor_{r}\|_{F}^{2}\right);$$

$$\left(\mathbb{E}\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|_{4}^{4}\right)^{1/2} \leq \left(1 + \frac{2(r+1)}{k-r-3}\right) \left(\|\boldsymbol{A} - \lfloor \boldsymbol{A}\rfloor_{r}\|_{2}^{2} + \frac{\sqrt{3}\,\mathrm{e}^{2}}{k-r}\|\boldsymbol{A} - \lfloor \boldsymbol{A}\rfloor_{r}\|_{F}^{2}\right).$$

Once we have derived expectation bounds for RSVD, we obtain matching bounds for NysSVD due to the close relationship between the two algorithms:

COROLLARY 6.8 (NysSVD expectation bounds). Fix a psd matrix $\mathbf{A} \in \mathbb{R}^{N \times N}$ and a target rank $r \geq 1$. Then NysSVD with $k \geq r + 2$ Gaussian initialization vectors produces a random approximation $\hat{\mathbf{A}} \in \mathbb{R}^{N \times N}$ that satisfies

$$\frac{\mathbb{E}\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|_{*}}{\|\boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_{r}\|_{*}} \leq \begin{cases}
1 + \frac{r}{k - r - 1}, & k \geq r + 2; \\
1 + r \log\left(1 + \frac{\|\lfloor \boldsymbol{A} \rfloor_{r}\|_{*}}{\|\boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_{r}\|_{*}}\right), & k = r + 1; \\
1 + r\left(\frac{\pi \|\lfloor \boldsymbol{A} \rfloor_{r}\|_{*}}{2\|\boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_{r}\|_{*}}\right)^{1/2}, & k = r.
\end{cases}$$

Additionally, if the block size k > r + 2,

$$\mathbb{E}\|\boldsymbol{A} - \hat{\boldsymbol{A}}\| \le \left(1 + \frac{2r}{k - r - 1}\right) \left(\|\boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_r\| + \frac{e^2}{k - r}\|\boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_r\|_*\right).$$

Last, if the block size $k \ge r + 4$,

$$\begin{split} & \left(\mathbb{E} \| \boldsymbol{A} - \hat{\boldsymbol{A}} \|_{\mathrm{F}}^2 \right)^{1/2} \leq \left(1 + \frac{r+1}{k-r-3} \right) \left(\| \boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_r \|_{\mathrm{F}} + \frac{1}{\sqrt{k-r}} \| \boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_r \|_* \right); \\ & \left(\mathbb{E} \| \boldsymbol{A} - \hat{\boldsymbol{A}} \|^2 \right)^{1/2} \leq \left(1 + \frac{2(r+1)}{k-r-3} \right) \left(\| \boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_r \| + \frac{\sqrt{3}\mathrm{e}^2}{k-r} \| \boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_r \|_* \right). \end{split}$$

Proof. NysSVD produces an approximation $A(\Omega)$ satisfying

$$\|A - A\langle \Omega \rangle\|_p = \|A^{1/2}(\mathbf{I} - \mathbf{\Pi}_{A^{1/2}\Omega})A^{1/2}\|_p = \|(\mathbf{I} - \mathbf{\Pi}_{A^{1/2}\Omega})A^{1/2}\|_{2p}^2,$$

where $\Omega \in \mathbb{R}^{N \times k}$ is a random Gaussian matrix. We recognize $\|(\mathbf{I} - \mathbf{\Pi}_{A^{1/2}\Omega})A^{1/2}\|_{2p}^2$ as the square error of RSVD applied to the matrix $A^{1/2}$ and apply the error bounds given in Theorem 6.7.

The error bounds in Theorem 6.7 and Corollary 6.8 are useful for theoretical analyses. For example, the recent paper [39] used Theorem 6.7 and Corollary 6.8 to control the variance of several randomized trace estimators.

7. Analysis of Krylov algorithms. In this section, we analyze RBKI and NysBKI and provide a matching analysis of RSI and NysSI for comparison. We develop both *gapless* error bounds that do not require any distance between the singular values and *gapped* error bounds that grow increasingly strong with the size of singular value gaps.

The gapless error bounds are given in Theorem 7.1, and the proof appears in subsection 7.4. Instead of bounding the error ratio

$$\frac{\mathbb{E}\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|^2}{\sigma_{r+1}(\boldsymbol{A})^2},$$

which is ideally close to one, these bounds apply to the log-error ratio




Fig. 12. (Gapless vs. gapped bounds). Gapless (left) versus gapped (right) error bounds on the log error ratio $\log(\mathbb{E}\|\mathbf{B} - \hat{\mathbf{B}}\|^2/\sigma_{r+1}(\mathbf{B})^2)$ when approximating the matrix \mathbf{B} from subsection 5.1 with block size k = 100 and target rank r = 75.

$$\log\left(\frac{\mathbb{E}\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|^2}{\sigma_{r+1}(\boldsymbol{A})^2}\right),$$

which is ideally close to zero. We demonstrate that the log-error ratio decreases at a rate $\mathcal{O}(1/m)$ for RSI or NysSI. The ratio decreases at a faster rate $\mathcal{O}(1/m^2)$ for RBKI or NysBKI. In each case, m is the total number of multiplications with \boldsymbol{A} or \boldsymbol{A}^* . For illustration, Figure 12 evaluates these error bounds for the matrix \boldsymbol{B} with slow singular value decay that was defined in subsection 5.1.

THEOREM 7.1 (Gapless error bounds). Fix a matrix $\mathbf{A} \in \mathbb{R}^{L \times N}$ and a target rank $r \geq 1$ such that $\sigma_{r+1}(\mathbf{A}) > 0$. Then RSI with $k \geq r + 2$ Gaussian initialization vectors and m matrix multiplications generates a random approximation $\hat{\mathbf{A}} \in \mathbb{R}^{L \times N}$ that satisfies

$$(\mathtt{RSI}) \qquad \log \left(\frac{\mathbb{E} \|\boldsymbol{A} - \hat{\boldsymbol{A}}\|^2}{\sigma_{r+1}(\boldsymbol{A})^2} \right) \leq \frac{1}{m-1} \log \left(1 + \frac{r}{k-r-1} \sum_{i > r} \frac{\sigma_i(\boldsymbol{A})^2}{\sigma_{r+1}(\boldsymbol{A})^2} \right).$$

With the same initialization and the same number of multiplications, RBKI satisfies

$$(\text{RBKI}) \qquad \log \left(\frac{\mathbb{E} \|\boldsymbol{A} - \hat{\boldsymbol{A}}\|^2}{\sigma_{r+1}(\boldsymbol{A})^2} \right) \leq \frac{1}{4(m-2)^2} \left[\log \left(4 + \frac{4r}{k-r-1} \sum_{i>r} \frac{\sigma_i(\boldsymbol{A})^2}{\sigma_{r+1}(\boldsymbol{A})^2} \right) \right]^2.$$

If $\mathbf{A} \in \mathbb{R}^{N \times N}$ is a psd matrix, NysSI satisfies

$$(\mathtt{NysSI}) \qquad \quad \log \biggl(\frac{\mathbb{E} \|\boldsymbol{A} - \hat{\boldsymbol{A}}\|^2}{\sigma_{r+1}(\boldsymbol{A})^2} \biggr) \leq \frac{1}{m - \frac{1}{2}} \log \biggl(1 + \frac{r}{k - r - 1} \sum_{i > r} \frac{\sigma_i(\boldsymbol{A})^2}{\sigma_{r+1}(\boldsymbol{A})^2} \biggr),$$

and NysBKI satisfies

$$(\texttt{NysBKI}) \quad \log \left(\frac{\mathbb{E} \|\boldsymbol{A} - \hat{\boldsymbol{A}}\|^2}{\sigma_{r+1}(\boldsymbol{A})^2} \right) \leq \frac{1}{8(m-\frac{3}{2})^2} \left[\log \left(4 + \frac{4r}{k-r-1} \sum_{i > r} \frac{\sigma_i(\boldsymbol{A})^2}{\sigma_{r+1}(\boldsymbol{A})^2} \right) \right]^2.$$

The gapless error bounds lead to qualitative insights. For example, RBKI and NysBKI converge at a fundamentally faster rate than the other algorithms. However, these bounds only describe the worst-case performance, which applies when the singular values are so slowly decaying that no real gaps occur. In more realistic applications, including all the test problems in section 5, we find small gaps appearing between the singular values. Therefore, we develop a set of gapped error bounds in Theorem 7.2 that guarantee faster, exponential convergence rates. The proof appears in subsection 7.3.

THEOREM 7.2 (Gapped error bounds). Fix a matrix $\mathbf{A} \in \mathbb{R}^{L \times N}$, a Schatten p-norm with $2 \leq p \leq \infty$, and two singular values $\sigma_r(\mathbf{A})$ and $\sigma_s(\mathbf{A})$ with r < s. Let $\lfloor \mathbf{A} \rfloor_r$ and $\lfloor \mathbf{A} \rfloor_{s-1}$ denote optimal rank-r and rank-(s-1) approximations of \mathbf{A} , and define the singular value gap

$$\gamma = \frac{\sigma_r(\mathbf{A}) - \sigma_s(\mathbf{A})}{\sigma_r(\mathbf{A}) + \sigma_s(\mathbf{A})} \in [0, 1].$$

Then, RSI with $k \geq s+1$ Gaussian initialization vectors and m matrix multiplications generates a random approximation $\hat{A} \in \mathbb{R}^{L \times N}$ that satisfies

$$(\mathtt{RSI}) \qquad \qquad \mathbb{E} \| \boldsymbol{A} - \hat{\boldsymbol{A}} \|_p^2 \leq \| \boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_r \|_p^2 + \mathrm{e}^{-4(m-2)\gamma} \cdot \frac{s-1}{k-s} \| \boldsymbol{A} - [\boldsymbol{A}]_{s-1} \|_{\mathrm{F}}^2.$$

With the same initialization and the same number of multiplications, RBKI satisfies

$$(\text{RBKI}) \qquad \mathbb{E} \| \boldsymbol{A} - \hat{\boldsymbol{A}} \|_p^2 \leq \| \boldsymbol{A} - \lfloor \boldsymbol{A} \rfloor_r \|_p^2 + 4 \, \mathrm{e}^{-4(m-2)\sqrt{\gamma}} \cdot \frac{s-1}{k-s} \| \boldsymbol{A} - [\boldsymbol{A}]_{s-1} \|_{\mathrm{F}}^2.$$

If $\mathbf{A} \in \mathbb{R}^{N \times N}$ is a psd matrix and $1 \le p \le \infty$, NysSI satisfies

$$({\tt NysSI}) \qquad \quad \mathbb{E} \| {\bm A} - \hat{{\bm A}} \|_p^2 \leq \| {\bm A} - \lfloor {\bm A} \rfloor_r \|_p^2 + \mathrm{e}^{-4(m-3/2)\gamma} \cdot \frac{s-1}{k-s} \| {\bm A} - [{\bm A}]_{s-1} \|_{\mathrm{F}}^2.$$

and NysBKI satisfies

$$(\mathtt{NysBKI}) \quad \mathbb{E} \| \pmb{A} - \hat{\pmb{A}} \|_p^2 \leq \| \pmb{A} - \lfloor \pmb{A} \rfloor_r \|_p^2 + 4 \, \mathrm{e}^{-4(m-3/2)\sqrt{2\gamma}} \cdot \frac{s-1}{k-s} \| \pmb{A} - [\pmb{A}]_{s-1} \|_{\mathrm{F}}^2.$$

The gapped error bounds show how Krylov methods capitalize upon small singular value gaps to achieve accelerated convergence. Given a small gap $\gamma \ll 1$, we can ensure an error bound

$$\mathbb{E}\|\boldsymbol{A} - \hat{\boldsymbol{A}}\|_{\mathrm{F}}^{2} \leq (1 + \varepsilon) \cdot \|\boldsymbol{A} - |\boldsymbol{A}|_{r}\|_{\mathrm{F}}^{2},$$

if we set $m = \mathcal{O}(\log(1/\varepsilon)/\gamma)$ in RSI or NysSI or $m = \mathcal{O}(\log(1/\varepsilon)/\sqrt{\gamma})$ in RBKI or NysBKI. The change from a $1/\gamma$ -dependence to a $1/\sqrt{\gamma}$ -dependence leads to an accelerated convergence rate in many applications. See Figure 12 for an illustration.

Theorems 7.1 and 7.2 improve upon existing results for RSI [55, 51, 13], RBKI [73, 109, 34, 99, 6], NysSI, and NysBKI. Musco and Musco [73] previously established the $\mathcal{O}(m^{-2})$ gapless convergence rate for RBKI, and we improve this result by obtaining explicit constants. Our gapped error bounds for RBKI and RSI feature sharper constants than previous results [51, 13, 34, 99] and extend to all Schatten p-norms for $2 \le p \le \infty$. The bounds for NysSI and NysBKI are new.

Because of the sharp, explicit nature of our estimates, we are able to make quantitative predictions: the gapless (Theorem 7.1) and gapped (Theorem 7.2) bounds predict that NysSI outperforms RSI by one-half a multiplication while NysBKI outperforms RBKI by a factor of $\sqrt{2}$ multiplications. These predictions are in close agreement with numerical experiments (compare with Figures 4 and 5).

We acknowledge one main limitation of our error bounds in Theorems 7.1 and 7.2, which is the requirement that the target rank r does not exceed k-2. We can extend our approach to prove probability bounds for r=k-1 and r=k by adapting formula (6.9) from Proposition 6.6, but we are fundamentally limited by the restriction $r \leq k$. Indeed, as pointed out by Meyer, Musco, and Musco [72], it is impossible to establish any gapless error bounds for RBKI (or NysBKI) in the case r > k, because the Krylov algorithm collapses to give a rank-k approximation when applied to the identity matrix A = I in exact arithmetic. Nonetheless, it is possible to establish gapped error bounds for r > k, because RBKI generally returns an approximation with rank $k \lfloor m/2 \rfloor$ and NysBKI generally returns an approximation with an even bigger rank km. The paper [72] establishes a qualitative convergence result for RBKI that depends on the minimum singular value gap $\min_{1 \leq i \leq r-k} (\sigma_i(A) - \sigma_{i+k}(A))/\sigma_i(A)$ and grows increasingly weak as this gap approaches zero (also see earlier work of [114]). Although the result is more complicated than Theorems 7.1 and 7.2, it provides additional evidence of the computational advantages of Krylov methods.

The rest of this section contains an overview of the technical approach (subsection 7.1) and background material on Chebyshev polynomials (subsection 7.2), followed by a derivation of the the gapped error bounds (subsection 7.3) and the gapless error bounds (subsection 7.4).




Fig. 13. (Chebyshev polynomials are almost convex). The Chebyshev polynomial $T_5(x)$ admits supporting lines on the range $x \ge 1$.

7.1. Overview of technical approach. To prove the gapped and gapless error bounds, our main approach is to apply a polynomial filter f(A) that increases the top singular values and decreases the bottom singular values. As we choose a filter, we need to ensure that $f(A)\Omega$ lies inside the approximation space. Therefore, we use power function filters to analyze subspace iteration methods, and we use Chebyshev polynomial filters to analyze Krylov methods. The enhanced ability of Chebyshev polynomials to separate the top singular values from the bottom singular values is why we obtain such powerful Krylov bounds. Chebyshev polynomials have long been used in this context; for example, see Kuczyński and Woźniakowski [61].

Our filtering analysis relies on the fact that

(7.1)
$$\|(\mathbf{I} - \mathbf{\Pi}_{f(\mathbf{A})\Omega})f(\mathbf{A})\|,$$

is the error of RSVD applied to a matrix $f(\mathbf{A})$, and we know how to bound the error of RSVD (Theorem 6.1). The main difficulty is relating (7.1) to the quantity

$$\|(\mathbf{I} - \mathbf{\Pi}_{f(\boldsymbol{A})\Omega})\boldsymbol{A}\|,$$

the error actually attained by the algorithms.

We develop two lemmas that relate $\|(\mathbf{I} - \mathbf{\Pi}_{f(\mathbf{A})\Omega})f(\mathbf{A})\|$ and $\|(\mathbf{I} - \mathbf{\Pi}_{f(\mathbf{A})\Omega})\mathbf{A}\|$. First, we establish Lemma 7.4 based on matrix submultiplicativity, which allows us to prove the gapped bounds. Next, we establish Lemma 7.5 based on convexity, which allows us to prove the gapless bounds. For RSI, the convexity argument is already visible in [55, Prop. 8.6]. For RBKI, the crucial new observation is that Chebyshev polynomials are not globally convex, yet they do admit supporting lines on the range $x \geq 1$. The supporting lines are all that we need to extend the convexity-based arguments. See Figure 13 for an illustration.

The gapless and gapped error bounds apply to the untruncated approximation \hat{A} , which is the approximation returned by our pseudocode and recommended for most practical applications. However, similar bounds extend to the approximation $\lfloor \hat{A} \rfloor_r$, which comes from applying an r-truncated singular value decomposition to \hat{A} . Owing to the reverse Eckart–Young inequality of [51, Thm. 3.4], the gapped error bounds (Theorem 7.2) remain valid even when we replace \hat{A} with $\lfloor \hat{A} \rfloor_r$. Additionally, we can prove alternative gapless bounds by pursuing Musco and Musco's observation [73] that either there is a singular value gap and the gapped error bounds apply or else there is no gap and the approximation is close to optimal. We omit a detailed treatment.

7.2. Chebyshev polynomials. The qth Chebyshev polynomial T_q of the first kind is a polynomial of degree q. This polynomial shares some properties with the qth power function $x \mapsto x^q$. The values of both polynomials lie inside [-1,1] for $0 \le x \le 1$, and the polynomials exhibit a sharp rate of increase for $x \ge 1$. Lemma 7.3 provides more fine-tuned estimates that will be used in the analysis.

LEMMA 7.3 (Chebyshev polynomials). For $q \in \{0, 1, 2, ...\}$ and $x \geq 1$, define the Chebyshev polynomial T_q of the first kind by

(7.2)
$$T_q(x) = \begin{cases} \cos(q \arccos x), & 0 \le x \le 1, \\ \cosh(q \operatorname{arcosh} x), & x \ge 1. \end{cases}$$

Then, the following properties hold:

- 1. T_q is a polynomial of degree q. If q is odd, then T_q is odd. If q is even, then T_q is even.
- 2. $T_q(x)$ is bounded above by

$$|T_q(x)| \le 1, \qquad 0 \le x \le 1.$$

3. $T_q(x)$ is increasing on the interval $x \ge 1$, and it is bounded below as

$$T_q\left(\frac{1+r}{1-r}\right) \ge \frac{1}{2}e^{2q\sqrt{r}}, \qquad 0 \le r < 1.$$

In contrast, the quantity x^q exhibits a slower rate of increase:

$$\left(\frac{1+r}{1-r}\right)^q \ge e^{2qr}, \qquad 0 \le r < 1.$$

4. The functional inverse of the Chebyshev polynomial satisfies

$$T_q^{-1}(x) \le \exp\left(\frac{1}{2}\left[\frac{\log(2x)}{q}\right]^2\right), \qquad x \ge 1.$$

5. The function $\phi(x) = xT_q(x^{1/2})^2$ has a supporting line at every point $(x, \phi(x))$ with $x \ge 1$, as does the function $\phi(x) = xT_q(x^{1/4})^2$.

Proof. Parts 1 and 2 are standard facts presented in [70, Ch. 2]. Parts 3–5 are technical results, proved in Appendix B.

7.3. Gapped error bounds. To establish the gapped error bounds, we will need to apply a polynomial ϕ that enhances the singular value gap. To that end, we establish the following filtering lemma.

LEMMA 7.4 (Enhancing the gap). Choose a diagonal, psd matrix with nonincreasing entries: $\mathbf{A} = \operatorname{diag}(a_{11}, a_{22}, \dots, a_{NN})$. Fix two indices $1 \leq r < s \leq N$ and a function $\phi(x)$ that is positive for $x \geq a_{rr}$, and partition the matrix \mathbf{A} as

$$oldsymbol{A} = egin{bmatrix} oldsymbol{A}_1 & & & \ & oldsymbol{A}_2 & & \ & oldsymbol{A}_3 \end{bmatrix},$$

where A_1 , A_2 , and A_3 are square matrices with dimensions r, s-1-r, and N-s+1.

If $\Omega \in \mathbb{R}^{N \times k}$ is a Gaussian matrix with block size $k \geq s+1$, then

$$\mathbb{E}\|(\mathbf{I} - \mathbf{\Pi}_{\boldsymbol{A}\phi(\boldsymbol{A})\boldsymbol{\Omega}})\boldsymbol{A}\|_p^2 \leq \left\|\begin{bmatrix}\mathbf{0} & & \\ & \boldsymbol{A}_2 & \\ & & \boldsymbol{A}_3\end{bmatrix}\right\|_p^2 + \frac{s-1}{k-s} \cdot \frac{\|\boldsymbol{A}_3\phi(\boldsymbol{A}_3)\|_p^2}{\phi(a_{rr})^2}.$$

for any Schatten p-norm with $2 \le p \le \infty$.

Proof. We partition the matrix Ω as $\Omega = \begin{bmatrix} \Omega_{\alpha} \\ \Omega_{\beta} \end{bmatrix}$, where Ω_{α} is $(s-1) \times k$ and Ω_{β} is $(N-s+1) \times k$. Then we set $Q = \Pi_{A\phi(A)\Omega\Omega_{\alpha}^{\dagger}}$ and apply the coarse upper bound

$$\|(\mathbf{I} - \mathbf{Q})\mathbf{A}\|_p^2 \le \left\| \begin{bmatrix} \mathbf{0} & & \\ & \mathbf{A}_2 & \\ & & \mathbf{A}_3 \end{bmatrix} \right\|_p^2 + \left\| (\mathbf{I} - \mathbf{Q}) \begin{bmatrix} \mathbf{A}_1 & & \\ & \mathbf{0} & \\ & & \mathbf{0} \end{bmatrix} \right\|_p^2$$

We can bound the second term using

(7.3)
$$\left\| (\mathbf{I} - \mathbf{Q}) \begin{bmatrix} \mathbf{A}_1 \phi(\mathbf{A}_1) & & \\ & \mathbf{A}_2 \phi(\mathbf{A}_2) & \\ & \mathbf{0} \end{bmatrix} \begin{bmatrix} \phi(\mathbf{A}_1)^{-1} & & \\ & \mathbf{0} & \\ & & \mathbf{0} \end{bmatrix} \right\|_p^2$$

$$(7.4) \qquad \leq \frac{1}{\phi(a_{rr})^2} \left\| (\mathbf{I} - \mathbf{Q}) \begin{bmatrix} \mathbf{A}_1 \phi(\mathbf{A}_1) & & \\ & \mathbf{A}_2 \phi(\mathbf{A}_2) & \\ & & \mathbf{0} \end{bmatrix} \right\|^2$$

(7.5)
$$\leq \frac{1}{\phi(a_{rr})^2} \| \mathbf{A}_3 \phi(\mathbf{A}_3) \mathbf{\Omega}_{\beta} \mathbf{\Omega}_{\alpha}^{\dagger} \|_p^2.$$

The inequality (7.4) depends on the fact that the operator norm of the right-most matrix is $1/\phi(a_{rr})$, while inequality (7.5) follows from Proposition 6.5. Last, we take expectations and apply the exact calculations for Gaussian matrices from Proposition 6.6 to show

$$\mathbb{E}\|\boldsymbol{A}_{3}\phi(\boldsymbol{A}_{3})\boldsymbol{\Omega}_{\beta}\boldsymbol{\Omega}_{\alpha}^{\dagger}\|_{p}^{2} \leq \mathbb{E}\|\boldsymbol{A}_{3}\phi(\boldsymbol{A}_{3})\boldsymbol{\Omega}_{\beta}\boldsymbol{\Omega}_{\alpha}^{\dagger}\|_{F}^{2} = \frac{s-1}{k-s}\mathbb{E}\|\boldsymbol{A}_{3}\phi(\boldsymbol{A}_{3})\|_{F}^{2},$$

which completes the proof.

We apply Lemma 7.4 to establish the main result, Theorem 7.2.

Proof of Theorem 7.2. We assume without loss of generality that $\mathbf{A} \in \mathbb{R}^{N \times N}$ is diagonal and psd, with nonincreasing diagonal entries (Lemma 6.3). We then apply Lemma 7.4 with $\phi(x) = x^{m-2}$ to bound the RSI error as follows:

$$\mathbb{E}\|(\mathbf{I} - \mathbf{\Pi}_{\boldsymbol{A}^{m-1}\boldsymbol{\Omega}})\boldsymbol{A}\|_p^2 \leq \|\boldsymbol{A} - \lfloor \boldsymbol{A}\rfloor_r\|_p^2 + \frac{s-1}{k-s} \sum_{i=s}^N \frac{\sigma_i(\boldsymbol{A})^{2(m-1)}}{\sigma_r(\boldsymbol{A})^{2(m-2)}}.$$

Lemma 7.3 part 3 gives the numerical identity

$$\left(\frac{\sigma_s(\mathbf{A})}{\sigma_r(\mathbf{A})}\right)^{2(m-2)} = \left(\frac{1-\gamma}{1+\gamma}\right)^{2(m-2)} \le e^{-4(m-2)\gamma},$$

which confirms the RSI error bound. The NysSI error bound is proved similarly. Observe that

$$\begin{aligned} \|\boldsymbol{A} - \boldsymbol{A} \langle \boldsymbol{A}^{m-1} \boldsymbol{\Omega} \rangle \|_p &= \|\boldsymbol{A}^{1/2} (\mathbf{I} - \boldsymbol{\Pi}_{\boldsymbol{A}^{m-1/2} \boldsymbol{\Omega}}) \boldsymbol{A}^{1/2} \|_p = \| (\mathbf{I} - \boldsymbol{\Pi}_{\boldsymbol{A}^{m-1/2} \boldsymbol{\Omega}}) \boldsymbol{A}^{1/2} \|_{2p}^2 \\ &= \| (\mathbf{I} - \boldsymbol{\Pi}_{\boldsymbol{A}^{m-1/2} \boldsymbol{\Omega}}) \boldsymbol{A} (\mathbf{I} - \boldsymbol{\Pi}_{\boldsymbol{A}^{m-1/2} \boldsymbol{\Omega}}) \|_p \leq \| (\mathbf{I} - \boldsymbol{\Pi}_{\boldsymbol{A}^{m-1/2} \boldsymbol{\Omega}}) \boldsymbol{A} \|_p. \end{aligned}$$

We bound $\mathbb{E}\|(\mathbf{I} - \mathbf{\Pi}_{\mathbf{A}^{m-1/2}\mathbf{\Omega}})\mathbf{A}\|_p^2$ by applying Lemma 7.4 with $\phi(x) = x^{m-3/2}$. To control the RBKI error, we apply Lemma 7.4 with $\phi(x) = T_{m-2}(x/\sigma_s(\mathbf{A}))$, which gives

$$\mathbb{E}\|\boldsymbol{A} - \boldsymbol{\Pi}_{\boldsymbol{A}\phi(\boldsymbol{A})\boldsymbol{\Omega}}\boldsymbol{A}\|_p^2 \leq \|\boldsymbol{A} - \lfloor\boldsymbol{A}\rfloor_r\|_p^2 + \frac{s-1}{k-s}\sum_{i=s}^N \sigma_i(\boldsymbol{A})^2 \left(\frac{\phi(\sigma_i(\boldsymbol{A}))}{\phi(\sigma_r(\boldsymbol{A}))}\right)^2.$$

Then we use the properties of Chebyshev polynomials (Lemma 7.3 parts (2) and (3)) to check that $|\phi(\sigma_i(\mathbf{A}))| \leq 1$ for i = s, ..., N and

$$\phi(\sigma_r(\mathbf{A})) = T_{m-2}\left(\frac{\sigma_r(\mathbf{A})}{\sigma_s(\mathbf{A})}\right) = T_{m-2}\left(\frac{1+\gamma}{1-\gamma}\right) \ge \frac{1}{2}e^{2(m-2)\sqrt{\gamma}}.$$

Similarly, to bound the NysBKI error, we define $\phi(x) = T_{2m-3}(\sqrt{x/\sigma_s(A)})$ so that $\|A - \hat{A}\|_p \le \|A - \Pi_{A\phi(A)\Omega}A\|_p$. We apply Lemma 7.4, which gives

$$\mathbb{E}\|\boldsymbol{A} - \boldsymbol{\Pi}_{\boldsymbol{A}\phi(\boldsymbol{A})\boldsymbol{\Omega}}\boldsymbol{A}\|_p^2 \leq \|\boldsymbol{A} - \lfloor\boldsymbol{A}\rfloor_r\|_p^2 + \frac{s-1}{k-s}\sum_{i=s}^N \sigma_i(\boldsymbol{A})^2 \left(\frac{\phi(\sigma_i(\boldsymbol{A}))}{\phi(\sigma_r(\boldsymbol{A}))}\right)^2.$$

We bound $|\phi(\sigma_i(\mathbf{A}))| \leq 1$ for $i = s, \dots, N$ and

$$\phi(\sigma_r(\mathbf{A})) = T_{2m-3}\left(\sqrt{\frac{1+\gamma}{1-\gamma}}\right) \ge T_{2m-3}\left(\frac{1+\gamma/2}{1-\gamma/2}\right) \ge \frac{1}{2}e^{2(m-3/2)\sqrt{2\gamma}},$$

where we have use the numerical identity

$$\sqrt{\frac{1+\gamma}{1-\gamma}} \ge \frac{1+\gamma/2}{1-\gamma/2}, \quad \text{for } \gamma \ge 0.$$

This completes the proof.

7.4. Gapless error bounds. To prove the gapless error bounds, we will need the following version of Jensen's inequality. Compare this result with [55, Prop. 8.6].

LEMMA 7.5 (Jensen's inequality with "almost" convex functions). Consider a diagonal, psd matrix $\mathbf{A} \in \mathbb{R}^{N \times N}$, a random rank-r orthogonal projection $\mathbf{Q} \in \mathbb{R}^{N \times N}$, and a function $f:[0,\infty) \to \mathbb{R}$ that has a supporting line at every point (x,f(x)) for $x \geq \sigma_{r+1}(\mathbf{A})^2$. Then

(7.6)
$$f(\mathbb{E}||(\mathbf{I} - \mathbf{Q})\mathbf{A}||^2) \le \mathbb{E}||(\mathbf{I} - \mathbf{Q})f(\mathbf{A}^2)(\mathbf{I} - \mathbf{Q})||.$$

Proof. We will repeatedly use the fact that QA is a rank-r approximation of A and hence $||A - QA|| \ge \sigma_{r+1}(A)$ by Weyl's inequality [57, Thm. 4.3.1]. First, we set $x_0 = \mathbb{E}||A - QA||^2 \ge \sigma_{r+1}(A)^2$ and use the supporting line property to argue

$$f(x_0) = \mathbb{E}[f(x_0) + f'(x_0)(\|\mathbf{A} - \mathbf{Q}\mathbf{A}\|^2 - x_0)] \le \mathbb{E}f(\|\mathbf{A} - \mathbf{Q}\mathbf{A}\|^2)$$

Next, we define the random vector v to be a dominant eigenvector of $(\mathbf{I} - \mathbf{Q})A^2(\mathbf{I} - \mathbf{Q})$, lying in the range of $\mathbf{I} - \mathbf{Q}$ and normalized so that ||v|| = 1. We set $X = ||(\mathbf{I} - \mathbf{Q})A||^2$ and observe that

(7.7)
$$X = v^*(\mathbf{I} - \mathbf{Q})A^2(\mathbf{I} - \mathbf{Q})v^* = v^*A^2v^* = \sum_{i=1}^N a_{ii}^2 v_i^2,$$

where a_{ii} denotes the *i*th diagonal entry of **A** (recall that **A** is a diagonal matrix) and v_i is the ith entry of v. Last, we use (7.7) and the supporting line property to argue

$$\begin{split} f(X) &= \sum\nolimits_{i=1}^N v_i^2 \big[f(X) + f'(X) (a_{ii}^2 - X) \big] \\ &\leq \sum\nolimits_{i=1}^N v_i^2 f(a_{ii}^2) \\ &= \boldsymbol{v}^* (\mathbf{I} - \boldsymbol{Q}) f(\boldsymbol{A}^2) (\mathbf{I} - \boldsymbol{Q}) \boldsymbol{v} \\ &\leq \| (\mathbf{I} - \boldsymbol{Q}) f(\boldsymbol{A}^2) (\mathbf{I} - \boldsymbol{Q}) \|, \end{split}$$

thus verifying the stated inequality (7.6).

We use Lemma 7.5 to prove the main result, Theorem 7.1.

Proof of Theorem 7.1. We assume that $\mathbf{A} \in \mathbb{R}^{N \times N}$ is diagonal and psd, with nonincreasing diagonal entries (Lemma 6.3). By replacing \mathbf{A} with $\mathbf{A}/\sigma_{r+1}(\mathbf{A})$ if necessary, we also assume that $\sigma_{r+1}(A)=1$. Last, we partition the test matrix $\mathbf{\Omega}=\begin{bmatrix} \mathbf{\Omega}_1 \\ \mathbf{\Omega}_2 \end{bmatrix}$ into a $r \times k$ matrix $\mathbf{\Omega}_1$ and a $(N-r) \times k$ matrix $\mathbf{\Omega}_2$.

To analyze RSI, we introduce the orthogonal projector $\mathbf{Q}=\mathbf{\Pi}_{\mathbf{A}^{m-1}\mathbf{\Omega}\mathbf{\Omega}_1^{\dagger}}$ and apply

Lemma 7.5 with the convex function $f(x) = x^{m-1}$ to verify

$$\mathbb{E}\|(\mathbf{I} - \mathbf{Q})\mathbf{A}\|^{2(m-1)} \le \mathbb{E}\|(\mathbf{I} - \mathbf{Q})\mathbf{A}^{m-1}\|^{2}$$

We identify $\mathbb{E}\|(\mathbf{I}-\boldsymbol{Q})\boldsymbol{A}^{m-1}\|^2$ as the mean squared error of RSVD applied to the matrix A^{m-1} with a test matrix $\Omega\Omega_1^{\dagger}$, and we mimic the proof of Theorem 6.1 to show that

$$\mathbb{E}\|(\mathbf{I} - \mathbf{Q})\mathbf{A}^{m-1}\|^{2} \le 1 + \frac{r}{k - r - 1} \sum_{i = r+1}^{N} \sigma_{i}(\mathbf{A})^{2(m-1)}.$$

We take logarithms and divide through by m-1 to obtain

$$\log(\mathbb{E}||(\mathbf{I} - \mathbf{Q})\mathbf{A}||^2) \le \frac{1}{m-1}\log\left(1 + \frac{r}{k-r-1}\sum_{i=r+1}^{N}\sigma_i(\mathbf{A})^{2(m-1)}\right),$$

which is a stronger version of the error bound for RSI.

To analyze RBKI, we define $Q = \Pi_{AT_{m-2}(A)\Omega\Omega_1^{\dagger}}$. Then we apply Lemma 7.3 part (5) to identify the "almost" convex function $f(x) = x [T_{m-2}(x^{1/2})]^2$, and we invoke Lemma 7.5 to obtain

$$\left[T_{m-2}\left(\left(\mathbb{E}\|(\mathbf{I}-\boldsymbol{Q})\boldsymbol{A}\|^{2}\right)^{1/2}\right)\right]^{2} \leq f(\mathbb{E}\|(\mathbf{I}-\boldsymbol{Q})\boldsymbol{A}\|^{2}) \leq \mathbb{E}\|(\mathbf{I}-\boldsymbol{Q})\boldsymbol{A}T_{m-2}(\boldsymbol{A})\|^{2}.$$

We recognize $\mathbb{E}\|(\mathbf{I}-\boldsymbol{Q})\boldsymbol{A}T_{m-2}(\boldsymbol{A})\|^2$ as the mean-squared error of RSVD applied to the matrix $AT_{m-2}(A)$. Hence, by mimicking the proof of Theorem 6.1, we obtain

$$\mathbb{E}\|(\mathbf{I} - \mathbf{Q})\mathbf{A}T_{m-2}(\mathbf{A})\|^2 \le 1 + \frac{r}{k-r-1}\sum_{i=r+1}^{N} \sigma_i(\mathbf{A})^2.$$

Last, we take square roots, apply the inverse Chebyshev polynomial T_{m-2}^{-1} , take logarithms, and multiply through by 2 to obtain

$$\begin{split} \log \left(\mathbb{E} \| (\mathbf{I} - \boldsymbol{Q}) \boldsymbol{A} \|^2 \right) &\leq 2 \log \left(T_{m-2}^{-1} \left(\sqrt{1 + \frac{r}{k - r - 1} \sum_{i = r + 1}^{N} \sigma_i(\boldsymbol{A})^2} \right) \right) \\ &\leq \frac{1}{4(m - 2)^2} \left[\log \left(4 + \frac{4r}{k - r - 1} \sum_{i = r + 1}^{N} \sigma_i(\boldsymbol{A})^2 \right) \right]^2, \end{split}$$

which confirms the error bound for RBKI. The last line uses the bound for T_{m-2}^{-1} which was stated in Lemma 7.3 part 4.

We confirm the error bounds for NysSI and NysBKI in a similar fashion. For NysSI, we define the orthogonal projector $Q = \Pi_{A^{m-1/2}\Omega\Omega^{\dagger}}$ and calculate

$$egin{aligned} \|oldsymbol{A} - \hat{oldsymbol{A}}\| & = \|oldsymbol{A}^{1/2} (\mathbf{I} - oldsymbol{Q}) oldsymbol{A}^{1/2} \| \ & = \|(\mathbf{I} - oldsymbol{Q}) oldsymbol{A}^{1/2}\|^2 = \|(\mathbf{I} - oldsymbol{Q}) oldsymbol{A} (\mathbf{I} - oldsymbol{Q}) \| \leq \|(\mathbf{I} - oldsymbol{Q}) oldsymbol{A}\|. \end{aligned}$$

By applying Lemma 7.5 with $f(x) = x^{m-1/2}$, we obtain

$$\mathbb{E}\|(\mathbf{I} - \mathbf{Q})\mathbf{A}\|^{2(m-1/2)} \le \mathbb{E}\|(\mathbf{I} - \mathbf{Q})\mathbf{A}^{m-1/2}\|^2$$

which leads to an error bound for NysSI.

Last, for NysBKI, we define the orthogonal projector $Q = \Pi_{AT_{2m-1}(A^{1/2})\Omega\Omega_1^{\dagger}}$ so that $||A - \hat{A}|| \le ||(\mathbf{I} - Q)A||$. By applying Lemma 7.5 with $f(x) = x [T_{2m-1}(x^{1/4})]^2$, we obtain

$$\left[T_{2m-1}\left(\left(\mathbb{E}\|(\mathbf{I}-\boldsymbol{Q})\boldsymbol{A}\|^{2}\right)^{1/4}\right)\right]^{2} \leq \mathbb{E}\|(\mathbf{I}-\boldsymbol{Q})\boldsymbol{A}T_{2m-1}(\boldsymbol{A}^{1/2})\|^{2}.$$

which leads to an error bound for Nysbki and completes the proof of Theorem 7.1.

8. Conclusion. In this work, we have described randomized low-rank approximation algorithms and provided user recommendations regarding which algorithms are the most efficient. We have focused on computations involving high-dimensional matrices, in which matrix multiplications are the main computational bottleneck. We have established simple, explicit bounds which allow for precise descriptions of the differences between algorithms. Our results demonstrate that RSVD and NysSVD are fast and accurate when the singular values of the target matrix decay quickly. However, in settings of slow singular value decay, RBKI and NysBKI are the available algorithms with the greatest speed and robustness. We have presented numerical tests demonstrating the utility of these Krylov methods for principal component analysis and kernel spectral clustering.

The wide adoption of RBKI and NysBKI will require changes in software, since RSI is currently the default randomized low-rank matrix approximation algorithm in Matlab [71] and sci-kit learn [84]. Yet, RBKI and NysBKI are of great benefit to computational scientists who have found RSI to be expensive while resulting in large random errors [22, 62, 113, 14, 18, 64]. RBKI and NysBKI are more accurate and scalable algorithms. To support the broader use of these Krylov methods, we have provided simple and stable pseudocode, which cuts down on the cost of RBKI by roughly 33% to 50%, and we have provided the first pseudocode for NysBKI, which is faster than RBKI by a factor of $\sqrt{2}$ multiplications.

Appendix A. Random matrix theory. In this section, we bound the moments (Lemma A.1) and inverse moments (Lemmas A.2 and A.3) of Gaussian random matrices. These results are of independent interest, since they are the sharpest available expectation bounds and concentration inequalities of their type, and they are helpful for analyzing randomized matrix computations. We use these results to prove Proposition 6.6 in Appendix A.1 and Theorem 6.7 in Appendix A.2.

Lemma A.1 (Moment bounds). Consider fixed matrices $S \in \mathbb{R}^{L \times N}$ and $T \in \mathbb{R}^{P \times Q}$ and a Gaussian matrix $G \in \mathbb{R}^{N \times P}$. Then, SGT satisfies the equalities

$$\begin{split} \mathbb{E} \| \boldsymbol{S} \boldsymbol{G} \boldsymbol{T} \|_{\mathrm{F}}^2 &= \| \boldsymbol{S} \|_{\mathrm{F}}^2 \| \boldsymbol{T} \|_{\mathrm{F}}^2, \\ \mathbb{E} \| \boldsymbol{S} \boldsymbol{G} \boldsymbol{T} \|_{4}^4 &= \| \boldsymbol{S} \|_{4}^4 \| \boldsymbol{T} \|_{\mathrm{F}}^4 + \| \boldsymbol{T} \|_{4}^4 \| \boldsymbol{S} \|_{\mathrm{F}}^4 + \| \boldsymbol{S} \|_{4}^4 \| \boldsymbol{T} \|_{4}^4, \end{split}$$

as well as the upper bounds

$$\begin{split} & (\mathbb{E}\|\boldsymbol{S}\boldsymbol{G}\boldsymbol{T}\|^2)^{1/2} \leq \|\boldsymbol{S}\|\|\boldsymbol{T}\|_{\mathrm{F}} + \|\boldsymbol{T}\|\|\boldsymbol{S}\|_{\mathrm{F}}, \\ & (\mathbb{E}\|\boldsymbol{S}\boldsymbol{G}\boldsymbol{T}\|^4)^{1/4} \leq \|\boldsymbol{S}\|(\|\boldsymbol{T}\|_{\mathrm{F}}^4 + 2\|\boldsymbol{T}\|_4^4)^{1/4} + \|\boldsymbol{T}\|(\|\boldsymbol{S}\|_{\mathrm{F}}^4 + 2\|\boldsymbol{S}\|_4^4)^{1/4}. \end{split}$$

Proof. The equalities come from direct calculations, e.g.,

$$\mathbb{E}\|\boldsymbol{S}\boldsymbol{G}\boldsymbol{T}\|_{\mathrm{F}}^2 = \mathbb{E} \ \mathrm{tr}\big(\boldsymbol{S}\boldsymbol{G}\boldsymbol{T}\boldsymbol{T}^*\boldsymbol{G}^*\boldsymbol{S}^*\big) = \mathbb{E} \sum_{ijkl} \boldsymbol{S}_{ij} \boldsymbol{G}_{jk} \boldsymbol{T}_{kl} \boldsymbol{T}_{kl} \boldsymbol{G}_{jk} \boldsymbol{S}_{ij} = \sum_{ij} \boldsymbol{S}_{ij}^2 \sum_{kl} \boldsymbol{T}_{kl}^2.$$

We have used the fact that unmatched Gaussians $G_{ab}G_{cd}$ for $(a, b) \neq (c, d)$ vanish in expectation, so it is only necessary to consider the matched Gaussian terms $G_{ab}G_{ab}$.

The inequalities come from a comparison principle for Gaussian random variables. We compare two Gaussian random fields

$$X_{uv} = \langle S^*u, GTv \rangle + ||S^*u|| ||Tv|| \gamma,$$

$$Y_{uv} = ||S^*u|| \langle h, Tv \rangle + ||Tv|| \langle g, S^*u \rangle,$$

where $\gamma \in \mathbb{R}$ is a Gaussian random variable and $\boldsymbol{h} \in \mathbb{R}^p$ and $\boldsymbol{g} \in \mathbb{R}^n$ are Gaussian random vectors, independent from one another and independent from \boldsymbol{G} . The indices $\boldsymbol{u} \in \mathbb{R}^L$ and $\boldsymbol{v} \in \mathbb{R}^Q$ are unit-length vectors satisfying $\|\boldsymbol{u}\| = \|\boldsymbol{v}\| = 1$. A short calculation verifies that

$$\begin{split} \mathbb{E}[X_{uv}X_{u'v'}] &= \langle S^*u, S^*u' \rangle \langle Tv, Tv' \rangle + \|S^*u\| \|S^*u'\| \|Tv\| \|Tv'\|, \\ \mathbb{E}[Y_{uv}Y_{u'v'}] &= \|S^*u\| \|S^*u'\| \langle Tv, Tv' \rangle + \langle S^*u, S^*u' \rangle \|Tv\| \|Tv'\|. \end{split}$$

Hence,

$$\mathbb{E}[X_{uv}X_{u'v'}] - \mathbb{E}[Y_{uv}Y_{u'v'}]$$

$$= (\|S^*u\|\|S^*u'\| - \langle S^*u, S^*u' \rangle)(\|Tv\|\|Tv'\| - \langle Tv, Tv' \rangle) \ge 0.$$

Consequently, the increments of X and Y satisfy

$$\mathbb{E} |X_{\boldsymbol{u}\boldsymbol{v}} - X_{\boldsymbol{u}'\boldsymbol{v}'}|^2 \le \mathbb{E} |Y_{\boldsymbol{u}\boldsymbol{v}} - Y_{\boldsymbol{u}'\boldsymbol{v}'}|^2,$$

and Slepian's lemma [107, Sec. 7.2] gives the result

$$\mathbb{E} \left| \max_{\boldsymbol{u}, \boldsymbol{v}} X_{\boldsymbol{u} \boldsymbol{v}} \right|^p \le \mathbb{E} \left| \max_{\boldsymbol{u}, \boldsymbol{v}} Y_{\boldsymbol{u} \boldsymbol{v}} \right|^p$$

for any $p \geq 1$. Using Jensen's inequality, we find also

$$\mathbb{E}\|SGT\|^p = \mathbb{E}\max_{u,v} |u^*SGTv|^p \leq \mathbb{E}|\max_{u,v} X_{uv}|^p \leq \mathbb{E}|\max_{u,v} Y_{uv}|^p.$$

To bound $\mathbb{E} | \max_{u,v} Y_{uv}|^p$ in the case p = 2, we use the triangle inequality a direct calculation involving second moments of Gaussians to calculate

$$\begin{split} \left(\mathbb{E} \left| \max_{\boldsymbol{u}, \boldsymbol{v}} Y_{\boldsymbol{u} \boldsymbol{v}} \right|^2 \right)^{1/2} &\leq \left(\mathbb{E} \big| \|\boldsymbol{S}\| \|\boldsymbol{T}^* \boldsymbol{h}\| + \|\boldsymbol{T}\| \|\boldsymbol{S} \boldsymbol{g}\| \big|^2 \right)^{1/2} \\ &\leq \left(\mathbb{E} \big| \|\boldsymbol{S}\| \|\boldsymbol{T}^* \boldsymbol{h}\| \big|^2 \right)^{1/2} + \left(\mathbb{E} \big| \|\boldsymbol{T}\| \|\boldsymbol{S} \boldsymbol{g}\| \big|^2 \right)^{1/2} \\ &= \|\boldsymbol{S}\| \|\boldsymbol{T}\|_{\mathrm{F}} + \|\boldsymbol{T}\| \|\boldsymbol{S}\|_{\mathrm{F}}. \end{split}$$

Similarly, to bound $\mathbb{E} |\max_{\boldsymbol{u},\boldsymbol{v}} Y_{\boldsymbol{u}\boldsymbol{v}}|^p$ in the case p=4, we calculate

$$\begin{split} \left(\mathbb{E} \left| \max_{\boldsymbol{u}, \boldsymbol{v}} Y_{\boldsymbol{u} \boldsymbol{v}} \right|^4 \right)^{1/4} & \leq \left(\mathbb{E} \big| \|\boldsymbol{S}\| \|\boldsymbol{T}^* \boldsymbol{h}\| \big|^4 \right)^{1/4} + \left(\mathbb{E} \big| \|\boldsymbol{T}\| \|\boldsymbol{S} \boldsymbol{g}\| \big|^4 \right)^{1/4} \\ & = \|\boldsymbol{S}\| (\|\boldsymbol{T}\|_{\mathrm{F}}^4 + 2\|\boldsymbol{T}\|_4^4)^{1/4} + \|\boldsymbol{T}\| (\|\boldsymbol{S}\|_{\mathrm{F}}^4 + 2\|\boldsymbol{S}\|_4^4)^{1/4}, \end{split}$$

where the last equality comes from a direct calculation involving fourth moments of Gaussians.

LEMMA A.2 (Inverse moment bounds). Consider a Gaussian matrix $G \in \mathbb{R}^{r \times k}$ with $r \leq k$. Then, $(GG^*)^{-1}$ satisfies the moment formulas

$$\mathbb{E}(\mathbf{G}\mathbf{G}^*)^{-1} = \frac{1}{k-r-1}\mathbf{I}, \qquad r \le k-2$$

$$\mathbb{E}\|(\mathbf{G}\mathbf{G}^*)^{-1}\|_*^2 = \frac{r^2(k-r) - 2r(r-1)}{(k-r)(k-r-1)(k-r-3)}, \qquad r \le k-4$$

$$\mathbb{E}\|(\mathbf{G}\mathbf{G}^*)^{-1}\|_{\mathrm{F}}^2 = \frac{r(k-1)}{(k-r)(k-r-1)(k-r-3)}, \qquad r \le k-4,$$

and the upper bounds

(A.1)
$$\mathbb{E}[a : \text{tr}(\mathbf{G}\mathbf{G}^*)^{-1}] \le \frac{r}{2}\log(1+2a), \qquad r = k-1,$$

(A.2)
$$\mathbb{E}\left[a: \operatorname{tr}(\boldsymbol{G}\boldsymbol{G}^*)^{-1}\right] \le \sqrt{\frac{\pi a}{2}}, \qquad r = k.$$

Last, for any $r \leq k$ and $t \geq 0$,

(A.3)
$$\mathbb{P}\left\{ \operatorname{tr}(\mathbf{G}\mathbf{G}^*)^{-1} > \frac{\operatorname{et}r}{k-r+1} \right\} \le \sqrt{\frac{\pi r}{k-r+1}} t^{-(k-r+1)/2}.$$

Proof. Explicit formulas for $\mathbb{E}(\mathbf{G}\mathbf{G}^*)^{-1}$, $\mathbb{E}\|(\mathbf{G}\mathbf{G}^*)^{-1}\|_*^2$, and $\mathbb{E}\|(\mathbf{G}\mathbf{G}^*)^{-1}\|_F^2$ are given in [86, pg. 119]. The remaining formulas are new, but the expectation bounds are related to the computations in [100].

To establish these formulas, we begin by calculating

$$\mathbb{E}[a: \text{tr}(\boldsymbol{G}\boldsymbol{G}^*)^{-1}] = \mathbb{E}\left[a: \sum_{i=1}^r (\boldsymbol{G}\boldsymbol{G}^*)_{ii}^{-1}\right] \le \sum_{i=1}^r \mathbb{E}\left[a: (\boldsymbol{G}\boldsymbol{G}^*)_{ii}^{-1}\right],$$

where we have used the subadditivity of $x \mapsto a : x$ and the linearity of expectation. The inverse diagonal elements $1/(\mathbf{G}\mathbf{G}^*)_{ii}^{-1}$ for $1 \le i \le r$ have chi-squared distributions with p = k - r + 1 degrees of freedom [86, pg. 119]. Hence, their density function is

$$f(x) = \frac{1}{2^{p/2}\Gamma(p/2)}x^{p/2-1}e^{-x/2}, \quad x > 0.$$

In the case p=2, this allows us to evaluate

$$\mathbb{E}\left[a: (\boldsymbol{G}\boldsymbol{G}^*)_{ii}^{-1}\right] = \frac{1}{2} \int_0^\infty \frac{\mathrm{e}^{-x/2}}{a^{-1} + x} \, dx = \int_{1/(2a)}^\infty \frac{\mathrm{e}^{1/(2a) - y}}{y} \, dy \le \frac{1}{2} \log(1 + 2a),$$

where we have substituted y = x/2 + 1/(2a) and applied the bound [3, Sec. 5.1.20]

$$\int_{x}^{\infty} \frac{e^{-t}}{t} dt \le \log\left(1 + \frac{1}{x}\right) e^{-x}, \qquad x > 0.$$

In the case p = 1, we evaluate

$$\mathbb{E}\left[a: (\boldsymbol{G}\boldsymbol{G}^*)_{ii}^{-1}\right] \leq \frac{1}{2\sqrt{\pi}} \int_0^\infty \frac{x^{-1/2}}{a^{-1} + x} \, dx = \sqrt{\frac{a}{\pi}} \int_0^\infty \frac{1}{1 + y^2} \, dy = \sqrt{\frac{\pi a}{2}},$$

where we have substituted $x = a^{-1}y^2$ and used the fact that $1/(1+y^2)$ is the derivative of arctan y. Thus we establish the bounds (A.1) and (A.2).

Last, to establish the concentration inequality (A.3), we set u = etr/p and argue using Markov's inequality

$$\mathbb{P}\left\{ \operatorname{tr}(\boldsymbol{G}\boldsymbol{G}^*)^{-1} > u \right\} = \mathbb{P}\left\{ u^p : \|(\boldsymbol{G}\boldsymbol{G}^*)^{-1}\|_*^p > u^p : u^p \right\} \le \frac{\mathbb{E}\left[u^p : \|(\boldsymbol{G}\boldsymbol{G}^*)^{-1}\|_*^p \right]}{u^p : u^p}.$$

We directly evaluate $u^p: u^p = \frac{1}{2}u^p$, and we apply the monotonicity and subadditivity of $x \mapsto u^p: x$ to obtain the upper bound

$$\begin{split} u^p : \| (\boldsymbol{G}\boldsymbol{G}^*)^{-1} \|_*^p &= u^p : \left(\sum_{i=1}^r (\boldsymbol{G}\boldsymbol{G}^*)_{ii}^{-1} \right)^p \leq u^p : r^{p-1} \sum_{i=1}^r \left((\boldsymbol{G}\boldsymbol{G}^*)_{ii}^{-1} \right)^p \\ &\leq \sum_{i=1}^r u^p : r^{p-1} \left((\boldsymbol{G}\boldsymbol{G}^*)_{ii}^{-1} \right)^p = r^{p-1} \sum_{i=1}^r \frac{u^p}{r^{p-1}} : \left((\boldsymbol{G}\boldsymbol{G}^*)_{ii}^{-1} \right)^p. \end{split}$$

Hence, we have shown

$$\mathbb{P}\left\{ \operatorname{tr}(\boldsymbol{G}\boldsymbol{G}^*)^{-1} > u \right\} \le \frac{2r^{p-1}}{u^p} \sum_{i=1}^r \mathbb{E}\left[\frac{u^p}{r^{p-1}} : \left((\boldsymbol{G}\boldsymbol{G}^*)_{ii}^{-1} \right)^p \right],$$

Last, we set $a = u^p/r^{p-1}$ and for $1 \le i \le r$ we evaluate

$$\mathbb{E}\left[a: \left((\boldsymbol{G}\boldsymbol{G}^*)_{ii}^{-1} \right)^p \right] \le \frac{1}{2^{p/2}\Gamma(p/2)} \int_0^\infty \frac{x^{p/2-1}}{a^{-1} + x^p} \, dx$$

$$= \frac{\pi\sqrt{a}}{2^{p/2+1}\Gamma(p/2+1)} \le \frac{1}{2} \sqrt{\frac{\pi a}{p}} \left(\frac{\mathbf{e}}{p}\right)^{p/2},$$

where the last inequality follows from Stirling's approximation [3, Sec. 6.1.38]. We obtain

$$\mathbb{P}\{\operatorname{tr}(\boldsymbol{G}\boldsymbol{G}^*)^{-1} > u\} \le \sqrt{\frac{\pi r}{p}} \left(\frac{\operatorname{er}}{up}\right)^{p/2},$$

and substituting u = etr/p completes the proof.

LEMMA A.3 (Inverse moment bounds, spectral norm). For $0 \le p \le 18$ and $k \ge r + 2m$, the Gaussian matrix $\mathbf{G} \in \mathbb{R}^{r \times k}$ satisfies

(A.4)
$$(\mathbb{E}\|(\mathbf{G}\mathbf{G}^*)^{-1}\|^p)^{1/p} \le \frac{e^2(k+r)}{2(k-r)^2}.$$

Proof. Our starting point is a calculation due to Edelman [37, Prop. 5.1] that bounds the density $f_{\lambda_{\min}}$ for $\lambda_{\min}(GG^*)$ as

$$f_{\lambda_{\min}}(\lambda) \le \frac{\sqrt{\pi}\Gamma\left(\frac{k+1}{2}\right)}{2^{\frac{k-r+1}{2}}\Gamma\left(\frac{r}{2}\right)\Gamma\left(\frac{k-r+1}{2}\right)\Gamma\left(\frac{k-r+2}{2}\right)}\lambda^{\frac{k-r-1}{2}}e^{-\frac{\lambda}{2}}, \qquad \lambda > 0.$$

Applying the Legendre duplication formula $\Gamma(z)\Gamma\left(z+\frac{1}{2}\right)=2^{1-2z}\sqrt{\pi}\Gamma(2z)$, we obtain

(A.5)
$$f_{\lambda_{\min}}(\lambda) \leq \frac{2^{\frac{k-r-1}{2}} \Gamma\left(\frac{k+1}{2}\right)}{\Gamma\left(\frac{r}{2}\right) \Gamma\left(k-r+1\right)} \lambda^{\frac{k-r-1}{2}} e^{-\frac{\lambda}{2}}, \qquad \lambda > 0.$$

We can simplify (A.5) further by neglecting the $e^{-\lambda/2}$ factor and noting

$$\frac{2^{\frac{k-r+1}{2}}\Gamma\left(\frac{k+1}{2}\right)}{\Gamma\left(\frac{r}{2}\right)} \le 2^{\frac{k-r+1}{2}} \prod_{i=0}^{k-r} \sqrt{\frac{r+i}{2}} = \prod_{i=0}^{k-r} \sqrt{r+i} \le \left(\frac{k+r}{2}\right)^{\frac{k-r+1}{2}},$$

where we have used $\Gamma(z+\frac{1}{2}) \leq z^{1/2}\Gamma(z)$ [60] and $(r+i)(k-i) \leq (\frac{k+r}{2})^2$. We find

(A.6)
$$f_{\lambda_{\min}}(\lambda) \le \frac{\lambda^{\frac{k-r-1}{2}}}{2\Gamma(k-r+1)} \left(\frac{k+r}{2}\right)^{\frac{k-r+1}{2}}, \quad \lambda > 0.$$

Integrating (A.6) with respect to λ gives the probability bound

(A.7)
$$P\{\lambda_{\min}(\mathbf{G}\mathbf{G}^*) \le t\} \le \frac{1}{\Gamma(k-r+2)} \left(\frac{t(k+r)}{2}\right)^{\frac{k-r+1}{2}}, \quad t > 0.$$

which is nonvacuous for

$$t \le t_* = \Gamma(k - r + 2)^{\frac{2}{k - r + 1}} \left(\frac{2}{k + r}\right).$$

By an explicit integration of (A.7), we obtain the moment bound

$$\mathbb{E}\|(\mathbf{G}\mathbf{G}^*)^{-1}\|^p = p \int_0^\infty s^{p-1} P\{\lambda_{\min}(\mathbf{G}\mathbf{G}^*) \le s^{-1}\} ds$$

$$\le t_*^{-p} + p \int_{t_*}^\infty s^{p-1} P\{\lambda_{\min}(\mathbf{G}\mathbf{G}^*) \le s^{-1}\} ds$$

$$\le \left(1 + \frac{2p}{k - r + 1 - 2p}\right) t_*^{-p}$$

$$= \left(1 + \frac{2p}{k - r + 1 - 2p}\right) \left(\frac{1}{\Gamma(k - r + 2)}\right)^{\frac{2p}{k - r + 1}} \left(\frac{k + r}{2}\right)^p.$$

The theorem is complete as soon as we can verify the numerical identity

(A.8)
$$\left(1 + \frac{2p}{x+1-2p}\right) \left(\frac{1}{\Gamma(x+2)}\right)^{\frac{2p}{x+1}} \le \left(\frac{e}{x}\right)^{2p}, \quad 0 \le p \le 18, \quad x \ge 2p.$$

To establish (A.8), we briefly argue that

(A.9)
$$x \mapsto e \Gamma(x+2)^{\frac{1}{x+1}} \left(1 - \frac{2p}{x+1}\right)^{2p} - x$$

is non-decreasing for $x \geq 2p$, which can be shown by explicitly examining its derivative and applying

$$e\Gamma(x+2)^{\frac{1}{x+1}} \ge x+1, \qquad \frac{d}{dx} \left(e\Gamma(x+2)^{\frac{1}{x+1}} \right) \ge 1.$$

Next, using the fact that (A.9) is non-decreasing and applying Stirling's approximation [3, Sec. 6.1.38], we calculate the lower bound

$$e \Gamma(x+2)^{\frac{1}{x+1}} \left(1 - \frac{2p}{x+1}\right)^{2p} - x \ge e \Gamma(2p+2)^{\frac{1}{2p+1}} \left(1 - \frac{2p}{2p+1}\right)^{2p} - 2p$$

$$\ge \left(\frac{2\pi}{(2p+1)^{1+\frac{1}{p}}}\right)^{\frac{1}{4p+2}} (2p+1) - 2p,$$

The right-hand side is non-negative provided that

$$\frac{2\pi}{(2p+1)^{1+\frac{1}{p}}} \ge e^{-2},$$

which holds for any $p \geq 18$. We conclude that

$$e\Gamma(x+2)^{\frac{1}{x+1}}\left(1-\frac{2p}{x+1}\right)^{2p}-x\geq 0, \qquad 0\leq p\leq 18, \quad x\geq 2p,$$

which is equivalent to (A.8), thus completing the proof.

A.1. Proof of Proposition 6.6. When we condition on H, the mapping $G \mapsto \|SGH^{\dagger}\|_{F}$ is Lipschitz with Lipschitz constant $L = \|S\|_{F} \|H^{\dagger}\|_{F}$, and the conditional expectation satisfies

$$\mathbb{E}\big[\|\boldsymbol{S}\boldsymbol{G}\boldsymbol{H}^{\dagger}\|_{\mathrm{F}}\,|\,\boldsymbol{H}\big] \leq \mathbb{E}\big[\|\boldsymbol{S}\boldsymbol{G}\boldsymbol{H}^{\dagger}\|_{\mathrm{F}}^{2}\,|\,\boldsymbol{H}\big]^{1/2} = \|\boldsymbol{S}\|_{\mathrm{F}}\|\boldsymbol{H}^{\dagger}\|_{\mathrm{F}}.$$

Using a concentration inequality for Lipschitz functions of Gaussian random fields [15, Thm. 4.5.7], we find for any $u \ge 1$,

$$\mathbb{P}\left\{\|\boldsymbol{S}\boldsymbol{G}\boldsymbol{H}^{\dagger}\|_{\mathrm{F}} > \sqrt{u}\|\boldsymbol{S}\|_{\mathrm{F}}\|\boldsymbol{H}^{\dagger}\|_{\mathrm{F}} \mid \boldsymbol{H}\right\} \leq \mathrm{e}^{-(\sqrt{u}-1)^{2}/2},$$

and the right-hand side is bounded by $e^{-(u-2)/4}$ for any $u \ge 0$. Hence, we obtain the conditional probability bound

(A.10)
$$\mathbb{P}\left\{\|\mathbf{S}\mathbf{G}\mathbf{H}^{\dagger}\|_{F}^{2} > \frac{utr}{k-r+1}\|\mathbf{S}\|_{F}^{2} \mid \|\mathbf{H}^{\dagger}\|_{F}^{2} \leq \frac{tr}{k-r+1}\right\} \leq e^{-(u-2)/4},$$

while Lemma A.2 implies the probability bound

(A.11)
$$\mathbb{P}\left\{\|\boldsymbol{H}^{\dagger}\|_{\mathrm{F}}^{2} > \frac{tr}{k-r+1}\right\} \leq \sqrt{\pi r} \left(\frac{t}{\mathrm{e}}\right)^{-(k-r+1)/2}.$$

Combining (A.10) and (A.11) establishes the probability bound (6.9) for $\|\mathbf{SGH}^{\dagger}\|_{\mathrm{F}}^2$. Additionally, Lemmas A.1 and A.2 allow us to verify the expectation bound (6.10) for $\|\mathbf{SGH}^{\dagger}\|_{\mathrm{F}}^2$, namely,

$$\begin{split} \mathbb{E} \| \boldsymbol{S} \boldsymbol{G} \boldsymbol{H}^{\dagger} \|_{\mathrm{F}}^{2} &= \mathbb{E} \, \mathbb{E} \big[\| \boldsymbol{S} \boldsymbol{G} \boldsymbol{H}^{\dagger} \|_{\mathrm{F}}^{2} \mid \boldsymbol{H}^{\dagger} \big] = \| \boldsymbol{S} \|_{\mathrm{F}}^{2} \, \mathbb{E} \| \boldsymbol{H}^{\dagger} \|_{\mathrm{F}}^{2} \\ &= \| \boldsymbol{S} \|_{\mathrm{F}}^{2} \, \mathbb{E} \, \operatorname{tr} (\boldsymbol{H}^{\dagger} (\boldsymbol{H}^{\dagger})^{*}) = \| \boldsymbol{S} \|_{\mathrm{F}}^{2} \, \operatorname{tr} (\mathbb{E} (\boldsymbol{H} \boldsymbol{H}^{*})^{-1}) \\ &= \| \boldsymbol{S} \|_{\mathrm{F}}^{2} \frac{r}{k - r - 1}. \end{split}$$

In the above display, we have applied conditioning and then exchanged the expectation and the trace.

A.2. Proof of Theorem 6.7. Using Lemma 6.3, we assume \boldsymbol{A} is diagonal and psd, with non-increasing diagonal entries. Then, we partition the matrices as

so that A_1 is a $r \times r$ matrix and Ω_1 is a $r \times k$ matrix. We will systematically derive expectation bounds in the Frobenius norm, spectral norm, and Schatten-4 norm.

To begin, Proposition 6.5 guarantees the error bound

$$\mathbb{E}\|\boldsymbol{A} - \boldsymbol{\Pi}_{\boldsymbol{A}\boldsymbol{\Omega}}\boldsymbol{A}\|_{\mathrm{F}}^2 \leq \|\boldsymbol{A}_2\|_{\mathrm{F}}^2 + \mathbb{E}\left[\|\boldsymbol{A}_1\|_{\mathrm{F}}^2 : \|\boldsymbol{A}_2\boldsymbol{\Omega}_2\boldsymbol{\Omega}_1^{\dagger}\|_{\mathrm{F}}^2\right].$$

Using the concavity of the parallel sum (Lemma 6.4 part 3) and Lemma A.1, we argue

$$\begin{split} \mathbb{E}\left[\|\boldsymbol{A}_1\|_{\mathrm{F}}^2:\|\boldsymbol{A}_2\boldsymbol{\Omega}_2\boldsymbol{\Omega}_1^{\dagger}\|_{\mathrm{F}}^2\right] &= \mathbb{E}\left[\mathbb{E}\left[\|\boldsymbol{A}_1\|_{\mathrm{F}}^2:\|\boldsymbol{A}_2\boldsymbol{\Omega}_2\boldsymbol{\Omega}_1^{\dagger}\|_{\mathrm{F}}^2\,\big|\,\boldsymbol{\Omega}_1\right]\right] \\ &\leq \mathbb{E}\left[\|\boldsymbol{A}_1\|_{\mathrm{F}}^2:\mathbb{E}\left[\|\boldsymbol{A}_2\boldsymbol{\Omega}_2\boldsymbol{\Omega}_1^{\dagger}\|_{\mathrm{F}}^2\,\big|\,\boldsymbol{\Omega}_1\right]\right] \\ &= \mathbb{E}\left[\|\boldsymbol{A}_1\|_{\mathrm{F}}^2:\|\boldsymbol{A}_2\|_{\mathrm{F}}^2\|\boldsymbol{\Omega}_1^{\dagger}\|_{\mathrm{F}}^2\right] \\ &= \|\boldsymbol{A}_2\|_{\mathrm{F}}^2\cdot\mathbb{E}\left[\frac{\|\boldsymbol{A}_1\|_{\mathrm{F}}^2}{\|\boldsymbol{A}_2\|_{\mathrm{F}}^2}:\|\boldsymbol{\Omega}_1^{\dagger}\|_{\mathrm{F}}^2\right]. \end{split}$$

Using Lemma A.2, we bound the last quantity as

$$\mathbb{E}\left[\frac{\|\boldsymbol{A}_1\|_{\mathrm{F}}^2}{\|\boldsymbol{A}_2\|_{\mathrm{F}}^2}:\|\boldsymbol{\Omega}_1^\dagger\|_{\mathrm{F}}^2\right] \leq \begin{cases} \frac{r}{k-r-1}, & k \geq r+2, \\ r\log\left(1+\frac{\|\boldsymbol{A}_1\|_{\mathrm{F}}^2}{\|\boldsymbol{A}_2\|_{\mathrm{F}}^2}\right), & k = r+1, \\ r\left(\frac{\pi\|\boldsymbol{A}_1\|_{\mathrm{F}}^2}{2\|\boldsymbol{A}_2\|_{\mathrm{F}}^2}\right)^{1/2}, & k = r, \end{cases}$$

which confirms the Frobenius norm error bounds for RSVD.

Next, working in the spectral norm, Proposition 6.5 guarantees

$$\mathbb{E}\|\boldsymbol{A} - \boldsymbol{\Pi}_{\boldsymbol{A}\boldsymbol{\Omega}}\boldsymbol{A}\|^2 \leq \|\boldsymbol{A}_2\|^2 + \mathbb{E}\|\boldsymbol{A}_2\boldsymbol{\Omega}_2\boldsymbol{\Omega}_1^{\dagger}\|^2$$

We use Lemmas A.1 to A.3 to calculate

$$\begin{split} \left(\, \mathbb{E} \| \boldsymbol{A}_2 \boldsymbol{\Omega}_1^\dagger \|^2 \, \right)^{1/2} &= \left(\, \mathbb{E} \big[\, \mathbb{E} \big[\, \| \boldsymbol{A}_2 \boldsymbol{\Omega}_2 \boldsymbol{\Omega}_1^\dagger \|^2 \, \big| \, \boldsymbol{\Omega}_1 \, \big] \, \big] \, \right)^{1/2} \\ &= \left(\, \mathbb{E} \big[\, \| \boldsymbol{A}_2 \| \| \boldsymbol{\Omega}_1^\dagger \|_F + \| \boldsymbol{\Omega}_1^\dagger \| \| \boldsymbol{A}_2 \|_F \, \big|^2 \, \right)^{1/2} \\ &\leq \| \boldsymbol{A}_2 \| \big(\, \mathbb{E} \| \boldsymbol{\Omega}_1^\dagger \|_F^2 \big)^{1/2} + \big(\, \mathbb{E} \| \boldsymbol{\Omega}_1^\dagger \|^2 \big)^{1/2} \| \boldsymbol{A}_2 \|_F \\ &\leq \left(\frac{r}{k-r-1} \right)^{1/2} \| \boldsymbol{A}_2 \| + \left(\frac{\mathrm{e}^2 (k+r)}{2(k-r)^2} \right)^{1/2} \| \boldsymbol{A}_2 \|_F, \end{split}$$

whence

$$\mathbb{E}\|\boldsymbol{A} - \boldsymbol{\Pi}_{\boldsymbol{A}\boldsymbol{\Omega}}\boldsymbol{A}\|^{2} \leq \|\boldsymbol{A}_{2}\|^{2} + \frac{2r}{k-r-1}\|\boldsymbol{A}_{2}\|^{2} + \frac{e^{2}(k+r)}{(k-r)^{2}}\|\boldsymbol{A}_{2}\|_{F}^{2}$$
$$\leq \left(1 + \frac{2r}{k-r-1}\right)\left(\|\boldsymbol{A}_{2}\|^{2} + \frac{e^{2}}{k-r}\|\boldsymbol{A}_{2}\|_{F}^{2}\right),$$

which confirms the spectral norm error bound for RSVD.

Last, to obtain fourth moment expectation bounds, we apply Proposition 6.6 and the triangle inequality to yield

$$\begin{split} \left(\left. \mathbb{E} \| \boldsymbol{A} - \boldsymbol{\Pi}_{\boldsymbol{A}\boldsymbol{\Omega}} \boldsymbol{A} \right\|_p^4 \right)^{1/2} & \leq \left(\left. \mathbb{E} \right| \| \boldsymbol{A}_2 \|_p^2 + \| \boldsymbol{A}_2 \boldsymbol{\Omega}_2 \boldsymbol{\Omega}_1^\dagger \|_p^2 \right|^2 \right)^{1/2} \\ & \leq \| \boldsymbol{A}_2 \|_p^2 + \left(\left. \mathbb{E} \| \boldsymbol{A}_2 \boldsymbol{\Omega}_2 \boldsymbol{\Omega}_1^\dagger \|_p^4 \right)^{1/2} \end{split}$$

and we proceed to bound $(\mathbb{E}\|A_2\Omega_2\Omega_1^{\dagger}\|_p^4)^{1/2}$ for $p=4,\infty$. We use Lemmas A.1 and A.2 to calculate

$$\begin{split} \left(\mathbb{E}\|\boldsymbol{A}_{2}\boldsymbol{\Omega}_{2}\boldsymbol{\Omega}_{1}^{\dagger}\|_{4}^{4}\right)^{1/2} &= \left(\mathbb{E}\left[\mathbb{E}\left[\|\boldsymbol{A}_{2}\boldsymbol{\Omega}_{2}\boldsymbol{\Omega}_{1}^{\dagger}\|_{4}^{4}\,\middle|\,\boldsymbol{\Omega}_{1}\,\right]\right]\right)^{1/2} \\ &= \left(\mathbb{E}\left[\|\boldsymbol{A}_{2}\|_{4}^{4}\|\boldsymbol{\Omega}_{1}^{\dagger}\|_{F}^{4} + \|\boldsymbol{A}_{2}\|_{4}^{4}\|\boldsymbol{\Omega}_{1}^{\dagger}\|_{4}^{4} + \|\boldsymbol{A}_{2}\|_{F}^{4}\|\boldsymbol{\Omega}_{1}^{\dagger}\|_{4}^{4}\right]\right)^{1/2} \\ &\leq \left(\mathbb{E}\left[\|\boldsymbol{\Omega}_{1}^{\dagger}\|_{F}^{4} + \|\boldsymbol{\Omega}_{1}^{\dagger}\|_{4}^{4}\right]\right)^{1/2}\|\boldsymbol{A}_{2}\|_{4}^{2} + \left(\mathbb{E}\|\boldsymbol{\Omega}_{1}^{\dagger}\|_{4}^{4}\right)^{1/2}\|\boldsymbol{A}_{2}\|_{F}^{2} \\ &\leq \frac{r+1}{k-r-3}\|\boldsymbol{A}_{2}\|_{4}^{2} + \left(\frac{r(k-1)}{(k-r)(k-r-1)(k-r-3)}\right)^{1/2}\|\boldsymbol{A}_{2}\|_{F}^{2} \\ &\leq \frac{r+1}{k-r-3}\|\boldsymbol{A}_{2}\|_{4}^{2} + \frac{k-2}{(k-r-3)\sqrt{k-r}}\|\boldsymbol{A}_{2}\|_{F}^{2}, \end{split}$$

where the last line follows because $r \le k - 4$. Thus, we confirm the Schatten-4 norm error bound for RSVD. We use Lemmas A.1 to A.3 to calculate

$$\begin{split} & \left(\mathbb{E} \| \boldsymbol{A}_{2} \boldsymbol{\Omega}_{2} \boldsymbol{\Omega}_{1}^{\dagger} \|^{4} \right)^{1/4} \\ & = \left(\mathbb{E} \left[\mathbb{E} \left[\| \boldsymbol{A}_{2} \boldsymbol{\Omega}_{2} \boldsymbol{\Omega}_{1}^{\dagger} \|^{4} \, | \, \boldsymbol{\Omega}_{1} \, \right] \right] \right)^{1/4} \\ & \leq \left(\mathbb{E} \left[\| \boldsymbol{A}_{2} \| (\| \boldsymbol{\Omega}_{1}^{\dagger} \|_{F}^{4} + 2 \| \boldsymbol{\Omega}_{1}^{\dagger} \|_{4}^{4})^{1/4} + \| \boldsymbol{\Omega}_{1}^{\dagger} \| (\| \boldsymbol{A}_{2} \|_{F}^{4} + 2 \| \boldsymbol{A}_{2} \|_{4}^{4})^{1/4} \, |^{4} \right)^{1/4} \\ & \leq \left(\mathbb{E} \left[\| \boldsymbol{\Omega}_{1}^{\dagger} \|_{F}^{4} + 2 \| \boldsymbol{\Omega}_{1}^{\dagger} \|_{4}^{4} \right] \right)^{1/4} \| \boldsymbol{A}_{2} \| + 3^{1/4} \left(\mathbb{E} \| \boldsymbol{\Omega}_{1}^{\dagger} \|^{4} \right)^{1/4} \| \boldsymbol{A}_{2} \|_{F} \\ & \leq \left(\frac{r+2}{k-r-3} \right)^{1/2} \| \boldsymbol{A}_{2} \| + \left(\frac{\sqrt{3} e^{2} (k+r)}{2(k-r)^{2}} \right)^{1/2} \| \boldsymbol{A}_{2} \|_{F}, \end{split}$$

whence

$$\left(\mathbb{E}\|\boldsymbol{A}_{2}\boldsymbol{\Omega}_{2}\boldsymbol{\Omega}_{1}^{\dagger}\|^{4}\right)^{1/2} \leq \frac{2(r+2)}{k-r-3}\|\boldsymbol{A}_{2}\|^{2} + \frac{\sqrt{3}e^{2}(k+r)}{(k-r)^{2}}\|\boldsymbol{A}_{2}\|_{F}^{2},$$

which confirms the last error bound for RSVD and completes the proof of Theorem 6.7.

Appendix B. Proof of Lemma 7.3. To confirm part 3 of Lemma 7.3, we first observe

(B.1)
$$2r = \int_0^r 2 \, ds \le \int_0^r \frac{2 \, ds}{1 - s^2} = \log\left(\frac{1 + r}{1 - r}\right),$$

and by exponentiating both sides we obtain $e^{2r} \le (1+r)/(1-r)$. Next, for $x \ge 1$, we express the Chebyshev polynomial $T_q(x)$ as

(B.2)
$$2T_q(x) = 2\cosh(\log(x+\sqrt{x^2-1})) = (x+\sqrt{x^2-1})^q + (x+\sqrt{x^2-1})^{-q},$$

where we have used the logarithmic representation $\operatorname{arcosh} x = \log(x + \sqrt{x^2 - 1})$ [3, Sec. 4.6.21]. By substituting x = (1 + r)/(1 - r) into (B.2), we establish

$$e^{2q\sqrt{r}} \le \left(\frac{1+\sqrt{r}}{1-\sqrt{r}}\right)^q \le \left(\frac{1+\sqrt{r}}{1-\sqrt{r}}\right)^q + \left(\frac{1+\sqrt{r}}{1-\sqrt{r}}\right)^{-q} = 2T_q\left(\frac{1+r}{1-r}\right),$$

which gives the stated lower bound for the Chebyshev polynomial T_q .

To confirm part 4 of Lemma 7.3, we write

(B.3)
$$T_q^{-1}(x) = \cosh\left(\frac{1}{q}\operatorname{arcosh} x\right)$$

and apply the inequalities $\cosh(x) \le \exp(x^2/2)$ [3] and $\operatorname{arcosh} x \le \log(2x)$, which are both valid for $x \ge 1$.

Last, to confirm part 5 of Lemma 7.3, set $\phi(x) = xT_q(x^p)^2$ for p = 1/2 or p = 1/4. A direct calculation shows the derivative $\phi'(x)$ is increasing for $x \ge 1$ and attains its largest value at the right endpoint of the interval $0 \le x \le 1$, which suffices to show

$$\phi(y) > \phi(x) + \phi'(x)(y - x)$$

for any $x \ge 1$ and any $y \ge 0$.
