## SLICING UP MULTIGRADED LINEAR SERIES

ÁDÁM GYENGE

Abstract. Multigraded linear series generalize the classical morphism to the linear series of a basepoint-free line bundle on a scheme. We investigate the collection of the natural cornering morphisms into elementary bigraded linear series obtained from direct summands of the original globally generated vector bundle. Our main result is a condition on the injectivity of the product morphism. We apply our result in three examples: modules over the reconstruction algebra, equivariant Hilbert and Quot schemes of quotient stacks and Kapranov's tilting bundle over the Grassmannian.

### 1. INTRODUCTION

Multigraded linear series were introduced by Craw-Ito-Karmazyn in [\[5\]](#page-10-0) as a generalisation of linear series. Given a scheme  $Y$  equipped with a collection of globally generated vector bundles  $E_1, \ldots, E_n$  their construction provides a universal morphism from Y to a certain fine moduli space  $\mathcal{M}(E)$  of cyclic modules over the endomorphism algebra of

$$
E = \mathcal{O} \oplus E_1 \oplus \cdots \oplus E_n.
$$

A natural construction arising in this context is when someone restricts the collection of vector bundles to a subset of the original ones:

$$
E_I = \mathcal{O} \oplus \bigoplus_{i \in I} E_i \quad \text{ for some } I \subseteq \{1, \ldots, n\}.
$$

This process is called cornering, and there is a corresponding natural cornering morphism

$$
\mathcal{M}(E) \to \mathcal{M}(E_I)
$$

between the original and the cornered moduli spaces.

A condition for the surjectivity of the cornering morphism was given in [\[5,](#page-10-0) Proposition 3.7]. In this paper we consider the complementary question of injectivity. Of course a single cornering morphism is rarely injective. Therefore we consider a collection of cornering morphisms for subsets  $I_1, \ldots, I_l \subset \{0, \ldots, n\}$ . Our main result is the following.

**Theorem 1.1** (Theorem [3.3\)](#page-5-0). Let  $I_1, \ldots, I_l$  be subsets of  $\{0, \ldots, n\}$  that cover I, that is,  $\bigcup_{i=1}^{l} I_i = \{0, \ldots, n\} = I$  such that  $0 \in I_i$ ,  $1 \leq i \leq l$ . Then the product of the cornering morphisms

$$
\mathcal{M}(E) \to \prod_{i=1}^l \mathcal{M}(E_{I_l})
$$

induces a closed immersion on the reduced scheme underlying  $\mathcal{M}(E)$ .

The components of the image of a point of  $\mathcal{M}(E)$  under this closed immersion can be considered as 'slices', from which the original point in  $\mathcal{M}(E)$  can be reconstructed.

Such situation occurs in a number moduli problems. We give three examples in the paper. We apply first our result to modules over the reconstruction algebra associated with a finite subgroup  $\Gamma <$  GL(2,  $\mathbb{C}$ ) without pseudo-reflections. In this setting there exists an index set Sp and a bundle  $T_{\text{Sp}}$  such that  $\mathcal{M}(T_{\text{Sp}})$  is the minimal resolution of the quotient singularity  $\mathbb{C}^2/\Gamma$  and the spaces  $\mathcal{M}(T_{\lbrack\rho\rbrack})$  obtained from  $\mathcal{M}(T_{\text{Sp}})$  via cornering with  $[\rho] = \rho_0, \rho$  give certain partial resolutions.

Corollary 1.2 (Corollary [4.2\)](#page-7-0). The product of the cornering morphisms

$$
\mathcal{M}(T_{\mathrm{Sp}}) \to \prod_{\rho \in \mathrm{Sp} \backslash \rho_0} \mathcal{M}(T_{[\rho]})
$$

is a closed immersion.

Second, when  $\Gamma < SL(2,\mathbb{C})$  is a finite subgroup our result implies that a certain map from the equivariant Hilbert scheme of the quotient stack [**C** <sup>2</sup>/Γ] to the product of certain Quot schemes, which were constructed and identified with Nakajima quiver varieties in [\[4\]](#page-10-1), is a closed immersion.

<span id="page-1-2"></span>Corollary 1.3 (Corollary [4.6\)](#page-9-0). Let  $I_1, \ldots, I_l$  be a covering of the set  $\{0, \ldots, r\}$  and  $n \in$  $N^{r+1}$ . The product of the cornering morphisms induces a closed immersion

$$
\operatorname{Hilb}^n([\mathbb{C}^2/\Gamma]) \to \prod_{i=1}^l \operatorname{Quot}_{I_i}^{n_{I_i}}([\mathbb{C}^2/\Gamma])
$$

Third, let E be the tilting bundle over the Grassmannian  $Gr(n, r)$  constructed in [\[8\]](#page-10-2). Its summands are indexed by Young diagrams of size at most  $n - r$  and length at most r. Denote by Young'( $n-r,r$ ) the nontrivial diagrams like that, and again, let  $[\lambda] = \{0, \lambda\}$  for any  $\lambda \in \text{Young}'(n-r,r)$ .

<span id="page-1-3"></span>Corollary 1.4 (Corollary [4.9\)](#page-9-1). There exists a closed immersion

$$
\operatorname{Gr}(n,r) \to \prod_{\lambda \in \operatorname{Young}'(n-r,r)} \mathcal{M}(E_{[\lambda]}).
$$

The structure of the paper is as follows. In Section [2](#page-1-0) we collect necessarily preliminaries on multigraded linear series and their cornering. In Section [3](#page-3-0) we establish our main technique for recovering modules from a set of its restrictions and we prove the main Theorem [3.3.](#page-5-0) Finally, in Section [4](#page-6-0) we give three applications of the main result and prove Corollaries [1.2,](#page-1-1) [1.3](#page-1-2) and [1.4.](#page-1-3)

### 2. Preliminaries

<span id="page-1-0"></span>Throughout the paper we work over an algebraically closed field **k** of characteristic zero.

2.1. Multigraded linear series. Let R be a finitely generated **k**-algebra. Let Y be a projective R-scheme. Given a collection  $E_1, \ldots, E_n$  of effective vector bundles on Y, define

$$
E \coloneqq \bigoplus_{0 \le i \le n} E_i
$$

where  $E_0$  is the trivial line bundle on Y. Let

$$
A \coloneqq \mathrm{End}_Y(E)
$$

denote the endomorphism algebra of E and consider the dimension vector

$$
v \coloneqq (v_i), \quad v_i \coloneqq \text{rk}(E_i), \quad 0 \le i \le n.
$$

The associative algebra A admits a presentation of the form

$$
A \simeq \Bbbk Q/I
$$

for some finite connected quiver Q and a two-sided ideal I ⊂ **k**Q. Denote the vertex set of Q by  $Q_0 = \{0, 1, \ldots, n\}$  and by  $(e_i)$ ,  $i \in Q_0$  the corresponding set of orthogonal idempotents.

Fix a dimension vector  $v = (v_i) \in \mathbb{N}^{\mathcal{Q}_0}$ . The space of stability conditions of A-modules of dimension  $v$  is

$$
\Theta_v = \big\{\theta = (\theta_i) : \mathbb{Z}^{Q_0} \to \mathbb{Q} \; : \; \sum_{i \in Q_0} \theta_i v_i = 0 \big\}.
$$

For  $\theta \in \Theta_v$ , an A-module M of dimension vector v is semistable (resp. stable) if  $\theta(N) \geq 0$ (resp.  $\theta(N) > 0$ ) for every nonzero proper A-submodule  $N \subset M$ . The space  $\Theta_n$  admits a preorder  $\geq$ , and this induces a wall-and-chamber structure, where  $\theta, \theta' \in \Theta_v$  lie in the relative interior of the same cone if and only if both  $\theta \ge \theta'$  and  $\theta' \ge \theta$  hold in this preorder. The interiors of the top-dimensional cones in  $\Theta_v$  are chambers, while the codimension-one faces of the closure of each chamber are walls. We say that  $\theta \in \Theta_v$  is generic with respect to  $v$ , if it lies in some chamber.

When the dimension vector (v) is indivisible and  $\theta \in \Theta_v$  is generic, there exists by [\[9,](#page-10-3) Proposition 5.3] a fine moduli space

$$
\mathcal{M}(A,v,\theta)
$$

of isomorphism classes of  $\theta$ -stable A-modules of dimension vector v. The universal family on  $\mathcal{M}(A, v, \theta)$  is a tautological locally-free sheaf

$$
T=\oplus_{i\in Q_0}T_i
$$

together with a k-algebra homomorphism  $A \to \text{End}(T)$  such that  $\text{rk}(T_i) = v_i$  for  $0 \leq i \leq n$ and  $T_0$  is the trivial bundle on  $\mathcal{M}(A, v, \theta)$ .

An A-module M is called  $\theta$ -generated if there exists a surjective A-module homomorphism  $Ae_0 \rightarrow M$ . As observed in [\[5,](#page-10-0) Proposition 2.3], E is a flat family of 0-generated A-modules if and only if  $E_i$  is globally generated for  $1 \leq i \leq n$ . In the rest of the paper we assume this and, as before, that  $E_0$  is the trivial line bundle. The dimension vector

$$
v = (\operatorname{rk}(E_i))_{0 \le i \le n}
$$

is then indivisible.

Choose a stability parameter  $\theta'$  such that

$$
\theta_i' = 1 \quad \text{for } i > 0.
$$

Then  $\theta'$  generic, and there is a smallest integer  $j > 0$  such that the ample line bundle  $L_{\theta'}$ provided by the GIT construction of  $\mathcal{M}(A, v, \theta')$  is very ample. Finally, set

$$
\theta \coloneqq j\theta',
$$

which is again generic. The *multigraded linear series* of  $E$  is the fine moduli space

$$
\mathcal{M}(E) \coloneqq \mathcal{M}(A, v, \theta)
$$

of 0-generated A-modules of dimension vector  $v$  (see [\[5,](#page-10-0) Definition 2.5]).

2.2. **Cornering.** We continue to assume that  $R$  is a finitely generated  $\mathbb{k}$ -algebra,  $Y$  is a projective R-scheme and that  $E_1, \ldots, E_n$  are nontrivial globally generated vector bundles on Y. We wrote  $E_0 = \mathcal{O}_Y$ ,  $E = \bigoplus_{0 \leq i \leq n} E_i$  and defined  $A = \text{End}(E)$ . We now obtain a number of new algebras from A as in [\[5,](#page-10-0) Section 3].

Let

$$
I \subseteq \{0, 1, \ldots, n\}
$$

be any subset containing {0}. Define the idempotent

$$
e_I\coloneqq \sum_{i\in I} e_i
$$

of A and the **k**-algebra

$$
A_I \coloneqq e_I A e_I.
$$

Since  $A \simeq \text{End}(E)$ , the locally-free sheaf

$$
E_I \coloneqq \bigoplus_{i \in I} E_i
$$

on Y satisfies

$$
A_I \simeq \mathrm{End}(E_I).
$$

The process of passing from  $A$  to  $A_I$  is called *cornering* the algebra  $A$ . The corresponding multigraded linear series is  $M(E)$ 

$$
\mathcal{M}(E_I) = \mathcal{M}(E_I, v_I, \theta_I)
$$

where  $v_I = (\text{rk}(E_i))_{i \in I}$  and  $\theta_I$  is a suitable 0-generated stability parameter from  $\Theta_{v_I}$ . By [\[5,](#page-10-0) Section 3], for each pair of subsets

$$
\{0\} \subseteq I' \subseteq I \subseteq \{0, 1, \dots, n\}
$$

there also exists a universal cornering morphism

$$
\tau_{I,I'}: \mathcal{M}(E_I) \to \mathcal{M}(E_{I'}).
$$

For any  $1 \leq i \leq n$ , we will simply write

$$
[i] = \{0, i\}, \quad E_{[i]} = E_0 \oplus E_i, \quad A_{[i]} = (e_0 + e_i)A(e_0 + e_i)
$$

<span id="page-3-0"></span>and

$$
\tau_{[i]} = \tau_{\{0,\ldots,n\},[i]} : \mathcal{M}(E) \to \mathcal{M}(E_{[i]}).
$$

## 3. Slicing up A-modules

3.1. Recollement. Denote by A-mod the category of all finitely presented A-modules. Consider for  $1 \leq i \leq n$  the functors

$$
A\text{-mod} \xrightarrow{\qquad j_{[i]}} A_{[i]}\text{-mod}
$$

defined by  $j_{[i]*}(-) := \text{Hom}_{A_{[i]}}(A, -), \ j^*_{[i]}(-) := (e_0 + e_i)A \otimes_A (-)$  and  $j_{[i]!(-)} := A(e_0 + e_i)A$  $e_i) \otimes_{A_{[i]}} (-)$ . These are three of the six functors in a recollement of the category A-mod [\[5\]](#page-10-0). We need the following technical result about this adjunction setup.

# <span id="page-3-2"></span>**Lemma 3.1.** (1) Let  $M \in A_{[i]}$ -mod. There is a canonical A-module homomorphism  $\nu(M): j_{[i]!}M \to j_{[i]*}M,$

which is natural in M.

(2) Let  $F \in A$ -mod, and  $M = j_{[i]}^*F$ . The homomorphism  $\nu(j_{[i]}^*F)$  from (1) agrees with the composition

$$
j_{[i]!}j_{[i]}^*F \to F \to j_{[i]*}j_{[i]}^*F
$$

of the natural homomorphisms arising from the adjunctions.

*Proof.* Given  $M \in A_{[i]}$ -mod, to show (1) we need to define a homomorphism of A-modules

$$
\nu_M\colon A(e_0+e_i)\otimes_{A_{[i]}} M\to \text{Hom}_{A_{[i]}}(A,M).
$$

We define  $\nu_M$  for  $p \in A, m \in M$  and  $a \in A$  by

(1) 
$$
p(e_0 + e_i) \otimes m \mapsto (a \mapsto ((e_0 + e_i)ap(e_0 + e_i)) \cdot m),
$$

extending this to sums of tensors linearly. This formula defines a homomorphism of left A-modules: the A-action on the left is multiplication on p on the left; the A-action on the right results in multiplication on a on the right. These clearly give the same result. It is also clear that the resulting homomorphism is natural in M.

For (2), we need to check that for  $M = j_{[i]}^* F$ , the homomorphism  $\nu_{j_{[i]}^* F}$  agrees with the homomorphism coming from the adjunctions. The latter homomorphisms are

$$
A(e_0 + e_i) \otimes_{A_{[i]}} (e_0 + e_i) A \otimes F \to F
$$

given by

$$
p(e_0 + e_i) \otimes (e_0 + e_i) \otimes f \mapsto p(e_0 + e_i) \cdot f
$$

and

$$
F \to \text{Hom}_{A_{[i]}}(A, (e_0 + e_i)A \otimes_A F)
$$

given by

$$
p(e_0 + e_i) \cdot f \mapsto (a \mapsto (e_0 + e_i)ap(e_0 + e_i) \cdot f).
$$

The composite of these two clearly agrees with  $(1)$ .

For  $F \in A$ -mod, combining for different  $i \in I$  the homomorphisms from the adjunctions gives rise to canonical A-module homomorphisms

$$
\psi_F: \bigoplus_{i \in I} j_{[i]!}(j^*_{[i]}(F)) \to F
$$

and

$$
\phi_F: F \to \bigoplus_{i \in I} j_{[i]*}(j^*_{[i]}(F)),
$$

<span id="page-4-0"></span>which are natural in F. The following proposition will be crucial.

**Proposition 3.2.** For any  $F \in A$ -mod, the homomorphism  $\psi_F$  is surjective, while the homomorphism  $\phi_F$  is injective. In particular,

$$
F \cong \operatorname{im}(\phi_F \circ \psi_F),
$$

the image of the natural homomorphism  $\phi_F \circ \psi_F$ .

*Proof.* To show the surjectivity of  $\psi_F$ , let us begin with the case  $F = A \in A$ -mod. Write

(2) 
$$
\widetilde{A}_{[i]} := A(e_0 + e_i) \otimes_{A_{[i]}} (e_0 + e_i) A = j_{[i]!}(j_{[i]}^*(A))
$$

to simplify notation. Then the canonical left A-module homomorphism

$$
\Psi \coloneqq \psi_A : \bigoplus_{i \in I} j_{[i]!}(j_{[i]}^*(A)) = \bigoplus_{i \in I} \widetilde{A}_{[i]} \to A
$$

can be written in the following explicit form. Any element of the source module is a sum of terms of the form

$$
(p_{m_1}\otimes q_{m_1},\ldots,p_{m_k}\otimes q_{m_k})\in\bigoplus_{i\in I}\widetilde{A}_{[i]}.
$$

Then  $\Psi$  maps such an element to  $\sum_s p_{m_s} q_{m_s} \in A$  and extends this linearly.

For any  $a \in A$ ,

$$
(p_{m_1} \otimes q_{m_1}, \ldots, p_{m_k} \otimes q_{m_k})a = (p_{m_1} \otimes q_{m_1}a, \ldots, p_{m_k} \otimes q_{m_k}a)
$$

$$
\mapsto \sum_s p_{m_s}q_{m_s}a = \left(\sum_s p_{m_s}q_{m_s}\right)a.
$$

So  $\Psi$  is in fact a bimodule homomorphism.

To show the surjectivity of Ψ, consider the direct sum decomposition of the regular left module  $_A A = e_0 A \oplus \bigoplus_{i \in I} e_i A$ . Combine

$$
\begin{array}{c}\n e_j A & \rightarrow \\
 p & \mapsto \\
 (0, \ldots, 0, (e_0 + e_j) \otimes p, 0, \ldots, 0)\n \end{array}
$$

where  $(e_0 + e_j) \otimes p$  is at the j-th term of the target, with

$$
\begin{array}{c}\neq{0}A & \rightarrow\\
p & \mapsto \frac{1}{k}\left(\left(e_0 + e_{m_1}\right) \otimes p, \ldots, \left(e_0 + e_{m_k}\right) \otimes p\right)\n\end{array}
$$

to obtain a linear map

$$
\mathbf{P}:A\rightarrow \bigoplus_{i\in I}\widetilde{A}_{[i]}.
$$

For any  $a \in A$  and  $p \in e_iA$ , the product pa is also in  $e_iA$ . Hence,

$$
P(pa) = (0, ..., 0, (e_0 + e_j) \otimes pa, 0, ..., 0) = (0, ..., 0, (e_0 + e_j) \otimes p, 0, ..., 0)a = P(p)a.
$$

Similarly, for  $p \in e_0A$ 

$$
P(pa) = \frac{1}{k} ((e_0 + e_{m_1}) \otimes pa, ..., (e_0 + e_{m_k}) \otimes pa)
$$
  
=  $\frac{1}{k} ((e_0 + e_{m_1}) \otimes p, ..., (e_0 + e_{m_k}) \otimes p) a = P(p)a.$ 

Therefore P is a right A-module homomorphism. (We remark that it is not a A-bimodule homomorphism.) It is straightforward to check that  $\Psi \circ P$  is the identity of A. We deduce that  $\Psi$  is surjective as stated.

Next, for an arbitrary  $F \in A$ -mod, we have

$$
\bigoplus_{i\in I} j_{[i]!}(j_{[i]}^*(F)) = \bigoplus_{i\in I} A(e_0 + e_i) \otimes_{A_{[i]}} (e_0 + e_i)A \otimes_A F = \bigoplus_{i\in I} \widetilde{A}_{[i]} \otimes_A F
$$

and

$$
\psi_F = \Psi \otimes \mathrm{Id}_F : \bigoplus_{i \in I} \widetilde{A}_{[i]} \otimes_A F \to A \otimes_A F \cong F.
$$

As the functor  $-\otimes_A F$  is right exact, we deduce the surjectivity of  $\psi_F$  for a general F. Let us now consider  $\phi_F$ . The composition in the target can be written as

$$
\bigoplus_{i \in I} j_{[i]*}(j^*_{[i]}(F)) = \bigoplus_{i \in I} \text{Hom}_{A_{[i]}}(A, (e_0 + e_i)A \otimes_A F).
$$

In this language, the map  $\phi_F$  is the map

$$
\begin{array}{rcl}\n\phi_F: & F & \to & \bigoplus_{i\in I} \text{Hom}_{A_{[i]}}(A, (e_0 + e_i)A \otimes_A F) \\
f & \mapsto & (a \mapsto (e_0 + e_i)a \otimes f)_{i\in I}.\n\end{array}
$$

Let  $f \in F$  be such that

$$
\phi_F(f) = (a \mapsto (e_0 + e_i)a \otimes f)_{i \in I} = (0)_{i \in I}.
$$

Take  $a = e_j$  for  $j \in I \cup \{0\}$  to see that in this case  $e_j \otimes f = 0$  for each j. But because  ${e_j}_{j \in I \cup \{0\}}$  is a complete set of orthogonal idempotents of A, the sum  $\sum_j e_j \otimes f = 1 \otimes f = 0$ . This can only happen if  $f = 0$ . Thus  $\phi_F$  is injective as claimed.

3.2. Closed immersion into the product. We now apply Proposition [3.2](#page-4-0) to prove our key result about multigraded linear series. The projective morphisms

$$
\tau_{[i]}\colon \mathcal{M}(E)\to \mathcal{M}(E_{[i]})
$$

induce, by the universal property of the product, a projective morphism

$$
\tilde{\tau} \colon \mathcal{M}(E) \to \prod_{1 \leq i \leq n} \mathcal{M}(E_{[i]}).
$$

<span id="page-5-0"></span>**Theorem 3.3.** The morphism  $\tilde{\tau}$  induces a closed immersion on the reduced scheme underlying  $\mathcal{M}(E)$ .

Proof. Let

$$
X\subset \prod_{1\leq i\leq n} \mathcal{M}(E_{[i]})
$$

denote the reduced image of  $\tilde{\tau}$ . This is a closed subvariety as  $\tilde{\tau}$  is projective. We will show that X is indeed isomorphic to the reduced scheme underlying  $\mathcal{M}(E)$ .

For  $i \in I$ , consider the universal bundle

$$
T_{0,i}\oplus T_i
$$

on the fine moduli space  $\mathcal{M}(E_{[i]})$ , a sheaf of 0-generated  $A_{[i]}$ -modules. Applying Lemma [3.1](#page-3-2) (1) to this family, we get a morphism

$$
\tilde{\nu}_i \colon j_{[i]!}(T_{0,i} \oplus T_i) \to j_{[i]*}(T_{0,i} \oplus T_i),
$$

of sheaves of A-modules on  $\mathcal{M}(E_{[i]})$ .

Pulling these bundles and morphisms back to the product

$$
\prod_{1\leq i\leq n}\mathcal{M}(E_{[i]})
$$

and taking a direct sum, we get a morphism

$$
\widetilde{\nu} \colon \bigoplus_{1 \leq i \leq n} j_{[i]!}(T_{0,i} \oplus T_i) \to \bigoplus_{1 \leq i \leq n} j_{[i]*}(T_{0,i} \oplus T_i)
$$

of A-module bundles over  $\prod_{1 \leq i \leq n} \mathcal{M}(E_{[i]})$ , where we omit the pullback from the notation. Finally restrict this bundle morphism to the closed subscheme  $X \subset \prod_{1 \leq i \leq n} \mathcal{M}(E_{[i]})$  to get

$$
\widetilde{\nu}|_X \colon \bigoplus_{1 \leq i \leq n} j_{[i]!}(T_{0,i} \oplus T_i)|_X \to \bigoplus_{1 \leq i \leq n} j_{[i]*}(T_{0,i} \oplus T_i)|_X.
$$

Over a closed point  $p \in X$ , the fibres of

$$
\oplus_{1\leq i\leq n}(T_{0,i}\oplus T_i)|_X
$$

consist of a collection  ${F_{pi}}$  of 0-generated  $A_{[i]}$ -modules of dimension vector  $(1, \text{rk}(E_i))$ which come from some (not necessarily unique)  $0$ -generated A-module of dimension vector  $v = (\text{rk}(E_i))_{0 \le i \le n}$  under pullback. So by Lemma [3.1](#page-3-2) (2) and Proposition [3.2,](#page-4-0) over  $p \in X$ the morphism  $\widetilde{\nu}|_p$  has as image a A-module  $F_p$  which is of dimension vector v. In particular,  $F_p$  is the unique 0-generated A-module giving rise to the collection of modules  $\{F_{pi}\}\$ . We also deduce that the image sheaf Im  $\tilde{\nu}|_X$  is a family of 0-generated A-modules of dimension vector v. By the universal property of  $\mathcal{M}(E)$ , we then obtain a morphism

$$
\epsilon\colon X\to \mathcal{M}(E)
$$

which induces this family. By the uniqueness part of the argument just given,  $\epsilon \circ \tilde{\tau}$  is the identity on closed points of  $\mathcal{M}(E)$ . The map  $\tilde{\tau} \circ \epsilon$  is the identity of closed points on X by construction. Hence indeed X is isomorphic to the reduced subscheme underlying  $\mathcal{M}(E)$  as claimed.  $\Box$ 

More generally, let  $I_1, \ldots, I_l$  be a covering of the set  $\{0, \ldots, n\}$  such that each  $I_i$  contains 0. Again, the morphisms

$$
\tau_{\{0,\ldots,n\},I_i}: \mathcal{M}(E) \to \mathcal{M}(E_{I_i})
$$

induce a projective morphism

$$
\tau: \mathcal{M}(E) \to \prod_{i=1}^l \mathcal{M}(E_{I_l})
$$

**Corollary 3.4.** The morphism  $\tau$  induces a closed immersion on the reduced scheme underlying  $\mathcal{M}(E)$ .

<span id="page-6-0"></span>*Proof.* The morphism  $\tau$  factors through the morphism  $\tilde{\tau}$  of Theorem [3.3](#page-5-0) by [\[5,](#page-10-0) Proposition 3.3].

#### 4. Examples

4.1. Modules over the reconstruction algebra. Let  $\Gamma < GL(2,\mathbb{C})$  be a finite subgroup that acts without pseudo-reflections. Let  $\text{Irr}(G)$  denote the set of isomorphism classes of irreducible representations of G. There is a tautological bundle

$$
T = \bigoplus_{\rho \in \mathrm{Irr}(G)} T^{\oplus \dim(\rho)}_{\rho}
$$

on the corresponding G-Hilbert scheme, the fine module space of G-equivariant coherent sheaves of the form  $\mathcal{O}_Z$  for  $Z \subset \mathbb{A}^2$  such that  $\Gamma(\mathcal{O}_Z)$  is isomorphic to the regular representation of G. Each summand  $T_{\rho}$  of this bundle is globally generated. In this context, the trivial representation corresponds to the trivial line bundle.

Recall that an irreducible represenation  $\rho \in \text{Irr}(G)$  is called special if  $H^1(T_\rho^{\vee}) = 0$ . Performing cornering along the set

$$
Sp \coloneqq \{ \rho \in \text{Irr}(G) \mid \rho \text{ is special } \}
$$

one obtains the reconstruction bundle

$$
T_{\mathrm{Sp}}\coloneqq \sum_{\rho\in\mathrm{Sp}}T_{\rho}
$$

and the reconstruction algebra

$$
B \coloneqq \mathrm{End}(T_{\mathrm{Sp}}) = \mathrm{End}(T)_{\mathrm{Sp}} = e \mathrm{End}(T)e
$$

where  $e = \sum_{\rho \in \text{Sp}} e_{\rho}$ .

- **Theorem 4.1** ([\[5,](#page-10-0) Theorem 4.4]). (1) The minimal resolution of the quotient singularity  $A^2/\Gamma$  is isomorphic to the multigraded linear series  $\mathcal{M}(T_{\text{Sp}})$ . In particular,  $\mathcal{M}(T_{\text{Sp}})$  is reduced.
	- (2) All partial resolutions of **A** <sup>2</sup>/Γ which the minimal resolution factors through is of the form  $\mathcal{M}(T_I)$  for some  $I \subset$  Sp.

It is known that the set of invertible sheaves

$$
\{\det(T_{\rho}) \,|\, \rho \in \mathrm{Sp} \setminus \rho_0\}
$$

provides an integral basis of  $Pic(\mathcal{M}(T_{\text{Sp}}))$  dual to the curve classes defined by the irreducible components of the exceptional divisor. The cornering morphism

$$
\mathcal{M}(T_{\text{Sp}}) \to \mathcal{M}(T_{[\rho]})
$$

contracts every exceptional curve except for the one corresponding to  $\rho$ . In this setting, our Theorem [3.3](#page-5-0) implies that the product of the cornering morphisms gives a closed immersion

<span id="page-7-0"></span>Corollary 4.2. The product of the cornering morphisms

$$
\mathcal{M}(T_{\text{Sp}}) \to \prod_{\rho \in \text{Sp}\backslash \rho_0} \mathcal{M}(T_{[\rho]})
$$

is a closed immersion.

Remark 4.3. As the singularity  $\mathbb{A}^2/\Gamma$  is rational,

$$
h^1(\mathcal{M}(T_{[\rho]}), \mathcal{O}_{\mathcal{M}(T_{[\rho]})}) = h^1(\mathcal{M}(T_{\text{Sp}}), \mathcal{O}_{\mathcal{M}(T_{\text{Sp}})}) = 0.
$$

Therefore, by [\[7,](#page-10-4) Exercise III.12.6.]

$$
\mathrm{Pic}\left(\prod_{\rho\in \mathrm{Sp}\backslash\rho_0}\mathcal{M}(T_{[\rho]})\right)=\bigoplus_{\rho\in \mathrm{Sp}\backslash\rho_0}\mathrm{Pic}(\mathcal{M}(T_{[\rho]}))\simeq \mathrm{Pic}(\mathcal{M}(T_{\mathrm{Sp}})).
$$

4.2. Hilbert schemes of Kleinian orbifolds. Only in this subsection we work over the complex numbers. Let  $\Gamma < SL(2, \mathbb{C})$  be a finite subgroup. The McKay graph of  $\Gamma$  is defined to be the graph with vertex set  $\{0, 1, \ldots, r\}$  corresponding to the irreducible representations of Γ such that, for each  $0 \leq i, j \leq r$ , we have dim  $\text{Hom}_{\Gamma}(\rho_i, \rho_i \otimes V)$  edges joining vertices i and  $i$ . McKay [\[10\]](#page-10-5) observed that this graph is an extended Dynkin diagram of ADE type. The framed McKay graph of  $\Gamma$  is obtained by introducing an additional vertex, denoted  $\infty$ , together with an edge joining the vertices  $\infty$  and 0.

Associate the doubled quiver to the framed McKay graph. For this, consider the set of pairs  $Q_1$  comprising an edge in the framed McKay graph and an orientation of the edge. For each  $a \in Q_1$ , and we write  $t(a)$ ,  $h(a)$  for the vertices at the tail and head respectively of the oriented edge, and we write  $a^*$  for the same edge with the opposite orientation. The framed McKay quiver of Γ, denoted Q, is the quiver with vertex set  $Q_0 = \{\infty, 0, \ldots, r\}$  and arrow set  $Q_1$ .

Let  $\mathbb{C}Q$  denote the path algebra of the framed McKay quiver Q. For  $i \in Q_0$ , let  $e_i \in \mathbb{C}Q$ denote the idempotent corresponding to the trivial path at vertex i. Let  $\epsilon: Q_1 \to {\pm 1}$  be

any map such that  $\epsilon(a) \neq \epsilon(a^*)$  for all  $a \in Q_1$ . The preprojective algebra of Q, denoted  $\Pi$ , is defined as the quotient of **C**Q by the ideal

(3) 
$$
\left\langle \sum_{\mathrm{h}(a)=i} \epsilon(a) a a^* \mid i \in Q_0 \right\rangle.
$$

The preprojective algebra  $\Pi$  does not depend on the choice of the map  $\epsilon$ . For each  $i \in Q_0$ , we simply write  $e_i \in \Pi$  for the image of the corresponding vertex idempotent.

Let  $A = \Pi/(b^*)$  be the quotient by the two sided ideal  $(b^*)$ , where  $b^*$  is the unique arrow from 0 to  $\infty$ . In this context the vertex  $\infty$ , and not 0 will have the distinguished role; this labeling is for historical reasons as vertices  $\{0, \ldots, r\}$  correspond bijectively to the irreducible representations  $\{\rho_0, \ldots, \rho_r\}$  of  $\Gamma$ . Define the idempotent  $\overline{e}_I := e_\infty + \sum_{i \in I} e_i \in A$ . The subalgebra

$$
(4) \t\t A_I \coloneqq \overline{e}_I A \overline{e}_I
$$

of A comprises linear combinations of classes of paths in Q whose tails and heads lie in the set  $\{\infty\} \cup I$ .

Let  $I \subset \{0, \ldots, r\}$  be a non-empty subset, and let  $n = (n_{i_1, \ldots, i_{|I|}}) \in \mathbb{N}^I$  be a dimension vector. In [\[4,](#page-10-1) Section 3.2] the author with its coauthors constructed a Quot scheme parameterizing  $n$ -(multi)dimensional locally-free quotients of certain sheaves on the Kleinian orbifold  $[\mathbb{C}^2/\Gamma]$ . Denote this scheme by  $\text{Quot}_I^n([\mathbb{C}^2/\Gamma])$ . As a special case, for  $I = \{0, \ldots, r\}$ and any  $n \in \mathbb{N}^{r+1}$ 

$$
\operatorname{Quot}^n_I([\mathbb{C}^2/\Gamma])\cong \operatorname{Hilb}^n([\mathbb{C}^2/\Gamma])
$$

where

<span id="page-8-0"></span>(5) 
$$
\operatorname{Hilb}^n([\mathbb{C}^2/\Gamma]) = \left\{ J \in \operatorname{Hilb}(\mathbb{C}^2)^\Gamma \mid H^0(\mathcal{O}_{\mathbb{C}^2}/J) \cong \bigoplus_{i \in \{0, ..., r\}} \rho_i^{\oplus n_i} \right\},
$$

a component of the Γ-equivariant Hilbert scheme of the plane; see [\[4,](#page-10-1) Lemma 3.3].

Extend the vector n to  $(1, n) \in \mathbb{N} \oplus \mathbb{N}^I$  to get a dimension vector for  $A_I$ -modules, and consider the stability condition  $\eta_I : \mathbb{Z} \oplus \mathbb{Z}^I \to \mathbb{Q}$  given by

$$
\eta_I(\rho_i) = \begin{cases}\n-\sum_{j \in I} n_j & \text{for } i = \infty \\
1 & \text{if } i \in I\n\end{cases}
$$

The vector  $(1, n_I)$  is indivisible and  $n_I$  is a generic stability condition for  $A_I$ -modules of dimension vector  $(1, n_I)$ , so there is a fine moduli space  $\mathcal{M}_{A_I}(1, n_I)$  of  $\eta_I$ -stable  $A_I$ -modules of dimension vector  $(1, n_I)$ . Let  $T_I := \bigoplus_{i \in \{\infty\} \cup I} T_i$  denote the tautological vector bundle on  $\mathcal{M}_{A_I}(1, n_I)$ , where  $T_\infty$  is the trivial bundle and  $T_i$  has rank  $n_i$  for  $i \in I$ . This setting is exactly the situation of Section [2.](#page-1-0)

**Proposition 4.4** ([\[4,](#page-10-1) Proposition 4.2]). For any non-empty subset  $I \subseteq \{0, ..., r\}$  and  $n \in \mathbb{N}^I$ , there is an isomorphism of schemes

$$
\operatorname{Quot}^{n_I}_I([\mathbb{C}^2/\Gamma]) \longrightarrow \mathcal{M}_{A_I}(1,n_I).
$$

Therefore, for each nonempty  $I \subset \{0, \ldots, r\}$  there is a cornering morphism

$$
\operatorname{Hilb}^n([\mathbb{C}^2/\Gamma]) \to \operatorname{Quot}^{n_I}_I([\mathbb{C}^2/\Gamma])
$$

where  $n_I = n|_I$ , the restriction of n to the indicies contained in I.

**Example 4.5.** For  $I = \{0\}$  and  $n_0 \in \mathbb{N}$ ,

$$
\mathrm{Quot}^{n_0}_I([\mathbb{C}^2/\Gamma]) \cong \mathrm{Hilb}^{n_0}(\mathbb{C}^2/\Gamma),
$$

the Hilbert scheme of  $n_0$  points on the quotient singularity  $\mathbb{C}^2/\Gamma$ . Then for any  $n \in \mathbb{N}^{r+1}$ the cornering morphism

$$
\operatorname{Hilb}^n([\mathbb{C}^2/\Gamma]) \to \operatorname{Hilb}^{n_0}(\mathbb{C}^2/\Gamma)
$$

can be identified with the map

 $J \mapsto J^{\Gamma}$

under the description [\(5\)](#page-8-0). This map is a resolution of singularities by [\[3\]](#page-10-6) if  $n = n_0 \cdot \rho_{req}$ with  $\rho_{reg}$  the regular representation of Γ.

More generally, for a singleton  $I = \{i\}$  with  $i \in \{0, \ldots, r\}$  the map

$$
\operatorname{Hilb} ^n ([\mathbb{C}^2/\Gamma]) \to \operatorname{Quot} ^{n_i}_i ([\mathbb{C}^2/\Gamma])
$$

can be described as the projection

$$
J\rightarrow J^{\rho_i},
$$

where  $J^{\rho_i}$  is the  $\rho_i$ -isotypic part of J. When  $\dim(\rho_i) = 1$ , there is yet another geometric description of the target as a Quot scheme of a certain sheaf on the quotient singularity  $\mathbb{C}^2/\Gamma$ ; for the details see [\[4,](#page-10-1) Proposition 3.4].

<span id="page-9-0"></span>**Corollary 4.6.** Let  $I_1, \ldots, I_l$  be a covering of the set  $\{0, \ldots, r\}$  and  $n \in \mathbb{N}^{r+1}$ . The product of the cornering morphisms induces a closed immersion

$$
\operatorname{Hilb}^n([\mathbb{C}^2/\Gamma]) \to \prod_{i=1}^l \operatorname{Quot}_{I_i}^{n_{I_i}}([\mathbb{C}^2/\Gamma])
$$

4.3. Grassmannian. Let V be an *n*-dimensional vector space. Denote by  $\text{Gr}(n, r)$  the Grassmannian of r-dimensional quotients of  $V$ . Let  $W$  be the rank r tautological quotient bundle on  $\text{Gr}(n, r)$ . Denote by  $\text{Young}(n - r, r) \subset \mathbb{Z}^r$  the set of partitions  $\lambda = (n - r \geq 1)$  $\lambda_1 \geq \cdots \geq \lambda_r \geq 0$  and write  $S^{\lambda}W$  for the vector bundle whose fibre over each point is the irreducible  $GL(r)$ -module of highest weight  $\lambda$ . Kapranov [\[8\]](#page-10-2) proved that the vector bundle

$$
E := \bigoplus_{M \in \text{Young}(n-r,r)} S^{\lambda} W
$$

is a tilting bundle on  $\text{Gr}(n, r)$ . The trivial partition  $\lambda_1 = \cdots = \lambda_r = 0$  corresponds to the trivial summand  $\mathcal{O}_{\mathrm{Gr}(n,r)}$  of E. Let

$$
Young'(n-r,r) := Young(n-r,r) \setminus \{0\}.
$$

In [\[1\]](#page-10-7) a quiver Q and a surjective k-algebra homomorphism  $\mathbb{k}Q \to A = \text{End}(E)$  was constructed. Let  $E_0, \ldots, E_m$  denote the summands of the tilting bundle E with  $E_0 =$  $\mathcal{O}_{\mathrm{Gr}(n,k)}$  and let  $v = (v_i)$  be the dimension vector given by  $v_i = \mathrm{rank}(E_i)$ . The tautological quotient bundle W is globally generated by  $[2, Corollary 3.5(i)]$ , and hence so is every indecomposable summand  $E_i$  of E. Therefore, we can apply the construction from Section [2.](#page-1-0) Denote by  $\mathcal{M}(E) := \mathcal{M}(A, v, \theta)$  the corresponding multigraded linear series and by

$$
f_E: \operatorname{Gr}(n,r) \to \mathcal{M}(E)
$$

<span id="page-9-2"></span>the universal morphism.

**Lemma 4.7.** The morphism  $f_E: Gr(n,r) \to \mathcal{M}(E)$  is a closed immersion.

*Proof.* The proof is a generalisation of [\[6,](#page-10-9) Proposition 4.1]. As every indecomposable summand  $E_i$  of E is globally generated, the same is true for each det( $E_i$ ). By [\[2,](#page-10-8) Lemma 3.7] the line bundle  $\det(W)$  is ample. Hence the line bundle  $\bigotimes_{0 \leq j \leq m} \det(E_j)$ , which is a tensor product of  $\det(W)$  and other globally generated bundles, is also ample by [\[7,](#page-10-4) Exercise II.7.5(d)]. The result now follows from [\[5,](#page-10-0) Theorem 2.6].

**Theorem 4.8** ([\[6,](#page-10-9) Theorem 4.2]). The closed immersion  $Gr(n, 2) \rightarrow \mathcal{M}(n, 2)$  is an isomorphism.

For any nontrivial partition  $\lambda \in \text{Young}'(n-r,r)$  let

$$
E_{[\lambda]} := \mathcal{O}_{\mathrm{Gr}(n,k)} \oplus S^{\lambda}W.
$$

<span id="page-9-1"></span>Corollary 4.9. There exists a closed immersion

$$
\operatorname{Gr}(n,r) \to \prod_{\lambda \in \operatorname{Young}'(n-r,r)} \mathcal{M}(E_{[\lambda]}).
$$

Proof. The cornering morphisms

$$
\mathcal{M}(E) \to \mathcal{M}(E_{[\lambda]}),
$$

by Theorem [3.3,](#page-5-0) induce (on the underlying reduced scheme) a closed immersion

$$
\mathcal{M}(E) \to \prod_{\lambda \in \text{Young}'(n-r,r)} \mathcal{M}(E_{[\lambda]}).
$$

Precomposing this with the morphism  $f_E$  from Lemma [4.7](#page-9-2) and taking into account that  $Gr(n, r)$  is reduced we obtain the claim.

Let 1 denote the partition  $\lambda_1 = 1, \lambda_2 = \cdots = \lambda_r = 0$ . As  $H^0(E_1) = H^0(W) = V$ ,

$$
\mathcal{M}(E_{[1]}) = \mathrm{Gr}(n,r)
$$

by [\[5,](#page-10-0) Example 2.7].
