# SUSPENSION HOMOTOPY OF $(n-1)$-CONNECTED $(2 n+2)$-DIMENSIONAL POINCARÉ DUALITY COMPLEXES

#### Abstract

We study the homotopy decompositions of the suspension $\Sigma M$ of an $(n-1)$-connected $(2 n+2)$ dimensional Poincaré duality complex $M, n \geq 2$. In particular, we completely determine the homotopy types of $\Sigma M$ of a simply-connected orientable closed (smooth) 6 -manifold $M$, whose integral homology groups can have 2 -torsion. If $3 \leq n \leq 5$, we obtain homotopy decompositions of $\Sigma M$ after localization away from 2 .

## 1. Introduction

In [24] So and Theriault found that the homotopy decomposition of the (double) suspension space of manifolds have directly or implicitly applications to important concepts in geometry and physics, such as topological $K$-theory, gauge groups and current groups. Since them, the topic of suspension homotopy of manifolds becomes popular, such as $[9,12,13,14,15,19]$. As can be seen in these papers, the 2-torsion of the homology groups of the given manifolds usually causes great obstruction to obtain a complete characterization of the homotopy decomposition of the (double) suspension.

This paper contributes to the suspension homotopy type of Poincaré duality complexes, which are connected CW-complexes whose integral cohomology satisfying the Poincaré duality theorem. Let $M$ be an $(n-1)$-connected

[^0]$(2 n+2)$ dimensional Poincaré duality complex, $n \geq 2$. By Poincaré duality, the integral homology groups $H_{*}(M)$ is given by

where $T=T_{2} \oplus T_{\neq 2}$ and $T_{2}=\oplus_{i=1}^{t_{2}} \mathbb{Z} / 2^{r_{i}}$ is the 2-primary component. When $M$ is a simply-connected orientable closed (smooth) 6-manifold, Huang [12] firstly determined the homotopy type of the double suspension $\Sigma^{2} M$ under the assumption that $T$ contains no 2 - or 3 -torsions, while Cutler and So [9] obtained the homotopy decompositions of $\Sigma M$ after localization away from 2. Our first main theorem (Theorem 1.1 below) gives a complete characterization of the homotopy types of $\Sigma M$, for which the 2 -torsion $T_{2}$ can be non-zero. The new and key point is that we use the second JamesHopf invariant to prove that the attaching map of the top cell of the given 6 -manifold is a suspension map and contains no Whitehead products, see Proposition 4.2.

To state our main results, we need the following stable cohomology operations. For each prime $p$ and integer $r \geq 1$, there are the higher order Bocksteins $\beta_{r}$ which detects the degree $2^{r}$ map on spheres $S^{n}$. For each $n \geq 2$, there are secondary cohomology operations

detecting the map $\eta^{2} \in \pi_{n+2}\left(S^{n}\right)$, where

That is, $\Theta_{n}$ is based on the null-homotopy of the composition

where $K_{m}=K(\mathbb{Z} / 2, m)$ denotes the Eilenberg-MacLane space of type $(\mathbb{Z} / 2, m)$. The map $\eta^{3}$ can be detected by the tertiary operation $\mathbb{T}$, see [10, Exercise 4.2.5]. For $m \geq 3$, let $\alpha_{1}(m)=\Sigma^{m-3} \alpha_{1}(3): S^{m+3} \rightarrow S^{m}$ be the generator of the 3 -primary component of $\pi_{m+3}\left(S^{m}\right)$. Denote by $\tilde{\alpha}_{1}(m)$ the possible lift (if exists) of $\alpha_{1}(m)$ to $P^{m}\left(3^{r}\right)$; i.e., $q_{m} \circ \tilde{\alpha}_{1}(m)=\alpha_{1}(m)$. See [20, Lemma 2.6] or [26, Chapter XIII] with $p=3$. Note that $\alpha_{1}(m)$ and $\tilde{\alpha}_{1}(m)$ can be detected by the first reduced Steenrod power operation (cf. [10, Chapter 1.5.5]).

We also need the following notations. For a finitely generated group $G$ and an integer $n \geq 2$, denote by $P^{n}(G)$ the $n$-dimensional Peterson space which is characterized by its unique non-trivial reduced integral cohomology group $G$ in dimension $n$. For $n, k \geq 2$, denote by $P^{n}(k)=P^{n}(\mathbb{Z} / k)$ the Moore space of homotopy type $(\mathbb{Z} / k, n-1)$ and $\mathbb{Z} / k$ is the group of integers mod $k$. There is a canonical homotopy cofibration

S^{n-1} \xrightarrow{k} S^{n-1} \xrightarrow{i_{n-1}} P^{n}(k) \xrightarrow{q_{n}} S^{m},

where $t$ is the degree $t$ map, $i_{n-1}$ and $q_{n}$ are the canonical inclusion and pinch maps, respectively. We shall also use the following elementary Changcomplexes (due to Chang [5]) with $n \geq 2, r \geq 1$ :

which admit the folloing homotopy cofibrations (cf. [29])

where $i_{m}: S^{m} \rightarrow Y$ and $q_{m}: X \rightarrow S^{m}$ respectively denote the appropriate inclusion and pinch maps for different complexes $X, Y ; i_{P}, i_{\eta}$ are the canonical inclusion into $C_{r}^{n+2}$.

Now it is prepared to state the first main theorem.
Theorem 1.1. Let $M$ be a simply-connected closed 6 -manifold with $H_{*}(M)$ given by (1), $n=2$. Let $\omega_{2}(M)$ be the second Stiefel-Whitney class of $M$. Let $T\left[c_{2}\right]=T / \oplus_{j=1}^{c_{2}} \mathbb{Z} / 2^{r_{j}}$. There exist integers $0 \leq c_{1} \leq l, 0 \leq c_{2} \leq t_{2}$ such that $0 \leq c_{1}+c_{2} \leq l$, and $c_{1}=c_{2}=0$ if and only if the Steenrod square $\mathrm{Sq}^{2}$ acts trivially on $H^{2}(M ; \mathbb{Z} / 2)$.

1. Suppose that $\omega_{2}(M)=0$, then the possible homotopy types of $\Sigma M$ can be distinguished by the the secondary operation $\Theta$ :
(a) If $\Theta$ acts trivially on $H^{3}(M ; \mathbb{Z} / 2)$, then there is a homotopy equivalence

where $\epsilon \in\{0,1\}$, and $\epsilon=0$ if the tertiary operation $\mathbb{T}$ acts trivially on $H^{2}(M ; \mathbb{Z} / 2)$ or $l=c_{1}=1$.
(b) If for any $u, v \in H^{4}(\Sigma M ; \mathbb{Z} / 2)$ with $\Theta(u) \neq 0, \Theta(v)=0$, there holds $u+v \notin \operatorname{im}\left(\beta_{s}\right)$ for any $s \geq 1$; while there exist $u^{\prime}, v^{\prime} \in H^{4}(\Sigma M ; \mathbb{Z} / 2)$ such that $\Theta\left(u^{\prime}\right) \neq 0, \Theta\left(v^{\prime}\right)=0$ and $\beta_{r}\left(u^{\prime}+v^{\prime}\right) \neq 0$, then there is a homotopy equivalence

& \vee\left(\bigvee_{i=1}^{c_{1}} C_{\eta}^{5}\right) \vee P^{5}\left(\frac{T}{\mathbb{Z} / 2^{r_{j_{1}}}}\right) \vee\left(P^{5}\left(2^{r_{j_{1}}}\right) \cup_{i_{4} \eta^{2}} e^{7}\right),
\end{aligned}

where $r_{j_{1}}$ is the maximum of $r_{j}$ such that $\beta_{r_{j}}\left(u^{\prime}+v^{\prime}\right) \neq 0$.
(c) If there exist $u \in H^{4}(\Sigma M ; \mathbb{Z} / 2)$ with $\Theta(u) \neq 0$ and $v \in \operatorname{ker}(\Theta)$ such that $u+v \in \operatorname{im}\left(\beta_{r}\right)$ for some $r$, then there is a homotopy equivalence

\Sigma M \simeq\left(\bigvee_{i=1}^{d} S^{4}\right) \vee P^{5}(T) \vee\left(\bigvee_{i=1}^{l-c_{1}} S^{3}\right) \vee\left(\bigvee_{i=1}^{l-c_{1}-c_{2}} S^{5}\right) \vee\left(\bigvee_{i=1}^{c_{1}} C_{\eta}^{5}\right) \vee\left(\bigvee_{j=1}^{c_{2}} C_{r_{j}}^{5}\right) \\
\vee P^{4}\left(\frac{T\left[c_{2}\right]}{\left.\mathbb{Z} / 2^{r_{j_{2}}}\right)} \mathrm{V}^{2}\left(P^{4}\left(2^{r_{j_{2}}}\right) \cup_{\tilde{\eta}_{r_{j_{2}}} \eta} e^{7}\right),\right. \text { or } \\
\Sigma M \simeq\left(\bigvee_{i=1}^{d} S^{4}\right) \vee P^{5}(T) \vee\left(\bigvee_{i=1}^{l-c_{1}} S^{3}\right) \vee\left(\bigvee_{i=1}^{l-c_{1}-c_{2}} S^{5}\right) \vee\left(\bigvee_{i=1}^{c_{1}} C_{\eta}^{5}\right) \\
\vee P^{4}\left(T\left[c_{2}\right]\right) \vee\left(\bigvee_{j_{1} \neq j=1}^{c_{2}} C_{r_{j}}^{5}\right) \vee\left(C_{r_{j_{2}}}^{5} \cup_{i_{P} \tilde{\eta}_{r_{j_{2}}} \eta} e^{7}\right),
\end{gathered}
$$

where $r_{j_{2}}$ is the minimum of $r_{j}$ such that $u+v \in \operatorname{im}\left(\beta_{r_{i}}\right)$. The second possibility doesn't exist if $l=c_{1}=1$.
2. Suppose that $\omega_{2}(M) \neq 0$, then $\Sigma M$ has the following possible homotopy decompositions:
(a) If for any $u \in H^{5}(\Sigma M ; \mathbb{Z} / 2)$ with $\operatorname{Sq}^{2}(u) \neq 0$ and any $v \in \operatorname{ker}\left(S q^{2}\right)$, there hold $u+v \notin \operatorname{im}\left(\beta_{r}\right)$ for any $r \geq 1$, then there is a homotopy equivalence

\Sigma M \simeq\left(\bigvee_{i=1}^{d} S^{4}\right) \vee P^{5}(T) \vee\left(\bigvee_{i=1}^{l-c_{1}} S^{3}\right) \vee & \left(\bigvee_{i=2}^{l-c_{1}-c_{2}} S^{5}\right) \vee\left(\bigvee_{i=1}^{c_{1}} C_{\eta}^{5}\right) \\
& \vee P^{4}\left(T\left[c_{2}\right]\right) \vee\left(\bigvee_{j=1}^{c_{2}} C_{r_{j}}^{5}\right) \vee C_{\eta}^{7}
\end{aligned}

(b) If there exist $u \in H^{5}(\Sigma M ; \mathbb{Z} / 2)$ with $\operatorname{Sq}^{2}(u) \neq 0, v \in \operatorname{ker}\left(\mathrm{Sq}^{2}\right)$ such that $u+v \in \operatorname{im}\left(\beta_{r_{i}}\right)$ for some $r_{i}$, then there is a homotopy equivalence

\Sigma M \simeq\left(\bigvee_{i=1}^{d} S^{4}\right) \vee P^{5}\left(\frac{T}{\mathbb{Z} / 2^{r_{i_{1}}}}\right) \vee\left(\bigvee_{i=1}^{l-c_{1}} S^{3}\right) \vee\left(\bigvee_{i=1}^{l-c_{1}-c_{2}} S^{5}\right) \vee\left(\bigvee_{i=1}^{c_{1}} C_{\eta}^{5}\right) \\
\left.\vee P^{4}\left(T\left[c_{2}\right]\right) \vee\left(\bigvee_{j=1}^{c_{2}} C_{r_{j}}^{5}\right) \vee\left(P^{5}\left(2^{r_{i_{1}}}\right) \cup_{\tilde{\eta}_{r_{i_{1}}}} e^{7}\right)\right)
\end{aligned}

where $r_{i_{1}}$ is the minimum of $r_{i}$ such that $u+v \in \operatorname{im}\left(\beta_{r_{i}}\right)$.
Remark 1.2. Although we list all the possibilities of homotopy types of $\Sigma M$ of the given 6 -manifolds, we cannot guarantee that all possibilities could happen and one could find a 6-manifold as an illustrating example. This is partially due to our lack of knowledge about manifolds. On Theorem 1.1, we also make the following remarks.
(1) $\omega_{2}(M)=v_{2}(M)$ (the second Wu class [21, page 132]) is a homotopy invariant for orientable topological 6-manifolds and does not depend on the smooth structure on $M$. When $M$ is smooth, $\omega_{2}(M)=0$ if and only if $M$ is spin.
(2) If $l=1$, then $\left(c_{1}, c_{2}\right) \in\{(0,0),(0,1),(1,0)\}$ can be determined by the action of the Steenrod square on $H^{2}(M ; \mathbb{Z} / 2)$, see Proposition 3.4 (3).
(3) Convention: Wedge summands like $\bigvee_{i=k}^{m} X_{i}$ with $k>m$ should be viewed as a point and can be removed.

Denote by $X \simeq_{\left(\frac{1}{2}\right)} Y$ if the spaces $X$ and $Y$ have the same homotopy type after localization away from 2. The following immediate corollary is an improvement of [9, Theorem 1.1].

Corollary 1.3. Let $M$ be a simply-connected 6-manifold as in Theorem 1.1. Then there is a homotopy equivalence

\Sigma M \simeq_{\left(\frac{1}{2}\right)}\left(\bigvee_{i=1}^{d} S^{4}\right) \vee\left(\bigvee_{i=1}^{l}\left(S^{3} \vee S^{5}\right)\right) \vee P^{4}(T) \vee P^{5}(T) \vee S^{7}
$$

For $n=3,4,5$, we have the following results on the homotopy types of the suspension of manifolds after localization away from 2 .

Theorem 1.4. Let $M$ be a 2 -connected 8 dimensional Poincaré duality complex with $H_{*}(M)$ given by (1), $n=3$.

1. Suppose $\mathcal{P}^{1}\left(H^{4}(M ; \mathbb{Z} / 3)\right)=0$, then there is a homotopy equivalence

\Sigma M \simeq{ }_{\left(\frac{1}{2}\right)}\left(\bigvee_{i=1}^{l}\left(S^{4} \vee S^{6}\right)\right) \vee\left(\bigvee_{i=1}^{d} S^{5}\right) \vee P^{5}(T) \vee P^{6}(T) \vee S^{9}
$$

2. Suppose $\mathcal{P}^{1}\left(H^{4}(M ; \mathbb{Z} / 3)\right) \neq 0$, then the homotopy type of $\Sigma M$ can be distinguished by the higher order Bockstein $\beta_{r}$ :
(a) If for any $u \in H^{5}(\Sigma M ; \mathbb{Z} / 3)$ with $\mathcal{P}^{1}(u) \neq 0$ and any $v \in \operatorname{ker}\left(\mathcal{P}^{1}\right)$, there hold $\beta_{r}(u+v)=0, \quad u+v \notin \operatorname{im}\left(\beta_{s}\right)$ for any $r, s \geq 1$, then there is a homotopy equivalence
$\Sigma M \simeq_{\left(\frac{1}{2}\right)}\left(\bigvee_{i=1}^{l}\left(S^{4} \vee S^{6}\right)\right) \vee\left(\bigvee_{i=2}^{d} S^{5}\right) \vee P^{5}(T) \vee P^{6}(T) \vee\left(S^{5} \cup_{\alpha_{1}(5)} e^{9}\right)$.
(b) If there exist $u \in H^{5}(\Sigma M ; \mathbb{Z} / 3)$ with $\mathcal{P}^{1}(u) \neq 0$ and $v \in \operatorname{ker}\left(\mathcal{P}^{1}\right)$ such that $u+v \in \operatorname{im}\left(\beta_{r}\right)$ for some $r$, then there is a homotopy equivalence
$\Sigma M \simeq_{\left(\frac{1}{2}\right)}\left(\bigvee_{i=1}^{l}\left(S^{4} \vee S^{6}\right)\right) \vee\left(\bigvee_{i=2}^{d} S^{5}\right) \vee P^{5}\left(\frac{T}{\mathbb{Z} / 3^{r_{j_{1}}}}\right) \vee P^{6}(T) \vee\left(P^{5}\left(3^{r_{j_{1}}}\right) \cup_{\tilde{\alpha}_{1}(5)} e^{9}\right)$,
where $r_{j_{1}}$ is the minimum of $r_{j}$ such that $u+v \in \operatorname{im}\left(\beta_{r_{j}}\right)$.
(c) If for any $u \in H^{5}(\Sigma M ; \mathbb{Z} / 3)$ with $\mathcal{P}^{1}(u) \neq 0$ and any $v \in \operatorname{ker}\left(\mathcal{P}^{1}\right)$, there hold $u+v \notin \operatorname{im}\left(\beta_{s}\right)$ for any $s \geq 1$, while there exist $u^{\prime} \in$ $H^{5}(\Sigma M ; \mathbb{Z} / 3)$ with $\mathcal{P}^{1}\left(u^{\prime}\right) \neq 0$ and $v^{\prime} \in \operatorname{ker}\left(\mathcal{P}^{1}\right)$ such that $\beta_{r}\left(u^{\prime}+\right.$ $\left.v^{\prime}\right) \neq 0$ for some $r \geq 1$, then there is a homotopy equivalence
$\Sigma M \simeq_{\left(\frac{1}{2}\right)}\left(\bigvee_{i=1}^{l}\left(S^{4} \vee S^{6}\right)\right) \vee\left(\bigvee_{i=2}^{d} S^{5}\right) \vee P^{5}(T) \vee P^{6}\left(\frac{T}{\mathbb{Z} / 3^{r_{j_{2}}}}\right) \vee\left(P^{6}\left(3^{r_{j_{2}}}\right) \cup_{i_{5} \alpha_{1}(5)} e^{9}\right)$,
where $r_{j_{2}}$ is the maximum of $r_{j}$ such that $\beta_{r_{j}}\left(u^{\prime}+v^{\prime}\right) \neq 0$.

Theorem 1.5. Let $M$ be a 3-connected 10 dimensional Poincaré duality complex with $H_{*}(M)$ given by (1), $n=4$. If $\mathcal{P}^{1}$ acts trivially on $H^{6}(M ; \mathbb{Z} / 3)$, then there is a homotopy equivalence

\Sigma M \simeq \simeq_{\left(\frac{1}{2}\right)}\left(\bigvee_{i=1}^{l}\left(S^{5} \vee S^{7}\right)\right) \vee\left(\bigvee_{i=1}^{d} S^{6}\right) \vee P^{6}(T) \vee P^{7}(T) \vee S^{11}
$$

otherwise there is a homotopy equivalence

$$
\Sigma M \simeq{ }_{\left(\frac{1}{2}\right)}\left(\bigvee_{i=1}^{l}\left(S^{5} \vee S^{7}\right)\right) \vee\left(\bigvee_{i=1}^{d} S^{6}\right) \vee P^{6}(T) \vee P^{7}\left(\frac{T}{\mathbb{Z} / 3^{r_{j_{1}}}}\right) \vee\left(P^{7}\left(3^{r_{j_{1}}}\right) \cup_{\tilde{\alpha}_{1}(7)} e^{11}\right)
$$

where $r_{j_{1}}$ is the minimum of $r_{j}$ such that $\mathcal{P}^{1}(u+v) \neq 0, u+v \in \operatorname{im}\left(\beta_{r_{j}}\right)$ for some $u \in H^{7}(\Sigma M ; \mathbb{Z} / 3)$ and $v \in \operatorname{ker}\left(\mathcal{P}^{1}\right)$.

Theorem 1.6. Let $M$ be a 4-connected 12 dimensional Poincaré duality complex with $H_{*}(M)$ given by (1), $n=5$. There is a homotopy equivalence

$$

The basis method to study the homotopy type of $\Sigma M$ is the homology decomposition. In the cases $2 \leq n \leq 5$, we only need to solve the obstruction caused by the 2 - and 3 -torsions of $H_{*}(M)$. For $n=4,5$, the results and discussions are similar to but easier than that in the case $n=3$, so we omit their proofs here. If $n=6$, there hold isomorphisms

$$
\pi_{13}\left(P^{7}\left(p^{r}\right)\right) \cong \pi_{14}\left(P^{8}\left(p^{r}\right)\right) \cong \mathbb{Z} /\left(15, p^{r}\right)
$$

It follows that in general the reduced Steenrod 3-th power $\mathcal{P}^{1}$, together with the Bocksteins $\beta_{r}$, is not enough to characterize the homotopy decomposition of the suspension of a $(n-1)$-connected $(2 n+2)$ dimensional Poincaré duality complex for $n \geq 6$.

The paper is arranged as follows. In Section 2 we compute some homotopy groups of some elementary complexes and list some lemmas on cohomology operations. In Section 3 we determine the homotopy type of the $(2 n+1)$ th homology section of the Poincaré duality complex $M$. Section 4 and Section 5 cover the proof of Theorem 1.1 and Theorem 1.4, respectively. In Section 6 we compute the homomorphisms induced by the second JamesHopf invariant on the 6 -th homotopy groups of the wedge sum of some elementary complexes, which play essential role in Section 4.

## 2. Preliminaries

Throughout the paper all spaces are based CW-complexes, all maps are base-point-preserving and are identified with their homotopy classes in notation. For an abelian group $G$ generated by $x_{1}, \cdots, x_{n}$, we use the notation

to indicate $x_{i}$ is a generator of the cyclic direct summand $C_{i}, i=1, \cdots, n$. For a prime $p$, denote by $\pi_{i}(X ; p)$ the $p$-primary component of the $i$-th homotopy group $\pi_{i}(X)$.
2.1. Some homotopy groups of elementary complexes. We will frequently use the followings (cf. [26]):

Lemma 2.1 (cf. [4]). Let $n \geq 3, r \geq 1$ be integers and let $p$ be a prime. The followings hold:
(1) $\pi_{n}\left(P^{n+1}\left(p^{r}\right)\right) \cong \mathbb{Z} / p^{r}\left\langle i_{n}\right\rangle$.
(2) $\pi_{n+1}\left(P^{n+1}\left(p^{r}\right)\right) \cong \begin{cases}\mathbb{Z} / 2\left\langle i_{n} \eta\right\rangle, & p=2 ; \\ 0, & p \geq 3 .\end{cases}$
(3) $\pi_{n+2}\left(P^{n+1}\left(p^{r}\right)\right) \cong \begin{cases}\mathbb{Z} / 4\left\langle\tilde{\eta}_{1}\right\rangle, & p=2, r=1 ; \\ \mathbb{Z} / 2 \oplus \mathbb{Z} / 2\left\langle\tilde{\eta}_{r}, i_{n} \eta^{2}\right\rangle, & p=2, r \geq 2 ; \\ 0, & p \geq 3 .\end{cases}$

The generator $\tilde{\eta}_{r}$ satisfies formulas

The homotopy fibration $F^{4}\left\{2^{r}\right\} \xrightarrow{j_{r}} P^{4}\left(2^{r}\right) \xrightarrow{q_{4}} S^{4}$ indicates the inclusion $i_{3}: S^{3} \rightarrow P^{4}\left(2^{r}\right)$ factors as $S^{3} \xrightarrow{\imath_{r}} F^{4}\left\{2^{r}\right\} \xrightarrow{j_{r}} P^{4}\left(2^{r}\right)$. From [28, Section 3.1], there is a canonical map $\lambda_{r}: S^{6} \rightarrow F^{4}\left\{2^{r}\right\}$, which is the skeletal inclusion map up to a homotopy equivalence.

Lemma 2.2 (cf. [28]). Let $r \geq 1$. There hold isomorphisms
(1) $\pi_{6}\left(P^{4}\left(2^{r}\right)\right) \cong \mathbb{Z} / 2^{\varrho_{r}}\left\langle j_{r} \lambda_{r}\right\rangle \oplus \mathbb{Z} / 2^{1-\delta_{r}}\left\langle i_{3} \nu^{\prime}\right\rangle \oplus \mathbb{Z} / 2\left\langle\tilde{\eta}_{r} \eta\right\rangle$, where $\varrho_{r}=$ $r+1$ for $r=1,2$, and $\varrho_{r}=r$ for $r \geq 3$.
(2) $\pi_{7}\left(P^{5}\left(2^{r}\right)\right) \cong \mathbb{Z} / 2^{r+1} \oplus \mathbb{Z} / 2^{\min (r-1,2)} \oplus \mathbb{Z} / 2\left\langle i_{4} \nu_{4}, i_{4}\left(\Sigma \nu^{\prime}\right), \tilde{\eta}_{r} \eta\right\rangle$; it follows that $j_{r} \lambda_{r}$ in (1) is not a suspension element.

From [22, Proposition 8.2 (1)] and computations in [28] we have
Lemma 2.3. There hold isomorphisms
(1) $\pi_{6}\left(C_{\eta}^{5}\right) \cong \mathbb{Z} / 6\left\langle i_{3} \nu^{\prime}\right\rangle ; i_{3} \alpha_{1}(3)=2 i_{3} \nu^{\prime}$.
(2) $\pi_{6}\left(C_{r}^{5}\right) \cong \mathbb{Z} / 2^{r+\delta_{r}}\left\langle i_{P} j_{r} \lambda_{r}\right\rangle \oplus \mathbb{Z} / 2^{1-\delta_{r}}\left\langle i_{3} \nu^{\prime}\right\rangle \oplus \mathbb{Z} / 2\left\langle i_{P} \tilde{\eta}_{r} \eta\right\rangle$.

The following Lemma can be found in [18, Theorem 3.1, (2)]; since it hasn't been published yet, we give it a proof here.
Lemma 2.4. Let $n \geq 3$. There exists a map $\bar{\zeta}: C_{\eta}^{n+2} \rightarrow S^{n}$ satisfying

It follows that for $r \leq s$, there exists a map $\alpha_{s}^{r}: C_{r}^{n+2} \rightarrow C_{s}^{n+2}$, which is the identity map for $r=s$ and is $i_{P} B\left(\chi_{s}^{r+1}\right) \bar{\xi}$ for $r<s$ such that

(2) By (7) the first square in the Lemma is homotopy commutative, and hence the map $\bar{\xi}_{r}$ in the Lemma exists. Recall we have the composition

for some $\varepsilon \in\{0,1\}$. If $\varepsilon=0$, we are done; otherwise we replace $\bar{\xi}_{r}$ by $\bar{\xi}_{r}+i_{n} \eta q_{n+1}$ to make $\varepsilon=0$. Note that all the relations mentioned above still hold even if we make such a replacement.

The formula (9) then follows by the relations (8), (5) and (6).
Let $p$ be an odd prime and let $S^{2 n+1}\left\{p^{r}\right\}$ and $T^{2 n+1}\left\{p^{r}\right\}$ be defined by the homotopy fibrations in which all spaces are $p$-local:

where $\Pi_{r+1}=\prod_{k=1}^{\infty} S^{2 p^{t} n-1}\left\{p^{r+1}\right\}, W_{n}$ is the homotopy fibre of the double suspension $E^{2}: S^{2 n-1} \rightarrow \Omega^{2} S^{2 n+1}$. Recall that $S^{2 n+1}\left\{p^{r}\right\}$ is $(2 n-1)$ connected and $W_{n}$ is $(2 p n-4)$-connected, we have

For $p=3$, these two groups are respectively generated by $\tilde{\alpha}_{1}(5)$ and $i_{5} \alpha_{1}(5)$, where $q_{5} \tilde{\alpha}_{1}(5)=\alpha_{1}(5)$ and $B\left(\chi_{s}^{r}\right) \tilde{\alpha}_{1}(5)=\tilde{\alpha}_{1}(5)$ for $s \geq r$.

Proof. By $[7,8]$ there are homotopy equivalences

where $n_{\alpha} \geq 4 n$ and for each $n$, there exists exactly one $\alpha$ such that $n_{\alpha}=4 n$. It follows immediately that

where $\pi_{8}\left(S^{5}\left\{p^{r}\right\}\right) \cong \mathbb{Z} /\left(3, p^{r}\right)$ and $\pi_{7}\left(S^{5}\left\{p^{r}\right\}\right) \cong \mathbb{Z} /\left(3, p^{r}\right)$ can be easily computed by (10).

By [23, Proposition 2.3], there is a canonical map $\gamma_{2}: P^{5}\left(p^{r}\right) \rightarrow S^{5}\left\{p^{r}\right\}$ which is 8 -connected. It follows by the group structures that

The group $\pi_{8}\left(P^{6}\left(p^{r}\right)\right)$ is stable, its generator is clear.
2.2. Some lemma on cohomology operations. Consider the following complexes

& C^{n+3}\left(i_{P} \tilde{\eta}_{r} \eta\right)=C_{r}^{n+1} \cup_{i_{P} \tilde{\eta}_{r} \eta} e^{n+3}
\end{aligned}

Lemma 2.6 (Section 2 of [19]). For each $n \geq 2, r \geq 1$, the following Steenrod squares are isomorphisms:
(1) $\mathrm{Sq}^{2}: H^{n}(X ; \mathbb{Z} / 2) \rightarrow H^{n+2}(X ; \mathbb{Z} / 2)$ with $X=C_{\eta}^{n+2}$ or $C_{r}^{n+2}$.
(2) $\mathrm{Sq}^{2}: H^{n+1}\left(A^{n+3}\left(\tilde{\eta}_{r}\right) ; \mathbb{Z} / 2\right) \rightarrow H^{n+3}\left(A^{n+3}\left(\tilde{\eta}_{r}\right) ; \mathbb{Z} / 2\right)$.

Lemma 2.7. Let $n \geq 3, r \geq 1$ and let $X=A^{n+3}\left(\eta^{2}\right), A^{n+3}\left(2^{r} \eta^{2}\right), B^{n+3}\left(\tilde{\eta}_{r} \eta\right)$ or $C^{n+3}\left(i_{P} \tilde{\eta}_{r} \eta\right)$. Then

Proof. For the complexes $X$ in the Lemma, it is clear that

$\Theta \neq 0$ for $X=A^{n+3}\left(\eta^{2}\right)$ or $A^{n+3}\left(2^{r} \eta^{2}\right)$ refers to [19, Lemma 2.7]. For $X=B^{n+3}\left(\tilde{\eta}_{r} \eta\right)$ or $C^{n+3}\left(i_{P} \tilde{\eta}_{r} \eta\right)$, There are homotopy commutative diagrams of homotopy cofibrations


Then we get $\Theta \neq 0$ for $X=B^{n+3}\left(\tilde{\eta}_{r} \eta\right), C^{n+3}\left(i_{P} \tilde{\eta}_{r} \eta\right)$ from the following induced commutative diagram of mod 2 cohomology groups (the coefficients $\mathbb{Z} / 2$ are omitted)

H^{n+3}\left(A^{n+3}\left(\eta^{2}\right)\right) & \stackrel{q^{*}}{\cong} & H^{n+3}\left(B^{n+3}\left(\tilde{\eta}_{r} \eta\right)\right) \\
\stackrel{i^{*}}{\cong}
\end{array} H^{n+3}\left(C^{n+3}\left(i_{P} \tilde{\eta}_{r} \eta\right)\right)
$$

where the isomorphisms $q^{*}$ and $i^{*}$ can be easily checked.
Lemma 2.8. For $r, s \geq 1$, let $X=S^{5} \cup_{\alpha_{1}(5)} e^{9}$, $P^{6}\left(3^{r}\right) \cup_{i_{5} \alpha_{1}(5)} e^{9}$ or $X=P^{5}\left(3^{s}\right) \cup_{\tilde{\alpha}_{1}(5)} e^{9}$. The first Steenrod power $\mathcal{P}^{1}$ acts non-trivially on $H^{*}(Y ; \mathbb{Z} / 3)$.

Proof. It is well-known that $\mathcal{P}^{1}$ is non-trivial for $Y=S^{5} \cup_{\alpha_{1}(5)} e^{9}$ (cf. [10, Chapter 1.5.5]). For the latter two complexes, $\mathcal{P}^{1} \neq 0$ can be easily deduced from the naturality of $\mathcal{P}^{1}$ and the relations in Lemma 2.5.
2.3. Matrix analysis method. Let $X=\Sigma X^{\prime}, Y_{i}=\Sigma Y_{i}^{\prime}$ be suspensions, $i=1,2, \cdots, n$. Let

be respectively the canonical inclusions and projections, $1 \leq k, l \leq n$. By the Hilton-Milnor theorem, we may write a map $f: X \rightarrow \bigvee_{i=1}^{n} Y_{i}$ as

where $f_{k}=p_{k} \circ f: X \rightarrow Y_{k}$ and $\theta$ satisfies $\Sigma \theta=0$. The first part $\sum_{k=1}^{n} i_{k} \circ f_{k}$ is usually represented by a vector $u_{f}=\left(f_{1}, f_{2}, \cdots, f_{n}\right)^{t}$. We say that $f$ is completely determined by its components $f_{k}$ if $\theta=0$; in this case, denote $f=u_{f}$. Let $h=\sum_{k, l} i_{l} h_{l k} p_{k}$ be a self-map of $\bigvee_{i=1}^{n} Y_{i}$ which is completely determined by its components $h_{k l}=p_{k} \circ h \circ i_{l}: Y_{l} \rightarrow Y_{k}$. Denote by

M_{h}:=\left(h_{k l}\right)_{n \times n}=\left[\begin{array}{cccc}
h_{11} & h_{12} & \cdots & h_{1 n} \\
h_{21} & h_{22} & \cdots & h_{2 n} \\

Then the composition law $h(f+g) \simeq h f+h g$ implies that the product

given by the matrix multiplication represents the composite $h \circ f$. Two maps $f=u_{f}$ and $g=u_{g}$ are called equivalent, denoted by

$$
\left[f_{1}, f_{2}, \cdots, f_{n}\right]^{t} \sim\left[g_{1}, g_{2}, \cdots, g_{n}\right]^{t}
$$

if there is a self-homotopy equivalence $h$ of $\bigvee_{i=1}^{n} Y_{i}$, which can be represented by the matrix $M_{h}$, such that

$$
M_{h}\left[f_{1}, f_{2}, \cdots, f_{n}\right]^{t} \simeq\left[g_{1}, g_{2}, \cdots, g_{n}\right]^{t}
$$

Note that the above matrix multiplication refers to elementary row operations in matrix theory; and the homotopy cofibres of the maps $f=u_{f}$ and $g=u_{g}$ are homotopy equivalent if $f$ and $g$ are equivalent.

Example 2.9. Using the relations (8), we have the equivalences for maps $S^{6} \rightarrow P^{4}\left(2^{r}\right) \vee C_{s}^{5}$ :

$$
\left[\begin{array}{c}
\tilde{\eta}_{r} \eta \\
i_{P} \tilde{\eta}_{s} \eta
\end{array}\right] \sim\left[\begin{array}{c}
\tilde{\eta}_{r} \eta \\
0
\end{array}\right] \text { if } r \leq s ; \quad\left[\begin{array}{c}
\tilde{\eta}_{r} \eta \\
i_{P} \tilde{\eta}_{s} \eta
\end{array}\right] \sim\left[\begin{array}{c}
0 \\
i_{P} \tilde{\eta}_{s} \eta
\end{array}\right] \text { if } r>s .
$$

We end this section with the following useful lemma.
Lemma 2.10 (Lemma 6.4 of [15]). Let $S \xrightarrow{f}\left(\bigvee_{i=1}^{n} A_{i}\right) \vee B \xrightarrow{g} \Sigma C$ be a homotopy cofibration of simply-connected $C W$-complexes. For each $j=$ $1, \cdots, n$, let

$$
p_{j}:\left(\bigvee_{i} A_{i}\right) \vee B \rightarrow A_{j}, \quad q_{B}:\left(\bigvee_{i} A_{i}\right) \vee B \rightarrow B
$$

be the obvious projections. Suppose that the composite $p_{j} f$ is null-homotopic for each $j \leq n$, then there is a homotopy equivalence

$$
\Sigma C \simeq\left(\bigvee_{i=1}^{n} A_{i}\right) \vee C_{q_{B} f}
$$

where $C_{q_{B} f}$ is the homotopy cofibre of the composite $q_{B} f$.

## 3. The $(2 n+1)$-th homology section of $M$

Recall the homology decompositions of simply-connected spaces (cf. [2]). Let $M$ be an $(n-1)$-connected $(2 n+2)$ dimensional manifold with $H_{*}(M)$ given by (1). Denote by $M_{k}$ the $k$-th homology section in the homology decomposition of $M$. There are homotopy cofibrations in which the labelled attaching maps induce trivial homomorphism in homology (or called homologically trivial):

$$
\begin{align*}
& \left(\bigvee_{i=1}^{d} S^{n}\right) \vee P^{n+1}(T) \xrightarrow{f} M_{n} \simeq\left(\bigvee_{i=1}^{l} S^{n}\right) \vee P^{n+1}(T) \rightarrow M_{n+1},  \tag{15}\\
& \bigvee_{i=1}^{l} S^{n+1} \xrightarrow[\rightarrow]{g} M_{n+1} \rightarrow M_{n+2}=M_{2 n+1}, S^{2 n+1} \xrightarrow{h} M_{2 n+1} \rightarrow M .
\end{align*}
$$

Lemma 3.1. There is a homotopy equivalence

$$
M_{n+1} \simeq\left(\bigvee_{i=1}^{l} S^{n}\right) \vee\left(\bigvee_{i=1}^{d} S^{n+1}\right) \vee P^{n+1}(T) \vee P^{n+2}(T)
$$

Proof. Consider the first homotopy cofibration in (15). It suffices to show that $f$, or equivalently each of the following components of the map $f$ is null-homotopic:

$$
\begin{aligned}
& f_{j}: S_{j}^{n} \hookrightarrow \bigvee_{i=1}^{d} S^{n} \hookrightarrow\left(\bigvee_{i=1}^{d} S^{n}\right) \vee P^{n+1}(T) \stackrel{f}{\rightarrow} M_{n}, j=1,2 \cdots, l \\
& f_{P}: P^{n+1}(T) \hookrightarrow\left(\bigvee_{i=1}^{d} S^{n}\right) \vee P^{n+1}(T) \xrightarrow{f} M_{n}
\end{aligned}
$$

Consider the commutative diagram of homotopy cofibrations:

where $m_{T}=\bigvee_{j} p_{j}^{r_{j}}$. Since $f$ is homologically trivial, so are $f_{j}$ and $f_{P}$. The Hurewizc theorem then implies that both $f_{j}$ and $f_{P} \circ \iota$ are null-homotopic, $j=1,2, \cdots, l$. Thus the homotopy cofibration on third column implies that there is a homotopy equivalence

$$
C_{f_{P}} \simeq M_{n} \vee P^{n+2}(T)
$$

which in turn implies that $f_{P}$ is null-homotopic.
Lemma 3.2. There is a homotopy equivalence

$$
M_{2 n+1} \simeq\left(\bigvee_{i=1}^{d} S^{n+1}\right) \vee P^{n+2}(T) \vee C_{\varphi_{n}}
$$

where $\varphi_{n}: \bigvee_{i=1}^{l} S^{n+1} \rightarrow\left(\bigvee_{i=1}^{l} S^{n}\right) \vee P^{n+1}(T)$ is a homologically trivial map. Furthermore, there holds homotopy equivalences

$$
\Sigma C_{\varphi_{2}} \simeq C_{\varphi_{3}}, C_{\varphi_{n}} \simeq P^{n+1}\left(T_{\neq 2}\right) \vee C_{\bar{\varphi}_{n}} \text { for } n \geq 3
$$

where $\bar{\varphi}_{n}: \bigvee_{i=1}^{l} S^{n+1} \rightarrow\left(\bigvee_{i=1}^{l} S^{n}\right) \vee P^{n+1}\left(T_{2}\right)$.
Proof. There is a homotopy cofibration $\bigvee_{i=1}^{l} S^{n+1} \xrightarrow{g} M_{n+1} \rightarrow M_{2 n+1}$ with $M_{n+1}$ given by Lemma 3.1. Consider the compositions

$$
\begin{aligned}
& g_{j}: S^{n+1} \hookrightarrow \bigvee_{i=1}^{l} S^{n+1} \xrightarrow{g} M_{n+1} \rightarrow\left(\bigvee_{i=1}^{d} S^{n+1}\right) \rightarrow S_{j}^{n+1} \\
& g_{P}: S^{n+1} \hookrightarrow \bigvee_{i=1}^{l} S^{n+1} \xrightarrow{g} M_{n+1} \rightarrow P^{n+2}(T)
\end{aligned}
$$

Since $g$ is homologically trivial, so are $g_{j}$ and $g_{P}$. The Hurewicz theorem then implies that $g_{S, j}$ and $g_{P}$ are null-homotopic. The homotopy equivalence for $M_{2 n+1}$ in the Lemma then follows by Lemma 2.10 .

For $n \geq 3$ and odd primes $p, \pi_{n+1}\left(P^{n+1}\left(p^{r}\right)\right)=0$ implies the map $\varphi_{n}$ factors as the composition

$$
\bigvee_{i=1}^{l} S^{n+1} \xrightarrow{\bar{\varphi}_{n}}\left(\bigvee_{i=1}^{l} S^{n}\right) \vee P^{n+1}\left(T_{2}\right) \hookrightarrow\left(\bigvee_{i=1}^{l} S^{n}\right) \vee P^{n+1}(T)
$$

thus we have $C_{\varphi_{n}} \simeq P^{n+1}\left(T_{\neq 2}\right) \vee C_{\bar{\varphi}_{n}}$. If $n=2$, we do once suspension to make $P^{4}\left(T_{\neq 2}\right)$ split off $\Sigma C_{\varphi_{2}}$ and cancel the possible Whitehead products in $\varphi_{2}$; thus $\Sigma C_{\varphi_{2}} \simeq P^{4}\left(T_{\neq 2}\right) \vee C_{\bar{\varphi}_{3}} \simeq C_{\varphi_{3}}$.

Lemma 3.3. Let $T_{2} \cong \bigoplus_{i=1}^{t_{2}} \mathbb{Z} / 2^{r_{i}}$ and let $n \geq 3$. If the Steenrod square $\mathrm{Sq}^{2}$ acts trivally on $H^{n}\left(C_{\varphi_{n}} ; \mathbb{Z} / 2\right)$, then there is a homotopy equivalence

$$
C_{\varphi_{n}} \simeq\left(\bigvee_{i=1}^{l} S^{n}\right) \vee P^{n+1}(T) \vee\left(\bigvee_{i=1}^{l} S^{n+2}\right)
$$

otherwise there exist integers $0 \leq c_{1} \leq l, 0 \leq c_{2} \leq t_{2}$ with $0<c_{1}+c_{2} \leq l$ ( $c_{1}=0$ or $c_{2}=0$ if $l=1$ ) such that

$$
\begin{aligned}
C_{\varphi_{n}} \simeq\left(\bigvee_{i=1}^{l-c_{1}} S^{n}\right) \vee\left(\bigvee_{i=1}^{c_{1}} C_{\eta}^{n+2}\right) \vee( & \left.\bigvee_{i=1}^{l-c_{1}-c_{2}} S^{n+2}\right) \vee P^{n+1}\left(T_{\neq 2}\right) \\
& \vee\left(\bigvee_{j=c_{2}+1}^{t_{2}} P^{n+1}\left(2^{r_{j}}\right)\right) \vee\left(\bigvee_{j=1}^{t_{2}} C_{r_{j}}^{n+2}\right)
\end{aligned}
$$

Proof. Write $\bar{\varphi}=\bar{\varphi}_{n}$ for simplicity. Note that $n \geq 3$ is the stable range for maps in $\pi_{n+1}\left(\left(\bigvee_{i=1}^{l} S^{n}\right) \vee P^{n+1}\left(T_{2}\right)\right)$. Hence $\bar{\varphi}$ contains no Whitehead products and can be represented by a matrix $\left[\begin{array}{c}A \\ B\end{array}\right]$, where $A$ is an $l \times l$ matrix representing the component

$$
\bar{\varphi}_{A}: \bigvee_{i=1}^{l} S^{n+1} \xrightarrow{\bar{\varphi}}\left(\bigvee_{i=1}^{l} S^{n}\right) \vee P^{n+1}\left(T_{2}\right) \rightarrow \bigvee_{i=1}^{l} S^{n}
$$

and $B$ is an $l \times t_{2}$ matrix representing the component

$$
\bar{\varphi}_{B}: \bigvee_{i=1}^{l} S^{n+1} \xrightarrow{\bar{\varphi}}\left(\bigvee_{i=1}^{l} S^{n}\right) \vee P^{n+1}\left(T_{2}\right) \rightarrow P^{n+1}\left(T_{2}\right) \simeq \bigvee_{i=1}^{t_{2}} P^{n+1}\left(2^{r_{i}}\right)
$$

By Lemma 2.1, entries of the matrix $A$ are possibly $0, \eta$ and entries of $B$ are possible 0 or $i_{n} \eta$.

If $\operatorname{Sq}^{2}\left(H^{n}\left(C_{\varphi}\right) ; \mathbb{Z} / 2\right)=0$, then $\operatorname{Sq}^{2}\left(H^{n}\left(C_{\bar{\varphi}}\right) ; \mathbb{Z} / 2\right)=0$. Lemma 2.6 (1) then implies that $\left[\begin{array}{l}A \\ B\end{array}\right]$ is the zero matrix; that is, $\bar{\varphi}$ is null-homotopic, which proves the first homotopy equivalence.

If $\operatorname{Sq}^{2}\left(H^{n}\left(C_{\varphi}\right) ; \mathbb{Z} / 2\right) \neq 0$, then $\operatorname{Sq}^{2}\left(H^{n}\left(C_{\bar{\varphi}}\right) ; \mathbb{Z} / 2\right) \neq 0$. By Lemma 2.6 (1) we see that at least one entry of $\left[\begin{array}{l}A \\ B\end{array}\right]$ is nonzero. Observe that there are
equivalences
(i) $\left[\begin{array}{l}\eta \\ \eta\end{array}\right] \sim\left[\begin{array}{l}\eta \\ 0\end{array}\right] \sim\left[\begin{array}{l}0 \\ \eta\end{array}\right]: S^{n+1} \rightarrow S^{n} \vee S^{n}$,
(ii) $\left[\begin{array}{c}\eta \\ i_{n} \eta\end{array}\right] \sim\left[\begin{array}{l}\eta \\ 0\end{array}\right]: S^{n+1} \rightarrow S^{n} \vee P^{n+1}\left(2^{r}\right)$,
(iii) $\left[\begin{array}{c}i_{n} \eta \\ i_{n} \eta\end{array}\right] \sim\left[\begin{array}{c}i_{n} \eta \\ 0\end{array}\right]: S^{n+1} \rightarrow P^{n+1}\left(2^{r}\right) \vee P^{n+1}\left(2^{s}\right)$ for $r \geq s$.

By ( $i$ ) we firstly apply elementary transformations to the matrix $A$ to get a diagonal matrix $D$ with diagonal entries

$$
d_{1}=\cdots=d_{c_{1}}=\eta, d_{c_{1}+1}=\cdots=d_{l}=0 .
$$

By (ii) we then apply appropriate row transformations to $\left[\begin{array}{l}D \\ B\end{array}\right]$ to make the entries of $B$ below the nonzero $d_{1}=\cdots=d_{c_{1}}=\eta$ all zero. Denote the resulted matrix by $\left[\begin{array}{c}D \\ C\end{array}\right]$. The nonzero entries of $C$ only possibly appear in the last $l-c_{1}$ columns. Finally, by (iii) we apply appropriate row transformations to $C$ to get a matrix $\left[\begin{array}{c}D \\ E\end{array}\right]$ such each column of $E$, and hence of $\left[\begin{array}{c}D \\ E\end{array}\right]$ contains at most one nonzero entry. Let $c_{2}$ be the number of $i_{n} \eta$ in $E$, then the second homotopy equivalence in the Lemma follows.

Note that we cannot determine the indices $r_{1}, \cdots, r_{c_{2}}$ among $r_{1}, \cdots, r_{t_{2}}$. Summarizing from Lemma 3.2 and 3.3 we get the following.
Proposition 3.4. Let $M$ be an ( $n-1$ )-connected $(2 n+2)$-manifold with $H_{*}(M)$ given by (1), $n \geq 2$. Identify $\Sigma M_{5}$ with $M_{7}$. There is a homotopy equivalence

$$
\begin{aligned}
& M_{2 n+1} \simeq\left(\bigvee_{i=1}^{d} S^{n+1}\right) \vee P^{n+2}(T) \vee\left(\bigvee_{i=1}^{l-c_{1}} S^{n}\right) \vee\left(\bigvee_{i=1}^{l-c_{1}-c_{2}} S^{n+2}\right) \vee P^{n+1}\left(T_{\neq 2}\right) \\
& \vee\left(\bigvee_{i=1}^{c_{1}} C_{\eta}^{n+2}\right) \vee\left(\bigvee_{j=c_{2}+1}^{t_{2}} P^{n+1}\left(2^{r_{j}}\right)\right) \vee\left(\bigvee_{j=1}^{c_{2}} C_{r_{j}}^{n+2}\right),
\end{aligned}
$$

where $0 \leq c_{1} \leq l, 0 \leq c_{2} \leq t_{2}$ and $c_{1}+c_{2} \leq l$. Moreover,
(1) $c_{1}=c_{2}=0$ if and only if $\mathrm{Sq}^{2}$ acts trivially on $H^{n}(M ; \mathbb{Z} / 2)$.
(2) Suppose $l=1$ and $\mathrm{Sq}^{2}$ acts non-trivially on $H^{n}(M ; \mathbb{Z} / 2)$ (Replace $H^{n}(M ; \mathbb{Z} / 2)$ by $H^{3}(\Sigma M ; \mathbb{Z} / 2)$ for $\left.n=2\right)$. If for any $x \in H^{n}(M ; \mathbb{Z} / 2)$ with $\mathrm{Sq}^{2}(x) \neq 0$ and any $y \in \operatorname{ker}\left(\mathrm{Sq}^{2}\right)$, we have $\beta_{r}(x+y)=0$ for any $r \geq 1$, then $\left(c_{1}, c_{2}\right)=(1,0)$; otherwise $\left(c_{1}, c_{2}\right)=(0,1)$.
The following is immediate.
Corollary 3.5. Under the same assumptions in Proposition 3.4, there is a homotopy equivalence

$$
M_{2 n+1} \simeq_{\left(\frac{1}{2}\right)}\left(\bigvee_{i=1}^{d} S^{n+1}\right) \vee\left(\bigvee_{i=1}^{l}\left(S^{n} \vee S^{n+2}\right)\right) \vee P^{n+1}(T) \vee P^{n+2}(T)
$$

As a byproduct, we note that Lemma 3.2 and Lemma 3.3 (or Proposition 3.4) help to understand the homotopy type of the loop space $\Omega M$ more clearly characterized by Chenery [6] or Theriault [25]. The proof of the following Corollary is similar to that of [6, Theorem 5.1].

Corollary 3.6. Let $M$ be an $(n-1)$-connected ( $2 n+2$ )-dimensional Poincaré duality complex whose integral homology is given by (1) with $d>1, n=2$, or $n \geq 4, n \neq 7$. Then there is a homotopy equivalence

$$
\Omega M \simeq \Omega\left(S^{n+1} \times S^{n+1}\right) \times \Omega\left(\Omega\left(S^{n+1} \times S^{n+1}\right) \ltimes X\right)
$$

where $X=\left(\bigvee_{i=1}^{d-2} S^{n+1}\right) \vee P^{n+2}(T) \vee C_{\varphi_{n}}$ is given by Lemma 3.2 for $n=2$ and by Lemma 3.3 for $n \geq 4, n \neq 7$.

## 4. Proof of Theorem 1.1

Let $M$ be a closed simply-connected 6-manifold. By Lemma 3.2, there is a homotopy cofibration

$$
S^{5} \xrightarrow{h} M_{5} \simeq\left(\bigvee_{i=1}^{d} S^{3}\right) \vee P^{4}(T) \vee C_{\varphi_{2}} \rightarrow M
$$

where $\varphi_{2}: \bigvee_{i=1}^{l} S^{3} \rightarrow\left(\bigvee_{i=1}^{l} S^{2}\right) \vee P^{3}(T)$. We may set

$$
h=\sum_{i=1}^{d} h_{i}^{S}+\sum_{j=1}^{t}+h_{\varphi_{2}}+\theta
$$

where $h_{i}^{S}, h_{j}^{P}$ and $h_{\varphi_{2}}$ are the compositions of $h$ with the canonical projections onto $S_{i}^{3}=S^{3}, P^{4}\left(p_{i}^{r_{i}}\right)$ and $C_{\varphi_{2}}$, respectively; $\theta$ is a sum of all possible Whitehead products, $\Sigma \theta=0$. Thus after suspension we get a homotopy cofibration

$$
S^{6} \xrightarrow{\bar{h}}\left(\bigvee_{i=1}^{d} S^{4}\right) \vee\left(\bigvee_{i=1}^{t} P^{5}\left(p_{i}^{r_{i}}\right)\right) \vee \Sigma C_{\varphi_{2}} \rightarrow \Sigma M
$$

where $\bar{h}=\sum_{i=1}^{d} \Sigma h_{i}^{S}+\sum_{j=1}^{t} \Sigma h_{j}^{P}+\Sigma h_{\varphi_{2}}$. For our topological 6-manifold $M$, the generalized splitting theorem of Wall [27] or Jupp [17] implies a homotopy equivalence (cf. [12, Corollary 2.2])

$$
\begin{equation*}
\Sigma M \simeq\left(\bigvee_{i=1}^{d} S^{4}\right) \vee \Sigma M^{\prime} \tag{16}
\end{equation*}
$$

Denote $T_{2}\left[c_{2}\right]=\bigoplus_{i=c_{2}+1}^{t_{2}} \mathbb{Z} / 2^{r_{i}}, T\left[c_{2}\right]=T_{2}\left[c_{2}\right] \oplus T_{\neq 2}$. By Proposition 3.4 with $n=2, \Sigma M^{\prime}$ is the homotopy cofibre of a map

$$
\begin{align*}
& S^{6} \xrightarrow{\bar{h}^{\prime}} \Sigma M_{5}^{\prime} \stackrel{e}{\simeq} P^{5}(T) \vee\left(\bigvee_{i=1}^{l-c_{1}} S^{3}\right) \vee\left(\bigvee_{i=1}^{l-c_{1}-c_{2}} S^{5}\right) \vee\left(\bigvee_{i=1}^{c_{1}} C_{\eta}^{5}\right)  \tag{17}\\
& \vee P^{4}\left(T\left[c_{2}\right]\right) \vee\left(\bigvee_{j=1}^{c_{2}} C_{r_{j}}^{5}\right)=: \Sigma W^{\prime}
\end{align*}
$$

Lemma 4.1. Let $Z$ be an element or a wedge sum of any two elements of $\left\{S^{2}, S^{4}, C_{\eta}^{4}, C_{r_{j}}^{4}, P^{3}\left(2^{r_{i}}\right)\right\}$ with $\mathbb{Z} / 2^{r_{i}}$ direct summands of $T_{2}\left[c_{2}\right] . \operatorname{Let} p_{Z}^{\prime}: W^{\prime} \rightarrow$ $Z$ be the canonical projection onto $Z$. Then all the compositions

$$
S^{6} \xrightarrow{\Sigma \bar{h}^{\prime}} \Sigma M_{5}^{\prime} \xrightarrow{e} \Sigma W^{\prime} \xrightarrow{\Sigma p_{Z}^{\prime}} \Sigma Z
$$

are suspensions of certain maps.

Proof. Write $\Sigma W^{\prime}=P^{5}(T) \vee P^{4}\left(T_{\neq 2}\right) \vee \Sigma X$ with

$$
X=\left(\bigvee_{i=1}^{l-c_{1}} S^{2}\right) \vee\left(\bigvee_{i=1}^{l-c_{1}-c_{2}} S^{4}\right) \vee\left(\bigvee_{i=1}^{c_{1}} C_{\eta}^{4}\right) \vee\left(\bigvee_{i=c_{2}+1}^{t_{2}} P^{3}\left(2^{r_{i}}\right)\right) \vee\left(\bigvee_{j=1}^{c_{2}} C_{r_{j}}^{4}\right)
$$

Clearly the projection $p=\left(\Sigma p_{Z}^{\prime}\right) \circ e: \Sigma M_{5}^{\prime} \rightarrow \Sigma Z$ factors through $\Sigma X$. Let $H$ be the second James-Hopf invariant, then $H\left(\Sigma p_{Z}^{\prime}\right)=0$. Consider the following commutative diagram

$$
\begin{gathered}
{\left[M_{5}^{\prime}, Z\right] \xrightarrow{E}\left[\Sigma M_{5}^{\prime}, \Sigma Z\right] \xrightarrow{H}\left[\Sigma M_{5}^{\prime}, \Sigma Z \wedge Z\right]} \\
e^{\sharp} \cong \underline{\cong} \\
{\left[\Sigma W^{\prime}, \Sigma Z\right] \xrightarrow{H}\left[\Sigma W^{\prime}, \Sigma Z \wedge Z\right]}
\end{gathered},
$$

where $E(\alpha)=\Sigma \alpha$ is the suspension homomorphism. We have

$$
H(p)=H \circ e^{\sharp}\left(\Sigma p^{\prime}\right)=e^{\sharp} H\left(\Sigma p^{\prime}\right)=0 .
$$

Since $M_{5}^{\prime}$ has dimension 4 , the top row is the generalized $E H P$ exact sequence (cf. [11, Section 4.K]). Then it follows by exactness that $p$ is the suspension of some map $M_{5}^{\prime} \rightarrow Z$. Thus the composition $p \circ \Sigma \bar{h}^{\prime}$ is a suspension.

In [9] Cutler and So showed that $\hbar$ contains trivial Whitehead product component $W$ if $H_{*}(M)$ contains no 2-torsions; i.e., $T_{2}=0$. When $T_{2} \neq 0$, after once-suspension the possible Whitehead products

$$
\theta_{\varphi}: S^{6} \rightarrow \Sigma C_{\varphi}
$$

lie in the groups $\pi_{6}\left(\Sigma Y_{1} \vee \Sigma Y_{2}\right)$, where $Y_{1}, Y_{2} \in\left\{S^{2}, S^{4}, P^{3}\left(2^{r_{i}}\right), C_{\eta}^{4}, C_{r_{j}}^{4}\right\}$.
Proposition 4.2. The attaching map $\hbar=e \circ \Sigma \bar{h}^{\prime}: S^{6} \rightarrow \Sigma W^{\prime}$ in (17) desuspends and contains no Whitehead product components.

Proof. By the work of [9], it suffices to consider the case $T=T_{2}$. Note that the second James-Hopf invariant $H$ satisfies $H \circ E=0$, where $E(\alpha)=\Sigma \alpha$. It follows that if there exist elements in $\pi_{6}\left(\Sigma Y_{1} \vee \Sigma Y_{2}\right)$ satisfying $H(\alpha) \neq 0$, then $\alpha \neq \Sigma \alpha^{\prime}$, and hence $\alpha$ is not a component of $\theta_{\varphi}$. Then the Proposition follows by Lemma 6.4, 6.5 and 4.1.

Due to [9], $P^{5}\left(T_{\neq 2}\right)$ and $P^{4}\left(T_{\neq 2}\right)$ split off $\Sigma M^{\prime}$. By the group structures and generators in Lemma 2.1, 2.2 and 2.3, we observe that $\pi_{6}\left(C_{\eta}^{5}\right)$ contains no suspended elements and the suspended generators of $\pi_{6}\left(P^{5}\left(2^{s}\right)\right), \pi_{6}\left(S^{3}\right)$, $\pi_{6}\left(P^{4}\left(2^{r}\right)\right), \pi_{6}\left(C_{r}^{5}\right)$ are respectively

where all the coefficients belong to $\{0,1\}$, and $c_{1}=c_{2}=0$ if and only if the Steenrod square $\mathrm{Sq}^{2}$ acts trivially on $H^{2}(M ; \mathbb{Z} / 2)$. We discuss the homotopy types of $C_{\hbar}$ and $\Sigma M^{\prime}$ by the following two propositions. In their proofs we shall frequently use the phrase "we may assume that" to mean that the original situations (or maps) is equivalent to the latter ones by doing suitable matrix operations, and their mapping cones are homotopy equivalent.

Proposition 4.3. Suppose that $\mathrm{Sq}^{2}$ acts trivially on $H^{4}(M ; \mathbb{Z} / 2)$.

1. If the secondary operation $\Theta$ acts trivially on $H^{3}(M ; \mathbb{Z} / 2)$, then

where $\epsilon \in\{0,1\}$, and $\epsilon=0$ if $\mathbb{T}\left(H^{2}(M ; \mathbb{Z} / 2)\right)=0$ or $l=c_{1}=1$.
2. If $\Theta$ acts non-trivially on $H^{3}(M ; \mathbb{Z} / 2)$, then the homotopy type of $\Sigma M^{\prime}$ can be distinguished as follows.
(a) If for any $u, v \in H^{4}(\Sigma M ; \mathbb{Z} / 2)$ with $\Theta(u) \neq 0, \Theta(v)=0$, there holds $u+v \notin \operatorname{im}\left(\beta_{s}\right)$ for any $s \geq 1 ;$ while there exist $u^{\prime}, v^{\prime} \in H^{4}(\Sigma M ; \mathbb{Z} / 2)$ satisfying $\Theta\left(u^{\prime}\right) \neq 0, \Theta\left(v^{\prime}\right)=0$ and $\beta_{r}\left(u^{\prime}+v^{\prime}\right) \neq 0$, then there is a homotopy equivalence

where $r_{j_{1}}$ is the maximum of $r_{j}$ such that $\beta_{r_{j}}\left(u^{\prime}+v^{\prime}\right) \neq 0$.
(b) If there exist $u, v \in H^{4}(\Sigma M ; \mathbb{Z} / 2)$ satisfying $\Theta(u) \neq 0, ~ \Theta(v)=0$, $u+v \in \operatorname{im}\left(\beta_{r}\right)$ for some $r$, then we have

\Sigma M^{\prime} \simeq P^{5}(T) \vee\left(\bigvee_{i=1}^{l-c_{1}} S^{3}\right) \vee\left(\bigvee_{i=1}^{l-c_{1}-c_{2}} S^{5}\right) \vee\left(\bigvee_{i=1}^{c_{1}} C_{\eta}^{5}\right) \vee\left(\bigvee_{j_{2} \neq j=1}^{t_{2}} C_{r_{j}}^{5}\right) \\
\vee P^{4}\left(T\left[c_{2}\right]\right) \vee\left(C_{r_{j_{2}}}^{5} \cup_{\left.i_{P} \tilde{\eta}_{r_{j_{2}} \eta} e^{7}\right)}\right.
\end{aligned}

where $r_{j_{2}}$ is the minimum of $r_{j}$ such that $u+v \in \operatorname{im}\left(\beta_{r_{j}}\right)$. The second homotopy equivalence is impossible if $l=c_{1}=1$.

Proof. Consider the equation (18) for $\hbar$. The assumption that $\mathrm{Sq}^{2}$ acts trivially on $H^{5}(\Sigma M ; \mathbb{Z} / 2)$ indicates $x_{i}=z_{i}=0$ for all $i$. Thus we have

(a) The assumptions in (2a) guarantee that in (19),

Dual to the formula $q_{4} \tilde{\eta}_{r}=\eta(4)$, there exists a map $\bar{\eta}_{r}: P^{5}\left(2^{r}\right) \rightarrow S^{3}$ satisfying $\bar{\eta}_{r} \circ i_{4}=\eta, 2 \bar{\eta}_{1}=\eta^{2} q_{5}$. By the equivalence

Thus we may assume that $\varepsilon_{i}=y_{i}=0$ for all $i$; moreover, if $s_{j}=1$ for some $c_{2}+1 \leq j \leq t_{2}$, then we can further assume that

Proposition 4.4. Suppose that $\mathrm{Sq}^{2}$ acts non-trivially on $H^{4}(M ; \mathbb{Z} / 2)$.

1. If for any $u \in H^{5}(\Sigma M ; \mathbb{Z} / 2)$ with $\operatorname{Sq}^{2}(u) \neq 0$ and any $v \in \operatorname{ker}\left(S q^{2}\right)$, there hold $u+v \notin \operatorname{im}\left(\beta_{r}\right)$ for any $r \geq 1$, then there is a homotopy equivalence
$\Sigma M^{\prime} \simeq P^{5}(T) \vee\left(\bigvee_{i=1}^{l-c_{1}} S^{3}\right) \vee\left(\bigvee_{i=2}^{l-c_{1}-c_{2}} S^{5}\right) \vee\left(\bigvee_{i=1}^{c_{1}} C_{\eta}^{5}\right) \vee P^{4}\left(T\left[c_{2}\right]\right) \vee\left(\bigvee_{j=1}^{c_{2}} C_{r_{j}}^{5}\right) \vee C_{\eta}^{7}$.
This possibility doesn't exist if $l=1$ and $\operatorname{Sq}^{2}\left(H^{2}(M ; \mathbb{Z} / 2)\right)$.
2. If there exist $u, v \in H^{5}(\Sigma M ; \mathbb{Z} / 2)$ such that

& \vee\left(\bigvee_{j=1}^{c_{2}} C_{r_{j}}^{5}\right) \vee\left(P^{5}\left(2^{r_{i_{1}}}\right) \cup_{\tilde{r}_{r_{i_{1}}}} e^{7}\right),
\end{aligned}

where $r_{i_{1}}$ is the minimum of $r_{i}$ such that $u+v \in \operatorname{im}\left(\beta_{r_{i}}\right)$.
Proof. By Lemma 2.6 and [19, Lemma 3.2 (2)], the assumption that $\mathrm{Sq}^{2}$ acts non-trivally on $H^{4}(M ; \mathbb{Z} / 2)$, or equivalently on $H^{5}(\Sigma M ; \mathbb{Z} / 2)$ implies that at least one of $x_{i}$ and $z_{i}$ equals 1 in the expression (18).
(1) If the conditions in (1) hold, then $x_{i}=0$ for all $i \leq t_{2}$ and $z_{i}=1$ for at least one $i \leq l-c_{1}-c_{2}$. Clearly we may assume that there exists exactly one such $i$, say $z_{1}=1$ and $z_{i}=0$ for $2 \leq i \leq l-c_{1}-c_{2}$. There hold obvious equivalences

where $\gamma_{Y}=i_{4} \eta^{2}, \eta, \tilde{\eta}_{s} \eta, i_{P} \tilde{\eta}_{s} \eta$ for $Y=P^{5}\left(2^{s}\right), S^{5}, P^{4}\left(2^{s}\right), C_{s}^{5}$, respectively. Hence we may further assume that $\varepsilon_{i}=y_{i}=z_{i}=s_{j}=t_{j}=0$ for all $i, j$. Thus we get

Proof of Theorem 1.1. Recall that for our 6-manifolds $M$, the Wu formula implies that the second Stiefel-Whitney class $\omega_{2}(M)=0$ if and only if $\mathrm{Sq}^{2}$ acts trivially on $H^{4}(M ; \mathbb{Z} / 2)$. The discussion on the homotopy types of $\Sigma M$ follows by (16), Proposition 4.3 and 4.4.

## 5. Proof of Theorem 1.4

Let $M$ be a 2-connected 8-dimensional Poincaré duality complex with $H_{*}(M)$ given by (1). In this section we study the homotopy decompositions of $\Sigma M$ after localization away from 2 . For convenience, we assume that $T$ contains no 2 -torsion.

By Corollary 3.5 and Lemma 2.10, after localization away from 2 the attaching map $h$ of the top cell of $M$ factors as the composition

Thus we have a homotopy equivalence

where $h^{\prime \prime}: S^{8} \rightarrow\left(\bigvee_{i=1}^{d} S^{4}\right) \vee P^{4}(T) \vee P^{5}(T)$ is a suspension map and contains no Whitehead products. Set $T=\bigoplus_{u=1}^{\bar{t}} \mathbb{Z} / 3^{r_{u}} \oplus T_{\geq 5}$ for some $0 \leq \bar{t} \leq k$. By Lemma 2.5 we may put

where $a_{i}, b_{j}, c_{k} \in \mathbb{Z} / 3$. Here we use the convention that $b_{j}=c_{k}=0$ if $\bar{t}=0$.
Lemma 5.1. Let $h^{\prime \prime}$ be the map given by (21). If $\mathcal{P}^{1}$ acts trivially on $H^{5}\left(C_{h^{\prime \prime}} ; \mathbb{Z} / 3\right)$, then there is a homotoppy equivalence

(1) If for any $u \in H^{5}\left(C_{h^{\prime \prime}} ; \mathbb{Z} / 3\right)$ with $\mathcal{P}^{1}(u) \neq 0$ and any $v \in \operatorname{ker}\left(\mathcal{P}^{1}\right)$, there hold $\beta_{r}(u+v)=0$ and $u+v \notin \operatorname{im}\left(\beta_{s}\right)$ for all $r, s \geq 1$, then there is a homotopy equivalence

C_{h^{\prime \prime}} \simeq{ }_{\left(\frac{1}{2}\right)}\left(\bigvee_{i=2}^{d} S^{5}\right) \vee P^{5}(T) \vee P^{6}(T) \vee\left(S^{5} \cup_{\alpha_{1}(5)} e^{9}\right)
$$

(2) If there exist $u \in H^{5}\left(C_{h^{\prime \prime}} ; \mathbb{Z} / 3\right)$ with $\mathcal{P}^{1}(u) \neq 0$ and $v \in \operatorname{ker}\left(\mathcal{P}^{1}\right)$ such that $u+v \in \operatorname{im}\left(\beta_{r}\right)$ for some $r$, then

$$

where $r_{j_{1}}$ is the minimum of $r_{j}$ such that $u+v \in \operatorname{im}\left(\beta_{r_{j}}\right)$.
(3) If for any $u \in H^{5}\left(C_{h^{\prime \prime}} ; \mathbb{Z} / 3\right)$ with $\mathcal{P}^{1}(u) \neq 0$ and any $v \in \operatorname{ker}\left(\mathcal{P}^{1}\right)$, there hold $u+v \notin \operatorname{im}\left(\beta_{s}\right)$ for all $s \geq 1$; while there exist $u^{\prime} \in$ $H^{5}\left(C_{h^{\prime \prime}} ; \mathbb{Z} / 3\right)$ with $\mathcal{P}^{1}\left(u^{\prime}\right) \neq 0$ and $v^{\prime} \in \operatorname{ker}\left(\mathcal{P}^{1}\right)$ such that $\beta_{r}\left(u^{\prime}+\right.$ $\left.v^{\prime}\right) \neq 0$ for some $r \geq 1$, then

where $r_{j_{2}}$ is the maximum of $r_{j}$ such that $\beta_{r_{j}}\left(u^{\prime}+v^{\prime}\right) \neq 0$.
Proof. Since $\mathcal{P}^{1}$ acts non-trivially on $H^{5}\left(C_{h^{\prime \prime}} ; \mathbb{Z} / 3\right)$, by Lemma 2.8 we see that in (21) at least one of $a_{i}, b_{j}, c_{j}$ is non-zero. The relation $q_{5} \tilde{\alpha}_{1}(5) \simeq \alpha_{1}(5)$ implies the following equivalences

\end{array}\right] } & \sim\left[\begin{array}{c}
\alpha_{1}(5) \\

(1) Under the additional condition, Lemma 2.8 implies

$$

Then by Lemma 2.10 we have a homotopy equivalence

for some map $h^{\prime \prime \prime}=\sum_{i=1}^{d} a_{i} \cdot \alpha_{1}(5): S^{8} \rightarrow \bigvee_{i=1}^{d} S^{5}, a_{i} \in \mathbb{Z} / 3$. ## 6. The weak second James-Hopf invariant

Let $X, Y$ be connected CW-complexes. Recall that the Hilton-Milnor theorem states that there is a homotopy equivalence

$$
\Omega \Sigma(X \vee Y) \simeq \Omega \Sigma X \times \Omega \Sigma Y \times \Omega \Sigma\left(\vee_{i \geq 1} X^{\wedge i} \wedge Y\right) .
$$

Let $\iota_{1}: X \rightarrow X \vee Y$ and $\iota_{2}: Y \rightarrow X \vee Y$ be the canonical inclusion into wedge sum, respectively. Let $E=E_{X}: X \rightarrow \Omega \Sigma X$ be the suspension map, which is the inclusion map if we identify $\Omega \Sigma X$ with the James construction $J(X)$ [16]. Recall the following duality isomorphism

that is, $\Omega_{0}[f, g]=\left[\Omega_{0} f, \Omega_{0} g\right]^{S}$. Let $X$ be a connected CW co- $H$-space. Recall that the second James-Hopf invariant $H=H_{2}$ is the composition

H: \Omega \Sigma X \xrightarrow{\Omega \Sigma\left(\iota_{1}+\iota_{2}\right)} \Omega \Sigma(X \vee X) \xrightarrow{p_{\left[\iota_{1}, \iota_{2}\right]}} \Omega \Sigma(X \wedge X),
$$

where $p_{\left[l_{1}, \iota_{2}\right]}$ is the canonical projection after pre-composing with the homotopy equivalence given by the Hilton-Milnor theorem.

For a map $f: X \rightarrow Y$, denote by $f_{E}$ the composition

f_{E}=E_{Y} \circ f=(\Omega \Sigma f) \circ E_{X}=\Omega_{0}(\Sigma f): X \rightarrow \Omega \Sigma Y .
$$

Let $\iota_{i}: S^{i+1} \rightarrow S^{2} \vee S^{3}, i=1,2$. There hold isomorphisms

\pi_{5}\left(\Omega \Sigma\left(S^{2} \vee S^{3}\right)^{\wedge 2}\right) & \cong \pi_{5}\left(\Omega \Sigma S^{2} \wedge S^{3}\right) \oplus \pi_{5}\left(\Omega \Sigma S^{3} \wedge S^{2}\right) \oplus \pi_{5}\left(\Omega \Sigma S^{2} \wedge S^{2}\right) \\
& \cong \mathbb{Z}\left\langle\left(\iota_{1} \wedge \iota_{2}\right)_{E}\right\rangle \oplus \mathbb{Z}\left\langle\left(\iota_{2} \wedge \iota_{1}\right)_{E}\right\rangle \oplus \mathbb{Z} / 2\left\langle\left(\iota_{1} \wedge \iota_{1}\right)_{E} \circ \eta_{4}\right\rangle
\end{aligned}
$$

Lemma 6.1. Let $H_{\sharp}: \pi_{5}\left(\Omega \Sigma\left(S^{2} \vee S^{3}\right)\right) \rightarrow \pi_{5}\left(\Omega \Sigma\left(S^{2} \vee S^{3}\right)^{\wedge 2}\right)$ be the homomorphism induced by the second James-Hopf invariant. Assume that

H_{\sharp}\left(\Omega_{0}\left[\Sigma \iota_{1}, \Sigma \iota_{2}\right]\right)=x \cdot\left(\iota_{1} \wedge \iota_{2}\right)_{E}+y \cdot\left(\iota_{2} \wedge \iota_{1}\right)_{E}+z \cdot\left(\iota_{1} \wedge \iota_{1}\right)_{E} \circ \eta_{4},
$$

then $x, y$ are odd integers.
Proof. Let $\sigma_{n} \in H_{n}\left(S^{n}\right) \cong \mathbb{Z}$ be a generator. There are isomorphisms

H_{5}\left(S^{5}\right) \xrightarrow{\tau_{3,2}} H_{5}\left(S^{3} \wedge S^{2}\right) \cong H_{3}\left(S^{3}\right) \otimes H_{2}\left(S^{2}\right), & \sigma_{5} \mapsto(-1)^{\beta} \cdot \sigma_{3} \otimes \sigma_{2},
\end{array}
$$

where $\alpha, \beta$ are integers. By the Bott-Samelson theorem,

H_{5}\left(\Omega \Sigma\left(S^{2} \vee S^{3}\right)\right) & \cong T\left\langle\left(\iota_{1}\right)_{E *}\left(\sigma_{2}\right),\left(\iota_{2}\right)_{E *}\left(\sigma_{3}\right)\right\rangle, \\
H_{5}\left(\Omega \Sigma\left(S^{2} \vee S^{3}\right)^{\wedge 2}\right) & \cong T\left\langle\left(\iota_{i} \wedge \iota_{j}\right)_{E *}\left(\sigma_{i+1} \otimes \sigma_{j+1}\right) \mid i, j=1,2\right\rangle,
\end{aligned}
$$

where $T\left\langle x_{1}, \cdots, x_{m}\right\rangle$ is the free tensor algebra $T(V)$ and $V$ is the free abelian group generated by $x_{1}, \cdots, x_{m}$.

Consider the following commutative diagram with $X=S^{2} \vee S^{3}$ :

where $h$ are the Hurewicz homomorphisms, $\rho_{2}$ are the $\bmod 2$ reductions. Note that

& =(-1)^{\alpha}\left(\left(\iota_{1} \wedge \iota_{2}\right)_{E *}\left(\sigma_{2} \otimes \sigma_{3}\right)-\left(\iota_{2} \wedge \iota_{1}\right)_{E *}\left(\sigma_{3} \otimes \sigma_{2}\right)\right), \\
h\left(\left(\iota_{1} \wedge \iota_{2}\right)_{E}\right) & =(-1)^{\alpha}\left(\iota_{1} \wedge \iota_{2}\right)_{E *}\left(\sigma_{2} \otimes \sigma_{3}\right), \\
h\left(\left(\iota_{2} \wedge \iota_{1}\right)_{E}\right) & =(-1)^{\beta}\left(\iota_{2} \wedge \iota_{1}\right)_{E *}\left(\sigma_{3} \otimes \sigma_{2}\right), \\
h\left(\left(\iota_{1} \wedge \iota_{1}\right)_{E} \circ \eta_{4}\right) & =0 .
\end{aligned}
$$

For simplicity denote by $\bar{x}=\rho_{2}(x)$ for an element $x \in G$; write

\mathrm{RD} & =H_{*}\left(\overline{\left(\iota_{1}\right)_{E *}\left(\sigma_{3}\right)} \otimes \overline{\left(\iota_{2}\right)_{E *}\left(\sigma_{2}\right)}-\overline{\left(\iota_{2}\right)_{E *}\left(\sigma_{2}\right)} \otimes \overline{\left(\iota_{1}\right)_{E *}\left(\sigma_{3}\right)}\right) \\
& =\left(\overline{\left(\iota_{1}\right)_{E *}\left(\sigma_{3}\right) \otimes\left(\iota_{2}\right)_{E *}\left(\sigma_{2}\right)}-\overline{\left(\iota_{2}\right)_{E *}\left(\sigma_{2}\right) \otimes\left(\iota_{1}\right)_{E *}\left(\sigma_{3}\right)}\right) \\
& \left.=\overline{\left(\iota_{1} \wedge \iota_{2}\right)_{E *}\left(\sigma_{2} \otimes \sigma_{3}\right)}-\overline{\left(\iota_{2} \wedge \iota_{1}\right)_{E *}\left(\sigma_{3} \otimes \sigma_{2}\right)}\right), \\
\mathrm{DR} & =\rho_{2}\left(x \cdot h\left(\iota_{1} \wedge \iota_{2}\right)_{E}+y \cdot\left(\iota_{2} \wedge \iota_{1}\right)_{E}\right) \\
& =\left(\bar{x} \cdot \overline{\left(\iota_{1} \wedge \iota_{2}\right)_{E *}\left(\sigma_{2} \otimes \sigma_{3}\right)}-\bar{y} \cdot \overline{\left(\iota_{2} \wedge \iota_{1}\right)_{E *}\left(\sigma_{3} \otimes \sigma_{2}\right)}\right) .
\end{aligned}
$$

Thus RD $=\mathrm{DR}$ implies $\bar{x}=\bar{y}=1$; i.e., $x, y$ are odd integers.
Let $\Sigma \iota_{1}: \Sigma X \rightarrow \Sigma X \vee \Sigma Y$ and $\Sigma \iota_{2}: \Sigma Y \rightarrow \Sigma X \vee \Sigma Y$ be the canonical inclusions, respectively. Temporarily we define the weak second James-Hopf invariant

H^{w}(\Sigma X, \Sigma Y): \pi_{n}(\Sigma X \wedge Y) \rightarrow \pi_{n}(\Sigma X \wedge Y)
$$

by the following defined commutative diagram

\begin{gathered}
\pi_{n}(\Sigma X \vee \Sigma Y) \xrightarrow{H_{\sharp}} \pi_{n}\left(\Sigma(X \vee Y)^{\wedge 2}\right) \\
{\left[\Sigma \iota_{1}, \Sigma \iota_{2}\right] \uparrow \uparrow} \\
\pi_{n}(\Sigma X \wedge Y) \xrightarrow{p_{(\Sigma X, \Sigma Y)}}, \\
H^{w}(\Sigma X, \Sigma Y) \\
\pi_{n}(\Sigma X \wedge Y)
\end{gathered}
$$

where $p_{(\Sigma X, \Sigma Y)}$ is the projection onto the second direct summand after composing with the natural isomorphism
$\pi_{n}\left(\Sigma(X \vee Y)^{\wedge 2}\right) \cong \pi_{n}(\Sigma X \wedge X) \oplus \pi_{n}(\Sigma X \wedge Y) \oplus \pi_{n}(\Sigma Y \wedge X) \oplus \pi_{n}(\Sigma Y \wedge Y)$.
The two lemmas below follows by the naturality of the homomorphisms $H^{w}$ for appropriate spaces.
Lemma 6.2. Let $\Sigma f: \Sigma X \rightarrow \Sigma X^{\prime}, \Sigma g: Y \rightarrow \Sigma Y^{\prime}$. If

Lemma 6.3. Let $U \xrightarrow{f} V \xrightarrow{i} X \xrightarrow{q} \Sigma U$ be a homotopy cofibration which induces the short exact sequence

Lemma 6.4. $\pi_{6}\left(P^{3}\left(2^{r}\right) \wedge C_{\eta}^{5}\right)=\pi_{6}\left(C_{\eta}^{4} \wedge C_{\eta}^{5}\right)=\pi_{6}\left(C_{\eta}^{4} \wedge C_{r}^{5}\right)=0$.
Proof. By [29, Lemma 4.2], $\pi_{6}\left(P^{3}\left(2^{r}\right) \wedge C_{\eta}^{5}\right)=\pi_{7}\left(P^{4}\left(2^{r}\right) \wedge C_{\eta}^{5}\right)=0$. By the same method used in the proof of [29, Lemma 4.2], we have

$$
s k_{8}\left(C_{\eta}^{4} \wedge C_{\eta}^{5}\right) \simeq S^{7} \vee C_{\eta}^{7}, \quad s k_{8}\left(C^{4} \wedge C_{r}^{5}\right) \simeq S^{7} \vee P^{3}\left(2^{r}\right) \wedge C_{\eta}^{5}
$$

where $s k_{8}(X)$ denotes the 8 -dimensional skeleton of $X$. Thus

$$
\pi_{6}\left(C^{4} \wedge C_{\eta}^{5}\right) \cong \pi_{6}\left(C_{\eta}^{7}\right)=0, \quad \pi_{6}\left(C_{\eta}^{4} \wedge C_{r}^{5}\right) \cong \pi_{6}\left(P^{3}\left(2^{r}\right) \wedge C_{\eta}^{5}\right)=0
$$

Lemma 6.5. The weak second James-Hopf invariant

$$
H^{w}(\Sigma X, \Sigma Y): \pi_{6}(\Sigma X \wedge Y) \rightarrow \pi_{6}(\Sigma X \wedge Y)
$$

is an isomorphism for $(X, Y)=\left(S^{2}, S^{2}\right),\left(S^{2}, P^{3}\left(2^{s}\right)\right),\left(S^{3}, P^{3}\left(2^{s}\right)\right),\left(S^{3}, C^{4}\left(2^{s}\right)\right)$, $\left(P^{3}\left(2^{r}\right), P^{3}\left(2^{s}\right)\right),\left(P^{3}\left(2^{r}\right), C_{s}^{4}\right)$ and $\left(C_{r}^{4}, C_{s}^{4}\right)$.

Proof. Denote by $1_{n}$ the identity of $S^{n}$. (1) Observe that

$$
\left(\Omega \Sigma \eta_{4}\right) \circ E=\left(\Omega \Sigma 1_{2} \wedge \eta\right) \circ E=\Omega_{0}\left(\Sigma 1_{2} \wedge \eta\right)
$$

is a generator of $\pi_{5}\left(\Omega \Sigma S^{2} \wedge S^{2}\right)$. Consider the following commutative diagram

$$
\begin{aligned}
& \pi_{5}\left(\Omega \Sigma S^{2} \wedge S^{3}\right) \xrightarrow{H^{w}\left(S^{3}, S^{4}\right)} \pi_{5}\left(\Omega \Sigma S^{2} \wedge S^{3}\right) \\
& \begin{array}{l}
\downarrow\left(\Omega \Sigma 1_{2} \wedge \eta\right)_{\sharp} \\
\left.S^{2} \wedge S^{2}\right) \xrightarrow{H^{w}\left(S^{3}, S^{3}\right)} \pi_{5}\left(\Omega \Sigma 1_{2} \wedge \eta\right)_{\sharp} . \\
\left.\Omega S^{2} \wedge S^{3}\right)
\end{array}
\end{aligned}
$$

Then by Lemma 6.1 we have

$$
\begin{aligned}
H^{w}\left(S^{3}, S^{3}\right)\left(\left(\Omega \Sigma 1_{2} \wedge \eta\right) \circ E\right) & =\left(\Omega \Sigma 1_{2} \wedge \eta\right) H^{w}\left(S^{3}, S^{4}\right)(E) \\
& =\left(\Omega \Sigma 1_{2} \wedge \eta\right) p_{\left(S^{3}, S^{4}\right)} H_{\sharp}\left(\Omega_{0}\left[\Sigma \iota_{1}, \Sigma \iota_{2}\right]\right) \\
& =\left(\Omega \Sigma 1_{2} \wedge \eta\right) p_{\left(S^{3}, S^{4}\right)}\left(x \cdot\left(\iota_{1} \wedge \iota_{2}\right)_{E}\right) \\
& =\left(\Omega \Sigma 1_{2} \wedge \eta\right)(x \cdot E) \\
& =\left(\Omega \Sigma 1_{2} \wedge \eta\right) \circ E
\end{aligned}
$$

Thus $H^{w}\left(S^{3}, S^{3}\right)$ is an isomorphism.
(2) By Lemma 6.1, $H^{w}\left(S^{4}, S^{3}\right)$ is surjective. There is a commutative diagram

$$
\begin{aligned}
& \pi_{6}\left(\Sigma S^{3} \wedge S^{2}\right) \xrightarrow{H^{w}\left(S^{4}, S^{3}\right)}>\pi_{6}\left(\Sigma S^{3} \wedge S^{2}\right) \\
& \begin{array}{ll}
\downarrow\left(\Sigma 1_{3} \wedge i_{2}\right)_{\sharp} & \not{ }^{\downarrow}\left(\Sigma 1_{3} \wedge i_{2}\right)_{\sharp}, \\
\left.\wedge P^{3}\left(2^{s}\right)\right) \xrightarrow{H^{w}\left(S^{4}, P^{3}\left(2^{s}\right)\right)} \pi_{6}\left(\Sigma S^{3} \wedge P^{3}\left(2^{s}\right)\right)
\end{array}
\end{aligned}
$$

where " $\rightarrow$ " denote surjections. It follows that $H^{w}\left(S^{3}, P^{3}\left(2^{s}\right)\right)$ is an epimorphism of $\mathbb{Z} / 2^{r}$, which must be an isomorphism.
(3) There is an isomorphism

$$
\left(\Sigma 1_{2} \wedge i_{2}\right)_{\sharp}: \pi_{6}\left(\Sigma S^{2} \wedge S^{2}\right) \rightarrow \pi_{6}\left(\Sigma S^{2} \wedge P^{3}\left(2^{s}\right)\right) .
$$

Then $H^{w}\left(S^{4}, P^{4}\left(2^{s}\right)\right)$ is an isomorphism by Lemma 6.2.
(4) Recall from [3] or [18] $\pi_{n}\left(C_{r}^{n+2}\right) \cong \mathbb{Z} / 2^{r}$ and $\pi_{n+1}\left(C_{r}^{n+2}\right)=0$ for $n \geq 3$. Hence we have an isomorphism

$$
\left(1_{4} \wedge i_{P}\right)_{\sharp}: \pi_{6}\left(S^{4} \wedge P^{3}\left(2^{s}\right)\right) \rightarrow \pi_{6}\left(S^{4} \wedge C_{s}^{4}\right)
$$

which implies that $H^{w}\left(S^{4}, C_{s}^{5}\right)$ is an isomorphism.
(5) There is a short exact sequence

$$
\begin{aligned}
& 0 \rightarrow \pi_{6}\left(\Sigma S^{2} \wedge P^{3}\left(2^{s}\right)\right) \xrightarrow{\left(\Sigma i_{2} \wedge 1_{P}\right)_{\sharp}} \pi_{6}(\Sigma P^{3}\left(2^{r}\right) \wedge \\
&\left.\xrightarrow{3}\left(2^{s}\right)\right) \\
& \xrightarrow{\left(\Sigma q_{3} \wedge 1_{P}\right)_{\sharp}} \pi_{6}\left(\Sigma S^{3} \wedge P^{3}\left(2^{s}\right)\right) \rightarrow 0 .
\end{aligned}
$$

It follows by former conclusions and Lemma 6.3 that $H^{w}\left(P^{4}\left(2^{r}\right), P^{4}\left(2^{s}\right)\right)$ is an isomorphism.
(6) We may assume that $r \geq s$. Then the middle homomorphism $\left(q_{4} \wedge i d\right)_{\sharp}$ in the following exact sequence is an isomorphism:

$$
\pi_{6}\left(S^{3} \wedge C_{s}^{4}\right) \xrightarrow{\left(i_{3} \wedge i d\right)_{\sharp}} \pi_{6}\left(P^{4}\left(2^{r}\right) \wedge C_{s}^{4}\right) \xrightarrow{\left(q_{4} \wedge i d\right)_{\sharp}} \pi_{6}\left(S^{4} \wedge C_{s}^{4}\right)^{\left(2^{r} 1_{4} \wedge i d\right)_{\sharp}} \pi_{6}\left(S^{4} \wedge C_{s}^{4}\right)
$$

It follows that $H^{w}\left(P^{4}\left(2^{r}\right), C_{s}^{5}\right)$ is an isomorphism, by Lemma 6.2.
(7) By Lemma 6.4, the cofibration $S^{3} \xrightarrow{i_{3} 2^{r}} C_{\eta}^{5} \xrightarrow{i_{\eta}} C_{r}^{5} \xrightarrow{q_{4}} S^{4}$ induces the exact sequence

$$
0 \rightarrow \pi_{6}\left(C_{r}^{5} \wedge C_{s}^{4}\right) \xrightarrow{\left(q_{4} \wedge i d\right)_{\sharp}} \pi_{6}\left(S^{4} \wedge C_{s}^{4}\right) \xrightarrow{\left(2^{r} i_{4} \wedge i d\right)_{\sharp}=0} \pi_{6}\left(C_{\eta}^{6} \wedge C_{s}^{4}\right) .
$$

Thus $\left(q_{4} \wedge i d\right)_{\sharp}: \pi_{6}\left(C_{r}^{5} \wedge C_{s}^{4}\right) \rightarrow \pi_{6}\left(S^{4} \wedge C_{s}^{4}\right)$ is an isomorphism, and therefore $H^{w}\left(C_{r}^{5}, C_{s}^{5}\right)$ is an isomorphism, by Lemma 6.2.
