# THE GRUENBERG-KEGEL GRAPH OF FINITE SOLVABLE RATIONAL GROUPS

#### Abstract

A finite group $G$ is said to be rational if every character of $G$ is rational-valued. The Gruenberg-Kegel graph of a finite group $G$ is the undirected graph whose vertices are the primes dividing the order of $G$ and an edge connects a pair of different vertices $p$ and $q$ whenever $G$ has an element of order $p q$. In this paper, we complete the classification of the Gruenberg-Kegel graphs of finite solvable rational groups initiated in [BKMdR23].


In this paper $G$ is a finite group. The following three conditions are equivalent, and when they are satisfied we say that $G$ is rational.

- Every character of $G$ takes values in the field of rational numbers.
- For every element $g$ of $G$, all the generators of $\langle g\rangle$ are conjugate in $G$.
- For every $g \in G,\left[N_{G}(\langle g\rangle): C_{G}(g)\right]=\varphi(|g|)$, where $\varphi$ denotes the Euler totient function.

The Gruenberg-Kegel graph of $G$, abbreviated GK-graph of $G$, is the undirected graph $\Gamma_{G K}(G)$ whose vertices are the primes dividing the order of $G$ and an edge connects a pair of different vertices $p$ and $q$ whenever $G$ has an element of order $p q$. Some authors use the term 'prime graph' to refer to the Gruenberg-Kegel graph, but since prime graphs appear in many different contexts, we will restrict the terminology to just GK-graph.

Several mathematicians contributed to the study of the Gruenberg-Kegel graph of some classes of finite groups. For instance, if $G$ is rational and solvable, then the set of possible vertices of $\Gamma_{G K}(G)$ is contained in $\{2,3,5\}$ (see [Gow76]); while if $\Gamma_{G K}(G)$ is a tree, then its size is bounded by 8 (see [Luc02]). In [GKL $\left.{ }^{+} 15\right]$, the graphs that occur as the Gruenberg-Kegel graph of a finite solvable group are characterized in a purely graph-theoretical way. An analogue for finite groups whose order is divisible by at most five different primes is obtained in [GKKM14]. Theorem D of [BKMdR23] contains an attempt to classify the GK-graphs of finite solvable rational groups and only for one graph it remained to be decided whether it is the GK-graph of a finite solvable rational group or not. The aim of this paper is to complete this attempt. Technically, we answer negatively [BKMdR23, Question F] and hence finish the proof of the following theorem:

Theorem A. The Gruenberg-Kegel graphs of non-trivial finite solvable rational groups are precisely the following:

As a consequence we have the following:
Corollary B. If $G$ is a finite solvable rational group of order divisible by 15 , then $G$ has elements of order 6,10 and 15 .

We start fixing some basic notation and recalling some definitions. We use standard group theoretical notation. For example, $N_{G}(H)$ denotes the normalizer of a subgroup $H$ in $G$ and $C_{G}(X)$ denotes the centralizer of a subset $X$ in $G$. Moreover, $C_{n}$ and $Q_{n}$ denote the cyclic and quaternion groups of order $n$, and $\operatorname{GL}(n, q)$ and $\operatorname{SL}(n, q)$ denote the general and special linear $n$-dimensional groups over the field $\mathbb{F}_{q}$ with $q$ elements. If $G$ is a group and $p$ a prime, then $G_{p}$ denotes a Sylow $p$-subgroup of $G$.

By default a $G$-module is a right $G$-module. We use exponential notation for the action of $G$ on a $G$-module $V$ and multiplicative notation for the internal operation in $V$, i.e. we consider $V$ as an abelian multiplicative group, and if $g \in G$ and $v \in V$, then $v \cdot g=v^{g}$. Then $V \rtimes G$ denotes the corresponding semidirect product, so that $v^{g}=g^{-1} v g$. In this paper we use always this notation for an elementary abelian 5 -group $V$. Then we consider $V$ as a right $\mathbb{F}_{5} G$-module, where $\mathbb{F}_{5}=\mathbb{Z} / 5 \mathbb{Z}$, the field with 5 elements. In other words, if $v \in V, \alpha \in \mathbb{F}_{5}$ and $g \in G$, then $v \cdot \alpha=v^{\alpha}$, where $\alpha$ is identified with an integer modulo 5 , and $v \cdot g=v^{g}=g^{-1} v g$. Although we consider $V$ as a multiplicative group inside the semidirect product $V \rtimes G$, we take advantage of considering $V$ as a vector space over $\mathbb{F}_{5}$ to use standard
linear algebra notation. For example, in some cases $V$ is going to be identified with $\mathbb{F}_{5}^{n}$ for some integer $n$ and if $K$ is the kernel of the action of $G$ on $V$, then $G / K$ is identified with a subgroup of $\operatorname{GL}(n, 5)$ (see e.g., Proposition 1 below).

We say that $V_{G}$ has the eigenvector property if for every $\alpha \in \mathbb{F}_{5} \backslash\{0\}$, every element $v$ of $V$ is an eigenvector with eigenvalue $\alpha$ for some $g \in G$, i.e. $v^{g}=v^{\alpha}$. As the group of units of $\mathbb{F}_{5}$ is generated by $2, V_{G}$ has the eigenvector property if and only if for every $v \in V$, there is some $g \in G$ such that $v^{g}=v^{2}$.

If $H$ is a subgroup of $G$ and $W$ is an $H$-module, then $W^{G}$ denotes the induced $G$-module, i.e. $W^{G}=$ $\bigoplus_{t \in T} W^{t}$, where $T$ is a right transversal of $H$ in $G$ and if $w \in W, t \in T, g \in G$ and $t g=h r$ with $h \in H$ and $r \in T$, then $\left(w^{t}\right)^{g}=\left(w^{h}\right)^{r}$. Observe that if $w \in W \backslash\{1\}$ and $g \in G$, then $w^{g} \in W$ if and only if $g \in H$. In particular, $\operatorname{Stab}_{G}(W)=H$.

By a theorem by P. Hegedüs, a Sylow 5 -subgroup of a finite solvable rational group is normal and elementary abelian [Heg05]. Our proof relies on the following proposition which is one of the main ingredients in the proof of Hegedüs' Theorem.
Proposition 1 ([Heg05], Section 4.9). Let $G$ be a finite solvable rational group such that the Sylow 5subgroup $V$ of $G$ is minimal normal. Let $S$ be a complement of $V$ in $G$, and regard $V$ as an $\mathbb{F}_{5} S$-module. Let $H$ be a minimal subgroup of $S$ such that there exists an $\mathbb{F}_{5} H$-submodule $W$ of $V$ with $V=W^{S}$ and the Brauer character of $W$ is rational. Let $K=C_{S}(W)$. Then one of the following holds:
(a) $H / K \cong Q_{8}$ and $W=\mathbb{F}_{5}^{2}$.
(b) $H / K \cong C_{3} \rtimes C_{4}$ and $W=\mathbb{F}_{5}^{2}$.
(c) $H / K \cong \mathrm{SL}(2,3)$ and $W=\mathbb{F}_{5}^{2}$.
(d) $H / K$ is isomorphic to the subgroup of $\operatorname{GL}(4,5)$ generated by

where the action by conjugation on $W=\mathbb{F}_{5}^{4}$ is given by right multiplication.
(e) $H / K$ is isomorphic to the subgroup of $\mathrm{GL}(4,5)$ generated by $\alpha, \beta$ and $\gamma^{2}$, where the action by conjugation on $W=\mathbb{F}_{5}^{4}$ is given by right multiplication.
(f) $H / K$ has order 144 .

A group $G$ is said to be cut if for every $g \in G$, every generator of $\langle g\rangle$ is conjugate to $g$ or $g^{-1}$ in $G$. Another important tool for our proof is the following lemma.

Lemma 2 ([BKMdR23], Lemma 3.5). Let $G$ be a finite cut group and let $G_{p}$ and $G_{q}$ be Sylow subgroups of $G$ for two distinct primes $p$ and $q$ dividing the order of $G$. Suppose that $G_{p}$ is normal in $G$ and $G$ does not contain an element of order pq. Then $G_{q}$ is either the quaternion group of order 8 or a cyclic group of order dividing 4 or $q$.

We start now the proof of Theorem A. By Theorem D in [BKMdR23], it suffices to prove that $(3-2-5)$ is not the GK-graph of a finite solvable rational group. By means of contradiction we fix a finite solvable rational group $G$ of minimal order with $\Gamma_{G K}(G)=(3-2-5)$. By Hegedüs Theorem, $G$ has a unique Sylow 5 -subgroup $V$, which is elementary abelian. Then $G=V \rtimes S$, where $S$ is a $\{2,3\}$-Hall subgroup $S$ of $G$. Thus we consider $V$ as a right $\mathbb{F}_{5} S$-module as explained above. Moreover, $S$ is rational since the class of solvable rational groups is closed under epimorphic images.

The rationality condition implies that $V_{S}$ has the eigenvector property. In other words, for every $v \in V$ there exists some $s \in S$ so that $v^{s}=v^{2}$.

Moreover, if $U$ is a normal subgroup of $G$ such that $U$ is properly contained in $V$, then $G / U$ is a rational solvable group whose GK-graph is $(3-2-5)$ by Theorem D in [BKMdR23]. Then $U=1$ because of the minimality of $G$. Thus, $V$ is a minimal normal subgroup of $G$, or equivalently, $V_{\mathbb{F}_{5} S}$ is simple.

As every rational group is cut, Lemma 2 applies to $G$ and hence a Sylow 3 -subgroup of $S$ is cyclic of order 3. We fix a Sylow 2-subgroup $S_{2}$ of $S$. Observe that $S_{2}$ is not normal in $S$, since otherwise $S / S_{2} \cong C_{3}$ would be rational. Thus $S$ has exactly three Sylow 2-subgroups, namely $S_{2}, S_{2}^{a}$ and $S_{2}^{a^{2}}$, where $a$ is any element of $S$ of order 3 . As $G$ has not elements of order 15, if $v \in V \backslash\{1\}$, then $v^{a} \neq v$.

The action of $S$ on $V$ is faithful. Indeed, otherwise the kernel $N$ of this action is a normal non-trivial 2-subgroup of $G$ such that $G / N$ is a solvable rational group with $\Gamma_{G K}(G / N)=(3-2-5)$ by Theorem D in [BKMdR23], in contradiction with the minimality hypothesis.

Lemma 3. Let $H$ be a subgroup of $S$ and $W a \mathbb{F}_{5} H$-submodule of $V$. If $V=W^{S}$, then the action of $H$ on $W$ has the eigenvector property and $H$ contains all the elements of order 3 of $S$.

Proof. Let $a$ be an element of $S$ of order 3 and $w \in W \backslash\{1\}$. Take $v=w w^{a} w^{a^{2}}$. As $v^{a}=v$, necessarily $v=1$ and hence $a \in H$. Moreover, from the eigenvector property of $V_{S}$, there exists $s \in S$ such that $w^{s}=w^{2} \in W \cap W^{s}$, and necessarily $s \in H$, as desired.

From now on, $H$ is a minimal subgroup of $S$ such that there exists an $\mathbb{F}_{5} H$-submodule $W$ with $V=W^{S}$ and with rational Brauer character. Then the kernel $K$ of the action of $H$ on $W$ is a 2-group. Applying Lemma 3 we conclude that $H$ contains all the elements of order 3 of $S$ and has the eigenvector property on $W$. We fix an element $a$ of $S$ of order 3. Let $A$ denote the subgroup of $S$ generated by the elements of order 3 ; then $A$ is the smallest normal subgroup of $S$ containing $a$, and $|A|=3$ if and only if $S$ has a normal Sylow 3-subgroup. Otherwise $A / A^{\prime}$ is an abelian 3-group with $\left[A: A^{\prime}\right]=3$. Therefore, in any case $A_{2}=A^{\prime}$ is the unique Sylow 2-subgroup of $A$, and hence it is normal in $S$. Moreover, as $\langle a\rangle$ is a Sylow 3 -subgroup of $A$ and as $A$ is normal in $S$, the Frattini argument implies that $S=A N_{S}(\langle a\rangle)$. As $A \subseteq H$, we also have $S=H N_{S}(\langle a\rangle)$ and hence $N_{S}(\langle a\rangle)$ contains a right transversal $T$ of $H$ in $S$ containing 1 which will be fixed throughout. So $V=\bigoplus_{t \in T} W^{t}$.

Moreover, $H / K$ is one of the groups of Proposition 1. Observe that cases (a) and (f) can be immediately excluded, as the former does not contain elements of order 3 , while in the latter 9 divides $|H / K|$ but a Sylow 3 -subgroup of $S$ has order 3, by Lemma 2. Thus from now on $W, H$ and $K$ are as in one of the cases (b), (c), (d) and (e) of Proposition 1. In Lemma 8 we prove that (b) cannot hold, and in Lemma 9 we prove that cases (d) and (e) are also not possible. The proof finishes by dismissing case (c), which requires an ad hoc argument.
Lemma 4. $\operatorname{Core}_{S}(K)=\bigcap_{s \in S_{2}} K^{s}=\bigcap_{t \in T} K^{t}=1$.
Proof. First of all, by Lemma $3,\langle a\rangle \subseteq H \subseteq N_{S}(K)$. Moreover, $\langle a\rangle$ is a left transversal of $S_{2}$ in $S$. Thus $\operatorname{Core}_{S}(K)=\bigcap_{s \in S_{2}} \bigcap_{i=0}^{2} K^{a^{i} s}=\bigcap_{s \in S_{2}} K^{s}$.

Now it suffices to see that $\bigcap_{t \in T} K^{t}=1$. Take $x \in \bigcap_{t \in T} K^{t}$ and for every $t \in T$ let $k_{t}=t x t^{-1}$. Let $v$ be an arbitrary element of $V$. Then $v=\prod_{t \in T} w_{t}{ }^{t}$ for unique $w_{t} \in W$ for each $t \in T$. As each $k_{t} \in K$,

v^{x}=\prod_{t \in T} w_{t}^{t x}=\prod_{t \in T} w_{t}^{k_{t} t}=\prod_{t \in T} w_{t}^{t}=v
$$

Therefore $x$ belongs to the kernel of the action of $S$ on $V$. As this action is faithful, $x=1$.
Lemma 5. $|A|=3$ if and only if $H / K \cong C_{3} \rtimes C_{4}$.
Proof. Clearly $|A|=3$ if and only if $A=\langle a\rangle$ if and only if $\langle a\rangle$ is normal in $S$. In that case, $K\langle a\rangle / K$ is a normal Sylow 3 -subgroup of $H / K$ and considering the four options (b), (c), (d) and (e) of Proposition 1 it follows that $H / K \cong C_{3} \rtimes C_{4}$. Conversely, suppose that $H / K \cong C_{3} \rtimes C_{4}$. Then $A \subseteq\langle K, a\rangle \triangleleft H$ and hence $[A,\langle a\rangle] \subseteq[K,\langle a\rangle] \subseteq K$. Moreover, as $T \subseteq N_{S}(\langle a\rangle)$, for every $t \in T$ we have $[A,\langle a\rangle]=\left[A^{t},\left\langle a^{t}\right\rangle\right] \subseteq K^{t}$, and therefore $[A,\langle a\rangle] \subseteq \bigcap_{t \in T} K^{t}=\operatorname{Core}_{S}(K)=1$, by Lemma 4. Therefore, $a$ is central in $A$ and as $A$ is generated by elements of order 3 and its Sylow 3-subgroup has order 3 necessarily $A=\langle a\rangle$.

We define $L$ as the smallest subgroup of $H$ containing $K$ and the elements of order 3 of $S$, that is $L=K A$. Note that $L$ and $L_{2}=K A_{2}$ are both normal in $H$. By inspecting the four options for $H / K$ it follows that

L / K \cong \begin{cases}C_{3}, & \text { if } H / K \cong C_{3} \rtimes C_{4} ;  \tag{2}\\ \operatorname{SL}(2,3), & \text { otherwise }\end{cases}
$$

Lemma 6. $Z(S) \neq 1$ and if $H / K \not \approx C_{3} \rtimes C_{4}$, then $Z(S) \cap A_{2} \cong C_{2}$.
Proof. Suppose that $H / K \cong C_{3} \rtimes C_{4}$. Then the Sylow 3-subgroup $\langle a\rangle$ of $S$ is normal in $S$, by Lemma 5 , and therefore so is $C_{S}(a)_{2}$ by the Frattini argument. Moreover, $|S| \geq 12$ and by the rationality hypothesis, $\left[S: C_{S}(a)\right]=\left[N_{S}(\langle a\rangle): C_{S}(a)\right]=2$. Thus $C_{S}(a)_{2} \neq 1$. In particular, $1 \neq C_{S}(a)_{2} \cap Z\left(S_{2}\right) \subseteq Z(S)$, as desired.

Suppose that $H / K \not \approx C_{3} \rtimes C_{4}$. By Lemma 5, $A_{2}$ is a non-trivial Sylow 2-subgroup of $A$ and hence $L_{2}=K A_{2}$ is the unique Sylow 2-subgroup of $L$. As $A_{2}$ is normal in $S$, there is $z \in A_{2} \cap Z\left(S_{2}\right)$ with $z \neq 1$.

We claim that $z \notin K^{s}$ for every $s \in S_{2}$. Indeed, if $s \in S_{2}$ with $z \in K^{s}$, then for every $x \in S_{2}$ we have $z=z^{s^{-1} x} \in K^{x}$. Thus $z \in \bigcap_{x \in S_{2}} K^{x}=1$, by Lemma 4, yielding a contradiction.

Let $s \in S_{2}$ and recall that $L / K \cong \mathrm{SL}(2,3)$ and hence $|Z(L / K)|=\left|Z\left(L_{2} / K\right)\right|=2$. Since $z \in A_{2} \cap Z\left(S_{2}\right)$, we have $z \in Z\left(L_{2}^{s}\right)$. Then $K^{s} z \in Z\left(L_{2}^{s} / K^{s}\right), a \in A=A^{s} \subseteq L^{s}$ and $\left|K^{s} a\right|=3$. Thus $\left|K^{s} z\right|=2$ and $\left|K^{s} z a\right|=6$ because $z \notin K^{s}$. Denote by $z_{2}$ the 2 -part of $z a$ and $z_{3}$ its 3 -part. Thus, $K^{s} z a=K^{s} z_{2} z_{3}$ and $K^{s} z=K^{s} z_{2}$ because of uniqueness of the 2-part. This shows that $z z_{2}^{-1} \in K^{s}$ for every $s \in S_{2}$. By

Lemma $4, z=z_{2}$ and hence $z_{3}=z_{2}^{-1} z a=a$, so that $z$ commutes with $a$. It follows that $z \in Z\left(S_{2}\right) \cap$ $C_{S}(a) \subseteq Z(S)$. Thus $1 \neq\langle z\rangle \subseteq Z(S) \cap A_{2}$. The result follows since $\left|Z(S) \cap A_{2}\right| \leq 2$ because $\mathrm{Z}(S) \cap A_{2} \subseteq L$ and, as $Z(S) \cap K=1$, by Lemma 4, we have that $Z(S) \cap A_{2} \cong K\left(Z(S) \cap A_{2}\right) / K \subseteq Z(L / K) \cong C_{2}$.

The following lemma also holds in the case where $H / K \cong \mathrm{SL}(2,3)$ but since its proof uses a different argument, we delay it until Lemma 11.

Lemma 7. Let $H / K$ be one of the groups in cases (b), (d) or (e) of Proposition 1. Then $C_{S}(a) \nsubseteq H$.
Proof. Observe that $L_{2} a$ is not central in $H / L_{2}, S=A_{2} N_{S}(\langle a\rangle)$ and $H$ is not rational. Thus $H \cap$ $N_{S}(\langle a\rangle) \nsubseteq C_{S}(a)$ and $N_{S}(\langle a\rangle) \nsubseteq H$. Since $\left[N_{S}(\langle a\rangle): C_{S}(a)\right]=2$, the lemma follows.

It is clear that $C_{S}(a)$ has a unique Sylow 2-subgroup which we denote $C_{S}(a)_{2}$.
Lemma 8. $H / K$ is not isomorphic to $C_{3} \rtimes C_{4}$.
Proof. Suppose that $H / K \cong C_{3} \rtimes C_{4}$. Let $u \in W \backslash\{1\}$. By Lemma $3, H$ contains an element $b$ such that $u^{b}=u^{2}$. Then $|K b|=4, H=\langle K, a, b\rangle$ and $a^{b} \in K a^{2}$. Define $v=u^{a}$ and observe that $\{u, v\}$ is a basis of $W$ since conjugation by $a$ has no fixed points in $W \backslash\{1\}$. As $G$ has not elements of order 15 , au has order 3 and hence $1=(a u)^{3}=u^{a^{2}} u^{a} u=v^{a} v u$. Thus $v^{a}=u^{4} v^{4}$. Moreover, $v^{b}=u^{a b}=u^{b a^{2}}=\left(u^{2}\right)^{a^{2}}=$ $\left(v^{a}\right)^{2}=u^{3} v^{3}$. Thus the $H$-orbit of $u$ in $W$ is $\mathcal{O}_{u}=\left\{u^{i}, v^{i},(u v)^{i}: i=1, \ldots, 4\right\}$.

Furthermore, $H / K$ has exactly 6 elements of order 4 , while $W$ has exactly 6 subspaces of dimension 1 . By the eigenvector property of $W_{H}$, for every $w \in W \backslash\{1\}$, the set $X_{w}=\left\{K h \in H / K: w^{h}=w^{2}\right\}$ is not empty. In addition, no element of order 4 of $H / K$ is central and hence $X_{u} \cap X_{v}=\emptyset$ whenever $W=\langle u, v\rangle$. Therefore, $\left|X_{w}\right|=1$ for every $w \in W \backslash\{1\}$ and hence there is a bijection from the set of one-dimensional subspaces of $W$ to the set of elements of order 4 of $H / K$, associating $\langle w\rangle$ with the unique element of $X_{w}$.

By Lemma 7, we may assume that $T \backslash\{1\}$ contains an element $d$ in $C_{S}(a)_{2}$. By the eigenvector property of $V_{S}$, there is a 2-element $s \in S$ such that $\left(u\left(u^{2} v\right)^{d}\right)^{s}=\left(u\left(u^{2} v\right)^{d}\right)^{2}$. If $u^{s}=\left(\left(u^{2} v\right)^{d}\right)^{2}$ then $u^{s d^{-1}}=u^{4} v^{2} \in W$, so $s d^{-1} \in H$ and it follows that $u^{4} v^{2} \in \mathcal{O}_{u}$, a contradiction. Hence $u^{s}=u^{2}$ and $\left(u^{2} v\right)^{d s}=\left(\left(u^{2} v\right)^{d}\right)^{2}=\left(u^{4} v^{2}\right)^{d}$. Thus $s, d s d^{-1} \in H, X_{u}=\{K b\}=\{K s\}$ and $X_{u^{2} v}=\left\{K d s d^{-1}\right\}$.

Notice that $C_{S}(a)$, and therefore $C_{S}(a)_{2}$, are both normal in $S$ by Lemma 5 . As $d \in C_{S}(a)_{2}$ also $\left[s, d^{-1}\right] \in C_{S}(a)_{2} \cap H$. Thus $K\left[s, d^{-1}\right] \in K C_{H}(a)_{2} / K \subseteq C_{H / K}(K a)_{2}=\left\langle K b^{2}\right\rangle$. Therefore $w^{\left[s, d^{-1}\right]} \in$ $\left\{w, w^{-1}\right\}$ for every $w \in W$. Moreover, $s=k b$ for some $k \in K$ and $u^{4} v^{2}=\left(u^{2} v\right)^{d s d^{-1}}=\left(u^{2} v\right)^{s\left[s, d^{-1}\right]}=$ $\left(u^{2} v\right)^{k b\left[s, d^{-1}\right]}=\left(u^{2} v^{3}\right)^{\left[s, d^{-1}\right]} \in\left\{u^{2} v^{3}, u^{3} v^{2}\right\}$, the desired contradiction.

In the latter proof we used that $C_{S}(a)_{2}$ was normal to dismiss case (b). In the proof for cases (d) and (e) we will use the same idea with the normal subgroup $A_{2} C_{S}(a)_{2}$ instead of $C_{S}(a)_{2}$.

Lemma 9. $H / K$ is neither isomorphic to $\langle\alpha, \beta, \gamma\rangle$ nor $\left\langle\alpha, \beta, \gamma^{2}\right\rangle$.
Proof. Suppose that $H / K$ is isomorphic to one of the groups in the statement, acting on $W=\mathbb{F}_{5}^{4}$ as in Proposition 1. To simplify notation we identify $H / K$ with the corresponding group of matrices. We start with a series of basic facts about these groups and their actions that follow from straightforward computations on GAP [GAP16]. The subgroup of $H / K$ generated by the 3 -elements of $H / K$ and its Sylow 2-subgroup are

L / K=\left\langle\alpha, \gamma^{-1} \alpha \gamma\right\rangle \quad \text { and } \quad(L / K)_{2}=\left\langle\alpha \gamma^{-1} \alpha \gamma, \gamma^{-1} \alpha \gamma \alpha\right\rangle,
$$

respectively. Moreover

$$
C_{H / K}(\alpha)_{2}= \begin{cases}\left\langle\alpha \gamma \beta \alpha, \alpha \beta \gamma(\alpha \beta)^{2}\right\rangle, & \text { if } H / K \text { is }\langle\alpha, \beta, \gamma\rangle ; \\ \left\langle\alpha \gamma \beta \alpha^{2} \beta \gamma(\alpha \beta)^{2}\right\rangle, & \text { if } H / K \text { is }\left\langle\alpha, \beta, \gamma^{2}\right\rangle\end{cases}
$$

and $C_{H / K}(\alpha)_{2}$ is normal in $H / K$. The elements

$$
u=(0,1,1,1) \quad \text { and } \quad v=(0,1,1,2)
$$

of $W$ lie in two different $H / K$-orbits. Moreover, the matrices

$$
\mu_{u}=\left(\begin{array}{llll}
0 & 0 & 3 & 2 \\
0 & 0 & 2 & 2 \\
4 & 1 & 0 & 0 \\
1 & 1 & 0 & 0
\end{array}\right) \quad \text { and } \quad \mu_{v}=\left(\begin{array}{cccc}
0 & 0 & 4 & 2 \\
0 & 0 & 2 & 4 \\
3 & 1 & 0 & 0 \\
1 & 3 & 0 & 0
\end{array}\right)
$$

belong to $\left\langle\alpha, \beta, \gamma^{2}\right\rangle$ and they are the unique matrices in $\langle\alpha, \beta, \gamma\rangle$ such that $u \cdot \mu_{u}=2 \cdot u$ and $v \cdot \mu_{v}=2 \cdot v$. Here we are using additive notation. Moreover

$$
\mu_{u}^{-1} \mu_{v}=\left(\begin{array}{cccc}
4 & 1 & 0 & 0  \tag{3}\\
2 & 2 & 0 & 0 \\
0 & 0 & 2 & 3 \\
0 & 0 & 4 & 4
\end{array}\right) \notin(L / K)_{2} C_{H / K}(\alpha)_{2}
$$

Now we put together all this information to find a contradiction. Since $C_{H / K}(\alpha)_{2}$ is normal in $H / K$ and $\langle K a\rangle$ and $\langle\alpha\rangle$ are conjugate in $H / K$, we derive that $C_{H / K}(\alpha)_{2}=C_{H / K}(K a)_{2}$.

By Lemma 7, we may assume that $T \backslash\{1\}$ contains an element $d$ in $C_{S}(a)_{2}$. In particular, $d \in A_{2} C_{S}(a)_{2}$. By rationality, there is an element $s \in S$ such that $\left(u v^{d}\right)^{s}=\left(u v^{d}\right)^{2}$. If $u^{s}=\left(v^{d}\right)^{2}$ and $v^{d s}=u^{2}$ then $s d^{-1} \in H$, so $u$ and $v^{2}$ lie in the same $H / K$-orbit and hence so do $u$ and $v$, yielding a contradiction. Then $u^{s}=u^{2}$ and $v^{d s}=\left(v^{d}\right)^{2}$. Thus $v^{d s d^{-1}}=v^{2}$ and $s, d s d^{-1} \in H$. Therefore by uniqueness,

$$
\mu_{u}=K s \quad \text { and } \quad \mu_{v}=K d s d^{-1}=K s\left[s, d^{-1}\right]=\mu_{u} \cdot K\left[s, d^{-1}\right] .
$$

As $A_{2} C_{S}(a)_{2}$ is normal in $S$ and $d \in A_{2} C_{S}(a)_{2}$, we have $\left[s, d^{-1}\right] \in A_{2} C_{S}(a)_{2} \cap H=A_{2}\left(C_{S}(a)_{2} \cap H\right)=$ $A_{2} C_{H}(a)_{2}$ and hence $\mu_{u}^{-1} \mu_{v}=K\left[s, d^{-1}\right] \in(L / K)_{2} C_{H / K}(K a)_{2}$, in contradiction with (3).

Thus necessarily $H / K \cong \mathrm{SL}(2,3)$ and $W=\mathbb{F}_{5}^{2}$. This case appears to be different from the previous ones, as in those our strategy consisted in finding elements $u, v \in W \backslash\{1\}$ lying in different $H$-orbits, and then exploiting this fact and that the element $u v^{d}$ is rational to find a contradiction, while, in the present setting, $H$ acts transitively on $W \backslash\{1\}$. This situation requires a new strategy, this time exploiting that the action of $H_{2}$ on $W \backslash\{1\}$ has three different orbits, which we use to construct an element $\mathbf{v} \in V$ in a slightly less straightforward manner. Then, by rationality there is a 2-element $s \in S$ such that $\mathbf{v}^{s}=\mathbf{v}^{2}$. We conclude the proof using $s$ to construct a non-trivial element in $C_{S}(a) \cap\left(\bigcap_{t \in T_{0}} K^{t}\right)$, contradicting Lemma 10 below.

We first recall a series of facts: $H=L=K A$, and, by Lemma $6, Z(S) \cap A_{2} \cong C_{2}$. We define $z$ to be the non-trivial central element of $S$ contained in $A_{2}$. By Lemma $4, z \notin K$ and hence $K z$ is the unique element of order 2 of $H / K$.

As $S$ is rational, there exists a 2 -element $b \in N_{S}(\langle a\rangle)$ such that $a^{b}=a^{2}$. Moreover, $b \notin H$, since $C_{H / K}(K a)=N_{H / K}(K a)$. Then $S=A C_{S}(a)\langle b\rangle$. We define $N:=A C_{S}(a)$, which has index 2 in $S$. Clearly, $N$ and its unique Sylow 2-subgroup $N_{2}$ are normal in $S$, and we can assume that $S_{2}=N_{2}\langle b\rangle$. Notice that a transversal $T_{0}$ of $H_{2}$ in $N_{2}$ is also a transversal of $H$ in $N$, so we can assume that $T=T_{0} \cup T_{0} b$, where $T_{0}$ contains 1 and is contained in $C_{S}(a)_{2}$. Let $V_{0}:=\bigoplus_{t \in T_{0}} W^{t}$. Then $V=V_{0} \oplus V_{0}^{b}$ and, in the action of $S$ on $V$, the elements of $N$ stabilize $V_{0}$ and $V_{0}^{b}$, while the elements of $S \backslash N$ interchange $V_{0}$ and $V_{0}^{b}$.

Lemma 10. $C_{S}(a) \cap\left(\bigcap_{t \in T_{0}} K^{t}\right)=1$.
Proof. Let $c \in C_{S}(a) \cap\left(\bigcap_{t \in T_{0}} K^{t}\right)$. By rationality, there is some 2-element $s \in S$ such that $c^{s}=c$ and $a^{s}=a^{2}$. Since no element $s$ in $N$ satisfies the second condition, we derive that $s=g b$ for some $g \in N$. Since $K$ is normal in $H, \operatorname{Core}_{N}(K)=\bigcap_{t \in T_{0}} K^{t}$ is normal in $N$. Thus

$$
c=c^{s} \in\left(\bigcap_{t \in T_{0}} K^{t}\right)^{s}=\bigcap_{t \in T_{0}} K^{t b} .
$$

Then $c \in \bigcap_{t \in T} K^{t}$, so $c=1$ by Lemma 4 .
As a consequence, we obtain the version in this case of Lemma 7:
Lemma 11. $\left|T_{0}\right|>1$. Equivalently, $C_{S}(a) \nsubseteq H$.
Proof. Suppose that $\left|T_{0}\right|=1$. Then $N=H$ and $[S: H]=2$. If in addition $K=1$, then $S$ is a rational group of order 48 which has a normal subgroup isomorphic to $Q_{8}$ but has not a normal Sylow 3-subgroup. A straightforward GAP [GAP16] computation shows that such group does not exists. Therefore there is some $k \in K$ with $k \neq 1$. Then $k^{b} \in H \backslash K$, since otherwise $k \in K \cap K^{b}=1$, by Lemma 4. Moreover we may assume that $K k^{b}$ has order 2 , just by substituting $k$ by $k^{2}$ if $K k^{b}$ has order 4 . Thus $K k^{b}=K z$. This implies that $[k, a]$ acts trivially on $W$ and $W^{b}$, and hence on $V$, so by faithfulness, $k$ commutes with $a$. This contradicts Lemma 10.

Next we obtain some extra information on the structure of $H$.
Lemma 12. There is an element $\mathbf{i} \in A_{2}$ such that:
(a) ai has order 3 and $\mathbf{i}^{a^{2}} \mathbf{i}^{a} \mathbf{i}=1$.
(b) $\mathbf{i}^{t}=\mathbf{i}$ for each $t \in T_{0}$ and $\mathbf{i}^{b}=\mathbf{i}^{a} \mathbf{i}=\mathbf{i}^{b^{-1}}$.
(c) $\mathbf{i}^{2}=z$.
(d) $\left\langle\mathbf{i}, \mathbf{i}^{a}\right\rangle \cong Q_{8}$ and $\langle\mathbf{i}, a\rangle \cong \operatorname{SL}(2,3)$.
(e) $H_{2}=K \rtimes\left\langle\mathbf{i}, \mathbf{i}^{a}\right\rangle$ and $H=K \rtimes\langle\mathbf{i}, a\rangle$.
(f) $H^{t}=K^{t} \rtimes\left\langle\mathbf{i}, \mathbf{i}^{a}\right\rangle$ for each $t \in T$.

Proof. Consider $N_{S_{2}}(\langle a\rangle)$ acting by conjugation on the set $\mathcal{S}_{3}(A)$ of Sylow 3 -subgroups of $A$. By Sylow theorem, the cardinality of $\mathcal{S}_{3}(A)$ is a power of 2 , which is different from 1 , because $\langle K a\rangle$ is not normal in $H / K$ and hence $\langle a\rangle$ is not normal in $S$. Since the group acting is a 2-group and $\langle a\rangle$ is a fixed point of this action, there must be another fixed point, say $\langle a \mathbf{i}\rangle$ for some $1 \neq \mathbf{i} \in A_{2}$. Then $\mathbf{i}^{a^{2}} \mathbf{i}^{a} \mathbf{i}=1$ because $a \mathbf{i}$ has order 3 so (a) is proved.

Moreover, working modulo $A_{2}$ it is clear that $(a \mathbf{i})^{t}=a \mathbf{i}$ for every $t \in T_{0}$ and $(a \mathbf{i})^{b}=(a \mathbf{i})^{2}=a^{2} \mathbf{i}^{a} \mathbf{i}$. Thus $\mathbf{i}^{t}=\mathbf{i}$ for each $t \in T_{0}$ and $\mathbf{i}^{b}=\mathbf{i}^{a} \mathbf{i}=\left(\mathbf{i}^{-1}\right)^{a^{2}}$, so $\mathbf{i}^{b^{-1}}=\mathbf{i}^{b}$, since $b^{2} \in C_{S}(\mathbf{i})$. This proves (b).

If $\mathbf{i} \in K$, then $\mathbf{i}=\mathbf{i}^{t} \in K^{t}$ and $\mathbf{i}=\left(\mathbf{i}^{a} \mathbf{i}\right)^{t b} \in K^{t b}$ for every $t \in T_{0}$, so that $1 \neq \mathbf{i} \in \bigcap_{t \in T} K^{t}=1$, a contradiction. Thus $\mathbf{i} \notin K$. Moreover $\mathbf{i}^{2} \notin K$, since otherwise $K \mathbf{i}$ is an element of order 2 in $H_{2} / K$, so $\mathbf{i}=k z$ for some $k \in K$. Then $1=\mathbf{i}^{a^{2}} \mathbf{i}^{a} \mathbf{i}=k^{a^{2}} k^{a} k z \in K z$, a contradiction. Therefore $K \mathbf{i}$ has order 4. Thus $K \mathbf{i}^{2}$ has order 2, and hence $\mathbf{i}^{2}=k z$ for some $k \in K$. Then $k z=\mathbf{i}^{2}=\left(\mathbf{i}^{2}\right)^{t}=k^{t} z$ and $k^{t b} z=\left(\mathbf{i}^{2}\right)^{t b}=\left(\mathbf{i}^{a} \mathbf{i}\right)^{2}=\left(\left(\mathbf{i}^{-1}\right)^{a^{2}}\right)^{2}=\left(\mathbf{i}^{-2}\right)^{a^{2}}=\left(k^{-1}\right)^{a^{2}} z$ for each $t \in T_{0}$. This implies that $k \in \bigcap_{t \in T} K^{t}$, so $k=1$ by Lemma 4 . This proves (c).

Summarizing, we have that $\mathbf{i}^{4}=a^{3}=1, \mathbf{i}^{a^{2}} \mathbf{i}^{a} \mathbf{i}=1$ and that $\mathbf{i}^{2}=z$ commutes with $a$. This implies that $\langle a, \mathbf{i}\rangle \cong \mathrm{SL}(2,3)$ since the above relations form a presentation of $\operatorname{SL}(2,3)$, and the order of $\langle\mathbf{i}, a\rangle$ is at least 24 because $|\mathbf{i}|=4,|a|=3$ and $\mathbf{i}^{a} \notin\left\{\mathbf{i}, \mathbf{i}^{-1}\right\}$. This proves (d) and (e) because $\left\langle\mathbf{i}, \mathbf{i}^{a}\right\rangle$ has order 8 and does not intersect $K$. Now, (f) follows from (e) and (b).

Fix i satisfying the conditions in Lemma 12. Observe that $\mathrm{SL}(2,3)$ has six elements of order 4 and they are not central. Arguing as in the proof of Lemma 8, we derive that there is $u \in W \backslash\{1\}$ such that $u^{\mathbf{i}}=u^{2}$. We denote

$$
\mathbf{j}=\mathbf{i}^{a}, \quad \mathbf{k}=\mathbf{j}^{a}, \quad u_{\mathbf{i}}=u, \quad u_{\mathbf{i}^{-1}}=u_{\mathbf{i}}^{\mathbf{j}}, \quad u_{\mathbf{j}}=u_{\mathbf{i}}^{a}, \quad u_{\mathbf{j}^{-1}}=u_{\mathbf{i}^{-1}}^{a}, \quad u_{\mathbf{k}}=u_{\mathbf{j}}^{a}, \quad \text { and } \quad u_{\mathbf{k}^{-1}}=u_{\mathbf{j}^{-1}}^{a}
$$

Then $W=\left\langle u_{\mathbf{i}}\right\rangle \times\left\langle u_{\mathbf{i}^{-1}}\right\rangle, I=\left\{\mathbf{i}, \mathbf{i}^{-1}, \mathbf{j}, \mathbf{j}^{-1}, \mathbf{k}, \mathbf{k}^{-1}\right\}$ is the set of elements of order 4 of $\langle a, \mathbf{i}\rangle$, and for every $w \in W \backslash\{1\}$ and $l \in I$

$$
w^{l}=w^{2} \text { if and only if } w \in\left\langle u_{l}\right\rangle
$$

Furthermore, the orbits of the action of $H_{2}$ on $W$ are

$$
\mathcal{O}_{\mathbf{i}}=\left\langle u_{\mathbf{i}}\right\rangle \cup\left\langle u_{\mathbf{i}^{-1}}\right\rangle \backslash\{1\}, \quad \mathcal{O}_{\mathbf{j}}=\left\langle u_{\mathbf{j}}\right\rangle \cup\left\langle u_{\mathbf{j}^{-1}}\right\rangle \backslash\{1\} \quad \text { and } \quad \mathcal{O}_{\mathbf{k}}=\left\langle u_{\mathbf{k}}\right\rangle \cup\left\langle u_{\mathbf{k}^{-1}}\right\rangle \backslash\{1\}
$$

and they are permuted cyclically by the action of $\langle a\rangle$, i.e.

$$
\mathcal{O}_{\mathbf{i}}^{a}=\mathcal{O}_{\mathbf{j}}, \quad \mathcal{O}_{\mathbf{j}}^{a}=\mathcal{O}_{\mathbf{k}} \quad \text { and } \quad \mathcal{O}_{\mathbf{k}}^{a}=\mathcal{O}_{\mathbf{i}}
$$

Recall that $V=W^{S}=\bigoplus_{t \in T} W^{t}$. In the remainder of the proof we fix the following element of $V$ :

$$
\mathbf{v}=\prod_{t \in T} w_{t}^{t}, \text { with } w_{t}= \begin{cases}u_{\mathbf{i}}, & \text { if } t \in T_{0} \\ u_{\mathbf{j}^{-1}}, & \text { if } t=b \\ u_{\mathbf{k}^{-1}} & \text { if } t \in T_{0} b \backslash\{b\}\end{cases}
$$

By rationality, there is a 2-element $s \in S$ such that $\mathbf{v}^{s}=\mathbf{v}^{2}$, which will be fixed throughout.
We use the bijection $T \rightarrow H \backslash S, t \mapsto H t$, and the action of $S$ on right $H$-cosets of $S$ by multiplication on the right, to define an action of $S$ on $T$. To avoid confusion with multiplication in $S$, we denote the action of $s \in S$ on $t \in T$ by $t^{(s)}$, i.e. $t^{(s)}$ denotes the unique element of $T$ satisfying

$$
H t^{(s)}=H t s
$$

So we have $t^{(1)}=t$ and $t^{\left(s_{1} s_{2}\right)}=\left(t^{\left(s_{1}\right)}\right)^{\left(s_{2}\right)}$ for every $s_{1}, s_{2} \in S$. The kernel of this action is the core of $H$ in $S$. As $A$ is normal in $S$ and is contained in $H$, it follows that $t^{(s)}=t$ for every $s \in A$. As $N$ is normal in $S$, under this action, the elements of $N$ stabilize $T_{0}$ and $T_{0} b$, while the elements of $S \backslash N$ interchange $T_{0}$ and $T_{0} b$.

Lemma 13. $s \in K \mathbf{i} T_{0}$, $s$ stabilizes $T_{0}$ and $T_{0} b$, and $b^{(s)}=b$. Moreover,

$$
K t s\left(t^{(s)}\right)^{-1}= \begin{cases}K \mathbf{i}, & \text { if } t \in T_{0} ; \\ K \mathbf{j}^{-1}, & \text { if } t=b ; \\ K \mathbf{k}^{-1}, & \text { if } t \in T_{0} b \backslash\{b\} .\end{cases}
$$

Hence, for every $w \in W$,

$$
w^{t s}= \begin{cases}w^{\mathbf{i} t^{(s)}}, & \text { if } t \in T_{0}  \tag{4}\\ w^{\mathbf{j}^{-1} t^{(s)}}, & \text { if } t=b \\ w^{\mathbf{k}^{-1} t^{(s)}}, & \text { if } t \in T_{0} b \backslash\{b\}\end{cases}
$$

Proof. As $T=T_{0} \cup T_{0} b$ is a right transversal of $H$ in $S$ and $H=H_{2} \rtimes\langle a\rangle$, there are unique $h \in H_{2}$, $i \in\{0,1,2\}, d \in T_{0}$ and $j \in\{0,1\}$ such that $s=h a^{i} d b^{j}$.

We first prove that $j=0$. By means of contradiction suppose that $j=1$. By Lemma $11,[S: H]>2$; hence there is some $t_{0} \in T_{0} \backslash\{1\}$. Then

$$
b^{(s)} \in T_{0}, \quad\left(t_{0} b\right)^{(s)} \in T_{0}, \quad u_{\mathbf{j}^{-1}}^{b s}=\left(u_{\mathbf{i}}^{b^{(s)}}\right)^{2} \quad \text { and } \quad u_{\mathbf{k}^{-1}}^{t_{0} s}=\left(u_{\mathbf{i}}^{\left(t_{0} b\right)^{(s)}}\right)^{2}
$$

Therefore $u_{\mathbf{j}^{-1}}^{b s b^{(s)^{-1}}}=u_{\mathbf{i}}^{2}=u_{\mathbf{k}^{-1}}^{t_{0} b s\left(\left(t_{0} b\right)^{(s)}\right)^{-1}}$, and hence the following elements belong to $H \cap N_{2}=H_{2}$ :

$$
\begin{aligned}
h_{1} & =b s\left(b^{(s)}\right)^{-1} a^{i}=b h d b\left(b^{(s)}\right)^{-1} \\
h_{2} & =t_{0} b s\left(\left(t_{0} b\right)^{(s)}\right)^{-1} a^{i}=t_{0} b h d b\left(\left(t_{0} b\right)^{(s)}\right)^{-1}
\end{aligned}
$$

Thus $u_{\mathbf{k}^{-1}}=u_{\mathbf{j}^{-1}}^{h_{1} h_{2}^{-1}} \in \mathcal{O}_{\mathbf{k}} \cap \mathcal{O}_{\mathbf{j}}=\emptyset$, a contradiction.
Therefore $j=0$, so $s \in N$, and hence $t^{(s)} \in T_{0}$ for every $t \in T_{0}$, and $b^{(s)} \in T_{0} b$. Thus $u_{\mathbf{i}}^{t h d\left(t^{(s)}\right)^{-1} a^{i}}=$ $u_{\mathbf{i}}^{t s\left(t^{(s)}\right)^{-1}}=u_{\mathbf{i}}^{2} \in \mathcal{O}_{\mathbf{i}} \cap \mathcal{O}_{\mathbf{i}}^{a^{i}}$. Hence $i=0$ and $t s\left(t^{(s)}\right)^{-1} \in K \mathbf{i}$ for each $t \in T_{0}$. Applying this to $t=1$ yields $s \in K \mathbf{i} T_{0}$.

If $b^{(s)} \neq b$ then $u_{\mathbf{j}^{-1}}^{b s\left(b^{(s)}\right)^{-1}}=u_{\mathbf{k}^{-1}}^{2}$. Therefore $b s\left(b^{(s)}\right)^{-1} \in N_{2} \cap H=H_{2}$ and $u_{\mathbf{k}^{-1}} \in \mathcal{O}_{\mathbf{j}} \cap \mathcal{O}_{\mathbf{k}}=\emptyset$, a contradiction. Thus $b^{(s)}=b$ and $u_{\mathbf{j}^{-1}}^{b s b^{-1}}=u_{\mathbf{j}^{-1}}^{2}$, so that $b s b^{-1} \in K \mathbf{j}^{-1}$. Moreover, if $t \in T_{0} b \backslash\{b\}$ then $u_{\mathbf{k}^{-1}}^{t s\left(t^{(s)}\right)^{-1}}=u_{\mathbf{k}^{-1}}^{2}$ so that $t s\left(t^{(s)}\right)^{-1} \in K \mathbf{k}^{-1}$.

For a positive integer $n$ consider the maps

$$
\begin{array}{ll}
\alpha_{n}: S \rightarrow S ; & x \mapsto x^{a^{n-1}} x^{a^{n-2}} \ldots x^{a^{2}} x^{a} x, \text { and } \\
\beta_{n}: S \rightarrow S ; & x \mapsto x^{a^{2(n-1)}} x^{a^{2(n-2)}} \ldots x^{a^{4}} x^{a^{2}} x .
\end{array}
$$

Observe that

$$
(a x)^{n}=a^{n} \alpha_{n}(x), \quad\left(a^{2} x\right)^{n}=a^{2 n} \beta_{n}(x) \quad \text { and } \quad \beta_{n}(x)^{b}=\alpha_{n}\left(x^{b}\right) .
$$

We now prove by induction on $n$ that for every $w \in W$ we have

$$
w^{t \alpha_{n}(s)}= \begin{cases}w^{\alpha_{n}(\mathbf{i}) t^{\left(\alpha_{n}(s)\right)},} & \text { if } t \in T_{0}  \tag{5}\\ w^{\beta_{n}\left(\mathbf{j}^{-1}\right) t^{\left(\alpha_{n}(s)\right)},} & \text { if } t=b \\ w^{\beta_{n}\left(\mathbf{k}^{-1}\right) t^{\left(\alpha_{n}(s)\right)}}, & \text { if } t \in T_{0} b \backslash\{b\}\end{cases}
$$

For $n=1$, simply apply (4). For the induction step, recall that $A$ is contained in the kernel of the action of $S$ on $T$ so that $t^{(a)}=t$ and $t^{\left(x^{a}\right)}=t^{(x)}$ for every $t \in T$ and $x \in S$. By Lemma 13 , $s$, and thus also $\alpha_{n}(s)$, stabilize $T_{0}$ and $T_{0} b$ and fix $b$. If $t \in T_{0}$ then

$$
\begin{aligned}
w^{t \alpha_{n+1}(s)} & =w^{t \alpha_{n}(s)^{a} s}=\left(w^{a^{-1}}\right)^{t \alpha_{n}(s) a s}=\left(w^{a^{-1}}\right)^{\alpha_{n}(\mathbf{i}) t^{\left(\alpha_{n}(s)\right)} a s}=\left(w^{\alpha_{n}(\mathbf{i})^{a}}\right)^{t^{\left(\alpha_{n}(s)\right)} s} \\
& =\left(w^{\alpha_{n}(\mathbf{i})^{a}}\right)^{t^{\left(\alpha_{n}(s)^{a}\right)^{\prime}} s}=\left(w^{\alpha_{n}(\mathbf{i})^{a}}\right)^{\mathbf{i t} t^{\left(\alpha_{n}(s)^{a} s\right)}}=\left(w^{\alpha_{n+1}(\mathbf{i})}\right)^{t^{\left(\alpha_{n+1}(s)\right)}}
\end{aligned}
$$

If $t \in T_{0} b$, then the induction step is slightly different: taking $l$ either $\mathbf{j}^{-1}$ or $\mathbf{k}^{-1}$, depending on whether $t=b$ or not,

$$
\begin{aligned}
w^{t \alpha_{n+1}(s)} & =w^{t \alpha_{n}(s)^{a} s}=\left(w^{a}\right)^{t \alpha_{n}(s) a s}=\left(w^{a}\right)^{\beta_{n}(l) t^{t^{\left(\alpha_{n}(s)\right)}} a s}=\left(w^{\beta_{n}(l)^{a^{-1}}}\right)^{t^{\left(\alpha_{n}(s)\right)} s} \\
& =\left(w^{\beta_{n}(l)^{a-1}}\right)^{t^{\left(\alpha_{n}(s)^{a}\right)} s}=\left(w^{\beta_{n}(l)^{a-1}}\right)^{l t^{\left(\alpha_{n}(s)^{a_{s}}\right)}=\left(w^{\beta_{n+1}(l)}\right)^{t^{\left(\alpha_{n+1}(s)\right)}} .} .
\end{aligned}
$$

Let $s_{0}=b s b^{-1}$. By Lemma 13, $s_{0} \in K \mathbf{j}^{-1}$. Thus $K a^{2} s_{0}$ has order 3 in $H / K$ and hence $a^{2} s_{0}$ has order $3 \cdot 2^{o}$ for some non-negative integer $o$. Let $n$ be the smallest even integer greater or equal than $o$. We
define $\hat{s}=\alpha_{2^{n}}(s)$. Since $n$ is even, $2^{n} \equiv 1 \bmod 3$ and hence $a^{2} \beta_{2^{n}}\left(s_{0}\right)=\left(a^{2} s_{0}\right)^{2^{n}}$ has order 3. Thus $\hat{s}=\alpha_{2^{n}}(s)=\beta_{2^{n}}\left(s_{0}\right)^{b} \in A \cap N_{2}$ by Lemma 13, so it follows that $\hat{s} \in A_{2}$. This implies that $t^{(\hat{s})}=t$ for every $t \in T$. Furthermore, by Lemma $12, \mathbf{i}^{2} \mathbf{i}^{a} \mathbf{i}=\left(\mathbf{j}^{-1}\right)^{a}\left(\mathbf{j}^{-1}\right)^{a^{2}} \mathbf{j}^{-1}=\left(\mathbf{k}^{-1}\right)^{a}\left(\mathbf{k}^{-1}\right)^{a^{2}} \mathbf{k}^{-1}=1$. As $2^{n} \equiv 1$ $\bmod 3$, we have

$$
\alpha_{2^{n}}(\mathbf{i})=\mathbf{i}, \quad \beta_{2^{n}}\left(\mathbf{j}^{-1}\right)=\mathbf{j}^{-1} \quad \text { and } \quad \beta_{2^{n}}\left(\mathbf{k}^{-1}\right)=\mathbf{k}^{-1}
$$

Then, by (5), for every $w \in W$,

$$
w^{t \hat{s} t^{-1}}= \begin{cases}w^{\alpha_{2}(\mathbf{i})}=w^{\mathbf{i}}, & \text { if } t \in T_{0} \\ w^{\beta_{\beta^{n}}\left(\mathbf{j}^{-1}\right)}=w^{\mathbf{j}^{-1}}, & \text { if } t=b ; \\ w^{\left.\beta_{2^{n}\left(\mathbf{k}^{-1}\right)}\right)=w^{\mathbf{k}^{-1}},}, & \text { if } t \in T_{0} b \backslash\{b\}\end{cases}
$$

In particular $u_{\mathbf{i}}^{\hat{s}}=u_{\mathbf{i}}^{\mathbf{i}}=u_{\mathbf{i}}^{2}$, so that $\hat{s}=k \mathbf{i}$ for some $k \in K$. If $t \in T_{0}$ then

$$
w^{t k t^{-1} \mathbf{i}}=w^{t \hat{s} t^{-1}}=w^{\mathbf{i}}
$$

Furthermore, if $t \in T_{0} b$ then $t \mathbf{i t}^{-1}=\mathbf{i}^{a} \mathbf{i}=\left(\mathbf{i}^{a^{2}}\right)^{-1}=\mathbf{k}^{-1}$ and hence

$$
w^{t k t^{-1} \mathbf{k}^{-1}}=w^{t \hat{s} t^{-1}}= \begin{cases}w^{\mathbf{j}^{-1}} & \text { if } t=b ; \\ w^{\mathbf{k}^{-1}}, & \text { if } t \in T_{0} b \backslash\{b\}\end{cases}
$$

Then

$$
k \in \bigcap_{t \in T \backslash\{b\}} K^{t} \quad \text { and } \quad w^{\mathbf{j}^{-1}}=w^{b k b^{-1} \mathbf{k}^{-1}}=w^{b k b^{-1} \mathbf{j}^{-1} \mathbf{i}^{-1}}=w^{b k b^{-1} \mathbf{i}^{-1}}
$$

Thus $b k b^{-1} \mathbf{i} \in K$, so that $b k b^{-1} \in K \mathbf{i}^{-1}$ and $b k^{2} b^{-1} \in K z$. Hence,

$$
k^{2} \in K^{b} z \cap \bigcap_{t \in T \backslash\{b\}} K^{t}
$$

In particular, $k^{2} \in \bigcap_{t \in T_{0}} K^{t} \backslash\{1\}$, and as $a$ normalizes $K^{b}$ and commutes with $z,\left[k^{2}, a\right] \in \bigcap_{t \in T} K^{t}=1$. This yields the final contradiction with Lemma 10.
