# FINITELY GENERATED SUBGROUPS OF ALGEBRAIC ELEMENTS OF PLANE CREMONA GROUPS ARE BOUNDED

#### Abstract

We prove that any finitely generated subgroup of the plane Cremona group consisting only of algebraic elements is of bounded degree. This follows from a more general result on 'decent' actions on infinite restricted products. We apply our results to describe the degree growth of finitely generated subgroups of the plane Cremona group.


## 1. Introduction

The Cremona group $\mathrm{Cr}_{2}(k)$ over a field $k$ is the group of birational transformations of the projective plane $\mathbb{P}^{2}$ over $k$. Cremona groups have been the delight of algebraic geometers and group theorists in both, classical and modern times. As of today, many aspects of $\mathrm{Cr}_{2}(k)$ are well understood and there are many tools at hand to study those groups. For instance, $\mathrm{Cr}_{2}(k)$ acts by isometries on an infinite dimensional hyperbolic space $\mathbb{H}^{\infty}$ Can11 and on various CAT(0) cube complexes LU21. Nevertheless, some questions have remained open. The goal of this article is to positively answer a question asked more than a decade ago by Favre in Fav10, Question 1].

Let us fix projective coordinates $[x: y: z]$ of $\mathbb{P}^{2}$. An element $f \in \operatorname{Cr}_{2}(k)$ is given by

$$
[x: y: z] \longmapsto\left[f_{0}: f_{1}: f_{2}\right],
$$

where the $f_{i} \in k[x, y, z]$ are homogeneous of the same degree and without nonconstant common factor. The degree $\operatorname{deg}(f)$ of $f$ is defined as the degree of the polynomials $f_{i}$. An element $f \in \operatorname{Cr}_{2}(k)$ is algebraic, if $\operatorname{deg}\left(f^{n}\right)$ is uniformly bounded for all $n \in \mathbb{Z}$. A subgroup $G<\operatorname{Cr}_{2}(k)$ is bounded if the degree of all elements in $G$ is uniformly bounded. Clearly, a bounded subgroup consists of algebraic elements. However, the converse is not true. For instance, consider the subgroup defined in the affine coordinates $(x, y)$ of $\mathbb{P}^{2}$ by

$$
G=\{(x, y) \longmapsto \rightarrow(x+R(y), y) \mid R \in k(y)\} .
$$

Every element in $G$ is algebraic, but $G$ is not bounded. In this paper, we show the following theorem, which solves Favre's question:

Theorem 1.1. Let $k$ be a field and let $G<\mathrm{Cr}_{2}(k)$ be a finitely generated subgroup such that every element of $G$ is algebraic. Then $G$ is bounded.

[^0]Remark 1.2. Note that the properties of being algebraic and being bounded are invariant under field extensions, so it is enough to show Theorem 1.1 for algebraically closed fields.

Remark 1.3. The first step towards the proof of Theorem 1.1 is due to Cantat, who showed in Can11 that a finitely generated subgroup $G<\operatorname{Cr}_{2}(k)$ consisting of algebraic elements is bounded or preserves a rational fibration (see Lam21 for a proof of this result for fields of arbitrary characteristic). It is therefore enough to show Theorem 1.1 for finitely generated groups that preserve a rational fibration.

In order to show Theorem 1.1 for finitely generated groups that preserve a rational fibration, we introduce the Jonquières complex - a CAT(0) cube complex with an isometric action of the group of birational transformations preserving a rational fibration, whose vertex stabilisers are bounded subgroups. Using a suitable description of this complex and the dynamics of $\mathrm{PGL}_{2}(k)$ on $\mathbb{P}^{1}$, we show that the action of our group on this complex is decent, as defined below.

Definition 1.4. Let $X_{0}$ be a set. We say that a group $G_{0}$ acts on $X_{0}$ purely elliptically, if each element of $G_{0}$ fixes a point of $X_{0}$. We say that a group $G_{0}$ acts on $X_{0}$ decently if

- each subgroup of $G_{0}$ with a finite orbit fixes a point of $X_{0}$, and
- each finitely generated subgroup of $G_{0}$ acting purely elliptically fixes a point of $X_{0}$.

It is an easy exercise that if $G_{0}$ is the isometry group of a simplicial tree $X_{0}$, then $G_{0}$ acts on $X_{0}$ decently (see Ser80, Corollary 3 in $\S 6.5$ and Example 6.3.4]). More generally, if $G_{0}$ is the isometry group of a $\operatorname{CAT}(0)$ cube complex $X_{0}$ with no infinite cubes, then $G_{0}$ acts on $X_{0}$ decently GLU23. Similarly, if $G_{0}$ is the isometry group of a CAT(0) 2-complex $X_{0}$ with rational angles, then $G_{0}$ acts on $X_{0}$ decently NOP22. For further examples, see [HO21].
1.1. Applications. The Cremona group $\mathrm{Cr}_{2}(k)$ can be equipped with the Zariski topology (see for instance Ser10]). An algebraic subgroup of $\mathrm{Cr}_{2}(k)$ is a Zariski closed bounded subgroup. This explains the terminology: an element in $\mathrm{Cr}_{2}(k)$ is algebraic if and only if it is contained in an algebraic subgroup. Note that for any $d \geq 1$, the subset of $\mathrm{Cr}_{2}(k)$ consisting of elements of degree at most $d$ is closed (see [BF13]), hence a bounded subgroup is contained in an algebraic subgroup. An algebraic subgroup $G$ is always projectively regularizable, i.e., there exists a birational map $\varphi: \mathbb{P}^{2} \rightarrow S$ such that $\varphi G \varphi^{-1}<\operatorname{Aut}(S)$ for some regular projective surface $S$. This follows from the theorems of Weil and Sumihiro or from the fact that the number of base-points of elements in an algebraic subgroup is uniformly bounded (we refer to Lam21] for references and a proof of this fact, or to [LU21]). Theorem 1.1 has therefore the following direct consequence:

Corollary 1.5. Let $k$ be a field and let $G<\mathrm{Cr}_{2}(k)$ be a finitely generated subgroup such that every element of $G$ is algebraic. Then $G$ is projectively regularizable.

From another point of view, algebraic elements correspond exactly to elements in $\mathrm{Cr}_{2}(k)$ inducing an elliptic isometry on the infinite dimensional hyperbolic space $\mathbb{H}^{\infty}$, on which $\mathrm{Cr}_{2}(k)$ acts Can11. Theorem 1.1 therefore states that the action of $\mathrm{Cr}_{2}(k)$ on $\mathbb{H}^{\infty}$ is decent.

While all algebraic elements are projectively regularizable, there exist also nonalgebraic elements that are projectively regularizable. It is still unknown whether a finitely generated subgroup of the Cremona group containing only projectively regularizable elements is projectively regularizable or not. This question is equivalent to the question whether $\mathrm{Cr}_{2}(k)$ acts decently on the blow-up complex - a CAT(0) cube complex constructed in LU21. In GLU23, the first and third authors together with Genevois positively answer this question when the base-field $k$ is finite.

Since elements in $\mathrm{Cr}_{2}(k)$ preserving a rational fibration are projectively regularizable if and only if they are algebraic (see for instance LU21, Table 1]), Corollary 1.5 directly implies the following. Let $G<\mathrm{Cr}_{2}(k)$ be a finitely generated subgroup preserving a rational fibration such that every element in $G$ is projectively regularizable. Then $G$ is projectively regularizable.

The notions of algebraic elements and bounded subgroups generalize to birational transformations of arbitrary regular projective surfaces and Theorem 1.1]generalizes to this setting:

Theorem 1.6. Let $S$ be a regular projective surface over a field $k$ and let $G<$ $\operatorname{Bir}(S)$ be a finitely generated subgroup such that every element of $G$ is algebraic. Then $G$ is bounded.

However, the most interesting and difficult case is the one of rational surfaces. In order to keep the notation more accessible, we discuss and prove the general case in the separate Section 5.1.

In Section 5.2 we apply Theorem 1.1 to give a first description of the asymptotic degree growth of finitely generated subgroups of $\mathrm{Cr}_{2}(k)$. This opens up new interesting questions about the dynamical behaviour of finitely generated subgroups of $\mathrm{Cr}_{2}(k)$. Let $G<\mathrm{Cr}_{2}(k)$ be a finitely generated subgroup with a finite generating set $T$. Denote by $B_{T}(n)$ the set of all elements in $G$ of word length $l_{T}$ at most $n$ with respect to the generating set $T$, and define

$$
D_{T}(n):=\max _{f \in B_{T}(n)}\{\operatorname{deg}(f)\}
$$

It has been shown in Ure18] that there are only countably many integer sequences that can appear in this way. However, still very little is known about them. In the case where $T$ consists of a single element, the growth of the function $D_{T}$ has been extensively studied (see Theorem 5.11). Theorem 1.1 is the main ingredient for the following result, which we prove in Section 5.2. For two functions, $f$ and $g$ on $\mathbb{Z}_{\geq 0}$, we write $f \asymp g$ if $f(x) \leq a g(b x)$ and $g(x) \leq c f(d x)$ for some $a, b, c, d>0$.

Corollary 1.7. Let $k$ be an algebraically closed field and let $G<\operatorname{Cr}_{2}(k)$ be a finitely generated subgroup with generating set $T$. Then one of the following is true:
(1) All elements in $G$ are algebraic, $G$ fixes a point in $\mathbb{H}^{\infty}$, and $D_{T}(n)$ is bounded.
(2a) The group $G$ contains an element that induces a parabolic isometry of $\mathbb{H}^{\infty}$, $D_{T}(n) \asymp n$, and $G$ preserves a rational fibration.
(2b) The group $G$ contains an element that induces a parabolic isometry of $\mathbb{H}^{\infty}$, $D_{T}(n) \asymp n^{2}$, and $G$ preserves an elliptic fibration.
(3) The group $G$ contains an element that induces a loxodromic isometry of $\mathbb{H}^{\infty}$ and $D_{T}(n) \asymp \lambda^{n}$ for $\lambda>0$.

It would be interesting to study the dynamical behaviour of the degrees of finitely generated subgroups in more detail. In Corollary 1.7, the asymptotic behaviour does not depend on the choice of the finite generating set $T$, since for any other generating set $T^{\prime}$ there is a constant $d>0$ such that for all $n$ we have $B_{T^{\prime}}(n) \subseteq B_{T}(d n)$, and so $D_{T^{\prime}}(n) \leq D_{T}(d n)$. For instance, one could ask, after fixing $T$, what is the precise asymptotic growth of $D_{T}(n)$, if the group $G$ contains a loxodromic element:

Question 1.8. Let $G<\operatorname{Cr}_{2}(k)$ be a finitely generated subgroup containing an element that induces a loxodromic isometry of $\mathbb{H}^{\infty}$, with finite generating set $T$. What is the asymptotic growth of $D_{T}(n)$ ? Do we always have $D_{T}(n) \sim c \lambda^{n}$ for some constants $c, \lambda>0$ ? Here, we write $f \sim g$ if $f$ and $g$ are functions such that $\lim _{n \rightarrow \infty} \frac{f(n)}{g(n)}=1$.

In another direction, it has been shown that the dynamical degree of $f \in \mathrm{Cr}_{2}(k)$, i.e., the number $\lambda(f):=\lim _{n \rightarrow \infty} \operatorname{deg}(f)^{1 / n}$ is always an algebraic integer (more precisely, it is always a Pisot or Salem number, see [BC16]). This leads to the following natural question, which is due to Cantat:

Question 1.9. Let $G<\mathrm{Cr}_{2}(k)$ be a finitely generated subgroup with finite generating set $T$. Which real numbers can be realized as $\lim _{n \rightarrow \infty} D_{T}(G)^{1 / n}$ ?

For instance, it could be interesting to construct examples of such subgroups and generating sets such that $\lim _{n \rightarrow \infty} D_{T}(G)^{1 / n}$ is transcendental. If $S$ is a regular projective surface and $f \in \operatorname{Aut}(S)$, then $\lambda(f)$ is the spectral radius of the induced transformation $f_{*}$ of $f$ on the Neron-Severi lattice of $S$. For this reason, the limit $\lim _{n \rightarrow \infty} D_{T}(G)^{1 / n}$ should be seen as an analogue to the joint spectral radius, which has been introduced in RS60 and has been studied by many authors (see for instance Jun09 or BF21).
1.2. Decent actions. In Section 3 we will show that Theorem 1.1 is a special case of a following more general result on groups acting decently on an infinite restricted product.

A pointed set $\left(X_{0}, x_{0}\right)$ is a set $X_{0}$ and a point $x_{0} \in X_{0}$. The restricted product $\bigoplus_{p \in P}\left(X_{p}, x_{p}\right)$ of a family $\left\{\left(X_{p}, x_{p}\right)\right\}_{p \in P}$ of pointed sets is the set of sections $\left\{y_{p}\right\}_{p \in P}$ with $y_{p} \in X_{p}$ such that all but finitely many $y_{p}$ are equal to $x_{p}$.

Note that for finite $P$ we have $\bigoplus_{p \in P}\left(X_{p}, x_{p}\right)=\Pi_{p \in P} X_{p}$. For infinite $P$, we have that $\bigoplus_{p \in P}\left(X_{p}, x_{p}\right)$ is a proper subset of $\Pi_{p \in P} X_{p}$.

If each $X_{p}$ is a simplicial tree and each $x_{p}$ is a vertex (which will be the case in our application towards Theorem 1.1), then $\bigoplus_{p \in P}\left(X_{p}, x_{p}\right)$ has a structure of a cube complex whose cubes have the form $\Pi_{p \in P} I_{p}$, where all but finitely many $I_{p}$ are equal to $x_{p}$ and the remaining $I_{p}$ are edges of $X_{p}$. This cube complex is CAT(0) though this will not be exploited explicitly in the current article.

Let $G_{0}$ be a group acting on $X_{0}$ and let $H$ be a group acting on $P$. The (unrestricted) wreath product $G_{0}{l_{P}}_{P} H$ of $G_{0}$ and $H$ over $P$ is the semidirect product of $\Pi_{p \in P} G_{p}$, where $G_{p}=G_{0}$, with the group $H$ acting on $\Pi_{p \in P} G_{p}$ by $h \cdot\left\{g_{p}\right\}_{p \in P}=$ $\left\{g_{h^{-1}(p)}\right\}_{p \in P}$.

Let $x_{0} \in X_{0}$. We will be considering the subgroup $G^{\oplus}$ of $G_{0} \imath_{P} H$ preserving $\bigoplus_{p \in P}\left(X_{p}, x_{p}\right)$, where $X_{p}=X_{0}$ and $x_{p}=x_{0}$, and where the action is defined as follows. For $g=\left\{g_{p}\right\}_{p \in P} \in \Pi_{p \in P} G_{p}$, we have $g \cdot\left\{y_{p}\right\}_{p \in P}=\left\{g_{p}\left(y_{p}\right)\right\}_{p \in P}$. For $h \in H$, we have $h \cdot\left\{y_{p}\right\}_{p \in P}=\left\{y_{h^{-1}(p)}\right\}_{p \in P}$.

It is not hard to verify that if $X_{0}$ is a simplicial tree, and $f$ is a combinatorial isometry of the cube complex $\bigoplus_{p \in P}\left(X_{p}, x_{p}\right)$, then $f$ induces a bijection of $P$. Furthermore, if $G_{0}$ is the group of all simplicial isometries of $X_{0}$, then we have $f \in G^{\oplus}$ if and only if $H$ contains that bijection. For example, if $P=\{p, q\}$ with $X_{0}$ the real line tiled by unit intervals, then $\bigoplus_{p \in P}\left(X_{p}, x_{p}\right)$ is the square tiling of the Euclidean plane, and a $90^{\circ}$ rotation of the plane induces the bijection interchanging $p$ and $q$.
Theorem 1.10. Let $G_{0}$ be a group acting decently on $X_{0}$. Let $P$ be the set of the points of the projective line $\mathbb{P}^{1}(k)$ over an algebraically closed field $k$, and let $H=\operatorname{Aut}\left(\mathbb{P}^{1}\right)$. Then $G^{\oplus}$ acts decently on $\bigoplus_{p \in P}\left(X_{p}, x_{p}\right)$.

We will prove Theorem 1.10 in Section 4 . We will deduce Theorem 1.1 from Theorem 1.10 at the end of Section 3. Note that in Theorem 1.10, we have to make some assumptions on $P$ and $H$. For example, assume that the set $X_{0}$ is a finite simplicial tree and $G_{0}$ is the group of the simplicial isometries of $X_{0}$. Suppose that $H$ is a finitely generated infinite torsion group acting by left multiplication on $P=H$. Then the entire $G^{\oplus}$ is finitely generated and acts purely elliptically on $\bigoplus_{p \in P}\left(X_{p}, x_{p}\right)$, but does not have a fixed-point.

## 2. Preliminaries

In this section, we briefly recall some well-known facts about blow-ups and conic bundles. By Remark [1.2, it is enough to work over an algebraically closed field for our problem, hence we assume our base-field $k$ to be algebraically closed. Unless mentioned otherwise, surfaces are assumed to be projective and smooth.
2.1. Subgroups of algebraic elements of automorphism groups. Let $S$ be a surface over $k$. An ample divisor $H$ on $S$ defines a degree function $\operatorname{deg}_{H}$ on $\operatorname{Bir}(S)$ by $\operatorname{deg}_{H}(f)=f^{*} H \cdot H$. An element $g \in \operatorname{Bir}(S)$ is then algebraic if the degree sequence $\left\{\operatorname{deg}_{H}\left(f^{n}\right)\right\}_{n}$ is bounded. A subgroup $G<\operatorname{Bir}(S)$ is bounded if $\left\{\operatorname{deg}_{H}(f) \mid f \in G\right\}$ is bounded. The properties of being algebraic and being bounded do not depend on the choice of an ample divisor (see for example Dan20]).

Let us observe that Theorem 1.1 holds if we work with finitely generated groups of automorphism groups:

Lemma 2.1. Let $S$ be a surface and let $G<\operatorname{Aut}(S)$ be a finitely generated subgroup such that every element in $G$ is algebraic. Then $G$ is bounded.

Proof. The linear action of Aut $(S)$ on the Néron-Severi lattice $N^{1}(S)$ of $S$ yields a homomorphism $\operatorname{Aut}(S) \rightarrow \mathrm{GL}\left(N^{1}(S)\right) \simeq \mathrm{GL}_{n}(\mathbb{Z})$, whose kernel is an algebraic group and therefore bounded. The image of an element $g \in G$ in $\operatorname{GL}\left(N^{1}(S)\right)$ is of finite order, since $g$ is algebraic (see for example Can15, Theorem 4.6]). Using that $G$ is finitely generated, we obtain that the image of $G$ in $\operatorname{GL}\left(N^{1}(S)\right)$ is finite. Therefore, $G$ is a finite extension of a bounded group and therefore bounded itself.
2.2. Bubble space, strong factorization, and base-points. Let $S$ be a surface and let $s \in S$. Then there exists a surface $\tilde{S}$ and a morphism $\pi: \tilde{S} \rightarrow S$ such that the fibre $E$ over $s$ is isomorphic to $\mathbb{P}^{1}$ and $\pi$ induces an isomorphism between $\tilde{S} \backslash E$ and $S \backslash\{s\}$. The morphism $\pi: \tilde{S} \rightarrow S$ is called the blow-up of $S$ in $s$, and it is unique up to isomorphism. Consider two distinct points $s, s^{\prime}$ on a surface $S$ and
their respective blow-ups $\pi_{s}$ and $\pi_{s^{\prime}}$. Blowing-up first $s$ and then $s^{\prime}$ gives the same transformation up to isomorphism as blowing-up first $s^{\prime}$ and then $s$. By abuse of language, we will say that $\pi_{s}$ and $\pi_{s^{\prime}}$ commute and we denote the successive blow-up of $s$ and then $s^{\prime}$ by $\pi_{s^{\prime}} \pi_{s}=\pi_{s} \pi_{s^{\prime}}$.

The bubble space of $S$ is the set $\mathcal{B}(S)$ of triples $(t, T, \pi)$, where $\pi: T \rightarrow S$ is a birational morphism from a surface $T$ and $t$ is a point on $T$; two triples $(t, T, \pi)$ and $\left(t^{\prime}, T^{\prime}, \pi^{\prime}\right)$ are identified if $\pi^{-1} \pi^{\prime}$ is a local isomorphism around $t^{\prime}$ mapping $t^{\prime}$ to $t$. The bubble space can be thought of as the set of all points on $S$ and on surfaces obtained from $S$ by successively blowing up points. The points in $\mathcal{B}(S)$ contained in $S$ are called proper points.

Zariski's strong factorization theorem states that every birational transformation $f: S \rightarrow T$ between surfaces can be factored into blow-ups of points. More precisely, there exists a surface $Z$ and a factorization

where $\pi$ and $\rho$ are compositions of blow-ups of points. Note that the points blown up by $\pi$ and $\rho$ can be seen as elements of the bubble space $\mathcal{B}(S)$ and $\mathcal{B}(T)$ respectively. Moreover, $Z$ can be chosen in such a way, and will be denoted by $Z_{f}$, that for any other such factorization

there exists a surjective morphism $\eta: Z^{\prime} \rightarrow Z_{f}$ such that $\pi^{\prime}=\pi \eta$ and $\rho^{\prime}=\rho \eta$. If we require $Z_{f}$ to be minimal in this sense, this factorization is unique up to isomorphism and up to possibly changing the order of blowing up the points. The morphism $\pi: Z_{f} \rightarrow S$ is called the minimal resolution of $f$, and the points (in $\mathcal{B}(S)$ ) blown up by $\pi$ are called the base-points of $f$.

A base-point $s$ of $f$ is called persistent if there exists $l \geq 1$ such that, for all $n \geq l$, the point $s$ is a base-point of $f^{n}$ but $s$ is not a base-point of $f^{-n}$.
2.3. Conic bundles. A rational fibration on a surface $S$ is a morphism $\pi: S \rightarrow C$, where $C$ is a curve, such that all the fibres are isomorphic to $\mathbb{P}^{1}$. Note that this is a more restrictive definition than the more usual one, which only asks that the fibres are rational curves.

Let $\pi: S \rightarrow C$ and $\pi^{\prime}: S^{\prime} \rightarrow C$ be rational fibrations. We say that a birational transformation $f: S \rightarrow S^{\prime}$ preserves the fibrations if there exists an automorphism $\hbar(f): C \rightarrow C$ such that the following diagram commutes


Let $\pi: S \rightarrow C$ be a rational fibration. An elementary transformation $f: S \rightarrow S^{\prime}$ is the composition of blowing up a point $s \in S$ followed by blowing down the strict transform of the fibre containing $s$. The surface $S^{\prime}$ comes equipped with the rational
fibration $\pi^{\prime}: S^{\prime} \rightarrow C$ defined by $\pi=\pi^{\prime} f^{-1}$. Note that $f$ preserves these fibrations for $\hbar(f)=\mathrm{id}$.

The following fact is well-known (see for instance [Sch22, Corollary 3.2]):
Proposition 2.2. Let $\pi: S \rightarrow C$ and $\pi^{\prime}: S^{\prime} \rightarrow C$ be rational fibrations. Every birational transformation $f: S \rightarrow S^{\prime}$ preserving the fibrations can be factored into a sequence of elementary transformations and a (fibration preserving) isomorphism.

A conic bundle is a composition with a rational fibration $\pi: S \rightarrow C$ of a sequence of blow-ups $\tilde{S} \rightarrow S$, such that we blow up in total at most one point $s \in S$ in each fibre. In other words, $\pi: S \rightarrow C$ has only finitely many singular fibres, each of them consisting of two rational curves of self-intersection -1 , called also -1-curves (the preimage of $s$ under the blow-up and the strict transform of the fibre of $s$ ).

## 3. The Jonquières complex

In this section we reduce Theorem 1.1 to Theorem 1.10. We always assume our base-field $k$ to be algebraically closed, which is justified by Remark 1.2, and we assume the surfaces to be projective and smooth.
3.1. The blow-up complex. Let $T$ be a surface. In LU21, the authors constructed the blow-up complex $\mathcal{C}(T)$ - a $\operatorname{CAT}(0)$ cube complex with an isometric action of $\operatorname{Bir}(T)$. Let us briefly recall the construction of $\mathcal{C}(T)$. The vertices of $\mathcal{C}(T)$ are equivalence classes of marked surfaces, i.e., pairs $(S, \varphi)$, where $S$ is a surface and $\varphi: S \rightarrow T$ a birational transformation. Marked surfaces $(S, \varphi)$ and $\left(S^{\prime}, \varphi^{\prime}\right)$ are equivalent if $\varphi^{-1} \varphi^{\prime}: S^{\prime} \rightarrow S$ is an isomorphism. Vertices (represented by) $(S, \varphi)$ and $(\tilde{S}, \tilde{\varphi})$, are connected by an edge if $\varphi^{-1} \tilde{\varphi}: \tilde{S} \rightarrow S$ is the blow-up of a point (or its inverse). More generally, $2^{n}$ different vertices form an $n$-cube if there is a marked surface $(S, \varphi)$ and distinct points $s_{1}, \ldots, s_{n} \in S$ such that these vertices are obtained by blowing up subsets of $\left\{s_{i}\right\}_{\{1 \leq i \leq n\}}$.
3.2. The Jonquières complex. Let $\mathbb{F}_{0}=\mathbb{P}^{1} \times \mathbb{P}^{1}$ with the rational fibration $\pi_{0}: \mathbb{F}_{0} \rightarrow \mathbb{P}^{1}$ onto the first factor. We define the Jonquières complex $\mathscr{J}$ as the subcomplex of the blow-up complex $\mathcal{C}\left(\mathbb{F}_{0}\right)$ induced on the set of vertices represented by marked surfaces $(S, \varphi)$ such that, for $\pi=\pi_{0} \varphi$, the rational map $\pi: S \rightarrow \mathbb{P}^{1}$ is a conic bundle.

Remark 3.1. Consider $2^{n}$ vertices of $\mathscr{J}$ spanning a cube. This means that there exists a surface $(S, \varphi)$ and distinct points $s_{1}, \ldots, s_{n} \in S$ such that these vertices are obtained by blowing up subsets of $\left\{s_{i}\right\}_{\{1 \leq i \leq n\}}$. Since these vertices belong to the Jonquières complex, we have that the points $s_{i}$ belong to distinct fibres of $\pi$. In other words, we have $\pi\left(s_{i}\right) \neq \pi\left(s_{j}\right)$ for all $i \neq j$.

Remark 3.2. Note that the Jonquières complex $\mathscr{J}$ is not a convex subcomplex of the blow-up complex $\mathcal{C}\left(\mathbb{F}_{0}\right)$. Indeed, consider the birational transformation $\varphi$ : $(x, y) \mapsto\left(x, x^{2}+y\right)$. It has three base-points, but only one of them is proper. Let $\rho: S \rightarrow \mathbb{F}_{0}$ be the minimal resolution of $\varphi$. Then the vertex represented by $(S, \rho)$ is not a vertex of the Jonquières complex because more than one point has been blown-up in the same fibre. However, the vertex represented by $(S, \rho)$ lies on a geodesic edge-path between the vertices $\left(\mathbb{F}_{0}, \mathrm{id}\right)$ and $\left(\mathbb{F}_{0}, \varphi^{-1}\right)$.

Nevertheless, by Proposition 2.2. the 1-skeleton of $\mathscr{J}$ it is isometrically embedded in the 1 -skeleton of $\mathcal{C}\left(\mathbb{F}_{0}\right)$.

For any $p \in \mathbb{P}^{1}$, consider the subcomplex $X_{p}$ of $\mathscr{J}$ induced on the vertices represented by the marked surfaces $(S, \varphi)$, where $\varphi: S \rightarrow \mathbb{F}_{0}$ induces an isomorphism between $S \backslash \pi^{-1}(p)$ and $\mathbb{F}_{0} \backslash \pi_{0}^{-1}(p)$.
Lemma 3.3. For any $p \in \mathbb{P}^{1}$, the subcomplex $X_{p}$ is a tree.
Proof. First note that $X_{p}$ is connected as a consequence of Proposition 2.2 and the fact that two elementary transformations performed in distinct fibres commute.

Second, consider the vertex $v_{0}=\left(\mathbb{F}_{0}, \mathrm{id}\right)$ in $X_{p}$, and let $\mathbb{P}_{p}^{1} \subset \mathbb{F}_{0}$ be the fibre over $p$. Let $v_{0}, v_{1}, v_{2}, v_{3}, \ldots$ be the consecutive vertices on an edge-path without backtracks in $X_{p}$. The surface $v_{1}$ is obtained from $v_{0}$ by blowing up a point $s$ in $\mathbb{P}_{p}^{1}$ to a -1-curve. The surface $v_{2}=\left(S_{2}, \varphi_{2}\right)$ is obtained from $v_{1}$ by blowing down the other - 1 -curve in the fibre over $p$ to a point $s_{2}$. In particular, the birational transformation $\varphi_{2}^{-1}$ sends the entire $\mathbb{P}_{p}^{1} \backslash\{s\}$ to $s_{2}$.

Continuing, for $i \geq 2$ the surface $v_{2 i-1}$ is obtained from $v_{2 i-2}$ by blowing up a point in the fibre over $p$ distinct from $s_{2 i-2}$ to a -1-curve, and the surface $v_{2 i}$ is obtained from $v_{2 i-1}$ by blowing down the other -1-curve in the fibre over $p$ to a point $s_{2 i}$. Thus the birational transformation $\varphi_{2 i}^{-1}$ sends the entire $\mathbb{P}_{p}^{1} \backslash\{s\}$ to $s_{2 i}$. In particular, $\varphi_{2 i}$ is not an isomorphism, and so $v_{2 i} \neq v_{0}$. This proves that there is no cycle in $X_{p}$, and so $X_{p}$ is a tree.

We choose a preferred vertex $x_{p}=\left(\mathbb{F}_{0}, \mathrm{id}\right)$ in each $X_{p}$, and we consider the family of pointed sets $\left\{\left(X_{p}, x_{p}\right)\right\}_{p \in \mathbb{P}^{1}}$.
Lemma 3.4. The cube complex $\mathscr{J}$ is isomorphic to $\bigoplus_{p \in \mathbb{P}^{1}}\left(X_{p}, x_{p}\right)$.
Proof of Lemma 3.4. Let $(S, \varphi)$ be a vertex of $\mathscr{J}$. The birational transformation $\varphi: S \rightarrow \mathbb{F}_{0}$ is decomposed as $\varphi=\sigma_{n} \cdots \sigma_{1}$, where each $\sigma_{i}$ is the blow-up of a point or the blow-down of a - 1 -curve in the fibre over a point $p_{i} \in \mathbb{P}^{1}$. For $p_{i} \neq p_{j}$, we have that $\sigma_{i}$ and $\sigma_{j}$ commute. Thus there is a finite subset $Q \subset \mathbb{P}^{1}$ such that $\varphi=\Pi_{p \in Q} \varphi_{p}$, where each (of the commuting) $\varphi_{p}$ is a composition of $\sigma_{i}$ with $p_{i}=p$. Consider the marked surfaces $\varphi_{p}: S_{p} \rightarrow \mathbb{F}_{0}$ for $p \in Q$, and $\varphi_{p}=\mathrm{id}, S_{p}=\mathbb{F}_{0}$ for $p \in \mathbb{P}^{1} \backslash Q$. They represent vertices of $X_{p}$. Then $\left\{\left(S_{p}, \varphi_{p}\right)\right\}_{p \in \mathbb{P}^{1}}$ defines a vertex of $\bigoplus_{p \in \mathbb{P}^{1}}\left(X_{p}, x_{p}\right)$.

This is a bijective correspondence between the vertices of $\mathscr{J}$ and $\bigoplus_{p \in \mathbb{P}^{1}}\left(X_{p}, x_{p}\right)$, and it extends to an isomorphism on the entire complexes.

The coordinate $y_{p}$ of a point $y \in \bigoplus_{p \in \mathbb{P}^{1}}\left(X_{p}, x_{p}\right)=\mathscr{J}$ should be thought of as the "marked fibre" in the surface corresponding to $y$ over the point $p$. Thus modifying the coordinate $y_{p}$ of $y$ corresponds to performing an alternating sequence of blow-ups of points and blow-downs of -1 curves in the fibre over $p$ of the surface corresponding to $y$.

The Jonquières group is the subgroup of $\operatorname{Bir}\left(\mathbb{F}_{0}\right)$ consisting of the Jonquières transformations $f$ that preserve the rational fibration $\pi_{0}: \mathbb{F}_{0} \rightarrow \mathbb{P}^{1}$. The Jonquières group acts on the vertex set of $\mathscr{J}$ by $f \cdot(S, \varphi)=(S, f \varphi)$, and this action extends to an action by isometries on the entire $\mathscr{J}$.

Remark 3.5. A subgroup $G$ of the Jonquières group is a subgroup of $\operatorname{Aut}(S)$ for some conic bundle $\pi: S \rightarrow \mathbb{P}^{1}$ if and only if $G$ fixes a point in $\mathscr{J}$. This is because if $G$ fixes an interior point of a cube in $\mathscr{J}$ described via a surface $S$ in Remark 3.1 then $G$ fixes this cube and in particular $G$ fixes the vertex corresponding to $S$. By the definition of a marked surface this is equivalent to $G<\operatorname{Aut}(S)$.

We conclude with the following.
Proof of Theorem [1.1. By Remark [1.2, we can assume the base-field $k$ to be algebraically closed. By Remark 1.3 , we can assume $G$ to be a subgroup of the Jonquières group.

As a consequence of Lemma 3.4 the complex $\bigoplus_{p \in \mathbb{P}^{1}}\left(X_{p}, x_{p}\right)$ inherits the action of the Jonquières group from $\mathscr{J}$. Because $X_{p}$ are trees (see Lemma3.3), their isometry groups are decent. All the elements of the Jonquières group induce elements of Aut $\left(\mathbb{P}^{1}\right)$ on $\mathbb{P}^{1}$. Moreover, by Remark 3.5 and by Lemma 2.1, to prove Theorem 1.1 for a subgroup $G$ of the Jonquières group, we need to find a fixed-point for $G$ in $\mathscr{J}$, which is guaranteed by Theorem 1.10 .

## 4. Proof of the main theorem

In this section we prove Theorem 1.10 . We keep the notation $\mathscr{J}$ for the general $\bigoplus_{p \in \mathbb{P}^{1}}\left(X_{p}, x_{p}\right)$ (and not just for the Jonquières complex). We denote by $\hbar$ the quotient map $G_{0}{l_{P}}_{P} \rightarrow H$. Abusing the notation, for $f \in G_{0}{l_{P}} H$ and $p \in P$, we denote by $f(p) \in P$ the point $\hbar(f)(p)$.

Convention 4.1. Note that for $f=h g \in G^{\oplus}$, with $h \in H$ and $g \in \Pi_{p \in P} G_{p}$, and for $y \in \mathscr{J}$, the value $f(y)_{p}$ equals $g_{h^{-1}(p)}\left(y_{h^{-1}(p)}\right)$ and so it depends only on $h, g_{h^{-1}(p)}$ and $y_{h^{-1}(p)}$. Henceforth, slightly abusing the notation, we will refer to $f(y)_{p}$ as $f\left(y_{f^{-1}(p)}\right)$.

This conveys the fact that for a Jonquières transformation $f$, the "marked fibre" in $f(S)$ over $p$ depends only on $f$ and the "marked fibre" in $S$ over $f^{-1}(p)$.

Lemma 4.2. Let $G_{0}$ be a group acting on $X_{0}$ so that each subgroup of $G_{0}$ with a finite orbit fixes a point of $X_{0}$ (which is the first item of Definition 1.4 for $G_{0}$ ). Then each subgroup of $G<G^{\oplus}$ with a finite orbit $Y$ in $\mathscr{J}$ fixes a point of $\mathscr{J}$ (which is the first item of Definition 1.4 for $G$ ).

Proof. For $p \in P$, let $Y_{p}=\left\{y_{p}: y \in Y\right\}$ denote the finite set of the coordinates of $Y$ in the factor $X_{p}$.

First, we consider each finite orbit $O \subset P$ of $\hbar(G)<H$. If for all $p \in O$ we have $Y_{p}=\left\{x_{p}\right\}$, then we define $z_{p}=x_{p}$ for all $p \in O$. Since $Y \subset \mathscr{J}$, there are only finitely many finite orbits $O$ of $\hbar(G)<H$ with $Y_{p} \neq\left\{x_{p}\right\}$ for some $p \in O$. For each such $O$, we choose $o \in O$. Let $G_{o}^{\prime}$ be the projection to $G_{o}$ of the stabiliser of $o$ in $G$, that is, the group of all $g_{o}$ over $g \in G$ fixing $o$. Note that $Y_{o}$ contains an orbit of $G_{o}^{\prime}$. Thus $G_{o}^{\prime}$ has a finite orbit and hence a fixed-point $z_{o} \in X_{o}$ by the hypothesis of the lemma. We set $z_{p}=f\left(z_{o}\right)$ (see Convention 4.1) for any $f \in G$ with $f(o)=p$, which only depends on $p$ and not on $f$ since $z_{o}$ was fixed by $G_{o}^{\prime}$.

Now, let $O \subset P$ be an infinite orbit of $\hbar(G)<H$. Since $Y \subset \mathscr{J}$, there is $o \in O$ with $Y_{o}=\left\{x_{o}\right\}$. Consequently, for any $p \in O$, we have that $Y_{p}$ consists only of a single element, which we call $z_{p}$. Since $Y \subset \mathscr{J}$, this $z_{p}$ equals $x_{p}$ for all but finitely many $p$.

Consequently, we have $z=\left\{z_{p}\right\}_{p} \in \mathscr{J}$. By construction, $z$ is a fixed-point of $G$.
4.1. Biregularity. The following encapsulates the idea of a Jonquières transformation $f$ having a persistent base-point in the fibre over a point $p \in P$.

Definition 4.3. Let $z=\left\{z_{r}\right\}_{r} \in \mathscr{J}$ be a distinguished vertex. Let $p \in P$ and $f \in G^{\oplus}$. We say that $f$ is biregular over $p$ (with respect to $z$ ) if $f(z)_{f(p)}=z_{f(p)}$ (or, in our notation from Convention 4.1, $f\left(z_{p}\right)=z_{f(p)}$ ). Equivalently, for $f=h g$ with $h \in H, g \in \Pi_{p} G_{0}$, we have $g_{p}\left(z_{p}\right)=z_{f(p)}$ (which equals $\left.z_{h(p)}\right)$. Otherwise, we say that $f$ is singular (w.r.t. $z$ ) over $p$.

An element $f \in G^{\oplus}$ has persistent fibre over $p \in P$ if there exists $l \geq 1$ such that, for all $n \geq l$, we have that $f^{n}$ is singular over $p$ and $f^{-n}$ is biregular over $p$.

Remark 4.4. Note that $f$ is biregular over $p$ if and only if $f^{-1}$ is biregular over $f(p)$. Furthermore, if $f$ is biregular over $p$ and $f^{\prime}$ is biregular over $f(p)$, then $f^{\prime} f$ is biregular over $p$.

Remark 4.5. The point $z$ is a fixed-point for $f$ if and only if $f$ is biregular over all $p \in P$.
Remark 4.6. If $f$ has persistent fibre over $p$, then it does not have a fixed-point $y \in \mathscr{J}$. Indeed, the orbit of $p$ under $\langle f\rangle$ is infinite, since $f^{m}(p)=p$ with $m>0$ would imply, by Remark 4.4, that $f^{l m}$ is simultaneously biregular and singular over $p$. Furthermore, for all $n \geq l$, we have $z_{f^{n}(p)} \neq f^{n}\left(z_{p}\right)=f^{n}\left(f^{n}\left(z_{f^{-n}(p)}\right)\right)$. For large $n$, we have $y_{f \pm n(p)}=z_{f \pm n}(p)$, contradicting $y_{f^{n}(p)}=f^{2 n}\left(y_{f-n}(p)\right)$.
4.2. Abelian case. The following proves Theorem 1.10 in the case where $\hbar(G)$ is abelian. Note that here, as well as in Lemma 4.9 we do not need to assume that $P$ is the projective line $\mathbb{P}^{1}$.

Lemma 4.7. Let $G_{0}$ be a group acting decently on $X_{0}$. Let $H$ be a group acting on $P$, and let $G<G^{\oplus}$ be such that either $\hbar(G)<H$ is trivial or it contains an element that has only finitely many finite orbits on $P$. If $G$ is finitely generated, acts purely elliptically on $\mathscr{J}$, and $\hbar(G)$ is abelian, then $G$ fixes a point of $\mathscr{J}$.
Proof. If $\hbar(G)$ is trivial, then $G<\Pi_{p \in P} G_{p}$. Let $Q \subset P$ be a finite set such that each generator $\left\{g_{p}\right\}_{p \in P}$ of $G$ satisfies $g_{p}\left(x_{p}\right)=x_{p}$ for $p \notin Q$. For each $q \in Q$, the projection of $G$ to $G_{q}$ is a purely elliptic subgroup, so it fixes a point $y_{q} \in X_{q}$. Setting $y_{p}=x_{p}$ for $p \notin Q$, we obtain a fixed-point $\left\{y_{p}\right\}_{p}$ for $G$ in $\mathscr{J}$.

Thus from now on we can assume that there is $t \in G$ with $\hbar(t)$ having only finitely many finite orbits on $P$. Let $z \in \mathscr{J}$ be a fixed-point of $t$. Then $t$ is biregular w.r.t. $z$ over each $p \in P$ by Remark 4.5. Let $Q \subset P$ be the union of the finite orbits of $\langle t\rangle$. Note that $Q$ is preserved by $\hbar(G)$, since $\hbar(G)$ is abelian.

Let $p \in P \backslash Q$. We claim that any $f \in G$ is biregular w.r.t. $z$ over $p$. To justify the claim, let $B$ be the finite set of $b \in P \backslash Q$ over which $f$ or $f^{-1}$ is singular. We will show that for some $n>0$, setting $f_{n}=t^{n} f$, we have $f_{n}^{i}(p) \notin B$, for all $i \in \mathbb{Z} \backslash\{0\}$. To find such $n$, suppose first that $f^{l}(p)=t^{k}(p)$ for some $k, l \in \mathbb{Z}$ with $l>0$. Then choose $m_{0}>0$ such that, for all $m \geq m_{0}$, and all $0 \leq j<l$, we have $t^{ \pm m} f^{j}(p) \notin B$. It suffices then to take $n=m_{0}+|k|$, since for any $i \neq 0$ we have $f_{n}^{i}(p)=t^{n i} f^{i}(p)=t^{ \pm m} f^{j}(p)$ for some $0 \leq j<l$ and $m \geq m_{0}$. Otherwise, if there is no $l \neq 0$ with $f^{l}(p) \in\langle t\rangle(p)$, then there are finitely many $k \in \mathbb{Z}$ with $t^{k}(p) \in\langle f\rangle B$, since $B$ is finite. It suffices then to take $n$ larger than the maximum of their $|k|$.

Thus we have $f_{n}^{i}(p) \notin B$, for all $i \in \mathbb{Z} \backslash\{0\}$. If $f$ was singular w.r.t. $z$ over $p$, then by Remark $4.4 f_{n} \in G$ or its inverse would have persistent fibre over $p$ (with $l=1$ ), contradicting Remark 4.6 and justifying the claim.

For each orbit $O$ of $\hbar(G)$ in $Q$, choose $o \in O$ and $y_{o} \in X_{o}$ that is fixed by the projection to $G_{o}$ of the stabiliser of $o$ in $G$, which is of finite index in $G$, hence finitely
generated. For each $f \in G$, choose $y_{f(o)}=f\left(y_{o}\right)$ (notation from Convention 4.1), which only depends on $f(o)$ and not on $f$, since $y_{o}$ was fixed by the projection to $G_{o}$ of the stabiliser of $o$ in $G$. Setting $y_{p}=z_{p}$ for $p \notin Q$ gives us a fixed-point $y$ for $G$.
4.3. Semisimple case. In order to treat the case of non-abelian $\hbar(G)$, we use the dynamics of elements in $\operatorname{Aut}\left(\mathbb{P}^{1}\right)=\mathrm{PGL}_{2}(k)$. An element $a \in \mathrm{PGL}_{2}(k)$ is semisimple, if it is conjugate to a diagonal element. With respect to suitable local coordinates, the automorphism of $\mathbb{P}^{1}$ induced by $a$ is given by $z \mapsto \lambda z$ for some $\lambda \in k^{*}$. Let us observe that $a$ is of infinite order if and only if $\lambda$ is not a root of unity. In this case, $a$ fixes exactly two points of $\mathbb{P}^{1}$ and it does not have any other finite orbit. If $k$ admits a norm $|\cdot|$ with $|\lambda| \neq 1$, then $a$ has north-south dynamics, defined below, in the topology of $\mathbb{P}^{1}$ induced by $|\cdot|$.

Definition 4.8. Let $a$ be a homeomorphism of a Hausdorff topological space $P$, fixing $p, q \in P$, and having the following property. For any disjoint open sets $U \ni p, V \ni q$, there is $n$ such that $a^{n}(P \backslash V) \subset U$ and $a^{-n}(P \backslash U) \subset V$. We then say that $a$ has north-south dynamics.

Lemma 4.9. Let $G_{0}$ be a group acting decently on $X_{0}$. Let $H$ be a group acting on $P$. Let $a \in H$ have north-south dynamics with $p, q$ as in Definition 4.8 for some Hausdorff topology on $P$ in which $H$ acts by homeomorphisms. Suppose also that $\operatorname{Stab}(p) \cap \operatorname{Stab}(q)<H$ is abelian. If $G<G^{\oplus}$ is finitely generated, acts purely elliptically on $\mathscr{J}$, and $\hbar(G)$ contains $a$, then $G$ has a fixed-point in $\mathscr{J}$.
Proof. Choose $t \in G$ with $\hbar(t)=a$. Let $z \in \mathscr{J}$ be a fixed-point of $t$. We claim that for any $f \in G$ and any $r \in P \backslash\{p, q\}$ with $f(r) \neq p, q$, we have that $f$ is biregular w.r.t. $z$ over $r$.

To justify the claim, first consider the case where $\hbar(f)$ interchanges $p$ and $q$. Then the group $\langle a, \hbar(f)\rangle$ is virtually abelian, since it has an index 2 subgroup contained in $\operatorname{Stab}(p) \cap \operatorname{Stab}(q)$. By Lemma 4.7 the group $\langle t, f\rangle$ has a finite orbit, hence a fixed-point $y$ in $\mathscr{J}$ by Lemma 4.2. Since both $y$ and $z$ belong to $\mathscr{J}$, all but finitely many coordinates of $y$ have to be that of $z$. Thus $t(y)=y$ implies $y_{r}=z_{r}$ for all $r$ in all infinite orbits of $\langle t\rangle$, so for all $r \neq p, q$. Since $f$ fixes $y$, we have that $f$ is biregular w.r.t. $z$ over $r$, as desired.

Second, consider the case where $\hbar(f)$ does not interchange $p$ and $q$. Then after possibly replacing $t$ with $t^{-1}$ and interchanging $p$ with $q$, we can assume $f(p) \neq q$. Let $B \subset P$ be the finite set of points over which $f$ or $f^{-1}$ is singular w.r.t. $z$. Let $U \ni$ $p$ (respectively, $V \ni q$ ) be an open neighbourhood intersecting $B \cup\left\{f^{-1}(p), f(q)\right\}$ only possibly at $p$ (respectively, $q$ ), and such that $f(U)$ is disjoint from $V$, which is possible since $f(p) \neq q$. Assume also that $U$ is disjoint from $V$. Let $n>0$ be as in Definition 4.8.

If $f$ is singular over $r$, then we have $r, f(r) \in P \backslash V$. Thus $t^{n} f(r) \subset U$, but $t^{n} f(r) \neq p$ since $f(r) \neq p$. Since $f(U)$ is disjoint from $V$, and $U$ does not contain $f^{-1}(p)$, unless $f(p)=p$, we obtain inductively, for all $m>0$, that $\left(t^{n} f\right)^{m}(r) \in U \backslash p$. We also have $t^{-n}(r) \in V \backslash q$ and analogously we obtain $t^{-n}\left(t^{n} f\right)^{m}(r) \in V \backslash q$ for all $m<0$. Consequently, $t^{n} f$ has persistent fibre over $r$ (with $l=1$ ), which contradicts Remark 4.6 and finishes the proof of the claim.

Note that if the entire $\hbar(G)$ stabilises $\{p, q\}$, then we are done by Lemma 4.7 Suppose also for the moment that $\hbar(G)$ does not fix $p$ or $q$. Then there is $f \in G$ and $r \neq p, q$ with $f(r)=p$. Consider another $f^{\prime} \in G$ with $r^{\prime} \neq p, q$ and $f^{\prime}\left(r^{\prime}\right)=p$.

Then $f^{-1} f^{\prime}\left(r^{\prime}\right)=r$. Applying the claim above to $f^{-1} f^{\prime}$, we have $f^{-1} f^{\prime}(z)_{r^{\prime}}=z_{r}$. Consequently, $f^{\prime}(z)_{p}=f(z)_{p}$. We now replace the coordinate $z_{p}$ of $z$ by $f(z)_{p}$, which, as we have seen, does not depend on $f$. Note that the new $z$ is still fixed by $t$, which can be verified by substituting above $f^{\prime}=t f$. Furthermore, now $f$ is biregular over $r$ and $f^{-1}$ is biregular over $p$. We analogously change the $z_{q}$ coordinate of $z$.

We will verify that the new $z$ is a fixed-point for $G$. It remains to verify the biregularity of $f \in G$ over $u \in\{p, q\}$ in the case where $f(u) \in\{p, q\}$. Choose any $r \neq p, q$ and $f^{\prime} \in G$ with $f^{\prime}(r)=u$. Introduce $f^{\prime \prime}=f f^{\prime}$, which satisfies $f^{\prime \prime}(r)=f(u)$. From the previous paragraph it follows that both $f^{\prime}, f^{\prime \prime}$ are biregular over $r$. This implies that $f$ is biregular over $u$, as desired.

In the case where $\hbar(G)$ fixes, say, $p$, we redefine $z_{p}$ to be the fixed-point of the projection of $G$ to $G_{p}$.
4.4. Conclusion. Recall that an element $h \in \operatorname{PGL}_{2}(k)$ is unipotent, if it is conjugate to an element of the form $\left(\begin{array}{cc}1 & c \\ 0 & 1\end{array}\right)$ for some $c \in k$. By considering the Jordan decomposition, we observe that, for $k$ algebraically closed, every element of $\mathrm{PGL}_{2}(k)$ is either unipotent or semisimple.

Proof of Theorem 1.10. Suppose first that $\hbar(G)$ contains a semisimple element $a$ of infinite order with eigenvalues $\lambda, \lambda^{-1}$ and fixed-points $p, q \in \mathbb{P}^{1}$. Since $a$ is of infinite order, $\lambda$ is not a root of unity. Let $z \in \mathscr{J}$. Let $\tilde{k} \subset k$ be the smallest field such that the points $p$ and $q$, the scalar $\lambda$, the elements of $\hbar(G)$, and all the points over which the elements of $G$ are singular w.r.t. $z$, are defined over $\tilde{k}$. Since $G$ is finitely generated, the field $\tilde{k}$ is a finitely generated field extension over the prime field of $k$.

Let $\mathscr{J}_{\tilde{k}}=\bigoplus_{p \in \mathbb{P}^{1}(\tilde{k})}\left(X_{p}, x_{p}\right)$, where $\mathbb{P}^{1}(\tilde{k})$ is the set of the $\tilde{k}$-rational points of $\mathbb{P}^{1}$. Note that the action of $G$ on $\mathscr{J}$ projects to an action on $\mathscr{J}_{\tilde{k}}$.

By DK18, Theorem 2.65], we can embed $\tilde{k}$ as a subfield into some local field $K$ with norm $|\cdot|$ such that $|\lambda| \neq 1$. Then $a$ has north-south dynamics on $\mathbb{P}^{1}(\tilde{k})$ with respect to the Hausdorff topology on $\mathbb{P}^{1}(\tilde{k})$ induced by the topology of $\mathbb{P}^{1}(K)$. By Lemma 4.9 applied with $P=\mathbb{P}^{1}(\tilde{k})$, we have that $G$ fixes a point $\left\{y_{p}\right\}_{p \in \mathbb{P}^{1}(\tilde{k})} \in \mathscr{J}_{\tilde{k}}$. Since all the elements of $G$ are biregular w.r.t. $z$ over all the points outside $\mathbb{P}^{1}(\tilde{k})$, we obtain that $G$ fixes the point $\left\{y_{p}\right\}_{p \in \mathbb{P}^{1}} \in \mathscr{J}$, where $y_{p}=z_{p}$ for $p \notin \mathbb{P}^{1}(\tilde{k})$.

Otherwise, if $\hbar(G)$ does not contain a semisimple element of infinite order, then all the elements of $\hbar(G)$ are unipotent or of finite order. By DK18, Proposition 14.46], there is a finite index subgroup $G^{\prime}<G$ with $\hbar\left(G^{\prime}\right)$ conjugate into the abelian subgroup of the elements of the form $\left(\begin{array}{cc}1 & c \\ 0 & 1\end{array}\right)$. Lemma 4.7 implies that also in this case $G^{\prime}$ (and hence $G$ ) fixes a point of $\mathscr{J}$.

## 5. Proofs of Theorem 1.6 and Corollary 1.7

5.1. Non-rational surfaces. Here, we give a proof of Theorem 1.6

Proof of Theorem 1.6. Again, by Remark 1.2, we can assume that $k$ is algebraically closed. If $S$ is rational, then the result follows from Theorem 1.1

If the Kodaira dimension of $S$ is non-negative, then there exists a smooth projective surface $T$ birationally equivalent to $S$ such that $\operatorname{Bir}(T)=\operatorname{Aut}(T)$ and the result follows from Lemma 2.1.

Finally, if the Kodaira dimension of $S$ is $-\infty$, but $S$ is not rational, then $S$ is birationally equivalent to $\mathbb{P}^{1} \times C$ for some non-rational smooth curve $C$. In this case, all the elements $f \in \operatorname{Bir}(S)$ preserve the rational fibration given by the projection to $C$. Indeed, if $F$ is a general fibre of the second projection $\pi_{2}: S \rightarrow C$, then the restriction of $\pi_{2} \circ f$ to $F$ induces a rational map to $C$. Since $F \cong \mathbb{P}^{1}$, this rational map cannot be dominant, hence its image is a point, which implies that $f(F)$ is another fibre. If the genus of $C$ is $>1$, then $\operatorname{Bir}(C)=\operatorname{Aut}(C)$ is finite. If the genus of $C$ is 1 , then $C$ is an elliptic curve and $\operatorname{Bir}(C)=\operatorname{Aut}(C)$ is virtually abelian. We can thus apply Lemma 4.7 .
5.2. Degree growth of finitely generated groups. There is a well-known and important correspondence between the dynamical behaviour of birational transformations in $\mathrm{Cr}_{2}(k)$ and the type of isometry they induce on the infinite dimensional hyperbolic space $\mathbb{H}^{\infty}$. The following theorem gives in particular a precise description of the degree growth. It is due to several people. We refer to Can15 for details and references.

Theorem 5.1 (Gizatullin; Diller and Favre; Cantat). Let $k$ be an algebraically closed field and $f \in \operatorname{Cr}_{2}(k)$. Then one of the following is true:
(1) The transformation $f$ is algebraic, the isometry of $\mathbb{H}^{\infty}$ induced by $f$ is elliptic, and the degree sequence $\left\{\operatorname{deg}\left(f^{n}\right)\right\}$ is bounded.
(2a) The isometry of $\mathbb{H}^{\infty}$ induced by $f$ is parabolic, $\operatorname{deg}\left(f^{n}\right) \sim$ cn for some $c>0$, and $f$ preserves a rational fibration.
(2b) The isometry of $\mathbb{H}^{\infty}$ induced by $f$ is parabolic, $\operatorname{deg}\left(f^{n}\right) \sim c n^{2}$ for some $n$, and $f$ preserves a fibration of genus 1 curves.
(3) The isometry of $\mathbb{H}^{\infty}$ induced by $f$ is loxodromic, $\operatorname{deg}\left(f^{n}\right)=c \lambda^{n}+\mathcal{O}(1)$ for some $c>0$ and $\lambda>1$.

We prove now Corollary 1.7
Proof of Corollary 1.7. If all elements in $G$ induce elliptic isometries on $\mathbb{H}^{\infty}$, i.e., they are algebraic, then $G$ and hence $D_{T}(n)$ are bounded by Theorem 1.1. This implies that the orbit of $G$ on $\mathbb{H}^{\infty}$ is bounded and hence that $G$ fixes a point in $\mathbb{H}^{\infty}$.

Next, consider the case, where no element in $G$ induces a loxodromic isometry of $\mathbb{H}^{\infty}$, but there is an element $f \in G$ inducing a parabolic isometry.

First, assume that $f$ preserves a rational fibration. Then all elements in $G$ preserve this same rational fibration (see for instance Ure17, Lemma 5.3.4]) and after conjugation we may assume that $G$ is a subgroup of the Jonquières group (note that the asymptotic growth of $D_{T}(n)$ is invariant under conjugation). For an element $g$ in the Jonquières group we have $\operatorname{deg}(g)=\frac{\# \mathfrak{b}(g)+1}{2}$ (see for instance Lam21), where $\# \mathfrak{b}(g)$ denotes the number of base-points of $g$. Since $\# \mathfrak{b}(g h) \leq$ $\# \mathfrak{b}(g)+\# \mathfrak{b}(h)$ we obtain that that $D_{T}(n) \leq K n$, where $K=\max _{g \in T}\{\# \mathfrak{b}(g)\}$. At the same time, since by assumption $G$ contains an element whose degree growth is linear, we have $k n \leq D_{T}(n)$, for some $k>0$. Hence, $D_{T}(n) \asymp n$.

Now, assume that $f$ preserves a fibration of curves of genus 1. Again, this implies that all of $G$ preserves the same fibration of curves of genus 1 and after conjugation
we may assume that $G$ is a subgroup of $\operatorname{Aut}(S)$, where $S$ is a Halphen surface Ure17, Lemma 5.3.4]. In this case, the statement follows from Lemma 5.2 below.

Finally, we consider the case, where $G$ contains an element $f$ inducing a loxodromic isometry on $\mathbb{H}^{\infty}$. By Theorem 5.1, there exist $c$ and $\lambda$ such that $\operatorname{deg}\left(f^{n}\right)=$ $c \lambda^{n}+\mathcal{O}(1)$. On the other hand, for $\lambda_{2}=\max _{g \in T}\{\operatorname{deg}(g)\}$ we have $D_{T}(n) \leq \lambda_{2}^{n}$. This shows that $f \asymp \lambda^{n}$.

A Halphen surface is a rational smooth projective surface $S$ such that $\left|-m K_{S}\right|$ is a pencil of genus 1 curves with empty base locus for some $m>0$. The ideas used in the following lemma have been described in Giz80 (see also Gri16 and CD12). We follow the account described in Lam21.

Lemma 5.2. Let $S$ be a Halphen surface and let $G<\operatorname{Aut}(S)$ be a finitely generated subgroup containing a non-algebraic element $f$. Then $D_{T}(n) \asymp c n^{2}$ for some $c>0$.

Proof. Let us first recall that after possibly passing to a finite index subgroup (which does not change the asymptotic growth of $D_{T}(n)$ ), we may assume that $G$ is abelian. Moreover, all algebraic alements in $\operatorname{Aut}(S)$ are of finite order and $\operatorname{Aut}(S)$ does not contain any element inducing a loxodromic isometry on $\mathbb{H}^{\infty}$ (see for instance Can15 for these facts). Hence, again up to passing to a finite index subgroup, we may assume that all elements in $G$ induce a parabolic isometry on $\mathbb{H}^{\infty}$.

Let $N_{\mathbb{R}}(S)$ be the Néron-Severi space of $S$. Recall that $N_{\mathbb{R}}(S)$ comes with an intersection form of signature $\left(1, \operatorname{dim}\left(N_{\mathbb{R}}(S)\right)-1\right)$, which is preserved by the action of $\operatorname{Aut}(S)$ by push-forwards. There exists a nef divisor class $D_{0} \in N_{\mathbb{R}}(S)$ such that $D_{0} \cdot D_{0}=0$ and such that $g_{*} D_{0}=D_{0}$ for all $g \in G$ (in fact, we can take $D_{0}=m K_{S}$ ). The assumption that all elements in $G$ induce parabolic isometries on $\mathbb{H}^{\infty}$ implies that for all $f \in G$, the only eigenvectors of $f$ are multiples of $D_{0}$. For all $g \in G$, the restriction of $g_{*}$ to $D_{0}^{\perp} / D_{0}$ has finite order, since $g_{*}$ preserves an integral lattice and the induced intersection form on $D_{0}^{\perp} / D_{0}$ is negative definite. Hence, up to passing to a finite index subgroup of $G$, we may assume that the restriction of $G$ to $D_{0}^{\perp} / D_{0}$ is the identity. Let $f_{1}, \ldots, f_{k}$ be generators of $G$.

Let $A \in N_{\mathbb{R}}(S)$ be an ample divisor. Note that we have $f_{*} A \neq A$ for all $f \in G$ and $A \notin D_{0}^{\perp}$. Write $\left(f_{i}\right)_{*} A=A+R_{i}$, where $R_{i} \in D_{0}^{\perp}$. Since the restriction of $\left(f_{i}\right)_{*}$ to $D_{0}^{\perp} / D_{0}$ is the identity, we can write $\left(f_{i}\right)_{*} R_{j}=R_{j}+t_{i j} D_{0}$ for some $t_{i j} \in \mathbb{R}$. Let us observe that $\left(f_{i}\right)_{*}\left(f_{j}\right)_{*} A=\left(f_{j}\right)_{*}\left(f_{i}\right)_{*} A$ for all $i$ and $j$ implies that $t_{i j}=t_{j i}$ for all $i$ and $j$.

By induction, we obtain

$$
\left(f_{i}\right)_{*}^{n} A=A+n R_{i}+\frac{n(n-1) t_{i i}}{2} D_{0},
$$

and, as a consequence,

$$
\left(f_{1}\right)_{*}^{n_{1}} \cdots\left(f_{k}\right)_{*}^{n_{k}} A=A+\sum_{i} n_{i} R_{i}+\left(\sum_{i} \frac{n_{i}\left(n_{i}-1\right)}{2} t_{i i}+\sum_{i<j} n_{i} n_{j} t_{i j}\right) D_{0}
$$

Since, by assumption, all the $f_{i}$ are non-algebraic and preserving a fibration of genus 1 curves, the sequence $\operatorname{deg}\left(f^{n}\right)$ grows quadratically in $n$, by Theorem 5.1, and hence the $t_{i i}$ are positive. We obtain that

$$
\operatorname{deg}_{A}\left(f_{1}^{n_{1}} \cdots f_{k}^{n_{k}}\right)=\left(\left(f_{1}\right)_{*}^{n_{1}} \cdots\left(f_{k}\right)_{*}^{n_{k}} A\right) \cdot A
$$

Since $A$ is ample, we have that $A \cdot D_{0}>0$. Hence, $D_{T}(n)$ has quadratic growth.
