# Thin Film Equations with Nonlinear Deterministic and Stochastic Perturbations

#### Abstract

In this paper we consider stochastic thin-film equation with nonlinear drift terms, colored Gaussian Stratonovych noise, as well as nonlinear colored Wiener noise. By means of Trotter-Kato-type decomposition into deterministic and stochastic parts, we couple both of these dynamics via a discrete-in-time scheme, and establish its convergence to a non-negative weak martingale solution.


## 1 Introduction.

We consider the nonlinear stochastic thin-film equation with nonlinear drift coefficients

for $(t, x) \in[0, T) \times \mathbb{T}_{L}$, on torus $\mathbb{T}_{L}$, where $T$ and $L$ are positive constants, and $\mathbb{T}_{L}$ denotes the torus on the interval $[0, L]$ with periodic boundary conditions

and non-negative initial condition $u(0, x)=u_{0}(x)$. The term $\partial_{x}(u \circ d W)$ is a stochastic perturbation in Stratonovich form, and $f(u) d W$ is a Stochastic perturbation of Ito type. Here

In particular, the functions $\left\{\Psi_{k}\right\}$ are the eigenfunctions of the Laplace operator with periodic boundary conditions, which satisfy

The processes $\beta^{k}$ and $\beta_{1}^{k}$ are mutually independent standard real-valued $\mathcal{F}_{t}$-Wiener processes on a complete filtered probability space $\left(\Omega, \mathcal{F},\left\{\mathcal{F}_{t}\right\}, \mathcal{P}\right), t \in[0, T]$, with a complete and right-continuous filtration $\left(\mathcal{F}_{t}\right)_{t \in[0, T]}$. The coefficients $\lambda_{k} \geq 0$ and $\gamma_{k}$ satisfy the coloring condition

Since in this work we will be studying the martingale solutions using the Skorokhod approach [27] and its generalization [17], without loss of generality we consider the probability space to be $\Omega=[0,1]$ with Lebesgue measure. Similarly to [13], may be re-written in Ito's form

Finally, we will assume that the nonlinear drift coefficients are $l(u)=-|u|^{r-1} u$ for some $r \geq 1$, and $f(u)$ is globally Lipschitz with $f(0)=0$.

The deterministic equations of type (1.1) arise in modeling the motion of liquid droplets of thickness $u$, spreading over the solid surface. This model follows from lubrication theory under the assumption that the dimensions in the horizontal directions are significantly larger than in the vertical (normal) one. In this regime the dynamics of the droplet is governed by the surface tension and limited by viscosity.

In broad terms, the dynamics of the deterministic version of (1.1) is characterized by the presence of the wetted regions $u>0$. The equation is parabolic in the interior of these regions, and degenerate on their boundary. The boundary of the wetted region, in turn, has a finite speed of propagation [4]. Thus, one may interpret (1.1) as a fourth-order nonlinear free boundary problem inside a wetted region, which itself evolves in time. Furthermore, the classical parabolic theory is not applicable to this equation, in particular, due to the lack of
comparison (maximum) principle, which is widely used in the existence theory of degenerate second order parabolic equations. Bernis and Friedman [5] used the energy-entropy method to prove the existence of a non-negative generalized weak solution, which was constructed as a limit of solutions of a regularized problem. In this work, the authors' notion of a weak solution is somewhat "weaker" than usual, since the integral identity in the definition of the weak solution has to hold not in the entire $\mathbb{T}$, but only on the subset where $u>0$. In addition, in [5] the authors analyzed the support of the solution. The existence of more regular (strong or entropy) solutions was shown in [2], where the authors also studied the asymptotic in $t$ behavior of the solution. Further properties of solutions, including convergence to steady states, finite propagation speed, and waiting time phenomenon, were obtained in [6]. The work [18] studies the generalized thin film equation with a nonlinear dissipative term $l(u)$, which models the relation between nonlinear absorption and spatial injection.

In this paper we consider the thin film equation with two different stochastic perturbations, of Ito and Statonovych type. It is worth mentioning that one needs to be very careful when dealing with the effect of noise on nonlocal and/or ill-posed problems. In some cases, e.g. [22], the presence of a even small stochastic perturbation leads to a finite time blowup while an unperturbed equation has global solution. In others [26], the effect of the random perturbation is exactly opposite - it may lead to the existence of a global solution while the corresponding deterministic equation has a finite time blowup. The long time behavior of stochastically perturbed evolution equations is typically described via the existence and properties of invariant measures, see, e.g. [23], [25], [24], [28], [15], [19], [7].

The stochastic version of thin-film equation, which takes into account the effect of random forcing when modeling the enhanced spreading of droplets, was first introduced in [10], with $l=f=0$. In the subsequent work [14] the authors additionally take the interface potential between fluid and substrate into account, which prevents the solution $u$ from becoming negative. This work describes coarsening and de-wetting phenomena. The first rigorous construction of a non-negative martingale solution of the stochastic thin film equation with Ito noise and additional interface potential was obtained in [11]. In [8], the author considered a more general case of the main operator in the form $-\partial_{x}\left(u^{n} u_{x x x}\right)$ (referred as more general mobility), and established the conditions for the existence of a global strong solution for this problem. In [13] the authors established the existence of a nonnegative matringale solution for (1.1) by means of Trotter-Kato type decomposition. The subsequent work [9] establishes the existence and uniqueness of a weak solution of this problem. To this end, the authors started with the establishing the existence of a weak solution for the regularized equation by means of Galiorkin approximations, and proceeded with passing to the limit in the regularized problem.

The equation (1.1), which is considered in this paper, has significant differences from the similar models, analyzed by the other authors. In it, we introduce the nonlinear drift $l(u)$, as well as the nonlinear stochastic Ito perturbation $f(u) d W_{1}(t)$. Due to the presence of these two terms, the equation is no longer in divergence form. In other words, if $f \equiv 0$ and $l \equiv 0$, integrating both sides of (1.1) over $\mathbb{T}$, one gets $\frac{d}{d t} \int_{\mathbb{T}} u d x=0$, implying, in view of nonnegativity of $u$, the conservation of mass property (almost surely). This property plays a crucial role in [13]. However, if either $f \neq 0$ or $l \neq 0$, this property no longer holds. Nevertheless, in this paper we obtain the estimates on the mass, which, in turn, enable us to obtain the energy estimates similar to [13]. Our analysis starts with Trotter-Kato decomposition, which separates the deterministic dynamics from stochastic. The principal
difference in our case is the presence of the nonlinear drift term in the deterministic dynamics, which prevents us from using the classic results on deterministic thin-film equations, e.g. [5, 2]. Instead, we obtain the analogs of the main result in [18] with different boundary conditions. The stochastic dynamics, in contrast to [13], is nonlinear, which makes its analysis more complicated, especially in view of the lack of mass preservation. In particular, it requires a different approach to establish the non-negativity property of the solutions.

The paper is structured as follows: in Section 2 we introduce the notation, list preliminary results, formulate the main results, and introduce the decomposition of the dynamics. In Section 3 we describe the deterministic dynamics in detail. Section 4 is devoted to stochastic dynamics, and finally, the main result is established in Section 5 .

## 2 Preliminaries and main results.

Throughout the paper, we denote

Next, for $Q \in \mathbb{R}^{d}$ with $\partial Q \in C^{\infty}$, for $s \in[0, \infty), p \in[1, \infty)$, let $W^{s, p}(Q)$ be the regular Sobolev space for $s \in \mathbb{N}$, and Sobolev-Slobodeckij space for non-integer $s$. For $p=2$ we will denote $W^{s, p}(Q)=H^{s}(Q)=H^{s}$. If $X$ is a Banach space, the space $C^{k+\alpha}(Q ; X)$ is the space of $k$ times differentiable functions $Q \rightarrow X$, whose $k$-th derivatives are Holder-continous with exponent $\alpha \in(0,1)$ on compact subsets of $Q$. We also denote $C^{k-}(Q ; X)$ to be the space of $k-1$-times differentiable functions, whose $k-1$-st derivatives are Lipschitz continuous. The space $B C^{0}(Q, X)$ is the set of bounded continuous functions. The pairings $\langle\cdot, \cdot\rangle$ is the $H^{-1}\left(\mathbb{T}_{L}\right)-H^{1}\left(\mathbb{T}_{L}\right)$ pairing in $L^{2}\left(\mathbb{T}_{L}\right)$, and $\langle\langle\cdot, \cdot\rangle\rangle$ stands for the pairing between $L^{2}\left(\mathbb{T}_{L}\right)$ and $H^{2}\left(\mathbb{T}_{L}\right)$ in $H^{1}\left(\mathbb{T}_{L}\right)$. We denote $H_{w}^{1}\left(\mathbb{T}_{L}\right)$ to be the space of $H^{1}\left(\mathbb{T}_{L}\right)$ functions endowed with the weak topology, induced by $\|\cdot\|_{1,2}$. The space $\dot{H}^{1}\left(\mathbb{T}_{L}\right)$ is the Sobolev space of $H^{1}\left(\mathbb{T}_{L}\right)$ functions endowed with the norm $\left\|\partial_{x} u\right\|_{L^{2}\left(\mathbb{T}_{L}\right)}$. In this space the functions which differ by an additive constant are the same. Denote $L_{2}(U ; H)$ to be the space of Hilbert-Schmidt operators from $U$ to $H$. In this case, for $A \in L_{2}(U ; H)$ we have

where $\left\{e_{n}\right\}$ is any orthonormal basis in $U$. The symbol $\langle\langle\cdot\rangle\rangle_{t}$ denotes the quadratic variation process. For $u: Q_{T} \rightarrow \mathbb{R}$ we denote

Consider a triple consisting of a filtered probability space $\left([0,1], \tilde{\mathcal{F}}, \tilde{\mathcal{F}}_{t \in[0, T]}, P\right)$, where $\tilde{\mathcal{F}}_{t \in[0, T]}$ is a complete right continuous filtration.

Definition 2.1. Let $u_{0} \in H^{1}\left(\mathbb{T}_{L}\right)$. An $\tilde{\mathcal{F}}_{t}$ adapted bounded continuous $H_{w}^{1}\left(\mathbb{T}_{L}\right)$-valued process $\tilde{u}$ on $[0, T]$, such that the distributional derivative $\partial_{x}^{3} \tilde{u}$ is $\tilde{\mathcal{F}}_{t}$ - adapted with $\partial_{x}^{3} \tilde{u} \in$
$L^{2}(\{\tilde{u}>r\})$ for any $r>0$, and $\tilde{u}^{2}\left(\partial_{x}^{3} \tilde{u}\right)$ is in $L^{2}(\{\tilde{u}>0\}) \mathbb{P}$ - almost surely, as well as mutually independent standard real-valued $\left(\tilde{\mathcal{F}}_{t}\right)$-Wiener processes $\tilde{\beta}^{k}$, is called a martingale solution of the equation (1.1), if its weak formulation

is satisfied for every $\varphi \in C^{\infty}\left(\mathbb{T}_{L}\right)$ and $t \in[0, T] \mathbb{P}=\lambda_{[0,1]}$ almost surely.
We have the following result:
Theorem 2.2. (existence of martingale solution) Suppose $u_{0} \in H^{1}\left(\mathbb{T}_{L}\right)$ is such that $u_{0} \geq 0$. Then the equation (1.1) with has a martingale solution $\tilde{u}(t)$ in the sense of Definition 2.1, which is non-negative a.s. for $t \in[0, T]$, and for any $p \geq 2$ there is $C_{p}>0$ such that

for any $p \in[2, \infty)$, where $C<\infty$ is independent on $u_{0}$.
In order to establish this result, we will use the Trotter-Kato type decomposition of the dynamics into deterministic and stochastic parts. This method was used by a number of authors, e.g. [13, 21], in particular, to establish the existence of for SPDEs with local Lipschitz coefficients. To this end, for fixed $N \geq 1$, we equi-partition the time interval $[0, T]$ into intervals of length $\delta=\frac{T}{N+1}$. Then, for $t \in[(j-1) \delta, j \delta]$ and for an arbitrary $\varphi \in C^{\infty}\left(\mathbb{T}_{\mathbb{L}}\right)$ we define the following dynamics:

Deterministic Dynamics (D) We look for the function $v_{N}$ satisfying

Stochastic Dynamics (S) We look for the function $w_{N}$ satisfying

Deterministic-Stochastic Connection (DS) We set $v_{N}(0):=u_{0}$, $v_{N}(j \delta, \cdot):=\lim _{t \rightarrow j \delta-} w_{N}(t, \cdot)$ and $w_{N}((j-1) \delta, \cdot):=\lim _{t \rightarrow j \delta-} v_{N}(t, \cdot)$ a.s.

The dynamics in (D) is deterministic with random initial conditions, while the dynamics in (S) is purely stochastic. We note that both deterministic and stochastic dynamics are significantly different from the one considered in [13] due to the presence of nonlinearities $l$ and $f$ in them respectively. In particular, $f$ makes the stochastic dynamics nonlinear. In order to resolve the lack of mass preservation property, our strategy is to show that, due to the dissipative nature of nonlinearity $l(u)$, the mass in deterministic dynamics is non-increasing in time, while the stochastic dynamics preserves the mass on average, i.e. $\mathbb{E} \int_{\mathbb{T}} w_{N}(x) d x \equiv$ const. We proceed with establishing the apriori bounds on the solutions of both deterministic and stochastic problems, which enable us to pass to the limit as $N \rightarrow \infty$, thus establishing that both $v_{N}$ and $w_{N}$ converge to the desired martingale solution for (1.1).

## 3 Deterministic dynamics.

In this section we consider the deterministic equation

with $\lambda \geq 1$, and nontrivial non-negative $u_{0} \in H^{1}\left(\mathbb{T}_{L}\right)$.
Definition 3.1. The function $u \in C\left(\bar{Q}_{T}\right) \cap L^{\infty}\left(0, T, H^{1}\left(\mathbb{T}_{L}\right)\right)$ is called the weak solution of (3.1) if

for all $\psi \in C^{1}\left(\bar{Q}_{T}\right)$, and $u(t, \cdot) \rightarrow u_{0}(\cdot)$ in $H^{1}\left(\mathbb{T}_{L}\right)$ as $t \rightarrow \infty$.
The equation of type (3.1) was studied in [18] with the nonlinear term in the form $\left(|u|^{n} u_{x x x}\right)_{x}, n \geq 1$, and with the boundary conditions $\left.u_{x}\right|_{x=0, L}=\left.u_{x x x}\right|_{x=0, L}=0$ on $[0, T]$. However, the main result in [18] guarantees the existence of the solution for arbitrary $0 \leq$ $u_{0}(x) \in H^{1}\left(\mathbb{T}_{L}\right)$ only for $n \in(1,2)$. For other values of $n$, the solution exists only under the initial conditions, which satisfy the entropy estimates. Therefore, the existence of the solution of (3.1) for any $0 \leq u_{0}(x) \in H^{1}\left(\mathbb{T}_{L}\right)$ requires extra work. We have the following result:

Theorem 3.2. The Cauchy problem (3.1) admits a nonnegative solution in $Q_{T}$. Furthermore,

Proof. For any $\varepsilon>0$ introduce $f_{\varepsilon}(u)=\frac{u^{6}}{\varepsilon u^{2}+u^{4}}$. Suppose $u_{0 \varepsilon}>0$ in $[0, L]$ and $u_{0 \varepsilon}(x) \in$ $C^{\infty}\left(\mathbb{T}_{L}\right)$ and $u_{0 \varepsilon} \rightarrow u_{0}$ in $H^{1}\left(\mathbb{T}_{L}\right), \varepsilon \rightarrow 0$. Thus, it follows from the results in [29] that the regularized problem

has a unique non-negative smooth (classic) solution $u^{\varepsilon}(t, x)$ in $Q_{T}$. This fact is proved using compactness arguments and parabolic Schauder estimates. Multiplying (3.2) by $-u_{x x}^{\varepsilon}$ and integrating over $(0, L)$ we have

The convergence of $u_{0 \varepsilon}$ implies the existence of a constant $C>0$ such that $\left\|u_{x}^{\varepsilon}(0)\right\| \leq C$. Then it follows from (3.3), Poincare inequality, and the embedding $H^{1}\left(\mathbb{T}_{L}\right) \in L^{\infty}\left(\mathbb{T}_{L}\right)$ :

\end{aligned}

Thus, any $M \geq 1$ has to satisfy the inequality $M^{2} \leq 2 C_{\delta}$, which is a contradiction. Hence (3.8) follows.

It follows from (3.4), (3.5) and (3.8) that the set $\left\{u^{\varepsilon}\right\}$ is relatively compact in $C\left(\bar{Q}_{T}\right)$, and hence up to a subsequence $u^{\varepsilon} \rightarrow u$ in $C\left(\overline{Q_{T}}\right)$. Note that all the derivatives $u_{t}^{\varepsilon}, u_{t}^{\varepsilon}, u_{x}^{\varepsilon}, u_{x x}^{\varepsilon}, u_{x x x}^{\varepsilon}$ and $u_{x x x x}^{\varepsilon}$ converge to the corresponding derivatives of $u$ in view of uniform parabolicity of in any compact subset of $P_{T}$. Thus, passing to the limit in (3.9) as $\varepsilon \rightarrow 0$, we deduce that $u$ solves (3.1), which is also non-negative. Let us show that the mass of the solution is non-increasing. Integrating the solution of the regularized problem (3.2) on $[0, L]$, we have

In this section we consider the stochastic contribution to (1.1) on $[0, \delta) \times \mathbb{T}_{L}$ for some $0<\delta \leq T$ :

Definition 4.1. Let $w_{0}=w_{0}(x, \omega) \in H^{1}\left(\mathbb{T}_{L}\right)$ almost surely. A triple consisting of a filtered probability space $\left([0,1], \tilde{\mathcal{F}},\left(\tilde{\mathcal{F}}_{t}\right)_{t \in[0, \delta)}, \mathbf{P}\right)$, where $\left(\tilde{\mathcal{F}}_{t}\right)_{t \in[0, \delta)}$ is a complete and right-continuous filtration, an $\left(\tilde{\mathcal{F}}_{t}\right)$ - adapted $H_{w}^{1}\left(\mathbb{T}_{L}\right)$ - valued process $\tilde{W}(t)$ and mutually independent standard real-valued $\left(\tilde{\mathcal{F}}_{t}\right)$ - Wiener processes $\tilde{\beta}^{k}(t)$ and $\tilde{\beta}_{1}^{k}(t)$ is called the solution of (4.1) if

For any $p \in[2, \infty)$ and for any $w_{0} \in L^{p}\left([0,1], \mathcal{F}_{0}, \mathbb{P}, H^{1}\left(\mathbb{T}_{L}\right)\right), w_{0} \geq 0$ a.s., there exists a non-negative solution $w(t, x, \omega)$ of (4.2) with the initial condition $w_{0}$, and satisfies the a-priori estimates

(H4') (Growth)

The condition (H1) (hemicontinuity) is straightforward.

& \leq C\left(\left\|w^{\varepsilon}(s)\right\|_{2}\left\|w_{x}^{\varepsilon}(s)\right\|_{2}+\left\|w_{x}^{\varepsilon}\right\|_{2}^{2}\right)=C\left\|w^{\varepsilon}(s)\right\|_{1,2}\left\|w_{x}^{2}(s)\right\|_{2} \tag{4.48}
\end{align*}
$$

Similarly,

Thus, for the sake of proving Theorem 4.2, one needs to pass to the limit in (4.5) as $\varepsilon \rightarrow 0$ and to show that $w^{\varepsilon}(t)$ converges to $w(t)$, which solves (4.1). We shall need the analog of Lemma 4.4 [13]:

We may now pass to the limit as $\varepsilon \rightarrow 0$ in (4.61) the same way as in Lemma 5.7 [13]. Similar identities hold for the limiting processes $\tilde{w}(t), \tilde{M}(t), \tilde{\beta}^{k}(t)$ and $\tilde{\beta}_{1}^{k}$. Thus (4.61) follows from [16], Proposition A1. Thus we have the existence of the solution of the initial value problem (4.1). Non-negativity of this solution follows from non-negativity $\tilde{w}^{\varepsilon}(t)$. The bounds (4.3) follow from (4.9) and (4.10), which are uniform in $\varepsilon$. Similarly we have the estimate for its mass from (4.45). This completes the proof of Theorem 4.2.

## 5 Proof of Theorem 2.2.

### 5.1 Estimates for the approximate solutions.

Let $\{j \delta, j=1, \ldots, N+1\}$ with $\delta=\frac{T}{N+1}$ be a partition of $[0, T]$. According to Theorem 3.2, on every interval $[(j-1) \delta, j \delta)$ there exists a non-negative solution $v_{N}$ of the equation (2.2) (in the sense of Definition 3.1) for any nonnegative $H^{1}\left(\mathbb{T}_{L}\right)$ initial condition. Similarly, it follows from Theorem 4.2 that on every interval $[(j-1) \delta, j \delta]$ there is a nonnegative martingale solution $\left(\tilde{w}_{j}, \tilde{W}_{j}\right)$ of (2.3) for any nonnegative initial process from $L^{p}\left([0,1], \mathcal{F}_{0}, \mathcal{P}, H^{1}\left(\mathbb{T}_{L}\right)\right)$, in the sense of Definition 4.1. Here $\mathcal{P}=\lambda_{[0,1]}$,

Let us now describe the construction of the solution $w_{N}$ on $[0, T]$. In view of Theorem 4.2 there is a martingale solution $w_{N}^{1}$ on $[0, \delta)$, with the initial condition $w_{N}^{0}(0):=v_{N}(\delta-$ 0 ), defined on $\left(\Omega^{1}=[0,1], \mathcal{F}^{1}, \mathcal{F}_{t}^{1}, \lambda_{[0,1]}^{1}\right)$ with the Wiener process $\tilde{\bar{W}}_{1}$ and filtration $\tilde{F}_{t}^{1}=$ $\sigma\left(\tilde{\bar{W}}_{1}(s), s \leq t\right)$ for $t \in[0, \delta)$. Introduce the new probability space $\left.\Omega^{2}:=[0,1] \times 0,1\right]=$ $\left\{\left(\omega_{1}, \omega_{2}\right), \omega_{1} \in[0,1], \omega_{2} \in[0,1]\right\}$, with the measure $\lambda^{2}=\lambda_{[0,1]}\left(\omega_{1}\right) \lambda_{[0,1]}\left(\omega_{2}\right), \mathcal{F}^{2}=\mathcal{F}^{1}\left(\omega_{1}\right) \times$ $\mathcal{F}^{2}\left(\omega_{2}\right)$. We define the new Wiener process $\tilde{\bar{W}}^{\prime}\left(t, \omega_{2}\right)$ and then construct the Wiener process $\tilde{\bar{W}}\left(t, \omega_{1}, \omega_{2}\right)$ on $[0,2 \delta)$ as follows:

This way the equation (2.3) has the following nonnegative martingale solution on $[0,2 \delta)$ :

Continuing this procedure, we have the existence of a martingale solution $w_{N}(t)$ on $[0, T)$, defined on $\Omega^{N}$ with some Wiener process

\left\|v_{N}\right\|_{L^{2}\left([0,1], \mathcal{F}, \lambda_{[0,1]} ; C^{\frac{1}{2}}\left([(j-1) \delta, j] ; H^{-1}\left(\mathbb{T}_{L}\right)\right)\right)} \leq C\left(\left\|u_{0}\right\|_{1,2}^{2}+\left\|u_{0}\right\|_{1,2}^{\lambda}\right) .
$$

The rest of the proof follows the lines of Lemma 4.3 from [13]
We now proceed with the corresponding result for $w_{N}$.
Lemma 5.4. For any $p \in[2, \infty), \varepsilon>0$ and $q \in[p, \infty)$, there exists a constant $C>0$ such that for all $N \in \mathbb{N}, j \in\{1, \ldots, N+1\}$ and $\gamma \in(0,1)$ we have

w_{N} \in L^{p}\left([0,1], \mathcal{F}, \lambda_{[0,1]}, B_{q}^{\frac{\gamma}{2}-\varepsilon, q}\left([(j-1) \delta, j \delta), B_{q}^{\frac{1}{2}-2 \gamma, q}\left(\mathbb{T}_{L}\right)\right)\right)
$$

and

\begin{equation*}
\mathbb{E}\left(\sum_{j=1}^{N+1}\left\|w_{N}\right\|_{B_{q}^{\frac{\gamma}{2}-\varepsilon, q}}^{p}\left([(j-1) \delta, j \delta), B_{q}^{\frac{1}{2}-2 \gamma, q}\left(\mathbb{T}_{L}\right)\right)\right)^{\frac{p}{q}} \leq\left\|u_{0}\right\|_{1,2}^{p} \tag{5.16}
\end{equation*}
$$

The proof of Lemma 5.4 is analogous to the proof of Lemma 4.2 [13], and hence the proof of Proposition 5.2 follows the lines of Proposition 4.2 [13].

### 5.2 Proof of the main result: Theorem [2.2]

This subsection is devoted to the proof of Theorem 2.2, While the proof is conceptually close to the proof of Theorem 1.2 [13], we are going to highlight the differences, induced by the presence of nonlinear terms $l(u)$ and $f(u)$.
Proposition 5.5. Denote

\mathcal{X}_{J}:=L^{2}\left([0, T] \times \mathbb{T}_{L}\right) \quad \text { (with weak topology) } \\
\mathcal{X}_{W}:=B C^{0}\left([0, T] ; H^{2}\left(\mathbb{T}_{L}\right) \times H^{2}\left(\mathbb{T}_{L}\right)\right)
\end{gathered}
$$

Then there exist random variables $\tilde{u}, \tilde{u}_{N}:[0,1] \rightarrow \mathcal{X}_{u}, J_{N}, J:[0,1] \rightarrow \mathcal{X}_{J}$ and $\tilde{\bar{W}}_{N}^{\prime}, \tilde{\bar{W}}:$ $[0,1] \rightarrow \mathcal{X}_{W}$ with $\left(\tilde{u}_{N}, \tilde{J}_{N}, \tilde{\bar{W}}_{N}^{\prime}\right) \sim\left(u_{N}, J_{N}, \bar{W}_{N}\right)$, where $J_{N}:=\chi_{v_{N}>0} v_{N}^{2}\left(\partial_{x}^{3} v_{N}\right)$. Furthermore, there are subsequences (still indexed with $N$ ), such that $\tilde{u}_{N}(\omega) \rightarrow \tilde{u}(\omega)$ in $\mathcal{X}_{u}$, $\tilde{J}_{N}(\omega) \rightharpoonup \tilde{J}(\omega)$ in $\mathcal{X}_{J}$ and $\tilde{\bar{W}}_{N}^{\prime}(\omega) \rightharpoonup \tilde{\bar{W}}(\omega)$ in $\mathcal{X}_{W}$ for every $\omega \in[0,1]$ as $N \rightarrow \infty$.
Proof. Once we introduce

\bar{W}_{N}^{0}(t, \cdot):=\left\{\begin{array}{l}
\bar{W}_{N}((j-1) \delta, \cdot) \text { for } t \in\left[(j-1) \delta,\left(j-\frac{1}{2}\right) \delta\right) \\
\bar{W}_{N}(2 t-j \delta, \cdot) \text { for } t \in\left[\left(j-\frac{1}{2}\right) \delta, j \delta\right)
\end{array}\right.
$$

and

$$
\tilde{\bar{W}}_{N}^{0}(t, \cdot):=\left\{\begin{array}{l}
\tilde{\bar{W}}_{N}^{\prime}((j-1) \delta, \cdot) \text { for } t \in\left[(j-1) \delta,\left(j-\frac{1}{2}\right) \delta\right) \\
\tilde{\bar{W}}_{N}^{\prime}(2 t-j \delta, \cdot) \text { for } t \in\left[\left(j-\frac{1}{2}\right) \delta, j \delta\right)
\end{array}\right.
$$

the rest of the proof becomes analogous to the proof of Proposition 5.2 [13.
In a similar way we get the analog of Proposition 5.3 [13]. In particular, the analogs of (5.4a)-(5.4c) in [13] in our case are

& \tilde{\beta}^{k}(t)=\lambda_{k}^{-1}\left(\tilde{W}_{2}(t), \Psi_{k}\right)_{2,2} \\
& \tilde{\beta}_{1}(t)=\gamma_{k}^{-1}\left(\tilde{W}_{1}(t), \Psi_{k}\right)_{2,2}
\end{aligned}

Corollary 5.6. For $\tilde{u}_{N}, \tilde{v}_{N}, \tilde{w}_{N}$ and $\tilde{u}$ in Proposition 5.5 we have

& \left\|\tilde{u}_{N}-u\right\|_{B C^{0}\left([0, T] \times \mathbb{T}_{L}\right)} \rightarrow 0 ; \\
& \left\|\tilde{v}_{N}-u\right\|_{L^{\infty}\left([0, T] \times \mathbb{T}_{L}\right)} \rightarrow 0 ; \\
& \left\|\tilde{w}_{N}-\tilde{u}\right\|_{L^{\infty}\left([0, T] \times \mathbb{T}_{L}\right)} \rightarrow 0
\end{aligned}
$$

as $N \rightarrow \infty \lambda_{[0,1]}$ almost surely.
The proof of this corollary is identical to Corrollary 5.4 [13]. Furthermore, we have the analog of Proposition 5.5 [13]:
Proposition 5.7. Let $\tilde{u}_{N}$ and $\tilde{u}$ be given in Proposition 5.5. Then there are subsequences of $\tilde{u}_{N}, \tilde{v}_{N}$ and $\tilde{w}_{N}$, still indexed with $N$, such that for any $p \in[2, \infty)$ we have $\tilde{u}_{N} \rightharpoonup^{*} \tilde{u}$, $\tilde{v}_{N} \rightharpoonup^{*} \tilde{u}$ and $\tilde{w}_{N} \rightharpoonup^{*} \tilde{u}$ in $L^{p}\left([0,1], L^{\infty}\left([0, T], H^{1}\left(\mathbb{T}_{L}\right)\right)\right.$ as $N \rightarrow \infty$. Furthermore,

\mathbb{E e s s s u p}_{t \in[0, T)}\|\tilde{u}(t)\|_{1,2}^{p} \leq C\left\|u_{0}\right\|_{1,2}^{p} \tag{5.17}
\end{equation*}

for some positive constant $C$ independent of $\tilde{u}$ and $u_{0}$.
Hence $\tilde{u}$ is a bounded continuous $H_{w}^{1}\left(\mathbb{T}_{L}\right)$ - valued process.
Proposition 5.8. Let $\tilde{u}_{N}, \tilde{u}, \tilde{J}_{N}$ and $\tilde{J}$ be as in Proposition 5.5. Then the distributional derivative $\partial_{x}^{3} \tilde{u}$ satisfies $\partial_{x}^{3} \tilde{u} \in L^{2}(\{\tilde{u}>r\})$ for any $r>0$. Furthermore, $\tilde{J}_{N}=\chi_{\tilde{v}_{N}>0} \tilde{v}_{N}^{2}\left(\partial_{x}^{3} \tilde{v}_{N}\right)$ and $\tilde{J}=\chi_{\tilde{u}>0} \tilde{u}_{N}^{2}\left(\partial_{x}^{3}\right) \lambda_{[0,1]}$ almost surely.

We may proceed with the scheme (2.2) - (2.3) to conclude that for $t \in[0, T)$ and $\delta=\frac{T}{N+1}$

& \left(v_{N}(t), \varphi\right)_{2}-\left(u_{0}, \varphi\right)_{2}=\left(v_{N}(t), \varphi\right)_{2}+\sum_{j=1}^{\left[\frac{t}{\delta}\right]}\left(-\left(v_{N}(j \delta, \cdot), \varphi\right)_{2}+\lim _{s \rightarrow j \delta}\left(w_{N}(s, \cdot), \varphi\right)_{2}\right) \\
& +\sum_{j=1}^{\left[\frac{t}{\delta}\right]}\left(\lim _{s \rightarrow j \delta}\left(v_{N}(s, \cdot), \varphi\right)_{2}-\left(w_{N}((j-1) \delta, \cdot), \varphi\right)_{2}-\left(v_{N}(0, \cdot), \varphi\right)_{2}\right. \\
& =\left(v_{N}(t), \varphi\right)_{2}-\left(v_{N}\left(\left[\frac{t}{\delta}\right] \delta, \cdot\right), \varphi\right)_{2}+\sum_{j=1}^{\left[\frac{t}{\delta}\right]}\left(\lim _{s \rightarrow j \delta}\left(v_{N}(s, \cdot), \varphi\right)_{2}-\left(v_{N}(j-1) \delta, \cdot\right), \varphi\right)_{2} \\
& +\sum_{j=1}^{\left[\frac{t}{\delta}\right]}\left(\lim _{s \rightarrow j \delta}\left(w_{N}(s, \cdot), \varphi\right)_{2}-\left(w_{N}(j-1) \delta, \cdot\right), \varphi\right)_{2}=\int_{0}^{t} \int_{\left\{v_{N}(s, \cdot)>0\right\}} v_{N}^{2}\left(\partial_{x}^{3} v_{N}\right)\left(\partial_{x} \varphi\right) d x d s \\
& -\frac{1}{2} \sum_{k \in \mathbb{Z}} \lambda_{k}^{2} \int_{0}^{\left[\frac{t}{\delta}\right] \delta}\left(\Psi_{k} \partial_{x}\left(\Psi_{k} w_{N}(s, \cdot)\right), \partial_{x} \varphi\right)_{2} d s+\int_{0}^{t}\left(l\left(v_{N}\right), \varphi\right)_{2} d s \\
& -\sum_{k \in \mathbb{Z}} \lambda_{k} \int_{0}^{\left[\frac{t}{\delta}\right] \delta}\left(\Psi_{k} w_{N}(s, \cdot), \partial_{x} \varphi\right)_{2} d \beta_{N}^{k}(s)+\sum_{k \in \mathbb{Z}} \gamma_{k} \int_{0}^{\left[\frac{t}{\delta}\right] \delta}\left(\Psi_{k} f\left(w_{N}(s, \cdot)\right), \varphi\right)_{2} d \beta_{1, N}^{k}(s)
\end{aligned}
$$

for all $\varphi \in C^{\infty}\left(\mathbb{T}_{L}\right)$. Changing the stochastic basis to

\left([0,1], \mathcal{F},(\mathcal{F})_{t \in[0, T]}, \lambda_{[0,1]}\right)
$$

for $\tilde{u}_{N}, \tilde{v}_{N}$ and $\tilde{w}_{N}$ we obtain

& \left(\tilde{v}_{N}(t, \cdot), \varphi\right)_{2}-\left(u_{0}, \varphi\right)_{2}=\int_{0}^{t} \int_{\left\{\tilde{v}_{N}(s, \cdot)>0\right\}} \tilde{v}_{N}^{2}\left(\partial_{x}^{3} \tilde{v}_{N}\right)\left(\partial_{x} \varphi\right) d x d s  \tag{5.18}\\
& -\frac{1}{2} \sum_{k \in \mathbb{Z}} \lambda_{k}^{2} \int_{0}^{\left[\frac{t}{\delta}\right] \delta}\left(\Psi_{k} \partial_{x}\left(\Psi_{k} \tilde{w}_{N}(s, \cdot)\right), \partial_{x} \varphi\right)_{2} d s+\int_{0}^{t}\left(l\left(\tilde{v}_{N}\right), \varphi\right)_{2} d s \\
& -\sum_{k \in \mathbb{Z}} \lambda_{k} \int_{0}^{\left[\frac{t}{\delta}\right] \delta}\left(\Psi_{k} \tilde{w}_{N}(s, \cdot), \partial_{x} \varphi\right)_{2} d \tilde{\beta}_{N}^{k}(s)+\sum_{k \in \mathbb{Z}} \gamma_{k} \int_{0}^{\left[\frac{t}{\delta}\right] \delta}\left(\Psi_{k} f\left(\tilde{u}_{N}(s, \cdot)\right), \varphi\right)_{2} d \tilde{\beta}_{1, N}^{k}(s)
\end{align*}

Lemma 5.9. Suppose $\tilde{u}_{N}, \tilde{v}_{N}, \tilde{w}_{N}, \tilde{u}, \tilde{v}, \tilde{w}$ are given in Propositions 5.5 and 5.7. Then for any $\varphi \in C^{\infty}\left(\mathbb{T}_{L}\right)$ and $t \in[0, T)$, there are subsequences, still denoted with $N$, such that

\sum_{k \in \mathbb{Z}} \lambda_{k}^{2} \int_{0}^{\left[\frac{t}{\delta}\right] \delta}\left(\Psi_{k} \partial_{x}\left(\Psi_{k} \tilde{w}_{N}(s, \cdot)\right), \partial_{x} \varphi\right)_{2} d s & \rightarrow \sum_{k \in \mathbb{Z}} \lambda_{k}^{2} \int_{0}^{\left[\frac{t}{\delta}\right] \delta}\left(\Psi_{k} \partial_{x}\left(\Psi_{k} \tilde{u}(s, \cdot)\right), \partial_{x} \varphi\right)_{2} d s  \tag{5.21}\\
\int_{0}^{t}\left(l\left(\tilde{v}_{N}\right), \varphi\right) d s & \rightarrow \int_{0}^{t}(l(\tilde{u}), \varphi) d s \tag{5.22}

-\sum_{k \in \mathbb{Z}} \lambda_{k} & \int_{0}^{\left[\frac{t}{\delta}\right] \delta}\left(\Psi_{k} \tilde{u}_{N}(s, \cdot), \partial_{x} \varphi\right)_{2} d \tilde{\beta}_{N}^{k}(s)+\sum_{k \in \mathbb{Z}} \gamma_{k} \int_{0}^{\left[\frac{t}{\delta}\right] \delta}\left(\Psi_{k} f\left(\tilde{u}_{N}(s, \cdot)\right), \varphi\right)_{2} d \tilde{\beta}_{1, N}^{k}(s) \rightarrow \\
& -\sum_{k \in \mathbb{Z}} \lambda_{k} \int_{0}^{t}\left(\Psi_{k} \tilde{u}(s, \cdot), \partial_{x} \varphi\right)_{2} d \tilde{\beta}^{k}(s)+\sum_{k \in \mathbb{Z}} \gamma_{k} \int_{0}^{t}\left(\Psi_{k} f(\tilde{u}(s, \cdot)), \varphi\right)_{2} d \tilde{\beta}_{1}^{k}(s) \tag{5.23}

Proof. The convergences (5.19) - (5.21) can be established the same way as in Lemma 5.7 [13]. Furthermore, the continuity of $l(u)$ implies $\left(l\left(\tilde{v}_{N}\right), \varphi\right)_{2} \rightarrow(l(\tilde{u}), \varphi)_{2}$ as $N \rightarrow \infty$ almost surely. Thus

\mathbb{E} \int_{0}^{t} \int_{0}^{L}\left(\left(l\left(\tilde{v}_{N}\right)-l(\tilde{u})\right)\right)^{2} d x d s \leq 2 \mathbb{E} \int_{0}^{t} \int_{0}^{L} l^{2}\left(\tilde{v}_{N}\right) \varphi^{2} d x d s+2 \mathbb{E} \int_{0}^{t} \int_{0}^{L} l^{2}(\tilde{u}) \varphi^{2} d x d s:=J_{1}+J_{2} .
$$

Using (5.7) and Sobolev embedding, we have

J_{1} \leq C_{1} \mathbb{E} \operatorname{esssup} \sup _{x \in \mathbb{T}_{L}}\left|l^{2}\left(\tilde{v}_{N}(t, x)\right)\right| \leq C_{2} \mathbb{E} \operatorname{esssup}\left\|v_{N}\right\|_{1,2}^{2 \lambda} \leq C_{3}\left\|u_{0}\right\|_{1,2}^{2 \lambda}
$$

In view of Proposition 5.7, the same estimate holds for $J_{2}$ as well. Thus, by Vitali's convergences theorem, we have (5.22). Finally, the convergence (5.23) can be shown the same way as the convergence of the last two terms in (4.56) in the proof of Theorem 4.2, Hence the proof of Lemma 5.9 follows.

We may now use Lemma 5.9 to pass to the limit as $N \rightarrow \infty$ in (5.18), which concludes the proof of Theorem 2.2.
