Efficient Algorithms for Attributed Graph Alignment with Vanishing Edge Correlation

Abstract

Graph alignment refers to the task of finding the vertex correspondence between two correlated graphs of n vertices. Extensive study has been done on polynomial-time algorithms for the graph alignment problem under the Erdős–Rényi graph pair model, where the two graphs are Erdős–Rényi graphs with edge probability q_u , correlated under certain vertex correspondence. To achieve exact recovery of the correspondence, all existing algorithms at least require the edge correlation coefficient ρ_u between the two graphs to be *non-vanishing* as $n \to \infty$. Moreover, it is conjectured that no polynomial-time algorithm can achieve exact recovery under vanishing edge correlation $\rho_u < 1/\text{polylog}(n)$. In this paper, we show that with a vanishing amount of additional *attribute information*, exact recovery is polynomial-time feasible under *vanishing* edge correlation $\rho_u \geq n^{-\Theta(1)}$. We identify a *local* tree structure, which incorporates one layer of user information and one layer of attribute information, and apply the subgraph counting technique to such structures. A polynomial-time algorithm is proposed that recovers the vertex correspondence for most of the vertices, and then refines the output to achieve exact recovery. The consideration of attribute information is motivated by real-world applications like LinkedIn and Twitter, where user attributes like birthplace and education background can aid alignment.

I. INTRODUCTION

Graph alignment for the Erdős–Rényi graph pair. The graph alignment problem, also referred to as the graph matching or noisy graph isomorphism problem, is the problem of finding the correspondence between the vertices of two correlated graphs. This problem has garnered significant attention due to its widespread use in various real-world applications (Cho and Lee, 2012; Haghighi et al., 2005; Korula and Lattanzi, 2014; Narayanan and Shmatikov, 2009; Singh et al., 2007). The graph alignment problem has been studied under various graph generation models. Among those models, the most well-studied one is the Erdős–Rényi graph pair model $\mathcal{G}(n, q_u, \rho_u)$ by Pedarsani and Grossglauser (2011). In this model, let Π^* denote an underlying permutation on $[n] \triangleq \{1, \ldots, n\}$ drawn uniformly at random. We generate two graphs G_1 and G'_2 with vertex set [n] as follows: For integers (i, j) with $1 \le i < j \le n$, the pair of indicators $(\mathbb{1}_{\{(i,j)\in G_1\}}, \mathbb{1}_{\{(\Pi^*(i),\Pi^*(j))\in G'_2\}})$ are i.i.d pairs of Bernoulli random variables with mean q_u and correlation coefficient ρ_u . Given a pair of graphs $(G_1, G'_2) \sim \mathcal{G}(n, q_u, \rho_u)$, the goal is to exactly recover the underlying permutation Π^* .

Two main lines of study have emerged in the graph alignment problem. In the first line, researchers assume unlimited computational resources and study the range of graph parameters q_u and ρ_u such that recovering the permutation II* is feasible or infeasible (Cullina and Kiyavash, 2016; Cullina and Kiyavash, 2017; Pedarsani and Grossglauser, 2011; Wu et al., 2022). This is commonly known as the *information-theoretic limit*. The second line of study focuses on the region of graph statistics where exact alignment is feasible with polynomial-time algorithms (Dai et al., 2019; Ding and Li, 2023; Ding et al., 2021; Fan et al., 2020; Mao et al., 2021, 2023a,b). This region is commonly known as the polynomial-time feasible region. Compared to the information-theoretic feasible region, the best-known polynomial-time feasible region requires further assumptions regarding the edge correlation coefficient ρ_u . To the best of our knowledge, the best-known polynomial-time feasible region is achieved together by Mao et al. (2023b) and Ding and Li (2023). The proposed polynomial-time algorithm by Mao et al. (2023b) achieves exact recovery, provided that ρ_u exceeds a threshold of $\sqrt{\alpha}$, where $\alpha \approx 0.338$ corresponds to Otter's tree counting constant (Otter, 1948). In the most recent development, Ding and Li (2023) specifically focus on the dense regime, characterized

by $nq_u = n^{\Theta(1)}$, and propose a novel polynomial-time algorithm that further relaxes the correlation requirement to $\rho_u > \beta$, where β represents an arbitrarily small constant. We delineate the polynomial-time feasible region together with the information-theoretic limit in Figure 1a. The question of whether there exists any polynomialtime algorithm that achieves exact recovery in the information-theoretic feasible region with $\rho_u < \sqrt{\alpha}$ in the sparse regime $nq_u = n^{o(1)}$ or with $\rho_u = o(1)$ in the dense regime $nq_u = n^{\Theta(1)}$ remains open, and the non-existence of such polynomial-time algorithms is conjectured by Yu (2023) and Mao et al. (2022).



Fig. 1: Comparison between polynomial-time feasible regions with (a) no attribute information and (b) vanishing attribute information. Figure 1a is when $mq_a\rho_a = 0$. The green region represents the best-known polynomial-time feasible region. The portion above the red dotted line is attainable using the algorithm by Mao et al. (2023b), while the section to the right of the black dotted line is achievable with the algorithm introduced by Ding and Li (2023). It is further conjectured by Yu (2023) and Mao et al. (2022) that no polynomial-time algorithm achieves exact recovery in the red region. Figure 1b is an example of vanishing attribute information $m = \sqrt{n}$, $q_a = \frac{n^{-7/16}}{\sqrt{\log n}}$ and $\rho_a = n^{-1/16}$. The green region is feasible by the proposed algorithm in this work. Note that for clarity the ρ_u axis in the plots are not scaled linearly.

Attributed graph alignment. As mentioned above, it is computationally challenging to achieve exact recovery in the low-correlation regime using only the vertex connection information. This motivates us to exploit additional side information about vertices, termed *attributes*, which are often widely available in real-world applications, to facilitate graph alignment. Examples of publicly available attribute information include (1) LinkedIn user profiles containing age, birthplace, and affiliation and (2) Netflix users' movie-watching histories and ratings. The utilization of attribute information has been considered in various of graph inference tasks such as community detection (Deshpande et al., 2018; Lu and Sen, 2023; Saad and Nosratinia, 2020), link prediction (Feng and Dai, 2023; Nie et al., 2024) and so on. In the context of graph alignment, a natural question is how does the existence of such attribute information facilitate the matching process?

To theoretically study the attributed graph alignment problem, the *attributed Erdős–Rényi graph pair model* $\mathcal{G}(n, q_u, \rho_u; m, q_a, \rho_a)$ is proposed by Zhang et al. (2024). In the proposed model, two attributed graphs G_1 and G'_2 both with n+m vertices are generated. The vertex set of both graphs G_1 and G'_2 can be partitioned into two subsets. The first subset includes vertices $[n] \triangleq \{1, \ldots, n\}$ which are called the users. The second subset includes vertices $\{a_1, \ldots, a_m\}$, which are called the attributes. Let Π^* denote a permutation on [n] drawn uniformly at random, which represents the relabelling of user vertices. In the two graphs, the user-user edges are randomly generated in the same manner as the edges in the Erdős–Rényi graph pair model $\mathcal{G}(n, q_u, \rho_u)$. In this model, we also generate edges between the attributes and users to represent the attachment of those attributes to users. For a user vertex i and an attribute vertex a_j , the pair of user-attribute edge indicators $(\mathbbm 1_{\{(i,a_j)\in G_1\}}, \mathbbm 1_{\{(\Pi^*(i),a_j)\in G'_2\}})$ are i.i.d pairs of Bern (q_a) random variables with correlation coefficient ρ_a^{-1} . Similarly to the Erdős–Rényi graph pair model, our

goal is to recover the underlying permutation Π^* .

Constant user-user edge correlation in prior work. The study by Zhang et al. (2024) provides an extensive investigation of the information-theoretic limit for graph alignment. The authors almost tightly characterize both the feasible and infeasible regions, with some gaps remaining in certain regimes. Computationally efficient algorithms for attributed graph alignment have been studied by Wang et al. (2024), where two polynomial-time algorithms are proposed and shown to achieve exact recovery with any $\rho_u = \Theta(1)$.² Both algorithms proposed by Wang et al. (2024) take a two-step approach. In the first step, user-attribute connection information is used to align a part of the users which are called the anchors, and in the second step, user-user connections between the anchors and the remaining users are used to complete the alignment. Compared to the state-of-the-art polynomial-time feasible region under the Erdős–Rényi graph pair model without attributes, the benefit of attribute information is reflected by lowering the requirement on ρ_u from $\rho_u > \sqrt{\alpha}$ to $\rho_u = \Theta(1)$. Despite the progress, the performance of algorithms by Wang et al. (2024) is largely constrained by the two-step procedure. Although both user-user and user-attribute edge information are available, they are *separately* used in the two steps for alignment. Moreover, this two-step procedure requires the exact accuracy of both steps, further restricting the feasible region.

Our results. In this paper, we advance the state-of-the-art polynomial-time feasible region and propose a polynomial-time algorithm that achieves exact recovery with edge correlation $\rho_u \ge n^{-\Theta(1)}$ by leveraging a small amount of attribute information. Theorem 2 presents the detailed conditions for the proposed algorithm to achieve exact recovery. To demonstrate a direct comparison to a few existing results on polynomial-time algorithms for graph alignment, we consider an example with attribute-related graph parameters fixed to $m = \sqrt{n}$, $q_a = \frac{n^{-7/16}}{\sqrt{\log n}}$ and $\rho_a = n^{-1/16}$, and delineate the feasible region of the proposed algorithm in terms of ρ_u and nq_u in Figure 1b. In this example, the amount of attribute side information in the graph generation model is small in the sense that for two correctly matched users *i* and $\Pi^*(i)$, the expected number of common attribute neighbors is given by $mq_u\rho_u(1+o(1)) = \frac{1+o(1)}{\sqrt{\log n}}$, which is vanishing as $n \to \infty$. In the following, we separately compare the feasible region in Figure 1b to the best-known polynomial-time feasible region for graph alignment without attributes by Mao et al. (2023b) and the best-known polynomial-time feasible region for attributed graph alignment by Wang et al. (2024). In addition, we specialize the attributed graph alignment problem to the seeded graph alignment problem, which is another variation of graph alignment, and compare the feasible region of the proposed algorithm to that of the best-known polynomial-time algorithms proposed by Mossel and Xu (2020). leftmargin=1.5em

- Compared to the feasible region by Mao et al. (2023b) shown in Figure 1a, we observe that the feasible region of the proposed algorithm shown in Figure 1b allows a vanishing correlation coefficient $\rho_u = \Omega(n^{-3/16+\delta})$, where δ is an arbitrarily small constant, instead of requiring ρ_u to be greater than certain constant. In other words, a small amount of attribute information significantly facilitates the computation in the graph alignment problem by lowering the requirement on ρ_u in the feasible region of polynomial-time algorithms.
- Compared to the feasible region by Wang et al. (2024), we observe that none of the feasible region shown in Figure 1b can be achieved by the algorithms by Wang et al. (2024) for two reasons. Firstly, the feasible region presented by Wang et al. (2024) does not allow such a small amount of attribute information $mq_a\rho_a = \frac{1}{\sqrt{\log n}}$. Secondly, the algorithms by Wang et al. (2024) require both ρ_a and ρ_u to be constants, while in this example we set $\rho_a = n^{-1/16}$ and allow any $\rho_u = \Omega(n^{-3/16+\delta})$. However, to make the comparison fair, we point out there also exists certain feasible region achieved by the algorithms by Wang et al. (2024), but not by the proposed algorithm in this work. The feasible region in this work requires a necessary condition $m = n^{\Theta(1)}$, while that in Wang et al. (2024) allows certain feasible region with $m = n^{o(1)}$.
- Consider the attributed Erdős–Rényi graph pair model G(n, q_u, ρ_u; m, q_a, ρ_a) with q_u = q_a and ρ_u = ρ_a. In this model, the m attributes can be interpreted as m seeds in the seeded graph alignment problem. Compared to the best-known existing algorithms for seeded graph alignment proposed by Mossel and Xu (2020), the proposed algorithm in this work can tolerate a weaker edge correlation ρ_u between the two graphs. While the edge correlation ρ_u being a constant appears as a necessary condition in the feasible region of all the algorithms by Mossel and Xu (2020), the proposed algorithm's feasible region covers values of ρ_u ranging from Θ(n^{-Θ(1)}) to Θ(1). Moreover, if we restrict the consideration to the case of ρ_u = Θ(1), the proposed algorithm requires strictly fewer seeds than the algorithms by Mossel and Xu (2020) if nq_u = n^c for 1/3 < c < 1 and c ≠ 1/2. To

provide a fair comparison, it is worth mentioning that when c is a constant not satisfying these two conditions or c = o(1), the proposed algorithm requires strictly more seeds. We provide the detailed justification for the above comparison in Appendix D.

Why can we achieve diminishing correlation coefficient with attributes? The proposed attributed graph alignment algorithm is based on the technique of subgraph counting, which is widely applied to various network analysis problems including cluster identification (Mossel et al., 2014), hypothesis testing (Mao et al., 2022) and graph alignment under the Erdős–Rényi graph pair model (Barak et al., 2019; Mao et al., 2023b). In this work, we identify a family of local tree structures involving both users and attributes. The family of trees are indexed by the $\binom{m}{k}$ size-k attribute subsets, and each of them comprises k independent length-2 paths connecting the root node i to the k distinct attributes within its index subset, passing through some user vertices. An example of an attributed tree from this family is depicted in Figure 2a. By counting the occurrence of these simple tree structures rooted at each user i, we are able to construct a feature vector of length $\binom{m}{k}$ for each i. Utilizing the similarity of these feature vectors, we can successfully align almost all users under a vanishing edge correlation $\rho_u = n^{-\Theta(1)}$.



Fig. 2: Comparison of subgraphs counted in Mao et al. (2023b) and in this work. Figure 2a provides an example of the attributed subgraph we propose to count. In this example, we have k = 3 branches, and each red node represents an attribute. Figure 2b provides an example of a chandelier. The structures enclosed by the ovals are the bulbs.

In the context of graph alignment without attributes, a polynomial-time algorithm based on subgraph counting is proposed by Mao et al. (2023b). This algorithm relies on counting a family of subgraph structures called the *chandeliers*. Chandeliers are delicately designed trees rooted at *i*, and each branch of the tree consists of a path starting at *i* followed by a rooted tree structure called a *bulb*. See Figure 2b for an example of a chandelier. By counting the chandeliers, the algorithm proposed by Mao et al. (2023b) can correctly align almost all the vertices under a constant correlation $\rho_u > \sqrt{\alpha}$.

When comparing chandeliers to the local attributed tree structures counted in this work, we observe a key distinction: while the local attributed trees connect the root *i* to a set of *labelled* attributes, the chandeliers connect the root *i* to a set of *unlabelled* bulbs. As the bulbs are unlabelled trees, it remains uncertain whether a bulb observed in G_1 matches a same bulb observed in G'_2 . Consequently, bulbs can be considered as a form of *noisy* signal for detecting vertex correspondence, whereas the attributes in the proposed tree structures provide a *noiseless* signal. This crucial distinction renders the proposed algorithm more robust against edge perturbations between the two graphs, enabling a wider range of edge correlation ρ_u in the feasible region. Another distinction between the attributed trees and the chandeliers lies in the length of the paths. In the attributed trees, the length of each path is fixed to 2, while in the chandeliers, the path length between the root and a bulb goes to infinity as *n* grows. In subgraph structures, the vertices on the paths are unlabelled, and thus, a longer wire length would introduce higher noise levels in the subgraph counting algorithm. In chandeliers, the wire length needs to be large enough to counterbalance the noise induced by the overlap in bulb structures. But in our case, as the attributes are individual vertices, we can set the path length to the minimum value of 2, thereby reducing noise in the alignment process.

More details on attributed graph alignment. Recall that G_1 and G'_2 are the two attributed graphs generated from $\mathcal{G}(n, q_u, \rho_u; m, q_a, \rho_a)$. For graph G_1 , its user-user connection and user-attribute connection are captured by two adjacency matrices A^u and A^a respectively. The matrix A^u is an $n \times n$ symmetric matrix with all-zero diagonal

entries. For a pair of distinct users $(i, j) \in [n] \times [n]$, the entry A_{ij}^{u} denotes the indicator of whether the edge (i, j)exists in G_1 . The matrix A^{a} is an $n \times m$ matrix. For a pair of user and attribute $(i, a_j) \in [n] \times \{a_1, \ldots, a_m\}$, entry A_{ij}^{a} denotes the indicator of whether the edge (i, a_j) exists in G_1 . For graph G'_2 , we similarly use two adjacency matrices B^{u} and B^{a} to capture its user-user connection and user-attribute connection respectively. Let $\sigma_{u}^{2} \triangleq q_{u}(1 - q_{u})$ denote the variance of a non-diagonal entry in A^{u} or B^{u} , and $\sigma_{a}^{2} \triangleq q_{a}(1 - q_{a})$ denote the variance of an entry in A^{a} or B^{a} . For a given attributed graph G, let $\mathcal{V}^{u}(G)$ denote the set of user vertices in G, $\mathcal{V}^{a}(G)$ denote the set of attribute vertices in G, and $\mathcal{V}(G) \triangleq \mathcal{V}^{u}(G) \cup \mathcal{V}^{a}(G)$. For the edges in G, let $\mathcal{E}^{u}(G)$ denote the set of all user-user edges in G, $\mathcal{E}^{a}(G)$ denote the set of all user-attribute edges in G, and $\mathcal{E}(G) \triangleq \mathcal{E}^{a}(G) \cup \mathcal{E}^{u}(G)$. Let G^{u} denote the induce subgraph of G on its set of users $\mathcal{V}^{u}(G)$. Let G^{a} be the graph such that $\mathcal{V}(G^{a}) = \mathcal{V}(G)$ and $\mathcal{E}(G^{a}) = \mathcal{E}^{a}(G)$. In other words, G^{u} and G^{a} denote the user part and the user-attribute part of G respectively. For graphs G_1 and G'_2 , we define short-hand notation $\mathcal{V}_{1}^{u} \triangleq \mathcal{V}^{u}(G_1)$, $\mathcal{E}_{2}^{u} \triangleq \mathcal{E}^{a}(G_2)$, $\mathcal{E}_{1} \triangleq \mathcal{E}(G_1)$, and $\mathcal{E}_{2} \triangleq \mathcal{E}(G'_2)$.

II. MAIN RESULTS AND PROPOSED ALGORITHMS

In this section, we present characterizations of polynomial-time feasible regions and our proposed polynomialtime algorithms that achieve these feasible regions. In Section II-A, we provide polynomial-time feasible regions for almost exact recovery and exact recovery, in Theorem 1 and Theorem 2, respectively. In Section II-B, we describe the proposed algorithm for almost exact recovery, which is based on subgraph counting. In Section II-C, we present two refinement algorithms, which build upon the output of the almost exact recovery algorithm to achieve exact recovery. These two algorithms work in two different regimes defined based on how much attribute information is available.

A. Polynomial-time feasible regions

Theorem 1 (Almost exact recovery). Consider an attributed Erdős–Rényi graph pair model $\mathcal{G}(n, q_u, \rho_u; m, q_a, \rho_a)$. Suppose

$$nq_{\rm u}\rho_{\rm u} = \omega(1),$$
 (1) $m\rho_{\rm a}^2\rho_{\rm u}^2 = \omega(n^{2/k}),$ (2) $n\rho_{\rm u}^2 = \omega(n^{2/k}),$ (3)

$$mq_{\rm a}\rho_{\rm a} = \omega \left(\frac{n^{2/k}}{n\rho_{\rm u}^2}\right) \quad and \quad mq_{\rm a}\rho_{\rm a} = \omega \left(\frac{1}{nq_{\rm u}\rho_{\rm u}}\right)$$
(4)

for some positive integer $k \geq 3$. Then with high probability, Algorithm 1 with parameters k and

$$\tau = c \binom{m}{k} (\rho_{\rm u} \sigma_{\rm u}^2)^k (\rho_{\rm a} \sigma_{\rm a}^2)^k \binom{n-1}{k} k!$$
(5)

for some constant 0 < c < 1 outputs an index set I and a vertex correspondence estimate $\hat{\Pi} : I \to [n]$ satisfying that

1) $\hat{\Pi}(i) = \Pi^*(i), \forall i \in I;$ 2) $|I| \ge n - o(n).$

We outline the key steps for establishing Theorem 1 in Section III, while deferring the detailed proof to Appendices A and B.

Theorem 2 (Exact recovery). Consider an attributed Erdős–Rényi graph pair $\mathcal{G}(n, q_u, \rho_u; m, q_a, \rho_a)$. Suppose conditions (1)–(4) in Theorem 1 are satisfied. Additionally, assume there exists some arbitrarily small positive constant ϵ such that

$$nq_{\rm u}(q_{\rm u} + \rho_{\rm u}(1 - q_{\rm u})) + mq_{\rm a}(q_{\rm a} + \rho_{\rm a}(1 - q_{\rm a})) \ge (1 + \epsilon)\log n,\tag{6}$$

$$\frac{\rho_{\rm u}(1-q_{\rm u})}{q_{\rm u}} \ge \epsilon \quad and \quad \frac{\rho_{\rm a}(1-q_{\rm a})}{q_{\rm a}} \ge \epsilon. \tag{7}$$

Then, there exists some polynomial-time algorithm that outputs a permutation $\hat{\Pi}$, which exactly recovers Π^* with high probability, i.e., $P(\hat{\Pi} = \Pi^*) = 1 - o(1)$.



Fig. 3: An example of computing $\omega_1(S)$. In graph S, edge $(4, a_3)$ appears in G_1 , while (2, 4) and $(2, a_1)$ do not. Therefore, these three edges have weights $1 - q_a, -q_u$ and $-q_a$ respectively, and the weight of S in G_1 is $\omega_1(S) = (1 - q_a)q_uq_a$.

The proof of Theorem 2 is presented in Appendix C.

Remark 1 (Interpretation of conditions for exact recovery). In this remark, we provide an interpretation for conditions Theorems 1 and 2. Condition (1) is known as the information theoretic limit of almost exact recovery under the Erdős–Rényi graph pair model (Cullina et al., 2019). As previously explained in our introduction, the quantity $mq_a\rho_a$ represents the expected number of common attribute neighbors for two correctly matched users, which characterizes the amount of attribute information in the model. Equation (4) provides lower bounds on the amount of attribute information. Equations (2) and (3) are lower bounds for edge correlations ρ_u and ρ_a . These are in line with the constant correlation assumption (for example $\rho_u = \Theta(1)$ and $\rho_a = \Theta(1)$ by Wang et al. (2024)). In our later discussion in Appendix E, we illustrate the necessity of conditions (1)-(4) for the proposed algorithm to achieve exact recovery. Conditions (6) and (7) can be better understood under an equivalent subsampling formulation of the attributed Erdős–Rényi graph pair model $\mathcal{G}(n, p, s_u; m, q, s_a)$ by Wang et al. (2024), where p and q are the edge probabilities for user-user edges and user-attribute edges. Under this model, condition (6) is equivalent to $nps_u^2 + mqs_a^2 \ge (1 + \epsilon) \log n$, which is the information-theoretic limit for exact recovery for a certain range of graph parameters (Zhang et al., 2024). Condition (7) represents the mild condition that the base graph edge probabilities p and q are base graph edge formation.

B. Proposed subgraph counting algorithm for almost exact recovery

In this section, we introduce the proposed subgraph counting algorithm. For graph G_1 , let $\tilde{A}^{u} \triangleq A^{u} - q_{u}$ denote the $n \times n$ normalized matrix with $\tilde{A}^{u}_{ij} = A^{u}_{ij} - q_{u}$, and $\tilde{A}^{a} \triangleq A^{a} - q_{a}$ denote the $n \times m$ normalized matrix with $\tilde{A}^{a}_{ij} = A^{a}_{ij} - q_{a}$. For graph G'_2 , we similarly define the two normalized adjacency matrices $\tilde{B}^{u} \triangleq B^{u} - q_{u}$ and $\tilde{B}^{a} \triangleq B^{a} - q_{a}$. As a result, all the off-diagonal entries of \tilde{A}^{u} and \tilde{B}^{u} and all entries of \tilde{A}^{a} and \tilde{B}^{a} have zero means.

Suppose we have an attributed graph S with $\mathcal{V}^{u}(S) \subseteq [n]$ and $\mathcal{V}^{a}(S) \subseteq \mathcal{V}^{a}$. We define the weight of S in graph G_{1} as

$$\omega_1(S) \triangleq \prod_{e \in \mathcal{E}^{\mathrm{u}}(S)} \tilde{A}_e^{\mathrm{u}} \prod_{f \in \mathcal{E}^{\mathrm{a}}(S)} \tilde{A}_f^{\mathrm{a}}.$$
(8)

Similarly, we define the weight of S in graph G'_2 as

$$\omega_2(S) \triangleq \prod_{e \in \mathcal{E}^{\mathrm{u}}(S)} \tilde{B}_e^{\mathrm{u}} \prod_{f \in \mathcal{E}^{\mathrm{a}}(S)} \tilde{B}_f^{\mathrm{a}}.$$
(9)

Note in the definitions above, graph S is not necessarily a subgraph of G_1 or G'_2 . Instead, S is a subgraph of the complete attributed graph defined on user set [n] and attribute set \mathcal{V}^a . We provide an example of computing the weight $\omega_1(S)$ for some $S \not\subseteq G_1$ in Figure 3.

With the weight of a subgraph defined, we introduce the family of subgraphs we propose to count. Fix a user vertex $i \in [n]$ and an attribute subset $\mathcal{A} \subseteq \mathcal{V}^{a}$ of size k, we define $\mathcal{G}_{i,\mathcal{A}}$ as the collection of all attributed graphs of the following structure: graphs in $\mathcal{G}_{i,\mathcal{A}}$ are trees rooted at i. Each tree has k branches, and each branch is a path of

length 2. The k vertices one hop away from the root i are user vertices from $[n] \setminus \{i\}$, and the k vertices two hops away from the root i are the k attributes in \mathcal{A} . In other words, $\mathcal{G}_{i,\mathcal{A}}$ includes all the ways of forming k length-2 independent paths from i to the k attributes in \mathcal{A} . We notice that for any $i \in [n]$ and $\mathcal{A} \subseteq \mathcal{V}^a$ of size k,

$$|\mathcal{G}_{i,\mathcal{A}}| = \binom{n-1}{k} k!. \tag{10}$$

This is because in the graph structure we mentioned above, we only have the flexibility to choose the k user vertices that are one hop away from i out of n-1 users in $[n] \setminus \{i\}$, and the order of choosing those user vertices matters. Given a fixed user vertex $i \in [n]$ and an attribute subset $\mathcal{A} \subseteq \mathcal{V}^{a}$ of size k, we define the weighted count of the collection $\mathcal{G}_{i,\mathcal{A}}$ in \mathcal{G}_{1} as

$$W_{i,\mathcal{A}}(G_1) \triangleq \sum_{S \in \mathcal{G}_{i,\mathcal{A}}} \omega_1(S).$$
(11)

Similarly we define the subgraph count in G'_2 as

$$W_{i,\mathcal{A}}(G_2') \triangleq \sum_{S \in \mathcal{G}_{i,\mathcal{A}}} \omega_2(S).$$
(12)

In the proposed graph counting algorithm, for each user vertex $i \in \mathcal{V}_1^{\mathrm{u}}$, we compute $W_{i,\mathcal{A}}(G_1)$ for each attribute subset \mathcal{A} of size k, and use them to form a feature vector of length $\binom{m}{k}$. For each user vertex $j \in \mathcal{V}_2^{\mathrm{u}}$, a feature vector is constructed similarly by computing $W_{j,\mathcal{A}}(G'_2)$ for each $\mathcal{A} \subseteq \mathcal{V}^{\mathrm{a}}$ of size k. Given the feature vectors, for a pair of user vertices $(i, j) \in \mathcal{V}_1^{\mathrm{u}} \times \mathcal{V}_2^{\mathrm{u}}$, we define their similarity score Φ_{ij} as the inner product of their feature vectors:

$$\Phi_{ij} \triangleq \sum_{\mathcal{A} \in \mathcal{V}^{\alpha}: |\mathcal{A}|=k} W_{i,\mathcal{A}}(G_1) W_{j,\mathcal{A}}(G'_2).$$
(13)

In the proposed algorithm, a threshold is set on the similarity scores to determine if user i should be mapped to j. We provide a detailed description of the proposed algorithm in Algorithm 1.

Remark 2 (Complexity of Algorithm 1). The time complexity of Algorithm 1 is $O(n^{k+1}m^k)$. To see this, notice that computing $W_{i,\mathcal{A}}(G_1)$ for a vertex $i \in \mathcal{V}_1^u$ requires $O(n^k)$ complexity because $|\mathcal{G}_{i,\mathcal{A}}| = \binom{n-1}{k}k!$. Moreover, there are $\binom{m}{k}$ attribute subsets of size k. Therefore, computing the feature vectors for all the users in G_1 requires $O(n^{k+1}m^k)$ time complexity. Similarly, the same time complexity is required for computing the feature vectors for all users in G'_2 . For computing the similarity scores, the time complexity is $O(n^2m^k)$, because we need to compute the score for n^2 pairs of users and each feature vector has length $\binom{m}{k}$. The total time complexity of the algorithm is $O(n^{k+1}m^k)$ because $k \ge 3$. Under our choice of $k = \Theta(1)$ in Theorem 1, Algorithm 1 runs in polynomial-time.

Remark 3 (Choice of parameter k). Regarding the choice of k, there is a trade-off between the time complexity and the size of the feasible region. As elaborated in Remark 2, the time complexity of the proposed algorithm scales

as $O(n^{k+1}m^k)$, which increases as k assumes larger values. Conversely, as indicated by the conditions (2)-(4), a larger value of k expands the feasible parameter range. Therefore, to minimize the time complexity of the algorithm, we can optimally choose k to be the smallest integer such that (2)-(4) are satisfied.

Remark 4 (Intuition behind the proposed statistics). The intuition behind the proposed statistic becomes clearer if we consider the unnormalized adjacency matrices A^u, A^a, B^u, B^a when computing the subgraph weights in equations (8) and (9). In this case, the weights $\omega_1(S)$ and $\omega_2(S)$ simply indicate whether S is a subgraph of G_1 and G'_2 respectively. For instance, with k = 2 and attribute set $\mathcal{A} = \{a_1, a_2\}$, the feature vector entry $W_{i,\mathcal{A}}(G_1)$ represents the number of desired trees with root i and leaves a_1 and a_2 in G_1 . When (i, j) is the correct pair, $W_{i,\mathcal{A}}(G_1)$ and $W_{j,\mathcal{A}}(G'_2)$ are positively correlated, whereas they are nearly independent for incorrect pairs. This leads to a higher mean of the product $W_{i,\mathcal{A}}(G_1)W_{j,\mathcal{A}}(G'_2)$ for correct pairs. Aggregating the positive correlation over all attribute subsets \mathcal{A} via taking the inner product of feature vectors yields a robust similarity metric resilient to edge perturbation.

C. Refinement algorithms for exact recovery

In this section, we introduce two algorithms for refining the permutation $\hat{\pi}$ found by Algorithm 1 to recover the correspondence of all users. The two algorithms work in the attribute information sparse regime $mq_a\rho_a = o(\log n)$ and the attribute information rich regime $mq_a\rho_a = \Omega(\log n)$ respectively. We later refer to these two regimes as the ATTRSPARSE regime and the ATTRRICH regime.

Before we introduce the two algorithms, we first set up essential notation for the neighborhood of user vertices. Given $I' \subseteq [n]$ and injection $\pi : I' \to [n]$, for a pair of users $i \in \mathcal{V}_1^u$ and $j \in \mathcal{V}_2^u$, we define $N_{\pi}^u(i, j)$ as the number of common user neighbors of i in G_1 and j in G'_2 under the mapping π . In other words, $N_{\pi}^u(i, j)$ represents the number of vertices $u \in I'$ such that i is connected to u in G_1 and j is connected to $\pi(u)$ in G'_2 . Moreover, for a pair of user $i \in \mathcal{V}_1^u$ and $j \in \mathcal{V}_2^u$, we define $N^a(i, j)$ as the number of common attribute neighbors of i and j, i.e., the number of attributes $a \in \mathcal{V}^a$ such that a is connected to i in G_1 and a is connected to j in G'_2 . We are now ready to introduce the two refinement algorithms.

Refinement algorithm in ATTRSPARSE regime. In this regime, since the amount of attribute information in the two graphs is limited, we use only the user-user edges to align the unmatched users. More explicitly, a pair of users are matched if they have enough matched common user neighbors. The detailed refinement algorithm is stated as Algorithm 2.

Input : Graphs G_1 and G'_2 , graph parameters q_u , threshold parameter γ_1 , outputs I and $\hat{\pi}$ from Algorithm 1 Output: Refined mapping $\tilde{\pi}$ 1 $J \leftarrow I$, $\tilde{\pi} \leftarrow \hat{\pi}$. while $\exists i \notin J, j \notin \tilde{\pi}(J) : N^u_{\pi}(i, j) \ge \gamma_1(n-2)q^2_u$ do 2 $\lfloor \tilde{\pi}(i) \leftarrow j, J \leftarrow J \cup \{i\}$. 3 return $\tilde{\pi}$.

Remark 5 (Complexity of Algorithm 2). The time complexity of Algorithm 2 is $O(n^3)$. To see the time complexity of Algorithm 2, we need to analyze the complexity of updating $N^{u}_{\pi}(u, v)$ for all pairs of users (u, v) throughout the process. Notice that in each execution of the while loop in Algorithm 2, we just need to update $N^{u}_{\pi}(u, v)$ for those user pairs (u, v) such that u is connected to i in G_1 and v is connected to $\tilde{\pi}(i)$ in G_2 , where i is the vertex newly added to I. This implies that in each while loop, the time complexity of updates is bounded by $d_{G_1}(i)d_{G'_2}(\tilde{\pi}(i))$, where $d_{G_1}(i)$ and $d_{G'_2}(\tilde{\pi}(i))$ represent the degree of i in G_1 and the degree of $\tilde{\pi}(i)$ in G'_2 respectively. Because the number of iterations is O(n) and the order of the user degrees are O(n), the total time complexity is $O(n^3)$.

We comment that Algorithm 2 is first proposed by Mao et al. (2023b). In this work, we adapt the original analysis to allow the vanishing correlation regime $\rho_u = o(1)$.

Refinement algorithm in ATTRRICH regime. In this regime, because we have a considerable amount of attribute information, we collaboratively consider user-user edges and user-attribute edges to align the unmatched users. More specifically, each pair of user vertices are matched if they have enough matched common user neighbors *or* enough common attribute neighbors. The detailed refinement algorithm is delineated as Algorithm 3.

2 L π̃(i) ← j, J ← J ∪ {i}.

Remark 6 (Time complexity of Algorithm 3). The time complexity of Algorithm 3 is $O(n^3 + n^2m)$. Compared to Algorithm 2, Algorithm 3 additionally needs to compute $N^a(u, v)$ for each pair of users u, v, which requires $O(n^2m)$ time complexity. Therefore, the total time complexity is $O(n^3 + n^2m)$.

III. MAIN IDEAS IN ACHIEVING ALMOST EXACT RECOVERY

In this section, we establish Theorem 1 based on three intermediate propositions. We defer the proofs of the intermediate propositions to Appendices A and B. From this point, we assume without loss of generality that the underlying permutation Π^* is the identity permutation.

A. First moment of similarity score

For the similarity score Φ_{ij} to be an appropriate measure of the similarity between two user vertices, we need the expected similarity score between a correct pair $\mathsf{E}[\Phi_{ii}]$ to be larger than that between a wrong pair $\mathsf{E}[\Phi_{ij}]$. The following proposition shows that $\mathsf{E}[\Phi_{ii}] > 0$, while $\mathsf{E}[\Phi_{ij}] = 0$.

Proposition 1 (Expectation of similarity score). For a pair of users $(i, j) \in \mathcal{V}_1^u \times \mathcal{V}_2^u$, the expectation of the similarity score Φ_{ij} is given by

$$\mathsf{E}[\Phi_{ij}] = \binom{m}{k} (\rho_{\mathrm{u}} \sigma_{\mathrm{u}}^2)^k (\rho_{\mathrm{a}} \sigma_{\mathrm{a}}^2)^k \binom{n-1}{k} k! \mathbb{1}_{\{i=j\}}.$$
(14)

Moreover, if $k = \Theta(1)$, then

$$\mathsf{E}[\Phi_{ii}] = \Omega(m^k n^k (\rho_{\rm u} \sigma_{\rm u}^2)^k (\rho_{\rm a} \sigma_{\rm a}^2)^k).$$
(15)

B. Second moment of similarity score

In the proposed algorithm, we separate almost all the correct pairs of matching from the wrong pairs by setting a threshold on the similarity score. For this algorithm to achieve almost exact recovery, requiring only that the correct pairs have a higher expected similarity score is not enough. We further need that the second moment of the similarity score is small enough, so that the similarity scores concentrate well around their means. In the following two propositions, we provide upper bounds on the similarity score between correct pairs and between wrong pairs, respectively.

Proposition 2. Suppose graph parameters $n, m, q_u, q_a, \rho_u, \rho_a$ satisfy conditions $nq_u\rho_u = \omega(1), n\rho_u^2 = \omega(1), mq_a\rho_a = \omega\left(\frac{1}{n\rho_u^2}\right), mq_a\rho_a = \omega\left(\frac{1}{n\rho_u^2}\right)$ and $m\rho_a^2\rho_u^2 = \omega(1)$. Assume parameter k in Algorithm 1 is set to a constant. Then for any $i \in [n]$, we have $\frac{Var(\Phi_{ii})}{E[\Phi_{ii}]^2} = o(1)$.

Proposition 3. Suppose graph parameters $n, m, q_u, q_a, \rho_u, \rho_a$ satisfy conditions $n\rho_u^2 = \omega(n^{2/k}), n^2q_u = \Omega(1), mq_a\rho_a = \omega\left(\frac{n^{2/k}}{n\rho_u^2}\right)$ and $m\rho_a^2\rho_u^2 = \omega(n^{2/k})$. Assume parameter k in Algorithm 1 is set to a constant. Then for any $(i, j) \in [n] \times [n]$ with $i \neq j$, we have $\frac{\operatorname{Var}(\Phi_{ij})}{\mathsf{E}[\Phi_{ii}]^2} = o(1/n^2)$.

We comment that the conditions presented in Propositions 2 and 3 are not only sufficient, but also necessary for establishing the variance bounds for the similarity score. We discuss more details about the tightness of these conditions in Appendix E.

C. Proof of Theorem 1

Given Propositions 1-3, we are ready to prove Theorem 1. It is easy to check that all conditions in Propositions 2 and 3 are satisfied under conditions (1)-(4). To prove Theorem 1, we define error event $\mathcal{E}_1 \triangleq \{\exists (i, j) \in [n] \times [n] : i \neq j, \Phi_{ij} \geq \tau\}$. Moreover, let $X \triangleq |\{i \in [n] : \Phi_{ii} < \tau\}|$. We define error event $\mathcal{E}_2 \triangleq \{X \geq \lambda n\}$ for some $\lambda = o(1)$, which will be specified later. We claim that it suffices to show $\mathsf{P}(\mathcal{E}_1 \cup \mathcal{E}_2) = o(1)$. To see this, we observe that \mathcal{E}_1^c represents the event that all wrong pairs have similarity score less than the threshold, which implies that $\hat{\Pi}(i) = \Pi^*(i), \forall i \in I$. On event $\mathcal{E}_1^c, \mathcal{E}_2^c$ implies the event that $|I| \geq n - o(n)$.

Firstly, we show that $P(\mathcal{E}_1) = o(1)$. For a wrong pair $(i, j) \in [n] \times [n]$ with $i \neq j$, we have

$$\mathsf{P}(\Phi_{ij} \ge \tau) \stackrel{(a)}{=} \mathsf{P}(\Phi_{ij} - \mathsf{E}[\Phi_{ij}] \ge c\mathsf{E}[\Phi_{ii}]) \stackrel{(b)}{\le} \frac{\operatorname{Var}(\Phi_{ij})}{c^2 \mathsf{E}[\Phi_{ii}]^2} \stackrel{(c)}{=} o(1/n^2),$$

where (a) follows because $\tau = c \mathsf{E}[\Phi_{ii}]$ from Proposition 1, (b) follows by Chebyshev's inequality and (c) follows by Proposition 3. Applying a union bound over the $n^2 - n$ wrong pairs of users yields that $\mathsf{P}(\mathcal{E}_1) = o(1)$.

Secondly, let $\lambda = \sqrt{\mathsf{P}(\Phi_{ii} < \tau)}$. We show that $\mathsf{P}(\mathcal{E}_2) = o(1)$ in the following. For the similarity score Φ_{ii} for a correct pair, we have

$$\mathsf{P}(\Phi_{ii} < \tau) \stackrel{(d)}{=} \mathsf{P}(\Phi_{ii} - \mathsf{E}[\Phi_{ii}] \le (c-1)\mathsf{E}[\Phi_{ii}]) \stackrel{(e)}{\le} \frac{\operatorname{Var}(\Phi_{ii})}{(c-1)^2 \mathsf{E}[\Phi_{ii}]^2} \stackrel{(f)}{=} o(1), \tag{16}$$

where (d) follows by Proposition 1, (e) follows by Chebyshev's inequality and (f) follows by Proposition 2. From (16), we have $\lambda = o(1)$. By the linearity of expectation, we know that $\mathsf{E}[X] = n\mathsf{P}(\Phi_{ii} < \tau)$. By Markov's inequality, it follows that

$$\mathsf{P}(X \ge \lambda n) \le \frac{\mathsf{E}[X]}{\lambda n} = \sqrt{\mathsf{P}(\Phi_{ii} < \tau)} = o(1).$$

Finally, applying a union bound over \mathcal{E}_1 and \mathcal{E}_2 completes the proof.

Appendix A

FIRST MOMENT COMPUTATION

In this Section, we prove Proposition 1 by computing the expectation of similarity score Φ_{ij} for correct pairs and wrong pairs.

Proof of Proposition 1.. By the definition of Φ_{ij} given in (13), we have

$$\stackrel{(a)}{=} E\left[\sum_{\mathcal{A}\subseteq\mathcal{V}^{u}:|\mathcal{A}|=k} \sum_{S\in\mathcal{G}_{i,\mathcal{A}}} \omega_1(S) \sum_{T\in\mathcal{G}_{j,\mathcal{A}}} \omega_2(T)\right]$$

$$\stackrel{(b)}{=} \sum_{\mathcal{A}\subseteq\mathcal{V}^{u}:|\mathcal{A}|=k} \sum_{S\in\mathcal{G}_{i,\mathcal{A}}} \sum_{T\in\mathcal{G}_{j,\mathcal{A}}} E[\omega_1(S)\omega_2(T)],$$
(17)

٦

where (a) follows because by definitions (11) and (12), and (b) follows by the linearity of expectation. Now we focus on one term in the summation $E[\omega_1(S)\omega_2(T)]$. We claim that a necessary condition for $E[\omega_1(S)\omega_2(T)]$ to be non-zero is that S = T. Towards contradiction, suppose $S \neq T$, i.e., there exists an edge $e^* \in E(S)$, but $e^* \notin E(T)$, or $e^* \in E(T)$, but $e^* \notin E(S)$. Without loss of generality, we only consider the case of $e^* \in E(S)$, but $e^* \notin E(T)$. We firstly assume that $e^* \in \mathcal{E}^u(S)$. By definitions (8) and (9), we have

$$\mathsf{E}[\omega_{1}(S)\omega_{2}(T)] = \mathsf{E} \left[\prod_{e \in \mathcal{E}^{\mathrm{u}}(S)} \tilde{A}_{e}^{\mathrm{u}} \prod_{f \in \mathcal{E}^{\mathrm{a}}(S)} \tilde{A}_{f}^{\mathrm{a}} \prod_{g \in \mathcal{E}^{\mathrm{u}}(T)} \tilde{B}_{g}^{\mathrm{u}} \prod_{h \in \mathcal{E}^{\mathrm{a}}(T)} \tilde{B}_{h}^{\mathrm{a}} \right]$$
$$\stackrel{(c)}{=} \mathsf{E}[\tilde{A}_{e^{*}}^{\mathrm{u}}]\mathsf{E} \left[\prod_{e \in \mathcal{E}^{\mathrm{u}}(S) \setminus \{e^{*}\}} \tilde{A}_{e}^{\mathrm{u}} \prod_{f \in \mathcal{E}^{\mathrm{a}}(S)} \tilde{A}_{f}^{\mathrm{a}} \prod_{g \in \mathcal{E}^{\mathrm{u}}(T)} \tilde{B}_{g}^{\mathrm{u}} \prod_{h \in \mathcal{E}^{\mathrm{a}}(T)} \tilde{B}_{h}^{\mathrm{a}} \right]$$
$$\stackrel{(d)}{=} 0,$$
(18)

where (c) follows because e^* only appears in S, so $\tilde{A}_{e^*}^{u}$ in independent of the rest of the terms in the product, and (d) follows because each single term in adjacency matrix \tilde{A}^u has zero mean. Similarly, if $e^* \in \mathcal{E}^a(S)$, we still have $\mathsf{E}[\omega_1(S)\omega_2(T)] = 0$. Therefore, the claim holds. The claim further implies that $\mathsf{E}[\Phi_{ij}] = 0$ for any pair $i \neq j$. To see this, we notice that $\mathcal{G}_{i,\mathcal{A}} \cap \mathcal{G}_{j,\mathcal{A}} = \emptyset$ if $i \neq j$, and it follows that each term in the summation (17) equals to zero.

Now, we can rewrite the summation (17) as

$$\sum_{\mathcal{A}\subseteq\mathcal{V}^{\mathrm{u}}:|\mathcal{A}|=k}\sum_{S\in\mathcal{G}_{i,\mathcal{A}}}\sum_{T\in\mathcal{G}_{j,\mathcal{A}}}\mathsf{E}[\omega_1(S)\omega_2(T)] = \mathbb{1}_{\{i=j\}}\sum_{\mathcal{A}\subseteq\mathcal{V}^{\mathrm{u}}:|\mathcal{A}|=k}\sum_{S\in\mathcal{G}_{i,\mathcal{A}}}\mathsf{E}[\omega_1(S)\omega_2(S)].$$
(19)

By symmetry, we notice that for any $|\mathcal{A}| = k$ and any $S \in \mathcal{G}_{i,\mathcal{A}}$, the term $\omega_1(S)\omega_2(S)$ has exactly the same distribution. Therefore, we fix a set \mathcal{A} and a graph $S \in \mathcal{G}_{i,\mathcal{A}}$, and consider the expectation $\mathsf{E}[\omega_1(S)\omega_2(S)]$:

$$E[\omega_{1}(S)\omega_{2}(S)] = E\left[\prod_{e\in\mathcal{E}^{u}(S)} \tilde{A}_{e}^{u}\tilde{B}_{e}^{u}\prod_{f\in\mathcal{E}^{a}(S)} \tilde{A}_{f}^{a}\tilde{B}_{f}^{a}\right]$$
$$\stackrel{(e)}{=}\prod_{e\in\mathcal{E}^{u}(S)} E[\tilde{A}_{e}^{u}\tilde{B}_{e}^{u}]\prod_{f\in\mathcal{E}^{a}(S)} E[\tilde{A}_{f}^{a}\tilde{B}_{f}^{a}]$$
$$\stackrel{(f)}{=}(\sigma_{u}^{2}\rho_{u})^{k}(\sigma_{a}^{2}\rho_{a})^{k},$$
(20)

where (e) follows by the independence of the terms in the product and (f) follows because for each $e \in \mathcal{E}^{u}(S)$,

$$\mathsf{E}[\tilde{A}_e^{\mathrm{u}}\tilde{B}_e^{\mathrm{u}}] = \mathrm{Cov}(\tilde{A}_e^{\mathrm{u}}, \tilde{B}_e^{\mathrm{u}}) + \mathsf{E}[\tilde{A}_e^{\mathrm{u}}]\mathsf{E}[\tilde{B}_e^{\mathrm{u}}] = \sigma_{\mathrm{u}}^2\rho_{\mathrm{u}}$$

and for each $f \in \mathcal{E}^{\mathbf{a}}(S)$,

$$\mathsf{E}[\tilde{A}_{f}^{\mathrm{a}}\tilde{B}_{f}^{\mathrm{a}}] = \mathrm{Cov}(\tilde{A}_{f}^{\mathrm{a}},\tilde{B}_{f}^{\mathrm{a}}) + \mathsf{E}[\tilde{A}_{f}^{\mathrm{a}}]\mathsf{E}[\tilde{B}_{f}^{\mathrm{a}}] = \sigma_{\mathrm{a}}^{2}\rho_{\mathrm{a}}$$

Finally, plugging (20) into (19) yields

$$\mathsf{E}[\Phi_{ij}] = \mathbb{1}_{\{i=j\}} \sum_{\mathcal{A} \subseteq \mathcal{V}^{\mathrm{u}}: |\mathcal{A}| = k} \sum_{S \in \mathcal{G}_{i,\mathcal{A}}} (\sigma_{\mathrm{u}}^{2} \rho_{\mathrm{u}})^{k} (\sigma_{\mathrm{a}}^{2} \rho_{\mathrm{a}})^{k}$$

$$\stackrel{(g)}{=} \binom{m}{k} \binom{n-1}{k} k! (\sigma_{\mathrm{u}}^{2} \rho_{\mathrm{u}})^{k} (\sigma_{\mathrm{a}}^{2} \rho_{\mathrm{a}})^{k} \mathbb{1}_{\{i=j\}}, \qquad (21)$$

where (g) follows because there are $\binom{m}{k}$ attribute subsets of size k and for each $|\mathcal{A}| = k$, $|\mathcal{G}_{i,\mathcal{A}}| = \binom{n-1}{k}k!$ as given in (10).

To see (15), we simply need to notice that $\binom{m}{k} = \Omega(m^k)$ and $\binom{n-1}{k}k! = \Omega(n^k)$ when $k = \Theta(1)$.

APPENDIX B

SECOND MOMENT COMPUTATION

In this section, we prove Propositions 2 and 3, which provide upper bounds on the variances of correct user pairs and wrong user pairs respectively. Towards that goal, we first perform some preprocessing on the the variance expression of the similarity score. By definitions (11)- (13), we have

$$= \operatorname{Var}\left(\sum_{\mathcal{A}\subseteq\mathcal{V}^{a}:|\mathcal{A}|=k} \sum_{S_{1}\in\mathcal{G}_{i,\mathcal{A}}} \sum_{S_{2}\in\mathcal{G}_{i,\mathcal{A}}} \omega_{1}(S_{1})\omega_{2}(S_{2})\right)$$
$$= \sum_{\mathcal{A},\mathcal{B}\subseteq\mathcal{V}^{a}:|\mathcal{A}|=|\mathcal{B}|=k} \sum_{S_{1}\in\mathcal{G}_{i,\mathcal{A}}} \sum_{S_{2}\in\mathcal{G}_{i,\mathcal{A}}} \sum_{T_{1}\in\mathcal{G}_{i,\mathcal{B}}} \sum_{T_{2}\in\mathcal{G}_{i,\mathcal{B}}} \operatorname{Cov}(\omega_{1}(S_{1})\omega_{2}(S_{2}),\omega_{1}(T_{1})\omega_{2}(T_{2})).$$
(22)

Now, we focus on one single term $\operatorname{Cov}(\omega_1(S_1)\omega_2(S_2), \omega_1(T_1)\omega_2(T_2))$ in the summation. Define the indicator $f_1(S_1, S_2, T_1, T_2) \triangleq \mathbb{1}_{\{S_1 \neq S_2 \text{ or } T_1 \neq T_2 \text{ or } V(S_1) \cap V(T_1) = \{i\}\}}$. We claim that

$$Cov(\omega_1(S_1)\omega_2(S_2), \omega_1(T_1)\omega_2(T_2)) = Cov(\omega_1(S_1)\omega_2(S_2), \omega_1(T_1)\omega_2(T_2))f_1(S_1, S_2, T_1, T_2).$$
(23)

To see the claim, we observe that if $f_1(S_1, S_2, T_1, T_2) = 0$, then we have $S_1 = S_2$, $S_2 = T_2$ and $V(S_1) \cap V(T_1) = \{i\}$, which together imply that $(E(S_1) \cup E(S_2)) \cap (E(T_1) \cup E(T_2)) = \emptyset$. So $\omega_1(S_1)\omega_2(S_2)$ and $\omega_1(T_1)\omega_2(T_2)$ are two independent random variables with zero covariance. For simplicity, we write f_1 instead of $f_1(S_1, S_2, T_1, T_2)$ when the choice of S_1, S_2, T_1, T_2 is clear from context.

Furthermore, we notice that by the definition of covariance, we have

$$Cov(\omega_{1}(S_{1})\omega_{2}(S_{2}),\omega_{1}(T_{1})\omega_{2}(T_{2})) = \mathsf{E}[\omega_{1}(S_{1})\omega_{2}(S_{2})\omega_{1}(T_{1})\omega_{2}(T_{2})] - \mathsf{E}[\omega_{1}(S_{1})\omega_{2}(S_{2})]\mathsf{E}[\omega_{1}(T_{1})\omega_{2}(T_{2})]$$

$$\stackrel{(a)}{\leq} \mathsf{E}[\omega_{1}(S_{1})\omega_{2}(S_{2})\omega_{1}(T_{1})\omega_{2}(T_{2})],$$

where (a) follows by equations (18) and (20).

Now, we focus on the cross moment $E[\omega_1(S_1)\omega_2(S_2)\omega_1(T_1)\omega_2(T_2)]$. We define indicator $f_2(S_1, S_2, T_1, T_2) \triangleq \mathbb{1}_{\{(E(S_1) \triangle E(T_1)) \subseteq (E(S_2) \cup E(T_2)) \text{ and } (E(S_2) \triangle E(T_2)) \subseteq (E(S_1) \cup E(T_1))\}}$, where \triangle denotes the symmetric difference operation. In other words, $f_2(S_1, S_2, T_1, T_2)$ is the indicator that every edge in the union graph of $S_1 \cup S_2 \cup T_1 \cup T_2$ appears in at least two graphs out of S_1, S_2, T_1, T_2 . We claim that

$$\mathsf{E}[\omega_1(S_1)\omega_2(S_2)\omega_1(T_1)\omega_2(T_2)] = \mathsf{E}[\omega_1(S_1)\omega_2(S_2)\omega_1(T_1)\omega_2(T_2)]f_2(S_1, S_2, T_1, T_2).$$
(24)

The reason for the claim is similar to the reason for (18) in the proof of Proposition 1. Suppose there exists an edge e^* that only appears in one of the four graphs S_1, S_2, T_1, T_2 , then the entry corresponding to e^* in the adjacency matrix is independent of all other terms in the product $\omega_1(S_1)\omega_2(S_2)\omega_1(T_1)\omega_2(T_2)$. Therefore, the expectation of

the entry, which is zero, can be pulled out of the expectation of the product, and result in a zero expectation of the product. For simplicity, we write f_2 instead of $f_2(S_1, S_2, T_1, T_2)$ when the choice of S_1, S_2, T_1, T_2 is clear from context.

By claims (23) and (24), we have

$$\operatorname{Cov}(\omega_1(S_1)\omega_2(S_2),\omega_1(T_1)\omega_2(T_2)) \le \mathsf{E}[\omega_1(S_1)\omega_2(S_2)\omega_1(T_1)\omega_2(T_2)]f_1f_2.$$
(25)

Plugging (25) into (22) gives

$$\operatorname{Var}(\Phi_{ij}) \leq \sum_{\mathcal{A}, \mathcal{B} \subseteq \mathcal{V}^{\mathrm{a}}: |\mathcal{A}| = |\mathcal{B}| = k} \sum_{S_1 \in \mathcal{G}_{i,\mathcal{A}}} \sum_{S_2 \in \mathcal{G}_{i,\mathcal{A}}} \sum_{T_1 \in \mathcal{G}_{i,\mathcal{B}}} \sum_{T_2 \in \mathcal{G}_{i,\mathcal{B}}} \mathsf{E}[\omega_1(S_1)\omega_2(S_2)\omega_1(T_1)\omega_2(T_2)]f_1f_2.$$
(26)

To simplify (26), we define Λ_{ij} as the set of all 4-tuples (S_1, S_2, T_1, T_2) such that

1) $S_1 \in \mathcal{G}_{i,\mathcal{A}}, S_2 \in \mathcal{G}_{j,\mathcal{A}}, T_1 \in \mathcal{G}_{i,\mathcal{B}}, T_2 \in \mathcal{G}_{j,\mathcal{B}}$, for some $\mathcal{A}, \mathcal{B} \subseteq \mathcal{V}^a$ with $|\mathcal{A}| = |\mathcal{B}| = k$;

- 2) $f_1(S_1, S_2, T_1, T_2) = 1;$
- 3) $f_2(S_1, S_2, T_1, T_2) = 1.$

As a result of this definition, we have

$$\operatorname{Var}(\Phi_{ij}) \le \sum_{(S_1, S_2, T_1, T_2) \in \Lambda_{ij}} \mathsf{E}[\omega_1(S_1)\omega_2(S_2)\omega_1(T_1)\omega_2(T_2)].$$
(27)

To bound the variance, we enumerate all those 4-tuples $(S_1, S_2, T_1, T_2) \in \Lambda_{ij}$ and bound their corresponding cross moment $\mathsf{E}[\omega_1(S_1)\omega_2(S_2)\omega_1(T_1)\omega_2(T_2)]$. For a fixed 4-tuple (S_1, S_2, T_1, T_2) , let H denote the union graph $S_1 \cup S_2 \cup T_1 \cup T_2$. Consider the user-user edges and user-attribute edges separately. Firstly, we partition the set of user-user edges in H into six disjoint subsets:

where

$$\begin{split} K_{11}^{\mathrm{u}} &\triangleq (\mathcal{E}^{\mathrm{u}}(S_1) \triangle \mathcal{E}^{\mathrm{u}}(T_1)) \cap (\mathcal{E}^{\mathrm{u}}(S_2) \triangle \mathcal{E}^{\mathrm{u}}(T_2)), \\ K_{21}^{\mathrm{u}} &\triangleq (\mathcal{E}^{\mathrm{u}}(S_1) \cap \mathcal{E}^{\mathrm{u}}(T_1)) \cap (\mathcal{E}^{\mathrm{u}}(S_2) \triangle \mathcal{E}^{\mathrm{u}}(T_2)), \\ K_{12}^{\mathrm{u}} &\triangleq (\mathcal{E}^{\mathrm{u}}(S_1) \triangle \mathcal{E}^{\mathrm{u}}(T_1)) \cap (\mathcal{E}^{\mathrm{u}}(S_2) \cap \mathcal{E}^{\mathrm{u}}(T_2)), \\ K_{22}^{\mathrm{u}} &\triangleq (\mathcal{E}^{\mathrm{u}}(S_1) \cap \mathcal{E}^{\mathrm{u}}(T_1)) \cap (\mathcal{E}^{\mathrm{u}}(S_2) \cap \mathcal{E}^{\mathrm{u}}(T_2)), \\ K_{02}^{\mathrm{u}} &\triangleq (\mathcal{E}^{\mathrm{u}}(S_1) \cup \mathcal{E}^{\mathrm{u}}(T_1))^c \cap (\mathcal{E}^{\mathrm{u}}(S_2) \cap \mathcal{E}^{\mathrm{u}}(T_2)), \\ K_{20}^{\mathrm{u}} &\triangleq (\mathcal{E}^{\mathrm{u}}(S_1) \cap \mathcal{E}^{\mathrm{u}}(T_1)) \cap (\mathcal{E}^{\mathrm{u}}(S_2) \cup \mathcal{E}^{\mathrm{u}}(T_2))^c. \end{split}$$

We notice that the sets $K_{11}^{\rm u}, K_{21}^{\rm u}, K_{12}^{\rm u}, K_{22}^{\rm u}, K_{20}^{\rm u}$, $K_{20}^{\rm u}$ are indeed disjoint by their definition, and they include all the user-user edges in H because each edge in H appears in at least two out of S_1, S_2, T_1, T_2 . Moreover, note that in the product $\omega_1(S_1)\omega_2(S_2)\omega_1(T_1)\omega_2(T_2)$, we are considering the weights of S_1 and T_1 in G_1 and the weights of S_2 and T_2 in G'_2 . As a result, for an edge $e \in K_{m_1,m_2}^{\rm u}$, its contribution to the product $\omega_1(S_1)\omega_2(S_2)\omega_1(T_1)\omega_2(T_2)$ is given by $(\tilde{A}_e^{\rm u})^{m_1}(\tilde{B}_e^{\rm u})^{m_2}$.

For the user-attribute edges in H, similarly, we partition it into six disjoint sets:

$$\mathcal{E}^{\mathbf{a}}(H) = K_{11}^{\mathbf{a}} \cup K_{21}^{\mathbf{a}} \cup K_{12}^{\mathbf{a}} \cup K_{22}^{\mathbf{a}} \cup K_{02}^{\mathbf{a}} \cup K_{20}^{\mathbf{a}},\tag{29}$$

where

$$\begin{split} K_{11}^{\mathbf{a}} &\triangleq (\mathcal{E}^{\mathbf{a}}(S_1) \triangle \mathcal{E}^{\mathbf{a}}(T_1)) \cap (\mathcal{E}^{\mathbf{a}}(S_2) \triangle \mathcal{E}^{\mathbf{a}}(T_2)), \\ K_{21}^{\mathbf{a}} &\triangleq (\mathcal{E}^{\mathbf{a}}(S_1) \cap \mathcal{E}^{\mathbf{a}}(T_1)) \cap (\mathcal{E}^{\mathbf{a}}(S_2) \triangle \mathcal{E}^{\mathbf{a}}(T_2)), \\ K_{12}^{\mathbf{a}} &\triangleq (\mathcal{E}^{\mathbf{a}}(S_1) \triangle \mathcal{E}^{\mathbf{a}}(T_1)) \cap (\mathcal{E}^{\mathbf{a}}(S_2) \cap \mathcal{E}^{\mathbf{a}}(T_2)), \\ K_{22}^{\mathbf{a}} &\triangleq (\mathcal{E}^{\mathbf{a}}(S_1) \cap \mathcal{E}^{\mathbf{a}}(T_1)) \cap (\mathcal{E}^{\mathbf{a}}(S_2) \cap \mathcal{E}^{\mathbf{a}}(T_2)), \\ K_{02}^{\mathbf{a}} &\triangleq (\mathcal{E}^{\mathbf{a}}(S_1) \cup \mathcal{E}^{\mathbf{a}}(T_1))^c \cap (\mathcal{E}^{\mathbf{a}}(S_2) \cap \mathcal{E}^{\mathbf{a}}(T_2)), \\ K_{20}^{\mathbf{a}} &\triangleq (\mathcal{E}^{\mathbf{a}}(S_1) \cap \mathcal{E}^{\mathbf{a}}(T_1)) \cap (\mathcal{E}^{\mathbf{a}}(S_2) \cup \mathcal{E}^{\mathbf{a}}(T_2))^c. \end{split}$$

For the similar reason as the user-user edges, for an edge $e \in K_{m_1,m_2}^{a}$ its contribution to the product $\omega_1(S_1)\omega_2(S_2)\omega_1(T_1)\omega_2(T_2)$ is given by $(\tilde{A}_e^{a})^{m_1}(\tilde{B}_e^{a})^{m_2}$. With the partition of the user-user edges and user-attribute edges, we have

$$\begin{split} \mathsf{E}[\omega_{1}(S_{1})\omega_{2}(S_{2})\omega_{1}(T_{1})\omega_{2}(T_{2})] \\ &= \mathsf{E}\left[\left(\prod_{m_{1},m_{2}}\prod_{e\in K_{m_{1},m_{2}}}(\tilde{A}_{e}^{\mathrm{u}})^{m_{1}}(\tilde{B}_{e}^{\mathrm{u}})^{m_{2}}\right)\left(\prod_{m_{1},m_{2}}\prod_{e\in K_{m_{1},m_{2}}}(\tilde{A}_{e}^{\mathrm{a}})^{m_{1}}(\tilde{B}_{e}^{\mathrm{a}})^{m_{2}}\right)\right) \\ &= \left(\prod_{m_{1},m_{2}}\prod_{e\in K_{m_{1},m_{2}}}\mathsf{E}[(\tilde{A}_{e}^{\mathrm{u}})^{m_{1}}(\tilde{B}_{e}^{\mathrm{u}})^{m_{2}}]\right)\left(\prod_{m_{1},m_{2}}\prod_{e\in K_{m_{1},m_{2}}}\mathsf{E}[(\tilde{A}_{e}^{\mathrm{a}})^{m_{1}}(\tilde{B}_{e}^{\mathrm{a}})^{m_{2}}]\right) \\ &= \left(\prod_{m_{1},m_{2}}\left(\mathsf{E}[(\tilde{A}_{e}^{\mathrm{u}})^{m_{1}}(\tilde{B}_{e}^{\mathrm{u}})^{m_{2}}]\right)^{|K_{m_{1},m_{2}}^{\mathrm{u}}|\right)\left(\prod_{m_{1},m_{2}}\left(\mathsf{E}[(\tilde{A}_{e}^{\mathrm{a}})^{m_{1}}(\tilde{B}_{e}^{\mathrm{a}})^{m_{2}}]\right)^{|K_{m_{1},m_{2}}^{\mathrm{u}}|\right) \end{split}$$
(30)

Now, we need to consider the cross moments $\mathsf{E}[(\tilde{A}_e^{\mathrm{u}})^{m_1}(\tilde{B}_e^{\mathrm{u}})^{m_2}]$ and $\mathsf{E}[(\tilde{A}_e^{\mathrm{a}})^{m_1}(\tilde{B}_e^{\mathrm{a}})^{m_2}]$. Recall that $(\tilde{A}_e^{\mathrm{u}}, \tilde{B}_e^{\mathrm{u}})$ is a pair of Bernoulli random variables with correlation coefficient ρ_{u} and marginal probability q_{u} , and $(\tilde{A}_e^{\mathrm{a}}, \tilde{B}_e^{\mathrm{a}})$ is a pair of Bernoulli random variables with correlation coefficient ρ_{a} and marginal probability q_{a} . We bound the cross moments in terms of the graph parameters $q_{\mathrm{u}}, \rho_{\mathrm{u}}, q_{\mathrm{a}}, \rho_{\mathrm{a}}$ in the following lemma.

Lemma 1 (Cross moments upper bound). Suppose $q_u \leq \frac{1}{2}$ and $q_a \leq \frac{1}{2}$, then there exists a constant c such that

$$\sigma_{\mathbf{u}}^{-m_{1}-m_{2}}\mathsf{E}[(\tilde{A}_{e}^{\mathbf{u}})^{m_{1}}(\tilde{B}_{e}^{\mathbf{u}})^{m_{2}}] \leq \begin{cases} \rho_{\mathbf{u}} & \text{if } (m_{1}, m_{2}) = (1, 1), \\ 1 & \text{if } (m_{1}, m_{2}) = (2, 0) \text{ or } (0, 2), \\ \frac{1}{\sqrt{q_{\mathbf{u}}}} & \text{if } (m_{1}, m_{2}) = (2, 1) \text{ or } (1, 2), \\ c \max\{1, \frac{\rho_{\mathbf{u}}}{q_{\mathbf{u}}}\} & \text{if } (m_{1}, m_{2}) = (2, 2), \end{cases}$$
(31)

and

$$\sigma_{\mathbf{a}}^{-m_{1}-m_{2}}\mathsf{E}[(\tilde{A}_{e}^{\mathbf{a}})^{m_{1}}(\tilde{B}_{e}^{\mathbf{a}})^{m_{2}}] \leq \begin{cases} \rho_{\mathbf{a}} & \text{if } (m_{1},m_{2}) = (1,1), \\ 1 & \text{if } (m_{1},m_{2}) = (2,0) \text{ or } (0,2), \\ \frac{1}{\sqrt{q_{\mathbf{a}}}} & \text{if } (m_{1},m_{2}) = (2,1) \text{ or } (1,2), \\ c \max\{1,\frac{\rho_{\mathbf{a}}}{q_{\mathbf{a}}}\} & \text{if } (m_{1},m_{2}) = (2,2). \end{cases}$$
(32)

Remark 7. The first three inequalities of (31) and (32) were originally established by Mao et al. (2022). In Lemma 1, we tighten the bounds specifically for the case of $(m_1, m_2) = (2, 2)$, ensuring that the bounds are tight up to a constant factor for any $\rho_u = O(1)$ and $\rho_a = O(1)$.

Proof of Lemma 1.. We firstly show (31) by separately consider different pairs of (m_1, m_2) .

• Suppose $(m_1, m_2) = (0, 2)$ or (2, 0), then we have

$$\sigma_{\rm u}^{-2} \mathsf{E}[(\tilde{A}_e^{\rm u})^2] = \sigma_{\rm u}^{-2} \mathsf{E}[(\tilde{B}_e^{\rm u})^2] = 1$$

• Suppose $(m_1, m_2) = (1, 1)$, then we have

$$\sigma_{\mathbf{u}}^{-2}\mathsf{E}[\tilde{A}_{e}^{\mathbf{u}}\tilde{B}_{e}^{\mathbf{u}}]=\sigma_{\mathbf{u}}^{-2}\mathrm{Cov}(\tilde{A}_{e}^{\mathbf{u}},\tilde{B}_{e}^{\mathbf{u}})=\rho_{\mathbf{u}}$$

• Suppose $(m_1, m_2) = (1, 2)$ or (2, 1), then we have

$$\sigma_{\mathbf{u}}^{-3}\mathsf{E}[(\tilde{A}_{e}^{\mathbf{u}})^{2}\tilde{B}_{e}^{\mathbf{u}}] = \sigma_{\mathbf{u}}^{-3}\mathsf{E}[\tilde{A}_{e}^{\mathbf{u}}(\tilde{B}_{e}^{\mathbf{u}})^{2}] = \frac{\rho_{\mathbf{u}}(1-2q_{\mathbf{u}})}{\sqrt{q_{\mathbf{u}}(1-q_{\mathbf{u}})}}.$$

Because $q_{\rm u} \leq \frac{1}{2}$, we have $\frac{1-2q_{\rm u}}{\sqrt{q_{\rm u}(1-q_{\rm u})}} \leq \frac{1}{\sqrt{q_{\rm u}}}$. It follows that

$$\frac{\rho_{\mathrm{u}}(1-2q_{\mathrm{u}})}{\sqrt{q_{\mathrm{u}}(1-q_{\mathrm{u}})}} \le \frac{\rho_{\mathrm{u}}}{\sqrt{q_{\mathrm{u}}}} \le \frac{1}{\sqrt{q_{\mathrm{u}}}}$$

• Suppose $(m_1, m_2) = (2, 2)$, then we have

$$\sigma_{\mathbf{u}}^{-4}\mathsf{E}[(\tilde{A}_{e}^{\mathbf{u}})^{2}(\tilde{B}_{e}^{\mathbf{u}})^{2}] = \frac{q_{\mathbf{u}}^{2}(1-q_{\mathbf{u}})^{2} + \rho_{\mathbf{u}}q_{\mathbf{u}}(1-q_{\mathbf{u}})(1-2q_{\mathbf{u}})^{2}}{q_{\mathbf{u}}^{2}(1-q_{\mathbf{u}})^{2}} = 1 + \frac{\rho_{\mathbf{u}}(1-2q_{\mathbf{u}})^{2}}{q_{\mathbf{u}}(1-q_{\mathbf{u}})^{2}}.$$

Because $q_{\rm u} \leq \frac{1}{2}$, we have $\frac{(1-2q_{\rm u})^2}{1-q_{\rm u}} \leq 1$, and it follows that

$$\sigma_{\mathbf{u}}^{-4}\mathsf{E}[(\tilde{A}_{e}^{\mathbf{u}})^{2}(\tilde{B}_{e}^{\mathbf{u}})^{2}] \leq 1 + \frac{\rho_{\mathbf{u}}}{q_{\mathbf{u}}}.$$

To complete the proof of (31), we just need to realize that $1 + \frac{\rho_u}{q_u} = \Theta(\frac{\rho_u}{q_u})$ when $\frac{\rho_u}{q_u} \ge 1$, and $1 + \frac{\rho_u}{q_u} = \Theta(1)$ when $\frac{\rho_u}{q_u} < 1$. The proof of (32) follows similarly as the proof of (31).

Moreover, we note that because edges in K_{m_1,m_2}^u or K_{m_1,m_2}^a appear in $m_1 + m_2$ out of the four graphs S_1, S_2, T_1, T_2 , we have

$$k = 2(K_{11}^{u} + K_{02}^{u} + K_{20}^{u}) + 3(K_{12}^{u} + K_{21}^{u}) + 4(K_{22}^{u}),$$
(33)

and

$$4k = 2(K_{11}^{a} + K_{02}^{a} + K_{20}^{a}) + 3(K_{12}^{a} + K_{21}^{a}) + 4(K_{22}^{a}).$$
(34)

By equations (31)-(34), we can rewrite (30) as

For simplicity of notation, for a 4-tuple $(S_1, S_2, T_1, T_2) \in \Lambda_{ij}$, we define

$$\Theta^{\mathrm{u}}(S_1, S_2, T_1, T_2) \triangleq \rho_{\mathrm{u}}^{|K_{11}^{\mathrm{u}}|} q_{\mathrm{u}}^{-\frac{1}{2}|K_{21}^{\mathrm{u}}| - \frac{1}{2}|K_{12}^{\mathrm{u}}|} c^{|K_{22}^{\mathrm{u}}|} \max\left\{1, \frac{\rho_{\mathrm{u}}^{|K_{22}^{\mathrm{u}}|}}{q_{\mathrm{u}}^{|K_{22}^{\mathrm{u}}|}}\right\},\tag{36}$$

and

$$\Theta^{\mathbf{a}}(S_1, S_2, T_1, T_2) \triangleq \rho_{\mathbf{a}}^{|K_{11}^{\mathbf{a}}|} q_{\mathbf{a}}^{-\frac{1}{2}|K_{21}^{\mathbf{a}}| - \frac{1}{2}|K_{12}^{\mathbf{a}}|} c^{|K_{22}^{\mathbf{a}}|} \max\left\{1, \frac{\rho_{\mathbf{a}}^{|K_{22}^{\mathbf{a}}|}}{q_{\mathbf{a}}^{|K_{22}^{\mathbf{a}}|}}\right\},\tag{37}$$

As a result, the variance expression (27) can be rewritten as

$$\operatorname{Var}(\Phi_{ij}) \leq \sigma_{u}^{4k} \sigma_{a}^{4k} \sum_{(S_{1}, S_{2}, T_{1}, T_{2}) \in \Lambda_{ij}} \Theta^{u}(S_{1}, S_{2}, T_{1}, T_{2}) \Theta^{a}(S_{1}, S_{2}, T_{1}, T_{2}) \triangleq \Gamma_{ij}.$$
(38)

To prove Propositions 2 and 3, we perform a type class enumeration analysis based on the different overlapping patterns of the four graphs S_1, S_2, T_1, T_2 . For each overlapping pattern, we provide a tight-up-to-constant characterization for $\Theta^{u}(S_1, S_2, T_1, T_2)$ and $\Theta^{a}(S_1, S_2, T_1, T_2)$, so that we can provide an upper bound for Γ_{ij} , which is tight up to constant.

A. Proof of Proposition 2

To prove Proposition 2, it suffices to show that $\frac{\Gamma_{ii}}{\mathsf{E}[\Phi_{ii}]^2} = o(1)$. The key idea in this proof is to partition the set of 4-tuples Λ_{ii} into smaller subsets according to the structure of the union graph $H = S_1 \cup S_2 \cup T_1 \cup T_2$. Within each subset, because the union graph structure is fixed, we can manage to tightly bound $\Theta^{u}(S_1, S_2, T_1, T_2)$ and $\Theta^{a}(S_{1}, S_{2}, T_{1}, T_{2})$ and hence provide a tight upper bound for Γ_{ii} . Firstly, we partition Λ_{ii} into k+1 disjoint subsets according to the number of shared attributes:

$$\Lambda_{ii} = \bigcup_{M=0}^{k} \Lambda_{ii}^{(M)},\tag{39}$$

where $\Lambda_{ii}^{(M)} \triangleq \{(S_1, S_2, T_1, T_2) \in \Lambda_{ii} : |\mathcal{V}^{a}(S_1) \cap \mathcal{V}^{a}(T_1)| = M\}$. Recall that $\mathcal{V}^{a}(S_1) = \mathcal{V}^{a}(S_2)$ and $\mathcal{V}^{a}(T_1) = \mathcal{V}^{a}(T_2)$ because $S_1, S_2 \in \mathcal{G}_{i,\mathcal{A}}$ and $T_1, T_2 \in \mathcal{G}_{i,\mathcal{B}}$. Thus, $\Lambda_{ii}^{(M)}$ includes all the 4-tuples such that there are M overlap attributes between \mathcal{A} and \mathcal{B} . By the partition defined, we have

$$\Gamma_{ii} = \sigma_{u}^{4k} \sigma_{a}^{4k} \sum_{M=0}^{k} \sum_{\substack{(S_{1}, S_{2}, T_{1}, T_{2}) \in \Lambda_{ii}^{(M)}}} \Theta^{a}(S_{1}, S_{2}, T_{1}, T_{2}) \Theta^{u}(S_{1}, S_{2}, T_{1}, T_{2})$$

$$\leq (k+1) \sigma_{u}^{4k} \sigma_{a}^{4k} \max_{\substack{0 \le M \le k}} \sum_{\substack{(S_{1}, S_{2}, T_{1}, T_{2}) \in \Lambda_{ii}^{(M)}}} \Theta^{a}(S_{1}, S_{2}, T_{1}, T_{2}) \Theta^{u}(S_{1}, S_{2}, T_{1}, T_{2}).$$
(40)

Because $k = \Theta(1)$, it suffices to show that for each $0 \le M \le k$,

$$\sigma_{\mathbf{u}}^{4k} \sigma_{\mathbf{a}}^{4k} \sum_{(S_1, S_2, T_1, T_2) \in \Lambda_{ii}^{(M)}} \Theta^{\mathbf{a}}(S_1, S_2, T_1, T_2) \Theta^{\mathbf{u}}(S_1, S_2, T_1, T_2) \triangleq \Gamma_{ii}^{(M)} = o(\mathsf{E}[\Phi_{ii}]^2).$$
(41)

To show this, we separately consider the cases of M = 0 and $1 \le M \le k$.

Case 1: M = 0. In this case, the two attribute subsets $\mathcal{V}^{a}(S_1) \cap \mathcal{V}^{a}(T_1) = \emptyset$. It turns out the fact that each edge in the union graph must appear in at least two of S_1, S_2, T_1, T_2 largely restrict the valid choices to the 4-tuple. In the rest of the paper, we call the set of non-root user vertices in an attributed tree as the port vertices of the tree.

Lemma 2. For any $(S_1, S_2, T_1, T_2) \in \Lambda_{ii}^{(0)}$, we have $S_1 = S_2$ and $T_1 = T_2$.

Proof of Lemma 2.. In this proof, we show that $S_1 = S_2$. The proof of $T_1 = T_2$ follows by exactly the same argument. Towards contradiction, we assume that $S_1 \neq S_2$. Recall that $S_1, S_2 \in \mathcal{G}_{i,\mathcal{A}}$ for some $|\mathcal{A}| = k$. We claim that $S_1 \neq S_2$ implies $\mathcal{E}^{a}(S_1) \neq \mathcal{E}^{a}(S_2)$. To see this, we note that if $\mathcal{E}^{a}(S_1) = \mathcal{E}^{a}(S_2)$, then S_1 and S_2 have the same set of port vertices, and it follows that $\mathcal{E}^{u}(S_1) = \mathcal{E}^{u}(S_2)$, which further implies that $S_1 = S_2$. With the claim and the fact that $|\mathcal{E}^{a}(S_1)| = |\mathcal{E}^{a}(S_2)|$, we know that there exists some edge $e^* \in \mathcal{E}^{a}(S_1)$, but $e^* \notin \mathcal{E}^{a}(S_2)$. Let a^* denote the attribute vertex incident to e^* . Because $\mathcal{V}^{a}(S_1) \cap \mathcal{V}^{a}(T_1) = \emptyset$, we have that $a^* \notin \mathcal{V}^{a}(T_1)$. Therefore, it follows that $e^* \notin \mathcal{E}^{a}(T_1)$ and $e^* \notin \mathcal{E}^{a}(T_2)$. This leads to a contradiction because the edge e^* only appears in graph S_1 .

One implication of Lemma 2 is on the user-attribute edges in the union graph H. Consider an attribute $a \in \mathcal{V}^{a}(S_{1})$. We know that a is included in the two graphs S_{1} and S_{2} , and in both graphs there is a single user-attribute edge connected to a. Therefore, in the union graph H, there must be exactly one edge incident to a that is from both S_{1} and S_{2} . By the similar argument, each attribute $a' \in \mathcal{V}^{a}(T_{1})$ is incident to one single edge that is from both T_{1} and T_{2} . This suggests all the user-attribute edges in H are shared by S_{1}, S_{2} or T_{1}, T_{2} , i.e., $K_{11}^{a} = \mathcal{E}^{a}(H)$. Because $|\mathcal{V}^{a}(S_{1})| = |\mathcal{V}^{a}(T_{1})| = k$, we further have $|K_{11}^{a}| = 2k$. Thus, we know that for any $(S_{1}, S_{2}, T_{1}, T_{2}) \in \Lambda_{ii}^{(0)}$, we have

$$\Theta^{a}(S_{1}, S_{2}, T_{1}, T_{2}) = \rho_{a}^{2k}.$$
(42)

Now, we move on to consider the user-user edges in the union graph H. Notice that all the user-user edges in the four graphs S_1, S_2, T_1, T_2 are incident to the root user i. Therefore, in the union graph H, we also only have user-user edges incident to i. Since we have shown in Lemma 2 that $S_1 = S_2$ and $T_1 = T_2$, all the user-user edge in H must be from S_1 and S_2 , or from T_1 and T_2 , or from all four graphs S_1, S_2, T_1, T_2 . Based on this fact, we further separate $\Lambda_{ii}^{(0)}$ into small sets according to the number of user-user edges shared by S_1, S_2, T_1, T_2 . Let

$$\Lambda_{ii}^{(0,\alpha)} \triangleq \{ (S_1, S_2, T_1, T_2) \in \Lambda_{ii}^{(0)} : |\mathcal{E}^{\mathrm{u}}(S_1)| \cap |\mathcal{E}^{\mathrm{u}}(S_2)| \cap |\mathcal{E}^{\mathrm{u}}(T_1)| \cap |\mathcal{E}^{\mathrm{u}}(T_2)| = \alpha \}$$
(43)

denote the set of all $(S_1, S_2, T_1, T_2) \in \Lambda_{ii}^{(0)}$ such that there are α user-user edges in the union graph that are shared by all the four graphs. An example of $(S_1, S_2, T_1, T_2) \in \Lambda_{ii}^{(0,2)}$ is illustrated in Figure 4. We claim that $\Lambda_{ii}^{(0,\alpha)} \neq \emptyset$ only if $1 \leq \alpha \leq k$. The upper bound k is easy to see because S_1, S_2, T_1, T_2 only have 4k user-user vertices in total. To see the lower bound 1, we notice that if $\alpha = 0$, then we are in the case when $S_1 = S_2, T_1 = T_2$, and $V(S_1) \cap V(S_2) = \{i\}$, i.e., $f_1(S_1, S_2, T_1, T_2) = 0$, so $(S_1, S_2, T_1, T_2) \notin \Lambda_{ii}$. As a result, $\Lambda_{ii}^{(0)} = \bigcup_{\alpha=1}^k \Lambda_{ii}^{(0,\alpha)}$.

With the number of edges shared by all four graphs fixed to α for $(S_1, S_2, T_1, T_2) \in \Lambda_{ii}^{(0,\alpha)}$, the structure of the union graph is clear to us. By the fact that $|\mathcal{E}^u(S_1)| = |\mathcal{E}^u(T_1)| = k$, we know that for any $(S_1, S_2, T_1, T_2) \in \Lambda_{ii}^{(0,\alpha)}$,

out of the user-user edges in H, there are $k - \alpha$ edges shared by $S_1, S_2, k - \alpha$ edges shared by T_1, T_2 , and α edges shared by S_1, S_2, T_1, T_2 . This suggests that $|K_{11}^{u}| = 2k - 2\alpha$, $|K_{02}^{u}| = |K_{20}^{u}| = 0$, $|K_{12}^{u}| = |K_{21}^{u}| = 0$ and $|K_{22}^{\rm u}| = \alpha$. Thus, we have Θ

$${}^{\mathrm{u}}(S_1, S_2, T_2, T_2) = \rho_{\mathrm{u}}^{-2k - 2\alpha} c^{\alpha} \max\{1, \frac{\rho_{\mathrm{u}}^{-\alpha}}{q_{\mathrm{u}}^{-\alpha}}\}$$
(44)

By equations Plugging (42) and (44) into (41) yields

$$\Gamma_{ii}^{(0)} = \sigma_{u}^{4k} \sigma_{a}^{4k} \sum_{\alpha=1}^{\kappa} \sum_{\substack{(S_{1}, S_{2}, T_{1}, T_{2}) \in \Lambda_{ii}^{(0,\alpha)}}} \rho_{a}^{2k} \rho_{u}^{2k-2\alpha} c^{\alpha} \max\{1, \frac{\rho_{u}^{\alpha}}{q_{u}^{\alpha}}\}$$
$$= \sigma_{u}^{4k} \sigma_{a}^{4k} \sum_{\alpha=1}^{k} |\Lambda_{ii}^{(0,\alpha)}| \rho_{a}^{2k} \rho_{u}^{2k-2\alpha} c^{\alpha} \max\{1, \frac{\rho_{u}^{\alpha}}{q_{u}^{\alpha}}\}.$$
(45)

Now, we consider the carnality of the set $\Lambda_{ii}^{(0,\alpha)}$. To count the number of 4-tuples (S_1, S_2, T_1, T_2) , it suffices to count the possible union graph H of the four graphs and the belonging of each edge in H to the four graphs S_1, S_2, T_1, T_2 . Note in the union graph H there are k attributes from S_1, S_2 and and k attributes from T_1, T_2 . The way of choosing those two disjoint attribute subset is given by $\binom{m}{k}\binom{m-k}{k}$. For the user vertices in H, recall that there are in $k - \alpha$ edges shared by $S_1, S_2, k - \alpha$ edges shared by T_1, T_2 , and α edges shared by S_1, S_2, T_1, T_2 , and all of them are incident to the root i. Therefore, we have the flexibility to choose α users shared by S_1, S_2, T_1, T_2 , $k-\alpha$ users shared by S_1, S_2 and $k-\alpha$ users shared by T_1, T_2 from n-1 users. The number of choices is given by $\binom{n-1}{\alpha}\binom{n-1-\alpha}{k-\alpha}\binom{n-1-k}{k-\alpha}$. Finally, the number of ways wiring the edges between the 2k attributes and $2k-\alpha$ users is given by $(k!)^2$. This is because each attribute chosen for S_1, S_2 need to connect to one of the k users chosen to be shared by S_1, S_2 or S_1, S_2, T_1, T_2 , and each attribute chosen for T_1, T_2 need to connect to one of the k users chosen to be shared by T_1, T_2 or S_1, S_2, T_1, T_2 . As a result, we have

$$\left|\Lambda_{ii}^{(0,\alpha)}\right| = \binom{m}{k} \binom{m-k}{k} \binom{n-1}{\alpha} \binom{n-1-\alpha}{k-\alpha} \binom{n-1-k}{k-\alpha} (k!)^2.$$

$$(46)$$

Because $k = \Theta(1)$ and $1 \le \alpha \le k$, we have

$$\left|\Lambda_{ii}^{(0,\alpha)}\right| \le Cm^{2k}n^{2k-\alpha},$$

for some constant C. By Proposition 1, we have

$$\begin{aligned} \frac{\Gamma_{ii}^{(0)}}{\mathsf{E}[\Phi_{ii}]^2} &\leq \frac{\sigma_{\mathrm{u}}^{4k} \sigma_{\mathrm{a}}^{4k} \sum_{\alpha=1}^k Cm^{2k} n^{2k-\alpha} \rho_{\mathrm{a}}^{2k} \rho_{\mathrm{u}}^{2k-2\alpha} c^{\alpha} \max\{1, \frac{\rho_{\mathrm{u}}^{\alpha}}{q_{\mathrm{u}}^{\alpha}}\}}{\left(\binom{m}{k}\binom{n-1}{k}k!(\sigma_{\mathrm{u}}^2\rho_{\mathrm{u}})^k(\sigma_{\mathrm{a}}^2\rho_{\mathrm{a}})^k\right)^2} \\ &\leq C' \sum_{\alpha=1}^k \frac{\max\{1, \frac{\rho_{\mathrm{u}}^{\alpha}}{q_{\mathrm{u}}^{\alpha}}\}}{n^{\alpha} \rho_{\mathrm{u}}^{2\alpha}}, \end{aligned}$$

for some constant C', because $k = \Theta(1)$ and $1 \le \alpha \le k$. Finally, to see that $\frac{\Gamma_{ii}^{(0)}}{\mathsf{E}[\Phi_{ii}]^2} = o(1)$, we observe that

$$\frac{\max\{1,\frac{\rho_{\mathrm{u}}^{-}}{q_{\mathrm{u}}^{\alpha}}\}}{n^{\alpha}\rho_{\mathrm{u}}^{2\alpha}} = \frac{1}{\min\{n^{\alpha}\rho_{\mathrm{u}}^{2\alpha},n^{\alpha}\rho_{\mathrm{u}}^{\alpha}q_{\mathrm{u}}^{\alpha}\}}.$$

Because we assume $n\rho_{\rm u}^2=\omega(1)$ and $n\rho_{\rm u}q_{\rm u}=\omega(1),$ it follows that

$$\frac{\Gamma_{ii}^{(0)}}{\mathsf{E}[\Phi_{ii}]^2} \le C' \sum_{\alpha=1}^k \frac{1}{\min\{n^\alpha \rho_{\mathbf{u}}{}^{2\alpha}, n^\alpha \rho_{\mathbf{u}}{}^\alpha q_{\mathbf{u}}{}^\alpha\}} = \frac{C'(1+o(1))}{\min\{n\rho_{\mathbf{u}}{}^2, n\rho_{\mathbf{u}}q_{\mathbf{u}}\}} = o(1),$$

which completes the proof for the case of M = 0.

Case 2: $1 \le M \le k$. In this case, there are some overlaps in the attribute sets of S_1 and T_1 . In the following lemma, we restrict the edge connection configuration of those common attributes of S_1 and T_1 in the union graph H.

Lemma 3. Let $(S_1, S_2, T_1, T_2) \in \Lambda_{ij}^{(M)}$ for some $1 \leq M \leq k$. Let H denote the union graph $S_1 \cup S_2 \cup T_1 \cup T_2$. For any shared attribute $a \in \mathcal{V}^{\mathrm{a}}(S_1) \cap \mathcal{V}^{\mathrm{a}}(T_1)$, exactly one of the following claims holds true:

- 1) a is incident to two edges in H. Moreover, one of the edges is shared by S_1, S_2 and the other one is shared by T_1, T_2 ;
- 2) a is incident to two edges in H. Moreover, one of the edges is shared by S_1, T_1 and the other one is shared by S_2, T_2 ;
- 3) a is incident to two edges in H. Moreover, one of the edges is shared by S_1, T_2 and the other one is shared by S_2, T_1 ;
- 4) a is incident to one edge in H, which is shared by all four graphs S_1, S_2, T_1, T_2 .

Remark 8. Although we state Lemma 3 in the proof of Proposition 2, where we are considering correct pairs (i, i), the lemma actually also applies to the case of (i, j) with $i \neq j$. The lemma will also be used in the proof of Proposition 3.

Proof of Lemma 3.. Consider a shared attributed $a \in \mathcal{V}^{a}(S_{1}) \cap \mathcal{V}^{a}(T_{1})$. We claim that a is incident to one or two edges in H. Notice that in each of $S_{1}, S_{2}, T_{1}, T_{2}$, there exists exactly one edge incident to a. Therefore, there must be at least one edge incident to a in H. Moreover, suppose there are three edge incident to a in H. By the pigeon hole principle, there must be at least one of them that appear in only one graph out of $S_{1}, S_{2}, T_{1}, T_{2}$, which is not allowed. If a is incident to two edges, one of the edges must be shared by all four graphs, which is exactly case 4 in the lemma. If a is incident to two edges, one of the edges must be shared by two graphs out of $S_{1}, S_{2}, T_{1}, T_{2}$ and the other one must be shared by the left two graphs, otherwise there exists an edge in H only appearing in one of $S_{1}, S_{2}, T_{1}, T_{2}$. This would lead to cases 1-3 in the lemma.



Fig. 5: Illustration of the four types of shared attributes in the union graph. In this figure, the red nodes represent the attributes and black nodes represent users. The labels beside the edges represent their belonging to graphs S_1, S_2, T_1, T_2 .

Given Lemma 3, we can partition those shared attributes in H into 4 types as visualized in Figure 5. A shared attribute satisfying *i*th claim in Lemma 3 is called a type-*i* attribute. Given a union graph H, we denote the number of type-*i* attribute in H as $Y_i(H)$. With the 4 types of attributes defined, we further define the set of 4-tuples

$$\Lambda_{ii}^{(M_1,M_2,M_3,M_4)} \triangleq \{ (S_1, S_2, S_3, S_4) \in \Lambda_{ii}^{(M)} : Y_1(H) = M_1, Y_2(H) = M_2, Y_3(H) = M_3, Y_4(H) = M_4 \},$$
(47)

and

$$\Gamma_{ii}^{(M_1,M_2,M_3,M_4)} \triangleq \sigma_{\mathbf{u}}^{4k} \sigma_{\mathbf{a}}^{4k} \sum_{\substack{(S_1,S_2,T_1,T_2) \in \Lambda_{ii}^{(M_1,M_2,M_3,M_4)}}} \Theta^{\mathbf{u}}(S_1,S_2,T_1,T_2) \Theta^{\mathbf{a}}(S_1,S_2,T_1,T_2)$$
(48)

By these definitions, it follows that

(36.36.36.36)

$$\Lambda_{ii}^{(M)} = \bigcup_{M_1 + M_2 + M_3 + M_4 = M} \Lambda_{ii}^{(M_1, M_2, M_3, M_4)},\tag{49}$$

and

$$\Gamma_{ii}^{(M)} = \sum_{M_1 + M_2 + M_3 + M_4 = M} \Gamma_{ii}^{(M_1, M_2, M_3, M_4)}.$$
(50)

To show that $\Gamma_{ii}^{(M)} = o(\mathsf{E}[\Phi_{ii}]^2)$, it suffices to show that

$$\max_{M_1+M_2+M_3+M_4=M} \Gamma_{ii}^{(M_1,M_2,M_3,M_4)} = o(\mathsf{E}[\Phi_{ii}]^2).$$

This is because $M \le k$ is a constant and hence, the number of ways of partitioning M into four integers is also a constant.

Now, consider an arbitrary $1 \le M \le k$, and fix some $M_1 + M_2 + M_3 + M_4 = M$. To bound $\Gamma_{ii}^{(M_1,M_2,M_3,M_4)}$, first consider the user-attribute edges in the union graph H of some $(S_1, S_2, T_1, T_2) \in \Lambda_{ii}^{(M_1,M_2,M_3,M_4)}$. By the definition of the four types of shared attributes, we know that each type-1 attributes is incident to two edges in K_{11}^a , each type-2 attributes is incident to one edge in K_{20}^a and one edge in K_{22}^a . Moreover, apart from the M shared attributes, there are 2k - 2M attributes in $\mathcal{V}^a(S_1) \triangle \mathcal{V}^a(T_1)$. Each of those attributes is incident to exactly one edge in K_{11}^a .

$$|K_{11}^{a}| = (2k - 2M) + 2M_1 + 2M_3 = 2k - 2M_2 - 2M_4,$$
(51)

$$|K_{12}^{\mathbf{a}}| = |K_{21}^{\mathbf{a}}| = 0, (52)$$

and

$$K_{22}^{\rm a}| = M_4. \tag{53}$$

It follows that for any $(S_1, S_2, T_1, T_2) \in \Lambda_{ii}^{(M_1, M_2, M_3, M_4)}$, we have

$$\Theta^{\mathbf{a}}(S_1, S_2, T_1, T_2) = \rho_{\mathbf{a}}^{2k - 2M_2 - 2M_4} c^{M_4} \max\{1, \frac{\rho_{\mathbf{a}}^{M_4}}{q_{\mathbf{a}}^{M_4}}\}.$$
(54)

Next, we move on to bound $\Theta^{u}(S_1, S_2, T_1, T_2)$. Similarity to the case of M = 0, we separately consider the 4-tuples in the set $\Lambda_{ii}^{(M_1,M_2,M_3,M_4)}$ according to the number of user-user edges shared by all 4 graphs:

$$\Lambda_{ii}^{(M_1,M_2,M_3,M_4,\alpha)} \triangleq \{ (S_1, S_2, T_1, T_2) \in \Lambda_{ii}^{(M_1,M_2,M_3,M_4)} : |\mathcal{E}^{\mathrm{u}}(S_1)| \cap |\mathcal{E}^{\mathrm{u}}(S_2)| \cap |\mathcal{E}^{\mathrm{u}}(T_1)| \cap |\mathcal{E}^{\mathrm{u}}(T_2)| = \alpha. \}$$
(55)

We claim that $\Lambda_{ii}^{(M_1,M_2,M_3,M_4,\alpha)} \neq \emptyset$ only if $M_4 \leq \alpha \leq k$. The upper bound $\alpha \leq k$ is easy to see. To see the lower bound $\alpha \geq M_4$. We notice that each type-4 attribute in H is connected to a port vertex that is shared by all four graphs. Therefore, there must be a user-user edge between root i and this port vertex. As a result, we can rewrite $\Gamma_{ii}^{(M_1,M_2,M_3,M_4)}$ as

$$\Gamma_{ii}^{(M_1,M_2,M_3,M_4)} = \sigma_{\mathbf{u}}^{4k} \sigma_{\mathbf{a}}^{4k} \sum_{\alpha=M_4}^k \sum_{\substack{(S_1,S_2,T_1,T_2)\in\Lambda_{ii}^{(M_1,M_2,M_3,M_4,\alpha)}}} \Theta^{\mathbf{u}}(S_1,S_2,T_1,T_2) \Theta^{\mathbf{a}}(S_1,S_2,T_1,T_2) \\ \leq \sigma_{\mathbf{u}}^{4k} \sigma_{\mathbf{a}}^{4k} k \max_{M_4 \leq \alpha \leq k} \sum_{\substack{(S_1,S_2,T_1,T_2)\in\Lambda_{ii}^{(M_1,M_2,M_3,M_4,\alpha)}}} \Theta^{\mathbf{u}}(S_1,S_2,T_1,T_2) \Theta^{\mathbf{a}}(S_1,S_2,T_1,T_2).$$
(56)

Now, it suffice to show that

$$\sigma_{\mathbf{u}}^{4k} \sigma_{\mathbf{a}}^{4k} \max_{M_4 \le \alpha \le k} \sum_{\substack{(S_1, S_2, T_1, T_2) \in \Lambda_{ii}^{(M_1, M_2, M_3, M_4, \alpha)}}} \Theta^{\mathbf{u}}(S_1, S_2, T_1, T_2) \Theta^{\mathbf{a}}(S_1, S_2, T_1, T_2) = o(\mathsf{E}[\Phi_{ii}]^2).$$
(57)

We have already found $\Theta^{a}(S_{1}, S_{2}, T_{1}, T_{2})$ in (54) for any $(S_{1}, S_{2}, T_{1}, T_{2}) \in \Lambda_{ii}^{(M_{1}, M_{2}, M_{3}, M_{4})}$. Now, we focus the user-user part on a 4-tuple $(S_{1}, S_{2}, T_{1}, T_{2}) \in \Lambda_{ii}^{(M_{1}, M_{2}, M_{3}, M_{4}, \alpha)}$. By our definition of $\Lambda_{ii}^{(M_{1}, M_{2}, M_{3}, M_{4}, \alpha)}$, we know that $K_{22}^{u} = \alpha$. Here we show that $|K_{12}^{u}| = |K_{21}^{u}| = 0$ and that $|K_{11}^{u}| \ge 2k - 2\alpha - 2M_{2}$. To see $|K_{12}^{u}| = |K_{21}^{u}| = 0$, towards contradiction, suppose there exists such a user-user edge (i, u^*) . Then u^* is a user shared by three graphs. Thus, in H, u^* must be incident to an user-attribute edges that is shared by three graphs, otherwise it is connected to an edge that only appear in one of S_1, S_2, T_1, T_2 , which is not allowed. However, this leads to a contradiction, because such a user-attribute edge shared by three graphs does not exist by Lemma 3. This shows that $|K_{12}^{u}| =$ $|K_{21}^{\rm u}| = 0$. To see that $|K_{11}^{\rm u}| \ge 2k - 2\alpha - 2M_2$, we notice there are $2k - 2\alpha$ user-user edges shared by two graphs out of S_1, S_2, T_1, T_2 because there are α edges shared by S_1, S_2, T_1, T_2 . Out of these edges shared by two graphs, only edges shared by S_1, T_1 or S_2, T_2 do not belong to K_{11}^{u} . We claim that the number of such edges is upper bounded by $2M_2$. To see the claim, we note that each user-user edge shared by S_1, T_1 or S_2, T_2 is connected between root i and a port vertex shared by S_1, T_1 or S_2, T_2 . In the union graph H, each of these port vertex must be incident to a user-attribute edge that is shared by S_1, T_1 or S_2, T_2 . However, by the definition of our 5 types of attributes in H, there are at most $2M_3$ user-attribute edges shared by S_1, T_1 or S_2, T_2 . This implies that we have at most $2M_3$ user-user edges shared by S_1, T_1 or S_2, T_2 . Now, we have that for any $(S_1, S_2, T_1, T_2) \in \Lambda_{ii}^{(M_1, M_2, M_3, M_4, \alpha)}$

$$\Theta^{u}(S_{1}, S_{2}, T_{1}, T_{2}) \leq \rho_{u}^{2k - 2\alpha - 2M_{2}} c^{\alpha} \max\{1, \frac{\rho_{u}^{\alpha}}{q_{u}\alpha}\}.$$
(58)

Plugging (54) and (58) into the left-hand side of (57) gives

$$\sigma_{\rm u}^{4k} \sigma_{\rm a}^{4k} \max_{M_4 \le \alpha \le k} |\Lambda_{ii}^{(M_1, M_2, M_3, M_4, \alpha)}| \rho_{\rm a}^{2k - 2M_2 - 2M_4} c^{M_4} \max\{1, \frac{\rho_{\rm a}^{M_4}}{q_{\rm a}^{M_4}}\} \rho_{\rm u}^{2k - 2\alpha - 2M_2} c^{\alpha} \max\{1, \frac{\rho_{\rm u}^{\,\alpha}}{q_{\rm u}\alpha}\}.$$
(59)

Now, we want to bound the size of the set $\Lambda_{ii}^{(M_1,M_2,M_3,M_4,\alpha)}$. To count the number of 4-tuples inside, it suffices to count the ways of forming union graphs H and the belonging of each edge in H to S_1, S_2, T_1, T_2 . The way of forming the user-user part of H is upper bounded by

$$\binom{n-1}{\alpha} \binom{n-1-\alpha}{2k-2\alpha} 6^{2k-2\alpha}.$$
(60)

To see this, recall that there are α user-user edges shared by all four graphs and $2k - 2\alpha$ edges shared by two out of S_1, S_2, T_1, T_2 . In (60), $\binom{n-1}{\alpha}$ represents the number of ways to choose α port vertices shared by four graphs and $\binom{n-1-\alpha}{2k-2\alpha}$ represents the number of ways to choose the other $2k - 2\alpha$ port vertices. But because each port vertices shared by two graphs could belong to S_1, S_2 or T_1, T_2 or S_1, T_2 or S_2, T_1 or S_1, T_1 or S_2, T_2 , we have the additional term $6^{2k-2\alpha}$ bounding the total number of configurations.

The way of forming the user-attribute part of H is upper bounded by

$$\binom{m}{M_1}\binom{m}{M_2}\binom{m}{M_3}\binom{m}{M_4}\binom{m}{2k-2M}(2k-\alpha)^{2(2k-M)}.$$
(61)

To see this, we note that $\binom{m}{M_1}\binom{m}{M_2}\binom{m}{M_3}\binom{m}{M_4}\binom{m}{2k-2M}$ upper bounds the way of choosing the five types of attributes from a total of m attribute. The term $(2k-\alpha)^{2(2k-M)}$ upper bounds the ways of wiring between the $2k-\alpha$ ports and $M_1 + M_2 + M_3 + M_4 + 2k - 2M = 2k - M$ attributes.

As a result, we have

$$\begin{aligned} |\Lambda_{ii}^{(M_1,M_2,M_3,M_4,\alpha)}| \\ &\leq \binom{n-1}{\alpha} \binom{n-1-\alpha}{2k-2\alpha} 6^{2k-2\alpha} \binom{m}{M_1} \binom{m}{M_2} \binom{m}{M_3} \binom{m}{M_4} \binom{m}{2k-2M} (2k-\alpha)^{2(2k-M)} \\ &= Cn^{2k-\alpha} m^{2k-M}, \end{aligned}$$
(62)

for some large enough constant C because of the fact that k, α, M are all constants.

Plugging (62) into (59) gives

$$\sigma_{u}^{4k} \sigma_{a}^{4k} \max_{M_{4} \le \alpha \le k} Cn^{2k-\alpha} m^{2k-M} \rho_{a}^{2k-2M_{2}-2M_{4}} c^{M_{4}} \max\{1, \frac{\rho_{a}^{M_{4}}}{q_{a}^{M_{4}}}\} \rho_{u}^{2k-2\alpha-2M_{2}} c^{\alpha} \max\{1, \frac{\rho_{u}^{\alpha}}{q_{u}^{\alpha}}\} \\
= \sigma_{u}^{4k} \sigma_{a}^{4k} Cn^{2k} m^{2k-M} \rho_{a}^{2k-2M_{2}-2M_{4}} c^{M_{4}} \max\{1, \frac{\rho_{a}^{M_{4}}}{q_{a}^{M_{4}}}\} \rho_{u}^{2k-2M_{2}} \\
\cdot \max_{M_{4} \le \alpha \le k} n^{-\alpha} \rho_{u}^{-2\alpha} c^{\alpha} \max\{1, \frac{\rho_{u}^{\alpha}}{q_{u}^{\alpha}}\}$$
(63)

Because it is assumed that $n\rho_{\rm u}q_{\rm u} = \omega(1)$ and $n\rho_{\rm u}^2 = \omega(1)$, the maximum

$$\max_{M_4 \le \alpha \le k} n^{-\alpha} \rho_{\mathrm{u}}^{-2\alpha} c^{\alpha} \max\{1, \frac{\rho_{\mathrm{u}}^{\alpha}}{q_{\mathrm{u}}^{\alpha}}\}$$

is attained at $\alpha = M_4$. Therefore, it suffices to show that

$$\sigma_{\mathbf{u}}^{4k} \sigma_{\mathbf{a}}^{4k} n^{2k-M_4} m^{2k-M} \rho_{\mathbf{a}}^{2k-2M_2-2M_4} \max\{1, \frac{\rho_{\mathbf{a}}^{M_4}}{q_{\mathbf{a}}^{M_4}}\} \rho_{\mathbf{u}}^{2k-2M_2-2M_4} \max\{1, \frac{\rho_{\mathbf{u}}^{M_4}}{q_{\mathbf{u}}^{M_4}}\} = o(\mathsf{E}[\Phi_{ii}]^2), \quad (64)$$

since C, c and M_4 are all constants. Notice that the left-hand side of (64) involves two maximum. We prove (64)

by considering all 4 combinations of the two maximum values. Suppose $\rho_u < q_u$ and $\rho_a < q_a$. Then we have $\max\{1, \frac{\rho_u^{M_4}}{q_u^{M_4}}\} = 1$ and $\max\{1, \frac{\rho_a^{M_4}}{q_a^{M_4}}\} = 1$. Dividing left-hand side of (64) by $E[\Phi_{ii}]^2$ yields

$$\frac{\sigma_{\mathbf{u}}^{4k}\sigma_{\mathbf{a}}^{4k}n^{2k-M_{4}}m^{2k-M}\rho_{\mathbf{a}}^{2k-2M_{2}-2M_{4}}\rho_{\mathbf{u}}^{2k-2M_{2}-2M_{4}}}{\mathsf{E}[\Phi_{ii}]^{2}} = \frac{\sigma_{\mathbf{u}}^{4k}\sigma_{\mathbf{a}}^{4k}n^{2k-M_{4}}m^{2k-M}\rho_{\mathbf{a}}^{2k-2M_{2}-2M_{4}}\rho_{\mathbf{u}}^{2k-2M_{2}-2M_{4}}}{\left(\binom{m}{k}(\rho_{\mathbf{u}}\sigma_{\mathbf{u}}^{2})^{k}(\rho_{\mathbf{a}}\sigma_{\mathbf{a}}^{2})^{k}\binom{n-1}{k}k!\right)^{2}} \le \frac{C'}{m^{M}n^{M_{4}}\rho_{\mathbf{a}}^{2M_{2}+2M_{4}}\rho_{\mathbf{u}}^{2M_{2}+2M_{4}}},$$

for some constant C'. To see (64) in this case, we notice

$$m^{M} n^{M_{4}} \rho_{\mathbf{a}}^{2M_{2}+2M_{4}} \rho_{\mathbf{u}}^{2M_{2}+2M_{4}} \stackrel{(a)}{\geq} m^{M} n^{M_{4}} \rho_{\mathbf{a}}^{2M} \rho_{\mathbf{u}}^{2M}$$
$$= n^{M_{4}} (m \rho_{\mathbf{a}}^{2} \rho_{\mathbf{u}}^{2})^{M}$$
$$\stackrel{(b)}{=} \omega(1),$$

where (a) follows because $M_2 + M_4 \leq M$ and (b) follows by the assumption $m\rho_a^2\rho_u^2 = \omega(1)$ and $M \geq 1$. Suppose $\rho_u \geq q_u$ and $\rho_a \geq q_a$. Then we have $\max\{1, \frac{\rho_u M_4}{q_u M_4}\} = \frac{\rho_u M_4}{q_u M_4}$ and $\max\{1, \frac{\rho_a M_4}{q_a M_4}\} = \frac{\rho_a M_4}{q_a M_4}$. Dividing left-hand side of (64) by $E[\Phi_{ii}]^2$ yields

$$\begin{split} & \frac{\sigma_{\mathbf{u}}^{4k}\sigma_{\mathbf{a}}^{4k}n^{2k-M_{4}}m^{2k-M}\rho_{\mathbf{a}}^{2k-2M_{2}-M_{4}}\rho_{\mathbf{u}}^{2k-2M_{2}-M_{4}}q_{\mathbf{a}}^{-M_{4}}q_{\mathbf{u}}^{-M_{4}}}{\mathsf{E}[\Phi_{ii}]^{2}} \\ &= \frac{\sigma_{\mathbf{u}}^{4k}\sigma_{\mathbf{a}}^{4k}n^{2k-M_{4}}m^{2k-M}\rho_{\mathbf{a}}^{2k-2M_{2}-M_{4}}\rho_{\mathbf{u}}^{2k-2M_{2}-M_{4}}q_{\mathbf{a}}^{-M_{4}}q_{\mathbf{u}}^{-M_{4}}}{\left(\binom{m}{k}(\rho_{\mathbf{u}}\sigma_{\mathbf{u}}^{2})^{k}(\rho_{\mathbf{a}}\sigma_{\mathbf{a}}^{2})^{k}\binom{n-1}{k}k!\right)^{2}} \\ &\leq \frac{C'}{m^{M}n^{M_{4}}\rho_{\mathbf{a}}^{2M_{2}+M_{4}}\rho_{\mathbf{u}}^{2M_{2}+M_{4}}q_{\mathbf{a}}^{M_{4}}q_{\mathbf{u}}^{M_{4}}}, \end{split}$$

for some constant C'. To see (64) in this case, we notice

$$m^{M}n^{M_{4}}\rho_{a}^{2M_{2}+M_{4}}\rho_{u}^{2M_{2}+M_{4}}q_{a}^{M_{4}}q_{u}^{M_{4}} = (mq_{a}\rho_{a}nq_{u}\rho_{u})^{M_{4}}(m\rho_{u}^{2}\rho_{a}^{2})^{M_{2}}m^{M-M_{2}-M_{4}} = \omega(1),$$

where the last equality follows because $mq_a\rho_a nq_u\rho_u = \omega(1)$, $m\rho_u^2\rho_a^2 = \omega(1)$, and at least one of M_2, M_4 and $M - M_2 - M_4$ is strictly positive.

Suppose $\rho_{\rm u} < q_{\rm u}$ and $\rho_{\rm a} \ge q_{\rm a}$. Then we have $\max\{1, \frac{\rho_{\rm u}^{M_4}}{q_{\rm u}^{M_4}}\} = 1$ and $\max\{1, \frac{\rho_{\rm a}^{M_4}}{q_{\rm a}^{M_4}}\} = \frac{\rho_{\rm a}^{M_4}}{q_{\rm a}^{M_4}}$. Dividing left-hand side of (64) by $E[\Phi_{ii}]^2$ yields

$$\begin{split} & \frac{\sigma_{\mathbf{u}}^{4k}\sigma_{\mathbf{a}}^{4k}n^{2k-M_4}m^{2k-M}\rho_{\mathbf{a}}^{2k-2M_2-M_4}\rho_{\mathbf{u}}^{2k-2M_2-2M_4}q_{\mathbf{a}}^{-M_4}}{\mathsf{E}[\Phi_{ii}]^2} \\ &= \frac{\sigma_{\mathbf{u}}^{4k}\sigma_{\mathbf{a}}^{4k}n^{2k-M_4}m^{2k-M}\rho_{\mathbf{a}}^{2k-2M_2-M_4}\rho_{\mathbf{u}}^{2k-2M_2-2M_4}q_{\mathbf{a}}^{-M_4}}{\left(\binom{m}{k}(\rho_{\mathbf{u}}\sigma_{\mathbf{u}}^2)^k(\rho_{\mathbf{a}}\sigma_{\mathbf{a}}^2)^k\binom{n-1}{k}k!\right)^2} \\ &\leq \frac{C'}{m^Mn^{M_4}\rho_{\mathbf{a}}^{2M_2+M_4}\rho_{\mathbf{u}}^{2M_2+2M_4}q_{\mathbf{a}}^{M_4}}, \end{split}$$

for some constant C'. To see (64) in this case, we notice

$$m^{M}n^{M_{4}}\rho_{a}^{2M_{2}+M_{4}}\rho_{u}^{2M_{2}+2M_{4}}q_{a}^{M_{4}} = (n\rho_{u}^{2}mq_{a}\rho_{a})^{M_{4}}(m\rho_{a}^{2}\rho_{u}^{2})^{M_{2}}m^{M-M_{2}-M_{4}} = \omega(1),$$

where the last equality follows because $mq_a\rho_a n\rho_u^2 = \omega(1)$, $m\rho_u^2\rho_a^2 = \omega(1)$, and at least one of M_2, M_4 and $M - M_2 - M_4$ is strictly positive.

Suppose $\rho_u \ge q_u$ and $\rho_a < q_a$. Then we have $\max\{1, \frac{\rho_u M_4}{q_u M_4}\} = \frac{\rho_u M_4}{q_u M_4}$ and $\max\{1, \frac{\rho_a M_4}{q_a M_4}\} = 1$. Dividing left-hand side of (64) by $E[\Phi_{ii}]^2$ yields

$$\begin{split} & \frac{\sigma_{\mathbf{u}}^{4k} \sigma_{\mathbf{a}}^{4k} n^{2k-M_4} m^{2k-M} \rho_{\mathbf{a}}^{2k-2M_2-2M_4} \rho_{\mathbf{u}}^{2k-2M_2-M_4} q_{\mathbf{u}}^{-M_4}}{\mathsf{E}[\Phi_{ii}]^2} \\ &= \frac{\sigma_{\mathbf{u}}^{4k} \sigma_{\mathbf{a}}^{4k} n^{2k-M_4} m^{2k-M} \rho_{\mathbf{a}}^{2k-2M_2-2M_4} \rho_{\mathbf{u}}^{2k-2M_2-M_4} q_{\mathbf{u}}^{-M_4}}{\left(\binom{m}{k} (\rho_{\mathbf{u}} \sigma_{\mathbf{u}}^2)^k (\rho_{\mathbf{a}} \sigma_{\mathbf{a}}^2)^k \binom{n-1}{k} k!\right)^2} \\ &\leq \frac{C'}{m^M n^{M_4} \rho_{\mathbf{a}}^{2M_2+2M_4} \rho_{\mathbf{u}}^{2M_2+M_4} q_{\mathbf{u}}^{M_4}}, \end{split}$$

for some constant C'. To see (64) in this case, we notice

$$m^{M}n^{M_{4}}\rho_{a}^{2M_{2}+2M_{4}}\rho_{u}^{2M_{2}+M_{4}}q_{u}^{M_{4}} = (n\rho_{u}q_{u}m\rho_{a}^{2})^{M_{4}}(m\rho_{a}^{2}\rho_{u}^{2})^{M_{2}}m^{M-M_{2}-M_{4}} = \omega(1),$$

where the last equality follows because $n\rho_u q_u = \omega(1)$, $m\rho_u^2 \rho_a^2 = \omega(1)$, and at least one of M_2 , M_4 and $M - M_2 - M_4$ is strictly positive.

B. Proof of Proposition 3

In this section, we prove Proposition 3 by showing that for any $i \neq j$,

$$\Gamma_{ij} = \sigma_{\mathbf{u}}^{4k} \sigma_{\mathbf{a}}^{4k} \sum_{(S_1, S_2, T_1, T_2) \in \Lambda_{ij}} \rho_{\mathbf{u}}^{|K_{11}^{\mathbf{u}}|} \Theta^{\mathbf{u}}(S_1, S_2, T_1, T_2) \Theta^{\mathbf{a}}(S_1, S_2, T_1, T_2) = o(\mathsf{E}[\Phi_{ij}]^2 n^{-2}).$$
(65)

In this proof, we exploit the property that every edge in the union graph H must appear in at least two subgraphs of S_1, S_2, T_1, T_2 to restrict the structure of union graph. In the following, we provide a lemma capturing a key property of the 4-tuples in Λ_{ij} .

Lemma 4. For any
$$(S_1, S_2, T_1, T_2) \in \Lambda_{ij}$$
, we have $\mathcal{E}^u(S_1) = \mathcal{E}^u(T_1)$ and $\mathcal{E}^u(S_2) = \mathcal{E}^u(T_2)$.

Proof of Lemma 4. Recall that for any 4-tuple $(S_1, S_2, T_1, T_2) \in \Lambda_{ij}$, we have $\mathcal{V}^{\mathbf{a}}(S_1) = \mathcal{V}^{\mathbf{a}}(S_2)$, $\mathcal{V}^{\mathbf{a}}(T_1) = \mathcal{V}^{\mathbf{a}}(T_2)$. Moreover, S_1, T_1 are rooted at *i* and S_2, T_2 are rooted at *j*. In this proof, we argue that $\mathcal{E}^{\mathbf{u}}(S_1) = \mathcal{E}^{\mathbf{u}}(T_1)$. The proof of $\mathcal{E}^{\mathbf{u}}(S_2) = \mathcal{E}^{\mathbf{u}}(T_2)$ would follow by the same argument. Towards contradiction, suppose that $\mathcal{E}^{\mathbf{u}}(S_1) \neq \mathcal{E}^{\mathbf{u}}(T_1)$. Recall that the user-user part of both S_1 and T_1 are *k* user-user edges incident to the root *i*. Thus, it follows that there must exist a user-user edge $(i, u^*) \in \mathcal{E}^{\mathbf{u}}(S_1)$, but $(i, u^*) \notin \mathcal{E}^{\mathbf{u}}(T_1)$, and also another user-user edge $(i, v^*) \in \mathcal{E}^{\mathbf{u}}(T_1)$, but $(i, v^*) \notin \mathcal{E}^{\mathbf{u}}(S_1)$. We observe that $u^* \neq v^*$, and hence, at least one of the following holds true:

- 1) $u^* \neq j;$
- 2) $v^* \neq j$.

We assume without loss of generality that $u^* \neq j$ holds true. This would imply that $(i, u^*) \notin \mathcal{E}^{\mathrm{u}}(S_2)$ and $(i, u^*) \notin \mathcal{E}^{\mathrm{u}}(T_2)$ because all the user-user edges in S_2 and T_2 are incident to their root j. This leads to a contradiction because we then have edge (i, u^*) appear only in the graph S_1 .

To prove (65), we separately consider two subcases of Λ_{ij} . We define:

$$\bar{\Lambda}_{ij} \triangleq \{ (S_1, S_2, T_1, T_2) \in \Lambda_{ij} : (i, j) \notin \mathcal{E}^{\mathrm{u}}(H) \},$$
(66)

$$\tilde{\Lambda}_{ij} \triangleq \{ (S_1, S_2, T_1, T_2) \in \Lambda_{ij} : (i, j) \in \mathcal{E}^{\mathrm{u}}(H) \}.$$
(67)

In other words, $\bar{\Lambda}_{ij}$ includes the cases when the edge (i, j) is excluded from the union graph H, while $\bar{\Lambda}_{ij}$ includes the cases when the edge (i, j) is included in the union graph H. Following the above definitions, we further define

$$\bar{\Gamma}_{ij} \triangleq \sigma_{u}^{4k} \sigma_{a}^{4k} \sum_{(S_1, S_2, T_1, T_2) \in \bar{\Lambda}_{ij}} \Theta^{u}(S_1, S_2, T_1, T_2) \Theta^{a}(S_1, S_2, T_1, T_2),$$
(68)

$$\tilde{\Gamma}_{ij} \triangleq \sigma_{\mathbf{u}}^{4k} \sigma_{\mathbf{a}}^{4k} \sum_{(S_1, S_2, T_1, T_2) \in \tilde{\Lambda}_{ij}} \Theta^{\mathbf{u}}(S_1, S_2, T_1, T_2) \Theta^{\mathbf{a}}(S_1, S_2, T_1, T_2).$$
(69)

Because the two sets $\bar{\Lambda}_{ij}$ and $\bar{\Lambda}_{ij}$ partition the set Λ_{ij} , it follows that $\Gamma_{ij} = \bar{\Gamma}_{ij} + \bar{\Gamma}_{ij}$. Therefore, it suffices to show that

$$\bar{\Gamma}_{ij} = o(\mathsf{E}[\Phi_{ij}]^2 n^{-2}),\tag{70}$$

and

$$\tilde{\Gamma}_{ij} = o(\mathsf{E}[\Phi_{ij}]^2 n^{-2}). \tag{71}$$

We first prove (70), and then prove (71) by showing that $\tilde{\Gamma}_{ij} = O(\bar{\Gamma}_{ij})$.

Consider the user-user edges in H for some $(S_1, S_2, T_1, T_2) \in \overline{\Lambda}_{ij}$. We note that all the user-user edges in H are shared either by S_1, T_1 or S_2, T_2 . This follows by the fact that $\mathcal{E}^{\mathrm{u}}(S_1) = \mathcal{E}^{\mathrm{u}}(T_1)$, $\mathcal{E}^{\mathrm{u}}(S_2) = \mathcal{E}^{\mathrm{u}}(T_2)$, and $\mathcal{E}^{\mathrm{u}}(S_1) \cap \mathcal{E}^{\mathrm{u}}(T_1) = \emptyset$ since $(i, j) \notin \mathcal{E}^{\mathrm{u}}(H)$. As a result, we have $|K_{11}^{\mathrm{u}}| = |K_{21}^{\mathrm{u}}| = |K_{12}^{\mathrm{u}}| = |K_{22}^{\mathrm{u}}| = 0$. Therefore, for any $(S_1, S_2, T_1, T_2) \in \overline{\Lambda}_{ij}$,

$$\Theta^{\mathbf{u}}(S_1, S_2, T_1, T_2) = 1. \tag{72}$$

Now, we consider the user-attribute part of the union graph H. By Lemma 3, the attributes in $\mathcal{V}^{a}(S_1) \cap \mathcal{V}^{a}(T_1)$

can be separated in four types in the same way as we have done in the proof of Proposition 2. We partition the set $\bar{\Lambda}_{ij}$ according the number of each type of shared attributes:

$$\bar{\Lambda}_{ij}^{(M_1,M_2,M_3,M_4)} \triangleq \{ (S_1, S_2, T_1, T_2) \in \bar{\Lambda}_{ij} : Y_1(H) = M_1, Y_2(H) = M_2, Y_3(H) = M_3, Y_4(H) = M_4 \},$$
(73)

where Y_t denotes the number of type-t attributes in H. Let

$$\bar{\Gamma}_{ij}^{(M_1,M_2,M_3,M_4)} \triangleq \sigma_{\mathbf{u}}^{4k} \sigma_{\mathbf{a}}^{4k} \sum_{(S_1,S_2,T_1,T_2)\in\bar{\Lambda}_{ij}^{(M_1,M_2,M_3,M_4)}} \rho_{\mathbf{u}}^{|K_{11}^{\mathbf{u}}|} \rho_{\mathbf{a}}^{|K_{11}^{\mathbf{u}}|} q_{\mathbf{u}}^{-2k+\mathcal{E}^{\mathbf{u}}(H)} q_{\mathbf{a}}^{-2k+\mathcal{E}^{\mathbf{u}}(H)}.$$
(74)

Therefore,

$$\bar{\Gamma}_{ij} = \sum_{0 \le M_1 + M_2 + M_3 + M_4 \le k} \bar{\Gamma}_{ij}^{(M_1, M_2, M_3, M_4)}.$$
(75)

Because $k = \Theta(1)$, it suffices to show that $\overline{\Gamma}_{ij}^{(M_1,M_2,M_3,M_4)} = o(\mathsf{E}[\Phi_{ij}]^2 n^{-2})$ for any $0 \le M_1 + M_2 + M_3 + M_4 \le k$.

Now, we consider the user-attribute edge connections in H of some $(S_1, S_2, T_1, T_2) \in \overline{\Lambda}_{ij}^{(M_1, M_2, M_3, M_4)}$. By a similar argument as for (51), (52) and (53) in the proof of Proposition 2, we still have $|K_{11}^a| = 2k - 2M_2 - 2M_4$, and $|K_{12}^a| = |K_{21}^a| = 0$ and $|K_{22}^a| = M_4$. Therefore, for any $(S_1, S_2, T_1, T_2) \in \overline{\Lambda}_{ij}^{(M_1, M_2, M_3, M_4)}$,

$$\Theta^{\mathbf{a}}(S_1, S_2, T_1, T_2) = \rho_{\mathbf{a}}^{2k - 2M_2 - 2M_4} c^{M_4} \max\{1, \frac{\rho_{\mathbf{a}}^{M_4}}{q_{\mathbf{a}}^{M_4}}\}.$$
(76)

Plugging (72) and (76) into (74) yields

$$\bar{\Gamma}_{ij}^{(M_1,M_2,M_3,M_4)} = \sigma_{\rm u}^{4k} \sigma_{\rm a}^{4k} |\bar{\Lambda}_{ij}^{(M_1,M_2,M_3,M_4)}| \rho_{\rm a}^{2k-2M_2-2M_4} c^{M_4} \max\{1, \frac{\rho_{\rm a}^{M_4}}{q_{\rm a}^{M_4}}\}.$$
(77)

Now, we need to bound $|\bar{\Lambda}_{ij}^{(M_1,M_2,M_3,M_4)}|$. To bound the size of this set, we bound the number of possible ways of forming union graph H of four graphs S_1, S_2, T_1, T_2 , and the belonging of each edge in H. We first consider the user-user part of the union graph H. Remember that $\mathcal{E}^u(S_1) = \mathcal{E}^u(T_1)$ and $\mathcal{E}^u(S_2) = \mathcal{E}^u(T_2)$. It follows that all user vertices in H are shared by S_1, T_1 or S_2, T_2 or all four graphs S_1, T_1, S_2, T_2 . Let β denote the number of users shared by all graphs S_1, T_1, S_2, T_2 . Then it follows that except for i and j, there are $k - \beta$ users in H that are shared by S_1, T_1 and $k - \beta$ users in H that are shared by S_2, T_2 . Moreover, we claim that $k - M_2 \leq \beta \leq k$. To see the claim, we note that each port vertex in H shared by S_1, T_1 or S_2, T_2 is incident to a user-attribute edge shared by S_1, T_1 or S_2, T_2 respectively. However, by the definition of attribute types, we know that there are in total $2M_2$ such user-attribute edges in H. This implies that $2(k - \beta) \leq 2M_2$, which gives the desired bound. Then, we can upper bound the number of ways of forming the user-user part of H by

$$\sum_{\beta=k-M_2}^k \binom{n}{\beta} \binom{n}{k-\beta} \binom{n}{k-\beta}.$$
(78)

In this upper bound, the term in the summation upper bounds the number of the ways of choosing β users shared by $S_1, S_2, T_1, T_2, k - \beta$ users shared by S_1, T_1 and $k - \beta$ users shared by S_2, T_2 from n - 2 users.

For the user-attribute connections, the number of choices is upper bounded by

$$\binom{m}{M_1}\binom{m}{M_2}\binom{m}{M_3}\binom{m}{M_4}\binom{m}{2k-2M}(2k)^{2(2k-M)},$$
(79)

where $M \triangleq M_1 + M_2 + M_3 + M_4$. The term $\binom{m}{M_1}\binom{m}{M_2}\binom{m}{M_3}\binom{m}{M_4}\binom{m}{2k-2M}$ upper bounds the number of ways of choosing the attributes in H from m attributes, and the term $(2k)^{2(2k-M)}$ upper bounds the number of ways of edge connections between those 2k - M chosen attributes and at most 2k users.

Because $k, M, \beta = \Theta(1)$, we have

$$\begin{split} |\bar{\Lambda}_{ij}^{(M_1,M_2,M_3,M_4)}| \\ &\leq \binom{m}{M_1} \binom{m}{M_2} \binom{m}{M_3} \binom{m}{M_4} \binom{m}{2k-2M} (2k)^{2(2k-M)} \sum_{\beta=k-M_2}^k \binom{n}{\beta} \binom{n}{k-\beta} \binom{n}{k-\beta} \\ &\leq \bar{C}m^{2k-M} \sum_{\beta=k-M_2}^k n^{2k-\beta} \\ &= (1+o(1))\bar{C}m^{2k-M} n^{k+M_2}, \end{split}$$
(80)

for some large enough constant \bar{C} . Finally, to see $\bar{\Gamma}_{ij}^{(M_1,M_2,M_3,M_4)} = o(\mathsf{E}[\Phi_{ij}]^2 n^{-2})$, we divide (77) by $\mathsf{E}[\Phi_{ii}]^2$:

$$\frac{\bar{\Gamma}_{ij}^{(M_1,M_2,M_3,M_4)}}{\mathsf{E}[\Phi_{ii}]^2} \leq \frac{\sigma_{\mathrm{u}}^{4k} \sigma_{\mathrm{a}}^{4k} (1+o(1)) \bar{C} m^{2k-M} n^{k+M_2} \rho_{\mathrm{a}}^{2k-2M_2-2M_4} c^{M_4} \max\{1, \frac{\rho_{\mathrm{a}}^{M_4}}{q_{\mathrm{a}}^{M_4}}\}}{\left(\binom{m}{k} (\rho_{\mathrm{u}} \sigma_{\mathrm{u}}^2)^k (\rho_{\mathrm{a}} \sigma_{\mathrm{a}}^2)^k \binom{n-1}{k} k!\right)^2} \\ \leq \frac{\bar{C}' \max\{1, \frac{\rho_{\mathrm{a}}^{M_4}}{q_{\mathrm{a}}^{M_4}}\}}{m^{M} n^{k-M_2} \rho_{\mathrm{a}}^{2M_2+2M_4} \rho_{\mathrm{u}}^{2k}},$$
(81)

for some constant C'. To show that $\frac{\bar{\Gamma}_{ij}^{(M_1,M_2,M_3,M_4)}}{\mathsf{E}[\Phi_{ii}]^2} = o(1/n^2)$, it suffices to show that

$$m^{M}n^{k-M_{2}}\rho_{a}^{2M_{2}+2M_{4}}\rho_{u}^{2k} = \omega(n^{2}),$$
(82)

and

$$m^{M} n^{k-M_{2}} \rho_{a}^{2M_{2}+M_{4}} q_{a}^{M_{4}} \rho_{u}^{2k} = \omega(n^{2}).$$
(83)

To see (82), we notice that

$$m^{M}n^{k-M_{2}}\rho_{a}^{2M_{2}+2M_{4}}\rho_{u}^{2k} \stackrel{(a)}{\geq} m^{M}n^{k-M}\rho_{a}^{2M}\rho_{u}^{2k}$$
$$= (m\rho_{a}^{2}\rho_{u}^{2})^{M}(n\rho_{u}^{2})^{k-M}$$
$$\geq (\min\{m\rho_{a}^{2}\rho_{u}^{2}, n\rho_{u}^{2}\})^{k}$$
$$\stackrel{(b)}{\equiv} \omega(n^{2}),$$

where (a) follows because $M_2 + M_4 \le M$ and (b) follows by assumptions $m\rho_a^2\rho_u^2 = \omega(n^{2/k})$ and $n\rho_u^2 = \omega(n^{2/k})$. To see (83), we observe that

$$m^{M}n^{k-M_{2}}\rho_{\mathbf{a}}^{2M_{2}+M_{4}}q_{\mathbf{a}}^{M_{4}}\rho_{\mathbf{u}}^{2k} = m^{M-M_{2}-M_{4}}m^{M_{2}+M_{4}}n^{k-M_{2}}\rho_{\mathbf{a}}^{2M_{2}+M_{4}}q_{\mathbf{a}}^{M_{4}}\rho_{\mathbf{u}}^{2k}$$
$$= m^{M-M_{2}-M_{4}}(m\rho_{\mathbf{a}}^{2}\rho_{\mathbf{u}}^{2})^{M_{2}}(mq_{\mathbf{a}}\rho_{\mathbf{a}})^{M_{4}}(n\rho_{\mathbf{u}}^{2})^{k-M_{2}}.$$

Suppose $mq_{\rm a}\rho_{\rm a} \ge 1$, then we have

$$m^{M-M_2-M_4} (m\rho_{\rm a}^2\rho_{\rm u}^2)^{M_2} (mq_{\rm a}\rho_{\rm a})^{M_4} (n\rho_{\rm u}^2)^{k-M_2} \ge m^{M-M_2-M_4} (m\rho_{\rm a}^2\rho_{\rm u}^2)^{M_2} (n\rho_{\rm u}^2)^{k-M_2} \ge m^{M-M_2-M_4} (\min\{m\rho_{\rm a}^2\rho_{\rm u}^2, n\rho_{\rm u}^2\})^k \stackrel{(c)}{=} \omega(n^2),$$

where (c) follows because $m\rho_{\rm a}^2\rho_{\rm u}^2 = \omega(n^{2/k})$ and $n\rho_{\rm u}^2 = \omega(n^{2/k})$. Suppose $mq_{\rm a}\rho_{\rm a} < 1$. Because $M_4 \le k - M_2$, we have

$$m^{M-M_{2}-M_{4}}(m\rho_{\mathrm{a}}^{2}\rho_{\mathrm{u}}^{2})^{M_{2}}(mq_{\mathrm{a}}\rho_{\mathrm{a}})^{M_{4}}(n\rho_{\mathrm{u}}^{2})^{k-M_{2}} \geq m^{M-M_{2}-M_{4}}(m\rho_{\mathrm{a}}^{2}\rho_{\mathrm{u}}^{2})^{M_{2}}(mq_{\mathrm{a}}\rho_{\mathrm{a}}n\rho_{\mathrm{u}}^{2})^{k-M_{2}}$$
$$\geq m^{M-M_{2}-M_{4}}(\min\{m\rho_{\mathrm{a}}^{2}\rho_{\mathrm{u}}^{2},mq_{\mathrm{a}}\rho_{\mathrm{a}}n\rho_{\mathrm{u}}^{2}\})^{k}$$
$$\stackrel{(d)}{=}\omega(n^{2}),$$

where (d) follows by assumptions $m\rho_a^2\rho_u^2 = \omega(n^{2/k})$ and $mq_a\rho_a n\rho_u^2 = \omega(n^{2/k})$. Next, we show that $\tilde{\Gamma}_{ij} = O(\bar{\Gamma}_{ij})$. The key idea in this part of the proof is that since we already fixed an edge

Next, we show that $\Gamma_{ij} = O(\Gamma_{ij})$. The key idea in this part of the proof is that since we already fixed an edge (i, j) in the union graph of the four tuples in $\tilde{\Lambda}_{ij}$, the choices of the 4-tuples is greatly restricted, and hence, it become a dominated case comparing to $\bar{\Lambda}_{ij}$.

Firstly, we further partition $\hat{\Lambda}_{ij}$ into three subsets

$$\tilde{\Lambda}_{ij} = \tilde{\Lambda}_{ij}(1) \cup \tilde{\Lambda}_{ij}(2) \cup \tilde{\Lambda}_{ij}(3), \tag{84}$$

where

$$\begin{split} \tilde{\Lambda}_{ij}(1) &\triangleq \{ (S_1, S_2, T_1, T_2) \in \tilde{\Lambda}_{ij} : (i, j) \in (\mathcal{E}^{\mathrm{u}}(S_1) \cap \mathcal{E}^{\mathrm{u}}(T_1)) \cap (\mathcal{E}^{\mathrm{u}}(S_2) \cup \mathcal{E}^{\mathrm{u}}(T_2))^c \} \\ \tilde{\Lambda}_{ij}(2) &\triangleq \{ (S_1, S_2, T_1, T_2) \in \tilde{\Lambda}_{ij} : (i, j) \in (\mathcal{E}^{\mathrm{u}}(S_1) \cup \mathcal{E}^{\mathrm{u}}(T_1))^c \cap (\mathcal{E}^{\mathrm{u}}(S_2) \cap \mathcal{E}^{\mathrm{u}}(T_2)) \} \\ \tilde{\Lambda}_{ij}(3) &\triangleq \{ (S_1, S_2, T_1, T_2) \in \tilde{\Lambda}_{ij} : (i, j) \in \mathcal{E}^{\mathrm{u}}(S_1) \cap \mathcal{E}^{\mathrm{u}}(T_2) \cap \mathcal{E}^{\mathrm{u}}(S_2) \cap \mathcal{E}^{\mathrm{u}}(T_2) \} \end{split}$$

In other words, $\tilde{\Lambda}_{ij}(1)$ includes the cases that (i, j) is shared only by S_1, T_1 , $\tilde{\Lambda}_{ij}(2)$ includes the cases that (i, j) is shared only by S_2, T_2 and $\tilde{\Lambda}_{ij}(3)$ includes the cases that (i, j) is shared all four graphs. We notice that $\tilde{\Lambda}_{ij}(1), \tilde{\Lambda}_{ij}(2), \tilde{\Lambda}_{ij}(3)$ indeed partition the set $\tilde{\Lambda}_{ij}$ because of $\mathcal{E}^{\mathrm{u}}(S_1) = \mathcal{E}^{\mathrm{u}}(T_1)$ and $\mathcal{E}^{\mathrm{u}}(S_2) = \mathcal{E}^{\mathrm{u}}(T_2)$. Following this definition, we define

$$\tilde{\Gamma}_{ij}(t) \triangleq \sigma_{\mathbf{u}}^{4k} \sigma_{\mathbf{a}}^{4k} \sum_{(S_1, S_2, T_1, T_2) \in \tilde{\Lambda}_{ij}(t)} \Theta^{\mathbf{u}}(S_1, S_2, T_1, T_2) \Theta^{\mathbf{a}}(S_1, S_2, T_1, T_2).$$

for each $t \in [3]$. Thus, to show that $\tilde{\Gamma}_{ij} = O(\bar{\Gamma}_{ij})$, it suffices to show that $\tilde{\Gamma}_{ij}(t) = O(\bar{\Gamma}_{ij})$ for each $t \in [3]$. Firstly, we show that $\tilde{\Gamma}_{ij}(1) = o(\bar{\Gamma}_{ij})$. Similarly to our analysis for $\bar{\Gamma}_{ij}$, we can partition $\tilde{\Lambda}_{ij}(1)$ as

$$\tilde{\Lambda}_{ij}(1) = \bigcup_{0 \le M_1 + M_2 + M_3 + M_4 \le k} \tilde{\Lambda}_{ij}^{(M_1, M_2, M_3, M_4)}(1),$$

according to the number of the four types of shared attributes in the union graph H, and define

$$\tilde{\Gamma}_{ij}^{(M_1,M_2,M_3,M_4)}(1) \triangleq \sigma_{\mathbf{u}}^{4k} \sigma_{\mathbf{a}}^{4k} \sum_{(S_1,S_2,T_1,T_2)\in\tilde{\Lambda}_{ij}^{(M_1,M_2,M_3,M_4)}(1)} \Theta^{\mathbf{u}}(S_1,S_2,T_1,T_2)\Theta^{\mathbf{a}}(S_1,S_2,T_1,T_2).$$

For each $(S_1, S_2, T_1, T_2) \in \tilde{\Lambda}_{ij}^{(M_1, M_2, M_3, M_4)}(1)$, it is easy to check that

$$\Theta^{\mathrm{u}}(S_1, S_2, T_1, T_2) = 1$$

and

$$\Theta^{\mathbf{a}}(S_1, S_2, T_1, T_2) = \rho_{\mathbf{a}}^{2k - 2M_2 - 2M_4} c^{M_4} \max\{1, \frac{\rho_{\mathbf{a}}^{M_4}}{q_{\mathbf{a}}^{M_4}}\}$$

which are the same as a 4-tuple $(S_1, S_2, T_1, T_2) \in \bar{\Lambda}_{ij}^{(M_1, M_2, M_3, M_4)}$. However, the cardinality of $\tilde{\Lambda}_{ij}^{(M_1, M_2, M_3, M_4)}(1)$ is much smaller than the cardinality of $\bar{\Lambda}_{ij}^{(M_1, M_2, M_3, M_4)}$. To see that, we observe that number of choices of the user-attribute part of the union graph in $\tilde{\Lambda}_{ij}^{(M_1, M_2, M_3, M_4)}(1)$ is the same as the number of choices in $\bar{\Lambda}_{ij}^{(M_1, M_2, M_3, M_4)}$. However, the number of ways of choosing the user-user part in $\tilde{\Lambda}_{ij}^{(M_1, M_2, M_3, M_4)}(1)$ is upper bounded by

$$\sum_{\beta=k-M_2}^k \binom{n}{\beta} \binom{n}{k-1-\beta} \binom{n}{k-\beta}.$$
(85)

This is because we can choose β users shared by $S_1, S_2, T_1, T_2, k - \beta$ users shared by T_1, T_2 and $k - \beta - 1$ users other than j that are shared by S_1, T_1 . If we compare (85) to (78), we can observe that there is a factor n missing in (85). This is because one of the users in S_1 and T_1 are already fixed to j, so we have one less user to choose. This implies that $\tilde{\Gamma}_{ij}^{(M_1,M_2,M_3,M_4)}(1) = O(\bar{\Gamma}_{ij}^{(M_1,M_2,M_3,M_4)}/n)$ for any $0 \le M_1 + M_2 + M_3 + M_4 \le k$, and it follows that $\tilde{\Gamma}_{ij}(1) = o(\bar{\Gamma}_{ij})$. The proof of $\tilde{\Gamma}_{ij}(2) = o(\bar{\Gamma}_{ij})$ follows similarly as the proof of $\tilde{\Gamma}_{ij}(1) = o(\bar{\Gamma}_{ij})$. Finally, we show that $\tilde{\Gamma}_{ij}(3) = O(\bar{\Gamma}_{ij})$. We perform the similar partition again:

$$\tilde{\Lambda}_{ij}(3) = \bigcup_{0 \le M_1 + M_2 + M_3 + M_4 \le k} \tilde{\Lambda}_{ij}^{(M_1, M_2, M_3, M_4)}(3)$$

according to the number of the four types of shared attributes in the union graph H, and define

$$\tilde{\Gamma}_{ij}^{(M_1,M_2,M_3,M_4)}(3) \triangleq \sigma_{\mathbf{u}}^{4k} \sigma_{\mathbf{a}}^{4k} \sum_{(S_1,S_2,T_1,T_2)\in \tilde{\Lambda}_{ij}^{(M_1,M_2,M_3,M_4)}(3)} \Theta^{\mathbf{u}}(S_1,S_2,T_1,T_2)\Theta^{\mathbf{a}}(S_1,S_2,T_1,T_2).$$

For each $(S_1, S_2, T_1, T_2) \in \tilde{\Lambda}_{ij}^{(M_1, M_2, M_3, M_4)}(3)$, in the user-attribute part of the union graph, we still have

$$\Theta^{\mathbf{a}}(S_1, S_2, T_1, T_2) = \rho_{\mathbf{a}}^{2k - 2M_2 - 2M_4} c^{M_4} \max\{1, \frac{\rho_{\mathbf{a}}^{M_4}}{q_{\mathbf{a}}^{M_4}}\}.$$

However, in the user-attribute part, we have $|K_{22}^{u}| = 1$ instead of $|K_{22}^{u}| = 0$ in the previous case. This is because we have the edge (i, j) shared by all four graphs. It is easy to check that we still have $|K_{11}^{u}| = |K_{12}^{u}| = |K_{21}^{u}| = 0$. Thus, we have

$$\Theta^{\mathbf{u}}(S_1, S_2, T_1, T_2) = c \max\{1, \frac{\rho_{\mathbf{u}}}{q_u}\} \le \frac{c}{q_u}$$

Moreover, if we compare $|\tilde{\Lambda}_{ij}^{(M_1,M_2,M_3,M_4)}(3)|$ to $|\bar{\Lambda}_{ij}^{(M_1,M_2,M_3,M_4)}|$, we observe that

$$\frac{|\tilde{\Lambda}_{ij}^{(M_1,M_2,M_3,M_4)}(3)|}{|\bar{\Lambda}_{ij}^{(M_1,M_2,M_3,M_4)}|} = O(1/n^2).$$

This is because in the union graph of a 4-tuple $(S_1, S_2, T_1, T_2) \in \tilde{\Lambda}_{ij}^{(M_1, M_2, M_3, M_4)}(3)$, we have two less users to choose, since one of the ports in S_1, T_1 is fixed to j and one of the ports in S_2, T_2 is fixed to i. As a result, for any $0 \leq M_1 + M_2 + M_3 + M_4 \leq k$, we have

$$\frac{\tilde{\Gamma}_{ij}^{(M_1,M_2,M_3,M_4)}(3)}{\bar{\Gamma}_{ij}^{(M_1,M_2,M_3,M_4)}} = O\left(\frac{c}{n^2 q_{\mathrm{u}}}\right) = O(1),$$

because of assumption $n^2 q_u = \Omega(1)$. This further implies that $\tilde{\Gamma}_{ij}(3) = O(\bar{\Gamma}_{ij})$, which completes the proof.

Appendix C

PROOF OF THEOREM 2

In this section, we prove the theoretical performance guarantee for exact alignment. Recall that Theorem 1 ensures that Algorithm 1 outputs a set of users I with |I| = n - o(n) and a mapping $\hat{\Pi}$ with $\hat{\Pi}(i) = \hat{\Pi}^*(i), \forall i \in I$. Therefore, to prove Theorem 2, it suffices to show that Algorithms 2 and 3 can exactly recover Π^* with input $I, \hat{\Pi}$ under the ATTRSPARSE regime and ATTRRICH regime respectively. In the following two propositions, we

provide performance guarantee for the two refinement algorithms respectively. To state the two propositions, we define function

$$f(x) \triangleq x \log x - x + 1.$$

Note that f(x) is a function monotonically decreasing in (0, 1), and monotonically increasing in $(1, \infty)$.

Proposition 4 (Feasible region of Algorithm 2 in ATTRSPARSE regime). Suppose $(G_1, G'_2) \sim \mathcal{G}(n, q_u, \rho_u; m, q_a, \rho_a)$, where

$$n\rho_{\rm u}^2 = \omega(\log n),\tag{86}$$

$$nq_{\rm u}(q_{\rm u}+\rho_{\rm u}(1-q_{\rm u})) \ge (1+\epsilon)\log n \tag{87}$$

and

$$\frac{\rho_{\rm u}(1-q_{\rm u})}{q_{\rm u}} \ge \epsilon \tag{88}$$

for some arbitrarily small constant ϵ . Let $\hat{\pi} \equiv \hat{\pi}(G_1, G'_2)$ be a mapping $I \to [n]$ such that $\hat{\pi} = \pi^*|_I$ and $|I| \ge (1 - \epsilon/16)n$. Let γ_1 denote the unique solution in $(1, \infty)$ to $f(\gamma_1) = \frac{3\log n}{(n-2)q_u^2}$. Then there exists an algorithm, namely Algorithm 2 with inputs γ_1 , I and $\hat{\pi}$, that outputs $\tilde{\pi} = \pi^*$ with high probability.

Proposition 5 (Feasible region of Algorithm 3 in ATTRRICH regime). Suppose $(G_1, G'_2) \sim \mathcal{G}$ $(n, q_u, \rho_u; m, q_a, \rho_a)$, where

$$n\rho_{\rm u}^2 = \omega(\log n),\tag{89}$$

$$m\rho_{\rm a}^2 = \omega(\log n),\tag{90}$$

$$nq_{\rm u}(q_{\rm u} + \rho_{\rm u}(1 - q_{\rm u})) + mq_{\rm a}(q_{\rm a} + \rho_{\rm a}(1 - q_{\rm u})) \ge (1 + \epsilon)\log n \tag{91}$$

$$nq_{\rm u}(q_{\rm u}+\rho_{\rm u}(1-q_{\rm u}))=\Omega(\log n), \tag{92}$$

$$mq_{\rm a}(q_{\rm a}+\rho_{\rm a}(1-q_{\rm u}))=\Omega(\log n), \tag{93}$$

$$\frac{\rho_{\rm u}(1-q_{\rm u})}{q_{\rm u}} \ge \epsilon,\tag{94}$$

and

$$\frac{\rho_{\rm a}(1-q_{\rm a})}{q_{\rm a}} \ge \epsilon,\tag{95}$$

for some arbitrarily small constant ϵ . Let $\hat{\pi} \equiv \hat{\pi}(G_1, G'_2)$ be a mapping $I \to [n]$ such that $\hat{\pi} = \pi^*|_I$ and $|I| \ge (1 - \epsilon/16)n$. Let γ_2 denote the unique solution in $(1, \infty)$ to $f(\gamma_2) = \frac{3 \log n}{(n-2)q_u^2}$, and let γ_3 denote the unique solution in $(1, \infty)$ to $f(\gamma_3) = \frac{3 \log n}{mq_a^2}$. Then there exists an algorithm, namely Algorithm 3 with inputs γ_2, γ_3, I and $\hat{\pi}$, that outputs $\tilde{\pi} = \pi^*$ with high probability.

With Propositions 4 and 5, we are now ready to prove Theorem 2.

Proof of Theorem 2.. In this proof, we partition the information theoretic feasible region

$$nq_{\mathbf{u}}(q_{\mathbf{u}} + \rho_{\mathbf{u}}(1 - q_{\mathbf{u}})) + mq_{\mathbf{a}}(q_{\mathbf{a}} + \rho_{\mathbf{a}}(1 - q_{\mathbf{a}})) \ge (1 + \epsilon)\log n$$

into three regimes:

1) $mq_{a}(q_{a} + \rho_{a}(1 - q_{a})) = o(\log n)$, and $nq_{u}(q_{u} + \rho_{u}(1 - q_{u})) \ge (1 + \epsilon)\log n$; 2) $mq_{a}(q_{a} + \rho_{a}(1 - q_{a})) = \Omega(\log n)$, and $nq_{u}(q_{u} + \rho_{u}(1 - q_{u})) = \Omega(\log n)$;

3) $mq_{a}(q_{a} + \rho_{a}(1 - q_{a})) \ge (1 + \epsilon) \log n$, and $nq_{u}(q_{u} + \rho_{u}(1 - q_{u})) = o(\log n)$,

and separately prove the feasibility of exact alignment in each regime.

In the first regime, by the assumptions in Theorem 2, all the conditions in Theorem 1 are satisfied, so the outputs I and $\hat{\pi}$ from Algorithm 1 satisfy that $\hat{\pi} = \pi^*|_I$, and $|I| \ge n - o(n)$ with high probability. Moreover, because condition (3) implies condition (86) and we have $nq_u(q_u + \rho_u(1 - q_u)) \ge (1 + \epsilon)\log n$ in this regime, all the conditions in Proposition 4 are satisfied. Therefore, on the event that $\{\hat{\pi} = \pi^*|_I\} \cap \{|I| \ge n - o(n)\}$, Algorithm 2 outputs $\tilde{\pi} = \pi^*$ with high probability. This completes the proof for the regime.

In the second regime, similarly, we know that the outputs from Algorithm 1 satisfy $\hat{\pi} = \pi^*|_I$, and $|I| \ge n - o(n)$ with high probability. Notices that condition (2) implies condition (90), and condition (3) implies condition (89). By assumptions $mq_a(q_a + \rho_a(1 - q_u)) = \Omega(\log n)$, and $nq_u(q_u + \rho_u(1 - q_u)) = \Omega(\log n)$ for the ATTRRICH regime, we can see that all the conditions in Proposition 5 are satisfied. Thus, on the event $\{\hat{\pi} = \pi^*|_I\} \cap \{|I| \ge n - o(n)\}$, Algorithm 3 outputs $\tilde{\pi} = \pi^*$ with high probability. Therefore, exact recovery is achieved with high probability.

Finally, consider the third regime. In this regime, we consider a strictly harder problem where all user-user edges are removed from the two graphs G_1 and G'_2 . Then both graphs reduce to bipartite graphs with edges only between the users and the attributes. For this bipartite graph alignment problem, it is well-known that the optimal MAP estimator can be implemented efficiently within $O(n^3)$ complexity (See for example Cullina et al. (2018)). In Theorem 1 of Zhang et al. (2024), it is shown that the MAP estimator achieves exact recovery if

$$m(\sqrt{q_{11}q_{00}} - \sqrt{q_{01}q_{10}})^2 \ge \log n + \omega(1), \tag{96}$$

where

$$q_{11} \triangleq q_{\rm a}(q_{\rm a} + \rho_{\rm a}(1 - q_{\rm a})),$$
$$q_{00} \triangleq 1 - q_{\rm a}(q_{\rm a} + \rho_{\rm a}(1 - q_{\rm a})) - 2q_{\rm a}(1 - q_{\rm a} - \rho_{\rm a}(1 - q_{\rm a}))$$

and

$$q_{10} = q_{01} \triangleq q_{\rm a}(1 - q_{\rm a} - \rho_{\rm a}(1 - q_{\rm a})).$$

To complete the proof, it suffices to show that (96) is satisfied under $mq_a(q_a + \rho_a(1-q_a)) \ge (1+\epsilon) \log n$ and other conditions of Theorem 2. Towards the proof, we define two more quantities $s_a \triangleq q_a + \rho_a(1-\rho_a)$ and $q \triangleq q_a/s_a$. In view of condition (7), we know that q is bounded away from 1. We separately consider two regimes of q to complete the proof.

Firstly, consider the regime q = o(1). Notice that $\frac{1}{q} = 1 + \frac{\rho_a(1-q_a)}{q_a}$, we then have $\rho_a = \omega(q_a)$, which further implies that $s_a = (1 - o(1))\rho_a$. It follows that

$$m(\sqrt{q_{11}q_{00}} - \sqrt{q_{01}q_{10}})^2 \ge m(\sqrt{q_{11}q_{00}} - q_a)^2$$

= $m(\sqrt{q_as_a} - q_a)^2(1 - o(1))$
= $(1 - o(1))mq_as_a,$

where the penultimate equality follows because q = o(1) and the last equality follows because $s_a = (1 - o(1))\rho_a = \omega(q_a)$. Finally, (96) follows by the assumption that $mq_as_a \ge (1 + \epsilon)\log n$.

Next, we consider the regime $q = \Theta(1)$. In this regime, by the definitions of q and s_a , we have $\rho_a = \Theta(q_a)$ and $\rho_a = \Theta(s_a)$. Moreover, we have

$$m(\sqrt{q_{11}q_{00}} - \sqrt{q_{01}q_{10}})^2 = (1-q)mq_{\rm a}s_{\rm a}\frac{1}{\left(\sqrt{1 + \frac{q(1-s_{\rm a})^2}{1-q}} + \sqrt{\frac{q(1-s_{\rm a})^2}{1-q}}\right)^2} = \Theta(mq_{\rm a}s_{\rm a}),$$

because q is bounded away from 1. The proof is then completed by realizing

$$mq_{\rm a}s_{\rm a} = mqs_{\rm a}^2 = \Omega(mq\rho_{\rm a}^2) = \Omega(n^{\Theta(1)}),$$

where the last equality follows by condition (2) and the assumption that $q = \Theta(1)$.

A. Proof of Proposition 4

In this section, we show that Algorithm 2 achieves exact recovery under the conditions specified by Proposition 4. Towards that goal, we first present a lemma in Mao et al. (2023b) that shows an Erdős–Rényi graph $G \sim \mathcal{G}(n, p)$ has good expansion property with high probability.

Lemma 5 (Lemma 13 in Mao et al. (2023b)). Suppose $G \sim \mathcal{G}(n, p)$, where $np \ge (1 + \epsilon) \log n$ for an arbitrarily small constant ϵ . Let $\kappa_G(I, I^c)$ denote the number of edges between $I \subseteq [n]$ and I^c , where $I^c \triangleq [n] \setminus I$. Then with

probability at least $1 - O(n^{-\epsilon/8})$, for all subsets $I \subseteq [n]$ with $|I| \leq \frac{\epsilon}{16}n$, we have $\kappa_G(I, I^c) \geq \eta |I| |I^c| p$, where η is the unique solution in (0, 1) to $f(\eta) = \frac{(1+\epsilon/8)\log n}{(1-\epsilon/16)np}$. Moreover, η satisfies lower bound

$$\eta \ge \max\left\{\frac{\epsilon}{16}, 1 - \sqrt{\frac{2(1+\epsilon/8)\log n}{(1-\epsilon/16)np}}\right\}.$$
(97)

Now, we are ready to prove Proposition 4. We assume without generality that the true permutation π^* is the identity permutation. For a pair of user vertices $i \in \mathcal{V}_1^u$ and $j \in \mathcal{V}_2^u$, let $N^u(i, j)$ denote the number of user vertices $u \in [n]$ such that u is connected to i in G_1 and u is connected to j in G'_2 . By the definition of the attributed Erdős–Rényi graph pair model, we have $N^u(i, j) \sim \text{Binom}(n-2, q_u^2)$ for any $i \neq j$. By the multiplicative Chernoff bound (see for example Mitzenmacher and Upfal (2005, Theorem 4.4)), we have

$$\mathsf{P}(N^{\mathrm{u}}(i,j) \ge \gamma_1(n-2)q_{\mathrm{u}}^2) \le \exp(-(n-2)q_{\mathrm{u}}^2h(\gamma_1)) = n^{-3}.$$

By a union bound over all the $\binom{n}{2}$ pairs of users, we have that

$$\mathsf{P}(\exists i, j \in [n], i \neq j : N^{\mathrm{u}}(i, j) \ge \gamma_1(n-2)q_{\mathrm{u}}^2) \le \binom{n}{2}n^{-3} \le n^{-1}.$$
(98)

Now, we assume that $\{\nexists i, j \in [n], i \neq j : N^{u}(i, j) \geq \gamma_1(n-2)q_u^2\}$. From this, we are going prove by induction that $\tilde{\pi} = \pi^*|_J$ throughout out the process of the algorithm. At the beginning of the algorithm, this certainly holds because we set J = I and $\tilde{\pi} = \hat{\pi}$. Now we suppose $\tilde{\pi} = \pi^*|_J$ up to l calls of the while loop in Algorithm 2. Consider the (l+1)-th call of the while loop. By the induction hypothesis, we have that

$$N^{\mathbf{u}}_{\tilde{\pi}}(i,j) \le N^{\mathbf{u}}(i,j) < \gamma_1(n-2)q_{\mathbf{u}}^2,$$

for all $i, j \in [n]$, $i \neq j$. As a result, at (l+1)-th call of the while loop, we either have that Algorithm 2 terminates or some i is added to J and $\tilde{\pi}(i) = i$. This proves that $\tilde{\pi} = \pi^*|_J$ after l+1 calls of the while loop.

To complete the proof, next we show that when the algorithm terminates, we have J = [n] and $\tilde{\pi}$ equals to the identity permutation. Towards contradiction, we suppose that the algorithm ends with |J| < n. This suggests that $N_{\tilde{\pi}}^{u}(i, i) < \gamma_1(n-2)q_u^2$ for each $i \in J^c$, which further implies that

$$\kappa_{G_1^{\mathrm{u}} \cap G_2^{\mathrm{u}}}(J, J^c) = \sum_{i \in J^c} N_{\tilde{\pi}}^{\mathrm{u}}(i, i) < \gamma_1 (n - 2) q_{\mathrm{u}}^2 |J^c|.$$
⁽⁹⁹⁾

From the attributed Erdős–Rényi graph pair model, it is not hard to see that $G_1^{\rm u} \cap G_2^{\prime u} \sim \mathcal{G}(n, q_{\rm u}s_{\rm u})$, where $s_{\rm u} \triangleq q_{\rm u} + \rho_{\rm u}(1 - q_{\rm u})$. Because condition (87) holds, from Lemma 5, we know that with probability at least $1 - O(n^{-\epsilon/8})$,

$$\kappa_{G_1^{\mathrm{u}} \cap G_2^{\mathrm{u}}}(J, J^c) \ge \eta |J| |J^c| q_{\mathrm{u}} s_{\mathrm{u}} \stackrel{(a)}{\ge} \eta (1 - \epsilon/16) n |J^c| q_{\mathrm{u}} s_{\mathrm{u}}, \tag{100}$$

where η is the unique solution in (0, 1) to $h(\eta) = \frac{(1+\epsilon/8)\log n}{(1-\epsilon/16)nq_us_u}$ and (a) follows because we assume $|J| \ge (1-\epsilon/16)n$ at the very beginning of the algorithms. To complete the proof, it suffices to show that $\gamma_1(n-2)q_u^2|J^c| \le \eta(1-\epsilon/16)n|J^c|q_us_u$, i.e., we want to show that

$$\gamma_1 \le \eta (1 - \epsilon/16) \frac{s_{\mathrm{u}}}{q_{\mathrm{u}}} \triangleq \bar{\gamma}_1.$$

By taking derivative, one can check that f(x) is monotone increasing on $(1, \infty)$. Thus, it suffices to show that $\bar{\gamma}_1 > 1$ and $f(\bar{\gamma}_1) \ge f(\gamma_1)$. We show these by considering two different cases.

Case 1: $q_{\rm u} = o(\rho_{\rm u})$: In view of $\eta \ge \epsilon/16$, we have

$$\bar{\gamma}_1 \ge (1 - \epsilon/16) \frac{\epsilon s_{\mathrm{u}}}{16q_{\mathrm{u}}}$$
$$= (1 - \epsilon/16) \frac{\epsilon}{16} \left(1 + \frac{\rho_{\mathrm{u}}(1 - q_{\mathrm{u}})}{q_{\mathrm{u}}} \right)$$
$$= \omega(1),$$

where the last equality follows because $q_u = o(\rho_u)$. Therefore, it follows that

$$f(\bar{\gamma}_1) > \bar{\gamma}_1(\log \bar{\gamma}_1 - 1) \stackrel{(b)}{=} \omega(\bar{\gamma}_1) \stackrel{(c)}{=} \omega\left(\frac{s_{\mathrm{u}}}{q_{\mathrm{u}}}\right),$$

where (b) follows because $\bar{\gamma}_1 = \omega(1)$ and (c) follows because $\eta \ge \epsilon/16$ and $\epsilon = \Theta(1)$. Finally, the proof of Case 1 is completed by realizing $f(\bar{\gamma}_1) \ge f(\gamma_1)$ because

$$\frac{s_{\rm u}/q_{\rm u}}{f(\bar{\gamma}_1)} = \frac{s_{\rm u}/q_{\rm u}}{3\log n/((n-2)q_{\rm u}^2)} = \frac{(n-2)q_{\rm u}s_{\rm u}}{3\log n} = \Omega(1),$$

where the last equality follows by the assumption that $nq_{\mathbf{u}}s_{\mathbf{u}} \ge (1+\epsilon)\log n$. <u>Case 2:</u> $q_{\mathbf{u}} = \Omega(\rho_{\mathbf{u}})$: Recall that we have $\eta \ge 1 - \sqrt{\frac{2(1+\epsilon/8)\log n}{(1-\epsilon/16)nq_{\mathbf{u}}s_{\mathbf{u}}}}$. Notice that

$$nq_{\mathbf{u}}s_{\mathbf{u}} \ge nq_{\mathbf{u}}^2 = \Omega(n\rho_{\mathbf{u}}^2) = \omega(\log n),$$

where the last equality follows by condition (86) in the proposition. Then it follows that $\eta \ge 1 - \epsilon/16$. Therefore, we have

$$\bar{\gamma}_1 \ge (1 - \epsilon/16)^2 \frac{s_u}{q_u}$$

$$\stackrel{(d)}{\ge} (1 - \epsilon/16)^2 (1 + \epsilon)$$

$$> 1 + \epsilon/2,$$

where (d) follows by condition (88) in the proposition. Finally, the proof is completed by

$$f(\bar{\gamma}_1) \ge f(1+\epsilon/2) \stackrel{(e)}{>} \frac{3\log n}{(n-2)q_{\mathrm{u}}^2} = f(\gamma_1),$$

where (e) follows because $f(1 + \epsilon/2) = \Omega(1)$, while $\frac{3 \log n}{(n-2)q_n^2} = O(\frac{3 \log n}{(n-2)\rho_n^2}) = o(1)$ by condition (86).

B. Proof of Proposition 5

To show Proposition 5, we firstly study some expansion property of random attributed graphs. To state the result, we need to define the *attributed Erdős–Rényi graph model* $\mathcal{G}(n, p; m, q)$, which generates random attributed graphs. In this model, we generate an attributed graph G with n + m vertices, where $\mathcal{V}^{\mathrm{u}}(G) = [n]$ and $\mathcal{V}^{\mathrm{a}}(G) = [n]$ $\{a_1,\ldots,a_m\}$. Between each pair $(i,j) \in \mathcal{V}^u(G) \times \mathcal{V}^u(G), i \neq j$, a user-user edge is generated i.i.d. with probability p, and between each pair $(i, a_i) \in \mathcal{V}^u(G) \times \mathcal{V}^a(G)$, a user-attribute edge is generated i.i.d. with probability q. We show that attributed graphs generated from the attributed Erdős–Rényi graph model satisfies good expansion property with high probability.

Lemma 6 (Expansion property of attributed Erdős–Rényi graph). Suppose $G \sim \mathcal{G}(n, p; m, q)$. Assume $np \geq 1$ $\lambda_1(1+\epsilon)\log n, \ mq \geq \lambda_2(1+\epsilon)\log n \ for \ some \ constants \ \epsilon, \lambda_1, \lambda_2 \ with \ \lambda_1+\lambda_2 \geq 1.$ Let $\kappa_G^{\mathrm{u}}(I, I^c)$ denote the number of user-user edges between $I \subseteq [n]$ and I^c , where $I^c \triangleq [n] \setminus I$. Let $\kappa_G^{\mathrm{u}}(I, \mathcal{V}^{\mathrm{u}}(G))$ denote the number of userattribute edges between $I \subseteq [n]$ and $\mathcal{V}^{a}(G)$. Let η_{1} denote the unique solution in (0,1) to $f(\eta_{1}) = \frac{\lambda_{1}(1+\epsilon/8)\log n}{(1-\epsilon/16)np}$ and η_2 denote the unique solution in (0,1) to $f(\eta_2) = \frac{\lambda_2(1+\epsilon/8)\log n}{mq}$. Then with probability at least $1 - O(n^{-\epsilon/8})$, for all subsets $I \subseteq [n]$ with $|I| \leq \frac{\epsilon}{16}n$, at least one of the following two events happens:

- 1) $\kappa_G^{u}(I, I^c) \ge \eta_1 |I| |I^c| p;$
- 2) $\kappa_G^{\mathbf{a}}(I, \mathcal{V}^{\mathbf{a}}(G)) \ge \eta_2 |I| mq.$

Moreover, η_1 and η_2 satisfy lower bounds

$$\eta_1 \ge \max\left\{\epsilon/16, 1 - \sqrt{\frac{2\lambda_1(1+\epsilon/8)\log n}{(1-\epsilon/16)np}}\right\},\tag{101}$$

$$\eta_2 \ge \max\left\{\epsilon/16, 1 - \sqrt{\frac{2\lambda_2(1+\epsilon/8)\log n}{mq}}\right\}.$$
(102)

Proof of Lemma 6. When $|I| = \emptyset$, both events in Lemma 6 happen. Therefore, we only consider the non-trivial cases of $1 \le |I| \le \epsilon/16$. For some fixed I with $1 \le |I| \le \epsilon/16$, we observe that $\kappa_G^u(I, I^c) \sim \text{Binom}(|I||I^c|, p)$. Notice that

$$f(\eta_1) = \frac{\lambda_1(1 + \epsilon/8)\log n}{(1 - \epsilon/16)np} \le \frac{1 + \epsilon/8}{(1 - \epsilon/16)(1 + \epsilon)} < 1.$$

Therefore, there indeed exists a unique solution $\eta_1 \in (0, 1)$. By the multiplicative Chernoff bound, we have

$$\begin{aligned} \mathsf{P}(\kappa_G^{\mathrm{u}}(I,I^c) &\leq \eta_1 |I| |I^c|p) \leq \exp(-f(\eta_1) |I| |I^c|p) \\ &= \exp\left(-\frac{\lambda_1 (1+\epsilon/8) \log n}{(1-\epsilon/16) n p} |I| |I^c|p\right) \\ &\stackrel{(a)}{\leq} \left(-\frac{\lambda_1 (1+\epsilon/8) \log n}{(1-\epsilon/16) n p} |I| (1-\epsilon/16) n p\right) \\ &= \exp\left(-\lambda_1 (1+\epsilon/8) |I| \log n\right), \end{aligned}$$

where (a) follows because $|I^c| \ge (1 - \epsilon/16)n$. Similarly, we observe that $\kappa_G^a(I, \mathcal{V}^a(G)) \sim \text{Binom}(|I|m, q)$. Note that

$$f(\eta_2) = \frac{\lambda_2(1+\epsilon/8)\log n}{mq} \le \frac{1+\epsilon/8}{1+\epsilon} < 1.$$

Thus, there indeed exists a unique solution $\eta_2 \in (0,1)$. By the multiplicative Chernoff bound, we have

$$\mathsf{P}(\kappa_G^{\mathrm{a}}(I,\mathcal{V}^{\mathrm{a}}(G)) \le \eta_2 |I|\mathcal{V}^{\mathrm{a}}(G)q) \le \exp(-f(\eta_2)|I|mq)$$

= $\exp\left(-\frac{\lambda_2(1+\epsilon/8)\log n}{mq}|I|mq\right)$
= $\exp(-\lambda_2(1+\epsilon/8)|I|\log n).$

Notice that $\kappa_G^{\mathrm{u}}(I, I^c)$ and $\kappa_G^{\mathrm{a}}(I, \mathcal{V}^{\mathrm{a}}(G))$ are two independent random variables because $\kappa_G^{\mathrm{u}}(I, I^c)$ only counts user-user edges, while $\kappa_G^{\mathrm{a}}(I, \mathcal{V}^{\mathrm{a}}(G))$ only counts user-attribute edges. Hence, we have

$$\begin{aligned} \mathsf{P}(\kappa_G^{\mathrm{u}}(I, I^c) &\leq \eta_1 |I| |I^c| p \text{ and } \kappa_G^{\mathrm{a}}(I, \mathcal{V}^{\mathrm{a}}(G)) \leq \eta_2 |I| \mathcal{V}^{\mathrm{a}}(G) q) \\ &\leq \exp(-(\lambda_1 + \lambda_2)(1 + \epsilon/8) |I| \log n) \\ &< n^{-(1 + \epsilon/8)|I|}. \end{aligned}$$

where the last inequality follows because $\lambda_1 + \lambda_2 \ge 1$. Applying a union bound over all $\binom{n}{k}$ choices of |I| = l yields

$$\begin{aligned} \mathsf{P}(\exists I \subseteq [n] : |I| = l, \kappa_G^{\mathrm{u}}(I, I^c) \leq \eta_1 |I| |I^c| p \text{ and } \kappa_G^{\mathrm{a}}(I, \mathcal{V}^{\mathrm{a}}(G)) \leq \eta_2 |I| \mathcal{V}^{\mathrm{a}}(G) q) \\ \leq \binom{n}{l} n^{-(1+\epsilon/8)l} \leq n^{-\epsilon l/8}. \end{aligned}$$

Finally, applying a union bounder over $1 \leq l \leq \lfloor \epsilon n/16 \rceil$ yields

$$\begin{split} \mathsf{P}(\exists I \subseteq [n] : 1 \leq |I| \leq \lfloor \epsilon n/16 \rceil, \kappa_G^{\mathrm{u}}(I, I^c) \leq \eta_1 |I| |I^c| p \text{ and } \kappa_G^{\mathrm{a}}(I, \mathcal{V}^{\mathrm{a}}(G)) \leq \eta_2 |I| \mathcal{V}^{\mathrm{a}}(G) q) \\ \leq \sum_{l=1}^{\lfloor \epsilon n/16 \rceil} n^{-\epsilon l/8} = O(n^{-\epsilon/8}). \end{split}$$

To complete the proof, we still need show the two lower bounds for η_1 and η_2 . For η_1 , we notice that

$$f(\eta_1) = \frac{\lambda_1 (1 + \epsilon/8) \log n}{(1 - \epsilon/16) np} \le \frac{1 + \epsilon/8}{(1 - \epsilon/16)(1 + \epsilon)} \le f(\epsilon/16).$$
(103)

Because f(x) is monotone decreasing on $x \in (0, 1)$, we know that $\eta_1 \ge \epsilon/16$. Moreover, because $f(x) \ge (1-x)^2/2$ for any $x \in (0, 1)$, it follows that

$$\frac{\lambda_1(1+\epsilon/8)\log n}{(1-\epsilon/16)np} \ge \frac{(1-\eta_1)^2}{2}.$$

This proves that

$$\eta_1 \ge 1 - \sqrt{\frac{2\lambda_1(1+\epsilon/8)\log n}{(1-\epsilon/16)np}}$$

For η_2 , similarly, we have

$$f(\eta_2) = \frac{\lambda_2(1+\epsilon/8)\log n}{mq} \le \frac{1+\epsilon/8}{1+\epsilon} \le f(\epsilon/16),\tag{104}$$

which implies that $\eta_2 \ge \epsilon/16$. Finally, we have

$$\eta_2 \ge 1 - \sqrt{\frac{2\lambda_2(1+\epsilon/8)\log n}{mq}},$$
$$\frac{\lambda_2(1+\epsilon/8)\log n}{\sum (1-\eta_2)^2} \ge \frac{(1-\eta_2)^2}{mq}$$

because

$$\frac{q(1+\epsilon/8)\log n}{mq} \ge \frac{(1-\eta_2)}{2}.$$

Now, we can proceed to prove Proposition 5. We assume without generality that the true permutation π^* is the identity permutation. For a pair of user vertices $i \in \mathcal{V}_1^u$ and $j \in \mathcal{V}_2^u$, let $N^u(i, j)$ denote the number of user vertices $u \in [n]$ such that u is connected to i in G_1 and u is connected to j in G'_2 , and let $N^a(i, j)$ denote the number of attribute vertices $a \in \{a_1, \ldots, a_m\}$ such that a is connected to i in G_1 and a is connected to j in G'_2 . By the definition of Erdős–Rényi graph pair model, we have $N^u(i, j) \sim \operatorname{Binom}(n-2, q_u^2)$ and $N^a(i, j) \sim \operatorname{Binom}(m, q_a^2)$ for any $i \neq j$. By the multiplicative Chernoff bound, we have

$$\mathsf{P}(N^{\mathrm{u}}(i,j) \ge \gamma_2(n-2)q_{\mathrm{u}}^2) \le \exp(-(n-2)q_{\mathrm{u}}^2 f(\gamma_2)) = n^{-3}$$

and

$$\mathsf{P}(N^{\mathrm{a}}(i,j) \ge \gamma_3 m q_{\mathrm{a}}^2) \le \exp(-m q_{\mathrm{a}}^2 f(\gamma_3)) = n^{-3}.$$

By the union bound, for a fixed pair (i, j),

$$\mathsf{P}(N^{\mathrm{u}}(i,j) \ge \gamma_2(n-2)q_{\mathrm{u}}^2 \text{ or } N^{\mathrm{a}}(i,j) \ge \gamma_3 m q_{\mathrm{a}}^2) \le 2n^{-3}.$$

Moreover, by a union bound over all $\binom{n}{2}$ pairs, we have

$$\mathsf{P}(\exists i, j \in [n], i \neq j : N^{\mathrm{u}}(i, j) \ge \gamma_2(n-2)q_{\mathrm{u}}^2 \text{ or } N^{\mathrm{a}}(i, j) \ge \gamma_3 m q_{\mathrm{a}}^2) \le \binom{n}{2} 2n^{-3} \le 2n^{-1}.$$
(105)

Now, we assume that $\{\nexists i, j \in [n], i \neq j : N^{\mathrm{u}}(i, j) \geq \gamma_2(n-2)q_{\mathrm{u}}^2$ or $N^{\mathrm{a}}(i, j) \geq \gamma_3 m q_{\mathrm{a}}^2\}$. By a similar induction as in the proof of Proposition 4, we have that $\tilde{\pi} = \pi^*|_J$ throughout out the process of the algorithm. Therefore, it suffices to show that when the algorithm terminates, we have J = [n]. Towards contradiction, we suppose that the algorithm ends with |J| < n. This suggests that for each $i \in J^c$, $N^{\mathrm{u}}_{\pi}(i,i) < \gamma_2(n-2)q_{\mathrm{u}}^2$ and $N^{\mathrm{a}}(i,i) < \gamma_3 m q_{\mathrm{a}}^2$. These further imply that

$$\kappa^{\mathbf{u}}_{G_1 \cap G_2}(J^c, J) = \sum_{i \in J^c} N^{\mathbf{u}}_{\tilde{\pi}}(i, i) < \gamma_2(n-2)q^2_{\mathbf{u}}|J^c|,$$
(106)

and

$$\kappa_{G_1 \cap G_2}^{\mathbf{a}}(J^c, \mathcal{V}^{\mathbf{a}}(G_1)) = \sum_{i \in J^c} N^{\mathbf{a}}(i, i) < \gamma_3 m q_{\mathbf{a}}^2 |J^c|.$$
(107)

From the attributed Erdős–Rényi graph pair model, it is not hard to see that $G_1 \cap G'_2 \sim \mathcal{G}(n, q_u s_u; m, q_a s_a)$, where $s_u \triangleq q_u + \rho_u(1 - q_u)$ and $s_a \triangleq q_a + \rho_a(1 - q_a)$. By conditions (91), (92) and (93), we know that there exists constants $\lambda_1, \lambda_2, \epsilon$ with $\lambda_1 + \lambda_2 \ge 1$ such that $nq_u s_u \ge \lambda_1(1 + \epsilon) \log n$ and $mq_a s_a \ge \lambda_2(1 + \epsilon) \log n$. Let η_1 denote the unique solution in (0, 1) to $f(\eta_1) = \frac{\lambda_1(1 + \epsilon/8) \log n}{(1 - \epsilon/16)nq_u s_u}$, and η_2 denote the unique solution in (0, 1) to $f(\eta_2) = \frac{\lambda_2(1 + \epsilon/8) \log n}{mq_a s_a}$. By Lemma 6, with probability at least $1 - O(n^{-\epsilon/8})$, we have at least one of

$$\kappa_{G_1 \cap G_2}^{\mathbf{u}}(J^c, J) \ge \eta_1 |J| |J^c| q_{\mathbf{u}} s_{\mathbf{u}} \ge \eta_1 (1 - \epsilon/16) n |J^c| q_{\mathbf{u}} s_{\mathbf{u}},$$

or

$$\kappa_{G_1 \cap G_2}^{\mathbf{a}}(J^c, \mathcal{V}^{\mathbf{a}}(G_1)) \ge \eta_2 |J^c| m q_{\mathbf{a}} s_{\mathbf{a}}.$$

To complete the proof, it suffices to show that

$$\bar{\gamma}_2 \triangleq \eta_1 (1 - \epsilon/16) \frac{s_{\mathrm{u}}}{q_{\mathrm{u}}} \ge \gamma_2, \tag{108}$$

and

$$\bar{\gamma}_3 \triangleq \eta_2 \frac{s_a}{q_a} \ge \gamma_3. \tag{109}$$

We firstly show (108) by considering two different cases.

Case 1: $q_{\rm u} = o(\rho_{\rm u})$: Because $\eta_1 \ge \epsilon/16$, we have

$$\begin{split} \tilde{y}_2 &\geq (1 - \epsilon/16) \frac{\epsilon s_{\mathrm{u}}}{16q_{\mathrm{u}}} \\ &= \frac{\epsilon}{16} (1 - \epsilon/16) \left(1 + \frac{\rho_{\mathrm{u}}(1 - q_{\mathrm{u}})}{q_{\mathrm{u}}} \right) \\ &= \omega(1), \end{split}$$

where the last equality follows because $q_{\rm u} = o(\rho_{\rm u})$. Therefore,

$$f(\bar{\gamma}_2) > \bar{\gamma}_2(\log \bar{\gamma}_2 - 1)$$

= $\omega(\bar{\gamma}_2)$
= $\omega(s_u/q_u),$ (110)

where the penultimate equality follows because $\bar{\gamma}_2 = \omega(1)$ and the last equality follows because $\epsilon = \Theta(1)$. Notice that (110) further implies that $f(\bar{\gamma}_2) > \frac{3\log n}{(n-2)q_u^2} = f(\gamma_2)$ because $\frac{s_u(n-2)q_u}{3\log n} = \Omega(1)$ by condition (92). Therefore, we have $\bar{\gamma}_2 > \gamma_2$.

Case 2: $q_{\rm u} = \Omega(\rho_{\rm u})$: By Lemma 6, we have $\eta_1 \ge 1 - \sqrt{\frac{2(1+\epsilon/8)\log n\lambda_1}{(1-\epsilon/16)nq_{\rm u}s_{\rm u}}}$. Because $nq_{\rm u}s_{\rm u} \ge nq_{\rm u}^2 = \Omega(n\rho_{\rm u}^2) = \omega(\log n)$ by (89), we have $\eta_1 \ge 1 - \epsilon/16$. Hence, we have

$$\begin{split} \bar{\gamma}_2 &\geq (1 - \epsilon/16)^2 \frac{s_{\mathrm{u}}}{q_{\mathrm{u}}} \\ &= (1 - \epsilon/16)^2 \left(1 + \frac{\rho_{\mathrm{u}}(1 - q_{\mathrm{u}})}{q_{\mathrm{u}}} \right) \\ &\geq (1 - \epsilon/16)^2 (1 + \epsilon) \\ &\geq 1 + \frac{\epsilon}{2}, \end{split}$$

where the penultimate inequality follows by assumption (94). Finally, we have

$$f(\bar{\gamma}_2) \ge f(1+\epsilon) \ge \frac{3\log n}{(n-2)q_u^2}$$

where the last inequality follows because $f(1+\epsilon) = \Theta(1)$ and $(n-2)q_u^2 = \Omega(n\rho_u^2) = \omega(\log n)$ by assumption (89).

To show (109), we again consider two cases. C

Case 1:
$$q_a = o(\rho_a)$$
: By Lemma 6, we have $\eta_2 \ge \epsilon/16$. Therefore, we have

$$\bar{\gamma}_3 \ge \frac{\epsilon}{16} \left(1 + \frac{\rho_{\mathrm{a}}(1-q_{\mathrm{a}})}{q_{\mathrm{a}}} \right) = \omega(1),$$

where the last equality follows because $q_{\rm a} = o(\rho_{\rm a})$. It follows that

$$f(\bar{\gamma}_3) > \bar{\gamma}_3(\log \bar{\gamma}_3 - 1) = \omega(\bar{\gamma}_3) = \omega\left(\frac{\epsilon s_{\mathbf{a}}}{16q_{\mathbf{a}}}\right)$$

From here, we conclude that $f(\bar{\gamma}_3) > \frac{3 \log n}{m q_a^2} = f(\gamma_3)$ because $mq_a s_a = \Omega(\log n)$. This completes the proof for $\bar{\gamma}_3 > \gamma_3.$

Case 2: $q_a = \Omega(\rho_a)$: By Lemma 6, we have $\eta_2 \ge 1 - \sqrt{\frac{2\lambda_2(1+\epsilon/8)\log n}{mq_as_a}}$. It follows that $\eta_2 \ge 1 - \epsilon/16$ because $mq_as_a \ge mq_a^2 = \Omega(m\rho_a^2) = \omega(\log n)$. Then by assumption (95), we have

$$\bar{\gamma}_3 \ge (1 - \epsilon/16) \frac{s_{\rm a}}{q_{\rm a}} = (1 - \epsilon/16) \left(1 + \frac{\rho_{\rm a}(1 - q_{\rm a})}{q_{\rm a}} \right) \ge (1 - \epsilon/16)(1 + \epsilon) \ge 1 + \epsilon/2$$

Finally, we have

$$f(\bar{\gamma}_3) \ge f(1+\epsilon/2) > \frac{3\log n}{mq_a^2} = f(\gamma_3),$$

where the penultimate inequality follows because $f(1 + \epsilon/2) = \Omega(1)$ and $mq_a^2 = \Omega(m\rho_a^2) = \omega(\log n)$. This shows that $\bar{\gamma}_3 > \gamma_3$ and completes the proof.

APPENDIX D

COMPARISON TO EXISTING WORKS FOR SEEDED GRAPH ALIGNMENT

In this section, we compare the feasible region of the proposed algorithms to the best-known feasible region under the context of seeded graph alignment. In the seeded Erdős–Rényi graph pair model $\mathcal{G}(N, \alpha, p, s)$ by Mossel and Xu (2020), the graph generation process is described as follows: First, a base graph G is sampled from Erdős–Rényi model $\mathcal{G}(N, p)$. Next, two correlated graphs G_1 and G_2 are produced by independently retaining each edge from G with a probability s. The graph G'_2 is then generated by applying a random permutation Π^* to G_2 . Let \mathcal{V}_1 and \mathcal{V}_2 denote the sets of vertices in G_1 and G'_2 respectively. A subset $\mathcal{V}_s \subset \mathcal{V}_1$ of size $\lfloor N \alpha \rfloor$ is then selected uniformly at random, and the vertex pairs $\mathcal{I}_0 = \{(v, \Pi^*(v)) : v \in \mathcal{V}_s\}$ are identified as the seed set. The graph pair (G_1, G'_2) and the seed set \mathcal{I}_0 are provided, and the goal is to recover the vertex correspondence for all the remaining vertices.

In the attributed Erdős–Rényi graph pair model $\mathcal{G}(n, q_u, \rho_u; m, q_a, \rho_a)$, when we set $q_u = q_a$ and $\rho_u = \rho_a$, the m attributes can be viewed as seeds, and graph pair can be viewed as generated from the seeded Erdős–Rényi graph pair model $\mathcal{G}(n + m, \frac{m}{n+m}, \frac{q_u}{q_u+\rho_u(1-q_u)}, q_u + \rho_u(1-q_u))$ except that the edges between the seeds are removed. Therefore, the feasible region of the proposed algorithms for attributed graph alignment directly implies feasible region for seeded graph alignment. In the following, we compare the feasible region of the proposed algorithms to that of the algorithms by Mossel and Xu (2020), and demonstrate that the implied feasible region covers certain parameter regimes that are unknown from the literature. For simplicity, we denote $N \triangleq n + m$, $\alpha \triangleq \frac{m}{m+n}$, $p \triangleq \frac{q_u}{q_u+\rho_u(1-q_u)}$ and $s \triangleq q_u + \rho_u(1-q_u)$. Firstly, the feasible region by Mossel and Xu (2020) requires a constant correlation $s = \Theta(1)$, while our feasible region includes both cases of s = o(1) and $s = \Theta(1)$. In the rest of the comparison, we consider constant correlation regime $s = \Theta(1)$. In this regime, we demonstrate that the seed fraction α required by the proposed algorithms is strictly smaller in the following two cases:

Case 1: $np = n^c$ for some constant 1/2 < c < 1. In this case, one can check that conditions (1), (3) and (4) in Theorem 1, and conditions (6) and (7) in Theorem 2 are satisfied without any further assumptions. To satisfy condition (2), we need to set $m = \omega(n^{\epsilon})$ for an arbitrarily small ϵ . This is equivalent as $\alpha = \omega(n^{\epsilon-1})$. In contrast, Theorem 4 in Mossel and Xu (2020) requires at least $\alpha = \Omega(\frac{\log n}{n^c})$.

Case 2: $np = n^c$ for some constant 1/3 < c < 1/2. In this case, one can check that conditions (1) and (3) in Theorem 1, and conditions (6) and (7) in Theorem 2 are satisfied without any further assumptions. For conditions (2) and (4), we need to set $m = \omega(n^{1-2c})$. This is equivalent as $\alpha = \omega(n^{-2c})$. In contrast, Theorem 4 in Mossel and Xu (2020) requires at least $\alpha = \Omega(\frac{\log n}{n^{2c}})$.

To provide a fair comparison, we point to that when $np = n^c$ for some c = 1/2 or $c \le 1/3$ or c = o(1), the algorithms by Mossel and Xu (2020) requires strictly less seeds to achieve exact recovery.

APPENDIX E **TIGHTNESS OF PROPOSITIONS 2 AND 3**

The conditions presented in Propositions 2 and 3 are not only sufficient, but also necessary for the variance lower bounds under the assumption that $k = \Theta(1)$. By the definition of Φ_{ij} , we can expand its variance expression as

$$\operatorname{Var}(\Phi_{ij}) = \operatorname{Var}\left(\sum_{\mathcal{A}\subseteq\mathcal{V}^{\mathbf{a}}:|\mathcal{A}|=k} W_{i,\mathcal{A}}(G_1)W_{j,\mathcal{A}}(G'_2)\right)$$
$$= \sum_{\mathcal{A},\mathcal{B}\subseteq\mathcal{V}^{\mathbf{a}}:|\mathcal{A}|=|\mathcal{B}|=k} \sum_{S_1\in\mathcal{G}_{i,\mathcal{A}}} \sum_{S_2\in\mathcal{G}_{i,\mathcal{A}}} \sum_{T_1\in\mathcal{G}_{i,\mathcal{B}}} \sum_{T_2\in\mathcal{G}_{i,\mathcal{B}}} \operatorname{Cov}(\omega_1(S_1)\omega_2(S_2),\omega_1(T_1)\omega_2(T_2)).$$

By considering specific overlapping patterns of the four subgraphs S_1, S_2, T_1, T_2 satisfying the conditions in the summation, we can obtain lower bounds on the variance. For a true pair of matched users, we have

$$\frac{\operatorname{Var}(\Phi_{ii})}{\mathsf{E}[\Phi_{ii}]^2} = \Omega\left(\max\left(\frac{1}{nq_{\mathrm{u}}\rho_{\mathrm{u}}}, \frac{1}{n\rho_{\mathrm{u}}^2}\right) + \frac{1}{m\rho_{\mathrm{u}}^2\rho_{\mathrm{a}}^2} + \max\left(\frac{1}{nq_{\mathrm{u}}\rho_{\mathrm{u}}mq_{\mathrm{a}}\rho_{\mathrm{a}}}, \frac{1}{n\rho_{\mathrm{u}}^2mq_{\mathrm{a}}\rho_{\mathrm{a}}}\right)\right).$$
(111)

To see the first term, consider the overlapping pattern shown in Figure 7a. In this case, we have $S_1 = S_2$, $T_1 = T_2$

and S_1, T_1 overlap at only 1 user-user edge. We can show that

$$Cov(\omega_1(S_1)\omega_2(S_2), \omega_1(T_1)\omega_2(T_2)) = \Omega(\sigma_{u}^{4k}\sigma_{a}^{4k}\rho_{u}^{2k-2}\rho_{a}^{2k}\max(\rho_{u}/q_{u}, 1))$$

and there are in total $\Omega(n^{2k-1}m^{2k})$ copies of (S_1, S_2, T_1, T_2) satisfying this pattern. Together with the first moment expression (15), we have $\frac{\operatorname{Var}(\Phi_{ii})}{\operatorname{E}[\Phi_{ii}]^2} = \Omega\left(\max\left(\frac{1}{nq_u\rho_u}, \frac{1}{n\rho_u^2}\right)\right)$. For the second term in the lower bound, we consider the overlapping pattern shown in Figure 7b. In this case,

we can show that

$$Cov(\omega_1(S_1)\omega_2(S_2), \omega_1(T_1)\omega_2(T_2)) = \Omega(\sigma_{\rm u}^{4k}\sigma_{\rm a}^{4k}\rho_{\rm u}^{2k-2}\rho_{\rm a}^{2k-2})$$

and $\Omega(n^{2k}m^{2k-1})$ copies of (S_1, S_2, T_1, T_2) follow this pattern. This would lead to the lower bound $\frac{\operatorname{Var}(\Phi_{ii})}{\operatorname{E}[\Phi_{ii}]^2} = 0$ $\Omega\left(\frac{1}{m\rho_u^2\rho_a^2}\right)$. The third term in (111) comes from the overlapping pattern shown in Figure 7c. In this case, we can show that

$$\operatorname{Cov}(\omega_{1}(S_{1})\omega_{2}(S_{2}),\omega_{1}(T_{1})\omega_{2}(T_{2})) = \Omega\left(\sigma_{\mathrm{u}}^{4k}\sigma_{\mathrm{a}}^{4k}\rho_{\mathrm{u}}^{2k-2}\rho_{\mathrm{a}}^{2k-2}\frac{\rho_{\mathrm{a}}}{q_{\mathrm{a}}}\max(\rho_{\mathrm{u}}/q_{\mathrm{u}},1)\right)$$

and there are $\Omega(n^{2k-1}m^{2k-1})$ copies of (S_1, S_2, T_1, T_2) following this pattern. With the first moment expression (15), we can get the lower bound $\frac{\operatorname{Var}(\Phi_{ii})}{\mathsf{E}[\Phi_{ii}]^2} = \Omega\left(\max\left(\frac{1}{nq_{\mathrm{u}}\rho_{\mathrm{u}}mq_{\mathrm{a}}\rho_{\mathrm{a}}}, \frac{1}{n\rho_{\mathrm{u}}^2mq_{\mathrm{a}}\rho_{\mathrm{a}}}\right)\right)$.

For a wrong pair of matching (i, j), we can similarly show that

$$\frac{\operatorname{Var}(\Phi_{ij})}{\mathsf{E}[\Phi_{ii}]^2} = \Omega\left(\frac{1}{(m\rho_{\rm u}^2\rho_{\rm a}^2)^k} + \frac{1}{(n\rho_{\rm u}^2)^k} + \frac{1}{(n\rho_{\rm u}^2mq_{\rm a}\rho_{\rm a})^k}\right),\tag{112}$$

where the three terms in the lower bound come from the three overlapping patterns shown in Figure 8 respectively. Note the condition $n^2q_u = \Omega(1)$ in Propositions 3 is not shown to be necessary by (112). However, $n^2q_u = \Omega(1)$ is a mild condition ensuring the existence of at least one user-user edge in graphs G_1 and G'_2 . Moreover, it is implied by condition $nq_u\rho_u = \omega(1)$ in Proposition 2, so it does not affect the overall feasible region of the algorithm.
