Graph Compression with Side Information at the Decoder

Abstract

In this paper, we study the problem of graph compression with side information at the decoder. The focus is on the situation when an unlabelled graph (which is also referred to as a structure) is to be compressed or is available as side information. For correlated Erdős-Rényi weighted random graphs, we give a precise characterization of the smallest rate at which a labelled graph or its structure can be compressed with aid of a correlated labelled graph or its structure at the decoder. We approach this problem by using the entropy-spectrum framework and establish some convergence results for conditional distributions involving structures, which play a key role in the construction of an optimal encoding and decoding scheme. Our proof essentially uses the fact that, in the considered correlated Erdős-Rényi model, the structure retains most of the information about the labelled graph. Furthermore, we consider the case of unweighted graphs and present how the optimal decoding can be done using the notion of graph alignment.

Index Terms

Graph compression, side information, labelled graphs, structures, conditional entropy, graph alignment

I. INTRODUCTION

Today, graph-structured data can be found in numerous contexts. Advancements in data collection methods and applications have led to a huge growth in the amount of graphical data that is generated. Some examples of graphical data include social interaction networks, biological networks, protein-protein interaction networks, and web graphs. Graphical data represents how entities are related to each other

in a pairwise manner. In practice, we often encounter unlabelled graphs along with labelled graphs¹. Where labelled graphs contain, for example, names of individuals along with the data pertaining to them, unlabelled graphs mainly appear in the context of privacy, where graphical data is revealed to the public for scientific purposes with the identities of the nodes hidden. Such anonymized graphs can then be analyzed without knowing the true identities of the nodes, thus ensuring the privacy of the nodes.

Although graphical data is useful for representing interrelations between entities, the size of such data is often enormous, which can make storage and processing difficult. For example, at the time of writing, the number of Facebook users is close to 3 billion. The prevalence of such large graphical data sets spurred interest in the information-theoretic study of graph compression in recent years. Many works, such as [1]–[8], studied the compression of a labelled graph or, alternatively, an unlabelled graph under various assumptions on the underlying random graph model and constraints on compression fidelity. Another scenario that is of importance is the compression of graphs with side information. Here one would like to compress a labelled or an unlabelled graph using a correlated labelled or unlabelled graph. For instance, one could possibly compress a labelled graph at a smaller rate with aid of a publicly available anonymized graph that is correlated with the labelled graph. This motivates us to study the graph compression problem with side information from an information theoretic perspective. The broad question of interest is the following: *what is the minimum achievable compression rate?*

Before undertaking to answer this question, a few issues must be addressed. The first relates to the use of the structure as side information. A natural question would be whether there is any tangible gain in the compression rate when compared to not using any side information. After all, the structure ignores the node label information. We will see later in the paper that most of the information about the random graph that we consider is contained in its structure and it can be fruitfully exploited as side information.

Another issue relates to the location of the side information: encoder and decoder, or only at the decoder. In the situations of compression involving structures, the availability of the side information at only the decoder is the most interesting. For example, if a structure and a correlated graph are present at the encoder, then the correlated graph can be used to recover the labels of the structure, which is usually referred to as *deanyomization*. There are already well-known techniques available for deanonymization [9]–[12]. The resulting deanonymized labelled graph can now be used to compress the correlated labelled graph. However, if the structure is only available at the decoder and there are no means of deanonymizing it, then it must be used without the knowledge of the labels.

The problem of graph compression using a correlated unlabelled graph at the decoder was introduced

and studied recently in [13]. The authors of that work considered correlated unweighted graphs that are generated independently by sampling edges from an underlying Erdős-Rényi graph with a fixed sampling probability. Under this model, an achievable compression rate was derived. The exact characterization of the optimal compression rate was left as an open problem.

A. Summary of Contributions

We consider the general setting of weighted graphs, where the weight (or mark) on an edge represents the degree of association of the nodes connected by that edge. We also consider the correlated Erdős-Rényi model for generating two labelled graphs, from which the respective unlabelled graphs are generated.

Our main result is the precise characterization of the minimum achievable rate of compression of a labelled or an unlabelled (weighted) graph with a labelled or an unlabelled (weighted) graph as side information at the decoder. This general result resolves the open problem of [13]. The main obstacle in the derivation is posed by the structure as it does not lend itself to a simpler analysis. The main feature of independence across edges in an Erdős-Rényi labelled random graph is no longer useful in dealing with the structure as multiple labelled graphs correspond to a single structure.

In order to deal with structures, we take the entropy-spectrum approach of [14]. Roughly speaking, in this approach, the convergence properties of the normalized negative logarithm of the probability distribution of a general source are used to identify the compression rate. In the paper, we prove a convergence result related to the conditional probability distribution involving structures. To prove this result, we first argue that the maximum of $P_{G_a,G_b}(G_a,\pi(G_b))$ over all permutations π of vertex labels of G_b is close in some sense to $P_{G_a,G_b}(G_a,G_b)$ for correlated Erdős-Rényi random graphs G_a and G_b . Then, we combine this with the fact that not many labelings are possible for a structure compared to the number of possible labelled graphs; there are at most n! distinct labelings of a graph, where n is the number of vertices, while there are $2^{\binom{n}{2}}$ labelled graphs.

The convergence result on the conditional probability distribution allows us to construct an encoding and decoding scheme for graph compression with side information at the decoder. It turns out that the rate achieved by this scheme is optimal. Finally, in the special case of unweighted graphs, we give a way to describe the optimal decoder using the notion of graph alignment.

B. Notation

For $k \in \mathbb{N}$, we use the notation [k] to denote the set $\{1, \ldots, k\}$. Throughout the paper, log stands for the base-2 logarithm. The set of all permutations defined over [n] is denoted by S_n . In this paper, we use uppercase letters for random variables (e.g., A, B, G, S, and U) and lowercase letters for their realizations (e.g., a, b, g, s, and u). Given a random variable X taking values in a finite set \mathcal{X} with probability distribution P_X , the random variable $P_X(X)$ represents the evaluation of the function $P_X(\cdot)$ at a random point X. The cardinality of a finite set \mathcal{X} is written as $|\mathcal{X}|$. A sequence of random variables $\{X_n\}_{n\geq 1}$ is said to *converge to* X *in probability* as $n \to \infty$ if $\mathbb{P}(|X_n - X| > \delta) \to 0$ as $n \to \infty$ for any $\delta > 0$.

C. Organization

The rest of the paper is organized as follows. In Section II, we give the necessary preliminaries and then formally introduce the problem of graph compression with side information for correlated Erdős-Rényi random graphs. Section III contains the main results related to the minimum achievable compression rate for the general case of weighted graphs. In Section IV, we address the unweighted graph case and present the decoding scheme in terms of the graph alignment concept. We finally give a discussion of potential extensions in Section V.

II. GRAPH COMPRESSION WITH SIDE INFORMATION

A. Preliminaries

Let G = (V, E, w) be a (weighted) graph with the vertex set V = [n] containing n vertices, the edge set E, and the edge-weight function $w : E \to [k]$. The weight w(e) of an edge e connecting two vertices $i, j \in V$ may indicate the strength of the connection between i and j. The weights of the edges are sometimes referred to as marks of the edges. We restrict our attention to simple and undirected weighted graphs. It is often useful to think of a graph in terms of its adjacency matrix representation. The entries of the adjacency matrix $\mathbf{A} = (a_{i,j})_{i,j \in [n]}$ of a graph are defined as $a_{i,j} = 0$ if there is no edge between vertices i and j, and $a_{i,j} = w(e)$ if $e \in E$ is the edge between vertices i and j. As the graphs are simple and undirected, the adjacency matrix is symmetric and the entries $(a_{i,j} : 1 \le i < j \le n)$ completely specify the graph G. Using this equivalence, it is customary to represent a graph by a string of $\binom{n}{2}$ symbols over the alphabet $\{0, 1, \ldots, k\}$. In the case of random graphs, a probability distribution of graphs P_G uniquely specifies a joint distribution for $(a_{i,j} : 1 \le i < j \le n)$, and vice versa.

A graph operation that is mainly used later in this paper is the permutation of the vertex labels. Let $\pi : [n] \to [n]$ be a permutation map of the vertex labels. We use the notation $\pi(G)$ to denote the graph obtained after applying π to the vertex labels of G. If $a_{i,j}^{\pi}$ and $a_{i,j}$ are the (i, j)th entries of the adjacency matrices of $\pi(G)$ and G, respectively, then $a_{i,j}^{\pi} = a_{\pi^{-1}(i),\pi^{-1}(j)}$.

A structure (or an unlabelled graph) S of a weighted graph G is obtained by removing the vertex labels of the graph. Precisely speaking, a structure S of a graph G is the set of (weighted) graphs isomorphic to

G. This set contains all the distinct graphs that are obtained by permuting the vertex labels of G. Thus, the probability distribution P_S of structures induced by a probability distribution P_G of graphs is given by

$$P_S(s) = \sum_{g \cong s} P_G(g), \tag{1}$$

where we use the notation $G \cong S$ to mean that the graph G has the structure S. It is well-known [1] that the number of distinct graphs having a structure S is $\frac{n!}{|\operatorname{Aut}(S)|}$, where $\operatorname{Aut}(S)$ denotes the automorphism group $\operatorname{Aut}(G)$ of a graph G with the structure S. The automorphism group of G contains all the permutations of vertex labels which when applied leaves G unchanged.

In the context of graph anonymization, the structure of a graph is revealed after removing the vertex labels of the graph. See Fig. 1 for a toy example. Another equivalent way of anonymizing a graph is by applying a uniform random permutation Π to a graph G and revealing $\Pi(G)$ publicly. These two methods are equivalent because S can be obtained by removing the vertex labels of $\Pi(G)$, and $\Pi(G)$ can be obtained by randomly assigning a labelling to S. From the point of view of privacy, both these representations carry equal amounts of information about the original vertex labels. So, we will work with structures in this paper.

B. Correlated Erdős-Rényi (CER) Random Graphs

A fundamental random graph model that is commonly used [9], [12] in the study of correlated graphs is the *Correlated Erdős-Rényi (CER)* model. Let G_a and G_b be a pair of correlated weighted graphs with the same vertex set [n]. Assume that $[k_a]$ and $[k_b]$ are the sets from which the weight functions w_a and w_b of graphs G_a and G_b take values, respectively. Let $\mathbf{A} = (a_{i,j})$ and $\mathbf{B} = (b_{i,j})$ be the adjacency

matrices of G_a and G_b , respectively. Given a joint distribution $P_{A,B}$ on $\{0, 1, \ldots, k_a\} \times \{0, 1, \ldots, k_b\}$, the joint distribution of graphs (G_a, G_b) under the CER model is given by

$$P_{G_a,G_b}(g_a,g_b) \triangleq \prod_{i < j} P_{A,B}(a_{i,j},b_{i,j}).$$

In this model, the way in which two vertices i and j are connected in G_a is correlated with how they are connected in G_b , and the connections are independent across the vertex pairs in both G_a and G_b .

We denote by S_a and S_b the structures of the graphs G_a and G_b , respectively. As structures are functions of labelled graphs, the CER model induces the joint distribution $P_{G_a,G_b,S_a,S_b}(g_a,g_b,s_a,s_b) = P_{G_a,G_b}(g_a,g_b)\mathbb{1}(g_a \cong s_a)\mathbb{1}(g_b \cong s_b).$

C. Problem Formulation

In this section, we formulate the problem of graph compression with side information at the decoder for the CER model. We will consider the compression of a labelled graph G_a or an unlabelled graph S_a with the correlated side information G_b or S_b at the decoder. We use the notation U_a to denote the random object that will be compressed, and the notation U_b to denote the correlated side information at the decoder. In our case, U_a will be either G_a or S_a , and U_b will be either G_b or S_b .

Let us formally define the graph compression problem with side information at the decoder. Suppose that we are given (U_a, U_b) with joint distribution P_{U_a, U_b} . Here, the number of vertices in U_a and U_b is n. Though we omitted it in the notation, the random objects implicitly depend on n. Our goal is to determine the minimum compression rate possible for encoding U_a with side information U_b at the decoder. An *encoder* ϕ_n operating at a rate $R \ge 0$ is a deterministic function whose input is U_a and whose output is a message $M_n \in [2^{\binom{n}{2}R}]$, i.e., $M_n = \phi_n(U_a)$. A *decoder* ψ_n is a deterministic function that takes a message $M_n \in [2^{\binom{n}{2}R}]$ and U_b as inputs, and produces a graph \hat{U}_a as the output, i.e., $\hat{U}_a = \psi_n(M_n, U_b)$. We say that R is an *achievable compression rate* if there exists a sequence of encoder and decoder pairs $\{(\phi_n, \psi_n)\}_{n\ge 1}$ such that

$$\mathbb{P}\left(\hat{U}_a \neq U_a\right) = \mathbb{P}\left(\psi_n(\phi_n(U_a), U_b) \neq U_a\right) \to 0$$
(3)

as $n \to \infty$. The minimum achievable compression rate R^* is defined as

$$R^* \triangleq \inf\{R : R \text{ is an achievable compression rate}\}.$$
 (4)

This model is illustrated in Fig. 2.



Fig. 2: Graph compression with side information at the decoder. The graphs (G_a, G_b) are correlated Erdős-Rényi graphs, and (S_a, S_b) are the respective structures. U_a can be G_a or S_a , and U_b can be G_b or S_b . The encoder compresses U_a into a message M_n of rate R. Using the correlated side information U_b , the decoder tries to recover U_a .

III. MINIMUM COMPRESSION RATE

A. A Candidate for R^*

If we would like to compress the labelled graph $U_a = G_a$ with the side information $U_b = G_b$ at the decoder, then we can consider the entries of the respective adjacency matrices $(A_{i,j} : 1 \le i < j \le n)$ and $(B_{i,j} : 1 \le i < j \le n)$, where the pairs $(A_{i,j}, B_{i,j})$ are i.i.d. with distribution $P_{A,B}$. These are correlated strings of length $\binom{n}{2}$ with independence across the symbols. We can now use the classical source coding with side information result [15] for memoryless sources to conclude that the minimum achievable compression rate is

$$R^* = H(A|B),$$

which is equal to $\lim_{n\to\infty}\frac{1}{\binom{n}{2}}H(G_a|G_b)$.

On the other hand, if either of U_a and U_b is a structure, then we can no longer exploit the independence. Nevertheless, it is natural to expect that the minimum achievable compression rate should be

$$\lim_{n \to \infty} \frac{1}{\binom{n}{2}} H(U_a | U_b) \tag{5}$$

assuming that the limit exists. In the next section, we give a characterization of this limit.

B. Characterization of the Limit in (5)

Before we proceed to characterize the limit in (5), we make a note of a few facts about the entropy [1] of an Erdős-Rényi (ER) random graph G and its structure S. It is intuitively clear that most of the randomness in a graph must come from its structure as it retains the information about $\binom{n}{2}$ connections, while ignoring the information about n vertex labels. The following expressions precisely quantify this intuition. If P_A stands for the probability distribution of an entry of the adjacency matrix under the ER

model, then

$$H(G) = \binom{n}{2} H(A) \quad \text{and} \tag{6}$$

$$H(S) = \binom{n}{2} H(A) - n \log n + \mathcal{O}(n).$$
⁽⁷⁾

The structural entropy (7) of weighted graphs can easily be obtained by essentially following the arguments of [1] used in the case of unweighted graphs. The key result used in [1] to compute the structural entropy is that $|\operatorname{Aut}(G)|$ of an Erdős-Rényi graph is 1 (i.e, G is asymmetric) with probability going to 1 as $n \to \infty$.

Lemma 1. Let (G_a, G_b) be correlated Erdős-Rényi random graphs specified by the distribution $P_{A,B}$. Let S_a and S_b be the respective structures of G_a and G_b . Then

$$\lim_{n \to \infty} \frac{1}{\binom{n}{2}} H(G_a|S_b) = H(A|B)$$
(8)

Moreover,

$$\lim_{n \to \infty} \frac{1}{\binom{n}{2}} H(G_a|G_b) = \lim_{n \to \infty} \frac{1}{\binom{n}{2}} H(S_a|G_b) = \lim_{n \to \infty} \frac{1}{\binom{n}{2}} H(S_a|S_b) = H(A|B).$$

Proof. Consider the relation $H(G_a|G_b) = H(G_a|G_b, S_b) = H(G_a|S_b) - I(G_a;G_b|S_b)$, and use the inequality $0 \le I(G_a;G_b|S_b) \le H(G_b|S_b)$ to get

$$H(G_{a}|G_{b}) \le H(G_{a}|S_{b}) \le H(G_{a}|G_{b}) + H(G_{b}|S_{b}).$$
(9)

Since the structure S_b is a function of the graph G_b , we have

$$H(G_b|S_b) = H(G_b) - H(S_b) = \binom{n}{2}H(B) - \left[\binom{n}{2}H(B) - n\log n + \mathcal{O}(n)\right]$$
$$= n\log n - \mathcal{O}(n), \tag{10}$$

where, in the second equality, we used (6) and (7). Because of the independence across the edges in the Erdős-Rényi model, $H(G_a|G_b) = \sum_{i < j} H(A_{i,j}|B_{i,j}) = {n \choose 2} H(A|B)$. Thus, the inequalities in (9) become

$$\binom{n}{2}H(A|B) \le H(G_a|S_b) \le \binom{n}{2}H(A|B) + n\log n - O(n),$$

which readily yields the limit (8) as $\frac{n \log n}{\binom{n}{2}} \to 0$.

$$\begin{split} H(G_a|G_b) - H(G_a|S_a) &\leq H(S_a|G_b) \leq H(G_a|G_b) \quad \text{ and} \\ H(S_a|G_b) &\leq H(S_a|S_b) \leq H(G_a|S_b). \end{split}$$

The work of [13] considered the graph compression problem in the case when (G_a, G_b) are independently sampled from an underlying Erdős-Rényi unweighted graph G with parameter p. In particular, G_a (or G_b) is obtained by sampling each edge in G with probability γ . This is an instance of the correlated Erdős-Rényi model with the distribution

$$P_{A,B}(0,0) = (1-p) + p(1-\gamma)^2$$
$$P_{A,B}(0,1) = p\gamma(1-\gamma)$$
$$P_{A,B}(1,0) = p\gamma(1-\gamma)$$
$$P_{A,B}(1,1) = p\gamma^2.$$

It was shown in [13] that

$$R^* \le H(A) - \delta = h_2(p\gamma) - \delta, \tag{11}$$

where $\delta = 2 \frac{s^2 \sigma^2}{(s+2)^2}$ with $\sigma^2 = (p\gamma)^2 (1 - (p\gamma)^2)$ and $s = \min\left\{1, \frac{1-\epsilon-p}{(1-\epsilon+p)(1-(p\gamma)^2)}\right\}$ for a constant $0 < \epsilon < 1-p$. On the other hand,

$$H(A|B) = p\gamma h_2(\gamma) + (1 - p\gamma)h_2\left(\frac{p\gamma(1 - \gamma)}{1 - p\gamma}\right),$$

which is believed to be the minimum achievable compression rate R^* . It can be easily seen that $H(A) - \delta$ is strictly larger than H(A|B) for certain parameters; for instance, by setting p = 1/2 and $\gamma = 1$, we see that H(A|B) = 0 and $H(A) - \delta = 1 - \frac{3}{8} \left(\frac{s}{s+2}\right)^2 > 0$.

C. Main Results

In order to prove our main result on what is the minimum achievable compression rate in the graph compression problem, we need the following auxiliary results. The first result is concerned with the asymptotic behavior of the maximum of $P_{G_a,G_b}(G_a,\pi(G_b))$ over all permutations π of vertex labels under the CER model. We know that if π is the identity permutation, then by the weak law of large numbers,

$$\frac{1}{\binom{n}{2}}\log\frac{1}{P_{G_a,G_b}(G_a,G_b)} = \frac{1}{\binom{n}{2}}\sum_{i< j}\log\frac{1}{P_{A,B}(A_{i,j},B_{i,j})} \longrightarrow H(A,B)$$
(12)

in probability, as $n \to \infty$. The following theorem shows that

$$\frac{1}{\binom{n}{2}}\log\frac{1}{\displaystyle\max_{\pi\in\mathcal{S}_n}P_{{}^{G_a,G_b}}(G_{\scriptscriptstyle a},\pi(G_{\scriptscriptstyle b}))}$$

and

$$\frac{1}{\binom{n}{2}}\log\frac{1}{\max_{\pi_a,\pi_b\in\mathcal{S}_n}P_{G_a,G_b}(\pi_a(G_a),\pi_b(G_b))}$$

also converge to the same limit H(A, B), which means that the random variables $\max_{\pi \in S_n} P_{G_a, G_b}(G_a, \pi(G_b))$, $\max_{\pi_a, \pi_b \in S_n} P_{G_a, G_b}(\pi_a(G_a), \pi_b(G_b))$ and $P_{G_a, G_b}(G_a, G_b)$ are close by in the above sense.

Theorem 1. For a pair of correlated Erdős-Rényi random graphs (G_a, G_b) ,

$$\frac{1}{\binom{n}{2}} \log \frac{1}{\max_{\pi \in \mathcal{S}_n} P_{G_a, G_b}(G_a, \pi(G_b))} \longrightarrow H(A, B)$$
(13)

and

$$\frac{1}{\binom{n}{2}} \log \frac{1}{\max_{\pi_a, \pi_b \in \mathcal{S}_n} P_{G_a, G_b}(\pi_a(G_a), \pi_b(G_b))} \longrightarrow H(A, B)$$
(14)

in probability and almost surely as $n \to \infty$.

Proof. We will first prove (13). Fix an integer $n \ge 1$ and a permutation $\pi \in S_n$ of the vertex labels. For a fixed $\delta > 0$, let \mathcal{A}_{π} be the event that $P_{G_a,G_b}(G_a,\pi(G_b)) > 2^{\binom{n}{2}\delta}P_{G_a,G_b}(G_a,G_b)$. It follows that

$$\mathbb{P}(\mathcal{A}_{\pi}) = \sum_{g_a, g_b} P_{G_a, G_b}(g_a, g_b) \mathbb{1}_{\mathcal{A}_{\pi}}$$
$$< 2^{-\binom{n}{2}\delta} \sum_{g_a, g_b} P_{G_a, G_b}(g_a, \pi(g_b)),$$

where the last inequality uses the definition of the event \mathcal{A}_{π} and the fact that $0 \leq 2^{-\binom{n}{2}\delta} P_{G_{a,G_{b}}}(g_{a},\pi(g_{b}))$ on \mathcal{A}_{π}^{c} . Since the map $g_{b} \mapsto \pi(g_{b})$ is a bijective function, we have

$$\sum_{g_a,g_b} P_{G_a,G_b}(g_a,\pi(g_b)) = \sum_{g_a,\pi^{-1}(g_b)} P_{G_a,G_b}(g_a,g_b) = 1,$$

and therefore,

$$\mathbb{P}\left(\mathcal{A}_{\pi}\right) < 2^{-\binom{n}{2}\delta}.$$
(15)

Let \mathcal{A} be the event that $\max_{\pi \in S_n} P_{G_a,G_b}(G_a,\pi(G_b)) > 2^{\binom{n}{2}\delta}P_{G_a,G_b}(G_a,G_b)$, which is $\bigcup_{\pi \in S_n} \mathcal{A}_{\pi}$. Then by the union bound, $\mathbb{P}(\mathcal{A}) \leq \sum_{\pi \in S_n} \mathbb{P}(\mathcal{A}_{\pi})$. By using (15) and the fact that there are only n! permutations, we obtain

$$\mathbb{P}(\mathcal{A}) < n! \cdot 2^{-\binom{n}{2}\delta} \le 2^{n\log n} \cdot 2^{-\binom{n}{2}\delta}.$$
(16)

Let \mathcal{B} be the event

.

$$\left|\frac{1}{\binom{n}{2}}\log\frac{1}{\max_{\pi\in\mathcal{S}_n}P_{G_a,G_b}(G_a,\pi(G_b))}-H(A,B)\right|>2\delta,$$

and \mathcal{B}' be the event

$$\left|\frac{1}{\binom{n}{2}}\log\frac{1}{P_{G_a,G_b}(G_a,G_b)} - H(A,B)\right| > \delta.$$

Since $P_{G_a,G_b}(G_a,G_b) \leq \max_{\pi \in S_n} P_{G_a,G_b}(G_a,\pi(G_b)) \leq 2^{\binom{n}{2}\delta} P_{G_a,G_b}(G_a,G_b)$ on \mathcal{A}^c , it can be easily verified that $\mathcal{B} \cap \mathcal{A}^c \subseteq \mathcal{B}' \cap \mathcal{A}^c$. This implies that

$$\mathbb{P}\left(\mathcal{B}\cap\mathcal{A}^{c}\right) \leq \mathbb{P}\left(\mathcal{B}'\cap\mathcal{A}^{c}\right) \leq \mathbb{P}\left(\left|\frac{1}{\binom{n}{2}}\log\frac{1}{P_{G_{a},G_{b}}(G_{a},G_{b})} - H(A,B)\right| > \delta\right) \\ \leq 2^{-\frac{2\delta^{2}\binom{n}{2}}{(\log C)^{2}}},$$
(17)

where *C* is the smallest non-zero value of the joint distribution $P_{A,B}$, and the last inequality follows by applying Hoeffding's inequality [16, Theorem 2.8] to the sum $\frac{1}{\binom{n}{2}}\sum_{i<j}\log\frac{1}{P_{A,B}(A_{i,j},B_{i,j})}$ consisting of i.i.d random variables with $\log\frac{1}{P_{A,B}(A_{i,j},B_{i,j})} \in [0,\log\frac{1}{C}]$ with probability 1. Therefore, by combining (16) and (17), we obtain

$$\mathbb{P}\left(\mathcal{B}\right) \le \mathbb{P}\left(\mathcal{A}\right) + \mathbb{P}\left(\mathcal{B} \cap \mathcal{A}^{c}\right) \le 2^{-\left[\binom{n}{2}\delta - n\log n\right]} + 2^{-\frac{2\delta^{2}\binom{n}{2}}{(\log C)^{2}}},\tag{18}$$

proving the convergence of (13) in probability. As the bound in (18) is summable, the Borel-Cantelli lemma implies the almost sure convergence of (13).

For the proof of (14), observe that

$$\max_{\pi_a,\pi_b\in\mathcal{S}_n} P_{_{G_a,G_b}}(\pi_a(G_a),\pi_b(G_b)) = \max_{\pi\in\mathcal{S}_n} P_{_{G_a,G_b}}(G_a,\pi(G_b)).$$

This is simply because for $\pi_a, \pi_b \in S_n$,

$$P_{G_{a,G_{b}}}(\pi_{a}(G_{a}),\pi_{b}(G_{b})) = \prod_{i < j} P_{A,B}(A_{\pi_{a}^{-1}(i),\pi_{a}^{-1}(j)},B_{\pi_{b}^{-1}(i),\pi_{b}^{-1}(j)})$$

$$= \prod_{i' < j'} P_{A,B}(A_{i',j'},B_{\pi_{b}^{-1}\circ\pi_{a}(i'),\pi_{b}^{-1}\circ\pi_{a}(j')})$$

$$= P_{G_{a,G_{b}}}(G_{a},\pi_{a}^{-1}\circ\pi_{b}(G_{b})),$$
(19)

where the equality (19) uses the symmetry of the adjacency matrices.

The above result will be helpful in handling the probabilities involving structures. The next theorem, which concerns the asymptotic behaviour of the conditional probabilities involving structures, is a key ingredient in showing that H(A|B) is indeed the minimum achievable compression rate R^* .

Theorem 2. Let (G_a, G_b) be a pair of correlated Erdős-Rényi random graphs. Let S_a and S_b be the structures of the graphs G_a and G_b , respectively. Then,

$$\frac{1}{\binom{n}{2}}\log\frac{1}{P_{G_a|S_b}(G_a|S_b)} \longrightarrow H(A|B)$$
⁽²⁰⁾

in probability as $n \to \infty$. In addition, the random variables $\frac{1}{\binom{n}{2}} \log \frac{1}{P_{G_a|G_b}(G_a|G_b)}, \frac{1}{\binom{n}{2}} \log \frac{1}{P_{S_a|G_b}(S_a|G_b)}$ and $\frac{1}{\binom{n}{2}} \log \frac{1}{P_{S_a|S_b}(S_a|S_b)}$ also converge in probability to H(A|B).

Proof. We will first show that (20) holds. Since the random structure S_b is a function of the random graph G_b , and the probability of a structure is equal to the sum of the probabilities of distinct graphs having that structure, the following relations hold with probability (w.p.) 1:

$$\begin{split} P_{\scriptscriptstyle S_b}(S_{\scriptscriptstyle b}) &= \frac{1}{|\operatorname{Aut}(G_{\scriptscriptstyle b})|} \sum_{\pi \in \mathcal{S}_n} P_{\scriptscriptstyle G_b}(\pi(G_{\scriptscriptstyle b})) \quad \text{and} \\ P_{\scriptscriptstyle G_a,S_b}(G_{\scriptscriptstyle a},S_{\scriptscriptstyle b}) &= \frac{1}{|\operatorname{Aut}(G_{\scriptscriptstyle b})|} \sum_{\pi \in \mathcal{S}_n} P_{\scriptscriptstyle G_a,G_b}(G_{\scriptscriptstyle a},\pi(G_{\scriptscriptstyle b})). \end{split}$$

In the above expressions, the summations are over the set of all permutations of n vertex labels. So, a distinct graph may appear multiple times in the summations. In particular, the number of terms in each summation corresponding to a distinct graph is exactly $|\operatorname{Aut}(G_b)|$ number of distinct permutations. However, the prefactor $\frac{1}{|\operatorname{Aut}(G_b)|}$ nullifies this overcounting in the summations to get the desired probability. Using the above expressions, the conditional probability distribution function can be expressed as

$$P_{G_{a}|S_{b}}(G_{a}|S_{b}) = \frac{P_{G_{a},S_{b}}(G_{a},S_{b})}{P_{S_{b}}(S_{b})}$$

$$= \frac{\frac{1}{|\operatorname{Aut}(G_{b})|}\sum_{\pi \in \mathcal{S}_{n}} P_{G_{a},G_{b}}(G_{a},\pi(G_{b}))}{\frac{1}{|\operatorname{Aut}(G_{b})|}\sum_{\pi \in \mathcal{S}_{n}} P_{G_{b}}(\pi(G_{b}))}$$

$$= \frac{\sum_{\pi \in \mathcal{S}_{n}} P_{G_{a},G_{b}}(G_{a},\pi(G_{b}))}{\sum_{\pi \in \mathcal{S}_{n}} P_{G_{b}}(\pi(G_{b}))}, \qquad (21)$$

which holds w.p. 1. Thus

$$\frac{1}{\binom{n}{2}}\log\frac{1}{P_{_{G_a|S_b}}(G_a|S_b)} = \frac{1}{\binom{n}{2}}\log\frac{1}{\sum\limits_{\pi\in\mathcal{S}_n}P_{_{G_a,G_b}}(G_a,\pi(G_b))} - \frac{1}{\binom{n}{2}}\log\frac{1}{\sum\limits_{\pi\in\mathcal{S}_n}P_{_{G_b}}(\pi(G_b))}.$$

If we can show that the first term on the right-hand side of (22) converges in probability to H(A, B), and the second term converges in probability to H(B), then by the linearity of convergence in probability, we will have the result (20).

Consider the second term on the right-hand side of (22). As the probability

$$P_{G_b}(\pi(G_b)) = \prod_{i < j} P_B(B_{\pi^{-1}(i), \pi^{-1}(j)}) = \prod_{i' < j'} P_B(B_{i', j'})$$

is invariant under any permutation π , $\sum_{\pi \in S_n} P_{G_b}(\pi(G_b)) = n! P_{G_b}(G_b)$. Hence, by noting that $\frac{\log n!}{\binom{n}{2}} \to 0$ and by applying the weak law of large numbers, we have

$$\frac{1}{\binom{n}{2}} \log \frac{1}{n! P_{G_b}(G_b)} = \frac{1}{\binom{n}{2}} \log \frac{1}{P_{G_b}(G_b)} - \frac{\log n!}{\binom{n}{2}} \\ = \frac{1}{\binom{n}{2}} \sum_{i < j} \log \frac{1}{P_B(B_{i,j})} - \frac{\log n!}{\binom{n}{2}} \\ \longrightarrow H(B)$$
(22)

in probability, as $n \to \infty$.

Let us now argue the convergence of the first term on the right-hand side of (22) to H(A, B). As

$$\log \frac{1}{n! \max_{\pi \in \mathcal{S}_n} P_{G_a, G_b}(G_a, \pi(G_b))} \leq \log \frac{1}{\sum_{\pi \in \mathcal{S}_n} P_{G_a, G_b}(G_a, \pi(G_b))} \leq \log \frac{1}{\max_{\pi \in \mathcal{S}_n} P_{G_a, G_b}(G_a, \pi(G_b))},$$

and $\frac{\log n!}{\binom{n}{2}} \to 0$, the desired convergence of the first term on the right-hand side of (22) is equivalent to

$$\frac{1}{\binom{n}{2}} \log \frac{1}{\max_{\pi \in \mathcal{S}_n} P_{G_a, G_b}(G_a, \pi(G_b))} \longrightarrow H(A, B)$$
(23)

in probability, which is guaranteed by Theorem 1. This completes the proof of (20).

We know that by the independence across edges and the weak law of large numbers, $\frac{1}{\binom{n}{2}} \log \frac{1}{P_{G_a,G_b}(G_a|G_b)}$ converges in probability to H(A|B) as $n \to \infty$. The rest of the theorem can be proved analogously by noting that

$$\begin{split} P_{S_{a}|G_{b}}(S_{a}|G_{b}) &= \frac{\sum\limits_{\pi \in \mathcal{S}_{n}} P_{G_{a},G_{b}}(\pi(G_{a}),G_{b})}{|\operatorname{Aut}(G_{a})|P_{G_{b}}(G_{b})}, \\ P_{S_{a}|S_{b}}(S_{a}|S_{b}) &= \frac{\sum\limits_{\pi a,\pi b \in \mathcal{S}_{n}} P_{G_{a},G_{b}}(\pi_{a}(G_{a}),\pi_{b}(G_{b}))}{|\operatorname{Aut}(G_{a})|\sum\limits_{\pi \in \mathcal{S}_{n}} P_{G_{b}}(\pi(G_{b}))}, \end{split}$$

w.p. 1 and $1 \leq |\operatorname{Aut}(G_a)| \leq n!$, and by applying Theorem 2 appropriately.

We are now ready to state our main result for compression of U_a , which is G_a or S_a , with U_b , which is G_b or S_b , as side information to the decoder.

Theorem 3. The minimum achievable compression rate is

$$R^* = H(A|B).$$

Proof. Converse part: Consider any sequence of encoding and decoding schemes $\{(\phi_n, \psi_n)\}_{n=1}^{\infty}$ such that $M_n = \phi_n(U_a) \in \left[2^{\binom{n}{2}R}\right]$ is the message and $\hat{U}_a = \psi_n(M_n, U_b)$ is the recovered graph with the probability of error going to zero, i.e.,

$$\epsilon_n \triangleq \mathbb{P}\left\{ \hat{U}_{\scriptscriptstyle a} \neq U_{\scriptscriptstyle a}
ight\}
ightarrow 0.$$

By Fano's inequality, we have $H(U_a|M_n, U_b) \leq H(U_a|\hat{U}_a) \leq h_2(\epsilon_n) + \epsilon_n \log 2^{\binom{n}{2}} \leq 1 + \binom{n}{2}\epsilon_n$, where $h_2(x) := -x \log x - (1-x) \log(1-x), x \in [0,1]$, with the convention that $0 \log 0 := 0$. The rate R can be bounded from below as follows:

$$\binom{n}{2}R = \log |\mathcal{M}_n| \ge H(M_n)$$
$$\ge H(M_n|U_b)$$
$$\stackrel{(a)}{=} I(M_n; U_a|U_b)$$

$$= H(U_a|U_b) - H(U_a|M_n, U_b)$$

$$\stackrel{(b)}{\geq} H(U_a|U_b) - 1 - \binom{n}{2}\epsilon_n,$$

where (a) uses the fact that M_n is a function of U_a , and (b) is a consequence of Fano's inequality. By letting n approach infinity, we get

$$R \ge \lim_{n \to \infty} \frac{1}{\binom{n}{2}} H(U_a | U_b).$$
(24)

We know from Lemma 1 that when U_a is G_a or S_a , and U_b is G_b or S_b , $\lim_{n\to\infty} \frac{1}{\binom{n}{2}} H(U_a|U_b) = H(A|B)$. As (24) holds for any achievable rate R, we have the converse result

$$R^* \ge H(A|B). \tag{25}$$

Achievability part: Let us now show that any rate arbitrarily close to H(A|B) is achievable, which implies $R^* \leq H(A|B)$. We use the standard random binning approach to show the existence of an encoding and decoding scheme with the desired performance. Generate a codebook by assigning each realization $u_a \in [2^{\binom{n}{2}}]$ to an index $\Phi_n(u_a) \in [2^{\binom{n}{2}R}]$ chosen uniformly at random. Assume that the codebook chosen in this fashion is made available to the decoder as well. Fix a $\delta > 0$, and let

$$\mathcal{T}_{n}(\delta) \triangleq \left\{ \left(u_{a}, u_{b}\right) : \left| \frac{1}{\binom{n}{2}} \log \frac{1}{P_{U_{a}|U_{b}}(u_{a}|u_{b})} - H(A|B) \right| \le \delta \right\}.$$
(26)

Upon seeing U_a , the encoder outputs the corresponding index $\Phi_n(U_a)$. Given an index $I \in [2^{\binom{n}{2}R}]$ and side information U_b , the decoder looks for a unique \hat{u}_a such that $I = \Phi_n(\hat{u}_a)$ and $(\hat{u}_a, U_b) \in \mathcal{T}_n(\delta)$.

We will now argue that if $R = H(A|B) + 2\delta$, then the probability of decoding error averaged over all random codebooks $\bar{\epsilon}_n \triangleq \mathbb{P}(\hat{U}_a \neq U_a)$ goes to zero; this will then imply the existence of a codebook with the probability of decoding error $\epsilon_n \to 0$. For the encoding and decoding schemes we considered, it is well-known [14, Lemma 7.2.1.] that

$$\bar{\epsilon}_n \le \mathbb{P}(\mathcal{T}_n^c(\delta)) + 2^{-\binom{n}{2}\delta}.$$
(27)

For the sake of completeness, we will give its proof here. Define the error events $\mathcal{E}_1 := \{(U_a, U_b) \notin \mathcal{T}_n(\delta)\}$ and $\mathcal{E}_2 := \{\exists \ \hat{u}_a \neq U_a \text{ s.t. } \Phi_n(\hat{u}_a) = \Phi_n(U_a), (\hat{u}_a, U_b) \in \mathcal{T}_n(\delta)\}$, where Φ_n is a random function. For a decoding error, one of the error events must occur. Therefore, by the union bound, we have

$$\bar{\epsilon}_n \leq \mathbb{P}(\mathcal{E}_1) + \mathbb{P}(\mathcal{E}_2) = \mathbb{P}(\mathcal{T}_n^c(\delta)) + \mathbb{P}(\mathcal{E}_2).$$

It is enough to show that $\mathbb{P}(\mathcal{E}_2) \leq 2^{-\binom{n}{2}\delta}$.

$$\mathbb{P}(\mathcal{E}_{2}) \leq \sum_{u_{a}, u_{b}} \left[P_{U_{a}, U_{b}}(u_{a}, u_{b}) \cdot \sum_{\substack{\hat{u}_{a} \neq u_{a}:\\(\hat{u}_{a}, u_{b}) \in \mathcal{T}_{n}(\delta)}} \mathbb{P}(\Phi_{n}(\hat{u}_{a}) = \Phi_{n}(u_{a})) \right] \\
= \sum_{u_{a}, u_{b}} \left[P_{U_{a}, U_{b}}(u_{a}, u_{b}) \cdot \sum_{\substack{\hat{u}_{a} \neq u_{a}:\\(\hat{u}_{a}, u_{b}) \in \mathcal{T}_{n}(\delta)}} \frac{1}{2^{\binom{n}{2}R}} \right] \\
\leq \frac{1}{2^{\binom{n}{2}R}} \sum_{u_{a}, u_{b}} P_{U_{a}, U_{b}}(u_{a}, u_{b}) \left| \left\{ \hat{u}_{a} : (\hat{u}_{a}, u_{b}) \in \mathcal{T}_{n}(\delta) \right\} \right|.$$
(28)

Since $P_{_{U_a|U_b}}(\hat{u}_a|u_b) \ge 2^{-H(A|B)-\delta}$ for any $(\hat{u}_a, u_b) \in \mathcal{T}_n(\delta)$, we have

$$1 \ge \sum_{\hat{u}_a: (\hat{u}_a, u_b) \in \mathcal{T}_n(\delta)} P_{U_a \mid U_b}(\hat{u}_a \mid u_b) \tag{29}$$

$$\geq 2^{-\binom{n}{2}[H(A|B)+\delta]} \left| \left\{ \hat{u}_a : (\hat{u}_a, u_b) \in \mathcal{T}_n(\delta) \right\} \right|,$$
(30)

which implies that $|\{\hat{u}_a: (\hat{u}_a, u_b) \in \mathcal{T}_n(\delta)\}| \leq 2^{\binom{n}{2}[H(A|B)+\delta]}$. By plugging this into (28), we have that for $R = H(A|B) + 2\delta$,

$$\mathbb{P}(\mathcal{E}_2) \le 2^{\binom{n}{2}[H(A|B)-R+\delta]} \sum_{u_a, u_b} P_{U_a, U_b}(u_a, u_b)$$
$$= 2^{-\binom{n}{2}\delta},$$

yielding the inequality (27).

We know from Theorem 2 that

$$\frac{1}{\binom{n}{2}}\log\frac{1}{P_{U_a|U_b}(U_a|U_b)}\longrightarrow H(A|B),$$

in probability, which means that for any $\delta > 0$, $\mathbb{P}(\mathcal{T}_n^c(\delta)) \to 0$ (or, equivalently $\mathbb{P}(\mathcal{T}_n(\delta)) \to 1$) as $n \to \infty$. This implies that the right-hand side of (27) goes to zero as $n \to \infty$, i.e., the probability of error (averaged over codebooks) $\bar{\epsilon}_n \to 0$. Hence, there exists a codebook with the compression rate $H(A|B)+2\delta$. Since $\delta > 0$ is arbitrary, we have $R^* \leq H(A|B)$, completing the proof of the theorem. \Box

It follows from the proof of Theorem 2 that the decoder can label the involved structure in all possible ways and check if the maximum of the joint probability distribution over all labelings satisfies a typicality condition. For instance, consider the case $U_a = G_a$ and $U_b = S_b$. It follows from the proof of Theorem 2 that in order to check if a graph g_a in a bin and the side information s_b satisfy the condition $(g_a, s_b) \in$ $\mathcal{T}_n(\delta)$, the decoder can first verify if the side information s_b is a typical unlabelled graph or not, and

$$2^{-\binom{n}{2}\left[H(A,B)+\frac{\delta}{2}\right]} \le \max_{g'_b \cong s_b} P_{G_a,G_b}(g_a,g'_b) \le 2^{-\binom{n}{2}\left[H(A,B)-\frac{\delta}{2}\right]}$$
(31)

by labelling s_b in all possible ways.

IV. UNWEIGHTED GRAPHS

In this section, we consider the special case of unweighted graphs. When the graphs are unweighted, the entries of the adjacency matrices take values in $\{0, 1\}$. In this case, we can cast Theorem 1 and the joint typicality condition in terms of graph alignment.

A. Graph Alignment

Let us briefly look at the idea of graph alignment, which finds its applications in deanonymization [10], [11] and pattern recognition [17]. In a nutshell, graph alignment involves finding a correspondence between the vertex sets of two graphs while optimizing an objective function. Let (G_a, G_b) be the correlated Erdős-Rényi random (unweighted) graphs with $P_{A,B}$ being the corresponding joint distribution of the entries of the adjacency matrices. We use the shorthand notation p_{ab} instead of $P_{A,B}(a,b)$ for $a, b \in \{0, 1\}$.

For example, let us consider the graph deanonymization problem. Here, a structure s_b corresponding to a true graph g_b is revealed publicly. The aim is to identify the true graph from s_b using another correlated labelled graph g_a . Given s_b alone, all the distinct graphs obtained by labelling s_b in all possible ways are equally likely. Note that the true graph g_b corresponds to some labelling of s_b . However, if one has access to a correlated labelled graph g_a , then they can use this extra information to estimate the true graph of s_b using g_a . This can be done by using the MAP estimator, which is optimal in the sense of minimizing the probability of error in recovering the true graph g_b . The MAP estimator is given by

$$\underset{g'_{b}}{\operatorname{argmax}} P_{G_{b}|G_{a},S_{b}}\left(g'_{b}|g_{a},s_{b}\right) = \underset{g'_{b}\cong s_{b}}{\operatorname{argmax}} P_{G_{a},G_{b}}\left(g_{a},g'_{b}\right).$$

The joint distribution $P_{G_a,G_b}(g_a,g_b')$ in the unweighted case can be expressed as

$$\prod_{i < j} p_{00}^{(1-a_{i,j})(1-b'_{i,j})} p_{10}^{a_{i,j}(1-b'_{i,j})} p_{01}^{(1-a_{i,j})b'_{i,j}} p_{11}^{a_{i,j}b'_{i,j}}$$

$$= p_{00}^{\binom{n}{2}} \left(\frac{p_{10}}{p_{00}}\right)^{\sum_{i < j} a_{i,j}} \left(\frac{p_{01}}{p_{00}}\right)^{\sum_{i < j} b'_{i,j}} \left(\frac{p_{11}p_{00}}{p_{10}p_{01}}\right)^{\sum_{i < j} a_{i,j}b'_{i,j}},$$
(32)

18

where $a_{i,j} \in \{0,1\}$ and $b_{i,j} \in \{0,1\}$, $i, j \in [n]$, are the entries of the adjacency matrices of g_a and g_b , respectively. Since the values of the sums $\sum_{i < j} a_{i,j}$ and $\sum_{i < j} b'_{i,j}$ remain unchanged for any $g'_b \cong s_b$, the MAP estimator becomes

$$\operatorname*{argmax}_{g'_b \cong s_b} \left(\frac{p_{_{11}} p_{_{00}}}{p_{_{10}} p_{_{01}}} \right)^{\sum_{i < j} a_{i,j} b'_{i,j}}$$

By using the fact that all the graphs having the structure s_b can be expressed as relabelled versions of the true graph g_b , the MAP estimator can be written equivalently as

$$\underset{\pi^{-1}(g_b):\pi\in\mathcal{S}_n}{\operatorname{argmax}} \left(\frac{p_{_{11}}p_{_{00}}}{p_{_{10}}p_{_{01}}}\right)^{\sum_{i< j}a_{i,j}b_{\pi(i),\pi(j)}}$$

Thus, if $p_{11}p_{00} > p_{10}p_{01}$, the MAP estimator chooses a graph $g'_b = \pi^{-1}(g_b)$ for some $\pi \in S_n$ such that it has the maximum value of $\sum_{i < j} a_{i,j}b'_{i,j} = \sum_{i < j} a_{i,j}b_{\pi(i),\pi(j)}$. In the other case of $p_{11}p_{00} < p_{10}p_{01}$, it produces the one that minimizes $\sum_{i < j} a_{i,j}b'_{i,j} = \sum_{i < j} a_{i,j}b_{\pi(i),\pi(j)}$.

The graph alignment statistic $\sum_{i < j} A_{i,j}B_{i,j}$ counts the pairs of vertices which have an edge in both the graphs G_a and G_b . Given a graph G_a and a structure S_b , the MAP estimator identifies the labelling of S_b that optimizes this statistic. We can also consider other equivalent statistics instead of $\sum_{i < j} A_{i,j}B_{i,j}$; for instance, the so-called *matching error* [10], $\sum_{i < j} [(1 - A_{i,j})B_{i,j} + A_{i,j}(1 - B_{i,j})]$, can also be used for the MAP estimation. The matching error measures the number of pairs of vertices for which the vertices are connected by an edge in G_a but not in G_b , or the vertices are connected by an edge in G_b but not in G_a .

It was shown in [9], [18] that the MAP estimator recovers the true graph with probability going to one as the number vertices grow larger and larger. This result is stated next. Though the original result applies to a more general setting where $P_{A,B}$ depends on n, we state it below in the special case of constant $P_{A,B}$.

Theorem 4 ([9], [18]). For correlated Erdős-Rényi random (unweighted) graphs (G_a, G_b) with $p_{11}p_{00} > p_{10}p_{01}$

$$\mathbb{P}\left(\sum_{i< j} A_{i,j} B_{i,j} < \max_{\pi \in \mathcal{S}_n} \sum_{i< j} A_{i,j} B_{\pi(i),\pi(j)}\right) \longrightarrow 0$$
(33)

as $n \to \infty$. If $p_{{}_{11}}p_{{}_{00}} < p_{{}_{10}}p_{{}_{01}}$, then

$$\mathbb{P}\left(\sum_{i< j} A_{i,j} B_{i,j} > \min_{\pi \in \mathcal{S}_n} \sum_{i< j} A_{i,j} B_{\pi(i),\pi(j)}\right) \longrightarrow 0$$
(34)

as $n \to \infty$.

The convergence in Theorem 4 is in fact exponential in *n*. More precisely, the probabilities are bounded above by $2^{-[(n-2)(\sqrt{p_{00}p_{11}}-\sqrt{p_{01}p_{10}})^2-2\log n]}$. Since we know that

$$\min_{\pi \in \mathcal{S}_n} \sum_{i < j} A_{i,j} B_{\pi(i),\pi(j)} \le \sum_{i < j} A_{i,j} B_{i,j} \le \max_{\pi \in \mathcal{S}_n} \sum_{i < j} A_{i,j} B_{\pi(i),\pi(j)}$$

Theorem 4 says that $\sum_{i < j} A_{i,j} B_{i,j}$ is equal to $\max_{\pi \in S_n} \sum_{i < j} A_{i,j} B_{\pi(i),\pi(j)}$ (resp. $\min_{\pi \in S_n} \sum_{i < j} A_{i,j} B_{\pi(i),\pi(j)}$) with high probability when $p_{11}p_{00} > p_{10}p_{01}$ (resp. $p_{11}p_{00} < p_{10}p_{01}$). This means the output of the MAP estimator is the true graph g_b with high probability.

B. Unweighted Graph Compression with Side Information

In the (unweighted) graph compression with side information, we can establish a convergence result, closely related to Theorem 1, for the graph alignment statistic. This result, which is stated next as a lemma, is an immediate consequence of Theorem 4.

Lemma 2. For correlated Erdős-Rényi random (unweighted) graphs (G_a, G_b) with $p_{11}p_{00} > p_{10}p_{01}$

$$\frac{\max_{\pi \in \mathcal{S}_n} \sum_{i < j} A_{i,j} B_{\pi(i),\pi(j)}}{\binom{n}{2}} \longrightarrow p_{11}$$
(35)

in probability as $n \to \infty$. On the other hand, if $p_{11}p_{00} < p_{10}p_{01}$ then

$$\frac{\min_{\pi \in \mathcal{S}_n} \sum_{i < j} A_{i,j} B_{\pi(i),\pi(j)}}{\binom{n}{2}} \longrightarrow p_{11}$$
(36)

in probability as $n \to \infty$. The same statements hold even for the maximum and minimum of $\sum_{i < j} A_{\pi_a(i), \pi_a(j)} B_{\pi_b(i), \pi_b(j)} \text{ over } \pi_a, \pi_b \in S_n.$

Proof. Let $p_{11}p_{00} > p_{10}p_{01}$. Fix a $\delta > 0$,

$$\mathbb{P}\left(\left|\frac{\max_{\pi\in\mathcal{S}_n}\sum_{i \delta\right) \\
= \mathbb{P}\left(\left|\max_{\pi\in\mathcal{S}_n}\sum_{i \binom{n}{2}\frac{\delta}{2} + \mathbb{P}\left(\left|\frac{\sum_{i \frac{\delta}{2}\right) \quad (37)$$

As we know that

$$\frac{\sum_{i < j} A_{i,j} B_{i,j}}{\binom{n}{2}} \longrightarrow \mathbb{E}[AB] = p_{11}$$

in probability by the weak law of large numbers, the second term in (37) goes to zero. The first term also goes to zero because of Theorem 4. This completes the proof of (35). The rest of the theorem statements

follow in a similar way.

Though the statement of Lemma 2 is weaker than that of Theorem 4, we record it here as it could be of independent interest.

When trying to check if an u_a in a bin and the side information u_b satisfy $(u_a, u_b) \in \mathcal{T}_n(\delta)$, the decoder can use the graph alignment statistic. Because

$$\frac{-\log P_{G_a,G_b}(g_a,g_b')}{\binom{n}{2}} = -\log p_{00} - \frac{\sum_{i < j} A_{i,j}}{\binom{n}{2}} \log \frac{p_{10}}{p_{00}} - \frac{\sum_{i < j} B'_{i,j}}{\binom{n}{2}} \log \frac{p_{01}}{p_{00}} - \frac{\sum_{i < j} A_{i,j} B'_{i,j}}{\binom{n}{2}} \log \frac{p_{11}p_{00}}{p_{10}p_{00}} + \frac{\sum_{i < j} A_{i,j} B'_{i,j}}{\binom{n}{2}} \log \frac{p_{11}p_{00}}{p_{00}} + \frac{\sum_{i < j} A_{i,j} B'_{i,j}}{\binom{n}{2}} \log \frac{p_{11}p_{00}}{p_{10}p_{00}} + \frac{\sum_{i < j} A_{i,j} B'_{i,j}}{\binom{n}{2}} \log \frac{p_{11}p_{00}}{p_{00}} + \frac{\sum_{i < j} A_{i,j} B'_{i,j}}{\binom{n}{2}} \log \frac{p_{11}p_{00}}{p_{00}} + \frac{\sum_{i < j} A_{i,j} B'_{i,j}}{\binom{n}{2}} \log \frac{p_{11}p_{00}}{p_{00}} + \frac{\sum_{i < j} A_{i,j} B'_{i,j}}{\binom{n}{2}} \log \frac{p_{11}p_{00}}{p_{10}} + \frac{\sum_{i < j} A_{i,j} B'_{i,j}}}{\binom{n}{2}} \log \frac{p_{11}p_{0,j}}{\binom{n}{2}} + \frac{\sum_{i < j} A_{i,j} B'_{i,j}}}{\binom{n}{2}} \log \frac{p_{11}p_{0,j}}{\binom{n}{2}} + \frac{\sum_{i < j} A_{i,j} B'_{i,j}}}{\binom{n}{2}} \log \frac{p_{11}p_{0,j}}{\binom{n}{2}} + \frac{\sum_{i < j} A_{i,j}}}{\binom{n}{2}} + \frac{\sum_{i < j} A_{i,j}}}{\binom{n}{2}} \log \frac{p_{11}p_{0,j}}{\binom{n}{2}} + \frac{\sum_{i < j} A_{i,j}}}{\binom{n}{2}} + \frac{\sum_{i < j} A_{i,j}$$

the decoder can, for instance, in the case of $U_a = G_a$ and $U_b = S_b$, verify $(g_a, s_b) \in \mathcal{T}_n(\delta)$ by first checking if the graph g_a in the bin and the structure s_b are typical or not, i.e.,

$$\binom{n}{2}(p_{10}+p_{11}-\delta_1) \le \sum_{i< j} A_{i,j} \le \binom{n}{2}(p_{10}+p_{11}+\delta_1),$$

and

$$\binom{n}{2}(p_{01} + p_{11} - \delta_2) \le \sum_{i < j} B'_{i,j} \le \binom{n}{2}(p_{01} + p_{11} + \delta_2)$$

where $\delta_1 := \delta/|\log \frac{p_{10}}{p_{00}}|$ and $\delta_2 := \delta/|\log \frac{p_{01}}{p_{00}}|$. Here $\sum_{i < j} B'_{i,j}$ counts the number of edges in the structure s_b . Next, the decoder can label s_b in all possible ways and check if one of the following graph alignment conditions is satisfied:

$$\binom{n}{2} (p_{11} - \delta_3) \le \max_{g'_b \ge s_b} \sum_{i < j} A_{i,j} B'_{i,j} \le \binom{n}{2} (p_{11} + \delta_3),$$

if $p_{11}p_{00} > p_{10}p_{01}$, or

$$\binom{n}{2} (p_{11} - \delta_3) \le \min_{g'_b \cong s_b} \sum_{i < j} A_{i,j} B'_{i,j} \le \binom{n}{2} (p_{11} + \delta_3),$$

if $p_{_{11}}p_{_{00}} < p_{_{10}}p_{_{01}}$, where $\delta_3 := \delta/|\log \frac{p_{_{11}}p_{_{00}}}{p_{_{10}}p_{_{01}}}|$.

V. DISCUSSION

In this work, we established the minimum achievable compression rate when the object to compress and the object available as side information are graphs or structures (unlabelled graphs). Unlike a labelled graph, a structure does not lend itself to a simple analysis. However, we can rely on the observation that structures retain most of the information about the labelled graphs. For an Erdős-Rényi graph, the entropy of a structure is roughly $n \log n$ bits less than the entropy of a labelled graph, which is of the order n^2 when the model parameters do not depend on the number of vertices n.

One of the key arguments in this paper is that the joint probability involving a structure, which is the sum of the joint probabilities over all labellings, can be approximated by the maximum of the joint probabilities over all labellings. We have shown that this maximum in turn is close in some sense to the true underlying labelling of the structure. As a result, we were able to show that the asymptotics of the conditional distributions involving structures are the same as those of the distributions involving only labelled graphs, yielding $R^* = H(A|B)$.

Our results readily extend to distributed compression involving unlabelled graphs. In this situation, Theorem 1 and Theorem 2 have to be extended for the problem under consideration. These results can then be used to construct an encoding and decoding scheme. In the current work, we considered the dense regime of the CER model, where $P_{A,B}$ does not depend on n. It is also of interest to consider other regimes where $P_{A,B}$ does depend on n. We believe that the current techniques should be extendable to other regimes as well, but we leave these questions for future study.

The CER model is rather ideal when considered in the context of practical graphs. Nevertheless, the model captures first-order correlations between graphs and can guide the choice of schemes to implement for real-world graphs. In addition to the CER model, it is also of interest to study graph compression with side information for random graph models such as the stochastic block model, where the connectivity of vertices is determined by the latent community membership variables. Furthermore, we can also study a more realistic scenario where the correlated graphs do not share the same vertex set but do possess some overlap of vertices.
