Almost Dominance: Inference and Application*

Abstract

This paper proposes a general framework for inference on three types of almost dominances: Almost Lorenz dominance, almost inverse stochastic dominance, and almost stochastic dominance. We first generalize almost Lorenz dominance to almost upward and downward Lorenz dominances. We then provide a bootstrap inference procedure for the Lorenz dominance coefficients, which measure the degrees of almost Lorenz dominances. Furthermore, we propose almost upward and downward inverse stochastic dominances and provide inference on the inverse stochastic dominance coefficients. We also show that our results can easily be extended to almost stochastic dominance. Simulation studies demonstrate the finite sample properties of the proposed estimators and the bootstrap confidence intervals. We apply our methods to the inequality growth in the United Kingdom and find evidence for almost upward inverse stochastic dominance.

1 Introduction

Suppose that there are two arbitrary cumulative distribution functions (CDFs) $F_1 : [0, \infty) \rightarrow$ [0, 1] and $F_2 : [0, \infty) \to [0, 1]$ of two income (or wealth, etc.) distributions in two populations. As introduced in [Atkinson](#page-28-0) [\(1970\)](#page-28-0), a Lorenz curve is a function that graphs the cumulative proportion of total income received by the bottom population. The distribution F_1 (weakly) Lorenz dominates F_2 if the Lorenz curve L_1 associated with F_1 is everywhere above the Lorenz curve L_2 associated with F_2 . Such Lorenz dominance implies that the wealth is distributed more equally in population F_1 compared to F_2 . Statistical tests of Lorenz dominance can be found in, for example, [McFadden](#page-31-0) [\(1989\)](#page-31-0), [Bishop et al.](#page-29-0) [\(1991a\)](#page-29-0), [Bishop et al.](#page-29-1) [\(1991b\)](#page-29-1), [Dardanoni and Forcina](#page-29-2) [\(1999\)](#page-29-2), [Davidson and Duclos](#page-30-0) [\(2000\)](#page-30-0), [Barrett](#page-28-1) [and Donald](#page-28-1) [\(2003\)](#page-28-1), [Barrett et al.](#page-28-2) [\(2014\)](#page-28-2), and [Sun and Beare](#page-32-0) [\(2021\)](#page-32-0).

[Zheng](#page-32-1) [\(2018\)](#page-32-1) introduces the notion of *almost Lorenz dominance*: When two Lorenz curves cross, F_1 almost Lorenz dominates F_2 if L_1 is above L_2 almost everywhere. The degree of almost Lorenz dominance can be measured by a coefficient, *Lorenz dominance coefficient* (LDC). The LDC was first proposed in [Zheng](#page-32-1) $(2018,$ Section 2.3),^{[1](#page-1-0)} which is similar to the violation ratio in [Huang et al.](#page-31-1) [\(2021\)](#page-31-1). [Zheng](#page-32-1) [\(2018\)](#page-32-1) shows that almost Lorenz dominance is highly related to Gini-type measures. Based on the seminal work of [Aaberge](#page-28-3) [\(2009\)](#page-28-3), we generalize almost Lorenz dominance to *almost upward Lorenz dominance* and *almost downward Lorenz dominance*. We relate the generalized LDCs to a class of inequality measures. It is straightforward to show that the smaller LDCs are, the more inequality measures demonstrate higher distribution equality in the dominant population. Thus, LDCs are of interest to us when we compare distributions in terms of distribution inequality. We then provide estimators for LDCs and establish the asymptotic properties of the estimators.^{[2](#page-1-1)} Based on the asymptotic distributions, we construct bootstrap confidence intervals (CIs) for LDCs. LDCs are nonlinear transformations of the difference functions

of two Lorenz curves. We show that this map is Hadamard directionally differentiable, and then we apply the bootstrap method of [Fang and Santos](#page-30-1) [\(2019\)](#page-30-1) to approximate the asymptotic distributions of the estimators and obtain the confidence intervals.^{[3](#page-2-0)}

The second degree inverse stochastic dominance [\(Atkinson,](#page-28-0) [1970\)](#page-28-0), also known as the generalized Lorenz dominance, is widely used for ranking distribution functions according to social welfare. However, as pointed out by [Aaberge et al.](#page-28-4) [\(2021\)](#page-28-4), when the distribution functions intersect, the second degree inverse dominance criterion may have limitations to attain an unambiguous ranking [\(Davies and Hoy,](#page-30-2) [1995;](#page-30-2) [Atkinson,](#page-28-5) [2008\)](#page-28-5). [Aaberge et al.](#page-28-4) [\(2021\)](#page-28-4) propose an approach for comparing intersecting distribution functions based on high-degree upward and downward inverse stochastic dominance criteria. They provide equivalence results between inverse stochastic dominance and the ranks of social welfare functions. Based on the framework of [Aaberge et al.](#page-28-4) [\(2021\)](#page-28-4), we introduce the notions of *almost upward inverse stochastic dominance* and *almost downward inverse stochastic dominance*. We then show that these types of almost dominances are also related to the ranks of social welfare functions. Similar to LDCs, the degree of almost inverse stochastic dominance can be measured by the *inverse stochastic dominance coefficients* (ISDCs). The smaller ISDCs are, the more social planner preference functions show higher social welfare for the dominant distribution. We provide inference and construct bootstrap confidence intervals for ISDCs.

Almost Lorenz dominance can be viewed as a special but nontrivial case of almost stochastic dominance which was first introduced by [Leshno and Levy](#page-31-2) [\(2002\)](#page-31-2). Almost stochastic dominance has been extensively studied by [Guo et al.](#page-30-3) [\(2013\)](#page-30-3), [Tzeng et al.](#page-32-2) [\(2013\)](#page-32-2), [Denuit et al.](#page-30-4) [\(2014\)](#page-30-4), [Guo et al.](#page-30-5) [\(2014\)](#page-30-5), [Tsetlin et al.](#page-32-3) [\(2015\)](#page-32-3), [Guo et al.](#page-30-6) [\(2016\)](#page-30-6), and [Huang et al.](#page-31-1) $(2021).4$ $(2021).4$ $(2021).4$ We show that our method on almost Lorenz dominance can

easily be generalized to almost stochastic dominance and provide bootstrap confidence intervals for the *stochastic dominance coefficients* (SDCs).

We study the inequality growth in the United Kingdom as an empirical example in the paper. We find that the estimated upward inverse stochastic dominance coefficients are small and the bootstrap confidence intervals are narrow, which implies that there may exist almost inverse stochastic dominance between the years considered in this example.

For simplicity of exposition, we focus on the almost Lorenz dominances in the main text. The results for other types of almost dominances are provided in the supplementary appendix. The organization of the paper is as follows. Section [2](#page-4-0) introduces the notions of Lorenz dominance coefficients, provides the properties of these coefficients, and relates them to measures of inequality. Section [2.3](#page-14-0) proposes estimators for LDCs and establishes the asymptotic distributions of the estimators. We then construct the confidence intervals for LDCs based on these asymptotic distributions. Section [3](#page-24-0) provides simulation evidence for the finite sample properties of the proposed method. In Section [4,](#page-26-0) we apply our methods to the empirical application. In the supplementary appendix, Sections A and B extend the results to almost inverse stochastic dominance and almost stochastic dominance. Section [C](#page-54-0) provides additional simulation results. Section [D](#page-58-0) contains the proofs of the results in the paper.

Notation [\(Sun and Beare,](#page-32-0) [2021\)](#page-32-0): Throughout the paper, all the random elements are defined on a probability space $(\Omega, \mathcal{A}, \mathbb{P})$. For an arbitrary set A, let $\ell^{\infty}(A)$ be the set of bounded real-valued functions on A equipped with the supremum norm $\|\cdot\|_{\infty}$ such that $||f||_{\infty}$ = sup_{x∈A} |f(x)| for every $f \in \ell^{\infty}(A)$. For a subset B of a metric space, let $C(B)$ be the set of continuous real-valued functions on B . Let \rightsquigarrow denote the weak convergence defined in [van der Vaart and Wellner](#page-32-5) [\(1996,](#page-32-5) p. 4). We follow the convention in [Folland](#page-30-10) [\(1999,](#page-30-10) p. 45) and define

$$
0 \cdot \infty = 0. \tag{1.1}
$$

2 Almost Lorenz Dominance

We suppose that the CDFs F_1 and F_2 satisfy the following regularity conditions which guarantee the weak convergence of the estimated quantile functions [\(Kaji,](#page-31-5) [2019;](#page-31-5) [Sun and](#page-32-0) [Beare,](#page-32-0) [2021\)](#page-32-0).

Assumption 2.1 *For* $j = 1, 2,$ F_j $(0) = 0$ and F_j is continuously differentiable on the interior *of its support with* $F_j'(x) > 0$ *for all* $x \in (0, \infty)$. In addition, F_j has finite $(2 + \epsilon)$ th absolute *moment for some* $\epsilon > 0$ *.*

With Assumption [2.1,](#page-4-1) we introduce the Lorenz curves. Let Q_1 and Q_2 denote the quantile functions corresponding to F_1 and F_2 , respectively, that is,

$$
Q_j(p) = \inf \{ x \in [0, \infty) : F_j(x) \ge p \}, \quad p \in [0, 1].
$$
 (2.1)

When F_j has finite first moment μ_j as implied by Assumption [2.1,](#page-4-1) the quantile function Q_j is integrable with $\int_0^1 Q_j(p) \mathrm{d}p = \mu_j$. Under Assumption [2.1](#page-4-1) with $\mu_j > 0$, the Lorenz curve L_j corresponding to F_j can then be defined as

$$
L_j(p) = \frac{1}{\mu_j} \int_0^p Q_j(t) \mathrm{d}t, \quad p \in [0, 1]. \tag{2.2}
$$

We say F_1 (weakly) Lorenz dominates F_2 if $L_1(p) \ge L_2(p)$ for all $p \in [0,1]$. We now follow [Zheng](#page-32-1) [\(2018\)](#page-32-1) and introduce the notion of almost Lorenz dominance. For all arbitrary CDFs $F_1 : [0, \infty) \to [0, 1]$ and $F_2 : [0, \infty) \to [0, 1]$ such that the corresponding Lorenz curves exist, define

$$
S(F_1, F_2) = \{ p \in [0, 1] : L_1(p) < L_2(p) \}.
$$

Definition 2.1 *For every* $\varepsilon \in [0, 1/2)$ *,* the CDF F_1 ε -almost Lorenz dominates the CDF F_2

*(*F¹ ε*-ALD* F2*), if*

$$
\int_{S(F_1,F_2)} (L_2(p) - L_1(p)) \, dp \le \varepsilon \int_0^1 |L_2(p) - L_1(p)| \, dp. \tag{2.3}
$$

Remark 2.1 *[Zheng](#page-32-1)* [\(2018\)](#page-32-1) defines the almost Lorenz dominance for all $\varepsilon \in (0,1/2)$ *, while we allow* $\varepsilon = 0$. The inequality [\(2.3\)](#page-5-0) holds with $\varepsilon = 0$ if and only if F_1 Lorenz dominates F2*. Thus, by Definition [2.1,](#page-4-2) almost Lorenz dominance is a weaker and generalized version of Lorenz dominance.*

Lemma 2.1 *For every* $\varepsilon \in [0, 1/2)$ *,* $F_1 \varepsilon$ -ALD F_2 *if and only if there is* $c \in [0, \varepsilon]$ *such that*

$$
\int_{S(F_1,F_2)} (L_2(p) - L_1(p)) dp = c \int_0^1 |L_2(p) - L_1(p)| dp.
$$
\n(2.4)

We define the distance function of the two Lorenz curves by

$$
\phi(p) = L_2(p) - L_1(p), \quad p \in [0, 1]. \tag{2.5}
$$

Based on the equality in [\(2.4\)](#page-5-1), we follow [Zheng](#page-32-1) [\(2018\)](#page-32-1) and define the F_1 - F_2 Lorenz Dom*inance Coefficient* as follows.[5](#page-5-2)

Definition 2.2 *Suppose that there are two Lorenz curves* L_1 *and* L_2 *corresponding to the CDFs* F_1 *and* F_2 *, respectively. The* F_1 - F_2 Lorenz dominance coefficient (F_1 - F_2 LDC)*, denoted by* $c(L_1, L_2)$ *, is defined as*

$$
c(L_1, L_2) = \inf \left\{ \varepsilon \in [0, 1] : \int_{S(F_1, F_2)} (L_2(p) - L_1(p)) \, dp \le \varepsilon \int_0^1 |L_2(p) - L_1(p)| \, dp \right\}.
$$
\n(2.6)

The following lemma summarizes the properties of the LDC $c(L_1, L_2)$.

Lemma 2.2 *The LDC* $c(L_1, L_2)$ *is the smallest* ε *in* [0, 1] *such that* [\(2.3\)](#page-5-0) *holds,* $c(L_1, L_2) = 0$ *if and only if* F_1 *Lorenz dominates* F_2 *, and* $c(L_1, L_2) = 1$ *implies that* F_2 *Lorenz dominates* F1*. With* [\(1.1\)](#page-3-0)*, it follows that*

$$
c(L_1, L_2) = \frac{\int_{S(F_1, F_2)} (L_2(p) - L_1(p)) dp}{\int_0^1 |L_2(p) - L_1(p)| dp} = \frac{\int_0^1 \max \{\phi(p), 0\} dp}{\int_0^1 \max \{\phi(p), 0\} dp + \int_0^1 \max \{-\phi(p), 0\} dp}.
$$
\n(2.7)

In addition, if $c(L_1, L_2) \in (0, 1]$ *, then* $c(L_2, L_1) = 1 - c(L_1, L_2)$ *.*

According to Lemma [2.2,](#page-6-0) $F_1 \in$ -ALD F_2 for all $\varepsilon \in [c(L_1, L_2), 1/2)$ if $c(L_1, L_2) < 1/2$. On the other hand, $c(L_1, L_2) > 1/2$ implies that $F_2 \varepsilon$ -ALD F_1 for all $\varepsilon \in [1 - c(L_1, L_2), 1/2)$. Thus, $c(L_1, L_2)$ presents the almost Lorenz dominance relationship between F_1 and F_2 , and provides all ε for which ε -ALD holds.

When L_1 and L_2 cross, given some $\varepsilon \in (0, 1/2)$, one interesting hypothesis is

$$
H_0: \int_{S(F_1,F_2)} (L_2(p) - L_1(p)) dp \le \varepsilon \int_0^1 |L_2(p) - L_1(p)| dp.
$$

Lemma [2.2](#page-6-0) shows that it is equivalent to test the following hypothesis on $c(L_1, L_2)$:

$$
H_0: c(L_1, L_2) \leq \varepsilon.
$$

The LDC provided in Definition [2.2](#page-5-3) is closely related to Gini-type measures that are weighted averages of the area between the diagonal line and Lorenz curves. Following [Shorrocks and Slottje](#page-31-6) [\(2002\)](#page-31-6), for every possible weighting function θ , a Gini-type measure for distribution F can be defined as

$$
I(F,\theta) = \frac{\int_0^1 [p - L_F(p)] \theta(p) \, dp}{\int_0^1 p \theta(p) \, dp}, \quad p \in [0,1],
$$
\n(2.8)

where L_F denotes the Lorenz curve associated with the distribution F .

We follow [Zheng](#page-32-1) [\(2018\)](#page-32-1) and denote $\mathscr B$ the set of all Gini-type measures for all possible weighting functions θ . Define

$$
\tilde{\theta}(p) = \theta(p) / \int_0^1 p\theta(p) \, \mathrm{d}p
$$

for every possible weighting function θ . It then follows that

$$
I(F,\theta) = \int_0^1 \left[p - L_F(p) \right] \tilde{\theta}(p) \,dp.
$$

For every $0 < \varepsilon < 1/2$, we define

$$
\mathscr{B}^*(\varepsilon) = \left\{ I(\cdot, \theta) : \tilde{\theta} > 0 \text{ and } \sup_{p \in [0,1]} \left\{ \tilde{\theta}(p) \right\} \le \inf_{p \in [0,1]} \left\{ \tilde{\theta}(p) \right\} \cdot \left(\frac{1}{\varepsilon} - 1 \right) \right\}.
$$
 (2.9)

As discussed in [Zheng](#page-32-1) [\(2018\)](#page-32-1), the condition in [\(2.9\)](#page-7-0) basically requires that the largest weight in weighting the distance $p-L_F(p)$ can not be larger than $1/\varepsilon-1$ times the smallest weight.

Proposition 1 of [Zheng](#page-32-1) [\(2018\)](#page-32-1) shows that for every $\varepsilon \in (0,1/2)$, $F \varepsilon$ -ALD G if and only if $I(F,\theta) \leq I(G,\theta)$ for all $I(\cdot,\theta) \in \mathcal{B}^*(\varepsilon)$. According to Lemma [2.2,](#page-6-0) for every $\varepsilon \geq c(L_1,L_2)$ with $c(L_1, L_2) \in (0, 1/2)$, $F \in$ -ALD G and thus $I(F, \theta) \leq I(G, \theta)$ for all $I(\cdot, \theta) \in \mathcal{B}^*(\varepsilon)$. Therefore, we have the following proposition.

Proposition 2.1 *If* $c(L_1, L_2) \in (0, 1/2)$ *, it follows that* $I(F_1, \theta) \leq I(F_2, \theta)$ *for all* $I(\cdot, \theta) \in$ $\cup_{\varepsilon\in [c(L_1,L_2),1/2)} \mathscr B^*(\varepsilon) .$ ^{[6](#page-7-1)} If $c\left(L_1,L_2\right)=0,$ it follows that $I\left(F_1,\theta\right)\leq I\left(F_2,\theta\right)$ for all $I\left(\cdot,\theta\right)\in$ $\cup_{\varepsilon \in (0,1/2)} \mathscr{B}^*(\varepsilon)$.

Proposition [2.1](#page-7-2) shows the importance of LDC concerning Gini-type measures. The smaller the LDC $c(L_1, L_2)$ is, the more Gini-type measures show higher equality in the distribution F_1 compared to F_2 . With the knowledge of $c(L_1, L_2)$, we can infer the relationship between F_1 and F_2 based on a class of Gini-type measures.

Following [Aaberge](#page-28-3) [\(2009\)](#page-28-3), we introduce the family of rank-dependent measures of inequality:

$$
J_P(L_j) = 1 - \int_0^1 P'(t) \, \mathrm{d}L_j(t) = 1 - \frac{1}{\mu_j} \int_0^1 P'(t) \, Q_j(t) \, \mathrm{d}t,\tag{2.10}
$$

where L_j is the Lorenz curve of the distribution F_j with mean μ_j and the weighting function P' is the derivative of a continuous, differentiable, and concave function $P : [0, 1] \rightarrow$ [0, 1] such that $P(0) = 0$, $P(1) = 1$, and $P'(1) = 0$. As demonstrated by [Yaari](#page-32-6) [\(1988\)](#page-32-6) and [Aaberge](#page-28-7) [\(2001\)](#page-28-7), P can be interpreted as a preference function of a social decision maker, which assigns weights to the incomes of individuals in accordance with their rank in the income distribution, and $J_P(L)$ measures the extent of inequality in an income distribution with Lorenz curve L . We formally define the set P of preference functions by

$$
P = \left\{ P \in C([0,1]) : P(0) = 0, P(1) = 1, P'(1) = 0, \newline P'(t) > 0 \text{ and } P^{(2)}(t) < 0 \text{ for all } t \in (0,1) \newline \}
$$

.

2.1 Almost Upward Lorenz Dominance and Inequality Measure

To unify notation, we let $L_j^1 = L_j$ for $j = 1, 2$. For $m \geq 2$, define function

$$
L_j^m(p) = \int_0^p L_j^{m-1}(t) dt, \quad p \in [0, 1].
$$

[Aaberge](#page-28-3) [\(2009\)](#page-28-3) introduces the mth-degree upward Lorenz dominance for $m \geq 2$ as illustrated in the following.

Definition 2.3 *A distribution* F_1 *mth-degree upward Lorenz dominates a distribution* F_2 *if* $L_1^m(p) \ge L_2^m(p)$ for all $p \in [0,1]$.

We generalize upward Lorenz dominance in [Aaberge](#page-28-3) [\(2009\)](#page-28-3) to almost upward Lorenz dominance.

Definition 2.4 *For every* $\varepsilon_m \in [0, 1/2)$ *, the CDF* $F_1 \varepsilon_m$ *-almost mth-degree upward Lorenz dominates the CDF* F_2 $(F_1 \varepsilon_m$ -AmULD F_2), if

$$
\int_{0}^{1} \max\left(L_{2}^{m}\left(p\right)-L_{1}^{m}\left(p\right),0\right) \mathrm{d}p \le \varepsilon_{m} \int_{0}^{1} \left|L_{2}^{m}\left(p\right)-L_{1}^{m}\left(p\right)\right| \mathrm{d}p. \tag{2.11}
$$

Remark 2.2 *In Definition [2.4,](#page-9-0) if* $\varepsilon_m = 0$ *, then* F_1 *mth-degree upward Lorenz dominates* F_2 *.*

For every $\varepsilon_m \in (0, 1/2)$, we define two sets of preference functions

$$
P_m(\varepsilon_m) = \left\{ \begin{array}{l} P \in P : (-1)^m P^{(m+1)} \ge 0, P^{(j)}(1) = 0 \text{ for } j \in \{2, ..., m\}, \\ \sup_t \left\{ (-1)^m P^{(m+1)}(t) \right\} \le \inf_t \left\{ (-1)^m P^{(m+1)}(t) \right\} \cdot \left(\frac{1}{\varepsilon_m} - 1 \right) \end{array} \right\}
$$

and

$$
P'_{m}(\varepsilon_{m}) = \left\{ P \in P : (-1)^{m} P^{(m+1)} \geq 0, (-1)^{j-1} P^{(j)}(1) \geq 0 \text{ for } j \in \{2, ..., m\}, \text{ }\sup_{t} \left\{ (-1)^{m} P^{(m+1)}(t) \right\} \leq \inf_{t} \left\{ (-1)^{m} P^{(m+1)}(t) \right\} \cdot \left(\frac{1}{\varepsilon_{m}} - 1 \right) \right\}.
$$

The following proposition relates almost upward Lorenz dominance to the inequality measures J_P in [\(2.10\)](#page-8-0).

Proposition 2.2 *For every* $\varepsilon_m \in (0, 1/2)$ *, if* $F_1 \varepsilon_m$ -Am*ULD* F_2 *, then* $J_P(L_1) \leq J_P(L_2)$ *for* $\textit{every}\,\,P\,\in\,\mathrm{P}_m\left(\varepsilon_m\right)$. If F_1 ε_m -AmULD F_2 and L_1^j $j_1^j(1) \geq L_2^j$ $\mathcal{Q}_2^{j}\left(1\right)$ for all $j\,\in\,\left\{2,\ldots,m\right\}$, then $J_P(L_1) \leq J_P(L_2)$ for every $P \in \mathrm{P}'_m(\varepsilon_m)$.

For $m \geq 2$, following Lemma [2.1,](#page-5-4) it is straightforward to show that $F_1 \varepsilon_m$ -AmULD F_2 if and only if there is $c_m \in [0, \varepsilon_m]$ such that

According to Lemma [2.3,](#page-10-0) $F_1 \varepsilon_m$ -AmULD F_2 for all $\varepsilon_m \in [c_m^u(L_1, L_2), 1/2)$ if $c_m^u(L_1, L_2)$ 1/2. On the other hand, $c_m^u(L_1, L_2) > 1/2$ implies that $F_2 \varepsilon_m$ -AmULD F_1 for all $\varepsilon_m \in [1 - \frac{1}{2}]$ $c^u_m(L_1,L_2),1/2$). Thus, $c^u_m(L_1,L_2)$ presents the degree of almost upward Lorenz dominance relationship between F_1 and F_2 , and provides all ε_m such that the ε_m -AmULD holds.

Proposition 2.3 *If* $c_m^u(L_1, L_2) \in (0, 1/2)$, it then follows that $J_P(L_1) \leq J_P(L_2)$ for all $P \in \cup_{\varepsilon_m \in [c_m^u(L_1,L_2),1/2)} P_m(\varepsilon_m)$ *.* If, in addition, L_1^j $j_1^j(1) \geq L_2^j$ $\mathcal{L}_2^{\jmath}\left(1\right)$ for all $j\,\in\,\{2,\ldots,m\}$, then $J_P(L_1) \leq J_P(L_2)$ for all $P \in \bigcup_{\varepsilon_m \in [c_m^u(L_1,L_2),1/2]} P'_m(\varepsilon_m)$.

Similar to Proposition [2.1,](#page-7-2) Proposition [2.3](#page-10-1) shows the importance of ULDC concerning inequality measures J_P . The smaller the ULDC $c_m^u(L_1, L_2)$ is, the more inequality measures show higher equality in the distribution F_1 compared to F_2 . With the knowledge of $c_m^u(L_1,L_2)$, we can infer the relationship between F_1 and F_2 based on a class of inequality measures.

2.2 Almost Downward Lorenz Dominance and Inequality Measure

Define function

We generalize downward Lorenz dominance in [Aaberge](#page-28-3) [\(2009\)](#page-28-3) to almost downward Lorenz dominance.

Definition 2.7 *For every* $\varepsilon_m \in [0, 1/2)$ *, the CDF* $F_1 \varepsilon_m$ -almost mth-degree downward Lorenz *dominates the CDF* F_2 $(F_1 \varepsilon_m$ -AmDLD F_2), if

The following proposition relates almost downward Lorenz dominance to the inequality measures J_P in [\(2.10\)](#page-8-0).

In addition, if $c_m^d(L_1, L_2) \in (0, 1]$ *, then* $c_m^d(L_2, L_1) = 1 - c_m^d(L_1, L_2)$ *.*

According to Lemma [2.4,](#page-13-0) F_1 ε_m -AmDLD F_2 for all $\varepsilon_m \in [c_m^d(L_1,L_2),1/2)$ if $c_m^d(L_1,L_2) <$ 1/2. On the other hand, $c_m^d(L_1, L_2) > 1/2$ implies that $F_2 \varepsilon_m$ -AmDLD F_1 for all $\varepsilon_m \in$ $[1 - c_m^d(L_1, L_2), 1/2]$. Thus, $c_m^d(L_1, L_2)$ presents the degree of almost downward Lorenz dominance relationship between F_1 and F_2 , and provides all ε_m such that the ε_m -AmDLD holds.

Proposition 2.5 *If* $c_m^d(L_1, L_2) \in (0, 1/2)$, it then follows that $J_P(L_1) \leq J_P(L_2)$ for all $P\,\in\,\cup_{\varepsilon_m\in[c_m^d(L_1,L_2),1/2)} \tilde{P}_m(\varepsilon_m)$ *. If, in addition,* $\tilde{L}_1^j\left(0\right)\leq\tilde{L}_2^j\left(0\right)$ *for all* $j\,\in\,\{2,\ldots,m\}$ *<i>, then* $J_P(L_1) \leq J_P(L_2)$ for all $P \in \bigcup_{\varepsilon_m \in [c_m^d(L_1,L_2),1/2)} \tilde{P}'_m(\varepsilon_m)$.

Similar to Proposition [2.1,](#page-7-2) Proposition [2.5](#page-13-1) shows the importance of DLDC concerning inequality measures J_P . The smaller the DLDC $c_m^d(L_1, L_2)$ is, the more inequality measures show higher equality in the distribution F_1 compared to F_2 . With the knowledge of $c_m^d(L_1,L_2)$, we can infer the relationship between F_1 and F_2 based on a class of inequality measures.

2.3 Estimation and Inference

As discussed in the previous sections, LDCs play an important role in comparing the equality of income (or wealth) distributions in two populations. In this section, we consider the estimation and the inference of LDCs.

2.3.1 Sampling Frameworks

Following [Barrett et al.](#page-28-2) [\(2014\)](#page-28-2) and [Sun and Beare](#page-32-0) [\(2021\)](#page-32-0), we consider two alternative frameworks for sampling from F_1 and F_2 . From F_1 and F_2 , we draw identically and independently distributed (iid) samples $\{X_i^j\}$ i , $j_{i=1}^{n_j}$ ($j = 1, 2$) that satisfy the following assumption.

Assumption 2.2 *[\(Barrett et al.,](#page-28-2) [2014;](#page-28-2) [Sun and Beare,](#page-32-0) [2021\)](#page-32-0) The iid samples* $\{X_i^1\}_{i=1}^{n_1}$ *and* $\{X_i^2\}_{i=1}^{n_2}$ drawn from F_1 and F_2 satisfy one of the following conditions.

(*i*) Independent samples: $\{X_i^1\}_{i=1}^{n_1}$ and $\{X_i^2\}_{i=1}^{n_2}$ are mutually independent, and the sample *sizes* n_1 *and* n_2 *are treated as functions of an underlying index* $n \in \mathbb{N}$ *such that as* $n \to \infty$,

$$
\frac{n_1 n_2}{n_1 + n_2} \to \infty \quad \text{and} \quad \frac{n_1}{n_1 + n_2} \to \lambda \in [0, 1]. \tag{2.17}
$$

(ii) Matched pairs: *The sample sizes* n_1 *and* n_2 *satisfy* $n_1 = n_2 = n$ *, the pairs* $\{(X_i^1, X_i^2)\}_{i=1}^n$ *are iid, and the bivariate copula for those pairs has maximal correlation strictly less than one (see, e.g., [Beare,](#page-29-8) [2010,](#page-29-8) Definition 3.2).*

2.3.2 Construction of Estimator

We define maps $\mathcal{F}_1 : \ell^{\infty}([0,1]) \to \mathbb{R}$, $\mathcal{F}_2 : \ell^{\infty}([0,1]) \to \mathbb{R}$, and $\mathcal{F} : \ell^{\infty}([0,1]) \to \mathbb{R}$ by

Clearly, for $m \ge 1$, we have $c_m^w(L_1, L_2) = \mathcal{F}(\phi_m^w)$ by [\(2.7\)](#page-6-1), [\(2.13\)](#page-10-2), and [\(2.16\)](#page-13-2). Following [Barrett et al.](#page-28-2) [\(2014\)](#page-28-2) and [Sun and Beare](#page-32-0) [\(2021\)](#page-32-0), for $j = 1, 2$, define the empirical CDF

Here, $B_0(\phi^w_m)$ is the contact set we need to estimate later. For more discussions on the estimation of contact sets, see, for example, [Linton et al.](#page-31-7) [\(2010\)](#page-31-7) for an improved bootstrap test of stochastic dominance and [Lee et al.](#page-31-8) [\(2018\)](#page-31-8) for testing functional inequalities. By Lemma S.4.5 of [Fang and Santos](#page-30-1) [\(2019\)](#page-30-1), we have that \mathcal{F}_1 and \mathcal{F}_2 are both Hadamard directionally differentiable at ϕ^w_m tangentially to $\ell^\infty\left([0,1]\right)$ with

Proposition [2.6](#page-19-0) provides the asymptotic distribution of $\hat{c}^w_m(L_1, L_2)$ when $\phi^w_m(p) \neq 0$ for some $p \in [0,1]$. We next construct a bootstrap confidence interval for $c_m^w(L_1, L_2)$ based on this asymptotic distribution.

2.3.4 Bootstrap Confidence Interval

Since the distribution of $\mathcal{F}'_{\phi^w_m}(\mathcal{I}^w_m(\mathbb{G}))$ in [\(2.30\)](#page-19-1) is unknown and depends on the underlying DGPs, we use the bootstrap method to approximate this distribution. Because $\mathcal{F}_{\phi^w_m}$ is nonlinear, the standard bootstrap method may not consistently approximate the distribution of $\mathcal{F}'_{\phi^w_m}(\mathcal{I}^w_m(\mathbb{G}))$ [\(Andrews,](#page-28-6) [2000;](#page-28-6) [Bickel et al.,](#page-29-3) [2012;](#page-29-3) [Fang and Santos,](#page-30-1) [2019\)](#page-30-1). We next employ the bootstrap method of [Fang and Santos](#page-30-1) [\(2019\)](#page-30-1) to obtain a consistent approximation of the asymptotic distribution and construct valid critical values. By Lemma [2.5,](#page-18-0) for $j, j' \in \{1, 2\}$ and $p, p' \in [0, 1]$, the estimator for $E[\mathcal{L}_j(p) \mathcal{L}_{j'}(p')]$, denoted by $\hat{E}\left[{\cal L}_{j}\left(p\right){\cal L}_{j'}\left(p'\right)\right]$, is defined as the sample covariance of the two samples

In practice, we approximate $\hat{c}^w_{m,\beta}$ by computing the β quantile of the n_B independently generated $\hat{c}^{w*}_{m}(L_1, L_2)$, where n_B is chosen as large as is computationally convenient.

For a nominal significance level $\alpha \in (0,1/2)$, we construct the $1-\alpha$ bootstrap confidence interval of $c_m^w(L_1, L_2)$ by

For* $m \ge 1$ *and* $w \in \{u, d\}$ *, if* $c^w_m(L_1,L_2)\,\in\,(0,1)$ and the CDF of $\mathcal F'_{\phi^w_m}(\mathcal I^w_m(\mathbb G))$ is continuous and increasing at $c^w_{m,\alpha/2}$ and $c_{m,1-\alpha/2}^w$, then it follows that

Proposition [2.7](#page-23-0) provides the two-sided confidence interval for $c_m^w(L_1,L_2)$. It is straightforward to extend the result to one-sided confidence intervals.

3 Simulation Evidence

We run Monte Carlo simulations to provide evidence for the finite sample properties of the estimators and the bootstrap confidence intervals. In this section, we focus on the Lorenz dominance coefficient. Additional simulations are provided in Section [C](#page-54-0) in the appendix. The number of bootstrap samples n_B is 1000. The number of Monte Carlo iterations is 1000. The nominal significance level is set to 0.05. We present the mean (Mean), the bias (Bias), the standard error (SE), and the root mean square error (RMSE) of the estimators, and present the coverage rate (CR) of the bootstrap confidence intervals in 1000 iterations.

As discussed in [Sun and Beare](#page-32-0) [\(2021\)](#page-32-0), [Reed](#page-31-9) [\(2001,](#page-31-9) [2003\)](#page-31-10) and [Toda](#page-32-7) [\(2012\)](#page-32-7) show that income distributions can be well approximated by members of the double Pareto parametric family. We use distributions from this family to construct the simulations. The density function for the double Pareto family is

$$
f(x) = \begin{cases} \frac{\alpha \beta}{\alpha + \beta} M^{\alpha} x^{-\alpha - 1} & x \ge M, \\ \frac{\alpha \beta}{\alpha + \beta} M^{-\beta} x^{\beta - 1} & 0 \le x < M, \end{cases}

where $M > 0$ is a scale parameter. For $\alpha, \beta > 0$, we write $X \sim dP(\alpha, \beta)$ to denote that the random variable X has the double Pareto distribution with M normalized to one and shape parameters α, β . Assumption [2.1](#page-4-1) is satisfied when $\alpha > 2$. We let $X^1 \sim dP(3, 1.5)$ and $X^2_{(\beta)} \sim dP(2.1, \beta)$ with $\beta \in \{2, 3, 4, 5\}$. Figure [3.1](#page-26-1) displays the Lorenz curves L_1 and $L_{2(\beta)}$ corresponding to the above DGPs. The LDC $c(L_1, L_2) = 0.04703, 0.31489, 0.45198,$ and 0.51960, respectively, for $\beta = 2, 3, 4$, and 5. We choose the tuning parameter from $t_n \in (0, 20]$. In Section [C.3,](#page-57-0) we show how to choose t_n empirically to construct the bootstrap confidence intervals. For independent samples, we let

Tables [3.1](#page-25-0) and [3.2](#page-27-0) show the simulation results for independent samples and matched pairs. For all the DGPs, as n_1 and n_2 increase, Mean gets close to $c(L_1, L_2)$, Bias decreases to 0, and both SE and RMSE decrease; under appropriate choices of t_n , CR approaches to 95%.

4 Empirical Application

In this section, we revisit the example of [Aaberge et al.](#page-28-4) [\(2021\)](#page-28-4) about the inequality growth in the United Kingdom over the past few decades which may be related to the business cycle [\(Blundell and Etheridge,](#page-29-9) [2010\)](#page-29-9). We use the replication data of [Aaberge et al.](#page-28-4) [\(2021\)](#page-28-4), which originally came from the European Community Household Panel (ECHP) for 1995–2001, and from the European Union Statistics on Income and Living Conditions (EU-SILC) for 2005–2010. In each year, the sample was restricted to households with a male aged 25–64. We follow [Aaberge et al.](#page-28-4) [\(2021\)](#page-28-4) and focus on the distribution of individual equivalent income adjusted for inflation and differences in household size and

composition.

Tables 3 and 4 of [Aaberge et al.](#page-28-4) [\(2021\)](#page-28-4) report the successful rankings based on the 3rd-degree upward and downward inverse stochastic dominances. They show that the 3rd-degree upward inverse stochastic dominance does not provide a complete ranking for several years. We apply the proposed method to estimate the upward inverse stochastic dominance coefficients (UISDCs) and construct the confidence intervals of these coeffi-cients for some of these years.^{[7](#page-27-1)} We compare the latter years (F_1) with the former years (F_2) shown in Table [4.1,](#page-28-8) and find that all the estimated UISDCs are small. Furthermore, the bootstrap confidence intervals are narrow. These facts provide evidence that the income distributions of the latter years may almost upward inverse stochastically dominate the income distributions of the former years, which complements the results of [Aaberge](#page-28-4) [et al.](#page-28-4) [\(2021\)](#page-28-4).

A Almost Inverse Stochastic Dominance

Following [Leshno and Levy](#page-31-2) [\(2002\)](#page-31-2), [Zheng](#page-32-1) [\(2018\)](#page-32-1), and [Aaberge et al.](#page-28-4) [\(2021\)](#page-28-4), in this section, we propose *almost inverse stochastic dominances*, define the *inverse stochastic dominance coefficients*, and establish an inference procedure for these coefficients. Let F_1 and

 F_2 be two distributions that satisfy Assumption [2.1.](#page-4-1) Define

$$
\Lambda_j^2(p) = \int_0^p F_j^{-1}(t) dt, \quad p \in [0, 1].
$$

Let P denote the social planner's preference function. As pointed out by [Yaari](#page-32-6) [\(1988\)](#page-32-6) and [Aaberge et al.](#page-28-4) [\(2021\)](#page-28-4), the social welfare functions are consistent with the condition of second-degree stochastic dominance if and only if $P^\prime > 0$ and $P^{(2)} < 0.$ We follow [Aaberge](#page-28-4) [et al.](#page-28-4) [\(2021\)](#page-28-4) and define the set of social planner's preference functions

$$
\mathcal{P} = \left\{ P \in C([0,1]) : P(0) = 0, P(1) = 1, P'(1) = 0, \newline P'(t) > 0 \text{ and } P^{(2)}(t) < 0 \text{ for all } t \in (0,1) \right\}.
$$

We then define the welfare functions W_P such that for every $P \in \mathcal{P}$ and every CDF F,

$$
W_P(F) = \int_0^1 P'(t) F^{-1}(t) dt.
$$

Theorem 1 of [Aaberge](#page-28-7) [\(2001\)](#page-28-7) demonstrates that a person who supports Axioms 1–4 in [Aaberge](#page-28-7) [\(2001\)](#page-28-7) ranks Lorenz curves according to the criterion W_P .

Remark A.1 *[Aaberge et al.](#page-28-4) [\(2021\)](#page-28-4) discuss the relationship between the inequality measure* J_P *defined in* [\(2.10\)](#page-8-0) and the social welfare measure W_P . [Ebert](#page-78-0) [\(1987\)](#page-78-0) shows that for every *preference function* $P \in \mathcal{P}$ *and every distribution function* F *that satisfies Assumption* [2.1,](#page-4-1) $W_P(F) = \mu_F(1 - J_P(L_F))$, where μ_F denotes the population mean for F and L_F denotes *the Lorenz curve corresponding to* F*. As pointed out by [Aaberge et al.](#page-28-4) [\(2021\)](#page-28-4), the product* $\mu_F J_P (L_F)$ presents the loss in social welfare due to inequality in the distribution.

A.1 Almost Upward Inverse Stochastic Dominance and Social Welfare

For $m > 3$, define

$$
\Lambda_j^m(p) = \int_0^p \Lambda_j^{m-1}(t) dt = \int_0^p \cdots \int_0^{t_3} \int_0^{t_2} F_j^{-1}(t_1) dt_1 dt_2 \cdots dt_{m-1}

[Aaberge et al.](#page-28-4) [\(2021\)](#page-28-4) introduce the mth-degree upward inverse stochastic dominance for $m \geq 3$.

Definition A.1 *A distribution* F_1 *mth-degree upward inverse stochastically dominates a distribution* F_2 *if* $\Lambda_1^m(p) \geq \Lambda_2^m(p)$ *for all* $p \in [0,1]$ *.*

When $m = 2$, the upward inverse stochastic dominance is the generalized Lorenz dominance. We generalize the upward inverse stochastic dominance in [Aaberge et al.](#page-28-4) [\(2021\)](#page-28-4) to almost upward inverse stochastic dominance.

Definition A.2 *For every* $\varepsilon_m \in [0, 1/2)$ *, the CDF* $F_1 \varepsilon_m$ *-almost mth-degree upward inverse stochastically dominates the CDF* F_2 ($F_1 \varepsilon_m$ -AmUISD F_2), if

\mathcal{P}_m(\varepsilon_m) = \left\{ P \in \mathcal{P} : (-1)^{m-1} P^{(m)} \ge 0, P^{(j)}(1) = 0 \text{ for } j \in \{2, ..., m-1\}, \newline \sup_t \left\{ (-1)^{m-1} P^{(m)}(t) \right\} \le \inf_t \left\{ (-1)^{m-1} P^{(m)}(t) \right\} \cdot \left(\frac{1}{\varepsilon_m} - 1 \right) \right\}
$$

and

$$
\mathcal{P}'_m(\varepsilon_m) = \left\{ P \in \mathcal{P} : (-1)^{m-1} P^{(m)} \ge 0, (-1)^{j-1} P^{(j)} (1) \ge 0 \text{ for } j \in \{2, ..., m-1\}, \sup_{t \in \mathbb{R}^m} \{(-1)^{m-1} P^{(m)}(t)\} \le \inf_t \{(-1)^{m-1} P^{(m)}(t)\} \cdot \left(\frac{1}{\varepsilon_m} - 1\right) \right\}.
$$
Then the following proposition links AmUISD to the social welfare function W_P with P from $\mathcal{P}_m(\varepsilon_m)$ and $\mathcal{P}'_m(\varepsilon_m)$.

Proposition A.1 *For every* $\varepsilon_m \in (0, 1/2)$ *, if* $F_1 \varepsilon_m$ *-AmUISD* F_2 *, then* $W_P(F_1) \ge W_P(F_2)$ *for every* $P \in \mathcal{P}_m\left(\varepsilon_m\right)$ *. If* F_1 ε_m *-AmUISD* F_2 *and* Λ_1^j $j_1^j(1) \geq \Lambda_2^j$ $\mathcal{Q}_2^{j}\left(1\right)$ for all $j\,\in\,\left\{3,\ldots,m\right\}$, then $W_P(F_1) \ge W_P(F_2)$ for every $P \in \mathcal{P}'_m(\varepsilon_m)$.

For $m \geq 3$, following Lemma [2.1,](#page-5-0) it is straightforward to show that $F_1 \varepsilon_m$ -AmUISD F_2 if and only if there is $c_m \in [0, \varepsilon_m]$ such that

The following lemma summarizes the properties of the m UISDC $c_m^u(F_1, F_2)$.

Lemma A.1 *The mUISDC* $c_m^u(F_1, F_2)$ *is the smallest* ε_m *in* $[0, 1]$ *such that* [\(A.1\)](#page-35-0) *holds. With*

[\(1.1\)](#page-3-0)*, it follows that*

In addition, if $c_m^u(F_1, F_2) \in (0, 1]$ *, then* $c_m^u(F_2, F_1) = 1 - c_m^u(F_1, F_2)$ *.*

According to Lemma [A.1,](#page-36-0) $F_1 \varepsilon_m$ -AmUISD F_2 for all $\varepsilon_m \in [c_m^u(F_1,F_2),1/2)$ if $c_m^u(F_1,F_2)$ < 1/2. On the other hand, $c_m^u(F_1, F_2) > 1/2$ implies that $F_2 \varepsilon_m$ -AmUISD F_1 for all $\varepsilon_m \in [1 - \frac{1}{2}]$ $c_m^u(F_1, F_2), 1/2$). Thus, $c_m^u(F_1, F_2)$ presents the degree of almost upward inverse stochastic dominance relationship between F_1 and F_2 , and provides all ε_m such that the ε_m -AmUISD holds.

Similar to Proposition [2.1,](#page-7-0) Proposition [A.2](#page-37-0) shows the importance of UISDC concerning welfare functions W_P . The smaller the UISDC $c_m^u(F_1, F_2)$ is, the more welfare functions show higher welfare for the distribution F_1 compared to F_2 . With the knowledge of $c_m^u(F_1, F_2)$, we can infer the relationship between F_1 and F_2 based on a class of welfare functions.

A.2 Almost Downward Inverse Stochastic Dominance and Social Welfare

[Aaberge et al.](#page-28-0) [\(2021\)](#page-28-0) introduce the mth-degree downward inverse stochastic dominance

\frac{1}{(m-2)!} \left[(1-p)^{m-2} \int_0^1 F^{-1}(t) dt - \int_p^1 (t-p)^{m-2} F^{-1}(t) dt \right], \quad p \in [0,1].

Definition A.4 *A distribution* F_1 *mth-degree downward inverse stochastically dominates a* distribution F_2 if $\tilde{\Lambda}_1^m(p) \geq \tilde{\Lambda}_2^m(p)$ for all $p \in [0,1]$.

We generalize the downward inverse stochastic dominance in [Aaberge et al.](#page-28-0) [\(2021\)](#page-28-0) to almost downward inverse stochastic dominance.

Definition A.5 *For every* $\varepsilon_m \in [0, 1/2)$ *, the CDF* $F_1 \varepsilon_m$ *-almost mth-degree downward inverse stochastically dominates the CDF* F_2 $(F_1 \varepsilon_m$ -AmDISD F_2), if

and

\tilde{\mathcal{P}}'_{m}(\varepsilon_{m}) = \left\{ P \in \mathcal{P} : P^{(m)} \leq 0, P^{(j)}(0) \leq 0 \text{ for } j \in \{2, \ldots, m-1\}, \text{sup}_{t} \{-P^{(m)}(t)\} \leq \inf_{t} \{-P^{(m)}(t)\} \cdot \left(\frac{1}{\varepsilon_{m}}-1\right) \right\}.
$$

Then the following proposition links AmDISD to the social welfare function W_P with P from $\tilde{\mathcal{P}}_m(\varepsilon_m)$ and $\tilde{\mathcal{P}}'_m(\varepsilon_m)$.

According to Lemma [A.2,](#page-39-1) F_1 ε_m -AmDISD F_2 for all $\varepsilon_m\in [c_m^d(F_1,F_2),1/2)$ if $c_m^d(F_1,F_2)<\infty$ 1/2. Similar to Proposition [2.1,](#page-7-0) Proposition [A.4](#page-40-0) shows the importance of DISDC concerning welfare functions W_P . The smaller the DISDC $c_m^d(F_1,F_2)$ is, the more welfare functions show higher welfare for the distribution F_1 compared to F_2 . With the knowledge of $c_m^d(F_1,F_2)$, we can infer the relationship between F_1 and F_2 based on a class of welfare functions.

B Almost Stochastic Dominance

In this section, we extend our results to almost stochastic dominance. We follow [Tsetlin](#page-32-1) [et al.](#page-32-1) [\(2015\)](#page-32-1) and let u be a decision maker's utility function and $u^{(k)}$ the kth derivative of u. Let F_1 and F_2 be CDFs that are restricted on the support [a, b] such that $F_1(a) = F_2(a) = 0$ and $F_1(b) = F_2(b) = 1$. For $j = 1, 2$ and $k \ge 2$, we define

[Leshno and Levy](#page-31-1) [\(2002,](#page-31-1) Theorem 1) associate ε_1 -AFSD with the class $U_1(\varepsilon_1)$ by showing that for every $\varepsilon_1\in (0,1/2),\ F_1$ ε_1 -AFSD F_2 if and only if $E_{F_1}[u(X)]\ge E_{F_2}[u(X)]$ for all u ∈ $U(\varepsilon_1)$, where E_F denotes the expectation for $X \sim F$. As pointed out by [Tsetlin](#page-32-1) [et al.](#page-32-1) [\(2015\)](#page-32-1), ε_1 -AFSD is a weaker version of first-degree stochastic dominance (FSD): ε_1 -AFSD requires that the ratio of the area between F_1 and F_2 for which $F_1 \geq F_2$ (i.e., $\int_{S_1(F_1,F_2)}(F_1\left(x\right)-F_2\left(x\right))\mathrm{d}x$) to the total area between F_1 and F_2 (i.e., $\int_a^b\left|F_1\left(x\right)-F_2\left(x\right)\right|\mathrm{d}x$) is less than or equal to ε_1 ; FSD requires that this ratio is zero, i.e., $\int_{S_1(F_1,F_2)} (F_1(x) F_2(x)dx = 0$. It is interesting to figure out the smallest value of ε_1 such that [\(B.1\)](#page-47-0) holds. According to Lemma [B.1,](#page-49-0) $F_1 \varepsilon_m$ -AmSD F_2 for all $\varepsilon_m \in [c_m(F_1, F_2), 1/2)$ if $c_m(F_1, F_2)$ < 1/2. On the other hand, $c_m(F_1, F_2) > 1/2$ implies that $F_2 \varepsilon_m$ -AmSD F_1 for all $\varepsilon_m \in$ $[1 - c_m(F_1, F_2), 1/2)$. Similar to Proposition 2.1 , Proposition [B.1](#page-49-1) shows the importance of SDC concerning utility functions. The smaller the SDC $c_m(F_1, F_2)$ is, the more utility functions show higher expected utility for the distribution F_1 compared to F_2 . With the knowledge of $c_m(F_1, F_2)$, we can infer the relationship between F_1 and F_2 based on a class of utility functions.

B.1 Estimation and Inference

Next, we provide an approach of estimating $c_m(F_1, F_2)$ and conducting inference on it.

C Additional Simulation Evidence

In this section, we provide additional simulation results for ISDCs and SDCs.

C.1 Inverse Stochastic Dominance Coefficient

We consider simulations for 3UISDC. In each iteration of the simulations for 3UISDC, the data $\{X_i^1\}_{i=1}^{n_1}$ are generated independently from $dP(2.1, 1.5)$, and the data $\{X_i^2\}_{i=1}^{n_2}$ are

generated independently from $dP(200, \beta)$, whose law is parametrized by β . We let $\beta \in$ $\{2.2, 2.3, 2.4, 2.5\}$. Figure [C.1](#page-56-0) displays the curves Λ_1^3 and $\Lambda_{2(\beta)}^3$ corresponding to the above DGPs. The 3UISDC $c_3^u(F_1,F_2) = 0.06229, 0.14052, 0.26581,$ and 0.42840, respectively, for $\beta =$ 2.2, 2.3, 2.4, and 2.5. We choose the tuning parameter from $t_n \in (0, 20]$. For independent samples, we let

 $(n_1, n_2) \in \{(200, 200), (200, 500), (200, 1000), (1000, 2000), (10000, 10000)\}.$

For matched pairs, we let

 $(n_1, n_2) \in \{(200, 200), (500, 500), (1000, 1000), (2000, 2000), (10000, 10000)\}.$

Tables [C.1](#page-57-0) and [C.2](#page-58-0) show the simulation results for independent samples and matched pairs. For all the DGPs, as n_1 and n_2 increase, Mean gets close to $c_3^u(F_1,F_2)$, Bias decreases to 0, and both SE and RMSE decrease; under appropriate choices of t_n , CR approaches to 95%.

C.2 Stochastic Dominance Coefficient

Mean gets close to $c_1(F_1, F_2)$, Bias decreases to 0, and both SE and RMSE decrease; under appropriate choices of t_n , CR approaches to 95%.

C.3 Tuning Parameter Selection

In the above simulations, we compute the confidence intervals for all t_n from some prespecified set and display the values that yield the best results. We now propose an empirical way of selecting t_n in practice. Let t_n be selected from a set S_t which is sufficiently large. Suppose that we observe the data $\{X_i^1\}_{i=1}^{n_1}$ and $\{X_i^2\}_{i=1}^{n_2}$. We then take the empirical distributions of $\{X_i^1\}_{i=1}^{n_1}$ and $\{X_i^2\}_{i=1}^{n_2}$ as the DGP to generate the data in the simulations and compute the dominance coefficient c based on the empirical distributions of $\{X_i^1\}_{i=1}^{n_1}$ and $\{X_i^2\}_{i=1}^{n_2}$. We take this c as the true value of the coefficient we are interested in. Then we follow the previous simulation procedure to compute the bootstrap confidence intervals for every value of t_n . Finally, we pick the value t_n which yields the coverage rate that is

For $j = 1$ and $j' = 2$, $E[\mathcal{B}_1(t_1) \mathcal{B}_2(t_2)] = \mathbf{C}(t_1, t_2) - t_1 t_2$. By Theorem 3.1 of [Lo](#page-78-1) [\(2017\)](#page-78-1) (see also [Cuadras](#page-78-2) [\(2002\)](#page-78-2) and [Beare](#page-78-3) [\(2009\)](#page-78-3)),

For $j = j'$, $E[\mathcal{B}_j(t_1) \mathcal{B}_j(t_2)] = t_1 \wedge t_2 - t_1 t_2$. By Theorem 3.1 of [Lo](#page-78-1) [\(2017\)](#page-78-1) again,

Proof of Lemma [2.6.](#page-18-1) The results follow from the continuous mapping theorem and Fubini's theorem (see, for example, Theorem 2.37 of [Folland](#page-30-0) [\(1999\)](#page-30-0)). \blacksquare

Proof of Proposition [2.6.](#page-19-0) For simplicity of notation, we focus on the case where $m = 1$. The proof of general results for $m \geq 2$ and $w \in \{u, d\}$ is similar. &=\left|\frac{\hat{\mathcal{F}}'_{1\phi}\left(h_{1}\right)\mathcal{F}_{2}\left(\hat{\phi}\right)-\mathcal{F}_{1}\left(\hat{\phi}\right)\hat{\mathcal{F}}'_{2\phi}\left(h_{1}\right)}{\left(\mathcal{F}_{1}\left(\hat{\phi}\right)+\mathcal{F}_{2}\left(\hat{\phi}\right)\right)^{2}}-\frac{\hat{\mathcal{F}}'_{1\phi}\left(h_{2}\right)\mathcal{F}_{2}\left(\hat{\phi}\right)-\mathcal{F}_{1}\left(\hat{\phi}\right)\hat{\mathcal{F}}'_{2\phi}\left(h_{2}\right)}{\left(\mathcal{F}_{1}\left(\hat{\phi}\right)+\mathcal{F}_{2}\left(\hat{\phi}\right)\right)^{2}}\right|\n\leq &\frac{\left|\left|\mathcal{F}_{2}\left(\hat{\phi}\right)\right|\left|\hat{\mathcal{F}}'_{1\phi}\left(h_{1}\right)-\hat{\mathcal{F}}'_{1\phi}\left(h_{2}\right)\right|+\left|\mathcal{F}_{1}\left(\hat{\phi}\right)\right|\left|\hat{\mathcal{F}}'_{2\phi}\left(h_{1}\right)-\hat{\mathcal{F}}'_{2\phi}\left(h_{2}\right)\right|\right|}{\left(\mathcal{F}_{1}\left(\hat{\phi}\right)+\mathcal{F}_{2}\left(\hat{\phi}\right)\right)^{2}}\leq C_{n}\left\|h_{1}-h_{2}\right\|_{\infty}.\n\end{split}
$$

Also, since $\hat{\mathcal{F}}'_{1\phi}\left(h\right)\to_{p}\mathcal{F}'_{1\phi}\left(h\right)$ and $\hat{\mathcal{F}}'_{2\phi}\left(h\right)\to_{p}\mathcal{F}'_{2\phi}\left(h\right)$ for every $h\in C$ ([0, 1]), then we have $\hat{\mathcal{F}}_\phi'(h) \to_p \mathcal{F}_\phi'(h)$. By Remark 3.4 of [Fang and Santos](#page-30-0) [\(2019\)](#page-30-0), Assumption 4 of [Fang and](#page-30-0) [Santos](#page-30-0) [\(2019\)](#page-30-0) holds.

By a proof similar to that of Theorem S.1.1 in [Fang and Santos](#page-30-0) [\(2019\)](#page-30-0), we can show that

$$
\hat{c}_{1-\alpha/2} \rightarrow_p c_{1-\alpha/2}
$$
 and $\hat{c}_{\alpha/2} \rightarrow_p c_{\alpha/2}$.

By Proposition [2.6](#page-19-0) in the paper and Example 1.4.7 (Slutsky's lemma), Theorem 1.3.6 (continuous mapping), and Theorem 1.3.4(vi) of [van der Vaart and Wellner](#page-32-0) [\(1996\)](#page-32-0),

$$
\lim_{n \to \infty} \mathbb{P}\left(\sqrt{T_n} \left(\hat{c}\left(L_1, L_2\right) - c\left(L_1, L_2\right)\right) > \hat{c}_{1-\alpha/2}\right) = \alpha/2
$$

and

$$
\lim_{n\to\infty}\mathbb{P}\left(\sqrt{T_n}\left(\hat{c}\left(L_1,L_2\right)-c\left(L_1,L_2\right)\right)<\hat{c}_{\alpha/2}\right)=\alpha/2,
$$

which imply that

$$
\lim_{n\to\infty} \mathbb{P}\left(\sqrt{T_n}\left(\hat{c}\left(L_1, L_2\right) - c\left(L_1, L_2\right)\right) \in \left[\hat{c}_{\alpha/2}, \hat{c}_{1-\alpha/2}\right]\right) = 1 - \alpha,
$$

or equivalently

$$
\lim_{n \to \infty} \mathbb{P}\left(c\left(L_1, L_2\right) \in \left[\hat{c}\left(L_1, L_2\right) - T_n^{-1/2} \hat{c}_{1-\alpha/2}, \hat{c}\left(L_1, L_2\right) - T_n^{-1/2} \hat{c}_{\alpha/2}\right]\right) = 1 - \alpha.
$$

= $-P^{(2)}(1) (\Lambda_1^3(1) - \Lambda_2^3(1)) + \int_0^1 P^{(3)}(t) d\Lambda_1^4(t) - \int_0^1 P^{(3)}(t) d\Lambda_2^4(t)$
= $-P^{(2)}(1) (\Lambda_1^3(1) - \Lambda_2^3(1)) + P^{(3)}(t) (\Lambda_1^4(t) - \Lambda_2^4(t)) |_0^1 - \int_0^1 P^{(4)}(t) (\Lambda_1^4(t) - \Lambda_2^4(t)) dt$
= $\sum_{j=3}^m (-1)^{j-2} P^{(j-1)}(1) (\Lambda_1^j(1) - \Lambda_2^j(1)) + \int_0^1 (-1)^{m-1} P^{(m)}(t) (\Lambda_1^m(t) - \Lambda_2^m(t)) dt.$

The remaining of the proof is similar to that of Proposition [2.2.](#page-9-0) \blacksquare

Proof of Lemma [A.1.](#page-36-1) The proof is similar to that of Lemma [2.2.](#page-6-0) ■

Proof of Proposition [A.2.](#page-37-0) The results directly follow from Proposition [A.1](#page-36-0) and Lemma $A.1.$

Proof of Proposition [A.3.](#page-39-0) The proof closely follows the strategies of the proofs of Theorem 1 of [Leshno and Levy](#page-31-0) [\(2002\)](#page-31-0) and Theorem 2.4 of [Aaberge et al.](#page-28-1) [\(2021\)](#page-28-1). By definition, for $m \geq 4$, we have that

\tilde{\Lambda}_j^m(p) = \int_p^1 \tilde{\Lambda}_j^{m-1}(t) dt = \int_0^1 \tilde{\Lambda}_j^{m-1}(t) dt - \int_0^p \tilde{\Lambda}_j^{m-1}(t) dt,
$$

which implies $\mathrm{d}\tilde{\Lambda}_{j}^{m}\left(p\right)/\mathrm{d}p=-\tilde{\Lambda}_{j}^{m-1}\left(p\right).$ Also, we have that

$$
\tilde{\Lambda}_{j}^{3}(p) = \int_{p}^{1} \Lambda_{j}^{2}(t) dt = \int_{0}^{1} \Lambda_{j}^{2}(t) dt - \int_{0}^{p} \Lambda_{j}^{2}(t) dt.
$$

By a strategy similar to that of the proof of Proposition $A.1$, we can show that

$$
W_P(F_1) - W_P(F_2)
$$

= $-P^{(2)}(0) (\tilde{\Lambda}_1^3(0) - \tilde{\Lambda}_2^3(0)) + \int_0^1 P^{(3)}(t) d\tilde{\Lambda}_1^4(t) - \int_0^1 P^{(3)}(t) d\tilde{\Lambda}_2^4(t)$
= $\sum_{j=3}^m -P^{(j-1)}(0) (\tilde{\Lambda}_1^j(0) - \tilde{\Lambda}_2^j(0)) + \int_0^1 -P^{(m)}(t) (\tilde{\Lambda}_1^m(t) - \tilde{\Lambda}_2^m(t)) dt.$

The remaining of the proof is similar to that of Proposition [2.4.](#page-12-0) \blacksquare

For matched pairs, let $\mathcal{H}_1 = \{1_{[a,x] \times [a,b]} : x \in [a,b]\}, \, \mathcal{H}_2 = \{1_{[a,b] \times [a,x]} : x \in [a,b]\},$ and $\mathcal{H} =$ $\mathcal{H}_1 \cup \mathcal{H}_2$. Define

$$
\hat{G}_n(f) = \sqrt{n} \left\{ \frac{1}{n} \sum_{i=1}^n f(X_i, Y_i) - E[f(X_i, Y_i)] \right\}
$$

for every $f \in \mathcal{H}$. Since \mathcal{H}_1 and \mathcal{H}_2 are both Donsker classes, by Example 2.10.7 of [van der](#page-32-0) [Vaart and Wellner](#page-32-0) [\(1996\)](#page-32-0), $\hat G_n \leadsto \mathbb G$ in $\ell^\infty(\mathcal H)$ for some zero-mean Gaussian process $\mathbb G.$ Define a map T such that for every $\psi \in \ell^{\infty}(\mathcal{H})$ and every $x \in [a, b]$,

$$
T(\psi)(x) = \begin{pmatrix} \psi\left(1_{[a,x]\times[a,b]}\right) \\ \psi\left(1_{[a,b]\times[a,x]}\right) \end{pmatrix}.
$$

Then by continuous mapping theorem,

$$
T\left(\hat{G}_n\right) = \begin{pmatrix} \sqrt{n}\{\hat{F}_1 - F_1\} \\ \sqrt{n}\{\hat{F}_2 - F_2\} \end{pmatrix} \rightsquigarrow T\left(\mathbb{G}\right),
$$

where for every $x \in [a, b]$,

$$
T\left(\mathbb{G}\right)(x)=\begin{pmatrix} \mathbb{G}\left(1_{[a,x]\times[a,b]}\right) \\ \mathbb{G}\left(1_{[a,b]\times[a,x]}\right) \end{pmatrix}.
$$

By continuous mapping theorem again, we obtain that

$$
\sqrt{T_n}\left\{(\hat{F}_1-\hat{F}_2)-(F_1-F_2)\right\} \rightsquigarrow \mathbb{G}_F,
$$

where for every $x \in [a, b]$,

$$
\mathbb{G}_F(x) = \sqrt{1 - \lambda} \mathbb{G}\left(1_{[a,x] \times [a,b]}\right) - \sqrt{\lambda} \mathbb{G}\left(1_{[a,b] \times [a,x]}\right)
$$

with $\lambda = 1/2$. Then it is easy to show that for all $x, x' \in [a, b]$,

$$
E\left[\mathbb{G}_{F}(x)\,\mathbb{G}_{F}(x')\right]
$$
\n
$$
= (1 - \lambda) E\left[\mathbb{G}\left(1_{[a,x]\times[a,b]}\right)\mathbb{G}\left(1_{[a,x']\times[a,b]}\right)\right] - \sqrt{\lambda(1 - \lambda)}E\left[\mathbb{G}\left(1_{[a,x]\times[a,b]}\right)\mathbb{G}\left(1_{[a,b]\times[a,x']}\right)\right]
$$
\n
$$
- \sqrt{\lambda(1 - \lambda)}E\left[\mathbb{G}\left(1_{[a,b]\times[a,x]}\right)\mathbb{G}\left(1_{[a,x']\times[a,b]}\right)\right] + \lambda E\left[\mathbb{G}\left(1_{[a,b]\times[a,x]}\right)\mathbb{G}\left(1_{[a,b]\times[a,x']}\right)\right]
$$
\n
$$
= (1 - \lambda) F_{1}(x \wedge x') - (1 - \lambda) F_{1}(x) F_{1}(x') - \sqrt{\lambda(1 - \lambda)} F_{12}(x, x')
$$
\n
$$
+ \sqrt{\lambda(1 - \lambda)} F_{1}(x) F_{2}(x') - \sqrt{\lambda(1 - \lambda)} F_{12}(x', x) + \sqrt{\lambda(1 - \lambda)} F_{1}(x') F_{2}(x)
$$
\n
$$
+ \lambda F_{2}(x \wedge x') - \lambda F_{2}(x) F_{2}(x').
$$

Proof of Proposition [B.2.](#page-51-1) As shown in Lemma [B.2,](#page-51-0)

$$
\sqrt{T_n}\left\{(\hat{F}_1-\hat{F}_2)-(F_1-F_2)\right\} \rightsquigarrow \mathbb{G}_F.
$$

Then by the linearity and continuity of \mathcal{I}_m defined in [\(B.7\)](#page-50-0) and the continuous mapping theorem, it follows that

\sqrt{T_n} \left(\hat{\phi}_m - \phi_m \right) = \sqrt{T_n} \left\{ \mathcal{I}_m(\hat{F}_1 - \hat{F}_2) - \mathcal{I}_m (F_1 - F_2) \right\}

= $\sqrt{T_n} \mathcal{I}_m \left((\hat{F}_1 - \hat{F}_2) - (F_1 - F_2) \right) \rightsquigarrow \mathcal{I}_m (\mathbb{G}_F) \equiv \mathbb{G}_m.$

For every $x\in [a,b],$

Var\left(\mathbb{G}_{m}(x)\right)=E\left[\left(\mathcal{I}_{m}\left(\mathbb{G}_{F}\right)(x)\right)^{2}\right]-E\left[\mathcal{I}_{m}\left(\mathbb{G}_{F}\right)(x)\right]^{2},
$$

where, by Fubini's theorem (see, for example, Theorem 2.37 of [Folland](#page-30-1) [\(1999\)](#page-30-1)),

E\left[\left(\mathcal{I}_m\left(\mathbb{G}_F\right)(x)\right)^2\right]
$$

= $\int \left(\int_a^x \cdots \int_a^{t_3} \int_a^{t_2} \mathbb{G}_F\left(\omega\right)(t_1) dt_1 dt_2 \cdots dt_{m-1}\right)^2 d\mathbb{P}\left(\omega\right)$
= $\int_a^x \cdots \int_a^{t'_3} \int_a^{t'_2} \left(\int_a^x \cdots \int_a^{t_3} \int_a^{t_2} E\left[\mathbb{G}_F\left(t_1\right) \mathbb{G}_F\left(t'_1\right)\right] dt_1 dt_2 \cdots dt_{m-1}\right) dt'_1 dt'_2 \cdots dt'_{m-1}$

and

$$
E\left[\mathcal{I}_m\left(\mathbb{G}_F\right)(x)\right]=0.
$$

By a proof similar to that of Proposition [2.6,](#page-19-0) we can show the weak convergence

$$
\sqrt{T_n} \left\{ \hat{c}_m \left(F_1, F_2 \right) - c_m \left(F_1, F_2 \right) \right\} \rightsquigarrow \mathcal{F}'_{\phi_m} \left(\mathbb{G}_m \right).
$$
