Symmetries in Riemann-Cartan geometries

Abstract

Riemann-Cartan geometries are metric based geometries admitting a non-zero torsion tensor. These geometries have been investigated as geometric frameworks for potential theories in physics including quantum gravity theories and have many important differences when compared to Riemannian geometries. One notable difference, is the number of symmetries for a Riemann-Cartan geometry is potentially smaller than the number of Killing vector fields for the metric. In this paper we will review the investigation of symmetries in Riemann-Cartan geometries and the mathematical tools used to determine geometries that admit a given group of symmetries. As an illustration we will determine all static spherically symmetric and all stationary spherically symmetric Riemann-Cartan geometries. Further, we will determine the subclasses of spherically symmetric Riemann-Cartan geometries that admit a seven-dimensional group of symmetries.

I. INTRODUCTION

Riemann-Cartan geometry is a generalization of Riemannian geometry where the nonmetric connection associated with covariant differentiation, ∇ , is still required to be metric compatible. Therefore, the metric, \mathbf{g} , is constant under covariant differentiation, $\nabla \mathbf{g}(\mathbf{X}, \mathbf{Y}) = 0$, but ∇ is no longer torsion-free. That is, the connection admits a non-zero tensor:

$$T(X, Y) = \nabla_X Y - \nabla_Y X - \mathcal{L}_X Y \neq 0, \tag{1}$$

where $\mathcal{L}_{\mathbf{X}}$ denotes the Lie derivative with respect to \mathbf{X} . By allowing a non-trivial torsion, the connection is no longer guaranteed to be uniquely defined in terms of the metric, unlike the Levi-Civita connection in Riemannian geometry. However, given a torsion tensor, the connection can be uniquely specified by taking the Levi-Civita connection and adding the contorsion tensor, which is constructed from the torsion tensor, using index notation as [1]

$$K_{abc} = \frac{1}{2} (T_{abc} + T_{bca} + T_{cab}). \tag{2}$$

If the torsion tensor is unspecified, the choice of connection cannot be specified uniquely and this freedom in the connection can complicate characterizing Riemann-Cartan geometries.

Despite this complication, we will denote a Riemann-Cartan geometry, as a triple $(M, \mathbf{g}, \boldsymbol{\omega})$ where M is the manifold, \mathbf{g} is the metric, and $\boldsymbol{\omega}$ is the metric-compatible connection defining ∇ .

The motivation for studying Riemann-Cartan geometries includes torsion based theories of gravitation, such as the Einstein-Cartan theory of gravitation, where torsion is associated with the intrinsic angular momentum [1, 2]. This association is partially motivated by the search for a quantum theory of gravity and the unification of gravity with other fundamental interactions arising in the quantum domain. Alternatively, within the class of teleparallel gravity theories, the curvature tensor vanishes and all information about the gravitational field is encoded in the torsion tensor and its covariant derivatives. In teleparallel gravity theories, the metric is subsumed by a frame basis as the primary object of study while the affine connection can be computed from some, as yet, arbitrary Lorentz frame transformation contained within the spin connection plus the Weitzenbock connection associated with the frame basis [3].

In any theory of gravity, it is important to determine solutions that reflect our physical Universe. However, due to the freedom in the choice of the connection, generating physically meaningful solutions in Riemann-Cartan geometry is more difficult than in theories of gravity based on Riemann geometry. Furthermore, the Ricci tensor is no longer necessarily symmetric, and depending on the gravity theory, the requirement that Ricci tensor is related to a symmetric energy momentum tensor will impose additional conditions that must satisfied [4].

Symmetries and symmetry methods are powerful tools in the analysis of complex mathematical and physical problems. Techniques based on symmetry have been used in General Relativity (GR) to produce meaningful solutions with closed form expressions. An important example of this is the Schwarzschild solution, which describes a spherically symmetric mass in vacuum and provides the simplest model for a vacuum black hole solution in GR. This was accomplished by requiring that the solution has spherical symmetry constraining the metric and curvature, which contains all of the information about the gravitational field within GR.

To illustrate, we note that any continuous symmetry can be generated by an infinitesimal

vector field, X, and if the metric, g, is invariant under such a symmetry then

$$\mathcal{L}_{\mathbf{X}}\mathbf{g} = 0. \tag{3}$$

The resulting first order linear partial differential equations are known as the Killing equations whose solutions are Killing symmetries or isometries. The study of Killing symmetries is well understood and they have been used to find a wealth of solutions in GR [5].

While GR is based on Riemannian geometry, where symmetry techniques have been established, in the case of alternative theories of gravity which are not based on Riemannian geometry, less is known. Symmetries and application of symmetry techniques are currently under development, particularly in teleparallel gravity [6–10]. Here, we are interested in using symmetry techniques to determine the constraints on the geometrical framework in Rieman-Cartan geometries, where many of the approaches in teleparallel gravity no longer apply.

The introduction of a non-vanishing torsion tensor introduces additional conditions for a symmetry generator, \mathbf{X} ; namely

$$\mathcal{L}_{\mathbf{X}}\mathbf{g} = 0, \quad \mathcal{L}_{\mathbf{X}}\mathbf{T} = 0,$$
 (4)

and these conditions can complicate the symmetry techniques used in GR. Any symmetry satisfying these conditions will be called an affine frame symmetry. For example, it has already been shown that the only Riemann-Cartan geometry that admits a maximal number of affine frame symmetries is Minkowski space in which the torsion vanishes [7]. Furthermore, any Riemann-Cartan geometry with non-zero torsion admits at most a seven-dimensional affine frame symmetry group [7]. If the metric and torsion tensor is given, equation (4) is sufficient to determine if a vector field \mathbf{X} is an affine frame symmetry, even if the symmetry group admits non-trivial isotropy. However, if instead one wishes to determine the most general class of Riemann-Cartan geometries which admits a given Lie group as a symmetry group, equation (4) leads to a significantly more difficult problem. However, by switching to a frame-based perspective, this problem can be answered for any symmetry group. More concretely, in metric-affine theories, the quantities in equation (4) can instead be represented in terms of the fundamental variables, the metric \mathbf{g} , the frame basis $\{\mathbf{h}^a\}$ and the connection, $\boldsymbol{\omega}$ [11].

In this paper we will review the current frame based symmetry techniques in Riemann-Cartan geometry, namely the affine frame symmetry approach [10] and the Cartan-Karlhede

algorithm. Using these tools we will summarize the construction of spherically symmetric Riemann-Cartan geometries, specialize to static spherically symmetric and stationary spherically symmetric Riemann-Cartan geometries and determine the subclasses of spherically symmetric Riemann-Cartan geometries that admit a seven-dimensional affine frame symmetry group.

A. Notation

Coordinate indices will be denoted by μ, ν, \ldots while tangent space indices will be denoted by a, b, \ldots . The spacetime coordinates will be x^{μ} , unless specified otherwise. The frame fields are denoted as \mathbf{h}_a and the dual coframe one-forms are \mathbf{h}^a . Then relative to a coordinate basis, the vielbein components are h_a^{μ} or h_{μ}^a . The spacetime metric will be denoted as $g_{\mu\nu}$ while the Minkowski tangent space metric is η_{ab} .

To denote a local Lorentz transformation leaving η_{ab} invariant, we will write $\Lambda_a^b(x^\mu)$ and $\Lambda_b^a = (\Lambda^{-1})_a^b$ as its inverse transformation. The connection one-form ω_b^a , is defined as $\omega_b^a = \omega_{bc}^a \mathbf{h}^c$, and the metric-compatibility condition implies that the first two lowered indices are anti-symmetric. The curvature and torsion tensors will be denoted, respectively, as R_{bcd}^a and T_{bc}^a .

Relative to a frame basis, $\{\mathbf{h}_a\}$, covariant derivatives with respect to a basis element will be denoted as $\nabla_a \equiv \nabla_{\mathbf{h}_a}$. Covariant derivatives with respect to a metric-compatible connection will be denoted using a semi-colon, $T_{abc;e}$. Integral curves of a vector field \mathbf{X} , with parameter τ , will be denoted as $\phi_{\tau}: M \to M$ and we will write the corresponding Lorentz frame transformation as $\phi_{\tau}^* \mathbf{h}^a = \Lambda_{(\tau)}^a{}_b \mathbf{h}^b$.

Due to the variety of commutator relations used in the affine frame symmetry formalism, we will use different indices to distinguish them. The commutators of the affine frame symmetry generators, $\{\mathbf{X}_I\}$ are $[\mathbf{X}_I, \mathbf{X}_J] = C^K_{\ IJ} \mathbf{X}_K$. The Lie algebra representations of the isotropy group, $\lambda_{\hat{i}} = \lambda^a_{\ \hat{i}b}$ are $[\lambda_{\hat{i}}, \lambda_{\hat{j}}] = C^{\hat{k}}_{\ \hat{i}\ \hat{j}} \lambda_{\hat{k}}$. Finally the commutator of the frames will be denoted as $[\mathbf{h}_a, \mathbf{h}_b] = c^c_{\ ab} \mathbf{h}_c$.

II. RIEMANN-CARTAN GEOMETRIES

Let M be a four-dimensional (4D) smooth manifold with coordinates, x^{μ} , with a nondegenerate coframe field \mathbf{h}^a defined on a subset $U \subset M$. We assume M is equipped with a symmetric metric field, g_{ab} , derived from the coframe fields to determine lengths and angles. Lastly, we require a notion of parallel transport and assume the existence of a linear affine connection one-form $\boldsymbol{\omega}^a_b$. From the perspective of metric-affine theories, of which includes Riemann-Cartan geometry, the geometrical quantities, g_{ab} , \mathbf{h}^a and $\boldsymbol{\omega}^a_b$, are independent quantities with 10, 16, and 64 independent elements, respectively [11]. We will assume that our geometrical framework is invariant under the group of linear transformations of the frame, $GL(4,\mathbb{R})$. Further, we shall assume that the connection is compatible with the metric. These two assumptions impose constraints on the derived geometrical quantities.

A. Gauge choices

A choice of gauge will refer to the choice of basis for the tangent space. Using the $GL(4,\mathbb{R})$ gauge we can use the freedom in the tangent space to diagonalize the symmetric metric, $g_{ab} = \eta_{ab} = \text{Diag}[-1, 1, 1, 1]$, with respect to the coframe, $\{\mathbf{h}^a\} = \{\mathbf{u}, \mathbf{x}, \mathbf{y}, \mathbf{z}\}$; this is known as the **Orthonormal gauge**. In this paper, $\{\mathbf{h}^a\}$ will always denote a frame basis in the orthonormal gauge.

There exists a subgroup of $GL(4,\mathbb{R})$ of residual gauge transformations that leave the form of the metric unchanged. This subgroup is the orthogonal group, O(1,3), under various representations. Due to physical motivations, we will require that the orientation of space and the direction of time cannot be changed. This constraint restricts the remaining gauge transformation from this subgroup to be the proper orthochronous Lorentz subgroup, $SO^*(1,3)$ of O(1,3). We will denote the action of the Lorentz group on the coframe as:

$$\mathbf{h}^a \to \Lambda^a_{b} \mathbf{h'}^b$$
.

In the orthonormal gauge, the metric is completely fixed and only the coframe and connection are independent dynamical variables yielding 16+64=80 independent elements, with a remaining 6 dimensional $SO^*(1,3)$ gauge freedom. To obtain a Riemann-Cartan geometry, we impose the assumption that the connection be metric compatible, i.e., $Q_{abc} \equiv -\nabla_c g_{ab} = -\nabla_c g_{ab}$

0, whence the connection becomes anti-symmetric, $\omega_{(ab)} = 0$. Due to the algebraic nature of this constraint, it can be implemented easily without loss of generality.

The fundamental variables remaining are the 16 elements of the coframe \mathbf{h}^a and the 24 elements of the anti-symmetric connection one-form $\boldsymbol{\omega}^a_{\ b}$. In terms of these quantities, the torsion tensor is of the form:

$$T^{a}_{bc} = \omega^{a}_{cb} - \omega^{a}_{bc} - c^{a}_{bc}, \tag{5}$$

where $[\mathbf{h}_c, \mathbf{h}_d] = c^e_{cd} \mathbf{h}_e$ and c^e_{cd} are the coefficients of anholonomy for the frame \mathbf{h}_a . The torsion tensor can be decomposed into three irreducible parts under the local Lorentz group [11]:

$$T_{abc} = \frac{2}{3}(t_{abc} - t_{acb}) - \frac{1}{3}(g_{ab}V_c - g_{ac}V_b) + \epsilon_{abcd}A^d.$$
 (6)

Here V denotes the vector part which is the trace of the torsion tensor:

$$V_a = T^b_{ba}, (7)$$

Lowering the index of the torsion tensor and applying the Hodge dual of the resulting tensor gives the axial part, **A**:

$$A^a = \frac{1}{6} \epsilon^{abcd} T_{bcd}. \tag{8}$$

Finally, we can construct the purely tensorial part, t:

$$t_{(ab)c} = \frac{1}{2}(T_{abc} + T_{bac}) - \frac{1}{6}(g_{ca}V_b + g_{cb}V_a) + \frac{1}{3}g_{ab}V_c.$$
(9)

We will call each of these tensors the *vector part*, *axial part*, *and tensor part* of the torsion tensor. The tensor part satisfies the following identities:

$$g^{ab}t_{(ab)c} = 0, \ t_{(ab)c} = t_{(ba)c}, \ t_{(ab)c} + t_{(bc)a} + t_{(ca)b} = 0.$$
 (10)

In a similar manner, the curvature tensor associated with the coframe and connection is defined as:

$$R^{a}_{bcd} = \mathbf{h}_{c}[\omega^{a}_{bd}] - \mathbf{h}_{d}[\omega^{a}_{bc}] + \omega^{e}_{bd}\omega^{a}_{ec} - \omega^{e}_{bc}\omega^{a}_{ed} - c^{e}_{cd}\omega^{a}_{be}. \tag{11}$$

where $[\mathbf{h}_c, \mathbf{h}_d] = c^e_{cd} \mathbf{h}_e$ and c^e_{cd} are, again, the coefficients of anholonomy for the frame \mathbf{h}_a . This tensor can be decomposed into three parts: the Weyl tensor, the trace-free Ricci tensor and the Ricci scalar. We will consider the following decomposition:

$$R_{abcd} = C_{abcd} + g_{a[c}R_{d]b} - g_{b[c}R_{d]a} - \frac{1}{3}Rg_{a[c}g_{d]b}.$$
 (12)

These tensors are respectively, the Ricci tensor

$$R_{ab} = R^e_{aeb}, (13)$$

the Ricci scalar,

$$R = R^a_{\ a},\tag{14}$$

and the trace-free Weyl tensor,

$$C_{abcd} = R_{abcd} - g_{a[c}R_{d]b} + g_{b[c}R_{d]a} + \frac{1}{3}Rg_{a[c}g_{d]b}.$$
 (15)

The trace-free Ricci tensor is then defined as $S_{ab} = R_{ab} - \frac{1}{4}Rg_{ab}$.

III. THE CARTAN-KARLHEDE ALGORITHM AND THE DIMENSION OF SYMMETRY GROUPS

The Cartan-Karlhede (CK) algorithm iteratively fixes a frame in an invariant manner by choosing canonical forms for the curvature tensor, the torsion tensor and their covariant derivatives. At the conclusion of the algorithm, the components of these tensors will be invariants for the geometry. To write the algorithm compactly, we will write \mathcal{R}^q and \mathcal{T}^q to denote the set of components of the curvature tensor and its covariant derivatives up to the qth order, and the set of components of the torsion tensor and its covariant derivatives up to the qth order, respectively.

The CK algorithm is then [7, 12]:

- 1. Set the order of differentiation q to 0.
- 2. Calculate \mathcal{R}^q and \mathcal{T}^q .
- 3. Determine the canonical form of the q-th covariant derivative of the curvature tensor and the torsion tensor.
- 4. Fix the frame as much as possible, using this canonical form, and record the remaining frame transformations that preserve this canonical form (the group of allowed frame transformations is the *linear isotropy group* H_q).

- 5. Find the number t_q of independent functions of coordinates, x^{μ} , in \mathcal{T}^q and \mathcal{R}^q in the canonical form.
- 6. If the dimension of H_q and number of independent functions are the same as in the previous step, let p + 1 = q, and the algorithm terminates; if they differ (or if q = 0), increase q by 1 and go to step 2.

If $dim(H_p) \neq 0$, the frame resulting from the CK algorithm is known as an *invariantly* defined frame fixed completely up to linear isotropy. While if H_p is the trivial group, so that $dim(H_p) = 0$, we say that the frame is an *invariant frame*. Relative to the frame determined by the algorithm, the non-zero components of \mathcal{R}^q and \mathcal{T}^q are then the set of Cartan invariants and we will denote them as $\mathcal{R} \equiv \mathcal{R}^{p+1}$ and $\mathcal{T} \equiv \mathcal{T}^{p+1}$.

In addition to these invariants, there are two sequences of discrete invariants: the dimension of the linear isotropy group, $dim\ H_q$ at each iteration, q, and the number of functionally independent components of the curvature tensor, torsion tensor and their covariant derivatives up to order q, denoted as t_q . The linear isotropy group, H_q is a subgroup of the Lorentz frame transformations that do not change the form of the curvature tensor, the torsion tensor and their covariant derivatives up to q^{th} order. Assuming the frame basis and connection are sufficiently smooth, the 4D spacetime is uniquely locally characterized by these two discrete sequences and the values of the (non-zero) Cartan invariants up to order q which provides classifying functions.

The CK algorithm provides a straightforward approach to determining the number of symmetries of a Riemann-Cartan geometry. Since there are t_p functionally independent invariants, they can be treated as essential coordinates, $x^{\alpha'}$. Then, the remaining $4 - t_p$ coordinates $x^{\tilde{\alpha}}$ are ignorable, and so the dimension of the affine frame symmetry isotropy group (hereafter called the isotropy group) of the spacetime will be $s = \dim(H_p)$ and the affine frame symmetry group has dimension:

$$r = s + 4 - t_p. \tag{16}$$

1. Lorentz frame transformations

Any Lorentz frame transformation can be constructed in an orthonormal frame by combining boosts in planes spanned by the timelike direction and a spacelike direction, with spatial rotations in planes spanned by two spacelike directions.

We will briefly describe boost and rotations using two examples. For an orthonormal frame, if we consider a boost in the $\mathbf{u} - \mathbf{x}$ plane, with real-valued parameter B, the resulting transformation is then

$$\mathbf{u}' = \frac{B^2 + 1}{2B}\mathbf{u} + \frac{B^2 - 1}{2B}\mathbf{x},$$

$$\mathbf{x}' = \frac{B^2 - 1}{2B}\mathbf{u} + \frac{B^2 + 1}{2B}\mathbf{x},$$

$$\mathbf{y}' = \mathbf{y}, \ \mathbf{z}' = \mathbf{z}.$$
(17)

Similarly, a rotation in the $\mathbf{y} - \mathbf{z}$ plane, with parameter Θ is then

$$\mathbf{u}' = \mathbf{u}, \ \mathbf{x}' = \mathbf{x}'$$

$$\mathbf{y}' = \cos(\Theta)\mathbf{y} + \sin(\Theta)\mathbf{z},$$

$$\mathbf{z}' = -\sin(\Theta)\mathbf{v} + \cos(\Theta)\mathbf{z}.$$
(18)

IV. AFFINE FRAME SYMMETRIES WITH ISOTROPY

To discuss symmetries for a given Riemann-Cartan geometry, $(M, \mathbf{g}, \boldsymbol{\omega})$ in a frame context, we will consider the frame generated at the conclusion of the CK algorithm. The linear isotropy group H_p encodes the freedom in specifying an invariantly defined (co)frame. That is, the CK algorithm produces an invariantly defined (co)frame, \mathbf{h}^a , up to linear isotropy H_p such that for any diffeomorphism, $\phi: M \to M$, the invariantly defined (co)frame satisfies:

$$\phi^* \mathbf{h}^a = \Lambda^a_{\ b} \mathbf{h}^b, \tag{19}$$

where Λ^a_b belongs to H_p and arises from the coordinate form of ϕ , i.e., $y^{\mu} = \phi^{\mu}(x^{\nu})$ [13]. If $\phi = \phi_{\tau}$ is generated by exponentiating the vector field which locally represents an infinitesimal generator of an affine frame symmetry, \mathbf{X} , with some parameter, τ , then we can calculate the effect of the Lie derivative of \mathbf{X} on the frame as

$$\mathcal{L}_{\mathbf{X}}\mathbf{h}^a = \lambda^a_{\ b}\mathbf{h}^b,\tag{20}$$

where $\lambda^a_{\ b}$ is the Lie algebra generator for $\Lambda^a_{(\tau)\ b}$ associated with ϕ_{τ} . By using an invariantly defined frame, up to the linear isotropy group, we have reduced the number of unknown

functions in λ^a_b and restricted their functional dependence to only those coordinates which are affected by ϕ_{τ} . Recall, to distinguish between those coordinates which are affected or unaffected by the affine frame symmetry generators we employ $x^{\alpha'}$ and $x^{\tilde{\alpha}}$, respectively.

In addition to the frame, we must consider the effect of the affine frame symmetry on the metric-compatible connection one-form $\boldsymbol{\omega}^a_{\ b} = \omega^a_{\ bc} \mathbf{h}^c$, where $\boldsymbol{\omega}_{ab} = -\boldsymbol{\omega}_{ba}$. If \mathbf{X} is an infinitesimal generator of an affine frame symmetry for the geometry then it must also be an affine collineation [14]:

$$\left(\mathcal{L}_{\mathbf{X}}\boldsymbol{\omega}\right)_{bc}^{a} = 0. \tag{21}$$

From the conditions (20) and (21) it follows that the Lie derivative of the curvature tensor, the torsion tensor and its covariant derivatives with respect to \mathbf{X} will vanish. Hence this definition of an affine frame symmetry is necessary and sufficient to generate an affine frame symmetry of the Riemann-Cartan geometry, and we introduce the following definition

Definition IV.1. An *affine frame symmetry* generator is a vector-field satisfying equations (20) and (21).

Note that if $\lambda^a_b = 0$, then the original definition of an affine frame symmetry in [7] is recovered. That is, the linear isotropy group is trivial and the frame resulting from the CK algorithm is an invariant frame. In practice, when generating solutions, the above definition is not practical, as one requires knowledge of the curvature tensor, the torsion tensor and their covariant derivatives in order to determine the parameters of the Lorentz transformations.

We will instead consider a more general class of frames. These frames are acted on by the Lie algebra generators of the isotropy group under Lie differentiation with the affine frame symmetry generators.

Definition IV.2. Consider a Riemann-Cartan geometry, $(\mathbf{h}^a, \boldsymbol{\omega}^a_b)$, admitting an affine frame symmetry, \mathbf{X} . The class of **symmetry frames**, \mathbf{h}^a , are those frames that satisfy

$$\mathcal{L}_{\mathbf{X}}\mathbf{h}^{a} = f_{X}^{\ \hat{i}}\lambda_{\hat{i}\ b}^{a}\mathbf{h}^{b},\tag{22}$$

where $f_X^{\hat{i}}(x^{\alpha'})$ are arbitrary functions and $\lambda^a_{\hat{i}b}$ are basis elements of the Lie algebra of the isotropy group (so that $\lambda_{\hat{i}ab} = -\lambda_{\hat{i}ba}$) and \hat{i} ranges from 1 to the dimension of the isotropy group.

The functions, $f_X^{\hat{i}}$, have been introduced to permit the possibility of an arbitrary infinitesimal generator of an element of the isotropy group. In general, a symmetry frame is not an invariantly defined frame until the components $f_X^{\hat{i}}$ are fixed in some coordinate independent way. A straightforward calculation shows that if \mathbf{X} generates an affine frame symmetry, so that equation (22) is satisfied, then the Lie derivative of the metric is zero, implying that \mathbf{X} is a Killing vector field [10].

The class of symmetry frames is guaranteed to exist and given two symmetry frames we can transform from one to the other using a subgroup of the Lorentz group, \overline{Iso} , which leaves the representation of the isotropy group unchanged. This can be determined using the chosen Lie algebra basis for the Lorentz group and picking those Lie algebra generators whose commutator with the Lie algebra elements of the isotropy group again lies in the isotropy algebra. For example, in the case of spherical symmetry there are three generators of the isotropy group, X_I , I = 1, 2, 3 and the group \overline{Iso} consists of all spatial rotations.

As the components of $f_X^{\hat{i}}$ appear in equation (22), they are tensor quantities that depend on the frame. Under a change of frame, $\tilde{\mathbf{h}}^a = \tilde{\Lambda}^a{}_b \mathbf{h}^b$, the components transform as:

$$\mathbf{X}_{I}(\tilde{\Lambda}_{b}^{a})[\tilde{\Lambda}^{-1}]_{c}^{b} + \tilde{\Lambda}_{b}^{a}f_{I}^{\hat{i}}\lambda_{\hat{i}d}^{b}[\tilde{\Lambda}^{-1}]_{c}^{d} = \tilde{f}_{I}^{\hat{i}}\lambda_{\hat{i}c}^{a}. \tag{23}$$

In analogy with the CK algorithm, we fix the parameters of the elements in \overline{Iso} to prescribe the form of the $f_X^{\hat{i}}$ as much as possible. For example, some of the $f_X^{\hat{i}}$ can be set to a constant or zero. In which case, we have restricted the frame freedom of \overline{Iso} to a smaller subgroup \overline{H}_p , which leaves the chosen form of $f_X^{\hat{i}}$ unchanged.

We will say that the resulting symmetry frame is an invariantly defined symmetry frame up to the isotropy group \overline{H}_p . While if \overline{H}_p is the trivial group, the symmetry frame is an invariant symmetry frame. Returning to the spherically symmetric example, a choice of $f_{X_I}^{\hat{i}} \equiv f_I^{\hat{i}}$, I = 1, 2, 3, for each affine frame symmetry generator can be made so that this subgroup, \overline{H}_q , consists of rotations in the $\mathbf{h}^3 - \mathbf{h}^4$ plane where their Lorentz parameters are constant.

Since the invariantly defined frame determined by the CK algorithm is a symmetry frame, it follows from equation (23) that the original definition of an affine frame symmetry generator can be restated as

Definition IV.3. An affine frame symmetry generator is a vector field satisfying

$$\mathcal{L}_{\mathbf{X}_I} \mathbf{h}^a = f_I^{\ \hat{i}} \lambda^a_{\ \hat{i}\ b} \mathbf{h}^b \tag{24}$$

$$(\mathcal{L}_{\mathbf{X}_I}\boldsymbol{\omega})^a_{bc} = 0, \tag{25}$$

where $\hat{i},\hat{j},\hat{k}\in\{1,\dots,n\}$ and the components of $f_I{}^{\hat{i}}$ are functions of the coordinates, $x^{\alpha'}$.

A. Determining the most general geometry for a given isometry group

Supposing that the manifold admits a Lie group of affine frame symmetries of dimension N, with a non-trivial isotropy group with dimension n (n < N). Choose coordinates so that the affine frame symmetry group is represented as a set of vector fields, \mathbf{X}_I , where $I, J, K \in \{1, ..., N\}$, with the corresponding Lie algebra:

$$[\mathbf{X}_I, \mathbf{X}_J] = C_{IJ}^K \mathbf{X}_K, \tag{26}$$

where $C_{\ IJ}^{K}$ are structure constants of the Lie algebra.

Then we can determine the most general Riemann-Cartan geometries admitting this Lie group as affine symmetries by solving the following equations for an orthonormal symmetry coframe, \mathbf{h}^a , the associated metric, $g_{\mu\nu} = \eta_{ab} h^a_{\ \mu} h^b_{\ \nu}$, and with a metric-compatible connection, $\omega^a_{\ bc}$ satisfying the conditions in definition (IV.3). The form of $f_I^{\ \hat{\imath}}$ can be specified by choosing some components to be equal to others, to be constant or to be zero. This defines a class of invariantly defined symmetry frames up to the linear isotropy in \overline{H}_q . For the moment we will consider an arbitrary symmetry frame. In addition, due to the properties of the Lie derivative, we have an additional relationship coming from (26):

$$[\mathcal{L}_{\mathbf{X}_I}, \mathcal{L}_{\mathbf{X}_I}]\mathbf{h}^a = \mathcal{L}_{[\mathbf{X}_I, \mathbf{X}_J]}\mathbf{h}^a = C_{IJ}^K \mathcal{L}_{\mathbf{X}_K}\mathbf{h}^a.$$
(27)

Equations (24), (26) and (27) determine the **most general** frame basis which admits a given affine frame symmetry group with a non-trivial isotropy group. To determine the connection we must solve equation (25) relative to this frame. Using the coordinate basis expression for the Lie derivative of the connection in [15], the corresponding frame basis expression is,

$$(\mathcal{L}_{\mathbf{X}_{I}}\omega)_{bc}^{a}\mathbf{h}_{a} = \mathbf{R}(\mathbf{X}, \mathbf{h}_{c})\mathbf{h}_{b} - \mathbf{T}(\mathbf{X}, \nabla_{c}\mathbf{h}_{b}) + \nabla_{c}\mathbf{T}(\mathbf{X}, \mathbf{h}_{b}) + \nabla_{c}\nabla_{b}\mathbf{X} - \nabla_{\nabla_{c}}\mathbf{h}_{b}\mathbf{X},$$
(28)

where $\mathbf{R}(\mathbf{h}_d, \mathbf{h}_c)\mathbf{h}_b = R^a_{bcd}\mathbf{h}_a$ and $\mathbf{T}(\mathbf{h}_c, \mathbf{h}_b) = T^a_{bc}\mathbf{h}_a$, respectively, denote the curvature tensor and torsion tensor of the connection ω^a_{bc} .

Then denoting the associated Lie algebra of the isotropy group as:

$$[\lambda_{\hat{i}},\lambda_{\hat{j}}]^a_{\ b}=\lambda^a_{\hat{i}\ b}\lambda^b_{\hat{i}\ c}-\lambda^a_{\hat{j}\ b}\lambda^b_{\hat{i}\ c}=C^{\hat{k}}_{\ \hat{i}\hat{j}}\lambda^a_{\hat{k}\ c}.$$

equations (24), (27) and (28) can be restated in the following proposition.

Theorem IV.4. The most general Riemann-Cartan geometry admitting a given group of symmetries having vector generators, \mathbf{X}_I , $I, J, K \in \{1, ..., N\}$ with a non-trivial isotropy group of dimension n can be determined by solving for the unknowns $h^a_{\ \mu}$, $f_I^{\ \hat{\imath}}$ (with $\hat{\imath}, \hat{\jmath}, \hat{k} \in \{1, ..., n\}$) and $\omega^a_{\ bc}$ from the following equations:

$$X_{I}^{\nu}\partial_{\nu}h^{a}_{\ \mu} + \partial_{\mu}X_{I}^{\nu}h^{a}_{\ \nu} = f_{I}^{\hat{i}}\lambda^{a}_{\hat{i}\ h}h^{b}_{\ \mu},\tag{29}$$

$$2\mathbf{X}_{[I}(f_{J]}^{\hat{k}}) - f_{I}^{\hat{i}} f_{J}^{\hat{j}} C_{\hat{i}\hat{i}}^{\hat{k}} = C_{IJ}^{K} f_{K}^{\hat{k}}, \tag{30}$$

$$X_{I}{}^{d}\mathbf{h}_{d}(\omega_{bc}^{a}) + \omega_{bc}^{d}f_{I}{}^{\hat{i}}\lambda_{\hat{i}d}^{a} - \omega_{dc}^{a}f_{I}{}^{\hat{i}}\lambda_{\hat{i}d}^{d} - \omega_{bd}^{a}f_{I}{}^{\hat{i}}\lambda_{\hat{i}c}^{d} - \mathbf{h}_{c}(f_{I}{}^{\hat{i}})\lambda_{\hat{i}d}^{a} = 0.$$
 (31)

where $\{\lambda_{\hat{i}\ b}^a\}_{\hat{i}=1}^n$ is a basis of the Lie algebra of the isotropy group, $[\lambda_{\hat{i}},\lambda_{\hat{j}}]=C^{\hat{k}}_{\ \hat{i}\hat{j}}\lambda_{\hat{k}},\ [\mathbf{X}_I,\mathbf{X}_J]=C^{K}_{\ IJ}\mathbf{X}_K.$

The above proposition applies for any symmetry frame. However, the solution to these equations is most readily accomplished using an invariantly defined symmetry frame up to \overline{H}_q where the components of $f_I^{\hat{i}}$ have been invariantly specified. This is achieved by fixing the parameters of elements in the group \overline{Iso} to set the form of the matrix $f_I^{\hat{i}}$ in an invariant manner.

These results can be applied to teleparallel geometries, by requiring that the connection is flat and so the curvature tensor expressed in terms of the connection and its derivatives must vanish.

Theorem IV.5. The most general teleparallel geometry which admits a given group of symmetries with vector generators, \mathbf{X}_I , $I, J, K \in \{1, ..., N\}$ with a non-trivial isotropy group of dimension n can be determined by solving for the unknowns $h^a_{\ \mu}$, $f_I^{\ \hat{\imath}}$ (with $\hat{\imath}, \hat{\jmath}, \hat{k} \in \{1, ..., n\}$) and $\omega^a_{\ bc}$ from Proposition (IV.4) along with an additional condition:

$$R^{a}_{bcd} = h^{\mu}_{c} \partial_{\mu} \omega^{a}_{bd} - h^{\nu}_{d} \partial_{\nu} \omega^{a}_{bc} + \omega^{a}_{fc} \omega^{f}_{bd} - \omega^{a}_{fd} \omega^{f}_{bc} - c^{e}_{cd} \omega^{a}_{be} = 0.$$
 (32)

where $[\mathbf{h}_c, \mathbf{h}_d] = c^e_{cd} \mathbf{h}_e$

V. RIEMANN-CARTAN GEOMETRIES WITH SO(3)-ISOTROPY

To illustrate the affine frame symmetry approach, we will review the construction of all Riemann-Cartan geometries admitting SO(3) isotropy [10]. To do this, we will work in spherical coordinates $\{x^{\mu}\} = \{t, r, \theta, \phi\}$ so that the generators of the affine frame symmetry group are:

$$\mathbf{X}_{1} = \sin(\phi)\partial_{\theta} + \frac{\cos(\phi)}{\tan(\theta)}\partial_{\phi}, \ \mathbf{X}_{2} = -\cos(\phi)\partial_{\theta} + \frac{\sin(\phi)}{\tan(\theta)}\partial_{\phi}, \ \mathbf{X}_{3} = \partial_{\phi}.$$
 (33)

The commutator relations for these vector fields are:

$$[\mathbf{X}_1, \mathbf{X}_2] = -\mathbf{X}_3, \ [\mathbf{X}_1, \mathbf{X}_3] = \mathbf{X}_2, \ [\mathbf{X}_2, \mathbf{X}_3] = -\mathbf{X}_1.$$
 (34)

To employ equation (29), we must specify a representation of our isotropy sub-algebra; we will choose the following:

With these quantities, we will determine a symmetry frame by specifying the form of $f_I^{\hat{i}}$ in equation (29) using equation (30). By exploiting the $SO^*(1,3)$ freedom, these equations can be solved to give:

$$f_{I}^{\hat{i}} = \begin{bmatrix} \frac{\cos(\phi)}{\sin(\theta)} & 0 & 0\\ \frac{\sin(\phi)}{\sin(\theta)} & 0 & 0\\ 0 & 0 & 0 \end{bmatrix}$$
 (36)

With $f_I^{\ \hat{i}}$ computed, we may solve equation (29), and determine the frame basis:

$$\mathbf{h}^{1} = \alpha(t, r)dt, \quad \mathbf{h}^{2} = \beta(t, r)dr, \quad \mathbf{h}^{3} = \gamma(t, r)d\theta, \quad \mathbf{h}^{4} = \gamma(t, r)\sin(\theta)d\phi. \tag{37}$$

The functions α, β, γ are arbitrary functions of t and r. The coordinate freedom will be restricted to coordinate transformations that preserve the diagonal form of the metric.

Relative to this frame, we may then solve for the connection from equation (31):

$$\omega_{12} = W_{5}(t, r)\mathbf{h}^{1} + W_{6}(t, r)\mathbf{h}^{2},$$

$$\omega_{13} = W_{7}(t, r)\mathbf{h}^{3} + W_{8}(t, r)\mathbf{h}^{4},$$

$$\omega_{14} = -W_{8}(t, r)\mathbf{h}^{3} + W_{7}(t, r)\mathbf{h}^{3},$$

$$\omega_{23} = W_{3}(t, r)\mathbf{h}^{3} + W_{4}(t, r)\mathbf{h}^{4},$$

$$\omega_{24} = -W_{4}(t, r)\mathbf{h}^{3} + W_{3}(t, r)\mathbf{h}^{4},$$

$$\omega_{34} = W_{1}(t, r)\mathbf{h}^{1} + W_{2}(t, r)\mathbf{h}^{2} - \frac{\cot(\theta)}{\gamma(t, r)}\mathbf{h}^{4},$$
(38)

where W_a , $a \in \{1, ... 8\}$ are arbitrary functions of t and r. Of course, by imposing conditions on the torsion tensor or curvature tensor, and solving the resulting differential equations, we can recover solutions to Riemannian geometry if the torsion tensor vanishes or teleparallel geometry if the curvature tensor vanishes. Within Riemann-Cartan geometry, we can consider the existence of additional symmetries.

VI. EXTENSION TO STATIC SPHERICALLY SYMMETRIC GEOMETRIES

A popular choice for an additional symmetry is staticity, where a globally defined timelike affine frame symmetry exists and the resulting metric is diagonal in the same coordinate system where the timelike affine frame symmetry has been rectified. Without loss of generality, we may choose coordinates so that this timelike vector field takes the form:

$$\mathbf{X}_4 = \partial_t, \tag{39}$$

which does not affect the diagonal nature of the vielbein matrix $h^a_{\ \mu}$. Then, the commutator relations immediately imply,

$$[\mathbf{X}_{I'}, \mathbf{X}_4] = 0 \quad I' = 1, 2, 3.$$
 (40)

By considering $f_I^{\hat{i}}$ where the index I now ranges from 1 to 4, the frame freedom allows equation (30) to be solved again, giving

$$f_{I}^{\hat{i}} = \begin{bmatrix} \frac{\cos(\phi)}{\sin(\theta)} & 0 & 0\\ \frac{\sin(\phi)}{\sin(\theta)} & 0 & 0\\ 0 & 0 & 0\\ 0 & 0 & 0 \end{bmatrix}. \tag{41}$$

Then solving equations (29) and (31), we find

$$\mathbf{h}^{1} = \alpha(r)dt, \quad \mathbf{h}^{2} = \beta(r)dr, \quad \mathbf{h}^{3} = \gamma(r)d\theta, \quad \mathbf{h}^{4} = \gamma(r)\sin(\theta)d\phi. \tag{42}$$

In general, in the static spherically symmetric Riemann-Cartan geometries, if $\frac{d\gamma}{dr} \neq 0$, then we may choose coordinates so that $\gamma(r) = r$ and the frame basis is now

$$\mathbf{h}^{1} = \alpha(r)dt, \quad \mathbf{h}^{2} = \beta(r)dr, \quad \mathbf{h}^{3} = rd\theta, \quad \mathbf{h}^{4} = r\sin(\theta)d\phi \tag{43}$$

and the connection coefficients then take the form:

$$\omega_{12} = W_{5}(r)\mathbf{h}^{1} + W_{6}(r)\mathbf{h}^{2},$$

$$\omega_{13} = W_{7}(r)\mathbf{h}^{3} + W_{8}(r)\mathbf{h}^{4},$$

$$\omega_{14} = -W_{8}(r)\mathbf{h}^{3} + W_{7}(r)\mathbf{h}^{3},$$

$$\omega_{23} = W_{3}(r)\mathbf{h}^{3} + W_{4}(r)\mathbf{h}^{4},$$

$$\omega_{24} = -W_{4}(r)\mathbf{h}^{3} + W_{3}(r)\mathbf{h}^{4},$$

$$\omega_{34} = W_{1}(r)\mathbf{h}^{1} + W_{2}(r)\mathbf{h}^{2} - \frac{\cos(\theta)}{r\sin(\theta)}\mathbf{h}^{4}.$$
(44)

VII. STATIC SPHERICALLY SYMMETRIC G_7 RIEMANN-CARTAN GEOMETRIES

In principle, additional symmetries can be appended to the group. However, this requires knowledge of the larger Lie algebra that contains the Lie sub-algebra constructed from the current affine frame symmetry generators. Furthermore, not all Lie algebras can be realized as affine frame symmetry generators for a given class of Riemann-Cartan geometries. A good example of this phenomenon is the de Sitter analogue in Riemann-Cartan geometry, which is a spherically symmetric geometry admitting a seven-dimensional group of affine frame symmetries. The non-trivial de Sitter group's ten dimensional Lie algebra is not realized in Riemann-Cartan geometry.

In the case of large affine frame symmetry groups, there is a constructive approach to determining the geometries that admit them. We will use the tools introduced above to determine a subclass of static spherically symmetric Riemann-Cartan geometries that admit seven affine frame symmetry generators, G_7 .

From the CK algorithm, a Riemann-Cartan geometry will admit such a group of affine frame symmetries if $dim\ H_p=3$ and the components of the torsion tensor, the curvature tensor and their covariant derivatives are constant relative to an invariantly defined frame; that is, $t_p=0$. As an illustration, in the following section we will outline the analysis for the subclasses of static spherically symmetric Riemann-Cartan geometries and determine the conditions in each inequivalent case. The results of this analysis will be gathered in appendix A.

Using the frame basis in equation (43), along with the connection in equation (44), we can compute the curvature tensor and torsion tensor. The tensor part of the torsion tensor admits at most a two dimensional linear isotropy group [7]. In order to realize a three dimensional linear isotropy group, this tensor, \mathbf{t} , must necessarily vanish. The vanishing of the tensor part of the torsion tensor gives

$$W_4 = W_2, \ W_8 = W_1, \ W_5 = W_3 + \frac{1}{\beta r} - \frac{\alpha_{,r}}{\alpha \beta}, \ W_7 = W_6.$$
 (45)

The axial and vector parts of the torsion tensor are then

$$\mathbf{A} = 2W_2\mathbf{h}^1 + 2W_1\mathbf{h}_2,$$

$$\mathbf{V} = -3W_6\mathbf{h}_1 - 3\left(W_3 - \frac{1}{r\beta}\right)\mathbf{h}_2.$$
(46)

The components of the torsion tensor and curvature tensor are not necessarily constant in the current frame. We will consider a boosted frame, $\{\mathbf{h}_a\}_{a=1}^4$, where

$$\mathbf{A} = 2C_1 \mathbf{h}_1', \quad \mathbf{V} = -3C_2 \mathbf{h}_1' \tag{47}$$

for some real-valued constants C_1 and C_2 . We will consider the vector-field

$$\tilde{\mathbf{V}} = \mathbf{h}_1' = (2C_1)^{-1} \mathbf{A} = (-3C_2)^{-1} \mathbf{V}.$$
(48)

The boost parameter in equation (17) can be written as $B = e^{f(r)}$, and we can rewrite the remaining components of the connection as

$$W_{1} = C_{1} \sinh(f), W_{2} = C_{1} \cosh(f),$$

$$W_{3} = \frac{1}{r\beta} + C_{2} \sinh(f), W_{6} = C_{2} \cosh(f).$$
(49)

We will continue to work with respect to the boosted frame to determine conditions on the remaining free functions using the covariant derivatives of \mathbf{h}'_1 and the Ricci tensor and the

Weyl tensor. In the case of the Weyl tensor, it necessarily must vanish as the largest linear isotropy group for a non-vanishing Weyl tensor is at most 2 dimensional [5].

In order for the Ricci tensor to admit a 3 dimensional linear isotropy group, the following component must vanish:

$$R_{12} = \frac{e^{-2f}(e^{4f}\alpha^2 - \alpha^2)(-\alpha\beta_{,r} - \beta\alpha_{,r})}{2\alpha^3\beta^3r}$$
 (50)

This vanishes if the boost parameter is unity, (i.e., if f = 0) or if the vielbein functions satisfy the following constraint, $D_0 = \alpha \beta$.

Recall, when we started the analysis for this section we assumed $\frac{d\gamma}{dr} \neq 0$ and chose coordinates so that $\gamma = r$. If we were to repeat the analysis here assuming $\gamma = \gamma_0$ is constant, then the equivalent of equation (50) implies that alpha or beta must vanish, and so it is not permitted.

1. f = 0 and $\alpha\beta \neq$ constant:

If $\nabla_a \tilde{V}_b$ admits a 3 dimensional linear isotropy group, then $\nabla_2 \tilde{V}_1 = 0$ and we find the following condition

$$-\frac{2}{\beta}(\ln \alpha)_{,r} = 0\tag{51}$$

which implies $\alpha = D_1$, and this may be rescaled so that $D_1 = 1$, giving

$$\nabla \tilde{\mathbf{V}} = 2C_2(\mathbf{g} + |\tilde{\mathbf{V}}|^{-2}\tilde{\mathbf{V}}\tilde{\mathbf{V}}). \tag{52}$$

Imposing the same condition on the Ricci tensor, we find that

$$\beta = \pm \frac{1}{\sqrt{D_2 r^2 + 1}},\tag{53}$$

with the corresponding Ricci tensor

$$\mathbf{R} = (-2C_1^2 + 2C_2^2 - 2D_2)(\mathbf{g} + |\tilde{\mathbf{V}}|^{-2}\tilde{\mathbf{V}}\tilde{\mathbf{V}}).$$
 (54)

The vanishing of the Weyl tensor implies

$$C_1 C_2 = 0, (55)$$

giving two possible cases. The coframe and connection that gives these G_7 geometries are explicitly given in appendix A.

We note that in this case, $\gamma = \text{constant}$ is permitted. However, if the above analysis is repeated with this condition, there are components of the Weyl tensor that can never vanish. This implies that the $\gamma = \text{constant}$ case does not admit any G_7 solutions in this case.

2. $D_0 = \alpha \beta$ and f = 0

We may rescale the arbitrary functions α and β so that $D_0 = 1$. We will now impose the condition that $\nabla_a \tilde{V}_b$ and R_{ab} relative to the boosted frame both admit a 3 dimensional linear isotropy group to get further conditions on the remaining functions.

If f = 0 then the vanishing of $\nabla_1 \tilde{V}_2$ implies that $\alpha = D_1$, a real-valued constant. Then the equation $1 = \alpha \beta$ implies that β must also be constant. Thus the vierbein components are:

$$\alpha = D_1, \ \beta = D_1^{-1}, \ \text{and} \ \gamma = r.$$
 (56)

Immediately, the remaining components of $\nabla_a \tilde{V}_b$ and R_{ab} satisfy the condition for a 3 dimensional linear isotropy group:

$$\nabla \tilde{\mathbf{V}} = 2C_2(\mathbf{g} + |\tilde{\mathbf{V}}|^{-2}\tilde{\mathbf{V}}\tilde{\mathbf{V}}),$$

$$\mathbf{R} = (-2C_1^2 + 2C_2^2)(\mathbf{g} + |\tilde{\mathbf{V}}|^{-2}\tilde{\mathbf{V}}\tilde{\mathbf{V}}).$$
(57)

Computing the Weyl tensor, we find the following conditions

$$D_1^2 = 1, \quad C_1 C_2 = 0. (58)$$

Thus there are four possible G_7 solutions, depending on the vanishing of C_1 or C_2 and the sign of D_1 . The coframe and connection for each of these cases are given in appendix A.

3. $D_0 = \alpha \beta$ and $f \neq 0$

Again, we may rescale the arbitrary functions alpha and beta so that D0 = 1. In the $f \neq 0$ case, by integrating the numerator of the component $\nabla_1 \tilde{V}_2 = 0$ with respect to r, we find that

$$-2\alpha \cosh(f) = D_1. \tag{59}$$

The vanishing of $\nabla_1 \tilde{V}_2$ in combination with the equation $1 = \alpha \beta$ implies that the vierbein functions are:

$$\alpha = -\frac{D_1}{2\cosh(f)}, \ \beta = -\frac{2\cosh(f)}{D_1}, \ \gamma = r.$$

$$(60)$$

Requiring that $\nabla_2 \tilde{V}_2 = \nabla_3 \tilde{V}_3 = C_3$ gives

$$2C_{2} - \frac{4e^{2f}D_{1}f_{,r}}{(e^{2f} + 1)^{2}} = C_{3},$$

$$2C_{2} - \frac{D_{1}\sinh(f)}{r\cosh(f)} = C_{3}.$$
(61)

Note that $C_3 = 2C_2$ is not permitted as this would imply $D_1 = 0$ and hence $\alpha = 0$, which cannot happen. Solving for f gives

$$f = \frac{1}{2} \ln \left(-\frac{r(2C_2 - C_3) + D_1}{r(2C_2 - C_3) - D_1} \right). \tag{62}$$

The Ricci tensor admits a 3 dimensional linear isotropy group if $D_1 = \pm 2$, while the Weyl tensor vanishes if $C_1 = 0$. Thus, the non-vanishing rank two tensors are:

$$\nabla \tilde{\mathbf{V}} = C_3(\mathbf{g} + |\tilde{\mathbf{V}}|^{-2}\tilde{\mathbf{V}}\tilde{\mathbf{V}}),$$

$$\mathbf{R} = -\frac{1}{4}C_3(2C_2 - 3C_3)(\mathbf{g} + |\tilde{\mathbf{V}}|^{-2}\tilde{\mathbf{V}}\tilde{\mathbf{V}}) + \frac{3}{4}(2C_2 - C_3)C_3|\tilde{\mathbf{V}}|^{-2}\tilde{\mathbf{V}}\tilde{\mathbf{V}}.$$
(63)

The coframe and connection that yields these G_7 geometries are explicitly given in appendix A.

VIII. STATIONARY SPHERICALLY SYMMETRIC RIEMANN-CARTAN GEOMETRIES AND THEIR G_7 SUBCLASSES

If we consider spherically symmetric Riemann-Cartan geometries that are stationary but not static a straightforward computation shows that

$$\mathbf{X}_4 = -C_0 \partial_t + r \partial_r, \tag{64}$$

with $C_0 \neq 0$. As in the static case, we find $[\mathbf{X}'_I, \mathbf{X}_4] = 0$ for I' = 1, 2, 3. Due to this commutator structure, the analysis in section VI may be repeated to determine the coframe and the connection.

In the original coordinates, the coframe functions functions take the form:

$$\alpha(t,r) = \alpha(re^{\frac{t}{C_0}}), \quad \beta(t,r) = \beta(re^{\frac{t}{C_0}})e^{\frac{t}{C_0}}, \quad \gamma(t,r) = \gamma(re^{\frac{t}{C_0}})$$

$$(65)$$

We may choose new coordinates $\{t', r', \theta, \phi\}$ so that $\mathbf{X}_4 = \partial_{t'}$. In this frame, the coframe basis is then:

$$\mathbf{h}^{1} = \alpha(r')dt', \quad \mathbf{h}^{2} = -r'\beta(r')dt' + \beta(r')dr', \quad \mathbf{h}^{3} = \gamma(r')d\theta, \quad \mathbf{h}^{4} = \gamma(r')\sin\theta d\phi, \tag{66}$$

from which it follows that the vielbein matrix is no longer diagonal in this coordinate system. In this coordinate system the connection one-forms are now:

$$\omega_{12} = W_{5}(r')\mathbf{h}^{1} + W_{6}(r')\mathbf{h}^{2},$$

$$\omega_{13} = W_{7}(r')\mathbf{h}^{3} + W_{8}(r')\mathbf{h}^{4},$$

$$\omega_{14} = -W_{8}(r')\mathbf{h}^{3} + W_{7}(r')\mathbf{h}^{3},$$

$$\omega_{23} = W_{3}(r')\mathbf{h}^{3} + W_{4}(r')\mathbf{h}^{4},$$

$$\omega_{24} = -W_{4}(r')\mathbf{h}^{3} + W_{3}(r')\mathbf{h}^{4},$$

$$\omega_{34} = W_{1}(r')\mathbf{h}^{1} + W_{2}(r')\mathbf{h}^{2} - \frac{\cos(\theta)}{\gamma(r')\sin(\theta)}\mathbf{h}^{4}.$$
(67)

A. G₇ Stationary spherically symmetric Riemann-Cartan Geometries

In what follows, we will drop the prime on the coordinates and work in the coordinate system where \mathbf{X}_4 has been rectified, so that $\mathbf{X}_4 = \partial_t$. With the coframe and connection, we can compute the curvature tensor and torsion tensor. We ask that the tensor-part of the torsion vanishes in order to ensure that the linear isotropy group of the torsion tensor is three dimensional. This gives the following conditions:

$$W_4 = W_2, W_8 = W_1, W_5 = W_3 + \frac{\gamma_{,r}}{\beta \gamma} - \frac{\alpha_{,r}}{\alpha \beta}, W_7 = W_6 - \frac{\gamma_{,r}r}{\alpha \gamma} + \frac{\beta_{,r}r}{\alpha \beta} + \frac{1}{\alpha}.$$
 (68)

Using these conditions, the axial and vector parts of the torsion become

$$\mathbf{A} = 2W_2\mathbf{h}_1 + 2W_1\mathbf{h}_2,$$

$$\mathbf{V} = -3\left(W_6 + \frac{\beta_{,r}r}{\alpha\beta} + \frac{1}{\alpha}\right)\mathbf{h}_1 - 3\left(W_3 + \frac{\gamma_{,r}}{\beta\gamma}\right)\mathbf{h}_2.$$
(69)

There is a new frame $\{\mathbf{h}'_a\}_{a=1}^4$ arising from applying a boost in the $\mathbf{h}_1 - \mathbf{h}_2$ plane where $\mathbf{A} = 2C_1\mathbf{h}'_1$ and $\mathbf{V} = -3C_2\mathbf{h}'_1$, for some real-valued constants C_1 and C_2 . We find that

for the boost parameter in equation (17), $B = e^{f(r)}$, we have additional conditions on the components of the connection:

$$W_{1} = C_{1} \sinh(f(r)), W_{2} = C_{1} \cosh(f(r)),$$

$$W_{3} = -\frac{\gamma_{,r}}{\beta \gamma} + C_{2} \sinh(f(r)), W_{6} = -\frac{r\beta_{,r}}{\alpha \beta} - \frac{1}{\alpha} + C_{2} \cosh(f(r)).$$
(70)

We will now work with respect to the boosted frame and determine conditions on the remaining free functions using the Ricci tensor and the covariant derivative of $\tilde{\mathbf{V}}$ where

$$\tilde{\mathbf{V}} = \mathbf{h}_1' = (2C_1)^{-1} \mathbf{A} = (-3C_2)^{-1} \mathbf{V}.$$
(71)

Computing the Ricci tensor, we find the following component must vanish if it is to admit a 3 dimensional linear isotropy group:

$$R_{12} = -\frac{e^{-2f}}{2\beta^3 \alpha^3 \gamma} \left(e^{4f} (r\beta - \alpha)^2 - (r\beta + \alpha)^2\right) \left(\beta \alpha_{,r} \gamma_{,r} - \beta \alpha \gamma_{,r,r} + \alpha \beta_{,r} \gamma_{,r}\right). \tag{72}$$

This vanishes if $f = \frac{1}{4} \ln \left(\frac{(r\beta + \alpha)^2}{(r\beta - \alpha)^2} \right)$ or $\gamma_{,r} = \frac{\alpha\beta}{D_0}$.

We will first consider the case where $f = \frac{1}{4} \ln \left(\frac{(r\beta + \alpha)^2}{(r\beta - \alpha)^2} \right)$ and we will consider the components of $\nabla_a \tilde{V}_b$. In order for $\nabla_a \tilde{V}_b$ to admit a 3 dimensional linear isotropy group, the following must vanish:

$$\nabla_3 \tilde{V}_3 - \nabla_2 \tilde{V}_2 = \frac{\gamma(\beta^2 r^2 - \alpha^2)_{,r} - 2\gamma_{,r}(r^2 \beta^2 - \alpha^2)}{\alpha \beta \gamma \sqrt{r^2 \beta^2 - \alpha^2}} = 0.$$
 (73)

This leads to the following solution, $\gamma^2 = D_1 \beta^2 r^2 - \alpha^2$. Supposing that $D_1 > 0$, since α and β are arbitrary we will choose the following parametrization for the functions

$$\alpha = \sqrt{|D_1|}\gamma \sinh(g(r)), \quad \beta = \frac{\sqrt{|D_1|}\gamma \cosh(g(r))}{r}, \tag{74}$$

while if $D_1 < 0$, sinh and cosh are switched in α and β . From the condition on f, it follows that f = g. However, by computing the Weyl tensor, there are components of this tensor of the form γ^{-1} and hence can never vanish. Thus, this tensor can never admit a 3 dimensional linear isotropy group and there are no G_7 solutions in this case.

The only possibility of attaining G_7 stationary spherically symmetric Riemann-Cartan geometries are if the coframe functions satisfy:

$$\gamma_{,r} = \frac{\alpha\beta}{D_0}.\tag{75}$$

We will rescale the arbitrary functions α and β so that $D_0 = 1$. To continue, we will consider the components of $\nabla_a \tilde{V}_b$ and R_{ab} relative to the boosted frame to get further conditions on the remaining functions.

Starting with the component $\nabla_2 \tilde{V}_1$, setting this to zero and integrating the numerator with respect to r gives:

$$2r\beta\sinh(f) - 2\alpha\cosh(f) = D_1,\tag{76}$$

where D_1 is an arbitrary constant of integration. Here, we can consider two subcases, when $f \neq 0$ and when f = 0.

1. f = 0:

If f = 0 then we can write $\alpha = D_1$. Examining the remaining non-zero components in $\nabla_a \tilde{V}_b$:

$$\nabla_2 \tilde{V}_2 = \frac{2(C_2 D_1 \beta - \beta_{,r} r - \beta)}{D_1 \beta},$$

$$\nabla_3 \tilde{V}_3 = \nabla_4 \tilde{V}_4 = \frac{2C_2 (\gamma - r\beta)}{\gamma},$$
(77)

These components should be constants and equal to the same value,

$$\nabla_2 \tilde{V}_2 = \nabla_3 \tilde{V}_3 = C_3. \tag{78}$$

The second equation, $\nabla_3 \tilde{V}_3 = C_3$ requires that $C_3 \neq 2C_2$ as this would imply that β would vanish, which cannot occur. Solving the first solution for β we find

$$\beta = D_2 r^{\frac{D_1(2C_2 - C_3) - 2}{2}}, \ C_3 \neq 2C_2. \tag{79}$$

Solving for γ from this equation gives

$$\gamma = \frac{2D_2 r^{\frac{D_1(2C_2 - C_3)}{2}}}{2C_2 - C_3}. (80)$$

By rescaling the r coordinate, we can set $D_2 = 1$. We will examine the components of the Ricci tensor. In particular, we ask that $R_{22} - R_{33} = 0$ giving an algebraic condition on D_1

$$\frac{D_1^2 - 1}{4} (2C_2 - C_3)^2 r^{-D_1(2C_2 - C_3)} = 0. (81)$$

Imposing that $D_1 = \pm 1$, the Ricci tensor now admits a 3 dimensional linear isotropy group:

$$\mathbf{R} = -\frac{1}{4}C_3(2C_2 - 3C_3)(\mathbf{g} + |\tilde{\mathbf{V}}|^{-2}\tilde{\mathbf{V}}\tilde{\mathbf{V}}) + \frac{3}{4}C_3(2C_2 - C_3)|\tilde{\mathbf{V}}|^{-2}\tilde{\mathbf{V}}\tilde{\mathbf{V}}.$$
 (82)

Computing the Weyl tensor, the algebraically independent non-vanishing components yield

$$C_1C_3 = 0 \text{ and } C_1(2C_2 - C_3) = 0.$$
 (83)

Since $C_3 \neq 2C_2$, this implies that in general $C_1 = 0$, implying that the axial part of the torsion vanishes, $\mathbf{A} = 0$. Imposing this, we find the Ricci tensors take the form:

$$\mathbf{R} = -\frac{1}{4}C_3(2C_2 - 3C_3)(\mathbf{g} + |\tilde{\mathbf{V}}|^{-2}\tilde{\mathbf{V}}\tilde{\mathbf{V}}) + \frac{3}{4}C_3(2C_2 - C_3)|\tilde{\mathbf{V}}|^{-2}\tilde{\mathbf{V}}\tilde{\mathbf{V}}.$$
 (84)

In appendix B, we summarize the coframe and connection that gives rise to the G_7 stationary spherically symmetric Riemann-Cartan geometries listed below.

2. $f \neq 0$:

If $f \neq 0$, the algebraic condition in equation (76) implies that α and β take the form:

$$\alpha = \frac{D_1 g(r)}{2 \cosh(f)}, \beta = \frac{D_1 (1 - g(r))}{2r \sinh(f)}.$$
 (85)

The remaining non-zero components satisfy $\nabla_i \tilde{V}_i = C_3$ for i = 2, 3, 4, this is now an algebraic equation for g(r) with the solution

$$g = \frac{-\gamma \sinh(2f)(C_3 - 2C_2)}{2D_1} - \frac{2 + \cosh(2f)}{2}.$$
 (86)

Substituting this into the differential equation for γ , $\gamma_{,r} = \alpha \beta$ we can algebraically solve for the boost parameter:

$$e^{2f} = \frac{8\gamma_{,r}r \pm \sqrt{\gamma^4(C_3 - 2C_2)^4 - 2D_1^2\gamma^2(C_3 - 2C_2)^2 + 64\gamma_{,r}^2r^2 + D_1^4}}{D_1^2 + \gamma^2(C_3 - 2C_2)^2 + 4\gamma(C_3 - 2C_2)}.$$
 (87)

Using these expressions in the Ricci tensor, there is one additional condition that must be satisfied before the tensor admits a 3 dimensional linear isotropy group:

$$R_{22} - R_{33} = \frac{D_1^2 - 4}{4\gamma^2} = 0. (88)$$

Thus, $D_1 = \pm 2$ and now the Ricci tensor takes the form

$$\mathbf{R} = \left[-2C_1^2 - \frac{3}{4}C_3(2C_2 - 3C_3) \right] (\mathbf{g} + |\tilde{\mathbf{V}}|^{-2}\tilde{\mathbf{V}}\tilde{\mathbf{V}}) + \frac{3}{4}C_3(2C_2 - C_3)|\tilde{\mathbf{V}}|^{-2}\tilde{\mathbf{V}}\tilde{\mathbf{V}}.$$
(89)

Computing the Weyl tensor, we find the following conditions on the constants:

$$C_1C_3 = 0, C_1(2C_2 - C_3) = 0.$$
 (90)

Here there are two possible cases, either C_1 vanishes or $C_2 = C_3 = 0$.

IX. DISCUSSION

In this paper we have discussed the development of symmetry techniques in Riemann-Cartan geometries. While it may be natural to consider a modification of the Killing equations in equation (4) to determine affine frame symmetries, the study of symmetries are more easily developed using a frame formalism. In this perspective, the metric is replaced with a frame basis which diagonalizes the metric and the torsion tensor is replaced with the connection coefficients. Then the generator, \mathbf{X} , of an affine frame symmetry of the Riemann-Cartan geometry is an affine collineation of the space where the Lie derivative of the frame basis with respect to \mathbf{X} is given by equation (20).

While these conditions may appear more complicated than the original formulation in terms of the metric and the torsion, there are two tools that have been developed to investigate symmetries. The first tool is the Cartan-Karlhede (CK) algorithm, which was originally developed to locally characterize a given Riemann-Cartan geometry in terms of invariants by determining an invariantly defined frame. A natural byproduct of this algorithm is a simple calculation to determine the number of affine frame symmetries in a given geometry. The second tool is the affine frame symmetry approach, which expands the class of invariantly defined frames to symmetry frames and allows for the explicit calculation of all Riemann-Cartan geometries which admit a desired affine frame symmetry group.

Using the symmetry frame approach, we have presented the construction of all spherically symmetric Riemann-Cartan geometries and identified the subclass of static spherically symmetric Riemann-Cartan Geometries. Then by employing the CK algorithm, we determined conditions for a given static spherically symmetric geometry to admit a seven dimensional affine frame symmetry group, G_7 . By explicitly solving these conditions for the frame basis

and the connection coefficients, we determined all inequivalent static spherically symmetric Riemann-Cartan G_7 geometries, which are summarized in appendix A below.

We note that this is one possible subclass of spherically symmetric G_7 Riemann-Cartan geometries, and in pursuit of all spherically symmetric Riemann-Cartan geometries admitting a G_7 group of affine frame symmetries. We examined the stationary spherically symmetric Riemann-Cartan geometries. These admit a timelike affine frame symmetry, \mathbf{X}_4 but the metric cannot be diagonalized in the same coordinate system where \mathbf{X}_4 has been rectified. Repeating the approach used for the static case, we determined all inequivalent subclasses that admit a G_7 group of affine frame symmetries which has been summarized in appendix B below.

In this paper, we have determined all spherically symmetric Riemann-Cartan geometries that admit a G_7 group of affine frame symmetries. More generally, since the maximal linear isotropy group for the torsion tensor is at most three dimensional, and can be realized as SO(3), SO(1,2) or E(2), we anticipate there are G_7 Riemann-Cartan geometries outside of the spherically symmetric class. This will be explored in future work.

APPENDIX A: STATIC SPHERICALLY SYMMETRIC G_7 RIEMANN-CARTAN GEOMETRIES

The connection one-forms for any static spherically symmetric G_7 Riemann-Cartan are:

$$\omega_{12} = W_5(r)\mathbf{h}^1 + W_6(r)\mathbf{h}^2,
\omega_{13} = W_6(r)\mathbf{h}^3 + W_1(r)\mathbf{h}^4,
\omega_{14} = -W_1(r)\mathbf{h}^3 + W_6(r)\mathbf{h}^3,
\omega_{23} = W_3(r)\mathbf{h}^3 + W_2(r)\mathbf{h}^4,
\omega_{24} = -W_2(r)\mathbf{h}^3 + W_3(r)\mathbf{h}^4,
\omega_{34} = W_1(r)\mathbf{h}^1 + W_2(r)\mathbf{h}^2 - \frac{\cos(\theta)}{r\sin(\theta)}\mathbf{h}^4$$

1. Case 1: f = 0 and $\alpha\beta \neq \text{constant}$.

The frame basis takes the form:

$$\mathbf{h}^{1} = dt, \quad \mathbf{h}^{2} = \pm \frac{1}{\sqrt{D_{2}r^{2} + 1}} dr, \quad \mathbf{h}^{3} = rd\theta, \quad \mathbf{h}^{4} = r\sin(\theta)d\phi$$

where the components of the connection one-forms are:

$$C_1 = 0$$
:

$$W_1 = 0, W_2 = 0, W_3 = \pm \frac{\sqrt{D_2 r^2 + 1}}{r}, W_6 = C_2, W_5 = \pm \frac{2\sqrt{D_2 r^2 + 1}}{r},$$

or $C_2 = 0$:

$$W_1 = 0, W_2 = C_1, W_3 = \pm \frac{\sqrt{D_2 r^2 + 1}}{r}, W_6 = 0, W_5 = \pm \frac{2\sqrt{D_2 r^2 + 1}}{r},$$

2. Case 2: $1 = \alpha \beta$ and f = 0

The frame basis takes the form:

$$\mathbf{h}^1 = \pm dt$$
, $\mathbf{h}^2 = \pm dr$, $\mathbf{h}^3 = rd\theta$, $\mathbf{h}^4 = r\sin(\theta)d\phi$

where the components of the connection one-forms are either

 $C_1 = 0$:

$$W_1 = 0, W_2 = 0, W_3 = \pm \frac{1}{r}, W_6 = C_2, W_5 = \pm \frac{2}{r},$$

or $C_2 = 0$:

$$W_1 = 0, W_2 = C_1, W_3 = \pm \frac{1}{r}, W_6 = 0, W_5 = \pm \frac{2}{r},$$

3. Case 3: $1 = \alpha \beta$ and $f \neq 0$ The frame basis is now:

$$\mathbf{h}^1 = \pm \left(\frac{1}{\cosh(f)}\right) dt$$
, $\mathbf{h}^2 = \pm \cosh(f) dr$, $\mathbf{h}^3 = r d\theta$, $\mathbf{h}^4 = r \sin(\theta) d\phi$

with boost parameter $B = e^{f(r)}$:

$$f = \frac{1}{2} \ln \left(-\frac{r(2C_2 - C_3) \mp 2}{r(2C_2 - C_3) \pm 2} \right).$$

where the connection one-forms' components are

$$W_1 = 0, W_2 = 0,$$

 $W_3 = \pm \frac{1}{r \cosh(f)} + C_2 \sinh(f), W_6 = C_2 \cosh(f),$
 $W_5 = \pm \frac{2}{r \cosh(f)} \pm \left(\frac{1}{\cosh(f)}\right)_r.$

APPENDIX B: STATIONARY SPHERICALLY SYMMETRIC G_7 RIEMANN-CARTAN GEOMETRIES

Relative to the coordinate system, where $\mathbf{X}_4 = \partial_t$ defined in section VIII, the coframe is then

$$\mathbf{h}^1 = \alpha(r)dt$$
, $\mathbf{h}^2 = -r\beta(r)dt + \beta(r)dr$, $\mathbf{h}^3 = \gamma(r)d\theta$, $\mathbf{h}^4 = \gamma(r)\sin\theta d\phi$,

while the connection one-forms are:

$$\omega_{12} = W_5(r)\mathbf{h}^1 + W_6(r)\mathbf{h}^2,
\omega_{13} = W_7(r)\mathbf{h}^3 + W_1(r)\mathbf{h}^4,
\omega_{14} = -W_1(r)\mathbf{h}^3 + W_7(r)\mathbf{h}^3,
\omega_{23} = W_3(r)\mathbf{h}^3 + W_2(r)\mathbf{h}^4,
\omega_{24} = -W_2(r)\mathbf{h}^3 + W_3(r)\mathbf{h}^4,
\omega_{34} = W_1(r)\mathbf{h}^1 + W_2(r)\mathbf{h}^2 - \frac{\cos(\theta)}{\gamma(r)\sin(\theta)}\mathbf{h}^4.$$

1. Case 1: f = 0

The coframe functions takes the form:

$$\alpha = \pm 1, \quad \beta = r^{\frac{\pm (2C_2 - C_3) - 2}{2}}, \quad \gamma = \frac{2r^{\frac{\pm (2C_2 - C_3)}{2}}}{2C_2 - C_3}$$

where $C_3 \neq 2C_2$. The arbitrary functions in the connection one forms are then:

$$\begin{split} W_1 &= 0, W_2 = 0, \\ W_3 &= -\frac{\gamma_{,r}}{\beta\gamma}, W_6 = -\frac{r\beta_{,r}}{\alpha\beta} - \frac{1}{\alpha} + C_2, \\ W_5 &= -\frac{\alpha_{,r}}{\alpha\beta}, \\ W_7 &= C_2 - \frac{\gamma_{,r}r}{\alpha\gamma}. \end{split}$$

2. Case 2: $f \neq 0$ and $C_1 = 0$

The coframe functions takes the form:

$$\alpha = \frac{\pm g(r)}{\cosh(f(r))}, \quad \beta = \frac{\pm (1 - g(r))}{r \sinh(f(r))}, \quad \gamma = \gamma(r)$$

where γ is an arbitrary function of r and g is defined as

$$g = \mp \frac{-\gamma \sinh(2f)(C_3 - 2C_2)}{4} - \frac{2 + \cosh(2f)}{2}.$$

The boost parameter is then defined as

$$e^{2f} = \frac{8\gamma_{,r}r \pm \sqrt{\gamma^4(C_3 - 2C_2)^4 - 8\gamma^2(C_3 - 2C_2)^2 + 64\gamma_{,r}^2r^2 + 16}}{4 + \gamma^2(C_3 - 2C_2)^2 + 4\gamma(C_3 - 2C_2)}.$$

The remaining functions of the connection one-forms are then

$$\begin{split} W_1 &= 0, W_2 = 0, \\ W_3 &= -\frac{\gamma_{,r}}{\beta \gamma} + C_2 \sinh(f), W_6 = -\frac{r\beta_{,r}}{\alpha \beta} - \frac{1}{\alpha} + C_2 \cosh(f), \\ W_5 &= C_2 \cosh(f), \\ W_7 &= C_2 \cosh(f) - \frac{\gamma_{,r} r}{\alpha \gamma}. \end{split}$$

3. Case 3: $f \neq 0$ and $C_2 = C_3 = 0$

The coframe functions takes the form:

$$\alpha = \frac{\pm g(r)}{\cosh(f(r))}, \quad \beta = \frac{\pm (1 - g(r))}{r \sinh(f(r))}, \quad \gamma = \gamma(r)$$

where γ is an arbitrary function of r and g is defined as

$$g = -\frac{2 + \cosh(2f)}{2}.$$

The boost parameter is then defined as

$$e^{2f} = \frac{8\gamma_{,r}r \pm \sqrt{64\gamma_{,r}^2r^2 + 16}}{4}.$$

The remaining functions of the connection one-forms are then

$$W_1 = C_1 \sinh(f), W_2 = C_1 \cosh(f),$$

$$W_3 = -\frac{\gamma_{,r}}{\beta \gamma}, W_6 = -\frac{r\beta_{,r}}{\alpha \beta} - \frac{1}{\alpha},$$

$$W_5 = -\frac{\alpha_{,r}}{\alpha \beta},$$

$$W_7 = -\frac{\gamma_{,r}r}{\alpha \gamma}.$$
