We provide information on the minimal free resolutions of the logarithmic derivation module of \mathscr{A} , which can be used to compute a lower bound for the graded Betti numbers of the resolution. Specifically, for the three-dimensional case, we determine the minimal free resolution of the logarithmic derivation module of $\mathscr A$. We present illustrative examples of our main theorems to provide insights into the relationship between algebraic and combinatorial properties for close-to-free arrangements. 1 Introduction

Let V be the ℓ -dimensional vector space \mathbb{K}^{ℓ} over a field K. The coordinate ring $S = Sym(V^*) \cong$ $\mathbb{K}[x_1,\ldots,x_\ell]$ is equipped with the usual grading and its degree i homogeneous part is denoted by S_i . A (central) hyperplane arrangement $\mathscr A$ is a finite set of linear hyperplanes in V. For a hyperplane $H \in \mathscr{A}$, the defining linear form is denoted by $\alpha_H \in S_1$ with $H = \ker \alpha_H$. The defining polynomial $Q(\mathscr{A})$ of \mathscr{A} is defined as $Q(\mathscr{A}) = \prod_{H \in \mathscr{A}} \alpha_H$, and it is defined up to a scalar multiple. One of the most important algebraic invariants associated to an arrangement $\mathscr A$ is its *logarithmic derivation module* $D(\mathscr A)$ defined by

Abstract

$$
D(\mathscr{A}) = \{ \theta \in \text{Der}\, S \mid \theta(\alpha_H) \in S\alpha_H \text{ for any } H = \ker \alpha_H \in \mathscr{A} \},
$$

where Der S is the free S-module of derivations generated by $\{\partial_{x_i} \mid 1 \leq i \leq \ell\}$. Given a derivation $\theta = \sum_{i=1}^{\ell} f_i \partial_{x_i} \in D(\mathscr{A})$, we say it is homogeneous if all $f_i \in S_d$ for some $d \in \mathbb{Z}_{\geq 0}$, and we write $\deg \theta = d$. Generally, $D(\mathscr{A})$ is a reflexive graded S-module [\[11\]](#page-22-0) and is not always free. If $D(\mathscr{A})$ is free, then there exist homogeneous derivations $\theta_1, \ldots, \theta_\ell \in D(\mathscr{A})$ such that $D(\mathscr{A}) = \bigoplus_{i=1}^{\ell} S\theta_i$. In this situation, we say that \mathscr{A} is free with exponents $\exp(\mathscr{A}) =$ (d_1, \ldots, d_ℓ) , where $d_i = \deg \theta_i$.

The study of $D(\mathscr{A})$ has focused primarily on the case when it is free (see [\[16\]](#page-22-1) for a survey). Much remains unexplored when it is not free. In order to understand non-free cases, a natural approach is to look at their graded minimal free resolution. Some works consider the degrees (the Betti numbers) of the graded minimal free resolution $[4, 7, 12]$ $[4, 7, 12]$ $[4, 7, 12]$. In particular, $[14, 15]$ $[14, 15]$ study the *derivation degree sequence*, denoted as $DS(\mathscr{A})$, which is defined as the unordered sequence

of the degrees of the minimal homogeneous generators of $D(\mathscr{A})$. Moreover, we use $|DS(\mathscr{A})|$ to represent the number of the minimal homogeneous generators of $D(\mathscr{A})$. In cases where \mathscr{A} is free, we have $DS(\mathscr{A}) = \exp(\mathscr{A})$. Although minimal homogeneous generators are not unique, their degrees do not depend on the choice since they are the degrees of $Tor_0(\mathbb{K}, D(\mathscr{A}))$. One of the main challenges in the study of non-free arrangements is that the determination of these two algebraic properties of $D(\mathscr{A})$ is generally influenced not only by the combinatorics of $\mathscr A$ but also by its geometry (see [Example 4.8\)](#page-20-0).

To tackle this issue, our initial approach involves examining arrangements that are close to free arrangements. This is inspired by the next-to-free minus (NT-free-1) defined by Abe.

DEFINITION 1.1 (Definition 1.3 and 6.1 in [\[1\]](#page-21-2)). We say that $\mathscr B$ is next-to-free minus (NTfree-1) if there exist a free arrangement $\mathscr A$ and a hyperplane $H \in \mathscr A$ such that $\mathscr B = \mathscr A \setminus \{H\}.$ In this case, we say $\mathscr A$ is a free addition of $\mathscr B$.

Now we introduce a class of arrangement, which has a nice structure called *strictly plus-one* generated (SPOG), closely related to the NT-free-1 arrangement.

DEFINITION 1.2 (Definition 1.1 in [\[1\]](#page-21-2)). An arrangement $\mathscr B$ is said to be strictly plusone generated (SPOG) with exponents $POexp(\mathscr{B}) = (d_1, \ldots, d_\ell)$ and level d, if there exist $f_1,\ldots,f_\ell,\alpha\in S$ with $\alpha\neq 0$ such that $D(\mathscr{B})$ has a minimal free resolution of the following form:

$$
0 \to S[-d-1] \xrightarrow{(\alpha, f_1, \dots, f_\ell)} S[-d] \oplus \left(\bigoplus_{i=1}^{\ell} S[-d_i] \right) \to D(\mathscr{B}) \to 0.
$$

In particular, $DS(\mathscr{B}) = (d_1, \ldots, d_\ell, d) = (POexp(\mathscr{B}), d)$.

REMARK 1.3. In other words, $\mathscr B$ is SPOG if there is a minimal set of homogeneous generators $\theta_1, \theta_2, \ldots, \theta_\ell$ and φ for $D(\mathscr{B})$ such that $\deg \theta_i = d_i$, $\deg \varphi = d$, and

$$
\sum_{i=1}^{\ell} f_i \theta_i + \alpha \varphi = 0,
$$

where $f_i \in S$ and $0 \neq \alpha \in S_1$. This α is called the level coefficient, and φ is a level element. Moreover, when $d = d_i$ for some i and $f_i \neq 0$, then θ_i also can be a level element. In other words, the choice of the level coefficient and element is not unique.

Abe [\[1\]](#page-21-2) shows that an NT-free-1 arrangement \mathscr{B} is either free or SPOG. If \mathscr{B} is SPOG and NT-free-1, the level of \mathscr{B} can be determined by the combinatorial properties of its free addition. To state his results, let us recall that the definition of the intersection lattice of $\mathscr A$, denoted by $L(\mathscr{A})$, as follows:

$$
L(\mathscr{A}) := \left\{ \bigcap_{H \in \mathscr{B}} H \mid \mathscr{B} \subset \mathscr{A} \right\},\
$$

where $L(\mathscr{A})$ is equipped with a partial order induced by reverse inclusion. For a given $X \in$ $L(\mathscr{A})$, the localization \mathscr{A}_X of \mathscr{A} at X is defined by

$$
\mathscr{A}_X := \{ H \in \mathscr{A} \mid X \subset H \},
$$

and the restriction \mathscr{A}^X of \mathscr{A} onto X is defined by

$$
\mathscr{A}^X := \{ H \cap X \mid H \in \mathscr{A} \setminus \mathscr{A}_X \}.
$$

The following is a significant theorem about NT-free-1 arrangements, which plays a crucial role in shaping our results.

THEOREM 1.4 (Theorem 1.4 and Proposition 5.3 in [\[1\]](#page-21-2)). Let $\mathscr A$ be free with $\exp(\mathscr A)$ = (d_1, \ldots, d_ℓ) and $H \in \mathscr{A}$. Then $\mathscr{A}' = \mathscr{A} \setminus \{H\}$ is free, or SPOG with $\text{POexp}(\mathscr{A}') = (d_1, \ldots, d_\ell)$ and level $d = |\mathscr{A}'| - |\mathscr{A}^H|$. Moreover, if $\ell = 3$, then $d \ge \max\{d_1, d_2, d_3\}$.

REMARK 1.5. Suppose that $\mathscr A$ is free and $\mathscr A' = \mathscr A \setminus H$ is SPOG.

- (1) Assume that $\theta_1,\ldots,\theta_\ell$ is a basis of $D(\mathscr{A})$. Since $DS(\mathscr{A}') = (PO \exp(\mathscr{A}), d)$ and $PO \exp(\mathscr{A}') =$ $\exp(\mathscr{A})$, there exists $a \varphi \in D(\mathscr{A}')$ of degree d such that $\theta_1, \ldots, \theta_\ell, \varphi$ generate $D(\mathscr{A}')$. Since $D(\mathscr{A}) \subsetneq D(\mathscr{A}')$, we have $D(\mathscr{A}') = D(\mathscr{A}) + S\varphi$, and $\varphi \notin D(\mathscr{A})$ as a level element of $D(\mathscr{A}')$.
- (2) Let $\varphi \notin D(\mathscr{A})$ be a level element of \mathscr{A}' . Let $\alpha_H \in S_1$ be such that ker $\alpha_H = H$. Since $\varphi \in D(\mathscr{A}') \setminus D(\mathscr{A})$, we have $\alpha_H \varphi \in D(\mathscr{A})$. Thus, we obtain a relationship between the minimal generators of $D(\mathscr{A}')$. Since SPOG arrangements have a unique relation among the minimal generators, we may always assume that α_H is the level coefficient.

In this paper, we introduce a new class of possibly non-free arrangements obtained by deleting two hyperplanes from free arrangements.

DEFINITION 1.6. We say that $\mathscr B$ is next-to-free-minus-two (NT-free-2) if there exist a free arrangement $\mathscr A$ and two hyperplanes $H_1, H_2 \in \mathscr A$ such that $\mathscr B = \mathscr A \setminus \{H_1, H_2\}.$

By analyzing the minimal free resolution, we deduce the following theorem:

THEOREM 1.7. Let $\mathscr B$ be a NT-free-2 arrangement. Then the projective dimension $pd_S(D(\mathscr B)) \le$ 1 if and only if $|DS(\mathcal{B})| < \ell + 2$.

Let $\mathscr{A} = \{H_1, \ldots, H_p \mid H_i = \ker \alpha_i\}$ be a free arrangement. We denote the NT-free-1 arrangement $\mathscr{A}\setminus\{H_j\}$ by \mathscr{A}_j and the NT-free-2 arrangement $\mathscr{A}\setminus\{H_j,H_k\}$ by $\mathscr{A}_{j,k}$. We note that $\mathscr{A}_{j,k} = \mathscr{A}_{k,j}$. We also denote \mathscr{A}^{H_j} by \mathscr{A}^j .

If \mathscr{A}_1 or \mathscr{A}_2 is free, then $\mathscr{A}_{1,2}$ is NT-free-1 and it is either free or SPOG by [Theorem 1.4.](#page-1-0) Therefore, we focus on the case when none of \mathscr{A}_1 and \mathscr{A}_2 are free. We show that when $|DS(\mathscr{A}_{1,2})| \leq \ell + 2$, the minimal free resolution of $D(\mathscr{A}_{1,2})$ assumes one of the forms listed in [Theorem 3.8.](#page-9-0) When $|DS(\mathcal{A}_{1,2})| > \ell + 2$, we obtain a lower bound for the Betti numbers of $D(\mathscr{A}_{1,2})$ using the information provided in [Theorem 3.9.](#page-13-0)

Note that since the logarithmic derivation module is a reflexive graded S-module, its projective dimension is less than or equal to $\ell - 2$ (see, [Lemma 2.10\)](#page-5-0). Consequently, for a threedimensional NT-free-2 arrangement $\mathscr{A}_{1,2}$, we can infer that $\text{pd}_S(D(\mathscr{A}_{1,2})) \leq 3-2=1$. Utilizing [Theorem 1.7,](#page-2-0) we then establish that $|DS(\mathscr{A}_{1,2})| \leq \ell + 2 = 5$. Furthermore, we determine the precise form of the minimal free resolution of $D(\mathscr{A}_{1,2})$.

THEOREM 1.8. Assume $\ell = 3$. Let $\mathscr A$ be free with $\exp(\mathscr A) = (d_1, d_2, d_3)$, and $\mathscr A_1$ and $\mathscr A_2$ be SPOG with levels c_1 and c_2 , respectively. We may assume $c_1 \leq c_2$. Then $\mathscr{A}_{1,2}$ can never be free in this set-up, and the module $D(\mathcal{A}_{1,2})$ has a minimal free resolution in one of the following forms:

(1) Suppose that $|\mathscr{A}_{H_1 \cap H_2}| = 2$.

There exist $f_i, g_i \in S$ such that

$$
(a_1, 0, f_1, f_2, f_3)
$$

\n
$$
0 \to S[-c_1 - 1] \oplus S[-c_2 - 1] \xrightarrow{(0, \alpha_2, g_1, g_2, g_3)}
$$

\n
$$
S[-c_1] \oplus S[-c_2] \oplus \left(\bigoplus_{i=1}^3 S[-d_i]\right) \to D(\mathscr{A}_{1,2}) \to 0,
$$

where $i = 1, 2, 3$.

(2) Suppose that $|\mathcal{A}_{H_1 \cap H_2}| > 2$.

(2.1) If $c_1 = c_2$, there exist $f_i \in S$ such that

$$
0 \to S[-c_1-1] \xrightarrow{(\alpha_1 \alpha_2, f_1, f_2, f_3)} S[-c_1+1] \oplus \left(\bigoplus_{i=1}^3 S[-d_i] \right) \to D(\mathscr{A}_{1,2}) \to 0.
$$

Moreover, $\mathscr{A}_{1,2}$ is SPOG if and only if $c_1 = c_2 = \max\{d_1, d_2, d_3\}$. If $\mathscr{A}_{1,2}$ is SPOG, let $d_2 = \max\{d_1, d_2, d_3\}$, then $f_2 \in S_1$.

(2.2) If $c_1 < c_2$, there exist $f_i, g_i, g \in S$ with $g \neq 0$ such that

$$
(a_1, 0, f_1, f_2, f_3)
$$

\n
$$
0 \to S[-c_1 - 1] \oplus S[-c_2] \xrightarrow{(g, \alpha_2, g_1, g_2, g_3)} S[-c_1] \oplus S[-c_2 + 1] \oplus \left(\bigoplus_{i=1}^3 S[-d_i]\right) \to D(\mathscr{A}_{1,2}) \to 0,
$$

where $i = 1, 2, 3$.

The organization of this article is as follows: In Section 2, we introduce previous results and definitions. In Sections 3 and 4, we focus on proving the main results. Specifically, in Section 3, we present the proofs and provide examples in a general-dimensional setting. In Section 4, we shift our attention to the three-dimensional case and provide further examples.

2 Preliminaries

In this section, we will summarize several results and definitions. Let $\mathscr A$ be an arrangement and $L(\mathscr{A})$ be its intersection lattice.

Let $\theta_E = \sum_{i=1}^{\ell} x_i \partial_{x_i}$ be the *Euler derivation*, which is a homogeneous derivation of deg $\theta_E =$ 1 and always contained in $D(\mathscr{A})$. Recall that for every $H \in \mathscr{A}$, there exists a decomposition:

$$
D(\mathscr{A}) \cong S\theta_E \oplus D_H(\mathscr{A}),\tag{2.1}
$$

where $D_H(\mathscr{A}) := \{ \theta \in D(\mathscr{A}) \mid \theta(\alpha_H) = 0 \}$ (see, for example, [\[9,](#page-21-3) Lemma 1.33]). This implies that $1 \in DS(\mathscr{A})$. Furthermore, if $\mathscr{A} \neq \emptyset$ is free with $\exp(\mathscr{A}) = (d_1, \ldots, d_\ell)$, we may assume that $d_1 = \deg \theta_E = 1$.

The following has been well-known and frequently utilized by specialists.

PROPOSITION 2.1 ([\[14\]](#page-22-3)). Let $H \in \mathscr{A}$. Then there is a polynomial B of degree $|\mathscr{A}| - |\mathscr{A}^H| - 1$ such that $\alpha_H \nmid B$, and $\theta(\alpha_H) \in (\alpha_H, B)$ for all $\theta \in D(\mathscr{A} \setminus \{H\}).$

From the above proposition, we can easily derive the following proposition. We include it here since we frequently utilize it.

PROPOSITION 2.2 (Corollary 3.3 in [\[1\]](#page-21-2)). Let $H \in \mathscr{A}$ and $\mathscr{A}' = \mathscr{A} \setminus \{H\}$. Assume that there exists $\varphi \in D(\mathscr{A}')$ with $\deg \varphi = |\mathscr{A}'| - |\mathscr{A}^H|$ such that $\varphi \notin D(\mathscr{A})$. Then $D(\mathscr{A}') = D(\mathscr{A}) + S\varphi$.

We now define the Euler restriction map $\rho: D(\mathscr{A}) \to D(\mathscr{A}^H)$ for an arrangement \mathscr{A} by taking modulo α_H . Additionally, let $\mathscr{A}' = \mathscr{A} \setminus \{H\}$. We have an exact sequence as follows:

PROPOSITION 2.3 (Proposition 4.45 in [\[9\]](#page-21-3)).

$$
0 \to D(\mathscr{A}') \xrightarrow{\cdot \alpha_H} D(\mathscr{A}) \xrightarrow{\rho} D(\mathscr{A}^H).
$$

Moving forward, let's delve into some results pertaining to the logarithmic derivation module $D(\mathscr{A})$ and its freeness.

THEOREM 2.4 (Addition-Deletion Theorem. Removal Theorem in [\[14\]](#page-22-3)). Let $H \in \mathscr{A}$, $\mathscr{A}' :=$ $\mathscr{A}\setminus\{H\}$ and $\mathscr{A}^{''}:=\mathscr{A}^{H}$. Then two of the following imply the third:

- (1) $\mathscr A$ is free with $\exp(\mathscr A) = (d_1, \ldots, d_\ell)$.
- (2) \mathscr{A}' is free with $\exp(\mathscr{A}') = (d_1, \ldots, d_{\ell-1}, d_{\ell} 1).$
- (3) \mathscr{A}'' is free with $\exp(\mathscr{A}'') = (d_1, \ldots, d_{\ell-1}).$

Moreover, all the three above hold true if $\mathscr A$ and $\mathscr A'$ are free.

THEOREM 2.5 (Saito's criterion. [\[11\]](#page-22-0)). Let $\theta_1, \ldots, \theta_\ell \in D(\mathscr{A})$ be homogenous and linearly independent over S. Then $\mathscr A$ is free with basis $\{\theta_1,\ldots,\theta_\ell\}$ if and only if

$$
\sum_{i=1}^{\ell} \deg \theta_i = |\mathscr{A}|.
$$

Let us introduce the multiarrangement theory. A multiarrangement is a pair (\mathscr{A}, m) , where $\mathscr A$ is a hyperplane arrangement in V and multiplicity m is a map: $\mathscr A \to \mathbb{Z}_{\geq 0}$. Define $|m| =$ $\sum_{H\in\mathscr{A}}m(H)$. If $m(H) = 1$ for all $H \in \mathscr{A}$, we say that the multiarrangement (\mathscr{A}, m) is a hyperplane arrangement, which is also called a simple arrangement. The logarithmic derivation module $D(\mathscr{A}, m)$ is defined as follows:

$$
D(\mathscr{A}, m) = \{ \theta \in \text{Der}\, S \mid \theta(\alpha_H) \in S\alpha_H^{m(H)} \text{ for any } H = \text{ker}\, \alpha_H \in \mathscr{A} \}.
$$

The module $D(\mathscr{A}, m)$ is also a reflexive graded S-module, which is not always free. We can define the concepts of freeness and exponents for (\mathscr{A}, m) in the same way as for simple arrangements.

DEFINITION 2.6 ([\[17\]](#page-22-5)). For an arrangement $\mathscr A$ and $H \in \mathscr A$, define the Ziegler multiplicity $m^H : \mathscr{A}^H \to \mathbb{Z}_{\geq 0}$ by $m^H(X) := |\{L \in \mathscr{A} \setminus \{H\} \mid L \cap H = X\}|$ for $X \in \mathscr{A}^H$. The pair $({\mathscr A}^H, m^H)$ is called the Ziegler restriction of ${\mathscr A}$ onto H. Also, there is a Ziegler restriction map:

$$
\pi: D_H(\mathscr{A}) \to D(\mathscr{A}^H, m^H)
$$

by taking modulo α_H . In particular, there is an exact sequence:

$$
0 \to D_H(\mathscr{A}) \xrightarrow{\cdot \alpha_H} D_H(\mathscr{A}) \xrightarrow{\pi} D(\mathscr{A}^H, m^H).
$$

THEOREM 2.7 (Theorem 11 in [\[17\]](#page-22-5)). Assume that $\mathscr A$ is free with exponents $\exp(\mathscr A)$ = $(1, d_2, \ldots, d_\ell)$. Then for any $H \in \mathscr{A}$, the Ziegler restriction (\mathscr{A}^H, m^H) is also free with $\exp(\mathscr{A}^H, m^H) = (d_2, \ldots, d_\ell)$. Explicitly, for the Ziegler restriction $\pi : D_H(\mathscr{A}) \to D(\mathscr{A}^H, m^H)$, any basis $\theta_2,\ldots,\theta_\ell$ for $D_H(\mathscr{A})$ such that $\pi(\theta_2),\ldots,\pi(\theta_\ell)$ form a basis for $D(\mathscr{A}^H,m^H)$. In particular, π is surjective when $\mathscr A$ is free.

LEMMA 2.8 (Lemma 4.2 and Lemma 4.3 in [\[2\]](#page-21-4)). Let $\mathscr A$ be central line arrangement and let m, m' be multiplicities on $\mathscr A$ such that $|m| = |m'| + 1$ and $m(H) \ge m'(H)$ for any $H \in \mathscr A$. If $\exp(\mathscr{A}, m') = (a, b), \text{ then } \exp(\mathscr{A}, m) = (a + 1, b) \text{ or } (a, b + 1).$

Finally, we present the basics of free resolutions.

DEFINITION 2.9. For arrangement \mathscr{B} , we denote the minimal free resolution of the module $D(\mathscr{B})$ by

$$
0 \to M_k \xrightarrow{R_k} M_{k-1} \xrightarrow{R_{k-1}} \cdots \xrightarrow{R_2} M_1 \xrightarrow{R_1} M_0 \to D(\mathscr{B}) \to 0,
$$

where $k = pd_S(D(\mathcal{B}))$ is the projective dimension of $D(\mathcal{B})$. Here, R_i $(i = 1, ..., k)$ are represented by matrices acting by multiplication from the left. We use $R_i(j)$ to denote the j-th row of R_i , and $R_i(j_1, j_2)$ to denote the (j_1, j_2) entry of R_i .

Let $JQ(\mathscr{A})$ be the Jacobian ideal of $Q(\mathscr{A})$ generated by $\frac{\partial Q(\mathscr{A})}{\partial x_i}$ for $i = 1, \ldots, n$. Since $D(\mathscr{A}) = {\theta \in \text{Der}\,S \mid \theta(Q(\mathscr{A})) \in SQ(\mathscr{A})}$, we have a free resolution of the form

$$
0 \to N_{\ell} \to \cdots \to N_3 \to D_H(\mathscr{A}) \to S^n \to S \to S/JQ(\mathscr{A}) \to 0
$$
\n(2.2)

by Hilbert's syzygy theorem. Since $pd_S(D(\mathscr{A})) = pd_S(D_H(\mathscr{A}))$ by [\(2.1\)](#page-3-0), we have

LEMMA 2.10. $pd_S(D(\mathscr{A})) \leq \ell - 2$.

From [\(2.2\)](#page-5-1), we see $D(\mathscr{A})$ is reflexive since it is a second syzygy.

The following theorem is a simplified version of the result found in the reference [\[7\]](#page-21-1).

THEOREM 2.11 (Theorem 0.2 in [\[7\]](#page-21-1)). If the logarithmic derivation module $D(\mathscr{B})$ has a free resolution given by:

$$
0 \to \bigoplus_{i=1}^{r_k} S[-d_i^k] \to \cdots \to \bigoplus_{i=1}^{r_1} S[-d_i^1] \to \bigoplus_{i=1}^{r_0} S[-d_i^0] \to D(\mathscr{B}) \to 0,
$$

then $|\mathscr{B}| = \sum_{j=0}^{k} (-1)^j \sum_{i=1}^{r_j} d_i^j$ $\frac{j}{i}$.

As a corollary, we have the following property for SPOG arrangements:

PROPOSITION 2.12 (Proposition 4.1 in [\[1\]](#page-21-2)). Let B be SPOG with $\text{POexp}(\mathscr{B}) = (d_1, d_2, \ldots, d_\ell)$ and level d. Then $\sum_{i=1}^{\ell} d_i - 1 = |\mathscr{B}|$.

3 The Minimal Free Resolution of NT-Free-2 Arrangements

In this section, we introduce some notations. If U is a subset of Der S, then $SU := \sum_{\xi \in U} S_{\xi}$. Throughout this section, we assume that $\mathscr{A} = \{H_i \mid H_i : \alpha_i = 0\}$ is free, with $\exp(\mathscr{A}) =$ $(1, d_2, \ldots, d_\ell)$, and \mathscr{A}_j is SPOG with $\text{POexp}(\mathscr{A}) = (1, d_2, \ldots, d_\ell)$ and level c_j for $j = 1, 2$. Let $c_1 \leq c_2$. By [Proposition 2.3,](#page-4-0) we have [Figure 1.](#page-6-0)

REMARK 3.1.

- (1) By [Remark 1.5](#page-2-1) [\(1\),](#page-2-2) we may assume that the level element for \mathscr{A}_j is not in $D(\mathscr{A})$.
- (2) As there is no confusion, we can simplify by stating that $D(\mathscr{A}_2^1) := D((\mathscr{A}_2)^1)$ and $D(\mathscr{A}_1^2) := D((\mathscr{A}_1)^2).$

LEMMA 3.2. Let \mathscr{A}_i be SPOG, where $H_i \in \mathscr{A}$. For any homogeneous basis element θ for $D(\mathscr{A})$, we have $\theta \notin \ker \rho^i$.

Proof. Assume that $\theta_1, \ldots, \theta_\ell$ is a basis for $D(\mathscr{A})$ such that $\theta_1 \in \text{ker } \rho_i$. By [Proposition 2.3,](#page-4-0) there is an element $\varphi \in D(\mathscr{A}_i)$ such that $\theta_1 = \alpha_i \varphi$. Since $\varphi, \theta_2, \ldots, \theta_\ell \in D(\mathscr{A}_i)$ are S-independent, by [Theorem 2.5,](#page-4-1) we may get that \mathscr{A}_i is free, which is a contradiction. \Box

LEMMA 3.3. We have $D(\mathscr{A}) + \ker \rho_i^j \subset D(\mathscr{A}_i)$, where $i \neq j \in \{1, 2\}$. Moreover,

- (1) there exists an element $\varphi \in D(\mathscr{A}_{1,2})$ such that $\alpha_2\varphi$ is the level element for \mathscr{A}_1 if and only if $D(\mathscr{A}_1) = D(\mathscr{A}) + \ker \rho_1^2$.
- (2) there exists an element $\varphi \in D(\mathcal{A}_{1,2})$ such that $\alpha_1\varphi$ is the level element for \mathcal{A}_2 if and only if $D(\mathscr{A}_2) = D(\mathscr{A}) + \ker \rho_2^1$.

Proof. By [Figure 1,](#page-6-0) it follows that ker $\rho_i^j \subset D(\mathscr{A}_i)$. Note that $D(\mathscr{A}) \subset D(\mathscr{A}_i)$; hence, we have $D(\mathscr{A}) + \ker \rho_i^j \subset D(\mathscr{A}_i).$

(1) By [Proposition 2.3,](#page-4-0) we can deduce the following equivalences:

There exists an element $\varphi \in D(\mathcal{A}_{1,2})$ such that $\alpha_2\varphi$ serves as the level element for \mathcal{A}_1 . \iff There exists a level element $\theta \in D(\mathscr{A}_1)$ such that $\theta \in \text{ker } \rho_1^2$.

By [Remark 1.5,](#page-2-1) we can represent $D(\mathscr{A}_1)$ as $D(\mathscr{A}) + S\theta$. Consequently, we can state the following equivalences:

> There exists a level element $\theta \in D(\mathscr{A}_1)$ such that $\theta \in \text{ker } \rho_1^2$. $\Longleftrightarrow D(\mathscr{A}_1) = D(\mathscr{A}) + \ker \rho_1^2.$

(2) This scenario bears resemblance to the one discussed in [Case \(1\).](#page-6-1)

LEMMA 3.4. For every element $\varphi \in D(\mathscr{A}_{1,2})$, if $\alpha_j \varphi \in D(\mathscr{A})$ for some $j \in \{1,2\}$, then $\varphi \in D(\mathscr{A}_j)$. Moreover, if both $\alpha_1\varphi$ and $\alpha_2\varphi$ are in $D(\mathscr{A})$, then φ itself is an element of $D(\mathscr{A})$.

Proof. Let $\varphi \in D(\mathscr{A}_{1,2})$ be given, and assume that $\alpha_1 \varphi \in D(\mathscr{A})$. By [Proposition 2.3](#page-4-0) and [Figure 1,](#page-6-0) we have $\alpha_1\varphi \in \text{ker } \rho^1 = \alpha_1 D(\mathscr{A}_1)$. Hence, we can conclude that $\varphi \in D(\mathscr{A}_1)$.

Similarly, if $\alpha_2\varphi \in D(\mathscr{A})$, we can deduce that $\varphi \in D(\mathscr{A}_2)$.

Moreover, if $\alpha_1\varphi \in D(\mathscr{A})$ and $\alpha_2\varphi \in D(\mathscr{A})$, then $\varphi \in D(\mathscr{A}_1) \cap D(\mathscr{A}_2) = D(\mathscr{A})$.

LEMMA 3.5. If $|\mathscr{A}_{H_1 \cap H_2}| = 2$, then $D(\mathscr{A}_{1,2}) = D(\mathscr{A}_1) + D(\mathscr{A}_2)$.

Proof. Let $\theta_{\ell,2}$ be a level element for $D(\mathscr{A}_2)$. Since $|\mathscr{A}_{H_1 \cap H_2}| = 2$, we can deduce that $|\mathscr{A}^2| =$ $|\mathscr{A}_1^2|+1$. Consequently, we have $\deg \theta_{\ell,2} = |\mathscr{A}_2| - |\mathscr{A}^2| = (1+|\mathscr{A}_{1,2}|) - (|\mathscr{A}_1^2|+1) = |\mathscr{A}_{1,2}| - |\mathscr{A}_1^2|$. Importantly, $\theta_{\ell,2} \in D(\mathscr{A}_{1,2}) \setminus D(\mathscr{A}_1)$. According to [Proposition 2.2,](#page-3-1) this implies that $D(\mathscr{A}_{1,2})$ = $D(\mathscr{A}_1) + S\theta_{\ell,2}$. Since $\theta_{\ell,2} \in D(\mathscr{A}_2)$, we have $D(\mathscr{A}_{1,2}) = D(\mathscr{A}_1) + D(\mathscr{A}_2)$. \Box

LEMMA 3.6. If $D(\mathscr{A}) + \ker \rho_2^1 = D(\mathscr{A}_2)$, then $|\mathscr{A}_{H_1 \cap H_2}| > 2$.

Proof. By [Lemma 3.3](#page-6-2) [\(2\),](#page-6-3) we may assume that $\alpha_1\varphi$ is a level element for $D(\mathscr{A}_2)$. If $|\mathscr{A}_{H_1 \cap H_2}| =$ 2, it follows that $D(\mathscr{A}_{1,2}) = D(\mathscr{A}_1) + D(\mathscr{A}_2)$ by [Lemma 3.5.](#page-7-0) This observation further implies that

$$
\varphi \in D(\mathscr{A}_{1,2})_{< c_2} \subset D(\mathscr{A}_1)_{< c_2} + D(\mathscr{A}_2)_{< c_2} \subset D(\mathscr{A}_1) + D(\mathscr{A}) \subset D(\mathscr{A}_1).
$$

Thus, $\alpha_1\varphi \in D(\mathscr{A})$, which is a contradiction with $\alpha_1\varphi \notin D(\mathscr{A})$ being a level element for $D(\mathscr{A}_2)$. Hence, $|\mathscr{A}_{H_1 \cap H_2}| > 2$. \Box

PROPOSITION 3.7. Let $\{\theta_1,\ldots,\theta_\ell\}$ be a basis for $D(\mathscr{A})$. There exist two level elements, $\theta_{\ell,1}$ for $D(\mathscr{A}_1)$ and $\theta_{\ell,2}$ for $D(\mathscr{A}_2)$, such that a minimal generator set for $D(\mathscr{A}_{1,2})$ falls into one of the following cases:

- (1) If $D(\mathscr{A})$ + ker $\rho_1^2 \subsetneq D(\mathscr{A}_1)$ and $D(\mathscr{A})$ + ker $\rho_2^1 = D(\mathscr{A}_2)$, then $|\mathscr{A}_{H_1 \cap H_2}| > 2$, and a minimal generator set for $D(\mathscr{A}_{1,2})$ can be expressed as either $\{\theta_1,\ldots,\theta_\ell,\varphi_2,\theta_{\ell,1} \mid \theta_{\ell,2} = \alpha_1 \varphi_2\}$ or $\{\theta_1,\ldots,\theta_{\ell-1},\varphi_2,\theta_{\ell,1}\mid c_1 < c_2 = \deg \theta_{\ell}, \alpha_2\theta_{\ell,2} = \alpha_2\alpha_1\varphi_2 \in S\theta_1 + \cdots + S\theta_{\ell-1} + \mathbb{K}^*\alpha_1\theta_{\ell}\},\$ where $\mathbb{K}^* = \mathbb{K} \setminus \{0\}.$
- (2) If $D(\mathscr{A})$ + ker $\rho_1^2 = D(\mathscr{A}_1)$, then $c_1 = c_2$, $|\mathscr{A}_{H_1 \cap H_2}| > 2$, $D(\mathscr{A})$ + ker $\rho_2^1 = D(\mathscr{A}_2)$, and a minimal generator set for $D(\mathscr{A}_{1,2})$ can be expressed as $\{\theta_1,\ldots,\theta_\ell,\varphi_1\mid \theta_{\ell,1}=\alpha_2\varphi_1\}.$
- (3) If $D(\mathscr{A})$ + ker $\rho_2^1 \subsetneq D(\mathscr{A}_2)$, then the set $\{\theta_1, \ldots, \theta_\ell, \theta_{\ell,1}, \theta_{\ell,2}\}$ forms, or can be extended to, a minimal generator set for $D(\mathscr{A}_{1,2})$.

Moreover, if $|\mathscr{A}_{H_1 \cap H_2}| = 2$, the set $\{\theta_1, \ldots, \theta_\ell, \theta_{\ell,1}, \theta_{\ell,2}\}$ forms a minimal generator set for $D(\mathscr{A}_{1,2})$.

Proof. Note that $c_1 \leq c_2$, which means this statement is not symmetric with respect to \mathscr{A}_1 and \mathscr{A}_2 . We prove this statement case by case.

(1) $D(\mathscr{A}) + \ker \rho_1^2 \subsetneq D(\mathscr{A}_1)$ and $D(\mathscr{A}) + \ker \rho_2^1 = D(\mathscr{A}_2)$.

By [Lemma 3.6,](#page-7-1) we have $|\mathscr{A}_{H_1 \cap H_2}| > 2$. Consequently, $|\mathscr{A}^2| = |\mathscr{A}_1^2|$. By [Lemma 3.3](#page-6-2) [\(2\),](#page-6-3) we may assume that $\theta_{\ell,2} = \alpha_1 \varphi_2$, where $\varphi_2 \in D(\mathscr{A}_{1,2})$. By [Theorem 1.4,](#page-1-0) this implies that

$$
\deg \varphi_2 = \deg \theta_{\ell,2} - 1 = (|\mathscr{A}_2| - |\mathscr{A}^2|) - 1 = |\mathscr{A}_{1,2}| - |\mathscr{A}_1^2|.
$$

Note that $\varphi_2 \notin D(\mathscr{A}_1)$. If it were, then $\alpha_1\varphi_2 \in D(\mathscr{A})$, which, since it is the level element of $D(\mathscr{A}_2)$, is not in $D(\mathscr{A})$.

 \square

According to [Proposition 2.2](#page-3-1) and since $\varphi_2 \in D(\mathscr{A}_{1,2}) \backslash D(\mathscr{A}_1)$, this indicates that $D(\mathscr{A}_{1,2})$ = $D(\mathscr{A}_1) + S\varphi_2$. Hence, the set $T = {\theta_1, \ldots, \theta_\ell, \theta_{\ell,1}, \varphi_2}$ generates $D(\mathscr{A}_{1,2})$.

If T is not a minimal generating set, there exists an element $\gamma \in T$ such that γ is generated by $T \setminus \{\gamma\}$. If $\gamma = \theta_{\ell,1}$, then there is some $h \in S$ such that $\theta_{\ell,1} - h\varphi_2 \in D(\mathscr{A})$. Since $\theta_{\ell,1} \in D(\mathscr{A}_1)$ and $D(\mathscr{A}) \subset D(\mathscr{A}_1)$, we can deduce that $h\varphi_2 \in D(\mathscr{A}_1)$. However, we have claimed that $\varphi_2 \notin D(\mathscr{A}_1)$. Therefore, it follows that $\alpha_2 \mid h$, and thus $h\varphi_2 \in \text{ker } \rho_1^2$. By $\theta_{\ell,1} - h\varphi_2 \in D(\mathscr{A})$ and $D(\mathscr{A}_1) = D(\mathscr{A}) + S\theta_{\ell,1}$, we have

$$
D(\mathscr{A}_1) = D(\mathscr{A}) + Sh\varphi_2.
$$

Since $h\varphi_2 \in \ker \rho_1^2$, we then have

$$
D(\mathscr{A}_1) = D(\mathscr{A}) + \ker \rho_1^2,
$$

which contradicts our assumption. If $\gamma = \varphi_2$, then $D(\mathscr{A}_{1,2}) = D(\mathscr{A}) + S\theta_{\ell,1} = D(\mathscr{A}_1)$, which contradicts $D(\mathscr{A}_1) \subsetneq D(\mathscr{A}_{1,2})$. If there is a $k \in \{1,\ldots,\ell\}$ such that $\gamma = \theta_k$, then we may assume that

$$
0 = p_1 \theta_1 + \dots + p_k \theta_k + \dots + p_\ell \theta_\ell + u \theta_{\ell,1} + v \varphi_2, \tag{3.1}
$$

where $p_k = 1$. It follows that $v\varphi_2 \in D(\mathscr{A}_1)$. Note that we claimed that $\varphi_2 \notin D(\mathscr{A}_1)$. Hence $\alpha_2 \mid v$, and $v = \alpha_2 v'$, where $v' \in S$. Since $p_k = 1$ and $\theta_1, \dots, \theta_\ell, \theta_{\ell,1}$ form a minimal generating set of $D(\mathscr{A}_1)$, we have $v \neq 0$. Thus deg $\theta_k = \deg v + \deg \varphi_2 \geq 1 + \deg \varphi_2 = c_2$. If $\deg \theta_k > c_2$, then $q_k = 0$ and $\alpha_2 \varphi_2 \in S \theta_1 + \cdots + S \tilde{\theta}_k + \cdots + S \theta_\ell + S \theta_{\ell,1}$. Since $v = \alpha_2 v'$, by [Equation \(3.1\),](#page-8-0) it follows that $\theta_k \in S\theta_1 + \cdots + S\hat{\theta}_k + \cdots + S\theta_\ell + S\theta_{\ell,1}$, which is a contradiction. Thus, $\deg \theta_k = c_2$. We may let $v = \alpha_2$. If $u = 0$, we have $\alpha_2\varphi_2 \in D(\mathscr{A})$. Then $\varphi_2 \in D(\mathscr{A}_2)$, which contradicts the fact that $\alpha_1\varphi_2$ is a level element of $D(\mathscr{A}_2)$. Hence, $u \neq 0$. If $c_1 = c_2$, then we may assume that $u = 1$. Thus, $\alpha_2\varphi_2$ can be a level element for $D(\mathscr{A}_1)$. By [Lemma 3.3](#page-6-2) [\(1\),](#page-6-1) we have $D(\mathscr{A}) + \text{ker } \rho_1^2 = D(\mathscr{A}_1)$, which contradicts our assumption.

As a conclusion, if T is not a minimal generating set, we may set $k = \ell$. Then, we have $c_1 < c_2 = \deg \theta_\ell$, and $T \setminus {\theta_\ell}$ forms a minimal generating set for $D(\mathscr{A}_{1,2})$. Since $\alpha_1 \theta_{\ell,1} \in D(\mathscr{A})$, we have $\alpha_1 \alpha_2 \varphi_2 \in S \theta_1 + \cdots + S \theta_{\ell-1} + \mathbb{K}^* \alpha_1 \theta_{\ell}$.

(2) $D(\mathscr{A}) + \ker \rho_1^2 = D(\mathscr{A}_1).$

By [Lemma 3.3](#page-6-2) [\(1\),](#page-6-1) we may assume that $\theta_{\ell,1} = \alpha_2 \varphi_1$, where $\varphi_1 \in D(\mathscr{A}_{1,2})$. This implies that deg $\varphi_1 = c_1 - 1$. If $\alpha_1 \varphi_1 \in D(\mathscr{A})$, we can conclude, based on [Lemma 3.4,](#page-7-2) that $\varphi_1 \in D(\mathscr{A}_1)$, which contradicts the assertion that $\theta_{\ell,1} = \alpha_2 \varphi_1$ is a level element for $D(\mathscr{A}_1)$. Therefore, we must conclude that $\alpha_1\varphi_1 \in D(\mathscr{A}_2)_{\leq c_1} \setminus D(\mathscr{A})$. It follows that $c_1 = c_2$. Hence, $\alpha_1 \varphi_1$ can serve as a level element for $D(\mathscr{A}_2)$. According to [Lemma 3.3](#page-6-2) (2), this implies $D(\mathscr{A}) + \ker \rho_2^1 = D(\mathscr{A}_2)$.

Referring to [Lemma 3.6,](#page-7-1) we establish that $|\mathscr{A}_{H_1 \cap H_2}| > 2$. Analogous to the proof in [Case \(1\),](#page-7-3) we conclude that $D(\mathscr{A}_{1,2}) = D(\mathscr{A}_1) + S\varphi_2$ and $\theta_{\ell,2} = \alpha_1\varphi_2$ is a level element for $D(\mathscr{A}_2)$. Since both $\alpha_1\varphi_1$ and $\alpha_1\varphi_2$ can be level elements of $D(\mathscr{A}_2)$, it follows that there exists a $k \in \mathbb{K} \setminus \{0\}$ such that $k\alpha_1\varphi_1 - \alpha_1\varphi_2 \in D(\mathscr{A})$, which implies $k\varphi_1 - \varphi_2 \in$ $D(\mathscr{A}_1)_{< c_1} \subset D(\mathscr{A})$. Thus, $\varphi_2 \in S\{\theta_1, \ldots, \theta_\ell, \varphi_1\}$. Note that $D(\mathscr{A}_1) \subset S\{\theta_1, \ldots, \theta_\ell, \varphi_1\}$. Consequently, the set $T = {\theta_1, ..., \theta_\ell, \varphi_1}$ generates $D(\mathscr{A}_{1,2})$.

If T is not a minimal generating set, there exists an element $\gamma \in T$ such that γ is generated by $T \setminus \{\gamma\}$. Then $D(\mathscr{A}_{1,2})$ is free. Note that $\deg \theta_1 + \cdots + \deg \theta_\ell = |\mathscr{A}| > |\mathscr{A}_{1,2}|$. By [Theorem 2.5,](#page-4-1) there is a $k \in \{1, ..., \ell\}$ such that $\gamma = \theta_k$. Suppose

$$
\theta_k = p_1 \theta_1 + \cdots + p_{k-1} \theta_{k-1} + p_{k+1} \theta_{k+1} + \cdots + p_\ell \theta_\ell + p \varphi_1.
$$

Note that φ_1 is not in either $D(\mathscr{A}_1)$ or $D(\mathscr{A}_2)$. It follows that $\alpha_1\alpha_2 \mid p$. Note that $\theta_{\ell,1} = \alpha_2 \varphi_1$. Thus, $\theta_k \in S\theta_1 + \cdots + S\theta_{k-1} + S\theta_{k+1} + \cdots + S\theta_{\ell} + S\theta_{\ell,1}$, which contradicts the fact that $\theta_1, \ldots, \theta_k, \ldots, \theta_\ell, \theta_{\ell,1}$ form a minimal generating set of $D(\mathscr{A}_1)$.

(3) $D(\mathscr{A}) + \ker \rho_2^1 \subsetneq D(\mathscr{A}_2)$.

By the proof of [Case \(2\),](#page-8-1) we can conclude that $D(\mathscr{A}) + \ker \rho_2^1 \subsetneq D(\mathscr{A}_2)$ implies $D(\mathscr{A}) +$ $\ker \rho_1^2 \subsetneq D(\mathscr{A}_1)$. Obviously, the set $\{\theta_1, \ldots, \theta_\ell, \theta_{\ell,1}, \theta_{\ell,2}\}$ forms, or can be extended to form, a generating set for $D(\mathscr{A}_{1,2})$. Suppose that the set $T = {\theta_i, \gamma_j, \theta_{\ell,1}, \theta_{\ell,2} \mid i = 1, \ldots, \ell, j =$ 1,..., t} forms a generating set for $D(\mathscr{A}_{1,2})$ such that $\gamma_j \notin S(T \setminus {\gamma_j})$. Thus, γ_j is not in either $D(\mathscr{A}_1)$ or $D(\mathscr{A}_2)$. This implies that deg $\gamma_j \geq c_2$.

If T is not minimal, there exists an element $\gamma \in T$ such that γ is generated by $T \setminus {\gamma}$. Assume that

$$
\gamma = p_1 \theta_1 + \dots + p_\ell \theta_\ell + p \theta_{\ell,1} + q \theta_{\ell,2} + q_1 \gamma_1 + \dots + q_\ell \gamma_\ell,\tag{3.2}
$$

where $p_i, q_j, p, q \notin \mathbb{K}^*$. If $\gamma = \theta_{\ell,1}$, then we may assume that $p = 0$. Note that $\deg \gamma_j \geq$ $c_2 \geq c_1 = \deg \theta_{\ell,1}$. Thus, $q_j \in \mathbb{K}$. It follows that $q_j = 0$ for all $j = 1, \ldots, t$. Therefore, $\theta_{\ell,1} \in D(\mathscr{A}_2)$, which is a contradiction.

Similarly, we can conclude that $\gamma \neq \theta_{\ell,2}$.

If there is a $k \in \{1, \ldots, \ell\}$ such that $\gamma = \theta_k$, then we may assume that $p_k = 0$. If $q_i = 0$ for all j, then $pq \neq 0$. By [Equation \(3.2\),](#page-9-1) we have $\deg \theta_k = \deg q + \deg \theta_{\ell,2} > c_2$. Thus, $p_i = 0$ for any deg $\theta_i \ge \deg \theta_k$. By the definition of an SPOG arrangement, both $\theta_{\ell,1}$ and $\theta_{\ell,2}$ are S-dependent with $\{\theta_i \mid \deg \theta_i \leq c_2\}$. It follows that θ_k is S-dependent with $\{\theta_i \mid \deg \theta_i < \deg \theta_k\}$, which is a contradiction. Thus, we may assume that q_1 has the smallest degree among the non-zero coefficient ${q_i}$. Therefore, deg $\theta_k = \text{deg } q_1 + \text{deg } \gamma_1$ deg γ_1 . Since $\alpha_1\gamma_j \in D(\mathscr{A}_1)$ and γ_j is not in $D(\mathscr{A}_1)$, it follows that γ_j is S-dependent with $\{\theta_{\ell,1}\}\cup\{\theta_i\mid \deg\theta_i\leq \deg\gamma_j\}$. Note that $\deg\gamma_j\geq c_2$ for all j, and $\theta_{\ell,1}$ is S-dependent with $\{\theta_i \mid \deg \theta_i \leq c_2\}$. It follows that θ_k is S-dependent with $\{\theta_i \mid \deg \theta_i \leq \deg \gamma_1\}$, which is a contradiction.

In conclusion, the set $\{\theta_1,\ldots,\theta_\ell,\theta_{\ell,1},\theta_{\ell,2}\}\)$ forms, or can be extended to, a minimal generating set for $D(\mathscr{A}_{1,2})$. Furthermore, in the scenario where $|\mathscr{A}_{H_1 \cap H_2}| = 2$, as corroborated by [Lemma 3.5,](#page-7-0) the set $\{\theta_1, \ldots, \theta_\ell, \theta_{\ell,1}, \theta_{\ell,2}\}$ serves as a minimal generating set for $D(\mathscr{A}_{1,2})$.

 \Box

When constructing a graded free resolution, it is minimal if, and only if, at each step, we select a minimal homogeneous system of generators for the kernel of the differential. Refer to Construction 4.2 and Theorem 7.3 in [\[10\]](#page-21-5) for details. Let us employ this approach to construct a minimal free resolution for $D(\mathscr{A}_{1,2})$.

THEOREM 3.8. If $|DS(\mathcal{A}_{1,2})| \leq \ell+2$, then $D(\mathcal{A}_{1,2})$ has a minimal free resolution of one of the following forms:

(1) If

D(\mathscr{A})

 + ker $\rho_1^2 = D(\mathscr{A}_1)$, there exist $f_1, ..., f_\ell \in S$ such that
\n

0 \to S[-c_1 - 1] \xrightarrow{(\alpha_1 \alpha_2, f_1, ..., f_\ell)} S[-c_1 + 1] \oplus \left(\bigoplus_{i=1}^{\ell} S[-d_i] \right) \to D(\mathscr{A}_{1,2}) \to 0.
$$

(2) If $D(\mathscr{A})$ + ker $\rho_1^2 \subsetneq D(\mathscr{A}_1)$, $D(\mathscr{A})$ + ker $\rho_2^1 = D(\mathscr{A}_2)$, and $|DS(\mathscr{A}_{1,2})| = \ell + 2$, there exist $f_i, g_i, g \in S$ with $g \neq 0$ such that

$$
(a_1, 0, f_1, ..., f_\ell)
$$

\n
$$
0 \to S[-c_1 - 1] \oplus S[-c_2] \xrightarrow{(g, \alpha_2, g_1, ..., g_\ell)} S[-c_1] \oplus S[-c_2 + 1] \oplus \left(\bigoplus_{i=1}^{\ell} S[-d_i]\right) \to D(\mathscr{A}_{1,2}) \to 0.
$$

(3) If $D(\mathscr{A})$ + ker $\rho_1^2 \subsetneq D(\mathscr{A}_1)$, $D(\mathscr{A})$ + ker $\rho_2^1 = D(\mathscr{A}_2)$, and $|DS(\mathscr{A}_{1,2})| = \ell + 1$, there exist $f_1, \ldots, f_{\ell-1} \in S$ such that

$$
0 \to S[-c_1-1] \xrightarrow{(\alpha_1,0,f_1,\ldots,f_{\ell-1})} S[-c_1] \oplus S[-c_2+1] \oplus \left(\bigoplus_{i=1}^{\ell-1} S[-d_i]\right) \to D(\mathscr{A}_{1,2}) \to 0.
$$

Moreover, in this case, $\mathcal{A}_{1,2}$ is SPOG.

(4) If $D(\mathscr{A})$ + ker $\rho_2^1 \subsetneq D(\mathscr{A}_2)$, there exist $f_i, g_i \in S$ such that

(0, 0, f_1, ..., f_\ell)
$$

\n
$$
0 \to S[-c_1 - 1] \oplus S[-c_2 - 1] \xrightarrow{(0, \alpha_2, g_1, ..., g_\ell)} S[-c_1] \oplus S[-c_2] \oplus \left(\bigoplus_{i=1}^{\ell} S[-d_i]\right) \to D(\mathscr{A}_{1,2}) \to 0.
$$

Proof. We retain the notation introduced in [Proposition 3.7](#page-7-4) and its proof. Given $|DS(\mathscr{A}_{1,2})| \leq$ $\ell+2$ and utilizing [Proposition 3.7,](#page-7-4) we proceed to analyze the proof on a case-by-case basis.

(1) $D(\mathscr{A}) + \ker \rho_1^2 = D(\mathscr{A}_1).$

Note that $\{\varphi_1,\theta_i \mid i=1,\ldots,\ell\}$ is a minimal generator set for $D(\mathscr{A}_{1,2})$. Since $\theta_{\ell,1} = \alpha_2 \varphi_1$ is a level element for $D(\mathscr{A}_1)$, we may assume that $\alpha_1(\alpha_2\varphi_1) + \sum_{i=1}^{\ell} f_i\theta_i = 0$. In other words, there exists a relation

$$
(\alpha_1 \alpha_2, f_1, \dots, f_\ell) \tag{3.3}
$$

between $\{\varphi_1, \theta_1, \ldots, \theta_\ell\}.$

Suppose there exists another S-independent relation, say:

(p, p_1, \ldots, p_\ell). \tag{3.4}
$$

This implies that $p\varphi_1 \in D(\mathscr{A})$. Consequently, $p\varphi_1(\alpha_2) \in S(\alpha_2)$. If $\varphi_1(\alpha_2) \in S(\alpha_2)$, it implies that $\varphi_1 \in D(\mathscr{A}_1)$, which contradicts the statement that $\theta_{\ell,1} = \alpha_2 \varphi_1$ is a level element for $D(\mathscr{A}_1)$. As a result, we conclude that $\alpha_2|p$. Therefore Relation [\(3.4\)](#page-10-0) is actually a relation amongst the minimal generators of the SPOG arrangement \mathscr{A}_1 , of which there is only one by [Definition 1.2.](#page-1-1) Consequently, there exist $f_1, \ldots, f_\ell \in S$ such that $D(\mathscr{A}_{1,2})$ has a minimal free resolution of the following forms:

0 \to S[-c_1 - 1] \xrightarrow{(\alpha_1 \alpha_2, f_1, \dots, f_\ell)} S[-c_1 + 1] \oplus \left(\bigoplus_{i=1}^{\ell} S[-d_i] \right) \to D(\mathscr{A}_{1,2}) \to 0.
$$

(2) $D(\mathscr{A}) + \ker \rho_1^2 \subsetneq D(\mathscr{A}_1), D(\mathscr{A}) + \ker \rho_2^1 = D(\mathscr{A}_2)$ and $|DS(\mathscr{A}_{1,2})| = \ell + 2$.

Note that $\{\theta_{\ell,1}, \varphi_2, \theta_1, \ldots, \theta_\ell\}$ is a minimal generator set for $D(\mathscr{A}_{1,2})$. Since $\theta_{\ell,1}$ is a level element for $D(\mathscr{A}_1)$, we can assume that

$$
\alpha_1 \theta_{\ell,1} + \sum_{i=1}^{\ell} f_i \theta_i = 0.
$$

In other words, there exists a relation

$$
(\alpha_1, 0, f_1, \dots, f_\ell) \tag{3.5}
$$

between $\{\theta_{\ell,1}, \varphi_2, \theta_1, \ldots, \theta_\ell\}.$

Since $\alpha_2\varphi_2 \in D(\mathscr{A}_1) \setminus D(\mathscr{A})$, we may assume that

g\theta_{\ell,1} + \alpha_2 \varphi_2 + \sum_{i=1}^{\ell} g_i \theta_i = 0,
$$

with $g \neq 0$. This gives another relation

(g, \alpha_2, g_1, \ldots, g_\ell) \tag{3.6}

between $\{\theta_{\ell,1}, \varphi_2, \theta_1, \ldots, \theta_\ell\}$, and it is S-independent with Relation [\(3.5\)](#page-11-0).

If there exist additional relations, denoted as $(p, q, p_1, \ldots, p_\ell)$, the implication is as follows:

p\theta_{\ell,1} + q\varphi_2 + \sum_{i=1}^{\ell} p_i \theta_i = 0.
$$

This implies that $q\varphi_2 \in D(\mathscr{A}_1)$. Consequently, $q\varphi_2(\alpha_2) \in S(\alpha_2)$. If $\varphi_2(\alpha_2) \in S(\alpha_2)$, it implies that $\alpha_1\varphi_2 \in D(\mathscr{A})$, which contradicts the assertion that the level element $\theta_{\ell,2} = \alpha_1\varphi_2$ for $D(\mathscr{A}_2)$ is not in $D(\mathscr{A})$. As a result, we conclude that $\alpha_2|q$. We see $\frac{q}{\alpha_2}(g, \alpha_2, g_1, \ldots, g_\ell)$ $(p, q, p_1, \ldots, p_\ell)$ is a relation of the form (3.5) , which is the unique $D(\mathscr{A}_1)$ relation. Thus, $(p, q, p_1, \ldots, p_\ell)$ can be represented by the relations [\(3.5\)](#page-11-0) and [\(3.6\)](#page-11-1). That (3.5) and (3.6) are S-independent is clear since $\alpha_2 \neq 0$.

Thus $D(\mathscr{A}_{1,2})$ has a minimal free resolution of the following forms:

$$
(a_1, 0, f_1, \dots, f_\ell)
$$

\n
$$
0 \to S[-c_1 - 1] \oplus S[-c_2] \xrightarrow{(g, \alpha_2, g_1, \dots, g_\ell)} S[-c_1] \oplus S[-c_2 + 1] \oplus \left(\bigoplus_{i=1}^{\ell} S[-d_i]\right) \to D(\mathscr{A}_{1,2}) \to 0.
$$

(3) $D(\mathscr{A}) + \ker \rho_1^2 \subsetneq D(\mathscr{A}_1), D(\mathscr{A}) + \ker \rho_2^1 = D(\mathscr{A}_2)$ and $|DS(\mathscr{A}_{1,2})| = \ell + 1$. Since \mathscr{A}_1 is SPOG and $D(\mathscr{A}_1)$ is generated by $\{\theta_{\ell,1}, \theta_1, \ldots, \theta_{\ell}\}\)$, we may assume that

$$
\alpha_1 \theta_{\ell,1} + \sum_{i=1}^{\ell} f_i \theta_i = 0.
$$

By [Proposition 3.7](#page-7-4) [\(1\),](#page-7-5) we have $c_1 < c_2 = \deg \theta_\ell$. Thus, $f_\ell = 0$, and we obtain a relation

$$
(\alpha_1,0,f_1,\ldots,f_{\ell-1})
$$

between $\{\theta_{\ell,1}, \varphi_2, \theta_1, \ldots, \theta_{\ell-1}\}\$, the minimal generating set of $D(\mathscr{A}_{1,2})$.

If additional relations are present, denoted as $(p, q, p_1, \ldots, p_{\ell-1})$, the corresponding equation is expressed as follows:

p\theta_{\ell,1} + q\varphi_2 + \sum_{i=1}^{\ell-1} p_i \theta_i = 0.
$$

Note that $\theta_{\ell,1}$ is S-dependent with $\theta_1, \ldots, \theta_{\ell-1}$ by $f_{\ell} = 0$. By rearranging, we get:

-q\varphi_2 = p\theta_{\ell,1} + \sum_{i=1}^{\ell-1} p_i \theta_i,

which implies that $q\varphi_2$ is S-dependent with $\theta_1, \ldots, \theta_{\ell-1}$. However, considering $q\alpha_2\theta_{\ell,2} =$ $q\alpha_2\alpha_1\varphi_2 \in S\theta_1 + \cdots + S\theta_{\ell-1} + q\mathbb{K}^*\alpha_1\theta_\ell$, we deduce that $q = 0$. This gives a relation between the generators for the SPOG arrangement \mathscr{A}_1 . Hence, we can conclude that ${\theta_{\ell,1}, \varphi_2, \theta_1, \ldots, \theta_{\ell-1}}$ has a unique relation $(\alpha_1, 0, f_1, \ldots, f_{\ell-1})$. Thus, $D(\mathscr{A}_{1,2})$ has a minimal free resolution of the following form:

0 \to S[-c_1 - 1] \xrightarrow{(\alpha_1, 0, f_1, ..., f_{\ell-1})} S[-c_1] \oplus S[-c_2 + 1] \oplus \left(\bigoplus_{i=1}^{\ell-1} S[-d_i] \right) \to D(\mathscr{A}_{1,2}) \to 0.
$$

Moreover, based on the definition of SPOG, we deduce that $\mathscr{A}_{1,2}$ is SPOG.

(4) $D(\mathscr{A}) + \ker \rho_2^1 \subsetneq D(\mathscr{A}_2)$.

Note that $\{\theta_{\ell,1}, \theta_{\ell,2}, \theta_1, \ldots, \theta_\ell\}$ is a minimal generator set for $D(\mathscr{A}_{1,2})$. Since $\theta_{\ell,j}$, where $j = 1, 2$, is a level element for $D(\mathscr{A}_j)$, we can assume that

$$
\alpha_1 \theta_{\ell,1} + \sum_{i=1}^{\ell} f_i \theta_i = 0,
$$

$$
\alpha_2 \theta_{\ell,2} + \sum_{i=1}^{\ell} g_i \theta_i = 0.
$$

In other words, there are two relations

$$
(\alpha_1, 0, f_1, \dots, f_\ell) \tag{3.7}
$$

$$
(0, \alpha_2, g_1, \dots, g_\ell) \tag{3.8}
$$

between $\{\theta_{\ell,1}, \theta_{\ell,2}, \theta_1, \ldots, \theta_\ell\}$. If there exist additional relations, denoted as $(p, q, p_1, \ldots, p_\ell)$, the implication is as follows:

p\theta_{\ell,1} + q\theta_{\ell,2} + \sum_{i=1}^{\ell} p_i \theta_i = 0.
$$

This implies that $q\theta_{\ell,2} \in D(\mathscr{A}_1)$. Consequently, $q\theta_{\ell,2}(\alpha_2) \in S(\alpha_2)$. Considering that $\theta_{\ell,2}$ is a level element for $D(\mathscr{A}_2)$, it follows that $\theta_{\ell,2}(\alpha_2) \notin S(\alpha_2)$. As a result, we conclude that $\alpha_2|q$. According to Relation [\(3.8\)](#page-12-0), we have $q\theta_{\ell,2} \in D(\mathscr{A})$. This observation suggests that this relation establishes a connection among $\{\theta_{\ell,1}, \theta_1, \ldots, \theta_{\ell}\}\$. Given that Relations [\(3.7\)](#page-12-1) and [\(3.8\)](#page-12-0) uniquely characterize the relationship between sets $\{\theta_{\ell,1}, \theta_1, \ldots, \theta_{\ell}\}\$ and $\{\theta_{\ell,2}, \theta_1, \ldots, \theta_\ell\}$, respectively, and taking into account the S-independence of $\theta_1, \ldots, \theta_\ell$, we can deduce that Relation $(p, q, p_1, \ldots, p_\ell)$ can be represented by Relations [\(3.7\)](#page-12-1) and [\(3.8\)](#page-12-0). That Relations [\(3.7\)](#page-12-1) and [\(3.8\)](#page-12-0) are S-independent is clear since $\alpha_1, \alpha_2 \neq 0$.

Thus $D(\mathscr{A}_{1,2})$ has a minimal free resolution of the following forms:

$$
(\alpha_1, 0, f_1, \dots, f_{\ell})
$$

\n
$$
0 \to S[-c_1 - 1] \oplus S[-c_2 - 1] \xrightarrow{(0, \alpha_2, g_1, \dots, g_{\ell})} S[-c_1] \oplus S[-c_2] \oplus \left(\bigoplus_{i=1}^{\ell} S[-d_i] \right) \to D(\mathscr{A}_{1,2}) \to 0.
$$

 \Box

THEOREM 3.9. Let B in [Definition 2.9](#page-5-2) be defined as $\mathcal{A}_{1,2}$. Assume that $|DS(\mathcal{A}_{1,2})| > \ell + 2$ with $DS(\mathscr{A}_{1,2}) = (d_1, \ldots, d_\ell, c_1, \ldots, c_r)$. Then, the following statements hold:

(1) We have $\bigoplus_{j=1}^r S[-c_j-1] \subsetneq M_1$, and there exist $h_{ij}, h_j \in S$ with $h_j \neq 0$ such that

 $R_1(1) = (h_{11}, \ldots, h_{\ell 1}, \alpha_1, 0, \ldots, 0),$ $R_1(2) = (h_{12}, \ldots, h_{\ell_2}, 0, \alpha_2, 0 \ldots, 0),$ $R_1(j) = (h_{1j}, \ldots, h_{\ell j}, h_j, 0, \ldots, 0, \alpha_2, 0, \ldots, 0),$

where $R_1(j)$ denotes the j-th row of R_1 , and $R_1(j)(\ell + j) = \alpha_2$ for $j = 3, \ldots, r$.

(2) We write

$$
R_1 = (\psi_1, \dots, \psi_r, \phi_1, \dots, \phi_t)^T,
$$

$$
M_1 = \left(\bigoplus_{j=1}^r S[-c_i - 1]\right) \oplus \left(\bigoplus_{i=1}^t S[-e_i]\right)
$$

with some $t > 0$. Here, ψ_i corresponds to $R_1(j)$ as defined in (1), where $j = 1, \dots, r$. Then, $\bigoplus_{i=1}^t S[-e_i-1] \subset M_2$. In particular, $M_2 \neq 0$. Moreover, $R_2(i)$ has the form $(f_{1i},...,f_{ri},0,...,0,\alpha_2,0,...,0),$ where $f_{ji} \in S$ and $R_2(i)(r+i) = \alpha_2$ for $i = 1,...,t$. When $\bigoplus_{i=1}^{t} S[-e_i - 1] = M_2$, we have $t = r - 2$ and $M_3 = 0$.

Proof. (1) By [Proposition 3.7,](#page-7-4) we may assume that the minimal generator set of $D(\mathscr{A}_{1,2})$ is $T = \{\theta_i, \varphi_j \mid \deg \theta_i = d_i, \deg \varphi_j = c_j, i = 1, \ldots, \ell, j = 1, \ldots, r\}.$ Here $\{\theta_i \mid i = 1, \ldots, \ell\}$ forms a basis for $D(\mathscr{A})$, and φ_1 and φ_2 represent the level elements of $D(\mathscr{A}_1)$ and $D(\mathscr{A}_2)$, respectively. By [Proposition 3.7,](#page-7-4) it holds that $c_i \geq c_2$ for $i > 2$, and

$$
M_0 = \left(\bigoplus_{i=1}^{\ell} S[-d_i]\right) \bigoplus \left(\bigoplus_{j=1}^r S[-c_i]\right).
$$

Note that $\alpha_1\varphi_1, \alpha_2\varphi_2 \in D(\mathscr{A})$ and $\alpha_2\varphi_j \in D(\mathscr{A}) \setminus D(\mathscr{A})$ for $j > 2$. Hence we have the following relations:

\psi_1 := (h_{11}, \dots, h_{\ell 1}, \alpha_1, 0, \dots, 0),
$$

\n
$$
\psi_2 := (h_{12}, \dots, h_{\ell 2}, 0, \alpha_2, 0 \dots, 0),
$$

\n
$$
\psi_j := (h_{1j}, \dots, h_{\ell j}, h_j, 0, \dots, 0, \alpha_2, 0, \dots, 0),
$$

where $h_i \neq 0$ and $\alpha_2 = \psi_i (\ell + j)$.

Suppose there exists a $j_0 \in \{1, \ldots, r\}$ such that ψ_{j_0} is not K-spanned by $\{R_1(i)\}_i$. In this $\sum_{i=1}^{w} p_i R_1(i)$, where $p_i \in S_{\geq 1}$. It's noteworthy that p_i and $R_1(i)(j)$, where $i = 1, \ldots, w$ scenario, we can assume the existence of relations $R_1(1), \ldots, R_1(w) \in R_1$ such that $\psi_{j_0} =$ and $j = 1, ..., \ell + r$, are homogeneous polynomials in $S_{\geq 1}$.

If $j_0 = 1$, this implies that

\alpha_1 = \psi_1(\ell + 1) = \sum_{i=1}^w p_i R_1(i)(\ell + 1) \in S_{\geq 2},
$$

leading to a contradiction. Hence, we deduce that $j_0 > 1$. Further, examining the expression

we again arrive at a contradiction. Consequently, we have that $R_1(1) = \psi_1, \ldots, R_1(r)$ ψ_r and $\bigoplus_{j=1}^r S[-c_i-1] \subset M_1$.

Assume $\bigoplus_{j=1}^r S[-c_i-1] = M_1$. Observe that $\psi_1(\ell+1,\ldots,\ell+r),\ldots,\psi_r(\ell+1,\ldots,\ell+r)$ r) form a lower triangular matrix. It is evident that the relations ψ_1, \ldots, ψ_r are Sindependent over S. As a consequence, we deduce that $M_2 = 0$. By referencing [Theorem 2.11,](#page-5-3) we can deduce that $|\mathscr{A}_{1,2}| = (\sum_{i=1}^{\ell} d_i + \sum_{j=1}^{r} c_j) - (\sum_{j=1}^{r} (c_j + 1)) = \sum_{i=1}^{\ell} d_i - r$. Considering $|\mathscr{A}_{1,2}| = |\mathscr{A}| - 2 = \sum_{i=1}^{\ell} d_i - 2$, it follows that $r = 2$, contradicting the assumption $|DS(\mathscr{A}_{1,2})| = \ell + r > \ell + 2$. Hence, we conclude that $\bigoplus_{j=1}^r S[-c_i-1] \subsetneq M_1$.

(2) We can assume that $\phi_i = (u_{1i}, \ldots, u_{\ell i}, v_{1i}, \ldots, v_{ri})$. We set ϕ as follows:

$$
\phi = \alpha_2 \phi_i - (v_{2i}\psi_2 + \dots + v_{ri}\psi_r)
$$

= $(\alpha_2 u_{1i} + \sum_{j=2}^r v_{ji}h_{1j}, \dots, \alpha_2 u_{\ell i} + \sum_{j=2}^r v_{ji}h_{\ell j}, \alpha_2 v_{1i} + \sum_{j=3}^r v_{ji}h_j, 0, \dots, 0).$

If $\phi = 0$, let $f_{1i} = 0$ and $f_{ji} = -v_{ji}$ for $j = 2, \ldots, r$. Then we have

$$
R_{\phi_i} = (f_{1i}, \dots, f_{ri}, 0, \dots, 0, \alpha_2, 0, \dots, 0)
$$

which represents a relation among the relations $R_1(1), \ldots, R_1(r+t)$, where $\alpha_2 = R_{\phi_i}(r+i)$. Otherwise, ϕ forms a relation among $\theta_1, \ldots, \theta_\ell, \varphi_1$. Since \mathscr{A}_1 is SPOG, ψ_1 is the unique relation among $\theta_1, \ldots, \theta_\ell, \varphi_1$. Hence, we deduce the existence of some $v \in S$ such that $\phi - v\psi_1 = 0$. Let $f_{1i} = -v$ and $f_{ji} = -v_{ji}$ for $j = 2, \ldots, r$. It follows that

$$
R_{\phi_i} = (f_{1i}, \dots, f_{ri}, 0, \dots, 0, \alpha_2, 0, \dots, 0)
$$

represents a relation among the relations $R_1(1), \ldots, R_1(r + t)$, where $\alpha_2 = R_{\phi_i}(r + i)$.

If there exists an $i_0 \in \{1, \ldots, t\}$ such that $R_{\phi_{i_0}}$ is not K-spanned by $\{R_2(i)\}_i$, we can assume the existence of relations $R_2(1), \ldots, R_2(w)$ such that $R_{\phi_{i_0}} = \sum_{i=1}^w p_i R_2(i)$, where $p_i \in S_{\geq 1}$. It's worth noting that p_i and $R_2(i)(j)$, where $i = 1, \ldots, w$ and $j = 1, \ldots, r + t$, are homogeneous polynomials in $S_{\geq 1}$. This implies that

$$
\alpha_2 = R_{\phi_{i_0}}(r + i_0) = \sum_{i=1}^w p_i R_2(i)(r + i_0) \in S_{\ge 2},
$$

leading to a contradiction. Consequently, this reasoning implies that $R_2(1) = R_{\phi_1}, \ldots, R_2(t) =$ R_{ϕ_t} and $\bigoplus_{j=1}^t S[-e_i-1] \subset M_2$.

Assume $M_2 = \bigoplus_{i=1}^t S[-e_i - 1]$. Observe that $R_{\phi_1}(r+1,\ldots,r+t), \ldots, R_{\phi_t}(r+1,\ldots,r+t)$ t) form a lower triangular matrix, it is evident that the relations $R_{\phi_1}, \ldots, R_{\phi_t}$ are Sindependent. As a consequence, we deduce that $M_3 = 0$. Since $\left(\sum_{i=1}^{\ell} d_i + \sum_{j=1}^{r} c_j\right)$ $(\sum_{j=1}^r (c_j+1)+\sum_{i=1}^t e_i)+(\sum_{i=1}^t (e_i+1))=|\mathcal{A}_{1,2}|$ by [Theorem 2.11,](#page-5-3) it follows that $r-t=2$. \Box

Proof of [Theorem 1.7.](#page-2-0) By [Theorems 1.4,](#page-1-0) [3.8](#page-9-0) and [3.9,](#page-13-0) the conclusion follows immediately. \Box

We would like to show some examples^{[1](#page-15-0)}.

EXAMPLE 3.10. Let $\ell = 4$ and

$$
Q(\mathscr{A}) = x_1 x_2 x_3 x_4 (x_1 - x_2)(x_1 - x_3)(x_1 - x_4)(x_2 - x_3)(x_2 - x_4)
$$

$$
(x_3 - x_4)(x_2 - x_3 + x_4)(x_1 - x_2 + x_3 - x_4).
$$

Then, $\mathscr A$ is free with $\exp(\mathscr A)=(1,3,4,4)$. The order of $H_i\in\mathscr A$ is consistent with its order of appearance in the polynomial.

By computer, \mathscr{A}_1 and \mathscr{A}_2 both are SPOG with level 4, and \mathscr{A}_8 and \mathscr{A}_{10} both are SPOG with level 5. Moreover, we have:

(1) $DS(\mathscr{A}_{1,2}) = (1, 3, 3, 4, 4)$. The minimal free resolution of $D(\mathscr{A}_{1,2})$ has the following forms:

$$
0 \to S[-5] \to S[-4]^2 \oplus S[-3]^2 \oplus S[-1] \to D(\mathscr{A}_{1,2}) \to 0.
$$

(2) $DS(\mathscr{A}_{2,10}) = (1, 3, 4, 4, 4, 4)$. The minimal free resolution of $D(\mathscr{A}_{2,10})$ has the following forms:

 $0 \to S[-5]^2 \to S[-4]^4 \oplus S[-3] \oplus S[-1] \to D(\mathscr{A}_{2,10}) \to 0.$

(3) $DS(\mathscr{A}_{1,8}) = (1, 3, 4, 4, 4, 5)$. The minimal free resolution of $D(\mathscr{A}_{1,8})$ has the following forms:

$$
0 \to S[-6] \oplus S[-5] \to S[-5] \oplus S[-4]^3 \oplus S[-3] \oplus S[-1] \to D(\mathscr{A}_{1,8}) \to 0.
$$

EXAMPLE 3.11. Let $\ell = 4$ and

$$
Q(\mathscr{A}) = x_1 x_2 x_3 x_4 (x_1 - x_2)(x_1 - x_3)(x_2 - x_3)(x_3 - x_4)
$$

$$
(x_2 - x_3 + x_4)(x_1 - x_2 + x_3 - x_4).
$$

Then, $\mathscr A$ is free with $\exp(\mathscr A)=(1,3,3,3)$. The order of $H_i\in\mathscr A$ is consistent with its order of appearance in the polynomial.

Note that \mathscr{A}^2 is not free, serving as a counter-example to Orlik's Conjecture. This can be found in $\left[5\right]$ or $\left[8\right]$ by performing a coordinate change.

By computation, $\mathscr{A}_1, \mathscr{A}_2$, and \mathscr{A}_3 are SPOG with level 3, and $|DS(\mathscr{A}_{2,j})| = 5 < l + 2$ for any $H_i \in \mathscr{A}_2$. Additionally, for \mathscr{A}^1 and \mathscr{A}^3 are free, we found that $|DS(\mathscr{A}_{1,3})| = 7 > \ell + 2$. The minimal free resolution of $D(\mathscr{A}_{1,3})$ has the following form:

$$
0 \to S[-5] \to S[-4]^4 \to S[-3]^6 \oplus S[-1] \to D(\mathscr{A}_{1,3}) \to 0.
$$

REMARK 3.12. The counterexample to Orlik's conjecture mentioned above corresponds to the situation $|D(\mathscr{A}_{1,2})| > \ell + 2$. However, every NT-free-2 arrangement of Edelman and Reiner's counterexample, with dimension $\ell = 5$, contains at most $7 = \ell + 2$ minimal generators.

Applying our theorem allows us to recover the result in [\[3\]](#page-21-8) and verify a part of Conjecture 4.4 from [\[1\]](#page-21-2).

COROLLARY 3.13. [\[3\]](#page-21-8) If $\mathscr A$ and $\mathscr A_{1,2}$ are both free, then at least one of $\mathscr A_1$ and $\mathscr A_2$ is free.

Proof. This is Theorem 1.2 in [\[3\]](#page-21-8). Moreover, in this paper, we can readily arrive at the same conclusion through [Proposition 3.7.](#page-7-4) \Box

COROLLARY 3.14. If $\mathscr{A}_{1,2}$ is SPOG, then $c_2 = d_j$ for some $j \in \{2, ..., l\}$.

Proof. By referring to [Theorem 3.8,](#page-9-0) we establish its validity for Case (3) in [Theorem 3.8,](#page-9-0) focusing solely on [Theorem 3.8](#page-9-0) [\(1\).](#page-9-2)

Assuming $\text{POexp}(\mathscr{A}_{1,2}) = (1, p_2, \ldots, p_\ell)$, [Proposition 2.12](#page-5-4) implies $\sum_{i=2}^{\ell} p_i = |\mathscr{A}_{1,2}|$. Ex-amining [Theorem 3.8](#page-9-0) [\(1\),](#page-9-2) we find $DS(\mathscr{A}_{1,2}) = (1, d_2, \ldots, d_\ell, c_2 - 1)$. It's noteworthy that $1 + \sum_{i=2}^{\ell} d_i = |\mathscr{A}|$ and $\text{POexp}(\mathscr{A}_{1,2}) \subset \text{DS}(\mathscr{A}_{1,2})$. This implies the existence of a d_j such that $\sum_{i=2}^{\ell} d_i + (c_2 - 1) - d_j = |\mathcal{A}_{1,2}|$. Consequently, we deduce that $c_2 = d_j$.

 \Box

4 Three Dimensional Case

In this section, we will persist in employing the notation introduced at the outset of the preceding section. Furthermore, we fix the parameter ℓ to be 3.

If $|\mathscr{A}_{H_1 \cap H_2}| > 2$, there exists a plane $H \in \mathscr{A}_{H_1 \cap H_2}$ that is distinct from both H_1 and H_2 . We can assume that $H = \ker x_2$, $H_1 = \ker x_1$, and $H_2 = \ker(x_1 - x_2)$.

PROPOSITION 4.1. If $|\mathscr{A}_{H_1 \cap H_2}| > 2$, then for any basis θ_2, θ_3 for $D_H(\mathscr{A})$, there exist a level element $\theta_{3,i}$ for $D(\mathscr{A}_i)$ such that

$$
x_1 \theta_{3,1} = f_2 \theta_2 + f_3 \theta_3, f_2, f_3 \in \mathbb{K}[x_2, x_3],\tag{4.1}
$$

$$
(x_1 - x_2)\theta_{3,2} = g_2\theta_2 + g_3\theta_3, g_2, g_3 \in \mathbb{K}[x_2, x_3].
$$
\n(4.2)

Proof. Suppose that $\theta'_{3,i} \in D_H(\mathscr{A}_i)$ is a level element for $D(\mathscr{A}_i)$, where $i = 1, 2$. Using [Theorem 1.4,](#page-1-0) we may assume that:

$$
x_1 \theta'_{3,1} = f'_2 \theta_2 + f'_3 \theta_3,\tag{4.3}
$$

$$
(x_1 - x_2)\theta'_{3,2} = g'_2\theta_2 + g'_3\theta_3,\tag{4.4}
$$

Since f'_i and g'_i are homogeneous polynomial in $S = \mathbb{K}[x_1, x_2, x_3]$, we may assume that:

$$
f'_i = x_1 f''_i + f_i, \ i = 2, 3, \ f_i \in \mathbb{K}[x_2, x_3],
$$

$$
g'_i = (x_1 - x_2)g''_i + g_i, \ i = 2, 3, \ g_i \in \mathbb{K}[x_2, x_3].
$$

Let $\theta_{3,1} = \theta'_{3,1} - f''_2 \theta_2 - f''_3 \theta_3$. Considering that $\theta_{3,1} \notin D(\mathscr{A})$ and $\deg \theta_{3,1} = \deg \theta'_{3,1}$, it is evident that $\theta_{3,1}$ qualifies as a level element for $D(\mathscr{A}_1)$. By substituting $\theta_{3,1}$ into [Equation \(4.3\),](#page-16-0) we obtain [Equation \(4.1\).](#page-16-1) A parallel application yields [Equation \(4.2\).](#page-16-2) \Box

LEMMA 4.2. Consider the scenario where $|\mathscr{A}_{H_1 \cap H_2}| > 2$, and let θ_2, θ_3 form a basis for $D_H(\mathscr{A})$. Assuming that $\theta_{3,1}$ and $\theta_{3,2}$ are the level elements for $D(\mathscr{A}_1)$ and $D(\mathscr{A}_2)$, respectively, satisfying [Proposition 4.1.](#page-16-3) If

$$
\begin{cases}\nf_2 = x_2 f_2' + k x_3^r, & k \in \mathbb{K}^*, r \in \mathbb{Z}^+, f_2' \in \mathbb{K}[x_2, x_3], \\
g_2 = x_2 g_2' + k' x_3^{r'}, & k' \in \mathbb{K}^*, r' \in \mathbb{Z}^+, g_2' \in \mathbb{K}[x_2, x_3],\n\end{cases}\n\begin{cases}\nf_3 = x_2 f_3', & f_3' \in \mathbb{K}[x_2, x_3], \\
g_3 = x_2 g_3', & g_3' \in \mathbb{K}[x_2, x_3],\n\end{cases}
$$

then

- (1) $c_1 = c_2$ if and only if $D(\mathscr{A}_1) = D(\mathscr{A}) + \text{ker } \rho_1^2$. In this case, $c_1 = c_2 = \max\{d_1, d_2, d_3\}$ if and only if $\mathcal{A}_{1,2}$ is SPOG.
- (2) $c_1 < c_2$ if and only if $D(\mathcal{A}_1) \subsetneq D(\mathcal{A}) + \ker \rho_1^2$ and $D(\mathcal{A}_2) = D(\mathcal{A}) + \ker \rho_2^1$.

Proof. Since $\deg \theta_{3,1} = c_1 \leq \deg \theta_{3,2} = c_2$, we have $r' \geq r$. Assuming that $h = \frac{k'}{k}$ $rac{k'}{k}x_3^{r'-r}$ $j_3^{r'-r}$, then we may get that:

$$
x_1(\theta_{3,2} - h\theta_{3,1}) = x_1\theta_{3,2} - hx_1\theta_{3,1}
$$

= $(x_1 - x_2)\theta_{3,2} + x_2\theta_{3,2} - hx_1\theta_{3,1}$
= $(g_2\theta_2 + g_3\theta_3) + x_2\theta_{3,2} - h(f_2\theta_2 + f_3\theta_3)$
= $(g_2 - hf_2)\theta_2 + (g_3 - hf_3)\theta_3 + x_2\theta_{3,2}$
= $x_2(g'_2 - hf'_2)\theta_2 + x_2(g'_3 - hf'_3)\theta_3 + x_2\theta_{3,2}.$

Consequently, $x_1(\theta_{3,2} - h\theta_{3,1}) \in x_2D(\mathscr{A}_2)$, implying $\theta_{3,2} - h\theta_{3,1} \in x_2D(\mathscr{A}_{1,2})$. We may assume that:

$$
\theta_{3,2} - h\theta_{3,1} = x_2\varphi, \text{ where } \varphi \in D(\mathscr{A}_{1,2}).
$$

This leads to:

$$
\theta_{3,2} - x_1 \varphi = h\theta_{3,1} - (x_1 - x_2)\varphi. \tag{4.5}
$$

Since the left side belongs to $D(\mathscr{A}_2)$, and the right side belongs to $D(\mathscr{A}_1)$, this implies that $\theta_{3,2} - x_1\varphi \in D(\mathscr{A})$. Note that $\theta_{3,2}$ is a level element for $D(\mathscr{A}_2)$. They imply that $x_1\varphi$ is a level element for $D(\mathscr{A}_2)$. By [Lemma 3.3,](#page-6-2) we know that $D(\mathscr{A}_2) = D(\mathscr{A}) + \ker \rho_2^1$.

Now, let's organize the proof on a case-by-case basis.

(1) If $D(\mathscr{A}_1) = D(\mathscr{A})$ + ker ρ_1^2 , by [Proposition 3.7](#page-7-4) [\(2\),](#page-7-6) we have $c_1 = c_2$. Conversely, we get $h \in \mathbb{K}^*$. Let $h = 1$. By [Equation \(4.5\),](#page-17-0) this implies that $\theta_{3,1} - (x_1 - x_2)\varphi \in D(\mathscr{A})$. Note that $\theta_{3,1}$ is a level element for $D(\mathscr{A}_1)$. They imply that $(x_1 - x_2)\varphi$ is a level element for $D(\mathscr{A}_1)$. By [Lemma 3.3,](#page-6-2) leading to the deduction that $D(\mathscr{A}_1) = D(\mathscr{A}) + \ker \rho_1^2$.

If $c_1 = c_2 = \max\{d_1, d_2, d_3\}$, then by [Theorem 3.8](#page-9-0) [\(1\)](#page-9-2) and the definition of an SPOG arrangement, we have that $\mathcal{A}_{1,2}$ is SPOG with level max $\{d_1, d_2, d_3\}$. Furthermore, if $\mathcal{A}_{1,2}$ is SPOG, by employing [Corollary 3.14](#page-16-4) and [Theorem 1.4,](#page-1-0) it follows that $c_1 = c_2$ $\max\{d_1, d_2, d_3\}.$

(2) Given that $c_1 < c_2$, by [Proposition 3.7](#page-7-4) [\(2\),](#page-7-6) we establish that $D(\mathscr{A}_1) \subsetneq D(\mathscr{A}) + \ker \rho_1^2$. If $D(\mathscr{A}_1) \subsetneq D(\mathscr{A}) + \ker \rho_1^2$ and $D(\mathscr{A}_2) = D(\mathscr{A}) + \ker \rho_2^1$ with $c_1 = c_2$, referring to the previous case, we encounter a contradiction.

$$
\Box
$$

Now, we are going to prove [Theorem 1.8.](#page-2-3)

Proof. Let $|\mathscr{A}_{H_1 \cap H_2}| > 2$. Recall $S = \mathbb{K}[x_1, x_2, x_3]$ and $\exp(\mathscr{A}) = (1, d_2, d_3)$. We may assume that $S' = \mathbb{K}[x_1, x_3]$. Since $\mathscr{A}_1^H = \mathscr{A}_2^H = \mathscr{A}^H = \mathscr{C}$, we may let the Ziegler restriction of $\mathscr{A}, \mathscr{A}_1$ and \mathscr{A}_2 on H be $(\mathscr{C}, m_0), (\mathscr{C}, m_1)$ and (\mathscr{C}, m_2) , respectively. Note that $H_1 \cap H = H_2 \cap H$. Thus $(\mathscr{C}, m_1) = (\mathscr{C}, m_2).$

Since $\mathscr A$ is free, by [Theorem 2.7,](#page-4-2) we may get that $(\mathscr C, m_0)$ is free with $\exp(\mathscr C, m_0)$ = (d_2, d_3) . Note that we do not differentiate between d_2 and d_3 . Since $|m_0| = |m_1| + 1$ and $m_0(L) \geq m_1(L)$ for any $L \in \mathscr{C}$, by [Lemma 2.8,](#page-4-3) we may assume that (\mathscr{C}, m_1) is free with $\exp(\mathscr{C}, m_1) = (d_2 - 1, d_3)$. Moreover, there exist a basis φ_1, φ_2 for $D(\mathscr{C}, m_1)$ such that $x_1\varphi_1, \varphi_2$ forms a basis for $D(\mathscr{C}, m_0)$. Let us look at the following exact sequences:

$$
0 \longrightarrow D_H(\mathscr{A}) \xrightarrow{\cdot x_2} D_H(\mathscr{A}) \xrightarrow{\pi} D(\mathscr{C}, m_0),
$$

$$
0 \longrightarrow D_H(\mathscr{A}_i) \xrightarrow{\cdot x_2} D_H(\mathscr{A}_i) \xrightarrow{\pi_i} D(\mathscr{C}, m_1),
$$

where $i = 1, 2$.

By [Theorem 2.7,](#page-4-2) there exist a basis θ_1 , θ_2 for $D_H(\mathscr{A})$ such that $\pi(\theta_1) = x_1\varphi_1$ and $\pi(\theta_2) = \varphi_2$. Using [Proposition 4.1,](#page-16-3) we may assume that $\theta_{3,i}$ is a level element for $D(\mathscr{A}_i)$ such that

$$
x_1 \theta_{3,1} = f_1 \theta_1 + f_2 \theta_2, f_1, f_2 \in \mathbb{K}[x_2, x_3].
$$
\n(4.6)

$$
(x_1 - x_2)\theta_{3,2} = g_1\theta_1 + g_2\theta_2, g_1, g_2 \in \mathbb{K}[x_2, x_3].
$$
\n(4.7)

Thus

$$
\pi(x_1 \theta_{3,1}) = \overline{f_1} x_1 \varphi_1 + \overline{f_2} \varphi_2 = x_1 \pi_1(\theta_{3,1})
$$

$$
\pi((x_1 - x_2)\theta_{3,2}) = \overline{g_1} x_1 \varphi + \overline{g_2} \varphi_2 = x_1 \pi_2(\theta_{3,2})
$$

Note that $\pi_i(\theta_{3,i}) \in D(\mathscr{C}, m_1) = S'\varphi_1 + S'\varphi_2$. Thus $\overline{f_2}, \overline{g_2} \in x_1S'$. Recall that $f_j, g_j \in \mathbb{K}[x_2, x_3]$, where $j = 1, 2$, thus $\overline{f_2} = \overline{g_2} = 0$, i.e., $f_2, g_2 \in x_2 \mathbb{K}[x_2, x_3]$.

By the definition and $\theta_{3,1} \in D_H(\underline{\mathscr{A}}_1)$, we have $\pi_1(\theta_{3,1}) = \rho_1^2(\theta_{3,1})$. By [Lemma 3.3,](#page-6-2) we have $\rho_1^2(\theta_{3,1}) \neq 0$. This implies that $f_1 \neq 0$. Since $f_1 \in \mathbb{K}[x_2, x_3]$, we may get that $f_1 \in$ $\mathbb{K}[x_2, x_3] \setminus x_2\mathbb{K}[x_2, x_3]$. Similarly, we have $g_1 \in \mathbb{K}[x_2, x_3] \setminus x_2\mathbb{K}[x_2, x_3]$. Thus we may assume that

$$
f_1 = x_2 f_1' + k x_3^r, f_2 = x_2 f_2'.
$$

$$
g_1 = x_2 g_1' + k' x_3^{r'}, g_2 = x_2 g_2'.
$$

where $f'_i, g'_i \in \mathbb{K}[x_2, x_3], r, r' \in \mathbb{Z}^+$ and $k, k' \in \mathbb{K}^*$. Note that we assumed $|\mathscr{A}_{H_1 \cap H_2}| > 2$. By [Lemma 4.2,](#page-16-5) $c_1 = c_2$ if and only if $D(\mathscr{A}_1) = D(\mathscr{A}) + \ker \rho_1^2$. By [Lemma 4.2,](#page-16-5) if $c_1 < c_2$, then $D(\mathscr{A}_1) \subsetneq D(\mathscr{A}) + \ker \rho_1^2$ and $D(\mathscr{A}_2) = D(\mathscr{A}) + \ker \rho_2^1$. In this case, if $|DS(\mathscr{A}_{1,2})| = \ell + 1$, by [Proposition 3.7](#page-7-4) [\(1\),](#page-7-5) it is evident that $c_1 < c_2 = d_2$ or d_3 . By [Theorem 1.4,](#page-1-0) we have $\max\{d_2, d_3\} \leq c_1$, which is a contradiction. Thus, if $c_1 < c_2$ we have $|DS(\mathscr{A}_{1,2})| = \ell + 2$.

As a conclusion, $|\mathscr{A}_{H_1 \cap H_2}| > 2$ if and only if either $D(\mathscr{A}_1) = D(\mathscr{A}) + \ker \rho_1^2$ and $c_1 = c_2$, or $|DS(\mathscr{A}_{1,2})| = \ell + 2$ and $c_1 < c_2$.

By [Proposition 3.7,](#page-7-4) we have $|DS(\mathscr{A}_{1,2})| \leq \ell+2$ when $\ell=3$. Combining with [Theorem 3.8,](#page-9-0) we successfully conclude the proof of the theorem. The moreover part in [Theorem 1.8](#page-2-3) [\(2.1\)](#page-3-2) is from Lemma 4.2 [\(1\).](#page-17-1) \Box

REMARK 4.3. As demonstrated in [Theorem 1.8](#page-2-3) [\(2.1\),](#page-3-2) it is evident that $\mathscr{A}_{1,2}$ is not necessarily SPOG.

Now we would like to provide some examples to apply [Theorem 1.8.](#page-2-3)

EXAMPLE 4.4. Let

$$
Q(\mathscr{A}) = x_1 x_2 x_3 (x_1 - x_2)(x_1 - x_3)(x_2 - x_3)(x_1 + x_2 - x_3).
$$

Then, $\mathscr A$ is free with $\exp(\mathscr A) = (1,3,3)$. See [Figure 2.](#page-19-0)

By [Theorem 1.4,](#page-1-0) it follows that \mathscr{A}_2 and \mathscr{A}_5 both are plus-one generated with exponents $(1,3,3)$ and level 3. By [Theorem 1.8,](#page-2-3) we have $\mathscr{A}_{2,5}$ is plus-one generated with $\text{POexp}(\mathscr{A}_{2,5})$ = (1, 2, 3) and level 3.

Example 4.5. Let

$$
Q(\mathscr{A}) = x_1 x_2 x_3 (x_1 + x_2)(x_1 - x_2)(x_1 + x_3)(x_1 - x_3)(x_2 + x_3)
$$

$$
(x_1 + x_2 + x_3)(x_1 + 2x_2 + x_3)(x_1 - 2x_2 + x_3).
$$

Then, $\mathscr A$ is free with $\exp(\mathscr A) = (1, 5, 5)$. See [Figure 3.](#page-19-1)

By [Theorem 1.4,](#page-1-0) it is easy to see that \mathscr{A}_1 , \mathscr{A}_6 and \mathscr{A}_{10} are free with exponent $(1,4,5)$, \mathscr{A}_3 and \mathscr{A}_4 are SPOG with $\text{POexp}(\mathscr{A}_3) = \text{POexp}(\mathscr{A}_4) = (1, 5, 5)$ and level 6, and the remaining \mathscr{A}_i are all SPOG with $\text{POexp}(\mathscr{A}_i) = (1, 5, 5)$ and level 5. By [Theorem 1.8,](#page-2-3) this implies the following results:

(1) Note that \mathscr{A}_2 and \mathscr{A}_{11} are not free, and $|\mathscr{A}_{H_2 \cap H_{11}}| = 2$, we may get that $DS(\mathscr{A}_{2,11}) =$ $(1, 5, 5, 5, 5)$, and the minimal free resolution of $D(\mathcal{A}_{2,11})$ has the following forms:

$$
0 \to S[-6]^2 \to S[-5]^4 \oplus S[-1] \to D(\mathscr{A}_{2,11}) \to 0.
$$

(2) Note that \mathscr{A}_3 and \mathscr{A}_4 are SPOG with level 6, and $|\mathscr{A}_{H_3 \cap H_4}| > 2$, we may get that $D(\mathscr{A}_{3,4})$ is not SPOG, $DS(\mathscr{A}_{3,4}) = (1, 5, 5, 5)$, and the minimal free resolution of $D(\mathscr{A}_{3,4})$ has the following forms:

$$
0 \to S[-7] \to S[-5]^3 \oplus S[-1] \to D(\mathscr{A}_{3,4}) \to 0.
$$

- (3) Note that \mathscr{A}_5 and \mathscr{A}_7 are SPOG with level 5, and $|\mathscr{A}_{H_5 \cap H_7}| > 2$, we may get that $\mathscr{A}_{5,7}$ is SPOG with $\text{POexp}(\mathcal{A}_{5.7}) = (1, 4, 5)$ and level 5.
- (4) Note that \mathscr{A}_3 is SPOG with level 6 and \mathscr{A}_5 is SPOG with level 5, and $|\mathscr{A}_{H_3 \cap H_5}| > 2$, we may get that $DS(\mathscr{A}_{3,5}) = (1, 5, 5, 5, 5)$, and the minimal free resolution of $D(\mathscr{A}_{3,5})$ has the following forms:

$$
0 \to S[-6]^2 \to S[-5]^4 \oplus S[-1] \to D(\mathscr{A}_{3,5}) \to 0.
$$

[Theorem 1.4](#page-1-0) by Abe shows that NT-free-1 arrangements that are non-free are SPOG. It is known that the converse does not hold in general [\[6,](#page-21-9) [13\]](#page-22-6). Using our result, we give such an example. First, recall the following result:

PROPOSITION 4.6 (Theorem 6.2 of [\[1\]](#page-21-2)). Let $\mathscr C$ be SPOG with a minimal set of homogeneous generators $\{\gamma_1,\ldots,\gamma_\ell,\varphi\}$ for $D(\mathscr{C})$, where φ is a level element with a level coefficient α . Suppose there exists a free addition $\mathscr{B} = \mathscr{C} \cup \{H\}$ of \mathscr{C} . If $\deg \varphi > \deg \gamma_i$ for any $i \in \{1, 2, ..., \ell\}$, then $H = \ker \alpha$.

The following is a SPOG arrangement that does not admit a free addition.

Example 4.7. Let

$$
Q(\mathscr{A}) = x_1 x_2 x_3 (x_1 - x_2)(x_1 + x_2)(x_1 + 2x_2)(2x_1 + x_2)(3x_1 + x_2)(x_2 + x_3)(3x_1 + x_2 + x_3),
$$

and let $H_1 = \{x_1 = 0\}$ and $H_2 = \{x_2 = 0\}$. By computer, $\mathscr A$ is free with $\exp(\mathscr A) = (1, 3, 6)$. We may assume that $\{\theta_1, \theta_2, \theta_3\}$ is a basis for $D(\mathscr{A})$. By [Theorem 1.8,](#page-2-3) $\mathscr{A}_{1,2}$ is SPOG with $PO \exp(\mathscr{A}_{1,2}) = (d_1 = 1, d_2 = 3, c_1 - 1 = 5)$ with level $d_3 = 6$. By [Proposition 3.7,](#page-7-4) we have a minimal generator set for $D(\mathscr{A}_{1,2})$ as $\{\theta_1,\theta_2,\theta_3,\varphi\}$, where $\alpha_2\varphi$ is a level element for $D(\mathscr{A}_1)$. Note that θ_3 is the level element of $\mathscr{A}_{1,2}$ with the level coefficient $\alpha = x_2 + x_3$. Since ker $\alpha \in \mathscr{A}_{1,2}$, by [Proposition 4.6,](#page-20-1) it follows that $\mathcal{A}_{1,2}$ does not admit free addition.

EXAMPLE 4.8. We give two arrangements B and C such that $L(\mathscr{B}) \cong L(\mathscr{C})$ but $DS(\mathscr{B}) \neq$ $DS(\mathscr{C})$. Their defining polynomials are

 $Q_{\mathscr{B}} = x_1x_2x_3(x_2 - 3x_3)(x_2 + 3x_3)(x_1 - x_3)(x_1 + x_3)(x_1 + x_2)(x_1 + x_2 - 3x_3)(x_1 + x_2 + 3x_3)$ $Q_{\mathscr{C}} = x_1 x_2 x_3 (x_2 - 3x_3)(x_2 + 3x_3)(x_1 - x_3)(x_1 + x_3)(x_1 + x_2)(x_1 + x_2 - 4x_3)(x_1 + x_2 + 3x_3).$

Their derivation degree sequences are

$$
DS(\mathscr{B}) = (1, 5, 6, 6)
$$

$$
DS(\mathscr{C}) = (1, 6, 6, 6, 6, 6).
$$

This example shows the intricate nature of the derivation degree sequence that depends not only on the combinatorics but also on the geometry of the arrangement.
