Robust bilinear factor analysis based on the matrix-variate t distribution

Abstract

Factor Analysis based on multivariate t distribution (tFA) is a useful robust tool for extracting common factors on heavy-tailed or contaminated data. However, tFA is only applicable to vector data. When tFA is applied to matrix data, it is common to first vectorize the matrix observations. This introduces two challenges for tFA: (i) the inherent matrix structure of the data is broken, and (ii) robustness may be lost, as vectorized matrix data typically results in a high data dimension, which could easily lead to the breakdown of tFA. To address these issues, starting from the intrinsic matrix structure of matrix data, a novel robust factor analysis model, namely bilinear factor analysis built on the matrixvariate t distribution (tBFA), is proposed in this paper. The novelty is that it is capable to simultaneously extract common factors for both row and column variables of interest on heavy-tailed or contaminated matrix data. Two efficient algorithms for maximum likelihood estimation of tBFA are developed. Closed-form expression for the Fisher information matrix to calculate the accuracy of parameter estimates are derived. Empirical studies are conducted to understand the proposed *t*BFA model and compare with related competitors. The results demonstrate the superiority and practicality of tBFA. Importantly, tBFA exhibits a significantly higher breakdown point than tFA, making it more suitable for matrix data.

Keywords: Factor analysis, Matrix data, Robustness, matrix-variate distribution, Expectation Maximization.

1 Introduction

Factor Analysis (FA) is a powerful multivariate analysis method that identifies latent common characteristics (or factors) within a given set of variables, and has been widely used in diverse scientific areas including but not limited to dimension reduction, time series prediction, psychology, social sciences, and economics. However, FA is based on the Gaussian assumption and hence is vulnerable to outliers. To overcome this problem, the FA model modeling with multivariate t (tFA) is suggested and has been proven to be effective for robust estimation (Zhang et al., 2014; McLachlan et al., 2007). However, FA and tFA are only applicable to vector-valued

or vector data, where observations are vectors. Nowadays, matrix-valued data or matrix data, where observations are matrices, has become increasingly common in our real life. For instance,

Data 1. In water research (Ouyang, 2005), observations consist of values of variables such as water temperature, water PH value, oxygen concentration, nitrogen concentration, etc., measured at 22 monitoring stations. The data can naturally be represented as a matrix with columns being 24 variables and rows being 22 different stations. The sample size of this data is 3.

When FA and tFA are applied to matrix data such as Data 1, it is common practice to first vectorize the matrix observations. This leads to two problems: (i) vectorization destroys the natural matrix structure, merging row and column variables together, making it incapable of capturing common factors among row variables and column variables of interest. Take Data 1as an example, FA and tFA can not extract the interesting common 'station' factors and 'water quality' factors; and (ii) vectorization often results in a very high dimension, making FA and tFAeasily trapped into the curse of dimensionality. For example, the dimension of the vectorized Data 1, d = 528, is much greater than the sample size of N = 3. This is the case of the so-called d > N problem, on which FA and tFA would fail due to the numerical issues (Zhao et al., 2008). tFA suffers one more problem, namely (iii) robustness may be lost, as the breakdown point of tFA is upper bounded by the inverse of the vectorized data dimension (Dümbgen and Tyler, 2010) and the higher the dimension, the lower the breakdown point that measures the robustness.

To address problem (i) and (ii), several matrix-based methods have emerged as promising alternatives to vector-based ones, including probabilistic and non-probabilistic methods. An example for non-probabilistic methods is the matrix factor models (MFM) proposed in Wang et al. (2019). Probabilistic methods include matrix-variate principal component analysis (PCA) (Xie et al., 2008), factored PCA (FPCA), and bilinear probabilistic PCA (BPPCA) (Zhao et al., 2012). Based on BPPCA, Shang et al. (2023) present a bilinear factor analysis (BFA) model. These methods share a common characteristic: they make use of bilinear transformations with number of parameters typically significantly smaller than those in linear transformations used by vector-based models. As a result, they effectively mitigate high-dimensional problems.

Despite the advantages of these matrix-based probabilistic methods, they all rely on the assumption of normal distribution and are thereby susceptible to outliers. Recently, in order to improve the robustness of FPCA, Ma et al. (2023) propose a robust extension of FPCA (RFPCA) using the matrix-variate t (Mt) distribution (Gupta et al., 2013). Inspired by RFPCA, in this

paper we propose a new robust extension of BFA for matrix data, which is built on the Mt distribution, to simultaneously solve the problems (i), (ii) and (iii) suffered by tFA. Throughout this paper, the proposed robust BFA model is referred to as tBFA. The main contributions of this paper are threefold.

(i) Due to the utilization of a bilinear transformation, the proposed tBFA alleviates greatly the high-dimensional problems and is capable to simultaneously extract common factors for both row and column variables of interest even in the presence of matrix outliers. Moreover, the proposed tBFA is generally compared favorably with the related methods.

(ii) Two efficient algorithms for ML estimation of tBFA model parameters are developed and analytical expression for the Fisher information matrix to calculate the accuracy of parameter estimates are also derived. The factor scores in tBFA are represented as matrices, instead of vectors in tFA, visual analysis to the matrix factor scores are provided.

(iii) More importantly, while a rigorous theoretical result is not yet available, our empirical results show that tBFA has a significantly higher breakdown point than its vector-based counterpart tFA, which makes tBFA applicable to matrix data.

The rest of this paper is organized as follows. In Sec. 2, we briefly review some related works. In Sec. 3.2, we propose our tBFA, and develop its maximum likelihood inference in Sec. 4. In Sec. 5, we conduct a number of experiments on simulated and real-world data. In Sec. 6, we close the paper with some conclusions and discussions.

2 Related works

In this section, we briefly review the multivariate-t factor analysis (tFA) (Zhang et al., 2014; McLachlan et al., 2007) and bilinear factor analysis (BFA) (Shang et al., 2023) models. The following notations are used throughout this paper. I and **0** represent identity and zero matrices of suitable dimensions, respectively. The transpose of vector \mathbf{x} or matrix \mathbf{X} is denoted by \mathbf{x}' or \mathbf{X}' , the matrix trace by $tr(\cdot)$ and the Kronecker product by \otimes . The half-vectorization vech(\mathbf{X}) is the vector containing unique sub-diagonal elements of matrix \mathbf{X} .

2.1 Multivariate-t factor analysis (tFA)

If a *d*-dimensional random vector \mathbf{x} follows the multivariate *t* distribution with center $\boldsymbol{\mu} \in \mathbb{R}^d$, covariance matrix $\boldsymbol{\Sigma} \in \mathbb{R}^{d \times d}$ and degrees of freedom $\nu > 0$, denoted by $t_d(\boldsymbol{\mu}, \boldsymbol{\Sigma}, \nu)$, the probability density function (p.d.f.) of \mathbf{x} is

$$p(\mathbf{x}) = \frac{|\mathbf{\Sigma}|^{-\frac{1}{2}} \Gamma(\frac{\nu+d}{2})}{(\pi\nu)^{\frac{d}{2}} \Gamma(\frac{\nu}{2})} \left(1 + \frac{\delta_{\mathbf{x}}(\boldsymbol{\theta})}{\nu}\right)^{-\frac{\nu+d}{2}},\tag{1}$$

where $\delta_{\mathbf{x}}(\boldsymbol{\theta}) = (\mathbf{x} - \boldsymbol{\mu})' \boldsymbol{\Sigma}^{-1}(\mathbf{x} - \boldsymbol{\mu})$ is the squared Mahalanobis distance between \mathbf{x} and $\boldsymbol{\mu}$, and ν can tune robustness by adaptively controlling the heaviness of tails (kurtosis). The mean $\boldsymbol{\mu}$ and the covariance matrix $\boldsymbol{\Sigma}\nu/(\nu-2)$ exist when $\nu > 1$ and $\nu > 2$, respectively (Liu and Rubin, 1995).

The multivariate-*t* distribution can be described as a hierarchical representation, as shown in (2) (Liu and Rubin, 1995). Specifically, we introduce a latent variable τ following the Gamma distribution $\text{Gam}(\nu/2,\nu/2)$. Given τ , the conditional distribution of \mathbf{x} is a multivariate normal distribution $\mathcal{N}_d(\boldsymbol{\mu}, \boldsymbol{\Sigma}/\tau)$.

$$\mathbf{x}|\tau \sim \mathcal{N}_d(\boldsymbol{\mu}, \boldsymbol{\Sigma}/\tau), \ \tau \sim \mathcal{G}(\nu/2, \nu/2).$$

Suppose the *d*-dimensional data vector \mathbf{x} follows a *q*-factor multivariate-*t* factor analysis (*t*FA) model. Based on the hierarchical representation in (2), the latent variable model for *t*FA can be expressed as

$$\begin{cases} \mathbf{x} = \mathbf{A}\mathbf{z} + \boldsymbol{\mu} + \boldsymbol{\epsilon}, & \text{with } \tau \sim \mathcal{G}(\nu/2, \nu/2), \\ \mathbf{z} | \tau \sim \mathcal{N}_q(\mathbf{0}, \mathbf{I}/\tau), & \boldsymbol{\epsilon} | \tau \sim \mathcal{N}_d(\mathbf{0}, \boldsymbol{\Psi}), \end{cases}$$

where $\mathbf{z} \in \mathbb{R}^{q}$ is the latent factor vector, $\mathbf{A} \in \mathbb{R}^{d \times q}$ is the factor loading matrix, $\boldsymbol{\mu} \in \mathbb{R}^{d}$ is the mean vector, $\boldsymbol{\Psi} = \operatorname{diag}(\psi_{1}, \psi_{2}, \dots, \psi_{d})$ is a positive diagonal matrix. Assuming $\mathbf{H} \in \mathbb{R}^{q \times q}$ is an orthogonal matrix, it is easy to see that model (3) remains invariant if we replace \mathbf{A} by $\mathbf{A}\mathbf{H}$. Therefore, the parameter \mathbf{A} can only be determined up to an orthogonal rotation, and the number of free parameters in *t*FA model is $\mathcal{D} = d(q+2) - q(q-1)/2 + 1$. In addition, to avoid over-parameterization, the maximum number of factors q should satisfy the inequality $q_{\max} \leq d + (1 - \sqrt{1 + 8d})/2$ (Zhao and Shi, 2014).

2.2 Bilinear factor analysis (BFA)

The latent variable model of BFA for matrix data introduced in Shang et al. (2023) is defined as

$$\begin{cases} \mathbf{X} = \mathbf{CZR}' + \mathbf{W} + \mathbf{C}\boldsymbol{\epsilon}_r + \boldsymbol{\epsilon}_c \mathbf{R}' + \boldsymbol{\epsilon}, \\ \mathbf{Z} \sim \mathcal{N}_{q_c,q_r}(\mathbf{0}, \mathbf{I}, \mathbf{I}), \quad \boldsymbol{\epsilon}_r \sim \mathcal{N}_{q_c,d_r}(\mathbf{0}, \mathbf{I}, \boldsymbol{\Psi}_r), \\ \boldsymbol{\epsilon}_c \sim \mathcal{N}_{d_c,q_r}(\mathbf{0}, \boldsymbol{\Psi}_c, \mathbf{I}), \quad \boldsymbol{\epsilon} \sim \mathcal{N}_{d_c,d_r}(\mathbf{0}, \boldsymbol{\Psi}_c, \boldsymbol{\Psi}_r), \end{cases}$$

where \mathcal{N}_{q_c,q_r} denotes the $q_c \times q_r$ -dimensional matrix-variate normal distribution. $\mathbf{W} \in \mathbb{R}^{d_c \times d_r}$ is the mean matrix, and $\mathbf{C} \in \mathbb{R}^{d_c \times q_c}$ and $\mathbf{R} \in \mathbb{R}^{d_r \times q_r}$ are the column and row factor loading matrices, respectively. $\mathbf{Z} \in \mathbb{R}^{q_c \times q_r}$ is the latent common factor matrix, and $\boldsymbol{\epsilon}_c \in \mathbb{R}^{d_c \times q_r}$, $\boldsymbol{\epsilon}_r \in \mathbb{R}^{q_c \times d_r}$, and $\boldsymbol{\epsilon} \in \mathbb{R}^{d_c \times d_r}$ represent the column, row, and common error terms, respectively. The positive diagonal matrices $\Psi_c = \text{diag}(\psi_{c,1}, \psi_{c,2}, \dots, \psi_{c,d_c})$ and $\Psi_r = \text{diag}(\psi_{r,1}, \psi_{r,2}, \dots, \psi_{r,d_r})$. It is assumed that $\mathbf{Z}, \boldsymbol{\epsilon}_c, \boldsymbol{\epsilon}_r$, and $\boldsymbol{\epsilon}$ are independent of each other. Notably, BFA model in (4) will degenerate to the classic FA when $d_c = 1$ or $d_r = 1$.

Like tFA, the factor loading matrices **C** and **R** in BFA can only be uniquely determined up to orthogonal rotation matrices. Consequently, the numbers of free parameters in **C** and **R** are $d_c q_c - q_c (q_c - 1)/2$ and $d_r q_r - q_r (q_r - 1)/2$, respectively, and the total number of free parameters in BFA is $\mathcal{D} = d_c (q_c + 1) - q_c (q_c - 1)/2 + d_r (q_r + 1) - q_r (q_r - 1)/2 + d_c d_r$. To avoid over-parameterization, the maximum numbers of column and row factors should satisfy the inequalities $q_{c,max} \leq d_c + (1 - \sqrt{1 + 8d_c})/2$ and $q_{r,max} \leq d_r + (1 - \sqrt{1 + 8d_r})/2$, respectively.

3 Robust BFA based on a matrix-variate t distribution (tBFA)

In this section, based on the Mt distribution (Gupta et al., 2013), we propose a novel robust BFA model (tBFA). In Sec. 3.1, we briefly review the Mt distribution, based on which, we propose our tBFA in Sec. 3.2. We discuss the model identifiability issue associated with tBFA in Sec. 3.3.

3.1 Matrix-variate t (Mt) distribution

Definition 1. Let $\mathbf{X} \in \mathbb{R}^{d_c \times d_r}$ be a random matrix. It is said that \mathbf{X} follows a Mt distribution with the mean matrix $\mathbf{W} \in \mathbb{R}^{d_c \times d_r}$, column and row covariance matrices $\mathbf{\Sigma}_c \in \mathbb{R}^{d_c \times d_c}$ and $\mathbf{\Sigma}_r \in \mathbb{R}^{d_r \times d_r}$, and degrees of freedom ν , denoted by $\mathbf{X} \sim Mt_{d_c,d_r}(\mathbf{W}, \mathbf{\Sigma}_c, \mathbf{\Sigma}_r, \nu)$, if $vec(\mathbf{X}) \sim t_{d_c d_r}(vec(\mathbf{W}), \mathbf{\Sigma}_r \otimes \mathbf{\Sigma}_c, \nu)$. The p.d.f. of \mathbf{X} is given by

$$p(\mathbf{X}) = \frac{|\mathbf{\Sigma}_{c}|^{-\frac{d_{r}}{2}} |\mathbf{\Sigma}_{r}|^{-\frac{d_{c}}{2}} \Gamma(\frac{\nu+d_{c}d_{r}}{2})}{(\pi\nu)^{\frac{d_{c}d_{r}}{2}} \Gamma(\frac{\nu}{2})} \left(1 + \frac{1}{\nu} tr\{\mathbf{\Sigma}_{c}^{-1}(\mathbf{X} - \mathbf{W})\mathbf{\Sigma}_{r}^{-1}(\mathbf{X} - \mathbf{W})'\}\right)^{-\frac{\nu+d_{c}d_{r}}{2}}.$$

X can be expressed as a latent variable model. Introduce a latent weight variable τ , which follows a Gamma distribution $\operatorname{Gam}(\nu/2,\nu/2)$. Given τ , **X** follows the matrix-normal distribution $\mathcal{N}_{d_c,d_r}(\mathbf{W}, \mathbf{\Sigma}_c/\tau, \mathbf{\Sigma}_r)$, that is,

$$\mathbf{X}|\tau \sim \mathcal{N}_{d_c,d_r}(\mathbf{W}, \boldsymbol{\Sigma}_c/\tau, \boldsymbol{\Sigma}_r), \ \tau \sim \operatorname{Gam}(\nu/2, \nu/2).$$

According to Definition 1, the Mt distribution is essentially a multivariate t distribution with a separable covariance structure $\Sigma = \Sigma_r \otimes \Sigma_c$. Consequently, the Mt distribution naturally inherits key characteristics of the multivariate t distribution. Specifically, the parameter ν serves to adjust robustness, and the expected value of the latent variable τ can be used for outlier detection. For detailed explanations and proofs, please refer to Ma et al. (2023).

3.2 Model formulation

Based on the Mt distribution in Definition 1, we propose our tBFA. Its latent variable model is defined as follows.

$$\begin{cases} \mathbf{X} = \mathbf{C}\mathbf{Z}\mathbf{R}' + \mathbf{W} + \mathbf{C}\boldsymbol{\epsilon}_r + \boldsymbol{\epsilon}_c \mathbf{R}' + \boldsymbol{\epsilon}, & \text{with} \\ \mathbf{Z} | \tau \sim \mathcal{N}_{q_c,q_r}(\mathbf{0}, \mathbf{I}/\tau, \mathbf{I}), & \boldsymbol{\epsilon}_r | \tau \sim \mathcal{N}_{q_c,d_r}(\mathbf{0}, \mathbf{I}/\tau, \boldsymbol{\Psi}_r), \\ \boldsymbol{\epsilon}_c | \tau \sim \mathcal{N}_{d_c,q_r}(\mathbf{0}, \boldsymbol{\Psi}_c/\tau, \mathbf{I}), & \boldsymbol{\epsilon} | \tau \sim \mathcal{N}_{d_c,d_r}(\mathbf{0}, \boldsymbol{\Psi}_c/\tau, \boldsymbol{\Psi}_r), \\ \tau \sim \mathcal{G}(\nu/2, \nu/2), \end{cases}$$

where $\mathbf{W} \in \mathbb{R}^{d_c \times d_r}$ is the mean matrix, and $\mathbf{C} \in \mathbb{R}^{d_c \times q_c}$ and $\mathbf{R} \in \mathbb{R}^{d_r \times q_r}$ are the column and row factor loading matrices, respectively. $\mathbf{Z} \in \mathbb{R}^{q_c \times q_r}$ represents the latent factor matrix, $\boldsymbol{\epsilon}_c \in \mathbb{R}^{d_c \times q_r}$, $\boldsymbol{\epsilon}_r \in \mathbb{R}^{q_c \times d_r}$, and $\boldsymbol{\epsilon} \in \mathbb{R}^{d_c \times d_r}$ are the column, row, and common error terms, respectively. Given τ , it is assumed that \mathbf{Z} , $\boldsymbol{\epsilon}_c$, $\boldsymbol{\epsilon}_r$, and $\boldsymbol{\epsilon}$ are independent of each other. The positive matrices $\Psi_c = \operatorname{diag}(\psi_{c,1}, \psi_{c,2}, \dots, \psi_{c,d_c})$ and $\Psi_r = \operatorname{diag}(\psi_{r,1}, \psi_{r,2}, \dots, \psi_{r,d_r})$.

Similar as BFA in Sec. 2.2, the numbers of free parameters for **C** and **R** are given by $d_cq_c - q_c(q_c-1)/2$ and $d_rq_r - q_r(q_r-1)/2$, respectively. In summary, the total number of free parameters for the *t*BFA model is $\mathcal{D} = d_c(q_c+1) - q_c(q_c-1)/2 + d_r(q_r+1) - q_r(q_r-1)/2 + d_cd_r + 1$. In addition, the maximum numbers of column factors $q_{c,max}, q_{r,max}$ should satisfy $q_{c,max} \leq d_c + (1 - \sqrt{1 + 8d_c})/2$, and $q_{r,max} \leq d_r + (1 - \sqrt{1 + 8d_r})/2$.

From (7), we can obtain

Consequently, we have

$$\mathbf{X}|\tau \sim \mathcal{N}_{d_c,d_r}(\mathbf{W}, \boldsymbol{\Sigma}_c/\tau, \boldsymbol{\Sigma}_r), \quad \mathbf{X} \sim Mt_{d_c,d_r}(\mathbf{W}, \boldsymbol{\Sigma}_c, \boldsymbol{\Sigma}_r, \nu),$$

where

$$\Sigma_c = \mathbf{C}\mathbf{C}' + \Psi_c, \quad \Sigma_r = \mathbf{R}\mathbf{R}' + \Psi_r. \tag{9}$$

To better understand *t*BFA model, following Zhao et al. (2012); Shang et al. (2023), we introduce two latent matrices, \mathbf{Y}^r and $\mathbf{Y}^r_{\boldsymbol{\epsilon}}$, and rewrite the model in (7) as (10). Model (10) can be viewed as a two-stage representation of the model (7). From a projection perspective, the

data matrix **X** is first projected onto \mathbf{Y}^r along the column direction, followed by the projection of \mathbf{Y}^r and the residual $\mathbf{Y}^r_{\boldsymbol{\epsilon}}$ onto the latent factors **Z** and error terms $\boldsymbol{\epsilon}_c$ along the row direction.

The following probability distributions can be obtained from tBFA model (7):

where Σ_c and Σ_r are given in (9) and

3.3 Model identifiability

Similar as BPPCA and BFA (Zhao et al., 2012; Shang et al., 2023), there are two parameter indeterminacies in tBFA. One indeterminacy arises from the rotational invariance in FA models, and the other results from the separable covariance structure of matrix-variate distributions.

(i) The factor loading matrices \mathbf{C} (reps. \mathbf{R}) in tBFA can be determined uniquely up to an orthogonal rotation. For example, let \mathbf{P}_c and \mathbf{P}_r be arbitrary orthogonal matrices of suitable dimensions. Model (7) remains invariant if we replace (\mathbf{C}, \mathbf{Z}) by ($\mathbf{CP}_c, \mathbf{P}'_c \mathbf{Z}$) and/or replace (\mathbf{Z}, \mathbf{R}) by ($\mathbf{ZP}_r, \mathbf{RP}_r$).

(ii) The parameters (\mathbf{C}, Ψ_c) and (\mathbf{R}, Ψ_r) can be uniquely determined up to a constant. It is easy to verify that for any a > 0, model (7) is invariant if we substitute $(\sqrt{a} \cdot \mathbf{C}, a \cdot \Psi_c)$ and $(\mathbf{R}/\sqrt{a}, \Psi_r/a)$ into (7).

To ensure the uniqueness of parameters when investigating the accuracy of estimators in Sec. 5.2.3, for (i), following Fosdick and Hoff (2014), we constrain \mathbf{C} and \mathbf{R} to lower triangular

matrices, i.e., $c_{11} = 0$, $r_{11} = 0$. For (ii), it is common practice to constrain the first element of Ψ_c to be 1, i.e., $\psi_{c,1} = 1$ (Srivastava et al., 2008).

4 Maximum likelihood inference of *t*BFA

4.1 Maximum likelihood (ML) estimation of tBFA

To obtain the ML estimates of the parameters $\boldsymbol{\theta} = \{\mathbf{W}, \mathbf{C}, \boldsymbol{\Psi}_c, \mathbf{R}, \boldsymbol{\Psi}_r, \nu\}$ in *t*BFA model, we develop two algorithms in this section. Given a set of observations $\mathcal{X} = \{\mathbf{X}_n\}_{n=1}^N$, the log-likelihood function for the observed data (ignoring constant terms) is

$$\mathcal{L}(\boldsymbol{\theta}|\mathcal{X}) = \sum_{n=1}^{N} \ln \left\{ p(\mathbf{X}_n) \right\} = -\frac{1}{2} \sum_{n=1}^{N} \left\{ (\nu + d_c d_r) \ln \left(\nu + \delta_{\mathbf{X}_n}(\boldsymbol{\theta}) \right) + d_r \ln |\mathbf{\Sigma}_c| + d_c \ln |\mathbf{\Sigma}_r| \right\} + N \left\{ \ln \Gamma(\frac{\nu + d_c d_r}{2}) - \ln \Gamma(\frac{\nu}{2}) + \frac{\nu}{2} \ln \nu \right\}.$$
(18)

where $\delta_{\mathbf{X}_n}(\boldsymbol{\theta})$ is defined in (17).

We will use EM-type algorithms to maximize \mathcal{L} in (18). It is widely acknowledged that the convergence speed of the EM algorithm depends on the proportion of missing information in complete data, and the basic EM algorithm may converge very slowly (Meng and van Dyk, 1997). For practical applications, developing algorithms with fast convergence or reduced time consumption is crucial. Therefore, we propose two EM-type algorithms. The first is the Expectation Conditional Maximization Either (ECME) algorithm (Liu, 1994), which requires less missing information and is expected to converge faster. The second is the Alternating Expectation Conditional Maximization (AECM) algorithm (Meng and van Dyk, 1997), which requires more missing information but has lower per-iteration complexity.

4.1.1 The ECME algorithm

ECME algorithm consists of an E-step and four CM-steps. In each CM-step, the maximization is performed only with respect to (w.r.t.) a subset of parameters, while keeping the others fixed. The parameters $\boldsymbol{\theta}$ are partitioned into $\boldsymbol{\theta}_1 = \mathbf{W}$, $\boldsymbol{\theta}_2 = (\mathbf{C}, \boldsymbol{\Psi}_c)$, $\boldsymbol{\theta}_3 = (\mathbf{R}, \boldsymbol{\Psi}_r)$, and $\boldsymbol{\theta}_4 = \nu$.

E-step: Considering $\mathcal{T} = \{\tau_n\}_{n=1}^N$ as missing data, the log-likelihood function of the complete data is $\sum_{n=1}^N \ln \{p(\mathbf{X}_n | \tau_n)\}$

 (τ_n) , and taking its expectation w.r.t. the conditional distribution $p(\mathcal{T}|\mathcal{X}, \boldsymbol{\theta})$ yields (ignoring

constant terms):

$$Q_{1}(\boldsymbol{\theta}|\boldsymbol{\mathcal{X}}) = N \left\{ \frac{\nu}{2} \ln \frac{\nu}{2} - \ln \Gamma(\frac{\nu}{2}) - \frac{d_{r}}{2} \ln |\boldsymbol{\Sigma}_{c}| - \frac{d_{c}}{2} \ln |\boldsymbol{\Sigma}_{r}| \right\} + \sum_{n=1}^{N} \left\{ \frac{\nu}{2} (\mathbb{E}[\ln \tau_{n} | \mathbf{X}_{n}] - \mathbb{E}[\tau_{n} | \mathbf{X}_{n}]) - \mathbb{E}[\tau_{n} | \mathbf{X}_{n}] \delta_{\mathbf{X}_{n}}(\boldsymbol{\theta}) \right\},$$

where

$$\tilde{\tau}_n = \mathbb{E}[\tau_n | \mathbf{X}_n] = \frac{\nu + d_c d_r}{\nu + \delta_{\mathbf{X}_n}(\boldsymbol{\theta})}, \quad \mathbb{E}[\ln \tau_n | \mathbf{X}_n] = \psi(\frac{\nu + d_c d_r}{2}) - \ln(\frac{\nu + \delta_{\mathbf{X}_n}(\boldsymbol{\theta})}{2}), \quad (20)$$

and $\psi(x) = d \ln(\Gamma(x))/dx$ is the digamma function.

CM-step 1: Given $(\theta_2, \theta_3, \theta_4)$, maximizing Q_1 in (19) w.r.t. $\theta_1 = \mathbf{W}$ results in

CM-step 2: With $(\hat{\theta}_1, \theta_3, \theta_4)$ fixed, maximize Q_1 in (19) w.r.t. θ_2 . This leads to the simplification of Q_1 to

where $\mathbf{U}_{q'_c} = (\mathbf{u}_{c,1}, \mathbf{u}_{c,2}, \dots, \mathbf{u}_{c,q'_c}), \ \mathbf{\Lambda}_{q'_c} = \operatorname{diag}(\lambda_{c,1}, \lambda_{c,2}, \dots, \lambda_{c,q'_c}), \ \text{and} \ \mathbf{V}_c \in \mathbb{R}^{q'_c \times q_c}$ is an orthogonal matrix satisfying $\mathbf{V}_c \mathbf{V}'_c = \mathbf{I}$. The pairs $(\lambda_{c,i}, \mathbf{u}_{c,i})$'s represent eigenvalue-eigenvector pairs of $\mathbf{\tilde{S}}_c$ in (24), arranged in decreasing order, $\lambda_{c,1} \ge \lambda_{c,2} \ge \dots \ge \lambda_{c,d_c}$. The optimal q'_c is determined as follows: if $\lambda_{c,q_c} \ge 1$, then $q'_c = q_c$; otherwise, q'_c is the unique integer satisfying $\lambda_{c,q'_c} \ge 1 \ge \lambda_{c,q'_c+1}$.

Given $\tilde{\mathbf{C}}$, maximize Q_{1c} w.r.t. the parameters Ψ_c . Zhao et al. (2008) propose updating each diagonal element of Ψ_c sequentially. The advantage of this approach is that each entry has a closed-form update. Let $\Psi_{c,i} = \text{diag}(\tilde{\psi}_{c,1}, \ldots, \tilde{\psi}_{c,i-1}, \psi_{c,i}, \psi_{c,i+1}, \ldots, \psi_{c,d_c})$. By assuming that Ψ_c is positive definite, we can choose an arbitrary small number $\eta > 0$ and assume $\tilde{\psi}_{c,i} \ge \eta$. Let $\mathbf{C}^* = \Psi_c^{-1/2} \tilde{\mathbf{C}}$, and \mathbf{e}_i be the *i*-th column of the identity matrix \mathbf{I}_{d_c} ,

By (27) and (28), we know $\tilde{\psi}_{c,k} \ge \eta$, $\tilde{\omega}_k \ge -1, k = 1, \dots, i-1$. Thus, \mathbf{B}_i is invertible and $\tilde{\psi}_{c,i}$ in (28) can always be computed. A pseudocode for the update of Ψ_c is available in Zhao and Shi (2014).

CM-step 3: Given $(\tilde{\theta}_1, \tilde{\theta}_2, \theta_4)$, maximize Q_1 in (19) w.r.t. θ_3 . Q_1 can be simplified to

Given Ψ_r , maximize Q_{1r} w.r.t. **R**, yielding

where $\mathbf{U}_{q'_r}$, $\mathbf{\Lambda}_{q'_r}$, and \mathbf{V}_r are defined similarly to the counterparts of CM-step 2, but computed using \mathbf{S}_r from (31).

CM-step 4: Given $(\tilde{\theta}_1, \tilde{\theta}_2, \tilde{\theta}_3)$, maximize the likelihood \mathcal{L} in (18) w.r.t. $\theta_4 = \nu$. Set the derivative of \mathcal{L} w.r.t. ν to zero, i.e., $\mathcal{L}'(\nu) = 0$, yielding the following equation:

$$\mathcal{L}'(\nu) = -\psi(\frac{\nu}{2}) + \ln\frac{\nu}{2} + 1 + \psi(\frac{\nu + d_c d_r}{2}) - \ln\left(\frac{\nu + d_c d_r}{2}\right) + \frac{1}{N} \sum_{n=1}^{N} \left[\ln\left(\frac{\nu + d_c d_r}{\nu + \tilde{\delta}_{\mathbf{X}_n}}\right) - \frac{\nu + d_c d_r}{\nu + \tilde{\delta}_{\mathbf{X}_n}}\right] \tag{33}$$

where $\tilde{\delta}_{\mathbf{X}_n} = \delta_{\mathbf{X}_n}(\tilde{\boldsymbol{\theta}}_1, \tilde{\boldsymbol{\theta}}_2, \tilde{\boldsymbol{\theta}}_3)$, and $\delta_{\mathbf{X}_n}(\boldsymbol{\theta})$ is defined in (17). Solving equation (33) gives $\tilde{\nu}$. This

is only a one-dimensional optimization problem and can be solved by the bisection method as suggested in Liu and Rubin (1995).

4.1.2 The AECM algorithm

In this subsection, we develop the AECM algorithm for tBFA, which consists of multiple cycles within a single iteration and each cycle has its own E-step and CM-step. We partition the parameters to be estimated into $\theta_1 = (\mathbf{W}, \nu)$, $\theta_2 = (\mathbf{C}, \Psi_c)$, and $\theta_3 = (\mathbf{R}, \Psi_r)$. The AECM algorithm for *t*BFA comprises three cycles, with the following details.

1) Cycle 1: In the E-step, $(\mathcal{X}, \mathcal{T}) = {\mathbf{X}_n, \tau_n}_{n=1}^N$ is treated as complete data. In the CM-step, with θ_2 and θ_3 given, maximize the expected log-likelihood of complete data w.r.t. θ_1 .

E-step 1: It is the same as the E-step in the ECME algorithm.

CM-Step 1: Given θ_2 and θ_3 , maximizing Q_1 in (19) w.r.t. θ_1 results in $\widetilde{\mathbf{W}}$ in (21), and it leads to the solution for $\tilde{\nu}$ in the following equation (34).

$$-\psi(\frac{\nu}{2}) + \ln\frac{\nu}{2} + 1 + \psi(\frac{\nu + d_c d_r}{2}) - \ln\left(\frac{\nu + d_c d_r}{2}\right) + \frac{1}{N} \sum_{n=1}^{N} \left(\ln\tilde{\tau}_n - \tilde{\tau}_n\right) = 0, \quad (34)$$

where $\tilde{\tau}_n$ is computed using (20).

2) Cycle 2: The E-step treats $(\mathcal{X}, \mathcal{Y}^r, \mathcal{T}) = {\mathbf{X}_n, \mathbf{Y}_n^r, \tau_n}_{n=1}^N$ as the complete data set, and the CM-step, with $\tilde{\boldsymbol{\theta}}_1$ and $\boldsymbol{\theta}_3$ given, maximizes the expected complete data log-likelihood w.r.t. $\boldsymbol{\theta}_2$.

E-step 2: The log-likelihood of the complete data is

Given $\tilde{\boldsymbol{\theta}}_1, \boldsymbol{\theta}_2, \boldsymbol{\theta}_3$, calculate the expectation of \mathcal{L}_c^c w.r.t. the distribution $p(\mathcal{Y}^r, \mathcal{T} | \mathcal{X}; \tilde{\boldsymbol{\theta}}_1, \boldsymbol{\theta}_2, \boldsymbol{\theta}_3)$, yielding

where the computation of $\tilde{\tau}_n$ is based on the formula in (20), but with the substitution of θ_1 by $\tilde{\theta}_1$.

CM-step 2: Given $\tilde{\theta}_1$ and θ_3 , maximize Q_c in (35) w.r.t. θ_2 yields

where \mathbf{S}_c is given by (23).

3) Cycle 3: In the E-step, consider $(\mathcal{X}, \mathcal{Y}^c, \mathcal{T}) = \{\mathbf{X}_n, \mathbf{Y}_n^c, \tau_n\}_{n=1}^N$ as the complete data. In the CM-step, given $\tilde{\boldsymbol{\theta}}_1$ and $\tilde{\boldsymbol{\theta}}_2$, maximize the expected complete data likelihood w.r.t. $\boldsymbol{\theta}_3$.

E-step 3: The log-likelihood of the complete data is

$$\mathcal{L}_{r}^{c}(\boldsymbol{\theta}_{3}|\boldsymbol{\mathcal{X}},\boldsymbol{\mathcal{Y}}^{c},\boldsymbol{\mathcal{T}}) = \sum_{n=1}^{N} \ln \left\{ p(\mathbf{X}_{n}|\mathbf{Y}_{n}^{c},\tau_{n}) p(\mathbf{Y}_{n}^{c}|\tau_{n}) p(\tau_{n}) \right\}.$$

Given $\tilde{\boldsymbol{\theta}}_1, \boldsymbol{\theta}_2, \boldsymbol{\theta}_3$, calculate the expectation of \mathcal{L}_r^c w.r.t. the distribution $p(\mathcal{Y}^c, \mathcal{T}|\mathcal{X}; \tilde{\boldsymbol{\theta}}_1, \tilde{\boldsymbol{\theta}}_2, \boldsymbol{\theta}_3)$ (ignoring constant terms):

where the computation of $\tilde{\tau}_n$ is based on the formula in (20), but with the substitution of θ_1 and θ_2 by $\tilde{\theta}_1$ and $\tilde{\theta}_2$, respectively.

CM-step 3: Given $\tilde{\theta}_1$ and $\tilde{\theta}_2$, maximizing Q_r in (40) w.r.t. θ_3 yields

4.1.3 Acceleration via Parameter Expansion

Due to the slow convergence of traditional EM-type algorithms for multivariate t distributions, Liu et al. (1998) proposed a parameter expansion technique to accelerate them. This technique introduces auxiliary parameters to extend the original model while keeping the observed data model unchanged, and then develops EM-type algorithms on the extended complete data model. In this section, we apply this technique to tBFA, and develop parameter-expanded ECME (PX-ECME) and PX-AECME algorithms to accelerate their parent ECME in Sec. 4.1.1 and AECM in Sec. 4.1.2.

After introducing the auxiliary parameter α , the extended model is represented as follows:

(45)

where the parameters are marked with subscript $_{\star}$ to distinguish them from the parameters in the original model (7).

The E-step(s) and CM-step(s) in PX-ECME and PX-AECM are similar to those in ECME and AECM, but they are implemented on the extended parameters (θ_{\star}, α). Under the extended model (45), we obtain

By (46), $\Sigma_{c\star}/\alpha$ corresponds to Σ_c , and $(\mathbf{W}_{\star}, \Sigma_{r\star}, \nu_{\star})$ corresponds to $(\mathbf{W}, \Sigma_r, \nu)$. Moreover, since $\Sigma_{c\star} = \mathbf{C}_{\star}\mathbf{C}'_{\star} + \Psi_{c\star}$, we establish the mappings $\mathbf{C}_{\star}/\sqrt{\alpha} \leftrightarrow \mathbf{C}$ and $\Psi_{c\star}/\alpha \leftrightarrow \Psi_c$. Through this mapping, the extended parameters $(\boldsymbol{\theta}_{\star}, \alpha)$ can be reduced back to the original parameters $\boldsymbol{\theta}$ at the end of each iteration.

For the PX-ECME algorithm, we observe that, compared to the ECME algorithm, its difference lies in replacing \mathbf{S}_c in (23) and \mathbf{S}_r in (30) with \mathbf{S}_c^* in (49) and \mathbf{S}_r^* in (50).

4.2 Matrix factor score

In FA model, the factor scores \mathbf{z} is a vector and can be computed by $\mathbb{E}(\mathbf{z}|\mathbf{x})$ (Anderson, 2003; Zhao et al., 2008). However, in *t*BFA model, the factor scores \mathbf{Z} is a matrix, instead of a vector. From (12) and (13), the matrix factor score $\mathbb{E}(\mathbf{Z}|\mathbf{X})$ can be obtained by

4.3 Asymptotic properties and estimating precision of parameter estimates

In this subsection, we discuss the theoretical properties of the ML estimator $\widehat{\Theta}$ as the sample size $N \to \infty$. Under general regularity conditions, $\widehat{\Theta}$ can converge in probability to the true

value of Θ_0 and distribution to a multivariate normal distribution with the mean vector Θ_0 and covariance matrix being the inverse of the Fisher information matrix. Specifically, we have

$$\sqrt{N}(\widehat{\boldsymbol{\Theta}} - \boldsymbol{\Theta}_0) \xrightarrow{L} \mathcal{N}_{\mathcal{D}}(\mathbf{0}, \mathbf{I}_1^{-1}(\boldsymbol{\Theta}_0)),$$

where \mathcal{D} represents the dimension of Θ , which is the number of free parameters in tBFA. $\mathbf{I}_1(\Theta_0)$ denotes the Fisher information matrix evaluated at Θ_0 , and the Fisher information matrix containing N i.i.d. observations can be computed as $\mathbf{I}_N(\Theta) = N\mathbf{I}_1(\Theta)$. The specific expressions of $\mathbf{I}_N(\Theta)$ are provided below.

To measure the accuracies of the ML estimators, following Wang et al. (2017), we derive the closed-form expression of $\mathbf{I}_N(\Theta)$ that can be used to compute the standard errors of $\widehat{\Theta}$. Let $\boldsymbol{\mu} = \operatorname{vec}(\mathbf{W})$. Denote $\boldsymbol{\theta}_c = \operatorname{vech}(\boldsymbol{\Sigma}_c)$ and $\boldsymbol{\theta}_r = \operatorname{vech}(\boldsymbol{\Sigma}_r)$. We calculate the first derivatives of (18) w.r.t. each element of Θ to obtain the score vector

$$\mathbf{s}(\boldsymbol{\theta}|\mathcal{X}) = \operatorname{vec}\left(\mathbf{s}^{\boldsymbol{\mu}}, \mathbf{s}^{\boldsymbol{\theta}_{c}}, \mathbf{s}^{\boldsymbol{\theta}_{r}}, \mathbf{s}^{\nu}\right).$$

The Hessian matrix can be computed using the related second derivatives of the log-likelihood function w.r.t. each element of Θ

$$\mathbf{H}(\boldsymbol{\theta} \mid \boldsymbol{\mathcal{X}}) = \begin{bmatrix} \mathbf{H}^{\mu\mu} & \mathbf{H}^{\mu\theta_{c}} & \mathbf{H}^{\mu\theta_{r}} & \mathbf{H}^{\mu\nu} \\ \mathbf{H}^{\theta_{c}\mu} & \mathbf{H}^{\theta_{c}\theta_{c}} & \mathbf{H}^{\theta_{c}\theta_{r}} & \mathbf{H}^{\theta_{c}\nu} \\ \mathbf{H}^{\theta_{r}\mu} & \mathbf{H}^{\theta_{r}\theta_{c}} & \mathbf{H}^{\theta_{r}\theta_{r}} & \mathbf{H}^{\theta_{r}\nu} \\ \mathbf{H}^{\nu\mu} & \mathbf{H}^{\nu\theta_{c}} & \mathbf{H}^{\nu\theta_{r}} & \mathbf{H}^{\nu\nu} \end{bmatrix}.$$

The expressions for each element of (64) and (65) can be found in the Theorem 2. To obtain the Fisher information matrix, the following Theorem 1 is required. The Fisher information matrix $\mathbf{I}_N(\mathbf{\Theta}) = -\sum_{n=1}^N \mathbb{E}[\mathbf{H}_n(\boldsymbol{\theta} \mid \mathbf{X}_n)] = -\mathbb{E}[\mathbf{H}(\boldsymbol{\theta} \mid \mathcal{X})]$ is detailed in Theorem 2. **Theorem 1.** For tBFA model (7), we have:

Other cases can be demonstrated using a similar method.

5 Experiments

In this section, a series of experiments are conducted on simulated and real data to understand our proposed tBFA and compare the performance of tBFA with three relevant methods: BFA (Shang et al., 2023), tFA (Zhang et al., 2014) and FA. All computations are performed by Matlab 9.13 on a desktop computer with Intel Core i7-8700K 3.70GHz CPU and 64G RAM.

5.1 Notes on implementation

5.1.1 Initialization and stopping rules

For all methods, we set $\eta = 0.005$. Unless otherwise stated, all iterative algorithms are initialized randomly. Iterations are stopped when the relative change in the log-likelihood function ($|1 - \mathcal{L}^{(t)}/\mathcal{L}^{(t+1)}|$) is smaller than a threshold *tol* (set to 10^{-8} in our experiments) or when the number of iterations exceeded a certain value t_{max} (set to 1000 in our experiments).

5.1.2 Model selection

In practice, the number of factors (q_c, q_r) in tBFA is often unknown. To determine (q_c, q_r) , we adopt the Bayesian Information Criterion (BIC). BIC is well known for its theoretical consistency (Schwarz, 1978). The BIC is defined as follows:

$$\mathcal{L}^*\left\{(q_c, q_r), \widehat{\Theta}(q_c, q_r)\right\} = -2\mathcal{L}\left\{\widehat{\Theta}(q_c, q_r) \mid \mathcal{X}\right\} + \mathcal{D}\ln N,$$

where $\widehat{\Theta}(q_c, q_r)$ represents the ML estimate of parameters Θ in the (q_c, q_r) -factor model, $\mathcal{L}(\widehat{\Theta} \mid \mathcal{X})$ denotes the value of the log-likelihood function (18) evaluated at $\widehat{\Theta}(q_c, q_r)$, and \mathcal{D} is the number of free parameters.

By BIC, (q_c, q_r) is determined by the minimizer of \mathcal{L}^* in the candidate set $\mathcal{I} = \{(q_c, q_r) \mid q_{c,min} \leq q_c \leq q_{c,max}, q_{r,min} \leq q_r \leq q_{r,max}\}$. Suppose that the true model is within the candidate set, due to the consistency of the BIC, as the sample size $N \to \infty$, the true model will be selected with probability approaching one.

5.2 Synthetic data

5.2.1 Convergence of different algorithms

In this experiment, we use three simulated datasets (i.e., Data 1, Data2 and Data3) to compare the convergence performance of four ML estimation algorithms for tBFA: ECME, PX-ECME, AECM, and PX-AECM. These datasets are generated by BFA, namely $\mathbf{X} \sim \mathcal{N}_{d_c,d_r}(\mathbf{W}, \mathbf{CC'} + \mathbf{\Psi}_c, \mathbf{RR'} + \mathbf{\Psi}_r)$. Data1 and Data2 are two low-dimensional datasets and Data3 is a highdimensional one. The details about the data settings are given below.

(i) Data1: Low-dimensional data with ordinary noise. The sample size N = 500. The data dimensions $d_c = d_r = 10$, and the numbers of factors $q_c = q_r = 3$. Let \mathbf{U}_c (resp. \mathbf{U}_r) is a $d_c \times q_c$ (resp. $d_r \times q_r$) randomly generated column-orthogonal matrix and \mathbf{L}_c (resp. \mathbf{L}_r) is a $q_c \times q_c$ $(q_r \times q_r)$ diagonal matrix. The parameter settings in BFA model are given by

 $\mathbf{W} = \mathbf{0}, \quad \mathbf{L}_{c} = \text{diag}\{\sqrt{5}, \sqrt{4.5}, \sqrt{4}\}, \quad \mathbf{L}_{r} = \text{diag}\{\sqrt{10}, \sqrt{9}, \sqrt{8}\}$ $\mathbf{C} = \mathbf{U}_{c}\mathbf{L}_{c}, \quad \mathbf{R} = \mathbf{U}_{r}\mathbf{L}_{r}, \quad \mathbf{\Psi}_{c} = \text{diag}\{\text{linspace}(0.5, 1, 10)\}, \quad \mathbf{\Psi}_{r} = \text{diag}\{\text{linspace}(1, 2, 10)\},$

where linspace(a, b, n) represents a vector of n evenly spaced points from a to b, i.e., $(a, a + (b - a)/(n-1), \ldots, b)'$.

(ii) Data2: Low-dimensional data with low noise. As EM algorithms tend to be inefficient in low-noise linear models (Petersen et al., 2005; Zhao et al., 2008), we examine the performance

of four algorithms under low-noise conditions. For Data2, $\Psi_c = \text{diag}\{\text{linspace}(0.05, 0.1, 10)\},$ $\Psi_r = \text{diag}\{\text{linspace}(0.1, 0.2, 10)\}$ are used to simulate low noise, with other parameter settings identical to Data1.

(iii) Data3: High-dimensional data. Due to the lower computational complexity at a single iteration of the AECM algorithm compared to the ECME algorithm, we expect the AECM algorithm to consume less CPU time on high-dimensional data. To explore this, we use highdimensional Data3 to compare the convergence performance of the four algorithms. The data dimensions are $d_c = 2000$, $d_r = 10$, the numbers of factors are also $q_c = q_r = 3$, the sample size is N = 100, and other parameter settings are similar as Data1.

All four algorithms use the true factor dimensions (3,3) to fit these three datasets. For demonstration purpose, we set $tol = 10^{-9}$ for Data3. Fig. 1 displays the evolution of the loglikelihood versus the number of iterations and used CPU time for the four algorithms on these three datasets. The main observations are as follows.

- (i) For Data1, both PX-ECME and ECME converge faster compared to their counterparts PX-AECM and AECM; PX algorithms converge faster than their non-PX counterparts.
- (ii) For Data2, the conclusions are roughly similar to those on Data1. However, AECM-type algorithms converge much slower on Data2 than on Data1, while ECME-type algorithms

are insensitive to low noise.

(iii) For Data3, AECM-type algorithms consume less time compared to their ECME-type counterparts; PX algorithms are more efficient than their non-PX counterparts.

Overall, PX-ECME algorithm performs well on different datasets. Therefore, we will use PX-ECME algorithm for tBFA in the following experiments.

5.2.2 Robustness

This experiment investigates the robustness of tBFA, BFA, tFA, and FA using simulated data containing outliers. Initially, we generate a dataset with N = 1000 normal observations from Data1 in Sec. 5.2.1. Subsequently, we add it with Np/(1-p) abnormal observations so that the proportion of all outliers is p. Inspired by Ma et al. (2023), we considered three types of outliers under four different situations:

- (i) Three types of outliers: 1) Factor Component (FC) outliers, showing outlyingness only in the FC subspace; 2) Orthogonal Component (OC) outliers, showing outlyingness only in the OC subspace; 3) FC+OC outliers, showing outlyingness in both the FC and OC subspaces.
- (ii) Four situations (Sit): two abnormal levels in two cases (symmetry and asymmetry). To be specific, the three types of outliers are generated from the following situations: Sit-I: U(-100, 100), Sit-II: U(-10000, 10000), Sit-III: U(100, 110), and Sit-IV: U(10000, 11000). In the symmetric cases, the outliers are symmetrical about the true population mean and thus their impacts on the estimate of the mean parameter may be relatively small.

In total, 12 outlier scenarios are investigated. For demonstration, Fig. 2 presents a two-dimensional subspace plot that illustrates the three types of outliers in an asymmetric case. Further details on generating the three types of outliers are provided in A.

To assess the accuracy of parameter estimates obtained by different methods, we report the relative differences between the true covariance matrix $\Sigma = \Sigma_r \otimes \Sigma_c$ and the estimated $\hat{\Sigma}$, denoted as $\|\Sigma - \hat{\Sigma}\|_F / \|\Sigma\|_F$, where $\|\cdot\|_F$ represents the Frobenius norm. For FA and tFA, $\hat{\Sigma} = \hat{A}\hat{A}' + \hat{\Psi}$. For BFA and tBFA, $\hat{\Sigma} = \hat{\Sigma}_r \otimes \hat{\Sigma}_c$, where $\hat{\Sigma}_c = \hat{C}\hat{C}' + \hat{\Psi}_c$ and $\hat{\Sigma}_r = \hat{R}\hat{R}' + \hat{\Psi}_r$. To reduce statistical variability, we report the average results over 50 repetitions.

Table 1 displays the results for Sit-I and Sit-III at varying proportions p. The results for Sit-II and Sit-IV, with higher abnormal levels, are similar to those in Table 1, and details are

omitted here. Looking at Table 1, we have the following.

- (i) tBFA versus BFA and FA: tBFA is more robust than BFA and FA, both of which are susceptible to outliers. The larger the value of p, the greater the distance.
- (ii) tBFA versus tFA: tFA is not robust except for OC and FC+OC outliers in the symmetric case. Notably, for FC outliers in the asymmetric case, tFA is only robust when the proportion of outliers is 0.5%, but not when it exceeds 1%. In contrast, tBFA maintains robustness across all p values in all six cases. This implies that tBFA can handle datasets with a significantly higher proportion of outliers compared to tFA.

Remarks: Our results obtained in this subsection are generally comparable with those in Ma et al. (2023). The main reason for the superior performance of tBFA over tFA is given below. It is known that the robustness of estimators can be assessed through breakdown points, and the breakdown point of the multivariate t distribution is upper-bounded by $1/(d+\nu)$ (Dümbgen and Tyler, 2010) and thus smaller than 1/d. For our used data, d = cr = 100 and thus 1/d = 1%. This elucidates the complete failure of tFA when $p \ge 1\%$ for PC outliers in the asymmetric case. However, this bound does not hold for tBFA, since tBFA still performs well even when p = 9%across all six cases. This suggests that the proposed tBFA has a significantly higher bound than tFA, making tBFA more suitable for matrix data.

5.2.3 Accuracies of estimators

This experiment investigates the finite sample performance of the ML estimators and the estimated standard errors. The experiment utilizes 5×5 -dimensional matrix datasets generated by *t*BFA (7), with the following parameter settings:

$$\mathbf{W} = \mathbf{0}, \quad \nu = 3, \quad \mathbf{\Psi}_c = \text{diag}\{0.1, 0.2, 0.3, 0.4, 0.5\}, \quad \mathbf{\Psi}_r = \text{diag}\{0.2, 0.3, 0.4, 0.5, 0.6\},$$
$$\mathbf{C}' = \begin{bmatrix} -1.03 & -0.78 & -1.35 & -1.05 & -2.10\\ 3.47 & -4.39 & 6.99 & -3.44 & -2.83 \end{bmatrix}, \quad \mathbf{R}' = \begin{bmatrix} -1.12 & -1.40 & -1.45 & -1.54 & -1.15\\ -2.15 & -5.44 & -4.71 & 6.28 & 2.04, \end{bmatrix}$$

To study performance under finite sample conditions, datasets with different sample sizes N are generated from the set $N \in \{100, 500, 5000\}$. We fit *t*BFA with the true factor dimensions $q_c = q_r = 2$ for each dataset. To reduce the effects of randomness, we perform 100 repetitions for each dataset. The following metrics are calculated.

The performance of the ML estimators is evaluated using the root mean square error (RMSE):

RMSE
$$\left(\widehat{\boldsymbol{\Theta}}_{i}\right) = \sqrt{\frac{1}{100} \sum_{h=1}^{100} \left(\widehat{\boldsymbol{\Theta}}_{i}^{(h)} - \boldsymbol{\Theta}_{i}\right)^{2}},$$

where $\widehat{\Theta}^{(h)}$ represents the ML estimators of the true parameters Θ obtained in the *h*-th repetition.

Additionally, to investigate the consistency of the estimated standard errors, the average values of information matrix-based standard errors (IMSE) in (71) and empirical standard deviations (ESTD) are calculated:

$$\text{IMSE}\left(\widehat{\boldsymbol{\Theta}}_{i}\right) = \frac{1}{100} \sum_{h=1}^{100} \text{SE}(\widehat{\boldsymbol{\Theta}}_{i}^{(h)}), \quad \text{ESTD}\left(\widehat{\boldsymbol{\Theta}}_{i}\right) = \sqrt{\frac{1}{99} \left[\sum_{h=1}^{100} \left(\widehat{\boldsymbol{\Theta}}_{i}^{(h)}\right)^{2} - \frac{1}{100} \left(\sum_{h=1}^{100} \widehat{\boldsymbol{\Theta}}_{i}^{(h)}\right)^{2}\right]},$$

where $\operatorname{SE}\left(\widehat{\Theta}_{i}^{(h)}\right)$ denotes the information matrix-based standard errors (IMSE) of Θ_{i} in the *h*-th repetition in Sec. 4.3. Note that the restrictions mentioned in Sec. 3.3 are imposed on *t*BFA to ensure the uniqueness of the estimators.

Table 2 provides the root mean squared error (RMSE) values of the ML estimates for four parameters $\mathbf{C}, \nu, \Psi_c, \Psi_r$ under different sample sizes. The results for \mathbf{R} are similar to those for \mathbf{C} and are omitted here. As shown in Table 2, with the increase in sample size, the RMSE values of all model parameters gradually decrease, indicating more accurate model estimation and demonstrating the consistency of the ML estimator.

Table 3 presents the estimated standard errors of the ML estimates for four parameters. From Table 3, it can be observed that both ESTDs and IMSEs decrease as sample size N increases.

Importantly, the two values approach each other, indicating the accuracy and stability of the theoretical standard errors calculated based on the information matrix.

5.3 Real data

In this section, we use real data to investigate the proposed tBFA, including the performance of BIC-based model selection, the interpretation of row and column common factors, and the prediction of matrix factor scores.

5.3.1 Athletic records data

Although factor analysis is widely used, the results in the literature mostly focus on vector data and there is relative paucity of the analysis on matrix data directly. For better comparison, in this experiment, vector data is artificially augmented to matrix data so that we can utilize the known factor analysis results on vector data as a reference.

We use a vector-valued dataset from Exercise 12.8 in Härdle and Simar (2019), denoted by Data-V. The dataset is composed of men's athletic records of 8 track events from 55 coun-

tries/regions in the 1984 Olympic Games. That is, Data-V consists of 55 observations and 8 variables. Table 4 provides a summary of variable information, including sample means, variances, kurtosis, and Jarque-Bera tests (Jarque and Bera, 1980). As indicated by the descriptive statistics in the table, all variables exhibit high kurtosis. The Jarque-Bera test *p*-values suggest that none of the variables follow a normal distribution. Therefore, modeling with heavy-tailed distributions would be appropriate.

To select the factor dimension q, we use BIC for FA and tFA on the original Data-V. The candidate model set is defined as $\mathcal{I} = \{q \mid 1 \leq q \leq 4\}$, encompassing 4 models. Fig. 3 (a) shows the evolutions of the BIC values of all candidates with varying (q) on Data-V for both FA and tFA. Table 5 summarizes the optimal results. It can be observed that both FA and tFA favor a 2-factor model. However, it is noticeable that the BIC values for tFA models are consistently smaller than those for FA models, suggesting that the 2-factor tFA model provides the best fit.

Next, we augment Data-V and compare the performance of tBFA and BFA on the augmented matrix data. The original Data-V can be considered as a special $8 \times 1 \times 55$ matrix-valued dataset, i.e., $d_c = 8, d_r = 1$. Based on the results of FA, with row factor number $q_c = 2$, column factor number $q_r = 1$, and the estimated factor loading matrix denoted as $\hat{\mathbf{A}}$, combined with the estimated degrees of freedom $\hat{\nu} = 4.28$ from tFA, we set $\mathbf{C} = \hat{\mathbf{A}}, \nu = 4.28$, and randomly generate a $d_r \times 1$ matrix \mathbf{R} . By (11), we can augment Data-V from $d_r = 1$ to any d_r ($d_r > 1$). In this experiment, we set $d_r = 7$, resulting in a matrix dataset of dimensions $8 \times 7 \times 55$, which is denoted as Data-M. Note that the factor dimensions of Data-M remain unchanged from those

of Data-V, i.e., $(q_c = 2, q_r = 1)$.

To select the factor dimensions (q_c, q_r) , we apply BIC for both BFA and tBFA on Data-M. The candidate model set is $\mathcal{I} = \{(q_c, q_r) \mid 1 \leq q_c \leq 4, 1 \leq q_r \leq 3\}$, including a total of 12 models. Fig. 3 (b) shows the evolutions of the BIC values of all candidates with varying (q_c, q_r) on Data-M for both BFA and tBFA. Table 5 summarizes the optimal results. It can be seen from Fig. 3 (b) and Table 5 that both matrix-based factor analysis models correctly select the true model. Notably, the BIC values for tBFA are smaller than that of BFA model, indicating that tBFA provides a better fit to the Data-M.

To further compare the results of FA (q = 2) and tFA (q = 2) on Data-V with BFA $(q_c = 2, q_r = 1)$ and tBFA $(q_c = 2, q_r = 1)$ on Data-M, varimax rotation (Lawley and Maxwell, 1971) is applied to the factor loading matrices $\hat{\mathbf{A}}$ in FA and tFA, as well as the column factor loading matrices $\hat{\mathbf{C}}$ in BFA and tBFA. The rotated factor loading results are presented in Table 6. Despite some numerical differences, all four methods exhibit consistent factor structure patterns. Specifically, one factor captures explosive power for short-distance races and speed and interprets variables $\mathbf{x}_1, \mathbf{x}_2, \mathbf{x}_3$, and another factor captures endurance for long-distance races and interprets the remaining variables, i.e., $\mathbf{x}_4, \mathbf{x}_5, \mathbf{x}_6, \mathbf{x}_7, \mathbf{x}_8$. The experimental results indicate that the BIC-

based tBFA successfully extracts meaningful factors and performs well as expected on Data-M. Note that it is infeasible to apply tFA to the vectorized Data-M as vectorization yields a dataset of dimensions 56×55 , facing the high-dimensional problem of d > N.

5.3.2 Fama–French 10 by 10 return series

In this experiment, we use the Fama–French 10 by 10 return series ¹ Wang et al. (2019). This dataset comprises 624 matrix observations, covering monthly returns from January 1964 to December 2015, a total of 624 months. Each observation is a 10×10 matrix, where the column variables represents the ten levels of market capital (Size) from small to large, and the row variables represents the ten levels of book-to-equity ratio (BE) from small to large. Based on this, stocks are classified into 100 portfolios. Following Wang et al. (2019), we preprocess the data by performing market adjustment on each observation, namely subtracting the corresponding monthly excess market returns to obtain market-adjusted return series.

To assess the normality assumption for the data, we perform the Jarque-Bera test for each variable (i.e., portfolio). For convenience, the set of all 100 variables are denoted by Ω . The results are reported in 7. Based on the reported *p*-values, the normal assumption for 99 out of 100 variables are rejected, indicating the data does not follow the matrix-variate normal distribution.

We use BFA and tBFA to analyze this dataset. BIC is used to select the factor dimensions (q_c, q_r) for both models. The candidate set is $\mathcal{I} = \{(q_c, q_r) \mid 1 \leq q_c \leq 6, 1 \leq q_r \leq 6\}$. Fig. 4

shows the evolutions of BIC values for BFA and tBFA as (q_c, q_r) takes different values. Table 8 collects the optimal results. From Fig. 4 and Table 8, it can be observed that both BFA and tBFA achieve the minimum BIC values when the factor dimensions are $(q_c = 2, q_r = 3)$. Moreover, it is observed that the BIC values for all candidate models of tBFA are lower than the corresponding BFA models, indicating that tBFA provides a better fit compared to BFA.

To further examine the obtained column (Size) and row (BE) common factors, the varimax rotation is applied to the column and row factor loading matrices, respectively. Table 9 shows the results scaled by 30. For comparison, the result by MFM taken from Wang et al. (2019) is also included. From Table 9, it can be observed that

(i) Size factors. The two common factors obtained by tBFA and BFA are comparable. Specifically, the first factor could be named 'small size factor', mainly explaining the portfolios

with the smallest market capital (from S1 to S5). The second factor could be named 'big size factor', primarily explaining portfolios with larger market capital (from S6 to S10). In constrast, there are possibly two or three factors for MFM as the largest S10 portfolio may be classified as a single factor.

(ii) BE factors. Both tBFA and BFA obtain three common factors, while MFM gives two factors. In detail, for tBFA, the first factor could be named 'medium BE factor', as it mainly explains portfolios with BE levels from 5 to 7, i.e., medium book-to-equity ratios. Likewise, the second factor could be named 'high BE factor', mainly explaining portfolios with BE levels from 8 to 10, namely relatively high book-to-equity ratios), and the third factor named 'small BE factor', mainly explaining portfolios with BE levels from 1 to 4, namely relatively low book-to-equity ratios. We note that Fama and French (1995) defined the lowest 30% of BE as Low, the highest 30% as High, and the middle 40% as Medium. This is roughly consistent with the factors obtained by tBFA and BFA, while the factors by MFM are not the case.

Fig. 5 plots the estimated factor matrix over time. From Fig. 5, it can be seen that, given the market size factor, the volatility of the 'low BE factor' is significantly lower than that of the 'medium and high BE factors'. This is because low BE indicates the typical performance of companies with higher average capital return rates (i.e., growth stocks), while high BE ratios often signify sustained low returns on book value, indicative of the typical performance of relatively poor-performing companies (Fama and French, 1995). Furthermore, when the BE factor is given, the larger the market capital, the more stable the return.

6 Conclusion and future works

To improve BFA in the presence of heavy-tailed matrix data or matrix-valued outliers, we propose in this paper a novel factor analysis tool called tBFA, using the matrix-variate t distribution. For the task of parameter estimation, we present two EM-type algorithms, namely, ECME and AECM. AECM scales better on high-dimensional matrix data while ECME converges faster. To expedite both ECME and AECM, we incorporate the PX technique and introduce two enhanced variants, namely PX-ECME and PX-AECM, demonstrating clear advantages over their non-PX counterparts. To assess the accuracy of the obtained ML estimator, we explicitly drive the closed-form expression of Fisher information matrix. Unlike tFA, where factor scores are vectors, the factor scores in tBFA are matrices. We also conduct a visual analysis of the matrix factor scores. Our empirical results on matrix datasets show that tBFA improves the robustness of BFA as expected. More importantly, tBFA performs much better than its vector-based cousin tFA, primarily owing to its higher breakdown point.

It is important to highlight that the newly proposed tBFA is tailored for matrix-valued data. In contemporary applications, there is a growing prevalence of naturally occurring tensor-valued data. For instance, the mortality data analyzed in (Fosdick and Hoff, 2014) consists of four modes: mode 1 encompasses 40 countries, mode 2 involves 9 time points, mode 3 encompasses 23 age groups, and mode 4 includes 2 gender groups. We consider extending the proposed tBFA model to accommodate tensor-valued data as a future research direction.

For future works, inspired by the works on the vector-based mixtures of factor analysis (Zhao and Yu, 2008; Zhao, 2014; Wang and Lin, 2022), it would be interesting to extend our tBFA in this paper to mixtures of tBFA for robustly clustering matrix data.

A Generating the three types of outliers

Let \mathbf{C}_{fc} (resp. \mathbf{R}_{fc}) be the $d_c \times q_c$ (resp. $d_r \times q_r$) factor loading matrix, spanning the column (resp. row) factor component subspace. Correspondingly, \mathbf{C}_{oc} and \mathbf{R}_{oc} denote their orthogonal complements. To introduce outliers, inspired by She et al. (2016), we utilize the following contaminated model, which is a modification of tBFA (7):

$$\mathbf{X}_{o} = \mathbf{W} + \mathbf{C}_{fc} \mathbf{Z} \mathbf{R}'_{fc} + \mathbf{C}_{fc} \boldsymbol{\epsilon}_{r} + \boldsymbol{\epsilon}_{c} \mathbf{R}'_{fc} + \boldsymbol{\epsilon} + \mathbf{C}_{o} \mathbf{Z}_{o} \mathbf{R}'_{o}.$$

Depending on the type of outliers, $\mathbf{C}_o, \mathbf{Z}_o$, and \mathbf{R}_o in (73) are set as follows.

(i) FC outliers, $\mathbf{C}_o = [\mathbf{C}_{fc}, \mathbf{O}]$ and $\mathbf{R}_o = [\mathbf{R}_{fc}, \mathbf{O}]$, where \mathbf{O} is a zero matrix of suitable dimension. \mathbf{Z}_o is a zero matrix except that the entries of the submatrix comprising the first q_c columns and q_r rows are drawn from a uniform distribution.

(ii) OC outliers, $\mathbf{C}_o = [\mathbf{O}, \mathbf{C}_{oc}]$ and $\mathbf{R}_o = [\mathbf{O}, \mathbf{R}_{oc}]$. \mathbf{Z}_o is a zero matrix except that the entries of the submatrix comprising the last $d_c - q_c$ columns and $d_r - q_r$ rows are drawn from a

uniform distribution.

(iii) FC+OC outliers, $\mathbf{C}_o = [\mathbf{C}_{fc}, \mathbf{C}_{oc}]$ and $\mathbf{R}_o = [\mathbf{R}_{fc}, \mathbf{R}_{oc}]$, the entries of \mathbf{Z}_o are drawn from a uniform distribution.

The uniform distribution in (i), (ii), and (iii) is one of those in the four situations described in Sec. 5.2.2.
