# Stochastic Bregman Proximal Gradient Method Revisited: Kernel Conditioning and Painless Variance Reduction

#### Abstract

We investigate Bregman proximal gradient (BPG) methods for solving nonconvex composite stochastic optimization problems. Instead of the standard gradient Lipschitz continuity (GLC) assumption, the objective function  $\Psi$  only satisfies a smooth-adaptability assumption w.r.t. some kernel function  $h$ . First, an in-depth analysis of the stationarity measure is made in this paper, where we reveal an interesting fact that the widely adopted Bregman proximal gradient mapping  $\mathcal{G}^{\lambda}_{\phi,h}(\cdot)$  in the existing works may not correctly depict the near-stationarity of the solutions. Denote  $\partial \Psi$  the limiting Fréchet subdifferential of  $\Psi$ , we show that  $\|\mathcal{G}^{\lambda}_{\phi,h}(\cdot)\|$  can be much smaller than  $dist(0, \partial \Psi(\cdot))$  (or  $\|\nabla \Psi(\cdot)\|$  for differentiable  $\Psi$ ). In some counterexamples with unbounded level set, one may even observe  $\mathcal{G}^{\lambda}_{\phi,h}(x_k) \to 0$  while having dist $(0, \partial \Psi(x_k)) = \Omega(1)$ . To resolve this issue, a new Bregman proximal gradient mapping  $\mathcal{D}^{\lambda}_{\phi,h}(\cdot)$  satisfying  $\|\mathcal{D}^{\lambda}_{\phi,h}(\cdot)\| = \Theta\big(\text{dist}(0,\partial\Psi(\cdot))\big)$  is proposed and analyzed in this paper. Second, a thorough analysis is made on the sample complexities of the stochastic Bregman proximal gradient methods. As  $\mathcal{G}^{\lambda}_{\phi,h}(\cdot)$  is still widely adopted in the literature and it makes sense for problems with bounded level set, both the old and new gradient mappings are analyzed. Note that the absence of GLC disables the standard analysis of the stochastic variance reduction techniques, existing stochastic BPG methods only obtain an  $O(\epsilon^{-2})$  sample complexity to make  $\mathbb{E}[\|\mathcal{G}^{\lambda}_{\phi,h}(\cdot)\|^2] \leq \epsilon$ . In this paper, we show that such a limitation in the existing analyses mainly comes from the insufficient exploitation of the kernel's properties. By proposing a new kernel-conditioning regularity assumption on the kernel h, we show that a simple epoch bound mechanism is enough to enable all the existing variance reduction techniques for stochastic BPG methods. Combined with a novel probabilistic argument, we show that there is a high probability event A conditioning on which  $O(\sqrt{n}\epsilon^{-1})$  samples are required to guarantee  $\mathbb{E}[\|\mathcal{G}^{\lambda}_{\phi,h}(\cdot)\|^2|\mathcal{A}]\leq \epsilon$ for the finite-sum stochastic setting. Moreover, with a novel adaptive step size control mechanism, we also show that  $\widetilde{O}(\sqrt{n}L_h(\mathcal{X}_\epsilon)e^{-1})$  samples are needed to guarantee  $||\mathcal{D}_{\phi,h}^{\lambda}(\cdot)||^2 \leq \epsilon$  with high probability, where  $L_h(\mathcal{X}_{\epsilon})$  denotes the Lipschitz constant of the kernel h in some compact set  $\mathcal{X}_{\epsilon}$ . Although  $L_h(\mathcal{X}_{\epsilon})$  may introduce additional  $\epsilon$ -dependence for problems with unbounded level set, it is a provably tight characterization of the worst case complexity.

## 1 Introduction

In this paper, we consider the composite stochastic nonconvex optimization problem

$$
\min_{x \in \mathbb{R}^d} \Psi(x) = f(x) + \phi(x),\tag{1}
$$

where  $\phi(x)$  is a convex but possibly non-differentiable function, while  $f(x)$  is a nonconvex and continuously differentiable function that may take the form of a finite sum  $f(x) = \frac{1}{n} \sum_{i=1}^{n} f_i(x)$  or a general expectation  $f(x) = \mathbb{E}_{\xi} [f_{\xi}(x)]$ . In particular, we consider the problem class where the gradient  $\nabla f$  is not globally Lipschitz continuous. With various applications to optimizing log-determinant of Fisher information matrix [\[21\]](#page-34-0), quadratic inverse problem [\[4\]](#page-33-0) multi-layer neural networks [\[32,](#page-34-1) [9\]](#page-33-1), etc., this problem setting has drawn increasing interest recently.

For standard nonconvex optimization problem where  $f$  has a globally Lipschitz continuous gradient, both the lower and upper bounds of the first-order methods are well-understood under both deterministic and stochastic settings. Define the proximal operator and the gradient mapping as

$$
\mathbf{prox}_{\lambda\phi}(v) := \underset{x \in \mathbb{R}^d}{\text{argmin}} \, \phi(x) + \frac{1}{2\lambda} \|x - v\|^2 \quad \text{and} \quad G^{\lambda}_{\phi}(x) := \frac{x - \mathbf{prox}_{\lambda\phi}(x - \lambda\nabla f(x))}{\lambda} \, . \tag{2}
$$

In terms of the squared gradient mapping  $||G^{\lambda}_{\phi}(\cdot)||^2$ , a standard proximal gradient method achieves the  $\mathcal{O}(1/T)$  convergence rate [\[3\]](#page-33-2), which is provably optimal [\[6\]](#page-33-3). For stochastic optimization setting, to obtain an  $\epsilon$ -stationary point  $\bar{x}$  such that  $\mathbb{E}[\|G_{\phi}^{\lambda}(\bar{x})\|^2] \leq \epsilon$ , the stochastic variance reduced methods achieved  $O(\sqrt{n}\epsilon^{-1})$  [\[38,](#page-35-0) [35\]](#page-35-1) and  $O(\epsilon^{-1.5})$  [\[14,](#page-33-4) [35,](#page-35-1) [7\]](#page-33-5) sample complexities have been derived for finite sum and general expectation settings, respectively, both of which have matched the information theoretic lower bounds [\[1,](#page-33-6) [41\]](#page-35-2). However, these results exclusively rely on the gradient Lipschitz continuity of the differentiable component  $f$ , without which all the above results would fail.

To address the difficulty due to the absence of the globally Lipschitz continuous gradient, several works proposed the notion of the smooth adaptability (smad)  $[2, 4]$  $[2, 4]$  $[2, 4]$ , or equivalently, relative smoothness [\[30\]](#page-34-2), which allows f to behave smoothly relative to the geometry introduced by the Bregman divergence of some kernel function h. Based on this condition, a generalized descent lemma has been established [\[2\]](#page-33-7), and a Bregman proximal gradient (BPG) method has been proposed:

$$
x_{k+1} = \mathbf{T}^{\lambda}_{\phi,h}(x_k, \nabla f(x_k)) \quad \text{with} \quad \mathbf{T}^{\lambda}_{\phi,h}(x,v) := \underset{y \in \mathbb{R}^d}{\text{argmin}} \ y^{\top} v + \phi(y) + \lambda^{-1} D_h(y,x), \quad (3)
$$

where  $D_h(y, x) := h(y) - \nabla h(x)^\top (y - x) - h(x)$  stands for the Bregman divergence induced by h. As suggested by  $[4, Section 4.1]$  $[4, Section 4.1]$ , a generalization to the gradient mapping  $(2)$  can be defined as

$$
\mathcal{G}_{\phi,h}^{\lambda}(x) := \frac{x - \mathbf{T}_{\phi,h}^{\lambda}(x, \nabla f(x))}{\lambda},\tag{4}
$$

which we call a Bregman proximal gradient mapping. Then in terms of  $\|\mathcal{G}_h^{\lambda}(\cdot)\|^2$ , an  $O(1/T)$  convergence can again be achieved by the BPG method [\[4\]](#page-33-0), as well as its several variants [\[36,](#page-35-3) [28,](#page-34-3) [16,](#page-34-4) [17,](#page-34-5) [31,](#page-34-6) [27\]](#page-34-7). Under such a stationarity measure, the current results **seemingly** recovers the optimal  $O(1/T)$  convergence of standard nonconvex optimization with Lipschitz continuous gradients.

On contrary to the deterministic setting, when randomness meets the nonconvex optimization problems that do not have Lipschitz continuous gradients, only a suboptimal  $O(\epsilon^{-2})$  sample complexity has been derived for general expectation setting [\[8,](#page-33-8) [9\]](#page-33-1), where [\[8\]](#page-33-8) introduced a general majorization minimization approach and [\[9\]](#page-33-1) considered a stochastic BPG with momentum updates. For the finite sum stochastic setting with n component functions, [\[26\]](#page-34-8) proposed a Finito/MISO type variance reduced BPG type method. However, only asymptotic convergence is provided and no clear dependence on  $n$  is discussed. With additional strong convexity assumption, [\[26\]](#page-34-8) further derived a linear convergence rate while still suffering a suboptimal  $O(n)$  dependence on the component functions. Neither of the two while sum suhering a suboptimal  $O(n)$  dependence on the component functions. Neither of the two<br>settings have achieved the desirable  $O(\epsilon^{-1.5})$  or  $O(\sqrt{n}\epsilon^{-1})$  complexity for variance reduced method. The key difficulty that prevents the existing results from exploiting the variance reduction techniques lies in the following dilemma: the current stochastic variance reduced methods explicitly require the gradient Lipschitz constant, while the considered problem class prevents such knowledge. As a result, a very natural question arises:

Q-1. For nonconvex composite stochastic optimization problems with general expectation or finite-sum structures, under the smooth adaptability assumption, is it possible to make the squared Bregman gradient mapping  $\epsilon$ -small (in expectation or with high probability) the squared Dregman gradient mapping e-sman (in expectation of with light probability)<br>with an  $O(\epsilon^{-1.5})$  or  $O(\sqrt{n}\epsilon^{-1})$  sample complexity? If possible, then what is the condition that facilitates such improvements?

To resolve this issue, we introduce a new *kernel conditioning* regularity assumption on the kernel function  $h$ , which has been overlooked in the existing the literature. Based on this condition, we introduce a simple mechanism that facilitates the analysis of most existing variance reduction techniques. Via a novel probabilistic analysis, we prove that there exists a high probability event  $A$ , conditioning on which the proposed methods output a point  $\bar{x}$  such that  $\mathbb{E}[\|\mathcal{G}^{\lambda}_{\phi,h}(\bar{x})\|^2|\mathcal{A}] \leq \epsilon$  within  $O(\epsilon^{-1.5})$  or Which the proposed methods output a point x such that  $\mathbb{E}[\mathbb{E}_{\phi,h}(\mathscr{L})] \mid \mathcal{A}$ <br> $O(\sqrt{n}\epsilon^{-1})$  samples for general expectation or finite sum settings, respectively.

Based on the above discussion, it **seems** that for both finite sum and general expectation settings, the variance reduced BPG type methods recover the optimal sample complexity of their counterparts for optimization problems with Lipschitz gradient. But is this claim really true? Recall that in our previous comment for deterministic setting, we also emphasized that the BPG methods only seemingly recovers the convergence rate of the optimal methods in problems with Lipschitz gradient. The reason for bringing up this doubt roots in the mismatch in the stationary measures:  $||G^{\lambda}_{\phi}(\cdot)||^2$  and  $||\mathcal{G}^{\lambda}_{\phi,h}(\cdot)||^2$ .

Although existing works argue that  $\mathcal{G}^{\lambda}_{\phi,h}(\cdot)$  recovers  $G^{\lambda}_{\phi}(\cdot)$  when  $h(\cdot)=(1/2)\|\cdot\|^2$ , it remains skeptical whether the two quantities are comparable for general kernel function  $h$ . This is the second question that we would like to address in this paper:

**Q-2.** Is the Bregman gradient mapping  $\mathcal{G}^{\lambda}_{\phi,h}(\cdot)$  an appropriate stationarity measure? If not, then which new quantity is suitable for measuring the convergence of BPG type methods and how can we analyze the convergence under this quantity?

Our answer to the qualification of  $\mathcal{G}_{\phi,h}^{\lambda}(\cdot)$  is mixed. When the objective function is has bounded level set and the level set is not too large compared to the distance between the initial point and the obtained  $\epsilon$ -stationary point, then (a scaled version of)  $\mathcal{G}^{\lambda}_{\phi,h}(\cdot)$  can be a suitable measure of stationarity. However, when the problem has an extremely large or even unbounded level set, using  $\mathcal{G}^{\lambda}_{\phi,h}(\cdot)$ to quantify convergence can be questionable. Suppose the component  $\phi = 0$  so that problem [\(1\)](#page-0-1) becomes differentiable, then  $G_{\phi}^{\lambda}(\cdot) = \nabla f(\cdot) = \nabla \Psi(\cdot)$  recovered the standard stationarity measure for differentiable nonconvex optimization problems. However, depending on where the decision variable  $x$ locates, the squared Bregman gradient mapping  $\|\mathcal{G}^{\lambda}_{\phi,h}(x)\|^2$  can be much smaller than  $\|\nabla\Psi(x)\|^2$ . For a counterexample with unbounded level set and objective value in this paper, one may even observe  $\|\mathcal{G}^{\lambda}_{\phi,h}(x_k)\|^2 \to 0$  while  $\|\nabla \Psi(x_k)\|^2 = 1$ . Therefore, to depict the general convergence behavior of the Bregman proximal gradient method and the stationarity of the output solution, we propose a new Bregman proximal gradient mapping

$$
\mathcal{D}_{\phi,h}^{\lambda}(x) := \frac{\nabla h(x) - \nabla h\big(\mathbf{T}_{\phi,h}^{\lambda}\big(x,\nabla f(x)\big)\big)}{\lambda}.
$$
\n(5)

It can be verified that  $\mathcal{D}^{\lambda}_{\phi,h}(\cdot) = \nabla \Psi(\cdot)$  when  $\phi = 0$ . For general convex non-differentiable  $\phi$ , we show that  $\|\mathcal{D}^{\lambda}_{\phi,h}(\cdot)\|$  shares the same magnitude of the standard stationarity measure dist $(0,\partial\Psi(\cdot)),$ where  $\partial \Psi(\cdot)$  denotes the set of limiting Fréchet subdifferential of  $\Psi$ . Denote Lev<sub>0</sub> := { $x \in \mathbb{R}^d$  :  $\Psi(x) \leq \Psi(x_0)$  the level set of the objective function and denote  $L_h(\mathcal{X})$  the Lipschitz constant of  $\nabla h$  in the compact set X. We show that the standard Bregman proximal gradient method with a novel adaptive step size control mechanism can find some  $\bar{x}$  s.t.  $\|\mathcal{D}^{\lambda}_{\phi,h}(\bar{x})\|^2 \leq \epsilon$  in a compact region  $\mathcal{X}_{\epsilon} := \text{Lev}_0 \cap B(x_0, R_{\epsilon}),$  where  $B(x_0, R_{\epsilon})$  stands for an L-2 ball with center  $x_0$  and radius  $R_{\epsilon} = O(\frac{1}{\sqrt{\epsilon}})$ . Consequently, regardless of the potential unboundedness of the level set Lev<sub>0</sub>, in the deterministic setting, we can guarantee an  $O(L_h(\mathcal{X}_{\epsilon})\epsilon^{-1})$  iteration complexity for the proposed method. Although  $L_h(\mathcal{X}_{\epsilon})$  may bring in additional  $\epsilon$ -dependence when Lev<sub>0</sub> is unbounded, we have constructed hard instance to show that such a dependence is tight and inevitable for Bregman proximal gradient methods. By carefully constructing the adaptive step size rules, we extend the above analysis to the stochastic setting and prove an  $\widetilde{O}(\sqrt{n}L_h(\mathcal{X}_{\epsilon})\epsilon^{-1})$  sample complexity for the finite-sum stochastic the stochastic setting and prove an  $\widetilde{O}(\sqrt{n}L_h(\mathcal{X}_{\epsilon})\epsilon^{-1})$ setting. As the extension to general expectation setting may require additional light-tail assumptions on the stochastic gradient estimators, we decide to skip this case in our paper.

Other related works. In this paragraph, we review a few works on convex optimization without globally Lipschitz gradients, which are related but not closely related to our paper. First, within the scope of BPG type methods, [\[30,](#page-34-2) [2\]](#page-33-7) were concurrently the first to propose the notion of relative smoothness (or smooth adaptability). They derived an  $O(1/T)$  sublinear convergence for general convex case and a linear convergence for strongly convex case, where the  $O(1/T)$  rate for general convex case is shown to be non-improvable by [\[11\]](#page-33-9). If the objective function satisfy a so-called triangle scaling property, [\[21\]](#page-34-0) further proposed an accelerated BPG method with improved rates. In [\[29,](#page-34-9) [20\]](#page-34-10), the authors discussed the sample complexity of stochastic BPG and its coordinate descent variant under (strong) convexity, while  $[10]$  studied the stochastic variance reduced BPG method for optimizing the average of n smooth functions and an optimal  $O(\sqrt{n})$  dependence on n has been obtained. However, [\[10\]](#page-33-10) relies on a very abstract technical assumption that is hard to verify and interpret. Beyond BPG type methods, [\[18,](#page-34-11) [19\]](#page-34-12) proposed a radial reformulation that transforms a convex function without Lipschitz gradient to an equivalent convex function with Lipschitz gradient, and [\[5,](#page-33-11) [13,](#page-33-12) [40\]](#page-35-4) proposed some Frank-Wolfe approaches based on additional self-concordance condition. Unlike the convex case where various different approaches may handle the non-Lipschitz gradient, the existing results for nonconvex optimization is rather limited. Besides the BPG approach that are already reviewed before, [\[22,](#page-34-13) [39\]](#page-35-5) proposed several (accelerated) gradient-based methods that require iteratively estimating the local gradient Lipschitz constant to determine the stepsize, which cannot handle the nonsmoothness of  $\phi$  and the stochasticity of f.

Organization. In Section [2,](#page-3-0) we start with introduce the some basic definitions and properties of the smooth adaptable functions, and then provide a thorough discussion on our kernel-conditioning regularity assumption and the new gradient mapping. In Section [3,](#page-8-0) we discuss how the kernel-conditioning regularity combined with a simple epoch bound mechanism can enable almost all the existing stochastic variance reduction schemes and provide the sample complexity analysis for bounding  $\|\mathcal{G}^{\lambda}_{\phi,h}(\cdot)\|^2$ under different settings. In Section [4,](#page-18-0) we propose novel adaptive step size control mechanisms for both deterministic and stochastic settings and analyze their convergence and complexities for bounding the new Bregman proximal gradient mapping  $||\mathcal{D}^{\lambda}_{\phi,h}(\cdot)||^2$ . Finally, we compare the complexity results under the old and new gradient mappings and then conclude the paper in Section [5.](#page-26-0)

**Notations.** For any set  $\mathcal{X}$ , we denote  $id_{\mathcal{X}}(\cdot)$  as the indicator function of the set. Namely,  $id_{\mathcal{X}}(x) = 0$ if  $x \in \mathcal{X}$  and  $\mathrm{id}_{\mathcal{X}}(x) = +\infty$  if  $x \notin \mathcal{X}$ . We denote the interior of  $\mathcal{X}$  as  $\mathrm{int}(\mathcal{X})$  and we denote the boundary of X as  $\partial X$ . We denote  $[n] := \{1, 2, \dots, n\}$ . Because many literature use the terminology L-smooth to denote L-Lipschitz continuity of the gradient, we will use "continuously differentiable" instead of "smooth" to avoid confusion.

## <span id="page-3-0"></span>2 Preliminary: kernel conditioning and gradient mapping

#### 2.1 Preliminary results

Before presenting the newly introduced kernel-conditioning regularity assumption and the new gradient mapping, let us provide a brief introduction to the basic concepts and properties of smooth adaptability and Bregman proximal gradient methods.

<span id="page-3-1"></span>**Assumption 2.1** (Smooth adaptability, [\[4\]](#page-33-0)). Let f and h be twice continuously differentiable in  $\mathbb{R}^d$ , and let h be strictly convex. Then we assume  $f$  is L-smooth adaptable to h for some positive constant  $L > 0$ . In other words, both  $L h + f$  and  $L h - f$  are convex functions.

Given the twice continuous differentiability of f and h, Assumption [2.1](#page-3-1) can be equivalently written as

$$
-L\nabla^2 h(x) \preceq \nabla^2 f(x) \preceq L\nabla^2 h(x), \ \forall x \in \mathbb{R}^d. \tag{6}
$$

As we consider the problem class where  $\nabla f$  is not globally Lipschitz continuous, then naturally, one would expect  $\|\nabla^2 f(x)\|$  and  $\|\nabla^2 h(x)\|$  to grow unbounded as  $\|x\| \to +\infty$ . A particularly interesting example that satisfies the smooth adaptability assumption is the function class with polynomially growing Hessian, as described below.

Proposition 2.2 (Proposition 2.1, [\[30\]](#page-34-2)). Suppose f is twice continuously differentiable function that satisfies  $\|\nabla^2 f(x)\| \leq p_r(\|x\|)$  for some r-degree polynomial  $p_r(\cdot)$ . Let L be such that  $p_r(\alpha) \leq L(1+\alpha^r)$ for  $\alpha \geq 0$ . Then the function f is L-smooth adaptable to  $h(x) := \frac{1}{2} ||x||^2 + \frac{1}{r+2} ||x||^{r+2}$ .

The polynomial kernel h is in fact 1-strongly convex over  $\mathbb{R}^d$ , and hence the Bregman proximal mapping  $\mathbf{T}_{\phi,h}^{\lambda}(\cdot)$  introduced in [\(3\)](#page-1-0) is unique and well-defined. Under smooth adaptability, a generalized descent lemma was derived in [\[4\]](#page-33-0), which is a key property for analyzing the BPG type algorithms.

<span id="page-3-2"></span>Lemma 2.3 (Extended descent lemma, [\[4\]](#page-33-0)). Suppose f and h satisfy Assumption [2.1](#page-3-1) for some constant  $L > 0$ , then for any  $\forall x, y \in \mathbb{R}^d$ , it holds that

$$
|f(x) - f(y) - \langle \nabla f(y), x - y \rangle| \leq LD_h(x, y).
$$

Similar versions of Assumption [2.1](#page-3-1) and Lemma [2.3](#page-3-2) are also established in [\[2,](#page-33-7) [30\]](#page-34-2). Next we discuss the regularity condition of the kernel function  $h$  that has been overlooked in the existing literature.

#### 2.2 Kernel conditioning

The general Bregman proximal gradient method aims to solve the problem min  $\{f(x) + \phi(x) : x \in \overline{C}\}\$ while requiring the kernel function h to satisfy dom $(h) = C$  and  $\mathbf{T}_{\phi,h}^{\lambda}(x,v) \subseteq C$  for any  $x \in C, v \in \mathbb{R}^d$ .

In this paper, we consider the case where  $C = \text{dom}(h) = \mathbb{R}^d$ , which is the most frequently considered case in BPG literature [\[4,](#page-33-0) [9,](#page-33-1) [16,](#page-34-4) [17,](#page-34-5) [28,](#page-34-3) [32\]](#page-34-1). Note that the standard BPG update [\(3\)](#page-1-0) requires solving the following subproblem (after adding a few constants) in each iteration:

$$
x_{k+1} = \mathbf{T}_{\phi,h}^{\lambda}(x_k, \nabla f(x_k)) = \underset{x \in \mathbb{R}^d}{\text{argmin}} \ f(x_k) + \langle \nabla f(x_k), x - x_k \rangle + \phi(x) + \lambda^{-1} D_h(x, x_k). \tag{7}
$$

To guarantee the update  $x_{k+1}$  to be well-defined, existing works typically requires h to be supercoercive, that is  $h(x)/||x|| \to +\infty$  as  $||x|| \to +\infty$ . For the unconstrained problem [\(1\)](#page-0-1) considered in this paper, such a requirement is commonly replaced by assuming h to be  $\mu$ -strongly convex for some constant  $\mu > 0$ , see [\[4,](#page-33-0) [9,](#page-33-1) [16,](#page-34-4) [17,](#page-34-5) [27,](#page-34-7) [28,](#page-34-3) [31,](#page-34-6) [36\]](#page-35-3) for example.

Though widely adopted by the current existing works, simply assuming  $h$  to be  $\mu$ -strongly convex has many issues. First, as shown in latter sections, such regularity condition is too weak to support the convergence of the new gradient mapping  $\|\mathcal{D}^{\lambda}_{\phi,h}(\cdot)\|^2$ . Instead, it is just sufficient to analyze the old gradient mapping  $\|\mathcal{G}^{\lambda}_{\phi,h}(\cdot)\|^2$ , which may fail to correctly characterize the convergence behavior of BPG method in many situations. Second, let  $\lambda_{\min}(\cdot)$  denote the minimum eigenvalue of a matrix, practical kernel functions such as the polynomial kernels often satisfy

<span id="page-4-0"></span>
$$
\limsup_{\|x\| \to +\infty} \lambda_{\min} (\nabla^2 h(x)) = +\infty \tag{8}
$$

which is much stronger than  $\mu$ -strong convexity. In fact, if one expect  $\lambda_{\min}(\nabla^2 f(x))$  to go to  $-\infty$  as  $||x|| \to +\infty$ , then [\(6\)](#page-3-3) immediately implies [\(8\)](#page-4-0). Therefore, to fully capture the regularity conditions of the kernel functions, we introduce the following kernel conditioning regularity assumption.

<span id="page-4-1"></span>**Assumption 2.4** (Kernel-conditioning). Let  $\mathcal{X} \subseteq \mathbb{R}^d$  be a compact set and let  $\kappa_h(\mathcal{X}) := \frac{L_h(\mathcal{X})}{\mu_h(\mathcal{X})}$  with

$$
\mu_h(\mathcal{X}) = \min_{x \in \mathcal{X}} \lambda_{\min}(\nabla^2 h(x)) \quad \text{and} \quad L_h(\mathcal{X}) = \max_{x \in \mathcal{X}} \lambda_{\max}(\nabla^2 h(x)).
$$

Then there exist positive constants  $\mu$ ,  $\delta$ ,  $\kappa_h^{\delta} > 0$  such that

$$
\inf_{x \in \mathbb{R}^d} \mu_h(x) \ge \mu \quad \text{and} \quad \sup_{\mathcal{X} \subseteq \mathbb{R}^d : \text{diam}(\mathcal{X}) \le \delta} \kappa_h(\mathcal{X}) \le \kappa_h^{\delta},
$$

where diam( $\mathcal{X}$ ) := sup{ $||x - y|| : x, y \in \mathcal{X}$ } denotes the diameter of the set  $\mathcal{X}$ .

Basically, Assumption [2.4](#page-4-1) inherits the global  $\mu$ -strong convexity assumption from the existing works. In addition, when both  $\lambda_{\min}(\nabla^2 h(x))$  and  $\lambda_{\max}(\nabla^2 h(x))$  go to  $+\infty$ , we assume the condition number of h to be bounded for any small enough set  $\mathcal{X}$ . Unlike the standard condition number that is often imposed on the objective function of a convex problem, we further require a uniformly bounded local condition number for the kernel function  $h$ , which, to the best of our knowledge, has not been considered yet. As an example, we show that the polynomial kernel satisfies this condition.

**Proposition 2.5.** Let  $h(x) = \frac{1}{2}||x||^2 + \frac{1}{r+2}||x||^{r+2}$  be the degree- $(r+2)$  polynomial kernel for some  $r \geq 1$ , then h is 1-strongly convex over  $\mathbb{R}^d$ . For  $\forall x \in \mathbb{R}^d$ , we have  $\kappa_h(x) \leq r+1$ . For  $\forall X \subseteq \mathbb{R}^d$ ,

$$
\text{diam}(\mathcal{X}) \leq \frac{1}{r} \cdot \max\left\{1, \min_{u \in \mathcal{X}} \|u\|\right\} \implies \kappa_h(\mathcal{X}) \leq 3r + 4,
$$

which further implies  $\kappa_h^{\delta} = 3r + 4$  for any  $\delta \leq 1/r$ .

*Proof.* First, by direct computation, we have  $\nabla^2 h(x) = (\|x\|^r + 1) \cdot I + r \|x\|^{r-2} \cdot xx^\top$ . For  $\forall x \in \mathbb{R}^d$ , we have  $\lambda_{\max}(\nabla^2 h(x)) = (r+1) \|x\|^r + 1$  and  $\lambda_{\min}(\nabla^2 h(x)) = \|x\|^r + 1$ . Therefore, it is straightforward to see that the kernel h is globally 1-strongly convex. For any  $x \neq 0$ ,

$$
\kappa_h(x) = \frac{\lambda_{\max}(\nabla^2 h(x))}{\lambda_{\min}(\nabla^2 h(x))} = \frac{(r+1)\|x\|^r + 1}{\|x\|^r + 1} \le \frac{(r+1)\|x\|^r}{\|x\|^r} = r+1.
$$

For  $x = 0$ ,  $\kappa_h(0) = 1$ . Overall, we prove that  $\kappa_h(x) \leq r+1$  for  $\forall x \in \mathbb{R}^d$ . Second, for any non-singleton compact set  $\mathcal{X} \subseteq \mathbb{R}^n$  s.t.  $\text{diam}(\mathcal{X}) \leq \delta$ , let  $y \in \text{argmax}_{u \in \mathcal{X}} ||u||$  and  $x \in \text{argmin}_{u \in \mathcal{X}} ||u||$ , then

<span id="page-4-2"></span>
$$
\kappa_h(\mathcal{X}) = \frac{\lambda_{\max}(\nabla^2 h(y))}{\lambda_{\min}(\nabla^2 h(x))} = \frac{(r+1)\|y\|^r + 1}{\|x\|^r + 1} \le \frac{(r+1)(\|x\| + \delta)^r + 1}{\|x\|^r + 1}.
$$

Set  $\kappa_h^{\delta} = \sup \left\{ \frac{(r+1)(t+\delta)^r + 1}{t^r + 1} \right\}$  $t^{(t+\delta)^r+1}_{t^r+1}$  :  $t \ge 0$ , we upper bound this supremum as follows. First, if  $t \ge r\delta$ , then

$$
\frac{(r+1)(t+\delta)^r + 1}{t^r + 1} = \frac{(r+1)(1+\delta/t)^r + t^{-r}}{1+t^{-r}}
$$
  
 
$$
\leq (r+1)(1+1/r)^r + \frac{t^{-r}}{1+t^{-r}} \leq 3r + 4,
$$

where the last inequality applies the fact that  $(1 + 1/r)^r \le e < 3$ ,  $\forall r > 0$ , indicating  $\kappa_h(\mathcal{X}) \le 3r + 4$ when  $\text{diam}(\mathcal{X}) \leq \frac{\min_{u \in \mathcal{X}} ||u||}{r}$ . On the other hand, if  $0 \leq t \leq r\delta$  and  $\delta \leq 1/r$ , then we have

$$
\frac{(r+1)(t+\delta)^r + 1}{t^r + 1} \le (r+1)(1+1/r)^r + 1 \le 3r + 4.
$$

Combining the above two cases proves the result.

#### 2.3 A new Bregman proximal gradient mapping

Before discussing the appropriate definition of the gradient mapping in BPG methods, let us first introduce a handy lemma to characterize the property of the Bregman proximal mapping  $\mathbf{T}_{\phi,h}^{\lambda}(\cdot)$ , and then discuss why the existing Bregman proximal gradient mapping  $\mathcal{G}^{\lambda}_{\phi,h}(\cdot)$  may not properly capture the convergence behavior of BPG method. Finally, we establish a few properties of the new Bregman proximal gradient mapping  $\mathcal{D}^{\lambda}_{\phi,h}(\cdot)$  that we propose in this paper.

<span id="page-5-0"></span>**Lemma 2.6.** For any point  $x \in \mathbb{R}^d$  and any update direction direction  $v \in \mathbb{R}^d$ , denote  $x^+_{\lambda} := \mathbf{T}^{\lambda}_{\phi,h}(x,v)$ the output of the Bregman proximal mapping. Denote  $[x, x_\lambda^+]$  the line segment between  $x_\lambda^+$  and x, then there exists a subgradient vector  $u \in \partial \phi(x_{\lambda}^+)$  such that

$$
\mu_h([x, x_{\lambda}^+]) \cdot \|x - x_{\lambda}^+ \| \le \lambda \|v + u\| \le L_h([x, x_{\lambda}^+]) \cdot \|x - x_{\lambda}^+ \|,
$$
  

$$
\sqrt{2\mu_h([x, x_{\lambda}^+]) \cdot D_h(x_{\lambda}^+, x)} \le \lambda \|v + u\| \le \sqrt{2L_h([x, x_{\lambda}^+]) \cdot D_h(x_{\lambda}^+, x)}.
$$

In particular, when  $\phi = 0$  and  $v = \nabla f(x) = \Psi(x)$ , we have  $\mu_h([x, x_\lambda^+]) \leq \frac{\|\nabla \Psi(x)\|}{\|G_{\lambda}^{\lambda} f(x)\|}$  $\frac{\|\nabla\Psi(x)\|}{\|\mathcal{G}^\lambda_{\phi,h}(x)\|} \leq L_h([x,x_\lambda^+]),$ indicating that  $\|\mathcal{G}_{\phi,h}^{\lambda}(\cdot)\|^2$  can be much smaller than the standard stationarity measure  $\|\nabla\Psi(\cdot)\|^2$ .

*Proof.* By the optimality condition of the subproblem  $x_{\lambda}^{+} = \operatorname{argmin}_{y \in \mathbb{R}^{d}} y^{\top} v + \phi(y) + \frac{1}{\lambda} D_{h}(y, x)$ , we have  $0 \in \partial \phi(x_\lambda^+) + v + \frac{1}{\lambda} \cdot \nabla_y^2 D_h(y, x)|_{y=x_\lambda^+}$ . That is, there exists a vector  $u \in \partial \phi(x_\lambda^+)$  such that

$$
\lambda(v+u) + (\nabla h(x_\lambda^+) - \nabla h(x)) = 0.
$$
\n(9)

Then [\[33,](#page-34-14) Theorem 2.1.9] indicates that

$$
\mu_h([x,x_\lambda^+]) \cdot \|x - x_\lambda^+\| \le \|\nabla h(x_\lambda^+) - \nabla h(x)\| \le L_h([x,x_\lambda^+]) \cdot \|x - x_\lambda^+\|.
$$

Combining this bound with equation [\(9\)](#page-4-2) proves the first inequality of Lemma [2.6.](#page-5-0) Also observe that  $\nabla_y^2 D_h(y, x) = \nabla^2 h(y)$ , we have

$$
\mu_h([x, x_\lambda^+]) \cdot I \preceq \nabla_y^2 D_h(y, x) \preceq L_h([x, x_\lambda^+]) \cdot I \quad \text{for} \quad \forall y \in [x, x_\lambda^+].
$$

Combined with the fact that  $\nabla_y D_h(y, x)|_{y=x} = 0$ , then [\[33,](#page-34-14) Theorem 2.1.5, Eq.(2.1.10)] and [33, Theorem 2.1.10, Eq.(2.1.24)] immediately indicates

$$
\frac{\left\|\nabla_y D_h(y,x)\right\|_{y=x_\lambda^+}\right\|^2}{2L_h([x,x_\lambda^+])} \le D_h(x_\lambda^+,x) - D_h(x,x) \le \frac{\left\|\nabla_y D_h(y,x)\right\|_{y=x_\lambda^+}\right\|^2}{2\mu_h([x,x_\lambda^+])}.
$$

Then substituting  $D_h(x, x) = 0$  and  $\lambda(v + u) = \nabla h(x) - \nabla h(x^+_{\lambda}) = -\nabla_z D_h(z, x) \big|_{z = x^+_{\lambda}}$  to the above bound proves the second inequality of Lemma [2.6.](#page-5-0)  $\Box$ 

## 2.3.1 The issues of the current Bregman proximal gradient mapping  $\mathcal{G}^{\lambda}_{\phi,h}(\cdot)$

Based on Lemma [2.6,](#page-5-0) we re-evaluate the qualification of  $\mathcal{G}^{\lambda}_{\phi,h}(\cdot)$  as a stationarity measure. Consider problem [\(1\)](#page-0-1) with  $\phi = 0$  and f being L-smooth adaptable to h. Then  $\Psi = f$  is continuously differentiable and the most natural stationarity measure should be  $\nabla \Psi(\cdot)$ . In the existing analysis of the BPG update  $x_{k+1} = \mathbf{T}_{\phi,h}^{\lambda}(x_k, \nabla f(x_k))$ , setting  $\lambda \leq 1/L$  and denoting  $\Delta_{\Psi} := \Psi(x_0) - \inf_x \Psi(x)$ , the typical convergence analyses in the existing works rely on establishing  $\sum_{k=0}^{T-1} D_h(x_{k+1}, x_k) \leq \frac{\Delta_{\Psi}}{1/\lambda - L}$ , see e.g. [\[4,](#page-33-0) Proposition 4.1]. Note that  $\|\mathcal{G}_{\phi,h}^{\lambda}(x_k)\|^2 = \frac{1}{\lambda^2} \|x_{k+1} - x_k\|^2$  in this case, the  $\mu$ -strong convexity of h indicates an  $O(1/T)$  convergence of the squared Bregman proximal gradient mapping

<span id="page-6-1"></span>
$$
\min_{0 \le k \le T-1} \|\mathcal{G}^{\lambda}_{\phi,h}(x_k)\|^2 \le \frac{2\Delta_{\Psi}}{T\mu\lambda(1-\lambda L)} = O\left(\frac{1}{T}\right).
$$

To evaluate the stationarity of BPG iterations in terms of  $\|\nabla\Psi(\cdot)\|^2$ , we set  $x = x_k$ ,  $x_{\lambda}^+ = x_{k+1}$ ,  $u = 0$ and  $v = \nabla f(x_k) = \nabla \Psi(x_k)$  to Lemma [2.6,](#page-5-0) then the summability of  $D_h(x_k, x_{k+1})$  indicates that

$$
\sum_{k=0}^{T-1} \|\nabla\Psi(x_k)\|^2 \le \frac{2}{\lambda^2} \sum_{k=0}^{T-1} L_h([x_k, x_{k+1}]) D_h(x_{k+1}, x_k) \le \max_{0 \le k \le T-1} \{L_h([x_k, x_{k+1}])\} \frac{2\Delta_{\Psi}}{\lambda(1 - \lambda L)}
$$
(10)  

$$
\implies \min_{0 \le k \le T-1} \|\nabla\Psi(x_k)\|^2 \le \frac{\max_{0 \le k \le T-1} \{L_h([x_k, x_{k+1}])\}}{T} \cdot \frac{2\Delta_{\Psi}}{\lambda(1 - \lambda L)}.
$$

Hence, the actual convergence rate of  $\|\nabla \Psi(x_k)\|^2$  should also rely on the growth rate of  $L_h([x_k, x_{k+1}]),$ which can be extremely bad in the worst case. We present such a worst-case instance in Example [1.](#page-6-0)

<span id="page-6-0"></span>**Example 1.** Let  $r \geq 4$  be an even integer, consider  $\min_{x \in \mathbb{R}^2} \Psi(x) = f(x) + \phi(x)$ , with  $\phi = 0$  and  $f(x_1, x_2) = \frac{1}{\sqrt{2} + \ln(1)}$  $\frac{1}{2+\ln(1+x_1^2)}+x_1^rx_2^2$ , then the following arguments hold: (1).  $\exists L \ge 1 \text{ s.t. } f \text{ is } L\text{-smooth adaptable to } h(x) := \frac{1}{2} ||x||^2 + \frac{1}{r+2} ||x||^{r+2} \text{ and } L_h(x) = O(||x||^r).$ (2). For  $\forall \epsilon < 8/r^2$  and  $\forall |x_1| \geq 1, x_2 \in \mathbb{R}$ , if  $\|\nabla \Psi(x)\|^2 \leq \epsilon$ , then one must have  $|x_1| \geq \Omega\left(\frac{1}{\sqrt{\epsilon} \ln^2 \epsilon^{-1}}\right)$ . (3). Let  $\{(x_1^k, x_2^k)\}\$ be generated by the BPG method with some  $\lambda < 1/L$  and  $(x_1^0, x_2^0) = (1, 0)$ . Then

it can be proved that  $x_1^k \nearrow +\infty$  and  $\|\nabla \Psi(x_1^T, x_2^T)\| \geq \tilde{\Omega}(T^{-\frac{1}{d+2}}), \forall T \geq 0$ .

The proof of the claims in Example [1](#page-6-0) is relegated to the Appendix [E.](#page-32-0) For this hard instance, it can be observed that  $(0, x_2)$ ,  $\forall x_2$  are all local maximum points. To minimize  $\Psi$ , one would like to find stationary points that are away from  $x_1 = 0$  $x_1 = 0$  $x_1 = 0$ . Suppose one starts from  $(1, 0)$ , then Example 1 reveals the following issues in the current gradient mapping and analysis:

- The convergence rate of BPG method in terms of  $\|\nabla\Psi(\cdot)\|^2$  is at most  $O(1/T^{\frac{1}{d+2}})$ , which is a significant mismatch with the  $O(1/T)$  converge rate in terms of  $\|\mathcal{G}^{\lambda}_{\phi,h}(\cdot)\|^2$ . In other words,  $\mathcal{G}_{\phi,h}^{\lambda}(\cdot)$  does not correctly characterize the convergence behavior of BPG method.
- $\bullet$  A second issue of the existing analysis is that solely  $(10)$  does not directly imply the convergence of  $\|\nabla \Psi(x_k)\|^2$ . Indeed, Example [1](#page-6-0) implies that  $L_h([x_k, x_{k+1}]) \to +\infty$  as  $k \to \infty$ . However, the existing analysis cannot determine whether  $\frac{\max_{0 \le k \le T-1} \{L_h([x_k,x_{k+1}])\}}{T}$  converges to 0 or not. Instead, the existing works hide this issue by assuming the level set  $Levo<sub>0</sub>$  to be compact. And then one may upper bound all  $L_h([x_k, x_{k+1}])$  with  $L_h(\text{Lev}_0)$ .
- Let  $T_{\epsilon}$  be the first time an  $\epsilon$ -stationary point is obtained. Then even if Lev<sub>0</sub> is assumed to be compact,  $L_h(\text{Lev}_0)$  can still be much larger than  $L_h([x_k, x_{k+1}]),$  for  $\forall k \leq T_{\epsilon}-1$ . In fact, the very motivation for [\[30\]](#page-34-2) to propose the notion of relative smoothness is to avoid such a pessimistic upper bound of Lipschitz constants.

Note that the above points only question the convergence and the convergence rate of of the current gradient mapping analysis for BPG. An additional issue is that  $\mathcal{G}^{\lambda}_{\phi,h}(x_k) \to 0$  does not necessarily imply  $\nabla \Psi(x_k) \to 0$  when the problem has unbounded level set, as illustrated by Example [2.](#page-6-2)

<span id="page-6-2"></span>**Example 2.** Let  $r \geq 4$  be an even integer, consider  $\min_{x \in \mathbb{R}} \Psi(x) := f(x) + \phi(x)$  with  $f(x) = -x$  and  $\phi(x) = 0$ . Then f is 1/2-smooth adaptable to  $h(x) := \frac{1}{r}x^r$ . Starting from  $x_0 = 0$  and take  $\lambda = 1$ , then the BPG method [\(3\)](#page-1-0) produces a iteration sequence with closed-form formula  $x_k = k^{\frac{1}{r-1}}$ ,  $k \geq 0$ . In this case, it can be shown that  $\|\mathcal{G}^{\lambda}_{\phi,h}(x_k)\|^2 = O\left(k^{-2+\frac{2}{r-1}}\right) \to 0$  while  $\nabla \Psi(x_k) \equiv -1$ .

Given this example, if the problem happens to be unbounded and the unboundedness is agnostic to the user, then using  $\|\mathcal{G}_{\phi,h}^{\lambda}(\cdot)\|^2$  to measure convergence may falsely report the near-stationarity of the iterations. Therefore, introducing a new gradient mapping that can correctly characterize the stationarity of the solutions can be crucial.

## 2.3.2 Properties of the new Bregman proximal gradient mapping  $\mathcal{D}^{\lambda}_{\phi,h}(\cdot)$

To correctly characterize the stationarity, one should first review the properties of the Bregman proximal mapping  $\mathbf{T}_{\phi,h}^{\lambda}(x,\nabla f(x))$ . With  $v = \nabla f(x)$  and  $\phi = 0$ , [\(9\)](#page-4-2) indicates that

$$
\lambda \nabla f(x) + \left( \nabla h\big(\mathbf{T}^{\lambda}_{\phi,h}\big(x, \nabla f(x)\big)\big) - \nabla h(x) \right) = 0.
$$

Slightly rearranging the terms yields

$$
\mathcal{D}^{\lambda}_{\phi,h}(x) := \frac{\nabla h(x) - \nabla h(\mathbf{T}^{\lambda}_{\phi,h}\big(x,\nabla f(x)\big)\big)}{\lambda} = \nabla f(x) = \nabla \Psi(x).
$$

Therefore, when encountering bad instances such as Example [2,](#page-6-2) the new gradient mapping  $\mathcal{D}^{\lambda}_{\phi,h}(\cdot)$ will never falsely report the near-stationarity of solutions. A second advantage of the new gradient mapping is that, regardless of the selection of kernel h, the new gradient mapping  $\mathcal{D}^{\lambda}_{\phi,h}(x)$  always recovers the standard stationarity measure  $\nabla \Psi(x)$ , while the old gradient mapping  $\mathcal{G}^{\lambda}_{\phi,h}(x)$  may depend on h. Still consider the Example [2](#page-6-2) with a fixed solution  $x = 10$  and  $\lambda = 1$ . Then direct computation gives  $\|\mathcal{G}^{\lambda}_{\phi,h}(10)\| \leq \frac{1}{(r-1)10^{r-1}}$ , indicating  $\|\mathcal{G}^{\lambda}_{\phi,h}(10)\| \leq 10^{-3}$  if  $r = 4$  and  $\|\mathcal{G}^{\lambda}_{\phi,h}(10)\| \leq$  $10^{-9}$  if  $r = 10$ , which shows that improperly selecting the kernel function h may also significantly influence the old gradient mapping.

When  $\phi \neq 0$  can be a general non-differentiable convex function, we need to further introduce the concept of a limiting Fréchet subdifferential for a non-convex and non-differentiable function  $\Psi$ .

**Definition 2.7** (Limiting Fréchet subdifferential [\[25\]](#page-34-15)). Let  $\Psi$  be a lower semicontinuous function that is potentially non-convex. A vector u is said to be a Fréchet subgradient of  $\Psi$  at  $x \in dom(\Psi)$  if

$$
\Psi(x + \Delta x) \ge \Psi(x) + u^\top \Delta x + o(\|\Delta x\|).
$$

The set of Fréchet subgradient of  $\Psi$  at x is called the Fréchet subdifferential and is denoted as  $\partial \Psi(x)$ . Then the limiting Fréchet subdifferential denoted by  $\partial \Psi(x)$  is defined as

$$
\partial \Psi(x) = \{v : \text{there } \exists x_k \to x \text{ and } v_k \in \hat{\partial} \Psi(x_k) \text{ s.t. } v_k \to v\}.
$$

It is known that  $\partial \Psi(\cdot) = {\nabla \Psi(\cdot)}\}$  when  $\Psi$  is differentiable, and  $\partial \Psi(\cdot)$  equals the set of convex subgradients when  $\Psi$  is convex and non-differentiable. For our considered setting where  $\Psi = f + \phi$ , with f being differentiable and  $\phi$  being convex non-differentiable, it is known that  $\partial \Psi(\cdot) = \nabla f(\cdot) + \partial \phi(\cdot)$ . Then for our problem setting, the standard stationarity measure should be  $dist^2(0, \partial \Psi(\cdot))$ , which is a natural generalization of  $\|\nabla\Psi(\cdot)\|^2$  to non-differentiable problems, see e.g. [\[12\]](#page-33-13). Based on the notion of limiting Fr´echet subdifferential and the newly proposed kernel-conditioning regularity (Assumption [2.4\)](#page-4-1), the next lemma demonstrates the ability of  $\mathcal{D}^{\lambda}_{\phi,h}(\cdot)$  to capture the near-stationarity of solutions.

<span id="page-7-0"></span>**Lemma 2.8.** Suppose Assumption [2.1](#page-3-1) and [2.4](#page-4-1) hold. For any  $x \in \mathbb{R}^d$  and  $\lambda > 0$ , if

 $||x - x_{\lambda}^+|| \le \delta$  and  $||\mathcal{D}^{\lambda}_{\phi,h}(x)||^2 \le \epsilon$ ,

where  $x^+_{\lambda} = \mathbf{T}^{\lambda}_{\phi,h}(x,\nabla f(x))$ , then  $\text{dist}^2(0,\partial\Psi(x^+_{\lambda})) \leq (1 + L\lambda \kappa^{\delta}_{h})^2 \cdot \epsilon$ .

*Proof.* By [\(9\)](#page-4-2), there exists  $u \in \partial \phi(x_{\lambda}^+)$  such that  $\|\nabla f(x) + u\| = \|\mathcal{D}_{\phi,h}^{\lambda}(x)\| \leq \sqrt{\epsilon}$ . On the other hand, by Assumption [2.1,](#page-3-1) we have  $L_f([x,x_\lambda^+]) \leq L \cdot L_h([x,x_\lambda^+])$ , which further indicates that

$$
\|\nabla f(x_{\lambda}^{+}) - \nabla f(x)\| \le L \cdot L_h([x, x_{\lambda}^{+}]) \cdot \|x - x_{\lambda}^{+}\|
$$
  

$$
\le \frac{L \cdot L_h([x, x_{\lambda}^{+}])}{\mu_h([x, x_{\lambda}^{+}])} \cdot \|\nabla h(x) - \nabla h(x_{\lambda}^{+})\| \le L\kappa_h^{\delta} \cdot \lambda \|\mathcal{D}_{\phi,h}^{\lambda}(x)\| \le L\lambda \kappa_h^{\delta} \sqrt{\epsilon},
$$

where the second last inequality is due to Assumption [2.4.](#page-4-1) With  $\nabla f(x_\lambda^+) + u \in \partial \Psi(x_\lambda^+)$ , we have

$$
\begin{array}{rcl}\n\text{dist}\big(0,\partial\Psi(x_{\lambda}^{+})\big) & \leq & \|\nabla f(x_{\lambda}^{+}) + u\| \\
& \leq & \|\nabla f(x) + u\| + \|\nabla f(x_{\lambda}^{+}) - \nabla f(x)\| \\
& \leq & \left(1 + L\lambda\kappa_h^{\delta}\right) \cdot \sqrt{\epsilon},\n\end{array}
$$

which proves the lemma.

<span id="page-8-3"></span>**Remark 2.9.** For any  $\epsilon > 0$ , suppose we say a point  $\bar{x}$  is an  $\epsilon$ -stationary point if  $dist^2(0, \partial \Psi(\bar{x})) \leq \epsilon$ . Then Lemma [2.8](#page-7-0) indicates that, if  $\|\mathcal{D}^{\lambda}_{\phi,h}(x)\|^2 \leq \epsilon$  and  $\|x - x^+_{\lambda}\| \leq \delta$ , then  $x^+_{\lambda}$  is an  $\hat{O}(\epsilon)$ -stationary point, where  $O(\cdot)$  only hides the constant  $(1+L\lambda\kappa_h^{\delta})^2$ . In contrast, for the current widely used Bregman proximal gradient mapping, we only have

$$
\|\mathcal{G}_{\phi,h}^{\lambda}(x)\|^2 \leq \epsilon \quad \Longrightarrow \quad \text{dist}^2\big(0, \partial \Psi(x_\lambda^+)\big) \leq (1 + L\lambda)^2 \cdot L_h^2\big([x, x_\lambda^+]\big) \cdot \epsilon
$$

where the quantity  $L_h^2([x,x_\lambda^+])$  is unbounded over  $\mathbb{R}^d$  and hence cannot be hidden in  $O(\cdot)$ . Therefore, having  $\|\mathcal{G}^{\lambda}_{\phi,h}(\cdot)\|^2 \leq \epsilon$  does not indicate the  $O(\epsilon)$ -stationarity of the solution. Moreover, for general non-differentiable convex function  $\phi \neq 0$ , taking  $v = \nabla f(x)$  in Lemma [2.6](#page-5-0) also yields

$$
\mu_h([x, x_\lambda^+]) \le \frac{\|\mathcal{D}_{\phi,h}^\lambda(x)\|}{\|\mathcal{G}_{\phi,h}^\lambda(x)\|} \le L_h([x, x_\lambda^+]).\tag{11}
$$

That is,  $\|\mathcal{G}_{\phi,h}^{\lambda}(\cdot)\|$  can be much smaller than the new Bregman proximal mapping  $\|\mathcal{D}_{\phi,h}^{\lambda}(\cdot)\|$ .

## <span id="page-8-0"></span>3 Enabling variance reduction via kernel conditioning

As discussed later in Section [5,](#page-26-0) when the level set is compact and is not too large in certain sense, the convergence rate provided by analyzing the old Bregman proximal gradient mapping  $\mathcal{G}^{\lambda}_{\phi,h}(\cdot)$  can still be comparable to the rate obtained by analyzing the new gradient mapping  $\mathcal{D}^{\lambda}_{\phi,h}(\cdot)$ . In addition, most existing works on BPG methods are analyzing convergence of the old gradient mapping  $\mathcal{G}^{\lambda}_{\phi,h}(\cdot)$ . Therefore, it is still meaningful to study the convergence in terms of the old gradient mapping. In this section, we would like to discuss how the kernel-conditioning regularity assumption can enable the general variance reduction techniques. In particular, combined with a novel probabilistic argument, we provide a simple epoch bound mechanism that can facilitate most episodic stochastic variance reduction techniques such as SVRG [\[23\]](#page-34-16), SPIDER [\[14\]](#page-33-4), SARAH and ProxSARAH [\[35\]](#page-35-1), etc., with improved sample complexities.

In the following subsections, we start with a simple approach that solves the finite-sum stochastic setting of problem [\(1\)](#page-0-1) with large  $O(\sqrt{n})$  batches. In Section [3.1,](#page-8-1) we illustrate the basic techniques and ideas through this approach due to its simplicity. Next, in Sections [3.2](#page-13-0) and [3.3,](#page-17-0) we provide more complicated improved algorithms that handle both finite-sum and general expectation settings with arbitrary batch sizes and improved success probabilities, respectively.

#### <span id="page-8-1"></span>3.1 Finite-sum stochastic setting with  $O($ √  $\overline{n})$  batch size

In this section, we consider problem [\(1\)](#page-0-1) with  $f(x) = \frac{1}{n} \sum_{i=1}^{n} f_i(x)$ . For this setting, we adopt the following variant of the smooth adaptability assumption.

<span id="page-8-2"></span>**Assumption 3.1.** For each  $i \in [n]$ ,  $f_i$  is  $L_i$ -smooth adaptable to h for some positive constant  $L_i > 0$ . For notational simplicity, denote  $L := \sqrt{\frac{1}{n} \sum_{i=1}^{n} L_i^2}$ , then f is L-smooth adaptable to h.

To exploit the finite-sum structure, we propose a stochastic variance reduced BPG method with epoch-wise bounds, as stated in Algorithm [1.](#page-9-0) In each epoch of this algorithm, based on the radius  $\delta$ defined in the kernel conditioning regularity (Assumption [2.4\)](#page-4-1), we impose an additional set constraint  $x \in \mathcal{X}_s$  in which the kernel h has limited condition number. With this simple mechanism, one can input any episodic variance reduced gradient estimator in place of  $(12)$ . In this subsection, we use the SARAH/Spider estimator with  $O(\sqrt{n})$  batch size for illustration.

Algorithm 1: Stochastic variance reduced BPG method with epoch bounds

First of all, let us define the true restricted Bregman proximal gradient mapping in epoch-s as

<span id="page-9-3"></span><span id="page-9-2"></span>
$$
\mathcal{G}^{\lambda}_{\phi + \mathrm{id}_{\mathcal{X}_s,h}}(x_{s,k}) := \frac{x_{s,k} - \hat{x}_{s,k+1}}{\lambda} \quad \text{with} \quad \hat{x}_{s,k+1} := \mathbf{T}^{\lambda}_{\phi + \mathrm{id}_{\mathcal{X}_s,h}}(x_{s,k}, \nabla f(x_{s,k})). \tag{14}
$$

Note that we add the indicator function  $id_{\mathcal{X}_s}$  to  $\phi$  to restrict all the updates within the region  $\mathcal{X}_s$ . For this restricted gradient mapping, the following lemma holds true.

<span id="page-9-6"></span>**Lemma 3.2.** Let  $\mathcal{G}^{\lambda}_{\phi+\text{id}_{\mathcal{X}_s,h}}(x_{s,k})$ ,  $\hat{x}_{s,k+1}$  and  $x_{s,k+1}$  be defined by [\(14\)](#page-9-2) and [\(13\)](#page-9-3), respectively. Then

<span id="page-9-7"></span>
$$
\left\|\mathcal{G}^{\lambda}_{\phi+\mathrm{id}_{\mathcal{X}_s},h}(x_{s,k})\right\|^2 \le \frac{2\|x_{s,k}-x_{s,k+1}\|^2}{\lambda^2} + \frac{2\|v_{s,k}-\nabla f(x_{s,k})\|^2}{\mu_h^2(\mathcal{X}_s)}.\tag{15}
$$

As the proof of this lemma is very standard, it is relegated to Appendix [B.](#page-27-0) Given this lemma, we can obtain the following descent result. Different from the standard descent result for stochastic BPG methods such as  $[9]$ , we need to keep the descent both in terms of the true restricted gradient mapping  $||\mathcal{G}^{\lambda}_{\phi+\mathrm{id}_{\mathcal{X}_s},h}(x_{s,k})||^2$  and the Bregman divergence term  $D_h(x_{s,k+1},x_{s,k})$ .

<span id="page-9-4"></span>**Lemma 3.3.** Let  $\{x_{s,k}\}_{k=0}^{\tau}$  be the s-th epoch of Algorithm [1.](#page-9-0) Then we have

$$
\Psi(x_{s,k+1}) \leq \Psi(x_{s,k}) - \frac{\lambda \mu_h(\mathcal{X}_s)}{8} \left\| \mathcal{G}^{\lambda}_{\phi + \mathrm{id}_{\mathcal{X}_s},h}(x_{s,k}) \right\|^2 - \left(\frac{1}{\lambda} - L\right) D_h(x_{s,k+1}, x_{s,k}) + \frac{5\lambda \|\mathcal{E}_{s,k}\|^2}{4\mu_h(\mathcal{X}_s)}
$$

where  $\mathcal{E}_{s,k} = \nabla f(x_{s,k}) - v_{s,k}$  denotes the gradient estimation error at  $x_{s,k}$ .

The proof of Lemma [3.3](#page-9-4) is relegated to Appendix [B.](#page-27-0) Next, we bound the error term  $\|\mathcal{E}_{s,k}\|^2$ , whose proof is kept in the main paper to illustrate how kernel conditioning affects the variance bounds.

<span id="page-9-5"></span>**Lemma 3.4.** Let  $\{x_{s,k}\}_{k=0}^{\tau}$  be the s-th epoch of Algorithm [1.](#page-9-0) Given any batch size  $b > 0$ , if we set  $|\mathcal{B}_{s,k}| = b$  for  $k = 1, \dots, \tau - 1$ . Then conditioning on the initial point  $x_{s,0}$  of the epoch, we have

$$
\mathbb{E}\left[\frac{\|\mathcal{E}_{s,k}\|^2}{\mu_h(\mathcal{X}_s)}\,\bigg|\,x_{s,0}\right] \leq \frac{2L^2(\kappa_h^{\delta})^2}{b} \cdot \sum_{j=1}^k \mathbb{E}\left[D_h(x_{s,j},x_{s,j-1})\mid x_{s,0}\right].
$$

Proof. By standard analysis of the SARAH/SPIDER estimator, see e.g. [\[34,](#page-34-17) Lemma 1], then it is not hard to obtain  $\mathbb{E} \left[ \|\mathcal{E}_{s,k}\|^2 \mid x_{s,0} \right] = \frac{1}{b} \sum_{j=1}^k \mathbb{E} \left[ \left\| \nabla f_{\xi}(x_{s,j}) - \nabla f_{\xi}(x_{s,j-1}) \right\| \right]$  $2 \mid x_{s,0}$ . Note that for any  $\xi \in [n]$ , Assumption [3.1](#page-8-2) indicates that  $\nabla f_{\xi}$  is  $L_{\xi} \cdot L_h(\mathcal{X}_s)$ -Lipschitz continuous in  $\mathcal{X}_s$ , as a result,

$$
\mathbb{E}\left[\frac{\|\mathcal{E}_{s,k}\|^2}{\mu_h(\mathcal{X}_s)}\middle| x_{s,0}\right] \leq \sum_{j=1}^k \frac{\left(\frac{1}{n}\sum_{\xi=1}^n L_{\xi}^2\right) \cdot L_h^2(\mathcal{X}_s)}{\mu_h(\mathcal{X}_s) \cdot b} \cdot \mathbb{E}\left[\|x_{s,j} - x_{s,j-1}\|^2 \mid x_{s,0}\right]
$$
  

$$
\leq \frac{\left(\frac{1}{n}\sum_{h=1}^n (\mathcal{X}_s)\right)}{\mu_h^2(\mathcal{X}_s)} \cdot \sum_{j=1}^k \frac{2L^2}{b} \cdot \mathbb{E}\left[D_h(x_{s,j}, x_{s,j-1}) \mid x_{s,0}\right]
$$
  

$$
\leq \frac{\left(\frac{1}{n}\sum_{h=1}^n (\mathcal{X}_s)\right)^2}{b} \cdot \sum_{j=1}^k \mathbb{E}\left[D_h(x_{s,j}, x_{s,j-1}) \mid x_{s,0}\right],
$$
 (16)

where (i) is due to Lemma [2.6](#page-5-0) and (ii) is due to Assumption [2.4.](#page-4-1) Hence we complete the proof.  $\Box$ 

Combining Lemma [3.3](#page-9-4) and [3.4](#page-9-5) and taking expectation yields the following lemma, the proof of which is relegated to Appendix [B.](#page-27-0)

<span id="page-10-1"></span>**Lemma 3.5.** Suppose we set  $|\mathcal{B}_{s,k}| = b = \tau = \lceil \sqrt{n} \rceil$ ,  $\forall s,k \geq 1$ . Then taking  $\lambda \leq \frac{1}{(2\kappa_h^{\delta}+1)L}$  yields

<span id="page-10-2"></span>
$$
\frac{1}{S\tau}\sum_{s=1}^S\sum_{k=0}^{\tau-1}\mathbb{E}\left[\frac{\mu_h(\mathcal{X}_s)}{8}\big\|\mathcal{G}^{\lambda}_{\phi+\mathrm{id}_{\mathcal{X}_s},h}(x_{s,k})\big\|^2+\frac{3\kappa_h^{\delta}L}{4\lambda}D_h(x_{s,k+1},x_{s,k})\right]\leq \frac{\Delta_\Psi}{S\tau\lambda},
$$

where  $\Delta_{\Psi} := \Psi(x_{1,0}) - \inf_x \Psi(x)$  denotes the initial function value gap.

Note that  $\mu_h(\mathcal{X}_s) \geq \mu$  by Assumption [2.4,](#page-4-1) the above lemma in fact indicates that  $S_{\tau} = O(1/\epsilon)$ iterations are needed to guarantee  $\min_{s,k} \mathbb{E} \big[ \| \mathcal{G}^{\lambda}_{\phi + id_{\mathcal{X}_s},h}(x_{s,k}) \|^2 \big] \leq \epsilon$ . However, due to the set constraint  $x \in \mathcal{X}_s$ , the restricted gradient mapping  $\mathcal{G}^{\lambda}_{\phi + id_{\mathcal{X}_s},h}(x_{s,k})$  does not necessarily equal to the true gradient mapping of interest:  $\mathcal{G}^{\lambda}_{\phi,h}(x_{s,k})$ . That is,  $\mathbb{E}[\|\mathcal{G}^{\lambda}_{\phi+\text{id}_{\mathcal{X}_{s},h}}(x_{s,k})\|^2] \leq O(\epsilon^2) \nRightarrow \mathbb{E}[\|\mathcal{G}^{\lambda}_{\phi,h}(x_{s,k})\|^2] \leq O(\epsilon^2).$ 

<span id="page-10-0"></span>
$$

Figure 1: Having the constraint set  $\mathcal{X}_s$  enables the variance reduction analysis via kernel conditioning, but it also causes issues. In the left figure,  $x_{s,k+1} \in \text{int}(\mathcal{X}_s)$  does not necessarily indicate  $\bar{x}_{s,k+1} :=$  $\mathbf{T}_{\phi,h}^{\lambda}(x_{s,k}, \nabla f(x_{s,k})) \in \text{int}(\mathcal{X}_s)$ . On the other hand,  $\bar{x}_{s,k+1} \notin \text{int}(\mathcal{X}_s)$  indicates that  $\hat{x}_{s,k+1} \in \partial \mathcal{X}_s$ . Namely, neither  $\tilde{G} = \frac{x_{s,k}-x_{s,k+1}}{\lambda}$  nor  $\mathcal{G}^{\lambda}_{\phi+\text{id}_{\mathcal{X}_s},h}(x_{s,k}) = \frac{x_{s,k}-\hat{x}_{s,k+1}}{\lambda}$  correctly characterize  $\mathcal{G}^{\lambda}_{\phi,h}(x_{s,k})$ . Only in case of the right figure where  $\hat{x}_{s,k} = \bar{x}_{s,k} \in \text{int}(\mathcal{X}_s)$ , one may claim  $\mathcal{G}^{\lambda}_{\phi,h}(x_{s,k}) = \mathcal{G}^{\lambda}_{\phi+\text{id}_{\mathcal{X}_s},h}(x_{s,k})$ .

To resolve the mismatch between  $\mathcal{G}^{\lambda}_{\phi + id_{\mathcal{X}_s},h}(\cdot)$  and  $\mathcal{G}^{\lambda}_{\phi,h}(\cdot)$ , we propose the following probabilistic argument to show that the right-hand-side case of Figure [1](#page-10-0) happens in the majority of iterations.

<span id="page-10-3"></span>**Lemma 3.6.** For any S epochs generated by Algorithm [1,](#page-9-0) define the set  $\mathcal{I}_1$  and event  $\mathcal{A}_1(m_1)$  as

$$
\mathcal{I}_1 := \left\{ s \in [S] : \max_{0 \le k \le \tau - 1} ||x_{s,k} - x_{s,0}|| \ge \frac{\delta}{4} \right\} \quad and \quad \mathcal{A}_1(m_1) := \left\{ \omega : |\mathcal{I}_1| \ge m_1 \right\},\
$$

where  $m_1 > 0$  is an arbitrary positive number. Then it holds that

$$
\operatorname{Prob}(\mathcal{A}_1(m_1)) \leq \frac{128\tau\Delta_{\Psi}}{3\mu\kappa_h^{\delta}L\delta^2 \cdot m_1}.
$$

Proof. By lemma [3.5,](#page-10-1) ignoring the squared gradient mapping terms yields

$$
\frac{\Delta_{\Psi}}{S\tau\lambda} \geq \frac{3\kappa_h^{\delta} L}{4\lambda S\tau} \mathbb{E}\bigg[\sum_{s=1}^{S}\sum_{k=0}^{\tau-1} D_h(x_{s,k+1}, x_{s,k})\bigg] \n\geq \frac{3\mu\kappa_h^{\delta} L}{8\lambda S\tau} \mathbb{E}\bigg[\sum_{s=1}^{S}\sum_{k=0}^{\tau-1} ||x_{s,k+1} - x_{s,k}||^2\bigg] \n\geq \frac{3\mu\kappa_h^{\delta} L}{8\lambda S\tau} \cdot \text{Prob}\left(\mathcal{A}_1(m_1)\right) \cdot \mathbb{E}\bigg[\sum_{s=1}^{S}\sum_{k=0}^{\tau-1} ||x_{s,k+1} - x_{s,k}||^2 \mid \mathcal{A}_1(m_1)\bigg],
$$
\n(17)

where the last inequality is due to the fact that

$$
\mathbb{E}[X] = \mathrm{Prob}(\mathcal{A}) \cdot \mathbb{E}[X \mid \mathcal{A}] + \mathrm{Prob}(\mathcal{A}^c) \cdot \mathbb{E}[X \mid \mathcal{A}^c] \ge \mathrm{Prob}(\mathcal{A}) \cdot \mathbb{E}[X \mid \mathcal{A}]
$$

for any non-negative random variable  $X \geq 0$  and any event A. Therefore, conditioning on the event  $\mathcal{A}_1(m_1)$ , there exists  $\mathcal{I} \subseteq [S]$  with  $|\mathcal{I}| \geq m_1$  and  $\max_{0 \leq k \leq \tau-1} ||x_{s,k} - x_{s,0}|| \geq \frac{\delta}{4}$  for any  $s \in \mathcal{I}$ . As a result, for any  $s \in \mathcal{I}$ , define  $k_s := \min\left\{0 \leq k \leq \tau - 1 : ||x_{s,k} - x_{s,0}|| \geq \frac{\delta}{4}\right\}$ . Then given  $s \in \mathcal{I}$ , the triangle inequality and the arithmetic inequality indicate that

<span id="page-11-2"></span>
$$
\frac{\delta}{4k_s} \le \frac{\|x_{s,k_s} - x_{s,0}\|}{k_s} \le \frac{\sum_{k=0}^{k_s - 1} \|x_{s,k+1} - x_{s,k}\|}{k_s} \le \sqrt{\frac{\sum_{k=0}^{k_s - 1} \|x_{s,k+1} - x_{s,k}\|^2}{k_s}}.
$$
\n(18)

Hence we have

<span id="page-11-3"></span>
$$
\sum_{k=0}^{\tau-1} \|x_{s,k+1} - x_{s,k}\|^2 \ge \sum_{k=0}^{k_s-1} \|x_{s,k+1} - x_{s,k}\|^2 \ge \frac{\delta^2}{16k_s} \ge \frac{\delta^2}{16\tau} \,. \tag{19}
$$

Note that the above inequalities hold w.p. 1 conditioning on  $\mathcal{A}_1(m_1)$ . Combined with [\(17\)](#page-10-2), we have

$$
\frac{\Delta_{\Psi}}{S\tau\lambda} \geq \frac{3\mu\kappa_h^{\delta}L}{8\lambda S\tau} \cdot \mathrm{Prob}\left(\mathcal{A}_1(m_1)\right) \cdot \frac{m_1\delta^2}{16\tau} \quad \Longrightarrow \quad \mathrm{Prob}\left(\mathcal{A}_1(m_1)\right) \leq \frac{128\tau\Delta_{\Psi}}{3\mu\kappa_h^{\delta}L\delta^2 \cdot m_1} \, .
$$

Hence we complete the proof.

By Lemma [3.6,](#page-10-3) we show that  $S - m_1$  epochs never move out of  $B(x_{s,0}, \delta/4)$  with  $O(1/m_1)$  probability, which indicates that the iterates in these epochs are at least  $\delta/4$  away from the boundary of  $\mathcal{X}_s$ . In the next lemma, we show that with high probability, the majority of iterates that do not exit  $B(x_{s,0}, \delta/4)$  will not suffer the mismatch between  $\mathcal{G}^{\lambda}_{\phi+\mathrm{id}_{\mathcal{X}_{s}},h}(\cdot)$  and  $\mathcal{G}^{\lambda}_{\phi,h}(\cdot)$ .

<span id="page-11-1"></span>**Lemma 3.7.** For any S epochs generated by Algorithm [1,](#page-9-0) define the set  $\mathcal{I}_2$  and event  $\mathcal{A}_2(m_2)$  as

$$
\mathcal{I}_2:=\left\{(s,k)\!\in\![S]\!\times\![\tau]:x_{s,k-1}\in B\Big(x_{s,0},\frac{\delta}{4}\Big),\hat{x}_{s,k}\in\partial\mathcal{X}_s\right\}\quad\text{and}\quad\mathcal{A}_2(m_2):=\left\{\omega:|\mathcal{I}_2|\geq m_2\right\}
$$

where  $m_2 > 0$  is an arbitrary positive number. Then it holds that

$$
\mathrm{Prob}\left(\mathcal{A}_2(m_2)\right) \leq \frac{128\lambda\Delta_{\Psi}}{\mu\delta^2 \cdot m_2}.
$$

Proof. Similar to the proof of Lemma [3.6,](#page-10-3) ignoring the Bregman divergence terms in Lemma [3.5](#page-10-1) yields

$$
\frac{\Delta_{\Psi}}{S\tau\lambda} \geq \frac{\mu}{8S\tau} \mathbb{E} \left[ \sum_{s=1}^{S} \sum_{k=0}^{\tau-1} \left\| \mathcal{G}^{\lambda}_{\phi + id_{\mathcal{X}_s}, h}(x_{s,k}) \right\|^2 \right]
$$
\n
$$
= \frac{\mu}{8\lambda^2 S\tau} \mathbb{E} \left[ \sum_{s=1}^{S} \sum_{k=0}^{\tau-1} \left\| \hat{x}_{s,k+1} - x_{s,k} \right\|^2 \right]
$$
\n
$$
\geq \frac{\mu \text{Prob} \left( \mathcal{A}_2(m_2) \right)}{8\lambda^2 S\tau} \cdot \mathbb{E} \left[ \sum_{s=1}^{S} \sum_{k=0}^{\tau-1} \left\| \hat{x}_{s,k+1} - x_{s,k} \right\|^2 \middle| \mathcal{A}_2(m_2) \right]
$$

.

Note that for  $\forall (s,k) \in \mathcal{I}_2$ , we have  $x_{s,k-1} \in B(x_{s,0}, \frac{\delta}{4})$  while  $\hat{x}_{s,k} \in \partial \mathcal{X}_s$ . Because  $B(x_{s,0}, \frac{\delta}{2}) \subseteq \mathcal{X}_s$ , one must have  $||x_{s,k-1} - \hat{x}_{s,k}|| \ge \frac{\delta}{4}$ . Conditioning on the event  $\mathcal{A}_2(m_2)$ , we have  $|\mathcal{I}_2| \ge m_2$ . Combining these facts gives  $\mathbb{E}\left[\sum_{s=1}^S\sum_{k=0}^{\tau-1} \|\hat{x}_{s,k+1}-x_{s,k}\|^2 \mid \mathcal{A}_2(m_2)\right] \geq \frac{m_2\delta^2}{16}$ . Consequently,

$$
\frac{\Delta_{\Psi}}{S\tau\lambda} \ge \frac{\mu \text{Prob}\left(A_2(m_2)\right)}{8\lambda^2 S\tau} \cdot \frac{m_2\delta^2}{16}.
$$

Slightly clearing up the above inequality proves this lemma.

<span id="page-12-0"></span>**Theorem 3.8.** Let us set  $S = \left[\frac{32\Delta_{\Psi}}{\lambda\mu\tau\epsilon}\right]$ ,  $b = \tau = \left[\sqrt{n}\right]$ , and  $\lambda \leq \frac{1}{(2\kappa_h^{\delta}+1)L}$ . Suppose the target accuracy  $\epsilon$  satisfies  $\epsilon \leq (\frac{\kappa_h^{\delta} L \delta}{4\tau})^2 = O(1/n)$  and let  $x_{\text{out}}$  be uniformly randomly selected from all iterations  $x_{s,k}$ that are  $\delta/4$ -away from the corresponding epoch boundary  $\partial \mathcal{X}_s$ , then there is a high probability event A, conditioning on which we have

$$
\mathbb{E}\Big[\big\|\mathcal{G}^{\lambda}_{\phi,h}(x_{\text{out}})\big\|^2\,\big|\,\mathcal{A}\Big]\leq\epsilon,
$$

with Prob  $(\mathcal{A}) \geq 1 - \frac{8\sqrt{n\epsilon}}{3\epsilon^{\delta}L^{\delta}}$  $\frac{8\sqrt{n\epsilon}}{3\kappa_h^8L\delta}$ , which goes to 1 as  $\epsilon \to 0$ . The corresponding sample complexity is  $O(\sqrt{n}\epsilon^{-1})$ .

Note that the typical complexity for nonconvex stochastic optimization is  $O(\sqrt{n}\epsilon^{-1})$  for finite-sum problem and  $O(\epsilon^{-1.5})$  for general expectation problems. That is, only in the accuracy regime where  $\epsilon \leq O(1/n)$ , utilizing the finite-sum structure will be beneficial. Otherwise, when  $n \geq \Omega(1/\epsilon)$ , it is better to ignore the finite-sum structure and simply treat it as a general expectation. Hence the  $O(\sqrt{n\epsilon})$  term in Prob(A) should naturally be close to 0.

*Proof.* First of all, suppose we select  $m_1 \geq \frac{512\tau\Delta_{\Psi}}{3\mu\kappa_b^3L\delta^2}$  and  $m_2 \geq \frac{512\lambda\Delta_{\Psi}}{\mu\delta^2}$  such that both Prob $(A_1(m_1))$ and  $\text{Prob}(\mathcal{A}_2(m_2))$  are upper bounded by 1/4. As a result, we have

$$
\mathrm{Prob}\big(\mathcal{A}_1^c(m_1) \cap \mathcal{A}_2^c(m_2)\big) \ge 1 - \mathrm{Prob}\big(\mathcal{A}_1(m_1)\big) - \mathrm{Prob}\big(\mathcal{A}_2(m_2)\big) \ge 1/2. \tag{20}
$$

That is, w.p. at least  $1/2$  neither  $\mathcal{A}_1(m_1)$  nor  $\mathcal{A}_2(m_2)$  happens. Define a third event  $\mathcal{A}_3$  as

 $\mathcal{A}_3 := \{\omega : \text{the index of } x_{\text{out}} \text{ is from } \mathcal{I}^*\}\$  $(21)$ 

where  $\mathcal{I}^* := (\bigcup_{s \in \mathcal{I}_1^c} \{s\} \times \{0, \cdots, \tau-1\}) \bigcap \mathcal{I}_2^c$ . That is, by definition, for any  $(s, k) \in \mathcal{I}^*$ , all iterations of epoch-s are  $\delta/4$ -close from the epoch starting point  $x_{s,0}$ . In the meanwhile, the restricted gradient mapping coincides with the real gradient mapping, namely,  $\mathcal{G}^{\lambda}_{\phi+\text{id}_{\mathcal{X}_s,h}}(x_{s,k}) = \mathcal{G}^{\lambda}_{\phi,h}(x_{s,k})$ . Therefore, by Lemma [3.5,](#page-10-1) ignoring the Bregman divergence terms gives

$$
\frac{\Delta_{\Psi}}{S\tau\lambda} \stackrel{\text{E.q. (20)}}{\geq} \frac{1}{2} \cdot \frac{\mu}{8S\tau} \mathbb{E} \bigg[ \sum_{s=1}^{S} \sum_{k=0}^{\tau-1} ||\mathcal{G}^{\lambda}_{\phi+\text{id}_{\mathcal{X}_s,h}}(x_{s,k})||^2 \bigg| \mathcal{A}^c_1(m_1) \cap \mathcal{A}^c_2(m_2) \bigg] \qquad (22)
$$
\n
$$
\geq \frac{\mu}{16S\tau} \mathbb{E} \bigg[ \sum_{(s,k)\in\mathcal{I}^*} ||\mathcal{G}^{\lambda}_{\phi+\text{id}_{\mathcal{X}_s,h}}(x_{s,k})||^2 \bigg| \mathcal{A}^c_1(m_1) \cap \mathcal{A}^c_2(m_2) \bigg]
$$
\n
$$
\stackrel{(i)}{\geq} \frac{\mu(S\tau - m_1\tau - m_2)}{16S\tau} \mathbb{E} \bigg[ \frac{\sum_{(s,k)\in\mathcal{I}^*} ||\mathcal{G}^{\lambda}_{\phi+\text{id}_{\mathcal{X}_s,h}}(x_{s,k})||^2}{|\mathcal{I}^*|} \bigg| \mathcal{A}^c_1(m_1) \cap \mathcal{A}^c_2(m_2) \bigg]
$$
\n
$$
= \frac{\mu(S\tau - m_1\tau - m_2)}{16S\tau} \mathbb{E} \bigg[ \frac{\sum_{(s,k)\in\mathcal{I}^*} ||\mathcal{G}^{\lambda}_{\phi,h}(x_{s,k})||^2}{|\mathcal{I}^*|} \bigg| \mathcal{A}^c_1(m_1) \cap \mathcal{A}^c_2(m_2) \bigg]
$$
\n
$$
= \frac{\mu(S\tau - m_1\tau - m_2)}{16S\tau} \mathbb{E} \bigg[ ||\mathcal{G}^{\lambda}_{\phi,h}(x_{\text{out}})||^2 \bigg| \mathcal{A}^c_1(m_1) \cap \mathcal{A}^c_2(m_2) \cap \mathcal{A}_3 \bigg]
$$
\n(22)

where in (i) is because  $|\mathcal{I}^*| \geq S\tau - m_1\tau - m_2$  conditioning on  $\mathcal{A}_1^c(m_1) \cap \mathcal{A}_2^c(m_2)$ . Suppose we have chosen  $m_1, m_2$  such that  $m_1 \tau + m_2 \leq \frac{S\tau}{2}$ , then  $\frac{\mu(S\tau - m_1 \tau - m_2)}{16S\tau} \geq \frac{\mu}{32}$  and hence

$$
\mathbb{E}\left[\left\|\mathcal{G}_{\phi,h}^{\lambda}(x_{\text{out}})\right\|^2 \Big|\mathcal{A}_1^c(m_1) \cap \mathcal{A}_2^c(m_2) \cap \mathcal{A}_3\right] \leq \frac{32\Delta_{\Psi}}{\mu S \tau \lambda}.
$$



Let us set  $S = \left[\frac{32\Delta\Psi}{\lambda\mu\tau\epsilon}\right]$  so that  $\frac{32\Delta\Psi}{\mu S\tau\lambda} \leq \epsilon$  and set  $\mathcal{A} := \mathcal{A}_1^c(m_1) \cap \mathcal{A}_2^c(m_2) \cap \mathcal{A}_3$ , then we have

$$
\text{Prob}(\mathcal{A}) = \text{Prob}\left(\mathcal{A}_1^c(m_1) \cap \mathcal{A}_2^c(m_2)\right) \cdot \text{Prob}\left(\mathcal{A}_3 \mid \mathcal{A}_1^c(m_1) \cap \mathcal{A}_2^c(m_2)\right)
$$
\n
$$
\geq \left(1 - \frac{128\tau\Delta_{\Psi}}{3\mu\kappa_h^{\delta}L\delta^2m_1} - \frac{128\lambda\Delta_{\Psi}}{\mu\delta^2m_2}\right) \cdot \left(1 - \frac{m_1\tau + m_2}{S\tau}\right)
$$
\n
$$
\geq 1 - \frac{128\tau\Delta_{\Psi}}{3\mu\kappa_h^{\delta}L\delta^2m_1} - \frac{128\lambda\Delta_{\Psi}}{\mu\delta^2m_2} - \frac{m_1}{S} - \frac{m_2}{S\tau}.
$$
\n(23)

To maximize the the above probability, we can choose  $m_1 = \sqrt{\frac{128\tau\Delta_\Psi S}{3\mu\kappa_h^5 L\delta^2}}$  such that

$$
\begin{split} \frac{128\tau\Delta_{\Psi}}{3\mu\kappa_{h}^{\delta}L\delta^{2}m_{1}}+\frac{m_{1}}{S}&=2\sqrt{\frac{128\tau\Delta_{\Psi}}{3\mu\kappa_{h}^{\delta}L\delta^{2}m_{1}}\cdot\frac{m_{1}}{S}}\\ &=2\sqrt{\frac{32\Delta_{\Psi}}{\mu S\tau\lambda}\cdot\frac{4\tau^{2}\lambda}{3\kappa_{h}^{\delta}L\delta^{2}}}\overset{\left(i\right)}{\leq} \frac{4\tau\sqrt{\epsilon}}{\delta}\sqrt{\frac{\lambda}{3\kappa_{h}^{\delta}L}\frac{\left(ii\right)}{S}}\frac{4\tau\sqrt{\epsilon}}{3\kappa_{h}^{\delta}L\delta}, \end{split}
$$

where (i) is due to the choice of S and (ii) is due to the choice of  $\lambda$  and the fact that  $\kappa_h^{\delta} \geq 1$ . Similarly, let us select  $m_2 = \sqrt{\frac{128\lambda S\tau\Delta_{\Psi}}{\mu\delta^2}}$  such that

$$
\frac{128 \lambda \Delta_\Psi}{\mu m_2 \delta^2} + \frac{m_2}{S\tau} = 2\sqrt{\frac{128 \lambda \Delta_\Psi}{\mu m_2 \delta^2} \cdot \frac{m_2}{S\tau}} = 2\sqrt{\frac{32 \Delta_\Psi}{\mu S \tau \lambda} \cdot \frac{4\lambda^2}{\delta^2}} \leq \frac{4 \lambda \sqrt{\epsilon}}{\delta} \leq \frac{4 \sqrt{\epsilon}}{3 \kappa_h^{\delta} L \delta}
$$

Now it remains to determine the parameter regimes where the above selection of  $m_1$  and  $m_2$  satisfies our previous requirements of them. That is, given the current choice of  $S$ , we require

$$
\epsilon \le \left(\frac{\kappa_h^{\delta} L \delta}{4\tau}\right)^2 \qquad \Longrightarrow \qquad m_1 \ge \sqrt{\frac{128\tau \Delta_{\Psi}}{3\mu \kappa_h^{\delta} L \delta^2} \cdot \frac{32\Delta_{\Psi}}{\lambda \mu \tau \epsilon}} \ge \frac{512\tau \Delta_{\Psi}}{3\mu \kappa_h^{\delta} L \delta^2} \quad \text{and} \quad m_1 \tau \le S\tau/4,
$$
\n
$$
\epsilon \le \left(\frac{\kappa_h^{\delta} L \delta}{4}\right)^2 \qquad \Longrightarrow \qquad m_2 \ge \sqrt{\frac{128\lambda \tau \Delta_{\Psi}}{\mu \delta^2} \cdot \frac{32\Delta_{\Psi}}{\lambda \mu \tau \epsilon}} \ge \frac{512\lambda \Delta_{\Psi}}{\mu \delta^2} \quad \text{and} \quad m_2 \le S\tau/4.
$$

That is, as long as the target accuracy  $\epsilon \leq \left(\frac{\kappa_h^{\delta} L \delta}{4\tau}\right)^2$ , then all the previous requirements on  $m_1$  and  $m_2$ are automatically satisfied. Therefore, combining the previous discussion, we have

<span id="page-13-1"></span>
$$
\text{Prob}\left(\mathcal{A}\right) \ge 1 - \frac{4(\tau + 1)\sqrt{\epsilon}}{3\kappa_h^{\delta}L\delta} \ge 1 - \frac{8\sqrt{n\epsilon}}{3\kappa_h^{\delta}L\delta} \to 1 \quad \text{as} \quad \epsilon \to 0.
$$

Hence we complete the proof.

One comment here is that if one define the event

$$
\mathcal{A}':=\big\{\omega:\mathcal{G}_{\phi+\mathrm{id}_{\mathcal{X}_{s^*}},h}(x_{s^*,k^*})=\mathcal{G}_{\phi,h}^\lambda(x_{s^*,k^*}),\,\,\text{where}\,\,(s^*,k^*)\,\,\text{is the index of}\,\,x_{\mathrm{out}}\big\},
$$

then  $A \subseteq A'$ . Therefore, it is clear that  $\mathbb{E} \left[ \|\mathcal{G}_h^{\lambda}(x_{\text{out}})\|^2 |\mathcal{A}' \right] \leq O(\epsilon)$  while  $\text{Prob}(A')$  could be potentially much closer to 1 than  $\text{Prob}(\mathcal{A})$ . However, as  $\mathcal{A}'$  also includes the points that are close to the epoch boundaries ( $\partial \mathcal{X}_s$ ), whose number is difficult to bound, we analyze the event A in Theorem [3.8.](#page-12-0)

#### <span id="page-13-0"></span>3.2 Improved algorithm for finite-sum setting

Though Algorithm [1](#page-9-0) is simple to describe and easy to analyze, it also suffers several drawbacks. In terms of implementation, it is limited to large  $O(\sqrt{n})$  batch sizes. In addition, when the iterates hit the boundary  $\partial \mathcal{X}_s$  before the epoch ends, which suggests the set  $\mathcal{X}_s$  starts to hurdle the algorithm from making progress, Algorithm [1](#page-9-0) still continues computing the rest iterations of the epoch, causing a waste of computation. Moreover, in terms of technical analysis of Theorem [3.8,](#page-12-0) a lot of "good" iterates where  $\mathcal{G}^{\lambda}_{\phi+\text{id}_{\mathcal{X}_{s}},h}(\cdot) = \mathcal{G}^{\lambda}_{\phi,h}(\cdot)$  are abandoned by the event  $\mathcal{A}_{3}$  due to technical difficulties, which makes

the final provable success probability to be  $\text{Prob}(\mathcal{A}) = 1 - O(\sqrt{n\epsilon})$ . In this section we introduce an improved version of Algorithm [1](#page-9-0) that both allows arbitrary batch sizes, proper restarting of epochs, and an improved  $1 - O(n\epsilon)$  success chance, as described by Algorithm [2.](#page-14-0)

Compared to Algorithm [1,](#page-9-0) this variant adopts an additional interpolation step [\(24\)](#page-13-1) to enable arbitrary batch size. An additional epoch restarting rule was also introduced in Line 6 of Algorithm [2,](#page-14-0) which enables us to update the "safe region"  $(\mathcal{X}_s)$  for kernel conditioning when it starts to hurdle the optimization progress. We present the convergence results as follows.

<span id="page-14-2"></span>**Lemma 3.9.** Let  $\{x_{s,k}\}_{k=0}^{\tau_s}$  be the s-th epoch of Algorithm [2.](#page-14-0) Then we have

<span id="page-14-3"></span>
$$
\Psi(x_{s,k+1}) \leq \Psi(x_{s,k}) - \frac{\gamma \eta \mu_h(\mathcal{X}_s)}{8} \big\| \mathcal{G}_{\phi+\text{id}_{\mathcal{X}_s},h}^\eta(x_{s,k}) \big\|^2 - \bigg( \frac{\gamma}{\eta} - L \kappa_h^\delta \gamma^2 \bigg) D_h(\bar{x}_{s,k+1},x_{s,k}) + \frac{5 \gamma \eta \|\mathcal{E}_{s,k}\|^2}{4 \mu_h(\mathcal{X}_s)}
$$

where  $\mathcal{E}_{s,k} = \nabla f(x_{s,k}) - v_{s,k}$  denotes the gradient estimation error at  $x_{s,k}$ .

By properly bounding the error term  $\mathcal{E}_{s,k}$ , we obtain Lemma [3.10](#page-14-1) for the restricted gradient mapping. The proof of Lemma [3.9](#page-14-2) and Lemma [3.10](#page-14-1) are both placed in Appendix [C.](#page-29-0)

A significant difference between the Lemma [3.10](#page-14-1) and Lemma [3.5](#page-10-1) is that in the above result, the actual epoch length  $\tau_s$  are also random variables. Therefore, one may not simply taking average by dividing epoch length  $\tau_s$  are also random variables. Therefore, one may not simply taking average by dividing  $\sum_{s=1}^{S} \tau_s$  on both sides. Moreover, intuitively and informally speaking, the output accuracy should be of order  $O(1/\sum_{s=1}^{S} \tau_s)$ . If  $\tau_s$  are too small compared to  $\tau$ , then one should frequently restart and take full batch to initialize the epochs, which may cause a bad sample complexity. Therefore, careful probabilistic analyses are required to exclude such undesirable event.

<span id="page-14-4"></span>**Lemma 3.11.** Consider any S epochs generated by Algorithm [2.](#page-14-0) For any  $m_1, m_2 > 0$ , let us inherit the definition of  $\mathcal{I}_2$  and  $\mathcal{A}_2(m_2)$  from Lemma [3.7,](#page-11-1) and let us modify  $\mathcal{I}_1$  and  $\mathcal{A}_1(m_1)$  as

$$
\mathcal{I}_1 := \left\{ s \in [S] : \tau_s < \tau \right\} \qquad \text{and} \qquad \mathcal{A}_1(m_1) := \left\{ \omega : |\mathcal{I}_1| \ge m_1 \right\}.
$$

Then it holds that

$$
\mathrm{Prob}\left(\mathcal{A}_1(m_1)\right) \leq \frac{32\gamma\tau\Delta_{\Psi}}{\eta\mu\delta^2 \cdot m_1} \qquad \text{and} \qquad \mathrm{Prob}\left(\mathcal{A}_2(m_2)\right) \leq \frac{128\eta\Delta_{\Psi}}{\gamma\mu\delta^2 \cdot m_2}.
$$

The proof of this lemma is very similar to that of Lemma [3.6](#page-10-3) and [3.7.](#page-11-1) The only difference is that one needs to pay attention to the relationship  $D_h(\bar{x}_{s,k+1}, x_{s,k}) \geq \frac{\mu}{2} ||\bar{x}_{s,k+1} - x_{s,k}||^2 = \frac{\mu}{2\gamma^2} ||x_{s,k+1} - x_{s,k}||^2$ . Hence we omit the proof. Next, we provide the final complexity result. As the bound for  $Prob(\mathcal{A})$ requires a significantly different analysis, the proof of this theorem is remained in the main paper.

<span id="page-15-1"></span>**Theorem 3.12.** For any constant batch size  $|\mathcal{B}_{s,k}| = b \in [n]$ , let us set the epoch length as  $\tau = [n/b]$ , stepsize  $\eta = \frac{\sqrt{2\tau}}{\sqrt{\pi}}$  $\frac{\sqrt{2\tau}}{7\tau+\sqrt{2b}}$ , interpolation coefficient  $\gamma = \frac{\sqrt{b}}{L\kappa_b^{\delta}\sqrt{\tau}}$ , and total epoch number  $S = \left[\frac{16\Delta_{\Psi}}{\tau\gamma\eta\mu\epsilon}\right]$ . Suppose the target accuracy satisfies  $\epsilon \leq \frac{\delta^2}{16} \cdot \min\left\{\frac{L^2(\kappa_h^{\delta})^2}{b\tau}, \frac{1}{9\eta^2}\right\} = O(1/n)$  and let  $x_{\text{out}}$  be uniformly randomly selected from all iterations, then there is a high probability event A such that

$$
\mathbb{E}\Big[\big\|\mathcal{G}_{\phi,h}^{\eta}(x_{\text{out}})\big\|^2\big|\,\mathcal{A}\Big] \leq 4\epsilon \qquad and \qquad \text{Prob}\,(\mathcal{A}) \geq 1 - \frac{8\eta\tau b\epsilon}{L^2(\kappa^{\delta}_h)^2\delta^2} - \frac{4\sqrt{\epsilon}}{\delta}.
$$

In particular, Prob  $(\mathcal{A}) \geq 1 - O(n\epsilon + \sqrt{\epsilon})$  goes to 1 as  $\epsilon \to 0$ . Suppose we take the batch size  $b = O(n^{\alpha})$ ,  $\alpha \in [0,1],$  then the total number of samples consumed is  $O(\epsilon^{-1} \cdot n^{\max{\{\alpha,\frac{1}{2}\}}})$ .

Compared to Theorem [3.8,](#page-12-0) the success probability of the event A increases from  $1 - O(\sqrt{n\epsilon})$  to  $1 - O(n\epsilon + \sqrt{\epsilon})$ . In addition, it also allows a much more flexible selection of batch size and epoch length without additional cost.

Proof. By lemma [3.10,](#page-14-1) ignoring the squared gradient mapping terms yields

$$
\frac{\Delta_{\Psi}}{\gamma\eta} \geq \mathbb{E}\bigg[\sum_{s=1}^{S} \sum_{k=0}^{\tau_{s}-1} D_{h}(\bar{x}_{s,k+1},x_{s,k})\bigg] \geq \frac{\mu}{2\gamma^{2}} \mathbb{E}\bigg[\sum_{s=1}^{S} \sum_{k=0}^{\tau_{s}-1} ||x_{s,k+1}-x_{s,k}||^{2}\bigg].
$$

By expanding the expectation over all possible  $\mathcal{I}_1, \mathcal{I}_2$ , and  $\{\tau_s\}$ , we have for all  $m_1, m_2 > 0$  that

$$
\frac{2\gamma\Delta_{\Psi}}{\mu\eta} \geq \mathbb{E}\bigg[\sum_{s=1}^{S} \sum_{k=0}^{\tau_{s}-1} \|x_{s,k+1}-x_{s,k}\|^{2}\bigg] \tag{25}
$$
\n
$$
\geq \sum_{|\mathcal{T}| < \infty} \sum_{|\mathcal{T}| < \infty} \sum_{\tau_{s} \leq |\mathcal{T}|} \sum_{\mathcal{T} \in \mathcal{T}} \text{Prob}(\mathcal{I}_{1}, \mathcal{I}_{2}, \{\tau_{s}\}_{s\in\mathcal{I}_{1}}) \mathbb{E}\bigg[\sum_{s=1}^{S} \sum_{k=0}^{\tau_{s}-1} \|x_{s,k+1}-x_{s,k}\|^{2} \bigg|\mathcal{I}_{1}, \mathcal{I}_{2}, \{\tau_{s}\}_{s\in\mathcal{I}_{1}}\bigg]
$$

$$
|Z_{1}| < m_{1} |Z_{2}| < m_{2} \tau_{s} \in [\tau-1], s \in \mathcal{I}_{1}

\geq \sum_{|\mathcal{I}_{1}| < m_{1} |Z_{2}| < m_{2} \tau_{s} \in [\tau-1], s \in \mathcal{I}_{1}} \sum_{\mathcal{I}_{1} \in \mathcal{I}_{1}} \text{Prob}(\mathcal{I}_{1}, \mathcal{I}_{2}, \{\tau_{s}\}_{s \in \mathcal{I}_{1}}) \mathbb{E} \left[ \sum_{s \in \mathcal{I}_{1}} \sum_{k=0}^{\tau_{s}-1} ||x_{s,k+1} - x_{s,k}||^{2} \middle| \mathcal{I}_{1}, \mathcal{I}_{2}, \{\tau_{s}\}_{s \in \mathcal{I}_{1}} \right]
$$

Note that for  $\forall s \in \mathcal{I}_1$ , since  $B(x_{s,0}, \delta/2) \in \mathcal{X}_s$  while  $dist(x_{s,\tau_s}, \partial \mathcal{X}_s) \leq \delta/4$ , we have  $||x_{s,\tau_s} - x_{s,0}|| \geq \delta/4$ . Repeating the analysis of [\(18\)](#page-11-2) and [\(19\)](#page-11-3) yields  $\sum_{k=0}^{\tau_s-1} ||x_{s,k+1} - x_{s,k}||^2 \ge \frac{\delta^2}{16\tau}$  $\frac{\delta^2}{16\tau_s}$ , which always holds true. Then substituting this lower bound to  $(25)$  gives

Let us inherit the definition of events  $A_3$  and  $A$  from the proof of Theorem [3.8](#page-12-0) while modifying the definition of  $\mathcal{I}^*$  to  $\mathcal{I}^* := \mathcal{I}_2^c$ . Then we have

= \sum_{|\mathcal{I}_{1}| < m_{1}} \sum_{|\mathcal{I}_{2}| < m_{2}} \sum_{\tau_{s} \in [\tau-1], s \in \mathcal{I}_{1}} \text{Prob}\left(\mathcal{I}_{1}, \mathcal{I}_{2}, \{\tau_{s}\}_{s \in \mathcal{I}_{1}}\right) \cdot \left(1 - \frac{|\mathcal{I}_{2}|}{(S - |\mathcal{I}_{1}|)\tau + \sum_{s \in \mathcal{I}_{1}} \tau_{s}}\right)
$$
\n
$$
\geq \sum_{|\mathcal{I}_{1}| < m_{1}} \sum_{|\mathcal{I}_{2}| < m_{2}} \sum_{\tau_{s} \in [\tau-1], s \in \mathcal{I}_{1}} \text{Prob}\left(\mathcal{I}_{1}, \mathcal{I}_{2}, \{\tau_{s}\}_{s \in \mathcal{I}_{1}}\right) \cdot \left(1 - \frac{m_{2}}{(S - |\mathcal{I}_{1}|)\tau + \sum_{s \in \mathcal{I}_{1}} \tau_{s}}\right).
$$

Note that for any positive numbers  $y_1, \dots, y_S > 0$ , the arithmetic-harmonic inequality states that

$$
\frac{y_1 + y_2 + \dots + y_S}{S} \ge \frac{S}{\frac{1}{y_1} + \frac{1}{y_2} + \dots + \frac{1}{y_S}}
$$

Applying this inequality gives

$$
\frac{1}{\tau}+\frac{\sum_{s\in\mathcal{I}_1}\tau_s^{-1}}{S}\geq \frac{(S-|\mathcal{I}|_1)\tau^{-1}+\sum_{s\in\mathcal{I}_1}\tau_s^{-1}}{S}\geq \frac{S}{(S-|\mathcal{I}|_1)\tau+\sum_{s\in\mathcal{I}_1}\tau_s}\,,

which implies that

-\frac{m_2}{(S-|\mathcal{I}_1|)\tau+\sum_{s\in\mathcal{I}_1}\tau_s} \ge 1 - \frac{m_2}{S\tau} - \frac{m_2}{S^2} \sum_{s\in\mathcal{I}_1} \tau_s^{-1}.
$$

Substituting this bound to the above inequality for  $\text{Prob}(\mathcal{A})$  and setting  $m_1^* = S/4$  yields

$$
\n
$$
\geq \left(1 - \frac{m_{2}}{S\tau}\right) \left(1 - \text{Prob}(\mathcal{A}_{1}(m_{1}^{*})) - \text{Prob}(\mathcal{A}_{2}(m_{2}))\right) - \frac{m_{2}}{S^{2}} \cdot \frac{32\gamma\Delta_{f}}{\mu\eta\delta^{2}}
$$
\n
$$
\stackrel{(ii)}{\geq} 1 - \frac{8\eta\tau b\epsilon}{L^{2}(\kappa_{h}^{\delta})^{2}\delta^{2}} - \frac{128\eta\Delta_{\Psi}}{\gamma\mu\delta^{2} \cdot m_{2}} - \frac{m_{2}}{S\tau} - \frac{m_{2}}{S^{2}} \cdot \frac{32\gamma\Delta_{\Psi}}{\mu\eta\delta^{2}}
$$

\stackrel{(iii)}{\geq} 1 - \frac{8\eta\tau b\epsilon}{L^{2}(\kappa_{h}^{\delta})^{2}\delta^{2}} - \frac{128\eta\Delta_{\Psi}}{m_{2}\gamma\mu\delta^{2}} - \frac{9m_{2}}{8S\tau}
$$

where (i) is due to  $(26)$  and the fact that

\text{Prob}\big(\mathcal{A}_1(S/4)\big) \le \frac{32\gamma\tau\Delta_{\Psi}}{\mu\delta^2S/4} = \frac{16\Delta_{\Psi}}{S\tau\gamma\eta\mu} \cdot \frac{8\gamma^2\tau^2\eta}{\delta^2} \le \frac{8\tau b\epsilon}{L^2(\kappa_h^{\delta})^2\delta^2},
$$

and (iii) is because we require  $\epsilon \leq \frac{\delta^2}{16} \cdot \min \left\{ \frac{L^2(\kappa_h^{\delta})^2}{b\tau}, \frac{1}{9\eta^2} \right\} = O(1/n)$  such that

$$
\frac{m_2}{S^2} \cdot \frac{32\gamma\Delta_{\Psi}}{\mu\eta\delta^2} = \frac{m_2}{S\tau} \cdot \frac{16\Delta_{\Psi}}{S\tau\gamma\eta\mu} \cdot \frac{2\gamma^2\tau^2}{\delta^2} \le \frac{m_2}{8S\tau}
$$

Therefore, to maximize the above probability, we can choose  $m_2^* = \sqrt{\frac{S\tau\eta\Delta\Psi}{\gamma\mu}} \cdot \frac{32}{3\delta}$  such that

$$
\frac{128\eta\Delta_{\Psi}}{m_2^*\gamma\mu\delta^2}+\frac{9m_2^*}{8S\tau}=2\sqrt{\frac{128\eta\Delta_{\Psi}}{m_2^*\gamma\mu\delta^2}\cdot\frac{9m_2^*}{8S\tau}}=\sqrt{\frac{\eta\Delta_f}{\gamma\mu S\tau}}\cdot\frac{24}{\delta}\leq\frac{6\eta\sqrt{\epsilon}}{\delta}\leq\frac{4\sqrt{\epsilon}}{\delta}\,,
$$

where the last inequality is due to the fact that  $\eta = \frac{\sqrt{2}}{\sqrt{2}}$  $\frac{\sqrt{2\tau}}{\sqrt{2\tau}}$  $\frac{\sqrt{2\tau}}{7\tau+\sqrt{2b}} \leq \sqrt{2/7}$ . Combining all the above discussion, we can conclude that

$$
\text{Prob}\left(\mathcal{A}\right) \ge 1 - \frac{8\eta\tau b\epsilon}{L^2(\kappa_h^{\delta})^2\delta^2} - \frac{4\sqrt{\epsilon}}{\delta} = 1 - O(n\epsilon + \sqrt{\epsilon})
$$

when taking  $m_1^* = S/4$  and  $m_2^* = \sqrt{\frac{S\tau\eta\Delta_{\Psi}}{\gamma\mu}} \cdot \frac{32}{3\delta}$ . Note that the requirement on  $\epsilon$  further implies that  $\text{Prob}(\mathcal{A}_1(m_1^*)) \leq 1/2$  and  $\text{Prob}(\mathcal{A}_2(m_2^*)) \leq 1/4$ , and hence  $\text{Prob}(\mathcal{A}_1^c(m_1^*) \cap \mathcal{A}_2^c(m_2^*)) \geq 1/4$ . Similar to the analysis of Theorem [3.8,](#page-12-0) by ignoring the Bregman divergence terms of Lemma [3.10,](#page-14-1) we obtain

$$
\frac{\Delta_{\Psi}}{\gamma\eta} \geq \frac{\mu}{8} \mathbb{E} \bigg[ \sum_{s=1}^{S} \sum_{k=0}^{\tau_s-1} \left\| \mathcal{G}_{\phi+\mathrm{id}_{\mathcal{X}_s},h}^{\eta}(x_{s,k}) \right\|^2 \bigg] \geq \frac{\mu}{32} \mathbb{E} \bigg[ \sum_{(s,k)\in\mathcal{I}_2^c} \left\| \mathcal{G}_{\phi+\mathrm{id}_{\mathcal{X}_s},h}^{\eta}(x_{s,k}) \right\|^2 \bigg| \mathcal{A}_1^c(m_1^*) \cap \mathcal{A}_2^c(m_2^*) \bigg].
$$

Conditioning on  $\mathcal{A}_{1}^{c}(m_{1}^{*}) \cap \mathcal{A}_{2}^{c}(m_{2}^{*})$ , regardless of the random sets  $\mathcal{I}_{1}, \mathcal{I}_{2}$  and  $\{\tau_{s}\}_{s \in \mathcal{I}_{1}}$ , we have

$$
|\mathcal{I}_2^c| = (S - |\mathcal{I}_1|)\tau + \sum_{s \in \mathcal{I}_1} \tau_s - |\mathcal{I}_2| \ge \frac{3S\tau}{4} - m_2^* \ge S\tau \Big(\frac{3}{4} - \frac{8\eta\sqrt{\epsilon}}{3\delta}\Big) \ge \frac{S\tau}{2}.
$$

where the second last inequality is because  $|\mathcal{I}_2| \leq m_2^* \leq \frac{8S\tau\eta\sqrt{\epsilon}}{3\delta}$  $\frac{\tau \eta \sqrt{\epsilon}}{3\delta}$ , and the last inequality is because  $\frac{8\eta\sqrt{\epsilon}}{3\delta} \leq 2/9 < 1/4$  since we require  $\epsilon \leq \frac{\delta^2}{16} \cdot \frac{1}{9\eta^2}$ . As a result,

$$
\frac{\Delta_{\Psi}}{\gamma\eta} \geq \frac{\mu}{32} \cdot \frac{S\tau}{2} \cdot \mathbb{E} \bigg[ \frac{|\mathcal{I}_2^c|}{S\tau/2} \cdot \frac{\sum_{(s,k)\in\mathcal{I}_2^c} ||\mathcal{G}_{\phi+\mathrm{id}_{\mathcal{X}_s},h}^{\eta}(x_{s,k})||^2}{|\mathcal{I}_2^c|} \bigg| \mathcal{A}_1^c(m_1^*) \cap \mathcal{A}_2^c(m_2^*) \bigg] \qquad (30)
$$
\n
$$
\geq \frac{\mu S\tau}{64} \mathbb{E} \bigg[ \frac{\sum_{(s,k)\in\mathcal{I}_2^c} ||\mathcal{G}_{\phi+\mathrm{id}_{\mathcal{X}_s},h}^{\eta}(x_{s,k})||^2}{|\mathcal{I}_2^c|} \bigg| \mathcal{A}_1^c(m_1^*) \cap \mathcal{A}_2^c(m_2^*) \bigg]
$$
\n
$$
= \frac{\mu S\tau}{64} \mathbb{E} \bigg[ ||\mathcal{G}_{\phi,h}^{\eta}(x_{\text{out}})||^2 \big| \mathcal{A}_1^c(m_1^*) \cap \mathcal{A}_2^c(m_2^*) \cap \mathcal{A}_3 \bigg],
$$

where the last equality is due to the definition of  $x_{\text{out}}$ ,  $A_3$ , and the fact that  $\mathcal{G}_{\phi+\text{id}_{\mathcal{X}_s},h}^{\eta}(\cdot)$  coincides with  $\mathcal{G}_{\phi,h}^{\eta}(\cdot)$  in  $\mathcal{I}_{2}^{c}$ . As a result, we have

$$
\mathbb{E}\Big[\big\|\mathcal{G}_{\phi,h}^{\eta}(x_{\text{out}})\big\|^2\,\big|\,\mathcal{A}\Big] \leq \frac{64\Delta_{\Psi}}{\gamma\eta\mu\tau S} \leq 4\epsilon.
$$

Given the choice of S,  $\gamma$ ,  $\eta$ , and the fact that  $\tau = \lfloor n/b \rfloor$ , the total sample complexity will be

$$
S(n + b\tau) = (n + b\tau) \cdot \left[ \frac{16\Delta_{\Psi}}{\tau \gamma \eta \mu \epsilon} \right] = O\left( \frac{L\kappa_h^{\delta} \Delta_{\Psi} \sqrt{n}}{\mu \epsilon} \cdot \left( 1 + \sqrt{b/\tau} \right) \right)
$$

which indicates an  $O(\sqrt{n}\epsilon^{-1})$  sample complexity for all  $b \leq O(\tau)$  (or equivalently,  $b \leq O(\lceil \sqrt{n} \rceil)$ ). If larger batch size  $b = [n^{\alpha}]$  with  $\alpha \in (1/2, 1]$  is taken, then we obtain an  $O(n^{\alpha} \epsilon^{-1})$  complexity.  $\Box$ 

## <span id="page-17-0"></span>3.3 Variance reduced algorithm for general expectation setting

In this section, we discuss how the previously introduced techniques can handle problem [\(1\)](#page-0-1) with  $f(x) = \mathbb{E}_{\xi}[f_{\xi}(x)]$ . For this setting, we assume the following assumptions.

<span id="page-17-2"></span>**Assumption 3.13.** For almost every  $\xi$ , the function  $f_{\xi}(x)$  is  $L_{\xi}$ -smooth relative to the kernel h for some random variable  $L_{\xi} \geq 0$ . The second moment of  $L_{\xi}$  exists and we denote  $L := \sqrt{\mathbb{E}_{\xi}[L_{\xi}^2]} < +\infty$ .

Besides the above variant of smooth-adaptability assumption for the general expectation setting, we also adopt the following assumption on the variance of the stochastic gradient estimator.

<span id="page-17-1"></span>**Assumption 3.14.** There exists a function  $\sigma(\cdot)$  such that for any  $x \in \mathbb{R}^d$ , we have

$$
\mathbb{E}\left[\left\|\nabla f_{\xi}(x) - \nabla f(x)\right\|^{2}\right] \leq \sigma^{2}(x).
$$

Unlike most existing results that require the stochastic gradient variance to be an absolute constant, see e.g. [\[9\]](#page-33-1), we only require it to be bounded by some function  $\sigma^2(x)$ . This assumption strictly includes the bounded variance assumption by setting  $\sigma(\cdot)$  to be a constant function, but it also allows the variance to go to  $+\infty$  as  $||x||$  grows unbounded, which is important for the considered problem class. A naive example is  $f(x) = \mathbb{E}[(\xi_1 x - \xi_2)^3/3]$  with  $\xi_1, \xi_2 \sim \mathcal{N}(0, 1)$ . This is a cubic polynomial function whose gradient is quadratic and is hence not Lipschitz continuous. One can explicitly compute that

$$
\mathbb{E}\left[\left\|\nabla f_{\xi}(x) - \nabla f(x)\right\|^{2}\right] = 2(x^{2} + 1)^{2},
$$

which indicates that Assumption [3.14](#page-17-1) holds with  $\sigma(x) = \sqrt{2}(x^2 + 1)$ . It is worth noting that there are also different alternative assumptions to capture the potentially unbounded variance. For example, the affine variance assumption introduced in [\[15\]](#page-33-14). However, for simplicity, we only discuss the result under current assumption, which more general than the affine variance assumption.

In terms of the algorithm design, it suffices to modify the construction of  $v_{s,0}$  in Algorithm [2](#page-14-0) as

<span id="page-17-3"></span>
$$
v_{s,0} = \frac{1}{|\mathcal{B}_{s,0}|} \sum_{\xi \in \mathcal{B}_{s,0}} \nabla f_{\xi}(x_{s,0}),
$$
\n(31)

,

where  $\mathcal{B}_{s,0}$  is a batch of i.i.d. samples from the distribution of  $\xi$ . Similarly, the set  $\mathcal{B}_{s,k}$  in [\(12\)](#page-9-1) are also i.i.d. samples of  $\xi$ . After this modification, the Lemma [3.9](#page-14-2) still holds true. To avoid repetition, we will only present the main results in this section while moving all the proof to Appendix [D.](#page-30-0)

<span id="page-18-4"></span>**Theorem 3.15.** Let  $q \in (0, 1/2)$  be some positive constant, for any constant batch size  $|\mathcal{B}_{s,k}| = b \leq$  $O(1/\sqrt{\epsilon})$  for  $k \neq 0$  and  $|\mathcal{B}_{s,0}| = \left[\frac{\sigma^2(x_{s,0})}{\mu_s(X_s)}\right]$  $\left[\frac{\sigma^2(x_{s,0})}{\mu_h(x_s)}\cdot B\right]$  with  $B=\frac{320b\tau}{\mu\delta^2L^2(\kappa^{\delta}_h)^2q}=O(1/\epsilon)$ , let us set the epoch length as  $\tau = \lceil q/\epsilon b \rceil$ , stepsize  $\eta = \frac{\sqrt{2}}{\sqrt{2}}$  $\frac{\sqrt{2\tau}}{\sqrt{2\tau}}$  $\frac{\sqrt{2\tau}}{7\tau+\sqrt{2b}}$ , interpolation coefficient  $\gamma = \frac{\sqrt{b}}{L\kappa_b^{\delta}\sqrt{\tau}}$ , and total epoch number  $S = \left[\frac{256\gamma\tau\Delta_{\Psi}}{\mu\eta\delta^2q}\right] = O\left(1/\sqrt{q\epsilon}\right)$ . Suppose the target accuracy  $\epsilon$  satisfies  $\epsilon \leq \frac{1}{16L^2(\kappa_h^{\delta})^2q}$  and let  $x_{\text{out}}$  be uniformly randomly selected from all iterations, then there is a high probability event  $\mathcal A$  s.t.

$$
\mathbb{E}\Big[\big\|\mathcal{G}_h^{\lambda}(x_{\text{out}})\big\|^2 \big|\,\mathcal{A}\Big] \le \frac{L^2(\kappa_h^{\delta})^2 \delta^2 \epsilon}{2} = O(\epsilon) \qquad and \qquad \text{Prob}\,(\mathcal{A}) \ge 1 - O(q + \sqrt{\epsilon}).
$$

Note that if  $\sigma^2(x) \le O(L_h(x))$ , then the batch size  $|\mathcal{B}_{s,0}| \le O(1/\epsilon)$ . Consequently, we can compute the total number of samples used as  $\sum_s |\mathcal{B}_{s,0}| + Sb\tau = O(\epsilon^{-1.5}q^{-0.5})$ . In particular, under the bounded variance assumption adopted in [\[9\]](#page-33-1) where  $\sigma^2(\cdot)$  is a constant, one would expect a significantly smaller sample consumption if  $\mu_h(\mathcal{X}_s)$  grows large.

## <span id="page-18-0"></span>4 Establishing convergence under the new gradient mapping

In Section [3,](#page-8-0) we have shown how a simple epoch bounding mechanism and a novel probabilistic argument can activate the kernel conditioning regularity and hence enable the general variance reduction techniques. However, these analyses are all based on the existing Bregman proximal gradient mapping  $\mathcal{G}_{\phi,h}^{\lambda}(\cdot)$ . Consider the special case where  $h=0$ , as discussed in Section [2,](#page-3-0) having a small  $\mathcal{G}_{\phi,h}^{\lambda}(\cdot)$  does not necessarily indicate the near-stationarity of the solution. The existing approaches circumvent this issue by assuming the level set Lev<sub>0</sub> :=  $\{x \in \mathbb{R}^d : \Psi(x) \leq \Psi(x_0)\}$  to be compact and hence one may replace the  $\max_{0 \le k \le T-1} \{ L_h([x_k, x_{k+1}]) \}$  in [\(10\)](#page-6-1) by  $L_h(\text{Lev}_0)$ , resulting in an  $O(\frac{LL_h(\text{Lev}_0)\Delta_{\Psi}}{T})$  convergence in  $\|\nabla \Psi(\cdot)\|^2$ . However, without the compactness assumption of the level set, such an argument may no longer holds. In fact, in the worst-case situation described by Example [2,](#page-6-2)  $\mathcal{G}^{\lambda}_{\phi,h}(\cdot) \to 0$  does not even indicate  $\nabla \Psi(\cdot) \to 0$ . Therefore, it is also meaningful to study the convergence under the new Bregman proximal gradient mapping  $\mathcal{D}^{\lambda}_{\phi,h}(\cdot)$ , without relying on the level set compactness.

#### <span id="page-18-3"></span>4.1 An ODE view on deterministic Bregman proximal gradient method

Let us start with the deterministic setting. To establish the convergence of  $\mathcal{D}^{\lambda}_{\phi,h}(\cdot)$  without compact level set assumption, the key is to provide a tight bound on iterations before finding an ϵ-stationary point. Let  ${x_t}_{t\geq 0}$  be the iteration sequence of some Bregman proximal gradient type method and let  $T_{\epsilon} := \inf\{t : ||\mathcal{D}^{\lambda}_{\phi,h}(x_t)||^2 \leq \epsilon\}$  be the first time an  $\epsilon$ -stationary point is obtained, then we aim to provide an  $R_{\epsilon}$  that only depends on  $\Delta_{\Psi}$ ,  $\epsilon$ , (and  $\kappa_h^{\delta}$ ) such that  $R_{\epsilon} \ge \sup\{\|x_t\| : t \le T_{\epsilon}\}.$  In other words, as long as the algorithm does not find an  $\epsilon$ -stationary point, it will not exit the compact region  $\mathcal{X}_{\epsilon} := B(x_0, R_{\epsilon}) \cap \text{Lev}_0$ , which further indicates an  $O\left(\frac{LL_h(\mathcal{X}_{\epsilon})\Delta_{\Psi}}{\epsilon}\right)$  iteration complexity. To get a sense on the magnitude of  $R_{\epsilon}$ , we start by considering a simple ODE continuation of the Bregman proximal gradient method for differentiable objective functions where  $\phi(\cdot) = 0$ . In this case, the limiting Bregman proximal gradient mapping has a simple explicit form.

**Lemma 4.1** (Limiting gradient mapping). Let h be twice continuously differentiable and  $\mu$ -strongly convex for some  $\mu > 0$ , and suppose the Hessian  $\nabla^2 h(x)$  is locally Lipschitz continuous everywhere. Suppose  $\phi(\cdot) = 0$ . Then for  $\forall x, v \in \mathbb{R}^d$ , the following limit exists

$$
\lim_{\lambda \to 0+} \frac{x - \mathbf{T}_{\phi,h}^{\lambda}(x,v)}{\lambda} = \left[\nabla^2 h(x)\right]^{-1} v.
$$

Therefore, we can define the limiting Bregman proximal gradient mapping as

<span id="page-18-2"></span>
$$
\mathcal{G}_h(x) := \lim_{\lambda \to 0+} \mathcal{G}_{\phi,h}^{\lambda}(x) = \left[\nabla^2 h(x)\right]^{-1} \nabla f(x). \tag{32}
$$

*Proof.* Let us inherit the notation  $x^+_{\lambda} := \mathbf{T}^{\lambda}_{\phi,h}(x,v)$  from Lemma [2.6](#page-5-0) with  $\phi(\cdot) = 0$ . By the  $\mu$ -strong convexity of h, setting  $u = 0$  in [\(9\)](#page-4-2) gives

<span id="page-18-1"></span>
$$
\mu \|x_{\lambda}^{+} - x\| \le \|\nabla h(x_{\lambda}^{+}) - \nabla h(x)\| = \lambda \|v\| \to 0 \quad \text{as} \quad \lambda \to 0 + . \tag{33}
$$

That is,  $\lim_{\lambda\to 0+}||x_{\lambda}^+-x||=0$ . Note that  $\nabla^2h(x)$  is locally Lipschitz continuous, there exists some  $\bar{\lambda}, \bar{\epsilon}, \bar{L} > 0$  s.t.  $x_{\lambda}^+ \in B(x, \bar{\epsilon})$  for all  $\lambda \in (0, \bar{\lambda})$ , and  $\nabla^2 h(\cdot)$  is  $\bar{L}$ -Lipsthiz continuous in  $B(x, \bar{\epsilon})$ . Denote

$$
r_{\lambda} := \nabla h(x_{\lambda}^{+}) - \nabla h(x) - \nabla^{2} h(x)(x_{\lambda}^{+} - x)
$$

as the residual term, then  $||r_{\lambda}|| \leq (L/2)||x_{\lambda}^{+} - x||^{2}$  and  $r_{\lambda} = -\lambda \cdot v - \nabla^{2}h(x)(x_{\lambda}^{+} - x)$ . Consequently,

$$
\|\lambda^{-1}(x - x_{\lambda}^{+}) - [\nabla^{2}h(x)]^{-1}v\| = \lambda^{-1}\|[\nabla^{2}h(x)]^{-1}v_{\lambda}\|
$$
  

$$
\leq \frac{\bar{L}\|[\nabla^{2}h(x)]^{-1}\|}{2\lambda}\|x_{\lambda}^{+} - x\|^{2} \leq \frac{\lambda\bar{L}\|[\nabla^{2}h(x)]^{-1}\|}{2\mu^{2}} \cdot \|v\|^{2},
$$

where the last inequality is due to [\(33\)](#page-18-1). Taking the limit of  $\lambda \to 0+$  proves the first inequality of the lemma. Next, replacing v with  $\nabla f(x)$  and utilizing the definition of  $\mathcal{G}^{\lambda}_{\phi,h}(\cdot)$  proves [\(32\)](#page-18-2).  $\Box$ 

Based on this Lemma, we construct the following ODE, which is a continuation model of the of Bregman proximal gradient method that takes infinitesimal step sizes:

<span id="page-19-0"></span>
$$
\dot{x}(t) = -\mathcal{G}_h(x(t)).\tag{34}
$$

Suppose Assumption [2.4](#page-4-1) holds, then we have the following proposition.

<span id="page-19-1"></span>**Proposition 4.2.** Suppose  $\{x(t): t \geq 0\}$  is the integral curve of the ODE [\(34\)](#page-19-0) with boundary condition  $x(0) = x_0$ . Let  $S(\tau) := \int_0^{\tau} ||\dot{x}(t)|| dt$  be the length of the integral curve segment  $\{x(t) : t \in [0, \tau]\}$ , and let  $T_{\epsilon} := \inf \{ t \geq 0 : ||\nabla \Psi(x(t))||^2 \leq \epsilon \}$  be the first time  $x(t)$  reaches an  $\epsilon$ -stationary point of  $\Psi$ . If Assumption [2.4](#page-4-1) holds, then  $S(T_{\epsilon}) \leq$  $\frac{\sqrt{\kappa_h^0} \Delta_\Psi}{\sqrt{\epsilon}}.$ 

*Proof.* By [\(32\)](#page-18-2), the ODE [\(34\)](#page-19-0) reduces to  $\dot{x}(t) = -[\nabla^2 h(x(t))]^{-1} \nabla f(x(t))$ . By definition, we have

$$
dS(t) = ||[\nabla^2 h(x(t))]^{-1} \nabla f(x(t))||dt \leq \lambda_{\min} (\nabla^2 h(x(t)))^{-\frac{1}{2}} \cdot ||[\nabla^2 h(x(t))]^{-\frac{1}{2}} \nabla f(x(t))||dt.
$$

On the other hand, we also have

$$
df(x(t)) = \langle \nabla f(x(t)), \dot{x}(t) \rangle dt = -\big\| [\nabla^2 h(x(t))]^{-\frac{1}{2}} \nabla f(x(t)) \big\|^2 dt.
$$

Combining the above two inequalities yields

$$
df(x(t)) \leq -\lambda_{\min} \left( \nabla^2 h(x(t)) \right)^{\frac{1}{2}} \cdot \left\| \left[ \nabla^2 h(x(t)) \right]^{-\frac{1}{2}} \nabla f(x(t)) \right\| \cdot dS(t)
$$

As  $\Psi = f$  when  $\phi = 0$ , we have  $\|\nabla f(x(t))\| \geq \sqrt{\epsilon}$  for  $t \in [0, T_{\epsilon}]$ . The above inequality further implies

$$
df(x(t)) \le -\sqrt{\frac{\lambda_{\min}(\nabla^2 h(x(t)))}{\lambda_{\max}(\nabla^2 h(x(t)))}} \cdot \sqrt{\epsilon} \cdot dS(t) \le -\frac{\sqrt{\epsilon} \cdot dS(t)}{\sqrt{\kappa_h^0}}, \qquad \forall 0 \le t \le T_{\epsilon},
$$

where the last inequality is due to  $\sup_{x \in \mathbb{R}^n} \frac{\lambda_{\max}(\nabla^2 h(x))}{\lambda_{\min}(\nabla^2 h(x))} \leq \kappa_h^0$  (Assumption [2.4\)](#page-4-1). Integrating the above inequality from  $t = 0$  to  $t = T_{\epsilon}$  yields

$$
\frac{\sqrt{\epsilon} \cdot (S(T_{\epsilon}) - S(0))}{\sqrt{\kappa_h^0}} \le f(x_0) - f(x(T_{\epsilon})) \le f(x_0) - \inf_x f(x) = \Delta_{\Psi}.
$$

Substituting  $S(0) = 0$  to the above inequality proves the lemma.

Given this proposition, as long as the smooth-adaptable function  $h$  satisfies the kernel conditioning regularity, the ode  $(34)$  (continuized Bregman proximal gradient method) can find an  $\epsilon$ -stationary point of the problem within an  $R_{\epsilon} = O(\frac{\Delta_{\Psi}}{\sqrt{\epsilon}})$  distance from the initial point regardless of the potential unboundedness of the level set. On the other hand, from (2) of Example [1,](#page-6-0) there is an instance for which any non-local-max  $\epsilon$ -stationary points are at least  $\tilde{\Omega}(\frac{\Delta_{\Psi}}{\sqrt{\epsilon}})$  away from the initial point, proving the tightness of the upper bound  $R_{\epsilon}$ . Therefore, the intuition behind Proposition [4.2](#page-19-1) is that, if the step sizes of the Bregman proximal gradient method are properly selected so that the iterations can sufficiently approximate the ODE solution curve, then we can claim that an  $\epsilon$ -stationary point can be obtained within a provably compact region  $\mathcal{X}_{\epsilon} = \text{Lev}_0 \cap B(x_0, R_{\epsilon}).$ 

#### 4.2 An adaptive step size control for Bregman proximal gradient method

In this section, we extend the discussion of Section [4.1](#page-18-3) to the general case, where  $\phi(\cdot) \neq 0$  can be a convex but non-differentiable function. A simple mechanism is proposed to adaptively determine the step sizes that can properly approximate the ODE [\(34\)](#page-19-0) without being too conservative:

<span id="page-20-0"></span>
$$
x_{k+1} = \mathbf{T}_{\phi,h}^{\lambda_k} (x_k, \nabla f(x_k)) \quad \text{with} \quad \lambda_k = \min \left\{ \frac{1}{2L}, \frac{\mu \delta}{3\rho}, \frac{\mu \delta}{\|\nabla f(x_k)\| + \rho} \right\} \tag{35}
$$

where L is introduced by Assumption [2.1,](#page-3-1)  $\mu$  and  $\delta$  are introduced by the Assumption [2.4,](#page-4-1) and  $\rho$  comes from the following bounded subgradient assumption on the non-differentiable term  $\phi$ .

<span id="page-20-1"></span>**Assumption 4.3.** There exists a constant  $\rho > 0$  such that  $\sup_{u \in \partial \phi(x)} \|u\| \leq \rho$  for any  $x \in \mathbb{R}^d$ .

In particular, if  $\phi = 0$ , then  $\rho = 0$ , the step size rule reduces to  $\lambda_k = \min\left\{\frac{1}{2L}, \frac{\mu \delta}{\|\nabla f(x_k)\|}\right\}$ . Under this assumption, the adaptively selected step size [\(35\)](#page-20-0) satisfies the following descent result.

<span id="page-20-4"></span>**Lemma 4.4.** Under Assumptions [2.1,](#page-3-1) [2.4,](#page-4-1) and  $4.3$ , the update [\(35\)](#page-20-0) satisfies both

$$
\Psi(x^{k+1}) \le \Psi(x_k) - \frac{3L\mu_h([x_k, x_{k+1}])}{2} \cdot ||x_{k+1} - x_k||^2
$$

and

$$
\Psi(x^{k+1}) \leq \Psi(x_k) - \frac{\min\left\{\rho\mu\delta, 3\min\left\{\frac{1}{2L}, \frac{\mu\delta}{3\rho}\right\} \cdot \left\|\mathcal{D}^{\lambda_k}_{\phi,h}(x_k)\right\|^2\right\}}{4L_h([x_k, x_{k+1}])}.
$$

Moreover, the two successive iterates are  $\delta$ -close:  $||x_{k+1} - x_k|| \leq \delta$ .

*Proof.* First of all, with  $\lambda_k \leq \frac{\mu \delta}{\|\nabla f(x_k)\| + \rho}$ , [\(9\)](#page-4-2) indicates that

<span id="page-20-6"></span>
$$
\mu \|x_{k+1} - x_k\| \le \|\nabla h(x_{k+1}) - \nabla h(x_k)\| \le \frac{\mu \delta}{\|\nabla f(x_k)\| + \rho} \cdot \|\nabla f(x_k) + u_{k+1}\| \le \mu \delta,\tag{36}
$$

where  $u_{k+1} \in \partial \phi(x_{k+1})$  and it satisfies  $||u_{k+1}|| \leq \rho$ . As result, we complete the proof of  $||x_{k+1}-x_k|| \leq \delta$ . Next, let us establish the descent results of this lemma. By standard analysis, we have

<span id="page-20-2"></span>
$$
\Psi(x^{k+1}) \leq \Psi(x_k) - \left(\frac{1}{\lambda_k} - L\right) D_h(x_{k+1}, x_k) - \frac{1}{\lambda_k} D_h(x_k, x_{k+1})
$$
\n
$$
\leq \Psi(x_k) - \frac{1}{2\lambda_k} D_h(x_{k+1}, x_k) - \frac{1}{\lambda_k} D_h(x_k, x_{k+1})
$$
\n
$$
\leq \Psi(x_k) - \frac{3L\mu_h([x_k, x_{k+1}])}{2} \cdot ||x_{k+1} - x_k||^2,
$$
\n(37)

where the second inequality is due to  $\lambda_k \leq 1/2L$ . By [\[33,](#page-34-14) Theorem 2.1.5, Eq.(2.1.10)], we also have

<span id="page-20-3"></span>
$$
D_h(x_{k+1}, x_k) \ge \frac{\|\nabla h(x_k) - \nabla h(x_{k+1})\|^2}{2L_h([x_k, x_{k+1}])} = \frac{\lambda_k^2 \cdot \|\mathcal{D}_{\phi, h}^{\lambda_k}(x_k)\|^2}{2L_h([x_k, x_{k+1}])}.
$$
\n(38)

A Similar inequality also holds for  $D_h(x_k, x_{k+1})$ . Suppose  $\lambda_k = \frac{\mu \delta}{\|\nabla f(x_k)\| + \rho}$ , then this situation may only happen if  $\|\nabla f(x_k)\| \geq 2\rho$  s.t.  $\frac{\mu\delta}{\|\nabla f(x_k)\|+\rho} \leq \frac{\mu\delta}{3\rho}$ . In this situation, with  $L \leq \frac{1}{2\lambda_k}$ , the second row of [\(37\)](#page-20-2) and [\(38\)](#page-20-3) indicate that

<span id="page-20-5"></span>
$$
\Psi(x_{k+1}) \leq \Psi(x_k) - \frac{3\lambda_k \cdot \|\mathcal{D}^{\lambda_k}_{\phi,h}(x_k)\|^2}{4L_h([x_k, x_{k+1}])} = \Psi(x_k) - \frac{3\|\mathcal{D}^{\lambda_k}_{\phi,h}(x_k)\|}{4L_h([x_k, x_{k+1}])} \cdot \frac{\mu\delta\|\nabla f(x_k) + u_{k+1}\|}{\|\nabla f(x_k)\| + \rho},
$$

where the last inequality is due to the fact that  $\mathcal{D}_{\phi,h}^{\lambda_k}(x_k) = \nabla f(x_k) + u_{k+1}$ . Because  $\|\nabla f(x_k)\| \geq 2\rho$ and  $||u_{k+1}|| \leq \rho$ , we have  $||\mathcal{D}_{\phi,h}^{\lambda_k}(x_k)|| \geq \rho$  and

$$
\frac{\mu\delta\|\nabla f(x_k) + u_{k+1}\|}{\|\nabla f(x_k)\| + \rho} \ge \frac{\mu\delta(\|\nabla f(x_k)\| - \|u_{k+1}\|)}{\|\nabla f(x_k)\| + \rho} \ge \frac{\mu\delta}{3}.
$$

Consequently, we have

$$
\Psi(x^{k+1}) \le \Psi(x_k) - \frac{\rho \mu \delta}{4L_h([x_k, x_{k+1}])}.
$$

If  $\lambda_k = \min\left\{\frac{1}{2L}, \frac{\mu\delta}{3\rho}\right\}$ , the second row of [\(37\)](#page-20-2) and [\(38\)](#page-20-3) indicate that

$$
\Psi(x^{k+1}) \leq \Psi(x_k) - \frac{3 \min\left\{\frac{1}{2L}, \frac{\mu \delta}{3\rho}\right\}}{4L_h([x_k, x_{k+1}])} \cdot \left\|\mathcal{D}^{\lambda_k}_{\phi, h}(x_k)\right\|^2.
$$

Therefore, no matter which value  $\lambda_k$  takes, it will at least achieve the minimum descent among the two cases. Hence we complete proof of the lemma.  $\Box$ 

As a result, we can obtain the following counterpart of Proposition [4.2.](#page-19-1)

<span id="page-21-0"></span>**Lemma 4.5.** Consider the update [\(35\)](#page-20-0), for any target accuracy  $\epsilon \leq \max\left\{\rho^2, \frac{2L\rho\mu\delta}{3}\right\}$ , we have

$$
\left\|\mathcal{D}^{\lambda_k}_{\phi,h}(x_k)\right\|^2 \geq \epsilon \quad \Longrightarrow \quad \Psi(x_{k+1}) \leq \Psi(x_k) - \frac{3}{4} \sqrt{\frac{\epsilon}{\kappa_h^{\delta}} \cdot \min\left\{1, \frac{2L\mu\delta}{3\rho}\right\}} \cdot \|x_{k+1} - x_k\|.
$$

Denote  $T_{\epsilon} := \min \left\{ k : ||\mathcal{D}_{\phi,h}^{\lambda_k}(x_k)||^2 \leq \epsilon, k \geq 0 \right\},\$  then

$$
\max_{0 \le k \le T_{\epsilon}} \|x_k - x_0\| \le R_{\epsilon} := \frac{4}{3} \sqrt{\max\left\{1, \frac{3\rho}{2L\mu\delta}\right\}} \cdot \frac{\sqrt{\kappa_h^{\delta}} \Delta_{\Psi}}{\sqrt{\epsilon}}.
$$

In particular, when  $\phi = 0$  and  $\rho = 0$ , the traveling upper bound  $R_{\epsilon}$  only suffers a constant  $1/3$ overhead comparing to the  $S(T_{\epsilon})$  in Proposition [4.2.](#page-19-1) Therefore, one does not really need to take an infinitesimal step size to control the searching area.

*Proof.* First of all, our requirement on the target accuracy indicates that  $\rho \mu \delta \geq 3 \min \left\{ \frac{1}{2L}, \frac{\mu \delta}{3\rho} \right\} \cdot \epsilon$ . Then the second inequality of Lemma [4.4](#page-20-4) indicates that

$$
\left\|\mathcal{D}_{\phi,h}^{\lambda_k}(x_k)\right\|^2 \ge \epsilon \qquad \Longrightarrow \qquad \Psi(x_{k+1}) \le \Psi(x_k) - \frac{3\min\left\{\frac{1}{2L}, \frac{\mu\delta}{3\rho}\right\}}{4L_h([x_k, x_{k+1}])} \cdot \epsilon. \tag{39}
$$

Combined with the first inequality of Lemma [4.4,](#page-20-4) we have

<span id="page-21-1"></span>
$$
\Psi(x_{k+1}) \leq \Psi(x_k) - \frac{1}{2} \times \frac{3L\mu_h([x_k, x_{k+1}])}{2} \|x_{k+1} - x_k\|^2 - \frac{1}{2} \times \frac{3 \min\left\{\frac{1}{2L}, \frac{\mu\delta}{3\rho}\right\}}{4L_h([x_k, x_{k+1}])} \cdot \epsilon
$$
\n
$$
\leq \Psi(x_k) - \sqrt{\frac{9\mu_h([x_k, x_{k+1}])}{16L_h([x_k, x_{k+1}])} \cdot 2L \cdot \min\left\{\frac{1}{2L}, \frac{\mu\delta}{3\rho}\right\} \cdot \epsilon \|x_{k+1} - x_k\|^2}
$$
\n
$$
\leq \Psi(x_k) - \frac{3}{4} \sqrt{\frac{\epsilon}{\kappa_h^{\delta}} \cdot \min\left\{1, \frac{2L\mu\delta}{3\rho}\right\}} \cdot \|x_{k+1} - x_k\|,
$$

where the last inequality is due to Assumption [2.4](#page-4-1) and  $||x_k - x_{k+1}|| \le \delta$  (Lemma [4.4\)](#page-20-4). This proves the first part of the lemma. Next, we show the bound on the maximum movement before finding an  $\epsilon$ -stationary solution. By the definition of  $T_{\epsilon}$ , we have  $\|\nabla \mathcal{D}^{\lambda_k}_{\phi,h}(x_k)\| > \epsilon$  for  $k \leq T_{\epsilon} - 1$ . As a result

$$
\sum_{k=0}^{T_{\epsilon}-1} \|x_{k+1} - x_k\| \le \frac{4}{3} \sqrt{\max\left\{1, \frac{3\rho}{2L\mu\delta}\right\}} \cdot \frac{\sqrt{\kappa_h^{\delta}} \Delta_{\Psi}}{\sqrt{\epsilon}} = R_{\epsilon}.
$$

Applying triangle inequality to the above bound proves the rest of the lemma.

Finally, given the results of Lemma [4.4](#page-20-4) and Lemma [4.5,](#page-21-0) we have the following theorem.

<span id="page-22-0"></span>**Theorem 4.6.** Let  $\{x_k\}_{k\geq 0}$  be generated by [\(35\)](#page-20-0), for any  $\epsilon \leq \max\{\rho^2, \frac{2L\rho\mu\delta^2}{3}\}$ , with  $R_{\epsilon}$  and  $T_{\epsilon}$ defined by Lemma [4.5](#page-21-0) and let  $\mathcal{X}_{\epsilon} := \text{Lev}_0 \cap B(x_0, R_{\epsilon})$  be a compact set, then we have

$$
T_{\epsilon} \le \max\left\{\frac{8L}{3}, \frac{4\rho}{\mu\delta}\right\} \cdot \frac{L_h(\mathcal{X}_{\epsilon})\Delta_{\Psi}}{\epsilon}
$$

where  $L_h(\mathcal{X}_{\epsilon})$  may depend on  $\epsilon$  if Lev<sub>0</sub> if unbounded. Moreover, the solution  $x_{T_{\epsilon}}$  and  $x_{T_{\epsilon}+1}$  satisfy

$$
\left\|\mathcal{D}^{\lambda_{T_{\epsilon}}}_{\phi,h}(x_{T_{\epsilon}})\right\|^{2} \leq \epsilon \quad \text{and} \quad \text{dist}^{2}\big(0,\partial\Psi(x_{T_{\epsilon}+1})\big) \leq \left(1+\frac{\kappa_{h}^{\delta}}{2}\right)^{2}\epsilon.
$$

In the special case where  $\phi = 0$ , the solution  $x_{T_{\epsilon}}$  satisfies  $\|\mathcal{D}^{\lambda_{T_{\epsilon}}}_{\phi,h}(x_{T_{\epsilon}})\|^2 = \|\nabla \Psi(x_{T_{\epsilon}})\|^2 \leq \epsilon$ .

As a remark, for the polynomial kernel where  $\mu$  and  $\delta$  are  $O(1)$ , the maximal iterations before finding an  $\epsilon$ -stationary point is reduced to  $T_{\epsilon} \leq O\left(\frac{\max\{L,\rho\}\cdot L_h(\mathcal{X}_{\epsilon})\Delta_{\Psi}}{\epsilon}\right)$ .

*Proof.* By Lemma [4.4](#page-20-4) and [4.5,](#page-21-0) it is straightforward that  $\{x_k : k \leq T_{\epsilon}\}\subseteq \text{Lev}_0 \cap B(x_0, R_{\epsilon}) = \mathcal{X}_{\epsilon}$ . Hence,  $L_h([x_k, x_{k+1}]) \leq L_h(\mathcal{X}_{\epsilon}) < +\infty$  for  $k \leq T_{\epsilon} - 1$ . Substituting this upper bound to [\(39\)](#page-20-5) and then summing the resulting inequalities up for  $k \leq T_{\epsilon} - 1$  yields

$$
\Delta_{\Psi} \geq \sum_{k=0}^{T_{\epsilon}-1} \frac{3 \min\left\{\frac{1}{2L}, \frac{\mu \delta}{3\rho}\right\}}{4L_h([x_k, x_{k+1}])} \cdot \epsilon \geq \frac{3 \min\left\{\frac{1}{2L}, \frac{\mu \delta}{3\rho}\right\}}{4L_h(\mathcal{X}_{\epsilon})} \cdot T_{\epsilon} \epsilon,
$$

which proves the first inequality of the theorem. Note that by Lemma [4.4,](#page-20-4) our adaptive step size control strategy guarantees that  $||x_{T_{\epsilon}} - x_{T_{\epsilon}+1}|| \leq \delta$ , then the second inequality of the theorem directly follows Lemma [2.8](#page-7-0) and the fact that  $\lambda_k \leq 1/2L$ . For the differentiable case where  $\phi = 0$ , the result directly follows the definition of  $T_{\epsilon}$  and the fact that  $\mathcal{D}^{\lambda}_{\phi,h}(\cdot) = \nabla f(\cdot) = \nabla \Psi(\cdot)$  for any  $\lambda > 0$ .  $\Box$ 

As commented in the theorem, the constant  $L_h(\mathcal{X}_{\epsilon})$  with  $R_{\epsilon} = O(1/\sqrt{\epsilon})$  potentially depends  $\epsilon$ . For example, for a degree- $(r+2)$  polynomial kernel  $h(x) = \frac{||x||^2}{2} + \frac{||x||^{r+2}}{r+2}$  and suppose the level set Lev<sub>0</sub> is unbounded, the worst-case pessimistic estimation gives  $L_h(\mathcal{X}_{\epsilon}) \leq O(\epsilon^{-\frac{r}{2}})$ , which, by Theorem [4.6,](#page-22-0) suggests that  $T_{\epsilon} \le O(\epsilon^{-\frac{r+2}{2}})$ . Such an iteration complexity for making  $\|\mathcal{D}^{\lambda}_{\phi,h}(\cdot)\|^2 \le \epsilon$  is significantly larger than the  $O(\epsilon^{-1})$  complexity for making  $\|\mathcal{G}^{\lambda}_{\phi,h}(\cdot)\|^2 \leq \epsilon$ . Therefore, it is crucial to verify whether the complexity  $O(\epsilon^{-\frac{r+2}{2}})$  is fundamental for Bregman proximal gradient method or it is just a loose technical artifact. Recall the Example [1](#page-6-0) where the standard Bregman proximal gradient method is analyzed, if the iterations move along the positive direction of  $x_1$  axis, it is not hard to observe that the gradient size  $\|\nabla f(x_1, 0)\|$  is monotonically decreasing in  $x_1$ . According to [\(35\)](#page-20-0) with  $\rho = 0$ , if we set  $\delta \geq \frac{\|\nabla f(x_1^0,0)\|}{2L}$  $\frac{(x_1,0)}{2L}$ , then  $\lambda_k \equiv 1/2L$  and the update rule [\(35\)](#page-20-0) coincides with the standard Bregman proximal gradient method. Then bullet (3) of Example [1](#page-6-0) states that  $\|\nabla f(x_1^k, x_2^k)\|^2 \geq \tilde{\Omega}(k^{-\frac{2}{r+2}})$ , and at least  $\tilde{\Omega}(\epsilon^{-\frac{r+2}{2}})$  iterations are needed to find an  $\epsilon$ -stationary point. Therefore, the potential  $\epsilon$ -dependence in  $L_h(\mathcal{X}_{\epsilon})$  provided by Theorem [4.6](#page-22-0) is a tight characterization of the iteration complexity.

#### 4.3 Adaptive step size control with stochastic variance reduction

Note that the exact gradient norm  $\|\nabla f(\cdot)\|$  is required in the adaptive step size control scheme [\(35\)](#page-20-0), which is inaccessible in the stochastic setting. Moreover, as both  $R_{\epsilon}$  and  $T_{\epsilon}$  are random variables, the complex interplay between them makes a sheer in-expectation analysis insufficient to bound the sample complexity. Instead, a high probability bound will be favorable in the following discussion. Basically, we will still adopt the framework of Algorithm [2,](#page-14-0) while removing the bound constraint  $\mathcal{X}_s$ and the early stop mechanism (Line 6) of each epoch. In other words, we set  $\mathcal{X}_s = \mathbb{R}^d$  in Algorithm [2.](#page-14-0) In addition, we modify the update [\(24\)](#page-13-1) with the following update under adaptive step size control:

$$
\bar{x}_{s,k+1} = \mathbf{T}_{\phi,h}^{\eta_{s,k}}(x_{s,k}, v_{s,k}) \quad \text{with} \quad \eta_{s,k} = \min\left\{\frac{1}{2\kappa_h^{\delta}L}, \frac{\mu\delta}{3\rho}, \frac{\mu\delta}{\|v_{s,k}\|+\rho}\right\},\tag{40}
$$

<span id="page-22-1"></span>
$$
x_{s,k+1} = x_{s,k} + \gamma_{s,k}(\bar{x}_{s,k+1} - x_{s,k}) \quad \text{with} \quad \gamma_{s,k} = \min\left\{1, \frac{\sqrt{\epsilon}/2L(\kappa_h^{\delta})^2}{\|\nabla h(x_{s,k}) - \nabla h(\bar{x}_{s,k+1})\|}\right\}.
$$
 (41)

By slightly modifying the analysis of [\(36\)](#page-20-6) and [\(48\)](#page-29-1), we obtain the following descent result for the update  $(40)$  and  $(41)$ , whose proof is omitted.

<span id="page-23-3"></span>**Lemma 4.7.** Given Assumption [2.4](#page-4-1) and [3.1,](#page-8-2) the update [\(40\)](#page-21-1) and [\(41\)](#page-22-1) satisfy  $\|\bar{x}_{s,k+1}-x_{s,k}\| \leq \delta$  and

<span id="page-23-4"></span>
$$
\Psi(x_{s,k+1}) \leq \Psi(x_{s,k}) - \frac{\gamma_{s,k}}{2\eta_{s,k}} \cdot D_h(\bar{x}_{s,k+1}, x_{s,k}) - \frac{\gamma_{s,k}}{\eta_{s,k}} \cdot D_h(x_{s,k}, \bar{x}_{s,k+1}) + \gamma_{s,k} \|\bar{x}_{s,k+1} - x_{s,k}\| \cdot \|\mathcal{E}_{s,k}\|
$$

where  $\mathcal{E}_{s,k} = \nabla f(x_{s,k}) - v_{s,k}$  is the gradient estimation error.

To establish the counterpart of Lemma [4.4,](#page-20-4) a high probability bound on  $\mathcal{E}_{s,k}$  is required. However, simply applying the standard Azuma-Hoeffding inequality may incur additional dependence on problem dimension. To avoid such a dependence, we need the following large deviation bound for vector-valued martingale in 2-smooth normed spaces from [\[24\]](#page-34-18).

<span id="page-23-0"></span>**Definition 4.8.** Let  $(E, ||| \cdot |||)$  denote a finite-dimensional space E equipped with some norm  $||| \cdot |||$ . We say the space  $(E, ||| \cdot ||)$  (and the norm  $||| \cdot |||$  on E) is  $\kappa$ -regular for some  $\kappa \in [1, +\infty)$ , if there exists a constant  $\kappa_+ \in [1, \kappa]$  and a norm  $||| \cdot |||_+$  on E such that the function  $p(x) := |||x|||_+^2$  is  $\kappa_+$ -smooth and  $|||x|||_+$  is  $\kappa/\kappa_+$ -compatible with  $|||\cdot|||$ . That is, for  $\forall x, y \in E$ , we have

$$
p(x + y) \le p(x) + \langle \nabla p(x), y \rangle + \kappa p(y)
$$
 and  $|||x|||^2 \le |||x|||^2 + \frac{\kappa}{\kappa_+} |||x|||^2$ .

We should notice that the  $\kappa$  and  $\kappa_+$  here has nothing to do with the condition numbers that are widely used throughout the paper.

<span id="page-23-1"></span>**Theorem 4.9** (Theorem 2.1-(ii), [\[24\]](#page-34-18)). Suppose  $(E, ||| \cdot |||)$  is  $\kappa$ -regular for some  $\kappa \geq 1$  and  $\{\zeta_t\}_{t\geq 0}$  is an E-valued martingale difference sequence w.r.t. the filtration  $\{\mathcal{F}_t\}_{t\geq 0}$  and default  $\zeta_0 = 0$ . Suppose  $\{\zeta_t\}_{t\geq0}$  satisfies the following light-tail property:

$$
\mathbb{E}\bigg[\exp\bigg\{\frac{|||\zeta_t|||^{\alpha}}{\sigma_t^{\alpha}}\bigg\} \mid \mathcal{F}_{t-1}\bigg] \le \exp\{1\}, \quad \forall t \ge 1.
$$

When  $\alpha = 2$ , for any  $N, \gamma \geq 0$ , it holds that

$$
\text{Prob}\left(\left|\left|\left|\sum_{i=0}^N \zeta_i\right|\right|\right| \geq (\sqrt{\kappa} + \gamma)\sqrt{2\sum_{i=0}^N \sigma_i^2}\right) \leq \exp\left\{-\frac{\gamma^2}{3}\right\}.
$$

Consider  $(\mathbb{R}^d, \|\cdot\|)$  where  $\|\cdot\|$  stands for the standard Euclidean (L-2) norm that we use throughout this paper. Setting  $\kappa = \kappa_+ = 1$  and  $|||\cdot||| = |||\cdot|||_+ = ||\cdot||$  in Definition [4.8,](#page-23-0) then straight computation shows that  $(\mathbb{R}^d, \|\cdot\|)$  is 1-regular. As a result, we have the following bound for  $\mathcal{E}_{s,k}$ .

<span id="page-23-2"></span>**Lemma 4.10.** Suppose Assumptions [2.4](#page-4-1) and [3.1](#page-8-2) hold. For any epoch  $s \ge 1$  and let  $p_s = \frac{6q}{\pi^2 s^2 \tau}$  for some  $q \in (0,1)$ . Suppose we select  $|\mathcal{B}_{s,k}| = b_s$  for all  $0 \le k \le \tau - 1$ , then

$$
\|\mathcal{E}_{s,k}\| \leq \left(1 + \sqrt{3\ln\left(\frac{1}{p_s}\right)}\right) \cdot \frac{\sqrt{2\tau\epsilon} \cdot L_{\max}}{\sqrt{b_s} \cdot L\kappa_h^{\delta}}
$$

with probability at least  $1 - p_s$ .

*Proof.* Fix any epoch index  $s \geq 1$ , consider the sequence  $\{\zeta_{k,j}^s\}$  defined as

$$
\zeta_{k,j}^s = \frac{1}{|\mathcal{B}_{s,k}|} \left( \left( \nabla f_{\xi_{k,j}^s}(x_{s,k}) - \nabla f_{\xi_{k,j}^s}(x_{s,k-1}) \right) - \left( \nabla f(x_{s,k}) - \nabla f(x_{s,k-1}) \right) \right).
$$

In the above definition, the index k runs through  $1 \leq k \leq \tau-1$ , and the index j can take value from  $1 \leq j \leq |\mathcal{B}_{s,k}|$  given each k. For each  $(k, j)$  in our index range,  $\xi_{k,j}^s$  stands for the j-th sample from the batch  $\mathcal{B}_{s,k} \subseteq [n]$ . Then by direct computation, we have  $\mathcal{E}_{s,k} = \sum_{k'=1}^{k} \sum_{j=1}^{|\mathcal{B}_{s,k'}|} \zeta_{k',j}^s$  and  $\{\zeta_{k,j}^s\}$  forms a

martingale difference sequence if the index  $(k, j)$  runs in a lexicographical order. Note that

$$
\begin{array}{rcl}\n\|\zeta_{k,j}^s\| & \leq & \frac{2L_{\max}L_h([x_{s,k-1},x_{s,k}])\|x_{s,k-1}-x_{s,k}\|}{b_s} \\
& \leq & \frac{2L_{\max}L_h([x_{s,k-1},x_{s,k}])}{b_s} \cdot \frac{\sqrt{\epsilon}/2L(\kappa_h^{\delta})^2}{\|\nabla h(x_{s,k-1}) - \nabla h(\bar{x}_{s,k})\|} \cdot \|x_{s,k-1} - \bar{x}_{s,k}\| \\
& \leq & \frac{2L_{\max}L_h([x_{s,k-1},x_{s,k}])}{b_s} \cdot \frac{\sqrt{\epsilon}/2L(\kappa_h^{\delta})^2}{\mu_h([x_{s,k-1},\bar{x}_{s,k}])\|x_{s,k-1} - \bar{x}_{s,k}\|} \cdot \|x_{s,k-1} - \bar{x}_{s,k}\|\n\end{array}
$$

where the last inequality is because  $||x_{s,k-1} - \bar{x}_{s,k}|| \leq \delta$ , Assumption [2.4,](#page-4-1) and the fact that

$$
\gamma_{s,k} \leq 1 \quad \Longrightarrow \quad [x_{s,k-1}, x_{s,k}] \subseteq [x_{s,k-1}, \bar{x}_{s,k}] \quad \Longrightarrow \quad L_h([x_{s,k-1}, x_{s,k}]) \leq L_h([x_{s,k-1}, \bar{x}_{s,k}]).
$$

As this bound holds almost surely, we have  $\mathbb{E}\left[\exp\left\{\frac{\|\zeta_{k,j}^s\|^2}{(L_{\max}\sqrt{\epsilon}/L\kappa_h^{\delta}b_s)^2}\right\}\right] \leq \exp\{1\}$ . Applying Theorem [4.9](#page-23-1) to this martingale difference sequence gives

$$
\text{Prob}\left(\|\mathcal{E}_{s,k}\| \ge \frac{(1+\gamma)\sqrt{2\tau\epsilon} \cdot L_{\max}}{\sqrt{b_s} \cdot L\kappa_h^{\delta}}\right) \le \exp\left\{-\frac{\gamma^2}{3}\right\}.
$$

Finally, setting  $\gamma = \sqrt{3\ln(1/p_s)}$  gives  $\exp{\{-\gamma^2/3\}} = p_s$ , which proves the lemma.

Let us define  $\widetilde{\mathcal{D}}_{\phi, h}^{\eta_{s,k}}(x_{s,k}) := \frac{\nabla h(x_{s,k}) - \nabla h(\bar{x}_{s,k+1})}{\eta_{s,k}}$  as the stochastic surrogate of the the exact Bregman proximal gradient mapping  $\mathcal{D}_{\phi,h}^{\eta_{s,k}}(x_{s,k})$ , then we have the following lemma.

<span id="page-24-0"></span>**Lemma 4.11.** Let us set  $\tau = \lceil \sqrt{n} \rceil$ , and  $|\mathcal{B}_{s,k}| = b_s = 8 \lceil \sqrt{n} \rceil (2 + 6 \ln(1/p_s)) L_{\max}^2 / L^2$ . For  $(s, k)$ -th iteration of the update [\(40\)](#page-21-1) and [\(41\)](#page-22-1), as long as  $\|\widetilde{\mathcal{D}}_{\phi,h}^{n_{s,k}}(x_{s,k})\|^2 \geq \epsilon$ , it holds w.p. at least  $1-p_s$  that

$$
\Psi(x_{s,k+1}) \leq \Psi(x_{s,k}) - \frac{\sqrt{\epsilon} \|x_{s,k+1} - x_{s,k}\|}{4\kappa_h^{\delta}}.
$$

Suppose the target accuracy satisfies  $\epsilon \leq \max\left\{2L\kappa_h^{\delta}\mu\delta\rho/3,\rho^2\right\}$ , then we also have

$$
\Psi(x_{s,k+1}) \leq \Psi(x_{s,k}) - \frac{\min\{1/2\kappa_h^{\delta}L, \frac{\mu\delta}{3\rho}\} \cdot \epsilon}{4(\kappa_h^{\delta})^2 L_h([x_{s,k}, \bar{x}_{s,k+1}])}.
$$

*Proof.* First of all, by Lemma [4.10,](#page-23-2) setting  $b_s = 8\lceil \sqrt{n} \rceil (2 + 6\ln(1/p_s)) L_{\text{max}}^2/L^2$  gives

$$
\text{Prob}\left(\left\|\mathcal{E}_{s,k}\right\| \le \frac{\sqrt{\epsilon}}{2\kappa_h^{\delta}}\right) \ge 1 - p_s. \tag{42}
$$

Given  $\|\widetilde{\mathcal{D}}_{\phi, h}^{\eta_{s,k}}(x_{s,k})\| \geq \sqrt{\epsilon}$ , we have with probability at least  $1 - p_s$  that

$$
\frac{\gamma_{s,k}}{\eta_{s,k}} \cdot D_h(\bar{x}_{s,k+1}, x_{s,k}) - \gamma_{s,k} \cdot ||\bar{x}_{s,k+1} - x_{s,k}|| \cdot ||\mathcal{E}_{s,k}|| \n\geq \frac{\gamma_{s,k}}{\eta_{s,k}} \cdot \frac{||\nabla h(x_{s,k}) - \nabla h(\bar{x}_{s,k+1})||^2}{2L_h([x_{s,k}, \bar{x}_{s,k+1}])} - \gamma_{s,k} \cdot ||\bar{x}_{s,k+1} - x_{s,k}|| \cdot \frac{\sqrt{\epsilon}}{2\kappa_0^{\delta}} \n\geq \frac{\gamma_{s,k}}{\eta_{s,k}} \cdot \frac{\mu_h([x_{s,k}, \bar{x}_{s,k+1}]) \cdot ||x_{s,k} - \bar{x}_{s,k+1}|| \cdot ||\nabla h(x_{s,k}) - \nabla h(\bar{x}_{s,k+1})||}{2L_h([x_{s,k}, \bar{x}_{s,k+1}])} - \gamma_{s,k} \cdot ||\bar{x}_{s,k+1} - x_{s,k}|| \cdot \frac{\sqrt{\epsilon}}{2\kappa_h^{\delta}} \n\geq \gamma_{s,k} ||\bar{x}_{s,k+1} - x_{s,k}|| \cdot \left( \frac{||\widetilde{\mathcal{D}}_{\phi,h}^{\eta_{s,k}}(x_{s,k})||}{2\kappa_h^{\delta}} - \frac{\sqrt{\epsilon}}{2\kappa_h^{\delta}} \right) \n\geq 0.
$$

Combining the above inequality with Lemma [4.7,](#page-23-3) we have

$$
\Psi(x_{s,k+1}) \leq \Psi(x_{s,k}) - \frac{\gamma_{s,k}}{2\eta_{s,k}} \cdot D_h(\bar{x}_{s,k+1}, x_{s,k})
$$
\n
$$
\leq \Psi(x_{s,k}) - \gamma_{s,k} \|\bar{x}_{s,k+1} - x_{s,k}\| \cdot \frac{\|\widetilde{\mathcal{D}}_{\phi,h}^{\eta_{s,k}}(x_{s,k})\|}{4\kappa_h^{\delta}}
$$
\n
$$
= \Psi(x_{s,k}) - \frac{\|x_{s,k+1} - x_{s,k}\| \cdot \|\widetilde{\mathcal{D}}_{\phi,h}^{\eta_{s,k}}(x_{s,k})\|}{4\kappa_h^{\delta}}
$$
\n
$$
\leq \Psi(x_{s,k}) - \frac{\sqrt{\epsilon} \|x_{s,k+1} - x_{s,k}\|}{4\kappa_h^{\delta}}.
$$
\n(43)

This proves the first inequality of the lemma. Next, let us prove the  $\Psi(x_{s,k+1}) \leq \Psi(x_{s,k}) - \Omega(\epsilon)$  result by discussing the following cases:

case 1. When  $\gamma_{s,k} = \frac{\sqrt{\epsilon}/2L(\kappa_h^{\delta})^2}{\|\nabla h(x_{s,k}) - \nabla h(\bar{x}_{s,k})\|}$  $\frac{\sqrt{\epsilon/2L(\kappa_h)}}{\|\nabla h(x_{s,k})-\nabla h(\bar{x}_{s,k+1})\|}$ , regardless of  $\eta_{s,k}$ , the second row of [\(43\)](#page-25-0) indicates that

$$
\Psi(x_{s,k+1}) \leq \Psi(x_{s,k}) - \frac{\sqrt{\epsilon} ||\bar{x}_{s,k+1} - x_{s,k}||/2L(\kappa_h^{\delta})^2}{\|\nabla h(x_{s,k}) - \nabla h(\bar{x}_{s,k+1})\|} \cdot \frac{\|\widetilde{D}_{\phi,h}^{\eta_{s,k}}(x_{s,k})\|}{4\kappa_h^{\delta}} \n\leq \Psi(x_{s,k}) - \frac{\sqrt{\epsilon} \cdot \|\widetilde{D}_{\phi,h}^{\eta_{s,k}}(x_{s,k})\|}{8L(\kappa_h^{\delta})^3 L_h([x_{s,k}, \bar{x}_{s,k+1}])} \n\leq \Psi(x_{s,k}) - \frac{\epsilon}{8L(\kappa_h^{\delta})^3 L_h([x_{s,k}, \bar{x}_{s,k+1}])}.
$$

case 2. If  $\gamma_{s,k} = 1$  and  $\eta_{s,k} = \frac{\mu \delta}{\|v_{s,k}\|+\rho}$ . This case may happen only if  $\frac{\mu \delta}{\|v_{s,k}\|+\rho} \leq \frac{\mu \delta}{3\rho}$ , namely, only if  $||v_{s,k}|| \ge 2\rho$ . Note that  $\tilde{\mathcal{D}}_{\phi, h}^{n_{s,k}}(x_{s,k}) = v_{s,k} + u_{s,k+1}$  for some  $u_{s,k+1} \in \partial \phi(\bar{x}_{s,k+1})$ , in this case, we have  $\|\tilde{\mathcal{D}}_{\phi,h}^{\eta_{s,k}}(x_{s,k})\| \geq \|v_{s,k}\| - \rho \geq \rho$ . Then the second row of [\(43\)](#page-25-0) gives

$$
\Psi(x_{s,k+1}) \leq \Psi(x_{s,k}) - 1 \cdot \|\bar{x}_{s,k+1} - x_{s,k}\| \cdot \frac{\|\widetilde{\mathcal{D}}_{\phi,h}^{\eta_{s,k}}(x_{s,k})\|}{4\kappa_h^{\delta}} \n\leq \Psi(x_{s,k}) - \frac{\|\nabla h(x_{s,k}) - \nabla h(\bar{x}_{s,k+1})\|}{L_h([x_{s,k}, \bar{x}_{s,k+1}])} \cdot \frac{\|\widetilde{\mathcal{D}}_{\phi,h}^{\eta_{s,k}}(x_{s,k})\|}{4\kappa_h^{\delta}} \n= \Psi(x_{s,k}) - \frac{\|\widetilde{\mathcal{D}}_{\phi,h}^{\eta_{s,k}}(x_{s,k})\|}{4\kappa_h^{\delta}L_h([x_{s,k}, \bar{x}_{s,k+1}])} \cdot \eta_{s,k} \|\widetilde{\mathcal{D}}_{\phi,h}^{\eta_{s,k}}(x_{s,k})\| \n= \Psi(x_{s,k}) - \frac{\|\widetilde{\mathcal{D}}_{\phi,h}^{\eta_{s,k}}(x_{s,k})\|}{4\kappa_h^{\delta}L_h([x_{s,k}, \bar{x}_{s,k+1}])} \cdot \frac{\mu\delta\|v_{s,k} + u_{s,k+1}\|}{\|v_{s,k}\| + \rho} \n\leq \Psi(x_{s,k}) - \frac{\mu\delta\rho}{12\kappa_h^{\delta}L_h([x_{s,k}, \bar{x}_{s,k+1}])}.
$$
\n(44)

case 3. If  $\gamma_{s,k} = 1$  and  $\eta_{s,k} = \min\left\{\frac{1}{2\kappa_b^{\delta}L}, \frac{\mu\delta}{3\rho}\right\}$ . In this case, the third row of [\(44\)](#page-25-1) indicates that

$$
\Psi(x_{s,k+1}) \leq \Psi(x_{s,k}) - \frac{\|\widetilde{\mathcal{D}}_{\phi,h}^{\eta_{s,k}}(x_{s,k})\|}{4\kappa_h^{\delta} L_h([x_{s,k}), \bar{x}_{s,k+1}])} \cdot \eta_{s,k} \|\widetilde{\mathcal{D}}_{\phi,h}^{\eta_{s,k}}(x_{s,k})\|
$$
  

$$
\leq \Psi(x_{s,k}) - \frac{\min\left\{\frac{1}{2\kappa_h^{\delta} L}, \frac{\mu_{\phi}}{3\rho}\right\}}{4\kappa_h^{\delta} L_h([x_{s,k}), \bar{x}_{s,k+1}])} \cdot \epsilon.
$$

Combining cases 1,2, and 3, we know the least descent among the three cases are guaranteed to be achieved. Note that if  $\epsilon \leq \max\left\{2L\kappa_h^{\delta}\mu\delta\rho/3, \rho^2\right\}$ , direct computation shows that  $\frac{\min\{1/2\kappa_h^{\delta}L, \frac{\mu\delta}{3\rho}\}\cdot\epsilon}{4(\kappa_h^{\delta})^2L_h([x_{\epsilon}, k, \bar{x}_{\epsilon}, k+1])}$  $4(\kappa_{h}^{\delta})^{2}L_{h}([x_{s,k},x_{s,k+1}])$ lower bounds the descents in all three cases, which completes the proof.

Consequently, define  $(S_{\epsilon}, K_{\epsilon}) := \operatorname{argmin}_{s,k} \left\{ (s-1)\tau + k : \|\tilde{\mathcal{D}}_{\phi, h}^{\eta_{s,k}}(x_{s,k})\|^2 \leq \epsilon \right\}$  as the first time that we find a point  $\|\widetilde{\mathcal{D}}_{\phi,h}^{\eta_{s,k}}(x_{s,k})\|^2 \leq \epsilon$ , and set  $R_{\epsilon} := \max_{s,k} \left\{ \|x_{s,k} - x_{1,0}\| : (s-1)\tau + k \leq (S_{\epsilon} - 1)\tau + K_{\epsilon} \right\}$  as the maximum traveling distance until finding such a point. Then the following theorem holds while the proof is omitted.

**Theorem 4.12.** Let us set the parameters according to Lemma [4.10](#page-23-2) and [4.11.](#page-24-0) Consider the target  $accuracy \epsilon \le \max\left\{2L\kappa_h^{\delta}\mu\delta\rho/3, \rho^2\right\}, let \mathcal{X}_{\epsilon} := \text{Lev}_0 \cap B(x_{1,0}, R_{\epsilon})$  be a compact set, then with probability at least  $1 - q$ , all the following arguments hold:

$$
R_{\epsilon} \leq \frac{4\kappa_{h}^{\delta} \Delta_{\Psi}}{\sqrt{\epsilon}} \quad \text{and} \quad S_{\epsilon} \leq \frac{\max\{8\kappa_{h}^{\delta} L, \frac{12\rho}{\mu \delta}\} \cdot (\kappa_{h}^{\delta})^{2} L_{h}(\mathcal{X}_{s}) \cdot \Delta_{\Psi}}{\epsilon \tau} + 1.
$$

Moreover, we have  $\|\mathcal{D}_{\phi,h}^{\eta_{S_{\epsilon},K_{\epsilon}}}(x_{S_{\epsilon},K_{\epsilon}})\|^2 \leq 2.5\epsilon$ . The total samples consumed is  $\sum_{s=1}^{S_{\epsilon}} n+\tau b_s = \widetilde{O}(\sqrt{n}/\epsilon)$ , where  $\tilde{O}(\cdot)$  hides the poly-logarithmic terms in q and  $\epsilon$ .

*Proof.* The bounds on  $R_{\epsilon}$  and  $S_{\epsilon}$  are straightforward consequence of Lemma [4.11.](#page-24-0) We only need to show the bound of exact Bregman proximal gradient mapping. For notational simplicity, let us denote  $(s, k) = S_{\epsilon}, K_{\epsilon}$ . Then by definition, we have  $\|\widetilde{\mathcal{D}}_{\phi, h}^{\eta_{s,k}}(x_{s,k})\|^2 \leq \epsilon$ . Let  $\hat{x}_{s,k+1} := \mathbf{T}_{\phi, h}^{\eta_{s,k}}(x_{s,k}, \nabla f(x_{s,k}))$  be the ideal intermediate update point that uses the exact gradient  $\nabla f(x_{s,k})$ , hence the exact gradient mapping will be  $\mathcal{D}_{\phi,h}^{\eta_{s,k}}(x_{s,k}) = \frac{\nabla h(x_{s,k}) - \nabla h(\hat{x}_{s,k+1})}{\eta_{s,k}}$ . By the proof of Lemma [3.2](#page-9-6) and [\(42\)](#page-23-4), we have

$$
\|\hat{x}_{s,k+1} - \bar{x}_{s,k+1}\| \leq \frac{\eta_{s,k} \|\mathcal{E}_{s,k}\|}{\mu_h(B(x_{s,k}, \delta))} \leq \frac{\eta_{s,k}\sqrt{\epsilon}}{2\kappa_h^{\delta} \cdot \mu_h(B(x_{s,k}, \delta))}.
$$

Consequently, with  $\widetilde{\mathcal{D}}_{\phi, h}^{\eta_{s,k}}(x_{s,k}) = \frac{\nabla h(x_{s,k}) - \nabla h(\bar{x}_{s,k+1})}{\eta_{s,k}},$  we further obtain that

$$
\left\|\mathcal{D}_{\phi,\,h}^{\eta_{s,k}}(x_{s,k})-\widetilde{\mathcal{D}}_{\phi,\,h}^{\eta_{s,k}}(x_{s,k})\right\|=\Big\|\frac{\nabla h(x_{s,k})-\nabla h(\bar{x}_{s,k+1})}{\eta_{s,k}}-\frac{\nabla h(x_{s,k})-\nabla h(\hat{x}_{s,k+1})}{\eta_{s,k}}\Big\|\leq \sqrt{\epsilon}/2.
$$

Using the fact that  $||a+b||^2 \leq 2(||a||^2 + ||b||^2)$ , we finish the proof of  $||\mathcal{D}_{\phi,h}^{\eta_{s,k}}(x_{s,k})||^2 \leq 2.5\epsilon$ .

## <span id="page-26-0"></span>5 Comparison and conclusion

Comparison. After establishing the convergence and complexities of the (deterministic or stochastic variance reduced) Bregman proximal gradient methods under both the old and new gradient mappings, it is crucial to make a thorough comparison between them. For general composite (deterministic or stochastic) nonconvex optimization of form  $(1)$ , suppose we aim to find some solution  $\bar{x}$  such that

$$
\operatorname{dist}^2(0, \partial \Psi(\bar{x})) \le \epsilon \tag{45}
$$

either deterministically, in expectation, or with high probability.

In the deterministic setting, the existing results [\[4,](#page-33-0) [16,](#page-34-4) [17,](#page-34-5) [28,](#page-34-3) [36,](#page-35-3) etc.] typically guarantee that  $\|\mathcal{G}^{\lambda}_{\phi,h}(x_{\text{out}})\|^2 \leq O\left(\frac{L\Delta_{\Psi}}{T}\right)$ . Assuming the level set Lev<sub>0</sub> to be compact and following Remark [2.9,](#page-8-3) the existing analysis based on the old gradient mapping can provide an iteration complexity of  $O(\frac{LL_h^2(\text{Levo})\Delta_{\Psi}}{\epsilon})$  for finding some  $\bar{x}$  that satisfies [\(45\)](#page-26-1), which can be improved to  $O(\frac{LL_h(\text{Levo})\Delta_{\Psi}}{\epsilon})$  by adopting a similar approach of [\(10\)](#page-6-1). On the other hand, based on the analysis of the new gradient map-ping provided in Section [4,](#page-18-0) with additional  $\rho$ -Lipschitz continuity assumption on the non-differentiable term  $\phi$ , it takes  $O\left(\frac{\max\{L,\rho\}\cdot L_h(\mathcal{X}_{\epsilon})\Delta_{\Psi}}{\epsilon}\right)$  iterations to find an  $\bar{x}$  that satisfies [\(45\)](#page-26-1). Because  $\mathcal{X}_{\epsilon} \subseteq \text{Lev}_0$ , it always holds that  $L_h(\mathcal{X}_\epsilon) \leq L_h(\text{Lev}_0)$ . Comparing the two results, it can be observed that the old analysis is more flexible in terms of the  $\phi$ , while being more restrictive in terms of the compactness of the level set Lev<sub>0</sub>. If the level set Lev<sub>0</sub> is not much larger than  $\mathcal{X}_{\epsilon}$  in the sense that  $L_h(\text{Lev}_0)$  and  $L_h(\mathcal{X}_{\epsilon})$  are having similar magnitudes, then the existing analysis based on the old gradient mapping can provide a comparable iteration complexity as that provided by our Theorem [4.6.](#page-22-0) However, if  $Lev<sub>0</sub>$ is compact but much larger than  $\mathcal{X}_{\epsilon}$ , then our new analysis will provide a much tighter bound on iteration complexity. If Lev<sub>0</sub> is unbounded so that  $L_h(\text{Lev}_0) = +\infty$ , then the existing analyses fail.

In the stochastic setting, let us consider the finite-sum case for example. After adopting the epoch In the stochastic setting, i.et us consider the limit-sum case for example. After adopting the epoch bound mechanism and the probabilistic argument in Section [3,](#page-8-0) we require  $O(\frac{\sqrt{n}L\psi}{\epsilon})$  to obtain some  $\bar{x}$  such that  $\|\mathcal{G}_{\phi,h}^{\eta}\|^2 \leq O(\epsilon')$  in conditional-expectation of some high probability event A. Unlike the deterministic case where the iteration sequence provably stays in the level set  $Lev<sub>0</sub>$ , the randomness of the algorithm gives a probability of the iteration sequence to move outside  $\text{Lev}_0$ . Based on the compactness of Lev<sub>0</sub>, if it one is able to show that  $\{x_k\}$  is almost surely bounded in some compact set X (see e.g. [\[9,](#page-33-1) Theorem 19]), then one may set  $\epsilon' = \epsilon/L_h^2(\mathcal{X})$  s.t.  $\bar{x}$  satisfies [\(45\)](#page-26-1) with a sample complexity of  $O(\frac{\sqrt{n}L L_h^2(\chi)\Delta_\Psi}{\epsilon})$ . If more careful analysis is adopted, an improved complexity of  $O(\frac{\sqrt{n}L L_h(\chi)\Delta_\Psi}{\epsilon})$ can be possible. If all the "if" arguments in the above discussion are done, and the set  $\mathcal{X}$  (agnostic to users) is not much larger than  $\mathcal{X}_{\epsilon}$  in sense that  $L_h(\mathcal{X})$  and  $L_h(\mathcal{X}_{\epsilon})$  share a similar magnitude, then the complexity provided by the analysis of old gradient mapping can be comparable to that provided by the analysis based on new gradient mapping. However, if  $Lev<sub>0</sub>$  is unbounded, then all the analysis based on the old gradient mapping can fail to provide stationarity of the output solutions.

Conclusion and future works. Several important questions in the Bregman proximal gradient methods for solving nonconvex composite stochastic optimization problems are considered in this paper. We reveal several weaknesses of the current widely adopted Bregman proximal gradient mapping  $\mathcal{G}_{\phi,h}^{\lambda}(\cdot)$ , including the potential inability to capture stationarity for unbounded problems and the sensitivity to the choice of kernel  $h$ . We resolve this issue by proposing an alternative gradient mapping  $\mathcal{D}^{\lambda}_{\phi,h}(\cdot)$  that is provably comparable with the standard near-stationarity measure dist $(0,\partial\Psi(\cdot))$ . We also propose a new kernel-conditioning regularity assumption that enables us to exploit the variance reduction techniques in the stochastic setting. An improved sample complexity under the old gradient mapping as well as brand-new complexity results and analysis techniques under the new gradient mapping are provided in this paper. In terms of future works, a potential interesting direction could be studying the proper form of kernel-conditioning regularity for smooth-adaptable functions  $h$  with dom(h)  $\subsetneq \mathbb{R}^d$  while being singular on  $\partial \text{dom}(h)$ , for which the examples can be found in [\[30\]](#page-34-2).

## A Supporting Lemmas

<span id="page-27-2"></span>**Lemma A.1** (Three-Point Property of Tseng [\[37\]](#page-35-6)). Let  $\phi(x)$  be a convex function, and let  $D_h(\cdot, \cdot)$  be the Bregman distance for h( $\cdot$ ). For a given vector z, let  $z_+ := \operatorname{argmin}_{x \in Q} \phi(x) + D_h(x, z)$ . Then

$$
\phi(x) + D_h(x, z) \ge \phi(z_+) + D_h(z_+, z) + D_h(x, z_+), \quad \forall x \in Q.
$$

<span id="page-27-1"></span>**Lemma A.2** (Lemma 2 finite-sum case of [\[35\]](#page-35-1)). Let  $v_{s,k}$  be generated by [\(12\)](#page-9-1), suppose  $|\mathcal{B}_{s,k}| = b$  and the sampled index are uniformly randomly picked from [n] with replacement, then

$$
\mathbb{E}\Big[\|\nabla f(x_{s,k}) - v_{s,k}\|^2 \, \big| \, x_{s,0}\Big] \leq \sum_{j=0}^{k-1} \mathbb{E}\Big[\|v_{s,j+1} - v_{s,j}\|^2 - \|\nabla f(x_{s,j+1}) - \nabla f(x_{s,j})\|^2 \, \big| \, x_{s,0}\Big],
$$

where the expectation term of  $||v_{s,j+1} - v_{s,j}||^2$  satisfies

$$
\mathbb{E}\Big[\|v_{s,j+1}-v_{s,j}\|^2\,\big|\,x_{s,0}\Big]\leq \mathbb{E}\bigg[\|\nabla f(x_{s,j+1})-\nabla f(x_{s,j})\|^2+\frac{1}{bn}\sum_{i=1}^n\|\nabla f_i(x_{s,j+1})-\nabla f_i(x_{s,j})\|^2\,\big|\,x_{s,0}\bigg].
$$

In particular, we have slightly modified the second inequality to suit our analysis.

<span id="page-27-3"></span>**Lemma A.3** (Lemma 2 general expectation case of [\[35\]](#page-35-1)). Let  $v_{s,k}$  be generated by [\(12\)](#page-9-1), suppose  $\mathcal{B}_{s,k}$ 's are i.i.d. mini-batches of size b sampled from the distribution of  $\xi$ , then the first inequality of Lemma [A.2](#page-27-1) still holds while the second inequality becomes

$$
\mathbb{E}\Big[\|v_{s,j+1}-v_{s,j}\|^2\,\big|\,x_{s,0}\Big]\leq \mathbb{E}\bigg[\|\nabla f(x_{s,j+1})-\nabla f(x_{s,j})\|^2+\frac{1}{b}\mathbb{E}_{\xi}\Big[\|\nabla f_{\xi}(x_{s,j+1})-\nabla f_{\xi}(x_{s,j})\|^2\Big]\,\big|\,x_{s,0}\bigg]\,,
$$

where the inner expectation is conditioned on  $x_{s,j}$  and  $x_{s,j+1}$ , and is only taken w.r.t.  $\xi$ .

Denote  $\widetilde{\mathcal{G}} = \frac{x_{s,k}-x_{s,k+1}}{\lambda}$ , then  $\|\mathcal{G}^{\lambda}_{\phi+\text{id}_{\mathcal{X}_s},h}(x_{s,k})-\widetilde{\mathcal{G}}\| = \frac{1}{\lambda}\|x_{s,k+1}-\hat{x}_{s,k+1}\|$  holds by definition. By the optimality of  $\hat{x}_{s,k+1}$  and  $x_{s,k+1}$  for the corresponding subproblems, Tseng's three point property (Lemma [A.1\)](#page-27-2) indicates that

\langle v_{s,k}, x_{s,k+1} \rangle + \phi(x_{s,k+1}) + \frac{D_h(x_{s,k+1}, x_{s,k})}{\lambda} + \frac{D_h(\hat{x}_{s,k+1}, x_{s,k+1})}{\lambda}
$$
  

$$
\leq \langle v_{s,k}, \hat{x}_{s,k+1} \rangle + \phi(\hat{x}_{s,k+1}) + \frac{D_h(\hat{x}_{s,k+1}, x_{s,k})}{\lambda}
$$

and

$$
\langle \nabla f(x_{s,k}), \hat{x}_{s,k+1} \rangle + \phi(\hat{x}_{s,k+1}) + \frac{D_h(\hat{x}_{s,k+1}, x_{s,k})}{\lambda} + \frac{D_h(x_{s,k+1}, \hat{x}_{s,k+1})}{\lambda}
$$
  

$$
\leq \langle \nabla f(x_{s,k}), x_{s,k+1} \rangle + \phi(x_{s,k+1}) + \frac{D_h(x_{s,k+1}, x_{s,k})}{\lambda}
$$

Summing up the two inequalities and applying Lemma [2.6](#page-5-0) gives

$$

Hence  $\|\hat{x}_{s,k+1}-x_{s,k+1}\| \leq \frac{\lambda \|v_{s,k}-\nabla f(x_{s,k})\|}{\mu_h([x_{s,k+1},\hat{x}_{s,k+1}])}$ , and  $\|\mathcal{G}^{\lambda}_{\phi+\text{id}_{\mathcal{X}_s},h}(x_{s,k})-\widetilde{\mathcal{G}}\| \leq \frac{\|v_{s,k}-\nabla f(x_{s,k})\|}{\mu_h([x_{s,k+1},\hat{x}_{s,k+1}])}$ . As a result,

\left\|\mathcal{G}^{\lambda}_{\phi+\mathrm{id}_{\mathcal{X}_s},h}(x_{s,k})\right\|^2 \leq \left(\left\|\widetilde{\mathcal{G}}\right\| + \left\|\mathcal{G}^{\lambda}_{\phi+\mathrm{id}_{\mathcal{X}_s},h}(x_{s,k}) - \widetilde{\mathcal{G}}\right\|\right)^2 \leq \frac{2\|x_{s,k} - x_{s,k+1}\|^2}{\lambda^2} + \frac{2\|v_{s,k} - \nabla f(x_{s,k})\|^2}{\mu_h^2(\mathcal{X}_s)},
$$

where the last inequality is because  $(a+b)^2 \leq 2a^2 + 2b^2$  and  $\mu_h^2([x_{s,k+1}, \hat{x}_{s,k+1}]) \geq \mu_h^2(\mathcal{X}_s)$ .  $\Box$

+ \frac{\mu_h(\mathcal{X}_s) || x_{s,k} - x_{s,k+1} ||^2}{2 \cdot 2\lambda} + \frac{2\lambda ||\mathcal{E}_{s,k}||^2}{2 \cdot \mu_h(\mathcal{X}_s)}.

Adding  $(15) \times \frac{\lambda \mu_h(\mathcal{X}_s)}{8}$  $(15) \times \frac{\lambda \mu_h(\mathcal{X}_s)}{8}$  to the above inequality and applying Lemma [2.6](#page-5-0) proves the lemma.

where (i) is due to [\(52\)](#page-30-4) and [\(29\)](#page-16-1), both (ii) and (iii) are due to setting  $m_1^* = S/4$ ,  $B = \frac{320b\tau}{\mu\delta^2 L^2(\kappa_h^{\delta})^2 q}$ , and  $S = \left\lceil \frac{256\gamma \tau \Delta_{\Psi}}{\mu \eta \delta^2 q} \right\rceil$  in Lemma [D.2,](#page-30-5) as well as the choice of  $q < 1/2$ ,  $\gamma = \frac{\sqrt{b}}{L(\kappa_b^{\delta})\sqrt{\tau}}$ , and the fact that  $\eta \leq \sqrt{2/7} < 1$ . Given the above parameter selections, straight computation gives  $\text{Prob}(\mathcal{A}_1(m_1^*)) \leq q$ ,  $\text{Prob}(\mathcal{A}_2(m_2)) \leq \frac{128\eta(1+\eta)\Delta_{\Psi}}{\gamma\mu\delta^2 \cdot m_2}$ , and  $\frac{32\gamma\Delta_{\Psi}}{\mu\eta\delta^2} + \frac{40S\tau\gamma^2}{B\mu\delta^2} \leq \frac{S}{8\tau}$ . Therefore, to maximize the above probability, we can choose  $m_2^* = \sqrt{\frac{S\tau \eta \Delta \Psi}{\gamma \mu}} \cdot \frac{32\sqrt{2}}{3\delta}$  such that

$$
\frac{256 \eta \Delta_\Psi}{m_2^* \gamma \mu \delta^2} + \frac{9 m_2^*}{8 S \tau} = 2 \sqrt{\frac{256 \eta \Delta_\Psi}{m_2^* \gamma \mu \delta^2} \cdot \frac{9 m_2^*}{8 S \tau}} = \frac{3 \eta \sqrt{q}}{\sqrt{2} \gamma \tau} \leq 2 L(\kappa_h^\delta) \sqrt{\frac{q}{\tau b}} \leq 2 L(\kappa_h^\delta) \sqrt{\epsilon} \,.
$$

Combining all the above discussion, we conclude that

$$
\mathrm{Prob}\left(\mathcal{A}\right) \ge 1 - 1 - 2L(\kappa_h^{\delta})\sqrt{\epsilon} = 1 - O(q + \sqrt{\epsilon})
$$

when taking  $m_1^* = S/4$  and  $m_2^* = \sqrt{\frac{S\tau\eta\Delta\Psi}{\gamma\mu}} \cdot \frac{32}{3\delta}$ . Note that the requirement on  $\epsilon$  further implies that Prob $(\mathcal{A}_1(m_1^*)) \leq 1/2$ . When  $\epsilon \leq \frac{1}{16L^2(\kappa_h^{\delta})^2}$ , we also have Prob $(\mathcal{A}_2(m_2^*)) \leq L(\kappa_h^{\delta})\sqrt{\epsilon} \leq 1/4$ , and hence  $\text{Prob}(\mathcal{A}_1^c(m_1^*) \cap \mathcal{A}_2^c(m_2^*)) \geq 1/4$ . Therefore, repeating the analysis of Theorem [3.12](#page-15-1) by ignoring the Bregman divergence terms of Lemma [3.10](#page-14-1) yields

$$
\frac{5S\tau}{4B} + \frac{\Delta_{\Psi}}{\gamma\eta} \ge \frac{\mu}{32} \mathbb{E} \bigg[ \sum_{(s,k)\in \mathcal{I}_2^c} \left\| \mathcal{G}_{\phi+\mathrm{id}_{\mathcal{X}_s},h}^{\eta}(x_{s,k}) \right\|^2 \left| \mathcal{A}_1^c(m_1^*) \cap \mathcal{A}_2^c(m_2^*) \right].
$$

Again, conditioning on  $\mathcal{A}_1^c(m_1^*) \cap \mathcal{A}_2^c(m_2^*)$ , we bound  $|\mathcal{I}_2^c|$  by

$$
|\mathcal{I}_2^c| = (S-|\mathcal{I}_1|)\tau + \sum_{s\in\mathcal{I}_1}\tau_s - |\mathcal{I}_2| \geq \frac{3S\tau}{4} - m_2^* \geq S\tau\Big(\frac{3}{4} - \frac{2\eta L(\kappa^{\delta}_h)\sqrt{2\epsilon}}{3}\Big) \geq \frac{S\tau}{2}\,.
$$

As a result, repeating the discussion of  $(30)$  yields

$$
\frac{5S\tau}{4B} + \frac{\Delta_{\Psi}}{\gamma \eta} \ge \frac{\mu S\tau}{64} \mathbb{E} \Big[ \big\| \mathcal{G}_{\phi,h}^{\eta}(x_{\text{out}}) \big\|^2 \big\| \mathcal{A}_{1}^{c}(m_{1}^{*}) \cap \mathcal{A}_{2}^{c}(m_{2}^{*}) \cap \mathcal{A}_{3} \Big].
$$

Since  $\mathcal{G}_{\phi+\mathrm{id}_{\mathcal{X}_s},h}^{\eta}(\cdot)$  coincides with  $\mathcal{G}_{\phi,h}^{\eta}(\cdot)$  in  $\mathcal{I}_2^c$ . We further have

$$
\mathbb{E}\Big[\big\|\mathcal{G}_{\phi,h}^{\eta}(x_{\text{out}})\big\|^2\big|\,\mathcal{A}\Big] \leq \frac{80}{B\mu} + \frac{64\Delta_{\Psi}}{\gamma\eta\mu\tau S} \leq \frac{L^2(\kappa_h^{\delta})^2\delta^2\epsilon}{2}
$$

Hence we complete the proof.

## <span id="page-32-0"></span>E Proof of Example [1](#page-6-0)

*Proof.* Because  $(1)$  is straightforward, we start with proving the argument  $(2)$ . Note that

$$
\frac{\partial \Psi(x_1, x_2)}{\partial x_1} = \frac{-1}{(\sqrt{2} + \ln(1 + x_1^2))^2} \cdot \frac{2x_1}{1 + x_1^2} + rx_1^{r-1}x_2^2 \text{ and } \frac{\partial \Psi(x_1, x_2)}{\partial x_2} = 2x_1^r x_2.
$$

By the symmetry of the objective function, let us assume  $x_1, x_2 > 0$  in the following discussion. By  $\|\nabla\Psi(x_1,x_2)\|^2 \leq \epsilon$ , we have  $\|\frac{\partial \Psi(x_1,x_2)}{\partial x_2}\|$  $\frac{(x_1, x_2)}{(x_2, x_2)}$   $\mid$  2  $\leq \epsilon$ , and hence  $x_2 \leq \sqrt{\epsilon}/2x_1^r$ . Together with  $|x_1| \geq 1$ , the second term of  $\frac{\partial \Psi(x_1, x_2)}{\partial x_1}$  satisfies  $rx_1^{r-1}x_2^2 \leq \frac{re}{4x_1^{r-1}}$  $\frac{r\epsilon}{4x_1^{r+1}} \leq \frac{r\epsilon}{4}$ . As  $r\epsilon/4 \leq \sqrt{\epsilon}$  when  $\epsilon \leq 8/r^2$ , we have

$$
\frac{1}{(\sqrt{2}+\ln(2x_1^2))^2} \cdot \frac{1}{x_1} \le \frac{1}{(\sqrt{2}+\ln(1+x_1^2))^2} \cdot \frac{2x_1}{1+x_1^2} \le \sqrt{\epsilon} + \frac{r\epsilon}{4} \le 2\sqrt{\epsilon},
$$

which indicates that  $x_1 \ge \Omega\left(\frac{1}{\sqrt{\epsilon} \ln^2 \epsilon^{-1}}\right)$ .

Finally, let us prove (3) of Example [1.](#page-6-0) To begin with, we show by induction that  $x_2^k \equiv 0, \forall k \ge 0$ . By initialization,  $x_2^0 = 0$  holds true. Suppose  $x_2^k = 0$ , then  $\frac{\partial \Psi(x_1^k, x_2^k)}{\partial x_2}$  $\frac{(x_1^k, x_2^k)}{\partial x_2} = \frac{\partial h(x_1^k, x_2^k)}{\partial x_2}$  $\frac{x_1, x_2}{\partial x_2} = 0$ . Denote  $z^k = (x_1^k, x_2^k)$  and  $z = (x_1, x_2)$ , then substituting these derivatives to the BPG subproblem yields

<span id="page-32-1"></span>
$$
(x_1^{k+1}, x_2^{k+1}) = \underset{x_1, x_2}{\text{argmin}} \left( \frac{\partial \Psi(x_1^k, x_2^k)}{\partial x_1} - \lambda^{-1} \frac{\partial h(z^k)}{\partial x_1} \right) \cdot x_1 + \lambda^{-1} \cdot \left( \frac{\|z\|^{d+2}}{d+2} + \frac{\|z\|^2}{2} \right). \tag{53}
$$

In [\(53\)](#page-32-1),  $x_2$  only appears in the last norm polynomial terms. Hence we have  $x_2^{k+1} = 0$ . Next, substituting  $x_2^k = x_2^{k+1} = 0$  to [\(53\)](#page-32-1) yields a simplified subproblem only in terms of the variable  $x_1$ , whose KKT condition can be written as

<span id="page-32-2"></span>
$$
(x_1^{k+1})^{d+1} + x_1^{k+1} = (x_1^k)^{d+1} + x_1^k - \lambda \cdot \frac{\partial \Psi(x_1^k, 0)}{\partial x_1}.
$$
 (54)

Since  $\frac{\partial \Psi(x_1^k,0)}{\partial x_1}$  $\frac{f(x_1^k,0)}{\partial x_1} < 0$  for  $\forall x_1 \geq 1$ . With  $x_1^0 = 1$ , the KKT condition [\(54\)](#page-32-2) indicates that  $\{x_1^k\}$  is monotonically increasing. Hence, substituting the value of  $\frac{\partial \Psi(x_1^k,0)}{\partial x_1}$  $\frac{\partial (x_1,0)}{\partial x_1}$ , we have

$$
(x_1^{k+1})^{r+1} \le (x_1^k)^{r+1} + \frac{2\lambda x_1^k}{(\sqrt{2} + \ln(1 + (x_1^k)^2))^2 (1 + (x_1^k)^2)} \le (x_1^k)^{r+1} + \frac{\lambda}{x_1^k} \le (x_1^k)^{r+1} \left(1 + \frac{\lambda}{(x_1^k)^{r+2}}\right)
$$

Take the  $(r+1)$ -th root and apply the inequality that  $(1+u)^{\alpha} \leq 1+\alpha u, \forall u \geq 0, \forall \alpha \in [0,1]$ , we obtain

<span id="page-32-3"></span>
$$
x_1^{k+1} \le x_1^k + \frac{\lambda}{(r+1)(x_1^k)^{r+1}} \le x_1^k + \frac{1}{(r+1)(x_1^k)^{r+1}},\tag{55}
$$

where the last inequality is because  $\lambda < L^{-1} \leq 1$ . Now, we are ready to derive the upper bound for  ${x_1^k}$ . Define  $k_t := \inf\{k : x_1^k \ge t\}$ , for  $t = 1, 2, 3, \dots$ , where  $k_1 = 0$ . Then we know  $x_1^{k_t-1} < t$ . On the other hand, [\(55\)](#page-32-3) indicates that  $x_1^{k_t} \leq t + \frac{1}{r+1}$ . Therefore, we have

$$
t+1 \leq x_1^{k_{t+1}} \leq x_1^{k_{t+1}-1} + \frac{1}{(r+1)t^{r+1}} \leq \cdots \leq x_1^{k_t} + \frac{k_{t+1}-k_t}{(r+1)t^{r+1}} \leq t + \frac{1}{r+1} + \frac{k_{t+1}-k_t}{(r+1)t^{r+1}}.
$$

That is,  $k_{t+1} - k_t \geq rt^{r+1}$ . Notice that if we want  $x_1^k \in [t, t+1)$ , then we will need

$$
k \ge k_t \ge r \cdot \sum_{\tau=1}^{t-1} \tau^{r+1} \ge \frac{r}{r+2} \cdot (t-1)^{r+2} \ge \frac{r}{r+2} \cdot (x_1^k - 2)^{r+2}
$$

 $\Box$ 

.

and hence we have  $x_1^k \leq (\frac{r+2}{r} \cdot k)^{\frac{1}{r+2}} + 2 = O(k^{\frac{1}{r+2}})$ . Substituting this bound and  $x_2^k = 0$  to the gradient  $\nabla \Psi(x_1^k, x_2^k)$  yields

$$
\|\nabla\Psi(x_1^k, x_2^k)\| = \frac{2x_1^k}{(\sqrt{2} + \ln(1 + (x_1^k)^2))^2(1 + (x_1^k)^2)} = \tilde{\Omega}\left(k^{-\frac{1}{r+2}}\right).
$$

Hence we complete the proof.
