ABSTRACT. Let X be a complete variety over an algebraically closed field k of characteristic zero, equipped with an action of an algebraic group G . Let H be a reductive group. We study the notion of G -connection on a principal H -bundle. We give necessary and sufficient criteria for the existence of G connections extending the Atiyah-Weil type criterion for holomorphic connections obtained by Azad and Biswas. We also establish a relationship between the existence of G-connection and equivariant structure on a principal H -bundle, under the assumption that G is semisimple and simply connected. These results have been obtained by Biswas et al. when the underlying variety is smooth.

1. Introduction

Atiyah initiated the study of holomorphic connection for holomorphic principal bundles([\[Ati57\]](#page-20-0)). However, the existence of a connection in the holomorphic category is not guaranteed. A well-known theorem due to A. Weil and M. F. Atiyah says that a holomorphic vector bundle E over a compact connected Riemann surface X admits a flat connection if and only if degree(W) = 0 for every direct summand W of E . This criterion has been extended for principal bundles over X having reductive structure group in [\[AB02,](#page-20-1) [AB03\]](#page-20-2).

When a manifold X admits an action of a Lie group G , the notion of G -connection on principal bundles over X was introduced in [\[BSKN15\]](#page-21-0). The authors in [\[BSKN15,](#page-21-0) [BP17\]](#page-21-1) investigated various necessary and sufficient conditions under which a principal bundle over X admits a G-connection. If X is a toric variety under the action of a torus T , then a T -connection is nothing but the logarithmic connection singular along the boundary divisor $D := X \setminus T$ (see [\[BSKN15,](#page-21-0) Section 4.2]). In [\[DKP23\]](#page-21-2), the authors have studied logarithmic connections on principal bundles over X , which is singular along D , where X is a normal projective variety (possibly with singularities) and D is a reduced Weil divisor on X. The authors have shown that the existence of a logarithmic connection on a principal bundle over a projective toric variety, singular along the boundary divisor, is equivalent to the existence of a torus equivariant structure on the bundle. The aim of this note is to consider G-connection, when X is a complete variety equipped with an action of more general algebraic group G than that of an algebraic torus. Then our goal is to establish an analogue of Atiyah-Weil type criterion for existence of G-connection.

Let X be a complete variety over an algebraically closed field k of characteristic zero. Let G be an algebraic group acting on X. Let H be a reductive linear algebraic group and $p : \mathcal{P} \to X$ be a principal H-bundle. We present an algebro-geometric construction of the G-Atiyah sequence

introduced in [\[BSKN15\]](#page-21-0) (see Section [3.1\)](#page-4-0). This will enable us to define a G -connection as an \mathcal{O} linear splitting of the G-Atiyah sequence. We then study relationship between G-connection on a vector bundle and its associated frame bundle (see Section [3.2\)](#page-6-0). We provide several necessary and sufficient conditions for existence of G-connection in the spirit of results obtained in [\[AB02\]](#page-20-1) and [\[AB03\]](#page-20-2), in terms of the connections on associated bundles. We show that to check the existence of G-connection it suffices to consider Levi reduction (see Corollary [3.13\)](#page-10-0). When H is semisimple, we show that a principal H-bundle admits a (flat) G-connection if and only if the associated adjoint bundle admits one (see Corollary [3.12\)](#page-10-1). More generally, for a reductive group H , the necessary and sufficient condition on a H-bundle to admit a flat connection is described (see Proposition [3.16\)](#page-12-0):

Theorem 1.1. Let H be a reductive linear algebraic group. Then a principal H-bundle \mathcal{P} admits a G-connection if and only if the following conditions hold:

- (1) the adjoint bundle $ad(\mathcal{P})$ admits a G-connection,
- (2) for every character χ of H, the associated line bundle $\mathcal{P} \times^{\chi} k$ associated to P admits a G-connection.

In Section [3.4,](#page-13-0) we characterize the existence of a G-connection using the infinitesimal deformation of the principal bundle. Section [4](#page-16-0) is devoted to investigating relationship between G-connection and G-equivariant structure on a principal bundle. We show the following (see Corollary [4.4\)](#page-19-0):

Theorem 1.2. Let $p : \mathcal{P} \to X$ be a principal H-bundle. Assume that G is semisimple and simply connected. Then the following conditions are equivalent.

- (1) The principal bundle admits an equivariant structure.
- (2) The principal bundle admits an integrable G-connection.
- (3) The principal bundle admits a G-connection.

Finally, as an application we show that a principal H -bundle on X admits a G -equivariant structure if and only if for all $q \in G$, we have

$$
\Phi_g: \mathcal{P} \stackrel{\cong}{\longrightarrow} \rho_g^* \mathcal{P}
$$

as principal H -bundles over X , where G is assumed to be semisimple and simply connected (see Proposition [4.6\)](#page-19-1). This generalizes a well-known criterion for existence of torus equivariant structure on bundles (cf. [\[Kly89,](#page-21-3) Proposition 1.2.1], [\[BP17,](#page-21-1) Corollary 4.4]). In the final section we illustrate some natural G-connections with examples.

2. Preliminaries

Throughout this article, we consider algebraic varieties, schemes, and morphisms over an algebraically closed field k of characteristic zero. Unless explicitly mentioned, we will assume that the considered schemes are of finite type over k . By a point of a scheme X , we will mean a closed point unless explicitly mentioned. A variety is an integral separated scheme. By algebraic group we mean smooth group scheme over k. Since, k is of zero characteristic, any algebraic group is reduced and hence, a group variety. By linear algebraic group we mean affine algebraic group.

Let X be a variety and H be a linear algebraic group. A principal H-bundle is a faithfully flat H-invariant morphism $p : \mathcal{P} \to X$ from a right H-variety \mathcal{P} to X such that the morphism

$$
\mathcal{P} \times H \to \mathcal{P} \times_X \mathcal{P}, (z, h) \mapsto (z \cdot h, z) \tag{2.1}
$$

is an isomorphism.

Remark 2.1. [\[Bri11,](#page-21-4) Remark 3.1] The principal bundle $p : \mathcal{P} \to X$ is locally isotrivial, i.e. for any point $x \in X$ there exists an open subscheme $U \subset X$ containing x and a finite étale surjective morphism $f: U' \to U$ such that the pullback bundle $P \times_U U'$ is trivial.

We now recall the automorphism functor from $[MO67, Section 3]$. Given a scheme S, we denote by Aut_S(X × S) the group of automorphisms of $X \times S$ viewed as a scheme over S. The automorphism functor is given by the following contravariant group functor from the category Sch/k of schemes over k to the category Gr of groups.

$$
\underline{Aut}(X): \mathrm{Sch}/k \longrightarrow \mathrm{Gr}, S \longmapsto \mathrm{Aut}_S(X \times S).
$$

If this functor is representable we say that the automorphism group scheme of X exists. Assume that X is proper scheme over k, then the functor $Aut(X)$ is representable by $Aut(X)$, a group scheme locally of finite type over k (see [\[MO67,](#page-22-0) Theorem 3.7]). In particular, the neutral component $Aut⁰(X)$ is an algebraic group. Also, recall that we have the following isomorphism of Lie algebras (see [\[MO67,](#page-22-0) Lemma 3.4 and Introduction], [\[Li10,](#page-22-1) Theorem 3.1], [\[Bri18,](#page-21-5) Section 2]). Note that here we need characteristic k to be zero.

$$
\alpha_X: \text{Lie}(\text{Aut}(X)) \xrightarrow{\cong} H^0(X, \mathcal{T}_X), \text{ given by}
$$
\n
$$
\phi \longmapsto \delta_{\phi}, \tag{2.2}
$$

where δ_{ϕ} is determined by the following formula

$$
\phi(f) = f + \varepsilon \, \delta_{\phi}(f) \in \Gamma(U, \mathcal{O}_X + \varepsilon \, \mathcal{O}_X) = \Gamma(U, I_k \otimes \mathcal{O}_X)
$$

for $f \in \Gamma(U, \mathcal{O}_X)$, U open subset of X, $I_k = \frac{k[\varepsilon]}{\sqrt{\varepsilon^2}}$ $\frac{k[\varepsilon]}{\langle \varepsilon^2 \rangle}$ is the ring of dual numbers and $\phi \in \text{Lie}(\text{Aut}(X)).$ Here, we have used the following identification (see [\[MO67,](#page-22-0) Lemma 3.3]):

Lie(Aut(X)) = { $\phi : \mathcal{O}_X \to I_k \otimes \mathcal{O}_X$ is a homomorphism of k-algebras on $X \mid (r \otimes 1) \circ \phi = id$ },

where the map $r: I_k \to k$ is given by sending ε to zero.

Let $p : \mathcal{P} \to X$ be a principal H-bundle on a proper scheme X. Consider the abstract group $\text{Aut}^H(\mathcal{P})$ associated to P consisting of automorphisms of P preserving the action of H. Since $p : \mathcal{P} \to X$ is a geometric quotient, for any $\psi \in \text{Aut}^H(\mathcal{P})$ there is an automorphism of X, say $\theta(\psi)$ satisfying

$$
p \circ \psi = \theta(\psi) \circ p. \tag{2.3}
$$

Thus we get a group homomorphism

$$
\theta: \operatorname{Aut}^H(\mathcal{P}) \to \operatorname{Aut}(X),\tag{2.4}
$$

which yields a map between group functors

$$
\theta: \underline{Aut}^H(\mathcal{P}) \to \underline{Aut}(X).
$$

The functor $Aut^H(\mathcal{P})$ is represented by a group scheme, locally of finite type by [\[Bri11,](#page-21-4) Theorem 4.2], which we will denote by Aut^H(P). In particular, the neutral component $(Aut^H(\mathcal{P}))^{\circ}$ is an algebraic group. We have an isomorphism of Lie algebras (see [\[Bri11,](#page-21-4) Theorem 4.2], [\[DG80,](#page-21-6) Proposition 2.5, Section 4, Ch II])

$$
\beta_{\mathcal{P}}: \mathrm{Lie}(\mathrm{Aut}^H(\mathcal{P})) \stackrel{\cong}{\longrightarrow} H^0(\mathcal{P}, \mathcal{F}_{\mathcal{P}})^H
$$

$$
\psi \longmapsto \delta_{\psi}, \tag{2.5}
$$

where δ_{ψ} is determined by the rule

$$
\psi(\widetilde{f}) = \widetilde{f} + \varepsilon \, \delta_{\psi}(\widetilde{f}) \in \Gamma(V, \mathcal{O}_{\mathcal{P}} + \varepsilon \, \mathcal{O}_{\mathcal{P}}) = \Gamma(V, I_k \otimes \mathcal{O}_{\mathcal{P}})
$$

for $\widetilde{f} \in \Gamma(V, \mathcal{O}_{\mathcal{P}})^H$, V open subset of $\mathcal P$ and $\psi \in \text{Lie}(\text{Aut}^H(\mathcal{P}))$.

The map θ in [\(2.4\)](#page-3-0) induces the following map between the corresponding Lie algebras

 $d\theta$: Lie(Aut^H(P)) \longrightarrow Lie(Aut(X))

and the following diagram commutes

$$
\text{Lie}(\text{Aut}^H(\mathcal{P})) \xrightarrow{\beta_{\mathcal{P}}} H^0(\mathcal{P}, \mathcal{F}_{\mathcal{P}})^H
$$
\n
$$
d\theta \downarrow \qquad \qquad \downarrow \eta(X)
$$
\n

\text{Lie}(\text{Aut}(X)) \xrightarrow{\alpha_X} H^0(X, \mathcal{F}_X)

(see [\[DKP23,](#page-21-2) Figure 2]).

3. Atiyah sequence for G-connection

Let X be a variety and H be a reductive liner algebraic group. Let $p : \mathcal{P} \to X$ be a principal H-bundle. We recall the construction of the Atiyah sequence in this set-up (cf. [\[DKP23,](#page-21-2) Section 3]). Since, the map p is smooth, we have the following relative cotangent sequence which is exact (see [\[Ser06,](#page-22-2) Theorem C.15]).

$$
0 \longrightarrow p^*\Omega_X \longrightarrow \Omega_{\mathcal{P}} \longrightarrow \Omega_{\mathcal{P}/X} \longrightarrow 0.
$$

Taking dual and using the fact $(p * \Omega_X)^{\vee} = p^* (\Omega_X^{\vee}) = p^* \mathcal{I}_X$ (see [\[Har80,](#page-21-7) Proof of Proposition 1.8]), we get the following exact sequence

$$
0 \longrightarrow \mathcal{I}_{\mathcal{P}/X} \longrightarrow \mathcal{I}_{\mathcal{P}} \longrightarrow p^* \mathcal{I}_X \longrightarrow 0. \tag{3.1}
$$

Since p is affine and H is reductive, taking invariant pushforward $p_*^H := p_*(\cdot)^H$, we get the following exact sequence

$$
0 \longrightarrow p_*^H \left(\mathcal{F}_{\mathcal{P}/X} \right) \longrightarrow p_*^H \left(\mathcal{F}_{\mathcal{P}} \right) \longrightarrow p_*^H \left(p^* \mathcal{F}_X \right) \longrightarrow 0, \tag{3.2}
$$

(see [\[Nev08,](#page-22-3) Section 2]).

Definition 3.1. The Atiyah sheaf associated to the principal bundle is the subsheaf of H-invariants of $p_*\mathscr{T}_{\mathcal{P}}$:

$$
\mathcal{A}t(\mathcal{P}) := p_*^H \mathscr{T}_{\mathcal{P}} \subset p_* \mathscr{T}_{\mathcal{P}}.
$$

Remark 3.2. The Atiyah sheaf $\mathcal{A}t(\mathcal{P})$ is coherent as $p : \mathcal{P} \to X$ is a principal H-bundle using [\[Nev08,](#page-22-3) Theorem 1.2]. Moreover, since p is surjective, using [\[GD71,](#page-21-8) Proposition 8.4.5], we get that $At(\mathcal{P})$ is torsion-free.

Note that $p_*^H(p^*\mathscr{T}_X) \cong \mathscr{T}_X$ (see [\[Nev08,](#page-22-3) Section 2]). Also, using [\[DKP23,](#page-21-2) Proposition 3.6], we have $p_*^H(\mathcal{I}_{\mathcal{P}/X})$ is isomorphic to the adjoint bundle $\text{ad}(\mathcal{P}) := \mathcal{P} \times_H \mathfrak{h}$, where H acts on its Lie algebra $\mathfrak h$ via the adjoint representation. Hence, the exact sequence (3.2) gives the following short exact sequence

$$
0 \longrightarrow \text{ad}(\mathcal{P}) \xrightarrow{\iota_0} \mathcal{A}t(\mathcal{P}) \xrightarrow{\eta} \mathcal{I}_X \longrightarrow 0. \tag{3.3}
$$

called the Atiyah sequence. Note that the maps in the Atiyah sequence preserves the natural Lie algebra structures.

3.1. Atiyah sequence for group action. Let G be a connected algebraic group (not necessarily linear algebraic group) acting on a complete variety X via the regular morphism $\rho: G \times X \to X$. Now ρ induces the following homomorphism of algebraic groups (see [\[Bri11,](#page-21-4) proof of Corollary 2.2], [\[Bri18,](#page-21-5) Remark 2.4])

$$
\bar{\rho}: G \longrightarrow \text{Aut}^0(X), \ g \mapsto (\rho_g: x \mapsto \rho(g, x)).
$$

This further induces the following map between the corresponding Lie algebras

$$
d\bar{\rho} \; : \; \mathfrak{g} \longrightarrow \text{Lie}(\text{Aut}(X)),
$$

$$
(\varphi : \text{Spec}(I_k) \to G) \longmapsto (\bar{\rho} \circ \varphi : \text{Spec}(I_k) \to \text{Aut}^0(X)).
$$

Composing it with the isomorphism [\(2.2\)](#page-2-0), we get the following Lie algebra homomorphism (see [\[DG80,](#page-21-6) Proposition 4.4, Section 4, Ch II], [\[Li91,](#page-22-4) Lemma 1.2] and [\[Li10\]](#page-22-1))

 $\alpha = \alpha_X \circ d\bar{\rho}$: $\mathfrak{g} \longrightarrow H^0(X, \mathscr{T}_X).$

This induces the following evaluation map between sheaves

$$
\zeta : \mathcal{O}_X \otimes_k \mathfrak{g} \longrightarrow \mathcal{I}_X \text{ given by,}
$$

\n
$$
\mathcal{O}_X(U) \otimes_k \mathfrak{g} \longrightarrow \mathcal{I}_X(U), f \otimes \delta \mapsto f \alpha(\delta)|_U,
$$
\n(3.4)

where U is an open subset of X, $f \in \mathcal{O}_X(U)$ and $\delta \in \mathfrak{g}$. Note that ζ preserves the natural Lie algebra structures between the sheaves, $\mathcal{O}_X \otimes \mathfrak{g}$ has a natural Lie bracket induced from the Lie bracket of \mathfrak{g} . **Remark 3.3.** Note that for any point $x \in X$, the map ζ yields the following map between the the fibers

$$
\zeta_x : \mathfrak{g} \longrightarrow \mathscr{T}_x(X) := \mathscr{T}_X \otimes_{\mathcal{O}_X} k(x),
$$

which is same as α . Also, ζ_x is identified with the differential of the orbit map $G \to X$, $g \mapsto \rho(g, x)$ (cf. [\[Bri13,](#page-21-9) the map op_X on Page 2]). The action map $\rho: G \times X \to X$ induces the following map between the corresponding tangent sheaves (see [\(3.1\)](#page-3-1))

$$
\mathscr{T}_{G\times X}\xrightarrow{d\rho}\rho^*\mathscr{T}_X.
$$

Let $p_1: G \times X \to G$ and $p_2: G \times X \to X$ denote the corresponding projection maps, respectively. Then we have $\mathscr{T}_{G\times X} \cong p_1^* \mathscr{T}_G \oplus p_2^* \mathscr{T}_X$. Let $j : p_1^* \mathscr{T}_G \hookrightarrow \mathscr{T}_{G\times X}$ denote the inclusion map. Consider the following composition of maps:

$$
p_1^* \mathcal{T}_G \xrightarrow{j} \mathcal{T}_{G \times X} \xrightarrow{d\rho} \rho^* \mathcal{T}_X. \tag{3.5}
$$

Let $\nu : X \cong \{1_G\} \times X \hookrightarrow G \times X$ denote the inclusion map given by $x \mapsto (1_G, x)$. Then pulling back the sequence [\(3.5\)](#page-5-0) via the map ν and using the fact that $\rho \circ \nu = \text{Id}_X$ and $p_1^* \mathscr{T}_G \cong \mathcal{O}_{G \times X} \otimes_k \mathfrak{g}$ (see [\[Bri17,](#page-21-10) p. 13]), we get the following map

$$
\zeta': \mathcal{O}_X \otimes_k \mathfrak{g} \longrightarrow \mathscr{T}_X.
$$

Note that, on fibers, the map ζ' is given by the differential of the orbit map $G \to X$, $g \mapsto \rho(g, x)$. Hence, using Nakayama's lemma we have $\zeta = \zeta'$.

Denote by $\mathcal{V} := \mathcal{O}_X \otimes_k \mathfrak{g}$ and consider the map

$$
\eta - \zeta \; : \; At(\mathcal{P}) \oplus \mathcal{V} \to \mathscr{T}_X, \, (v, w) \to \eta(v) - \zeta(w).
$$

Definition 3.4. Define the G-Atiyah sheaf

$$
\mathcal{A}t_{\rho}(\mathcal{P}) := Ker(\eta - \zeta)
$$

as a subsheaf of $At(\mathcal{P}) \oplus \mathcal{V}$.

Clearly, $At_{\rho}(\mathcal{P})$ is torsion-free. Note that being kernel, $At_{\rho}(\mathcal{P})$ acquires a natural Lie algebra structure from the component wise Lie algebra structure from $\mathcal{A}t(\mathcal{P}) \oplus \mathcal{V}$. We have the projection map

$$
\mathrm{pr}_2:\mathcal{A}t_\rho(\mathcal{P})\to\mathcal{V}
$$

and the map

$$
\iota: \mathrm{ad}(\mathcal{P}) \to \mathcal{A}t_{\rho}(\mathcal{P}), \, \iota(v) = (\iota_0(v), 0).
$$

Note that ι is injective and $\text{Ker}(\text{pr}_2) = \text{Im}(\iota)$; hence, we have the following exact sequence

$$
0 \longrightarrow \text{ad}(\mathcal{P}) \stackrel{\iota}{\longrightarrow} \mathcal{A}t_{\rho}(\mathcal{P}) \stackrel{pr_2}{\longrightarrow} \mathcal{V} \longrightarrow 0. \tag{3.6}
$$

We call this the G-Atiyah sequence for the principal bundle P . Observe that the above sequence is obtained from the Atiyah sequence (3.3) by pulling back via the map ζ , defined in (3.4) (see [\[HS97,](#page-21-11) Chapter III, Section 1]). Since both the sheaves $ad(\mathcal{P})$ and V are locally free, $\mathcal{A}t_{\rho}(\mathcal{P})$ is also locally free. Clearly, pr_2 preserves the Lie algebra structure. Note that ι also preserves the Lie

algebra structure as ι_0 does so. Hence, the maps in the above sequence [\(3.6\)](#page-5-1) preserves the natural Lie algebra structures between the sheaves.

Definition 3.5. A G-connection on the principal H-bundle P is a \mathcal{O}_X -linear splitting, i.e., a \mathcal{O}_X module map

$$
\lambda: \mathcal{V} \to \mathcal{A}t_{\rho}(\mathcal{P}) \text{ such that } pr_2 \circ \lambda = Id_{\mathcal{V}}.
$$

A G-connection λ is said to be flat or integrable if moreover λ preserves the Lie algebra structures of the sheaves.

Remark 3.6. The G-Atiyah sequence [\(3.6\)](#page-5-1) defines a class $a_{\rho}(\mathcal{P}) \in \text{Ext}^{1}(\mathcal{V}, \text{ad}(\mathcal{P}))$. Thus the principal H-bundle admits a G-connection if and only if $a_{\rho}(\mathcal{P}) = 0$. Note that

$$
\text{Ext}^1(\mathcal{V}, \text{ad}(\mathcal{P})) = H^1(X, \mathcal{H}_{\text{com}}(\mathcal{V}, \text{ad}(\mathcal{P}))) = H^1(X, \text{ad}(\mathcal{P}) \otimes_k \mathfrak{g}^{\vee}).
$$

Hence, $Ext^1(V, ad(P))$ is isomorphic to the direct sum of finitely many copies of $H^1(X, ad(P))$. In particular, if $H^1(X, \text{ad}(\mathcal{P})) = 0$, then $\mathcal P$ admits a G-connection.

3.2. G-connection on vector bundle. As before, let G be a connected algebraic group acting on a complete variety X via the regular morphism $\rho: G \times X \to X$. Let $\pi: \mathcal{E} \to X$ be a vector bundle of rank r over X and $p : \mathcal{P} \to X$ be the associated $GL(r, k)$ -bundle, called the frame bundle. Then by Remark [3.6,](#page-6-1) the G-Atiyah sequence [\(3.6\)](#page-5-1) for the frame bundle defines a class $a_{\rho}(\mathcal{P}) \in H^1(X, \mathcal{H}_{em}(\mathcal{V}, \text{ad}(\mathcal{P})))$. Consider the following canonical isomorphisms.

$$
\mathcal{E}^{\vee} \otimes \mathcal{E} \cong ad(\mathcal{P}) \text{ (cf. [Ati57, Proposition 9]),}
$$

$$
\mathscr{H}om(\mathcal{V}, ad(\mathcal{P}))) \cong \mathscr{H}om(\mathcal{V}, \mathcal{E}^{\vee} \otimes \mathcal{E}) \cong \mathcal{V}^{\vee} \otimes \mathcal{E}^{\vee} \otimes \mathcal{E} \cong \mathscr{H}om(\mathcal{E}, \mathcal{E} \otimes \mathcal{V}^{\vee}).
$$

Let us denote by $b_{\rho}(\mathcal{E}) \in H^1(X, \mathcal{H}_{em}(\mathcal{E}, \mathcal{E} \otimes \mathcal{V}^{\vee}))$ the image of the class $a_{\rho}(\mathcal{P})$. Then the class $b_{\rho}(\mathcal{E})$ corresponds to the following extension (see [\[Ati57,](#page-20-0) Proposition 2], [\[Gra61,](#page-21-12) Section 3])

$$
0 \longrightarrow \mathcal{E} \otimes \mathcal{V}^{\vee} \longrightarrow D_{\rho}(\mathcal{E}) \longrightarrow \mathcal{E} \longrightarrow 0. \tag{3.7}
$$

Note that the class $a_{\rho}(\mathcal{P})$ is zero if and only if the class $b_{\rho}(\mathcal{E})$ is zero. Thus we can define G-connection for the vector bundle $\mathcal E$ as an $\mathcal O_X$ -linear splitting of the sequence [\(3.7\)](#page-6-2).

Proposition 3.7. Let \mathcal{E} be a vector bundle on a complete variety X admitting a G-connection. Then there is a k-linear sheaf homomorphism

$$
\nabla:\mathcal{E}\longrightarrow\mathcal{E}\otimes_{\mathcal{O}_X}\mathcal{V}^\vee
$$

satisfying the following Leibniz like condition

$$
\nabla(f s) = f \nabla(s) + s \otimes \zeta^{\vee}(df),
$$

where $f \in \mathcal{O}_X(U)$ and $s \in \mathcal{E}(U)$ for open subset $U \subset X$. Here ζ^{\vee} is the dual of the map ζ defined in [\(3.4\)](#page-4-3). Note that $d: \mathcal{O}_X \to \Omega^1_X$ is the universal derivation and we have the natural map $\Omega^1_X \to (\Omega^1_X)^{\vee \vee}$. *Proof.* Let P denote the principal frame bundle associated to E . Consider the following canonical isomorphism of $\mathcal{O}_{\mathcal{P}}$ -modules (see [\[DKP23,](#page-21-2) proof of Proposition 4.6])

$$
\Psi: p^*\mathcal{E} \longrightarrow \mathcal{O}_{\mathcal{P}}^{\oplus r}, \, \tilde{s} \longmapsto (\tilde{f}_1, \ldots, \tilde{f}_r),
$$

where \tilde{s} is a section of $p^*\mathcal{E}$ over the open subset $V \subset \mathcal{P}$ and

$$
\tilde{s}(e) = (e, \tilde{f}_1e_1 + \ldots + \tilde{f}_r e_r)
$$

for all $e \in V$ and $e = (e_1, \ldots, e_r)$ is an ordered basis of the fiber $\mathcal{E}(x)$, $x = p(e)$. Note that Ψ is $GL(r, k)$ -equivariant. Define the map

$$
\widetilde{\nabla} : \mathcal{E} \otimes_k \mathcal{V} \longrightarrow \mathcal{E}
$$

as follows: Let $\lambda : \mathcal{V} \to \mathcal{A}t_{\rho}(\mathcal{P})$ be a G-connection on P. Let s and w be local sections of \mathcal{E} and V, respectively, over an affine open subset $U = \text{Spec}(B) \subset X$. Let $\lambda(w) = (\delta_w, w)$, where δ_w is a local section of $\mathcal{A}t(\mathcal{P})$ such that $\eta(\tilde{\delta}_w) = \zeta(w)$. Let $p^{-1}(U) = \text{Spec}(A) \subset \mathcal{P}$. Then $(p^*\mathcal{E})(p^{-1}(U)) =$ $\mathcal{E}(U) \otimes_B A$. So $s \otimes 1$ defines a local section of $p^*\mathcal{E}$ over $p^{-1}(U)$, where 1 denotes the multiplicative identity of the ring A. Write

$$
\Psi(s\otimes 1)=(\tilde{f}_1,\ldots,\tilde{f}_r)\in\mathcal{O}_{\mathcal{P}}^{\oplus r}.
$$

Then, define

$$
\widetilde{\nabla}(s\otimes w)=\Psi^{-1}(\widetilde{\delta}_w(\widetilde{f}_1),\ldots,\widetilde{\delta}_w(\widetilde{f}_r)).
$$

Note that $\tilde{\nabla}(s\otimes w)$ is an element of $\mathcal{E}(U)$ as Ψ is $GL(r, k)$ -equivariant. Since, the map Ψ is $\mathcal{O}_{\mathcal{P}}$ -linear and λ is \mathcal{O}_X -linear, we have

$$
\widetilde{\nabla}(cs \otimes w) = c \widetilde{\nabla}(s \otimes w) \text{ and } \widetilde{\nabla}(s \otimes fw) = f \widetilde{\nabla}(s \otimes w). \tag{3.8}
$$

Also, note that

$$
fs \otimes 1 = (p^{\sharp}f)(s \otimes 1).
$$

Then,

$$
\Psi(f s \otimes 1) = (p^{\sharp} f) \Psi(s \otimes 1) = ((p^{\sharp} f) \tilde{f}_1, \dots, (p^{\sharp} f) \tilde{f}_r).
$$

Thus, we have

$$
\widetilde{\nabla}(f s \otimes w) = \Psi^{-1}(\widetilde{\delta}_w((p^{\sharp} f) \widetilde{f}_1), \dots, \widetilde{\delta}_w((p^{\sharp} f) \widetilde{f}_r)). \tag{3.9}
$$

Note that for $i = 1, \ldots, r$, we have

$$
\widetilde{\delta}_w((p^{\sharp}f)\widetilde{f}_i) = (p^{\sharp}f)\widetilde{\delta}_w(\widetilde{f}_i) + \widetilde{f}_i\widetilde{\delta}_w((p^{\sharp}f)).
$$
\n(3.10)

Then from (3.9) and (3.10) , we have

$$
\widetilde{\nabla}(f s \otimes w) = (p^{\sharp} f) \Psi^{-1}(\widetilde{\delta}_w(\widetilde{f}_1), \dots, \widetilde{\delta}_w(\widetilde{f}_r)) + \widetilde{\delta}_w((p^{\sharp} f)) \Psi^{-1}(\widetilde{f}_1, \dots, \widetilde{f}_r)
$$
\n
$$
= f \widetilde{\nabla}(s \otimes w) + \zeta(w)(f) s,
$$
\n(3.11)

where we have used

$$
\eta(\widetilde{\delta}_w)(f) = p_*(\widetilde{\delta}_w(p^{\sharp}(f))).
$$

Let us define

$$
\nabla:\mathcal{E}\longrightarrow\mathcal{E}\otimes_{\mathcal{O}_X}\mathcal{V}^\vee
$$

as follows: for a section s of $\mathcal E$ over an open subset $U \subset X$ consider the $\mathcal O_X(U)$ -linear map

$$
\widetilde{\nabla}^U_s: \mathcal{V}(U) \longrightarrow \mathcal{E}(U), \text{ given by } w \longmapsto \widetilde{\nabla}^U(s \otimes w).
$$

Finally define

$$
\nabla^U(s) = \Upsilon\left(\widetilde{\nabla}^U_s\right),\,
$$

where Υ : $\mathscr{H}_{em}(\mathcal{V}, \mathcal{E}) \cong \mathscr{E} \otimes_{\mathcal{O}_X} \mathcal{V}^{\vee}$ is the canonical isomorphism. Then from [\(3.8\)](#page-7-2) and [\(3.11\)](#page-7-3), it follows that ∇ is a k-linear map satisfying Leibniz rule.

Remark 3.8. The above proposition suggests that we can define G-connection for any coherent \mathcal{O}_X -module as well. Note that when X is nonsingular and the map ζ is surjective any coherent \mathcal{O}_X -module admitting G-connection is necessarily locally free (using [\[BGK](#page-21-13)+87, Proposition 1.2, p. 211]). This does not hold for singular varieties; for example, the cotangent sheaf always admits a G-connection (use Proposition [4.1\)](#page-16-1) although it need not be locally free.

3.3. Homomorphisms and induced G -connections. Let G be a connected algebraic group acting on a complete variety X via the regular morphism $\rho: G \times X \to X$. Let $\tau: G_1 \to G$ be a homomorphism of connected algebraic groups. This induces an action of G_1 on X as follows:

$$
\rho_1: G_1 \times X \longrightarrow X, \text{ given by } (g_1, x) \longmapsto \rho(\tau(g_1), x).
$$

Now ρ_1 induces a homomorphism of algebraic groups

$$
\bar{\rho_1}: G_1 \longrightarrow \operatorname{Aut}^0(X), g_1 \mapsto ((\rho_1)_{g_1}: x \longmapsto \rho(\tau(g_1), x)).
$$

Thus we have $\bar{\rho}_1 = \bar{\rho} \circ \tau$. This implies that the corresponding maps between their Lie algebras satisfy $d\bar{\rho}_1 = d\bar{\rho} \circ d\tau$. This implies we get $\alpha_1 = \alpha \circ d\tau$. Hence, the corresponding map defined in [\(3.4\)](#page-4-3) is

$$
\zeta_1 : \mathcal{O}_X \otimes_k \mathfrak{g}_1 \longrightarrow \mathscr{T}_X \text{ given by,}
$$

$$
\mathcal{O}_X(U) \otimes_k \mathfrak{g}_1 \longrightarrow \mathscr{T}_X(U), \ f \otimes \delta_1 \mapsto f \alpha_1(\delta)|_U,
$$

where U is an open subset of X, $f \in \mathcal{O}_X(U)$ and $\delta \in \mathfrak{g}_1$. Thus, we get

$$
\zeta_1 = \zeta \circ d\tau.
$$

Hence, the following diagram commutes

$$
\mathcal{A}t(\mathcal{P}) \oplus (\mathcal{O}_X \otimes_k \mathfrak{g}_1) \xrightarrow{\text{Id} \oplus d\tau} \mathcal{A}t(\mathcal{P}) \oplus (\mathcal{O}_X \otimes_k \mathfrak{g}_1) \xrightarrow[\eta - \zeta]{} \mathcal{
$$

.

This further induces the following map between the kernels,

$$
\widetilde{\tau}: \mathcal{A}t_{\rho_1}(\mathcal{P}) \longrightarrow \mathcal{A}t_{\rho}(\mathcal{P}), (v, w_1) \longmapsto (v, d\tau(w_1)).
$$

Thus, we get the following commutative diagram of the corresponding Atiyah sequences.

$$
0 \longrightarrow \text{ad}(\mathcal{P}) \xrightarrow{\iota_1} \mathcal{A}t_{\rho_1}(\mathcal{P}) \xrightarrow{\text{pr}_2} \mathcal{O}_X \otimes_k \mathfrak{g}_1 \longrightarrow 0
$$
\n

\downarrow id \qquad \qquad \downarrow \tilde{\tau} \qquad \qquad d\tau \qquad \downarrow
$$
\n
$$
0 \longrightarrow \text{ad}(\mathcal{P}) \xrightarrow{\iota} \mathcal{A}t_{\rho}(\mathcal{P}) \xrightarrow{\text{pr}_2} \mathcal{O}_X \otimes_k \mathfrak{g} \longrightarrow 0.
$$
\n
$$
(3.12)
$$

Proposition 3.9. A G-connection on the principal H-bundle P induces a G_1 -connection on P .

Proof. If the principal H-bundle $\mathcal P$ admits a G-connection, the map ι in [\(3.12\)](#page-9-0) admits a splitting. This will produce a splitting of ι_1 by the commutativity of the exact sequences in [\(3.12\)](#page-9-0). Thus $\mathcal P$ will admit a G_1 -connection as well.

Next we consider G-connections induced on associated bundles of a principal bundle. This has been studied for logarithmic connections in [\[DKP23,](#page-21-2) Section 5]. Let X be a complete variety and $\tau : H \to H_1$ be a homomorphism between reductive algebraic groups H and H_1 . Let $p : \mathcal{P} \to X$ be a principal H-bundle. The associated principal H_1 -bundle $\mathcal{P}_1 := \mathcal{P} \times^H H_1$ is constructed as the quotient

$$
\left(\mathcal{P}\times H_{1}\right) /\sim
$$

where

$$
(e, h_1) \sim (eh, \tau(h)^{-1}h_1)
$$
 for all $h \in H$.

The projection map

$$
p': \mathcal{P}_1 \to X
$$
 is given by $p'([e, h_1]) = p(e)$.

Proposition 3.10. With the notation as above, a (flat) G-connection on the principal H-bundle \mathcal{P} induces a (flat) G-connection on the associated principal H_1 -bundle \mathcal{P}_1 .

Proof. Note that we have the following commutative diagram of the corresponding Atiyah sequences

$$
0 \longrightarrow \text{ad}(\mathcal{P}) \xrightarrow{\iota_0} \mathcal{A}t(\mathcal{P}) \xrightarrow{\eta} \mathcal{J}_X \longrightarrow 0
$$

\n
$$
\downarrow \text{ad}(\tau) \qquad \qquad \downarrow \text{At}(\tau) \qquad Id \qquad \downarrow
$$

\n
$$
0 \longrightarrow \text{ad}(\mathcal{P}_1) \xrightarrow{\iota_0'} \mathcal{A}t(\mathcal{P}_1) \xrightarrow{\eta'} \mathcal{J}_X \longrightarrow 0,
$$

(see [\[DKP23,](#page-21-2) proof of the Proposition 5.1]). From the commutativity of the second square in the above diagram, we get the following commutative diagram

$$
\mathcal{A}t(\mathcal{P}) \oplus \mathcal{V} \xrightarrow{\eta-\zeta} \mathcal{T}_X
$$
\n
$$
\downarrow \text{At}(\tau) \oplus Id \qquad \qquad \downarrow Id
$$
\n
$$
\mathcal{A}t(\mathcal{P}_1) \oplus \mathcal{V} \xrightarrow{\eta'-\zeta} \mathcal{T}_X
$$

.

This further induces the following map between the kernels,

$$
\mathrm{At}_\rho(\tau):\mathcal{A}t_\rho(\mathcal{P})\longrightarrow\mathcal{A}t_\rho(\mathcal{P}_1),\,(v,w)\longmapsto(\mathrm{At}(\tau)(v),w).
$$

Thus, we get the following commutative diagram of the corresponding Atiyah sequences.

$$
0 \longrightarrow \mathrm{ad}(\mathcal{P}) \xrightarrow{\iota} \mathcal{A}t_{\rho}(\mathcal{P}) \xrightarrow{\text{pr}_2} \mathcal{V} \longrightarrow 0
$$

$$
\downarrow \mathrm{ad}(\tau) \qquad \qquad \downarrow \mathrm{At}_{\rho}(\tau) \qquad Id \qquad \downarrow
$$
\n
$$
0 \longrightarrow \mathrm{ad}(\mathcal{P}_1) \xrightarrow{\iota_1} \mathcal{A}t_{\rho}(\mathcal{P}_1) \xrightarrow{\text{pr}_2} \mathcal{V} \longrightarrow 0.
$$

(3.13)
$$

Let the principal H-bundle P admits a G-connection h, then from the commutativity of (3.13) , $\text{At}_{\rho}(\tau) \circ h$ will be a G-connection on \mathcal{P}_1 . Note that the map $\text{At}(\tau)$ preserves the Lie algebra structure; hence, does the map $At_o(\tau)$. Thus, if h is flat, the induced G-connection $At_o(\tau) \circ h$ is also flat. \Box

Proposition 3.11. Let $\tau : H \to H_1$ be an injective homomorphism between reductive algebraic groups H and H₁. Let $p : \mathcal{P} \to X$ be a principal H-bundle. Then a (flat) G-connection on the associated principal H₁-bundle $\mathcal{P}_1 := \mathcal{P} \times^H H_1$ induces a (flat) G-connection on the principal H-bundle \mathcal{P} .

Proof. We have a map $\bar{\gamma}$: ad(\mathcal{P}_1) \to ad(\mathcal{P}) such that $\bar{\gamma} \circ \text{ad}(\tau) = Id_{\text{ad}(\mathcal{P})}$ (see [\[DKP23,](#page-21-2) proof of the Proposition 5.3,.). Note that a G-connection λ_1 on \mathcal{P}_1 induces a splitting

$$
\lambda_1':\mathcal{A}t(\mathcal{P}_1)\to\mathrm{ad}(\mathcal{P}_1)
$$

of ι_1 in [\(3.13\)](#page-10-2). Then $\bar{\gamma} \circ \lambda'_1 \circ \mathrm{At}_{\rho}(\tau)$ gives a splitting of ι . Hence, we get a G-connection on \mathcal{P} . Note that the map $\bar{\gamma}$ preserves the Lie algebra structure. If G-connection h_1 on \mathcal{P}_1 is flat, we can choose the splitting λ'_1 to preserve the Lie algebra structure. Hence, $\bar{\gamma} \circ \lambda'_1 \circ At_\rho(\tau)$ will give a flat G-connection on P .

As a corollary, we get the following result analogous to a result for holomorphic connection in [\[AB03,](#page-20-2) Proposition 2.2].

Corollary 3.12. Let H be a semisimple linear algebraic group and P be a principal H-bundle on X. Then $\mathcal P$ admits a (flat) G-connection if and only if the associated adjoint bundle ad($\mathcal P$) admits a (flat) G-connection.

We now recall the notion of Levi subgroup. Let H be a connected reductive affine algebraic group over k. Let P be a parabolic subgroup of H and $R_u(P)$ be the unipotent radical of P. There is a connected closed subgroup $L \subset P$, called the Levi subgroup, such the restriction to L of the quotient map

$$
\pi: P \longrightarrow P/R_u(P)
$$

is an isomorphism. Note that L is also reductive (see [\[Hum75,](#page-21-14) Section 30.2], [\[Mil17,](#page-22-5) Page 559]). Given a principal H-bundle P on a projective variety X over k there is a natural reduction of structure group $\mathcal{P}_L \subset \mathcal{P}$ to a certain Levi subgroup $L \subset H$ associated to \mathcal{P} (see [\[BBN05\]](#page-21-15)). As a consequence of Proposition [3.9](#page-9-1) and Proposition [3.11,](#page-10-3) we get the following.

Corollary 3.13. When X is projective, with the notation as above, to study existence of (flat) G-connection on P it suffices to check existence of (flat) G-connection on a Levi reduction.

We now extend Corollary [3.12](#page-10-1) for any reductive group H (cf. [\[AB03,](#page-20-2) Section 3]). Let $Z^0(H) \subset H$ denote the connected component of the center of H containing the identity element. Let $H' :=$

 $H/Z⁰(H)$ be the quotient. Note that H' is semisimple. Let [H, H] denote the commutator and $A := H/[H, H]$ be the abelian quotient. For a principal H-bundle P , let P_1 (respectively, P_2) denote the principal H'-bundle (respectively, principal A-bundle) obtained by extending the structure group of P under the obvious projection map of H to H' (respectively, A). Then we have the following (cf. [\[AB02,](#page-20-1) Lemma 3.4]).

Proposition 3.14. The principal H-bundle $\mathcal P$ admits a G-connection if and only if both the bundles \mathcal{P}_1 and \mathcal{P}_2 admit G-connection.

Proof. The forward direction is a consequence of Proposition [3.9.](#page-9-1) For the converse direction, consider the diagonal homomorphism $\Delta: H \to H' \times A$ induced by the projections from H to H' and A. Note that Δ is a surjective map between linear algebraic group with ker(Δ) = $Z^0(H) \cap [H, H]$, which is finite (see [\[Hum75,](#page-21-14) Lemma 19.5]). Hence, Δ is an étale morphism. Let $\mathcal{P}(\Delta) := \mathcal{P} \times^H (H' \times A)$ denote the principal $(H' \times A)$ -bundle obtained by extending the structure group of P by the homomorphism ∆. Now consider the map

$$
\mathcal{P} \longrightarrow \mathcal{P}(\Delta), \text{ given by } z \longmapsto [z, (1, 1)].
$$

This is an étale morphism as étale locally, the above map is of the form $Id \times \Delta$. Note that there is an isomorphism of principal bundles

$$
\mathcal{P}(\Delta) \stackrel{\cong}{\longrightarrow} \mathcal{P}_1 \times_X \mathcal{P}_2
$$
, given by

$$
[z, (h', a)] \longmapsto [(z, h'), (z, a)].
$$

The inverse map is given by

$$
[(z, h'), (zh, a)] \longmapsto [z, (h', [h]^{-1}a)],
$$

where [h] denote the image of h in A. Hence, the composite map $\tilde{\Delta}$: $\mathcal{P} \rightarrow \mathcal{P}_1 \times_X \mathcal{P}_2$ is an etale morphism. As a consequence, the Atiyah sequence for P and $P' := P_1 \times_X P_2$ coincide (see [\[BMW12,](#page-21-16) Lemma 1.12]). Note that étaleness of the map $\tilde{\Delta}$ implies that $d\tilde{\Delta}$: $\mathcal{F}_{\mathcal{P}} \stackrel{\cong}{\rightarrow} \tilde{\Delta}^*(\mathcal{F}_{\mathcal{P}'})$ is an isomorphism (using [\[Mil80,](#page-22-6) Ch. I, Proposition 3.5] and [\[Ser06,](#page-22-2) Theorem C.15]). Thus, the induced map $At(\tilde{\Delta})$ between the corresponding Atiyah sheaves is also isomorphism. Thus, we get the following commutative diagram of the corresponding Atiyah sequences

$$
0 \longrightarrow \text{ad}(\mathcal{P}) \xrightarrow{\iota} \mathcal{A}t(\mathcal{P}) \xrightarrow{\eta} \mathcal{F}_X \longrightarrow 0
$$

\n
$$
\downarrow \text{ad}(\tilde{\Delta}) \qquad \downarrow \text{At}(\tilde{\Delta}) \qquad Id \downarrow
$$

\n
$$
0 \longrightarrow \text{ad}(\mathcal{P}') \xrightarrow{\iota'} \mathcal{A}t(\mathcal{P}') \xrightarrow{\eta'} \mathcal{F}_X \longrightarrow 0.
$$

This forces that the map $ad(\tilde{\Delta})$ is also an isomorphism. This shows that the Atiyah sequence for P and $\mathcal{P}' := \mathcal{P}_1 \times_X \mathcal{P}_2$ coincide. Hence, their G-Atiyah sequences also coincide. It remains to show that if the G-Atiyah sequences corresponding to \mathcal{P}_1 and \mathcal{P}_2 split, then the G-Atiyah sequence for \mathcal{P}' also splits. We have the following fiber product diagram

$$
\mathcal{P}' := \mathcal{P}_1 \times_X \mathcal{P}_2 \xrightarrow{\qquad} \mathcal{P}_1
$$
\n
$$
\downarrow \qquad \qquad \downarrow p_2 \xrightarrow{\qquad} \mathcal{P}_2 \xrightarrow{\qquad} \qquad X
$$

Let the Atiyah sequence for \mathcal{P}_i , $i = 1, 2$ be the following

$$
0 \longrightarrow \mathrm{ad}(\mathcal{P}_i) \xrightarrow{\iota_i} \mathcal{A}t(\mathcal{P}_i) \xrightarrow{\eta_i} \mathcal{I}_X \longrightarrow 0.
$$

And, denote the *G*-Atiyah sequence for P_i , $i = 1, 2$ by

$$
0 \longrightarrow \text{ad}(\mathcal{P}_i) \xrightarrow{\iota_i^0} \mathcal{A}t_{\rho}(\mathcal{P}_i) \xrightarrow{pr_2} \mathcal{V} \longrightarrow 0. \tag{3.14}
$$

.

Hence, by the functoriality of the Atiyah sequence (see [\[Ati57,](#page-20-0) Page 188], [\[Her20\]](#page-21-17)), we get that

$$
0 \longrightarrow \mathrm{ad}(\mathcal{P}_1) \oplus \mathrm{ad}(\mathcal{P}_2) \xrightarrow{\iota'} \mathcal{A}t(\mathcal{P}') \xrightarrow{\eta' = (\eta_1, \eta_2)} \mathcal{I}_X \longrightarrow 0
$$

is the Atiyah sequence for \mathcal{P}' , where

$$
\mathcal{A}t(\mathcal{P}') = \text{Ker}(\eta_1 \circ a_1 - \eta_2 \circ a_2) \subset \mathcal{A}t(\mathcal{P}_1) \oplus \mathcal{A}t(\mathcal{P}_2).
$$

Here the map a_i denote the projection of $\mathcal{A}t(\mathcal{P}_1) \oplus \mathcal{A}t(\mathcal{P}_2)$ to the ith factor for $i = 1, 2$. Thus, the G-Atiyah sequence for the bundle \mathcal{P}' is given by

$$
0 \longrightarrow \text{ad}(\mathcal{P}_1) \oplus \text{ad}(\mathcal{P}_2) \stackrel{\iota}{\longrightarrow} \mathcal{A}t_{\rho}(\mathcal{P}') \stackrel{\text{pr}_{\mathcal{V}}}{\longrightarrow} \mathcal{V} \longrightarrow 0,
$$
\n(3.15)

where

$$
\mathcal{A}t_{\rho}(\mathcal{P}') = \{(\delta_1,\delta_2,\delta): (\eta_1 \circ a_1)(\delta_1) = (\eta_2 \circ a_2)(\delta_2) = \zeta(\delta)\} \subset \mathcal{A}t(\mathcal{P}_1) \oplus \mathcal{A}t(\mathcal{P}_2) \oplus \mathcal{V}.
$$

We are given that P_i admits a G-connection, i.e., a splitting

$$
\lambda_i: \mathcal{V} \longrightarrow \mathcal{A}t_{\rho}(\mathcal{P}_i)
$$

of (3.14) . This will induce a splitting of the sequence (3.15) . Hence, \mathcal{P}' admits a G-connection. This completes the proof. \Box

Remark 3.15. As a corollary of the proof we get that the principal bundles P_1 and P_2 admit Gconnection if and only if the fiber product $\mathcal{P}_1 \times_X \mathcal{P}_2$ admits G-connection.

Now we give a necessary and sufficient criterion for a principal H-bundle to admit G-connection (cf. [\[AB03,](#page-20-2) Theorem 3.1]).

Proposition 3.16. Let H be a reductive linear algebraic group. With the notation as above, a principal H-bundle P admits a G-connection if and only if the following conditions hold:

- (1) the adjoint bundle $ad(\mathcal{P})$ admits a G-connection,
- (2) for every character χ of H, the line bundle $\mathcal{P} \times^{\chi} k$ associated to \mathcal{P} admits a G-connection.

Proof. As H' is semisimple, Corollary [3.12](#page-10-1) implies that P_1 admits a G-connection if and only if $ad(\mathcal{P}_1)$ admits a G-connection. Note that we have the following direct sum decomposition

$$
\mathrm{ad}(\mathcal{P})\cong\mathrm{ad}(\mathcal{P}_1)\oplus\mathrm{ad}(\mathcal{P}_2)
$$

from the proof of Proposition [3.14.](#page-11-0) Also, note that the adjoint bundle $\text{ad}(\mathcal{P}_2)$ is trivial as A is abelian. Hence, it always admits a connection which implies it admits a G-connection also. Thus, P_1 admits a G-connection if and only if ad(P) admits a G-connection by Remark [3.15.](#page-12-3) Next we determine the criterion for existence of G-connection on the associated A-bundle \mathcal{P}_2 . Note that the abelian quotient $A := H/[H, H]$ is a product of copies of k^* , say $A \cong (k^*)^n$. Then the principal A-bundle \mathcal{P}_2 becomes a direct sum of n line bundles, say $L_1 \oplus \ldots \oplus L_n$ (as $(k^*)^n$ acts faithfully on $kⁿ$). Hence, by Remark [3.15](#page-12-3) \mathcal{P}_2 admits a G-connection if and only if each of the line bundles L_i admits so. Consider the character

$$
\chi_i : (k^*)^n \to k^*
$$
 given by $(t_1, \ldots, t_n) \mapsto t_i$.

Then, we have the isomorphism of line bundles

$$
L_i \cong \mathcal{P}_2 \times^{\chi_i} k.
$$

Hence, the principal A-bundle $\mathcal P$ admits a G-connection if and only if the associated line bundles $\mathcal{P}_2 \times^{\chi} k$ admits G-connection for all characters χ of A. Note that since any character χ of H factors through the abelian quotient A, say χ'

$$
\mathcal{P}_2 \times^{\chi'} k \cong \mathcal{P} \times^H A \times^{\chi'} k \cong \mathcal{P} \times^{\chi} k.
$$

Then we are done by Proposition [3.14.](#page-11-0)

3.4. Infinitesimal deformation map and connection. Let X be a complete variety and $\mathcal P$ be a principal H-bundle on X. Let $\rho: G \times X \to X$ be an action of a connected algebraic group G on X.

Let $\widetilde{\mathcal{P}} := \rho^* \mathcal{P} \to G \times X$ be the pull back of the principal H-bundle. Note that there is a canonical isomorphism

$$
\widetilde{\mathcal{P}}|_{\{1_G\}\times X} \cong P
$$

as principal bundles over X. Considering $\widetilde{\mathcal{P}}$ as a family of principal H-bundles on X, we have the infinitesimal deformation map

$$
\kappa_1: \mathfrak{g} \longrightarrow H^1(X, \text{ad}(\mathcal{P})),\tag{3.16}
$$

which arises as follows:

Consider the Atiyah sequence for the pull back principal H-bundle $\widetilde{\mathcal{P}}$ (see [\(3.3\)](#page-4-2))

$$
0 \longrightarrow \text{ad}(\widetilde{\mathcal{P}}) \xrightarrow{\tilde{\iota}_0} \mathcal{A}t(\widetilde{\mathcal{P}}) \xrightarrow{\tilde{\eta}} \mathcal{I}_{G \times X} \longrightarrow 0. \tag{3.17}
$$

Let $p_1: G \times X \to G$ and $p_2: G \times X \to X$ denote the corresponding projection maps, respectively. Then we have $\mathcal{T}_{G\times X} \cong p_1^* \mathcal{T}_G \oplus p_2^* \mathcal{T}_X$. Hence, pulling back the exact sequence [\(3.17\)](#page-13-1) by the inclusion

 $j: p_1^* \mathscr{T}_G \hookrightarrow \mathscr{T}_{G \times X}$ we get the following commutating diagram with exact rows:

$$
0 \longrightarrow \text{ad}(\widetilde{\mathcal{P}}) \longrightarrow \begin{array}{c} \iota'_0 \\ \downarrow \text{ad}(\widetilde{\mathcal{P}}) \longrightarrow \mathcal{A}t(\widetilde{\mathcal{P}}) \times_{\mathcal{F}_{G \times X}} p_1^* \mathcal{F}_G \longrightarrow p_1^* \mathcal{F}_G \longrightarrow 0 \\ \downarrow \text{ad}(\widetilde{\mathcal{P}}) \longrightarrow \widetilde{\iota}_0 \longrightarrow \mathcal{A}t(\widetilde{\mathcal{P}}) \longrightarrow \widetilde{\eta} \longrightarrow \mathcal{F}_{G \times X} \longrightarrow 0. \end{array} \tag{3.18}
$$

We denote by $\mathcal{A}t_j(\widetilde{\mathcal{P}}) := \mathcal{A}t(\widetilde{\mathcal{P}}) \times_{\mathscr{T}_{G \times X}} p_1^* \mathscr{T}_G$ for the notational convenience. Restricting the short exact sequence of the top row to $\{1_G\} \times X$ and taking the connecting homomorphism we get the map κ_1 in [\(3.16\)](#page-13-2) (see [\[BS07,](#page-21-18) Section 3]).

Lemma 3.17. The connecting homomorphism

$$
\kappa_2 : \mathfrak{g} = H^0(X, \mathcal{V}) \longrightarrow H^1(X, ad(\mathcal{P}))
$$

arising from the G-Atiyah sequence [\(3.6\)](#page-5-1) coincides with the homomorphism κ_1 defined in [\(3.16\)](#page-13-2).

Proof. Let ν : $X \cong \{1_G\} \times X \hookrightarrow G \times X$ denote the inclusion map given by $x \mapsto (1_G, x)$. We show that the restriction of the top exact sequence in (3.18) via ν coincides with the G-Atiyah sequence [\(3.6\)](#page-5-1) for the principal bundle P. This will immediately imply that κ_1 and κ_2 are also same, being the connecting homomorphism of the same sequence. First note that we have the following canonical isomorphisms

$$
\nu^*(\mathrm{ad}(\widetilde{\mathcal{P}})) \cong \mathrm{ad}(\nu^*\widetilde{\mathcal{P}}) \cong \mathrm{ad}(\mathcal{P}) \text{ since } \rho \circ \nu = \mathrm{Id}_X \text{ (see [BMW12, Lemma 1.5]),}
$$

$$
\nu^*(p_1^*\mathscr{T}_G) \cong \mathcal{O}_X \otimes_k \mathfrak{g} \text{ since } \mathscr{T}_G \cong \mathcal{O}_G \otimes_k \mathfrak{g} \text{ and } p_1 \circ \nu = 1_G.
$$

By the functoriality of the Atiyah sequence (see [\[BMW12,](#page-21-16) Lemma 1.12]), the map ρ induces the following commutating diagram.

$$
0 \longrightarrow \text{ad}(\widetilde{\mathcal{P}}) \longrightarrow \widetilde{\iota_0} \longrightarrow \mathcal{A}t(\widetilde{\mathcal{P}}) \longrightarrow \widetilde{\mathcal{T}}_{G \times X} \longrightarrow 0 \qquad (3.19)
$$

$$
\downarrow \cong \qquad \qquad \downarrow \qquad \qquad d_{\rho} \downarrow
$$

$$
0 \longrightarrow \rho^* \text{ad}(\mathcal{P}) \longrightarrow \rho^* \mathcal{A}t(\mathcal{P}) \longrightarrow \rho^* \mathcal{I}_X \longrightarrow 0.
$$

Here the left most vertical arrow is the canonical isomorphism using [\[BMW12,](#page-21-16) Lemma 1.5]. The bottom row is exact since the map ρ is flat (see [\[Bri17,](#page-21-10) Remark 2.2.3]). Then using [\[HS97,](#page-21-11) Chapter III, Lemma 1.3], we get that the right-hand square in [\(3.19\)](#page-14-1) is a pull-back diagram. Now pulling back the (3.18) via ν , we get

$$
0 \longrightarrow \text{ad}(\mathcal{P}) \longrightarrow \nu^* \mathcal{A}t_j(\widetilde{\mathcal{P}}) \longrightarrow \nu^* p_1^* \mathcal{F}_G \longrightarrow 0 \qquad (3.20)
$$

\n
$$
\downarrow \qquad \qquad \downarrow \qquad \qquad \nu^*(j) \downarrow
$$

\n
$$
0 \longrightarrow \text{ad}(\mathcal{P}) \longrightarrow \nu^* \mathcal{A}t(\widetilde{\mathcal{P}}) \longrightarrow \nu^* \mathcal{F}_{G \times X} \longrightarrow 0.
$$

Here the bottom row is exact as the map j is injective. Also the right-hand square is a pull-back diagram as before. Finally pulling back (3.19) via ν , we get

$$
0 \longrightarrow \text{ad}(\mathcal{P}) \longrightarrow \nu^* \mathcal{A}t(\widetilde{\mathcal{P}}) \longrightarrow \nu^* \mathcal{I}_{G \times X} \longrightarrow 0 \qquad (3.21)
$$

\n
$$
\downarrow \cong \qquad \qquad \downarrow \qquad \qquad \nu^*(d\rho) \downarrow
$$

\n
$$
0 \longrightarrow \text{ad}(\mathcal{P}) \longrightarrow \mathcal{A}t(\mathcal{P}) \longrightarrow \mathcal{I}_X \longrightarrow 0.
$$

Here we have used the fact that $\rho \circ \nu = \text{Id}_X$. From the diagrams [\(3.20\)](#page-14-2) and [\(3.21\)](#page-15-0), we see that the top row in [\(3.20\)](#page-14-2) is the pull-back of the bottom row of [\(3.21\)](#page-15-0) via the composition $\nu^*(d\rho) \circ \nu^*(j)$. Note that this map coincides with the map ζ in [\(3.4\)](#page-4-3) by Remark [3.3.](#page-5-2) Hence, the lemma follows. \square

The following proposition indicates that infinitesimal deformations of a principal bundle can be characterized in terms of G-connections. When the underlying variety is smooth, this has been obtained in [\[BP17,](#page-21-1) Section 2.3].

Proposition 3.18. The principal H-bundle P admits a G-connection if and only if κ_1 is the zero map.

Proof. Let $\lambda : V \to \mathcal{A}t_{\rho}(\mathcal{P})$ be a G-connection on \mathcal{P} . Consider the induced map

$$
\lambda_*: H^0(X, \mathcal{V}) \longrightarrow H^0(X, \mathcal{A}t_\rho(\mathcal{P}))
$$

between the corresponding global sections. Let

$$
H^{0}(X, \mathcal{A}t_{\rho}(\mathcal{P})) \xrightarrow{\kappa_0} H^{0}(X, \mathcal{V}) \xrightarrow{\kappa_2} H^{1}(X, \text{ad}(\mathcal{P}))
$$
\n(3.22)

be the long exact sequence arising from the Atiyah sequence [\(3.6\)](#page-5-1). Since λ is a connection, we have $\kappa_0 \circ \lambda_* = Id_{H^0(X,\mathcal{V})}$. This shows that κ_0 is surjective. Hence, $\kappa_2 = 0$ from the exactness of [\(3.22\)](#page-15-1). Finally, using Lemma [3.17](#page-14-3) we get $\kappa_1 = 0$.

Conversely, suppose that κ_1 is the zero map. Hence, using Lemma [3.17](#page-14-3) and [\(3.22\)](#page-15-1) we get that the map κ_0 is surjective. Let $V \subset H^0(X, \mathcal{A}t_\rho(\mathcal{P}))$ be a subspace such that the restriction

$$
\kappa = \kappa_0|_V : V \xrightarrow{\cong} \mathfrak{g}
$$

is an isomorphism. Using this define a map

$$
\underline{\lambda} : \mathfrak{g} \xrightarrow{\kappa^{-1}} V \subset H^0(X, \mathcal{A}t_{\rho}(\mathcal{P})),
$$

which further induces the following map

$$
\lambda: \mathcal{V} \longrightarrow \mathcal{A}t_{\rho}(\mathcal{P}).
$$

Note that $pr_2 \circ \lambda = Id_{\mathcal{V}}$. Hence, λ is a G-connection on the principal bundle \mathcal{P} .

4. Equivariant structure and G-connection

In this section we investigate the relationship between the condition that a principal bundle admits a G -equivariant structure and the condition that it admits a (flat) G -connection. When the underlying variety is smooth, this has been studied in [\[BSKN15,](#page-21-0) [BP17\]](#page-21-1).

Let X be a complete variety over k. Let P be a principal H-bundle on X and $\rho: G \times X \to X$ be an action of a connected algebraic group G on X. An equivariant structure on $\mathcal P$ is a lift of the action ρ on P given by a morphism $\sigma: G \times P \to P$ such that

• the following diagram commutes,

$$
G \times P \xrightarrow{\sigma} P
$$

\n
$$
\begin{array}{ccc}\n& & p \\
& Id \times p & p \\
& G \times X & \xrightarrow{\rho} & X\n\end{array}
$$

\n
$$
(4.1)
$$

• the actions of H and G on P commute.

Proposition 4.1. If the principal H-bundle P admits an equivariant structure, then P admits an integrable G-connection.

Proof. Let the principal bundle \mathcal{P} admit an equivariant structure. The action σ induces the following homomorphism of algebraic groups

$$
\bar{\sigma}: G \longrightarrow (\text{Aut}^H(\mathcal{P}))^0, \ g \mapsto (\sigma_g: z \mapsto \sigma(g, z)),
$$

since the action of G and H on $\mathcal P$ are compatible. This gives rise to the following map between Lie algebras

$$
d\bar{\sigma} : \mathfrak{g} \longrightarrow \mathrm{Lie}(\mathrm{Aut}^H(\mathcal{P})).
$$

Composing it with the isomorphism [\(2.5\)](#page-3-2), we get the map

$$
\beta = \beta_{\mathcal{P}} \circ d\bar{\sigma} \; : \; \mathfrak{g} \longrightarrow H^0(\mathcal{P}, \mathscr{T}_{\mathcal{P}})^H \hookrightarrow H^0(\mathcal{P}, \mathscr{T}_{\mathcal{P}}).
$$

This induces the following map as in [\(3.4\)](#page-4-3)

$$
\widetilde{\zeta}: \mathcal{O}_{\mathcal{P}} \otimes_k \mathfrak{g} \longrightarrow \mathscr{T}_{\mathcal{P}},
$$

which is also compatible with the natural Lie algebra structures on the sheaves. Note that $\widetilde{\mathcal{V}} :=$ $\mathcal{O}_{\mathcal{P}} \otimes_k \mathfrak{g}$ has a natural H-equivariant structure where H acts on \mathfrak{g} trivially. Let $V \subseteq \mathcal{P}$ be an H-invariant open subset. Then for $\tilde{f} \in \mathcal{O}_{\mathcal{P}}(V)$, $\delta \in \mathfrak{g}$ and $h \in H$, we have

$$
\widetilde{\zeta}((\widetilde{f}\otimes \delta)h) = \widetilde{\zeta}(\widetilde{f}\otimes \delta h) = (\widetilde{f}h)\beta(\delta)|_V
$$

$$
= (\widetilde{f}\beta(\delta)|_V) h \text{ (since } \beta(\delta) \in H^0(\mathcal{P}, \mathcal{F}_{\mathcal{P}})^H)
$$

$$
= \widetilde{\zeta}((\widetilde{f}\otimes \delta)) h.
$$

Hence, the map ζ is also H-equivariant. Applying H-invariant pushforward p_*^H , we get

$$
\zeta': \mathcal{V} \cong p_*^H(\mathcal{O}_{\mathcal{P}}) \otimes_k \mathfrak{g} \longrightarrow p_*^H \mathcal{F}_{\mathcal{P}} = \mathcal{A}t(\mathcal{P}).
$$

Now define the map λ as follows

$$
\lambda : \mathcal{V} \longrightarrow \mathcal{A}t(\mathcal{P}) \oplus \mathcal{V}
$$

\n
$$
v \longmapsto \zeta'(v) \oplus v.
$$
\n(4.2)

We show that $\eta \circ \zeta' = \zeta$. First note that as the bundle P is equivariant from [\(4.1\)](#page-16-2), we get the following commutative diagram

where that the map θ is defined in [\(2.4\)](#page-3-0). To see this, take $g \in G$. We need to show that $\theta(\sigma_g) = \rho_g$. But note that from (2.3) , we have

$$
(\theta(\sigma_g))(p(z)) = p(\sigma_g(z))
$$

 $= \rho_q(p(z))$ (using commutativity of the diagram in [\(4.1\)](#page-16-2)).

Now the assertion follows using the surjectivity of the projection map p . Taking the corresponding Lie algebras in [\(4.3\)](#page-17-0) and using [\(2.6\)](#page-3-3), we get the following commutative diagram of Lie algebras

Let U be an open subset of X and $\delta \in \mathfrak{g}$. Denote by $V = p^{-1}(U)$. Note that $\zeta(1 \otimes \delta) = \alpha(\delta)|_U$ and $\widetilde{\zeta}(1 \otimes \delta) = \beta(\delta)|_V$. From [\(4.4\)](#page-17-1), we have $(\eta(X) \circ \beta)(\delta) = \alpha(\delta)$. Since η is a sheaf homomorphism, we get

$$
\eta(\beta(\delta)|_V) = \eta(X)(\beta(\delta))|_V = \alpha(\delta)|_U.
$$

Hence, we get $\eta \circ \zeta' = \zeta$. Thus

$$
(\eta - \zeta)(\lambda(v)) = (\eta \circ \zeta')(v) - \zeta(v) = 0.
$$

Hence, we get that Im(λ) \subseteq $At_{\rho}(\mathcal{P})$ and the induced map from [\(4.2\)](#page-17-2) will also be denoted by

$$
\lambda: \mathcal{V} \longrightarrow \mathcal{A}t_{\rho}(\mathcal{P}).
$$

Clearly, the composition $pr_2 \circ \lambda = Id_{\mathcal{V}}$. So λ defines a G-connection on the principal bundle \mathcal{P} . Also, since ζ' preserves the Lie algebra structure, λ is in fact an integrable connection.

Proposition 4.2. Let the principal H-bundle $p : \mathcal{P} \to X$ admit an integrable G-connection. Assume that G is semisimple and simply connected. Then P admits an equivariant structure.

Proof. Let $\lambda : \mathcal{V} \to \mathcal{A}t_{\rho}(\mathcal{P})$ be an integrable G-connection. Since, $pr_2 \circ \lambda = Id_{\mathcal{V}}$, we get

$$
\lambda(w)=(v,w),
$$

where v, w are sections of the sheaves $\mathcal{A}t(\mathcal{P})$ and V such that (v, w) is a section of $\mathcal{A}t_{\rho}(\mathcal{P})$, i.e.

$$
\eta(v) = \zeta(w). \tag{4.5}
$$

Consider the following composite of maps

$$
\lambda':\mathcal{V}\stackrel{\lambda}{\longrightarrow}\mathcal{A}t_{\rho}(\mathcal{P})\stackrel{\mathrm{pr}_1}{\longrightarrow}\mathcal{A}t(\mathcal{P}).
$$

So $\lambda'(w) = v$. Taking global sections we get the following map.

$$
\lambda'(X): \mathfrak{g} \longrightarrow H^0(\mathcal{P}, \mathscr{T}_{\mathcal{P}})^H.
$$

Note that $\lambda'(X)$ is a Lie algebra homomorphism as λ is integrable. Using [\(4.5\)](#page-18-0), we see that

$$
\eta(X) \circ \lambda'(X) = \alpha. \tag{4.6}
$$

Since G is connected, simply connected and semisimple for any algebraic group G' and any Lie algebra homomorphism from $\mathfrak g$ to Lie (G') lifts to a unique morphism from G to G' (see [\[DG80,](#page-21-6) Proposition 2.9(b), Section 6, Ch II]). Thus there are algebraic group homomorphisms $\bar{\rho} = \bar{\rho}' : G \to \text{Aut}(X)$ and $\bar{\sigma}: G \to \text{Aut}^H(\mathcal{P})$ such that

Lie(
$$
\bar{\rho}
$$
) = α , Lie($\bar{\rho'}$) = $\eta(X) \circ \lambda'(X)$ and Lie($\bar{\sigma}$) = $\lambda'(X)$.

Since $\eta(X) \circ \lambda'(X) = \mathrm{Lie}(\theta) \circ \mathrm{Lie}(\bar{\sigma}) = \mathrm{Lie}(\theta \circ \bar{\sigma}),$ we have $\bar{\rho'} = \theta \circ \bar{\sigma}$, i.e. the following diagram commutes.

(see [\[DG80,](#page-21-6) Proposition 2.1, Section 6, Ch II]). This implies that the conditions in [\(4.1\)](#page-16-2) are satisfied (cf. [\[Bri18,](#page-21-5) Remark 2.4(i)]). Hence, P admits an equivariant structure.

Proposition 4.3. Suppose the principal H-bundle $p : \mathcal{P} \to X$ admits a G-connection. Assume that G is semisimple. Then, P admits an integrable G-connection.

Proof. Let $\lambda : \mathcal{V} \to \mathcal{A}t_{\rho}(\mathcal{P})$ be a G-connection. Then taking global sections, we get

$$
\lambda(X): \mathfrak{g} \longrightarrow H^0(X, \mathcal{A}t_{\rho}(\mathcal{P})),
$$

which is k-linear. Since λ is a connection, we have $pr_2(X) \circ \lambda(X) = Id_{\mathfrak{g}}$. Hence, the Lie algebra homomorphism $pr_2(X)$ is also surjective. Since $\mathfrak g$ is semisimple there exists a Lie subalgebra $\mathfrak a$ of $H^0(X, \mathcal{A}t_{\rho}(\mathcal{P}))$ such that

$$
q:=\mathrm{pr}_2(X)|_{\mathfrak{a}}:\mathfrak{a}\stackrel{\cong}{\longrightarrow} \mathfrak{g}
$$

is an isomorphism of Lie algebras (see [\[Bou60,](#page-21-19) Corollaire 3, pg. 91]). Consider the homomorphism of sheaves

$$
\lambda':\mathcal{V}\longrightarrow \mathcal{A}t_{\rho}(\mathcal{P})
$$

induced from the map q^{-1} : $\mathfrak{g} \to \mathfrak{a} \subseteq H^0(X, \mathcal{A}t_\rho(\mathcal{P}))$. Clearly, λ' preserves the Lie algebra structures and $\text{pr}_2 \circ \lambda' = Id_{\mathcal{V}}$ holds. Thus λ' is an integrable *G*-connection.

Corollary 4.4. Let $p : \mathcal{P} \to X$ be a principal H-bundle. Assume that G is semisimple and simply connected. Then the following conditions are equivalent.

- (1) The principal bundle admits an equivariant structure.
- (2) The principal bundle admits an integrable G-connection.
- (3) The principal bundle admits a G-connection.

Remark 4.5. Some examples of semisimple and simply connected algebraic groups are $SL(n, k)$, $Sp(2n, k)$ and $Spin(n, k)$ and non-examples are $PGL(n, k)$ and $SO(n, k)$ (see [\[MT11,](#page-22-7) Table 9.2]).

The following proposition provides a criterion for existence of equivariant structure extending [\[BP17,](#page-21-1) Corollary 4.4] to the case of varieties possibly having singularities.

Proposition 4.6. Let $p : \mathcal{P} \to X$ be a principal H-bundle on X such that for all $g \in G$ we have isomorphisms

$$
\Phi_g: \mathcal{P} \xrightarrow{\cong} \rho_g^* \mathcal{P} \tag{4.7}
$$

of principal H-bundles over X. Assume that G is semisimple and simply connected. Then, $\mathcal P$ admits an equivariant structure.

Proof. We first show that the given condition (4.7) implies that there is an isomorphism as principal H-bundles over $G\times X$

$$
\Psi: p_2^* \mathcal{P} \stackrel{\cong}{\longrightarrow} \rho^* \mathcal{P} =: \widetilde{\mathcal{P}},
$$

where $p_2 : G \times X \to X$ denotes the projection onto the second factor. Note that

$$
p_2^* \mathcal{P} = \{(g, x, z) \in (G \times X \times \mathcal{P}) : x = p(z)\}\
$$
and $\widetilde{\mathcal{P}} = \{(g, x, z) \in (G \times X \times \mathcal{P}) : \rho(g, x) = p(z)\}.$

Let $(g, x, z) \in p_2^* \mathcal{P}$. Then using the isomorphism Φ_g , we get

$$
\Phi_g(z) = (x, z') \text{ such that } \rho(g, x) = p(z').
$$

Hence, we define $\Psi(g, x, z) = (g, x, z')$. Note that its inverse map is given by

$$
(g_1, x_1, z_1) \longmapsto (g_1, x_1, \Phi_{g_1}^{-1}(x_1, z_1)).
$$

Thus the top exact sequence in [\(3.18\)](#page-14-0) admits a canonical splitting (cf. [\[NR75,](#page-22-8) Section 3]). Hence, by Lemma [3.17](#page-14-3) the infinitesimal deformation map κ_1 is zero map. Then by Proposition [3.18](#page-15-2) the principal bundle P admits a G-connection. Finally, using Corollary [4.4](#page-19-0) we conclude that P admits an equivariant structure. \Box

5. Examples

5.1. Toric varieties. Let X be a complete toric variety under the action of the algebraic torus $T \cong (k^*)^n$. Let $D = X \setminus T$ be the boundary divisor. Then by [\[Oda88,](#page-22-9) Proposition 3.1], we have that the logarithmic tangent sheaf $\mathcal{T}_X(-\text{log}D) \subseteq \mathcal{T}_X$ is isomorphic to the trivial bundle $\mathcal{O}_X \otimes_k \text{Lie}(T)$. Hence, a T-connection is same as a logarithmic connection singular along D . Note that the torus T is not semisimple, so we cannot directly apply Corollary [4.4.](#page-19-0) A different proof is given in [\[DKP23\]](#page-21-2).

5.2. Line bundle. Let X be a normal complete variety over k. Let G be a connected linear algebraic group acting on X. Then for any line bundle $\mathcal L$ on X there exists an integer n such that the tensor power $\mathcal{L}^{\otimes n}$ admits a G-equivariant structure (see [\[MFK94,](#page-22-10) Corollary 1.6]). Hence, $\mathcal{L}^{\otimes n}$ admits an integrable G-connection by Corollary [4.4.](#page-19-0) If X satisfies $H^1(X, \mathcal{O}_X) = 0$, then by Remark [3.6](#page-6-1) we see that any line bundle on X admits a G-connection. As a consequence, $\mathcal{O}_{\mathbb{P}^n}(1)$ admits a $PGL(n+1, k)$ connection but it does not admit any $PGL(n+1,k)$ -equivariant structure (see [\[MFK94,](#page-22-10) Page 33]). Note that $PGL(n+1,k)$ is not simply connected $(SL(n+1,k))$ being the simply connected cover). This shows that the assumptions on G in Corollary [4.4](#page-19-0) are necessary.

5.3. Trivial Action. If the action $\rho: G \times X \to X$ is trivial, the image of the induced map $\overline{\rho}: G \to$ Aut⁰(X) is Id_X. Hence, the induced map α : $\mathfrak{g} \to H^0(X, \mathcal{T}_X)$ is the zero map. Hence, we have

$$
\mathcal{A}t_{\rho}(\mathcal{P})=\text{ad}(\mathcal{P})\oplus (\mathcal{O}_X\otimes \mathfrak{g}).
$$

Hence, a G-connection on the principal bundle P corresponds to a \mathcal{O}_X -module homomorphism $\mathcal{O}_X \otimes$ $\mathfrak{g} \to \text{ad}(\mathcal{P})$. Note that there is a tautological G-connection on $\mathcal P$ induced from the zero map from $\mathcal{O}_X \otimes \mathfrak{g}$ to ad(P). Hence, by Proposition [\(4.1\)](#page-16-1) the principal bundle P admits a natural integrable G-connection.

5.4. **Tautological G-Connection.** Let X be a complete variety over k and $p : \mathcal{P} \to X$ be a principal H-bundle. Recall that $G := (Aut^H(\mathcal{P}))^{\circ}$ is an algebraic group. Note that G has a tautological action on P and X, respectively given as follows:

$$
\rho_0: G \times \mathcal{P} \to \mathcal{P}, \text{ given by } (\psi, z) \to \psi(z)
$$

$$
\sigma_0: G \times X \to X, \text{ given by } (\psi, x) \to \theta(\psi)(x),
$$

where $\psi \in G$, $x \in X$, $z \in \mathcal{P}$ and θ is defined in [\(2.4\)](#page-3-0). Note that under these actions the principal bundle P becomes G-equivariant using (2.3) . Hence, it admits an integrable G-connection by Proposition [4.1](#page-16-1) (cf. [\[BP17,](#page-21-1) Proposition 3.3]).
