Opposites of weak ω -categories and the suspension and hom adjunction

Abstract

We define inductively the opposites of a weak globular ω -category with respect to a set of dimensions, and we show that the properties of being free on a globular set or a computad are preserved under forming opposites. We then provide a new description of the hom functor on ω -categories, and we show that it admits a left adjoint that we construct explicitly and call the suspension functor. We also show that the hom functor preserves the property of being free on computad, and that the opposites of a hom ω -category are hom ω -categories of opposites of the original ω -category.

1 Introduction

In recent years, higher category theory has found applications in various fields. Globular higher categories and their computads have been used significantly in rewriting theory [22], homology theory [18], topological quantum field theory [4], and in the study of Homotopy Type Theory with equality [2, 20, 24]. Moreover, there has recently been significant progress [15] towards the conjecture that globular higher groupoids are equivalent to homotopy types [14].

Globular higher categories, or ω -categories, are a model of higher categories that have been introduced independently by a number of authors. Batanin and Leinster define them as algebras for some monad T on the category of globular sets [6, 19], Grothendieck and Maltsiniotis define them as models of some globular theory [21], while Finster and Mimram define them as models of some type theory [13]. The various notions of ω -category arising from those definitions have been shown to be equivalent by Ara [3] and Bourke [9], and by Benjamin, Finster and Mimram [7] respectively, so we may choose to work with either of them. In this paper, we will use Leinster's definition together with the recent description of the monad T by Dean et al. [12], which is in turn heavily inspired by the type-theoretic approach of Finster and Mimram. To obtain the

monad T, Dean et al. first construct a category of computads Comp consisting of generating data for ω -categories, and then produce an adjunction

$\mathsf{Free}:\mathsf{Glob}\rightleftarrows\mathsf{Comp}:\mathsf{Cell}$

between globular sets and computeds inducing the monad T of Leinster.

Our primary contribution in this paper is the construction of the opposites of an ω -category. Such a construction is well-known in many contexts, including ordinary and enriched categories, bicategories, or $(\infty, 1)$ -categories, and it has significantly helped in the development of the corresponding theories. The existence of dual categories allows for the unification of concepts, such as limits with colimits, or left and right Kan extensions and lifts, and for the simultaneous proof of theorems about them. That makes us believe that the existence of opposites for ω -categories will allow for the theory of ω -categories to be developed more easily.

Ordinary categories or $(\infty, 1)$ -categories admit a single opposite, obtained by reversing the direction of all its arrows. Bicategories admit three opposites, obtained by reversing the direction of its arrows, its 2-cells, or both of them at the same time. More generally, it is expected that *n*-categories admit $2^n - 1$ opposites, obtained by reversing the direction of cells of certain dimensions. For ω -categories, we show that there exists a faithful action of the group

$$G = \mathcal{P}(\mathbb{N}_{>0})$$

of subsets of the positive natural numbers on the category of ω -categories, where a subset w acts on an ω -category by reversing the direction of its n-cells for every $n \in w$.

To define the opposite of an ω -category with respect to some $w \in G$, we first define the opposite of a globular set and a computed

$$\mathsf{op}_w:\mathsf{Glob} o\mathsf{Glob}$$

 $\mathsf{op}_w:\mathsf{Comp} o\mathsf{Comp}$

compatible with the adjunctions Free and Cell, in the sense that the following squares commute strictly and up to a natural isomorphism respectively:

$$\begin{array}{ccc} \text{Comp} & \stackrel{\text{op}_w}{\longrightarrow} & \text{Comp} & & \text{Comp} \\ \hline & & & & \text{Free} \end{array} & & \uparrow & \text{Free} & & \text{Cell} & \stackrel{\text{op}_w^{\text{Cell}}}{\longrightarrow} & \downarrow & \text{Cell} \\ \hline & & & & \text{Glob} & & & \text{Glob} & & & \text{Glob} \end{array}$$

Out of this data, we get a natural isomorphism

$$\mathsf{op}_w^T: T\,\mathsf{op}_w \Rightarrow \mathsf{op}_w\,T$$

making the pair $(\mathsf{op}_w, \mathsf{op}_w^T)$ an automorphism of the monad T, hence an automorphism

$$\mathsf{op}_w:\omega\operatorname{Cat}
ightarrow\omega\operatorname{Cat}$$

of the category of ω -categories by the general theory of monads [23].

Our second goal is to show that the same techniques can give a novel construction of the hom ω -categories of an ω -category of Cottrell and Fujii [11]. Unilike strict ω -categories, the ω -categories we consider are not defined via enrichment, so it is not immediately clear that for everu ω -category X and objects $x, y \in X_0$, the globular set $\Omega(X, x, y)$ of cells with source x and target y admits the structure of an ω -category. Here we will give a new construction of such an ω -category structure. Starting from the suspension and hom adjunction

$$\Sigma : \mathsf{Glob} \rightleftharpoons \mathsf{Glob}^{\star,\star} : \Omega$$

between globular sets and bipointed globular sets, we will extend the left adjoint to a functor

$$\Sigma: \mathsf{Comp} \to \mathsf{Comp}^{\star,\star}$$

between computads and bipointed computads, compatible with the Free \dashv Cell adjunction, in that the following squares commute strictly and up to a natural transformation respectively

$$\begin{array}{ccc} \mathsf{Comp} & \xrightarrow{\Sigma} & \mathsf{Comp}^{\star,\star} & & \mathsf{Comp} & \xrightarrow{\Sigma} & \mathsf{Comp}^{\star,\star} \\ \mathsf{Free}^{\uparrow} & \uparrow & \mathsf{Free}^{\star,\star} & & \mathsf{Cell} & & \downarrow \\ \mathsf{Glob} & \xrightarrow{\Sigma} & \mathsf{Glob}^{\star,\star} & & \mathsf{Glob} & \xrightarrow{\Sigma} & \mathsf{Glob}^{\star,\star} \end{array}$$

where $Free^{*,*} \dashv Cell^{*,*}$ are the obvious bipointed generalisations of Free and Cell respectively. Using the mate correspondence, we then get a natural transformation

$$\Omega^T:T\,\Omega\Rightarrow\Omega\,T^{\star,\star}$$

for $T^{\star,\star} = \mathsf{Cell}^{\star,\star} \mathsf{Free}^{\star,\star}$, which makes the pair (Ω, Ω^T) a morphism of monads from $T^{\star,\star}$ to T. On the level of algebras, this gives rise to a functor

$$\Omega: \omega \operatorname{Cat}^{\star,\star} \to \omega \operatorname{Cat}$$

from the category of bipointed ω -categories to the category of ω -categories, extending the hom functor Ω on globular sets defined above. By the adjoint lifting theorem, this functor admits a left adjoint, which coincides with the suspension functor on computads. Moreover, we will show that Ω preserves the property of being free on a computad by giving a novel criterion for freeness. Finally, we will show that the two constructions we describe in this article are related by the following commutative square

$$\begin{array}{c} \omega \operatorname{Cat}^{\star,\star} \xrightarrow{\operatorname{op}_{w}} \omega \operatorname{Cat}^{\star,\star} \\ \Omega \\ \omega \operatorname{Cat} \xrightarrow{\operatorname{op}_{w-1}} \omega \operatorname{Cat} \end{array}$$

where $w - 1 = \{x \in \mathbb{N}_{>0} : x + 1 \in w\}.$

2 Globular pasting diagrams

In this section, we briefly recall the notion of globular pasting diagrams, since they are a basic ingedient for any definition of weak ω -categories. Those are a family of globular sets such that diagrams indexed by them in a strict ω -category can be composed in a unique way. Pasting diagrams are parametrised by rooted, planar trees [6], an inductive description of whose as iterated lists was recently given by Dean et al [12, Section 2]. Our presentation in this section follows ibid. and Leinster [19, Appendix F.2], noting that pasting diagrams are bipointed globular sets generated by the suspension and the wedge sum operations.

To set the notation, we recall that *globular sets* are presheaves on the category \mathbb{G} of globes with objects the natural numbers \mathbb{N} and morphisms freely generated by the source and target inclusions

$$s_n, t_n \colon [n] \to [n+1]$$

under the globularity relations:

$$s_{n+1} \circ s_n = t_{n+1} \circ s_n$$
 $s_{n+1} \circ t_n = t_{n+1} \circ t_n.$

In other words, a globular set X consists of a set X_n for every natural number $n \in \mathbb{N}$ together with *source* and *target* functions

src, tgt:
$$X_{n+1} \to X_n$$

satisfying the duals relations:

$$\operatorname{src} \circ \operatorname{src} = \operatorname{src} \circ \operatorname{tgt} \qquad \operatorname{tgt} \circ \operatorname{src} = \operatorname{tgt} \circ \operatorname{tgt}.$$


We will call elements of X_n the *n*-cells of X. The *k*-source and *k*-target of an *n*-cell x for k < n are the *k*-cells defined by

$$\operatorname{src}_k x = \operatorname{src}(\cdots(\operatorname{src} x)) \qquad \qquad \operatorname{tgt}_k x = \operatorname{tgt}(\cdots(\operatorname{tgt} x))$$

We will denote by \mathbb{D}^n the representable globular set associated to a natural number $n \in \mathbb{N}$, and call it the *n*-disk.

Bipointed globular sets are triples (X, x_-, x_+) consisting of a globular set and two distinguished 0-cells x_-, x_+ of it. They form a category $\mathsf{Glob}^{*,*}$ toether with morphisms of globular sets that preserve the distinguished 0-cells. By the Yoneda lemma, this is the coslice category $\mathbb{D}^0 + \mathbb{D}^0 \setminus \mathsf{Glob}$ or the category of cospans of globular sets from \mathbb{D}^0 to itself. The category of bipointed globular sets is locally finitely presentable as a coslice of a presheaf topos [1, Proposition 1.57], so in particular it is complete and cocomplete. Limits and connected colimits in $\mathsf{Glob}^{\star,\star}$ are computed as in Glob , i.e. they are created by the functor $\mathcal{U}_{\star,\star}$: $\mathsf{Glob}^{\star,\star} \to \mathsf{Glob}$ that forgets the basepoints. The coproduct of a family of bipointed sets is computed as the wide pushout of the corresponding maps out of $\mathbb{D}^0 + \mathbb{D}^0$.

Being a category of cospans, the category $\mathsf{Glob}^{*,*}$ is monoidal with respect to the composition of cospans, which we will call the *wedge sum*. More explicately, the wedge sum \lor of a pair of bipointed globular sets (X, x_-, x_+) and (Y, y_-, y_+) is obtained by the following pushout square in Glob ,



with basepoints the image of x_{-} and the image of y_{+} in the pushout. The unit of the wedge sum is given by the 0-disk \mathbb{D}^{0} with both basepoints being its unique 0-cell. More generally, we will denote by $\bigvee_{i=1}^{n} X_{i}$ the iterated monoidal product of a finite family of bipointed globular sets X_{1}, \ldots, X_{n} , and we will denote the inclusion of the *j*-th component for $1 \leq j \leq n$ by

$$\operatorname{in}_j \colon X_j \to \bigvee_{i=1}^n X_j.$$

This is a morphism of globular sets, that is only a morphism of bipointed globular sets for n = 1.

The suspension of a globular set X is the bipointed globular set ΣX with two 0-cells v_{-} and v_{+} , and with positive dimensional cells given by

$$(\Sigma X)_{n+1} = X_n$$

for every $n \in \mathbb{N}$. The source and target maps of an *n*-cell of ΣX for n > 2is given by its source and target in X, while the source and target of 1-cells are given by v_{-} and v_{+} respectively. The basepoints of the suspensions are v_{-} and v_{+} . Suspension is left adjoint to the *path space* functor $\Omega: \operatorname{Glob}^{*,*} \to \operatorname{Glob}$ sending a bipointed globular set (X, x_{-}, x_{+}) to the globular set given by

$$\Omega(X, x_{-}, x_{+})_{n} = \{ x \in X_{n+1} \mid \operatorname{src}_{0}(x) = x_{-} \text{ and } \operatorname{tgt}_{0}(x) = x_{+} \}$$

The unit of the adjunction is the identity of the functor

$$\Omega \Sigma = id$$

while the counit $\kappa : \Sigma \Omega \Rightarrow id$ is the natural transformation with components the bipointed morphisms

$$\kappa: \Sigma \Omega(X, x_-, x_+) \to (X, x^-, x^+)$$

given by the subset inclusions $\Omega(X, x_-, x_+)_n \subseteq X_{n+1}$.

Finally, we have introduced all the ingredients to define globular pasting diagrams and the family parametrising them. We will call elements of that family Batanin trees following Dean et al [12].

Definition 1. A *Batanin tree* is a list $br[B_1, \ldots, B_n]$, where the B_i are Batanin trees.


In other words, the set Bat of Batanin trees is the carrier of the initial algebra of the list endofunctor List: Set \rightarrow Set given by

$$\operatorname{List} X = \coprod_{n \in \mathbb{N}} X^n$$

with the obvious action on morphisms. In particular, there exists a tree br[] corresponding to the empty list, and using this tree, we can define more complicated trees, such as the tree

$$B = \mathsf{br}[\mathsf{br}[\mathsf{br}[],\mathsf{br}[]],\mathsf{br}[]].$$

It is convenient to visualise Batanin trees as planar trees by representing br[] as a tree with one root and no branches, and $br[B_1, \ldots, B_n]$ as a tree with a new root and n branches, each of which is connected to the root of the tree corresponding to B_i . For example, the tree B above can be visualised as



The *dimension* of a Batanin tree is the height of the corresponding planar tree, or equivalently the maximum of the dimension of the cells in the corresponding globular pasting diagram, defined below. It can be computed recursively by

$$\dim(\operatorname{br}[B_1,\ldots,B_n]) = \max(\dim B_1 + 1,\ldots,\dim B_n + 1).$$


In particular, it follows that br[] is the unique tree of dimension 0.

Definition 2. The *bipointed globular set of positions* of a Batanin tree *B* is the bipointed globular set $\mathsf{Pos}^{*,*}(B)$ defined recursively by

$$\mathsf{Pos}^{\star,\star}(\mathsf{br}[B_1\ldots,B_n]) = \bigvee_{i=1}^n \Sigma \mathcal{U}_{\star,\star} \, \mathsf{Pos}^{\star,\star}(B_i).$$

The globular pasting diagram Pos(B) of a Batanin tree B is the underlying globular set of $Pos^{\star,\star}(B)$, according to the fomulae in [19, Appendix F.2].

A way to calculate the globular set of positions of a tree is described in [8], where positions correspond to *sectors* of the tree, i.e. the spaces between two consecutive branches at each node, as well as the space before the first branch and the one after the last one. Under this description, the basepoint are given by the left-most and right-most sector at the root. For the tree B above, we can label the position as follows.



The dimension of a position is given by the distance of the node it is attached in from the root, while its source and target are given by the positions right below it. Therefore, the globular set of positions of B is the following globular set

$$x \xrightarrow[h]{\substack{f \\ \neg g \rightarrow \\ \downarrow b \\ h}} y \xrightarrow{k} z$$

which is bipointed by the positions x and z respectively. Here, the positions f, g, h, a, b are the positions of the left branch of B, while k is the position of its right branch. The dimension of those positions has been raised by the suspension operation. The 0-positions x, y, z are the new cells created by the suspension operation. The two basepoints of $\mathsf{Pos}^{\star,\star}(B)$ are given by x and z.

Definition 3. The *k*-boundary of a Batanin tree *B* is the tree $\partial_k B$ defined recursively by

$$\partial_0 B = \mathsf{br}[]$$

 $\partial_{k+1} \mathsf{br}[B_1, \dots, B_n] = \mathsf{br}[\partial_k B_1, \dots, \partial_k B_n]$

The *k*-boundary of a tree B is the tree obtained by removing all nodes of B whose distance from the root is at least k. In terms of pasting diagrams, this amounts to removing all cells of dimension more than k and identifying all parallel *k*-cells. For example, the 1-boundary of the tree B considered above is the following tree.



The positions of the boundary can be included back into the positions of the original tree in two ways, the *source* and *target inclusions*

$$s_k^B, t_k^B \colon \mathsf{Pos}(\partial_k B) \to \mathsf{Pos}(B)$$

defined recursively as follows: the morphisms s_0^B and t_0^B out of $\mathbb{D}^0 \cong \mathsf{Pos}(\mathsf{br}[])$ select the first and second basepoint respectively, while for $B = \mathsf{br}[B_1, \ldots, B_n]$ the morphisms s_{k+1}^B and t_{k+1}^B are given by

$$s_{k+1}^B = \bigvee_{i=1}^n \Sigma s_k^{B_i} \qquad t_{k+1}^B = \bigvee_{i=1}^n \Sigma t_k^{B_i}.$$

In particular, the source and target inclusions are morphisms of bipointed globular sets when k > 0.

3 Computads and ω -categories

Dean et al. [12] recently presented a new definition of ω -categories and their computads, inspired by the type-theoretic definition of Finster and Mimram [13], and they showed that their notion of ω -category coincides with the operadic definition of Leinster [19]. In this approach, first a category of computads Comp is defined together with an adjunction

Free: Glob
$$\rightleftharpoons$$
 Comp: Cell

and then ω -categories are defined as algebras for the monad

$$T: \operatorname{Glob} \to \operatorname{Glob}$$

induced by the adjunction. We recall that morphisms of computads here are strict ω -functors, and not Batanin's morphisms of computads [5]. In other words, the comparison functor

$$K^T\colon \mathsf{Comp} o \omega\,\mathsf{Cat}$$

is fully faithful and injective on objects.

We will briefly recall the definition of computads and the Free \dashv Cell adjunction. First, categories Comp_n of *n*-computads are defined recursively for every natural number $n \in \mathbb{N}$, together with forgetful functor

 $u_n \colon \operatorname{Comp}_n \to \operatorname{Comp}_{n-1}$

for n > 0. In the same mutual recursion, functors

are defined and natural transformations

$$\mathsf{bdry}_n \colon \mathsf{Cell}_n \Rightarrow \mathsf{Sphere}_n u_n$$

 $\mathsf{pr}_i \colon \mathsf{Sphere}_n \Rightarrow \mathsf{Cell}_n$

for i = 1, 2. Here the functors Cell_n and Sphere_n return the set of *n*-cells, and the set of pairs of parallel *n*-cells of the ω -category generated by a computed C, while bdry_n returns the source and the target of an *n*-cell.

An *n*-computed is a triple C consisting of an (n-1)-computed C_{n-1} , a set of *n*-dimensional generators V_n^C and an attaching function

 $\phi_n^C \colon V_n^C \to \mathsf{Sphere}_{n-1}(C_{n-1})$

assigning to each generator a source and target. A morphism $\sigma: C \to D$ consists of a morphism $\sigma_{n-1}: C_{n-1} \to D_{n-1}$ and a function $\sigma_{n,V}: V_n^C \to \operatorname{Cell}_n D$ compatible with the source and target functions in the sense defined in [12, Section 3.1]. The forgetful functors u_n are the obvious projections. As a base case for this definition, here we let Comp_{-1} be the terminal category and $\operatorname{Sphere}_{-1}$ the functor choosing some terminal set.

The set $\operatorname{Cell}_n C$ of *n*-cells of a computed *C* is inductively defined together with the set of morphisms with target *C* and the function $\operatorname{bdry}_{n,C}$. Cells of *C* are either of the form var *v* for a generator $v \in V_n^C$, or when n > 0, they are coherence cells $\operatorname{coh}(B, A, \tau)$, where *B* is a tree of dimension at most *n*, *A* is an (n-1)-sphere of $\operatorname{Free}_{n-1} \operatorname{Pos}(B)$, satisfying a fullness condition that will be explained below, and τ : $\operatorname{Free}_n \operatorname{Pos}(B) \to C$ is a morphism. The boundary of a cell is given recursively by the formula

$$\begin{aligned} \mathsf{bdry}_{n,C}(\mathsf{var}\,v) &= \phi_n^C(v)\\ \mathsf{bdry}_{n,C}(\mathsf{coh}(B,A,\tau)) &= \mathsf{Sphere}_{n-1}(\tau_{n-1})(A) \end{aligned}$$

The functor $Free_n$ sends a globular set X to the computed

$$\operatorname{Free}_n X = (\operatorname{Free}_{n-1} X, X_n, \phi_n^X) \qquad \phi_n^X(x) = (\operatorname{var}(\operatorname{src} x), \operatorname{var}(\operatorname{tgt} x)),$$

and a morphism $f: X \to Y$ to the morphism consisting of $\operatorname{Free}_{n-1} f$ and $\operatorname{var} \circ f_n$. The functor Sphere_n sends an *n*-computed *C* to the set

Sphere_n
$$C = \{(a, b) \in \operatorname{Cell}_n C \times \operatorname{Cell}_n C \mid \operatorname{bdry}_n a = \operatorname{bdry}_n b\}$$

and acts on morphisms in the obvious way. The projection natural transformations are the obvious ones. We will denote by

src, tgt:
$$\operatorname{Cell}_n \Rightarrow \operatorname{Cell}_{n-1} u_n$$

the composite of bdry_n with the projections.

The fullness condition mentioned above for $A = (a, b) \in \text{Sphere}_n \operatorname{Free}_n \operatorname{Pos}(B)$ is a condition on the generators used to define a and b. It is equivalent to the statement that

$$a = \operatorname{Cell}_n \operatorname{Free}_n(s_n^B)(a') \qquad \qquad b = \operatorname{Cell}_n \operatorname{Free}_n(t_n^B)(b')$$

for cells a', b' of $\mathsf{Free}_n \mathsf{Pos}(\partial_n B)$ using all generators of $\partial_n B$. That means that the *support* of a', b' contains all positions of $\partial_n B$, where the support of an *n*-cell

c over a computed C is the set of generators defined by

$$\begin{split} \mathsf{supp}(\mathsf{var}\,v) &= \begin{cases} \{v\}, & \text{when } n = 0\\ \{v\} \cup \mathsf{supp}(\mathsf{pr}_1\,\phi_n^C(v)) \cup \mathsf{supp}(\mathsf{pr}_2\,\phi_n^C(v)), & \text{when } n > 0 \end{cases}\\ \\ \mathsf{supp}(\mathsf{coh}\,(B,A,\tau)) &= \bigcup_{k \leq n} \bigcup_{v \in \mathsf{Pos}_k(B)} \mathsf{supp}(\tau_{k,V}(v)) \end{split}$$

This completes the inductive definition. The category **Comp** of computads is the limit of the categories Comp_n for all $n \in \mathbb{N}$, i.e computads $C = (C_n)_{n \in \mathbb{N}}$ are sequences of *n*-computads C_n such that $u_{n+1}C_{n+1} = C_n$, and mopphisms of such are sequences of morphisms. The free functor

 $\mathsf{Free}\colon\,\mathsf{Glob}\to\mathsf{Comp}$

is the functor with components Free_n for all $n \in \mathbb{N}$, while the cell functor

Cell: Comp \rightarrow Glob

sends a computed C to the globular set consisting of $\operatorname{Cell}_n C_n$ for all $n \in \mathbb{N}$, and the source and target functions defined above. The unit of the adjunction

 $\eta: \mathsf{id} \Rightarrow \mathsf{Cell}\,\mathsf{Free}$

sends a cell x of a globular set X to the generator var x, while the counit

 $\varepsilon \colon$ Free Cell \Rightarrow id

consists of the morphisms ε_C : Free Cell $C \to C$ given by the identities of the set

 $V_n^{\mathsf{Free \,Cell\,}C} = \mathsf{Cell}_n \, C$

for all $n \in \mathbb{N}$.

4 Opposites

An important feature of ordinary category theory is the duality stemming from the existence of opposite categories. This feature extends to higher categories, where we may define opposites by reversing the direction of all cells in certain dimensions. In this section, we will progressively define the opposite of a globular set, a computad, and an ω -category with respect to a set of dimensions $w \subseteq \mathbb{N}_{>0}$. We will then show that the formation of opposites in all those cases gives rise to an action of the Boolean group

$$G = \mathcal{P}(\mathbb{N}_{>0}) \cong \mathbb{Z}_2^{\mathbb{N}_{>0}}$$

of subsets of the positive integers with respect to symmetric difference. This group is clearly isomorphic to the group of functions $\mathbb{N}_{>0} \to \mathbb{Z}_2$ with pointwise multiplication, where each subset is identified with its indicator function. Abusing notation we will identify a subset w with its indicator function, and write w(n) for the value of the indicator function at $n \in \mathbb{N}_{>0}$.

4.1 The opposite of a globular set

The group G acts on the category \mathbb{G} of globes by swapping the source and target inclusions. More precisely, an element $w \in G$ acts as the identity-on-objects functor

$$\operatorname{op}_w \colon \mathbb{G} \to \mathbb{G}$$

given on the generating morphisms by

$$\mathsf{op}_w(s_n) = \begin{cases} t_n & \text{if } n+1 \in w, \\ s_n & \text{if } n+1 \notin w, \end{cases} \qquad \mathsf{op}_w(t_n) = \begin{cases} s_n & \text{if } n+1 \in w, \\ t_n & \text{if } n+1 \notin w. \end{cases}$$

The functor op_{\emptyset} is clearly the identity functor. Moreover, for every pair of elements $w, w' \in G$, we can easily check that

$$\mathsf{op}_w \, \mathsf{op}_{w'} = \mathsf{op}_{ww'}$$

so the assignment $w \mapsto \mathsf{op}_w$ is a group homomorphism $G \to \mathsf{Aut}(\mathbb{G})$. Since the group G is Abelian, this action extends to an action on the category Glob of globular sets by precomposition

$$\begin{array}{l} {\rm op}\colon G\to {\rm Aut}({\rm Glob})\\ {\rm op}_w(X)=X\circ {\rm op}_w\,. \end{array}$$

The opposite $op_w X$ of a globular set X therefore has the same cells as X, with the source and target of n-cells reversed for $n \in w$.

Since pasting diagrams are bipointed by their 0-source and 0-target inclusions, it will be useful to further extend this action to an action on bipointed globular sets

op:
$$G \to Aut(Glob^{\star,\star})$$

by letting op_w take a bipointed globular set (X, x_-, x_+) to the opposite globular set $\mathsf{op}_w X$ with the same basepoints when $1 \notin w$, and with the basepoints swapped otherwise.

Lemma 4. For every $w \in G$, there exists a natural isomorphism

$$\mathsf{op}_w^{\Sigma} \colon \Sigma \circ \mathsf{op}_{w-1} \Rightarrow \mathsf{op}_w \circ \Sigma$$

where $w-1 \in G$ is the sequence defined by (w-1)(n) = w(n+1). Moreover, op_{\emptyset}^{Σ} is the identity natural transformation, and for every pair of elements $w, w' \in G$, the following diagram commutes:

$$\begin{split} \Sigma \operatorname{op}_{w-1} \operatorname{op}_{w'-1} & \xrightarrow{\operatorname{op}_{w}^{\Sigma} \operatorname{op}_{w'-1}} \operatorname{op}_{w} \Sigma \operatorname{op}_{w'-1} \xrightarrow{\operatorname{op}_{w} \operatorname{op}_{w'}^{\Sigma}} \operatorname{op}_{w} \operatorname{op}_{w'} \Sigma \\ & \parallel & \parallel \\ \Sigma \operatorname{op}_{ww'-1} & \xrightarrow{\operatorname{op}_{ww'}^{\Sigma}} \operatorname{op}_{ww'} \Sigma \end{split}$$

Proof. For every globular set X, the bipointed globular sets $\sum \operatorname{op}_{w-1} X$ and $\operatorname{op}_w \sum X$ have the same sets of cells. Moreover, the source and target of an n-cell in both of them agree when n > 2: they are given by the target and source functions of X respectively when $n \in w$, and they are given by the source and target functions of X when $n \notin w$. The source and target of a 1-cell in the first one are given by v^- and v^+ respectively, while in the latter it is given by those when $1 \notin w$, and by v^+ and v^- when $1 \in w$. Therefore, we may define an isomorphism of globular sets

$$\operatorname{op}_{w,X}^{\Sigma} \colon \Sigma \operatorname{op}_{w-1} X \to \operatorname{op}_w \Sigma X$$

to be the identity on positive-dimensional cells, and to be given on 0-cells by

$$\mathsf{op}_{w,X}^{\Sigma}(v_{\pm}) = \begin{cases} \mathsf{op}_{w,X}^{\Sigma}(v_{\mp}), & \text{if } 1 \in w, \\ \mathsf{op}_{w,X}^{\Sigma}(v_{\pm}), & \text{if } 1 \notin w. \end{cases}$$

Since op_w reverses the basepoints if and only if $1 \in w$, we see that this is a morphism of bipointed globular sets. Naturality of these morphisms follows easily by the fact that it is the identity of positive-dimensional cells. Finally, the claimed diagram commutes for $w, w' \in G$: both morphisms are identity on positive-dimensional cells, they are the identity on 0-cells when $1 \in w \cap w'$ or $1 \notin w \cup w'$, and they swap the two 0-cells otherwise.

Lemma 5. For every $w \in G$ and $n \in \mathbb{N}$, there exists a natural isomorphism

$$\mathsf{op}_w^\vee\colon \bigvee_{i=1}^n \circ \ \mathsf{swap}_{w(1)} \circ (\mathsf{op}_w)^n \Rightarrow \mathsf{op}_w \circ \bigvee_{i=1}^n$$

where $swap_0$ is the identity of $(Glob^{\star,\star})^n$, while $swap_1$ is the automorphism

$$swap_1(X_1, ..., X_n) = (X_n, ..., X_1).$$

Moreover, op_{\emptyset}^{\vee} is the identity natural transformation, and for every pair of elements $w, w' \in G$, the following diagram commutes:


$$\begin{array}{c|c} \bigvee \circ (\mathsf{op}_{ww'})^n \circ \mathsf{swap}_{ww'(1)} & \xrightarrow{\mathsf{op}_{ww'}^{\vee}} & \mathsf{op}_{ww'} \circ \bigvee \\ & & \\$$

Proof. Fix $n \in \mathbb{N}$ and $w \in G$ and let X_1, \ldots, X_n be bipointed globular sets and suppose first that $1 \notin w$, so that the basepoints of X_i and $\mathsf{op}_w X_i$ agree. The functor op_w on globular sets preserves \mathbb{D}^0 , and it preserves colimits, being an equivalence of categories. Therefore, there exists a natural isomorphism of globular sets


$$\mathsf{op}_w^{\vee} \colon \bigvee_{i=1}^n (\mathsf{op}_w X_i) \to \mathsf{op}_w \left(\bigvee_{i=1}^n X_i\right),$$

that can be easily seen to preserve the basepoints. Moreover, since op_w preserves the cells of a globular set, and colimits of globular sets are computed pointwise, we may take op_w^{\vee} to be the identity.

Suppose now that $1 \in w$, so that the functor op_w swaps the basepoints. Using that op_w preserves colimits and \mathbb{D}^0 , we see that $\mathsf{op}_w(\bigvee_{i=1}^n X_i)$ is the colimit of the following diagram.



On the other hand, $\bigvee_{i=n}^{1} \mathsf{op}_{w} X_{i}$ is the colimit of the following diagram:



By symmetry of pushouts, we get a natural isomorphism of globular sets

$$\mathsf{op}_w^{\vee} \colon \bigvee_{i=n}^1 (\mathsf{op}_w X_i) \to \mathsf{op}_w \left(\bigvee_{i=1}^n X_i \right)$$

that can be easily seen to preserve the basepoints. Since colimits are computed object-wise, this isomorphism is given level-wise by the symmetry of pushouts.

Knowing how those isomorphisms are defined pointwise, we can easily deduce that the claimed diagram commutes for every pair $w, w' \in G$. If $1 \notin w \cup w'$, then both sides of the diagram are identities. If $1 \in w \cap w'$ again both are identities, since the symmetry of the pushout squares to the identity. Finally, when $1 \in ww'$, then both sides are given by the symmetry of the pushout, so they agree.

Using those lemmas, we can deduce that pasting diagrams are closed under the formation of opposites: we define recursively on the Batanin tree B for every $w \in G$ the *w*-opposite Batanin tree $\mathsf{op}_w B$ by the formula

$$\mathsf{op}_w(\mathsf{br}[B_1,\ldots,B_n]) = \mathsf{br}(\mathsf{swap}_{w(1)}[\mathsf{op}_{w-1}B_1,\ldots,\mathsf{op}_{w-1}B_n]),$$

where swap_0 is the identity of the set of lists, while swap_1 reverses a list

$$swap_1[B_1, ..., B_n] = [B_n, ..., B_1]$$

The opposite tree realizes the opposite pasting diagram, in the sense that there exists an isomorphism of bipointed globular sets

$$\operatorname{op}_w^B \colon \operatorname{Pos}^{\star,\star}(\operatorname{op}_w B) \to \operatorname{op}_w(\operatorname{Pos}^{\star,\star}(B)).$$

We can define this isomorphism recursively on $B = br[B_1, \ldots, B_n]$ to be the following composite

$$\begin{split} \mathsf{Pos}^{\star,\star}(\mathsf{op}_w \, B) &= \bigvee_{i=1}^n \mathsf{swap}_{w(1)}(\Sigma \, \mathsf{Pos}(\mathsf{op}_{w-1} \, B_i)) \\ & \xrightarrow{\forall \, \mathsf{swap}_{w(1)} \, \Sigma \, \mathsf{op}_{w-1}^{B_i}} \, \bigvee_{i=1}^n \mathsf{swap}_{w(1)}(\Sigma \, \mathsf{op}_{w-1} \, \mathsf{Pos}(B_i)) \\ & \xrightarrow{\forall \, \mathsf{swap}_{w(1)} \, \mathsf{op}_w^{\Sigma}} \, \bigvee_{i=1}^n \mathsf{swap}_{w(1)}(\mathsf{op}_w \, \Sigma \, \mathsf{Pos}(B_i)) \\ & \xrightarrow{\mathsf{op}_w^{\vee}} \, \mathsf{op}_w \left(\bigvee_{i=1}^n \Sigma \, \mathsf{Pos}(B_i) \right) = \mathsf{op}_w(\mathsf{Pos}^{\star,\star}(B)). \end{split}$$

Lemma 6. The isomorphism op_{\emptyset}^{B} is the identity for every tree B, and for any $w, w' \in G$, the following diagram of isomorphisms commutes:

$$\begin{array}{c} \operatorname{\mathsf{Pos}}(\operatorname{\mathsf{op}}_w \operatorname{\mathsf{op}}_{w'}^{}B) \xrightarrow{\operatorname{\mathsf{op}}_{w''}^{}B} \operatorname{\mathsf{op}}_w(\operatorname{\mathsf{Pos}}(\operatorname{\mathsf{op}}_{w'}^{}B)) \xrightarrow{\operatorname{\mathsf{op}}_w(\operatorname{\mathsf{op}}_{w'}^{}B)} \operatorname{\mathsf{op}}_w \operatorname{\mathsf{op}}_w \operatorname{\mathsf{op}}_{w'}^{}\operatorname{\mathsf{Pos}}(B) \\ \\ & \\ & \\ \operatorname{\mathsf{Pos}}(\operatorname{\mathsf{op}}_{ww'}^{}B) \xrightarrow{} \operatorname{\mathsf{op}}_{ww'}^{}\operatorname{\mathsf{Pos}}(B) \end{array}$$

Proof. This lemma is an easy induction on B, using naturality of the isomorphisms in Lemmas 4 and 5, and of the commuting diagrams there.

Lemma 7. For every $w \in G$, $k \in \mathbb{N}$ and Batanin tree B,

$$\operatorname{op}_w \partial_k = \partial_k \operatorname{op}_w$$
.

Moreover, the following equations hold

-

$$\begin{array}{c|c} k+1 \in w & k+1 \notin w \\ \\ & \mathsf{op}_w(t^B_k) \circ \mathsf{op}^{\partial_k B}_w = \mathsf{op}^B_w \circ s^{\mathsf{op}_w B}_k & \mathsf{op}_w(s^B_k) \circ \mathsf{op}^{\partial_k B}_w = \mathsf{op}^B_w \circ s^{\mathsf{op}_w B}_k \\ \\ & \mathsf{op}_w(s^B_k) \circ \mathsf{op}^{\partial_k B}_w = \mathsf{op}^B_w \circ t^{\mathsf{op}_w B}_k & \mathsf{op}_w(t^B_k) \circ \mathsf{op}^{\partial_k B}_w = \mathsf{op}^B_w \circ t^{\mathsf{op}_w B}_k \end{array}$$

Proof. We proceed by induction on k. For k = 0 both $\mathsf{op}_w \partial_k B$ and $\partial_k \mathsf{op}_w B$ are equal to the disk D_0 , and the equations state that op_w^B preserves the basepoints. Suppose therefore that the result is true for some $k \in \mathbb{N}$ to prove that it also holds for k + 1. Letting $B = \mathsf{br}[B_1, \ldots, B_n]$, we see that

$$\begin{split} \mathsf{op}_w \, \partial_{k+1} B &= \mathsf{op}_w(\mathsf{br}[\partial_k B_1, \dots, \partial_k B_n]) \\ &= \mathsf{br}(\mathsf{swap}_{w(1)}[\mathsf{op}_{w-1} \, \partial_k B_1, \dots, \mathsf{op}_{w-1} \, \partial_k B_n]) \\ &= \mathsf{br}(\mathsf{swap}_{w(1)}[\partial_k \, \mathsf{op}_{w-1} \, B_1, \dots, \partial_k \, \mathsf{op}_{w-1} \, B_n]) \\ &= \partial_{k+1} \, \mathsf{br}(\mathsf{swap}_{w(1)}[\mathsf{op}_{w-1} \, B_1, \dots, \mathsf{op}_{w-1} \, B_n]) \\ &= \partial_{k+1} \, \mathsf{op}_w \, B \end{split}$$

by the inductive hypothesis.

We will prove the first equation in the case that $k + 1 \in w$ and $1 \in w$. The other equation and the rest of the cases follow by the same argument. By the inductive hypothesis, we may assume that for $1 \leq i \leq n$, the following square commutes

$$\begin{array}{c} \operatorname{Pos}(\operatorname{op}_{w-1}B_i) \xrightarrow{\operatorname{op}_{w-1}^{B_i}} \operatorname{op}_{w-1}(\operatorname{Pos}(B_i)) \\ \xrightarrow{s_{k-1}^{\operatorname{op}_{w-1}B_i}} \\ \operatorname{Pos}(\partial_{k-1}\operatorname{op}_{w-1}B_i) \\ \| \\ \operatorname{Pos}(\operatorname{op}_{w-1}\partial_{k-1}B_i) \xrightarrow{\partial_{k-1}B_i} \operatorname{op}_{w-1}\operatorname{Pos}(\partial_{k-1}B_i) \end{array}$$

Applying the suspension functor and then the wedge sum from n to 1, we get that the left square below commutes. Naturality of the isomorphisms in Lemmas 4 and 5 then imply that the right square below also commutes.

$$\begin{array}{c} \bigvee \Sigma \operatorname{Pos}(\operatorname{op}_{w-1} B_i) \longrightarrow \bigvee \Sigma \operatorname{op}_{w-1} \operatorname{Pos}(B_i) \longrightarrow \operatorname{op}_w \bigvee \Sigma \operatorname{Pos}(B_i) \\ & \uparrow & \uparrow & \uparrow \\ & \downarrow \Sigma \operatorname{Pos}(\partial_{k-1} \operatorname{op}_{w-1} B_i) & \downarrow \Sigma \operatorname{op}_{w-1}(t_{k-1}^{B_i}) & \operatorname{op}_w \vee \Sigma t_{k-1}^{B_i} \\ & \parallel & \mid \\ & \downarrow \\ & \bigvee \Sigma \operatorname{Pos}(\operatorname{op}_{w-1} \partial_{k-1} B_i) \rightarrow \bigvee \Sigma \operatorname{op}_{w-1} \operatorname{Pos}(\partial_{k-1} B_i) \rightarrow \operatorname{op}_w \bigvee \Sigma \operatorname{Pos}(\partial_{k-1} B_i) \end{array}$$

The outer part of the diagram though is precisely the square:

whose commutativity amounts to the first equation.

4.2 The opposite of a computad


The opposite of a computed is defined similarly to the opposite of a globular set by swapping the source and target of its generators. To define this action, we fix an element $w \in G$ and define recursively on the dimension $n \in \mathbb{N}$, an endofunctor and two natural transformation

$$\mathsf{op}_w \colon \mathsf{Comp}_n \to \mathsf{Comp}_n$$

 $\mathsf{op}_w^{\mathsf{Cell}} \colon \mathsf{Cell}_n \Rightarrow \mathsf{Cell}_n \mathsf{op}_w$
 $\mathsf{op}_w^{\mathsf{Sphere}} \colon \mathsf{Sphere}_n \Rightarrow \mathsf{Sphere}_n \mathsf{op}_w$

satisfying the following properties:

(OP1) forming opposites commutes with the forgetful functors, and the inclusion of globular sets into computads



(OP2) the natural transformations are compatible with the boundary natural transformation

$$\begin{array}{c} \operatorname{Cell}_{n+1} & \xrightarrow{\operatorname{op}^{\operatorname{Cell}}_w} & \operatorname{Cell}_{n+1} \operatorname{op}_w \\ & & \downarrow \\ \operatorname{bdry}_{n+1} \\ \downarrow & & \downarrow \\ \operatorname{Sphere}_n u_{n+1} \xrightarrow{\operatorname{Sphere}} u_{n+1} \\ \end{array} \\ \operatorname{Sphere}_n u_{n+1} \xrightarrow{\operatorname{Sphere}} u_{n+1} \\ \operatorname{Sphere}_n u_{n+1} \operatorname{op}_w \\ \end{array}$$

(OP3) the natural transformation op_w^{Sphere} swaps the two cells of a sphere when $n + 1 \in w$ and leaves them unchanged otherwise, in the sense that the following diagrams commute for i = 1, 2

$$\begin{array}{ccc} \mathsf{Sphere}_n & \stackrel{\mathsf{op}_w^{\mathsf{Sphere}}}{\longrightarrow} & \mathsf{Sphere}_n \, \mathsf{op}_w & & \mathsf{Sphere}_n \, \mathsf{op}_w^{\mathsf{Sphere}} & \mathsf{Sphere}_n \, \mathsf{op}_w \\ & & \mathsf{pr}_i & & & \mathsf{n+1} \notin w & & & & \\ & \mathsf{Cell}_n & \stackrel{\mathsf{op}_w^{\mathsf{Cell}}}{\longrightarrow} & \mathsf{Cell}_n \, \mathsf{op}_w & & & & & \\ & & & \mathsf{Cell}_n & \stackrel{\mathsf{op}_w^{\mathsf{Cell}}}{\longrightarrow} & \mathsf{Cell}_n \, \mathsf{op}_w \end{array}$$

(OP4) the natural transformation op_w^{Cell} preserves generators, in that for every globular set X and $x \in X_n$, we have that

$$\operatorname{op}_{w,\operatorname{Free}X}^{\operatorname{Cell}}(\operatorname{var} x) = \operatorname{var} x.$$

(OP5) the natural transformation op^{Sphere} preserves fullness, in that for every full *n*-sphere A of Free Pos(B), the *n*-sphere

$$A' = \operatorname{Sphere}_n \operatorname{Free}_n(\operatorname{op}_w^B)^{-1}(\operatorname{op}_w^{\operatorname{Sphere}}(A))$$

of Free $Pos(op_w B)$ is also full.

As a base case, we define op_w and $\mathsf{op}_w^{\mathsf{Sphere}}$ to be the identities of Comp_{-1} and Sphere_{-1} respectively. Let therefore $n \in \mathbb{N}$ and suppose inductively that data as above has been defined for all natural numbers less than n, satisfying the given properties.

Computads. First we will define the action of op_w on all *n*-computads. Let $C = (C_{n-1}, V_n^C, \phi_n^C)$ be an *n*-computad. The opposite computad $\mathsf{op}_w C$ consists of the opposite computad $\mathsf{op}_w C_{n-1}$, the same set of generators V_n^C , and the attaching function

$$\phi_n^{\mathsf{op}_w\,C}\colon V_n^C\xrightarrow{\phi_n^C}\mathsf{Sphere}_{n-1}\,C_{n-1}\xrightarrow{\mathsf{op}_w^{\mathsf{Sphere}}}\mathsf{Sphere}_{n-1}(\mathsf{op}_w\,C_{n-1}).$$

By Properties (OP3) and (OP4), we can easily deduce that op_w commutes with the inclusion $Free_n$ on objects, while it clearly commutes with the forgetful functors u_n by definition.

Cells and morphisms. We will then define op_w on morphisms σ of *n*-computads of target C, together with the component of the natural transformation $\mathsf{op}_w^{\mathsf{Cell}}$ at C mutually recursively. For a generator $v \in V_n^C$, we let

$$\mathsf{op}_w^{\mathsf{Cell}}(\mathsf{var}\,v) = \mathsf{var}\,v,$$

and we observe that

$$\mathsf{bdry}_n \operatorname{op}^{\mathsf{Cell}}_w(\mathsf{var}\, v) = \operatorname{op}^{\mathsf{Sphere}}_w \operatorname{bdry}_n(\mathsf{var}\, v)$$

Given a coherence cell $c = \operatorname{coh}(B, A, \tau)$ of C, we may assume that recursively that $\operatorname{op}_w(\tau)$ has been defined, and let

$$\begin{aligned} A' &= \mathsf{Sphere}_{n-1} \operatorname{Free}_{n-1}(\mathsf{op}_w^B)^{-1}(\mathsf{op}_w^{\mathsf{Sphere}}(A)) \\ \mathsf{op}_w^{\mathsf{Cell}}(c) &= \operatorname{coh}(\mathsf{op}_w \, B, A', \mathsf{op}_w(\tau) \circ \operatorname{Free}_n(\mathsf{op}_w^B)) \end{aligned}$$

We then observe again that the boundary of this cell is given by

$$\begin{split} \mathsf{bdry}_n \operatorname{op}^{\mathsf{Cell}}_w(c) &= \mathsf{Sphere}_{n-1}(\operatorname{op}_w \tau_{n-1})(\operatorname{op}^{\mathsf{Sphere}}_w A) \\ &= \operatorname{op}^{\mathsf{Sphere}}_w(\mathsf{Sphere}_{n-1}(\tau_{n-1})(A)) \\ &= \operatorname{op}^{\mathsf{Sphere}}_w \operatorname{bdry}_n(c). \end{split}$$

Finally, for a morphism $\sigma = (\sigma_{n-1}, \sigma_V) : D \to C$, we define assume that $\mathsf{op}_w^{\mathsf{Cell}}$ has been defined on cells of the form $\sigma_V(v)$ for $v \in V_n^D$ and define

$$\mathsf{op}_w(\sigma) = (\mathsf{op}_w \, \sigma_{n-1}, \mathsf{op}_w^{\mathsf{Cell}} \circ \, \sigma_V) : \mathsf{op}_w \, D \to \mathsf{op}_w \, C$$

This is a well-defined morphism of computeds by the observation on the boundary of the cells $op_w^{Cell}(c)$, i.e. by Properties (OP2).

It follows immediately from the definition that op_w commutes with the forgetful functor u_n on morphisms as well. Using that op_w^{Cell} preserves generators, we can also deduce that op_w commutes with the inclusion Free_n on morphisms as well. Therefore, we have shown Properties (OP1), (OP2) and (OP4) so far.

Naturality. We will now show that op_w is a functor and that $\mathsf{op}_w^{\mathsf{Cell}}$ is natural. For that, we fix a morphism of *n*-computads $\sigma: C \to D$, and we proceed recursively to show that the following square commutes

$$\begin{array}{c|c} \operatorname{Cell}_n C & \xrightarrow{\operatorname{Cell}_n \sigma} & \operatorname{Cell}_n D \\ & & & \downarrow & \downarrow & \downarrow \\ \operatorname{cell}_n \operatorname{op}_w C & \xrightarrow{} & \operatorname{Cell}_n \operatorname{op}_w D \end{array}$$

and that for all morphism $\tau \colon E \to C$,

$$\mathsf{op}_w \, \sigma \circ \mathsf{op}_w \, \tau = \mathsf{op}_w (\sigma \circ \tau).$$

By definition of $\operatorname{op}_w \sigma$, the square above commutes when restricted to generators. Moreover, for a coherence cell $c = \operatorname{coh}(B, A, \tau)$, we see that

$$\begin{split} \mathsf{op}_w^{\mathsf{Cell}} \circ \mathsf{Cell}_n(\sigma)(c) &= \mathsf{op}_w^{\mathsf{Cell}}(\mathsf{coh}(B, A, \sigma \circ \tau)) \\ &= \mathsf{coh}(B, A', \mathsf{op}_w(\sigma \circ \tau) \circ \mathsf{Free}(\mathsf{op}_w^B)) \\ &= \mathsf{coh}(B, A', \mathsf{op}_w(\sigma) \circ \mathsf{op}_w(\tau) \circ \mathsf{Free}(\mathsf{op}_w^B)) \\ &= \mathsf{Cell}_n(\mathsf{op}_w \, \sigma)(\mathsf{coh}(B, A', \mathsf{op}_w(\tau) \circ \mathsf{Free}(\mathsf{op}_w^B))) \\ &= \mathsf{Cell}_n(\mathsf{op}_w \, \sigma) \circ \mathsf{op}_w^{\mathsf{Cell}}(\mathsf{coh}(B, A, \tau)) \end{split}$$

where A' is defined as above. Given arbitrary $\tau: E \to C$, we may assume that the square commutes when restricted to the image of τ_V . By the inductive hypothesis, op_w preserves composition of morphisms of (n-1)-computads. Hence it suffices to show the equality above for the generators of E. We recall the definition of the composition of morphisms of *n*-computads given in [12, Section 3.1]:

$$(\sigma_{n-1}, \sigma_v) \circ (\tau_{n-1}, \tau_V) = (\sigma_{n-1} \circ \tau_{n-1}, \mathsf{Cell}_n(\sigma) \circ \tau_v)$$

Using this definition, we have:

$$\begin{aligned} (\mathsf{op}_w(\sigma \circ \tau))_V &= \mathsf{op}_w^{\mathsf{Cell}} \circ \mathsf{Cell}_n(\sigma) \circ \tau_V \\ &= \mathsf{Cell}_n(\mathsf{op}_w \, \sigma) \circ \mathsf{op}_n^{\mathsf{Cell}} \circ \tau_V \\ &= (\mathsf{op}_w(\sigma) \circ \mathsf{op}_w(\tau))_V. \end{aligned}$$

Therefore, op_w is a functor and $\mathsf{op}_w^{\mathsf{Cell}}$ is natural.

Spheres. The natural transformation $\mathsf{op}_w^{\mathsf{Sphere}}$ is completely determined by Property (OP3). Indeed, for an *n*-computed *C* and for a sphere $(a, b) \in \mathsf{Sphere}_n C$, we are forced to define

$$\mathsf{op}_w^{\mathsf{Sphere}}(a,b) = \begin{cases} (\mathsf{op}_w^{\mathsf{Cell}} \, b, \mathsf{op}_w^{\mathsf{Cell}} \, a), & \text{if } n+1 \in w \\ (\mathsf{op}_w^{\mathsf{Cell}} \, a, \mathsf{op}_w^{\mathsf{Cell}} \, b), & \text{if } n+1 \notin w \end{cases}$$

Property (OP2) shows us that those $\mathsf{op}_w^{\mathsf{Cell}} a$ and $\mathsf{op}_w^{\mathsf{Cell}} b$ have the same source and target, so that this assignment is well-defined. It is clearly natural by naturality of $\mathsf{op}_w^{\mathsf{Cell}}$.

Fullness. To finish the recursive definition, it remains to show that for every Batanin tree B and every n-sphere A = (a, b) of Free_n Pos(B), the n-sphere

$$A' = \mathsf{Sphere}_n \operatorname{Free}_n(\mathsf{op}_w^B)^{-1}(\mathsf{op}_w^{\mathsf{Sphere}}(A))$$

of $\operatorname{Free}_n \operatorname{Pos}(\operatorname{op}_w B)$ is also full. We will show that in the case that $n + 1 \in w$, the other case being similar. By assumption, we may write

$$a = \operatorname{Cell}_n \operatorname{Free}_n(s_n^B)(a_0)$$
 $b = \operatorname{Cell}_n \operatorname{Free}_n(t_n^B)(b_0).$

For *n*-cells a_0, b_0 of Free_n Pos $(\partial_n B)$ whose support contains all positions of $\partial_n B$. Then we have that A' = (a', b') where

$$\begin{aligned} a' &= \mathsf{Cell}_n \operatorname{Free}_n((\mathsf{op}^B_w)^{-1} \circ t^B_n)(\mathsf{op}^{\mathsf{Cell}}_w b_0) \\ b' &= \mathsf{Cell}_n \operatorname{Free}_n((\mathsf{op}^B_w)^{-1} \circ t^B_n)(\mathsf{op}^{\mathsf{Cell}}_w a_0) \end{aligned}$$

By Lemma 7, we can rewrite those cells as

$$\begin{aligned} a' &= \mathsf{Cell}_n \operatorname{Free}_n(s_n^{\operatorname{op}_w B})(\mathsf{Cell}_n \operatorname{Free}_n(\operatorname{op}_w^{\partial_n B})^{-1}(\operatorname{op}_w^{\mathsf{Cell}} b_0)) \\ b' &= \mathsf{Cell}_n \operatorname{Free}_n(t_n^{\operatorname{op}_w B})(\mathsf{Cell}_n \operatorname{Free}_n(\operatorname{op}_w^{\partial_n B})^{-1}(\operatorname{op}_w^{\mathsf{Cell}} a_0)). \end{aligned}$$

Using the definition of the support and that $\mathsf{op}^{\mathsf{Cell}}_w$ preserves generators, we may show recursively that

$$supp(op_w^{Cell}(c)) = supp(c)$$

for every cell c. Moreover, isomorphisms of computads induce bijections on the support of cells, so the support of the cells


$$\begin{aligned} \mathsf{Cell}_n \, \mathsf{Free}_n(\mathsf{op}_w^{\partial_n B})^{-1}(\mathsf{op}_w^{\mathsf{Cell}} \, b_0) \\ \mathsf{Cell}_n \, \mathsf{Free}_n(\mathsf{op}_w^{\partial_n B})^{-1}(\mathsf{op}_w^{\mathsf{Cell}} \, a_0) \end{aligned}$$

must contain all positions of $\partial_n \operatorname{op}_w B$. Therefore, A' is full.

Lemma 8. For every $n \in \mathbb{N}$, the endofunctor op_{\emptyset} on *n*-computads is the identity, and so are the natural transformations $\mathsf{op}_{\emptyset}^{\mathsf{Cell}}$ and $\mathsf{op}_{\emptyset}^{\mathsf{Sphere}}$. Moreover, for any pair of elements $w, w' \in G$,

$$\mathsf{op}_w\,\mathsf{op}'_w=\mathsf{op}_{ww'}$$

and the following diagrams commute.



In particular, op_w , op_w^{Cell} and op_w^{Sphere} are invertible with inverses op_w , $op_w^{Cell} op_w$ and $op_w^{Sphere} op_w$ respectively.

Proof. We proceed inductively on $n \in \mathbb{N}$, since the result holds trivially for n = -1. Since op_{\emptyset} and op_{\emptyset}^{Sphere} are identities for (n-1)-computads, we see that

$$\operatorname{op}_{\emptyset} C = C$$

for every n-comptuted C. Using Lemma 7, we can then show mutually recursively for an n-computed C that

$$\operatorname{op}_{\emptyset} \sigma = \sigma \qquad \qquad \operatorname{op}_{\emptyset}^{\mathsf{Cell}} c = c$$

for every morphism $\sigma: D \to C$ and every *n*-cell *c* of *C*. Using then that $\mathsf{op}_{\mathbb{A}}^{\mathsf{Sphere}}$

is defined using $\mathsf{op}_{\emptyset}^{\mathsf{Cell}}$, we see that $\mathsf{op}_{\emptyset}^{\mathsf{Sphere}}$ must be the identity as well. Let now $w, w' \in G$ and $C = (C_{n-1}, V_n^C, \phi_n^C)$ an *n*-computed. Then $\mathsf{op}_w \mathsf{op}'_w C$ consists of the (n-1)-computed

$$\mathsf{op}_w \, \mathsf{op}'_w \, C_{n-1} = \mathsf{op}_{ww'} \, C_{n-1},$$

the same set of generators, and the attaching function

$$\phi_n^{\mathsf{op}_w \operatorname{op}'_w C} = \mathsf{op}_{w,\mathsf{op}_{w'} C}^{\mathsf{Sphere}} \circ \mathsf{op}_{w',C}^{\mathsf{Sphere}} \circ \phi_n^C = \mathsf{op}_{ww',C}^{\mathsf{Sphere}} \circ \phi_n^C = \phi_n^{\mathsf{op}_{ww'} C}.$$

Hence, $\mathsf{op}_w \mathsf{op}_{w'}$ and $\mathsf{op}_{ww'}$ agree on *n*-computads. Fixing a computed *C*, we can show that they also agree on morphisms with target C mutually inductively to recursively to showing that the claimed diagram for $\mathsf{op}_w^{\mathsf{Cell}}$ commutes. The commutative diagram from $\mathsf{op}_w^{\mathsf{Sphere}}$ then follows from the one for $\mathsf{op}_w^{\mathsf{Cell}}$.

Having defined the opposite of an *n*-computed for every $n \in \mathbb{N}$, in a way that is compatible with the forgetful functors u_n , we get a functor

$$\mathsf{op}_w\colon \mathsf{Comp} o \mathsf{Comp}$$

sending a computed $C = (C_n)_{n \in \mathbb{N}}$ to the computed

$$\operatorname{\mathsf{op}}_w C = (\operatorname{\mathsf{op}}_w C_n)_{n \in \mathbb{N}}$$

and acts similarly on morphisms. Property (OP1) shows that op_w is compatible with the inclusion functors Free in that

$$\begin{array}{c} \mathsf{Comp} \xrightarrow{\mathsf{op}_w} \mathsf{Comp} \\ \\ \mathsf{Free} & & & \\ \mathsf{Glob} \xrightarrow{\mathsf{op}_w} \mathsf{Glob} \end{array}$$

commutes. Moreover, combining Properties (OP2) and (OP3), we see that the natural transformations op_w^{Cell} give rise to a natural transformation

$$\mathsf{op}^{\mathsf{Cell}}_w \colon \mathsf{op}_w \operatorname{Cell} \Rightarrow \mathsf{Cell} \operatorname{op}_w$$

The following lemma is an easy consequence of Lemma 8.

Lemma 9. The functor op_{\emptyset} : Comp \rightarrow Comp is the identity functor, and the natural transformations op_{\emptyset}^{Cell} is the identity of Cell. Moreover, for any pair $w, w' \in G$,

$$\mathsf{op}_w \, \mathsf{op}'_w = \mathsf{op}_{ww'}$$

and the following diagrams commute.

$$\begin{array}{c} \mathsf{op}_w \, \mathsf{op}_{w'} \, \mathsf{Cell} \stackrel{\mathsf{op}_w \, \mathsf{op}_{w'}^{\mathsf{cell}} \, \mathsf{op}_w \, \mathsf{Cell} \, \mathsf{op}_{w'} \stackrel{\mathsf{op}_{w'}^{\mathsf{cell}} \, \mathsf{op}_{w'}}{\longrightarrow} \mathsf{Cell} \, \mathsf{op}_w \, \mathsf{op}_{w'} \\ \\ \\ \mathsf{op}_{ww'} \, \mathsf{Cell} \stackrel{\mathsf{op}_{ww'}^{\mathsf{cell}}}{\longrightarrow} \, \mathsf{Cell} \, \mathsf{op}_{ww'}. \end{array}$$

In particular, each op_w is invertible with inverse itself, and op_w^{Cell} is invertible with inverse $op_w op_w^{Cell} op_w$.

4.3 The opposite of an ω -category.

So far, we have defined the opposite of a globular set, a pasting diagram and a computad. To extend those definitions and define the opposite of an ω -category, we observe first that the functor $\mathsf{op}_w : \mathsf{Glob} \to \mathsf{Glob}$ together with the natural transformation

$$\begin{array}{l} \operatorname{op}_w^T : T \operatorname{op}_w \Rightarrow \operatorname{op}_w^T \\ \\ \operatorname{op}_w^T = (\operatorname{op}_w^{\mathsf{Cell}} \mathsf{Free})^{-1} \end{array}$$

is a morphism of monads from T to T^{-1} . This amounts to commutativity of the following two diagrams

$$T \operatorname{op}_{w} \xrightarrow{\operatorname{op}_{w}^{T}} \operatorname{op}_{w} T \xrightarrow{T \operatorname{op}_{w}^{T}} T \operatorname{op}_{w} T \xrightarrow{\operatorname{op}_{w}^{T}} T \operatorname{op}_{w} T \xrightarrow{\operatorname{op}_{w}^{T}} \operatorname{op}_{w} \operatorname{op}_{w} \operatorname{op}_{w} T \xrightarrow{\operatorname{op}_{w}^{T}} \operatorname{op}_{w} \operatorname{op}_{w} T \xrightarrow{\operatorname{op}_{w}^{T}} \operatorname{op}_{w} \operatorname{op}_{w} T \xrightarrow{\operatorname{op}_{w}^{T}} \operatorname{op}_{w} \operatorname{op}_{w} T \xrightarrow{\operatorname{op}_{w}^{T}} \operatorname{op}_{w} \operatorname{op}_{w} \operatorname{op}_{w} T \operatorname{op}_{w} \operatorname{op}_{w$$

 $^{{}^1\}mathsf{op}^T_w$ can also be obtained as the mate of $\mathsf{op}^{\mathsf{Cell}}_w\mathsf{Free}$ under the $\mathsf{op}_w\dashv\mathsf{op}_w$ adjunction.

The left one is the assertion that $\mathsf{op}_w^{\mathsf{Cell}}$ preserves generators, which we have already shown. The right one is obtained from the following diagram by whiskering on the right with Free, and then replacing $\mathsf{op}^{\mathsf{Cell}}$ Free with its inverse.

$$\begin{array}{c} \operatorname{op}_w^{\operatorname{cell} \operatorname{Free Cell}} & \operatorname{op}_w T\operatorname{Cell} \xrightarrow{\operatorname{p}_w^{\operatorname{Cell}}} \operatorname{Cell} \operatorname{op}_w \operatorname{Free Cell} \xrightarrow{\operatorname{T}} \operatorname{op}_w \operatorname{Cell} \xrightarrow{\operatorname{T}} T\operatorname{Cell} \operatorname{op}_w \\ & \bigoplus \\ \operatorname{op}_w \operatorname{Cell} \varepsilon \\ & \bigoplus \\ \operatorname{op}_w^{\operatorname{Cell}} \varepsilon \\ & \bigoplus \\ \operatorname{Cell} \varepsilon \operatorname{op}_w \end{array} \xrightarrow{\operatorname{Cell}} \operatorname{Cell} \operatorname{op}_w \\ \end{array}$$

To show that this diagram commutes, we fix a computed C and proceed inductively on the cells of Free Cell C. Given a generator $v \in V_n^{\text{Free Cell } C}$, we compute that

$$\begin{split} ((\operatorname{\mathsf{Cell}} \varepsilon_{\operatorname{\mathsf{op}}_w C}) \circ (T \operatorname{\mathsf{op}}_{w,C}^{\operatorname{\mathsf{Cell}}}) \circ (\operatorname{\mathsf{op}}_{w,\operatorname{\mathsf{Free}}}^{\operatorname{\mathsf{Cell}}} C))(\operatorname{var} c) \\ &= ((\operatorname{\mathsf{Cell}} \varepsilon_{\operatorname{\mathsf{op}}_w C}) \circ (T \operatorname{\mathsf{op}}_{w,C}^{\operatorname{\mathsf{Cell}}}))(\operatorname{var} c) \\ &= (\operatorname{\mathsf{Cell}} \varepsilon_{\operatorname{\mathsf{op}}_w C})(\operatorname{var} \operatorname{\mathsf{op}}_{w,C}^{\operatorname{\mathsf{cell}}} c) \\ &= \operatorname{\mathsf{op}}_{w,C}^{\operatorname{\mathsf{Cell}}}(c) \\ &= \operatorname{\mathsf{op}}_{w,C}^{\operatorname{\mathsf{cell}}}((\operatorname{\mathsf{op}}_w \operatorname{\mathsf{Cell}} \varepsilon_C)(c)) \end{split}$$

so the diagram commutes when restricted to generators. Let now $c = \operatorname{coh}(B, A, \tau)$ a coherence cell of Free Cell C. Then letting

$$A' = \mathsf{Sphere}_{n-1} \operatorname{Free}_{n-1}(\mathsf{op}^B_w)^{-1}(\mathsf{op}^{\mathsf{Sphere}}_w(A)),$$

we compute that

$$\begin{split} ((\mathsf{Cell}\,\varepsilon_{\mathsf{op}_w\,C})\circ(T\,\mathsf{op}_{w,C}^{\mathsf{Cell}})\circ(\mathsf{op}_{w,\mathsf{Free}\,\mathsf{Cell}\,C}^{\mathsf{Cell}}))(\mathsf{coh}(B,A,\tau)) \\ &= \mathsf{coh}(\mathsf{op}_w\,B,A',\varepsilon_{\mathsf{op}_w\,C}\circ\mathsf{Free}_n(\mathsf{op}_{w,C}^{\mathsf{Cell}})\circ\mathsf{op}_w\,\tau\circ\mathsf{Free}_n(\mathsf{op}_w^B)) \\ \mathsf{op}_{w,C}^{\mathsf{Cell}}((\mathsf{op}_w\,\mathsf{Cell}\,\varepsilon_C)(c)) \\ &= \mathsf{coh}(\mathsf{op}_w\,B,A',\mathsf{op}_w(\varepsilon_C\circ\tau)\circ\mathsf{Free}_n(\mathsf{op}_w^B)), \end{split}$$

so it suffices to show that the following equality of morphisms:

$$\mathsf{op}_w(\varepsilon_C\circ\tau) = \varepsilon_{\mathsf{op}_w\,C}\circ\mathsf{Free}_n(\mathsf{op}^{\mathsf{Cell}}_{w,C})\circ\mathsf{op}_w\,\tau$$

By induction on the dimension and the structure of cells, we may assume that the diagram commutes when restricted to cells of the form $\tau_{k,V}(v)$ for $k \leq n$ and $v \in \mathsf{Pos}_k(B)$. Then for every such v,

$$\begin{split} (\mathsf{op}_w(\varepsilon_C \circ \tau))_{k,V}(v) &= \mathsf{op}_{w,C}^{\mathsf{Cell}}((\varepsilon_C \circ \tau)_{k,V}(v)) \\ &= (\mathsf{op}_{w,C}^{\mathsf{Cell}} \circ \mathsf{Cell}(\varepsilon_C))(\tau_{k,V}(v)) \\ &= (\mathsf{op}_{w,C}^{\mathsf{Cell}} \circ (\mathsf{op}_w \operatorname{Cell}(\varepsilon_C)))(\tau_{k,V}(v)) \\ &= ((\mathsf{Cell} \, \varepsilon_{\mathsf{op}_w \, C}) \circ (T \, \mathsf{op}_{w,C}^{\mathsf{Cell}}) \circ \mathsf{op}_{w,\mathsf{Free} \, \mathsf{Cell} \, C})(\tau_{k,V}(v)) \\ &= \mathsf{Cell}(\varepsilon_{\mathsf{op}_w \, C} \circ \mathsf{Free} \, \mathsf{op}_{w,C}^{\mathsf{Cell}})((\mathsf{op}_w \, \tau)_{k,V}(v)) \\ &= (\varepsilon_{\mathsf{op}_w \, C} \circ \mathsf{Free} \, \mathsf{op}_{w,C}^{\mathsf{Cell}} \circ \mathsf{op}_w \, \tau)_{k,V}(v), \end{split}$$

so the morphisms agree on every generator of Free Pos(B). Thus, they must be equal, and the square commutes for coherence cells as well.

Definition 10. The opposite of an ω -category $(X, \alpha : TX \to X)$ with respect to some $w \in G$ is the ω -category consisting of the globular set $\mathsf{op}_w X$ and the structure morphism

$$T \operatorname{op}_w X \xrightarrow{\operatorname{op}_{w,X}^T} \operatorname{op}_w TX \xrightarrow{\operatorname{op}_w \alpha} \operatorname{op}_w X$$

The construction of the opposite of an $\omega\text{-}\mathrm{category}$ is well-defined and gives rise to endofunctors

$$\mathsf{op}_w:\omega\operatorname{Cat}\to\omega\operatorname{Cat}$$

for every $w \in G$ as shown by Street [23], and explained by Leinster [19, Theorem 6.1.1]. Moreover, the following lemma - an immediate consequence of Lemma 9 - shows that those endofunctors are invertible and give rise to an action

$$\mathsf{op}: G \to \mathsf{Aut}(\omega \operatorname{\mathsf{Cat}})$$

of G on the category of ω -categories.

Lemma 11. The natural transformation op_{\emptyset}^T is the identity, and for any $w, w' \in G$ the following diagram commutes:

$$\begin{array}{cccc} T \operatorname{op}_{w} \operatorname{op}_{w'} & \xrightarrow{\operatorname{op}_{w}^{T} \operatorname{op}_{w'}} & \operatorname{op}_{w} T \operatorname{op}_{w'} & \xrightarrow{\operatorname{op}_{w} \operatorname{op}_{w'}^{T}} & \operatorname{op}_{w} \operatorname{op}_{w'} T \\ & & & & \\ & & & & \\ & & & & \\ & & & & \\ & & & & \\ & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & & & \\ & & & & &$$

Since ω -categories are algebras for the monad (T, μ, η) on Glob induced by the adjunction Free \dashv Cell, there exists a free/underlying adjunction

$$F^T: \mathsf{Glob} \rightleftarrows \omega \mathsf{Cat}: U^T$$

between globular sets and ω -categories, and there exists a comparison functor

$$K^T: \mathsf{Comp} o \omega \mathsf{Cat}$$

sending a computed C to the ω -category (Cell C, Cell ε_C). Moreover, K^T is a morphism of adjunctions meaning that

$$F^T = K^T$$
 Free $Cell = U^T K^T$

The commutative diagram showing that op_w^T is a morphism of monads implies in particular that the components of the natural transformation $\mathsf{op}_w^{\mathsf{Cell}}$ are morphisms of free ω -categories, so it can also be seen as a natural isomorphism

$$\operatorname{op}_w^K:\operatorname{op}_wK^T\Rightarrow K^T\operatorname{op}_w$$

The opposite functors on globular sets, computeds and ω -categories are therefore related by the following five squares

where

$$\mathsf{op}_w^F = \mathsf{op}_w^K \mathsf{Free}$$
 $\mathsf{op}_w^{\mathsf{Cell}} = U^T \mathsf{op}_w^K$.

In particular, the opposite of an ω -category that is free on a globular set or computed is again free on the opposite of the underlying globular set or the opposite computed, up to natural isomorphism.

5 The suspension and hom functors

Strict ω -categories are precisely categories enriched over strict ω -categories, so for every strict ω -category X and every pair of 0-cells $x_-, x_+ \in X_0$, the globular set $\Omega(X, x, x_+)$ of cells from x_- to x_+ admits an ω -category structure in a functorial way [10]. The same result was recently proven for arbitrary ω -categories [11] using the operadic definition of Leinster. To illustrate the power of the inductive techniques used in the previous section, we will provide an alternative, elementary proof of this result, and show that the formation of opposites and hom ω -categories commute in a suitable sense.

Recall that the *path space* or *hom* functor Ω : $\mathsf{Glob}^{\star,\star} \to \mathsf{Glob}$, taking a bipointed globular set to the globular set of cells from the first base-point to the second one admits a left adjoint, the *suspension* functor, $\Sigma : \mathsf{Glob} \to \mathsf{Glob}^{\star,\star}$ with unit the identity and counit $\kappa : \Sigma \Omega \Rightarrow$ id given by subset inclusions. Our goal in this section will be to extend the suspension functor to computads, and the path space functor on ω -categories.

To do so, we let first $\mathsf{Comp}^{\star,\star}$ the category of computads with two chosen 0-cells and morphisms preserving those 0-cells. By the Free \dashv Cell adjunction and the Yoneda lemma, this is precisely the slice of Comp under $\mathsf{Free}(\mathbb{D}^0 + \mathbb{D}^0)$. The adjunction descends to the slices to give an adjunction

$$\mathsf{Free}^{\star,\star}:\mathsf{Glob}^{\star,\star}\rightleftarrows\mathsf{Comp}^{\star,\star}:\mathsf{Cell}^{\star,\star}$$

where $\operatorname{Free}^{\star,\star}(X, x_{-}, x_{+})$ is the computed $\operatorname{Free} X$ with the 0-cells $\operatorname{var} x_{-}$ and $\operatorname{var} x_{+}$, and $\operatorname{Cell}^{\star,\star}(C, c_{-}, c_{+})$ is the globular set $\operatorname{Cell} C$ with the basepoints c_{-} and c_{+} respectively. The unit and counit of this adjunction are given by those of the

original adjunction seen as pointed map. The monad $T^{\star,\star}$: $\mathsf{Glob}^{\star,\star} \to \mathsf{Glob}^{\star,\star}$ induced by this adjunction sends a bipointed globular set (X, x_-, x_+) to the globular set TX with basepoints var x_- and var x_+ . Its category of algebras can be seen to be the category $\omega \operatorname{Cat}^{\star,\star}$ of ω -categories with two chosen basepoints. Therefore, to define a hom ω -category functor

$$\Omega: \omega \operatorname{Cat}^{\star,\star} \to \omega \operatorname{Cat}$$

extending the hom functor $\Omega:\mathsf{Glob}^{\star,\star}\to\mathsf{Glob},$ in that the following square commutes

$$\begin{array}{c} \omega \operatorname{Cat}^{\star,\star} & \xrightarrow{\Omega} & \omega \operatorname{Cat} \\ U^{T^{\star,\star}} & & & \downarrow U^{T} \\ \operatorname{Glob}^{\star,\star} & \xrightarrow{\Omega} & \operatorname{Glob}, \end{array}$$

it suffices to define a natural transformation

$$\Omega^T:T\,\Omega\Rightarrow\Omega\,T^{\star,\star}$$

such that the pair (Ω, Ω^T) is a morphism of monads from T to $T^{\star,\star}$. To define such a natural transformation, it suffices to define its mate [17, Proposition 2.1]

$$\Sigma^T:\Sigma T\Rightarrow T^{\star,\star}\Sigma$$

which we will define inductively together with an extension of the suspension functor to computads.

5.1 The suspension of a computad

We define first the suspension of a Batanin tree B to be the Batanin tree

$$\Sigma B = br[B]$$

since by definition

$$\mathsf{Pos}^{\star,\star}(\Sigma B) = \Sigma \mathsf{Pos}(B).$$

We will then proceed inductively on $n\in\mathbb{N}$ to define a functor and two natural transformations


$$\begin{array}{l} \Sigma: \mathsf{Comp}_n \to \mathsf{Comp}_{n+1} \\ \Sigma^{\mathsf{Cell}}: \mathsf{Cell}_n \Rightarrow \mathsf{Cell}_{n+1} \Sigma \\ \Sigma^{\mathsf{Sphere}}: \mathsf{Sphere}_n \Rightarrow \mathsf{Sphere}_{n+1} \Sigma \end{array}$$

satisfying the following properties:

(S1) the suspension commutes with the forgetful functors, and the inclusion of globular sets into computads:

$$\begin{array}{ccc} \mathsf{Comp}_{n+1} & \xrightarrow{\Sigma} & \mathsf{Comp}_{n+2} & & \mathsf{Comp}_n & \xrightarrow{\Sigma} & \mathsf{Comp}_{n+1} \\ & & \downarrow^{u_{n+1}} & \downarrow^{u_{n+2}} & & \mathsf{Free}_n \uparrow & & \uparrow \mathsf{Free}_{n+1} \\ & & \mathsf{Comp}_n & \xrightarrow{\Sigma} & \mathsf{Comp}_{n+1} & & & \mathsf{Glob} & \xrightarrow{\Sigma} & \mathsf{Glob} \end{array}$$

(S2) the natural transformations are compatible with the boundary natural transformations:



(s3) the natural transformations are compatible with the projection natural transformations for i = 1, 2:

$$\begin{array}{c} \mathsf{Sphere}_n \xrightarrow{\Sigma^{\mathsf{Sphere}}} \mathsf{Sphere}_n \\ & & & & \\ & & & & \\ & & & & \\ \mathsf{Cell}_n \xrightarrow{\Sigma^{\mathsf{Cell}}} \mathsf{Cell}_n \end{array}$$

(S4) the natural transformation Σ^{Cell} preserves generators, in the for every globular set X and $x \in X_n$, we have that

$$\Sigma^{\text{Cell}}(\operatorname{var} x) = \operatorname{var} x$$

(S5) the natural transformation Σ^{Sphere} preserves fullness, in that for every full *n*-sphere *A* of Free Pos(*B*), we have that $\Sigma^{\text{Sphere}} A$ is a full (n + 1)-sphere of Free Pos(ΣB).

To start the induction, we recall that Comp_{-1} is the terminal category and that Comp_0 is the category Set of sets. The suspension functor is defined as the functor picking the 2-element set $\{v_-, v_+\}$. We recall also that the unique (-1)-computed has a unique (-1)-sphere. We define Σ^{Sphere} to be the natural transformation picking the 0-sphere (v_-, v_+) . This concludes the base case. We will now assume that we have defined the the data satisfying the properties we have cited, up to dimension n-1, for a fixed $n \in \mathbb{N}$.

Computads. We will first define the functor Σ on all objects: Given an *n*-computed $C = (C_{n-1}, V_n^C, \phi_n^C)$, its suspension is the (n + 1)-computed consisting of ΣC_{n-1} , the same set of generators, and the attaching function $\phi_{n+1}^{\Sigma C}$ given by the composite

$$\phi_{n+1}^{\Sigma C}: V_n^C \xrightarrow{\phi_n^C} \mathsf{Sphere}_{n-1} C_{n-1} \xrightarrow{\Sigma^{\mathsf{Sphere}}} \mathsf{Sphere}_n \Sigma C_{n-1}$$

By definition, the suspension functor on objects commutes with the forgetful functors. Using that the suspension functor on (n-1)-computads commutes also with the inclusion of globular sets, and that Σ^{Cell} and hence Σ^{Sphere} preserve generators, we see that the suspension functor on *n*-computads also commutes with the inclusions.

Cells and morphisms. We then define the suspension of a morphism of *n*-computads together with the natural transformation Σ^{Cell} mutually inductively, while showing that Property (s2) holds. Given a morphism of *n*-computads σ of target $C = (C_{n-1}, V_n^C, \phi_n^C)$, we define Σ_C^{Cell} and $\Sigma(\sigma)$. For a generator $v \in V_n^C$, we let

$$\Sigma_C^{\text{Cell}}(\operatorname{var} v) = \operatorname{var} v,$$

and we compute that

$$(\mathsf{bdry}_{n+1,\Sigma\,C}\,\boldsymbol{\Sigma}_C^{\mathsf{Cell}})(\mathsf{var}\,v) = \phi_{n+1}^{\Sigma\,C}(v) = (\boldsymbol{\Sigma}_{C_{n-1}}^{\mathsf{Sphere}}\,\mathsf{bdry}_{n,C})(\mathsf{var}\,v).$$

For a coherence *n*-cell $c = \operatorname{coh}(B, A, \tau)$ of C, we let

$$\Sigma_C^{\mathsf{Cell}}(\mathsf{coh}(B, A, \tau)) = \mathsf{coh}(\Sigma B, \Sigma^{\mathsf{Sphere}} A, \Sigma \tau)$$

using that the suspension commutes with Free_n and $\operatorname{Pos}(-)$, and that it preserves fullness. Then by naturality of $\Sigma^{\operatorname{Sphere}}$, we compute that

$$(\mathsf{bdry}_{n+1, \mathsf{\Sigma}\,C}\,\mathsf{\Sigma}_C^{\mathsf{Cell}})(\mathsf{coh}(B, A, \tau)) = (\mathsf{\Sigma}_{C_{n-1}}^{\mathsf{Sphere}}\,\mathsf{bdry}_{n,C})(\mathsf{coh}(B, A, \tau)).$$

For a morphism $\sigma: D \to C$, we let $\Sigma \sigma: \Sigma D \to \Sigma C$ consist of $\Sigma \sigma_{n-1}$ and the function

$$(\Sigma \, \sigma)_V : V_{n+1}^{\Sigma \, D} = V_n^D \xrightarrow{\sigma_V} \mathsf{Cell}_n(C) \xrightarrow{\Sigma_C^{\mathsf{Cell}}} \mathsf{Cell}_{n+1} \, \Sigma \, C$$

This is a well-defined morphism by the observation on the boundary of Σ^{Cell} . Functoriality of the suspension, and naturality of Σ^{Cell} can be shown mutually inductively in the same way that they were shown for the opposite functors.

Spheres. Finally, the natural transformation Σ^{Sphere} is defined for a computed C and an *n*-sphere A = (a, b) of it again by

$$\Sigma^{\mathsf{Sphere}}(a,b) = (\Sigma^{\mathsf{Cell}} a, \Sigma^{\mathsf{Cell}} b).$$

We observe that those (n + 1)-cells are parallel again by Property (s2).

Fullness. To finish the induction, it remains to show that for every Batanin tree *B* and full *n*-sphere A = (a, b) of $\operatorname{Free}_n \operatorname{Pos}(B)$, the sphere $\Sigma^{\operatorname{Sphere}} A$ is full in $\operatorname{Free}_{n+1} \operatorname{Pos}(\Sigma B)$. To show that, we first let

$$a = \operatorname{Cell}_n \operatorname{Free}_n(s_n^B)(a_0)$$
 $b = \operatorname{Cell}_n \operatorname{Free}_n(t_n^B)(b_0),$

where the support of a_0 and b_0 contains all positions of $\partial_n B$. Then $\Sigma^{\text{Sphere}} A$ consists of the cells

$$\begin{split} a' &= \Sigma^{\mathsf{Cell}}(\mathsf{Cell}_n \operatorname{Free}_n(s_n^B)(a_0)) \\ &= \mathsf{Cell}_n \Sigma \operatorname{Free}_n(s_n^B)(\Sigma^{\mathsf{Cell}}(a_0)) \\ &= \mathsf{Cell}_n \operatorname{Free}_n(\Sigma s_n^B)(\Sigma^{\mathsf{Cell}}(a_0)) \\ &= \mathsf{Cell}_n \operatorname{Free}_n(s_{n+1}^{\Sigma B})(\Sigma^{\mathsf{Cell}}(a_0)) \\ b' &= \mathsf{Cell}_n \operatorname{Free}_n(t_{n+1}^{\Sigma B})(\Sigma^{\mathsf{Cell}}(b_0)), \end{split}$$

so it remains to show that when the support of a contains all positions of a tree B, then the support of $\Sigma^{\mathsf{Cell}} a$ contains all positions of ΣB . More generally, it suffices to prove that for every computed C and every cell $c \in \mathsf{Cell}_n C$,

$$\mathsf{supp}(\mathbf{\Sigma}^{\mathsf{Cell}}(c)) = \mathsf{supp}(c) \cup \{v_{-}, v_{+}\}$$

This statement can be easily shown by structural induction on cells.

- ...

Infinite-dimensional computads. This concludes the induction on $n \in \mathbb{N}$. Compatibility of the suspension functors with the forgetful functors allows us to define a functor

$$\Sigma: \mathsf{Comp} \to \mathsf{Comp}^{\star,\star}$$

sending a computed $C = (C_n)_{n \in \mathbb{N}}$ to the computed with components

$$(\Sigma C)_0 = \{v_-, v_+\}$$
 $(\Sigma C)_{n+1} = \Sigma C_n$

and with basepoints $\operatorname{var} v_{-}$ and $\operatorname{var} v_{+}$. By construction, this functor commutes with the suspension operation on globular sets, in that the following square commutes:

$$\begin{array}{ccc} \mathsf{Comp} & \xrightarrow{\Sigma} & \mathsf{Comp}^{\star,\star} \\ \mathsf{Free}^{\uparrow} & & \uparrow^{\mathsf{Free}^{\star,\star}} \\ \mathsf{Glob} & \xrightarrow{\Sigma} & \mathsf{Glob}^{\star,\star} \end{array}$$

Moreover, Property (s2) shows that the natural transformations Σ^{Cell} can be combined to a natural transformation

$$\Sigma^{\text{Cell}} : \Sigma \text{ Cell} \Rightarrow \text{Cell}^{\star,\star} \Sigma.$$

Whiskering this natural transformation on the right with Free and using commutativity of the square above, we get the desired natural transformation

$$\boldsymbol{\Sigma}^T:\boldsymbol{\Sigma}\,T\Rightarrow T^{\star,\star}\,\boldsymbol{\Sigma}\,.$$

5.2 Hom ω -categories

To get the path space functor, it remains to show that the mate

$$\Omega^T = (\Omega T^{\star,\star} \kappa) \circ (\Omega \Sigma^T \Omega) : T \Omega \Rightarrow \Omega T^{\star,\star}$$

is part of a morphism of monads, meaning that the following diagrams commute:

$$T \Omega \xrightarrow{\Omega^{T}} \Omega T^{\star,\star} \qquad TT \Omega \xrightarrow{T\Omega^{T}} T \Omega T^{\star,\star} \xrightarrow{\Omega^{T}} \Omega T^{\star,\star} \Omega T^{\star,\star} T^{\star,\star} \Omega T^{\star,\star} \Omega T^{\star,\star} \Omega^{\star,\star} \Omega^{\star,\star} T^{\star,\star} \Omega T^{\star,\star} \Omega^{\star,\star} \Lambda^{\star,\star} \Omega^{\star,$$

By the mate correspondence, commutativity of those diagrams is equivalent to the commutativity of the following ones:

The left one commutes, since Σ^{Cell} preserves generators. The right one is obtained from the following diagram by whiskering on the right with Free:

To show that this diagram commutes, we fix a computed C and proceed inductively. The diagram commutes when restricted to 0-cells of $\Sigma T \operatorname{Cell} C$, since those are precisely the basepoints of the suspension. Let therefore $n \in \mathbb{N}$ and $c \in (\Sigma T \operatorname{Cell} C)_{n+1} = (T \operatorname{Cell} C)_n$ a cell. If $c = \operatorname{var} c'$ is a generator cell, then

$$(\mathsf{Cell}^{\star,\star}(\varepsilon_{\Sigma\,C})\circ T^{\star,\star}(\Sigma_C^{\mathsf{Cell}})\circ \Sigma_{\mathsf{Free}\,\mathsf{Cell}\,C}^{\mathsf{Cell}})(c) = \Sigma_C^{\mathsf{Cell}}(c') = (\Sigma_C^{\mathsf{Cell}}\circ\Sigma\,\mathsf{Cell}(\varepsilon_C))(c),$$

so the diagram commutes when restricted to generators. If $c = \operatorname{coh}(B, A, \tau)$ is a coherence cell, we may assume inductively that the diagram commutes when restricted to cells of the form $\tau_{k,V}(v)$ for $k \leq n$ and $v \in \operatorname{Pos}_k(B)$. Then we compute that

$$\begin{split} (\mathsf{Cell}^{\star,\star}(\varepsilon_{\Sigma\,C}) \circ T^{\star,\star}(\Sigma_C^{\mathsf{Cell}}) \circ \Sigma_{\mathsf{Free\ Cell\ }C}^{\mathsf{Cell\ }})(c) \\ &= \mathsf{coh}(\Sigma\,B, \Sigma^{\mathsf{Sphere\ }}A, \varepsilon_{\Sigma\,C} \circ \mathsf{Free\ }\Sigma_C^{\mathsf{Cell\ }} \circ \Sigma\,\tau) \\ (\Sigma_C^{\mathsf{Cell\ }} \circ \Sigma\,\mathsf{Cell\ }(\varepsilon_C))(c) \\ &= \mathsf{coh}(\Sigma\,B, \Sigma^{\mathsf{Sphere\ }}A, \Sigma(\varepsilon_C \circ \tau)), \end{split}$$

so it remains to show that the following equality of morphisms holds.

$$\varepsilon_{\Sigma C} \circ \mathsf{Free} \, \Sigma_C^{\mathsf{Cell}} \circ \Sigma \, \tau = \Sigma(\varepsilon_C \circ \tau).$$

For that, we fix a position $v \in \mathsf{Pos}_k(B)$ and compute by the inductive hypothesis that

$$\begin{split} (\Sigma(\varepsilon_C \circ \tau))_V(v) &= \Sigma_C^{\mathsf{Cell}}((\varepsilon_C \circ \tau)_V(v)) \\ &= \Sigma^{\mathsf{Cell}}(\mathsf{Cell}(\varepsilon_C)(\tau_V(v))) \\ &= \mathsf{Cell}(\varepsilon_{\Sigma C} \circ \mathsf{Free} \, \Sigma_C^{\mathsf{Cell}})(\Sigma_{\mathsf{Free}\, \mathsf{Cell}\, C}^{\mathsf{Cell}}(\tau_V(v))) \\ &= \mathsf{Cell}(\varepsilon_{\Sigma C} \circ \mathsf{Free} \, \Sigma_C^{\mathsf{Cell}})((\Sigma \, \tau)_V(v)) \\ &= (\varepsilon_{\Sigma C} \circ \mathsf{Free} \, \Sigma_C^{\mathsf{Cell}} \circ \Sigma \, \tau)_V(v), \end{split}$$

so the morphisms are equal.


Definition 12. The hom ω -category of a bipointed ω -category $(X, \alpha : TX \to X, x_-, x_+)$ is the ω -category that consists of the globular set $\Omega(X, x, x_+)$ and the structure morphism

$$T \Omega(X, x, x_+) \xrightarrow{\Omega^T} \Omega T^{\star, \star} X \xrightarrow{\Omega \alpha} \Omega(X, x, x_+)$$

As explained above, this definition extends to a functor

$$\Omega:\omega\operatorname{Cat}^{\star,\star}\to\omega\operatorname{Cat}$$

that extends the path space functor Ω : $\mathsf{Glob}^{\star,\star} \to \mathsf{Glob}$, in the sense that the following solid square commutes:



Suspension. The category of bipointed ω -categories is cocomplete being the category of algebras of a finitary monad on a locally presentable category, and the vertical functors in this commuting square are monadic. Therefore, by the adjoint lifting theorem [16], the hom ω -category functor also admits a left adjoint Σ that commutes with the free functors $F^{T^{\star,\star}}$ and F^T . It is not hard to show that restricting the left adjoint to the subcategory of computads gives the suspension functor defined before, in the sense that the following diagram commutes up to isomorphism:

Since the suspension of an ω -category is defined as a left adjoint, commutativity of this square amounts to showing for every computed C and every bipointed ω -category (Y, y_{-}, y_{+}) that there exists a natural bijection

$$\psi:\omega\operatorname{Cat}^{\star,\star}(K^{T^{\star,\star}}(\Sigma \operatorname{C}),Y)\xrightarrow{\sim}\omega\operatorname{Cat}(K^TC,\Omega Y)$$

We claim that such a bijection is given by

$$\psi(f) = \Omega(f \circ \boldsymbol{\Sigma}_C^{\mathsf{Cell}}) : K^T C \to \Omega Y$$

First of all, we need to check that $\psi(f)$ is a morphism of ω -categories for every morphism of bipointed ω -categories f. This amounts to commutativity of the

exterior of the following diagram

where the unnamed morphisms $T^{\star,\star}Y \to Y$ is $T^{\star,\star}$ -algebra structure of Y. The left square in this diagram commutes, being the transpose of diagram (1). The top square commutes by naturality, and the bottom square commutes by f being an algebra morphism. Therefore, $\psi(f)$ is well-defined.

To show that ψ is bijective, we use that morphisms out of a computad are determined by their values on generators [12, Corollary 6.5]. Assume that $\psi(f) = \psi(g)$ for a pair of morphisms of bipointed ω -categories. Then f and g agree on the 0-dimensional generators being bipointed, and they agree on positive-dimensional ones by $\Omega \Sigma^{Cell}$ being a bijection on the generators. Therefore, f = g. For surjectivity, given a morphism $h : K^T C \to \Omega Y$, we define inductively a sequence of morphisms $f_n : K_n^T(\Sigma C)_n \to Y$ by letting f_0 being the unique morphism determined by $f(v_{\pm}) = y_{\pm}$ and f_{n+1} being the morphism induced by f_n and the function

$$V_{n+1}^{\mathbf{\Sigma}\,C} = V_n^C \xrightarrow{\mathrm{var}} \mathrm{Cell}_n \, C \xrightarrow{h} (\Omega Y)_n \hookrightarrow Y_{n+1}$$

Finally, we let $f: K^T(\Sigma C) \to Y$ be the morphisms out of the colimits induced by the f_n . Then by construction $\psi(f)$ and h agree on generators, so they must be equal.

Hom computads. Before closing this section, we will show that for for every bipointed computed C, the hom ω -category $\Omega K^T C$ is free on a computed. Using that the comparison functor K^T is fully faithful, this implies that the hom ω -category functor restricts to a functor

$$\Omega: \mathsf{Comp}^{\star,\star} \to \mathsf{Comp}$$


making the following two diagrams commute up to isomorphism:

$$\begin{array}{ccc} \omega \operatorname{Cat}^{\star,\star} & \xrightarrow{\Omega} & \omega \operatorname{Cat} & & \operatorname{Comp}^{\star,\star} & \xrightarrow{\Omega} & \operatorname{Comp} \\ K^{T^{\star,\star}} & & \uparrow & & \uparrow \\ \operatorname{Comp}^{\star,\star} & \xrightarrow{\Omega} & \operatorname{Comp} & & & \operatorname{Glob}^{\star,\star} & \xrightarrow{\Omega} & \operatorname{Glob} \end{array}$$

In order to show this property, we first need to identify the generators of the computed ΩC . Those are precisely the *indecomposable cells* of the ω -category $\Omega K^T C$:

Definition 13. An *n*-cell of an ω -category $\mathbb{X} = (X, \alpha : TX \to X)$ is *indecomposable* when it is not of the form $\alpha(\operatorname{coh}(B, A, \operatorname{Free} \sigma))$ for any Batanin tree B, full (n-1)-type A and morphism $\sigma : \operatorname{Pos}(B) \to X$. We will denote the set of indecomposable *n*-cells by X_n^{ind} .

Using the indecomposable cells of an ω -category X, we can build a computad $C_{\mathbb{X}}$ together with a morphism $\sigma_{\mathbb{X}} : K^T C_{\mathbb{X}} \to \mathbb{X}$. We start inductively by letting $C_{\mathbb{X},-1}$ the unique -1-computed and $\sigma_{\mathbb{X},-1} : K_{-1}^T C_{\mathbb{X},-1} \to \mathbb{X}$ the unique morphism from the initial ω -category. We then define the *n*-computed $C_{\mathbb{X},n}$ to be the triple $(C_{\mathbb{X},n-1}, V_n^{\mathbb{X}}, \phi_n^{\mathbb{X}})$ defined via the following pullback square



where $\operatorname{Par}_{n-1} X$ is the set of pairs of parallel (n-1)-cells of X. The morphism $\sigma_{\mathbb{X},n}: K_n^T C_{\mathbb{X},n} \to \mathbb{X}$ is the one determined by $\sigma_{\mathbb{X},n-1}$ and the function $V_n^{\mathbb{X}} \to X_n$ in the diagram above. Finally, we define $C_{\mathbb{X}}$ to consist of the computads $C_{\mathbb{X},n}$, and we let $\sigma_{\mathbb{X}}$ to be the morphism out of the colimit induced by the morphisms $\sigma_{\mathbb{X},n}$.

Proposition 14. For every bipointed computed C, the ω -category $\Omega K^{T^{\star,\star}}C$ is free on a computed.

Proof. Let $\mathbb{X} = \Omega K^{T^{\star,\star}}C$. We will show that the morphism $\sigma_{\mathbb{X}}$ is an isomorphism, or equivalently that it is bijective on all cells. We proceed by strong induction on the dimension of cells. Let therefore $n \geq 0$ and suppose that the result holds for all k < n. Since the inclusion $K_{n-1}^T C_{n-1} \to K^T C$ is the identity on cells of dimension at most (n-1), the bottom morphism of the square 2 must be an isomorphism, and hence the top one should be as well. This implies that $\sigma_{\mathbb{X}}$ is injective on generator *n*-cells.

This shows that $\sigma_{\mathbb{X}}$ is injective on 0-cells. If n > 0, then we can see that $\sigma_{\mathbb{X}}$ sends a coherence *n*-cell $c = \operatorname{coh}(B, A, \tau)$ to the decomposable *n*-cell:

$$\begin{split} \sigma_{\mathbb{X}}(c) &= \sigma_{\mathbb{X}}(\operatorname{coh}(B, A, \varepsilon \circ \operatorname{Free} \tau^{\dagger})) \\ &= (\sigma_{\mathbb{X}} \circ \operatorname{Cell}(\varepsilon))(\operatorname{coh}(B, A, \operatorname{Free} \tau^{\dagger})) \\ &= (\alpha_{\mathbb{X}} \circ \operatorname{Cell} \operatorname{Free} \sigma_{\mathbb{X}})(\operatorname{coh}(B, A, \operatorname{Free} \tau^{\dagger})) \\ &= \alpha_{\mathbb{X}}(\operatorname{coh}(B, A, \operatorname{Free}(\sigma_{\mathbb{X}} \tau^{\dagger}))) \end{split}$$

where τ^{\dagger} : $\mathsf{Pos}(B) \to \mathsf{Cell} \operatorname{\mathsf{Free}} C$ the transpose of τ under the $\mathsf{Free} \dashv \mathsf{Cell}$ adjunction. As $\sigma_{\mathbb{X}}$ sends generators to indecomposable cells, it can not send a generator and a coherence to the same cell.

Finally, to show that $\sigma_{\mathbb{X}}$ is injective on *n*-cells, it remains to show that it is injective on coherence cells. For that, let $c = \operatorname{coh}(B, A, \tau)$ and $c' = \operatorname{coh}(B', A', \tau')$ and suppose that

$$\sigma_{\mathbb{X}}(c) = \sigma_{\mathbb{X}}(c').$$

From the definition of $\alpha_{\mathbb{X}}$, we can compute further that

$$\begin{split} \sigma_{\mathbb{X}}(c) &= (\Omega \operatorname{\mathsf{Cell}}^{\star,\star}(\varepsilon_C)(\Omega \, T^{\star,\star}\kappa_{\operatorname{\mathsf{Cell}}^{\star,\star}C})(\Omega \, \Sigma_{\Omega \, \operatorname{\mathsf{Cell}}^{\star,\star}C}^T))(\operatorname{coh}(B, A, \operatorname{Free}(\sigma_{\mathbb{X}}\tau^{\dagger}))) \\ &= (\Omega \, \operatorname{Cell}^{\star,\star}(\varepsilon_C)(\Omega \, T^{\star,\star}\kappa_{\operatorname{\mathsf{Cell}}^{\star,\star}C}))(\operatorname{coh}(\Sigma \, B, \Sigma^{\operatorname{Sphere}} \, A, \Sigma \, \operatorname{Free}(\sigma_{\mathbb{X}}\tau^{\dagger}))) \\ &= \operatorname{coh}(\Sigma \, B, \Sigma^{\operatorname{Sphere}} \, A, \varepsilon_C \, \operatorname{Free} \kappa \circ \Sigma \, \operatorname{Free}(\sigma_{\mathbb{X}}\tau^{\dagger}))) \\ &= \operatorname{coh}(\Sigma \, B, \Sigma^{\operatorname{Sphere}} \, A, \varepsilon_C \circ \operatorname{Free}(\kappa \circ \Sigma(\sigma_{\mathbb{X}}\tau^{\dagger}))) \end{split}$$

so from the equality above and injectivity of the constructor coh, we get that $\Sigma B = \Sigma B'$, that $\Sigma^{\text{Sphere}} A = \Sigma^{\text{Sphere}} A'$, and that the corresponding morphisms agree. The suspension is injective on trees by injectivity of br[], so B = B'. The equality of morphisms implies that $\sigma_{\mathbb{X}} \tau^{\dagger} = \sigma_{\mathbb{X}} \tau'^{\dagger}$ by transposing along the adjunction Free \vdash Cell and $\Sigma \vdash \Omega$. By structural induction on the *n*-cells, we may assume that $\sigma_{\mathbb{X}}$ is injective on the *n*-cells in the image of τ^{\dagger} from which we conclude that $\tau^{\dagger} = \tau'^{\dagger}$ and hence that $\tau = \tau'$. Finally by structural induction, we can see that Σ^{Cell} and Σ^{Sphere} are monic, so A = A' and c = c'.

To show that $\sigma_{\mathbb{X}}$ is surjective on *n*-cells, we proceed by structural induction on the cells. Since the function $\sigma_{\mathbb{X},n,V}^{\text{ind}}$ is bijective, every indecomposable *n*-cell is in the image of $\sigma_{\mathbb{X}}$. Suppose therefore that $c \in X_n$ can be decomposed in the form

$$c = \alpha_{\mathbb{X}}(\mathsf{coh}(B, A, \mathsf{Free}\,\tau)) = \mathsf{coh}(\Sigma B, \Sigma^{\mathsf{Sphere}} A, \varepsilon_C \circ \mathsf{Free}(\kappa \circ \Sigma \tau)).$$

By structural induction, we may assume that for every position $p \in \mathsf{Pos}_k(B)$, there exists a cell $\tau'(p) \in \mathsf{Cell}_n(C_{\mathbb{X}})$ such that

$$\tau(p) = \sigma_{\mathbb{X}}(\tau'(p))$$

By injectivity of σ on cells of dimension at most k, those cells are unique and they can be assembled into a morphism $\tau' : \mathsf{Pos}(B) \to \mathsf{Cell}(C_{\mathbb{X}})$ such that $\tau = \sigma_{\mathbb{X}}\tau'$. Using this morphism and the calculations above, we see that

$$c = lpha_{\mathbb{X}}(\mathsf{coh}(B, A, \mathsf{Free}(\sigma_{\mathbb{X}}\tau'))) = \sigma_{\mathbb{X}}(\mathsf{coh}(B, A, \varepsilon \circ \mathsf{Free}\, \tau')),$$

so $\sigma_{\mathbb{X}}$ is surjective on *n*-cells.

5.3 Opposites of hom ω -categories

As a final application of the techniques introduced in this paper, we show that the operations of forming hom ω -categories and opposite categories commute. To make this statement precise, we first extend the action of $G = \mathbb{Z}_2^{\mathbb{N}>0}$ on ω Cat to an action on bipointed ω -categories

$$\mathsf{op}: G \to \mathsf{Aut}(\omega \,\mathsf{Cat}^{\star,\star})$$

by letting for $w \in G$ the opposite of a bipointed ω -category (X, x, x_+) be the ω -category $\mathsf{op}_w X$ with the same basepoints when $1 \notin w$, and with the basepoints swapped when $1 \in w$.

Lemma 15. For every $w \in G$, there exists a natural isomorphism

$$\mathsf{op}_w^{\Sigma}: \Sigma \operatorname{op}_{w-1} \Rightarrow \mathsf{op}_w \Sigma: \mathsf{Comp} \to \mathsf{Comp}^{\star,\star}$$

compatible with the natural isomorphism of Lemma 4 in the sense that

$$\mathsf{op}^{\Sigma}_w \mathsf{Free} = \mathsf{Free} \, \mathsf{op}^{\Sigma}_w$$


and the following diagram commutes:

$$\begin{array}{c|c} \Sigma \operatorname{op}_{w-1} \operatorname{Cell} & \stackrel{\operatorname{op}_w^{L} \operatorname{Cell}}{\longrightarrow} \operatorname{op}_w \Sigma \operatorname{Cell} \\ \Sigma \operatorname{op}_{w-1}^{\operatorname{Cell}} & & & & & & \\ \Sigma \operatorname{Cell} \operatorname{op}_{w-1} & & & & & & \\ \Sigma^{\operatorname{Cell}} \operatorname{op}_{w-1} & & & & & & & \\ \operatorname{Cell} \Sigma \operatorname{op}_{w-1} & & & & & & & \\ \end{array} \begin{array}{c} & & & & & & \\ \Sigma^{\operatorname{Cell}} \operatorname{op}_w^{\operatorname{Cell}} \Sigma & & & & & \\ \end{array} \end{array}$$

Proof. We will build natural isomorphism

$$\mathsf{op}_w^{\Sigma}: \Sigma \operatorname{op}_{w-1} \Rightarrow \mathsf{op}_w \Sigma: \mathsf{Comp}_n \to \mathsf{Comp}_{n+1}$$

inductively on $n \ge -1$ commuting with the forgetful functors u_n , the inclusion functors Free_n and making the following pentagons commute



For the unique (-1)-computed, we let

$$\mathsf{op}_w^{\Sigma}: \{v_-, v_+\} \to \{v_-, v_+\}$$

be the identity function when $1 \notin w$, and the function swapping the two generators when $1 \in w$. This is a natural isomorphism making the second pentagon commute: both sides send the unique (-1)-sphere to the 0-sphere (v_-, v_+) when $1 \notin w$, and to the 0-sphere (v_+, v_-) otherwise.

For an *n*-computed $C = (C_{n-1}, V_n^C, \phi_n^C)$ where $n \in \mathbb{N}$, we let

$$\mathsf{op}_{w,C}^{\Sigma} = (\mathsf{op}_{w,C_{n-1}}^{\Sigma}, \mathsf{var}) : \Sigma \, \mathsf{op}_{w-1} \, C \to \mathsf{op}_w \, \Sigma \, C$$

This is a well-defined morphism of computads by the commutativity of the second pentagon one dimension lower. Moreover, it commutes with the forgetful and the free functors by construction.

We will show that the first pentagon commutes for a computed C and that op_w^{Σ} is natural mutually inductively. First we see that the pentagon commutes when restricted to generators, since both $\mathsf{op}_w^{\mathsf{Cell}}$ and Σ^{Cell} preserve generators. Suppose now that n > 0 and let $c = \mathsf{coh}(B, A, \tau)$ a coherence *n*-cell of *C*. Then we see that

$$\begin{split} (\mathsf{op}_{w,\Sigma C}^{\mathsf{Cell}} \circ \Sigma_C^{\mathsf{Cell}})(c) \\ &= \mathsf{coh}(\mathsf{op}_w \,\Sigma \,B, A_1, \mathsf{op}_w \,\Sigma \,\tau \circ \mathsf{Free}_n \,\mathsf{op}_w^{\Sigma \,B}) \\ (\mathsf{Cell}_{n+1}(\mathsf{op}_{w,C}^{\Sigma}) \circ \Sigma_{\mathsf{op}_{w-1} \,C}^{\mathsf{Sphere}} \circ \mathsf{op}_{w-1,C}^{\mathsf{Sphere}})(c) \\ &= \mathsf{coh}(\Sigma \,\mathsf{op}_{w-1} \,B, A_2, \mathsf{op}_{w,C}^{\Sigma} \circ \Sigma \,\mathsf{op}_{w-1} \,\tau \circ \Sigma \,\mathsf{Free}_n \,\mathsf{op}_{w-1}^B) \end{split}$$

where

$$\begin{split} A_1 &= \mathsf{Sphere}_n \operatorname{Free}_n(\mathsf{op}_w^{\Sigma\,B})^{-1}(\mathsf{op}_w^{\mathsf{Sphere}}\,\Sigma^{\mathsf{Sphere}}\,A) \\ A_2 &= \Sigma_{\mathsf{op}_{w-1}\,C}^{\mathsf{Sphere}}(\mathsf{Sphere}_{n-1}\operatorname{Free}_{n-1}(\mathsf{op}_{w-1}^B)^{-1}(\mathsf{op}_{w-1}^{\mathsf{Sphere}}\,A)) \end{split}$$

By definition of the suspension and the opposite of a tree, we have that

$$\operatorname{op}_w \Sigma B = \Sigma \operatorname{op}_{w-1} B,$$

so the trees over which those coherence cells are built agree. Moreover, the natural isomorphism $\mathsf{op}_w^{\Sigma B}$ is defined to be the composite

$$\mathsf{op}_w^{\Sigma B} = \mathsf{op}_{w,\mathsf{Pos}(B)}^{\Sigma} \circ \Sigma \, \mathsf{op}_{w-1}^B$$
.

Using that fact and the naturality of Σ^{Sphere} , we can rewrite the spheres A_1 and A_2 respectively as

$$\begin{split} A_1 &= \mathsf{Sphere}_n \operatorname{Free}_n \Sigma(\mathsf{op}_{w-1}^B)^{-1}(\mathsf{Sphere}_n \operatorname{Free}_n(\mathsf{op}_{w,\operatorname{\mathsf{Pos}}(B)}^{\Sigma})^{-1}(\mathsf{op}_w^{\operatorname{\mathsf{Sphere}}} \Sigma^{\operatorname{\mathsf{Sphere}}}A)) \\ A_2 &= \operatorname{\mathsf{Sphere}}_n \Sigma \operatorname{\mathsf{Free}}_{n-1}(\mathsf{op}_{w-1}^B)^{-1}(\Sigma_{\mathsf{op}_{w-1}C}^{\operatorname{\mathsf{Sphere}}} \operatorname{op}_{w-1}^{\operatorname{\mathsf{Sphere}}}A) \end{split}$$

and observe that they agree by commutativity of the diagram for spheres one dimension lower, and commutativity of the suspension with the functor $Free_n$. Moreover, we may assume that the naturality square for τ commutes by the

inductive hypothesis, which shows that the morphisms defining the coherence cells agree. Therefore, the first pentagon commutes on coherence cells as well.

Let now $\sigma : D \to C$ be a morphism of *n*-computed and suppose that the pentagon commutes when restricted to cells of the form $\sigma_{n,V}(v)$ for $v \in V_n^D$. To show that the naturality square for σ commutes, i.e. that

$$\mathsf{op}_{w,C}^{\mathbf{\Sigma}} \circ \mathbf{\Sigma} \, \mathsf{op}_{w-1} \, \sigma = \mathsf{op}_w \, \mathbf{\Sigma} \, \sigma \circ \mathsf{op}_{w,D}^{\mathbf{\Sigma}}$$

we may assume by induction on the dimension and commutativity with the forgetful functors that the underlying morphisms of *n*-computads agree. It remains to show that the two morphisms agree on top-dimensional generators. Let therefore $v \in V_{n+1}^{\sum \operatorname{op}_{w-1} D} = V_n^D$ be a generator. Then

$$\begin{split} (\mathsf{op}_{w,C}^{\Sigma} \circ \Sigma \, \mathsf{op}_{w-1} \, \sigma)_V(v) &= \mathsf{Cell}_{n+1}(\mathsf{op}_{w,C}^{\Sigma})(\Sigma_{\mathsf{op}_{w-1}}^{\mathsf{Cell}} \, \mathsf{op}_{w-1,C}^{\mathsf{Cell}}(\sigma_V(v))) \\ &= \mathsf{op}_{w,\Sigma C}^{\mathsf{Cell}} \, \Sigma_C^{\mathsf{Cell}}(\sigma_V(v)) \\ &= (\mathsf{op}_w \, \Sigma \, \sigma)_V(v) \\ &= \mathsf{Cell}_{n+1}(\mathsf{op}_w \, \Sigma \, \sigma)(\mathsf{var} \, v) \\ &= \mathsf{Cell}_{n+1}(\mathsf{op}_w \, \Sigma \, \sigma)((\mathsf{op}_{w,D}^{\Sigma})_V v) \\ &= (\mathsf{op}_w \, \Sigma \, \sigma \, \circ \mathsf{op}_{w,D}^{\Sigma})_V(v) \end{split}$$

so the two morphisms agree on generators as well. Hence, the naturality square commutes.

This concludes the induction on $n \in \mathbb{N}$. By commutativity with the forgetful functors, the natural isomorphisms op_w^{Σ} for every $n \in \mathbb{N}$ combine to a natural isomorphism

$$\operatorname{op}_w^{\Sigma} : \Sigma \operatorname{op}_{w-1} \Rightarrow \operatorname{op}_w \Sigma : \operatorname{Comp} \to \operatorname{Comp}$$

as well. Commutativity of the first pentagon shows that the diagram of the lemma commutes, since op_w^{Σ} Cell is the identity on positive-dimensional cells. \Box

Proposition 16. For every $w \in G$, the following diagram commutes

$$\begin{array}{c} \omega \operatorname{Cat}^{\star,\star} \xrightarrow{\operatorname{op}_{w}} \omega \operatorname{Cat}^{\star,\star} \\ \Omega \\ \omega \\ \omega \operatorname{Cat} \xrightarrow{\operatorname{op}_{w-1}} \omega \operatorname{Cat} \end{array}$$

Proof. In order to prove commutativity of this diagram for some $w \in G$, it is useful to prove commutativity of the analogous diagram on the level of globular sets first:

The mate of the natural isomorphism of Lemma 4 is a natural transformation fitting in this square defined as the whiskered composite

$$\mathsf{op}_{w-1}\,\Omega=\Omega\,\mathsf{\Sigma}\,\mathsf{op}_{w-1}\,\Omega\xrightarrow{\Omega\,\mathsf{op}_w^{\Sigma}\,\Omega}\Omega\,\mathsf{op}_w\,\mathsf{\Sigma}\,\Omega\xrightarrow{\Omega\,\mathsf{op}_w\,\kappa}\Omega\,\mathsf{op}_w$$

for κ the counit of the adjunction $\Sigma \dashv \Omega$. One of the snake equations of this adjunction states that $\Omega \kappa$ is an identity. Combining that with the fact that op_w preserves cells and acts trivially on morphisms, we see that $\Omega \mathsf{op}_w \kappa$ must also be an identity. Moreover, the natural isomorphism op_w^{Σ} was defined to be the identity on positive-dimensional cells, so $\Omega \mathsf{op}_w^{\Sigma}$ must also be an identity. Since the mate of op_w^{Σ} is an identity natural transformation, we conclude that the square above must commute.

Since the diagram commutes on the level of globular sets, and the forgetful functors U^T and $U^{T^{\star,\star}}$ are faithful, it follows that the diagram commutes on the level of ω -categories if it commutes for objects, meaning that for every bipointed ω -category X, the ω -categories $\Omega \operatorname{op}_w X$ and $\operatorname{op}_{w-1} \Omega X$ are equal. Both ω -categories have the same underlying globular set by commutativity of the square on the level of globular sets, so it remains to show that they have the same structure morphisms. Unwrapping the definitions of op_w and Ω , this amounts to the commutativity of the following diagram of natural transformations

where $\mathbf{op}_{w}^{T^{\star,\star}}$ is simply \mathbf{op}_{w}^{T} seen as a natural isomorphism between bipointed globular sets. By naturality of the mate correspondence, commutativity of this diagram is equivalent to that of the following one:

Replacing each op_w^T by each inverse and rotating the diagram, we are left to show that the following diagram commutes:

But this is precisely the diagram of Lemma 15 whiskered on the right with Free, hence it commutes. $\hfill \Box$
