Abstract

Tauchi provides an example illustrating the action of a real algebraic subgroup H of $GL(2n,\mathbb{R})$ with finitely many orbits on \mathbb{R}^{2n} , while the dimension of the space of relative Hinvariant distributions on \mathbb{R}^{2n} is infinite. We offer a perspective on this example from the viewpoint of D-modules, where we explicitly determine the simple quotient regular holonomic D-modules and demonstrate that the distributions exhibit an enlarged symmetry.

1 Introduction

In 2018, Tauchi [\[10\]](#page-9-0) discovered a representation of a Lie group with finitely many orbits, where the dimension of relatively invariant distributions with a fixed character is infinite. This intriguing representation is motivated by providing an example demonstrating that the smooth regular representation on some homogeneous space of $SL(2n, \mathbb{R})$ with finitely many orbits under a real mirabolic subgroup has infinite multiplicity of a degenerate principal series representation [\[11\]](#page-9-1), [\[12\]](#page-9-2). Distributions of interest are characterized by being annihilated by vector fields corresponding to a Lie algebra. In this paper, we explore the left ideal generated by these vector fields in the ring of differential operators and the corresponding D-modules. This D-module must be non-holonomic due to the infinite dimension of its solutions. We identify countably many quotient D-modules, each turning out to be a simple holonomic D-module. Subsequently, we revisit the Lie algebraic interpretation of these quotient D-modules. It's important to note that the group used here is solvable (upper triangular), potentially resulting in the corresponding D-module having irregular singularities. Nevertheless, these simple holonomic D-modules must exhibit regular singularities.

The interplay between Lie algebra and D-modules for relatively invariant distributions was leveraged by the author [\[7\]](#page-9-3) to gain insights into the seminal work of van Dijk. In [\[13\]](#page-9-4), among other contributions, he highlights the non-existence of a spherical distribution — an invariant eigendistribution of the pseudo-Laplacian — on the tangent space of a rank-one semisimple symmetric space $SL(m+1,\mathbb{R})/GL(m,\mathbb{R})$ supported on the singular nilpotent orbits. This marked the beginning of harmonic analysis on this semisimple symmetric space [\[21,](#page-9-5) [22,](#page-9-6) [18,](#page-9-7) [19\]](#page-9-8) and the exploration of a generalized Gelfand pair [\[14,](#page-9-9) [15,](#page-9-10) [20\]](#page-9-11). Kowata [\[5\]](#page-9-12) establishes the non-existence of singular invariant distributions and hyperfunctions [\[4\]](#page-8-0) without resorting to the pseudo-Laplacian, subject to certain conditions. For instance, when considering the tangent space of $SL(m+1,\mathbb{R})/GL(m,\mathbb{R})$,

Kowata identifies a larger symmetry, $SO_0(m, m)$, compared to $GL(m, \mathbb{R})$. The author [\[7\]](#page-9-3) rearticulates this finding in terms of D-modules. Notably, in this tangent space setting, as well as the global setting [\[8\]](#page-9-13), two Lie algebras, $\mathfrak{gl}(m,\mathbb{R})$ and $\mathfrak{so}(m,m)$, exhibit the same D-modules. As a corollary, we deduce an automatic extension of the symmetry of spherical distribution and the non-existence of singular spherical distribution. In other words, there is no contribution of singular orbits under the smaller Lie group.

Tauchi's example focuses primarily on real projective spaces \mathbb{P}^3 and \mathbb{P}^5 of dimensions three and five, respectively. These spaces correspond to the real vector spaces $\mathbb{R}^4 \setminus \{0\}$ and $\mathbb{R}^6 \setminus \{0\}$ with the origin removed and divided by \mathbb{R}^{\times} . In our analysis, we operate on vector spaces $\mathbb{R}^{2n} = \mathbb{C}^n$ with $n = 2, 3$ without dividing by \mathbb{R}^{\times} , and we observe that including the origin poses no issues.

We introduce various real Lie subgroups of $GL(2n,\mathbb{R})$ and their Lie algebras, including their complexifications. Further, we delve into the orbit decomposition of \mathbb{R}^{2n} and \mathbb{C}^{2n} for each case.

In the context of the ring of differential operators with polynomial coefficients, denoted as

we define the left ideal $\mathcal I$ of $\mathcal D$ and the corresponding D-module $\mathcal D/\mathcal I$, along with its hyperfunction or distribution solutions. The reference for D-modules will be [\[1,](#page-8-1) [2\]](#page-8-2).

2 $n = 2$

2.1 Lie algebra

We define a solvable Lie subalgebra of $\mathfrak{gl}(4,\mathbb{C})$ by

The Lie algebra \mathfrak{h}_1 is illustrated as

where the figure on the left is represented in standard coordinates, whereas the figure on the right $\sqrt{ }$ 0 0 1 0 \setminus

illustrates the upper-triangular realization of the Lie algebra. Put $c =$ $\overline{}$ 0 1 0 0 1 0 0 0 0 0 0 1 | and a Lie

algebra isomorphism $\iota : \mathfrak{gl}(4) \to \mathfrak{gl}(4)$ by $\iota(A) = cAc^{-1}$.

We now consider the several subalgebras $\mathfrak{h}_3 \subset \mathfrak{h}_2 \subset \mathfrak{h}_1$ defined by

2.2 Real form

Let $X := \mathbb{C}^4$ be a complex four-dimensional vector space with the standard coordinates $z =$ $(z_1, z_2, z_3, z_4)^T$. Let $J :=$ $\sqrt{ }$ $\overline{}$ 0 0 1 0 0 0 0 1 1 0 0 0 0 1 0 0 \setminus . We define a real four-dimensional vector space

X_{\mathbb{R}} := \{ \mathbf{z} = (z_1, z_2, z_3, z_4)^T \in \mathbb{C}^4 \mid \mathbf{z} = J\overline{\mathbf{z}} \} = \{ (z_1, z_2, \overline{z_1}, \overline{z_2})^T \mid z_1, z_2 \in \mathbb{C} \}.

Then $X_{\mathbb{R}}$ is a real form of the complex vector space $X = \mathbb{C}^{4}$. The corresponding real form of the complex Lie algebra $\mathfrak{gl}(4,\mathbb{C}) = \mathrm{End}_{\mathbb{C}}(X)$ is $\mathfrak{g}_{\mathbb{R}} := \{X \in \mathfrak{gl}(4,\mathbb{C}) \mid J\overline{X}J = X\}.$

We define the real Lie algebra $\mathfrak{h}_{i\mathbb{R}} := \mathfrak{h}_i \cap \mathfrak{g}_{\mathbb{R}}$ for $i = 1, 2, 3$.

• $\mathfrak{h}_{1\mathbb{R}} = \mathfrak{h}_{2\mathbb{R}}$, which is not a real form of \mathfrak{h}_1 .

The image of each real Lie algebra by ι is given as

The dimension of each Lie algebra is

 $\dim_{\mathbb{C}} \mathfrak{h}_1 = 9$, $\dim_{\mathbb{C}} \mathfrak{h}_2 = 6$, $\dim_{\mathbb{C}} \mathfrak{h}_3 = 4$, $\dim_{\mathbb{R}} \mathfrak{h}_{1\mathbb{R}} = \dim_{\mathbb{R}} \mathfrak{h}_{2\mathbb{R}} = 6$, $\dim_{\mathbb{R}} \mathfrak{h}_{3\mathbb{R}} = 4$.

2.3 Orbit decomposition

For each Lie algebra or its corresponding Lie group, we consider the orbit decomposition by the action of $GL(4,\mathbb{C}) \supset H_1 \supset H_2 \supset H_3$ on $X = \mathbb{C}^4$ and the action of $G_{\mathbb{R}} \supset H_{1\mathbb{R}} = H_{2\mathbb{R}} \supset H_{3\mathbb{R}}$ on $X_{\mathbb{R}}$. The upper triangular realization $\iota(\mathfrak{h}_i)$ is preferred over the standard realization \mathfrak{h}_i to facilitate the observation of the orbit decomposition.

2.3.1 Complex

We define Zariski locally closed subsets O_2, O_1, O_0 of $\mathbb{C}^2 = \{(z_3, z_2)^T \in \mathbb{C}^2\}$ and O'_2, O'_1, O'_0 of $\mathbb{C}^2 = \{ (z_1, z_4)^T \in \mathbb{C}^2 \}$ by

Here, the index denotes the dimension of each orbit. We define $O_{ij} = O_i \times O'_j \subset \mathbb{C}^2 \times \mathbb{C}^2 \subset \mathbb{C}^4$ for $i, j = 0, 1, 2$. Then

Lemma 2. • O_{ij} are $\iota(H_2)$ -orbits.

- O_{ij} remain $\iota(H_3)$ -orbits unless $(i, j) = (1, 2), (2, 1)$.
- O_{12c} and O_{21c} are $\iota(H_3)$ -orbits for $c \in \mathbb{C}^{\times}$.
- $O_{22} \cup O_{12} \cup O_{02}$, O_{21} , O_{20} , $O_{11} \cup O_{01}$, O_{10} , O_{00} are $\iota(H_1)$ -orbits.

2.3.2 Real

The real form $X_{\mathbb{R}} = \{(z_1, z_2, \overline{z_1}, \overline{z_2}) \mid z_1, z_2 \in \mathbb{C}\}\)$ is a subset of $O_{22} \cup O_{11} \cup O_{00}$.

Lemma 3. • *There are three H*_{3R}-orbits

- Each orbit under $H_{3\mathbb{R}}$ is also an orbit under $H_{2\mathbb{R}}$.
- The real manifold O_{iiR} is a real form of the complex manifold O_{ii} for $i = 0, 1, 2$.

Remark 4. The groups H_3 and $H_{3\mathbb{R}}$ and their orbit decompositions are given by Tauchi [\[10\]](#page-9-0). It is important that H_3 has infinitely many orbits in \mathbb{C}^4 and $H_{3\mathbb{R}}$ has finitely many orbits in the real form $X_{\mathbb{R}}$.

2.4 D-module

In $X = \mathbb{C}^4$, we use coordinates $(z_1, z_2, z_3, z_4) \in X$, and $(z_1, z_2, z_3, z_4, \zeta_1, \zeta_2, \zeta_3, \zeta_4) \in T^*X$ for the cotangent bundle. The ring of differential operators on X is denoted by $\mathcal{D} = \mathcal{D}_X =$ $\mathbb{C}[z_1,z_2,z_3,z_4,\tfrac{\partial}{\partial z}$ $\frac{\partial}{\partial z_1}, \frac{\partial}{\partial z_2}$ $\frac{\partial}{\partial z_2}, \frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_3}, \frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_4}$. For a complex subspace $Y := \{z_2 = z_4 = 0\}$, which is the closure of O_{11} , we define a D-module

The characteristic variety of $\mathcal{B}_{Y|X}$ is the conormal bundle $\{\zeta_1 = z_2 = \zeta_3 = z_4 = 0\} = T_Y^* X \subset T^* X$ of Y, and the multiplicity of T_Y^*X is one, that is, $\mathcal{B}_{Y|X}$ is a simple holonomic system. We denote by $\delta(z_2, z_4) \in \mathcal{B}_{Y|X}$ the class represented by $1 \in \mathcal{D}$. For $l \in \mathbb{Z}_{\geq 0}$, we consider the element $T_l := (z_1 \frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_2}$ ^l $\delta(z_2, z_4) \in \mathcal{B}_{Y|X}$. Then

Lemma 5. The annihilator \mathcal{I}_{1l} of T_l is the left ideal of \mathcal{D} generated by

Proof. The partial algebraic Fourier transform

gives an algebra isomorphism from $\mathcal D$ to $\mathcal D$. This isomorphism sends $\mathcal B_{Y|X}$ to

The image of $\delta(z_2, z_4)$ is $1 \in \mathcal{O}_X$ and the image of T_l is $(-z_1z_2)^l \in \mathcal{O}_X$. In the one variable case, the annihilator of z_1^l in $\mathbb{C}[z_1, \frac{\partial}{\partial z_1}]$ $\frac{\partial}{\partial z_1}$] is the left ideal of $\mathbb{C}[z_1, \frac{\partial}{\partial z_1}]$ $\frac{\partial}{\partial z_1}$] generated by $z_1 \frac{\partial}{\partial z_2}$ $\frac{\partial}{\partial z_1} - l$ and ∂^{l+1} $\frac{\partial}{\partial z_2} - l$ is $\frac{\partial}{\partial z_2}(-z_2) - l = -\left(z_2 \frac{\partial}{\partial z_2}\right)$ $\frac{\partial}{\partial z_2} + l + 1,$ which $\frac{\partial^{l+1}}{\partial z_1^{l+1}}$. The inverse partial Fourier transform of $z_2 \frac{\partial}{\partial z_1^{l+1}}$ demonstrates the desired lemma. □

Let \mathcal{I}_3 be the left ideal generated by

We define left D-modules $\mathcal{M}_{1l} := \mathcal{D}/\mathcal{I}_{1l}$ and $\mathcal{M}_3 := \mathcal{D}/\mathcal{I}_3$.

Theorem 6. (i) We have a D-module isomorphism $\mathcal{M}_{1l} \ni P \mapsto P \circ (z_1 \frac{\partial}{\partial z_1} \cdot P)$ $\frac{\partial}{\partial z_2}$ ^{\int} $\delta(z_2, z_4) \in \mathcal{B}_{Y|X}$. Especially, \mathcal{M}_{1l} is a simple holonomic system.

(ii) The natural D-module homomorphism $\mathcal{M}_3 \to \mathcal{M}_{1l}$ is surjective.

(iii) For any positive integer L, the natural D-module homomorphism $\mathcal{M}_3 \to \bigoplus$ L $_{l=0}$ \mathcal{M}_{1l} is surjective.

Proof. (i) follows from Lemma lemma: isom, and (ii) follows from the fact that $\mathcal{I}_3 \subset \mathcal{I}_{1l}$ for all $l \in \mathbb{Z}_{\geq 0}$. We prove (iii). For a given $P_l \in \mathcal{D}$ with $l = 0, 1, \ldots, L$, we put

then $P \equiv P_l \mod \mathcal{I}_{1l}$ with $l = 0, 1, \ldots, L$ follows.

We observe that

We will interpret these elements as images of a Lie algebra. Let

be a Lie algebra homomorphism induced from the standard representation of $GL(4,\mathbb{C})$ on $X=\mathbb{C}^4$. We define the character $\chi_l : \mathfrak{h}_1 = \mathfrak{a} \oplus \mathfrak{n} \to \mathbb{C}$ by

$$
\chi_l(E_{11}) = -l, \ \chi_l(E_{22}) = l + 1, \ \chi_l(E_{33}) = 0, \ \chi_l(E_{44}) = 1
$$

and $\chi_l(\mathfrak{n}) = 0$. The restriction of χ_l on \mathfrak{h}_3 is denoted by χ since it does not depend on l. Explicitly,

$$
\chi(E_{11} + E_{22}) = 1, \ \chi(E_{33} + E_{44}) = 1.
$$

Then Lemma [5](#page-4-0) and the equation [\(3\)](#page-5-0) show that

$$
(\rho - \chi)(\mathfrak{h}_3) \quad \subset \quad \mathcal{I}_3
$$

\n
$$
\cap \qquad \cap
$$

\n
$$
(\rho - \chi)(\mathfrak{h}_1) \quad \subset \quad \mathcal{I}_{1l} \tag{4}
$$

Remark 7. The Lie algebra homomorphism ρ induces the associative algebra homomorphism

$$
\tilde{\rho}:U(\mathfrak{gl}(4))\rightarrow \{P\in \mathcal{D}\mid [P,z_1\frac{\partial}{\partial z_1}+z_2\frac{\partial}{\partial z_2}+z_3\frac{\partial}{\partial z_3}+z_4\frac{\partial}{\partial z_4}]=0\}
$$

from the universal enveloping algebra of the Lie algebra $\mathfrak{gl}(4)$ onto the subalgebra of D of homogeneous degree zero. Note that the map $\tilde{\rho}$ is not injective; for example, a non-zero element $E_{14}E_{32} - E_{12}E_{34} \in U(\mathfrak{gl}(4))$ belongs to the kernel of $\tilde{\rho}$. Therefore, it is possible that two different Lie subalgebras of $\mathfrak{gl}(4)$ generate two distinct left ideals of $U(\mathfrak{gl}(4))$, whose images under $\tilde{\rho}$ may coincide. This is one of the reasons why invariance under a smaller Lie algebra extends to that under a larger Lie algebra.

2.5 Relatively invariant distribution

Let $\mathcal{B}_{X_{\mathbb{R}}}$ be sections of hyperfunctions on $X_{\mathbb{R}}$. From the diagram [\(4\)](#page-5-1), we conclude the following on solutions of differential equations.

Theorem 8.

$$
\{u \in \mathcal{B}_{X_{\mathbb{R}}} \mid Pu = 0, \forall P \in (\rho - \chi)(\mathfrak{h}_3)\} \qquad \supset \qquad \{u \in \mathcal{B}_{X_{\mathbb{R}}} \mid Pu = 0, \forall P \in \mathcal{I}_3\}
$$

$$
\bigoplus_{l \in \mathbb{Z}_{\geq 0}} \{u \in \mathcal{B}_{X_{\mathbb{R}}} \mid Pu = 0, \forall P \in (\rho - \chi)(\mathfrak{h}_1)\} \qquad \supset \qquad \bigoplus_{l \in \mathbb{Z}_{\geq 0}} \{u \in \mathcal{B}_{X_{\mathbb{R}}} \mid Pu = 0, \forall P \in \mathcal{I}_1\}
$$

Tauchi defines [\[10\]](#page-9-0) a distribution

$$
T_2^l = z_1^l \frac{\partial^l}{\partial z_2^l} \delta(z_2, \overline{z}_2) = (z_1 \frac{\partial}{\partial z_2})^l \delta(z_2, \overline{z}_2)
$$
\n
$$
\tag{5}
$$

on the real manifold $X_{\mathbb{R}} = \{(z_1, z_2, \overline{z_1}, \overline{z_2}) \mid z_1, z_2 \in \mathbb{C}\}\simeq \mathbb{R}^4$. Here $\delta(z_2, \overline{z_2})$ denotes the Dirac distribution $\frac{1}{-2\sqrt{-1}}\delta(\Re z_2, \Im z_2)$ on \mathbb{R}^4 . The support of T_2^l is the closure of $O_{11\mathbb{R}}$, that is, $O_{11\mathbb{R}} \sqcup O_{00\mathbb{R}}$.

Proposition 9. $T_2^l \in \{u \in \mathcal{B}_{X_{\mathbb{R}}}\mid Pu = 0, \forall P \in \mathcal{I}_{1l}\} \simeq \text{Hom}_{\mathcal{D}}(\mathcal{M}_{1l}, \mathcal{B}_{X_{\mathbb{R}}})$. Especially, T_2^l is relatively invariant under \mathfrak{h}_1 with the character χ_l , and is relatively invariant under \mathfrak{h}_3 with the $character \chi.$

Note that the relative invariance of T_2^l under \mathfrak{h}_3 is due to Tauchi. We regard Theorem [6](#page-4-1) as a D-module counterpart of this result.

3 $n = 3$

3.1 D-module

In $X = \mathbb{C}^6$, we use coordinates $(z_1, z_2, z_3, z_4, z_5, z_6) \in X$. The ring of differential operators on X is denoted by $\mathcal{D} = \mathcal{D}_X = \mathbb{C}[z_1, z_2, z_3, z_4, z_5, z_6, \frac{\partial}{\partial z_3}]$ $\frac{\partial}{\partial z_1}, \frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_2}, \frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_3}, \frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_4}, \frac{\partial}{\partial z_5}$ $\frac{\partial}{\partial z_5}, \frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_6}$. Let $Y = \{z_3 = z_6 = 0\} \subset$ $X = \mathbb{C}^6$, and define a simple holonomic D-module $\mathcal{B}_{Y|X}$ by

$$
\mathcal{B}_{Y|X}=\mathcal{H}_{[Y]}^2(\mathcal{O}_X)=\mathcal{D}/(\mathcal{D}\frac{\partial}{\partial z_1}+\mathcal{D}\frac{\partial}{\partial z_2}+\mathcal{D}z_3+\mathcal{D}\frac{\partial}{\partial z_4}+\mathcal{D}\frac{\partial}{\partial z_5}+\mathcal{D}z_6).
$$

The standard generator represented by $1 \in \mathcal{D}$ is denoted by $\delta(z_3, z_6) \in \mathcal{B}_{Y|X}$. We define a section of $\mathcal{B}_{Y|X}$.

$$
T_l = (z_2 \frac{\partial}{\partial z_3} + z_4 \frac{\partial}{\partial z_5})^l z_2 z_5 \delta(z_3, z_6)
$$
\n
$$
(6)
$$

$$
= z_2^l \left(z_2 z_5 \frac{\partial^l}{\partial z_3^l} + l z_4 \frac{\partial^{l-1}}{\partial z_3^{l-1}} \right) \delta(z_3, z_6)
$$

$$
= (z_2 z_5 - z_3 z_4)(z_2 \frac{\partial}{\partial z_3})^l \delta(z_3, z_6).
$$
 (7)

Lemma 10. The annihilator ideal \mathcal{I}_{1l} of T_l is generated by the following elements:

$$
\frac{\partial}{\partial z_1}, z_6, z_2 \frac{\partial}{\partial z_2} + z_3 \frac{\partial}{\partial z_3}, z_2 \frac{\partial}{\partial z_2} + z_4 \frac{\partial}{\partial z_4} - 1 - l, z_2 \frac{\partial}{\partial z_4} + z_3 \frac{\partial}{\partial z_5},
$$

$$
\frac{\partial^{l+1}}{\partial z_2^{l+1}} \frac{\partial}{\partial z_4}, z_3 \frac{\partial}{\partial z_4}, \frac{\partial^{l+2}}{\partial z_2^{l+2}} \frac{\partial}{\partial z_5}, z_3^{l+1} \frac{\partial}{\partial z_5},
$$

$$
\frac{\partial^2}{\partial z_4^2}, \frac{\partial^2}{\partial z_5^2}, \frac{\partial^2}{\partial z_4 \partial z_5}, z_4 \frac{\partial}{\partial z_4} + z_5 \frac{\partial}{\partial z_5} - 1.
$$

Proof. We define a left ideal \mathcal{I}'_l of \mathcal{D} generated by

$$
\frac{\partial}{\partial z_1}
$$
, $\frac{\partial}{\partial z_4}$, $\frac{\partial}{\partial z_5}$, z_6 , $z_2 \frac{\partial}{\partial z_2} - l$, $\frac{\partial^{l+1}}{\partial z_2^{l+1}}$, $z_3 \frac{\partial}{\partial z_3} + l$, z_3^l .

Using a similar argument to Theorem [6\(](#page-4-1)i), we see that $\mathcal{M}'_l := \mathcal{D}/\mathcal{I}'_l$ forms a simple holonomic system. Let \mathcal{I}'' be the left ideal generated by elements in the statement of Lemma other than $z_2\frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_4}+z_3\frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_5}$. By computing the image of generators of left ideals, we obtain the property:

$$
\mathcal{I}''z_4 \subset \mathcal{I}'_l \text{ and } \mathcal{I}''z_5 \subset \mathcal{I}'_{l+1},\tag{8}
$$

$$
\mathcal{I}'_l \frac{\partial}{\partial z_4} \subset \mathcal{I}'' \text{ and } \mathcal{I}'_{l+1} \frac{\partial}{\partial z_5} \subset \mathcal{I}''.
$$
\n
$$
(9)
$$

For example, $(z_2 \frac{\partial}{\partial z_1})$ $\frac{\partial}{\partial z_2} - l) \frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_4}=\frac{\partial}{\partial z_4}(z_2\frac{\partial}{\partial z_4}%)+\frac{\partial}{\partial z_4}(z_3\frac{\partial}{\partial z_4})=0$ $\frac{\partial}{\partial z_2}+z_4\frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_4} - l - 1$) – $z_4 \frac{\partial^2}{\partial z_2^2}$ $\frac{\partial^2}{\partial z_4^2} \in \mathcal{I}''$. We will see that the map $\mathcal{D} \ni P \mapsto (P z_4, P z_5) \in \mathcal{D}^{\oplus 2}$ induces a D-module isomorphism

$$
\phi: \mathcal{D}/\mathcal{I}'' \ni P \mapsto (Pz_4, Pz_5) \in \mathcal{M}'_l \oplus \mathcal{M}'_{l+1}.
$$

Actually, ϕ is well-defined from the property [\(8\)](#page-7-0). For a given $P_1, P_2 \in D$, put $P := P_1 \frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_4} + P_2 \frac{\partial}{\partial z_4}$ $\frac{\partial}{\partial z_4} \in$ D, then $Pz_4-P_1 \in \mathcal{I}'_l$ and $Pz_5-P_2 \in \mathcal{I}'_{l+1}$. This proves the surjectivity of ϕ . For the injectivity of ϕ , take a $P \in \mathcal{D}$ such that $(P \mod \mathcal{I}'')$ is in the kernel of ϕ . We may write $P = Q_1 \frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_4} + Q_2 \frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_5} + Q_3$ with $Q_i \in \mathbb{C}[z_1, z_2, z_3, z_4, z_5, z_6, \frac{\partial}{\partial z_5}]$ $\frac{\partial}{\partial z_1}, \frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_2}, \frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_3}, \frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_6}$. Then by assumption, $0 \equiv Pz_4 \equiv Q_1 + Q_3z_4$ $\text{mod } \mathcal{I}'_l$ and $0 \equiv Pz_5 \equiv Q_2 + Q_3z_5 \mod \mathcal{I}'_{l+1}$. There exist $Q_4 \in \mathcal{I}'_l, Q_5 \in \mathcal{I}'_{l+1}$ such that $Q_1 =$ $-Q_3z_4+Q_4, Q_2=-Q_3z_5+Q_5.$ Then $P=-Q_3(z_4\frac{\partial}{\partial z_3}$ $\frac{\partial}{\partial z_4}+z_5\frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_5} - 1$ + $Q_4 \frac{\partial}{\partial z_5}$ $\frac{\partial}{\partial z_4} + Q_5 \frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_5} \in \mathcal{I}''$ by the property [\(9\)](#page-7-1).

Note that the image of the map ϕ is the sum of two simple holonomic systems. Therefore, $\mathcal{D}/(\mathcal{I}''+D(z_2\frac{\partial}{\partial z_1})$ $\frac{\partial}{\partial z_4}+z_3\frac{\partial}{\partial z_4}$ $\frac{\partial}{\partial z_5}$)) is a simple holonomic system or zero. It is easy to see that the annihilator contains $\mathcal{I}'' + D(z_2 \frac{\partial}{\partial z_1})$ $\frac{\partial}{\partial z_4}+z_3\frac{\partial}{\partial z_4}$ \Box $\frac{\partial}{\partial z_5}$; then, maximality implies equality.

We define a complex Lie subalgebra $\mathfrak{h}_1 \subset \mathfrak{gl}(6, \mathbb{C})$ by

$$
\mathfrak{h}_1 = \bigoplus_{j=1}^6 \mathbb{C} E_{1j} \oplus \bigoplus_{i=2}^6 \mathbb{C} E_{i6} \oplus \mathbb{C} (E_{22} + E_{33}) \oplus \mathbb{C} (E_{44} + E_{55}) \oplus \mathbb{C} (E_{22} + E_{44}) \oplus \mathbb{C} (E_{42} + E_{53}).
$$

and its character $\chi_l : \mathfrak{h}_1 \to \mathbb{C}$ by

$$
\chi_l(E_{22} + E_{33}) = 0, \ \chi_l(E_{22} + E_{44}) = -1 - l, \ \chi_l(E_{44} + E_{55}) = -1, \n\chi_l(E_{1j}) = \chi_l(E_{i6}) = \chi_l(E_{42} + E_{53}) = 0.
$$

Then in terms of a Lie algebra homomorphism

$$
\rho: \mathfrak{gl}(6,\mathbb{C})\ni E_{ij}\mapsto -z_j\frac{\partial}{\partial z_i}\in \mathcal{D},
$$

Lemma [10](#page-7-2) implies $(\rho - \chi_l)(\mathfrak{h}_1) \subset \mathcal{I}_{1l}$.

We define a Lie subalgebra $\mathfrak{h}_3 \subset \mathfrak{h}_1$ by

$$
\mathfrak{h}_3=\mathbb{C}(E_{11}+E_{22}+E_{33})\oplus\mathbb{C}(E_{44}+E_{55}+E_{66})\oplus\mathbb{C}(E_{42}+E_{53})\oplus\mathbb{C}(E_{15}+E_{26})\oplus\mathbb{C}E_{13}\oplus\mathbb{C}E_{46}.
$$

We denote by χ the restriction of χ_l on \mathfrak{h}_3 since the restriction does not depend on l. We define the left ideal $\mathcal{I}_3 \subset \mathcal{D}$ generated by $(\rho - \chi)(\mathfrak{h}_3)$, that is,

$$
z_1\frac{\partial}{\partial z_1} + z_2\frac{\partial}{\partial z_2} + z_3\frac{\partial}{\partial z_3}, z_4\frac{\partial}{\partial z_4} + z_5\frac{\partial}{\partial z_5} + z_6\frac{\partial}{\partial z_6} - 1, z_5\frac{\partial}{\partial z_1} + z_6\frac{\partial}{\partial z_2}, z_2\frac{\partial}{\partial z_4} + z_3\frac{\partial}{\partial z_5}, z_3\frac{\partial}{\partial z_1}, z_6\frac{\partial}{\partial z_4}.
$$

Then $(\rho - \chi)(\mathfrak{h}_3) \subset (\rho - \chi_l)(\mathfrak{h}_{1l})$ for all $l \in \mathbb{Z}_{\geq 0}$, and $(\rho - \chi)(\mathfrak{h}_3) \subset \mathcal{I}_3 \subset \mathcal{I}_{1l}$. We have the same diagram [\(4\)](#page-5-1).

Now we move on to solutions of these D-modules. We choose a real form $X_{\mathbb{R}}$ = $\{(z_1, z_2, z_3, \overline{z_1}, \overline{z_2}, \overline{z_3}) \mid (z_1, z_2, z_3) \in \mathbb{C}^3\}$ of $X = \mathbb{C}^6$. Denote by $\mathcal{B}_{X_{\mathbb{R}}}$ the set of hyperfunctions on $X_{\mathbb{R}}$.

Lemma 11. *Tauchi's distribution* $T_0^l = (\overline{z}_1 \frac{\partial}{\partial \overline{z}_l})$ $\frac{\partial}{\partial \overline{z}_2}+z_2\frac{\partial}{\partial z}$ $\frac{\partial}{\partial z_3}$ ^l $|z_2|^2 \delta(z_3, \overline{z}_3) \in \mathcal{B}_{X_{\mathbb{R}}}$ is a solution of $\mathcal{D}/\mathcal{I}_{1l}$.

This shows T_0^l is relatively invariant under

 $\mathfrak{h}_{3\mathbb{R}} = \mathfrak{h}_3 \cap \mathfrak{g}_{\mathbb{R}}$ $=\{a(E_{11}+E_{22}+E_{33})+\overline{a}(E_{44}+E_{55}+E_{66})+b(E_{42}+E_{53})+\overline{b}(E_{15}+E_{26})+cE_{13}+\overline{c}E_{46}\mid a,b,c\in\mathbb{C}\}\$

with the character χ . Orbit decomposition is similar to $n = 2$, so we omit its description.
