# ON A MOD 3 PROPERTY OF $\ell$ -TUPLES OF PAIRWISE COMMUTING PERMUTATIONS

ABSTRACT. Let  $S_n$  denote the symmetric group of permutations acting on n elements. We investigate the double sequence  $\{N_{\ell}(n)\}$  counting the number of  $\ell$  tuples of elements of the symmetric group  $S_n$ , where the components commute, normalized by the order of  $S_n$ . Our focus lies on exploring log-concavity with respect to n:

$$N_{\ell}(n)^2 - N_{\ell}(n-1) \ N_{\ell}(n+1) \ge 0.$$

We establish that this depends on  $n \pmod{3}$  for sufficiently large  $\ell$ . These numbers are studied by Bryan and Fulman as the nth orbifold characteristics, generalizing work of Macdonald and Hirzebruch–Hofer concerning the ordinary and string-theoretic Euler characteristics of symmetric products. Notably,  $N_2(n)$  represents the partition numbers p(n), while  $N_3(n)$  represents the number of non-equivalent n-sheeted coverings of a torus studied by Liskovets and Medynkh. The numbers also appear in algebra since  $|S_n|$   $N_\ell(n) = |\text{Hom}(\mathbb{Z}^\ell, S_n)|$ .

#### 1. Introduction and main results

Let  $S_n$  denote the symmetric group on n elements. This paper delves into the log-concavity [Br15] of commuting  $\ell$ -tuples of permutations in  $S_n$ . Let

$$C_{\ell,n} := \left\{ (\pi_1, \dots, \pi_\ell) \in S_n^\ell : \pi_j \pi_k = \pi_k \pi_j \text{ for } 1 \le j, k \le \ell \right\}.$$

Let  $n \geq 20$ . We establish that the normalized number of elements

$$N_{\ell}(n) := \frac{|C_{\ell,n}|}{|S_n|} \in \mathbb{N}$$

is log-concave with respect to n at n, for almost all  $\ell$  (i. e. for all but finitely many), if and only if n is divisible by 3. This double sequence  $\{N_{\ell}(n)\}$  emerges as the specialization of the  $\ell$ th orbifold characteristic to the nth symmetric product of a manifold of ordinary Euler characteristic one, as demonstrated in the work of Bryan and Fulman [BF98]. Let  $g_{\ell}(n)$  be the number of subgroups of  $\mathbb{Z}^{\ell}$  of index n. Then:

**Theorem 1.1** (Bryan and Fulman, Theorem 2.1). For  $\ell \in \mathbb{N}$ , we have

$$\sum_{n=0}^{\infty} P_n^{g_{\ell}}(x) t^n = \prod_{n=1}^{\infty} (1 - t^n)^{-x g_{\ell-1}(n)} = \exp\left(x \sum_{n=1}^{\infty} g_{\ell}(n) \frac{t^n}{n}\right),$$

where  $P_n^{g_\ell}(x)$  is a polynomial of degree n with  $P_n^{g_\ell}(1) = N_\ell(n)$ .

We also refer to Abdesselam et al. ([ABDV23], p. 3) and White [Wh13].

In the instance where  $\ell=2$ , we discover that the polynomials correspond to the D'Arcais polynomials [DA13], known in combinatorics as the (shifted) Nekrasov–Okounkov polynomials [NO06, Ha10]. Further,  $P_n^{g_\ell}(1) = N_2(n) = p(n)$ , where p(n) denotes the number of partitions of n (see [An98, On04]). Additionally,  $N_2(n)$  equals the number of conjugacy classes in  $S_n$  [ET68]. Moving forward,  $\ell=3$  gives a connection to topology (see the introduction of Britnell [Br13]) due to work of Liskovets and Medynkh [LM09]. It has been proven that  $N_3(n)$  counts the number of non-equivalent n-sheeted coverings of a torus. Moreover, there is a direct connection to algebra and geometry highlighted by White [Wh13]. Obvious bijections exist between the elements of  $C_{\ell,n}$  and  $\operatorname{Hom}\left(\mathbb{Z}^{\ell}, S_n\right)$  and the number of actions of the group  $\mathbb{Z}^{\ell}$  on a set X of n labeled elements.

We call the double sequence  $\{N_{\ell}(n)\}\$  log-concave at n for  $\ell$ , if

$$\Delta_{\ell}(n) := N_{\ell}(n)^2 - N_{\ell}(n-1) N_{\ell}(n+1) \ge 0.$$

If  $\Delta_{\ell}(n) < 0$ , we call the pair  $(n, \ell)$  an exception (or strictly log-concave). In Section 1.1, Table 1 and Table 2 we recorded all exceptions for

$$1 < n < 30$$
 and  $1 < \ell < 40$ .

# 1.1. Landscape of exceptions.

## 1.2. Log-concavity of $\{N_{\ell}(n)\}$ at n for fixed n. We state our main result.

**Theorem 1.2.** Let  $n \geq 2$ . Then  $\{N_{\ell}(n)\}$  is log-concave at n for almost all  $\ell$ , if  $n \equiv 0 \pmod{3}$ . Further, let  $n \equiv 1 \pmod{3}$ . Then  $\{N_{\ell}(n)\}$  is strictly log-convex at n for almost all  $\ell$ . If  $n \equiv 2 \pmod{3}$ , then  $\{N_{\ell}(n)\}$  is log-concave at n for almost all  $\ell$ , if n < 20 and strictly log-convex at n for almost all  $\ell$ , if  $n \geq 20$ .

Through an in depth examination of the proof, we obtain the following:

Corollary 1.3. The possible bounds can be made explicit. Let

Then  $\Delta_{\ell}(n) > 0$  for  $n \equiv 0 \pmod{3}$  and  $\ell \geq \kappa(n)$ , and  $\Delta_{\ell}(n) < 0$  for  $n \equiv 1$ (mod 3) and  $\ell \geq \kappa(n)$ . Moreover, let  $n \geq 20$  and  $n \equiv 2 \pmod{3}$ , then  $\Delta_{\ell}(n) < 0$ for  $\ell \geq \kappa(n)$ .

This leads to the following result:

**Theorem 1.4.** Let  $1 \leq n \leq 20$ . Then we have the complete classification of exceptions as in Table 3.

### 1.3. Log-concavity of $\{N_{\ell}(n)\}$ for fixed $\ell$ .

It is a well-known result that the partition function p(n) is log-concave, as established by Nicolas [Ni78], and also by DeSalvo and Pak [DP15]. Consequently, as  $N_2(n) = p(n)$  the same log-concavity holds true for the sequence  $\{N_2(n)\}$ . Actually,  $\Delta_2(n) > 0$  for all even numbers n and all odd numbers n > 25. Both proofs rely on 6

the Rademacher formula for partition numbers, involving the Dedekind eta function. Limited knowledge exists on  $\ell > 2$ . We refer to Table 4 for the classification of all exceptions for  $n \leq 10^5$  for  $\ell = 3$  and  $n \leq 10^4$  otherwise.

Table 4 provides some evidence suggesting that for a fixed  $\ell$  the sequence  $N_{\ell}(n)$  is log-concave for almost all n. Additionally, we refer to Table 5, where we recorded the possible smallest  $n_0 = n_0(\ell)$  such that  $N_{\ell}(n)$  is log-concave for all  $n \geq n_0$ .

1.4. Exceptions for arbitrary  $\ell$  large. From our joint studies for large  $\ell$  and n, the following application arises.

Corollary 1.5. Let an arbitrary  $N \in \mathbb{N}$  be given. Then there exists a constant  $L \in \mathbb{N}$ , such that there exists an  $n \geq N$  with  $\Delta_{\ell}(n) < 0$  for all  $\ell \geq L$ .

This follows from Corollary 1.3. Let  $n \geq 20$ ,  $n \equiv 2 \pmod{3}$  and  $n \geq N$ . Let  $\ell \geq \kappa(n)$ . Then the result of Corollary 1.3 follows. Further, we obtain:

**Corollary 1.6.** Let  $\ell$  be given and  $\{N_{\ell}(n)\}$  be log-concave for almost all n. Let  $n_0(\ell)$  be given, such that  $\Delta_{\ell}(n) > 0$  for all  $n \geq n_0(\ell)$ . Then the sequence  $\{n_0(\ell)\}_{\ell}$  is unbounded.

#### 2. Preliminaries

Let  $n, \ell \geq 1$ . Let  $g_{\ell}(n)$  denote the number of subgroups of  $\mathbb{Z}^{\ell}$  of index n. Then

$$g_{\ell}(n) = \sum_{d|n} d g_{\ell-1}(d),$$

where  $g_0(n) = 1$  for n = 1 and 0 otherwise. The function  $g_\ell$  is multiplicative and satisfies the following for p prime and  $m \in \mathbb{N}$ :

$$g_{\ell}(p^m) = \frac{(p^{\ell}-1)\cdots(p^{\ell+m-1}-1)}{(p-1)\cdots(p^m-1)}.$$

Therefore,  $g_1(n) = g_{\ell}(1) = 1$ ,  $g_{\ell}(2) = 2^{\ell} - 1$ , and  $g_{\ell}(4) = \frac{1}{3} (2^{\ell} - 1) (2^{\ell+1} - 1)$ . Let  $\ell \geq 2$ . Then

$$n^{\ell-1} \le g_{\ell}(n) \le n^{\ell} \le \sigma(n) \, n^{\ell-1},$$

where  $\sigma(n) := \sum_{d|n} d$ .

Moreover, the identity (Theorem 1.1):

$$\sum_{n=0}^{\infty} N_{\ell}(n) t^{n} = \exp\left(\sum_{n=1}^{\infty} g_{\ell}(n) \frac{t^{n}}{n}\right)$$

implies that we have the following two properties:

(2.1) 
$$N_{\ell}(n) = \sum_{k \leq n} \sum_{\substack{m_1, \dots, m_k \geq 1 \\ m_1 + \dots + m_k = n}} \frac{1}{k!} \frac{g_{\ell}(m_1) \cdots g_{\ell}(m_k)}{m_1 \cdots m_k},$$

(2.2) 
$$N_{\ell}(n) = \frac{1}{n} \sum_{k=1}^{n} g_{\ell}(k) N_{\ell}(n-k), \text{ where } N_{\ell}(0) := 1.$$

A straightforward calculation leads to:

**Lemma 2.1.** Let  $\ell, n \geq 1$ , then  $\Delta_1(n) = 0$ . Let  $\ell > 1$ , then  $\Delta_{\ell}(1) < 0$  and  $\Delta_{\ell}(2) > 0$ . Further, let  $\ell > 1$ , then  $\Delta_{\ell}(3) < 0$  for  $2 \leq \ell \leq 13$  and  $\Delta_{\ell}(3) > 0$  for  $\ell \geq 14$ .

#### 3. Proof of Theorem 1.2

Let  $n, \ell \geq 2$ . It is well-known [BM65, MM65, SS20, HN22] that the maximum  $M_1(n)$  over all products of partitions of n is given by

$$M_1(n) := \max_{k \le n} \max_{\substack{m_1, \dots, m_k \ge 1 \\ m_1 + \dots + m_k = n}} m_1 \cdots m_k = \begin{cases} 3^{n/3}, & n \equiv 0 \pmod{3}, \\ 4 \cdot 3^{(n-4)/3}, & n \equiv 1 \pmod{3}, \\ 2 \cdot 3^{(n-2)/3}, & n \equiv 2 \pmod{3}. \end{cases}$$

This maximum is obtained for the following values of k dependent on  $n \pmod{3}$ :

$$k = \begin{cases} n/3, & n \equiv 0 \pmod{3}, \\ (n-1)/3 \text{ or } (n+2)/3, & n \equiv 1 \pmod{3}, \\ (n+1)/3, & n \equiv 2 \pmod{3}. \end{cases}$$

Moreover, for each of these values of k, the number of tuples reaching the maximum is given by:

$$\begin{cases} 1, & n \equiv 0 \pmod{3}, \\ \frac{n-1}{3} \text{ or } {\binom{(n+2)/3}{2}}, & n \equiv 1 \pmod{3}, \\ \frac{n+1}{3}, & n \equiv 2 \pmod{3}. \end{cases}$$

Since  $n^{\ell-1} \leq g_{\ell}(n) \leq g_2(n) \ n^{\ell-1}$ , we obtain

(3.1) 
$$A_{\ell}(n) \leq N_{\ell}(n) \leq N_{2}(n) (M_{1}(n))^{\ell-1}.$$

The values of  $A_{\ell}(n)$  are given by

$$A_{\ell}(n) = \begin{cases} \frac{3^{(\ell-2)n/3}}{(n/3)!}, & n \equiv 0 \pmod{3}, \\ \frac{3(4\cdot3^{(n-4)/3})^{\ell-2}}{2((n-4)/3)!}, & n \equiv 1 \pmod{3}, \\ \frac{(2\cdot3^{(n-2)/3})^{\ell-2}}{((n-2)/3)!}, & n \equiv 2 \pmod{3}. \end{cases}$$

We recall that  $N_2(n) = p(n)$ .

3.1. The case  $n \equiv 0 \pmod{3}$ . We obtain via (3.1):

$$\frac{N_{\ell}(n)^{2}}{N_{\ell}(n-1)N_{\ell}(n+1)} \geq \frac{3^{-2n/3}}{\left((n/3)!\right)^{2} p(n-1) p(n+1)} \left(\frac{9}{8}\right)^{\ell-1} \\
> \frac{3^{-2n/3}}{\left((n/3)!\right)^{2} p(n-1) p(n+1)} \left(1 + \frac{\ell-1}{8}\right).$$

Therefore,  $\Delta_{\ell}(n) > 0$  for  $\ell \ge 1 + 8\left(\frac{((n/3)!)^2 p(n-1)p(n+1)}{3^{-2n/3}} - 1\right)$ .

3.2. The case  $n \equiv 1 \pmod{3}$ . We obtain via (3.1):

$$\frac{N_{\ell}(n)^{2}}{N_{\ell}(n-1)N_{\ell}(n+1)} \leq \left(\left(\frac{n-1}{3}\right)! \ p(n)\right)^{2} 2 \cdot 3^{2(n-1)/3} \left(\frac{8}{9}\right)^{\ell-1} \\
< \left(\left(\frac{n-1}{3}\right)! p(n)\right)^{2} 2 \cdot 3^{2(n-1)/3} \left(1 + \frac{\ell-1}{8}\right)^{-1}.$$

Therefore,  $\Delta_{\ell}(n) < 0$  for  $\ell \ge 1 + 8\left(\left(\left(\frac{n-1}{3}\right)!p(n)\right)^2 2 \cdot 3^{2(n-1)/3} - 1\right)$ .

3.3. The case  $n \equiv 2 \pmod{3}$ . This particular case is more delicate compared to all other cases.

A direct calculation reveals the following:

**Lemma 3.1.** For fixed n > 1 the leading term of  $N_{\ell}(n)$  in terms of  $\ell$  is obtained by  $B_{\ell}(n) = C_1(n) (M_1(n))^{\ell-1}$ , defined by

$$C_{1}(n) = \begin{cases} \frac{1}{2^{n/3} \left(\frac{n}{3}\right)!}, & n \equiv 0 \pmod{3}, \\ \frac{7}{6} \frac{1}{2^{(n-4)/3} \left(\frac{n-4}{3}\right)!}, & n \equiv 1 \pmod{3}, \\ \frac{1}{2^{(n-2)/3} \left(\frac{n-2}{3}\right)!}, & n \equiv 2 \pmod{3}. \end{cases}$$

The bases of the second order growth terms are obtained by  $M_2(n)$  defined as

$$M_2(n) = \begin{cases} 2, & n = 3, \\ 2^3 \cdot 3^{(n-6)/3}, & n > 3, n \equiv 0 \pmod{3}, \\ 3, & n = 4, \\ 10, & n = 7, \\ 2^5 \cdot 3^{(n-10)/3}, & n > 7, n \equiv 1 \pmod{3}, \\ 5, & n = 5, \\ 2^4 \cdot 3^{(n-8)/3}, & n > 5, n \equiv 2 \pmod{3}. \end{cases}$$

Then we obtain

$$B_{\ell}(n) \leq N_{\ell}(n) \leq B_{\ell}(n) + p(n) M_{2}(n)$$
.

*Proof.* We obtain for  $n \equiv 0 \pmod 3$  that the leading term of  $N_{\ell}(n)$  in terms of  $\ell$ is  $\frac{1}{2^{n/3}(\frac{n}{n})!} \cdot 3^{(\ell-1)n/3}$ . For  $n \equiv 1 \pmod{3}$ ,  $n \geq 4$ , the maximal growth term of  $N_{\ell}(n)$ with respect to  $\ell$  is  $2^{-\frac{n-4}{3}} \frac{7}{6((n-4)/3)!} \cdot \left(4 \cdot 3^{\frac{n-4}{3}}\right)^{\ell-1}$ . For  $n \equiv 2 \pmod{3}$ , we obtain  $N_{\ell}\left(n\right)=R+\frac{1}{\left(\left(n-2\right)/3\right)!}\cdot2^{-\frac{n-2}{3}}\cdot\left(2\cdot3^{\frac{n-2}{3}}\right)^{\ell-1}$ , where R collects the terms of strictly slower growth. Similarly for  $M_2(n)$  Continuing with the proof for  $n \equiv 2 \pmod{3}$ , considering for  $n \equiv 2 \pmod{3}$ ,  $n \geq 5$ , the terms of largest growth in  $\ell$  are obtained as follows:

$$\frac{\left(N_{\ell}(n)\right)^{2}}{N_{\ell}(n-1)N_{\ell}(n+1)} \\
\geq \frac{\frac{\left(C_{1}(n)\right)^{2}}{C_{1}(n-1)C_{1}(n+1)}\left(\frac{\left(M_{1}(n)\right)^{2}}{M_{1}(n-1)M_{1}(n+1)}\right)^{\ell-1}}{\left(1+\frac{p(n-1)}{C_{1}(n-1)}\left(\frac{M_{2}(n-1)}{M_{1}(n-1)}\right)^{\ell-1}\right)\left(1+\frac{p(n+1)}{C_{1}(n+1)}\left(\frac{M_{2}(n+1)}{M_{1}(n+1)}\right)^{\ell-1}\right)} \\
\geq \frac{6}{7}\frac{n+1}{n-2}\frac{1}{\left(1+\frac{1}{71}\right)^{2}} > \frac{6}{7}\frac{n+1}{n-2}\frac{35}{36} = \frac{5}{6}\frac{n+1}{n-2} \ge 1$$

if  $n \leq 17$  and  $\frac{p(n+s)}{C_1(n+s)} \left(\frac{M_2(n+s)}{M_1(n+s)}\right)^{\ell-1} \leq \frac{1}{71}$  for  $s = \pm 1$ . This holds true if  $\ell \geq 1 + \max_{s=\pm 1} \log_{M_1(n+s)/M_2(n+s)} \left(71 \frac{p(n+s)}{C_1(n+s)}\right)$ . Note that

$$\frac{M_1(n-1)}{M_2(n-1)} = \begin{cases}
\frac{4}{3} \ge \frac{9}{8}, & n = 5, \\
\frac{12}{10} = \frac{6}{5} \ge \frac{9}{8}, & n = 8, \\
\frac{4 \cdot 3(n-5)/3}{252(n-11)/3} = \frac{9}{8}, & n > 8, n \equiv 2 \pmod{3}
\end{cases}$$

and

$$\frac{M_1(n+1)}{M_2(n+1)} = \frac{3^{(n+1)/3}}{2^3 \cdot 3^{(n-5)/3}} = \frac{9}{8}.$$

Therefore,

$$\max_{s=\pm 1} \log_{M_1(n+s)/M_2(n+s)} \left( 71 \frac{p(n+s)}{C_1(n+s)} \right) \leq \max_{s=\pm 1} \log_{9/8} \left( 71 \frac{p(n+s)}{C_1(n+s)} \right) \\
= \log_{9/8} \left( 71 \cdot 2^{(n+1)/3} \left( \frac{n+1}{3} \right) ! p(n+1) \right)$$

since  $C_1(n+1) < C_1(n-1)$  for  $n \equiv 2 \pmod{3}$  and n > 2.

In the opposite direction, we obtain

$$(N_{\ell}(n))^{2} - N_{\ell}(n-1) N_{\ell}(n+1)$$

$$\leq \frac{(C_{1}(n))^{2}}{C_{1}(n-1) C_{1}(n+1)} \left(\frac{(M_{1}(n))^{2}}{M_{1}(n-1) M_{1}(n+1)}\right)^{\ell-1} \left(1 + \frac{p(n)}{C_{1}(n)} \left(\frac{M_{2}(n)}{M_{1}(n)}\right)^{\ell-1}\right)^{2}$$

$$\leq \frac{6}{7} \frac{n+1}{n-2} \left(1 + \frac{1}{97}\right)^{2} < \frac{6}{7} \frac{n+1}{n-2} \frac{49}{48} = \frac{7}{8} \frac{n+1}{n-2} \leq 1$$

if  $n \geq 23$  and  $\frac{p(n)}{C_1(n)} \left(\frac{M_1(n)}{M_2(n)}\right)^{\ell-1} \leq \frac{1}{97}$ . This holds true if  $\ell \geq 1 + \log_{M_1(n)/M_2(n)} \left(97 \frac{p(n)}{C_1(n)}\right) = \log_{9/8} \left(97 \cdot 2^{(n-2)/3} \cdot \left(\frac{n-2}{3}\right)! p(n)\right)$  since  $\frac{M_1(n)}{M_2(n)} = \frac{2 \cdot 3^{(n-2)/3}}{16 \cdot 3^{(n-8)/3}} = \frac{9}{8}$ . In order to complete the analysis, let us consider the case n = 20. Including the third largest products as well, we derive the following through another straightforward calculation:

**Lemma 3.2.** In terms of the first three growth terms, we have

$$N_{\ell}(20) \le C_1(20) (M_1(20))^{\ell-1} + C_2(20) (M_2(20))^{\ell-1} + p(20) (M_3(20))^{\ell-1}$$

with

$$C_2(20) = \frac{43}{4!4!3!2^3}, \qquad M_3(20) = 5 \cdot 3^5.$$

With the first two growth terms, we establish for  $n \in \{19, 21\}$ 

$$N_{\ell}(n) \ge C_1(n) (M_1(n))^{\ell-1} + C_2(n) (M_2(n))^{\ell-1}$$

with

$$C_2(19) = \frac{41}{6!2^3}, \qquad C_2(21) = \frac{1}{3!4!2^5}.$$

*Proof.* For  $n = 21 \equiv 0 \pmod{3}$ , the leading terms of  $N_{\ell}(n)$  regarding  $\ell$  are  $\frac{1}{2^{7} \cdot 7!} \cdot 3^{7\ell-7} + \frac{1}{6 \cdot 2^{5} \cdot 4!} (8 \cdot 3^{5})^{\ell-1}$ . For  $n = 19 \equiv 1 \pmod{3}$ , we obtain the leading first two terms of  $N_{\ell}(n)$  regarding  $\ell$  as  $\frac{41}{6!} \cdot 2^{5\ell-8} \cdot 3^{3\ell-3} + \frac{7}{2^{5} \cdot 6!} \cdot (4 \cdot 3^{5})^{\ell-1}$ . For  $n = 20 \equiv 2 \pmod{3}$  we obtain the first two leading terms of  $N_{\ell}(n)$  regarding  $\ell$  as  $2^{\ell-7} \cdot 3^{6\ell-6} \cdot \frac{1}{6!} + 2^{4\ell-8} \cdot 3^{4\ell-4} \cdot \frac{43}{4!4!3}$ .

Therefore, regarding the proof for n = 20, we establish

For  $M_3$  (20) the calculation is similar.

$$(N_{\ell}(20))^{2} - N_{\ell}(19) N_{\ell}(21)$$

$$\leq \left(C_{1}(20) (M_{1}(20))^{\ell-1} + C_{2}(20) (M_{2}(20))^{\ell-1} + p(20) (M_{3}(20))^{\ell-1}\right)^{2}$$

$$- \left(C_{1}(19) (M_{1}(19))^{\ell-1} + C_{2}(19) (M_{2}(19))^{\ell-1}\right)$$

$$\cdot \left(C_{1}(21) (M_{1}(21))^{\ell-1} + C_{2}(21) (M_{2}(21))^{\ell-1}\right)$$

$$< -2^{5\ell-15} \cdot 3^{10\ell-10} \cdot \frac{211}{7!3!6!} + \left(C_{2}(20) (M_{2}(20))^{\ell-1} + p(20) (M_{3}(20))^{\ell-1}\right)^{2}$$

$$+ C_{1}(20) p(20) (M_{1}(20) M_{3}(20))^{\ell-1}$$

$$< -\frac{211}{7!3!6!2^{10}} (2^{5}3^{10})^{\ell-1} + \left((C_{2}(20) + p(20))^{2} + 2C_{1}(20) p(20)\right) (10 \cdot 3^{11})^{\ell-1} \leq 0$$

if

$$\ell \geq 1 + \log_{16/15} \left( \frac{2^{10} \cdot 3!6!7! \left( \left( C_2 \left( 20 \right) + p \left( 20 \right) \right)^2 + 2C_1 \left( 20 \right) p \left( 20 \right) \right)}{211} \right)$$

$$= 1 + \log_{16/15} \left( \frac{3!6!7!2^{10}}{211} \left( \left( \frac{43}{4!4!3!2^3} + p \left( 20 \right) \right)^2 + \frac{p \left( 20 \right)}{6!2^5} \right) \right)$$

since  $(M_2(20))^2 = 2^8 3^8 < 10 \cdot 3^{11} = M_3(20) M_1(20)$ . Recall that  $N_{\ell}(1) = 1$  and  $N_{\ell}(2) = 2^{\ell-1}$  and we obtain  $N_{\ell}(3) = \frac{1}{2} \cdot 3^{\ell-1} + 2^{\ell-1} - \frac{1}{2}$ . Therefore,  $\frac{N_{\ell}(1)N_{\ell}(3)}{(N_{\ell}(2))^2} > 1$  for  $\ell \geq 2$  and it is  $\frac{2}{3}$  for  $\ell = 0$  and 1 for  $\ell = 1$ .

3.4. **Remark.** Note that from the proof we can actually derive the following bounds for  $\ell \geq L(n)$ :

$$L\left(n\right) = \begin{cases} 1 + \log_{9/8}\left(\left(\left(n/3\right)!\right)^{2}p\left(n-1\right)p\left(n+1\right)3^{3n/2}\right), & n \equiv 0 \pmod{3}, \\ 1 + \log_{9/8}\left(\left(\left(\frac{n-1}{3}\right)!p\left(n\right)\right)^{2} \cdot 2 \cdot 3^{2(n-1)/3}\right), & n \equiv 1 \pmod{3}, \\ 2, & n \equiv 2, \\ 1 + \log_{9/8}\left(71 \cdot 2^{(n+1)/3}\left(\frac{n+1}{3}\right)!p\left(n+1\right)\right), & n \equiv 2 \pmod{3}, \\ 2 < n \leq 17, & n \equiv 2 \pmod{3}, \\ 1 + \log_{16/15}\left(\frac{3!6!7!2^{10}}{211}\left(\left(\frac{1}{6!2^{6}} + p\left(20\right)\right)^{2} + \frac{p(20)}{6!2^{5}}\right)\right), & n \equiv 20, \\ 1 + \log_{9/8}\left(97 \cdot 2^{(n-2)/3} \cdot \left(\frac{n-2}{3}\right)!p\left(n\right)\right), & n \equiv 2 \pmod{3}, \\ & n \geq 23. \end{cases}$$

For  $1 \le n \le 20$  this leads to the bounds in Table 6.

The proof of Corollary 1.3 and Table 3 is now complete, after verifying the remaing cases with PARI/GP.
