# SPECTRAL BIPARTITE TURÁN PROBLEMS ON LINEAR HYPERGRAPHS

#### Abstract

Let $F$ be a graph and let $\mathcal{B}_{r}(F)$ be the class of $r$-uniform Berge- $F$ hypergraphs. In this paper, by establishing a relationship between the spectral radius of the adjacency tensor of a uniform hypergraph and its local structure via walks, we give a spectral asymptotic bound for $\mathcal{B}_{r}\left(C_{3}\right)$-free linear $r$-uniform hypergraphs and upper bounds for the spectral radii of $\mathcal{B}_{r}\left(K_{2, t}\right)$-free or $\left\{\mathcal{B}_{r}\left(K_{s, t}\right), \mathcal{B}_{r}\left(C_{3}\right)\right\}$-free linear $r$ uniform hypergraphs, where $C_{3}$ and $K_{s, t}$ are respectively the triangle and the complete bipartite graph with one part having $s$ vertices and the other part having $t$ vertices. Our work implies an upper bound for the number of edges of $\left\{\mathcal{B}_{r}\left(K_{s, t}\right), \mathcal{B}_{r}\left(C_{3}\right)\right\}$-free linear $r$-uniform hypergraphs, and extends some known work on (spectral) extreme problems of hypergraphs.


## 1. Introduction

A hypergraph $H=(V(H), E(H))$ consists of a vertex set $V(H)$ and an edge set $E(H)$, where each edge of $E(H)$ is a subset of $V(H)$. The hypergraph $H$ is called $r$-uniform if each edge has exactly $r$ elements, and is called linear if any two edges intersect into at most one vertex. Clearly a simple graph is a 2 -uniform linear hypergraph. A walk $W$ of length $k$ in $H$, simply called a $k$-walk, is an alternating sequence of vertices and edges of the form $v_{1} e_{1} v_{2} e_{2} v_{3} \cdots v_{k} e_{k} v_{k+1}$, where $v_{i} \neq v_{i+1}$ and $\left\{v_{i}, v_{i+1}\right\} \subseteq e_{i}$ for $i \in[k]:=\{1, \ldots, k\}$. The hypergraph $H$ is connected if every two vertices are connected by a walk.

In the above walk $W$, if $v_{1}=v_{k+1}$ and except $v_{1}, v_{k+1}$ no vertices or edges are repeated, then $W$ is called a (Berge) cycle; and the subhypergraph of $H$ induced by the edges $e_{1}, \ldots, e_{k}$ is called a Berge- $C_{k}$, where $C_{k}$ denotes a cycle on $k$ vertices (as simple graph). Formally, let $F$ be a simple graph and $H$ be a hypergraph. A hypergraph $H$ is called a Berge-F [20] if there is a bijection $\phi: E(F) \rightarrow E(H)$ such that $e \subseteq \phi(e)$

[^0]for all $e \in E(F)$. Denote by $\mathcal{B}_{r}(F)$ the family of all $r$-uniform Berge- $F$ hypergraphs. So $\mathcal{B}_{r}\left(C_{2}\right)$ is a family of $r$-uniform hypergraphs consisting of two edges sharing two vertices. The $r$-expansion of $F$, denoted by $F^{r}$, is the $r$-uniform hypergraph obtained from $F$ by enlarging each edge of $F$ with a vertex set of size $r-2$ disjoint from $V(F)$ such that distinct edges are enlarged by disjoint vertex sets. Clearly, $F^{r}$ is a Berge- $F$.

For a given family $\mathcal{F}$ of hypergraphs, we say $H$ is $\mathcal{F}$-free if it does not contain a subhypergraph isomorphic to any hypergraph $F \in \mathcal{F}$. So, linear hypegraphs are exactly $\mathcal{B}_{r}\left(C_{2}\right)$-free hypergraphs. Let $\operatorname{ex}_{r}(n, \mathcal{F})$ and $\operatorname{spex}_{r}(n, \mathcal{F})$ denote the maximum number of edges and the maximum spectral radius of $\mathcal{F}$-free $r$-uniform hypergraphs on $n$ vertices, respectively. Similarly, write $\operatorname{ex}_{r}^{\operatorname{lin}}(n, \mathcal{F})$ and $\operatorname{spex}_{r}^{\operatorname{lin}}(n, \mathcal{F})$ for the maximum number of edges and the maximum spectral radius of $\mathcal{F}$-free linear $r$-uniform hypergraphs on $n$ vertices, respectively. If simple graphs are considered, the subscripts $r$ are omitted in the above notations.

Turán type problems on graphs and hypergraphs that aim to determine $\operatorname{ex}_{r}(n, \mathcal{F})$ are the central topic of extremal combinatorics and have a vast literature; see e.g. [16, 28, 27, 30, 31]. The Erdös-Stone-Simonovits theorem ([7, 5]) stated that

$$
\operatorname{ex}(n, F)=\left(1-\frac{1}{\chi(F)}\right)\binom{n}{2}+o\left(n^{2}\right)
$$

where $\chi(F)$ is the chromatic number of $F$. Hence it is a challenging problem to determine the order of magnitude of $\operatorname{ex}(n, F)$ for a bipartite graph $F$.

Let $K_{s, t}$ denote the complete bipartite graph with two parts having $s$ vertices and $t$ vertices respectively, where $s \leq t$. The famous Zarankiewicz problem just asks for the maximum number of edges in a $K_{s, t}$-free graph on $n$ vertices, and the matrix version of the Zarankiewicz problem is seeking for $z(m, n, s, t)$ that is the maximum number of ones in a $(0,1)$-matrix of size $m \times n$ that does not contain, $J_{s, t}$, the all ones matrix of size $s \times t$, as a submatrix. Kóvari, Sós and Turán [24] presented one of the earliest bounds:

$$
\operatorname{ex}\left(n, K_{s, t}\right) \leq \frac{(t-1)^{\frac{1}{s}}}{2} n^{2-\frac{1}{s}}+\frac{s-1}{2} n
$$

Füredi 14 gave the case of $s=2$ :

$$
\lim _{n \rightarrow 0} \operatorname{ex}\left(n, K_{2, t}\right) n^{-\frac{3}{2}}=\frac{\sqrt{t-1}}{2}
$$

For the general case, Füredi [13] improved the asymptotic coefficient $(t-1)^{\frac{1}{s}}$ to $(t-$ $s+1)^{\frac{1}{s}}$ :

$$
\operatorname{ex}\left(n, K_{s, t}\right) \leq \frac{(t-s+1)^{\frac{1}{s}}}{2} n^{2-\frac{1}{s}}+\frac{s}{2} n^{2-\frac{2}{s}}+\frac{s}{2} n
$$

With the development of spectral extremal graph theory, the above results have the spectral versions as well. Babai and Barry [1] proposed the spectral Zarankiewicz problem and gave the upper bound

$$
\operatorname{spex}\left(n, K_{s, t}\right) \leq\left((t-1)^{\frac{1}{s}}+o(1)\right) n^{1-\frac{1}{s}}, 2 \leq s \leq t
$$

Furthermore, Nikiforov [29] presented the following upper bounds:

$$
\begin{gathered}
\operatorname{spex}\left(n, K_{2, t}\right) \leq \sqrt{(t-1)(n-1)+\frac{1}{4}}+\frac{1}{2}, \text { for } 2 \leq t \\
\operatorname{spex}\left(n, K_{s, t}\right) \leq(t-s+1)^{\frac{1}{s}} n^{1-\frac{1}{s}}+(s-1) n^{1-\frac{2}{s}}+s-2, \text { for } 3 \leq s \leq t
\end{gathered}
$$

Due to the difficulty of a general hypergraph Turán problem, the linear hypergraph Turán type problems have been paid more attention. For example, Ruzsa and Szemerédi [33] considered the ( 6,3 )-problem, the maximum number of edges of 3 -uniform hypergraphs not carrying three edges on six vertices. Erdös, Frankl and Rödl [6] investigated the generalized ( 6,3 )-problem, the maximum number of edges in an $r$-uniform hypergraph on $n$ vertices and in which the union of any three edges has size greater than $3 r-3$ (equivalently, the number $\operatorname{ex}_{r}^{\operatorname{lin}}\left(n, \mathcal{B}_{r}\left(C_{3}\right)\right)$ ), and presented that

$$
\begin{equation*}
n^{2-\epsilon}<\operatorname{ex}_{r}^{\operatorname{lin}}\left(n, \mathcal{B}_{r}\left(C_{3}\right)\right)=o\left(n^{2}\right) . \tag{1.1}
\end{equation*}
$$

for any $\epsilon>0$ when $n$ is large enough. Lazebnik and Verstraëte [25] gave the upper bound of the number of edges in an $r$-uniform hypergraphs $H$ on $n$ vertices without cycles of length less than five (implying that $H$ is linear and $\left\{\mathcal{B}_{r}\left(C_{3}\right), \mathcal{B}_{r}\left(C_{4}\right)\right\}$-free):

$$
e(H) \leq \frac{1}{r(r-1)} n^{\frac{3}{2}}+\frac{r-2}{2 r(r-1)} n+O\left(n^{-\frac{1}{2}}\right),
$$

where $e(H)$ denotes the number of edges of $H$; in particular, when $r=3$, if $H$ has the maximum number of edges, then

$$
e(H)=\frac{1}{6} n^{\frac{3}{2}}+o\left(n^{\frac{3}{2}}\right) .
$$

Timmons [35] generalized the result and presented

$$
\begin{equation*}
\operatorname{ex}_{r}^{\operatorname{lin}}\left(n,\left\{\mathcal{B}_{r}\left(C_{3}\right), \mathcal{B}_{r}\left(K_{2, t}\right)\right\}\right) \leq \frac{\sqrt{t-1}}{r(r-1)} n^{\frac{3}{2}}+\frac{n}{r} \tag{1.2}
\end{equation*}
$$

as $K_{2,2}=C_{4}$. Füredi and Özkahya [15] proved that for $k \geq 2$,

$$
\operatorname{ex}_{3}^{\operatorname{lin}}\left(n, \mathcal{B}_{r}\left(C_{2 k+1}\right)\right) \leq 2 k n^{1+\frac{1}{k}}+9 k n
$$

Gerbner, Methuku and Vizer 19 proved that for all $r, t \geq 2$.

$$
\operatorname{ex}_{r}^{\operatorname{lin}}\left(n, \mathcal{B}_{r}\left(K_{2, t}\right)\right) \leq \frac{\sqrt{t-1}}{r(r-1)} n^{\frac{3}{2}}+O(n)
$$

Ergemlidze, Győri and Methuku [8] proved that

$$
\operatorname{ex}_{3}^{\operatorname{lin}}\left(n, \mathcal{B}_{3}\left(C_{5}\right)\right)=\frac{1}{3 \sqrt{3}} n^{\frac{3}{2}}+O(n)
$$

For all integers $r \geq 2$ and $2 \leq s \leq t$, Gao and Chang [17] gave

$$
\operatorname{ex}_{r}^{\operatorname{lin}}\left(n, K_{s, t}^{r}\right) \leq \frac{(t-1)^{\frac{1}{s}}}{r(r-1)} n^{2-\frac{1}{s}}+O\left(n^{2-\frac{2}{s}}\right)
$$

and

$$
\begin{equation*}
\operatorname{ex}_{3}^{\operatorname{lin}}\left(n,\left\{C_{3}^{3}, K_{s, t}^{3}\right\}\right) \leq \frac{(t-s+1)^{\frac{1}{s}}}{6} n^{2-\frac{1}{s}}+\frac{s-1}{6} n^{2-\frac{2}{s}}+\frac{s-2}{6} n . \tag{1.3}
\end{equation*}
$$

Gao and Chang's result yields the corresponding bounds for some related Berge hypergraphs, as

$$
\operatorname{ex}_{r}^{\operatorname{lin}}\left(n, \mathcal{B}_{r}(F)\right) \leq \operatorname{ex}_{r}^{\operatorname{lin}}\left(n, F^{r}\right)
$$

The spectral version of hypergraph Turán type problems is seeking for the maximum spectral radius of hypergraphs on $n$ vertices, not containing a given hypergraph familiy $\mathcal{F}$ as sub-hypergraphs, where the spectral radius is the maximal absolute value of the eigenvalues of the adjacency tensor of a uniform hypergraph $H$. Hou, Chang and Cooper [21] proved that

$$
\begin{equation*}
\operatorname{spex}_{r}^{\operatorname{lin}}\left(n, \mathcal{B}_{r}\left(C_{4}\right)\right) \leq \sqrt{\frac{3}{2}+\frac{1}{2(r-1)}}(n-1)^{\frac{1}{2}}+O\left(n^{-\frac{1}{2}}\right) \tag{1.4}
\end{equation*}
$$

Gao, Chang and Hou [18] proved

$$
\operatorname{spex}_{r}^{\operatorname{lin}}\left(n, K_{r+1}^{r}\right) \leq \frac{n}{r}
$$

with equality if and only if $r \mid n$ and a $K_{r+1}^{r}$-free linear $r$-uniform hypergraph whose spectral radius attains the upper bound is a transversal design with $n$ vertices and $r$ groups. She, Fan, Kang and Hou [34] generalised the result to $F^{r}$ when $\chi(F) \geq r+1 \geq 3$ :

$$
\operatorname{spex}_{r}^{\operatorname{lin}}\left(n, F^{r}\right)=\frac{1}{r-1}\left(1-\frac{1}{\chi(F)-1}\right) n+o(n) .
$$

In this paper, we give a spectral analog result to the generalized (6,3)-problem or the asymptotic value of $\operatorname{spex}_{r}^{\operatorname{lin}}\left(n, \mathcal{B}_{r}\left(C_{3}\right)\right)$ (see Theorem 3.1), and given an upper bound for the spectral radius of $\mathcal{B}_{r}\left(K_{2, t}\right)$-free linear hypergraphs (see Theorem 3.3), which extends the work of Chang and Cooper [21] (Eq. (1.4)). We also present an upper bound for the spectral radius of $\left\{\mathcal{B}_{r}\left(K_{s, t}\right), \mathcal{B}_{r}\left(C_{3}\right)\right\}$-free linear hypergraphs for a general $s, t$ (see Theorem 3.7), and consequently we get an upper bounds for the number of edges of $\left\{\mathcal{B}_{r}\left(K_{s, t}\right), \mathcal{B}_{r}\left(C_{3}\right)\right\}$-free linear hypergraphs (see Corollary 3.8), which extends the work of Timmons [35] (Eq. (1.2)) and that of Gao and Chang [17] (Eq. (1.3)). The main
technique used in this paper is establishing the relationship between the spectral radius of a uniform hypergraph and its local structure via 1 -walks and 2-walks.

## 2. Preliminaries

For positive integers $r$ and $n$, a complex tensor (also called hypermatrix [4) $\mathcal{A}=$ $\left(a_{i_{1} i_{2} \ldots i_{r}}\right)$ of order $r$ and dimension $n$ refers to a multidimensional array $a_{i_{1} i_{2} \ldots i_{r}} \in \mathbb{C}$ for all $i_{1}, i_{2}, \ldots, i_{r} \in[n]$, where $[n]:=\{1,2, \ldots, n\}$. In 2005, Qi [32] and Lim [26] independently introduced the eigenvalues of tensors. If there exists a number $\lambda \in \mathbb{C}$ and a nonzero vector $\mathbf{x} \in \mathbb{C}^{n}$ such that

$$
\begin{equation*}
\mathcal{A} \mathbf{x}^{r-1}=\lambda \mathbf{x}^{[r-1]}, \tag{2.1}
\end{equation*}
$$

where $\mathbf{x}^{[r-1]}:=\left(x_{i}^{r-1}\right) \in \mathbb{C}^{n}$, and $\mathcal{A} \mathbf{x}^{r-1} \in \mathbb{C}^{n}$ defined by

$$
\left(\mathcal{A} \mathbf{x}^{r-1}\right)_{i}=\sum_{i_{2}, \ldots, i_{r}=1}^{n} a_{i i_{2} \ldots i_{r}} x_{i_{2}} \ldots x_{i_{r}}, i \in[n] .
$$

then $\lambda$ is called an eigenvalue of $\mathcal{A}$, and $\mathbf{x}$ is called an eigenvector of $\mathcal{A}$ corresponding to the eigenvalue $\lambda$. The spectral radius $\rho(\mathcal{A})$ is defined to be the maximum modulus of the eigenvalues of $\mathcal{A}$.

In 2012, Cooper and Dutle [4] introduced the adjacency tensor of an $r$-uniform hypergraph $H$ with vertex set $V(H)=\left\{v_{1}, v_{2}, \ldots, v_{n}\right\}$, an order $r$ dimension $n$ tensor $\mathcal{A}(H)=\left(a_{i_{1} i_{2} \ldots i_{r}}\right)$ whose $\left(i_{1}, i_{2}, \ldots, i_{r}\right)$-entry is given by

$$
a_{i_{1} i_{2} \ldots i_{r}}= \begin{cases}\frac{1}{(r-1)!}, & \text { if }\left\{v_{i_{1}}, v_{i_{2}}, \ldots, v_{i_{r}}\right\} \in E(H) \\ 0, & \text { otherwise }\end{cases}
$$

The weak irreducibility of nonnegative tensors was defined by Friedland, Gaubert and Han [12]. It was proved that an $r$-uniform hypergraph $H$ is connected if and only if its adjacency tensor $\mathcal{A}(H)$ is weakly irreducible (see [12] and [36]). The spectral property of nonnegative tensors or connected hypergraphs was investigated [4, 9, 10, 11] The Perron-Frobenius theorem of nonnegative matrices was generalized to nonnegative tensors, part of which is stated in the following.

Theorem 2.1 ([2, 36]). Let $\mathcal{A}$ be a nonnegative tensor of order $r$ and dimension $n$. Then the following statements hold.
(1) $\rho(\mathcal{A})$ is an eigenvalue of $\mathcal{A}$ corresponding to a nonnegative eigenvector.
(2) If furthermore $\mathcal{A}$ is weakly irreducible, then $\rho(\mathcal{A})$ is the unique eigenvalue of $\mathcal{A}$ corresponding to the unique positive eigenvector $\mathbf{x}$ up to a positive scalar.

Definition 2.2 ( 3 ). For a hypergraph $H=(V, E)$, the 2-shadow of $H$, denoted by $\partial H$, is the multi-graph formed by replacing each edge $e$ of $H$ with a complete graph on the vertices of $e$. That is,

$$
\partial H=(V, \partial E, \varphi),
$$

where $\partial E=\left\{\binom{e}{2}: e \in E(H)\right\}$ and $\varphi$ is a multiplicity function on $\partial E$ satisfying

$$
\varphi(f)=|\{e \in E(H): f \subseteq e\}|
$$

for any $f \in \partial E$.
For a multi-graph $G=(V, E, \varphi)$, where $\varphi$ is a multiplicity function on $E$, the adjacency matrix $A(G)=\left(a_{u v}\right)$ is the matrix of order $|V| \times|V|$ with entries

$$
a_{u v}= \begin{cases}\varphi(\{u, v\}), & \text { if } u \neq v \text { and }\{u, v\} \in E \\ 0, & \text { otherwise }\end{cases}
$$

Naturally, the spectral radius of an multi-graph $G$ is defined to be the spectral radius of its adjacency matrix $A(G)$, that is $\rho(G)=\rho(A(G))$.

Using a method similar to the one in [34], we establish a relation between the spectral radius of a uniform hypergraph and that of its 2-shadow graph.

Lemma 2.3 ([34]). Let $H$ be an r-uniform hypergraph. Then

$$
\rho(H) \leq \frac{1}{r-1} \rho(\partial H)
$$

If $H$ is also connected, then the equality holds if and only if $H$ is regular.
Let $u, v$ be two vertices of a hypergraph $H$. Denote by $w_{k}(u, v)$ the number of $k$ walks of $H$ starting at $u$ ending at $v$. Therefore, the number of $k$-walks starting at $u$ is $w_{k}(u):=\sum_{v \in V(H)} w_{k}(u, v)$. Finally we apply the local structure of a uniform hypergraph to bound the spectral radius of the hypergraph.

Lemma 2.4. Let $H$ be an r-uniform hypergraph with spectral radius $\rho:=\rho(H)$. If $w_{2}(u) \leq P w_{1}(u)+(r-1) Q$ for any vertex $u \in V(H)$, then

$$
\rho^{2}-\frac{P}{r-1} \rho-\frac{Q}{r-1} \leq 0
$$

where $P$ and $Q$ are parameters independent of the choice of $u$.
Proof. Let $\mathbf{x}$ be an nonnegative eigenvector of $H$ corresponding to the spectral radius $\rho$. Denote $E_{v}:=\{e \in E(H): v \in e\}$ for a vertex $v$ of $H$, and $\mathbf{x}^{S}:=\prod_{v \in S} x_{v}$ for a subset
$S \subseteq V(H)$. By eigenvector equation (2.1), for any $v \in V(H), \rho x_{v}^{r-1}=\sum_{e \in E_{v}} \mathbf{x}^{e \backslash\{v\}}$. Hence,

$$
\begin{aligned}
&\left(\rho-\frac{P}{r-1}\right) \sum_{v \in V(H)} \rho x_{v}^{r-1}=\left(\rho-\frac{P}{r-1}\right) \sum_{v \in V(H)} \sum_{e \in E_{v}} \mathbf{x}^{e \backslash\{v\}} \\
& \leq\left(\rho-\frac{P}{r-1}\right) \sum_{v \in V(H)} \sum_{e \in E_{v}} \sum_{u \in e \backslash\{v\}} \frac{x_{u}^{r-1}}{r-1} \\
&=\frac{1}{r-1} \sum_{v \in V(H)} \sum_{e \in E_{v}} \sum_{u \in e \backslash\{v\}}\left(\rho-\frac{P}{r-1}\right) x_{u}^{r-1} \\
&=\frac{1}{r-1} \sum_{v \in V(H)} \sum_{e \in E_{v}} \sum_{u \in e \backslash\{v\}}\left(\sum_{e^{\prime} \in E_{u}} \mathbf{x}^{e^{\prime} \backslash\{u\}}-\frac{P}{r-1} x_{u}^{r-1}\right) \\
& \leq \frac{1}{r-1}\left(\frac{1}{r-1} \sum_{v \in V(H)} \sum_{e \in E_{v}} \sum_{u \in e \backslash\{v\}} \sum_{e^{\prime} \in E_{u}} \sum_{w \in e^{\prime} \backslash\{u\}} x_{w}^{r-1}\right. \\
&\left.-\sum_{v \in V(H)} \sum_{e \in E_{v}} \sum_{u \in e \backslash\{v\}} \frac{P}{r-1} x_{u}^{r-1}\right),
\end{aligned}
$$

where the 2nd and the 5th inequalities follow from the AM-GM inequality. Clearly, for any given $v \in V(H)$,

$$
\begin{gathered}
\sum_{e \in E_{v}} \sum_{u \in e \backslash\{v\}} \sum_{e^{\prime} \in E_{u}} \sum_{w \in e^{\prime} \backslash\{u\}} x_{w}^{r-1}=\sum_{w \in V(H)} w_{2}(v, w) x_{w}^{r-1}, \\
\sum_{e \in E_{v}} \sum_{u \in e \backslash\{v\}} x_{u}^{r-1}=\sum_{u \in V(H)} w_{1}(v, u) x_{u}^{r-1}
\end{gathered}
$$

Thus, by the assumption of the theorem,

$$
\begin{aligned}
\rho\left(\rho-\frac{P}{r-1}\right) \sum_{v \in V(H)} x_{v}^{r-1} & \leq \frac{1}{(r-1)^{2}}\left(\sum_{v \in V(H)} \sum_{w \in V(H)} w_{2}(v, w) x_{w}^{r-1}-\sum_{v \in V(H)} \sum_{u \in V(H)} P w_{1}(v, u) x_{u}^{r-1}\right) \\
& =\frac{1}{(r-1)^{2}}\left(\sum_{w \in V(H)} \sum_{v \in V(H)} w_{2}(v, w) x_{w}^{r-1}-\sum_{u \in V(H)} \sum_{v \in V(H)} P w_{1}(v, u) x_{u}^{r-1}\right) \\
& =\frac{1}{(r-1)^{2}}\left(\sum_{w \in V(H)} w_{2}(w) x_{w}^{r-1}-\sum_{u \in V(H)} P w_{1}(u) x_{u}^{r-1}\right) \\
& \leq \frac{Q}{r-1} \sum_{v \in V(H)} x_{v}^{r-1}
\end{aligned}
$$

which implies the desired inequality.
Corollary 2.5. Let $H$ be a linear r-uniform hypergraph with the spectral radius $\rho:=$ $\rho(H)$. If $\sum_{u \in N_{H}(v)} d(u) \leq P d(v)+Q$ for any vertex $v \in V(H)$, then

$$
\rho^{2}-\frac{P}{r-1} \rho-\frac{Q}{r-1} \leq 0
$$

where $P$ and $Q$ are parameters independent of the choice of $v$.
Proof. As $H$ is linear, for any $v \in V(H), w_{1}(v)=(r-1) d(v)$, and

$$
w_{2}(v)=\sum_{u \in N_{H}(v)}(r-1) d(u) \leq(r-1) P d(v)+(r-1) Q=P w_{1}(v)+(r-1) Q
$$

The result follows by Lemma 2.4.
Lastly we need a lemma for later use.
Lemma 2.6. 13] Let $v, k \geq 1$ be integers and $c, x_{0}, x_{1}, \ldots, x_{v}$ be reals. If $\sum_{i=1}^{v}\binom{x_{i}}{k} \leq$ $c\binom{x_{0}}{k}$, then

$$
\sum_{i=1}^{v} x_{i} \leq x_{0} c^{\frac{1}{k}} v^{1-\frac{1}{k}}+(k-1) v
$$

3. Spectral Radius of $\mathcal{B}_{r}\left(C_{3}\right)$-Free, $\mathcal{B}_{r}\left(K_{2, t}\right)$-free, or $\left\{\mathcal{B}_{r}\left(C_{3}\right), \mathcal{B}_{r}\left(K_{s, t}\right)\right\}$-Free LINEAR HYPERGRAPHS

We need some notations. Let $u, v$ be two vertices of a hypergraph $H$. The distance between $u$ and $v$ (or from $u$ to $v$ ) is the minimum length of the walks between them. Denote respectively by $N_{H}(u)$ and $N_{H}^{2}(u)$ the sets of vertices of $H$ whose distance from $u$ is exactly one and two. We will use $N(u)$ and $N^{2}(u)$ if there exists no confusion. Let $S, T \subseteq V(H)$, where $S \cap T=\emptyset$. Denote by $H[S]$ the subhypergraph of $H$ whose vertex set is $S$ and whose edge set consists of all edges of $H$ contained in $S$. Similarly, $H[S, T]$ is the subhypergraph of $H[S \cup T]$ whose edge set consists of all edges of $H$ intersecting both $S, T$.
3.1. Spectral radius of $\mathcal{B}_{r}\left(C_{3}\right)$-free linear hypergraphs. By Lemma 2.3, the spectral version of the generalized $(6,3)$-problem can be obtained.

Theorem 3.1. For any $\varepsilon>0$, when $n$ is large enough,

$$
\begin{equation*}
n^{1-\varepsilon}<\operatorname{spex}_{r}^{\operatorname{lin}}\left(n, \mathcal{B}_{r}\left(C_{3}\right)\right)=o(n) \tag{3.1}
\end{equation*}
$$

Proof. By Eq. (1.1), there exists a $\mathcal{B}_{r}\left(C_{3}\right)$-free linear $r$-uniform hypergraph $H$ on $n$ vertices with more than $n^{2-\epsilon}$ edges. So,

$$
\operatorname{spex}_{r}^{\operatorname{lin}}\left(n, \mathcal{B}_{r}\left(C_{3}\right)\right) \geq \rho(H) \geq \frac{r e(H)}{n}>r n^{1-\epsilon}
$$

which proves the lower bound in Eq. (3.1).
Next we will prove the right equality. Assume to the contrary that $\operatorname{spex}_{r}^{\operatorname{lin}}\left(n, \mathcal{B}_{r}\left(C_{3}\right)\right) \neq$ $o(n)$. Then there exists a $\xi>0$ and a sequence of $\mathcal{B}_{r}\left(C_{3}\right)$-free linear $r$-uniform hypergraphs $H_{n_{k}}$ on $n_{k}$ vertices such that $\rho\left(H_{n_{k}}\right) \geq \xi n_{k}$. By Lemma [2.3, we have $\rho\left(\partial H_{n_{k}}\right) \geq(r-1) \xi n_{k}$. Without loss of generality, we assume that $\left\{H_{n}\right\}$ is a sequence of $\mathcal{B}_{r}\left(C_{3}\right)$-free linear $r$-uniform hypergraphs on $n$ vertices such that $\rho\left(\partial H_{n}\right) \geq \xi n$. In the following we simply write $H$ for $H_{n}$.

Let $\mathbf{x}$ be a nonnegative eigenvector of $\partial H$ corresponding to $\rho:=\rho(\partial H)$ with a certain vertex $u$ satisfying

$$
x_{u}=\max \left\{x_{i}: i \in V(\partial H)\right\}=1
$$

Since $H$ is linear, $\partial H$ is a simple graph. By eigenvector equation, we have

$$
\rho=\rho x_{u}=\sum_{v \in N_{\partial H}(u)} x_{v} \leq n-1 .
$$

Therefore,

$$
\begin{aligned}
\rho^{2} & =\rho^{2} x_{u}=\rho \sum_{v \in N_{\partial H}(u)} x_{v}=\sum_{v \in N_{\partial H}(u)} \sum_{w \in N_{\partial H}(v)} x_{w} \\
& =\sum_{v \in N_{\partial H}(u)}\left(\sum_{w \in N_{\partial H}(v) \cap\left\{N_{\partial H}(u) \cup\{u\}\right\}} x_{w}+\sum_{w \in N_{\partial H}(v) \backslash\left\{N_{\partial H}(u) \cup\{u\}\right\}} x_{w}\right) .
\end{aligned}
$$

Observe that

$$
\sum_{v \in N_{\partial H}(u)} \sum_{w \in N_{\partial H}(v) \cap\left\{N_{\partial H}(u) \cup\{u\}\right\}} x_{w}=\sum_{\{v, w\} \in E\left(\partial H\left[N_{\partial H}(u)\right]\right)}\left(x_{v}+x_{w}\right)+\sum_{v \in N_{\partial H}(u)} x_{u} .
$$

Moreover,

$$
\begin{aligned}
& \frac{1}{2} \sum_{\{v, w\} \in E\left(\partial H\left[N_{\partial H}(u)\right]\right)}\left(x_{v}+x_{w}\right)+\sum_{v \in N_{\partial H}(u)} x_{u}+\sum_{v \in N_{\partial H}(u)} \sum_{w \in N_{\partial H}(v) \backslash\left\{N_{\partial H}(u) \cup\{u\}\right\}} x_{w} \\
& \leq\left|E\left(\partial H\left[N_{\partial H}(u)\right]\right)\right|+\left|N_{\partial H}(u)\right|+\left|E\left(\partial H\left[N_{\partial H}(u), N_{\partial H}^{2}(u)\right]\right)\right| \\
& \leq|E(\partial H)| .
\end{aligned}
$$

Since $H$ is $B_{r}\left(C_{3}\right)$-free and linear, $\partial H\left[N_{\partial H}(u)\right]$ is the graph consisting of $d_{u}(H)$ disjoint cliques of size $r-1$. So

$$
\begin{aligned}
\frac{1}{2} \sum_{\{v, w\} \in E\left(\partial H\left[N_{\partial H}(u)\right]\right)}\left(x_{v}+x_{w}\right) & =\frac{1}{2} \sum_{v \in N_{\partial H}(u)} d_{\partial H\left[N_{\partial H}(u)\right]}(v) x_{v} \\
& =\frac{r-2}{2} \sum_{v \in N_{\partial H}(u)} x_{v} \\
& =\frac{r-2}{2} \rho .
\end{aligned}
$$

Therefore, by the above discussion and the fact $\rho<n$, we have

$$
\begin{aligned}
e(H) & =e(\partial H) \geq \rho^{2}-\frac{1}{2} \sum_{\{v, w\} \in E\left(\partial H\left[N_{\partial H}(u)\right]\right)}\left(x_{v}+x_{w}\right) \\
& =\rho^{2}-\frac{r-2}{2} \rho \\
& \geq \xi^{2} n^{2}-\frac{(r-2) n}{2}
\end{aligned}
$$

for $n$ sufficiently large; a contradiction to Eq. (1.1).
3.2. Spectral radius of $\mathcal{B}_{r}\left(K_{2, t}\right)$-free linear hypergraphs. Ergemlidze, Györi and Methuku [8] prensented the upper bound of $\operatorname{ex}_{3}^{\operatorname{lin}}\left(n, B_{r}\left(C_{4}\right)\right)$ by the following relation on degrees. Let $H$ be a $\mathcal{B}_{3}\left(C_{4}\right)$-free linear 3 -uniform hypergraph. Then, for any $v \in V(H)$,

$$
\sum_{u \in N_{H}(v)} d(u) \leq 6 d(v)+\frac{n}{2}
$$

Note that $C_{4}=K_{2,2}$. While considering $\operatorname{exx}_{r}^{\operatorname{lin}}\left(n, B_{r}\left(K_{2, t}\right)\right)$, Gerbner, Methuku and Vizer [19] find the following relation.

Lemma 3.2. [19] Let $H$ be a $\mathcal{B}_{r}\left(K_{2, t}\right)$-free linear r-uniform hypergraph. Then, for any $v \in V(H)$,

$$
\sum_{u \in N_{H}(v)} d(u) \leq\left(2 r^{2}-4 r+1\right) t d(v)+\frac{(t-1) n}{r-1}
$$

Before proving the main result, we need the following basic fact.
Fact 1. (1) If $x^{2}-p x-q \leq 0$ with $p>0, q>0$ and $\sqrt{q} \geq \frac{p}{2}$, then $x \leq q^{\frac{1}{2}}+p^{\frac{1}{2}} q^{\frac{1}{4}}$.
(2) If $x^{2}-p x-q \leq 0$ with $p>0$ and $q \geq 0$, then $x \leq p+\frac{q}{p}$.

Theorem 3.3. For $t \geq 2$, if $n \geq \frac{\left(2 r^{2}-4 r+1\right)^{2}}{4(t-2)}$, then

$$
\operatorname{spex}_{r}^{\operatorname{lin}}\left(n, \mathcal{B}_{r}\left(K_{2, t}\right)\right) \leq \frac{(t-1)^{\frac{1}{2}}}{r-1} n^{\frac{1}{2}}+\frac{\left(2 r^{2}-4 r+1\right)^{\frac{1}{2}}(t-1)^{\frac{1}{4} t^{\frac{1}{2}}}}{r-1} n^{\frac{1}{4}}
$$

Proof. For a $\mathcal{B}_{r}\left(K_{2, t}\right)$-free linear $r$-uniform hypergraph $H$ with $\rho:=\rho(H)$, by Lemma 3.2, taking $P=\left(2 r^{2}-4 r+1\right) t$ and $Q=\frac{(t-1) n}{r-1}$ in Corollary 2.5, we have

$$
\rho^{2}-\frac{\left(2 r^{2}-4 r+1\right) t}{r-1} \rho-\frac{(t-1) n}{(r-1)^{2}} \leq 0 .
$$

So, if $n \geq \frac{\left(2 r^{2}-4 r+1\right)^{2}}{4(t-2)}$, we have

$$
\rho \leq \frac{(t-1)^{\frac{1}{2}}}{r-1} n^{\frac{1}{2}}+\frac{\left(2 r^{2}-4 r+1\right)^{\frac{1}{2}}(t-1)^{\frac{1}{4}} t^{\frac{1}{2}}}{r-1} n^{\frac{1}{4}},
$$

by using Fact 1 (1).
3.3. Spectral radius of $\left\{\mathcal{B}_{r}\left(K_{s, t}\right), \mathcal{B}_{r}\left(C_{3}\right)\right\}$-free linear hypergraphs. An $r$-uniform hypergraph $H$ is called hm-bipartite if its vertex set has a bipartition (called hmbipartition) $V(H)=V_{1} \cup V_{2}$ such that each edge of $H$ intersects $V_{1}$ into exactly one vertex and $V_{2}$ the other $r-1$ vertices [23, 22]. In the above bipartition, $V_{1}$ is called the head part and $V_{2}$ is called the mass part; and if $\left|V_{1}\right|=m,\left|V_{2}\right|=n$, then the above $H$ is called $(m, n)$-hm-bipartite. An $(m, n)$-hm-bipartite linear $r$-uniform hypergraph $H$ is called exact $\mathcal{B}_{r}\left(K_{s, t}\right)$-free if $H$ contains no a subgraph $\mathcal{B}_{r}\left(K_{s, t}\right)$ with the part of $s$ vertices of $K_{s, t}$ in the head part of $H$ and the remaining part of $t$ vertices in the mass part of $H$.

Lemma 3.4. Let $H$ be an $(m, n)$-hm-bipartite exact $\mathcal{B}_{r}\left(K_{s, t}\right)$-free linear r-uniform hypergraph with an hm-bipartition $V(H)=V_{1} \cup V_{2}$ satisfying $\left|V_{1}\right|=m,\left|V_{2}\right|=n$, where $t \geq 2, s \geq 2$. Suppose further that $H$ is $\mathcal{B}_{r}\left(C_{3}\right)$-free. Then

$$
\begin{equation*}
e(H) \leq \frac{(t-1)^{\frac{1}{s}}}{r-1} m n^{1-\frac{1}{s}}+\frac{s-1}{r-1} n . \tag{3.2}
\end{equation*}
$$

Proof. For a fixed set $\left\{v_{1}, v_{2}, \ldots, v_{s}\right\} \subseteq V_{1}$, set

$$
N_{V_{2}}\left(v_{1}, v_{2}, \ldots, v_{s}\right)=\left\{v \in V_{2}:\left\{v_{1}, v_{2}, \ldots, v_{s}\right\} \subseteq N_{H}(v)\right\} .
$$

Since $H$ is linear, if there an edge containing $\{a, b\}$, then $\{a, b\}$ is contained in a unique edge of $H$, denoted by $e_{a b}$. Clearly, if $v_{0} \in N_{V_{2}}\left(v_{1}, v_{2}, \ldots, v_{s}\right)$, then $e_{v_{0} v_{1}}, e_{v_{0} v_{2}}, \ldots, e_{v_{0} v_{s}}$ are mutually distinct edges as $H$ is hm-bipartite. If $v_{0}, v_{0}^{\prime} \in N_{V_{2}}\left(v_{1}, v_{2}, \ldots, v_{s}\right)$, then $e_{v_{0} v_{1}}, e_{v_{0} v_{2}}, \ldots, e_{v_{0} v_{s}}, e_{v_{0}^{\prime} v_{1}}, e_{v_{0}^{\prime} v_{2}}, \ldots, e_{v_{0}^{\prime} v_{s}}$ are mutually distinct edges which form a $\mathcal{B}_{r}\left(K_{s, 2}\right)$ as $H$ is hm-bipartite; Otherwise, it may be assumed that $e_{v_{0} v_{1}}=e_{v_{0}^{\prime} v_{1}}:=e$, then $e, e_{v_{0} v_{2}}, e_{v_{0}^{\prime} v_{2}}$ would form a $\mathcal{B}_{r}\left(C_{3}\right)$; a contradiction to the assumption on $H$.

Now, consider the number of the pair

$$
\left\{\left(v_{0},\left\{v_{1}, v_{2}, \ldots, v_{s}\right\}\right): v_{0} \in V_{2},\left\{v_{1}, v_{2}, \ldots, v_{s}\right\} \subseteq N_{H}\left(v_{0}\right)\right\}
$$

By a simple double counting, noting that $H$ is hm-bipartite and $\mathcal{B}_{r}\left(K_{s, t}\right)$-free, if $m \geq s$,

$$
\sum_{v \in V_{2}}\binom{d(v)}{s} \leq(t-1)\binom{m}{s}
$$

By Lemma 2.6, we have

$$
(r-1) e(H)=\sum_{v \in V_{2}} d(v) \leq(t-1)^{\frac{1}{s}} m n^{1-\frac{1}{s}}+(s-1) n
$$

If $m \leq s-1$, surely $H$ is $\mathcal{B}_{r}\left(K_{s, t}\right)$-free. The Eq. (3.2) also holds by using the following claim.

Claim 1. Let $H$ be an $(m, n)$-hm-bipartite $B_{r}\left(C_{3}\right)$-free linear r-uniform hypergraph. Then

$$
e(H) \leq \frac{m n}{r-1}
$$

Proof of Claim 1. Using double counting, consider the pair

$$
\left\{(w,\{u, v\}): w \in V_{1},\{u, v\} \in\binom{N_{V_{2}}(w)}{2}\right\} .
$$

When fix a $w \in V_{1}$, the number of sets $\{u, v\} \in\binom{N_{V_{2}}(w)}{2}$ is $\binom{(r-1) d(w)}{2}$. When fix a set $\{u, v\} \in\binom{V_{2}}{2}$, the number of vertices $w \in V_{1}$ satisfying $u \in N(v)$ and $\{u, v\} \in\binom{N_{V_{2}}(w)}{2}$ is exactly 1 , as $H$ is linear, hm-bipartite and $\mathcal{B}_{r}\left(C_{3}\right)$-free; the number of vertices $w \in V_{1}$ satisfying $u \notin N(v)$ and $\{u, v\} \in\binom{N_{V_{2}}(w)}{2}$ is at most $m$. So,

$$
\begin{equation*}
\sum_{w \in V_{1}}\binom{(r-1) d(w)}{2} \leq\binom{ r-1}{2} e(H)+m\left(\binom{n}{2}-\binom{r-1}{2} e(H)\right) \tag{3.3}
\end{equation*}
$$

Since $\binom{x}{2}$ is a convex function in $x$, we have

$$
\begin{align*}
\sum_{w \in V_{1}}\binom{(r-1) d(w)}{2} & \geq m\binom{\left(\sum_{w \in V_{1}}(r-1) d(w)\right) / m}{2}=m\binom{(r-1) e(H) / m}{2}  \tag{3.4}\\
& =\frac{(r-1)^{2} e(H)^{2}-(r-1) m e(H)}{2 m}
\end{align*}
$$

By Eqs. (3.3) and (3.4), we have

$$
e(H)^{2}+\left(\frac{r-2}{r-1} m^{2}-m\right) e(H)-\frac{m^{2} n(n-1)}{(r-1)^{2}} \leq 0
$$

which implies

$$
e(H) \leq \frac{m n}{r-1} \leq \frac{s-1}{r-1} n
$$

and the upper bound in Eq. (3.2).

Theorem 3.5. Let $H$ be an $(m, n)$-hm-bipartite exact $\mathcal{B}_{r}\left(K_{s, t}\right)$-free linear r-uniform hypergraph with an hm-bipartition $V(H)=V_{1} \cup V_{2}$ satisfying $\left|V_{1}\right|=m,\left|V_{2}\right|=n$, where $s \geq 2, t \geq 2$. Suppose further that $H$ is $\mathcal{B}_{r}\left(C_{3}\right)$-free. Then for $k=0,1, \ldots, t-2$,

$$
\begin{equation*}
e(H) \leq \frac{(t-k-1)^{\frac{1}{s}}}{r-1} m n^{1-\frac{1}{s}}+\frac{s-1}{r-1} n^{1+\frac{k}{s}}+k m . \tag{3.5}
\end{equation*}
$$

Proof. We will use induction on $k$. For $k=0$, the assertion is given by Lemma 3.4. Suppose $k \geq 1$ and assume the assertion true for all $k^{\prime}<k$.

For any vertex $u \in V_{2}$, write $N_{V_{1}}(u)=N_{H}(u) \cap V_{1}$ and set

$$
H_{u}:=H\left[N_{V_{1}}(u) \cup V_{2} \backslash\{u\}\right] .
$$

Clearly, $d(u)=\left|N_{V_{1}}(u)\right|$ as $H$ is linear and hm-bipartite. Further $H_{u}$ is an $(d(u), n-$ 1)-hm-bipartite $\mathcal{B}_{r}\left(K_{s, t-1}\right)$-free linear $r$-uniform hypergraph and is also $\mathcal{B}_{r}\left(C_{3}\right)$-free; otherwise, $H$ would contain a $\mathcal{B}_{r}\left(K_{s, t}\right)$.

Note that $k \geq 1$ and hence $t-1 \geq 2$. By the induction assumption applied for $t-1$ and $k-1$ in $H_{u}$,

$$
\begin{align*}
e\left(H_{u}\right) & \leq \frac{(t-k-1)^{\frac{1}{s}}}{r-1} d(u)(n-1)^{1-\frac{1}{s}}+\frac{s-1}{r-1}(n-1)^{1+\frac{k-1}{s}}+(k-1) d(u)  \tag{3.6}\\
& \leq \frac{(t-k-1)^{\frac{1}{s}}}{r-1} d(u) n^{1-\frac{1}{s}}+\frac{s-1}{r-1} n^{1+\frac{k-1}{s}}+(k-1) d(u) .
\end{align*}
$$

On the other hand, as $H$ is hm-bipartite,

$$
\begin{equation*}
e\left(H_{u}\right)=e\left(H\left[N_{V_{1}}(u) \cup V_{2}\right]\right)-d(u)=\sum_{v \in N_{V_{1}}(u)} d(v)-d(u) . \tag{3.7}
\end{equation*}
$$

Thus, By Eqs. (3.6) and (3.7),

$$
\begin{equation*}
\sum_{v \in N_{V_{1}}(u)} d(v) \leq \frac{(t-k-1)^{\frac{1}{s}}}{r-1} d(u) n^{1-\frac{1}{s}}+\frac{s-1}{r-1} n^{1+\frac{k-1}{s}}+k d(u) \tag{3.8}
\end{equation*}
$$

Summing Eq. (3.8) for all $u \in V_{2}$, and noting that $\sum_{u \in V_{2}} d(u)=(r-1) e(H)$, we get

$$
\begin{aligned}
\sum_{u \in V_{2}} \sum_{v \in N_{V_{1}}(u)} d(v) & \leq \frac{(t-k-1)^{\frac{1}{s}}}{r-1}\left(\sum_{u \in V_{2}} d(u)\right) n^{1-\frac{1}{s}}+\frac{s-1}{r-1} n^{2+\frac{k-1}{s}}+k\left(\sum_{u \in V_{2}} d(u)\right) \\
& =(t-k-1)^{\frac{1}{s}} n^{1-\frac{1}{s}} e(H)+\frac{s-1}{r-1} n^{2+\frac{k-1}{s}}+k(r-1) e(H),
\end{aligned}
$$

Meanwhile,

$$
\begin{aligned}
\sum_{u \in V_{2}} \sum_{v \in N_{V_{1}}(u)} d(v) & =\sum_{v \in V_{1}} \sum_{u \in N_{V_{2}}(v)} d(v)=(r-1) \sum_{v \in V_{1}} d(v)^{2} \\
& \geq \frac{(r-1)\left(\sum_{v \in V_{1}} d(v)\right)^{2}}{m}=\frac{(r-1) e(H)^{2}}{m} .
\end{aligned}
$$

Therefore,

$$
e(H)^{2}-\left(\frac{(t-k-1)^{\frac{1}{s}}}{r-1} m n^{1-\frac{1}{s}}+k m\right) e(H)-\frac{(s-1) m n^{2+\frac{k-1}{s}}}{(r-1)^{2}} \leq 0
$$

So,

$$
\begin{aligned}
e(H) & \leq \frac{(t-k-1)^{\frac{1}{s}}}{r-1} m n^{1-\frac{1}{s}}+k m+\frac{\frac{(s-1) m n^{2+\frac{k-1}{s}}}{(r-1)^{2}}}{\frac{(t-k-1)^{\frac{1}{s}}}{r-1} m n^{1-\frac{1}{s}}+k m} \\
& =\frac{(t-k-1)^{\frac{1}{s}}}{r-1} m n^{1-\frac{1}{s}}+k m+\frac{(s-1) n^{2+\frac{k-1}{s}}}{(r-1)\left((t-k-1)^{\frac{1}{s}} n^{1-\frac{1}{s}}+k(r-1)\right)} \\
& \leq \frac{(t-k-1)^{\frac{1}{s}}}{r-1} m n^{1-\frac{1}{s}}+k m+\frac{s-1}{r-1} n^{1+\frac{k}{s}},
\end{aligned}
$$

where the first inequality applies Fact $\mathbb{1}(2)$. The result now follows.
The right-hand side of the inequality (3.5) is very interesting, and the key is to see how much $k$ is taken to minimize the right-hand side of the inequality. For more details, one can refer to [29]. If $2 \leq s \leq t$, letting $k=s-2$, we obtain the following corollary.

Corollary 3.6. Let $H$ be an $(m, n)$-hm-bipartite exact $B_{r}\left(K_{s, t}\right)$-free linear r-uniform hypergraph with an hm-bipartition $V(H)=V_{1} \cup V_{2}$ satisfying $\left|V_{1}\right|=m,\left|V_{2}\right|=n$, where $2 \leq s \leq t$. Suppose further that $H$ is $B_{r}\left(C_{3}\right)$-free, then

$$
e(H) \leq \frac{(t-s+1)^{\frac{1}{s}}}{r-1} m n^{1-\frac{1}{s}}+\frac{s-1}{r-1} n^{2-\frac{2}{s}}+(s-2) m .
$$

Now we are arriving at the main result in this subsection.
Theorem 3.7. Let $H$ be a $\left\{\mathcal{B}_{r}\left(K_{s, t}\right), \mathcal{B}_{r}\left(C_{3}\right)\right\}$-free linear r-uniform hypergraph on $n$ vertices, where $2 \leq s \leq t$. If $s=2$, then

$$
\rho(H) \leq \frac{\sqrt{4(t-1)(n-1)+(r-t)^{2}}+r-t}{2(r-1)}
$$

If $s \geq 3$, then

$$
\rho(H) \leq \frac{(t-s+1)^{\frac{1}{s}}}{r-1} n^{1-\frac{1}{s}}+\frac{s-1}{r-1} n^{1-\frac{2}{s}}+s-2 .
$$

Proof. First consider the case of $s=2$. For any $u \in V(H)$, using double counting on the following set of pairs:

$$
\left\{(v, w): v \in N(u), w \in N^{2}(u) \cap N(v)\right\}
$$

and noting that $H$ is linear and $\left\{\mathcal{B}_{r}\left(K_{2, t}\right), \mathcal{B}_{r}\left(C_{3}\right)\right\}$-free, we have

$$
\sum_{v \in N(u)}(r-1)(d(v)-1) \leq(t-1)(n-1-(r-1) d(u))
$$

that is

$$
\sum_{v \in N(u)} d(v) \leq(r-t) d(u)+\frac{(t-1)(n-1)}{r-1}
$$

By Corollary 2.5, we get

$$
\rho^{2}(H)-\frac{r-t}{r-1} \rho(H)-\frac{(t-1)(n-1)}{(r-1)^{2}} \leq 0 .
$$

So,

$$
\rho(H) \leq \frac{\sqrt{4(t-1)(n-1)+(r-t)^{2}}+r-t}{2(r-1)} .
$$

Next we consider the case of $s \geq 3$. For any $u \in V(H)$, set $H(u):=H\left[N_{H}(u), N_{H}^{2}(u)\right]$. Obviously $H(u)$ is an hm-bipartite $\mathcal{B}_{r}\left(C_{3}\right)$-free linear $r$-uniform hypergraph with the head part $N_{H}(u)$ and the mass part $N_{H}^{2}(u)$. Furthermore, $H(u)$ is exact $\mathcal{B}_{r}\left(K_{s, t-1}\right)$-free; otherwise $H$ contains a subhypergraph in $\mathcal{B}_{r}\left(K_{s, t}\right)$. Note that $\left|N_{H}(u)\right|=(r-1) d(u)=$ : $n_{1},\left|N_{H}^{2}(u)\right|=: n_{2} \leq n-1-(r-1) d(u)$. So, $H(u)$ is an $\left(n_{1}, n_{2}\right)$-hm-bipartite exact $\mathcal{B}_{r}\left(K_{s, t-1}\right)$-free $r$-uniform hypergraphs. As $t \geq s \geq 3$, by Theorem 3.5, for every $0 \leq k \leq t-3$,

$$
\begin{aligned}
e(H(u)) & \leq \frac{(t-k-2)^{\frac{1}{s}}}{r-1} n_{1} n_{2}^{1-\frac{1}{s}}+\frac{s-1}{r-1} n_{2}^{1+\frac{k}{s}}+k n_{1} \\
& \leq\left((t-k-2)^{\frac{1}{s}} n^{1-\frac{1}{s}}+k(r-1)\right) d(u)+\frac{s-1}{r-1} n^{1+\frac{k}{s}} .
\end{aligned}
$$

Meanwhile, $e(H(u))=\sum_{v \in N_{H}(u)} d(v)-(r-1) d(u)$. Thus,

$$
\sum_{v \in N_{H}(u)} d(v) \leq\left((t-k-2)^{\frac{1}{s}} n^{1-\frac{1}{s}}+(k+1)(r-1)\right) d(u)+\frac{s-1}{r-1} n^{1+\frac{k}{s}}
$$

By Corollary 2.5,

$$
\rho^{2}(H)-\frac{(t-k-2)^{\frac{1}{s}} n^{1-\frac{1}{s}}+(k+1)(r-1)}{r-1} \rho(H)-\frac{s-1}{(r-1)^{2}} n^{1+\frac{k}{s}} \leq 0 .
$$

Using Fact [1, we get

$$
\begin{aligned}
\rho(H) & \leq \frac{(t-k-2)^{\frac{1}{s}} n^{1-\frac{1}{s}}+(k+1)(r-1)}{r-1}+\frac{\frac{s-1}{(r-1)^{2}} n^{1+\frac{k}{s}}}{\frac{(t-k-2)^{\frac{1}{s}} n^{1-\frac{1}{s}}+(k+1)(r-1)}{r-1}} \\
& \leq \frac{(t-k-2)^{\frac{1}{s}} n^{1-\frac{1}{s}}}{r-1}+\frac{s-1}{r-1} n^{\frac{k+1}{s}}+k+1 .
\end{aligned}
$$

Setting $k=s-3$, we get the desired result.
It is known that for an $r$-uniform hypergraph $H$ on $n$ vertices,

$$
\rho(H) \geq \frac{r e(H)}{n}
$$

where the right side of the inequality is the average degree of $H$. We obtain the following corollary immediately.

Corollary 3.8. For $t \geq 2$,

$$
\operatorname{ex}_{r}^{\text {lin }}\left(n,\left\{\mathcal{B}_{r}\left(K_{2, t}, \mathcal{B}_{r}\left(C_{3}\right)\right)\right\}\right) \leq \frac{\sqrt{4(t-1)(n-1)+(r-t)^{2}}+r-t}{2 r(r-1)} n ;
$$

and for $3 \leq s \leq t$,

$$
\operatorname{ex}_{r}^{\text {lin }}\left(n,\left\{\mathcal{B}_{r}\left(K_{s, t}, \mathcal{B}_{r}\left(C_{3}\right)\right)\right\}\right) \leq \frac{(t-s+1)^{\frac{1}{s}}}{r(r-1)} n^{2-\frac{1}{s}}+\frac{s-1}{r(r-1)} n^{2-\frac{2}{s}}+\frac{s-2}{r} n .
$$

When considering $\mathcal{B}_{r}\left(K_{s, t}\right)$-free linear hypergraphs $H$ with removal of condition of $\mathcal{B}_{r}\left(C_{3}\right)$-free, the upper bound of $\rho(H)$ would become larger. But can the asymptotic term be left unchanged? We pose the following problem:

Problem 1. For $2 \leq s \leq t$, does the following inequality hold?

$$
\operatorname{spex}_{r}^{l i n}\left(n, \mathcal{B}_{r}\left(K_{s, t}\right)\right) \leq \frac{(t-s+1)^{\frac{1}{s}}}{r-1} n^{1-\frac{1}{s}}+o\left(n^{1-\frac{1}{s}}\right)
$$
