# Conformally related vacuum gravitational waves and their symmetries

# Abstract

A special conformal transformation which carries a vacuum gravitational wave into another vacuum one is built by using Möbius-redefined time. It can either transform a globally defined vacuum wave into a vacuum sandwich wave, or carry the gravitational wave into itself. The first type, illustrated by linearly and circularly polarized vacuum plane gravitational waves, permutes the symmetries and the geodesics. Our pp waves with conformal  $O(2, 1)$  symmetry of the second type, which seem to have escaped attention so far, are anisotropic generalizations of the familiar inversesquare profile. An example inspired by molecular physics, for which the particle can escape, or perform periodic motion, or fall into the singularity is studied in detail.

# <span id="page-1-0"></span>I. INTRODUCTION

We consider special class of gravitational wave (GW) space-times whose metric is written in Brinkmann coordinates [\[1\]](#page-29-2) as,

ds^{2} = dX^{2} + dY^{2} + 2dUdV - 2H(U, \mathbf{X}) dU^{2}. \qquad (I.1)
$$

Here  $U$  and  $V$  are light-cone coordinates,  $X$  and  $Y$  represent the transverse plane and  $H(U, \mathbf{X})$  is the wave profile. Brinkmann space-times are smooth Lorentz manifolds endowed with a covariantly constant null Killing vector field  $\xi = \partial_V [2]$  $\xi = \partial_V [2]$ . Such structures arised before in the study of the one-parameter central extension of the Galilei group [\[3\]](#page-30-0) called the Bargmann group [\[4\]](#page-30-1). In the proposed Kaluza-Klein-type "Bargmann" framework [\[2,](#page-29-3) [4–](#page-30-1)[6\]](#page-30-2) the motions in ordinary space are obtained by projecting out the "vertical" null direction along the coordinate  $V$  and identifying the other null coordinate,  $U$ , with Newtonian time. The profile  $H(U, \mathbf{X})$  is the Newtonian potential  $[2, 5, 6]$  $[2, 5, 6]$  $[2, 5, 6]$  $[2, 5, 6]$  $[2, 5, 6]$ .

An insight is provided by the so-called memory effect  $[7-11]$  $[7-11]$  which amounts to studying test particles initially at rest by using the symmetries of the corresponding background space-time. It is particularly convenient to use conformal symmetries  $[12-17]$  $[12-17]$  generated by conformal Killing vectors (CKV) ,

where  $\psi$  is a smooth function of the coordinates [\[18–](#page-31-1)[22\]](#page-31-2). In flat Minkowski space-time, the conformal Lie algebra of CKVs is 15 dimensional. The same number of dimensions arises for conformally flat space-times, which include, in addition to Minkowski space-time, also that for oscillator and for a linear potential  $[2, 5, 23-28]$  $[2, 5, 23-28]$  $[2, 5, 23-28]$  $[2, 5, 23-28]$  $[2, 5, 23-28]$ .

The maximal number of symmetries of a non-conformally-flat space-time is 7 [\[20](#page-31-5)[–22\]](#page-31-2). Their research is simplified when the space-time is conformally related to one whose symmetries are known, and therefore the CKVs are interchanged. This happens, in particular, for the time redefinition  $(II.1)$  below, proposed in  $[22, 29]$  $[22, 29]$  $[22, 29]$ .

In this paper we study a special time-redefined conformal transformation which (i) either interchanges two vacuum GWs (as illustrated by linearly polarized plane GWs (LPP) and circularly polarized vacuum plane GWs (CPP) [\[30](#page-31-7)[–32\]](#page-32-0), or (ii) leaves the wave form-invariant (Secs. [III](#page-4-0) and [IV\)](#page-11-0) as illustrated by a special gravitational wave inspired by the anisotropic  $O(2, 1)$  invariant field of a polar molecule [\[33–](#page-32-1)[35\]](#page-32-2).

# <span id="page-2-0"></span>II. CONFORMAL TRANSFORMATIONS OF GRAVITATIONAL WAVES

The GW space-time,  $ds^2$  in [\(I.1\)](#page-1-1), can be transformed into another GW,  $d\tilde{s}^2$ , by a special conformal transformation with redefined time  $f(\widetilde{U})$  [\[22,](#page-31-2) [29\]](#page-31-6),

where  $(\hat{\cdot})$  means  $d/d\tilde{U}$ . The corresponding conformal relation is,

where  $\mathcal{S}_{\tilde{U}}(f)$  is the Schwarzian derivative,

The vacuum condition for a pp-wave space-time [\(I.1\)](#page-1-1) requires the Ricci tensor to vanish,  $R_{\mu\nu} = 0$ , which implies that

This condition involves only the spatial behavior of the wave profile.

The conformally related wave profile  $\widetilde{H}$  in [\(II.4\)](#page-3-0) satisfies the vacuum condition [\(II.6\)](#page-3-1) if the Schwarzian derivative term vanishes [\[28,](#page-31-4) [32\]](#page-32-0) which implies in turn Möbius-redefined time [\[36\]](#page-32-3),

completed into a special Möbius conformal transformation (SMCT),

A, B, C and D here are arbitrary constants such that  $AD - BC \neq 0$ . Under such a redefinition the metric [\(II.3\)](#page-3-0) becomes,

The new wave profile  $(II.9)$  is in general different from the initial one in  $(I.1)$  and approximates realistic situations: the particle is transformed into one which moves in a sandwich wave with a short wave zone  $[U_i, U_j]$  outside of which the space-times is flat [\[14,](#page-30-7) [15,](#page-30-8) [37–](#page-32-4)[43\]](#page-33-0), further studied in Secs. [III](#page-4-0) and [IV.](#page-11-0)

#### <span id="page-4-0"></span>III. CONFORMALLY RELATED VACUUM GRAVITATIONAL WAVES

In this section, we focus our attention at vacuum plane GWs with line element

where the arbitrary functions  $\alpha(U)$  and  $\gamma(U)$  correspond to the "+" and " $\times$ " polarization modes. These waves are taken conformally into an approximate sandwich form [\(II.9\)](#page-3-2) by [\(II.7\)](#page-3-3)-[\(II.8\)](#page-3-4) [\[14,](#page-30-7) [15,](#page-30-8) [40,](#page-32-5) [42,](#page-32-6) [44\]](#page-33-1) with profile function

where  $\tilde{\alpha}(\tilde{U}) = \alpha[f(\tilde{U})]$  and  $\tilde{\gamma}(\tilde{U}) = \gamma[f(\tilde{U})]$ . The new GWs include two classes which correspond to different choices of the coefficients  $A, B, C$  and  $D, C = 0$  means a dilation and a U-translation of the original GWs which does not bring any new insight and will therefore not considered in what follows.  $C \neq 0$  introduces in turn a new, rationally-redefined scale factor. In terms of the redefined parameters  $\rho = C/\sqrt{AD - BC}$  and  $\delta = D/C$  which determine the width and the center of the new GW shown in FIG. [1,](#page-5-0) the conformal factor can be presented as

$$
\Omega^4 = \frac{1}{\left[\rho(U+\delta)\right]^4} \,. \tag{III.3}

Apart of focusing and shifting, the parameters  $\rho$  and  $\delta$  do not change the trajectory. Choosing  $\rho = 1$  and  $\delta = 0$  for the sake of simplicity,

generates the special rational transformation [\[22,](#page-31-2) [45\]](#page-33-2),

Eqns  $(2.10)$  and Eq.  $(2.11)$  of Andrzejewski and al.  $\left|44, 45\right|$  are also similar, except for that their profiles tend, unlike ours, to a Dirac delta. The Möbius mapping SMCT [\(II.7\)](#page-3-3)- [\(II.8\)](#page-3-4) shown in FIG[.1](#page-5-0) shrinks a globally defined GW into one concentrated around a single point which then behaves as an approximate sandwich wave [\[14,](#page-30-7) [15,](#page-30-8) [40,](#page-32-5) [42,](#page-32-6) [44\]](#page-33-1).

Eqn. [\(III.5\)](#page-4-1) is in fact the oscillator counterpart of the conformal transformation applied to planetary motion with a time-dependent gravitational constant, proposed by Dirac [\[2,](#page-29-3) [46\]](#page-33-3).

Keane and Tupper [\[22\]](#page-31-2) noted in particular that [\(III.5\)](#page-4-1) allows us to obtain a conformally related "dual" space-time. Our Möbius-redefined time and SMCT [\(II.7\)](#page-3-3)-[\(II.8\)](#page-3-4) have this property also, since the inverse transformation is identical to the original one.

The general vacuum GWs in [\(III.1\)](#page-4-3) admit Killing vectors of the form

where the two-vector  $\boldsymbol{\beta} = (\beta_i)$  satisfies the vectorial Sturm-Liouville equation [\[47,](#page-33-4) [48\]](#page-33-5):

Here  $\dot{\left( \cdot \right)}$  means  $d/dU$ .

The remarkable fact is that equation is indeed identical to the equations of motion satisfied by the transverse coordinates  $X(U)$  [\[49\]](#page-33-6). Thus once we know the specific form of the Killing vector [\(III.6\)](#page-5-3), we obtain an analytical geodesic and vice versa.

The transformation  $(II.7)$ - $(II.8)$ , carries the Killing vector  $(III.6)$  into:

satisfies the transverse equations of motion for the conformally related GW [\(III.2\)](#page-4-4),

Below we illustrate our point by two vacuum GWs, one linearly polarized, and the other circularly polarized. Both are globally defined and have a 7-dimensional symmetry algebra. Then we study how their symmetries and geodesics change under the transformation [\(III.5\)](#page-4-1).

# <span id="page-6-0"></span>A. Conformally related linearly polarized vacuum GWs

1. The simplest globally defined linearly polarized vacuum GW (LPP) of Brdicka [\[50\]](#page-33-7), whose metric is,

Its CKV are obtained by solving the conformal Killing equations,

Here  $\eta$ ,  $\epsilon$ ,  $\rho$ ,  $\delta_i$  and  $\beta_i$  are arbitrary constants which generate time-translations,  $\widehat{E}$ , vertical-translations, N, dilations, D, space-translations,  $P_i$ , and boosts  $G_i$ , respectively. These symmetries span the 7-dimensional homothetic algebra  $\mathcal{E}_7$ ,

We note that the  $g_L$ -terms in [\(III.12\)](#page-6-1) can be collected into

$$
\mathbf{g}_L \cdot \partial_{\mathbf{X}} - \dot{\mathbf{g}}_L \mathbf{X} \cdot \partial_V \,. \tag{III.15}

which is [\(III.6\)](#page-5-3). Thus [\(III.13\)](#page-6-2) yield also analytical solutions for the corresponding geodesics.

2. The conformal transformation [\(III.5\)](#page-4-1) carries the Brdicka wave [\(III.11\)](#page-6-3) into a rational LPP with damped profile,

whose CKVs can be obtained either directly or by the conformal transformation [\(III.5\)](#page-4-1),

Note that the  $\tilde{g}_L$ -terms in [\(III.17\)](#page-7-0) fit also into [\(III.8\)](#page-5-4), therefore [\(III.18\)](#page-7-1) is an analytically-found geodesics in the rational LPP GW space-time.

The parameters represent the same symmetries as in the Brdicka case, except for  $\eta$ which becomes a special Killing vector (SCKV) identified as an expansion  $\widehat{K},$

\widehat{K} = U^2 \partial_U - \frac{1}{2} \mathbf{X}^2 \partial_V + U \mathbf{X} \cdot \partial_\mathbf{X},

which acts as a redefined-time translation  $\widehat{E} = \partial_U$ . The commutation relations are,

Thus the algebra  $\mathcal{E}_7 \supset \mathcal{G}_6$  for the Brdicka GW [\(III.11\)](#page-6-3) is transformed, for the rationaltime LPP GW [\(III.16\)](#page-7-2), into

Here  $S, \mathcal{E}, \mathcal{G}$  are the special conformal algebra, homothetic algebra and isometric algebra generators, respectively. The subscripts indicate the dimension of the algebra. The commutation relations do not change even if the CKV do [\[22,](#page-31-2) [51\]](#page-33-8).

3. The circularly polarized (CPP) GW has line element

where  $\omega$  is an arbitrary constant frequency. The corresponding CKVs were studied, e.g., in [\[16,](#page-30-9) [31\]](#page-32-7) :

represent also the analytic geodesics in the CPP GW space-time. Here  $\omega_{\pm}$  = √  $\omega^2\pm 1$ and  $\mathcal{D}_U$  is the bilinear derivative  $\mathcal{D}_U(f \cdot g) = g \frac{df}{dU} - f \frac{dg}{dU}$ .

The parameters  $\eta$ ,  $\rho$ ,  $\epsilon$ ,  $\delta_i$  and  $\beta_i$  generate "screw" symmetries  $\hat{S}$  [\[31\]](#page-32-7), namely dilations D, vertical-translations N, space-translations  $P_i$ , and boosts  $G_i$ , respectively, span a 7-d homothetic algebra  $\mathcal{E}_7 \supset \mathcal{G}_6$  [\[16\]](#page-30-9).

4. Inserting [\(III.5\)](#page-4-1) into [\(III.22\)](#page-7-3) yields the rational CPP GW whose line element is,

are also analytical geodesics in the rational CPP GW space-time.

Here the parameters  $\rho$ ,  $\epsilon$ ,  $\delta_i$ ,  $\beta_i$  represent the same symmetries as for the CPP wave, — except for  $\eta$ , which is a new special symmetry denoted by  $\widehat{S}_K$ ,

which corresponds to Eq.  $\#$  (147) of Keane and Tupper in Ref. [\[22\]](#page-31-2). Its geometric meaning is obtained by integrating the Killing vector [\(III.32\)](#page-9-1). We just present its space part,

where  $X_0$ ,  $Y_0$  and  $U_0$  are initial positions. It describes a "growing screw" whose size increases linearly with  $U$  while its frequency decreases as shown in FIG. [2.](#page-10-0)

A similar "screw" has also been found for planetary motions with for time-dependent gravitational constant in Newtonian gravity [\[2,](#page-29-3) [46\]](#page-33-3).

## <span id="page-9-0"></span>B. Gedesics, found numerically and analytically

Now we compare the how geodesics change under applying the transformation [\(III.5\)](#page-4-1).

1. Numerical solutions are shown in FIG. [3](#page-11-1) for the LPP GW of Brdicka, [\(III.11\)](#page-6-3), and for the *rational LPP* [\(III.16\)](#page-7-2). Analytic solutions are obtained in turn in [\(III.13\)](#page-6-2) for the Brdicka GW, and a piecewise function for the rational LPP GW is in turn,

These solutions plotted in FIG. [4](#page-12-0) should be compared with the numerical ones in FIG[.3.](#page-11-1)

2. The geodesics of both the usual CPP GW [\(III.22\)](#page-7-3) and the rational-time CPP GW [\(III.27\)](#page-8-0) perform screw-like motions. FIG. [5](#page-13-0) compares these two numerically-obtained geodesics.

On the other hand, [\(III.24\)](#page-8-1) is an analytically found geodesic for the CPP GW space-time [\(III.22\)](#page-7-3) which follows the same trajectory as  $5(a)$  when the parameters are chosen  $\omega = 1.5, \, \delta_1 = 0, \, \delta_2 = 0, \, \beta_1 = 0$  and  $\beta_2 = 5.$

plotted in FIG. [6](#page-13-2) which should be compared with the numerical solution in FIG[.5\(b\).](#page-13-3) In FIG. [7](#page-14-0) we show the variations of the velocities in FIG. [6](#page-13-2) on X and Y directions.

# <span id="page-11-0"></span>IV. O(2, 1)-CONFORMALLY INVARIANT GRAVITATIONAL WAVES

In the previous section we discussed vacuum GWs that are carried into another vacuum GW by the special Möbius transformation  $(II.7)-(II.8)$  $(II.7)-(II.8)$  $(II.7)-(II.8)$ . In this section we consider a special

vacuum GWs which are invariant.

We start by completing  $(II.7)$  by the well-known  $\xi$ -preserving conformal transformations of the conformal Killing equations in the free Minkowski metric in  $2 + 1$  dimensions,  $(1.1)$ with  $H = 0$ . We get three special transformations, namely,

which generate an  $O(2, 1)$  conformal group.

The  $O(2, 1)$  symmetry has been considered in various physical instances:

the Galilei to the Schrödinger algebra [\[52\]](#page-33-9). All Schrödinger-symmetric systems are derived, in  $d \geq 3$  space dimensions, from the vanishing of the Weyl [\[53\]](#page-33-10) or in in  $d = 1$ from that of the Cotton tensor [\[54\]](#page-34-2), respectively.

- An inverse-square potential could be added  $[4, 52-59]$  $[4, 52-59]$  $[4, 52-59]$ . Applications include the interaction of a polar molecule with an electron [\[33,](#page-32-1) [35\]](#page-32-2) (which will be discussed further in subsec[.V\)](#page-16-0), the Efimov effect  $[35, 60]$  $[35, 60]$  $[35, 60]$ , near-horizon fields of black holes  $[34, 35, 61]$  $[34, 35, 61]$  $[34, 35, 61]$  $[34, 35, 61]$  $[34, 35, 61]$  and the vacuum AdS/CFT correspondence [\[35,](#page-32-2) [62,](#page-34-6) [63\]](#page-34-7) ;
- A Dirac-monopole and a magnetic vortex [\[64,](#page-35-0) [65\]](#page-35-1).

Hence we focus our attention at vacuum gravitational waves with  $O(2, 1)$  symmetry. For symplicity, we focus our investigations to the planar case with coordinates  $X, Y$ . Substituting the three vectors in  $(IV.2a)-(IV.2c)$  $(IV.2a)-(IV.2c)$  $(IV.2a)-(IV.2c)$  into the conformal Killing equation  $(1.2)$  for the Brinkmann metric [\(I.1\)](#page-1-1) leaves us with,

Note that  $(IV.4b)$  and  $(IV.4c)$  differ only in the coefficients of their first terms – which involves the generator of time translation symmetry, [\(IV.4a\)](#page-14-3).

Solving these equations with the vacuum condition [\(II.6\)](#page-3-1) yields, for an exact plane wave, the line element,

where  $R^2 = X^2 + Y^2$ ;  $C_1$  and  $C_2$  are arbitrary constants. The proof follows at once from that dilatation symmetry  $(IV.4b)$ , combined with time-translation-invariance  $(IV.4a)$  imply indeed, by Euler's formula, that the potential is homogeneous of order  $(-2)$ .

The potential [\(IV.5\)](#page-15-0) breaks the rotational symmetry, however still allows for the conformal  $O(2, 1)$  symmetry of the inverse-square potential  $[2, 4, 58]$  $[2, 4, 58]$  $[2, 4, 58]$  $[2, 4, 58]$  $[2, 4, 58]$  to the anisotropic case. It should be compared to the statement [\[53,](#page-33-10) [54\]](#page-34-2) which says that the profiles of the only Bargmann manifolds with *Schrödinger* symmetry correspond, in  $3+1$  dimensions, to an (i) isotropic oscillator, to an (ii) inverse-square potential with constant coefficient, to a (iii) uniform force field.

The special GW [\(IV.5\)](#page-15-0) satisfies, for an arbitrary linear combination of  $\widehat{E}$ ,  $\widehat{D}$ ,  $\widehat{K}$  in  $(IV.2a)-(IV.2c)$  $(IV.2a)-(IV.2c)$  $(IV.2a)-(IV.2c)$ , the conformal Killing equations  $(1.2)$  with,

The metric [\(IV.5\)](#page-15-0) is conveniently presented in cylindrical coordinates  $(R, \theta)$ ,

where the constant  $C$  is proportional to the product of the electric charge and the dipole momentum, and  $\theta$  is the polar angle in the  $X - Y$  plane.

## <span id="page-16-0"></span>V. A MOLECULAR PHYSICS-INSPIRED SPACETIME

In this section, we study a vacuum spacetime inspired by polar molecules represented by the anisotropic inverse-square potential  $\left|33, 34\right|$ ,

where  $C_1$  and  $C_2$  are real constants, cf. [\(IV.8\)](#page-15-2). Postponing the 3-dimensional problem to further study, we limit our attention at the plane. For simplicity, we put also the NR mass  $M = 1$ . The conformal Killing vectors in [\(IV.2a\)](#page-12-3)-[\(IV.2b\)](#page-12-5)-[\(IV.2c\)](#page-12-4) preserve the vertical vector  $\xi = \partial_V$  and therefore project to conformal symmetries of the underlying non-relativistic system providing us with three conserved quantities  $\left[4, 52, 57, 58\right]$  $\left[4, 52, 57, 58\right]$ ,

To explain in simple terms what happens, consider first dilations, [\(IV.2b\)](#page-12-5), which leave the Lagrange density  $L_0 dU$  of a free NR particle invariant provided the time scales with the square of the factor as the position does  $[52]$ . Then adding a potential H changes the Lagrange density by  $-HdU$ , which is also invariant if H is inverse-square in the radius [\[4,](#page-30-1) [58,](#page-34-8) [59\]](#page-34-3).

However dilations act only on the radial variable, therefore the potential  $(V.1)$  is left invariant. Then an easy calculation shows that the two other transformations in  $(IV.2)$ remain also unbroken. Remarkably, the associated "Noether" quantities were found by Jacobi [\[57\]](#page-34-9) . . . 60 years before Emmy Noether was born !

The Casimir operator of  $O(2, 1)$  is,

generate a compact  $SO(2)$  group of rotations, augmented with two non-compact two dimensional boosts. Here  $\tau$  is a positive fixed parameter with the dimension of time. See Ref. [\[65\]](#page-35-1) for details. The Casimir operator can also be written as,

The conserved quantity generated by translations along the V coordinate and interpreted as the mass of the underlying non-relativistic system [\[2,](#page-29-3) [4,](#page-30-1) [6\]](#page-30-2) was scaled to unity).

A lightlike particle in the special GW background [\(IV.5\)](#page-15-0) (viewed, in the Bargmann framework, as a massive non-relativistic particle in one dimension less) moves along null geodesics. In cylindrical coordinates,

Let us assume, for simplicity, that  $C_1 = 0$  so that the planar metric [\(IV.8\)](#page-15-2) has only one polarization state,

For  $C_2 = 0$  we get Minkowski-space which has no interest for us. Then  $C_2 > 0$  can be achieved by shifting  $\theta$ . Henceforth we set  $C_2 = 1$ .

The metric  $(V.8)$  is the "Bargmannian" form  $[2, 4, 6]$  $[2, 4, 6]$  $[2, 4, 6]$  $[2, 4, 6]$  $[2, 4, 6]$  of the anisotropic version of a NR particle in an inverse-square potential

shown in FIG[.8.](#page-18-0) Its anisotropy is manifest by realizing that for fixed  $R = R_0$ ,  $H(R, \theta)$  is proportional to  $\sin 2\theta$ .

The nature of the potential [\(V.8\)](#page-17-0) is determined by the sign of the coefficient of  $dU^2$  the potential of the underlying non-relativistic dynamics  $[2, 4]$  $[2, 4]$  $[2, 4]$  — which alternates at every quadrant. Its behavior is conveniently studied by plotting the force, FIG[.9:](#page-19-0) It is repulsive for  $0 < \theta < \pi/2$  and for  $\pi < \theta < 3\pi/2$ , and attractive for  $\pi/2 < \theta < \pi$  and for  $3\pi/2 < \theta < \pi$  $2\pi$ . The force is maximal on the separation "crosslines" at  $\theta = k\pi/2$ ,  $k = 0, 1, 2, 3$ , where the

repulsive potential becomes attractive and vice versa, cf. [\(V.9\)](#page-17-1). It is obviously symmetric w.r.t.  $\theta \to \theta + \pi$ .

A qualitative insight into the possible motions can be obtained by using the conformal  $o(2, 1)$  symmetry. For simplicity we restict our attention at what happens to a particle that we simply put at  $U = U_0$  to some position  $(R_0, \theta_0)$  with vanishing initial velocity. Then the conserved quantities [\(V.2\)](#page-16-2) generated by  $o(2, 1)$  reduce, putting  $M = 1, C_1 = 0, C_2 = 1$  for simplicity, to

From [\(V.10a\)](#page-18-1) we deduce that the conserved energy, which is initially just the potential, may be **positive**, negative or **zero**, corresponding to the repulsive or attractive quadrant or to the separation line between them, as depicted in FIG.s [8](#page-18-0) and [9.](#page-19-0)

1. In the repulsive quadrants  $0 < \theta < \pi/2$  or  $\pi < \theta < 3\pi/2$  the energy is positive,

$$
\mathcal{E} = \mathcal{E}_0 = \frac{\mathbf{P}^2}{2} + \frac{\sin 2\theta}{R^2} > 0 \Rightarrow \frac{\mathbf{P}^2}{2} > \left| \frac{\sin 2\theta}{R^2} \right|.
$$
 (V.11)

Thus the motion is outgoing. When the particle crosses the separation line and enters into the attractive area, the absolute value of negative potential is less than that of the initial potential: the particle will be pushed out to infinity.

2. In the attractive quadrants,  $\pi/2 < \theta < \pi$  or  $3\pi/2 < \theta < 2\pi$  the energy is negative,

$$
\mathcal{E} = \mathcal{E}_0 = \frac{\mathbf{P}^2}{2} + \frac{\sin 2\theta}{R^2} < 0 \Rightarrow \frac{\mathbf{P}^2}{2} < \left| \frac{\sin 2\theta}{R^2} \right| \,. \tag{V.12}
$$

Thus the kinetic energy is dominated by the potential energy, and we get incoming motion with the particle falling into the hole.

3. An intermediate behaviour is observed for vanishing energy when the initial position is on one of the a separation line between repulsive and attractive quadrants, i.e., for  $\theta_k = k \frac{\pi}{2}$  $\frac{\pi}{2}$ ,  $k = 0, 1, 2, 3$ : by [\(V.10a\)](#page-18-1) and [\(V.10b\)](#page-18-2) we have,

$$
\mathcal{E} = \mathcal{E}_0 = 0 \quad \text{and} \quad \mathcal{D} = \mathcal{D}_0 = -\mathbf{P} \cdot \mathbf{X} = 0. \tag{V.13}
$$

so that [\(V.10c\)](#page-18-3) implies that

In conclusion, a particle put on the "rim" will follow a circular trajectory inside the attractive region. Moreover, the vanishing of the energy,

implies that the particle oscillates between the "rims" of the attractive quadrants,

$$
\frac{\pi}{2} \le \theta \le \pi \quad \text{or} \quad \frac{3\pi}{2} \le \theta \le 2\pi. \tag{V.16}
$$

Numerical investigations indicate that the eqns  $(V.6)-(V.7)$  $(V.6)-(V.7)$  $(V.6)-(V.7)$  admit all three types of outgoing/infalling/bounded solutions. The first two are shown in FIG[.10,](#page-20-0) and the circularly

oscillating one in FIG[.11.](#page-21-0) The general behavior is summarised in FIG[.12.](#page-22-0)

Analytic solutions can be found also.

We first inquire about radial motions. Putting  $\theta = \theta_0 = \text{const.}$  into [\(V.6\)](#page-17-2)-[\(V.7\)](#page-17-2) yields,

$$
\frac{d^2R}{dU^2} - \frac{2\sin 2\theta_0}{R^3} = 0 \quad \text{and} \quad \frac{2\cos 2\theta_0}{R^4} = 0.
$$

The 2nd eqn requires  $\cos 2\theta_0 = 0$ , which implies,

leaving us with,

$$
\frac{d^2R}{dU^2} = \pm \frac{2}{R^3} \,,\tag{V.18}
$$

where the sign is positive in the repulsive,  $\ell = 0, 2$  case and is negative in the attractive,  $\ell = 1, 3$  one. Thus for  $\ell$  pair the particle is expulsed to infinity along the "crest", and for  $\ell$ odd it is sucked into the origin along the "bottom valley" which correspond to the maximally repulsive or maximally attractive directions in FIGs. [8](#page-18-0) and [9.](#page-19-0) The solution of the familiar inverse-cube force equation  $\left[4, 53, 58, 59\right]$  is,

$$
R(U) = \sqrt{(V_0 U + R_0)^2 \pm \frac{2U^2}{R_0^2}},
$$
\n
$$
(V.19)
$$

where  $R_0 > 0$  and  $V_0$  are the initial position resp. the initial velocity along the diagonal.  $V_0$  < 0 means falling towards the origin, and  $V_0 > 0$  moving outwards. Starting in the repulsive quadrant we have the plus sign and the particle can not reach the origin. In the attractive quadrant the motion is directed towards the origin; the solution becoming imaginary indicates that the particle has fallen into the hole.

The equations  $(V.6)-(V.7)$  $(V.6)-(V.7)$  $(V.6)-(V.7)$  admit also exact *circular*, *analytic solutions*. Let us indeed fix the radius,  $R(U) = R_0 = \text{const.}$  which reduces [\(V.6\)](#page-17-2)-[\(V.7\)](#page-17-2) to,

Deriving the first eqn. by  $U$  we get

$$
\frac{d\theta}{dU}\left(\frac{d^2\theta}{dU^2} + \frac{2C_2}{R_0^4}\cos 2\theta\right) = 0
$$

which is an identity when the 2nd equation is satisfied. The first equation in  $(V.20)$  then implies that

which admits real solutions when the sin is negative i.e. in the quadrants  $\pi/2 \leq \theta \pi$  and  $3\pi/2 \leq \theta 2\pi$  and is then solved in terms of elliptic integrals [\[66\]](#page-35-2),

where  $D$  is an integration constant. This formula can also be verified directly and is plotted in FIG[.13](#page-23-0) to be compared with the numerical solution in FIG[.11\)](#page-21-0).

This solution has zero-energy. Conversely [\[67\]](#page-35-3), for vanishing energy  $\mathcal{E} = 0$  the conserved quantity generated by dilations, [\(V.10b\)](#page-18-2) implies  $R = R_0 = \text{const.}$ , [\(V.14\)](#page-20-1). Then [\(V.2a\)](#page-16-3) becomes [\(V.15\)](#page-20-2) which for  $R = R_0$  is [\(V.21\)](#page-22-2) that we have just solved. In conclusion,  $o(2, 1)$ symmetry implies, for zero energy, motion on (part of) a circle.

Restoring the radius in the equations shows that the period increases proportionally to the its square,  $R_0^2$ ,

as seen in FIG. [14.](#page-24-1) Inserting  $\theta(U)$  from  $(V.22)$  into the conserved Casimir  $(V.5)$  we get, for  $C_1 = 0,$

On the other hand, the angular momentum for  $(V.22)$  is

whose square fixes the constant in  $(V.24)$  to vanish. The length of  $(V.25)$  thus oscillates as shown in FIG[.15,](#page-25-1) consistently with the breaking of the axial symmetry.

The metric is still a vacuum however the U-dependent prefactor breaks the  $O(2, 1)$  symmetry. In the (approximate) wave-zone it behaves as a "spike" — i.e., a narrow vacuum wave, whose sign alternates depending on the direction, shown in FIG[.16.](#page-25-2)

We found no analytic solutions, but numerical calculations indicate that particles at rest in the (approximate) before zone (See [\[12,](#page-30-6) [14,](#page-30-7) [15,](#page-30-8) [37,](#page-32-4) [38\]](#page-32-9) for the terminology). fly apart with constant velocities in the after-zone i.e., after the gravitational wave has passed, as seen in FIGs[.17](#page-26-0) and  $18$ : we get the *velocity effect* [\[9,](#page-30-10) [16\]](#page-30-9).

# <span id="page-25-0"></span>VI. HISTORY: FROM ARNOLD THROUGH NEWTON, BACK TO GALILEI

The zero - energy motions which oscillate along quarter-of-circles in the attractive zone between the separation lines of the attractive and repulsive quarters have indeed quite remarkable ancestry. Let's proceed backwards in history.

We start with noting that our equations  $(V.20)$  are reminiscent of studying planetary motion making use of the Bohlin-Arnold duality between harmonic oscillators and the Kepler problem [\[68–](#page-35-4)[70\]](#page-35-5). Eqns. #(8.3) in [\[70\]](#page-35-5) which assume circular trajectories are (apart of circular motion in the usual  $r^{-1}$  potential) consistent when the *force is inversely proportional*

to the fifth power of the distance from the sun,

. (VI.1)

This was known already by Newton, who, in his Principia, wondered: - What force laws do allow for circular trajectories ? And he found, using geometrical techniques, that (in addition to  $r^{-2}$ ) one can have also [\(VI.1\)](#page-27-1). See [\[71\]](#page-35-6) vol. I Proposition VII. Problem II, where the proof is left as an exercise.

Yet another intriguing feature is that both our circular solution in sec[.V](#page-16-0) and the parabolic trajectory of the 1680 comet (proved by Newton in his Principia [\[71\]](#page-35-6), Book III Proposition XLI, Problem XXI) have, just like our circular one found above, zero energy which separate bounded and unbounded motions. Even more incredibly, FIG.4 in Galilei's "Dialogo" [\[72\]](#page-35-7), written before Newton was even born, suggests such a circular motion which would pass through the center of the Earth.

Returning to our circularly oscillating motions in sect.  $V$  we note that they do *not* enter into the Bohlin-Arnold framework. Let us explain. The clue is that the Bohlin-Arnold trick [\[68,](#page-35-4) [69\]](#page-35-8) is based on a *duality* between two central potentials proportional to  $r^a$  and  $r^A$ , respectively. They are duals when the constraint

is satisfied; then motion in the  $r^a$  and in the  $r^A$  potentials can be swapped into each other.

The newtonian potential corresponds, for example, to  $a = -1$ ; its dual has therefore  $A = 2$  i.e., that of an isotropic harmonic oscillator. This duality swaps also the dynamical

symmetries of the oscillator with the Runge-Lenz vector-induced one of planetary motion. Working for simplicity in the plane using complex coordinates,  $\zeta = \xi + i\eta$  for the oscillator and  $z = x + iy$  for the Kepler problem, the corresponding Levi-Civita - Bohlin - Arnold map [\[68–](#page-35-4)[70,](#page-35-5) [73,](#page-35-9) [74\]](#page-35-10),

$$
z = \left(\zeta + \frac{1}{\zeta}\right)^2\tag{VI.3}
$$

interchanges also those dynamical symmetries [\[75\]](#page-35-11). The potential of the inverse-5 force [\(VI.1\)](#page-27-1) is in turn self-dual,  $a = A = -4$ .

However the *inverse square* potential, which is what we are interested in in this paper, does not enter the Bohlin-Arnold duality because it has no dual: the constraint [\(VI.2\)](#page-27-2) can not be satisfied for  $a = -2$ . It is therefore a remarkable tour de force that Sundaram et all [\[67\]](#page-35-3) could extend the Bohlin-Arnold duality to that case.

### <span id="page-28-0"></span>VII. SUMMARY AND DISCUSSIONS

In this paper we study conformally related vacuum gravitational waves and their associated symmetries by using a special Möbius conformal transformation [\(II.7\)](#page-3-3)-[\(II.8\)](#page-3-4). The vacuum condition is preserved by eliminating the additional non-vacuum oscillator term [\(II.4\)](#page-3-0) [\[28,](#page-31-4) [32\]](#page-32-0). The resulting GW is in general different from the original one. The transformation [\(II.7\)](#page-3-3)-[\(II.8\)](#page-3-4) carries a global GW into an (approximate) sandwich wave, as illustrated by LPP GW and CPP GW which exemplify the memory effect [\[7](#page-30-4)[–9,](#page-30-10) [12,](#page-30-6) [14,](#page-30-7) [15\]](#page-30-8).

A vacuum GW can also be invariant under the special Möbius conformal transformation  $(II.7)-(II.8)$  $(II.7)-(II.8)$  $(II.7)-(II.8)$  when it has an  $O(2,1)$  symmetry. The remarkable efficiency of this symmetry is that its generators act on the radial variable only, therefore they apply equally well to anisotropis systems.

The particularly interesting example originating in molecular physics [\[33\]](#page-32-1) but applied here in the gravitational context by using the Bargmann framework  $[2, 4, 6]$  $[2, 4, 6]$  $[2, 4, 6]$  $[2, 4, 6]$  $[2, 4, 6]$  is studied in some detail. It has the form of the inverse-square potential [\[58\]](#page-34-8) whose rôle played in black-hole physics has been noticed before [\[34\]](#page-32-8) in the isotropic case.

For the polar-molecular application, [\(V.1\)](#page-16-1) the familiar rotational symmetry is broken by an angle-dependent coefficient which makes it anisotropic: it alternates between repulsive and attractive at every quarter-of-a circle, see [\(V.8\)](#page-17-0). The particle is accordingly being pushed out to infinity or attracted towards the singularity at the origin, depending on the sign of the energy in the underlying non-relativistic problem. The behavior is reminiscent of that in the Kepler problem.

Bounded motion arise in the attractive quadrant, with the particle oscillates along quarter-of-circle between the lines which separate the attractive and repulsive quadrants.

Analytic solutions were found for escaping or incoming radial motion along the "crests" or "valley bottoms" which correponds to the usual inverse-square potential with repulsive or attractive sign.

The anisotropy breaks the rotational symmetry : the length of the angular momentum [\(V.25\)](#page-23-2) oscillates, as shown in FIG[.15](#page-25-1) in the periodic case.

The analytic periodic motions in the attractive zone show remarkable historical analogies, recounted in sec. [VI](#page-25-0) by proceeding backwards in time.

Approximately sandwich waves are obtained by putting the profile into a Gaussian envelop. No analytic solutions are found but we observe instead the (approximate) velocity effect [\[9,](#page-30-10) [16\]](#page-30-9).

The rôle played by the inverse-square potential in black-hole physics has been noticed before [\[61\]](#page-34-5), for the isotropic Reissner-Nordström solution [\[34\]](#page-32-8). The anisotropic metric [\(V.8\)](#page-17-0), which seems to have escaped attention so far, is a pp wave which resembles that near the "Dirac String" in the Lorentzian Taub-NUT metric [\[76–](#page-35-12)[78\]](#page-35-13).
