# $A_{\alpha}$-spectral radius and path-factor covered graphs *

#### Abstract

Let $\alpha \in[0,1)$, and let $G$ be a connected graph of order $n$ with $n \geq f(\alpha)$, where $f(\alpha)=14$ for $\alpha \in\left[0, \frac{1}{2}\right], f(\alpha)=17$ for $\alpha \in\left(\frac{1}{2}, \frac{2}{3}\right], f(\alpha)=20$ for $\alpha \in\left(\frac{2}{3}, \frac{3}{4}\right]$ and $f(\alpha)=\frac{5}{1-\alpha}+1$ for $\alpha \in\left(\frac{3}{4}, 1\right)$. A path factor is a spanning subgraph $F$ of $G$ such that every component of $F$ is a path with at least two vertices. Let $k \geq 2$ be an integer. A $P_{\geq k}$-factor means a path-factor with each component being a path of order at least $k$. A graph $G$ is called a $P_{\geq k}$-factor covered graph if $G$ has a $P_{\geq k}$-factor containing $e$ for any $e \in E(G)$. Let $A_{\alpha}(G)=\alpha D(G)+(1-\alpha) A(G)$, where $D(G)$ denotes the diagonal matrix of vertex degrees of $G$ and $A(G)$ denotes the adjacency matrix of $G$. The largest eigenvalue of $A_{\alpha}(G)$ is called the $A_{\alpha}$-spectral radius of $G$, which is denoted by $\rho_{\alpha}(G)$. In this paper, it is proved that $G$ is a $P_{\geq 2}$-factor covered graph if $\rho_{\alpha}(G)>\eta(n)$, where $\eta(n)$ is the largest root of $x^{3}-((\alpha+1) n+\alpha-4) x^{2}+\left(\alpha n^{2}+\left(\alpha^{2}-2 \alpha-1\right) n-2 \alpha+1\right) x-\alpha^{2} n^{2}+\left(5 \alpha^{2}-3 \alpha+2\right) n-10 \alpha^{2}+15 \alpha-8=0$.


 Furthermore, we provide a graph to show that the bound on $A_{\alpha}$-spectral radius is optimal.Keywords: graph; $A_{\alpha}$-spectral radius; $P_{\geq 2}$-factor; $P_{\geq 2}$-factor covered graph.

## 1 Introduction

In this paper, we only consider finite and undirected graphs which have neither loops nor multiple edges. Let $G=(V(G), E(G))$ be a graph, where $V(G)$ is the vertex set of $G$ and $E(G)$ is the edge set of $G$. The order of $G$ is denoted by $|V(G)|=n$. A graph $G$ is called trivial if $|V(G)|=1$. Let $i(G)$ denote the number of isolated vertices in $G$. For any $v \in V(G)$, the neighborhood $N_{G}(v)$ of $v$ in $G$ is defined by $\{u \in V(G): u v \in E(G)\}$. The cardinality of $N_{G}(v)$ is called the degree of $v$ in $G$ and is denoted by $d_{G}(v)$. For a vertex subset $S$ of $G$, the induced subgraph induced by $S$, denoted by $G[S]$, is the subgraph of $G$ whose vertex set is $S$ and whose edge set consists of all edges of $G$ which have both ends in $S$. We write $G-S$ for $G[V(G) \backslash S]$. A subset $S \subseteq V(G)$ is called an independent set if $G[S]$ has no edges. The complement of a graph $G$ is a graph $\bar{G}$ with the same vertex set as $G$, in which any two distinct vertices are adjacent if and only if they are nonadjacent in $G$. Let $P_{n}$ and $K_{n}$ denote the path and complete graph of order $n$, respectively. Let $G_{1}$ and $G_{2}$ be two disjoint graphs. The union of $G_{1}$

[^0]and $G_{2}$, denoted by $G_{1} \cup G_{2}$, is the graph with vertex set $V\left(G_{1}\right) \cup V\left(G_{2}\right)$ and edge set $E\left(G_{1}\right) \cup E\left(G_{2}\right)$. The join of $G_{1}$ and $G_{2}$, denoted by $G_{1} \vee G_{2}$, is the graph with vertex set $V\left(G_{1}\right) \cup V\left(G_{2}\right)$ and edge set $E\left(G_{1}\right) \cup E\left(G_{2}\right) \cup\left\{u v: u \in V\left(G_{1}\right), v \in V\left(G_{2}\right)\right\}$. Let $k \geq 3$ be an integer. The sequential join of graphs $G_{1}, G_{2}, \cdots, G_{k}$, denoted by $G_{1} \vee G_{2} \vee \cdots \vee G_{k}$, is the graph with vertex set $V\left(G_{1}\right) \cup V\left(G_{2}\right) \cup \cdots \cup V\left(G_{k}\right)$ and edge set $E\left(G_{1}\right) \cup E\left(G_{2}\right) \cup \cdots \cup E\left(G_{k}\right) \cup\left\{e=x_{i} x_{i+1}: x_{i} \in V\left(G_{i}\right), x_{i+1} \in V\left(G_{i+1}\right), 1 \leq i \leq k-1\right\}$.

Given a graph $G$ with vertex set $V(G)=\left\{v_{1}, v_{2}, \cdots, v_{n}\right\}$, the adjacency matrix of $G$ is defined as $A(G)=\left(a_{i j}\right)$, where $a_{i j}=1$ if $v_{i} v_{j} \in E(G)$, and $a_{i j}=0$ otherwise. Let $D(G)$ denote the diagonal matrix of vertex degrees of $G$. The signless Laplacian matrix $Q(G)$ of $G$ are defined by $Q(G)=D(G)+A(G)$. For any $\alpha \in[0,1)$, Nikiforov [1] defined the $A_{\alpha}$-matrix of $G$ as

$$
A_{\alpha}(G)=\alpha D(G)+(1-\alpha) A(G)
$$

Obviously, $A_{0}(G)=A(G)$ and $A_{\frac{1}{2}}(G)=\frac{1}{2} Q(G)$. Thus, $A_{\alpha}(G)$ generalizes both the adjacency matrix and the signless Laplacian matrix of $G$. Note that $A_{\alpha}(G)$ is a real symmetric nonnegative matrix. Hence, the eigenvalues of $A_{\alpha}(G)$ are real. The largest eigenvalue of $A_{\alpha}(G)$ is called the $A_{\alpha}$-spectral radius of $G$, which is denoted by $\rho_{\alpha}(G)$. More contents on $A_{\alpha}$-matrix can be found in [2/5].

A subset $M \subseteq E(G)$ is called a matching if any two edges of $M$ have no common vertices. $M$ is called a perfect matching if each vertex of $G$ is incident to exactly one edge of $M$. A path factor is a spanning subgraph $F$ of $G$ such that every component of $F$ is a path with at least two vertices. A $P_{\geq k}$-factor means a path-factor with every component having order at least $k$, where $k \geq 2$ is an integer. In fact, a graph $G$ has a perfect matching if and only if $G$ has a $\left\{P_{2}\right\}$-factor. A graph $G$ is called a $P_{\geq k}$-factor covered graph if $G$ has a $P_{\geq k}$-factor containing $e$ for any $e \in E(G)$.

O [6] obtained an adjacency spectral radius condition for the existence of a perfect matching in a graph. Liu, Pan and Li [7] established a relationship between a perfect matching and a signless Laplacian spectral radius of a graph. Zhang and Lin [8 proved an upper bound for the distance spectral radius to guarantee the existence of a perfect matching in a graph. Zhao, Huang and Wang [9] presented an $A_{\alpha}$-spectral radius condition for a graph to contain a perfect matching. For the relationship between spectral radius and the existence of certain spanning subgraphs in graphs, one may be referred to $10-12$ and the references cited in. Egawa and Furuya 13 got a sufficient condition for a graph to possess a $\left\{P_{2}, P_{5}\right\}$-factor. Wang and Zhang [14] gave a degree condition for the existence of a $\left\{P_{2}, P_{5}\right\}$-factor in a graph. Las Vergnas [15] showed a characterization for a graph with a $P_{\geq 2^{-}}$ factor. Kaneko [16] provided a necessary and sufficient condition for a graph to contain a $P_{\geq 3}$-factor. Kano, Lu and Yu [17] established a connection between the number of isolated vertices and $P_{\geq 3}$-factors in graphs. Zhou and Sun [18] claimed a binding number condition for a graph with a $P_{\geq 2}$-factor (resp. a $P_{\geq 3}$-factor). Wang and Zhang [19] presented a minimum degree and independence number condition for a graph to contain a $P_{\geq 3}$-factor. Wang and Zhang [20] studied the relationship between isolated toughness and a $P_{\geq 2}$-factor (resp. a $P_{\geq 3}$-factor) in a graph. Zhou, Sun and Bian [21] posed an isolated toughness condition for a graph to have a $P_{\geq 3}$-factor. Zhou [22,23], Zhou, Sun and Yang [24] obtained some results on the existence of $P_{\geq 3}$-factors in graphs with given properties. Zhou, Sun and Liu [25], Wu [26], Liu [27] gave some sufficient conditions for graphs to possess $P_{\geq 3}$-factors with given properties. More results on graph factors, we refer the reader to [28 35].

Zhou, Zhang and Sun [36] provided an $A_{\alpha}$-spectral radius condition for a graph with a $P_{\geq 2}$-factor, which is shown in the following.

Theorem 1.1 (Zhou, Zhang and Sun [36]). Let $\alpha \in[0,1$ ), and let $G$ be a connected graph of order
$n$ with $n \geq f(\alpha)$, where

$$
f(\alpha)= \begin{cases}14, & \text { if } \alpha \in\left[0, \frac{1}{2}\right] \\ 17, & \text { if } \alpha \in\left(\frac{1}{2}, \frac{2}{3}\right] \\ 20, & \text { if } \alpha \in\left(\frac{2}{3}, \frac{3}{4}\right] \\ \frac{5}{1-\alpha}+1, & \text { if } \alpha \in\left(\frac{3}{4}, 1\right)\end{cases}
$$

If $\rho_{\alpha}(G)>\theta(n)$, then $G$ contains a $P_{\geq 2}$-factor, where $\theta(n)$ is the largest root of $x^{3}-((\alpha+1) n+\alpha-$ 5) $x^{2}+\left(\alpha n^{2}+\left(\alpha^{2}-3 \alpha-1\right) n-2 \alpha+1\right) x-\alpha^{2} n^{2}+\left(7 \alpha^{2}-5 \alpha+3\right) n-18 \alpha^{2}+29 \alpha-15=0$.

In this paper, we extend Theorem 1.1 to $P_{\geq 2}$-factor covered graphs, and obtain a result on the existence of a $P_{\geq 2}$-factor covered graph by using $A_{\alpha}$-spectral radius.

Theorem 1.2. Let $\alpha \in[0,1)$, and let $G$ be a connected graph of order $n$ with $n \geq f(\alpha)$, where $f(\alpha)$ is defined as in Theorem 1.1. If $\rho_{\alpha}(G)>\eta(n)$, then $G$ is a $P_{\geq 2}$-factor covered graph, where $\eta(n)$ is the largest root of $x^{3}-((\alpha+1) n+\alpha-4) x^{2}+\left(\alpha n^{2}+\left(\alpha^{2}-2 \alpha-1\right) n-2 \alpha+1\right) x-\alpha^{2} n^{2}+\left(5 \alpha^{2}-3 \alpha+\right.$ 2) $n-10 \alpha^{2}+15 \alpha-8=0$.

## 2 Preliminaries

In this section, we provide several necessary preliminary results, which will be used to verify Theorem 1.2. Las Vergnas [15 posed a necessary and sufficient condition for graphs to possess $P_{\geq 2}$-factors.

Lemma 2.1 (Las Vergnas [15]). A graph $G$ has a $P_{\geq 2}$-factor if and only if

$$
i(G-S) \leq 2|S|
$$

for any vertex subset $S$ of $G$.
Zhang and Zhou 37] obtained a necessary and sufficient condition for the existence of a $P_{\geq 2}$-factor covered graph.

Lemma 2.2 (Zhang and Zhou [37]). Let $G$ be a connected graph. Then $G$ is a $P_{\geq 2}$-factor covered graph if and only if the following three conditions hold for any $S \subseteq V(G)$ :
(i) $i(G-S) \leq 2|S|$;
(ii) If $S$ is nonempty and there exists a connected component of $G-S$ with at least two vertices, then $i(G-S) \leq 2|S|-1$;
(iii) If $S$ is not an independent set, then $i(G-S) \leq 2|S|-2$.

Lemma 2.3 (Nikiforov [1]). For a complete graph $K_{n}$ of order $n$, we have

$$
\rho_{\alpha}\left(K_{n}\right)=n-1
$$

Lemma 2.4 (Nikiforov [1]). Let $G$ be a connected graph, and $H$ be a proper subgraph of $G$. Then

$$
\rho_{\alpha}(G)>\rho_{\alpha}(H)
$$

Let $M$ be a real symmetric matrix whose rows and columns are indexed by $V=\{1,2, \cdots, n\}$. Assume that $M$, with respect to the partition $\pi: V=V_{1} \cup V_{2} \cup \cdots \cup V_{r}$, can be written as

$$
M=\left(\begin{array}{ccc}
M_{11} & \cdots & M_{1, r} \\
\vdots & \ddots & \vdots \\
M_{r 1} & \cdots & M_{r, r}
\end{array}\right)
$$

where $M_{i j}$ denotes the submatrix (block) of $M$ formed by rows in $V_{i}$ and columns in $V_{j}$. Let $q_{i j}$ denote the average row sum of $M_{i j}$. Then matrix $M_{\pi}=\left(q_{i j}\right)$ is called the quotient matrix of $M$. If the row sum of each block $M_{i j}$ is a constant, then the partition is equitable.

Lemma 2.5 ( [38]). Let $M$ be a real symmetric matrix with an equitable partition $\pi$, and let $M_{\pi}$ be the corresponding quotient matrix. Then every eigenvalue of $M_{\pi}$ is an eigenvalue of $M$. Furthermore, if $M$ is nonnegative, then the largest eigenvalues of $M$ and $M_{\pi}$ are equal.

## 3 The proof of Theorem 1.2

Proof of Theorem 1.2. Suppose to the contrary that $G$ is not $P_{\geq 2}$-factor covered. Choose a connected graph $G$ of order $n$ such that its $A_{\alpha}$-spectral radius is as large as possible.

Let $h(x)=x^{3}-((\alpha+1) n+\alpha-5) x^{2}+\left(\alpha n^{2}+\left(\alpha^{2}-3 \alpha-1\right) n-2 \alpha+1\right) x-\alpha^{2} n^{2}+\left(7 \alpha^{2}-5 \alpha+\right.$ 3) $n-18 \alpha^{2}+29 \alpha-15$. By the condition of Theorem 1.1, $\theta(n)$ is the largest root of $h(x)=0$. Let $\varphi(x)=x^{3}-((\alpha+1) n+\alpha-4) x^{2}+\left(\alpha n^{2}+\left(\alpha^{2}-2 \alpha-1\right) n-2 \alpha+1\right) x-\alpha^{2} n^{2}+\left(5 \alpha^{2}-3 \alpha+2\right) n-10 \alpha^{2}+15 \alpha-8$. According to the condition of Theorem 1.2, $\eta(n)$ is the largest root of $\varphi(x)=0$. We verify Theorem 1.2 by the next two possible cases.

Case 1. $G$ has no $P_{\geq 2}$-factor.
In terms of Theorem 1.1, we have $\rho_{\alpha}(G) \leq \theta(n)$ for $n \geq f(\alpha)$, where

$$
f(\alpha)= \begin{cases}14, & \text { if } \alpha \in\left[0, \frac{1}{2}\right] \\ 17, & \text { if } \alpha \in\left(\frac{1}{2}, \frac{2}{3}\right] \\ 20, & \text { if } \alpha \in\left(\frac{2}{3}, \frac{3}{4}\right] \\ \frac{5}{1-\alpha}+1, & \text { if } \alpha \in\left(\frac{3}{4}, 1\right)\end{cases}
$$

It suffices to show $\theta:=\theta(n) \leq \eta(n)$. Notice that $h(\theta)=0$. Plugging $\theta$ into $x$ of $\varphi(x)-h(x)$ gives

$$
\varphi(\theta)=\varphi(\theta)-h(\theta)=-\theta^{2}+\alpha n \theta-\left(2 \alpha^{2}-2 \alpha+1\right) n+8 \alpha^{2}-14 \alpha+7
$$

Claim 1. $\theta>n-4$.
Proof. Let $H=K_{1} \vee\left(K_{n-4} \cup 3 K_{1}\right)$. We consider the partition $V(H)=V\left(3 K_{1}\right) \cup V\left(K_{n-4}\right) \cup V\left(K_{1}\right)$. The corresponding quotient matrix of $A_{\alpha}(H)$ equals

$$
B_{0}=\left(\begin{array}{ccc}
\alpha & 0 & 1-\alpha \\
0 & n+\alpha-5 & 1-\alpha \\
3(1-\alpha) & (1-\alpha)(n-4) & \alpha n-\alpha
\end{array}\right)
$$

By a direct computation, the characteristic polynomial of $B_{0}$ is

$$
\begin{aligned}
h(x)= & x^{3}-((\alpha+1) n+\alpha-5) x^{2}+\left(\alpha n^{2}+\left(\alpha^{2}-3 \alpha-1\right) n-2 \alpha+1\right) x \\
& -\alpha^{2} n^{2}+\left(7 \alpha^{2}-5 \alpha+3\right) n-18 \alpha^{2}+29 \alpha-15
\end{aligned}
$$

Notice that the partition $V(H)=V\left(3 K_{1}\right) \cup V\left(K_{n-4}\right) \cup V\left(K_{1}\right)$ is equitable. According to Lemma 2.5, the largest root $\theta$ of $h(x)=0$ equals $\rho_{\alpha}(H)$, that is, $\rho_{\alpha}(H)=\theta$.

Obviously, $K_{n-3}$ is a proper subgraph of $H=K_{1} \vee\left(K_{n-4} \cup 3 K_{1}\right)$. Using Lemmas 2.3 and 2.4, we conclude

$$
\theta=\rho_{\alpha}(H)=\rho_{\alpha}\left(K_{1} \vee\left(K_{n-4} \cup 3 K_{1}\right)\right)>\rho_{\alpha}\left(K_{n-3}\right)=n-4
$$

Claim 1 is true.
By virtue of Claim 1, we get

$$
\frac{\alpha n}{2}<n-4<\theta
$$

Then

$$
\begin{aligned}
\varphi(\theta) & =-\theta^{2}+\alpha n \theta-\left(2 \alpha^{2}-2 \alpha+1\right) n+8 \alpha^{2}-14 \alpha+7 \\
& <-(n-4)^{2}+\alpha n(n-4)-\left(2 \alpha^{2}-2 \alpha+1\right) n+8 \alpha^{2}-14 \alpha+7 \\
& =-(1-\alpha) n^{2}+\left(7-2 \alpha-2 \alpha^{2}\right) n+8 \alpha^{2}-14 \alpha-9
\end{aligned}
$$

If $0 \leq \alpha \leq \frac{3}{4}$, then $\frac{7-2 \alpha-2 \alpha^{2}}{2-2 \alpha}<14 \leq f(\alpha) \leq n$. Thus, we possess

$$
\begin{aligned}
\varphi(\theta) & <-(1-\alpha) n^{2}+\left(7-2 \alpha-2 \alpha^{2}\right) n+8 \alpha^{2}-14 \alpha-9 \\
& \leq-196(1-\alpha)+14\left(7-2 \alpha-2 \alpha^{2}\right)+8 \alpha^{2}-14 \alpha-9 \\
& =-20 \alpha^{2}+154 \alpha-107 \\
& <0
\end{aligned}
$$

If $\frac{3}{4}<\alpha<1$, then $\frac{7-2 \alpha-2 \alpha^{2}}{2-2 \alpha}<\frac{5}{1-\alpha}+1=f(\alpha) \leq n$. Thus, we obtain

$$
\begin{aligned}
\varphi(\theta) & <-(1-\alpha) n^{2}+\left(7-2 \alpha-2 \alpha^{2}\right) n+8 \alpha^{2}-14 \alpha-9 \\
& \leq-(1-\alpha)\left(\frac{5}{1-\alpha}+1\right)^{2}+\left(7-2 \alpha-2 \alpha^{2}\right)\left(\frac{5}{1-\alpha}+1\right)+8 \alpha^{2}-14 \alpha-9 \\
& =\frac{1}{1-\alpha}\left(-6 \alpha^{3}+11 \alpha^{2}-12 \alpha-3\right) \\
& <0
\end{aligned}
$$

From the discussion above, we always have $\varphi(\theta)<0$, which implies $\theta(n)=\theta<\eta(n)$. Together with $\rho_{\alpha}(G) \leq \theta(n)$ for $n \geq f(\alpha)$, we conclude $\rho_{\alpha}(G) \leq \theta(n)<\eta(n)$ for $n \geq f(\alpha)$, which is a contradiction to $\rho_{\alpha}(G)>\eta(n)$.
Case 2. $G$ has a $P_{\geq 2}$-factor.
According to Lemma 2.1, we obtain $i(G-S) \leq 2|S|$ for any subset $S$ of $V(G)$. Since $G$ is not $P_{\geq 2}$-factor covered, using Lemma 2.2, there exists a subset $S$ of $V(G)$ so that either $S$ is nonempty and some connected component of $G-S$ is nontrivial, or $S$ is not an independent set. Otherwise, it follows from Lemma 2.2 that $G$ is $P_{\geq 2}$-factor covered, a contradiction. Furthermore, at least one of the following statements holds:
(a) $S$ is nonempty, one connected component of $G-S$ is nontrivial, and $i(G-S) \geq 2|S|$;
(b) $S$ is not an independent set, and $i(G-S) \geq 2|S|-1$.

Subcase 2.1. Statement (a) holds.
In this subcase, we have $|S| \geq 1$ and $i(G-S)=2|S|$. In view of Lemma 2.4 and the choice of $G$, we conclude that

- the induced subgraph $G[S]$ and every connected component of $G-S$ are complete graphs;
- $G=G[S] \vee(G-S)$;
- $G-S$ has only one nontrivial connected component, say $G_{1}$.

Let $|S|=s$ and $\left|V\left(G_{1}\right)\right|=n_{1} \geq 2$. Recall that $i(G-S)=2|S|$. Then $G=K_{s} \vee\left(K_{n_{1}} \cup 2 s K_{1}\right)$, where $n_{1}=n-3 s \geq 2$. It is obvious that the partition $V(G)=V\left(K_{s}\right) \cup V\left(K_{n_{1}}\right) \cup V\left(2 s K_{1}\right)$ is an
equitable partition of $G$, and the corresponding quotient matrix of $A_{\alpha}(G)$ is

$$
B_{1}=\left(\begin{array}{ccc}
\alpha n-\alpha s+s-1 & (1-\alpha)(n-3 s) & 2 s(1-\alpha) \\
(1-\alpha) s & n+\alpha s-3 s-1 & 0 \\
(1-\alpha) s & 0 & \alpha s
\end{array}\right)
$$

By a simple computation, the characteristic polynomial of $B_{1}$ is given by

$$
\begin{align*}
\varphi_{1}(x)= & x^{3}-((\alpha+1) n+(\alpha-2) s-2) x^{2} \\
& +\left(\alpha n^{2}+\left(\alpha^{2}-\alpha\right) s n-(\alpha+1) n-2 s^{2}-(2 \alpha-2) s+1\right) x \\
& -\alpha^{2} s n^{2}+\left(4 \alpha^{2}-4 \alpha+2\right) s^{2} n+\left(\alpha^{2}+\alpha\right) s n \\
& -\left(8 \alpha^{2}-14 \alpha+6\right) s^{3}-\left(2 \alpha^{2}-2 \alpha+2\right) s^{2}-\alpha s . \tag{3.1}
\end{align*}
$$

By virtue of Lemma 2.5, $\rho_{\alpha}(G)$ is the largest root of $\varphi_{1}(x)=0$. Let $\eta_{1}=\rho_{\alpha}(G) \geq \eta_{2} \geq \eta_{3}$ be the three roots of $\varphi_{1}(x)=0$ and $R_{1}=\operatorname{diag}(s, n-3 s, 2 s)$. One checks that $R_{1}^{\frac{1}{2}} B_{1} R_{1}^{-\frac{1}{2}}$ is symmetric, and also contains

$$
\left(\begin{array}{cc}
n+\alpha s-3 s-1 & 0 \\
0 & \alpha s

as its submatrix. Since $R_{1}^{\frac{1}{2}} B_{1} R_{1}^{-\frac{1}{2}}$ and $B_{1}$ possess the same eigenvalues, the Cauchy interlacing theorem (cf. [39]) implies that $\eta_{2} \leq n+\alpha s-3 s-1<n-3$.

If $s=1$, then $G=K_{1} \vee\left(K_{n-3} \cup 2 K_{1}\right)$ and $\varphi_{1}(x)=\varphi(x)$. Recall that $\eta(n)$ is the largest root of $\varphi(x)=0$ and $\rho_{\alpha}(G)$ is the largest root of $\varphi_{1}(x)=0$. Thus, we conclude $\rho_{\alpha}(G)=\eta(n)$, which is a contradiction to $\rho_{\alpha}(G)>\eta(n)$. In what follows, we are to consider $s \geq 2$.

From the discussion above, we easily see $\eta(n)=\rho_{\alpha}\left(K_{1} \vee\left(K_{n-3} \cup 2 K_{1}\right)\right)$. Note that $K_{n-2}$ is a proper subgraph of $K_{1} \vee\left(K_{n-3} \cup 2 K_{1}\right)$. From Lemmas 2.3 and 2.4, we have $\rho_{\alpha}\left(K_{1} \vee\left(K_{n-3} \cup 2 K_{1}\right)\right)>$ $\rho_{\alpha}\left(K_{n-2}\right)=n-3$. Thus, we obtain

= & (2-2 \alpha) n^{2}+\left(\left(4 \alpha^{2}-4 \alpha\right) s+2 \alpha^{2}+4 \alpha-10\right) n-\left(8 \alpha^{2}-14 \alpha+6\right) s^{2} \\
& -\left(10 \alpha^{2}-16 \alpha+2\right) s-10 \alpha^{2}+12 \alpha+10 \tag{3.4}
\end{align*}

Let $l_{1}(s, n)=(2-2 \alpha) n^{2}+\left(\left(4 \alpha^{2}-4 \alpha\right) s+2 \alpha^{2}+4 \alpha-10\right) n-\left(8 \alpha^{2}-14 \alpha+6\right) s^{2}-\left(10 \alpha^{2}-16 \alpha+2\right) s-$ $10 \alpha^{2}+12 \alpha+10$. Notice that

& -\left(8 \alpha^{2}-14 \alpha+6\right) s^{2}-\left(10 \alpha^{2}-16 \alpha+2\right) s-10 \alpha^{2}+12 \alpha+10 \\
= & \left(4 s^{2}+4 s-6\right) \alpha^{2}-\left(16 s^{2}+4 s-12\right) \alpha+12 s^{2}-8 s-2 \\
\geq & \frac{9}{16}\left(4 s^{2}+4 s-6\right)-\frac{3}{4}\left(16 s^{2}+4 s-12\right)+12 s^{2}-8 s-2 \\
= & \frac{1}{8}\left(18 s^{2}-70 s+29\right) \\
> & 0
\end{aligned}

where the last two inequalities hold from $\frac{16 s^{2}+4 s-12}{2\left(4 s^{2}+4 s-6\right)}>\frac{3}{4} \geq \alpha$ and $s \geq 4$, respectively.
If $s=3$, then $-\frac{\left(4 \alpha^{2}-4 \alpha\right) s+2 \alpha^{2}+4 \alpha-10}{2(2-2 \alpha)}=-\frac{7 \alpha^{2}-4 \alpha-5}{2-2 \alpha}<14 \leq f(\alpha) \leq n$ due to $0 \leq \alpha \leq \frac{3}{4}$. Consequently, for $0 \leq \alpha \leq \frac{3}{4}$ and $n \geq f(\alpha) \geq 14$, we obtain

If $s=2$, then $-\frac{\left(4 \alpha^{2}-4 \alpha\right) s+2 \alpha^{2}+4 \alpha-10}{2(2-2 \alpha)}=-\frac{5 \alpha^{2}-2 \alpha-5}{2-2 \alpha}<14 \leq f(\alpha) \leq n$ due to $0 \leq \alpha \leq \frac{3}{4}$. Hence, for $0 \leq \alpha \leq \frac{3}{4}$ and $n \geq f(\alpha) \geq 14$, we conclude

From the discussion above, we have $l_{1}(s, n)>0$ for $2 \leq s \leq \frac{n-2}{3}$. Together with (3.3), (3.4) and $s \geq 2$, we get

As $\eta(n)=\rho_{\alpha}\left(K_{1} \vee\left(K_{n-3} \cup 2 K_{1}\right)\right)>$ $n-3>\eta_{2}$ (see (3.2)), we infer $\rho_{\alpha}(G)<\eta(n)$ for $2 \leq s \leq \frac{n-2}{3}$, which is a contradiction to $\rho_{\alpha}(G)>\eta(n)$. Subcase 2.1.2. $\frac{3}{4}<\alpha<1$.

According to (3.1), we have

& +\left((2-2 \alpha) n^{2}-\left(2 \alpha^{2}-8 \alpha+10\right) n-4 \alpha+12\right) s \\

= & : \Phi_{1}(s, n) .
\end{aligned}

Thus, we obtain

Recall that $\frac{3}{4}<\alpha<1$ and $n \geq f(\alpha)=\frac{5}{1-\alpha}+1>\frac{5}{1-\alpha}$. By a direct calculation, we have

& <\frac{1}{3}\left(\left(6 \alpha^{2}-12 \alpha+2\right)\left(\frac{5}{1-\alpha}\right)-24 \alpha^{2}+36 \alpha-4\right) \\
& =\frac{1}{3(1-\alpha)}\left(24 \alpha^{3}-30 \alpha^{2}-20 \alpha+6\right) \\

This implies that $\varphi_{1}(n-3)=\Phi_{1}(s, n) \geq \min \left\{\Phi_{1}(2, n), \Phi_{1}\left(\frac{n-2}{3}, n\right)\right\}$ because the leading coefficient of $\Phi_{1}(s, n)$ (view as a cubic polynomial of $s$ ) is positive, and $2 \leq s \leq \frac{n-2}{3}$. By virtue of $\frac{3}{4}<\alpha<1$ and $n \geq f(\alpha)=\frac{5}{1-\alpha}+1>\frac{5}{1-\alpha}$, we obtain

& =\frac{1}{1-\alpha}\left(72 \alpha^{3}-124 \alpha^{2}+102 \alpha-20\right) \\
& >0
\end{aligned}
$$

and

\Phi_{1}\left(\frac{n-2}{3}, n\right)= & \frac{1}{27}\left(\left(4 \alpha^{2}-16 \alpha+12\right) n^{3}+\left(-24 \alpha^{2}+132 \alpha-132\right) n^{2}\right. \\
& \left.+\left(12 \alpha^{2}-246 \alpha+438\right) n+40 \alpha^{2}-16 \alpha-444\right) \\
> & \frac{1}{27}\left(\left(4 \alpha^{2}-16 \alpha+12\right)\left(\frac{5}{1-\alpha}\right)^{3}+\left(-24 \alpha^{2}+132 \alpha-132\right)\left(\frac{5}{1-\alpha}\right)^{2}\right.
\end{aligned}
$$

$$
\begin{aligned}
& \left.+\left(12 \alpha^{2}-246 \alpha+438\right)\left(\frac{5}{1-\alpha}\right)+40 \alpha^{2}-16 \alpha-444\right) \\
= & \frac{1}{27(1-\alpha)^{2}}\left(40 \alpha^{4}-156 \alpha^{3}+318 \alpha^{2}+252 \alpha-54\right) \\
> & 0
\end{aligned}

Consequently, we conclude $\varphi_{1}(n-3) \geq \min \left\{\Phi_{1}(2, n), \Phi_{1}\left(\frac{n-2}{3}, n\right)\right\}>0$ for $2 \leq s \leq \frac{n-2}{3}$. As $\eta(n)=\rho_{\alpha}\left(K_{1} \vee\left(K_{n-3} \cup 2 K_{1}\right)\right)>n-3>\eta_{2}$ (see (3.2)), we deduce $\rho_{\alpha}(G)<\eta(n)$ for $2 \leq s \leq \frac{n-2}{3}$, which is a contradiction to $\rho_{\alpha}(G)>\eta(n)$.
Subcase 2.2. Statement (b) holds.
In this subcase, we infer $|S| \geq 2$ and $i(G-S)=2|S|-1$ or $2|S|$. Similarly, one has

- the induced subgraph $G[S]$ and every connected component of $G-S$ are complete graphs;
- $G=G[S] \vee(G-S)$;
- $G-S$ has at most one nontrivial connected component $G_{1}$.

We also let $|S|=s \geq 2$ and $\left|V\left(G_{1}\right)\right|=n_{1}$. Notice that $n_{1}=0$ or $n_{1} \geq 2$.
Subcase 2.2.1. $i(G-S)=2 s-1$.
Subcase 2.2.1.1. $n_{1} \geq 2$.
In this subcase, $G=K_{s} \vee\left(K_{n_{1}} \cup(2 s-1) K_{1}\right)$ and $n=3 s-1+n_{1} \geq 3 s+1$. It is clear that the partition $V(G)=V\left(K_{s}\right) \cup V\left(K_{n_{1}}\right) \cup V\left((2 s-1) K_{1}\right)$ is an equitable partition of $G$, and the corresponding quotient matrix of $A_{\alpha}(G)$ equals

According to Lemma 2.5, $\rho_{\alpha}(G)$ is the largest root of $\varphi_{2}(x)=0$. Let $\beta_{1}=\rho_{\alpha}(G) \geq \beta_{2} \geq \beta_{3}$ be the three roots of $\varphi_{2}(x)=0$ and $R_{2}=\operatorname{diag}(s, n-3 s+1,2 s-1)$. One checks that $R_{2}^{\frac{1}{2}} B_{2} R_{2}^{-\frac{1}{2}}$ is symmetric, and also contains

as its submatrix. Since $R_{2}^{\frac{1}{2}} B_{2} R_{2}^{-\frac{1}{2}}$ and $B_{2}$ have the same eigenvalues, the Cauchy interlacing theorem (cf. [39]) yields that $\beta_{2} \leq n+\alpha s-3 s<n-2 s \leq n-4$.

Recall that $\eta=\eta(n)=\rho_{\alpha}\left(K_{1} \vee\left(K_{n-3} \cup 2 K_{1}\right)\right)$. Since $K_{n-2}$ is a proper subgraph of $K_{1} \vee\left(K_{n-3} \cup\right.$ $2 K_{1}$ ), it follows from Lemmas 2.3 and 2.4 that

Note that $(2-2 \alpha) s+3 \alpha-3>0$ and

& -\left(8 \alpha^{2}-14 \alpha+6\right) s^{3}+\left(4 \alpha^{2}-9 \alpha+9\right) s^{2}-3(\alpha-3) s+10 \alpha^{2}-12 \alpha-16 \\
= & \left(4 s^{3}-4 s^{2}-10 s+8\right) \alpha^{2}-\left(16 s^{3}-32 s^{2}-2 s+16\right) \alpha+12 s^{3}-36 s^{2}+28 s-4 \\
\geq & \frac{9}{16}\left(4 s^{3}-4 s^{2}-10 s+8\right)-\frac{3}{4}\left(16 s^{3}-32 s^{2}-2 s+16\right)+12 s^{3}-36 s^{2}+28 s-4 \\

where the last two inequalities hold from $\frac{16 s^{2}+4 s-12}{2\left(4 s^{2}+4 s-6\right)}>\frac{3}{4} \geq \alpha$ and $s \geq 4$, respectively.
If $s=3$, then $-\frac{\left(4 \alpha^{2}-4 \alpha\right) s^{2}-\left(4 \alpha^{2}-10 \alpha+10\right) s-2 \alpha^{2}-7 \alpha+15}{2((2-2 \alpha) s+3 \alpha-3)}=-\frac{22 \alpha^{2}-13 \alpha-15}{6-6 \alpha}<14 \leq f(\alpha) \leq n$ due to $0 \leq \alpha \leq \frac{3}{4}$. Hence, for $0 \leq \alpha \leq \frac{3}{4}$ and $n \geq f(\alpha) \geq 14$, we get

Hence, for $0 \leq \alpha \leq \frac{3}{4}$ and $n \geq f(\alpha) \geq 14$, we have

$$
l_{2}(2, n) \geq l_{2}(2,14)=46 \alpha^{2}-180 \alpha+115>0
$$

From the discussion above, we conclude $l_{2}(s, n) \geq 0$ for $2 \leq s \leq \frac{n-1}{3}$. Combining this with (3.7) and $s \geq 2$, we obtain

$$
\varphi_{2}(\eta)>l_{2}(s, n) \geq 0
$$

Recall that $\rho_{\alpha}(G)$ is the largest root of $\varphi_{2}(x)=0$. As $\eta=\eta(n)=\rho_{\alpha}\left(K_{1} \vee\left(K_{n-3} \cup 2 K_{1}\right)\right)>n-3>\beta_{2}$ (see (3.6)), we deduce $\rho_{\alpha}(G)<\eta(n)$ for $2 \leq s \leq \frac{n-1}{3}$, which is a contradiction to $\rho_{\alpha}(G)>\eta(n)$. In what follows, we consider $\frac{3}{4}<\alpha<1$.

In terms of (3.5), we et

$$
\begin{aligned}
\varphi_{2}(n-3)= & (n-3)^{3}-((\alpha+1) n+(\alpha-2) s-1)(n-3)^{2} \\
& +\left(\alpha n^{2}+\left(\alpha^{2}-\alpha\right) s n-n-2 s^{2}-(2 \alpha-3) s\right)(n-3) \\
& -\alpha^{2} s n^{2}+\left(4 \alpha^{2}-4 \alpha+2\right) s^{2} n-\left(\alpha^{2}-3 \alpha+1\right) s n \\
& -\left(8 \alpha^{2}-14 \alpha+6\right) s^{3}+\left(4 \alpha^{2}-9 \alpha+3\right) s^{2} \\
= & 2(1-\alpha)(4 \alpha-3) s^{3}+\left(\left(4 \alpha^{2}-4 \alpha\right) n+4 \alpha^{2}-9 \alpha+9\right) s^{2} \\
& +\left((2-2 \alpha) n^{2}-\left(4 \alpha^{2}-10 \alpha+10\right) n-3 \alpha+9\right) s \\
& +(3 \alpha-3) n^{2}-(9 \alpha-15) n-18 \\
= & \Phi_{2}(s, n) .
\end{aligned}
$$

Thus, we have

$$
\begin{aligned}
\frac{\partial \Phi_{2}(s, n)}{\partial s}= & 6(1-\alpha)(4 \alpha-3) s^{2}+2\left(\left(4 \alpha^{2}-4 \alpha\right) n+4 \alpha^{2}-9 \alpha+9\right) s \\
& +(2-2 \alpha) n^{2}-\left(4 \alpha^{2}-10 \alpha+10\right) n-3 \alpha+9
\end{aligned}
$$

Recall that $\frac{3}{4}<\alpha<1$ and $n \geq f(\alpha)=\frac{5}{1-\alpha}+1>\frac{5}{1-\alpha}$. By a simple calculation, we obtain

$$
\begin{aligned}
\left.\frac{\partial \Phi_{2}(s, n)}{\partial s}\right|_{s=2} & =(2-2 \alpha) n^{2}+\left(12 \alpha^{2}-6 \alpha-10\right) n-80 \alpha^{2}+129 \alpha-27 \\
& >(2-2 \alpha)\left(\frac{5}{1-\alpha}\right)^{2}+\left(12 \alpha^{2}-6 \alpha-10\right)\left(\frac{5}{1-\alpha}\right)-80 \alpha^{2}+129 \alpha-27 \\
& =\frac{1}{1-\alpha}\left(80 \alpha^{3}-149 \alpha^{2}+126 \alpha-27\right) \\
& >0
\end{aligned}
$$

and

$$
\begin{aligned}
\left.\frac{\partial \Phi_{2}(s, n)}{\partial s}\right|_{s=\frac{n-1}{3}} & =\frac{1}{3}\left(\left(4 \alpha^{2}-8 \alpha\right) n-16 \alpha^{2}+23 \alpha+3\right) \\
& <\frac{1}{3}\left(\left(4 \alpha^{2}-8 \alpha\right)\left(\frac{5}{1-\alpha}\right)-16 \alpha^{2}+23 \alpha+3\right) \\
& =\frac{1}{3(1-\alpha)}\left(16 \alpha^{3}-19 \alpha^{2}-20 \alpha+3\right)
\end{aligned}
$$

$<0$.
This implies that $\varphi_{2}(n-3)=\Phi_{2}(s, n) \geq \min \left\{\Phi_{2}(2, n), \Phi_{2}\left(\frac{n-1}{3}, n\right)\right\}$ because the leading coefficient of $\Phi_{2}(s, n)$ (view as a cubic polynomial of $s$ ) is positive, and $2 \leq s \leq \frac{n-1}{3}$. In light of $\frac{3}{4}<\alpha<1$ and $n \geq f(\alpha)=\frac{5}{1-\alpha}+1>\frac{5}{1-\alpha}$, we have

$$
\Phi_{2}(2, n)=(1-\alpha) n^{2}+\left(8 \alpha^{2}-4 \alpha-5\right) n-48 \alpha^{2}+70 \alpha-12
$$

$$
\begin{aligned}
& >(1-\alpha)\left(\frac{5}{1-\alpha}\right)^{2}+\left(8 \alpha^{2}-4 \alpha-5\right)\left(\frac{5}{1-\alpha}\right)-48 \alpha^{2}+70 \alpha-12 \\
& =\frac{1}{1-\alpha}\left(48 \alpha^{3}-78 \alpha^{2}+62 \alpha-12\right) \\
& >0
\end{aligned}
$$

and

$$
\begin{aligned}
\Phi_{2}\left(\frac{n-1}{3}, n\right)= & \frac{1}{27}\left(\left(4 \alpha^{2}-16 \alpha+12\right) n^{3}+\left(-24 \alpha^{2}+144 \alpha-144\right) n^{2}\right. \\
& \left.+(-249 \alpha+504) n+20 \alpha^{2}-14 \alpha-534\right) \\
> & \frac{1}{27}\left(\left(4 \alpha^{2}-16 \alpha+12\right)\left(\frac{5}{1-\alpha}\right)^{3}+\left(-24 \alpha^{2}+144 \alpha-144\right)\left(\frac{5}{1-\alpha}\right)^{2}\right. \\
& \left.+(-249 \alpha+504)\left(\frac{5}{1-\alpha}\right)+20 \alpha^{2}-14 \alpha-534\right) \\
= & \frac{1}{27(1-\alpha)^{2}}\left(20 \alpha^{4}-54 \alpha^{3}+159 \alpha^{2}+389 \alpha-114\right) \\
> & 0
\end{aligned}
$$

Hence, we have $\varphi_{2}(n-3) \geq \min \left\{\Phi_{2}(2, n), \Phi_{2}\left(\frac{n-1}{3}, n\right)\right\}>0$ for $2 \leq s \leq \frac{n-1}{3}$. As $\eta=\eta(n)=$ $\rho_{\alpha}\left(K_{1} \vee\left(K_{n-3} \cup 2 K_{1}\right)\right)>n-3>\beta_{2}$ (see (3.6)), we conclude $\rho_{\alpha}(G)<\eta(n)$ for $2 \leq s \leq \frac{n-1}{3}$, which is a contradiction to $\rho_{\alpha}(G)>\eta(n)$.
Subcase 2.2.1.2. $n_{1}=0$.
In this subcase, $G=K_{s} \vee(2 s-1) K_{1}$ and $n=3 s-1$. The quotient matrix of $A_{\alpha}(G)$ by the partition $V(G)=V\left(K_{s}\right) \cup V\left((2 s-1) K_{1}\right)$ equals

$$
B_{3}=\left(\begin{array}{cc}
2 \alpha s+s-\alpha-1 & (1-\alpha)(2 s-1) \\
(1-\alpha) s & \alpha s
\end{array}\right)
$$

By a direct computation, we get the characteristic polynomial of $B_{3}$ as

$$
\varphi_{3}(x)=x^{2}-(3 \alpha s+s-\alpha-1) x+5 \alpha s^{2}-2 s^{2}-3 \alpha s+s
$$

Since the partition $V(G)=V\left(K_{s}\right) \cup V\left((2 s-1) K_{1}\right)$ is equitable, it follows from Lemma 2.5 that $\rho_{\alpha}(G)$ is the largest root of $\varphi_{3}(x)=0$. Note that $n=3 s-1$. By a direct computation, we obtain

$$
\varphi_{3}(n-3)=\varphi_{3}(3 s-4)=(4-4 \alpha) s^{2}+(12 \alpha-16) s-4 \alpha+12
$$

If $0 \leq \alpha \leq \frac{1}{2}$, then $n=3 s-1 \geq f(\alpha)=14$. Thus, we infer $s \geq 5$, and so

$$
\begin{aligned}
\varphi_{3}(n-3) & =(4-4 \alpha) s^{2}+(12 \alpha-16) s-4 \alpha+12 \\
& \geq 5(4-4 \alpha) s+(12 \alpha-16) s-4 \alpha+12 \\
& =(4-8 \alpha) s-4 \alpha+12 \\
& \geq 5(4-8 \alpha)-4 \alpha+12 \\
& =32-44 \alpha
\end{aligned}
$$

$>0$.

If $\frac{1}{2}<\alpha \leq \frac{2}{3}$, then $n=3 s-1 \geq f(\alpha)=17$. Thus, we have $s \geq 6$, and so

$$
\begin{aligned}
\varphi_{3}(n-3) & =(4-4 \alpha) s^{2}+(12 \alpha-16) s-4 \alpha+12 \\
& \geq 6(4-4 \alpha) s+(12 \alpha-16) s-4 \alpha+12 \\
& =(8-12 \alpha) s-4 \alpha+12 \\
& \geq 6(8-12 \alpha)-4 \alpha+12 \\
& =60-76 \alpha \\
& >0
\end{aligned}
$$

If $\frac{2}{3}<\alpha \leq \frac{3}{4}$, then $n=3 s-1 \geq f(\alpha)=20$. Thus, we get $s \geq 7$, and so

$$
\begin{aligned}
\varphi_{3}(n-3) & =(4-4 \alpha) s^{2}+(12 \alpha-16) s-4 \alpha+12 \\
& \geq 7(4-4 \alpha) s+(12 \alpha-16) s-4 \alpha+12 \\
& =(12-16 \alpha) s-4 \alpha+12 \\
& \geq 7(12-16 \alpha)-4 \alpha+12 \\
& =96-116 \alpha \\
& >0
\end{aligned}
$$

If $\frac{3}{4}<\alpha<1$, then $n=3 s-1 \geq f(\alpha)=\frac{5}{1-\alpha}+1$. Thus, we deduce $s \geq \frac{5}{3(1-\alpha)}+\frac{2}{3}$, and so

$$
\begin{aligned}
\varphi_{3}(n-3) & =(4-4 \alpha) s^{2}+(12 \alpha-16) s-4 \alpha+12 \\
& \geq(4-4 \alpha)\left(\frac{5}{3(1-\alpha)}+\frac{2}{3}\right) s+(12 \alpha-16) s-4 \alpha+12 \\
& =\frac{1}{3}((28 \alpha-20) s-12 \alpha+36) \\
& \geq \frac{1}{3}\left((28 \alpha-20)\left(\frac{5}{3(1-\alpha)}+\frac{2}{3}\right)-12 \alpha+36\right) \\
& =\frac{1}{9(1-\alpha)}\left(-20 \alpha^{2}+92 \alpha-32\right) \\
& >0
\end{aligned}
$$

From the discussion above, we conclude $s \geq 5$ and $\varphi_{3}(n-3)>0$. Next, we consider the derivative of $\varphi_{3}(x)$, we have $\varphi_{3}^{\prime}(x)=2 x-(3 \alpha s+s-\alpha-1)$. It follows from $s \geq 5$ and $n=3 s-1$ that

$$
\begin{aligned}
\varphi_{3}^{\prime}(n-3) & =2(n-3)-(3 \alpha s+s-\alpha-1) \\
& =(5-3 \alpha) s+\alpha-7 \\
& \geq 5(5-3 \alpha)+\alpha-7 \\
& =18-14 \alpha
\end{aligned}
$$

$>0$.

Combining this with $\varphi_{3}(n-3)>0$ and $\eta(n)>n-3$, we conclude $\rho_{\alpha}(G)<n-3<\eta(n)$ for $s \geq 5$, which contradicts $\rho_{\alpha}(G)>\eta(n)$.
Subcase 2.2.2. $i(G-S)=2 s$.

In this subcase, $G=K_{s} \vee\left(K_{n_{1}} \cup 2 s K_{1}\right)$. If $n_{1} \geq 2$, then $n=3 s+n_{1} \geq 3 s+2$. By a similar proof as that of Subcase 2.1 above, we have $\rho_{\alpha}(G)<\eta(n)$ for $2 \leq s \leq \frac{n-2}{3}$, which contradicts $\rho_{\alpha}(G)>\eta(n)$.

If $n_{1}=0$, then $G=K_{s} \vee 2 s K_{1}$ and $n=3 s$. Consider the partition $V(G)=V\left(K_{s}\right) \cup V\left(2 s K_{1}\right)$. The corresponding quotient matrix of $A_{\alpha}(G)$ equals

$$
B_{4}=\left(\begin{array}{cc}
2 \alpha s+s-1 & 2 s(1-\alpha) \\
(1-\alpha) s & \alpha s
\end{array}\right)
$$

The characteristic polynomial of $B_{4}$ is

$$
\varphi_{4}(x)=x^{2}-(3 \alpha s+s-1) x+5 \alpha s^{2}-2 s^{2}-\alpha s
$$

Since the partition $V(G)=V\left(K_{s}\right) \cup V\left(2 s K_{1}\right)$ is equitable, it follows from Lemma 2.5 that $\rho_{\alpha}(G)$ is the largest root of $\varphi_{4}(x)=0$. Notice that $n=3 s$. By a simple calculation, we get

$$
\varphi_{4}(n-3)=\varphi_{4}(3 s-3)=(4-4 \alpha) s^{2}+(8 \alpha-12) s+6
$$

If $0 \leq \alpha \leq \frac{2}{3}$, then $n=3 s \geq f(\alpha) \geq 14$. Thus, we have $s \geq 5$, and so

$$
\begin{aligned}
\varphi_{4}(n-3) & =(4-4 \alpha) s^{2}+(8 \alpha-12) s+6 \\
& \geq 5(4-4 \alpha) s+(8 \alpha-12) s+6 \\
& =(8-12 \alpha) s+6 \\
& \geq 5(8-12 \alpha)+6 \\
& =46-60 \alpha \\
& >0
\end{aligned}
$$

If $\frac{2}{3}<\alpha \leq \frac{3}{4}$, then $n=3 s \geq f(\alpha)=20$. Thus, we conclude $s \geq 7$, and so

$$
\begin{aligned}
\varphi_{4}(n-3) & =(4-4 \alpha) s^{2}+(8 \alpha-12) s+6 \\
& \geq 7(4-4 \alpha) s+(8 \alpha-12) s+6 \\
& =(16-20 \alpha) s+6 \\
& \geq 7(16-20 \alpha)+6 \\
& =118-140 \alpha \\
& >0 .
\end{aligned}
$$

If $\frac{3}{4}<\alpha<1$, then $n=3 s \geq f(\alpha)=\frac{5}{1-\alpha}+1$. Thus, we get $s \geq \frac{5}{3(1-\alpha)}+\frac{1}{3}$, and so

$$
\begin{aligned}
\varphi_{4}(n-3) & =(4-4 \alpha) s^{2}+(8 \alpha-12) s+6 \\
& \geq(4-4 \alpha)\left(\frac{5}{3(1-\alpha)}+\frac{1}{3}\right) s+(8 \alpha-12) s+6 \\
& =\frac{1}{3}((20 \alpha-12) s+18) \\
& \geq \frac{1}{3}\left((20 \alpha-12)\left(\frac{5}{3(1-\alpha)}+\frac{1}{3}\right)+18\right) \\
& =\frac{1}{9(1-\alpha)}\left(-20 \alpha^{2}+78 \alpha-18\right)
\end{aligned}
$$

$$
>0
$$

From the discussion above, we obtain $s \geq 5$ and $\varphi_{4}(n-3)>0$. In what follows, we consider the derivative of $\varphi_{4}(x)$, we get $\varphi_{4}^{\prime}(x)=2 x-(3 \alpha s+s-1)$. According to $s \geq 5$ and $n=3 s$, we obtain

$$
\begin{aligned}
\varphi_{4}^{\prime}(n-3) & =2(n-3)-(3 \alpha s+s-1) \\
& =(5-3 \alpha) s-5 \\
& \geq 5(5-3 \alpha)-5 \\
& =20-15 \alpha \\
& >0
\end{aligned}
$$

Combining this with $\varphi_{4}(n-3)>0$ and $\eta(n)>n-3$, we deduce $\rho_{\alpha}(G)<n-3<\eta(n)$ for $s \geq 5$, which is a contradiction to $\rho_{\alpha}(G)>\eta(n)$. This completes the proof of Theorem 1.2.

## 4 Extremal graphs

In this section, we create a graph to claim that the bound on $A_{\alpha}$-spectral radius established in Theorem 1.1 is sharp.

Theorem 4.1. Let $\alpha \in[0,1)$, and let $\eta(n)$ be the largest root of $x^{3}-((\alpha+1) n+\alpha-4) x^{2}+\left(\alpha n^{2}+\left(\alpha^{2}-\right.\right.$ $2 \alpha-1) n-2 \alpha+1) x-\alpha^{2} n^{2}+\left(5 \alpha^{2}-3 \alpha+2\right) n-10 \alpha^{2}+15 \alpha-8=0$. Then $\rho_{\alpha}\left(K_{n-3} \vee K_{1} \vee \overline{K_{2}}\right)=\eta(n)$ and $K_{n-3} \vee K_{1} \vee \overline{K_{2}}$ is not a $P_{\geq 2}$-factor covered graph if $n \geq f(\alpha)$, where

$$
f(\alpha)= \begin{cases}14, & \text { if } \alpha \in\left[0, \frac{1}{2}\right] \\ 17, & \text { if } \alpha \in\left(\frac{1}{2}, \frac{2}{3}\right] \\ 20, & \text { if } \alpha \in\left(\frac{2}{3}, \frac{3}{4}\right] \\ \frac{5}{1-\alpha}+1, & \text { if } \alpha \in\left(\frac{3}{4}, 1\right)\end{cases}
$$

Proof. We partition the vertex set of the graph $K_{n-3} \vee K_{1} \vee \overline{K_{2}}$ as $V\left(K_{n-3}\right) \cup V\left(K_{1}\right) \cup V\left(\overline{K_{2}}\right)$. Then the quotient matrix of $A_{\alpha}\left(K_{n-3} \vee K_{1} \vee \overline{K_{2}}\right)$ in terms of the partition $V\left(K_{n-3}\right) \cup V\left(K_{1}\right) \cup V\left(\overline{K_{2}}\right)$ can be written as

$$
B\left(K_{n-3} \vee K_{1} \vee \overline{K_{2}}\right)=\left(\begin{array}{ccc}
\alpha(n-1) & (1-\alpha)(n-3) & 2(1-\alpha) \\
1-\alpha & n+\alpha-4 & 0 \\
1-\alpha & 0 & \alpha
\end{array}\right)
$$

whose characteristic polynomial is $x^{3}-((\alpha+1) n+\alpha-4) x^{2}+\left(\alpha n^{2}+\left(\alpha^{2}-2 \alpha-1\right) n-2 \alpha+1\right) x-\alpha^{2} n^{2}+$ $\left(5 \alpha^{2}-3 \alpha+2\right) n-10 \alpha^{2}+15 \alpha-8$. Since the partition is equitable, it follows from Lemma 2.5 that the largest root $\eta(n)$ of $x^{3}-((\alpha+1) n+\alpha-4) x^{2}+\left(\alpha n^{2}+\left(\alpha^{2}-2 \alpha-1\right) n-2 \alpha+1\right) x-\alpha^{2} n^{2}+\left(5 \alpha^{2}-3 \alpha+\right.$ 2) $n-10 \alpha^{2}+15 \alpha-8=0$ is equal to the $A_{\alpha}$-spectral radius of the graph $K_{n-3} \vee K_{1} \vee \overline{K_{2}}$, that is to say, $\rho_{\alpha}\left(K_{n-3} \vee K_{1} \vee \overline{K_{2}}\right)=\eta(n)$. Write $S=V\left(K_{1}\right)$. Then $i\left(K_{n-3} \vee K_{1} \vee \overline{K_{2}}-S\right)=2>1=2|S|-1$. According to Lemma 2.2 (ii), we know that the graph $K_{n-3} \vee K_{1} \vee \overline{K_{2}}$ is not a $P_{\geq 2}$-factor covered graph. Theorem 4.1 is proved.
