SPECTRUM OF RANDOM CENTROSYMMETRIC MATRICES; CLT AND CIRCULAR LAW

Abstract. We analyze the asymptotic fluctuations of linear eigenvalue statistics of random centrosymmetric matrices with i.i.d. entries. We prove that for a complex analytic test function, the centered and normalized linear eigenvalue statistics of random centrosymmetric matrices converge to a normal distribution. We find the exact expression of the variance of the limiting normal distribution via combinatorial arguments. Moreover, we also argue that the limiting spectral distribution of properly scaled centrosymmetric matrices follows the circular law.

keywords: Centrosymmetric matrix, Linear eigenvalue statistics, Central limit theorem, Circular law.

1. INTRODUCTION

Let M be an $n \times n$ matrix with real or complex entries. The empirical spectral distribution (ESD) is defined by the measure

$$
\mu_n(\cdot) = \frac{1}{n} \sum_{i=1}^n \delta_{\lambda_i}(\cdot),
$$

where $\lambda_1, \lambda_2, \ldots, \lambda_n$ are the eigenvalues of the matrix M, and $\delta_x(\cdot)$ is the point measure at $x \in \mathbb{C}$. The linear eigenvalue statistics (LES) of M corresponding to a test function f is defined by

$$
L(f) = \sum_{k=1}^{n} f(\lambda_k).
$$

The function f is referred to as the test function. The asymptotic behaviour of $\mu_n(\cdot)$ and $a_n(L(f)-b_n)$ for some sequences $\langle a_n \rangle$ and $\langle b_n \rangle$ have been studied in depth for different types of random matrices. We give a brief overview below.

Jonsson [\[20\]](#page-27-0) established the central limit theorem (CLT) for LES in Wishart matrices. Subsequently, researchers extensively studied the fluctuation of eigenvalues of various random matrices. Some of the key contributions include Johansson [\[19\]](#page-27-1), Sinai and Soshnikov [\[32\]](#page-27-2), Bai and Silverstein [\[5\]](#page-26-0), Lytova and Pastur [\[24\]](#page-27-3), Shcherbina [\[29\]](#page-27-4). Furthermore, the same has been studied for several structured matrices, such as band and sparse matrices [\[4,](#page-26-1) [22,](#page-27-5) [30,](#page-27-6) [18\]](#page-27-7), Toepliz and band Toeplitz matrices [\[10,](#page-26-2) [23\]](#page-27-8), circulant matrices [\[1,](#page-26-3) [2,](#page-26-4) [25\]](#page-27-9).

The CLT of LES for non-Hermitian matrices have been studied in different set ups as well; such as when the test function is analytic [\[27,](#page-27-10) [26,](#page-27-11) [17\]](#page-27-12), the test function is non-analytic but the moments of the matrix entries match with that of a Ginibre ensemble up to fourth

moment [\[21\]](#page-27-13). Later, it was generalized for continuous bounded test functions [\[13,](#page-26-5) [11,](#page-26-6) [12\]](#page-26-7). A more comprehensive list of recent results can be found on the review article by Forrester $|16|$.

In this article, we study the spectral properties of random centrosymmetric matrices. A centrosymmetric matrix is symmetric around its center which is formally defined in the Definition [3.1.](#page-1-0) Centrosymmetric matrices appeared in many different contexts in mathematics, such as solutions to chessboard separation problems [\[9\]](#page-26-8), stochastic matrices [\[8\]](#page-26-9), and in various other contexts [\[15,](#page-27-15) [33,](#page-27-16) [28,](#page-27-17) [6\]](#page-26-10). However, to the best of our knowledge the spectral properties of random centrosymmetric matrices have not been studied yet. In this paper, we investigate the limiting ESD of a random centrosymmetric matrix and the fluctuations of the LES.

2. NOTATIONS AND LAYOUT

This article is organized as follows. We state the main theorem in Section [3.](#page-1-1) The proof of the CLT is shown in Section [6,](#page-5-0) and the variance calculation of the limiting normal distribution is delegated to Section [7.](#page-16-0) In addition, it was also argued that the limiting spectral distribution follows the circular law, which was demonstrated in Section [5.](#page-4-0)

Throughout this article, the identity matrix is denoted by I , and the counter-identity matrix is denoted by J, as defined in Definition [4.1.](#page-3-0) The dimensions of such matrices should be understood from the context. The eigenvalues of an $n \times n$ matrix M are denoted by $\lambda_1(M)$, $\lambda_2(M)$, ..., $\lambda_n(M)$. The complex conjugate transpose of a matrix Y is denoted by Y^* , whereas \hat{Y} stands for only the complex conjugate of Y without taking transpose. The notation $\mathcal{R}_z(M) = (zI - M)^{-1}$ represents the resolvent of a square matrix M. The notations $\zeta_n \stackrel{d}{\to} \zeta$, $\zeta_n \stackrel{p}{\to} \zeta$, and $\zeta_n \stackrel{a.s.}{\to} \zeta$ are used to indicate that the sequence of random variables $\{\zeta_n\}_n$ converges to ζ in distribution, in probability, and almost surely, respectively.

For any random variable ξ , ξ° denotes the centered random variable $\xi - \mathbb{E}[\xi]$. Moreover, if ξ depends on a random matrix, then $\xi_k^{\circ} := \xi - \Xi_k[\xi]$, where $\Xi_k[\cdot]$ signifies averaging with respect to the k-th column of the underlying random matrix.

The vectors e_1, e_2, \ldots, e_n denote the canonical basis vectors of \mathbb{R}^n . The disc of radius r, denoted by \mathbb{D}_r , is the set $\{z \in \mathbb{C} : |z| \leq r\}$, and its boundary is denoted by $\partial \mathbb{D}_r$. The notations K or C are used to denote a universal constant whose exact value may change from line to line.

3. Main result

Let us first define the centrosymmetric matrix.

Definition 3.1 (Centrosymmetric Matrix). A random Centrosymmetric matrix is a random matrix which is symmetric about its center. Formally, let $M = [m_{i,j}]_{n \times n}$ be a random matrix, where m_{ij} are i.i.d. random variables subject to the following constraint

$$
m_{i,j} = m_{n-i+1,n-j+1}
$$
 for $i, j \in \{1, ..., n\}.$

Then M is called a random centrosymmetric matrix.

Definition 3.2 (Poincaré inequality). A complex random variable ζ is said to satisfy the Poincaré inequality with a positive constant α if for any differentiable function $g : \mathbb{C} \to \mathbb{C}$, we have $Var(g(\zeta)) \leq \frac{1}{\alpha}$ $\frac{1}{\alpha}\mathbb{E}[\tilde{g}'(\zeta)|^2]$. Here, $\mathbb C$ is identified with \mathbb{R}^2 and $|g'(\zeta)|$ represents the

 ℓ^2 norm of the two dimensional vector g'. Here are some characteristics of the Poincaré inequality.

- (1) If ζ satisfies the Poincaré inequality with constant α , then $\kappa\zeta$ also satisfies the Poincaré inequality with constant α/κ^2 for any nonzero real constant κ .
- (2) If two independent random variables ζ_1, ζ_2 satisfy the Poincaré inequality with the same constant α , then $\zeta = (\zeta_1, \zeta_2)$ also satisfies the Poincaré inequality with the same constant α . Here ζ is treated as a random vector and, accordingly, g' in the definition of Poincaré inequality will be replaced by ∇g .
- (3) [\[3,](#page-26-11) Lemma 4.4.3] If $\zeta \in \mathbb{C}^n$ satisfies the Poincaré inequality with a constant α , then for any differentiable function $g: \mathbb{C}^n \to \mathbb{C}$,

$$
\mathbb{P}(|g(\zeta) - \mathbb{E}[g(\zeta)]| > t) \leq C \exp\left\{-\frac{\sqrt{\alpha}t}{\sqrt{2}||\|\nabla g\|_2\|_{\infty}}\right\},\,
$$

where $C = -2\sum_{k=1}^{\infty} 2^k \log(1 - 2^{-2k-1})$. Here \mathbb{C}^n is identified with \mathbb{R}^{2n} . Moreover, $\|\nabla g(x)\|_2$ is the ℓ^2 norm of the $2n$ dimensional vector $\nabla g(x)$ at $x \in \mathbb{C}^n$, and $\|\|\nabla g\|_2\|_{\infty} = \sup_{x \in \mathbb{C}^n} \|\nabla g(x)\|_2.$

For instance, a Gaussian random variable satisfies the Poincaré inequality.

Condition 3.3. Let $M = [m_{ij}]_{n \times n}$ be a centrosymmetric matrix, where

$$
m_{ij} = \frac{1}{\sqrt{n}} x_{ij}.
$$

Assume that $\{x_{ij} : 1 \le i, j \le n\}$ are i.i.d. complex random variables subject to the constraint $x_{ij} = x_{n+1-i,n+1-j}$. In addition, x_{ij} s satisfy the following conditions.

- (i) $\mathbb{E}[x_{ij}] = 0, \mathbb{E}[x_{ij}^2] = 0$ and $\mathbb{E}[|x_{ij}|^2] = 1$ for all $1 \le i, j \le n$,
- (ii) x_{ij} are continuous random variables with bounded density and satisfy the Poincaré inequality with some universal constant α .

Before stating our main theorem, let us define the centered LES as

$$
L_f^{\circ}(M) = \sum_{k=1}^n f(\lambda_k(M)) - \sum_{k=1}^n \mathbb{E}[f(\lambda_k(M))].
$$

Our main theorem is stated as follows.

Theorem 3.4. Suppose M is a centrosymmetric random matrix satisfying Condition [3.3.](#page-2-0) Let $f: \mathbb{C} \to \mathbb{C}$ be an analytic function. Then L_f° $f_f^{\circ}(M) \stackrel{d}{\rightarrow} N(0, \sigma_f^2)$, where

$$
\sigma_f^2 = \frac{2}{\pi} \int_{\mathbb{D}_1} f(w) \overline{f'(w)} \, d\mathfrak{R}(w) d\mathfrak{I}(w).
$$

In particular, if f is a polynomial given by $P_d(z) = \sum_{k=0}^d a_k z^k$, then $\sigma_p^2 = \sum_{k=1}^d 2k |a_k|^2$.

4. Truncation and reduction

Before proceeding to the technical proof of the main theorem, we need to recall one important theorem regarding centrosymmetric matrices.

Definition 4.1 (Counter-identity Matrix). It is defined as the square matrix whose counterdiagonal elements are 1 and all the other elements are zero.

Throughout this article, we shall denote the counter-identity matrix by J . The size of J should be understood from the context. Notice that

$$
J = J^T, \quad J^2 = I,
$$

where I the identity matrix of the same dimension. Now, we invoke the following theorem, which reduces the centrosymmetric matrix to a block diagonal matrix.

Theorem 4.2. [\[35,](#page-27-18) Theorem 9]

(a) If $M =$ $\left(\begin{array}{cc} A & B \\ C & D \end{array}\right)$ is an $n \times n$ centrosymmetric matrix with $n = 2s$ and A, B, C , and D are $s \times s$ matrices, then M is orthogonally similar to

$$
Q^T M Q = \left(\begin{array}{cc} A + JC & 0 \\ 0 & A - JC \end{array} \right),
$$

where

$$
Q = \sqrt{\frac{1}{2}} \left(\begin{array}{cc} I & -J \\ J & I \end{array} \right).
$$

(b) If $M =$ $\sqrt{ }$ $\overline{1}$ $A \quad x \quad B$ $y \quad q \quad yJ$ C Jx D \setminus is an $n \times n$ centrosymmetric matrix with $n = 2s + 1$, and

 A, B, C, D are $s \times s$ matrices, x is $s \times 1$ matrix, y is $1 \times s$ matrix, and q is a scalar, then M is orthogonally similar to

$$
Q^{T}MQ = \begin{pmatrix} A + JC & \sqrt{2}x & 0 \\ \sqrt{2}y & q & 0 \\ 0 & 0 & A - JC \end{pmatrix},
$$

where

$$
Q = \sqrt{\frac{1}{2}} \begin{pmatrix} I & 0 & -J \\ 0 & \sqrt{2} & 0 \\ J & 0 & I \end{pmatrix}.
$$

In the definitions of Q above, I is an $s \times s$ identity matrix and J is an $s \times s$ counter-identity matrix. Moreover, notice that in both the cases $Q^T Q = I = Q Q^T$.

Since the Q^TMQ is orthogonally similar to the matrix M, the eigenvalues of Q^TMQ are the same as those of M . The remaining part of this article analyses the eigenvalues of Q^TMQ . For convenience, we adopt the following simplified notation for Q^TMQ .

$$
Q^T M Q = \left[\begin{array}{cc} T_1 & 0 \\ 0 & T_2 \end{array} \right],
$$

where $T_2 = A - JC$ and

$$
T_1 = \begin{cases} A + JC & \text{if } n = 2s \\ \begin{pmatrix} A + JC & \sqrt{2}x \\ \sqrt{2}y & q \end{pmatrix} & \text{if } n = 2s + 1. \end{cases}
$$

Though the above theorem reduces the centrosymmetric matrix to a block diagonal matrix, the block matrices are not independent. Therefore, we need to take care of the dependence structure in the course of the proof.

5. Circular Law for Random Centrosymmetric Matrix

Let us first state the general circular law.

Theorem 5.1 (Circular Law, [\[34\]](#page-27-19)). Consider a random matrix $M = \frac{1}{\sqrt{2}}$ $\frac{1}{n}[x_{ij}]_{i,j=1}^n$, where $x_{ij}s$ are i.i.d. random variables with mean zero and variance 1. Then, as $n \to \infty$, the ESD of M converges almost surely to the uniform distribution on the unit disc of $\mathbb C$ with density 1 $\frac{1}{\pi}1_{\{z\in\mathbb{C} \;|\; |z|\leq 1\}}.$

Now, let us state the circular law for random centrosymmetric matrix.

Theorem 5.2 (Circular Law for Random Centrosymmetric Matrix). Consider a random centrosymmetric matrix $M = \frac{1}{\sqrt{2}}$ $\frac{1}{\overline{n}}[x_{ij}]_{i,j=1}^n$, where $x_{ij}s$ are i.i.d. random variables for $i \leq j$ with mean zero and variance 1. Then, as $n \to \infty$, the ESD of M converges almost surely to the uniform distribution on the unit disc of $\mathbb C$ with density $\frac{1}{\pi} 1_{\{z \in \mathbb C \mid |z| \leq 1\}}$.

Proof. We have a centrosymmetric matrix $M = \frac{1}{\sqrt{2}}$ $\frac{1}{\overline{n}}[x_{ij}]_{i,j=1}^n$, where x_{ij} s are i.i.d. centered random variables with variance 1.

From Theorem [4.2,](#page-3-1) it is evident that the eigenvalues of M are the eigenvalues of T_1 and T_2 . The entries of T_1 and T_2 are i.i.d. centered random variables having variance 2. However, sizes of T_1 and T_2 is $\lceil n/2 \rceil \times \lceil n/2 \rceil$, and they are scaled by $1/\sqrt{n}$. Hence, by Theorem [5.1](#page-4-1) the ESD of T_1 converges to the circular law. The same applies to T_2 as well. Hence, ESD of the matrix M converges to the circular law.

□

6. Proof of the central limit theorem

In Section [5,](#page-4-0) we have seen that the limiting ESD follows the circular law. However, for any finite n , there might be some eigenvalues outside the unit disc. To avoid such situations, we shall work on the event where the eigenvalues are confined within a disc of finite radius. Keeping this in mind, we define the event

(6.1)
$$
\Omega_n = \{ \|T_1\| \le \rho_1 \} \cap \{ \|T_2\| \le \rho_2 \},
$$

where ρ_1 and ρ_2 are same as ρ , given in Lemma [A.2.](#page-25-0) Additionally, Lemma [A.2](#page-25-0) also implies that

(6.2)
$$
P(\Omega_n^c) \le K \exp\left(-\sqrt{\frac{\alpha n}{2}} \frac{3\rho_m}{4}\right), \text{ where } \rho_m = \min\{\rho_1, \rho_2\}.
$$

Let us denote $\rho = \max\{\rho_1, \rho_2\}$. If f is a complex analytic function on $\partial \mathbb{D}_{\rho+\tau}$, then we can express $L_n(f)$ on the event Ω_n as follows

$$
L_f(M) = \sum_{i=1}^n f(\lambda_i(M))
$$

=
$$
\frac{1}{2\pi i} \oint_{\partial \mathbb{D}_{\rho+\tau}} \sum_{i=1}^n \frac{f(z)}{z - \lambda_i(M)} dz
$$

=
$$
\frac{1}{2\pi i} \oint_{\partial \mathbb{D}_{\rho+\tau}} f(z) \operatorname{Tr} \mathcal{R}_z(M) dz.
$$

The above represents $L_f(M)$ in terms of the resolvent of the matrix. This brings down our task to the analysis of the resolvent. However, to keep the norm of the resolvent bounded, we need to restrict our attention to the event Ω_n , where norms of T_1, T_2 are bounded. From the probability estimate [\(6.2\)](#page-5-1) and the Lemma [A.2,](#page-25-0) we may express the centered linear eigenvalue statistic as follows.

$$
L_f^{\circ}(M) = \frac{1}{2\pi i} \oint_{\partial \mathbb{D}_{\rho+\tau}} f(z) \operatorname{Tr} \hat{\mathcal{R}}_z^{\circ}(M) dz + o(1).
$$

where $\hat{\xi} = \xi 1_{\Omega_n}$, and $\xi^{\circ} = \xi - \mathbb{E}[\xi]$. The $o(1)$ at the end of the above expression can further be explained as follows.

We can rewrite

$$
\operatorname{Tr} \mathcal{R}_z^{\circ}(M) = \operatorname{Tr} \hat{\mathcal{R}}_z^{\circ}(M) + \operatorname{Tr} \mathcal{R}_z(M) 1_{\Omega_n^c} - \mathbb{E}[\operatorname{Tr} \mathcal{R}_z(M) 1_{\Omega_n^c}].
$$

We will demonstrate that $\text{Tr } \mathcal{R}_z(M) 1_{\Omega_n^c} - \mathbb{E}[\text{Tr } \mathcal{R}_z(M) 1_{\Omega_n^c}] = o(1)$. First, let us prove that $\text{Tr } \mathcal{R}_z(M) 1_{\Omega_n^c} = o(1)$. Since we are dealing with continuous random variables, almost surely there is no eigenvalue on the circle $\partial \mathbb{D}_{\rho+\tau}$. Therefore, $\sup_{z\in \partial \mathbb{D}_{\rho+\tau}}|\operatorname{Tr} \mathcal{R}_z(M)|$ is bounded almost surely. Consequently, we conclude

$$
\mathbb{P}\left(\sup_{z\in\partial\mathbb{D}_{\rho+\tau}}|\operatorname{Tr}\mathcal{R}_z(M)\mathbb{1}_{\Omega_n^c}|>\epsilon\right)\leq \mathbb{P}(\Omega_n^c)\to 0 \text{ as } n\to\infty.
$$

Next, we prove that $\mathbb{E}[\text{Tr } \mathcal{R}_z(M)1_{\Omega_n^c}] \to 0$ asymptotically. We note that the assumptions listed in Condition [3.3](#page-2-0) are consistent with the assumptions of the Lemma [A.3.](#page-26-12) Hence, using the Lemma [A.3,](#page-26-12) and the bound [\(6.2\)](#page-5-1) we may conclude that

$$
\mathbb{E}[\text{Tr }\mathcal{R}_z(M)1_{\Omega_n^c}] \leq \mathbb{E}[|\text{Tr }\mathcal{R}_z(M)|] \mathbb{P}(\Omega_n^c)
$$

$$
\leq Cn^{7/2} \exp\left(-\sqrt{\frac{\alpha n}{2}} \frac{3\rho_m}{4}\right)
$$

$$
\to 0 \text{ as } n \to \infty.
$$

Furthermore, standard use of complex analysis shows that

$$
\frac{1}{\pi} \int_{\mathbb{D}_1} f'(w) \overline{f'(w)} d\mathfrak{R}(w) d\mathfrak{I}(w)
$$
\n
$$
= \frac{1}{\pi} \int_{\mathbb{D}_1} \left[\frac{1}{2\pi i} \oint_{\partial \mathbb{D}_1} \frac{f(z) dz}{(w - z)^2} \frac{1}{2\pi i} \oint_{\partial \mathbb{D}_1} \frac{f(\bar{\eta}) d\bar{\eta}}{(\bar{w} - \bar{\eta})^2} \right] d\mathfrak{R}(w) d\mathfrak{I}(w)
$$
\n
$$
= -\frac{1}{4\pi^2} \oint_{\partial \mathbb{D}_1} \oint_{\partial \mathbb{D}_1} f(z) \overline{f(\eta)} \left[\frac{1}{\pi} \int_{\mathbb{D}_1} \frac{d\mathfrak{R}(w) d\mathfrak{I}(w)}{(w - z)^2 (\bar{w} - \bar{\eta})^2} \right] dz d\bar{\eta}
$$
\n
$$
= -\frac{1}{4\pi^2} \oint_{\partial \mathbb{D}_1} \oint_{\partial \mathbb{D}_1} \frac{f(z) \overline{f(\eta)}}{(1 - z\bar{\eta})^2} dz d\bar{\eta}.
$$

Hence, the main Theorem [3.4](#page-3-2) is essentially the same as proving Proposition [6.1.](#page-6-0)

Proposition 6.1. The sequence ${\rm Tr} \hat{\mathcal{R}}_z^{\circ}(M)$, is tight in the space $\mathcal{C}(\partial \mathbb{D}_{\rho+\tau})$, which is the space of continuous function on $\partial \mathbb{D}_{\rho+\tau}$, and converges in distribution to a Gaussian process with covariance kernel given by $2(1-z\bar{\eta})^{-2}$.

Our first goal is to reduce the above proposition to (6.5) , (6.6) , (6.7) . First of all, by Cramer-Wold device, to show finite dimensional convergence it is sufficient to show that for any $\{z_l; 1 \leq l \leq q\} \subset \partial \mathbb{D}_{\rho+\tau}$, and $\{\alpha_l, \beta_l; 1 \leq l \leq q\} \subset \mathbb{C}$ for which

(6.3)
$$
\sum_{l=1}^{q} \left[\alpha_l \operatorname{Tr} \hat{\mathcal{R}}_{z_l}^{\circ}(M) + \beta_l \overline{\operatorname{Tr} \hat{\mathcal{R}}_{z_l}^{\circ}(M)} \right] \mathbf{1}_{\Omega_n}
$$

is real and converges to a Gaussian random variable with mean zero. In order to show this, we use the martingale CLT, which is stated in Lemma [A.4.](#page-26-13) For notaional convenience, we define the relevant conditional expectations with respect to the columns of the matrices T_1 and T_2 . Let $\Xi_k[\xi]$ be the averaging of the random variable ξ over the k-th columns of matrices T_1 and T_2 , and $\mathbb{E}_k[\cdot] = \Xi_{k+1} \Xi_{k+2} \ldots \Xi_{\lceil \frac{n}{2} \rceil}[\cdot] = \Xi_{k+1} \mathbb{E}_{k+1}[\cdot]$. For instance, $\mathbb{E}_0[\cdot] = \mathbb{E}[\cdot]$ and $\mathbb{E}_{\lceil \frac{n}{2} \rceil}[\cdot] = [\cdot]$. Therefore, we can express

$$
\operatorname{Tr} \hat{\mathcal{R}}_z^{\circ}(M) = \operatorname{Tr} \hat{\mathcal{R}}_z^{\circ}(T_1) + \operatorname{Tr} \hat{\mathcal{R}}_z^{\circ}(T_2)
$$

=
$$
\operatorname{Tr} \hat{\mathcal{R}}_z(T_1) - \mathbb{E}[\operatorname{Tr} \hat{\mathcal{R}}_z(T_1)] + \operatorname{Tr} \hat{\mathcal{R}}_z(T_2) - \mathbb{E}[\operatorname{Tr} \hat{\mathcal{R}}_z(T_2)]
$$

$$

where $\xi_k^{\circ} = \xi - \Xi_k[\xi]$. Since $\mathbb{E}_k[\cdot]$ is defined as the conditional expectation given the first k columns of T_1 and T_2 , $(\mathbb{E}_k - \mathbb{E}_{k-1})[\xi]$ forms a martingale difference sequence. Consequently, the sequences ${W_{z,k}(T_1)}_{1 \le k \le \lceil n/2 \rceil}$ and ${W_{z,k}(T_2)}_{1 \le k \le \lceil n/2 \rceil}$ are martingale difference sequences with respect to the filtration $\mathcal{F}_{n,k} = \sigma\{t_j^1, t_j^2 : 1 \leq j \leq k\}$, where t_j^1 and t_j^2 are the jth columns of matrices T_1 and T_2 respectively. Therefore, the sum $W_{z,k}(T_1) + W_{z,k}(T_2)$ also forms a martingale difference sequence with respect to the same filtration $\mathcal{F}_{n,k}$.

where X^* denotes the complex conjugate of the matrix X. As a result, ${\psi_{n,k}}_{1\leq k\leq n/2}$ constitutes a martingale difference sequence with respect to the filtration $\mathcal{F}_{n,k}$. We notice that proving the following equation [\(6.5\)](#page-7-0) is sufficient for the validity of the condition (i) of Lemma [A.4;](#page-26-13)

We defer the calculation of the covariance kernel to Section [7.4.](#page-24-0) Hence, establishing Proposition [6.1](#page-6-0) is equivalent to demonstrating the tightness of the sequence ${\rm Tr} \hat{\mathcal{R}}_z^{\circ}(T_1) + {\rm Tr} \hat{\mathcal{R}}_z^{\circ}(T_2) \}_n$ and verifying the conditions outlined in [\(6.5\)](#page-7-0), [\(6.6\)](#page-8-0), and [\(6.7\)](#page-8-1). Before proceeding any further, let us do some reductions.

For $i = 1, 2$, let $T_i^{(k)}$ be the matrix obtained by zeroing out the kth column of T_i , and let $\hat{\mathcal{R}}_z(T_i^{(k)}$ $\mathcal{R}_i^{(k)}) \,:=\, \mathcal{R}_z(T_i^{(k)})$ $\Omega_{n,k}^{(k)}$) $\mathbf{1}_{\Omega_{n,k}}$, where $\Omega_{n,k} = \left\{ \left\| \mathbf{1}_{\Omega_{n,k}} \right\| \leq k \right\}$ $T_1^{(k)}$ $\left\| \begin{array}{c} \rho(k) \\ 1 \end{array} \right\| \leq \rho_1 \Big\} \cap \left\{ \Biggl\| \begin{array}{c} 0 \end{array} \right\}$ $T_2^{(k)}$ $\left\| \begin{array}{c} \rho_2 \\ \vdots \\ \rho_n \end{array} \right\| \leq \rho_2 \bigg\}$. The space $\Omega_{n,k}$ is different from Ω_n , but asymptotically both the spaces are the same. In fact, we can check that

The important difference between Ω_n and $\Omega_{n,k}$ is that the latter is independent of the k-th columns of T_1 and T_2 , which will allow us to decouple some expectation calculations in future. where $\gamma_{1k}(z) := e_k^t \hat{\mathcal{R}}_z(T_1^{(k)})$ $f_1^{(k)}$) t_k^1 and $\gamma_{2k}(z) := e_k^t \hat{\mathcal{R}}_z(T_2^{(k)})$ $\mathcal{L}_2^{(k)}$) t_k^2 . Now, let us find the tail bounds of $\gamma_{1k}(z)$ and $\gamma_{2k}(z)$. Note that $\gamma_{1k}(z)$ is product of two independent random variables. To prove the tightness of Tr $\hat{\mathcal{R}}_z^{\circ}(T_1)$ we need to show that for any $\epsilon > 0$ there exit a compact set $\mathcal{K}(\epsilon) \subset \mathcal{C}(\partial \mathbb{D}_{\rho+\tau})$ such that

By adopting the same approach as demonstrated in [\(6.9\)](#page-9-2), similar tail estimates for $e_k^t \hat{\mathcal{R}}_z \left(T_1^{(k)} \right)$ $\hat{\mathcal{R}}_{\eta}\left(T_1^{(k)}\right)$ $t_k^{(k)}$ t_k^1 can be obtained possibly with τ^2 or τ^3 in the rhs of [\(6.9\)](#page-9-2). Noting that $|\gamma_{1k}(z)| < n^{-1/8}$ on Φ_n , leveraging the estimate $|(1 + \gamma_{1k}(z))|^{-1} \leq 2$ in $\mathbb{E}[\lvert \vartheta_i(k) \rvert^2]$, we have [\(6.19\)](#page-11-0). Similarly, we can prove the tightness of $\overline{\mathrm{Tr}\, \hat{\mathcal{R}}_z^\circ(T_2)}$.

6.2. **Proof of** [\(6.5\)](#page-7-0). To estimate the right hand side of [\(6.5\)](#page-7-0), we first estimate the term $|W_{z,k}(T_1) + W_{z,k}(T_2)|^4$. We proceed by expanding $\log(1 + \gamma_{k1}(z))$ and $\log(1 + \gamma_{k2}(z))$ up to two terms first, and then using the estimates from (6.9) , (6.10) , (6.13) , and (6.14) we get the bound

+ $|\beta_i|^4 \mathbb{E}[|W_{\bar{z}_i,k}(T_1^*) + W_{\bar{z}_i,k}(T_2^*)|^4])$
= $\theta^{-2}O(n^{-1}),$

which implies (6.5) .

6.3. **Proof of** [\(6.6\)](#page-8-0). Likewise, we can expand $\log(1 + \gamma_{k1}(z))$ and $\log(1 + \gamma_{k2}(z))$ up to two terms and use (6.9) , (6.10) to get the following estimate

 $\mathbb{E}_k \{ \mathbb{E}_k [(\log(1 + \gamma_{1k}(z)) + \log(1 + \gamma_{2k}(z)))_k^{\circ}] \} \mathbb{E}_k [(\log(1 + \gamma_{1k}(\eta)) + \log(1 + \gamma_{2k}(\eta)))_k^{\circ}] \} = O(n^{-2}).$ Thus, using $(6.13),(6.14)$ $(6.13),(6.14)$ and the above we have

= \frac{1}{n} \left(e_k^t \mathbb{E}_k[\hat{\mathcal{R}}_z(T_1^{(k)})] \operatorname{Var}((T_1^{(k)})_{ki}) I \mathbb{E}_k[\hat{\mathcal{R}}_{\bar{\eta}}(T_1^{(k)*}) e_k] \right)
$$
\n
$$
+ \frac{1}{n} \left(e_k^t \mathbb{E}_k[\hat{\mathcal{R}}_z(T_2^{(k)})] \operatorname{Var}((T_2^{(k)})_{ki}) I \mathbb{E}_k[\hat{\mathcal{R}}_{\bar{\eta}}(T_2^{(k)*}) e_k] \right) + O(n^{-2})
$$
\n
$$
=: \frac{1}{n} \Gamma_k(z, \bar{\eta}) + O(n^{-2}),
$$

where $(T_1^{(k)}$ $(T_1^{(k)})_{ij}$ and $(T_2^{(k)})$ $\binom{n(k)}{2}$ _{ij} are the *ij*th element of $T_1^{(k)}$ $T_1^{(k)}$ and $T_2^{(k)}$ $x_2^{(\kappa)}$ respectively.

Consequently, [\(6.7\)](#page-8-1) becomes

Since $\|\hat{\mathcal{R}}_z(T_1^{(k)}\)$ $\hat{\mathcal{R}}_z(T_2^{(k)})+\hat{\mathcal{R}}_z(T_2^{(k)})$ $\mathbb{E}_{2}^{(k)}$) $\|\leq 4\tau^{-1}$ on $\mathbb{D}_{\rho+\tau/2}^{c}$, the sequence $\chi_{k}(z,\bar{\eta})$ consists of uniformly bounded analytic functions on $\mathbb{D}^c_{\rho+\tau/2}$. Thus, by Vitali's theorem (see [\[14,](#page-26-15) Section 2.9]), proving [\(6.7\)](#page-8-1) is equivalent to show that $\chi_k(z, \bar{\eta})$ converges in probability.

Lemma 6.2. Let $\chi_k(z, \bar{\eta})$ be the same as defined in [\(6.20\)](#page-12-0), that is, $\chi_k(z, \bar{\eta}) = \frac{1}{n} \sum_{k=1}^{\lceil n/2 \rceil} \Gamma_k(z, \bar{\eta})$. Then Var $(\chi_k(z, \bar{\eta})) \to 0$ as $n \to \infty$.

= \mathbb{E}\left\{\left(\text{Tr}\,\hat{\mathcal{R}}_z^{\circ}(T_1) + \text{Tr}\,\hat{\mathcal{R}}_z^{\circ}(T_2)\right) \left(\text{Tr}\,\hat{\mathcal{R}}_\eta^{\circ}(T_1^*) + \text{Tr}\,\hat{\mathcal{R}}_\eta^{\circ}(T_2^*)\right)\right\}

= \mathbb{E}\left\{\text{Tr}\,\hat{\mathcal{R}}_z^{\circ}(M)\,\text{Tr}\,\hat{\mathcal{R}}_{\bar{\eta}}^{\circ}(M^*)\right\}.

Let us rewrite $\Gamma_k(z, \bar{\eta})$ as

We shall use the Poincaré inequality to get estimates on Var $\left(\frac{1}{n}\right)$ $\frac{1}{n} \Gamma_k^1(z,\bar{\eta})$. This is shown in the equation [\(6.22\)](#page-14-0). However, since we are working on the event $\Omega_{n,k}$, where norms of the matrices are bounded, some terms may not be differentiable with respect to the matrix entries. To circumvent such a problem, we define a smoothing function as follows.

Let $\epsilon_n = 4/n$, and $\omega_{\epsilon_n,k} : \mathbb{R}^{\lceil n^2/4 \rceil} \to [0,1]$ be a smooth function such that

Let us define the smoothed version of $\mathcal R$ as

So, $\tilde{\Gamma}_k^1(z,\bar{\eta}) = \sum_{s=0}^{\lceil n/2 \rceil} \tilde{\Lambda}_{ks} \tilde{\Upsilon}_{sk}$. Since $x_{ij}s$ satisfy Poincaré inequality, we have

The sum is divided by n because the matrix T_1 is scaled by $1/$ \overline{n} . Moreover, the sum stops at $k-1$ because $\tilde{\Gamma}_k^1(z,\bar{\eta})$ is a constant for $i, j = k, k+1, \ldots, \lceil n/2 \rceil$. On the other hand, we have

\begin{split} &\frac{\partial\tilde{\Lambda}_{ks}}{\partial t_{ij}^1}=\tilde{\Lambda}_{ki}\tilde{\Lambda}_{js}\mathbf{1}_{\{j\neq k\}}+\Lambda_{ks}\frac{\partial\omega_{\epsilon_n,k}}{\partial t_{ij}^1}\mathbf{1}_{\left\{\rho_1<\|T_1^{(k)}\|<\rho_1+\epsilon_n\right\}},\\ &\frac{\partial\tilde{\Upsilon}_{sk}}{\partial t_{ij}^1}=\Upsilon_{sk}\frac{\partial\omega_{\epsilon_n,k}}{\partial t_{ij}^1}\mathbf{1}_{\left\{\rho_1<\|T_1^{(k)}\|<\rho_1+\epsilon_n\right\}},\\ &\frac{\partial\left(\tilde{\Gamma}_k^1(z,\bar{\eta})\right)}{\partial t_{ij}^1}=\sum_{s=0}^{\lceil n/2\rceil}\tilde{\Lambda}_{ki}\tilde{\Lambda}_{js}\tilde{\Upsilon}_{sk}+\sum_{s=0}^{n/2}\left(\Lambda_{ks}\tilde{\Upsilon}_{sk}+\tilde{\Lambda}_{ks}\Upsilon_{sk}\right)\frac{\partial\omega_{\epsilon_n,k}}{\partial t_{ij}^1}\mathbf{1}_{\left\{\rho_1<\|T_1^{(k)}\|<\rho_1+\epsilon_n\right\}}.\end{split}
$$

Let us denote $\tilde{y}_{jk} = \sum_{s=0}^{\lceil n/2 \rceil} \tilde{\Lambda}_{js} \tilde{\Upsilon}_{sk}$. Then using the facts that $\|\tilde{\Lambda}\|, \|\tilde{\Upsilon}\| \leq (\tau - \epsilon_n)^{-1}$, we have

$$

$$
\sum_{i,j=1}^{k-1} \left| \sum_{s=0}^{\lceil n/2 \rceil} \left(\Lambda_{ks} \tilde{\Upsilon}_{sk} + \tilde{\Lambda}_{ks} \Upsilon_{sk} \right) \frac{\partial \omega_{\epsilon_n,k}}{\partial a_{ij}} \mathbf{1}_{\left\{ \left(\rho_1 < \|T_1^{(k)}\| < \rho_1 + \epsilon_n \right\} \right\}} \right|^2
$$
\n
$$
\leq \frac{10}{\epsilon_n^2} \sum_{i,j=1}^{k-1} \left\| \tilde{\Lambda}_k \right\|_2^2 \left\| \tilde{\Upsilon}_k \right\|_2^2 \mathbf{1}_{\left\{ \rho < \|T_1^{(k)}\| < \rho + \epsilon_n \right\}} \leq 10n^4 \left(\tau - \epsilon_n \right)^{-4} \mathbf{1}_{\left\{ \rho_1 < \|T_1^{(k)}\| < \rho_1 + \epsilon_n \right\}}.
$$

Using the above estimates, (6.1) , we have

Therefore from [\(6.21\)](#page-14-1), we obtain

\leq \frac{2}{\alpha n \left(\tau - \epsilon_n\right)^6} + \frac{Kn^3}{\left(\tau - \epsilon_n\right)^4} \exp\left(-\sqrt{\frac{\alpha n}{2}} \frac{3\rho_1}{4}\right) \to 0 \text{ as } n \to \infty.
$$

Similarly, Var $\left(\frac{1}{n}\right)$ $\frac{1}{n} \sum_{k=1}^{\lceil n/2 \rceil} \Gamma_k^2(z, \bar{\eta})$ $\to 0$ as $n \to \infty$. Thus,

\leq 2 \operatorname{Var}\left(\frac{1}{n} \sum_{k=1}^{\lceil n/2 \rceil} \Gamma_k^1(z,\bar{\eta})\right) + 2 \operatorname{Var}\left(\frac{1}{n} \sum_{k=1}^{\lceil n/2 \rceil} \Gamma_k^2(z,\bar{\eta})\right) \to 0, \text{ as } n \to \infty.
$$

□

This completes the proof of the central limit theorem. Now, we demonstrate the calculation of the covariance kernel in Section [7.](#page-16-0) Before that, let us verify this result through a numerical simulation; see Figure [3.](#page-16-1)

FIGURE 3. Histogram of $L^{\circ}(P_d)$ of a 4000 × 4000 random centrosymmetric matrix sampled 1000 times. The entries of the matrix are drawn from the Gaussian distribution, where $P_d(x) = 2x^3 + x^4$.

7. Calculation of variance

This section is dedicated to calculating the covariance kernel. We proceed with the expression of the variance in the case of polynomial test functions.

Proposition 7.1. Let M be the random matrix as defined in Definition [3.1](#page-1-0) satisfying the Condition [3.3.](#page-2-0) Then we have

$$
Var(Tr(P_d(M))) = \sum_{k=1}^d 2k|a_k|^2 + o(1),
$$

where $P_d(x) = \sum_{k=1}^d a_k x^k$ is a polynomial of degree $d \geq 1$.

Notice that, the variance expression does not contain the constant term of the polynomial $P_d(x)$. The constant term of a matrix polynomial will be a constant multiplied by the identity matrix, and this term will not affect the fluctuation result of the LES of a random matrix, as we center the LES by its mean.

We recognize that the essential ingredients are $\mathbb{E}[Tr(M^k) Tr(\bar{M}^l)]$ and $\mathbb{E}[Tr(M^k)]$, where M is obtained by taking complex conjugates of all the entries of M . We compute these quantities using combinatorial arguments. Before proving the Proposition [7.1,](#page-16-2) we introduce and analyze some required notions such as pair partitions and chain merging in the following subsections.

7.1. Analyzing expected product. We evaluate $\mathbb{E}[x_1x_2 \cdots x_n]$, where x_i are random variables from Condition [3.3.](#page-2-0) Note that $\mathbb{E}[x_i^2] = 0$ if x_i satisfies Condition 3.3.

In the next calculations, we need to evaluate the terms of the forms $\mathbb{E}[Tr(M^k)]$ and $\mathbb{E}[\text{Tr}(M^k) \text{Tr}(\bar{M}^l)]$. Upon expansion, the term $\text{Tr}(M^k)$ is represented as $\sum_{i_1,i_2,\dots,i_k=1}^{n} x_{i_1 i_2}$ $x_{i_2i_3}\cdots x_{i_ki_1}$. Notice that here the random variables $x_{i_1i_2}, x_{i_2i_3}, \ldots, x_{i_ki_1}$ are linked via their indices i_1, i_2, \ldots, i_k . The arrangement of these indices plays an important role in evaluating expectations. We formalize this using the notation of *index chain* as defined below.

Definition 7.2 (Index chains). The index chain of the product of random variables $x_{i_1 i_2}$ $x_{i_2i_3} \cdots x_{i_ki_1}$ is the unique sequence $i_1 \rightarrow i_2 \rightarrow \cdots \rightarrow i_k \rightarrow i_1$ of indices.

- (a) Single chain: In the calculation of $\mathbb{E}[Tr(M^k)]$, the indices of the product are chained as $i_1 \rightarrow i_2 \rightarrow \cdots \rightarrow i_k \rightarrow i_1$ which will be referred as single chain.
- (b) Double chain: In the calculation of $\mathbb{E}[Tr(M^k) Tr(\bar{M}^l)]$, there are two chains of indices $i_1 \to i_2 \to \cdots \to i_k \to i_1$ and $j_1 \to j_2 \to \cdots \to j_l \to j_1$ which will be referred as double chain.

In principle, the indices of an index chain can take values from the set $\{1, 2, 3, \ldots, n\}$. However, while calculating $\mathbb{E}[\text{Tr}(M^k)]$ and $\mathbb{E}[\text{Tr}(M^k) \text{Tr}(\bar{M}^l)]$, we shall see that not all the indices are free to be chosen from $\{1, 2, 3, \ldots, n\}$. Some indices will be determined by the choices of the other indices. In this context, we shall use the terms 'degree of freedom' and 'free indices', which are defined in Definition [7.3.](#page-17-0)

Definition 7.3 (Degrees of freedom and free indices). In a given index chain, free indices are the indices which are not constrained by any other index. The degree of freedom represents the number of free indices in a chain.

This will be relevant while calculating the $\mathbb{E}[\text{Tr } M^k]$ or $\mathbb{E}[\text{Tr } M^k \overline{M}^l]$. We shall use the notion of free indices in the remaining part of this section; in particular in the proofs of Lemma [7.4,](#page-17-1) Lemma [7.5,](#page-22-0) and Lemma [7.6.](#page-23-0)

Now, we proceed to the calculation of $\mathbb{E}[Tr(M^k)]$ and $\mathbb{E}[Tr(M^k) Tr(M^l)]$, which are discussed in Sections [7.2](#page-17-2) and [7.3.](#page-19-0)

7.2. Single Chain Expectation. In this subsection, we focus on computing the expected value of the trace of a matrix raised to the power of k , that is, the expectation of a single chain. Specifically, we are interested in evaluating the expressions of the form.

$$
\mathbb{E}[\text{Tr}(M^k)] = \frac{1}{n^{k/2}} \sum_{i_1, i_2, \dots, i_k=1}^n \mathbb{E}[x_{i_1 i_2} x_{i_2 i_3} \cdots x_{i_{k-1} i_k} x_{i_k i_1}].
$$

We state the first lemma in this regard.

Lemma 7.4. Let M be the random matrix as defined in Definition [3.1](#page-1-0) satisfying the Condition [3.3.](#page-2-0) Then we have the following

$$
\mathbb{E}[\text{Tr}(M^k)] \le n^{-k/6} k^{2k} \left(\frac{4}{3\alpha}\right)^k
$$

$$
\le k^{3k} n^{-k/6}, \text{ if } k > 4/3\alpha.
$$

Here α is the constant of Poincaré inequality. In particular, if $k \leq n^{\beta}$ for some $\beta < 1/18$, then $\mathbb{E}[\text{Tr}(M^k)] = o(1)$.

Proof. This lemma evaluates the limit expectation of a single chain through intra chain merging, which is defined in Section [7.3.](#page-19-0) The expectation of the trace of M^k can be expressed as

$$
\mathbb{E}[\text{Tr}(M^k)] = \frac{1}{n^{k/2}} \sum_{i_1, i_2, \dots, i_k=1}^n \mathbb{E}[x_{i_1 i_2} x_{i_2 i_3} \cdots x_{i_{k-1} i_k} x_{i_k i_1}].
$$

To evaluate $\mathbb{E}[x_{i_1i_2}x_{i_2i_3}\cdots x_{i_{k-1}i_k}x_{i_ki_1}]$, we need to determine the number of ways in which $x_{i_1i_2}x_{i_2i_3}\cdots x_{i_{k-1}i_k}x_{i_ki_1}$ simplifies to a product where each x_{ij} may appear with some multiplicity. However, given that $\mathbb{E}[x_{ij}] = 0 = \mathbb{E}[x_{ij}^2]$ according to Condition [3.3,](#page-2-0) we should focus on the cases where more than two random variables are equal. Since the product has k random variables, essentially the the task boils down to considering the integer partitions of k, where group sizes in each partition is at least 3. For example, $22 = 10 + 5 + 4 + 3$ is an integer partition of 22 having four groups, where group sizes are 10, 5, 4, 3.

Suppose in an integer partition of k , we have g groups, where each group contains k_1, k_2, \ldots, k_g random variables respectively, and the random variables within any particular group are equal. For example, a group of size k_i consists of k_i equal random variables, and no two groups share the same random variables. Additionally, the cardinality of each group is at least 3, and $\sum_{l=1}^{g} k_l = k$.

Let us analyze a generic group of size k_l . To reduce notional complexity, here we denote the group as $x_{\alpha_1} x_{\alpha_2} \cdots x_{\alpha_{k_l}}$, where each α_p is of the form $(i_{\alpha_p}, i_{\alpha_p+1})$. As per the construction, $x_{\alpha_1} = x_{\alpha_2} = \cdots = x_{\alpha_{k_l}}$. Therefore, using the fact that x_{ij} s satisfy Poincaré inequality, we have

$$
\mathbb{E}[x_{\alpha_1}x_{\alpha_2}\cdots x_{\alpha_{k_l}}] = \mathbb{E}[|x_{11}|^{k_l}] \leq k_l! \left(\frac{2}{\alpha}\right)^{k_l/2}.
$$

Hence, we conclude that if we fix a partition $\sum_{l=1}^{g} k_l = k$, and fix random variables in each group of the partition, then

$$
\mathbb{E}[x_{i_1i_2}x_{i_2i_3}\cdots x_{i_{k-1}i_k}x_{i_ki_1}] \leq \prod_{l=1}^g k_l! \left(\frac{2}{\alpha}\right)^{k_l/2}
$$

$$
= \left(\frac{2}{\alpha}\right)^{k/2} \prod_{l=1}^g k_l!
$$

$$
\leq \left(\frac{2}{\alpha}\right)^{k/2} k!,
$$

where the last inequality follows from the fact that $m!n! \leq (m+n)!$. However, if we fix a partition of k , but do not fix the random variables in the partition groups, then we have some choices for the indices $\alpha_1, \alpha_2, \ldots, \alpha_{k_l}$ in the product $x_{\alpha_1} x_{\alpha_2} \cdots x_{\alpha_{k_l}}$, which is a group of size k_l . Now, since all the random variables in this group are equal, we only have the freedom to choose α_1 . Once α_1 is fixed, the remaining α_p s in the same group can either be α_1 or $n + 1 - \alpha_1$. Hence, for a given α_1 , we have at most 2^{k_l-1} many possibilities of the indices $\alpha_2, \alpha_3, \ldots, \alpha_{k_l}$ for that group.

The index $\alpha_1 = (i_{\alpha_1}, i_{\alpha_1+1})$ consists of two indices. However, since this group $x_{\alpha_1} x_{\alpha_2} \cdots x_{\alpha_{k_l}}$ is a part of the full chain $x_{i_1i_2}x_{i_2i_3}\cdots x_{i_{k-1}i_k}x_{i_ki_1}$, one of the indices among $i_{\alpha_1}, i_{\alpha_1+1}$ must also appear in some other group. As a result, either i_{α_1} or i_{α_1+1} must be determined by some other group. Therefore, we have the freedom to choose only one of the indices $i_{\alpha_1}, i_{\alpha_1+1},$ which can be done in at most n possible ways. Hence, we have an additional factor $n2^{k_l-1}$ in the *l*th group of the partition. And overall, we have a factor of $n^g 2^{\sum_{l=1}^g (k_l-1)} = n^g 2^{k-g}$.

Finally, combining all the above arguments we have

$$
\mathbb{E}[\text{Tr}(M^{k})] = \frac{1}{n^{k/2}} \sum_{i_{1},i_{2},...,i_{k}=1}^{n} \mathbb{E}[x_{i_{1}i_{2}}x_{i_{2}i_{3}}\cdots x_{i_{k-1}i_{k}}x_{i_{k}i_{1}}]
$$

\n
$$
= \frac{1}{n^{k/2}} \sum_{g=1}^{k/3} \sum_{k_{1}+k_{2}+...+k_{g}=k} n^{g}2^{k-g} \left(\frac{2}{\alpha}\right)^{k/2} k!
$$

\n
$$
\leq \frac{1}{n^{k/2}} \left(\frac{k}{3}\right)^{k} n^{k/3}2^{2k/3} \left(\frac{2}{\alpha}\right)^{k/2} k!
$$

\n
$$
\leq n^{-k/6}k^{2k} \left(\frac{4}{3\alpha}\right)^{k}
$$

\n
$$
\leq n^{-k/6}k^{3k},
$$

for $k > 4/3\alpha$. The third last inequality follows from the fact that $n^g 2^{k-g} \leq n^{k/3} 2^{2k/3}$ for $1 \leq g \leq k/3$ and the number of partitions of k into at most $k/3$ many groups is $(k/3)^k$. This completes the proof. \Box

Now, we shall proceed with the calculation of the covariance between $\text{Tr } M^k$, $\text{Tr } M^l$.

7.3. Double chain Expectation. In this section, our focus is on computing the expected value of the product of traces of matrices raised to different powers, which requires the computation of the expectation of a double chain. Specifically, we are interested in expressions of the form

$$
\sum_{k,l=1}^d \frac{1}{n^{(k+l)/2}} \sum_{i_1,i_2,\dots,i_k,j_1,j_2,\dots,j_l=1}^n \mathbb{E} \left[(x_{i_1i_2} x_{i_2i_3} \cdots x_{i_ki_1}) (\bar{x}_{j_1j_2} \bar{x}_{j_2j_3} \cdots \bar{x}_{j_lj_l}) \right].
$$

Here, k and l are positive integers denoting the lengths of the respective chains. From the Condition [3.3,](#page-2-0) we know that $\mathbb{E}[x_{ij}] = 0 = \mathbb{E}[x_{ij}^2]$. Therefore as explained in Lemma [7.4,](#page-17-1) we need to choose the indices of the chains in such such a way that each random variable occurs with a multiplicity. However, it is quite evident that if we make more random variables equal to each other within a chain or across different chains, then we lose more degrees of freedom in the index chains. So, we aim to make fewer random variables equal, preferably 2, across two different chains. Since in this case, we have the term $\mathbb{E}[|x_{ij}|^2]$, which is 1. Thus, when we have a product of two chains such as $(x_{i_1i_2}x_{i_2i_3}\cdots x_{i_ki_1})(\bar{x}_{j_1j_2}\bar{x}_{j_2j_3}\cdots \bar{x}_{j_lj_1}),$ we can pair random variables from the first chain $x_{i_1 i_2} x_{i_2 i_3} \cdots x_{i_k i_1}$ with the second chain $\bar{x}_{j_1j_2}\bar{x}_{j_2j_3}\cdots\bar{x}_{j_lj_1}$ in the following three different ways:

- (1) All the random variables of one chain find their pair within the chain itself intra chain merging.
- (2) All random variables in one chain find their pair in the other chain cross chain merging.
- (3) Some of the random variables of one chain find their pairs in the chain itself, and others find in the other chain - partial chain merging.

Let us explain each case as follows.

Case 1 (Intra chain merging): As we have seen in the Lemma [7.4,](#page-17-1) the single chain expectation is asymptotically zero. Thus, intra chain merging gives us zero asymptotic contribution.

Case 2 (Cross chain merging): To evaluate $\mathbb{E}[\text{Tr}(M^k) \text{Tr}(\bar{M}^l)]$, let us consider a simple example with $k = l = 5$.

$$
\mathbb{E}[\text{Tr}(M^5) \text{Tr}(\bar{M}^5)] = \frac{1}{n^5} \sum_{\substack{i_1,i_2,\ldots,i_k,\\j_1,j_2,\ldots,j_5=1}}^n \mathbb{E}\left[(x_{i_1i_2} x_{i_2i_3} x_{i_3i_4} x_{i_4i_5} x_{i_5i_1})(\bar{x}_{j_1j_2}\bar{x}_{j_2j_3}\bar{x}_{j_3j_4}\bar{x}_{j_4j_5}\bar{x}_{j_5j_1}) \right].
$$

We shall see in the proof of Lemma [7.5,](#page-22-0) we get maximum contribution if every random variable from the first chain gets paired with a random variable from the second chain.

One way of cross-chain merging is that if $x_{i_t i_l}$ gets paired with $\bar{x}_{j_p j_q}$, then the pairing for $x_{i_{t+1}i_{t+1}}$ will be $\bar{x}_{j_{p+1}j_{q+1}}$ for all t and l such that $1 \leq t, l \leq 5$. In other words, the random variables from the first chain get matched with the random variables in the second chain in the same order as they appear in the first chain, see Figure [4,](#page-20-0) and we demonstrate that it gives us a nonzero asymptotic contribution.

FIGURE 4. Sequential cross chain merging

For any pair of random variables (x_{ij}, \bar{x}_{kl}) , where x_{ij} and \bar{x}_{kl} are from the chains $x_{i_1i_2}x_{i_2i_3}x_{i_3i_4}$ $x_{i_4i_5}x_{i_5i_1}$, and $\bar{x}_{j_1j_2}\bar{x}_{j_2j_3}\bar{x}_{j_3j_4}\bar{x}_{j_4j_5}\bar{x}_{j_5j_1}$ respectively, $\mathbb{E}[x_{ij}\bar{x}_{kl}] \neq 0$ if and only if $(i, j) = (k, l)$ or $(i, j) = (n + 1 - k, n + 1 - l)$. This leads to the following possible pairings in the above example.

$$
\begin{cases}\nj_1 = n + 1 - i_1 \\
j_2 = n + 1 - i_2\n\end{cases} \text{ or } \begin{cases}\nj_1 = i_1 \\
j_2 = i_2\n\end{cases}
$$
\n
$$
\begin{cases}\nj_2 = n + 1 - i_2 \\
j_3 = n + 1 - i_3\n\end{cases} \text{ or } \begin{cases}\nj_2 = i_2 \\
j_3 = i_3\n\end{cases}
$$
\n
$$
\begin{cases}\nj_3 = n + 1 - i_3 \\
j_4 = n + 1 - i_4\n\end{cases} \text{ or } \begin{cases}\nj_3 = i_3 \\
j_4 = i_4\n\end{cases}
$$
\n
$$
\begin{cases}\nj_4 = n + 1 - i_4 \\
j_5 = n + 1 - i_5 \\
j_1 = n + 1 - i_1\n\end{cases} \text{ or } \begin{cases}\nj_4 = i_4 \\
j_5 = i_5\n\end{cases}
$$
\n
$$
\begin{cases}\nj_5 = n + 1 - i_5 \\
j_1 = n + 1 - i_1\n\end{cases} \text{ or } \begin{cases}\nj_5 = i_5 \\
j_1 = i_1\n\end{cases}
$$

If we start with $j_1 = n + 1 - i_1$, then the chain has to follow the constraints listed in the left column; not the ones which are listed on the right column. Similarly, if we start with the condition $j_1 = i_1$, then we have to follow the constraints that are listed on the right column.

For example, if we take $(i_1, i_2) = (n+1-j_1, n+1-j_2)$ and decide to take $(i_2, i_3) = (j_2, j_3)$, then to keep the continuity of the chain, we must have $j_2 = i_2 = n + 1 - j_2$ which enforces one extra constraint $j_2 = n + 1 - j_2$. Thus, we have lost a degree of freedom there. Now, if the indices follow the constraints listed on the first column, then there are $n⁵$ many choices for choosing all the indices. For each such choice, the chain will reduce to a product of the terms of the form $\mathbb{E}[|x_{ij}|^2] (= 1)$.

Thus, we conclude that when we do the cross chain merging for the first and the second chain, namely $i_1 \rightarrow i_2 \rightarrow i_3 \rightarrow i_4 \rightarrow i_5 \rightarrow i_1$ and $j_1 \rightarrow j_2 \rightarrow j_3 \rightarrow j_4 \rightarrow j_5 \rightarrow j_1$, one way for cross chain merging is to copy the first chain in place of the second chain, resulting in: $i_1 \to i_2 \to i_3 \to i_4 \to i_5 \to i_1 \to i_2 \to i_3 \to i_4 \to i_5 \to i_1$. This represents one possibility with 5 free indices. Additionally, we can start the second chain with i_2 or i_3 or ... or i_5 like $i_2 \to i_3 \to \cdots \to i_5 \to i_1 \to i_2$, resulting in 4 more choices. Therefore, we have $5n^5$ combinations for cross chain merging of the first and the second chain so far. Moreover, since $x_{(i,j)} = x_{(n+1-i,n+1-j)}$, we can perform a cross chain merging by changing the second chain to $n + 1 - i_1 \rightarrow n + 1 - i_2 \rightarrow \cdots \rightarrow n + 1 - i_5 \rightarrow n + 1 - i_1$, which will contribute another $5n⁵$. Hence, the total number of combinations for cross chain merging of the first and second chain is $2 \times 5n^5$ from type of merging in Figure [4.](#page-20-0)

Now, let us consider the another type of case as demonstrated in Figure [5,](#page-21-0) where the first chain is not merging with the second chain in the same sequence. We shall argue that such mergings will give negligible contributions.

FIGURE 5. Non sequential cross chain merging

For this case, we need to impose more constraints that will reduce the degree of freedom and leads to zero asymptotic contribution. Here, $x_{i_1 i_2} = \bar{x}_{j_3 j_4}$ if and only if $(i_1, i_2) = (j_3, j_4)$ or the dual case $(i_2, i_3) = (n + 1 - j_3, n + 1 - j_4).$

If $j_3 = i_1$, this implies $j_4 = i_2$. Furthermore, since we are pairing $x_{i_2 i_3}$ and $\bar{x}_{j_5 j_1}$, we shall have $j_5 = i_2$ and $i_3 = j_1$, or the dual case. Now, let us look at the consecutive random variables of those already paired up. We observe that to maintain the continuity of the chain, we must impose restrictions that will significantly reduce the number of free indices and lead to zero asymptotic contribution.

In conclusion, the total number of combinations that provide a nonzero asymptotic contribution is $2 \times 5n^5$. We obtain that contribution from the cases as demonstrated in the Figure [4.](#page-20-0) Consequently,

$$
\lim_{n \to \infty} \mathbb{E}[\text{Tr}(M^5) \text{Tr}(\bar{M}^5)] = \lim_{n \to \infty} \frac{2 \times 5n^5 + o(n^5)}{n^5} = 2 \times 5.
$$

Now, we generalize the above result in the following lemma.

Lemma 7.5. Let M the random matrix as defined in Definition [3.1](#page-1-0) satisfying the Condition [3.3.](#page-2-0) Then we have

$$
\mathbb{E}[\text{Tr}(M^k)\,\text{Tr}(\bar{M}^k)] = 2k + o(1),
$$

if $k < n^{\gamma}$ for $\gamma < 1/20$.

Proof. Let us expand $\mathbb{E}[\text{Tr}(M^k) \text{Tr}(\bar{M}^k)]$ as follows;

$$
\mathbb{E}[\text{Tr}(M^{k}) \text{Tr}(\bar{M}^{k})] = \frac{1}{n^{k}} \mathbb{E} \left[\sum_{\substack{i_{1}, i_{2}, \dots, i_{k} \\ j_{1}, j_{2}, \dots, j_{k} = 1}}^{n} (x_{i_{1}i_{2}} x_{i_{2}i_{3}} \cdots x_{i_{k}i_{1}}) (\bar{x}_{j_{1}j_{2}} \bar{x}_{j_{2}j_{3}} \cdots \bar{x}_{j_{k}j_{1}}) \right]
$$

$$
= \frac{1}{n^{k}} \sum_{\substack{i_{1}, i_{2}, \dots, i_{k} \\ j_{1}, j_{2}, \dots, j_{k} = 1}}^{n} \mathbb{E} \left[(x_{i_{1}i_{2}} x_{i_{2}i_{3}} \cdots x_{i_{k}i_{1}}) (\bar{x}_{j_{1}j_{2}} \bar{x}_{j_{2}j_{3}} \cdots \bar{x}_{j_{k}j_{1}}) \right].
$$

The main contribution will come from two possible cases, such as (a) the chain $i_1 \rightarrow i_2 \rightarrow$ $\cdots \rightarrow i_k \rightarrow i_1$ overlaps completely with the chain $j_1 \rightarrow j_2 \rightarrow \cdots \rightarrow j_k \rightarrow j_1$, or (b) it overlaps with the dual version of the second chain, which is $n + 1 - j_1 \rightarrow n + 1 - j_2 \rightarrow \cdots$ $n+1-j_k \rightarrow n+1-j_1$. In either cases, we have k many possible ways to start the second chain. Once the chains overlap, it reduces to the product of terms of the form $\mathbb{E}[|x_{ij}|^2] (= 1)$. Such complete overlapping will contribute $2kn^k$.

Now, we argue that if the chains do not overlap completely, then the contribution is negligible. Let us assume that only p random variables from the the first chain overlap with p random variables in the second chain. In that case, the overlapping part contributes $2p n^p$. Additionally, the extra $k - p$ random variables from the first and the second chain may contribute at most $n^{(k-p-1)/3}(k-p)^{3(k-p)}$ each. This is a consequence of the result stated in the Lemma [7.4](#page-17-1) with a chain of length $k - p$. Note that in the Lemma [7.4,](#page-17-1) we had the factor $n^{-k/6}$, where k was the length of the chain, because the trace sum was already divided by $n^{k/2}$. Here, length of the chain is $k - p$, but the factor $n^{-(k-p)/2}$ is not taken into account yet. Consequently, we would get a contribution of $n^{(k-p)/3}$. However, to keep the continuity of the full chain (e.g. $x_{i_1 i_2} x_{i_2 i_3} \cdots x_{i_k i_1}$), one of the index among $k - p$ variables is already determined by the remaining p variables which are matched with p variables of the another chain (e.g. $x_{j_1j_2}x_{j_2j_3}\cdots x_{j_kj_1}$). As a result, we have the factor $n^{(k-p-1)/3}$. Hence in such a case, the combined contribution turns out to be at most

(7.1)
$$
2pn^pn^{2(k-p-1)/3}(k-p)^{6(k-p)} = n^k \times 2pn^{-(k-p+2)/3}(k-p)^{6(k-p)}.
$$

Additionally, the starting points of the *p*-chains can be set to one of indices among i_1, i_2, \ldots, i_k (for the first chain) or j_1, j_2, \ldots, j_k (for the second chain). Therefore, by multiplying a factor of k^2 and summing up over all possible values of p, we see that if the full chains do not overlap, then we have the following contribution

(7.2)
$$
n^k \sum_{p=1}^{k-3} 2pk^2 n^{-(k-p+2)/3} (k-p)^{6(k-p)}.
$$

Note that p can not be $k-1$ or $k-2$. Because in that case, the remaining chain would be of length one or two, and from the Condition [3.3,](#page-2-0) we have $\mathbb{E}[x_{ij}] = 0 = \mathbb{E}[x_{ij}^2]$. The above sum is $o(n^k)$ if $k < n^{\gamma}$ for $\gamma < 1/20$. Thus, we have

$$
\mathbb{E}[\text{Tr}(M^{k}) \text{Tr}(\bar{M}^{k})]
$$
\n
$$
= \frac{1}{n^{k}} \sum_{\substack{i_{1}, i_{2}, \dots, i_{k}, \\ j_{1}, j_{2}, \dots, j_{k}=1}}^{n} \mathbb{E}[(x_{i_{1}i_{2}}x_{i_{2}i_{3}} \cdots x_{i_{k}i_{1}})(\bar{x}_{j_{1}j_{2}}\bar{x}_{j_{2}j_{3}} \cdots \bar{x}_{j_{k}j_{1}})]
$$
\n
$$
= \frac{2kn^{k}}{n^{k}} + o(1)
$$
\n
$$
= 2k + o(1).
$$

Case 3 (Partial chain merging): If the chain lengths are not equal, then we have a partial chain merging, which is explained in the following lemma.

□

Lemma 7.6. Let M be the random matrix as defined in Definition [3.1,](#page-1-0) and satisfying the Condition [3.3.](#page-2-0) Then for $k \neq l$, we have

$$
\mathbb{E}[\text{Tr}(M^k)\,\text{Tr}(\bar{M}^l)] \le 2kln^{-|l-k|/6}|l-k|^{3|l-k|} + o(1),
$$

if $k, l < n^\gamma$ for $\gamma < 1/20$.

Proof. Without loss of generality, let us assume that $k < l$. We adopt the methodology from Lemma [7.5.](#page-22-0) Let a sub chain of length p from the first chain $x_{i_1 i_2} x_{i_2 i_3} \cdots x_{i_k i_1}$ gets matched to a sub chain of length p from the second chain $x_{j_1j_2}x_{j_2j_3}\cdots x_{j_lj_1}$. In that case, following the equations (7.1) and (7.2) , we have

$$
\mathbb{E}[\text{Tr } M^k \bar{M}^l] \leq \frac{1}{n^{(k+l)/2}} \sum_{p=1}^{k-3} 2pn^p \times kn^{(k-p-1)/3}(k-p)^{3(k-p)} \times ln^{(l-p-1)/3}(l-p)^{3(l-p)} \n+ \frac{1}{n^{(k+l)/2}} 2kn^k \times ln^{(l-k-1)/3}(l-k)^{3(l-k)} \n\leq n^{-(l+k)/2} \sum_{p=1}^k 2pkln^{(k+l+p-2)/3}(k-p)^{3(k-p)}(l-p)^{3(l-p)} \n+ 2kln^{-(l-k)/6}(l-k)^{3(l-k)} \n\leq 2kln^{-(l-k)/6}(l-k)^{3(l-k)} + o(1).
$$

The $o(1)$ in the last inequality is a consequence of $k, l \leq n^{\gamma}, \gamma < 1/20$.

We summarise all the above cases as follows.

Remark 7.7. While calculating $\mathbb{E}[\text{Tr}(M^k) \text{Tr}(\bar{M}^l)]$, the significant contribution comes only when $k = l$, see Lemma [7.5.](#page-22-0) From Lemma [7.4](#page-17-1) and Lemma [7.6,](#page-23-0) we conclude that if $k \neq l$, although intra-chain merging and partial-chain merging are possible strategies, asymptotically they provide zero contributions. In particular, $\mathbb{E}[\text{Tr}(\tilde{M}^k) \text{Tr}(\bar{M}^l)] = O(|l-k|^{3|l-k|}n^{-|l-k|/6})$ for $k, l \leq n^{1/20}$.

Now, we are ready to summarize the above results into the proof of Proposition [7.1.](#page-16-2)

Proof of Proposition [7.1.](#page-16-2) We may write the variance as

$$
\operatorname{Var}(\operatorname{Tr}(P_d(M)))
$$
\n
$$
= \operatorname{Var}\left(\sum_{k=1}^d a_k \operatorname{Tr}(M^k)\right)
$$
\n
$$
= \sum_{k,l=1}^d a_k \bar{a}_l \operatorname{Cov}\left(\operatorname{Tr}(M^k), \operatorname{Tr}(M^l)\right)
$$
\n
$$
= \sum_{k,l=1}^d a_k \bar{a}_l \left(\mathbb{E}\left[\operatorname{Tr}(M^k) \operatorname{Tr}(\bar{M}^l)\right] - \mathbb{E}\left[\operatorname{Tr}(M^k)\right] \mathbb{E}\left[\operatorname{Tr}(\bar{M}^l)\right]\right)
$$
\n(7.3)\n
$$
= \sum_{\substack{k \neq l \\ k,l=1}}^d 0 + \sum_{k=1}^d 2k |a_k|^2 + o(1)
$$
\n
$$
= \sum_{k=1}^d 2k |a_k|^2 + o(1).
$$

The equality in [\(7.3\)](#page-24-1) follows from the Lemmas [7.4,](#page-17-1) [7.5,](#page-22-0) and Remark [7.7.](#page-23-1) \Box

7.4. Covariance kernel of $\text{Tr} \hat{\mathcal{R}}_z(M)$. In this subsection, we find the covariance kernel of the Gaussian process as mentioned in Proposition [6.1.](#page-6-0) As defined at the beginning of Section [6,](#page-5-0) let $\rho = \max\{\rho_1, \rho_2\}$. Now, on the event Ω_n , we can expand $\text{Tr } \hat{\mathcal{R}}_z(M)$ on the boundary $\partial \mathbb{D}_{\rho+\tau}$ as follows

$$
\text{Tr}\,\hat{\mathcal{R}}_z(M) = \frac{n}{z} + \sum_{k=1}^{\lfloor \log^2 n \rfloor - 1} z^{-k-1} \,\text{Tr}\,M^k + \frac{1}{z^{\lfloor \log^2 n \rfloor + 1}} \,\text{Tr}[\hat{\mathcal{R}}_z(M)M^{\lfloor \log^2 n \rfloor}].
$$

We see that on the event Ω_n , the last term is bounded by $\frac{n}{\tau}(\rho/|z|)^{\lfloor \log^2 n \rfloor} = o(1)$. Hence, using Remark [7.7,](#page-23-1) we have

$$
\mathbb{E}[\text{Tr}\, M^k \, \text{Tr}\, \bar{M}^l] = O(|k-l|^{3|k-l|} n^{-|k-l|/6}).
$$

Furthermore, since $(x^3n^{-1/6})^x$ is a decreasing function of x for $1 \leq x \leq n^{1/18}/e$, we can estimate

$$
\sum_{k \neq l}^{\lfloor \log^2 n \rfloor} |k - l|^{3|k - l} n^{-|k - l|/6}
$$

$$
\leq 2 \log^2 n \sum_{m=1}^{\lfloor \log^2 n \rfloor} m^{3m} n^{-m/6}
$$

$$
\leq \frac{2 \log^4 n}{n^{1/6}} = o(1).
$$

As a result, $\sum_{k\neq l=1}^{\lfloor \log^2 n \rfloor} z^{(-k-1)} \bar{z}^{(-l-1)} \mathbb{E}[\text{Tr } M^k \text{Tr } \bar{M}^l] = o(1)$. Hence, by using Lemma [7.5,](#page-22-0) we obtain

$$
\mathbb{E}[\text{Tr}\,\hat{\mathcal{R}}_z^{\circ}(M)\,\text{Tr}\,\hat{\mathcal{R}}_{\tilde{\eta}}^{\circ}(\bar{M})] \n= \left\{ \mathbb{E}[\text{Tr}\,\hat{\mathcal{R}}_z(M)\,\text{Tr}\,\hat{\mathcal{R}}_{\tilde{\eta}}(\bar{M})] - \frac{n^2}{z\bar{\eta}} \right\} + o(1) \n= \sum_{k=1}^{\lfloor \log^2 n \rfloor} (z\bar{\eta})^{-k-1} \mathbb{E}[M^k\bar{M}^k] + o(1) \n= 2 \sum_{k=1}^{\lfloor \log^2 n \rfloor} k(z\bar{\eta})^{-k-1} + o(1) \n= 2 \left(\frac{1}{z\bar{\eta}}\right)^2 \left(1 - \frac{1}{z\bar{\eta}}\right)^{-2} \n= 2 (1 - z\bar{\eta})^{-2}.
$$

This completes the proof of the Proposition [6.1.](#page-6-0)

Appendix A.

Lemma A.1. [\[17,](#page-27-12) Lemma A.3] Let M be a periodic random band matrix with bandwidth b_n and variance profile ω . The matrix M is of the form $M = \frac{1}{\sqrt{2b_n+1}}(X \circ W)$, where $X \circ W$ denotes the entrywise hadamarad product between the matrices X and W. Assume that the entries of X are i.i.d. random variables with mean zero variance one, and satisfy the Poincaré inequality with constant α . Moreover, $W_{ij} =$ ¹ $\omega\left(\frac{i-j}{2b_n+1}\right)$, where $\omega : \mathbb{R} \to [0,1]$ is a piece-wise continuous periodic function with periodicity 1. In addition, ω is continuous at 0, and $\int_{-1/2}^{1/2} \omega(x) dx = 1$. Then there exists $\rho \ge 1$ such that

$$
\mathbb{P}(\|M\| > \rho/4 + t) \le K \exp\left(-\sqrt{\frac{\alpha(2b_n+1)}{2\omega}}t\right), \quad \forall t > 0,
$$

where K is a constant, which does not depend on n .

In our case, we have a matrix with i.i.d. entries whose entries satisfy the Poincaré inequality. Therefore, by taking the variance profile $\omega \equiv 1$, and using the above lemma we can have the following.

Lemma A.2. Let T be a random matrix with $m \times m$ dimension having i.i.d. entries with mean zero and variance one. Moreover, assume that the entries satisfy the Poincaré inequality with constant α . Then there exists $\rho \geq 1$ such that

$$
\mathbb{P}(\|T/\sqrt{m}\| > \rho/4 + t) \le K \exp\left(-\sqrt{\frac{\alpha m}{2}}t\right), \quad \forall \ t > 0,
$$

where $K > 0$ is a universal constant, which does not depend on the size of the matrix and the bandwidth.

Lemma A.3. [\[27,](#page-27-10) Lemma 2.2] Let $M = [m_{ij}]$ be an $n \times n$ random matrix with i.i.d. complex valued random variables satisfying (i) $\mathbb{E}[m_{ij}] = 0 = \mathbb{E}[m_{ij}^2],$ (ii) $\mathbb{E}[|m_{ij}|^k] \leq k^{\alpha k}$ for some $\alpha > 0$ and for all $k > 2$, (iii) $\Re(m_{ij})$ and $\Im(m_{ij})$ have a bounded joint density. Then for any $p \in [1, 2)$, and any $z \in \mathbb{C}$,

 $\mathbb{E}[|\operatorname{Tr} R_z(M)|^p] \le C(p) n^{3p/2+2},$

where the constant $C(p)$ depends on p, but $C(p) \rightarrow \infty$ as $p \uparrow 2$.

We note down the essential ingredient of this article, which martingale CLT as follows.

Lemma A.4. [\[7,](#page-26-16) Theorem 35.12] Let $\{\psi_{n,k}\}_{1\leq k\leq n}$ be a martingale difference sequence with respect to a filtration $\{\mathcal{F}_{k,n}\}_{1\leq k\leq n}$. Suppose for any $\gamma > 0$, (*i*) $\lim_{n\to\infty} \sum_{k=1}^n \mathbb{E}[\psi_{n,k}^2, \mathbf{1}_{|\psi_{n,k}| > \gamma}] = 0.$ (ii) $\sum_{k=1}^{n} \mathbb{E}[\psi_{n,k}^2 \, | \mathcal{F}_{n,k-1}] \stackrel{p}{\to} \sigma^2$ as $n \to \infty$. Then $\sum_{k=1}^{n} \psi_{n,k} \stackrel{d}{\rightarrow} \mathcal{N}_1(0, \sigma^2)$.

Lemma A.5 (Sherman-Morrison formula, [\[31\]](#page-27-20)). Let M and $M + ve_k^t$ be two invertible matrices, where $v \in \mathbb{C}^n$. Then

$$
(M + ve_k^t)^{-1}v = \frac{M^{-1}v}{1 + e_k^t M^{-1}v}.
$$
