

General Mneimneh-type Binomial Sum involving Harmonic Numbers

Abstract. Recently, Mneimneh proved the remarkable identity

$$\sum_{k=0}^n H_k \binom{n}{k} p^k (1-p)^{n-k} = \sum_{i=1}^n \frac{1 - (1-p)^i}{i} \quad (p \in [0, 1])$$

as the main result of a 2023 *Discrete Mathematics* paper, where $H_k := \sum_{i=1}^k 1/i$ is the classical k -th harmonic number. Thereafter, Campbell provided several other proofs of Mneimneh's formula as above in a note published in *Discrete Mathematics* in 2023. Moreover, Campbell also considered how Mneimneh's identity may be proved and generalized using the *Mathematica* package *Sigma*. In particular, he found the generalized Mneimneh's identity

$$\sum_{k=0}^n x^k y^{n-k} \binom{n}{k} H_k = (x+y)^n \left(H_n - \sum_{i=1}^n \frac{y^i (x+y)^{-i}}{i} \right).$$

In this paper, we will prove a more generalization of Mneimneh's identity involving Bell numbers and some Mneimneh-type identities involving (alternating) harmonic numbers by using a few results of our previous papers.

Keywords: Mneimneh's identity; harmonic numbers; Binomial coefficients and sums; (unsigned) Stirling numbers; Bell polynomials; Bell numbers.

1 Introduction

Let $\mathbb{N} = \{1, 2, 3, \dots\}$ be the set of natural numbers, and $\mathbb{N}_0 := \mathbb{N} \cup \{0\}$. In his recent paper [7], Mneimneh used the method of probabilistic analysis to establish the following binomial sum identity involving harmonic numbers

$$\sum_{k=0}^n H_k \binom{n}{k} p^k (1-p)^{n-k} = \sum_{i=1}^n \frac{1 - (1-p)^i}{i} \quad (p \in [0, 1]), \quad (1.1)$$

where H_k is the *classical k -th harmonic number* defined by

$$H_k := \sum_{i=1}^k \frac{1}{i} \quad \text{and} \quad H_0 := 0.$$

Quite recently, Campbell [1] gave two new proofs of (1.1) by using Zeilberger's algorithm and beta-type integral formula. Further, using the Sigma package for the Mathematica Computer Algebra System, Campbell gave the more general Mneimneh's identity

$$\sum_{k=0}^n x^k y^{n-k} \binom{n}{k} H_k = (x+y)^n \left(H_n - \sum_{i=1}^n \frac{y^i (x+y)^{-i}}{i} \right). \quad (1.2)$$

Clearly, setting $(x, y) = (p, 1-p)$ in (1.2) gives (1.1). Moreover, Campbell also emphasized that this approach may also be used to derive identities for expressions such as

$$\sum_{k=0}^n x^k y^{n-k} \binom{n}{k} H_k^2.$$

In a 2024 *Discrete Mathematics* article [6], Komatsu and Wang extended Mneimneh's formula to the generalized hyperharmonic numbers. Genčev [4] studied of the binomial sum

$$\sum_{k=0}^n \binom{n}{k} \left(\sum_{j=1}^k \frac{z^j}{j} \right) p^k (1-p)^k \quad (r \in \mathbb{N}, p, z \in \mathbb{R}, p \neq 1)$$

and established explicit formula, see [4, Thm. 2.1].

In this paper, using the method of integrals of natural logarithms, we will establish the explicit formulas of the following general Mneimneh-type binomial sums involving Bell numbers and some Mneimneh-type binomial sums involving (alternating) harmonic numbers.

Theorem 1.1. *For any reals x, y with $x/(x+y) \geq 0$ and $n, p \in \mathbb{N}$, we have*

$$\sum_{k=0}^n x^k y^{n-k} \binom{n}{k} Y_p(k) = (-1)^{p-1} p! (x+y)^n \sum_{j=1}^n \left(1 - \left(\frac{y}{x+y} \right)^j \right) \sum_{i=0}^{p-1} (-1)^i \frac{Y_i(n)}{i!} \frac{s(j, p-i)}{j!}, \quad (1.3)$$

where $s(n, k)$ and $Y_k(n)$ stand for the (unsigned) Stirling numbers of the first kind and Bell numbers (see Section 2), respectively.

Remark 1.2. All Stirling numbers $s(n, k)$ and Bell numbers $Y_k(n)$ can be expressed in terms of a linear combination of products of harmonic numbers.

In particular, letting $p = 1, 2$ in Theorem 1.1 and noting the facts that $s(n, 1) = (n-1)!$, $s(n, 2) = (n-1)!H_{n-1}$, $Y_0(n) = 1$, $Y_1(n) = H_n$, $Y_2(n) = H_n^2 + H_n^{(2)}$, we also obtain (1.2) and

$$\sum_{k=0}^n x^k y^{n-k} \binom{n}{k} (H_k^2 + H_k^{(2)}) = 2(x+y)^n \sum_{j=1}^n \left(1 - \left(\frac{y}{x+y} \right)^j \right) \frac{H_n - H_{j-1}}{j}. \quad (1.4)$$

Theorem 1.3. For any reals x, y and $z \in (-\infty, 1)$ with $x/(x+y) \geq 0$ and $n \in \mathbb{N}$, we have

$$\sum_{k=0}^n x^k y^{n-k} \binom{n}{k} \left(\sum_{j=1}^k \frac{z^j}{j} \right) = \sum_{j=1}^n \frac{(y+zx)^j - y^j}{j} (x+y)^{n-j}. \quad (1.5)$$

Obviously, letting $z \rightarrow 1$ in (1.5) gives (1.2). Setting $z = -1$ in Theorem 1.3 yields the following corollary.

Corollary 1.4. For any reals x, y with $x/(x+y) \geq 0$ and $n \in \mathbb{N}$, we have

$$\sum_{k=0}^n x^k y^{n-k} \binom{n}{k} \bar{H}_k = \sum_{j=1}^n \frac{y^j - (y-x)^j}{j} (x+y)^{n-j}, \quad (1.6)$$

where \bar{H}_k is the alternating k -th harmonic number defined by

$$\bar{H}_k := \sum_{j=1}^k \frac{(-1)^{j-1}}{j} \quad \text{and} \quad \bar{H}_0 := 0. \quad (1.7)$$

Specially, setting $(x, y) = (p, 1-p)$ ($p \in [0, 1]$) in (1.6) yields the following Mneimneh-type identity

$$\sum_{k=0}^n \bar{H}_k \binom{n}{k} p^k (1-p)^{n-k} = \sum_{j=1}^n \frac{(1-p)^j - (1-2p)^j}{j}. \quad (1.8)$$

From equation (1.4) and Theorem 1.3, we can also obtain the following corollary.

Corollary 1.5. For any reals x, y with $x/(x+y) \geq 0$ and $n \in \mathbb{N}$, we have

$$\sum_{k=0}^n x^k y^{n-k} \binom{n}{k} H_k^{(2)} = (x+y)^n \left\{ \sum_{j=1}^n \frac{y^j (x+y)^{-j}}{j} \sum_{i=1}^j \frac{y^{-i} (x+y)^i}{i} - \sum_{j=1}^n \frac{y^j (x+y)^{-j}}{j} H_j \right\}, \quad (1.9)$$

$$\sum_{k=0}^n x^k y^{n-k} \binom{n}{k} H_k^2 = (x+y)^n \left\{ \begin{aligned} & H_n^2 + H_n^{(2)} - 2 \sum_{j=1}^n \frac{y^j (x+y)^{-j}}{j^2} - 2H_n \sum_{j=1}^n \frac{y^j (x+y)^{-j}}{j} \\ & + 3 \sum_{j=1}^n \frac{y^j (x+y)^{-j}}{j} H_j - \sum_{j=1}^n \frac{y^j (x+y)^{-j}}{j} \sum_{i=1}^j \frac{y^{-i} (x+y)^i}{i} \end{aligned} \right\}. \quad (1.10)$$

We will prove Theorem 1.1 in Section 3, and Theorem 1.3 and Corollary 1.5 in Section 4.

Conjecture 1.6. The Theorems 1.1 and 1.3 hold for any reals x, y and z .

2 Preliminaries and lemmas

2.1 (unsigned) Stirling number of the first kind

We recall the definition of *(unsigned) Stirling number of the first kind*. Let $s(n, k)$ denote the (unsigned) Stirling number of the first kind, which is defined by [2, 3]

$$n!x(1+x)\left(1+\frac{x}{2}\right)\cdots\left(1+\frac{x}{n}\right)=\sum_{k=0}^n s(n+1, k+1)x^{k+1}, \quad (2.1)$$

with $s(n, k) := 0$ if $n < k$, and $s(n, 0) = s(0, k) := 0$, $s(0, 0) := 1$, or equivalently, by the generating function:

$$\log^k(1-x) = (-1)^k k! \sum_{n=1}^{\infty} s(n, k) \frac{x^n}{n!} \quad (x \in [-1, 1)).$$

The Stirling numbers $s(n, k)$ of the first kind satisfy a recurrence relation in the form

$$s(n, k) = s(n-1, k-1) + (n-1)s(n-1, k) \quad (n, k \in \mathbb{N}).$$

Obviously, $s(n, k)$ can be expressed in terms of a linear combinations of products of harmonic numbers (see (2.5)). In particular,

$$\begin{aligned} s(n, 1) &= (n-1)!, \\ s(n, 2) &= (n-1)!H_{n-1}, \\ s(n, 3) &= \frac{(n-1)!}{2} \left[H_{n-1}^2 - H_{n-1}^{(2)} \right], \\ s(n, 4) &= \frac{(n-1)!}{6} \left[H_{n-1}^3 - 3H_{n-1}H_{n-1}^{(2)} + 2H_{n-1}^{(3)} \right], \\ s(n, 5) &= \frac{(n-1)!}{24} \left[H_{n-1}^4 - 6H_{n-1}^{(4)} - 6H_{n-1}^2H_{n-1}^{(2)} + 3(H_{n-1}^{(2)})^2 + 8H_{n-1}H_{n-1}^{(3)} \right]. \end{aligned}$$

In [9, Thm 2.5], we proved

$$s(n, k) = (n-1)! \zeta_{n-1}(\{1\}_{k-1}) \quad (k, n \in \mathbb{N}), \quad (2.2)$$

where $\zeta_n(\{1\}_k)$ is a special multiple harmonic sum defined by ($\{l\}_r$ denotes the sequence obtained by repeating l exactly r times)

$$\zeta_n(\{1\}_r) := \sum_{n \geq n_1 > n_2 > \cdots > n_r > 0} \frac{1}{n_1 n_2 \cdots n_r}. \quad (2.3)$$

For $\mathbf{k} = (k_1, \dots, k_r) \in \mathbb{N}^r$ and positive integer n , the generalized *multiple harmonic sums* (MHSs) are defined by

$$\zeta_n(\mathbf{k}) \equiv \zeta_n(k_1, \dots, k_r) := \sum_{n \geq n_1 > \cdots > n_r > 0} \frac{1}{n_1^{k_1} \cdots n_r^{k_r}}. \quad (2.4)$$

We set $\zeta_n(\emptyset) := 1$ if $\mathbf{k} = \emptyset$ and $\zeta_n(\mathbf{k}) := 0$ if $n < r$. For $\mathbf{k} = (k) \in \mathbb{N}$,

$$\zeta_n(k) \equiv H_n^{(k)} = \sum_{j=1}^n \frac{1}{j^k} \quad (2.5)$$

is the n -th generalized *harmonic number* of order k , and furthermore, if $k = 1$ then $H_n \equiv H_n^{(1)}$ is the classical n -th harmonic number. When taking the limit $n \rightarrow \infty$ in (2.4) we get the so-called classical *multiple zeta values* (MZVs) (see [5, 12]),

$$\zeta(\mathbf{k}) := \lim_{n \rightarrow \infty} \zeta_n(\mathbf{k}),$$

defined for $\mathbf{k} \in \mathbb{N}^r$ and $k_1 > 1$ to ensure convergence of the series.

2.2 Bell polynomials

Define the *exponential partial Bell polynomials* $B_{n,k}$ by

$$\frac{1}{k!} \left(\sum_{n=1}^{\infty} x_n \frac{t^n}{n!} \right)^k = \sum_{n=k}^{\infty} B_{n,k}(x_1, x_2, \dots, x_n) \frac{t^n}{n!}, \quad k = 0, 1, 2, \dots,$$

and the *exponential complete Bell polynomials* Y_n by

$$Y_n(x_1, x_2, \dots, x_n) := \sum_{k=0}^n B_{n,k}(x_1, x_2, \dots, x_n)$$

(see [2, Section 3.3]). According to [8, Eq. (2.44)], the complete Bell polynomials Y_n satisfy the recurrence

$$Y_0 = 1, \quad Y_n(x_1, x_2, \dots, x_n) = \sum_{j=0}^{n-1} \binom{n-1}{j} x_{n-j} Y_j(x_1, x_2, \dots, x_j), \quad n \geq 1,$$

from which, the first few polynomials can be obtained immediately:

$$\begin{aligned} Y_0 &= 1, & Y_1(x_1) &= x_1, & Y_2(x_1, x_2) &= x_1^2 + x_2, & Y_3(x_1, x_2, x_3) &= x_1^3 + 3x_1x_2 + x_3, \\ Y_4(x_1, x_2, x_3, x_4) &= x_1^4 + 6x_1^2x_2 + 4x_1x_3 + 3x_2^2 + x_4. \end{aligned}$$

Define the *Bell number* $Y_k(n)$ by

$$Y_k(n) := Y_k(H_n, 1!H_n^{(2)}, 2!H_n^{(3)}, \dots, (k-1)!H_n^{(k)}). \quad (2.6)$$

Clearly, the Bell number $Y_k(n)$ is a rational linear combination of products of harmonic numbers. We have

$$\begin{aligned} Y_1(n) &= H_n, \\ Y_2(n) &= H_n^2 + H_n^{(2)}, \\ Y_3(n) &= H_n^3 + 3H_nH_n^{(2)} + 2H_n^{(3)}, \\ Y_4(n) &= H_n^4 + 8H_nH_n^{(3)} + 6H_n^2H_n^{(2)} + 3(H_n^{(2)})^2 + 6H_n^{(4)}, \\ Y_5(n) &= H_n^5 + 10H_n^3H_n^{(2)} + 20H_n^2H_n^{(3)} + 15H_n(H_n^{(2)})^2 + 30H_nH_n^{(4)} + 20H_n^{(2)}H_n^{(3)} + 24H_n^{(5)}. \end{aligned}$$

In [9, Eq. (2.9)], we showed

$$\zeta_n^*(\{1\}_m) = \frac{1}{m!} Y_m(n) \quad (n, m \in \mathbb{N}_0), \quad (2.7)$$

where $\zeta_n^*(\{1\}_r)$ is a special multiple harmonic star sum defined by

$$\zeta_n^*(\{1\}_r) := \sum_{n \geq n_1 \geq n_2 \geq \dots \geq n_r > 0} \frac{1}{n_1 n_2 \cdots n_r}.$$

For $\mathbf{k} = (k_1, \dots, k_r) \in \mathbb{N}^r$ and positive integer n , the generalized *multiple harmonic star sums* (MHSSs) are defined by

$$\zeta_n^*(\mathbf{k}) \equiv \zeta_n^*(k_1, \dots, k_r) := \sum_{n \geq n_1 \geq \dots \geq n_r > 0} \frac{1}{n_1^{k_1} \cdots n_r^{k_r}}. \quad (2.8)$$

Similarly, we set $\zeta_n^*(\emptyset) := 1$ if $\mathbf{k} = \emptyset$.

2.3 Some Lemmas

Next, we present some lemmas, which are useful in the development of our main theorems.

Lemma 2.1. (*[10, Thm. 2.9]*) For $n \in \mathbb{N}$ and $p \in \mathbb{N}_0$, we have

$$\int_0^1 t^{n-1} \log^p(1-t) dt = (-1)^p \frac{Y_p(n)}{n}. \quad (2.9)$$

Lemma 2.2. (*[9, Thm. 2.2]*) For $n, m \in \mathbb{N}$ and $x \in (-\infty, 1)$, we have

$$\begin{aligned} \int_0^x t^{n-1} \log^m(1-t) dt &= m! \frac{(-1)^m}{n} \zeta_n^*(\{1\}_m; x) \\ &+ \frac{1}{n} \sum_{j=0}^{m-1} (-1)^j j! \binom{m}{j} \log^{m-j}(1-x) \left(\zeta_n^*(\{1\}_j; x) - \zeta_n^*(\{1\}_j) \right), \end{aligned} \quad (2.10)$$

where $\zeta_n^*(\{1\}_r)$ ($r \in \mathbb{N}_0$) is defined by

$$\zeta_n^*(\{1\}_r; x) := \sum_{n \geq n_1 \geq n_2 \geq \dots \geq n_r > 0} \frac{x^{n_r}}{n_1 n_2 \cdots n_r} \quad \text{and} \quad \zeta_n^*(\emptyset; x) := x^n.$$

(Note that in [9, Thm. 2.2], the range of values for x is $x \in [-1, 1)$, but in fact, the above equation also holds for $x \in (-\infty, -1]$.)

Lemma 2.3. (*[11, Thm. 4.3]*) For $\mathbf{k} = (k_1, \dots, k_r) \in \mathbb{N}^r$ and $l \in \mathbb{N}_0, n \in \mathbb{N}$, we have

$$\sum_{n \geq n_1 \geq n_2 \geq \dots \geq n_r > 0} \prod_{j=1}^r \frac{1}{(n_j + l)^{k_j}} = (-1)^r \sum_{j=0}^r (-1)^j \zeta_{n+l}^*(\vec{\mathbf{k}}_j) \zeta_l^*(\overleftarrow{\mathbf{k}}_{j+1}), \quad (2.11)$$

where $\vec{\mathbf{k}}_j := (k_1, \dots, k_j)$ and $\overleftarrow{\mathbf{k}}_j := (k_r, \dots, k_j)$ for all $1 \leq j \leq r$.

3 Proof of Theorem 1.1

For $x/(x+y) = 0$, namely $x = 0$, (1.3) is obviously holds. For $x/(x+y) > 0$, applying Lemma 2.1, the left hand side of (1.3) can be rewritten as

$$\begin{aligned}
\sum_{k=0}^n x^k y^{n-k} \binom{n}{k} Y_p(k) &= (-1)^p \sum_{k=1}^n x^k y^{n-k} \binom{n}{k} k \int_0^1 t^{k-1} \log^p(1-t) dt \\
&= (-1)^p \int_0^1 \log^p(1-t) \sum_{k=1}^n x^k y^{n-k} \binom{n}{k} k t^{k-1} dt \\
&= (-1)^p \int_0^1 \log^p(1-t) \sum_{k=0}^{n-1} x^{k+1} y^{n-k-1} \binom{n}{k+1} (k+1) t^k dt \\
&= (-1)^p \int_0^1 \log^p(1-t) \sum_{k=0}^{n-1} x^{k+1} y^{n-k-1} n \binom{n-1}{k} t^k dt \\
&= (-1)^p n x \int_0^1 \log^p(1-t) \sum_{k=0}^{n-1} (xt)^k y^{n-k-1} \binom{n-1}{k} dt \\
&= (-1)^p n x \int_0^1 \log^p(1-t) (tx+y)^{n-1} dt \quad (\text{letting } u = tx+y) \\
&= (-1)^p n \int_y^{x+y} u^{n-1} \log^p\left(\frac{x+y-u}{x}\right) du \\
&= (-1)^p n \int_y^{x+y} u^{n-1} \left\{ \log\left(\frac{x+y}{x}\right) + \log\left(1 - \frac{u}{x+y}\right) \right\}^p du \\
&= (-1)^p n \sum_{l=0}^p \binom{p}{l} \log^{p-l}\left(\frac{x+y}{x}\right) \int_y^{x+y} u^{n-1} \log^l\left(1 - \frac{u}{x+y}\right) du \\
&= (-1)^p n \sum_{l=1}^p \binom{p}{l} \log^{p-l}\left(\frac{x+y}{x}\right) \int_y^{x+y} u^{n-1} \log^l\left(1 - \frac{u}{x+y}\right) du \\
&\quad + (-1)^p \left((x+y)^n - y^n \right) \log^p\left(\frac{x+y}{x}\right) \quad (\text{letting } u = v(x+y)) \\
&= (-1)^p n (x+y)^n \sum_{l=1}^p \binom{p}{l} \log^{p-l}\left(\frac{x+y}{x}\right) \int_{y(x+y)^{-1}}^1 v^{n-1} \log^l(1-v) dv \\
&\quad + (-1)^p \left((x+y)^n - y^n \right) \log^p\left(\frac{x+y}{x}\right). \tag{3.1}
\end{aligned}$$

(In order to utilize Lemmas 2.1 and 2.2, the integration in the second to last row of the above equation needs to satisfy $y(x+y)^{-1} < 1$, namely $x/(x+y) > 0$) Using Lemmas 2.1 and 2.2, by an elementary calculation, the (3.1) is equal to

$$\begin{aligned}
\sum_{k=0}^n x^k y^{n-k} \binom{n}{k} Y_p(k) &= (x+y)^n \sum_{1 \leq i \leq l \leq p} (-1)^{l-i} i! \binom{l}{i} \binom{p}{l} \log^{p-i}\left(\frac{x}{x+y}\right) \\
&\quad \times \left(\zeta_n^*(\{1\}_i) - \zeta_n^*(\{1\}_i; y(x+y)^{-1}) \right) \\
&= (x+y)^n \sum_{1 \leq i \leq l \leq p} (-1)^{l-i} i! \binom{l}{i} \binom{p}{l} \log^{p-i}\left(\frac{x}{x+y}\right)
\end{aligned}$$

$$\times \sum_{n \geq k_1 \geq \dots \geq k_i \geq 1} \frac{1 - \left(\frac{y}{x+y}\right)^{k_i}}{k_1 \cdots k_i}. \quad (3.2)$$

Noting the fact that the (3.2) can be rewritten as

$$\begin{aligned} \sum_{k=0}^n x^k y^{n-k} \binom{n}{k} Y_p(k) &= (x+y)^n \sum_{i=1}^p (-1)^i i! \log^{p-i} \left(\frac{x}{x+y}\right) \sum_{n \geq k_1 \geq \dots \geq k_i \geq 1} \frac{1 - \left(\frac{y}{x+y}\right)^{k_i}}{k_1 \cdots k_i} \\ &\quad \times \sum_{l=i}^p (-1)^l \binom{l}{i} \binom{p}{l} \end{aligned} \quad (3.3)$$

and

$$\sum_{l=i}^p (-1)^l \binom{l}{i} \binom{p}{l} = \begin{cases} (-1)^p, & (p=i), \\ 0, & (\text{otherwise}), \end{cases}$$

we obtain

$$\sum_{k=0}^n x^k y^{n-k} \binom{n}{k} Y_p(k) = p! (x+y)^n \sum_{n \geq k_1 \geq \dots \geq k_p \geq 1} \frac{1 - \left(\frac{y}{x+y}\right)^{k_p}}{k_1 \cdots k_p}. \quad (3.4)$$

In Lemma 2.3, replacing n by $n-j+1$ and letting $r = p-1$, $(k_1, \dots, k_r) = (\{1\}_{p-1})$ and $l = j-1$, we easily obtain

$$\begin{aligned} &\sum_{n-j+1 \geq i_1 \geq \dots \geq i_{p-1} \geq 1} \frac{1}{(i_1 + j - 1) \cdots (i_{p-1} + j - 1)} \\ &= (-1)^{p-1} \sum_{i=0}^{p-1} (-1)^i \zeta_n^*(\{1\}_i) \zeta_{j-1}(\{1\}_{p-1-i}). \end{aligned} \quad (3.5)$$

Hence,

$$\begin{aligned} \sum_{n \geq k_1 \geq \dots \geq k_p \geq 1} \frac{1 - \left(\frac{y}{x+y}\right)^{k_p}}{k_1 \cdots k_p} &= \sum_{j=1}^n \frac{1 - \left(\frac{y}{x+y}\right)^j}{j} \sum_{n \geq k_1 \geq \dots \geq k_{p-1} \geq j} \frac{1}{k_1 \cdots k_{p-1}} \\ &= \sum_{j=1}^n \frac{1 - \left(\frac{y}{x+y}\right)^j}{j} \sum_{n-j+1 \geq i_1 \geq \dots \geq i_{p-1} \geq 1} \frac{1}{(i_1 + j - 1) \cdots (i_{p-1} + j - 1)} \\ &= (-1)^{p-1} \sum_{j=1}^n \frac{1 - \left(\frac{y}{x+y}\right)^j}{j} \sum_{i=0}^{p-1} (-1)^i \zeta_n^*(\{1\}_i) \zeta_{j-1}(\{1\}_{p-1-i}) \\ &= (-1)^{p-1} \sum_{j=1}^n \left(1 - \left(\frac{y}{x+y}\right)^j\right) \sum_{i=0}^{p-1} (-1)^i \frac{Y_i(n)}{i!} \frac{s(j, p-i)}{j!}, \end{aligned} \quad (3.6)$$

where we used the equations (2.2) and (2.7).

Finally, substituting (3.6) into (3.4) yields the desired evaluation (1.3). Thus, this concludes the proof of Theorem 1.1.

4 Proofs of Theorem 1.3 and Corollary 1.5

For $x/(x+y) = 0$, namely $x = 0$, Theorem 1.3 and Corollary 1.5 are obviously hold. For $x/(x+y) > 0$, in (2.10), setting $m = 1$ and replacing x by z gives

$$\int_0^z t^{n-1} \log(1-t) dt = \frac{1}{n} \left\{ x^n \log(1-z) - \sum_{j=1}^n \frac{z^j}{j} - \log(1-z) \right\}. \quad (4.1)$$

Hence,

$$\sum_{j=1}^n \frac{z^j}{j} = (z^n - 1) \log(1-z) - n \int_0^z t^{n-1} \log(1-t) dt.$$

Hence, by a similar argument as in the proof of (3.1) gives

$$\begin{aligned} \sum_{k=0}^n x^k y^{n-k} \binom{n}{k} \left(\sum_{j=1}^k \frac{z^j}{j} \right) &= -nx \int_0^z \log(1-t) (xt+y)^{n-1} dt + \log(1-z) ((xz+y)^n - (x+y)^n) \\ &= -n \int_y^{xz+y} u^{n-1} \log\left(\frac{x+y-u}{x}\right) du + \log(1-z) ((xz+y)^n - (x+y)^n) \\ &= -n \int_y^{xz+y} u^{n-1} \left\{ \log\left(\frac{x+y}{x}\right) + \log\left(1 - \frac{u}{x+y}\right) \right\} du \\ &\quad + \log(1-z) ((xz+y)^n - (x+y)^n) \\ &= -\log\left(\frac{x+y}{x}\right) ((xz+y)^n - y^n) + \log(1-z) ((xz+y)^n - (x+y)^n) \\ &\quad - n \int_y^{xz+y} u^{n-1} \log\left(1 - \frac{u}{x+y}\right) du \\ &= -\log\left(\frac{x+y}{x}\right) ((xz+y)^n - y^n) + \log(1-z) ((xz+y)^n - (x+y)^n) \\ &\quad - n(x+y)^n \int_{y(x+y)^{-1}}^{(xz+y)(y+x)^{-1}} v^{n-1} \log(1-v) dv. \end{aligned} \quad (4.2)$$

Therefore, applying (4.1), by a direct calculation, we deduce

$$\sum_{k=0}^n x^k y^{n-k} \binom{n}{k} \left(\sum_{j=1}^k \frac{z^j}{j} \right) = (x+y)^n \sum_{j=1}^n \frac{\left(\frac{xz+y}{y+x}\right)^j - \left(\frac{y}{y+x}\right)^j}{j}. \quad (4.3)$$

This completes the proof of Theorem 1.3 (Noting that from $x/(x+y) > 0$ and $z \in (-\infty, 1)$ gives $(xz+y)(x+y)^{-1} < 1$).

Multiplying (1.5) by $1/z$ and integrating over the interval $(0,1)$, we have

$$\sum_{k=0}^n x^k y^{n-k} \binom{n}{k} H_k^{(2)} = \sum_{j=1}^n \frac{(x+y)^{n-j}}{j} \int_0^1 \frac{(xz+y)^j - y^j}{z} dz$$

$$\begin{aligned}
&= \sum_{j=1}^n \frac{(x+y)^{n-j}}{j} y^j \sum_{i=1}^j \int_0^1 \left(\frac{xz}{y} + 1\right)^{i-1} d\frac{xz}{y} \\
&= (x+y)^n \left\{ \sum_{j=1}^n \frac{y^j (x+y)^{-j}}{j} \sum_{i=1}^j \frac{y^{-i} (x+y)^i}{i} - \sum_{j=1}^n \frac{y^j (x+y)^{-j}}{j} H_j \right\}.
\end{aligned} \tag{4.4}$$

Then, applying the well-known identity

$$\sum_{j=1}^n \frac{H_j}{j} = \zeta_n^*(1, 1) = \frac{1}{2} Y_2(n) = \frac{H_n^2 + H_n^{(2)}}{2}$$

and substituting (4.4) into (1.4) yields (1.10). Thus, we complete the proof of Corollary 1.5.

5 Conclusion

We presented the explicit formulas of the following Mneimneh-type binomial sum of (alternating) harmonic numbers

$$\sum_{k=0}^n x^k y^{n-k} \binom{n}{k} Y_p(k), \quad \sum_{k=0}^n x^k y^{n-k} \binom{n}{k} \bar{H}_k, \quad \sum_{k=0}^n x^k y^{n-k} \binom{n}{k} H_k^{(2)} \quad \text{and} \quad \sum_{k=0}^n x^k y^{n-k} \binom{n}{k} H_k^2.$$

It is possible that some of other Mneimneh-type binomial sums can be obtained using techniques of the present paper. For example, multiplying (1.5) by $\log^{p-1}(z)/z$ ($p \in \mathbb{N}$) and integrating over the interval $(0,1)$, we have

$$\sum_{k=0}^n x^k y^{n-k} \binom{n}{k} H_k^{(p+1)} = \frac{(-1)^{p-1}}{(p-1)!} \sum_{j=1}^n \frac{(x+y)^{n-j}}{j} \int_0^1 \log^{p-1}(z) \frac{(xz+y)^j - y^j}{z} dz. \tag{5.1}$$

Hence, if the evaluation of the integral on the right hand of above can be established, we can obtain the explicit formula of Mneimneh-type binomial sums on the left hand of above. We leave the detail to the interested reader. It should be emphasized that Komatsu-Wang [6, Eq. (4)] gave an evaluation of (5.1) with $x = 1 - q$ and $y = q$, where q is a real number. Genčev [4, Thm. 2.1] established a generalization of Mneimneh summation formula

$$\sum_{k=0}^n \binom{n}{k} \left(\sum_{j=1}^k \frac{z^j}{j^r} \right) p^k (1-p)^k = \sum_{n \geq n_1 \geq \dots \geq n_r \geq 1} \frac{(1-p)^{n_1} \left(\left(1 + \frac{zp}{1-p} \right)^{n_r} - 1 \right)}{n_1 \cdots n_r}, \tag{5.2}$$

where $r \in \mathbb{N}, p, z \in \mathbb{R}$ and $p \neq 1$.
