Subsampling for Big Data Linear Models With Measurement Errors

Abstract: Subsampling algorithms for various parametric regression models with massive data have been extensively investigated in recent years. However, all existing studies on subsampling heavily rely on clean massive data. In practical applications, the observed covariates may suffer from inaccuracies due to measurement errors. To address the challenge of large datasets with measurement errors, this study explores two subsampling algorithms based on the corrected likelihood approach: the optimal subsampling algorithm utilizing inverse probability weighting and the perturbation subsampling algorithm employing random weighting assuming a perfectly known distribution. Theoretical properties for

both algorithms are provided. Numerical simulations and two real-world examples demonstrate the effectiveness of these proposed methods compared to other uncorrected algorithms.

Key words and phrases: Corrected likelihood method, Measurement error, Subsampling algorithm.

1. Introduction

To address the ever-increasing volume of data brought about by technological advancements, it is imperative to adopt refined techniques such as divide and conquer, online updating of streaming data, and subsampling-based methods. These techniques offer effective solutions to computational challenges posed by large datasets. However, existing literature often assumes that direct and accurate observation of covariates, which may not always be feasible in practical data collection scenarios. Consequently, statistical models that do not account for measurement errors can lead to biased estimated results. Therefore, it is essential to investigate subsampling algorithms for linear models that consider measurement errors in covariates.

For the subsampling algorithm of linear models, [Ma, Mahoney and Yu \(2015\)](#page-21-0) proposed a leverage sampling algorithm based on leverage scores and their linear transformations. A deterministic subsampling method named information-based optimal subdata selection (IBOSS) was proposed by [Wang, Yang and Stufken \(2019\)](#page-22-0), and extended by [Wang \(2019b\)](#page-22-1), aiming to find subsamples with the maximum information matrix under the D-optimality criterion, which performs well in finding corners. [Cheng, Wang and Yang \(2020\)](#page-21-1) and [Yu,](#page-23-0) [Liu and Wang \(2023\)](#page-23-0) extended the IBOSS algorithm to logistic and nonlinear models, respectively. [Wang et al. \(2021\)](#page-22-2) proposed an orthogonal subsampling approach for big data linear regression. [Yi and Zhou \(2023\)](#page-22-3) and [Zhang et al. \(2024\)](#page-23-1) explored using space-filling or uniform designs to obtain the subsample so that a wide range of models could be considered.

[Wang, Zhu and Ma \(2018\)](#page-22-4) proposed the optimal subsampling method based on the Aoptimality criterion. This method was further developed by [Wang \(2019a\)](#page-22-5), [Ai et al. \(2021a\)](#page-21-2), [Ai et al. \(2021b\)](#page-21-3), [Wang and Ma \(2021\)](#page-22-6), and [Yu et al. \(2022\)](#page-23-2). In addition to the widely used method based on inverse probability weighting, [Wang and Kim \(2022\)](#page-22-7) introduced the maximum sample conditional likelihood estimation, and enhanced the estimator for selected subsamples. This approach overcomes the limitations of inverse probability weighting and makes more efficient use of sample information. [Yao and Jin \(2024\)](#page-22-8) introduced a perturbation subsampling method that employs repeated random weighting of known distributions to address the limitations of inverse probability weighting. This method has been successfully applied to linear models, longitudinal data, and high-dimensional data with promising performance.

For the measurement error model, [Fuller \(1987\)](#page-21-4) systematically introduced a comprehensive statistical inference of linear regression models with measurement errors. [Nakamura](#page-22-9) [\(1990\)](#page-22-9) proposed the corrected score method for the generalized linear model with measurement errors. [Carroll et al. \(2006\)](#page-21-5) systematically studied the theory of nonlinear regression models with measurement errors. [Liang, Hardle and Carroll \(1999\)](#page-21-6) offered the parameter estimation of a semi-parametric partially linear model with measurement errors. [Liang and](#page-21-7) [Li \(2009\)](#page-21-7) examined variable selection in partially linear models with measurement errors, and proposed that when the variance of the measurement error is unknown, it can be estimated through repeated observations. [Lee, Wang and Schifano \(2020\)](#page-21-8) introduced an online update method for correcting measurement errors in big data streams.

This study focuses on the subsampling problem in linear models with measurement errors. The presence of measurement errors in covariates can introduce inaccuracies of parameter estimation, thereby diminishing the statistical power. We employ the corrected likelihood approach proposed by [Nakamura \(1990\)](#page-22-9) to estimate the parameters with subsamples. We introduce an optimal subsampling method based on the corrected likelihood approach, and the optimal subsampling probabilities are determined by minimizing the trace of the variance. The consistency and asymptotic normality of estimators obtained by this approach are established. Furthermore, we propose a perturbation subsampling method based on the corrected likelihood approach that approximates the objective function of the full data using a perturbation with independently generated stochastic weights. The effectiveness of our method is also confirmed through numerical analysis. By accounting for measurement errors in covariates, more precise and reliable results can be obtained in the analysis of massive datasets. Our approaches not only alleviate the computational burden associated with parameter estimation in big data but also enhance computational efficiency and improve prediction accuracy.

The rest of the paper is outlined as follows. Section 2 offers a comprehensive introduction to the model setup and parameter estimation of the measurement error model. Sections 3 and 4 introduce the linear model subsampling algorithm with measurement errors and establish the correspondingly theoretical properties. Section 5 comprises numerical simulations. Section 6 presents case studies aimed at validating effectiveness of the algorithm. Finally, Section 7 summarizes this paper. The detailed proofs are provided in the supplementary

materials

2. Linear model with measurement errors

In this section, we present an overview of the model and parameter estimation.

2.1 Model

Here, we consider the linear model with measurement errors

$$
\begin{cases} y_i = \mathbf{X}_i^T \boldsymbol{\beta} + \epsilon_i, \\ y_i = \mathbf{X}_i + \mathbf{U}_i, \end{cases} i = 1, 2, \dots, n,
$$
 (2.1)

where $\mathbf{X}_i = (x_{i1}, \dots, x_{ip})^T$ is a *p*-dimensional covariate vector, y_i is the corresponding response variable, $\boldsymbol{\beta} = (\beta_1, \beta_2, \dots, \beta_p)^T$ is an unknown parameter vector, and ϵ_i is a random error term with mean zero and variance σ^2 . However, in applications, the exact value of \mathbf{X}_i is often difficult to obtain. Let $\mathbf{U}_i = (u_{i1}, \dots, u_{ip})^T$ be a random error vector with mean zero and variance-covariance matrix Σ_{uu} , and W_i be the actual observed random variable. Assuming Σ_{uu} is known, the measurement error U_i is independent of ϵ_i and \mathbf{X}_i .

According to [Fuller \(1987\)](#page-21-4), the ordinary least squares method cannot be directly applied to estimate linear models with measurement errors, as the resulting estimators are biased and inconsistent. For model [\(2.1\)](#page-4-0), it follows that

$$
y_i = \mathbf{W}_i^T \boldsymbol{\beta} + \epsilon_i - \mathbf{U}_i^T \boldsymbol{\beta} \triangleq \mathbf{W}_i^T \boldsymbol{\beta} + \delta_i, \ i = 1, 2, \dots, n,
$$

where $\delta_i = \epsilon_i - \mathbf{U}_i^T \boldsymbol{\beta}$. Note that

$$
Cov(\mathbf{W}_i, \delta_i) = Cov(\mathbf{X}_i + \mathbf{U}_i, \epsilon_i - \mathbf{U}_i^T \boldsymbol{\beta}) = -\Sigma_{uu} \boldsymbol{\beta} \neq 0.
$$

Since the assumption of independence is violated, the ordinary method cannot be applied directly. This also suggests that when there are no measurement errors, i.e., $\Sigma_{uu} = 0$, the estimator is unbiased. Example [1](#page-5-0) illustrates the influences of measurement errors.

Example 1. The responses y_i are generated from $y_i = 0.5 + 0.5x_i + \varepsilon_i$, $x_i \sim N(0, 1)$ and $\varepsilon_i \sim N(0, 1), i = 1, ..., 1000$. We consider the measurement error of the covariate x_i by replacing w_i with $w_i = x_i + u_i$, $u_i \sim N(0, 0.5^2)$. The black solid line represents true model. The blue dotted line represents the regression line fitted by the full dataset, while the red dashed line represents the regression line fitted by a subsample with size 50 selected using L-optimal subsampling. From Figure [1,](#page-5-1) we can see that the presence of measurement errors in covariates have great effect on the resulting subsample estimator, if measurement errors are ignored.

Figure 1: The plot on the left is the fitting result of the data without measurement errors. The plot on the right is the fitting result of the data with measurement errors, while ignoring measurement errors.

2.2 Parameter estimation

To correct measurement errors, we apply the corrected likelihood method proposed by [Naka](#page-22-9)[mura \(1990\)](#page-22-9). When Σ_{uu} is known, using the corrected likelihood method, we obtain

$$
\ell(\boldsymbol{\beta}) = \frac{1}{2n} \sum_{i=1}^{n} (y_i - \mathbf{W}_i \boldsymbol{\beta})^2 - \frac{1}{2} \boldsymbol{\beta}^T \boldsymbol{\Sigma}_{uu} \boldsymbol{\beta}.
$$

Minimizing $\ell(\boldsymbol{\beta})$, we have

$$
\hat{\boldsymbol{\beta}} = \arg \min_{\boldsymbol{\beta}} \ell(\boldsymbol{\beta}) = \left(\sum_{i=1}^n \mathbf{W}_i \mathbf{W}_i^T - n \boldsymbol{\Sigma}_{uu} \right)^{-1} \sum_{i=1}^n \mathbf{W}_i y_i.
$$

According to [Liang, Hardle and Carroll \(1999\)](#page-21-6), under certain assumptions, the parameter estimators possess both consistency and asymptotic normality.

Lemma 1. Suppose that there exists an $s > 2$ such that $E\|\mathbf{X}_i\|^{2s} < \infty$, $E\|\mathbf{U}_i\|^{2s} < \infty$ and $E|\epsilon_i|^{2s} < \infty$, where $\|\cdot\|$ represents an Euclidean norm. Additionally, $\frac{1}{n}\sum_{i=1}^n \mathbf{X}_i \mathbf{X}_i^T$ converges to the covariance matrix H , where H is a non-random positive definite matrix. Then it follows that

- (i) $\|\hat{\boldsymbol{\beta}} \boldsymbol{\beta}\| = O_P(n^{-\frac{1}{2}})$ as $n \to \infty$.
- (ii) $\hat{\boldsymbol{\beta}}$ follows an asymptotic normal distribution, i.e.,

$$
\sqrt{n}(\hat{\boldsymbol{\beta}} - \boldsymbol{\beta}) \stackrel{d}{\rightarrow} N_p(\mathbf{0}, \mathcal{H}^{-1} \Gamma \mathcal{H}^{-1}),
$$

 $as\ n \to \infty$, where $\Gamma = \sigma^2 \mathcal{H} + \mathcal{H} \beta^T \Sigma_{uu} \beta + E[(\mathbf{U} \mathbf{U}^T - \Sigma_{uu}) \beta]^{\otimes 2} + \sigma^2 \Sigma_{uu}$, and $\mathbf{v}^{\otimes 2} = \mathbf{v} \mathbf{v}^T$ for any v .

Remark 1. In applications, Σ_{uu} is often unknown. [Liang and Li \(2009\)](#page-21-7) proposed that $\hat{\Sigma}_{uu}$ can be obtained by utilizing repeated observations corresponding to each \mathbf{X}_i . For repetitive observations $\mathbf{W}_{i,j} = \mathbf{X}_i + \mathbf{U}_{i,j}, j = 1, \ldots, J_i, i = 1, \ldots, n$, we have

$$
\widehat{\mathbf{\Sigma}}_{uu} = \frac{\sum_{i=1}^{n} \sum_{j=1}^{J_i} (\mathbf{W}_{i,j} - \overline{\mathbf{W}}_i)(\mathbf{W}_{i,j} - \overline{\mathbf{W}}_i)^T}{\sum_{i=1}^{n} (J_i - 1)},
$$

where $\overline{\mathbf{W}}_i = J_i^{-1}$ $\overline{W}_i^{-1} \sum_{j=1}^{J_i} \mathbf{W}_{i,j}$. By substituting \mathbf{W}_i by $\overline{\mathbf{W}}_i$, the estimator $(\sum_{i=1}^n \overline{\mathbf{W}}_i \overline{\mathbf{W}}_i^T$ $nJ_i^{-1}\hat{\Sigma}_{uu}$ ⁻¹ $\sum_{i=1}^n \overline{\mathbf{W}}_i y_i$ is unbiased, and the aforementioned properties remain valid.

3. Optimal subsampling based on corrected likelihood

In this section, we will present a general subsampling algorithm that can be used to obtain estimators with measurement error models. We will establish the consistency and asymptotic normality of these estimators and calculate the optimal subsampling probability using the A (or L) - optimality criterion.

3.1 General subsampling algorithm

Define some symbols before introducing the algorithm. We take a random subsample from the full data with replacement based on the subsampling probability $\pi_i, i = 1, \ldots, n$, where $\sum_{i=1}^n \pi_i = 1$. In addition, we denote the subsample as $\mathcal{F}_r = \{(\mathbf{W}_i^*, y_i^*)\}_{i=1}^r$ with r being the subsample size. The corresponding subsampling probability is denoted as $\pi_i^*, i = 1, \ldots, r$. We can formulate the weighted loss function as follows

$$
\ell^*(\boldsymbol{\beta}) = \frac{1}{2n} \sum_{i=1}^r \frac{1}{r \pi_i^*} (y_i^* - \mathbf{W}_i^{*T} \boldsymbol{\beta})^2 - \frac{1}{2} \boldsymbol{\beta}^T \boldsymbol{\Sigma}_{uu} \boldsymbol{\beta}.
$$

Algorithm [1](#page-8-0) is a general subsampling algorithm that relies on the corrected likelihood to address big data subsampling problems with measurement errors.

Algorithm 1 General subsampling algorithm based on corrected likelihood

- 1 **Subsample:** Extract a random subsample $\mathcal{F}_r = \{(\mathbf{W}_i^*, y_i^*)\}_{i=1}^r$ of size $r (r \ll n)$ from the full dataset with replacement based on the subsampling probabilities $\{\pi_i\}_{i=1}^n$. The subsampling probabilities corresponding to the subsample are denoted as $\{\pi_i^*\}_{i=1}^r$.
- 2 Estimate: Minimize the objective function $\ell^*(\beta)$ based on the subsample \mathcal{F}_r to obtain the parameter estimator, that is,

$$
\tilde{\boldsymbol{\beta}} = \arg\min_{\boldsymbol{\beta}} \ell^*(\boldsymbol{\beta}).
$$

3.2 Asymptotic properties

In order to obtain the asymptotic properties of $\tilde{\beta}$, the following assumptions are needed.

Assumption 1. The information matrix $\mathcal{H}_W = \frac{1}{n}$ $\frac{1}{n} \sum_{i=1}^{n} \mathbf{W}_{i} \mathbf{W}_{i}^{T} - \mathbf{\Sigma}_{uu}$ converges to a positive definite matrix in probability.

Assumption 2. $\frac{1}{n} \sum_{i=1}^n ||\mathbf{W}_i||^4 = O_P(1)$ and $\frac{1}{n} \sum_{i=1}^n (y_i - \mathbf{W}_i^T \hat{\boldsymbol{\beta}})^4 = O_P(1)$, where $\|\mathbf{W}_i\|^k =$ $(\sum_{j=1}^p w_{ij}^2)^{k/2}.$

Assumption 3. $\max_{i=1,...,n} (n\pi_i)^{-1} = O_P(1)$.

Assumption 4. There exists some $\delta > 0$ such that $\frac{1}{n} \sum_{i=1}^{n} (y_i - \mathbf{W}_i^T \hat{\boldsymbol{\beta}})^{2+\delta} ||\mathbf{W}_i||^{2+\delta} = O_P(1)$.

Assumption [1](#page-8-1) indicates that $E(\mathbf{XX}^T)$ is positive definite and consistent with [Wang, Zhu](#page-22-4) [and Ma \(2018\)](#page-22-4). Assumption [2](#page-8-2) requires the limited moment, and ensures the consistency of parameter estimator. Assumption [3](#page-8-3) restricts the weights in $\ell^*(\beta)$ in order to protect the estimating equation from being dominated by data points with minimal subsampling probabilities. Assumption [4](#page-8-4) introduces a finite moment, which ensures the asymptotic normality of the parameter estimator.

Theorem 1. Under Assumptions [1–](#page-8-1)[3,](#page-8-3) as $r \to \infty$ and $n \to \infty$, $\tilde{\beta}$ converges to $\hat{\beta}$ in conditional probability given \mathcal{F}_n and the convergence rate is \sqrt{r} . That is, with probability approaching one, for any $\varepsilon > 0$, there exist finite constants Δ_{ε} and r_{ε} such that

$$
P(\|\tilde{\boldsymbol{\beta}} - \hat{\boldsymbol{\beta}}\| \geq r^{-1/2} \Delta_{\varepsilon} | \mathcal{F}_n) < \varepsilon
$$

for all $r > r_{\varepsilon}$.

Remark 2. If a sequence of random variables is bounded in conditional probability, it will also be bounded in unconditional probability. Therefore, Theorem [1](#page-9-0) implies that $\|\tilde{\boldsymbol{\beta}} - \hat{\boldsymbol{\beta}}\| =$ $O_P(r^{-1/2})$.

Theorem 2. Under Assumptions [1](#page-8-1)[–4,](#page-8-4) if $r = o(n)$, then as $r \to \infty$ and $n \to \infty$, $\tilde{\beta} - \hat{\beta}$ converges to a normal distribution in conditional probability given \mathcal{F}_n , that is,

$$
V^{-1/2}(\tilde{\boldsymbol{\beta}} - \hat{\boldsymbol{\beta}}) \stackrel{d}{\rightarrow} N_p(\mathbf{0}, I),
$$

where $V = \mathcal{H}_W^{-1} V_c \mathcal{H}_W^{-1}$ and

$$
V_c = \frac{1}{rn^2} \sum_{i=1}^n \frac{(y_i - \mathbf{W}_i^T \hat{\boldsymbol{\beta}})^2 \mathbf{W}_i \mathbf{W}_i^T}{\pi_i} - \frac{1}{r} (\boldsymbol{\Sigma}_{uu} \hat{\boldsymbol{\beta}})^{\otimes 2}
$$

.

Remark 3. Theorem [2](#page-9-1) shows that the second term of V_c is independent of the sampling probabilities when \mathcal{F}_n is given. Hence it can be disregarded when we compute the optimal subsampling probabilities.

3.3 Optimal subsampling algorithm

To determine the optimal subsampling probabilities, we utilize the A (or L) - optimality criterion from optimal design of experiments. This criterion aims to minimize the asymptotic mean square error of $\tilde{\beta}$ (or $\mathcal{H}_W \tilde{\beta}$). Given that $\tilde{\beta}$ (or $\mathcal{H}_W \tilde{\beta}$) is asymptotically unbiased, minimizing the asymptotic variance V (or V_c) is sufficient.

Theorem 3. (i) In Algorithm [1,](#page-8-0) if the subsampling probabilities π_i , $i = 1, \ldots, n$ are selected as

$$
\pi_i^{mV} = \frac{|y_i - \mathbf{W}_i^T \hat{\boldsymbol{\beta}}| \|\mathcal{H}_W^{-1} \mathbf{W}_i\|}{\sum_{i=1}^n |y_i - \mathbf{W}_i^T \hat{\boldsymbol{\beta}}| \|\mathcal{H}_W^{-1} \mathbf{W}_i\|}, i = 1, \dots, n,
$$
\n(3.2)

then the asymptotic variance $tr(V)$ of $\tilde{\beta}$ attains its minimum.

(ii) In Algorithm [1,](#page-8-0) if the subsampling probabilities π_i , $i = 1, \ldots, n$ are selected as

$$
\pi_i^{mV_c} = \frac{|y_i - \mathbf{W}_i^T \hat{\boldsymbol{\beta}}| \|\mathbf{W}_i\|}{\sum_{i=1}^n |y_i - \mathbf{W}_i^T \hat{\boldsymbol{\beta}}| \|\mathbf{W}_i\|}, i = 1, \dots, n,
$$
\n(3.3)

then the asymptotic variance $tr(V_c)$ of $\mathcal{H}_W\tilde{\boldsymbol{\beta}}$ attains its minimum.

In (3.2) and (3.3) , we observe that the optimal subsampling probabilities with measurement errors are similar to those of the generalized linear model developed by [Ai et al.](#page-21-3) [\(2021b\)](#page-21-3). However, our A-optimal subsampling probability includes a correction term Σ_{uu} for \mathcal{H}_W . Notably, the computing time required to determine $\|\mathcal{H}_W^{-1}\mathbf{W}_i\|$ has a complexity of $O(np^2)$. While the L-optimal subsampling method demands only $O(np)$ time to calculate $\|\mathbf{W}_{i}\|$. Due to the presence of $\hat{\boldsymbol{\beta}}$ in the optimal sampling probability, we adopt the two-step algorithm, which is summarized in Algorithm [2.](#page-11-0)

Theorem 4. Under Assumptions [1-](#page-8-1)[3,](#page-8-3) as $r_0r^{-1/2} \to 0, r \to \infty$ and $n \to \infty$, if $\tilde{\beta}_0$ exists, then $\breve{\boldsymbol{\beta}}$ converges to $\hat{\boldsymbol{\beta}}$ in conditional probability given \mathcal{F}_n and the convergence rate is \sqrt{r} . That

Algorithm 2 Optimal subsampling algorithm based on corrected likelihood

- 1 Apply the uniform subsampling probability $1/n$ to Algorithm [1](#page-8-0) with subsample size r_0 to obtain a pilot estimate $\tilde{\beta}_0$ of β . Replace $\hat{\beta}$ with $\tilde{\beta}_0$ to obtain the optimal subsampling probabilities $\{\pi_i^{mV}\}_{i=1}^n$ or $\{\pi_i^{mV_c}\}_{i=1}^n$.
- 2 Take the optimal subsampling probabilities into Algorithm [1](#page-8-0) with subsample size r . Combine the $r_0 + r$ samples obtained from the two steps, and obtain β .

is, with probability approaching one, for any $\varepsilon > 0$, there exist constants Δ_{ε} and r_{ε} such that

$$
P(\|\check{\boldsymbol{\beta}} - \hat{\boldsymbol{\beta}}\| \geq r^{-1/2} \Delta_{\varepsilon} | \mathcal{F}_n) < \varepsilon
$$

for all $r > r_{\varepsilon}$, where $\breve{\beta}$ is obtained by Algorithm [2.](#page-11-0)

Theorem 5. Under Assumptions [1](#page-8-1)[-4,](#page-8-4) if $r = o(n)$, then as $r_0r^{-1/2} \to 0$ and $r \to \infty$, $\check{\beta} - \hat{\beta}$ converges to a normal distribution in conditional probability given \mathcal{F}_n , that is,

$$
(V^{\tilde{\boldsymbol{\beta}}_0})^{-1/2}(\check{\boldsymbol{\beta}}-\hat{\boldsymbol{\beta}})\stackrel{d}{\to}N_p(\mathbf{0},I),
$$

where $\breve{\boldsymbol{\beta}}$ is obtained by Algorithm [2,](#page-11-0) $V^{\tilde{\boldsymbol{\beta}}_0} = \mathcal{H}_{W}^{-1} V_{c}^{\tilde{\boldsymbol{\beta}}_0} \mathcal{H}_{W}^{-1}, \mathcal{H}_{W} = \frac{1}{n}$ $\frac{1}{n} \sum_{i=1}^{n} \mathbf{W}_i \mathbf{W}_i^T - \mathbf{\Sigma}_{uu}$ and

$$
V_c^{\tilde{\boldsymbol{\beta}}_0} = \frac{1}{rn^2} \sum_{i=1}^n \frac{(y_i - \mathbf{W}_i^T \hat{\boldsymbol{\beta}})^2 \mathbf{W}_i \mathbf{W}_i^T}{\pi_i(\tilde{\boldsymbol{\beta}}_0)} - \frac{1}{r} (\boldsymbol{\Sigma}_{uu} \hat{\boldsymbol{\beta}})^{\otimes 2}.
$$

The standard error of an estimator has significant importance for statistical inference, such as hypothesis test and constructing confidence intervals. However, the computation of asymptotic covariance matrices necessitates utilizing the full data, which can be highly resource-intensive given the substantial sample size. To reduce computational costs, we employ the subsample to approximate the covariance matrix of β . This approximation is denoted as

$$
\breve{V}=\breve{\mathcal{H}}_W^{-1}\breve{V}_c\breve{\mathcal{H}}_W^{-1},
$$

where $\breve{\mathcal{H}}_W = \frac{1}{n(r_0)}$ $\frac{1}{n(r_0+r)}\sum_{i=1}^{r+r_0} \mathbf{W}_i^* \mathbf{W}_i^{*T} - \mathbf{\Sigma}_{uu}$, and

$$
\breve{V}_c = \frac{1}{(r+r_0)^2 n^2} \sum_{i=1}^{r+r_0} \frac{(y_i^* - \mathbf{W}_i^* \breve{\mathbf{B}})^2 \mathbf{W}_i^* \mathbf{W}_i^{*T}}{\pi_i^*} - \frac{1}{r+r_0} (\mathbf{\Sigma}_{uu} \breve{\mathbf{B}})^{\otimes 2}.
$$

Here, \mathcal{H}_W and \check{V}_c represent moment estimations for \mathcal{H}_W and V_c , respectively. If $\check{\beta}$ is substituted with $\hat{\boldsymbol{\beta}}$, these estimates become unbiased.

4. Perturbation subsampling based on corrected likelihood

The optimal subsampling algorithm mentioned in Section 3 requires the calculation of unequal sampling probabilities for the full data at once. However, as the sample size increases, implementation becomes increasingly memory-intensive. Therefore, this section introduces the perturbation subsampling algorithm to address this issue.

4.1 Perturbation subsampling algorithm

Suppose that $\{\mu_i\}_{i=1}^n$ are generated from a Bernoulli distribution with probability $q_n = r/n$, $\{\nu_i\}_{i=1}^n$ are generated from a known probability distribution with mean $1/q_n$. The weighted loss function can be written as

$$
L^*(\boldsymbol{\beta}) = \frac{1}{2n} \sum_{i=1}^n \psi_i (y_i - \mathbf{W}_i^T \boldsymbol{\beta})^2 - \frac{1}{2} \boldsymbol{\beta}^T \boldsymbol{\Sigma}_{uu} \boldsymbol{\beta},
$$

where $\psi_i = \mu_i \nu_i$.

Algorithm 3 Perturbation subsampling algorithm based on corrected likelihood

- 1 **Sampling:** Generate *n* i.i.d. random variables $\{\mu_{k,i}\}_{i=1}^n$ such that $\mu_{k,i} \sim$ *Bernoulli* (q_n) , where $q_n = r/n$.
- 2 Random weighting: Generate n i.i.d. random variables $\{\nu_{k,i}\}_{i=1}^n$ from a completely known distribution with $E(\nu_{k,i}) = 1/q_n$ and variance being b_n^2 .
- 3 Estimation: Minimize $L^*(\beta)$ to obtain parameter estimator $\tilde{\beta}_k = \arg\min_{\beta} L^*(\beta)$.
- 4 **Combination** Repeat steps 1-3 m times and then combine the resulting estimates, namely $\check{\boldsymbol{\beta}}^{(m)} = \frac{1}{m}$ $\frac{1}{m}\sum_{k=1}^m \check{\boldsymbol{\beta}}_k$.

The conditional variance of $\check{\beta}^{(m)}$ can be estimated as

$$
\widehat{Var}(\check{\boldsymbol{\beta}}^{(m)}|\mathcal{F}_n) = \frac{1}{m(m-1)}\sum_{k=1}^m(\check{\boldsymbol{\beta}}_k - \check{\boldsymbol{\beta}}^{(m)})(\check{\boldsymbol{\beta}}_k - \check{\boldsymbol{\beta}}^{(m)})^T.
$$

4.2 Asymptotic properties

To obtain the asymptotic properties of $\check{\beta}^{(m)}$, the following assumption is given.

Assumption 5. lim sup $\limsup_{n\to\infty} q_n E(\psi^2) < \infty$, and there exists $\alpha > 0$ such that $\limsup_{n\to\infty}$ n→∞ $q_n^{2+\alpha} E \nu^{2+\alpha} <$ ∞.

In Assumption [5,](#page-13-0) finite second-order moment and higher-order moment are assumed, It is equivalent to that there exists $\alpha > 0$ such that lim sup n→∞ $q_n^{1+\alpha} E \psi^{2+\alpha} < \infty.$

Theorem 6. Under Assumptions [1,](#page-8-1) [2,](#page-8-2) [5,](#page-13-0) as $r \to \infty$ and $n \to \infty$, then $\check{\beta}^{(m)}$ converges to $\hat{\beta}$ in conditional probability given \mathcal{F}_n and the convergence rate is \sqrt{mr} . That is, with probability approaching one, for any $\varepsilon > 0$, there exist constants Δ_{ε} and r_{ε} such that

$$
P(\|\check{\boldsymbol{\beta}}^{(m)} - \hat{\boldsymbol{\beta}}\| \ge (mr)^{-1/2} \Delta_{\varepsilon}|\mathcal{F}_n) < \varepsilon
$$

for all $r > r_{\varepsilon}$.

Remark 4. According to Theorem [6,](#page-13-1) $\check{\boldsymbol{\beta}}^{(m)}$ is the consistent estimator of $\hat{\boldsymbol{\beta}}$. When $rm < n$, the convergence rate is \sqrt{rm} , otherwise it is \sqrt{n} . Hence, the estimation based on the full data is still more effective than that using repeat perturbation subsampling.

Theorem 7. Under Assumptions [1,](#page-8-1) [2,](#page-8-2) [4,](#page-8-4) [5,](#page-13-0) if $r = o(n)$, then as $r \to \infty$ and $n \to \infty$, $\check{\bm{\beta}}^{(m)}-\hat{\bm{\beta}}$ converges to a normal distribution in conditional probability given \mathcal{F}_n , that is,

$$
\Sigma^{-1/2}\sqrt{mr/a_n}(\check{\boldsymbol{\beta}}^{(m)}-\hat{\boldsymbol{\beta}})\stackrel{d}{\to}N_p(\mathbf{0},I),r\to\infty,n\to\infty,
$$

where $a_n = 1 - q_n + b_n^2 q_n^2$, $\Sigma = \mathcal{H}_{W}^{-1} \Sigma_c \mathcal{H}_{W}^{-1}$, $\mathcal{H}_{W} = \frac{1}{n}$ $\frac{1}{n} \sum_{i=1}^{n} \mathbf{W}_{i} \mathbf{W}_{i}^{T} - \mathbf{\Sigma}_{uu}, \text{ and } \Sigma_{c} =$ 1 $\frac{1}{n}\sum_{i=1}^n \mathbf{W}_i \mathbf{W}_i^T (y_i - \mathbf{W}_i^T \hat{\boldsymbol{\beta}})^2.$

5. Simulation studies

We generate the full data from model (2.1) with $n = 10000$, $\boldsymbol{\beta} = (1, 1, 1, 1, 1)^T$ and $\epsilon_i \sim$ $N(0, \sigma_{\epsilon}^2)$. Let $\mathbf{X}_i \sim N_5(\mathbf{0}, \Sigma)$, where $\Sigma_{j,k} = 0.5^{|j-k|}$, for $j, k = 1, 2, ..., 5$, and $\mathbf{U}_i \sim$ $N_5(\mathbf{0}, \sigma_u^2 I)$, then $\mathbf{W}_i = \mathbf{X}_i + \mathbf{U}_i$. We consider the following three values for σ_u^2 and σ_ϵ^2 . respectively: $\sigma_u^2 = 0.6, 0.4, 0.2; \sigma_{\epsilon}^2 = 1.44, 1, 0.64.$

In Algorithm [3,](#page-13-2) let $m = 10$, and assume that the known distribution with random weighting follows an exponential distribution with mean $1/q_n$, i.e., $\nu_i \sim \text{Exp}(q_n)$. Correspondingly, $b_n^2 = 1/q_n^2$ and $a_n = 1 - q_n + b_n^2 q_n^2 = 2 - q_n$. We choose $r_0 = 100$ and $r = 200, 400, 600, 800, 1000$. For each value of r, we perform $N = 1000$ repetitions to calculate the mean squared error (MSE): $\frac{1}{N} \sum_{i=1}^{N} ||\hat{\beta}_i - \beta||^2$. For comparison, we consider six subsampling methods including the perturbation subsampling based on corrected likelihood in Algorithm [3](#page-13-2) (CLEPS), A (or L)-optimal subsampling based on corrected likelihood in Algorithm [2](#page-11-0) (A-opt and L-opt), uniform subsampling (UNIF), leverage subsampling (BLEV), and D-optimal subsampling (IBOSS). Measurement errors are not considered for UNIF, BLEV and IBOSS. To ensure equity, all methods except for A-opt and L-opt use $r_0 + r$ subsamples for parameter estimation.

The results presented in Figure [2](#page-16-0) demonstrate the superior performance of CLEPS compared to other methods, closely followed by the A-opt and L-opt. Furthermore, as the subsample size increases, the MSEs of our proposed methods approach to zero, while other approaches that do not account for measurement errors show relatively stable MSEs. These results confirm the inconsistency of ordinary least squares estimator for linear models with measurement errors. Additionally, decreasing σ_u^2 and σ_{ϵ}^2 lead to a reductions for MSEs obtained by all six methods. Notably, even for big variance of the random error, our methods maintain good performance.

To further investigate the impact of other parameters on the sampling method, Figure [3](#page-17-0) offers the variations in MSE across distinct values of r_0, n, p , and m while keeping $\sigma_{\epsilon}^2 = 1$ and $\sigma_u^2 = 0.4$. Additionally, Table [1](#page-17-1) presents the results about different m for CLEPS.

In Figure [3,](#page-17-0) the top left plot shows that as r_0 ascends, the performance of A-opt and L-opt initially enhances and subsequently declines for fixed $r_0 + r = 1000$. This reason is that the inaccurate estimation is obtained in the first step when r_0 is too small. The top right plot indicates that as the sample size increases, the CLEPS performs more efficiently,

while other methods remain almost unchanged. The bottom left plot displays that as the dimension p increases, the MSEs of various methods rises. When $p > 15$, A-opt and L-opt underperform compared to other methods, whereas the CLEPS consistently demonstrates the best performance. The bottom right plot shows that when $m = 1$, the MSE of CLEPS is slightly bigger than the A-opt and L-opt.

In Table [1,](#page-17-1) it is observed that as m increases, the MSE decreases. However, the rate of reduction in MSE progressively diminishes. This suggests that m should be significantly

smaller than r in order to achieve effective inference. It is advisable to set $m < r/10$, in accordance with the findings in [Shang and Cheng \(2017\)](#page-22-10), [Wang \(2019b\)](#page-22-1), and [Wang and Ma](#page-22-6) [\(2021\)](#page-22-6), which suggest that the number of partitions should be significantly smaller than the sample size within each data partition.

6. Real examples

6.1 Diamond price dataset

The diamond price dataset is an integrated dataset containing prices and other characteristics of approximately 54,000 diamonds. This dataset can be accessed at https://www.kaggle.com /datasets/shivam2503/diamonds. Our aim is to explore the relationship between diamond prices (y) and three covariates: carat (x_1) , depth (x_2) and table (x_3) . All variables are standardized and the linear model is

$$
y = x_1\beta_1 + x_2\beta_2 + x_3\beta_3 + \epsilon.
$$

Following the literature, the measurement error model is $\mathbf{W} = \mathbf{X} + \mathbf{U}$, where $\mathbf{X} =$ $(x_1, x_2, x_3)^T$, U is the measurement error vector with mean zero and covariance matrix $\sigma_u^2 I_3$, $\sigma_u^2 = 0.6, 0.4, 0.2$. Figure [4](#page-19-0) depicts MSEs for different σ_u^2 and r values when $m = 10, r_0 =$ $200, N = 500$. As the sample size increases, the MSEs of the proposed methods decrease and become smaller than those of other methods. Moreover, with an increase in the variance of measurement error, there is a corresponding decrease in the MSEs of the proposed methods.

6.2 Airline delay dataset

The airline delay dataset has nearly 120 million records, which can be found in https:// community.amstat.org/jointscsg-section/dataexpo/dataexpo2009. It includes detailed information on the arrival and departure of all commercial flights within the America from 1987 to 2008. This study focuses solely on 2008 data, yielding a total of 2389217 samples and 29 variables. After cleaning, 715731 observation data points were obtained. We select Arrival Delay as the response variable, with Departure Delay, Distance, Air Time, and Elapsed Time as the covariates. It's worth noting that the flight elapsed time incorporates two types of time: Actual Elapsed Time and CRS Elapsed Time. Among them, the CRS Elapsed Time refers to the original elapsed time. Therefore, the Flight Elapsed Time is regarded as a variable with measurement errors of two repetitions, while other variables have no measurement errors. The estimate for the covariance matrix of measurement error is

$$
\begin{bmatrix} 0 & & & \\ & 0 & & \\ & & 0 & \\ & & & 0.0195 \end{bmatrix}.
$$

In our proposed methods, the Flight Elapsed Time is calculated as the mean of the two variables, whereas in other methods, it is determined as the Actual Elapsed Time.

Figure [5](#page-20-0) displays the impact of varying r on MSE when $m = 10, r_0 = 200$, and $N = 500$. Notably, the MSEs of the proposed methods consistently decrease and outperform other methods, indicating that our methods also have good properties in applications when Σ_{uu} is unknown.

7. Summary

For large-scale data with measurement errors in covariates of linear models, this paper studies two subsampling methods based on the corrected likelihood. Theoretical results and numerical studies demonstrate that the two algorithms proposed in this paper outperform other existed sampling methods when measurement errors are present. However, this work only considers linear models. Future research directions could include investigating nonlinear models, high-dimensional data, or distributed data.

where $\mathcal{H}_W = \frac{1}{r}$ $\frac{1}{r}\sum_{i=1}^{r}[\frac{1}{n\pi_{i}^{\ast}}\mathbf{W}_{i}^{\ast}\mathbf{W}_{i}^{\ast T}-\mathbf{\Sigma}_{uu}], \dot{\ell}^{\ast}(\boldsymbol{\beta})=\frac{1}{n}\sum_{i=1}^{r}$ $\frac{1}{r\pi_i^*}[-\mathbf{W}_i^*(y_i^*-\mathbf{W}_i^{*T}\boldsymbol{\beta})] - \mathbf{\Sigma}_{uu}\boldsymbol{\beta}.$ Therefore, we only need to prove

> $\dot{\ell}^*(\hat{\boldsymbol{\beta}}) = O_{P \mid \mathcal{F}_n}(r^{-1/2})$ $(S2.2)$

\tilde{\mathcal{H}}_W - \mathcal{H}_W = O_{P|\mathcal{F}_n}(r^{-1/2}),\tag{S2.3}

where $\mathcal{H}_W = \frac{1}{n}$ $\frac{1}{n}\sum_{i=1}^n \mathbf{W}_i \mathbf{W}_i^T - \mathbf{\Sigma}_{uu}.$

\tilde{\boldsymbol{\beta}} - \hat{\boldsymbol{\beta}} = O_{P|\mathcal{F}_n}(r^{-1/2}).\tag{S6.4}

As $m>1$, we have $\check{\boldsymbol{\beta}}^{(m)}=\frac{1}{m}$ $\frac{1}{m} \sum_{k=1}^{m} \check{\beta}_k$. Then according to the weak law of large numbers, it follows that
