# ON THE CLASSIFICATION OF FINITE QUASI-QUANTUM GROUPS OVER ABELIAN GROUPS

#### Abstract

Using a variety of methods developed in the theory of finite-dimensional quasi-Hopf algebras, we classify all finite-dimensional coradically graded pointed coquasi-Hopf algebras over abelian groups. As a consequence, we partially confirm the generation conjecture of pointed finite tensor categories due to Etingof, Gelaki, Nikshych and Ostrik.


## 1. Introduction

As a continuation to a series of previous works [17, 18, 20], this paper completes the classification problem of finite-dimensional coradically graded pointed coquasi-Hopf algebras over abelian groups. Throughout, we work over an algebraically closed field $\mathbb{k}$ of characteristic zero. Unless stated otherwise, in this paper all spaces, maps, (co)algebras, (co)modules, and categories, etc., are over $\mathbb{k}$.

The classification of finite-dimensional pointed Hopf algebras over finite abelian groups was completed over the last two decades, and a systematic approach (in particular Weyl groupoids and arithmetic root systems) was established, see [3, 5, 6, 14, 15]. Meanwhile, Etingof and Gelaki proposed to classify pointed finite tensor categories. By the Tannakian formalism [11], this amounts to a classification of certain finite quasi-quantum groups, namely finite-dimensional elementary quasi-Hopf algebras, or dually finite-dimensional pointed coquasi-Hopf algebras. In the pioneering works [7, 8, $9,13,4]$, a few examples and classification results of such algebras, and consequently the associated pointed finite tensor categories, are thus obtained. In [17, 18, 20], the authors of the present paper continue the study of the classification problem of finite quasi-quantum groups and several interesting classification results are also obtained. To explain this and our main result of this paper, we need some concrete notations.
Once and for all, let $G$ be a finite abelian group and $\Phi$ be a 3-cocycle on $G$. Based on an analog of the lifting method in the theory of finite-dimensional pointed Hopf algebras, a complete understanding of the Nichols algebras in the twisted YetterDrinfeld module category ${ }_{{ }_{k} G}^{\mathrm{k} G} \mathcal{Y} \mathcal{D}^{\Phi}$ is the crux for the classification of finite-dimensional pointed coquasi-Hopf algebras. A twisted Yetter-Drinfeld module $V \in{ }_{\mathbb{k} G}^{\mathbb{k} G} \mathcal{Y} \mathcal{D}^{\Phi}$ is said to be of diagonal type, if it is a direct sum of 1-dimensional twisted Yetter-Drinfeld

[^0]modules. The associated Nichols algebra $B(V)$ is called diagonal if $V$ is so. Let $H$ be a pointed coquasi-Hopf algebra over $G$, and $\operatorname{gr}(H)$ the coradically graded coquasiHopf algebra associated to $H$. The coinvariant subalgebra $R$ of $\operatorname{gr}(H)$ will be a twisted Yetter-Drinfeld module in ${ }_{k G}^{k G} \mathcal{Y D}^{\Phi}$ for certain $\Phi$, and $H$ is called diagonal if $R$ is diagonal as a twisted Yetter-Drinfeld module. In [17, 18], we classified all finite-dimensional Nichols algebras of diagonal type in ${ }_{k G}^{\mathbb{K} G} \mathcal{Y D}^{\Phi}$ and proved that every finite-dimensional pointed coquasi-Hopf algebra of diagonal type must be the form of $B(V) \# \mathbb{k} G$.

The aim of this paper is to study Nichols algebras of nondiagonal type and the main result is the following (see Theorem 3.1 for an equivalent form).
Theorem 0.1. Let $B(V) \in{ }_{k}^{k} G \mathcal{V} \mathcal{D}^{\Phi}$ be a Nichols algebra of nondiagonal type with $G_{V}=G$. Then $B(V)$ is infinite dimensional.
Here $G_{V}$ is the support group of $V$ (see the paragraph after Definition 2.3). Under assumption that $G_{V}=G$, which is natural for us since the braided Hopf algebra structure of $B(V)$ is determined by $G_{V}$ rather than $G$ (see the paragraph after Proposition 2.6), our result tells us that every finite-dimensional Nichols algebra $B(V) \in{ }_{k G G}^{k} \mathcal{Y D}^{\Phi}$ must be of diagonal type finally, which already was classified in our previous works. As consequences, we can get the structure of general finite-dimensional pointed coquasiHopf algebras now (see Theorems 5.1 and 5.2).
Theorem 0.2. If $M$ is a finite-dimensional pointed coquasi-Hopf algebra over finite abelian group $G$, then $\operatorname{gr}(M) \cong B(V) \# \mathfrak{k} G$ for a Yetter-Drinfeld module of finite type $V \in{ }_{\frac{k}{k} G}^{\mathrm{k} G} \mathcal{D D}^{\Phi}$.
In [11], Etingof, Gelaki, Nikshych and Ostrik conjecture that every pointed finite tensor category over a field of characteristic zero is tensor generated by objects of length 2. Let $G(\mathcal{C})$ be the set of isomorphism classes of simple objects in a pointed tensor category $\mathcal{C}$. Then $G(\mathcal{C})$ is naturally a group under tensor product. Using our classification result and some useful result in [18], we can partially prove the conjecture (see Theorem 5.5).

Theorem 0.3. Let $\mathcal{C}$ be a pointed finite tensor category over a field of characteristic zero. If the group $G(\mathcal{C})$ is abelian, then $\mathcal{C}$ is tensor generated by objects of length 2 .

The paper is organized as follows. In Section 2, we recall some necessary notions and particularly introduce a method to study Nichols algebras in ${\underset{k}{k} G}_{\mathbb{K} G} \mathcal{Y D}^{\Phi}$ called change of based groups. Sections 3 and 4 are designed to give a proof of the above Theorem 0.1. The last section is devoted to the classification of finite-dimensional pointed coquasi-Hopf algebras and the generation problem of pointed finite tensor categories.

## 2. Preliminaries

In this section, we recall some necessary notions and basic facts about pointed coquasiHopf algebras, twisted Yetter-Drinfeld modules and Nichols algebras. The reader is referred to $[11,17,18]$ for related concepts and notations.
2.1. Pointed coquasi-Hopf algebras. A coquasi-Hopf algebra is a coalgebra $(H, \Delta, \varepsilon)$ equipped with a compatible quasi-algebra structure and a quasi-antipode. Namely, there exist two coalgebra homomorphisms

a convolution-invertible map $\Phi: H^{\otimes 3} \longrightarrow \mathbb{k}$ called the associator, a coalgebra antimorphism $S: H \longrightarrow H$ and two functions $\alpha, \beta: H \longrightarrow \mathbb{k}$ such that for all $a, b, c, d \in H$ the following equalities hold:

The triple $(S, \alpha, \beta)$ is called a quasi-antipode. $H$ is called a pointed coquasi-Hopf algebra if $(H, \Delta, \varepsilon)$ is a pointed coalgebra, i.e., every simple comodule of $H$ is 1dimensional.

Let $C$ be a coalgebra, the coradical $C_{0}$ of $C$ is the sum of all simple subcoalgebras of $C$. Fix a coalgebra $C$ with coradical $C_{0}$, define $C_{n}$ inductively as follows: for each $n \geq 1$, define

C_{n}=\Delta^{-1}\left(C \otimes C_{n-1}+C_{0} \otimes C\right)

Then we get a filtration $C_{0} \subset C_{1} \subset \cdots C_{n} \subset \cdots$, which is called the coradical filtration of $C$. A coquasi-Hopf algebra has a coradical filtration since it is a coalgebra.
Given a coquasi-Hopf algebra $(H, \Delta, \varepsilon, m, \mu, \Phi, S, \alpha, \beta)$, let $\left\{H_{n}\right\}_{n \geq 0}$ be its coradical filtration, and let

\operatorname{gr} H=H_{0} \oplus H_{1} / H_{0} \oplus H_{2} / H_{1} \oplus \cdots,
$$

the corresponding coradically graded coalgebra. Then naturally gr $H$ inherits from $H$ a graded coquasi-Hopf algebra structure. The corresponding graded associator $\mathrm{gr} \Phi$ satisfies $\operatorname{gr} \Phi(\bar{a}, \bar{b}, \bar{c})=0$ for all homogeneous elements $\bar{a}, \bar{b}, \bar{c} \in \operatorname{gr} H$ unless they all lie in $H_{0}$. Similar conditions hold for gr $\alpha$ and $\operatorname{gr} \beta$. A coquasi-Hopf algebra $H$ is called coradically graded if $H \cong \operatorname{gr}(H)$ as coquasi-Hopf algebras.

If $H$ is a pointed coquasi-Hopf algebra, then $H_{0}$ is a pointed cosemisimple coquasiHopf algebra, which is determined by a group $G$ together with a 3-cocycle on $G$ as follows.

Example 2.1. Let $G$ be a group. Clearly the group algebra $\mathbb{k} G$ is a Hopf algebra with $\Delta(g)=g \otimes g, S(g)=g^{-1}$ and $\varepsilon(g)=1$ for any $g \in G$. Let $\omega$ be a normalized 3-cocycle on $G$, i.e.

for all e, $f, g, h \in G$. By linearly extending, $\omega:(\mathbb{k} G)^{\otimes 3} \rightarrow \mathbb{k}$ becomes a convolutioninvertible map. Define two linear functions $\alpha, \beta: \mathbb{k} G \rightarrow \mathbb{k}$ by

\alpha(g):=\varepsilon(g) \quad \text { and } \quad \beta(g):=\frac{1}{\omega\left(g, g^{-1}, g\right)}
$$

for any $g \in G$. Then $k G$ together with these $\omega, \alpha$ and $\beta$ makes a coquasi-Hopf algebra, which will be written as $(\mathbb{k} G, \omega)$ in the following. The comodule category of $(\mathbb{k} G, \omega)$ forms a tensor category, which is called a Gr-category and denoted by $\operatorname{Vec}_{G}^{\omega}$.

Let us now consider the construction of Gr-categories which will be especially important in this paper. The crux to determine all the Gr-categories is to give a complete list of the representatives of the 3 -cohomology classes in $\mathrm{H}^{3}\left(G, \mathbb{k}^{*}\right)$ for all groups $G$. However, when $G$ is a finite abelian group, the problem was solved in [18], and a list of the representatives of $\mathrm{H}^{3}\left(G, \mathbb{k}^{*}\right)$ can be given as follows.
Let $\mathbb{N}$ denote the set of nonnegative integers, $\mathbb{Z}$ the ring of integers, and $\mathbb{Z}_{m}$ the cyclic group of order $m$. Any finite abelian group $G$ is of the form $\mathbb{Z}_{m_{1}} \times \cdots \times \mathbb{Z}_{m_{n}}$ with $m_{j} \in \mathbb{N}$ for $1 \leq j \leq n$. Denote by $\mathcal{A}$ the set of all $\mathbb{N}$-sequences

such that $0 \leq c_{l}<m_{l}, 0 \leq c_{i j}<\left(m_{i}, m_{j}\right), 0 \leq c_{r s t}<\left(m_{r}, m_{s}, m_{t}\right)$ for $1 \leq l \leq n, 1 \leq$ $i<j \leq n, 1 \leq r<s<t \leq n$, where $c_{i j}$ and $c_{r s t}$ are ordered in the lexicographic order of their indices. We denote by $\underline{\mathbf{c}}$ the sequence (2.3) in the following. Let $g_{i}$ be a generator of $\mathbb{Z}_{m_{i}}, 1 \leq i \leq n$. For any $\underline{\mathbf{c}} \in \mathcal{A}$, define

Here and below $\zeta_{m}$ stands for an $m$-th primitive root of unity. According to [18, Proposition 3.8], $\left\{\omega_{\underline{\mathbf{c}}} \mid \underline{\mathbf{c}} \in \mathcal{A}\right\}$ forms a complete set of representatives of the normalized 3 -cocycles on $G$ up to 3 -cohomology.
2.2. Nichols algebras of Yetter-Drinfeld modules. Nichols algebras are very important for the construction of pointed coquasi-Hopf algebras. For our purpose, we are mainly concerned with the Nichols algebras in the Yetter-Drinfeld module category of the coquasi-Hopf algebra $(\mathbb{k} G, \Phi)$, where $G$ is a finite abelian group and $\Phi$ is a normalized 3 -cocycle on $G$. To emphasize $\Phi$, we denote the Yetter-Drinfeld category of $(\mathbb{k} G, \Phi)$ as ${ }_{k G}^{k G} \mathcal{Y} \mathcal{D}^{\Phi}$. For convenience, we call an object in ${ }_{k G}^{k G} \mathcal{Y} \mathcal{D}^{\Phi}$ a twisted Yetter-Drinfeld module. Define

for all $g, x, y \in G$. By direct computation one can show that $\widetilde{\Phi}_{g}$ is a 2 -cocycle on $G$. The construction of category of twisted Yetter-Drinfeld modules can be summarized as follows, the detailed computations can be found in $[18,19]$.

Definition 2.2. An object in ${ }_{k G G}^{\mathbb{k} G} \mathcal{Y D}^{\Phi}$ is a $G$-graded vector space $V=\oplus_{g \in G} V_{g} \quad\left(V_{g}=\right.$ $\{v \in V \mid \rho(v)=g \otimes v\}$ as a $k G$-comodule) with each $V_{g}$ a projective $G$-representation with respect to the 2-cocycle $\widetilde{\Phi}_{g}$, namely for any e, $f \in G, v \in V_{g}$ we have

The module structure on the tensor product $V_{g} \otimes V_{h}$ is determined by

The associativity and the braiding constraints of ${ }_{k G G}^{k G} \mathcal{Y D}^{\Phi}$ are given respectively by

for all $X \in V_{e}, Y \in V_{f}, Z \in V_{g}$.
Let $\Phi$ be a 3 -cocycle on $G$ as given in (2.4). One can verify directly that

Suppose $V_{g}$ is $\left(G, \widetilde{\Phi}_{g}\right)$-representation, $V_{h}$ is a $\left(G, \widetilde{\Phi}_{h}\right)$-representation, then $V_{g} \otimes V_{h}$ is a $\left(G, \widetilde{\Phi}_{g h}\right)$-representation. In particular, the dual object $V_{g}^{*}$ of $V_{g}$ is a $\left(G, \widetilde{\Phi}_{g^{-1}}\right)$ representation and $\left(V_{g}^{*}\right)^{*}=V_{g}$, see [20, Proposition 2.5] for details.
A Yetter-Drinfeld module $V \in{ }_{k G G}^{k G} \mathcal{Y}^{\Phi}$ is called diagonal if $V$ is direct sum of 1 dimensional twisted Yetter-Drinfeld modules. For a simple Yetter-Drinfeld module $V$ in ${ }_{k G G}^{\mathbb{k} G} \mathcal{Y D}^{\Phi}$, there exists some $g \in G$ such that $V=V_{g}$ and we define $g_{V}:=g$ in this case. Recall that a 2-cocycle $\varphi$ on $G$ is called symmetric if $\varphi(g, h)=\varphi(h, g)$ for all $h, g \in G$. By (2.6), it is not hard to show that a simple Yetter-Drinfeld module $V$ with $g_{V}=g$ is 1-dimensional if and only if $\widetilde{\Phi}_{g}$ is symmetric.
Let $V$ be a nonzero object in ${ }_{k}^{k} G \mathcal{Y} \mathcal{D}^{\Phi}$. By $T(V)$ we denote the tensor algebra in ${ }_{\mathbb{k} G}^{\mathbb{k} G} \mathcal{Y D}^{\Phi}$ generated freely by $V$. It is clear that $T(V)$ is isomorphic to $\bigoplus_{n \geq 0} V^{\otimes \vec{n}}$ as a linear
 structure on $T(V)$. Define a comultiplication on $T(V)$ by $\Delta(X)=X \otimes 1+1 \otimes X, \forall X \in$ $V$, a counit by $\varepsilon(X)=0$, and an antipode by $S(X)=-X$. These provide a graded Hopf algebra structure on $T(V)$ in the braided tensor category ${ }_{k}^{\mathrm{k} G} \mathcal{Y D}^{\Phi}$.
Definition 2.3. The Nichols algebra $B(V)$ of $V$ is the quotient Hopf algebra $T(V) / I$ in ${ }_{k G}^{\frac{k}{k} G} \mathcal{Y} D^{\Phi}$, where I is the unique maximal graded Hopf ideal contained in $\bigoplus_{n \geq 2} V^{\otimes \vec{n}}$.

A Nichols algebra $B(V)$ is called of diagonal type if $V$ is diagonal. Suppose $V=$ $\bigoplus_{i=1}^{n} V_{i} \in{ }_{k G}^{k G} \mathcal{Y D}^{\Phi}$ is direct sum of simple objects, then we will say that the rank of $B(V)$ is $n$. According to [20, Proposition 3.1], $B(V)$ is a $\mathbb{Z}^{n}$-graded algebra with $\operatorname{deg} V_{i}=e_{i}$, where $\left\{e_{i}: 1 \leq i \leq n\right\}$ is a set of free generators of $\mathbb{Z}^{n}$. For $V \in{ }_{k}^{\mathbb{k} G} \mathcal{Y} \mathcal{D}^{\Phi}$, we will call $G$ the based group of $V$ and $B(V)$. Let $V=V_{1} \oplus V_{2} \oplus \cdots \oplus V_{n}$ be direct sum of simple Yetter-Drinfeld modules in ${ }_{k}^{\mathrm{k} G} \mathcal{Y}^{(1)}$, $g_{i}$ the degree of $V_{i}$ for $1 \leq i \leq n$, the subgroup $G_{V}:=\left\langle g_{1}, g_{2}, \cdots g_{n}\right\rangle$ will be called the support group of $V$.

Next we will recall the definition of the twisting of a Nichols algebra through a 2cochain of $G$. Let $\left(V, \triangleright, \delta_{L}\right) \in{ }_{\mathbb{k} G}^{\mathrm{k} G} \mathcal{Y} \mathcal{D}^{\Phi}$, and let $J$ be a 2 -cochain of $G$. There is a new action $\triangleright_{J}$ of $G$ on $V$ determined by

for homogenous element $X \in V$ and $g \in G$. Here $x=\operatorname{deg}(X)$ is the $G$-degree of $X$.
 there is a tensor equivalence

which takes $V$ to $V^{J}$ and

for $Y \in U, Z \in V$.
Let $B(V)$ be a Nichols algebra in ${ }_{k}^{\mathbb{k} G} \mathcal{Y} \mathcal{D}^{\Phi}$. Then $B(V)^{J}$ is a Hopf algebra in ${ }_{\mathbb{k} G}^{\mathbb{k} G} \mathcal{Y} \mathcal{D}^{\Phi * \partial J}$ with multiplication $\circ$ determined by

for all homogenous elements $X, Y \in B(V), x=\operatorname{deg} X, y=\operatorname{deg} Y$. Using the same terminology as for coquasi-Hopf algebras, we say that $B(V)$ and $B(V)^{J}$ are twist equivalent, or $B(V)^{J}$ is a twisting of $B(V)^{J}$.
Lemma 2.4. [18, Lemma 2.12] The twisting $B(V)^{J}$ of $B(V)$ is a Nichols algebra in ${ }_{{ }_{k}^{k} G}^{\mathrm{k} G} \mathcal{Y} \mathcal{D}^{\Phi * \partial J}$ and $B(V)^{J} \cong B\left(V^{J}\right)$.
2.3. Reduction. The study of Nichols algebras in ${\underset{\mathrm{k}}{\mathrm{k}} \mathrm{G} G}_{\mathrm{Y}}^{\mathrm{D}}{ }^{\Phi}$ is deeply related on the 3 -cocycle $\Phi$ on $G$. Recall that a 3-cocycle $\Phi$ on $G$ is called an abelian 3-cocycle if $\underset{\mathbb{k} G}{\mathbb{k} G} \mathcal{Y} \mathcal{D}^{\Phi}$ is pointed, i.e. each simple object of $\underset{\mathbb{k} G}{\mathbb{k} G} \mathcal{Y} \mathcal{D}^{\Phi}$ is 1 -dimensional. A key observation in [18] is that every Nichols algebra in ${ }_{\mathbb{k} G}^{\mathbb{k} G} \mathcal{Y D}^{\Phi}$ is twist equivalent to a Nichols algebra in a normal Yetter-Drinfeld category when $\Phi$ is an abelian 3-cocycle. Suppose $G=\mathbb{Z}_{m_{1}} \times \mathbb{Z}_{m_{2}} \times \cdots \times \mathbb{Z}_{m_{n}}, e_{i}$ is a generator of $\mathbb{Z}_{m_{i}}$ for all $1 \leq i \leq n$, and $\Phi$ is an abelian 3 -cocycle on $G$. Then up to cohomology $\Phi$ must be of the form

The folowing lemma follows immediately.
Lemma 2.5. (1). Each 3-cocycle of a finite cyclic group or direct sum of two finite cyclic groups is abelian;
(2). Let $B(V) \in \underset{\mathbb{k} G}{\mathbb{k} G} \mathcal{Y} \mathcal{D}^{\Phi}$ be a Nichols algebra of rank 1 or rank 2 , then $\Phi_{G_{V}}$ is an abelian 3-cocycle on $G_{V}$.

Suppose $G=\mathbb{Z}_{m_{1}} \times \cdots \times \mathbb{Z}_{m_{n}}=\left\langle g_{1}\right\rangle \times \cdots\left\langle g_{n}\right\rangle$. Associated to $G$ there is a finite group $\widehat{G}$ defined by

be the canonical epimorphism. The following proposition is very important for the study of Nichol algebras of diagonal type.

Proposition 2.6. [18, Proposition 3.15] Suppose that $\Phi$ is an abelian 3-cocycle on $G$. Then $\pi^{*} \Phi$ is a 3-coboundary on $\widehat{G}$, namely, there is a 2 -cochain $J$ of $\widehat{G}$ such that $\partial J=\pi^{*} \Phi$.

Since the Yetter-Drinfeld module structure of $B(V)$ is determined by the based group $G$, while the braided Hopf algebra structure of $B(V)$ and the braiding are determined by the support group $G_{V}$. So if the braided Hopf algebra structure of $B(V)$ is the only concern, we can omit some Yetter-Drinfeld module information of $B(V)$ and realize it in a new Yetter-Drinfeld category. Let $B(V) \in \underset{\mathbb{k} G}{\mathbb{k} G} \mathcal{Y} \mathcal{D}^{\Phi}$ and $B(U) \in \frac{\mathbb{k} H}{\mathbb{k} H} \mathcal{Y} \mathcal{D}^{\Psi}$, we will say that $B(V)$ is isomorphic to $B(U)$ if there is a linear isomorphism $F: B(V) \longrightarrow$ $B(U)$ which preserves the multiplication and comultiplication.
For a Yetter-Drinfeld module $V \in \underset{\mathbb{k} G}{\mathbb{k} G} \mathcal{Y D}^{\Phi}$, we use $\delta_{V}: V \longrightarrow \mathbb{k} G \otimes V$ to denote the comodule structure map of $V$.
 a finite abelian group. Let $G_{V}$ and $H_{U}$ be the support groups of $V$ and $U$ respectively. If there is a linear isomorphism $F: V \longrightarrow U$ and a group epimorphism $\pi: G_{V} \longrightarrow H_{U}$ such that:

for any $g \in G_{V}, v \in V$. Then $B(V)$ is isomorphic to $B(U)$.
Let $G$ and $\mathbb{G}$ be two finite groups and $\pi: \mathbb{G} \rightarrow G$ a group epimorphism, $\iota: G \rightarrow \mathbb{G}$ be a section of $\pi$, that is $\pi \circ \iota=\operatorname{id}_{G}$. With these notations, we have following lemma.

Lemma 2.8. Let $V \in \underset{\mathbb{k} G}{\mathbb{k} G \mathcal{Y} \mathcal{D}^{\Phi} \text {. Then there is an object } \widetilde{V} \in \underset{\mathbb{k} \mathbb{G}}{\mathbb{k} \mathbb{G}} \mathcal{Y} \mathcal{D}^{\pi^{*} \Phi} \text { such that }{ }^{\text {a }} \text {. }}$ $\widetilde{V}=V$ as linear spaces and the Yetter-Drinfeld module structure is determined by

Proof. We need to show that the space $\widetilde{V}$ with action and coaction of $\mathbb{G}$ defined by
 it is obvious that we have $\widetilde{V}=\bigoplus_{g \in G} \widetilde{V}_{\iota(g)}$ such that $\widetilde{V}_{\iota(g)}=V_{g}$ as vector spaces for all $g \in G$. We only need to prove that $\widetilde{V}_{\iota(g)}$ is a projective $\mathbb{G}$-representation associated to 2 -cocycle $\pi^{*} \Phi_{\iota(g)}$. Let $e, f \in \mathbb{G}$ and $v \in V$, we have

& =\frac{\pi^{*} \Phi(\iota(g), e, f) \pi^{*} \Phi(e, f, \iota(g))}{\pi^{*} \Phi(e, \iota(g), f)} e f \triangleright v \\

So we have proved that $\widetilde{V}_{\iota(\underline{g})}$ is a projective $\mathbb{G}$-representation associated to the 2 cocycle $\pi^{*} \Phi_{\iota(g)}$, and hence $\widetilde{V} \in \underset{\mathbb{k} \mathbb{G}}{\mathbb{k} \mathbb{Y}} \mathcal{D} \mathcal{D}^{\pi^{*} \Phi}$. The isomorphism $B(V) \cong B(\widetilde{V})$ follows from Lemma 2.7 immediately.

 cochain $J$ of $\widehat{G}$ such that $\partial J=\pi^{*} \Phi$. According to Lemma 2.4, $B\left(\widetilde{V}^{J^{-1}}\right)$ is a Nichols algebra in $\underset{\mathbb{k} \widehat{G}}{\mathbb{G} \widehat{G}} \mathcal{Y}$, which is twist equivalent to $B(V)$. So we obtain the following proposition.

Proposition 2.9. Let $\Phi$ be an abelian 3-cocycle and $B(V)$ be a Nichols algebra in


Let $V \in \underset{\mathbb{k} G}{\mathbb{k} G} \mathcal{Y} \mathcal{D}^{\Phi}$, if the action of the support group $G_{V}$ on $V$ is diagonal, then $V$ has a basis $\left\{X_{1}, \cdots, X_{n}\right\}$ such that

where $q_{i j} \in \mathbb{k}$ for $1 \leq i, j \leq n$. Such a basis $\left\{X_{1}, \cdots, X_{n}\right\}$ is called a standard basis of $V$. The following lemma follows from [18, Lemma 4.1] immediately.

Lemma 2.10. Let $V \in \underset{\mathbb{k} G}{\mathbb{k} G} \mathcal{Y}^{\Phi}$, the following three conditions are equivalent:
(1). $V$ has a standard basis.
(2). The action of support group $G_{V}$ on $V$ is diagonal.
(3). $\Phi_{G_{V}}$ is an abelian 3-cocycle on $G_{V}$.

Now suppose $V$ has a standard basis $\left\{X_{1}, \cdots, X_{n}\right\}$, then we can define a nondirected graph $\mathcal{D}(V)$ associated to $B(V)$ as follows:

1) There is a bijecton $\phi$ from $I=\{1,2, \ldots, n\}$ to the set of vertices of $\mathcal{D}(V)$.
2) For all $1 \leq i \leq n$, the vertex $\phi(i)$ is labelled by $q_{i i}$.
3) For all $1 \leq i, j \leq n$, the number $n_{i j}$ of edges between $\phi(i)$ and $\phi(j)$ is either 0 or 1 . If $i=j$ or $q_{i j} q_{j i}=1$ then $n_{i j}=0$, otherwise $n_{i j}=1$ and the edge is labelled by $\widetilde{q_{i j}}=q_{i j} q_{j i}$ for all $1 \leq i<j \leq n$.

The diagram $\mathcal{D}(V)$ is called the generalized Dynkin diagram of $B(V)$. Note that a Nichols algebra of diagonal type always has a generalized Dynkin diagram. It is also helpful to point out that if the generalized Dynkin diagram $\mathcal{D}(V)$ exists, it does not depend on the choice of the standard basis of $V$. It is not hard to see that if $B(V)$ has a generalized Dynkin diagram, then $B\left(V^{J}\right)$ also have the same generalized Dynkin diagram with $B(V)$ for any 2-cochain $J$ of $G$. So combining this with Proposition 2.9, we have the following important proposition.

 Nichols algebras have the same generalized Dynkin diagrams.

According to this proposition, all finite-dimensional Nichols algebras with a standard basis can be determined by Heckenberger's classification result of arithmetic root systems [15]. Note that if $B(V)$ is rank 1 or rank 2 , then $G_{V}$ must be a finite cyclic group or direct product of two finite cyclic groups. According to (2.4), all the 3cocycles on finite cyclic group or direct product of two finite cyclic groups must be abelian. So a Nichols algebra of rank 1 or rank 2 always has a standard basis. One of the main result in [20] is as follows.
Proposition 2.12. [20, Proposition 3.18] Suppose $V \in{ }_{k}^{\mathbb{K} G} \mathcal{Y D}^{\Phi}$ is a simple YetterDrinfeld module of nondiagonal type with $\operatorname{deg} V=g$. Then $B(V)$ is finite dimensional if and only if $V$ is one of the following two types:
(I). $g \triangleright v=-v$ for all $v \in V$;
(II). $\operatorname{dim}(V)=2$ and $g \triangleright v=\zeta_{3} v$ for all $v \in V$, here $\zeta_{3}$ is a 3 -rd primitive root of unity.

## 3. Nichols algebras

 where $G$ is a finite abelian group and $\Phi$ is a 3 -cocycle on $G$. The main result is as follows.

Theorem 3.1. Suppose that $B(V) \in{ }_{k G}^{\mathbb{K} G} \mathcal{Y D}^{\Phi}$ has no standard basis, then $B(V)$ is infinite dimensional.

See Remark 3.14 for the proof. Since a Nichols algebra of rank 1 or 2 always has a standard basis, so our start point will be Nichols algebras of rank 3 .
3.1. Nichols algebras of rank 3. Suppose $B(V) \in{ }_{k G G}^{k G} \mathcal{Y} \mathcal{D}^{\Phi}$ is a Nichols algebra of rank 3. If $\Phi_{G_{V}}$ is an abelian 3 -cocycle on $G_{V}$, then the dimension of $B(V)$ can be determined by Proposition 2.11. So in this subsection, we will mainly consider the case that $\Phi_{G_{V}}$ is nonabelian.

Definition 3.2. Let $\alpha$ be a 2 -cocycle on $G$. An element $g \in G$ is called an $\alpha$-element if $\alpha(g, h)=\alpha(h, g)$ for all $h \in G$.

Lemma 3.3. Suppose $\Phi$ is a 3 -cocycle on $G, g \in G$, then $g$ is a $\widetilde{\Phi}_{g}$-element.
Proof. For each element $h \in G$, we have

\widetilde{\Phi}_{g}(g, h)=\frac{\Phi(g, g, h) \Phi(g, h, g)}{\Phi(g, g, h)}=\frac{\Phi(h, g, g) \Phi(g, h, g)}{\Phi(h, g, g)}=\widetilde{\Phi}_{g}(h, g) .

Lemma 3.4. Let $G$ be a finite abelian group and $\Phi$ a 3 -cocycle on $G$. Then for any $g_{1}, g_{2}, g_{3} \in G$, we have

Lemma 3.5. Assume $G=\left\langle g_{1}, g_{2}, g_{3}\right\rangle$ and $V \in{ }_{k G}^{\mathbb{k} G} \mathcal{Y D}^{\Phi}$ is a simple Yetter-Drinfeld module with $\operatorname{deg} V=g_{1}$. Then $\operatorname{dim}(V)=n$, where $n$ is the order of $\frac{\widetilde{\Phi}_{g_{1}}\left(g_{2}, g_{3}\right)}{\Phi_{g_{1}}\left(g_{3}, g_{2}\right)}$. Moreover, there exists a basis $\left\{X_{1}, X_{2}, \cdots, X_{n}\right\}$ of $V$ such that

Here $\alpha, \beta, \gamma \in \mathbb{k}^{*}$ satisfy

where $m_{i}=\left|g_{i}\right|$ is the order of $g_{i}$ for $1 \leq i \leq 3$. In particular, $V$ is of diagonal type if and only if $\frac{\widetilde{\Phi}_{g_{1}}\left(g_{2}, g_{3}\right)}{\widetilde{\Phi}_{g_{1}}\left(g_{3}, g_{2}\right)}=1$.

& =\epsilon_{i} X_{1}+X_{2}+\epsilon_{i}^{-1} X_{3}+\cdots+\epsilon_{i}^{1-l} X_{l+1} \cdots+\epsilon_{i}^{s-2} X_{s} \\
& =\epsilon_{i} Y_{i} .
\end{align*}
$$

Then $Y_{i}$ 's are clearly linearly independent since they correspond to different eigenvalues. Then $\left\{Y_{1}, \cdots, Y_{s}\right\}$ forms a basis of $V$, and $\left\{\epsilon_{i} \mid 1 \leq i \leq s\right\}$ are all eigenvalues of $g_{3}$ when viewed as a linear transformation on $V$.
Next we prove that $s=n$. Notice that

\end{align*}

 hence

\underbrace{g_{2} \triangleright\left(g _ { 2 } \triangleright \left(\cdots \left(g_{2}\right.\right.\right.}_{n} \triangleright Y_{1}) \cdots)))=k Y_{1}
$$

for some scaler $k \in \mathbb{k}^{*}$. This implies that $Y_{1}, g_{2} \triangleright Y_{1}, \cdots, \underbrace{g_{2} \triangleright\left(g_{2} \triangleright\left(\cdots\left(g_{2}\right.\right.\right.}_{n-1} \triangleright Y_{1}) \cdots))$ span a sub-Yetter-Drinfeld module of $V$, and hence $V$ since $V$ is simple. So we obtain that $\operatorname{dim}(V)=n$ and hence $s=n$.

The equations (3.3) and (3.4) follow from

The last statement is obvious and the proof is completed.
By this lemma, we have the following important proposition.
Proposition 3.6. Let $V=V_{1} \oplus V_{2} \oplus V_{3} \in{ }_{\mathbb{k} G}^{\mathbb{k} G} \mathcal{Y D}^{\Phi}$ be a direct sum of simple twisted Yetter-Drinfeld modules with $G=G_{V}$. Then we have

Proof. Let $\operatorname{deg} V_{i}=g_{i}, 1 \leq i \leq 3$. Then $G=\left\langle g_{1}, g_{2}, g_{3}\right\rangle$ since $G_{V}=G$. By Lemma 3.5, we have $\operatorname{dim}\left(V_{1}\right)=\left|\frac{\widetilde{\Phi}_{g_{1}}\left(g_{2}, g_{3}\right)}{\widetilde{\Phi}_{g_{1}}\left(g_{3}, g_{2}\right)}\right|, \operatorname{dim}\left(V_{2}\right)=\left|\frac{\widetilde{\Phi}_{g_{2}}\left(g_{3}, g_{1}\right)}{\tilde{\Phi}_{g_{2}}\left(g_{1}, g_{3}\right)}\right|, \operatorname{dim}\left(V_{3}\right)=\left|\frac{\widetilde{\Phi}_{g_{3}}\left(g_{1}, g_{2}\right)}{\widetilde{\Phi}_{g_{3}}\left(g_{2}, g_{1}\right)}\right|$, and (3.16) follows from Lemma 3.4.

Now we can consider nondiagonal Nichols algebras of rank 3. Firstly, we have the following propositions.
Proposition 3.7. Let $V=V_{1} \oplus V_{2} \oplus V_{3} \in{ }_{\mathbb{k} G}^{\mathbb{k} G} \mathcal{Y D}^{\Phi}$ be a direct sum of simple twisted Yetter-Drinfeld modules with $G=G_{V}$. If $\operatorname{dim}\left(V_{1}\right)=\operatorname{dim}\left(V_{2}\right)=\operatorname{dim}\left(V_{3}\right) \geq 3$, then $B(V)$ is infinite dimensional.

Proof. Let $\operatorname{deg} V_{i}=g_{i}, 1 \leq i \leq 3$. Since $G=G_{V}$, we have $G=\left\langle g_{1}, g_{2}, g_{3}\right\rangle$. Let $\left|g_{i}\right|=m_{i}, 1 \leq i \leq 3$, and $n=\left|\frac{\tilde{\Phi}_{g_{1}}\left(g_{2}, g_{3}\right)}{\tilde{\Phi}_{g_{1}}\left(g_{3}, g_{2}\right)}\right|$. Then $\operatorname{dim}\left(V_{1}\right)=\operatorname{dim}\left(V_{2}\right)=\operatorname{dim}\left(V_{3}\right)=n$ by Proposition 3.6. According to Proposition 2.12, if $V_{i}$ is not a simple Yetter-Drinfeld module of type (I) for some $i \in\{1,2,3\}$, then $B\left(V_{i}\right)$ must be infinite dimensional, hence $B(V)$ is infinite dimensional.
In the following, we assume that $V_{1}, V_{2}, V_{3}$ are simple Yetter-Drinfeld modules of type (I). By Lemma 3.5, $V_{1}$ has a basis $\left\{X_{1}, X_{2}, \cdots, X_{n}\right\}$ such that

Similarly, $V_{2}$ also has a basis $\left\{Y_{1}, Y_{2}, \cdots, Y_{n}\right\}$ such that

where $\beta_{2}^{m_{1}}=\prod_{i=1}^{m_{1}-1} \Phi_{g_{2}}\left(g_{1}, g_{1}^{i}\right)$. Let $H=G_{V_{1} \oplus V_{2}}$ and $\Psi=\Phi_{H}$. Since $H$ is direct sum of two cyclic groups, $\Psi$ must be an abelian 3-cocycle on $H$ by Lemma 2.5. This implies
 $W=\mathbb{k}\left\{X_{1}, X_{2}, X_{3}, Y_{1}, Y_{2}, Y_{3}\right\}$ be a submodule of $V_{1} \oplus V_{2} \in \underset{\mathbb{k} H}{\mathbb{k} H} \mathcal{Y} \mathcal{D}^{\Psi}$. We will consider the generalized Dynkin diagram $\mathcal{D}(W)$.
If $\beta_{1} \beta_{2} \neq\left(\frac{\widetilde{\Phi}_{g_{2}}\left(g_{1}, g_{3}\right)}{\widetilde{\Phi}_{g_{2}}\left(g_{3}, g_{1}\right)}\right)^{k}$ for $k \in\{0, \pm 1, \pm 2\}$, then the generalized Dynkin diagram $\mathcal{D}(W)$ (with unlabeled edges) associated to $B(W)$ is


By Propsition 2.11, $B(W)$ is twist equivalent to a Nichols algebra $B(U)$ in $\underset{\mathbb{k} \hat{H} \hat{H} \mathcal{V} \text {, }}{\substack{ \\\mathbb{H}}}$ and $B(U)$ has the same generalized Dynkin diagram with $B(W)$. Comparing the classification of generalized Dynkin diagrams of finite-dimensional Nichols algebras in [15], $B(U)$ and hence $B(W)$ must be infinite dimensional. This implies that $B\left(V_{1} \oplus V_{2}\right)$ is infinite dimensional.
If $\beta_{1} \beta_{2}=\left(\frac{\widetilde{\Phi}_{g_{2}}\left(g_{1}, g_{3}\right)}{\widetilde{\Phi}_{g_{2}}\left(g_{3}, g_{1}\right)}\right)^{k}$ for some $k \in\{0, \pm 1, \pm 2\}$, then the generalized Dynkin diagram $\mathcal{D}(W)$ (with unlabeled edges) has a subdiagram of the form


Comparing the classification result in [15], again we have $B(W)$ is infinite dimensional, and hence $B\left(V_{1} \otimes V_{2}\right)$ is infinite dimensional.
In either case $B\left(V_{1} \oplus V_{2}\right)$ is infinite dimensional, hence so is $B(V)$ since $B\left(V_{1} \oplus V_{2}\right)$ is a subalgebra of $B(V)$.
Proposition 3.8. Let $V=V_{1} \oplus V_{2} \oplus V_{3} \in \underset{\mathbb{k} G}{\mathbb{K} G \mathcal{Y} \mathcal{D}^{\Phi} \text { be a direct sum of simple twisted }}$ Yetter-Drinfeld modules and $G=G_{V}$. Assume that $\operatorname{dim}\left(V_{1}\right)=\operatorname{dim}\left(V_{2}\right)=\operatorname{dim}\left(V_{3}\right)=$ 2, and at least one of $V_{i}$ 's is of type (II). Then $B(V)$ is infinite dimensional.

Proof. Without loss of generality, we can assume that $V_{1}$ is a simple twisted YetterDrinfeld module of type (II). In what follows we will prove that $B\left(V_{1} \oplus V_{2}\right)$ (similarly for $B\left(V_{1} \oplus V_{3}\right)$ ) is infinite dimensional, which forces $B(V)$ is infinite dimensional.

Let $g_{i}=\operatorname{deg}\left(V_{i}\right)$ and $m_{i}=\left|g_{i}\right|$ for $1 \leq i \leq 3, H:=G_{V_{1} \oplus V_{2}}=\left\langle g_{1}, g_{2}\right\rangle$ and $\Psi=\left.\Phi\right|_{H}$. Then $\Psi$ is an abelian 3-cocycle on $H$ by Lemma 2.5, and hence $B\left(V_{1} \oplus V_{2}\right)$ is a Nichols
algebra of diagonal type in $\frac{\mathbb{k} H}{\mathbb{k} H} \mathcal{Y D}^{\Psi}$. By Lemma 3.5, $V_{1}$ has a basis $\left\{X_{1}, X_{2}\right\}$ such that

Here $\beta_{1}$ is a root of unit satisfying $\beta_{1}^{m_{2}}=\prod_{i=1}^{m_{2}-1} \Phi_{g_{1}}\left(g_{2}, g_{2}^{i}\right)$. In the following, we need to consider two cases: (a) $V_{2}$ has type (I), (b) $V_{2}$ has type (II).
(a). Since $\operatorname{dim}\left(V_{2}\right)=2$, by Lemma 3.5, $V_{2}$ has a basis $\left\{Y_{1}, Y_{2}\right\}$ such that

If $\beta_{1} \beta_{2}= \pm 1$, the generalized Dynkin diagram of $\mathcal{D}\left(V_{1} \oplus V_{2}\right)$ is


By Propsition 2.11, $B\left(V_{1} \oplus V_{2}\right)$ is twist equivalent to some Nichols algebra $B(U)$ in ${ }_{k}^{k} \hat{H} \mathcal{H} \mathcal{D}$, and $B(U)$ have the same generalized Dynkin diagram with $B\left(V_{1} \oplus V_{2}\right)$. By ${ }^{\mathrm{k} \hat{K}}$ checking up the classification of generalized Dynkin diagrams of finite-dimensional Nichols algebras of diagonal type in [15], we can see that $B(U)$ and hence $B\left(V_{1} \oplus V_{2}\right)$ is infinite dimensional.
(b). By Lemma 3.5, $V_{2}$ has a basis $\left\{Y_{1}, Y_{2}\right\}$ such that

Here $\beta_{2}^{m_{1}}=\prod_{i=1}^{m_{1}-1} \Phi_{g_{2}}\left(g_{1}, g_{1}^{i}\right)$ and $k \in\{1,2\}$ is a fixed number. If $\beta_{1} \beta_{2} \neq \pm 1$, then the generalized Dynkin diagram $\mathcal{D}\left(V_{1} \oplus V_{2}\right)$ (with unlabeled edges) of $B\left(V_{1} \oplus V_{2}\right)$ is


If $\beta_{1} \beta_{2}= \pm 1$, then the generalized Dynkin diagram $\mathcal{D}\left(V_{1} \oplus V_{2}\right)$ (with unlabeled edges) of $B\left(V_{1} \oplus V_{2}\right)$ is


In both cases $B\left(V_{1} \oplus V_{2}\right)$ is infinite dimensional by the classification of generalized Dynkin diagrams of finite-dimensional Nichols algebras of diagonal type in [15].

It remains to consider $B\left(V_{1} \oplus V_{2} \oplus V_{3}\right)$ where $V_{1}, V_{2}, V_{3}$ are simple twisted YetterDrinfeld modules of type (I) and $\operatorname{dim}\left(V_{i}\right)=2,1 \leq i \leq 3$. We have the following theorem.

Theorem 3.9. Let $V_{1}, V_{2}, V_{3} \in \underset{\mathbb{k} G}{\mathbb{k} G} \mathcal{Y D}^{\Phi}$ be simple Yetter-Drinfeld modules of type (I) such that $\operatorname{dim}\left(V_{i}\right)=2, \operatorname{deg}\left(V_{i}\right)=g_{i}, 1 \leq i \leq 3$ and $\left.G=\left\langle g_{1}\right\rangle \times\left\langle g_{2}\right\rangle \times g_{3}\right\rangle$. Then the Nichols algebra $B\left(V_{1} \oplus V_{2} \oplus V_{3}\right)$ is infinite dimensional.

The proof of the theorem is quite technical and lengthy. To avoid digressing from the present main theme, we postpone the proof to the next section. With the help of this theorem, we can prove the following proposition.
 Drinfeld modules and $G=G_{V}$. If $\operatorname{dim}\left(V_{1}\right)=\operatorname{dim}\left(V_{2}\right)=\operatorname{dim}\left(V_{3}\right)=2$ and $V_{1}, V_{2}, V_{3}$ are all simple Yetter-Drinfeld modules of type $(I)$, then $B(V)$ is infinite dimensional.

Proof. Let $g_{i}=\operatorname{deg}\left(V_{i}\right)$ and $m_{i}=\left|g_{i}\right|$ for $i=1,2,3$. Let $\mathbb{G}=\left\langle\mathfrak{g}_{1}\right\rangle \times\left\langle\mathrm{g}_{2}\right\rangle \times\left\langle\mathrm{g}_{3}\right\rangle$ be the abelian group with free generators $g_{1}, g_{2}, g_{3}$ such that $\left|g_{i}\right|=m_{i}$ for $1 \leq i \leq 3$. Then it is obvious that there is a group epimorphism $\pi: \mathbb{G} \longrightarrow G$ such that $\pi\left(\mathrm{g}_{i}\right)=g_{i}$, $1 \leq i \leq 3$. Let $\iota: G \longrightarrow \mathbb{G}$ be a section of $\pi\left(\right.$ that is $\left.\pi \circ \iota=\mathrm{id}_{G}\right)$ such that $\iota\left(\mathbb{g}_{i}\right)=g_{i}$
 module associated to $V_{i}$ define by (2.16)-(2.17). Let $\widetilde{V}=\widetilde{V_{1}} \oplus \widetilde{V_{2}} \oplus \widetilde{V_{3}}$. By Lemma
2.8, we have $B(V) \cong B(\widetilde{V})$. On the other hand, by Theorem $3.9, B(\widetilde{V})$ is infinite dimensional, thus $B(V)$ is also infinite dimensional.

Combining Proposition 3.7, 3.8 and 3.10 , the following theorem is clear.
 $G_{V}=G$. Then $B(V)$ is infinite dimensional.

Corollary 3.12. Let $B(V) \in \underset{\mathbb{K} G}{\mathbb{k} G} \mathcal{Y} \mathcal{D}^{\Phi}$ be a Nichols algebra of rank 3, and $\Phi_{G_{V}} a$ nonabelian 3-cocycle on $G_{V}$. Then $B(V)$ is infinite dimensional.

Proof. Let $H=G_{V}$ and $\Psi=\Phi_{H}$. Then the Nichols algebra $B(V)$ can be realized in $\mathbb{k}_{\mathbb{k} H} \mathcal{Y} \mathcal{D}^{\Psi}$, and the rank of $B(V)$ must be greater than or equal to 3 . For each $i \in\{1,2,3\}$, let $U_{i}$ be a nonzero simple Yetter-Drinfeld submodule of $V_{i}$ and $U=$ $U_{1} \oplus U_{2} \oplus U_{3}$. It is clear $H=G_{U}$. By Lemma 2.10, $U$ is nondiagonal since $\Psi$ is nonabelian on $H=G_{U}$, thus $U_{1}, U_{2}, U_{3}$ are all nondiagonal in $\underset{\mathbb{k} H}{\mathbb{k} H} \mathcal{Y} \mathcal{D}^{\Psi}$. Now $B(U)$ is infinite dimensional by Theorem 3.11, and so is $B(V)$ since $B(U) \subset B(V)$.
3.2. The general case. In this subsection, we will give a classification of finitedimensional Nichols algebras in $\mathbb{1}_{\mathbb{k} G}^{\mathbb{k} G} \mathcal{Y} \mathcal{D}^{\Phi}$, where $G$ is a finite abelian group and $\Phi$ is a 3 -cocycle on $G$. Firstly, we have the following theorem.
 infinite dimensional.

Proof. By Lemma 2.7, $B(V)$ can be realized in ${ }_{\mathbb{k} G_{V}}^{\mathbb{k} G_{V}} \mathcal{Y} \mathcal{D}^{\left.\Phi\right|_{G_{V}}}$. Since each 3-cocycle of cyclic group or direct sum of two cyclic groups is abelian, so the rank of $B(V)$ must be greater than or equal to 3 because $\left.\Phi\right|_{G_{V}}$ is nonabelian. Thus $B(V)$ is infinite dimensional by Corollary 3.12.

Remark 3.14. Since the conditions " $\left.\Phi\right|_{G_{V}}$ is abelian" and " $B(V)$ has a standard basis" are equivalent by Lemma 2.10, Theorem 3.13 is equivalent to Theorem 3.1.

We draw the following immediate consequences.
Corollary 3.15. Suppose $B(V) \in \underset{\mathbb{k} G}{\mathbb{k} G} \mathcal{Y D}^{\Phi}$ is a finite-dimensional Nichols algebra and $G=G_{V}$. Then $B(V)$ must be of diagonal type.
 Then we have
(1). $\left.\Phi\right|_{G_{V}}$ is abelian and $V$ has a standard basis;
(2). $B(V)$ is isomorphic to a Nichols algebra of diagonal type in $\underset{\mathbb{k} G_{V}}{\mathbb{k} G_{V}} \mathcal{Y} \mathcal{D}^{\Phi_{G_{V}}}$.

Proof. (1) follows from Theorem 3.13, and (2) follows from Proposition 3.10.
3.3. Classification. Next we will present a classification of finite-dimensional Nichols algebras in ${ }_{k G}^{k G} \mathcal{Y D}^{\Phi}$. Let $\Delta_{\chi, E}$ be an arithmetic root system, where $E=\left\{e_{1}, \cdots, e_{n}\right\}$ is a set of free generator of $\mathbb{Z}^{n}$ and $\chi$ is a bicharacter of $\mathbb{Z}^{n}$. For each positive root $\alpha \in \Delta_{\chi, E}$, define $q_{\alpha}=\chi(\alpha, \alpha)$. Then the height of $\alpha$ is defined by

\operatorname{ht}(\alpha)= \begin{cases}\left|q_{\alpha}\right|, & \text { if } q_{\alpha} \neq 1 \text { is a root of unity; }  \tag{3.27}\\ \infty, & \text { otherwise }\end{cases}
$$

Let $V \in{ }_{k G G}^{\mathbb{K} G} \mathcal{Y D}^{\Phi}$ be a Yetter-Drinfeld module with a standard basis $\left\{Y_{1}, \cdots, Y_{n}\right\}$, $\operatorname{deg}\left(Y_{i}\right)=g_{i}, 1 \leq i \leq n$. Then there is a pair $(\chi, E)$ associated to $V$, where $E=$ $\left\{e_{1}, \cdots, e_{n}\right\}$ is a set of free generator of $\mathbb{Z}^{n}$ and $\chi$ is a bicharacter of $\mathbb{Z}^{n}$ given by

g_{i} \triangleright Y_{j}=\chi\left(e_{i}, e_{j}\right) Y_{j}, 1 \leq i, j \leq n . \tag{3.28}
\end{equation*}

Remark 3.17. If $V$ has another standard basis $\left\{Y_{1}^{\prime}, \cdots, Y_{n}^{\prime}\right\}$, and a pair ( $\chi^{\prime}, E^{\prime}$ ) associated to $V$ with respect to the basis $\left\{Y_{1}^{\prime}, \cdots, Y_{n}^{\prime}\right\}$. Then there is an isomorphism $\tau: \mathbb{Z}^{n} \rightarrow \mathbb{Z}^{n}$ such that

\tau(E)=E^{\prime}, \quad \chi^{\prime}\left(\tau\left(e_{i}\right), \tau\left(e_{j}\right)\right)=\chi\left(e_{i}, e_{j}\right)

for all $1 \leq i, j \leq n$.
Definition 3.18. A Yetter-Drinfeld module $V \in{ }_{k G}^{k G} \mathcal{Y D}^{\Phi}$ is said to be of finite type if
(1) $V$ has a standard basis;
(2) $\Delta_{\chi, E}$ is an arithmetic root system and $\mathrm{ht}(\alpha)<\infty$ for all $\alpha \in \Delta_{\chi, E}$, where $(\chi, E)$ is a pair associated to $V$.

Theorem 3.19. Let $V \in{ }_{k G}^{\mathbb{k} G} \mathcal{Y D}^{\Phi}$ be a Yetter-Drinfeld module. Then $B(V)$ is finite dimensional if and only if $V$ is of finite type.

Proof. Firstly, suppose that $B(V)$ is finite dimensional. By Corollary 3.16, $\left.\Phi\right|_{G_{V}}$ is an abelian 3 -cocycle on $G_{V}$, thus $V$ has a standard basis. Let $H=G_{V}, \Psi=\left.\Phi\right|_{G_{V}}$, and $(\chi, E)$ a pair associated to $V$. By Proposition 2.11, $B(V)$ is isomorphic to a
 based groups and twisting, which do not change the pair $(\chi, E)$ associted to $V$, thus $(\chi, E)$ is also a pair associated to $U$. On the other hand, since $B(U) \in \frac{\mathbb{k} H}{\mathbb{k} H} \mathcal{Y} \mathcal{D}$ is finite dimensional, $\Delta_{\chi, E}$ is an arithmetic root system. Moreover, $B(U)$ is finite dimensional implies that the nilpotent index of a root vector of each root $\alpha \in \Delta_{\chi, E}$ is finite, i.e., $\operatorname{ht}(\alpha)<\infty$ for all $\alpha \in \Delta_{\chi, E}$.
Conversely, Suppose that $V$ is finite type. By Proposition 2.11, $B(V)$ is twist equiva-
 diagram with $B(V)$. So $\Delta_{\chi, E}$ is the arithmetic root system of $B(U)$. Furthermore, $B(U)$ is finite dimensional since $\operatorname{ht}(\alpha)<\infty$ for all $\alpha \in \Delta_{\chi, E}$. This implies $B(V)$ is infinite dimensional since $B(V)$ is twist equivalent to $B(U)$.

## 4. The proof of Theorem 3.9

The main task of this section is to prove Theorem 3.9. Firstly, we will consider a special case.
4.1. A special case. In this subsection, we will prove the following proposition.

Proposition 4.1. Suppose $G=\langle e\rangle \times\langle f\rangle \times\langle g\rangle$ is a finite abelian group, $\Phi$ is a 3 -cocycle on $G$ given by

\end{equation*}
$$

for all $0 \leq i_{1}, j_{1}, k_{1}<m_{1}, 0 \leq i_{2}, j_{2}, k_{2}<m_{1}, 0 \leq i_{3}, j_{3}, k_{3}<m_{3}$, where $m_{1}=$ $|e|, m_{2}=|f|, m_{3}=|g|$. Let $U, V, W \in{ }_{\mathbb{k} G}^{\mathbb{k} G} \mathcal{Y D}^{\Phi}$ be simple Yetter-Drinfeld modules of type (I) such that $\operatorname{deg}(U)=e, \operatorname{deg}(V)=g, \operatorname{deg}(W)=f$ and $\operatorname{dim}(U)=\operatorname{dim}(V)=$ $\operatorname{dim}(W)=2$. Then $B(U \oplus V \oplus W)$ is infinite dimensional.

In what follows, the Yetter-Drinfeld category ${ }_{k G}^{\mathbb{k} G} \mathcal{Y D}^{\Phi}$ and modules $U, V, W$ in it are assumed satisfying the conditions of this proposition.

Lemma 4.2. The simple module $U$ has a basis $\left\{X_{1}, X_{2}\right\}$ satisfying

Here $\beta_{1}, \gamma_{1} \in \mathbb{k}$ such that $\beta_{1}^{m_{2}}=1, \gamma_{1}^{m_{3}}=1$.
Proof. Since $U$ is of type (I) and $\operatorname{dim}(U)=2$, by Lemma 3.5, $U$ has a basis $\left\{X_{1}^{\prime}, X_{2}^{\prime}\right\}$ such that

Here $\beta_{1}^{m_{2}}=1, \gamma_{1}^{\prime \frac{m_{3}}{2}}=1$. Let $\gamma \in \mathbb{k}$ such that $\gamma_{1}^{2}=\gamma_{1}^{\prime}$. It is clear that $\gamma_{1}^{m_{3}}=1$. Let $X_{1}=X_{1}^{\prime}, \quad X_{2}=\frac{1}{\gamma_{1}} X_{2}^{\prime}$, we get (4.2)-(4.4).

Similar to Lemma 4.2, we have the following two lemmas.
Lemma 4.3. The simple module $V$ has a basis $\left\{Y_{1}, Y_{2}\right\}$ satisfying

Here $\beta_{2}, \gamma_{2} \in \mathbb{k}$ are numbers such that $\beta_{2}^{m_{3}}=1, \gamma_{2}^{m_{1}}=1$.

Lemma 4.4. The simple module $W$ has a basis $\left\{Z_{1}, Z_{2}\right\}$ such that

& f \triangleright Z_{1}=\beta_{3} Z_{1}, f \triangleright Z_{2}=-\beta_{3} Z_{2},  \tag{4.9}\\
& e \triangleright Z_{1}=\gamma_{3} Z_{2}, e \triangleright Z_{2}=\gamma_{3} Z_{1}, \tag{4.10}
\end{align*}
$$

where $\beta_{3}, \gamma_{3} \in \mathbb{k}$ are numbers $\beta_{3}^{m_{2}}=1, \gamma_{3}^{m_{1}}=1$.
In the following, $\left(\beta_{i}, \gamma_{i}\right), i=1,2,3$ will be called structure constants of $U, V, W$ respectively. It is clear that the structure constants depend on the choice of the bases of $U, V, W$.

Remark 4.5. The structure constants $\left(\beta_{i}, \gamma_{i}\right), i=1,2,3$ can be changed to be $\left(-\beta_{i}, \gamma_{i}\right)$, $\left(\beta_{i},-\gamma_{i}\right)$ and $\left(-\beta_{i},-\gamma_{i}\right)$ if we transform the bases of $U, V$ and $W$ respectively. For example, let $\bar{X}_{1}=X_{2}, \bar{X}_{2}=X_{1}$, the constants will changed to be $\left(-\beta_{1}, \gamma_{1}\right)$. Let $\bar{X}_{1}=X_{1}, \bar{X}_{2}=-X_{2}$, the constants will be $\left(\beta_{1},-\gamma_{1}\right)$. Let $\bar{X}_{1}=X_{2}, \bar{X}_{2}=-X_{1}$, the constants will changed to be $\left(-\beta_{1},-\gamma_{1}\right)$.

Proposition 4.6. Keep the previous notations, we have
(1). If $\beta_{2} \beta_{3} \neq \pm 1$, then $B(V \oplus W)$ is infinite dimensional.
(2). If $\beta_{1} \gamma_{2} \neq \pm 1$, then $B(U \oplus V)$ is infinite dimensional.
(3). If $\gamma_{1} \gamma_{3} \neq \pm 1$, then $B(U \oplus W)$ is infinite dimensional.

Proof. (1). Let $H=\langle f\rangle \times\langle g\rangle$ and $\Psi=\left.\Phi\right|_{H}$. Then it is obvious that $\Psi=1$ and $B(V \oplus W) \in \mathbb{k} H \mathcal{K} \mathcal{Y} \mathcal{D}$ is a Nichols algebra of diagonal type. The generalized Dynkin diagram $\mathcal{D}(V \oplus W)$ is


Comparing the classification result of finite-dimensional Nichols algebras in $\frac{\mathbb{k} H}{k} H \mathcal{Y} \mathcal{D}$, we obtain that $B(V \oplus W)$ is infinite dimensional.
(2). Let $\bar{Y}_{1}=Y_{1}+Y_{2}, \bar{Y}_{2}=Y_{1}-Y_{2}$. Then it is clear that $\left\{\bar{Y}_{1}, \bar{Y}_{2}\right\}$ is a basis of $V$ which satisfies

& f \triangleright \bar{Y}_{i}=-\bar{Y}_{i}, i=1,2, \\
& e \triangleright \bar{Y}_{1}=\gamma_{2} \bar{Y}_{1}, e \triangleright \bar{Y}_{2}=-\gamma_{2} \bar{Y}_{2}, \\
& g \triangleright \bar{Y}_{1}=\beta_{2} \bar{Y}_{2}, g \triangleright \bar{Y}_{2}=\beta_{2} \bar{Y}_{1} .
\end{aligned}

The rest of the proof is similar to (1).
(3). Let $\bar{X}_{1}=X_{1}+X_{2}, \bar{X}_{2}=X_{1}-X_{2}$. Then it is clear that $\left\{\bar{X}_{1}, \bar{X}_{2}\right\}$ is a basis of $U$ which satisfies

& f \triangleright \bar{X}_{1}=\beta_{1} \bar{X}_{2}, f \triangleright \bar{X}_{2}=\beta_{1} \bar{X}_{1} .
\end{aligned}

Similarly, let $\bar{Z}_{1}=Z_{1}+Z_{2}, \bar{Z}_{2}=Z_{1}-Z_{2}$. Then $\left\{\bar{Z}_{1}, \bar{Z}_{2}\right\}$ is a basis of $W$ and we have

& f \triangleright \bar{Z}_{1}=\beta_{3} \bar{Z}_{2}, e \triangleright \bar{Z}_{2}=-\beta_{3} \bar{Z}_{1} .
\end{aligned}

The same as (1), if $\gamma_{1} \gamma_{3} \neq \pm 1$, then $B(U \oplus W)$ is infinite dimensional.
If the structure constants of $U, V, W$ satisfy $\beta_{2} \beta_{3}= \pm 1, \beta_{1} \gamma_{2}= \pm 1$ and $\gamma_{1} \gamma_{3}= \pm 1$, then one can show that $B(U \oplus V), B(U \oplus W), B(V \oplus W)$ are all finite dimensional, the proof is the same as that of [20, Proposition 5.1]. In what follows, we will prove that $B(U \oplus V \oplus W)$ is infinite dimensional. For $\mathbb{Z}^{3}$-graded homogenous elements $X, Y \in B(U \oplus V \oplus W)$, we denote $\operatorname{deg}(X \otimes Y)=(\operatorname{deg}(X), \operatorname{deg}(Y))$.
Proposition 4.7. Suppose $\beta_{2} \beta_{3}= \pm 1, \beta_{1} \gamma_{2}= \pm 1$ and $\gamma_{1} \gamma_{3}= \pm 1$, then $B(U \oplus V \oplus W)$ is infinite dimensional.

Proof. Let $T(U \oplus V \oplus W)$ be the tensor algebra of $U \oplus V \oplus W, \mathcal{I}$ the maximal $\mathbb{N}$-graded Hopf ideal contained in $\bigoplus_{n \geq 2}(U \oplus V \oplus W)^{\otimes \vec{n}}$. Thus $B(U \oplus V \oplus W)=$ $T(U \oplus V \oplus W) / \mathcal{I}$ by definition. According to Proposition 2.9, $B(U \oplus V \oplus W)$ is $\mathbb{Z}^{3}$-graded with $\operatorname{deg}(U)=e_{1}, \operatorname{deg}(V)=e_{2}, \operatorname{deg}(W)=e_{3}$, where $\left\{e_{1}, e_{2}, e_{3}\right\}$ are free generators of $\mathbb{Z}^{3}$. Next we will prove that $B(U \oplus V \oplus W)$ is infinite dimensional. Without loss of generality, we can assume that $\beta_{2} \beta_{3}=-1, \beta_{1} \gamma_{2}=-1$ and $\gamma_{1} \gamma_{3}=-1$ by Remark 4.5.
The remaining proof will be divided into four steps.
Step 1. We will consider the comultiplications of some elements in the spaces $\operatorname{ad}_{V}(W), \operatorname{ad}_{U}(V), \operatorname{ad}_{U}(W) \subset B(U \oplus V \oplus W)$. In $\operatorname{ad}_{V}(W)$ we have

& -\beta_{3}\left[1 \otimes Z_{1} Y_{1}+Z_{1} Y_{1} \otimes 1+\beta_{2} Y_{1} \otimes Z_{1}+Z_{1} \otimes Y_{1}\right] \\
= & 1 \otimes \operatorname{ad}_{Y_{1}}\left(Z_{1}\right)+\operatorname{ad}_{Y_{1}}\left(Z_{1}\right) \otimes 1+2 Y_{1} \otimes Z_{1} .

Firstly we have

By Lemma 3.5, $\operatorname{dim}\left(V_{1}\right)=\left|\frac{\widetilde{\Phi}_{g_{1}}\left(g_{2}, g_{3}\right)}{\tilde{\Phi}_{g_{1}}\left(g_{3}, g_{2}\right)}\right|$, the order of $\frac{\tilde{\Phi}_{g_{1}}\left(g_{2}, g_{3}\right)}{\tilde{\Phi}_{g_{1}}\left(g_{3}, g_{2}\right)}$. Since $\operatorname{dim}\left(V_{i}\right)=2$ for $1 \leq i \leq 3$, we have

$$
\begin{equation*}
\frac{\widetilde{\Phi}_{g_{1}}\left(g_{2}, g_{3}\right)}{\widetilde{\Phi}_{g_{1}}\left(g_{3}, g_{2}\right)}=-1 . \tag{4.41}
\end{equation*}
$$

By (4.39) and (4.41), we obtain

$$
\frac{\widetilde{\Phi}_{g_{1}}\left(g_{2}, g_{3}\right)}{\widetilde{\Phi}_{g_{1}}\left(g_{3}, g_{2}\right)}=\Phi\left(g_{1}, g_{2}, g_{3}\right)=\zeta_{\left(m_{1}, m_{2}, m_{3}\right)}^{c_{123}}=-1 .
$$

Proof of Theorem 3.9. Let $\Psi$ and $\Gamma$ be the 3 -cocycles of $G$ given by

$$
\begin{equation*}
\Psi\left(g_{1}^{i_{1}} g_{1}^{i_{2}} g_{1}^{i_{3}}, g_{1}^{j_{1}} g_{1}^{j_{2}} g_{1}^{j_{3}}, g_{1}^{k_{1}} g_{1}^{k_{2}} g_{1}^{k_{3}}\right)=(-1)^{i_{1} j_{2} k_{3}}, \tag{4.42}
\end{equation*}
$$

(4.43) $\Gamma\left(g_{1}^{i_{1}} g_{1}^{i_{2}} g_{1}^{i_{3}}, g_{1}^{j_{1}} g_{1}^{j_{2}} g_{1}^{j_{3}}, g_{1}^{k_{1}} g_{1}^{k_{2}} g_{1}^{k_{3}}\right)=\prod_{l=1}^{3} \zeta_{m_{l}}^{\left.c_{i l} i_{l} \frac{j_{l}+k_{l}}{m_{l}}\right]} \prod_{1 \leq s<t \leq 3} \zeta_{m_{t}}^{c_{s t i t}\left[\frac{j_{s}+k_{s}}{m_{s}}\right]}$.

By (4.39) and Lemma 4.8, we have $\Phi=\Gamma \times \Psi$. By (2.13), $\Gamma$ is an abelian 3-cocycle of $G$. Let $\widehat{G}=\left\langle\mathfrak{g}_{1}\right\rangle \times\left\langle g_{2}\right\rangle \times\left\langle g_{3}\right\rangle$ such that $\left|g_{i}\right|=m_{i}^{2}, 1 \leq i \leq 3$, and $\pi: \widehat{G} \longrightarrow G$ be the epimorphism determined by

$$
\begin{equation*}
\pi\left(\mathrm{g}_{i}\right)=g_{i}, 1 \leq i \leq 3 \tag{4.44}
\end{equation*}
$$

Let $\iota: G \longrightarrow \widehat{G}$ be the section of $\pi$ given by

$$
\begin{equation*}
\iota\left(g_{i}^{l}\right)=\mathrm{g}_{i}^{l}, \quad 0 \leq l<m_{i} \tag{4.45}
\end{equation*}
$$

Then we have an object $\widetilde{V}=\widetilde{V}_{1} \oplus \widetilde{V}_{2} \oplus \widetilde{V}_{3} \in \underset{\mathbb{k} \widehat{G}}{\mathbb{k} \widehat{G}} \mathcal{Y} \mathcal{D}^{\pi^{*} \Phi}$ defined by (2.16)-(2.17), and $B(\widetilde{V}) \cong B(V)$ by Lemma 2.8. By Proposition $2.6, \pi^{*} \Gamma$ is a 3 -coboundary of $\widehat{G}$. Let $J$ be the 2-cochain of $\widehat{G}$ such that $\partial J=\pi^{*} \Gamma$. So we have

$$
\partial\left(J^{-1}\right) \cdot \pi^{*} \Phi=\left(\pi^{*} \Gamma\right)^{-1} \cdot \pi^{*}(\Psi \Gamma)=\pi^{*} \Psi
$$

By lemma 2.4, we have

Note that $\operatorname{deg}\left(\widetilde{V}_{i}^{J^{-1}}\right)=\operatorname{deg}\left(\widetilde{V}_{i}\right)=\mathrm{g}_{i}$ for $1 \leq i \leq 3$, and

$$
\begin{aligned}
& \pi^{*} \Psi\left(\mathrm{~g}_{1}^{i_{1}} \mathrm{~g}_{1}^{i_{2}} \mathrm{~g}_{1}^{i_{3}}, \mathrm{~g}_{1}^{j_{1}} \mathrm{~g}_{1}^{j_{2}} \mathrm{~g}_{1}^{j_{3}}, \mathrm{~g}_{1}^{k_{1}} \mathrm{~g}_{1}^{k_{2}} \mathrm{~g}_{1}^{k_{3}}\right) \\
& =\Psi\left(\pi\left(\mathrm{g}_{1}^{i_{1}} \mathrm{~g}_{1}^{i_{2}} \mathrm{~g}_{1}^{i_{3}}\right), \pi\left(\mathrm{g}_{1}^{j_{1}} \mathrm{~g}_{1}^{j_{2}} \mathrm{~g}_{1}^{j_{3}}\right), \pi\left(\mathrm{g}_{1}^{k_{1}} \mathrm{~g}_{1}^{k_{2}} \mathrm{~g}_{1}^{k_{3}}\right)\right) \\
& =\Psi\left(g_{1}^{i_{1}} g_{1}^{i_{2}} g_{1}^{i_{3}}, g_{1}^{j_{1}} g_{1}^{j_{2}} g_{1}^{j_{3}}, g_{1}^{k_{1}} g_{1}^{k_{2}} g_{1}^{k_{3}}\right) \\
& =(-1)^{k_{1} j_{2} i_{3}}
\end{aligned}
$$

for all $0 \leq i_{l}, j_{l}, k_{l}<m_{l}^{2}, 1 \leq l \leq 3$. By Proposition 4.1, $B(\widetilde{V})^{J^{-1}}$ is infinite dimensional. So $B(\widetilde{V})$ and $B(V)$ are also infinite dimensional.

## 5. Finite quasi-quantum groups over abelian groups

In this section, we will give a classification of finite-dimensional coradically graded pointed coquasi-Hopf algebras over finite abelian groups.
Let $M=\oplus_{i \geq 0} M_{i}$ be a coradically graded pointed coquasi-Hopf algebra over a finite abelian group $G$. Then $M_{0}=(\mathbb{k} G, \Phi)$ for a 3-cocycle $\Phi$ on $G$. Let $R=\oplus_{i \geq 0} R[i]$ be the coinvariant subalgebra of $M$. With these notations, we have

Theorem 5.1. Assume that $M$ is finite dimensional. Then coinvariant subalgebra $R$ of $M$ is a Nichols algebra in $\underset{\mathbb{k} G}{\mathbb{k} G} \mathcal{Y D}^{\Phi}$.

Proof. First we have $G_{R[1]}=G_{R}$ for $R$ is coradically graded. Since $R$ is finite dimensional, we have $B(R[1])$ is also finite dimensional since $B(R[1])$ is a subquotient of $R$. This implies that $\Phi_{G_{R[1]}}$ is an abelian 3-cocycle on $G_{R[1]}$ by Corollary 3.16. So we have $R \cong B(R[1])$ by [18, Proposition 5.1].

Now we can give a classification of finite-dimensional coradically graded pointed coquasi-Hopf algebras over finite abelian groups.

Theorem 5.2. (1). Let $V \in \underset{\mathbb{k} G}{\mathbb{k} G} \mathcal{Y}^{\Phi}$ be a Yetter-Drinfeld module of finite type. Then $B(V) \# \mathbb{k} G$ is a finite-dimensional pointed coquasi-Hopf algebra.
(2). Let $M$ be a finite-dimensional coradically graded pointed coquasi-Hopf algebra over a finite abelian group, $M_{0}=(G, \Phi)$. Then we have $M \cong B(V) \# \mathbb{k} G$ for a Yetter-Drinfeld module of finite type $V \in \underset{\mathbb{k} G}{\mathbb{k} G} \mathcal{Y}^{\Phi}$.

Proof. (1). It follows from Theorem 3.19 that $B(V)$ is finite dimensional, thus $B(V) \neq \mathbb{k} G$ is finite dimensional.
(2). Let $R$ be the coinvariant subalgebra of $M$. Then $M=R \# \mathbb{k} G$. Let $V=R[1]$.
 for the Yetter-Drinfeld module $V$, and $V$ is of finite type since $M$ and hence $B(V)$ is finite dimensional.

Finally, we will consider the generation problem of pointed finite tensor categories. We partially prove the following conjecture due to Etingof, Gelaki, Nikshych and Ostrik.

Conjeture 5.3. Every pointed finite tensor categories over a field of characteristic zero is tensor generated by objects of length two.

In fact, this conjecture can be viewed as a generalization of Andruskiewitsch-Schneider conjecture. Let $\mathcal{C}$ be a pointed finite tensor categories. Then it is well known that $\mathcal{C} \cong \operatorname{comod}(M)$ for a finite-dimensional pointed coquasi-Hopf algebra $M$, see [12] for details. In [20], we prove the following proposition.
Proposition 5.4. [20, Proposition 4.10] Let $\mathcal{C}$ be a pointed finite tensor category, and $M$ a finite-dimensional pointed coquasi-Hopf algebra such that $\mathcal{C} \cong \operatorname{comod}(M)$. Then $\mathcal{C}$ is tensor generated by objects of length two if and only if $M$ is generated by group-like elements and skew-primitive elements.

With the help of Theorem 5.2 and Proposition 5.4, we can prove the following theorem.
Theorem 5.5. Let $\mathcal{C}$ be a pointed finite tensor category over a field of characteristic zero such that $G(\mathcal{C})$ is an abelian group. Then $\mathcal{C}$ is tensor generated by objects of length two.

Proof. Let $M$ be a finite-dimensional pointed coquasi-Hopf algebra such that $\mathcal{C} \cong$ $\operatorname{comod}(M)$. By Proposition 5.4, we only need to show that $M$ is generated by grouplike elements and skew-primitive elements. Let $k$ be the based field of $M, K$ the algebraically closure of $k$. Let $\widetilde{M}=M \otimes_{k} K$. Then $\widetilde{M}$ is also a pointed coquasiHopf algebra with the structure induced from that of $M$, and it is obvious that $M$ is generated by group-like elements and skew-primitive elements if and only if $\widetilde{M}$ is generated by group-like elements and skew-primitive elements. On the other hand, we have $\operatorname{gr}(\widetilde{M}) \cong B(V) \# \mathbb{k} G$ by Theorem 5.2 , where $G=G(\mathcal{C})$ and $V$ is a Yetter-
 and hence $\widetilde{M}$ are generated by group-like elements $G$ and skew-primitive elements $V$. Therefore $M$ is generated by group-like elements and skew-primitive elements.
