LIFTINGS OF POINT-WISE FINITE DIMENSIONAL PERSISTENCE MODULES OVER LOCAL COMMUTATIVE ARTINIAN RINGS

ABSTRACT. Let k be a field and let $V : \mathscr{C} \to k$ -Mod be a pointwise finite dimensional persistence module, where \mathscr{C} is a small category. Assume that for all local Artinian k-algebras R with residue field isomorphic to k, there is a generalized persistence module $M : \mathscr{C} \to R$ -Mod, such that for all $x \in Ob(\mathscr{C})$, M(x) is free over R with finite rank and $k \otimes_R M(x) \cong V(x)$. If V is a direct sum of indecomposable persistence modules $V_I : \mathscr{C} \to k$ -Mod with endomorphism ring isomorphic to k, then M is a direct sum of indecomposables $M_I : \mathscr{C} \to R$ -Mod with endomorphism ring isomorphic to R.

1. INTRODUCTION

In this article, we assume that k is a field of arbitrary characteristic and denote by \mathcal{A}_{k} the category of local commutative Artinian k-algebras with residue field isomorphic to k. In particular, the morphisms in \mathcal{A}_{\Bbbk} induce the identity on \Bbbk . For all objects R in \mathcal{A}_{\Bbbk} , we denote by R-Mod the category of R-modules. In particular, k-Mod is just the category of k-vector spaces. Let \mathscr{C} be a small category and let $V: \mathscr{C} \to \Bbbk$ -Mod be a persistence module indexed by \mathscr{C} , i.e., V is a functor from \mathscr{C} to k-Mod. Recall that V is said to be pointwise finite dimensional if for all objects $x \in Ob(\mathscr{C})$, V(x) has finite dimension over k. It follows from a result due to M. B. Botman and W. Crawley-Boevey (see [2, Thm. 1.1]) that if V is pointwise finite dimensional then V is a direct sum of indecomposable modules with local endomorphism ring. This result improved that due to Crawley-Boevey (see [4, Thm. 1.1]) which states that every pointwise persistence module over a totally ordered indexing set $(\mathcal{R}, <)$ (with \mathcal{R} having a countable subset which is dense in the order topology on \mathscr{R}) is a direct sum of indecomposable persistence modules each having an endomorphism ring isomorphic to k. They also prove in [2, Thm. 1.3] that every pointwise finite dimensional middle exact module over a product of two totally ordered sets (as defined in [3, §2] decomposes into a direct sum of block modules (as defined in $[3, \S2]$), which provides an alternative proof to [3, Thm. 2.1]. It is noted in the Proof Outline section in [3] that these block modules have endomorphism ring isomorphic to k. These observations provide non-trivial examples of pointwise finite dimensional persistence modules that decompose as a direct sum of indecomposable persistence modules with endomorphism ring isomorphic to k.

Let R be a fixed object in \mathcal{A}_{\Bbbk} . An R-generalized persistence module indexed by \mathscr{C} is just a functor $M : \mathscr{C} \to R$ -Mod. Let V be a pointwise finite dimensional persistence module. We say that (M, ϕ) is a lift of V over R is a R-generalized persistence module M such that for all objects $x \in Ob(\mathscr{C})$, M(x) is free of finite rank over R, together with a natural equivalence $\phi : (\Bbbk \otimes_R -) \circ M \to V$, where $\Bbbk \otimes_R - : R$ -Mod $\to \Bbbk$ -Mod is the natural projection functor. We say that two lifts (M, ϕ) and (M', ϕ') of V over R are isomorphic if there is a natural equivalence $f : M \to M'$ such that the induced natural equivalence $\mathrm{id}_{\Bbbk} \otimes f : (\Bbbk \otimes_R -) \circ M \to (\Bbbk \otimes_R -) \circ M'$ satisfies that $\phi' \circ (\mathrm{id}_{\Bbbk} \otimes f) = \phi$. Our goal is to give a short proof of the following result.

Theorem 1.1. Let V a pointwise finite dimensional persistence module such that V is the direct sum of indecomposable persistence modules with endomorphism ring isomorphic to \Bbbk . Then for all objects R in \mathcal{A}_{\Bbbk} and all lifts (M, ϕ) of V over R, the R-generalized persistence module M is a direct sum of indecomposables R-generalized persistence modules with endomorphism ring isomorphic to R.

Remark 1.2. Observe that if V is a pointwise finite dimensional persistence module, then V has always a *trivial lift* which is defined by the composition of V with the functor $(R \otimes_{\Bbbk} -) : \Bbbk$ -Mod \rightarrow R-Mod. However,

if for example we let \mathscr{C} be the cycle quiver with relations (Q, ρ) , where

$$Q: \gamma \bigcap_{1} \bullet_{1} \text{ and } \rho = \{\gamma^{2}\},$$

then the simple persistence module S_1 corresponding to the unique vertex of Q fits in a short exact sequence of persistence modules

$$0 \to S_1 \xrightarrow{\iota} P_1 \xrightarrow{\pi} S_1 \to 0,$$

where P_1 is the projective cover of S_1 . It follows that P_1 defines a non-trivial lift of S_1 over the ring of dual numbers $\mathbb{k}[\epsilon]$, with $\epsilon^2 = 0$, by letting ϵ act on P_1 as $\iota \circ \pi$.

It is important to mention that generalized persistence modules over symmetric monoidal categories, which include categories of vector spaces, have been studied by A. Patel in [5].

2. Proof of Theorem 1.1

Let R be a fixed object in \mathcal{A}_{\Bbbk} . We denote by $\operatorname{Pers}_{R}^{\mathscr{C}}$ the abelian category if R-generalized persistence modules indexed by \mathscr{C} . Note that in particular $\operatorname{Pers}_{\Bbbk}^{\mathscr{C}}$ is just the the category of persistence modules $V : \mathscr{C} \to \Bbbk$ -Mod. If $\mathscr{C}(x, y)$ is a morphism between objects in \mathscr{C} , then for all R-generalized persistence modules M in $\operatorname{Pers}_{R}^{\mathscr{C}}$, we let $M(x, y) = M(\mathscr{C}(x, y))$. Note that every object V in $\operatorname{Pers}_{\Bbbk}^{\mathscr{C}}$ can be viewed as an object in $\operatorname{Pers}_{R}^{\mathscr{C}}$ by considering \Bbbk as an R-module. For all objects M and N in $\operatorname{Pers}_{R}^{\mathscr{C}}$, we denote by $\operatorname{Hom}_{R}^{\mathscr{C}}(M, N)$ the abelian group of morphisms (i.e. natural transformations) $f : M \to N$. Note that in particular that $\operatorname{Hom}_{R}^{\mathscr{C}}(M, N)$ is an R-module. We also let $\operatorname{End}_{R}^{\mathscr{C}}(M) = \operatorname{Hom}_{R}^{\mathscr{C}}(M, M)$ and denote by $\Bbbk \otimes_{R} M$ the composition of functors ($\Bbbk \otimes_{R} -) \circ M$. For all lifts (M, ϕ) of V over R, we denote by $\pi_{M} : M \to V$ the natural projection, i.e., for all $x \in \mathscr{C}$, $(\pi_{M})_{x} : M(x) \to V(x)$ is the natural projection between R-modules.

Lemma 2.1. Let V be a pointwise finite dimensional persistence module and let (M, ϕ) be a lift of V over R. Then there is an isomorphism of R-modules $\operatorname{Hom}_{\mathcal{B}}^{\mathscr{C}}(M, V) \cong \operatorname{Hom}_{\Bbbk}^{\mathscr{C}}(V, V)$.

Proof. Let $f \in \operatorname{Hom}_{\Bbbk}^{\mathscr{C}}(V, V)$ and let $x \in \operatorname{Ob}(\mathscr{C})$ be fixed but arbitrary. Since M(x) is free over R, it follows that there exists $g_x \in \operatorname{Hom}_R(M(x), V(x))$ such that $g_x = f_x \circ (\pi_M)_x$. It is straightforward to prove that for all morphisms $\mathscr{C}(x, y)$ in \mathscr{C} , $g_y \circ M(x, y) = V(x, y) \circ g_x$, and thus we have a morphism $g \in \operatorname{Hom}_R^{\mathscr{C}}(M, V)$. In this way, we obtain a morphism between R-modules $\Phi : \operatorname{Hom}_{\Bbbk}^{\mathscr{C}}(V, V) \to \operatorname{Hom}_R^{\mathscr{C}}(M, V)$, defined by $\Phi(f) = g$. Next let $g \in \operatorname{Hom}_R^{\mathscr{C}}(M, V)$. For all $x \in \operatorname{Ob}(\mathscr{C})$, let $f_x : V(x) \to V(x)$ be defined as $f_x(v) = g_x(v)$ for all $v \in V(x)$. Thus we obtain a morphism $f \in \operatorname{Hom}_{\Bbbk}^{\mathscr{C}}(V, V)$, and in this way we obtain a morphism between R-modules $\Psi : \operatorname{Hom}_R^{\mathscr{C}}(M, V) \to \operatorname{Hom}_{\Bbbk}^{\mathscr{C}}(V, V)$ defined as $\Psi(g) = f$. It is straightforward to prove that Φ and Ψ are inverses of each other and thus $\operatorname{Hom}_R^{\mathscr{C}}(M, V) \cong \operatorname{Hom}_{\Bbbk}^{\mathscr{C}}(V, V)$.

Lemma 2.2. Assume that $V : \mathscr{C} \to \Bbbk$ -Mod is a pointwise finite dimensional persistence module such that $\operatorname{End}_{\Bbbk}^{\mathscr{C}}(V) = \Bbbk$. Then for all objects R in \mathcal{A}_{\Bbbk} and all lifts (M, ϕ) of V over R, $\operatorname{End}_{R}^{\mathscr{C}}(M) = R$. In particular, M is an indecomposable R-generalized persistence module.

In order to prove Lemma 2.2, we need to recall the following definition from [6, Def. 1.2].

Definition 2.3. Let $\theta : R \to R_0$ be a morphism of Artinian objects in \mathcal{A}_k . We say that θ is a *small extension* if the kernel of θ is a non-zero principal ideal tR that is annihilated by the unique maximal ideal \mathfrak{m}_R of R.

Remark 2.4. (i) Let $\theta : R \to R_0$ be a small extension in \mathcal{A}_{\Bbbk} with $tR = \ker \theta$. Then it follows that $tR \cong \Bbbk$ as *R*-modules.

(ii) Let R be a fixed object in \mathcal{A}_{\Bbbk} with length $\ell(R) > 0$. Then there is a small extension $\theta : R \to R_0$. Indeed, let \mathfrak{m}_R the unique maximal ideal of R. Since R is Artinian, there exists $p \ge 1$ such that $\mathfrak{m}_R^p = 0$ and $\mathfrak{m}_R^{p-1} \ne 0$. Let $t \in \mathfrak{m}_R^{p-1}$ with $t \ne 0$. By letting $R_0 = R/tR$, we obtain that R_0 is in \mathcal{A}_{\Bbbk} and the natural projection $\theta : R \to R_0$ is a small extension. Therefore, we can use small extensions to prove results on the the objects R in \mathcal{A}_{\Bbbk} by using induction on the length of R. Proof of Lemma 2.2. In the following, we adapt the arguments in the proof of [1, Lemma 2.3] to our situation. Let $\theta: R \to R_0$ be a small extension in \mathcal{A}_{\Bbbk} with ker $\theta = tR$ and assume that for all lifts (M_0, ϕ_0) of V over R_0 , we have $\operatorname{End}_{R_0}^{\mathscr{C}}(M_0) = R_0$. Let $f \in \operatorname{End}_R^{\mathscr{C}}(M)$, and consider $f_0 = \operatorname{id}_{R_0} \otimes_{R,\theta} f \in \operatorname{End}_{R_0}^{\mathscr{C}}(R_0 \otimes_{R,\theta} M)$. Since $R_0 \otimes_{R,\theta} M$ defines a lift of V over R_0 , it follows by induction that there exists $r_0 \in R_0$ such that $f_0 = \mu_{r_0}$, where μ_{r_0} denotes multiplication by r_0 . Let $r \in R$ such that $\theta(r) = r_0$ and consider $g = f - \mu_r \in \operatorname{End}_R^{\mathscr{C}}(M)$. Then $\operatorname{id}_{R_0} \otimes_{R,\theta} g = 0$. This implies that $g \in \operatorname{Hom}_R^{\mathscr{C}}(M, tR \otimes_R M)$. Since $tR \cong \Bbbk$, it follows that $tR \otimes_R M \cong \Bbbk \otimes_R M \cong V$. By using Lemma 2.1, we have that $\operatorname{Hom}_R^{\mathscr{C}}(M, tR \otimes_R M) \cong \operatorname{End}_{\Bbbk}^{\mathscr{C}}(V)$. Since $\operatorname{End}_{\Bbbk}^{\mathscr{C}}(V) = \Bbbk$, there exists $\lambda \in R$ such that $g = \mu_{t\lambda}$. This implies that $f = \mu_{r+t\lambda}$ and thus every morphism in $\operatorname{End}_R^{\mathscr{C}}(M)$ is multiplication by an scalar in R and thus $\operatorname{End}_R^{\mathscr{C}}(M) = R$.

Proof of Theorem 1.1. Assume that there is an isomorphism $\overline{\varphi} : V \to \bigoplus_{I \in \mathscr{I}} V_I$, with $\operatorname{End}_{\Bbbk}^{\mathscr{C}}(V_I) = \Bbbk$ for all $I \in \mathscr{I}$. Let (M, ϕ) be a lift of V over R, and for all $I \in \mathscr{I}$ let (M_I, ϕ_I) be a lift of V_I over R. For each $x \in \operatorname{Ob}(\mathscr{C})$, there is a morphism $\overline{\varphi}_x : V(x) \to \bigoplus_{I \in \mathscr{I}} V_I(x)$, where $V_I(x) \neq 0$ for at most finitely many $I \in \mathscr{I}$. Since M(x) is free over R, there exists a morphism of R-modules $\varphi_x : M(x) \to$ $\bigoplus_{I \in \mathscr{I}} M_I(x)$ such that $\overline{\varphi}_x \circ (\pi_M)_x = (\bigoplus_{I \in \mathscr{I}} \pi_I(x)) \circ \varphi_x$. Let $\mathscr{C}(x, y)$ be a morphism in \mathscr{C} , and let $g_x = \varphi_y \circ M(x, y) - (\bigoplus_{I \in \mathscr{I}} M_I(x, y)) \circ \varphi_x$. Then $\operatorname{id}_{\Bbbk} \otimes_R g_x = \overline{\varphi}_y \circ V(x, y) - (\bigoplus_{I \in \mathscr{I}} V_I(x, y)) \circ \overline{\varphi}_x = 0$. This implies that $\operatorname{im} g_x = \mathfrak{m}_R \operatorname{im} g_x$. By Nakayama's Lemma, we have $\operatorname{im} g_x = 0$ or $g_x = 0$. Thus we obtain a morphism between R-generalized persistence modules $\varphi : M \to \bigoplus_{I \in \mathscr{I}} M_I$. Moreover, since for all $x \in \operatorname{Ob}(\mathscr{C}), \overline{\varphi}(x)$ is an isomorphism between R-generalized persistence modules. Moreover, by Lemma 2.2, for each $I \in \mathscr{I}$, $\operatorname{End}_R^{\mathscr{C}}(M) = R$. This finishes the proof of Theorem 1.1.
