A CONVERSE OF DYNAMICAL MORDELL–LANG CONJECTURE IN POSITIVE CHARACTERISTIC

Abstract. In this paper, we prove the converse of the dynamical Mordell–Lang conjecture in positive characteristic: For every subset $S \subseteq \mathbb{N}_0$ which is a union of finitely many arithmetic progressions along with finitely many p-sets of the form $\left\{\sum_{j=1}^m c_j p^{k_j n_j} : n_j \in \mathbb{N}_0\right\}$ $(c_j \in \mathbb{Q}, k_j \in \mathbb{N}_0)$, there exist a split torus $X = \mathbb{G}_m^k$ defined over $K = \overline{\mathbb{F}_p}(t)$, an endomorphism Φ of $X, \alpha \in X(K)$ and a closed subvariety $V \subseteq X$ such that $\{n \in \mathbb{N}_0 : \Phi^n(\alpha) \in V(K)\} = S.$

1. INTRODUCTION

Throughout the paper, let p be a prime, N be the set of positive integers and $\mathbb{N}_0 := \mathbb{N} \cup \{0\}$. An arithmetic progression in \mathbb{N}_0 is a set of the form $\{a + bt : t \in \mathbb{N}_0\}$ for some $a, b \in \mathbb{N}_0$. We use a convention that a variety may not be irreducible.

The *dynamical Mordell–Lang conjecture* predicts that for a quasi-projective variety X defined over a field K of characteristic 0, an endomorphism Φ of X, a point $\alpha \in X(K)$ and a closed subvariety $V \subseteq X$, the set of $n \in \mathbb{N}_0$ such that $\Phi^n(\alpha) \in V(K)$ is a finite union of arithmetic progressions in \mathbb{N}_0 . It is one of the central problems in arithmetic dynamics.

Conjecture 1.1. (Dynamical Mordell–Lang conjecture; [\[5,](#page-5-0) Conjecture 1.7]) Let X be a quasi-projective variety defined over a field K of characteristic 0, Φ be an endomorphism of X, $\alpha \in X(K)$ and $V \subseteq X$ be a closed subvariety. Then the set $\{n \in \mathbb{N}_0 : \Phi^n(\alpha) \in V(K)\}$ is a union of finitely many arithmetic progressions.

We remark that if Conjecture [1.1](#page-0-0) holds for $K = \mathbb{C}$, then it holds for every field K of characteristic 0 [\[2,](#page-5-1) Proposition 3.1.2.1]. There is extensive literature on various special cases of dynamical Mordell–Lang conjecture. We provide two significant examples.

Theorem 1.2. Conjecture [1.1](#page-0-0) is true for the following cases:

- (1) (Bell–Ghioca–Tucker [\[1,](#page-5-2) Theorem 1.3]) $\Phi: X \to X$ is an étale morphism over $\mathbb C$,
- (2) (Xie [\[8,](#page-5-3) Theorem 1], [\[9,](#page-5-4) Theorem 1.4]) $\Phi : \mathbb{A}^2 \to \mathbb{A}^2$ is a morphism over \mathbb{C} .

It is natural to ask whether Conjecture [1.1](#page-0-0) still holds when K has a positive characteristic. The following example says that the assumption that K has a characteristic 0 in Conjecture [1.1](#page-0-0) is essential.

Example 1.3. ([\[4,](#page-5-5) Example 1.2]) Let p be an odd prime, $X = \mathbb{G}_m^3$ be defined over $K = \mathbb{F}_p(t)$, $\Phi: X \to X$ be given by $\Phi(x, y, z) = (tx, (1 + t)y, (1 - t)z), \alpha = (1, 1, 1) \in X(K)$ and $V \subset \mathbb{G}_m^3$ be the hyperplane defined by the equation $y + z - 2x = 2$. Then $\{n \in \mathbb{N}_0 : \Phi^n(\alpha) \in V(K)\} = \{p^{n_1} + p^{n_2} : n_1, n_2 \in \mathbb{N}_0\}.$

Motivated by the work of Moosa and Scanlon [\[7,](#page-5-6) Theorem B], Ghioca and Scanlon proposed a version of dynamical Mordell–Lang conjecture in positive characteristic.

Conjecture 1.4. (Ghioca–Scanlon; [\[2,](#page-5-1) Conjecture 13.2.0.1]) Let K be a field of characteristic p, X be a quasi-projective variety defined over K, Φ be an endomorphism of $X, \alpha \in X(K)$ and $V \subseteq X$ be a closed subvariety. Then the set $\{n \in \mathbb{N}_0 : \Phi^n(\alpha) \in V(K)\}$ is a union of finitely many arithmetic progressions along with finitely many *p-sets* of the form

(1)
$$
\left\{\sum_{j=1}^{m} c_j p^{k_j n_j} : n_j \in \mathbb{N}_0 \text{ for each } 1 \leq j \leq m \right\} \subset \mathbb{N}_0
$$

for some $m \in \mathbb{N}, c_1, \ldots, c_m \in \mathbb{Q}$ and $k_1, \ldots, k_m \in \mathbb{N}_0$.

Conjecture [1.4](#page-0-1) has been studied by several authors [\[2,](#page-5-1) [4,](#page-5-5) [3,](#page-5-7) [10\]](#page-5-8). Notably, it has been proved in [\[3\]](#page-5-7) when $X = \mathbb{G}_m^N$ and $V \subset \mathbb{G}_m^N$ has dimension at most 2 [\[3,](#page-5-7) Theorem 1.2], or when $X = \mathbb{G}_m^N$ and $\Phi : \mathbb{G}_m^N \to \mathbb{G}_m^N$ is an algebraic group endomorphism such that no iterate of Φ induces a power of Frobenius on a nontrivial connected algebraic subgroup of \mathbb{G}_m^N [\[3,](#page-5-7) Theorem 1.3].

For a fixed field K of characteristic p, we say $S \subseteq \mathbb{N}_0$ is a K-DML set if there are X, V, Φ and α defined over K as in Conjecture [1.4](#page-0-1) such that $S = \{n \in \mathbb{N}_0 : \Phi^n(\alpha) \in V(K)\}\$. For a quasi-projective variety X defined over K, We say $S \subseteq \mathbb{N}_0$ is a K-DML set over X if there are V, Φ and α defined over K such that $S = \{n \in \mathbb{N}_0 : \Phi^n(\alpha) \in V(K)\}.$ We say $S \subseteq \mathbb{N}_0$ is a K-DML set over split torus if it is a K-DML set over \mathbb{G}_m^k for some $k \in \mathbb{N}$.

For $m \in \mathbb{N}, c_1, \ldots, c_m \in \mathbb{Q} \setminus \{0\}, k_1, \ldots, k_m \in \mathbb{N}_0$ and a prime power $q = p^k$, we denote

$$
B(q; c_1, \ldots, c_m; k_1, \ldots, k_m) := \left\{ \sum_{j=1}^m c_j q^{k_j n_j} : n_j \in \mathbb{N}_0 \text{ for each } 1 \le j \le m \right\}
$$

.

We say a subset $S \subseteq \mathbb{N}_0$ is a p-set if $S = B(p; c_1, \ldots, c_m; k_1, \ldots, k_m)$ for some $m \in \mathbb{N}, c_1, \ldots, c_m \in \mathbb{Q} \setminus \{0\}$ and $k_1, \ldots, k_m \in \mathbb{N}_0$. Note that since we have

$$
B(q; c_1, \ldots, c_m; k_1, \ldots, k_m) = B(p; c_1, \ldots, c_m; k k_1, \ldots, k k_m)
$$

for $q = p^k$, the set $B(q; c_1, \ldots, c_m; k_1, \ldots, k_m)$ is a p-set if it is a subset of \mathbb{N}_0 . Corvaja, Ghioca, Scanlon and Zannier [\[3\]](#page-5-7) proved that a p-set $B(q; c_1, \ldots, c_m; k_1, \ldots, k_m)$ is a $\mathbb{F}_q(t)$ -DML set over split torus when c_j are small positive integers and $k_j = 1$. (Take $u_n = n$ in [\[3,](#page-5-7) Theorem 1.4]). Note that [3, Theorem 1.4] is a direct consequence of [\[3,](#page-5-7) Proposition 4.2 and 4.3] so we can replace the field K with $\mathbb{F}_q(t)$.

Theorem 1.5. ([\[3,](#page-5-7) Theorem 1.4]) A p-set $B(q; c_1, \ldots, c_m; 1, \ldots, 1)$ is a $\mathbb{F}_q(t)$ -DML set over split torus if c_j are positive integers such that $\sum_{j=1}^{m} c_j < \frac{q}{2}$.

The goal of this paper is to prove the converse of the dynamical Mordell–Lang conjecture in positive characteristic, i.e., every union of finitely many arithmetic progressions in \mathbb{N}_0 along with finitely many p-sets is a K -DML set for some field K of characteristic p . Now we state the main theorem of the paper.

Theorem 1.6. Let S be a subset of \mathbb{N}_0 which is a union of finitely many arithmetic progressions along with finitely many p-sets. Then S is a $\overline{\mathbb{F}_p}(t)$ -DML set over split torus.

1.1. Organization. The paper is organized as follows. In Section [2,](#page-2-0) we reduce the proof of Theorem [1.6](#page-1-0) to a special form (Theorem [3.1\)](#page-3-0) using several lemmas. Section [3](#page-3-1) is devoted to the proof of the main theorem. We prove Theorem [3.1](#page-3-0) by dividing each p -set into smaller p -sets to which Theorem [1.5](#page-1-1) can be applied and using lemmas in Section [2.](#page-2-0)

2. Reduction of the main theorem

In this section, we provide a reduction of Theorem [1.6](#page-1-0) to a simpler problem. From now on, we assume that K is a field of characteristic p and $K \neq \mathbb{F}_2$.

Lemma 2.1. If S_i is a K-DML set over X_i for $1 \leq i \leq m$, then $\cup_{i=1}^m S_i$ and $\cap_{i=1}^m S_i$ are K-DML sets over $X_1 \times \cdots \times X_m$.

Proof. It is enough to prove the lemma for $m = 2$. Assume that $S_i = \{n \in \mathbb{N}_0 : \Phi_i^n(\alpha_i) \in V_i(K)\}$ $(V_i \subseteq X_i)$ is a K-DML set over X_i for $i \in \{1,2\}$. Then we have

$$
S_1 \cup S_2 = \{ n \in \mathbb{N}_0 : (\Phi_1, \Phi_2)^n (\alpha_1, \alpha_2) \in V(K) \}
$$

for $V = V_1 \times X_2 \cup X_1 \times V_2 \subseteq X_1 \times X_2$ (a variety is not assumed to be irreducible) and

$$
S_1 \cap S_2 = \{ n \in \mathbb{N}_0 : (\Phi_1, \Phi_2)^n (\alpha_1, \alpha_2) \in V(K) \}
$$

for $V = V_1 \times V_2 \subseteq X_1 \times X_2$. Thus $S_1 \cup S_2$ and $S_1 \cap S_2$ are K-DML sets over $X_1 \times X_2$.

Lemma 2.2. Every arithmetic progression in \mathbb{N}_0 is a K-DML set over split torus.

Proof. We prove that an arithmetic progression $T_{a,b} := \{a + bt : t \ge 0\}$ $(a, b \in \mathbb{N}_0)$ is a K-DML set over split torus. Since $K \neq \mathbb{F}_2$, there exists an element $c \in K \setminus \{0, 1\}.$

- (1) $b = 0$: Let $X = \mathbb{G}_m^{a+1}$, $\alpha = (1, c, \ldots, c)$, $V = \{(x_1, \ldots, x_{a+1}) \in X : x_{a+1} = 1\}$ and $\Phi : X \to X$ be given by $\Phi(x_1, ..., x_{a+1}) = (c, x_1, ..., x_a)$. Then we have $\{n \in \mathbb{N}_0 : \Phi^n(\alpha) \in V(K)\} = \{a\} = T_{a,0}$ so $T_{a,0}$ is a K-DML set over X.
- (2) $b > 0$: Since $T_{a,b} = T_{a,0} \cup T_{a+b,b}$, we may assume that $a > 0$ by Lemma [2.1.](#page-2-1) Let $X = \mathbb{G}_m^{a+b}$, $\alpha = (c, 1, \ldots, 1), V = \{(x_1, \ldots, x_{a+b}) \in X : x_1 = \cdots = x_{a+b-1} = 1\}$ and $\Phi : X \to X$ be given by

$$
\Phi(x_1,\ldots,x_a,y_1,\ldots,y_b)=(1,x_1,\ldots,x_{a-1},y_2,\ldots,y_b,x_ay_1).
$$

Then we have $\{n \in \mathbb{N}_0 : \Phi^n(\alpha) \in V(K)\} = T_{a,b}$ so $T_{a,b}$ is a K-DML set over X.

By Lemma [2.1](#page-2-1) and [2.2,](#page-2-2) it remains to show that every p-set $B(p; c_1, \ldots, c_m; k_1, \ldots, k_m)$ is a $\overline{\mathbb{F}_p}(t)$ -DML set over split torus. The following lemma will be frequently used in the paper. For $S \subseteq \mathbb{N}_0$ and $m \in \mathbb{N}$, write $mS := \{ms : s \in S\}$ and $m + S := \{m + s : s \in S\}.$

Lemma 2.3. Let $S \subseteq \mathbb{N}_0$ and $m \in \mathbb{N}$.

- (1) mS is a K-DML set over split torus if and only if S is a K-DML set over split torus.
- (2) $m + S$ is a K-DML set over split torus if and only if S is a K-DML set over split torus.

Proof. (1) Assume that mS is a K-DML set over $X = \mathbb{G}_m^k$. If $\{n \in \mathbb{N}_0 : \Phi^n(\alpha) \in V(K)\} = mS$, then

$$
\{n \in \mathbb{N}_0 : (\Phi^m)^n(\alpha) \in V(K)\} = \{n \in \mathbb{N}_0 : mn \in mS\} = S
$$

so S is also a K-DML set over $X = \mathbb{G}_m^k$. Conversely, assume that S is a K-DML set over $X = \mathbb{G}_m^k$ and $\{n \in \mathbb{N}_0 : \Phi^n(\alpha) \in V(K)\} = S$. Define $X' = X^m = \mathbb{G}_m^{km}$, $V' = V \times X^{m-1}$, $\Phi' : X' \to X'$ $(\Phi'(x_1, ..., x_m) = (\Phi(x_m), x_1, ..., x_{m-1}))$ and $\alpha' = (\alpha, ..., \alpha) \in X'(K)$. Then

$$
\{n \in \mathbb{N}_0 : (\Phi')^n(\alpha') \in V'(K)\} \cap T_{0,m} = mS
$$

so mS is a K-DML set over split torus by Lemma [2.1](#page-2-1) and [2.2.](#page-2-2)

(2) Assume that $m + S$ is a K-DML set over $X = \mathbb{G}_m^k$. If $\{n \in \mathbb{N}_0 : \Phi^n(\alpha) \in V(K)\} = m + S$, then

$$
\{n \in \mathbb{N}_0 : \Phi^n(\Phi^m(\alpha)) \in V(K)\} = S
$$

so S is also a K-DML set over $X = \mathbb{G}_m^k$. Conversely, assume that S is a K-DML set over $X = \mathbb{G}_m^k$ and $\{n \in \mathbb{N}_0 : \Phi^n(\alpha) \in V(K)\}=S$. If $S=\mathbb{N}_0$, then $m+S=T_{m,1}$ is a K-DML set over split torus. Now assume that $S \neq \mathbb{N}_0$ and choose $\beta \in X(K) \setminus V(K)$. Define $X' = X^2 = \mathbb{G}_m^{2k}$, $V' = X \times V$, $\Phi' : X' \to X'$ $(\Phi'(x, y) = (\Phi(x), x))$ and $\alpha' = (\alpha, \beta) \in X'(K)$. Then

$$
\{n \in \mathbb{N}_0 : (\Phi')^n(\alpha') \in V'(K)\} = 1 + S,
$$

so $1 + S$ is a K-DML set over X'. Iterating this process, we conclude that $m + S$ is a K-DML set over split torus.

By Lemma [2.3\(](#page-2-3)1), we may assume that $c_1, \ldots, c_m \in \mathbb{Z} \setminus \{0\}$. By Lemma 2.3(2), we may assume that $k_1,\ldots,k_m>0$. In addition, since the sum $\sum_{j=1}^m c_j p^{k_j n_j}$ is nonnegative for every $n_1,\ldots,n_m\in\mathbb{N}_0$, we have $c_j \in \mathbb{N}$ for every j. Now for $k := k_1 \cdots k_m$, we have

$$
B(p;c_1,\ldots,c_m;k_1,\ldots,k_m)=\bigcup_{\substack{0\leq i_l\leq k/k_l-1\\ \text{for }1\leq t\leq m}}B(p;c_1p^{k_1i_1},\ldots,c_mp^{k_mi_m};k,\ldots,k).
$$

3. Proof of Theorem [1.6](#page-1-0)

In this section, we prove Theorem [1.6.](#page-1-0) By the reduction arguments in Section [2,](#page-2-0) it is enough to prove the following special form of Theorem [1.6.](#page-1-0)

Theorem 3.1. Every p -set

$$
B(p;c_1,\ldots,c_m;k,\ldots,k) = B(q;c_1,\ldots,c_m;1,\ldots,1)
$$

 $(c_j \in \mathbb{N}, k \in \mathbb{N}, q = p^k)$ is a $\overline{\mathbb{F}_p}(t)$ -DML set over split torus.

The key idea of the proof is to divide the p-set $B(q; c_1, \ldots, c_m; 1, \ldots, 1)$ into smaller p-sets to which Theorem [1.5](#page-1-1) can be applied.

Lemma 3.2. Let S be a K-DML set over X and L be an extension field of K. Then S is a L-DML set over $X_L := X \times_K L$.

Proof. Assume that $\{n \in \mathbb{N}_0 : \Phi^n(\alpha) \in V(K)\} = S$ for X, V, Φ and α . Then $X_L := X \times_K L$, $V_L := V \times_K L$, $\Phi_L: X_L \to X_L$ and $\alpha \in X(K) \subseteq X(L) = X_L(L)$ satisfies

$$
\{n \in \mathbb{N}_0 : \Phi_L^n(\alpha) \in V_L(L)\} = \{n \in \mathbb{N}_0 : \Phi^n(\alpha) \in V(L) \cap X(K)\} = S
$$

since $V(L) \cap X(K) = V(K)$ (cf. [\[6,](#page-5-9) Remark 3.31]).

Corollary 3.3. A p-set $B(q; c_1, \ldots, c_m; 1, \ldots, 1)$ is a $\overline{\mathbb{F}_p}(t)$ -DML set over split torus if $c_j \in \mathbb{N}$ and $\sum_{j=1}^m c_j <$ $\frac{q}{2}$.

Proof. $B(q; c_1, \ldots, c_m; 1, \ldots, 1)$ is a $\mathbb{F}_q(t)$ -DML set over split torus by Theorem [1.5.](#page-1-1) Since $\overline{\mathbb{F}_p}(t)$ is an extension field of $\mathbb{F}_q(t)$, $B(q; c_1, \ldots, c_m; 1, \ldots, 1)$ is a $\overline{\mathbb{F}_p}(t)$ -DML set over split torus by Lemma [3.2.](#page-3-2)

The following lemma is an important ingredient in the proof of Theorem [3.1.](#page-3-0)

$$
\sqcup
$$

Lemma 3.4. Assume that Theorem [3.1](#page-3-0) holds for $m = m_0$. If $B(q; c_1, \ldots, c_{m_0+1}; 1, \ldots, 1)$ is a $\overline{\mathbb{F}_p}(t)$ -DML set over split torus, then $B(q; c_1, \ldots, c_{m_0}, q c_{m_0+1}; 1, \ldots, 1)$ is also a $\mathbb{F}_p(t)$ -DML set over split torus.

Proof. We have

$$
B(q; c_1, \ldots, c_{m_0}, q c_{m_0+1}; 1, \ldots, 1)
$$

=
$$
\bigcup_{i=1}^{m_0} (c_i + B(q; c_1, \ldots, c_{i-1}, c_{i+1}, \ldots, c_{m_0}, q c_{m_0+1}; 1, \ldots, 1)) \cup B(q; q c_1, \ldots, q c_{m_0+1}; 1, \ldots, 1)
$$

=
$$
\bigcup_{i=1}^{m_0} (c_i + B(q; c_1, \ldots, c_{i-1}, c_{i+1}, \ldots, c_{m_0}, q c_{m_0+1}; 1, \ldots, 1)) \cup q B(q; c_1, \ldots, c_{m_0+1}; 1, \ldots, 1).
$$

By Lemma [2.3\(](#page-2-3)2) and the assumption that Theorem [3.1](#page-3-0) holds for $m = m_0$, each set

$$
c_i + B(q; c_1, \ldots, c_{i-1}, c_{i+1}, \ldots, c_{m_0}, qc_{m_0+1}; 1, \ldots, 1)
$$

is a $\overline{\mathbb{F}_p}(t)$ -DML set over split torus. By Lemma [2.3\(](#page-2-3)1), $qB(q; c_1, \ldots, c_{m_0+1}; 1, \ldots, 1)$ is a $\overline{\mathbb{F}_p}(t)$ -DML set over split torus. Thus $B(q; c_1, \ldots, c_{m_0}, q c_{m_0+1}; 1, \ldots, 1)$ is a $\overline{\mathbb{F}_p}(t)$ -DML set over split torus by Lemma [2.1\(](#page-2-1)1). \Box

Proof of Theorem [3.1.](#page-3-0) When $m = 1$, we have

$$
B(q; c_1; 1) = c_1 B(q; 1; 1) = c_1 B(q^2; 1; 1) \cup qc_1 B(q^2; 1; 1).
$$

The p-set $B(q^2; 1; 1)$ is a $\overline{\mathbb{F}_p}(t)$ -DML set over split torus by Corollary [3.3](#page-3-3) so $B(q; c_1; 1)$ is a $\overline{\mathbb{F}_p}(t)$ -DML set over split torus by Lemma [2.1](#page-2-1) and [2.3\(](#page-2-3)1).

We proceed by induction on m and assume that Theorem [3.1](#page-3-0) holds for $m - 1 \in \mathbb{N}$. Choose a sufficiently large $k \in \mathbb{N}$ such that $c_1 + \cdots + c_m < \frac{q^{\frac{k}{m}}}{2}$ $\frac{m}{2}$. Then we have

$$
B(q;c_1,\ldots,c_m;1,\ldots,1) = \bigcup_{\substack{0 \le i_t \le k-1 \\ \text{for } 1 \le t \le m}} B(q^k;c_1 q^{i_1},\ldots,c_m q^{i_m};1,\ldots,1)
$$

so it is enough to show each each p-set $B(q^k; c_1q^{i_1}, \ldots, c_mq^{i_m}; 1, \ldots, 1)$ is a $\overline{\mathbb{F}_p}(t)$ -DML set over split torus. For $i_{\min} := \min(i_1, \ldots, i_m)$, we have

$$
B(q^k; c_1 q^{i_1}, \dots, c_m q^{i_m}; 1, \dots, 1) = q^{i_{\min}} B(q^k; c_1 q^{i_1 - i_{\min}}, \dots, c_m q^{i_m - i_{\min}}; 1, \dots, 1)
$$

so we may assume that $min(i_1, \ldots, i_m) = 0$ by Lemma [2.3\(](#page-2-3)1). Without loss of generality, assume that $k = i_0 \geq i_1 \geq \cdots \geq i_m = 0.$

Since $\sum_{t=0}^{m-1} (i_t - i_{t+1}) = i_0 - i_m = k$, we have $\max(i_0 - i_1, \ldots, i_{m-1} - i_m) \geq \frac{k}{m}$. Choose $0 \leq r \leq m-1$ such that $i_r - i_{r+1} = \max(i_0 - i_1, \dots, i_{m-1} - i_m) \geq \frac{k}{m}$. Then we have

$$
q^{k-i_r} B(q^k; c_1 q^{i_1}, \dots, c_m q^{i_m}; 1, \dots, 1) = B(q^k; c_1 q^{k-i_r+i_1}, \dots, c_m q^{k-i_r+i_m}; 1, \dots, 1).
$$

By Lemma $2.3(1)$, the induction hypothesis and Lemma [3.4,](#page-3-4) the *p*-set

$$
B(q^k;c_1q^{i_1},\ldots,c_mq^{i_m};1,\ldots,1)
$$

is a $\overline{\mathbb{F}_p}(t)$ -DML set over split torus if the *p*-set

$$
B(q^k; c_1 q^{i_1-i_r}, \ldots, c_{r-1} q^{i_{r-1}-i_r}, c_r, c_{r+1} q^{k-i_r+i_{r+1}}, \ldots, c_m q^{k-i_r+i_m}; 1, \ldots, 1)
$$

is a $\overline{\mathbb{F}_p}(t)$ -DML set over split torus. Now we have

$$
c_1 q^{i_1-i_r} + \dots + c_{r-1} q^{i_{r-1}-i_r} + c_r + c_{r+1} q^{k-i_r+i_{r+1}} + \dots + c_m q^{k-i_r+i_m}
$$

$$
\leq q^{k-i_r+i_{r+1}}(c_1+\cdots+c_m)
$$

$$
< q^{k-\frac{k}{m}} \cdot \frac{q^{\frac{k}{m}}}{2}
$$

$$
= \frac{q^k}{2}
$$

so the p-set $B(q^k; c_1q^{i_1}, \ldots, c_mq^{i_m}; 1, \ldots, 1)$ is a $\overline{\mathbb{F}_p}(t)$ -DML set over split torus by Corollary [3.3.](#page-3-3)
