# Additive Kinematic Formulas for Convex Functions

#### Abstract

We prove a functional version of the additive kinematic formula as an application of the Hadwiger theorem on convex functions together with a Kubota-type formula for mixed Monge-Ampère measures. As an application, we give a new explanation for the equivalence of the representations of functional intrinsic volumes as singular Hessian valuations and as integrals with respect to mixed MongeAmpère measures. In addition, we obtain a new integral geometric formula for mixed area measures of convex bodies, where integration on $\mathrm{SO}(n-1) \times \mathrm{O}(1)$ is considered.

## 1 Introduction and Statement of Results

For $n \in \mathbb{N}$ we denote by $\mathscr{K}^{n}$ the set of convex bodies in $\mathbb{R}^{n}$, i.e., the set of non-empty, compact, convex subsets. Among the central objects in convex geometry are the intrinsic volumes $V_{j}: \mathscr{K}^{n} \rightarrow \mathbb{R}, 0 \leq j \leq n$, which are given as coefficients in the Steiner formula

$$
\operatorname{vol}_{n}\left(K+r B^{n}\right)=\sum_{j=0}^{n} r^{n-j} \kappa_{n-j} V_{j}(K)
$$

for $r>0$ and $K \in \mathscr{K}^{n}$. Here, vol $_{n}$ denotes the $n$-dimensional volume (i.e., the Lebesgue measure on $\mathbb{R}^{n}$ ), $B^{n}$ is the Euclidean unit ball in $\mathbb{R}^{n}$, and $\kappa_{i}$ denotes the $i$-dimensional volume of the unit ball in $\mathbb{R}^{i}$. Furthermore, for $\lambda, \mu \geq 0$ and $K, L \in \mathscr{K}^{n}$ we write

$$
\lambda K+\mu L=\{\lambda x+\mu y: x \in K, y \in L\}
$$

for the Minkowski sum of the bodies $\lambda K$ and $\mu L$. The expression $2 V_{n-1}(K)$ gives the usual surface area of $K \in \mathscr{K}^{n}$ and if $\operatorname{dim} K \leq j$, i.e., if $K$ is contained in a $j$-dimensional affine subspace, then $V_{j}(K)$ is the usual $j$-dimensional volume of $K$ (we will thus use $V_{j}$ instead of $\mathrm{vol}_{j}$ ).

Alternative but equivalent definitions of the intrinsic volumes can be given, for example, in terms of differential geometry (see [20, (4.25), (4.26)] or [13, Theorem 4.9])
and integral geometry (see [13, Remarks 5.1 and 5.5]). Another approach characterizes the operators $V_{j}$ by their unique properties, which we explain in the following. We call a map $\mathrm{Z}: \mathscr{K}^{n} \rightarrow \mathbb{R}$ a valuation if

$$
\mathrm{Z}(K \cup L)+\mathrm{Z}(K \cap L)=\mathrm{Z}(K)+\mathrm{Z}(L)
$$

for $K, L \in \mathscr{K}^{n}$ such that also $K \cup L \in \mathscr{K}^{n}$. The operator Z is said to be translation invariant if $\mathrm{Z}(K+x)=\mathrm{Z}(K)$ for $K \in \mathscr{K}^{n}$ and $x \in \mathbb{R}^{n}$ and it is rotation invariant if $\mathrm{Z}(\vartheta K)=\mathrm{Z}(K)$ for $K \in \mathscr{K}^{n}$ and $\vartheta \in \mathrm{SO}(n)$. Here $\vartheta K=\{\vartheta x: x \in K\}$ and $\mathrm{SO}(n)$ denotes the special orthogonal group, i.e., the group of orientation preserving rotations of $\mathbb{R}^{n}$. The result below is due to Hadwiger [10, Satz IV] and characterizes linear combinations of intrinsic volumes. Here and in the following, continuity of operators defined on $\mathscr{K}^{n}$ is understood with respect to the Hausdorff metric (see, for example, [20, Section 1.8] for details).

Theorem 1.1 (Hadwiger's Theorem). A map Z: $\mathscr{K}^{n} \rightarrow \mathbb{R}$ is a continuous, translation and rotation invariant valuation if and only if there exist $c_{0}, \ldots, c_{n} \in \mathbb{R}$ such that

$$
\mathrm{Z}(K)=\sum_{j=0}^{n} c_{i} V_{i}(K)
$$

for $K \in \mathscr{K}^{n}$.
Among its numerous applications, the strength of Theorem 1.1 is particularly evident in integral geometry, where it provides almost effortless proofs of formulas that involve integration of geometric quantities with respect to invariant measures. See, for example, [12-14]. One such result is the following additive kinematic formula for which we refer to [13, Theorem 5.13] (see [13, Corollary 5.2] for a more general local version and [20, Theorem 4.4.6] for a different approach).

Theorem 1.2 (Additive Kinematic Formula). For $0 \leq j \leq n$ and $K, L \in \mathscr{K}^{n}$,

$$
\begin{equation*}
\int_{\mathrm{SO}(n)} V_{j}(K+\vartheta L) \mathrm{d} \vartheta=\sum_{k=0}^{j} \frac{\binom{2 n-j}{n-j} \kappa_{n-k} \kappa_{n+k-j}}{\binom{2 n-j}{n-k} \kappa_{n} \kappa_{n-j}} V_{k}(K) V_{j-k}(L), \tag{1.1}
\end{equation*}
$$

where $\mathrm{d} \vartheta$ denotes integration with respect to the Haar probability measure on $\mathrm{SO}(n)$.

The aim of this article is to establish a functional version of Theorem 1.2. For this, we denote by $\operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ the set of convex functions $v: \mathbb{R}^{n} \rightarrow \mathbb{R}$. In [5], functional analogs of the intrinsic volumes on $\operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ were introduced and characterized in a Hadwiger-type theorem. For $v \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right) \cap C^{2}\left(\mathbb{R}^{n}\right)$ and $j \in\{0, \ldots, n\}$, these functional intrinsic volumes are of the form

$$
\begin{equation*}
v \mapsto \int_{\mathbb{R}^{h}} \zeta(|x|)\left[\mathrm{D}^{2} v(x)\right]_{j} \mathrm{~d} x, \tag{1.2}
\end{equation*}
$$

where $|x|$ denotes the Euclidean norm of $x \in \mathbb{R}^{n}, \mathrm{~d} x$ denotes integration with respect to Lebesgue measure on $\mathbb{R}^{n}$, and $\zeta:(0, \infty) \rightarrow \mathbb{R}$ is continuous with bounded support with
a possible singularity at $0^{+}$(see Section 5 for details). Here, $\mathrm{D}^{2} v(x)$ denotes the Hessian matrix of $v$ at $x \in \mathbb{R}^{n}$ and we write $[A]_{j}$ for the $j$ th elementary symmetric function of the eigenvalues of the symmetric matrix $A \in \mathbb{R}^{n \times n}$.

While (1.2) is easy to understand, it turns out that this representation of functional intrinsic volumes as singular Hessian integrals is not well suited for an additive kinematic formula. It was shown in [6, Theorem 2.5] that (1.2) can be rewritten as

$$
v \mapsto \int_{\mathbb{R}^{n}} \alpha(|x|) \mathrm{dMA}\left(v[j], h_{B^{n}}[n-j] ; x\right),
$$

where $\alpha$ is a continuous function with compact support on $[0, \infty)$ that is obtained from $\zeta$ via an integral transform (see Section 5). Here, we write $h_{K}(x)=\sup \{\langle x, y\rangle: y \in K\}$, $x \in \mathbb{R}^{n}$, for the support function of $K \in \mathscr{K}^{n}$, where $\langle\cdot, \cdot\rangle$ denotes the standard inner product on $\mathbb{R}^{n}$, and we remark that $h_{B^{n}}(x)=|x|$ for $x \in \mathbb{R}^{n}$. Moreover, MA $\left(w_{1}, \ldots, w_{n} ; \cdot\right)$ denotes the mixed Monge-Ampère measure of the functions $w_{1}, \ldots, w_{n} \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ and in the equation above the function $v$ is repeated $j$ times and $h_{B^{n}}$ is repeated $n-j$ times. Under additional $C^{2}$ assumptions on its arguments, the mixed Monge-Ampère measure is absolutely continuous with respect to the Lebesgue measure and takes the form

$$
\mathrm{dMA}\left(w_{1}, \ldots, w_{n} ; x\right)=\operatorname{det}\left(\mathrm{D}^{2} w_{1}(x), \ldots, \mathrm{D}^{2} w_{n}(x)\right) \mathrm{d} x
$$

where det: $\left(\mathbb{R}^{n \times n}\right)^{n} \rightarrow \mathbb{R}$ denotes the mixed discriminant. For a more precise definition of this measure, we refer to Section 2.

For our purposes, we will thus consider the (renormalized) functional intrinsic volumes $\overline{\mathrm{V}}_{j, \alpha}^{*}: \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right) \rightarrow \mathbb{R}$ given by

$$
\begin{equation*}
\overline{\mathrm{V}}_{j, \alpha}^{*}(v)=\binom{n}{j} \frac{1}{\kappa_{n-j}} \int_{\mathbb{R}^{n}} \alpha(|x|) \mathrm{dMA}\left(v[j], h_{B^{n}}[n-j] ; x\right) \tag{1.3}
\end{equation*}
$$

for $v \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$, where $0 \leq j \leq n$, and $\alpha \in C_{c}([0, \infty))$. This particular choice of normalization has the advantage that

$$
\overline{\mathrm{V}}_{j, \alpha}^{*}\left(h_{K}\right)=\alpha(0) V_{j}(K)
$$

for $K \in \mathscr{K}^{n}$ (see, for example, [11, Lemma 4.6]). The Hadwiger theorem on the space $\operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$, which was first established in [5, Theorem 1.5], is the following result. For the version stated below, see [6, Theorem 2.6]. See also [7, Theorem 1.1] and [16, Theorem 1.2].

For the statement of the result, we recall some terminology. Continuity of a functional $\mathrm{Z}: \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right) \rightarrow \mathbb{R}$ is understood with respect to epi-convergence, which on $\operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ is equivalent to pointwise convergence. The operator Z is dually epitranslation invariant if $\mathrm{Z}(v+f)=\mathrm{Z}(v)$ for $v \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ and affine functions $f$ on $\mathbb{R}^{n}$ and it is rotation invariant if $\mathrm{Z}\left(v \circ \vartheta^{-1}\right)=\mathrm{Z}(v)$ for $v \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ and $\vartheta \in \operatorname{SO}(n)$. Lastly, Z is a valuation if

$$
\begin{equation*}
\mathrm{Z}(v \wedge w)+\mathrm{Z}(v \vee w)=\mathrm{Z}(v)+\mathrm{Z}(w) \tag{1.4}
\end{equation*}
$$

for $v, w \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ such that also $v \wedge w \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$, where $v \wedge w$ and $v \vee w$ denote the pointwise minimum and maximum of $v$ and $w$, respectively.

Theorem 1.3. A functional $Z: \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right) \rightarrow \mathbb{R}$ is a continuous, dually epi-translation and rotation invariant valuation if and only if there exist functions $\alpha_{0}, \ldots, \alpha_{n} \in C_{c}([0, \infty))$ such that

$$
\mathrm{Z}(v)=\sum_{j=0}^{n} \overline{\mathrm{~V}}_{j, \alpha_{j}}^{*}(v)
$$

for $v \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$.
We will use the functional Hadwiger theorem together with a Kubota-type formula for (conjugate) mixed Monge-Ampère measures (see Lemma 2.4) to prove the following functional counterpart of Theorem 1.2.

Theorem 1.4. If $0 \leq j \leq n$ and $\alpha:[0, \infty) \rightarrow[0, \infty)$ is measurable, then

$$
\begin{aligned}
& \quad \kappa_{n} \int_{\mathrm{SO}(n)} \int_{\mathbb{R}^{n}} \alpha(|y|) \mathrm{dMA}\left(v+\left(w \circ \vartheta^{-1}\right)[j], h_{B^{n}}[n-j] ; y\right) \mathrm{d} \vartheta \\
& \quad=\sum_{i=0}^{j}\binom{j}{i} \int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} \alpha(\max \{|x|,|y|\}) \\
& \operatorname{dMA}\left(w[j-i], h_{B^{n}}[n-j+i] ; y\right) \mathrm{dMA}\left(v[i], h_{B^{n}}[n-i] ; x\right) \\
& \text { for } v, w \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right) .
\end{aligned}
$$

Observe that the left side of (1.5) can be rewritten as a multiple of

$$
\int_{\mathrm{SO}(n)} \overline{\mathrm{V}}_{j, \alpha}^{*}\left(v+\left(w \circ \vartheta^{-1}\right)\right) \mathrm{d} \vartheta
$$

which resembles (1.1). However, in general, the right side of (1.5) is not a sum of products of functional intrinsic volumes. A case in which this is possible is given by Corollary 4.2 below. In Section 4 we also show how Theorem 1.2 can be retrieved from Theorem 1.4 and treat further consequences, such as formulas for functional analogs of mixed volumes (Corollary 4.3) or analytic versions of the Minkowski difference (Corollary 4.4).

As a further application of Theorem 1.4, we establish a novel explanation of the aforementioned equivalence between (1.3) and the singular Hessian integrals (1.2) in Section 5.

Lastly, in Section 6 we study the implications of Theorem 1.4 for mixed area measures of convex bodies. We write $S_{n-1}(K, \cdot)$ for the surface area measure of $K \in \mathscr{K}^{n}$, which is a Borel measure on the unit sphere $\mathbb{S}^{n-1}$. For a body $K$ of dimension $n$ and a Borel set $\omega \subseteq \mathbb{S}^{n-1}$, the expression $S_{n-1}(K, \omega)$ gives the ( $n-1$ )-dimensional Hausdorff measure, denoted by $\mathscr{H}^{n-1}$, of all boundary points $x \in \partial K$ at which $K$ has an outer unit normal in $\omega$ (we refer to [20, Section 4.2] for a detailed description). The coefficients $S\left(K_{i_{1}}, \ldots, K_{i_{n-1}}, \cdot\right)$ in the polynomial expansion

$$
S_{n-1}\left(\lambda_{1} K_{1}+\cdots+\lambda_{m} K_{m}, \cdot\right)=\sum_{i_{1}, \ldots, i_{n-1}=1}^{m} \lambda_{i_{1}} \cdots \lambda_{i_{n-1}} S\left(K_{i_{1}}, \ldots, K_{i_{n-1}}, \cdot\right)
$$

for $m \in \mathbb{N}, \lambda_{1}, \ldots, \lambda_{m} \geq 0$, and $K_{1}, \ldots, K_{m} \in \mathscr{K}^{n}$, are the mixed area measures of the bodies $K_{i_{1}}, \ldots, K_{i_{n-1}}$. For $0 \leq j \leq n-1$ we consider measures of the form $S\left(K[j], B_{H}^{n-1}[n-\right.$ $1-j], \cdot)$, where the body $K \in \mathscr{K}^{n}$ is repeated $j$ times and the ( $n-1$ )-dimensional unit ball

$$
B_{H}^{n-1}=B^{n} \cap e_{n}^{\perp}=\left\{\left(x_{1}, \ldots, x_{n}\right) \in \mathbb{R}^{n}: x_{1}^{2}+\cdots+x_{n-1}^{2} \leq 1, x_{n}=0\right\}
$$

is repeated $(n-1-j)$ times. Here, $e_{n}$ denotes the $n$th basis vector of the standard orthonormal basis of $\mathbb{R}^{n}$ and we write $H=e_{n}^{\perp}$. The authors studied these measures and their connection with mixed Monge-Ampère measures and functional intrinsic volumes in more detail in [11].

For $n \geq 2$, we identify $\mathrm{SO}(n-1)$ as the group of rotations that fix $e_{n}$ and $\mathrm{O}(1)$ as the group that consists of the identity and $\operatorname{diag}(1, \ldots, 1,-1)$. We use Theorem 1.4 to prove the following result, where integration on $\mathrm{SO}(n-1) \times \mathrm{O}(1)$ is with respect to the Haar probability measure. In addition, we write $z_{n}=\left\langle z, e_{n}\right\rangle$, for $z \in \mathbb{S}^{n-1}$.
Theorem 1.5. Let $n \geq 2$. If $0 \leq j \leq n-1$ and $\beta:[0,1] \rightarrow[0, \infty)$ is measurable, then

$$
\begin{align*}
& \int_{\mathrm{SO}(n-1) \times \mathrm{O}(1)} \int_{\mathbb{S}^{n-1}}\left|z_{n}\right| \beta\left(\left|z_{n}\right|\right) \mathrm{d} S\left((K+\eta L)[j], B_{H}^{n-1}[n-1-j], z\right) \mathrm{d} \eta \\
& \quad=\frac{1}{2 \kappa_{n-1}} \sum_{i=0}^{j}\binom{j}{i} \int_{\mathbb{S}^{n-1}} \int_{\mathbb{S}^{n-1}}\left|w_{n}\right|\left|z_{n}\right| \beta\left(\min \left\{\left|w_{n}\right|,\left|z_{n}\right|\right\}\right) \\
& \quad \mathrm{d} S\left(L[j-i], B_{H}^{n-1}[n-1-j+i], w\right) \mathrm{d} S\left(K[i], B_{H}^{n-1}[n-1-i], z\right) \tag{1.6}
\end{align*}
$$

for $K, L \in \mathscr{K}^{n}$.
A rotational integral formula for mixed area measures which is equivalent to Theorem 1.5 is provided in Corollary 6.2.

## 2 Preliminaries

Throughout this section, we state some results on convex functions. For general references, we refer to [18-20].

For $v \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ we write $\partial v(x)$ for the subdifferential of $v$ at $x \in \mathbb{R}^{n}$, which is the set

$$
\partial v(x)=\left\{y \in \mathbb{R}^{n}: v(z) \geq v(x)+\langle y, z-x\rangle \forall z \in \mathbb{R}^{n}\right\} .
$$

The function $v$ is differentiable at $x$ if and only if $\partial v(x)$ contains only one element, namely the gradient $\nabla v(x)$.

The Monge-Ampère measure of $v$, which is a Radon measure on $\mathbb{R}^{n}$, is defined as

$$
\operatorname{MA}(v ; B)=V_{n}\left(\bigcup_{b \in B} \partial v(b)\right)
$$

for Borel sets $B \subseteq \mathbb{R}^{n}$ (see, for example, [9, Theorem 2.3]). The mixed Monge-Ampère measure, which is associated to an $n$-tuple of elements of $\operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$, is now given by the relation

$$
\begin{equation*}
\operatorname{MA}\left(\lambda_{1} v_{1}+\cdots+\lambda_{m} v_{m} ; \cdot\right)=\sum_{i_{1}, \ldots, i_{n}=1}^{m} \lambda_{i_{1}} \cdots \lambda_{i_{n}} \operatorname{MA}\left(v_{i_{1}}, \ldots, v_{i_{n}} ; \cdot\right) \tag{2.1}
\end{equation*}
$$

where $m \in \mathbb{N}, v_{1}, \ldots, v_{m} \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$, and $\lambda_{1}, \ldots, \lambda_{m} \geq 0$. Equation (2.1) uniquely determines the mixed Monge-Ampère measure if we additionally assume that it is symmetric in its entries. See [22] and [6, Theorem 4.3].

For a convex function $w: \mathbb{R}^{n} \rightarrow(-\infty, \infty]$, we consider its convex conjugate or Legendre-Fenchel transform

$$
w^{*}(x)=\sup \left\{\langle x, y\rangle-w(y): y \in \mathbb{R}^{n}\right\}
$$

for $x \in \mathbb{R}^{n}$. For each $v \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$, the convex conjugate $v^{*}$ is a lower semicontinuous, convex function on $\mathbb{R}^{n}$ with values in $(-\infty, \infty]$, which satisfies $v(\bar{x})<\infty$ for at least one $\bar{x} \in \mathbb{R}^{n}$ and which is super-coercive, that is,

$$
\lim _{|x| \rightarrow \infty} \frac{v^{*}(x)}{|x|}=\infty .
$$

We denote the set of all such functions by $\operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ and remark this duality can be stated as $u^{*} \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ if and only if $u \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$.

While the space of convex bodies is naturally embedded into $\operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ by associating with each body $K \in \mathscr{K}^{n}$ its support function $h_{K} \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$, the canonical representative of $K$ in $\operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ is given by its convex indicator function

$$
\mathbf{I}_{K}(x)=h_{K}^{*}(x)= \begin{cases}0 & \text { if } x \in K  \tag{2.2}\\ \infty & \text { else }\end{cases}
$$

We equip the space $\operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ with the topology associated with epi-convergence, where a sequence of convex functions $w_{j}: \mathbb{R}^{n} \rightarrow(-\infty, \infty], j \in \mathbb{N}$, epi-converges to $w: \mathbb{R}^{n} \rightarrow(-\infty, \infty]$ if for every $x \in \mathbb{R}^{n}$,

- $w(x) \leq \liminf _{j \rightarrow \infty} w_{j}\left(x_{j}\right)$ for every sequence $x_{j} \rightarrow x$ and
- $w(x)=\lim _{j \rightarrow \infty} w_{j}\left(x_{j}\right)$ for some sequence $x_{j} \rightarrow x$.

By [19, Theorem 11.34], convex conjugation is a homeomorphism between $\operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ and $\operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$. Let us remark that while on $\operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ epi-convergence coincides with pointwise convergence, this is not the case anymore on $\operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$. For an alternative description of epi-convergence on $\operatorname{Conv}_{\text {sc }}\left(\mathbb{R}^{n}\right)$ which uses Hausdorff convergence of level sets, we refer to [3, Lemma 5].

We need the following result, which is a consequence of [8, Lemma 3.3].
Lemma 2.1. The map

$$
(\vartheta, u) \mapsto u \circ \vartheta
$$

is jointly continuous on $\mathrm{SO}(n) \times \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$.
For a convex function $w: \mathbb{R}^{n} \rightarrow(-\infty, \infty]$ we write

$$
\operatorname{epi}(w)=\left\{(x, t) \in \mathbb{R}^{n} \times \mathbb{R}: w(x) \leq t\right\}
$$

for its epi-graph, which is a convex subset of $\mathbb{R}^{n} \times \mathbb{R}$. For the convex conjugate of the pointwise sum of two functions $v_{1}$ and $v_{2}$ in $\operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ we have

$$
\begin{equation*}
\operatorname{epi}\left(v_{1}+v_{2}\right)^{*}=\operatorname{epi}\left(v_{1}^{*}\right)+\operatorname{epi}\left(v_{2}^{*}\right) . \tag{2.3}
\end{equation*}
$$

The corresponding operation on $\operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ is infimal convolution or epi-sum which for $u_{1}, u_{2} \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ is given by

$$
\left(u_{1} \square u_{2}\right)(x)=\inf \left\{u_{1}(x-y)+u_{2}(y): y \in \mathbb{R}^{n}\right\}
$$

for $x \in \mathbb{R}^{n}$. The set in (2.3) can now be written as epi $\left(v_{1}^{*} \square v_{2}^{*}\right)$. By the preceding exposition, the following result, which can be found in [19, Theorem 7.46 (a)], is easy to see.
Lemma 2.2. Let $u_{j}, v_{j} \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ for $j \in \mathbb{N}$. If $u_{j}$ epi-converges to $u \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ and $v_{j}$ epi-converges to $v \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$, then $u_{j} \square v_{j}$ epi-converges to $u \square v$.

Next, for the convex conjugate of the pointwise multiplication of $v \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ with $\lambda>0$ we have

$$
\operatorname{epi}(\lambda v)^{*}=\lambda \operatorname{epi}\left(v^{*}\right)=\operatorname{epi}\left(\lambda \cdot v^{*}\right)
$$

where $(\lambda \cdot u)(x)=\lambda u\left(\frac{x}{\lambda}\right)$ denotes the epi-multiplication of $u \in \operatorname{Conv}_{s c}\left(\mathbb{R}^{n}\right)$ with $\lambda>0$. This operation continuously extends to $\lambda=0$ with $0 \cdot u=\mathbf{I}_{\{o\}}$.

The conjugate Monge-Ampère measure of $u \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ is defined by

$$
\operatorname{MA}^{*}(u ; \cdot)=\operatorname{MA}\left(u^{*} ; \cdot\right)
$$

or equivalently

$$
\int_{\mathbb{R}^{n}} \beta(y) \mathrm{dMA}^{*}(u ; y)=\int_{\operatorname{dom}(u)} \beta(\nabla u(x)) \mathrm{d} x
$$

for measurable $\beta: \mathbb{R}^{n} \rightarrow[0, \infty)$. Here,

$$
\operatorname{dom}(u)=\left\{x \in \mathbb{R}^{n}: u(x)<\infty\right\}
$$

is the domain of $u$ and it follows from Rademacher's theorem that a convex function is differentiable almost everywhere (w.r.t. the Lebesgue measure) on its domain. Similarly, for $u_{1}, \ldots, u_{n} \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ the conjugate mixed Monge-Ampère measure is given by

\begin{equation*}
\operatorname{MA}^{*}\left(u_{1}, \ldots, u_{n} ; \cdot\right)=\operatorname{MA}\left(u_{1}^{*}, \ldots, u_{n}^{*} ; \cdot\right) \tag{2.4}
\end{equation*}
$$

and satisfies

$$
\begin{equation*}
\operatorname{MA}^{*}\left(\left(\lambda_{1} \cdot u_{1}\right) \square \cdots \square\left(\lambda_{m} \cdot u_{m}\right) ; \cdot\right)=\sum_{i_{1}, \ldots, i_{n}=1}^{m} \lambda_{i_{1}} \cdots \lambda_{i_{n}} \operatorname{MA}^{*}\left(u_{i_{1}}, \ldots, u_{i_{n}} ; \cdot\right) \tag{2.5}
\end{equation*}
$$

for $m \in \mathbb{N}, u_{1}, \ldots, u_{m} \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$, and $\lambda_{1}, \ldots, \lambda_{m} \geq 0$.
We use (2.2) and (2.4) to obtain the following equivalent formulation of [11, Lemma 4.6]. Here we write $V:\left(\mathscr{K}^{n}\right)^{n} \rightarrow \mathbb{R}$ for the mixed volume, which is defined as the unique symmetric map such that

$$
V_{n}\left(\lambda_{1} K_{1}+\cdots+\lambda_{m} K_{m}\right)=\sum_{i_{1}, \ldots, i_{n}=1}^{m} \lambda_{i_{1}} \cdots \lambda_{i_{n}} V\left(K_{i_{1}}, \ldots, K_{i_{n}}\right)
$$

for $m \in \mathbb{N}, K_{1}, \ldots, K_{m} \in \mathscr{K}^{n}$, and $\lambda_{1}, \ldots, \lambda_{m} \geq 0$. See [20, Theorem 5.1.7] for further details on mixed volumes.

Lemma 2.3. If $K_{1}, \ldots, K_{n} \in \mathscr{K}^{n}$, then

$$
\mathrm{MA}^{*}\left(\mathbf{I}_{K_{1}}, \ldots, \mathbf{I}_{K_{n}} ; B\right)=V\left(K_{1}, \ldots, K_{n}\right) \delta_{o}(B)
$$

for Borel sets $B \subseteq \mathbb{R}^{n}$, where $\delta_{o}$ is the Dirac measure at the origin. In particular,

$$
\binom{n}{j} \mathrm{MA}^{*}\left(\mathbf{I}_{K}[j], \mathbf{I}_{B^{n}}[n-j] ; B\right)=\kappa_{n-j} V_{j}(K) \delta_{o}(B)
$$

for $0 \leq j \leq n$.
The next result is a Kubota-type formula for conjugate mixed Monge-Ampère measures and was established by the authors in [11, Theorem 5.1]. Here, for $1 \leq k \leq n$ we denote by $\mathrm{G}(n, k)$ the Grassmannian of $k$-dimensional linear subspaces of $\mathbb{R}^{n}$ and integration on this space is always understood with respect to the Haar probability measure. For $u \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ and $E \in \mathrm{G}(n, k)$ we write

$$
\operatorname{proj}_{E} u\left(x_{E}\right)=\min _{y \in E^{\perp}} u\left(x_{E}+y\right)
$$

with $x_{E} \in E$, for the projection function of $u$.
Lemma 2.4. If $1 \leq k<n$ and $\varphi: \mathbb{R}^{n} \rightarrow[0, \infty)$ is measurable, then

$$
\begin{aligned}
& \frac{1}{\kappa_{n}} \int_{\mathbb{R}^{n}} \varphi(y) \mathrm{dMA}^{*}\left(u_{1}, \ldots, u_{k}, \mathbf{I}_{B^{n}}[n-k] ; y\right) \\
&=\frac{1}{\kappa_{k}} \int_{\mathrm{G}(n, k)} \int_{E} \varphi\left(y_{E}\right) \mathrm{dMA}_{E}^{*}\left(\operatorname{proj}_{E} u_{1}, \ldots, \operatorname{proj}_{E} u_{k} ; y_{E}\right) \mathrm{d} E
\end{aligned}
$$

for $u_{1}, \ldots, u_{k} \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$.
For $t \geq 0$, let $u_{t} \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ be defined by $u_{t}(x)=t|x|+\mathbf{I}_{B^{n}}(x)$ for $x \in \mathbb{R}^{n}$. We need the following result, which is a consequence of [6, Lemma 8.4] together with the defining relation (2.4).

Lemma 2.5. If $1 \leq j \leq n$ and $\alpha \in C_{c}([0, \infty))$, then

$$
\int_{\mathbb{R}^{n}} \alpha(|y|) \mathrm{dMA}^{*}\left(u_{t}[j], \mathbf{I}_{B^{n}}[n-j] ; y\right)=\kappa_{n} \alpha(t)
$$

for $t \geq 0$.
Lastly, we need some results on valuations on $\operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$, which are defined analogously to (1.4). By [4, Proposition 3.5], a map $Z: \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right) \rightarrow \mathbb{R}$ is a valuation if and only if $v \mapsto Z^{*}(v)=\mathrm{Z}\left(v^{*}\right)$ is a valuation on $\operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$. We say that $Z$ is epi-translation invariant if $\mathrm{Z}^{*}$ is dually epi-translation invariant or equivalently if $\mathrm{Z}\left(u \circ \tau^{-1}+c\right)=\mathrm{Z}(u)$ for $u \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$, translations $\tau$ on $\mathbb{R}^{n}$, and $c \in \mathbb{R}$. The operator Z is epi-homogeneous of degree $j \in \mathbb{N}$ if $\mathrm{Z}(\lambda \cdot u)=\lambda^{j} \mathrm{Z}(u)$ for $u \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ and $\lambda \geq 0$.

The following result from [6, Proposition 5.3] provides some examples of valuations on $\operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$. We denote by $C_{c}\left(\mathbb{R}^{n}\right)$ the set of continuous real-valued functions with compact support on $\mathbb{R}^{n}$.

Lemma 2.6. Let $\varphi \in C_{c}\left(\mathbb{R}^{n}\right)$ and $0 \leq j \leq n$. If $u_{1}, \ldots, u_{n-1} \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$, then

$$
u \mapsto \int_{\mathbb{R}^{n}} \varphi(x) \mathrm{dMA}^{*}\left(u_{1}, \ldots, u_{n-j}, u[j] ; x\right)
$$

defines a continuous, epi-translation invariant valuation on $\operatorname{Conv}_{s c}\left(\mathbb{R}^{n}\right)$ that is epihomogeneous of degree $j$.

We say that a map Z on $\operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ is rotation invariant if $\mathrm{Z}\left(u \circ \vartheta^{-1}\right)=\mathrm{Z}(u)$ for $u \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ and $\vartheta \in \operatorname{SO}(n)$. The following Hadwiger-type result, provided in [5, Theorem 1.3], is equivalent to Theorem 1.3 and shows that not many examples of valuations remain under the additional assumption of rotation invariance. For the version stated below, see [6, Theorem 1.7].

Theorem 2.7. A functional $\mathrm{Z}: \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right) \rightarrow \mathbb{R}$ is a continuous, epi-translation and rotation invariant valuation if and only if there exist functions $\alpha_{0}, \ldots, \alpha_{n} \in C_{c}([0, \infty))$ such that

$$
\mathrm{Z}(u)=\sum_{j=0}^{n} \int_{\mathbb{R}^{n}} \alpha_{j}(|y|) \mathrm{dMA}^{*}\left(u[j], \mathbf{I}_{B^{n}}[n-j] ; y\right)
$$

for $u \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$.
Let us remark that Lemma 2.5 shows that the operator Z that appears in Theorem 2.7 uniquely determines the densities $\alpha_{j}$.

## 3 Proof of Theorem 1.4

Throughout this section, we use the abbreviated notation

$$
\operatorname{MA}_{j}^{*}(u ; \cdot)=\operatorname{MA}^{*}\left(u[j], \mathbf{I}_{B^{n}}[n-j] ; \cdot\right)=\operatorname{MA}\left(u^{*}[j], h_{B^{n}}[n-j] ; \cdot\right)
$$

for $0 \leq j \leq n$ and $u \in \operatorname{Conv}_{s c}\left(\mathbb{R}^{n}\right)$, which was introduced in [6].
To prove the next result, we follow the strategy of the proof of [8, Lemma 3.4]. Moreover, we use that $(u \circ \vartheta)^{*}=u^{*} \circ \vartheta$, for $u \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ and $\vartheta \in \operatorname{SO}(n)$, and $\operatorname{MA}(v ; \vartheta B)=\mathrm{MA}(v \circ \vartheta ; B)$, for $v \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right), \vartheta \in \mathrm{SO}(n)$, and Borel sets $B \subseteq \mathbb{R}^{n}$.

Lemma 3.1. For any $1 \leq j \leq n$, fixed $\bar{v} \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ and $\alpha \in C_{c}([0, \infty))$ the map

$$
\begin{equation*}
u \mapsto \int_{\mathrm{SO}(n)} \int_{\mathbb{R}^{n}} \alpha(|y|) \mathrm{dMA}_{j}^{*}\left(u \square\left(\bar{v} \circ \vartheta^{-1}\right) ; y\right) \mathrm{d} \vartheta \tag{3.1}
\end{equation*}
$$

is a continuous, epi-translation and rotation invariant valuation on $\operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$.
Proof. We start by showing that

$$
\begin{equation*}
(\vartheta, u) \mapsto \int_{\mathbb{R}^{n}} \alpha(|y|) \mathrm{dMA}_{j}^{*}\left(u \square\left(\bar{v} \circ \vartheta^{-1}\right) ; y\right) \tag{3.2}
\end{equation*}
$$

is jointly continuous on $\mathrm{SO}(n) \times \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$. For this, observe that it follows from the rotational symmetry of the integrand and the two basic facts mentioned before the statement of the lemma that

$$
\begin{aligned}
\int_{\mathbb{R}^{n}} \alpha(|y|) \mathrm{dMA}_{j}^{*}\left(u \square\left(\bar{v} \circ \vartheta^{-1}\right) ; y\right) & =\int_{\mathbb{R}^{n}} \alpha(|y|) \mathrm{dMA}_{j}^{*}\left(\left(u \square\left(\bar{v} \circ \vartheta^{-1}\right)\right) \circ \vartheta ; y\right) \\
& =\int_{\mathbb{R}^{n}} \alpha(|y|) \mathrm{dMA}_{j}^{*}((u \circ \vartheta) \square \bar{v} ; y)
\end{aligned}
$$

for every $u \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ and $\vartheta \in \operatorname{SO}(n)$. Thus, by Lemma 2.2, Lemma 2.6, and Lemma 2.1, the map given in (3.2) is jointly continuous on $\operatorname{SO}(n) \times \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$.

Let $u_{i} \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right), i \in \mathbb{N}$, be such that $u_{i}$ epi-converges to some $\bar{u} \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$, which means that $\left\{u_{i}: i \in \mathbb{N}\right\} \cup\{\bar{u}\}$ is sequentially compact. Together with the fact that $\mathrm{SO}(n)$ is compact and the map given in (3.2) is jointly continuous, it follows that the supremum

$$
\begin{equation*}
\sup \left\{\left|\int_{\mathbb{R}^{n}} \alpha(|y|) \mathrm{dMA}_{j}^{*}\left(u_{i} \square\left(\bar{v} \circ \vartheta^{-1}\right) ; y\right)\right|: i \in \mathbb{N}, \vartheta \in \mathrm{SO}(n)\right\} \tag{3.3}
\end{equation*}
$$

is finite. Thus, we may apply the dominated convergence theorem to obtain

$$
\begin{aligned}
& \lim _{i \rightarrow \infty} \int_{\mathrm{SO}(n)} \int_{\mathbb{R}^{n}} \alpha(|y|) \mathrm{dMA}_{j}^{*}\left(u_{i} \square\left(\bar{v} \circ \vartheta^{-1}\right) ; y\right) \mathrm{d} \vartheta \\
&=\int_{\operatorname{SO}(n)} \int_{\mathbb{R}^{n}} \alpha(|y|) \mathrm{dMA}_{j}^{*}\left(\bar{u} \square\left(\bar{v} \circ \vartheta^{-1}\right) ; y\right) \mathrm{d} \vartheta
\end{aligned}
$$

which shows that (3.1) is continuous.
Lastly, it follows from the properties of infimal convolution and the corresponding properties provided in Lemma 2.6 that (3.1) defines an epi-translation and rotation invariant valuation.

Remark 3.2. An alternative argument showing that the supremum in (3.3) is finite, can be based on [11, Remark 5.2].

For the proof of the main result of this section, we need the elementary property

$$
\begin{equation*}
\operatorname{MA}^{*}\left(\mathbf{I}_{B^{n}} ; \cdot\right)=\kappa_{n} \delta_{o} \tag{3.4}
\end{equation*}
$$

which is a special case of Lemma 2.3. The next result is the equivalent version of Theorem 1.4 on $\operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$.

Theorem 3.3. If $0 \leq j \leq n$ and $\alpha:[0, \infty) \rightarrow[0, \infty)$ is measurable, then

$$
\begin{aligned}
& \kappa_{n} \int_{\mathrm{SO}(n)} \int_{\mathbb{R}^{n}} \alpha(|y|) \mathrm{dMA}_{j}^{*}\left(u \square\left(v \circ \vartheta^{-1}\right) ; y\right) \mathrm{d} \vartheta \\
&=\sum_{i=0}^{j}\binom{j}{i} \int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} \alpha(\max \{|x|,|y|\}) \mathrm{dMA}_{j-i}^{*}(v ; y) \mathrm{dMA}_{i}^{*}(u ; x)
\end{aligned}
$$

for $u, v \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$.

Proof. For the proof, it is sufficient to consider a function $\alpha \in C_{c}([0, \infty))$. If $j=0$, the statement trivially follows from (3.4). Thus, we will assume $1 \leq j \leq n$ throughout the following. For $u, v \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ set

$$
\begin{equation*}
\mathrm{Z}(u, v)=\int_{\mathrm{SO}(n)} \int_{\mathbb{R}^{n}} \alpha(|y|) \mathrm{dMA}_{j}^{*}\left(u \square\left(v \circ \vartheta^{-1}\right) ; y\right) \mathrm{d} \vartheta \tag{3.5}
\end{equation*}
$$

For fixed $\bar{v} \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ it follows from Lemma 3.1 that $u \mapsto \mathrm{Z}(u, \bar{v})$ is a continuous, epi-translation and rotation invariant valuation on $\operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$. Thus, by Theorem 2.7 there exist functions $\alpha_{i, \bar{v}} \in C_{c}([0, \infty)), 0 \leq i \leq n$, such that

$$
\mathrm{Z}(u, \bar{v})=\sum_{i=0}^{n} \int_{\mathbb{R}^{n}} \alpha_{i, \bar{v}}(|y|) \mathrm{dMA}_{i}^{*}(u ; y)
$$

for every $u \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$. In particular, if we choose $u=\lambda \cdot u_{t}$, where $u_{t}=t|\cdot|+\mathbf{I}_{B^{n}}$, it follows from (3.4), Lemma 2.6, and Lemma 2.5 that

$$
\begin{equation*}
\mathrm{Z}\left(\lambda \cdot u_{t}, \bar{v}\right)=\kappa_{n}\left(\alpha_{0, \bar{v}}(0)+\sum_{i=1}^{n} \lambda^{i} \alpha_{i, \bar{v}}(t)\right) \tag{3.6}
\end{equation*}
$$

for every $t, \lambda \geq 0$. Since for every fixed $\bar{u} \in \operatorname{Conv}_{\text {sc }}\left(\mathbb{R}^{n}\right)$ also the map $v \mapsto \mathrm{Z}(\bar{u}, v)$ is a continuous, epi-translation and rotation invariant valuation, it follows from (3.6) together with homogeneity that for every fixed $\bar{t} \geq 0$ each of the maps

$$
v \mapsto \alpha_{0, v}(0) \quad \text { and } \quad v \mapsto \alpha_{i, v}(\bar{t}), 1 \leq i \leq n
$$

is a continuous, epi-translation and rotation invariant valuation. Thus, by Theorem 2.7 there exist functions $\alpha_{0, k} \in C_{c}([0, \infty)), \alpha_{i, k}(\bar{t}, \cdot) \in C_{c}([0, \infty)), 1 \leq i \leq n, 0 \leq k \leq n$, such that

$$
\alpha_{0, v}(0)=\sum_{k=0}^{n} \int_{\mathbb{R}^{n}} \alpha_{0, k}(|y|) \mathrm{dMA}_{k}^{*}(v ; y)
$$

and

$$
\alpha_{i, v}(\bar{t})=\sum_{k=0}^{n} \int_{\mathbb{R}^{n}} \alpha_{i, k}(\bar{t},|y|) \mathrm{dMA}_{k}^{*}(v ; y)
$$

for every $v \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ and $1 \leq i \leq n$. We thus have

$$
\begin{align*}
\mathrm{Z}(u, v)= & \kappa_{n} \alpha_{0, v}(0)+\sum_{i=1}^{n} \int_{\mathbb{R}^{n}} \alpha_{i, v}(|x|) \mathrm{dMA}_{i}^{*}(u ; x) \\
=\kappa_{n} & \sum_{k=0}^{n} \int_{\mathbb{R}^{n}} \alpha_{0, k}(|y|) \mathrm{dMA}_{k}^{*}(v ; y)  \tag{3.7}\\
& +\sum_{i=1}^{n} \sum_{k=0}^{n} \int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} \alpha_{i, k}(|x|,|y|) \mathrm{dMA}_{k}^{*}(v ; y) \mathrm{dMA}_{i}^{*}(u ; x)
\end{align*}
$$

for every $u, v \in \operatorname{Conv}_{\text {sc }}\left(\mathbb{R}^{n}\right)$.
It remains to determine the relation between $\alpha_{i, k}$ and $\alpha$. In order to do this, we will evaluate $\mathrm{Z}(u, v)$ at $u=\lambda \cdot u_{s}$ and $v=\mu \cdot u_{t}$ with $\lambda, \mu, s, t \geq 0$. Notice that

$$
\lambda \cdot u_{s}(x)=s|x|+\mathbf{I}_{\lambda B^{n}}(x) \quad \text { and } \quad\left(\mu \cdot u_{t}\right) \circ \vartheta^{-1}(x)=t|x|+\mathbf{I}_{\mu B^{n}}(x)
$$

for $\vartheta \in \mathrm{SO}(n)$ and $x \in \mathbb{R}^{n}$. For $0 \leq s \leq t$ we now have

$$
\begin{aligned}
\left(\left(\lambda \cdot u_{s}\right) \square\left(\left(\mu \cdot u_{t}\right) \circ \vartheta^{-1}\right)\right)(x) & =\inf \{s|x-y|+t|y|: \\
& = \begin{cases}s|x|, & \left.|x| \leq \lambda B^{n}, y \in \mu B^{n}\right\} \\
s \lambda+t(|x|-\lambda), & \lambda<|x| \leq \lambda+\mu, . \\
+\infty, & \lambda+\mu<|x|,\end{cases}
\end{aligned}
$$

Hence,

$$
\operatorname{proj}_{E}\left(\left(\lambda \cdot u_{s}\right) \square\left(\left(\mu \cdot u_{t}\right) \circ \vartheta^{-1}\right)\right)\left(x_{E}\right)= \begin{cases}s\left|x_{E}\right|, & \left|x_{E}\right| \leq \lambda, \\ s \lambda+t\left(\left|x_{E}\right|-\lambda\right), & \lambda<\left|x_{E}\right| \leq \lambda+\mu, \\ +\infty, & \lambda+\mu<\left|x_{E}\right|,\end{cases}
$$

for every $\vartheta \in \mathrm{SO}(n)$ and $E \in \mathrm{G}(n, j)$. Thus, it follows from (3.5) and Lemma 2.4 (for $j=n$ the lemma holds trivially) that

$$
\begin{align*}
\mathrm{Z}\left(\lambda \cdot u_{S}, \mu \cdot u_{t}\right) & =\int_{\mathbb{R}^{n}} \alpha(|y|) \mathrm{dMA}_{j}^{*}\left(\left(\lambda \cdot u_{S}\right) \square\left(\mu \cdot u_{t}\right) ; y\right) \\
& =\frac{\kappa_{n}}{\kappa_{j}} \int_{\mathrm{G}(n, j)} \int_{E} \alpha\left(\left|y_{E}\right|\right) \mathrm{dMA}_{E}^{*}\left(\operatorname{proj}_{E}\left(\left(\lambda \cdot u_{S}\right) \square\left(\mu \cdot u_{t}\right)\right) ; y_{E}\right) \mathrm{d} E \\
& =\frac{\kappa_{n}}{\kappa_{j}} \int_{\mathrm{G}(n, j)} \int_{(\lambda+\mu) B^{n}} \alpha\left(\left|\nabla \operatorname{proj}_{E}\left(\left(\lambda \cdot u_{s}\right) \square\left(\mu \cdot u_{t}\right)\right)\left(x_{E}\right)\right|\right) \mathrm{d} x_{E} \mathrm{~d} E \\
& =\kappa_{n}\left(\lambda^{j} \alpha(s)+\left((\lambda+\mu)^{j}-\lambda^{j}\right) \alpha(t)\right) \\
& =\kappa_{n}\left(\lambda^{j} \alpha(s)+\sum_{i=0}^{j-1}\binom{j}{i} \lambda^{i} \mu^{j-i} \alpha(t)\right) \tag{3.8}
\end{align*}
$$

for $0 \leq s \leq t$. On the other hand, by (3.7), (3.4), and Lemma 2.5,

$$
\begin{align*}
& \mathrm{Z}\left(\lambda \cdot u_{s}, \mu \cdot u_{t}\right) \\
& \quad=\kappa_{n}^{2}\left(\alpha_{0,0}(0)+\sum_{k=1}^{n} \mu^{k} \alpha_{0, k}(t)\right)+\kappa_{n}^{2} \sum_{i=1}^{n} \lambda^{i}\left(\alpha_{i, 0}(s, 0)+\sum_{k=1}^{n} \mu^{k} \alpha_{i, k}(s, t)\right) . \tag{3.9}
\end{align*}
$$

Since $\lambda, \mu \geq 0$ were arbitrary, we can compare coefficients of the last two equations to obtain

$$
\kappa_{n} \alpha_{j, 0}(s, 0)=\alpha(s), \quad \kappa_{n} \alpha_{0, j}(t)=\alpha(t), \quad \kappa_{n} \alpha_{i, j-i}(s, t)=\binom{j}{i} \alpha(t),
$$

for $1 \leq i \leq j-1$ and $\alpha_{i, k}(s, t)=0$ if $i+k \neq j$ whenever $0 \leq s \leq t$.
Proceeding for the case $s \geq t$ similarly as in the derivation of (3.8), we obtain

$$
\mathrm{Z}\left(\lambda \cdot u_{s}, \mu \cdot u_{t}\right)=\kappa_{n}\left(\mu^{j} \alpha(t)+\sum_{i=0}^{j-1}\binom{j}{i} \mu^{i} \lambda^{j-i} \alpha(s)\right) .
$$

A comparison with the coefficients available from (3.9) shows that

$$
\kappa_{n} \alpha_{j, 0}(s, 0)=\alpha(s), \quad \kappa_{n} \alpha_{0, j}(t)=\alpha(t), \quad \kappa_{n} \alpha_{i, j-i}(s, t)=\binom{j}{i} \alpha(s),
$$

for $1 \leq i \leq j-1$ and $\alpha_{i, k}(s, t)=0$ if $i+k \neq j$, also for $s \geq t$.
The claim now follows after considering (3.4).

## 4 Further Formulas

For $\alpha \in C_{c}([0, \infty))$ and $0 \leq j \leq n$, we define the $j$ th functional intrinsic volume on $\operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ with density $\alpha$, denoted by $\overline{\mathrm{V}}_{j, \alpha}$, as

$$
\begin{equation*}
\overline{\mathrm{V}}_{j, \alpha}(u)=\binom{n}{j} \frac{1}{\kappa_{n-j}} \int_{\mathbb{R}^{n}} \alpha(|y|) \mathrm{dMA}_{j}^{*}(u ; y) \tag{4.1}
\end{equation*}
$$

for $u \in \operatorname{Conv}_{\text {sc }}\left(\mathbb{R}^{n}\right)$. Clearly, $\overline{\mathrm{V}}_{j, \alpha}^{*}(v)=\overline{\mathrm{V}}_{j, \alpha}\left(v^{*}\right)$ for every $v \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$.
By (4.1), we have the following reformulation of Theorem 3.3.
Theorem 4.1. If $0 \leq j \leq n$ and $\alpha \in C_{c}([0, \infty))$, then

$$
\begin{align*}
\kappa_{n} \kappa_{n-j} \int_{\mathrm{SO}(n)} & \overline{\mathrm{V}}_{j, \alpha}\left(u \square\left(v \circ \vartheta^{-1}\right)\right) \mathrm{d} \vartheta \\
= & \binom{n}{j} \sum_{i=0}^{j}\binom{j}{i} \int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} \alpha(\max \{|x|,|y|\}) \mathrm{dMA}_{j-i}^{*}(v ; y) \mathrm{dMA}_{i}^{*}(u ; x) \tag{4.2}
\end{align*}
$$

for $u, v \in \operatorname{Conv}_{\text {sc }}\left(\mathbb{R}^{n}\right)$.
If in (4.2) we choose $v$ to be the convex indicator function $\mathbf{I}_{L}$ of a convex body $L \in \mathscr{K}^{n}$, then a direct application of Lemma 2.3 gives a specialization of Theorem 4.1 reading as follows, where we write

\left[\begin{array}{c}
k \\
j
\end{array}\right]:=\binom{k}{j} \frac{\kappa_{k}}{\kappa_{j} \kappa_{k-j}}
$$

for $j, k \in \mathbb{N}$.
Corollary 4.2. If $0 \leq j \leq n$ and $\alpha \in C_{c}([0, \infty))$, then

$$
\int_{\mathrm{SO}(n)} \overline{\mathrm{V}}_{j, \alpha}\left(u \square \mathbf{I}_{\vartheta L}\right) \mathrm{d} \vartheta=\sum_{i=0}^{j}\left[\begin{array}{c}
n-i \\
j-i
\end{array}\right]\left[\begin{array}{c}
n \\
j-i
\end{array}\right]^{-1} \overline{\mathrm{~V}}_{i, \alpha}(u) V_{j-i}(L)
$$

for $u \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ and $L \in \mathscr{K}^{n}$.
Proof. It follows from Lemma 2.3 that for $u \in \operatorname{Conv}_{\text {sc }}\left(\mathbb{R}^{n}\right), L \in \mathscr{K}^{n}$, and $0 \leq j \leq n$, we have

$$
\binom{n}{j} \mathrm{MA}_{j}^{*}\left(\mathbf{I}_{L} ; B\right)=\kappa_{n-j} V_{j}(L) \delta_{0}(B)
$$

for Borel sets $B \subseteq \mathbb{R}^{n}$. Applying Theorem 4.1, we then infer

$$
\begin{aligned}
& \int_{\mathrm{SO}(n)} \overline{\mathrm{V}}_{j, \alpha}\left(u \square I_{\vartheta L}\right) \mathrm{d} \vartheta \\
& =\frac{\binom{n}{j}}{\kappa_{n} \kappa_{n-j}} \sum_{i=0}^{j}\binom{j}{i} \int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} \alpha(\max \{|x|,|y|\}) \mathrm{dMA}_{j-i}^{*}\left(\mathbf{I}_{L} ; y\right) \mathrm{dMA}_{i}^{*}(u ; x) \\
& =\frac{\binom{n}{j}}{\kappa_{n} \kappa_{n-j}} \sum_{i=0}^{j} \frac{\binom{j}{i} \kappa_{n-(j-i)}}{\binom{n}{j-i}} V_{j-i}(L) \int_{\mathbb{R}^{n}} \alpha(|x|) \mathrm{dMA}_{i}^{*}(u ; x) \\
& \left.=\sum_{i=0}^{j} \frac{\binom{n}{j}\binom{j}{i}}{\binom{n-i}{j-i}} \begin{array}{c}
n \\
i
\end{array}\right) \quad \frac{\kappa_{n-i} \kappa_{n-(j-i)}}{\kappa_{n} \kappa_{n-j}} \overline{\mathrm{~V}}_{i, \alpha}(u) V_{j-i}(L) \\
& =\sum_{i=0}^{j}\left[\begin{array}{c}
n-i \\
j-i
\end{array}\right]\left[\begin{array}{c}
n \\
j-i
\end{array}\right]^{-1} \overline{\mathrm{~V}}_{i, \alpha}(u) V_{j-i}(L),
\end{aligned}
$$

where we used that $\alpha(\max \{|x|, 0\})=\alpha(|x|)$ for $x \in \mathbb{R}^{n}$ and

$$
\frac{\binom{n}{j}\binom{j}{i}}{\binom{n}{i}}=\binom{n-i}{j-i}
$$

for $0 \leq i \leq j \leq n$.
Note that if in the last result we furthermore also choose $u$ to be the indicator function of a convex body $K \in \mathscr{K}^{n}$, then we recover the additive kinematic formula for convex bodies (1.1), which can be written as

$$
\int_{\mathrm{SO}(n)} V_{j}(K+\vartheta L) \mathrm{d} \vartheta=\sum_{i=0}^{j}\left[\begin{array}{c}
n-i \\
j-i
\end{array}\right]\left[\begin{array}{c}
n \\
j-i
\end{array}\right]^{-1} V_{i}(K) V_{j-i}(L) .
$$

Next, we consider mixed functionals. A corollary of (1.1) for the mixed volume $V:\left(\mathscr{K}^{n}\right)^{n} \rightarrow \mathbb{R}$ states that if $0 \leq j \leq n$, then

$$
\binom{n}{j} \int_{\mathrm{SO}(n)} V(K[j], \vartheta L[n-j]) \mathrm{d} \vartheta=\left[\begin{array}{l}
n  \tag{4.3}\\
j
\end{array}\right]^{-1} V_{j}(K) V_{n-j}(L)
$$

for every $K, L \in \mathscr{K}^{n}$. See, for example, formula (6.7) in [21].
For $\alpha \in C_{c}([0, \infty))$ we define the operator $\overline{\mathrm{V}}_{\alpha}$ on $\left(\operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)\right)^{n}$ as

$$
\overline{\mathrm{V}}_{\alpha}\left(u_{1}, \ldots, u_{n}\right)=\int_{\mathbb{R}^{n}} \alpha(|y|) \mathrm{dMA}^{*}\left(u_{1}, \ldots, u_{n} ; y\right)
$$

for $u_{1}, \ldots, u_{n} \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$. Clearly, by the properties of the conjugate mixed MongeAmpère measure, the functional $\overline{\mathrm{V}}_{\alpha}$ is symmetric in its entries. Moreover, in each of its arguments it is continuous with respect to epi-convergence, epi-homogeneous of degree 1 , and epi-translation invariant. We remark that functionals of this form were also treated in [1] and, from a valuation point of view, in [4, 15].

By Lemma 2.3, it is immediate to check that $\overline{\mathrm{V}}_{\alpha}$ generalizes the classical mixed volumes, i.e.,

$$
\overline{\mathrm{V}}_{\alpha}\left(\mathbf{I}_{K_{1}}, \ldots, \mathbf{I}_{K_{n}}\right)=\alpha(0) V\left(K_{1}, \ldots, K_{n}\right)
$$

for $K_{1}, \ldots, K_{n} \in \mathscr{K}^{n}$. We have the following functional integral formula which includes (4.3) in the special case where $k=n, u=\mathbf{I}_{K}$, and $v=\mathbf{I}_{L}$ (see also [13, Lemma 5.8]).

Corollary 4.3. If $0 \leq j \leq k \leq n$ and $\alpha \in C_{c}([0, \infty))$, then

$$
\begin{aligned}
& \quad \int_{\mathrm{SO}(n)} \overline{\mathrm{V}}_{\alpha}\left(u_{1}, \ldots, u_{j}, v_{1} \circ \vartheta^{-1}, \ldots, v_{k-j} \circ \vartheta^{-1}, \mathbf{I}_{B^{n}}[n-k]\right) \mathrm{d} \vartheta \\
& \quad=\frac{1}{\kappa_{n}} \int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} \alpha(\max \{|x|,|y|\}) \mathrm{dMA}_{j}^{*}\left(u_{1}, \ldots, u_{j} ; x\right) \mathrm{dMA}_{k-j}^{*}\left(v_{1}, \ldots, v_{k-j} ; y\right) \\
& \text { for } u_{1}, \ldots, u_{j}, v_{1}, \ldots, v_{k-j} \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right) .
\end{aligned}
$$

Proof. Let $u, v \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$. For $\varepsilon>0$ it follows from Theorem 4.1 and the properties of the measures $\mathrm{MA}_{n-j}^{*}(\nu ; \cdot)$ that

$$
\begin{aligned}
& \int_{\mathrm{SO}(n)} \overline{\mathrm{V}}_{k, \alpha}\left(u \square \varepsilon \cdot\left(v \circ \vartheta^{-1}\right)\right) \mathrm{d} \vartheta \\
& \quad=\frac{1}{\kappa_{n} \kappa_{n-k}}\binom{n}{k} \sum_{i=0}^{k}\binom{k}{i} \varepsilon^{k-i} \int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} \alpha(\max \{|x|,|y|\}) \mathrm{dMA}_{k-i}^{*}(v ; y) \mathrm{dMA}_{i}^{*}(u ; x)
\end{aligned}
$$

for every $u, v \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$. On the other hand, by (2.5) we have

$$
\begin{aligned}
& \int_{\mathrm{SO}(n)} \overline{\mathrm{V}}_{k, \alpha}\left(u \square \varepsilon \cdot\left(v \circ \vartheta^{-1}\right)\right) \mathrm{d} \vartheta \\
& =\frac{1}{\kappa_{n-k}}\binom{n}{k} \int_{\mathrm{SO}(n)} \int_{\mathbb{R}^{n}} \alpha(|x|) \mathrm{dMA}_{k}^{*}\left(u \square \varepsilon \cdot\left(v \circ \vartheta^{-1}\right) ; x\right) \mathrm{d} \vartheta \\
& =\frac{1}{\kappa_{n-k}}\binom{n}{k} \sum_{i=0}^{k}\binom{k}{i} \varepsilon^{k-i} \int_{\mathrm{SO}(n)} \int_{\mathbb{R}^{n}} \alpha(|x|) \mathrm{dMA}^{*}\left(u[i], v \circ \vartheta^{-1}[k-i], \mathbf{I}_{B^{n}}[n-k] ; x\right) \mathrm{d} \vartheta \\
& =\frac{1}{\kappa_{n-k}}\binom{n}{k} \sum_{i=0}^{k}\binom{k}{i} \varepsilon^{k-i} \int_{\mathrm{SO}(n)} \overline{\mathrm{V}}_{\alpha}\left(u[i], v \circ \vartheta^{-1}[k-i], \mathbf{I}_{B^{n}}[n-k]\right) \mathrm{d} \vartheta .
\end{aligned}
$$

The result now follows after comparing coefficients together with multilinearity.
As an application, Corollary 4.3 can be used to obtain generalizations of further formulas. In particular, mimicking the so-called Minkowski difference (see, for example, [21, Note 3 of Section 6.1]), we can introduce the operation of inf-deconvolution. If for $u, v \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$, there exists $w \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$ such that

$$
w \square v=u,
$$

then we say that $w$ is the inf-deconvolution of $u$ and $v$, which we denote by

$$
w=u \diamond v .
$$

Equivalently, this means that $u \diamond v$ exists if and only if the (pointwise) difference $u^{*}-v^{*}$ is an element of $\operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ and

$$
(u \diamond v)^{*}=u^{*}-v^{*} .
$$

Moreover, we say that $v$ rolls freely in $u$ if for every $\vartheta \in \operatorname{SO}(n)$ the expression $u \diamond\left(v \circ \vartheta^{-1}\right)$ is well-defined. With this new terminology at hand, we obtain the following consequence of Corollary 4.3.

Corollary 4.4. Let $0 \leq k \leq n, \alpha \in C_{c}([0, \infty))$, and $u, v \in \operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n}\right)$. If $v$ rolls freely in $u$, then

$$
\begin{align*}
& \int_{\mathrm{SO}(n)} \overline{\mathrm{V}}_{k, \alpha}\left(u \diamond\left(v \circ \vartheta^{-1}\right)\right) d \vartheta  \tag{4.4}\\
& =\frac{\binom{n}{k}}{\kappa_{n} \kappa_{n-k}} \sum_{j=0}^{k}(-1)^{k-j}\binom{k}{j} \int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} \alpha(\max \{|x|,|y|\}) \mathrm{dMA}_{k-j}^{*}(v ; y) \mathrm{dMA}_{j}^{*}(u ; x)
\end{align*}
$$

Proof. Since $\overline{\mathrm{V}}_{\alpha}$ is linear with respect to inf-convolution in each of its arguments and presuming that $u \diamond\left(v \circ \vartheta^{-1}\right)$ exists for every $\vartheta \in \operatorname{SO}(n)$, we have

$$
\begin{aligned}
& \overline{\mathrm{V}}_{k, \alpha}\left(u \diamond\left(v \circ \vartheta^{-1}\right)\right) \\
& =\overline{\mathrm{V}}_{\alpha}\left(u \diamond\left(v \circ \vartheta^{-1}\right)[k], \mathbf{I}_{B^{n}}[n-k]\right) \\
& =\overline{\mathrm{V}}_{\alpha}\left(u \diamond\left(v \circ \vartheta^{-1}\right)[k-1], u, \mathbf{I}_{B^{n}}[n-k]\right) \\
& \quad \quad-\overline{\mathrm{V}}_{\alpha}\left(u \diamond\left(v \circ \vartheta^{-1}\right)[n-1],\left(v \circ \vartheta^{-1}\right), \mathbf{I}_{B^{n}}[n-k]\right) \\
& \vdots \\
& =\sum_{j=0}^{k}(-1)^{k-j}\binom{k}{j} \overline{\mathrm{~V}}_{\alpha}\left(u[j],\left(v \circ \vartheta^{-1}\right)[k-j], \mathbf{I}_{B^{n}}[n-k]\right),
\end{aligned}
$$

which can be proved in detail by induction on $k \in\{0, \ldots, n\}$. Integration over $\operatorname{SO}(n)$ together with an application of Corollary 4.3 results in relation (4.4).

## 5 Singular Hessian Integrals

In this section, we demonstrate another application of the special case $k=n$ of Corollary 4.3. Let us first state its equivalent version on $\operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)($ for $k=n)$, where we write $\mathrm{MA}_{j}(v ; \cdot)=\operatorname{MA}\left(v[j], h_{B^{n}}[n-j] ; \cdot\right)$ for $v \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ and $0 \leq j \leq n$.

Corollary 5.1. If $0 \leq j \leq n$ and $\alpha \in C_{c}([0, \infty))$, then

$$
\begin{aligned}
& \int_{\mathrm{SO}(n)} \int_{\mathbb{R}^{n}} \alpha(|x|) \mathrm{dMA}\left(v[j], w \circ \vartheta^{-1}[n-j] ; x\right) \mathrm{d} \vartheta \\
&=\frac{1}{\kappa_{n}} \int_{\mathbb{R}^{n}} \int_{\mathbb{R}^{n}} \alpha(\max \{|x|,|y|\}) \mathrm{dMA}_{n-j}(w ; y) \mathrm{dMA}_{j}(v ; x)
\end{aligned}
$$

for $v, w \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$.

As mentioned in Section 1, functional intrinsic volumes were previously defined in terms of Hessian measures. For this, let

$$
D_{j}^{n}=\left\{\zeta \in C_{b}((0, \infty)): \lim _{s \rightarrow 0^{+}} s^{n-j} \zeta(s)=0, \exists \lim _{s \rightarrow 0^{+}} \int_{s}^{\infty} t^{n-j-1} \zeta(t) \mathrm{d} t \in \mathbb{R}\right\}
$$

for $0 \leq j \leq n-1$, where $C_{b}((0, \infty))$ denotes the set of continuous function with bounded support on $(0, \infty)$. In addition, set

$$
D_{n}^{n}=\left\{\zeta \in C_{b}((0, \infty)): \exists \lim _{s \rightarrow 0^{+}} \zeta(s) \in \mathbb{R}\right\},
$$

which we identify with $C_{c}([0, \infty))$. In [5, Theorem 1.4] and later also in $[6,8,16]$, it was shown that for $0 \leq j \leq n$ and $\zeta \in D_{j}^{n}$, the map

$$
\begin{equation*}
v \mapsto \int_{\mathbb{R}^{n}} \zeta(|x|)\left[\mathrm{D}^{2} v(x)\right]_{j} \mathrm{~d} x \tag{5.1}
\end{equation*}
$$

continuously extends from $\operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right) \cap C_{+}^{2}\left(\mathbb{R}^{n}\right)$ to $\operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$. This extension was used as the original definition for functional intrinsic volumes, meaning they can be understood as singular Hessian integrals.

In [6], an alternative proof of existence for the continuous extension of (5.1) was found. The essential observation (see [6, Proposition 6.7]) is that

$$
\begin{equation*}
\int_{\mathbb{R}^{n}} \zeta(|x|) \mathrm{dMA}(v[j], q[n-j] ; x)=\int_{\mathbb{R}^{n}} \mathscr{R}^{n-j} \zeta(|x|) \mathrm{dMA}_{j}(v ; x) \tag{5.2}
\end{equation*}
$$

for $0 \leq j \leq n-1, \zeta \in D_{j}^{n}$, and $v \in C^{2}\left(\mathbb{R}^{n}\right)$, where

$$
\mathscr{R}^{n-j} \zeta(s)=s^{n-j} \zeta(s)+(n-j) \int_{s}^{\infty} t^{n-j-1} \zeta(t) \mathrm{d} t
$$

for $s>0$ and where $q(x)=|x|^{2} / 2$. If we consistently define $\mathscr{R}^{0} \zeta=\zeta$ for $\zeta \in D_{n}^{n}$, then (5.2) remains true also for $j=n$. In addition, it was previously shown in [8, Lemma 3.8], that $\mathscr{R}^{n-j}$ is a bijection from $D_{j}^{n}$ to $D_{n}^{n}$. Together with

$$
\begin{equation*}
\binom{n}{j} \mathrm{dMA}(v[j], q[n-j] ; x)=\left[\mathrm{D}^{2} v(x)\right] j \mathrm{~d} x \tag{5.3}
\end{equation*}
$$

for $v \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right) \cap C^{2}\left(\mathbb{R}^{n}\right)$ and $0 \leq j \leq n$, this then implies that (5.1) continuously extends to $\operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ (for $j=0$ we use the convention $\left[\mathrm{D}^{2} v(x)\right]_{0} \equiv 1$ ).

As we illustrate in the following, Corollary 5.1 gives a straightforward understanding of (5.2). Indeed, if in Corollary 5.1 we choose $w=q$, then it follows from the rotational symmetry of $q$ that

\begin{equation*}
\int_{\mathbb{R}^{n}} \zeta(|x|) \mathrm{dMA}(v[j], q[n-j] ; x)=\int_{\mathbb{R}^{n}} \beta(|x|) \mathrm{dMA}_{j}(v ; x) \tag{5.4}
\end{equation*}
$$

for every $0 \leq j \leq n, \zeta \in D_{n}^{n}$, and $v \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$, where

$$
\beta(|x|)=\frac{1}{\kappa_{n}} \int_{\mathbb{R}^{n}} \zeta(\max \{|x|,|y|\}) \mathrm{dMA}_{n-j}(q ; y)
$$

for $x \in \mathbb{R}^{n}$. If $j=n$, then $\mathrm{MA}_{0}(q ; \cdot)=\kappa_{n} \delta_{0}$ (see [11, Lemma 4.6]) implies that $\beta(|x|)=$ $\zeta(|x|)$. If $0 \leq j \leq n-1$, then direct calculations (see also [6, Theorem 4.5 (d)]) show that

$$
\mathrm{dMA}_{n-j}(q ; y)=\frac{n-j}{n} \frac{1}{|y|^{j}} \mathrm{~d} y
$$

on $\mathbb{R}^{n} \backslash\{o\}$ and, by [11, Lemma 4.3], $\mathrm{MA}_{n-j}(q ;\{o\})=V\left(\{o\}[n-j], B^{n}[j]\right)=0$. Therefore,

$$
\begin{aligned}
\beta(|x|) & =\frac{1}{\kappa_{n}}\left(\zeta(|x|) \int_{|x| B^{n}} \mathrm{dMA}_{n-j}(q ; y)+\int_{\mathbb{R}^{n} \backslash|x| B^{n}} \zeta(|y|) \mathrm{dMA}_{n-j}(q ; y)\right) \\
& =\frac{1}{\kappa_{n}}\left(\zeta(|x|) \frac{n-j}{n}\left(n \kappa_{n}\right) \int_{0}^{|x|} r^{n-1-j} \mathrm{~d} r+\frac{n-j}{n}\left(n \kappa_{n}\right) \int_{|x|}^{\infty} \zeta(r) r^{n-1-j} \mathrm{~d} r\right) \\
& =\zeta(|x|)|x|^{n-j}+(n-j) \int_{|x|}^{\infty} \zeta(r) r^{n-j-1} \mathrm{~d} r \\
& =\mathscr{R}^{n-j} \zeta(|x|)
\end{aligned}
$$

for $x \in \mathbb{R}^{n}$. By using the properties of the transform $\mathscr{R}^{n-j}$ and of the measures $\operatorname{MA}(v[j], q[n-j] ; \cdot)$ for $v \in C^{2}\left(\mathbb{R}^{n}\right)$ (see, for example, [5, Lemma 3.1]), one can now extend (5.4) from $\zeta \in D_{n}^{n}$ to $\zeta \in D_{j}^{n}$.

We remark that using the same method as above, similar relations can be obtained between integrals with respect to $\mathrm{MA}_{j}(v ; \cdot)$ and integrals with respect to MA $(v[j], w[n-$ $j] ; \cdot)$, where $w \in \operatorname{Conv}\left(\mathbb{R}^{n} ; \mathbb{R}\right)$ is rotationally symmetric.

## 6 Formulas for Convex Bodies

For the proof of Theorem 1.5 we use a connection between conjugate mixed MongeAmpère measures and mixed area measures which was established in [17, Section 3] and further expanded upon in [11, Section 4.2].

Let $n \geq 2$ and let $\operatorname{proj}_{H}: \mathbb{R}^{n} \rightarrow H$ denote the orthogonal projection onto the hyperplane $H=e_{n}^{\perp}$, which we will identify with $\mathbb{R}^{n-1}$. To each convex body $K \in \mathscr{K}^{n}$ we assign the function

$$
\lfloor K\rfloor(x)= \begin{cases}\min \{t \in \mathbb{R}:(x, t) \in K\} & \text { if } x \in \operatorname{proj}_{H} K \\ \infty & \text { else. }\end{cases}
$$

This defines a lower semicontinuous, convex function on $\mathbb{R}^{n-1}$ with compact domain, and in particular, $\lfloor K\rfloor$ is an element of $\operatorname{Conv}_{\mathrm{sc}}\left(\mathbb{R}^{n-1}\right)$. Furthermore, observe that

$$
\begin{equation*}
\lfloor K+L\rfloor=\lfloor K\rfloor \square\lfloor L\rfloor \tag{6.1}
\end{equation*}
$$

for $K, L \in \mathscr{K}^{n}$.
In the following, we denote by $\mathbb{S}_{-}^{n-1}=\left\{z \in \mathbb{S}^{n-1}:\left\langle z, e_{n}\right\rangle<0\right\}$ the lower half-sphere in $\mathbb{R}^{n}$. The gnomonic projection gno: $\mathbb{S}_{-}^{n-1} \rightarrow \mathbb{R}^{n-1}$ is defined by

$$
\operatorname{gno}(z)=\frac{\left(z_{1}, \ldots, z_{n-1}\right)}{\left|z_{n}\right|}
$$

for $z=\left(z_{1}, \ldots, z_{n}\right) \in \mathbb{S}_{-}^{n-1}$, with inverse

$$
\operatorname{gno}^{-1}(x)=\frac{(x,-1)}{\sqrt{1+|x|^{2}}}
$$

for $x \in \mathbb{R}^{n-1}$. By [17, Section 3.2] and [11, Remark 4.7] we have the following reformulation of [11, Corollary 4.9].

Lemma 6.1. If $\varphi: \mathbb{S}_{-}^{n-1} \rightarrow[0, \infty)$ is measurable, then

$$
\int_{\mathbb{R}^{n-1}} \varphi\left(\operatorname{gno}^{-1}(y)\right) \mathrm{dMA}^{*}\left(\left\lfloor K_{1}\right\rfloor, \ldots,\left\lfloor K_{n-1}\right\rfloor ; y\right)=\int_{\mathbb{S}_{-}^{n}}\left|\left\langle z, e_{n}\right\rangle\right| \varphi(z) \mathrm{d} S\left(K_{1}, \ldots, K_{n-1}, z\right)
$$

for $K_{1}, \ldots, K_{n-1} \in \mathscr{K}^{n}$.
Proof of Theorem 1.5. Let $\beta:[0,1] \rightarrow[0, \infty)$ be measurable and let $\tilde{\beta}:[0,1] \rightarrow[0, \infty)$ be given by $\tilde{\beta}(t)=t \beta(t)$ for $t \in[0,1]$. Since $\tilde{\beta}\left(\left|z_{n}\right|\right)=0$ if $z_{n}=\left\langle z, e_{n}\right\rangle=0$, we thus obtain

$$
\begin{align*}
& \int_{\mathbb{S}^{n-1}}\left|z_{n}\right| \beta\left(\left|z_{n}\right|\right) \mathrm{d} S\left((K+\vartheta L)[j], B_{H}^{n-1}[n-1-j], z\right) \\
& =\int_{\mathbb{S}_{-}^{n-1}} \tilde{\beta}\left(\left|z_{n}\right|\right) \mathrm{d} S\left((K+\vartheta L)[j], B_{H}^{n-1}[n-1-j], z\right)  \tag{6.2}\\
& \quad+\int_{\mathbb{S}_{+}^{n-1}} \tilde{\beta}\left(\left|z_{n}\right|\right) \mathrm{d} S\left((K+\vartheta L)[j], B_{H}^{n-1}[n-1-j], z\right), \tag{6.3}
\end{align*}
$$

for $\vartheta \in \operatorname{SO}(n-1)$, where $\mathbb{S}_{+}^{n-1}=\left\{z \in \mathbb{S}^{n-1}:\left\langle z, e_{n}\right\rangle>0\right\}$.
Next, we want to obtain suitable representations for the integrals in (6.2) and (6.3) so that we can apply Theorem 3.3. Notice that the integral in (6.3) can be rewritten as an integral on $\mathbb{S}_{-}^{n-1}$. Indeed, if we denote by $\bar{K}$ and $\bar{L}$ the reflections of $K$ and $L$ through $H$, respectively, then (6.3) can be written as

$$
\int_{\mathbb{S}_{-}^{n-1}} \tilde{\beta}\left(\left|z_{n}\right|\right) \mathrm{d} S\left((\bar{K}+\vartheta \bar{L})[j], B_{H}^{n-1}[n-1-j], z\right)
$$

Here we used that the considered reflection fixes $B_{H}^{n-1}$ and elements of $\mathrm{SO}(n-1)$.
Let $u, v \in \operatorname{Conv}_{\mathrm{cd}}\left(\mathbb{R}^{n-1}\right)$ be given by $u=\lfloor K\rfloor$ and $v=\lfloor L\rfloor$. Furthermore, let the measurable function $\alpha:[0, \infty) \rightarrow[0, \infty)$ be defined by the relation

$$
\alpha(t)=\beta\left(\frac{1}{\sqrt{1+t^{2}}}\right) \quad \text { or equivalently } \quad \beta(s)=\alpha\left(\frac{\sqrt{1-s^{2}}}{s}\right)
$$

for $t \in[0, \infty)$ and $s \in(0,1]$. By (6.1) and Lemma 6.1, applied with $\varphi(z)=\beta\left(\left|\left\langle z, e_{n}\right\rangle\right|\right)$ for $z \in \mathbb{S}_{-}^{n-1}$, we now have

$$
\begin{aligned}
& \int_{\mathbb{S}_{-}^{n-1}} \tilde{\beta}\left(\left|z_{n}\right|\right) \mathrm{d} S\left((K+\vartheta L)[j], B_{H}^{n-1}[n-1-j], z\right) \\
& \quad=\int_{\mathbb{R}^{n-1}} \alpha(|y|) \mathrm{dMA}_{j}^{*}\left(u \square\left(v \circ \vartheta^{-1}\right) ; y\right),
\end{aligned}
$$

where we have used that $v \circ \vartheta^{-1}=\lfloor\vartheta L\rfloor$ and $\left\lfloor B_{H}^{n-1}\right\rfloor=\mathbf{I}_{B^{n-1}}$. For $\bar{u}=\lfloor\bar{K}\rfloor, \bar{v}=\lfloor\bar{L}\rfloor$, we obtain analogously

$$
\begin{aligned}
& \int_{\mathbb{S}_{+}^{n-1}} \tilde{\beta}\left(\left|z_{n}\right|\right) \mathrm{d} S\left((K+\vartheta L)[j], B_{H}^{n-1}[n-1-j], z\right) \\
& \quad=\int_{\mathbb{S}_{-}^{n-1}} \tilde{\beta}\left(\left|z_{n}\right|\right) \mathrm{d} S\left((\bar{K}+\vartheta \bar{L})[j], B_{H}^{n-1}[n-1-j], z\right) \\
& \quad=\int_{\mathbb{R}^{n-1}} \alpha(|y|) \mathrm{dMA}_{j}^{*}\left(\bar{u} \square\left(\bar{v} \circ \vartheta^{-1}\right) ; y\right) .
\end{aligned}
$$

Hence we get

$$
\begin{align*}
& \int_{\mathbb{S}^{n-1}} \tilde{\beta}\left(\left|z_{n}\right|\right) \mathrm{d} S\left((K+\vartheta L)[j], B_{H}^{n-1}[n-1-j], z\right)  \tag{6.4}\\
& \quad=\int_{\mathbb{R}^{n-1}} \alpha(|y|) \mathrm{dMA}_{j}^{*}\left(u \square\left(v \circ \vartheta^{-1}\right) ; y\right)+\int_{\mathbb{R}^{n-1}} \alpha(|y|) \mathrm{dMA}_{j}^{*}\left(\bar{u} \square\left(\bar{v} \circ \vartheta^{-1}\right) ; y\right) .
\end{align*}
$$

We now integrate (6.4) over $\mathrm{SO}(n-1)$ with respect to the Haar probability measure. Together with Theorem 3.3, applied with respect to the ambient space $\mathbb{R}^{n-1}$, we infer

$$
\begin{align*}
& \int_{\mathrm{SO}(n-1)} \int_{\mathbb{S}^{n-1}} \tilde{\beta}\left(\left|z_{n}\right|\right) \mathrm{d} S\left((K+\vartheta L)[j], B_{H}^{n-1}[n-1-j], z\right) \mathrm{d} \vartheta \\
& =\int_{\mathrm{SO}(n-1)} \int_{\mathbb{R}^{n-1}} \alpha(|y|) \mathrm{dMA}_{j}^{*}\left(u \square\left(v \circ \vartheta^{-1}\right) ; y\right) \mathrm{d} \vartheta \\
& \quad+\int_{\mathrm{SO}(n-1)} \int_{\mathbb{R}^{n-1}} \alpha(|y|) \mathrm{dMA}_{j}^{*}\left(\bar{u} \square\left(\bar{v} \circ \vartheta^{-1}\right) ; y\right) \mathrm{d} \vartheta \\
& =\frac{1}{\kappa_{n-1}} \sum_{i=0}^{j}\binom{j}{i} \int_{\mathbb{R}^{n-1}} \int_{\mathbb{R}^{n-1}} \alpha(\max \{|x|,|y|\}) \mathrm{dMA}_{j-i}^{*}(v ; y) \mathrm{dMA}_{i}^{*}(u ; x) \\
& \quad+\frac{1}{\kappa_{n-1}} \sum_{i=0}^{j}\binom{j}{i} \int_{\mathbb{R}^{n-1}} \int_{\mathbb{R}^{n-1}} \alpha(\max \{|x|,|y|\}) \mathrm{dMA}_{j-i}^{*}(\bar{v} ; y) \mathrm{dMA}_{i}^{*}(\bar{u} ; x) \\
& =\frac{1}{\kappa_{n-1}} \sum_{i=0}^{j}\binom{j}{i} \int_{\mathbb{S}_{-}^{n-1}} \int_{\mathbb{S}_{-}^{n-1}}\left|w_{n}\right|\left|z_{n}\right| \beta\left(\min \left\{\left|w_{n}\right|,\left|z_{n}\right|\right\}\right) \\
& \quad \mathrm{d} S\left(L[j-i], B_{H}^{n-1}[n-1-j+i], w\right) \mathrm{d} S\left(K[i], B_{H}^{n-1}[n-1-i], z\right)  \tag{6.5}\\
& \quad+\frac{1}{\kappa_{n-1}} \sum_{i=0}^{j}\binom{j}{i} \int_{\mathbb{S}_{-}^{n-1}} \int_{\mathbb{S}_{-}^{n-1}}\left|w_{n}\right|\left|z_{n}\right| \beta\left(\min \left\{\left|w_{n}\right|,\left|z_{n}\right|\right\}\right) \\
& \quad \mathrm{d} S\left(\bar{L}[j-i], B_{H}^{n-1}[n-1-j+i], w\right) \mathrm{d} S\left(\bar{K}[i], B_{H}^{n-1}[n-1-i], z\right) .
\end{align*}
$$

In the last step we used Lemma 6.1 together with the fact that $s \mapsto \sqrt{1-s^{2}} / s$ is decreasing and thus

$$
\beta(\min \{a, b\})=\alpha\left(\max \left\{\frac{\sqrt{1-a^{2}}}{a}, \frac{\sqrt{1-b^{2}}}{b}\right\}\right)
$$

for $a, b \in(0,1]$. Observe that the last integral in (6.5) can be rewritten as

$$
\begin{align*}
& \int_{\mathbb{S}_{-}^{n-1}} \int_{\mathbb{S}_{-}^{n-1}}\left|w_{n}\right|\left|z_{n}\right| \beta\left(\min \left\{\left|w_{n}\right|,\left|z_{n}\right|\right\}\right) \\
& \mathrm{d} S\left(\bar{L}[j-i], B_{H}^{n-1}[n-1-j+i], w\right) \mathrm{d} S\left(\bar{K}[i], B_{H}^{n-1}[n-1-i], z\right)  \tag{6.6}\\
&=\int_{\mathbb{S}_{+}^{n-1}} \int_{\mathbb{S}_{+}^{n-1}}\left|w_{n}\right|\left|z_{n}\right| \beta\left(\min \left\{\left|w_{n}\right|,\left|z_{n}\right|\right\}\right) \\
& \quad \mathrm{d} S\left(L[j-i], B_{H}^{n-1}[n-1-j+i], w\right) \mathrm{d} S\left(K[i], B_{H}^{n-1}[n-1-i], z\right)
\end{align*}
$$

for $0 \leq i \leq j$. Similar to the above, we obtain

$$
\begin{align*}
& \int_{\mathrm{SO}(n-1)} \int_{\mathbb{S}^{n-1}} \tilde{\beta}\left(\left|z_{n}\right|\right) \mathrm{d} S\left((K+\vartheta \bar{L})[j], B_{H}^{n-1}[n-1-j], z\right) \mathrm{d} \vartheta \\
& =\frac{1}{\kappa_{n-1}} \sum_{i=0}^{j}\binom{j}{i} \int_{\mathbb{S}_{+}^{n-1}} \int_{\mathbb{S}_{-}^{n-1}}\left|w_{n}\right|\left|z_{n}\right| \beta\left(\min \left\{\left|w_{n}\right|,\left|z_{n}\right|\right\}\right) \\
& \quad \mathrm{d} S\left(L[j-i], B_{H}^{n-1}[n-1-j+i], w\right) \mathrm{d} S\left(K[i], B_{H}^{n-1}[n-1-i], z\right)  \tag{6.7}\\
& \quad+\frac{1}{\kappa_{n-1}} \sum_{i=0}^{j}\binom{j}{i} \int_{\mathbb{S}_{-}^{n-1}} \int_{\mathbb{S}_{+}^{n-1}}\left|w_{n}\right|\left|z_{n}\right| \beta\left(\min \left\{\left|w_{n}\right|,\left|z_{n}\right|\right\}\right) \\
& \quad \mathrm{d} S\left(L[j-i], B_{H}^{n-1}[n-1-j+i], w\right) \mathrm{d} S\left(K[i], B_{H}^{n-1}[n-1-i], z\right) .
\end{align*}
$$

Thus, combining (6.5), (6.6), and (6.7), we obtain

$$
\begin{align*}
& \int_{\mathrm{SO}(n-1) \times \mathrm{O}(1)} \int_{\mathbb{S}^{n-1}} \tilde{\beta}\left(\left|z_{n}\right|\right) \mathrm{d} S\left((K+\eta L)[j], B_{H}^{n-1}[n-1-j], z\right) \mathrm{d} \eta \\
& =\frac{1}{2} \int_{\mathrm{SO}(n-1)} \int_{\mathbb{S}^{n-1}} \tilde{\beta}\left(\left|z_{n}\right|\right) \mathrm{d} S\left((K+\vartheta L)[j], B_{H}^{n-1}[n-1-j], z\right) \mathrm{d} \vartheta \\
& \quad+\frac{1}{2} \int_{\mathrm{SO}(n-1)} \int_{\mathbb{S}^{n-1}} \tilde{\beta}\left(\left|z_{n}\right|\right) \mathrm{d} S\left((K+\vartheta \bar{L})[j], B_{H}^{n-1}[n-1-j], z\right) \mathrm{d} \vartheta  \tag{6.8}\\
& =\frac{1}{2 \kappa_{n-1}} \sum_{i=0}^{j}\binom{j}{i} \int_{\mathbb{S}^{n-1}} \int_{\mathbb{S}^{n-1}}\left|w_{n}\right|\left|z_{n}\right| \beta\left(\min \left\{\left|w_{n}\right|,\left|z_{n}\right|\right\}\right) \\
& \quad \mathrm{d} S\left(L[j-i], B_{H}^{n-1}[n-1-j+i], w\right) \mathrm{d} S\left(K[i], B_{H}^{n-1}[n-1-i], z\right),
\end{align*}
$$

where we used that $\left|w_{n}\right|\left|z_{n}\right| \beta\left(\min \left\{\left|w_{n}\right|,\left|z_{n}\right|\right\}\right)=0$ if $z \in \mathbb{S}^{n-1} \cap e_{n}^{\perp}$ or $w \in \mathbb{S}^{n-1} \cap e_{n}^{\perp}$. This concludes the proof.

Arguing similarly as in the proof of Corollary 4.3, we obtain from Theorem 1.5 the following equivalent version.
Corollary 6.2. Let $n \geq 2$. If $0 \leq i \leq j \leq n-1$ and $\beta:[0,1] \rightarrow[0, \infty)$ is measurable, then

$$
\begin{aligned}
& \left.\int_{\mathrm{SO}(n-1) \times \mathrm{O}(1)} \int_{\mathbb{S}^{n-1}}\left|z_{n}\right| \beta\left(\left|z_{n}\right|\right) \mathrm{d} S\left(K_{1}, \ldots, K_{i}, \eta L_{1}, \ldots, \eta L_{j-i}\right), B_{H}^{n-1}[n-1-j], z\right) \mathrm{d} \eta \\
& =\frac{1}{2 \kappa_{n-1}} \int_{\mathbb{S}^{n-1}} \int_{\mathbb{S}^{n-1}}\left|w_{n}\right|\left|z_{n}\right| \beta\left(\min \left\{\left|w_{n}\right|,\left|z_{n}\right|\right\}\right) \mathrm{d} S\left(K_{1}, \ldots, K_{i}, B_{H}^{n-1}[n-1-i], z\right) \\
& \quad \mathrm{d} S\left(L_{1}, \ldots, L_{j-i}, B_{H}^{n-1}[n-1-j+i], w\right)
\end{aligned}
$$

for $K_{1}, \ldots, K_{i}, L_{1}, \ldots, L_{j-i} \in \mathscr{K}^{n}$.
