Mean field error estimate of the random batch method for large interacting particle system

Abstract

The random batch method (RBM) proposed in [Jin et al., J. Comput. Phys., 400(2020), 108877] for large interacting particle systems is an efficient with linear complexity in particle numbers and highly scalable algorithm for N-particle interacting systems and their mean-field limits when N is large. We consider in this work the quantitative error estimate of RBM toward its mean-field limit, the Fokker-Planck equation. Under mild assumptions, we obtain a uniform-in-time $O(\tau^2 + 1/N)$ bound on the scaled relative entropy between the joint law of the random batch particles and the tensorized law at the mean-field limit, where τ is the time step size and N is the number of particles. Therefore, we improve the existing rate in discretization step size from $O(\sqrt{\tau})$ to $O(\tau)$ in terms of the Wasserstein distance.

Keywords: relative entropy, random batch method, interacting particle system, propagation of chaos

1 Introduction

Interacting particle systems arise in a variety of important problems in physical, social, and biological sciences, for example, molecular dynamics [12], swarming [4, 6, 11, 39], chemotaxis [2, 16], flocking [1, 10, 15], synchronization [9, 14], consensus [34] and random vortex model [36]. In this paper, we consider the following general first order system of N particles:

$$dX^{i} = b(X^{i}) dt + \frac{1}{N-1} \sum_{j:j \neq i} K(X^{i} - X^{j}) dt + \sqrt{2\sigma} dW^{i}, \quad i = 1, 2, \dots, N$$
(1.1)

Here $X^i \in \mathbb{R}^d$ are the labels for particles, $b : \mathbb{R}^d \to \mathbb{R}^d$ is the drift force, $K : \mathbb{R}^d \to \mathbb{R}^d$ is the interaction kernel, $\sigma > 0$ is the diffusion coefficient and W^i are N independent ddimensional Wiener processes (standard Brownian motions). We assume that the initial values $X^i(0) := X_0^i$ are drawn independently from the same distribution ρ_0 .

As is well known, under certain conditions, the mean field limit (i.e., $N \to \infty$) of (1.1) is given by the following nonlinear Fokker-Planck equation:

$$\partial_t \rho = -\nabla \cdot \left((b(x) + K * \rho)\rho \right) + \sigma \Delta \rho, \tag{1.2}$$

where $\rho(t, x)$ is the particle density distribution. The convergence of the interacting particle system (1.1) towards the Fokker-Planck equation (1.2) as $N \to \infty$ has been systemically studied in [27, 33, 18, 13, 7, 8].

If one numerically discretizes (1.1) directly, the computational cost per time step is $O(N^2)$, which is prohibitively expensive for large N. The Random Batch Method (RBM) proposed in [22] is a simple and generic random algorithm to reduce the computation cost per time step from $O(N^2)$ to O(N). The idea was to utilize small but random batch, so that interactions only occur inside the small batches at each time step. This random mini batch idea was the key component of the so-called stochastic gradient descent (SGD) [37, 3] in machine learning. Due to the simplicity and scalability, it already has a variety of applications in solving the Poisson-Nernst-Planck, Poisson-Boltzmann and Fokker-Planck-Landau equations [29, 5], efficient sampling [31], molecular simulation [24, 32], and quantum Monte-Carlo method [26]. Readers can refer to the review article [20].

The RBM algorithm corresponding to (1.1) is given in Algorithm 1. Suppose one aims to do the simulation until time T > 0. One first chooses a time step $\tau > 0$ and a batch size $p \ll N, p \ge 2$ that divides N. Define the discrete time $t_k := k\tau, k \in \mathbb{N}$. For each time subinterval $[t_{k-1}, t_k)$, there are two steps: (1) at time t_{k-1} , one divides the N particles into n := N/p groups (batches) randomly; (2) the particles evolve with interaction inside the batches only.

Algorithm 1 The Random Batch Method (RBM)

1: for $k = 1 : [T/\tau]$ do

- 2: Divide $\{1, 2, ..., N\}$ into n = N/p batches randomly.
- 3: for each batch ξ_k do
- 4: Update \overline{X}^i 's $(i \in \xi_k)$ by solving the following stochastic differential equation (SDE) with $t \in [t_{k-1}, t_k)$:

$$d\bar{X}^{i} = b\left(\bar{X}^{i}\right)dt + \frac{1}{p-1}\sum_{j\in\xi_{k}, j\neq i}K\left(\bar{X}^{i} - \bar{X}^{j}\right)dt + \sqrt{2\sigma}dW^{i}.$$

The RBM is not only an efficient numerical method for approximating the original particle system (1.1), but also, when N is large, a numerical particle method for the Fokker-Planck equation (1.2). The goal of this paper is to provide an explicit bound $O(\tau^2 + 1/N)$ of the rescaled relative entropy between the random batch system (1.3) and the Fokker-Planck equation (1.2), as given in Theorem 4.1. More precisely, denote

$$\bar{\rho}_t^N = \operatorname{Law}(\bar{X}_t^1, \cdots, \bar{X}_t^N),$$

here $\bar{X}_t^1, \dots, \bar{X}_t^N$ are the continuous version of the random batch particles defined below, which coincide with the Euler-Maruyama discretization of (1.3) at time T_k :

$$\bar{X}_{t}^{i} = \bar{X}_{T_{k}}^{i} + (t - T_{k})b\left(\bar{X}_{T_{k}}^{i}\right) + \frac{(t - T_{k})}{p - 1} \sum_{j \in \xi_{k}} K(\bar{X}_{T_{k}}^{i} - \bar{X}_{T_{k}}^{j}) + \sqrt{2\sigma}(W_{t}^{i} - W_{T_{k}}^{i}), \quad t \in [T_{k}, T_{k+1}).$$

$$(1.4)$$

Set

$$\rho_t^N\left(x_1,\ldots,x_N\right) = \rho_t^{\otimes N}$$

where ρ_t is the solution to the mean field Fokker-Planck equation (1.2). In this paper, we will prove the following uniform-in-time relative entropy bound

$$\sup_{t} \mathcal{H}_{N}\left(\bar{\rho}_{t}^{N} \mid \rho_{t}^{N}\right) \leq \mathcal{H}_{N}\left(\bar{\rho}_{0}^{N} \mid \rho_{0}^{N}\right) + c_{1}\tau^{2} + \frac{c_{2}}{N},\tag{1.5}$$

where the constants c_1 and c_2 are independent of N. Here,

$$\mathcal{H}_{N}\left(\bar{\rho}_{t}^{N} \mid \rho_{t}^{N}\right) = \frac{1}{N} \int_{\mathbb{R}^{dN}} \bar{\rho}_{t}^{N}\left(\mathbf{x}\right) \log \frac{\bar{\rho}_{t}^{N}\left(\mathbf{x}\right)}{\rho_{t}^{N}\left(\mathbf{x}\right)} d\mathbf{x},$$

is the rescaled relative entropy.

Our proof consists of the following ingredients. Firstly, we study the time evolution of the relative entropy of the joint law and the tensorized law based on the Markov property of the discrete random batch. In order to do so, like [30], we derive a Liouville equation for the joint law for the fixed batch version of the RBM, where the drift term is the backward conditional expectation at the previous step, conditioned on the current value of N particles. Then one can define the joint law of some given ξ_k , namely $\bar{\varrho}_t^{N,\xi_k}$ by the Markov property. Since

$$\bar{\varrho}_t^N = \mathbb{E}_{\xi_k} \left[\bar{\varrho}_t^{N, \xi_k} \right],$$

therefore one can obtain the desired time evolution equation. Secondly, during the proof, like in [30], techniques including integration by parts (to eliminate the Gaussian noise that would possibly lower the convergence rate) and the Girsanov transform are used. We also obtain the estimate of the Fisher information for the joint law of the fixed batch version of the RBM, as was done in [35]. Thirdly, we use the Law of Large Number at the exponential scale as in [19].




Figure 1: Illustration of the various equations.

Several systems will be involved for our analysis. For clarity, in Fig.1, we depict the relationships between these systems.

Recently, there have been some theoretical results on the random batch method. The strong and weak error analysis for the RBM has been conducted in [23] and they show that the strong error is of $O(\sqrt{\tau})$ while the weak error is of $O(\tau)$ for interacting particles with disparate species and weights. Moreover, the theoretical justification for the sampling accuracy is done in [25] and they give the geometric ergodicity and the long time behavior of the RBM for interacting particle systems. They show that the Wasserstein distance between the invariant distributions of the interacting particle systems and the random batch interacting particle systems is bounded by $O(\sqrt{\tau})$. Besides, the error estimate and the longtime behavior of the discrete time approximation of random batch method was studied in [41] using the triangle inequality framework, and still an $O(\sqrt{\tau})$ bound is obtained. We note that the order of accuracy in the time step τ may not be optimal in the work [25, 41]. This is because they used the strong error estimate of RBM. The novelty of our result is to go beyond the existing strong error of RBM. We analyze the law of RBM at the level of the Liouville equation, enabling us to improve the order of convergence. It is worth mentioning that [21] also investigates the mean field limit of RBM, which gives rise to a mean field limit for p-body particle systems, unlike the classical one-body mean field limit for interacting particle systems. Our work can be seen as an extension and improvement of the work [21]. More precisely, unlike the propagation of chaos in the classical mean field limit for interacting particle systems, the chaos in [21] is imposed at every discrete time. In other words, their argument of the mean field limit relies on the fact that two particles are unlikely to be related in RBM when $N \to \infty$ for finite iterations. Our results provide a uniform-in-time explicit error estimate between system (1.3) and the mean-field limit (1.2)and directly prove the classical propagation of chaos for RBM.

The rest of the paper is organized as follows. We first introduce some preliminaries in Section 2 including the Euler-Maruyama discretization of random batch and the Liouville equation for the joint law for the case of the fixed batch size. In Section 3, we present some auxiliary results which are useful in the proof of the main results. In Section 4, we present the main result: the uniform-in-time estimate of the relative entropy between the joint law of the random batch particles and the tensorized law for the limit equation (the Fokker-Planck equation) and provide the detailed proof. Some technical details that are not so essential are moved to Appendix B.

$\mathbf{2}$ **Preliminaries**

2.1Discrete random batch

For the convenience of the analysis, we define

$$K^{\xi_k}(\bar{X}^i_t) = \frac{1}{p-1} \sum_{j \in \xi_k, j \neq i} K(\bar{X}^i_t - \bar{X}^j_t), \quad t \in [T_k, T_{k+1}).$$
(2.1)

Consider the Euler-Maruyama scheme with constant time step for (1.1):

$$X_{T_{k+1}}^{i} = X_{T_{k}}^{i} + \tau b(X_{T_{k}}^{i}) + \frac{\tau}{N-1} \sum_{j:j \neq i} K(X_{T_{k}}^{i} - X_{T_{k}}^{j}) + \sqrt{2\sigma} \left(W_{T_{k+1}}^{i} - W_{T_{k}}^{i}\right).$$
(2.2)

Similarly, the Euler-Maruyama scheme for the RBM with time step τ at the k-th iteration for the *i*-th particle is:

$$\bar{X}_{T_{k+1}}^{i} = \bar{X}_{T_{k}}^{i} + \tau b\left(\bar{X}_{T_{k}}^{i}\right) + \tau K^{\xi_{k}}(\bar{X}_{T_{k}}^{i}) + \sqrt{2\sigma}\left(W_{T_{k+1}}^{i} - W_{T_{k}}^{i}\right),$$
(2.3)

with $T_k := k\tau$. Here, ξ_k are i.i.d. sampled. Also we consider the following continuous version which coincides with the discrete RBM at grid point T_k :

$$\bar{X}_{t}^{i} = \bar{X}_{T_{k}}^{i} + (t - T_{k})b\left(\bar{X}_{T_{k}}^{i}\right) + (t - T_{k})K^{\xi_{k}}(\bar{X}_{T_{k}}^{i}) + \sqrt{2\sigma}(W_{t}^{i} - W_{T_{k}}^{i}), \quad t \in [T_{k}, T_{k+1}).$$
(2.4)

Denote

$$\bar{\mathbf{X}}_{T_k} = (\bar{X}_{T_k}^1, \cdots, \bar{X}_{T_k}^N)^T \in \mathbb{R}^{Nd},$$

then the Euler-Maruyama scheme for the RBM for N particles with time step τ at the k-th iteration can be written as:

$$\bar{\mathbf{X}}_{T_{k+1}} = \bar{\mathbf{X}}_{T_k} + \tau \mathbf{b}(\bar{\mathbf{X}}_{T_k}) + \tau \mathbf{K}^{\xi_k}(\bar{\mathbf{X}}_{T_k}) + \sqrt{2\sigma} \left(\mathbf{W}_{T_{k+1}} - \mathbf{W}_{T_k} \right),$$
(2.5)

where

$$\mathbf{b}(\bar{X}_{T_k}) = \left(b\left(\bar{\mathbf{X}}_{T_k}^1\right), \cdots, b\left(\bar{X}_{T_k}^N\right)\right)^T \in \mathbb{R}^{Nd};$$
(2.6)

$$\mathbf{K}^{\xi_k}(\bar{\mathbf{X}}_{T_k}) = \left(K^{\xi_k}(\bar{X}_{T_k}^1), \cdots, K^{\xi_k}(\bar{X}_{T_k}^N)\right)^T \in \mathbb{R}^{Nd},\tag{2.7}$$

and $\mathbf{Z}_k \sim N(0, I_{Nd})$. At time t, the continuous version for N particles at grid point T_k (2.4) can be written as:

$$\bar{\mathbf{X}}_t = \bar{\mathbf{X}}_{T_k} + (t - T_k)\mathbf{b}(\bar{\mathbf{X}}_{T_k}) + (t - T_k)\mathbf{K}^{\xi_k}(\bar{\mathbf{X}}_{T_k}) + \sqrt{2\sigma}\left(\mathbf{W}_t - \mathbf{W}_{T_k}\right), \qquad (2.8)$$

where $\mathbf{W}_t = (W_t^1, \dots, W_t^N)^T$. We refer (2.5) as the discrete-RBM (or fixed batch size RBM), abbreviated as **d-RBM** and (2.8) as the continuous-RBM, abbreviated as **c-RBM**.

Furthermore, denote the N particle joint law of $\bar{\mathbf{X}}_t$ by $\bar{\rho}_t^N$. Following the basic approach introduced in [17, 19], our main idea is to use the relative entropy methods to compare the joint law $\bar{\rho}_t^N(x_1,\ldots,x_N)$ of the c-RBM (2.8) to the tensorized law

$$\rho_t^N(x_1,\ldots,x_N) = \rho^{\otimes N} = \prod_{i=1}^N \rho_t^i(x_i),$$

consisting of N independent copies of a process following the law ρ , solution to the mean-field limit equation, the Fokker-Planck equation (1.2). One can readily check that ρ_t^N solves

$$\partial_t \rho_t^N + \sum_{i=1}^N \operatorname{div}_{x_i} \left(\rho_t^N \left(b(x_i) + K * \rho_t(x_i) \right) \right) = \sum_{i=1}^N \sigma \Delta_{x_i} \rho_t^N.$$
(2.9)

Our method revolves around the control of the rescaled relative entropy

$$\mathcal{H}_{N}\left(\bar{\rho}_{t}^{N} \mid \rho_{t}^{N}\right) = \frac{1}{N} \int_{\mathbb{R}^{dN}} \bar{\rho}_{t}^{N}\left(\mathbf{x}\right) \log \frac{\bar{\rho}_{t}^{N}\left(\mathbf{x}\right)}{\rho_{t}^{N}\left(\mathbf{x}\right)} d\mathbf{x},$$

where $\mathbf{x} = (x_1, \dots, x_N)^T$. The proof of our main results is based on the Markov property of the d-RBM. More precisely, let $\bar{\varrho}_t^{N,\boldsymbol{\xi}}$ be the probability density of c-RBM (2.8) for a given sequence of batches $\boldsymbol{\xi} := (\xi_0, \xi_1, \dots, \xi_k, \dots)$. Consequently, we have the following expression of the density:

$$\bar{\rho}_t^N(\mathbf{x}) = \mathbb{E}_{\boldsymbol{\xi}} \left[\bar{\varrho}_t^{N, \boldsymbol{\xi}}(\mathbf{x}) \right].$$

Here, $\mathbb{E}_{\boldsymbol{\xi}}\left[\bar{\varrho}_t^{N,\boldsymbol{\xi}}(\cdot)\right]$ means taking expectation for all possible choice of batch $\boldsymbol{\xi}$. Note that $\bar{\varrho}_t^{N,\boldsymbol{\xi}}$ is consistent with an analogue of the Liouville equation, whose explicit expression will be given in Lemma 2.1.

2.2 An analogue of the Liouville equation

Consider the c-RBM (2.8). Our goal is to prove that the probability density of the continuous version satisfies an analogue of the Liouville equation with time-varying drift terms.

Lemma 2.1. Denote by $\bar{\varrho}_t^{N,\xi}$ the probability density function of $\bar{\mathbf{X}}_t = (\bar{X}_t^1, \cdots, \bar{X}_t^N)$ defined in (2.8) for $t \in [T_k, T_{k+1})$. Then the following Liouville equation holds:

$$\partial_t \bar{\varrho}_t^{N,\boldsymbol{\xi}} + \sum_{i=1}^N \operatorname{div}_{x_i} \left(\bar{\varrho}_t^{N,\boldsymbol{\xi}} \left(\hat{b}_t^{\boldsymbol{\xi},i} \left(\boldsymbol{x} \right) + \hat{K}_t^{\boldsymbol{\xi},i} \left(\boldsymbol{x} \right) \right) \right) = \sum_{i=1}^N \sigma \Delta_{x_i} \bar{\varrho}_t^{N,\boldsymbol{\xi}}, \tag{2.10}$$

where

$$\hat{b}_{t}^{\boldsymbol{\xi},i}\left(\boldsymbol{x}\right) = \mathbb{E}\left[b\left(\bar{X}_{T_{k}}^{i}\right) \mid \bar{\boldsymbol{X}}_{t} = \boldsymbol{x}, \boldsymbol{\xi}\right], \quad t \in \left[T_{k}, T_{k+1}\right), \quad (2.11)$$

and

$$\hat{K}_{t}^{\boldsymbol{\xi},i}\left(\boldsymbol{x}\right) := \mathbb{E}\left[K^{\boldsymbol{\xi}_{k}}\left(\bar{X}_{T_{k}}^{i}\right) \mid \bar{\boldsymbol{X}}_{t} = \boldsymbol{x}, \boldsymbol{\xi}\right], \quad t \in [T_{k}, T_{k+1}).$$

$$(2.12)$$

Here, $\boldsymbol{x} = (x_1, \cdots, x_n) \in \mathbb{R}^{Nd}$.

The derivation is not difficult and has appeared in many previous work [30, 35]. For the convenince of the readers, we also attach a proof in Appendix A.

2.3 Assumptions

Before the main results and proofs, we firstly give the following assumptions we use throughout this paper.

Assumption 2.1. (a) The field b: $\mathbb{R}^d \to \mathbb{R}^d$ and the interaction kernel K are Lipshitz:

$$|b(x_1) - b(x_2)| \le r |x_1 - x_2|, \quad |K(x) - K(y)| \le L|x - y|.$$

(b) The field b is strongly confining in the sense that there exists two constants α and β such that for any $x_1 \neq x_2$, :

$$(x_1 - x_2) \cdot (b(x_1) - b(x_2)) \le \alpha - \beta |x_1 - x_2|^2$$

for some constant $\beta > 0$ and $\beta > 2L$.

(c) Moreover, the Hessians of b and K have at most polynomial growth, namely,

$$|\nabla^2 b(x)| \le C(1+|x|)^q, \quad |\nabla^2 K(x)| \le \tilde{C}(1+|x|)^q.$$

(d) $K^{\xi} - F$ is uniformly bounded, namely,

$$\operatorname{esssup}_{\xi} \| K^{\xi} - F \|_{L^{\infty}(\mathbb{R}^d)} < +\infty,$$

where $F(x_i) = \frac{1}{N} \sum_{j=1}^{N} K(x_i - x_j).$

The confining property of b holds if there exists a compact set $S \subset \mathbb{R}^d$ such that for any $x_1, x_2 \notin S$, it holds that:

$$(x_1 - x_2) \cdot (b(x_1) - b(x_2)) \le -\beta |x_1 - x_2|^2.$$

By definition, K^{ξ} satisfies the same conditions as those for K for any ξ .

3 Some auxiliary results

3.1 The Log-Sobolev inequality

In this paper, we obtain the uniform in time estimate under an additional assumption of a log-Sobolev inequality (LSI) for ρ_t , uniformly in t. We remark that such assumption is a common ingredient in the proof of uniform-in-time propagation of chaos, see also the recent paper [28].

Assumption 3.1. The Log-Sobolev inequality (LSI): There exists a constant $C_{LS} > 0$ such that for any nonnegative smooth functions f, one has

$$\operatorname{Ent}_{\rho_t}(f) := \int f \log f d\rho_t - \left(\int f d\rho_t\right) \log\left(\int f d\rho_t\right) \le C_{LS} \int \frac{|\nabla f|^2}{f} d\rho_t.$$
(3.1)

One crucial property of the LSI is the tensorization, i.e. if ρ_t satisfies a LSI then $\rho_t^N = \rho_t^{\otimes^N}$ satisfies the same inequality with the same constant (and thus independent of N).

3.2 Moment control

In this section, we aim to find a uniform-in-time bound for the moments $\mathbb{E} \left| \bar{X}_t^i \right|^p$. We have the following fact. The proof is similar to [21], so we omit it.

Lemma 3.1. Under Assumption 2.1, for any p > 2, there exists a constant C_p independent of N and ξ such that for any i

$$\sup_{t \ge 0} \mathbb{E}\left[\left| \bar{X}_t^i \right|^p \mid \mathcal{F}_{\xi} \right] \le C_p, \tag{3.2}$$

where \mathcal{F}_{ξ} denotes the σ -algebra generated by sequence ξ .

The above result indicates that for a fixed sequence of divisions of random batches $\xi = (\xi_k)_{k\geq 0}$, the *p*th moment of \bar{X}_t^i is bounded by C_p independent of ξ . We remark that using the moment control, we can bound terms like $b(\bar{X}_t^i)$ and $K^{\xi}(\bar{X}_t^i)$ which can be found in the proof Theorem 4.1.

3.3 Estimate of the Fisher information

The Fisher information for a probability measure ρ is defined by

$$\mathcal{I}(\rho) = \int \left| \nabla \log \rho \right|^2 \rho dx.$$
(3.3)

In our analysis, we require a bound for the Fisher information of $\bar{\varrho}_{T_k}^{N,\boldsymbol{\xi}}$, which is the law of RBM for a given sequence of batches $\boldsymbol{\xi} = (\xi_0, \dots, \xi_k, \dots)$ at grid point T_k . Our proof is based on Stam's convolution inequality for Fisher information [38, Eq. (2.9)]. This inequality guarantees that for any pair of suitably regular probability density functions p, q on \mathbb{R}^d , the Fisher information satisfies the inequality

$$\frac{1}{\mathcal{I}(p*q)} \ge \frac{1}{\mathcal{I}(p)} + \frac{1}{\mathcal{I}(q)},\tag{3.4}$$

where p * q denotes the convolution of p and q. The d-RBM (2.5) for N particles at time T_{k+1} can be seen as a combination of applying the deterministic mapping

$$\psi_{\tau}^{\xi_k}(\mathbf{x}) := \mathbf{x} + \tau \left(\mathbf{b}(\mathbf{x}) + \mathbf{K}^{\xi_k}(\mathbf{x}) \right), \quad \mathbf{x} = (x_1, \cdots, x_n) \in \mathbb{R}^{Nd}, \tag{3.5}$$

with a convolution step with a Gaussian kernel, where **b** and \mathbf{K}^{ξ_k} are defined as (2.6) and (2.7) respectively. More precisely,

$$\mathbf{b}(\mathbf{x}) = (b(x_1), \cdots, b(x_n))^T \in \mathbb{R}^{Nd},$$

and

$$\mathbf{K}^{\xi_k}(\mathbf{x}) = \left(K^{\xi_k}(x_1), \cdots, K^{\xi_k}(x_n) \right)^T \in \mathbb{R}^{Nd}.$$

We exploit the inequality (3.4) so as to bound the Fisher information $\mathcal{I}(\bar{\varrho}_{T_{k+1}}^{N,\boldsymbol{\xi}})$ in terms of $\mathcal{I}(\bar{\varrho}_{T_k}^{N,\boldsymbol{\xi}})$. In order to do so, we bound the Fisher information for the intermediate density after the first step.

Lemma 3.2. For some step size $\tau < \frac{1}{2(r+L)}$, let $p_k(\cdot)$ be the density of the random variable $\mathbf{Z}_k = \psi_{\tau}^{\xi_k}(\bar{\mathbf{X}}_{T_k})$ obtained by applying the deterministic mapping $\psi_{\tau}^{\xi_k}$. Then under Assumption 2.1, we have the bound

$$\mathcal{I}(p_k) \le \frac{1 + \tau(r+L)}{1 - \tau(r+L)} \left(\mathcal{I}(\bar{\varrho}_{T_k}^{N,\boldsymbol{\xi}}) + \frac{M(r+L)N\tau}{1 - \tau(r+L)} \right),$$
(3.6)

where M is a constant independent of N.

Proof. Consider the norm of \mathbf{x} defined as $\|\mathbf{x}\|^2 = \sum_i^n \|x_i\|_2^2$. Then, Assumption 2.1 implies that for $\tau < \frac{1}{r+L}$, the mapping $\psi_{\tau}^{\xi_k}(\mathbf{x}) := \mathbf{x} + \tau \left(\mathbf{b}(\mathbf{x}) + \mathbf{K}^{\xi_k}(\mathbf{x}) \right)$ is a bi-Lipschitz mapping, i.e.

$$(1 - \tau(r+L)) \|\mathbf{x} - \mathbf{y}\| \le \|\psi_{\tau}^{\xi_k}(\mathbf{x}) - \psi_{\tau}^{\xi_k}(\mathbf{y})\| \le (1 + \tau(r+L)) \|\mathbf{x} - \mathbf{y}\|,$$

the one deduces that

from which one deduces that

$$\|\nabla\psi_{\tau}^{\xi_{k}}(\mathbf{x})\| \leq (1 + \tau(r+L)), \quad \|\nabla\psi_{\tau}^{\xi_{k}}(\mathbf{x})^{-1}\| \leq (1 - \tau(r+L))^{-1}.$$
(3.7)

By the change of variable formula, we have

$$p_k(\mathbf{z}) = \frac{\bar{\varrho}_{T_k}^{N,\boldsymbol{\xi}}(\mathbf{x})}{\det(\nabla \psi_{\tau}^{\boldsymbol{\xi}_k}(\mathbf{x}))}$$

Consequently, we have the bound on the Fisher information:

$$\begin{split} \mathcal{I}(p_k) &= \int_{\mathbb{R}^{Nd}} p_k(\mathbf{z}) \left| \nabla_{\mathbf{z}} \log p_k(\mathbf{z}) \right|^2 d\mathbf{z} \\ &= \int_{\mathbb{R}^{Nd}} \bar{\varrho}_{T_k}^{N,\boldsymbol{\xi}}(\mathbf{x}) \left| \nabla \psi_{\tau}^{\xi_k}(\mathbf{x})^{-1} \left(\nabla_{\mathbf{x}} \log \bar{\varrho}_{T_k}^{N,\boldsymbol{\xi}}(\mathbf{x}) - \nabla_{\mathbf{x}} \log \det \left(\nabla \psi_{\tau}^{\xi_k}(\mathbf{x}) \right) \right) \right|^2 d\mathbf{x} \\ &\leq (1 + \tau(r+L)) \int_{\mathbb{R}^{Nd}} \bar{\varrho}_{T_k}^{N,\boldsymbol{\xi}}(\mathbf{x}) \left| \nabla \psi_{\tau}^{\xi_k}(\mathbf{x})^{-1} \nabla_{\mathbf{x}} \log \bar{\varrho}_{T_k}^{N,\boldsymbol{\xi}}(\mathbf{x}) \right|^2 d\mathbf{x} \\ &+ \left(1 + \frac{1}{\tau(r+L)} \right) \int_{\mathbb{R}^{Nd}} \bar{\varrho}_{T_k}^{N,\boldsymbol{\xi}}(\mathbf{x}) \left| \nabla \psi_{\tau}^{\xi_k}(\mathbf{x})^{-1} \nabla_{\mathbf{x}} \log \det \left(\nabla \psi_{\tau}^{\xi_k}(\mathbf{x}) \right) \right|^2 d\mathbf{x} =: I_1 + I_2 \end{split}$$

The inequality follows from the simple fact $(a+b)^2 \leq (1+\lambda)a^2 + (1+\frac{1}{\lambda})b^2$. It is clear that

$$I_1 \leq \frac{1 + \tau(r+L)}{1 - \tau(r+L)} \int_{\mathbb{R}^{Nd}} \bar{\varrho}_{T_k}^{N,\boldsymbol{\xi}}(\mathbf{x}) \left| \nabla \log \bar{\varrho}_{T_k}^{N,\boldsymbol{\xi}}(\mathbf{x}) \right|^2 d\mathbf{x} = \frac{1 + \tau(r+L)}{1 - \tau(r+L)} \mathcal{I}(\bar{\varrho}_{T_k}^{N,\boldsymbol{\xi}}).$$

The second term can be estimated by

$$\begin{split} I_{2} &\leq \frac{2}{\tau(r+L)} \int_{\mathbb{R}^{Nd}} \bar{\varrho}_{T_{k}}^{N,\boldsymbol{\xi}}(\mathbf{x}) \left| \nabla \psi_{\tau}^{\xi_{k}}(\mathbf{x})^{-2} \nabla \cdot \left(I_{Nd} + \tau \nabla \mathbf{b}(\mathbf{x}) + \tau \nabla \mathbf{K}^{\xi_{k}}(\mathbf{x}) \right) \right|^{2} d\mathbf{x} \\ &\leq \frac{(1+\tau(r+L))\tau}{(1-\tau(r+L))^{2}(r+L)} \int_{\mathbb{R}^{Nd}} \bar{\varrho}_{T_{k}}^{N,\boldsymbol{\xi}}(\mathbf{x}) \left| \nabla \cdot \left(\nabla \mathbf{b}(\mathbf{x}) + \nabla \mathbf{K}^{\xi_{k}}(\mathbf{x}) \right) \right|^{2} d\mathbf{x} \\ &\leq \frac{(1+\tau(r+L))N\tau}{(1-\tau(r+L))^{2}} \frac{M}{r+L}, \end{split}$$

where the last inequality above is due to the polynomial growth of the Hessians and the boundness of the moments, and M is a constant independent of N.

Let q_{τ} denote the *Nd*-dimensional Gaussian distribution $\mathcal{N}(0, 2\sigma\tau\mathbf{I}_{Nd})$. Clearly we have the identity $\mathcal{I}(q_{\tau}) = \frac{Nd}{2\sigma\tau}$. By the d-RBM (2.5), we have that $\bar{\varrho}_{T_{k+1}}^{N,\boldsymbol{\xi}} = p_k(\mathbf{x}) * q_{\tau}$, Invoking the convolution inequality (3.4), for $\tau < \frac{1}{2(r+L)}$, we have the bound

$$\frac{1}{\mathcal{I}\left(\bar{\varrho}_{T_{k+1}}^{N,\boldsymbol{\xi}}\right)} \geq \frac{1}{\mathcal{I}\left(p_{k}\right)} + \frac{1}{\mathcal{I}\left(q_{\tau}\right)} \geq \frac{(1-\tau(r+L))^{2}}{1+\tau(r+L)} \frac{1}{\max(\mathcal{I}\left(\bar{\varrho}_{T_{k}}^{N,\boldsymbol{\xi}}\right),MN)} + \frac{2\sigma\tau}{Nd}.$$
 (3.8)

Let $u_k = \frac{1}{\mathcal{I}(\bar{\varrho}_{T_k}^{N,\boldsymbol{\xi}})}$. Then, one has a relation like

$$u_{k+1} \ge \min(\gamma u_k + \delta, \gamma B + \delta)$$

where $\gamma = (1 - \tau(r + L))^2 / (1 + \tau(r + L))$, $B = \frac{1}{MN}$ and $\delta = \frac{2\sigma\tau}{Nd}$. For this recursion, one easily obtains

$$u_k \ge \min\left(u_0, \gamma B + \delta, \frac{\delta}{1-\gamma}\right),$$

because $u < \gamma u + \delta$ for $u < \delta/(1-\gamma)$ and $u > \gamma u + \delta$ for $u > \delta/(1-\gamma)$.

Consequently, one can obtain the following control for the Fisher information. The upper bound clearly scales linearly with N.

Lemma 3.3. Under Assumption 2.1, we have the following bound of the Fisher information independent of the batch $\boldsymbol{\xi} = (\xi_0, \dots, \xi_k, \dots)$:

$$\mathcal{I}\left(\bar{\varrho}_{T_{k}}^{N,\boldsymbol{\xi}}\right) \leq \max\left(\mathcal{I}\left(\rho_{0}^{N}\right), \frac{1+\tau(r+L)}{(1-\tau(r+L))^{2}}MN, \frac{Nd(r+L)(3+\tau(r+L))}{2\sigma}\right).$$
(3.9)

4 The main results

Equipped with the preparation work before, we now establish an $O(\tau^2)$ error estimate for RBM in terms of the scaled relative entropy. Firstly, we notice that the d-RBM (2.5) at discrete time points is a time homogeneous Markov chain, and $\bar{\rho}_{T_k}^N$ is the law at T_k . Recall that $\bar{\varrho}_t^{N,\boldsymbol{\xi}}$ is the probability density of the c-RBM (2.8) for a given sequence of batches $\boldsymbol{\xi} := (\xi_0, \xi_1, \cdots, \xi_k, \cdots)$, so that $\bar{\rho}_{T_k}^N = \mathbb{E}_{\boldsymbol{\xi}} \left[\bar{\varrho}_{T_k}^{N,\boldsymbol{\xi}} \right]$. Moreover, by the Markov property, we are able to define

$$\bar{\rho}_t^{N,\xi_k} := \mathbb{E}\left[\bar{\varrho}_t^{N,\boldsymbol{\xi}} \mid \xi_i, i \ge k\right] = \mathcal{S}_{T_k,t}^{N,\xi_k} \bar{\rho}_{T_k}^N, \quad t \in [T_k, T_{k+1}),$$
(4.1)

where the operator $S_{T_k,t}^{N,\xi_k}$ is the evolution operator from T_k to t for the Liouville equation of the c-RBM (2.8) derived in Lemma 2.1, for some given ξ_k :

$$\partial_t \bar{\rho}_t^{N,\xi_k} + \sum_{i=1}^N \operatorname{div}_{x_i} \left(\bar{\rho}_t^{N,\xi_k} \left(\bar{b}_t^{\xi_k,i} \left(\mathbf{x} \right) + \bar{K}_t^{\xi_k,i} \left(\mathbf{x} \right) \right) \right) = \sum_{i=1}^N \sigma \Delta_{x_i} \bar{\rho}_t^{N,\xi_k}, \quad \bar{\rho}_{T_k}^{N,\xi_k} = \bar{\rho}_{T_k}^N, \quad (4.2)$$

where

$$\bar{b}_{t}^{\xi_{k},i}\left(\mathbf{x}\right) := \mathbb{E}\left[b\left(\bar{X}_{T_{k}}^{i}\right) \mid \bar{\mathbf{X}}_{t} = \mathbf{x}, \xi_{k}\right], \quad t \in \left[T_{k}, T_{k+1}\right),$$

and

$$\bar{K}_{t}^{\xi_{k},i}\left(\mathbf{x}\right) := \mathbb{E}\left[K^{\xi_{k}}\left(\bar{X}_{T_{k}}^{i}\right) \mid \bar{\mathbf{X}}_{t} = \mathbf{x}, \xi_{k}\right], \quad t \in [T_{k}, T_{k+1}).$$

Here, $\bar{b}_t^{\xi_k,i}(\mathbf{x})$ and $\bar{K}_t^{\xi_k,i}(\mathbf{x})$, the expectation conditional on the k-th batch ξ_k , are a little bit different from (2.11) and (2.12) which are the expectation conditional on all fixed batch $\boldsymbol{\xi} = (\xi_0, \dots, \xi_k, \dots)$.

Since for $t \in [T_k, T_{k+1})$,

$$\bar{\rho}_t^N = \mathbb{E}_{\xi_k} \left[\bar{\rho}_t^{N,\xi_k} \right],$$

then by (4.2) one gets

$$\partial_t \bar{\rho}_t^N = -\sum_{i=1}^N \mathbb{E}_{\xi_k} \left[\operatorname{div}_{x_i} \left(\bar{\rho}_t^{N,\xi_k} \left(\bar{b}_t^{\xi_k,i} \left(\mathbf{x} \right) + \bar{K}_t^{\xi_k,i} \left(\mathbf{x} \right) \right) \right) + \sigma \Delta_{x_i} \bar{\rho}_t^{N,\xi_k} \right].$$
(4.3)

Theorem 4.1. Consider the joint law $\bar{\rho}_t^N$ for N particle $\bar{\rho}_t^N$ defined in (2.8) and the tensorized law ρ_t^N of the Fokker-Plank equation (1.2). Suppose $\sigma > 0$, then under Assumptions 2.1 and 3.1, there exist positive constants c_1 , c_2 and Δ independent of N and t but dependent on σ , such that for all $\tau \in (0, \Delta)$,

$$\sup_{t} \mathcal{H}_{N}\left(\bar{\rho}_{t}^{N} \mid \rho_{t}^{N}\right) \leq \mathcal{H}_{N}\left(\bar{\rho}_{0}^{N} \mid \rho_{0}^{N}\right) + c_{1}\tau^{2} + \frac{c_{2}}{N}.$$
(4.4)

It is well-known that one can bound the Wasserstein-1 distance with square root of the relative entropy by the Csiszár-Kullback-Pinsker inequality, see for instance [40].

Corollary 4.1. Under the same assumptions as in Theorem 4, the following hold:

$$W_1\left(\bar{\rho}_t^N, \rho_t^N\right) \le C_1 \tau + \frac{C_2}{\sqrt{N}}.$$

Here the constants C_1, C_2 are independent of N and t.

Proof of Theorem 4. We prove this result in six main steps.

Step 1: Estimate time derivative of the relative entropy.

By using the equations (2.9) and (4.3) for ρ_t^N and $\bar{\rho}_t^N$, respectively, we calculate the time derivative of the relative entropy in the time interval $[T_k, T_{k+1})$:

$$\frac{d}{dt}\mathcal{H}_{N}\left(\bar{\rho}_{t}^{N}\mid\rho_{t}^{N}\right) = \frac{1}{N}\int_{\mathbb{R}^{Nd}}\left(\partial_{t}\bar{\rho}_{t}^{N}\right)\left(\log\frac{\bar{\rho}_{t}^{N}}{\rho_{t}^{N}}+1\right)d\mathbf{x} + \frac{1}{N}\int_{\mathbb{R}^{Nd}}\left(\partial_{t}\rho_{t}^{N}\right)\left(-\frac{\bar{\rho}_{t}^{N}}{\rho_{t}^{N}}\right)d\mathbf{x}$$

$$=\frac{1}{N}\sum_{i=1}^{N}\int_{\mathbb{R}^{Nd}}\left(\mathbb{E}_{\xi_{k}}\left(\bar{\rho}_{t}^{N,\xi_{k}}\left(\bar{b}_{t}^{\xi_{k},i}(\mathbf{x})+\bar{K}_{t}^{\xi_{k},i}(\mathbf{x})\right)\right)-\sigma\operatorname{div}_{x_{i}}\bar{\rho}_{t}^{N}\right)\cdot\left(\nabla_{x_{i}}\log\frac{\bar{\rho}_{t}^{N}}{\rho_{t}^{N}}\right)d\mathbf{x} \quad (4.6)$$

$$+\frac{1}{N}\sum_{i=1}^{N}\int_{\mathbb{R}^{Nd}}\left(\rho_{t}^{N}\left(b(x_{i})+K*\rho_{t}(x_{i})\right)-\sigma\operatorname{div}_{x_{i}}\rho_{t}^{N}\right)\cdot\left(-\nabla_{x_{i}}\frac{\bar{\rho}_{t}^{N}}{\rho_{t}^{N}}\right)d\mathbf{x}.$$

Introduce

$$F(x_i) = \frac{1}{N-1} \sum_{j: j \neq i} K(x_i - x_j),$$
(4.7)

rearrange the terms

$$\frac{d}{dt}\mathcal{H}_{N}\left(\bar{\rho}_{t}^{N}\mid\rho_{t}^{N}\right) = \frac{1}{N}\sum_{i=1}^{N}\int_{\mathbb{R}^{Nd}}\mathbb{E}_{\xi_{k}}\left(\rho_{t}^{N,\xi_{k}}\left(\bar{b}_{t}^{\xi_{k},i}(\mathbf{x})-b(x_{i})\right)\right)\cdot\nabla_{x_{i}}\log\frac{\bar{\rho}_{t}^{N}}{\rho_{t}^{N}}d\mathbf{x} \\
+ \frac{1}{N}\sum_{i=1}^{N}\int_{\mathbb{R}^{Nd}}\mathbb{E}_{\xi_{k}}\left(\bar{\rho}_{t}^{N,\xi_{k}}\bar{K}_{t}^{\xi_{k},i}(\mathbf{x})-\bar{\rho}_{t}^{N,\xi_{k}}K^{\xi_{k}}(x_{i})\right)\cdot\nabla_{x_{i}}\log\frac{\bar{\rho}_{t}^{N}}{\rho_{t}^{N}}d\mathbf{x} \\

- \frac{\sigma}{N}\sum_{i=1}^{N}\int_{\mathbb{R}^{Nd}}\bar{\rho}_{t}^{N}\left|\nabla_{x_{i}}\log\frac{\bar{\rho}_{t}^{N}}{\rho_{t}^{N}}\right|^{2}d\mathbf{x} \\
:= \frac{1}{N}\sum_{i=1}^{N}(J_{1}^{i}+J_{2}^{i}+J_{3}^{i}+J_{4}^{i}+J_{5}^{i}).$$
(4.8)

As done in [30], for J_3^i , our approach is to introduce another copy of RBM $\bar{\mathbf{Y}}$ that depends on another batch ξ_k such that

- $\bar{\mathbf{Y}}_{T_k} = \bar{\mathbf{X}}_{T_k};$
- the Brownian Motion are the same in $[T_k, T_{k+1})$;
- the batch $\tilde{\xi}_k$ on $[T_k, T_{k+1})$ is independent of ξ_k .

Consequently, density of the law $\bar{\rho}_t^{N,\tilde{\xi}_k}$ for $\bar{\mathbf{Y}}$ satisfies both (4.1) and (4.2). Then

$$J_{3}^{i} = \int_{\mathbb{R}^{Nd}} \mathbb{E}_{\xi_{k}} \left[\left(K^{\xi_{k}}(x_{i}) - F(x_{i}) \right) \left(\bar{\rho}_{t}^{N,\xi_{k}} - \bar{\rho}_{t}^{N} \right) \right] \cdot \nabla_{x_{i}} \log \frac{\bar{\rho}_{t}^{N}}{\rho_{t}^{N}} d\mathbf{x}$$

$$= \int_{\mathbb{R}^{Nd}} \mathbb{E}_{\xi_{k},\tilde{\xi}_{k}} \left[\left(K^{\xi_{k}}(x_{i}) - F(x_{i}) \right) \left(\bar{\rho}_{t}^{N,\xi_{k}} - \bar{\rho}_{t}^{N,\tilde{\xi}_{k}} \right) \right] \cdot \nabla_{x_{i}} \log \frac{\bar{\rho}_{t}^{N}}{\rho_{t}^{N}} d\mathbf{x}$$

$$\leq \frac{2}{\sigma} \mathbb{E}_{\xi_{k},\tilde{\xi}_{k}} \left[\int_{\mathbb{R}^{Nd}} \left| K^{\xi_{k}}(x_{i}) - F(x_{i}) \right|^{2} \frac{\left| \bar{\rho}_{t}^{N,\xi_{k}} - \bar{\rho}_{t}^{N,\tilde{\xi}_{k}} \right|^{2}}{\bar{\rho}_{t}^{N,\tilde{\xi}_{k}}} d\mathbf{x} \right] + \frac{\sigma}{8} \int_{\mathbb{R}^{Nd}} \bar{\rho}_{t}^{N} \left| \nabla_{x_{i}} \log \frac{\bar{\rho}_{t}^{N}}{\rho_{t}^{N}} \right|^{2} d\mathbf{x}.$$

$$(4.9)$$

Here the second equality is due to the fact

$$\mathbb{E}_{\xi_k}\left[\bar{\rho}_t^{N,\xi_k}\right] = \bar{\rho}_t^N,$$

and the consistency of the random batch, that is

$$\mathbb{E}_{\xi_k}\left[K^{\xi_k}(x_i)\right] = F(x_i)$$

Then the term $\left|\bar{\rho}_{t}^{N,\xi_{k}}K^{\xi_{k}}(x_{i})-\bar{\rho}_{t}^{N}F(x_{i})\right|$ is of O(1). The second equality is due to $\mathbb{E}_{\tilde{\xi}_{k}}\left[\bar{\rho}_{t}^{N,\tilde{\xi}_{k}}\right] = \bar{\rho}_{t}^{N}$. In the last inequality, we applied Young's inequality and the fact $\mathbb{E}_{\xi_{k},\tilde{\xi}_{k}}\left|\nabla_{x_{i}}\log\frac{\bar{\rho}_{t}^{N}}{\rho_{t}^{N}}\right|^{2}\bar{\rho}_{t}^{N,\tilde{\xi}_{k}} = 0$ $\left| \nabla_{x_i} \log \frac{\bar{\rho}_t^N}{\rho_t^N} \right|^2 \bar{\rho}_t^N.$ The introduction of the independent copy of $\tilde{\xi}_k$ is useful since we may apply the Girsanov transform later to estimate this quantitatively. Then apply Young's inequality for J_1^i, J_2^i, J_4^i and the Log-Sobolev inequality for J_3^i , we

+ \frac{2}{\sigma N}\sum_{i=1}^{N}\int_{\mathbb{R}^{Nd}}\bar{\rho}_{t}^{N}\left|F(x_{i}) - K*\rho_{t}(x_{i})\right|^{2}d\mathbf{x}.$$
(4.10)

Step 2: Estimate $\mathbb{E}_{\xi_k} \int_{\mathbb{R}^{Nd}} \left| \bar{b}_t^{\xi_k,i}(\mathbf{x}) - b(x_i) \right|^2 \bar{\rho}_t^{N,\xi_k} d\mathbf{x}.$

For any $t \in [T_k, T_{k+1})$, by Taylor's expansion, we have

$$\begin{aligned} \bar{b}_t^{\xi_k,i}(\mathbf{x}) - b(x_i) &= \mathbb{E}\left[b\left(\bar{X}_{T_k}^i\right) - b\left(\bar{X}_t^i\right) \mid \bar{\mathbf{X}}_t = \mathbf{x}, \xi_k\right] \\ &= \mathbb{E}\left[\bar{X}_{T_k}^i - \bar{X}_t^i \mid \bar{\mathbf{X}}_t = \mathbf{x}, \xi_k\right] \cdot \nabla_{x_i} b(x_i) + \bar{r}_t(x_i), \end{aligned}$$

where the remainder takes the form

In Lemma B.1, we show that for $t \in [T_k, T_{k+1})$,

where c is a positive constant independent of N and ξ_k . For the first term, consider $\mathbb{E}\left[\bar{\mathbf{X}}_{T_k} - \bar{\mathbf{X}}_t \mid \bar{\mathbf{X}}_t = \mathbf{x}, \xi_k\right]$. By Bayes' law,

$$= \int_{\mathbb{R}^{Nd}} (\mathbf{y} - \mathbf{x}) \frac{\bar{\rho}_{T_{k}}^{N}(\mathbf{y}) P\left(\bar{\mathbf{X}}_{t} = \mathbf{x} \mid \bar{\mathbf{X}}_{T_{k}} = \mathbf{y}, \xi_{k}\right)}{\bar{\rho}_{t}^{N, \xi_{k}}(\mathbf{x})} d\mathbf{y}.$$

$$(4.12)$$

Clearly, the distribution $P\left(\bar{\mathbf{X}}_t = \mathbf{x} \mid \bar{\mathbf{X}}_{T_k} = \mathbf{y}, \xi_k\right)$ is Gaussian, namely,

$$P\left(\bar{\mathbf{X}}_{t}=\mathbf{x} \mid \bar{\mathbf{X}}_{T_{k}}=\mathbf{y}, \xi_{k}\right) = \left(4\pi\sigma\left(t-T_{k}\right)\right)^{-\frac{Nd}{2}} \exp\left(-\frac{\left|\mathbf{x}-\mathbf{y}-\mathbf{b}(\mathbf{y})\left(t-T_{k}\right)-\mathbf{K}^{\xi_{k}}(\mathbf{y})\left(t-T_{k}\right)\right|^{2}}{4\sigma\left(t-T_{k}\right)}\right)$$

Then one can use integration by parts to calculate (4.12). Indeed, we show in Lemma B.2 that r

$$\frac{1}{N}\sum_{i=1}^{N}\mathbb{E}_{\xi_{k}}\int_{\mathbb{R}^{Nd}}\left|\bar{b}_{t}^{\xi_{k},i}(\mathbf{x})-b(x_{i})\right|^{2}\bar{\rho}_{t}^{N,\xi_{k}}d\mathbf{x}$$

$$\lesssim\mathbb{E}_{\xi_{k}}\left[\frac{1}{N}\sum_{i=1}^{N}\mathbb{E}\left[\left|\bar{r}_{t}\left(\bar{X}_{t}^{i}\right)\right|^{2}\mid\xi_{k}\right]+\frac{1}{N}\sum_{i=1}^{N}\int_{\mathbb{R}^{Nd}}\left|\mathbb{E}\left[\bar{X}_{T_{k}}^{i}-\bar{X}_{t}^{i}\mid\bar{\mathbf{X}}_{t}=\mathbf{x},\xi_{k}\right]\right|^{2}\bar{\rho}_{t}^{N,\xi_{k}}d\mathbf{x}\right]$$

$$\leq\mathbb{E}_{\xi_{k}}\left[\frac{1}{N}\sum_{i=1}^{N}\mathbb{E}\left[\left|\bar{r}_{t}\left(\bar{X}_{t}^{i}\right)\right|^{2}\mid\xi_{k}\right]+\frac{1}{N}\int_{\mathbb{R}^{Nd}}\left|\mathbb{E}\left[\bar{\mathbf{X}}_{T_{k}}-\bar{\mathbf{X}}_{t}\mid\bar{\mathbf{X}}_{t}=\mathbf{x},\xi_{k}\right]\right|^{2}\bar{\rho}_{t}^{N,\xi_{k}}d\mathbf{x}\right]$$

$$\leq\tilde{c}\tau^{2}\left(3+\frac{1}{N}\mathcal{I}\left(\bar{\rho}_{T_{k}}^{N}\right)\right),$$

$$(4.14)$$

where the positive constant \tilde{c} is independent of ξ_k , N and t, and this is what we desire. **Step 3:** Estimate $\mathbb{E}_{\xi_k} \int_{\mathbb{R}^{Nd}} \left| \bar{K}_t^{\xi_k,i}(\mathbf{x}) - K^{\xi_k}(x_i) \right|^2 \bar{\rho}_t^{N,\xi_k} d\mathbf{x}.$ Similar to step 2, by Taylor's expansion, for any $t \in [T_k, T_{k+1})$,

$$\leq \tilde{c}' \tau^{2} \left(3 + \frac{1}{N} \mathcal{I} \left(\bar{\rho}_{T_{k}}^{N} \right) \right),$$
(4.16)

where the positive constant \tilde{c}' is independent of N, ξ_k and t.

Step 4: Estimate
$$\mathbb{E}_{\xi_k,\tilde{\xi}_k} \left[\int_{\mathbb{R}^{Nd}} \left| K^{\xi_k}(x_i) - F(x_i) \right|^2 \frac{\left| \bar{\rho}_t^{N,\xi_k} - \bar{\rho}_t^{N,\tilde{\xi}_k} \right|^2}{\bar{\rho}_t^{N,\tilde{\xi}_k}} d\mathbf{x} \right]$$

$$\begin{split} & \frac{\bar{\rho}_{t}^{N,\xi_{k}}}{\bar{\rho}_{t}^{N,\tilde{\xi}_{k}}}(\mathbf{x}) = \mathbb{E}\left[\frac{dP_{\bar{\mathbf{X}}}}{dP_{\bar{\mathbf{Y}}}} \mid \bar{\mathbf{Y}}_{t} = \mathbf{x}, \xi_{k}, \tilde{\xi}_{k}\right] \\ & = \mathbb{E}\left[\exp\left(\sqrt{\frac{1}{2\sigma}} \int_{T_{k}}^{t} \left(\mathbf{K}^{\tilde{\xi}_{k}} - \mathbf{K}^{\xi_{k}}\right)(\mathbf{y}) d\mathbf{W}_{s} - \frac{1}{4\sigma} \int_{T_{k}}^{t} \left|\left(\mathbf{K}^{\tilde{\xi}_{k}} - \mathbf{K}^{\xi_{k}}\right)(\mathbf{y})\right|^{2} ds\right) \mid \bar{\mathbf{Y}}_{t} = \mathbf{x}, \xi_{k}, \tilde{\xi}_{k}\right]. \end{split}$$
Denote

$$\tilde{\mathbf{K}}(\mathbf{y}) := \frac{1}{\sqrt{2\sigma}} \left(\mathbf{K}^{\tilde{\xi}_k} - \mathbf{K}^{\xi_k} \right) (\mathbf{y}).$$

Then, for $t \in [T_k, T_{k+1})$,

$$\begin{split} &\int_{\mathbb{R}^{Nd}} \left| \frac{\bar{\rho}_{t}^{N,\xi_{k}}}{\bar{\rho}_{t}^{N,\tilde{\xi}_{k}}} - 1 \right|^{2} \bar{\rho}_{t}^{N,\tilde{\xi}_{k}} d\mathbf{x} \\ &= \int_{\mathbb{R}^{Nd}} \bar{\rho}_{t}^{N,\tilde{\xi}_{k}}(\mathbf{x}) \left| \mathbb{E} \left[\exp \left(\int_{T_{k}}^{t} \tilde{\mathbf{K}} \left(\bar{\mathbf{Y}}_{T_{k}} \right) d\mathbf{W}_{s} - \frac{1}{2} \int_{T_{k}}^{t} \left| \tilde{\mathbf{K}} \left(\bar{\mathbf{Y}}_{T_{k}} \right) \right|^{2} ds \right) \mid \bar{\mathbf{Y}}_{t} = \mathbf{x}, \xi_{k}, \tilde{\xi}_{k} \right] - 1 \right|^{2} d\mathbf{x} \end{split}$$

Notice the fact that $\bar{\mathbf{Y}}_t = \mathbf{y} + \left(\mathbf{b}(\mathbf{y}) + \mathbf{K}^{\tilde{\xi}_k}(\mathbf{y})\right)(t - T_k) + \sqrt{2\sigma} \left(\mathbf{W}_t - \mathbf{W}_{T_k}\right)$, resulting in that

= \int \bar{\rho}_{t}^{N,\tilde{\xi}_{k}}(\mathbf{x}) \left| \int \left(e^{\sqrt{\frac{1}{2\sigma}} \tilde{\mathbf{K}}(\mathbf{y}) \left(\mathbf{x} - \mathbf{y} - (t - T_{k}) \mathbf{F}^{\tilde{\xi}_{k}}(\mathbf{y}) \right) - \frac{1}{2} |\tilde{\mathbf{K}}(\mathbf{y})|^{2} (t - T_{k})} - 1 \right) P\left(\bar{\mathbf{X}}_{T_{k}} = \mathbf{y} \mid \bar{\mathbf{Y}}_{t} = \mathbf{x}, \xi_{k}, \tilde{\xi}_{k} \right) d\mathbf{y} \right|^{2} d\mathbf{x}, \\$$
(4.17)

where $\mathbf{F}^{\tilde{\xi}_k}(\mathbf{y}) = \mathbf{b}(\mathbf{y}) + \mathbf{K}^{\tilde{\xi}_k}(\mathbf{y})$. Now we split (4.17) into three terms

$$e^{\sqrt{\frac{1}{2\sigma}}\tilde{\mathbf{K}}(\mathbf{y})\left(\mathbf{x}-\mathbf{y}-(t-T_k)\mathbf{F}^{\tilde{\xi}_k}(\mathbf{y})\right)-\frac{1}{2}|\tilde{\mathbf{K}}(\mathbf{y})|^2(t-T_k)}-1}$$

= $\sqrt{\frac{1}{2\sigma}}\tilde{\mathbf{K}}(\mathbf{y})\left(\mathbf{x}-\mathbf{y}\right)+\left(-\sqrt{\frac{1}{2\sigma}}\tilde{\mathbf{K}}(\mathbf{y})\mathbf{F}^{\tilde{\xi}_k}(\mathbf{y})-\frac{1}{2}|\tilde{\mathbf{K}}(\mathbf{y})|^2\right)(t-T_k)+(e^{\mathbf{z}}-\mathbf{z}-1)$ (4.18)
:= $K_1+K_2+K_3,$

where $\mathbf{z} = \sqrt{\frac{1}{2\sigma}} \tilde{\mathbf{K}}(\mathbf{y}) \left(\mathbf{x} - \mathbf{y} - (t - T_k) \mathbf{F}^{\tilde{\xi}_k}(\mathbf{y}) \right) - \frac{1}{2} |\tilde{\mathbf{K}}(\mathbf{y})|^2 (t - T_k)$. Then

$$\int_{\mathbb{R}^{Nd}} \left| \frac{\bar{\rho}_t^{N,\xi_k}}{\bar{\rho}_t^{N,\tilde{\xi}_k}} - 1 \right|^2 \bar{\rho}_t^{N,\tilde{\xi}_k} d\mathbf{x} = \int_{\mathbb{R}^{Nd}} \bar{\rho}_t^{N,\tilde{\xi}_k} (\mathbf{x}) \left| \int_{\mathbb{R}^{Nd}} \left(K_1 + K_2 + K_3 \right) P\left(\bar{\mathbf{X}}_{T_k} = \mathbf{y} \mid \bar{\mathbf{Y}}_t = \mathbf{x}, \xi_k, \tilde{\xi}_k \right) d\mathbf{y} \right|^2 d\mathbf{x}.$$

Equipped with the estimation for integration of K_1 , K_2 and K_3 from Lemma B.3, Lemma B.4 and Lemma B.5 in Appendix B, we can get the estimate

$$\int_{\mathbb{R}^{Nd}} \frac{\left|\bar{\rho}_t^{N,\tilde{\xi}_k} - \bar{\rho}_t^{N,\xi_k}\right|^2}{\bar{\rho}_t^{N,\tilde{\xi}_k}} d\mathbf{x} \le c\tau^2 \left(N + \mathcal{I}\left(\bar{\rho}_{T_k}^N\right)\right).$$

Hence,

$$\frac{1}{N} \sum_{i=1}^{N} \mathbb{E}_{\xi_{k},\tilde{\xi}_{k}} \left[\int_{\mathbb{R}^{Nd}} \left| K^{\xi_{k}}(x_{i}) - F(x_{i}) \right|^{2} \frac{\left| \bar{\rho}_{t}^{N,\xi_{k}} - \bar{\rho}_{t}^{N,\tilde{\xi}_{k}} \right|^{2}}{\bar{\rho}_{t}^{N,\tilde{\xi}_{k}}} d\mathbf{x} \right] \\
\leq \frac{1}{N} \mathbb{E}_{\xi_{k},\tilde{\xi}_{k}} \left[\int_{\mathbb{R}^{Nd}} \left| \mathbf{K}^{\xi_{k}}(\mathbf{x}) - \mathbf{F}(\mathbf{x}) \right|^{2} \frac{\left| \bar{\rho}_{t}^{N,\xi_{k}} - \bar{\rho}_{t}^{N,\tilde{\xi}_{k}} \right|^{2}}{\bar{\rho}_{t}^{N,\tilde{\xi}_{k}}} d\mathbf{x} \right] \\
\lesssim \tilde{c}'' \tau^{2} \left(1 + \frac{1}{N} \mathcal{I}\left(\bar{\rho}_{T_{k}}^{N} \right) \right),$$
(4.19)

where the positive constant \tilde{c}'' is independent of ξ_k , N and t. **Step 5:** Estimate $\int_{\mathbb{R}^{Nd}} \bar{\rho}_t^N |K(x_i) - K * \rho_t(x_i)|^2 d\mathbf{x}$.

Let $\Phi(x_i) = (F(x_i) - K * \rho_t(x_i))^2$ with $F(x_i)$ given in (4.7). Define the probability density

$$f = \frac{1}{\lambda} \exp(N\eta \Phi) \rho_t^N, \quad \lambda = \int_{\mathbb{R}^{Nd}} \exp(N\eta \Phi) \rho_t^N d\mathbf{x},$$

where η is an arbitrary positive number. Thanks to the function $h(x) = x \log x + 1 - x \ge 0$ for any x > 0, we can obtain

$$\begin{split} \frac{1}{N} \int_{\mathbb{R}^{Nd}} \bar{\rho}_t^N \log \bar{\rho}_t^N d\mathbf{x} &= \frac{1}{N} \int_{\mathbb{R}^{Nd}} f\left(\frac{\bar{\rho}_t^N}{f} \log \frac{\bar{\rho}_t^N}{f} - \frac{\bar{\rho}_t^N}{f} + 1\right) d\mathbf{x} + \frac{1}{N} \int_{\mathbb{R}^{Nd}} \bar{\rho}_t^N \log f d\mathbf{x} \\ &\geq \frac{1}{N} \int_{\mathbb{R}^{Nd}} \bar{\rho}_t^N \log f d\mathbf{x}. \end{split}$$

On the other hand, one can easily check that

$$\frac{1}{N} \int_{\mathbb{R}^{Nd}} \bar{\rho}_t^N \log f d\mathbf{x} = \eta \int_{\mathbb{R}^{Nd}} \bar{\rho}_t^N \Phi d\mathbf{x} + \frac{1}{N} \int_{\mathbb{R}^{Nd}} \bar{\rho}_t^N \log \rho_t^N d\mathbf{x} - \frac{\log \lambda}{N}$$

Then we can conclude that

$$\int_{\mathbb{R}^{Nd}} \bar{\rho}_t^N \Phi d\mathbf{x} \le \frac{1}{\eta} \left(\mathcal{H}_N\left(\bar{\rho}_t^N \mid \rho_t^N\right) + \frac{1}{N} \log \int_{\mathbb{R}^{Nd}} \rho_t^N \exp(N\eta \Phi) d\mathbf{x} \right).$$
(4.20)

We rewrite

$$\Phi(x_i) = \left| \frac{1}{N} \sum_{j=1}^N K(x_i - x_j) - K * \rho_t(x_i) \right|^2 = \frac{1}{N^2} \sum_{j_1, j_2 = 1}^N \phi(x_i, x_{j_1}) \phi(x_i, x_{j_2}),$$

where $\phi(x,z) = K(x-z) - K * \rho_t(x)$. Note that each ϕ has vanishing expectation with respect to ρ :

By taking $||K||_{L^{\infty}}$ small enough, we deduce that

where the constant C is independent of N and t. Taking $\eta = \frac{4C_{LS}}{\sigma}$, and by Lemma D.1, we can obtain the estimate:

$$\begin{aligned} \frac{d}{dt}\mathcal{H}_{N}\left(\bar{\rho}_{t}^{N}\mid\rho_{t}^{N}\right) &\leq -\frac{\sigma}{4C_{LS}}\mathcal{H}_{N}\left(\bar{\rho}_{t}^{N}\mid\rho_{t}^{N}\right) + c_{1}\tau^{2}\left(1+\frac{1}{N}\mathcal{I}\left(\bar{\rho}_{T_{k}}^{N}\right)\right) + \frac{c_{2}}{N} \\ &\leq -\frac{\sigma}{4C_{LS}}\mathcal{H}_{N}\left(\bar{\rho}_{t}^{N}\mid\rho_{t}^{N}\right) + c_{1}\tau^{2}\left(1+\frac{1}{N}\mathbb{E}_{\xi_{k}}\left[\mathcal{I}\left(\bar{\rho}_{T_{k}}^{N,\xi_{k}}\right)\right]\right) + \frac{c_{3}}{N} \\ &\leq -C_{0}\mathcal{H}_{N}\left(\bar{\rho}_{t}^{N}\mid\rho_{t}^{N}\right) + C_{1}\tau^{2} + \frac{C_{2}}{N}, \end{aligned}$$

where the second inequality is due to the convexity of the Fisher information $\mathcal{I}(\rho)$ with respect to ρ , and the third inequality is due to Lemma 3.3. Note that the constants C_0, C_1 and C_2 are independent of N, τ and ξ_k , then by Gronwall's inequality, we end the proof.

5 Conclusion

In this paper we prove the error estimate of propagation of chaos form for random batch method for N- particle systems toward its mean-field limit, the Fokker-Planck equation, based on the relative entropy. We show that the convergence rate is $O(\tau^2 + 1/N)$, where τ is the small time steps. Our result can be seen as an improvement over the previous work, and we fill the gap to understand the approximation error of the RBM as a numerical method for its mean-field limit. Our results need some regularity assumptions on the force terms. It will be an interesting topic to investigate the error estimate of random batch method for singular interacting kernel such as the Biot-Savart Law in incompressible flows, among other applications.

Indeed, for $t \in [T_k, T_{k+1})$, consider the random variable $\bar{\varrho}_t^{N, \boldsymbol{\xi}} | \mathcal{F}_{T_k}$, where $\mathcal{F}_{T_k} = \sigma \left(\bar{\mathbf{X}}_s, s \leq T_k \right)$. Then, by definition of $\bar{\mathbf{X}}_t$ for $t \in [T_k, T_{k+1})$, $\bar{\varrho}_t^{N, \boldsymbol{\xi}} | \mathcal{F}_{T_k}$ satisfies the Liouville equation:

Taking expectation, one has

and for the drift term,

$$\mathbb{E}\left[\operatorname{div}_{x_{i}}\left(\left(b\left(\bar{X}_{T_{k}}^{i}\right)+K^{\xi_{k}}\left(\bar{X}_{T_{k}}^{i}\right)\right)\left(\bar{\varrho}_{t}^{N,\boldsymbol{\xi}}\mid\mathcal{F}_{T_{k}}\right)\right)\right]$$

$$=\operatorname{div}_{x_{i}}\int\left(\bar{\varrho}_{t}^{N,\boldsymbol{\xi}}\mid\mathcal{F}_{T_{k}}\right)(\mathbf{x}\mid\mathbf{y})(b(y_{i})+K^{\xi_{k}}(y_{i}))\bar{\varrho}_{t}^{N,\boldsymbol{\xi}}(\mathbf{y})d\mathbf{y}$$

$$=\operatorname{div}_{x_{i}}\int(b(y_{i})+K^{\xi_{k}}(y_{i}))\bar{\varrho}_{t,T_{k}}^{N,\boldsymbol{\xi}}(\mathbf{x},\mathbf{y})d\mathbf{y}$$

$$=\operatorname{div}_{x_{i}}\left(\bar{\varrho}_{t}^{N,\boldsymbol{\xi}}(\mathbf{x})\mathbb{E}\left[b\left(\bar{X}_{T_{k}}^{i}\right)+K^{\xi_{k}}\left(\bar{X}_{T_{k}}^{i}\right)\mid\bar{\mathbf{X}}_{t}=\mathbf{x},\boldsymbol{\xi}\right]\right),$$

where $\bar{\varrho}_{t,T_k}^{N,\boldsymbol{\xi}}$ denotes the joint distribution of $\bar{\mathbf{X}}_t$ and $\bar{\mathbf{X}}_{T_k}$. Note that we used Bayes' law in the third equality. Combining all the above, we obtain the desired result (2.10).

$$\int_{\mathbb{R}^{Nd}} \bar{\rho}_t^{N,\tilde{\xi}_k}(\mathbf{x}) \left| \int_{\mathbb{R}^{Nd}} K_1 P\left(\bar{\mathbf{X}}_{T_k} = \mathbf{y} \mid \bar{\mathbf{Y}}_t = \mathbf{x}, \xi_k, \tilde{\xi}_k \right) d\mathbf{y} \right|^2 d\mathbf{x} = \frac{1}{2\sigma} \mathbb{E} \left[\left| \bar{I}_1(\bar{\mathbf{Y}}_t) - \bar{I}_2(\bar{\mathbf{Y}}_t) - \bar{I}_3(\bar{\mathbf{Y}}_t) \right|^2 \mid \xi_k, \tilde{\xi}_k \right]. \tag{B.9}$$

For the first term \bar{I}_1 , using Bayes' formula and integration by parts, since $P\left(\bar{\mathbf{Y}}_t = \mathbf{x} \mid \bar{\mathbf{X}}_{T_k} = \mathbf{y}, \xi_k, \tilde{\xi}_k\right)$ is Gaussian, we have

$$\begin{split} \bar{I}_{1}(\mathbf{x}) \\ &= \int_{\mathbb{R}^{Nd}} \tilde{\mathbf{K}}(\mathbf{y}) \cdot \left(\mathbf{I}_{Nd} + (t - T_{k}) \nabla \mathbf{F}^{\tilde{\xi}_{k}}(\mathbf{y})\right) \cdot \left(\mathbf{y} - \mathbf{x} + (t - T_{k}) \mathbf{F}^{\tilde{\xi}_{k}}(\mathbf{y})\right) P\left(\bar{\mathbf{X}}_{T_{k}} = \mathbf{y} \mid \bar{\mathbf{Y}}_{t} = \mathbf{x}, \xi_{k}, \tilde{\xi}_{k}\right) d\mathbf{y} \\ &= \int_{\mathbb{R}^{Nd}} \tilde{\mathbf{K}}(\mathbf{y}) \cdot \left(\mathbf{I}_{Nd} + (t - T_{k}) \nabla \mathbf{F}^{\tilde{\xi}_{k}}(\mathbf{y})\right) \cdot \left(\mathbf{y} - \mathbf{x} + (t - T_{k}) \mathbf{F}^{\tilde{\xi}_{k}}(\mathbf{y})\right) \frac{\bar{\rho}_{T_{k}}^{N,\xi_{k}}(\mathbf{y})}{\bar{\rho}_{t}^{N,\tilde{\xi}_{k}}(\mathbf{x})} P\left(\bar{\mathbf{Y}}_{t} = \mathbf{x} \mid \bar{\mathbf{X}}_{T_{k}} = \mathbf{y}\right) d\mathbf{y} \\ &= 2\sigma \left(t - T_{k}\right) \int_{\mathbb{R}^{Nd}} \frac{\nabla_{\mathbf{y}} \left(\tilde{\mathbf{K}}(\mathbf{y}) \bar{\rho}_{T_{k}}^{N,\xi_{k}}(\mathbf{y})\right)}{\bar{\rho}_{t}^{N,\tilde{\xi}_{k}}(\mathbf{x})} P\left(\bar{\mathbf{Y}}_{t} = \mathbf{x} \mid \bar{\mathbf{X}}_{T_{k}} = \mathbf{y}\right) d\mathbf{y} \\ &= 2\sigma \left(t - T_{k}\right) \int_{\mathbb{R}^{Nd}} \left(\nabla \tilde{\mathbf{K}}(\mathbf{y}) + \tilde{\mathbf{K}}(\mathbf{y}) \frac{\nabla \bar{\rho}_{T_{k}}^{N,\xi_{k}}(\mathbf{y})}{\bar{\rho}_{T_{k}}^{N,\xi_{k}}(\mathbf{y})}\right) P\left(\bar{\mathbf{Y}}_{t} = \mathbf{x} \mid \bar{\mathbf{X}}_{T_{k}} = \mathbf{y}\right) d\mathbf{y}. \end{split}$$

Since K^{ξ_k} is uniformly bounded by Assumption 2.1, then $\tilde{\mathbf{K}}(\mathbf{y})$ and $\nabla \tilde{\mathbf{K}}(\mathbf{y})$ are also uniformly bounded, hence

$$\mathbb{E}\left[\left|\bar{I}_{1}(\bar{\mathbf{Y}}_{t})\right|^{2} \mid \xi_{k}, \tilde{\xi}_{k}\right] \leq c \left(t - T_{k}\right)^{2} \left(1 + \mathcal{I}\left(\bar{\rho}_{T_{k}}^{N}\right)\right), \qquad (B.10)$$

and the constant c is independent of N, ξ_k , $\tilde{\xi}_k$. For the second term \bar{I}_2 , by Jensen's inequality, it holds that

$$\mathbb{E}\left[\left|\bar{I}_{2}(\bar{\mathbf{Y}}_{t})\right|^{2} \mid \xi_{k}, \tilde{\xi}_{k}\right] \leq (t - T_{k})^{2} \mathbb{E}\left[\left|\tilde{\mathbf{K}}(\bar{\mathbf{X}}_{T_{k}}) \cdot \nabla \mathbf{F}^{\tilde{\xi}_{k}}(\bar{\mathbf{X}}_{T_{k}}) \cdot \int_{T_{k}}^{t} d\mathbf{W}_{s}\right|^{2} \mid \xi_{k}, \tilde{\xi}_{k}\right].$$

By Assumption 2.1, since $\tilde{\mathbf{K}}$ is bounded and $\nabla \mathbf{F}^{\tilde{\xi}_k}$ has polynomial growth, then by the moment control Lemma 3.1, we can obtain

$$\mathbb{E}\left[\left|\bar{I}_{2}(\bar{\mathbf{Y}}_{t})\right|^{2} \mid \xi_{k}, \tilde{\xi}_{k}\right] \leq cN \left(t - T_{k}\right)^{2}, \tag{B.11}$$

and the constant c is independent of N, ξ_k , $\tilde{\xi}_k$. For the third term \bar{I}_3 , by Jensen's inequality, it holds that

$$\mathbb{E}\left[\left|\bar{I}_{3}(\bar{\mathbf{Y}}_{t})\right|^{2} \mid \xi_{k}, \tilde{\xi}_{k}\right] \leq (t - T_{k})^{2} \mathbb{E}\left[\left|\tilde{\mathbf{K}}(\bar{\mathbf{X}}_{T_{k}}) \cdot \mathbf{F}^{\tilde{\xi}_{k}}(\bar{\mathbf{X}}_{T_{k}})\right|^{2} \mid \xi_{k}, \tilde{\xi}_{k}\right].$$

By Assumption 2.1, since $\tilde{\mathbf{K}}$ is bounded and $\mathbf{F}^{\tilde{\xi}_k}$ has polynomial growth, then by moment control Lemma 3.1, we can obtain

$$\mathbb{E}\left[\left|\bar{I}_{3}(\bar{\mathbf{Y}}_{t})\right|^{2} \mid \xi_{k}, \tilde{\xi}_{k}\right] \leq cN \left(t - T_{k}\right)^{2}, \qquad (B.12)$$

and the constant c is independent of N, ξ_k , $\tilde{\xi}_k$. Finally, combining (B.10), (B.11) and (B.12), we get

$$\int_{\mathbb{R}^{Nd}} \bar{\rho}_t^{N,\tilde{\xi}_k}(\mathbf{x}) \left| \int_{\mathbb{R}^{Nd}} K_1 P\left(\bar{\mathbf{X}}_{T_k} = \mathbf{y} \mid \bar{\mathbf{Y}}_t = \mathbf{x}, \xi_k, \tilde{\xi}_k \right) d\mathbf{y} \right|^2 d\mathbf{x} \le c\tau^2 \left(N + \mathcal{I}\left(\bar{\rho}_{T_k}^N \right) \right). \quad (B.13)$$

$$\int_{\mathbb{R}^{Nd}} \bar{\rho}_t^{N,\tilde{\xi}_k}(\boldsymbol{x}) \left| \int_{\mathbb{R}^{Nd}} K_2 P\left(\bar{\boldsymbol{X}}_{T_k} = \boldsymbol{y} \mid \bar{\boldsymbol{Y}}_t = \boldsymbol{x}, \xi_k, \tilde{\xi}_k \right) d\boldsymbol{y} \right|^2 d\boldsymbol{x} \le cN\tau^2.$$
(B.15)

Proof. For K_2 , by Jensen's inequality,

$$\int \bar{\rho}_t^{N,\tilde{\xi}_k}(\mathbf{x}) \left| \int K_2 P\left(\bar{\mathbf{X}}_{T_k} = \mathbf{y} \mid \bar{\mathbf{Y}}_t = \mathbf{x}, \xi_k, \tilde{\xi}_k \right) d\mathbf{y} \right|^2 d\mathbf{x}$$

$$\leq \int \bar{\rho}_t^{N,\tilde{\xi}_k}(\mathbf{x}) \int |K_2|^2 P\left(\bar{\mathbf{X}}_{T_k} = \mathbf{y} \mid \bar{\mathbf{Y}}_t = \mathbf{x}, \xi_k, \tilde{\xi}_k \right) d\mathbf{y} d\mathbf{x}$$

$$= (t - T_k)^2 \mathbb{E} \left[\left| \left(\sqrt{\frac{1}{2\sigma}} \tilde{\mathbf{K}}(\mathbf{y}) \mathbf{F}^{\tilde{\xi}_k}(\mathbf{y}) + \frac{1}{2} |\tilde{\mathbf{K}}(\mathbf{y})|^2 \right) \right|^2 \mid \xi_k, \tilde{\xi}_k \right].$$

By Assumption 2.1, since $\tilde{\mathbf{K}}$ is bounded and $\mathbf{F}^{\tilde{\xi}_k}$ has polynomial growth, then by moment control Lemma 3.1, we can obtain

$$\int \bar{\rho}_t^{N,\tilde{\xi}_k}(\mathbf{x}) \left| \int K_2 P\left(\bar{\mathbf{X}}_{T_k} = \mathbf{y} \mid \bar{\mathbf{Y}}_t = \mathbf{x}, \xi_k, \tilde{\xi}_k \right) d\mathbf{y} \right|^2 d\mathbf{x} \le cN\tau^2, \tag{B.16}$$

and the constant c is independent of $N, \xi_k, \tilde{\xi}_k$.

Lemma B.5. Recall the notations

Then under the setting of Theorem 4.1, there exists a positive constant c independent of ξ_k , $\tilde{\xi}_k$, N and t such for $t \in [T_k, T_{k+1})$,

$$\int_{\mathbb{R}^{Nd}} \bar{\rho}_t^{N,\tilde{\xi}_k}(\boldsymbol{x}) \left| \int_{\mathbb{R}^{Nd}} K_3 P\left(\bar{\boldsymbol{X}}_{T_k} = \boldsymbol{y} \mid \bar{\boldsymbol{Y}}_t = \boldsymbol{x}, \xi_k, \tilde{\xi}_k \right) d\boldsymbol{y} \right|^2 d\boldsymbol{x} \le cN\tau^2.$$
(B.18)

Proof. For K_3 , by Jensen's inequality,

$$\begin{split} &\int_{\mathbb{R}^{Nd}} \bar{\rho}_t^{N,\tilde{\xi}_k}(\mathbf{x}) \left| \int_{\mathbb{R}^{Nd}} K_3 P\left(\bar{\mathbf{X}}_{T_k} = \mathbf{y} \mid \bar{\mathbf{Y}}_t = \mathbf{x}, \xi_k, \tilde{\xi}_k \right) d\mathbf{y} \right|^2 d\mathbf{x} \\ &\leq \int_{\mathbb{R}^{Nd}} \bar{\rho}_t^{N,\tilde{\xi}_k}(\mathbf{x}) \int_{\mathbb{R}^{Nd}} |K_3|^2 P\left(\bar{\mathbf{X}}_{T_k} = \mathbf{y} \mid \bar{\mathbf{Y}}_t = \mathbf{x}, \xi_k, \tilde{\xi}_k \right) d\mathbf{y} d\mathbf{x} \\ &= \mathbb{E} \left[\left| e^{\hat{\mathbf{Y}}_t} - 1 - \hat{\mathbf{Y}}_t \right|^2 \mid \xi_k, \tilde{\xi}_k \right], \end{split}$$

where we denote the process

$$\begin{split} \hat{\mathbf{Y}}_t &:= \sqrt{\frac{1}{2\sigma}} \tilde{\mathbf{K}}(\bar{\mathbf{X}}_{T_k}) \cdot \left(\bar{\mathbf{Y}}_t - \bar{\mathbf{X}}_{T_k} - (t - T_k) \mathbf{F}^{\tilde{\xi}_k}(\bar{\mathbf{X}}_{T_k})\right) - \frac{1}{2} |\tilde{\mathbf{K}}(\bar{\mathbf{X}}_{T_k})|^2 \left(t - T_k\right) \\ &= -\frac{1}{2} |\tilde{\mathbf{K}}(\bar{\mathbf{X}}_{T_k})|^2 \left(t - T_k\right) + \tilde{\mathbf{K}}(\bar{\mathbf{X}}_{T_k}) \cdot \int_{T_k}^t d\mathbf{W}_s. \end{split}$$

$$\bar{\mathbf{Z}}_{t} = \frac{1}{2} \left| \tilde{\mathbf{K}} \right|^{2} (t - T_{k}) + \tilde{\mathbf{K}} \cdot \int_{T_{k}}^{t} \left(e^{\hat{\mathbf{Y}}_{s}} - 1 \right) d\mathbf{W}_{s} = \frac{1}{2} \left| \tilde{\mathbf{K}} \right|^{2} (t - T_{k}) + \tilde{\mathbf{K}} \cdot \int_{T_{k}}^{t} \left(\bar{\mathbf{Z}}_{t} + \hat{\mathbf{Y}}_{s} \right) d\mathbf{W}_{s}.$$

So

$$\mathbb{E}\left[\left|\bar{\mathbf{Z}}_{t}\right|^{2} \mid \xi_{k}, \tilde{\xi}_{k}\right] = \frac{1}{4}\mathbb{E}\left[\left|\tilde{\mathbf{K}}\right|^{2} \mid \xi_{k}, \tilde{\xi}_{k}\right] + \int_{T_{k}}^{t} \mathbb{E}\left[\left|\tilde{\mathbf{K}}\right|^{2} \left(\bar{\mathbf{Z}}_{t} + \hat{\mathbf{Y}}_{s}\right)^{2} \mid \xi_{k}, \tilde{\xi}_{k}\right] ds.$$

By Assumption 2.1, since $\tilde{\mathbf{K}}$ is uniformly bounded, then $\mathbb{E}\left|\left|\hat{\mathbf{Y}}_{t}\right|^{2} \mid \xi_{k}, \tilde{\xi}_{k}\right| \leq cN \left(t - T_{k}\right)^{2}$. Thus

C The Radon-Nikodym derivatives of path measures

The following lemma describes the relationship between the two Radon-Nikodym derivatives (of path measures and of push forward measures):

Lemma C.1 (Lemma A.1, [30]). Let Q_1, Q_2 be two probability distributions on \mathcal{X} , and Q_2 is absolutely continuous with respect to Q_1 . Let $\phi : \mathcal{X} \to \mathbb{R}^d$ be a measurable mapping, and consider the push forward measure $\phi_{\#}Q_1$ and $\phi_{\#}Q_2$, denoted by $Q_{1,\phi}$ and $Q_{2,\phi}$, respectively. Then the Randon-Nikodym derivatives $\frac{dQ_{1,\phi}}{dQ_{2,\phi}} \in L^1\left(dQ_{2,\phi}, \mathbb{R}^d\right), \frac{dQ_1}{dQ_2} \in L^1\left(dQ_2, \mathcal{X}\right)$ are welldefined, and

$$\frac{dQ_{1,\phi}}{dQ_{2,\phi}}(x) = \mathbb{E}_{X \sim Q_2} \left[\frac{dQ_1}{dQ_2} \mid \phi(X) = x \right],$$

D The Law of Large Numbers at exponential scale

The following lemma describes the Law of Large Numbers at exponential scale which is appeared in [19]:

Lemma D.1. Consider any $\rho \in L^1(\mathbb{R}^d)$ with $\rho \geq 0$ and $\int_{\mathbb{R}^d} \rho(x) dx = 1$. Assume that a scalar function $\psi \in L^{\infty}$ with $\|\psi\|_{L^{\infty}} < \frac{1}{2e}$, and that for any fixed $z, \int_{\mathbb{R}^d} \psi(z, x) \rho(x) dx = 0$, then

$$\int_{\mathbb{R}^{Nd}} \rho^N \exp\left(\frac{\eta}{N} \sum_{j_1, j_2=1}^N \psi\left(x_1, x_{j_1}\right) \psi\left(x_1, x_{j_2}\right)\right) \mathrm{d}\boldsymbol{x} \le C,$$

where $\rho^N(t, \mathbf{x}) = \prod_{i=1}^N \rho(t, x_i)$, η is an arbitrary positive number and constant C only depends on η and $\|\psi\|_{L^{\infty}}$.
