# A CLASSIFICATION OF $\mathbb{F}_{p^{k}}$-BRACES USING BILINEAR FORMS

#### Abstract

Let $\mathbb{F}_{p^{k}}$ be a finite field of odd characteristic $p$. In this paper we give a classification, up to isomorphism, of the commutative, 3-nilpotent $\mathbb{F}_{p^{k} \text {-algebras, }}$ starting from the connection with their bi-brace structure. Such classification is the generalization in odd characteristic of the result proved by Civino at al. in characteristic 2.


## 1. Introduction

Let $\mathbb{F}_{p^{k}}$ be a finite field of odd characteristic $p$ and let $V$ be an $n$-dimensional vector space over $\mathbb{F}_{p^{k}}$. Starting from elementary, abelian and regular subgroups of $\operatorname{AGL}(V,+)$ it is possible to construct an operation on $V$, denoted by $\circ$, such that the triple $(V,+, \circ)$ is a bi-brace of abelian type [13. It is well known (see e.g. [6, 7]) that there exists a bijection between bi-braces, regular subgroups of AGL $(V,+)$ normalized by $(V,+)$ and commutative, 3-nilpotent rings $(V,+, \cdot)$, where the product is defined by $a \cdot b=a \circ b-a-b$.

After the definition of braces given by Rump in 13 as a generalization of Jacobson radical rings, in recent years their study has interested many researchers due to the connections of such structures to several other algebraic research topics. Some examples of such applications are the use of braces for analyzing nondegenerate involutive set-theoretical solutions of the Yang-Baxter equation [2, 13], or even for studying the Hopf-Galois structures (see, e.g. [15,16), and regular subgroups of the holomorph (see, e.g. [1, 6]). Another interesting application of braces is the one to cryptanalysis of block ciphers, under the hypothesis that $V \cdot V$ is a one-dimensional subspace of $V$, which was recently investigated in [3, 8, 9 .

In according with the cryptanalytic application, our goal is to classify the isomorphism classes of $(V,+, \cdot)$, with $V \cdot V$ is a one-dimensional subspace. In particular we prove that the isomorphism classes of such algebras are completely determined by the equivalence classes of the symmetric bilinear forms $b: V \times V \longrightarrow \mathbb{F}_{p^{k}}$, defined by $b(a, b)=a \cdot b$. Such result generalizes in odd characteristic the classification proved in [9] for characteristic 2.

The paper is organized as follows. In Section 2 we give the necessary background on brace theory, keeping particular emphasis to the relation between twosided braces, radical rings and regular subgroups of the holomorph. In Section 3 starting from a vector space $V$ on $\mathbb{F}_{p^{k}}$, we define a skew bi-brace of abelian type, we give the properties of the associated commutative 3-nilpotent ring $(V,+, \cdot)$ and we describe the elements of the corresponding elementary abelian regular subgroup of

[^0]the holomorph of $V$. Finally, in Section 4, we show that the isomorphism classes of
 are completely determined by the equivalence classes of the bilinear forms defined by the products of $V$.

## 2. Preliminaries

In this section we give the basic notions on braces, first defined by Rump 13, and we recall some one-to-one correspondences between braces and other well-known algebraic structures.

Definition 2.1. A skew (left) brace is a triple $(G,+, \circ)$, where $(G,+)$ and $(G, \circ)$ are groups and

\begin{equation*}
a \circ(b+c)=a \circ b-a+a \circ c . \tag{2.1}
\end{equation*}
$$

A skew (right) brace is the analogous satisfying the condition

$$
\begin{equation*}
(a+b) \circ c=a \circ c-c+b \circ c \tag{2.2}
\end{equation*}
$$

A skew (left/right) brace with abelian additive group $(G,+)$ is called skew brace of abelian type (or simply (left/right) brace).

A skew brace ( $G,+, \circ$ ) is said to be a skew two-sided brace (or simply skew brace) if both Equation (2.1) and Equation (2.2) are satisfied, i.e. if it is a skew left and a skew right brace. Notice that any skew brace such that its multiplicative group $(G, \circ)$ is an abelian group is two-sided.

Throughout this paper we will always consider braces with abelian multiplicative group.

Let $(G,+, \circ)$ be a brace, it is possible to define a radical ring $(G,+, \cdot)$ by setting $a \cdot b:=a \circ b-a-b$, for $a, b \in G$ (see for example [13]).

Let us denote by $\sigma: G \longmapsto \operatorname{Sym}(G)$ the right regular representation of $(G,+)$, with $\sigma_{a}: g \mapsto g+a$. Recall that the holomorph of a group $G$ is defined as the group

$$
\operatorname{Hol}(G)=\operatorname{Aut}(G) \ltimes \sigma(G)
$$

and it is isomorphic to the normaliser $N_{\operatorname{Sym}(G)}(\sigma(G))$ of $\sigma(G)$ in $\operatorname{Sym}(G)$.
Let $T_{\circ}$ be a regular subgroup of $\operatorname{Hol}(G)$. We can give a labelling of the elements of $T_{\circ}$ by the elements of $G$ via the bijection $\tau$ defined by $a \mapsto \tau_{a}$, where $\tau_{a}$ is the unique element in $T_{\circ}$ sending 0 to $a$. Since $T_{\circ} \leq \operatorname{Hol}(G)$, then each element $\tau_{a} \in T_{\circ}$ can be written uniquely as a product of an element $\gamma_{a} \in \operatorname{Aut}(G)$ and an element $\sigma_{a} \in \sigma(G)$.

We can define the regular subgroup $(G, \circ)$ of $\operatorname{Hol}(G)$ with the operation o defined by

$$
\begin{equation*}
a \circ b:=b \tau_{a} \quad \text { for each } a, b \in G, \tag{2.3}
\end{equation*}
$$

obtaining that $(G, \circ)$ and $T_{\circ}$ are isomorphic via the bijection $\tau$. In particular, we have a one to one correspondence between braces with additive group $(G,+)$ and regular subgroups of $\operatorname{Hol}(G)$. For more details, see [1, Proposition 2.3].
Definition 2.2. A brace $(G,+, \circ)$ is called bi-brace if $(G, \circ,+)$ is also a brace.
The same construction as above gives rise to a bijection between bi-braces $(G,+, \circ$ ) and regular subgroups of $\operatorname{Hol}(G)$ normalized by $\sigma(G)$ (see [5, Theorem 3.1]).

Theorem 2.3 ( [6, 7]). Let $(G,+)$ be an abelian group. The following data are equivalent:

1. a bi-brace $(G,+, \circ)$;
2. an abelian, regular subgroup $N$ of $\operatorname{Hol}(G,+)$ normalized by $\sigma(G)$;
3. a commutative, 3-nilpotent ring $(G,+, \cdot)$.

Finally we conclude this section with the following useful definitions
Definition 2.4. The function $\gamma:(G, \circ) \longmapsto \operatorname{Aut}(G)$ defined by $\gamma_{a}: b \mapsto-a+a \circ b$ is called gamma function (for more details see e.g., [12]).

In 12 it has been proved that regular subgroups of the holomorph are in bijective correspondence with these functions.

Definition $2.5([10])$. A bi-brace $(G,+, \circ)$ is called $\mathbb{F}_{p^{k} \text {-brace }}$ if $(G,+)$ is an $\mathbb{F}_{p^{k}}$ vector space and the values of the gamma function are automorphisms of $\mathbb{F}_{p^{k} \text {-vector }}$ spaces.

It is worth to highlight that if $(G,+, \circ)$ is a two-sided brace, the notion of $\mathbb{F}_{p^{k}}$-braces coincides with the classical notion of $\mathbb{F}_{p^{k}}$-vector spaces (see Example 2 in (10]).

## 3. The setting

Let $p$ be an odd prime integer and $n \geq 2$ be a positive integer. Let $V$ be an $n$-dimensional vector space over $\mathbb{F}_{p^{k}}$. Let denote us by $\mathbb{F}_{p^{k}}^{\times}$the nonzero elements of $\mathbb{F}_{p^{k}}$. Let $\operatorname{Sym}(V)$ be the group of all the permutations on $(V,+)$ and $\operatorname{GL}(V,+)$ the group of invertible $\mathbb{F}_{p^{k} \text {-endomorphisms on }}(V,+)$. Let us denote by $T_{+}$the translation group of $(V,+)$, i.e.

$$
T_{+}=\left\{\sigma_{a}: x \mapsto x+a \mid a \in V\right\} \leq \operatorname{Sym}(V)
$$

and by $\operatorname{AGL}(V,+):=\operatorname{GL}(V,+) \ltimes T_{+}=\operatorname{Hol}(\mathrm{V})$ the affine group of $V$. It is well known that $T_{+}$is an elementary abelian regular subgroup of $\operatorname{Sym}(V)$ isomorphic to $(V,+)$ and $\operatorname{AGL}(V,+)$ is the normaliser of $T_{+}$in $\operatorname{Sym}(V,+)$.

Theorem 3.1 (Dixon). [11] Let $X$ be a finite set and $\Phi, \Psi$ be regular subgroups of $\operatorname{Sym}(X)$. If $\Phi \cong \Psi$, there exists $g \in \operatorname{Sym}(X)$ such that $\Psi=\Phi^{g}=g^{-1} \Phi g$.

Let $T_{\circ}$ be be elementary abelian regular subgroup of $\operatorname{AGL}(V,+)$. By Theorem 3.1, there exists $g \in \operatorname{Sym}(V)$ such that $T_{\circ}=T_{+}^{g}$. If $a \in V$, we can denote by $\tau_{a}$ the unique permutation in $T_{\circ}$ sending 0 to $a$, and so

$$
T_{\circ}=\left\{\tau_{a} \mid a \in V\right\}
$$

It is possible to define an abelian group $(V, \circ)$ isomorphic to $T_{\circ}$, where the operation - is defined by

$$
\begin{equation*}
a \circ b=a \tau_{b} \quad \text { for any } a, b \in V \tag{3.1}
\end{equation*}
$$

Since, by hypothesis, $T_{\circ}$ is a subgroup of $\operatorname{AGL}(V,+)$, then each element $\tau_{a} \in T_{\circ}$ can be written in a unique way as a product of an element of $G L(V,+)$ and an element of $T_{+}$, in other words

$$
\begin{equation*}
\tau_{a}=\gamma_{a} \sigma_{a} \tag{3.2}
\end{equation*}
$$

where $\gamma_{a} \in \mathrm{GL}(V,+)$ and $\sigma_{a} \in T_{+}$. Notice that the homomorphism

$$
\gamma:(V, \circ) \longmapsto \mathrm{GL}(V,+), a \mapsto\left(\gamma_{a}: b \mapsto-a+a \circ b\right)
$$

is precisely the gamma function defined in Equation (2.4), and $(V,+, \circ)$ is an $\mathbb{F}_{p^{k-}}$ brace.

Notice that for all $a, b, c \in V$

$$
\begin{aligned}
(a+b) \circ c & =(a+b) \tau_{c} \\
& =(a+b) \gamma_{c} \sigma_{c} \\
& =a \gamma_{c}+b \gamma_{c}+c \\
& =(a \circ c)+(b \circ c)-c
\end{aligned}
$$

and so, since $(V,+)$ and $(V, \circ)$ are abelian groups, $(V,+, \circ)$ is a skew brace of abelian type.

For any $a \in V$ we can define the endomorphism $\delta_{a}=\gamma_{a}-\mathbb{1}_{V}$ of $V$ and we can define a product on $V$ by

$$
\begin{equation*}
a \cdot b=a \delta_{b} \quad \text { for } b \in V \tag{3.3}
\end{equation*}
$$

Notice that by Equations (3.2) and (3.3), for every $a, b \in V$, we have

$$
\begin{equation*}
a \circ b=a+b+a \cdot b \tag{3.4}
\end{equation*}
$$

Definition 3.2. A ring $(V,+, \cdot)$ is said to be a (Jacobson) radical ring if every element $a, b \in V$ is invertible with respect to the circle operation defined by $a \circ b=$ $a+b+a \cdot b$.

Finally the following result holds (see also [6]).
Theorem 3.3. $(V,+, \cdot)$ is a commutative, associative $\mathbb{F}_{p^{k} \text {-algebra }}$ such that the resulting ring is radical.

In order to give a bi-brace structure over $(V,+, \circ)$, throughout the paper we will assume the following assumption.

Assumption 3.4. $T_{+}<\operatorname{AGL}(V, \circ) \cong \mathrm{N}_{\operatorname{Sym}(\mathrm{V})}\left(T_{\circ}\right)$.
In [6, Lemma 3], the authors proved that $\left[\sigma_{a}, \tau_{b}\right]=\sigma_{a \cdot b}$ for every $a, b \in V$, from which it follows that $T_{+}<\operatorname{AGL}(V, \circ)$ if and only if $\sigma_{a \cdot b} \in T_{0}$. Hence, under the Assumption 3.4, by Equation (3.4) we have

$$
\sigma_{a \cdot b} \in T_{\circ} \cap T_{+}=\left\{\sigma_{x} \mid x \in \operatorname{Ann}(V)\right\}
$$

where $\operatorname{Ann}(V)=\{a \in V \mid a \cdot V=0\}$ is the annihilator of the algebra $(V,+, \cdot)$. Hence $T_{+}<\operatorname{AGL}(V, \circ)$ if and only if $a \cdot b \cdot c=0$ for all $a, b, c \in V$. Therefore

$$
\begin{equation*}
V \cdot V \subseteq \operatorname{Ann}(V) \tag{3.5}
\end{equation*}
$$

and as a consequence we obtain $c \delta_{a \cdot b}=c \cdot a \cdot b=0$ for every $a, b, c \in V$, and so

$$
\gamma_{a \cdot b}=\mathbb{1}_{n} \quad \text { for all } a, b \in V
$$

By Equation (3.4), Definition 2.4 and reminding that $V^{3}=0$, we get that for all $x, a, b \in V$

$$
\begin{aligned}
x \gamma_{a+b} & =-a-b+x \circ(a+b) \\
& =-a-b+x+(a+b)+x \cdot(a+b) \\
& =x+x \cdot a+x \cdot b
\end{aligned}
$$

and

$$
\begin{aligned}
x \gamma_{a \circ b} & =-(a \circ b)+x \circ(a \circ b) \\
& =-(a+b+a \cdot b)+x \circ(a+b+a \cdot b) \\
& =-(a+b+a \cdot b)+x+(a+b+a \cdot b)+x \cdot(a+b+a \cdot b) \\
& =x+x \cdot a+x \cdot b
\end{aligned}
$$

Thus, $T_{+}<\operatorname{AGL}(V, \circ)$ if and only if

$$
\gamma_{a+b}=\gamma_{a \circ b}=\gamma_{a} \gamma_{b}
$$

from which follows that $(V,+, \circ)$ is a bi-brace. In other words we proved the following result, which generalizes [7, Proposition 4.1].
 bi-brace if and only if $V^{3}=0$.

We conclude this section constructing a matrix form for the endomorphism $\gamma_{a}$, $a \in V$. Let $\left\{e_{1}, \ldots, e_{n}\right\}$ be the canonical basis of $V$ and let us set $d$ the dimension of $\operatorname{Ann}(V)$. Without lost of generality we can assume that $\operatorname{Ann}(V)=$ $\operatorname{span}\left\{e_{m+1}, \ldots, e_{n}\right\}$ with $m=n-d$. For the case $k=1$ of the following result, see also [4, Theorem 3.11].

Theorem 3.6. For every $a \in V$ there exists a matrix $\Theta_{a} \in\left(\mathbb{F}_{p^{k}}\right)^{m \times d}$ such that

$$
\gamma_{a}=\left(\begin{array}{cc}
\mathbb{1}_{m} & \Theta_{a} \\
0 & \mathbb{1}_{d}
\end{array}\right)
$$

Moreover, $\Theta_{a}$ is the zero matrix for every $a \in \operatorname{Ann}(V)$.
Proof. Notice that $a \in \operatorname{Ann}(V)$ if and only if $a \circ b=a+b$ for all $b \in V$. It follows that $e_{j} \circ e_{i}=e_{j}+e_{i}$ for $j=m+1, \ldots, n$ and $i=1, \ldots, n$. In other words

$$
\begin{equation*}
e_{j} \circ e_{i}=e_{j} \gamma_{e_{i}}+e_{i}=e_{j}+e_{i} \tag{3.6}
\end{equation*}
$$

on the other hand for $j=1, \ldots, m$ and $i=1, \ldots, m$

$$
\begin{equation*}
e_{j} \circ e_{i}=e_{j} \gamma_{e_{i}}+e_{i}=e_{j}+e_{i}+e_{j} \cdot e_{i} \tag{3.7}
\end{equation*}
$$

where $e_{j} \cdot e_{i} \in \operatorname{Ann}(V)=\operatorname{span}\left\{e_{m+1}, \ldots, e_{n}\right\}$. Thus, by Equation (3.6) and (3.7) we obtain

$$
\gamma_{e_{i}}=\left(\begin{array}{cc}
\mathbb{1}_{m} & \Theta_{e_{i}} \\
0 & \mathbb{1}_{d}
\end{array}\right) \text { for } i=1, \ldots, m
$$

and $\gamma_{e_{i}}=\mathbb{1}_{n}$ for $i=m+1, \ldots, n$. Moreover, denoting by $\Theta_{i, j}$ the $j$-th row of the matrix $\Theta_{i}$, we get that $e_{i} \cdot e_{j}=(\underbrace{0, \ldots, 0}_{m}, \Theta_{i, j})$. Finally, for every $a=$ $a_{1} e_{1}+\cdots+a_{n} e_{n} \in V$

$$
\gamma_{a}=\left(\begin{array}{cc}
\mathbb{1}_{m} & a_{1} \Theta_{e_{1}}+\cdots+a_{m} \Theta_{e_{m}} \\
0 & \mathbb{1}_{d}
\end{array}\right)
$$

## 4. Isomorphism classes of $(V,+, \cdot)$

In this section $(V,+, \cdot)$ will denote an $n$-dimensional commutative, 3-nilpotent $\mathbb{F}_{p^{k} \text {-algebra }}$ with product defined in Eq. (3.3) and $\operatorname{Ann}(V)=\operatorname{span}\left\{e_{m+1}, \ldots, e_{n}\right\}$ of dimension $d=n-m$. Let $\Theta_{i}$ be the $m \times d$ matrix with entries in $\mathbb{F}_{p^{k}}$ associated to the vector $e_{i}$ of the canonical basis of $V$, defined in Theorem 3.6. Recall that $\Theta_{j}=0$ for $j=m+1, \ldots, n$.

Definition 4.1. We shall say that the $m \times m$ matrix $\Theta:=\left[\Theta_{1} \ldots \Theta_{m}\right]$ with entries in $\left(\mathbb{F}_{p^{k}}\right)^{d}$ is the defining matrix with respect to the canonical basis $\left\{e_{1}, \ldots, e_{n}\right\}$ for the algebra $(V,+, \cdot)$.
Lemma 4.2. The defining matrix $\Theta$ of the algebra $(V,+, \cdot)$ has the following properties:
(1) $\Theta$ is symmetric;
(2) each $\mathbb{F}_{p^{k}}$-linear combination of $\Theta_{1}, \ldots, \Theta_{m}$ is non-zero, except the one with all zero coefficients.
Proof. By Theorem 3.6, we have $e_{i} \cdot e_{j}=(\underbrace{0, \ldots, 0}_{m}, \Theta_{i, j})$ and, since $(V,+, \cdot)$ is a commutative algebra, $\Theta_{i, j}=\Theta_{j, i}$ and so $\Theta$ is symmetric.

Let us suppose that a non trivial $\mathbb{F}_{p^{k}}$-linear combination of $\Theta_{1}, \ldots, \Theta_{m}$ is nonzero, in other words let

$$
\sum_{i=1}^{m} a_{i} \Theta_{i}=0 \quad \text { with } a_{i} \in \mathbb{F}_{p^{k}} \text { and } a_{s} \neq 0, \text { for some } s \in\{1, \ldots, m\}
$$

Then

$$
\gamma_{a_{1} e_{1}+\cdots+a_{m} e_{m}}=\left(\begin{array}{cc}
\mathbb{1}_{m} & a_{1} \Theta_{1}+\cdots+a_{m} \Theta_{m} \\
0 & \mathbb{1}_{d}
\end{array}\right)=\mathbb{1}_{n}
$$

and $a_{1} e_{1}+\cdots+a_{m} e_{m} \in \operatorname{Ann}(V)$, which is a contradiction since $\operatorname{Ann}(V)=$ $\operatorname{span}\left\{e_{m+1}, \ldots, e_{n}\right\}$.

Conversely we have the following.
Theorem 4.3. Any $m \times m$ symmetric matrix $\Theta=\left[\Theta_{1}, \ldots, \Theta_{m}\right]$, with entries in $\left(\mathbb{F}_{p^{k}}\right)^{d}$, such that each non trivial $\mathbb{F}_{p^{k}}$-linear combination of $\Theta_{1}, \ldots, \Theta_{m}$ is nonzero, is the defining matrix with respect to the canonical basis of a commutative, 3nilpotent $\mathbb{F}_{p^{k} \text {-algebra, with }} \operatorname{Ann}(V)=\operatorname{span}\left\{e_{m+1}, \ldots, e_{n}\right\}$ of dimension $d=n-m$.

Proof. Let $\Theta$ be an $m \times m$ symmetric matrix with entries in $\left(\mathbb{F}_{p^{k}}\right)^{d}$ such that each $\mathbb{F}_{p^{k}}$-linear combination of its columns $\Theta_{1}, \ldots, \Theta_{m}$ is non-zero, except the one with all zero coefficients.

For $a=a_{1} e_{1}+\cdots+a_{n} e_{n} \in V$, let us define the map $\tau_{a}=\gamma_{a} \sigma_{a}$, where

$$
\gamma_{a}=\left(\begin{array}{cc}
\mathbb{1}_{m} & a_{1} \Theta_{1}+\cdots+a_{m} \Theta_{m} \\
0 & \mathbb{1}_{d}
\end{array}\right)
$$

and $\sigma_{a}$ is the translation of $(V,+)$ sending $0 \mapsto a$. Let

$$
T_{\circ}=\left\{\tau_{a} \mid a \in V\right\}<\operatorname{AGL}(V,+)
$$

and $\circ$ be the operation induced by $T_{\circ}$ on $V$ as in Equation (3.1).
By Theorem 2.3 and Proposition 3.5, in order to prove that $(V,+, \cdot)$ is a commutative, 3-nilpotent algebra, it is enough to prove that $T_{\circ}$ is an abelian regular subgroup of $\operatorname{AGL}(V,+)$ normalized by $T_{+}=\left\{\sigma_{a} \mid a \in V\right\}$.

- $T_{\circ}$ is a group. The neutral element is $\tau_{0}=\mathbb{1}_{V}$ and $\circ$ is associative by definition. We claim that $\tau_{x}^{-1}=\tau_{x}^{p-1}$. Indeed, for every $a, b \in V$ we have

$$
\begin{aligned}
a \underbrace{\tau_{b} \ldots \tau_{b}}_{p-\text { times }} & =a \underbrace{\gamma_{b} \ldots \gamma_{b}}_{p}+b \underbrace{\gamma_{b} \ldots \gamma_{b}}_{p-1}+\cdots+b \gamma_{b}+b \\
& =a+b(\underbrace{\gamma_{b} \ldots \gamma_{b}}_{p-1}+\underbrace{\gamma_{b} \ldots \gamma_{b}}_{p-2}+\cdots+\gamma_{b}+\mathbb{1}_{n}),
\end{aligned}
$$

since $\gamma_{b}^{p}=\gamma_{p b}=\mathbb{1}_{n}$. Notice that $1+\cdots+(p-1)=\frac{(p-1) p}{2}=k p$, for $k=\frac{p-1}{2}$ positive integer. Thus

$$
\begin{aligned}
\underbrace{\gamma_{b} \ldots \gamma_{b}}_{p-1}+\underbrace{\gamma_{b} \ldots \gamma_{b}}_{p-2}+\cdots+\gamma_{b} & =\left(\begin{array}{cc}
(p-1) \mathbb{1}_{m} & \sum_{i=1}^{p-1} \Theta_{b} \\
0 & (p-1) \mathbb{1}_{d}
\end{array}\right) \\
& =\left(\begin{array}{cc}
(p-1) \mathbb{1}_{m} & 0 \\
0 & (p-1) \mathbb{1}_{d}
\end{array}\right)
\end{aligned}
$$

and so $\underbrace{\gamma_{b} \ldots \gamma_{b}}_{p-1}+\underbrace{\gamma_{b} \ldots \gamma_{b}}_{p-2}+\cdots+\gamma_{b}+\mathbb{1}_{n}=0$. It follows that $a \underbrace{\tau_{b} \ldots \tau_{b}}_{p}=a$.

- $T_{\circ}$ is abelian. Indeed, for every $a, b, c \in V$

$$
\begin{aligned}
a \tau_{c} \tau_{b}=a \gamma_{c} \sigma_{c} \gamma_{b} \sigma_{b} & =a \gamma_{c} \gamma_{b}+c \gamma_{b}+b \\
& =a \gamma_{b} \gamma_{c}+b \gamma_{c}+c \\
& =a \tau_{b} \tau_{c} .
\end{aligned}
$$

- $T_{\circ}$ is regular, or in other words, for every $a, b \in V$ there exists a unique $c \in V$ such that $a \tau_{c}=b$. We claim that $c=a \underbrace{\tau_{a} \ldots \tau_{a}}_{p-2} \tau_{b}$. Indeed,

$$
\begin{aligned}
a \tau_{c} & =a \tau_{a \tau_{a} \ldots \tau_{a} \tau_{b}}=a \gamma_{a \gamma_{a} \sigma_{a} \ldots \gamma_{a} \sigma_{a} \gamma_{b} \sigma_{b}} \sigma_{a \tau_{a} \ldots \tau_{a} \tau_{b}} \\
& =a \gamma_{a} \underbrace{\gamma_{a} \ldots \gamma_{a}}_{p-2} \gamma_{b}+a \underbrace{\gamma_{a} \ldots \gamma_{a}}_{p-3} \gamma_{b}+\cdots+a \gamma_{b}+b+ \\
& +a \underbrace{\gamma_{a} \ldots \gamma_{a}}_{p-2} \gamma_{b}+a \underbrace{\gamma_{a} \ldots \gamma_{a}}_{p-3} \gamma_{b}+\cdots+a \gamma_{a} \gamma_{b}+a \gamma_{b}+b .
\end{aligned}
$$

Notice that for every $a, b \in V$ we have

$$
\gamma_{a \gamma_{b}}=\gamma_{-b+b \circ a}=\gamma_{-b} \gamma_{b} \gamma_{a}=\gamma_{a} .
$$

Therefore

$$
\begin{aligned}
a \tau_{c} & =a \underbrace{\gamma_{a} \ldots \gamma_{a}}_{p-1} \gamma_{b}+a \underbrace{\gamma_{a} \ldots \gamma_{a}}_{p-2} \gamma_{b}+\cdots+a \gamma_{a} \gamma_{b}+a \gamma_{b}+b \\
& =a(\underbrace{\gamma_{a} \ldots \gamma_{a}}_{p-1}+\underbrace{\gamma_{a} \ldots \gamma_{a}}_{p-2}+\gamma_{a}+\mathbb{1}_{n}) \gamma_{b}+b \\
& =b .
\end{aligned}
$$

Let us assume by contradiction that $c$ is not unique. Let $\bar{c} \in V$, with $\bar{c} \neq c$, such that $a \tau_{\bar{c}}=b$ or analogously that $\bar{c} \tau_{a}=b$.

$$
\bar{c}=b \tau_{a}^{-1}=b \underbrace{\tau_{a} \ldots \tau_{a}}_{p-1}=a \tau_{b} \underbrace{\tau_{a} \ldots \tau_{a}}_{p-2}=a \underbrace{\tau_{a} \ldots \tau_{a}}_{p-2} \tau_{b}=c .
$$

- $T_{+}<N_{\operatorname{Sym}(V)}\left(T_{\circ}\right)$, or in other words, for every $a, b \in V, \sigma_{a} \tau_{b} \sigma_{a}^{-1} \in T_{\circ}$. Indeed

$$
\begin{aligned}
x \sigma_{a} \tau_{b} \underbrace{\sigma_{a} \ldots \sigma_{a}}_{p-1} & =(x+a) \gamma_{b} \sigma_{b} \sigma_{a} \ldots \sigma_{a} \\
& =x \gamma_{b}+a \gamma_{b}+b+\underbrace{a+\cdots+a}_{p-1} \\
& =x \tau_{a \gamma_{b}+b+(p-1) a}
\end{aligned}
$$

since $\gamma_{a \gamma_{b}+b+(p-1) a}=\gamma_{a} \gamma_{b} \gamma_{(p-1) a}=\gamma_{b}$.
In the rest of the present section we consider true the following assumption, that allow us to study the product in $V$ as a standard symmetric bilinear form.

Assumption 4.4. $V \cdot V$ is a one-dimensional subspace of $V$.
Let us define the symmetric bilinear form

$$
\begin{aligned}
b: & V \times V \\
& \longrightarrow \mathbb{F}_{p^{k}} \\
(a, b) & \longmapsto
\end{aligned}
$$

The following result directly follows from Lemma 4.2,
Corollary 4.5. If $V \cdot V$ is a one-dimensional subspace of $V$, then $\Theta$ is an $m \times m$ invertible matrix with coefficients in $\mathbb{F}_{p^{k}}$.
Remark 4.6. Notice that $\operatorname{Rad}(b)=\{a \in V \mid b(a, V)=0\}$ coincides with $\operatorname{Ann}(V)=$ $\{a \in V \mid a \cdot V=0\}$. So, by Equation (3.5), we can decompose the annihilator $\operatorname{Ann}(V)=(V \cdot V) \oplus H$, for a suitable $(d-1)$-dimensional subspace $H$ of $V$. Thus, up to consider the quotient algebra $(V / H,+, \cdot)$, we can assume that $V \cdot V$ coincides with $\operatorname{Ann}(V)$ and spanned by the last vector of the canonical basis. We obtain the following decomposition of $V$

$$
V=W \oplus(V \cdot V)
$$

where $V \cdot V=\operatorname{span}\left\{e_{n}\right\}$.
We notice that $\Theta=\left[\Theta_{1}, \ldots, \Theta_{n-1}\right]$ is the matrix associated to the bilinear form $b$ restricted to the subspace $W$ of $V$ defined above.

Before proving the main theorem of this work, we recall some useful general definitions and some well known results concerning the classification of bilinear forms over finite fields of odd characteristic.

Definition 4.7. Let $b$ a nondegenerate symmetric bilinear form on an $\mathbb{F}_{p^{k} \text {-vector }}$ space with associated matrix $B$. The discriminant of $b$ is defined to be the coset $\operatorname{det}(B) \mathbb{F}_{p^{k}}^{\times 2}$ in $\mathbb{F}_{p^{k}}^{\times} / \mathbb{F}_{p^{k}}^{\times 2}$.
Theorem 4.8. 14, Proposition 5, pg. 34] Let b be a nondegenerate symmetric bilinear form on $a \overline{\mathbb{F}}_{p^{k} \text {-vector space } V \text { of dimension strictly bigger than } 1 \text {, then there }}$ exists a basis for $V$ such that the matrix $B$ associated to $b$ has one of the following non-equivalent diagonal form

$$
\left[\begin{array}{cccc}
1 & 0 & 0 & 0 \\
0 & 1 & 0 & \vdots \\
\vdots & 0 & \ddots & 0 \\
0 & \cdots & 0 & 1
\end{array}\right] \text { or }\left[\begin{array}{cccc}
1 & 0 & 0 & 0 \\
0 & \ddots & 0 & \vdots \\
\vdots & 0 & 1 & 0 \\
0 & \cdots & 0 & q
\end{array}\right]
$$

where $q$ is a non-square element of $\mathbb{F}_{p^{k}}$.
Corollary 4.9. 14, Corollary of Proposition 5, pg. 35] For two nondegenerate bilinear forms over $\mathbb{F}_{p^{k}}$ to be equivalent it is necessary and sufficient that they have the same rank and same discriminant.

We are ready to prove the one to one correspondence between the isomorphism classes of $(V,+, \cdot)$ and congruence classes of the corresponding defining matrices.

Theorem 4.10. Let $\left(V,+, \cdot_{1}\right)$ and $\left(V,+, \cdot{ }_{2}\right)$ be two commutative, 3-nilpotent $\mathbb{F}_{p^{k}-}$ algebras with $V \cdot{ }_{1} V=V \cdot{ }_{2} V=\operatorname{span}\left\{e_{n}\right\}$. A matrix with block form

$$
\left(\begin{array}{cc}
A & 0 \\
0 & l
\end{array}\right), \quad A \in G L\left(m, p^{k}\right), l \in\{1, q\}
$$

is an isomorphism between the algebras $\left(V,+,{ }_{1}\right)$ and $\left(V,+, \cdot_{2}\right)$ if and only if

$$
\begin{equation*}
A \Theta^{1} A^{t r}=l \Theta^{2} \tag{4.1}
\end{equation*}
$$

where $\Theta^{1}$ and $\Theta^{2}$ are the defining matrices of the algebras $\left(V,+, \cdot{ }_{1}\right)$ and $\left(V,+,{ }_{2}\right)$ respectively and $q$ is a non-square element of $\mathbb{F}_{p^{k}}$.

Proof. Let $A$ be an $(n-1) \times(n-1)$ invertible matrix and $l \in \mathbb{F}_{p^{k}}^{\times}$such that $A \Theta^{1} A^{t r}=l \Theta^{2}$. For $i, j=1, \ldots, n-1$

$$
\begin{aligned}
e_{i}\left(\begin{array}{cc}
A & 0 \\
0 & l
\end{array}\right) \cdot 1 e_{j}\left(\begin{array}{cc}
A & 0 \\
0 & l
\end{array}\right) & =\left(A_{i}, 0\right) \cdot 1\left(A_{j}, 0\right) \\
& =(\underbrace{0, \ldots, 0}_{n-1}, A_{i} \Theta_{i, j}^{1} A_{j}^{t r}) \\
& =\left(0, \ldots, 0, l \Theta_{i, j}^{2}\right) \\
& =\left(0, \ldots, 0, \Theta_{i, j}^{2}\right)\left(\begin{array}{cc}
A & 0 \\
0 & l
\end{array}\right) \\
& =e_{i} \cdot 2 e_{j}\left(\begin{array}{cc}
A & 0 \\
0 & l
\end{array}\right) .
\end{aligned}
$$

Viceversa if $\left(\begin{array}{cc}A & 0 \\ 0 & l\end{array}\right)$ is an isomorphism between $\left(V,+, \cdot_{1}\right)$ and $\left(V,+, \cdot_{2}\right)$ then

$$
e_{i}\left(\begin{array}{cc}
A & 0 \\
0 & l
\end{array}\right) \cdot 1 e_{j}\left(\begin{array}{cc}
A & 0 \\
0 & l
\end{array}\right)=e_{i} \cdot 2 e_{j}\left(\begin{array}{cc}
A & 0 \\
0 & l
\end{array}\right)
$$

Lastly , if $\left(V,+, \cdot_{1}\right)$ and $\left(V,+, \cdot_{2}\right)$ satisfies Equation (4.1) for some invertible matrix $A$, then the bilinear forms associated to the products are equivalent. By Corollary 4.9, it is enough to consider $l \in \mathbb{F}_{p^{k}}^{\times} / \mathbb{F}_{p^{k}}^{\times 2}$ or equivalently $l \in\{1, q\}$, where $q$ is a pre-selected non-square of $\mathbb{F}_{p^{k}}$.

We are now ready to give a complete classification of the isomorphism classes of commutative, 3-nilpotent $\mathbb{F}_{p^{k}}$-algebras $(V,+, \cdot)$ with $V \cdot V$ of dimension 1.

Theorem 4.11. Let $(V,+, \cdot)$ be an $\mathbb{F}_{p^{k-a l g e b r a ~}}$ as above. If $V \cdot V$ is an onedimensional subspace of $V$, then there are two isomorphism classes of the algebra if $n-1$ is even and there is one class is $n-1$ is odd.

Proof. By Theorem 4.8 it is enough to fix

$$
\Theta^{1}=\left[\begin{array}{cccc}
1 & 0 & 0 & 0 \\
0 & 1 & 0 & \vdots \\
\vdots & 0 & \ddots & 0 \\
0 & \cdots & 0 & 1
\end{array}\right], \Theta^{2}=\left[\begin{array}{cccc}
1 & 0 & 0 & 0 \\
0 & \ddots & 0 & \vdots \\
\vdots & 0 & 1 & 0 \\
0 & \cdots & 0 & q
\end{array}\right]
$$

and by Proposition 4.10 it is enough to check whenever $\Theta^{1}$ and $q \Theta^{2}$ represent equivalent bilinear forms.

- If $n-1$ is even, then $\operatorname{det}\left(\Theta^{1}\right)=1$ is a square and $\operatorname{det}\left(q \Theta^{2}\right)=q^{n}$ is not a square. Then $\Theta^{1}$ and $q \Theta^{2}$ are not congruent.
- If $n-1$ is odd, then $\operatorname{det}\left(\Theta^{1}\right)=1$ is a square and $\operatorname{det}\left(q \Theta^{2}\right)=q^{n}$ is a square. Then $\Theta^{1}$ and $q \Theta^{2}$ are congruent.

In conclusion, we notice that Theorem 4.10 and Theorem 4.11 only depend on the defining matrix of the algebras. Therefore the isomorphism classes of $(V,+, \cdot)$ are in one to one correspondence to the isomorphism classes of $V / H$, defined in Remark 4.6. In other words the obtained results hold also in the case of an algebra $(V,+, \cdot)$ with $V \cdot V$ of dimension one and $\operatorname{Ann}(V)$ of any dimension.
