### A Short Note on the Infinity Product Tan (z) Function

Abstract: We derive the infinite product of the tangent function, Tan(z), expressed in terms of trigonometric expressions such as Euler's Sinc function and Viète's formula, along with their generalizations. All the results presented in this work are novel.

### 1. Introduction

Infinite product (1) was previously published by Viète in 1593, based on geometric considerations. A detailed compendium, including analysis and evaluations of infinite products of elementary functions in terms of trigonometric functions, can be found in the classical literature

$$\prod_{k=0}^{\infty} \cos\left(\pi 2^{-k-2}\right) = \frac{2}{\pi} \tag{1}$$

Viète's formula is the following infinite product of nested radicals

$$\frac{1}{8}\sqrt{\frac{1}{2}(\sqrt{2}+2)(\sqrt{\sqrt{2}+2}+2)(\sqrt{\sqrt{\sqrt{2}+2}+2}+2)} = \frac{2}{\pi}$$

Viète's formula may be obtained as a special case of a formula for the sinc function that has often been attributed to Leonhard Euler[1], more than a century later:

$$\prod_{k=0}^{\infty} \cos\left(2^{-k-1}z\right) = \frac{\sin(z)}{z} \tag{3}$$

expressing each term of the product on the left as a function of earlier terms using the half-angle formula:

$$\cos\left(\frac{z}{2}\right) = \sqrt{\frac{1}{2}(\cos(z)+1)} \tag{4}$$

gives Viète's formula

This formula has been generalization obtained through use of both Chebyshev polynomial and Fourier transformation (see Nishimura [3] and Kent E. Morrison [2]) for integer  $q \ge 2$ . As

$$\prod_{j=0}^{\infty} \frac{\sum_{n=1}^{q} \cos\left(\frac{(2n-1)z}{(2q)^{j+1}}\right)}{q} = \frac{\sin(z)}{z}$$
(5)

This can be written in more compact way

$$\prod_{k=0}^{\infty} \frac{\sin\left(zq^{-k}\right)\csc\left(zq^{-k-1}\right)}{q} = \operatorname{sinc}(z) \tag{6}$$

# 2. The Tan Function

We present two new generalizations of the infinite product of the tangent function in the style of Leonhard Euler's  $\operatorname{sinc}(z)$  type.  $q \ge 2$ .

$$\prod_{k=0}^{\infty} 2^{-\left((q-1)q^k\right)} q^{-q^k(k(q-1)+q)} z^{(q-1)q^k} \cot^{q^{k+1}}\left(\frac{1}{2}zq^{-k-1}\right) \cot^{-q^k}\left(\frac{zq^{-k}}{2}\right) = \frac{2\tan\left(\frac{Z}{2}\right)}{z}$$
(7)

And the equivalent convergent product

$$\prod_{k=0}^{\infty} \frac{\tan\left(\frac{zq^{-k}}{2}\right)\cot\left(\frac{1}{2}zq^{-k-1}\right)}{q} = \frac{2\tan\left(\frac{z}{2}\right)}{z} \tag{8}$$

## 3. Generalization.

It is possible to generalize (7) and (8) so that n and m are integers  $\{n, m\} \ge 0$ as following:

$$\prod_{k=m}^{n-1} 2^{-\left((q-1)q^k\right)} q^{-q^k(k(q-1)+q)} z^{(q-1)q^k} \sin^{-q^{k+1}} \left(\frac{1}{2}zq^{-k-1}\right) \sin^{q^k} \left(\frac{zq^{-k}}{2}\right) \cos^{q^{k+1}} \left(\frac{1}{2}zq^{-k-1}\right) \cos^{-q^k} \left(\frac{zq^{-k}}{2}\right)$$

And

$$\prod_{k=m}^{n-1} \frac{\tan\left(\frac{zq^{-k}}{2}\right) \cot\left(\frac{1}{2}zq^{-k-1}\right)}{q}$$
(10)
$$= q^{m-n} \tan\left(\frac{zq^{-m}}{2}\right) \cot\left(\frac{zq^{-n}}{2}\right)$$

For brevity, we employ mathematical induction to prove the case of Formula (10) when q = 2 and m = 0

Proof: starting with

$$\prod_{k=0}^{n-1} \frac{1}{2} \tan\left(2^{-k-1}z\right) \cot\left(2^{-k-2}z\right) = 2^{-n} \tan\left(\frac{z}{2}\right) \cot\left(2^{-n-1}z\right)$$
(11)

Step 1: Base Case n=1 We need to show that the formula holds for n=1 : the left-hand side LHS becomes:

$$\frac{1}{2}\tan(2^{-1-1}z)\cot(2^{-1-2}z) = \frac{1}{2}\tan\left(\frac{z}{2}\right)\cot\left(\frac{z}{4}\right)$$
(12)

The right-hand side RHS becomes:

$$2^{-1}\tan\left(\frac{z}{2}\right)\cot\left(2^{-1-1}z\right) = \frac{1}{2}\tan\left(\frac{z}{2}\right)\cot\left(\frac{z}{4}\right) \tag{13}$$

The LHS and RHS are equal for the base case.

Step 2: Inductive Hypothesis Assume that the formula is true for some arbitrary positive integer n:

$$\prod_{k=0}^{n-1} \frac{1}{2} \tan\left(2^{-k-1}z\right) \cot\left(2^{-k-2}z\right) = 2^{-k} \tan\left(\frac{z}{2}\right)$$
(14)

Step 3: Inductive Step We need to prove that the formula holds for n+1 : Consider the LHS for  ${\rm n}+1$  :

$$\prod_{k=0}^{n} \frac{1}{2} \tan\left(2^{-k-1}z\right) \cot\left(2^{-k-2}z\right)$$
(15)

Multiply both sides by  $\left(\frac{1}{2}\tan\left(2^{-n-1}z\right)\cot\left(2^{-n-2}z\right)\right)$ :

$$\left(\prod_{k=0}^{n-1} \frac{1}{2} \tan\left(2^{-k-1}z\right) \cot\left(2^{-k-2}z\right)\right) \cdot \frac{1}{2} \tan\left(2^{-n-1}z\right) \cot\left(2^{-n-2}z\right)$$
(16)

Using the inductive hypothesis, the RHS simplifies to:

$$2^{-k} \tan\left(\frac{Z}{2}\right) \cot\left(2^{-n-1}z\right) \cdot \frac{1}{2} \tan\left(2^{-n-1}z\right) \cot\left(2^{-n-2}z\right)$$
(17)

Simplify the RHS:

$$2^{-n-1}\tan\left(\frac{Z}{2}\right)\cot\left(2^{-n-1}z\right) \tag{18}$$

The RHS matches the LHS for (n + 1).

Therefore, by mathematical induction, the given formula holds for all positive integers (n)

Example 1. Infinitely nested radicals

Using several values for *n* Integers  $\frac{2n \tan(\frac{\pi}{2n})}{\pi}$  in formula (10) get the following tables:

Product $\infty$	Result
$\frac{1}{4}\sqrt{\frac{2+\sqrt{2+\sqrt{2}}}{2-\sqrt{2+\sqrt{2}}}}\cdots$	$\frac{4}{\pi}$
$\frac{(2-\sqrt{3})(2+\sqrt{3})\left(\frac{1}{4}\sqrt{3(2-\sqrt{2})}(1+\sqrt{2})+\frac{1}{4}(-1+\sqrt{2})\sqrt{2+\sqrt{2}}\right)}{4\sqrt{3}\left(\frac{1}{4}\sqrt{2-\sqrt{2}}(1+\sqrt{2})-\frac{1}{4}(-1+\sqrt{2})\sqrt{3(2+\sqrt{2})}\right)}\cdots$	$\frac{2\sqrt{3}}{\pi}$
$\frac{1}{4}\sqrt{\frac{(2-\sqrt{2})(2+\sqrt{2+\sqrt{2}+\sqrt{2}})}{(2+\sqrt{2})(2-\sqrt{2+\sqrt{2}+\sqrt{2}})}}\cdots$	$\frac{8\sqrt{\frac{2-\sqrt{2}}{2+\sqrt{2}}}}{\pi}$
$\frac{\sqrt{1-\frac{2}{\sqrt{5}}}\left(\frac{1}{8}(-1+\sqrt{2})\sqrt{2+\sqrt{2}}(-1+\sqrt{5})+\frac{1}{4}(1+\sqrt{2})\sqrt{\frac{1}{2}(2-\sqrt{2})(5+\sqrt{5})}\right)}{4\left(-\frac{1}{8}\sqrt{2-\sqrt{2}}(1+\sqrt{2})(-1+\sqrt{5})+\frac{1}{4}(-1+\sqrt{2})\sqrt{\frac{1}{2}(2+\sqrt{2})(5+\sqrt{5})}\right)}\cdots$	$\frac{10\sqrt{1-\frac{2}{\sqrt{5}}}}{\pi}$
	$\frac{12(2-\sqrt{3})}{\pi}$
$\frac{1}{4}\sqrt{\frac{(2-\sqrt{2+\sqrt{2}})(2+\sqrt{2+\sqrt{2+\sqrt{2}}})}{(2+\sqrt{2+\sqrt{2}})(2-\sqrt{2+\sqrt{2+\sqrt{2}}})}}\cdots$	$\frac{16\sqrt{\frac{2-\sqrt{2+\sqrt{2}}}{2+\sqrt{2}+\sqrt{2}}}}{\pi}$
