# THE 2-ADIC VALUATIONS OF THE ALGEBRAIC CENTRAL *L*-VALUES FOR QUADRATIC TWISTS OF WEIGHT 2 NEWFORMS

ABSTRACT. Let f be a normalized newform of weight 2 on  $\Gamma_0(N)$  whose coefficients lie in  $\mathbb{Q}$  and let  $\chi_M$  be a primitive quadratic Dirichlet character with conductor M. In this paper, under mild assumptions on M, we give a sharp lower bound of the 2-adic valuation of the algebraic central L-value  $L(f, \chi_M, 1)$  and evaluate the 2-adic valuation for an infinite number of M.

## 1. INTRODUCTION

The aim of this paper is to give a sharp lower bound of the 2-adic valuations of the algebraic central L-values for a certain family of quadratic twists of an elliptic curve defined over  $\mathbb{Q}$ . The 2-adic valuation of the algebraic central L-value for an elliptic curve deeply relates to the order of the 2-primary part of the Tate–Shafarevich group if the analytic rank of the elliptic curve is zero. Also, according to the Goldfeld conjecture, it is expected that the density of square-free integers m with the analytic ranks of quadratic twists of an elliptic curve by the extension  $\mathbb{Q}(\sqrt{m})/\mathbb{Q}$  be 0 is equal to 1/2. Therefore, we also aim to evaluate the 2-adic valuations for an infinite number of quadratic twists.

In [12] and [13], Zhao gave a lower bound of the 2-adic valuations of the algebraic parts for a family of CM elliptic curves of the form  $y^2 = x^3 - D^2 x$  under some assumptions on D. His method using induction on the number of prime divisors of D is highly versatile and currently has been applied to various elliptic curves. For example in [7], the second author of this paper calculated the 2-adic valuations for a wider family of elliptic curves than the one discussed by Zhao. Kezuka [4] applied Zhao's method to a certain family of elliptic curves having complex multiplication by  $\mathbb{Z}[(-1 + \sqrt{-3})/2]$ . For elliptic curves having complex multiplication by  $\mathbb{Z}[(-1 + \sqrt{-3})/2]$ , there are Coates–Li's result [2] and Coates–Kim–Liang–Zhao's result [3].

There are also several works, using Zhao's method, on elliptic curves defined over  $\mathbb{Q}$  that do not necessarily have complex multiplication. In [8], Zhai evaluated the 2-adic valuations for a family of quadratic twists  $E^{(m)}$  of elliptic curves when m satisfies  $m \equiv 1 \mod 4$  and additional assumptions. He gave the lower bound of the 2-adic valuations for a similar family of quadratic twists in [10]. Cai–Li–Zhai [1] determined the 2-adic valuations for a certain family of quadratic twists  $E^{(m)}$  with  $m \equiv 1 \mod 4$ . In [9], Zhai also gave a stronger lower bound of the 2-adic valuations for a subfamily of [10] and determined the 2-adic valuation in some cases by combining the result of [1]. Moreover, Zhai gave lower bounds of the 2-adic valuations in terms of local Tamagawa factors in [11]. All results mentioned here calculated only for quadratic twists  $E^{(m)}$  where  $m \equiv 1 \mod 4$ . In this paper, we give lower bounds of 2-adic valuations in general setting, including the case  $m \equiv 3 \mod 4$  and most of the cases discussed in [8], [10], [1] and [9].

Before stating theorems, we introduce several notations (See §2 for details). By the modularity theorem, a  $\mathbb{Q}$ -isogeny class of an elliptic curve E defined over  $\mathbb{Q}$  corresponds to a normalized Hecke eigenform  $f \in S_2(\Gamma_0(N))^{\text{new}}$ , namely  $L(E/\mathbb{Q}, s) = L(f, s)$ . Therefore, in the rest of the paper, we write almost everything in terms of f. Let  $m \geq 1$  be a square-free odd integer and  $\varepsilon \in \{\pm 1\}$ . Then, the L-function of the quadratic twist  $E^{(\varepsilon m)}$  is equal to the twisted L-function  $L(f, \chi_M, s)$ . Here,  $\chi_M$  is a

primitive quadratic character with conductor M, where M is given by

$$M = \begin{cases} m & (\varepsilon m \equiv 1 \mod 4), \\ 4m & (\varepsilon m \equiv 3 \mod 4). \end{cases}$$

Denote the period lattice associated to f by  $\mathcal{L}_f$ . Then, there exist periods  $\Omega_f^{\pm} \in \mathbb{R}$  such that

$$\mathcal{L}_f = \Omega_f^+ \mathbb{Z} + i\Omega_f^- \mathbb{Z}, \quad \text{or} \quad \mathcal{L}_f = \Omega_f^+ \mathbb{Z} + \frac{\Omega_f^+ + i\Omega_f^-}{2}$$

We define the set of prime numbers as

$$\mathcal{S}_i \coloneqq \{q : \text{odd prime} \mid q \nmid N, v_2(a_q - 2) = i\},\$$

where  $a_q$  is the q-th Fourier coefficient of f and  $v_2$  is the 2-adic valuation of  $\overline{\mathbb{Q}}$  normalized so that  $v_2(2) = 1$ . The main result is the following.

**Theorem 1.1.** Assume that the Manin constant for E is equal to 1 (See §2). Write  $M = 4^n m = 4^n q_1 \cdots q_r$ , where  $n \in \{0, 1\}$  and  $q_1, \ldots, q_r$  are distinct odd primes. We set  $\mathfrak{v}_m := \min_{1 \le i \le r} \{v_2(a_{q_i} - 2)\}$ . We put  $\mathfrak{w}_m$  as 0 if  $\mathfrak{v}_m = 0$  and 1 otherwise. If  $q_i \in S_0 \cup S_1 \cup S_2$  for all i, there exists an integer c independent of r such that

$$v_2\left(\frac{L(f,\chi_M,1)}{\Omega_f^{\mathrm{sgn}(\chi_M)}}\right) \ge \mathfrak{w}_m \cdot r + c.$$
(1)

Moreover, there exists an infinitely many M for which the equality of (1) holds. Hence, the Mordell–Weil group  $E^{(\varepsilon m)}(\mathbb{Q})$  and the Tate–Shafarevich group  $\operatorname{III}(E^{(\varepsilon m)}/\mathbb{Q})$  are finite for such M.

**Remark 1.2.** In Theorem 1.1, the integer c is given explicitly. In addition, some of the conditions that the equality holds can be written explicitly in terms of  $v_2(L(f, 1)/\Omega_f^+)$ ,  $v_2(L(f, \chi_4, 1)/\Omega_f^-)$  and  $q_i \mod 4$ . More precisely, see from Theorem 4.1 to Theorem 4.4.

Relation between Theorem 1.1 and some results. Let  $\Omega_E^+$  be the period associated to E defined in §2. For a prime number q with (q, N) = 1,  $N_q = q + 1 - a_q$  denotes the number of  $\mathbb{F}_q$ -rational points of reduction modulo q. We write F by the field obtained by adjoining to  $\mathbb{Q}$  one fixed root of the 2-division polynomial of E. For distinct odd primes  $q_1, \ldots, q_r$  and  $M = m = q_1 \cdots q_r$ , we state relations between Theorem 1.1 and known results.

- (i) In [8], Zhai obtained lower bounds and some equality conditions for various cases. For example in [8, Theorem 1.1], he gave an equality condition when E has negative discriminant, E[2](Q) = {O}, v<sub>2</sub>(L(E/Q, 1)/Ω<sup>+</sup><sub>E</sub>) = 0, q<sub>i</sub> is inert in F for all i and M ≡ 1 mod 4. Note that if E[2](Q) = {O} and q is inert in F for a prime number q with (q, N) = 1, then a<sub>q</sub> is odd integer. This is a special case of Theorem 4.2-(i).
- (ii) In [10], Zhai calculated lower bounds when  $q_i \equiv 1 \mod 4$  for all i and  $v_2(N_{q_i}) \geq 1$ . Theorem 4.1-(ii) and Theorem 4.2-(ii) neither contain this result nor are contained in this one.
- (iii) In [1], Cai–Li–Zhai showed that the equality holds when  $E[2](\mathbb{Q}) \simeq \mathbb{Z}/2\mathbb{Z}$ ,  $v_2(L(E/\mathbb{Q}, 1)/\Omega_E^+) = -1$ ,  $q_i \equiv 1 \mod 4$  for all *i* and  $v_2(N_{q_i}) = 1$ . Note that if  $E[2](\mathbb{Q}) \neq \{O\}$ , then  $a_q$  is even integer for a prime number q with (q, N) = 1. This result is a special case of Theorem 4.1-(ii) and Theorem 4.2-(ii).
- (iv) In [9], Zhai calculated lower bounds when  $L(E/\mathbb{Q}, 1) \neq 0$ ,  $E[2](\mathbb{Q}) \neq \{O\}$ ,  $r \geq 2$ ,  $q_i \equiv 1 \mod 4$  for all *i* and there exists k  $(1 \leq k \leq r)$  such that  $q_k \in \bigcup_{j\geq 2} S_j$ . It neither includes Theorem 4.1-(ii) and Theorem 4.2-(ii) nor is included in them.

**Example of Theorem 1.1.** We give a example of Theorem 1.1 in the case M = 4m (See §5 for more details). Let  $f \in S_2(\Gamma_0(37))^{\text{new}}$  be the eigenform

$$f = q - 2q^2 - 3q^3 + 2q^4 - 2q^5 + 6q^6 - q^7 + O(q^8).$$

We see that f corresponds to an isogeny class of the elliptic curve given by the equation  $y^2 + y = x^3 - x$ with Cremona label **37a1**. In this case, the integer c appearing in Theorem 1.1 is zero. Therefore, if  $q_i \in S_0 \cup S_1 \cup S_2$  for all i, then we have

$$v_2\left(\frac{L(f,\chi_M,1)}{\Omega_f^{\operatorname{sgn}(\chi_M)}}\right) \ge \mathfrak{w}_m \cdot r.$$
(2)

The condition for the equality of (2) holds if all primes  $q_i$  dividing m satisfy,  $q_i \neq 37$ ,  $q_i \equiv 1 \mod 4$  and  $a_{q_i}$  is odd. For example, the following prime numbers satisfy these conditions, and in fact, there are an infinite number of such prime numbers.

**Outline of the proof.** We state an outline of the proof of Theorem 1.1 in the case M = m. The new approach for a calculation of 2-adic valuations is to use the modular symbol

$$\langle r \rangle_f^{\pm} \coloneqq \pi i \int_{i\infty}^r f(z) dz \pm \pi i \int_{i\infty}^{-r} f(z) dz \quad (r \in \mathbb{P}^1(\mathbb{Q})),$$

and the quantity

$$\mathcal{T}_{d,m} = \sum_{k \in (\mathbb{Z}/m\mathbb{Z})^{\times}} \chi_d(k) \frac{1}{\Omega_f^{\operatorname{sgn}(\chi_d)}} \left\langle \frac{k}{d} \right\rangle_f^{\operatorname{sgn}(\chi_d)},$$

where d is a positive divisor of m. As we will discuss in detail later, for example, in [8], [10], [1], [9] and [11], 2-adic valuations are calculated without dividing  $\langle r \rangle_f^+$  and  $\langle r \rangle_f^-$ . Separating  $\langle r \rangle^+$  and  $\langle r \rangle^-$  allows us to deal with the case where  $m \equiv 3 \mod 4$ .

As in previous works, we prove the main theorem based on Zhao's method (cf. [12], [13]). First, for a divisor d of m, we show  $\mathcal{T}_{d,m}$  is equal to  $L(f, \chi_d, 1)/\Omega_f^{\operatorname{sgn}(\chi_d)}$  up to  $\overline{\mathbb{Q}}^{\times}$  (see Theorem 2.1 and Proposition 3.3). Next, we consider the decomposition

$$\sum_{d|m} \mathcal{T}_{d,m} = \mathcal{T}_{1,m} + \sum_{\substack{d|m\\d \neq 1,m}} \mathcal{T}_{d,m} + \mathcal{T}_{m,m}.$$
(3)

We calculate the 2-adic valuation on the left-hand side in Proposition 3.5 and Proposition 3.6. The first term on the right-hand side is equal to the algebraic part  $L(f,1)/\Omega_f^+$  up to  $\overline{\mathbb{Q}}^{\times}$  (see Proposition 3.3). Since the second term on the right-hand side can be calculated from the induction hypothesis, we can consequently calculate the 2-adic valuation of the third term that is essentially equal to the algebraic part  $L(f, \chi_m, 1)/\Omega_f^{\text{sgn}(\chi_m)}$ . The proof for the case M = 4m can be done in almost the same way.

As mentioned before, other works essentially used another modular symbol

$$\langle r \rangle_f \coloneqq \langle r \rangle_f^+ + \langle r \rangle_f^- \quad (r \in \mathbb{P}^1(\mathbb{Q}))$$

and the quantity

$$T_{d,m} \coloneqq \sum_{k \in (\mathbb{Z}/m\mathbb{Z})^{\times}} \chi_d(k) \frac{1}{\Omega_f^{\operatorname{sgn}(\chi_d)}} \left\langle \frac{k}{m} \right\rangle_f.$$

By considering a transformation  $k \mapsto -k$ , we see that  $\mathcal{T}_{m,m} = T_{m,m}$ . However, whereas each term in  $\mathcal{T}_{d,m}$  is algebraic, each term in  $T_{d,m}$  is not necessarily algebraic. Therefore, unlike equation (3), it is necessary to decompose  $\sum_{d|m} T_{d,m}$  properly so that each term is algebraic. On the other hand, since we have separated  $\langle r \rangle^+$  and  $\langle r \rangle^-$ , we can calculate more simply and obtain a sharp lower bound.

**Organization of the paper.** In §2, we give definitions of periods and modular symbols. In §3, we discuss various properties of the quantity  $\mathcal{T}_{D,M}$ . In §4, we state the exact statement of Theorem 1.1 in four theorems and prove them. In §5, we give numerical examples of Theorem 1.1.

## 2. Preliminaries

Let  $f \in S_2(\Gamma_0(N))^{\text{new}}$  be a normalized Hecke eigenform. Assume that f is defined over  $\mathbb{Q}$ , that is, all coefficients of the q-expansion of f lie in  $\mathbb{Q}$ . Then, f corresponds to a  $\mathbb{Q}$ -isogeny class of elliptic curves defined over  $\mathbb{Q}$ . We write the optimal elliptic curve in the isogenous class as E. There exists a nonconstant rational map  $\Phi : X_0(N) \to E$  defined over  $\mathbb{Q}$ . Fix a global minimal Weierstrass model of E and let  $\omega$  be the Néron differential form on E. Since f(q)dq/q is a basis for the  $\mathbb{Q}$ -vector space  $S_2(\Gamma_0(N))$ , there exists  $\nu_E \in \mathbb{Q}^{\times}$  such that

$$\nu_E f(q) \frac{dq}{q} = \Phi^* \omega_E. \tag{4}$$

The number  $\nu_E$  is called the *Manin constant*. It is well-known that  $\nu_E \in \mathbb{Z}$  and conjectured that  $\nu_E = 1$ . In the rest of the paper, we assume that  $\nu_E = 1$ . We define the period lattice  $\mathcal{L}_f$  for f as

$$\mathcal{L}_f := \left\{ \int_{\gamma} f(q) \frac{dq}{q} \, \middle| \, \gamma \in H_1(X_0(N)(\mathbb{C}), \mathbb{Z}) \right\} \subset \mathbb{C}.$$

Since there exists a surjective map  $\Gamma_0(N) \longrightarrow H_1(X_0(N), \mathbb{Z})$  (for example, see [6, Theorem 12.1]), we can take some  $r \in \mathbb{P}^1(\mathbb{Q})$  and have

$$\mathcal{L}_f = \left\{ 2\pi i \int_r^{g \cdot r} f(z) dz \, \middle| \, g \in \Gamma_0(N) \right\}.$$

Similarly, one can define the period lattice  $\mathcal{L}_E$  of  $\omega_E$ . It is known that  $\mathcal{L}_E$  is of the form

$$\mathcal{L}_E = \begin{cases} \Omega_E^+ \mathbb{Z} + i\Omega_E^- \mathbb{Z} & (\Delta(E) < 0), \\ \Omega_E^+ \mathbb{Z} + \frac{\Omega_E^+ + i\Omega_E^-}{2} \mathbb{Z} & (\Delta(E) > 0), \end{cases}$$

where  $\Delta(E)$  is the discriminant of the fixed model of E. By the equation (4) and the assumption  $\nu_E = 1$ , we see that  $\mathcal{L}_E = \mathcal{L}_f$ . Therefore we have

$$\mathcal{L}_{f} = \begin{cases} \Omega_{f}^{+}\mathbb{Z} + i\Omega_{f}^{-}\mathbb{Z} & (\Delta(E) < 0), \\ \Omega_{f}^{+}\mathbb{Z} + \frac{\Omega_{f}^{+} + i\Omega_{f}^{-}}{2}\mathbb{Z} & (\Delta(E) > 0), \end{cases}$$
(5)

where  $\Omega_f^{\pm} = \Omega_E^{\pm}$ . For  $r \in \mathbb{P}^1(\mathbb{Q})$ , set

$$\langle r \rangle^{\pm} = \langle r \rangle_f^{\pm} \coloneqq \pi i \int_{i\infty}^r f(z) dz \pm \pi i \int_{i\infty}^{-r} f(z) dz.$$

It is straightforward to check that  $\langle r \rangle^+ \in \mathbb{R}$  and  $\langle r \rangle^- \in i\mathbb{R}$ . We also set

$$[r]^+ \coloneqq \frac{1}{\Omega_f^+} \langle r \rangle^+, \quad [r]^- \coloneqq \frac{1}{i\Omega_f^-} \langle r \rangle^-.$$

Then, for any  $r \in \mathbb{P}^1(\mathbb{Q})$ , we have  $[r]^{\pm} \in \mathbb{Q}$  (cf. [5, Chapter IV, §2]) and  $[-r]^{\pm} = \pm [r]^{\pm}$ . Note that  $[0]^+$  is equal to the algebraic part  $L(f, 1)/\Omega_f^+$ .

Let  $m = q_1 \dots q_r$  be the product of distinct odd primes and  $M = 4^n m$  with  $n \in \{0, 1\}$ . We write the primitive quadratic Dirichlet character with conductor M as  $\chi_M$ . Note that for a odd prime number q, the sign  $\operatorname{sgn}(\chi_q) \coloneqq \chi_q(-1)$  is +1 if and only if  $q \equiv 1 \mod 4$ .

**Theorem 2.1** (cf. [6, Theorem 9.9]). Let  $\chi_M$  be a quadratic character with conductor M and  $\tau(\chi_M) = \sum_{a \mod M} \chi_M(a) e^{2\pi i a/M}$ . Then, we have

$$\tau(\chi_M) \frac{L(f, \chi_M, 1)}{\Omega_f^{\operatorname{sgn}(\chi_M)}} = \sum_{k \in (\mathbb{Z}/M\mathbb{Z})^{\times}} \chi_M(k) \left[\frac{k}{M}\right]^{\operatorname{sgn}(\chi_M)}$$

In particular,  $L(f, \chi_M, 1)/\Omega_f^{\operatorname{sgn}(\chi_M)}$  is algebraic.

## 3. Twisted L-function and Modular Symbols

In the rest of the paper, we fix a normalized Hecke eigenform  $f \in S_2(\Gamma_0(N))^{\text{new}}$  defined over  $\mathbb{Q}$ . Let  $M = 4^n m = 4^n q_1 \cdots q_r$  be an integer with (M, N) = 1, where  $n \in \{0, 1\}$  and  $q_1, \ldots, q_r$  are distinct odd primes.

**Lemma 3.1.** For  $k \in \mathbb{Z}$  with (k, M) = 1, the following holds.

$$\nu\left(\left[\frac{k}{M}\right]^+ - [0]^+\right) \in \mathbb{Z}, \quad \nu\left[\frac{k}{M}\right]^- \in \mathbb{Z},$$

where  $\nu = 1$  if  $\mathcal{L}_f$  is rectangular and  $\nu = 2$  otherwise. In particular, we have

$$v_2\left(\left[\frac{k}{M}\right]^+ + \left[\frac{k}{M}\right]^-\right) \ge \min\left\{0, v_2\left([0]^+\right)\right\}$$

*Proof.* Since (M, kN) = 1, we can take  $a, b \in \mathbb{Z}$  such that aM - bkN = 1. Then the matrix

$$\gamma^+ \coloneqq \begin{pmatrix} a & k \\ bN & M \end{pmatrix}.$$

belongs to  $\Gamma_0(N)$  and  $\gamma^+ \cdot 0 = k/M$  holds. Similarly, there exists  $\gamma^- \in \Gamma_0(N)$  such that  $\gamma^- \cdot 0 = -k/M$ . Therefore it holds that

$$\Omega_f^+ \left[\frac{k}{M}\right]^+ \pm i\Omega_f^- \left[\frac{k}{M}\right]^- = 2\pi i \int_{i\infty}^{\gamma^{\pm}.0} f(z)dz$$
$$= 2\pi i \int_{i\infty}^0 f(z)dz + 2\pi i \int_0^{\gamma^{\pm}.0} f(z)dz$$
$$= \Omega_f^+[0]^+ + 2\pi i \int_0^{\gamma^{\pm}.0} f(z)dz.$$

Thus we have

$$\Omega_f^+\left(\left[\frac{k}{M}\right]^+ - [0]^+\right) \pm i\Omega_f^-\left[\frac{k}{M}\right]^- \in \mathcal{L}_f.$$

and the claim follows by (5).

For each prime p not dividing N, the Hecke operator  $T_p$  acts on modular symbols as follows:

$$T_p[r]^{\pm} = [pr]^{\pm} + \sum_{k \in \mathbb{Z}/p\mathbb{Z}} \left[\frac{k+r}{p}\right]^{\pm}.$$

Moreover, since f is a Hecke eigenform, we see that  $T_p[r]^{\pm} = a_p[r]^{\pm}$ , where  $a_p$  is the p-th Fourier coefficient of f.

We put

$$\mathcal{T}_M \coloneqq \sum_{k \in (\mathbb{Z}/M\mathbb{Z})^{\times}} \chi_M(k) \left[\frac{k}{M}\right]^{\operatorname{sgn}(\chi_M)},$$

 $\mathcal{T}_1 \coloneqq [0]^+ = L(f,1)/\Omega_f^+$  and  $\mathcal{T}_4 \coloneqq 2[1/4]^- = \tau(\chi_4)L(f,\chi_4,1)/\Omega_f^-$ . Moreover, for each positive divisor D of M, we set

$$\mathcal{T}_{D,M} \coloneqq \sum_{k \in (\mathbb{Z}/M\mathbb{Z})^{\times}} \chi_D(k) \left[\frac{k}{M}\right]^{\operatorname{sgn}(\chi_D)}$$

Obviously, we have  $\mathcal{T}_{M,M} = \mathcal{T}_M$ . By Theorem 2.1,  $\mathcal{T}_M$  is essentially equal to the algebraic part of  $L(f, \chi_M, 1)$ . First, we show that  $\mathcal{T}_{D,M}$  is also essentially equal to the algebraic part of  $L(f, \chi_D, 1)$  (see Proposition 3.3).

**Lemma 3.2.** For an odd prime q dividing M and a positive divisor D of M/q, we have

$$\mathcal{T}_{D,M} = (a_q - 2\chi_D(q))\mathcal{T}_{D,\frac{M}{q}}.$$

*Proof.* We can identify  $(\mathbb{Z}/M\mathbb{Z})^{\times}$  with the set

$$\left\{k'\frac{M}{q}+k\,\middle|\,k\in(\mathbb{Z}/(M/q)\mathbb{Z})^{\times},\ k'\in(\mathbb{Z}/q\mathbb{Z})^{\times}\right\}.$$

Therefore it holds that

$$\mathcal{T}_{D,M} = \sum_{k \in (\mathbb{Z}/(M/q)\mathbb{Z})^{\times}} \sum_{k' \in (\mathbb{Z}/q\mathbb{Z})^{\times}} \chi_D(k) \left[ \frac{k' \frac{M}{q} + k}{M} \right]^{\operatorname{sgn}(\chi_D)}$$

$$= \sum_{k \in (\mathbb{Z}/(M/q)\mathbb{Z})^{\times}} \left( \sum_{k' \in \mathbb{Z}/q\mathbb{Z}} \chi_D(k) \left[ \frac{k' \frac{M}{q} + k}{M} \right]^{\operatorname{sgn}(\chi_D)} - \chi_D(k) \left[ \frac{k}{M} \right]^{\operatorname{sgn}(\chi_D)} \right)$$

$$= \sum_{k \in (\mathbb{Z}/(M/q)\mathbb{Z})^{\times}} \chi_D(k) \sum_{k' \in \mathbb{Z}/q\mathbb{Z}} \left[ \frac{k' \frac{M}{q} + k}{M} \right]^{\operatorname{sgn}(\chi_D)} - \chi_D(q) \sum_{k \in (\mathbb{Z}/(M/q)\mathbb{Z})^{\times}} \chi_D(k) \left[ \frac{kq}{M} \right]^{\operatorname{sgn}(\chi_D)}. (6)$$

Note that the last equality follows from the transformation  $k \mapsto qk$  in the second term. We temporarily fix  $k \in (\mathbb{Z}/(M/q)\mathbb{Z})^{\times}$ . Considering the action of the Hecke operator  $T_q$  at the prime q, we have

$$a_q \left[\frac{kq}{M}\right]^{\operatorname{sgn}(\chi_D)} = \left[\frac{kq^2}{M}\right]^{\operatorname{sgn}(\chi_D)} + \sum_{k' \in \mathbb{Z}/q\mathbb{Z}} \left[\frac{k'\frac{M}{q} + k}{M}\right]^{\operatorname{sgn}(\chi_D)}.$$
(7)

Taking the sum  $\sum_{k \in (\mathbb{Z}/(M/q)\mathbb{Z})^{\times}} \chi_D(k)$  in the equation (7) yields the identity

$$\sum_{k \in (\mathbb{Z}/(M/q)\mathbb{Z})^{\times}} \chi_D(k) \sum_{k' \in \mathbb{Z}/q\mathbb{Z}} \left[ \frac{k' \frac{M}{q} + k}{M} \right]^{\operatorname{sgn}(\chi_D)} = (a_q - \chi_D(q)) \sum_{k \in (\mathbb{Z}/(M/q)\mathbb{Z})^{\times}} \chi_D(k) \left[ \frac{kq}{M} \right]^{\operatorname{sgn}(\chi_D)}.$$
 (8) stituting (8) into (6) leads to the claim.

Substituting (8) into (6) leads to the claim.

**Proposition 3.3.** For a positive divisor D of M, it holds

$$\mathcal{T}_{D,M} = \mathcal{T}_D \cdot \prod_{q \mid \frac{M}{D}} (a_q - 2\chi_D(q))$$

In particular, we have

$$\mathcal{T}_{1,m} = \mathcal{T}_1 \prod_{i=1}^r (a_{q_i} - 2), \quad \mathcal{T}_{4,4m} = \mathcal{T}_4 \prod_{i=1}^r (a_{q_i} - 2\chi_4(q))$$

*Proof.* The claim follows by using Lemma 3.2 iteratively.

In the rest of the paper, for some function F,  $\sum_{d|m} F(d)$  denotes the summation over all positive divisor d of m. Moreover,  $\sum_{D}' F(D)$  denotes  $\sum_{d|m} F(d)$  if n = 0 and  $\sum_{d|m} F(4d)$  if n = 1. For example, the sum  $\sum_{D}^{\prime} \mathcal{T}_{D,M}$  is given by

$$\sum_{D}' \mathcal{T}_{D,M} = \begin{cases} \sum_{d|m} \mathcal{T}_{d,m} & (n=0), \\ \sum_{d|m} \mathcal{T}_{4d,4m} & (n=1). \end{cases}$$

Next, we calculate a lower bound of  $v_2(\sum_D' \mathcal{T}_{D,M})$  in Proposition 3.5 and Proposition 3.6. Proposition 3.5 states a lower bound under no conditions. Proposition 3.6 states it in the case where  $sgn(\chi_q)$  is +1 for all odd prime divisors q of M.

**Lemma 3.4.** For each  $k \in (\mathbb{Z}/M\mathbb{Z})^{\times}$ , the following holds:

$$\sum_{D}' \chi_D(k) = \begin{cases} \prod_{i=1}^r (1 + \chi_{q_i}(k)) & (n = 0), \\ \chi_4(k) \prod_{i=1}^r (1 + \chi_{q_i}(k)) & (n = 1). \end{cases}$$

In particular, we have  $v_2(\sum_D' \chi_D(k)) \ge r$ .

*Proof.* One can prove the claim by using the induction on the number of prime divisors of m. 

**Proposition 3.5.** We have

$$v_2\left(\sum_{D}' \mathcal{T}_{D,M}\right) \ge r + \min\{0, v_2(\mathcal{T}_1)\}.$$

*Proof.* From the facts that (-1)-multiplication map on  $(\mathbb{Z}/M\mathbb{Z})^{\times}$  is bijective and  $[-r]^{\pm} = \pm [r]^{\pm}$  holds for each  $r \in \mathbb{Q}$ , we see that

$$\sum_{k \in (\mathbb{Z}/M\mathbb{Z})^{\times}} \sum_{\substack{D \\ \operatorname{sgn}(\chi_D) = +}}^{\prime} \chi_D(k) \left[\frac{k}{M}\right]^{-\operatorname{sgn}(\chi_D)} = \sum_{k \in (\mathbb{Z}/M\mathbb{Z})^{\times}} \sum_{\substack{D \\ \operatorname{sgn}(\chi_D) = -}}^{\prime} \chi_D(k) \left[\frac{k}{M}\right]^{\operatorname{sgn}(\chi_D)} = 0.$$

Therefore we have

$$\sum_{D}' \mathcal{T}_{D,M} = \sum_{k \in (\mathbb{Z}/M\mathbb{Z})^{\times}} \sum_{D}' \chi_{D}(k) \left[\frac{k}{M}\right]^{\operatorname{sgn}(\chi_{D})}$$

$$= \sum_{k \in (\mathbb{Z}/M\mathbb{Z})^{\times}} \sum_{\operatorname{sgn}(\chi_{D})=+}' \chi_{D}(k) \left[\frac{k}{M}\right]^{\operatorname{sgn}(\chi_{D})} + \sum_{k \in (\mathbb{Z}/M\mathbb{Z})^{\times}} \sum_{\operatorname{sgn}(\chi_{D})=-}' \chi_{D}(k) \left[\frac{k}{M}\right]^{\operatorname{sgn}(\chi_{D})}$$

$$= \sum_{k \in (\mathbb{Z}/M\mathbb{Z})^{\times}} \sum_{\operatorname{sgn}(\chi_{D})=+}' \chi_{D}(k) \left[\frac{k}{M}\right]^{+} + \sum_{k \in (\mathbb{Z}/M\mathbb{Z})^{\times}} \sum_{\operatorname{sgn}(\chi_{D})=-}' \chi_{D}(k) \left[\frac{k}{M}\right]^{-}$$

$$= \sum_{k \in (\mathbb{Z}/M\mathbb{Z})^{\times}} \left(\sum_{D}' \chi_{D}(k)\right) \left(\left[\frac{k}{M}\right]^{+} + \left[\frac{k}{M}\right]^{-}\right)$$
(9)
claim follows from Lemma 3.1 and Lemma 3.4.

The claim follows from Lemma 3.1 and Lemma 3.4.

**Proposition 3.6.** Suppose that  $sgn(\chi_q)$  is +1 for all odd prime divisors q of M.

(i) If 
$$n = 0$$
, then  

$$v_2\left(\sum_{d|m} \mathcal{T}_{d,m}\right) \ge \begin{cases} r+1 + \min\{0, v_2(\mathcal{T}_1)\} & (\mathcal{L}_f : rectangular), \\ r+1 + \min\{-1, v_2(\mathcal{T}_1)\} & (\mathcal{L}_f : non-rectangular). \end{cases}$$
(ii) If  $n = 1$ , then

$$v_2\left(\sum_{d|m} \mathcal{T}_{4d,4m}\right) \ge \begin{cases} r+1 & (\mathcal{L}_f : rectangular), \\ r & (\mathcal{L}_f : non-rectangular). \end{cases}$$

*Proof.* We only prove the case where n = 1 (For n = 0, one can prove similarly). Note that we have the identification

$$(\mathbb{Z}/4m\mathbb{Z})^{\times} = \left\{4k + m, 4k - m \mid k \in (\mathbb{Z}/m\mathbb{Z})^{\times}\right\}.$$

From the equation (9), we have

$$\sum_{d|m} \mathcal{T}_{4d,4m} = \sum_{\substack{k=1\\(k,4m)=1}}^{4m} \left( \sum_{d|m} \chi_{4d}(k) \right) \left( \left[ \frac{k}{4m} \right]^+ + \left[ \frac{k}{4m} \right]^- \right)$$

$$= \sum_{\substack{k=1\\(k,4m)=1}}^{2m} \left( \sum_{d|m} \chi_{4d}(k) \right) \left( \left[ \frac{k}{4m} \right]^+ + \left[ \frac{k}{4m} \right]^- \right) \\ + \sum_{\substack{k=1\\(k,4m)=1}}^{2m} \left( \sum_{d|m} \chi_{4d}(4m-k) \right) \left( \left[ \frac{4m-k}{4m} \right]^+ + \left[ \frac{4m-k}{4m} \right]^- \right) \\ = \sum_{\substack{k=1\\(k,4m)=1}}^{2m} \left( \sum_{d|m} \chi_{4d}(k) \right) \left( \left[ \frac{k}{4m} \right]^+ + \left[ \frac{k}{4m} \right]^- \right) \\ + \sum_{\substack{k=1\\(k,4m)=1}}^{2m} \left( \sum_{d|m} \chi_{4d}(-k) \right) \left( \left[ \frac{k}{4m} \right]^+ - \left[ \frac{k}{4m} \right]^- \right) \\ + \sum_{\substack{k=1\\(k,4m)=1}}^{2m} \left( \sum_{d|m} \chi_{4d}(-k) \right) \left( \left[ \frac{k}{4m} \right]^+ - \left[ \frac{k}{4m} \right]^- \right) \\ + \sum_{\substack{k=1\\(k,4m)=1}}^{2m} \left( \sum_{d|m} \chi_{4d}(-k) \right) \left( \left[ \frac{k}{4m} \right]^+ - \left[ \frac{k}{4m} \right]^- \right) \\ + \sum_{\substack{k=1\\(k,4m)=1}}^{2m} \left( \sum_{d|m} \chi_{4d}(-k) \right) \left( \left[ \frac{k}{4m} \right]^+ - \left[ \frac{k}{4m} \right]^- \right) \\ + \sum_{\substack{k=1\\(k,4m)=1}}^{2m} \left( \sum_{d|m} \chi_{4d}(-k) \right) \left( \left[ \frac{k}{4m} \right]^+ - \left[ \frac{k}{4m} \right]^- \right) \\ + \sum_{\substack{k=1\\(k,4m)=1}}^{2m} \left( \sum_{d|m} \chi_{4d}(-k) \right) \left( \left[ \frac{k}{4m} \right]^+ - \left[ \frac{k}{4m} \right]^- \right) \\ + \sum_{\substack{k=1\\(k,4m)=1}}^{2m} \left( \sum_{d|m} \chi_{4d}(-k) \right) \left( \left[ \frac{k}{4m} \right]^+ - \left[ \frac{k}{4m} \right]^- \right) \\ + \sum_{\substack{k=1\\(k,4m)=1}}^{2m} \left( \sum_{d|m} \chi_{4d}(-k) \right) \left( \left[ \frac{k}{4m} \right]^+ - \left[ \frac{k}{4m} \right]^- \right) \\ + \sum_{\substack{k=1\\(k,4m)=1}}^{2m} \left( \sum_{d|m} \chi_{4d}(-k) \right) \left( \left[ \frac{k}{4m} \right]^+ - \left[ \frac{k}{4m} \right]^- \right) \\ + \sum_{\substack{k=1\\(k,4m)=1}}^{2m} \left( \sum_{d|m} \chi_{4d}(-k) \right) \left( \sum_{d|m$$

Since  $sgn(\chi_{4d}) = -1$  for all positive divisors d of m by the assumption, we obtain

$$\sum_{d|m} \mathcal{T}_{4d,4m} = 2 \sum_{\substack{k=1\\(k,4m)=1}}^{2m} \left( \sum_{d|m} \chi_{4d}(k) \right) \left[ \frac{k}{4m} \right]^{-}.$$

The claim follows from Lemma 3.1 and Lemma 3.4.

Finally, we calculate a lower bound of  $\mathcal{T}_1$  and  $\mathcal{T}_4$  in Proposition 3.9. This proposition is related to whether the assumptions of the main theorem are empty or not. The details are mentioned in Remark 4.5.

Lemma 3.7. The rational numbers

$$\mathcal{T}_{1,m} - \#(\mathbb{Z}/m\mathbb{Z})^{\times} \cdot \mathcal{T}_1, \quad \mathcal{T}_{4,4m}$$

belong to  $2\mathbb{Z}$  (resp.  $\mathbb{Z}$ ) if  $\mathcal{L}_f$  is rectangular (resp. non-rectangular).

*Proof.* First, we calculate  $\mathcal{T}_{1,m} - \#(\mathbb{Z}/m\mathbb{Z})^{\times} \cdot \mathcal{T}_1$ . Dividing  $\mathcal{T}_{1,m}$  into two summations, we have

$$\mathcal{T}_{1,m} = \sum_{\substack{k \in (\mathbb{Z}/m\mathbb{Z})^{\times} \\ = \sum_{\substack{k=1 \\ (k,m)=1}}^{(m-1)/2} \left[\frac{k}{m}\right]^{+} + \sum_{\substack{k=1 \\ (k,m)=1}}^{(m-1)/2} \left[\frac{m-k}{m}\right]^{+} \\ = 2 \sum_{\substack{k=1 \\ (k,m)=1}}^{(m-1)/2} \left[\frac{k}{m}\right]^{+}.$$

Therefore it holds

$$\mathcal{T}_{1,m} - 2\sum_{\substack{k=1\\(k,m)=1}}^{(m-1)/2} [0]^+ = 2\sum_{\substack{k=1\\(k,m)=1}}^{(m-1)/2} \left( \left[\frac{k}{m}\right]^+ - [0]^+ \right)$$

and the claim follows from Lemma 3.1. Second, we caluclate  $\mathcal{T}_{4,4m}$ . By using the identification

$$(\mathbb{Z}/4m\mathbb{Z})^{\times} = \left\{4k + m, 4k - m \,\middle|\, k \in (\mathbb{Z}/m\mathbb{Z})^{\times}\right\},\$$

we have

$$\mathcal{T}_{4,4m} = \sum_{k \in (\mathbb{Z}/4m\mathbb{Z})^{\times}} \chi_4(k) \left[\frac{k}{4m}\right]^-$$
$$= \sum_{k \in (\mathbb{Z}/m\mathbb{Z})^{\times}} \left( \chi_4(4k+m) \left[\frac{4k+m}{4m}\right]^- + \chi_4(4k-m) \left[\frac{4k-m}{4m}\right]^- \right)$$

$$=\chi_4(m)\sum_{k\in(\mathbb{Z}/m\mathbb{Z})^{\times}}\left(\left[\frac{4k+m}{4m}\right]^{-}-\left[\frac{4k-m}{4m}\right]^{-}\right).$$

Since

$$\sum_{k \in (\mathbb{Z}/m\mathbb{Z})^{\times}} \left[ \frac{4k-m}{4m} \right]^{-} = \sum_{k \in (\mathbb{Z}/m\mathbb{Z})^{\times}} \left[ \frac{-4k+m}{4m} \right]^{-} = \sum_{k \in (\mathbb{Z}/m\mathbb{Z})^{\times}} \left[ \frac{4k+m}{4m} \right]^{-},$$

we have

$$\mathcal{T}_{4,4m} = 2\chi_4(m) \sum_{k \in (\mathbb{Z}/m\mathbb{Z})^{\times}} \left[\frac{4k+m}{4m}\right]^-.$$
(10)

The claim follows from here.

**Lemma 3.8.** If there exists an odd prime q dividing m such that  $a_q$  is even, then we have

$$\mathcal{T}_{4,4m} \in \begin{cases} 4\mathbb{Z} & (\mathcal{L}_f : rectangular), \\ 2\mathbb{Z} & (\mathcal{L}_f : non-rectangular). \end{cases}$$

*Proof.* By the equation (10), it is sufficient to show

$$\sum_{k \in \mathbb{Z}/m\mathbb{Z}} \left[ \frac{4k+m}{4m} \right]^{-} \in \begin{cases} 2\mathbb{Z} & (\mathcal{L}_f : \text{rectangular}), \\ \mathbb{Z} & (\mathcal{L}_f : \text{non-rectangular}) \end{cases}$$

Let q be a prime dividing m such that  $a_q$  is even. Recall the identification

$$(\mathbb{Z}/m\mathbb{Z})^{\times} = \left\{ k'\frac{m}{q} + k \, \middle| \, k \in (\mathbb{Z}/(m/q)\mathbb{Z})^{\times}, \, k' \in (\mathbb{Z}/q\mathbb{Z})^{\times} \right\}.$$

Then we see that

$$\sum_{k \in (\mathbb{Z}/m\mathbb{Z})^{\times}} \left[ \frac{4k+m}{4m} \right]^{-} = \sum_{k' \in (\mathbb{Z}/q\mathbb{Z})^{\times}} \sum_{k \in (\mathbb{Z}/(m/q)\mathbb{Z})^{\times}} \left[ \frac{4(k'\frac{m}{q}+k)+m}{4m} \right]^{-}.$$

We temporarily fix  $k \in (\mathbb{Z}/(m/q)\mathbb{Z})^{\times}$  and calculate as follows:

$$a_{q} \left[ \frac{(4k+m)q}{4m} \right]^{-} = \left[ \frac{(4k+m)q^{2}}{4m} \right]^{-} + \sum_{k' \in \mathbb{Z}/q\mathbb{Z}} \left[ \frac{k' + \frac{(4k+m)q}{4m}}{q} \right]^{-} \\ = \left[ \frac{4kq^{2} + m}{4m} \right]^{-} + \left[ \frac{4k+m}{4m} \right]^{-} + \sum_{k' \in (\mathbb{Z}/q\mathbb{Z})^{\times}} \left[ \frac{4(k'\frac{m}{q} + k) + m}{4m} \right]^{-}.$$
(11)

Note that  $[q^2/4]^{\pm} = [1/4]^{\pm}$  since  $q^2 \equiv 1 \mod 4$ . Taking the sum  $\sum_{k \in (\mathbb{Z}/(m/q)\mathbb{Z})^{\times}}$  in the equation (11) yields

$$\sum_{k' \in (\mathbb{Z}/q\mathbb{Z})^{\times}} \sum_{k \in (\mathbb{Z}/(m/q)\mathbb{Z})^{\times}} \left[ \frac{4(k'\frac{m}{q}+k)+m}{4m} \right]^{-}$$

$$= \sum_{k \in (\mathbb{Z}/(m/q)\mathbb{Z})^{\times}} \left\{ a_q \left[ \frac{(4k+m)q}{4m} \right]^{-} - \left[ \frac{4k+m}{4m} \right]^{-} \right\} - \sum_{k \in (\mathbb{Z}/(m/q)\mathbb{Z})^{\times}} \left[ \frac{4kq^2+m}{4m} \right]^{-}$$

$$= \sum_{k \in (\mathbb{Z}/(m/q)\mathbb{Z})^{\times}} \left\{ a_q \left[ \frac{(4k+m)q}{4m} \right]^{-} - 2\left[ \frac{4k+m}{4m} \right]^{-} \right\},$$

where the last equality is obtained by using the transformation  $k \mapsto q^{-2}k$  on the latter sum. Therefore, we see that

$$\sum_{k \in (\mathbb{Z}/m\mathbb{Z})^{\times}} \left[\frac{4k+m}{4m}\right]^{-} = a_q \sum_{k \in (\mathbb{Z}/(m/q)\mathbb{Z})^{\times}} \left[\frac{(4k+m)q}{4m}\right]^{-} - 2 \sum_{k \in (\mathbb{Z}/(m/q)\mathbb{Z})^{\times}} \left[\frac{4k+m}{4m}\right]^{-}.$$

By the assumption,  $a_q$  is an even integer. Therefore, the lemma holds from Lemma 3.1.

**Proposition 3.9.** We put  $\mathfrak{w}_m$  as 0 if  $\mathfrak{v}_m = 0$  and 1 otherwise. Then, for any prime q dividing m, the following holds.

(i) If  $\mathcal{L}_f$  is rectangular, then

 $v_2(a_q - (q+1)) \ge \mathfrak{w}_m + 1 - v_2(\mathcal{T}_1), \quad v_2(a_q - 2\chi_4(q)) \ge \mathfrak{w}_m + 1 - v_2(\mathcal{T}_4)$ 

- (ii) If  $\mathcal{L}_f$  is non-rectangular, then
  - $v_2(a_q (q+1)) \ge \mathfrak{w}_m v_2(\mathcal{T}_1), \quad v_2(a_q 2\chi_4(q)) \ge \mathfrak{w}_m v_2(\mathcal{T}_4)$

*Proof.* By Proposition 3.3, we have

$$\mathcal{T}_{1,q} - \#(\mathbb{Z}/q\mathbb{Z})^{\times}\mathcal{T}_1 = (a_q - (q+1))\mathcal{T}_1, \quad \mathcal{T}_{4,4q} = (a_q - 2\chi_4(q))\mathcal{T}_4.$$

The claim follows from Lemma 3.7 and Lemma 3.8.

#### 4. The 2-adic valuations of the algebraic parts

Let  $M = 4^n m$  be a positive integer with (M, N) = 1, where  $n \in \{0, 1\}$  and m is a square-free odd integer. We define r(m) as the number of the prime divisors of m. We set

$$\mathfrak{v}_m = \min_{q|m:\text{prime}} \{ v_2(a_q - 2) \}$$

and

$$\mathfrak{w}_m = \begin{cases} 0 & (\mathfrak{v}_m = 0), \\ 1 & (\mathfrak{v}_m \ge 1). \end{cases}$$

Moreover, for an integer i, we define

$$\mathcal{S}_i^{\pm} = \{q : \text{odd prime} \mid q \nmid N, \text{sgn}(\chi_q) = \pm 1, v_2(a_q - 2) = i\}$$

and set  $S_i = S_i^+ \cup S_i^-$ . Note that if  $S_i^{\pm}$  is non-empty, by Chebotarev's density theorem,  $S_i^{\pm}$  has positive density.

In the following, we state Theorem 1.1 in four cases, according to whether  $\mathcal{L}_f$  is rectangular or not, and whether n = 0 or not. Since proofs are the same in all cases, we only prove Theorem 1.1 for the case where  $\mathcal{L}_f$  is rectangular and n = 1 in Theorem 4.3. In the following,  $\delta_{i,j}$  denotes the Kronecker delta.

**Theorem 4.1** (Rectangular, n = 0). We assume that  $\mathcal{L}_f$  is rectangular and n = 0 and write  $m = q_1 \cdots q_{r(m)}$ .

(i) If 
$$q_i \in S_0 \cup S_1 \cup S_2$$
 for all *i*, then

$$v_2\left(\frac{L(f,\chi_m,1)}{\Omega_f^{\operatorname{sgn}(\chi_m)}}\right) \ge \mathfrak{w}_m \cdot r(m) + \min\left\{\delta_{\mathfrak{v}_m,0}, v_2\left(\frac{L(f,1)}{\Omega_f^+}\right)\right\}.$$

(ii) If  $q_i \in \mathcal{S}_0^+ \cup \mathcal{S}_1^+ \cup \mathcal{S}_2^+$  for all *i*, then

$$v_2\left(\frac{L(f,\chi_m,1)}{\Omega_f^{\mathrm{sgn}(\chi_m)}}\right) \ge \mathfrak{w}_m \cdot r(m) + \min\left\{1 + \delta_{\mathfrak{v}_m,0}, v_2\left(\frac{L(f,1)}{\Omega_f^+}\right) + \delta_{\mathfrak{v}_m,2}\right\}$$
(12)

In particular, if  $v_2(L(f,1)/\Omega_f^+) = 1$  and  $q_i \in \mathcal{S}_0^+$  for all i, or  $v_2(L(f,1)/\Omega_f^+) < 1$  and  $q_i \in \mathcal{S}_1^+$  for all i, then the equality of (12) holds.

**Theorem 4.2** (Non-rectangular, n = 0). We assume that  $\mathcal{L}_f$  is non-rectangular and n = 0 and write  $m = q_1 \cdots q_{r(m)}$ .

(i) If  $q_i \in S_0 \cup S_1 \cup S_2$  for all *i*, then

$$v_2\left(\frac{L(f,\chi_M,1)}{\Omega_f^{\mathrm{sgn}(\chi_M)}}\right) \ge \mathfrak{w}_m \cdot r(m) + \min\left\{\delta_{\mathfrak{v}_m,0}, v_2\left(\frac{L(f,1)}{\Omega_f^+}\right)\right\}.$$
(13)

In particular, if  $v_2(L(f,1)/\Omega_f) = 0$  and  $q_i \in S_0$  for all *i*, then the equality (13) holds.

(ii) If  $q_i \in \mathcal{S}_0^+ \cup \mathcal{S}_1^+ \cup \mathcal{S}_2^+$  for all *i*, then

$$v_2\left(\frac{L(f,\chi_M,1)}{\Omega_f^{\operatorname{sgn}(\chi_M)}}\right) \ge \mathfrak{w}_m \cdot r(m) + \min\left\{\delta_{\mathfrak{v}_m,0}, v_2\left(\frac{L(f,1)}{\Omega_f^+}\right) + \delta_{\mathfrak{v}_m,2}\right\}.$$

In particular, if  $v_2(L(f,1)/\Omega_f^+) = 0$  and  $q_i \in \mathcal{S}_0^+$  for all i, or  $v_2(L(f,1)/\Omega_f^+) < 0$  and  $q_i \in \mathcal{S}_1^+$ , then the equality of (12) holds.

**Theorem 4.3** (Rectangular, n = 1). We assume that  $\mathcal{L}_f$  is rectangular and n = 1 and write  $m = q_1 \cdots q_{r(m)}$ .

(i) If  $q_i \in S_0 \cup S_1 \cup S_2$  for all *i*, then

(ii)

$$\begin{aligned} v_2 \left( \frac{L(f, \chi_M, 1)}{\Omega_f^{\operatorname{sgn}(\chi_M)}} \right) &\geq \mathfrak{w}_m \cdot r(m) \\ &+ \min \Biggl\{ -1 + \delta_{\mathfrak{v}_m, 0}, -1 + \delta_{\mathfrak{v}_m, 0} + v_2 \Biggl( \frac{L(f, 1)}{\Omega_f^+} \Biggr), v_2 \Biggl( \frac{L(f, \chi_4, 1)}{\Omega_f^-} \Biggr) + \delta_{\mathfrak{v}_m, 2} \Biggr\}. \end{aligned}$$
If  $q_i \in \mathcal{S}_0^+ \cup \mathcal{S}_1^+ \cup \mathcal{S}_2^+$  for all  $i$ , then

$$v_2\left(\frac{L(f,\chi_M,1)}{\Omega_f^{\operatorname{sgn}(\chi_M)}}\right) \ge \mathfrak{w}_m \cdot r(m) + \min\left\{\delta_{\mathfrak{v}_m,0}, v_2\left(\frac{L(f,\chi_4,1)}{\Omega_f^-}\right) + \delta_{\mathfrak{v}_m,2}\right\}$$
(14)

In particular, if  $v_2(L(f,\chi_4,1)/\Omega_f^-) = 0$  and  $q_i \in \mathcal{S}_0^+$  for all *i*, then the equality of (14) holds.

**Theorem 4.4** (Non-rectangular, n = 1). Assume that  $\mathcal{L}_f$  is non-rectangular and n = 1 and write  $m = q_1 \cdots q_{r(m)}$ .

(i) If 
$$q_i \in S_0 \cup S_1 \cup S_2$$
 for all  $i$ , then

$$v_{2}\left(\frac{L(f,\chi_{M},1)}{\Omega_{f}^{\operatorname{sgn}(\chi_{M})}}\right) \geq \mathfrak{w}_{m} \cdot r(m)$$

$$+ \min\left\{-1 + \delta_{\mathfrak{w}_{m},0}, -1 + \delta_{\mathfrak{w}_{m},0} + v_{2}\left(\frac{L(f,1)}{\Omega_{f}^{+}}\right), v_{2}\left(\frac{L(f,\chi_{4},1)}{\Omega_{f}^{-}}\right) + \delta_{\mathfrak{w}_{m},2}\right\}.$$

$$(15)$$

In particular, if  $v_2(L(f, \chi_4, 1)/\Omega_f^-) = -1$  and  $q_i \in S_0$  for all *i*, then the equality of (15) holds. (ii) If  $q_i \in S_0^+ \cup S_1^+ \cup S_2^+$  for all *i*, then

$$v_2\left(\frac{L(f,\chi_M,1)}{\Omega_f^{\mathrm{sgn}(\chi_M)}}\right) \ge \mathfrak{w}_m \cdot r(m) + \min\left\{-1 + \delta_{\mathfrak{v}_m,0}, v_2\left(\frac{L(f,\chi_4,1)}{\Omega_f^-}\right) + \delta_{\mathfrak{v}_m,2}\right\}.$$
 (16)

In particular, if  $v_2(L(f,\chi_4,1)/\Omega_f^-) = -1$  and  $q_i \in \mathcal{S}_0^+$  for all *i*, then the equality of (16) holds.

**Remark 4.5.** In Theorem 4.1-(i), we can show that the equality holds when  $v_2(\mathcal{T}_1) < 1$  and  $q_i \in S_0$  for all *i*. However, Proposition 3.9 shows that such a condition does not hold. This means that the equality

$$v_2\left(\frac{L(f,\chi_m,1)}{\Omega_f^{\mathrm{sgn}(\chi_m)}}\right) = \mathfrak{w}_m \cdot r(m) + \min\left\{\delta_{\mathfrak{v}_m,0}, v_2\left(\frac{L(f,1)}{\Omega_f^+}\right)\right\}$$

is not necessarily determined only by  $v_2(\mathcal{T}_1)$  and  $v_2(a_{q_i}-2)$ . Tabel 1 shows, for each theorem, the conditions under which the equality holds and the conditions under which is non-empty, taking Proposition 3.9 into account (The non-empty conditions are the same as those described in the claim for each theorem).

*Proof of Theorem 4.3.* We only prove (ii) in the theorem. For the claim (i), we can prove it similarly. Note that (14) is equivalent to

$$v_2(\mathcal{T}_{4m}) \ge \mathfrak{w}_m \cdot r(m) + \min\{1 + \delta_{\mathfrak{v}_m,0}, v_2(\mathcal{T}_4) + \delta_{\mathfrak{v}_m,2}\}.$$

We show the claim by induction on the number of the prime divisors of m.

We suppose  $sgn(\chi_{q_i}) = +1$  for all *i*. Then, from Proposition 3.6, we have the following estimation:

$$v_2\left(\sum_{d|m} \mathcal{T}_{4d,4m}\right) \ge r(m) + 1.$$
(17)

Moreover, we see that

$$\mathfrak{w}_{q_1} + \min\{1 + \delta_{\mathfrak{v}_{q_1}, 0}, v_2(\mathcal{T}_4) + \delta_{\mathfrak{v}_{q_1}, 2}\} = \begin{cases} \min\{2, v_2(\mathcal{T}_4)\} & (\mathfrak{v}_{q_1} = 0), \\ 1 + \min\{1, v_2(\mathcal{T}_4)\} & (\mathfrak{v}_{q_1} = 1), \\ 2 + \min\{0, v_2(\mathcal{T}_4)\} & (\mathfrak{v}_{q_1} = 2). \end{cases}$$

We consider the case r(m) = 1. By (17), we have

$$v_2\left(\sum_{d|q_1} \mathcal{T}_{4d,4q_1}\right) \ge 2 \ge \mathfrak{w}_{q_1} + \min\{1 + \delta_{\mathfrak{v}_{q_1},0}, v_2(\mathcal{T}_4) + \delta_{\mathfrak{v}_{q_1},2}\}.$$
(18)

By Proposition 3.3, we see that

$$v_{2}(\mathcal{T}_{4,4q_{1}}) = v_{2}(a_{q_{1}} - 2\chi_{4}(q_{1})) + v_{2}(\mathcal{T}_{4})$$
  

$$\geq \mathfrak{v}_{q_{1}} + v_{2}(\mathcal{T}_{4})$$
(19)

$$\geq \mathfrak{w}_{q_1} + \min\{1 + \delta_{\mathfrak{v}_{q_1},0}, v_2(\mathcal{T}_4) + \delta_{\mathfrak{v}_{q_1},2}\}.$$
(20)

Note that the inequality (19) follows from  $q_i \in S_0 \cup S_1 \cup S_2$  for all *i*. Therefore, from (18) and (20), we obtain

$$v_{2}(\mathcal{T}_{4q_{1}}) = v_{2}\left(\sum_{d|q_{1}}\mathcal{T}_{4d,4q_{1}} - \mathcal{T}_{4,4q_{1}}\right)$$
  

$$\geq \min\left\{v_{2}\left(\sum_{d|q_{1}}\mathcal{T}_{4d,4q_{1}}\right), v_{2}(\mathcal{T}_{4,4q_{1}})\right\}$$
  

$$\geq \mathfrak{w}_{q_{1}} + \min\left\{1 + \delta_{\mathfrak{v}_{q_{1}},0}, v_{2}(\mathcal{T}_{4}) + \delta_{\mathfrak{v}_{q_{1}},2}\right\}.$$

Moreover, if  $v_2(\mathcal{T}_4) = 1$  and  $\mathfrak{v}_{q_1} = 0$ , then the left-hand side is strictly larger than the right-hand side in (18), and the both sides are equal in (20). Therefore, we have  $v_2(\sum_{d|q_1} \mathcal{T}_{4d,4q_1}) > v_2(\mathcal{T}_{4,4q_1})$  and

$$v_{2}(\mathcal{T}_{4q_{1}}) = v_{2}\left(\sum_{d|q_{1}}\mathcal{T}_{4d,4q_{1}} - \mathcal{T}_{4,4q_{1}}\right)$$
  
=  $v_{2}(\mathcal{T}_{4,4q_{1}})$   
=  $\mathfrak{w}_{q_{1}} + \min\{1 + \delta_{\mathfrak{v}_{q_{1}},0}, v_{2}(\mathcal{T}_{4}) + \delta_{\mathfrak{v}_{q_{1}},2}\}.$ 

Thus, the claim holds for r(m) = 1. Suppose it is true for  $1, \ldots, r(m) - 1$ . Then, by (17), it holds that

$$v_2\left(\sum_{d|m} \mathcal{T}_{4d,4m}\right) \ge r(m) + 1$$
  
$$\ge \mathfrak{w}_m \cdot r(m) + \min\{1 + \delta_{\mathfrak{v}_m,0}, v_2(\mathcal{T}_4) + \delta_{\mathfrak{v}_m,2}\}$$
(21)

and by Proposition 3.3, we see that

$$v_{2}(\mathcal{T}_{4,4m}) = \sum_{i=1}^{r(m)} v_{2}(a_{q_{i}} - 2\chi_{4}(q_{i})) + v_{2}(\mathcal{T}_{4})$$

$$\geq \sum_{i=1}^{r(m)} v_{2}(a_{q_{i}} - 2) + v_{2}(\mathcal{T}_{4})$$

$$\geq \mathfrak{v}_{m} \cdot r(m) + v_{2}(\mathcal{T}_{4})$$

$$\geq \mathfrak{w}_{m} \cdot r(m) + \min\{1 + \delta_{\mathfrak{v}_{m},0}, v_{2}(\mathcal{T}_{4}) + \delta_{\mathfrak{v}_{m},2}\}.$$
(22)

For a divisor d of m with  $d \neq 1, m$ , by Proposition 3.3 and the induction hypothesis, it holds that

$$v_{2}(\mathcal{T}_{4d,4m}) = v_{2}(\mathcal{T}_{4d}) + \sum_{q \mid \frac{m}{d}} v_{2}(a_{q} - 2\chi_{d}(q))$$

$$\geq v_{2}(\mathcal{T}_{4d}) + \sum_{q \mid \frac{m}{d}} v_{2}(a_{q} - 2)$$

$$\geq \mathfrak{w}_{d} \cdot r(d) + \min\{1 + \delta_{\mathfrak{v}_{d},0}, v_{2}(\mathcal{T}_{4}) + \delta_{\mathfrak{v}_{d},2}\} + \mathfrak{v}_{m} \cdot (r(m) - r(d))$$

$$\geq \mathfrak{w}_{m} \cdot r(m) + \min\{1 + \delta_{\mathfrak{v}_{m},0}, v_{2}(\mathcal{T}_{4}) + \delta_{\mathfrak{v}_{m},2}\}.$$
(23)

Therefore, we have

$$v_{2}(\mathcal{T}_{4m}) = v_{2} \left( \sum_{d|m} \mathcal{T}_{4d,4m} - \mathcal{T}_{4,4m} - \sum_{\substack{d|m \\ d \neq 1,m}} \mathcal{T}_{4d,4m} \right)$$
$$= \min \left\{ v_{2} \left( \sum_{d|m} \mathcal{T}_{4d,4m} \right), v_{2}(\mathcal{T}_{4,4m}), v_{2} \left( \sum_{\substack{d|m \\ d \neq 1,m}} \mathcal{T}_{4d,4m} \right) \right\}$$
$$\geq \mathfrak{w}_{m} \cdot r(m) + \min\{1 + \delta_{\mathfrak{v}_{m},0}, v_{2}(\mathcal{T}_{4}) + \delta_{\mathfrak{v}_{m},2}\}.$$
(24)

Moreover, if  $v_2(\mathcal{T}_4) = 1$  and  $\mathfrak{v}_d = 0$  for a divisor d of m with  $d \neq 1, m$ , then the left-hand side is strictly larger than the right-hand side in (21), and both sides are equal in (22) and (23). In addition, since the number of divisors of m is even, we see that

$$\begin{split} v_2 \left( \sum_{\substack{d \mid m \\ d \neq 1, m}} \mathcal{T}_{4d, 4m} \right) &\geq 1 + \mathfrak{v}_m \cdot r(m) + \min\{1 + \delta_{\mathfrak{v}_m, 0}, v_2(\mathcal{T}_4) + \delta_{\mathfrak{v}_m, 2}\} \\ &> \mathfrak{w}_m \cdot r(m) + \min\{1 + \delta_{\mathfrak{v}_m, 0}, v_2(\mathcal{T}_4) + \delta_{\mathfrak{v}_m, 2}\}. \end{split}$$

Thus, we have

$$v_2(\mathcal{T}_{4,4m}) < v_2\left(\sum_{d|m} \mathcal{T}_{4d,4m}\right), v_2\left(\sum_{\substack{d|m\\ d\neq 1,m}} \mathcal{T}_{4d,4m}\right).$$

Therefore the equality of (24) holds. This completes the proof.

## 5. Numerical Example

In this section, we give examples for the case N = 34 in Theorem 4.1 and for the case N = 37 in Theorem 4.3.

## 5.1. Example of Theorem 4.1. Let $f_1 \in S_2(\Gamma_0(34))^{\text{new}}$ be the normalized Hecke eigenform

$$f_1 = q + q^2 - 2q^3 + q^4 - 2q^6 - 4q^7 + q^8 + q^9 + O(q^{10})$$

By computation, we see that the period lattice of  $f_1$  is rectangular,  $v_2(L(f_1, 1)/\Omega_{f_1}^+) = 0$  and the global minimal Weierstrass model of  $E_{f_1}$  is given by the equation  $y^2 + xy = x^3 - 3x + 1$  with Cremona label **34a1**. In TABLE 2, we give the comparison between the 2-adic valuation of the algebraic part  $v_2\left(L(f_1, \chi_m, 1)/\Omega_{f_1}^{\operatorname{sgn}}\right)$  and the lower bound in Theorem 4.1 for various integers m with r(m) = 1. Here, items for which the equality condition holds are colored by red, that is, the items for  $m = q \in S_1^+$ .

# 5.2. Example of Theorem 4.3. Let $f_2 \in S_2(\Gamma_0(37))^{\text{new}}$ be the normalized Hecke eigenform

$$f_2 = q - 2q^2 - 3q^3 + 2q^4 - 2q^5 + 6q^6 - q^7 + O(q^8).$$

We see that the period lattice of  $f_2$  is rectangular,  $v_2(L(f_2, \chi_4, 1)/\Omega_{f_2}^-) = 0$  and the global minimal Weierstrass model of  $E_{f_2}$  is represented as  $y^2 + y = x^3 - x$  with Cremona label **37a1**. In TABLE 3, we give the comparison between the 2-adic valuation of the algebraic part  $v_2(L(f_2, \chi_{4m}, 1)/\Omega_{f_2}^{\text{sgn}(\chi_{4m})})$  and the lower bound in Theorem 4.3 for various integers m with r(m) = 1.
